GUWAHATI, Nov 16: Chief Minister Himanta Biswa Sarma on Saturday said that the state police must transform itself into a force that serves and protects the people with dignity and respect, not one that uses unnecessary force against common citizens on the streets.

A food delivery boy, also a student of Cotton University, had allegedly entered a no-entry zone in Guwahati by mistake on Friday night and the officer-in-charge of Panbazar police station had assaulted him, with the video of the incident going viral on social media.

Family members of the suspected militants were camping outside the hospital and demanded that the bodies be handed over to them. Assam police officials tried to



Colombia's government eager for post-fossil fuels economy

BOGOTA (COLOMBIA), Nov 16: Colombia's fiery left-wing President Gustavo Petro is one of the biggest opponents of fossil fuels on the world stage today, with speeches that lump oil and coal with cocaine as his country's "three poisons".

He's set a goal of weaning Colombia off those fossil fuels, putting the green energy transition and environmental protection at the center of his agenda.

His opposition is long-held, but it's also practical. Colombia's oil reserves are projected to last only about seven years, and without new discoveries, the country will eventually have to find a way forward without the oil and coal that make up more than half its exports.

But doing so will require overcoming the same challenges that many smaller nations face with the energy transition: higher borrowing costs that more developed nations face. Environment Minister Susana Muhamad said.

Muhamad has been highlighting Colombia's challenge at the United Nations climate talks in Azerbaijan, where the major goal of this year's talks known as COP29 is establishing just how much wealthy nations will contribute to the developing world to cope with climate change and transform their energy systems.

At a press conference on the sidelines of the climate talks Saturday, Muhamad said the world "cannot continue to play with the same financial rules that leave developing countries behind".

Muhamad also touted her country's support for a non-proliferation treaty for fossil fuels. The treaty, modelled on others like a non-nuclear proliferation treaty, is aimed at ending the expansion of new coal, oil and gas projects, and manage a global transition away from fossil fuels.

Colombia launched a new investment portfolio at the end of September for its climate adaptation plans, which it hopes will attract around \$40 billion to help fund ecotourism, a fair energy transition and conservation and restoration of ecosystems.

CBDT launches campaign to intimate taxpayers on undeclared foreign assets in ITR

NEW DELHI, Nov 16: The income tax department on Saturday said it has launched a campaign to send messages to taxpavers who have not disclosed high-value foreign income or assets in their ITRs for AY 2024-25. The Central Board of Direct Taxes (CBDT) has launched a Compliance-Cum-Awareness Campaign for Assessment Year (AY) 2024-25 to assist taxpayers in accurately completing Schedule Foreign Assets (Schedule FA) and reporting income from foreign

sources (Schedule FSI) in their income tax returns (ITR). In a statement, CBDT said informational messages will be sent via SMS and email to resident taxpavers who have already submitted their ITRs for AY 2024-25. These messages are intended for individuals identified through information received under bilateral and multilateral agreements, suggesting that they may hold foreign accounts or assets, or have received income from foreign jurisdictions. "India has become the biggest laboratory in the digital world. A laboratory where you can experiment at a scale, which is impossible and inconceivable anywhere else, probably except the United States. Maybe we even leapfrog them for a variety of reasons," he said.

India has become a place that is digitally and financially connected with an identity, which has led to innovations one after another, he said, adding that UPI is an innovation and 48 to 50 per cent of all global financial transactions happen in India.

As many as 10 billion transactions a month are happening, which may be lower in terms of value and very high in terms of volume, the NITI CEO said. He said 'Viksit Bharat' is not necessarily just being a prosperous country, but also an inclusive nation which will have a "rising tide which lifts all the boats."

He said the country is expected to become a USD 30 trillion economy by 2047, surpassing the present size of the US and Chinese economies.

Research and innovation are crucial for becoming a modern developed economy, he said.

With the vast base that has been created in the last 10 years, India has probably become a huge hub for fintech innovation. Subrahmanvam said.

Talking about the transformation in the country during the last decade, he said there will be a drinking water supply in every village by the end of next year.

"Every house is connected to an electricity supply. There is a road to every village. We have housing which is being built at a rapid pace," he said.

In the last 10 years, 25 crore people have escaped "acute poverty", he said, also highlighting the transformation in highways, railways (including Vande Bharat trains) and others in the country.

He also said India can be a leader in climate change as the technologies to address the issue have not yet been invented fully.

Observing that most countries in the West have developed stable economies which have to be "rewired and re-engineered" for a green future. He said such re-engineering is not required in a large part of India and climate-friendly mobility and power systems can be developed.

The government's missions, such as those related to AI and semiconductor are aimed at keeping the country ahead in the concerned areas, he said.

India is going to be a powerful nation in terms of its innovative capabilities, he said.

He also said NITI Aayog is preparing visions for the country, preparing economic plans for cities and trying to transform agriculture into new areas like horticulture and aquaculture. "The second area in which NITI works is how we capture the technological trends to benefit the country..." he said. India should be a global leader in frontier technologies, he added.

Since the technologies don't exist, everybody is starting afresh and India should be setting the benchmarks, the standards, and the certification methods for technologies, he said. "I think NITI would lead that drive," he said. (PTI)

73rd Boro Sahitya Sabha anniversary celebrated with statewide enthusiasm

DIPHU, Nov 16: The 73rd anniversary of the Boro Sahitya Sabha (BSS) was celebrated with enthusiasm across the state, including Karbi Anglong and West Karbi Anglong districts.

Events commemorating this foundation day were organised in each branch or unit of the BSS, with participation from individuals and officials of various Bodo organisations. The celebration featured a range of activities, including traditional games, sports competitions, and contests aimed at engaging students and youth. In Howraghat, the Howraghat Town Bodo Society organised a vibrant celebration. The event took place at the Howraghat Sports Association playground, where the BSS flag was ceremoniously hoisted by president of Howraghat Town Bodo Society, KK Brahma. He was joined by Secretary Bhabananda Khakhlary and Joint Secretary Paresh Boro.

In his speech Brahma talk about the historical progression of the Boro language and its development. He also called upon the younger generation to engage with literature for the advancement of the community.

The Boro Sahitya Sabha was established on November 16, 1952, in Basugaon, now part of Chirang district, aiming to promote Bodo language and literature.

The founding president, Joy Bhadra Hagjer, along with representatives from Assam, West Bengal, Meghalaya, Nagaland, Tripura, and Nepal, laid the foundation for this literary organisation.

Following India's independence, a group of Bodo intellectuals recognized the urgent necessity to preserve the Bodo language. Many early authors were educated in institutions where instruction was primarily in Assamese or Bengali, leading to a collective understanding that the Bodo language required similar levels of preservation and development. There was a realisation among the Bodo population that education was essential for their overall development and the advancement of their language.

Through sustained efforts by the Bodo Sahitya Sabha, the Bodo language was introduced as a medium of instruction at the primary level in 1963 and subsequently at the secondary level in 1968. The language and its literature have gained recognition as one of the Major Indian Languages (MIL) within several universities, including Gauhati, Dibrugarh, and North-Eastern Hill Universities. In 2004, the Bodo language was designated as an associated official language of Assam. Its status has further been enhanced with the introduction of Post-Graduate Courses in Bodo language and literature at Gauhati University in 1996 and Bodoland University, Kokraihar.

Furthermore, under the auspices of the Commission for Scientific and Technical Terminology of the Ministry of Human Resource Development, Government of India, the Bodo Sahitya Sabha is actively engaged in the development of over forty thousand scientific and technical terms in the Bodo language. It is also anticipated that the Sahitya Academy will grant "Bhasa Sonman" to the Bodo language and its literature as an initial step toward comprehensive recognition.

Furthermore, the Government of India has, in principle, acknowledged the importance of including the Bodo language and literature in the Eight Schedule of the Constitution of India.

In view of the apprehended adverse impact on environment and wildlife several organisations have opposed the proposal of exploration and drilling at the place as it will disturb the eco system and ultimately destroy the biodiversity in which several varieties of butterflies, insects, frogs, reptiles and six other primate species are found apart from the endangered Hoolock Gibbon.

DIPHU. Nov 16: A team from Centre for Urbanization, Buildings & Environment (CUBE) from IIT Madras, is on a three day visit in Karbi Anglong district, to inspect the technical and social aspects of the implementation of Jal Jivan Mission (JJM), which is a Central and State government sponsored scheme aimed at providing safe drinking water to every rural household and public institution in India by 2024. In Karbi Anglong district the PHE Rural Division is the nodal agency for implementing JJM. CUBE has been raised by IIT Madras and Government of Tamil Nadu as an applied research, technology and consultancy centre.

Technical Auditors of CUBE IIT Madras, Chenna Prasad R and Upam Dev Agnibashya, the two officials in their three day visit in the district have inspected the five completed Pipe Water Supply Scheme (PWSS) of JJM, which are in operation providing free flow of piped water to the doorstep in rural households and public institutions.

On Saturday, the team accompanied by Biman Baruah, executive engineer and Bikrom Teron, Sub-Divisional Officer (SDO) of Diphu Rural PHE Division visited Jeng Bey PWSS, under JJM at Langsoli-et, which is 23 km from here, to find out about the functioning of the scheme. The two officers inspected the whole plant like the pump house, water tank, solar panels, boring, water tape and also interacted with the villagers.

The Jeng Bey PWSS was completed on December 24, 2023 with a total cost of Rs. 68,53,235 out of which central share is Rs. 58,59,515.93 and state share is Rs.

6,51,057.33. As informed by Longki Bey S/o of the village headman of Mensing Bey, said it covers two villages Jeng Bey with 44 families and Diliram Terang with 40 families. While the information provided on the board for Functional Household Tape Connection (FHTC) is 74 families. Inglongkiri Medical Sub-Centre and Nilalung LP School are also covered under Jeng Bey PWSS.

The Technical Auditor, CUBE IIT Madras, Chenna, Prasad R said, "We come here to audit the JJM implementation in Karbi Anglong. We have done the survey, where JJM are provided and looked into the whole thing. We also interacted with the villagers about JJM and whether it benefited them or not."

The technical auditor also expressed satisfactory in all the sites they visited as the piped water has reach to every household. All the reports collected will be submitted to the JJM head office.

Earlier, Longki Bey, S/o Mening Bey, of headman of Jeng Bey village told the visiting team that before the PWSS was set up, villagers have to reach down to the stream to fetch water. It was a long walk and time consuming. Some households draw water from kutcha ringwells and during rainy season the water is muddy. Now as the PWSS has been installed villagers are overjoyed particularly women as the burden of fetching water from kutcha ringwells and rivers is no more.

The executive engineer, Baruah said in Karbi Anglong there are 525 new JJM schemes and out of this 140 schemes have been complete. Another 385 schemes are yet to be completed.

Israel, Palestine and a divided Africa: Seeking a path forward

The ongoing conflict in Gaza between Israel and Palestine, which began on October 7, 2023, marks a significant military engagement in the region, being the largest confrontation since the 1973 Yom Kippur War. This conflict has global ramifications, with the African continent likely to feel its effects profoundly. Africa, with its 55 countries and diverse political landscape, is particularly vulnerable to such geopolitical divides.

Africa's Divided Stance on Israel-Palestine: African countries vary widely in their stance on the Israel-Palestine issue, often shaped by historical, ideological, and economic factors. Pro-Palestinian countries like Algeria, Tunisia, South Africa, Senegal, Mali, Zimbabwe, Namibia, and Libya support Palestine, often viewing the Palestinian struggle through the lens of their anti-colonial histories. In contrast, several nations, including Kenya, Ethiopia, Uganda, Rwanda, Morocco, and Chad, have established close relations with Israel, motivated by economic, technological, and security interests. Additionally, neutral countries such as Nigeria, Ghana, Egypt, the Democratic Republic of Congo, and Sudan maintain diplomatic ties with both Israel and Palestine, typically refraining from favoring one side over the other.

At the continental level, the African Union (AU) has traditionally supported Palestine's statehood and criticised Israeli policies. A Deeper Look at Africa's Reactions: African responses to the Gaza conflict highlight the continent's fractured stance on foreign policy issues. In South Africa, for instance, public protests have likened the Palestinian struggle to the country's anti-apartheid movement. South African President Cyril Ramaphosa has voiced strong support for Palestine, and his government filed a lawsuit against Israel at the International Court of Justice. Algeria's Foreign Minister similarly condemned Israeli actions, citing international law, while Comoros President Azali Assoumani labeled Israeli actions as genocidal.

On the other hand, several sub-Saharan nations, including South Sudan, Cameroon, Togo, and Cape Verde, chose not to support the recent United Nations resolution calling for a ceasefire in Gaza. Even Muslim-majority countries like Morocco, Chad, and Sudan have limited their response to public condemnations without altering diplomatic ties. Malawi and Kenya recently agreed to send laborers to Israel following a halt in work permits for Palestinians, further signaling the complexities in Africa's stance. Africa and Israel share a complex, long-standing relationship that dates back to before Israel's founding. Theodor Herzl, the founder of the Zionist movement, expressed support for African liberation, envisioning solidarity between Jews and Africans in their quests for self-determination. This vision gained traction in the 1960s, with Israel maintaining a strong presence in Africa, including 33 embassies across the continent. Israel's model of decolonisation and development attracted the admiration of African leaders who saw parallels in their own struggles for independence.

However, following the 1973 Yom Kippur War, pressure from Arab countries led many African states to sever ties with Israel. This led to a period of estrangement, with African leaders feeling frustrated by unmet promises from Arab allies, particularly in the realm of energy cooperation. Gradually, ties began to thaw, and by the early 21st century, Israel was once again seeking partnerships in Africa, with diplomatic and economic collaborations resuming.

In recent years, Israel's outreach has intensified. In 2016, Israeli Prime Minister Benjamin Netanyahu visited East Africa, and a year later, he addressed the Economic Community of West African States. In 2022, Israel and several African nations agreed to expand cooperation in renewable energy, trade, and technology. Kenya's President William Ruto visited Israel in 2023, further strengthening ties in agriculture, climate change, security, and other sectors.

Manipur's crisis: A test of constitutional integrity and governance

The essence of the Indian Constitution, and indeed that of any demo-cratic nation's foundational document, lies in safeguarding the rights of the weak and ensuring justice is upheld, whether in the dynamic between the citizen and the state or among various societal groups. The Constitution empowers the state with both the authority and the duty to uphold the laws that represent the collective will of the people. When this core principle is ignored, justice is denied, leading to potential unrest and unlawful behavior by those marginalized. The state of Manipur, a part of the Indian Union, has been a glaring example of constitutional failure over the past 18 months. The situation has escalated to the point where basic constitutional guarantees - the right to equality, the right to life, and the right to seek legal redress - have been persistently compromised. Since the onset of ethnic violence in May 2023, the state machinery has shown signs of complete collapse, a fact underscored by the Supreme Court's pronouncement on August 1, 2023, when it explicitly stated that there was an "absolute breakdown of the state machinery in Manipur." Yet, despite this stark acknowledgment, conditions on the ground remain dire.

Central Reserve Police Force (CRPF) engaging in an encounter that left 11 armed militants dead. The CRPF's actions might seem justified in terms of immediate tactical success - no casualties among their ranks - but the broader implications are troubling. These slain individuals, claimed

not personally intervened in the escalating crisis within Manipur, a state under his direct purview. His failure to visit or actively address the unrest signifies a concerning disconnect. This inaction is not just an oversight; it carries significant consequences. Good for crop, good for human health either

Nodav the farmer wants to rely fully on chemical or inorganic pesticides to save the crop from harmful insects. Which is to keep moving and moving ahead on the path of destruction, and nothing else. Laying stress on the organic farming, so was told to the farmers in 'Kisan Sangoshthi' (Farmers-Symposium) organised by Shivshakti Bio-Group. The symposium was organised in the Shaikpura village of Sehore district close to Bhopal, the capital of MP.

Speaking about the organic manure and organic pesticides available in the market, Omprakash Tyagi of the Shivshakti organisation tells the presence of farmerfriendly culture of microorganisms offer the life to the farm-land that ultimately transcends into the crop. Thus crop grows up into the higher state of vitality

Notably, as low is the intrinsic health of the crop, so many pesticides will it requires to protect itself from pests. Whereas the crop produced from organic manure possess enough immunity to fight out the onslaught of pests. Therefore it requires pesticide far a little amount, that's too in unavoidable condition

Owing to which crop remains free from harmful elements caused by pesticides, thus gets to be far a more nutritious for the human health. And keeps farmer away from burden of unnecessary over expenses as well.

Secondly, as chemical fertilizer boost up the growth of crops, so swiftly the soil-friendly organisms perish. Notably, with their mobility the organisms maintain porosity and dampness in the soil, as also allows the presence of oxygen through pores for the plants.

On the other hand, when organisms destroyed, land succumbs to get hard. Then the same piece of land requires more fertilizer, and more water. In other words the cost of farming gets more expensive. According to a study, 9 kg/hectare of chemical fertilizer was once needed in 1960-61; in 1987-88 it

shot up to 51.20 kg/hectare! Organic farming increases fertil-

ity and the soil friendly organisms so also. It contributes in the preservation of environment, and cow stock moreover. Farmland should have minimum 0.9% carbon, but with the time it came down to 0.6-0.7 % and even a worst level in many a place in the country. With this note symposium ended.

The Chief Minister's administration has been widely criticized by multiple fact-finding teams for discriminatory practices, yet there has been no meaningful shift in his approach or in the central government's stance.

The paradox here is stark. Prime Minister Narendra Modi has positioned India as a potential mediator in international conflicts, such as the Israel-Hamas confrontation and the Russia-Ukraine war, yet he has

price for allowing regional conflicts to fester unchecked, and Manipur is poised to become another example unless urgent steps are taken.

The narrative of violence has been relentless. Farmers in paddy fields are targeted by snipers, and civilians face brutal killings, such as the shooting of a Meitei woman in her field and the horrific murder of a Kuki woman. These acts underscore the audacity and cruelty of militants who have capitalized on the absence of effective governance.

More than 200 people have died, and thousands have been displaced since May 2023 in clashes between the Meitei and Kuki communities. Despite this, the state's leadership has failed to restore peace. The ruling 'double-engine' government - implying both state and central BJP leadership . has shown itself unable or unwilling to act decisively

The Chief Minister's troubles have only grown, with Kuki organizations demanding a Supreme Court-monitored Special Investigation Team (SIT) probe into his alleged role in inciting violence. This demand is bolstered by leaked audio recordings that purportedly implicate him. While the veracity of these recordings must be proven,

of fences along the India-Myanmar border and the abolition of the Free Movement Regime, have exacerbated tensions. These measures, opposed by various tribal groups for threatening social and economic ties across borders, illustrate the disconnect between policy makers and the lived realities of Manipur's communities.

The implications of allowing Manipur's crisis to persist are severe, not just for the state but for the entire North-East region, which has long grappled with insurgency. Stability in this region is essential for national security, and leaving Manipur to navigate its current turmoil without adequate intervention risks deeper unrest.

The Indian Constitution's promise of justice and protection must be made real in Manipur. The government must act with urgency to reestablish the rule of law. address the grievances of all communities, and restore peace. This could involve bold measures such as the imposition of President's rule to bring neutrality and rebuild public trust. Without decisive action, the state risks further descending into violence, taking with it the principles of justice and equality that are the bedrock of Indian democracy. LIMA (PERU), Nov 16: President Joe Biden is expected to use his final meeting with China's leader, Xi Jinping, to urge him to dissuade North Korea from further deepening its support for Russia's war on Ukraine.

Saturday's talks on the sidelines of the annual Asia-Pacific Economic Cooperation summit in Peru come just over two months before Biden leaves office and makes way for Republican President-elect Donald Trump.

It will be Biden's last checkin with Xi - someone the Democrat saw as his most consequential peer on the world stage.

With the final meeting, officials say Biden will be looking for Xi to step up Chinese engagement to prevent an already dangerous moment with North Korea from further escalating.

Biden on Friday, along with South Korean President Yoon Seok Yul and Japan's Prime Minister Shigeru Ishiba, condemned North Korean leader Kim Jong Un's decision to send thousands of troops to help Moscow repel Ukrainian forces who have seized territory in Russia's Kursk border region.

Biden called it "dangerous and destabilising cooperation". White House officials also

have expressed frustration with Beijing, which accounts for the vast majority of North Korea's trade, for not doing

war against Ukraine. And tensions flared last year after Biden ordered the shooting down of a Chinese spy balloon that traversed the United States. (AP)

BEIRUT, Nov 16: Israeli ground forces reached their deepest point in Lebanon since they invaded six weeks ago, before pulling back on early Saturday after fierce battles with Hezbollah militants, Lebanese state media reported.

Israeli troops captured a strategic hill in the southern Lebanese village of Chamaa. about 5 kilometers (3 miles) from the Israeli border early Saturday, the state-run National News Agency reported. It said Israeli troops were later pushed back from the hill.

It added that Israeli troops detonated the Shrine of Shimon the Prophet in Chamaa as well as several homes before they withdrew, but the claim could not be immediately verified. Israel's military said in a statement that its troops "continue their limited, localized, and targeted operational activity in southern Lebanon." The military did not immediately respond to requests for comment on the Lebanese media reports.

The push on the ground came as Israeli warplanes pounded Beirut's southern suburbs as well as several other areas in southern Lebanon including the port city of Tyre.

The morning strike in Beirut hit an area known as Dahiyeh, which the Israeli military called a Hezbollah stronghold, saying its planes had hit multiple sites used by the militant group. Residents were given advance warning by Israel, and it was not immediately clear whether there

were any casualties. The increase of violence came as Lebanese and Hezbollah officials are studying a draft proposal presented by the U.S. earlier this week on ending the war.

Since late September, Israel dramatically escalated its bombardment of Lebanon, vowing to cripple Hezbollah and end its barrages in Israel. More than 3,400 people have been killed in Lebanon by Israeli fire - 80% of them in the eight weeks - according to Lebanon's Health Ministry.

On Friday, Lebanon's caretaker prime minister apparently urged Iran to try and convince Hezbollah to agree to a cease-fire deal with Israel, which would require the group to pull back from the Israel-Lebanon border. The proposal is based on U.N. Security Council resolution 1701, which ended the last Israel-Hezbollah war in the summer of 2006.

A copy of the draft proposal was handed over earlier this week by the U.S. ambassador to Lebanon to Parliament Speaker Nabih Berri, who has been negotiating on behalf of Hezbollah, according to a Lebanese official. The official who spoke on condition of anonymity because he was not authorized to speak about the secret talks said Berri is expected to give Lebanon's response on Monday

Another Lebanese politician said Hezbollah officials had received the draft, were studying it and would express their opinion on it to Berri. The politician also spoke on condition of anonymity because he was not authorized to speak to the media about the ongoing talks.

Berri told the pan-Arab Asharq Al-Awsat daily newspaper that the draft does not include any item that allows Israel to act in Lebanon if the deal is violated.

"We will not accept any infringement of our sovereignty," Berri was quoted as saying. He added that one of the items mentioned in the draft that Lebanon does not accept is the proposal to form a committee to supervise the agreement that in-

cludes members from Western countries.

Berri added that talks are ongoing regarding this point as well as other details in the draft, adding that "the atmosphere is positive but all relies on how things will end.'

There is also a push to end the war between Israel and Hamas, which began after Palestin-

ian militants stormed into Israel on Oct. 7, 2023, killing about 1,200 people - mostly civilians — and abducting 250 others. The U.N. Security Council's 10 elected members on Thursday circulated a draft resolution demanding "an immediate, unconditional and permanent cease-fire" in Gaza.

The U.S., Israel's closest ally, holds the key to whether the U.N. Security Council adopts the resolution. The four other permanent members — Russia, China, Britain and France — are expected to support it or abstain.

Israel's bombardment and ground offensives since the initial Hamas attack have killed more than 43,000 people in Gaza, Palestinian health officials say. The officials don't distinguish between civilians and combatants but say more than half of those killed have been women and children. (AP)

The agreement requires both countries to use all available means to provide immediate military assistance if either is attacked

Iwaya's visit comes after the Ukrainian capital was attacked overnight by Russian drones, damaging residential buildings and infrastructure in Kyiv's Obolon district. No casualties were reported.

Ukrainian air defences neutralised up to a dozen drones, said the head of Kyiv's military administration, Serhii Popko.

Russia attacked Ukraine with 83 Shahed drones in the early hours of Saturday morning, the Ukrainian air force reported. Of those, 55 were shot down, while another 30 veered off course or were lost after electronic jamming, it said.

Georgia election chief doused in paint as protests continue after divisive parliamentary vote

TBILISI, Nov 16: The head of Georgia's Central Electoral Commission was doused with black paint on Saturday at a meeting to confirm the results of the country's divisive Oct. 26 parliamentary elections.

Protesters gathered outside the commission's building in Tbilisi, where officials announced that the ruling Georgian Dream party had won 53.93% of the vote.

Opposition supporters have rejected the results amid allegations that the vote was rigged, an accusation that Georgian Dream denies.

The Saturday session was interrupted when David Kirtadze, a commission member from the opposition United National Movement party, threw black paint at commission chairman Giorgi Kalandarishvili.

Before the incident, Kirtadze told Kalandarishvili that the official results of the vote did not reflect voters' "true choice.

Kalandarishvili responded by saying that the use of "pressure, bullying and personal insults" roved that there was no evidence of vote rigging.

When the meeting resumed, Kalandarishvili was seen with a bandaged eye.

"It once again becomes evident that there is no tangible proof indicating that the elections were manipulated," he told the audience.

European election observers have described the Georgian parliamentary elections as taking place in a "divisive" atmosphere marked by instances of bribery, double voting and physical violence

Many Georgians viewed the vote as a pivotal referendum on the country's effort to join the European Union. The bloc suspended Georgia's membership application process indefinitely in June after the country's parliament passed a "foreign influence law" that critics say mimics Moscow's crackdown on civil society.

Critics have accused the ruling Georgian Dream, established by Bidzina Ivanishvili, a shadowy billionaire who made his fortune in Russia, of becoming increasingly authoritarian and tilted toward Moscow. It has recently adopted laws similar to those used by the Kremlin to crack down on freedom of speech and LGBTQ+ rights.

President Salome Zourabichvili, who has rejected the official results, says Georgia has fallen victim to pressure from Moscow against joining the European Union. Zourabichvili, who holds a mostly ceremonial position, has urged the United States and EU to support the demonstrations. Officials in Washington and Brussels have urged a full investigation of the election, while the Kremlin has rejected the accusations of interference. (AP)



Security forces directed to restore order, peace in Manipur

Fresh order came after the Manipur government imposed AFSPA in the entire state on October 1

NEW DELHI, Nov 16: All security forces deployed in Manipur have been directed to take necessary steps to restore order and peace in the state as the security scenario remained "fragile" in the past few days, the Union Home Ministry said Saturday.

A fresh cycle of violence erupted in Manipur last Monday after 11 suspected militants, who allegedly attacked a police station and adjoining CRPF camp with sophisticated weapons in Manipur's Jiribam district, were killed in an exchange of fire.

A day later, six civilians, including women and children were abducted by armed militants from the same district.

"The security scenario in Manipur has remained fragile for the past few days. Armed miscreants from both communities in conflict have been indulging in violence leading to unfortunate loss of lives and disruption in public order," the ministry said on Satur-

day. The home ministry said strict action would be initiated against anyone trying to indulge in violent and disruptive activities. It said important cases have been handed over to the NIA for effective investigation.

One human trafficker held in Tripura

HT Correspondent AGARTALA, Nov 16: The Government Railway Police (GRP) arrested a suspected human trafficker from the Belabar area of Agartala city, near the Indo-Bangladesh border, on Friday. Speaking on the issue, GRP Officer-in-Charge Tapas Das said that the arrest followed an ongoing investigation into a human trafficking case, which led them to identify the suspect, Raju Mia. "We arrested Raju Mia from the Belabar area in a joint operation conducted by the Tripura Police, BSF, and the GRP. He has been apprehended for his involvement in facilitating illegal crossings of the India-Bangladesh border. During the preliminary interrogation, he disclosed the names of other individuals involved in the trafficking network. The accused has been produced before the court," he stated.

More than 200 people have been killed and thousands rendered homeless in ethnic violence between Imphal Valley-based Meiteis and adjoining hills-based Kuki-Zo groups since May last year.

Don't hamper NH projects with land issues: Nagaland Dy CM Zeliang

DIMAPUR. Nov 16: Nagaland deputy chief minister TR Zeliang urged the public not to hamper National Highway projects in the state with land issues.

Addressing the media after undertaking a fourday tour to five districts of Phek, Kiphire, Shamator. Tuensang and Mokokchung from November 11 here on Friday, Zeliang, who is also the minister in charge of National Highway, said he reviewed and assessed the National Highway projects, covering an approximate length of 750 n, in the districts. "This is highly unethical and can lead to delay or even failure to sanction the project." Zeliang said. He also said the state government would recommend that those projects which are being stalled due to the land issue be foreclosed as there is no provision to pay for land compensation other than National Highway projects.

He added that land comp on mat state has been one major issue in the failure and delay of projects. Zeliang said during the four-day tour, he was overwhelmed by the support of the public for the government. He solicited the same support when a project is sanctioned and work commences so that the appointed contractors do not face any hurdle and the public gets to enjoy good roads. He also asked contractors to maintain quality work and complete the projects as per the scheduled date for their completion.

He accused Mahayuti leaders of being "hell-bent" on insulting state's icons like Chhatrapati Shivaji Maharaj, whose statue collapsed in August this year, and Jyotiba Phule and Savitribai Phule.

"A person holding a Constitutional post made derogatory comments on the married life of Savitribai and Jyotiba Phule. The corruption caused the collapse of the statue of Shivaji Maharaj (in coastal Sindhudurg district)," Pawar said.

Speaking to reporters at Satara, the former chief minister said the people would ensure change (of



regime in Maharashtra). "People want change and they will bring about a change. They will stand with Maha Vikas Aghadi

(MVA)," he added. The 83-year-old politician, known for keeping his ears close to the ground, claimed the overall atmosphere in the state reminds him of the 2019 elections when "people remained silent but reacted on vot-

ing day". Pawar said welfare schemes announced by the ruling coalition won't have much impact on electors. Referring to the course correc-

tion by BJP and allies after their dismal performance in the 2024 Lok Sabha elections, Pawar said the parties in power seem to have taken serious note of the setback.

"They introduced cash transfer schemes to make people happy. However, they haven't provided information on how long these schemes will last.

"For example, they are giving Rs 1,500 (monthly aid) to 2 crore women under the 'Ladki Bahin' scheme which made them happy. However, despite spending money, the impact (on Mahayuti's poll prospects) won't be significant," he stated.

Pawar highlighted what he termed as the contradiction be-

tween Mahayuti's promises and the ground reality, claiming that crimes against women are on the rise.

"67,000 cases of violence against women had been registered over the last two years. The data suggests around 64,000 women and girls have gone missing in the state, including in Nagpur, which is home to the state Home Minister (Devendra Fadnavis)," he claimed. He said the government's claims

about caring for women fall flat as they have failed to protect them.

"This contradiction (in government's claim and act) will have some impact (on electoral outcome)," he added.

The former Union agriculture minister also said that farmers were suffering due to risk to their crops. "Soybean and cotton are crucial crops in some regions. Farmers, however, are frustrated by high input costs, pushing them to commit suicide," Pawar said.

According to him, the lack of jobs is another pressing issue in the state. "While the number of educational institutions grew, the number of jobs is dwindling. Youths are struggling with unemployment and the lack of opportunities. Our job is to raise these issues, while the government abuses its power," Pawar added. (PTI)

Rahul makes promises, flies abroad: Amit Shah

MADHUPUR (JHARK-HAND), Nov 16: Taking potshots at the Congress, Union Home Minister Amit Shah on Saturday claimed that the party's leader Rahul Gandhi believes in flying abroad after making promises, while it is only the BJP that fulfils what its guarantees.

Addressing a rally at Madhupur in Deoghar district, the Union Home Minister said that while terrorists not only attacked India but also enjoyed biryani after killing people during the UPA rule, Prime Minister Narendra Modi wiped out terrorists through surgical and air strikes.

"Rahul baba makes promises one after another, but after making promises he flies abroad... But on the other hand, PM Modi's promise is like one etched on stone (patthar ki lakeer). He fulfils what

he promises. BJP fulfils its guarantees and only we can shape Jharkhand. The Congress, JMM and RJD can never work in the interest of the state," he said.

Alleging that the ruling JMMled coalition has turned infiltrators into its 'vote-bank'. Shah declared that illegal immigration will be checked once the BJP is voted to power in the state.

"Infiltrators are posing a threat not only to the tribals but also to the state's youth by snatching jobs and fuelling crime. The Jharkhand High Court had directed to iden-



tify and deport infiltrators. While the Centre agreed, the Hemant Soren government in the state didn't," he claimed.

Shah said that the Jharkhand elections are not to change MLAs, the chief minister or the government but to shape the future of youth and poor and to check corruption.

He said that while Jharkhand powers the nation with coal, the people of the state have remained poor. Shah claimed that if the BJP is voted to power in Jharkhand, the party will make it the most prosperous state in the country in five years. India will become the thirdlargest economy in the world before December 2027, he asserted. (PTI)

PDP chief seeks NC's clarification Focus on winning polling booths: PM after Kharge's remarks on Article 370 MUMBAI, Nov 16: Prime Minis-

SRINAGAR, Nov 16: People's Democratic Party (PDP) president Mehbooba Mufti Saturday sought a clarification from Jammu and Kashmir government after Congress president Mallikarjun Kharge's remarks that his party never talked about restoration of Article 370.

Mehbooba was reacting to Kharge's remarks on the return of Article 370 during a press conference in Pune on Thursday. "This government has been given a huge mandate by the people. They have reposed huge faith in it. (Article) 370 is an emotional issue for the people of J-K, and people's sentiments are connected to it," Mufti told reporters in Beerwah area of central Kashmir's Budgam district.

During the Pune press conference, Kharge said, 'Amit Shah, in his poll rallies, accuses the Congress of spreading lies. (But) He (himself) is saying the Congress wants to bring back Article 370 (in J&K). Tell me, who said that and when?"

"You are raking up an issue. If it (resolution to repeal Article 370) had been already passed in Parliament, why are you raking up the issue again? It means you want to keep the issue alive to divide. If you want to say this, go to Kashmir and say it. Elections are over in Kashmir," the Congress president said.

The PDP chief said the resolution passed by the ruling National Conference (NC) in the J-K assembly asking the Centre to work out a mechanism for restoring special status of the erstwhile state, was vague and not clear on the restoration of Article 370. "The NC and Congress government should clarify. PDP had also said that the resolution was not clear (on Article 370) and it was mentioned vaguely. This government has 50 members, they should have said this while holding their head high," she added. The former J-K chief minister said the resolution should have condemned what was done on August 5, 2019 -- when the Centre abrogated Article 370. (PTI)

BJP claims some Muslim bodies asking community to vote for INDIA bloc



NEW DELHI, Nov 16: The BJP on Saturday alleged that some Muslim bodies are trying to vitiate the poll atmosphere in Maharashtra and Jharkhand by appealing to their community members to vote for the INDIA bloc on the lines of religion, and urged the Election Commission and the Supreme

Court to take action in the matter. Addressing a press conference at the BJP headquarters here, party national spokesperson Gaurav Bhatia said All India Muslim Personal Law Board's functionary Maulana Sajjad Nomani has said that the outfit has decided to support Maha Vikas Aghadi (MVA) on 269 seats and other non-BJP parties on a few seats in Maharash-

Kharge claims not allowed into reserved airport lounge

RANCHI, Nov 16: Congress president Mallikarjun Kharge on Saturday attacked Prime Minister Narendra Modi and Union Home Minister Amit Shah, accusing them of delaying helicopters of his and Rahul Gandhi in Jharkhand, and alleged that despite holding cabinet minister rank, the opposition leaders were not given access to reserved airport lounge.

Congress leader Rahul Gandhi's helicopter, which was supposed to take him from Mahagama in Jharkhand's Godda district after he addressed an election rally there, was grounded for about two hours on Friday, prompting allegations from the Congress that the delay was politically motivated.

Prime Minister Modi was stranded at De-

oghar airport for nearly two hours on Friday and a 'no-fly zone' was declared in the region's airspace as the PM waited for the issue to be resolved, officials said.

"Yesterday, our leader Rahul Gandhi's helicopter was deliberately delayed by two hours as the PM was sitting in his plane. Today, my chopper was delayed by 20 minutes as Union Home Minister Amit Shah was landing. His path was separate and mine was separate.

"Rahul Gandhi ji, who is the leader of the opposition in Lok Sabha, holds a cabinet minister's rank, and so do I. But in airport's reserved lounge, they (officials) say it is for Prime Minister Modi, I want to ask can even a toilet be reserved for the PM," Kharge alleged, without mentioning the name of the airport. Attacking the BJP over the infiltration issue raked by the party, he alleged that Modi and Shah are frightening people despite having the power to check it. "Are PM Modi and Amit Shah sleeping? Why can't they check infiltration despite being in power? When they can stop a helicopter, why can't they stop infiltrators?" he questioned.

Kharge also accused the Centre of using ED, CBI, I-T against those who help the Congress and its allies. He alleged that the BJP wanted to form the government in Jharkhand to loot its natural resources. Further attacking the BJP, he said, "They say 'bant gave toh kat gave' (if divided, we will be wiped out), I say 'dar gaye toh mar gaye' (if you are afraid, you die)." (PTI)

"In Brazil, I will attend the 19th G-20 Summit as a troika member. Last year, India's successful presidency elevated the G-20 to people's G-20 and mainstreamed the priorities of the Global South into its agenda," the Prime Minister said

Modi, Chinese President Xi Jinping and US President Joe Biden will be among the leaders to attend the summit in Rio de Janeiro on November 18 and 19.

India is part of the G20 troika along with Brazil and South

Firefighting equipment at Jhansi hospital 'completely fine': UP Dy CM



LUCKNOW/JHANSI, Nov 16: Uttar Pradesh Deputy Chief Minister Brajesh Pathak on Saturday dismissed media reports that the Jhansi Medical College, where a blaze claimed the lives of 10 newborns, had expired fire extinguishers.

In a statement, Pathak said a fire safety audit was carried out at the medical college in February and a mock drill was conducted in June.

At least 10 children died on Friday night in the Neonatal Intensive Care Unit (NICU) of the Maharani Laxmi Bai Medical College, one of the largest government hospitals in the state's Bundelkhand region, possibly due to an electrical short circuit. Another 16 children are battling for life after being injured in the incident. Some media reports have claimed that the hospital had expired fire extinguishers and faulty alarms.

"The Yogi Adityanath government is standing with the children and their families. Our staff, doctors, and rescue team have worked bravely to save the children. All the firefighting equipment in the medical college was completely fine. A fire safety audit was conducted here in February and a mock drill was also Pathak said in the s cted in Jun ment. Principal of the medical college, Dr Narendra Singh Sengar, also termed as "baseless" the allegations that the hospital had expired fire extinguishers.

In the third and final leg of his trip, Modi will visit Guyana from November 19 to 21 at the invitation of President Mohamed Irfaan Ali. It will be the first ever visit of an Indian Prime Minister to Guyana in over 50 years.

We will exchange views on

giving strategic direction to our unique relationship, which is based on shared heritage, culture and values," Modi said.

NEW DELHI, Nov 16: Himachal Pradesh has moved the Supreme Court seeking authorisation of the appointment of six parliamentary secretaries which was recently quashed by the high court recently for being illegal and unconstitutional.

The Himachal Pradesh High Court had on November 13 quashed the appointment of six chief parliamentary secretaries by Chief Minister Sukhvinder Singh Sukhuled government and declared the law under which they were appointed void.

In its appeal before the top court, the state government said the high court order was "bad in law" and sought a stay on the HC direction.

"The legal consequence would be that six parliamentary secretaries, who are also MLAs, are likely to face disqualification under Article 192 of the Constitution as the protection granted to them from the office of profit norms has been taken away, without adjudication, causing political instability," the appeal filed by the state government said. While quashing the appointment, the high court had also directed that all the facilities and privileges of the six chief parliamentary secretaries be withdrawn with immediate effect.

The high court had declared the Himachal Pradesh Parliamentary Secretaries (Appointment, Salaries, Allowances, Powers, Privileges and Amenities) Act, 2006 as void. Pronouncing the verdict, the high court had said the officials are usurpers of public office and all facilities extended to them be withdrawn with immediate effect.

Army Chief Gen Dwivedi to visit Nepal next week



NEW DELHI, Nov 16: Army Chief General Upendra Dwivedi will embark on a four-day visit to Nepal next week to explore ways to further expand the already close defence and strategic relationship between the two countries.

General Dwivedi is set to be conferred the honorary rank of "General of the Nepal Army" by Nepalese President Ramchandra Paudel during his visit in continuation of an age-old tradition that first started in 1950, reflecting the strong ties between the two militaries.

The Army Chief's visit to Nepal next week will mark another significant chapter in the evolving military diplomacy between the two nations, sources in the defence establishment said.

It is expected to strengthen the defence ties paving the way for continued collaboration on multiple fronts, including military exercises, training programmes and strategic discussions on regional security concerns, they said.

General Dwivedi is set to hold extensive talks with his Nepalese counterpart General Ashok Raj Sigdel besides meeting the top political leadership of the Himalayan nation

The scope and complexity of this exercise are set to be expanded, providing an opportunity to further improve the operational synergy between the two armies. they said.

India has been supporting Nepal in its military modernisation by supplying various forms of military hardware, including small arms, vehicles and advanced training simulators.

Through the Nepal-India bilateral consultative group on security issues, the two countries have held 15 meetings to discuss defence cooperation and several equipment needs have been met under this forum, the sources said.

Industrialist out on bail in Morbi Own-source revenue for panchayats remains low at ₹ 59 per capita bridge collapse case honoured

MORBI. Nov 16: Industrialist Javsukh Patel. the main accused in the 2022 Gujarat suspension bridge collapse that claimed 135 lives, received criticism after he was felicitated at an event organised by the Patidar community in Morbi district.

While the victims' kin expressed anguish over the event, the organisers said that Patel, currently out on bail, was honoured in his capacity as the son of late OR Patel, a philanthropist who founded the Ajanta Group.

Patel was weighed in "modak" (sweet dumpling) on a scale at the function organised by Kadva Patidar Kanya Kelavani Mandal on the outskirts of Morbi town on Friday to mark the 'Pran Pratishtha' of the Uma Sanskardham temple. The modak will be packed in 60,000 boxes and distributed among Patidar families, the organisers said.

"It is a matter of sadness for us to see the main accused in the Morbi suspension bridge collapse being honoured like that," said Narendra Parmar, a member of the association representing victims and their families.

A court recently relaxed Patel's bail condition barring him from entering the Morbi district, making it possible for him to attend the event. His firm Oreva Group was responsible for the operation and maintenance of a Britishera suspension bridge on river Machchhu in Morbi town that collapsed on October 30, 2022, killing 135 persons, including women and children, and injuring 56 others.

"I learnt about Patel's felicitation through a news report and felt sad. He was barred from entering Morbi but secured the court's permission for the event. The incident and losing a child is not something one forgets in his lifetime," said Parmar, whose 10-year-old daughter was killed in the tragedy.

AK Patel, a member of the organisation that held the programme, said they honoured Jaysukh Patel to pay respects to his late father OR Patel, who founded the Ajanta Group, describing him as "the father of wall clocks". "We decided to felicitate Jaysukh Patel and his brothers at the event as a tribute to their father OR Patel's service to society," he said. (PTI)

NEW DELHI, Nov 17: Own Source Revenue (OSR) generation for panchayats remains low, with the income through tax collected by the rural local governance bodies on an average being just ₹ 59 per capita between 2017 and 2022, according to government data. Even as the generation of OSR for panchayats has come into focus to give these rural bodies more financial autonomy, according to the data compiled by the Panchayati Raj ministry, between 2017 and 2022, only an amount of ₹ 5,118.98 crore was raised as OSR by the panchayats.

This comes down to ₹ 59 per capita and ₹ 2.27 lakh per panchayat over the five-year period for 2.25 lakh gram panchayats across the country. The total population coming under these panchayats was more than 86.95 crore in the said period.

Among the states, Gujarat collected the highest amount as OSR at ₹ 829.75 crore, while Kerala came second collecting ₹ 802.95 crore.

Andhra Pradesh, which raised ₹ 791.93 crore, occupied the third position, followed by Karnataka (₹ 627.56 crore), Tamil Nadu (₹ 516.3 crore) and West Bengal (₹ 435.17 crore).

In terms of the per capita OSR raised by the pan-

chayats, Goa topped the list with ₹ 1,635 raised in taxes per person, followed by Puducherry, which raised ₹ 757 per capita. At a one-of-its-kind conclave organised by the Panchayati Raj ministry recently, in which representatives from the 16th Finance Commission participated along with officials from the ministries of Panchayati Raj, rural development, finance, housing and urban affairs, experts and representatives from the state finance commissions and other relevant institutions, the issue of panchayats raising their own resources was discussed

However, according to the information shared by the ministry at the conclave, Arunachal Pradesh, Bihar, Jharkhand, Manipur, Nagaland, Sikkim, Uttar Pradesh, the Andaman and Nicobar Islands, Dadra and Nagar Haveli and Daman and Diu. Ladakh and Lakshadweep are among the states and Union territories that do not have OSR rules.

Andhra Pradesh, Assam, Chhattisgarh, Goa, Gujarat, Haryana, Himachal Pradesh, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Mizoram, Odisha, Punjab, Rajasthan, Tamil Nadu, Telangana, Tripura, Uttarakhand, West Bengal and Puducherry, meanwhile, have framed these rules. (PTI)

NEW DELHI, Nov 16: The government needs to be proactive in addressing the issue of declining reproductive rate and recognising preservation of fertility as a healthcare right is a step in that direction, said Dr Ajay Murdia, the man behind Indira IVF, one of largest fertility chains in India.

A Lancet study projects that India's Total Fertility Rate will dip to 1.29 by 2050, well below the replacement level of 2.1.

"Women are born with about 1 million eggs and unlike other cells in the body, these eggs are neither regenerated nor can they be replaced," Dr Murdia, founder and chairman of Indira IVF told PTI.

By the age of 25, the total number of eggs falls to around 300,000. After 35 years, the decline becomes more rapid

"This biological clock, ticking away like a one-way bank account with only withdrawals and no deposits, has long dictated the timeline of motherhood.

"Yet, in this evolving landscape, a revolutionary solution has emerged, one that is transforming the very essence of family planning: 'Egg freezing', a technology that has now become accessible to women across India," he said.

Dr Murdia said the need for such solutions is clear in India's shifting reproductive paradigm. As women across different segments of society race against time to harmonize family planning with personal and professional aspirations, fertility preservation has become not just important, it has become imperative, the founder and chairman of Indira IVF said.

"What we are witnessing is a societal transformation that demands immediate governmental intervention," he said.

"When women choose to freeze their eggs, they're investing in their future. While we have made strides with initiatives like our partnership with SafeTree to introduce India's first-ever infertility insurance plan offering comprehensive support to couples under 35, we urgently call upon the government to recognize fertility preservation as an essential healthcare right for all Indians."



MUMBAI, Nov 16: Filmmaker Imtiaz Ali says he has always considered Subhash Ghai his Dronacharya as the veteran director's films played an important role in teaching him the art of storytelling while growing up in Jamshedpur.

Ghai launched his memoir, titled "Karma's Child" and co-written by journalist and author Suveen Sinha, at the National Centre for the Performing Arts here on Friday evening. It is published by HarperCollins

'You know about the music of Subhash Ghai films. Music from his films is very popular and touched your heart. He has maintained a beautiful balance between good and popular music.

"Subhash ji came to watch my film 'Socha Na Tha'. He was such a huge personality, and I did not even dare to stand in front of him. Luckily, he liked my film. At that time, the film was in trouble, meaning it wasn't getting the release and needed some money.

"So, Subhash ji bought the TV rights so that the film could be released. His point of view was that the film is nice and lovely; it has to be released. Later, he signed me as well. When I saw him for the first time, he was like a deity who saved me



and released my film." he said.

Ghai, known for films such as "Karma", "Khal Nayak", "Ram Lakhan", "Hero", "Pardes" and "Taal", said he is happy as well as nervous about his memoir.

"Whenever you tell a story in films, sometimes there are good and bad things (attached). You have spoken against some people and you have to agree with some people. So, the era is high and low, the dilemma of the director. I have expressed my experience from my perspective," he said.

The 79-year-old filmmaker said it feels "good" when upcoming directors compliment his films and appreciate his work.

"When I was making those films, I was thinking it was nice, but when an upcoming generation compliments your films, you know it's not the market. Back then it was a market, and now it is real admiration. I feel the genuine admiration has started now," he added. (PTI)



Carlos Alcaraz was the big name missing when the last two semifinal spots were filled at the ATP Finals on Friday.

Alcaraz's 7-6 (5), 6-4 loss to Alexander Zverev meant the French Open and Wimbledon champion — who has been sick this week — was eliminated from the elite, eight-man tournament.



Viktor Gyokeres outscores Haaland, Lewandowski, Kane as striker's price tag hits \$100M

LISBON, Nov 16: Viktor Gyokeres is the Swedish striker whose explosive goal-scoring has made him one of the hottest properties in Europe and could see him become soccer's next USD 100 millionplus player.

Yet, Premier League clubs seemingly missed his rare talent when it was right under their noses. Instead, Sporting Lisbon took a chance on Gyokeres and now stands to make a fortune after plucking him from the second tier of English soccer last year.

"He is ready for something bigger," Sweden coach Jon Dahl Tomasson told broadcaster Viaplay ahead of Gyokeres' hat trick against Manchester City in the Champions League last week. "Everybody likes a goalscorer."

Sporting bought Gyokeres from Coventry City for around USD 25 million. He has gone on to score 66 goals in 68 appearances — including 23 goals in 18 this term and helped Sporting win the Portuguese title last season.

To put the 26-year-old forward's

club statistics into context, this season he is outscoring Robert Lewandowski (19 in 17 games), Harry Kane (17 in 16) and Erling Haaland (15 in 16).

Gyokeres stretches defences with his direct runs and is deadly in front of goal with rasping shots that find the corner of the net with unerring precision.

His impressive numbers have sparked speculation he will soon be on the move again — maybe during the January transfer window — with clubs like Manchester United, City, Arsenal, Barcelona and Paris Saint-Germain (PSG) all reportedly interested. Links to United and City are understandable. Gyokeres' former coach at Lisbon. Ruben Amorim, has just taken over at United. Hugo Viana, Lisbon's outgoing sporting director who signed him from Coventry City, is on his way to City. Gyokeres deflects comparisons to past Sporting greats Cristiano Ronaldo and Luis Figo.

"I try not to compare myself to them. I just want to be myself and

As for this edition, India has reportedly denied travelling to Pakistan for the tournament, and the ICC is working with PCB to find a possible solution to it, including osting it in a hybrid model or shifting the competition out of Pakistan, possibly the United Arab Emirates (UAE) or South Africa.

Sources in the PCB yesterday said the trophy tour was planned in consultation and with the approval of the ICC and it was not a unilateral decision of the PCB.

"If they had issues they should have notified the PCB immediately before announcing the trophy tour. Anyways the PCB as hosts and commercial partners of the ICC is cooperating as always with them,' another source said.

The trophy would now be taken to Islamabad, Taxila, Abbottabad, Murree, Nathiagali and Karachi with the trophy tour ending on November 22. (PTI)
