Currently, subscribers of the Employees' Provident Fund Organisation (EPFO) have to wait for 7-10 days for the settlement of their claims online. After the settlement, the money is transferred to the beneficiaries' bank accounts.

Under the plan, EPFO subscribers will receive dedicated cards that can be used at ATMs to withdraw savings, a top official said, adding that the EPFO is mulling providing services at par with the banking system to its more than 7 crore subscribers.



NEW DELHI, Dec 13: Union minister Nitin Gadkari on Friday said that the Delhi-Dehradun expressway, which is expected to reduce travel time between the two cities to two hours, will be completed within the next three months.


Currently, the travel time between the two cities is five to six

Addressing 'Times Network India Economic Conclave 2024', Gadkari further said that construction of the Delhi-Mumbai Expressway is expected to be completed within two months.

The travel time between the two metropolitan cities is expected to reduce to 12 hours with the completion of the expressway from the present 24 hours. The road transport and highways minister said Delhi-Dehradun highway project

has two packages. "A ₹ 10,000 crore project has been approved for Delĥi's Kalindi Kunj, extending to Faridabad. Prime Minister Narendra Modi is set to inaugurate the project within

the next 15-20 days," Gadkari said. Gadkari also said that the Modi government is working to reduce air pollution, lower the import of



fossil fuel and enhance farm in-

"The transport ministry is responsible for 40 per cent of the air pollution... While a huge part of pollution is due to stubble burning in neighbouring states of Punjab and Haryana, road construction and fossil fuels also add to the annual problem," he said.

The minister also pointed out that the problem of stubble burning will be solved in two years as the government is working on 400 projects that will convert 200 lakh tonnes of rice straw every year to alternate fuels.

Gadkari said that his ministry is

working on 36 green express highways, which will help reduce the

logistics costs in the country. "India's logistics cost is 14-16 per cent compared to 8 per cent in China and 12 per cent in the US and European Union. We aim to bring this down to 9 per cent in two years," he said.

According to the minister, this will push India's exports by 1.5 times and help us become more competitive.

About the increasing number of road accidents in India, Gadkari said India is the Number 1 in the world in terms of deaths due to road accidents with 1,78,000 deaths from 5,00,000 accidents a year due to faulty road, poor enforcement of law and lack of education and awareness.

"Despite trying hard over the last 10 years we have not succeeded in reducing road accidents

in the country," Gadkari admitted. The minister emphasised that his ministry's recent initiatives on

The official in Ontario Premier Doug Ford's government said on Thursday that it's contemplating restricting Ontario's liquor control board from buying American-made alcohol.

Ontario is also considering restricting exports of critical minerals required for electric vehicle batteries and preventing US-based companies from the government's procurement process, the official said on condition of anonymity because the functionary wasn't authorised to speak publicly about the potential meas-

Ford confirmed on Wednesday evening that Ontario s contemplating restricting electricity exports to the three states. He reiterated that on Thursday and said it would make electricity unaffordable for Americans.

"It's a last resort," Ford said. "I don't think President-elect Trump wants that to happen. We're sending a message to the US If you come and attack Ontario, you attack the livelihoods of people in Ontario and Canadians, we are going to use every tool in our tool box to defend Ontarians and Canadians. Let's hope it never comes to that.

Hope for survival of secularism

alt all fresh suits, proceedings, and orders in relation to the Places of Worship (Special Provisions) Act 1991, ordered a three-judge bench of the Supreme Court of India on December 12, implications of which will be far reaching since it would transcend beyond the legal boundaries to the social and political life of the people of the country. The order has kindled a new hope of survival of secularism in its battle with communalism being attacked socially, politically, and legally by the Hindutva forces, though the Places of Worship Act has a bar against raising such issues. Altogether 18 cases filed by the Hindutva forces claiming as many as 10 Mosques or Dargahs were pending in various courts across the country, despite the Ayodhya Verdict of 2019 had upheld the Places of Worship Act with the ultimate objective of not allowing the incidents of the distant past in the history going back to the 16th Century AD any destruction of the present and future of the people now. An oversight of the real objective of the Places of Worship Act by a former CJI D Y Chandrachud in 2022 paved the way for mushrooming growth of cases against the Mosques and Dargahs, because he said that there was no bar on ascertaining the nature of places of worship under the said Act, though it bars changing their character with a cut-off date of August 15, 1947, when India became independent. In the current order, CJI Sanjiv Khanna led three-member bench has cor-

Since the ruling establishment at the Centre have been pursuing the Hindutva agenda, the halt order of the Supreme Court is significant, especially given Centre's attitude in this matter that has been exposed in the court. What is lying ahead is a matter of imagination. When the senior advocate Vikas Shing sought a reference to a five-judge bench, Chief Justice Khanna said that the court would consider this case in the light of the five-judge bench which delivered the Ayodhya Verdict of November 2019. Ayodhya verdict had not only upheld the Places of Worship Act but had also observed that "for any person who seeks solace or recourse against the actions of any number of ancient rulers, the law is not the answer". The freeze order that bars courts registering fresh suits or passing orders in pending cases seeking to "reclaim" Hindu temples destroyed by Mughal "invaders" in the 16th century was passed amidst interruptions by the petitioners representing Hindutva forces is also significant. The order will remain in force until the bench hear the petitions challenging the validity of the Places of Worship Act.

By the halting order, the Supreme Court bench, comprised of CJI Sanjiv Khanna, Justice P V Sanjay Kumar, and Justice K V Vishwanathan, has not only protected the Places of Worship Act but the 'basic structure' of the Constitution of India which stands on secularism. At this point of time, Supreme Court order has just given a little hope to secularism to survive the onslaught of communalism in India, but there is a long social, political, and legal battle ahead

Gunotsav and it's impact on Assam's education

nadequate infrastructure, heterogeneity in the quality of teaching and, above all, a large disparity in educational results across urban and rural schools. Gunotsay, an ambitious initiative launched by the Assam government in 2017. However, Gunotsav is not only a tool for assessment, but is a general master plan for the development of a continuous process of education and a culture of responsibility and excellence in its schools. The core or whole of Gunotsav is the combined or complete assessment of the school. Traditional models relied heavily on standardized test scores as the sole indicator of school performance. But, on the other hand, Gunotsav elevates this perspective by integrating multiple layers (such as the strategy for instruction, students' engagement, the quality of facilities, and community involvement). This multifactorial appraisal has been a revolution, allowing us to see what weaknesses and strengths schools have and how to apply interventions that are focused and relevant to the local context. The program has been instrumental in demystifying the technical aspect of the problems schools face, and in developing solutions that are as well as responsive to school needs, thereby delivering significant and sustainable improve-

One of the focuses of Gunotsav has been an improvement in the quality of instruction. It is generally agreed that teaching effectiveness plays a significant role in positive student learning. Just prior to the introduction of Gunotsav, teaching quality in parts of Assam was inconsistent with, in fact, often with the negative impact of lack of training and exposure to modern teaching practices. Evaluations performed by Gunotsav have brought to light the defiprompted governmental intervention (and educational courses for professionals) with which to guarantee that the teachers have the compe-

tences necessary to keep pace with



pedagogical techniques. As interactive and student centred approaches to teaching and learning, these courses have, moving beyond the traditional rote drudgery in the classroom, inspired curiosity and critical thinking and the creation of knowledge and knowledge work as well as the development of understancings. The outcome is an educational environment where the student is the final learner and, as a result, achieves a higher cognitive development and a higher learning

and-learning dependent context, higher proportion of attendance and a beneficial effect on education and child development. Gunotsav has also played a major role in encouraging motivations for community involvements as a desirable component in learning process achievement. One of its more peculiar characteristics is the fact that school assessment might involve the local parents and other stakeholders. Even the participatory concept implies that, when it comes to education, it is not the school's entitlement, like that of a family and community. But if the parents and community leaders rise then it is possible to provide a supportive context in which the students can see that education is truly the means to give value to their lives. In this activity, the student learning is systematically valued and progressed to a reverberation that reaches beyond the classroom walls. Schools now assume an even greater responsibility for statutory responsibilities, for community for the good of that statutory responsibility, and so contributes to a climate of trust and cooperation in order to achieve sustained educational enhancement.

For instance, a description of student achievement has been newly proposed as a cycle of Gunotsav as its cause. One of the benefits of this curriculum is to take the classroom out of a box

and offer a degree of educational route more broadly by considering how potential developmental students of skills might be acquired outside of the classroom setting. This also covers the acquisition of co-curricular activities, reinforcement of problem-solving abilities and more general ability promotion that are of highest concern in the development of the individual and in the specific profession. As it promotes a healthy equilibrium between academic difficulty and holistic growth, Gunotsav develops its students to be better equipped to face the challenging real life problem situations and produces an adaptable, resourceful and very intelligent generation of thinkers. This model conforms to global educational trends, which do not emphasize memorization and test results, but rather focus on the development of skills and personal growth, continually expand-

ing and adapting to the life experiences accumulated on the road.

Despite the success of Gunotsav, the presence of implementation has resulted in the lack of

uncomplicated progress without some challenges. Due to the variability of Assam socio-economic context, it is a considerable hurdle since schools are spatially diverse in the various parts of the state with varying school-communitycommunity-resource-spread and thus varying access to and use of resources. Although urban schools have apparently better access to resources and equipment, rural schools have for generations been trying to finish the essential task of daily functioning. Implementation of the program relies on correcting this imbalance and ensuring that benefits from the change are fairly shared and uniformly distributed. Ongoing monitoring, financial and political support are all needed in iliending these challenges and keeping the program viable. This may be constrained by the limitations of resource delivering a very low increase rate, nevertheless by

taking this approach it could be hoped that encourage a platform of transparency and accountability at least will give a base from which agile steps can be taken even if funding is tight.

The approach of Gunotsay model has implications that extend beyond Assam itself, and might serve as a model for other regions which are challenged by an education dilemma as challenging as that posed by Assam itself. The study points to the necessity of a counterbalancing approach to school assessment â€an assessment that gives equal prominence to qualitative and quantitative data. That it is an inclusive, situationally appropriate and combined paradigm, which gives equal prominence to the following dimensional elements teachinglearning quality, infrastructural and community involvement in the approach, is theorized, to however, arise, due to its particular atquality, infrastructural and community involvement. It demonstrates that it is possible to produce substantial change when the evaluations are comprehensive and the interventions are unique and when all those who contribute to the process of change are involved.

Gunotsav has fundamentally redefined educational standards in Assam. The shift from a narrow interpretation of test scores to a more encompassing, integrative interpretation of the school itself has established a new standard of what school improvement should entail. Changes in pedagogical practice, indedction, and in community involvement have played their own significant role in the evolution of a school system able to respond to the needs of the students. With this unifying plan, the school reforms developed by Gunotsav have been ensured that it is not an isolated project but it has been used to foster continuous change. The experience in its application offers relevant teaching experiences on the ways in which educational tasks can be adjusted in order to address the demands of a changing society, but also includes the unique features of heterogeneous educational systems.

Overall, Gunotsav has not only served as a means of evaluation, i.e., albeit Gunotsay functions as such, in itself, but rather as a movement, which in its own right advocates for the continual development and a shared commitment to educational quality. The effect is that of the wider lesson that educational quality is not single-dimensional, and that it is addressed by more than just the delivery of academic learning, but also by inbuilding learning, teacher provision, and community provision. Advanceing a legacy that began with Gunotsay, the initiative is a lasting example that educational reform is a process that has bloomed from collaboration, innovation, and deep and persistent commitment to renewal. One Nation, One Election: Transforming India's democracy

ne Nation, One Election is an idea that has been widely discussed in India for many years. It aims to hold simultaneous elections for the Lok Sabha (the national Parliament) and all State Legislative Assemblies across the country. This proposal suggests that instead of having elections frequently in different states and at the national level, a single, synchronized electoral process should take place once every five years. This concept has been proposed as a way to save time, money, and resources, and to make governance more stable and effective. It is an ambitious idea that could bring significant changes to the Indian political and administrative system if implemented.

India is the largest democracy in the world, with elections playing a vital role in shaping its future. After techie suicide, top court sets eight points for correct alimony

and hopping mad on the hot tin inally, the cat is out of the bag roof! Techie Atul Subhash, 34, strung himself up like a ceiling fan and left a placard with the three words 'Justice Is Due'. Atul Subhash also left a 24-page suicide note and an audio-video explanation on why he killed himself and who abetted the suicide, bringing into focus the female-male divide into sharp focus? Nobody assisted Subhash in placing the noose around his neck, but he did affirm that his estranged wife and her relatives drove him to suicide. There was massive inducement and a big

On Monday, Atul Subhash hanged himself to death in his Bengaluru home and the Bengaluru cops lodged a case of abetment to suicide against Subhash's wife Ankita Singhania and her mom Nisha Singhania, brother Anurag and Nikita's uncle Sushil; also the judge who cackled when Ankita told Subhash to go kill himself and not bother her with sobstories

Subhash's mom and dad and bro are beyond inconsolable and the mom fainted while the dad noted, with sad reality, that his son wasn't the sort who would commit suicide, he was too much the independent

So, a lot of provocation and lots more of abetment went into the suicide, which is a crime. Why, even killing oneself is a crime. Both Atul as well as Ankita Singhania have cases lodged against them after the rather dramatic suicide, funny!

But, death is no laughing matter, what's funny is the snail-like pace of the Bengaluru Police in taking action. If it was a man prodding a woman into committing suicide, the cops would have done a Usain Bolt to take action. No wonder the male of the species stands little chance against the female of the species, in court or outside court.

There is something very 'insect-like', everybody is aware, certain female critters are known to feast on their male mates after a round of procreation. Isn't it a fact, AnkitaSinghania separated from Atul Subhash after she became the mother of his son?

Didn't she walk out on Subhash, taking the son along with her? Ankita went to her mum's house in Jaunpur in Yogi Adityanath's Uttar Pradesh and Atul Subhash's role was over, except that he felt like he was an ATM for Ankita and Ankita wouldn't let him spend time with his son.

Yup, cruelty has a face and cruelty wears lipstick! Ask the feminists and they will throw a tantrum. Don't for-

get the role of the divorce lawyer with a private detective thrown in for good measure. Atul Subhash walked into the parlour like so many other "suckers" before him and so many others after him.

But Atul refused to be Ankita's ATM and Ankita flooded him with cases of dowry harassment and domestic violence. Even the death of her father from cancer was blamed on Subhash! She let him understand, once and for all, who wore the pants – of course, 'She!'

At one time, Atul Subhash was living perpetually in the courtroom, travelling 40 days in a month of 30 days! From Bengaluru tech city to the Jaunpur family court! Atul Subhash was deadbeat as well as dead-

One of his Bengaluru friends says Atul Subhash made ₹ 14 lakh a month and had been planning to kill himself from July 2024 per the hints in the writings he left behind...Eerie because there is a Stephen King 9/11 story about the "things people left behind" after Mohammad Atta and his pals beat down the twin towers of the World Trade Centre.

Dead people live their spoor! Atul Subhash was no exception. He wanted payback from Ankita and her family for making him feel like a heel. He was not only a victim but

also the butt of gallows humour – black as the nights in the afterlife must be.

Techie Atul Subhash couldn't lift a heel without dockets hanging from his calves and the number of sections jotted against his name, anybody could make a noose of them – Section 498 to, perhaps, Section 306 to, maybe, Section 304...Ask the feminist lawyers or the lady judge who laughed at him and killed him with cruel words

Will the offending lady judge who laughed at Atul's helplessness be judged? Will Ankita Singhania be taken to court and tried till she confesses to driving Atul Subhash to committing suicide — as also her mom and her brother? News says Ankita has been sacked from her techie job and she's staring at a paycheck-less future.

'Subhash's death has also left Ankita high and dry. No more alimony; no more money in the bank @ of ₹ 100,000 per month, month after month – the woman did not know how well she was set, thanks to a jovial guy with a fat techie salary.

Ankita Singhania's hunger for easy money has done her in. Atul Subhash didn't want any more of her. He took decisive action, one she thought he didn't have the guts to take. From 'ATM' to 'Zero Alimony' didn't take too long, did it?

And the Supreme Court has taken notice, or at least that is how it looked like when the top court asked courts across India to base their orders on cases of misuse of dowry laws on eight factors, broadening the debate on the gender-bias that plagues cases filed by wives against their bushouds.

The eight points of reference are: Social and economic status of husband and wife; basic needs of wife and children in the future; qualification and employment of both parties; means of income and property; wife's standard of living while living in in-laws' house; has she left her job to take care of the family? Reasonable amount for legal battle for a wife who is not working and, last, what will be the financial status of the husband, his earnings and other responsibilities along with alimony?

Has Atul Subhash's death been in vain? Atul's soul might be stranded between here and there in the hereafter, but his soulless tormentors wouldn't be sleeping any easy even if the system works for them. There's a sneaking feeling Atul Subhash took the easy way out. He could have flown off to the Bahamas or booked a seat in a SpaceX flight to the Restaurant at the End of the Universe! 

Biden watching situation in **Bangladesh very closely: White House**



WASHINGTON, Dec 13: President Joe Biden is closely monitoring the situation in Bangladesh and the US will hold the country's interim government accountable for ensuring the protection of religious and ethnic minorities, the White House has said.

The security situation in Bangladesh has been difficult following the ouster of the former prime minister Sheikh Hasina, White House National Security Communications Advisor John Kirby said.

"And we have been working closely with the interim government to enhance the capability of their law enforcement and security services to deal with the challenge," Kirby said at a news conference on Thursday

Hasina was ousted as prime minister in the face of a massive anti-government protest in August. There have been a spate of incidents of violence against Hindus and other minorities, as well as at-

tacks on temples in the last few weeks in

"We've been very clear in our engagement with all Bangladeshi leaders that protection of religious and ethnic minorities is absolutely critical, and the leaders of the interim government have repeatedly committed to providing security to all Bangladeshis, regardless of religion or ethnicity,"

"We want to hold them to that," Kirby said in response to a question.

Over the past few weeks, Indian Americans have

held peaceful protests and marches in several cities, including in front of the White House, in Chicago, New York, SFO, Detroit, Houston and Atlanta, urging Biden to help stop alleged brutalities against the minority Hindu community in Bangladesh.

Earlier in the day, Indian-American Congressman Raja Krishnamoorthi urged members of the Senate Foreign Relations Committee to address the issue of violence against minorities, primarily Hindus, in Bangladesh during the confirmation hearing of Senator Marco Rubio for the position of secre-

President-elect Donald Trump has nominated Senator Rubio for the top diplomatic position. The missiles, including 11 cruise missiles date of his confirmation hearing has not been an-

"As targeted violence against Hindus and other earlier this year, Zelenskyy said. minorities continues amid the disorder in Bangladesh, I urge the members of the Senate's Committee on Foreign Relations to address this crisis directly during the upcoming hearings to confirm Senator Rubio as the next US secretary of state," Krishnamoorthi said.

Over the weekend, a large number of Indian-Americans held a march from the White House to is needed: a massive strike – a masthe US Capitol over alleged attacks on Hindus in Bangladesh.

Raising slogans like "We want Justice" and "Protect Hindus", the demonstrators urged the war might unfold next year. Russia targets Ukrainian infrastructure with a massive attack by cruise missiles and drones

massive aerial attack against Ukraine on Friday, firing 93 cruise and ballistic missiles and almost 200 drones, Ukrainian President Volodymyr Zelenskyy said, describing it as one of the heaviest bombardments of the country's energy sector since Russia's full-scale invasion almost three years ago.

Ukrainian defences shot down 81 that were intercepted by F-16 warplanes provided by Western allies

Russia is "terrorising millions of people" with such assaults, he said on his Telegram channel, renewing his plea for international unity against Russian President Vladimir

"A strong reaction from the world sive reaction. This is the only way to stop terror," Zelenskyy said.

But uncertainty surrounds how the dent-elect Donald Trump, who takes office next month, has vowed to end the war and has thrown into doubt whether vital US military support for Kyiv will continue.

In Moscow, the Defence Ministry said the Russian military used longrange precision missiles and drones ergy facilities in Ukraine that ensure the functioning of the military industaliation for Wednesday's Ukrainian attack using US-supplied the Army Tactical Missile System, or AT-ACMs, on a Russian air base, it said.

Trump said in an interview published in TIME magazine on Thursday that he was against allowing Ukraine to hit targets on Russian soil using US provided weapons.

Kremlin spokesman Dmitry Peskov said Friday that Trump's stance "conforms to our position."

"In this case, we have a shared vision of causes of escalation and that is positive. Obviously, Trump realises what escalates the conflict." Peskov told reporters.

The US Embassy in Kyiv said Friday's attack also targeted transport networks and other key facilities.

Ukraine's biggest private energy company, DTEK, said the attack "seriously damaged" its thermal power plants. Russia has repeatedly attempted to cripple Ukraine's electricity system in an effort to break the will of civilians left in the dark with no running water or heating and to disrupt Ukrainian defence manufac-

Ukrainian Energy Minister Herman Halushchenko said energy workers were doing everything necessary to "minimize negative consequences for the energy system," promising to release more details on damages once the security situation allowed it.

Ukraine's air force reported multiple strike drones launched at Ukraine overnight followed by swarms of cruise missiles in the country's air space. It said Russia also used airlaunched ballistic Kinzhal missiles against Ukraine's western regions.

A similar massive attack on November 28 involved about 200 misuntil emergency teams restored sup-

Ukrainian officials have warned that Russia is stockpiling cruise and


ballistic missiles for more attacks. On November 21, Russia for the first time used an intermediate range hypersonic ballistic missile to strike an industrial plant in the city of Dnipro, in eastern Ukraine. Putin described the attack with the Oreshnik missile as retaliation for Ukrainian strikes on Russian territory with longer-range Western weapons.

He declared that more attacks with the new weapon could follow, and US officials warned Wednesday that the Oreshnik could be used again in coming days. There was no immediate sign one was launched in Friday's attack. Around half of Ukraine's energy infrastructure has been destroyed during the war, and rolling electricity blackouts are common and widespread.

Kyiv's Western allies have provided Ukraine with air defence systems to help it protect critical infrastructure, but Russia has sought to overwhelm the air defences with combined strikes involving large numbers of missiles and drones called "swarms."

Russia has held the initiative this year as its military has steadily rammed through Ukrainian defences in the east in a series of slow but

Suspected Chinese spy with business ties Ukraine's reformed military procurement to Prince Andrew barred from UK



LONDON, Dec 13: A suspected Chinese spy with business ties to Prince Andrew has been barred from the UK because of concerns he poses a threat to national secu-

A British immigration tribunal upheld the decision on Thursday in a ruling that revealed the Chinese national had developed such a close relationship with Andrew that he was invited to the prince's birthday party. Government officials were concerned the man could have misused his influence because the prince was under "considerable pressure" at the

time, according to the ruling. British authorities believe the Chinese national, whose name wasn't released, was working on behalf of the United Front Work Department, an arm of the Chinese Communist Party that is used to influence foreign entities.

The government determined that the businessman "was in a position to generate relationships between senior Chinese officials and prominent UK figures which could be leveraged for political interference purposes by the Chinese State," according to the tri-

Prince Andrew, the younger brother of King Charles III, has been repeatedly criticised for his links to wealthy foreigners, raising concerns that those individuals are trying to buy access to the

Andrew's finances have been was forced to step away from royal duties and give up public funding amid concerns about his relationship with Jeffrey Epstein, the American financier and convicted pedophile who committed suicide in prison in 2019.

British intelligence chiefs have become increasingly concerned about China's efforts to influence UK government policy. In 2022, Britain's domestic intelligence service, known as MI5, warned politicians that a British-Chinese lawyer had been seeking to improperly influence members of

Parliament for years. A parliamentary researcher was arrested in 2023 on suspicion of providing sensitive information to

The 50-year-old Chinese national covered by this week's ruling was described as a man who worked as a junior civil servant in

China before he came to the UK as a student in 2002. He earned a master's degree in public administration and public policy at the University of York before starting a business that advises UK-based companies on their operations in

He was granted the right to live and work in the UK for an indefinite period in 2013. Although he didn't make Britain his permanent home, the man told authorities that he spent one to two weeks a month in the country and considered it his "second home."

He was stopped while entering the UK on November 6, 2021, and ordered to surrender his mobile phone and other digital devices on which authorities found a letter from a senior adviser to Andrew confirming that he was authorised to act on behalf of the prince in relation to potential partners and investors in China.

Western officials are closely monitoring DOT, three Western diplomats told The Associated Press. So far, they have been pleased with the results one year



since it was formed. They spoke on condition of anonymity in order to speak freely about their assessments

DOT embodies the uneasy coexistence of a digital-savvy youthful ethos and paper-heavy post-Soviet bureaucracy. Its office exudes a fresh startup culture vibe, while catering to one of the most stubbornly rigid ministries in the country.

The contrast underscores the spirit of how Russia's war in Ukraine is being fought, in which innovative drone wars coincide with World War II-style trenches.

'We understand that we have been on the radars of NATO, of G7 (Group of Seven) countries, of all NATO member countries in terms of whether we manage or not to put in place a procurement system that is resilient, that is effective, efficient, and that is not prone to corruption," Zhumadilov

Nonlethal military purchases became the focus of two corruption scandals under the leadership of Oleksii Reznikov, the previous defence minister. The first involved inflated prices for food supplies and the other was connected to low-quality winter jack-

Umerov, Reznikov's successor. has described DOT as not just a new agency, but as the beginning of a new public procurement architecture in Ukraine's defence sector. Ukrainian President Volodymyr Zelenskyy specifically tasked Umerov to increase transparency in defence procurement where corruption has always been rife.

Zhumadilov, an influential public figure with Crimean Tatar origins known for spearheading reforms in public procurement, was selected because of his previous track record of success. He previously headed Ukraine's procurement of medical supplies.

Plastered on the wall of the agency is a mood board devised by the company's marketing department.

DOT's answer to increasing transparency is DOT-Chain, an IT

system that manages the army's supply demands by digitising the entire process, from the submission of applications to issuing invoices. Developed by a team of DOT IT specialists, it could reduce delivery time fourfold and is the largest digital project in the institution. For now it will cover foodstuff, but Zhumadilov envisions scaling it up.

There were blips on the road. A planned merger with the Defence Procurement Agency, the state company in charge of purchasing lethal military supplies, was aborted after NATO officials recommended against it, casting Umerov's decision-making in negative light.

Acknowledging that corrupt practices in defence purchases has plagued Ukraine for years, Umerov has said the state needed to eliminate the "Soviet, oliapproach to public

But, like most things in the war, that is easier said than done.

Zhumadilov said their company still faces resistance from ministry officials set in their old ways.

"We are trying to be open to our colleagues at Ministry of Defence and the Armed Forces of Ukraine, but at the same time, and this is also good news, we are an autonomous agency within a larger ecosystem, we can preserve our own culture here.

DOT-Chain, which was designed to lower the burden of army paperwork, for instance, still faces pushback from bureaucrats who prefer signing thousands of papers per week to clicking a smartphone.

"They say that we don't need that. We just want to keep on signing papers," he said. "We are saying, Look, the sheer amount of papers that you are signing on a weekly basis ... it is just unsustainable." (AP)

No problem with Adani funding Colombo Port project with own resources: Sri Lankan minister

Rathnayaka, however, said the

government is still opposed to another Adani project -- the wind power project in the northeastern district of Mannar -- as it was against Sri Lanka's interests.

'The president and the government have informed the court our reasons to oppose it,' Rathnayaka said, referring to fundamental rights petitions filed against it by environmentalists.

President Anura Kumara Dissanayake in his campaign rallies for the September 21 presidential election had vowed to cancel Adani Green Energy's wind power project in Mannar. (PTI)

WASHINGTON, Dec 13: Four Indian-Americans facing sentences ranging from 17 years to life imprisonment are among nearly 1,500 people granted clemency by President Joe Biden.

These four Indian-Americans are Meera Sachdeva, Babubhai Patel, Krishna Mote and Vikram Dutta."America was built on the promise of possibility and second chances. As President, I have the great privilege of extending mercy to people who have demonstrated remorse and rehabilitation, restoring opportunity for Americans to participate in daily life and contribute to their communities, and taking steps to remove sentencing disparities for non-violent offenders, especially those convicted of drug offences," Biden said in a statement on Thursday. "That is why, today, I am pardoning 39 people

who have shown successful rehabilitation and have shown commitment to making their communities stronger and safer. I am also commuting the sentences of nearly 1,500 people who are serving long prison sentences - many of whom would receive lower sentences if charged under today's laws, policies, and practices," he said.

This was the largest single-day act of clemency

in recent times. In December 2012, Dr Meera Sachdeva was sentenced to 20 years in prison and ordered to repay nearly USD 8.2 million for fraud at a former Mis-

sissippi cancer centre she ran. She is now 63. Babubhai Patel was sentenced to 17 years on 26 convictions for a healthcare fraud conspiracy, a drug conspiracy, and related fraud and drug violations in 2013. Also in 2013, Krishna Mote, 54, was sentenced to serve life in prison after he was convicted of conspiracy to distribute more than 280 grams of crack cocaine and more than 500 grams of cocaine, and distribution of crack cocaine as an aider and

Vikram Dutta, 63, was in January 2012 sentenced in a Manhattan federal court to 235 months in prison after he was found guilty of conspiracy charges stemming from his use of his perfume distribution business to launder millions of dollars for a Mexican narcotics organisation. (PTI)

NEW DELHI, Dec 13: Accusing the Congress of always choosing "satta" (power) over the Constitution, senior BJP leader Rajnath Singh on Friday said the opposition party never tolerated autonomy of institutions and tried to destroy constitutional principles and spirit.

Initiating a two-day debate in the Lok Sabha on "Discussion on the Glorious Journey of 75 Years of the Constitution of India", the defence minister said the Congress has sought to project the Constitution as its own contribution, while deliberately ignoring the contribution of several leaders.

"The talk of protection of the Constitution does not seem appropriate coming from it (Congress). These days, I see that many opposition leaders keep the Constitution in their pockets. Actually, this is what they have learnt from childhood, they have seen their families keep the Constitution in their pockets for generations," he said.

The Bharatiya Janata Party (BJP), on the other hand, always bows before the Constitution and has never played with the independence and autonomy of institutions, Singh asserted, drawing some jibes from the members of the opposition benches during a speech that was largely heard in attention.

The seasoned parliamentarian said the Congress, during its decades in power, often amended the Constitution with a malicious spirit to change it gradually, while the Narendra Modi government has effected amendments to strengthen its fundamental values and for people's empowerment.

Whenever there was a choice, the Congress chose power over the Constitution, he claimed.

It always tried to "hijack and appropriate" the framing of the Constitution, Singh said, highlighting the imposition of Emergency, dismissal of many state governments and superseding of Supreme Court judges for "standing up" to the then Indira Gandhi government to

The Modi government has ensured that the Constitution is applicable in Jammu and Kashmir by repealing Article 370, he added amid thumping of benches by the BJP-led National Democratic Alliance (NDA) members.

Without naming the Hindu Mahasabha, Singh said "many big leaders" had, in 1944, come out with "The Constitution of Hindusthan Free State" to share their ideas about the Constitution India should adopt after its independence. They had called for ensuring citizens' religious freedom and said that the State must be secular, he added. The Congress dubbed those leaders as communal. Singh said. slamming it for overturning a Supreme Court judgment to deny alimony to a divorced Muslim woman for its "appeasement politics". The Constitution is an expression of the general will of the people, he said. "We must also remember those who were not part of the Constituent Assembly but whose ideas are part of it (Constitution). We must remember Pandit Madan Mohan Malviya, Lala Lajpat Rai, Bhagat Singh, Veer Savarkar and several other such icons whose ideas strengthened the Constitution," he added.

"Our Constitution touches upon social, economic, political, cultural lives and shows the way for nation building. It is the outcome of a series of historical events," he said.

Singh's mention of the country's first prime minister, Jawaharlal Nehru, a persistent target of the BJP's attack over the years, as one of those who contributed to the making of the Constitution drew rare cheers from the opposition benches. The BJP leader, though, later also charged Nehru with amending the Constitution to override a Supreme Court judgment for

NEW DELHI, Dec 13: The opposition move to seek impeachment of Vice President Jagdeep Dhankhar led to pandemonium in the Rajya Sabha on Friday, with opposition and treasury benches clashing and the Chairman too wading into the issue.

The proceedings of the House, which have been marred because of the issue and the Adani controversy, were adjourned in the first hour itself but not before Dhankhar, saying he was a farmer's son and he will not "show weakness".

"Day in and day out there is only a campaign against the Chairman....it's a campaign not against me, it's a campaign against category to which I belong," he as-

"I am personally pained for a reason that the main opposition party has put is as a blitz as a campaign against the Chairman. They are entitled to bring motion against me. This is their constitutional right but they are deviating from the constitutional provisions...,'

The Chairman, before adjourning the proceedings at around 11.45 AM till Monday, appealed to Leader of Opposition in the House Mallikarjun Kharge and Leader of the House J P Nadda to come to his chamber for finding a way out to end the logiam.

"I appeal to you Khargeji, please spare time, accept my



prayer, see me in my chamber today. Same request I am making to the Leader of the House also...I will try to navigate things so that we are able to work as member of the House. I would expect Kharge Ji to respond. Lets us meet in my chamber and find a way out," Dhankhar said.

To this, a visibly angry Kharge retorted: "How can I respect you. You are insulting me".

As he was speaking, the Chair adjourned the proceedings till

Trouble arose after BJP's Radha Mohan Das Agrawal raised a point of order and narrated the procedure related to the no-confidence motion against Vice President of India, who is an ex-officio Chairman of the Raiva Sabha.

Agarwal spoke at length on the impeachment notice given by the

opposition parties, calling it an insult to the nation and the chair of the Vice President and farmers. He said the notice as the rules

specify is to be taken up after 14 days but the Congress leaders have gone to the press with allegations. The Congress, he alleged, has a history of "insulting Presidents and Vice Presidents"

Jawaharlal Nehru, as the country's first prime minister, used to "continuously insult President Rajendra Prasad", he alleged. He went on to add that Prasad was not given a cremation in the national capital and was even deprived of

medical facilities when he was ill. "Nehru asked (the then President) Sarvepalli Radhakrishnan not to attend Prasad's funeral in Patna. But Sarvepalli Radhakrishnan did not listen to the Prime Minister and he went for the fu-

neral (of India's first President)," he alleged.

He said leader of the opposition Kharge should have waited for 14 days as per rules for the no confidence motion to be taken up and then spoken on the subject but instead he has been making allegations against Dhankhar through

press statements and social media. "Congress has no faith in the Constitution," he said.

"He (Kharge) had made 10 allegations (against Dhankhar)... 10 Janpath ki chatukarita mein 10 aaroop (10 allegations in sycophancy of 10 Janpath - the residence of Congress leader Sonia Gandhi)."

He demanded that his breach of privilege motion against the 60 opposition MPs who signed the no confidence motion be taken up and the chair should initiate action against them.

Surendra Singh Nagar (BJP) said the Congress party is "antifarmer", "anti-OBC" and the country will not forgive it for this act of its

Neeraj Shekhar (BJP) said the Congress doesn't want any son of farmer, Dalit or poor to progress.

"They are making personal remarks (against Dhankhar)," he

Kiran Choudhary (BJP) said the act of Congress through the noconfidence motion has shown their "anti-farmer" attitude. "They work only to save one family.

Amid the din, opposition Con-

gress MPs tried to make their point.

Dhankhar finally allowed Pramod Tiwari (Cong) to speak.

Tiwari said if the chairman was a son of farmer, the Leader of the Opposition Kharge is a son of farm labourer and a Dalit, who is not being allowed to speak.

Just as he brought a reference to the ruling side trying to save a billionaire, who is facing bribery allegations in the US, Dhankhar interjected to say nothing will go on record.

Dhankhar said, "Kisan ka beta hoon, kamzori nahi dikhaoga (I am son of the farmer, I will not go weak)" "I have tolerated enough," he said, adding the opposition parties have to wait for 14 days before the motion brought by them can be discussed.

"It will come after 14 days," he said. The treasury benches created ruckus when the floor was given to the opposition leaders to make their point.

When Kharge was give the floor, he alleged that the Chairman was purposely encouraging BJP members and giving more time to

"Make them sit. We have not come here to listen praises for you," the Congress President said.

Earlier, Dhankhar said he has received four notices under Rule 267 that seek to set aside business of the day to take up the issue being sought to be raised. (PTI)

Efforts being made to reduce minorities, especially Muslims, to 'second-grade' citizens: Akhilesh

NEW DELHI, Dec 13: Samajwadi Party chief Akhilesh Yadav alleged Friday that efforts are underway to reduce the country's minorities, particularly Muslims, to "secondgrade" citizens, and claimed their rights and properties are being systematically eroded.

Speaking in Lok Sabha during a debate on the 'Glorious Journey of 75 Years of the Constitution of India', Yadav charged the government with fostering inequality and failing to uphold the constitutional rights of marginalised commu-

"This Constitution is our armour, our security. It provides us strength whenever needed. The Constitution is the true guardian of the rights of the oppressed, neglected, suppressed. and deprived. For people like us and the weak in the country, especially for PDA (Pichdde, Dalit and Alpsankhyak), saving the Constitution is a matter of life and death," he said.

The former Uttar Pradesh chief minister accused the government of neglecting minorities, and said their rights and properties are being systematically eroded. " More than 20 crore people, especially Muslims, are being reduced to second-grade citizens. Atrocities against them are increasing daily. Their properties are being looted, homes demolished, and places of worship seized with administrative help," Yadav al-

The SP chief reiterated his call for a caste survey, stating it is vital for bridging social gaps and achieving justice.

"Whenever we get the opportunity, we will conduct a caste census. It will not deepen caste divisions but reduce them, ensuring rights and equality for those who have been deprived

for long. Reservation was the most significant tool for social justice, but it has been diluted with outsourcing and contractbased jobs," Yadav added.

Yadav also criticised the government for its handling of border issues with neighbouring countries, claiming that India's territorial integrity is under threat. "Protecting the nation's borders is the primary duty of any government. Yet, we see intrusions...In Ladakh, our troops have withdrawn from our (own) territory, and it won't be long before we are denied access to sacred sites like Kailash Mansarovar," Yadav claimed.

On the issue of economic disparities in the country, Yadav highlighted the plight of the underprivileged.

"Out of 140 crore people, 82 crore depend on government rations for survival. While the country boasts of being among the fastest-growing economies, the reality is starkly different. Two-thirds of the nation's wealth is concentrated in the hands of a few families. If the government has courage, it should reveal the per capita income of those living below the poverty line," he said. He accused the government

of manipulating elections through fear and administrative overreach.

"During the Uttar Pradesh elections (recent bypolls to nine assembly seats), many were denied the right to vote. Women were threatened and police officials openly discouraged them with revolvers. Yet, those brave women defied intimidation and cast their votes. Is this the democracy we live in?" Yadav questioned.

He also warned against the erosion of democratic principles, drawing parallels with authoritarian regimes. (PTI)

IMPHAL, Dec 13: Speaking on the re-imposition of Armed Forces Special Powers' Act (AFSPA) in Manipur's six police station areas, Manipur chief minister N Biren said that the State Government had requested the Central Government to review and withdraw AFSPA from the said police stations. The chief minister sought cooperation and support from the public in the government's effort to restore peace and tranquility in the State.

Biren Singh was speaking at the Nupee Lal Numit observation recently at the Nupee Lal Memorial complex in Imphal.

A formal function was also held at the GP Women's College, Central Hall, after paying the floral tribute at the Nupee Lal Memorial Complex.

Addressing the gathering, N Biren Singh maintained that Nupee Lal Numit is observed every year to remember the role played by "our brave" women in 1904 and 1939, revolting against the "injustice" of British imperialism. He also said that apart from the contribution of women during the above two instances, we should also remember the bravery and courage shown by Manipuri women in other instances including ousting the Burmese (Awa) during the Seven Year Devastation period (1819-1826)

The chief minister then mentioned that the bravery and courage could also be seen among present day women of the State, as they had been leading from the forefront in every issue pertaining to the safety of the people of the state. He spoke on the contribution of Manipuri women in certain sectors including social, economic, art and culture, hospitality and games and sports among others, apart from their household activities. The chief minister said his government is committed to "ensure constitutional protection

of indigenous communities" in the state. He asserted that the war on drugs to protect

the youths of the state would continue.

Singh appreciated the efforts of the Assam Rifles and Ukhrul district SP for destroying more than 100 acres of illegal poppy cultivation in Ukhrul and Kangpokpi areas.

The government will definitely extend assistance to any reasonable demand, and all recognised tribes in the state should unite to

Singh also highlighted how the people of Chadong village were shifted due to the construction of a dam and said the project has ushered in new means of livelihood for the villagers through fisheries and tourism.

Singh also extended his wishes for Christmas and called for peace in the state. (PTI)

Steps taken to boost tea industry in Tripura: Commerce Minister



AGARTALA, Dec 13: Tripura industries and commerce minister Santana Chakma on Friday asserted that the BJP-led government has taken steps to boost the tea industry in the northeastern state.

Addressing the first-ever consultative meeting of stakeholders for establishing a tea e-auction centre in the state, the minister alleged that tea. one of the oldest organised sectors, was largely ignored by the previous Left Front regime.

"Our government has taken initiatives to boost the tea industry in a big way. Now, tea produced in the state has got a brand and logo for proper marketing. Chief Minister Manik Saha has laid the foundation for an e-auction centre in Agartala. It will be made operational shortly," she said.

Seeking assistance from stakeholders Tea Board India (TBI), Tea Research Institute (TRI), Association of Tea Auctioneers and Tea Development Corporation (TTDC) for boosting the tea industry in the state, Chakma said the suggestions made by the experts during the meeting will be taken up at appropriate levels.

Sumanta Poddar, who represented the India Tea Association (ITA), claimed that the tea produced

in the state was safest to drink as it uses a minimal range of pesticides.

Tripura Tea is the safest because it uses a minimal range of pesticides. Transportation of the finished product to auction centres at Kolkata or Guwaĥati is a major challenge for tea sellers of the state," he said.

Tanmoy Bandhapadhyay, in-charge of the Tea Research Institute (TRI), Tripura and Cachar centres, laid emphasis on quality plucking of tea leaves which is key to producing quality tea.

"There is a need to focus on quality plucking and manpower shortage in tea gardens. There is also a need to highlight the benefits of drinking tea to attract buyers in a big way," he said.

Tea Board of India (TBI)'s Factory Advisory Officer (FAO), Agartala, C Bharathiraja also laid emphasis on promotion of tea produced in the northeastern state.

"Branding and promotion of tea are required for the betterment of the tea industry. Besides, transportation of tea from factories to auction markets still remains a challenge. These are areas where attention is needed," he said. Acknowledging the concern over transportation

costs, Director of Industries and Commerce, Vishwasree V, assured the attendees that the issues discussed in the consultation meeting will be looked into. The northeastern state, which has 52 tea gardens, produces around 9 million kg of finished tea

Raj Kapoor would have been 100 on December 14. He released his first film in 1948, the year after Independence. And as India evolved through the decades, so did his movies, mirroring the dreams and conflicts of society in shades of black and white that gave way to glossy technicolour.

The man, the filmmaker, the far-seeing entrepreneur who started R K Studios with his first film itself and the patriarch of filmdom's 'first family', the lines blur and rearrange into the portrait of the larger than life persona still known as the original showman of Indian cinema.

Through the sepia tints of nostalgia

emerges a sharp visionary who knew what would tick.

He was the impassioned lover of "Barsaat", the impoverished wannabe of "Shree 420", the down on his luck Chaplinesque tramp of "Awara", the sensitive joker of "Mera Naam Joker" and the possessive husband of "Sangam". Add to these titles such as "Bobby", "Satyam Shivam Sundaram" and "Ram Teri Ganga Maili" he produced and directed but did not act in, and you have the consummate film man with an unerring eye on the box office.

Raj Kapoor ruled the silver screen along with the two other greats Dev Anand and fellow Peshawari Dilip Kumar. Unlike his colleagues, however, he was not just the actor but also producer and director who made films, spectacles and otherwise, with music that strikes a chord many decades later.

He only directed 10 movies, some such as "Awara" and "Shree 420" in the gallery of unforgettable classics, others like "Bobby"

and "Sangam" blockbusters and then those debatable hits, including "Satyam Shivam Sundaram", "Prem Rog" and "Ram Teri Ganga Maili"

His filmography includes "Andaz", "Jaagte Raho" and "Teesri Kasam" where Raj Kapoor the actor shone bright. He also produced films through his RK Studios, amongst the most powerful in the industry for many decades.

In all this, there was one flop - the introspective, ambitious "Mera Naam Joker", now considered a classic. The failure broke him and he went on to do the teen romance "Bobby"

And all the films had great songs. Remember the global hit "Awara Hoon", "Jeena Yahan Marna Yahan", "Pyar Hua Iqrar Hua" or "Hum Tum Kamre Mein Band Ho". "He was an amazing musician... I suppose it was inborn. He probably got it from my mum who was a singer, not my father... He could play any instrument, whether it

was the accordion, tabla, piano, flute or a 'duff'," brother Shashi Kapoor recalled in a documentary

Raj Kapoor was the eldest of the three brothers - also including the unforgettable Shammi Kapoor. Each carved his own separate space in the industry, away from the shadow of their illustrious father Prithviraj Kapoor.

Raj Kapoor was only 17 when he asked his father for permission to abandon his studies for a career in the movies. Prithviraj agreed on the condition that he would work as one of the many assistants employed by him on a monthly stipend of Rs 10.

After a couple of movies as an actor, including the 1947's "Neel Kamal" with Madhubala, Raj Kapoor decided to take the plunge as director and producer with "Aag". He was 24, and one of the world's youngest filmmakers at the time

"Aag" was also a rumination on inner versus outer beauty, love and loyalty, themes

that deeply resonated with the filmmaker who tackled it again in "Barsaat" (1949) and "Satyam Shivam Sundaram" (1978).

Raj Kapoor turned to Charlie Chaplin's tramp persona in many of his early films starting from 1951's "Awara" and continuing in "Shree 420" and "Jis Desh Mein Ganga Behti Hai", which was directed by his trusted aide Radhu Karmakar.

He was a creature of habit. Through his 37- year career as a filmmaker - beginning with "Aag" in 1948 and ending with "Ram Teri..." in 1985 - he stuck mostly to the same talented team.

It included writer K A Abbas, cinematographer Karmakar, musicians Shankar-Jaikishen, lyricist Shailendra and singer Mukesh, who he called his soul and came to be known as his voice.

According to brother Shashi, their father and his theatrical productions influenced the socialist overtones in his elder brother's earlier films. (PTI)

Gukesh's incredible powers of self-awareness led him to World title: Paddy Upton



BENGALURU, Dec 13: Paddy Upton, the renowned mental conditioning coach who worked with D Gukesh, said the 'incredible self-awareness" of the 18-year-old Indian Grandmaster powered him to a historic World Chess Championship

Gukesh became the youngest ever world champion when he defeated China's Ding Liren 7.5-6.5 to annex the crown at Singapore on Thursday.

"I think the most fascinating thing working with Gukesh was his level of self-awareness, just to really recognise where his thoughts are being directed. So, if there was even a moment on the chessboard where he found himself overthinking he had an amazing awareness of it, when his mind drifted off and that's quite unique," Upton told PTI.

'Gukesh has incredible powers of self-awareness and a lot of our work was helping him identify what were the things that would potentially distract his focus. So yeah, I think that's the thing that's really stood out, his ability to recognise his thoughts and manage his mind and his understanding of how to do so.

"And kudos to him, he is a world champion because he was able to manage himself and remain focused and stay in the game even though he's 0-1 down right from the beginning. So that really is a mark of a champion, they cannot be set back by such a big and early setback."

One of the key aspects that Upton drove into Gukesh was conversations and went deep that he did not have to overreach into theory and ideas and conto be at his best in each of the 14 cepts compared to some athletes games. "One of the things that I who maybe are more emotionreally drilled into Gukesh is that one of the biggest mistakes that lectual and the conversation athletes make when they're apneeds to be quite different. (PTI)

proaching the biggest event of their life is they think they need to play the best they've ever played in their whole life or even better, and that's a huge mistake.

"So, athletes end up over-efforting in the big moments, and the thing with Gukesh was just to get him to consistently play his natural best chess, and that was going to be good enough,' he said.

The biggest challenge Gukesh and Upton faced was to keep the mental sharpness over three weeks of intense and draining

chess. They had a plan for it.

"We always knew it was going to be a three-week affair. It was going to be a ding-dong battle. It was going to be long and sustained.

"We had a very clear strategy. About three weeks before the tournament, we stopped doing any new work. I told him, this is now time, we're just going to consolidate everything we've already done.

"Let's just make sure that we really ingrain this in his brain. And he also had a very highlevel, two-page document that I sent to him that summarised the mental strategy for the 18 days. He had that both in his head and he had it on paper. But credit to him and his team that they were able to execute it," he explained.

So, what was the nature of his conversations with Gukesh? Was it intense? Casual? Or purely cerebral?

"We had deeply theoretical ally based and maybe less intel-

Treesa and Gavatri, who won their maiden BWF Super 300 title at Syed Modi International in Lucknow recently, lost 17-21 13-21 to their world number 4 opponents in 49 minutes.

Thereafter, the Japanese pair zoomed ahead and a six-point burst took them to 18-10. Treesa and Gayatri narrowed down the deficit to 17-19 but Matsuyama and Shida prevailed.

After the change of sides, Treesa and Gayatri had a slender 4-2 lead but Matsuyama and Shida turned the tables quickly and entered the break with a four-point advantage.

The Japanese pair kept a firm grip on the rallies and slowly and steadily kept moving ahead to eventually shut the door on the Indians.

Matsuyama and Shida joined the Chinese pair of Sheng Shu and Ning in the semifinal stage of the tournament. (PTI)

Carlsen lauds Gukesh but rules out world title clash with him

NEW DELHI, Dec 13: World number one Magnus Carlsen has lauded D Gukesh for making the most of his chances to be crowned the youngest ever world chess champion but has ruled out the possibility of a title showdown with him as desired by the Indian

The 18-year-old defeated defending champion Ding Liren in the 14th and final round of the match on Thursday to become only the second Indian after Viswanathan Anand to claim the coveted trophy.

"It's an incredible achievement (by Gukesh), first he was down in the FIDE circuit, won the tournament in Chennai on demand, then he had an amazing performance in the Candidates tournament," said Carlsen on a popular recap stream, analysing the match.

Carlsen said he was a bit surprised by how the match unfolded with most of the games ending in

"This was something that was bit unexpected, a lot of us thought that Gukesh was a favourite to win the match but this was a game that never really took off. Gukesh was doing a great job of keeping the position alive and suddenly it was all over," Carlsen said.

"It's a really good thing for him, he has the title now for two years, winning this championship is extremely motivating so there is a very good chance that he is going to go for a great run of results now and probably become the number two player now and may be number one in the not so distant future," he noted.

In the post-event press confer-

ence, Gukesh stated that he would love to fight it out against Carlsen at some point. The Norwegian maverick decided not to defend his title in 2023 after winning the world championship in 2013.

"Winning World Chess Championship does not mean I am the best player, obviously that is Magnus Carlsen. I want to reach the level Magnus has achieved," Gukesh said.

"Obviously playing against Magnus in the world championship would be amazing, it would be the toughest challenge there is in chess. It is up to Magnus, but I would love to test myself against the best player in the world.'

But Carlsen ruled that out. "I am not part of this circus any-

more," said Carlsen in a general reference to world title clashes.

Carlsen also praised Gukesh's team and said they did a good job. "It is becoming progressively harder (to play mainstream openings) all main lines are analysed so they had to jump a bit," Carlsen said of the opening choices made by Gukesh.

"I have generally kept it fairly risk-free with the white pieces, I have tried not to let things go out of control," he added.

The world's best player for a decade now was critical of Liren's

choices in the final game. "There are lot of things that Ding could have done differently, Gukesh really made most of his

chances," he said. "It's a massive moment for India, it's a combination of work that is being done there. This is not

BRISBANE, Dec 13: Rohit Sharma's elegance and Virat Kohli's class will face the ultimate 'Test' when India take on an Australian team eager to set the record straight on a spicy Gabba track in the third game of the Border-Gavaskar series, starting Saturday.

With the series locked at 1-1, Brisbane could well decide the course of the rubber and whether Rohit's men would continue to be the master of their fate in the ongoing World Test Championship.

For India, the biggest hope remains in Australia's batting vulnerability which can lead to an implosion if a certain Travis Head doesn't decide to be the marauder.

Steve Smith is currently sailing in the same boat as Kohli if inconsistent batting form is taken into

Senior off-spinner R Ashwin and Washington Sundar were steady without being exceptional in the first two Tests but Ravindra Jadeja is a safer option if India realistically want to add batting depth considering his good record in overseas con-

As far as pace bowling is concerned, Akash Deep is blessed with more skills but skipper Rohit loved rookie Harshit Rana's big heart. In case of Australia, their batting is no less fragile than that of India's.

Head has had a Rishabh Pant-like effect on his days, which often come against India.

But Steve Smith's form is a worry as the Indians have been bowling straight lines to him. Bumrah is a combination of legendary pacers, says Chappell

SYDNEY, Dec 13: Jasprit Bumrah embodies the qualities of pace legends such as Dennis Lillee, Andy Roberts and Richard Hadlee but at the same time is forging his own legacy, one that is set to inspire future generations of pacemen, feels for-

mer India coach Greg Chappell. He also said that Bumrah is the only player standing between Australia and the Border Gavaskar Trophy. "What sets Bumrah apart is his combination of skills: (Malcolm) Marshall's adaptability, Lillee's aggression, Richard Hadlee's control, Roberts' strategy, Wasim (Akram) and Waqar's (Younis) reverse swing, (Glenn) McGrath's precision, (Dale) Steyn's explosiveness, and (Kagiso) Rabada's modern versatility.'

"As Nasser Hussain aptly observed, "He's the complete bowler. As he has had back surgery already, it is not certain he will have a long career, but if he does, his name will be mentioned in the same breath as the champions above," Chappell wrote in the 'Sydney Morning Herald'. An all-format bowler, Bumrah has reinforced his status as the best bowler in the world several times including when he led India to a 295-run win in the Perth Test recently. "While the legends of yesteryear established the foundations, Bumrah is carving his own legacy – one that promises to inspire future generations of pacemen." The former Australia captain said Bumrah's lethal yorkers and unsettling bounce evoked memories of Lillee's raw aggression on the field. "Lillee was a warrior, combining raw aggression with psychological prowess. I opposed him many times in domestic cricket and watched him from close quarters against the best batsmen of his era.

"His ability to make it hard for batsmen to score runs with his probing line and length, allied to his guile and determination, made him the champion that he was. Bumrah, though less overtly combative, channels Lillee's ability to unsettle batsmen. His deadly yorkers and disconcerting bounce - esbecially with his unorthodox release point and trajectory echo Lillee's capacity to dictate terms.

"Bumrah's quiet intensity and precision make him a nightmare, much like Lillee's unrelenting aggression." Another great of the game was Roberts, who combined pace with strategic brilliance. Chappell felt Bumrah's 2018 performance at the MCG where he used variations to get the better of the batters was reminiscent of the way Roberts operated.

"Bumrah shares Roberts' cerebral approach. Both bowlers use subtle variations to outfox batsmen, relying on strategy rather than brute force. Bumrah's spell in the 2018 Boxing Day Test against Australia – culminating in 6-33 – was a modern echo of Roberts' game-changing bursts.'

"Roberts had a loping and relaxed run-up and a very strong shoulder action like Bumrah, and skidded onto you quite quickly, so it was important to be focused on the ball leaving the hand. "The danger of a bowler who zeroes in on the stumps, as Roberts did and Bumrah does, is that if you relax for a moment and try to hit across their deliveries, you become even more vulnerable to LBWs and bowled. I would use the same approach against Bumrah," Chappell added. (PTI)

A day in the life of a world champion: Gukesh gets his trophy, revels in stardom

SINGAPORE, Dec 13: His eyes were expectedly burning after a sleepless night but the adrenaline kept D Gukesh going as he smiled through a plethora of engagements, including signing hundreds of autographs, before finally getting his hands on the world chess championship trophy a day after becoming its

youngest owner. The 18-year-old Chennai-lad got the better of defending champion Ding Liren of China on Thursday for the historic triumph that made him the 18th overall and only the second Indian after Viswanathan Anand to win the crown that came with a whooping prize of USD 1.3 million.

The morning after began with getting a glimpse of the trophy, which he refused to touch as he wanted to wait till the closing ceremony in the evening. He finally held it after it was presented to him by FIDE (International Chess Federation) President Arkady Dvorkovich.

In his introduction, the FIDE presenters spoke of his "brilliant poise" and, "performance for the ages" that he delivered against an older and more experienced rival.

"I mean this moment, it feels like I have lived it a million times. Every morning when I woke up, this moment was the reason I woke up. To hold this trophy and this reality means more than anything else in my life," the graceful teenager said in his acceptance speech after being presented with his gold medal and the trophy that came with a USD 1.3 mil-

lion reward. Before that, he sat down to meet and greet a seemingly never-ending stream of fans, both the young and old, even toddlers. (PTI)
