DIBRUGARH, Dec 23: Nearly 32 lakh people received benefits under various schemes during a special initiative by the Assam government which concluded on Monday, Chief Minister Himanta Biswa Sarma said.

The '12 Days of Development' campaign reached out to both the poor and middle-class sections of the state, he added.

"We had started this campaign in Guwahati, and after 12 days, we are concluding it in Dibrugarh today," Sarma told reporters after attending a meeting.

During the campaign, 20 lakh new ration cards were distributed, assistance was provided to six lakh flood-hit people, and meritorious students received scooters, bicycles, and other incentives under various schemes, the CM said.

"About 30-32 lakh people have received benefits under government schemes during this period. We are confident that these schemes will help the poor and middle-class sections of the population," Sarma said.



More planes, flights, airports to brighten Indian aviation in 2025

NEW DELHI/MUMBAI, Dec 23: The trails of mega-mergers, tailwinds of expanding fleets, flights and airports will dot the fast-growing Indian aviation firmament in 2025, though the dark clouds of supply chain woes will persist longer.

Also, new airline takeoffs, the future trajectory of revised norms to tackle pilot fatigue and efforts to reduce carbon emissions will be on the radar.

And in 2024, two airlines flew into the sunset, one airline is on a liquidation taxiway, aircraft orders climbed, single-day domestic air passenger traffic soared past record 5 lakh at least twice, and airfare movements continued to raise concerns. Not to leave out 999 hoax bomb calls received by airlines till November 14 this year.

The aviation sector had its share of accidents in the form of a few trainer aircraft crashes and a roof collapse incident at Terminal 1 of the Delhi airport that killed one person.

For the "fascinating" Indian market, where the domestic air traffic is projected to jump to 164-170 million this fiscal ending March 2025, the larger longterm focus will be on increasing wide-body aircraft, providing more direct overseas flight connectivity and making the country a global aviation hub.

In the words of Akasa Air's chief Vinay Dube, prospects are exceptional for the Indian aviation market, and IATA chief Willie Walsh is of the view that there is a massive opportunity for Indian airlines. The fleet of Indian carriers is

more than 800 planes, including over 60 wide-body aircraft, and there are 157 airports. (PTI)

Rupee falls 7 paise to close at 85.11 against US dollar MUMBAI, Dec 23: The rupee depreciated 7 paise was trading higher by 0.48 per cent at 108.13. Brent crude, the global oil benchmark, fell 0.37 per

and settled for the day at 85.11 against the US dollar on Monday, amid continued strength in the dollar index bolstered by the Fed's policy stance.

According to forex traders, notwithstanding a positive trend in domestic equities, the rupee stayed weak due to significant dollar demand. Moreover, higher crude oil prices triggered by volatile geopolitical situation also dented sentiments.

They said the dollar index is expected to remain elevated as the US Federal Reserve indicated slowerthan-expected rate cut in 2025.

West Bengal's revenue expenditure outpaces capital spending in H1 FY25: Report

KOLKATA, Dec 23: West Bengal's fiscal performance in the first half of the 2024-25 fiscal reflects a growing imbalance between revenue and capital expenditure, aligning with broader trends observed across major Indian states, according to rating agency CareEdge. While the state recorded a 13.5-per cent year-on-year increase in revenue expenditure, its capital expenditure grew by only 7.7 per cent, significantly falling short of its budgeted targets, the agency's latest report on state and central finances said. Amit Mitra, principal chief advisor to Chief Minister Mamata Banerjee and the state's finance department, had recently said Bengal's capital spending had increased from ₹ 2,226 crore in 2010-11 to a budgeted amount of ₹ 35,865.55 crore in 2024-25.

"Revenue expenditure of states remained strong in H1 FY25. In aggregate, the top 20 states in our sample utilised 41.5 per cent of their budgeted revenue expenditure in H1 FY25, slightly higher than the 40 per cent utilisation in H1 FY24," the CareEdge report said. It noted that the possible reasons for such slippages could include the implementation of electoral promises, including measures like freebies, income assistance and loan waivers.

West Bengal's fiscal deficit stood at 3.7 per cent of

its Gross State Domestic Product (GSDP) in the first

half (H1) of FY25, exceeding the 15th Finance Commission's recommended ceiling of 3 per cent, it showed. This places the state in the higher fiscal deficit bracket among the country's top 20 states.

While the aggregate fiscal deficit for these states averaged 2.9 per cent of GSDP, West Bengal's figure underscores its ongoing fiscal challenges, driven by elevated revenue spending and slower-than-expected capital expenditure growth during the period, the agency said.

The analysis of state finances for the first half of FY25 revealed a mixed performance among the 20 major states, representing 93 per cent of the country's GDP. While revenue expenditure showed robust growth, capital expenditure (capex) remained sluggish, raising concerns over infrastructure development and long-term economic growth, the report said.

On the central finances front, during the first seven months of FY25, the Centre's fiscal deficit was recorded at ₹ 7.5 trillion (46.5 per cent of the budget estimate), it noted. On the receipts side, tax collections remained largely steady. However, on the expenditure side, the capex scenario was sluggish.

"As highlighted earlier, the general elections during the first quarter weighed on the overall capex during H1. Although we expect capex to pick up in the remainder of the fiscal year, the ratio of capital expenditure to revenue expenditure is expected to slightly trail below the budgeted level for FY25," the report added. Dissanayake's India visit

ri Lankan President Anura Kumara Dissanayake's recent trip to India is an important moment in strengthening the ties between the two neighbouring countries. This visit highlights the growing bond and cooperation between India and Sri Lanka. This was his first official trip abroad since becoming President in September, showing his dedication to strengthening economic relations with India while also tackling worries about China's growing role in Sri Lanka. In his meeting with Prime Minister Narendra Modi, Dissanayake thanked India for helping stabilize Sri Lanka's economy during its 2022 crisis. He also shared his vision for working together on economic growth, focusing on sustainable development and recovery. The visit ended with a joint statement that highlighted various plans for working together, including partnerships in energy and efforts to strengthen regional security. India's plan to provide liquefied natural gas (LNG) to Sri Lanka and work on renewable energy projects shows its continued support in helping Sri Lanka expand its energy options. One key announcement was the plan to build an energy pipeline linking India and Sri Lanka, with support from the United Arab Emirates. This pipeline, along with plans to develop Trincomalee (a port city in Sri Lanka) into a regional energy hub, shows India's aim to strengthen its presence in the Indian Ocean while helping Sri Lanka meet its urgent energy needs. Both countries also stressed the need to restart the passenger ferry service and repair important infrastructure, like the Kankesanthurai port (located in northern Sri Lanka, about 60 km from India), to improve connectivity be-

The agreements and announcements bring hope for the economic recovery of Sri Lanka and stronger ties between the two nations. However, there are concerns about how they might affect Sri Lanka's independence and control over its economy in the long run. With India's large workforce, especially in fields like medicine where many local doctors are already unemployed, Sri Lanka may end up struggling to safeguard jobs for its skilled workers. The FSP warned that this could impact not only skilled professionals but also small workers in sectors like transportation, barbering, and street vending. They fear that cheaper labour from India could flood the market and hurt local jobs. The energy sector, a major focus of the visit, has also faced criticism. While India's role in LNG supply, offshore wind power, and connecting power grids could help solve Sri Lanka's immediate energy problems, some worry that these partnerships might make Sri Lanka too dependent on India's energy systems.

India's financial help, including \$4 billion in aid for food, fuel, and medicines, was vital in helping Sri Lanka stabilize its economy during its toughest time. The agreements made during Dissanayake's first visit to New Delhi as President aims to strengthen this support by promoting investment partnerships, improving transport links, and boosting trade. India's proposal to promote trade settlements using the Indian Rupee (INR) and Sri Lankan Rupee (LKR) could help ease the pressure on Sri Lanka's foreign exchange reserves. President Dissanayake's government faces the challenge of balancing the advantages of these initiatives with the risks they bring with them. Critics believe Sri Lanka should carefully manage these partnerships to make sure they truly benefit its people and meet their needs.

Pakistan must reconcile with Bangladesh's 1971 painful legacy

fter decades of hiatus, Bangladesh and Pakistan have made a major step toward a new era of regional cooperation in South Asia, riddled with suspicion, distrust, disrespect, and South Asia, riquied with suspection, lack of neighbourliness among the eight countries.

When Nobel laureate Dr Muhammad Yunus, Chief Advisor of the Interim Government of Bangladesh embraced Pakistan Prime Minister Shehbaz Sharif with grins on their faces decided to put the bilateral relations at a new height. Yunus and Sharif met on the sidelines of the D-8 Summit, which

was held by developing nations in Cairo, Egypt. Shehbaz Sharif called for a strategic relationship between Dhaka and Islamabad and said "We are looking forward to strengthening our relationship with our brother-in-country Bangladesh.

Dr Yunus expressed his keenness to reactivate the South Asian Association for Regional Cooperation (SAARC) as "a top priority." "I am a big fan of the idea of SAARC. I keep harping on the issue. I want a summit of SAARC leaders even if it is only for a photo session because that will carry a strong message," the French news agency AFP quoted Yunus as telling Shehbaz. The moribund eight-nation SAARC (Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan, and Sri Lanka) was largely stalled due to arguments between Islamabad and New Delhi.

Bangladesh and Pakistan are two wings of India and are not physically connected by land, rivers, and blue mountains. The two leaders expressed their desire to resolve outstanding grievances from the brutal birth of Bangladesh in 1971. December is an emotional month for Bangladesh.

The day is observed with due solemnity to respect the millions of martyrs at the gigantic National Martyrs Memorial on the outskirts of the capital Dhaka.

All organizations, professional bodies, and political parties assemble at dawn to pay homage at the site, except for the Islamist party Jamaat-e-Islami, which allegedly were henchmen and armed militia groups, which rampaged and pillaged thousands of villages during the nine months of liberation war.

On a historic day, Lieutenant General Amir Abdullah Khan Niazi, Commander of Eastern Command, Pakistan Army and Indian Lieutenant General Jagiit Singh Aurora of the Eastern Command, Indian Army flanked by a dozen Mukti Bahini commanders signed a historic 'instrument of surrender' in accordance to

16 December after a humiliating defeat, which created an inde-

pendent Bangladesh.

It was the world's largest surrender in terms of number of personnel since World War II. The prisoners of war (POWs) were repatriated under the Tripartite Agreement signed in April 1974 by Foreign Ministers of Bangladesh, Pakistan, and India in New Delhi. The Organization of Islamic Cooperation (OIC) held in Lahore, Pakistan in February 1974 helped resolve the issue of Bangladesh's recognition intervened by Egypt and Algeria.

According to textbook history, the eastern province of Pakistan (known as East Pakistan) plunged into a bloody civil war after the military junta refused to accept the people's mandate of the firstever general elections in 1970.

The martial law government based in Rawalpindi launched a crackdown codenamed 'Operation Searchlight' in March 1971 after denying handing down political power to the elected representatives. In hours the Awami League leader Sheikh Mujibur Rahman was detained and the party banned.

When Mujib was picked up by the military in Dhaka, nearly 1,500 political and student leaders, intellectuals, acclaimed poets, senior lawyers, journalists and others were arrested from (western) Pakistan. Relations between the two countries experienced hiccups during the last five decades. The three military dictators General Ziaur Rahman, General H.M. Ershad and General Moeen U Ahmed went ahead to thaw the bilateral relations with their counterpart military junta in Pakistan, which were never sustainable in the see-saw diplomatic maneuver by the autocratic regimes in both

During the democratic era, the two Begums failed to build up the relationship between Bangladesh and Pakistan. The prestigious Pakistan newspaper The Dawn writes: In the years since the split (independence), Dhaka's leaders — especially the recently ousted regime of Sheikh Hasina — stayed firmly in the Indian camp, preferring to maintain close ties with New Delhi and keeping Islamabad at arm's length.

However, the newspaper wrote that ties between the two capitals have thawed ever since a popular uprising toppled Hasina's government in August, with trade and bilateral relations seeing a marked improvement.

They also agreed to expand and deepen bilateral cooperation in all areas of mutual interest and emphasized the need to align efforts to achieve mutually beneficial development objectives. Yunus told AFP "The issues (of 1971) have kept coming again

The two leaders acknowledged the importance of people-topeople contacts and cultural exchanges including enhanced exchange of artists, sportspersons, academics, students, etc. Political historian Mohiuddin Ahmad said he does not see how the relationship would defrost the relationship which has deepened scars of the brutal independence war.

It is no denying that in Clause 13 of the Tripartite Agreement, Pakistan agreed to put 195 senior military officers on trial for war crimes. crimes against humanity and rape as a weapon of war.

Unfortunately, lack of a guarantee clause in the agreement, the military dictator and also President, General Ziaul Huq instead pardoned the accused, which was a serious breach of the Delhi agreement, said the Mukti Bahini veteran Mohiuddin Ahmad.

Sharif said the 1974 Tripartite Agreement involving Bangladesh, Pakistan, and India settled things, "but if there are other outstanding issues," he would be happy to look into it. Yunus said it would indeed be nice to resolve things "once and for all for the future generations.

Former Ambassador Humayun Kabir doubts that settling down on the 1971 issue, who is also a liberation war veteran said it would be not easy for the millions of people who joined the guerrillas (Mukti Bahini), those became war refugees, the genocide survivors and the rape victims would be able to forget the nightmare and pardon the perpetrators, who were unfortunately not punished for committing crimes in 1971.

When military usurper General Pervez Musharraf visited Bangladesh in July 2002, he was greeted by a general strike and Dhaka University students fought a pitched battle with riot police in the capital demanding Pakistan should seek an apology for what military troops had committed. He (Musharraf) regretted the excesses committed during Bangladesh's 1971 war of independence but called for burying the past in the spirit of friendship. Well, his statement was short of apology for the crimes committed during the war and said "Your brothers and sisters in Pakistan share the pains of the events of 1971."

Perhaps stating only one-word "apology" in public for crimes committed by the Pakistan military during 1971 would melt the ice once and for all, remarks Ambassador Kabir. UK economy seeking to strike a balance amidst GDP decline

onsecutive monthly decline in GDP marking the first back to back contraction since the Covid-19 lockdown are signals to UK economy policymakers to clear the decks for a precarious balancing act. This is necessary to stabilise short-term economic performance while fostering long-term growth.

Systemic vulnerabilities are underscored by the latest data. Manufacturing and, construction output has weakened. Trade figures reveal a dip in both imports and exports. The

services sector has stalled. An atmosphere of uncertainty, which is not improved by anticipation and immediate aftermath of a new fiscal policy, envelops the business sector. There is a modest tide in consumer confidence. But it is insufficient to offset broader economic stagnation. Indeed the UK economy is at a crossroads.

An ambitious government budget aiming to reinvigorate the economy lies at the heart of the matter. For it comes with difficult decisions like higher taxes for businesses and increased social security contributions. Such measures are necessary to ad-

public infrastructure. But at the same time it invites the risk of dampening business sentiment and deterringpublic sector activity in the short run. This is by no means an unprecedented approach as many advanced countries adopt austerity during economic adversity periods. To recalibrate sluggish growth adopting investment heavy strategies is not unheard of.

Reduced corporate activity and strained employer finances are some of the fallouts of this game-plan of economic revival. But looked at through a broader lens, public invest-

dress the fiscal gaps and invest in ment in infrastructure, healthcare and education has the potential to deliver substantial economic dividends in the medium and long-term.

Besides stimulating domestic demand, these investments create an enabling atmosphere for business to thrive. But there has to be clarity and consistency in implementing these policies. UK's recovery had been sluggish compared to its peers in this period. Similarly burdened by energy costs and supply chain issues, only Germany fares worse in the growth metrics. With its cautious approach in monetary policy, the Bank of England faces a difficult task. Interest rate cuts though tempting can shoot up inflationary pressure and in its turn destabilise an already fragile investor confidence. Growth aspirations has to be balanced with economic stability. To achieve this fiscal and monetary policies have to be deftly coordinated. Success depends on the government's ability to communicate its vision effectively. The powers that be has to reduce the hardship of both business and households. The road ahead may be rocky. But there is hope for a more resilient and inclusive economic future. (IPA Service)

Eliminating child marriage in Assam

By: Himangshu Ranjan Bhuyan hild marriage being a deep-rooted social problem in India is also not different to the state of Assam. Rooted in tradition and poverty and a ack of education, the practice disallows young girls from even having their childhood, the right to education, or scope for growth. It is often marked by cycles of poverty and gender inequality, leaving a lasting unhealable wound in the fabric of the society. In recent years, Assam has emerged as a frontline state in this fight against this harmful practice by implementing rig-orous measures and reformative policies. The work is carried out at the state's end and it burdens the burden or its youth's protection and better future The alarmingly high prevalence of child marriage in Assam has been of national concern. The National Fam-ily Health Survey (NFHS-5) conducted between 2019 and 2021 reports that about 31.8% of the women in Assam aged 20–24 were married before attaining the age of 18 years. This is above the national average and calls for immediate action. The practice not only is a vi-olation of the Prohibition of Child Marriage Act, 2006 but also puts the girls at a risk of early pregnancy, health problems and lack of opportunities. Although these effects are not visible, for boys too, they are just as devastating since child marriage often takes away the educational and economic opportunities for them. Confronting evil calls for a unified strategy including law enforcement, education, economic development and social reconstruction. With this, the Assam state government is initiating a string of actions to effectively deal with practice of child marriage, in a planned man ner. Dr. Himanta Biswa Sarma, Chief Minister of Assam, has driven such an attempted suppression by involving both enforcement and awareness campaigns State initiatives have involved mass arrests of those indulging in underage marriages, community outreach programs, and greater vigilance by local authorities The most prominent action Assam has taken in its fight against ^rchild marriage was the massive crackdown initiated in February 2023. Thousands of people including grooms and grooms' relatives were detained for the violation of child marriage laws. While the move received mixed reactions, it clearly conveyed a message about the state's zero-tolerance policy. Critics did com-plain that membership arrests disrupted families and pe nalised the economically disadvantaged, but the government defended its actions emphasizing the importance of strong enforcement to discourage future vi-Besides filing legal proceedings, Assam has also tried sequences of child marriage. Campaigns Targeting rural and marginal areas where the practice is most prevalent have informed parents of the legal, medical, and social consequences of early marriage. The state has collaborated with NGOs, religious leaders, and local influencers to enhance awareness and behavioral change in these communities. Such co-operation has also been at the heart of efforts to undermine long-held deep cultural attitudes and promote community-supported answers. marriage. In order to break the practice education access, in a long term plan, improving girl's access should be encouraged. The scheme of providing free textbooks, bicycles and scholarships implemented by the state gov-ernment is to encourage girls to complete their educa-tion. This initiative is, therefore, of crucial importance in relation to eradicating the main causes of child mar-riage since studies show that education has a direct relation with delayed marriages. It not only postpones marriage, therefore keeping girls in school, but also gives them opportunities for further education and work, which in turn leads to greater independence and self-sufficiency Economic empowerment is also one of the key aspects/factors of Assam strategy. Poverty is still consider ered as the most significant factor underlying child marriage as economically disadvantaged families usually see marriage as a solution to end their economic hardships. The state has also taken steps in the direction of enhancing livelihood prospects of such families, particularly in rural regions. Skill development and vocational training courses are also developed with the goal of providing alternative livelihood opportunities to reduce the economic pressure that is a contributing factor in early marriage. Despite these efforts, challenges persist. Traditionally ngrained cultural practices and patriarchal expectations still constrain progress. Child marriage by many families, particularly those in rural communities, is seen as a way to save their daughters from social disapproval or to accumulate financial security through dowries. Such convictions frequently take precedence over legal issues and awareness campaigns and show that the key to success lies in a continuous and comprehensive ap-The following challenge is to find a balance between severe regulation and awareness of socio-economic facts. Arrests and legal proceedings against offenders are obviously a worthwhile endeavor, but must not be the only thing, and should be supported by measures designed to help families caught up in the scandal. Counselling of the parents, rehabilitation, alternative provision for these children are important intervention measures to prevent the amplification of vulnerabilities of these children due to enforcement. The state also has a task to fill in the holes in the infrastructure and access to schools and health care, which is likely to play an important role in decreasing the occurrence of child mar-The role of community participation cannot be undermined. The success of child marriage abolition is not only in Assam, it also depends on collective efforts of all stakeholders. From parents and educators to religious authorities and legislators, each sector of society has its piece to play. Grassroots activism and community-based interventions are likely to make lasting impact by addressing the specific needs of the communities involved and promoting a feeling of ownership. In the end, we can conclude that, Child marriage in Assam, therefore, serves as a remarkable illustration of the state's resolve to its children and their empowerment of future generations. Despite the advances made, it is still far from being there. Education, economic empowerment, community engagement, and legal enforcement are not mutually exclusive, and thoughtful attention needs to go to them in state, instead. Through identify ing the underlying factors and fostering a culture of awareness and equity, Assam can unlock the potential for a society in which the potential of every child emerges to blossom. Child marriage abolition is not only legal responsibility but also moral responsibility, and work done in Assam serves as a model for others to adopt. What are the best drinks for losing weight?

ccording to the Centers for Disease Control and Prevention (CDC), 71.6% ▲ of people in the United States aged 20 or older are overweight or have obesity. However, when it comes to losing weight, there are no quick fixes.

Most often, weight loss involves changing eating, drinking, and exercise habits.

Increasing daily activity levels and consuming the right amounts of high quality, nutrient dense foods can help a person lose weight.

No specific drink leads to weight loss, but some drinks may support the necessary lifestyle changes.

In this article, we look at drinks that may help people lose weight. We also investigate which drinks to avoid and give other weight

Drinks that may support weight loss

The following beverages may help promote weight loss if a person incorporates them into a healthful diet and activity plan:

Water is a good choice for weight loss, as it contains no calories. Water is one of the most healthful drinks — it contains no calories, facilitates metabolic and physiologic processes and aids in detoxification, among many other benefits.

For people looking to manage their weight, many health organizations, including the CDC, recommend either choosing water instead of more caloric beverages or increasing overall water consumption.

Researchers have found links between regular consumption of green and black tea and reduced risk of cardiovascular disease, some cancers, and diabetes.

Additional studies suggest that green tea can help people lose weight and keep it off because of two key ingredients: caffeine and a compound called epigallocatechin gallate.

However, a review of multiple studies found that, in most cases, weight loss resulting from green tea was not statistically significant. When green tea did make a difference, the procedures involved were more complicated than simply drinking the tea.

Apple cider vinegar

Many people claim that apple cider vinegar has health benefits, including aiding weight loss. One small study found that participants hunger, increased a feeling of fullne couraged the body to burn calories.

on a restricted-calorie diet who also took apple cider vinegar experienced more weight loss and lower cholesterol levels than others who only followed the diet.

Meal replacement shakes

People looking to lose weight may find meal replacement shakes a useful option, particularly if a busy lifestyle means that it is difficult to make time for healthful meals.

Eating a balanced, nutrient-dense meal or snack is ideal, but a replacement shake can be healthful and satisfying. Many of these shakes contain a range of important nutrients, protein, and fiber, with fewer calories than processed

However, not all meal replacement shakes are healthful. It is important to be mindful of the ingredients and nutrition information.

If a person wishes to try meal replacement shakes, they should be sure to check the labels and avoid options that contain unhealthful ingredients, such as added sugars, artificial sweeteners, and corn syrups.

Some research suggests that meal replacement shakes can help people start to lose weight or maintain a healthy weight.

One 2011 review of studies reported evidence that shakes could to lead to significant weight loss, while others studies in the analysis were inconclusive.

Protein shakes

Protein shakes do not contain the nutrition of a balanced meal or some meal replacement shakes. However, consuming a high amount of protein may help reduce hunger and maintain a feeling of fullness. As a result, a person may consume fewer calories after a protein shake, and this could help with weight loss.

It is important to be aware, however, that protein shakes also contain calories. As with meal replacement shakes, a person should check for unhealthful ingredients in protein

Drinks containing ginger

People have used ginger to improve digestive health for hundreds of years. Ginger has anti-inflammatory properties and can be a healthful addition to hot tea or sparkling water. However, some ginger drinks have added sugar, which promotes inflammation and

One small study found that drinking a beverage of hot tea and ginger powder decreased hunger, increased a feeling of fullness, and en-



As there were only 10 participants in the study, however, confirming the findings will require further research.

Carbonated water

Carbonated, or sparkling, water can be a good alternative to sugary carbonated beverages, such as sodas.

Carbonated water can encourage the body to feel full, which may lead a person to consume fewer calories.

Drinks to avoid

Experts have noted that people feel less full or satisfied after consuming calories in beverages, compared with those in solid foods.

Authors of a study from 2006 reported that people in the U.S. who are older than 2 years consumed 21% of their calories in beverages, while many drinks offer very little nutritional

Anyone looking to lose weight should avoid the following types of drinks: Sweetened soft drinks

Full of calories and low in nutrients, sweetened, carbonated beverages such as sodas do not aid weight loss. A 12-ounce (oz) can of

soda can contain around 10–13 teaspoons (tsp) of sugar, depending on the drink.

Fruit juices and smoothies

Fruit juices have some nutritional benefits. However, though the sugar in them is naturally derived, juices contain so much sugar

that they add a lot of calories to the diet. A 12-oz serving of orange juice contains 10 tsp of sugar, while the same serving of a

smoothie typically has even more sugar. When a person opts for juice, it is important to choose 100% fruit juice with no added ugar and to be mindful of portion sizes

Energy drinks

Energy and sports drinks also deliver some benefits, but they are typically high in calories. The following figures are for 12 oz of each type of drink:

• Sports drinks: 5–10 tsp of sugar

• Energy drinks: 10-14 tsp of sugar Also, energy drinks often contain artificial sweeteners, which may not be healthful.

• Mixers, such as fruit juice or soda, increase the calorie count of each drink.

• Drinking can lower inhibitions, making it more likely for dieters to eat foods that they are trying to avoid.

· Drinking interferes with digestion and sleep, complicating weight loss.

However, the other side narrates a different story. While creating anything, it is important to take note of the fact that a large group of audience is going to see that work, and that audience includes people from various age groups - ranging from children to senior citizens

It is also going to include people from various backgrounds - different religions, castes, and states. If we talk about children, Putting out something violent will have a direct impact on the child's psyche. Many people faint at the sight of blood whereas others cannot stand obscenity. It varies from person to person. Censorship draws a rational line and showcases the things that will work in favor of the majority i.e., something that appeals to the majority. After all, article 19 does have some limitations, and on this basis, artists cannot put out anything that may offend other people. A line needs to be drawn.

Bangladesh wants Hasina back, sends note verbale to India

'We must ensure justice in every killing... we will also ask India to send back fallen autocrat Sheikh Hasina'

DHAKA, Dec 23: Bangladesh's interim government said on Monday that it has sent a diplomatic note to India to send back deposed prime minister Sheikh Hasina to

Hasina, 77, has been living in exile in India since Aug 5 when she fled the country amid the student-led protests that toppled her 16-year regime. Bangladesh-based International Crimes Tribunal (ICT) has issued arrest warrants for Hasina and several former Cabinet ministers, advisers, and military and civil officials for "crimes against humanity and genocide".

"We have sent a note verbale to the Indian government saying that Bangladesh wants her back here for the judicial process," Foreign Affairs Adviser Touhid Hossain told reporters at his office.

Earlier in the morning, Home Advisor Jahangir Alam said his office has sent a letter to the foreign ministry to facilitate the ousted



"We have sent a letter to the foreign ministry regarding her extradition. The process is currently underway," he told reporters in response to a query.

Alam said an extradition treaty between Dhaka and New Delhi already exists and Hasina could be brought back to Bangladesh under

In October, Law Adviser Asif Nazrul had reportedly said that Bangladesh would strongly protest if India tried to refuse Hasina's extradition by citing any provision in the treaty.

In an interview with PTI in Dhaka in September, Yunus had said that Hasina making political remarks from India is an "unfriendly gesture", asserting that she must remain silent to prevent discomfort to both countries until Dhaka requests her extradition.

"If India wants to keep her until the time Bangladesh (government) wants her back, the condition would be that she has to keep quiet," he said.

In recent weeks, Hasina has accused the Yunus-led interim government perpetrating "genocide" and failing to protect minorities, especially Hindus, since her ouster. (PTI)

Trump threatens to try take back Panama Canal

PHOENIX, Dec 23: Donald Trump suggested Sunday that his new administration could try to regain control of the Panama Canal that the United States "foolishly" ceded to its Central American ally, contending that shippers are charged "ridiculous" fees to pass through the vital transportation channel linking the Atlantic and Pacific Oceans.

Panama's conservative president José Raúl Mulino, who was elected in April on a pro-business platform, roundly rejected that notion as an affront to his country's

The Republican presidentelect's comment came during his first major rally since winning the White House on Nov. 5. He also basked in his return to power as a large audience of conservatives cheered along. It was a display of party unity at odds with a just-concluded budget fight on Capitol Hill, where some GOP lawmakers openly defied their leader's de-

Addressing supporters at Turning Point USA's AmericaFest in Arizona, Trump pledged that his "dream team Cabinet" would deliver a booming economy, seal U.S. borders and quickly settle wars in the Middle East and Ukraine.

"I can proudly proclaim that the Golden Âge of Âmerica is upon us," Trump said. "There's a spirit that we have now that we didn't have just a short while ago."

His appearance capped a fourday pep rally that drew more than 20,000 activists and projected an image of Republican cohesion despite the past week's turbulence in Washington with Trump pulling strings from his Mar-a-Lago resort in Florida as Congress worked to avoid a government shutdown heading into the holidays.



House Republicans spiked a bipartisan deal after Trump and Elon Musk, his billionaire ally, expressed their opposition on social media. Budget hawks flouted Trump's demand that they raise the nation's debt ceiling, which would have spared some new rounds of the same fight after he takes office on Jan. 20, with Republicans holding narrow control of the House and Senate. The final agreement did not address the issue and there

was no shutdown. Trump, in his remarks in Phoenix, did not mention the congressional drama, though he did reference Musk's growing power. To suggestions that "President Trump has ceded the presidency to Elon," Trump made clear, "No, no. That's not happening.'

"He's not gonna be president," Trump said.

The president-elect opened the speech by saying that "we want to try to bring everybody together. We're going to try. We're going to really give it a shot." Then he suggested Democrats have "lost their confidence" and are "befuddled" after the election but eventually will "come over to our side because we want to have them."

Atop a list of grievances some old, some new — was the Panama Canal.

"We're being ripped off at the Panama Canal," he said, bemoaning that his country "foolishly gave it away." The United States built the canal in the early 1900s as it looked for ways to facilitate the transit of commercial and military vessels between its coasts. Washington relinquished control of the waterway to Panama on Dec. 31, 1999, under a treaty signed in 1977 by President Jimmy Carter.

The canal depends on reservoirs to operate its locks and was heavily affected by 2023 Central American droughts that forced it to substantially reduce the number of daily slots for crossing ships. With fewer ships using the canal each day, administrators also increased the fees that are charged all shippers for reserving a slot.

With weather returning to normal in the later months of this year, transit on the canal has normalized. But price increases are still ex-

pected for next year. Mulino, Panama's president, has been described as a conservative populist who aligns with Trump on many issues. Panama is a strong U.S. ally and the canal is crucial for its economy, generating about one-fifth of that government's an-

Former Israeli spies describe attack using exploding electronic devices against Hezbollah



WASHINGTON, Dec 23: Two recently retired senior Israeli intelligence agents shared new details about a deadly clandestine operation years in the making that targeted Hezbollah militants in Lebanon and Syria using exploding pagers and walkie talkies three months ago.

Hezbollah began striking Israel almost immediately after Hamas' Oct. 7, 2023, attack that sparked the Israel-Hamas war.

The agents spoke with CBS "60 Minutes" in a segment aired Sunday night. They wore masks and spoke with altered voices to hide their identities.

One agent said the operation started 10 years ago using walkie-talkies laden with hidden explosives. which Hezbollah didn't realise it was buying from Israel, its enemy. The walkie-talkies were not detonated until September, a day after booby-trapped

We created a pretend world," said the officer, who went by the name "Michael."

pagers were set off.

Phase two of the plan, using the booby-trapped telligence agency learned Hezbollah had been buying pagers from a Taiwan-based company, the

second officer said. The pagers had to be made slightly larger to accommodate the explosives hidden inside. They were tested on dummies multiple times to find the right amount of explosive that would hurt only the Hezbollah fighter and not anyone else in close

Mossad also tested numerous ring tones to find one that sounded urgent enough to make someone pull the pager out of their pocket.

The second agent, who went by the name "Gabriel," said it took two weeks to convince Hezbollah to switch to the heftier pager, in part by using false ads on YouTube promoting the devices as dustproof, waterproof, providing a long battery life and more. He described the use of shell companies, including one based in Hungary, to dupe the Taiwanese firm, Gold Apollo, into unknowingly partnering with the Mossad.

Hezbollah also was unaware it was working with

Gabriel compared the ruse to a 1998 psychological film about a man who has no clue that he is liv-

ing in a false world and his family and friends are

actors paid to keep up the illusion. "When they are buying from us, they have zero clue that they are buying from the Mossad," Gabriel said. "We make like Truman Show,' everything is controlled by us behind the scene. In their experience, everything is normal. Everything was 100% kosher including businessman, marketing, engineers, showroom, everything.

By November, the war between Israel and Hezbollah, a byproduct of the deadly attack by Hamas militants in southern Israel on Oct. 7, 2023, ended with a ceasefire. More than 45,000 Palestinians have been killed in the war in Gaza between Israel and Hamas militants, health officials have said.

Magdeburg mourns Christmas market attack victims

MAGDEBURG (GERMANY), Dec 23: Mourners laid flowers near the scene of the deadly Christmas market attack on Monday as investigators puzzled over the motive of the suspect and fears swirled that the rampage could deepen divisions in German society. The Johanniskirche, a church a short walk from the scene of the attack, has become a central place of mourning since the suspect drove a car into the busy market on Friday evening, killing five people and injuring 200. A carpet of flowers now covers the broad sidewalk in front of the church.

Authorities have identified the suspect as a Saudi doctor who arrived in Germany in 2006 and had received permanent residency. They say he does not fit the usual profile of perpetrators of extremist attacks.

The man described himself as an ex-Muslim who was highly critical of Islam and in many posts on social media expressed support for the far-right. A picture has emerged of someone who had come to authorities' attention in the past for threatening behaviour and been the subject of tipoffs, but was not known to have committed any violence.

German Interior Minister Nancy Faeser said Sunday that "the views and statements that the perpetrator expressed are being investigated, as are the tipoffs and proceedings with various authorities and the justice system." She said "the right conclusions" will then have to be drawn.

The country's vice chancellor voiced fears that the attack will fuel online misinformation ahead of a national election expected in late February. He urged people to "take time for the truth" and said: "Don't let yourselves

"There is still a lot we don't know and a lot is unexplained, including the exact motive," Robert Habeck said in a video posted

China says Philippine plan to deploy midrange missiles would be 'extremely irresponsible'

BEIJING, Dec 23: China said a plan by the Philippines to deploy midrange missiles would be a provocative move that stokes regional tensions.

The Philippines top army official told reporters in Manila earlier on Monday that the military plans to acquire a mid-range system to defend the country's territory amid tensions with China in the South China Sea.

"Yes, there are plans, there are negotiations, because we see its feasibility and adaptability," Lt Gen Roy Galido said.

The US deployed its Typhon mid-range missile system in the northern Philippines in April and troops from both countries have been training jointly for the potential use of the heavy weaponry.

China opposes US military assistance to the Philippines and has been particularly alarmed by the deployment of the Typhon system. Under President Joe Biden, the US has strengthened an arc of military alliances in the Indo-Pacific to counter course, with the Philippine navy and the Philippine China, including in any confrontation over Taiwan. air force," Galido said. (AP)

China's Foreign Ministry spokesperson Mao Ning said that deployment of the weapon by the Philippines would intensify geopolitical confrontation and an arms race.

"It is an extremely irresponsible choice for the history and people of itself and the whole of Southeast Asia, as well as for the security of the region," she told a daily briefing.

The Philippines would not necessarily buy the Typhon system, Galido said.

The army is working not only with the United States but with other friendly countries on a long list of weapons platforms that it plans to acquire,

The Philippines defence plan includes protecting its exclusive economic zone, which reaches 200 nautical miles (370 km).

Prime Minister Edi Rama said Saturday the government will shut down TikTok for one year, accusing the popular video service of inciting violence and bullying, especially among children.

Authorities have held 1,300 meetings with teachers and parents since the November stabbing death of a teenager by another teen after a quarrel that started on social media apps. Ninety per cent of them approve of the ban on TikTok.

"The ban on TikTok for one year in Albania is not a rushed reaction to a single incident, but a carefully

ent communities in schools across the country," said Rama on Sunday.

Following Tirana's decision, TikTok asked for "urgent clarity from the Albanian government" in the case of the stabbed teenager. The company said it had "found no evidence that the perpetrator or victim had TikTok accounts, and multiple reports have in fact confirmed videos leading up to this incident were being posted on another platform, not Tik-

"To claim that the killing of the teenage boy has no connection to TikTok because the conflict didn't originate on the platform demonstrates a failure to grasp both the seriousness of the threat TikTok poses to children and youth today and the rationale behind our decision to take responsibility for addressing this threat," said Rama.

"Albania may be too small to demand that Tik-Tok protect children and youth from the frightening pitfalls of its algorithm," he said, blaming TikTok for "the reproduction of the unending hell of the lan-

guage of hatred, violence, bullying and so on." Albanian children comprise the largest group of TikTok users in the country, according to domestic researchers.

Many youngsters in Albania did not approve of the ban. "We disclose our daily life and entertain ourselves, that is, we exploit it during our free time," said Samuel Sulmani, an 18-year-old in the town of Rreshen, 75 km north of the capital Tirana, on Sunday. "We do not agree with that because that's a deprivation for us." (AP)

Bethlehem plans another somber Christmas under the shadow of war

Dec 23: The Nativity Store in Manger Square has sold handmade olive wood carvings and religious items to people visiting the traditional birthplace of Jesus since 1927. But as Bethlehem prepares to mark its second Christmas under the shadow of the war in Gaza, there are almost no tourists, leaving the Nativity Store and other businesses unsure of how much longer they can hold on.

For the second straight year, Bethlehem's Christmas celebrations will be somber and muted, in deference to ongoing war in Gaza. There will be no giant Christmas tree in Manger Square, no raucous scout marching bands, no public lights twinkling and very few public decorations or displays.

"Last year before Christmas, we had more hope, but now again we are close to Christmas and we don't have anything," said Rony Tabash, the third-generation owner of Nativity Store.

Israel's war against Hamas has been raging for nearly 15 months, and there still is no end in sight. Repeated ceasefire efforts have

Since the war began, tourism to

West Bank has plummeted. And after Israel barred entry to most of the 150,000 Palestinians in the West Bank who had jobs in Israel, the Palestinian economy contracted by 25% in the past year. The yearly Christmas celebra-

tions in Bethlehem — shared among Armenian, Catholic and Orthodox denominations — are usually major boons for the city, where tourism accounts for 70% of its yearly income. But the streets are empty this season. Tabash said he continues to open

the store every day, but often an entire week will go by without a sale. Tabash works with more than 25 local families who create handcarved religious items out of the region's storied olive wood. But with no buyers, work has dried up for these families.

The number of visitors to the city plunged from a pre-COVID high of around 2 million visitors per year in 2019 to fewer than 100,000 visitors in 2024, said Jiries Qumsiyeh, the spokesperson for

the Palestinian tourism ministry. According to the Christmas story, Mary was forced to give birth to Jesus in a stable because



there was no room at the inn. Today, nearly all of Bethlehem's 5,500 hotel rooms are empty.

The city's hotel occupancy rate plunged from around 80% in early 2023 to around 3% today, said Elias Al Arja, the head of Bethlehem Hoteliers Association. At his own hotel, the Bethlehem Hotel, he said he has laid off a staff of more than 120 people and retains just five employees.

The city hosts more than 100 stores and 450 workshops dealing with traditional Palestinian handicraft, Qumsiyeh said. But just a

week before Christmas, when the city should be bursting with visitors, Manger Square was mostly empty save for a few locals selling coffee and tea. Only two of the eight stores in the main drag of the square were open for business.

Oumsiveh worries that when the war ends and tourism eventually rebounds, many of the families that have handed down traditional skills for generations will no longer be making the items that reflect Palestinian heritage and cul-

Many are leaving the region en-

tirely. "We have witnessed a very high rate of emigration since the beginning of the aggression, especially among those working in the tourism sector," said Qumsiyeh.

Almost 500 families have left Bethlehem in the past year, said Mayor Anton Salman. And those are just the families who moved abroad with official residency visas. Many others have moved abroad on temporary tourist visas and are working illegally, and it's unclear if they will return, Salman

Around half of the population in the Bethlehem area, including nearby villages, works in either tourism or in jobs in Israel.

The unemployment rate in Bethlehem is roughly 50%, said Salman. Unemployment across the West Bank is around 30%, according to the Palestinian Economy Ministry.

Canceling Christmas festivities is one way to draw attention to the difficult situation in Bethlehem and across the Palestinian territories, said Salman. "This year we want to show the world that the Palestinian people are still suffering and they haven't the joy that everybody else in the world having," said Salman.

It is another blow to the Holy Land's dwindling population over the decade due to emigration and a low birthrate. Christians are a small percentage

of the population. There are about 182,000 in Israel, 50,000 in the West Bank and Jerusalem and 1,300 in Gaza, according to the U.S. State Department Father Issa Thaljieh, the parish

priest of the Greek Orthodox Church in the Church of the Nativity, said many families are struggling financially, leaving them unable to pay rent or school fees, much less buy Christmas presents or celebrate the holiday in other ways. The church's social services have tried to help, but the needs are

great, he said. Thaljieh said his Christmas message this year focused on encouraging Palestinians in Bethlehem to

stay despite the challenges. "A church without Christians is not a church," he said, as workers hand-polished the ornate brass candelabras in the cavernous, empty church a week before the holiday.

"The light that was born when Jesus Christ was born here is the light that moves beyond darkness, so we have to wait, we have to be patient, we have to pray a lot, and we have to stay with our roots because our roots are in Bethlehem,' he said

Some families are finding ways to bring back pockets of joy.

Bethlehem resident Nihal Bandak, 39, gave into her three children's requests to have a Christmas tree this year, after not having one last year. Decorating the tree is the favorite part of Christmas of her youngest daughter, 8-year-old Stephanie.

Mathew Bandak, 11 was thrilled his family brought back some of their traditions, but also torn.

"I was happy because we get to decorate and celebrate, but people are in Gaza who don't have anything to celebrate," he said.

Rony Tabash, the third-generation owner of Nativity Store, said he will continue to open the store, because it's part of his family's his-

"We are not feeling Christmas, but in the end, Christmas is in our hearts," he said, adding that the entire city was praying for a ceasefire and peace. "We have a big faith that always, when we see Christmas, it will give us the light in the

BSF apprehends 13 Bangladeshi smugglers

SHILLONG, Dec 23: Acting on specific intelligence on Sunday, vigilant troops of 4 Bn, BSF Meghalaya Frontier, apprehended 13 Bangladeshi nationals involved in smuggling activities, a BSF source said. NC leader holds protests demanding against Kejriwal; vows to remove AAP from power rationalisation of reservation in J&K

and Lok Sabha member from Srinagar Aga Ruhullah Mehdi on Monday led a peaceful protest outside the residence of Chief Minister Omar Abdullah to support the demand for rationalisation of reservation in Jammu and Kash-

The firebrand leader had on Sunday announced that he will be joining the peaceful protests against the existing reservation policy in Jammu and Kashmir implemented after the abrogation of Article 370.

With the Centre granting reservation to Pahari-speaking people in Jammu and Kashmir, the open merit category has been reduced to just 30 per cent while 70 per cent seats are reserved for various com-

Students, especially those undergoing training in medicine and surgery, have been protesting against this policy, saying it promotes mediocrity where merit should reign supreme.

Several political leaders, includ-



ing Lok Sabha member from Baramulla Sheikh Abdul Rashid alias Engineer and arch-rival PDP leaders Waheed Para and Iltija Mufti, have supported the protest led by the NC leader against his own party government.

Mirwaiz Umar Farooq, the chairman of the separatist Hurriyat Conference, has also called for rationalisation of the reservation. PDP MLA from Pulwama in a

post on X said he "wholeheartedly welcome Ruhullah's decision to stand with the youth in demanding rationality and fairness in reservation policies. This is a pivotal moment to address pressing grievances and ensure our policies are inclusive, youth-friendly, and

Para said at the heart of this matter lies the urgent and vehement demand for proportional repopportunities based on the socioeconomic realities of communities, ensuring no group is disproportionately favoured or left

"Our demand is not antithetical to affirmative action. In fact, we are in favour of strengthening it. We believe that inclusion through reservation must go beyond tokenism to foster substantive equality. We believe in empowering marginalised communities to not just be present but to shape decisions and lead change.

"However, let's be clear: Merit must remain the bedrock of our systems. Reservations must serve only as targeted exceptions to bridge inequalities, not as tools for perpetual imbalance. Policies that reduce the majority to a minority are neither just nor sustainable,' he added.

The Mirwaiz, in a post of X, said the issue of reservation should be addressed with justice and fairness by those in charge, safeguarding the interests of all pense of any one group.

"The current status of reservations does that, by undermining the interests of the General/open merit category. Fervent appeal to address their concerns immediately! Support #openmeritstudentsassociation @OMSA_JK sit in protest," he said.

The Mirwaiz said he would be part of the protests if allowed by the authorities.

"Would be part of it if authorities allowed. My delegation will be there to support. Will also raise the issue in #JamaMasjid whenever permitted to go," he added.

Awami Ittehad Party MLA Sheikh Khursheed and chief spokesman Inam un Nabi also joined the protests in support of rationalisation of reservations.

Jammu and Kashmir Chief Minister Omar Abdullah on Sunday said while his government has formed a sub-committee to review the reservation policy, it will abide by the court directions on the mat-

BJP issues 'chargesheet'



NEW DELHI, Dec 23: Senior BJP leader Anurag Thakur on Monday issued a "chargesheet" against AAP national convenor Arvind Kejriwal, accusing him of turning Delhi into a "corruption

lab" through a series of "scams". No immediate reaction was available from the Aam Aadmi Party (AAP) over the allegations of the BJP leader.

Ahead of the Delhi Assembly polls, the state unit of the BJP has formed a "chargesheet committee" that has so far issued detailed reports listing the alleged failures of the ruling AAP MLAs.

'What kind of a party is this which came to power promising to give corruption-free government but was involved in eight to nine scams related to the liquor policy, Delhi Jal Board, DTC, Waqf Board," Thakur charged.

"Ĝhotale Pe Ghotala, Kejriwal Ne Banaya Delhi Ko Bhrashtachar Ki Prayogshala" (Kejriwal turned Delhi into a laboratory of corruption with scams), Thakur gave the slogan and asserted that

the BJP will remove the AAP from power in Delhi.

The elections for the 70-member Delhi Assembly are due to be held in February next year.

The former Union minister also targeted the AAP and Kejriwal over education and health, alleging it failed to open new Mohalla Clinics and hospitals and did not use the Centre's funds to boost the city's healthcare infrastructure.

He charged that the smog tower in Connaught Place, which was supposed to provide relief from air pollution, was lying defunct although the AAP government spent crores of rupees on advertisement

He cited water shortage, lack of sanitation, damaged roads, and other issues to corner the ruling

Thakur also alleged that the AAP has been supporting "antinational" forces and Kejriwal questioned India's surgical strikes. He said the party got the support of "Khalistanti elements" during the Punjab polls. (PTI)

CPI(M) rallies behind party member on his remarks against Rahul, Priyanka

The ruling CPI(M) leaders on Monday rallied behind the party's politburo member A Vijayaraghavan in the raging political row over his controversial remarks on the Lok Sabha poll victories of Congress leaders Rahul Gandhi and Priyanka Gandhi Vadra from Wayanad.

During a recent party event in Wayanad, Vijayaraghavan reportedly claimed that Rahul secured victory in the high-range segment twice with the support of communal forces and that extremist elements were present at Priyanka Gandhi's campaign rallies.

Prominent Marxist party leaders on Monday said that Vijayaraghavan didn't say anything wrong or against the party's policy and they would oppose minority communalism and majority communal-

They also reiterated the charges raised by Vijayaraghavan against the Congress and accused the grand-old party of entering into an unholy nexus with communal outfits for electoral gains.

The CPI(M) leadership came out in support of the politburo member a day after the Congress and their United Democratic Front (UDF) ally, the Indian Union Muslim League (IUML), alleged that Vijayaraghavan was attempting to provoke majority communalism in soci-

When his reaction was sought by the media, CPI(M) state secretary M V Govindan said what Vijayaraghavan had said was accurate and alleged that communal outfits like SDPI and Jamaat-e-islami were acting like front partners of the

He charged that their nexus was evident during the recent Palakkad Assembly bypoll.

The criticism against the Jamaat-e-islami was not against the Muslim community and the opposition against the RSS was not against the Hindus, he said, adding that the CPI(M) would not show any compromise in opposing both the minority and majority communalism.

Strongly supporting Vijayaraghavan, senior CPI(M) leader and ruling LDF convenor T P Ramakrishnan said the leader had criticised the stand of the Congress party, which forges a nexus with communal forces during elections.

"Vijayaraghavan has not taken any communal stand. His remarks were also not meant to promote communalism. He has taken a stand that can safeguard society from communal forces," he said.

Senior leader and former minister P K Sreemathi also said Vijayaraghavan had not said anything other than the Marxist party's policy and stand.

Pointing out that communal and extremist forces are gaining strength in the state, she said they cannot be allowed to flourish in Kerala. "Whoever it is... whether it is Hindu

communalism or Muslim extremism, the CPI(M) will take a strong stand against it." she said. She also accused the Congress of forg-

ing ties with communal forces during On Sunday, Congress leaders accused Viiavaraghavan of making comments against Rahul and Priyanka to "please" the Sangh Parivar, while the IUML al-

leged that he was attempting to provoke majority communalism in society. AICC general secretary K C Venugopal strongly criticised Vijayaraghavan, accusing him of using "communal" language that even the Sangh Parivar might hesitate to employ against Rahul. Venugopal also questioned whether the

CPI(M) shared the same opinion. Leader of Opposition, V D Satheesan. echoed similar sentiments, charging the CPI(M) with pushing the same communal agenda propagated by the Sangh Pari-

Harshly criticising Vijayaraghavan, KPCC chief K Sudhakaran accused the ruling CPI(M) of "surrendering to extreme communalism and providing support to the RSS in the state". (PTI)

Bhujbal meets Fadnavis

CM hints at national stage for sulking leader

MUMBAI/PUNE, Dec 23: Senior NCP leader Chhagan Bhujbal, who is sulking over not being included in the new Mahayuti government in Maharashtra, met Chief Minister Devendra Fadnavis here on Monday.

Talking to reporters after the meeting, Bhujbal said he had an elaborate discussion with the CM on the prevailing political and social atmosphere in the state. In Pune, Fadnavis said there are plans to send Bhujbal to the "national stage" since Deputy CM Ajit Pawar wants the NCP to become a "national party".

The former state minister was accompanied by his nephew Sameer Bhujbal during the nearly 30-minute meeting with Fadnavis at the latter's 'Sagar' bunglow in Mumbai.

Fadnavis told me that the Other Backward Classes have played an important role in the landslide victory of the Mahayuti in the assembly elections (held on November 20) and he will take care that the OBC community's interest is not harmed," Chhagan Bhujbal said.

He also said Fadnavis has sought some time to think over the issues pertaining to OBCs. "He (Fadnavis) said he would arrive at some

decision in 10 to 12 days," the NCP leader added. OBC leaders are opposed to activist Manoj Jarange's demand for reservation for the Maratha community in the Other Backward Class (Kunbi) category. Bhujbal has also been vocal about his opposition to the demand.

Asked if he was planning to switch over to the BJP, Chhagan Bhujbal refused to elaborate and said he has already spoken his mind on the issue of him being ignored in the ministry expansion. Speaking to reporters in Pune, Chief Minister Fadnavis said there are discussions underway to send Bhujbal to the national stage.

"Bhujbhal met me in Mumbai. He has already told you the reasons for which the visit was scheduled. He is our leader. Ajit Pawar cares about Bhujbhal saheb. Ajit dada wants his party to become a national party. Thus, it was discussed to send Bhujbhal saheb to the national stage," the CM said.

On Sunday, representatives of OBC organisations from different parts of Maharashtra met Bhujbal in the city.

The NCP leader, who represents Yevla constituency in Nashik district, did not attend the Winter Session of the state legislature that concluded in Nagpur on Saturday.

He left for Nashik on December 16, a day after 39 Mahayuti MLAs took oath as ministers. The Mahayuti, comprising the BJP, Shiv Sena led by Eknath Shinde and Ajit Pawar's NCP, won 230 of the 288 seats in the state assembly polls held last month. (PTI)

He died on December 15 at a state-run hospital where he was rushed after complaining of chest pain and uneasiness while he was in udicial custody and lodged at the Parbhani district central prison, as

23: Three suspected Khalistani terrorists allegedly involved in the grenade attack in Gurdaspur were killed in an encounter with police in Pilibhit early Monday, with Puniab's Director General of Police Gaurav Yadav terming it as a major breakthrough against a Pakistansponsored terror module.

The success comes after three blasts which took place in different districts of Punjab this month.

The gunfight between members of the Khalistan Zindabad Force (KZF) and a joint team of Uttar Pradesh Police and Punjab Police took place in Puranpur area of Pilibhit after three module members opened fire at the police party.

DGP Yadav said the three have been identified as Varinder Singh alias Ravi (23), Gurvinder Singh (25) and Jashanpreet Singh alias Partap Singh (18).

They are residents of Kalanaur police station and are accused of hurling a hand grenade at the Bakshiwala police post in Kalanaur in Punjab's Gurdaspur district on December 18, a Punjab police statement said on Monday. No one was injured in the Bakshiwala incident.

Terrorist organisation KZF had later used social media platform to claim the responsibility for this act of terror.

Amitabh Yash, Additional Director General (Law and Order), Uttar Pradesh Police said the trio was involved in the grenade attack on a police checkpoint in Gurdaspur.

"The three sustained serious injuries in the encounter and were immediately rushed to CHC Puranpur for treatment," he said.

The ADG told PTI that the three suspects later succumbed to their cording to the statement.

LUCKNOW, Dec 23: The Maha Kumbh Mela 2025 will see a strong force of 50,000 police personnel fanning out across Prayagraj to respond to potential terror threats, cyber attacks, rogue drones and human trafficking, Uttar Pradesh Director General of Police, Prashant Kumar said on Mon-

Held every 12 years, the Maha Kumbh will be organised in Prayagraj from January 13 to February 26. About 45 crore pilgrims are expected at the Maha Kumbh.

In an exclusive interview to PTI, the state DGP said he is personally overseeing measures for a safe and secure Kumbh.

Kumar said this Kumbh will be truly digital in which the police force will use modern technologies like AI enabled cameras, drones and effective strategy to detect and neutralise rogue drones.

With cyber crimes on the rise, police is also taking all measures to save pilgrims from cyber crimi-

"Ahead of the Mahakumbh, the police force has hired a team of private experts from the Future Crime Research Foundation and tied up with IIT Kanpur for cyber world patrolling to save pilgrims from cyber frauds and crimes," the DGP said.

'We have established a cyber police station in the Mahakumbh area for the first time. We have roped in national agencies like I4C and CERT-IN for cyber patrolling and analysing cyber security networks. They will also work on data protection," the officer added.

Asked about the police deployment, Kumar said this time there will be around 50,000 policemen on duty which is 40 per cent more that that last Kumbh in 2019.

NHRC notice to TN govt, DGP over electrocution of 2 labourers during repair work



NEW DELHI, Dec 23: The NHRC on Monday said it has issued a notice to the Tamil Nadu government and the state's police chief over reports that two persons, working as contract labourers with the Tamil Nadu Generation and Distribution Corporation were electrocuted while repairing a high-tension overhead power line in Tiruchi.

Commission in a statement said it has also noted that such incidents have occurred earlier too in the state. This is a "serious human rights violation" and a "matter of concern" for the rights panel.

The NHRC has taken "suo motu cognisance of a media report that two persons, working as contract labourers with the Tamil Nadu Generation and Distribution Corporation (Tangedco) died due to electrocution while repairing a high-tension overhead power line near Olaiyur Ring Road in KK Nagar, Tiruchi in Tamil Nadu on December 18, 2024," it said.

The Commission has observed that the contents of the media report, if true, "indicate gross negligence" on the part of the electricity department resulting in the death of two labourers.

Accordingly, it has issued notices to the chief secretary and the director general of police of Tamil Nadu, seeking a detailed report within two weeks.

"It is expected to include the status of the FIR registered in the matter and compensation, if any provided to the next of kin of the two victims. The Commission would also like to know the steps taken or proposed by the state government and Tangedco to ensure that such incidents do not recur," it added.

According to the media report, as per the preliminary investigations, the power supply to the cable was "not fully turned off during the repair work". The workers were on the job without any protective gear, the statement said, quoting the re-

In a similar incident, a worker was electrocuted while repairing a transformer in the Thoothukudi district of Tamil Nadu last year. Last month, a migrant worker was reportedly electrocuted during Cyclone Fengal and his body was found near an ATM in Muthialpet,



forests in government records. The overall results could have been stronger, especially since the government included bamboo and smaller trees (5-10 cm diameter at breast height) in the tree cover estimates for ISFR 2023. The assessment also expanded to 751 districts, up from 636 in 2021.

Experts including Kerala's former principal chief conservator of forests Prakriti Srivastava, conservationist researcher Krithika Sampath and former National Board for Wildlife member Prerna Singh Bindra claimed that the government counted bamboo plantations, coconut groves, and orchards among others as part of the forest cover and produced "another



They argued that such areas do not offer any ecological value for

biodiversity and wildlife conservation. The increase in tree cover (1.289 sq km) is also mainly due to plantations of rubber, eucalyptus, acacia and mango, coconut, areca nut and shade trees in tea and coffee plantations.

Forest cover refers to all land that has a tree canopy density of more than 10 per cent and spans over an area of one hectare or more, regardless of the type of ownership or legal status. It includes natural forests as well as man-made plantations, orchards and tree patches in urban and rural areas that meet the size and canopy

Tree cover is defined as patches of trees and isolated trees outside

RFA that are less than one hectare. "Mango contributes to 13.25 per cent of the tree cover," they

They said according to government data, 1,488 sq km of unclassed forests have been lost between 2021 and 2023 but "there is no explanation for it" in the ISFR 2023.

'Unclassed forests' are non-notified forests under government ownership.

The experts also said the report does not establish a correlation between forest area (areas designated as forests in government records) and forest cover.

The report "clearly reflects that the data on both is not robust and therefore cannot be correlated", the experts said. They claimed that the report failed to comply with the

Supreme Court order in the Lafarge case which called for digitiof forest maps, geo-referencing of Recorded Forest Areas (RFA), and documentation of diverted forest lands. The absence of these elements weakens the report's credibility.

They also said that forest lands diverted for dams, roads, railways and other such permanent constructions are lost forever, but are not deleted from records, thus "inflating the figures".

Debadityo Sinha, who leads the climate and ecosystems team at the Vidhi Centre for Legal Policy, said India lost 30,808 sq km of open and scrub forests alongside 14,073 sq km of moderately dense forests and 1,816 sq km of dense forests to "non-forest" uses.

The report mentions the carbon sequestration potential of 406.05 million tonnes of carbon from these degraded lands but is silent on non-forest uses, Sinha posted

on X "In my understanding, these areas are already home to some of the country's most significant engineering projects -- mines, highways, and strategic developments of national importance -- and many are being planned or approved following the latest amendments to the Forest Conservation Act," he said. The experts expressed concerns that the forest cover in the



The film, directed by Barry Jenkins, serves as both a prequel and sequel to "The Lion King", the 2019 remake of the 1994 animated movie. It explores the journey of Mufasa from an orphaned cub to becoming the king of the jungle.

Superstar Shah Rukh Khan has voiced the title role of Mufasa in the Hindi dubbed version along with his elder son Aryan Khan lending his voice to Simba and his youngest son AbRam Khan as Mufasa, the cub. Mishra said he was motivated to dub for Pumbaa after he heard actor Shreyas Talpade record for the character of Timon, the meerkat. Timon and Pumbaa are the iconic duo who feature in "The Lion King" universe as friends and mentors of Simba, Mufasa's son. "I never liked dubbed English films because they (Hindi dubbed dialogues) sounded incomplete. Today, attention is paid to every word and not just on the first and last word. "I was initially a bit worried. But when I heard the way Shreyas did it, I felt he did it the way it was required. So, I did it exactly on the basis of what was written in the script," Mishra told PTI. The actor said he simply followed the pace and rhythm set by Talpade to dub for his character.

"I ensure I dub after Shreyas because he is born and brought up in Mumbai so I believe he rather understands the character well. So, I just follow him, it helps me," he added, in a reference to using the local Mumbai dialect for voice acting in "Mufasa: The Lion King". Mishra, known for films such as "Ankhon Dekhi", "Dhamaal", "Vadh", and "Bhool Bhulaiyaa 3", said directors today are actively reaching out to him for various projects.

"That's the change that has happened. Like, 'Vadh' part two is being made, it was great working with the directors (Jaspal Singh Sandhu and Rajeev Barnwal). Then I'm working on the next part of 'Dhamaal'. I'm happy that directors today want to work with me," the 61-year-old actor said. 


However, assessing performances, especially in films, isn't something he engages in.

Liverpool rout Spurs 6-3 to take 4-point lead into Christmas in Premier League

LONDON, Dec 23: Liverpool heads into Christmas with a four-point lead, a game in hand and as the overwhelming title favorite in the Premier League on the back of a wild 6-3 win at

As for Manchester United and its new manager Ruben Amorim, they stumble into the festive period in 13th place as low as they've been at Christmas since the 1989-90 season - and with a familiar sinking feeling. United lost 3-0 at home to Bournemouth for the second straight season, the latest statistic to show just how far this English giant has fallen and the

job Amorim has to turn around its fortunes.

Worse for United, it seems like great rival Liverpool cannot be stopped.

Make that 21 games in all competitions without defeat after the Reds' biggest league win of the season, with Mohamed Salah netting two of the goals to move above Manchester City's Erling Haaland to the

top of the scoring charts. Liverpool has 39 points from 16 games and stretched its lead over second-place Chelsea, which could only draw 0-0 at Everton, to end a five-match winning streak in the league.

Salah now has 15 goals in the Premier League to break a tie with Haaland — and will leave London thinking he should have had more.

In an end-to-end contest resembling a basketball match, Liverpool scored more than five goals for the first time this season, with Luis Diaz (two), Alexis Mac Allister and Dominik Szoboszlai also netting.

"You can see quality players with top discipline," Tottenham captain Son Heung-min said. "There's a reason they are top. If vou give them a mistake, they punish you."

Tottenham's injury-hit de-

fense was open at the back but its attack caused Liverpool's problems throughout, with James Maddison, Dejan Kulusevski and Dominic Solanke all finding the net.

Spurs are another big team in the bottom half, having slipped to 11th place.

The optimism that might have been generated by a last-gasp 2-1 derby win at Manchester City last weekend has disappeared for United, which lost 4-3 at Tottenham in the English League Cup quarterfinals on Thursday before being handed a defeat to Bournemouth by the same score as 12 months ago.

The 2022 World Championship bronze-medallist failed to submit her whereabouts for the period between April 2022 and March 2023, as mandated by WADA regulations. The BFI was also to blame for this unprecedented embarrassment given that federation is duly notified of such a lapse by the international body.

The federation ought to have intervened to ensure that the athlete submitted the required details on time. As a result, India had to fight afresh for qualification in the women's 57kg category, the spot ultimately going to Jaismine Lamboria in the final Olympic Qualifiers. There were wholesale changes for this event with former Asian Games gold-medallist Amit Panghal replacing Deepak Bhoria in the 51kg category.

Eventually Panghal and Nishant made the cut for the quadrennial spectacle along with Jaismine, adding to the three quotas won by Nikhat Zareen (50kg), Preeti Pawar (54kg) and Lovlina (75kg)

In all, six boxers qualified for Paris, a decline from the five men and four woman who represented India in the 2021 Tokyo Games.

Heading into the big event on the back of two consecutive World Championship titles, Zareen was hailed as one of India's strongest medal contenders.

However, in the fiercely competitive 50kg category, the Telangana boxer was completely outclassed by China's Wu Yu in a brutally one-sided bout.

Zareen, unable to match the relentless pace of her opponent, later said that she had "not eaten for the last two days to maintain weight"

US Open doubles champion Max Purcell suspended for anti-doping breach

MELBOURNE, Dec 23: Twotime Grand Slam winning doubles player Max Purcell has entered a voluntary provisional suspension under tennis' antidoping rules.

The International Tennis Integrity Agency announced the sanction in a statement on Monday after the 26-year-old Australian admitted to violating Article 2.2 of the Tennis Anti-Doping Program "relating to the

Instagram saying he had "unknowingly received an IV infusion of vitamins above the allowable limit of 100 ml.'

Purcell said he had told the medical clinic that the infusion needed to be below 100 ml because he was a professional athlete, but that the medical records he received back showed that the IV had been above that level.

"This news was devastating to

Former AIFF secretary lodges complaint against Chaubey

In his formal complaint dated December 22, 2024, Prabhakaran also accused Chaubey of nepotism and even misusing the brand of FIFA without prior approval from the international body. When contacted by PTI for a reaction on Prabhakaran's allegations and the formal complaint, Chaubey declined to comment. Prabhakaran's allegations against Chaubey included conflict of interest, actions causing financial loss and reputational damage to AIFF, bribery attempt by a political functionary, misrepresentation and misinformation, use of AIFF platforms to further his political career and interference in administrative

MELBOURNE, Dec 23: The Indian team has expressed dissatisfaction with the practice pitches ahead of the fourth Test against Australia here, blaming their variable bounce for the hit that Rohit Sharma took on his knee but MCG curator Matt Page has defended the tracks by saying that "standard protocol" has

been followed. Rohit developed swelling on his left knee as he tried to play a throwdown from support staff member Dayanand Garani and didn't take further part in the nets on Sunday. The side opted not to practice on Monday. It was learnt the skipper needed icing at night and the team think-tank held the used pitch's uneven bounce responsible for the injury scare.

The Indian team had sent its training schedule two months ago but the MCG curator stuck to the standard operating procedure of giving a new practice track only three days prior to the Test match, which begins on December 26 in this case.

"So for us, three days out, we prepare pitches for here. If teams come and play before that, they get what pitches we've had," Page told reporters about why India didn't get a pitch that would resemble the centre

"So today, we're on fresh pitches. If we needed to play this morning, they would have been on those fresh pitches. Stock standard procedure for us, three days out. We do our pitches that we're going to have for our Test match," Page defended the

Pakistan completes a 3-0 sweep of ODI series against South Africa

JOHANNESBURG, Dec 23: Pakistan completed a 3-0 sweep of its ODI series against South Africa, winning the third match by 36 runs under the DLS method.

Opener Saim Ayub hit 101 runs in 94 balls as Pakistan scored 308-9 at the Wanderers in a game reduced to 47 overs by rain. South Africa was all out for 271 in 42 overs in pursuit of a winning target of 308.

Strike rotation and solid defence key to face Bumrah, says Simon Katich

cricketer Simon Katich has advised Australian batters to concentrate on rotating the strike and maintaining a solid defence to succeed against the peerless Indian pacer Jasprit Bumrah.

Katich noted that since Bumrah rarely bowls loose deliveries, the Australians must be strategically good in their approach.

"I know all the talk is around having more positive intent, and I think that's all well and good and it is certainly something they have to be mindful of. But against someone like Bumrah intent is not about just blazing him for fours, because he doesn't bowl many bad balls," Katich told SEN 1116.

"So a lot of that intent has to be about rotating strike and being able to defend really well, because you're not gonna be able to play with any intent if you aren't there after the tenth over. That's the challenge for all of these guys," Katich added.

To illustrate his point, Katich made a reference to Australia's second innings in the third Test at Brisbane, where the hosts attempted an aggressive approach but ultimately lost their wickets.

"We saw it in the second innings in Brisbane. Australians came out with really positive intent, trying to score more quickly and look what happened, 7/80 in no time.

"It's not easy to do against the red ball that moves around off the seam in a wearing wicket which the Gabba was starting to become with cracks.

"The top order has to be very careful and mindful of how they go about it. You're not going to score

him on off the length, because he is so good," he added.

For the remaining two Tests, Australia has opted to place their trust in teenage sensation Sam Konstas, replacing opener Nathan McSweeney, who was given a maiden call-up ahead of the series.

I know the young kid's (Konstas) got a lot of potential, and a lot of ability, but it'll be a challenge because not many guys around the world have been able to do that to that quality of bowling," Katich said. Katich also felt Mitchell Marsh's inability to bowl the expected volume of overs suggests he isn't "100%" fit and should be replaced by uncapped rookie Beau Webster for the Boxing Day Test against India.

Marsh has been dealing with recurring back stiffness since the white-ball tour of the UK in September. During the Perth Test, he bowled 17 overs in total, taking two wickets on the opening day but

later pulled up sore. In Adelaide, he bowled four overs while in Brisbane he rolled his arm for two overs.

"I've been saying for a couple Tests, Mitch Marsh has not been able to bowl the volume of overs that everyone expected of him. Given the conditions and given he is a wicket taker," Katich said on 'SEN Breakfast'.

"We saw that in Perth, he bowled well on day one. Took some key wickets and then struggled to back up. I mean obviously the Aussie hierarchy know better then we do around where his fitness is at. (PTI)

Chess player Tania Sachdev rues lack of recognition from Delhi govt

NEW DELHI, Dec 23: Olympiad gold-winning Indian chess player Tania Sachdev on Monday lamented the "lack of recognition" from the government of Delhi, prompting chief minister Atishi to reach out to her for "thoughts and suggestions" on the matter.

The 38-year-old Arjuna Awardee, who is based in the national capital, said the Delhi government is yet to acknowledge her achievements.

"Having played for India since 2008, it's disheartening to see a lack of recognition from the Delhi government for achievements in chess. States that support and celebrate their champions, directly inspire excellence and motivate talent. Sadly, Delhi has yet to take this step," she posted on her 'X' account.

"In 2022 Chess Olympiad I came back with a historic team bronze and an individual medal. Two years

later 2024, the historic Chess Olympic gold, and till date there has been no acknowledgment or recognition by the state govt," she said.

She tagged Atishi and her ruling Aam Aadmi Party supremo Arvind Kejriwal, urging them to support the state's chess players. Atishi responded to her post by inviting her for a conversation, while insisting that her government has been supportive of sporting talent.

"Hi Tania, we have always supported all our athletes, sportsmen and sportswomen, especially in our schools. Would love to meet you and understand what more can be done especially for chess players," Atishi

The ability to take 20 wickets is not that good in Indian team: Cheteshwar Pujara

MELBOURNE, Dec 23: The In- and even tailenders, Bumrah and dian team in Australia lacks a bowling attack that is good enough to take 20 wickets in a Test, Cheteshwar Pujara said on Monday and called it the side's biggest concerns heading into the last two matches of the Border-Gavaskar Trophy.

The five-match series is currently levelled at 1-1 with everything to play for in the Tests in Melbourne and Sydney.

The visitors have been relying heavily on pace spearhead Jasprit Bumrah to get them wickets and while he has been a great success with both the red and pink ball, the peerless fast bowler has not received enough support from the other end, something that has plagued India besides their toporder batting woes.

"My biggest question and the reason for a little bit of concern is that the Indian bowling is looking a little weak," Pujara told Star Sports. "Batting is a little better, like the



"Now, there is a weakness in the bowling, so what will you feed the team? That is the biggest question, because you can't drop Nitish, you can't drop Jadeja, so what will be the team combination?"

Pujara felt that Nitish Reddy and Ravindra Jadeja are not able to do the job of being the side's fourth and fifth bowler. "Ashwin has taken retirement,

so two spinners, I don't think they will play in Melbourne. So, how will you strengthen the bowling? Because the three seamers are very good, but their supporting role, fourth and fifth seamer, Nitesh Kumar is the fourth seamer and Ravindra Jadeia is the fifth bowler. If you add both of them together, the bowling is not that

"We will have to think about that, because if you want to win a Test match, then you have to take 20 wickets, and the ability to take 20 wickets is not that good, the sup-



not good, so we will have to improve that as soon as possible, and how that will be, I don't know, but that is a big question."

With the exception of opener KL Rahul, the top-order batting has also been a big letdown so far in the series, and Pujara said it has got to do a lot with their inability to see off Mitchell Starc's initial spells with

"He has been the best bowler for them in this series. And the way Mitchell Starc has played in the last 1-1.5 years, he has brought a lot of improvement. And he has a lot of ability.

"If I talk about my personal experience, when he used to play in the last series in 2018 or 2021, I used to feel that if he plays against

"And now, it feels like he will take wickets. So what is the difference? The difference is that his line length, his accuracy has increased a lot. He is bowling very less loose deliveries. He is playing on the stump. Every ball is hitting on the good length spot. He is getting swing.

Starc has so far taken 14 wickets in the series, the most by an Australian bowler and only behind Bumrah across two teams.

Pujara observed, "The change he has brought in his game has made him a different player. And he is looking more dangerous than Cummins and Hazlewood. So we will have to take care of his game, especially from the new games.

"In the first five overs, his first spell, he has taken the most wickets there. So if there is a good batting in the first five overs, bring him for the second or third spell. Because he gets tired. So the batting of the top order so far, our top order has never played in the third or fourth
