MUMBAI, Dec 24: The Indian economy is recovering from the slowdown in momentum witnessed in the September quarter, driven by strong festival activity and a sustained upswing in rural demand, according to a Reserve Bank of India (RBI) bulletin released on Tuesday.

An article on the 'State of the Economy' in the December bulletin noted that the global economy continues to exhibit resilience with steady growth and moderating inflation

"High frequency indicators (HFIs) for the third quarter of 2024-25 indicate that the Indian economy is recovering from the slowdown in momentum witnessed in Q2, driven by strong festival activity and a sustained upswing in rural demand," it said. The article further said the growth trajectory is poised to lift in the second half of 2024-25, driven mainly by resilient domestic private consumption demand

the only major state in the country to register a reduction in road accident fatalities, chief minister Himanta Biswa Sarma asserted on Tuesday

He said that while the state has witnessed dip in accident fatalities, the time period till January is very crucial to maintain these numbers.

"Assam is the only major state in the country to see reduction in road accident fatalities. Overall accidents and fatalities have seen a reduction of around 15 per cent. Many districts have seen a dip in accidents following enforcement of instructions of last review meeting." Sarma wrote on micro-blog-



ging site X after chairing a review the state will carry out extensive meeting on road safety in Dibru- measures to ensure that the state garh. The chief minister said that roads are safe for all.

Among steps to ensure continued improvement in road safety indices are strict enforcement of the 'No Drink and Drive' rule with intensified checking after 10 pm, especially in Guwahati, he said.

Sarma said an intensified road safety drive and monitoring will be carried out till 'Magh Bihu', the harvest festival celebrated in mid-January, while an SOP will be published to ensure safety in picnic spots. The excise department will also explore regulating bar timings and enforcing dynamic seasonal timings, he said.



NEW DELHI, Dec 24: In a bid to get battle-ready for challenges ahead, the Congress will decide on an action plan for the next year at its CWC meeting named 'Nav Satyagraha Baithak' being held in Karnataka's Belagavi to mark the 100th anniversary of the Belgaum session presided over by Mahatma Gandhi.

The opposition party asserted that the "insult" to B R Ambedkar by home minister Amit Shah will be taken up for deliberation at Belagavi and that there will be a "strong follow-up" on the issue.

Addressing a joint press conference along with Congress general secretary organisation K C Venugopal and AICC media and publicity department head Pawan Khera, Congress general secretary in-charge communications Jairam Ramesh said the extended Congress Working Committee (CWC) meeting on December 26 has been named 'Nav Satyagraha Baithak' which would see two resolutions being passed.

Ramesh said the Congress is marking the current week as the 'Ambedkar Samman Saptah' against the "insult" of B R Ambedkar by home minister Shah. He said there is only one solution to the issue which

is that the home minister be sacked and must apologise for his remarks.



Ramesh said that on December 27, a 'Jai Bapu, Jai Bhim, Jai Samvidhan' rally will be held in Belagavi. The Congress general secretary alleged that Prime Minister Narendra Modi and the BJP want to change the Constitution and are acting contrary to its spirit.

"When Prime Minister Modi became an MP and entered Parliament, he prostrated on the steps. The result is that the old Parliament building was abandoned and new building was inaugurated. On November 26 this year, the PM prostrated on the original copy of the Constitution, which means a new Constitution will be brought," Ramesh claimed. (CONTD. ON PAGE-2)

HT Correspondent JORHAT, Dec 24: A total of 348 unemployed youths from five districts of Assam were recruited by private companies at a job fair held at the Jorhat Engineering College (JEC) auditorium on Monday.

The mela, under the Deen Dayal Upadhyay Gramin Kaushal Yoiana, was organised by the Assam State Rural Livelihood Mission.

The districts covered were Jorhat, Golaghat, Sivasagar, Majuli, and Charideo.

NEW DELHI, Dec 24: India played a crucial role in helping Bhutan comply with the Montreal Protocol and has the potential to lead South Asia by sharing its knowledge and technology with other countries to combat climate change, former UNEP India head Atul Bagai said on Tuesday.

Bagai received the National Order of Merit from Bhutan's King Jigme Khesar Namgyel Wangchuck on December 17 for his instrumental contributions to the Himalayan country's environmental governance, particularly its successful compliance with the Montreal Protocol.

CHENNAI, Dec 24: The NIA has chargesheeted two men for allegedly conspiring to establish an Islamic caliphate in India, besides spreading terror in Tamil Nadu and neighbouring states, it said in a statement.

According to the National Investigation Agency (NIA) investigation, the accused were actively involved in recruiting "Daris/students" to "secret classes" of the Hizb ut Tahrir (HuT) terror organisation.

In its chargesheet filed before the special NIA court, Poonamallee, Chennai, Abdul Rehman alias Abdul Rahman and Mujibur Rehman alias Mujibur Rahman Altham Sahib have been charged under sections of the Indian Penal Code and the Unlawful Activities (Prevention) Act for conspiring and preparing to undertake terrorist acts to promote the HuT ideology in Tamil Nadu and other places.

"They had also conducted Bayan (religious exposition) classes and had made several short films to further the organisation's anti-India ideology on social media platforms. They had further organised an exhibition to showcase the military might of Islamic nations that would be invited (Nussrah) to overthrow the legally established government in India through violent jihad and war," according to the NIA statement. The NIA investigations revealed that the accused had conspired with self-styled HuT officebearers (CONTD. ON PAGE-2)

Sensex, Nifty settle almost flat in highly volatile trade; metal, power stocks drag

MUMBAI, Dec 24: Benchmark equity indices Sensex and Nifty ended on a flat note in a volatile trade on Tuesday, as investors preferred to stay on the sidelines awaiting further triggers amid persistent foreign fund outflows.

After gyrating between highs and lows, the 30-share index declined 67.30 points or 0.09 per cent to settle at 78,472.87. During the day, it dropped 142.38 points or 0.18 per cent to 78,397.79.

The NSE Nifty dipped 25.80 points or 0.11 per cent to 23,727.65.

As many as 2,019 stocks declined, while 1,977 advanced and 96 remained unchanged on the BSE.

"The domestic market concluded flat ahead of the holiday, with metal and power stocks dragging performance while FMCG and auto sectors gained from recent corrections.

"The near-term market trajectory hinges on the outcome of Q3 results and the Union budget, but caution prevails due to a strong dollar, high bond yields, and concerns over rate cuts. The rupee hitting an all-time low further evoked the caution," Vinod Nair, Head of Research, Geojit Financial Services, said.

From the 30 blue-chip stocks, Power Grid, State Bank of India, Titan, Tata Steel, IndusInd Bank, UltraTech Cement, Adani Ports and Infosys were among the laggards.

In contrast, Tata Motors, ITC, Nestle, Tata Consultancy Services, NTPC and Zomato were among the gainers.



The BSE smallcap gauge climbed 0.37 per cent, and the BSE midcap index rose 0.09 per cent

"The Nifty index saw a lacklustre start to the much-anticipated 'Santa Claus Rally Period,' with the index closing at 23,728, down 26 points. The sluggish session was attributed to persistent selling by FIIs, concerns over India's slowing economic growth, and a weakening Indian rupee, which hit a record low of Rs. 85.13 against the dollar.

"These factors weighed on investor sentiment, keeping the market directionless and choppy throughout the day. Our earlier call suggested a low-volume trading session, and that prediction held true as Nifty traded in a volatile range," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd. said.

Among sectoral indices, metal slumped 0.93 per cent, power declined 0.73 per cent, utilities

(0.52 per cent), consumer durables (0.50 per)cent) and commodities (0.33 per cent). BSE Consumer Discretionary, energy, health-

care, telecommunication, auto, oil & gas and services were the gainers. Foreign Institutional Investors (FIIs) offloaded equities worth ₹ 168.71 crore on Mon-

day, according to exchange data. In Asian markets, Shanghai and Hong Kong settled higher, while Seoul and Tokyo ended in negative territory.

European markets were trading with gains in mid-session deals. Wall Street ended in the positive zone overnight trade on Monday.

The rupee extended the slide for the second straight session and depreciated 9 paise to settle at a fresh all-time low of 85.20 (provisional) against the US dollar on Tuesday.

Global oil benchmark Brent crude climbed 0.62 per cent to USD 73.08 a barrel.

"Investors are now turning their attention to the Reserve Bank of India's upcoming monetary policy and the Union Budget for 2025, anticipating measures that could support economic growth and market stability," Ameya Ranadive Chartered Market Technician, CFTe, Sr Technical Analyst, StoxBox, said.

The BSE benchmark jumped 498.58 points or 0.64 per cent to settle at 78,540.17 on Monday. The Nifty surged 165.95 points or 0.70 per cent to 23,753.45

the major factor contributing to the decline in the growth rate of the economy is fixed capital formation and from the production side, the main concern is manufacturing. "Undermining both is inflation. The erosion of purchasing power due to repeated inflation shocks and persisting price pressures is starkly reflected in weakening sales growth of listed non-financial nongovernment corporations," it said.

Their outlook on demand conditions also remains subdued as no let-up in the incidence of price shocks seems to be in sight; they will increasingly be inclined to pass on input costs to selling prices.

Consequently, there is no robust capacity creation by investing in fixed assets. Instead, corporations are churning and utilising existing capacity to meet the inflation-dented consumer demand, the article said. "The result is lacklustre private investment. The slowdown in consumer demand seems to be associated with slower corporate wage growth," it said. The authors further said another headwind emerging is the slowing rate of nominal GDP growth, which could hinder fiscal spending, including on capex, to achieve budgetary deficit and debt targets.

The article also noted that as per the projections based on the in-house Dynamic Stochastic General Equilibrium (DSGE), real GDP growth is likely to recover to 6.8 per cent and 6.5 per cent in Q3 and Q4 of 2024-25, respectively. Growth for 2025-26 is projected at 6.7 per cent while headline CPI inflation (retail) is projected to average 3.8 per cent in 2025-26. In the December monetary policy, the RBI had projected the GDP growth for 2024-25 at 6.6 per cent with Q3 at 6.8 per cent; and Q4 at 7.2 per cent. GDP growth for the April quarter of 2025-26 was projected at 6.9 per cent; and Q2 at 7.3 per cent. The RBI said the views expressed in the bulletin are of the authors and do not represent the views of the central bank. (PTI)

Recently, the Asian Development Bank (ADB) lowered India's economic growth forecast to 6.5 per cent for the current financial year from its earlier estimate of 7 per cent due to lower-than-expected growth in private investment and housing demand.

The multilateral development bank has also lowered India's growth forecast for the 2025-26 financial year. Earlier this month, the Reserve Bank of India also significantly lowered the growth projection for the current fiscal year to 6.6 per cent from 7.2 per cent earlier. Next year's Budget will also be watched for any pre-emptive measures the government might take in response to a possible hike in US tariffs after US President-elect Donald Trump last week said India charges a lot of tariff and threatened to impose reciprocal tax. According to HDFC Securities' Senior Analyst of Commodities NEW DELHI, Dec 24: The National Financial Reporting Authority (NFRA) has imposed a fine of ₹ 2 crore on Deloitte Haskins & Sells LLP as well as penalties on two chartered accountants for lapses in auditing of Zee Entertainment Enterprises Ltd during 2018-19 and

2019-20 financial years. Along with slapping a fine of ₹ 10 lakh, A B Jani has been barred from taking up any audit work for 5 years while the fine is ₹ 5 lakh on Rakesh Sharma and the debarment period is 3 years.

Jani was the Engagement Partner (EP) and Sharma was the Engagement Quality Control Review (EQCR) Partner for the audit of the company for 2018-19 and 2019-20. The regulator had suo motu examined the audit file for the statutory audit of Zee Entertainment Enterprises Ltd (ZEEL) for the given periods to assess whether the auditor committed any professional misconduct.

After examining the audit file and responses of the audit firm to its queries as well as other records, NFRA said prima facie the auditors had not discharged their professional duties under the Companies Act as well as the Standards on Auditing (SA). In its 30-page order dated De-

Indian Oil Corp to invest ₹ 61,000 crore for naphtha cracker project in Odisha

BHUBANESWAR, Dec 24: State-owned Indian Oil Corporation Ltd (IOCL) will invest ₹ 61,000 crore to set up a naphtha cracker project at Paradip in Odisha, a statement said on Tuesday.

A Memorandum of Understanding (MoU) for this will be signed between the Odisha government and the IOCL in January during the 'Utkarsh Odisha - Make in Odisha 2025' summit, it said. The foundation stone of the IOC's upcoming ₹ 4,352 crore yarn project at Bhadrak will also be laid at that time, it added.

The decisions were taken at a meeting between

Chief Minister Mohan Charan Majhi and IOCL Chairman AS Sahney in Bhubaneswar.

"The Naphtha Project in Paradeep has received in principle approval and IOCL will invest over ₹ 61,000 crore for the project. It is likely to be one of the largest projects in the sector in the country. The State Government is an equity holder of this project, and will earn dividends in addition to taxes," said the statement issued by the Chief Minister's Office.

"It was also decided that, the foundation for the upcoming Yarn project of IOCL at Bhadrak

will also be laid in January. ₹4,352 crore will be invested for this project. It was informed that once the project is completed, various large scale garments manufacturing units will come up in the area. "My task was to help the Bhutanese government understand the implications of ratifying the protocol and the benefits it would bring. Bhutan ratified it in 2004, and that marked the start of my close collaboration with the country," Bagai recalls.

The Montreal Protocol, adopted in 1987 and often hailed as the most successful international environmental agreement, aims to phase out ozone-depleting substances (ODS). For nearly 12 years, Bagai worked alongside Bhutanese officials to craft and implement a comprehensive strategy for compliance. "Advocacy was a major focus. Bhutan's Queen was designated as the country's ozone ambassador, and she played a key role in spreading awareness," he said. One of Bhutan's most significant achievements under Bagai's guidance was its early commitment to phase out hydrochlorofluorocarbons (HCFCs) in the air conditioning sector by 2025. This was well ahead of the 2040 deadline set for developing countries.

This bold move became a global example and inspired other nations to consider accelerated timelines for phasing out ODS, Bagai noted. As the UNEP India head from 2017 to 2024, Bagai strengthened the bilateral relationship between India and Bhutan on environmental collaboration by developing and leading a Memorandum of Understanding (MoU) between the two countries. This MoU serves as the cornerstone of their environmental partnership, with India providing technical and financial support to Bhutan on various environmental issues, including waste management. Using Hindutva for personal gains

SS Sarsanghchalak Mohan Bhagwat is desperate to fix the soup he has landed in. His advice to Hindu society to refrain from raking up temple-mosque is part of this course-correction exercise. While suggesting to neo-Hindutva crusaders to refrain from raking up such issues, Bhagwat also cautioned that nobody can become a "leader of Hindus" by continuing to "raise temple-mosque disputes." In the 11 years of the Modi rule, Hindutva propagators have mushroomed everywhere and in his eagerness to emerge as the supreme leader of the Hindutva, Bhagwat allowed them to grow. He patronised "sants and swamis" whose job is to propagate the Hindutva philosophy of RSS and Bhagwat. They have one thing in common: both crave power, for which they use the political philosophy of Hindutva. These people have been using Hindutva and propagating ultra Hindutva line for their personal gains. Chief Minister Yogi Adityanath has never been associated with the RSS. Yogi has his own Hindu Yuva Vahini.

Demand for excavation of masjids for tracing Hindu temples has been acute in UP. Yogi contradicting Bhagwat was seen in the BJP circles as his attempt to emerge as the worthy successor of "Hindu Hriday Samrat" Modi. But a quick learner, Yogi preferred to fall in line and stand by Bhagwat. RSS had planned to use Maha Kumbh in Prayagraj to project Yogi as a Modi-like brand, a Hindutva icon. Having come to realise that his protest to Bhagwat may jeopardise his future, Yogi endorsed Bhagwat's line that the protection of Sanatan Dharma is essential for world peace. Bhagwat was forced to come out with this statement to counter the pro-Modi leaders and elements in the saffron ecosystem and to frustrate the attempt to hijack RSS's agenda. After the 2019 Lok Sabha win, Modi has been assiduously trying to project himself as the supreme leader of the saffron ecosystem. It was only recently, just ahead of the 2024 Lok Sabha elections, could Bhagwat and other RSS leaders showed Modi his right place.

It is only now that Modi has become proactive and not loosen his grip on the party. A large number of saffron leaders are advocating Modi's line. The Akhil Bharatiya Sant Samiti (AKSS), which is close to Modi, has criticised Bhagwat's remarks, saying that these are matters for religious leaders to decide and not for the RSS. The war of supremacy between Bhagwat and Modi has been raging and has now turned aggressive and sharper with the date for the election of a BJP president of BJP comes closer. Bhagwat has also come to realise that the RSS and BJP have been losing their support base. The various Hindu groups are sharpening their attacks on Muslims. Nearly two months back Bhagwat had advised the saffron rank and file to maintain restraint. The latest developments have fallen flat. Bhagwat sees them as open defiance and this is unacceptable to the RSS leadership. The dissent between the RSS and the BJP will be playing a pivotal role in the fast evolving "Hindutva" philosophy which can be seen branching from its very foundation. A crystalline propagation of a synchronised philosophy can work for the progress of the people of the nation.

Digital dreams are turning into dangerous realities for women

enjoy posting pictures and sharing content on Instagram, but I always do it cau-Ltiously. My private account feels like a safer space since I carefully choose who can see my posts, but even then, I am careful. I do have a public account where I post under a pen name, yet I'm always consciously aware of what I share.

There's always a lingering fear what if my pictures are stolen or misused? What if my thoughts are criticized or twisted into something I never intended? I want to post freely, without overthinking every detail, but I can't. Even in the "safe" digital space I've tried to create, there's no real guarantee of safety. Sadly, this isn't just my experience; it's a reality faced by countless women worldwide.

The internet has become a significant part of our lives, offering a platform for self-expression, learning, and connection. But for women, especially Gen Z, it's also a space filled with challenges. Online harassment, stalking, cyberbullying, and identity theft are alarmingly common. According to a study by the National Commission for Women, 54.8% of women have experienced cyber harassment, while 26% of them have reported cases of morphed images or videos. Moreover, cybercrime has also had a significant economic impact on women, with many losing jobs or experiencing financial losses due to online fraud. Women who step into public-facing careers or advocacy roles often face even more scrutiny. A striking example of this is Miss Universe 2021, Harnaaz Sandhu, who faced relentless online trolling for her weight gain after winning the title. Despite her achievements and the positive messages she shared about self-love and body positivity, she was subjected to widespread criticism and bodyshaming on social media.

Harnaaz courageously addressed the issue, explaining that her weight gain was due to a medical condition, but the abuse she endured highlights the intense scrutiny women in public-facing roles face. The impact of online harassment is not just emotional but has real-world consequences, with some women experiencing anxiety, depression, or a loss of confidence as a result of cyberattacks on their

reputations. The fear of being judged or targeted often shapes how women interact online. Many of us hear things like, "Why are you posting your pictures online? Isn't that asking for trouble?" or "Stay away from social media if vou don't want issues." Such remarks not only shift the blame onto women but also silence them. It forces us to think twice before sharing anything, making even simple acts like posting a photo or expressing an opinion feel risky.

Privacy, which should be a given, is a constant battle. A woman shared how a harmless picture she posted with friends on her private account was stolen, edited, and used inappropriately by someone she knew. The incident left her shaken, while her parents blamed her for posting the picture. Despite filing a complaint, she felt like justice was out of reach. Stories like these aren't rare. According to the National Crime Records Bureau (NCRB), one in four people who experience cybercrime in India are women.

In 2019, cybercrime incidents increased by 18.4% overall, and cybercrime against women increased by 28% including influencers and journalists, shared their experiences. They spoke about the constant threats and relentless trolling they face for simply expressing their thoughts. They explained that, as long as you conform to societal narratives, you might endure online spaces a little longer, but even then, there's no guarantee of feeling digitally safe. The speakers also revealed that this fear extends beyond them to their families, as online abusers often target loved ones, making the digital world even more riskier.

For Muslim women, this anxiety takes on an even more intense form. Online platforms become spaces where our faith, identity, and beliefs are often questioned or ridiculed. Muslim women who wear hijabs or follow other Islamic practices are frequently targeted because of their visible religious identity. For instance, an article I wrote for Youth Ki Awaaz about my experience of exclusion while wearing a hijab received a comment claiming that Muslim women deserve discrimination and accusing hijabis of promoting "love jihad."

While I wasn't personally offended by the



comment, it was a small glimpse into the misinterpreted hate that often escalates into brutal messages and threats that women receive online. Incidents like the "Sulli Deals" and "Bulli Bai" tech tools, where Muslim women's pictures were auctioned without consent, were not just shocking but terrifying. The violation of privacy and dignity was blatant, yet many victims felt abandoned by the system. One victim shared how she was repeatedly told to "ignore it" or to "delete her account," as though the solution lay in erasing her digital existence.

The rise of AI and deepfake technology has worsened the situation. India has recorded 37% of cases related to the harassment of women due to morphed images, also known as deepfakes. Explicit deepfake videos of Indian actresses have circulated online, despite being fabricated. The emotional and professional damage caused by such videos can be devastating

Similarly, Rana Ayyub, an Indian journalist who spoke out against the government's response to the rape of an eight-year-old girl. was targeted with a deepfake video as part of a coordinated hate campaign. AI tools, once celebrated for their innovation, are now being

weaponized, making women increasingly vulnerable to new forms of abuse.

This growing threat has prompted many women to seek ways to protect themselves. A lot of Gen Z women are now more cautious about what they share online, fully aware of the dangers of digital footprints. While privacy settings and security features are readily available, many women still feel like they don't have full control over their online identities. In response, women like me turn to pseudonyms, use private profiles, and share content only within small, trusted circles. However, even these precautions don't always work.


The numbers speak volumes. A survey by Amnesty International found that 38% of Indian women have faced online abuse for expressing opinions on politics, gender, or human rights. This silencing effect discourages women from participating in important conversations, effectively erasing their voices. Cultural expectations add another layer of difficulty for women, both in the real world and in digital spaces. Women are often told to behave a certain way, even online. For example, a young woman faced backlash from her relatives after posting pictures from a solo trip, with comments like, "Girls shouldn't attract attention," as though her photos were an invitation for criticism. This mindset makes online platforms feel less like spaces of freedom and more like areas that require constant monitoring.

Furthermore, the intersectionality of gender, race, and religion deepens the issue. Women of color, LGBTQ+ individuals, and those from marginalized communities are disproportionately targeted by online abuse. For them, the internet often becomes a hostile environment where their identities are exploited to fuel hateful agendas, amplifying their vulnerability and silencing their voices.

As we look toward the future, ensuring digital safety for women requires urgent action. Governments, tech companies, and online platforms must take greater responsibility in addressing these threats. Policy changes, stronger laws against online harassment, and tools to combat deepfakes are essential for creating safer digital spaces. Education on digital literacy and online safety must also be prioritized so that women are better equipped to protect themselves. The online world has become an integral part of our lives, but finding the balance between expression and safety remains a challenge for women. As more young women take to social media to share their stories and raise their voices, it's vital to remember that their security should never be compromised. When women with privileges whether they are celebrities or public figures can be so easily harassed and exploited through such technology, it raises an even more daunting question: What will happen to ordinary citizens who lack the visibility or resources to protect themselves?

While influential women may have the means to take legal action or publicize their struggles, many women, especially those in vulnerable or marginalized communities, are left powerless in the face of such digital abuse. By raising awareness, advocating for better policies, and empowering women with the right tools, we can work toward a digital space where women can truly thrive without fear. A fight for women's rights

en's rights refer to legal and social rights that specifically address issues faced by men. In India, while women's empowerment is important to focus on, challenges faced by men are often overlooked, such as false allegations in domestic violence cases under Section 498A IPC, lack of mental health support, and limited parental rights. Recent debates around shared parenting laws highlight the need for a balanced approach to gender justice. Men's rights in India often receive less attention in broader discussions on gender equality. Men do not receive legal recognition as victims of domestic abuse, making it challenging to seek protection or report cases of abuse. Men who are victims of emotional. financial, or physical abuse by a spouse face social stigma and do not receive legal recourse under existing frameworks such as the Protection of Women from Domestic Violence Act, 2005. Societal expectations for men to suppress emotions lead to neglect of their mental health, leading to increased suicide rates and untreated psychological problems. NCRB data for 2022 shows that 72.5% of suicide cases are by men, emphasizing the need for gender-sensitive mental health policies. Divorce or separation laws favor maternal custody, marginalizing the role of fathers and denying them equal rights in child rearing. The Guardians and Wards Act, 1890, prefers maternal custody unless the mother is deemed unfit, thereby limiting fathers' opportunities for parental involvement. Gender-specific laws such as Section 498A (dowry harassment) are sometimes misused, causing reputafinancial, tional. and emotional harm to innocent men. In Rajesh Sharma v. State of UP (2017), the Supreme Court noted the misuse of Section 498A and introduced safeguards against false accusations Men lack dedicated institutions or helplines to redress grievances. Social stereotypes portray men as perpetrators, influencing institutional attitudes and limiting appropriate remedies in cases such as workplace abuse or sexual harassment. The Vishaka Guide-

adhu Charan, a daughter of Rajasthan, is fighting against discrimination against women at the government level. For several decades, unmarried women in Rajasthan were being denied the right to become workers and assistants in Anganwadi centers. The Women and Child Development Department had made it mandatory for women applying for these posts to be married. Unmarried women could not even apply for it. Madhu fought a long legal battle in the Rajasthan High Court against this discrimination and won, but the government department is still imposing conditions.

When applications were sought for the appointment of Anganwadi worker in Gugdi village of Balotra district in the year 2019, Madhu also applied but she was denied work saying that she is not yet married. On this, Madhu knocked the door of the High Court. After a legal battle that lasted for about five years, the Rajasthan High Court gave a verdict in favor of Madhu on 4 September 2023. In this decision, the High Court declared the condition of women being married as illegal and unconstitutional, calling it illogical and a violation of the rights of unmarried female candidates. However, the government argued in the High Court that if an unmarried girl is appointed in the Anganwadi center, then after marriage she will go somewhere else, which will disrupt the work of the Anganwadi center, but the court did not accept this argument. The High Court made a strong comment in the decision and said that "The Rajasthan government has started a new chapter of discrimination between unmarried women and married women. Which is illegal and arbitrary. Considering a candidate ineligible for public employment just because she is unmarried is illogical. This is discriminatory and comes under the category of violating the fundamental rights given by the Constitution."

The Women and Child Development Department wanted to appeal against the court's decision because the government advocate had advised to appeal. The department would have appealed but before that the matter came to the notice of the state's Deputy Chief Minister Diya Kumari. The Deputy Chief Minister gave instructions to employ unmarried women by complying with the order of the High Court. On this, the government on 28 February 2024 approved the amendment in the rules and selection conditions for unmarried women to become Anganwadi workers and assistants in the state. On this, the selection conditions were amended by the department, making all women eligible to apply for the posts of Anganwadi workers and assistants. But the unfortunate situation is that despite this victory, the struggle of Madhu and thousands of women like her has not stopped yet.

In fact, the Women and Child Development Department has accepted unmarried women as eligible under the court's decision but has imposed a new condition. The department is asking women to sign an affidavit, in which it is written that if in future the woman will not be a resident of the concerned village due to marriage or any other reason, then she will automatically resign from the honorarium service and her honorarium service will be considered over. Now the department is ready to appoint Madhu as Anganwadi worker in compliance with the court's decision but she is being asked to submit an affidavit as mentioned above. Madhu is not willing to give this affidavit. Madhu says that the Women and Child Department does not seem to intend to comply with the decision of the Rajasthan High Court. Therefore, I do not accept this affidavit and signing it. The attitude of the department is anti-women. I will continue to fight against it.

Madhu has questioned the state government and the Women and Child Department about this new condition. Madhu has said in a letter sent to the department that when such a condition is not imposed while giving work on honorarium or contract to men in any government department, then why is it being imposed on women?

This question is not of Madhu alone, but of thousands of women of the state who have been deprived of jobs for many years just because they are not married. The format of the affidavit is like imposing a new condition in a way.

There is a huge number of single women in the country including Rajasthan, who are living a lonely life due to social neglect and social cultural reasons. Many women are forced to live an unmarried life due to reasons like not getting married due to some circumstances, not being able to get married due to illness or disability etc. If we look at the census data, the number of single women in India has increased by 30 percent between the years 2001 and 2011. There are seven crore women in India who are either not married or are living as divorced or widows. This number is 12 percent of the population of our country.

According to the report of a survey conducted by the National Forum for Single Women Rights (NFSWR) in seven states including Rajasthan, the condition of single women is worse in the states of North India as compared to the South. According to this report, single women in rural areas have to constantly grapple with social prejudices and struggle for survival. Single women are not only victims of physical and financial insecurity, but they also often have to face open discrimination. This is a class of single women who are victims of circumstances. It is unfortunate that in our society the identity of women has been linked to men. Single, unmarried women are not seen in a positive light. Often their character is maligned. The kind of negative environment that exists in society towards single women is not seen towards single men. On one hand, governments claim to run welfare schemes for single women, while on the other hand, they are being denied jobs due to being unmarried. Madhu's struggle is against such discrimination and injustice, which should be appreciated. (The author is a Laadli Media Fellow and an independent journalist)

laws Amend existing laws such as the Domestic Violence Act and Section 498A of the IPC to make them gender-neutral. ensuring equal protection for men against domestic violence and false allegations. In countries such as Canada and the UK. domestic violence laws are gender-neutral. This promotes the best interests of the child while addressing parental grievances. The concept of shared parenting is well established in Australia, which mandates equal consideration for both parents in custody decisions. Establish dedicated policies focusing on men's mental health by integrating mental health services into workplace wellness programs and creating awareness campaigns. Japan has introduced workplace mental health programs targeting stress reduction, which can be adapted to include gender-specific concerns.

Addressing false allegations: Put in place stringent mechanisms to prevent and punish false allegations in cases of domestic violence. dowry harassment, and sexual harassment to prevent misuse of laws. Institutional measures to ensure a balanced approach lines cover workplace towards gender justice are the harassment only for women, establishment of men's wel-

fare commissions. Create statutory bodies at national and state levels similar to women's commissions to address specific issues related to men, including legal aid and counselling. The United Kingdom has a "Men and Boys Coalition" that advocates for issues such as mental health and paternal rights. Set up gender-neutral helplines and shelters to ensure access to immediate help and support for male victims of domestic violence or abuse. The MEN Against Violence and Abuse (Men Against Violence and Abuse) initiative in India provides support to male victims of abuse. Train judiciary and law enforcement officials on gender-neutral approaches and challenges faced by men to ensure fair treatment in cases related to domestic violence, custody, and abuse.

Regular sensitization workshops for the police in Kerala have resulted in a more balanced handling of genderbased complaints. Force organizations to adopt inclusive workplace policies that address issues such as paternity leave, sexual harassment faced by men, and mental health support. Sweden's parental leave policy provides equal leave to fathers, promoting shared parenting and gender equality at home. Men's rights need to be addressed with equal sincerity to ensure a balanced approach to gender justice. Gender-neutral laws, increased mental health support, and awareness campaigns to eliminate social stereotypes are important steps. As Martin Luther King Jr. said, "Injustice anywhere is a threat to justice everywhere." A truly inclusive system uplifts all genders, promoting fairness and harmony in society.

LAHORE, Dec 24: "Even though the chance was missed, we should try again," says Punjab Assembly Speaker Malik Ahmad Khan when asked about Atal Bihari Vajpayee's 1999 'bus yatra', a bold attempt by the then Indian prime minister to put India-Pakistan relations on the peace track

Vajpayee took a bus ride to Lahore on February 19, 1999. He and Pakistan premier Nawaz Sharif signed the Lahore Declaration after a historic summit here. The agreement signalled a breakthrough, but just months later a Pakistani intrusion led to the Kargil War.

Wednesday is Vajpayee's 100th birth anniversary.

'Vajpayee's visit to Lahore in 1999 was a defining moment. Even though the chance was missed, we should try again. With Prime Minister Narendra Modi, who follows Vajpayee's vision, leading India, and Shehbaz Sharif, Nawaz's brother, in charge in Pakistan, there is a real possibility of restarting the peace process," says Khan, who is a senior member of the Pakistan Muslim League-Nawaz (PML-N).

Khan says the future of the region depends on free trade and unrestricted movement between countries

"Peace in the region is not just a good idea – it is necessary for growth and prosperity," the Punjab Speaker adds

Another senior PML-N leader from Punjab, Mohammad Mehdi, describes Vajpayee's Lahore visit as historic. He believes the visit could have led to lasting peace if the Kargil conflict had not happened.

"The Western media paid a lot of attention to Vajpayee's visit because it came just months after both countries became nuclear powers," Mehdi says, referring to nuclear tests conducted by India and Pakistan in May 1998.

"There was excitement, espe-

cially within PML-N ranks, when Vajpayee arrived in Lahore in February 1999. His speech, saying 'Pakistan is a reality, and both countries now need to move forward and leave the past behind,' gave hope to many," Mehdi recalls

Unfortunately, the Kargil conflict happened soon after, and the peace efforts were unsuccessful, he says. Mehdi says Jamaat-e-Islami (JI) held protests during Vajpayee's visit, which many believe were organised by the military led by General Pervez Musharraf.

"Jamaat-i-Islami workers even attacked the Turkish ambassador's car near Lahore Fort, mistaking it for an Indian delegation," he says.

Mehdi believes back-channel talks between Pakistan and India are still happening. "Right now, relations between

the two countries are at their lowest point. Neither country has an envoy in the other's capital. However, businessmen on both sides desperately want to restore ties to improve trade and use shorter routes through Pakistan to reach Central Asia and Europe," he says.

Political expert Brig (retd.) Farooq Hameed says Nawaz Sharif should have involved the powerful Pakistan Army in the peace process. "The initiative failed because the

WASHINGTON, Dec 24: President Joe Biden on Monday signed into law a defence bill that authorises significant pay raises for unior enlisted service members, aims to counter China's growing power and boosts overall military spending to USD 895 billion despite his objections to language stripping coverage of transgender medical treatments for children in military families.

Biden said his administration strongly opposes the provision because it targets a group based on gender identity and "interferes with parents' roles to determine the best care for their children." He said it also undermines the all-volunteer military's abilty to recruit and retain talent.

"No service member should have to decide between their family's health care access and their call to serve our nation," the president said in a statement.

The Senate forwarded the bill to Biden after passing it last week by a vote of 85-14. In the House, a majority of Democrats voted against the bill after House Speaker Mike Johnson insisted on adding the provision to ban transgender medical care for children. The legislation easily passed by a vote of 281-140. Biden also objected to other language in the bill prohibiting the use of money earmarked to transfer detainees held at Guantanamo Bay, Cuba, to some foreign countries and into the United States. He urged Congress to lift those restrictions.

UNITED NATIONS, Dec 24: The U.N. organization assisting in investigating the most serious crimes in Syria said Monday the country's new authorities were "very receptive" to its request for cooperation during a just-concluded visit to Damascus, and it is preparing to deploy

The visit led by Robert Petit, head of the International, Impartial and Independent Mechanism for Syria, was the first since the organization was established by the U.N. General Assembly in 2016. It was created to assist in evidence-gathering and prosecution of individuals responsible for possible war crimes, crimes against humanity and genocide since Syria's civil war began in 2011.

Petit highlighted the urgency of preserving documents and other evidence before it is lost.

Since the rebel overthrow of Syria's President Bashar Assad and the rebel opening of prisons and deention facilities there have been rising demands from "The fall of the Assad rule is a significant opportu-

nity for us to fulfill our mandate on the ground," Petit said. "Time is running out. There is a small window of opportunity to secure these sites and the material they hold." U.N. associate spokesperson Stephane Tremblay said Monday the investigative team "is preparing for an operational deployment as early as possible and as soon as it is authorized to conduct activities on Syrian soil."

The spokesperson for the organization, known as the IIIM, who was on the trip with Petit, went further, telling The Associated Press: "We are preparing to de-

ploy on the expectation that we will get authorization." The representatives from the caretaker authorities were very receptive to our request for cooperation and are aware of the scale of the task ahead." the spokesperson said, speaking on condition of not being named.

SARAJEVO (BOSNIA-HERZE-GOVINA), Dec 24: Tens of thousands of homes in Bosnia were without electricity on Tuesday after more heavy snow and winds that also brought traffic chaos in neighbouring Croatia and Serbia.

In Slovenia, the resumption of a search for an injured Hungarian hiker missing in the Alps north of the capital Ljubljana since Sunday was temporarily suspended because of strong winds. Rescuers on Monday reached his female companion and transferred her to safety, but they were unable to locate the man and couldn't use a helicopter because of strong winds. Throughout the

Balkans authorities issued travel warnings as snow drifts closed some major routes, including sections of motorways in Croatia.

Bosnia, Serbia and Croatia banned the movement of heavy vehicles and imposed limited traffic levels on affected roads.

Parts of Bosnia faced a total halt of railway traffic because of the snow. Bosnia's state power company described the situation as "extremely hard" in some areas of the country. The weight of heavy, moist snow brought down distribution lines which are hard to access due to snow drifts, the company said in a statement. (AP)

and arson charges in New York City for allegedly setting a woman on fire inside a subway train and then watching her die after she was engulfed in flames, police said Monday.

The suspect, identified by police as Sebastian Zapeta, was taken into custody hours after the woman died on Sunday morning.

Zapeta, 33, is a Guatemalan citizen who entered the US illegally after he had been previously removed in 2018, said Jeff Carter, a spokesman for US Immigration and Customs Enforcement, Surveillance video showed the suspect approach the woman, who was sitting motionless and may have been sleeping, on a stationary F train at the Coney Island-Stillwell Avenue subway station in Brooklyn and set her clothing on fire, police said.

The woman's clothing "became fully engulfed in a matter of seconds," said Jessica Tisch, the New York City police commissioner, while the suspect remained at the scene, watching her burn from a bench on the subway platform as police and a transit worker extinguished the flames.

The woman was pronounced dead at the scene. Police have not yet released her identity. Tisch called the incident "one of the most de-

praved crimes one person could possibly commit against another human being.' Police arrested Zapeta later Sunday, riding

the same subway line, after getting a tip from a group of high school students who recognised images of the suspect that were circulated by police. It is unclear when and where Zapeta reentered the US after being removed about six vears ago.

In a statement, Brooklyn District Attorney Eric Gonzalez said, "The depravity of this horrific crime is beyond comprehension, and my

office is committed to bringing the perpetrator to justice." "This gruesome and senseless act of violence against a vulnerable woman will be met with the most serious consequences," he said. It was unclear if Zapeta has an attorney or when he would be arraigned.

A Brooklyn address for Zapeta released by police matches a service centre for Samaritan Daytop Village, which provides housing and substance abuse support. The organisation did not immediately respond to a request for comment.

New York Gov. Kathy Hochul this year has sent New York National Guard members to the city's subway system to help police conduct random searches of riders' bags for weapons following a series of high-profile crimes on city trains. Hochul recently deployed additional members to help patrol during the holiday season. (AP)

Hong Kong police issue arrest Sudan's war 'deepening, widening' a famine crisis: Report warrants, bounties for six activists

CAIRO, Dec 24: Famine is spreading in Sudan due to a war between the military and a notorious paramilitary group that has wrecked the country and created the world's largest displacement crisis, a global hunger-monitoring group said on Tuesday.

The Integrated Food Security Phase Classification, or IPC, said it detected famine in five areas, including in Sudan's largest displacement camp, Zamzam, in North Darfur province, where famine was found for the first time in August.

"This marks an unprecedented deepening and widening of the food and nutrition crisis. driven by the devastating conflict and poor humanitarian access," an IPC report said.

As well as in the Zamzam camp, which hosts more than 400,000 people, famine was also detected in two other camps for displaced people, Abu Shouk and al-Salam in North Darfur, and the Western Nuba Mountains, IPC's report said.

Five other areas in North Darfur are projected "with reasonable evidence" to experience famine in the



next six months, including el-Fasher, the provincial capital of North Darfur, it said. Seventeen areas in the Nuba Mountains and the northern and southern areas of Darfur are at risk of famine, it added.

The report said some areas in Khartoum and the east-central province of Gezira "may be experiencing" famine-like conditions. It said experts were unable to confirm whether famine threshold has been surpassed due to lack of data.

Ahead of the IPC's report, Sudan's government said it had suspended its participation in the global system, according to a senior United Nations official with knowledge of the move.

In a letter dated December 23. Agriculture Minister Abu Baker al-Beshri accused the IPC of "issuing unreliable reports that undermine Sudan's sovereignty and dignity", said the UN official, who spoke in condition of anonymity.

Many outspoken prodemocracy activists have since been jailed, with others fleeing abroad

"The Hong Kong government's latest round of arrest warrants and bounties against six Hong Kong activists is a cowardly act of intimidation that aims to silence Hong Kong people," said Maya Wang, associate China director at Human Rights Watch.

"The six — including two Canadian citizens — live in the UK and Canada. We call on the UK and Canadian governments to act immediately to push back against the Hong Kong government's attempts to threaten Hong Kongers living in their countries.

Tuesday's arrest warrants take the total number of wanted people to 19. (AP)

According to the warrants, the six are wanted for national security offences such as secession, subversion and collusion with foreign forces. No question of violating constitutional provisions as alleged by Cong: Manipur minister 'In normal times, govt always summoned House thrice'



IMPHAL, Dec 24: Manipur law minister Th Basanta Kumar Singh on Tuesday rejected Congress's allegation that the state government had violated constitutional rules by not holding the winter session of the Assembly.

Talking to reporters, Kumar said Article 174 of the Constitution states that Houses of the legislature of the state shall be summoned to meet at least twice every year, and six months shall not intervene between the last sitting and the date appointed for the next session. The Budget and the Autumn sessions were held earlier this

"Manipur Congress's allegation that rules of the Constitution have been violated is false. During the chief ministership of O Ibobi Singh from 2002 to 2016, there have been five occasions when assembly sessions were held twice in a calendar year. There is no question of vio-

lating constitutional provisions by the BJP-led government in the state," he said.

Kumar's remark came in the wake of recent allegations by CLP leader O Ibobi Singh that the BJP-led government violated constitutional provisions by not holding the winter session of the assembly.

"The state government has always made efforts to implement the mandatory provisions of the Constitution and rules framed by the Manipur Legislative Assembly. It is pertinent to mention that in normal times, the government had always summoned the House three times, from 2017 to 2020," he added

"Following the Covid outbreak pandemic in 2021 and the unfortunate incident of May 3, 2023, the state government could not fulfil the conditions provided in the rules due to unavoidable circumstances and hardship faced by people during this period," the minister added

Meanwhile, in the wake of the pen-down strike by employees of the Board of Secondary Education Manipur (BOSEM) following the appointment of Akham Joykumar Singh as its chairman, Kumar said he was appointed in accordance with the rules and regulations.

"There were five applicants for the post and after examination of the eligibility criteria, Joykumar was appointed as chairman," he added The minister appealed to call off the strike in

Three arrested for killing sambar deer in Arunachal

ITANAGAR, Dec 24: Three poachers were held for killing a sambar deer re- bruch district on December 20. cently inside the Daying Ering Memorial Wildlife Sanctuary (DEMWS) in Arunachal Pradesh's East Siang district, an official said.

Acting on a tip-off, a team led by Borguli range forest officer CK Chowpoo arrested the poachers, the Divisional Forest Officer of DEMWS, Kenpi Ete, said. The poachers, identified as Mibom Perme and Doping Taying, were from

The third poacher, identified as Toni Perme, was arrested on Tuesday, she said. Ete said the poachers entered the sanctuary using a machine boat and shot the animal using a single-barrel gun in an isolated pocket under Borguli Wildlife Range

She said the accused were booked under various sections of the Wildlife (Protection) Act 1972 and section 25

1(B) of the Arms Act 1959. The seized articles were handed over

to the police, and an FIR has been registered at Mebo police station, she said. Sambar deer is a Schedule I species under the Wildlife (Protection) Act, of 1972. The DFO said stringent action as per the provisions of the Wildlife Act will be taken against any person involved in hunting or abetment of hunting inside the sanctuary.

She also expressed dismay that de-

spite continuous efforts by the depart ment officials to gain the confidence of the fringe villagers for their support in protecting the sanctuary, such hunting incidents by a few put the conservation efforts in vain. Directing the field officers to intensify surveillance in and around the sanctuary to prevent such incidents in future, Ete appealed to the general public to report hunting incidents to sanctuary officials for prompt action. People struggling with rising prices, govt sleeping like 'Kumbhkaran': Rahul

EW DELHI, Dec 24: Leader of Opposition in the Lok Sabha Rahul Gandhi on Tuesday said that the people are struggling with rising prices and are forced to compromise on small things of daily needs while the government is sleeping like 'Kumbhakaran'.

Gandhi shared a video on his social media handles on his recent visit to a vegetable market in Giri Nagar here and interaction with housewives who narrated their ordeal due to rising prices of food items

"A few days ago, I went to a local vegetable market and while shopping with customers, I talked to the vendors to know how the budget of the common people is deteriorating and how inflation has troubled everyone," Gandhi said in his post accompanying the video.

"People are struggling with rising prices and are forced to compromise on small things of daily needs," the former Congress chief said in his post in Hindi.

'We discussed the prices of garlic, peas, mushrooms and other vegetables, and heard the real experiences of the people. How garlic at ₹ 400 per kg and peas at ₹ 120 per kg have shaken everyone's budget," he said.

What will people eat and what will they save, he wondered.

"While talking over tea, we closely understood the problems of the lives of

housewives - how the income remained stagnant, inflation kept increasing uncontrollably. How saving has become impossible and how it has become difficult to arrange even a rickshaw fare of ₹ 10 due to just meeting the food expenses," Gandhi said

He urged people to share their experiences with him if they are also feeling the effect of inflation.

"Tell us how you are struggling with this problem - you know the condition of the market, you too share your personal experiences with us," he said.

În a post on X, Gandhi said, "Garlic was once ₹ 40, today it is ₹ 400! Rising inflation has spoiled the budget of the common person's kitchen - the government is sleeping like Kumbhakaran!"

In the over five-minute video, Gandhi is seen accompanying some housewives as they buy vegetables and haggle with vendors

The housewives tell Gandhi that they

have to curtail their eating habits as they are unable to afford the vegetables they used to earlier.

They also tell him that while wages have remained stagnant, prices have risen sharply

The Congress on Monday took a swipe at the Modi government over "rising" prices of food items, saying the bullet train announced by it has not arrived but the inflation, which is spiralling upwards faster than the speed of a bullet train, has broken the back of the common person.

Congress general secretary in-charge communications Jairam Ramesh had said the people want answers not more "jumlabaazi (rhetoric)".

Vajpayee's legacy lives on as country marks his birth centenary

NEW DELHI, Dec 24: Delivering one of his more famous speeches at the BJP's inaugural convention at Shivaji Park in Mumbai, Atal Bihari Vajpayee predicted on December 30, 1980 with his signature flourish: 'Andhera chhatega, suraj niklega, kamal khilega' (darkness will end, the sun will rise, lotus will bloom).

As his birth centenary arrives, his words have aged well, with the BJP returning to power for a third straight term at the centre and lotus in full bloom.

If Prime Minister Narendra Modi made the BJP's cultural agenda the centre of national politics, Vajpayee helped the party occupy this centre when its cultural agenda was considered an anathema.

A statesman politician and a peerless orator, India's first non-Congress prime minister to have served a full term commanded respect and affection from across the political aisle and stood tall with his innate democratic spirit, honed through decades in opposition, in a politics crowded with powerful satraps.

The three-time prime minister was the original builder of coalition politics at the national level, successfully running an alliance government for a full term while navigating some of the biggest national crises, including the plane hijack in 1999 and the terror attack on Parliament in 2001, both with direct links to Pakistan.

His government's measured handling of the two incidents drew criticism from some quarters, including right wing organisations considered ideologically affiliated to the BJP but less than friendly to him for not pushing their cultural and economic agenda, but his standing ensured that he faced no political threat or popular backlash.

And even as he was still smarting from the fall of his government by one vote in the Lok Sabha in April 1999, his firm military and deft diplomatic response to Pakistan's intrusion into Kargil as the head of a caretaker government earned him plaudits and powered the BJP-led National Democratic Alliance to a more stable majority, ensuring him a full term at the



helm

Ashok Tandon, media adviser to Vajpayee during his six-year stint as PM, said besides being an outstanding parliamentarian who did his bit in "strengthening the roots of parliamentary democracy' after entering the Lok Sabha for the first time in 1957, he brought "good governance" at the centre of agenda as the head of government.

"Good governance was his landmark contribution. He headed a diverse coalition of parties and kept them together, while pursuing policies which helped the country in every field," he told PTI, citing the launch of Sarva Shiksha Abhiyan, PM Gramin Sadak Yojna and the Golden Quadrilateral highway project under his stewardship.

It was his boost to reforms, disinvestment and infra projects that made the idea of seven to eight per cent growth rate possible and his government legislated fiscal prudence through the FRBM Act in 2003.

However, the fruits of reforms came a little too late and this coupled with the BJP's political missteps, especially in the crucial state of Uttar Pradesh, and the Congress-led UPA's harnessing of rural distress delivered a shock defeat to Vajpayee in 2004 amid a decline in his health

His public appearances were limited, he campaigned last for his party in the 2007 assembly polls in Uttar Pradesh before slowly fading away from the public eye as dementia hit him. He died in 2018. The Modi government began observing

his birth anniversary as "Good Governance Day" and bestowed Bharat Ratna on him in 2015.

An impressive mix of tradition and modernity in his world view, Vajpayee, a full-time RSS worker before being sent by the Hindutva organisation to the Jana Sangh in 1951 when the party was founded, maintained a lifelong adherence to the Sangh's values even though he at times resented its methods.

Unlike his lifelong companion L K Advani, who despite being an ideological hardliner and more invested organisational leader fell from the RSS's grace due to his public airing of views, including his ill-fated praise of M A Jinnah, that were bound to antagonise the Hindutva organisation, Vajpayee used his cultivated ambivalence and gifted articulation to shape his image of a moderate while never crossing swords with it.

The only time he openly denounced a polarising Hindutva cause was when the Babri mosque was demolished in 1992, but his stand was considered an act of political pragmatism necessary for the BJP to realise its political ambitions after fetching merely two seats in the 1984 polls.

With the moderate, poet-at-heart and statesman-like Vajpayee as the BJP's prime ministerial face and the party agreeing to put a moratorium on its contentious ideological planks of the Rem temple construction, Article 370 repeal and the Uniform Civil Code, regional parties from across the country were drawn as he led them to poll wins.

His passionate moves to improve ties with Pakistan resulted in his spectacular journey to Lahore in a bus in February 1999 and then hosting the Agra Summit with Pakistan's president Pervez Musharraf in 2001 but they met with little suc-

As the army chief before he deposed prime minister Nawaz Sharif, Musharraf was behind his country's misadventure in Kargil, which followed months after Vajpayee's bus journey. (PTI)


HYDERABAD, Dec 24: Top Telugu actor Allu Arjun was on Tuesday grilled by police for over three hours when he appeared before them for questioning in connection with the death of a woman in a stampede during the screening of 'Pushpa-2' here on December 4.

Arjun reached the Chikkadpally police station accompanied by his father Allu Aravind and lawyers a little after 11 AM and the questioning was held till 2.45 PM. A police team led by Central Zone DCPAkshansh Yadav questioned the actor. "He cooperated with the Police

fully. If required, they said they'll call him again. They (the police) wanted to question him and he cooperated. They treated him very well," Arjun's advocate Ashok Reddy told PTI.

MUMBAI, Dec 24: His lens empathetic, rooted to Indian reality and always political, Shyam Benegal was the arthouse pioneer who rewrote the rules of cinema with films such as "Ankur". "Nishant" and "Bhumika" that blazed an alternate path to mainstream movies.

The pioneer of parallel cinema, one of India's greatest directors whose work found an audience in the most discerning of global film circles, died in a Mumbai hospital on Monday evening. It was just nine days after he celebrated his 90th birthday.

Benegal, who burst on the scene with his first film "Ankur" in 1974, was a chronicler of India's times and politics, that rare artiste who worked both in non-fiction and fiction across varied mediums -- films, documentaries, biopics and ambitious TV shows. The title of his debut film, translating to seedling, was perhaps prophetic. "Ankur", which delves into feudalism and exploitation of women in a small village in India, prepared the ground for a cinema without artifice in an era dominated by superman heroes and loud song and dance routines. It was the first of his more than 25 films that included "Mandi", "Manthan", "Junoon", "Kalyug" and "Zubeidaa". The remarkable oeuvre boasts the documentary on an-

other great, "Satyajit Ray, Filmmaker", and televisions shows, the ambitious "Bharat Ek Khoj", based on Jawaharlal Nehru's book "Discovery of India", and "Samvidhaan", a 10-part serial on the making of the Constitution.

Through his work, which was distinctly different and alternate to mainstream movies as audiences knew till then, Benegal made several stars out of great actors. There was Shabana Azmi, Smita Patil, Naseeruddin Shah and Girish Karnad of course. And then there were those stars such as Shashi Kapoor and Rekha who gave arguably their best performances in "Kalyug"

The filmmaking was both deeply personal and inherently political. Telling stories of class and caste struggles, feminist concerns, rural distress and community dynamics. The gaze was incisive, the themes serious and the treatment sometimes sombre and other times satirical.

If "Kalyug" is a modern day retelling of the Mahabharata, "Bhumika" is a searing profile of a woman filmstar and her often exploitative relationships, "Mandi" deals with a brothel and its occupants who deftly navigate the men in their lives and "Welcome to Sajjanpur" about an aspiring novelist turned letter writer is an outright satire.

Fondly called Shyam Babu by

friends and colleagues, Benegal was a pillar of meaningful cinema of the 1970s and 1980s alongside Sai Paranjpye, Govind Nihalani, Mani Kaul, Saeed Akhtar Mirza, and Kumar Shahani.


Benegal disliked the term "middle cinema" used to bracket his films and preferred that his work be called "new or alternate cinema"

"I don't remember who said this: 'Every social act of yours is also a political act whether you like it or not'," he told PTI in 2022.

"One has to be as objective as possible and the second point is to be sympathetic. If you are not objective, you are already colouring the story with your subjectivity. Sympathy is necessary. When I say sympathy, I mean empathy so you can be one with the subject," Benegal said.

His was the cinema of and by the erudite, attracting some of the most talented in the business.

The late playwright Vijay Tendulkar wrote the screenplay "Manthan", a film on the milk cooperative movement in Anand, Gujarat, made with Rs 2 funding from five lakh farmers, and "Nishant", set in a feudal family. The late music composer Vanraj

Benegal was understated about his achievements. "There are people who have done wonderful things. There's nothing unique in what one has done. You do what you think you want to do. That's not unique. Climbing Mount Everest is unique," he said. Interestingly, Mahatma Gandhi was the one personality Benegal explored in all his complexities and significance.

In "The Making of the Mahatma", Rajit Kapoor portrayed Gandhi during his South African years. Gandhi appeared in two episodes of "Bharat Ek Khoj" and was played by Neeraj Kabi in 10-part series "Šamvidhaan". In his biopic on Netaji, 2005's Netaji Subhas Chandra Bose: The Forgotten Hero", the role of Gandhi was enacted by Surendra Rajan. (PTI)

Shabana Azmi: 'Shyam Benegal was like a guru to me, he was progressive and well-informed'

MUMBAI, Dec 24: Shyam Benegal, the pioneer of parallel cinema, played a pivotal role in Shabana Azmi's career as the actor says he was a guru who influenced not only her approach towards acting but also her understanding of life.

Benegal, known for his socially relevant and thought-provoking films such as "Ankur" (1974), "Mandi" (1983), "Mammo" (1994) and "Zubeidaa" (2001), died in Mumbai on Monday evening, just nine days after his 90th birthday.

It was Benegal who gave Azmi her first acting role in his directorial debut "Ankur", which explored themes of caste, class, and sexual politics, with a focus on the struggles of rural women. Over the years, the duo collaborated on several projects, including "Nishant" (1975), "Junoon" (1978), "Susman" (1978) and "Antarnaad" (1992).

"Shyam Benegal has been my guru in everything, not just in acting but in the way I view the world. When I went abroad for Ankur with him to the Berlin Film Festival and, as a young kid with stars in my eyes, I wanted to run to the first shopping place. "But he asked all kinds of questions to the taxi driver; he wanted to know about the garden and the history," Azmi told PTI in a recent interview.

The 74-year-old actor described Benegal as a "progressive" and "wellinformed" filmmaker.

"He opened me up in different ways. When we went to the (Berlin) festival, he would say, 'Let's watch

It took Benegal's genius to see me beyond my looks: Manoj Bajpayee on 'Zubeidaa'

NEW DELHI, Dec 24 It took the genius of Shyam Benegal to see beyond his looks, says actor Manoj Bajpayee who never imagined himself playing a royal and did so in the 2001 film "Zubeidaa" after the filmmaker convinced him. Benegal, who pioneered the art house cinema movement in the country with films such as "Mandi" and "Ankur", died in Mumbai on Monday evening just nine day after his 90th birthday.

The actor met Benegal a couple of years after his breakout role as the mafia don Bhiku Mhatre in the 1998 crime classic "Satya" by Ram Gopal Varma.

"He sent me a message through Ram Gopal Varma. And Varma told me only one thing, 'Shyam Benegal wants to work with you. He wants to cast you in some role. I don't know what the film is all about but you are not going to say no to anything that he offers. That should be our regard and respect to that filmmaker, so you are going to say yes. You are not going to say no.

"And I was so grateful to Ram Gopal Varma that I decided that I will do whatever he gives me," Bajpayee told PTI in a recent interview. So the actor did say yes to Benegal's film but was taken aback when he found that the role was that of Prince Vijayendra Singh of Fatehpur opposite Karisma Kapoor. (PTI)

"We wanted clarity for our batting unit before the team meeting," Australia coach Andrew McDonald said ahead of the fourth Test with the series locked at

Dodemaide informing Konstas about his inclusion was a departure from protocol as traditionally, it's the Australian skipper who confirms the playing XI on match eve or on the morning of the match

medallist shooter Manu Bhaker's coach Jaspal Rana on Tuesday castigated the Sports Ministry, Sports Authority of India and the National Rifle Association of India, holding them responsible for "ignoring" his ward's credentials for the Dhyan Chand Khel Ratna award.

The champion shooter's omission has sparked a controversy even though ministry sources have asserted that the names are yet to be finalised and her name will be there when the final list is released in a week's time.

In August, Bhaker became independent India's first athlete to win two medals in a single edition of the Olympics with her bronze-winning show in the 10m air pistol individual and 10m air pistol mixed team events

"I will hold all of them responsible. How can anyone even say Manu did not apply? She made history by becoming the first Indian to win two Olympic medals in the same Olympics. Her name should have been there automatically. Don't the people at the helm know who Manu Bhaker is and what are her credentials? This humiliation might just affect her progress," Rana, who was the personal coach of Manu when she won the medals at the Paris Games, told PTI.

"I can say that a wrong precedent is being set. Things like this can destroy an athlete's confidence."

Reports of her omission from the national honours evoked shock with her family insisting that application was duly submitted.

"If this can shock the sports fraternity, if you are speaking to me regarding this, if people are writing about this, then how come the committee that decides the names fail to understand that she deserves the honour," Rana asked.

"What is their job otherwise. Isn't it to go through the performance of the athletes over the last cycle and then arrive at a conclusion and recommend the names. According to me this is not a mistake and this is not an oversight," Rana said.

"Anyway, it is not the first time. It has happened with me too. I have never received the Khel Ratna award," said the shooter who won three gold medals and equalled the world record in 25m centre fire pistol at the 2006 Asian Games in Doha.

"It's really appalling. Why should a top sportsperson apply or request for an award? Awards should come naturally and automatically. How can it be ignored? There has to be some system in place," Rana observed.

"Does every athlete know how to apply? Does it make sense that only an athlete can apply? Why not the federation, Sports Authority of India (or the) ministry," the coach asked.

A ministry source had earlier told PTI that Sports Minister Mansukh Mandaviya will decide on the recommendations of the 12-member award selection committee and, in all likelihood, Manu's name will be there in the final list.

"There is no final list of nominees at this point. Sports Minister Mansukh Mandaviya will decide on the recommendations in a day or two and her name, in all likelihood, will be there in the final list," the source said.

The legendary Rana returned as Bhaker's coach exactly one year before the Paris Olympics, and was by her side as she went on to create history in the French capital. ZURICH, Dec 24: The world soccer players' union disagreed with FIFA's temporary changes to transfer rules on Monday following the landmark Lassana Diarra judgement.

Former France international Diarra challenged FIFA 's rules due to a dispute with a club dating to 2014, and the European Court of Justice ruled in October that some rules were contrary to European Union law because they restricted freedom of movement and were anti-competitive.

FIFA then opened a "global dialogue" and on Monday published interim amendments which take effect in time for the January transfer window. They "strike a balanced compromise," FIFA said in a statement

But global players' union FIF-PRO was against the changes, and accused FIFA of failing to reach consensus.

"Following Lassana Diarra's successful challenge against the legality of Article 17 of the FIFA Regulations on the Status and Transfer of Players, FIFPRO informed FIFA of the conditions under which it could negotiate the amendments to the regulations to reflect the ruling," a union statement said.

"Until now, we have been unable to reach a consensus. We do not agree with the temporary measures announced by FIFA which have been introduced with-

out a proper collective bargaining process. "The measures do not provide legal certainty to professional footballers and do not reflect the judgement by the European Court of Justice.'

FIFA said there was "a clear understanding" between all parties that the interim measures have no impact on ongoing discussions over long-term amendments to the rules, and introduced interim changes to offer stability and certainty for the upcoming transfer window.

"FIFA looks forward to continuing its close cooperation with key stakeholders as part of the global dialogue launched in October with the objective of developing a robust, transparent, non-discriminatory, objective and proportionate regulatory framework that will apply uniformly to professional football at a global level," it said in a statement.

FIFA legal director Emilio Garcia Silvero posted on X on Monday saying the next goal was to have "a permanent framework that fully aligns with the ECJ's views & has the support of all parties before July 2025.

Diarra took his case to the ECJ after he sued FIFA for damages in the Belgian courts. Diarra cited FIFA rules for the collapse of a move to Belgian club Charleroi after the termination of his contract with Russian club Lokomotiv Moscow in 2014. (AP)

BENGALURU, Dec 24: The image of a smiling D Gukesh standing with outstretched hands will forever be embossed in the memory of a nation of billions. The moment, which came right

after his victory over Ding Liren of China in the World Chess Championship in Singapore, was a bold signature on India's rise as a true global chess super power in the post Viswanathan Anand era. Year 2024 was a story of resur-

gence in Indian chess, crafted by Anand himself.

The fearless and ambitious teenagers or "Vishy's children" as Garry Kasparov calls them, now have a role model to emulate -- an 18-year-old from Chennai, the voungest ever world champion in the long history of chess.

But the genesis of that success was during the FIDE Candidates tournament in April. He emerged as the youngest ever winner of that tournament, setting up a title clash with 32-

year-old defending champion

Liren. The Gukesh moment

Gukesh was viewed as the favourite going into the title matches, consisting of 14 rounds. That tag itself might have been a pressure point. But with wins in Games 3, 11 and 14, the Indian managed to seal an epochal feat. Gukesh showed immense presence of mind to carry an entire nation's hope on his tender



shoulders.

But a crumb of credit should also go to a highly-efficient and varied support staff that included the Anand, the pioneer of chess revolution in India. and renowned mental conditioning coach Paddy Upton

Chess Olympiad triumph

Before Gukesh, India showed its envious inventory of chess champions to the world in all its splendour at Budapest in September. The country walked away with six gold medals in team and individual categories.

In the men's team category final, India defeated Slovenia while their women counterparts subdued Azerbaijan to join China and erst-

while USSR as the only three nations to bag the men's and

In the individual section, Gukesh (Board 1), Arjun Erigaisi (Board 3), Divya Deshmukh

(Board 3) and Vantika Agarwal (Board 4) walked away with gold medals.

Siblings impress

The Rameshbabu household in Chennai have two Grandmasters -R Praggnanandhaa and Vaishali, who had crossed the 2500 ELO ratings last year. This year, they became the first siblings to play the Candidates, adding another feather to an already burgeoning cap. They are also the first siblings to achieve the GM norm. Pragg fells Carlsen

How about having arguably the world's best player in knots? Magnus Carlsen is not an unfamiliar rival to Praggnanandhaa, whom he had beaten earlier in Rapid and Blitz formats.

But beating the world No. 1 in the Classical version is a different challenge altogether. Praggnanandhaa achieved this feat during the Norway Chess, Carlsen's home tournament, in May

Milestone for Erigaisi, Divya This is more technical but significant, nonetheless. Erigaisi became the second Indian, after Anand, of course, to cross the 2800 Elo rating points.

The Indian beat Russia's Dmitry Andreikin in the fifth round of the European Chess Club Cup 2024 to achieve this rare feat. He was also the 15th GM in the history of chess

to go past this mark. Currently, Erigaisi is world No.4 with 2801 points behind Carlsen (2831), Fabiano Caruana (2805) and Hikaru Nakamura (2802). Divya managed to cross the

2500 Élo rating barrier this year to join an elite club of GMs.

Deep talent pool

Gukesh, Praggnanandhaa, Erigaisi, Vidit Gujrathi and P Harikrishna are the frontline men's players, while D Harika, Vaishali, Divya, Vantika and Tanya Sachdev form a formidable women's line-

But the real strength of Indian chess is elsewhere.

"These are famous names because they have achieved several honours. But what makes India a strong chess nation is the fact that thousands of kids are now taking to chess. They have seen Gukesh or Praggnanandhaa climbing heights, and now they think: 'why can't we do this?'," says DP Anantha, Vice-President of All India Chess Federation.

"That increasing talent pool is our real strength. I don't think any other nation can match us now in that aspect. We will see many young names coming forward next year," he added.

Perhaps, it's apt to borrow a catch line from the 80s to describe India's chess present chess landscape -- 'Neighbours Envy, Owner's Pride.'

Big 2025 loading

India are currently ranked fourth in the FIDE team rankings. The nation has 64 Grand Masters, logging an average Elo rating of 2668 and a good number of them are less than 25.

Many of them will be seen in action in tournaments such as Freestyle Chess Grand Slam Tour, FIDE Women's GP, FIDE Women's World Cup in Georgia and Asian Championships in the UAE etc.

So, keep those seat-belts fastened, more excitement is on the way! (PTI)

fruitful for Rohit as he has managed 10, 3 and 6 runs in the last three innings, while Rahul has encashed on the opportunity by notching up a fine 84 in the first innings at Brisbane in the third Test. The skipper said, he would do

whatever is best for the team. "Let's not worry about who bats where. Something that we need to figure and not something I would be discussing here. We will do what is best for the team," Rohit On Kohli's form, and his sup-

"With regards to ongoing issue for my nomination for the most prestigious Khel Ratna award -- I would like to state that as an athlete my role is to play and perform for my country.

"I believe there has been a lapse, maybe on my part while filing for the nomination which is being corrected," Bhaker wrote on X.

Bhaker said her aim is to perform for the country whether she gets an award or not.

"Awards and recognition keeps me motivated but are not my goal," she asserted.

"Irrespective of the award I shall remain motivated to win more medals for my country. It is a request to everyone, please do not speculate on this," she said.

This was after her personal Jaspal Rana and father Ramkishan Bhaker lambasted the sports ministry and the selection committee for overlooking her despite

her monumental achievements. The youngster is the first athlete from independent India to win two medals in a single edition of the



Olympics.

She won her bronze medals in the 10m air pistol individual and 10m air pistol mixed team (with Sarabjot Singh) events in Paris. (PTI)

Meeting held to finalise date for MAC Cup 2025 in D

HT Bureau DIPHU, Dec 24: In a bid to finalise the date and venue for the Member of Autonomous Council (MAC) Cup for 2025, a meeting was held under the chairmanship of Tuliram Ronghang, Chief Executive Member (CEM) of the Karbi Anglong Autonomous Council (KAAC), at the conference hall of the Arboretum-cum-Craft Centre in Diphu's Matipung area on Monday

Explaining the game format and fixture, Rajeshan Terang, secretary of the KAAC Sports & Youth Welfare Department, and Ruplongki Bey, liaison officer of KAAC, presented how the game will be played through a league system in group stages.

"Each MAC constituency will have one team, and the MAC Level Organising Committee will conduct the games in their respective MAC constituencies. One of the rules is that no MAC team can hire or bring players from outside. All players must be from within the respective MAC constituency," Terang informed. Terang also mentioned that there will be 3 groups for West Karbi Anglong and 5 groups in Karbi Anglong district, adding, "Each MAC team will play two matches, one at home and the other away at a different location. The group matches will

end on February 3, after which the tournament will proceed to the knockout stages, beginning with the round of 16." He further explained that the two teams from each group with the highest points will compete in the round of 16, followed by the quarter-finals, semi-finals, and ultimately the final.

"There will be a third-place match between the two losing teams from the semi-final encounters," he added. He also informed that there will be a total of 76 matches from the group stages to the final.

The inaugural match, scheduled for January 11, will be played between Khorkhanti and Mahamaya at the Samelangso stadium. The final will take place in February during the Karbi Youth Festival at the Karbi Anglong Sports Association (KASA) stadium, he said.

In addition to the game overview provided by secretary Terang, CEM Ronghang said, "We are introducing FIFA rules this season so that our players can learn how to play according to international standards. From this season onward, the MAC Cup will follow a new roadmap for football in the district." The CEM urged all MACs and EMs present at the meeting to begin preparing their teams for the upcoming four-week football carnival
