New thinking needed for India's economy: Rahul



NEW DELHI, Dec 1: Congress leader Rahul Gandhi expressed concern on Sunday over India's GDP growth rate declining to its lowest in two years and said the country's economy cannot progress as long as a handful of billionaires accrue its benefits.

He said a new thinking is required for India's economy and a new deal for businesses should be an important part of it.

"When everyone gets an equal opportunity to move forward, only move forward," he said in a post in Hindi on X.

The leader of opposition in the Lok Sabha said India's Gross Domestic Product (GDP) growth rate has fallen to 5.4 per cent, its lowest in two years.

"The thing is clear -- the Indian economy cannot progress as long as a handful of billionaires are accruing its benefits and the farmers, labourers, middle class and the poor are struggling with various economic problems," he asserted.

Sharing some facts, Gandhi said it is a worrying situation as retail inflation has risen to a 14-month high of 6.21 per cent.

The price of potatoes and onions has increased by almost 50 per cent this year compared to October last year, he noted. Gandhi said the rupee has reached its lowest level of Rs 84.5 and the unemployment rate has broken a 45-year record. "In the last five years, the income of labourers, employees and small businessmen has either stagnated or reduced (CONTD. ON PAGE-2)

NGT takes suo motu cognisance of newspaper report on forest encroachment in Kamrup

Green Tribunal notice to principal chief conservator

Green Tribunal has sought a response from the principal chief conservator of forest, Assam, in a matter regarding alleged encroachment of forest land in the Kamrup metropolitan district of

The NGT has taken suo motu cognisance of a newspaper report claiming that a substantial portion of the 16 reserved forests covering more than 35,329 hectares in the Kamrup metropolitan district had been encroached.

The illegal encroachments in the district included ecologically important hills like Fatasil, South Kalapahar, Jalukbari, Gotanagar, Hengrabari, Sarania, and Garbhanga, the report al-

In an order dated November 19, a bench of NGT chairperson Justice Prakash Shrivastava and expert member A Senthil Vel said noting the re-

port, "Due to the encroachment of the forests, the man-animal conflict is increasing in several parts of the state, which has become a major cause of concern. Forest encroachments have also increased air temperature and this year, Assam faced the hottest September month ever." It said as per the report, in the last few years, over 113 eviction drives had been launched, clearing 402.32 hectares in 2022-23 and 564.58 hectares in 2023-24.

"Furthermore, it is asserted that in some forests, people are staying for years and it may be difficult to evict them. Forests along the inter-state boundaries are also under encroachment by the neighbouring states and those can be cleared only after the boundary disputes are completely settled," the tribunal noted.

It said that the report raised "substantial issues" regarding compliance



with environmental norms and also "indicated violation of the Forest Conservation Act, and the Environment Protection Act".

The tribunal impleaded as parties or respondents the state's principal chief conservator of forest and the district

"Issue notice to the above respondents for filing their response/reply by way of affidavit before the eastern zonal bench of the tribunal (in Kolkata)," the tribunal said.

The matter has been posted for further proceedings on January 21. (PTI)

Manipur situation will impact **Assam: Himanta**

GUWAHATI, Dec 1: Chief Minister Himanta Biswa Sarma said on Sunday that the situation in neighbouring Manipur will have an impact on the state.

Additional police forces have been deployed in Barak Valley which shares a border with violence-hit Manipur to ensure no spill-over effects.

Talking to reporters on the sidelines of a programme in Cachar district, Sarma said, "I think the situation in Manipur will definitely have some impact on Assam. That is why we have deployed additional police forces in Barak Valley to see that nothing spills over to Assam." The Barak Valley of Cachar district shares a border with Jiribam of Manipur.

The ethnically diverse Jiribam, which was largely untouched by the clashes in Imphal Valley and the adjoining hills, witnessed violence after the mutilated body of a farmer was found in a field in June this year.

More than 250 people have been killed and thousands rendered homeless in ethnic violence between Imphal Vallevbased Meiteis and adjoining hills-based Kuki-Zo groups since May last year.

The violence escalated in Manipur after three women and three children belonging to the Meitei community had gone missing from a relief camp in Jiribam district, following a gunfight between security forces and suspected Kuki-Zo militants that resulted in the deaths of 10 insurgents on November 11. Bodies of those six were later found. (PTI)

Injecting Drug Use has emerged as the main route of HIV transmission in the state during 2024-25 so far, followed by hetero-sexual route, the statement said on the occasion of World AIDS Day on Sunday.

Chief Minister Himanta Biswa Sarma affirmed a collective effort to strive for a future with no AIDS and extend support to those living with the infection.

"On World AIDS Day, we reiterate our collective responsibility to support those living with HIV, fight stigma and strive for a future without AIDS. Let's educate, support & fight for a world where AIDS is no more and provide the best care to



those affected," he posted on X. A statement by the Assam State AIDS Control Society (ASACS) said the state has an adult HIV prevalence rate of 0.13 per cent, which is lower than the all-India prevalence rate of 0.20 per cent, as

per India's HIV Estimation Report 2023.

Although the HIV prevalence rate is low, new HIV infections in the

India, France looking at strong economic ties: French foreign trade minister

ing close partnership in the defence domain, India and France are now looking at significantly deepening economic and trade ties especially in sectors like clean energy, new technologies and aviation, French foreign trade minister Sophie Primas has said.

At the end of her three-day visit to India. Primas said France is looking forward to further negotiations between New Delhi and the European Union for finalisation of a "mutually beneficial" free trade deal that could expand two-way economic engagement.

India and the EU restarted negotiations for the ambitious trade deal in June 2022 after a gap of over eight years but the talks have dragged on for a variety of reasons, including the 27-nation bloc's position on carbon tax.

"I would also like to add that, at the European Union level, we remain committed to reaching a trade deal between the EU and India, which is mutually beneficial and has ambitious sustainable development goals. We are looking forward to further talks with India at the EU level," Primas told PTI.

On India-France trade relations, the French minister said the focus now is on expansion of the economic engagement as both sides have already built a robust partner-

ship in the strategic domain. The French foreign trade minister visited India from November 27 to 29 during which she held talks with Commerce Minister Piyush Goyal on a range of issues, including ways to encourage more investment flows between the two countries.

"India is a fast-emerging economy with vast opportunities for

Italy can be India's landing base for **Europe: Minister Urso**

MUMBAI, Dec 1: Italian minister Adolfo Urso has said his country can be the "landing base" for India to access the European market.

In a similar way, India can act as the landing base for Italy, the European country's minister for business and 'Made in Italy' told PTI here on Saturday.

Speaking on the sidelines of 93year-old Italian ship Amerigo Vespucci's call on Mumbai port and the Villaggio Italia exposition arranged to coincide with that, Urso also said "new geopolitical events" make it necessary to consolidate the lines of communication between the two countries.

"India can be for Europe the landing base in Asia in the great south-eastern Asian basin, and Italy can be for India the landing base in Europe, for the most significant and richest world market," he said in an interview to PTI.

This line of communication passes through the Arabian peninsula which has a very important place in the economic realm, he

While this is a preferred line of commercial communication between the two continents of Asia and Europe, the same route can also double up as a significantly important line of connectivity in terms of data and information,

Urso said. "It is certainly the preferred main line of commercial communication between our continents, but it can also be the line of connectivity as regards the transport of data and therefore of information, on one side above the seas, maritime trade: on the other side under the seas, the connection lines that transport information and data," he

The trade relations between the two sides are on an upswing in the last few years but both sides are of the view that there is huge potential to enhance the engagement.

On boosting bilateral trade, Primas indicated having certain issues but did not elaborate on them.

The project is also seen as an initiative by like-minded nations to gain strategic influence in the face of China's Belt and Road Initiative (BRI) that has faced increasing criticism over lack of transparency and disregard for sovereignty of the nations. The BRI is a mega connectivity project that connects China with Southeast Asia, Central

Wedding season, rural traction, SUVs drive domestic PV sales of top automakers in Nov

NEW DELHI, Dec 1: Leading automakers Maruti Suzuki India, Tata Motors and Toyota Kirloskar Motor on Sunday reported growth in their domestic passenger vehicle sales riding on ongoing wedding season demand, continued rural traction and strong offtake of

On the other hand, newly-listed Hyundai Motor India Ltd (HMIL) registered a 2 per cent year-on-year decline in domestic sales to 48,246 units last month as against 49,451 units in the year-ago period.

Market leader Maruti Suzuki India posted domestic passenger vehicle (PV) wholesales of 1,41,312 units in November as compared with 1,34,158 units in the year-ago month, a growth of 5 per cent.

"Our November sales were driven by a variety of factors, including the ongoing wedding season demand, continued traction in the rural market, introduction of limited editions and the ongoing robust uptake for SUVs," Maruti Suzuki India senior executive officer, marketing and sales, Partho Banerjee told PTI.

The company's rural penetration increased to 48.7 per cent in November this year, which is 2.2 per cent higher than the same month last year, he added.

On the urban market, Banerjee said, "We are not seeing that sort of traction that we saw in October. Generally what happens is that the urban customers wait for December and hold back a little in November expecting better offers (in the year-end).

In November, he said, "We could maximise contribution of SUVs (in our portfolio) which has now gone up to 29 per cent.

MSIL's utility vehicles, consisting of Brezza, Ertiga, Grand Vitara and XL6, clocked sales of 59,003 units last month as compared to 49,016 units earlier. However, sales of mini-segment cars, comprising Alto and S-Presso, were down at 9,750 units as against 9,959 units in November 2023. Sales of compact cars, including Baleno, Celerio, Dzire, Ignis, Swift, Tour S and WagonR, declined to 61,373 units as compared to 64,679 units in the year-ago month.

Another major player, Tata Motors said its domestic PV sales, including EVs were up 2 per cent at 47,063 units as against 46,068 units in November 2023.

Similarly, Toyota Kirloskar Motor (TKM) said its total sales rose 44 per cent year-on-year to 25,586 units in November as compared to 17,818 units in the same month last year.



"Our diverse portfolio, spanning from hatchbacks to SUVs, continues to offer tailored mobility solutions that resonate with varying lifestyles," TKM vice president, Sales-Service-Used Car Business Sabari Manohar said in a statement.

On the other hand, Hyundai Motor India Ltd said its domestic sales declined 2 per cent year on year to 48,246 units in November as against 49,451 units in the year-ago period. Exports declined 20 per cent year on year to 13,006 units last month.

The company said it achieved its highest-ever monthly rural contribution of 22.1 per cent in November 2024, augmenting its reach in the hinterland of

The company's push towards fortifying SUV supremacy continued in November with SUVs contributing 68.8 per cent of total domestic sales, Hyundai Motor India Whole-time director and chief operating officer Tarun Garg said.

JSW MG Motor India reported a 20 per cent rise in wholesales at 6,019 units in November 2024 as compared to the same month last year.

The company's electric crossover utility vehicle Windsor continues with its strong performance for the second month in a row with 3,144 wholesale units, JSW MG Motor India said in a statement.

This is the second straight monthly increase in jet fuel prices. Rates were increased by ₹ 2,941.5 per kl (3.3 per cent) on November 1. That hike came after two rounds of reduction which had taken the rates to their lowest level this year. ATF price on October 1 was cut by 6.3 per cent (₹ 5,883 per kl) and by ₹ 4,495.5 per kl, or 4.58 per cent on September 1.

The ATF price in Mumbai was increased to ₹ 85,861.02 per kl on Sunday from ₹ 84,642.91 previously. Oil firms also increased the price of commercial LPG by ₹ 16.5 to ₹ 1818.50 per 19-kg cylinder.

Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL) revise prices of ATF and cooking gas on the first of every month based on the average price of benchmark international fuel and foreign exchange rate. Prices of petrol and diesel continue to remain frozen. Rates had been cut by ₹ 2 per litre in mid-March ahead of the general elections. Petrol costs ₹ 94.72 a litre in Delhi while diesel is priced at ₹87.62. (PTI)

Potato traders threaten strike from Tuesday if West Bengal doesn't allow selling to other states

KOLKATA, Dec 1: Potato traders of West Bengal threatened to go on strike on Tuesday if the state government does not lift re-

strictions on selling to other states. West Bengal recently re-imposed curbs on selling potatoes to neighbouring states in an effort to control the prices in the local markets. Potatoes are retailing at ₹ 35-

40 per kg in the local markets. Following the decision of the state government, police have intensified surveillance at inter-state borders to prevent the transportation of potatoes out of the state. This has led to several trucks being stranded at border crossings. "We will go on strike from Tuesday if strictions," Progressive Potato Traders' Association secretary Lalu Mukherjee told PTI. He criticised the government's decision, stating, "Such abrupt measures disrupt our business and cause huge losses as we fail to fulfil commitments." Traders and cold storage associations blamed the state government for failing to control prices in the local markets, attributing it to profiteering

by intermediaries. "Despite the wholesale price of potatoes in Kolkata being ₹ 27 per kg, how is it retailing at ₹ 35-40?" a trader questioned. Neighbouring states such as Odisha and Jharkhand rely heavily on West Bengal for their potato supply. After the restrictions were imposed, prices in these states have also gone up. Odisha's Food Supplies and Consumer Welfare Minister Krushna Chandra Patra on Saturday alleged that the Mamata Banerjee government was playing politics over the supply of potatoes.

West Bengal also depends on other states for fish and other items. If desired, Odisha can also stop the goods vehicles at its border. But, we are not going to do so," he said. "We have made arrangements for the supply of adequate potatoes to consumers in the state. Potatoes have started arriving in the state from Uttar Pradesh. Besides, the tuber can also be brought from Punjab," he

Legal fraternity must avoid misusing loopholes in cases against women, children: Himanta CM attends inauguration of Sub-divisional Judicial Magistrate (M) court building at Lakhipur

GUWAHATI, Dec 1: Chief minister Himanta Biswa Sarma and Chief Justice of Gauhati High Court Vijay Bishnoi inaugurated the court building of the Sub-divisional Judicial Magistrate (M) at Lakhipur in Cachar district on Sunday.

Speaking on the occasion, chief minister Sarma said that the inauguration of the court building will not only enhance the efficiency of the judiciary in Lakhipur and Cachar district but will also have a positive impact on fulfilling the aspirations of the people across Barak Valley. He also noted that with Lakhipur now recognised as a co-district, this new judicial building is expected to play a significant role in shaping the future of the judiciary in the region.

The chief minister remarked that before independence, the judicial administration of Cachar district, the heart of the Barak Valley, was under the Sylhet Sadar Court, with a circuit court operating in Silchar. However, after independence, the undivided Cachar district came under the jurisdiction of the Jorhat district and the Sadar Judge. To address the legal needs of the district and expand its judicial framework, a separate and independent post of District Judge for Cachar was created in 1955, CM Sarma added.

The chief minister further said that to strengthen the state's judicial system, the present state government has undertaken several significant initiatives. He mentioned that, as a result of these efforts, the judicial infrastructure in the state has seen remarkable progress in recent years. Highlighting these proactive steps, the chief minister said that the present state

government has built and inaugurated new District Judicial Court buildings in Barpeta and Sivasagar districts. Similarly, on November 23, the Sub-divisional Judicial Magistrate Court building in Bokakhat, under Golaghat district, was also inaugurated.

He added that these new court buildings, in addition to housing courtrooms and chambers for judges, are equipped with modern facilities such as libraries, video conferencing rooms, various office spaces, a Vulnerable Witness Deposition Centre, meditation rooms, and CCTV control rooms, among other advanced

Moreover, the construction of court complexes and residential quarters in Dhubri, Goalpara, Tinsukia, and Gohpur is progressing at a fast pace. The construction work of the court complexes in

complete. Soon, the court complex being built in Diphu, Karbi Anglong, will also be inaugurated. Additionally, district judicial systems have been established in the newly formed districts of South Salmara-Mankachar, Bajali, Biswanath, Majuli, and West Karbi Anglong.

Chief minister Sarma said that the present state government is taking all steps to turn Prime Minister Narendra Modi's vision of 'Ease of Justice' into reality. In order to bring the judiciary closer to the common people, the state government has taken several steps to make justice more accessible. He stated that to protect children from sexual abuse and ensure swift resolution of cases related to child marriage, POCSO (Protection of Children from Sexual Offences) courts have been established in 17 districts. He also said that two such courts have been

With the state's economic development, the number of commercial disputes has increased. Therefore, a plan has been made to establish a dedicated Commercial Court in Guwahati. Similarly, a specialised NDPS (Narcotic Drugs and Psychotropic Substances) court is also being planned. Efforts are underway to establish a Directorate of Prosecution in the state, which will function as the controlling authority for all administrative tasks related to prosecution.

CM Sarma also said that to reduce the number of pending cases in courts and decrease the number of prisoners, the state government has implemented measures to withdraw petty cases. Under this initiative, nearly 81,000 petty cases were withdrawn by March of this year. The chief minister further said that to ensure a safe environment for witnesses, safe deposition centers have been established, and several of these centers are already operational.

Highlighting various initiatives taken by the state government, CM Sarma said that E-service centers and the mobile app 'Borsha' have been launched to provide affordable legal information and emergency assistance to distressed women. He emphasised that the legal fraternity has a responsibility to not weaponise loopholes in delaying trials in cases involving crimes against women and children.

The chief minister also said that under the decisive leadership of Prime Minister Narendra Modi and Home minister Amit Shah, India has ushered in a revolutionary transformation in its legal framework by replacing the colonial-era Indian Penal Code (IPC), Code of Criminal Procedure

(CrPC), and Indian Evidence Act with the Bharatiya Nyaya Sanhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS), and Bharatiya Sakshya Adhiniyam (BSA). This new legal framework has facilitated a more efficient and technology-driven judicial process, making justice delivery smoother and reducing the burden of excessive cases on the judicial system.

CM Sarma added that the Bharatiya Sakshya Adhiniyam has now placed special emphasis on the use of scientific methods for the collection of evidence. As a result, in the coming days, the role of forensic experts in the investigation process will significantly increase. To aid this, the construction of the National Forensic Science University campus in Guwahati has already begun. CM Sarma said the university will provide advanced training opportunities to investigating officers, enhancing the scientific approach to criminal investigations. Additionally, special attention is being given to the training of police officers on the new criminal laws and the appropriate use of information technology in law enforcement and investigations.

It may be noted that the new judicial magistrate court building has been constructed at a financial outlay of ₹ 3.78 crores. This was followed by a public meeting at Nehrubali Playground, Nagaon, where Keshab Mahanta, minister for Transport, IT, etc., was the chief guest. Speaking on the occasion, the minister said, "Your health is your right, and sometimes we knowingly make mistakes by indulging in highrisk behaviours like unprotected sex and sharing needles and syringes while taking drugs as injecting drug users, which may lead to HIV." Thus, the minister appealed to the gathering, which comprised mainly college stu-



dents, to refrain from all kinds of high-risk behaviours and inculcate healthy lifestyles.

Speaking on the occasion, Dr P Ashok Babu, IAS, commissioner and secretary to the government of Assam, Health & Family Welfare Department, said, "There was a time when the main route of HIV transmission in the state was through unprotected sex, but now the main route of HIV transmission is through sharing needles and syringes by injecting drug users." 'Out of the total HIV-detected cases, more than 60 percent are injecting drug users, and that is why there are Opioid Substitution Therapy (OST) Centres in a few hospitals across Assam where injecting drug users are rehabilitated by offering legally pre-

scribed drugs orally," he said. Speaking on the significance of World AIDS Day, project director of Assam State AIDS Control Society,

Dr Indranoshee Das, ACS, in her speech, said that World AIDS Day gives an opportunity to people around the globe to unite in the fight against HIV and to commemorate those who have died due to AIDS-related illnesses. "In order to combat the HIV menace, Assam State AIDS Control Society, in the last couple of years, has taken up various kinds of campaigns like Integrated Health Campaigns in HIV-vulnerable districts, campaigns in prisons and detention centres, and Intensified IEC Campaigns in 10 HIV high-prevalence districts of Assam." The 10 districts that successfully

conducted the 60-day Intensified IEC Campaign during August-October

2024 were felicitated during the event. The public meeting was followed by cultural programmes, including mime shows, street plays, flash mobs, etc. A blood donation camp was also organised at the venue.

Apart from the state-level event, World AIDS Day was also observed in all districts of Assam with public meetings, rallies, etc. World AIDS Day was also conducted in colleges across the state

Defence against US charges on Adani group

The defence mounted by the Adani Group, both by its leadership and by the Indian government, in the face of damning allegations of corruption and irregularities levelled by US authorities, raises serious questions about the interplay between corporate interests and political power in India. While the US investigation exposes what it claims are grave financial offences, including corruption, both the Adani Group and the Indian government have presented a united front to defend the company, framing the charges as mere technicalities and distancing the leadership from any involvement in misconduct. The US allegations, which point to potentially fraudulent activities, stock price manipulation. The US investigators have delved deep into the Adani Group's dealings, alleging irregularities that could have far-reaching implications on both international trade and domestic investment confidence. At the heart of these accusations is the claim that the Adani Group has been involved in a series of financial practices designed to artificially inflate stock prices, manipulate market values, and conceal financial misdeeds through complex offshore networks. These are serious allegations that, if proven, could constitute significant breaches of financial regulations and international laws.

Despite the gravity of the situation, the response from the Adani Group and the Indian government has been resolute. The group, led by billionaire Gautam Adani, has maintained that the charges against it are groundless, presenting them as nothing more than misunderstandings or, at worst, technical errors in compliance. In a series of statements, the company has claimed that the allegations are exaggerated and misinterpreted, downplaying the seriousness of the claims. From the Indian government's perspective, the Adani Group's defence has been met with strong political support. External Affairs Ministry spokespersons have gone on record to claim that this is a purely legal matter involving private entities, and thus, the government should not be expected to intervene in the ongoing legal proceedings. This rhetoric, however, has done little to quell suspicions about the underlying motivations. By positioning the matter as an issue of legal technicalities rather than a serious case of financial misconduct, both the Adani Group and the Indian government appear to be strategically deflecting attention from the substantive nature of the allegations. The response has been remarkably uniform, with key political figures and even media outlets in India rallying around the Adani Group, presenting it as a victim of foreign interference rather than a company embroiled in a financial scandal.

The broader implications of this defence are significant, as it raises questions about the extent to which corporate influence intersects with governmental action in India. The Adani Group, with its vast business interests spanning energy, infrastructure, and logistics, is one of India's most influential corporate entities. Its rise has been closely intertwined with India's own economic development under the leadership of Prime Minister Narendra Modi. The Adani Group's meteoric growth over the last decade is often seen as symbolic of the country's booming economy and its aspirations to become a global economic powerhouse. As such, the defence of the group is not merely a corporate issue—it has been made to look like a matter

BJP's resurgence and Congress's struggles across India

The recent Assembly and bye-election results across India have once again reaffirmed the central role of electoral performance in shaping political narratives. While elections are undoubtedly about numbers, they serve as a barometer for public sentiment, political strategies, and the relevance of leadership. From the BJP's remarkable resurgence in Maharashtra to its clean sweep in Assam's bye-elections, these outcomes hold critical lessons for political stakeholders

Maharashtra: BJP's Strategic Resur**gence:** Maharashtra, historically a complex political battlefield, witnessed a transformative election with the BJP securing a decisive victory. This success is particularly notable given the state's shifting alliances and power dynamics since the 2019 Assembly elections. The Shiv Sena's factional struggles and the NCP's lack of cohesive strategy paved the way for the BJP to reclaim its foothold in the state. This outcome underscores the importance of internal unity and disciplined strategy in contemporary politics. By presenting a united front, the BJP demonstrated its ability to adapt, restructure narratives, and mobilize voters effectively.

Moreover, the results exposed the Congress's inability to regain lost ground. The party's dismal performance in regions like Vidarbha highlighted its declining grassroots connect and lack of a coherent strategy to counter the BJP's dominance. While the Congress celebrates minor gains in states like chand its structural and organization weaknesses make a nationwide revival seem increasingly unlikely.

Jharkhand: A Fragile Success for Congress: The Jharkhand Assembly elections offered a glimmer of hope for the Congress, but the victory owed more to its alliance with the Jharkhand Mukti Morcha (JMM) than its own efforts. While the coalition managed to secure a majority, the Congress's contribution was marginal compared to the dominant role played by the JMM. This raises questions about the Congress's ability to position itself as a credible political force, even in alliance-led victories. The BJP's relatively weak presence in

Jharkhand politics has been a historical trend, vet its performance was not far behind that of the Congress. The possibility of a future alliance between the BJP and the JMM, while speculative, cannot be ruled out given the fluid nature of Indian politics. The Congress must reflect on its role in such coalitions and work toward building an independent organizational presence in states where it remains a junior partner.

Assam Bye-Elections: BJP's Unyielding **Dominance:** Assam's bye-election results were a resounding affirmation of the BJP-led NDA's grip on state politics. Winning all five contested Legislative Assembly constituencies, including the symbolic victory in the minority-dominated Samaguri, the BJP demonstrated its ability to consolidate support across diverse demographics. Samaguri, held by the Congress for 25 years, was a high-stakes battle. The BJP's victory, spearheaded by youth leader Diplu Ranjan Sarmah, reflected its capacity to dismantle Congress strongman Rakibul Hussain.

The BJP's junior allies, including the Asom Gana Parishad (AGP) and the United People's Party Liberal (UPPL), also played pivotal roles, retaining their strongholds in Bongaigaon and Sidli, respectively. The coordinated efforts of the NDA alliance highlighted the BJP's organizational strength and its ability to manage coalition dynamics effectively. Chief Minister Himanta Biswa Sarma lauded the results as a testament to Assam's faith in Prime Minister Narendra Modi's governance model. His emphasis on Samaguri, a constituency with a significant minority population, underscored the BJP's strategy of broadening its appeal beyond traditional vote banks. The Congress, on the other hand, faced criticism for its lack of cohesion and strategic vision. Despite marginal gains in vote share in some constituencies, internal squabbles and arrogance, as pointed out by opposition leader Akhil Gogoi, undermined its performance.

National Implications: The Invincibility of the BJP?

The electoral outcomes in Maharashtra and Assam underline the BJP's ability to adapt and thrive in challenging political terrains. Unlike Congress, whose structural fragility has been exposed repeatedly since 2014, the BJP's year-round organizational activity and robust ground-level presence give it a decisive edge. These victories not only strengthen the BJP's position in regional politics but also have national implications, consolidating its leadership within the NDA and bolstering Prime Minister Modi's government.

ess, despite being a key player in the INDIA bloc, faces an existential crisis. Its repeated electoral failures raise questions about its relevance and ability to challenge the BJP in a bipolar contest. While the INDIA bloc provides a platform for collective opposition, the Congress's lack of organizational strength and strategic clarity could jeopardize its role within the coalition.

The Road Ahead: Indian politics is a dynamic arena where adaptability, strategy, and organizational strength often determine success. Mamata overrules Abhishek plan on TMC revamping through 'new wave'

uoyed by a clean sweep in the November 13 by-elections to six assembly constituencies, Trinamool Congress supremo Mamata Banerjee has reposed faith on veteran leaders. It puts on ice for the time being, the party's unofficial number two, chief minister Banerjee's nephew, Abhishek Banerjee's rejig plan. To create a new wave in the party by inducting more youth workers in the leadership.

In a recent organisational meeting at Mamata Banerjee's Kalighat home, the chief minister reasserted her position as the party's sole decision maker. The decisions taken at the meeting are pointers that Abhishek's recommendations to remove underperformers as indicated in Lok Sabha poll results will not be implemented in a hurry.

Addressing the martyr's day rally of TMC on July 21, Abhishek had announced that the underperformers in the civic and rural bodies run by Trinamool would be acted against in three months. A similar fate awaited leaders in whose areas the TMC candidates trailed behind BJP nominees in the Lok Sabha elections.

Lest his decisions be termed as arbitrary, Banerjee's office had prepared a report of functionaries of 120 civic bodies. This "performance based" report had been given to party supremo and chief minister, Mamata Banerjee.

Abhishek, the national general secretary of the TMC had gone abroad thereafter for his eve treatment. In an informal talk with scribes on his birthday November 7, he had indicated that several district chiefs are likely to lose their posts.

The three month deadline went by without any change in the party hierarchy. Meanwhile, Abhishek's loyalists had started rooting for more organisational and administrative responsibilities be given to him.

One of them, Bharatpur MLA Humayun Kabir who had often hit the headlines for the wrong reasons demanded that Abhishek be made deputy chief minister. He further stated that home department be given to Abhishek.

There were subtle recommendations that Abhishek be given a higher position in the party hierarchy. Without actually taking sides, veteran leader and Dum Dum MP, Saugata Roy said that it is difficult for one person to look into all the aspects of the administration, meaning Mamata is burdened with too much government departments.

Though a part of the old guard and known for his proximity to the party supremo, Roy put in a word for Abhishek, the MP from Diamond Harbour. It was learnt from TMC sources that Roy was on a relationship mending mission with Abhishek who was unhappy at the veteran leader contesting yet again from Dum Dum in the recent Lok Sabha elections.

But there were dissenting voices too seeking that Mamata Banerjee was the only leader in the TMC who was a "vote catcher". Both Kolkata mayor, Firad Hakim and Serampur MP Kalyan Bandopadhyay endorsed that Mamata Banerjee is the only leader in the Trinamool Congress who enjoyed the allegiance of one and all.

During the Lok Sabha elections campaign, Kalyan Bandopadhyay had clearly said that he needed none other than Mamata Banerjee to campaign for him. He added for good measure that he would not mind if Abhishek joined the cam-

But just as a section of the TMC were looking forward to induction of Abhishek loyalists in key positions in the party, three disciplinary committees formed by the party supremo put paid to the idea. Mamata Banerjee made it clear that there is no possibility now of handing over the reins of authority in the party if the composition of the three disciplinary committees are anything to go by.

Comprising the leaders who had been with her when she broke away from Congress and floated Trinamool Congress like Sudip Bandopadhyay, Firad Hakim, Sovandeb Chattopadhyay, Arup Biswas, Kalyan Bandopadhyay, Mala Roy, Javed Khan and others. One of the disciplinary committees has already sent its first show cause noticed to Bharatpur MLA Humayun Kabir who had charged a coterie in the party trying to influence every decision of Mamata Banerjee.

Not replying to three show cause notices would amount to suspension. Another Abhishek loyalist, Arup Chakraborty has been dropped as party spokesman; both moves are being interpreted in TMC circles as a warning to those seeking to overshadow Mamata by her nephew.

Earlier, a senior TMC leader, a part of the group of veterans had said that Kabir's remarks have been taken note of. Action will be taken against him once the party supremo gives her nod. The show cause notice to Kabir is a pointer to the receipt of that nod. It is a clear message that the old guard will be decision makers remaining in key slots of TMC for quite sometime now. Is stage 3 breast cancer curable?

Thile advanced stages of cancer may not be completely curable, with timely awareness, appropriate diagnosis and medical intervention, vou can try to tackle the symptoms and prolong your life span, points out Dr Pritam Kataria, consultant, medical oncology at the Sir H N Reliance Foundation Hospital. Breast cancer is one of the most common types of cancer in India, with more women being diagnosed with it than men. Globally too, the incidence of breast cancer is rising.

Self-examination, early diagnosis and mammography are some of the ways to detect and confirm if you have underlying symptoms. However, in most cases, women do not seek help until the cancer reaches its later stages

In 2002, veteran actor Mumtaz was diagnosed with breast cancer. She was 54 and was able to recover after multiple rounds of radiation and chemotherapy

In September 2018, actor Ayushman Khurrana's wife Tahira Kashyap, was diagnosed with Stage 0 breast cancer (this is in the pre-cancer stage, affects the milk duct and is non-invasive). She underwent a mastectomy (removal of the breast) and later wrote a book documenting her iourney to recovery.

Last week, actor Hina Khan - who is just 36 years old - announced that she has been diagnosed with Stage 3 breast cancer. While the news came as a shock, there were many who wondered why her cancer remained

Dr Pritam Kataria, consultant, medical oncology at the Sir HN Reliance Foundation Hospital, answers some of the most frequently asked questions about breast cancer:

What are the warning signs of breast cancer that women should not ignore?

The most common symptom of breast cancer is a new lump or mass in the breast; however, not all such lumps are signs of cancer. A painless, hard mass that has irregular edges is more likely to be cancer. But breast cancers can be also soft, round, tender or even painful.

Other possible symptoms of breast

- Swelling of all or part of a breast (even if no lump is felt)
- · Skin dimpling (sometimes looking like an orange peel)
- Breast or nipple pain · Nipple retraction (turning in-
- Nipple or breast skin that is red,
- dry, flaking or thickened nipple discharge (other than breast milk) • Swollen lymph nodes under the

Breast cancer: How to do a self- such as a lump, pain or nipple discharge, as well as for women who have no breast complaints. The procedure allows the detection of breast cancers, benign tumours and cysts before they can be detected by palpation

breast cancer be treated/cured?

Yes, it can. There are typically five different stages of breast cancer, depending on the size and severity of the tumour. The risk of treatment and survival increases with each stage.

Stage 0 is one of the most difficult to detect due to poor symptoms. In stages 3 and 4, the tumour has probably grown in terms of size but may or may not have spread to other organs. In advanced stages, the tumour may have spread to other organs including the lungs, liver and the brain.

Based on the severity of symptoms and size of the tumour, there are two types of treatment -- local therapy and systemic therapy.

Local therapy includes radiation therapy and surgery. Systemic therapy includes chemotherapy, targeted therapy, immunotherapy and hormonal therapy.

In most cases where women are diagnosed with stage 1, 2 or 3 of breast cancer, it can be cured with surgery and radiation therapy.

What causes upper stomach pain?

tomachaches are a plaint. many issues responsible for upper stomach pain, such as gas or a stomach virus, are not cause for concern, others may require medical treatment.

In this article, learn about ten possible causes of upper stomach pain, as well as treatment options and when to see a doctor.

Gas Gas occurs naturally in the intestines and digestive tract. When this gas accumulates, it can cause feelings of pressure, bloating, or full-

Gas usually goes away without treatment within a few hours. If it occurs with a fever, uncontrolled vomiting, or intense pain, it is best to see a doctor.

Gas pain is not usually serious, and overthe-counter (OTC) medications can help. A person can also try eating more slowly to avoid swallowing air and prevent the gas from getting worse. Some people notice that certain foods are more likely to cause gas pain. Indigestion

The medical term for indigestion is dyspepsia. It usually appears when there is too much acid in the stomach, which can happen after eating highly acidic foods. It can cause a burning feeling in the upper stomach and sometimes in the mouth or throat. The pain may also feel like it stems from the chest.

Less commonly, indigestion can result from a stomach ulcer, acid reflux, or even stomach cancer

OTC medicines are highly effective at managing temporary indigestion. Identifying the triggers, such as certain foods, can help a person make healthful lifestyle changes Gastritis

Acute gastritis occurs in the short term and comes on quickly, usually because of a bacterial infection, such as with Helicobacter pylori bacteria. Gastritis causes the stomach lining to become swollen and painful.

Causes of chronic gastritis include:

- Crohn's disease autoimmune dis-

- eases sarcoidosis
- allergies · viruses in people
- with weakened immune
- systems alcohol consump-

NSAID use

Antibiotics can usually treat bacterial infections. When gastritis is chronic, diagnosing and treating the underlying cause can help. **Stomach viruses**

Gastroenteritis is a stomach virus that can cause nausea, vomiting, and diarrhea, in addition to upper stomach pain. Some people call gastroenteritis the stomach flu, but it is not actually a type of flu.

For most people, symptoms go away on their own within a few days. Avoiding heavy meals and drinking only clear liquids can help a person stop vomiting.

It is vital to avoid dehydration, so consider drinking something that restores electrolytes until the symptoms pass.

Muscle pain

Many muscles extend to the upper stomach. Pain from a mild muscle injury or spasms can cause temporary pain in the upper abdomen.

The pain often gets better with gentle massage and rest. Some people also find relief by using cold and hot packs

Appendicitis Appendicitis is an infection of the appendix. Without treatment, it can cause the appendix to rupture, and the con-

dition can become life

threatening In the early stages of appendicitis, a person may notice a dull ache around their belly button, but this pain can radiate to the upper stomach. As the infection gets worse, the pain moves to the lowerright side.

Gallstones Gallstones are hard formations of cholesterol or bilirubin that can develop in the gallbladder. They do not always cause problems, but sometimes they

block a biliary duct. A blockage from a gallstone can cause intense pain in the upperright stomach, as well as vomiting, fatigue, and exhaustion.

In some cases, surgery is necessary to resolve problems from gallstones. For example, if gallstones block the cystic duct, then a doctor will remove the gallbladder.

If gallstones block the common bile duct, then an Endoscopic retrograde cholangio-pancreatography (ERCP) may be needed to help extract them. This involves inserting a thin camera and other implements down your throat to manipulate and resolve the block-

Liver or pancreas is-

The liver, pancreas, and gallbladder work together to support digestion. All three organs are in the upper-right side of the

Sometimes, untreated gallstones block biliary ducts, causing pain in the liver or pancreas.

Liver diseases, such as hepatitis, can cause liver pain. Pancreatitis, which is inflammation of the pancreas, may also cause pain. Some other causes, such as liver or pancreatic cancer, are less likely.

The right treatment depends on the underlying cause. People with pancreatitis may need to stay in the hospital for fluids and observation. Liver diseases require medication, and a liver transplant can treat

advanced liver disease. **Bowel obstruction**

A bowel obstruction blocks the intestines, making it difficult or impossible for anything to pass through. This can cause intense pain, constipation, and difficulty digesting and absorbing food.

A bowel obstruction is a medical emergency, as the bowel can tear or become seriously infected. Medications, fluid, and pain relievers often help. In some cases, a surgeon may need to remove the blockage.

Diverticular disease Small pouches called diverticula can appear in the intestines, especially in the colon-Trusted Source. The presence of these pouches is known as diverticulosis. When these pouches

become inflamed or infected, a person can develop intense abdominal pain. Inflammation of the diverticular is known diverticulitis.

The location of the pain depends on where the diverticula are. While diverticula are more common in the lower intestines, they can also appear in the upper intestines, causing pain in the upper

Probiotics and a high fiber diet often help treat diverticulitis. Antibiotics have been traditionally used to treat diverticulitis, but

emerging recommendations suggest supportive care only in uncomplicated diverticulitis

If the infection worsens or does not go away, a doctor may perform surgery to remove the diverticula or a part of the intestines.

When to contact a doctor

In most cases, it is safe to wait and see if upper stomach pain goes away without treatment. If the pain persists or gets worse, it is best to see a doctor. See a doctor within

This medical emergency occurs when blood flow to part of the brain is disrupted, depriving brain tissue of oxygen and nutrients. Without immediate medical attention, brain cells can begin to die within minutes. Therefore, a thorough grasp of stroke prevention, diagnosis, and treatment is crucial in reducing both the frequency and impact of this critical health emergency.

Stroke prevention primarily involves addressing risk factors and adopting a healthy lifestyle. Many strokes can be prevented through modifications in diet, exercise, and managing medical conditions. Adopting a healthy lifestyle is fundamental to stroke prevention. This includes a balanced diet rich in fruits, vegetables, whole grains, and lean proteins while limiting salt, sugar, and saturatedfats to maintain healthy blood pressure and cholesterol

Regular physical activity like brisk walking, swimming, or cycling helps keep a healthy weight and improve cardiovascular health. Quitting smoking significantly reduces stroke risk by preventing blood vessel damage and high blood pressure. Moderation in alcohol consumption is also important.

Medical management is vital for stroke prevention. Controlling blood pressure through regular monitoring and medication is crucial. Managing diabetes by keeping blood sugar levels under control also reduces stroke risk. Additionally, lowering high LDL cholesterol levels, which can lead to plaque buildup in arteries, is important. Diagnosis

Prompt diagnosis of a stroke is critical for effective treatment and im-

proving outcomes. The quicker a stroke is identified and treated, the better

the chances of minimizing brain damage. The acronym "BEFAST" helps

The golden period for effective medical therapy has been extended to 4.5 hours from onset of symptoms, and for clot retrieval procedures, it can extend up to 24 hours. Acting swiftly within these time frames significantly enhances the chances of minimizing stroke-related damage and improvingpatient outcomes.

Assessment of different types of strokes Strokes are broadly categorized into two types based on their underlying causes: ischemic strokes, which account for approximately 80% of cases and occur due to blockage or narrowing of blood vessels supplying the brain; and haemorrhagic strokes, constituting about 20% of cases, which result from the rupture of a blood vessel in the brain.

Imaging tests, such as CT scans or MRIs, are used to determine the type of stroke and assess the extent of brain damage. Blood tests can identify conditions that increase stroke risk, like high cholesterol, elevated blood sugar levels, and blood clotting issues. An electrocardiogram detects heart conditions that may have contributed to the stroke.

For an ischemic stroke, treatment includes clot-busting medications or mechanical thrombectomy. Thrombolytics, such as tissue plasminogen activator, can dissolve the clot if given within a few hours of symptom onset. Mechanical thrombectomy involves using a catheter to remove the clot from

the blocked artery, typically within six hours of symptom onset. For a haemorrhagic stroke, treatment approaches differ. Surgery, such as aneurysm clipping or arteriovenous malformation repair, can help stop the bleeding. Medications to lower blood pressure, control bleeding, and prevent seizures may also be administered. While strokes remain a significant health threat, understanding and managing risk factors, recognizing symptoms, and seeking immediate treatment can improve outcomes. A commitment to a healthy lifestyle and regular medical check-ups is key to prevention, and rapid response is essential for effective treatment. After Aleppo, Syrian insurgents advance to nearby province Assad says he'll defeat 'them'

BEIRUT, Dec 1: Thousands of Syrian insurgents took over most of Aleppo on Saturday, establishing positions in the country's largest city and controlling its airport before expanding their shock offensive to a nearby province. They faced little to no resistance from government troops, according to fighters and activists.

A war monitor, the Syrian Observatory for Human Rights, said the insurgents led by Hayat Tahrir al-Sham seized control of Aleppo International airport, the first international airport to be controlled by insurgents. The fighters claimed they seized the airport and posted pictures from there.

The lightning offensive threatened to reignite the country's civil war, which had been largely in a stalemate for years.

Late on Friday, witnesses said two airstrikes hit the edge of Aleppo city, targeting insurgent reinforcements and falling near residential areas. The Observatory said 20 fighters were killed.

Trump threatens BRICS countries of 100% tariff if they drop dollar as currency

WASHINGTON, Dec 1: Presidentelect Donald Trump on Saturday warned BRICS countries against any move to replace the US dollar and has sought a commitment from the ninemember group that includes India, Russia, China, and Brazil.

BRICS, formed in 2009, is the only major international group of which the United States is not a part. Its other members are South Africa, Iran, Egypt, Ethiopia, and the United Arab Emirates. Over the past few years a few of its member countries, in particular Russia and China, are seeking an alternative to the US Dollar or create own BRICS currency. India has so far not been part of the move.

On Saturday, Trump warned BRICS nations against such a move.

"The idea that the BRICS Countries are trying to move away from the Dollar while we stand by and watch is OVER," the president-elect said in a post on Truth Social, a platform owned by him. "We require a commitment from these Countries that they will neither create a new BRICS Currency, nor back any other Currency to replace the mighty U.S. Dollar or, they will face 100% Tariffs and should expect to say goodbye to selling into the wonderful U.S. Economy," Trump warned.

"They can go find another sucker!' There is no chance that the BRICS will replace the US Dollar in International Trade, and any Country that tries should wave goodbye to America," he said. At the 2023 summit in South Africa, BRICS countries committed to study the feasibility of a new common currency. A proposal in this regard was made by the Brazilian President Luiz Inacio Lula de Silva. India, an important pillar of BRICS, has said it is against de-dol-

"...ask you about de-Dollarization as a possibility for the world. At times India has expressed interest in alternative currency. It can serve as a reserve mechanism. I wonder how do you see that right now what you see as the role of the dollar and these discussions about your national policy? India's External Affairs Minister S Jaishankar said during his appearance at the Carnegie Endowment for International Peace this fall.

"I think you have us confused for someone else because we have never actively targeted the dollar. That's not part of either our economic policy or our political or our strategic policy. Some others may have," Jaishankar said. "What I will tell you is a natural concern there. We often have trade partners who do not have dollars to take. So, we now have to look at whether we forgo dealings with them or do we find some settlement which works otherwise. So, there's no, I can say malicious intent vis-a-vis the dollar in business. WE are trying to do our business," he said. "Sometimes you make it difficult

Bangladesh HC acquits all accused in 2004 Hasina attack case

DHAKA, Dec 1: The High Court here on Sunday scrapped the lower court's verdict and acquitted all accused, including former Bangladesh prime minister Khaleda Zia's son Tarique Rahman and former state minister Lutfozzaman Babar, in a 2004 grenade attack in ousted premier Sheikh Hasina's rally. "The High Court annulled the trial court verdict and acquitted all convicts including Tarique Rahman," a spokesman for the attorney general's office said.

Rahman, 57, is the acting chairman of Bangladesh Nationalist Party (BNP).

Two cases -- one for murder and another under the Explosives Act -- were filed after a grenade attack on an Awami League rally at Bangabandhu Avenue in Dhaka left 24 people dead and nearly 300 injured. The HC bench of Justice AKM Asaduzzaman and Justice Syed Enayet Hossain acquitted all 49 accused and observed that the trial court's verdict in the cases was "illegal."

The High Court's verdict comes after the bench heard the death references and appeals related to the cases filed over the attack.

The trial court had delivered the judgement based on a confession by Mufti Abdul Hannan, the top leader of the banned Harkat-ul-Jihad al-Islami (HuJI) militant outfit who was accused in the case. Hannan has been executed in connection with another case.

The High Court said the confessional statement had no evidential value as it was taken on force and not examined properly by the magistrate con-

On November 21, the bench kept the death references (trial court documents for confirmation of death sentences) and the appeals filed by the convicted accused in the cases as curia advisari vult (meaning the verdict will be delivered any day) after it concluded a hearing on those matters.

During the hearing on the death references and appeals, the defence lawyers for the accused requested the High Court to scrap the trial court verdict as there was no specific allegation against

Meanwhile, appearing for the State, Deputy Attorney Generals Md Jashim Sarker and Md Russell Ahammad requested the High Court bench to uphold the lower court verdicts in the cases as the allegations against the convicted accused were proved beyond reasonable doubt.

Kash Patel as FBI Director

WASHINGTON, Dec 1: Presidentelect Donald Trump on Saturday nominated close confidante Kash Patel for the powerful position of Director of the Federal Bureau of Investigation, making him the highest ranking Indian American in his incoming administration. "I am proud to announce that

Kashyap 'Kash' Patel will serve as the next Director of the Federal Bureau of Investigation. Kash is a brilliant lawyer, investigator, and 'America First' fighter who has spent his career exposing corruption, defending Justice, and protecting the American People," Trump announced on Truth Social, a social media platform he owns. Trump said Patel played a pivotal role in uncovering "the Russia, Russia, Russia Hoax," standing as an advocate for truth, accountability, and the Constitution. Patel, 44, served as chief of staff to the Acting United States Secretary of Defense in the last few weeks of the Trump Administration in 2017.

"Kash did an incredible job during my First Term, where he served as Chief of Staff at the Department of Defense, Deputy Director of National Intelligence, and Senior Director for Counterterrorism at the National Security Council. Kash has also tried over 60 jury trials," he said.

"This FBI will end the growing crime epidemic in America, dismantle the migrant criminal gangs, and stop the evil scourge of human and drug trafficking across the Border. Kash will work under our great Attorney General, Pam Bondi, to bring back Fidelity, Bravery, and Integrity to the FBI," Trump said.

New York-born Patel has his roots in Gujarat. However, his parents are from East Africa – mother from Tanzania and father from Uganda. They came to the US from Canada in 1970. "We are Gujarati," he had told PTI in

an earlier interview. The family moved to Queens in New York – often called as Little India -- in the late 70s. It is here that Patel was born and grew. Patel's parents are retired now and spend their time in both the US and Gujarat. After his schooling in New York and college in Richmond, Virginia, and law school in New York, Patel went to Florida where he was a state public defender for four years and then federal public defender for another four

"So, lots of trials, lots of international investigations, lots of time in court, understanding the federal system and trying cases and learning how to run investigations," he said.

From Florida he moved to Washington DC as a terrorism prosecutor at the Department of Justice. Here he was an international terrorism prosecutor for about three and a half years. During this period, he worked on cases all over the world, in America in East Africa as well as in Uganda and Kenya. While, still employed by the Department of Justice, he went as a civilian to join Special Operations Command at the Department of Defense. At the Pentagon, he sat as the Department of Justice's lawyer with Special Forces people and worked interagency collaborative targeting operations around the world.

After a year in the position, Congressman Davin Nunes, Chairman of the House Permanent Select on Intelligence Committee, pulled him as senior counsel on counterterrorism. After April 2017, he spearheaded the Russia investigation of the House Intelligence Committee. It was here where he attracted media attention and played a key role in drafting a GOP memo, which, according to then-President Donald trump, exposed the role of Democratic party and its leadership in the Russian investigation.

The New York Times described this as a "Kash Memo." Patel said that this was a "great team effort."

Patel is an Ice hockey fan and has been playing the sport since he was six. "I still play and I spend a lot of time volunteering coaching youth hockey in the area.'

Landmark climate change case will open at top UN court

THE HAGUE, Dec 1: The top United Nations court will take up the largest case in its history on Monday, when it opens two weeks of hearings into what countries worldwide are legally required to do to combat climate change and help vulnerable nations fight its devastating impact.

After years of lobbying by island nations who

fear they could simply disappear under rising sea

waters, the UN General Assembly asked the International Court of Justice last year for an opinion on "the obligations of States in respect of climate change. "We want the court to confirm that the conduct that has wrecked the climate is unlawful." Mar-

garetha Wewerinke-Singh, who is leading the legal team for the Pacific island nation of Vanuatu, told The Associated Press. In the decade up to 2023, sea levels have risen by a global average of around 4.3 centimeters

(1.7 inches), with parts of the Pacific rising higher

still. The world has also warmed 1.3 degrees Celsius (2.3 Fahrenheit) since pre-industrial times because of the burning of fossil fuels. Vanuatu is one of a group of small states pushing for international legal intervention in the cli-

"We live on the front lines of climate change impact. We are witnesses to the destruction of our lands, our livelihoods, our culture and our human rights," Vanuatu's climate change envoy Ralph

Regenvanu told reporters ahead of the hearing. Any decision by the court would be non-binding advice and unable to directly force wealthy nations into action to help struggling countries. Yet it would be more than just a powerful symbol



since it could serve as the basis for other legal ac-

tions, including domestic lawsuits. On Sunday, ahead of the hearing, advocacy groups will bring together environmental organizations from around the world. Pacific Islands Students Fighting Climate Change — who first developed the idea of requesting an advisory opinion — together with World Youth for Climate Justice plan an afternoon of speeches, music and

From Monday, the Hague-based court will hear from 99 countries and more than a dozen intergovernmental organizations over two weeks. It's the largest lineup in the institution's nearly 80-year history.

mate meeting, countries cobbled together an agreement on how rich countries can support poor countries in the face of climate disasters. Wealthy countries have agreed to pool together at least \$300 billion a year by 2035 but the total is short of the \$1.3 trillion that experts, and threatened nations, said is needed.

"For our generation and for the Pacific Islands, the climate crisis is an existential threat. It is a matter of survival, and the world's biggest economies are not taking this crisis seriously. In May, a UN tribunal on maritime law said that carbon emissions qualify as marine pollution and countries must take steps to adapt to and mitigate their adverse effects. That ruling came a month after Europe's high-

better protect their people from the consequences

of climate change, in a landmark judgment that

could have implications across the continent. The ICJ's host country of The Netherlands made history when a court ruled in 2015 that protection from the potentially devastating effects of climate change is a human right and that the government has a duty to protect its citizens. Besides, both the NSCN-IM and the ZUF have entered into ceasefire and "Cessation of Operation (CoO)" with Government of India and it is imperative on both sides to protect the life and property of innocent Naga public etc., the joint statement also said. "It is also pertinent to note that 99% Naga public and citizens follow Christianity as a result it is the Christmas season which observes the birth of the Prince of Peace on Lord Jesus Christ, Christmas and New Year are the biggest festivals of the Christians all over the world. Both sides should hold out their olive branch in this season. We also appeal to both the Government of India and the Government of Manipur to maintain law and order in the region," the joint statement added.

"These three organisations also jointly condemned the abduction of Laishram Kamal Babu Singh, a construction worker Leimakhong's 57th Mountain Division (which is in a highly fortified cantonment) by suspected Kuki militants", the Rongmei bodies added. Security Force (BSF) deployed in Tripura has seized narcotics and other contraband worth over ₹ 46 crore and detained 675 individuals, including Bangladeshi and Rohingya nationals, in various operations conducted throughout 2024.

Marking its 60th Raising Day on Sunday the BSF Tripura Frontier highlighted its pivotal role in ensuring border security and combating cross-border crimes. Over the years, the force has undertaken critical responsibilities such as counter-insurgency operations, maintaining border sanctity, and fostering harmony among border communities, often under harsh conditions in remote and malariaprone areas.

In a press release, the BSF emphasized its achievements in maintaining vigilance and thwarting illegal activities along the Indo-Bangladesh border.

Their efforts in 2024 led to the rescue of 1,383 cattle and the seizure of contraband, including 66,316 bottles of Phensedyl, 9,203.24 kgs of cannabis, 605,334 Yaba tablets, 1,222,894.5 kgs of Sugar, 496.26 grams of gold, 381.01 grams of brown sugar, 1 pistol (7.65 mm) and 210 items (ammunition/tinny arms) and 48,60,735 Taka Bangladeshi currency items worth ₹ 46,00,45,074

Tripura private hospital halts services for Bangladeshi patients

AGARTALA, Dec 1: ILS Hospital in Agartala has temporarily suspended its services for Bangladeshi patients following protests over recent incidents in Bangladesh, including attacks on Hindu minorities and alleged desecration of the Indian national

The decision was made after a group of protestors staged a demonstration outside the hospital earlier today. ILS Hospital and the Cancer Hospital in Agartala typically treat over 100 Bangladeshi patients each month, but this

move is set to disrupt the medical access for those who cross the border seeking healthcare.

A protestor present at the demonstration stated, "As Indians, we cannot remain silent about the atrocities being reported from Bangladesh. Attacks on the Hindu minority community and acts of disrespect toward our national flag are unacceptable. While the political situation in Bangladesh is an internal matter, such actions affect us deeply, and we must stand in solidarity with our people."

The protestor further alleged that children in Bangladesh were being indoctrinated to disrespect the Indian flag and condemned the groups in the neighboring country. We approached the hospital management, and they agreed to suspend services for Bangladeshi patients as a symbolic protest. This is not about religion or targeting any community; it is about standing up for justice and dignity," the protestor added.

In response to the protest, ILS Hospital CEO Dr Gautam Kundu said, "We understand and support the sentiments expressed by the protestors. After considering their concerns, we have decided to suspend services for Bangladeshi patients until the situation improves. This includes shutting down our dedicated desk for Bangladeshi patients. While the number of such patients had already declined in recent months, this step is being taken to respect the sentiments of the people."

The hospital's decision reflects growing tensions between the two countries amid rising concerns over the safety of minorities in Bangladesh and the reported disrespect shown to Indian national

Mobile internet ban extended till Dec 3 in nine districts of Manipur

IMPHAL, Dec 1: The Manipur government on Sunday extended the suspension of mobile internet for two days in nine districts of the state till December 3.

An order issued by the home department said the suspension was extended in Imphal West, Imphal East, Kakching, Bishnupur, Thoubal, Churachandpur, Kangpokpi, Pherzawl and Jiribam.

'The state government after reviewing the prevailing law and order situation and its correlation with the general operation of internet services has decided to continue suspension of mobile internet and mobile data services including VSATs and VPN services in the territorial jurisdiction of Imphal West, Imphal East, Kakching, Bishnupur, Thoubal, Churachandpur and Kangpokpi, Pherzawl and Jiribam of Manipur till 5.15 pm of December 3, in public interest,"



the order said. Internet services have been temporarily suspended since November 16 after violence broke out in the state following the recovery of dead bodies of three women and three children in Jiri and Barak rivers in Manipur and

Assam respectively. The Manipur government had conditionally lifted the suspension on broadband services (ILL and FTTH) on November 19, considering the hardships faced by common people, healthcare facilities, educational institutions and other offices.

The order had, however, stated that subscribers should not accept any connection other than the one allowed, and no wifi or hotspots should be allowed.

The violence escalated in Manipur after three women and three children belonging to the Meitei community had gone missing from a relief camp in Jiribam district, following a gunfight between security forces and suspected Kuki-Zo militants that resulted in the deaths of 10 insurgents on November 11. Bodies of those six were

later found. More than 250 people have been killed and thousands rendered homeless in ethnic violence between Imphal Valley-based Meiteis and adjoining hills-based Kuki-Zo groups since May last

Delay in govt formation 'insult' to Maharashtra: Aaditya Thackeray Oath-taking ceremony of the new Mahayuti government will take place on December 5

MUMBAI, Dec 1: Shiv Sena (UBT) leader Aaditya Thackeray on Sunday claimed the Mahayuti's inability to decide on a chief minister and form government more than a week after the announcement of assembly poll results was an "insult" to

Targeting the Bharatiya Janata Party (BJP), which is the largest constituent of the Mahayuti, Thackeray claimed that to declare the swearing-in date unilaterally without even staking claim to form government is "pure anarchy"

The Mahayuti alliance of the BJP, Shiv Sena and NCP retained power with a landslide victory in the assembly elections, the results of which were announced on November 23.

The oath-taking ceremony of the new Mahayuti government will take place on December 5 evening and Prime Minister Narendra Modi will attend it, state BJP chief Chandrashekhar Bawankule said on



There has been no announcement yet on who would be the chief minister.

Devendra Fadnavis, who has been chief minister twice and was deputy CM in the last Eknath Shinde-led government, was the frontrunner for the post, according to

Maharashtra's caretaker Chief Minister

headed to his native village Dare in Satara district on Friday, amid speculation that he was not happy with the way the new state government was shaping up.

The group that will carry essential items with it will head towards Delhi peacefully,

The first group of farmers, during their march to Delhi, will stop at the Jaggi city centre in Ambala, the Mohra grain market, Khanpur Jattan and Pipli in Haryana, he

Pandher said the farmers will walk every day from 9 am to 5 pm and spend the nights

He added that the number of farmers in the first group will be shared later. Lashing out at the BJP-led Centre, Pandprotesting farmers since February 18. Accusing the Centre of running away, he

said, "They have stopped the talks with us." "Contract farming is not acceptable to us. We are demanding a legal guarantee on the MSP (minimum support price) for crops,'

Besides a legal guarantee on the MSP, the protesters are demanding farm loan waiver, pension for farmers and farm labourers, no hike in the electricity tariff, withdrawal of police cases and "justice" for the victims of the 2021 Lakhimpur Kheri violence, reinstatement of the Land Acquisition Act, 2013 and compensation to the families of the farmers who died during a previous agher said it has not held any talks with the itation in 2020-21. Our fight is for the spirit of our Parl panel seeks details of properties in country, says Priyanka Gandhi 'unauthorised' occupation of state govts



NEW DELHI, Dec 1: The parliamentary committee scrutinising the Waqf (Amendment) Bill has sought details from various state governments about the veracity and updated details of Waqf properties which, according to the Sachar committee, they had occupied in an unauthorised manner, sources

The parliamentary committee, whose tenure has been extended by Lok Sabha till the last day of the next Budget Session, has also sought from the states details of the properties claimed by Waqf boards exercising Section 40 of the Waqf Act. Section 40, an amendment effected during the Congress-led UPA government's tenure in 2013, is one of the most hotly contested features of the existing law as it has given Waqf boards the power to decide if any property belongs to the Waqf or not.

The proposed law, which has faced flack from opposition parties and various Muslim groups for its alleged attempts to interfere in religious matters, has sought to curb this power while making a slew of other changes in the existing Act.

The sources said the parliamentary panel has decided to get an update on the points made by the Sachar committee on the Waqf properties that are allegedly in unauthorised occupation of state governments or their official agencies.

The Sachar committee was informed by various state Waqf boards during 2005-06 about the alleged unauthorised occupation. The parliamentary panel has been collecting

information from states through the Union Ministry of Minority Affairs. Sources said the panel headed by BJP MP Jagdambika Pal has noted that there were 316 such properties in Delhi, 60 in Rajasthan and

42 in Karnataka reported to the Sachar committee in 2005-06. While 53 of them were in Madhya Pradesh,

60 were in Uttar Pradesh and 53 in Odisha. The committee has sought updates from all these six states, the sources said, adding that the panel has got information from several

"The chief ministers of the above states may kindly investigate in detail into the veracity of this information in the Sachar Committee Report... and update this Committee in detail," a source said, citing the communication. State governments have also been urged to share details of the cases where their agencies are involved in a legal dispute with Waqf boards over ownership or possession of any property, with the panel noting that the Sachar Committee had stated its list was not exhaustive. The UPA government constituted the Sachar Committee in 2005 to study the social, economic and educational status of the Muslim community in India.

It submitted its report in 2006 highlighting the poor status of Muslims on all these indicators as it recommended a host of measures

Lok Sabha had on November 28 adopted a resolution to extend the tenure of the Joint Committee on the Waqf (Amendment) Bill till the last day of the Budget session of Parliament next year.

The parliamentary panel's meetings have become a political battleground, with the ruling BJP and opposition members vociferously debating the changes proposed by the govern-

Opposition members had been calling for extending its tenure, which was to end on November 29, and the committee took a unanimous decision to seek more time despite Pal's earlier assertion that he was ready with the

He has asserted that he has accommodated the views of every opposition member, rejecting their allegation of "bulldozing" the proceedings of the panel's meetings. (PTI)

'The situation in the country is not good. Leaders like Mahatma Gandhi, Pandit Jawahar Lal Nehru, Maulana Abdul Kalam Azad, Sardar (Vallabhbhai) Patel, (BR) Ambedkar made this country home for Hindus, Muslims, Sikhs and Christians. Gandhi even sacrificed his life for it," she said.

"However, people are being pitted against each other (on the basis of religion) and I am afraid we are being pushed towards the 1947like situation," Mehbooba, a former chief minister, said addressing a gathering of party workers here

Attacking BJP, she said the government has failed to provide jobs, education, good hospitals and roads to the people and is diverting the attention of the people by targeting mosques on the pretext of finding temples beneath.

"This is exactly what is happening in the country. Four innocent youth were recently killed in Sambhal (UP) but who will speak for them. Anyone doing so will be put in iail like Umar Khalid who is behind the bars for the last four years. In the prevailing condi-



tions, there is no one to listen," Mehbooba

The PDP leader referred to a petition claiming that the Ajmer Sharif Dargah was built over a Shiva temple and said people of different faiths including Hindus and Sikhs visit the 800-year-old shrine which is a glaring example of 'Ganga-Jamuni' culture.

"They also want to dig up this shrine in search of a temple... For how long will this

Mehbooba said it was former Prime Minister Indira Gandhi who helped Bangladesh to achieve independence.

"Majority of Hindus in our country are secular and I have no doubt about this. We have to stand up to counter this emerging situation as we have to live together and there is no other way," she said.

She also referred to the recent assembly results in the country and said "there is something wrong somewhere.'

One state was left deliberately so that the opposition cannot talk (on the fraud) and there is no doubt on it. Election commission is silent on the sharp rise in the poll percentage after the end of voting, she said.

The voting stops at 6 pm and we have 58 percent polling, which increases to 68 percent within the next three hours and becomes 70 percent before the start of counting,

Praising Jammu for its secular character, the PDP president said people of all religions could be seen moving around and living in communal harmony unlike in Kashmir where mostly people belonging to one community are around or the security forces.

"Jammu people have much more responsibility today, even if they had voted for one party (BJP) in the assembly elections to safeguard brotherhood and communal harmony,"

The former chief minister also accused Union Home Minister Amit Shah of sending the message that complainants, rather than offenders, will face arrest.

Criticising the arrest of AAP MLA Naresh Balyan, Kejirwal claimed that it sent a message to the people of Delhi and the city's gangsters that those who raise their voices against crimes would face jail while the gangsters themselves

would be protected. "Instead of taking action against the criminals, Amit Shah and the BJP have attacked me and arrested my MLA," Kejriwal said, stressing that his criticisms were about the worsening security situation in Delhi, not political gamesmanship. The AAP leader also questioned how the people of Delhi could rely on the central government for their safety when their concerns were being dismissed.

"After all, to whom will the people of Delhi go for their safety? Will they be safe by arresting me and attacking my MLA," Kejriwal asked, urging Shah to take responsibility for addressing the city's crime crisis.

The AAP supremo further challenged the Union home minister, saying, "If you have the courage, arrest the gangsters who are terrorising Delhi. Arrest those who are committing murders, rapes and extortion. The people of Delhi want concrete action against the criminals who have taken over the city."

In a security scare on Saturday, a man splashed some liquid on Kejriwal during his 'padyatra' in south Delhi's Malviya Nagar.

Targeting the saffron party, AAP leaders alleged that the BJP was resorting to dishonest means as it fears a third consecutive defeat in the upcoming Delhi assembly polls. With the Delhi assembly elections due in February next year, political tensions between AAP and the BJP over law and

"He insisted that there should be no discrimination against anyone in any way and at any level." the Pope said.

"Sadly, displays of discrimination and exclusion, tensions and violence-based differences of ethnic or social origin, race, colour, language and religion are a daily experience of many individuals and communities, most especially among the poor, the powerless and those without a voice." he said. Winters of despair: How Delhi's annual pollution curbs affect construction workers

Nearly 3,500 projects completed NEW DELHI, Dec 1: "When they stop our work, we don't just lose the wages. It's the food on our plates and the little we try to save for our children's future," says Raju Singh, a mason from Bihar.

He was one of thousands of migrant and local construction workers rendered jobless following the November 11 ban on constructions, prompted by the Delhi-NCR's air quality plunging to hazardous levels. More such bans are likely to follow throughout the winter. While that is good news for the city's residents, the story is different for these construction workers. "Even though working in the pol-

luted air makes it hard for us to breathe, I would rather work than sit idle," Raju Singh says, describing the crushing blow the restrictions have on his finances. These trysts with work stoppages

have become an annual affair for him, and hundreds of others like The Commission for Air Quality

Management in the National Capital Region and Adjoining Areas (CAQM) -- a statutory body responsible for formulating strategies to combat pollution in the region -implements anti-pollution measures under the Graded Response Action Plan (GRAP).

Index (AQI) readings, GRAP I and into the city are banned. GRAP-IV

work-from-home.

Dr Sarath Guttikunda, the founder and director of UrbanEmissions.Info, shared a study in which he reviewed Delhi's air pollution from 1990-2022 and found that construction-related work plays a significant part in the dust category, accounting for 10-30 per cent of the pollution. Construction activities were banned for 20 days in 2021 and 35 days in 2022. Last year, nonessential construction work was banned for 26 days, and the outlook for this year appears similarly grim.

Ajay Kumar (34), another mason from Bihar, was also rendered jobless when the GRAP curbs were implemented. To support his family, he started

working as a helper at a vegetable shop, earning less than a third of his usual income. An unskilled labourer, Rina Devi

(40) shares a similar story. She switched to stitching clothes for neighbours on an old sewing ma-

"It was the only way to make money. The income was meagre but it allowed us to pay for food and basic necessities," she says.

Sujit, a labourer from West Bengal describes how such consecutive bans trap them in a vicious debt cycle. "When work stops, we've to borrow money at high interest. When work resumes, most of our earnings go into paying off the debt." he says. Sujit moved to Delhi to escape

climate change-induced flooding in his village, only to run into a form of crisis caused by the activities responsible for the climate change he was escaping from -- construction and industry

Most of Delhi-NCR's estimated 13 lakh construction workers consists of migrants from Bihar, Jharkhand and Uttar Pradesh.

Driven by the promise of high wages, they often bring their families, setting up temporary shelters at the construction sites, and inadvertently creating conditions for another major problem -- child labour. Now 12, Kajal has spent her entire life moving from one worksite to another, never been to school and worked in construction from the age of 10.

'We move around the city for work," she says during a break from carrying stones up the floors of a Greater Noida worksite.

Drawn by the promise of high wages, her family relocated from Jharkhand, only to find themselves struggling to make ends meet each

On top of the blanket construction bans, other GRAP measures significantly limit employment opportunities during winters. Skilled workers are prioritised for the few available jobs, leaving unskilled labourers like Shalini Singh, a 35vear-old mother of two, with little to no work. She had been working at a site in Delhi's Haiderpur, trying to save every rupee for these lean months.

Her husband, who struggles with alcoholism, contributes little, leaving her solely responsible for her children's upbringing.

"Every year, I know work will stop. So I save as much as I can," she says.

But with her children growing older, managing expenses on an irregular income is becoming harder.

"I dream of giving my daughter a different life," she says. "She wants to be an architect but how can I pay for her studies if I have no regular work for four or five

paying jobs carrying bricks or breaking rocks, are among the worst affected. "Women in construction are

often categorised as unskilled labour and are paid less than men," says Shashi Kaur, a social worker with CFAR, an NGO which assists workers register for job cards. "When work stops, they have

few resources to fall back on," she

As on October 1, Delhi's minimum wage for unskilled workers is Rs 18,066 a month. This is significantly higher than in nearby states and the disparity leads to even more families migrating to the national

However, the higher wage means little when there is no work. When the restrictions are finally lifted, the poor air quality endangers workers'

Dr Sajjad Khan, who works in a mohalla clinic, said he got the most patients during winter and they came with pollution-related ailments. He said exposure to such high pollution levels might cause long-term respiratory ailments.

But for many workers, the immediate need for money outweighs the potential health consequences.

Although the Delhi government has welfare schemes for construction workers, accessing these benefits is a challenge for many.

A fund managed by the Delhi Building and Other Construction Workers' Welfare Board provides financial aid to non-migrant workers but registrations dropped from four lakh in 2023 to 81,000 now, a senior official said. (PTI)

Besides this, 2,140 habitations having a population of 250-plus as per the 2001 census have been approved for providing connectivity, the officials said.

Out of the sanctioned programme, 3,429 projects, including 217 bridges, have been completed so far, they said, adding out of the targeted habitation of 2,140, 2,129 have been connected so far, thereby incurring an expenditure of


Dholakia said Gandhi "I didn't interact with any firefighter with a six-pack and all,

I GET REPRIMANDED FOR NOT BEING ACTIVE ON SOCIAL MEDIA, SAYS SAIYAMI KHER

MUMBAI, Dec 1: Actor Saiyami Kher says she is often asked by people in the film industry to be "out there" on social media, a piece of advice she finds difficult to follow.

Kher, known for work in 'Choked", "Ghoomer", and "Breathe: Into The Shadows", said one has to project a curated image of their real life on the In-

The actor, who has 1.1 million followers on Instagram and 1.3 lakh followers on X, was speaking ahead of the premiere of her film "Agni". She made her Hindi movie debut in 2016 with "Mirzya"

"I'm not the biggest fan of social media and I get reprimanded for it a lot, saying, 'You need to be out there, you need to wear certain clothes and be on social media'. That's the advice I keep

getting but I do what my heart tells me to do," Kher told PTI in an interview.

"My family makes way more sacrifices for me than I make as an actor because you have to show decorum and you need to show that everything in your life is good because that's what you keep seeing on social media," she added.

It's important to be "thickskinned" as an actor but everyone has their bad days, she said.

"All the sacrifices my family makes because of all my tantrums and bad moods... It's a bit unfair, you take them for granted, and you snap at them. When you have a bad day, that's (family) the only cushion you have. So, the sacrifices they make are much more than I do.' "Agni", billed as India's first film on firefighters, delves into the

lives of a fireman (Pratik Gandhi), and a policeman (Divyenndu), who are drawn into a perplexing surge of fire incidents around the city.

Kher plays Avni, an officer who investigates a massive fire accident that takes place in the movie, directed by Rahul Dholakia ("Parzania", "Raees").

"What resonates with me about 'Agni' was the righteousness of the character. She is somebody who stands or gets angry when people are corrupt or not following the rules. She is an investigative officer and it infuriates her because people around her are so relaxed about not following the rules

"I feel cinema is a powerful (medium)... it impacts people in good and bad ways. I hope that the work I do impacts people in a good way," she said.

Kher said an actor can't sign a project on the assumption that it will be a hit or not.

"If the film or role excites you, it's about the gut feeling. For me, it is always about trying something new and with 'Agni' it was a different world. The reason I became an actor is that when you grow up, you are often asked, 'What do you want to do?' "I used to never have an answer to it but I would be like, 'I want to be a lawyer, an architect, a doctor'. So, as an actor you get to do that. That's the reason I became an actor as I love living different lives. You get to learn about the life of a firefighter and see what they go through. If the project excites you and (helps) you learn something new, for me that is what it is about." "Agni" will start streaming on Prime Video from December 6. (PTI)

GM Arjun Erigaisi becomes 2nd Indian to breach 2800 ELO rating barrier

NEW DELHI, Dec 1: Grandmaster Arjun Erigaisi on Sunday became the second Indian after legendary Viswanathan Anand and 16th worldwide to reach the gold-standard ELO rating of 2800, while also occupying the fourth spot in the latest rankings.

The 21-year-old has been in sensational form this year, having won an individual gold as well as team title in India's recent historic performance in the Chess Olympiad.

'Arjun Erigaisi has become the 16th player in history to break the 2800 Elo barrier in classical chess ratings!" the world governing body of the sport FIDE said on 'X'.

"ArjunErigaisi joins five-time World Champion Viswanathan Anand as the second Indian to achieve this milestone. In the December 2024 #FIDERating list, his rating stands at 2801, and he is currently ranked #4 in

Earlier this year, this 21-yearold also delivered a stellar performance at the 45th #ChessOlympiad, winning both team gold and individual gold!"

Born in Warangal, Telangana, Erigaisi earned the Grandmaster's title at the age of 14 years, 11 months, 13 days. In September 2024, he became India's top rated player.

Erigaisi now has 2801 rating points for the fourth sport, just below Hikaru Nakamura (2802) of USA. Norwegian Magnus Carlsen continued to be at the top spot with 2831 ratings, followed by Fabiano Caruana (2805) of the USA.

Another Indian chess prodigy, the 18-year-old D Gukesh, who is currently fighting against Ding Liren of China for the World Championships title in Singapore, is one place below Erigaisi at fifth with 2783 ratings. Liren (2728) is at 22nd. (PTI)

SA20 establishing itself as No 2 league, schedule clashes not expected going ahead: Smith

MUMBAI, Dec 1: SA20 has begun establishing itself as the No 2 league in the world and there will be better schedules drawn up to avoid clashes with international cricket for South African players, says league commissioner Graeme Smith.

In order to avoid any clash in schedule which the league faced in the first two editions, the third iteration of the South African T20 league will start a few days after the conclusion of the New Year's Test.

The third season will also feature Dinesh Karthik, who is the first Indian player in the leauge.

"Our ambition, it doesn't sound right to say (that) you want to be the No 2 league in the world, but being realistic, IPL is just incredible. It's a beast. It's been the driving force for a lot of change in the cricketing landscape,' Smith told media on SA20 India Day. "We've been fortunate to attract six franchises from the IPL to work with the BCCI in terms of developing SA20 and learning

from what they've done very well over the years.

"For us, two seasons in, the stats, the viewership, the digital stats, the crowd attendance is all starting to show that we are the No 2 league," he said.

Smith said working closely with Cricket South Africa will avoid situations in the past such as in February this year when seven uncapped players were sent for a Test tour to New Zealand and other frontline players held back for SA20.

"In the beginning, there were some hard choices for Cricket South Africa to make when they were building their league. There's a lot of bilateral cricket that also just comes and goes without context. They needed to make a tough decision to invest in the league and to make the best players available and to make a success of it," he said.

"Now we are going into season 3, we're starting to manage the FTPs better, working with Cricket South Africa in terms of

ICC: Jay Shah takes over as new chairman with eye on ending CT impasse

DUBAI. Dec 1: Indian cricket administrator Jay Shah on Sunday took charge as the chairman of the International Cricket Council (ICC) with an immediate goal of ending the impasse surrounding the Champions Trophy and a broader vision of making cricket a commercially viable Olympic sport.

The 36-year-old Shah, who headlined the BCCI as its secretary for the last five years, is the fifth Indian and the youngest ever to head the global cricket body.

He was the unanimous choice of the ICC's Board of Directors and replaced New Zealand attorney Greg Barclay, who didn't wish to continue for a third consecutive term.

Before Shah, businessman late Jagmohan Dalmiya, politician Sharad Pawar, lawyer Shashank Manohar and industrialist N Srinivasan have all headed the world cricket body.

Shah, the son of India's Home Minister Amit Shah, will have his task cut out as the ICC looks to find an acceptable solution to implement the 'Hybrid Model' for the Champions Trophy originally scheduled in Pak-

As of now, the Pakistan Cricket Board (PCB) has decided to accept the 'Hybrid Model' under which India play their matches in Dubai. But the PCB also wants the same courtesy to be accorded to Pakistan in all four ICC tournaments till 2031, which will be cohosted or singularly hosted by the Indian cricket board.

Now, as the head of the global body and with less than 100 days left for the tournament to begin, Shah will have to co-ordinate with both the PCB and his former colleagues at the BCCI for an "acceptable solution" in order to organise a hassle-free tournament.

India have already refused to travel to Pakistan as it hasn't received clearance from its

Shah didn't make any comment on the Champions Trophy while outlining his prior-



ities for his term which included leveraging the sport's inclusion in the Los Angeles 2028 Olympic Games as an opportunity and further

Having started as an administrator at the district level in Gujarat Cricket Association when he was still a college student, Shah has worked his way up the ladder from state to national and now global level.

It was during his time that Gujarat became a domestic force by winning the Ranji Trophy for the first time and he has also been the man behind the world's largest cricket stadium in Ahmedabad's Motera.

During his tenure as BCCI secretary, the domestic match fees have increased manifold and he has been instrumental in starting Test cricket incentive bonus for national players with emphasis on white-ball game.

However, the two major milestones for him as BCCI secretary are the starting of Women's Premier League and having equal match fees for men and women's national team players.

His young age has allowed him to be more empathetic to current players but he has also been able to crack the whip when necessary, like making it mandatory for stars to play domestic cricket after Shreyas Iyer and Ishan Kishan lost their central contracts for giving more emphasis to IPL compared to Ranji Trophy. He has overwhelming support in the ICC board room save one country and he wouldn't have a lot of problems in taking policy deci-

While it is still not clear who will be the next BCCI secretary, India could be represented at the ICC Board by either current president Roger Binny, or vice-president . Rajiv Shukla.

In case Binny becomes the director from India, Shukla could be the alternate director. And if Shukla is elevated as India's representative, the co-representative could be Arun Dhumal, who is among the two to three names being discussed for the next secretary's post, treasurer Ashish Shelar and joint secretary Devajit Lon Saikia being the others. Sindhu, Lakshya clinch singles titles; Treesa-Gayatri pair shines in doubles



LUCKNOW, Dec 1: Top seeds P V Sindhu and Lakshya Sen produced commanding performances to claim the women's and men's singles titles, respectively. at the Syed Modi International badminton tournament here on Sunday.

Sindhu, a two-time Olympic medallist, ended her long title drought by outplaying China's world number 119 Wu Luo Yu 21-14, 21-16 to lift the trophy for the third time, having previously triumphed in 2017 and 2022.

In the men's singles final, Lakshya, a 2021 World Championships bronze medallist, was at his dominant best as he demolished Singapore's Jia Heng Jason Teh 21-6, 21-7 in the title clash, displaying complete command over the match.

Sindhu's victory marks her return to the top of the podium after over two years, with her last title win being at the Singapore Open in July 2022. The world number 18 also reached the finals of the Malaysia Mas-

ters Super 500 earlier this year. Lakshva's win comes as a balm after a disappointing loss in the bronze medal playoff at the Paris Olympics. The victory will

undoubtedly boost his confidence ahead of the new season.

Indian badminton had more to celebrate on the day as the women's doubles pair of Treesa Jolly and Gayatri Gopichand clinched their maiden Super 300 title with a convincing 21-18, 21-11 win over China's Bao Li Jing and Li Qian.

The result made Treesa and Gayatri the first Indian women's doubles team to win the title at this tournament. The Commonwealth Games bronze medallists, who had finished runners-up in 2022, went one step further this year with their solid perform-

In the men's doubles final, Pruthvi Krishnamurthy Roy and Sai Pratheek K put up a valiant fight before going down 14-21, 21-19, 17-21 to China's Huang Di and Liu Yang in a marathon 71-minute clash.

Meanwhile, in the mixed doubles final, fifth seeds Tanisha Crasto and Dhruv Kapila started strong but couldn't sustain their momentum, losing 21-18, 14-21, 8-21 to Thailand's sixth-seeded pair Dechapol Puavaranukroh and Supissara Paewsampran. (PTI)
