Of the new ministers, Phukan is a four-time MLA from Dibrugarh, Paul is a two-time legislator from Patharkandi, while Rai and Goala are first-time MLAs from Lakhipur and Doom Dooma respectively.

Phukan and Goala represent the Upper Assam tea districts of Dibrugarh and Tinsukia respectively while Paul and Rai are from the two Barak Valley districts of Sribhumi (formerly Karimganj) and Cachar

Tea Welfare and Labour minister Sanjay Kishan, who represents the Tinsukia constituency, resigned from office on Thursday, to pave the way for Goala with both representing the tea tribe community. Kishan has since been appointed

as the chairman of the Assam Food and Civil Supplies department.

Parimal Suklabaidya had resigned from the Himanta Biswa Sarma cabinet after he was elected to the Lok Sabha from Silchar (SC) constituency earlier this year.

All the new ministers thanked the chief minister for including them in his ministry.

They also pledged to serve the people and work for the development of the state.

The ministers are yet to be allocated their portfolios with the chief minister likely to reshuffle and redistribute the departments among the 19 ministers.

Seventy-year-old Phookan is a BJP veteran and has represented Dibrugarh constituency for four consecutive terms since 2006.

Goala, a former student leader, joined the BJP prior to the 2021 assembly elections. The 46-year-old contested and (CONTD. ON PAGE-2)

Innovative, participative diplomacy can help solving conflicts: Jaishankar DOHA (QATAR), Dec 7: External Affairs

Minister S Jaishankar on Saturday called for "more innovative and participative diplomacy" and said the needle is moving towards the reality of negotiations rather than the continuation of the war between Russia and Ukraine

Jaishankar highlighted the increasing cost of oil, fertilisers and shipping etc. for several countries, including India, due to conflicts in the Gulf and the Mediterranean region.

He is visiting Doha to participate in the Doha Forum at the invitation of Prime Minister and Minister of Foreign Affairs of State of Qatar Mohammed bin Abdulrahman. He was addressing a panel along with the Qatari prime minister and Norway's Foreign Minister Espen Barth Eide.

Jaishankar said that diplomats have to tell themselves, it's a messy world. "It's terrible. There are conflicts, but therefore there's all the more reason for diplomats of the world to step forward," he said.

He also said the era of the 60s and the 70s when the UN Security Council or a few Western powers managed conflicts is "behind us,"



adding that all countries need to step forward. "I think this, there is a greater case for more vigorous diplomacy, for more innovative diplomacy, for a more participative diplomacy, and, and I think more countries need to have the boldness to bypass the West," the former diplomat turned minister said

When the anchor asked about India's role in the Russia-Ukraine conflict, Jaishankar said, "The needle is moving more towards the reality of negotiation than the continuation of the war." (CONTD. ON PAGE-2)

# Hotels in Barak Valley not to host B'desh nationals till attacks on Hindus stop

GUWAHATI, Dec 7: Hotels in Barak Valley of Assam have announced they would not host any Bangladesh national till attacks on Hindus and other minorities in the neighbouring country stop.

Barak Valley, which comprises three districts of Cachar, Sribhumi (formerly Karimganj) and Hailakandi, shares a 129-km-long border with Bangladesh's Sylhet region.

president Babul Rai told reporters

"The situation of Hindus and other minorities in Bangladesh is concerning. We cannot accept this in any way. We have, therefore, decided to stop hosting any national from that country in all the three districts of Barak Valley until the situation improves and atrocities on the Hindus stop. This is our form of protest," Barak Valley Hotel and Restaurant Association

"The people of Bangladesh must ensure that stability returns to the country. Only if the situation improves, we can reconsider our decision," he said.

A few days ago, Bajrang Dal had asked organisers of an ongoing global expo in Silchar to close down two stalls selling Bangladeshi products as a protest against atrocities on Hindus in the neighbouring country. Their demand was accepted.

Bajrang Dal protestors had also gone to the Bangladesh Visa Centre in Silchar and demanded that the name 'Bangladesh' be removed from the signboard. There have been widespread

protests in all the three districts of Barak Valley against the alleged atrocities on minorities in Bangladesh and arrest of Hindu monk Chinmaya Krishna Das. (PTI)

"The United States has long been a champion of media freedom around the world. A free and independent press is an essential component of any democracy, enabling informed and constructive debate and holding those in power accountable," the US embassy official said.

Last month, US prosecutors charged Gautam Adani, 62, his nephew Sagar and other defendants for paying over USD 250 million in bribes between 2020 and 2024 to Indian government officials to win solar energy contracts on terms that could potentially bring in more than USD 2 billion in profit. The Adani Group has dismissed the charges as "baseless".

The opposition Congress demanded a thorough investigation into the allegations and accused the government of shielding the businessman. In an unprecedented criticism of the the US State Department, the BJP said on Thursday, "French investigative media group Mediapart revealed that OCCRP is funded by the U.S. State Department's USAID, as well as other deep state figures like George Soros and the Rockefeller Foundation.

"In fact, 50% of OCCRP's funding comes directly from the U.S. State Department. OCCRP, therefore, functions as a media tool for carrying out deep state agendas," the party said in a series of posts on X. "A French investigative journalist has revealed that the US govt controls the media organization OCCRP, dictating that any story it ran was influenced & lacked genuine backing. But what is its connection with Congress?" one of the posts said. (PTI)

#### Reshuffle of ministers' portfolios

Describing how India is walking the talk, by going to Moscow, talking to President Vladimir Putin, going to Kyiv, engaging, President Volodymyr Zelenskyy, transparently carrying messages to each others, Jaishankar said India is trying to find "common threads" which can be picked up at some time.

He also said that India is articulating the sentiments and the interest of the Global South comprising 125 other countries who have found their fuel cost, their food cost, their inflation, their fertiliser costs impacted by this war.

"And, in the last few weeks and months, I've even seen this sentiment expressed by major European leaders, who are actually telling us, please keep engaging Russia and engaging Ukraine. So we do think that things are moving somewhere in that direction," he added.

Jaishankar also spoke about Prime Minister Narendra Modi and US president-elect Donald Trump. Referring to Trump's recent threats to BRICS about imposing 100 per cent tariff if those countries went ahead with BRICS currency, Jaishankar said, "I am not exactly sure what was the trigger for it but we've always said that India has never been for de-dollarisation. Right now, there is no proposal to have a BRICS currency.'

He also explained how countries in BRICS don't have an identical position on the issue. Answering a question if India has a role to play in Russia, China, North Korea and Iran forming an anti-American, anti-westernism axis, Jaishankar said: "Every country has its interests. They agree on some, they disagree on some. Sometimes the same countries work in different combinations in different issues." "The reality is much more complicated, much more granular," he said at the panel discussions as part of the 22nd edition of the Doha Forum on the theme 'The Innovation Imperative.' As per its website, Doha Forum is a global platform for dialogue, bringing together leaders in policy to discuss critical challenges facing the world, and to build innovative and action-driven networks.

Under the banner 'Diplomacy, Dialogue, Diversity', Doha Forum promotes the interchange of ideas and discourse towards policy making and action-oriented recommendations. "In a world where borders are porous, our


#### Govt hiking tax rates for common

12 per cent to 18 per cent," the leader of opposition in the Lok Sabha said. "This is a grave injustice -- taxing the hard-earned money of poor and middle-class families in order to give tax breaks to billionaires and waive their massive debts," he claimed. "Our fight is against this injustice. We will raise our voice strongly against the burden of taxes on the common people and put pressure on the government to stop this 'loot'," the Congress leader added. He also shared a graphic that showed that the government's collection from the Goods and Services Tax (GST) has gone up from ₹ 5.98 lakh crore to ₹ 10.61 lakh crore from 2019 to 2024, while that from the income tax has increased from ₹4.92 lakh crore in 2019 to ₹11.87 lakh crore in 2024 and from the corporate tax from ₹ 5.56 lakh crore to ₹ 10.2 lakh crore in the last five years. Congress general secretary, communications, Jairam Ramesh also hit out at the Bharatiya Janata Partv-led Centre over the state of the country's economy and cited the comments of a senior Reserve Bank of India (RBI) official. He said RBI's deputy governor Michael Patra has summarised the current economic situation very well in an interview. "Dr Patra says the economy is not moving ahead as fast as it should because -- private investment is not picking up; manufacturing growth is sluggish. Earlier in July this year, UltraTech Cement had announced the acquisition of a 32.72 per cent stake in India Cements from promoters and their associates in a ₹ 3,954 deal in a move to expand its footprint in the highly competitive and fast-growing southern cement market, particularly Tamil Nadu.

Besides, it had also announced a ₹ 3,142.35 crore open offer to acquire 26 per cent share of ICL from its shareholders. UltraTech leads the Indian cement market with a consolidated capacity of 156.66 million tonnes per annum (MTPA) of grey cement. It is followed by billionaire Gautam Adani-led Adani Group, which is rapidly pacing up its capacity through acquisitions and capacity expansions. Adani Cement recently announced to acquisition of CK Birla group firm Orient Cement, through

which it will achieve a capacity of 100 MT (million tones) per annum by the end of FY25 and a gain of 2 per cent in the overall market share in the country. (PTI)

All eyes are now on the Congress over its next move as the principal opposition party increasingly finds itself singled out in Parliament on several issues -- protests on Adani and farmers' issues, with many of its partners staying away.

The opposition alliance was formed in June 2023 with the motto of "BJP hatao, desh bachao" ahead of the Lok Sabha polls. But one of its founders, Janata Dal (United) chief Nitish Kumar, has since switched sides and joined hands with the ruling National Democratic Alliance (NDA) led by the Bharatiya Janata Party (BJP). SP's Rajya Sabha MP Javed Ali Khan said his party is still in the Indian National Developmental Inclusive Alliance (INDIA), but admitted that "differences of opinion" exist within the bloc. "We are still a part of the INDIA bloc as we were among the founders. But differences of opinion on some issues among the alliance partners are there," he told PTI. On recent developments within the opposition alliance, Communist Party of India (CPI) general secretary D Raja said Congress president Mallikarjun Kharge is the chairperson of the bloc and he should respond to the issues.

He, however, admitted that the Congress has to be more accommodative towards its partners and should do some "serious introspection". "The Congress will have to do some serious introspection and ponder on why seat sharing was not done properly for Assembly polls, where it lost badly," Raja told PTI. He said all parties have to remain united as the INDIA bloc was formed with the "BJP hatao, desh bachao" slogan and that everyone should work towards that goal. "That is why the Congress must be accommodative to the other parties and should listen to them," the Left leader said, pointing to the poor performance of the grand old party in recent Assembly polls.

JD(U) leader Rajiv Ranjan said, "The INDIA bloc has always been prone to disintegration. Now, it is just a formality so that the effects of its disintegration could be transformed into reality." He said during the Assembly polls in Chhattisgarh, Madhya Pradesh and Rajasthan, the SP expressed its surprise at the Congress's stand. "This alliance was visible on only papers but now, it will not even exist there," the JD(U) leader said after the SP announced that it is walking out of the MVA. BJP leader C R Kesavan termed the INDIA bloc "opportunistic" and said, "The INDI bloc is a divided house of hypocrisy. The bitter bickering among them, which is now in the open, is because the INDI bloc feels that Rahul Gandhi's failed leadership is the reason for its repeated failure in elections." On Banerjee's "ready to lead the INDIA bloc" remark, Rashtriya Janata Dal (RJD) spokesperson Mrityunjay Tiwari said the leaders of all the constituents of the opposition alliance will decide who would lead them. "Mamata Banerjee is a strong pillar in the fight against the BJP-led NDA government. Various leaders are leading from the front in their respective states." he said.

SP leader Abu Asim Azmi said, "The MVA never respected us.... Uddhav Thackeray and his party had said they will leave communalism and join hands with secular forces. However, he and his party have once again hailed those who demolished the Babri masjid. The Samajwadi Party can never stay with those who want to divide people on the basis of religion." "We were never called for the coordination meeting of the MVA. We wanted coordination like it was during the Lok Sabha polls. But the Congress, Shiv Sena (UBT) and NCP (SP) kept fighting with each other over seat sharing. That is why we (MVA) lost (the Maharashtra election)," Azmi, who heads the SP's Maharashtra unit, added. The INDIA bloc's first meeting in Patna was hosted by Nitish Kumar. (PTI)


### Farmers seek low taxes, doubling PM-KISAN amount in pre-budget meet with FM

NEW DELHI, Dec 7: Farmer representatives and agricultural stakeholders urged the government to provide cheaper long-term credit, implement lower taxes, and double the PM-KISAN income support during a comprehensive pre-budget consultation with Finance Minister Nirmala Sitharaman on Saturday.

The two-hour meeting saw a detailed discussion of proposals, aimed at addressing multiple challenges in the agricultural sector, with key demands focusing on financial relief, market reforms, and strategic investments.

Bharat Krishak Samaj Chairman Ajay Vir Jakhar emphasised the need for targeted interventions to boost agricultural productivity and farmer welfare.

Primary demands included reducing interest rates on agricultural loans to as low as 1 per cent and increasing the annual PM-KISAN instalment from ₹ 6,000 to ₹ 12,000. Farmers' bodies also strongly advocated for zero-premium crop insurance for small farmers under the Pradhan Mantri Fasal Bima Yojana



Taxation reforms were a critical component of the proposals, with stakeholders calling for GST exemptions on agricultural machinery, fertilisers, seeds, and medicines. PHD Chambers of Commerce and Industry requested a reduction of pesticide GST from

18 per cent to 5 per cent. Jakhar proposed a targeted investment strategy of ₹ 1,000 crore annually for eight years, focusing on specific crops like chickpeas,

soybean, and mustard to enhance national agricultural productivity. This approach aims to strategically enhance crop yields, reduce import dependence, and improve national nutritional security, he

told PTI after the meeting. Bhartiya Kisan Union (BKU) Speaker Dharmendra Malik demanded a comprehensive review of the Minimum Support Price (MSP) mechanism, seeking calculations that include land rent, farm

wages, and post-harvest expenses. He also demanded the display of agricultural machinery prices on company websites, improvement in mandi infrastructure, widening MSP coverage beyond 23 commodities, disallowing imports below MSP levels and fixing minimum export prices only in emergencies. PHD Chambers of Commerce and Industry Chairman (Agribusiness committee) RG Agarwal called for a reduction in GST on pesticides from 18 per cent to five per cent, while highlighting the need to curb the sale of smuggled and fake pesticides while ensuring data protection for new molecular developments.

More ambitious proposals included constitutional reforms, such as adding agriculture to the Concurrent List and establishing a central Indian Agricultural Service.

Minister of State for Finance Pankaj Chaudhary and senior officials from finance and agriculture ministries attended the meeting, which included representatives from farmer producer companies, agricultural associations, and corporate sectors. (PTI)

# Governor launches statewide 100-Day TB elimination campaign

HT Bureau GUWAHATI, Dec 7: Reaffirming Assam's commitment to eradicating TB by 2025 in alignment with Prime Minister's vision, Assam Governor Lakshman Prasad Acharya, launched the 100-day intensified campaign on TB elimination at the GMCH auditorium on Saturday.

It may be noted that to tackle TB with an aim to completely eliminate it from the country, a special 100 day campaign has started on Saturday with a focus on the high burden TB districts. Along with better drugs and diagnosis, patient support amount has also been doubled under the programme.

The 100-day campaign will target 17 high-priority districts in Assam and includes activities such as high burden area mapping, identification of vulnerable populations in tea gardens, slums, and mining areas, extensive screening campaigns (Nikshay Shibirs), and promoting Jan Bhaghidari (public participation) to mobilize resources and raise awareness.

Speaking on the occasion, Governor Acharya highlighted the socio economic burden of TB, which predominantly affects the poorer sections of society. He stressed on the importance of community driven efforts in making the implementation of the National Tuberculosis Elimination Pro-

Stating the state's achievements with regard to TB treatment, the Governor said that the patients who have been treated successfully with TB germs will act as TB Champions during this campaign. He also highlighted Assam's inno-



GUWAHATI, Dec 7: The Minister of Agriculture, Agricultural Education, and Agricultural Research Surya Pratap Shahi on Saturday participated in a grand roadshow in Dispur, extending an invitation to the people of the state to participate in the Prayagraj Mahakumbh-2025.

Speaking on the occasion, Shahi said, "The state government is extending invitations for Mahakumbh-2025, the grand festival of Sanatan Indians, to all states across India and the entire world.'

"The Mahakumbh embodies the spirit of India's cultural and spiritual consciousness and is a divine and vibrant representation of 'Ek Bharat- Shreshth Bharat-Samaveshi Bharat' (One India, Great India, Inclusive India)," he further stated while addressing the media after the roadshow.

During the press conference, the agriculture minister reminded, "Many of you may have witnessed the 'divine and grand' experience of the Prayagraj Kumbh in 2019, which became an indelible symbol of India's cultural pride on the global stage. The world widely acknowledged the efficient management of the event.'

He highlighted that special emphasis has



been placed on making Mahakumbh Mela 2025 clean and green. Approximately three lakh plants have been cultivated across Prayagraj, with the Uttar Pradesh government pledging to ensure their care and maintenance even after the conclusion of the Mela

Ayurvedic and Unani specialists, and 182 nursing staff."

The preparations include the launch of a dedicated website and app, an AI-powered chatbot in 11 languages, QR-based passes for people and vehicles, a multilingual digital lost-and-found centre, and integration of all locations on Google Maps.

Further to streamline the traffic flow during the event, 101 smart parking facilities have been created, capable of accommodating up to five lakh vehicles daily. The parking area spans 1,867.04 hectares, which is 763.75 hectares larger compared to the 1,103.29 hectares allocated for parking in 2019.

During the press conference, Shahi provided details about the arrangements for the Mahakumbh. He informed, "35 existing permanent ghats and 9 new ghats have been constructed in the Mahakumbh city to facilitate bathing for devotees.'

He further mentioned that a riverfront, modelled after Mumbai's Marine Drive, has been developed along a 15.25-kilometer stretch on the banks of the Ganges, extending from the Sangam to Nagvasuki Temple, Surdas to Chhatnag, and near Curzon Bridge to Mahavir Puri.

Shahi informed that the preparations for the Mahakumbh Mela are being made with a focus on health and hygiene. He said, "A large number of specialist doctors have been deployed. A 100-bed hospital has been set up at the Parade Ground. In total, there will be 291 MBBS doctors and specialists, 90

#### Editor's pick ATACMS: A little too late for Ukraine?

The Biden administration has finally relented to Kyiv's long-pending demand from its Western allies to use the long-range Army Tactical Missile System (ATACMS). Washington's permission to use the ATACMS by Kyiv comes against the backdrop of North Korea deploying 10,000 troops in support of Russia to fight Ukrainian forces. The latest ATACMS are long-range guided missiles with a range of 300 kilometres (km) that can strike deep inside Russian territory. These missiles were already delivered in April this year, but approval for their use was only given over the last few days. A medium-range variant of the ATACMS was delivered at the end of 2023. The Biden administration's decision to lift restrictions on the supply of these missiles comes alongside several other restrictions on Kyiv's use of weapons systems being lifted. These weapons systems or platforms include the F-16s, M1-Abrams, High Mobility Rocket Systems (HI-MARS), and Patriot missiles. The employment of ATACMS was earlier confined to Ukrainian territory. The United States (US) under the Biden administration consistently opposed supplying weapons systems because it deemed their battlefield use too escalatory. Indeed, the US's fear of escalation has been the prime reason for Ukrainians fighting this war with one hand tied behind their backs. The outcome has left the Ukrainians suffering setbacks, enabling Russian advances and incremental territorial gains inside Ukraine. It has also left the Ukrainian cities and infrastructure reeling from incessant Russian bombardment. The ATACMS, however, are very versatile and can be launched from

an equally versatile platform, the HIMAR launch platform, which is also a distinct missile launch system that was already in use prior to the latest decision by the Biden administration. The HIMAR launch platform is manoeuvrable just like the ATACMS projectile is. The speed and manoeuvrability of the ATACMS as well as the manoeuvrability of the HIMAR platform from which they will be launched makes it very difficult for Russian air defence missiles to intercept and target them. The ATACMS will bring great benefits to the Ukrainians if used effectively, by helping Kyiv destroy Russian command and control centres, air defence systems, air bases, weapons depots or storage facilities, communication facilities and large military installations. The Black Sea area in southern Russia adjoining Ukraine would be subject to considerable bombardment by the ATACMS. Consequently, the ATACMS are intended ultimately to improve and strengthen the bargaining position of the Ukrainians when negotiations begin between Kyiv and Moscow. Despite the Biden administration giving a go-ahead for the use of AT-ACMS by Kyiv, their use is restricted to the Kursk region where there is a large combined and concentrated deployment of Russian and North Korean troops. Still, the Ukrainians will also benefit from cruise missile capabilities developed as part of an Anglo-French collaboration called the Storm Shadows (British) and SCALP (French). As opposed to the ATACMS, these cruise missiles have a shorter range of 155 miles and are launched from an airborne platform. Despite being developed by America's North Atlantic Treaty Organization (NATO) allies, their use was permitted only after Washington lifted its own restrictions on the use of the ATACMS. Washington's veto as the largest funder has meant that even its trans-Atlantic allies are prohibited from supplying weapon systems and missiles to Kyiv that were not built by the US. Nevertheless, despite their delayed delivery and approval for use, these missile systems and their platforms can inflict great damage and strike Russian targets at extended ranges, forcing Moscow to relocate its assets such as planes, ammunition storage facilities, and command centres deep inside Russian territory. Compelling Moscow to come to the negotiation table for a peace settlement is a vital goal, which the incoming President, Donald Trump, has alluded to.

Russia has predictably reacted with menacing threats that it will not tolerate Western long-range weapons being used by the Ukrainians. However, these threats from Moscow have not prevented the US-led NATO states from supplying and permitting Kyiv's limited use to strike Russia over the course of nearly three years. In fact, Ukraine used AT-ACMS to strike the Bryansk region of Russia immediately after the goahead by the US, suggesting that training and deployment were already underway. Russia has downplayed its significance.

At the tactical level, the decision may not impact the immediate military balance in the conflict between Russia and Ukraine and is unlikely to deter Russia from its coming offensive in the Kursk region to oust the Ukrainian forces. The decision may also be a little too late, given some concerns in the US that the ATACM stockpile may be low. The Biden administration's decision to allow Ukraine to use ATACMS coincided with Russia's announcement of a new nuclear doctrine. lowering the threshold for nuclear

es, goods days are in the offing for the Northeast tourism industry. The reason is not far to seek. The Central Government is currently pumping funds for boosting the NE tourism sector. Meanwhile, Prime Minister Narendra Modi has echoed that 'Ashtalakshmi' (eight NE states) will become the tourism hub soon.

Discussing the second form of Goddess Lakshmi - Dhan Lakshmi, Modiji said that the Northeast was blessed with abundant natural resources with a great confluence of minerals, oil, tea gardens and biodiversity.

To him, there is a huge potential of renewable energy and this blessing of "Dhan Lakshmi" was a boon for the entire Northeast. He was speaking at the first Ashtalakshmi Festival in New Delhi on December 6, 2024.

Ashtalakshmi Mahotsav is a threeday cultural festival, being celebrated for the first time from 6th to 8th December at Bharat Mandapam in New Delhi. It highlights the vast cultural tapestry of Northeast India, bringing together an array of traditional arts, crafts, and cultural practices.

Geographically, Northeast India (NEI) is regarded as the cradle of many castes, communities, cultural ethos and faiths. Tucked away in a 'strategic region', linked with the national mainstream by a narrow corridor called the "Chicken's Neck" via Siliguri in West Bengal, those who once visited the region can never forget this paradise on the planet Earth. The region is home to 3.8% of the national population and occupies about 8% of India's total geographical area. Siliguri corridor, a narrow strip of land in West Bengal, popularly known as "chicken's neck" connects this region to the rest of mainland India.

Good news. In a significant development, the Centre has approved ₹ 800 crore for the development of eight iconic tourist sites across six Northeastern states recently. The projects spread across Meghalaya, Assam, Arunachal Pradesh, Manipur, Sikkim, and Tripura, were sanctioned by the Department of Expenditure (DoE), Government of India in the last week of November, 2024. The DoE has released 66 per cent of the approved funds as the first instalment directly to the respective states, with the Ministry of Tourism tasked with monitoring progress. The states have been given a two-year timeline for project completion, with the full funds set to be disbursed by March 2026.

Among the approved projects are the Nathula Border in Sikkim (₹ 97.37 crore), 51 Shakti Peethas Park in Tripura's Gomati district (₹ 97.7 crore), Loktak Lake in Manipur (₹ 89.48 crore), Umiam Lake Development in Meghalaya's Shillong (₹ 99.27 crore), Assam State Zoo in Guwahati (₹ 97.12 crore), and the Siang Eco-Retreat in Arunachal Pradesh's Pasighat (₹ 46.48 crore). These initiatives are part of a broader scheme under which the Centre has approved 40 projects worth ₹ 3,295 crore across 23 states to ensure a more balanced distribution of tourists nation-

selected for development under the central government's Swadesh Darshan 2.0 Scheme on November 24, 2023. These include one from Manipur and two each from the seven other states in the northeast. The move aims to not only boost tourism in the eight states but also help in further development in the region. NE states, some of which share borders with


other countries, are known for their pristine beauty, blessed with majestic hills, scenic waterfalls, criss-crossing rivers and adventurous

treks, and many of these sites have not been explored by domestic tourists.

Union Minister of Tourism and Culture Gajendra Singh Shekhawat inaugurated 12th Edition of International Tourism Mart at Kaziranga, Assam on November 26, 2024. He highlighted the rich cultural legacy and tourism potential of the Northeast. The tourism mart is organised annually to showcase Northeast's potential with a focus on promoting Sustainable Tourism. This ITM is a remarkable opportunity for Northeast India to showcase its rich culture and diversity to the world and also offers a platform for people from across the globe to witness the extraordinary heritage of this region.

A coffee table book on Assam "Guwahati and Around" published by Assam Tourism Development Corporation Limited was also launched. The book takes a comprehensive look at the rich heritage, culture and diversity of Guwahati and its picturesque surroundings. The book is a visual tapestry in words capturing the true essence of the region.

This ITM celebrated multiple achievements of Northeast India's tourism & cultural prowess. In July this year, 'Moidams of Charaideo' were declared as the 43rd UNESCO World Heritage Site from India. As cultural heritage from the times of the great Ahom dynasty, their declaration as World Heritage is a testament to the immense

example. In October 2020, the E-commerce giant Flipkart was slammed on social media for calling Nagaland not a part of India. The Flipkart was trolled after it had told a customer in Dimapur (Nagaland) that it did not deliver goods outside India. So, the Flipkart customer support on Facebook was scathingly criticised after it had told the customer that 'it doesn't deliver outside India'. However, later on, the company realised the mistake and apologised.

So, the Centre may formulate a goal-driven comprehensive plan to promote religious sites of NER in the International Tourism Mart for Northeast in 2025. # Cities grappling with vehicle parking problems

Tehicle parking problems in India are significant urban challenges that affect not only traffic flow but also the very fabric of urban life. The problem arises from a combination of rapid urbanization, rising vehicle ownership. and outdated urban planning, creating a complex dilemma for traffic management, urban planning, and quality of life in metropolitan areas. As cities expand and car ownership becomes more accessible. Indian urban centers are struggling to accommodate the growing number of vehicles. Lack of adequate parking infrastructure and cities not designed for the number of vehicles today lead to rampant illegal parking. This not only leads to road congestion but also to a shortage of pedestrian space. Many Indian cities were founded in ancient or colonial times but were not planned with modern traffic demands in mind. Narrow streets and mixed land use put pressure on the load of parked and moving vehicles. Additionally, lax enforcement of parking rules and a cultural tendency towards non-compliance further aggravate the situation, leaving urban spaces cluttered.

A direct consequence of parking problems is severe traffic congestion, which increases travel time, increases pollution levels, and degrades the quality of urban life. Pedestrians are particularly inconvenienced, as parked vehicles often encroach on pedestrian paths, forcing them onto the streets and comtheir promising safety. Economically, lack of parking affects local businesses, as congested streets do not attract customers. The high demand for parking spaces also increases the cost of real estate. which in turn promotes urban sprawl and environmental degradation by promoting the development of parking infrastructure at the expense of green spaces. Motor vehi-

cle matters in India fall under both the central and state jurisdictions. Although vehicle congestion is an emerging problem for Indian cities, the automobile industry is unlikely to be banned, as it has considerable economic and employment potential and is vital to India. The parking policies of all five cities seem to agree on some important aspects. They are unanimous in their view that parking cannot be free, and wherever public space is used, a fee must be levied, as the concept of

'free parking' is not sustainable. Addressing the parking problem requires a comprehensive strategy that includes the development of adequate parking infrastructure, the adoption of smart parking technologies, and the enforcement of parking regulations. For example, defining parking areas and using technology such as vehicle identification sensors and automatic license plate recognition can streamline parking management. In addition, adjusting parking fees based on land value and congestion can discourage unnecessary vehicle use in congested areas. In addition to infrastructure solutions. promoting public transport and sustainable urban mobility practices can reduce parking pressure. Encouraging the use of public transport, cycling, and walking can reduce reliance on private vehicles, thereby reducing demand for parking spaces.

Vehicle parking problems in India are a complex issue that requires a multi-pronged approach, including urban planning, policy reforms, technological innovations, and cultural change. By tackling this challenge head-on, India can enhance its urban mobility, improve the quality of life of its citizens, and set an example for sustainable urban development. The way forward lies in collaborative efforts between the government, the private sector, and the public to reimagine and rebuild better urban spaces. Celebrations are also Bangladesh's turning point: Secularism to Islamic Nationalism and the regional implications

he political upheaval that led to the ouster of Sheikh Hasina Wazeds Awami League government in Bangladesh on August 5 this year has sparked a significant transformation, but the nature of this change remains a matter of intense debate. The first few months following the governments fall left many observers in India and the West uncertain about the direction the country would take. At first glance, it appeared to be a familiar, military-driven change of government, one that would result in superficial shifts within the upper echelons of power without altering the fundamental political landscape. This interpretation was particularly popular among sections of Dhakas elite, who sought to downplay the significance of the upheaval and framed it as a reaction to the excesses of the Wazed administration. They suggested that the new government would prioritize stabilizing the country and restoring the status quo, but with more authoritarian undertones. However, this initial reading of

events overlooked deeper currents in Bangladeshs political history. The alternative, more widely accepted by retired diplomats and political analysts, is that what unfolded was a genuine regime change-a dramatic shift in the ideological direction of the country. This argument is rooted in the complex and often tumultuous political trajectory of Bangladesh since its independence in 1971. For much of the countrys history, two ideological strands have dominated: one centered around the legacy of the Liberation War and its secular ideals, championed by

the Awami League and its found-ing leader, Sheikh Mujibur Rahman; the other, а counter-revolutionary narrative, which emerged after the assassination of Sheikh Mujibur Rahman in 1975 and the rise of military dictatorships. The Bangladesh Nationalist Party (BNP), formed by Ziaur Rahman, became the main proponent of this counter-revolutionary ideology, aligning itself with Islamist parties, some of which had opposed Bangladeshs secession from Pakistan.

The fall of the Awami League government in August 2024 cannot be fully understood without considering the historical context of ideological divisions. these Throughout her tenure, Sheikh Hasina Wazed maintained a fierce commitment to secularism and the legacy of the 1971 Liberation War. Her governments prosecution of war criminals, particularly leaders of the Jamaat-e-Islami, and its focus on eradicating the influence of Islamists in politics, reinforced the secular vision of Bangladesh. The Awami Leagues approach was also marked by a determination to uphold the memory of Sheikh Mujibur Rahman as the father of the nation, a legacy that sharply contradicted the narrative pushed by Islamist factions.

However, in the wake of the August 2024 upheaval, the dominant political forces in Bangladesh seem to be shifting away from this secular, Liberation War-inspired vision. The new government, backed by the BNP and Jamaat-e-Islami, has unleashed a brutal political cleansing targeting the Awami League and its supporters. Criminal cases have been filed against nearly 194,000 members of the Awami League, and the prop-

erties of its leaders have been destroyed. The most symbolic target of this political purge has been the monuments to Sheikh Mujibur Rahman, which have been defaced or demolished, signaling a direct challenge to the secular nationalism that once defined the nation. While the student movement has been at the forefront of this political upheaval, it is clear that the regime change has the full support of the BNP and Jamaat-e-Islami, which have long been associated with the counter-revolutionary forces in Bangladesh. The questions surrounding which political faction—whether the Razakar lobby or the softer Islamists within the BNP-has gained the upper hand remain unresolved. However, it is evident that the forces aligned with the legacy of the 1971 Liberation War have been decisively defeated. The counter-revolution has triumphed, and with it, the revival of a vision of Bangladesh as an Is-

This revival of Islamic nationalism has also had serious implications for Bangladeshs minority communities, particularly Hindus. Since the creation of Pakistan in 1947, there has been a systematic attempt to marginalize and push out the Hindu population from East Pakistan, and later Bangladesh, as part of an ongoing effort to solidify the countrys Islamic identity. The 1971 war, which saw a massive exodus of Hindus to India, only exacerbated the situation. Though the formation of Bangladesh brought some relief to the Hindu community, the 1990s saw another wave of migration to India due to continued persecution. Today, Hindus make up just 7.95% of the population, a dramatic decline from their share at

the time of independence. Under the new government, attacks on Hindu religious institutions have become more frequent, and the persecution of Hindus is being framed as a response to the perceived over-assertion of the Hindu community in the 15 years of Awami League rule. The assault on Hindu religious sites, including the ISKCON temples, is seen as a proxy attack on India, which supporters of the regime accuse of exploiting Bangladeshs resources. This targeting of Hindus has led to protests from Hindu organizations across the globe, with many voicing their condemnation of the new regimes actions. Despite the Modi governments strong response to these attacks, Indias policy toward Bangladesh remains cautious. The closure of the border and the halt on visa issuance have effectively stopped the flow of Hindu refugees into India, leaving them trapped in

political environment. For India, the situation in Bangladesh presents a strategic conundrum. The growing influence of radical Islamism in its eastern neighbour poses a direct threat to the security and stability of Indias own Muslim-majority states, particularly West Bengal. A radicalized Bangladesh could embolden extremist elements within India, exacerbating existing communal tensions. The rise of radical Islamism in Bangladesh could also complicate Indias long-standing efforts to maintain a peaceful and cooperative relationship with its neighbor. The reality of a hostile regime on Indias eastern border is one that New Delhi cannot afford

Bangladeshs increasingly hostile

to ignore. The longer the situation persists, the more it will tilt the strategic balance in favor of Bangladeshs Islamist factions, further complicating Indias security outlook.

Indias response to this crisis will need to be measured but firm. While economic sanctions or an economic blockade may not be politically viable, New Delhi must explore other avenues to counter the growing influence of radical Islam in Bangladesh. This could involve diplomatic pressure, closer cooperation with international organizations, and support for Bangladeshs secular forces, including the Hindu minority com-However, munity. the geopolitical realities of the situation suggest that India will need to be more proactive in addressing the ideological shift in Bangladesh and its implications for regional security.

The regime change Bangladesh marks a pivotal moment in the countrys history. The rise of radical Islamism and the revival of an Islamic Republic in Bangladesh represent a dramatic departure from the secular ideals that shaped the nations independence and identity. This shift has profound implications not only for Bangladesh but also for its neighbors, particularly India. The growing influence of Islamists in Bangladesh presents a significant challenge to regional stability, and India must tread carefully as it navigates this increasingly complex geopolitical landscape. # Adapting to the digital battlefield of the 'caliphate' warriors

n a world where digital landscapes have become the new battlegrounds, the forces of terrorism are constantly evolving, finding ways to adapt and persevere against tightening restrictions. While traditional battlefields may have been replaced with keyboards and screens, the ideologies and motivations of extremist groups remain as potent as ever. Cybercriminals exploit vulnerabilities in digital infrastructures, causing financial. political, and social disruptions. In response, nation-States are compelled to reassess traditional security protocols to confront the growing sophistication of cyber threats.

These advancements pose considerable challenges to counterterrorism efforts, enabling the rapid and targeted dissemina-

reach of extremist content, such as that found in Voice of Khurasan, highlight the persistent threat posed by digital extremism. It is assessed that the presence of a virtual caliphate has given wider reach to individuals towards groups like IS, especially through platforms like Rocket.Chat and Telegram. Such assessment underscores the effectiveness of ISKP's digital strategies, which continue to resonate globally despite monitoring and enforcement efforts. The ability of such content to circulate widely demonstrates the adaptability of extremist groups in leveraging technology to maintain relevance and evade detection.

The problem, however, is not just the scale of dissemination but the technological sophistication underpinning it. Magazines like Voice of Khurasan demonstrate the seamless integration of emerging technologies such as AI and cryptocurrency to further extremist agendas. These tools enable the creation of highly targeted propaganda, automated counternarratives, and financial anonymity, making traditional counterterrorism measures increasingly insufficient.

Experts in counterterrorism and cybersecurity emphasise the need for innovative and collaborative approaches to counter these threats. Dr Hany Farid, a leading digital forensics expert, points out that integrating cryptocurrency and AI into propaganda systems underscores the need for real-time interventions and collaboration between governments and tech companies. This observation underscores the dual need for rapid detection mechanisms and public-private partnerships to disrupt the flow of extremist content and funding.

Dr Gabriel Weimann, a professor at the University of Haifa, echoes the sentiment,

# the World Wide Web

he internet is one of the most transformative inventions in human history, an innovation that has reshaped how we communicate, work, learn, and live. Its story is one of collaboration, discovery, and

One of the internet's most transformative features has been its ability to adapt and grow. Technologies like Wi-Fi, developed in the 1990s and based on research into detecting black holes, freed users from the constraints of physical connections. Mobile internet, powered by smart-

fice of Scientific Research and Development head Vannevar Bush in an article entitled "As We May Think", published in the Atlantic Monthly in 1945.

The memex would help us access all knowledge, instantaneously and from our desks. It had a searchable index, and documents were linked together by the "trails" made by users when they associated one document with another. Bush imagined the memex using microfiche and photography, but conceptually it was almost the modern internet.

The true value in this early idea was the links: if you wanted to explore more, there was an easy, builtin way to do that. Anyone who has spent hours following random links on Wikipedia and learning about things they never knew interested them will recognise this value. (There is of course a Wikipedia page about this phenomenon.)

Links have made the web what it is. But as social media platforms, generative AI tools and even search engines are trying harder to keep users on their site or app, the humble link is starting to look like an endangered species.

The laws of links

Modern search engines were developed in the shadow of the memex, but at first they faced unexpected legal issues. In the early days of the internet, it was not clear whether "crawling" web pages to ingest them into a search engine index was a violation of copyright.

It was also not clear whether, in linking to informa-

tion that might help someone build a bomb, defraud someone, or carry out some other nefarious activity, search engines or website hosts were "publishers". Being publishers would make them legally liable for content they hosted or linked to.

The issue of web crawling has been dealt with by a combination of fair use, country-specific exemptions for crawling, and the "safe harbour" provisions of the US Digital Millenium Copyright Act. These permit web crawling as long as the search engines do not alter the original work, link to it, only use it for a relatively short term, and don't profit from the original content.

This doesn't mean the internet is a complete Wild West, though. Section 230 has been successfully challenged on the basis of illegal discrimination, when a mandatory questionnaire about housing asked for race. Is the sidelining of links a good thing, though? Many experts argue not. Using content without credit is arguably copyright infringement. Replacing artists and writers with AI reduces creativity in society.

Summarising information, without linking out to original sources, reduces people's ability to fact check, is prone to bias, and may reduce the learning, thought and creativity supported by browsing many documents. After all, Wikipedia would be no fun without the rabbit hole, and the internet without links is just an

to humanity's desire to connect and share information. The seeds of the internet were planted long before it became a

household term. In the early 1960s, a group of visionary scientists imagined a world where computers could talk to one another. One of these pioneers, J.C.R. Licklider, dreamed of an "Intergalactic Computer Network," a system where users could access data and programs from any site, regardless of location. While this idea seemed like science fiction

at the time, it inspired a generation of computer scientists to think beyond the limitations of individual machines. The first concrete step toward this

vision came with ARPANET, developed in 1969 by the U.S. Department of Defense's Advanced Research Projects Agency (ARPA). Designed to connect researchers and share computing resources, ARPANET was a groundbreaking experiment in networked communication. The first message sent over ARPANET, from UCLA to Stanford, was a simple word: "LOGIN." However, as often happens with new technology, things didn't go entirely as planned. The system crashed after just the first two letters, sending only "LO." Despite this hiccup, it was a historic moment—the birth of networked computing.

As ARPANET grew, so did the possibilities for communication. Email. one of the earliest and most transformative applications of the network, was invented in 1971 by Ray Tomlinson. While it may seem unremarkable today, the idea of sending messages instantly between computers was revolutionary at the time. Tomlinson's choice to use the "@" symbol to separate usernames from computer names created a standard format that

has endured for decades. Email quickly became ARPANET's most popular feature, hinting at the internet's future as a communication powerhouse.

Meanwhile, the network continued to evolve. Throughout the 1970s, researchers developed the protocols that would form the backbone of the internet. Vinton Cerf and Robert Kahn, often called the "fathers of the internet," introduced TCP/IP (Transmis-Control Protocol/Internet sion

(DNS) in 1983, which replaced the cumbersome system of numerical IP addresses with human-readable names like ".com" and ".org." This change made it easier for people to navigate the growing network. Around the same time, the first domain name, Symbolics.com, was registered in 1985, marking the start of the internet's commercial era.

While the internet was becoming more sophisticated, it was still primarily used by researchers and government agencies. That changed dramatically in 1989 when a British computer scientist named Tim Berners-Lee invented the World Wide Web. Working at CERN, the European physics research center, Berners-Lee developed a system for linking documents using hypertext, enabling users to navigate between pages with a simple click. His creation, the web. was introduced to the public in 1991. The first website, hosted on Berners-Lee's computer, was a guide explaining how the web worked. While modest by today's standards, this was the beginning of a revolution.

The web's simplicity and accessibility fueled its rapid adoption. By the mid-1990s, the internet was no longer just for academics or government agencies: it was becoming a tool for everyday people. The launch of userfriendly web browsers like Mosaic and later Netscape made it easy for anyone with a computer and a modem to explore this new frontier. Businesses began to recognize the internet's potential, and the dot-com boom of the late 1990s saw a surge of investment in internet-based companies. While many of these startups failed during the dot-com bust in 2000, the era solidified the internet's role as an essential part of the global economy

The internet wasn't just about browsing websites and shopping online. It was also a platform for creativity, community, and innovation. # Prez Yoon's impeachment fails as his ruling party boycotts vote

SEOUL, Dec 7: A South Korean legislative push to impeach President Yoon Suk Yeol over his shortlived imposition of martial law fell through on Saturday after most lawmakers from his conservative governing party boycotted the vote.

The defeat of the motion is expected to intensify public protests calling for Yoon's ouster and deepen political chaos in South Korea, with a survey suggesting a majority of South Koreans support the president's impeachment.

Yoon's martial law declaration drew criticism from his own ruling conservative party, but it is also determined to oppose Yoon's impeachment apparently because it fears losing the presidency to liberals.

Impeaching Yoon required support from two-thirds of the National Assembly, or 200 of its 300 members. The opposition parties who brought the impeachment motion had 192 seats, but only three lawmakers from PPP participated in the vote. The motion was scrapped without ballot counting because the number of votes didn't reach 200.

National Assembly Speaker Woo Won Shik called the result very regrettable and an embarrassdemocracy that has been closely watched by the world The failure to hold a qualified

vote on this matter means we were not even able to exercise the democratic procedure of deciding on a critical national issue, he said. Opposition parties could submit

a new impeachment motion after a new parliamentary session opens next Wednesday.

There are worries that Yoon won't be able to serve out his remaining 2 years in office because his leadership took a huge hit. Many experts say some ruling party lawmakers could eventually join opposition parties' efforts to impeach Yoon if public demands for it grow further.

If Yoon is impeached, his powers will be suspended until the Constitutional Court decides whether to remove him from office. If he is removed, an election to replace him must take place within 60 days.

Woo repeatedly urged ruling party members to return to the chamber to participate in the vote, waiting several hours for them to come.

At one point, Democratic Party leaders visited a hall on the floor below the main chamber where PPP lawmakers were gathered, ating moment for the country's tempting to persuade them to vote.



After being blocked from entering, they angrily accused the conservatives' leadership of preventing its lawmakers from voting freely. Earlier Saturday, Yoon issued a

public apology over the martial law decree, saying he won't shirk legal or political responsibility for the declaration and promising not to make another attempt to impose martial law. He said would leave it to his party to chart a course through the country's political turmoil, including matters related to my term in office.

The declaration of this martial law was made out of my desperation. But in the course of its implementation, it caused anxiety and

inconveniences to the public. I feel very sorry over that and truly apologise to the people who must have been shocked a lot, Yoon said.

Since taking office in 2022, Yoon has struggled to push his agenda through an opposition-controlled parliament and grappled with low approval ratings amid scandals involving himself and his wife

In his martial law announcement on Tuesday night, Yoon called parliament a den of criminals bogging down state affairs and vowed to eliminate shameless North Korea followers and anti-state forces

Yoon's bizarre and poorly-thoughtout stunt has paralysed South Korean politics and sparked alarm among key diplomatic partners like the US and Japan.

Tuesday night saw special forces troops encircling the parliament building and army helicopters hovering over it, but the military withdrew after the National Assembly unanimously voted to overturn the decree, forcing Yoon to lift it before daybreak Wednesday.

The declaration of martial law was the first of its kind in more than 40 years in South Korea. Eighteen lawmakers from the ruling party voted to reject Yoon's martial law decree along with opposition lawmakers.

Yoon's speech fuelled speculation that he and his party may push for a constitutional amendment to shorten his term, instead of accepting impeachment, as a way to ease public anger over the marital law and facilitate Yoon's early exit from office.

Lee Jae-myung, the leader of the main liberal opposition Democratic Party, told reporters that Yoon's speech was greatly disappointing and that the only way forward is his immediate resignation or impeachment. His party called Yoon's martial law unconstitu-

tional, illegal rebellion or coup. The passage of Yoon's impeachment motion appeared more likely Friday when the chair of Yoon's party called for his removal on Friday, but the party remained formally opposed to impeachment. On Saturday, tens of thousands of people densely packed several blocks of roads leading up to the National Assembly, waving banners, shouting slogans and dancing and singing along to K-pop songs with lyrics changed to call for Yoon's ouster. Protesters also gathered in front of PPP's headquarters

near the Assembly, angrily shouting for its lawmakers to vote to impeach Yoon. A smaller crowd of Yoon's supporters, which still seemed to be in

the thousands, rallied in separate streets in Seoul, decrying the impeachment attempt they saw as unconstitutional.

Lawmakers on Saturday first voted on a bill appointing a special prosecutor to investigate stock price manipulation allegations surrounding Yoon's wife. Some lawmakers from Yoon's party were seen leaving the hall after that vote, triggering angry shouts from opposition lawmakers.

On Friday, PPP chair Han Donghun, who criticised Yoon's martial law declaration, said he had re-

ceived intelligence that during the brief period of martial law Yoon ordered the country's defence counterintelligence commander to arrest and detain unspecified key politicians based on accusations of anti-state activities.

Hong Jang-won, first deputy director of South Korea's National Intelligence Service, told lawmakers in a closed-door briefing Friday that Yoon had ordered him to help the defence counterintelligence unit to detain key politicians. The targeted politicians included Han, Lee and Woo, according to Kim Byung-kee, one of the lawmakers who attended the meeting.

The Defence Ministry said Friday it suspended three military commanders including the head of the defence counterintelligence unit over their involvement in enforcing martial law.

Vice Defence Minister Kim Seon Ho has told parliament that Defence Minister Kim Yong Hyun ordered the deployment of troops to the National Assembly after Yoon imposed martial law. Opposition parties accused Kim of recommending to Yoon to enforce martial law.

Kim resigned Thursday, and prosecutors imposed an overseas travel ban on him. (AP)

#### **Road** accident in Ivory Coast leaves 26 dead, 28 injured Abidjan (Ivory Coast),

Dec 7: A fiery crash involving two minibuses in Ivory Coast on Friday killed at least 26 people and injured 28 more, authorities said.

The two vehicles collided in Brokoua, a village in the centre west of the country, the transportation ministry said in a statement without providing further details. However, the statement said an investigation was launched.

Ten of the 26 killed died in a fire that followed the collision, according to the ministry. Videos from the scene from local media outlets showed the two vehicles in flames.

"The Minister of Transport invites, once again, all road users to be more vigilant in road traffic, by respecting traffic regulations," the statement read.

Accidents are common in the west African country due to dilapidated roads and reckless driving, killing over 1,000 people annually, according to the ministry.

Last month, 21 people were killed and at least 10 others injured

But I expect this dip to be temporary," Krishnamurthy V Subramanian, Executive Director at IMF.

"From the vantage point that I've been sitting on the IMF board, I have no hesitation in saying the world is bullish on India. The kind of public digital infrastructure that India has enacted, is something that almost every of my board colleagues often finds a mention. They mention it with sincere appreciation. Apart from that, the kind of inclusive growth that India has pursued over the last decade is also something that comes up for appreciation," Subramanian, the former Indian Chief Economic Advisor and author of the latest book "India@100" told PTI in an interview.

Responding to a question, Subramanian said India during Covid chose to implement economic policy that was different from the rest of the world. While the rest of the world identified Covid as purely a demand-side shock, India was the only large economy to diagnose Covid as both a demand-side and a supply-side shock, he said. Therefore, India implemented a judicious mix of demand and supply-side policies, spent judiciously but making sure that it reached those that were generally impacted by the pandemic, he said. As a result, when the war in Europe started and the supply side problems that resulted, which led to substantial inflation in the rest of the world, it did not have as much of an impact on India, he explained. "This is something that is very clearly revealed. If you see, while in the rest of the world, during the last couple of years, these countries, especially advanced economies have faced anywhere between two and a half to four times the historical average inflation, India had less than its historical average," he said.



"Because you have to keep in mind you know India's average inflation has been more than seven per cent and even though there were periods where inflation was slightly higher than the band of two per cent to six per cent you know which is basically what the inflation targeting regime requires, but still it's been less than the historical average primarily because the very responsible fiscal policy that was pursued during Covid. The contrast with the rest of the world is palpable in this case," Subramanian said. From 2002 to 2013, the total factor productivity growth, rate of that was 1.3 per cent per annum on average. From 2014 onwards, it has been 2.7 per cent per annum. In other words, productivity has grown at more than double that compared to the previous period, he said.

"If you look at one of the telling indicators of the vibrancy of an economy, which is new firm creation.. from 2004 to 2014 using World Bank data, the new firm creation was only 3.2 per cent, it was a trickle. That was because of a combination of a lot of factors. The economy itself was there weren't enough reforms done which was reflected in this. In contrast, if you look from 2014 onwards, new firm creation has been orders of magnitude higher using the same World Bank data. As a result, today, India has the third largest entrepreneurial ecosystem in the world," Subramanian said. "Similarly, if you look at the innovation rankings in 2015 using global innovation rankings, India was ranked 85th. Today in the 2024 ranking, India is ranked 39th. I actually would want India to be even better, get into the top 20 and then 15." (AP)

MANAMA (BAHRAIN), Dec 7: Iran is poised to "quite dramatically" increase its stockpile of near weapons-grade uranium as it has started cascades of advanced centrifuges, the head of the International Atomic Energy Agency warned Friday. The comments from Rafael Mariano Grossi came just hours after Iran said it conducted a successful space launch with its heaviest payload ever, the latest for its programme that the West alleges improves Tehran's ballistic missile programme.

The launch of the Simorgh rocket comes as Iran's nuclear programme now enriches uranium at 60%, a short, technical step from weapons-grade levels of 90%. While Iran maintains its programme is peaceful, officials in the Islamic Republic increasingly threaten to potentially seek the bomb and an intercontinental ballistic missile that would allow Tehran to use the weapon against distant foes like the United States.

The moves are likely to further raise tensions gripping the wider Middle East over Israel's continued war on Hamas in the Gaza Strip and as an uneasy ceasefire



position it to produce one, if it so chooses." The Iranian debate over seeking the bomb "risks emboldening nuclear weapons advocates within Iran's decision-making apparatus and shifting the thinking of current and future Iranian elites about the utility of nuclear weapons," the report added.

An IAEA statement issued shortly after Grossi's remarks said Iran had begun feeding two cascades of advanced IR-6 centrifuges with uranium previously enriched up to 20% at its underground Fordo fa-

cility. That site is located under a mountain, protecting it from airstrikes.

Cascades are a group of centrifuges that spin uranium gas to-

gether to more quickly enrich the uranium. The IR-6 centrifuges enrich uranium faster than Iran's baseline IR-1 centrifuges, which have been the workhorse of the country's atomic programme. Adding 20%

uranium, as opposed to 5% uranium previously planned, further speeds up that process. "The facility's updated design information showed that the effect of this change would be to significantly increase the rate of production," the IAEA state-

#### Biden considering preemptive pardons for officials, allies before Trump takes office

WASHINGTON, Dec 7: President Joe Biden is weighing whether to issue sweeping pardons for officials and allies who the White House fears could be unjustly targeted by President-elect Donald Trump's administration, a preemptive move that would be a novel and risky use of the president's extraordinary constitutional power.

The deliberations so far are largely at the level of White House lawyers. But Biden himself has discussed the topic with some senior aides, according to two people familiar with the matter who spoke on condition of anonymity Thursday to discuss the sensitive subject. No decisions have been made, the people said, and it is possible Biden opts to do nothing at all.

Pardons are historically afforded to those accused of specific crimes - and usually those who have already been convicted of an offense — but Biden's team is considering issuing them for those who have not even been investigated, let alone charged.

They fear that Trump and his allies, who have boasted of enemies lists and exacting "retribution", could launch investigations that would be reputationally and financially costly for their targets even if they don't result in prosecutions.

While the president's pardon power is absolute, Biden's use in this fashion would mark a significant expansion of how they are deployed, and some Biden aides fear it could lay the groundwork for an

even more drastic usage by Trump. They also worry that issuing pardons would feed into claims by Trump and his allies that the individuals committed acts that necessitated immunity. Recipients could include infectious-disease specialist Dr. Anthony Fauci, who was instrumental in combating the coronavirus pandemic and who has become a pariah to conservatives angry about mask mandates and vaccines. Others include witnesses in Trump's criminal or civil trials

and Biden administration officials who have drawn the ire of the incoming president and his allies. Some fearful former officials have reached out to the Biden

White House preemptively seeking some sort of protection from the future Trump administration, one of the people said. It follows Biden's decision to pardon his son Hunter - not just for his convictions on federal gun and tax violations, but for any potential federal offense committed over an 11-year period, as the president feared that Trump allies would seek to prosecute his son for other offenses. That could serve as a model for other pardons Biden might issue to those who could find themselves in legal jeopardy under Trump. Biden is not the first to consider such pardons - Trump aides considered them for him and his supporters involved in his failed efforts to overturn the 2020 presidential election that culminated in a violent riot at the Capitol on January 6, 2021. #### Saudi Arabia calls for an end to Gaza war and attacks Israel's actions

MANAMA, BAHRAIN, Dec 7: Saudi Arabia's foreign minister has reiterated the kingdom's call for an end to the war in the Gaza Strip.

Prince Faisal bin Farhan described Israel as acting with "impunity and is getting away without punishment" in its war on Hamas there.

The prince said that any permanent solution requires a two-state solution, with the Palestinians having east Jerusalem as their capital.

After the speech, Prince Turki al-Faisal, a prominent royal in the kingdom who led Saudi intelligence for more than two decades and served as ambassador to the US and Britain, took the stage. He harshly criticized Israel's conduct in the wars

"Israel has become an apartheid, colonial and genocidal state," Prince Turki said. "It is about time for the world to address that issue and take the necessary steps to bring those who are thus charged by the International Criminal Court to justice." Israeli officials could not be immediately reached for comment on Prince Turki's remarks. The Saudis spoke at the International Institute for Security Studies' Manama Dialogue in Bahrain. (AP)

#### Israeli strikes kill at least 29 people at Gaza hospital

JERUSALEM, Dec 7: Palestinian officials say at least 29 people were killed, including four medical staff, when Israeli strikes pummelled the area around one of the last remaining hospitals in northern Gaza. The situation in and around the Kamal Adwan hospital is "catastrophic," according to Dr. Hussam Abu Safia, the director of the hospital. Elsewhere in the region, Lebanon said it is closing all its land border crossings with Syria except for a main one that links Beirut with the Syrian capital, Damascus. Friday's decision came hours after an Israeli airstrike damaged a border crossing in northern Lebanon just days after it was reopened. Jordan also closed a border crossing with Syria because of the security situation on the Syrian side. Syrian insurgents have entered the central towns of Rastan and Talbiseh, just north of the central city of Homs, bringing them closer to Syria's third largest city. (AP)

Declares December 21 as 'World Meditation Day' UNGA unanimously adopts resolution co-sponsored by India

UNITED NATIONS, Dec 7: India co-sponsored a UN General Assembly draft resolution that was unanimously adopted to proclaim December 21 as World Meditation Day.

India, including Liechtenstein, Sri Lanka, Nepal, Mexico and Andorra, was a member of the core group of countries that guided the unanimous adoption of the resolution titled 'World Meditation Day' in the 193-member UN General Assembly on Friday.

"A day for comprehensive wellbeing and inner transformation! Glad that India along with other nations of the core group guided the unanimous adoption of the resolution on the declaration of December 21 as World Meditation Day @UN General Assembly today (Friday)," India's Permanent Representative to the UN Ambassador Parvathaneni Harish said in a post on X.

He said India's leadership in overall human wellbeing stems from "our civilisational dictum of #VasudhaivaKutumbakam - the whole world is one family".

Harish noted that December 21 marks the Winter Solstice, which in Indian tradition is the beginning of "Uttarayana – an auspicious time of the year, especially for inner reflection" and meditation.

It also falls exactly six months after the International Day of Yoga commemorated on June 21, which is the Summer Solstice.

Recalling that India had in 2014 taken the lead in declaring June 21 as International Day of Yoga, Harish said that in a decade, it has become a global movement which has led to common people across the globe practising yoga and making it part of their daily lives.

A press release by the Permanent Mission of India to the UN said India's instrumental role in the

#### 'Mandays generation has been reducing with every passing day

AGARTALA, Dec 7: Tripura Pradesh Congress Committee (TPCC) on Saturday demanded that the state government provide at least 100 mandays to all MGNREGA job card holders during the remaining months of the current fiscal year (2024-25).

TPCC president Asish Kumar Saha claimed that an average 44 mandays have been generated in the northeastern state so far during the current financial year and the average mandays stood at 55 days in the previous fiscal year. "The MGNREGA was formulated to provide

100 mandays to people engaged in the unorganized sector during the UPA regime. The BJP in its vision document had promised to give 200 mandays to rural poor with an increase of wage of ₹ 340. Now, we are witnessing that the mandays' generation has been reducing with every passing day leaving the poor in an alarming sit-

uation," Saha told PTI.

"The situation in tribal areas is worrisome with the poor people running pillar to post to get jobs under the MGNREGA. The devastating floods, untimely rainfall, skyrocketing price rise and unemployment have been affecting the lives of poor people," he said.

Saha claimed that the state government had set a target to generate 3 crore mandays in the current financial year but it appears the achievement is far from the target as 1.30 lakh job card holders did not get mandays out of 6.83 lakh job card holders. "Since the unprecedented flood has severely affected the economy of 20 lakh people, we demand to ensure the allocation of 100 mandays for the remaining months of the ongoing financial year. The Congress will not hesitate to launch a statewide agitation if the demand is not met", he added. (PTI)

**IMPHAL, Dec 7:** In light of the "grave silence and inaction", various civil society organisations in Manipur have unanimously resolved to stage a protest rally in New Delhi on December 22, 2024, under the theme "Peace and Mutual Coexistence". These organisations also said that this rally, being organised with the cooperation of the Manipuri Diaspora in Delhi, is a call to awaken the conscience of the nation and urge the Prime Minister to break his silence on Manipu

It can be mentioned that, in light of the ongoing unrest and communal tensions in Manipur, representatives from various civil society organizations came together for a meeting on the theme "Peace and Mutual Coexistence" on December 5, 2024 at Sangai Hotel, Imphal, Manipur and sought to address the current crisis and chart a path toward lasting peace and reconciliation.

"Manipur, a historically independent kingdom until its merger with India in 1949, has long been a land of diverse ethnic communities living in relative harmony. However, post-independence political tensions, ethnic divisions, and armed conflicts have marred the state's social fabric. In recent years, the situation has worsened, leading to internal displacement, loss of lives, and growing distrust among communities following the outbreak of engineered conflict since May 3, 2023. With the intent to restore peace and rebuild a spirit of mutual coexistence, the meetings have been convened to build up a collective leadership of Manipur's civil society,"a joint statement from the civil society organisations said. The joint press statement was released to the press by Committee of Peaceful Coexistence, Manipur (CPCM) Meetei Meitei Tribe Union (MMTU) Federal Students' Organisation, Kangleipak (FESOK), United Meitei Pangal Committee (UMPC), Manipuri Students' Federation (MSF), Committee on Relief & Rehabilitation (CRR), Kanglei Panas (KP), Yelhoumee Phurup (YP), Apunba Awonba Manipur Amagidamak (AAMA), All Manipur Women's Voluntary Association (AMAWOVA), All India Tanzeeme Insaaf (AITI), Women Association for Socio-Economic Development (WASEDEV), Struggling Women Association (SWA), All Manipur Student Guardian Organisation (AMSGO), Imagi Meira (IM), All Manipur Meitei Pangal Clubs' Organisation (AMMPACO), Meipak Ningthou Committee (MNC), Youth Collective Manipur (YCM), Nupi Union For Peace and Integrity (NUPI), and Manipur International Youth Centre (MIYC).

The silence of Prime Minister Narendra Modi regarding the ongoing crisis in Manipur since May 3, 2023, has left the people of this war-torn state deeply anguished and disillusioned, it said, adding that for over 18 months, Manipur has been engulfed in ethnic strife, leading to untold suffering, displacement, and a breakdown of social harmony.

The burning question that we, the citizens of Manipur, ask today is: How can the Prime Minister of India seek peace abroad while ignoring the cries of his own people at home?" the joint press statement said.

AHMEDABAD, Dec 7: Governments before 2014 worked piecemeal while trying to achieve the Constitutional objective of a welfare state but this concept was turned into reality by Prime Minister Narendra Modi, Union minister Amit Shah said on Saturday.

The basic objective of creating a State by ensuring the welfare of every person, equal development, and the life of dignity for every family was subsequently decided, he said.

NEW DELHI, Dec 7: Former Supreme Court judge Justice R F Nariman has criticised the top court's 2019 judgement in the Ramjanmabhoomi-Babri Masjid case, describing it as a "great travesty of justice" that did not do justice to the principle of secularism.

Speaking at the First Justice A M Ahmadi Memorial Lecture on 'Secularism and the Indian Constitution', Justice Nariman, however, said the judgment had a "silver lining" as it upheld the Places of Worship (Special Provisions) Act 1991.

He said the Places of Worship Act should be strictly implemented to put an end to disputes over religious places which are popping up every day across the country like 'hydra heads"

"In my opinion, a great travesty of justice was that secularism was not given its due by these judgements," Justice Nariman said.

Justice Nariman also disagreed with the reasoning given by the court to grant the disputed land despite holding that the demolition of the mosque was illegal.

"Today we find hydra heads popping all over the Country. We find suits after suits not only against mosques but also against dargahs. All this, according to me could try," he said. (PTI)





CHANDIGARH/NEW DELHI, Dec 7: The rate of decline of tuberculosis incidence in India has doubled since 2015 and is ahead of the global average, Union health minister J P Nadda said on Saturday while inaugurating a nationwide campaign in Haryana's Panchkula to reduce such cases and mortality due to it.

The 100-day TB elimination campaign will be implemented in 347 districts of 33 states where the prevalence of the disease is higher. The campaign is focused on enhancing detection, reducing diagnostic delays and improving treatment outcomes.

"Under this programme, we have taken detection, tests, treatment and supportive strategies forward in an accelerated way. I feel this 100-day programme will prove to be a milestone in making a 'TB-mukt Bharat' and it will have a far-reaching impact," Nadda said.

The Union health minister highlighted the country's long struggle in its fight against tuberculosis, saying that at one time TB meant a 'slow death'.

"Even family members suffering from TB were isolated to pre-

"Ni-kshay support worth ₹ 3,338 crore has been provided through direct benefit transfer to over 1.17 crore tuberculosis patients," the minister said and underscored the government has increased Ni-kshay poshan amount recently from ₹ 500 to ₹ 1,000 and added energy boosters for the nourishment support for TB patients.

Ni-kshay Poshan is not only a policy decision, this is a financial commitment for people in the health sector to eliminate TB, he said.

Nadda said the government has now made it mandatory for even private practitioners to notify any new tuberculosis patient so that their treatment can be followed up immediately.

"This might look like a small step but it has led to an eight-fold increase in the rate of TB notifications in the private sector," Nadda said

The 100-day campaign underscores the Union government's commitment to achieving the goal of end-TB by addressing the challenges of tuberculosis notification and mortality in India under the National TB Elimination Programme of the Ministry of Health and Family Welfare.

Some of the key focus areas of the campaign are increasing access to advanced diagnostics, targeted screening among vulnerable groups, specialised care for highrisk individuals, and provision of expanded nutritional support.

Speaking about Haryana, he said earlier, there were only six medical colleges and now the number has grown to 15. The Haryana chief minister has announced to opening a medical college in each district, he said

Nadda further said the number of undergraduate seats for doctors has increased from 650 in 2014 to 2,185 in Haryana. Similarly, the number of post-graduate seats increased from 243 to 889 now, he added.

some understanding. "The CM has been entrusted with some responsibility and I'm entrusted with some. I'm functioning

accordingly," Shivakumar said. Speaking to reporters here, he said, "There is no need or there is no situation for anyone to speak about any formula. I have already said that whatever CM has said is final, and it (matter) is now closed or finished." Shivakumar had reportedly told a news channel recently that there was an agreement between them, before coming to power, to which Siddara-

no such agreement, and that he

would abide by the high command's decision. Reacting to Siddaramaiah's comments, Shivakumar said whatever the chief minister says is final, there is no objection to it.

Rejecting the possibility of any power-sharing agreement involving CM and Deputy CM, before Congress formed a government, home minister G Parameshwara on Thursday said, ultimately, the high command will take a decision, and everyone will abide by it.

There was stiff competition between Siddaramaiah and Shivakumar for the chief minister's post after the declaration of Assembly election results in May last year, and the Congress had managed to convince the latter and made him the deputy chief minister. There were some reports at the time that a compromise had been reached based on a "rotational chief minister formula," according to which Shivakumar will become CM after two-and-half years, but they have not been officially confirmed by the party. # Tribunal upholds extension of five-year ban on ITTE The tribunal was constituted by the MHA under the UAPA

NEW DELHI, Dec 7: A Delhi High Court tribunal has upheld the government's decision to extend a five-year ban imposed on the LTTE, saying the group continues to be a threat to India's sovereignty and territorial integrity and it is still indulging in activities prejudicial to integrity and security of the country.

The tribunal comprising Delhi High Court Judge Manmeet Pritam Singh Arora observed that the objective of the Liberation Tigers of Tamil Eelam (LTTE) for a separate homeland (Tamil Eelam) for all Tamils threatens the sovereignty and territorial integrity of India.

It amounts to the cession and secession of a part of the territory of India from the Union and thus falls within the ambit of unlawful activities, the tribunal observed.

In the final conclusion, the tribunal observed that "it is of the opinion that there is sufficient and cogent material on record for declaring LTTE as an Unlawful Association within the mandate of the Act (UAPA)"

The tribunal was constituted by the Ministry of Home Affairs under the Unlawful Activities (Prevention) Act after the ban on LTTE was extended for five years on May 14, 2024.

According to a notification issued by the Ministry of Home Affairs on Friday, the government has submitted before the tribunal that even after its military defeat in May 2009 in Sri Lanka, the LTTE has not abandoned the concept of 'Eelam' and has been clandestinely working towards the cause by undertaking fundraising and propaganda activities.

The remaining LTTE leaders or cadres have also initiated efforts to regroup the scattered activists and resurrect the outfit locally and in-



ternationally.

The home ministry said pro-LTTE groups and elements continue to foster a separatist tendency amongst the masses and enhance the support base for LTTE in India, particularly in Tamil Nadu, which will ultimately have a strong disintegrating influence over the country's territorial integrity.

LTTE sympathisers living abroad continue to spread anti-India propaganda among Tamils holding the Government of India responsible for the defeat of the LTTE, which, if not checked, is likely to develop a sense of hate among the Tamil populace towards the government of India and the Constitution. it said.

Abhijit Sinha, a joint secretary in the counter-terrorism and counter-radicalisation division in the MHA, had filed an affidavit before the tribunal mentioning the reasons and grounds under which the ban on LTTE has been extended.

Sinha stated that as per the information and material received from the central intelligence and probe agencies pertaining to the unlawful activities of the LTTE, it has been found that the group's cadres and sympathisers are still active and

continue to look at Tamil Nadu as a base for carrying out anti-India activities He submitted that despite the

elimination of its top leadership, including V Prabhakaran, by the security forces of Sri Lanka, several LTTE cadres and sympathisers are being arrested and prosecuted. The joint secretary in the MHA

stated that the LTTE's objective for a separate homeland for the Tamils is still the forefront agenda which threatens the sovereignty and integrity of India and amounts to an attempt of secession of a part of the territory of India from the Union and thus falls within the ambit of unlawful activities.

Vaiko, the general secretary of Marumalarchi Dravida Munnetra Kazhagam (MDMK), had sought impleadment before the tribunal over the issue.

His application was rejected but the tribunal allowed him to place his arguments and documents in a 'limited extent" as he himself contended that he "sympathises" with the LTTE's "aspirations and deprecates its ban, which impacts vari-

ous innocent boys and girls". However, Vaiko has categorically denied that he is a member of the LTTE.

Appearing for him, advocate R Murali stated that the main bone of contention by the Government of India in declaring the LTTE as an unlawful association is the group's object for a separate homeland for all Tamils that threatens the sovereignty and territorial integrity of India and amounts to cession and secession of a part from the Union, which is ascribed by India as unlawful activity

He stated the said object of the LTTE for a separate homeland for Tamil Eelam is restricted only to the Tamils living in the northern and eastern part of Sri Lanka and the word 'Eelam' itself connotes Territorial Land within Sri Lanka'

"The object of LTTE is not to have a separate homeland for Tamils in all the places of the world where Tamils are living, but instead it is only limited and restricted to Tamils living in Sri Lanka

"The object of establishment of Tamil Eelam is not intended to take even an inch of land belonging to Indian territory. There is no material whatsoever placed before this tribunal to support the appre-hension exhibited by the Government of India that the concept of Tamil Eelam includes annexation of any part of Indian territory," he submitted.

Another application was filed on behalf of Visuvanathan Rudrakumaran seeking impleadment. It stated that the applicant is an Eelam Tamil, born in Sri Lanka and is presently a permanent resident of the United States.

It was stated that the applicant was a legal advisor to the LTTE and had participated in the peace process between the group and the Government of Sri Lanka in and before 2009. (PTI)



#### Gun shop sealed in Jammu; deadline Javadekar visits Ernakulam market set for surrendering excess firearms complex built under Centre's SCM

JAMMU, Dec 7: A shop selling guns was sealed for not renewing its trade license here on Saturday while authorities set a deadline for all firearms license holders to surrender their excess weapons within a week, officials said.

The owner of the gun shop in the Shiv Nagar area, Amarnath Bhargav, claimed that the district administration did not issue any notice to him before taking action.

"I have timely applied for the renewal of the license and completed all requisite formalities several months ago but they came and sealed the shop without a notice," Bhargav said, demanding an inquiry into the

delay in renewing the license.

He said that he has been running the shop for the last 45 years.

Meanwhile, District Magistrate of Jammu, Sachin Kumar Vaishya, issued an order directing all firearm license holders of the district to comply with the provisions of the Arms (Amendment) Act 2019.

According to the Act, no individual is permitted to possess more than two firearms. The

identified license holders with more than two firearms must surrender their additional official said.

"These license holders are instructed to deposit their other firearm at the nearest police station or authorised unit armoury, in case of Armed Forces members of the Union," the order said.

"Upon surrender, they must also ensure proper endorsement on their licenses, to avoid cancellation and further legal action It said non-compliance with

the order will lead to immediate cancellation of licenses, with stringent action initiated against defaulters. (PTI)



NEW DELHI, Dec 7: Allu Arjun's "Pushpa 2: The Rule" continues to spread like wildfire at the global box office, earning ₹ 449 crore gross in just two days. The second part of the "Pushpa" franchise, which released across the globe on Friday with dubbed versions in Hindi, Tamil, Kannada, Bengali, and Malayalam, debuted with a historic box office score of ₹ 294 crore gross on day one.

Production banner Mythri Movie Makers, which has bankrolled "Pushpa 2", shared the movie's latest box office figures on social media. "WILDFIRE at the box-office #Pushpa2TheRule grosses 449 crores worldwide in 2 days... The fastest Indian film to hit the milestone," the studio said on X.

The Sukumar-directed movie is a sequel to 2021's Telugu blockbuster "Pushpa: The Rise". The film's day one collection of ₹ 294 crore broke the record for the highest opening in the history of Indian cinema, which earlier belonged to SS Rajamouli's "RRR" (₹ 223.5 crore), followed by "Baahubali 2" (₹ 217 crore) and "Kalki 2898 AD" (₹ 175 crore). The Hindi version of "Pushpa 2", whose trailer was launched by Arjun and Rashmika Mandanna in Patna last month, also smashed records as it earned ₹ 72 crore net on day one, surpassing the opening day figure of Shah Rukh Khan's 2023 hit "Jawan", whose Hindi version had earned around ₹ 65 crore on day one. In the sequel, Arjun returns as labourer-turned-sandalwood smuggler Pushpa Raj, alongside Mandanna as Srivalli and Fahadh Faasil as SP Bhanwar Singh Shekhawat. The original film, directed by Sukumar and produced by Mythri Movie Makers, was not only a commercial success, amassing over ₹ 300 crore in India, but also established a strong fan base beyond the traditional Telugu base and it has only grown since then. # My relationship with NSD like Dronacharya and Eklavya: Manoj Bajpayee

NEW DELHI, Dec 7: After being rejected four times by the National School of Drama, Manoj Bajpayee says he developed a Dronacharya-Eklavya relationship with the premier acting institute because he considered it an absentee mentor that shaped his success.

A monthly stipend of ₹ 2,500, a roof over his head, free food from canteen and being surrounded by the best in the world of acting. As a 22-year-old, there was no better place than NSD, the "Satya" actor said.

But it was not to be despite four attempts. "My relationship with NSD is very much like what Eklavya had with Guru Dronacharya. That they didn't ask for my thumb is a different matter. They have rather welcomed me. They call me to hold workshops with the students. There is mutual respect. The National School of Drama is among

the best institutions in the world," Bajpayee told PTI in an interview during a visit to the news agency's headquarters.

According to the actor, who started in theatre before going on to become a big name in arthouse and mainstream movies, institutes such as NSD, Pune's Film and Television Institute of India and Kolkata's Satyajit Ray Film & Television Institute are world class institutes. "I don't understand why they don't get their due," he said.

He said he never complained about NSD's rejection even when it happened the first time.

"On the contrary, I thought I wasn't good enough and had many flaws, because NSD can never go wrong," he said. But the first time he failed, it really broke him. Bajpayee, who was then studying in Delhi University, said he shut himself in his rented room in

Mukherjee Nagar. His friends intervened and helped him come out of his shock

"It was a bad time in my life where I was absolutely clueless about what to do next. My first aim was to enter NSD. That I'll work with the best of the best in India for three years, I'll be in the campus all of 24 hours. Where I didn't have to think about food, lodgings. I'll get a scholarship, I think at the time it used to be around ₹ 2,500. I've heard it is ₹ 15,000 today."

The actor, known for hits such as "Satya", "Shool", "Zubeida", "Gangs of Wasseypur", "Aligarh" and the OTT series "The Family Man", said the other three attempts he made to enter the institute "didn't shake him up" the way it did the first time.


He had gradually found a "foothold" through plays held at Mandi House, the nerve centre of Delhi's theatre

scene at the time, over the years.

"I only did theatre all day long for three years. I can confidently say I used to work 18 hours a day. I remember I had malaria, I was so belligerent and passionate to learn this craft that I went to the rehearsal despite being down with malaria. I fainted near a tea store outside Hindu College.

"I woke up after some students there sprinkled some water on my face... I was working so hard, there was a drive to learn, there was a lot of passion for this work. I didn't lose any time," he said.

The dream to get into the premier Delhi institute of performing arts probably took shape when he was in high school and read about the many stalwarts who had studied at NSD, Bajpayee said, recalling how this dream inspired him to leave his village and land in Delhi. (PTI)

Two of the biggest Europe vs. South America pairings have been given kickoff times that are 3 a.m. in central Europe: Bayern Munich vs. Boca Juniors in Miami on June 20 and Inter Milan vs River Plate in Seattle on June 25.

FIFA said its match schedule aimed to maximize rest and minimize travel for players and took forecast heat and weather into account.

The two West Coast locations Pasadena and Seattle stage only group-stage games with all round of 16 games being played in Atlanta, Charlotte, Miami, Orlando and Philadelphia. Quarterfinals also are in Atlanta, Orlando and Philadelphia.

Teams qualified for the Club World Cup by winning a continental title from 2021 through 2024, or being high ranked with consistent results over those four editions

He was 93 and is survived by two sons and one daughter.

Born in Kolkata, Chandhok moved to the erstwhile Madras and co-founded the Madras Motor Sports Club (MMSC) in 1953.

He was a fantastic father and protector," Chandhok's son and MMSC vice-president Vicky said.

"In a way, he was also the patriarch of Indian motorsports who saw the big picture with a clear vision for the growth of the sport. The family and the motorsports fraternity will miss him," added Vicky, a former racing driver.

MMSC president Ajit Thomas called Chandhok an "institutional figure" who gave Indian motorsports a definitive direction.

"In Indu Chandhok's demise, the MMSC and Indian motorsports have lost a giant and an institutional figure. He was instrumental in providing definitive direction to motorsports in India and we are now enjoying the fruits of his untiring efforts. He also shaped MMSC to what it is today," said Thomas in a statement. Chandhok's grandson, Karun, went on the compete in the biggest motorsport event in the world, Formula One, taking part in 11 races in 2010-11. Former FMSCI president Shramik Masturlal said Chandhok took Indian motorsports to great heights. "Indu was an institution in himself. LIVERPOOL, Dec 7: The Merseyside derby between Everton and Liverpool was postponed on Saturday because of Storm Darragh, which brought dangerous winds and rain to the west coast.

The Premier League match was due to kick off at 12.30 p.m. U.K. time, but Everton issued a statement in the morning to say it would not go ahead. The Met office said parts of Wales had experienced wind gusts of over 90 mph.

"Storm Darragh continues to bring strong winds across the UK, with red, amber and yellow wind warnings in force," the office said on social media. Aston Villa will host Southampton in a 3 p.m. kickoff. The team urged fans to use extra time to get to Villa Park in Birmingham.

'We want to advise all supporters to allow extra time for travel to today's game due to poor weather conditions across the country. Please take extra care and stay safe. We look forward to seeing you at the game," the team said in a statement. Three other games were scheduled in the Premier League on Saturday.

Manchester United was hosting Nottingham Forest at 5:30 p.m. local time. United has not commented on the storm.

In London, Brentford was hosting Newcastle, and Crystal Palace was hosting Manchester City. Both games are at 3 p.m. Brentford and Palace both

said their games will be played. "Today's match is still scheduled to go ahead despite the bad weather," Brentford said. "Please travel safely, plan ahead, and allow extra time for your journey."

Storm Darragh was expected to "gradually ease from late morning as it crosses the UK, so the strongest winds in the west will start to reduce through Saturday," Met Office chief meteorologist Steve Willington said.

Everton and league leader Liverpool issued nearly identical statements about the postponement.

"Following a Safety Advisory Group meeting at Goodison Park, attended by officials from both clubs, as well as representatives from Merseyside Police and Liverpool City Council this morning, it was decided that, due to the risk to safety in the local area due to strong wind gusts, and an amber severe wind warning that remains in place until 6 a.m. on Sunday, today's fixture should be postponed on safety grounds," Everton's statement read.

'We apologize for the inconvenience caused and thank supporters for their understanding. Whilst we appreciate this will be deeply disappointing for supporters, the safety of fans, staff and players is of paramount importance.'

# Travis' ton helps Australia take control as visiting top-order crumbles

ADELAIDE, Dec 7: Australia tightened their grip on the pink ball Test as their formidable pacers scythed through India's toporder after nemesis Travis Head's counterattacking century handed his team a substantial first-innings lead on a riveting second day here on Saturday.

The Adelaide Oval was throbbing with life through the three sessions of play as Head dominated India with his wide range of strokes on way to a 140 off 141 balls before the trio of Scott Boland (2/39), Mitchell Starc (1/49) and Pat Cummins (2/33) left the visitors in a spot of bother at 128 for five in their second innings and trailing by 29 runs. At stumps, Rishabh Pant was living dan-

gerously on a 25-ball 28 and Nitish Reddy was batting on 15 off 14.

Thanks to Head's eighth Test century, which he reached in 111 balls after toying with the Indian bowling attack, Australia ended with 337 all out, and more importantly, a 157-run first-innings lead.

The hosts are looking to restore parity in the five-match series after the 295-run hammering in the opener at Perth.

Head's hundred, the fastest in a pink ball Test, reduced Marnus Labuschagne's (64) composed half-century, coming after a lean run of form, to a mere footnote.

India lost KL Rahul (7) early in their second innings and Yashasvi Jaiswal (24) was done in by a peach of a delivery from Boland, who again struck with his first delivery that had a hint of late movement.

Boland then had Virat Kohli (11) caught behind after he got one to land right in the channel which has been troubling the Indian batting mainstay for a while now.

#### India's batting might face Bangladesh bowling firepower in U19 Asia Cup final

**DUBAI, Dec 7:** It will be a battle of India's formidable batting against Bangladesh's incisive bowling when the two teams clash for the ACC U19 Men's Asia Cup title at the Dubai International Cricket Stadium here on Sunday.

India, the most successful team in the tournament's history with eight titles, will be keen to reclaim their crown after a three-year gap. Defending champions Bangladesh, who eliminated India in the last edition, are determined to retain their title in what will be a rematch of the 2023 semi-final.

India's batting has been spearheaded by opener Ayush Mhatre, who has amassed 175 runs, and 13year-old sensation Vaibhav Survavanshi, who has scored 167 runs in the tournament.

Bangladesh, on the other hand, have relied on their bowlers, with Md. Al Fahad and Md. Iqbal Hasan Emon leading the charts, bagging

To make matters worse for the visitors, Starc knocked down Shubman Gill's (28) middle stump with his late in-swing doing the damage to leave India at 86 for four in front of a record crowd of over 50,000.

However, unperturbed by the Australian inroads, Pant looked to be batting in a universe of his own and played some outrageous shots against the fast bowlers, leaving everyone stunned

Least bothered by the fact that India were three down with not enough on the board. Pant danced down the track first ball and smashed Boland over mid-off for a boundary, and he maintained that audacious approach until the umpires called stumps.

Earlier, Head continued to be a thorn in India's flesh with yet another magnificent knock that powered Australia's response after bowling out India for 180.

Head, who got off the mark with a cracking boundary off Jasprit Bumrah (4/61), got a reprieve on 76 as Mohammed Siraj failed to complete the catch despite getting both hands to it after the batter tried to slog-sweep R Ashwin, having just smashed his third six against the off-spinner.

Amid the rejoicing around Head's century, Siraj (4/98) was rewarded for his discipline as he had Alex Carey caught (15) behind following a faint outside edge with Australia's lead crossing 100.

Desperate to prevent Australia from adding to that advantage, India took the second new ball the moment it was made available to them, and their lead pacer Bumrah too was brought back into the attack.

Bumrah, however, pulled his adductor muscle as the physio attended to him. Fortunately for India, Bumrah was up on his feet quickly and ready to bowl again, even as Head flicked him for two boundaries in between

During his knock, Head played some incredible shots, including a pick-up six over Siraj over deep square leg, but the pacer had the last laugh as he brought his innings to an end when he cleaned him up with a yorker.

In all, Head struck 17 fours and four sixes. Earlier, Rohit Sharma giving his strike bowler Bumrah only four overs in the first session seemed odd, and so were some of his field placements.

Then, in another surprising move, he started the proceedings after tea with Ashwin instead of the fast bowlers.

Luck, though, was with Ashwin as Mitchell Marsh decided to walk off despite a half-baked appeal by the Indian team. Seeing Marsh heading in the direction of the dressing room, Richard Illingworth raised his finger too, but replays clearly showed there was a gap between bat and pad

Head, though, went about his task in the manner he does best -- dictating the terms to the bowlers with his free-flowing strokes. None of the Indian bowlers, including Bumrah, looked like they could cause problems for Head. (PTI)

# Milestones galore as England leads New Zealand by 533 runs in the 2<sup>nd</sup> test after 2 days

WELLINGTON, Dec 7: England led New Zealand by 533 runs with five second-innings wickets in hand Saturday after another day of extraordinary incidents and milestones, including a hat-trick on the second day of the second test at the Basin Reserve.

At stumps, England was 378-5 in its second innings with Joe Root 73 not out and captain Ben Stokes unbeaten on 35.

Root was among the historymakers Saturday, reaching his 100th score of 50 or more in tests. When he reached his 65th half century, which goes along with his 35 centuries, he became the fourth player after Sachin Tendulkar, Jacques Kallis and Ricky Ponting to achieve that feat.

When Stokes declares, possibly overnight, New Zealand will have to achieve the highest successful fourth-innings run chase in test history to win the match and level the three-match series. England won the first test by eight wickets in Christchurch. The record successful fourth innings total currently sits at 418, achieved by the West Indies against Australia at St. John's in the Caribbean 21 years ago. Under any normal circumstances, Stokes probably would have been happy to declare by now, confident in his bowlers' ability to defend such a mammoth lead. But the match has progressed so fast and so far with 783 runs being scored and 25 wickets falling on the first two days, that three full days are still available to New Zealand reach its winning target. Most other winning fourth-in-

#### Focus on batting as demoralised India look to avoid series defeat against Australia Ding Liren might have odds favouring him in World Chess C'ship playoffs, feels GM Tania Sachdev

MUMBAI, Dec 7: Title defender Ding Liren can draw from his experience and have the odds favouring him if the World Chess Championship match against India's D Gukesh heads into playoffs, feels Grand Master Tania Sachdev. With both players tied on 4.5 points after nine rounds Sachdev hopes that Gukesh should be able to make the most of the chances that come his way.

"Definitely, the odds were a lot higher for Gukesh at the start. But the way that the match has turned out, I think those odds have come down," Sachdev told PTI Videos in an exclusive interaction.

"If it goes into a tie-break, a play-off, Ding with his experience in speed chess, perhaps the odds might start favouring him.'

"So, I'm hoping that Gukesh finds some big chances and is finally able to capitalise on them in the classical portion of the match.'

Sachdev said the contest between the Indian Grand Master and his Chinese rival has turned out against the expectations.

"When the World Championship match started, players and chess fans across the world had a very different idea of how this would go. Many thought that Gukesh was a big favourite, as he comes from a fantastic year and the performances that he's had. He had set the bar so high."

She continued, "Ding came from a very challenging, very difficult professional year himself. A lot of conversation was around, in the classical, will this match even reach game 14?"

Sachdev said Ding has shown "exceptional resilience" in the contest so far.

"Ding has shown exceptional resilience and resourcefulness, while Gukesh has had many chances. It feels that he's so close, he's knocking on the door, but every time Ding holds the line."

Sachdev backed Gukesh to find his way through the pressure situations in the ongoing contest.

'There is going to be pressure. This is the biggest stage in the world. It's the World Championship. Nerves and pressure are a part of it," she said. (PTI)

BRISBANE, Dec 7: A desperate India will need their under-fire batters to step up in the second Women's ODI against Australia here on Sunday, as the visitors aim to avoid yet another series loss Down Under.

India's batting woes continued as the tourists were bundled out for 100 in the series opener, leading to a demoralising fivewicket defeat, their heaviest in terms of balls remaining since ODIs were reduced to 50 overs a side.

India have never won a series Down Under and they will have their task cut out against a quality Australian side, which showed no signs of rust despite playing in the format after a gap of nine months.

On the other hand, it was the Indians who appeared under-prepared as the squad was unable to train together as some of the players were competing in domestic T20 tournaments while others played in the Women's Big Bash League.

Additionally, one of their two practice sessions here was washed out due to rain.

After opting to bat, the Indian batters were unable to capitalise on good batting conditions. They lost wickets at regular intervals, were unable to stitch partnerships, and were done in by Megan Schutt's brilliant spell with the new ball.

"We were expecting a good score if our batters had applied themselves better. If we had more runs on the scoreboard, anything could have happened." India coach Amol

With the batting inconsistencies continuing from the New Zealand series, time is running out for India, who will host the ODI Wold Cup next year. The Indian think tank will be keen to sta-

bilise their batting and bowling line-up ahead of the marquee event.
