

# Sonia linked to organisation financed Himanta directs police to take action by George Soros Foundation: BJP

NEW DELHI, Dec 8: The BJP on Sunday alleged that former Congress president Sonia Gandhi has links to an organisation financed by the George Soros Foundation and which has backed the idea of Kashmir as an independent nation.

This association shows the influence of foreign entities in India's internal affairs, the ruling party said in a series of posts on X.

Meanwhile, notwithstanding the US' dismissal of BJP's allegations that it is backing attempts to destabilise India, party MP Nishikant Dubey said he would pose 10 questions to leader of opposition Rahul Gandhi in the Lok Sabha on the issue. He said media portal Organised Crime and Corruption Reporting Project (OCCRP) and Hungarian-American businessman have colluded with the opposition to ruin India's economy and defame the Modi government.

The BJP claimed that Sonia Gandhi, as the co-president of the Forum of the Democratic Leaders in Asia Pacific (FDL-AP) Foundation, is linked to an organisa-



# CM expects to complete 'Wrestling going on within INDIA bloc': Naqvi 3.5 km bridge by 2028 Palashbari-Sualkuchi bridge's 'bhumi pujan' performed

GUWAHATI, Dec 8: Chief Minister Himanta Biswa Sarma on Sunday performed the 'bhumi pujan' of the Palashbari-Sualkuchi bridge over the Brahmaputra river, said an official statement.

Sarma noted the subsequent actions taken, including the development of the project report, tendering processes, and land acquisitions, which culminated in today's Bhumi Pujan.

"The bridge, spanning a total length of 3.6 kilometers, is expected to be completed by June 2028. It would feature a 5.3-kilometer four-lane road connecting Palashbari and a 2-kilometer route to Sualkuchi, alongside elevated roads to protect the wetlands north of Sualkuchi," the statement quoted Sarma as saying.

The chief minister also posted that this bridge would catalyse a transformative shift in connectivity between the northern and southern banks of the Brahmaputra, easing access to prominent locations such

as Gauhati University, Tura in Meghalaya, and Goalpara. Later, he reiterated that government initiatives, previously impeded by logistical challenges in areas like

Hajo, Ramdia, and Sualkuchi could now be implemented. Sarma also noted the imminent construction of the Indian Institute of Management (IIM) in Palashbari, which would improve communication for students in North Assam once the bridge is completed. Reflecting on the progress made since Prime Minister Modi took office in 2014, Sarma highlighted the sig-

nificance of the Dhola-Sadiya and Bogibeel bridges. "The ongoing construction of a bridge connecting Jorhat and Majuli, along with plans to initiate a major tunnel road project between Gohpur and Golaghat next year, with an investment of 12,000 crore rupees," he said.

Furthermore, he announced plans for a 32-kilometer elevated corridor aimed at protecting Kaziranga's (CONTD. ON PAGE-2)



# All BJP mandals to have offices by 2026: Himanta

GUWAHATI, Dec 8: The ruling BJP is in the process of constructing permanent offices in all its mandals across Assam to bring the party further closer to the people, chief minister Himanta Biswa Sarma said on Sunday.

He said most of these mandal offices will be completed before the 2026 Assembly elections

Speaking to reporters after inaugurating the office building of Sualkuchi Mandal in Kamrup (Rural) district, Sarma said, "Today is a joyous day for us as this office building, with all modern facilities, has been opened. We are aiming to build such offices in all the mandals of the state." He said that most of these buildings will be completed before the next state elections, due in 2026. DAMASCUS, Dec 8: Syrians poured into streets echoing with celebratory gunfire on Sunday after a stunning rebel advance reached the capital, putting an end to the Assad family's 50 years of iron rule but raising questions about the future of the country and the wider region.

Joyful crowds gathered in central squares in Damascus, waving the Syrian revolutionary flag in scenes that recalled the early days of the Arab Spring uprising, before a brutal crackdown and the rise of an insurgency plunged the country into a nearly 14-year civil war.

Others gleefully ransacked the presidential palace and the Assad family residence after President Bashar Assad and other top officials vanished, their whereabouts unknown. Russia, a close ally, said Assad left the country after negotiations with rebel groups and had given instructions to transfer power peacefully.

Abu Mohammed al-Golani, a former al-Qaida commander who cut ties with the group years ago and says he embraces pluralism and religious tolerance, leads the biggest rebel faction and is poised to chart the country's future direction.

The end of Assad's rule deals a major blow to Iran and its allies, already weakened by over a year of con-



flict with Israel. The rebels now face the daunting task of healing bitter divides in a country ravaged by war and still split among different armed factions. Turkeybacked opposition fighters are battling US-allied Kurdish forces in the north, and the Islamic State group is still active in some remote areas.

Syrian state television aired a video statement early Sunday by a group of rebels saying that Assad had been overthrown and all prisoners had been set free. They called on people to preserve the institutions of "the free Syrian state." The rebels later announced a curfew in Damascus (CONTD. ON PAGE-2)

Congress general secretary incharge communications Jairam Ramesh said a discussion in Parliament on the India-China relationship should focus on both strategic and economic policy, especially since our dependence on China has increased economically, even as it unilaterally changed the status quo on our borders over four years back. In a statement, Ramesh said the Congress has studied the recent suo motu statement made by external affairs minister S Jaishankar in both Houses of Parliament titled "Recent Developments in India's Relations with China".

It is unfortunate, but typical of the Modi government, that MPs



were not permitted to seek any clarifications, he said.

While "fully appreciating" the sensitive nature of many aspects of India-China border relations, he said the Congress has four pointed questions on the statement issued by the Modi government.

Ramesh noted that the statement claims that "the House is well aware of the circumstances leading up to the violent clashes in Galwan Valley in June 2020", and pointed out that it is an unfortunate reminder that the very first official communication to the nation on this crisis came on June 19, 2020, when the PM provided a clean chit publicly to China and falsely stated 'Na koi hamari seema mein ghus aaya hai, na hi koi ghusa hua hai".

# The policy also aims to promote clean and gender-segregated sanitation facilities States asked to submit action plans for implementation of national menstrual hygiene policy

NEW DELHI, Dec 8: The Centre has urged states to submit action plans for effective implementation of the menstrual hygiene policy for school girls to ensure their access to low-cost hygiene products and gender-responsive sanitation facilities in public and government-aided schools.

The Union Health Ministry's letter to all states comes after the Supreme Court on November 12 stated that the effective roll-out of the policy would require comprehensive action plans tailored to the specific needs and contexts of each state and UT.

The Centre had last month informed the Supreme Court about the 'Menstrual Hygiene Policy for School Going Girls,' which was approved by the Union Health Ministry on November 2.



The policy aims to mainstream freedom, mobility and participation menstrual hygiene within the school in daily activities. It advocates for streamlining

aided schools, the policy says that states/UTs should assess and estimate the actual requirement of menstrual hygiene products to enable efficient use of resources.

To enable coverage, assessment through appropriate levels of survey mechanisms can be undertaken by states or UTs followed by gap filling, so that girls in government and government aided schools have regular access to menstrual hygiene products.

Additionally, the policy seeks to dissipate harmful social norms, promote safe menstrual hygiene practices, and enable environment friendly management of menstrual waste. The health ministry has asked states to develop and submit a detailed state and UT action plan that incorporates all aspects of the policy, (CONTD. ON PAGE-2)



JODHPUR, Dec 8: Union Home Minister Amit Shah on Sunday said India will soon create a comprehensive anti-drone unit to secure its borders as the "menace" of unmanned aerial vehicles is going to get serious in the coming days.

Addressing BSF troops at the 60th Raising Day event of the force here at its training camp, about 300 km from

the India-Pakistan border, Shah said the initial results of a "laser equipped anti-drone gun-mounted" mechanism have been encouraging.

This has led to an increase in drone neutralisation and detection cases, up from 3 per cent to 55 per cent, along the India-Pakistan border in Punjab, he said.

"The drone menace is going to get more serious in the coming days... We are tackling this issue in a 'whole of government' approach with the border guarding forces, defence and research organisations and the DRDO join-

"We are going to create a comprehensive anti-drone unit for the country in the coming time," Shah said.

According to official data, more than 260 drones have been downed or recovered from India's border with Pakistan this year as compared to about 110 in 2023. The maximum number of such interdictions of drones carrying arms and drugs have taken place in Punjab and very few in Rajasthan and Jammu. (CONTD. ON PAGE-2)

The proposed amendments primarily focus on promoting policyholders' interests **Insurance Amendment Bill proposing** 100% FDI unlikely in winter session

NEW DELHI, Dec 8: Insurance Amendment Bill, which proposes 100 per cent FDI in the insurance sector, may not be introduced in Parliament in the ongoing session, sources said.

Some finetuning may be required in the draft Bill after receiving comments from stakeholders, sources said.

Given the paucity of time, it is difficult to present the Bill in the ongoing session, sources said, adding it may, however, come in the Budget session

The finance ministry has proposed to amend various provisions of the Insurance Act, of 1938, including raising foreign direct investment (FDI) in the insurance sector to 100 per cent, reduction in paid-up capital, and provision for composite licence.

The Department of Financial Services (DFS) has sought public comments on the proposed amendments by December 10.

As per the proposal, the FDI limit in Indian insurance companies will be raised from 74 per cent to 100 per cent.

This is the second public consultation that the DFS has sought on the proposed amendments to the Insurance Act 1938, the Life Insurance Corporation Act 1956, and the Insurance Regulatory and De-

### CII urges govt to stick to fiscal deficit ₹ 24,454 crore inflow in Dec first week GDP for 2024-25

NEW DELHI, Dec 8: Industry body CII has suggested the government to stick to the fiscal deficit target of 4.9 per cent of GDP for 2024-25 and 4.5 per cent for 2025-26, cautioning that "overly aggressive targets" beyond these could adversely affect India's economic growth.

"India has been growing rapidly amidst a slowing global economy. Prudent fiscal management for macroeconomic stability has been pivotal to this growth," said Chandrajit Banerjee, Director General, CII, elaborating on suggestions for the forthcoming Union Budget. CII also highlighted the announcement in the Union Budget 2024-25 to keep the fiscal deficit at levels that help reduce the debt-to-GDP ratio.

In preparation for this, the forthcoming budget could lay out a glide path to bring the central government's debt to below 50 per cent of GDP in the medium term (by 2030-31), and below 40 per cent of GDP in the long term, CII has sug-

The proposal includes raising the FDI limit in Indian Insurance Companies from 74 per cent to 100 per cent and enabling an insurer to carry on one or more classes of insurance business and activities related/incidental to insurance," it said.

Further, it said, the requirement of net-owned funds for foreign reinsurers is also proposed to be reduced from ₹ 5,000 crore to ₹ 1,000 crore. The Insurance Act, of 1938, serves as the principal Act to provide the legislative framework for insurance in India. It provides the framework for the functioning of insurance businesses and regulates the relationship between an insurer, its policyholders, shareholders and the regulator IRDAI.

The US on Saturday rejected BJP's allegations that organisations funded by its State Department and elements in the American "deep state" were behind attempts to destabilise India through targeted attacks on Prime Minister Narendra Modi and business tycoon Gautam Adani

A spokesperson at the US embassy described the allegations as "disappointing" and asserted that the US government has been a champion of media freedom around the world. Reacting to the US embassy's statement, BJP MP Dubey said, "Yesterday I read the statement of the US embassy officials again and again. They admitted that the US government funds OCCRP and Soros' foundation also funds it."

The job of OCCRP and Soros is to ruin India's economy and defame the Modi government in connivance with opposition leaders, he said in his post on X in Hindi. "After yesterday's statement, I will have to ask Rahul Gandhi my 10 questions in the Lok Sabha. The opposition is trying to suppress my voice in Parliament. A video circulating online purported to show rebels breaking open cell doors and freeing dozens of female prisoners, many of whom appeared shocked and confused. At least one small child could be seen among them.

Rebel commander Anas Salkhadi, who appeared on State TV later in the day, sought to reassure Syria's religious and ethnic minorities, saying: "Syria is for everyone, no exceptions. Syria is for Druze, Sunnis, Alawites, and all sects." "We will not deal with people the way the Assad family did," he added. (AP)

Cars set to get expensive from January as OEMs announce increase in price

NEW DELHI, Dec 8: Prices of various car models -- ranging from entry-level hatchbacks to high-end luxury offerings -- are set to rise as automakers have announced price hikes with effect from January.

Carmakers cite an increase in input costs and operational expenses as the main reason to implement price increases from the next month.

Industry experts, however, note that the exercise is also undertaken by automakers every year in December to shore up sales volume in the last month of the year, as customers postpone buyouts to later months to get the new year manufactured units.

"We have seen a few cycles of price increase in India. It happens at the beginning of the calendar year and financial year, but few OEMs pick the timing based on their planned launches as well," Deloitte India Partner Rajat Mahajan said. While there could be multiple factors for the price increase, the key one is due to a decline in profitability of a few large auto OEMs in the second quarter, he added. "Due to the festive season, the price revisions were not done. Hence, this is expected at the beginning of Q4.

"Rising input costs of few materials, shifting consumer preferences on advanced features but a low willingness to pay, clubbed with the pressure of supporting dealers to offset high inventory

Increased commodity prices and higher logistics expenses driven by persistent inflationary pressures are putting a significant strain on the company's overall operational costs, Mercedes-Benz India stated. Prices of Mercedes-Benz cars will be revised in the range of Rs 2 lakh for the GLC to Rs 9 lakh for the top-end Mercedes-Maybach S 680 luxury limousine.

Audi India will increase prices by up to 3 per cent across the model range due to an increase in input and transportation costs.

'This correction is essential for Audi India and our dealer partners to ensure sustainable growth,' Audi India Head Balbir Singh Dhillon said.

Similarly, BMW India is looking to increase prices of its model range by up to 3 per cent from January next year. (PTI)

Does this not reveal a shift in our official position, he asked. Ramesh said.

Why has the Chinese government yet to corroborate any details about the disengagement in Depsang and Demchok, he asked. "Have traditional grazing rights for Indian livestock herders been restored? Will there be unfettered access to our traditional patrolling points? Have the buffer zones ceded during previous negotiations been taken back by India?" he said.

The Congress reiterates the demand it has been making for the past few years -- Parliament must, to reflect a collective national resolve, be given an opportunity to debate the full gamut of the India-China relationship, he asserted. "This discussion should focus on both strategic and economic policy, especially since our dependence on China has increased economically, even as it unilaterally changed the status quo on our borders over four years back," Ramesh said. His remarks come days after Jaishankar said India is committed to remaining engaged with China to find a fair and mutually acceptable settlement of the boundary issue. (PTI)

# India to set up anti-drone unit

The minister reviewed the ceremonial parade, took salute and awarded medals to gallantry award winners and gave away some other decorations. The Border Security Force (BSF), which has a strength of about 2.65 lakh personnel, was raised on December 1, 1965. It is primarily tasked with guarding more than 6,300 kms of Indian fronts with Pakistan and Bangladesh apart from rendering a variety of duties in the internal security domain of the country. Shah said the ongoing Comprehensive Integrated Border Management System (CIBMS) for securing India's borders with Pakistan (2,289 km) and Bangladesh (4,096 km) is a work in progress. "We have had an encouraging response from the CIBMS deployed along the riverine border in Assam's Dhubri (India-Bangladesh international border) but some improvements are required," he said. The minister also said that the Modi government's Vibrant Village Programme (VVP) for developing and bringing into the mainstream the population of northern borders will be implemented for all the frontier villages of the country in the future. This is Modi government's "biggest achievement' vis-a-vis enhancing border security and working for the population living in these remote areas with a fund allocation of ₹ 4,800 crore. It is being run on an "experimental basis" currently in around 3,000 villages, he said. Shah said the Union government has sanctioned a "big" budget for strengthening India's borders -- fencing, fron-

tier infrastructure, roads and other logistics. "Securing global recognition and the number one place for India by 2047 is not possible without our security personnel... the jawans who guard our borders with dedication," he said. Speaking about securing India's frontiers, Shah said for many years, India's border security policy "lacked clarity".

During prime minister Atal Bihari Vajpayee's tenure, an integrated approach to border management and the "One Border, One Force" policy was introduced, which became even more defined after Shri Narendra Modi became Prime Minister," he said. Shah said fencing has been completed along 591 kms of the India-Bangladesh border.

Floodlights have been "installed" along 1,159 kilometers of the border apart from the construction of 579 observation posts, he said.

Additionally, 685 locations have been provided with electricity connections, 575 places with water connections, and 570 solar plants have been installed to ensure power supply, he stated. Shah said about 573 new border posts have been created by the Modi government apart from 1,812 km of roads in remote frontier areas.

BSF director general (DG) Daljit Singh Chawdhary said 13,226 newly trained personnel have been posted in various battalions and this will add to the "operational strength" of the force. (PTI)

In fact, Mohammad Farid Khan, chairman of Summit Communications, a company associated with Airtel to create this transit link, also has ties with Sheikh Hasina's Awami League. He is the younger brother of Awami League MP Fariq Khan. This is also believed to be the reason behind the decision of the Yunus government.

# What does the liver do?

person's liver is in the upper right section of the abdomen and sits below the diaphragm. It typically weighs around 3 pounds, but this can vary between people. The skin is the only organ heavier and larger than the liver.

The liver is roughly triangular and consists of two lobes: a larger right lobe and a smaller left lobe. The falciform ligament separates the lobes. This ligament is a band of tissue that keeps the liver anchored to the diaphragm.

A layer of fibrous tissue called Glisson's capsule covers the outside of the liver. The peritoneum, a membrane that forms the lining of the abdominal cavity, then covers this.

This helps hold the liver in place and protects it from physical damage.

#### **Blood vessels**

Unlike most organs, the liver has two major sources of blood. The portal vein brings in nutrient-rich blood from the digestive system, and the hepatic artery carries oxygenated blood from the heart.

The blood vessels divide into small capillaries, with each ending in a lobule. Lobules are the functional units of the liver and consist of millions of cells called hepatocytes.

Three hepatic veins remove blood from the

#### liver. Functions

The liver is a gland that has many functions in the body. It is difficult to give a precise number, but it may have more than 500 distinct roles.

#### The major functions of the liver include:

• Bile production: Bile helps the small intestine break down and absorb fats, cholesterol, and some vitamins. Bile consists of bile salts, cholesterol, bilirubin, electrolytes, and water.

• Absorbing and metabolizing bilirubin: The breakdown of hemoglobin forms bilirubin. The liver or bone marrow stores iron released from hemoglobin, which makes the next generation of blood cells.

• Supporting blood clots: Vitamin K is necessary to create coagulants that help clot the blood. Bile is essential for vitamin K absorption and forms in the liver. The liver must produce enough bile to make clotting factors. • Fat metabolization: Bile breaks down

fats and makes them easier to digest.

• Metabolizing carbohydrates: The liver stores carbohydrates. The body can break in 8—15 days. Researchers suggest surgical removal of the right or left lobe of the liver redown stored carbohydrates in the liver, known as glycogen, into glucose. Glucose, or sugar, is released into the bloodstream to regulate blood sugar levels and for a quick burst of en-

• Vitamin and mineral storage: The liver stores fat-soluble vitamins, known as vitamins A, D, E, K, and B12. It keeps significant amounts of these vitamins stored. The liver stores iron from hemoglobin in the form of ferritin, ready to make new red blood cells. The liver also stores and releases copper

• Helps metabolize proteins: Bile helps break down proteins for digestion.

• Filters the blood: The liver filters and removes compounds from the body, including hormones, such as estrogen and aldosterone, and compounds from outside the body, including alcohol and other drugs

• Immunological function: The liver is part of the mononuclear phagocyte system. Cells involved in immune activity, Kupffer cells, are found in high numbers in the liver. These cells destroy disease-causing viruses, bacteria, or other microorganisms that might enter the liver through the gut.

• Production of albumin: Albumin is the most common protein in blood serum. It transports fatty acids and steroid hormones to help support the correct pressure and prevent the leaking of blood vessels.

• Synthesis of angiotensinogen: This hormone raises blood pressure by narrowing the blood vessels when alerted by production of an enzyme called renin in the kidneys Regeneration

Because of the importance of the liver and its functions, evolution has ensured that it can regrow rapidly as long as it is kept healthy. All vertebrates, from fish to humans, have the ability to regrow the liver.

The liver is the only visceral organ that can regenerate. It can regenerate completely, as long as a minimum of about 25% of the tissue remains. The liver can regrow to its previous size and ability without any loss of function during the growth process.

Removal of two-thirds of the liver in mice causes the remaining liver tissue to regrow to its original size and restore function within 7—10 days. In humans, the process takes slightly longer, but regeneration can still occur sults in complete restoration of the liver mass after 3 months, while maximum cellular activity happens 7 to 10 days after the procedure. Over the following few weeks, the new liver

tissue becomes indistinguishable from the original tissue. A number of compounds are responsible for

liver regeneration, including growth factors and cytokines. Some of the most important compounds in the process appear to be but are not limited to:

Hepatocyte growth factor

- Insulin • Transforming growth factor-alpha
- Epidermal growth factor
- Interleukin-6
- Norepinephrine
- Diseases

An organ as complex as the liver can experience a range of problems. A healthy liver functions very efficiently. However, the consequences can be dangerous or even fatal in a diseased or malfunctioning liver. **Examples of liver disease include:** 

• Fascioliasis: The parasitic invasion of a

worm, known as a liver fluke, causes this condition. The liver fluke can lie dormant in the liver for months or even years. Fascioliasis is a tropical disease

• Cirrhosis: This sees scar tissue replace liver cells in a process known as fibrosis. Toxins, alcohol, and hepatitis are some of the many factors that cause this condition. Eventually, fibrosis can lead to liver failure because the functionality of liver cells becomes destroyed.

• Hepatitis: Hepatitis is the name given to a general infection of the liver, and viruses, toxins, or an autoimmune response can cause it. An inflamed liver characterizes this condition. In many cases, the liver can heal itself, but liver failure can occur in serious cases.

• Alcoholic liver disease: Drinking too much alcohol over long periods can cause liver damage.

• Primary sclerosing cholangitis (PSC): PSC is a serious inflammatory disease of the bile ducts that results in their destruction. There is currently no cure, and the cause is unknown.

• Fatty liver disease: This usually occurs alongside obesity or the harmful use of alcoup in the liver cells. Nonalcoholic fatty liver disease occurs when alcohol use is not the cause

• Gilbert's syndrome: This is a genetic disorder affecting 4—16% of the population. In Gilbert's syndrome, the body does not fully break down bilirubin. Mild jaundice can occur, but the disorder is harmless.

• Liver cancer: The most common types of liver cancer are hepatocellular carcinoma and cholangiocarcinoma. The leading causes are alcohol and hepatitis. It is the sixth most common form of cancer globally and the third most frequent cause of cancer death around the world.

#### Health

Below are some recommendations from the American Liver Foundation to help keep the liver working as it should:

• Diet: As the liver is responsible for digesting fats, consuming too many can overwork the organ and disturb it from other tasks. This also has links to fatty liver disease.

• Moderate alcohol ingestion: Avoid consuming more than two drinks at a time. Drinking too much alcohol causes cirrhosis of the liver over time

• Avoiding illicit substances: Illicit substances can overload the liver with toxins. Avoiding these substances can allow the liver to perform its necessary functions without im-

• Caution when mixing medications: Some prescription drugs and natural remedies can interact negatively. Mixing drugs with al-

cohol puts significant pressure on the liver. • Protection against airborne chemicals: Airborne chemicals can cause liver damage. When painting or using strong cleaning or gardening chemicals, the area should be well ventilated, and people should wear a mask.

• Travel and vaccinations: Vaccination is essential if a person travels to an area where hepatitis A or B might be a concern. Malaria grows and multiplies in the liver, and yellow fever can lead to liver failure.


• Safe sex: There is no vaccination for hepatitis C. Safe sex practices can help prevent the disease

# Covid-19 lockdowns may have sped up age-related effects on the brain

recent study reported the somewhat alarming observation that the social disruptions of Covid-All lockdowns caused significant changes in teenagers' brains.

Using MRI data, researchers at the University of Washington in Seattle showed that the usual, age-related thinning of the cortex – the folded surface – of the adolescent brain accelerated after the lockdowns and the effect was greater in the female brain than the male. What are we to make of these findings?

Science shows the critical importance of adolescence for the brain. The notoriously different behaviour of teenagers is due to a large degree to the immaturity of their brain cortex. During adolescence, substantial anges take place to enable the brain to re One of these very important changes is the thinning of the cortex.

opment in adolescence, is it possible that the pandemic lockdowns really did accelerate harmful brain ageing in teenagers? And how strong is the evidence that it was due to the lockdowns and not something else?

To answer the first question, we have to realise that ageing and development are two sides of the same coin. They are inextricably linked. On the one hand, biological ageing is the progressive decline in the function of the body's cells, tissues and systems. On the other, development is the process by which we reach maturity.

Adverse conditions at critical periods of our life, especially adolescence, are very likely to influence our ageing trajectory. It is therefore plausible that the "accelerated maturation" of the teenage brain cortex is an age-related change that will affect the rate of brain ageing throughout life.



### How did the human brain evolve to be Lethal Smog: How pollution surge fuels stroke cases so large? The answer may be in our guts

ur gut microbes may hold the key o understanding the evolution of the human brain. Researchers have proposed that these tiny organisms could have provided the essential energy boost that allowed our brains to grow to such extraordinary sizes. With the largest relative brain size of all primates, humans spend more total energy than expected based on their body size, the study published in the journal Microbial Genomics noted.

"Variation in the gut microbiota represents an unexplored mechanism through which primate metabolism could facilitate different brain energetic requirements," the researchers wrote in their study.

Gut microbes use fibre and amino acids to produce short-chain fatty acids (SCFA), acetate, butyrate and propionate, all of which serve as energy sources for their human hosts. The energy is produced through metabolic processes such as appetite and satiety, carbohydrate conversion to fatty acids, cholesterol and triglyceride production and glucose-insulin metabolism. SCFAs also interact with host metabolic processes, increasing glucose production to meet the high energy demands of large brains. The energy could also have an impact on other bodily functions like growth, maintenance and fat deposition.

Another role played by SCFAs is facilitating communication between the gut and brain, making them an important target for understanding brain evolution. To learn more, the researchers implanted gut microbes from two large-brained primate species (humans and squirrel monkeys) and one small-brained primate (macaque) into mice. The experiment revealed that mice with gut microbes from large-sized brains produced and used more energy, while those from the small-brain species

stored more energy as fat. "We know the community of microbes living in the large intestine can produce compounds that affect aspects of human biology - for example, causing changes to metabolism that can lead to insulin resistance and weight gain," first author of the paper Katherine Amato, associate professor of anthropology at Northwestern University, said in a statement. The researchers also found that mice

with microbes from humans and squirrel monkeys exhibited similar biological characteristics, which could be driven by their shared trait of large brains.

The two larger-brained primate species are not close evolutionary relatives of one another. But they share two common features — they exhibit rapid brain growth after birth and have a relatively large brain for their body size. This means the two species require more energy to support the brain across the lifecycle.

Larger-brained primates tend to have higher blood glucose levels and lower body fat. The scientists found that mice given gut microbes from large-brained mammals exhibited reduced growth and body fat, suggesting that gut microbes may influence energy allocation, diverting resources away from body growth and fat storage toward the brain.

However, humans differ from other large-brained primates. While they exhibit increased glucose levels for brain energy, they also have higher body fat. While the former provides energy to the brain, the extra body fat could serve as a backup energy source for the brain, especially during periods of low food availability or ineased energy demand.

Although the mice with human gut microbes did not show an increase in body fat typical of humans, the researchers speculate that this could be because of the restricted energy budgets of mice compared to humans. (Courtesy: Down to Earth)

ir pollution has long been recognized as a significant contributor to respiratory and cardiovascular diseases. However, growing evidence now highlights its alarming connection to stroke, one of the leading causes of death and disability worldwide. The recent surge in pollution levels across North India has underscored this link, with deteriorating air quality posing severe risks to public health, including an increased incidence of strokes.

How Pollution Contributes to Stroke Stroke occurs when blood flow to the brain is interrupted due to a clot or bleeding, leading to brain cell damage. While lifestyle factors like poor diet and sedentary habits are well-established stroke risk factors, air pollution has emerged as a silent yet potent contributor.

Fine particulate matter, nitrogen dioxide, and other pollutants can infiltrate the bloodstream, causing inflammation and oxidative stress. These processes damage blood vessels, accelerate atherosclerosis (narrowing of arteries), and raise blood pressure, all of which heighten the risk of ischemic and haemorrhagic strokes. Studies suggest that even short-term exposure to high pollution levels can trigger strokes in vulnerable individuals, while prolonged exposure significantly increases the lifetime risk.

#### The Situation in North India

North India, particularly during the winter months, experiences hazardous pollution levels due to a combination of factors such as stubble burning, vehicular emissions, and industrial discharge. Cities like New Delhi and its surrounding regions frequently record air quality indices (AQIs) in the "severe" category. This toxic air is not only affecting

the lungs but is also contributing to a marked rise in stroke cases. Neurology departments across hospitals in North India report a surge in stroke-related admissions during high pollution periods. Patients with pre-existing conditions, such as hypertension or diabetes, are particularly susceptible to pollution-induced strokes.

#### Vulnerable Groups and Immediate Impact

Children, the elderly, and individuals with pre-existing cardiovascular conditions are most vulnerable to the effects of pollution. Pregnant women exposed to high pollution levels may also face increased risks of complications that could affect both maternal and foetal health, including the likelihood of strokes.

In urban areas with poor air quality, people are often unknowingly inhaling pollutants that compromise their cardiovascular systems over time. Shortterm spikes in pollution levels, such as during festive seasons or crop residue burning, can act as immediate triggers for strokes, leading to emergency situations in hospitals.

#### Mitigating the Risks

Tackling the pollution-stroke connection requires both individual and collective action. At a policy level, stricter regulations on emissions, better public transport systems, and promoting cleaner energy sources are critical. On an individual level, people can minimize exposure by wearing masks, using air purifiers, and avoiding outdoor activities during high-pollution days. WASHINGTON, Dec 8: President-elect Donald Trump said on Saturday that the US military should stay out of the escalating conflict in Syria as a shock opposition offensive closes in on the capital, declaring in a social media post, "THIS IS NOT OUR FIGHT."

With world leaders watching the rapid rebel advance against Syria's Russian-and Iranian-backed president, Bashar Assad, President Joe Biden's national security adviser separately stressed that the Biden administration had no intention of intervening.

ing as necessary to keep the Islamic State — a violently anti-Western extremist group not known to be involved in the offensive but with sleeper cells in Syria's deserts — from exploiting openings presented by the fighting. On Sunday, ex-Defence Minister Kim Yong Hyun was taken into custody at a Seoul detention facility after undergoing an investigation by prosecutors, a law enforcement official said, requesting anonymity in line

with privacy rules. The official gave no further details. But South Korean media reported that Kim voluntarily appeared at a Seoul prosecutors' office, where he had his mobile phone confiscated and was detained. The reports said police searched Kim's former office and residence on Sunday

Repeated calls to Seoul prosecutors' offices and police agency were unanswered Senior prosecutor Park Se-hyun

said in a televised statement Sunday that authorities launched a 62-member special investigation team on the marital law case. Park, who will head the team, said the probe would "leave no suspicions".

Yoon accepted Kim's resignation offer on Thursday after opposition parties submitted a separate impeachment motion against him.

Kim is a central figure in Yoon's martial law enforcement, which led to special forces troops encircling the National Assembly building and army helicopters hovering over it. The military withdrew after the parliament unanimously voted to overleadership, including Gandapur and turn Yoon's decree, forcing his Khan's wife Bushra Bibi, vanished Cabinet to lift it before daybreak from the scene when the law en-Wednesday forcers launched an operation to clear

In Kim's impeachment motion document, the Democratic Party and other opposition parties accused him of proposing martial law to Yoon. Vice Defence Minister Kim Seon Ho told parliament that Kim Yong Hyun ordered the deployment of troops to the National Assembly.

The Democratic Party called Yoon's martial law imposition "unconstitutional, illegal rebellion or a coup". It has filed complaints with police against at least nine people, including Yoon and Kim, over the alleged rebellion.

In a statement Wednesday, Kim The Chief Minister said he saw the said that "all troops who performed role of the Pakistan People's Party duties related to martial law were act-(PPP) and Pakistan Muslim League N ing on my instructions, and all re-(PML-N) in the crackdown against sponsibility lies with me". Prosecutor General Shim Woo

Jung told reporters on Thursday the prosecution plans to investigate the rebellion charges against Yoon following complaints. While the president mostly has immunity from prosecution while in office, that does not extend to allegations of rebellion or treason

The Defence Ministry said it has suspended three top military commanders over their alleged involvement in the martial law imposition. They were among those facing the opposition-raised rebellion allegations.

On Saturday, Yoon issued an apology over the martial law decree, saying he won't shirk legal or political responsibility for the declaration. He said he would leave it to his party to chart a course through the country's political turmoil, "including matters related to my term in office"

Since taking office in 2022 for a single five-year term, Yoon has struggled to push his agenda through an opposition-controlled parliament and grappled with low approval ratings amid scandals involving himself and his wife. In his martial law announcement on Tuesday night, Yoon called parliament a "den of criminals" bogging down state affairs and vowed to eliminate "shameless North Korea followers and anti-state forces.'

The declaration of martial law was the first of its kind in more than 40 years in South Korea. The turmoil has sparked alarm among key diplomatic partners like the US and Japan.

The scrapping of Yoon's impeachment motion is expected to intensify protests calling for his ouster and deepen political chaos in South Korea, with a survey suggesting a majority of South Koreans support the president's impeachment. Yoon's martial law declaration drew criticism from the conservative ruling party, but it is determined to oppose Yoon's impeachment apparently because it fears losing the presidency to liberals.

Ruling People Power Party leader Han Dong-hun said Sunday the PPP will work with the government to determine Yoon's early and orderly exit from office in a way that minimises confusion, but he didn't say when that would happen. He also claimed Yoon will not be involved in state affairs, including foreign policy.

Yoon's presidential office didn't immediately respond. The Democratic Party criticised Han Donghun's comments, saying that the exclusion of an incumbent president from state affairs isn't supported by the constitution. The party said authorities should immediately arrest Yoon and all others implicated in the case. The presidential office said Sunday that Yoon accepted the resignation offer by Safety Minister Lee Sang-min, who has also faced an opposition-led impeachment motion over his alleged role in the martial law enforcement. (AP)

President-elect Donald Trump takes office next month.

The latest package will include more drones and munitions for the High Mobility Artillery Rocket Systems, or HIMARS, that the US has provided. While these weapons are critically needed now, they will be funded through the Ukraine Security Assistance Initiative, which pays for longer-term systems to be put on contract.

The weapon systems purchased are often intended to support Ukraine's future military capabilities, not make an immediate difference on the battlefield.

The USD 988 million package is on top of an additional USD 725 million in US military assistance, including counter-drone systems and HIMARS munitions, announced Monday that would be drawn from the Pentagon's stockpiles to more quickly get to the front lines.

The US has provided Ukraine with more than USD 62 billion in military aid since Russia's invasion in February 2022.

"The baton will soon be passed," Austin said. "Others will decide the course ahead. And I hope that they will build on the strength that we have forged over the past four years."

Ukraine is facing an intensified onslaught by Russia, which is now using thousands of North Korean troops to augment its fight to take back the Kursk region. Moscow also has launched an intermediaterange ballistic missile and regularly strikes Kyiv's civilian infrastructure.

With questions about whether Trump will maintain military support to Ukraine, the Biden administration has been trying to spend every dollar remaining from a massive foreign aid bill passed earlier this year to put Ukraine in the strongest position possible.

"This administration has made its choice. So has a bipartisan coalition in Congress. The next administration must make its own choice," Austin said in a speech at an annual gathering of national security officials, defence firms and lawmakers at the Ronald Reagan Presidential Library in Simi Valley, California.

Trump, a longtime admirer of Russian President Vladimir Putin, has criticised US aid for Ukraine and called for bringing a quick end to the war, raising concerns in Ukraine about what terms may be laid out for any future negotiations. Austin said he was "confident that President Reagan would have stood on the side of Ukraine, American security and human freedom"

It was one of Austin's last major speeches as President Joe Biden's defence secretary and a cap to his more than 41 years serving as a soldier and general.

Under Austin's watch, the Pentagon in 2022 launched a regular meeting that now counts more than 50 countries to figure out how to get the tens of millions of rounds of ammunition and billions of dollars in advanced weaponry to Ukraine. Without that flow of support, it's possible the country would have fallen to Russia after it invaded. "Together, we have helped Ukraine survive an all-out assault by the largest military in

Europe," Austin said. Austin and Kentucky Sen. Mitch McConnell, the longtime Republican leader, were honored at the conference for their lifetime of service, and they used the opportunity to press for the US to continue to build and support its alliances, a sharp contrast to Trump's "America First" policy.

Austin called the Ukraine Defence Contact Group "the most consequential global coalition since the time of President George H.W. Bush and Iraq's 1990 invasion of Kuwait", showing that "America and our friends have become the arsenal of Ukrainian democracy'

Before Saturday's announcement, there was roughly USD 8 billion left to use to pull existing weapons out of US stockpiles and to put additional weapons on contract to help Ukraine.

"We're not going to stop Putin by telling Ukraine we aren't going to give you anything more," Rep. Adam Smith of Washington state. the top Democrat on the House Armed Services Committee, said at a panel at the Reagan National Defense Forum. (AP)

# Bangladesh's Foreign Affairs Adviser optimistic about resolving standoff in ties with India

DHAKA, Dec 8: Bangladesh and India will be able to overcome the stalemate in the relationship witnessed in recent months, Foreign Affairs Adviser Md Touhid Hossain said here on Sunday.

His comments came ahead of Indian Foreign Secretary Vikram Misri's visit to Bangladesh on Monday during which he is likely to raise with Dhaka India's concerns over attacks on Hindus after a massive uprising ended deposed prime minister Sheikh Hasina's 15-year rule in August. This will be the first visit to be made by a senior Indian government official to Bangladesh since the interim government came to power on August

"We expect that we will be able to overcome this impasse. Establishing mutual communication and meeting each other is very important to overcome any such stalemate," Hossain told a seminar titled 'SAARC - People of South Asia Crave' at the National Press Club.

"I hope they (foreign secretaries) will have a

fruitful discussion," he said. He noted that it is important to acknowledge that there is a problem if they want to solve any problem.

Hossain, a career diplomat, said it is also important to note that the relations between Bangladesh and India witnessed changes after August 5, and both sides need to try and take forward the relations and accept this changed reality.

The downturn that the two countries witnessed over the last few months in terms of bilateral business activities affected both sides, he said.

He also referred to the impacts on businesses in Kolkata and West Bengal.

Bangladesh's foreign office spokesperson Mohammad Rafiqul Alam said efforts were made to keep all the elements of the bilateral relations on the agenda during the Foreign Office Consultation with India. He described trade, border management, connectivity, and water issues as the key areas expected to be discussed.

The close ties between India and Bangladesh

came under severe strain after Hasina was forced to leave the country in the face of a massive antigovernment protest in August. Yunus came to power days after Hasina took shelter in India.

The relations deteriorated further in recent weeks over attacks on Hindus and the arrest of Hindu monk Chinmoy Krishna Das.

There have been a spate of incidents of violence against Hindus and other minorities as well as attacks on temples in the neighbouring country in the last few weeks that triggered strong concerns in New Delhi.

"Our position on the matter is very clear -- the interim government must live up to its responsibility of protecting all minorities," External Affairs Ministry spokesperson Randhir Jaiswal said on November 29.

India also hoped that the case relating to Bangladeshi monk Chinmoy Krishna Das, arrested on a charge of sedition, would be dealt with in a just, fair and transparent manner. (PTI)

# 2 Pearl Harbour survivors, ages 104 and 102, return to Hawaii to honour those killed in 1941 attack

**PEARL HARBOUR** (HAWAII), **Dec 8:** Ira "Ike" Schab, a 104-yearold Pearl Harbour attack survivor, spent six weeks in physical therapy to build the strength to stand and salute during a remembrance ceremony honouring those killed in the Japanese bombing that thrust the US into World War II some 83 years ago.

On Saturday, Schab gingerly rose from his wheelchair and raised his right hand, returning a salute delivered by sailors standing on a destroyer and a submarine passing by in the harbour.

"He's been working hard because this is his goal," said his daughter, Kimberlee Heinrichs, who travelled to Hawaii with Schab from their Beaverton, Oregon, home so they could attend the ceremony. "He wanted to be able to stand for that." Schab is one of only two servicemen who lived through the attack who made it to an annual remembrance ceremony hosted by the US Navy and National Park Service on a grass field overlooking the harbour. A third survivor had been planning to join them but had to cancel because of health issues.

The December 7, 1941 bombing killed more than 2,300 US service-

Ken Stevens, 102, who served on the USS Whitney, joined Schab at the ceremony. USS Curtiss sailor Bob Fernandez, 100, had planned to attend but had to cancel due to health issues.

Ceremony attendees observed a moment of silence at 7:54 a.m., the same time the attack began eight decades ago. F-22 jets in missing man formation flew overhead shortly after. Fernandez, speaking before the ceremony, recalled feeling shocked and surprised as the attack began.

"When those things go off like that, we didn't know what's what," said Fernandez. "We didn't even know we were in a war."

Fernandez was a mess cook on the Curtiss and his job that morning was to bring sailors coffee and food as he waited tables during breakfast. Then they heard an alarm sound. Through a porthole, Fernandez saw a plane with the red ball insignia painted on Japan-

Fernandez rushed down three decks to a magazine room where he and other sailors waited for someone to unlock a door storing 5-inch (12.7centimeter), 38-caliber shells so they could begin passing them to the ship's guns. He has told interviewers over the years that some of his fellow sailors were praying and crying as they heard gunfire up above.

"I felt kind of scared because I didn't know what the hell was going on," Fernandez said.

The ship's guns hit a Japanese plane that crashed into one of its cranes. Shortly after, its guns hit a dive bomber that then slammed into the ship and exploded below deck, setting the hangar and main decks on fire, according to the Navy History and Heritage Command.

Fernandez's ship, the Curtiss, lost 21 men and nearly 60 of its sailors were injured. Many laud Pearl Harbour survivors as heroes, but Fernandez doesn't view himself that way.

"I'm not a hero," he told The Associated Press in a phone interview from California, where he now lives with his nephew in Lodi.

"I'm just nothing but an ammunition passer." (AP)

Prolonged violence, internet shutdown, curfew affecting students in Manipur: Academics



IMPHAL, Dec 8: Prolonged violence in Manipur with frequent internet shutdowns, curfews and general strikes is affecting the academic and career pursuits of students pursuing higher education in the northeastern state, many edu-

cationists said. With frequent internet shutdowns, students are facing problems in having access to online resources and many recruiters are hesitant to visit campuses in Manipur for placement drive due to curfews and general strikes, they said

Head of the Department of Computer Science and Engineering and also in charge of placement of National Institute of Technology (NIT) Manipur, K H Johnson Singh told PTI "We have witnessed a decline in recruitment drives after violence broke out in the state. At least 40 companies (online mode) came and 70 students have been selected this year. This is much less than what we were used to before the outbreak of violence. We had expected selection of some 100 students and some 50 companies.

He said, "Recruiters who prefer offline mode of interviews are much reluctant to visit for campus interviews. Despite our consistent assurance that the NIT campus is safe and just 20 minutes from the airport, the media images of tyres burning in the streets, mob violence and gunfights at peripheral areas seemed to have affected their psychology."

Eighty per cent of our students stay in hostels within the campus and have access to broadband 24 hours a day, he added.

Assistant professor of mass

Timely completion of assignments given to students is also affected as many students do not have broadbands at their homes.

Internet shutdown also has severely affected career counselling agencies with many senior counsellors unable to provide desired information flow to students seeking employment. Counsellors also said that submission of resumes to national companies has been affected.

Sapam Joychandra, director of SS Career Counselling told PTI, 'We are unable to conduct psychometric assessment of students that would help chart out a career route for the concerned student. Counselling through zoom, online mock tests and other tools have been affected. Students are unable to submit their resumes on time to outside companies. Those having broadband is very limited and the majority of the students rely on mobile data internet services for every form of update related to their education and career. For my organisation alone, there is a drastic change of 90 per cent in student guiding activities before and after the violence.

# Tourist from UK dies of cardiac arrest at Hornbill Festival

KOHIMA, Dec 8: A tourist from the UK attending the Hornbill Festival in Nagaland died of cardiac arrest, police said Sunday.

The 67-year-old man complained of severe chest pain on Saturday evening and was rushed to a health camp located at the festival venue, Naga Heritage Village Kisama, they said.

From there, he was referred to a hospital, following which he was taken to the state capital Kohima, around 12 km away. He was admitted to a private hospital where he breathed his last later in the night, they added.

The man was travelling alone with a tour guide, officials said. All arrangements were made by the state Tourism Department to send the body back to his home, they said. Over 1.22 lakh people have attended the 10-day festival since it began on December 1. Among them were 2,085 foreigners and 30,816 tourists from other states of India. (PTI)

# Muzzle loading shooting a big hit at Hornbill fest

Single-barrelled guns cost ₹8,500 while the double-barrelled guns are priced at ₹18,000

DIMAPUR, Dec 8: The muzzle loading shooting experience at the Hornbill Festival at Kisama is witnessing a growing interest among tourists from far and near.

This traditional activity, deeply rooted in local heritage has become a unique attraction during the festival.

Two Konyak gunsmiths from Changlangshu village in Mon district K Moba and Nyeiba, having experience of 35 years in gun-making, have put up a stall at Craftscape, Kisama, showcasing the traditional way of gun-making.

Their products, known for their quality and durability, are being sold across Nagaland and outside the state. They also take special orders on request and are also making guns at the site.

Single-barrelled guns cost ₹ 8,500 while the double-barrelled guns are priced at ₹ 18.000.

The Konyak Nagas are expert gunsmiths. Their origin of gun-making is obscure but the knowledge has existed within the com-



munity for a long time. Historically, these guns are handmade by blacksmiths in the villages using a combination of wood and metals often recycled

from old materials

The Konyak morung (a traditional youth dormitory or club) at the festival venue provides visitors with an experience of muzzle-loading gun shooting and is attracting many visitors to the ongoing Hornbill Festival.

A fee of ₹ 200 per shot allows tourists to experience the thrill of firing historic muzzle loading guns under supervision. These guns, which date back to centuries-old traditions, were once a vital part of the region's hunting and defensive practices.

The use of muzzle guns demonstrates the tribe's historical proficiency in crafting weapons and their importance in ceremonial occasions. This feature provides insight into the state's cultural and historical past. as do other examples of traditional warfare. Meanwhile, the eighth day of the 25th Hornbill Festival on Sunday celebrated the vibrant cultural heritage of Nagaland, with 18 cultural troupes presenting diverse traditional performances at the main arena in Kisama.



### body polls to be held on Dec 21

CHANDIGARH, Dec 8: Elections to five municipal corporations and 44 municipal councils and nagar panchayats in Punjab will be held on December 21, the State Election Commission said on Sunday. All necessary arrangements have been made for the civic body polls, it said.

Addressing the media here, State Election Commissioner Raj Kamal Chaudhari said polling for five municipal corporations and 44 municipal councils and nagar panchayats will take place on December 21 from 7 am to 4 pm.

"The model code of conduct will come into force from today," he said. The five municipal corporations going to polls are Amritsar, Jalandhar, Ludhiana, Patiala and Phagwara.

The process of filling nominations will start from December 9 and the last date will be December 12. Scrutiny of nomination papers will be done on December 13 and the last date for the withdrawal of nominations will be December 14, Chaudhari said. He said 37.32 lakh voters, including 17.75 lakh females and 204 others, are eligible to cast their votes in these elections. (PTI)

Earlier this week, police registered a case against more than 200 persons from the village and nearby areas for allegedly trying to conduct a "re-election" using ballot papers in an unauthorised manner.

Pawar, accompanied by several NCP (SP) leaders, including Jayant Patil, met villagers.

MUMBAI, Dec 8: BJP's Rahul Narwekar is poised to be elected unopposed as the speaker of the Maharashtra legislative assembly, with the opposition alliance Maha Vikas Aghadi (MVA) deciding not to put up a contest.

Narwekar, who was the speaker in the 14th assembly for two and a half years and gave the key verdicts tied to the Shiv Sena and NCP, was reelected from the Colaba assembly seat in Mumbai.

Accompanied by Chief Minister Devendra Fadnavis and his deputies Eknath Shinde and Ajit Pawar, Narwekar filed his nomination before the legislature secretary Jitendra Bhole on Sunday.

MVA leaders met Fadnavis and urged him to follow the protocol of giving the deputy speaker's post to the opposition. They also sought the post of the leader of the opposition.

The speaker's election will be formally announced in the House on Monday. This will be followed by a floor test to prove the new government's strength. Governor CP Radhakrishnan will then address the joint session of both Houses of the state legislature.

During his tenure as Maharashtra assembly speaker, Narwekar had ruled that the party led by Eknath Shinde was the legitimate and "real Shiv Sena" after a split in the Bal Thackeray-founded party.

He also held that the faction under Ajit Pawar was the real Nationalist Congress Party (NCP), which was founded by Sharad Pawar.

In the recently concluded Maharashtra assembly elections, the Mahavuti coalition piled up stunning numbers, winning over 230 of the 288 seats, while the MVA collectively got only 46 seats.

# Foreign Secretary Misri to visit Dhaka on Monday amid frosty India-Bangladesh ties



**RANCHI, Dec 8:** The Bharatiya Janata Party (BJP) will launch its membership drive in Jharkhand from December 22.

NEW DELHI, Dec 8: Foreign Secretary Vikram Misri is expected to raise with Dhaka India's concerns over attacks on Hindus and other minorities as he embarks on a day-long visit to Bangladesh on Monday, in the first high-level trip from New Delhi after a massive uprising ended deposed prime minister Sheikh Hasina's 15-year rule in August.

Misri is scheduled to hold wideranging talks with his Bangladeshi counterpart Md. Jashim Uddin and meet the country's de-facto foreign minister Mohammad Touhid Hossain

It is learnt that the Indian foreign secretary is also likely to call on Bangladesh's interim leader and Nobel Peace laureate Muhammad Yunus during his nearly 12-hour visit to Dhaka

On its part, Bangladesh is likely to convey its concerns over India continuing to provide shelter to

Hasina. Last month, Yunus said his government will seek Hasina's extradition from India, people familiar with Misri's visit said.

The close ties between India and Bangladesh came under severe strain after Hasina was forced to leave the country in the face of a massive anti-government protest in August. Yunus came to power days after Hasina took shelter in India. The relations deteriorated fur-

ther in recent weeks over attacks on Hindus and the arrest of Hindu monk Chinmoy Krishna Das.

There have been spate of incidents of violence against Hindus and other minorities as well as attacks on temples in the neighbouring country in the last few weeks that triggered strong concerns in New Delhi

"Our position on the matter is very clear -- the interim govern-

ment must live up to its responsibility of protecting all minorities," External Affairs Ministry spokesperson Randhir Jaiswal said on November 29

"We are concerned at the surge of extremist rhetoric, increasing incidents of violence and provocation. These developments cannot be dismissed only as media exaggeration. We once again call upon Bangladesh to take all steps for the protection of minorities," he said. India also hoped that the case re-

lating to Bangladeshi monk Chinmoy Krishna Das, arrested on a charge of sedition, will be dealt with in a just, fair and transparent manner.

In the meetings, the Bangladeshi side is also likely to raise an incident of storming of its mission in Agartala on Monday by a group of protesters

Subsequently, Bangladesh foreign ministry on Tuesday sum-

moned the Indian envoy to Dhaka Pranay Verma and lodged a protest over the incident. West Bengal, Assam, Megha-

laya and Tripura witnessed protests in the last few days over the persecution of Hindus in Bangladesh and the arrest of Das.

Das was arrested at Dhaka's Hazrat Shahialal International Airport last month in connection with sedition case.

India on Friday announced that Misri is travelling to Dhaka to attend a meeting under the framework of Foreign Office Consultations.

"The foreign secretary is scheduled to visit Bangladesh for Foreign Office Consultations on December 9. This is part of our structured interactions with the Bangladesh side," Ministry of External Affairs (MEA) Spokesperson Randhir Jaiswal said in brief remarks. (PTI)

# Farmers' march stopped at barricades, teargas shells fired

SHAMBHU, Dec 8: A 'jatha' (group) of 101 farmers resumed its foot march to Delhi Sunday afternoon from the Shambhu protest site on the Punjab-Haryana border, but was soon halted by a multilayered barricading erected by the Haryana security personnel. Teargas shells were lobbed and water jets

were shot through cannons to disperse the protesters after they reached the barricades. Ambala police had earlier said the farmers' outfits may march to Delhi only after getting permission from the national capital administration

The group, dubbed as 'marjeevras', (someone willing to die for a cause), was marching for a legal guarantee for Minimum Support Price. They were stopped only a few metres away

One of the Haryana security personnel was seen asking farmers to show permission to march to Delhi

"First we will identify them to see whether they have any permission. We have got the list (of 101 farmers) but they are not those whose names are mentioned in the list. They are not giving their identities which means they are coming in the shape of a mob," he told reporters at the site.

A farmer said, "They are saying that our names were not on the list. We do not know which list they have. When we asked them whether they would allow us to move ahead after verifying our identities, they told us then we would have to show the permis-



As the confrontation escalated, the security forces lobbed tear gas shells.

The gas forced the farmers, many of whom had covered their faces and were wearing protective eyewear, to recede a few metres. Some tried to cover the shells with wet jute bags.

Farmers claimed that one of the protesters was injured in the attack and had to seek hospital care. Punjab farmer leader Sarwan Singh Pandher said their protest reached 300 days on Sunday.

In another recent incident, a Pakistani youth named Mohammed Asad from Lahore drove to the zero line on his motorcycle and seemingly awaited arrest by the BSF. During interrogation, he claimed to have had a family dispute over his girlfriend

The officials noted that Asad, who was subsequently moved to prison, may have been acting as a courier. Security agencies have requested additional custody for extended interrogation.

In October, a 31-year-old man who identified himself as Shahid Imran entered India through the Jammu sector, claiming that he wanted to visit a Kali temple to get married.

The officials explained that such infiltrators are generally booked under the Foreigners Act and Passports Act, for which the punishment ranges from two years to eight years in prison and following this, they are deported.

They said that in the late-1990s and early-2000s, ISI exploited the Samjhauta Express, the rail link between India and Pakistan, for covert courier operations, employing individuals known as "sawari operators". This service continued until February 2019, when the train service was halted.

The "sawari operators" played a crucial role in smuggling drugs and transporting funds intended to finance terrorist activities in Jammu and Kashmir, as well as Punjab.

However, following a significant crackdown by authorities, these operations were effectively curtailed, leading to the arrest and imprisonment of numerous individuals involved in such activities.

Recent developments suggest that the ISI's current method of sending couriers mirrors these past tactics.

The officials said that the infiltration strategies being employed now are reminiscent of the past, as the agency seeks new ways to bypass law enforcement and deliver crucial communication and resources across the border. (PTI)

# Tantrik dies in Gujarat police's custody; officials claim he committed 12 murders



AHMEDABAD, Dec 8: A 42-year-old tantrik arrested for allegedly conspiring to murder a businessman died in police custody in Gujarat's Ahmedabad on Sunday after admitting to killing 12 people by giving them drinks laced with a chemical, police said.

The Sarkhej police arrested Navalsinh Chavda around 1 am on December 3 when he was on his way to commit the crime after his partner for a taxi business with whom he shared the plan tipped off the police, an official said.

The police secured Chavda's remand till 3 pm on December 10 for further probe into his occult practices and possible involvement in human sacrifices, he said.

"Around 10 am on Sunday, Chavda fell ill and was rushed to the civil hospital in an ambulance, but the doctors declared him dead on arrival. The accused confessed to 12 murders during interrogation, and all deaths had occurred due to consumption of sodium nitrite," the official said.

Deputy Commissioner of Police (DCP) Shivam Verma said the accused confessed to having committed 12 murders by making his victims consume sodium nitrite dissolved in water during occult rituals.

CHENNAI, Dec 8: ISRO's successful launch of European Space Agency's (ESA) Proba-3 satellites onboard PSLV-C59 rocket is a 'groundbreaking mis-Sun, Venkitakrishnan said. sion' and would significantly advance the understanding of Sun's corona and solar wind, a former ISRO scientist said.

According to P V Venkitakrishnan, former director of Capacity Building Programme Office, ISRO headquarters, the 'innovative design and advanced technologies' used in the mission would pave the way for future space weather forecasting and solar physics research.

"This mission is a collaborative effort between the European Space Agency (ESA) and the Indian Space Research Organisation. Proba-3 is a pioneering mission designed to explore the Sun's corona, the outer atmosphere of the Sun", he told PTI.

It aims to study the Corona, which is

hotter than the Sun's surface, and explore the solar wind which is a stream of charged particles emanating from the

"The data from Proba-3 satellites would help scientists better understand and predict space weather events, which can impact the Earth's magnetic field and satellite operations."

He noted that the two satellites --Coronagraph and Occulter-- would form a 'precise formation 150 meters apart after several orbital manoeuvres in the coming days.

The instrument in the Coronagraph spacecraft would capture high-resolution images of the Sun's corona. This setup will mimic a total solar eclipse which traditionally lasts only for a few minutes and does not occur frequently. Proba 3 will provide 6 continuous

eclipses annually.

Due to poisoning, several of his victims died of heart attacks, while the nature of the deaths of a few other victims was a matter of investigation, the official said.

Chavda had found out about the chemical from another tantrik. The substance would take effect 15 to 20 minutes after consumption and cause heart attack, etc., leading to death, he said. The accused called himself a "bhuvaji" and proclaimed that he had the power to perform magic and miracles. He also had an ashram at Wadhwan in Surendranagar where he practised black magic, police said.

He would offer to multiply his victims' wealth or solve their problems, they said. The police had recovered incriminating evidence from Chavda's vehicle, including items used in rituals and white powder. (PTI)

#### **Drop in student numbers impact** Indigenous PM2.5 sensor to tackle air quality Kota's coaching, hostel industry challenges under works at IIT-Kanpur

KOTA (RAJASTHAN), Dec 8: Business has slowed down for coaching centres and hostels in Kota following negative publicity over student suicides, new guidelines regulating coaching centres and the expansion of coaching brands to other cities, according to industry stakeholders.

The number of students in Kota has fallen to 85,000 to 1 lakh this year from the usual 2 to 2.5 lakh, reducing the annual revenue to ₹ 3,500 crore from ₹ 6,500 to 7,000 crore, they said.

Despite the setback, stakeholders remain optimistic about the credibility of the Kota coaching model and its environment, that is absent in other cities.

Kota's educational system and environment are unmatched and will attract students back next session, which will compensate for the decline, Govindram Mittal, Zonal Chairperson, United Council of Rajasthan Industries said.

He said that industrialists are also looking at alternative opportunities, with plans to establish Information Technology (IT) hubs in the city, modelled after Bengaluru. Earlier this year, the Karnataka

government approved a Bill seeking to reserve 50 per cent of management positions and 75 per cent of non-management positions in private sector for locals, drawing criticism from across the industry.

Industrialists here have approached companies based in Bengaluru to shift base to Kota and after a nod from these companies, land for IT sectors have been earmarked under the direction of Lok Sabha speaker and Kota-Bundi MP Om Birla, Mittal said. President of Kota Hostel Association Naveen Mittal said that the coaching centre and hostel industry here is certainly in crisis. Some owners who have built several hostels on loans are finding it difficult to pay back installments.

He said that the crisis has hit hostel owners hard, with occupancy down to 40 to 50 per cent in most of the city's 4,500 hostels. According to the National

Crime Records Bureau (NCRB), Kota ranks behind 50 cities in terms of suicide rates, yet the city has been portrayed negatively, Naveen emphasised.

The room rents have dipped from ₹ 15,000 to ₹ 9,000 and many hostels remain vacant, Manik Sahani, a hostel manager in Coral Park said. "The quality of teaching in

Kota is far better than in other cities. The environment is excellent for studies," Priyadarshani Panna, a NEET aspirant from Odisha said. "Kota gives the best facilities and environment for education and accommodation. This was the reason I chose to prepare for NEET in Kota", another student from Jalore district said. This is the first time in decades that the student hub here has seen a sharp drop of 30-40 per cent in the

number of students coming in. Kota's annual average student strength was close to 1.5 lakh in 2023 and this year it's down to 85,000, the industry stakeholders claimed. (PTI)

NEW DELHI, Dec 8: An indigenous PM2.5 sensor designed for affordability and scalability is

being developed to address the Global South's air quality challenges, Professor S N Tripathi, Dean of the Kotak School of Sustainability at IIT-Kanpur, said.

The sensor is being developed by the Airawat Research Foundation at IIT-Kanpur, with a demonstration planned by mid-2025 and a market launch expected in early 2026, he said.

"This cost-effective solution encourages community participation, enabling the collection of realtime, granular air quality data. Such data can help government departments pinpoint pollution sources and implement localised, just-in-time interventions," Professor Tripathi told PTI.

He highlighted the stark disparity in air quality monitoring infrastructure, with many rural areas going unmonitored.

He proposed a suite of technolo-



gies, including portable air quality sensors, mobile Real-Time Source Apportionment (RTSA) labs, and drone-based vertical profiling, to

address this gap. The innovations aim to provide detailed, accurate data for decentralised policy actions tailored to local conditions, he said.

At the Kotak School of Sustainability, efforts are underway to insustainability tegrate into

educational curricula and research initiatives, he said.

The professor said that the school draws on principles like

Rta' (harmony with nature) and 'Aparigraha' (minimalist living) from ancient Indian texts, combining them with artificial intelligence and large language models.

"We aim to create transdisciplinary education essential for addressing complex challenges like

climate change. From revising school curricula to introducing an MTech programme in climate and sustainability, we're working to embed sustainability at every level of education," Tripathi said.

The school is also leveraging partnerships with AICTE and NCERT to make sustainability a central theme across the Indian educational framework.

"We've developed AI models to forecast CNG demand and optimise truck routing in cities like Ahmedabad and Rohtak. Such solutions are being adapted for government agencies and other urban contexts," Tripathi said.

A notable achievement is the use of 'Digital Twin' technology to create digital replicas of real-world systems, he said.

In Bengaluru, a traffic flow model, developed as a pilot project, is capable of forecasting congestion and optimising infrastructure planning, such as metro line routes, he said. (PTI)

# Bollywood largely offers stereotypical roles to me, lucky to have got diverse roles: Sanjay Mishra

**MUMBAI, Dec 8:** Actor Sanjay Mishra says he is grateful to directors who gave him the opportunities to play diverse characters, especially in an industry that is fixated on casting him in comedic roles.

The actor has established a name for himself, primarily through comedic roles in films like "Golmaal: Fun Unlimited", "Dhamaal", "All the Best: Fun Begins", "Bunty Aur Babli", and "Bhool Bhulaiyaa" two and three, among others.

At the same, Mishra has also showcased his range as an actor with performance-driven parts in films such as "Ankhon Dekhi', "Masaan", "Vadh", and "Bhakshak". "Rajat Kapoor and Subhash Kapoor allowed me to be part of movies like 'Ankhon Dekhi' and 'Phas Gaye Re Obama' respectively. But here in the industry, they offer similar roles to an actor.

"For instance, they need Johnny Lever, and Sanjay Mishra for a particular scene in a movie, and cast them in those parts," Mishra told PTI in an interview.

Citing the example of late Hindi

cinema icon Mehmood, the actor
said people knew him mostly for
comedic roles but he also made
"Kunwara Baap", a film with a serious message about polio vaccination. "If you don't take a chance,
then how will things change?" he asked.

Mishra believes that it is the fear of losing money that prevents filmmakers from casting actors like him in more unconventional roles.

"A lot of money goes into making a movie. For instance, if I would've got the role of Bhoot in 'Bhool Bhulaiyaa', then the film would be minus ₹. 400 crores.

"In the industry, it is fixed that this kind of role is made for so-andso actors because it is about math (return on investment). That's why content-driven films are being made and you can do what you wish to do (with them)," he said.

Mishra, however, is committed to exploring diverse roles.

He is set to appear in the upcoming feature "Jaaiye Aap Kahan Jaayenge", a fictional tale where a man named Kishan attempts to do good for society, especially women, by innovating a mobile toilet rickshaw to overcome this challenge.

The film stars Karan Aanand as Kishan, also known as Sadhu, Mishra as the father, Adrija as the daughter, and Monal Gajjar as the wife, alongside Ishtiyaq Khan, Neeraj Sood, Subrat Dutta, and Hrishita Bhatt in pivotal roles.

Mishra recounts his collaborative journey with director Nikhil Raj Singh and said the film developed during their road trips across India.

"We should do some films that other people will talk about and say to you, 'I'll watch the film too... When you are a part of a story since its development stage, then you've to do it. I'm sure people in the future will say, 'You did a good film'." Aanand expressed gratitude to the director for entrusting him with the role of Kishan.

"I liked the relationships shown in the film-between father-son, fatherdaughter, and husband-wife. There's a social message in the movie, which I believe will touch everyone. The film talks about a problem and





It did not disclose plans to replace Ashworth, who was one of the big hires under Ratcliffe after the British billionaire paid \$1.3 billion for a 27.7% stake in the storied club in February.

Ashworth, one of the most highly regarded sporting directors in soccer, was hired from Premier League rival Newcastle

dening leave during months of negotiations before taking up his new role in July.

Along with new chief executive Omar Berrada and Jason Wilcox as technical director, he was one three appointments seen as key to Ratcliffe's overhaul.

ADELAIDE, Dec 8: Pat Cummins felt his intervention was not required in the Travis Head-Mohammed Siraj send-off row since the Australia vice captain is a "big boy" who can talk for himself as the skipper hailed his team's behaviour in the ongoing series against India.

Head smashed a match-winning 140 from 141 balls in the pink ball Test as Australia bounced back from the humiliating defeat at Perth to win by 10 wickets and level the five-match series one-all.

After Head was cleaned up by Siraj, the two were seen exchanging words as the batter later suggested he had only said "well bowled".

Following Head's claim that Siraj's send-off was uncalled for, and that he had only praised the India pacer's delivery after being bowled, Siraj swiftly denied the accusation, calling it a "lie".

"Travis Head is vice-captain of the team, so he's a big boy. He can talk for himself," Cummins said during the post-match media interaction.

Siraj denied the Head claim and said, "I didn't say anything to him. In the press conference, he said the wrong thing. He lied. No way he said 'well-bowled'."

Addressing the matter, Cummins further said: "As a general rule, you normally let the boys be themselves. If you ever need to step in to intervene as captain, I

would, but as I said, for our group, I've never really felt like I've needed to do that.

Acknowledging the high stakes of the series with packed crowds every day, Cummins said: "It's a big series so there's a lot riding on it. The umpire stepped in pretty quickly, and that was the end of it." "To be honest, they can do

whatever they want. I'm more worried about our boys. Like always, I thought our boys' behaviour was excellent this week, like it seems to be every week."

Cummins went on to praise Head's match-turning innings and said he has the ability to put pressure on the opposition and take control of the game across

# Rohit, Kohli cut sorry figure; India crash to 10-wicket defeat in Adelaide

ADELAIDE, Dec 8: Rohit Sharma and Virat Kohli's never-ending technical problems against both pace and spin has set the alarm bells ringing as Indian batters capitulated twice in just 81 overs to lose the 'pink ball' Test against Australia by a comprehensive 10-wicket margin on the third day, here.

Australia maintained their tremendous record in day/night Tests and levelled the five-match series 1-1, bouncing back in style after their Perth debacle. They have now won 12 of the 13 day/night games they have played, losing only one pink ball Test in their history -- against the West Indies.

It was shortest-ever Test between India and Australia in terms of balls bowled. Only 1031 balls were bowled out of a possible 2700 legal deliveries.

Starting the day at 128 for 5, Nitish Kumar Reddy's (42) cavalier approach prevented a second successive innings defeat under lights at Adelaide as India were bowled out for 175.

Australia needed to score just 19 runs and they completed the formalities in just 3.2 overs.

India's second innings lasted only 36.5 overs, with skipper Pat Cummins using the short ball effectively to claim 5 for 57. Scott Boland (3/51) inflicted early damage, while Mitchell Starc (2/60) chipped in with crucial wickets.

Such was the dominance of the three premier Australian quicks that Cummins didn't even need Mitchell Marsh and Nathan Lyon to roll their arms in the second innings.

In fact, the specialist spinner and allrounder bowled just five overs between them in the entire game.

After a facile 295-run win in Perth, Indian batting unit won't be too amused to learn that they survived a total of 81 overs across both innings, which isn't even a whole day of Test match batting.



It was a tale of two shoddy batting efforts with the two senior-most players Rohit and Kohli looking well past their best. Jasprit Bumrah gave it all but lacked a potent bowling partner at the other end.

For Rohit, things are getting increasingly difficult as he now has lost the last four Tests that he has captained.

In his last six Test matches, he has batted in 12 innings with just one half-century in Bengaluru. The only other innings where he crossed 20-run mark is the 11ball-23 cameo in Kanpur against Bangladesh.

If one looks at the pattern of 37-year-old Rohit's dismissals, it is very similar to Krishnamachari Srikkanth and Virender Sehwag's way og getting out at the end of their careers.

These three were gifted with exceptional hand-eye co-ordination where they picked length at ease during their prime and re-

acted accordingly. Now with reflexes slowing down, the reaction to the length is a split second slower and the way Nahid Rana, Taskin Ahmed,

Tim Southee and now Pat Cummins have squared him, it speaks volumes about where he is going wrong.

He is still trying to cover the line of his deliveries but wrong judgement of length means is causing trouble. Number six wouldn't solve his issues and he needs to again bat in top three.

For Kohli, the hundred at Perth now seems like "buffet runs" which came easily after KL Rahul and Yashasvi Jaiswal added 201 runs and by the time, he came in, India

were ahead by 300 runs and the contest was as good as dead. To his credit, he hung in there for a 100 but it was tired attack that he belted to signal end of a prolonged lean patch

His problems with the fourth stump line has persisted since James Anderson exposed it in 2014.

The 26-year-old Kohli, back then, worked hard and managed around his technical deficiency of edging behind stumps. He would stand closer to off-stump to cover the line but at 36, the movements have slowed and the effects are showing.

If India need to be competitive in the remainder of the series, the two veterans need to figure out how to get over the slump or it might just be too late.

If India had to pull off a coup, it needed Rishabh Pant's (28) excellence but Starc, the undisputed 'OG' of 'pink ball' Tests with 74 victims, bowled a delivery on length which the Indian batter jabbed at without pressing forward fully.

The regulation catch was duly accepted by Steve Smith stationed at second slip.

Reddy, who is time and again showing that positive attitude and big heart at times trumps technique, continued to defy the Australians.

In the first two Tests, Reddy's commitment and ability to fight it out has been exemplary.

He hasn't yet got a fifty but scores of 41, 37 not out, 42 and 42 show a lot of promise for the future. His seam-up wicket-towicket bowling can only improve if he stays around the national team.

It was difficult to survive the pink Kookaburra as Ravichandran Ashwin perished trying to hook Pat Cummins. The Australian skipper then ended Harshit Rana's misery with a short ball that could have knocked his head off and it didn't take much time to polish off the tail. (PTI)

England beat New Zealand by 323 runs in 2<sup>nd</sup> test to take unassailable 2-0 series lead



WELLINGTON (NEW ZEALAND), Dec 8: England conquered the Wellington gale Sunday to seal a 323 run win over New Zealand on the third day of the second test and to take a 2-0 lead in the three-match se-

ries. Joe Root completed his 36th century as England batted for less than 30 minutes in the morning before declaring with a lead of 582 runs and New Zealand crumbled under the weight of the deficit and was all out for 259 in its second innings

England's win followed its comprehensive eight wicket win in the first test at Christchurch, capping its first series victory in New Zealand since 2008 ahead of the final test in Hamilton which begins on Saturday.

The third day differed from the first two in Wellington which were warm and sunny. It was cool, gloomy and windy but otherwise England's thorough command of the series continued. Root resumed on 73 with Eng-

land already 533 ahead. He sped to his century from 127 balls with 10 boundaries and then was out for 106 at which point Ben Stokes declared England's second innings at 427-6.

Stokes left himself high and dry at 49 not out, just short of his 49th half century.

Chris Woakes had the job at first of bowling into the Welling-

land throughout the series. Brook's 171 at Haglev Oval in the first test and Carse's 10-106 — his 4-64 in the first innings and 6-42 in the second — propelled England's to its emphatic

Brook then scored 123 from only 115 balls in the first innings at Wellington to lead England's recovery from 43-4 to 280.

"It's amazing to be stood here winning the series and particularly after being 40-4 on day one and I think looking back to the start of this game I think that's a huge reason why we have (won)," Stokes said.

"Harry Brook and Ollie Pope were just amazing on day one to play like that. That wicket in cricket terms was what we call a snake pit. Especially on day one it was doing plenty and providing a lot of assistance for the bowlers.

"To have the bravery and the backing of your own ability and to also have the skill to go out and play like that was just absolutely phenomenal."

Carse took 4-46 and Gus Atkinson took 4-31 including a hat-trick as New Zealand was bowled out for 125, giving England a lead of 155.

Atkinson took the last three New Zealand wickets to become the first England bowler since Moeen Ali in 2017 to compete a

test hat-trick.

# We left Perth in Perth and shut outside noise: Starc after Adelaide success

ADELAIDE, Dec 8: Mitchell Starc, one of the architects of Australia's comeback win in Adelaide, said the hosts had left the Perth debacle behind by shutting the 'outside noise" following their heavy defeat in the series-opener. A 295-run embarrassing defeat despite bowling India out for just 150 in the first innings invited criticism for the hosts from all quarters.

Living up to his reputation with the pink ball, leftarm quick Starc handed Australia a dream start by dismissing Perth centurion Yashasvi Jaiswal in the very first ball of the second Test en route to finishing with an impressive match haul of 8/108.

"There was a lot of outside noise after the game but we left Perth in Perth. Cannot really put my finger on it," Starc said after the end of the match.

About his approach with the pink ball, he said: "Nothing changes in my approach. Probably slightly fuller lengths. It (pink ball) is more like the white ball than the red ball.

"We were really positive with bat and ball and got the rewards. It's nice when the ball hits the stumps.

He further credited his skipper Pat Cummins for helping in his growth and highlighted improvements in his bowling, including mastering deliveries that move away and those that swing back. He also talked about enhancement in his accuracy with the wobble seam technique.

Bumrah can't bowl from both ends, others need to take responsibility: Rohit

**ADELAIDE, Dec 8:** Jasprit Bumrah is only human and cannot always shoulder the responsibility of bowling opposition out all by himself, skipper Rohit Sharma said on Sunday, urging others to share the load with the premier fast bowler.

India lost to Australia by 10 wickets in the second Test and during the home team's first innings, only Bumrah stood out with a four-wicket haul.

"We are not just playing with one bowler. There are other bowlers also who will have to take responsibility and get the job done for the team, be it (Mohammed) Siraj, Harshit Rana, Nitish Reddy, Akash Deep or Prasidh (Krishna)," skipper Rohit had a loud and clear message for his bowling unit.

The captain understands that there is a bit of inexperience in the line-up and they will grow in confidence with time.

"These bowlers have just arrived in Test cricket, it's important to give them confidence. Whenever they play a match, it's important to give them confidence. We keep planning and discussing. But

you can't expect Bumrah to bowl from both the ends and from morning to evening," Rohit said.

"It's very important to manage (all) bowlers. We discuss all this with each other. We talk to the bowler and then we make the decisions.'

Rohit said that he takes workload management of bowlers very seriously.

"I speak with him (Bumrah) whenever he finishes a spell. I enquire about how his body is feeling, is he (feeling) fresh or not? It's a five-match series, we want Bumrah to play all the matches and remain fresh," Rohit knows what his lethal weapon means in the larger context of the series

Young Harshit Rana was clobbered for 86 in just 16 overs but the skipper was against making a two-Test youngster the fall guy for a comprehensive defeat in Adelaide.

"Rana didn't do anything wrong in the first Test. He did very well. He gave the team crucial breakthroughs when they were needed. I believe that if



someone hasn't done anything wrong, he cannot be left out without a reason because then what confidence does the team get?

"It happens, sometimes the team doesn't get what it wants. He came up against a good batsman who put pressure on him. But he has a heart and a passion so we should back such (qualities in a player)," Rohit said.

"The player might think that you give me one match but leave me out in the next. This is not good for any player or any team, that's what I think. We should

assess what the situation is and how helpful the conditions are," he elaborated. While he doesn't want to judge Rana on the basis of one game but if change is warranted it would be done for benefit of the team.

"But judging someone after one match is not the right thing. We always keep (all) options open for any player to play since we have to win a Test match. If we must make such changes to win a Test, we will do that." The Indian skipper feels that one doesn't need to read too much into the verbal altercation between Travis Head and pacer Siraj after the latter gave the left-hander angry send-off after a brilliant century.

While Head insisted that he acknowledged Siraj, saying "well bowled" after his dismissal, the Indian pacer countered by alleging that the Aussie batter was lying

"There is a thin line between getting aggressive and over-aggressive. It is my job as captain to see that no one crosses the line. But a few words can be ex-

changed. Siraj knows what he needs to do for the team and he will do everything required," Rohit defended his teammate. Probed further by the Australian media, Rohit said: "When India and Australia play, these things happen. My job is not to look at one incident but at bigger picture." Not even being able to score 200 across both innings is certainly disappointing, and the skipper made no bones about it.

"When you come to Australia, I feel the best chance of winning a Test match is by putting runs on the board. We knew that there would be challenges with that ball

"But in the past, we've done that many times where the conditions have been a little challenging, and we've batted really well to put runs on the board, and then try and put pressure on the opposition,' Rohit said.

"Like I said, that is the disappointing part, that we didn't bat well enough. We probably were 30-40 runs short with the bat in the first innings." (PTI)
