Coach restaurant

GUWAHATI: A new rail coach restaurant was inaugurated here at the Uzan Bazar riverfront by the Northeast Frontier Railway (NFR), in an effort to offer passengers a "unique dining experience". AGARTALA/KOLKATA, Dec 3: The Bangladesh Assistant High Commission in Tripura's capital Agartala on Tuesday announced the suspension of all visa and consular services with immediate effect until further notice because of "security reasons", a day after the mission's premises was breached by a group of people protesting against the arrest of Hindu monk Chinmoy Krishna Das in Dhaka.

Amid escalating tensions between the two countries, Dhaka summoned the Indian envoy posted there to protest against the alleged

vandalism of its mission in Tripura. Also on Tuesday, police registered a suo motu case and arrested seven people for their alleged involvement in the incident at the Bangladesh mission. Action was also taken against four policemen for dereliction of duty, West Tripura district SP Kiran Kumar K said

"Given the security situation, all visa and consular services at the Bangladesh Assistant High Commission, Agartala, will remain suspended until further notice. This comes into effect immediately," Md Al-Ameen, the first secretary to the Bangladesh mission, said. Condemning the incident, chief

Rahul Gandhi, other Congress MPs from UP to visit Sambhal today

LUCKNOW/SAMBHAL, Dec 3: Leader of Opposition in the Lok Sabha Rahul Gandhi along with the five other Congress MPs from Uttar Pradesh will visit violence-hit Sambhal on Wednesday, Uttar Pradesh Congress chief Ajay Rai said.

Newly-elected Wayanad MP Priyanka Gandhi Vadra is also likely to accompany the delegation, he said.

The party's general secretary and UP in-charge Avinash Pande will be there too, Rai told PTI.

Curbs under section 163 (power to issue order in urgent cases of nuisance or apprehended danger) of the Bharatiya Nagarik Suraksha Sanhita (BNSS) were set to expire on Sunday and have now been extended till December 31.

When asked about Rahul Gandhi's visit to Sambhal, Superintendent of Police of Sambhal Krishan Kumar told PTI, "Section 163 of the BNSS is already imposed in Sambhal. No outsider is allowed (to enter Sambhal). If they come, then they will be served a notice."

Sambhal has been in the eye of the storm since November 19, when a Mughal-era mosque was surveyed on court orders following claims that a Harihar temple previously stood at the site.

Violence erupted during a second survey on Novem-

ber 24 as protesters gathered near Shahi Jama Masjid and clashed with security personnel. Four people died and several others were injured in the violence that ensued. Meanwhile, UP Congress general secretary Sachin Chaudhary told PTI in Sambhal, "National secretary Pradeep Narwal, state vice-president Rizwan Qureshi and I met the family members of deceased Bilal and Noman, and helped them talk to Priyanka Gandhi ji. Priyanka ji enquired about their wellbeing.'

Chaudhary also said that Rahul Gandhi will come to Sambhal on Wednesday and there is a programme to meet the family members of the deceased. Samajwadi Party MLA from Sambhal (CONTD. ON PAGE-2)

Protests held in Diphu against B'desh atrocities

HT Bureau DIPHU, Dec 3: In solidarity with the Hindu minority in Bangladesh over the alleged violence against them, the Hindu community here in Diphu town came out on the streets to protest against the atrocities by organising a sit-in demonstration in front of the Post Office on Tuesday. The sit-in demonstration was organised under the aegis of the Lokh Jagaran Manch and was attended by hundreds of Hindus irrespective of caste, tribe, community, and language as people participated from every walk of life. They condemned the Bangladesh government for failing to protect religious minorities. Politicians, elected members, businessmen, International Society for

Krishna Consciousness (ISKCON) Prabhus were also present during the demonstration. Tutan Acharjee, Motmandir Ar-

chak Pramukh, Vishwa Hindu Parishad, and Madhaya Karbi Anglong said the Hindus were gathered

there to protest the attack on religious minorities in Bangladesh. A memorandum will be submitted addressed to Muhammad Yunus, the government of Bangladesh on the immediate crisis and lawlessness in Bangladesh.

The memorandum, submitted through the DC of Karbi Anglong, has expressed strong resentment against the atrocities being committed by Islamic extremists in Bangladesh.

The Hindu community through their memorandum also expressed deep concern about the religious minorities of Bangladesh and believed that they have the right to live with dignity and peace, free from arbitrary interference by the government of Bangladesh and any Islamic extremists.

It pointed out, "The media reports reflect the dire situation of religious minorities including spiritual leaders, particularly Sadhus and saints in Bangladesh. How-

ever, the government of Bangladesh has remained silent, failing to take necessary steps to stop such incidents.

It further pointed out the government of Bangladesh oppressing the peaceful democratic rallies by Hindu minorities, who are seeking protection against atrocities. The arrest of ISKCON Sanyasi, Pujya Shri Chinmoy Krishna Das by the Bangladesh government while he was leading a peaceful protest as unfair and undemocratic.

It has urged the Bangladesh government to take immediate action to stop the atrocities against Hindus and other religious minorities and to release Sanyasi Pujya Shri Chinmoy Krishna Das from prison.

Acharjee informed that the memorandum will also be sent to the Prime Minister of India.

Sabha on Tuesday passed a bill that seeks to amend existing law governing exploration and production of oil and gas, and delink petroleum operations from mining operations to boost investment in the sector.

The Oilfields (Regulation and Development) Amendment Bill. 2024, introduced in the Rajya Sabha in August this year, was passed by a voice vote.

Replying to the debate on the bill, Oil Minister Hardeep Singh Puri said that the oil and gas sector involves high investment and long gestation period.

"We need oil and gas sector for 20 more years. We need to bring this legislation here to provide a win-win confidence not only to our own operators but also to foreign investors so that they can come and do business here with a view to benefit everyone," Puri said.

He said policy stability, dispute resolution and sharing of infrastructure, especially for small players are new provisions in the bill.

The bill aims to decriminalise some of the provisions of the original 1948, the Oilfields (Regulation and Development) Act, by introducing "penalties, adjudication by an adjudicating authority and appeal as against the order of adjudicating authority".

The bill proposes to introduce 'petroleum lease' and expands the definition of mineral oils to include crude oil, natural gas, petroleum, condensate, coal bed methane, oil shale, shale gas, shale oil, tight gas, tight oil and gas hydrate. This is with a view to raising domestic output and cutting reliance on imports. Several opposition members de-

The 2023 Act introduced significant changes to the appointment process of election commissioners, replacing the earlier provisions of the Election Commission (Conditions of Service of Election Commissioners and Transaction of Business) Act, 1991.

The most contentious aspect of the new legislation is the exclusion of the CJI from the selection committee.

Instead, appointments are now made based on the recommendations of a three-member panel comprising the Prime Minister, a cabinet minister and the Leader of the Opposition or the leader of the largest opposition party in the Lok Sabha. Section 8 of the Act further empowers the selection committee to regulate its own procedure transparently and allows consideration of candidates beyond those recommended by a search committee led by the Union law minister. (PTI)

GUWAHATI, Dec 3: Natural Rubber (NR) plantation in the North East under Project INROAD (Indian Natural Rubber Operations for Assisted Development) for FY2024-25 stands completed. In the first four years of the project, an area of 125,272 hectares (ha) has been covered under new NR plantations across 94 districts in the North East and parts of West Bengal. This represents one of the highest NR plantation achievements ever in the country within a span of four years. INROAD is a landmark initiative and the first of its kind in the world, where the tyre industry is contributing directly towards the development of rubber plantations. The project entails the development of 200,000 ha of rubber plantations in the North Eastern states and West Bengal, financially supported by four members of the Automotive Tyre Manufacturers Association (ATMA), including Apollo, Ceat, JK, and MRF. The project is being implemented by the Rubber Board of India.

"Notwithstanding challenges, nearly 90 percent of the plantation target for the first four years under Project INROAD has been achieved. Beyond expanding planting areas, the project has seen significant progress in strengthening local nurseries and building grower capacities—a testament to the collaborative efforts among tyre companies and the Rubber Board of India," said Rajiv Budhraja, director general, ATMA, on the completion of four years of INROAD.

During the last four years of the project, a record



project has reached out to resource-deprived populations in the designated states, engaging farmers with landholdings of less than one acre. Once completed, the project is poised to uplift the economic and social status of 2.5 lakh beneficiaries.

The share of the North East in India's area under NR plantation before the launch of the INROAD project was 23 percent. DIPHU, Dec 3: Countering the statement of All Party Hills Leaders Conference (APHLC) president, Jones Ingti Kathar saying 'Karbi Anglong is a tribal land', the BJP -East Karbi Anglong District Committee has condemned Kathar's statement and demanded to withdraw his statement.

It has not been mentioned if this is Karbi area, Khasi area, Rengma area, Kuki area or Garo area. It is mentioned as 'tribal area' and all tribes including Nagas Adivasis and indigenous Assamese who have entered Karbi Anglong at a particular time during

1968 and before their children and grandchildren will get land pattas and their names should be included in voter list of Karbi Anglong Autonomous Council." In a press conference held here at

BJP office the party spokesperson Laichan Engleng said, "There are certain political parties and leaders who are misleading the people. The Mikir Hills now Karbi Anglong was created under the special provision of Sixth Scheduled for protection of the rights and privilege of the Karbis and other recognised tribes under Sixth Scheduled provision listed in Karbi Anglong Autonomous Council. Kathar should have not made such a provocative statement that is creating confusion among the people. He should withdraw his statement." Engleng further stated "Karbi

Anglong being a tribal land does not mean that everyone can come and settle here. There are recognised and unrecognised tribes as listed in the KAAC. Our Chief Executive Member (CEM) of KAAC, Tuliram Ronghang has clarified that whether Muslims or Hindus from Bangladesh and Kukis from Manipur entering Karbi Anglong as illegal migrants cannot be given protection. We understand Kukis are tribals that doesn't mean all Kukis can come and settle in Karbi Anglong. The Kukis living here since 1952 are recognised. They are permanent settlers. They enjoy voting rights and other benefits like any other tribes by KAAC. The Kuki influx entering recently in Karbi Anglong in the aftermath of Manipur violence cannot be provided land here.'

Supreme Court has its task cut out

There is more to the communal fire into which people of India are being systematically pushed, both through illegal and legal stratagem. There are instances of even misusing the apex legal platform of the country, the Supreme Court of India. Hearings by various courts in relation to the Places of Worship Act 1991, can be cited as examples, which provides maintenance of religious character of a place as existed on August 15, 1947, when India became independent. The Supreme Court of India will be hearing only one aspect of the issue - its constitutional validity - on December 4, 2024, but there are much more things that need to be addressed, to rescue the people from the communal fire. Presently, about a dozen of known and much publicized cases are being heard by the courts of India across various states, and every case has its unique background. However, one thing is common - claims are being made that Mosques or Dargah (places of worship) were built on the places where there were Hindu temples.

The Ayodhya Ram Mandir and Babri Mosque issue is well known. Mosque was demolished in 1992, following large-scale loss of lives and properties in Hindu-Muslim riots across the country. The Supreme Court of India delivered a judgement in favour of the Ram Temple in 2019 while ordering land to be allotted somewhere else for the Babri Mosque. Ram Temple was built, and PM Narendra Modi inaugurated it in January 2024. The provision under the Places of Worship Act 1991 prohibited any change in character of any religious place, and the objective of the Act was to put a stop on escalation of such cases in the country to save lives and properties from the communal fire. It should be noted that Kashi was one of places in the rhetoric and slogans. The Gyanvapi case came to the Supreme Court of India, and in 2022, Chief Justice DY Chandrachud led bench observed that the 1991 Act did not prohibit ascertaining the religious character of the structure, even if its use cannot be changed. It was an oversight of the basic purpose of the Act. His decision opened the floodgate of cases against the Mosques and Muslim places of worship, which are ultimately leading to communal disturbances. It should not be out of place to mention that Justice Chandrachud was also one of the judges of Ayodhya judgement of 1019.

A bench consisting of Chief Justice Sanjiv Khanna and Justice Sanjay Kumar will conduct the hearing on December 4, 2024 on only one aspect, i.e. the constitution validity of the Places of Worship (Special Provisions) Act, 1991. Six petitions altogether have been filed. One set of petitions filed on behalf of Hindus have challenged the constitutional validity of the Act, while the other set of petitions have supported the legislation. Some of the Hindu petitioners had filed the case against the Act in 2020, while Jamiat Ulema-e-Hind had filed its petition in support of the Act in 2022. The Supreme Court has greater responsibilities than to decide on only the constitutional validity of the Places of Worship Act 2019.

Lebanon ceasefire and the future of Hezbollah

The ceasefire in Lebanon apart from giving respite to the beleaguered Lebanese, will also be a litmus test for the Hezbollah on whether it can continue to flourish as a political and militant outfit in Lebanon or not.

It would not be wrong to say that the whole of the world and the Middle East and in particular Lebanon took a cautious sigh of relief as the fragile ceasefire between Hezbollah and Israel, was announced last week.

The main concern however was whether this ceasefire could hold, as claims and counter claims by attacks and incursions by both the parties were reported in the first twenty-four hours. But precariously so far, the ceasefire has been held by both the parties. While fighting may be over, or at least paused, attention now shifts to another challenge facing Lebanon and Hezbollah: internal reckoning. In addition, what ace does Iran has, as it ordered its proxy to agree to a ceasefire in Lebanon. But the larger question is whether Hezbollah will be able to survive this ceasefire as a political and militant group in Lebanon or not.

While some segments of the Lebanese

intended to erode Hezbollah's ability to operate freely in its bastion of southern Lebanon, barring the group from having a military presence south of the Litani River. Those close to Hezbollah say it is unclear whether that means its fighters — many of whom are residents of villages and towns in

the south — would be able to return. Hezbollah's ability to continue firing heavier projectile barrages deeper into Israel, including anti-tank missiles and drones, shows it still possesses potent military capabilities. People close to the group also point to its ability to prevent Israel from advancing deep into Lebanon, killing about 50 Israeli soldiers, as proof of its capability.

Unlike in 2006, when Hezbollah was able to ignore a similar deal that ended a war that year, the group will now have to show that it is actively complying with the terms of the ceasefire. The weak Lebanese state — already worn out by a yearlong conflict and festering economic crisis — could pay the price if it does not.

That may open the door to opponents demanding the dismantling of Hezbollah, which remains a powerful representative of the country's Shias, one of its largest communities, with vast reach into the levers of

Rising counterfeit Indian currency threatens to unsettle economy

It is a matter of grave concern that counterfeit ₹ 500 notes from the Mahatma Gandhi (new) series have nearly quadrupled between 2018-19 and 2023-24. And, the detection of counterfeit ₹ 2,000 notes has tripled since 2020-21. The ₹ 2,000 notes continue to remain legal tender and can be exchanged at RBI offices. According to the latest Reserve Bank of India report, 98 percent of the ₹ 2,000 denomination notes have been returned since its May 2023 move to withdraw the currency notes.

It is the fast-expanding circulation of fake ₹ 500 and ₹ 200 notes which has become a matter of real concern. The ₹ 500 note has become the backbone of day-to-day transactions, with its circulation witnessing consistent growth over the years. Both the government and the RBI are worried. Last week, Union Minister of State for Finance PankajChaudhary expressed concerns in Lok Sabha about the rising prevalence of counterfeit currency in the country.

Going by the official data, in 2018-19 21,865 million pieces (mpcs) of the fake currency notes were detected. It reached its peak at 91,110 mpcs in 2022-23, before slightly declining to 85,711 mpcs in 2023-24. This is a sharp increase from 21,865 mpcs detected in 2018-19. However, the number of undetected counterfeit currency notes is anybody's guess. Usually, they are in circulation in rural or semi-urban markets. The operators and customers avoid banks to dodge detection. Fake Indian currency notes are mainly used in terror-related activities to cripple the country's economy and create economic terror.

West Bengal and Assam are believed to be key entry points of fake Indian currency from Bangladesh, Pakistan and Nepal. Both Bangladesh and Pakistan are said to be using Nepal to despatch counterfeited Indian currency to the eastern part of the country.Lately, in a major crackdown on counterfeit currency operations by the police four individuals were arrested from the Ghulam Patty area of Assam's Golaghat town. Police seized sophisticated currency printing equipment and fake notes of various denominations and arrested several persons including Dudu Ali and Rajibuddin Ahmed branded as key operatives. However, kingpins manage to stay under shadow. A recent RBI estimate showed that nearly 80 percent of the total counterfeit notes seized in the country enter through three Indo-Bangladesh border districts of Malda, Murshidabad and Nadia. Malda accounts for the biggest share of the amount of counterfeit Indian currency notes. They are pushed into the country through these three Muslim-majority West Bengal districts bordering Bangladesh. A sizable section of the youth from these districts earns their livelihood as contractual labour working in states such as Gujarat, Haryana, Uttar Pradesh, Tamil Nadu and Kerala. Many of them are said to be used as couriers of counterfeit Indian currency notes smuggled through Bangladesh. The Reserve Bank of India estimates that about 80 percent of the total counterfeit notes seized in the country enter through three Indo-Bangladesh border districts of Malda, Murshidabad and Nadia. Malda accounts for a majority of that amount that are pushed from these three districts. Bangladesh is not only an important conduit for fake Indian currency, but counterfeit notes are also being printed there. Lately, the supply and distribution networks of fake Indian currency notes appear to have proliferated in Bangladesh. The recent spurt in the illicit despatches of fake Indian currency notes into India through the border has become a cause of concern. Not long ago, the police in Dhaka had seized a large number of gunny bags filled with huge quantities of fake Indian currency notes. The Bangladesh police were quoted by the local media in Dhaka saying that a Lahore-based syndicate in Pakistan prints such fake notes, which are then transported to Bangladesh via Sri Lanka in containers loaded with marble stones. The consignments are hidden in "special chambers" at the homes of syndicate members before being smuggled into India. The counterfeit Indian currency notes boom in Bangladesh was also unearthed by the Indian police following an investigation. It was found that those illegal currency notes were printed in Pakistan and then illicitly imported into India either directly through the border with Nepal and Bangladesh or through other routes linking Dubai, Bangkok, Hong Kong, and Colombo. Pakistan and Bangladesh are two major producers and distributors of fake Indian currency notes. The goal is to fund terrorism, raise inflation rates in India, and reduce confidence in the currency. According to the International Criminal Police Organisation (INTERPOL), counterfeiting financial instruments fuels the economy of the underground and promotes the activities of organised criminal networks and terrorists. To correctly assess the amount of money that is counterfeited, countries use Parts Per Million (ppm) for measurement. Counterfeit currencies pose a global problem. The US\$ is said to be the world's most counterfeited currency. Some of the counterfeited US dollars are reported to be of very high quality. Fraudsters try to sell them as legitimate currency, or use them to get loans or lines of credit. The second most popular counterfeited banknote is Euro since the currency was launched in 2002. However, central banks in several parts of the world have been working to mint counterfeit-proof currencies using the latest technology with features that are difficult to fake. Such features include raised intaglio printing on bills, serial numbers, watermarks, and security threads and milled or receded edges on coins. For trained eyes, identifying fake Indian currency notes is not very difficult. Genuine Indian currency notes have a security thread embedded in the note. To check, one has to hold the label transparent and rotate it slightly. However, smart currency counterfeiters too have access to the latest technology. That is posing a big problem before the central banking system. Fraudulent groups or individuals are accessing emerging technology to counterfeit banknotes and other financial instruments across the world. Among the world's most counterfeited notes are: US Dollar, British Pound, Euro, Australian Dollar, Philippine Peso, Canadian Dollar, South African Rand, New Zealand Dollar and Malaysian Ringgit. Incidentally, they are all convertible currencies. On the other hand, Indian Rupee (INR) is only partially convertible. While it can be freely converted into foreign currency and vice versa for trade in goods and services, it is not fully convertible in the capital account meaning that it can only be exchanged for foreign currencies and vice versa for limited reasons. Thus, counterfeited Indian currency remains mostly an Indian problem. (IPA Service)

Reignited civil war in Syria is down to destabilising shockwaves from Israel's wars of aggression in the Middle East and the malign role of NATO powers in shielding the jihadist forces in Idlib now terrorising Aleppo.

There is no ignoring the overlapping alliances which shape this conflict. Syria is allied to Iran, which Israel has repeatedly attacked, including through bombing an Iranian consulate in Syria itself. Both are allied to Hezbollah, which has fought on the Bashar al-Assad government's side in the civil war and which Israel seeks to crush by invading Lebanon.

It does not follow that every outbreak of violence in the region is part of a master plan, but perceptions that Hezbollah and Iran have been weakened by Israeli attacks will have encouraged the terrorist regime in Idlib to reopen hostilities.

And it is a terrorist regime, though Western reportage since the civil war began 13 years ago has been coy about the nature of Syria's opposition.

The Idlib-based Syrian Salvation Government is dominated by Hay'atTahrir al-Sham (HTS), itself a merger of a number of al-Qaida-affiliated Islamist groups, including Jaysh al-Sunna, whose recruitment of child soldiers was exposed in 2016, and Nour al-din al-Zinki, notorious for filming the beheading of a 12-year-old Palestinian boy in the same year.

Ahrar al-Sham, the largest of the groups, has been nicknamed the Syrian Taliban and its rule is just as repressive. An EU asylum agency briefing noted in 2020 that "the jihadist coalition HTS has been responsible for the repressive social norms and policies against female residents ... resulting in further violations including executions, corporal punishments, restrictions of freedom of movement, of dress, on work, education and on access to healthcare."

The open terrorist dictatorship of the most reactionary forces in Syria has continued in the country's north-west to date through armies on Syrian soil. It is the presence of the Turkish army that has stopped Syria's

the illegal presence of NATO

military stamping out the last bastion of jihadist rule in the country, just as it is the presence of the US military in the north-east which has prevented reintegration of Kurdish areas.

The official rationale for stationing troops in Syria against its will is to prevent a revival of the Islamic State terror group, though once-and-future president Donald Trump was more honest when he stated the US was in Syria "only for the oil," hundreds of thousands of barrels of which have been illegally exported via Iraqi Kurdistan — with Damascus estimating revenues lost to this theft at hundreds of billions of dollars.

This underlines the hypocrisy of US officials now blaming Assad for failing to engage in a "political process" to end the war. The process has been prevented by foreign occupying armies.

Assad too has his foreign allies, and Russian bombers are again conducting air raids over rebelheld territory: if HTS assumed Russia was too overstretched in Ukraine to engage (the apparently accurate assumption of Azerbaijan when it marched past Russian peacekeepers to drive the entire Armenian population out of Nagorno-Karabakh last year) it may have miscalculated.

That only emphasises the potential of Syria's war to draw in great powers, powers which are now far closer to direct conflict than in the war's earlier stages. The spread of war across the Middle East comes at a huge cost in human lives, and increases the number of flashpoints for a new world war.

The answer must be to redouble our efforts for peace. These wars cannot be considered in isolation. Stopping Israel's genocide in Gaza and attacks on Lebanon, prioritising a ceasefire and negotiations to end great power conflict in Ukraine, and demanding British pressure on our NATO ally Turkey to stop its jihadist allies rampaging through Syria are related priorities for the peace movement. (IPA Service) population and Hezbollah's supporters, see the ceasefire as a victory for the party, others have decried the bloodshed and destruction caused by a conflict they did not back.

Hezbollah opened a limited battlefront against Israel on 8 October 2023 in support of Hamas and Palestinians under attack in the Gaza Strip. The conflict started last year after Hezbollah began firing rockets into northern Israel following Hamas's October 7 attack, before Israel launched a full-scale in-

vasion in September. Imad Salamey, a Middle Eastern politics expert at the Lebanese American University, told UK-based website Middle East Eye that "Hezbollah's claim of victory holds little weight outside its core constituency. The war was not widely popular among the Lebanese people, many of whom are more focused on the devastating economic losses inflicted during the conflict."

For more than a year, the conflict was mostly limited to clashes in the border areas between Lebanon and Israel. However, the picture changes in September, when Israel exploded thousands of pagers used by Hezbollah members before launching a widespread bombing campaign across the country followed by a ground invasion.More than 3,900 people in Lebanon were killed and over a million displaced.

While Lebanese have largely acted in solidarity with those displaced and killed by Israel, and stood by their compatriots in the face of Israeli forces, how the conflict has shifted domestic political dynamics may determine Lebanon's fate for years to come.

In fact, the presence of Hezbollah and its militant arm has been a point of contention for decadesin Lebanese politics. Salamey says that Hezbollah is "likely concerned about growing opposition within Lebanon, which could create two polarised camps, one supporting Hezbollah and the other pushing for disarmament".

"To suppress dissent and maintain control, Hezbollah may feel compelled to take domestic actions, including using its influence to neutralise political opponents or deter their activities through various actions," he added.

In contrast, Qassim Qassir, an analyst close to Hezbollah, told MEE that the group remains "reassured" about its internal political position in Lebanon.The group is currently reviewing its latest actions and will "define its future vision and is reassured that the results of the battle were in its favour", according to Qassir.

Qassir said further that these people have so far "failed" to take advantage of the war and its consequences to score political points against Hezbollah.

The US-brokered ceasefire agreement is

Hezbollah's victory narrative will be embraced for now by its constituency, many of whom will be relieved to be able to start going back home. But the message will be undermined without massive reconstruction, compensation, and resumption of social welfare in the face of widespread destruction and displacement.

The World Bank estimates the war has caused \$8.5 billion in damage and economic losses – more than one-third of Lebanon's GDP. Hezbollah insists that money for reconstruction will not be an issue, but given that its own main backer Iran has its own economic woes and Hezbollah's unpopularity with other MiddleEastern governments, it is unclear who maycontribute funds for reconstruction, and with what conditions

As powerful a representative as Hezbollah remains for Lebanon's Shia, its domestic political rivals are always looking for an opportunity to exploit claims that the group brings

nothing but trouble to the country as a whole. These rivals include Christian leaders who are keen to shift the levers of power in Lebanon's sectarian power-sharing system in their favour. The danger as in Lebanon's past that such challenges to power end up in sectarian violence is a spectre the country has long lived with.

Janna Kadri and Tala Alayli, in their piece on the website Al Mayadeen opines that Hezbollah's steadfast ability to endure and confront one of the most technologically advanced militaries on the planet highlights its endurance power David Pratt, Foreign Editor with The Herald on Sunday sums it up pithily opining that by steadfastly championing Palestinian rights and opposing external domination, Hezbollah amplified its influence far beyond Lebanon's borders. It became a beacon of resistance against the forces of oppression, inspiring solidarity across diverse communities united in the pursuit of justice.

Sayyed Nasrallah's role as a rallying figure cemented this legacy, while also galvanising a shared vision of dignity and sovereignty in defiance of foreign domination. Through its actions and narrative, Hezbollah solidified its position not just as a regional force but as an emblem of global resistance against colonialism and imperialism, Pratt wrote further.

Perhaps nowhere will the post-ceasefire political landscape be tested more than in the country's south, much of which are inhabited by Lebanon's Shia population and therefore Hezbollah heartlands. Of particular note was the revelation that 45% of these startups are led by women, spanning diverse sectors such as education, agriculture, and health. Further reinforcing this narrative, PM Modi. at the G20 Ministerial Conference on Women Empowerment in Gandhinagar, Gujarat, emphasized that 15% of India's unicorn startups have at least one woman founder, with their combined valuation exceeding \$40 billion. These figures underscore the critical role of women in driving India's entrepreneurial success and highlight the need to remove systemic barriers restricting their access to opportunities and resources. Entrepreneurship in India has gained unparalleled significance in recent years. However, amplifying the entrepreneurial drive among women necessitates focused interventions, particularly in terms of enhancing financial literacy, business acumen, and access to capital. Assam, under the leadership of Chief Minister Dr. HimantaBiswaSarma, has emerged as a beacon of women's empowerment, implementing a host of initiatives aimed at nurturing an entrepreneurial ecosystem that actively includes women. Through targeted policies such as relieving women from the burden of microfinance loans, introducing the Orunodoi scheme, and launching transformative programs like 'Lakhpati-Baideu' and 'Swa-NirbharNari,' the Assam government has taken significant strides in promoting women's economic independence. These measures, combined with efforts to eradicate practices like child marriage and safeguard the rights of girl children, have laid the groundwork for an equitable and progressive society. The Role of Self-Help Groups: The contribution of women's self-help groups (SHGs) to Assam's economy has been remarkable, driving socioeconomic empowerment and fostering a spirit of entrepreneurship in rural communities. With more than 3.62 lakh SHGs involving over 40 lakh women, these collectives engage in activities ranging from small-scale industries to agriculture and handicrafts. The state government's provision of Revolving Funds (RF) and Community Investment Funds (CIF) has further strengthened these groups, enabling them to scale their operations and improve their livelihoods.

the Assam government increased the RF allocation from ₹15,000 to ₹25,000 per SHG in the 2023-24 financial year. Meanwhile, CIF allocations, which support cluster-level organizations in providing loans to SHGs, have been raised to ₹1.5 lakh per SHG from 2022-23. These funds are instrumental in creating sustainable livelihood opportunities and addressing the social and economic needs of SHG members.

The impact of these financial interventions is evident in the Livelihood Tracking System, which reveals a significant increase in the annual income of SHG members—from ₹57,960 to ₹70,503 over three years. Additionally, the number of 'LakhpatiBaideu,' or women with an annual household income exceeding ₹1 lakh, has surged from 241,983 to 872,559 during the

Will banning men from tailoring shops and salons make women safe?

ocial beliefs often portray women as weak and men as aggressive, promoting unequal gender dynamics that perpetuate harassment. Studies conducted by the National Institutes of Health show that workplace harassment disproportionately affects women because patriarchal attitudes are ingrained. Many people, including employers and employees, are unaware of workplace harassment laws, leading to unchecked misconduct. Only 35% of Indian women employees are aware of the Sexual Harassment Prevention Act, 2013. Inefficient implementation of laws and lack of accountability embolden harassers. The Nirbhaya Fund (2013) allocated for women's safety remains underutilized due to poor governance. The low representation of women in certain occupations creates a male-dominated environment, prone to abuse of power. According to the Economic Survey 2023-2024, the female labor force participation rate has increased, but it remains at around 37%. Fear of justice, victim blaming, or retribution discourages victims from reporting harassment, perpetuating a culture of silence. According to National Crime Records Bureau data, crimes against women, including sexual harassment, are grossly underreported due to fear of repercussions, inadequate awareness, and social prejudices. Gender segregation implies that women re-

quire constant protection, thereby undermining their agency and professionalism. Preventing male tailors from taking women's measurements reinforces the notion of women's dependency for protection. Such policies generalize men as a potential threat, creating distrust and harming workplace dynamics. Studies show that inclusive work environments foster greater respect and cooperation between the sexes. Segregation maintains unequal opportunities, restricting participation in occupations dominated by one gender. India's armed forces have historically barred women from combat roles, reflecting the impact of segregation on professional opportunities. Reforms such as NDA induction represent progress, but prejudices persist. Rather than addressing social attitudes, segregation targets symptoms while leaving root causes such as power imbalances and poor education untouched. The National Crime Bureau Report (2023) highlighted that a significant proportion of crimes against women under the IPC were linked to 'cruelty by husband or his relatives'. Segregation reduces the client base for male professionals, which disproportionately affects people from lower-income groups. In smaller towns or villages where unisex salons may not be available, such practices may reduce job opportunities for male barbers. Launch comprehensive awareness campaigns focusing on respect, consent, and workplace ethics to tackle the root of harassment. The POSH Act, 2013 mandates training sessions,

which should be extended to informal sectors such as tailoring and salons. Promote mixed-gender staffing in businesses to develop mutual understanding and reduce stereotyping. Initiatives such as UN Women's He for She campaign encourage men and women to collaborate equally in diverse settings. Ensure strict implementation of anti-harassment laws and create robust mechanisms for grievance redressal. Expanding internal complaint committees in informal sectors can protect vulnerable workers. Instead of surveillance, prioritize safe infrastructure such as private fitting rooms and customer-friendly layouts. Provide financial and training support to professionals affected by restrictive regulations, thereby securing their livelihoods. Government-funded skill enhancement programs under the National Urban Livelihoods Mission (NULM, 2013) can help barbers and tailors diversify their clientele. Segregating occupations by gender is a superficial response that reinforces stereotypes while failing to address systemic issues of oppression. By promoting inclusive workplaces, strengthening legal protections, and promoting behavioral change, India can build a society rooted in equality and respect. Taking inspiration from global best practices like the He for She campaign, India must strive for a future where safety and respect are inherent, not imposed. UK Parliament raises concerns over attacks on Hindu minority in Bangladesh

'The UK govt will continue to monitor the situation, including making representations from this House'

LONDON, Dec 3: The British government continues to monitor the situation in Bangladesh as members of Parliament raised concerns over recent attacks on the minority Hindu community there and arrest of religious leaders, a senior minister said here.

During an urgent question tabled in the House of Commons by Labour MP Barry Gardiner on Monday, the Foreign Office Minister in charge of the Indo-Pacific, Catherine West said that she had been given assurances by the interim government in Bangladesh that support was available for minority communities during her visit to Bangladesh last month.

She stressed that the UK was one of the first countries with ministerial support to arrive in Dhaka to speak with Chief Adviser Professor Yunus and be "vocal" in support of minorities.

"We are aware of the statement of concern from the Indian government following the arrest of Chinmoy Krishna Das, a wellknown Hindu leader, on sedition charges. The UK Foreign, Commonwealth and Development Office (FCDO) desk is closely monitoring those developments," said West.

"The UK government will continue to monitor the situation, including making representations from this House, and will engage with the interim government in Bangladesh on the importance of freedom of religion or belief specifically as it affects the Hindu community," she said.

Tension between India and Bangladesh has been simmering since August 5, when deposed prime minister Sheikh Hasina fled



with Das' arrest last week. The Hindu community in Bangladesh has regularly faced attacks on its members and places of worship during the widespread protests against Hasina's Awami League-led government over a controversial job quota system.

The attacks have continued even after Muhammad Yunus, a Nobel laureate, took over as the Chief Adviser of the interim government on August 8.

Gardiner, MP for Brent West in London with a large British Hindu population, described the situation as being "clearly on a knife edge" and raised concerns on behalf of the "large diaspora populations in the UK

and large Hindu communities with strong links to the community in Bangladesh".

The shadow foreign secretary, Conservative MP Priti Patel, noted that the degree of escalation in the violence is "deeply, deeply concerning".

"What we are witnessing now is uncontrolled violence in many quarters. We are watching with horror and shock as further violence spreads in Bangladesh. The thoughts of all of us in the House are with the diaspora community here and those affected in Bangladesh. These are deeply disturbing reports," she said.

Her party colleague and chair of the All Party Parliamentary Group (APPG) for British Hindus, Bob Blackman, echoed the concerns to highlight that "Hindus are suffering with their houses being burned and their businesses ransacked".

"Priests have been arrested, and I understand that two more were arrested over the weekend, and 63 monks have been denied access to the country. The clear issue is an attempt at the ethnic cleansing of Hindus from Bangladesh... We want to hear not just words of piety, but absolute condemnation of what is going on.

Religious minorities are being deliberately persecuted because of their religion," said Blackman, MP for Harrow East in London - another constituency with a large British Hindu population.

Several other MPs raised concerns on behalf of their constituents with family in Bangladesh. British Sikh Labour MP Gurinder Singh Josan asserted that all communities were "appalled" at the situation and asked Minister Catherine West about the "engagement she has had with the UK's Hindu and Bangladeshi communities on this issue"

"Let me respond on how I have been learning in my role. I was delighted to go to the London borough of Brent to visit the Neasden Temple and learn about Diwali; I had an exceptional visit with the British Asian Trust and learned so much.

That was a prelude to Diwali. After going to Bangladesh, I went to India. I am on a wonderful journey - I am falling in love,' responded the Minister, who was in New Delhi for talks last month. (PTI)

India has been expressing concerns over attacks on minorities, especially Hindus, in that country. There has been a rise in violent

attacks against Hindus in Bangladesh. Hindu minority groups have been frequently reporting atrocities against their community members in different parts of Bangladesh, even after Yunus took charge. (PTI)

JERUSALEM, Dec 3: Israel unleashed its largest wave of airstrikes across Lebanon since agreeing to a ceasefire with Hezbollah last week, killing at least 11 people on Monday after the Lebanese militant group fired a volley of projectiles as a warning over what it said were Israeli truce violations.

Lebanese security services. Israel has said its strikes are in response to unspecified Hezbollah violations, and that under the ceasefire deal it reserves the right to retaliate. Lebanon's parliament speaker, Nabih Berri, accused Israel of violating the truce more than 50 times in recent days by launching airstrikes, demolishing homes near the border and violating Lebanon's airspace. Officials in the US — which along with France helped broker the truce and heads a commission meant to monitor adherence to the deal - played down the significance of Israeli strikes. White House national security spokesman John Kirby said, "Largely speaking, the ceasefire is holding.' "We've gone from dozens of strikes down to one a day maybe two a day," Kirby told reporters, referring to Israeli strikes. "We're going to keep trying and see what we can do to get it down to zero." Under the deal, Iran-backed Hezbollah has 60 days to withdraw its fighters and infrastructure from southern Lebanon. During that time, Israeli troops are also to withdraw to their side of the border. **RELEASE THE HOSTAGES**

KOTA BHARU (MALAYSIA), Dec 3: Severe floods caused by monsoon rains killed more than 30 people and displaced tens of thousands in Malaysia and southern Thailand, officials said Tuesday, with both countries preparing shelters and evacuation plans in anticipation of more heavy rain.

Malaysian Prime Minister Anwar Ibrahim said five days of heavier-than-expected rain that battered the country's east coast last week was equal to the rainfall over the past six months, wreaking havoc in the northeastern state of Kelantan and neighbouring Terengganu

The projectiles were apparently the first time that Hezbollah took aim at Israeli forces after the 60-day ceasefire went into effect last Wednesday. The increasingly fragile truce aimed to end more than a vear of war between Hezbollah and Israel — part of a wider regional conflict sparked by the devastating Israel-Hamas war in Gaza.

In the United States, Presidentelect Donald Trump demanded the immediate release of Israeli hostages held by the Palestinian militant Hamas group in Gaza, saying on social media that if they are not freed before he takes office in January there would be "HELL TO PAY."

It was not immediately clear whether Trump was threatening to directly involve the U.S. military in Israel's ongoing war in Gaza. The US has given Israel crucial military and diplomatic support throughout the nearly 15-month conflict.

A new exchange of fire threatens Lebanon ceasefire

Lebanon's Health Ministry said an Israeli airstrike on the southern village of Haris killed five people and wounded two while another airstrike on the village of Tallousa killed four and also wounded two.

Israel's military carried out a string of airstrikes late Monday against what it said were Hezbollah fighters, infrastructure and rocket launchers across Lebanon, in response to Hezbollah firing two projectiles toward Mount Dov - a disputed Israeli-held territory known as Shebaa Farms in Lebanon where the borders of Lebanon, Syria, and Israel meet. Israel said the projectiles fell in open areas and no injuries were reported.

Hezbollah said in a statement that it fired on an Israeli military position in the area as a "defensive and warning response" after what it called "repeated violations" of the ceasefire deal by Israel. It said complaints to mediators tasked with monitoring the ceasefire "were fu-

tile in stopping these violations." Before the Hezbollah projectiles, Israeli carried out at least four airstrikes and an artillery barrage in southern Lebanon, including a drone strike that killed a person on a motorcycle, according to Lebanese state media. Another strike killed a corporal in the

Zimbabwe court rules against law that denies abortion to marital rape victims, girls below 18

HARARE, Dec 3: A law prohibiting abortion services for women raped by their husbands and girls under the age of 18 is unconstitutional, Zimbabwe's High Court has ruled.

In his ruling handed down on November 22 and made public this week, Judge Maxwell Takuva said since Zimbabwe's laws already criminalise marital rape and sex with a minor, victims should be allowed to abort if they become pregnant.

The ruling is significant, given Zimbabwe's restrictive abortion laws that often lead women and girls into illegal and unsafe backstreet abortions that in many cases turn fatal.

Abortion is allowed in very few circumstances in Zimbabwe, including such as if the pregnancy endangers the life of a woman, or if there is a risk of a physical or mental defect "of such a nature that (the child) will permanently be seriously handicapped." Women can also access legal bortion services in cases of unlawful sex such as incest. (AP)

5 Australians serving life sentences for drugs in Indonesia could soon return home

JAKARTA, Dec 3: The remaining five Australians from the Bali Nine group who are serving life sentences for drug smuggling in Indonesia could be repatriated home this month as Indonesia and Australia put finishing touches on a draft proposal for their transfer, Indonesia's senior law minister said Tuesday. The Indonesian government is awaiting Australia's response to key points related to the transfer arrangements, including provisions requiring Australia to acknowledge Indonesia's sovereignty, respect the rulings of Indonesian courts and ensure that the five maintain their prisoner status after returning home, Yusril Ihza Mahendra told reporters.

"I hope that we can find an understanding on that, agreed on the draft. And we hope that we can finalise

these matters in December," Mahendra said after meeting Australian Home Affairs Minister Tony Burke in Jakarta. Burke said the proposal "is a significant step forward and shows significant goodwill. We now need to work through the issues within each country and we'll we will be doing that without delay."

Australian Prime Minister Anthony Albanese last month appealed to Indonesia's new President Prabowo Subianto to allow their repatriation.

Two convicted ringleaders of the Bali Nine, Andrew Chan and Myuran Sukumaran, were executed by a firing squad in 2015, causing a diplomatic furore between neighbours Indonesia and Australia. Tan Duc Thanh Nguyen died from cancer in prison in May. (AP)

They fled war in Sudan but haven't been able to flee hunger

Abrahim fled from one village in Sudan to the next as people were slaughtered. Yet the killing of relatives and her husband's disappearance aren't what forced the 23-year-old to leave the country for good. It was hunger, she said. We don't have anything to eat

because of the war," Abrahim said, cradling her 1-year-old daughter under the sheet where she now shelters, days after crossing into Chad. The war in Sudan has created

vast hunger, including famine. It has pushed people off their farms. Food in the markets is sparse, prices have spiked and aid groups say they're struggling to reach the most vulnerable as warring parties limit access.

Some 24,000 people have been killed and millions displaced during the war that erupted in April 2023, sparked by tensions between the military and a powerful paramilitary group, the Rapid

Global experts confirmed famine in the Zamzam displacement camp in July. They warn that some 25 million people — more are expected to face acute hunger this year. "People are starving to death at

the moment ... It's man-made. It's these men with guns and power who deny women and children food," Jan Egeland, head of the Norwegian Refugee Council, told The Associated Press. Warring parties on both sides are blocking assistance and delaying authorisation for aid groups, he said.

Between May and September, there were seven malnutrition-related deaths among children in one hospital at a displacement site in Chad run by Doctors Without Borders, known by its French acronym MSF. Such deaths can be from disease in hunger-weakened bodies

In September, MSF was forced



to stop caring for 5,000 malnourished children in North Darfur for several weeks, citing repeated, deliberate obstructions and blockades. US President Joe Biden has called on both sides to allow unhindered access and stop killing civilians.

But the fighting shows no signs of slowing. More than 2,600 people were killed across the country in October, according to the Armed Conflict Location & Event

Abrahim escaped her village in West Darfur and sought refuge for more than a year in nearby towns with friends and relatives. Her husband had left home to find work before the war, and she hasn't heard from him since.

She struggled to eat and feed their daughter. Unable to farm, she cut wood and sold it in Chad, travelling eight hours by donkey there and back every few days, earning enough to buy grain. But after a few months the wood ran out, forcing her to leave for good.

Others who have fled to Chad described food prices spiking three-fold and stocks dwindling in the market. There were no vegetables, just grains and nuts.

Awatif Adam came to Chad in October. Her husband wasn't making enough transporting people with his donkey cart, and it was too risky to farm, she said. Her 6-year-old twin girls and 3year-old son lost weight and were always hungry. (AP)

Centre urged to dismantle militant camps in Manipur

IMPHAL, Dec 3: Coordinating Committee on Manipur Integrity (COCOMI), an umbrella body of Meitei civil society organisations, on Tuesday asked the central government to secure the Indo-Myanmar border and dismantle the infrastructure of armed militant groups

COCOMI also called for transparent investigations into allegations of collusion between security forces and Kuki armed groups.

The Centre needs to take "decisive action to secure the Indo-Myanmar border and to dismantle the infrastructure of armed militant groups within the state in a stipulated time," COCOMI said in a statement

A comprehensive strategy is required to address infiltration, illegal poppy cultivation, illegal arms smuggling and trafficking of drugs and also to restore the demographic balance in Manipur, it said.

COCOMI also alleged that the crisis in the northeastern state resulted from "Kuki aggression" and that the India-Myanmar border has been "mismanaged deliberately".

Both the central and state governments have repeatedly claimed that infiltration from Myanmar is the root cause behind the violence between Imphal valley-based Meiteis and Kukis based in hill districts.

Manipur has remained gripped by recurring bouts of violence since ethnic clashes between the two communities first erupted in May last year. At least 258 people have been killed and thousands rendered homeless since then. (PTI)

3 arrested with arms in Manipur's Imphal

IMPHAL, Dec 3: Three persons were arrested with arms and ammunition in Manipur's Imphal East district, police said on Tuesday.

They were arrested from Kshetrigao Sabal Leikai when they were loitering in the area to "commit prejudicial activities" like extorting money from the people, police said in a statement.

"They were later found to be members of Arambai Tenggol," it said.

Those arrested were identified as Ningombam Lemba Singh (25), Mangshatabam Poireinganba Meitei (21) and Laishram Bidvas Singh (21). A minor was also held along with them, police said.

Among the items seized from them were a Ghatak rifle along with a magazine and five live rounds, a .32 pistol with magazine, three mobile phones, and a fourwheeler, the statement said.

In Churachandpur district, a raid in Phaikhothang village led to the Searching for missing man in Manipur Tracker dogs, drones leaving no stone unturned IMPHAL, Dec 3: The Indian Army has deployed over 2,000 personnel for the search of the Meitei man who has been missing for over a week, police said.

Laishram Kamalbabu Singh, a native of Assam's Cachar district who lived in Khukrul in Imphal West, was a works supervisor for a contractor working with the Military Engineering Services (MES) in Leimakhong Military Station of the 57th Mountain Division, according to the Army. Chief minister N Biren Singh had said he went missing from the military station, asking its authorities to take responsibility for finding him.

"Massive joint search operations by Manipur Police assisted by Indian Army is being undertaken with effect from 25.11.2024 to trace Laishram Kamalbabu Singh (56 yrs) who has been missing since 25.11.2024," the Manipur Police said in a Facebook post on Monday night. "Indian Army has extended all support and resources to trace him utilising 2000 plus troops, hel-



icopters, drones and Army tracker dogs. Further investigation using technical intelligence is being undertaken." it added

Meanwhile, the Joint Action Committee (JAC), formed in response to the disappearance of Singh, continued its sit-in protest at Kanto Sabal, some 2.5 km from the military station, where the road has been barricaded. Singh's wife Akoijam Belarani also joined the

protests. The military camp, located in Kangpokpi district, is some 16 km away from the state capital Imphal and is surrounded by the hills where the Kuki people live.

AGARTALA, Dec 3: Seven individuals have been arrested, and disciplinary action has been taken against four police officers following an attack on the Bangladesh Assistant High Commission in Agartala on Monday.

The incident involved right-wing activists who stormed the diplomatic premises and desecrated Bangladesh's national flag, leading to widespread condemnation.

The attack occurred during a protest organized by the 'Hindu Sangharsh Samity,' a right-wing group voicing concerns over alleged atrocities against Hindu minorities in Bangladesh. The demonstration, which included a sit-in near the Bangladesh Assistant High Commission, also demanded the release of ISKCON member Chinmoy Krishna Das Prabhu.

Although the protest was largely peaceful, tensions escalated when a group of agitators breached security to submit a plement the government's memorandum. Some individuals forced their way into the high commission's premises, disrupting order and desecrating the neighboring country's flag.

Reacting to the breach, West Tripura Superintendent of Police (SP) Kiran Kumar confirmed that security had been tightened around the diplomatic office. "We have taken swift action, suspending two sub-inspectors and transferring a deputy superintendent of police to headquarters for negligence ments present at the proof duty. A suo motu case has been registered, and seven individuals have been taken into custody. Investigations are ongoing," he said.

Fadnavis meets him at Varsha Shinde visits hospital ahead of BJP legislature party meeting

MUMBAI, Dec 3: Maharashtra's caretaker Chief Minister Eknath Shinde on Tuesday visited a private hospital in Thane for a "check-up," two days before a new CM is sworn in at an open ground ceremony in south Mumbai.

Hours after Shinde returned from the hospital, BJP leader Devendra Fadnavis, being seen as the frontrunner for the top post in the new BJP-Shiv Sena-NCP government, visited Shinde's official residence `Varsha' here in the evening.

It was the first face-to-face meeting between the two leaders after the duo, along with NCP chief Ajit Pawar, met the top BJP leadership in Delhi last week.

Even as it is not known yet who would take oath as chief minister at Azad Maidan on the evening of December 5, preparations are in full swing for the ceremony, to be attended by Prime Minister Narendra Modi, about 2,000 VVIPs and some 40,000 supporters.

Shinde, who had been staying at his private residence in Thane for the last few days, visited the hospital in the morning. "I came for a check-up. My health is in good condition," he told reporters while leaving the hospital for Varsha'



A doctor said Shinde had throat issues. "The CM had fever and infection, which caused weakness. He also underwent an MRI scan as a precautionary measure," he said

Shinde, whose party, Shiv Sena, is a constituent of the BJP-led Mahayuti coalition, has been unwell for the last few days. His decision to head to his village in Satara district last Friday had sparked speculation that he was unhappy over the way the new government was shaping up. Following the BJP-led Mahayuti's landslide victory in the November 20 elections, the new Maharashtra government is slated to be sworn in on Thursday The legislature party of the state BJP will meet at Vidhan Bhawan on Wednes-

day morning to elect its leader. But there were indications that distribution of portfolios among the three allies might not be a smooth process. Sena leaders on Monday said that as per the "convention" of alliance politics, their party should get the home portfolio if the

CM post went to the BJP.

NCP chief Ajit Pawar, meanwhile, may meet Union minister Amit Shah in Delhi on Tuesday evening, a senior party leader said. State NCP chief Sunil Tatkare was responding to a question about reports that Pawar had sought a meeting with the senior BJP leader.

No appointment had been sought as such, Tatkare clarified.

The Ajit Pawar-led Nationalist Congress Party is part of the Mahayuti along with the BJP and the Shinde-led Shiv Sena.

Shiv Sena (UBT) leader Sanjay Raut claimed that Shinde was "sulking and throwing tantrums" at Fadnavis with the backing of the "superpower in Delhi", an apparent reference to the BJP's top brass. BJP leader Prasad Lad, meanwhile, announced that the swearing-in ceremony will be a grand affair with nearly 42.000 attendees.

Maharashtra village cancels 'repoll' plan with ballot papers after police intervention

SOLAPUR/MUMBAI, Dec 3: A section of villagers from Maharashtra's Malshrias assembly segment seeking "re-election using ballot papers" gave up their plan on Tuesday after intervention by police and administration, NCP (SP) leader Uttam Jankar who won the seat said.

State Congress president Nana Patole alleged that officials used police to block villagers under BJP's pressure, raising serious concerns about the credibility of EVMs.

Earlier, residents of Markadwadi village under the Malshiras segment in Solapur district had put up banners claiming a "repoll" will be held on "ballot papers" on December 3.

The village is part of the Malshiras assembly constituency, where Jankar defeated BJP's Ram Satpute bv 13.147 votes in the November 20 polls.

Though Jankar won the seat, Markadwadi residents claimed the quantum of votes polled by the NCP (SP) leader was less compared with Satpute, expressing doubt about Electronic Voting Machines (EVMs).

The Malshiras sub-divisional magistrate on Monday imposed prohibitory orders, under section 163 of the Bharatiya Nagrik Suraksha Sanhita, from December 2 to 5 in the area. Tehsildar Vijaya Pan-



garkar rejected the villagers' plea seeking re-poll using ballot papers.

"The assembly elections were conducted lawfully, and no objections were raised during voting or counting. Conducting a ballot paper poll now is illegal and beyond the scope of the election process," Pangarkar said on Tuesday.

Later, Deputy Superintendent of (Malshiras division) Police Narayan Shirgavkar said they had a detailed meeting with the villagers and NCP (SP) leader Jankar. "We explained the procedures in

the law to them and warned them that even if one vote is cast, cases will be registered," Shirgavkar said. Jankar said after discussions with police officials and villagers, the

'repoll" plan was cancelled. The Congress, which won only 16 seats in the Maharashtra assembly polls, has questioned the election process and EVM credibility. On Tuesday, Patole claimed that the people of Maharashtra suspect that the elections were not conducted transparently.

"Markadwadi villagers took a democratic step to address these doubts through a ballot paper poll. Instead, the administration, under BJP pressure, imposed restrictions and used police force to block them. This raises serious concerns about the credibility of EVMs and the government's intent," Patole tweeted.

If there were no irregularities why is the administration afraid of a mock poll, Patole questioned. "This was an opportunity to restore public trust in EVMs, but instead, the BJP's influence has eroded faith in the electoral system," the Congress leader stated NCP (SP) MLA from Ahilyanagar district, Rohit Pawar, also criticised the administration.

The ballot paper poll decision by Markadwadi villagers was an opportunity for the Election Commission to demonstrate EVM transparency. Instead, the administration acted in fear, imposing restrictions and deploying a massive police force. This raises questions about the state of democracy," he told reporters.

Ram Satpute, who lost the electoral contest in Malshiras constituency, accused BJP MLC Ranjitsinh Mohite Patil of orchestrating the unrest among villagers. "This was not a villagers' movement," Satpute said.

"Ranjitsinh Mohite Patil created a false narrative to malign the administration at the state level while targetting EVMs. The administration has rightly dismantled his plan. For the past three days, Mohite Patil's men have been threatening villagers, trying to instigate unrest. Uttamrao Jankar is merely a pawn. while Mohite Patil is the mastermind behind this scheme," Satpute alleged.

Earlier this year, Mohite Patil's younger brother and NCP (SP) leader defeated Satpute in the Lok Sabha elections.

Jankar said a meeting was held with police officials who warned of

seizing the material at the polling station and filing cases.

"After meeting police, we discussed the matter with villagers. The villagers opined if the administration does not allow polling, there will be chaos and conflict between police and residents, which will deter people at the polling station," he said.

Considering the stand of the police and the administration, the villagers decided to stop the "polling" process, Jankar said.

Earlier, a villager Ranjit Markad claimed the village had 2,000 eligible voters on the polling day, and 1,900 of them exercised their franchise

"The village always supported Jankar in the past, but this time, as per the counting of votes through EVMs, Jankar got 843 votes while BJP candidate Satpute polled 1,003 votes. This is not possible and we do not trust these EVM numbers, that is why we decided to conduct the repoll through ballot papers," said Markad.

In the recently concluded Maharashtra polls, the Mahayuti won 230 of the state's 288 seats, with the BJP emerging victorious in 132, Shiv Sena 57 and Ajit Pawar's NCP 41. The Maha Vikas Aghadi, comprising the Shiv Sena (UBT), Congress and Sharad Pawar's NCP (SP), managed to get just 46 seats. (PTI)

In the complaint, Goud stated that during the election campaign, when he contacted his followers for meetings and rallies, many of them informed him that they had received threatening calls warning them not to attend his events. "These individuals also reported

that the caller knew about their conversations and contact details, which led me to suspect that my phone was being tapped," he said. Based on the complaint, police said a case was registered at the Panjagutta police station on December 1, charging Harish Rao, former Deputy Commissioner of Police P Radha Kishan Rao, and others with criminal conspiracy, ex-

by public servants under relevant sections of the IPC and IT Act. The investigation is underway.

The complainant further suspected that the former minister influenced police officials to monitor his activities. He alleged that despite submitting petitions to the police department multiple times regarding the surveillance of him and his associates, no action had been taken earlier.

Reacting to the allegations, Rao in a post on 'X' said: "I have been questioning your (Revanth Reddy) unjust acts and exposing your real nature and standing by people. But you are unable to stand it and hence getting many illicit cases foisted against me. Since I exposed your double standards and questioned you in public, you foisted another false case against me in Panjagutta police station. Even if you file a lakh of false cases, I will not stop questioning on behalf of people.'

Radha Kishan Rao is one of the accused in another case of phone tapping that allegedly happened during the previous BRS regime and is currently in prison.

The Hyderabad police, investigating the case, have arrested four police officials (now suspended) since March 13 for allegedly erasing intelligence data from various electronic gadgets.

The former chief of the Special Intelligence Bureau (SIB) in Telangana and another accused are still absconding and are suspected to be in the US. (PTI)

CHANDIGARH, Dec 3: Chandigarh has become the country's first administrative unit where 100 per cent implementation of the three criminal laws has been done with Prime Minister Narendra Modi on Tuesday saying these new legislations are becoming protector of citizen's rights and the basis of ease of justice.

The laws -- Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita and Bharatiya Sakshya Adhiniyam -- came into effect on July 1, replacing the British-era Indian Penal Code, Code of Criminal Procedure and the Indian Evidence Act, respectively.

Chandigarh has become the country's first administrative unit where 100 per cent implementation of the three laws has been done.

Speaking on the occasion, the prime minister said the new criminal laws represent a concrete step towards realising the ideals enshrined in the Constitution for the benefit of all citizens.

He said the new laws came into effect at a time when country is moving ahead with the pledge of "Viksit Bharat" and 75 years of adoption of Constitution have been completed, thus the launch of the Bharatiya Nyaya Sanhita, rooted in constitutional values, is a significant occasion.

He said these laws signify the end of colonial-era laws

MCD spent nearly 100 cr on dengue control measures in 2024, reveals RTI response



NEW DELHI, Dec 3: The Municipal Corporation of Delhi (MCD) has spent nearly ₹ 100 crore on dengue control operations in the financial year 2024-25 so far, up from ₹ 87.99 crore in the previous fiscal year, according to

an RTI response. This increase reflects the MCD's intensified efforts to combat mosquito-borne diseases, which have seen a rise in the number of cases this year.

A detailed breakdown of the 2024 expenditure shows that ₹96.79 crore was spent, includ-

ing ₹ 4.8 crore on fogging, ₹ 83.25 lakh on anti-larval measures, ₹ 42.02 lakh on medicines and equipment, ₹ 1.2 lakh on special drives, ₹ 17.05 lakh on worker training and ₹ 2.20 lakh on advertisements.

The Right to Information (RTI) response also revealed that 2.89 crore houses were inspected for mosquito breeding in 2024, in comparison to 4.14 crore in 2023.

Although dengue cases have decreased compared to last year's 9.266, other mosquito-borne diseases, such as malaria and chikungunya, have seen a significant rise. By November 30, Delhi had recorded 766 malaria cases, a 99 per cent increase from 384 cases in 2023 and the highest in four years. Similarly, chikungunya cases surged to 266 this year, up from just 44 in 2023, also the highest in four years.

The spike in mosquito-borne diseases was most noticeable between September and October, likely due to changing weather conditions in Delhi, the data showed. However, there has been a decline in the number of such cases with the onset of winter.

In contrast, last year, the spike occurred between August and November.

Mosquitoes in India typically breed during the monsoon season, which runs from June to September. This year, however, a delayed monsoon in Delhi led to a late rise in cases, followed by an early decline as winter approached.

The civic body has also been combating the Japanese encephalitis virus, another mosquito-borne disease. A case of Japanese encephalitis was reported in Delhi earlier this month, prompting the MCD to intensify anti-mosquito measures. (PTI)

Those present on the occasion observed a two-minute silence as a mark of respect to those who lost their lives in the tragedy, an official said. Demanding justice for the victims, former vice chancellor of the Bhoj Open University, Kamlakar Singh said the disaster happened decades ago, but the survivors and their children were still dealing with the fallout, including health, environmental and economic problems.

"The disaster still continues to kill and disable the new generation. The perpetrators responsible for this continue to enjoy a happy and rich life," he said. The people of Bhopal are still seeking justice and accountability from the corporations that waged a "genocide" in their city 40 years ago, Singh said.

The world must know that the disaster is continuing, causing chronic illnesses, disabling the next generation (of survivors), and environmental damage that keeps unfolding, he said. (PTI)

My personality is that of a rebel, I like challenging norms: 'Mirzapur' star **Shweta Tripathi**

NEW DELHI, Dec 3: Like many others, she once dreamt of being the heroine in wispy chiffons running through mustard fields. But Shweta Tripathi's career arc turned out radically different and the "Mirzapur" actor, who says she likes challenging norms, will have it no other way.

"My personality type is of a rebel. I am all of 5ft, I don't fit your archetype of a heroine, I like challenging those norms," the actor, known for her roles with a difference in "Masaan" and OTT shows including "Yeh Kaali Kaali Aankhein", told PTI. The actor, who is in her 30s, can pinpoint just when it

Saudi Arabia's network of spending and influence detailed before getting 2034 World Cup from FIFA

GENEVA, Dec 3: Saudi Arabia's growing influence and massive spending in global sports ahead of being confirmed by FIFA as the 2034 World Cup host was detailed on Monday in a report that cited risks to good governance off the field.

More than 900 sponsor deals — more than one-third traced to the \$925 billion Saudi sovereign wealth fund — and a network of officials with overlapping state, business and sports roles were cited by Play The Game, a publicly funded sports ethics institute in Denmark. The oil-rich kingdom's investment of tens of billions of dollars in soccer, golf, boxing, tennis, the Esports Olympics and a yet-to-be-built ski resort will get its most cov-

eted prize next week from FIFA, the 2034 World Cup in men's soccer. The close ties between FIFA president Gianni Infantino and Saudi Crown Prince Mohammed bin Salman were built since 2018 amid global criticism of the kingdom's record on human rights, including for

women, migrant workers and freedom of expression.

"Saudi Arabia's sports strategy seeks to divert attention from these realities, revealing the tension between the ideals of sport and the realities of power, money, and politics," Play The Game's Stanis Elsborg said in the report.

FIFA passed a mandatory step toward the 2034 decision by publishing at the weekend an in-

house evaluation of the World Cup hosting plan that offered more praise than critical analysis, including labor issues for how most of the 15 stadiums will be built.

On Dec. 11 in Zurich, FIFA will host an online meeting to ask more than 200 member federations to acclaim Saudi Arabia as the 2034 host, 14 months after shaping a fast-tracked and narrow-focused contest that produced just one candidate.

Nearly 50 of those voters have signed working agreements with the Saudi soccer federation, while the soccer bodies for North America, Africa and Asia separately struck cooperation deals or tournament sponsor deals with the sovereign Public



Investment Fund (PIF), state oil firm Aramco and the planned megacity project Neom.

"The awarding of the 2034 World Cup to Saudi Arabia is merely the culmination of years sponsor category of "major worldwide partner," worth a reported \$100 million each year through 2027.

The chairman of Aramco, Yasir Al-Rumayyan, also is governor of the PIF which has a goal to "deliver a strategy focused on achieving attractive financial returns and long-term value for the country." He is chairman also of the LIV Golf project, new airline Riyadh Air, and English Premier League club Newcastle.

"Aramco and FIFA intend to leverage the power of football to create impactful social initiatives around the world," FIFA said in April.

Saudi state and sports officials have consistently cited the crown prince's Vision 2030 pro-

gram to diversify the economy beyond dependence on oil and modernize the traditionally conservative society while giving opportunities to a young population. Infantino has not taken questions from international media, nor held a news conference, in the 14 months since the Saudi candidacy was declared. No news conference is scheduled on Dec. 11 at FIFA headquarters after the closed-doors

With their backs against the wall, India came out all guns blazing in the Border-Gavaskar Trophy series opener at Perth to win by a massive 295 runs with Bumrah (5/30 and 3/42) ripping apart Australia's batting in each innings

"He's obviously a fantastic bowler; (he) has been for a number of years. Our batters are world class as well and always find ways to come up with solutions," Carey told the media

"We've had a look at him now. Hopefully we can combat that first, second spell. Get him bowl-

ing a little bit deeper in the innings with an older ball.

"We saw Travis (Head) sort of counterpunch a bit (in the second innings). I trust our batters, we'll find a way not only (against) Bumrah. They played a couple of other debutantes who bowled well as well," Carey said. After Australia were set an im-

probable 534 to win, Josh Hazlewood had invited the media to ask their batters how they planned to go about in the second innings, sparking rumours of a rift between the batting and bowling

Carey said Australia's resounding loss at Perth sparked a "big reaction externally" but maintained that the team will stick to its processes

"It's quite a big reaction externally for one Test loss. Internally, we don't feel that. We didn't play the way we would have liked to have played."

"We know (that) over four or five Test matches, (if) we keep rocking up and playing our style of cricket we will have the success. We've had that success to, I guess, call upon the method does work.

"We're calm internally, we're excited to get back out and play a

better style of cricket and we've got that opportunity come Fridav.

Carey did not want to draw much attention to the last contest here in which India were shot out for their lowest-ever Test total of 36

"There are obviously amazing days in cricketing history but we don't expect to go out there and do that again. We have a process and a plan that we try to execute and whatever happens, happens. I was not here for that Test match." Australia have never lost a pink

ball Test in Adelaide, in fact they have only lost once in day and night fixture.

'We are excited. We take a lot of confidence for our record in pink-ball cricket - it doesn't mean we will have the success but (with) our methods, our style of play and the experience we have in this group we'll bounce back from Perth," he added.

New Zealand penalised WTC points, drop to fifth in table



DUBAI, Dec 3: New Zealand's aspirations of qualifying for the World Test Championship Final suffered a setback after they were docked three penalty points due to slow over-rate against England leading to a drop in the ranking table, the ICC stated on Tuesday.

The deduction is a welcome news for India, who enjoy pole position with 61.11 percentage points.

New Zealand now have a points percentage of 47.92 percent and can only move as high as 55.36 percent with victories from their remaining two fixtures against England. South Africa (59.26), Australia (57.26) and Sri Lanka (50) are placed second, third and fourth respectively.

"The race to feature at next year's ICC World Test Championship Final at Lord's has taken a twist with New Zealand and England sanctioned for maintaining a slow over-rate during the opening Test of their series in Christchurch," the ICC said in a statement.

"Both teams were fined 15 percent of their match fees and penalised three crucial World Test Championship competition points, adding more intrigue to the thrilling final stages of the ongoing cycle," it further stated.

While England are already out of contention of reaching next year's final despite the impressive eight-wicket triumph at Hagley Oval, the loss in competition points is a major blow to New Zealand who drop from equal fourth to outright fifth on the standings as a result.

It means the inaugural World Test Championship winners face a tough ask to qualify for next year's one-off Test in June 2025, with two wins against England and several other results also needing to go their way if they are to reach the Lord's decider.

New Zealand and England were both found to have three overs short of the target after time allowances were taken into consideration, with sides penalised one point for each over they were found to be short.

Both captains - Tom Latham of New Zealand and Ben Stokes of England - pleaded guilty to the offence and accepted the proposed sanction, so there was no need for a formal hearing.

On-field umpires Ahsan Raza and Rod Tucker, third umpire Adrian Holdstock and fourth official Kim Cotton levelled the charges, with David Boon of the Emirates ICC Elite Panel of Match Referees imposing the sanctions. (PTI)

LONDON, Dec 3: Opting to go in without a proven performer like R Ashwin and batting first in an opening Test of a high-pressure series in Australia are reflections of an Indian team that is brave and supremely confident in its ability to win from any situation, feels England's all-time great Alastair Cook. Cook, a former captain and the first England batter to make 10,000 runs in Test cricket, praised India for their remarkable comeback after getting bowled out for just 150 in the first Test at Perth.

"I thought India was so brave. I thought that first, you know, they win the toss and bat on that wicket, you look there, even though there's only 150 they got, the thought process to say, 'we're going to take Australia on there. We know it's going to be hard, but we think it's going to be hard for both sides only, and then it'll be a one-innings game'," Cook said on TNT Sports.

He added, "I think most captains would have bowled first, certainly would have done and probably got the end of a bad result, like normally in Australia. But India took it on brilliantly. It
