

Two terror suspects arrested in Kokrajhar

Another success of Operation Praghat Arrested duo 'sleeper cell' members B'desh-based terror network

GUWAHATI, Dec 25: Two suspected members of a 'sleeper cell' of a terror network have been arrested along with a huge cache of arms and ammunition in Assam's Kokrajhar district, police said on Wednesday.

Addressing a press conference here, special director general of police Harmeet Singh said, "The Special Task Force (STF), along with Kokrajhar district police, carried out an operation in the district's Namapara area on Tuesday night and arrested the duo.

"The team, led by STF inspector general Parthasarathi Mahanta, achieved a huge success in averting a possible terror act by jihadi elements of a global terrorist organisation. We seized war-like stores from them," he added.

Congress 'shameless' party, using Ambedkar for 'political gains': Himanta

GUWAHATI, Dec 25: Chief Minister Himanta Biswa Sarma on Wednesday termed the Congress a "shameless" party, which is using Dr Babasaheb Ambedkar's name for "political gains" only.

He claimed that Congress had launched innumerable schemes and established many institutions in the name of leaders from Jawaharlal Nehru's family, but there was no such establishment after Ambedkar.

"Congress does not have any shame. The party which imposed emergency, suspended the Constitution, killed democracy, that Congress is doing processions in the name of the Constitution, and it shows that they don't have any shame. It will not be an exaggeration if they are termed as shameless," Sarma told reporters here.

He said that the Congress rolled out Indira Gandhi Awas Yojana, launched many schemes in the name of Rajiv Gandhi and named many big universities in the country after Jawaharlal Nehru.

"...but have you dedicated even one scheme in the name of Babasaheb Ambedkar? Forget university, but have you even named a school after him?

"Can anyone tell me if there was a photograph of Ambedkar in any Rajiv Bhawan before yesterday? I was in Congress for 22 years and never saw a picture of him in Rajiv Bhawan," Sarma said after visiting BJP headquarters to pay tribute to former Prime Min-

He said that Ambedkar's Jayanti was celebrated at AICC on Tuesday but wondered since when did Sonia Gandhi, Rahul Gandhi, Indira Gandhi and Rajiv Gandhi started garlanding the statue or portrait of Ambedkar.

"When Ambedkar resigned from the ministry, it was told that the country would not suffer. You gave Bharat Ratna to everyone in the world, but not to Ambedkar.

"Today to avail political advantage, Ambedkar's memory, ideology, and sacrifice has been made a weapon for political gains only. This is such a notorious and shameful act that has never taken place in India," the CM said.

He asked when did Rahul Gandhi visit the statue of Ambedkar or did ever Indira Gandhi visit the same?

"Did they ever tell the nation what role Ambedkar played in drafting the Constitution? Don't you (Congress) have any shame today? If you had little shame, you would not have held Ambedkar's picture," Sarma said. He advised the Congress party that they will "do well in drama and nautanki" if anyone gives them a role. "Your job will be in the Mumbai film industry for doing drama, but you will never be in the minds and hearts of the people. The people know very well how you ignored Ambedkar for 75 years," he added. 



BPCL picks Andhra Pradesh for India's last greenfield refinery project

NEW DELHI, Dec 25: Stateowned Bharat Petroleum Corporation Ltd (BPCL) has picked Andhra Pradesh for setting up a new oil refinery-cum-petrochemical complex, which may be the last greenfield project in India which has detailed a very ambitious energy transition plan to net zero

In a stock exchange filing, BPCL said its board at a meeting on Tuesday "accorded its approval to commence pre project activities for setting up of a greenfield refinery cum petrochemical complex in east coast at Andhra Pradesh at an estimated cost of ₹ 6,100 crore".

The pre-project activities include initial studies, land identification, and acquisition, preparation of detailed feasibility report, environment impact assessment, basic design engineering package, and front-end engineering design, it

While the firm did not reveal the capacity or the timelines for completing the project, the refinery could be at least 9 million tonnes (180,000 barrels per day) capacity.

BPCL is India's third largest oil refiner behind state-owned Indian Oil Corporation (IOC) and Reliance Industries Ltd. It currently owns refineries at Mumbai (12 million tonnes a year capacity), Kochi in Kerala (15.5 million tonnes) and Bina in Madhya Pradesh (7.8 million tonnes). It had lost a fourth oil refinery to Oil India Ltd in the aborted privatisa-

BPCL had to give up its Numaligarh refinery in Assam to Oil India Ltd when the government



was attempting to privatise the company. The transfer was to keep the Numaligarh unit within the public sector to honour the Assam Accord. But BPCL privatisation was aborted due to lack of interest by bidders.

The planned unit in Andhra Pradesh is being touted as India's last greenfield refinery project. BPCL is part of a consortium that is pursuing a 60 million tonnes a year refinery-cum-petrochemical complex on west coast in Maharashtra that was conceived six years back but is yet to get off the drawing board due to land acquisi-

tion woes. India -- the world's third largest oil consuming and importing nation -- has a refining capacity of 256.8 million tonnes and publicly announced plans for expanding current units and a near complete 9 million tonnes facility at Barmer in Rajasthan of Hindustan Petroleum Corporation Ltd (HPCL) will take it to 300 million tonnes by the end of the decade

Its oil demand is growing at 4-5 per cent annually and the new refinery shows the country's confidence in fuel demand growth even as electric vehicles are eroding

sales of oil consumption in China. India's nearly two dozen refineries produced 276.1 million tonnes of fuel in 2023-24 fiscal (April 2023 to March 2024) while domestic consumption was 234.3 million tonnes. The rest of the products were exported.

It is being said that the planned expansion as well as the new unit at Barmer (likely to be commissioned next year) and the one BPCL is now looking at building on Andhra coast will be sufficient to meet India's fuel demand till at

India has set 2070 as the target date to achieve net zero carbon

BPCL has lined up ₹ 1.7 lakh crore of investment for expanding its core oil refining and fuel retailing business as well as in new energy ventures.

To meet the anticipated demand beyond our planned expansions in Bina and Kochi (refineries), we are actively evaluating options for setting up additional integrated refining and petrochemical capacities in the next 5-7 years," Chairman G Krishnakumar had stated at the company's annual shareholder meeting on August 30.

Building on a strong Indian energy presence, BPCL aspires to meet 7-10 per cent of the nation's primary energy demand by 2047.

BPCL is targeting net-zero carbon emissions by 2040 by investing ₹ 1 lakh crore in renewable power, green hydrogen, compressed biogas, carbon capture, utilisation, and storage (CCUS), energy efficiency improvements, and carbon offsets.

The company has set aggressive targets to build 2 GW of renewable energy capacity by 2025 and 10 GW by 2035.

The increase in female member additions is indicative of a broader shift towards a more inclusive and diverse workforce

State-wise analysis of payroll data denotes that net member addition in the top five states/ UTs constitutes around 61.32 per cent of net member addition, adding a total of around 8.22 lakh net members during the month.

Of all the states, Maharashtra is leading by adding 22.18 per cent of net members during the month.

The states/UTs of Maharashtra, Karnataka, Tamil Nadu, Delhi, Haryana, Telangana and Gujarat individually added more than 5 per cent of the total net members during the month.

Month-on-month comparison of industry-wise data displays significant growth in the members working in establishments engaged in the industries -- Road motor transport. Electronic media companies in the private sector, and banks other than nationalised banks, mong others

Of the total net membership, around 42.29 per cent addition is from expert services (consisting of manpower suppliers, normal contractors, security services, miscellaneous activities etc).

The payroll data is provisional since data generation is a continuous exercise, as updating employee records is a continuous process.

The previous data gets updated every month. From the month of April 2018, EPFO has been releasing payroll data covering the period from September 2017 onwards.

EPFO adds 13.41 lakh N Srinivasan resigns as CEO, MD of **India Cements post**

NEW DELHI, Dec 25: Leading cement maker UltraTech has completed the acquisition of promoters a 32.72 per cent stake in India Cements Ltd, following which N Srinivasan and other promoters of the South-based cement maker have stepped down.

The Aditva Birla Group firm has completed the acquisition of 10.13 crore equity shares of India Cements Ltd (ICL), representing 32.72 per cent of the equity share capital of the company.

This, together with the existing shareholding of 7.05 crore equity shares (22.77 per cent) of the equity share capital of ICL, has resulted in the Company's shareholding increasing to 17.19 crore equity shares representing 55.49 per cent of ICL's equity share capital," UltraTech had informed in a late-night regulatory filing on Tuesday.

Consequently, ICL "has become a subsidiary of the Company" with effect from December 24, 2024, it added. On Wednesday, ICL informed that pursuant to the completion of the transaction and due to the consequent cessation of control by the existing promoters over the company, N Srinivasan has stepped down as Vice Chairman and Managing Director.

Besides, his daughter Rupa Gurunath, wife Chitra Srinivasan and V M Mohan have also stepped down from the board of the company, according to a regulatory fil-

Moreover, "pursuant to the consummation of the Transaction on December 24 2024. UltraTech has acquired sole control of the company and has become the promoter of the company in accordance with the LODR Regulations", informed

Further, the board also recorded the resignation of certain independent directors - S Balasubra-Adityan, Aparna Srivastava, Lakshmi Sreekumar and Sandhya Rajan with effect from the end of business hours on December 25, 2024. it added. (PTI)

Swan ties up with AG&P for India FSRU

NEW DELHI, Dec 25: Business tycoon Nikhil Merchant-run Swan Energy has lined up a floating LNG receipt and regasification unit for its proposed liquefied natural gas import project at Jafrabad in Gujarat, the firm said in a regulatory filing.

Swan signed a Heads of Agreement with Singapore's AG&P Terminals and Logistics to form joint venture companies to provide a floating storage and regasification unit (FSRU) and a floating storage unit to operate the Jafrabad terminal as well as for supplying LNG. A joint venture company (LNG supply company) will be incorporated "for the purpose of supplying LNG in India or any other jurisdiction", Swan said in the filing, adding it will hold 51 per cent equity stake and the balance 49 per cent equity stake shall be held by AG&P LNG.

Another joint venture company (vessel company) will be incorporated "for the purpose of providing floating storage and regasification unit (FSRU) and floating storage unit (FSU) to operate Swan LNG

Airtel tops subscriber additions in NE region: TRAI report

GUWAHATI, Dec 25: Airtel emerged as the leading telecom provider in wireless subscriber additions in the North Eastern region for the month of October 2024, according to an official statement.

According to the Telecom Regulatory Au-

thority of India (TRAI), Airtel added 136,382 wireless subscribers in Assam and 47,625 wireless subscribers in the North East, bringing its total subscriber base to 11,890,497 in Assam and 6,267,645 in the North East.

Airtel emerged as the leading telecom operator in Assam, adding the maximum number of wireless subscribers, followed by state-run BSNL with 21,348 subscribers.

Other private operators, Reliance Jio and VIL. recorded wireless subscriber losses of 86,145 and 6,089 subscribers, respectively, during the same period, the statement

"Nationally, Airtel has added 1.93 million (1,928,263) wireless subscribers across all telecom circles in October 2024", it further

This growth has raised its total wireless subscriber base to 385.41 million (38,541,0746) as of October 31.

TRAI also reported Airtel's peak Visitor Location Register (VLR) at 98.88 percent in Assam and 103.97 percent in the North East, while its overall VLR percentage stood at 99.48 percent, the highest in the industry, it claimed.

"The telecom industry witnessed a decline in total wireless subscribers in India-from 1,153.72 million at the end of September 2024 to 1,150.42 million at the end of October 2024—Airtel's market share stood at 33.50 percent, reflecting its ability to retain and attract customers amidst challenging con-

Singh said that from Kokrajhar, the STF team recovered four handmade rifles that are made to look like AKs, 34 rounds of live ammunition, and 24 rounds of blank cartridges signalling that they were practicing firing.

We also seized a pair of live un-primed IED with cortex, one handmade grenade with explosives, one circuit of detonators made out of agricultural equipment, 14 electronic switches, three iron cases used for making IEDs with 20 iron pieces and plates for causing maximum damage," he added.

Besides, a huge number of switches and wires with explosives used in firecrackers along with other incriminating items have been recovered from the two arrested persons, Singh said. (PTI)

'The sad part is that with the downsliding of Bangladesh's economy and closure of its textile industry, the influx of Bangladeshis has increased unprecedentedly. Tripura CM recently said 1,500 Bangladeshis were detained, while BSF and our state police are also capturing them. "I feel that we need to be cautious in Assam because we are apprehending 20-25 Bangladeshis everyday and we don't have any idea how many have already entered without being caught," he added.

Sarma further said that Union Home Minister Amit Shah has asked the NE states, especially the Border States, to be vigilant after all the CMs mentioned about the issue during the recently held Plenary Session of the North Eastern Council (NEC) in Agartala. (PTI)

FPI inflows into Indian equities drop in 2024, rebound anticipated in 2025

NEW DELHI, Dec 25: After a robust 2023, foreign investors significantly scaled back their investments in Indian equities in 2024, with net inflows amounting to over ₹ 5,000 crore, as elevated domestic valuations, coupled with geopolitical uncertainties prompted investors to adopt a more cautious stance.

Looking ahead to 2025, FPI flows into Indian equities could see a recovery, supported by a cyclical upswing in corporate earnings, particularly in domestic-oriented sectors like capital goods, manufacturing, and infrastructure, Vinit Bolinjkar, Head of Research, Ventura Securities, said.

However, elevated valuations and cheaper alternatives in other emerging markets, such as ASEAN and Latin America, could constrain these inflows.

Additionally, lingering concerns over a prolonged global recession may weigh on investor sentiment and appetite for risk assets, he added. On the other hand, Feroze Azeez, Deputy CEO at Anand Rathi Wealth Ltd, believes geopolitical escalations, central bank interest rate cuts, and potential US tariff sanctions could act as tailwinds for FPI inflows into Indian markets.

As of now, foreign portfolio investors (FPIs) have made a net investment of over ₹ 5,052 crore in the Indian equity markets and Rs 1.12 lakh crore in the debt market (till December 24), as per data available with the depositories.

This follows the extraordinary ₹ 1.71 lakh crore net investment in equities in 2023, driven by optimism surrounding India's resilient economic fundamentals. In contrast, 2022 witnessed the worst net outflow of ₹ 1.21 lakh crore due to aggressive rate hikes by global central banks. Prior to the outflow, FPIs invested money in the last three years (2019, 2020 and 2021). In 2024, FPI outflows were



recorded during the months of Jan-

uary, April, May, October, and No-The drastic decline in FPIs flow in 2024 stems from a combination

of global and domestic factors. The reduced inflow into Indian equities was primarily driven by elevated valuations, prompting investors to redirect their investment to attractively valued Chinese equities, Himanshu Srivastava, Asso-Director of Manager ciate Research, Morningstar Investment Research India, said.

This shift was further fuelled by a series of stimulus measures introduced by China to bolster economic growth, making its equities increasingly appealing.

In addition, heightened geopolitical tensions, particularly the Israel-Iran conflict, increased risk aversion, pushing investors toward safer assets. Caution ahead of the US Presidential election and concerns over fewer US Fed rate cuts next year, despite this year's 100 bps cuts, further dampened sentiment, he added.

On the domestic front, factors like high valuations, weak corporate earnings for the September quarter, expectations of subdued results for December, rising inflation, slower GDP growth, and a depreciating rupee have weighed on investor confidence, Narender Singh, smallcase Manager and Founder at Growth Investing, said.

In contrast to equities, FPIs have shown a marked preference for Indian debt markets, investing ₹ 1.12 lakh crore in 2024, up from ₹ 68,663 crore in 2023.

This trend has been significantly influenced by India's inclusion in JP Morgan's Government Bond Index, with expectations of further inclusion in other major global bond indices along with anticipated interest rate cuts by the US Federal Reserve led to enhanced flow from foreign investors into the Indian bond markets, Morn-

ingstar's Srivastava said. Apart from the index inclusion, other key drivers include India's improving fiscal position where deficit reduced from 5.1 per cent to 4.9 per cent further expected to decline to 4.5 per cent next year plus a healthy forex reserves, Singh

Moreover, FPIs inflow into the debt market are anticipated to grow as Bloomberg is including Indian government bonds to its emerging market index by January 2025. Additionally, interest from various foreign pension funds in Indian government bonds is likely

to create more inflows into the indian debt market, Anand Rathi Wealth's Azeez said.

Prior to 2023, FPIs had consistently pulled out funds, withdrawing ₹ 15,910 crore in 2022, ₹ 10,359 crore in 2021, and a record ₹ 1.05 lakh crore in 2020.

On the equity front, the financial services sector experienced the largest outflows, totalling ₹ 54, 500 crore, followed by the oil & gas sector with ₹ 50,000 crore, and fast-moving consumer goods (FMCG) with ₹ 20,000 crore.

FPIs began 2024 on a weak footing, withdrawing ₹ 25,700 crore in January amid a spike in US bond yields and uncertainty surrounding the global and domestic interest rate environment.

However, this trend reversed in February and March, as FPIs invested ₹ 36,600 crore, encouraged by India's strong economic growth, market resilience, and easing US bond yields.

The recovery was short-lived, as FPIs turned net sellers in April, a trend that persisted into May, driven by political uncertainty during the general elections.

Despite this, FPIs returned to equities in June and sustained their buying momentum until September, culminating in a net investment of ₹ 57,359 crore in September alone, buoyed by a rate cut from the US Federal Reserve.

October and November, however, marked a sharp reversal, with FPIs pulling out a massive ₹ 1.16 lakh crore collectively. October saw an unprecedented outflow of ₹ 94,017 crore -- the largest monthly withdrawal on record -- amid increased allocations to China, concerns over muted corporate earnings, and the high valuation of Indian equities. Despite the volatility, FPIs have shown signs of revival in December, with net inflows exceeding ₹ 20,071 crore so far, signaling renewed interest in Indian equities. (PTI)



Forest cover goal yet to be met

ndia is still struggling to meet the target of the National Forest Policy set 35 years ago in 1988. In 2023, it could attain a forest and tree cover of only 25.17 percent against the target of a minimum one-third (33.3 percent) of the total land area of the country to maintain environmental stability, restore ecological balance and conserve natural heritage. Since then the climate change induced environmental crisis has aggravated and it is frustrating. India's State of Forest Report (ISFR) 2023 released on December 21 by Union Minister for Environment, Forest and Climate Change Bhupender Yadav shows that the total forest and tree cover is 8,27,357 sq km, which is 25.17 percent of the geographical area of the country. Forest cover spans an area of 7,15,343 sq km (21.76 percent) whereas tree cover spans an area of 1,12,014 sq km (3.41 percent). The total forest and tree cover of the country as per 2013 assessment was 789,164 sq km which was only 24.01 per cent of the geographical area of the country. If it rose to only 25.17 percent in a decade, it was a dismal performance, especially when the climate crisis has aggravated to a serious level.

Forest cover in 2013 in India was 697,898 sq km which was 21.23 percent of total geographical area of the country with increased to only 715,343 sq km (21.76 percent) whereas the tree cover rose from 91,266 sq km, which was 2.78 percent, to 112,014 sq km (3.41 percent), it clearly shows the increase in forest cover was far worse than the increase in tree cover. Forest is under the government while ownership of trees also includes private individuals or public in general, indicating that people are more serious than the government as far as forest and tree cover are concerned. How hard has been India's struggle for increasing forest and tree cover can be just imagined in the background that numerous schemes are being implemented by the government but with limited success, as the ISFR 2023 data shows which contains information on forest cover, tree cover, mangrove cover, growing stock, carbon stock in India's forests, instances of forest fire, agroforestry, etc to present a detailed picture of the forest heat at country level, special thematic information on forest cover and important characteristics of forests.

It should be noted that to increase forest cover the Union Ministry of Forest and Environment provides technical and financial assistance to States/UTs under various Centrally Sponsored Schemes, namely Green India Mission (GIM), Forest Fire Prevention and Management Scheme, CAMPA, Nagar Van Yojana and other schemes such as National Afforestation programme as per the mandate of National Forest Policy 1988. Green India Mission (GIM) activities were started in the Financial Year 2015-16 and its total cost is estimated to be around ₹ 46,000 crore. Nevertheless, the present assessment also reveals that 19 states/UTs have above 33 percent of the geographical area under forest cover. Out of these, eight states/UTs namely Mizoram, Lakshadweep, A & N Island, Arunachal Pradesh, Nagaland, Meghalaya, Tripura, and Manipur have forest cover above 75 percent.

India's decent job creation flagship programme goes off-track

ndia's only decent job creation flagship programme announced in the Union Budget $\overline{2024-25}$ has gone out of track. Though supposed to be launched on August 1, it is now likely to be launched in January 2025, since details of the programmes are not yet ready. One of the reasons for the inordinate delay is, the Union Ministry of Labour and Employment has told the Department related Parliamentary Committee, was pendency of Union Cabinet's

Now, the Union Ministry of Labour and Employment is unable to properly implement this programme in the current financial year, and hence it has requested the Union Ministry of Finance to cut its allocation by almost a third.

"We have a limited amount of time this year. Therefore, in Revised Estimate, we have requested for a cut on that amount," the Union Ministry of Labour and Employment has informed the department related Parliamentary Committee on November 19, as per the parliamentary panel's re-

The decent job creation flagship programme contains three Employment Linked Incentive (ELI) Schemes for which the Union Budget had allocated Rs10,000 crore. The Union Ministry of Labour and Employment has now urged the Union Ministry of finance to reduce the budget for the ELI Schemes for the current financial year to ₹ 6,852 crore, the House panel was informed in response to a query.

Apart from citing limited time available in the current financial year, which will end on March 31, 2025, the Union Ministry of Labour and Employment has cited eligibility conditions as major roadblocks to the successful implementation of the scheme in the stipulated time-frame.

The three ELI schemes are yet to get approval from the Union Cabinet and have faced considerable delays with only a quarter to go before the end of the current fi-



nancial year.

However, the Union Ministry of Labour and Employment has said to the House panel, "The Cabinet note has been submitted. We are expecting to start shortly. The total budgetary allocation for this scheme in the next six-and-ahalf years will be ₹ 1.07 trillion. This year, ₹ 10,000 crore has been given and we expect to spend above ₹ 6,000 crore.'

As for the finances and physical targets, the Union Ministry of Labour has said that they expect to spend ₹ 3,576 crore on Scheme A, ₹ 1,534 crore on Scheme B, and ₹ 1,651 crore on Scheme C. The ministry expected 93 lakh workers to get benefit under the three schemes in the current financial year.

Scheme A of ELI is for firsttimers. Scheme B is to promote decent job creation in the manufacturing sector, and Scheme C is to incentivise employers across all sectors to create additional employment over and above the prescribed threshold.

Subsidies would be given to the employers and employees both, through membership of the Employment Provident Fund Organ-

isation (EPFO). It was claimed in the Union Budget 2024-25 that the programme would generate 8 million decent jobs, apart from skilling 10 million youth over the next five years.

As per the proposal of the Union government, the proposed amount to be spent under ELI Scheme

from FY25 to

FY28 is Rs 22,333 crore, under Scheme B from FY25 to FY31 is ₹ 48,326 crore, and under Scheme C from

FY25 to FY31 is ₹ 36,040 crore.

However, after the announcement of the scheme until now, progress remained totally unsatisfactory, despite over two dozen meetings being held between the officials of the Union Ministry of Labour and Employment and other stakeholders from other ministries and departments, and representatives of states, employers' and labour organisations. Employers were particularly hesitant about joining the schemes.

There were many hurdles in the way. EPFO was to be revamped to implement the ELI schemes the process of which remained very

slow. The Parliamentary panel has also noted that the EPFO was still preparing a dedicated IT infrastructure in consultation with the Union Ministry for Electronics and Information Technology (MeitY) for implementation of the scheme that involves preparation of software system/apps for

Another hurdle was the payments system framework. Though the Centre had already issued directions to all ministries and departments to ensure payments of subsidies and incentives to beneficiaries of all schemes through Aadhaar Payment Bridge, the progress remained very slow at EPFO level.

EPFO was given direction to ensure that employers complete the first stage of Universal Account Number (UAN) activation through Aadhaar-based OTP by

November 30, 2024, starting with the latest joinee employees in the current financial year 2024-25. The second stage of the process was to be included in the Biometric authentication, through face recognition technology, after which employers would be required to complete the process for all employees working with them.

However, the November 30 deadline failed, which was extended on December 4 with the next deadline of December 15. Along with the extension of the deadline to activate UAN, the government has also extended the date for the Aadhaar seeding of bank accounts. On December 11, Union labour secretary Ms Sumita Dawra urged the hesitant India Inc at CII Global Economic Forum to take advantage of the ELI scheme to make themselves more competitive.

One of the chief reasons for delays in implementation of the scheme is that the Union government is yet to announce the details of the ELI scheme which made the employers apprehensive and hesitant about the scheme. Now, the Union Ministry of Labour and Employment has informed the House panel that the schemes do not have cabinet anproval yet, which they may get shortly. Officials in the Union Ministry of Labour and Employment expect the details of the schemes will be ready for notification and implementation by January 2025, only weeks before February 1, 2025, when the next Union Budget 2025-26 will be tabled in the Parliament.

It is very bad news for the workforce in the country, since over 90 per cent of them are working in informal jobs both in informal and formal sectors. They are engaged in low quality and low waged jobs without any social security. Most of them have precarious employment arrangements and nearly 20 percent of the employed as per PLFS government data are not in paid em-

Centre's 'One Nation One Poll' bill may not pass the Opposition test

he introduction of the controversial bill, 'One Nation One Poll,' has created more hullabaloo than acceptance. The BJP has been talking about it, but now after introducing it has sent it to the joint select committee of the Parliament.

Prime Minister Narendra Modi is in a hurry to fulfil the BJP's unfinished agenda. He had already opened the Ayodhya temple and abrogated Article 370 of the Constitution, which gave special status to Jammu and Kashmir.

This long-awaited bill aims to streamline the electoral process for 28 states and eight Union territories, with an electorate of nearly a billion voters. The bill has triggered widespread debate, significant interest, and opposition from various parties.

Though momentum is building for simultaneous elections, some questions need answers, including whether Modi has the required twothirds majority to pass the bill in Parliament. Is there a political consensus? Will the Opposition come on board? Is the timing of the bill

Most Opposition parties reject the idea of simultaneous polls. They include the Congress, the Left parties, the Trinamool Congress, and regional and smaller parties. They reject it mainly to settle political scores and apprehension that the bill may benefit the BJP.

Former President Ram Nath Kovind chaired a nine-member committee recommending simultaneous polls last year, labelling it a 'game changer.' Thirty-two parties supported the concept, and 15 rejected it. The panel also advised that the Centre form a panel to oversee the implementation of this proposal. Also, there should be a joint electoral roll for all elections so that voters will use the same list for national, state, and local polls.

Over the years, elections have become a standard feature, but the 'One Nation, One Poll' bill has the potential to reshape our election process. Proponents of the bill argue that it could significantly reduce campaign costs, alleviate the strain on administrative resources, and streamline governance. This could ultimately benefit the public by reducing the frequency of elections, a prospect that should inspire optimism.

Elections in India are held at different levels. The first is panchayat, followed by the district level, the state assembly level, and finally, the national level. They happen at different times, and the government wants to streamline the system.

Interestingly, the idea of simultaneous polls is not new. Historically, it was a synchronised poll from 1952 to 1967. The premature dismissal of various governments and the consequential dissolution of Assemblies led to staggered polls. Prime Minister Indira Gandhi dismissed many Opposition-ruled state governments.

The most important thing is that the BJP needs the support of the allies and friendly parties. In the recent 2024 polls, the BJP was 40 short of a majority in the house and could



form the government only with the help of J.D. (U) and Telugu Desam.

Most opposing parties reject simultaneous polls, including Congress, the Left parties, the Trinamool Congress, and regional and smaller parties. Even in the BJP, 20 MPs were absent while the bill was introduced

The Kovind panel also suggested having the votes in two parts. The first will be for Lok Sabha and Assembly votes, and the second for local groups.

The bill faces significant constitutional, legal, and political challenges. The Kovind panel suggests amending Articles 83 and 172 to allow simultaneous elections. However, the BJP lacks the two-thirds majority for this amendment, and the Constitution needs clarification on concurrent polls. The potential impact on the federal structure of the country and the logistical challenges of conducting simultaneous elections for a billion voters are crucial factors to consider.

Prime Minister Modi's main challenge is to gather enough support in Parliament. At the same time, the government must build political consensus and persuade the Opposition to

The Opposition has rejected simultaneous polls, fearing it might benefit the BJP. The 15 opposing parties hold 205 MPs, while Modi needs 362 votes to proceed.

A legal framework for simultaneous elections is essential to address mid-term government collapses and central political manoeuvring. The one nation, one poll approach reduces waste and election frequency, so the Opposition should consider it carefully and present any alternative proposals for public discussion.

'One Nation One Poll' has been one of the poll promises of the BJP. In his third term, Modi wants to finish the unfinished agenda. Modi presents this legislation with a clear strategy: Whether he succeeds or not, he benefits. If the bill gets passed, it will be an advantage for the BJP government. If it fails, he can claim that he tried to enact the reform but faced Opposition obstruction. Despite potential delays, it's important to debate the bill, as election spending ultimately comes from taxpayers' money. Now that the bill has been sent to a joint select committee, we must wait for its report. (IPA Service)

Cultivating prosperity: A strategic vision for Indian agriculture in the Union Budget FY26

ndia's agricultural landscape is at a critical juncture. As pre-budget consultations gain **I** momentum, it is imperative to address the growing complexities of the agrarian sector with policies that foster productivity, competitiveness, and sustainability. Agriculture must not only secure the livelihoods of millions of peasants but also align with the imperatives of environmental stewardship. The Union Budget for FY26 provides an opportunity to recalibrate priorities and address structural issues that hinder the sector's growth.

The Climate Crisis and Resilient Agriculture India's agricultural sector faces unprecedented challenges from climate change. Average temperatures have risen by 0.7°C since 1951, and monsoon precipitation has decreased by 6%, exposing the fragility of the nation's agri-production systems. This underscores the urgent need for climate-resilient agriculture supported by robust research and development

Currently, agri-R&D in India accounts for less than 0.5% of the agricultural GDP, a figure that must be doubled to at least 1% to drive innovations that can withstand climate disruptions. Investments should focus on sustainable practices such as increasing soil organic carbon and enhancing moisture retention. The National Mission on Natural Farming, while well-intentioned, lacks the capacity to meet the food needs of India's projected 1.67 billion population by 2050. Ensuring the right balance of biofertilisers and chemical fertilisers is crucial for nourishing soils and sustaining high productiv-

Reforming Fertiliser Subsidy Policies

India's current fertiliser subsidy framework exacerbates imbalances in nutrient application. The over-subsidisation of urea distorts the use of nitrogen (N) relative to phosphate (P) and potash (K), while micronutrients like iron and zinc are often neglected. This not only depletes soil health but also leads to inefficiencies in agricultural output.

Innovative fertiliser products, such as nanourea and single superphosphates, have limited adoption due to skewed subsidy structures. Reforming this system to promote balanced fertilisation is imperative. One potential solution lies in replacing subsidies with direct income transfers to farmers on a per-hectare basis. Leveraging existing databases, such as soil health cards and PM-KISAN, can facilitate targeted transfers. This approach would liberate fertiliser prices from state controls, restoring nutrient balance, reducing environmental degradation, and curbing urea leakages. Political will and effective communication with farmers will be critical to the success of such reforms.

Building Value Chains Beyond Production Indian agriculture must transition from a narrow focus on production to an integrated food system encompassing production, marketing, and consumption. This transformation should aim to ensure food and nutritional security while boosting farmers' incomes.



India's milk sector offers a compelling blueprint. Through cooperative and private initiatives, milk production has surged to 239 million tonnes, surpassing the combined value of major staples like rice, wheat, and pulses. Farmers in this sector receive 75-80% of the consumer price, showcasing the potential of equitable value chains.

However, fruits and vegetables, despite their economic importance, have not witnessed similar progress. Farmers typically receive only a third of the consumer price, due to fragmented supply chains and market inefficiencies. Establishing a dedicated board akin to the National Dairy Development Board, led by visionary leadership, could revolutionize the fruits and vegetables sector. Building robust value chains would ensure that farmers receive a fair share while stabilizing consumer prices.

Addressing Anti-Market Policies

India's food policies often reflect a pro-consumer bias, with measures like export bans, stock limits, and subsidized domestic dumping harming farmer incomes. For instance, the Food Corporation of India (FCI) incurs an economic cost of over ₹39/kg for rice but sells it domestically at ₹29/kg, effectively undercutting market prices. Similar practices with wheat further distort the market.

Such interventions not only suppress farmgate prices but also impose an implicit tax on the agricultural sector. According to the Organisation for Economic Co-operation and Development (OECD), India's producer support estimate (PSE) is negative 15.5%, contrasting sharply with China's 14% and the OECD average of 13.8%. This highlights the regressive nature of India's agricultural policies, which undermine the very farmers they seek to sup-

To rectify this, the government must priori-

pricing and transparent trade mechanisms. Allowing markets to function efficiently will incentivize farmers and attract private investments, driving long-term growth in the

Reimagining Agriculture in the Union

The Union Budget for FY26 must adopt a holistic approach to agriculture, addressing the sector's challenges while leveraging its untapped potential. Key priorities should include: 1. Enhancing Agri-R&D: Doubling the allocation for agricultural research to drive climate

Climate change and neglect put butterflies on the brink of extinction in South Asia

n the dark undergrowth of mangrove forests, an anthology of color stirs. Flickers of turquoise rise like exhales from the brackish marshlands, and flashes of sunset orange spark alive in the

The Sundarbans mangrove forest in Bangladesh and India is largely known as one of the last remaining habitats for the Bengal tiger (Panthera tigris tigris), but the coastal groves also thrum with a wealth of smaller animals, including 37 known species of butterfly. The small stature of these butterflies belies their importance; they pollinate flowering plants and nourish the birds that flit through the canopy, ultimately supporting the health of the entire forest ecosystem.

But butterflies in the Sundarbans and throughout South Asia are at increasing risk of extinction, mimicking a global trend that some experts have nicknamed "the insect apocalypse". By some estimates, 250,000-500,000 insect species have gone extinct in the past 150 years, and many more are now on the brink of survival. Climate change and urban development form the largest risks, along with the minimal legal protections and large-scale conservation initiatives focused on butterflies and other insects.

"If my government is not aware, [butterfly species] will be lost. It will be coming in probably 10 years because climate change is thriving," said Monwar Hossain, a professor and lepidopterist at Jahangirnagar University in Bangladesh.

The unique beauty and vibrancy of Bangladesh's butterflies first attracted Hossain's

attention nearly three decades ago. Over his career, Hossain has observed the climate crisis unfold through record-breaking heat waves, severe cyclones and accelerating sea level rise, and his research often focuses on the unique ways these changes impact Bangladesh's 400+ endemic butterfly species.

Insects, including butterflies, are cold-blooded, so they are unable to adjust to changes in temperature as easily as mammals and birds. This puts them at special risk during short-term weather events like heat waves as well as from changes to long-term temperature trends.

Many insects are also unable to migrate long distances to escape changing climate patterns or storms. The reliance of pollinators like butterflies on flowering plants adds an extra dimension to their vulnerability, as even small changes in the flowering season can spell starvation for the unlucky nectar gatherers.

these Bangladesh currently has few protections for butterflies, such as protected areas or bans on collecting and trading specimens. Hossain contrasted this deficit with the international attention and surplus of funding dedicated to large mammals, such as tigers.

"Every animal has its own right to survive, so I don't want to compare the butterfly, but in my country's context, millions and millions of dollars [are used] for the tiger," Hossain said. "Sometimes we say to the government, why not include the butterfly?

A 2021 study determined less than 2% of the ranges of Bangladeshi butterflies were included in protected areas. The



hury, was far from surprised by the results. A Bangladeshi native, Chowdhury has witnessed the entomological oversights of conservation and development decisions in South Asia first-

"Nothing is actually happening with insect conservation in Bangladesh," Chowdhury said.

Part of the issue, according to Chowdhury, is a lack of prior research. Animal conservation is typically predicated by years, if not decades, of careful documentation and monitoring. Before politicians write laws to protect animals, scientists are tasked with providing evidence that shows if and what kinds of protections the animals need.

Recent years have seen a few promising additions to South Asia's collection of entomologUnion for Conservation of Nature included butterflies for the first time in its most recent Bangladesh report, thanks in large part to Hossain, who authored the butterfly section of the report. Chowdhury has also contributed several scientific articles, including a four-year observational study on butterflies in Bangladesh's capital city of Dhaka. But the entomology community is still playing

catch-up. Chowdhury pointed out that naturalists have surveyed birds for centuries; scientists can now use these historical accounts to estimate how populations have changed over time. For insects, particularly those in South Asia, 'there is no account". Making an accurate account from scratch takes years of consistent observation, which can be both

Nitin Ravikanthachari observed a similar problem in his home city of Bengaluru, India.

"You can literally count the number of people [in India] studying butterflies on one hand," he said.

Ravikanthachari spent much of his adolescence prowling the gardens and parks of Bengaluru, camera in hand, and even after beginning a university degree in biology, he often met up with fellow photographers to walk the city and photograph butterflies. As his interest in lepidoptery grew, Ravikanthachari realised how little scientific attention had been dedicated to the subject, and he decided he wanted "to do something more concrete" to address this gap and call attention to the importance of butter-

ists founded the Bangalore Butterfly Club (BBC). Rather than relying on large institutions and universities to generate information about their city's butterflies, the BBC started conducting their own research walks to count the number and species of butterflies in the city. Over time, they could use this data to establish trends and gauge the health of butterfly populations.

The initiative was massively successful.

To date, the BBC has catalogued more than 170 species of butterflies in Bengaluru, including 14 formerly unknown species. More than 400 members attend research walks, educational events and an annual butterfly festival hosted by the group. Ravikanthachari even rediscovered a species thought to be extinct after a 120-year from scientific absence records.

Ravikanthachari said they are now trying to export the BBC's success to other cities in India, and Chowdhury is hopeful a similar model could prove useful in Bangladesh, especially in heavily urbanised areas where development pressures catalyze existing risks related to climate change

"Population is actually a power, but we are not using

that," Chowdhury said. He pointed to apps like iNaturalist as a way to not only provide more opportunities for sightings to be recorded and to build a species database, but also to educate the public on the importance of butterflies and

Hossain has also integrated community education and citi-zen science into his research. South Asia's butterflies. (Cour-In 2012, Ravikanthachari and His library of scientific studies *tesy: Scroll.in*)

three other amateur lepidopter- is supplemented by brochures and children's books, and his lab began hosting an annual butterfly fair with performances, competitions and educational activities in 2010. The Butterfly Park and Research Centre, opened in 2015, not only breeds butterflies for research purposes, but also functions as a public garden on the Jahangirnagar University cam-

> Through these opportunities to interact with and learn about butterflies, Hossain said he sees more and more young people becoming interested in the environment and conservation.

> "Once they see the butterfly, the climate change, the forest, they get it," Hossain said.

> Ultimately, he hopes the growing community of citizen scientists, environmental advocates and butterfly enthusiasts will translate into more scientific research and legislation about butterflies. The more people who become interested in butterflies, he explained, the more opportunities there are to continue the work he started 28 vears ago.

Brahmaputra at risk: The need for immediate action

The Brahmaputra River, one of the world's mightiest and most ecologically significant rivers, is facing an existential crisis. Originating from Tibet and flowing through India and Bangladesh, it is not only a lifeline for millions of people but also a vital force that sustains biodiversity, agriculture, and culture across the region. However, the river's future is uncertain, threatened by an unprecedented combination of climate change, pollution, and anthropogenic pressures. The need for immediate, concerted action to save this vital watercourse has never been more urgent.

The Brahmaputra's ecosystem is uniquely rich and diverse, supporting a variety of flora and fauna that depend on the river's health for survival. It serves as a critical water source for the densely populated region it flows through, providing drinking water, irrigation for crops, and sustaining livelihoods for millions of people, including farmers, fishermen, and indigenous communities. The river also plays a major role in transportation, commerce, and even religious practices in the areas surrounding it. The river's significance cannot be overstated; it is an essential part of the economic and social fabric of the regions it

Yet, the river is at significant risk due to the intensifying impacts of climate change and the unchecked pollution that continues to degrade its waters. The effects of climate change, especially the accelerated melting of glaciers in the Tibetan Plateau and the changing monsoon patterns, are altering the hydrology of the Brahmaputra. As the glaciers retreat, the river's flow is becoming more erratic, leading to both extreme flooding during the monsoon season and reduced water availability in the dry months. These variations in water levels put communities at risk, often leading to disastrous floods or severe droughts that threaten food security, destroy homes, and disrupt the

The problem is compounded by the rising levels of pollution in the Brahmaputra. Industrial waste, untreated sewage, plastic, and other forms of waste have been dumped into the river for decades. The burgeoning population along the river's banks has only exacerbated this issue, with rapid urbanization and a lack of effective waste management systems. In cities like Guwahati, one of the largest urban centers along the Brahmaputra, the river is increasingly becoming a dumping ground for all manner of pollutants. The water quality has deteriorated significantly, affecting both the river's aquatic life and the people who depend on it for drinking water and sustenance. In addition to the health risks posed by contaminated water, the pollution also hampers the river's ability to function as a natural purifier of the surrounding environ-

Moreover, the construction of dams and other hydropower projects on the Brahmaputra in both India and China is further endangering the river. These developments disrupt the natural flow of the river, threaten fish populations, and alter the delicate balance of the river's ecosystem. The damming of tributaries that feed into the Brahmaputra also reduces the river's ability to flush out pollutants, making the situation even more dire. The lack of regional cooperation regarding the management of the river's resources is also a significant hurdle, as countries along its course struggle with competing interests and fail to implement a unified approach to protecting this shared nat-

The ramifications of these combined threats are vast. Biodiversity is suffering as fish species and other aquatic life are being pushed to the brink of extinction. The loss of these species has a cascading effect on the entire ecosystem, disrupting food chains and altering

the dynamics of the river's environment. For the communities that rely on the river for their livelihood, the situation is even more dire. Fishing, agriculture, and other river-dependent activities are becoming increasingly unsustainable as water quality deteriorates, water availability fluctuates, and natural habitats are destroyed. The challenges presented by the Brahmaputra's declining health are not limited to environmental concerns but have wide-ranging social, economic, and political implications as well.

Despite the growing threats, there is still hope for the Brahmaputra, but only if immediate and coordinated action is taken. The first and most important step is to address the root causes of pollution. Comprehensive waste management systems need to be established in the cities along the river, with a strong focus on reducing industrial effluent and treating sewage before it reaches the water. Governments and industries must be held accountable for the pollution they contribute to, and stricter environmental regulations must be enforced to curb harmful practices. Public awareness campaigns, aimed at educating citizens about the importance of the river and the role they can play in protecting it, are also essential to drive change at the grassroots level.

Another crucial step is the establishment of regional cooperation for the sustainable management of the river. India, China, and Bangladesh must come together to formulate a shared strategy for the Brahmaputra's protection. This could involve establishing joint monitoring systems to assess the river's health. coordinating flood control efforts, and ensuring the equitable distribution of the river's resources. International bodies, such as the United Nations, could play a significant role in facilitating this cooperation, ensuring that all stakeholders have a seat at the table and that the needs of the communities along the river

The impact of climate change must also be addressed through adaptive measures that account for the changing dynamics of the river's flow. This could include the construction of more resilient infrastructure, better flood management systems, and policies that promote water conservation. At the same time, efforts should be made to protect the river's ecosystems, including reforestation projects and initiatives to restore wetlands, which act as natural filters for the water and provide essential habitats for wildlife.

Additionally, sustainable development practices must replace the traditional focus on economic growth at the expense of the environment. Large-scale hydropower projects on the Brahmaputra should undergo rigorous environmental impact assessments, with alternatives considered that would not disrupt the river's natural flow or biodiversity. The focus should shift to low-impact renewable energy sources that can meet the region's growing energy demands without further endangering the river.

Saving the Brahmaputra is not just about protecting a river; it is about safeguarding the future of the people who rely on it. A healthy river is vital to ensuring the economic, social, and environmental well-being of millions. The task ahead is formidable, but it is not impossible. It requires the collective will of governments, industries, local communities, and international organizations to come together and prioritize the long-term health of the river over short-term gains.

The situation is urgent, and the consequences of in-

action are too severe to ignore. The Brahmaputra is a

treasure that must be preserved for future generations. We must act now, not only for the river itself but for the countless lives that depend on it. BEIJING, **Dec 25**: It was a breakthrough year in India-China ties after a near freeze in their ties for over four years – the longest since the 1962 war – with an agreement to end the eastern Ladakh military

After "amassing of a large number of troops by China along the Line of Actual Control (LAC) in Eastern Ladakh" in April-May 2020, as External Affairs Minister S Jaishankar said in a recent statement in Lok Sabha, resulting in the Galwan valley clash in June 2020, there had been a breakdown in the relations between the two Asian gi-

The post-1962 war chill lasted till the then Prime Minister Rajiv Gandhi's visit to Beijing in 1988.

This time, the two countries held periodic talks between the top commanders and through the Working Mechanism for Consultation and Coordination (WMCC), resulting in disengagement in stages from four points -- the Galwan Valley, the Pangong Lake, Hot Springs, and Gogra -- in eastern Ladakh by creating buffer zones.

Finally, on October 21, India and China firmed up an agreement on patrolling and disengagement of troops along the LAC in eastern Ladakh at the remaining friction points of Depsang and Demchok.

The agreement led to the first structured meeting between Prime Minister Narendra Modi and President Xi Jinping on the sidelines of the BRICS summit at Kazan in Russia soon after, their first in five

Subsequently, Jaishankar met Chinese Foreign Minister Wang Yi on the sidelines of the G20 meeting in Brazil in November where they reached an understanding that the Special Representatives (SRs) and the Foreign Secretary-level mechanisms will be convened soon.

Constituted in 2003 to comprehensively address the vexed dispute of the India-China border spanning to 3,488 kms, the Special Representatives mechanism is headed by NSA Doval and Foreign Minister Wang.

Defence Minister Rajnath Singh too met his Chinese counterpart Dong Jun at the ASEAN Defence Ministers' meeting in Vientiane in Laos in November.

After the 23rd SR dialogue between Doval and Wang in December, the Ministry of External Affairs (MEA) said the extensive talks focussed on a "positive" direction for cross-border cooperation, including resuming the Kailash Mansarovar Yatra and border trade, while the Chinese side said a six-point consensus, including continuing to take measures to maintain peace at borders and promote healthy and stable development of relations, was reached

between the two sides. While there was no clarity from China on why it moved its troops near the LAC in 2020, equally puzzling is the timing for the agreement to bring down the border

tensions with India, months ahead of the 75th anniversary of their diplomatic relationship.

But Beijing, in recent months, appeared to be mellowing down after its economy struggled to reverse its slowdown, weighed down by issues such as property crisis and rising unemployment.

Throughout the over four-year crisis, bilateral trade was not impacted. In fact, it continued to

The bilateral trade, according to Chinese official figures, totalled USD 138.2 billion in 2023, with Chinese exports climbing to USD 122 billion and Indian exports to China standing at USD 16.2 billion. India's trade deficit with China amounted to USD 105.8 billion last year.

The trade deficit in the first six months of this year climbed to USD 41.89 billion, with Chinese exports totalling USD 50.35 billion against India's exports to China USD 8.46 billion, according to data from the Indian Embassy in Bei-

In 2025, amid stubborn attempts by the US and EU to restrict Chinese exports with heavy tariffs, China looks to push its exports as well as investments in India, especially electric vehicles.

Experts here see the trade expansion with India, currently the fastest growing economy in the world, also as a new avenue to partly offset its likely damages in the Trump 2.0 era. China also recalibrated its for-

eign, trade and military policies ahead of this year's US Presidential elections, especially after President-elect Donald Trump vowed to enhance tariffs over and above what he imposed against China in his first tenure.

Officials here say there is considerable concern in Beijing that India-US relations under Trump's Presidency will pick up further momentum, especially the Quad grouping comprising the US, India,

Australia and Japan, which China perceives as an alliance aimed at containing it.

Besides India, China also sought to recalibrate frayed ties with Aus-

tralia and Japan. Meanwhile, as China marked 75 years of communist party rule, a crucial meeting of the ruling Communist Party in July adopted a resolution for comprehensive reforms to lift the sluggish growth by achieving socialist modernisation by 2035.

President Xi, who continued to crack the corruption whip on the ruling Communist Party and the military officials, asked them in January to turn the knife inwards and carry the anti-graft campaign without any mercy.

Xi's anti-graft campaign in the military has drawn global attention, which his critics say enabled him

to consolidate his hold on power. China also announced to raise its retirement age from January 2025 after its population dipped for a second consecutive year. The demographic crisis was further highlighted as China's marriage registrations in the first half of 2024 fell to a record low since 1980, not to mention the reduced number of kindergartens and drop in the number of children enrolled in them.

In June, Chinese spacecraft Chang'e-6 successfully touched down in the South Pole-Aitken Basin - the far side of the Moon, in the first endeavour of its kind in human history to collect samples from the rarely explored terrain and brought back the soil. Meanwhile, Tibet and Arunachal Pradesh continued to be contentious issues as China celebrated the 65th year of its takeover of Tibet.

In March, the Joe Biden administration recognised Arunachal Pradesh as Indian territory. Biden also signed into law the 'Promoting a Resolution to the Tibet-China Dispute Act' in July, triggering a

Azerbaijani airliner with 67 people onboard crashes in Kazakhstan leaving 32 survivors

MOSCOW, Dec 25: An Azerbaijani airliner with 67 people onboard crashed Wednesday in the Kazakhstani city of Aktau, leaving at least 32 survivors, according to officials. More than 30 people are likely dead.

Kazakhstan's Emergency Ministry said in a Telegram statement that those on board included five crew. At least 29 have been hospitalized, the ministry told Russia's state news agency RIA Novosti.

Russian news agency Interfax auoted medical workers as saying that four bodies have been recovered and emergency workers at the scene as saying that both pilots, according to a preliminary assessment, died in the crash.

The Embraer 190 aircraft made an emergency landing 3 km from the city, Azerbaijan Airlines said

Kazakhstan's Emergency Ministry initially said 25 people survived the crash, later revising that number to 27, 28, and then 29 as the search and rescue operation continued at the site of the crash, bringing the supposed death toll

Prosecutor General's Office in Azerbaijan later reported that at least 32 people survived the crash, adding that the number wasn't final.

Imran Khan demands meeting with party team ahead of negotiations with Pakistan govt

ISLAMABAD, Dec 25: Jailed former prime minister Imran Khan has sought a meeting with his negotiating team that is in talks with the Pakistan government saying it will make the process "meaning-

Khan, 72, founder of the Pakistan Tehreek-e-Insaf (PTI), also put forth the demands of his party and said if the government agrees, he will postpone the civil disobedience movement announced ear-

He nominated Sahibzada Mohammad Hamid Raza, chairman of PTI alliance partner Sunni Ittehad Council (SIC), as the spokesperson for his party's negotiation committee. A member of the National Assembly, Raza is also a chairman of the National Assembly Standing Committee on Human Rights.

The PTI leader's announcement came during a meeting with his lawyers' team on Tuesday in Rawalpindi's Adiala Jail, where he has been incarcerated since last

"The efforts of the party's negotiation committee are a good thing. To make the negotiation process meaningful, it is important that I meet with my nominated negotiation team so that I can have a proper understanding of the issues," Khan said in a post on X after that meeting. Earlier on Monday, the Pakistan

government and Khan's party, in their maiden meeting, agreed to continue talks to address contentious issues, including Khan's release from jail.

The long-anticipate tween the committees representing the government and the PTI were chaired by the National Assembly (NA) Speaker Ayaz Sadiq, who had last week announced to facilitate the two sides in their effort to defuse the prevailing political ten-

The Monday's meeting took place a day after the Shehbaz Sharif-led Pakistan government was prompted to form a negotiation committee to start formal talks with Khan's PTI after it threatened



to give a call for civil disobedi-

After nominating Raza as the spokesperson for the PTI's negotiation process, Khan also forwarded demands of his party for the success of negotiations with the government

These include the release of all under-trial political prisoners of his party and the formation of a judicial commission to probe the events on May 9, 2023 and November 26 this year.

"If these demands are implemented, we will postpone the civil disobedience movement. But I fear that the government will try to sideline our demands for investigations of May 9 last year and November 26, but we will not allow that to happen," he said.

Khan also rejected the military court as "unconstitutional" and added that the decision by these courts were tarnishing Pakistan's reputation in the international world, and such inhumane actions may even lead to economic sanctions for the country.

He also said that by the decision of the military court, the constitutional bench set up after an amendment in the constitution in October this year became irrelevant and by allowing the army led courts to announce judgment of trial of civilian, the judiciary indirectly acknowledged the political engineering being done to harm his PTI

"After the 26th Constitutional

been completely crippled. The establishment of the Constitutional Bench and its decisions are tantamount to embarrassing Supreme Court," he added.

Khan had announced yet another round of protest in the form of a civil disobedience movement this time, asking the Pakistani diaspora to boycott remittances if his demands are not met by Sunday (December 22).

"We will appeal to Pakistanis living abroad that the situation in Pakistan is evident to you, democracy, the judiciary, and the media has been stifled, and a period of oppression and fascism is ongoing. Therefore, we urge you to start the boycott of remittances," Khan had announced on December 19.

After Khan was arrested in an accountability case in 2023, hundreds and thousands of his followers and workers of his party vandalised a dozen military installations, including the Jinnah House (Lahore Corps Commander House). Mianwali Air Base and the ISI building in Faisalabad on May

Khan's party had launched a protest march earlier in the year and the latest was on November 26 when police had arrested hundreds of PTI supporters participating in the protest march to the capital, Islamabad, and a planned sit-in demonstration. (PTI)

WASHINGTON, Dec 25: Sanjeeb Wazed, son of deposed Bangladesh prime minister Sheikh Hasina, has accused the Muhammad Yunus led interim government of "weaponising the judiciary" for carrying out a "political witch hunt" against the Awami League leadership.

Wazed's allegations, as a long post on X, came two days after the interim government on Monday said it has sent a diplomatic note to New Delhi seeking Hasina's extradition from India.

Hasina, 77, has been living in India since August 5 when she fled Bangladesh following a massive student-led protest that toppled her Awami League's (AL) 16-year

Bangladesh's International Crimes Tribunal (ICT) has issued arrest warrants for Hasina and several former Cabinet ministers, advisers, and military and civil officials for "crimes against humanity and genocide." "The judges and prosecutors appointed by the unelected Yunus led regime to conduct farcical trial process through International Crimes Tribunal makes it a political witch hunt that forsakes justice and marks another ongoing onslaught to persecute Awami League leadership," Wazed said in

his post on Tuesday. An IT entrepreneur, Wazed is based in the US and has been an ICT adviser in Hasina's government. "The kangaroo tribunal and subsequent request for extradition

comes while hundreds of leaders and activists are extrajudicially killed, framing of outrageous murder charges, illegal incarceration of thousands by law enforcement and violent attacks including looting vandalism and arson going on with impunity everyday fuelled by denial of the regime," he added. On Monday, India confirmed re-

ceiving the 'note verbale' or diplomatic communication from the Bangladesh high commission in New Delhi but refrained from commenting on it. Under the provisions of the

India-Bangladesh extradition treaty, extradition may be refused if the offence is one of a "political character." Bangladesh's de facto foreign minister Touhid Hossain said Dhaka wants Hasina back to face the judicial process.

Wazed further accused that the chief prosecutor of ICT Tribunal Tajul Islam appointed by Yunus regime on December 22, despite proven records of defending war criminals, "reportedly spread deliberate disinformation campaign" against Hasina by claiming that Interpol issued red notice against her, and termed it as "a desperate bid to extradite her and hold farcical trial to serve the interest of Dr Yunus."

"But the very prosecutor later altered his statement following media exposure of the outright lie and now officially sent a request to India for the extradition." Hasina's son said.(PTI)

BETHLEHEM (WEST BANK), Dec 25: Bethlehem marked another somber Christmas Eve on Tuesday in the traditional birthplace of Jesus under the shadow of war in Gaza.

The cheer that typically descends on the West Bank during Christmas week were nowhere to be found. The festive lights and giant tree that normally decorate Manger Square were missing, as were the throngs of foreign tourists.

Palestinian scouts marched silently through the streets, a departure from their usual raucous brass marching band. Security forces arranged barriers near the Church of the Nativity, built atop the spot where Jesus is believed to have been born. A young boy stood holding a pile of balloons for sale, but gave up because there were no customers to buy them.

The cancellation of Christmas festivities is a severe blow to the town's economy. Tourism accounts for an estimated 70 per cent of Bethlehem's income — almost all from the Christmas season. The number of visitors to Bethlehem plunged from a pre-COVID high of around 2 million per year in 2019 to fewer than 1,00,000 in 2024, said Jiries Qumsiyeh, the spokesperson for the Palestinian Tourism Min-

fire and dozens of Israelis have been killed in militant attacks, has greatly stalled tourism. Palestinian officials do not provide a breakdown of how many of the deceased are civilians and how many are fighters.

Since the deadly October 7, 2023, Hamas attack that sparked the war, access to and from Bethlehem and other towns in the West Bank has been limited, with long lines of motorists waiting to pass through Israeli military checkpoints. The restrictions have prevented some 1,50,000 Palestinians from leaving the territory to work in Israel, causing the Israeli economy to contract by 25 per cent.

In the October 7 assault on southern Israel, Hamas-led militants killed about 1,200 people, most of them civilians, and took more than 250 Israeli hostages. Israeli officials

believe that around 100 hostages remain in captivity in the Gaza

Latin Patriarch Pierbattista Pizzaballa, the top Roman Catholic cleric in the Holy Land, noted the shuttered shops and empty streets and expressed hope that next year would be better.

"This has to be the last Christmas that is so sad," he told hundreds of people gathered in Manger Square, where normally tens of thousands would congregate.

Pizzaballa held a special pre-Christmas Mass in the Church of the Holy Family in Gaza City. Several Palestinian Christians told the Associated Press that they had been displaced in the church since the war began in October of last year with barely enough food and water.

"We hope by next year at the same day we'd be able to celebrate

Bethlehem," said Najla Tarazi, a displaced woman who prayed for the war to end. "We don't feel

Bethlehem is an important centre in the history of Christianity, but Christians make up only a small percentage of the roughly 14 million residents spread across the Holy Land. There are about 1,82,000 in Israel, 50,000 in the West Bank and Jerusalem and 1.300 in Gaza, according to the US State Department.

Nagaland: Congress returns to spotlight after two decades, civic polls held after 20 years

KOHIMA, Dec 25: Nagaland witnessed a significant political shift this year as the Congress made a comeback by winning the lone Lok Sabha seat in the state after decades of political marginalisation and elections to Urban Local Bodies (ULBs) were held for the first time in 20 years with 33 per cent reservation for women, marking a pivotal moment in its political landscape.

In the parliamentary elections held earlier this year, Congress candidate S Supongmeren Jamir clinched the state's only Lok Sabha seat, delivering a win that many political analysts termed as a historic resurgence for the party in a state where it had long been absent from the political limelight.

Jamir's victory marked the end of a 20-year hiatus for Congress in the state's Lok Sabha elections. The last Congress candidate to win the seat was K Asungba Sangtam, who served from 1999 to 2004.

For the state's people, Jamir's triumph carries a deep, symbolic significance, marking a shift in the state's political dynamics, which had been dominated by the ruling alliance of the Nationalist Democratic Progressive Party (NDPP) and the Bharatiya Janata Party (BJP).

Jamir, a former member of the Assembly and the incumbent president of Nagaland Pradesh Congress Committee (NPCC), won decisively, securing 4,01,951 votes. He defeated his nearest rival, Dr Chumben Murry of the NDPP, by a margin of 50,984

The victory was not just a political win for Jamir but represented the broader revival of the Congress, which had been nearly wiped out in the state assembly since 2014, with no representation in the state Assembly.

For the people of Nagaland, Congress' victory was not unex-

Many voters were motivated by the desire to stand against BJP's alleged violence against minority communities in India.

In a state where the population is predominantly Christian, there is a deep-rooted sense of solidarity against what is perceived as growing religious intolerance.

"Religious sentiments played a major role in this Lok Sabha election while some churches also played anti-BJP propaganda," observed H Chishi, a veteran journalist and political analyst.

"The victory of our president, Supongmeren Jamir, in the Lok Sabha election has really strength-

He will have a critical role to play in addressing key issues affecting the Nagas, including the long-standing Naga Political Issue and the demand for a Frontier Nagaland Territory, which has been a significant concern for the people of Eastern Nagaland," said a local political analyst who wished to remain anonymous.

Entering Parliament, Jamir, in his maiden speech, stressed the importance of an early resolution of the Naga political problem and the ENPO issue, while also calling for improvements to the facilities at the only airport and railway station at Dimapur.

With an energised base and the promise of greater representation, Jamir's win may be just the beginning of a new chapter for Congress in the state, as they look toward the 2028 state elections with growing

Nonetheless, the ruling NDPP made up the Lok Sabha defeat by sweeping the civic body polls, winning all three municipal councils - Kohima, Mokokchung and Dimapur — and most of the town councils.

Altogether 523 candidates from 11 political parties were in the fray. NDPP fielded the highest number of candidates at 178, followed by BJP at 44, Congress at 37, NPP at 22, NPF at 21 and NCP at 15. JD(U) contested nine seats, RPI (Athawale) and LJP seven each, and Rising Peoples' Party one. Also, there were 182 Independent

Congress winning just seven civic seats of the 37 it contested while not being able to find candidates for maximum seats has raised doubts about the party regaining its hold in the state. (PTI)

And not just the Maitri Setu, the ₹230-crore Integrated Check Post (ICP) strategically located at Sabroom in the southernmost tip of the border state is yet to be made functional due to the political turbulence on the other side of the



Another strategic connectivity project, the Agartala-Akhaura rail link, which was inaugurated by Modi and Hasina in November 2023, remains a non-starter in the wake of the current political instability in Bangladesh.

The 15-km critical rail link, built at a cost of ₹ 972 crore and is supposed to connect Agartala with Kolkata via Bangladesh, is yet to be made operational. If the link is established, the distance between Agartala and Kolkata will be reduced from 1.559 km (via Guwahati) to 500 km (via Bangladesh), curtailing travel time from the current 31 hours to 10-12 hours.

The viability of the first-ever Special Economic Zone (SEZ), which is coming up in Sabroom at a cost of ₹ 635, also remains doubtful due to the forceful regime change in Dhaka.

"Things have changed in Tripura post August 5 (when Hasina resigned and fled Bangladesh). Local economies have been badly affected.

downsizing of the hospitality sector, etc. are visible in the short run," noted economist Indranil Bhowmik told PTI.

"Nonetheless, optimism stands in the long run, particularly on the upcoming Matarbari Deep Sea Port in Bangladesh's Cox's Bazar which is being promoted through Japanese cooperation. The multiplier linkages of this project will necessitate Bangladesh to keep good relations with India for ensuring economic sustainability," he added.

Tripura also experienced a major tragedy in the worst-ever floods in decades that claimed 38 lives and caused extensive damage to physical infrastructure as well as properties and crops in August.

The loss suffered by the state on account of the floods stood at an estimated ₹ 15,000 crore. Hundreds continue to grapple with their losses as the Centre is yet to release special funds for the rehabilitation of the affected people. However, the state declared a special package of ₹ 564 crore in aid of the flood victims.

Tripura's long tradition of communal harmony suffered a dent when it witnessed two major incidents of violence in which two people were killed and over a hundred were rendered homeless.

On July 12 and 13, some 70 shops and houses were set ablaze by a group of people at Gandatwisa in Dhalai district following the death of a tribal youth

Even before the dust of the Gandatwisa incident had settled, another clash broke out at Kadamtala in North Tripura district just ahead of the Durga Puja on October 6. A Muslim trader was shot dead by the police, triggering communal tension in the northeastern state.

Tripura hogged national headlines yet again in early December after an unruly group of Hindu right-wing activists breached the security cordon and barged into the Bangladesh Assistant High Commission in Agartala vandalising property and removing the country's national flag, to protest alleged atrocities on minorities in the neighbouring nation.

While Tripura Police arrested seven people in connection with the incident and suspended three police officers, the Ministry of External Affairs (MEA) issued an apology for 'the premises breach' at the Bangladesh mission, terming it "deeply regrettable"

In order to address the issues faced by indigenous people, the Centre and the state government signed an accord with newly emerged influential tribal party, Tipra Motha, just ahead of the Lok Sabha elections.

The northeastern state, which had experienced bloody insurgency for several decades, also witnessed the mass surrender of hundreds of militants of the National Liberation Front of Tripura (NLFT) and All Tripura Tiger Force (ATTF), prompting Chief Minister Manik Saha to proclaim the state as "insurgent-free". SP MLA terms Maha election results as 'Vote Jihad'

THANE, Dec 25: Samajwadi Party legislator Rais Shaikh on Wednesday said the results of assembly constituencies in Maharashtra with a sizable Muslim presence disprove the claim that the minority community votes en mass against the BJP.

The MLA from Bhiwandi (East) cited voting figures to claim that the BJP-led Mahayuti coalition won 21 out of 38 seats in the November 20 elections where the Muslim population ranges from 20 percent to 52 percent. Most of the winning candidates were Hindus, Shaikh said in a statement here.

"If 'vote Jihad' existed, this would not have been the case. Some Mahayuti candidates won by a margin of as little as 1,500 votes. But the claim of 'vote Jihad' has been used to malign the Muslim community," he alleged.

He himself won in a Muslim-majority constituency by a margin of 52,000 votes, including 18,000 votes from Hindus, the SP MLA said, adding that the BJP's "divisive slogans" such as 'Batnege to Katnege' and 'Ek Hai Toh Safe Hai" did not have any impact on voters.

On the other hand, Muslim candidates Hasan Mushrif and Abdul Sattar were elected from Hindu-majority Kagal and Sillod seats, respectively, he pointed out.

Shaikh also said that while Muslims are 11.56 percent of Maharashtra's population, their representation in the new assembly is only 3.47 percent. During the election campaign, BJP leader and then deputy Chief Minister Devendra Fadnavis had accused the Opposition of trying to polarize voters and said if there was 'vote Jihad', it would have to be countered by `dharma

Delhi govt departments distance themselves from AAP's promised schemes

NEW DELHI, Dec 25: The Delhi government's Women and Child Development and Health departments issued public notices on Wednesday distancing themselves from the ruling AAP's promised schemes of providing ₹2,100 to women and free treatment for the elderly, triggering a fresh row ahead of

assembly polls. The two departments also cautioned the people against providing personal details to anyone on the pretext of registration for "non-existent" schemes, saying any private individual or political party collecting such physical forms or information is "fraudulent and without any authority

The development, which came days after AAP leaders launched the exercise of registering people for the Mukhya Mantri Mahila Samman Yojana and Sanjeevani Yojana with much fanfare, left the AAP convener Arvind Keiriwal furious

Kejriwal, who is leading the registration drive, alleged that the BJP was rattled by the two schemes and claimed that Chief Minister Atishi could be arrested in a "fake" case in the coming days.

'They are completely rattled with Mahila Samman Yojna and Sanjeevani Yojna. They have hatched a plan to come up with a fake case and arrest Chief Minister Atishi in the next few days," he said on X.

He also claimed that before Atishi's arrest, raids would be conducted against senior A AP leaders

BJP MP Bansuri Swaraj had on Tuesday claimed that she spoke to the health secretary of the Delhi government and was informed that there was no "Sanjeevani Yoina" in existence.

Both the schemes were announced by Kejriwal ahead of Assembly polls in February next year and AAP had started registrations for the schemes in campaign mode. Its leaders are confident that the measure will help woo voters as many believe that such schemes were a factor in the ruling parties retaining power in several state elections.

"It has been brought to the notice of the Department of Women and Child Development, through media reports and social media posts, that a political party is claiming to disburse ₹ 2100 per month under Mukhyamantri Mahila Samman Yojana to women in Delhi.

"It is clarified that no such scheme has been notified by the Government of Delhi.

said the public notice by the department. If and when the scheme begins, the department will launch a digital portal for eligible individuals to submit their applications online as per the approved guidelines, it

Since no such scheme exists, the question of physical forms for registration under this non-existent scheme does not arise, read the

"Any private individual/ political party collecting such physical forms/applications or collecting information from applicants under the name of the Mukhyamantri Mahila Samman Yojana is fraudulent and without any authority," it said.

The notice cautioned the people that providing personal details and sensitive information like PAN account numbers, phone numbers or Voter ID, in the name of the scheme may lead to crime including cyber and banking frauds.

It advised people not to entertain the "misleading" promise of non-non-existent scheme and to exercise caution and asked them not to provide personal details to unauthorised persons.

The Mahila Samman Yojna was announced by the AAP government in the budget 2024-25 to provide ₹ 1000 per month to all eligible women aged above 18 in Delhi. Kejriwal recently promised to raise the amount to ₹2100 per woman if AAP returned to power.

The Health and Family Department public notice similarly cautioned the people about "Sanjeevani Yojna" announced by the AAP supremo for free treatment of senior citizens above 60 years at government and private hospitals.

It has also come to the notice of the department that a registration drive to get enrolled under this scheme by filling up physical forms has also been started by some political functionaries and volunteers who are visiting door to door to collect information from elderly citizens and handing over to them some sort of "Health/Sanjeevani Scheme Card".

The notice said details of senior citizens like phone numbers, addresses, Aadhar and bank accounts were being sought for the registration and many of the elderly people have started visiting government hospitals and government offices to enquire about the

The notice said the Health and Family department does not have any supposed "Sanieevani Scheme" in existence till date.

"Any private individual/political party collecting such physical forms/ applications or collecting information of applicants under the name of "Sanjeevani Yojna" is fraudulent and without any authority," read the notice clarifying the department has not authorised any health officials to collect personal details of the elderly. (PTI)

Atishi accuses BJP of distributing cash to voters in Kejriwal's New Delhi constituency

NEW DELHI, Dec 25: Delhi Chief Minister Atishi on Wednesday alleged that the BJP was distributing cash to women in AAP chief Arvind Kejriwal's New Delhi constituency ahead of Assembly polls in the city. In a press conference, senior AAP leader Atishi said ₹ 1,100 each was given to women from slum clusters at former BJP MP Parvesh Verma's residence at Windsor Place, and their voter ID details were noted down.

Verma, however, denied the charges and said the money was distributed as part of a campaign by Rashtriya Swabhiman', an NGO formed by his late father and former Delhi Chief Minister Sahib Singh Verma. "I ask the Delhi Police, CBI, ED to conduct raids at the bungalow where crores of rupees are kept," she said, adding that the AAP will make formal complaints to the police and the election commission and demanded Verma's arrest.

Kejriwal has also alleged that cash was being distributed to people in his constituency.

Verma, a former West Delhi BJP MP, had earlier claimed that he was asked by senior party leaders to start preparations for contesting from the New Delhi Assembly segment.

In a statement, Verma said the 'Rashtriya Swabhiman' was behind the scheme to provide monthly financial assistance of ₹1,100 to women from poor sections of society. "I am seeing the pain of women which Arvind

Kejriwal could not see for 11 years. They were hassled... I decided that we would give them ₹ 1.100 per month. At least I am not distributing liquor like Arvind Kejriwal. I am happy that I am helping peoe," Verma said. Verma said the Rashtriya Swabhiman has been involved in helping people and has redeveloped two villages devastated by an earthquake in Gujarat, and four villages in Odisha that were destroyed in a cyclone. The organisation also spent crores of rupees in saving the lives of people during the Covid pandemic, providing oxygen concentrators and opening a care centre in West Delhi.

Proposal to name Mysuru road after Siddaramaiah evokes strong objections

the Mysuru City Corporation council to name a stretch of road in the city after Karnataka Chief Minister Siddaramaiah has evoked strong

According to official sources, the proposal calls for naming a stretch of KRS Road from the Lakshmi Venkataramanaswamy temple to the Outer Ring Road junction as 'Siddaramaiah Arogya Marga'.

Based on a suggestion by Chamaraja Congress MLA Harish Gowda, the Mysuru City Corporation (MCC) took the decision at its meeting on November 22.

The matter was first placed before the Mysuru deputy commissioner prior to being tabled in the council meeting. The MCC then issued a newspaper notice inviting views from the public on the proposal within 30 days on December 13, the sources said.

Mysuru is the home district of Siddaramaiah, who is serving his second term as the chief minister. The JD(S) called the move to name the KRS Road in the historic city of Mysuru as 'Siddaramaiah Arogya Marga' condemnable.

Pointing out that Siddaramaiah is an accused in the MUDA site allotment case and is facing probe by the Lokayukta police, the opposition party said in a post on 'X': "There is no elected board in the Mysuru City Corporation. The officials appointed by the Congress government have decided to name the road after Siddaramaiah as they are indebted to him."

Naming a road after the "corrupt" chief minister, who is involved in the MUDA scam, is a "betrayal and insult" not only to the historic city of Mysuru, but also to the entire state, the JD(S) alleged.

RTI activist Snehamavi Krishna. on whose complaint a case was registered in the alleged MUDA site allotment scam, said the road for which Siddaramaiah's name is proposed is "historic", as Maharaja Nalwadi Krishnaraja Wadiyar donated a vast swathe of land and established a tuberculosis hospital there in memory of his sister Princess Krishnajammanni and her children who succumbed to TB. Speaking to reporters, Krishna

said, "The officials have decided to name a road after Siddaramaiah, who is an accused in the MUDA case, despite not having any power to do so. Several citizens have expressed their objections to the proposal. I'm also fighting against it legally. If the proposal is not dropped, we will challenge it in the high court and seek action against the concerned officials.

Siddaramaiah is facing allegations of illegalities in the allotment of 14 sites to his wife Parvathi B M by the Mysuru Urban Development Authority (MUDA).

Siddaramaiah, his wife, brotherin-law Mallikarjuna Swamy and Devaraju -- from whom Swamy had purchased a land and gifted it to Parvathi -- and others have been named in an FIR registered by the Mysuru-located Lokayukta police on September 27, following a special court order. (PTI)


Modi said, "He stands tall as a statesman who continues to inspire countless people."

The Shri Mata Vaishno Devi Sangarsh Samiti called for the bandh and said that all activities in Katra would remain suspended during the protest.

Scores of people led by Samiti leaders Bhupinder Singh and Sohan Chand took out a protest Mookerjee. Years later, he was a march in the town, raising slogans against the Shrine Board and the administration, accusing them of adopting a stubborn attitude.

However, when police personnel stopped the protesters from advancing, clashes broke out between the two sides.

Several protesters, including Singh and Chand, were detained by the police and taken away in a police vehicle from the protest site, officials said. Singh alleged that the government was derailing the issue and forcing the people of Katra to come on the roads.

"We are demanding the shelving of this project to save the jobs of thousands of people. Instead of holding talks with us, as promised by the administration, they are using police to detain us. This is unfortunate", he said

Former minister Jugal Kishore criticised the "use of force" against the protesters. "We strongly condemn the administration's move to use force against peaceful demonstrators. Their actions are aimed at disturbing the situation in Katra, which is unacceptable," Kishore told reporters.

He accused the administration of avoiding dialogue. "Instead of holding discussions, they are aggravating the situation," he said.

In response to the protest call, all business establishments remained closed, and traffic was off the roads in the holy town.

"A 72-hour shutdown by pony owners, shopkeepers, and other local stakeholders began on Wednesday to protest the proposed ropeway project," a Samiti spokesperson said.

The spokesperson added that the administration had initially scheduled a meeting for December 23 but postponed it to 3 PM today. "We met the Deputy Commissioner today, who requested more time to consult higher authorities.

Therefore, we have decided to con-

tinue with the strike," he said. Last month, the Shri Mata Vaishno Devi Shrine Board announced plans to install the ropeway to facilitate access to the temple for senior citizens, children, and others who find it challenging to trek the 13-km-long path to the

cave shrine. The proposed Rs 250-crore project aims to connect Tarakote Marg to Sanji Chhat, which leads to the shrine.

Meanwhile, pilgrims expressed frustration over the shutdown, citing the closure of eateries and the suspension of local transport, which caused significant inconvenience.

"We are facing a lot of difficulties. Where will pilgrims eat or rest during this three-day bandh? This is not the right way to protest," a pilgrim told reporters.

'We humbly request those leading the protests to call off the strike, as thousands of pilgrims are facing hardships," he added. (PTI)

ED probing role of Canadian colleges, **Indian entities in human trafficking**

NEW DELHI, Dec 25: The Enforcement Directorate is investigating the alleged involvement of some Canadian colleges and a few Indian entities in a money laundering case linked to the trafficking of Indians into the US from the Canada border.

The investigation is linked to the death of a fourmember Indian family, hailing from Dingucha village in Gujarat. The four died of extreme cold while trying to cross the Canada-US border illegally on January

The ED said it took cognisance of an Ahmedabad Police FIR against Bhavesh Ashokbhai Patel, who emerged as the main accused in the matter, and a few others, to file a complaint under the criminal sections of the Prevention of Money Laundering Act (PMLA). Patel and others are alleged to have "hatched a wellplanned conspiracy to send people (Indians) to the Canada via illegal c committing the offence of human trafficking," it said.

The agency had earlier found that as part of the racket, the accused "arranged" admission for people, desirous to go to the US illegally, in colleges and universities based in Canada.

A Canadian student visa was applied for such people and once they reached that country, instead of joining the college, they "illegally" crossed the US-Canada border, the agency said in a statement on

"In view of this, the fee received by colleges based in Canada was remitted back to the individuals' account," the ED alleged. Indians were "lured" into the racket and charged between ₹ 55 and ₹ 60 lakh per person, according to

The agency said it undertook fresh searches in this case on December 10 and December 19 at eight locations in Mumbai, Nagpur, Gandhinagar and Vado-

It was found, the ED said, two "entities", one based in Mumbai and the other in Nagpur, entered into an "agreement" for admission of Indians in universities based in foreign countries on a commission

The agency said the latest searches found that about 25,000 students are being referred by one entity and more than 10,000 students by the other to various colleges based outside India every year.

"Further, it is gathered that there are around 1,700 agents/partners based in Gujarat and around 3,500 ents/partners of other entities all over India out of which around 800 are active. "It is further revealed that around 112 colleges

based in Canada have entered into an agreement with one entity and more than 150 with another entity. Their involvement in the instant case is under investigation," the ED said. The agency suspects that out of the total 262 such

colleges in Canada, a few, which are geographically located near the Canada-US border, are involved in the trafficking of Indian nationals.

The ED said it froze ₹ 19 lakh in bank deposits, some "incriminating" documents and digital devices, and seized two vehicles in connection with

SC restrains ED from accessing seized electronic devices of 'lottery king' Santiago Martin

NEW DELHI, Dec 25: In a significant order, the Supreme Court has restrained the Enforcement Directorate from accessing and copying content from electronic devices seized during searches against Santiago Martin, also known as the "lottery king", his relatives, and employees.

The apex court order of December 13 was passed on a petition of Future Gaming and Hotels Services Pvt Ltd (FGHSPL) and Martin and it may lead to re-think by investigative agencies before they decide to confiscate mobile phones or laptops of accused. The order may come to aid other similarly placed accused.

"Issue notice, in the meanwhile, there will be ad-interim relief in terms of prayer clauses (i) and (ii) of the application for interim relief. The prayer clauses (i) and (ii) read thus: (i) Issue an ex-parte ad-interim order directing the Respondents (ED and its officers) not to access and copy the contents of Mobile phone of the Applicant

No.2 (Martin) and the electronic devices belonging to the Applicant No 1's employees," a bench of Justices Abhay S Oka and Pankaj Mithal said.

The bench issued notices to the Centre, the ED and its officers on the petition and fixed it for hearing along with pending ones on February 17, 2025. Other matters include Amazon India employees and the 2023 Newsclick case, where petitioners have sought guidelines for the seizure of digital devices by investigative agencies. (PTI)

Intense cold wave conditions in Kashmir, Srinagar records minus 7.3 degrees Celsius

SRINAGAR, Dec 25: Minimum temperatures decreased at most places in Kashmir as the valley continued to reel under intense cold conditions, leading to the freezing of several water bodies and water supply lines in many areas.

Srinagar recorded a low of minus 7.3 degrees Celsius on Tuesday night -- down from the previous night's minus 6.6 degrees Celsius, the meteorological department said on Wednesday. It has predicted a dip of two to

three degrees in the minimum temperatures in Kashmir over the next Except in Gulmarg, the night temperatures plummeted across all

other weather stations in the Kashmir valley. Currently under the grip of 'Chillai-Kalan', the harshest winter period of 40 days that started on December 21, the Kashmir valley is experiencing below-normal maxi-

mum as well as minimum tempera-

tures for this time of the season, the officials said. The fall in the mercury has led to the freezing of water supply lines even as a thin layer of ice covered the surface of several water bodies,

including the Dal Lake. The city was colder than Gulmarg, a tourist resort town known for skiing activities in north Kashmir, where the mercury settled at a low of minus 6.6 degrees Celsius, up from minus 7.4 degrees Celsius the previous night, the department added.

Pahalgam, the base camp for the annual Amarnath Yatra in south Kashmir, registered a minimum temperature of minus 8.4 degrees Celsius, down from the previous night's minus 7.8 degrees Celsius,

Qazigund, the gateway town to Kashmir, logged a minimum temperature of minus 6.6 degrees Celsius, while Konibal, a hamlet in the Pampore area, was the coldest recorded place in the valley at minus 9.5 degrees Celsius, it said.

Kupwara, in north Kashmir, registered a low of minus 6.4 degrees Celsius, while Kokernag, in south Kashmir, was at minus 5.4 degrees

There is a possibility of light snowfall over the higher reaches towards the later afternoon on December 27 till the forenoon the next day, the Met Office said.

While the weather would stay mainly dry on December 29, 30, and 31, light snowfall is possible in the isolated higher reaches on New Year's Eve, and light snowfall could take place at isolated to scattered places in Kashmir from Janu-

During the 40 days of Chillai-Kalan, the chances of snowfall are most frequent and maximum and

the temperature drops considerably. It ends on January 30 next year, but the cold wave continues even after that in the valley. The 40 days are followed by a 20-day 'Chillai-Khurd' (small cold) and a 10-day

'Chillai-Bachha' (baby cold). (PTI)

Haryana 2024: Election hustle, farmers' struggle bookend sporting glory CHANDIGARH, Dec 25: For a state that witnessed two elections of great significance this year and accounted for more than 20 per cent

contingent, it is only fitting that the

year's top newsmakers came from

two fields: politics and sports. Add to the mix, the issues of farmers and farming -- farmers' protest remained a constant underrunning theme in the state's sociopolitical discourse through the year -- and Haryana's 2024 roundup is almost complete.

As Haryana seemed to be settling into the regular humdrum of daily politics after high-pitched election season came the unsettling news of the passing of its five-time chief minister and political stalwart Om Prakash Chautala. He died on December 20 at the age of 89.

The state entered 2024 with a great deal to look forward to for everybody: a BJP looking to repeat the 2019 feat of winning all 10 LS seats and also retaining power in assembly, a Congress emboldened by projections it would wrest back a large number of parliamentary seats from the BJP and also dethrone it in the state, an AAP hopeful of making inroads in a new territory; and a population in anticipation.

What nobody saw coming though was a change of guard in the government just months before the



assembly polls.

So, when the BJP replaced its chief minister of more than nine years Manohar Lal Khattar with low-profile OBC leader Nayab Singh Saini (54) in March not only the BJP's rivals, but many in the party too were caught off-guard And some were left angry too, like senior BJP leader Anil Vij whose chief ministerial ambition was all too known.

While the BJP gamble did not pay off in the Lok Sabha polls, losing five of the 10 seats to the Congress, it certainly reaped the rewards in the October assembly polls as it staved off a resurgent Congress to win a third consecutive

The AAP was decimated, drawing a blank.

AAP could not win from Kurukshetra, the lone LS seat it contested

in partnership with the Congress. Ajay Singh Chautala-led Jannayak Janta Party, whose alliance with the BJP broke down in March, was also routed in the Assembly polls. The party faced a series of desertions after the alliance ended.

But the JJP was not the only party to face desertions. The BJP and the Congress also saw many of their leaders switch sides to pursue their ambitions in the election year.

In the BJP, Anil Vij voiced his displeasure publicly for not being kept in the loop while replacing Khattar with Saini. Congress leader and Sirsa MP Kumari Selja was apparently miffed with the party for giving a free hand to her bete noire Bhupinder Singh Hooda in ticket

She stayed away from the poll

campaign for days, giving the BJP ammunition to attack the Congress with "anti-Dalit" jibes as the October 5 polling neared. The Congress infighting saw the

departure of senior leader Kiran Choudhry, who joined the BJP with her daughter Shruti Choudhry, ahead of the Assembly election. Kiran Choudhry, daughter-in-law of former chief minister late Bansi

Lal, was made a Rajya Sabha member. Shruti won the Assembly poll and is now a minister in the Saini government. The Congress too got a boost with the return of senior leader and

former Union minister Birender Singh after a decade with the BJP. But all these pre-poll churning didn't end in favour of the Congress in the assembly poll. The party

ended with 37 seats in the House of 90, while the BJP got 48. Experts believe the Congress was in ascendence but it failed to get the final push due to infighting, overreliance on sitting MLAs and rebel-

lion at some places. Hooda later said the assembly poll outcome was opposite to what the atmosphere in the state was.

On the BJP's poll win, Chief Minister Saini said the people "put a stamp" on the government's policies under the leadership of Prime

After he demitted the chief minister's office in March, Khattar fought the Lok Sabha poll from Karnal and won. He is now a Union Minister.

The Assembly poll results announced on october 8 brought notso-good news for many top leaders including Haryana Congress chief Udai Bhan, former assembly speaker Gian Chand Gupta and former deputy CM and JJP leader Dushyant Chautala

Other prominent leaders who lost included Indian National Lok Dal leader Abhay Singh Chautala, BJP's O P Dhankar, Bhavya Bishnoi and Capt Abhimanyu.

But one new entrant who emerged victorious was Olympian Vinesh Phogat who joined the Congress weeks after heartbreak at the Paris Olympics where she was declared overweight and disqualified from the gold medal match the night before the final bout.

The Congress fielded her from

the Julana constituency. Fellow wrestler Bajrang Punia also joined the Congress with her, but he did not fight the polls.

Punia and Phogat had been the face of fierce protests against former Wrestling Federation of India head Brij Bhushan Sharan Singh, who has been accused of sexual harassment by women grapplers. (PTI)

SHYAM BENEGAL: A LOOK AT 10 PATHBREAKING **MOVIES BY THE FILMMAKER**

NEW DELHI, Dec 25: Filmmaker Shyam Benegal, who passed away in Mumbai at the age of 90, heralded a parallel cinema movement in the 1970s and 1980s with his realistic portrayal of societal issues.

Here's a look at some of the most iconic movies of the legendary director.

Ankur - Benegal made a powerful debut in 1974 with "Ankur", a searing and impactful portrayal of class, caste, power and exploitation in rural India. It also marked the first feature film of Shabana Azmi, who went on to become Benegal's frequent collaborator.

The film follows the story of an upper caste son of the village landlord, played by Anant Nag, who becomes involved with his lower caste servant's wife (Azmi). It explores themes of oppression, infidelity, and retaliation by the oppressed.

Nishant (1975) - Once again set in a village, "Nishant" revolves around a group of powerless villagers who are unable to take a stand against the corrupt feudal system.

This movie reunited Benegal with Azmi and introduced another stalwart of Indian cinema, Naseeruddin Shah, who went on to work with the director in many of his later films.

How women were the main victims of village politics and patriarchy was a theme Benegal touched upon in the movie. Also starring Girish Karnad, Amrish Puri, Mohan Agashe, Nag and Smita Patil, the film was selected to compete for the Palme d'Or at the 1976 Cannes Film Festival.

Manthan (1976) - It was inspired by the groundbreaking milk cooperative movement by Dr Verghese Kurien that transformed India into one of the largest milk producers in the



"Manthan", or "Churning" in English, was financed by 5 lakh farmers of Gujarat 48 years ago

who contributed Rs 2 each. The opening credits of the movie read: "500,000 Farmers of Gujarat presents." The film tells the inspiring story of how a young veterinary doctor (Girish Karnad) fights against oppressive forces to establish a milk cooperative that empowers rural farmers.

It also starred Smita Patil, Naseeruddin Shah, and Amrish Puri. A restored version of the film was showcased under the Cannes Classics segment at the Cannes Film Festival in May.

Bhumika (1977) - Benegal reunited with Patil, Shah and Nag for the movie which was based on the autobiography of the doyenne of Marathi theatre and cinema Hansa Wadkar.

Also starring Amol Palekar and Amrish Puri, "Bhumika" is considered one of the best biopics on an Indian movie star.

Junoon (1978) - Adapted from author Ruskin Bond's novella "A Flight of Pigeons", the period film marked Benegal's first association with Bollywood star Shashi Kapoor, who also turned producer with the project.

Set around the Rebellion of 1857, the movie featured Kapoor's wife Jennifer Kendal as well as Âzmi, Shah, Nafisa Ali, Tom Alter, Kulbhushan Kharbanda and Deepti Naval.

The film narrated a story of a rebel, possessed by his desire for a teenage British girl. He shelters her and her family, stretching the limits of what is permissible in traditional Indian culture.

Kalyug (1981) - The film was a modern day retelling of the mythical epic Mahabharatha, set in a contemporary corporate milieu. Benegal directed the movie from a screenplay co-written by him and eminent actor-playwright Girish Karnad.

It featured Shashi Kapoor alongside Rekha, Anant Nag, Raj Babbar, Supriya Pathak, Kulbhushan Kharbanda, Victor Bannerjee, Reema Lagoo, and AK Hangal. The film was praised for the way it explored themes of power, greed and familial conflict, with critics particularly taking note of Benegal's ability to weave a complex narrative.

Mandi (1983) - Considered one of the best films of Benegal's career, the film was a poignant exploration of the lives of women working in the sex trade. Based on Urdu short story "Anandi" by Ghulam Abbas, the movie stood out for its dark humour and layered commentary on gender, class and double standards of the so-

Patil, Shah and Azmi were universally praised for their performances in the movie, which also featured actors Neena

Gupta, Om Puri, Saeed Jaffrey, Annu Kapoor, Satish Kaushik, Pankaj Kapur, Amrish Puri and Ila Arun.

*Mammo (1994) - The movie started a trilogy with Muslim women as protagonists. Starring Farida Jalal and late Surekha Sikri in lead roles, the movie was a tender drama about an elderly woman who spent the bulk of her adult life in Pakistan, while her sisters live in India.

After her husband dies and she is illtreated by his relatives, she lands up in Mumbai, upturning the lives of her sister Fayyazi and Fayyazi's orphaned grandson

The movie won Sikri a National Award for best supporting actress and also starred Rajit Kapur. It was followed by "Sardari Begum" in 1996, which is considered the

second part of the trilogy.

*Zubeidaa (2001) - The third part of the trilogy focussed on the life story of Zubeida Begum, whose son, former journalist Khalid Mohamed, wrote the screenplay of the film.

In the film, Benegal beautifully captured the inner turmoil of a woman torn between societal expectations and personal freedom. It featured Karisma Kapoor as Zubeida, an aspiring Muslim actress, who marries a Hindu prince (Manoj Bajpayee) and becomes his second wife. The critically-acclaimed movie also starred Manoj Bajpayee, Rekha, Surekha Sikri, Lillette

Dubey and Rajit Kapur.

Mujib: The Making of a Nation (2023) - The final film of Benegal's life chronicled the story of Sheikh Mujibur Rahman, the founding father and first president of Bangladesh. A co-production between Bangladesh and India, the film featured a virtually Bangladeshi cast led by Arifin Shuvoo as Rahman. (PTI)

Boney Kapoor submits master plan for Noida Film City

NOIDA, Dec 25: Filmmaker Boney Kapoor and Bhutani Infra-backed firm Bayview Projects has submitted the master plan for the development of the first phase of the much-anticipated Noida International Film City and hopes to complete the work within three years post approval, officials have said.

For Bayview Projects, Kapoor submitted the master plan to the Yamuna Expressway Industrial Development Authority (YEIDA) on Tuesday. YEIDA CEO Arun Vir Singh confirmed receiving the master plan and told reporters, "It will be our endeavour to ensure that the plan is approved at the earliest if it conforms to all norms and guidelines.'

The ambitious project of the Uttar Pradesh government is to be built on a 1,000-acre land in a publicprivate partnership in Sector 21 of YEIDA along the Yamuna Expressway near Delhi. About 230 acre will be developed in the first phase.

Bayview Projects won the bid on January 31 with the offering of 18 per cent rev-

enue share to the Uttar Pradesh government - the highest among four bidders.

Addressing the media alongside Singh, Kapoor detailed his vision for the film city's development, emphasising its potential to revolutionise filmmaking in India and attract global talent.

Kapoor said the first phase of the project would include the completion of sound stages and a dedicated film university.

"The university is being built to train talent from across the country, particularly Uttar Pradesh, enabling individuals to come with a script and leave with a complete film," Kapoor said.

Facilities will encompass all aspects of production, including post-production, he

"Filmmakers won't need to go elsewhere for resources. Everything, including ?equipment and infrastructure, will be available right

The first phase, targeted for completion within three years, will serve as a foundation for expanding the film city, he said

Kapoor plans to invite filmmakers from around the world to utilise the infrastructure. "Our aim is to make this a one-stop destination for filmmaking," he added.

Kapoor outlined several standout features of the film city like Virtual Studios, underwater filming facilities,

Additionally, there will be a designated floor equipped with advanced technology to replace traditional green screens, enabling actors to visualise scenes on LED screens in real-time, he said.

There will also be large water tanks for shooting complex underwater scenes and ship-based sequences, he added.

Kapoor envisions a setup similar to Parliament's visitor galleries, where the public can witness live shooting and interact with directors or actors during breaks, depending on their convenience.

Drawing parallels to international filmmaking hubs, Kapoor expressed confidence in positioning Noida International Film City as a global destination. (PTI)

The Indian skipper was the last to hit the nets on Christmas eve and there is speculation doing rounds that he could replace the team's most assured opener, KL Rahul, at the top of the order.

If that happens, Rahul will come in at No. 3 while Shubman Gill could either play in the middle order or make way for a Dhruv Jurel in the playing eleven. The series is currently locked 1-1.

The Indian skipper stopped batting in the middle order after being elevated to the opening slot back in 2019. But he chose to come down in Adelaide and Brisbane to accommodate an in-form Rahul and first-Test centurion Yashasvi Jaiswal

The move was a spectacular failure and it remains to be seen how the team adjusts in case Rohit opens and Gill is either dropped or bats at number five.

"Carlos Corberan has been appointed as coach of Valencia CF. signing a contract through to 2027," a statement on Valencia's website said early Wednesday. "A buy-out option in his contract with West Bromwich Albion was taken up to allow him to leave.'

No official figure was given but the compensation for the former Valencia youth player was reported to be in the region of \$3 million.

The Spaniard led West Brom to its current seventh place in England's second-tier Championship.

West Brom earlier said in a statement that the 41-year-old Corberan "is set to return to his homeland with the club's gratitude and best wishes following a two-year tenure at The Hawthorns." Chris Brunt, Damia Abella and Boaz Myhill "will oversee first-team duties until further notice." Valencia's next Spanish league match will be against Real Madrid at home on Jan. 3 in a game postponed from October because of the deadly floods that hit Valencia. Konstas has talent and attitude to go with it, reckons Ponting

DUBAI, Dec 25: Young Sam Konstas has certainly got talent for international cricket and a "bit of an attitude to go with it" but it won't be an easy debut for the teenager against a world class bowling attack, reckons legendary Ricky Ponting.

Australia's newest batting sensation Konstas, 19, is set to make his debut in Boxing Day Test against

With only 11 First-Class matches under his belt, Konstas will take the opening slot alongside the experienced Usman Khawaja in the fourth Test starting here Thursday with Australia desperate to find the right combination at the top.

Konstas had previously failed to win favour from the Australian selectors who picked Nathan Mc-Sweeney for the first three Tests of the Border-Gavaskar Trophy, but the latter's ordinary returns forced them to give the New South Wales' opener a crack at Test cricket.

"I've seen a lot, there's a lot of talent there, no doubt about it," Ponting told the ICC Review while talking about Konstas.

"The way he played in the PM's XI game (he scored 107 against the Indians), the way that he was able to approach his first BBL game the other night ... I know it's different formats, but you can see that the talent is there and there's also a bit of an attitude to go with it."

"And not a bad attitude, (but) an attitude that he knows that he's good and he wants to show the world that he's good," added Ponting. Konstas is the youngest batter since Ponting in 1993 in Australia's Sheffield Shield to have scored two hundreds in a match.

Ponting, however, said the situation will be a challenging one for the right-hander who has shown having a knack for getting big runs.

'There's still a challenge there. It's a Test match. It's your first Test match. You're playing against some of the best bowlers in the world,"

South Africa aims to seal its place in WTC final in test series against Pakistan



CENTURION (SOUTH AFRICA), Dec 25: South Africa will be eyeing a place in the World Test Championship final with an all-seam attack against

The Proteas need to win one of its remaining two test matches in this WTC cycle to guarantee a place at the Lord's final next year and captain Temba Bavuma believes expectations have risen in his team to do well in the two-test

"There'll be pressure that comes with that," Bavuma said. "But to be honest with you, we're series 2-0. We understand that for us to do that, there's certain things that we need to do as a team: keep things simple, keep doing the small things right, and allow the results to take care of itself."

South Africa has included four fast bowlers in the lineup with Corbin Bosch, who consistently bowls above 140 kph, set to play his first test at his hometown.

Seasoned fast bowlers Kagiso Rabada and Marco Jansen will team up with Dane Paterson and Bosch to challenge Pakistan's batters on an expected pacey Centurion pitch where fast bowlers have a clear advantage over the last six with spinners dismissing only 16 batters.

Heading into the tests, South Africa's top-order batters did struggle against Pakistan in a rare 3-0 ODI whitewash with Tony de Zorzi, Ryan Rickelton and Tristan Stubbs all failing to read the offspin bowling of Salman Ali Agha in the opening game of the series.

"Whether it's easy, whether it's hard, we've got to find a way to do it," Bavuma said. "Whatever, I don't know, trauma that was there guys will have to deal with it."

Pakistan has long been struggling in test matches in South Africa, losing 12 and winning just first toured the country in 1995. Pakistan's below-par show in South Africa includes its lowest test score of 49 at the Wanderers

Pakistan is lying at No. 7 in the WTC points table and Aaqib Javed is its fourth head coach in this WTC cycle with Mickey Arthur and Mohammad Hafeez quitting after one series. Jason Gillespie resigned just two weeks before Thursday's test.

Gillespie, who was hired by the Pakistan Cricket Board in April, had a horror start to his two-year contract when Bangladesh swept Pakistan in Pakistan 2-0 in the test series before England won the first test at Multan.

Gillespie was removed from the selection panel and Javed masterminded Pakistan's back-to-back wins against England on two engineered spinning pitches where Noman Ali and Sajid Khan bagged 39 wickets.

But Pakistan has brought in only Noman Ali for the two-test series in South Africa and is still contemplating whether to follow South Africa and go with an allout pace attack.

Shaheen Shah Afridi, who played in the preceding white-ball series in South Africa, has been surprisingly left out for the test

Naseem Shah and Babar Azam return to the test fold after missing the last two home tests against England while selectors have recalled seamer Mohammad Abbas after three years with the left-arm seam option of Mir Hamza in the squad.

Abbas took 90 wickets in 25 test matches from 2017 to 21 before he ran out of selectors' favor despite his consistent performances for Hampshire in England and in domestic firstclass cricket. (AP)

When the skipper was asked about his feelings during his Test debut at 18, Cummins spoke about an element of naivety that can stop a kid from overthinking about how big a deal it is.

"I spent a bit of the time wondering why or how I was there, how it happened so quick. I just remember being really excited and I think it's similar to Sammy (Konstas) this week.

INDIAN CRICKET IN 2024

Painful trophy wait ends before rare loss at home triggers transition talk

NEW DELHI, Dec 25: The monkey was finally off India's back in a roller-coaster 2024 when the financial giants of international cricket ended a 13-year wait for a world title, lost a rare Test series at home and dealt with transition triggered by both expected and unexpected retirements by the stalwarts of the game. There was plenty of action over the last 12 months that kept the loyal Indian fan interested.

The Indian cricket team and its unparalleled fan base were desperate for an ICC trophy after repeatedly faltering in the knock-out stages over the past decade, most recently in the ODI World Cup final at home last year.

The trophy finally came home after Rohit Sharma and Co. played a near perfect tournament to become the T20 World Cup champions in the USA and the Caribbean.

India's clarity of thought throughout the one-month long event was remarkable and with a little bit of luck on their side, especially in the final at Barbados, they were able to go the distance. On undercooked pitches in New York, they were pace heavy before unleashing their trump card Kuldeep Yadav from the Super 8 stage of the tournament.

India picked as many as four spinners in the squad but played three in Ravindra Jadeja, Axar Patel and Kuldeep. With Jadeja not getting to do much with both bat and ball, Axar came of age in the competition producing match-winning performances with both and ball.

The pace duo of Jasprit Bumrah and Arshdeep Singh also played their part to perfection, collecting 15 and 17 wickets

respectively. In the batting department, Rohit led from the front with a fearless approach that demoralised opposition attacks. His approach was best summed up in the Super 8 game against Australia where he tore into the likes of Mitchell Starc and Pat
