

SENSEX DROPS 235 POINTS

Markets end lower amid caution ahead of inflation data

MUMBAI, Dec 12: Equity market benchmark indices Sensex and Nifty ended lower on Thursday due to selling pressure in index majors Reliance Industries, L&T and HUL as investors turned cautious ahead of the inflation data an-

Besides, weakness in the rupee and foreign fund outflows hit investors' sentiment, traders

The 30-share BSE benchmark Sensex declined 236.18 points or 0.29 per cent to settle at 81,289.96. During the day, it dropped 314.5 points or 0.38 per cent to 81,211.64.

The NSE Nifty dropped 93.10 points or 0.38 per cent to 24,548.70.

"Investors traded with caution ahead of the announcement of inflation and IIP data and steadily cut their equity bets. There is a lack of confidence amongst investors due to global uncertainty, rising US bond yields fuelling fund outflows, and persisting conflicts in the Middle East and West Asia," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.

Among the 30-share Sensex blue-chip firms, NTPC. Hindustan Unilever. Tata Motors. Maruti, Larsen & Toubro, Reliance Industries. Asian Paints and State Bank of India were the biggest laggards.

Bharti Airtel, IndusInd Bank, Tech Mahindra,



Infosys, Adani Ports and Tata Consultancy Services were among the gainers.

"Markets closed slightly lower on the weekly expiry day, shedding nearly half a per cent amid mixed signals. The market awaits a fresh catalyst to resume its rebound, while rotational buying in key sectors like IT and banking keeps recovery hopes alive," Ajit Mishra - SVP, Research, Religare Broking Ltd, said.

The BSE smallcap gauge tanked 1 per cent, and the midcap index declined 0.56 per cent. FMCG dropped 1.15 per cent, energy (1.03

per cent), industrials (0.83 per cent), consumer discretionary (0.81 per cent), oil & gas (0.73 per

IT, utilities, teck and BSE Focused IT were the gainers.

"The market continued to remain rangebound ahead of domestic CPI data and a weakening rupee. Though inflation is anticipated to drop, investors are maintaining a close vigil on the vegetable prices, which will determine the future rate trajectory. Meanwhile, the Nifty IT index reached a new high after US inflation data met expectations, boosting hopes for a Fed rate cut next week," Vinod Nair, Head of Research, Geojit Financial Services, said.

In Asian markets, Seoul, Tokyo, Shanghai and Hong Kong settled in the green. European markets were trading on a mixed

note. Wall Street ended mostly higher in overnight trade on Wednesday.

The rupee depreciated by 4 paise to settle at an all-time low of 84.87 (provisional) against the US dollar on Thursday

The company's client, a leading cloud service provider, has rented as much as 6 MW IT Load capacity, consisting of high-density racks spread over an entire floor, and a bulk bandwidth, the filing said.

The tenure of the contract is 10 years.

No court to entertain, pass

There are several cross petitions which seek strict implementation of the 1991 law to maintain communal harmony and to preserve the present status of mosques, sought to be reclaimed by Hindus on the ground that they were temples before invaders razed them.

The bench made it clear that it would be examining the "vires (legality), contours and ambit" of the 1991 law and it was imperative to ask other courts to "stay off their hands" till it passed any further orders.

"In pending suits, the courts will not pass any effective interim or final order, including order of survey, till further orders," the bench said. Senior advocate J Sai Deepak, appearing for a Hindu party, opposed the order restraining all other courts and said the parties should have been heard before such a direction.

The CJI said it was quite natural to ask courts not to pass any order as the Supreme Court was hearing the

larger issue. The bench said if parties insisted then, the matter could be sent to a High Court. 'Can the trial courts overreach the Supreme Court," asked the bench and said the apex court was already dealing with the validity of the law. Observing the court couldn't decide the matter without the Centre's response, it asked the government to file its reply to the pleas and cross ones in four weeks. It also granted a further of four weeks to other parties to file their rejoinder after the Centre filed its reply.

Notably, the bench had issued notice to parties, including the Centre, on the lead petition in September 2022. The bench also appointed nodal counsel for assisting it in the hearing on the pleas which would be listed after eight weeks. During the hearing, the bench asked, "How many suits are pending now"

One of the advocates said a total of 18 suits pertaining to 10 mosques were pending in several courts across the country. "Ultimately, we will have to hear the arguments," the bench said, observing the primary issue was with regard to Sections 3 and 4 of the 1991 law. While Section 3 deals with the bar of conversion of places of worship, Section 4 pertains to the declaration as to the religious character of certain places of worship and bar of jurisdiction of courts, etc.

The bench also allowed the pleas of various parties including Muslim bodies seeking to intervene in the proceedings. The top court is seized of about six pleas, including the lead one praying that Sections 2, 3, and 4 of the Act be set aside.

Among the various reasons submitted was the contention that these provisions took away the right of judicial remedy to reclaim a place of worship of any person or a religious group. Various Muslim parties, including the Gyanvapi Mosque management committee, moved the apex court to oppose several pending petitions that challenge the constitutional validity of the 1991 law.

The mosque committee listed a series of contentious claims made over the years concerning various mosques and dargahs (shrines), including the Shahi Idgah Masjid in Mathura, the Quwwat-ul-Islam Mosque near Delhi's Qutub Minar, the Kamal Maula Mosque in Madhya Pradesh, and others. It therefore said the petitions challenging the Act were filed with "mischievous intent" to facilitate lawsuits against these religious sites, which the 1991 Act currently protected. (PTI)

Delhi govt to raise financial aid to

The AAP, pitted against a confident BJP trying to upstage it in the polls due before February next year, believes the announcement would boost its chances in the elections.

Kejriwal asserted that he was a "magician" of accounts and knew how to save money to fund the scheme. BJP leaders who raised questions about the scheme and created doubts "should not worry any longer", he said. The AAP government allocated Rs 2,000 crore for the scheme under the budget. The eligibility criteria of the potential beneficiaries laid down that the woman should not be employed with the government or receiving pension, and they should not be paying GST or income tax.

The scheme is likely to benefit around 45 lakh eligible women, a significant number which the AAP believes would help the party bolster its performance in the poll, especially because of the promise to raise the amount to Rs 2,100 after the elections. The BJP, which is yet to announce its manifesto, attacked Kejriwal, asking why the AAP government did not implement such a scheme for women in Punjab despite a similar announcement made by him before the elections in the state in 2022.

"Kejriwal is only repeating his fake promise. Even during the Lok Sabha polls in Delhi, they got women to fill up forms but paid nothing to them," Delhi BJP president Virendra Sachdeva claimed. Delhi chief minister Atishi said the honorarium amount will be raised to Rs 2,100 after the elections. (PTI)

India votes in favour of UNGA

The resolution demanded immediate access by the civilian population in the Gaza Strip to basic services and hunanitarian assistance indispensable to its survival, while "rejecting any effort to starve Palestinians"

It further demanded the facilitation of full, rapid, safe and unhindered entry of humanitarian assistance, at scale and under the coordination of the United Nations, to and throughout the Gaza Strip and its delivery to all Palestinian civilians who need it, including to civilians in besieged north Gaza, who are in urgent need of immediate humanitarian relief. It also demanded that the parties fully comply with their obligations under international law in relation to persons they detain, including by releasing all those arbitrarily detained. It called upon all parties to fully comply with international law, including international humanitarian law, notably with regard to the protection of civilians, especially women and children.

It reiterated its unwavering commitment to the vision of the two-state solution, with the Gaza Strip as part of the Palestinian State, and where two democratic States, Palestine and Israel, live side by side in peace within secure and recognized borders, consistent with international law and the relevant United Nations resolutions.

The resolution rejected any attempt at demographic or territorial change in the Gaza Strip, including any actions that reduce the territory of the Gaza Strip, and stresses the importance of unifying the Gaza Strip with the West Bank under the Palestinian Authority.

Last week, India voted in favour of a General Assembly resolution that called for the withdrawal of Israel from the Palestinian territory occupied since 1967, including East Jerusalem, and reiterated the call for achieving a comprehensive, just and lasting peace in the Middle East. The draft resolution 'Peaceful settlement of the question of Palestine' tabled by Senegal was overwhelmingly adopted in the 193-member General Assembly on Tuesday.

India was among the 157 nations that voted in favour, while eight Member States - Argentina, Hungary, Israel, Micronesia, Nauru, Palau, Papua New Guinea and the United States voted against it. Cameroon, Czechia, Ecuador, Georgia, Paraguay, Ukraine, and Uruguay abstained. (PTI)

NEW DELHI, Dec 12: Gold (MCX), gold contracts for Februprices climbed ₹ 500 to ₹ 80,900 per 10 grams in the national capital on Thursday due to persistent buying by retailers and jewellers, according to the All India Sarafa Association.

The precious metal of 99.9 per cent purity finished at ₹80,400 per 10 grams in the previous trading session. The yellow metal has jumped nearly ₹ 2,000 in the past three sessions.

Silver also rallied ₹ 700 to ₹ 97,000 per kg on Thursday. The white metal settled at ₹96,300 per kg in the previous session.

The price of gold of 99.5 per cent purity also surged ₹ 500 to ₹ 80,500 per 10 grams. It ended at ₹ 80,000 per 10 grams on Wednes-

According to traders, persistent buying by jewellers and a firm trend in the international markets were among the factors that aided

the rally in gold prices. Meanwhile, in futures trade on the Multi Commodity Exchange

ary delivery dipped ₹ 114 or 0.14 per cent to ₹78,888 per 10 grams.

"Gold traded within a volatile range and experienced minor profit booking at higher levels, with Comex prices facing resistance near USD 2,720-2,725 and MCX encountering a hurdle around ₹ 79,000," Jateen Trivedi, VP Research Analyst of Commodity and Currency at LKP Securities, said.

However, silver contracts for March delivery climbed ₹ 420 or 0.44 per cent to ₹ 96,222 per kg.

Globally, Comex gold futures fell USD 9.70 per ounce or 0.35 per cent at USD 2,747 per ounce.

"Gold surged past USD 2,700 in Wednesday's session after inflation data came in slightly mixed, however, market participants continued to discount one more rate cut in December's US Federal Reserve meeting supporting bullion," Manav Modi, Analyst, Commodity Research, Motilal Oswal Fipolitical tensions, especially in the Middle East, with Syria also now in the picture.

Distress is also rising amid geo-

China's central bank increasing their gold reserve once again has also supported sentiment. Any change in rate cut expectations could increase volatility in prices, Modi said.

"Traders are now focusing on US economic data, including the producer price index (PPI) and weekly unemployment claims," Saumil Gandhi, Senior Analyst of Commodities at HDFC Securities, said. Besides, the US Fed and European Central Bank's (ECB) monetary policy, press briefings are expected to influence the bul-

lion prices, Gandhi added. The focus, however, will remain glued to the highly anticipated Federal Open Market Committee's (FOMC) monetary policy meeting next week, which will play a key role in determining the next leg of a directional move for the nonyielding commodity. (PTI)

'One nation, one election': Cabinet clears Bill

Draft legislation likely to be introduced during Parl's ongoing session

NEW DELHI, Dec 12: The Union Cabinet on Thursday approved two bills, including one to amend the Constitution to implement "one nation, one election", and the draft legislations are likely to be introduced in Parliament in the ongoing winter session,

As of now, the Cabinet has given its nod to draft legislations to hold simultaneous polls to the Lok Sabha and legislative assemblies only, the sources said.

While a high-level committee led by former president Ram Nath Kovind had also proposed holding the municipality and panchayat polls along with the national and state elections in a phased manner, the Cabinet has decided to stay away, "as of now", from the manner in which local body elections are conducted. The Constitution amendment bill to hold simultaneous polls to the Lok Sabha and state assemblies will not require ratification by at least 50 per cent of the states, the sources noted.



AAP's go solo gamble

am Aadmi Party chief Arvind Kejriwal has refused an alliance with Congress in the upcoming Delhi Assembly elections. It assumes significance on two counts. It marks a turning point in the political landscape of the national Capital. It underscores AAP's confidence in its political dominance. But it reveals a challenge to the unity in the opposition against the BJP-led NDA dispensation. The BJP will always like to be faced with a fractured Opposition rather than a united one. Kejriwal shunning Congress has implications which goes beyond the dynamics of both the parties. It risks splintering the opposition vote which is to BJP's benefit. The BJP gets an advantage in constituencies which are to witness a triangular contest. In so many words, such electoral battles will take place in constituencies where the Congress still has a foothold. Rise of AAP has marked systematic dismantling of Congress's long standing dominance. Post its landslide victories in 2015 and 2020 elections, the AAP appears to be the first choice of Delhi's electorate. The AAP leadership believes that its brand of governance will carry the day. It is its signal to stand on its own. The AAP, having nothing to do with Congress, conveys a message to the other INDIA constituents who have recently voiced a demand for West Bengal chief minister Mamata Banerjee heading the anti-BJP alliance. In the days to come, it is now upto the Congress to shore up its claim to the INDIA leadership.

The AAP having nothing to do with Congress is a snub too. It may be recalled that the Congress has refused seat sharing with AAP in Haryana. The Congress despite having a more extensive national support base than the AAP is facing an existential crisis in Delhi. After being reduced to irrelevance in the past decade it looked in vain for a lifeline from the AAP in the coming Delhi Assembly elections. The decision of AAP not to accept Congress as a fellow traveller in Delhi Assembly poll is rooted in real political rationale. The Congress is unable to reclaim voter confidence in Delhi assembly constituencies, the padayatra by Rahul Gandhi notwithstanding. But it is not a win-win situation for AAP in the coming election There are problems galore, the AAP organization is not in good health. There are many desertions. AAP leadership is perhaps exuding too much overconfidence ignoring BJP's performance in the Lok Sabha polls

Going it alone is certainly a step towards political self sufficiency for AAP. Even as it stands poised to challenge traditional political players, its decision for a solo run focuses on the problem of managing egos and balancing ambitions among the INDIA coalition partners. It is a high gamble for AAP chief Arvind Kejriwal. A victory will shoot up his stocks in INDIA and the national Opposition while a defeat will plummet it

Pak launches major offensive to expand trade, investment ties with B'desh

n December 9 Monday, Indian foreign secretary held crucial talks in Dhaka with his Bangladesh counterpart as also the head of interim government Dr. Muhammad Yunus to find some ways for improving the bilateral relations in the wake of reports of attacks on Hindus by the communal elements of the country. The discussions were the first at the high level between the two countries in the Bangladesh capital with no breakthrough in sight though both expressed their desire to continue the dialogue.

No sooner after the departure of the Indian foreign secretary for New Delhi from Dhaka, Pakistan Government's trade ministry swung into action to identify the areas of trade and investment in Bangladesh so that in a short term, the Yunus government can get some assistance from Islamabad in meeting its economic challenges posed by its present re-

Already, in the last two months, Islamabad and Dhaka had talks about the trade possibilities but now, Islamabad wants a full-fledged meeting of the Pakistan Bangladesh Joint Economic Commission proposed to be held in end December/January to start a new era in bilateral economic relations. Bangladesh is also making preparations and its ministries have been asked to earmark the areas where Pakistan can replace the supplies from Indian sources. Islamabad has mostly identified but Bangladesh is yet to make its list final as the administration is not sure to what extent, Dhaka can be benefitted by diverting to Pakistan supplies from India.

The holding of a JEC meeting in a big way is the brainwave of the Pakistan foreign ministry and the Islamabad strategy is to give some concessions to Bangladesh taking into the additional costs due to distance compared to India. Bangladesh has already requested granting duty free access to ten product categories covering 104 items.. Further Pakistan is assuring Bangladesh of a Free Trade Agreement (FTA).

More than trade Pakistani businessmen are interested in investments in Bangladesh having a huge market. A large number of non-resident Pakistani businessmen who are called NRPs like our NRIs, are in touch with both Islamabad and Dhaka for setting up facilities in Bangladesh. Many of them are interested in technical cooperation in textiles, the premier industry of Bangladesh. At their request, Pakistan government is including the joint ventures s an important part of discussions at the coming JEC meeting.. Further, Bangladesh-Pakistan Chamber of Commerce office will be set up in both Dhaka and Chittagong.

While right now, Indian officials are not generally visiting the Bangladesh government offices for discussions as they used to do before August 5 this year, the Pakistan High Commission officials in Dhaka are now regular in meeting the officials in Dhaka.. The Pak officials based in Dhaka High Commission on the basis of bilateral discussions have proposed the setting up of a joint venture between the oil exploration agencies of the two countries. A proposal has been mooted to sign a MoU between the two corporations during the JEC meeting. The proposed JV will be working for joint hydrocarbon and minerals exploration. There is another proposal that an MoU will be signed between Trade Development Authority of Pakistan (TDAF) and Export Promotion Bureau of Bangladesh (EPB) at the JEC meet..

The ouster of Sheikh Hasina from power in Bangladesh on August 5 and the installation of the Yunus regime was nowhere near the imagination of the Indian policy makers. South Block was confident that like earlier challenges, Hasina would ride through this anti-quota movement challenge also. But the scenario turned completely opposite. From a virtual non-entity in Hasina years, Pakistan has entered the centre stage of Bangladesh politics. Last month, Bangladesh imported 35, 000 rifles from Pakistan. An agreement has been concluded that Pakistan army will conduct training of a section of Bangladeshi soldiers. Pakistan ship has landed in Chittagong Port for the first time in the last five decades. Pakistan army and Bangladesh army are cosying.

Superstition: Holding back Assam's growth

uperstition continues to wield significant influence over many aspects of daily life In Assam, impeding progress and growth in numerous ways. Despite advancements in science, technology, and education, deeply ingrained beliefs in the supernatural persist, particularly in rural areas. These beliefs are often entrenched in local customs and rituals, shaping not only individual behavior but also societal structures. As Assam strives to move forward, it is increasingly clear that superstition represents a barrier to its full potential. Its effects reach across healthcare, education, agriculture, and gender relations, keeping a substantial portion of society bound to outdated and irrational practices. One of the most visible and

harmful manifestations of superstition in Assam is the persistent belief in witchcraft. In remote areas, particularly in the tea gardens and rural villages, accusations of witchcraft are not just rare occurrences but a prevalent social issue. When families experience hardships such as crop failure, illness, or an untimely death, they often resort to supernatural explanations. The most common scapegoats in these situations are older women, who are sometimes accused of being witches responsible for bringing misfortune. These accusations, rooted in deep superstition, lead to tragic consequences, including physical violence, social ostracism, and, in extreme cases, death. Despite the passing of laws like the Assam Witch Hunting (Prohibition) Act, the practice continues, particularly in areas where education and law enforcement remain weak. The impact of such violence is twofold: not only does it result in direct harm to the accused, but it also perpetuates gender inequality, as it is predominantly women who bear the brunt of these superwitchcraft underlines a larger societal issue in Assam, one that prevents people from addressing real problems with practical solutions. Rather than recognizing that economic hardship or health issues may have more mundane and complex causes, such as poor farming practices or inadequate healthcare, the supernatural is invoked. This reliance on the irrational holds back societal progress by obstructing critical thinking and scientific inquiry. For example, in Assam's tea gardens, which play a significant role in the state's economy, farmers often resist adopting new techniques or technologies, opting instead for traditional, sometimes superstitious practices that they believe will ensure better harvests. Such attitudes prevent the region from achieving its agricultural poten-

tial. Crop rotation, efficient irrigation systems, and modern fertilization techniques-methods that have been proven to increase vields—are frequently shunned in favor of rituals and prayers. As a result, agricultural productivity remains stagnant, and rural poverty continues to be a pervasive issue.

Superstition also hampers Assam's healthcare system. In the face of illness, particularly in remote villages, many people turn to traditional healers, religious figures, or perform rituals in the hope of curing diseases that could easily be treated with modern medicine. While traditional medicine has its place in Assam's cultural heritage, the widespread practice of relying on superstitious remedies often delays crucial medical intervention. This is especially true in the case of serious illnesses, where waiting for a ritualistic cure can prove fatal. The belief that certain ailments are the result of curses or witchcraft leads many to ignore proper

In many ways, this belief in health crises. In rural Assam, where healthcare facilities are often inadequate, the consequences are grave. The lack of access to quality healthcare, compounded by the pervasive influence of superstition, means that preventable diseases continue to claim lives, especially in vulnerable communities.

The education system in Assam also faces the destructive influence of superstition. Despite the increasing emphasis on education in recent years, many rural families still harbor beliefs that limit the educational aspirations of their children. Superstitions about auspicious times to begin school or the belief that certain subjects are not suitable for girls are prevalent. In many households, children, particularly girls, are often discouraged from pursuing higher

education due to superstitious ideas about their future roles in society. Some parents, influenced by belief systems that prioritize marriage over education, may even prevent their daughters from completing their schooling. This stunted educational development leads to a cycle of poverty, where women are left with few opportunities for economic independence

or social mobility. Superstitions are not limited to the private sphere but extend into the broader socio-political landscape of Assam as well. The public realm, where policy decisions and community activities take place, is often influenced by irrational beliefs. Politicians and local leaders may appeal to superstitions to gain favor with their constituents, using promises of spiritual interventions or invoking religious symbolism to secure votes. This manipulation of super-

belief systems are exploited to maintain power rather than being challenged or addressed. As a result, rational policies focused on economic development, healthcare, or education are often sidelined in favor of spiritual or superstitious agendas.

Even in urban areas, where education and modernity are more widespread, superstition remains an undercurrent in public life. For example, astrology plays a significant role in marriage and career decisions, influencing everything from when and whom a person marries to what profession they choose to pursue. This reliance on astrology and other forms of divination reflects a broader cultural phenomenon in which people look outside themselves for explanations and solutions, rather than rusting in personal effort, planning, and education. It is a mindset that holds back both individual and collective growth. When life choices are made based on astrologers' readings or superstitions about the future, it limits the ability to think critically and act independently. The result is a society that remains tethered to tradition, even when it no longer serves its best interests.

The persistence of superstition in Assam's society cannot be fully understood without considering the psychological factors at play. Superstition offers a sense of control in a world that often feels uncertain. In rural areas where economic insecurity is rampant and where environmental or social conditions may seem unpredictable, superstitionprovides people with a way of understanding and coping with the complexities of life. It serves as a form of social cohesion, offering communities a shared belief system. However, this comfort comes at a high cost. How to increase voter turnout in elections

he results of the Maharashtra and Jharkhand Legislative Assembly elections are now out, and new governments have been formed in both states. The Chief Ministers and some ministers have also taken their oaths

In the Maharashtra Assembly elections, over 65% voter turnout was recorded, the highest in the last 30 years. This is significant for two reasons: first, it shows an almost 4% increase compared to the 2024 Lok Sabha elections, and second, it is close to the average national voter turnout of around

But the question arises can this voter turnout percentage be considered sufficient for a strong democracy? Certainly not! Then, what can be done? This is a serious issue that all responsible citizens of the country need to think about how

can voter turnout be increased in elections? As mentioned above, the Maharashtra Assembly elections recorded over 65% voter turnout, the highest in the last 30 years. This is significant for two reasons: first, it shows an almost 4% increase compared to the 2024 Lok Sabha elections, and second, it is close to the average national voter turnout of

Maharashtra's data is noteworthy because the state has the largest urban population in the country. Historically, it has lagged behind the national average due to low voter turnout in cities and towns.

However, a closer look at Maharashtra's data reveals that voter apathy in urban areas hasn't entirely disappeared. For example. Western Maharashtra's Kolhapur district recorded a high voter turnout of 76.25%, followed by Gadchiroli a region often in the news for Maoist activities at 73.68%. In contrast, Mumbai City district recorded a low voter turnout of 52.07%. Similar figures were observed in other urban districts like Pune, Thane, and Mumbai Suburban.

On the positive side, voter turnout has improved overall across the state. The credit for this change, though slow and gradual, goes primarily to the current Election Commission of India. This time, the Election Commission was quite proactive in increasing voter turnout. Its campaign involved social media and local celebrities, from cricketers to film stars. Measures like setting up polling stations in high-rise buildings and residential societies and introducing a token system to reduce wait times were also implemented. High-voltage campaigns by political parties also helped increase voter participation. Maharashtra's improved voter turnout is reassuring for Indian

That said, urban areas across the country generally see lower voter turnout. From Shimla to Surat, urban voter apathy remains consistent. This trend is not new. During the first three decades of elections, urban voter participation was much better. However, since the 1980s, the gap between urban and rural voter turnout has widened. Urban anathy needs to be understood. Urban India contributes 60% to the GDP and a significant share to taxes. However, the condition of cities continues

Take Delhi, for instance. The city's pollution levels have become so severe that life has become difficult for residents. Delhi is now the most polluted capital in the world. This is the state of the capital. In recent years, major cities like Delhi, Mumbai, Chennai, and Bengaluru have been paralyzed by floods during the rainy season. Life in these cities came to a halt for several days. Waterlogging on roads caused traffic jams, disrupted rail services, flooded homes, and forced schools and colleges to shut down. These recurring issues highlight the poor state of urban planning and infrastructure.

It's important to understand that urban India is the backbone of the country's economy. Almost the entire service sector is concentrated in cities. According to census data, 31% of the population lives in cities, although non-governmental estimates suggest the urban population is much higher. Cities provide employment opportunities, and they are where the dreams of the country's youth are realized.

This neglect leads voters to become disillusioned with their representatives. They feel that when their leaders are ineffective, there s no point in voting. Voters are repeatedly let down by their representatives.

the scorching heat gripped almost the entire country. Despite this, voters stepped out of their homes to cast their votes. On election day, temperatures in many places exceeded 42 degrees Celsius. It wasn't easy to campaign or stand in long queues at polling stations in such harsh weather. Yet millions of voters braved the heat and exercised their democratic right.

This is encouraging and a positive sign for our democracy. People understand that their votes shape the nation's destiny. That's why they step out to vote.

However, the already proactive Election Commission must make polling stations more accessible and attractive to draw even more voters. Power plays and electoral controversies in Maharashtra's political shift

he political landscape of Maharashtra has recently witnessed dramatic upheavals following the resounding victory of the BJP-led Mahayuti alliance in the Assembly elections. Devendra Fadnavis, a seasoned leader and former Chief Minister, has returned to power, underscoring the BJP's political strategy and dominance in the state. Yet, this transition of power has not been without its share of internal discord and controversies, highlighting the complexities of coalition politics and the nuanced interplay of electoral strategies.

After the BJP's spectacular success, securing 132 of the 288 seats, the Mahayuti alliance seemed poised for celebratory fireworks. However, the post-election period revealed internal fissures, particularly in the dynamics involving Eknath Shinde, the former caretaker Chief Minister, who retreated to his village in Satara amid the unfolding drama. Shinde, who had risen to prominence by splitting from the Shiv Sena to form a BJPbacked government, believed his tenure as Chief Minister was guaranteed for another term. His aspirations, however, collided with the political calculus of the BJP's central leadership, which ultimately favored Fadnavis.

Shinde's disappointment stemmed from his expectation that his leadership, accessibility, and cooperation as a junior partner in the ruling alliance would secure his continuation in the role. However, the BJP's leadership recognized Fadnavis's political acumen, intelligence, and administrative prowess as indispensable assets. Fadnavis, despite being

overlooked initially, demonstrated remarkable discipline and resilience, accepting his role as Deputy Chief Minister under Shinde's leadership in the previous government. This time, however, the BJP brass could not overlook his credentials, and he was reinstated as Chief Minister.

The rise of Fadnavis underscores the BJP's strategic emphasis on consolidating power through capable leadership and meticulous planning. During his earlier tenure as Chief Minister from 2014 to 2019, Fadnavis focused on infrastructure development and maintained a hands-off approach to the operational intricacies of law enforcement, a quality that distinguished him from predecessors. His pragmatic governance style and ability to navigate Maharashtra's complex political terrain ultimately tipped the scales in his favor.

Shinde, recognizing the inevitability of his diminished role, sought to secure the influential Home portfolio. However, this attempt was thwarted as Fadnavis retained control over the department, reflecting the BJP's prioritization of centralized authority within the alliance. The Home portfolio, often regarded as the cornerstone of state power due to its control over law enforcement and the ability to influence dissenters, has historically been a coveted position in Maharashtra's political framework.

Amid the tussle within the Mahayuti alliance, Ajit Pawar and his faction of the Nationalist Congress Party (NCP) emerged as pivotal players. With 41 seats, Pawar's faction wielded significant bargaining power, ensuring his continued control over the Finance portfolio. Known for his adept fiscal management, Pawar's alignment with Fadnavis further solidified the BJP's grip on the coalition.

Meanwhile, the Congress party's response to its defeat was to raise suspicions about the credibility of Electronic Voting Machines (EVMs). Allegations of tampering and irregularities have been a recurring theme in Indian electoral discourse, but the Supreme Court has dismissed such claims



due to a lack of evidence. Notably, allegations of voter suppression through police intervention in Ûttar Pradesh's Kundarki constituency, where BJP's Ramveer Singh won despite a Muslim-majority electorate, added fuel to the debate. These claims require thorough investigation by the Election Commission of India (ECI) to maintain electoral integrity and public trust.

In Maharashtra, Economist and commentator Parakala Prabhakar raised concerns about unusually high voter turnout in certain constituencies during late evening hours, suggesting potential irregularities. The Chief Electoral Officer of Maharashtra, S Chockalingam, clarified that voters waiting in queues after 6 pm constituted only 1 percent of the total turnout and attributed the late-night activity to the logistics of securing EVMs. Nonetheless, such allegations underscore the need for transparency and robust mechanisms to address public doubts

The political culture of Maharashtra, distinct from that of Uttar Pradesh, is marked by a more nuanced and democratic ethos. This differentiation was evident in constituencies like Mumbai City, where Aditya Thackeray of the Opposition secured a predictable victory, albeit with a reduced margin. Such outcomes reaffirm the resilience of Maharashtra's diverse political spectrum despite the BJP's overarching dominance.

In conclusion, the formation of the BJP-led Mahayuti government in Maharashtra highlights the multifaceted dimensions of coalition politics, electoral strategy, and governance. While the BJP's ability to consolidate power through decisive leadership and grassroots mobilization remains evident, the internal dynamics within the alliance reflect the inherent challenges of managing competing ambitions. As the government takes shape under Fadnavis's leadership, the focus will undoubtedly shift to addressing pressing developmental priorities and maintaining the delicate balance of coalition governance in one of India's most politically significant states. How the untiring, dangerous work for human rights has given life to support for Palestine in the Russia-Ukraine war?

s it antisemitic to criticise Zionism? This was the motion up for debate at the Munk Debate, held in honour of industrialist and free speech advocate Peter Munk. Journalist Douglas Murray supported the motion at the debate in Toronto on June 17 while news anchor-writer Mehdi Hasan opposed it. The motion was resolved with the conclusion that anti-Zionism is indeed antisemitism.

India has no history of antisemitism. So why have meetings about Palestine been banned and demonstrations by students protesting against the genocide being committed in Gaza been stopped?

The unwritten reason is that for a Hindutva government, the Palestinian cause is identified with Islam, the religion of a majority of the Palestinians.

But debates about religion eclipse the central fact that the real issue is land: Israel's illegal occupation of Palestinian terri-

occupation This "founded on brute force, repression and fear, collaboration and treachery, beatings and torture chambers, and daily intimidation, humiliation and manipulapolitical writes scientist-activist Norman Finkelstein in his 2018 book, Gaza: An Inquest into its Mar-

It is for this reason that India, in the first years after independence from British colonialism, forbade citizens from visiting Israel and South Africa as a gesture of solidarity with the people of Palestine and South Africa fighting against apartheid.

It is also the reason why many have refused to condemn the militant group Hamas's attack on Israel on October 7 last year that killed at least 1,200 people. This is despite the fact that they neither support Hamas's ideology nor do they condone the attack on civilians.

As scholar Edward Said wrote in Covering Islam, the Western media and experts have been guilty of "exaggerated stereotyping and belligerent hostility" towards Muslims in general and Arabs in partic-

Scholar Jack G Shaheen's analysis of 1,000 Hollywood movies similarly found "cinema's systematic, pervasive and unapologetic degradation men, women and children. In his 2009 book Reel Bad Arabs: How Hollywood Vilifies a People. Shaheen wrote that Arabs have been depicted as "brute ing to genocide in a 2009

murderers, sleazy rapists, religious fanatics, oil rich dimwits

This outlook is evident in the refusal of Western countries and the English media to use the term "genocide" to refer to the mass violation of human rights in Gaza. Increasingly, the human rights discourse has been used by the West to justify the Israeli occupation and freedom of speech has been weaponised to vilify Arabs.

Anyone who has seen the bombing of hospitals, the testimonies of doctors who have worked in hospitals there, the images of children buried under rubble and the relentless bombing of infrastructure would be hard put to deny that Israel is not committing war crimes that amount to genocide.

It is the human rights community that has played a vital role in documenting these crimes against humanity and even if many of these reports lie buried, they are a record of Israel's violations.

More recently, Amnesty International documented how Israeli forces have carried out acts prohibited under the Genocide Convention, with the speintent to destroy Palestinians in Gaza.

"Israeli forces have caused unprecedented destruction, at a level and speed not seen in any other conflict in the 21st century, leveling entire cities and destroying critical infrastructure, agricultural land and cultural and religious sites. rendering large swathes of Gaza uninhabitable," says the report released on December

There is no telling what the impact of the Amnesty International report will be. There will mine its influence.

Long before Hamas's attack on October 7, Israel had been condemned for crimes amount-

United Nations Fact Finding report by Richard Goldstone, former judge of the Constitutional and abusers of women". Court of South Africa and a Jew from a family that supported Zionism.

> The United Nations appointed the committee after the three-week long "Operation Cast Lead", as Israel called it, during which 1,400 Palestinians were killed between December 2008 and January 2009.

Goldstone's report found that the operation was anchored in a military doctrine aimed at disproportionate destruction and disruption in the lives of as many people "as a legitimate means to achieve military and political goals". The goal was to clear: "dire consequences for the non-combatants in Gaza". The report added that this policy was rooted in the humiliation and dehumanisation of the Palestinian population.

The report also commended the resilience and dignity of the residents of Gaza and recommended that the Security Council "refer the situation in Gaza to the Prosecutor of the International Criminal Court".

Israel's reaction was predictable, dismissing the report and condemning Goldstone, who was accused of being an antisemite and a traitor to the Jewish people. The vilification and defamation of Goldstone even led to the US House of Representatives voting 344 to 36 in condemning the report as 'irremediably biased and unworthy'

Finkelstein wrote that Goldstone's report was significant in heralding the dawn of the new era in which the "human rights dimension of the Israel-Palestine conflict moved centre stage - and even temporarily - displacing the fatuous 'peace The report also coin cided with a vicious campaign in Israel and the United States to discredit human rights organisations.

Under the mounting pressure

Goldstone recanted. But he did not recant from the main charge that Israel deliberately deployed "disproportionate and indiscriminate force in order to punish, humiliate and terrorise a civilian population". How could he when Israeli soldiers and writers had boasted that the Israeli Defense Forces had unleashed "insane" amounts of firepower.

An indiscriminate and disproportionate attack on civilian areas is itself a war crime. Two decades since Goldstone's report, human rights activists and organisations have continued their work of documenting Israel's war crimes, providing activists, students and journalists with material evidence with which to expose Israel's genocidal acts

It is also the human rights discourse that gives space to students to protest on campuses and the right to free speech to journalists such as Hasan, comedian Mehdi Bassem Youseff or intellectual-activist Finkelstein to publish his books on Israel's war crimes. Youseff's interview with English broadcaster Piers Morgan, in which the comedian highlighted the racism of the Western media, got millions of viewers from around the world.

When we listen to debates, read books on genocide and war crimes or take part in protests on political issues, it is the efforts of human rights activists and organisations that keep us informed of events on the ground, often at risk to their own lives.

kraine has passed the thousandth day of fullscale war. The country has managed to stay alive in the largest conflict since World War II, despite Russia's significant advantage in human and material resources, and the unreliable military assistance of Ukraine's Western allies.

Even after 1,000 days of conflict, uncertainty continues to define the Ukraine-Russia war. Following the failure of his initial blitzkrieg strategy, President Putin has shifted to a strategy of prolonged conflict, banking on the West's wavering resolve to support Ukraine "as long as it takes.". According to former Ukrainian Foreign Minister Dmytro Kuleba, the biggest problem Ukraine has faced is the "dominance of the concept of [avoiding] escalation" in the decision-making processes of Kyiv's Western partners. This cautious approach has led to delays in the supply of Western weapons and significant restrictions on the use of these weapons, significantly worsening the Ukrainian army's position on the battlefield.

The failure of Biden's containment strategy

The containment strategy chosen by President Biden has failed to weaken the Russian economy and isolate Moscow enough to force Putin to abandon this war. Moreover, Russia has been able to rebuild its economy and its military-industrial complex, still receiving Western components for weapons production via intermediary third countries.

President Biden may have avoided the direct clash between the North Atlantic Treaty Organization (NATO) and Russia, but this has not removed the threat to Ukraine's neighbours. Russian drones and missile wreckage are regularly found in Romania, Moldova, and Poland, but NATO has not yet dared to shoot down Russian air targets even over the territory of its member states. This indicates the West's inability to respond appropriately to security challenges and has only deepened relations between Russia, Iran, North Korea, and China. This was confirmed by the participation of North Korean troops in

The war is causing heavy civilian casualties and significant damage to Ukraine's economy and energy sector. It is paradoxical that recently the world has been increasingly hearing about "war fatigue", not from Ukrainians exhausted by the war, but from countries that have not been directly affected by the war.

This general "fatigue" has resulted in the international community's willingness to sacrifice parts of Ukraine's territories to appease Putin. "Peace in exchange for territory" has become a deceptive strategy to end the Russia-Ukraine conflict—a process actively promoted on international platforms and in the global information space. In fact, almost three years into a fullscale war, Ukraine has once again returned to the issue of peace through concessions, as it did after the occupation of Crimea and Donbas in 2014.

Trump's quick end to the war Donald Trump's victory significantly raises the prospects of a freeze in the Russia-Ukraine war. During his election campaign, he repeatedly said that he could end the Russia-Ukraine war in 24 hours. However, for Ukraine, the critical question remains the terms on which such a truce would be established. Trump's comments raise concern in Kyiv as he has threatened to cut off financial support and the supply of weapons to Ukraine as a way to bring both parties to the negotiating table.

While the Biden administration stated that only Ukraine should decide where, when, and how to start negotiations, Trump does not hide the fact that he will initiate the negotiation process. The biggest risk for Ukraine in these circumstances is the newly elected American president's desire to broker a 'quick deal'. Hasty agreements could result not only in significant concessions for Ukraine but also a fragile ceasefire that could quickly escalate into a new clash.

Donald Trump has not yet unveiled his peace plan, but his team's ideas point to the possibility of freezing the war, postponing Ukraine's accession to NATO for at least 20 years and creating a demilitarised zone along the front line, all while excluding the involvement of American financial and human resources in the peacekeeping process. The



Trump administration's desire to transfer responsibility for the situation in Ukraine onto Europeans only strengthens Moscow's confidence that the situation is developing most favourably.

Recently, Moscow has been escalating significantly and is trying to seize as much Ukrainian territory as possible, driving Ukrainian troops out of Russia's Kursk region before the United States (US) inaugurates its new president. In response to the Ukrainian army's permission to use Western long-range weapons to strike into Russian territory, the Kremlin has approved an updated nuclear doctrine. One of the conditions for the use of nuclear weapons is if ballistic missiles are launched against Russia.

Raising the stakes in the war and Putin's calculations

A high-stakes game requires strong positions from all parties. Russia is trying to gain a dominant negotiating position by intensifying missile and drone attacks against infrastructure, energy facilities, and civilians throughout Ukraine. The recent shelling of Ukrainian cities has not stopped day or night. Kyiv alone has suffered 10 combined aerial assaults in 2024, with Russia deploying 1,250 aerial weapons. Putin's strategic calculation is

not to reach agreements on end-

ing the war and legalising 20 percent of occupied Ukrainian territory; rather, he seeks to gain control over all of Ukraine. The Russian president has repeatedly stated that Moscow is ready to negotiate with Ukraine, but based on emerging "realities" (meaning that Russia retains territorial gains) and the agreements reached in Istanbul. On 15 April 2022, representatives of Ukraine to certain conditions for ending the war, which required Kyiv to agree to neutrality, significantly limit the size of its army (number of troops, aircraft, weapons and equipment), and enact several bans on joint exercises with other countries, as well as bans on the admission of foreign troops and weapons into its territory. As for Russia's commitments, Moscow promised not to attack Ukraine again and agreed to comprehensive security guarantees with the US, Britain, France, and China. Given the complete failure of the Budapest Memorandum, which did not protect Ukraine from military aggression by one of the signatories, this agreement looks like an attempt to limit Ukraine's sovereignty in exchange for dubious security guarantees.

Putin may agree to negotiate with the new American president to break his diplomatic isolation from the West. The incentives that Trump will give him to end the war remain to be seen. Moreover, whether Donald Trump is ready to respond to all of Vladimir Putin's terms, which would automatically mean the surrender of Ukraine's interests and a weakening of the US position, remains uncertain.

There are doubts about Trump taking into account all the risks and obstacles when he prematurely claimed to resolve the Russian-Ukrainian conflict. The ability to pull off a "big deal" in international relations using business templates for negotiations did not yield significant results with the Democratic People's Republic of Korea (DPRK), Iran, and China during his last presidential term. It is quite possible that it might not work with Russia either.

Ukraine: A more flexible position and the search for approaches in the Trump era

In this situation, Ukraine can hardly hope to liberate the occupied territories and return to 1991 borders. While the Ukrainian government officially emphasises that it will not make any territorial concessions, President Zelenskyy said in a recent speech to parliament that "Ukraine may

have to outlast someone in Moscow to achieve all its goals". This refers to the diplomatic settlement of territorial issues after a change in Russia's political leadership in the future. For now, Ukraine's priority should be to strengthen its negotiating position with the support of the $\check{U}\dot{S}$ and to obtain effective security guarantees. According to Volodymyr Zelenskyy, "This is a losing status for Ukraine at the entrance. In a weak position, there is nothing to do in these negotiations.

Taking into account the change in political leadership in the US, the Ukrainian government has to fulfil several important tasks.

First, matching Donald "transactional' ap-Trump's proach" to international relations, the Ukrainian government must convince Trump that continuing to support Kyiv is beneficial for the US. This is not only about Washington's geopolitical status, which could be damaged by making concessions to Putin and the threat of a renewed war; Ukraine can become an important contributor to the economic and security spheres of the West. In his Victory Plan, Volodymyr Zelenskyy proposed that Western companies can engage in the joint protection and extraction of important natural resources, including rare-earth metals. He also put forth the possibility of replacing certain US army contingents stationed in Europe with Ukrainian units after the war.

Second, Ukraine needs to develop an algorithm for long-term support by European countries, which will be forced to take greater responsibility for security in the European continent and increase financial spending on defence. Since the beginning of the full-scale invasion, the EU has been providing significant cal, economic, financial, and humanitarian assistance to Kyiv. Supporting Ukraine is in the interests of European countries because, according to EU High Representative Josep Borrell, "The ten-year security agreement, which the EU signed with Ukraine in June, remains valid. We supported and will continue to support Ukraine. And we will do it not because we are very friendly and very generous - but because it is in our interests! Ukraine's security is part of our security." Many European countries allocate a large portion of their military budgets to support Ukraine. Another important trend has been the participation of European companies in joint arms production, investment in the Jkrainian military sector, and the localisation of Western arms production plants in Ukraine.

Third, Ukraine must mobilise its internal resources. On 18 November, the President of Ukraine presented a 10-point conceptual document, the Internal Resilience Plan, which envisages consolidating efforts and resources for longterm struggle. This plan covers various areas, including maintaining unity, strengthening the army and defence industry, changing approaches at the front, protecting energy and improving the quality of human capital. In the context of a long-term war, such a strategy is necessary to adapt the state's governance and society to new realities. President Zelenskyy has stated

that the decisive moments of this war will take place next year. Trump's desire to end the war quickly, on one hand, accelerates the prospect of peace for Ukraine. On the other hand, it reduces the probability of a just and lasting peace, which Ukraine has long advocated for. In the current situation, Vladimir Putin sees favourable conditions for achieving his goals and has set terms that could lead not only to Ukraine's capitulation but also to the loss of its statehood. However, given Trump's unpredictability, forecasting an end to the war remains highly uncertain. (Courtesy: ORF)

Superpower retreats and their fallout

he Vietnam War was fought between the forces of the North (supported by the Soviet Union and China) and those of the South (supported by the United States of America). While it lasted twenty years (1955 to 1975) the direct involvement of the American troops lasted about a decade from 1965 onwards. The scars of 58,281 US fatalities and 303, 644 wounded had tired the spirits, emotions and morale of the Americans, and they secretly negotiated a pull-out plan under the garb of the Paris Peace Accords that the Americans knew would not hold up.

The Americans made many insincere and knowingly immoral promises to intervene on behalf of its ally, the Southern side, but when the push came to shove, it pushed the Southern side under the bus with non-inter-

vention or support. Later day US President Ronald Reagen was to coin the term 'Vietnam Syndrome' to suggest a reluctance to support an international military intervention, beyond a point. A similar reneging of support after almost a decade of direct military intervention was to face the Sovietpropped puppet government of Afghanistan, under Mohammad Najibullah.

Ultimately the political and popular will of the Soviets had waned as the human and financial cost of continuing the war in Afghanistan had waned.

A few years later, exactly as it had happened in Vietnam, the Afghan government was ousted in a bloody offensive and Najibullah's corpse was dragged behind a truck through the streets of Kabul. Eventually, the Soviets left him to his fate. It was the sort of end of a regime that was far less than ideal as the land of many 'Great Games' earlier i.e., Afghanistan, had seen similar consequences of bloodlust with the British troops leaving Afghanistan in Jan 1842 (only one survivor had managed to reach the British controlled township of Jalalabad). Sadly, even Najibullah's ouster wasn't to be the last of the 'abandoning' of a regime in Kabul.

In 2021, an exhausted and dispirited American force 'abandoned' its ally i.e., the Ashraf Ghani government, in Kabul on the pretext of a deal signed between the Taliban and the US in Doha.

Everyone knew that the deal would not hold up and lo behold the Taliban stormed into Kabul, soon after. The 'longest war in US history' with a two trillion financial cost, a no-win situation, and mounting pictures of 'US body bags' had yet again forced the Americans to push their ally under the bus. By blindsiding its purported ally, the Americans had unilaterally let down its ally after making promises to defend the same. Afghan Vice President Amrullah Saleh was left mocking the US on its pusillanimous stand, "when a superpower decided to become a mini power".

Russian forces edge closer to key eastern Ukraine city in 'intense' fighting 'Its capture would compromise Ukraine's defensive abilities and supply routes'

KYIV, Dec 12: Fighting around the key eastern Ukraine city of Pokrovsk is "extremely intense" after a monthslong Russian push, Ukraine's top military commander said, with analysts estimating Russian forces are now within just a few kilometres of the city.

Ukrainian troops repelled nearly 40 Russian attempts to storm defences around Pokrovsk over the previous 24 hours, the General Staff said in a battlefield report Thursday.

"Russian occupiers are throwing all available forces forward, attempting to break through the defences of our troops," Ukrainian army chief Gen. Oleksandr Syrskyi said in a Facebook post late Wednesday. His forces are outnumbered, he said.

Ukraine's stretched defences in Donetsk have been creaking since

South Korea's Yoon defends martial law as act of governance, vows to 'fight to the end'



SEOUL (SOUTH KOREA), Dec **12:** South Korean President Yoon Suk Yeol defended his martial law decree as an act of governance and denied rebellion charges, vowing Thursday to "fight to the end" in response to attempts to impeach him and intensifying investigations into last week's dramatic move.

The main opposition Democratic Party quickly slammed Yoon's speech as "an expression of extreme delusion" and "false propaganda." Later Thursday, it and other opposition parties submitted

a new impeachment motion against Yoon for a floor vote this

The opposition-controlled parliament also passed motions Thursday to impeach and suspend Yoon's police chief and justice minister over the imposition of martial law, escalating the pressure

on Yoon's embattled government. Yoon's short-lived December 3 martial law declaration has generated political chaos and large protests calling for his ouster. The decree brought hundreds of armed troops who attempted to encircle parliament and raid the election commission, though no major violence or injuries occurred. Martial law lasted only six hours as Yoon was forced to lift it after the National Assembly unanimously voted it down.

In a televised speech Thursday, Yoon, a conservative, said he enacted martial law as a warning to the liberal Democratic Party. He called the party "a monster" and "anti-state forces" that he said tried to use its legislative muscle to impeach top officials, undermined the government's budget bill for next year and sympathised with North

"I will fight to the end to prevent the forces and criminal groups that have been responsible for paralysing the country's government and disrupting the nation's constitutional order from threatening the future of the Republic of Korea," Yoon said. "The opposition is now doing a sword dance of chaos, claiming that the declaration of martial law constitutes to an

act of rebellion. But was it really?" Yoon said martial law was an act of governance that cannot be the subject of investigations and doesn't amount to rebellion. He said the deployment of nearly 300 soldiers to the National Assembly was designed to maintain order, not dissolve or paralyse it.

Kim Min-seok, head of a Democratic Party task force, dismissed Yoon's statement as "an expression of extreme delusion" and "a declaration of war against the people." Kim accused the president of attempting to incite pro-Yoon riots by far-right forces. He said the Democratic Party will focus on getting the motion impeaching Yoon passed on Saturday.

It's unclear how Yoon's comments will affect his fate. Opposition parties hold 192 seats combined, eight votes short of a two-thirds majority of the 300 members of the National Assembly. The earlier attempt to impeach Yoon failed with most lawmakers from Yoon's governing People Power Party boycotting the vote. Yoon's speech was expected to

deepen a divide inside the PPP. When party chair Han Dong-hun, a critic of Yoon, called Yoon's statement "a confession of rebellion" during a party meeting, Yoon loyalists angrily jeered and called on Han to stop speaking. Han has urged party members to vote in favour of Yoon's impeachment.

Opposition parties and even some PPP members say the martial law decree was unconstitutional. South Korean law allows the president to declare martial law during wartime or similar emergencies, and they said such a situation did not exist.

They argue that deploying troops to seal the National Assembly to suspend its political activities amounted to rebellion because the constitution doesn't give a president such rights in any situa-

The country's law enforcement authorities are investigating whether Yoon and others involved in imposing martial law committed rebellion, abuse of power and other crimes. A conviction for rebellion carries a maximum penalty of

The National Assembly on Thursday passed a bill that could introduce an independent counsel to investigate Yoon on rebellion charges without his approval. A bill it endorsed earlier this week on appointing an independent counsel requires Yoon's approval. The Justice Ministry on Monday placed an overseas travel ban on Yoon.

South Korean law gives a president immunity from prosecution while in office, except for allegations of rebellion or treason. This means that Yoon can be questioned and detained by investigative agencies over his martial law decree, but many observers doubt that authorities will forcefully detain him because of the potential for clashes with his presidential security service.

On Wednesday, Yoon's presidential security service didn't allow police to search the presidential office.

Yoon's statement was seen as an about-face. Last Saturday, he apologised over declaring martial law and said he wouldn't avoid responsibility for it. He said he would leave it to his party to chart a course through the political turmoil, "including matters related to my term in office.

On Wednesday, Yoon's former defence minister, Kim Yong Hyun, was arrested on allegations of playing a key role in a rebellion and committing abuse of power. The national police chief, Cho Ji Ho, and the head of Seoul's metropolitan police have been detained while their actions of sending police forces to the National Assembly are investigated as a criminal matter.

The Toshakhana case involves allegations of corruption against Khan and Bibi, specifically regarding the sale of gifts from foreign dignitaries.

They were arrested in the said case on July 13 — the same day they were acquitted in the iddat case. However, the Islamabad High Court approved her post-arrest bail plea in the case in October and she was released after spending months behind bars.

Separately, the IHC dismissed an FIA plea to revoke her bail after she appeared in court for the hearing of the Toshakhana 2.0 case, also called the iewellery set case.

Foreign powers should not take advantage of fissures in Syrian society: Singapore



SINGAPORE, Dec 12: Singapore's foreign ministry has said international powers should not take advantage of the fissures in Syrian society to pursue their own strategic objectives. "All parties must ensure the safety and well-being of Syrian civilians who have already suffered so much," the ministry said in a statement on Wednesday, adding that Singapore is closely monitoring developments in Syria.

The complex situation in Syria can only be resolved definitively through an inclusive, Syrian-led political process as affirmed in the UN Security Council Resolution 2254. Any meaningful political solution must respect the sovereignty, territorial integrity, and independence of Syria, it said.

Since the outbreak of the civil war in 2011, more than 3,00,000 Syrians have been killed and more than 13 million have been displaced with many seeking refuge in other countries. "We hope they can return safely to their homes when peace is restored," the ministry said.

Given the current volatile situation, Singaporeans should avoid travelling to or remaining in Syria, the ministry advised, adding that Singapore has no diplomatic representation in Syria, which constrains its ability to extend consular assistance in an emergency. (AP)

HT Correspondent KOKRAJHAR, Dec 12: A twoday 'Winter Session' of the Bodoland Territorial Council Legislative Assembly (BTCLA), 2024 began on Thursday at the BTC Legislative Assembly Hall in Kokrajhar.

The session was chaired by Katiram Boro, the speaker of the Bodoland Territorial Council Legislative Assembly.

The session began with a question hour where the opposition leader raised concerns over infrastructure development in the BTC, particularly during the financial year 2024-25 as well as implementation of the BTR Peace Accord 2020, ex-gratia payments for Bodoland Martyrs' families, and concerns related to land revenue, health, education, and forest management.

The session is expected to address key developmental and policy matters aimed at strengthening governance in the Bodoland Territorial Region (BTR) on the second day of the session.

The CEM further stated that the two bills have been introduced in the house, and hopeful that the bills would be passed on Friday after being debated in the session.

CEM Boro said that the government of BTR is rendering relentless services towards the welfare and development of the peoples across the region, and marked the better governance in the council. He has stressed that the government is committed on the focus strongly on fulfilling the aspirations of the people and ensuring the peace and progress of Bodoland region.

Opposition raises concerns over simultaneous polls BJP, allies say burden on exchequer will be lessened

NEW DELHI, Dec 12: Opposition parties on Thursday raised concerns over bills cleared by the government for holding simultaneous elections and said larger consultations are required while ruling NDA leaders asserted the burden on the exchequer will be lessened.

The Union Cabinet approved bills to implement 'One Nation, One Election' and sources said the draft legislations are likely to be introduced in Parliament in the ongoing Winter session.

Opposition MPs questioned if the country is logistically ready to hold simultaneous elections, pointing out that recent polls in Maharashtra and Jharkhand could not be held together with that in Haryana and Jammu and Kashmir.

Minister of State for Agriculture Bhagirath Chaudhary welcomed the move and said, "One nation, one election will be good for the nation. It will help in saving people's money.

He also dismissed the reservations expressed by opposition, and said, "they are in a habit to oppose everything.

BJP's ally Lok Janshakti Party (RV) MP Shambhavi Choudhary also welcomed the move.

"This is an ambitious bill, LJP has supported it... Every six month there is election in some state and leaders focus on that. Many times representatives are also not able to give time in Parliament, resources are wasted," she said.

"One Nation one election



in that direction, nothing like it. But what is the reality? Is the Election Commission ready for it? Do we have enough forces, infrastructure?" Shiv Sena (UBT) MP Anil Desai said.

"J&K, and Haryana elections could have been held together with Maharashtra but it was not done. Even the Jharkhand election was held in two phases... If government has some solution it can be discussed, but in present situation it does not appear they can do it," Desai said.

Congress Lok Sabha member K Suresh said his party has already made its stand clear, and it is opposed to simultaneous polls.

"Our party has already cleared our stand from the beginning, our stand has not changed. We are opposing it. Entire opposition is opposing it," he said.

CPI(M) Rajya Sabha member sounds good, if the nation can go John Brittas said it is against the

federal spirit of the country.

"One nation, one election, is part of their slogan 'one leader, one country, one ideology, one language...' It's against the federal spirit of the country," he said.

"If they are keen on reform in the electoral scene, they should understand what are the issues plaguing the electoral system. If they were so keen about one election, why did they segregate the election of Maharashtra and Haryana, they could not even hold four elections together," Brittas said.

DMK leader Tiruchi Siva also said his party opposes the bill. "Let them bring it, my party is

totally against it, we have too many questions to raise, and they have to be replied in a comprehensive manner," he said.

Siva questioned what would happen if a government comes into

"Suppose if Lok Sabha gets dis-

solved earlier, would they dissolve all state assemblies and hold elec-

tions?" he questioned. BJD Rajya Sabha member Sasmit Patra said greater consultations need to be held.

"Greater consultation has to be done. What happens when there is a lack of majority, hung assembly or Parliament, or a government loses confidence mid-way... " he questioned.

Aam Aadmi Party (AAP) MP Sanjay Singh said, "There's only one slogan of the Modi government that is 'one nation, one

"He just wants a friend to sell India's wealth and he is working for him. If there is one nation, one election, then what will happen when the government midway comes in minority. Won't there be any mid term election?" Singh

Moving ahead with its 'one nation, one election' plan, the government in September accepted the recommendations of the high-level committee for holding simultaneous polls for the Lok Sabha, state assemblies and local bodies in a phased manner. Citing recommendations of the high-level committee, sources had said one of the proposed bills would seek to amend Article 82A by adding subclause (1) relating to the appointed date. It will also seek to insert subclause (2) to Article 82A relating to the end of terms of the Lok Sabha and state legislative assemblies to-

Congress does not believe in democratic systems, trying to bring in 'anarchy', says Nadda

NEW DELHI, Dec 12: BJP president JP Nadda on Thursday accused the Congress of trying to bring in "anarchy", as he condemned the charges levelled against Rajya Sabha Chairman Jagdeep Dhankhar by opposition

Speaking to reporters in Parliament complex, Nadda, who is also the leader of the House in the Rajya Sabha, accused the Leader of Opposition Mallikarjun Kharge and the Congress of not cooperating in functioning of the House.

Condemning the press conference held by opposition leaders on Thursday where they accused the Chairman of being "partisan", Nadda said, "Kharge ji is a senior leader, he should know the ruling of the Chairman is final and unquestionable. Levelling such allegations outside the House is condemnable. We condemn it, and it is unfortunate"

"Kharge ji has been given enough opportunities to speak in the House, it is on-record that he refused... He was also invited to come to the Chairman's chamber. but he refused to go," Nadda said.

"It is clear the Congress does not want to cooperate in the House. They do not believe in democratic and Parliamentary systems, and they are trying to bring in anarchy," he alleged. Nadda charged that the Congress was trying to create a situation where working in Parliament becomes difficult. (PTI)

opposition MPs on Thursday staged a protest inside Parliament complex carrying placards of different Hindi letters that jointly read 'desh bikne nahin denge' and raised slogans to reiterate their demand of a joint parliamentary probe into the Adani issue.

This is the latest in a series of unusual daily demonstrations led by the Congress over the Adani issue. Congress general secretary Priyanka Gandhi Vadra, MPs from the Congress, DMK, and the Left parties, among others, stood in front of the Makar Dwar steps and in front of Samvidhan Sadan with most of them carrying the placards that together read 'desh bikne nahin denge (will not let the country be sold off)'.

They raised slogans against the alleged collusion between Modi and Adani and demanded a joint parliamentary committee (JPC) probe into the matter.

On Wednesday, several opposi-

tion MPs greeted their BJP counterparts in Parliament premises with a tricolour in the form of a card in one hand and a red rose in the other, as they urged the ruling party to ensure that the House functions and all issues, including the Adani matter, are discussed.

Leader of Opposition in the Lok Sabha Rahul Gandhi also offered the tricolour in the form of a card to Defence Minister Rajnath Singh when the latter was entering the main Parliament building.

On Tuesday, MPs carried dark blue 'iholas' with caricatures of Prime Minister Narendra Modi and industrialist Gautam Adani printed on one side and "Modi-Adani Bhai-Bhai" written on the obverse.

On Monday, leaders of some INDIA bloc parties had protested in Parliament complex over the Adani row, with Rahul Gandhi conducting a mock "interview" over the issue with Congress members wearing masks of Modi and Adani. (PTI)

Jharkhand assembly passes ₹ 11,697cr supplementary budget, House adjourned sine die

RANCHI, Dec 12: The Jharkhand Assembly on Thursday passed the second supplementary budget of ₹ 11,697.45 crore for the 2024-25 fiscal. After this, the four-day session of the assembly was adjourned sine die by Speaker Ra-

bindra Nath Mahato Finance Minister Radhakrishna Kishore tabled the second supplementary budget, allocating a maximum outlay of ₹ 6,390.55 crore to the women, child development and social

security department to boost the government's flagship scheme Maiyan Samman Yojana. Under this scheme, the state government initially provided ₹ 1,000 per month to women between the age group of 18 and 50 years. The amount has been increased to ₹ 2,500 per month from December. Taking part in the debate on supplementary budget, BJP's Satyandra Nath Tiwary said that his party appreciated the initiative but is not happy with the way certain criteria were brought in post-election.

During the election, the ruling party promised to give the benefit of Maiyan Samman to all women, but now it brought certain qualifying criteria. I don't think even one per cent of the women will be able to qualify the criteria, he said.

The MNF's strength in the CADC before Rasik Mohan's removal was 14, while the ZPM had five members and the BJP one, an official said

With eight MNF members joining the BJP and five others joining the ZPM, the saffron party now has nine members in the council, while

3 cadres of militant outfit Prepak (Pro) arrested in Manipur

IMPHAL, Dec 12: Three cadres of the banned militant outfit People's Revolutionary Party of Kangleipak (Prepak-Pro) were arrested in Manipur's Thoubal district, police said

on Thursday. The arrested members of the outlawed group were involved in extortion, a police statement said.

'State and central governments have been putting all efforts to bring a permanent solution'


IMPHAL, Dec 12: Manipur Chief Minister N. Biren Singh on Thursday said the Centre and the state governments are making all efforts to bring a permanent solution to the ongoing crisis in the state, but suggested that it could take time due to the fragile nature of the

Speaking at a programme to commemorate Nupi Lan, Singh said, "The state and central governments have been putting all efforts to bring a permanent solution. However, bringing a solution would take time as the situation had become chronic and fragile."

Regarding the re-imposition of Armed Forces Special Powers Act (AFSPA) in six police station areas, Biren said, "The state government had requested the Centre to review and withdraw AFSPA from the said police stations" and sought cooperation and support from the public in the government's effort to restore peace and tranquility in the state.

The CM said Nupi Lal Numit is observed annually to remember the role played by Manipuri women in 1904 and 1939, revolting against the injustice of British colonialism.

Singh said apart from the contribution of women during the two historical events, "we should also remember the bravery and courage shown by Manipuri women in other instances, including ousting the Burmese during the Seven Year Devastation period (1819-



He also mentioned that the bravery and courage of the past could also be seen among present-day women of the state, as they had been leading from the forefront in every issue pertaining to the safety of the people of the

Singh said, "Manipuri women have contributed in multiple sectors, including social, economic, art and culture, hospitality, and games and sports, among others, apart from their household activities" and that the "cultural performances shown by our women in different national and international events have showcased the uniqueness of our culture across the world.'

He informed that "the state government, acknowledging the hard work and commitment of women, had introduced certain women welfare schemes, including Ima Nongthangleima Yaipha Tengbang Scheme, providing financial assistance of ₹ 500 per month to unemployed women who are above the age of 40 years.'

Singh also spoke on the initiatives of the central government under Prime Minister Narendra Modi in passing the Women's Reservation Bill 2023 in Parliament.

He also mentioned other initiatives taken up by the state government for students, including the Chief Minister's Scholarship for Civil Service Coaching, Chief Minister's Coaching Scheme for Entrance Examination to Professional Courses for NEET and JEE, and the establishment of DIET in every district, among

Later, replying to media queries on the treatment of Myanmar refugees, Singh said, "Those who are criticising should come here and see the ground realities. There are no differences. Refugees are being treated under the guidelines of the United Nations and the supervision of the government of India and the government of Manipur. Equal treatment is being given.'

Earlier, Singh, along with the legislators, paid floral tributes to the statue of Nupi Lan at Nupi Lan Memorial Complex in Imphal.

Forest, Environment and Climate Change Minister Th Biswajit Singh, who was also present on the occasion, said Nupi Lal is observed every year to remember the courage and sacrifice of women freedom fighters and to pay tribute to their contributions, adding that the observation is a proud moment for every Manipuri. The participation of animal husbandry staff as accredited representatives under A-HELP will undoubtedly enhance the state's animal health infrastructure," he noted. Saha explained that under this scheme, animal husbandry workers associated with the Tripura Rural Livelihood Mission (TRLM) will be selected as accredited A-HELP repre-

These workers will receive 16 days of specialised training, supported by the National Dairy Development Board, to equip them for their roles.

"Following this training, the administrative infrastructure of the Animal Husbandry Department will extend its services to rural-level animal husbandry farmers through these trained workers. However, critical services such as artificial insemination and vaccination will be provided under the direct supervision of local veterinarians to ensure proper animal health care," he clarified.

Additionally, the A-HELP representatives will be tasked with registering livestock and poultry in villages, maintaining records of their births and deaths, and ensuring overall animal health management. During the event, ARDD minister Sudhangshu Das,

a sex racket involving minor girls. The alleged sex racket case was brought to light by the minor victims in August this year and a regular case was subsequently registered.

Police have arrested 9 people, out of which 3 are prime accused, in connection with alleged rape and sexual assault of minors. The sex scandal continued over a period of 4 years from 2019 to 2024 till the lodging of FIR in the said case.

The child panel, which took suo moto cognizance of the case, termed the fouryear operation of the racket and the reported sexual exploitation of minors as "alarming". The report alleged that prime accused

Chaya Dulom, a female attendant with the department of health and family welfare and her husband David Dulom, a surveyor with the water resources department, lured adolescent girls into the racket. Victims reportedly faced repeated sex-

ual exploitation, often multiple times a day, the report said. The Commission expressed concern

over the complicity of government employees in such heinous crime and recommended strict disciplinary actions, including termination of service. It also called for an investigation into

against officials involved in sex racket

the role of police constable Hainu Naiham, who allegedly coerced victims to cooperate with the accused instead of protecting them.

The Commission suggested that disciplinary authorities across departments take stringent measures against erring employees involved in heinous crimes to deter such activities in the future.

"The sex racket was going on since the vear 2019 under the guise of a restaurant cum bar at Itanagar. Chaya Dulom and her gang was continuously involved in enticing adolescent girls for work at the restaurant cum bar with ulterior motives of attracting customers and sexual exploitation of the victims. During the enquiry it was informed by the victims that they were subjected to rape and sexual exploitation several times even in a single day," the Commission said in its report.

The Commission observed that since the racket has been going on in the state capital over a prolonged period of 4 years there are compelling reasons for having many more victims as well as accused persons in the said case if thoroughly investigated.

"The fact that the number of victims in this case is more than the number of accused persons is in itself highly questionable and reflects the lacunas in the entire investigation process," it said.

In addition, there is a high probability of involvement of high-profile persons who can manipulate the course of the investigation, the Commission said and recommended for reconstitution of SIT for a thorough investigation into the case in order to bring out the extent of the offence and actual picture of the case, APSCPCR Chairperson Ratan Anya said in the report.

The Commission also recommended for timely disbursement of victim compensation to all the victims as per the provisions of the Arunachal Pradesh Victim Compensation Scheme, 2011.

During the investigation by the Commission. Anya said, around 9 victims were found to be major, over 18 years of age, and their case details have been forwarded to the Arunachal Pradesh State Commission for Women (APSCW) for further intervention. (PTI)

Churning in Hindi cinema forcing filmmakers to think differently: Manoj Bajpayee

NEW DELHI, Dec 12: Hindi cinema is going through a lull phase but this churning will, hopefully, lead to something better as creative people always find a way, says actor Manoj

In a year where the box office once again appears to be dominated by blockbusters from the South like "Kalki 2898 AD" and "Pushpa 2: The Rule", the successful business of "Stree 2", "Bhool Bhulaiyaa 3", and "Singham Again" has given some hope to Bollywood.

Asked whether Hindi cinema was in "trouble", Bajpayee said that isn't the case.

"... But it is definitely forcing filmmakers to think differently. And there is nothing wrong with it. I think it is a churning, it's a lull period. I'm hopeful that it will go back to its natural self very soon

self very soon.

"I don't see it as a problem because creative people always find a way. It is a jolt, a shock. And, now they are thinking hard and trying to come together to find a solution to it. And they will find a solution," the actor told PTI in an interview during a visit to the news agency's headquarters.

Bajpayee said horror comedy
"Stree 2", which earned over Rs

800 crore at the box office, did "remarkable" business.

"That means people are somewhere willing to go to theatres but they want something else. And that 'something else', a filmmaker has to really innovate and think hard about... My films these days come onto OTT and they have an even bigger audience.

"Last year, my film 'Sirf Ek Bandaa Kaafi Hai' amassed historical views on OTT. If we convert it into rupees (box office collection), then it would be called an all-time blockbuster. The same goes for 'Gul-

The National Award winner

said mass audience always wants a hero and when theatres shut down during the pandemic, people stopped getting that from Hindi cinema but in south, single screens have thrived. "We always search for a hero in our films. In the changing times, people stopped getting their hero because there were many multiplexes. The south never let the multiplexes flourish and maintained unity. They knew that their cinema would survive only through mass audiences.

"But we (Hindi industry) changed because while multi-

plexes were coming up, an aspirational India was also emerging. They wanted their hero. The kind of heroes they got, who ruled for 20-30 years... During COVID, there was a shift as mass audiences were going to theatres in big numbers but the multiplex audience chose to sit at home and enjoy OTT."

Rising ticket costs

could also be a factor in people choosing to stay at home and enjoy movies on the OTT, according to Bajpayee.

Citing the example of
"Pushpa 2" star Allu Arjun, he
said the Telugu actor is giving

The Athlete Biological Passport (ABP) is an advanced anti-doping tool that monitors an athlete's biological markers over time. By analysing variations in parameters such as blood and steroid profiles, the ABP helps to ensure fair play in sports and protect clean athletes.

NEW DELHI, Dec 12: The National Dope Testing Laboratory (NDTL) here NDTL, New Delhi on 6th December 2024, as an Athlete Passport Management Unit (APMU) to manage the Athlete Biological Passport (ABP)," a PIB release said. "This milestone marks a significant achievement for India in advancing its anti-doping initiatives. Now, India is part of a group of the 17 APMUs approved by WADA worldwide.

The objective of having Athlete Biological Passport (ABP) is to monitor selected variables (biomarkers of doping) over time that indirectly reveal the effect of doping, as opposed to the traditional direct detection of doping by analytical doping controls.

According to the WADA website, ABP is currently composed of two modules -haematological and steroidal. Haematological module considers a panel of biomarkers of blood doping that are measured in athletes blood sample. The steroidal module considers a panel of biomarkers of steroid doping measured in athletes urine sample.

It's a new approach that monitors an athlete's blood profile over time and can

Rohit had only one fifty in his last 10 innings heading into the Pink-ball Test last week when Shastri, interestingly, advised against changing the opening combination of Yashasvi Jaiswal and KL Rahul after their success in the position while backing the captain to bat in the

Shastri said he has no doubt the winner of the third Test, starting here on Saturday, could go on to claim the series.

"I feel whichever team wins this Test match will win the series. I have absolutely no doubt in my mind. So it is very, very important that India get the balance right, because Australia have got the confidence back," the former captain



The triumph of 2021 is considered one of the greatest in the history of Indian cricket and Shastri, while speaking at the first annual Usman Khawaja Foundation lunch at the Gabba, said the unity showed by the team, despite restrictions due to COVID-19, played a big part in the historic win.

"In COVID, the first Test match you start with five bowlers and the same five bowlers don't play the last Test. That says it all, it's like Australia playing without these five bowlers in the last Test of the series, it's a different ball game. Plus you didn't have quite a few batsmen as well. So it's a tribute to the players.

"You can only do so much as a coach from behind the scenes. At the end of it, it's the players who have to go out there and do their job and they were magnifi-

Four years ago, after getting bundled out for their lowest Test total of 36 in Adelaide, India made a magnificent comeback to win two of the remaining three games and emerge winners.
