GUWAHATI, Dec 29: Altogether 1.8 crore voters, including 89.54 lakh women, have been named in the final electoral roll of the 2025 Panchayat election in Assam, according to an official statement issued on Sunday.

The Final Electoral Rolls for the Panchayat Election 2025 have been published after taking into account the delimitation of Gaon and Anchalik panchayat and Zilla Parishad constituencies in 2024 across 27 districts, excluding areas under the Sixth Schedule and municipal bodies.

"After disposal of all claims and objections received from 27 districts, there are 1,80,14,913 electors. Among them, 90,60,640 are males, 89,53,865 are females and 408 are other gender voters," the official statement said.

These electors will vote for 397 Zilla Parishad constituencies, 181

# Two held with drugs worth ₹ 15 crore in Cachar

HT Bureau GUWAHATI, Dec 29: Assam Police has seized 50,000 Yaba tablets worth ₹ 15 crore and apprehended two persons at Ghoongur Bypass in Cachar district, said chief minister Himanta Biswa Sarma on Sunday.

The tablets were seized during a special operation where the police intercepted a vehicle from a neighbouring state.

"Narcotics worth ₹15cr seized. on credible inputs, Based @cacharpolice conducted a special operation at Ghoongur Bypass and intercepted a vehicle coming from a neighbouring state," Sarma wrote on micro-blogging site X. Upon searching the vehicle, 50,000 Yaba tablets which were kept in five

pockets were recovered. "Upon search, 50,000 YABA tablets concealed in 5 packets were recovered. Two have been apprehended and the vehicle has been seized," the Sarma added. Over this achievement, the chief minister also appreciated Assam Police.

NEW DELHI. Dec 29: Atleast seven illegal immigrants were deported from south Delhi, police said on Sunday.

Deputy Commissioner of Police (south) Ankit Chauhan said on Saturday a team apprehended seven nationals of Bangladesh, including five women, near the Arjangarh Metro Station in Fatehpur Beri area. He said raids were conducted in slums, labour camps, and unauthorised colonies, leading to the capture of the illegal immigrants.

The detained individuals were identified as Mohammad Umor Faruk (33), Riyaj Miyan (20) and five women, all hailing from Bangladesh, he added. During interrogation they revealed that they had illegally crossed the border and were residing (CONTD. ON PAGE-2)

# **BJP** accuses **AAP** of trying to register 'illegal voters' in Delhi

NEW DELHI, Dec 29: The BJP on Sunday accused the Arvind Kejriwal-led AAP of trying to register "illegal voters", fearing defeat in the Delhi Assembly polls.

The BJP's city unit chief Virendra Sachdeva said in a press conference that his party would not allow "fake votes" to be cast in Delhi.

"We have provided multiple pieces of evidence but Kejriwal is merely attempting to cover up his 'wrongdoings' by creating confusion among the people," he charged. Elections to the 70-member Delhi

Assembly are due in February

Earlier in the day, Kejriwal had claimed that the BJP was manipulating changes in electoral rolls of his New Delhi constituency by filing applications to delete more than 5,000 votes since mid-December.

Sachdeva charged that applications submitted after December 23, when updating electoral rolls was frozen, reflected Kejriwal's ongoing

"manipulation plan" in the 70 constituencies.

He also responded to AAP leader Sanjay Singh on his allegation that the BJP was trying to delete his wife's name from the electoral roll. Sachdeva claimed that the two women who applied to cancel Singh's wife's vote had family ties with him. He said the updation of electoral rolls was frozen on December 23, with the updated voters' list set to be released on January 6.

Despite this, applications for new voters have been submitted in every assembly constituency, he charged. In Narela alone, more than 2,000 people applied for new voter registrations on December 24. Similar applications were observed in various constituencies on December 25, 26 and 27, he added. "What is most surprising is that none of these applications belonged to 18-20-yearolds and most of the applicants were in the 30-48 age group. Who brought them (here) and what is

their background?" Sachdeva asked. The BJP has filed complaints with the Election Commission in this regard, he said. BJP leader Pravesh Verma, the

party's probable candidate from New Delhi, accused AAP and Kejriwal of creating "drama". He said Kejriwal's "Operation Lotus' charge was a reflection of his "desperate attempt to distract people from the (CONTD. ON PAGE-2)

NEW DELHI, Dec 29: Employee attrition in private sector banks has witnessed an increase to about 25 per cent and this high turnover rate poses significant operational risk, according to the latest Report on Trend and Progress of Banking in India 2023-24

Employee attrition rates are high across select private sector banks and small finance banks (SFBs), the report, which was released by the Reserve Bank of India (RBI) said. The total number of employees of private banks surpassed that of public sector banks (PSBs) during 2023-24, but their attrition has increased sharply over the last three years, with average attrition rate of around 25 per cent, it said.

# **2024: Big ticket investments** boosts TN govt's USD 1 tn dream

CHENNAI, Dec 29: Tamil Nadu made sincere efforts in 2024 to realise its USD 1 trillion economy dream by 2030 as the ruling DMK government secured some big ticket investments and rolled out sector-specific policies, among others. Measures regarding ease of doing business were also announced by the State government. The DMK government conducted its maiden Global Investors Meet (GIM) in 2024.

The year 2024 also witnessed the changing of hands at one of the city's iconic cement company, The India Cements Ltd. Billionaire Kumar Mangalam Birla promoted UltraTech Cement announced the acquisition of the decades old, city-headquartered company, promoted by noted industrialist N Srinivasan. The GIM in January fetched the government ₹ 6.64 lakh crore investment commitments by several companies that would generate 26 lakh new jobs in the state.

Some of the big ticket investments include ₹ 16,000 crore by Vietnam-based VinFast to establish a manufacturing facility in southern Tuticorin district that would generate about 20,000 new jobs, and the ₹ 9.000 crore investment commitment by auto-maker Tata Motors to manufacture sports utility vehicle, electric vehicles at Ranipet. It would generate about 5,000 jobs in the region.

### Foodgrain output set to scale new peak Indian economy to grow at 6.5-6.8% in FY25 on high in 2025 as farm sector eyes 4 pc growth consumption: Deloitte

The Agriculture Ministry's initial projections paint an optimistic picture, with kharif (summer) foodgrain production estimated at a record 164.7 million tonnes for the 2024-25 crop year ending June 2025.

Winter crop planting has maintained steady progress, with wheat sown across 29.31 million hectares as of mid-December 2024, while total rabi (winter) crops cover 55.88 million hectares.

"We had a good kharif crop because of normal rainfall," Agriculture Secretary Devesh Chaturvedi told PTI.

"Overall, the crop prospect for the whole year looks promising," he added, though cautioning against potential heat waves in February-March that could affect the winter wheat harvest.

The agricultural sector is projected to bounce back strongly, with growth projections of 3.5-4 per cent in 2024-25, up from 1.4 per cent in the previous fiscal year.

Agri-economist S Mahendra Dev attributes this improvement to "good monsoon and rise in rural demand".

This growth comes despite localised floods and droughts affecting crops in parts of Maharashtra, Uttar Pradesh, and Rajasthan. Climate change-induced weather anomalies have particularly impacted onion and tomato yields in certain regions.

However, the path ahead isn't without hurtheir long-term sustainability. dles. To address the persistent challenge of self-sufficiency in pulses and oilseeds, the government will roll out the National Mission on Edible Oils - Oilseeds (NMEO-Oilseeds)

import dependency through targeted interventions and increased support prices.

The horticulture sector has shown remarkable progress, with record production of fruits and vegetables. The success is attributed to improved farming practices and technology adoption under various government schemes.

The sector is witnessing increased technological adoption, with drones and AI-driven tools gaining traction. "These innovations offer immense potential to enhance productivity," said Ashish Dobhal, CEO of UPL Sustainable AgriSolutions.

The government's flagship PM-KISAN scheme continues to provide crucial support, having disbursed over ₹ 3.46 lakh crore to more than 11 crore farmers since its 2018 launch

Seven new agricultural schemes announced in September 2024, with a combined outlay of ₹ 13,966 crore, are set for full implementation in 2025. These initiatives span various aspects of agriculture, including digital transformation, crop science, livestock health, and natural resource management.

However, farmer unrest remains a concern, particularly in Punjab and Harvana, where demands for legal MSP guarantees and other reforms persist.

A parliamentary committee has suggested doubling the PM-KISAN support to ₹ 12,000 per beneficiary and implementing universal crop insurance for small farmers.

While farmer-producer organisations (FPOs) have expanded with 9,204 registrations, they continue to face challenges, including limited market access and weak managerial capacity, potentially affecting

"If he is so sure of voter manipulation, why hasn't he submitted concrete evidence to the Election Commission or the courts? His press conferences are merely a stage for sensationalism, not accountability," Verma added. AAP is eyeing a third consecutive term in Delhi while the BJP, which has been out of power since 1998, is looking to mount a comeback in the House. (PTI)

# PM Internship Scheme: 6.21 lakh applications received for 1.27 lakh opportunities

NEW DELHI, Dec 29: About 6.21 lakh applications have been received for 1.27 lakh opportunities under the Prime Minister's Internship Scheme and the selection process is continuing, the government said on Sunday. The scheme, announced in the 2024 Union

Budget, aims to provide internship opportunities to 1 crore youth in top-500 companies over five years. A pilot project of the scheme, started on October 3, aims to provide 1.25 lakh internship opportunities during 2024-25. In a release on Sunday, the corporate affairs ministry said approximately 6.21 lakh applications have been received against 1.27 lakh internship opportunities. "The selection process for internship is ongoing.

Partner companies have posted about 1.27

lakh internship opportunities on the intern-ship scheme portal. About 4.87 lakh individuals have completed their KYC and registered themselves on the portal, the release said. Under the scheme, interns will be provided a monthly financial assistance of ₹ 5,000 for 12 months and a one-time grant of ₹6,000. While mentioning about various initiatives taken this year, the ministry said the framework governing cost record and audit will be amended after considering stakeholders' comments and recommendations of the ministry-appointed committee.

From financial year 2023-24, the ministry has issued regular advisories to companies on adhering to the prescribed timelines for filing cost audit reports. (PTI)

The pilot sent out a distress signal shortly before the plane overshot the end of the runway and skidded across a buffer zone before hitting the wall, the officials said.

Senior Transport Ministry official Joo Jong-wan said workers have retrieved the flight data and cockpit voice recorders of the plane's black box, which will be examined by government experts investigating the cause of the crash and fire. He said it may take months for investigators to complete their probe. The runway at the Muan airport will be closed until January 1, the ministry said.

Thailand's prime minister, Paetongtarn Shinawatra, expressed deep condolences to the families of those affected by the accident in a post on social platform X. Paetongtarn said she ordered the Ministry of Foreign Affairs to provide assistance immediately.

Kerati Kijmanawat, the director of Airports of Thailand, confirmed in a statement that Jeju Air flight 7C 2216 departed from Suvarnabhumi Airport with no reports of abnormal conditions with the aircraft or on the runway. Jeju Air in a statement expressed its "deep apology" over the crash and said it will do its "utmost to manage the aftermath of the accident." (AP)



## Indian job market: **Future tense**

T ndia's jobs market deterioration and failure of the government in decent job creation have sharply pushed up the number of jobs and enterprises in the informal sector, the technical term for which is 'Unincorporated Sector.' The Annual Survey of 'Unincorporated Sector Enterprises (ASUSE) 2023-24' found an estimated 7.34 crore establishments with a growth rate of 12.84 percent having 12.06 crore workers with a rise of 10.01 percent. It can be called a robust growth compared to the COVID-19 disruption years, but is an indication of failure in reaching decent job creation targets. The survey covered unincorporated non-agricultural establishments belonging to three sectors - manufacturing, trade, and other services. These units were under proprietorship, partnership (excluding Limited Liability Partnerships), Self-Help Groups (SHG), co-operatives, societies, trusts etc. As the majority of jobs in such enterprises are not generally covered under social security, these are not considered as decent jobs. ASUSE 2023-24 was conducted during October 2023 to September 2024, which means it also covers the first six months of the current financial year 2024-25, the budget of which has a big flagship programme for decent job creation in India through three Employment Linked Incentive Schemes worth Rs10,000 crore, which is yet to take-off.

Nevertheless, ASUSE 2023-24 highlights the robust recovery after the disruption by COVID-19 crisis in 2020 and 2021, when such enterprises greatly suffered by lockdowns and containment measures that had stopped the economic wheel of the country. It should be noted that the first such full survey was conducted during the financial year 2021-22 from April 2021 to March 2022. The current survey is the third in its series. ASUSE 2023-24 has found 7.34 crore establishments out of which 2.02 crore were in manufacturing, 2.28 crore in trade, and 3.04 crore in other services sector. It estimated the Gross Value Added (GVA) growth in the unincorporated sector to be 16.52 per cent at current prices during the period from October 2023 to September 2024. Out of 12.06 crore estimated workers covered in survey year 2023-24 in the unincorporated sector, 5.61 crore were in rural areas and 6.45 crore in urban areas. ASUSE 2023-24 says that growth in the unincorporated sector has mainly been driven by the "other services" sector that recorded an establishment growth of 23.55%, employment growth of 17.86% and GVA growth of 26.17%

Percentage share of GVA in manufacturing was 21 percent, in trade was 35 percent and in other services 44 percent. The result of the current survey revealed that along with the total number of workers, the total number of hired workers also increased in this sector from 2.95 crore in ASUSE 2022-23 to 3.15 crore in ASUSE 2023-24. The data also revealed that the percentage of market establishment at an overall level increased marginally from 99.56 per cent in survey year 2022-23 to 99.66 per cent in 2023-24.





# Non-invasive radiotherapy proving highly Why does red wine sometimes effective in treatment of brain tumors cause headaches?

The occurrence of brain tumors in India is steadily rising. More and more cases of brain tumors are reported each year in our country among people of varied age groups. In 2020, brain tumor was ranked as the 10th most common kind of tumor among Indians. While there is no specified known cause, age bracket or gender for brain tumors, there is still hope for patients the medical fraternity has made several strides to treat brain tumor effectively with a reduced rate of morbidity and mortality.

Symptoms of such tumors pose a challenge in its early diagnosis and hence complications arise for surgical intervention. Only, once the patient have persistent symptoms and come for further investigation and hence the doctors advice not to ignore any such symptoms for better outcomes.

The International Association of Cancer Registries (IARC) reported that there are over 28,000 cases of brain tumors reported in India each year and more than 24,000 people reportedly die due to brain tumors annually. Every year 40,000 to 50,000 people are diagnosed with brain tumors, out of which 20% are children.

While there has been tremendous advancements made in the treatment modality of brain tumors, the latest CyberKnife radiosurgery system can be used as an alternative to surgery, or in conjunction with other treatments. With the advent of cyberknife, the procedure has played a significant role in the management both non-cancerous and cancerous brain tumors. The technique that has been around in India for about 3-4 years has been mostly used to treat a range of cancerous and non cancerous/benign tumors in the body including the prostate, lung, liver, etc., is now being commonly used to kill tumors of brain and spine as well. What is CyberKnife?

Basically, CyberKnife radiation surgery is the most advanced, non invasive radiation therapy tools available to treat especially non-cancerous as well as cancerous and other diseases with the help of precise beams of high-dose radiation. It is a no pain and a no risk day-care treatment wherein patients are discharged as soon as the session gets over and therefore, no hospitalisation is required. The treatment uses a sophisticated image guidance system to beam high doses of radiation directly to your tumor. The CyberKnife radiation therapy has clinically proven success rates, however, it works the best for a tumors that's upto 2-2.5 cm in size. However, in a few rare cases it is also used as an treatment option to cure brain tumors that either cannot be operated because of their location in the head, or the patients who cannot undergo brain tumor surgery due to their poor medical condition, etc. And, the success of the treatment largely depends and increases beyond 90% upon choosing the right patient. The next

generation of CyberKnife - M6 is highly precise when compared to the earlier ones used in India as this offers some of the exceptional features and delivers a maximum dose of radiation directly to the tumor from many different angles with submillimeter precision for the higher success rates. Also, the emitted focused beams of intense energy destroy cancer cells and shrink/control the growth of tumors. It further prevents the cancerous cells from multiplying. Besides, the CyberKnife system automatically adjusts itself and tracks the tumor which aids in minimising radiation exposure to healthy organs and tissues. The CyberKnife radiation surgery offers multiple benefits compared to conventional radiation treatments and surgery. Cyber Knife Vs conventional Gamma Knife For brain tumor patients, Gamma Knife treatment is not as convenient or comfortable, largely because Gamma Knife requires an invasive head frame be bolted into the skull. Besides, the entire treatment process; right from imaging to planning to treatment itself has to happen on the same day. Typically, the head frame is mounted to the patient s skull in the morning, followed by imaging scans which take place. The patient has no choice but to wait in the hospital during the treatment planning process with the metal head frame bolted to their skull. Compared to this, the CyberKnife is a non-invasive, realtime motion tracking technology for accurate delivery of high-dose radiation therapy. Instead of a bulky head frame, CyberKnife patients are provided with a soft, mesh mask during the treatment. Moreover, treatment with CyberKnife is flexible; imaging is performed few days in advance, thereby leaving the neurosurgeon with enough time to design and finalise a customised treatment plan. Once the plan is set in place, the patient will return for a non-invasive, pain-free experience. Using advanced tumor-tracking technology, the CyberKnife system is able to either deliver one single high-dose treatment, or smaller

doses (upto 5) over the course of two to five days. This approach limits side effects and enables most patients to return to their regular routine the same day. Additionally, clinical studies have shown that patients with certain cancerous and non-cancerous conditions in the brain, neck and spine have a better outcome with a lower dose of two to five fractionated radiation treatments than a single, large dose. Medical accounts of red wine headaches go back to Roman times, but the experience is likely as old as winemaking – something like 10,000 years. As chemists specializing in winemaking, we wanted to try to figure out the source of these headaches.

Many components of red wine have been accused of causing this misery – sulfites, biogenic amines and tannin are the most popular. Our research suggests the most likely culprit is one you may not have considered. **The common suspects** 

Sulfites have been a popular scapegoat for all sorts of ailments since it became mandatory in the 1990s to label them on wines in the US. However, not much evidence links sulfites directly to headaches, and other foods contain comparable levels to wine without the same effects. White wines also contain the same amount of sulfites as red wines.

Your body also produces about 700 milligrams of sulfites daily as you metabolise the protein in your food and excrete it as sulfate. To do so, it has compounds called sulfite oxidases that create sulfate from sulfite – the 20 milligrams in a glass of wine are unlikely to overwhelm your sulfite oxidases.

Some people point the finger for red wine headaches at biogenic amines. These are nitrogenous substances found in many fermented or spoiled foods, and can cause headaches, but the amount in wine is far too low to be a problem.

Tannin is a good guess, since e white wines contain only tiny s amounts, while red wines contain s substantial amounts. Tannin is a fi type of phenolic compound – it's n found in all plants and usually plays a role in preventing disease, resisting predation or encouraging seed dispersal by animals.

But there are many other phenolic compounds in grapes' skin

and seeds besides tannin that le make it into red wines from the winemaking process, and are not present in white, so any of them could be a candidate culprit.

Tannin is also found in many other common products, such as tea and chocolate, which generally don't cause headaches. And phenolics are good antioxidants – they're unlikely to trigger the inflammation that would cause a headache.

#### A red wine flush

Some people get red, flushed skin when drinking alcohol, and the flushing is accompanied by a headache. This headache is caused by a lagging metabolic step as the body breaks down the booze.

The metabolism of alcohol happens in two steps. First, ethanol is converted to acetaldehyde. Then, the enzyme ALDH converts the acetaldehyde to acetate, a common and innocuous substance. This second step is slower for people who get flushed skin, since their ALDH is not very efficient. They accumulate acetaldehyde, which is a somewhat toxic compound also linked to hangovers.

So, if something unique in red wine could inhibit ALDH, slowing down that second metabolic step, would that lead to higher

at levels of acetaldehyde and a headache? To try to answer this question, we scanned the list of phenolics abundant in red wine. We spied a paper showing that

quercetin is a good inhibitor of ALDH. Quercetin is a phenolic compound found in the skins of grapes, so it's much more abundant in red than white wines because red grape skins are left in longer during the fermentation process than white grape skins.

**Putting enzymes to the test** Testing ALDH was the next step. We set up an inhibition assay in test tubes. In the assay, we measured how fast the enzyme ALDH breaks down acetaldehyde. Then, we added the suspected inhibitors – quercetin, as well as some other phenolics we wanted to test – to see whether they slowed the process.

These tests confirmed that quercetin was a good inhibitor. Some other phenolics had varying effects, but quercetin glucuronide was the winner. When your body absorbs quercetin from food or wine, most is converted to glucuronide by the liver in order to quickly eliminate it from the body.

Our enzyme tests suggest that quercetin glucuronide disrupts your body's metabolism of alcohol. This disruption means extra acetaldehyde circulates, causing inflammation and headaches. This discovery points to what's known as a secondary, or synergistic, effect.

These secondary effects are much harder to identify because two factors must both be in play for the outcome to arise. In this case, other foods that contain quercetin are not associated with headaches, so you might not initially consider quercetin as the cause of the red wine problem.

The next step could be to give human subjects two red wines that are low and high in quercetin and ask whether either wine causes a headache. If the highquercetin wine induces more headaches, we'd know we're on the right track.

So, if quercetin causes headaches, are there red wines without it? Unfortunately, the data available on specific wines is far too limited to provide any helpful advice. However, grapes exposed to the Sun do produce more quercetin, and many inexpensive red wines are made from grapes that see less sunlight.

If you're willing to take a chance, look for an inexpensive, lighter red wine. (*Courtesy: Scroll.in*)

By analyzing 20 unique randomized, controlled studies in 54 different publications, reviewers determined that additional vitamin D supplementation for postmenopausal women and older men given that those populations had normal vitamin D levels, no previous fractures, and no issues with bone density — was unnecessary and had no bearing on the severity of injuries from falls.

The finding was an update from a 2018 recommendation that postmenopausal women should not supplement with 400 units or less of vitamin D and 1,000 milligrams or less of calcium for the primary prevention of fracture; men were not included in that recommendation.

#### What is vitamin D good for?

Vitamin D is essential for the bones and teeth, the immune system, brain health, and for regulating inflammation. The body produces vitamin D as a response to sun exposure.

Certain foods and supplements can also boost vitamin D intake. Despite its name, vitamin D is not a vitamin but a hormone or prohormone.

An adequate intake of vitamin D may support good immune function and reduce the risk of autoimmune diseases. Researchers believe there may be a link between long-term vitamin D deficiency and ciency, which can lead to osteoporosis, bone and joint pain, and muscle weakness. These are all factors associated with falls and fractures in older adults.

#### What are physicians' recommendations for vitamin D intake?

Mary Tinetti, MD, a Yale Medicine geriatrician and Gladys Phillips Crofoot Professor of Medicine at Yale School of Medicine, who is an expert in fall prevention, told Medical News Today that the recommendations for vitamin D supplementation have shifted numerous times.

"Falls and vitamin D is an ever-changing topic, with guidelines about testing and supplementing changing, and different groups are making different recommendations depending on current data and what data are considered," Tinetti said.

David Cutler, MD, board certified family medicine physician at Providence Saint John's Health Center in Santa Monica, CA, told MNT that belief in the benefits of vitamin D has changed over time as more research has been published.

"Vitamin D was once considered a panacea for a variety of ailments but now is considered by some to be unimportant. Many recent, large, well-conducted studies have shown no benefits in reducing fracture risk, cardiovascular disease, cancer prevention, or death from vitamin D supplementation," Cutler said. comes independent of increased vitamin D. Needless to say, this nuanced balancing of benefits and risks is difficult for experts, let alone the average person, to reconcile," Cutler explained.

## Do I need to take vitamin D supplements?

Cutler added that many people do not need extra vitamin D supplements in general, but he supported the new findings that it doesn't eliminate the danger to older adults from falls. He emphasized that the context of someone's overall health should be taken into account when considering the need for vitamin D supplements.

"The appropriate conclusion is not that patients do not need any vitamin D but more correctly that patients with adequate amounts of vitamin D will not reduce their fracture risk by additional supplementation." — David Cutler, MD

"Addressing the issue of vitamin D supplementation with your physician requires looking at all the potential benefits and risks in the context of your personal health situation. This includes addressing diet for adequate calcium intake, exercise for fall prevention, and genetic factors that may affect the risk of kidney stones. So, it is only by comprehensively evaluating your entire health status that an appropriate recommendation for vitamin D supplementation can be made," Cutler said. #### Sadness vs. Depression

Feeling sad after a breakup, losing a job, or experiencing a tough day is normal. Sadness is a fundamental human emotion that allows us to process loss or disappointment. However, depression is a clinical condition marked by a persistent low mood, low energy, and a lack of interest in activities that lasts for an extended period, typically two weeks or more.

Learn the difference between normal emotional experiences and mental health conditions. Familiarize yourself with clinical definitions and share accurate information in your circles.

#### Use Language Carefully

Instead of saying "I'm depressed" when you're sad, try "I'm feeling down." This distinction respects those with actual mental health struggles while accurately describing your emotions.

#### Seek Help When Necessary

If you suspect your feelings go beyond normal, consult a mental health professional. They can provide clarity and support rather than relying on internet checklists or social media advice.

#### **Practice Self-Care**

Whether it's stress, sadness, or clinical anxiety, prioritizing self-care can help. Activities like exercise, journaling, mindfulness, and connecting with loved ones benefit overall mental health.

#### A Balanced Perspective

# Conceiving amid smog: Impact of pollution on IVF success

s pollution levels surge across North India, the detrimental effects of poor air quality extend far beyond respiratory illnesses. Increasing evidence reveals a concerning link between pollution and reproductive health, particularly in the success rates of in vitro fertilization (IVF) treatments. For couples struggling with infertility, pollution represents an often-overlooked factor that could significantly impact their journey toward parenthood.

#### **Connection Between Pollution and Fertility**

Air pollution, laden with fine particulate matter, heavy metals, and other toxins, is known to affect overall health. Its influence on reproductive health is now a focus of scientific research. Pollutants like nitrogen dioxide, and sulphur dioxide can disrupt hormonal balance, oxidative stress levels, and inflammation in the body, factors that play a crucial role in fertility. For men, exposure to polluted air has been associated with lower sperm count, reduced motility, and an increase in abnormal sperm morphology. This not only reduces the likelihood of conception but may also elevate the risk of miscarriage and complications during pregnancy.

**Pollution Crisis and Reproductive Health** North India is facing alarming pollution levels, with the region frequently enveloped in hazardous smog during the winter months. Cities like Delhi, Gurugram, and Lucknow report air quality indices (AQI) that often exceed safe limits by several folds. This environmental crisis amplifies health risks, including those related to fertility. For couples seeking IVF treatment, the toxic air quality may pose an added hurdle. Prolonged exposure to polluted air could affect both partners, diminishing the effectiveness of fertility treatments and adding to the emotional and financial strain of the process.

# North Korea's Kim vows toughest anti-US policy before Trump takes office

SEOUL. Dec 29: North Korean leader Kim Jong Un said he will implement the "toughest" anti-US policy, less than a month before Donald Trump takes office as US president, the country's state media reported Sunday.

Trump's return to the White House raises prospects for highprofile diplomacy with North Korea. During his first term, Trump met Kim three times for talks on the North's nuclear programme.

Many experts however say a quick resumption of Kim-Trump summitry is unlikely as Trump would first focus on conflicts in Ukraine and the Middle East. North Korea's support for Russia's war against Ukraine also poses a challenge to efforts to revive diplomacy, experts say.

During a five-day plenary meeting of the ruling Workers' Party that ended Friday, Kim called the US "the most reactionary state that regards anti-communism as its invariable state policy." Kim said that the US-South Korea-Japan security partnership is expanding into "a nuclear military bloc for aggression.3

This reality clearly shows to which direction we should ad-



vance and what we should do and diers how," Kim said, according to the official Korean Central News Agency

It said Kim's speech "clarified the strategy for the toughest anti-US counteraction to be launched aggressively" by North Korea for its long-term national interests and security

KCNA didn't elaborate on the anti-US strategy. But it said Kim set forth tasks to bolster military capability through defence technology advancements and stressed the need to improve the mental toughness of North Korean sol-

The previous meetings between Trump and Kim had not only put an end to their exchanges of fiery rhetoric and threats of destruction, but they developed personal connections. Trump once famously said he and Kim "fell in love." But their talks eventually collapsed in 2019, as they wrangled over USled sanctions on the North.

North Korea has since sharply increased the pace of its weapons testing activities to build more reliable nuclear missiles targeting the US and its allies. The US and South Korea have

responded by expanding their military bilateral drills and also trilateral ones involving Japan, drawing strong rebukes from the North, which views such US-led exercises as invasion rehearsals.

Further complicating efforts to get North Korea to rid itself of nuclear weapons is its deepening military cooperation with Russia.

According to US, Ukrainian and South Korean assessments, North Korea has sent more than 10,000 troops and conventional weapons systems to support Moscow's war against Ukraine. There are concerns that Russia could give North Korea advanced weapons technology in return, including help to build more powerful nuclear missiles.

Russia and China, locked in separate disputes with the US, have repeatedly blocked US-led pushes to levy more UN sanctions on North Korea despite its repeated missile tests in defiance of UN Security Council resolutions.

Last month, Kim said that his past negotiations with the United States only confirmed Washington's "unchangeable" hostility toward his country and described his nuclear buildup as the only way to counter external threats. (AP)

WASHINGTON, Dec 29: Elon Musk has received support from President-elect Donald Trump on his stance on H-1B visas, a day after the tech billionaire vowed to "go to war" to defend the programme used to bring skilled foreign workers to the US.

Musk, who along with Indian-American tech entrepreneur Vivek Ramaswamy has been tapped by Trump to lead his Department of Government Efficiency (DOGE), argued last week that foreign workers are needed for tech companies like Musk's SpaceX and Tesla.

Musk on Friday blasted a user on X who used a video of Musk discussing SpaceX processes to go after the billionaire's stance on the visa programme.

'The reason I'm in America along with so many critical people who built SpaceX, Tesla and hundreds of other companies that made America strong is because of H1B," Musk wrote on X. He also used a profane quote

from Tom Cruise's character in the movie "Tropic Thunder" to attack his critics.

"Take a big step back and F---YOURSELF in the face," Musk said. Trump on Saturday sided with Musk, saying he fully backs the programme opposed by some of his supporters.

"I've always liked the visas, I have always been in favour of the visas. That's why we have them," Trump told the New York Post newspaper.

"I have many H-1B visas on my roperties. I've been a believer in H-1B. I have used it many times. It's a great programme," Trump

grant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise. Technology companies depend on it to hire tens of thousands of employees each year from countries like India and China.

The tech industry has long called for more H-1B visas to attract highly skilled workers to the US. Trump's first administration restricted the programme in 2020, arguing that it allows businesses to replace Americans with lower-paid foreign workers.

Musk, himself once on an H-1B visa and whose electric vehicle company Tesla has hired workers using the programme, defended the tech industry's need to bring in foreign workers.

"Anyone – of any race, creed or nationality – who came to America and worked like hell to contribute to this country will forever have my respect. America is the land of freedom and opportunity. Fight

with every fiber of your being to keep it that way!" he wrote on X on Friday. Musk also lashed out at those

who prioritise personal gain over the well-being of the country. "This is the right position for

those who want America to win. For those who want America to lose for their own personal gain, I have no respect. Zero," he said in

a separate post. Musk has been consistently posting on X in favour of the programme

"There is a permanent shortage of excellent engineering talent. It is the fundamental limiting factor in Silicon Valley," Musk wrote on said. The H-1B visa is a non-immi-December 25 on X.

Several of Trump's supporters and immigration hardliners have been increasingly pushing for scrapping the H-1B visa programme amid debate over immigration

The debate sparked when Laura Loomer, a right-wing influencer, criticised Trump's selection of Indian-American entrepreneur Sriram Krishnan as an adviser on artificial intelligence policy in his coming administration. Krishnan favours the ability to bring more skilled immigrants into the US.

Loomer declared the stance to be "not America First policy" and said the tech executives who have aligned themselves with Trump were doing so to enrich themselves.

The debate intensified when Ramaswamy criticised American culture for promoting mediocrity instead of focusing on academic excellence and success on the basis of merit.

"Trump's election hopefully marks the beginning of a new golden era in America, but only if our culture fully wakes up. A culture that once again prioritises achievement over normalcy; excellence over mediocrity; nerdiness over conformity; hard work over laziness," Ramaswamy said on Thursday

He faced backlash for the comment.

In response, Musk called for removing "contemptible fools" from the Republican Party who oppose his immigration agenda.

Musk later clarified that his statement was addressing the "hateful, unrepentant racists" he considers a threat to the Republican Party's future. (PTI)

Commission has written a letter to President Anura Kumara Dissanayake alleging that they have been denied permission to meet Rohingya refugees staying at a military camp since last week.

"On December 26, a team of officials from the Human Rights Commission of Sri Lanka (HRCSL), including a director, attempted to monitor the detention conditions of these asylum seekers at the Sri Lanka Air Force Camp in Mullaitivu in the Northern Province. However, they were refused access to the asylum seekers." the letter said

The Sri Lanka Navy on December 20 said they had rescued over 100 Rohingyas from Myanmar in a distressed condition in the seas off the island's northeastern coast.

They were spotted by local fishermen in the Mullaithivu district's Vellamullivaikkal area. The government later said their arrival could be due to a human trafficking racket.

"Investigations revealed that they had deliberately landed here and we consider them as illegal immigrants," Deputy Minister of Foreign Affairs Arun Hemachandra was quoted as saying by The Sunday Times here.

The HRCSL letter stated that the powers and functions of the commission extend not only to Sri Lankan citizens but to "any person" detained within Sri Lanka.

The commission said it had the statutory authority to access the said Air Force Camp and monitor the detention conditions of all asylum seekers, including the children present there.

fighters and a dozen passengers were injured in Florida on Saturday when a fire truck with its lights flashing drove around rail crossing arms and into the path of a high-speed passenger train after waiting for another train to pass, according to video of the incident and a person

briefed on what happened. The crash happened at 10:45 am in crowded downtown Delray Beach. In the aftermath the Brightline train was stopped on the tracks, its front destroyed, about a block away from the Delray Beach Fire Rescue truck. Its ladder was ripped off and in the grass several yards away, The Sun-Sentinel reported.

The Delray Beach Fire Rescue said in a social media post that three Delray Beach firefighters were in stable condition at a hospital. Palm Beach County Fire Rescue took 12 people from the train to the hospital with minor injuries

The person familiar with the details of the crash, who was not authorised to disclose what happened because of the ongoing investigation and spoke on condition of anonymity, said the fire truck stopped at the crossing and waited for a freight train to go by before maneuvering around the lowered crossing arms. Video of the collision shows the fire truck

driving around cars stopped at the crossing with its lights flashing to cross the double tracks

Emmanuel Amaral rushed to the scene on screeching train brakes from where he was

jured colleagues away from the tracks. One of their helmets came to rest several hundred feet away from the crash.

"The front of that train is completely smashed, and there was even some of the parts to the fire truck stuck in the front of the train, but it split the car right in half. It split the fire truck right in half, and the debris was everywhere," Amaral said.

A Brightline safety officer said the entire community is involved in ensuring railroad safety and drivers should never go around closed gates.

The Federal Railroad Administration will investigate. A spokesperson for the National Transportation Safety Board said in the afternoon that it was still gathering information about the crash and had not decided yet whether to investigate.

The NTSB is already investigating two crashes involving Brightline's high-speed trains that killed three people early this year at the same crossing in Melbourne along the railroad's route between Miami and Orlando.

More than 100 people have died after being hit by trains since Brightline began operations in July 2017 — giving the railroad the worst death rate in the nation. But most of those deaths have been either suicides, pedestrians who tried to run across the tracks ahead of a train or drivers who went around crossing gates instead of waiting for a train to pass. Brightline has not been found to be at fault in those previous deaths.

# Palestinian shot dead in West Bank home, her family blames Palestinian security forces

JENIN (WEST BANK), Dec 29: A Palestinian woman was shot and killed in her home in the volatile northern West Bank town of Jenin, where the Palestinian Authority is carrying out a rare campaign against militants.

The family of Shatha al-Sabbagh, a 22-year-old journalism student, said she was killed by a sniper with the Palestinian security forces late Saturday while she was with her mother and two small children. They said there were no militants in the area at the time.

A statement from the Palestinian security forces said she was shot by "outlaws" — the term it has been using for local militants who have been battling Israeli forces in recent years. The security forces condemned the shooting and vowed to investigate it.

Separately, a fourth infant has died of hypothermia in the Gaza Strip, where hundreds of thousands of Palestinians displaced by nearly 15 months of war are huddled in tents along the rainy, windswept coast.

The Western-backed Palestinian Authority exercises limited self-rule in parts of the Israeli-occupied West Bank. It is deeply unpopular among Palestinians,

In a statement, the al-Sabbagh family accused the Palestinian security forces of having become "repressive tools that practice terrorism against their own people instead of protecting their dignity and standing up to the (Israeli) occupation."

The Hamas militant group also blamed the security forces and condemned the shooting. It noted that al-Sabbagh was the sister of one of its fighters who was killed in a battle with Israeli troops last year.

Palestinian security forces launched a rare operation earlier this month in Jenin, which has seen heavy fighting between Palestinian militants and Israeli forces in recent years. The Palestinian Authority says the operation is aimed at restoring law and order, while critics charge it with aiding the occupation.

Violence has flared in the West Bank since Hamas' October 7, 2023 attack out of Gaza triggered the war there. At least 835 Palestinians have been killed by Israeli fire in the West Bank since then, according to the Palestinian Authority. Most appear to have been militants killed in clashes with Israeli forces, but the dead also include civilians and participants in violent demonstrations.

## Pakistan 2024: Troubled ties with neighbours, Pak solider killed, 11 wounded in economic woes and a problem called Khan

ISLAMABAD, Dec 29: Pakistan was haunted by political uncertainty, economic instability, a deteriorating security situation and troubled relations with neighbours in 2024. But what defined the year were not just these perennial ills but the country's inability to tackle incarcerated former prime minister Imran Khan.

Amid political turbulence, Pakistan hosted a Shanghai Cooperation Organisation (SCO) conclave, which was also attended by External Affairs Minister S Jaishankar -the first high-ranking Indian minister in nearly a decade to visit Islamabad amid frosty ties between the two neighbours. The last Indian foreign minister to visit Pakistan was Sushma Swaraj. She had travelled to Islamabad to attend the 'Heart of Asia' conference on Afghanistan in December 2015.

In his address at the SCO event, Jaishankar said, "If friendship has fallen short and good neighbourliness is missing somewhere, there are surely reasons to introspect and causes to address.'

He also said if activities across borders are "characterised" by terrorism, extremism and separatism, they are hardly likely to encourage trade, energy flows and connectivity in parallel. His remarks were seen as directed towards Pakistan, which has troubled relations with all its neighbours.

If the year began with Iran conducting missile strikes within Pakistan in January, targeting Baloch militants, it ended with Pakistan carrying out airstrikes in Afghanistan, killing at least 46 people, including women and children, according to Afghanistan's Taliban government. Pakistan says the target was militants.

Pakistan witnessed a series of terror attacks, particularly in troubled and Khyber-Balochistan Pakhtunkhwa provinces in 2024, among the toughest years for its se-

curity forces. According to the details shared

with Parliament by the interior ministry, 924 people were killed and 2,121 injured in 1,566 terrorism incidents in the first 10 months of the year. At least 573 dead and 1,353 injured belonged to law enforcement agencies, including the army. On the economic front, Pakistan

was on the verge of default in 2022 and only averted it due to the timely intervention by the International Monetary Fund.

Prime Minister Shehbaz Sharif takes credit for pulling the country back from the brink of bankruptcy and turning around the economy.

In 2024 inflation came down to single digits, policy rates reduced from 22.5 to 15 per cent, foreign exchange reserves improved, and the stock market made record gains.

But it was jailed former prime minister Imran Khan who often hogged the headlines.

In the elections in February, independent candidates backed by Khan's party surprised everyone by winning more than 100 out of the 226 seats in a hung parliament.

And then the Pakistan Muslim League-Nawaz threw in a surprise. nominating Shehbaz Sharif as the prime ministerial candidate instead of the party supremo and three-time former premier Nawaz Sharif.

As the PML-N and the Pakistan Peoples Party struck a power-sharing deal to form a coalition government led by Shehbaz, Khan's Pakistan Tehreek-e-Insaf (PTI) decided to sit in the Opposition. Khan was arrested in August 2023 after his conviction in a case

of corruption and has remained behind bars since then. Contrary to expectations, his

popularity swelled in 2024, proving right his words -- uttered before he was ousted as PM in 2022 after losing a trust vote in Parliament --that he would be "more dangerous when out of power." (AP)

ISLAMABAD. Dec 29: A Pakistan paramilitary soldier has been killed and 11 others injured in firing by the Afghan Taliban forces at the border posts of Pakistan troops, days after strikes by Pakistan targeted the banned Tehreek-e-Taliban (TTP) militants.

According to defence sources, the Afghan troops resorted to "unprovoked fire on multiple Pakistani border posts" in the Upper Kurram district on Saturday morning.

They fired at posts in Ghozgarhi, Matha Sangar, Kot Ragha and Tari Mengal areas using both light and heavy weaponry, sources said. Pakistani forces retaliated, inflicting significant

losses on the other side as seven to eight personnel of the Afghan forces were killed in the exchange of fire, sources added.

However, in the fire exchange, a "Frontier Constabulary (FC) soldier was killed and 11 others were injured"

The incident of firing occurred days after Pakistan targeted terrorist positions in Paktika province of Afghanistan to punish the banned TTP militants, allegedly using Afghan soil to train and attack Pakistan.

The Saturday attack came after militants made an infiltration attempt on Friday night, using the posts controlled by the Afghan Taliban

to cross into Pakistani territory, but the attempt was thwarted.

"The firing was effectively responded to and there are confirmed reports of heavy losses on the Afghan side with over 15 militants killed and many others wounded," according to sources.

Reportedly, the Afghan forces abandoned their posts and left the area after the incident.

Relations between Pakistan and Taliban-led Afghanistan have deteriorated gradually since they came to power in 2021 because the latter allegedly failed to rein in the TTP rebels who have increased attacks on the Pakistani forces. (PTI)



Three die off northern

France coast in Channel

PARIS, Dec 29: At least three migrants died early Sunday while attempting to cross the English Channel to Britain from northern France, authorities said.

The deaths were confirmed after an early morning rescue operation involving French emergency services and the navy's "Dauphin" helicopter.

The prefecture described the attempted crossing as "difficult," with around 50 people stranded in the water and on the beach near Sangatte at around 6 am. Rescuers assisted 45 individuals, including four who were transported to hospitals.

Three unconscious people were pulled from the water but could not be revived, despite efforts by med-

An investigation has been opened by prosecutors in Boulogne-sur-Mer.

Sunday's tragedy comes during spike in Channel crossing attempts as 2024 draws to a close. Officials have noted a significant increase in attempted crossings over the past days.

This year has been one of the deadliest for migrants attempting the perilous journey between France and England, one of the world's busiest shipping lanes. Despite French and British efforts to stop it, the route remains a major smuggling corridor for people fleeing conflict or poverty.

Migrants favour the UK for reasons of language, family ties or perceived easier access to asylum and work. (AP)

# Croatia holds presidential election with incumbent NATO, EU critic considered favourite

Zagreb, Dec 29: Croatia's leftleaning president, an outspoken critic of Western military support for Ukraine in its war against Russia, is running for reelection in the Adriatic Sea state. but is unlikely to get an outright majority in the first round of voting on Sunday. President Zoran Milanovic, who is often compared to Donald Trump for his combative style of communication with political opponents, faces seven other contenders. including Dragan Primorac, the candidate of the ruling Croatian Democratic Union. The two are expected to face off in the second round on January 12 if no contender gets more than 50 per cent of the vote, according to

pre-election polls. The most popular politician in Croatia, 58-year-old Milanovic had served as prime minister in the past. Populist in style, Milanovic has been a fierce critic of current

# 'Hydropower generation is only the secondary goal' Siang project to mitigate flood risks posed by China: Arunachal CM

ITANAGAR, Dec 29: Arunachal Pradesh Chief Minister Pema Khandu said the Siang Upper Multipurpose Project (SUMP), estimated to cost ₹ 1.13 lakh crore, was being planned by the Centre not just for generating electricity but to maintain the natural flow of the river all year round and mitigate risks of flooding if China released excess water.

Khandu's remarks came in the wake of China approving the construction of the world's largest dam, at a cost of USD 137 billion, on the Brahmaputra river in Tibet close to the Indian border. The dam is to be built at a huge gorge in the Himalayan reaches where the Brahmaputra river makes a huge U-turn to flow into Arunachal Pradesh and then to Bangladesh.

"The SUMP, with an estimated installed capacity of 11,000 mw, is not just about generating power, but also about maintaining the natural flow of the Siang river and mitigating potential flood risks from water releases by China," Khandu told PTI in an interview. Describing SUMP as a project of national importance, he said hydropower generation is only the secondary goal of it.

"The real objective of the project is to save the Siang river and the communities that have depended on it for generations," he said.

The survey for preparing the pre-feasibility report of the projects is yet to be done amid stiff opposition from locals who are concerned about displacement, loss of livelihoods, and environmental impact of the mega dam.

Warning of severe consequences if China's project moves ahead "without safeguards", Khandu said the neighbouring country's plans to divert water from the Brahmaputra into its arid regions could drastically reduce the flow of the Siang river during winters.

"In such a scenario, the volume of water



could decrease so much that one might be able to cross the mighty river on foot," he claimed.

"The proposed Siang project would create a reservoir capable of storing 9 billion cubic meters of water. This would ensure the river maintains a consistent flow, even during dry seasons. Additionally, the reservoir would act as a buffer in case of sudden water releases from upstream Chinese dams, potentially averting catastrophic flooding in Arunachal Pradesh, Assam and Bangladesh," he said.

Acknowledging the ongoing bilateral discussions between India and China, the CM cautioned against "complacency"

"China is unpredictable and can do anything," Khandu said, underscoring the need for India to remain vigilant.

"We cannot take chances when it comes to national security and the welfare of our people," he said.

The Chinese government approved the

construction of the hydropower project in the lower reaches of the Yarlung Zangbo river, the Tibetan name for the Brahmaputra. It is expected to generate more than 300 billion kWh of electricity each year - enough to meet the annual needs of over 300 million people.

The total investment in the dam could exceed one trillion yuan (USD 137 billion), which would dwarf any other single infrastructure project on the planet, including China's own Three Gorges Dam, regarded as the largest in the world.

On the concerns of the locals, Khandu said the government would conduct extensive surveys before finalising the plans.

"Only after these studies, we will know the exact location of the dam, its height, and the submergence area," he said, adding that a public hearing will be held to listen to people's concerns.

The CM said India was a democratic country, and it does not believe in "forcing"

things on its people

However, he criticised activists, accusing them of spreading misinformation among villagers about the project.

He claimed that these activists were instigating people without providing accurate information about the project's benefits.

"I urge people to come forward and get their confusions addressed through dialogue," he said.

Khandu also spoke about the state's broader hydropower development plans.

He said the Cabinet Committee on Economic Affairs (CCEA) recently sanctioned ₹ 1,750 crore for the 186 mw Tato-I Hydro Electric Project and ₹ 1,939 crore for the 240 mw Heo Hydro Electric Project in the Shi Yomi district.


The CM said the state has signed agreements with NHPC, NEEPCO, THDCIL, and SJVN to develop 13 hydropower projects with a combined capacity of over 11,000 mw. Once completed, these projects are expected to generate substantial revenue for the state.

The Centre has also approved a significant equity support scheme to boost hydropower development in the Northeast, he said.

Under this initiative, ₹ 4,136 crore has been allocated to northeastern states to develop hydroelectric projects with a cumulative capacity of 15,000 mw by 2032.

"This initiative will transform the hydroelectric landscape of Arunachal Pradesh and the northeast region," Khandu said, adding the Centre has also agreed to increase the Local Area Development Fund (LADF) contribution from power projects to over 2 per cent.

"We are taking steps to ensure that Arunachal Pradesh becomes a powerhouse for the nation while protecting the interests of our people and environment,' he added. (PTI)

# Speeding train severely injures elephant in Tripura

AGARTALA, Dec 29: A full-grown elephant was severely injured after allegedly being hit by a speeding train in Tripura's Khowai district, an official said on Sunday.

District Forest Officer (DFO) Akshay Balu Bhorde told PTI that the elephant was bleeding profusely following the accident that happened on Saturday night

It was given preliminary treatment and a team from the state veterinary hospital was sent to the spot, he said.

"A local train, which was going from Agartala to Dharmangar on Saturday night, hit the elephant at Champlai. The elephant herd was moving from one habitation to another when the accident happened," Bhorde said.

"The train, which was supposed to run at low speed (20 km per hour) as it is an elephant corridor, might have crossed to 50 km per hour, leading to severe injuries to the elephant," he said.

Bhorde said both back legs of the elephant were severely fractured, and it cannot even crawl due to the injuries.

Northeast Frontier Railway's CPRO Kapinjal Kishore Sharma, however, said, "It was not exactly known what has happened because the loco pilot is not aware of any mishap."

'The loco pilot cautiously passed the elephant corridor. A probe is on to know what exactly occurred on Saturday night," he added

The forest officer said that an elephant had died in February after being hit by a train at Champlai, a designated elephant corridor.



# Akash Sagar's video posted one week after Church visit

SHILLONG, Dec 29: Police investigation has revealed that Akash Sagar had gone to the Church of Epiphany at Mawlynnong in East Khasi Hills - also known as the cleanest village in Asia - days before he uploaded the video on social media.

"Sagar had gone and committed the act one week before he uploaded the same on social media," East Khasi Hills SP Sylvester Nongtnger has said. The police had registered a case against one Akash Sagar following an FIR filed against him. It is alleged that Sagar had uploaded the video, where he was seen entering the church and shouting "Jai Shree Ram" and singing a Hindu song. Nongtnger said that Sagar is not a resident of the state and had gone to Mawlynnong village as a tourist. He said that police are on the job to locate the accused's place of origin.

Earlier, attempts were also made to check the airports.

On December 26, the Thma U Rangli-Juki (TUR) leader Angela Rangad had filed an FIR against a social media user for "criminally trespassing" the Church of Epiphany at Mawlynnong in East Khasi Hills - also known as the cleanest village in Asia - and shouted non-Christian slogans allegedly aimed at creating communal disharmony.

In a complaint lodged with the Laitumkhrah police station, Rangad had said, "Recently I came across videos on social media, Facebook and Instagram by one Akash Sagar, where he is found criminally trespassing the Church of Epiphany, Mawlynnong, East Khasi Hills, Meghalaya and deliberately desecrating the religious sanctity of the church by deliberately and in a premeditated and planned way trespassed into the altar area and

shouted non-Christian slogans and mockingly sang non-Christian songs.

"This act was deliberately and in collusion with two others who appear in the video, done to create communal disharmony, insulting the minority culture and to establish a majoritarian culture of hate in violation of all constitutional rights of religious freedom," she added.

Rangad also alleged that this video creates a culture of fear and is liable to create public disorder while adding moreover these videos are being shared widely by handles promoting religious majoritarianism and hate.

"I therefore appeal to you to take strong legal

act and criminal conspiracy and also ask the social media platforms to ban these videos, their creator and the people and groups that are sharing these. This person needs to be booked and legal action should ensue to ensure that such criminal acts that threaten the peace do not take place again," the TUR leader had stated in the FIR.

# Akhilesh pitches for ballot voting, Says EVMs not trustworthy 'Even faces of those who win elections seem dejected as they too do not have faith in the system'

LUCKNOW, Dec 29: Samajwadi Party (SP) president Akhilesh Yadav has called for elections to be conducted using ballot papers, citing a lack of trust in electronic voting machines (EVMs).

The former Uttar Pradesh chief minister said this at a press conference at the SP headquarters here on Sunday, alongside Rahul Kumar Kamboj, an Indian-origin member of Parliament in Germany.

"Even a country like Germany conducts elections using ballot papers. But in India, elections are conducted with EVMs to serve vested interests," Yadav said.

Emphasising the need for elections that inspire confidence, he said, "No one trusts EVMs. Even the faces of those who win elections seem dejected as they too do not have faith in the system.

highlighted the benefits of Germany's ballot-paper voting system. "In Germany, voting is still conducted using ballot papers. It is an important system because any discrepancies can be addressed with a

recount," he explained. Reflecting on his visit to Lucknow and his longstanding relationship with Yadav, Kamboj said, "My efforts are focused on fostering a collaboration between Indian-origin

individuals and Germany, so that the qualities of both countries can come together. We aim to facilitate cultural exchanges and I invite everyone to participate in the upcoming cultural festivals in Germany. Visa issues will no longer be a hurdle," he said.

Kamboj also spoke of building a bridge between opportunities in Europe and their implementation in India, specifically in Uttar Pradesh. "If we can identify the opportu-

nities available in Germany and Europe, and bring them to places like Lucknow, it will open new avenues. That is my mission," he added. Welcoming Kamboj, Yadav ex-

pressed enthusiasm for strengthening ties. "Your visit has created an opportunity to deepen the relationship between our regions, which will benefit the people of this state and country," he said.

Highlighting the need for a stronger future for the next generation, Yadav said, "Our youngsters need better education, training and skills to secure good jobs. Building bridges between opportunities will open pathways to progress."

Sharing a personal anecdote, Yadav recounted his government trip to Germany. "I remember visiting Frankfurt and deciding to travel to Hannover by road.

The roads in Germany are among the best and that inspired me to replicate them in Uttar Pradesh. Today, when people drive on the Agra-Lucknow Expressway, they feel that it is one of the best roads in the world," he said.

NEW DELHI, Dec 29: Sharmistha leashing trolls on social media, should do Mukherjee, the daughter of former president Pranab Mukherjee, alleged on Sunday that decay has set in the Congress and stressed the need for serious introspection on the "sad state of affairs" in the party.

"The Congress has to answer for this. I can only state the fact. But I would like to just add, I do not know whether it was deliberate or sheer negligence. What are the conventions in such a grand old party?" she asked.

"If there is this loss of institutional memory, if Rahul Gandhi and the people around him do not know how the Congress acted in these earlier situations, that itself is a serious and sad state of affairs within the Congress," Mukherjee told PTI Videos.

Asked about recognising the contributions of non-dynastic leaders in the Congress, she said, "Let us not forget what was done to (former prime minister) P V Narasimha Rao.<sup>3</sup>

"The whole Congress ecosystem, as in, its social media was relentlessly trolling me and my father over this and some other issues. The kind of language that was used on me and one of the tallest leaders like my father shows that there is a real rot in the Congress. "The Congress, rather than un-

serious introspection that why a person like me who believed in the hardcore Congress ideology, today feels alienated by the party," she said.

Earlier, in a post on X, Mukherjee said: "When baba passed away, Congress didn't even bother to call CWC for a condolence meeting. A senior leader told me it's not done for Presidents. That's utter rubbish as I learned later from baba's diaries that on K R Narayanan's death, CWC was called and condolence msg was drafted by baba only.

Speaking on the row over the setting up of a memorial for former prime minister Manmohan Singh, Mukherjee said she would not venture into the controversy as she is not part of the Congress anymore







## **Dravidianism and communism** will stay forever: Stalin

CHENNAI. Dec 29: The ties between Dravidianism and communism were beyond electoral politics and the "ideological friendship" would stay on forever, Tamil Nadu Chief Minister M K Stalin said on Sunday.

The "political friendship" between the two movements may have taken the occasional break, he said in an apparent reference to alliance regrouping, "but the ideological friendship will continue under all circumstances."

"It is bound to continue," the CM, also president of the ruling Dravida Munnetra Kazhagam (DMK) said at an event to mark the birth centenary of freedom fighter and CPI veteran R Nallakannu, here.

Veteran Communist leader Singaravelar

had supported Periyar when he founded the Dravidar Kazhagam (DK).

In fact, DMK stalwart and former CM M Karunanidhi had once said he would have joined the communist movement if the DK did not come into existence. Stalin recalled.

"I myself am named Stalin," he said in an apparent reference to Russian communist leader Joseph Stalin.

"The friendship between the two movements is ideological friendship, beyond electoral politics. The best gift to be given to Nallakannu on the occasion of his birth centenary would be that of democratic forces joining hands against casteism, communalism, majoritarianism, and autocracy," Stalin said. (PTI)

Chadha and Delhi Chief Minister Atishi, Kejriwal claimed the BJP was trying to win elections through "unfair means" after failing to present strong candidates or issues.

"BJP has already lost the elections. They don't have a chief ministerial face or even proper candidates. They only aim to win through manipulation, but we won't let them succeed," Kejriwal said.

The former Delhi chief minister also alleged that the BJP had filed 11,000 voter deletion applications in one constituency alone, but the move was halted at Chief Election Commissioner's intervention. "We exposed this, and thankfully, it was stopped."

Kejriwal said that a large-scale operation began on December 15, with 5,000 voter deletion applications and 7,500 addition requests filed so far in his assembly constituency, New Delhi.

He claimed this could alter 12 per cent of the constituency's votes. The total number of voters in the constituency, he said, is 106,873, as per the voter list published on October 29 after the summary revision, which was conducted between August 20 and October 20.

"Operation Lotus has now reached my constituency. They are attempting to manipulate the electoral rolls to change the election outcome," Kejriwal alleged. "This kind of manipulation undermines democracy. We appeal to the Election Commission to continue its strict monitoring to prevent such malpractice," he said.

The BJP is yet to respond to the allegations. (PTI)

# 2024: India navigated geopolitical challenges with steely resolve, focused on expanding strategic heft

NEW DELHI, Dec 29: In a year marked by geopolitical tensions and turbulence, India and China ended an over four-and-a-half-year border standoff and announced steps to reduce mistrust even as New Delhi faced fresh challenges after deposed Bangladesh prime minister Sheikh Hasina fled the country in the face of a mass movement against her rule.

The year 2024 saw India shifting gears in expanding its strategic heft in the neighbourhood and beyond with a steely resolve while navigating the two most consequential crises -- the war in Ukraine and the Israel-Hamas conflict.

At the fag end of the year, New Delhi was readying its approach in dealing with US President-elect Donald Trump's second term amid fears that his policy approach relating to trade and tariff may have profound implications for international trade.

Though the overall India-US relations broadly continued to blossom, especially in the domains of defence, critical technologies and clean energy, the ties came under some strain over the so-called "murder for hire" case.

Washington has been pressing India to take action against Indians allegedly involved in a foiled plot to assassinate pro-Khalistan separatist Gurpatwant Singh Pannun in New York last year.

In November last year, US federal prosecutors charged Indian national Nikhil Gupta of working with an Indian government employee in the plot.

The relations between India and Canada sharply nosedived in the second half of the year after Ottawa linked several Indian diplomats including High Commissioner Sanjay Verma to the murder of Khalistani separatist Hardeep Singh Nijjar.

India strongly rejected the charges and recalled Verma even as the Canadian government said Indian diplomats were expelled. India expelled acting Canadian High Commissioner Stewart Wheeler

and five other diplomats following Canada's allegations. However, the end of the military

faceoff between India and China along the Line of Actual Control in eastern Ladakh was the high point in the foreign policy domain.

A brutal clash at Galwan Valley in June 2020 that killed 20 Indian soldiers and an unspecified number of Chinese soldiers took relations between the two nuclear-armed to disturb peace and tranquillity in neighbours to their lowest point in border areas.

Following an understanding reached on October 21, the two sides completed the disengagement of troops at the two remaining friction points of Demchok and Depsang

Nearly four weeks later, the Special Representatives on the border issue -- India's National Security Adviser Ajit Doval and China's foreign minister Wang Yi held talks in Beijing

It was the first dialogue under the framework of Special Representatives in nearly five years.

In the talks, Doval and Wang focused on "positive" direction for cross-border cooperation including resuming the Kailash Mansarovar Yatra, river data sharing and border trade

There were indications of some positive approach in India-Pakistan relations as External Affairs Minister S Jaishankar travelled to Islamabad in October to attend a summit of the Shanghai Cooperation Or-

->

ganisation (SCO). It was the first such visit from India to Pakistan in nearly a decade that came amid frosty ties between the two neighbours.

Jaishankar's exchange of pleasantries and brief interaction with Pakistan Prime Minister Shehbaz Sharif and Foreign Minister Ishaq Dar triggered hopes of better ties between the two neighbours.

However, India's relations with Bangladesh also came under severe strain after deposed prime minister Hasina fled the country in the face of a massive anti-government protest that ended her nearly 16year rule.

Hasina, 77, has been living in India since August 5.

The relations nosedived dramatically after the interim government headed by Muhammad Yunus failed to contain attacks on minorities, especially Hindus, in that country.

This month, the Yunus-government sent a diplomatic note to New Delhi seeking extradition of Hasina, a move that may further strain the ties

The year also saw India forced to focus more on the neighbourhood with pro-China leaders helming governments in the Maldives and

#### Nepal Following insistence of Maldivian President Mohamed Muizzu, India withdrew all its military personnel from the Maldives, a key island nation for New Delhi in the

Indian Ocean In June, top leaders from India's neighbourhood and the Indian Ocean region including Muizzu,

Nepal Prime Minister Pushpa Kamal Dahal 'Prachanda' and Sri Lankan President Ranil Wickremesinghe graced the swearing-in ceremony of Prime Minister Modi. Bangladesh Prime Minister Hasina, Mauritius Prime Minister

Pravind Kumar Jugnauth, his Bhutanese counterpart Tshering Tobgay and Vice-President of Seychelles Ahmed Afif also attended the glittering ceremony.

In his first foreign trip after becoming the prime minister for a third straight term, Modi travelled to Moscow in July.

In his meeting with President Vladimir Putin, Modi told him that a solution to the Ukraine conflict is not possible on the battlefield and peace efforts do not succeed in the

midst of bombs and bullets. Modi's visit to Russia triggered some criticism in the West as the trip came amid global outrage over a Russian missile strike on a children's hospital in Kyiv.

In his televised opening remarks at summit talks with Putin in the Kremlin, Modi said killing of innocent children is heart-wrenching and very painful.

In August, Modi travelled to Ukranian capital city of Kyiv and conveyed to President Volodymyr Zelenskyy that both Ukraine and Russia should sit together without wasting time to end the ongoing war and that India was ready to play an "active role" to restore peace in the region.

The prime minister said India was on the side of peace since the beginning of the conflict and he would even like to contribute personally for a peaceful resolution of the crisis.

Modi's nearly nine-hour visit to Ukraine was the first by an Indian prime minister since its independence in 1991.

In February, Qatar released eight jailed former Indian Navy personnel and seven of them returned home.

It was seen as a major diplomatic victory for India that came nearly three-and-half months after a Qatari court handed them death sentence. (PTI)



## Law will take its own course in theater stampede case: DGP

NEW DELHI, Dec 29: A 46-year-old murder convict who jumped parole during the COVID pandemic was apprehended from Mumbai, police here said on Sunday.

Ajay Kumar Tripathi was found working in the metro city's Ghatkopar area with a food app as a delivery executive.

He was serving a life sentence for killing a boy he had kidnapped from northeast Delhi's Bhajanpura area.

"Tripathi was convicted of kidnapping and murdering a child in 2000 in Delhi. He was serving a life sentence when he was granted parole on July 23, 2021, during the COVID-19 pandemic," a police officer said.

On September 19, 2021, when his parole ended. Tripathi did not return.

ing. In 2010 also, he jumped parole and evaded arrest for five years," the officer said.

To track him down this time, police collected information from his previous addresses, jail records, and visitors and found Tripathi had moved to the Maharashtra capital.

"A team camped in Mumbai, verified local delivery personnel, and traced Tripathi to Gautam Nagar in Chembur. He was apprehended on December 28," the officer said.

Tripathi, originally from Agra, holds a graduate degree and worked as a storekeeper when he kidnapped the boy. (PTI)

Following the incident, the city police registered a case against Allu Arjun, his security team, and the theatre management under different sections of Bharatiya Nyaya Sanhita (BNS) at the Chikkadpally police station based on the complaint lodged by the deceased woman's family.

The regular bail petition filed by the actor, who was named as accused no 11, has been posted by a local court to December 30. Allu Ariun was arrested on December 13 in connection with the incident and later granted interim bail by the Telangana High Court. (PTI)

Zeenat had been relocated from Maharashtra's Tadoba-Andhari Tiger Reserve (TATR) to Similipal last month to introduce new gene pool to the tiger population.

After leaving Similipal, Zeenat ventured through forests in Manbazar and Bandwan before crossing into West Bengal, covering over 120 km across the borders of West Bengal, Jharkhand, and Odisha.

Despite efforts, the tigress avoided baits in trap-door cages and instead killed domestic goats that strayed into the forest. Surveillance using drones was also conducted. but the dense forests made monitoring challenging.

Officials said Zeenat had been traveling shorter distances in recent days, suggesting she may be settling in the area. (PTI)

# 4 workers die after inhaling toxic IIMs develop framework for capital market, banking gas at chemical unit in Bharuch

#### BHARUCH (GUJARAT), Dec cial said.

**29:** Four workers died on Sunday after inhaling toxic fumes following gas leakage at a chemical plant at Dahej in Gujarat's Bharuch district, police said.

The victims fell unconscious after inhaling the toxic fumes leaking from a pipe at a production unit of the Gujarat Fluorochemicals Limited (GFL) at around 10 pm on Saturday, Dahej police station inspector BM Patidar said.

They were rushed to a private hospital in Bharuch. Three of them died at around 3 am on Sunday, while another one succumbed at 6 am, the official said.

"The incident occurred at around 10 pm when the four workers fell unconscious due to gas leakage from the pipe passing through the ground floor of the company's CMS plant. They were rushed to a private hospital where all four of them died," he said.

The bodies were sent for postmortem and further probe into the incident was underway, the offi-

The deceased have been identified as Rajesh Kumar (hailing from Gujarat), Mudrika Yadav (belonging to Jharkhand), Sushit Prasad and Mahesh Nandlal (both from Uttar Pradesh), police said. GFL, Dahej, Deputy General Manager Jignesh Parmar told reporters that they will investigate the matter and a compensation of

₹ 25 lakh would be paid to the kin of each of the deceased workers. "The company and the management are saddened by the incident.

We have promised to cooperate with legal authorities and we will investigate the matter and bring out our report," he said.

Sub Divisional Magistrate, Bharuch, Manisha Manani said three of the deceased were from other states.

"Four persons died due to gas leakage at the GFL plant near Ambeta village. The bodies have been sent to the civil hospital in Bharuch for post-mortem and an investigation is underway," Manani said. (PTI)

NEW DELHI, Dec 29: Researchers at Indian Institute of

Management (IIM) at Lucknow, Amritsar and Kashipur have combined to develop a new framework to guide the country's capital market players and banking sectors in adopting technologies that would enable them to use software without installing them. Referred to as Software-as-a-

Service (SaaS) technologies, these are cloud-based services that deliver software applications over the Internet, eliminating the need for

organisations to install and maintain software on their own servers. While SaaS is widely used globally, its adoption in India, particularly among regulated industries, has been slow.

The research delves into the reasons for this hesitation and offers insights into how firms can assess risks involved in adopting SaaS. The research has been published in the prestigious Journal of Organi-

sational Computing and Electronic Commerce.

"Popular SaaS applications include Google Drive and Microsoft 365. While SaaS offers cost savings and flexibility, its adoption in India has been slow, especially in highly regulated industries, due to concerns over data security, privacy, and compliance with stringent regulations," said IIM Lucknow professor Arunabha Mukhopadhyay, who led the research.

"The research addresses these concerns by introducing a riskbased IT governance framework, designed to help organisations in regulated sectors assess the risks associated in using cloud-based software. The framework focuses on how top management makes these decisions, especially about data security, loss of control, and regulatory compliance," he told PTI.

Other members of the team included Swati Jain from IIM Amrit-



sar and Shubhendu Dutta from IIM Kashipur.

The team found that decisions about adopting SaaS in regulated industries depend largely on how leadership views and manages risks. The researchers developed a model that considers factors such as the organisation's risk tolerance, security measures, and internal processes. If the perceived risks are

deemed too high, the model sugare manageable, the organisation

"Our study, which includes a case study of a capital market firm, shows that organisations make decisions about SaaS adoption not just by evaluating the technology itself but by carefully assessing the

risks involved. We emphasise the importance of managing risks related to data security and regulatory compliance," Mukhopadhyay said.

'The framework we developed helps organisations evaluate these risks and make more informed decisions about whether to adopt SaaS. The practical implications of the study are significant. SaaS providers can leverage these findings to tailor their offerings to better meet the needs of companies in regulated industries, addressing their security and compliance concerns.

"For organisations, especially in banking and capital markets, understanding how to evaluate and manage risks will help them adopt SaaS solutions more confidently.

This research contributes to a deeper understanding of the factors influencing technology adoption, particularly in sectors where regulatory requirements and security concerns are paramount," he added. (PTI)

Modi praised ANR for taking Telugu cinema to "newer heights"


"His films beautifully depicted Indian traditions and values.'

His comments come after he announced on Friday that director Matt Reeves' sequel to his 2022 film "The Batman" was postponed by a year -- from October 2, 2026, to October 1, 2027.


The development led to a section of fans online criticising the studio over the delay in the part two of the movie, starring Robert Pattinson in the title role.

The filmmaker, also known for directing Marvel Studios's "Guardians of the Galaxy" film franchise as well as "The Suicide Squad" from the erstwhile DC Films, previously confirmed the delay in the release of "The Batman".

At a memorial service at Y B Chavan Centre in south Mumbai, several film industry people, including Azmi, Shah, Javed Akhtar, Kulbhushan Kharbanda, Ila Arun, Prahlad Kakkar, Urmila Matondkar, Divya Dutta, gathered to honour Benegal.

"The first image I've of Shyam Benegal was in 1973 and what struck me about him the most was his wide, warm smile as I went to visit him at ASP office where he was the creative director and was looking for cast for 'Ankur'.

"The last image I've of Shyam was on December 14, 2024, when he, Nira and Pia had organised a celebration for his 90th birthday. After spending a beautiful hour with us, he was whisked away with that same warm wide smile," Azmi said.

The filmmaker passed away on December 23 after suffering from a chronic kidney disease.

Azmi, who collaborated with Benegal on films like "Ankur", "Nishant", "Junoon", "Susman", and "Antarnaad", shared an anecdote about Benegal's personal life.

"Not many people know that Shyam Benegal was a romantic man. He got to know that Nira (his wife) loves vellow flowers, so the day they got married, he sent her a bouquet of yellow flowers and a message written on it saying, 'Only 23 hours'. Then the bouquet kept coming every hour till they got married. Can you imagine? If I were Nira, I would've postponed the marriage, it was so lovely," Azmi added.

# Australian tail wags after Bumrah magic, Test at MCG poised for exciting finish

MELBOURNE, Dec 29: Jasprit Bumrah left the hosts in a daze with a dream spell but the courageous Australian lower order steered the side to a commanding 333-run lead on Sunday, setting up the Boxing Day Test for an intriguing last-day finish.

Australia finished the fourth day at 228 for nine, leaving India skipper Rohit Sharma a bit irritated as the home team was in a spot at 156 for 8 at one stage.

Australia's number 8, 10 and 11 batters saw off nearly 35 overs and it could prove decisive if India doesn't bat exceedingly well on a track which has remained true in all four days.

Bumrah (4/53 in 17 overs) was an artist at work in the first two sessions and found his ally in Mohammed Siraj (3/66 in 22 overs) as momentum suddenly swung in India's favour.

Bumrah was unplayable for the better part of the second innings and completed 200 Test wickets on the day at an incredible average of 19.56.

But as luck would have it, he couldn't complete his five-for as he overstepped when he had




