## Manmohan Singh cremated with full state honours

NEW DELHI, Dec 28: Former Prime Minister Manmohan Singh, who led India to the path of economic liberalisation in the 1990s, was cremated with full state honours here on Saturday in the presence of top dignitaries from the country and abroad.

Singh's funeral pyre was lit by his eldest daughter, Upinder Singh, at the Nigambodh Ghat as family members, friends, and dignitaries bid farewell to the reformist former prime minister.

President Droupadi Murmu, the supreme commander of the armed forces, led the nation in paying last respects to the departed leader.

Priests and family members recited religious hymns from the holy Gurbani, while chants of "Satnam Waheguru" filled the air, as Singh was cremated according to Sikh rituals

Before Singh's mortal remains were consigned to flames, the security forces gave a salute of three volleys of small arms and the buglers sounded the "Last Post" as a mark of honour for the former Prime Minister.

AHMEDABAD, Dec 28: The increasing use of divisive rhetoric based on religion, caste, and ethnicity poses a major challenge to the constitutional ideal of fraternity as well as the sense of unity in the country, Supreme Court judge Justice Prashant Kumar Mishra has

He was speaking on the theme of `Fraternity: Spirit of the Constitution' at a national council meeting of the Akhil Bharatiya Adhivakta Parishad, a lawyers' organisation, at Vadtal in Gujarat's Kheda district. The use of identity politics for votes by politicians can deepen social divisions, he warned.

Divisive ideologies, growing economic inequality, and social injustice are major threats to the spirit of brotherhood, and upholding fraternity is a "shared responsibility" of common citizens, institutions as well as leaders, Justice Mishra said.

Among the ideals of liberty, equality, and justice, fraternity shines as the unifying thread that binds the fabric of our democratic society, and without fraternity, the other ideals remain fragile, "like a tripod missing a crucial leg," he said. "A major challenge to the fraternity is the increasing use of divisive rhetoric based on religion, caste and ethnicity. When individuals or groups promote narratives that pit one community against another, it weakens the sense of unity envisioned by the Constitution,' Justice Mishra said.

### Contribution to PM CARES Fund falls in 2022-23

**NEW DELHI, Dec 28:** The total voluntary contribution to the PM CARES Fund fell to ₹912 crore in the fiscal year 2022-23, its lowest since the public charitable trust was created in March 2020 follow-

ing the COVID-19 outbreak. A study of the audited statements on the Prime Minister's Citizen Assistance and Relief in Emergency Situations (PM CARES) Fund website shows that the voluntary contribution peaked at ₹ 7,184 crore in 2020-21 and then fell to ₹ 1,938 crore in 2021-22, before declining further in 2022-23 as the Covid threat receded after 2021.

The fiscal 2022-23 is the last year for which the statement is available on the website.

sharper decline, registering a high of ₹495 crore in 2020-21, before falling to ₹ 40 crore and ₹ 2.57 crore in the next two years.

The total expenditure in 2022-23 was around ₹ 439 crore, with ₹ 346 crore of it used by the "PM Cares for Children", a government initiative to support children who lost both of their parents, legal guardians, or surviving parents to the Covid pandemic.

An amount of nearly ₹ 92 crore was spent on the procurement of oxygen concentrators, according to the statement.

In Guwahati city, Special Task Force (STF) personnel conducted an operation at a hotel in Paltan Bazar on Friday night and seized 416 gm of heroin, estimated to be worth ₹ 2.75 crore.

Four persons were apprehended from the hotel, Sarma said.

"In a late-night anti-narcotics operation carried out by @STFAssam, 4 traffickers were apprehended at a hotel in Paltan Bazar, Guwahati and 416 gm of heroin were recovered from their possession. We will continue our mission of #AssamAgainstDrugs to save our youth from the vices of contraband substances," the chief minister posted on X.

In another operation in the Nagaon district, drugs worth over ₹ 3.5 crore were seized and a person was apprehended by the police on Friday night, Sarma said.

## Telcos investment recovery in limbo as tariff hike backfires

try's private telecom operators face twin challenges on investment recovery in the New Year - customers leaving their network after tariff hikes and satellite players mainly Elon Musk's Starlink eyeing a chunk of their bread and butter data business.

To recover investments and protect margins, private telcos resorted to tariff hikes in mid-year but that move backfired.

Around 2 crore subscribers dropped their connections. Reliance Jio, Bharti Airtel and Vodafone Idea jointly lost 2.6 crore customers due to a 10-26 per cent

Around 68 customers switched to state-run player BSNL which refrained from price hike. The lossmaking PSU still offers generation-old 3G service and is on the path of rolling out 4G network across the country.

Despite subscriber loss, private players need to recover investment and invest more in 5G to offer new-age services to drive future

### Manmohan Singh cremated

United Progressive Alliance (UPA) to victory in the 2004 Lok Sabha polls, stepped back from the Prime Minister's chair, nominating Singh to lead the coalition.

The quintessential economist went on to steer the nation for the next 10 years, a period that saw him end India's nuclear apartheid by pressing ahead with the Indo-US civil nuclear deal, despite resistance from the Left Front that was giving support to the UPA from outside.

In a show of uncharacteristic firmness in 2008, Singh risked his government over the deal after the Left withdrew support. He faced and won a no-confidence vote in the Lok Sabha.

Entering the Rajya Sabha in 1991 as a member from Assam, Singh remained in the House of Elders till April 2024. His last innings in the Upper House was from Rajasthan, the only other state he ever represented besides Assam. Singh died of age-related complications at the All India Institute of Medical Sciences (AIIMS) in Delhi, the ace tertiary-care public establishment where the former Prime Minister always got admitted whenever he faced medical complications. Sources close to the family said the "Akhand path" would be held at Singh's residence on January 1 and its "bhog" would be held on January 3. They said the Antim Ardas and kirtan for Singh would be conducted at the Gurdwara Rakab Ganj on the evening of January 3.

Earlier in the day, Singh's body, placed in a flower-bedecked casket and carriage, was taken from his 3, Motilal Nehru residence in Lutyens' Delhi to the headquarters of the Congress party, which he represented in Par-

liament for 33 long years. At the party office, Kharge, Sonia Gandhi, Rahul Gandhi and Priyanka Gandhi Vadra paid rich tributes to their leader, as did thousands of Congress workers who had gathered to catch a last glimpse of Singh.

The former prime minister's final journey then started from the AICC office to the Nigambodh Ghat, where the procession reached around 11:30 am. A large crowd had gathered at the AICC office as well as at the Nigambodh Ghat. The vehicle carrying the mortal remains of Singh left his residence a little before 9 am. The procession moved forward amid chants of "Manmohan Singh Amar Rahe". A number of Congress workers and leaders, along with hundreds of Singh's well-wishers, walked along chanting "jab tak suraj-chand rahega, tab tak tera naam rahega".

Demands for honouring Singh with Bharat Ratna, the highest civilian award of the country, were also raised during the procession. Draped in the tricolour, the flower-bedecked casket was placed on a raised platform at the ghat, where leaders cutting across party lines laid wreaths on Singh's mortal remains.

Singh's wife Gursharan Kaur and one of their daughters also laid a wreath on his body at the AICC headquarters. The three daughters of Singh -- Upinder Singh, Daman Singh and Amrit Singh -- along with other relatives, were present.(PTI)

#### Divisive rhetoric major challenge empowering marginalised groups, can become harmful when it focuses solely on narrow group interests at the expense of the common good, often resulting in "exclusion, discrimination, and conflict," he said.

"Divisive rhetoric creates mistrust among communities, leading to the spread of stereotypes and misunderstandings. These tensions can escalate into social unrest. Moreover, when political leaders use social identities for electoral gains, it deepens these divisions, making it harder to build a collective sense of belonging," the judge added. Digital technology and social media have often been misused to spread hate speech, misinforma-

tion and divisive content, Justice Mishra observed. "These challenges to safeguarding fraternity highlight the importance of collective efforts in addressing these issues. Overcoming divisive rhetoric, bridging economic disparities, and harnessing technology responsibly

requires active participation from every segment of society," he noted.

"When we live by the principle of fraternity, we ensure that the values of justice, equality, and freedom endure for generations to come. However, the responsibility to uphold fraternity does not rest on any single individual or group. It is a shared responsibility that involves every citizen, institution, and leader in society," he said. Justice Mishra also called for a "multi-faceted approach" to promote fraternity effectively, involving collaborative efforts of lawmakers, civil society, and technology.

"Laws should be crafted not just to protect rights but to ensure social cohesion and address systemic inequalities. By prioritising these values, the legal framework of the nation can provide the foundation for a society built on fraternity," he said.

The judiciary must play a proactive role in safeguarding the principles of fraternity, the judge further said. "We can prioritise mediation and reconciliation where appropriate, write judgments that are not only legally sound but also explained in accessible language, and ensure that court procedures themselves reflect fraternal

Singh's funeral at the Nigambodh Ghat. "It was difficult to see very much, beyond the backs of the heads of assorted dignitaries and close relatives of the departed soul, so it became more of an occasion to reflect on the life and legacy of the late great PM," Tharoor said, adding that he found himself seated next to Navjot Singh Sidhu, who was a memorable companion during the proceedings.

He referred to Vajpayee's memorial, "Sadbhav Atal", which is spread over seven acres and "where memories related to Atalji are present", and shared pictures of the memorial on X.

"But during the tenure of the same Prime Minister, Narendra Modi, the last rites of former Prime Minister Manmohan Singh were performed at the public Nigambodh Ghat instead of the National Memorial. Because he was a Congress leader, not a BJP leader?" he asked in a post in Hindi on X.

After the matter of a memorial for Singh took a political colour, the Centre clarified that a decision to build one was already conveyed to Congress president Mallikarjun Kharge by Union home minister Amit Shah after Friday's Cabinet meeting. A government statement also said the funeral could be held as the process of setting up a trust and allotting land for the memorial could take a while.

Kharge had written to Modi on Friday seeking a memorial for Singh. Several sections of the society have also urged the government to confer Bharat Ratna, the highest civilian honour of the country, on the late economist-

# What awaits Moscow under Trump

President-elect Donald Trump's second term marks a policy shift from the previous Biden administration. He aims to shift Washington's focus from Europe to the Indo-Pacific to counter China's rise. Trump wants to do so by ending the Ukraine war by facilitating negotiations between Kyiv and Moscow. Further, he hopes to split the maturing Moscow-Beijing and the Moscow-Tehran partnership. The President-elect, however, has not mentioned how he plans to do so.

Despite the nature of United States (US) policy towards Ukraine likely changing under Trump, the Kremlin has reacted cautiously to his victory because Trump, despite wanting to improve relations with Moscow in his first term, was unable to do so. Second, Moscow is sceptical of Trump's ability to deliver on Moscow's demands about European security architecture. Meanwhile, Trump wants North Atlantic Treaty Organization (NATO) countries to increase their defence spending and wants to continue arming Ukraine while pursuing a ceasefire.

**Endgame in Ukraine?** 

Since the early days of his campaign, Trump has claimed that he would end the war "in 24 hours" if elected. While Trump has not outlined his plans, a few proposals have emerged from his aides. In September, Vice-Presidentelect J.D. Vance presented the plan of freezing the conflict along current lines, creating a heavily fortified demilitarised zone, offering security guarantees to Ukraine and assuring Moscow that Ukraine would not join NATO. Another plan was presented by Keith Kellogg and Fred Fleitz, former Chiefs of Staff in the National Security Council under Trump, which suggested that US military aid to Ukraine would be contingent on Kyiv negotiating with Moscow and imposing a moratorium on its NATO membership. Easing of sanctions would be contingent on Moscow's willingness to negotiate, and levies would be imposed on the revenue generated from Russian energy exports, which would be used for Ukraine's reconstruction. With the nomination of Keith Kellogg as the special envoy for Russia and Ukraine. Washington's policy approach to the war will likely reflect

While Ukrainian ruling elites are aware that the terms for ending the conflict will lead to the ceding of some territory to Russia, the official stance for negotiations remains that Russia would have to withdraw from all of the occupied territories, including Crimea, which Russia annexed in 2014. However, for Russia, the war in Ukraine is not about territory alone, as Moscow wants guarantees that Ukraine will not join NATO and remain neutral. However, outgoing US President Joe Biden granted Ukraine permission to use long-range Army Tactical Missile Systems (ATACMs), significantly escalating the conflict. Biden's last-ditch efforts to arm Ukraine, which are exacerbating the conflict, are probably driven by his desire to drag the Trump administration into continuing support for Kyiv. Ukraine currently fires AT-ACMS and Anglo-French Storm Shadow missiles into Bryansk and Kursk regions in Russia. This has led to Putin approving changes to the Russian nuclear doctrine, lowering the threshold for the use of nuclear weapons. Also in a show of determination to the West, and to reemphasise red lines and stop further escalation, Putin launched the intermediate-range ballistic missile 'Oreshnik' on an industrial plant in the city of Dnipro, Ukraine. For Putin, despite scepticism, there is some hope for marginal de-escalation in the conflict. He will also seek a dialogue with the US about European security, but Washington's position on this is unclear.

On splitting the Russia-China and Russia-Iran partnership

Trump's desire to break the Russia-China and Russia-Iran partnership may be more difficult to achieve than he anticipates. Beijing is Moscow's largest trading partner, with bilateral trade increasing from U\$\$88 billion in 2014 to U\$\$240 billion in 2024. With markets shrinking in the West because of sanctions, China has emerged as a pivotal partner to Russia, with cooperation spanning across military, economic, critical technology, energy, and other sectors. Beijing is an important stakeholder in Moscow's strategy to pivot eastwards and move its supply chains from Europe towards Asia. With the invasion of Ukraine, Moscow's reliance on China has increased further, with the Chinese yuan becoming an important reserve currency in Russia.

Despite growing asymmetry with concerns over Chinese banks not processing ruble transactions, and China complying with certain sanctions and export control regulations due to its business interests in the West, China still remains an important partner for Moscow, as both nations have shared grievances with the West. This is reflected in Russia-China cooperation within regional and plurilateral organisations like the Shanghai Cooperation Organisation (SCO) and BRICS, where both countries aim to carve out an alternative geoeconomic framework to the West. Thus, along with increasing political-economic interaction, the prospect of Moscow de-linking from China looks highly unlikely.

Similarly, in the case of Iran, the Moscow-Tehran partnership improved in the 21st century, with Russia assisting Iran in developing its nuclear energy, and with talks to expedite deliveries of advanced military platforms such as the S-400 Anti-Missile System. Since 2022, Iran has increased its supply of drones to Russia. Further, Iran is an important regional player for Moscow, as it is a critical node in the International North-South Trade Corridor, connecting Russia to the Indian Ocean. Further, Iran is an important partner in intergovernmental and plurilateral organisations like the SCO and BRICS.

Trump 2.0 a repeat of Trump 1.0?

Trump's arrival in the White House in 2016 came with the possibility of a reset in America's relationship with Russia and was thus well-received by Moscow. Still, despite the campaign promises, Moscow's hopes were unaddressed. Sanctions imposed by Trump's predecessor continued and required the assent of US congressional committees for its revocation. The first Trump administration continued to impose more sanctions against Russia, particularly on Russian energy, with the sanctioning of the Nord Stream 2 undersea gas pipeline, which aimed to transport gas from Russia to Europe via the Baltic Sea. Further, it was during Trump's first term that the US withdrew from the Intermedi-

ate-Range Nuclear Forces Treaty (INF) treaty.
For these reasons, uncertainty looms over what the future holds for Moscow under Trump 2.0. While Russia's concerns about European security remain unaddressed, it is unlikely that US sanctions on Moscow will be lifted, as certain sanctions, such as sanctions on Russian Liquefied Natural Gas (LNG), profit the US as it increases American LNG exports. Further, it is doubtful that Russia's frozen sovereign assets (worth US\$300 billion) will be unfrozen, and it is unlikely that Russia will agree to these funds being used in Ukraine's reconstruction or to pay a tax on its future energy sales to contribute to the reconstruction. Thus, while Trump may attempt to end the conflict in Ukraine by offering certain concessions to Moscow, it is unlikely that a lasting, long-term peace will be achieved in 2025. (Courtesy: ORF)

# Live -streaming has improved courtroom accountability

he judicial system has not been left untouched in a world increasingly defined by digital transparency. Courtroom live-streaming, once unthinkable due to its perceived threat to the sanctity of judicial proceedings, is now rapidly gaining momentum as a tool to enhance accountability and transparency.

At the heart of this shift is the public's demand for a justice system that can be scrutinised in real-time, one that holds judges accountable not only for their rulings but also for their conduct within the courtroom.

This article explores the transformative role live-streaming has played in shaping the way we view judicial accountability. Using recent incidents, such as the controversial remarks made by Karnataka High Court Justice V. Srishananda, we will delve into how this technological shift has highlighted the importance of judicial decorum, the potential consequences of misconduct, and the delicate balance between transparency and the judicial process.

The decision to live-stream court proceedings in India began as a response to the growing demand for transparency in the judicial process. In 2018, the Supreme Court of India, in its landmark decision in SwapnilTripathi versus Supreme Court of India, held that live-streaming was a fundamental right of access to justice under Article 21 (Protection of Life and Personal Liberty) of the Constitution

The court observed that transparency was a vital component of judicial accountability and that live-streaming could enhance the quality of judicial conduct.

Moreover, in the case of NareshShridharMirajkar versus State of Maharashtra and Ors. the court held that "courts must take the aid of tech to enhance open court move beyond physical accessibility to virtual accessibility".

The Supreme Court, in the case of Supt. and Remembrancer of Legal Affairs versus SatyenBhowmick (1981), reaffirmed the requirement of "in-camera proceedings" wherever needed from time to time.

These decisions ushered in a new era for the Indian judiciary, where the concept of 'open courts' was no longer limited to the physical confines of a courtroom. Judicial proceedings became accessible to the broader public, embodying transparency in its

For many, this was a welcome change, offering citizens the chance to witness the judicial process firsthand. But with increased visibility came increased scrutiny— not just of the rulings handed down, but of the language of the judges themselves.

Justice V. Srishananda's contro-

versial remarks serve as a case study of the perils of live-streaming courtroom proceedings. During a hearing, he referred to a Muslim-dominated area in Bengaluru as "Pakistan", a communal and inflammatory comment that sparked outrage.

In another instance, he made gender-biased remarks toward a female advocate in a matrimonial dispute, revealing deep-seated biases that had no place in a court of law. These incidents, captured on camera and circulated widely, put judicial conduct in the spotlight, raising serious questions about how judges are held accountable for their words and actions.

What made these incidents even more troubling was not just the nature of the comments but the lack of immediate accountability. Had these remarks not been captured on live-stream, they might have gone unnoticed or been minimised. The very fact that the public could witness these incidents in real time forced the judiciary to confront the reality that the conduct of judges is now open to widespread scrutiny.

Justice Srishananda's actions were not just personal missteps, they became a reflection of a larger issue within the judiciary— an issue of unchecked authority and a lack of accountability. Judges occupy a unique position in society. They are entrusted with the immense responsibility of upholding the rule of law and dispensing justice fairly and impartially.

As such, their conduct inside the courtroom must be beyond reproach. The introduction of livestreaming into courtrooms has only heightened this expectation, as every word, gesture and action is now subject to public observa-

Judicial decorum— the professional and respectful behaviour expected of judges— is not merely a formality. It is a safeguard for the integrity of the judicial process. When judges allow their biases to seep into their conduct, whether through gendered comments or communal remarks, they compromise the very notion of impartiality. And in the age of live-streaming, these compromises are no longer hidden behind the closed doors of a courtroom—they are exposed for all to see.

In Justice Srishananda's case, his remarks damaged the credibility of the judiciary and cast doubts on the impartiality of the proceedings he presided over. His comments about a Muslim-majority area being akin to "Pakistan" were not only insensitive but also reflected a communal bias that could influence his decision-making.

Similarly, his gendered comments toward a female advocate revealed an inherent lack of respect for women in the legal profession, further eroding trust in the system.

While hearing a case suomotu, former Chief Justice of India D.Y.



Chandrachud remarked, "The answer to sunlight is more sunlight. Not to suppress what happens in the court. This is a very important reminder to everyone. The answer is not to close doors and shut

Underscoring the importance of transparency in judicial proceedings. He argued that live streaming of court cases should continue despite controversies surrounding judges' comments, emphasising that suppressing information is not the solution. This statement serves as a vital reminder of the judiciary's responsibility to maintain openness and accountability in a democratic society.

He also emphasised that the controversies created due to the circulation of objectionable remarks made by judges cannot be a reason to shut down the livestreaming of court proceedings.

The statement was made in response to advice from Attorney General R. Venkataramani and Solicitor General Tushar Mehta to hold a judicial proceeding in-house to prevent misrepresentation of remarks on social media.

In the related incident, the Supreme Court objected to remarks made by Justice V. Srishananda of the Karnataka High Court and expressed that no part of India should be referred to as Pakistan because that is fundamentally contrary to the territorial integrity of the nation.

Justice Srishananda later expressed regret for his comments, clarifying that he did not intend to offend any community or members of the Bar. The Supreme Court Bench accepted his apology but also issued strong observations regarding the need for judges to refrain from making casual, misogynistic or prejudicial remarks.

In this digital age, where court proceedings are widely reported, the Bench emphasised the importance of judges acting with care and caution in their statements.

The consequences of such misconduct extend beyond the individual judge. They impact public perception of the judiciary as a whole. Judges are meant to be impartial arbiters of justice, and when they display bias, whether through

their rulings or their conduct, they undermine public confidence in the legal system.

The live-streaming of Justice Srishananda's remarks brought this issue to the forefront, as the public could witness firsthand the prejudices at play in a court of law. The widespread dissemination of these videos on social media further fuelled public outrage, with many calling into question the impartiality of the judiciary. When the public loses faith in the fairness of the legal system, it erodes the very foundation of democracy.

This incident also highlighted the lack of immediate mechanisms to hold judges accountable for their conduct. While there are disciplinary processes in place for judicial misconduct, they are often slow and opaque, leaving the public with little recourse when judges act inappropriately.

In the case of Justice Srishananda, his eventual apology came only after the Supreme Court took suomotucognisance of the incident, illustrating the reactive nature of judicial accountability.

The introduction of live-streaming has fundamentally altered the way the public interacts with the judiciary. Previously, courtroom proceedings were confined to the physical audience present in the courtroom, limiting the scope of public scrutiny. Now, with live-streaming, the judiciary is under constant observation, with every decision and every comment subject to real-time critique.

While some may argue that livestreaming puts undue pressure on judges, it is important to recognise that this transparency is essential for ensuring accountability. The power wielded by judges is immense, and with that power comes the responsibility to maintain the highest standards of conduct. Livestreaming ensures that judges are held to these standards, as their actions are now visible to a much larger audience.

Moreover, live-streaming has the potential to democratise access to justice. In a country as vast and diverse as India, many citizens are unable to attend court proceedings in person.

Live-streaming allows them to engage with the judicial process in

a way that was previously impossible. It offers a window into the workings of the legal system, fostering a greater understanding of and respect for the rule of law.

While live-streaming offers significant benefits in terms of transparency and accountability, it also poses challenges. One of the primary concerns is the potential for judicial proceedings to become sensationalised.

In a media landscape that thrives on controversy, there is a risk that live-streamed court cases could be reduced to sound bites, with complex legal arguments oversimplified for the sake of public consumption.

Additionally, live-streaming raises concerns about the impact on the integrity of the judicial process. Judges may feel pressured to cater to public opinion or avoid making controversial decisions for fear of backlash. This could lead to a chilling effect, where judges become overly cautious in their rulings, prioritising public perception over the merits of the case.

To mitigate these risks, it is crucial to strike a balance between transparency and the integrity of the judicial process. Live-streaming should be seen as a tool for enhancing accountability, not as a means of turning the courtroom into a spectacle. Judges must be given the space to make independent decisions, free from undue external pressures, while still being held accountable for their conduct.

The introduction of live-streaming into Indian courtrooms has undoubtedly changed the way we view judicial accountability. Incidents such as Justice Srishananda's controversial remarks have highlighted the importance of judicial decorum and the need for greater transparency in the legal system.

Live-streaming offers a powerful tool for holding judges accountable, but it also poses challenges that must be carefully navigated.

As the judiciary continues to adapt to the digital age, it is essential to ensure that transparency does not come at the expense of the integrity of the judicial process. Judges must uphold the highest standards of conduct, and when they fail to do so, they must be held accountable— not just by their peers, but by the public as well.

Live-streaming has opened the doors to a more transparent and accountable judiciary, but with this increased visibility comes the responsibility to ensure that justice is not only done but seen to be done.

Hence, live-streaming is an irreversible trend, increasing scrutiny of judges' actions. As a result, any misconduct will be more readily exposed and criticised, necessitating judges to uphold high standards of behaviour consistently, regardless of whether their actions are being filmed. ## Trump's threat of a tariff wall has grave economic implications

onald Trump is threatening to use tariffs as a weapon against other countries. He has already made three threatening statements: first, he threatened the BRICS countries that if they dared to move away from the dollar, then they would have to face 100 percent tariff in the US market. Second, he has threatened the European Union that unless the EU bought more American oil and gas as a means of reducing its trade surplus vis-à-vis the US (the surplus on goods trade was \$208.7 billion in 2023), it would face high tariffs in the US market. Third, he has announced that there will be a 10 percent tariff anyway on global imports into the US and a 60 percent tariff on Chinese goods. (China had a \$279.4 billion surplus on goods trade vis-à-vis the US in 2023, which was lower than earlier, e.g., the \$418 billion surplus in 2018, but quite substantial nonetheless).

Each of these proposed measures has important economic implications. For instance, while EU's replacing its residual reliance on Russian gas by the purchase of American gas may not lead to cost escalation within EU, it will certainly raise gas prices within the US; in fact it has been estimated that US gas prices will rise by as much as 30 percent in such an eventuality. Trump's response to this has been to say that gas production will be raised within the US to cope with the increased demand for it. But raising gas production requires investment, and that too private investment in the US, which cannot be ordered to happen. Besides, given the environmental damage associated with oil and gas, and hence the general commitment to move away from them, such investment may not actually occur; and even if it does, the environmental concerns will only become more acute. Likewise, if 100 percent tariffs are levied on BRICS countries, they would certainly retaliate, whose effects can be quite serious for American exports.

All this, however, is still in the realm of mere possibilities; what is more certain is the 10 percent tax on global imports and the 60 percent tax on imports from China; and I would like to discuss one obvious impact they would have on the world economy. Let us assume that such tariffs do not lead to any retaliation by other countries (and if they do, then this fact will only modify the argument presented below, not negate the thrust of it). They would however increase the demand for American goods within the US which should raise the level of output and employment within that country. In fact Trump has been complaining that while Americans buy large numbers of European cars, the reverse is not true; the imposition of tariffs on European cars will increase the demand for American cars within the US and hence raise their production (and employment in that industry).

industry). As against this, however, the rise in the cost of living because of tariffs on imported goods, will reduce purchasing power in the hands of the consumers which will have an employment-contracting effect, that would be even more pronounced if the Trump administration undertakes anti-inflationary "austerity" measures to counter the rise in prices. But let us assume, as is more likely, that there would be a net increase in employment and output in the US because of this tariff measure of Trump.

In the rest of the world, however, by the same token the loss of American markets would reduce employment in the absence of any counteracting measures to boost demand. The US in such a case would simply have exported its unemployment to the rest of the world; it would have pursued through tariff measures a beggarthy-neighbour policy towards the rest of the world. True, the rest of the world would not be affected adversely if there is a boost to its domestic demand through the pursuit of an expansionary fiscal policy (monetary policy for expansion is a blunt instrument); but this is not possible in economies other than China.

Such an expansionary fiscal policy must take the form of either a larger fiscal deficit, or heavier taxes on the capitalists, and the rich in general, who save a large proportion of their incomes; taxing the working people who consume the bulk of their incomes anyway and using such tax proceeds for boosting government expenditure would only change the composition of aggregate demand (less working people's consumption and more government spending), but not its magnitude. But such fiscal measures as would actually increase the magnitude of aggregate demand are precisely the ones that international finance capital opposes; it opposes fiscal deficits beyond a stipulated limit (typically 3 percent of the GDP) and it obviously opposes any taxes on the rich, for such taxes fall heavily on the financiers themselves. An economy pursuing such demandboosting measures, therefore, becomes a victim of capital flight and hence gets destabilised, which is why such fiscal expansion cannot occur within a neoliberal regime characterised by the hegemony of globalised finance.

Even if the imposition of tariffs by the US entails a certain shift away from neoliberalism, the essence of such a regime consists in the free cross-border movement of capital, especially of finance, and no compromise on this score will be tolerated by international finance capital; in fact it is signifi-

the cant that Trump, while champiued oning protectionism has not said a
word in favour of capital controls.
The absence of capital controls exposes countries to the threat of
capital flight in the event of fiscal
expansion which they would,
therefore, like to avoid.

The case of China, however, is altogether different. In fact, successive US administrations have been protecting the US market from the entry of goods produced in China for quite some time, as is evident from the decline in China's goods trade surplus vis-à-vis the US mentioned earlier. China has managed to counter to a great extent this loss of the American market by expanding its domestic market.

The reason China has been able to do this, while other countries cannot, is because China, notwithstanding all the "liberalisation" it has undertaken, still remains essentially a "command economy" where the political leadership's writ runs in economic matters: there is a substantial presence of public sector, and generally noncapitalist, enterprises in the Chinese economy, whose investment decisions, and even wage policy, can be influenced by the govern-Indeed it is not surprising that even as there has been a general

even as there has been a general stagnation in real wage-rates over much of the world, including in the countries of the global north, China has seen increases in real wages as a result of government directives. The expansion of the domestic market in China, therefore, is not constrained by the dictates of international finance capital, unlike in the case of capitalist countries.

Hence, leaving aside China, where the effects of American protectionism can in principle be countered, the rest of the world would see an aggravation of recession because of it (unless it moves

away from a neoliberal regime) This effect will be particularly sharp in countries of the global south. The Bretton Woods institutions that remain silent in the face of trump's protectionism will lecture to countries of the global south about the virtues of free trade and prevent them from adopting any protectionist policies of their own; at the same time they would be made to adhere strictly to "fiscal deficit norms" while avoiding any heavier taxation of the rich (so as not to disincentive capital inflows). They would, therefore, be made to face American protectionism meekly and bear the brunt not only of the recessionary tendency it would generate but also of a drying up of capital inflows into their shores for relocating plants for producing export goods.

The accentuation of the recessionary tendency in the rest of the world would also entail a further strengthening of the neo-fascist tendency that is currently sweeping the world.

Since neo-fascism gets a boost because of the alliance between corporate capital and the neo-fascist elements in a period of economic crisis, any aggravation of crisis will only lead to a further strengthening of the neo-fascist tendency, of the "othering" of some hapless minority group in each such crisis-affected country in an attempt to divert the discourse away from issues of material life.

Rosa Luxemburg's statement that the development of capitalism ultimately leads to a denouement where mankind is presented with a choice between socialism and barbarism is thus coming true with a vengeance. The dead-end of neoliberal capitalism, which is the latest phase of capitalism, is bringing mankind to a situation of pervasive and barbaric neo-fascism, from which only a transition to socialism, effected in stages, can provide a way out. ## Singapore 2024: A new prime minister in saddle, city-state elevates ties with India

SINGAPORE, Dec 28: After two decades, the baton changed hands in the city-state in 2024, a planned transition to the fourth generation of People's Action Party politicians. Ties with India were elevated this year.

Economist Lawrence Wong, 51. succeeded Prime Minister Lee Hsien Loong, 72, who relinquished his position in May after holding the office since 2004. Both belong to the ruling party that has been driving Singapore's economic progress for more than five decades.

As India and Singapore celebrate 60 years of diplomacy in 2025, the two countries elevated their bilateral relations to a Comprehensive Strategic Partnership during the visit of Prime Minister Narendra Modi in September.



## Airstrike on insurgents mistakenly killed 10 civilians, Nigerian military says



DAKAR (Senegal), Dec 28: An airstrike targeting an armed group in northwestern Nigeria mistakenly killed at least 10 civilians, the West African nation's military said Friday.

The villagers were killed on Christmas Day when the air force targeted a logistics base of the Lakurawa insurgent group in the Silame area of Sokoto state, Edward Buba, Nigerian defense spokesperson, told journalists at a press conference. On Thursday, the Sokoto state government said the air force mistakenly shelled the villagers in the early hours of Wednesday in an

attempt to dislodge the insurgents from the area. However, on Friday, Buba said only that the Lakurawa insurgents were directly hit by munitions and that the civilians died from "sec-

ondary explosions". The Lakurawa insurgent group began infiling a wave of coups that disrupted Nigeria's relations with neighbouring Niger, Mali and Burkina Faso, hurting their ability to cooperate on transnational threats.

Initially gaining local support by helping communities defend themselves against armed cattle rustlers, the group later sought to impose strict Islamic laws across border communities of the French-speaking countries.

Airstrikes on civilians happen frequently in the country. Last year, at least 85 civilians were killed when an army drone attack erroneously targeted a religious gathering in northwest Nigeria.

Since 2017, some 400 civilians have been killed by such accidental strikes by the military, according to the Lagos-based SBM Intelligence

Before the Lakurawa insurgents, Nigeria had been battling Boko Haram in the northeastern part of the country. Boko Haram launched an insurgency in 2009 to establish its radical interpretation of Islamic law, or Sharia, in the region.

The group has since splintered into different factions, together accounting for the deaths of at least 35,000 people and the displacement of more than 2 million, as well as a humanitarian crisis with millions of people in dire need of

## Israeli airstrikes hit Yemen airport as jet with hundreds onboard was landing, UN official says

UNITED NATIONS, Dec 28: Israeli airstrikes hit Yemen's main airport as a civilian Airbus 320 with hundreds of passengers on board was landing and a UN delegation was waiting to leave, the UN's top

humanitarian official in Yemen said Friday. Julien Harneis told UN reporters that the most frightening thing about the two airstrikes on Thursday wasn't their effect on him and about 15 others in the VIP lounge at the international airport in Yemen's capital, Sanaa, including the head of the UN World Health Organisation.

Rather, it was the destruction of the airport control tower as a Yemenia Airways plane was taxiing in after touching down.

"Fortunately, that plane was able to land safely and the passengers were able to disembark, but it could have been far, far worse," said Harneis, who was with WHO Director-General Tedros Adhanom Ghebreyesus in the lounge. He said one airstrike landed approximately 300 metres (330 yards) south of the VIP lounge and another about 300 metres to the north around 4:45 pm, while about five members of the UN team were outside the building.

"Not only obviously did we have zero indication of any potential airstrikes, but we cannot remember the last time there were airstrikes in Sanaa during daylight hours," Harneis said in a video news conference from Sanaa. The UN said at least three people were killed and dozens injured in the strike. Among the injured was a crew member from the UN Humanitarian Air Service, which was about to fly the JN delegation of some 20 people out of Sanaa.

He suffered a serious leg injury from shrapnel and

Immediately after the airstrikes, Harneis said, UN security officials moved the delegation out of the VIP building and into five armoured cars where they waited for approximately 40 minutes to ascertain what happened and help the injured crew member.

He was taken to a hospital in Sanaa and underwent four hours of surgery while the rest of the delegation spent the night in a UN compound, Harneis said. The UN plane with Tedros and the UN team, including the injured crew member, was able to depart for Jordan on Friday afternoon - without an operating control tower. The United Nations said the injured crew member was taken to a hospital in Jordan, and Tedros was heading back to Geneva, where WHO is based. Yemen's Iran-backed Houthi rebels, who control Sanaa and much of the country's north, have gone after Israel since it started attacking Gaza following the Oct 7, 2023 attacks by Gaza's Hamas militants on southern Israel. The Houthis have attacked ships in the Red Sea, disrupting one of the world's main maritime routes, and recently stepped up missile and drone attacks on Israel.

Israel has escalated its response.

The Israeli army said it wasn't aware that the WHO chief or UN delegation were at the Sanaa airport on Thursday. Israel said it bombed the airport because it is used by the Houthis and Iran. Harneis responded, stressing that the airport is civilian, not military, and is used for transporting UN and other humanitarian workers, and for one civilian flight -Yemenia to and from Amman, Jordan. The flight operates as a result of an international agreement, and thousands of Yemenis have used the flight to get ad-

### **Canadian Cabinet ministers meet with** Trump's nominee for commerce secretary

TORONTO, Dec 28: Two Canadian Cabinet ministers left a meeting at Mar-a-Lago on Friday without assurances President-elect Donald Trump will back away from threatened tariffs on all products from the major American

The Canadians called the talks "productive" and said there would be further discussions but one official said the Americans remain fixated on the US trade deficit with Canada. Finance Minister Dominic LeBlanc and Foreign Minister Mélanie Joly met with Howard Lutnick, Trump's nominee for commerce secretary, as well as North Dakota Governor Doug Burgum, Trump's pick to lead the Interior Department.

Trump has threatened to impose 25% tariffs on all Canadian products if Canada does not stem what he calls a flow of migrants and fentanyl into the United States even though far fewer of each cross into the US from Canada than from Mexico, which Trump has also threatened.

"Minister LeBlanc and Minister Joly had a positive, productive meeting at Mar-a-Lago with Howard Lutnick and Doug Burgum, as a follow-up to the dinner between the Prime Minister and President Trump last month," said Jean-Sébastien Comeau, spokesman for LeBlanc.

Comeau said both ministers outlined the measures in Canada's billion-dollar plan to increase security at the border and reiterated "the shared commitment to strengthen border security as well as combat the harm caused by fentanvl to save Canadian and American lives." Comeau said Lutnick and Burgum agreed to relay the information to Trump.

A senior Canadian official, however, said the Americans remain preoccupied on the US trade deficit with Canada and want it to shrink. The official spoke on condition of anonymity as they were not authorised to speak publicly on the matter. Trump has made an issue of the US trade deficit, erroneously calling it a subsidy.

Canada's ambassador to Washington, Kirsten Hillman, has said the US had a \$75 billion trade deficit with Canada last year. But she noted a third of what Canada sells into the US are energy exports and said there is a deficit when oil prices are high.

About 60% of US crude oil imports and 85% of US electricity imports are from Canada. Alberta



alone sends 4.3 million barrels of oil per day to the US which tends to consume about 20 million barrels a day. The Trump transition team did not immediately respond to a message seeking comment.

Further discussions are expected in the coming weeks. Joly will also have dinner with US Senator Lindsey Graham on Friday.

Trump has been trolling Prime Minister Justin Trudeau on social media in recent weeks by calling him the Governor of the 51st state.

Trudeau has not directly responded, but did post a link Thursday to a six-minute video on YouTube from 2010 in which American NBC journalist Tom Brokaw "explains Canada to Americans." "Some information about Canada for Americans" Trudeau wrote in the post on X.

The video, which originally aired during the 2010 Vancouver Olympics, explains similarities between the two countries, the massive trading relationship and the actions of the Canadian military in World War 2 and Afghanistan.

"In our darkest hours Canada has been with us," Brokaw says in the video. "In the long history of sovereign neighbours there has never been a relationship as close, productive and peaceful as the US and Canada." Trudeau has told Trump that Americans would also suffer if the president-elect follows through on a plan to impose sweeping tariffs on Canadian products.

Nearly \$3.6 billion Canadian dollars (\$2.7 billion) worth of goods and services cross the border each day. Canada is the top export destination for 36 US states. Flows of migrants and seizures

of drugs are vastly different at the US' two land borders. US customs agents seized 43 pounds of fentanyl at the Canadian border during the last fiscal year, compared with 21,100 pounds at the Mexican border. Most of the fentanyl reaching the US — where it causes about 70,000 overdose deaths annually — is made by Mexican drug cartels using precursor chemicals smuggled from Asia.(AP)

# Janet Yellen tells Congress US

WASHINGTON, Dec 28: US Treasury Secretary Janet Yellen said her agency will need to start taking "extraordinary measures," or special accounting maneuvers intended to prevent the nation from hitting the debt ceiling, as early as January 14, in a letter sent to congressional leaders Friday

"Treasury expects to hit the statutory debt ceiling between January 14 and January 23," Yellen wrote in a letter addressed to House and Senate leadership, at which point extraordinary measures would be used to prevent the government from breaching the nation's debt ceiling which has been suspended until Jan 1,

The department has in the past deployed what are known as "extraordinary measures" or accounting maneuvers to keep the government operating. But once those measures run out the government risks defaulting on its debt unless lawmakers and the president agree to lift the limit on the US government's ability to borrow.

"I respectfully urge Congress to act to protect the full faith and credit of the United States," she said.

The news comes after President Joe Biden signed a bill into law last week that averted a government shutdown but did not include President-elect Donald Trump's core debt demand to raise or suspend the nation's debt limit. The bill was approved by Congress only after fierce internal debate among Republicans over how to han-

After a protracted debate in the summer of 2023 over how to fund the government, top White House official has said. licymakers crafted the Fiscal Responsibility Act, which included suspending the nation's \$31.4 trillion borrowing authority until Jan 1, 2025.

Notably however, Yellen said, on Jan 2 the debt is projected to temporarily decrease due to a scheduled redemption of nonmarketable securities held by a federal trust fund associated with Medicare payments. As a result, "Treasury does not expect that it will be necessary to start taking extraordinary measures on January 2 to prevent the United States from defaulting on its obligations," she said.

The federal debt currently stands at roughly \$36 trillion — which ballooned across both Republican and Democratic administrations. And the spike in inflation after the coronavirus pandemic pushed up government borrowing costs such that debt service next year will exceed spending on national security.

Manmohan Singh put US-India relations on 'fundamentally new footing': Condoleezza Rice

mer prime minister Manmohan Singh was a great leader who helped to put US-India relations on a "fundamentally new footing" with the landmark Civilian Nuclear Agreement between the two nations, former US Secretary of State

Condoleezza Rice has said. Singh, who was India's prime minister for 10 years from 2004 to 2014 died in New Delhi on Thursday night. He was 92.

"I am very saddened to learn of the passing of India's former Prime Minister Manmohan Singh - a great man and a great leader who helped to put US-Indian relations on a fundamentally new footing with the landmark US-India Civilian Nuclear Agreement of 2008," Rice said in a post on X on Friday.

Rice, 70, was Secretary of State from 2005 to 2009 and before that she served as the National Security Advisor from 2001 to 2005, both under the then President George W Bush. Those eight years are seen as years that transformed the India-US relationship, in particular the

landmark civil nuclear deal that was initiated jointly by Singh and

"Prime Minister Singh risked his political future and then remade his government to gain the support needed to secure a deal that would ultimately change the geopolitical trajectory of the region and have far-reaching implications for decades to come. I extend my deepest condolences to the people of India for this great loss – may he rest in eternal peace," Rice said.

Meanwhile, Indian American Congressman Raja Krishnamoorthi also mourned Singh's death. Singh "played a key role in both

modernising India's economy and strengthening ties with the United States. His vision for a better India and a better world will continue,' Krishnamoorthi said in a statement. In a post on X, Gita Gopinath.

### Huge cache of weapons recovered in Arunachal's Changlang

DIBRUGARH, Dec 28: Security forces recovered huge cache of weapons near MS 27 along Miao-Vijaynagar axis in Arunachal Pradesh's Changlang district.

The joint operation was carried out under Spear Corps by Assam Rifles, Army and local police involved extensive search efforts by specialized teams, supported by advanced technology such as high technology drones, tracker dogs and metal detectors.

"During the operation, a total of ten MQ 81 Chinese origin Assualt Rifles/ Type 81 Aslt Rifles were re-covered from different locations around MS27, making it one of the largest recoveries in South Arunachal in recent past. The weapons were concealed inside forest area," said an official of Army.

He said, "These weapons were being searched by major insurgent groups operating in Changlang district for more than six months."

It is alleged that these weapons were buried by ENNG before their surrender last vear.

The security forces utilizing their expertise and reliable intelligence have managed to uncover the hidden cache in thickly forest area.

"Prior to conduct of operation, the security personals ensured safe passage to the tourists present in Namdapha Reserve Forest for bird sighting. The operation was carried out with the utmost professionalism and precision, ensuring that huge cache of weapons didn't fall in the hands of insurgents," the official said. ### Sarpanch's murder: Huge protest in Beed; even Mahayuti MLAs demand Dhananjay Munde's ouster



BEED, Dec 28: Thousands of people gathered in Maharashtra's Beed city on Saturday to protest against the brutal murder of Massajog sarpanch Santosh Deshmukh as even MLAs from ruling parties demanded the sacking of NCP minister Dhananjay Munde.

Maratha quota activist Manoj Jarange, Chhatrapati Sambhaji of the Kolhapur royal family, local BJP MLAs Suresh Dhas, Abhimanyu Pawar; NCP MLA Prakash Solanke and NCP (SP) MLAs Jitendra Awhad and Sandeep Kshirsagar participated in the `aakrosh morcha' or protest march.

The protesters demanded arrest of Walmik Karad, an associate of Dhananjay Munde, a politician from Beed district.

Santosh Deshmukh was abducted and tortured to death on December 9. While four persons have been arrested, Opposition leaders claimed in the state legislature during the winter session that Walmik Karad was the mastermind of the murder.

Karad, named as an accused in a related case of extortion, is still at large.

Vaibhavi Deshmukh, the daughter of the deceased sarpanch, demanded justice for her father said he visited Ganderbal to ensure that people during the protest. He lost his life while saving a person from the Dalit community, she said.

Abhimanyu Pawar, who was

earlier an aide of chief minister Devendra Fadnavis before he became MLA from Ausa in neighbouring Latur district, said the pain caused by Deshmukh's murder was felt in different parts of Maha-

"Even if I am part of the (ruling) dispensation, I want to tell the government that if the accused are not arrested, protests will reach other parts of the state. We want justice for the family of Santosh Desh-

BJP MLA Dhas alleged that Munde, the Food and Civil Supplies Minister, won assembly election from Parli in Beed district with the help of bogus votes.

The Nationalist Congress Party to which Munde belongs is part of the ruling BJP-led Mahayuti coalition. NCP MLA Prakash Solanke said some of the accused were still at large even 19 days after the murder, and Walmik Karad too had not been arrested.

"Dhananjay Munde was the guardian minister of Beed for four of the last five years. Munde needs to be sacked. Until the accused are convicted, Munde should be sacked so that there is an impartial probe," Solanke said.

The Majalgaon constituency which he represents has collected ₹ 40 lakh for the Deshmukh family, he informed.

Quota activist Jarange said the Maratha community will not keep quiet till the deceased, who belonged to the Maratha community,

"If the CM does not want this protest to spread to other parts of the state, the accused should be arrested and action should be taken against those who are supporting them. There is suspicion that the government is shielding the accused," Jarange said.

The Shiv Sena (UBT) demanded resignations of both Dhananjay Munde and his cousin, BJP minister Pankaja Munde.

According to police, Deshmukh was prima facie killed because he opposed an extortion bid targeting a windmill company in Beed dis-

Local NCP leader Vishnu Chate allegedly demanded ₹ 2 crore from the company. Deshmukh tried to intervene, leading to his abduction, torture and murder. Chate is among the four arrested accused. (PTI)

## Farmers resisting Dallewal's hospitalisation not well-wishers, says SC

Supreme Court on Saturday came down heavily on the Punjab government for not shifting farmer leader Jagjit Singh Dallewal, who has been fasting for over a month, to a hospital even as it doubted the intention of the agitating farmers for resisting availability of medical aid to their septuagenarian leader.

In an unprecedented hearing, a vacation bench of Justices Surya Kant and Sudhanshu Dhulia, however, gave the Punjab government time till December 31 to persuade Dallewal to shift to a hospital, giving it the liberty to seek logistical support from the Centre, if the situation warrants

Expressing helplessness, the Punjab government said it is facing huge resistance from the protesting farmers who have encircled Dallewal and are preventing him from being taken to a hospital.

The bench told Punjab Advocate General Gurminder Singh, "Who has allowed all this to happen? Who has allowed this fort to be constructed? How did this manpower reach the protest site periodically and systematically? We don't want to say much as it will aggravate the situation. So long as the gathering is there for the purpose of demands raised by farmers, it is understand-

Justice Surya Kant added, "Peaceful agitation for the purpose of raising their demands, and voicing their grievances in a democratic manner is understandable. But gathering of farmers to prevent a person from shifting to the hospital, who requires immediate medical aid, is something which is completely unheard of."

Justice Kant told Singh perhaps it appears to the court that the state government itself does not want Dallewal to receive any medical

"If there is resistance to a lawful action, you will have to deal with it the way the law enforcement agencies normally do. What appears to be the scenario is that Dallewal is refusing despite the fact that his health is not supporting him as he appears to be under some kind of peer pressure.

The bench also spoke to Punjab chief secretary and director general of police and said the court does not expect the state government to use unwanted force on the protesting farmers, but the officers on the ground are a better judge of the situation and they need to see what strategy needs to be adopted.

When Justice Dhulia sought suggestions on possible solutions to the ssue, Singh said, "There is either conciliation or confrontation. Conciliation we have suggested. We have placed the letter of Dallewal that in case the Central government negotiates with the farmers, he will be persuaded to take medical intervention.'

Justice Kant said the court also understands the political equation between the state government and the Centre, but right now the priority of the court is to provide medical aid to Dallewal

"Don't try to put words in our mouth. We are aware of the political situation. This is a constitutional court and no pre-condition is acceptable to us," Justice Kant told the Punjab advocate general.

Dallewal has been on an indefinite fast at the Khanauri border point between Punjab and Haryana since November 26 to press the Centre to accept farmers' demands, including a legal guarantee of minimum support price for crops.

Farmers under the banner of Samyukta Kisan Morcha (Non-Political) and Kisan Mazdoor Morcha have been camping at Shambhu and Khanauri border points between Punjab and Haryana since February 13 after their march to Delhi was stopped by security

## Heavy snowfall disrupts life in Kashmir

Flights, rail services suspended, Jammu-Srinagar highway closed

SRINAGAR, Dec 28: Normal life was thrown out of gear in Kashmir on Saturday as most areas of the valley received snowfall, disrupting flight and railway operations and also leading to the closure of the Srinagar-Jammu National Highway, officials said.

Moderate to heavy snowfall was recorded across Kashmir since Friday, including the season's first snowfall in Srinagar city and other plain areas of the valley.

In south Kashmir, heavy to very heavy snowfall was recorded in the plains, while central Kashmir's plains received moderate snowfall.

The plains of north Kashmir received light to moderate snowfall,

the officials said. Srinagar recorded about eight inches of snow, while neighbouring Ganderbal recorded about seven inches. Sonamarg, a famous tourist destination, recorded around eight inches of snow, the

officials added. The Zojila axis along the Srinagar-Leh highway received about 5 inches of snow, they said. Areas in Budgam district received 7-10 inches of snow, while the plains in Anantnag district recorded around 17 inches.

The upper areas of the south Kashmir district received over two feet of snow, the officials said.

The tourist town of Pahalgam recorded 18 inches of fresh snow-

Areas in Pulwama district recorded 10-15 inches of snow, while neighbouring Kulgam received 18-25 inches and Shopian recorded around 18 inches of snowfall, the officials added.

In Bandipora district of north Kashmir, the plains recorded four inches of snow, while the higher reaches, including Gurez, received 6 to 10 inches of snowfall.

Areas in Baramulla district recorded 4-9 inches of snow, while the famous ski resort of Gulmarg



the officials said.

Kupwara plains received 1-2 inches of snow, and its upper reaches recorded 2-3 inches.

Even though the snowfall was welcomed by locals and tourists, it threw normal life out of gear.

The Jammu-Srinagar National Highway (NH-44) was closed for traffic due to snow, the Traffic Department officials said.

They added that clearance work was being hampered due to heavy snowfall at the Navyug Tunnel.

Men and machinery are on the job, and commuters are advised to avoid travel until the weather improves and the road is cleared, the officials said.

Train services on the Banihal-Baramulla section were suspended due to heavy snow accumulation on the track, the railway officials said. Efforts to clear the track are underway, they added.

Air traffic to and from Srinagar was also affected as flight operations at the airport were suspended due to snowfall, the airport officials said.

"Due to bad weather conditions, all flights at Srinagar Airport have been cancelled. No flight operations could take place at the airport since the morning owing to the inclement weather," officials added.

The snowfall also affected power supply in several areas of the valley, the officials said. Jammu and Kashmir Chief Minister Omar Abdullah was monitoring the situation.

"In Kashmir region, 41 feeders at the 33 KV level and 739 feeders at the 11 KV level are down. None at the 132 KV or 220 KV levels. Restoration work is underway, and more than 90 per cent of feeders are expected to be up and functional by evening today. I'm in regular touch with the PDD team to monitor the situation," Abdullah said in a post on X.

Kashmir University postponed all its examinations scheduled for Saturday due to the inclement weather. Fresh dates for the postponed exams will be notified separately, the University said. (PTI)

### Patna administration offers to facilitate Transperson appointed as guest protestors' meeting with BPSC



administration on Saturday said it has made an offer to the candidates, demanding cancellation of the Bihar Public Service Commission (BPSC) examination held on December 13, to facilitate a meeting with it so that they could put forth

their grievances. The candidates, seeking cancellation of the 70th Integrated Combined Competitive Examination (CCE), 2024, under the BPSC over allegations of question paper leak have been protesting for more than a week.

The protestors would be required to nominate five of their representatives for talks after which the BPSC would take a decision 'within a reasonable time", Patna District Magistrate (DM) Chan-

"The district administration has offered the protesting aspirants to give a list of the representatives (all of them examinees) so that we can facilitate their meeting with the BPSC authorities over the issue,' the DM told PTI on Saturday.

"They can apprise the commission's officials of their grievances in the meeting. The district administration also assures the protesting aspirants that the commission would take appropriate decisions or a stand within a reasonable time," Singh said.

The commission is an independent body and it is free to make decisions on its own, he said.

The BPSC had decided to cancel the preliminary examination held at Bapu Pariksha Parisar centre only group of unruly aspirants. The reexamination will be held on January 4 at some other centre in the

The protestors have been sitting on dharna at Gardani Bagh for several days. They contend that cancellation should be ordered across the board since re-examination for just one centre would go against the principle of "level playing field".

Meanwhile, the Patna Police have issued notices to certain people, associated with coaching institutes, and sought clarification over allegedly instigating the protesting aspirants and delivering provocative speeches while addressing students at Gardani Bagh, the dedicated site for organising protests in the city.

'Yes, notices have been served to them by the Patna Police in this regard. They have been asked to appear before the police at Gardani Bagh police station today... they need to produce evidence regarding the allegations they levelled against government authorities while addressing protesting aspirants," the

"The police have already registered an FIR in this regard," he

The DM, however, refused to divulge the names of those people who have been asked to appear before the police. (PTI)

Noting that she received support from her parents, which helped her reach this stage, Pujar said her family comes from an agricultural background, and her parents educated her to achieve in life. "The faculty at the university also supported me when

I was admitted and studying for my MA. I like teaching and want to pursue a PhD and become a professor. I want transgenders to pursue education," Pujar said.

According to university officials, out of the thirty candidates who applied for the post, she had the necessary qualifications and good marks, and she performed well in the lecture, which led to her selection by the committee. This, they said, is likely the first such appointment at a university in the state, with Pujar serving as an inspiration for more trans persons to get educated and reach prominent positions in society. 

## ANUPAM KHER, HANSAL MEHTA CLASH OVER 'THE ACCIDENTAL PRIME MINISTER' POST MANMOHAN SINGH'S DEATH



NEW DELHI, Dec 28: Veteran actor Anupam Kher and Hansal Mehta got into a war of words over their movie "The Accidental Prime Minister" after the filmmaker agreed with a journalist that the 2019 political drama was filled with "lies" about former PM Manmohan Singh.

Singh, the architect behind India's economic reforms, passed away on Thursday night at Delhi's All India Institute of Medical Sciences (AIIMS) at the age of 92. He served as the prime minister from 2004 to 2014.

It all started with a post by senior journalist Vir Sanghvi, who on Friday labelled "The Accidental Prime Minister", which was based on the memoir of Singh's former media advisor Sanjay Baru, as "one of the worst Hindi movies ever made".

Featuring Kher as former PM Singh and actor Akshaye Khanna as Baru, the movie was directed by Vijay Gutte and depicted political events and decisions during Singh's leadership, focusing on his challenges as the prime minister and influence of the Congress party on his administration.

"If you want to remember the lies that were told about Manmohan Singh you should rewatch 'The Accidental Prime Minister'. It is not only one of the worst Hindi movies ever made but is an example of how media was used to tarnish the

name of a good man," Sanghvi wrote on X.

Mehta, 56, shared Sanghvi's post and captioned it, "+100."

In an earlier post, the filmmaker had condoled Singh's demise and said the na-

"More than anybody else, I owe him one. Whatever the compulsion or intent, it is a regret I will carry with a very heavy heart. Sorry, sir. Besides your achievements as an economist, Finance Minister, and Prime Minister, you were an honorable man-a rare gentleman in a vocation dominated by ruffians," Mehta had

However, Mehta's endorsement of Sanghvi's post irked Kher, who called the filmmaker a "hypocrite". He also pointed out Mehta served as the creative director

"The HYPOCRITE in this thread is NOT @virsanghvi. He has the freedom to not like a film. But @mehtahansal was the #CreativeDirector of #TheAccidental-PrimeMinister. Who was present at the entire shoot of the film in England! Giving his creative inputs and must have taken the fee also for it.

"So for him to say 100% to #VirSanghvi's comment is so messed up and full of double standards!" the 69-year-old actor wrote.

Kher said though he doesn't agree with Sanghvi's opinion, he believes artistes

## Bollywood 2024: When Hindi cinema failed to deliver at box office and Telugu pan-Indian films ruled

**NEW DELHI, Dec 28:** With its formulaic stories and action dramas biting the dust at the box office, the dream factory of Bollywood failed to deliver on the expectations of the audiences who turned to Telugu blockbusters like "Pushpa 2" and "Kalki 2898 AD" for larger-thanlife stories.

For the Hindi film industry, which banked mostly on nostalgia of re-releases like "Laila Majnu", "Tumbbad", "Veer Zaara" and many others to bring viewers to theatres, the one big success was "Stree 2", a horror comedy that made ₹ 597 crore nett.

Except for "Stree 2", no other Hindi film reached near the ₹ 500 crore mark at the box office in 2024. "Pushpa 2", starring Allu Arjun in the titular role and released on December 5, has earned over ₹ 700 crore in Hindi alone at the box office whereas its worldwide gross is more than ₹ 1,700 crore, according to figures shared by its producers.

In a novel promotional strategy, Arjun travelled all the way to Patna for the trailer launch of the movie, an indication that the makers were projecting it as a pan-India movie and not a Telugu film. "Pushpa 1", released in 2021, had done surprisingly good business in the Hindi belt. Malayalam superstar Mohanlal said the success of films like "Pushpa 2" are important for the Indian film industry.

"To make an entertainer and bring out a big success is not an easy thing. It requires a lot of patience and many other factors. It is a magic recipe and nobody knows the formula. 'Pushpa' and films like that are turning the wheel of the Indian film industry," the actor told

PTI. Like "Pushpa 2", Nag Ashwin's futuristic retelling of Mahabharata in "Kalki", starring Telugu superstar Prabhas with prominent roles by Amitabh Bachchan and Deepika Padukone, made over ₹ 290 crore just in Hindi language in June this year, according to trade website Sacnilk.

It is in stark contrast to 2023 when Bollywood registered four blockbusters in "Pathaan" and "Jawan", which raked in over ₹ 1,000 crore each at the worldwide box office, as well as Sunny Deol's "Gadar 2" and Ranbir Kapoor's

"Animal". "I would not call it a bad year for Bollywood but yes if you compare to last year, we had four films crossing ₹ 400 crore at the box office. This year has not been that great except for 'Stree 2' and 'Pushpa 2', which is a Telugu re-

lease. "Box office can be unpredictable and there are phases. But there are lessons to be learned, we need to make films that cater to pan-India audiences. Bollywood will, hopefully, bounce back in a big way next year," trade analyst Taran Adarsh told PTI. According to Amit Sharma, MD, Miraj Entertainment Ltd, 2024 was "disastrous" for Hindi cinema.

"The business is down by at least 30 per cent compared to 2023 where we had 'Pathaan', 'Gadar 2', 'Jawan', 'Animal', 'Dunki', 'Fukrey' and 'Dream Girl 2'... When it comes to Bollywood in 2024, you can't really speak about anything apart from 'Stree 2' and to an extent 'Bhool Bhulaiyaa 3' and 'Singham' and films like 'Laapata Ladies' and 'Shaitaan'. But commercially there is no comparison between 2024 and 2023," he told PTI.

Horror-comedy seemed to be the most successful genre in Bollywood as not just "Stree 2" but Kartik Aaryan's "Bhool Bhulaiyaa 3" and Maddock Films' "Munjya" also did decent business at the box office. But the Hindi cinema's big bet on action movies, starting the year with "Fighter" failed to yield good results.

Directed by Siddharth Anand of "Pathaan" fame, "Fighter", starring Hrithik Roshan and Deepika Padukone, couldn't replicate the success of the 2023 Shah Rukh Khan starrer.

The movie, made on a big budget, reportedly to be around ₹ 250 crore, and featuring high octane action sequences, underperformed at the box office, earning ₹ 212 crore in nett at the Indian box office, according to Sacnilk.

Ajay Devgn-starrer "Singham

Again", the latest entry in filmmaker Rohit Shetty's cop universe, amassed just ₹ 247 crore nett, did decent business but fell short of being a blockbuster.

The fact that the movie clashed with "Bhool Bhulaiyaa 3" in Diwali this year may have also impacted the business of the two movies. The films registered great opening day numbers but ran out of steam in just two weeks.

Other major disappointments at the ticket window were "Yodha" starring Sidharth Malhotra, Akshay Kumar's "Bade Miyan Chote Miyan", Devgn's "Maidaan" and Aaryan's "Chandu Champion" and Alia Bhatt-starrer "Jigra"

The dry run of Akshay's films at the box office continued after "Bade Miyan Chote Miyan" with both "Sarfira" and "Khel Khel Mein" not doing too well. (PTI)

# Paralympian Kathuniya questions panel for overlooking him for Khel Ratna

NEW DELHI, Dec 28: Twotime Paralympic silver medallist Yogesh Kathuniya on Saturday voiced his disappointment over not being nominated for the prestigious Khel Ratna Award despite his "consistent" performances on the world

Kathuniya expressed frustration at what he perceived as favouritism and a lack of transparency in the award selection process. "I don't know what criteria they have set. I even filled the form. It's not like I didn't fill the form. I did everything, but even after getting the highest aggregate marks, I was not nominated this time as well," Kathuniya told PTI videos in an exclusive interview.

"If you look at 2016-2020, there was no favouritism," he said. "Last time, I remember well, I did not even fill the form for the Arjuna Award, yet I was nominated. There was a policy that if you played in the Paralympics or Olympics and won a medal, you would be directly considered. Why can't you do it

"If you could do it before, why can't you do it now? What is the use of playing if we must ask for the awards? What value does an award hold if we are



Kathuniya, who has won six medals at the world level, including two silver in two Paralympics, two silver and a pronze in the World Championship, and a silver in the Asian Games, is baffled by the lack of recognition. "People say it doesn't matter, but why doesn't it matter? It affects me. The first

'You didn't have a gold medal.' I said, fine, I don't have a gold medal. When there are three positions -- gold, silver, and bronze -- why is only gold val-

"Silver and bronze have been recognised before. Why not now? Are they not medals too?'

"If you leave my 245 points

aside, I have won six medals. Even after all that, if I don't get it, what is the guarantee I'll get it next year?

Kathuniya's plea is not just for himself but for all deserving athletes. "Give it to everyone who deserves it," he urged.

"I want it, Praveen wants it, it. Those who have already got

the Arjuna Award and have repeated their medals this time deserve it. Why differentiate? Count our achievements, not our social media reach.'

'The one with more name on social media gets it. Decisions are taken based on favouritism. Otherwise, why hasn't our voice reached them till now? I've said it so many times, but nothing

has come of it," he said. Kathuniya described the Khel Ratna Award as more than just another accolade, terming it a source of inspiration.

'The award is for motivation. It's a goal, a dream. When the President gives you that award, it inspires you to do better. That's what we are asking from the government -- not favours, iust recognition.

"I don't want to become a celebrity. I want to play for the country. I'll continue to play. But at least give us the recognition we deserve." He also criticised the delay in announcing the list of winners.

"The list was finalised on December 15. Why hasn't the list been announced yet? Are they afraid because people are filing court cases? If this continues, the National Sports Awards for 2024 will be given in 2025, and Manu wants it, Harvinder wants the 2025 awards in 2026," he

## Ronaldo backs Amorim at Man United, picks Vinicius over Rodri at soccer awards

**DUBAI. Dec** 28: Cristiano Ronaldo backed Manchester United coach Ruben Amorim on Friday, saying "the storm will finish" after his Portuguese countryman's difficult start to life in the Premier League.

The former Manchester United star, and five-time Ballon d'Or winner, currently plays for Saudi Arabia's Al-Nassr. Ronaldo spoke after being named the best player in the Middle East at the Globe Soccer Awards in Dubai. Amorim — who was hired after

"(Amorim) did a fantastic job in Portugal with my (club) Sporting," the 39-year-old Ronaldo said. "But the Premier League is a different beast, the most competitive league in the world.'

"I knew that it would be tough and they will continue the storm.

But the storm will finish and the sun will rise," he added.

Ronaldo's second spell at United ended in November 2022, with disagreements between him and Ten Hag. "I say this one year and half ago

Gutsy Reddy's maiden ton keeps India afloat

Reddy, an unknown entity in red ball cricket before the start of Border-Gavaskar series, virtually bailed India out with his dogged maiden Test century here on Saturday, severely denting Australia's hopes of winning the Boxing Day

Reddy's unbeaten 105 took India to 358 for nine, still 116 runs short of Australia's first innings score of 474 as rain brought an early end to the third day's play.

With the flat MCG deck not offering much to the bowlers, saving the Test match shouldn't be a big deal for India. Reddy, easily India's 'find of the series', played a pivotal role in visitors' fightback.

Reddy's combative spirit and the invaluable 127-run stand he shared with Washington Sundar (50 off 162 balls) proved to be the turning point for the hosts.

Reddy's innings was termed as one of greatest Test knocks by the legendary Sunil Gavaskar given the situation as India were in a precarious position after Rishab Pant's dismissal courtesy a rash shot had left India tottering at 191 for six.

The young Andhra batter could have been stranded on 99 when Jasprit Bumrah got dismissed, leaving Reddy with last-man in Mohammed Siraj, who walked in to another round of boos and faced three deliveries from home skipper Muthyala's expressions changed with each ball but Siraj survived to allow Reddy savour the moment he must have dreamt a thousand

A picture-perfect straight drive off Scott Boland was the moment of the series for India as Reddy balanced his helmet with the bat and took a knee, expressing his gratitude towards the Indian dugout which gave him a standing

Without learning his lessons or caring about success percentage, Pant tried a similar shot but the extra bounce meant that the top edge flew to third man for a regulation catch.

"If there was a word called 'worstest', then this was one such shot," former India skipper Sunil Gavaskar said on air.

But Reddy showed steely resolve as he started with a punchy off-drive off Lyon and also jumped down the track to loft him over for a straight six during a splendid recovery act. (PTI)

## New Zealand fight back to beat Sri Lanka by 8 runs in first T20I



**MOUNT MAUNGANUNI (New** Zealand), Dec 28: Daryl Mitchell and Michael Bracewell made halfcenturies in a 105-run sixth wicket partnership to help lead New Zealand to an eight-run win over Sri Lanka on Saturday in the first of three T20 Internationals.

Outstanding bowling at the death also turned the match in New Zealand's favor as Sri Lanka slumped from 121-0 to 164-8 in reply to New Zealand's 172-8.

Mitchell made 62 and Bracewell 59 in a partnership lasting only 60 balls, after coming together with New Zealand in trouble at 65-5 when Wanindu Hasaranga dismissed Glenn Phillips and Mitchell Hay with consecutive deliveries in the 10th over.

New Zealand's total looked inadequate as Pathum Nissanka made 90 in 60 balls and shared a 121-run opening stand with Kusal Mendis which seemed to have set up Sri Lanka for a comfortable win. Mendis contributed 46 to Sri Lanka's first century opening partnership in T20s in 122 innings over eight vears.

He was out in the 14th over, an over where Jacob Duffy took three wickets for one run, marking the point at which Sri Lanka's run chase began to unravel. Kamindu Mendis and Kusal Perera were also out in the same over.

"They're class batters, particularly those two at the top," Duffy said. "We know these conditions well with a bit of bounce and swing up top.

Nissanka was dismissed with the total 153-5 in the 19th over and only 20 runs needed for victory.

But Sri Lanka went into the match with a long tail and it wasn't able to finish what Nissanka and Kusal Mendis had started. "We're really disappointed about the result and we really should have done better," Sri Lanka captain Charith Asalanka said. "I think Pathum Nissanka and Kusal Mendis batted really well and the rest of us, myself included, should take respon-

sibility for this loss." New Zealand was under pressure for most of the match, stumbling to 32-2 at the end of the ower play as Binura Fernando bowled superbly at the top of the innings, finishing with 2-22.

Hasaranga then stepped up and took his two important middleorder wickets as New Zealand reached 65-5 by the midpoint of its

## could have got Konstas out 6-7 times in first 2 overs: Bumrah



MELBOURNE, Dec 28: Jasprit Bumrah said on Saturday he "never felt" he was far away from a wicket even as Australia's 19year-old Test debutant Sam Konstas went after India's champion pacer in what is a rare sight in in-

ternational cricket. Bumrah said it was an interesting battle against Konstas on the opening day of the fourth Test but believed he could have got the batter out six-seven times in the first

Konstas, who played some unconventional shots on way to an impressive 60 off 65 balls, hit Bumrah for two sixes during his knock. This was the first time in three years that Bumrah was hit for a six in Test cricket.

"I don't look at things that way. Yes, I have felt good and the results have been in my favour but I have bowled better in different places. This is how cricket goes,

some days your execution might be off and you get wickets but some days your execution could be perfect but you don't get wickets. So I think it all evenly balances out," Bumrah told Channel 7.

"I have experienced heaps of it. I have played T20 cricket a lot, more than 12 years of T20 cricket." Bumrah, who has so far taken 24 wickets in the Border Gavakar Trophy 2024-25, added, "Interesting batsman (Konstas) as well and I always felt I was in the game, I never felt I am far away from a wicket.

"Initially I felt I could have got him out 6-7 times in the first two overs but that's how cricket goes, some days it pays off, it looks good, some days if it doesn't you might be criticising the same per-

"I love different challenges, always looking forward to a new challenge." Bumrah, who made his ODI debut Down Under, said Australia always brings the best out of

"It always brings the best in you. I came here on my first Test tour in 2018, I made my ODI debut here

in 2016 as well, so it brings out a lot of challenges because the wickets are very flat, the Kookaburra ball does a bit with the new ball and then doesn't do anything.

"So your accuracy is tested, the weather sometimes can test your fitness, your patience, so everything is tested. So once you come out on top after that it really leaves you in a good space and you can become a better cricketer," said Bumrah, who returned figures of 4 for 99 in the first innings, here.

Bumrah also praised Steve Smith, who scored 140 in Australia's first innings, terming him a challenging batter to bowl to.

"He (Smith) is always been a challenge. He is unorthodox, bit like me. He is not a conventional batter, someday he is shuffling someday not, so it brings out a new challenge. He scores in different area of the ground and so you have to be consistent and bowl good balls ball after ball. "I always had good battles with him in all formats I played against him. Obviously, one of the greats of the game and in this format he is always difficult to bowl," he said.(PTI)

### Young guy from India got every shot in book: **Boland lauds Nitish Reddy**

MELBOURNE, Dec 28: Nitish Reddy's straight drive off Scott Boland that carried him past his maiden Test hundred has convinced the Australian pacer about the young Indian batter's potential with the bat.

Reddy made an unbeaten 105 as India reached 358 for nine in their first innings, and more importantly gave the side a chance to salvage the fourth Test here. "Yeah, obviously he's playing really nicely. Coming in down the middle, it's a lower-order, but he's sort of trying to put the pressure back on us. And he's playing nicely," Boland replied to a query from PTI after the day's play.

"He played really well. He's been a young guy from India who's come through and strikes the ball really well. It looks like he's got pretty much every shot in the book," he added.

Boland first had a glimpse of Reddy during the Pink Ball match between India and the PM XI in Canberra.

"I played the 'A' game against him, the PM's game and then a couple of Tests. You see he can score all around the ground. "He's obviously a very nice player and does well in the IPL and he's

doing well here in Australian conditions as well," he noted. Boland felt that the MCG pitch didn't have the expected nip.

"Yeah, I think it started off with a fair bit of nip in it. I think there's still a little bit of nip there at the moment. Not as consistent as I'd like as a bowler, but I think it's going to be a pretty good Test match wicket." Talking about Australia's plan in general against the India batters, the beefy pacer replied: "Coming off that break, we tried to take them a bit

wider with the ball. We obviously set a 7-2 field and tried to see if they wanted to flash their hands outside the off stump." (PTI)

## Nick Kyrgios heavily criticizes Sinner, Swiatek for doping-related issues

BRISBANE, Dec 28: Just days away from his return to tennis at the Brisbane International, Nick Kyrgios hasn't minced his words in referring to doping-related charges against Jannik Sinner and Iga Swiatek, labelling breaches of the sport's anti-doping program as "disgusting for our sport."

The International Tennis Integrity Agency (ITIA) levelled charges against world No.1 Sinner and former world No.1 Iga Swiatek. Sinner tested positive twice for an anabolic steroid in March, but avoided a ban because the ITIA determined he was not to blame.

Swiatek also accepted a onemonth suspension in November after testing positive for the banned substance trimetazidine.

"Two world No.1s both getting done for doping is disgusting for our sport. It's a horrible look," Kyrgios said at his Brisbane International press conference on Saturday. "Tennis integrity right now, and everyone knows it but no one wants to speak about it, it's awful."

Kyrgios, 29, has not played tournament tennis since June 2023 due to wrist and knee injuries. He was asked about his motivations for speaking out on the Sinner and Swiatek situa-

tions. "Someone like me ... I would never even in my entire life ever try and dope in this sport," he said. "Especially going through an injury like I went through, obviously there are things out there that could speed up healing, help me get back to prime level, help my recovery.

'There's so many things out there that are prohibited in our sport that I could have been doing to get me back quicker ...



(but) that's just not who I am. I'm always against that.'

Sinner had successfully argued that his physiotherapist had accidentally contaminated him during treatment with clostebol which had transferred

from a cut on his own hand. Kyrgios raised questions over what happened next.

"I (pay) my team hundreds and thousands of dollars to be the professionals they are, to make sure that doesn't happen," Kyrgios said. "So they knew it happened. Why did they wait five to six months to do anything about it? He kept his team for five months ... that doesn't make sense."

Kyrgios will take on 21-yearold Giovanni Perricard of France in the first round in Brisbane. It will be the first tourlevel appearance by Kyrgios since the Stuttgart Open in June

2023. Kyrgios has been mostly sidelined with career-threatening wrist and knee injuries since the 2022 U.S. Open quarterfinals. Kyrgios is also entered in the Australian Open beginning Jan 12. It would be his first Grand Slam singles tournament in more than two years.

Kyrgios, who won the Brisbane International in 2018, will partner Novak Djokovic in doubles in Brisbane. Djokovic beat Kyrgios in the 2022 Wimbledon singles final. Djokovic is the No. 1-seeded

player at the Brisbane Interna-

tional and will play Australia's

Rinky Hijikata in the opening

round following the singles draw held Saturday. Kyrgios and Djokovic are in the top half of the singles draw and are not slated to play each other until the semifinals should they both win through. (AP)
