ONOE bills introduced in LS; Oppn terms move 'dictatorial'

NEW DELHI, Dec 17: Two bills that lay down the mechanism to hold simultaneous elections were introduced in the Lok Sabha after a fiery debate on Tuesday, with the opposition terming the move "dictatorial" and Law Minister Arjun Ram Meghwal asserting that the legislation would not tamper with the powers enjoyed by states.

The Constitution (129th Amendment) Bill was introduced in the Lok Sabha by Meghwal after a nearly 90-minute debate, followed by a division of votes. As many as 269 members voted in favour of the Bill and 198 against it.

Meghwal also introduced The Union Territories Amendment Bill, which seeks to align elections in the Union territories of Puducherry, Delhi, and Jammu and Kashmir with the Lok Sabha polls.

He said the proposed bills did not attack the

Principles such as judicial review, federal character of the Constitution, separation of powers, secular character, and supremacy of the Constitution had not changed, Meghwal said, adding that the objections to the Bill were political in nature.

Congress member Manish Tewari opposed the introduction of the bills and termed the move an assault on the basic structure doctrine that stipulates certain features of the Constitution are beyond the amending power of Parliament. "One of the essential features is federalism and the structure of our democracy. The bills assault the basic structure of the Constitution and exceed the legislative competence of this House," Tewari, a former Union minister, said. (CONTD. ON PAGE-2)



Doval in Beijing to attend India-China SR talks to restore ties

BEIJING, Dec 17: National Security Advisor Ajit Doval arrived here on Tuesday to take part in the India-China Special Representatives' talks to be held on Wednesday aimed at restoring the bilateral ties stalled for over four years due to the military standoff in eastern Ladakh.

Doval will hold the 23rd round of the Special Representatives (SR) talks with his Chinese counterpart and foreign minister Wang Yi and was expected to discuss a range of issues to rebuild the bilateral ties following the October 21 agreement of disengagement and patrolling in eastern Ladakh between the two countries. Ahead of crucial talks, China said on Tuesday that

it is ready to honour commitments based on the com-

mon understandings reached between Prime Minister Narendra Modi and President Xi Jinping during their meeting at Kazan in Russia on the sidelines of the BRICS summit on October 24.

"China stands ready to work with India to deliver on important common understandings reached between our two leaders, enhance mutual trust and mutual confidence through dialogue and communication, honour our commitments and promote our bilateral relations to go back to the sound and steady growth,' Chinese foreign ministry spokesman Lin Jian told a media briefing when asked about SR talks. Declining feral horse population in Assam national park: NGT issues notice

NEW DELHI, Dec 17: The National Green Tribunal has issued notice to the Centre and others over the critically endangered status of the feral horses in the Dibru-Saikhowa National Park in Assam.

In the order passed on December 16 in a suo motu case, a bench of NGT chairperson Justice Prakash Shrivastava and expert member A Senthil Vel said the "unique" horses, found only in the national park, were facing extinction and required "urgent intervention."

Feral horses reportedly descend from the stock of domesticated horses but are untamed and roam

Referring to the news report, the bench said these horses were not covered under the Wildlife Protection Act and in the absence of a census, it was difficult to ascertain their conservation status

"The matter indicates a violation of the provisions of the Biodiversity Act and Environment Protection Act. The news item raises substantial issues relating to compliance with the environmental norms," the tribunal said.

It impleaded as parties or respondents the secretaries of the Union ministry of environment, forest and climate change and the

National Biodiversity Authority besides the directors of the Zoological Survey of India and Wildlife Institute of India and the state's chief wildlife warden.

"Issue notice to the above respondents for filing their response/reply by way of affidavit before the eastern zonal bench of the tribunal (in Kolkata)," the tribunal said. The matter will be heard on February 27.

According to the report, these horses have survived in the wild for about 80 years and were believed to be descendants of war horses either from World War II or China's Przewalski's horse species. (PTI)

NTA will be restructured in 2025: Dharmendra Pradhan

NEW DELHI, Dec 17: The NTA will not conduct any recruitment exams from 2025 and instead focus only on higher education entrance tests, Union Education Min-Dharmendra Pradhan announced on Tuesday.

The agency will be restructured next year and new posts are being created, he added.

The move is part of examination reforms based on the recommendations of a high-level panel set up earlier this year following alleged leaks in the National Eligibilitycum-Entrance Test (NEET) medical entrance exam and a series of cancellations of others due to suspected leaks and other glitches.

The education ministry is also in conversation with the health ministry on conducting NEET in the traditional pen-and-paper mode or switching to a Computer Based Test (CBT). "The National Testing Agency (NTA) will be limited to conducting only entrance exams for higher education and not conduct any recruitment exams from next year," Pradhan told reporters.

He clarified that the Common University Entrance Test - Undergraduate (CUET-UG) would continue to be held once a year.

Lower Q2 GDP growth a temporary blip; eco to improve in coming quarters: Sitharaman

Minister Nirmala Sitharaman on Tuesday said the lower-than-expected GDP growth of 5.4 per cent in the second quarter was a "temporary blip" and exuded confidence that the economy will see healthy growth in the coming quar-

Replying to a debate in the Lok Sabha on the first batch of Supplementary Demands for Grants, she said India has seen "steady and sustained" growth and its GDP growth rate has averaged 8.3 per cent in the last three years.

"The real growth rate for Q1 and Q2 of this financial year (FY25) has been 6.7 per cent and 5.4 per cent, respectively. At 5.4 per cent, the Q2 rate is slower than expected...Q2 of this financial year has been a challenging quarter for India and most other economies of the world," she said.

India continues to be the fastestgrowing major economy in the world, Sitharaman said, adding that the credit goes to the people of India who are struggling and meeting their aspirations, thereby, contributing to the economy.

Terming the second quarter's less-than-expected growth as a "temporary blip", she said the economy will see healthy growth in the coming quarters.

The finance minister further said

there is no broad-based slowdown in the manufacturing sector. Half of the sectors within the overall manufacturing basket continue to remain strong

"A generalised slowdown in manufacturing is not expected, as is restricted to few segments...out of 23 manufacturing sectors in the Index of Industrial Production, about half of them remain strong even now," she said.

Besides, she said, the capital expenditure of the Union Government has grown by 6.4 per cent between July and October 2024. The government has allocated ₹

11.11 lakh crore toward capex during the current financial year. "I think steps that we are taking to push for growth and to sustain growth are going to this route of capital expenditure so that the multiplier effect will spread through the economy and therefore give a

greater traction," she said. For every rupee spent on the capital account, she said, the multiplier effect sometimes results in touching 4.3, whereas if you spent on the revenue account, for every one rupee, you would get only 0.98. About inflation, Sitharaman said it is better controlled in the NDA regime, whereas under the UPA, it touched double digits.

Retail inflation in April-October 2024-25 stood at 4.8 per cent, the lowest since the Covid pandemic,

volatile food and energy prices, remains at a decadal low of 3.6 per cent, she added. Sitharaman said the unemployment rate has come down from 6 per cent in 2017-18 to 3.2 per cent now.

Later, the Lok Sabha passed Supplementary Demands for Grants, seeking approval of additional net expenditure of ₹ 44,143 crore in the current fiscal, mainly on account of higher spending by agriculture, fertiliser and defence ministries.

The first batch of Supplementary Demands for Grants for 2024-25 sought approval to authorise gross additional expenditure of ₹ 87,762.56 crore. Of this, proposals involving net cash outgo aggregate to ₹44,142.87 crore and gross additional expenditure, matched by savings of the Ministries/ Departments or enhanced receipts/recoveries, aggregates to ₹ 43,618.43 crore.

The additional spending includes ₹ 6,593.73 crore towards the fertiliser subsidy scheme, about ₹ 9,000 crore for agriculture and farmer welfare, and ₹ 8,000 crore towards defence spending.

It also includes expenditure of ₹ 3,000 crore towards expenditure by the Ministry of External Affairs and ₹ 4,800 crore towards expenditure by the Home Ministry. (PTI)

Samajwadi Party member Dharmendra Yadav said the measure to introduce "one nation, one election" by the BJP was an attempt to bring dictatorship in the country. Union home minister Amit Shah said Prime Minister Narendra Modi had favoured referring the bills to a joint committee of Parliament for wider deliberations at every level. "Detailed discussions can take place in the JPC. The report of the JPC will be approved by the Cabinet. Then again, there will be a discussion on this (bills) in the House," Shah said. Meghwal said he would move a resolution referring the Bills to a joint committee of Parliament.

Earlier, Trinamool Congress member Kalyan Banerjee said the bills linked the tenure of state assemblies to that of the Lok Sabha, thus undermining the mandate of the people. "The state government is not subordinate to the central government or Parliament. The bills take away the autonomy of the state assembly. It is not an election reform but just the fulfilment of one gentleman's desire and dream," he said. DMK member TR Baalu said, "The electors have the right to elect the government for five years and this right cannot be curtailed with

The opposition members also objected to Speaker Om Birla's move to call the treasury benches to speak on the bills, leading to a heated debate. Parliamentary affairs minister Kiren Rijiju said the speaker had given a ruling to allow floor leaders of all parties to speak on the introduction of the bills. "You alone do not represent

The SRs meeting is taking place after a gap of five years. The last meeting was held in 2019 in Delhi. Constituted in 2003 to comprehensively address the vexed dispute of the India-China border spanning 3,488 km, the SRs mechanism over the years met 22 times. While success eluded it in resolving the boundary dispute, officials on both sides regard it as a very promising, useful and handy tool in addressing the recurring tensions

Huge leap in business activity

The data comes as both governments are preparing to resume Free Trade Agreement (FTA) negotiations next year after Prime Ministers Keir Starmer and Narendra Modi agreed to relaunch the process during their meeting on the sidelines of the G20 Summit in Brazil last month.

"We very much welcome the renewed commitment made by both Prime Ministers at G20 and the intention to restart FTA negotiations early in 2025," said Richard McCallum, Group CEO of the UK India Business Council (UKIBC). "As the HSBC data show, UK-India trade is growing rapidly. This will only accelerate further when the FTA is in place... In the UKIBC's view, sustained business reforms and geopolitical factors make India a highly attractive investment destination, source of goods and services, and strategic supply chain partner for UK business across sectors," he said.

According to official UK Department for Business and Trade (DBT) statistics, the total trade in goods and services between the UK and India was GBP 42 billion in the four quarters to the end of 2024. This is expected to be significantly enhanced with an FTA, negotiations for which began in January 2022 before being paused in the fourteenth round earlier this year due to general elections in both countries. The talks are scheduled to resume in the new year, with a clear timeline yet to be officially confirmed. (PTI)

India doubles RE capacity in Apr-Nov, to become world's renewable energy capital: Pralhad Joshi

NEW DELHI, Dec 17: Renewable energy capacity addition in the country almost doubled to 15 GW during the April-November period of this fiscal year, compared to a year ago, and the country is all set to become the renewable energy capital of the world, Union New & Renewable Energy Minister Pralhad Joshi said on Tuesday.

Addressing at CII International Energy Conference & Exhibition 2024 here, Joshi said, "in fact, over the past decade, under the visionary leadership of Prime Minister Narendra Modi, India has charted an extraordinary path in the renewable energy sector. Today, India is one of the world's most promising nations in the clean energy space.'

The minister noted that India is not only witnessing an energy revolution but is also becoming the renew able energy capital of the world.

Between April-November of the current financial vear, India added almost 15 GW of renewable energy capacity, nearly double the 7.54 GW added during the same period last year, he said. At present, India's total installed capacity of the

non-fossil fuel sector has touched 214 GW, over 14 per cent increase compared to the same month last The government is transforming the entire energy

sector as this transformation is driven by a strong belief that a Viksit Bharat by 2047, is closely linked to sustainable and green growth, he said, adding that the roadmap for this transition is ambitious but achievable. India is firmly committed to achieving the goal of 500 GW of non-fossil fuel-based generation capac ity by 2030, he said.

He informed that in just last month alone, 2.3 GW of new capacity was added, which means a 4-fold increase from the 566.06 MW added in November 2023. "So yes, this transformation is not just a dream, it is

happening today," he stressed. In the last three financial years alone, he informed that India has attracted USD 6.1 billion in FDI into the renewable energy sector.

He noted that the PLI (production-linked incentive) scheme with an outlay of ₹ 24,000 crore has been introduced to boost domestic manufacturing of solar panels and modules.

"We are also in the process of setting up 50 solar parks with a cumulative capacity of 38 GW by 2025-26," the minister informed.

The government under the PM Surya Ghar Muft Bijli Yojana is empowering Indian households by enabling them to generate their own electricity through solar rooftops. The scheme targets 1 crore installations by 2026-27, with an outlay of ₹ 75,021 crore.

On the Green Hydrogen Mission, he said "under the SIGHT Programme of National Green Hydrogen Mission, we are extending support on 2 components majorly -- Component I for Electrolyser Manufacturing supported with ₹ 4,440 crore and Component II for Green Hydrogen production supported with ₹ 13,050 crore," he said.

He informed that two tranches of bidding have been completed under Component I allocating 3,000 MWPA Electrolyser Manufacturing capacity. Under Component II, 4.12 Lakh tonnes per annum (LTPA) quantity has been awarded to 10 companies, with a total subsidy of ₹ 3,055 crore.

Currently, 4.5 LTPA tender is live for green hydrogen production, and 7.39 LTPA for green ammonia (for fertilizers), he said and invited the industry to par-

New APHLC formed in Karbi Anglong

Non-political group unites for the autonomous state movement in Assam's hill districts

DIPHU, Dec 17: In a landmark development for Karbi Anglong, a new All Party Hills Leaders Conference (APHLC) was formally launched on Tuesday in a meeting held at the Diphu government Boys Higher Secondary School.

This non-political organisation, though sharing the same name as the APHLC led by Jones Ingti Kathar, is an entirely different entity. Its primary goal is to create a common platform for political parties, NGOs, and social organisations to come together and raise a unified voice for the creation of an autonomous state for the hill districts of Assam.

The event witnessed strong participation from political leaders, elected representatives, and members of various socio-cultural organisations, all united under the cause of autonomy. The newly formed APHLC is headed by James Hanse as president, Pitor Tisso as general secretary, and Augustin Kramsa as chief adviser. The launch was marked by the official release of the organisation's registration certificate under the Society Registration Act, facilitated by Karbi traditional king Longsing Ronghang, who expressed his unwavering support for the new initiative.

Ronghang, in his speech, emphasised the need for such an organisation, saying that it could unite all political parties, social organisations, and communities within Karbi Anglong to advocate for the common cause of an autonomous state. "I have been looking for such an organisation, which can lead the people of Karbi Anglong by uniting all political parties, social organisations, NGOs, and all communities and tribes to raise a single voice for an autonomous state issue," he said, further reiterating his full endorsement of the new APHLC.

The new APHLC's leaders were quick to clarify that their objective is not to form a political party but to create a broad-based platform where political and non-political groups, including youth, women, and student organisations, can come together and work towards a common goal — the creation of an autonomous state for the Karbi Anglong region. Chief Adviser Augustin Kramsa, in his welcome



address, made it clear that today's meeting was not about forming a political entity but about building unity for a cause that transcends

General Secretary Pitor Tisso also addressed the gathering, drawing attention to the historical context of the original APHLC formed in 1960 by Captain Williamson Sangma, which successfully led to the creation of Meghalaya. He explained that the new APHLC would continue in the same spirit, bringing together various political and independent groups to support the hill state movement. "In the

present context, JI Kathar's APHLC has taken up the name, but it focuses on the Sixth Schedule for its political advantage. Our APHLC, however, is dedicated to a collective effort that includes political and non-political organisations, and it is aimed at spearheading the autonomous state

Appeasement gone wrong?

Like Grandfather Nehru..." posted a Pakistani politician who was a minister in the Imran Khan regime. Fawad Hussain, clearly in awe of Priyanka Gandhi Vadra, whose Palestine Tote bag and black & white check sari made an emphatic if controversial political statement, and will likely launch a fashion trend, too, if not anywhere else, at least in her parliamentary constituency Wayanad and places nearby where "All eyes On Rafa" has been trending for months since Hamas terrorists fled to Rafa and the Israel Defence Forces followed in hot pursuit. India must not mix up border issues with economic imperatives

hina's sudden change of mind to uphold peace and tranquility with India at the Line of Actual Control (LAC) and work for early resolution of outstanding issues should not be read beyond these words as framed at the joint declaration at the end of the 30th meeting of the Working Mechanism for Consultation and Coordination on India-China Border Affairs in Delhi, earlier this month. China seems to be willing to make a careful compromise on the border issue after a gap of almost four-and-a-half years, when the Chinese troops tried to aggressively change the status quo on the LAC in eastern Ladakh without much success.

Hopefully, the Chinese peace offer does not come with an unwritten rider that is to allow more

merchandise export to

the Indian market.

China needs a steady export market to partially cover its shrinking trade surplus with the United States. China's exports shrank sharply in November as Donald Trump's imminent return to the White House brings fresh trade risks. China is out to grab the vast market in India by

dumping a whole range of merchandise. India has become China's (including Hong Kong) second largest source of trade surplus and the fourth largest export destination after the US. South Korea and Vietnam. The world's No.1 exporter, China would probably settle for a small military compromise on the Ladakh border in exchange for a bigger pie of the Indian market. Last year, India's import from China was worth \$121.97 billion, according to the UN Comtrade Data Base on international trade. US President-elect Trump has pledged to slap an additional tariff on Chinese goods. Trump wants to introduce tariffs in excess of 60 percent on Chinese merchandise. Trump's threats have rattled China's industrial complex, which sells goods worth more than \$400 billion annually to the US. Last year, China's trade surplus with the US amounted to \$336 billion. As a single country, India came next. The European Union and ASEAN, representing clusis naturally concerned. It may be interesting to note that before the US presidential election, China had unofficially supported Democratic Party candidate Kamala Harris, a strong supporter of Ukraine in the country's fight against Russia, to ensure that its exports to the USA were not disturbed. A Harris victory would have further escalated the Russia-Ukraine war. China probably did not mind Ukraine's NATO-backed military resistance against Russia, its socalled key "ally", to continue for the sake of its unhindered export to the US. Over the years, China's massive exports to the US since the Nixon era helped the People's Republic (PRC) become the world's second largest economy. China's economy was worth only \$113.69 billion in 1972 when the

making China a formidable economic and military power today. In 1972, China's communist regime, led by Mao Zedong, decided to establish

a diplomatic link with the US after a gap of 23 years. Communist China had its own strategic reasons to open dialogue with the US as its relationship with the more powerful Communist neighbour, the Soviet Union, threatened to turn sour despite their shared political ideology with the USSR's growing influence in Asia. By the late 1960s, China and the Soviet Union were involved in frequent border skirmishes threatening to verge on all-out war. President Nixon and his secretary of state Henry Kissinger decided to exploit the opportunity to rebuild a relationship with China to corner the Soviet Union in order to create a balance of power between the US and the mighty USSR. "The enemy of my enemy is my friend' Nixon had said. China's rise to economic power started thereafter. In 1978, the country launched a major economic reform program by adopting an open-door policy to attract foreign investment and technology while maintaining its commitment to socialism.

China is now the world's second largest economy with a GDP of around \$17.8 trillion. Donald Trump has vowed to make imports from China much dearer to slash the US trade deficit with China to rebuild its economy and push employment in the US. China needs a big and growing market such as India to keep its export-driven economy flourish. And, this might have driven China to indirectly support Democrat Kamala Harris to continue to enjoy trade concessions. Chinese exports are expected to reach a historical high this year as customers have been rushing to frontload orders in the light of President-elect Donald Trump's threat of higher import tariffs when he takes office in January. According to analysts, China's export growth is expected to accelerate to seven percent during the current October-December quarter from the same period last year pushing the country's total exports this year to \$3.548 trillion.

Thus, China's sudden change of mind to uphold "peace and tranquility with India" at the Line of Actual Control (LAC) appears to be more artificial than real. Militarily far advanced, China has already surrounded India with its considerable strategic influence over Pakistan, Bangladesh, Sri Lanka, the Maldives, Nepal and more lately Bhutan. India would probably make a major mistake to link its trade and economic imperatives with the Chinese 'peace' offer at Galwan.

India must drastically cut down direct and indirect imports (through Nepal) and investments from China to expand its own industrial production and protect the small and medium scale sectors. Several Indian industries – such as steel. solar modules, furniture, glass, textile, paper, leather, automotive, medical, electronics goods, thermoplastic polyurethane, handicrafts and MSME clusters, such as fireworks, decorative lights, toys, silk weaving, and festive products -- are reeling under Chinese trade dumping. India must take a hard line on imports from China. The massive trade deficit with China is killing the country's economy, erasing the value of Rupee, raising inflation and creating unemployment. India's economic peace and prosperity are not negotiable. (IPA Service)

Fragile Secularism: Minority **Persecution in Bangladesh**

he political and social fabric of Bangladesh is currently under intense scrutiny, as its interim government faces severe allegations of failing to protect minorities, particularly Hindus, amidst escalating violence. This situation has drawn the attention of neighboring India, which has expressed concern over the targeted attacks on religious minorities. However, Bangladesh's governing elite, led by Chief Advisor Muhammad Yunus, has countered by accusing India of politicizing the issue to serve its domestic agenda, thereby framing the crisis as an "internal political issue" between the two nations.

Rising Violence Against Minorities

The persistent persecution of Hindus and other minorities in Bangladesh has eroded the claims of secularism espoused by the current regime. Incidents of temple desecrations, property destruction, rapes, and mass killings have surfaced repeatedly. On December 4, Bangladesh's administration sought to dismiss these atrocities, with Yunus stating that reports of anti-Hindu violence were "exaggerated" and politically motivated.

Yunus attempted to contextualize the Islamist attacks as a reaction to the perception that Hindus were aligned with the ousted Awami League, led by Sheikh Hasina. He argued that the violence was not communal but politically motivated. However, this narrative conveniently ignores the documented targeting of minorities and the tacit endorsement of such actions by the interim government.

India's Concerns and Bangladesh's Rebuttal

Indian officials have repeatedly raised concerns over the violence against minorities in Bangladesh. These concerns were dismissed by Nahid Islam, Bangladesh's Information Advisor, who warned that such narratives could harm India's domestic politics. Nahid's remarks implied that India's concern over minority persecution in Bangladesh was driven by "Hindutva forces" seeking to undermine harmony and democratic relations between the two countries.

Nahid's statement ignored the extensive evidence of violence against minorities, including videos, media reports, and international criticism. Instead, Bangladesh's administration accused India of spreading propaganda to destabilize the country's "democratic nation-rebuilding process" and to support the Awami League's purported fascism. This rhetoric highlights the government's strategy of deflection rather than addressng the underlying issues.

Historical Context and Shifting Dynamics

India and Bangladesh share deep historical and cultural ties. India played a pivotal role in Bangladesh's independence in 1971, offering military and diplomatic support during its liberation from Pakistan. This bond, however, appears strained under the current administration, which seems to have forgotten the cooperative spirit of the past.

Yunus and his interim government have sought to rewrite the narrative, portraying India as a meddling neighbor captivated by the fear that Bangladesh might become an Islamist state akin to Afghanistan without Sheikh Hasina's leadership. Yunus urged India to abandon this "narrative," claiming that Bangladesh's issues with minority persecution were being exaggerated for political gain. This stance, however, fails to account for the lived realities of minorities facing violence and displacement.

The Political Mask of Violence

Yunus's administration has consistently downplayed the severity of anti-Hindu violence, portraying it as a byproduct of political turmoil rather than communal hatred. In an interview with PTI, Yunus stated that attackers targeted Hindus because of their perceived alignment with the Awami League. He suggested that Hindus should refrain from identifying themselves by their religion to avoid persecution, a recommendation that starkly contrasts with principles of religious free-

dom and equality. Despite Yunus's assertions, reports from international observers and local media paint a grim picture. On December 3, a Muslim mob in the Sunamgani district vandalized 130 homes and 20 Hindu temples, citing a Facebook post as provocation. This was not an isolated incident but part of a larger pattern of targeted violence that includes the disruption of Hindu religious festivals, such as Durga Puja, and demands for discriminatory practices like the imposition of jizya.

The International Response

The global community has begun to take notice of the deteriorating situation in Bangladesh. Johnnie Moore, a former commissioner of the United States Commission on International Religious Freedom (US-CIRF), criticized Yunus's administration for its failure to protect minorities. He stated that "there isn't a minority in the country that doesn't feel under threat right now." Such international criticism underscores the gap between Bangladesh's claims of secular governance and the ground realities of religious persecution.

In a meeting with political party representatives, Yunus accused "big countries" of orchestrating a campaign to undermine his government. Although he avoided naming India directly, his remarks were a clear indictment of India's role in highlighting the plight of minorities in Bangladesh. Yunus alleged that this campaign was part of an effort to delegitimize his administration and to portray the removal of Sheikh Hasina as a destabilizing event.

Yunus's rhetoric conveniently shifts the focus away from the failings of his government and towards India as a scapegoat. This strategy not only undermines India's legitimate concerns but also disregards the shared responsibility of both nations to uphold human

rights and regional stability. **The Cost of Deflection**

The ongoing violence against minorities in Bangladesh and the government's dismissive response has far-reaching implications. By deflecting blame onto India. the interim administration risks alienating a historically supportive neighbor and eroding its international credibility. More importantly, this approach does little to address the root causes of the violence or to ensure the safety and dignity of Bangladesh's minorities.

The persistent targeting of Hindus and other minorities is not merely a political issue; it is a human rights crisis that demands urgent attention and action. While Bangladesh's government may seek to downplay these events as "exaggerated" or "political," the evidence suggests otherwise. India's concerns, far from being propagandistic, reflect a genuine alarm over the erosion of secularism and justice in Bangladesh.

As Bangladesh grapples with these challenges, it must recognize that deflection and denial are not sustainable strategies. True progress lies in acknowledging and addressing the systemic issues that enable violence and discrimination. India and China: Seeking stability amidst tensions

ndia and China, two of the world's most populous nations, share a complex relationship marked by both cooperation and contention. Their interactions span centuries, encompassing cultural exchanges, trade, and, in recent times, geopolitical rivalries. A significant aspect of their contemporary relationship revolves around the disputed border, known as the Line of Actual Control (LAC), which has been a source of tension and conflict.

In 2020, the Galwan Valley clash resulted in the loss of lives on both sides, bringing the longstanding border dispute into sharp focus. This incident underscored the urgent need for diplomatic nt to ensure peace and stability in the region. In response, both nations initiated a series of diplomatic and military talks aimed at de-escalation and disengagement along the LAC.

A pivotal development in these efforts is the anticipated visit of India's National Security Adviser (NSA), Ajit Doval, to China. Doval is expected to engage in discussions under the Special Representatives (SR) mechanism, a diplomatic channel established in 2003 to explore frameworks for a boundary settlement. This mechanism has facilitated 22 formal rounds of talks, with the last occurring in 2019.

The upcoming meeting between Doval and his Chinese counterpart, Foreign Minister Wang Yi, signifies a mutual commitment to addressing the border issue. Their engagement follows a series of high-level interactions, including meetings between Prime Minister Narendra Modi and President Xi Jinping, and discussions between other senior officials. These dialogues have been instrumental in reviving mechanisms aimed at normalizing bilat-

The Special Representatives mechanism was created to explore

the "framework of a boundary settlement". Since then, 22 formal rounds of talks have been held under the mechanism, the last being in 2019. During the military standoff on the LAC that began in April-May 2020, the Special Representatives held talks several times to find ways to end the face-off.

The standoff, and a brutal clash at Galwan Valley in June the same year that killed 20 Indian soldiers and at least four Chinese troops, had taken bilateral ties to their lowest point since the 1962

The anticipated visit of NSA Doval to China is expected to further the progress made in these discussions. The focus will be on building upon the recent agreement on patrolling arrangements long the LAC, aiming to de-escalate tensions and work towards a boundary settlement.

The significance of these talks extends beyond the immediate border issues. They are crucial for the broader geopolitical landscape, influencing regional stability and international relations. Both India and China are key players in global affairs, and their relationship has implications for economic partnerships, security

alliances, and diplomatic engagements worldwide. The complexities of the India-China relationship are further highlighted by their economic interactions. China is one of India's largest trading partners, with bilateral trade reaching significant volumes annually. However, trade imbalances and market access issues have been points of contention. The border tensions have also impacted economic relations, with increased scrutiny on Chinese investments in India and calls for diversification of supply

In recent years, both nations have engaged in infrastructure development along the border areas, enhancing connectivity and asserting their strategic positions. New leadership in Syria: Challenges and opportunities in the post-Assad era

he transition of power in Syria from Bashar al-Assad to Mohammed al-Bashir, appointed Prime Minister on December 10, 2024, marks a transformative chapter in the nation's tumultuous history. Assad's regime, synonymous with authoritarian rule, civil strife, and international entanglements, has come to an end under the weight of external pressures and the withdrawal of Russian support. This political shift offers Syria a glimmer of hope for renewal, though it is fraught with uncertainty and immense challenges.

The departure of Assad leaves a significant power vacuum, highlighting the fragility of the state. Mohammed al-Bashir, a moderate figure recognized for his diplomatic expertise, has pledged a path of national reconciliation and reconstruction. His leadership signals a departure from the autocratic governance of the past and a potential shift toward a more inclusive and reformist approach.

However, the challenges of uniting a deeply fractured nation remain formidable. Control of Syria is fragmented among Kurdish forces, remnants of opposition groups, and radical Islamist factions, creating an environment rife with instability. For millions of displaced Syrians, enduring poverty and lacking access to basic services, the road to recovery seems long and arduous. The shattered Syrian economy further complicates matters, demanding immediate stabilization alongside long-term reconstruction.

The role of the Central Intelligence Agency (CIA) in the downfall of Assad's regime is a critical but contentious aspect of this transition. The CIA's covert operations, including the controversial Operation Timber Sycamore, aimed to destabilize Assad's government by arming and training selected rebel groups. These efforts, coupled with intelligence activities, cyber warfare, and psychological operations, significantly undermined Assad's grip on power. However, the unintended consequences of such interventions, including the empowerment of extremist factions, illustrate the complexities of foreign involvement in Syria's internal conflicts. For the United States, the strategy yielded geopolitical advantages by curbing Iranian influence, limiting Russia's presence in the region, and advancing counterterrorism objectives. Yet, these gains must be weighed against the long-term instability they may have exacerbated.

Prime Minister al-Bashir has outlined a comprehensive roadmap for Syria's recovery, addressing political, economic, and social dimensions. Politically, he has prioritized forming a transitional government that includes representatives from Syria's diverse ethnic and political communities. Drafting a new constitution, with provisions to decentralize power and protect minority rights, is a cornerstone of this vision. Economically, al-Bashir's administration aims to rehabilitate Syria's devastated infrastructure, attract foreign investments, and combat entrenched corruption to pave the way for sustainable growth. On the social front, reintegration programs for displaced populations and former combatants are essential components of his strategy, alongside expanded healthcare and education initiatives to address the needs of waraffected communities.

The implications of Assad's fall and al-Bashir's ascent reverberate beyond Syria's borders. Regionally, these developments may recalibrate power dynamics in West Asia, diminishing Iran's influence in Syria while creating opportunities for rapprochement with Israel. Cooperation on border security and potential economic partnerships could emerge as key areas of mutual interest.

Globally, Russia's diminished role in Svria marks a strategic setback for Moscow. Strained by its involvement in Ukraine and the impact of Western sanctions, Russia's resource constraints have forced a recalibration of its Middle Eastern strategy, leaving a void that other powers may seek to fill. Meanwhile, China may view Syria's reconstruction as an avenue to expand its Belt and Road Initiative, potentially deepening its influence in the region.

Security concerns loom large in the wake of Assad's departure. The power vacuum left behind creates opportunities for extremist groups like ISIS and al-Qaeda to regain a foothold, threatening both regional and global stability. The ongoing refugee crisis, driven by persistent instability, poses additional challenges for neighboring countries and Europe. Furthermore, proxy conflicts fueled by regional rivalries and geopolitical tensions risk entangling Syria in broader frictions. This precarious situation underscores the necessity of a coordinated international response to support Syria's transition and mitigate the risks of renewed violence.

The fall of Assad's regime also reflects the shifting dynamics of Russian involvement in

Syria. Since its military intervention in 2015, Russia had been a staunch supporter of Assad, providing critical military and economic aid to sustain his rule. However, the prolonged conflict, coupled with domestic criticism and financial strain, led the Kremlin to scale back its commitments. This retreat not only weakened Assad's position but also signaled a broader recalibration of Russia's strategy in the Middle

For Syria's new leadership, navigating these complexities will require balancing domestic reforms with international cooperation. Prime Minister al-Bashir's focus on inclusivity, economic revitalization, and social healing offers a blueprint for progress, but the success of these initiatives hinges on overcoming entrenched challenges. Domestic unity, underpinned by trust-building measures and equitable representation, is critical for sustainable governance. Simultaneously, the international community must provide robust and sustained support, ranging from humanitarian aid to investments in recon-

struction and security. Syria's transition from Assad to al-Bashir represents a pivotal moment, laden with both opportunity and risk. While the path to stability and prosperity is fraught with obstacles, a concerted effort by domestic actors and global partners holds the potential to guide Syria toward a more peaceful and resilient future. The coming months will be critical in determining whether this new chapter in Syria's history leads to enduring progress or further turmoil. Rice water contains the nourishing antioxidant ferulic acid, as well as allantoin, an organic compound that helps soothe and heal the skin during freezing temperature. Rice water has inositol, a carbohydrate that can repair hair damaged due to extreme weather conditions and dryness during winters. It can strengthen the roots, make it smooth and silky by combating the losses due to natural atmospheric conditions.

It is commonly available in every home in India. From ancient times, when cosmetics were not available, such natural ingredients were used for beauty care.

Rice water is a natural skin toner which promotes cell growth, stimulates blood flow and keeps the skin smooth and bright in chilly weather conditions.

You can use rice water cubes to boosts collagen and nourish, refresh skin. Put rice water into the ice tray and freeze it. Add cucumber too. Apply these ice cubes onto the face and uncovered areas around the face, neck and un-



Witch-hunts: Assam's hidden horror

Titch-Hunt, an inhuman and superstition-based practice, still a harsh reality in Assam. However, this barbaric custom still prevails, in the state's rural and tribal regions, where the women (and men) are purported to be practicing witchcraft and subjected to cruelest treatment. This unseen horror, not only opens up the ways in which deep-seated prej udic es pervade Assamese society, but also expresses the ways in which poverty, gender inequality, and the unavailability of education and health care are deeply flawed. The recurrence of witch-hunts is a painful lesson in the gap between advancement and the persistent hold of superstition over susceptible populations.

Community paranoia and mistrust often manifest with outward signs of witch-hunting along with poverty and illiteracy. In many Assamese villages, when no other explanation is found for a sudden death, crop failure, or illness, accusations of witchcraft begin as part of a scapegoating process. Traditional healers (òjà) are very central figures in perpetuating such beliefs. They explain natural occurrences to be supernatural, raising further suspicion. This phenomenon thrives in areas with minimal reach to science and medicine supplies, where explanations of sorrows are still founded upon folklore and myth. Upon the naming process, the accused persons are

ground for superstitious acts. Lack of proper training and knowledge will definitely help time-old notions rule in dayto-day activities of society. In such circumstances, accusations of witchcraft can frequently be used as a tool to administrate social phobias, leading to a dreadful death for the victim and family members that are not called for.

Measures for checking witch-hunting activities in Assam have seen some partial achievements. The landmark achievement is the Assam Witch Hunting (Prohibition, Prevention, and Protection) Act of 2015 has criminalized the act, which has strict punishment mechanisms against those indulging in accusations, violence, or ostracizing others. Also rehabilitating victims and educating society about the dangers of such practices, by law. Enforcement has been patchy, and even where societal complicity is strong, the legislation is having limited impact. Victims tend to be reluctant to report events because they may fear reprisal, and cultural normalization of witch-hunts in the countryside inhibits inquiry. Besides, the lack of coordination among law enforcement agencies, local authorities and community leaders has been a constraint to the effect of such legal instruments.

Education is an important means of debunking the superstition that underpins witch-hunting. However, the challenge goes beyond merely increasing literacy rates. It includes the task of raistraditional healers, thereby diminishing their power on the community belief.

Economic empowerment is key in combating witch-hunting. Thereby, poverty and economic disruption enhance the polarization of communal and interpersonal conflict, increasing the likelihood that people will engage in violence. Alternative livelihoods, skill development programs, and financial support can alleviate the economic pressures that often underlie accusations of witchcraft. The empowerment of women economically is of highest importance, because captivity is diminished on women's side and consequently power is increased, such that women are

better able to resist societal oppression. Civil society groups and campaigners have played a vital role in bringing attention to witch-hunting and rescuing victims. Individuals like Padmasri Late Birubala Rabha, a renowned anti-witchhunting activist, have dedicated her lives to fighting this practice. These grassroot efforts have saved so many lives and made the country and the rest of the world aware of the phenomenon. Such approaches also validate the need to approach entrenched behavioral patterns at community levels. Organizations and NGOs have to be developed in their mobilization activities aimed at educating, rehabilitation, and lobbying for victimized parties.

It is also imperative that media houses play an important role in combating this

form of witch-hunting. Through the medium of the nedia, the survivor stories can be brought to the fore and the root causes of the violence highlighted, thereby galvanizing the attention of the public to the matter. Nevertheless, reporting of witchcraft must be carried out with delicacy to avoid the sensationalization or its re-victimization of the victims. Equitable and thoughtful coverage can help to overcome societal misconceptions and push for suptowards anti-witch-hunting

The witch-hunting in Assam is a black mark of its people's socio-cultural aspect. It is symbolic, not just of the failings of contemporary governance, but of a rupture of values of compassion and of justice. Stopping this kind of practice requires a multipronged response involving law, education, health care, and economic autonomy. It requires an active participation of governmental bodies, NGO, and grassroots communities to tackle those structural inequalities that feed the

re criminal law provisions relating to the payment of maintenance by husbands to their wives and cruelty by a husband against his wife being weaponised against men? The suicide of 34-year-old Atul Subhash on Monday led to this discourse gaining traction on news debates and social

In a 24-page suicide note and 81-minute video, Subhash alleged harassment by his wife through the filing of false cases against him for cruelty as well as monthly maintenance.

However, lawyers and academics that Scroll spoke with provided an alternative view to the popular narrative of the laws being weaponised. It is often difficult for women to pursue maintenance in courts and file complaints of cruelty by the husband with the police, they

Pointing to the high rate of domestic violence faced by and suicide among married women, they said that rather than misuse, these laws are actually not being used enough by women.

Rationale for such laws Article 15(3) of the Constitution of India enables the state to make special legal provisions for women and children. This affirms the social reality of discrimination faced by women in Indian society, according to Delhi-based criminal lawyer and writer Abhinav Sekhri. "The provisions relating to maintenance and cruelty discriminate in favour of women because our society discriminates against women," he said.

Mumbai-based women's rights lawyer Flavia Agnes agreed. "A woman has to leave her family after marriage and moves in with a new family,' she said. "She is in an especially vulnerable position and needs laws to protect her.'

Bengaluru-based legal academic Sarasu Esther Thomas, who specialises in family law and gender, explained the rationale for Section 85 of the Bharatiya Nyaya Sanhita - the replacement for Section 498A of

husband.

Cruelty consists of both physical violence and mental harassment, including the demand for dowry. Maintenance can be demanded by any woman unable to maintain herself.

"Maintenance is needed because of the lack of social security for women," Thomas said. She pointed out the gender disparity in education, the burden of care and domestic work on women and the social pressure on wives to leave work after marriage. All these result in the wife becoming economically dependent on her husband.

Calling the provision "essential" and "understanding of the reality of India", she said that

breakdown of a family does not leave women destitute and allows her and her children to, as far as possible, maintain the standard of living they are accustomed to.

As for the cruelty law, she said that violence against women in the marital home is so widespread that ordinary criminal law provisions were not adequate to deal with it and a separate legal provision was needed. "The latest National Family Health Survey shows that nearly one-third of all married women face spousal violence," she said. "Do one-third of all married women file cruelty cases against their husbands?" she asked. "This indicates that the law is underused," she said.

A lack of implementation Experts familiar with these laws told Scroll that, far from weaponisation, in reality it is quite difficult for women to avail of the remedies of maintenance and cruelty from the criminal justice system.

When it comes to maintenance, women must face a long and arduous process in courts. Sekhri said that even in Delhi.

"where the courts are much more gender-sensitised and accessible than most other parts of the country, it is by no means easy to file maintenance cases and get favourable orders." He pointed out that court take multiple hearings and intensely scrutinise all evidence and documents. "Courts don't rush to conclusions in such cases," he said.

Agnes said that "it takes a lot of time and money to file maintenance cases and get favourable orders and then to have them enforced or executed".

Delhi-based lawyer and women's rights researcher Mihira Sood told Scroll that the maintenance amount granted is usually "paltry and unrealistic" She said that "the process of legally securing maintenance is punishing for women."

In cruelty cases, the police is reluctant to register first information reports and both the police and courts push women to arrive at a "compromise" and withdraw the case, according to the experts Scroll spoke with. "Police doesn't register a first information report unless the complainant has physical injuries and is accompanied by a lawyer or a social worker,' Agnes said. She added that even though harassment is part of cruelty as per the law, the police don't consider it sufficient and don't register cruelty complaints when there is no element of physical violence. The gendered character of the witchhunt is particularly salient. Women, especially widows or single mothers or women offending against paternalistic norms are overrepresented in the target population. Their socio-economic disadvantages exacerbate the susceptibility open to false accusations. These women are silenced or punished for reasons that have little to do with superstition and more to do with property disputes, personal vendettas, or attempts to suppress their autonomy. Witch-hounding is therefore not a practice of ignorance, but systemic oppression where long-standing patriarchal control is implemented through violence and terror.

Schools in the country are required to adopt the teaching of rational thinking and human rights in order to breed a cohort opposed to these

Health care is another important area in this campaign. Many of the cases of witchcraft result from the inability to cure or to diagnose diseases, particularly from rural areas where the medical facilities are either lacking or too expensive. Enhancement of the rural health facilities, provision of mobile health units, and educating the population about health conditions can alleviate unsubstantiated accusations against the witch-wearing individuals. Accessible health care relieves the dependence of

In as much as it is Assam's battle against witchcraft, it is also essentially a battle for its identity. It becomes difficult to come to an agreement over the war of tradition of and progress, traditional thinking and modern science. The answer to this veiled horror would be closer to the human dignity and equality society in Assam. The road ahead is long, but sustained efforts can help the state come out of the darkness of witchhunting and provide hope to those who have suffered under its shadow. MOSCOW, Dec 17: A senior Russian general was killed Tuesday by a bomb hidden in a scooter outside his apartment building in Moscow, a day after Ukraine's security service levelled criminal charges against him. A Ukrainian official said the service carried out the attack.

Lt. Gen. Igor Kirillov, the chief of the military's nuclear, biological and chemical protection forces, was killed as he left for his office. Kirillov's assistant also died in the attack.

Kirillov, 54, was under sanctions from several countries, including the UK and Canada, for his actions in Moscow's war in Ukraine. On Monday, Ukraine's Security Service, or SBU, opened a criminal investigation against him, accusing him of directing the use of banned chemical weapons.

An official with the SBU said the agency was behind the attack. The official, who spoke on condition of anonymity because they were not authorised to release the information, described Kirillov as a war criminal and an entirely legitimate target.

The SBU has said it recorded more than 4,800 occasions when Russia used chemical weapons on the battlefield since its full-scale invasion in February 2022. In May, the US State Department said that

Russia has denied using any chemical weapons in Ukraine and, in turn, has accused Kyiv of using toxic agents in combat.

Kirillov, who took his current job in 2017, was one of the most high-profile figures to level those accusations. He held numerous briefings to accuse the Ukrainian military of using toxic agents and planning to launch attacks with radioactive substances claims that Ukraine and its Western allies rejected as propaganda.

The bomb used in Tuesday's attack was triggered remotely, according to Russian news reports. Images from the scene showed shattered windows and scorched

Russia's top state investigative agency said it's investigating Kirillov's death as a case of terrorism, and officials in Moscow vowed to

punish Ukraine. Dmitry Medvedev, deputy head of Russia's Security Council chaired by President Vladimir Putin, described the attack as an attempt by Kyiv to distract public attention away from its military failures and vowed that its senior military-political leadership will face inevitable retribution.

Over the past year, Russia has been on the front foot in the war in Ukraine, grinding deeper into the eastern region of Donetsk region despite heavy losses. Ukraine tried to change the dynamic with an incursion into Russia's Kursk region, but it has continued to slowly lose

Taipei mayor calls for less confrontation with China

TAIPEI (TAIWAN), Dec 17: The China-friendly mayor of Taiwan's capital, Taipei, on Tuesday called for less confrontation between the sides, even as Beijing continues to send warships and fighter jets to intimidate the self-governing island

Chiang Wan-an was speaking Tuesday at the 15th Taipei-Shanghai Twin-City Forum, which is not sanctioned by Taiwan's government, whose official position is that Taiwan is already an independent country with no reason to unify with China.

Chiang put a somewhat romantic twist on his remarks, saying "I am a Taipei mayor elected by the people. I have high expectations for whether there is peace, tension, or development across the strait. I think there should be more ... lights on fishing boats at dawn and less noise of (war) ships and (war)

Between Monday and Tuesday, China sent 10 military aircraft and seven aircraft toward Taiwan, according to Taiwan's Defence Ministry. Four of the aircraft crossed the middle line of the Taiwan Strait that forms an unofficial border between the sides. China considers Taiwan part of its territory, to be brought under its control by force if necessary, although economic ties between the sides — especially with China's financial hub of Shanghai — remain robust, with an emphasis on high-tech.

Shanghai's representative, Vice Mayor Hua Yuan, told the 102 participants that, "the people of the two sides are all one family.'

Taiwan banned nine Chinese re-

porters from the gathering, saying they were superfluous, along with a Shanghai official for Taiwan affairs, in response to new, harsh new penalties targeting "diehard Taiwan independence separatists." Taiwan's Mainland Affairs Council said Beijing's move had severely disrupted already meagre bilateral exchanges and put Taiwanese residents in China at risk. Faced with China's massive military, Taiwan has been upgrading its defences with latest version F-16 fighter jets, missiles, submarines and artillery. (AP)

Magnitude 7.3 earthquake causes widespread damage in Pacific island nation of Vanuatu

ZEALAND), Dec 17: A powerful magnitude 7.3 earthquake struck just off the coast of Vanuatu on Tuesday, causing widespread destruction in the South Pacific island nation as the injured began arriving at a hospital and unconfirmed reports of casualties emerged.

A tsunami warning was called off less than two hours after the quake. With communications still down hours later and official information scarce, witness accounts of casualties began to surface on social media and through patchy phone calls.

The earthquake happened at just before 1 pm at a depth of 57 kilometres and was centred 30 kilometres west of Port Vila, the largest city in Vanuatu — a group of 80 islands that is home to about 3,30,000 people. It was followed by a magnitude 5.5 aftershock near the same location, with tremors continuing throughout the afternoon and evening.

It was not immediately clear how much damage was caused as phone lines and government websites remained down. In the first official information published on social media, the Geohazards Department said its monitoring systems remained offline due to power outages.

Residents were urged to stay away from coastlines for at least 24 hours — and until tsunami and earthquake monitoring systems were operational once again. No confirmed reports of damage or casualties were provided, but accounts detailing widespread destruction filtered out on social media and in interviews.

Dan McGarry, a journalist based in Port Vila, told The Associated Press he heard of one death from a police officer outside Vila Central Hospital. McGarry saw three people on gurneys "in obvious distress," he said.

Doctors were working "as fast as they could" at a triage centre outside the emergency ward, he added. But the nation is not equipped for a mass casualty event, McGarry said.

Video shared by the Vanuatu Broadcasting and Television Corporation showed crowds outside



the hospital. Phone numbers for the police, the hospital and other public agencies did not connect.

A video posted on social media appeared to show crumpled buildings in Port Vila, including one that had collapsed onto its lower floors and cars parked on the street below. Amanda Laithwaite said her husband was among a group of rescuers attempting to shift the roof of the three-story building because they believed people were trapped inside, but their progress was slow without specialist machinery.

Elsewhere, a building housing a number of diplomatic missions in Port Vila — including those of the United States, Britain, France and New Zealand — was significantly damaged, several of its tenants said. But there were no reports of embassy staff unaccounted for. **Buckled windows and debris**

The US Embassy's Facebook page said all staff were safe, but the building was closed until further notice. The office had only opened in July, as part of a wider push by the US to expand its Pacific presence in order to counter China's burgeoning influence on governments in the region.

Australia's foreign ministry also said its workers were safe.

A video on social media showed the building with some damage to its structure, including buckled windows and debris that had crumbled from walls to the ground. Other photos and videos showed items and shelves that had tumbled to the floors of shops and landslides that appeared to block some

"We haven't heard at the moment about any casualties, but I will be shocked if we don't hear that bad news coming through from Port Vila at some point,' Katie Greenwood, the Fiji-based head of the Asia-Pacific regional office for the Red Cross, told the Australian Broadcasting Corp.

Bangladesh Law Adviser slams Modi's Vijay Diwas post, says India was merely an ally in 1971 victory



DHAKA, Dec 17: Bangladesh interim government's Law Adviser Asif Nazrul has criticised Prime Minister Narendra Modi's post on X commemorating Victory Day saying, "India was merely an ally in this victory, nothing more."

Victory Day or "Bijoy Dibosh" is commemorated every year on December 16 when the Pakistan military surrendered to Indian forces in 1971, bringing about the liberation of Bangladesh.

Nazrul's comment was reposted by the office of Chief Adviser Muhammad Yunus.

Attaching a screenshot of Modi's post that paid tribute to Indian soldiers for their role in the historic victory in 1971, Nazrul wrote on Facebook in Bengali on Monday, "I strongly protest. December 16, 1971, marks Bangladesh's Victory Day. India was merely an ally in this victory, nothing more."

Yunus' Press Secretary Shafiqul Alam shared Nazrul's post, The Daily Star newspaper reported on Tuesday

Anti-Discrimination Student Movement Convener Hasnat Abdullah also criticised Modi's post. Abdullah wrote on Facebook that this was Bangladesh's Liberation War and it was for the coun-

Political strife erupts over South Korean court as it is set to determine fate of impeached Yoon

SEOUL, Dec 17: South Korea's acting leader are directly appointed by the president. Three others vowed Tuesday to convey to the world that things are back to normal following parliament's impeachment of conservative President Yoon Suk Yeol, but mal appointments by the president has widely been rival parties began squabbling over the mechanics a formality. Prime Minister Han Duck-soo, who became acting leader, has taken steps to reassure the US and other countries and stabilise markets. Presiding over a Cabinet Council meeting on Tuesday, Han said he will continuously do my utmost to inform the international society that Republic of Korea is fast regaining stability and maintain confidence with partners.

But the country's intense political strife appears to be far from over, as the rival parties began bickering over whether to fill three vacant justices' seats at the Constitutional Court.

To formally end Yoon's presidency, the ninemember court panel needs support from at least six justices. But since three seats remain vacant following retirements, a unanimous decision in favour of Yoon's impeachment is required to throw him out of office for good. Three of the court's nine justices

are nominated by the Supreme Court head and another three by the National Assembly, and their forare to be nominated by the National Assembly by the Democratic Party and the other by Yoon's ruling People Power Party.

The court can rule on Yoon's case only with the current six justices. But the main liberal opposition Democratic Party, which led the impeachment efforts against Yoon, has said it would speed up the process of restoring the court's nine-justice system to promote fairness and public confidence in its rul-But PPP floor leader Kweon Seong-dong, a Yoon

loyalist, created a stir Tuesday as he voiced his objection to a Democratic Party push to fill the three vacancies. He said it would be inappropriate for Han, the acting leader, to appoint justices nominated by parliament, saying such authorities solely rest with the president.

An acting president can appoint Constitutional Court justices when there is a presidential vacancy, but not when the president's duties are just suspended, Kweon said.

Many observers say the court's current six-member configuration is advantageous for Yoon's chances to return to office, as it would only require a single justice rejecting the parliament impeachment. They note Cheong Hyungsik, one of the six justices, is a clear conservative who was directly appointed by Yoon. (AP)

Trump says it was 'stupid' for Biden to let Ukraine use US weapons to strike deeper into Russia

PALM BEACH, Dec 17: President-elect Donald Trump on Monday suggested that he may reverse President Joe Biden's recent decision to allow Ukrainian forces to use American long-range weapons to strike deeper into Russian terri-

Trump called the decision made by Biden last month "stupid." He also expressed anger that his incoming administration was not consulted before Biden made the move. With the loosening of the restrictions, Biden gave Ukraine longsought permission to use the Army Tactical Missile System provided by the U.S. to strike Russian positions hundreds miles from its bor-

"I don't think that should have been allowed, not when there's a possibility — certainly not just weeks before I take over," Trump said during at a wide-ranging news conference at his Mar-a-Lago resort. "Why would they do that without asking me what I thought? I wouldn't have had him do that. I think it was a big mistake."

Trump's withering criticism of the Biden administration's move comes as the Democratic administration aims to push every last dollar already designated for Ukraine out the door to help repel Russia's invasion before Trump takes office on Jan. 20, with future aid uncer-

But even as Biden tries to surge weaponry and other aid to Ukraine in his final five weeks in office, the moment underscored that it's Trump who holds the most significant influence over how Ukraine can use its U.S.-provided arsenal in the long run. It's a critical piece of leverage he could use to try to follow through on his campaign pledge to bring about a swift end to the conflict. Asked if he would consider re-

versing the Biden administration decision, Trump responded: "I might. I think it was a very stupid thing to do. The White House pushed back

on Trump's criticism, noting that the decision was made after months of deliberations that started before last month's election. "All I can assure you is that in the

conversations we've had with them since the election, and we've had at various levels, we have articulated to them the logic behind it, the thinking behind it, why we were doing it," White House national security spokesperson John Kirby said of the current administration's coordination with the outgoing ad-

Trump's relationship with Russian leader Vladimir Putin has been scrutinised since his 2016 campaign for president, when he called on Russia to find and make public missing emails deleted by Hillary Clinton, his Democratic opponent. Trump publicly sided with Putin over U.S. intelligence officials on whether Russia had interfered in the Trump has praised the Russian leader and even called him "pretty smart" for invading Ukraine.

Vice President-elect JD Vance has said that while the U.S. has differences with Russia, it was counterproductive to approach Moscow as an enemy.

Trump on Monday reiterated his call on both Ukrainian President Volodymyr Zelenskyy and Russian President Vladimir Putin to negotiate an end to the war, calling the death and despair caused by the conflict "carnage."

But Trump also appeared to acknowledge that finding an immediate endgame to the war something he has previously said he could get done within 24 hours of taking office — could be difficult.

"I think the Middle East will be in a good place," Trump said, referring to the conflict in Gaza and an unsettled Syria following the ouster of Bashar al-Assad. "I think actually more difficult is going to be the Russia-Ukraine situation.'

Trump declined to say whether he has spoken with Putin since the election.

Zelenskyy met with Trump in Paris earlier this month, while the president-elect was visiting France for the reopening of the Notre Dame Cathedral. Zelenskyy and other Ukrainian officials have been making a forceful effort to get Trump to maintain support for Ukraine. (AP)





Nadda slams Cong over Preamble amendment 'Bad lot interfered with Constitution many times'

NEW DELHI, Dec 17: Even a good constitution can prove to be bad if those implementing it are not good, Leader of the House in the Rajya Sabha J P Nadda said on Tuesday, asserting the "bad lot" interfered with the Indian Constitution many times.

Participating in a discussion on the "Glorious Journey of 75 Years of the Constitution of India". Nadda attacked the Congress over the Emergency, amendment to the Preamble of the Constitution and also raised the Article 370 issue.

He said the nation is indebted to the members of the Constituent Assembly who shaped the Consti-

"As the prime minister said, India is not just the largest democracy, but the mother of democracy. The architects of our Constitution knew this is not a nation in the making, it was always a nation," said Nadda, who is also the BJP

"As per Indian ethos, democracy comprises freedom, acceptability, equality, inclusivity and allowing citizens to lead a dignified life," he

The BJP leader quoted B R Ambedkar to say "however good a are implementing it are not good, it will prove to be bad". He also said the "bad lot has interfered

with the Constitution many times". Mentioning Article 370, which was abrogated in 2019, the BJP president blamed former prime minister Jawaharlal Nehru and the Congress for bringing it in the first

Ambedkar had opposed the provision of Article 370, while Article 35A was brought in with Presidential assent without a debate in Parliament, Nadda said.

"I am proud to say, Syama Prasad Mookerjee raised the issue of Article 370 and sacrificed his

Nehru Ji and sought an investigation. But that request was ignored and this is also registered in the pages of history," he claimed. "I t is a question of the good lot and the bad lot," Nadda said. "Ambedkar said there was no need to include 'secular', as the entire Constitution embodied the concept of a secular state that meant no discrimination on grounds of religion and equal rights and status of all citizens," he

"On the inclusion of the term socialist, he had said it is against the very grain of democracy to decide what kind of society people of India should live in," Nadda

Voting showed BJP does not have 2/3 majority for constitutional amendment: Tharoor on ONOE bills

NEW DELHI, Dec 17: Congress MP Shashi Tharoor on Tuesday hit out at the government, saying voting at the introduction stage of two bills on simultaneous elections in the Lok Sabha showed the BJP did not have the two-third majority required to pass a constitutional mendment.

Two bills that lay down the mechanism to hold simultaneous elections were introduced in the Lok Sabha after a fiery debate on Tuesday

Opposition parties dubbed the draft laws -- a Constitution amendment bill and an ordinary bill -- as an attack on the federal structure, a charge rejected by the govern-

"We (the Congress) are not the only ones that have opposed this bill. The vast majority of the opposition parties have opposed this bill and the grounds are very many, it is a violation of the federal structure of the Constitution. Why should a state government fall if the central government falls?" he told reporters in the Parliament premises

"Why should the timetable of one who enjoys the mandate of the people be truncated because of the



timetable of another? It makes no sense. In a parliamentary system, you cannot have fixed terms. The reason that fixed terms ended in 1969 is because of the fact that we have in our country a parliamentary system... different Houses, different majorities, different coalitions, may rise and fall at different times," Tharoor said.

He added that going through the trouble of changing the system like this made no sense because it would again result in the same mess when a future government at the Centre or in the states lose the

"My view is that this entire thing is a folly. In any case, the votes today have demonstrated that the BJP does not have the twothird majority required to pass a constitutional amendment." he

Tharoor said the government might constitute Parliament's joint committee in such a way that it has a majority but, without a two-third majority in the House, there would not be a constitutional amendment. "So this discussion is increas-

SFI activists stage protest against Kerala Governor



THIRUVANANTHAPURAM, **Dec 17:** The Kerala University Senate campus here on Tuesday witnessed dramatic scenes as activists of the Student's Federation of India (SFI), the students' wing of the ruling CPI(M), staged a protest against Governor Arif Mohammed Khan while he was attending a seminar.

The ruling CPI(M) and the SFI have been at loggerheads with Governor Khan over various issues

Despite the intense security laid by police, the SFI activists forcefully opened the closed gates of the campus and ran towards the Senate

Hall where Khan was participating

in the seminar. Though the police closed the doors and windows of the seminar hall and prevented the protesters from entering inside, they engaged in a minor scuffle with the law en-

The SFI activists later staged a sit-in at the portals of the Senate Hall. They held a protest march through the campus and went out through the main gate.

SFI leaders, who led the protest, later accused Governor Khan of attempting to "saffronise" universities in the state.

They also criticised him over the

various varsities and warned that it was only a token protest.

Meanwhile, Governor Khan, who came out after inaugurating the three-day-long seminar organised by the Sanskrit Department, lashed out at the reporters when they asked questions about the SFI

When reporters asked why the protesters were not arrested, a fuming Khan told them to ask the question to the city police commis-

"What is my role in it? Why are you asking this question to me? Go and ask the police commissioner. How do I know? I am addressing a meeting," he said.

Accusing the media of not having an interest in academic seminars or in the number of people attending it, the Governor also alleged that it was interested only in disruptive activity.

Fadnavis was in favour of inducting me in cabinet: Bhujbal

MUMBAI, Dec 17: Senior NCP leader Chhagan Bhujbal on Tuesday launched a veiled attack on party president Ajit Pawar over his exclusion from the new council of ministers, claiming Maharashtra Chief Minister Devendra Fadnavis was in favour of his induction in the cabinet. He said Ajit Pawar, the NCP president, makes decisions for the party like Fadnavis for the BJP and Eknath Shinde for the Shiv Sena.

Amid speculation over his "Jahan nahi chaina, wahan nahi rehna" remark a day before, Bhujbal said he would speak on Wednesday after discussing with NCP workers and people from the Yeola constituency.

The prominent OBC leader said he wasn't disappointed about not being made a minister but felt humilated by his treatment.

Speaking to reporters in Nashik, Bhujbal claimed that he was asked to contest Lok Sabha elections in May but his name was never finalised. Weeks after winning assembly elections from Yeola seat, Bhujbal said he was recently offered a Rajya Sabha seat.

"I accepted the suggestion to contest Lok Sabha elections from Nashik. When I wanted to be in the Rajya Sabha earlier this year, I was asked to fight the assembly elections. I was offered a Rajya Sabha seat eight days ago which I rejected.

'They didn't listen to me then, now they are giving it (Rajya Sabha seat). Am I a toy in your hands? he asked. Do you think whenever you tell me I will stand up, whenever you tell me I will sit down and contest the elections? What will the people in my constituency feel if I resign? he questioned.

"I have confirmed that Chief Minister Devendra Fadnavis insisted on my inclusion in the state cabinet. The chief of each party in the Mahayuti alliance decides for his party. Fadnavis for BJP, Eknath Shinde for Shiv Sena, and Ajit Pawar for NCP," he said.

Fadnavis expanded his cabinet in Nagpur on Sunday and inducted 39 new members in his team — 19 from the BJP, 11 from the Shinde-led Shiv Sena and 9 from Ajit Pawar's Nationalist Congress Party (NCP). (PTI)

"Constructing the ground floor of a house is the hardest. Nehru. Ambedkar and Patel built the foundation. You (BJP-NDA) are constructing the second and third

Badlapur sexual assault case probe complete

MUMBAI, Dec 17: The Badlapur sexual assault case investigation is over and a senior police officer has been suspended for dereliction of duty, the Maharashtra government told the Bombay High Court on Tuesday.

Two charge sheets have been filed against the slain accused in the case and trustees of the school, the HC was told.

Two police constables were given a strict warning for not taking the case seriously.

Public Prosecutor Hiten Venegaonkar, appearing for the Special Investigation Team (SIT) which investigated the case, told a division bench of Justices Revati Mohite Dere and Prithviraj Chavan that the probe was complete and the SIT disbanded.

Two girls, aged four and five, were allegedly sexually assaulted in the toilet of their school in Badlapur in Thane district by an attendant in August, leading to a huge outrage and staging of protests.

The arrested accused was killed in an alleged retaliatory firing by police when he was being shifted in a police vehicle in September.

A departmental inquiry was initiated against Badlpur police station officials for delay in registering an FIR and investiga-

NEW DELHI, Dec 17: Underlining that the ongoing conflict in the international arena has revealed the "hazards of a hybrid warfare", a parliamentary panel has recommend that the DRDO should expand its R&D efforts to enhance combat readiness against any nonconventional warfare and security

In its report tabled in Parliament on Tuesday, the committee has noted "with concern that out of 55 projects, 23 were not completed within the stipulated time".

"Although, 571 projects worth Rs 34161.58 cr have been successfully completed and closed during the last 10 years (1 Jan 2012 -- till date), with respect to projects which were partially successful or unsuccessful, eight such projects worth Rs 770.31 cr were stage closed during this period," the re-

The report of the Parliamentary Standing Committee on Defence is titled -- 'Action Taken by the Government on the Observations/ Recommendations contained in the Forty-Second Report (17th Lok Sabha) of the Standing Committee on Defence on the subject -- A Re-

Out of 35 monitoring stations, 28 recorded air quality in the 'severe' category while some breached the 450 mark, classified as 'severe

The remaining seven stations recorded air quality in the 'very poor' category, according to the Sameer app, which provides hourly data from the Central Pollution Control Board.

An AQI of 400 or higher is deemed "severe" and it can have an adverse effect on both healthy individuals and people with medical conditions.

The weather department said, "Mainly calm winds prevailed over Delhi during the past 24 hours, bringing down visibility from 800 meters in shallow fog at Palam on Monday to 350 meters in moderate fog at Safdarjung on Tuesday morn-

The ED's case, filed under the Prevention of Money Laundering Act (PMLA), is based on an FIR registered by the cyber crime unit of the Ahmedabad Police in Gujarat. Bank deposits worth ₹ 30 lakh were frozen during the raids apart from seizure of "incriminating" documents, the ED said in a

Magicwin, according to the agency, is a "betting" website "guised" as a gaming portal which is "actually owned" by Pakistani nationals. The operations of this website are mostly handled by Indian nationals working or settled in Dubai, it said.

"The betting games being shown on the website are originally played in the Philippines and other countries which allow betting activities," it said.

However, as per the investigation, the same is "re-telecast" on Magicwin's website by copying the APIs (application programming interface) of the original games. The agency said betting activities llike deposits, placing of betting and withdrawal are "controlled" by the "owners" of Mag-

The ED claimed its probe found that that the money, deposited in the bank accounts by the players/betters, was "diverted" through layers of "shell and mule" bank accounts and further the profit part of the owners were invested in crypto assets, withdrawn in cash or sent to Dubai through Hawala channels.

The winning amounts of the players/betters were transferred to their bank accounts through mer-

and photo-shoots for Magicwin and posted i t on their social media accounts for its "promotion". Advertisements were also done through hoardings out of home (OOH) in various parts of India including Gujarat and Maharashtra, the ED found.

The profits generated by these betting websites is more than 50 per cent of the total deposits made by the players, it said.

The agency said it has conducted as many as 68 searches in this case till now and has seized funds and assets worth a total ₹ 3.55 crore. (PTI)

Budaun court to decide on Dec 24 whether to hear Shamsi masjid vs Neelkanth temple case

BUDAUN (UP), Dec 17: A court in Budaun will on December 24 decide whether a hearing will be held in the Jama Masjid Shamsi versus Neelkanth temple

The dispute started in 2022 when Mukesh Patel, the then convener of Akhil Bharat Hindu Mahasabha, claimed that the Neelkanth Mahadev temple existed at the Jama Masjid Shamsi mosque site.

He sought permission to worship in the structure. Advocate Anwar Alam, representing the Muslim side, on Tuesday said he presented a copy of the Supreme Court order in the court along with the application. He recalled that the Supreme Court ordered on December 12 that in such cases, the lower court should neither pass any order nor take a decision on the survey. Alam said if the lower court cannot pass any order, then there is no justification for hearing such cases. "Such hearings will only waste the court's and our time," he added. While presenting his arguments in the court, the

Hindu side's lawyer, Vivek Render, said the Supreme Court has never said anywhere that the ongoing hearing should be stopped. He said the apex court has clearly ordered that the

cases in which the hearing is going on cannot be stopped, but the lower court cannot issue any kind of order or interim order.

Render also said the Muslim side's lawyers are deliberately presenting such arguments to delay the case so that maximum time can be wasted. (PTI)

BARRACKPORE (WB), Dec 17: Senior BJP leader Arjun Singh on Tuesday met Bangladeshi lawyer Rabindra Ghosh, who has been defending jailed Hindu monk Chinmoy Krishna Das, in West Bengal's North 24 Parganas district and felicitated him for his efforts in standing by the rights of Hindu minorities in Bangladesh.

Ghosh's courage in fighting for justice for Hindu minorities in Bangladesh. His relentless efforts, despite threats to his life, inspire us," Singh said after the meeting.

Kartick Maharaj echoed Singh's sentiments, emphasising the importance of standing up for the rights of oppressed communities.

"Rabindra Ghosh's commitment to justice reflects the true spirit of humanity. It is our duty to support him in this cause," Maharaj said. Ghosh expressed gratitude for



the recognition and reiterated his commitment to defending persecuted minorities.

"It is heartening to receive such support. The situation of minorities in Bangladesh is dire, and I will continue to fight against injustice,"

The lawyer also highlighted the "deteriorating" condition of minorities in Bangladesh under the current interim government led by Chief Adviser Muhammad Yunus.

"The interim administration's silence on fundamentalist and violence is alarming. It's a travesty of justice," he added.

Earlier this month, Chinmoy Krishna Das, a spokesperson for the Bangladesh Sammilita Sanatani Jagran Jote, was arrested at Dhaka's Hazrat Shahjalal International Airport.

Denied bail, Das has been sent to jail till January 2 next year.

Ghosh had alleged that Das was booked on false charges for his efforts to rally the Hindu community in Bangladesh.

Human rights groups, including Ghosh's NGO, in Bangladesh have documented several cases of violence, land grabs, and forced conversions targeting Hindus in recent

"The international community must take notice of these atrocities. Unity among minority communities is crucial in demanding their rights," Ghosh said.

The BJP has been critical of the interim government Bangladesh, accusing it of failing to protect minorities. (PTI)

The initiative covers high-end diagnostic tests, life-saving surgeries, and even ambulances, cutting down response times to 18 minutes.



Zakir Hussain could have been young Salim in 'Mughal-e-Azam'

NEW DELHI, Dec 17: Zakir Hussain was seven when he performed in public for the first time. It was around the same time that he met director K Asif on the sets of "Mughal-e-Azam" for what was almost an audition for the role of the young Prince Salim. But

His father, the tabla legend Alla Rakha, intervened and said his son was going to be a musician.

And Hussain, who went on to be one of the most accomplished tabla players in history, fulfilled his father's prophecy.

Hussain died at a San Francisco hospital on Monday due to complications arising from idiopathic pulmonary fibrosis, a lung disease. He was 73. The tabla maestro recalled his early brush with

the movies in Nasreen Munni Kabir's book "Zakir Hussain: A Life in Music".

"Did I tell you that I auditioned for young Prince Salim's role in Mughal-e-Azam?" he is quoted as say-

The filmmaker K Asif

and his father knew each other, both regulars at Mohan Studio. While Alla Rakha was on the studio's payroll, Asif, known for his obsession with detail and grandeur, was busy building the famous 'Sheesh Mahal' set for the song "Jab pyaar kiya toh darna kya"

'Abba's man Friday, Shaukat, took me to Mohan Studio one day. Shaukat has passed away now. Besides working for my father, he would moonlight as a film extra. So Shaukat took me to see Asif Sahib because he

had asked Abba to send me over. I remember they were filming on the Sheesh Mahal set, and I met Dilip

Kumar Sahib there.

"He looked at me, cupped his hands around my face and lifted my chin so that he could take a closer look. He turned to Shaukat and said: 'Asif ke paas le jaana' [Take him to Asif]. So that

was that," reads the book. Before Asif could say anything, Alla Rakha had a change of heart and said, "Nahin, yeh actor nahin banega, yeh music karega. musician hoga (No, he will not become an actor, he'll play music and become a

musician).' "It was hardly a real audition. I don't think there were proper auditions in those days. Someone just looked at an aspiring actor and said: 'Isko le lete hain'

[Let's take him]. No one used to ask the actor to read lines or anything like that. That's not how it was done... I don't know what the outcome was but apparently my father had a change of heart," Hussain recalled.

The young Salim was ultimately played by actor Jalal Agha in the film that released in 1960 and is considered an all-time classic.

Hussain took his father's legacy of tabla to new heights and the silver screen did beckon later on in life. Hussain acted in the Mer-

chant Ivory film production "Heat and Dust", "The Perfect Murder" and "Saaz".

His last screen appearance was in Dev Patel's "Monkey Man", a beautiful scene where Patel's character trains in boxing to the beats of the tabla. (PTI)

Can 'Guru' Gambhir and Nayar offer cogent solutions to technical flaws in batters?

NEW DELHI, Dec 17: Rohit Sharma and Virat Kohli are copping maximum criticism for being walking wickets during the ongoing Test series against Australia but even Shubman Gill, Yashasvi Jaiswal and Rishabh Pant haven't shown the patience needed to survive Down Under, indicating a larger problem.

Patience is a virtue that one develops over time and Kohli had once showed how it's done during his golden phase between 2014 and 2019. KL Rahul, blessed with sound technique, has displayed that during the current series with scores of 77 and 84 in Perth and Brisbane.

In case of Jaiswal, save his second innings knock of 161 at Perth, a shuffle across the crease is making him a candidate for leg-before.

Gill loves to play on the rise outside the off-stump and away from his body and could be impatient when one bowls the stump and even for Pant, a compulsive stroke player, the ball that leaves him from five metre length with adequate bounce, is creating issues.

So, will head coach Gautam Gambhir and his deputy Abhishek Nayar, who is highly regarded in Mumbai cricket circuit for being a "Mind Coach and Life Coach rolled into one", do anything about it? A former India great, who didn't wish to be named, offered his per-

"Not all great players or players of repute happen to be great coaches. They might have done some incredible things as players and knew what to do and how to react during a particular situation,"

Watching the dismissals of especially Kohli in Australia, which seemed like a replay of previous ones, has led to growing concerns. Everyone understands the technical flaw, but can anyone provide the corrective measures to break the rut?

Rohit, barring the England tour in 2021, he does not really have a track record in SENA countries in Tests. But with Kohli, the problem of reaching for deliveries on and outside the off-stump has resurfaced once again and has been a persistent issue for quite some time. Sanjay Manjrekar's tweet is worth taking note of.

"I guess the time has come to scrutinise the role of a batting coach in the Indian team. Why major technical issues have remained unresolved for so long with certain Indian batters?" he

Manjrekar's view raises questions on the role of Sanjay Bangar, Vikram Rathour, and now Navar. Their official designation might be assistant coach, but they essentially are batting coaches.

Devang Gandhi, who was a touring selector between 2016-17 to 2020-21, had a more nuanced take compared to the veteran India star. "It would be very easy to target Nayar as a low hanging fruit or for that matter Gautam," Gandhi, who has coached the Delhi Ranji team and Bengal U-19, told PTI during a conversation.

"But they have just come into system. To discuss or nudge a player, first you need to be around

some kind of mutual trust between the two, you can offer him solutions. But at this level, it is more about the experienced player's own mental make-up.

So what is Kohli's problem? Gandhi, a former Test opener and an NCA Level-2 coach, believes it's all about his mental approach.

'...if you watch his training videos that are available for public, I find him doing all the right things. During training he is playing close to his body. But the moment it is the match situation, the hands are moving towards those channel deliveries like conditioned reflex or muscle memory," he explained.

Gandhi then blamed it on the rising T20 engagements.

"The moment his bat is away from the body, the bat-face will open up towards cover. Now this is a white ball problem of hitting through the line. In India the ball will hit the bottom of the bat but in Australia, it will towards the upper part. "What solution can Gambhir or Nayar possibly give, apart from telling him to not play those deliveries? "After 30 Test hundreds, Virat doesn't need to be told that but at 36, does he have that patience to accept that now if he scores a hundred, it will be off 200 balls and not 140 like earlier times? Can he bide those extra 60 balls?," Gandhi questioned.

Sachin Tendulkar's epic 241 in the 2004 New Year's Test in Sydney is often cited as a prime example of patience. He didn't hit a single cover drive until he scored

Women's soccer world champion Spain drawn with Italy, Belgium and Portugal in Euro 2025 group



LAUSANNE, Dec 17: World Cup winner Spain will chase a sweep of major women's soccer titles at the 2025 European Championship after drawing a group with Italy, Belgium and Portugal.

A European title would complete the set for Spain women after winning the inaugural UEFA Nations League in February for coach Montse Tomé, who took over when the team and federation was in turmoil after the 2023 world title win in Sydney. Tomé is the only female coach in Spain's Euro 2025 group.

Euro 2025 host Switzerland will open the 16-nation tournament against Norway on July 2 in Basel. The group also includes Iceland and Finland.

The past two European champions, titleholder England and Euro 2017 winner the Netherlands, landed in a strong group with topseeded France and Wales.

France and England reunite next July 5 in Zurich after coming through the same qualifying group, in which they traded away wins in a five-day spell and France finished on top of the standings.

"We had some beautiful matches in May and June. It's a very good challenge," France coach Laurent Bonadei said.

Germany, the record eight-time European champion, was drawn with Denmark, Poland and Sweden, the inaugural winner in 1984. Basel's St. Jakob Park stadium

also will host the final on July 27. More than 700,000 tickets are publicly available for the 31 games being hosted in eight Swiss

Switzerland has the responsibility to continue the momentum in European women's soccer after three successful major tourna-

DOHA (QATAR), Dec 17: Real Madrid star Vinícius Júnior is about to find out if he'll be finally getting his hands on a big global

FIFA's "The Best" awards take place on Tuesday, when the top men's and women's soccer players of 2024 will be announced based on voting by fans, the current captains and coaches of all national teams, and media representatives. It is FIFA's version of the older and more prestigious Ballon d'Or prize.

Vinícius is on an 11-player shortlist for the best men's player, having been so disappointed to lose out to Manchester City mid-fielder Rodri for the Ballon d'Or in October that he and his Madrid team snubbed the ceremony in Paris in protest.

The FIFA ceremony starts at 1700 GMT in Doha, where Madrid and Vinicius traveled on Monday for the Intercontinental Cup final

Rodri is also on the shortlist, along with Kylian Mbappé and Lionel Messi — last year's winner of the FIFA prize on a tiebreaker over Erling Haaland.

Barcelona playmaker Aitana Bonmati won the best women's player for 2023 and is seeking back-to-back FIFA prizes as one of four Spain players on the 16-woman shortlist.

Bonmati has won the Ballon d'Or for two straight years, and won the Spanish league, Spanish cup and Champions League with Barcelona in 2024.

The contenders have been selected based on their performances from Aug, 21, 2023, to Aug, 10, 2024.

FIFA said the award winners have been decided by an "equally weighted voting system" between fans, the captains and coaches, and the media.

The best men's and women's coaches and the best men's and women's goalkeepers will also be announced, along with the best

men's and women's 11s and the Marta and Puskás Awards for the best goals in women's and men's soccer, respectively.

Among those attending the gala dinner at the Aspire Academy in Doha will be FIFA President Gianni Infantino. (AP)

Rahul has by far looked the most assured Indian batter on the tour and it was on display once again on Tuesday when he produced a gritty 84 off 139 balls in challenging conditions, contributing immensely to the visitors' 252 for nine on day four of the third Test here.

After India managed to avoid followon in the rain-hit game, Rahul turned up for the media interaction and was expectedly asked about his style of play compared to the struggling Indian lot.

"See I'm quite certain that everybody has their own set plans... You also need to have a bit of luck as a top-order

"Just a little bit that goes your way if you can get through those first 10-15 overs and get a bit of confidence then you start feeling good and you start enjoying playing with the Kookaburra ball with the pace and bounce here in Australia," said Rahul who has reaped the benefits of playing close to his

Rahul has been a picture of patience and perseverance in the BorderGavaskar Trophy while the other Indian batters have been found wanting against the new ball.

What has made Rahul's success more remarkable is that he was not the firstchoice opener before the start of the series. He did well in the first Test and then skipper Rohit Sharma decided to drop himself down the order.

The classy right-hander said it is all about sticking to the basics in overseas conditions and that includes giving due respect to the bowlers when the ball is hard and new.

"It's just about getting through those first 20-30 balls for everybody and everyone's trying their best to do that and it's a long series. So we played three games five innings now, so I'm sure everyone will go back and come up with their own plans the next time we bat.

"The only thing you can do in the first 30 overs is to tighten up your defence, try and respect that the first 30 overs is the bowler's time and give them their time, leave balls, try and play as tight as possible and then really try to cash in once the ball gets older. So that's my plan, and that's pretty simple, and I'm sure that's the plan for everybody.'
