AGARTALA, Dec 21: Union Home Minister Amit Shah on Saturday said the time has come for a change in the approach of the police force with the end of insurgency in the northeast, in order to ensure that

people get speedy justice. Shah, addressing the 72nd plenary of the North Eastern Council (NEC) here, said Prime Minister Narendra Modi has brought peace in the region by inking 20 peace accords in 10 years, leading to the surrender of 9,000 armed militants.

"The police fought the insurgency in the northeast for the past four decades. As insurgency has now ended, we need to change the approach of the force to ensure people get justice within three years of lodging FIRs," he said.

The home minister also said connectivity is no longer a problem in



GUWAHATI: The Guwahati Police successfully cracked down on vehicle theft, arresting two individuals in separate operations conducted by the city's police teams, the officials informed on Saturday. In the first operation, a team from the Gorchuk Police Station under the West Guwahati Police District (WGPD) apprehended a veteran criminal, Pranab Ronghang, during a raid in a luxury apartment on VIP Road. India's bid to become

NEW DELHI, Dec 21: India and Russia have decided to step up joint efforts in dealing with the challenges of radicalisation and terror financing.

Ways to deepen cooperation in tackling threats of terrorism were discussed at a meeting of the India-Russia joint working group (JWG) on counter-terrorism cooperation.

At a separate meeting on issues relating to the United Nations, Russia reiterated its support for India as a permanent member of a reformed JN Security Council.

The meeting took place in Moscow on December 19 and 20. "In the 13th JWG on counter-terrorism, both sides shared their experiences in countering terrorism including cross-border terrorism, extremism, and agreed to enhance cooperation to address problems of radicalisation as well as terror financing," the ministry of external affairs (MEA) said on Saturday.

"They discussed current terrorist threats at the global and regional level and combating the use of new and emerging technologies for terrorist purposes," it said in a statement. The MEA said both sides reaffirmed their commitment to strengthening counter-terrorism co-

operation in bilateral as well as multilateral platforms.

India and Russia also held the sixth round of consultations on UNrelated issues in Moscow. "In the consultations on UN-re-

lated issues, both sides exchanged views on regional and global developments and issues pertaining to the UNSC (UN Security Council), including its reform," the MEA said. "Russia reiterated its support for India as a permanent member of a reformed UN Security Council," it said, Tanmaya Lal, secretary (West) in the MEA, led the Indian delegation at the JWG on Counter Terrorism (CT) (CONTD. SpaDeX Mission: ISRO says launch IFSR 2023 records 25.17% increase in forest and tree cover in the country Assam witnesses decline in forest and tree cover vehicle moved to First Launch Pad

GUWAHATI, Dec 21: The Indian State of Forest Report (ISFR) 2023 released on Saturday showed a decline in the forest and tree cover in Assam by 83.93 sq km since 2021.

Assam and other Northeastern states other than Sikkim and Mizoram witnessed a decline in forest and tree cover, although the total forest and tree cover of the country has increased compared to 2021.

Assam also witnessed a decline of forest cover inside the Recorded Area/Green Forest wash (RFA/GW) by 86.66 sq Km. Other states which saw the maximum decrease of forest cover inside the RFA/GW are Tripura (116.90 sq km) followed by Telangana (105.87 sq km), Andhra Pradesh (83.47 sq km), and Gujarat (61.22 sq km).

The States showing the maximum increase of forest cover in-

However, Mizoram saw an increase in tree and forest cover by 178.42 sq km. Similarly, Sikkim saw an increase in greenery by 2.88 sq km.

The total forest and tree cover of the country has increased by 1445.81 sq km as compared to the last assessment of 2021. The current assessment shows an increase of 156.41 sq km in the forest cover at the national level as compared to the previous assessment, the ISFR stated.

The total forest and tree cover of the country is 8,27,356.95 sq km which is 25.17% of the geographical area of the country. The total Forest Cover has an area of 7,15,342.61 sq km (21.76%) whereas the Tree Cover has an area of 1,12,014.34 sq km (3.41%).

BENGALURU, Dec 21: The launch vehicle of India's SpaDeX mission has been integrated and moved to the first launch pad of Satish Dhawan Space Centre, Sriharikota, ISRO said on Saturday.

This mission is intended to develop and demonstrate a technology needed to dock and undock spacecraft in space, apart from other things. "The launch vehicle has been integrated and now moved to the First Launch Pad, for further integration of satellites and launch preparations," ISRO said in a post on the social media X.

SpaDeX mission is a cost-effective technology demonstrator mission for the demonstration of 'in-space docking' using two small spacecraft launched by PSLV, ISRO



tion (BAS), ISRO stated in an explainer.

In-space docking technology is essential when multiple rocket launches are required to achieve common mission objectives. Through this mission, India is marching towards becoming the fourth country in the world to have space docking technology, it added. After the successful launch of the PSLV-C59/Probas-3 mission on December 9, ISRO chairman and secretary of the department of space, S

Somanath said a similar mission was coming up with the launch of PSLV-C60 in December itself.

"It (The PSLV-C60 mission) is going to demonstrate the space docking experiment called SpaDex. The rocket is ready now and we are getting ready for the final stage of activities leading to the launch, possibly in December itself," Somanath had said

According to the ISRO, SpaDeX mission consists of two small spacecraft (about 220 kg each) to be launched by PSLV-C60, independently and simultaneously, into a 470 km circular orbit at 55 ° inclination, with a local time cycle of about 66 days. SpaDeX mission was floated to develop and demonstrate the technology needed for rendezvous, docking, and undocking of two small spacecraft (SDX01, which is the Chaser, and SDX02, the Target. nominally) in a low-Earth circular orbit, the explainer added. GST Council postpones decision to cut tax on insurance, rate panel defers report submission

JAISALMER, Dec 21: A GST Council meeting on Saturday postponed a decision on reducing taxes on health and life insurance, while the much talked- about GoM recommendation of rate rejig in 148 items was not tabled before the Council

Some members of the Council, chaired by Union Finance Minster Nirmala Sitharaman and comprising her state counterparts, felt that more deliberations were required before a final decision could be arrived at with regard to insurance taxation.

Bihar Deputy Chief Minister Samrat Chaudhary, who heads the panel on GoM on insurance, said one more meeting is required to take a call on taxation of group, individual, senior citizen's policies. "Some (Council) members said more discussions required. We (GoM) will meet in January again," Chaudhary told reporters here.

Besides, the report of the GoM on rate rationalisation, which had recommended tweaks in 148 items, was not tabled before the Council. "We will submit the GoM report on rate rationalisation in next meeting of Council," said Chaudhary who is the convenor of the panel.

The ongoing Council meeting will also deliberate on bringing Aviation Turbine Fuel (ATF) in Goods and Services Tax fold.

Several proposals of Fitment Committee, comprising officials from the Centre and states' GST



departments would come up for review before the Council.

One of the proposals include cutting taxes on food delivery platforms like Swiggy and Zomato, to 5 per cent (without input tax credit), from the current 18 per cent (with ITC).

It is likely to have proposed a rate hike on sale of used EVs as well as small petrol and diesel vehicles to 18 per cent from the current 12 per cent. This hike would bring used and old smaller cars and EVs at par with old larger vehicles, according to sources.

Also, the Group of Ministers (GoM) on GST compensation cess is likely to get a six-month extension till June 2025, to submit their report. The compensation cess regime comes to an end in March 2026, and the GST Council has set Union Minister of State for Finance Pankaj Chaudhary, to decide

the future course of the cess. The GoM on insurance had recommended exempting insurance premiums paid for term life insurance policies from GST. Also premium paid by senior citizens towards health insurance cover has been proposed to be exempted

from the tax. Besides, GST on premiums paid by individuals, other than senior citizens, for health insurance with coverage of up to ₹ 5 lakh is proposed to be exempted.

However, 18 per cent GST will continue on premiums paid for policies with health insurance cover of over ₹ 5 lakh. The GST rate rationalisation GoM report, which has suggested rate tweaks in 148 items, was not tabled before up a panel of ministers, under the Council and would be taken up per cent from 12 per cent. (PTI)

arrived at a consensus to hike tax on sin goods, like aerated beverages, cigarettes, tobacco and related products, to 35 per cent from the present 28 per cent.

Currently, GST is a four-tier tax structure with slabs at 5, 12, 18 and 28 per cent. Luxury and demerit goods are taxed at highest bracket of 28 per cent, while packed food and essential items are at the lowest 5 per cent slab

The GoM had also decided to propose rationalising tax rates on apparel. As per the decision, readymade garments costing up to ₹ 1,500 would attract 5 per cent GST, those between ₹ 1,500-10,000 would attract 18 per cent. Garments costing above ₹ 10,000 would attract 28 per cent tax.

Currently, garments costing up to ₹ 1,000 attract 5 per cent GST, while those above that attract 12 per cent. The GoM also proposed hiking GST on shoes above ₹ 15,000/pair from 18 per cent to 28 per cent. It also proposed hiking the GST rate on wrist watches above ₹ 25,000 from 18 per cent to 28 per cent

The GoM had proposed reducing GST on packaged drinking water of 20 litre and above to 5 per cent from 18 per cent, and reducing tax rate on bicycles costing less than ₹ 10,000 to 5 per cent, from 12 per cent. Also, GST on exercise notebooks would be reduced to 5



JAISALMER, Dec 21: In a significant move to plug leakage, the GST Council on Saturday approved a proposal to implement the 'Track and Trace Mechanism' for specified evasion-prone commodities, under which a unique mark will be affixed on such goods or packages to trace them throughout the supply chain.

This is to insert an enabling provision in CGST Act, 2017, through Section 148A so as to empower the government to enforce the Track and Trace Mechanism for specified evasion-prone commodities.

"The system shall be based on a Unique Identification Marking which shall be affixed on the said goods or the packages thereof. This will provide a legal framework for developing such a system and will help in the implementation of a mechanism for tracing specified commodities throughout the supply chain," the finance ministry said while listing out decisions taken in the 55th Council meeting here.

"To clarify that in respect of supply of 'Online Services' such as supply of online money gaming, OIDAR services, etc. to unregistered recipients, the supplier is required to mandatorily record the name of the state of the unregistered recipient on the tax invoice and such name of state of recipient shall be deemed to be the address on record of the recipient for the purpose of section 12(2)(b) of IGST Act, 2017 read with proviso to rule 46(f) of CGST Rules, 2017," it said.



With regard to the decision taken about the GST rate on goods, finance minister Nirmala Sitharaman said the Council has decided to cut the rate on fortified rice kernel (FRK) to 5 per cent from 18 per cent and also exempted GST on gene therapy.

Besides, she said, it was decided to reduce the rate of compensation cess to 0.1 per cent on supplies to merchant exporters at par with the GST rate on such supplies and to exempt from IGST imports of all equipment and consumable samples by the Inspection Team of the International Atomic Energy Agency (IAEA) subject to specified conditions

As regards services, she said, the Council decided to exempt GST on the contributions made by general insurance companies from the third-party motor vehicle premiums collected by them to the Motor Vehicle Accident Fund, constituted under section 164B of the Motor Vehicles Act, 1988

This fund is constituted for providing compensation/cashless treatment to the victims of road accidents including the hit and run

In addition, she said, the GST Council recommended no GST on the transaction of vouchers as they are neither a supply of goods nor a supply of services.

The provisions related to vouchers are also being simplified, she said, adding, that the Council recommended to amend the definition of 'pre-packaged and labelled' to cover all commodities that are intended for retail sale and containing not more than 25 kg or 25 litre, which are 'pre-packed' as defined under the Legal Metrology Act, or a label affixed thereto is required to bear the declarations under the provisions of the Act and rules. It was also clarified that no GST is payable on the 'penal charges' levied and collected by banks and NBFCs from borrowers for non-compliance with loan terms. (PTI)

Underlining that The Assam Game and Betting Act, 1970, is in vogue in the state, Saikia, by his appointment as BCCI secretary (acting) is under "direct conflict with the policies" of the state as the primary sponsor of BCCI Men's Team, Dream 11, is being "investigated by several agencies for betting and match-fixing"

The Congress leader pointed out that Saikia was in a "similar peculiar position in the past, where he had to resign from the post of senior additional advocate general of Assam in December 2018 to make himself eligible to contest for the post of secretary of Assam Cricket Association". "In this regard, I pray to your conscience to kindly treat this matter with utmost importance and see it as a serious breach of privileges by a constitutional post holder in the Government of Assam; and accordingly act upon the matter at the earliest," Saikia added.

Responding to the allegation, AG Saikia claimed there was no question of 'office of profit' as both positions in the BCCI and ICC were honourary in nature. "The basic thing is that the positions I am holding in BCCI and ICC are honourary posts. How does the question of 'office of profit' arise?" he said. "If the leader of the opposition is lacking in legal knowledge, I pity him. He is in such a high position in the assembly. The leader of the opposition should know what is an office of profit, and what the requirements are for becoming officebearers in BCCI and the advocate general," Saikia told PTI.

Number of domestic migrants estimated to have lowered by 12 pc since 2011: EAC-PM

NEW DELHI, Dec 21: The number of domestic migrants is estimated to have lowered by around 12 per cent to 40.20 crore between 2011 and 2023, indicating increased economic opportunities across the country, said a report by prime minister's economic advisory panel EAC-PM.

According to a working paper by the Economic Advisory Council to the Prime Minister (EAC-PM), the number of domestic migrants stood at 40,20,90,396 in 2023, which was 11.78 per cent lower compared to the figure registered as per Census 2011.

The paper titled '400 Million Dreams! Examining volume and directions of domestic migration in India using novel high frequency data', said as per Census 2011, the total number of migrants stood at 45,57,87,621.

"Overall domestic migration in India is slowing. We estimate the overall number of migrants in the country, as of 2023, to be 40,20,90,396. This is about 11.78 per cent lower as compared to the number of migrants enumerated as per Census 2011 (45,57,87,621)," it said.

Consequently, the paper said, the migration rate which stood at 37.64 per cent of total population as per Census 2011, is estimated to have reduced to 28.88 per cent.

"We hypothesize that this is on account of availability of improved services such as education, health, infrastructure and connectivity as well as improved economic opportunities in or near in major sources of migration and is an indicator of overall economic growth," noted the paper authored by former EAC-PM chairman Bibek Debroy.

The paper used three high-frequency and granular data sets -- Indian Railway Unreserved Ticketing System (UTS) data on passenger volumes; mobile telephone subscribers roaming data from the Telecom Regulatory Authority of India (TRAI), and district level banking data to understand the likely impact of migration at the places of origin.

Looking at the spatial dimensions of travel, the paper said, the top origin districts are coalesced around major urban agglomera-

tions viz. Delhi, Mumbai, Chennai, Bangalore, Kolkata etc.

Not only is this in line with gravity models of migration but perhaps also is a tentative confirmation of priors i.e short distance migration accounts for the largest share of migrants and that distance has a negative effect on labour flows, it added.

The report also noted that the composition of the top five states that attract maximum number of abad-Kolkata; Paschim Bardmigrants (including intra-state mi-

haman-Howrah; Valsad -Mumbai; Chittoor-Bengaluru Urban, and Surat-Mumbai are the most popular routes for migration between districts," the paper said, adding that this has implications for urban planning as well as for planning of transportation networks.

Using TRAI's mobile phone roaming data, the report finds that April-June is the high months for movement with November-December witnessing secondary highs.

A secondary high in winter time is perhaps indicative of travel around the festival/marriage season. January, on the other hand, appears to be the month of lowest travel, it said.

As per Census 2011, just five states -- Uttar Pradesh, Maharashtra, Andhra Pradesh, Bihar and West Bengal -- together account for about 48 per cent of the total outbound migrants, which includes within-state migrants as well.

Similarly, just five states -- Maharashtra, Uttar Pradesh, Andhra Pradesh, West Bengal and Tamil Nadu -- together account for about 48 per cent of all incoming migrants. This includes within-state migrants as well.

In the period from 1991 to 2001, the compounded annual growth rate of the number of migrants was 2.7 per cent.

This increased to 3.7 per cent during 2001 to 2011. Interestingly, in the period from 1991 to 2001 India's workforce grew from 3.17 crore to 4.02 crore (an annual average growth of 2.6 per cent), whereas from 2001 to 2011, the workforce grew from 4.02 crore to 4.82 crore (an annual average growth of 1.99 per cent). During the 87th annual general meeting of ATPA, Barua suggested that tea planters should be strictly classified into two categories: those who wish to sell their produce through the transparent and non-biased public auction system, and those who prefer private channels.

According to Barua it should be implemented by the Tea Board at the start of the coming season, with any changes in preference requiring written consent from the board.

Barua, who has spent over three decades in the tea industry, emphasised that the public auction system is the most effective platform for selling tea, ensuring transparency and fairness.

He warned that selling through private channels is counterproductive and conflicts with the industry's broader interests. His suggestion to bifurcate the sellers would be a radical shift in the tea industry's regulatory framework, aiming to address longstanding concerns related to pricing and quality control. Reflecting on the difficulties faced by the industry in 2023, Barua pointed out that poor price realizations and Maximum Residue Limit (MRL) issues had plagued tea production.

While the industry had initially benefited from the Tea Board's directive to route all dust grades through public auctions, result-



ing in a price increase of ₹ 50 per kilogram, the prices had significantly dropped after mid-year. Despite a 110 million kg shortfall up to September, the industry was left grappling with uncertainty after the crop production caught up to 68 million kg in October, which further exacerbated the situation.

He further highlighted the impact of the state government's decision to halt production at the end of November in response to the chief minister's call, which, in conjunction with the Tea Board's circular, created a challenging environment for tea planters.

Amidst the challenges, Barua remained optimistic about the potential for change in

the tea industry. He acknowledged that while technological innovations in factory machinery have significantly reduced costs by up to 40 per cent, the same progress had not been evident in the fields.

However, he noted that the introduction of modern power tools like battery-operated plucking machines, pruning machines, and other field tools has helped improve efficiency and reduce costs in field operations. Barua expressed satisfaction with how vounger workers are embracing these technologies, contributing to a more efficient workforce.

In a momentous change for the ATPA,

Barua announced his decision to step down as Chairman and hand over the leadership to Samudra Baruva, with Atulit Chokhani taking over as vice chairman.

The transition marks a new chapter for the ATPA as the tea industry faces the challenges of rising production costs, changing market dynamics, and the need for innovation to remain competitive in an increasingly volatile global market.

As the industry looks ahead to a new season, the proposed reforms and Barua's leadership transition signal a commitment to navigating the complexities of the Assam tea sector and ensuring its long-term sustainability.

Syria's collapse: Foreign meddling and economic ruin

y the end of November, the situation in Syria was dire. Government forces were on the brink of exhaustion, stretched thin by an eco-D nomic crisis that spiralled out of control. Soldiers earned a paltry \$7 a month, with even high-ranking officers receiving only \$40. This was in blunt contrast to militia fighters funded by external powers, who earned up to \$2,000 monthly. This glaring disparity revealed not just economic fault lines but the extent of foreign intervention sustaining these militias. Meanwhile, protests erupted across Suwayda province, historically a stronghold of Assad support, highlighting widespread famine, collapsing services, and the devaluation of the Syrian pound. Discontent was palpable, threatening to upend the regime's fragile grasp on power.

Iran, Syria's long-time ally, reportedly pressured Assad to address these challenges. Tehran's warnings accentuated the erosion of public trust and a crumbling economy, urging decisive action. Yet Assad seemed increasingly aloof, allegedly seeking new alliances with Gulf nations, hoping these relationships would secure his future.

By December, reports emerged that the United States and the United Arab Emirates were considering lifting sanctions on Assad-but only if he severed ties with Iran and halted arms transfers to Hezbollah. This diplomatic manoeuvre was a calculated strategy to weaken Assad's regime further. Relief from Caesar sanctions was an unlikely prospect given Washington's decade-long effort to dismantle the Assad family rule. The outcome was preordained: Assad was isolated, and the geopolitical chessboard advanced. The trajectory of Assad's downfall mirrors a broader pattern in Western foreign policy. Leaders once celebrated as reformers-from Saddam Hussein to Muammar Gaddafi-are vilified when their geopolitical utility wanes. Assad, who was once lauded for fostering coexistence among Syria's religious and ethnic groups, became the West's pariah.

In 2010, Syria was a stable nation, ranked seventh on The New York Times' "31 best places to visit." Assad met with Queen Elizabeth, hosted Nancy Pelosi, and welcomed Pope John Paul II. Yet the West's affection was short-lived. As geopolitical calculations shifted, Assad's regime was recast as the antithesis of democracy, paving the way for intervention. The Syrian conflict was never just a civil war. It was a proxy war fueled by external actors. Over 100,000 jihadists were funnelled into Syria, backed by a coalition of nations. The United States, Israel, Saudi Arabia, and Qatar allegedly provided financial and logistical support.

Turkey and Jordan facilitated arms shipments and fighter transport. Western media amplified anti-Assad narratives, while the UK-backed White Helmets shaped public perceptions. Each player pursued its agenda, yet all converged on a singular goal: regime change. The motivations driving this coalition were diverse. The United States and Israel sought regional hegemony, neutralising perceived threats while advancing the Greater Israel project. Qatar's pipeline ambitions clashed with Assad's preference for an Iranian alternative, further entrenching divisions.

These dynamics turned Syria into a battleground for competing interests, with devastating consequences for its people.By late 2013, the influx of foreign fighters intensified. Western nations grappled with their citizens joining extremist groups in Syria. The UK reported approximately 600 fighters, while France contributed around 1,200.

Belgium, the Netherlands, and Sweden also faced significant outflows However, the greatest contributions came from West Asia and North Africa, with Tunisia leading at 3,000 fighters, followed by Saudi Arabia at 2,500.

Russia's involvement, particularly from regions like Chechnya, underscored the conflict's global reach. The arms supply chain further exacerbated the war. Gulf states like Qatar and Saudi Arabia allegedly supplied weapons, supported by over 160 military cargo flights. These arms, transported through Turkey and Jordan, sustained rebel factions. European nations, such as Croatia, indirectly contributed by routing surplus weapons through Jordan. This complex web of arms smuggling empowered extremist groups, further destabilising Syria. Western hypocrisy was stark.

While denouncing Assad's regime, the United States supported "moderate rebels" aligned with Al Qaeda and ISIS. Declassified documents revealed this duplicity. In 2012, General Michael Flynn's memo to the Pentagon warned that the opposition included jihadist factions. Similarly, Hillary Clinton's advisor, Jake Sullivan, acknowledged in an email that "Al Qaeda is on our side in Syria." The West's support for these groups undercut its claims of promoting democracy, revealing a strategy rooted in destabilisation. Atrocity propaganda became a central tool in the anti-Assad narrative. Staged chemical attacks, amplified by the White Helmets, justified military intervention.

Western media perpetuated these fabrications, obscuring the reality on e ground Idlib pr ice under "rebel" control b

Right to Information is being constricted by government and judiciary

saw a video on YouTube in which the Supreme Court was scolding a young lawyer for having sought information about a municipal body by inspection. The court was asking him why he wanted this information and telling him not to use the right to information (RTI) since he was an officer of the court.

The court tells the lawyer that it will impose costs on him. The court lambasts him for asking about recruitment, budget. etc. The judge tells him, "It is high time all this is put to an end." The court asks why he wants to inspect the records of a municipal body. Recently, a Madras High Court division

Bench comprising Justice N. Paul Vasanthakumar and Justice K. Ravichandrababu has ruled that RTI applicants must give reasons for seeking information.

I found it difficult to believe that a citizen could be asked why he was seeking information from a municipal body. I have heard many public servants ask why a citizen is seeking certain information. If we accept this position, we could be asked to explain why we wish to speak or publish something. Our fundamental rights are our human rights recognised by the Constitution.

Since the RTI has been accepted as a fundamental right of citizens under Article 19(1)(a), nobody has the right to ask for reasons. Democracy is the 'rule of the people, for the people and by the people'. Citizens are sovereigns, and they are seeking what belongs to them. To emphasise this, the Parliament stated in Section 6(2) of the Right to Information Act, 2005, "An applicant making a request for information shall not be required to give any reason for requesting the information or any other personal details except those that may be necessary for contacting

him.' The first clarion call for the right to information came from Justice Mathew in 1975 in the Raj Narain case where he said: "In a government of responsibility like ours, where all the agents of the public must be responsible for their conduct, there can be but few secrets.

"The people of this country have a right to know every public act, everything that is done in a public way by their public functionaries. They are entitled to know the particulars of every public transaction in all its bearing. Their right to know, which is derived from the concept of freedom of speech, though not absolute, is a factor which should make one wary when secrecy is claimed for transactions which can at any rate have no repercussions on public security.'

This was reinforced by many other mands or directions under the RTI Act for

Supreme Court judgments such as S.P. Gupta. The Parliament codified this right in 2005 to make it effective. Justice RavindraBhat gave a perfect explanation of the RTI in 2007 in the Bhagat Singh case when he stated: "A rights-based enactment is akin to a welfare measure, like the Act, it should receive a liberal interpretation. The contextual background and history of the Act are such that the exemptions, outlined in Section 8, relieving the authorities from the obligation to provide information, constitute restrictions on the exercise of the rights provided by

"Therefore, such exemption provisions have to be construed in their terms; there is some authority supporting this view (see Nathi Devi versus Radha Devi Gupta 2005 (2) SCC 201; B.R. Kapoor versus State of Tamil Nadu 2001 (7) SCC 231 and V. Tulasamma versus Sesha Reddy 1977 (3) SCC 99). Adopting a different approach would result in narrowing the rights and approving a judicially mandated class of restriction on the rights under the Act, which is unwarranted.

The entire approach to citizens' right to

information changed in August 2011 when the **DEGREE OF THOUGHT** Supreme Court held in Aditya Bandopadhyay By: Shailesh Gandhi versus CBSE and stated in Para 33: "Some high

courts have held that Section 8 of the RTI Act is in the nature of an exception to Section 3, which empowers the citizens with the right to information, which is a derivative from the freedom of speech; and that, therefore. Section 8 should be construed strictly, literally and narrowly." In Para 37, it made a comment without any evidence: "The right to information is a cherished right. Information and the right to information are intended to be formidable tools in the hands of responsible citizens to fight corruption and to bring in transparency and accountability. The provisions of RTI Act should be enforced strictly and all efforts should be made to bring to light the necessary information under Clause (b) of Section 4(1)of the Act which relates to securing trans-

parency and accountability in the working of public authorities and in discouraging corruption.

"But with regard to other information [that is information other than those enumerated in Section 4(1)(b) and (c) of the Act] equal importance and emphasis are given to other public interests (like confidentiality of sensitive information, fidelity and fiduciary relationships, efficient operation of governments, etc.) "Indiscriminate and impractical dedisclosure of all and sundry information (unrelated to transparency and accountability in the functioning of public authorities and eradication of corruption) would be counter-productive as it will adversely affect the efficiency of the administration and result in the executive getting bogged down with the non-productive work of collecting and furnishing information.

"The Act should not be allowed to be misused or abused, to become a tool to obstruct national development and integration or to destroy the peace, tranquility and harmony among its citizens. Nor should it be converted into a tool of oppression or intimidation of honest officials striving to do their duty.

"The nation does not want a scenario where 75 percent of the staff of public authorities spends 75 percent of their time collecting and furnishing information to applicants instead of discharging their regular duties.

"The threat of penalties under the RTI Act and the pressure of the authorities under the RTI Act should not lead to employees of public authorities prioritising 'information furnishing' at the cost of

their normal and regular duties. This passage was used enthusiastically by various public servants to

deny information to citizens. This judgment suggested confidentiality of sensitive information should be kept in mind. It introduced an exemption that was not envisaged by the Parliament. The law clearly intended that all infor-

mation held by public authorities, except as provided under Sections 8 and 9, be provided. The quoted passage also suggested that the RTI may be used to oppress and intimidate government servants. It also suggested that RTI queries must meet the standard of 'improving transparency and eradication of corruption'

It further suggested that it could be used to oppress and intimidate honest officials doing their duty. This was an unfortunate statement that emboldened public servants to refuse information based on their assessment of what information must be given under the RTI.

There has not been a single recorded case of oppression and intimidation of public officials. There are numerous cases of threats and assaults of RTI users. Over 100 RTI users have been murdered. According to one study by the Right to Information Assessment and Advocacy Group (RaaG), a group that conducts studies and assessments on the implementation of the RTI Act in India, about 50 percent of the RTI queries relate to information that should be available suomotu under Section 4 of the Act.

Another 25 percent relate to the fact that public servants do not respond to applications, complaints and representations by citizens. This means 75 percent of the RTI queries are a consequence of public authorities not fulfilling their duties.

Unfortunately, the passage quoted above is being used everywhere to indicate that these fundamental rights should be recognised on a case-to-case basis. A narrative has been created that the right to information was inferior to the right to speak and publish.

As to the charge of public servants requiring a disproportionate amount of time to answer RTI queries, one needs to understand that RTI expects information to be provided as it exists.

Some officers claim that it takes a lot of time to trace information. They must first understand the reason for keeping records. Records are primarily kept for referencing. If they take too much time to locate, they will not be useful for referencing

Section 4 (1)(a) of the RTI Act mandates that all public authorities must "maintain all its records duly catalogued and indexed in a manner and form which facilitates the right to information under this Act and ensure that all records that are appropriate to be computerised are, within a reasonable time and subject to availability of resources, computerised and connected through a network all over the country on different systems so that access to such records is facilitated".

It is unfortunate that public authorities do not implement the law laid down in Section 4 (1)(a) and (b). Across the country, this part of the judgment was quoted enthusiastically and complaints were filed against RTI users.

Some police stations filed first information reports (FIRs) against RTI users and started calling public-spirited citizens extortionists and blackmailers. It appeared to legitimise assaults on RTI activists.

This narrative needs to be challenged. Citizens and the media need to discuss and defend their fundamental rights. Whereas the freedom to speak and publish has been expanded along the way, RTI is being weakened beyond what the law and the Constitution permit. This is an unfortunate curbing of citizen's fundamental rights. (IPA Service)

Syria's tragedy is a miniature of a global pattern. The collapse of nations like Iraq, Libya, and Syria reflects a broader system where sovereignty is sacrificed for strategic interests. Foreign interventions, far from promoting democracy or stability, have left legacies of destruction, displacement, and despair.

Elon Musk gets Donald Trump to push for government shutdown

pparently heeding his corporate 'handler," multibillionaire Elon Musk, Republican President-elect Donald Trump torpedoed a spending agreement covering the federal government from now through March 14 unless congressional Democrats raised the U.S. debt ceiling.

Musk and Trump don't want to deal with the mess of raising the debt ceiling next year even though it doesn't need to be raised until at least June. And, most important, they want it raised now to allow for a massive tax cut for billionaires promised by Trump during his campaign. Musk went on social media all day long yesterday to rant and rave about the bi-partisan compromise deal reached by House Speaker Mike Johnson and House Minority Leader Hakeem Jeffries, a deal which put money into the hurricane and storm relief efforts across the country and continued the funding of essential government programs until next January.

If all this sounds convoluted, it is. Showing his ignorance about law-making in a democracy, Musk said that there should be no agreements on legislation until after

Trump takes over on January 20. That would mean intense suffering immediately for millions of Americans and guarantee long term suffering for them next year while he, Musk, wallows in comfort becoming the richest man in the world.

It doesn't matter that Musk is lying when he claims he deserves, because of his innate brilliance, all his riches and wealth. He conveniently ignores that his wealth comes from government contracts paid for by the U.S. working class. Even more important, he forgets that when Tesla was about to collapse into insolvency he went, hat in hand, to then-President Obama to beg for a 600 milliondollar handout from the government which Obama granted to him. Today he shows gratitude to the people who provide him with the money lining his pockets by not even offering a slice of cake to the hungry, as Marie Antoinette famously did just before the French Revolution.

The blowing up of the budget deal and the impending government shutdown show Musk's clout and Trump's satisfaction with being his lap dog as long as he (Trump) gets his stay-out-of-jail-card by being elected again and, if Musk allows him to do it, the

power to grant unlimited drilling rights to his pals in the fossil fuel industry.

The collapse of the deal, already on shaky ground due to flak from Trumpite rightwingers in the U.S. House and the twitterverse, raises the prospect of a government shutdown of all but essential services at midnight at the end of tomorrow December 20. House Speaker Mike Johnson, R-La., and Senate Majority Leader Charles Schumer, D-N.Y., had worked out the spending plan, which would give the pro-rated share of a trillion dollars to the military and its contractors and keep domestic spending, also prorated, at the same level as it is now, at about \$200 billion less. Those two shares began this past October 1. Their plan would avoid the shutdown. Musk and, then Trump, only in the last minute when it was clear he had marching orders from his master, opposed it. Trump did not even get involved in this fight until after Musk spent a full day sabotaging it on social media.

"We should pass a streamlined spending bill that doesn't give Chuck Schumer and the Democrats everything they want," Trump and Vance tweeted out of reverence for the wishes of Musk. "The only way to do that is

with a temporary funding bill WITHOUT to run up future debts—like debt from the DEMOCRAT GIVEAWAYS combined with an increase in the debt ceiling.

Musk tweeted that anybody "who votes for this outrageous spending bill deserves to be voted out in two years!" Musk owns twitter, now called X. He purchased it allegedly to promote freedom of the press which he and his billionaire pals are busy taking away. The billionaire owner of the LA Times recently hopped on the "free press" bandwagon by ordering his writers to stop producing articles critical of Trump.

The debt ceiling hike is the financial and political key to Musk's clout, however. Both Trump and Musk know full well why the debt ceiling must be raised. If it isn't raised eventually the federal government will run out of financial room to pay its debts.

Demagogues, almost all Republicans, rail against and vote against raising the debt ceiling. They portray it as akin to failing to balance your checkbook. It isn't. It's the equivalent of maxing out on the national credit card and asking for and getting a hike on your credit limit. No increase, and you default. That debt limit hike not only lets the government borrow to pay past bills, but also

planned Trump-GOP tax cuts for corporations and the rich after January 20.

In prior financial fights, the House's Democrats bailed the Republicans out by voting to raise the debt limit, as well as to pass temporary money bills, like the one that Musk via Trump torpedoed. The Democrats bailed out the GOP the only time the Republicans led the nation to the brink of a default, in 2011. It was close. Wall Street downgraded the U.S.'s world-leading credit rating from AAA to AA+. "The downgrade reflects our view that the effectiveness, stability, and predictability of American policymaking and political institutions have weakened at a time of ongoing fiscal and economic challenges to a degree more than we envisioned." Standard and Poor's said then. Sound familiar?

This time, after Trump, under orders from Musk, torpedoed the spending deal, Minority Leader Hakeem Jeffries, D-N.Y., said the Democrats weren't necessarily going to play the game or be the political patsies for Trump and Musk.

"House Republicans have been ordered to shut down the government. And hurt the working-class Americans they claim to support," Jeffries retorted in a tweet. "You break the bipartisan agreement, you own the consequences that follow." In other words, the shutdown. Or as Gen. Colin Powell said of the results of one U.S. Middle East war: "Once you break it, you are going to own it."

The money bill's numbers count only "discretionary" spending which Congress controls, for everything from air traffic control to food inspections to wage and hour law enforcement to battling monopolies. That spending, and half the government with it, would shut down if Congress doesn't meet the deadline. That figure doesn't cover preset programs available to all, notably Social Security, Medicare and Medicaid, all of which Trump has mused about cutting. But "discretionary" spending also includes paying workers who run those three big programs, and all others.

The 1,547-page bill had more than just continuing present levels of spending. Addons included \$110 billion in relief for disaster victims, a one-year extension of farm subsidies, and curbs on so-called pharmacy benefit managers whose rulings on which medicines are covered and which aren't help drive up health care costs. The majestic Mahabhairab Temple

The Mahabhairab temple is one of the most important historical monuments religious places of India set in the bustling city of Tezpur. It not only holds by itself a magnificent architectural wonder but also engulfs the spiritual core, abundant cultural depths, and history-filled strata, which lie on the ground itself. Widely recognized as a temple of the deity Lord Shiva, Mahabhairab Temple has survived centuries of socio-political change, environmental degradation, and evolution. It still stands as a living monument to spirituality and to the role of community.

The history of the Mahabhairab Temple is steeped in mythological and historically conjectural tales. In many accounts, it has been said that the first building of the temple was undertaken by Banasura, the demon king ruling over the city of Tezpur, which has then been called Sonitpur. The temple is essentially stone structure, which contains some intricate carvings which describe the adeptness of the artist mixing in which religiosity images are present. The sanctum sanctorum houses one of the oldest and largest Shiva Lingams in stone, which is venerated by devotees with much devotion. This Lingam forms the center of identity to this temple, reflecting an unbroken continuity of the spiripractice, generation after tual generation. This layout and design share also with the Hindu architecture all the essential features, including garbhagriha (sanctum), mandapa (hall) and open courtyard which is open to pilgrims during the important festivals like Mahashivratri.

The majestic and pious festivals at Mahabhairab Temple are unique in some way in respect to Mahashivratri. Veneration taking place in this sacred place transforms the temple into a point of attraction for followers throughout Assam and neighbouring states, who come to pay their respects to Lord Shiva. The rituals performed during Mahashivratri are intricate and profound, beginning with the traditional abhisheka (ritual bathing)



of the Shiva Lingam using water, milk, honey, and other sacred substances. Below are the offerings given by individuals, throwing a combination of bel leaves and blossoms mixed with prayer onto their deity, the general atmosphere, whatever it may incorporate, reveals piety and reverence. It holds within its cadences residues of chanting the "Om Namah Shivaya", other within the immobility of the air, imbues to the community and it remains into late hours; devotees can stay until the vigils chanting the hymns or, through discourse, they can make and explain the different aspects that Shiva, both the philosophy

based on it or the cult, gives rise to. Besides religious significance, Mahabhairab Temple is a cultural hub which continues to be a significant socio-cultural backbone of Tezpur. Cultural events, including classical music concerts or Astraditional dances, are samese commonplace in temple grounds. These activities not only radiate the local culture, but also facilitate community gathering and artistic dissemination. The temple's stewardship, usually administered by local trust boards and committees, guarantees the temple's inclusiveness and openness to people of different backgrounds, thereby sustaining the temple's role as a representation of commonality.

The temple has suffered a great deal of tribulations in the course of its long past, with invasions, natural disasters, and periods of abandonment. Yet, thanks to the adaptability of the community and to patronage by different rulers throughout history, it has survived and has been reconstituted. Based on historical data, in the medieval age the temple may have been attacked by invaders who sought to destroy areas of Hindu worship. Despite such challenges, the temple was rebuilt and maintained, with contributions from local rulers and patrons who realized its importance. The Mahabhairab Temple also captivated the eyes of British scholars and travelers that visited during the colonial era. They described the morphology and religious practices of this temple, making it to wider academic debate in Indian temples.

Due to the fact that this lovely temple stands on a hilltop, which enhances its scenic view and presents a vast landscape for a stunning panorama, covering the Brahmaputra River. This geographical positioning is not only decorative but also has strategical and religious value. Hindus have long viewed hills as holy places, as a closer embodiment of the divine. These are not myths from another era but have the role of inspiring present-day cultural practices, such as theatrical performances and traditional storytelling sessions recounting legends associated with the temple. The timeless allure of the Mahabhairab Temple resides in its multifacetedness. It is a church, a historical monument, and a cultural center where the influence of the people of Tezpur still permeates and shapes. Its blend of mythology, painting, and communal activities (which is in fact a miniature version of the larger cultural world of Assam) is a microcosm that offers not only spiritual benefits but also historical and social benefits, as well. The history of the temple is not a static entity but a living, dynamic process in time and responding to the demands of the moment while maintaining the customs of antiquity. Key ally vows to topple Canadian PM Trudeau in fresh blow to his govt

TORONTO, Dec 21: The future of Canadian Prime Minister Justin Trudeau's leadership appeared increasingly uncertain after New Democratic Party (NDP) leader Jagmeet Singh, a key ally, said he would introduce a motion to topple the minority Liberal government.

Singh, whose party has been helping keep Trudeau in office, announced in an open letter posted on social media that he would declare a loss of confidence in the Trudeauled Liberal government next year, a move that would trigger an early election if other opposition parties support his move.

Canada's next election must be held on or before October.

Singh is the last of Canada's three main opposition parties to turn on Trudeau. In his letter, Singh said the Liberals were undeserving of "another chance."

"That's why the NDP will vote to bring this government down and give Canadians a chance to vote for a government who will work for them." he wrote.

He said the New Democrats plan to use their next opposition day in the House of Commons — during which opposition priorities are given precedence over government business — to introduce the vote.

The House is currently on its winter break and is set to resume on January 27.

Singh's letter came as questions swirled about the future of Trudeau, with at least 21 Liberal MPs now calling for him to resign, CBC News reported.

Singh's announcement is the latest in a series of political setbacks suffered by Trudeau this week after the resignation of Chrystia Freeland, his deputy prime minister and finance minister. Freeland quit

Singh also said the Liberals have frequently not lived up to their promises and that the time for change is now.

The letter was released just before Trudeau announced his revamped front bench on Friday morning.

The New Democrats ended their parliamentary alliance with the Liberals in early September, but have repeatedly declared confidence in the government when the Conservatives have introduced votes to bring the Liberals down. Conservative leader Pierre

Poilievre has repeatedly called for an election as soon as possible. Had Singh voted with the Con-

servatives, "we would be a third of the way into an election campaign right now," Poilievre told reporters on Friday.

"But he suddenly had an epiphany and says that he can no longer support the costly chaos that he has enabled as part of the NDP-Liberal coalition.

The Conservative leader said he was writing to Governor General Mary Simon "asking her to urgently reconvene Parliament and require a non-confidence vote" to end Trudeau's reign.

Trudeau has not responded publicly to these calls and has reportedly told members of the party that he will take the holidays to reflect and decide what to do. (PTI)

Minister Nancy Faeser traveled to Magdeburg on Saturday, and a memorial service is to take place in the city cathedral in the evening. Faeser ordered flags lowered to half-staff at federal buildings across the coun-

Verified bystander footage distributed by the German news agency dpa showed the suspect's arrest at a tram stop in the middle of the road. A nearby police officer pointing a handgun at the man shouted at him as he lay prone, his

head arched up slightly. Other officers swarmed around the suspect and took him into custody.

Thi Linh Chi Nguyen, a 34-yearold manicurist from Vietnam whose salon is located in a mall across from the Christmas market, was on the phone during a break when she heard loud bangs and thought at first they were fireworks. She then saw a car drive through the market at high speed. People screamed and a child was thrown into the air by the car.

Shaking as she described the horror of what she witnessed, she recalled seeing the car bursting out of the market and turning right onto Ernst-Reuter-Allee street and then coming to a standstill at the tram stop where the suspect was arrested. The number of injured people

was overwhelming. "My husband and I helped them for two hours. He ran back home and grabbed as many blankets as he could find because they didn't have enough to cover the injured people. And it was so cold," she said.

The market itself was still cordoned off Saturday with red-andwhite tape and police vans every 50 meters (about 54 yards). Police with machine pistols guarded every entry to the market.

Some thermal security blankets still lay on the street. Christmas markets are a German holiday tradition cherished since the Middle Ages, now successfully exported to much of the Western world.

Aviv overnight; 16 people slightly injured The Israeli military says the Iran-backed Houthis have launched more than 200 missiles and drones during the Israel-Hamas war in Gaza. The Houthis

The press service of Tatarstan's governor, Rustam Minnikhanov, said that eight drones attacked the city. Six hit residential buildings, one hit an industrial facility and one was shot down over a river, the statement said. A video posted on local Telegram news channel Astra, verified by The Associated Press, shows a drone flying into the upper floors of a high-rise building.

Local authorities said there were no casualties. Flights were halted at Kazan's airport and all mass gatherings cancelled on Saturday and Sunday. The attacks, which Ukraine didn't acknowledge in keeping with its security policy, comes after a Ukrainian attack Friday on a town in Russia's Kursk border region using U.S.-supplied missiles killed six people, including a child.

Moscow sent 113 drones into Ukraine overnight into Saturday, Ukrainian officials said. According to Ukraine's Air Force, 57 drones were shot down during the attacks. A further 56 drones were "lost," likely having been electronically jammed.

The governor of Ukraine's Kharkiv region, Oleh Syniehubov, said eight people were wounded Friday night in drone attacks on the regional capital, also called Kharkiv. (AP)

'Cyprus can help rid Syria of chemical weapons, search for missing people'

NICOSIA (CYPRUS), Dec 21: Cyprus stands ready to help eliminate Syria's remaining chemical weapons stockpiles and to support a search for people whose fate remains unknown after more than a decade of war, the top Cypriot diplomat said Saturday

Foreign Minister Constantinos Kombos said Cyprus' offer is grounded on its own past experience both with helping rid Syria of chemical weapons 11 years ago and its own ongoing, decades-old search for hundreds of people who disappeared amid fighting between Greek Cypriot and Turkish Cypriots in the 1960s and a 1974 Turkish invasion.

Cyprus in 2013 hosted the support base of a mission jointly run by the United Nations and the Organisation for the Prohibition of Chemical Weapons (OPCW) to remove and dispose of Syria's chemical weapons.

"As a neighbouring country located just 65 miles from Syria, Cyprus has a vested interest in Syria's future. Developments there will directly impact Cyprus, particularly in terms of potential new migratory flows and the risks of terrorism and extremism," Kombos told The Associated Press in written replies to questions. Kombos said there are "profound concerns" among his counterparts across the region over Syria's future security, especially regarding a possible resurgence of extremist groups

like Islamic State in a fragmented and polarised society. Other challenges include new migratory flows from the country as well as ensuring the safety and rights of women and minorities including Druze, Christians, Jews and Kurds, so that the "rich mosaic of Syria is preserved."

"This is particularly critical in light of potential social and demographic engineering disguised as "security" arrangements, which could further destabilize the country," Kombos said. The diplomat also pointed to the recent proliferation of narcotics production like the stimulant Captagon that is interconnected with smuggling networks involved in people and arms trafficking.

Kombos said ongoing attacks against Syria's Kurds must stop immediately, given the role that Kurdish forces have played in combating extremist forces like the IS group in the past decade.

A Syrian-led process transitioning the country to an inclusive democracy should integrate the Kurds' "legitimate asks" while safeguarding the country's unity and territorial integrity. Saleh Muslim, a member of the Kurdish Presidential Council, said in an interview that the Kurds primarily seek "equality" enshrined in rights accorded to all in any democracy. He said a future form of governance could accord autonomy to the Kurds under some kind of federal structure.

"But the important thing is to have democratic rights for all the Syrians and including the Kurdish people," he said. Muslim warned that the Kurdish-majority city of Kobani. near Syria's border with Turkey, is in "very big danger" of falling into the hands of Turkish-backed forces, and accused Turkey of trying to occupy it.

Kombos said the international community needs to ensure that the influence Turkey is trying to exert in Syria is "not going to create an even worse situation than there already is". "Whatever the future landscape in Syria, it will have a direct and far-reaching impact on the region, the European Union and the broader international community," Kombos said. (AP)

Meditation transcends all religions, borders: Leaders on 1st World Meditation Day at UN

'Today, meditation is not a luxury, but it is a necessity

UNITED NATIONS, Dec 21: Meditation transcends all religions and borders and is also a powerful instrument of diplomacy in the current global landscape marked by escalating conflicts and deep-seated mistrust, top spiritual and UN leaders said on the first World Meditation Day commemorated here.

The Permanent Mission of India to the United Nations organised a special event 'Meditation for Global Peace and Harmony' to mark the first World Meditation Day at the global body's headquarters on Friday.

"Today meditation is not a luxury, as it was thought, but it is a necessity," spiritual leader Gurudev Sri Sri Ravi Shankar said in his keynote address at the packed event attended by UN Ambassadors, officials, staff, civil society members as well as members of the Indian-American diaspora.

"Meditation is something you can do anywhere, everywhere, by everyone. In this sense, international Meditation Day plays a very important role and opens the door to those who have some reservations," he said.

He added that for many people,

the moment they hear the word meditation, they may feel that the practice either has to be from some religion or it is not taught in their religion.

He underscored that meditation "transcends all religions, all geographical boundaries and age groups so it is very, very useful in many, many ways.

President of the 79th session of the UN General Assembly Philemon Yang said in his remarks that meditation "transcends borders, faiths, traditions and time, offering each of us the opportunity to pause, to listen and to connect with our inner selves.

Yang said that the world today needs peace more than ever before. "The tensions in the world require that we embrace peace and anything that brings peace....Let us build on the practice we have shared to bring about a safer, more iust and equitable future for everyone, everywhere.'

Earlier this month, the 193-member UN General Assembly unanimously adopted a resolution declaring December 21 as World Meditation Day,

India was a member of the core



group of countries that guided the unanimous adoption of the resolution titled 'World Meditation Day in the UNGA. Andorra, Liechtenstein, Mexico, Nepal and Sri Lanka were the other members of the core group. Under-Secretary-General for Op-

erational Support Atul Khare said at the event that at the UN, civilian and uniform personnel work tirelessly on the world's most pressing challenges with colleagues operating under high pressure, including in high-risk environments, often far away from their family and country of origin

"This can and does take a toll on their mental health. Our uniform personnel are often tasked with protecting civilians against physical violence, and are often themselves exposed to atrocities, war crimes and crimes against humanity," Khare said

While the physical safety of peacekeepers of is of utmost importance, it is equally critical that their mental health is also taken care of, he said.

In this context. Khare said that a special app called 'MindCompanion' was launched by the UN in October this year

The app is aimed at increasing awareness and understanding of mental health issues and its self-assessment feature will help users gauge their mental well-being regularly.

"I take this opportunity on this Meditation Day to encourage everyone to reaffirm our commitment to overall mental health and to use the tools available, such as meditation, to seek inner transformation and peace. Let us embrace this practice to create a more peaceful world, starting with the world within ourselves," Khare said.

India's Permanent Representative to the UN Ambassador Parvathaneni Harish said that the ancient wisdom of meditation offers a beacon of hope amid growing stress and anxiety at the individual level and conflicts and tensions at the global level.

"In our current global landscape, marked by escalating conflicts and deep-seated mistrust, meditation emerges not merely as a personal practice but as a powerful instrument of diplomacy. Meditation helps us to cultivate empathy, deep self-awareness, capacity to understand complex situations with

greater clarity. "These are skills that are critical to navigating an increasingly interconnected and complex global environment," Harish said.

Harish noted that December 21 marks the Winter Solstice, which in Indian tradition is the beginning of Uttarayana - an auspicious time of the year, especially for inner reflection and meditation. It also falls exactly six months after the International Day of Yoga commemorated on June 21, which is the Summer Solstice.

In 2014, India took the lead at the UN in declaring June 21 as the International Day of Yoga.

Permanent Representative of Nepal to the UN Ambassador Lok Bahadur Thapa said that the world is at a pivotal crossroads and "our collective dreams and aspirations" for a better, just, equitable, prosperous and sustained world are thwarted by multiple, intersecting

and recurring global challenges. "Geopolitical competition, economic instability, social divisions and environmental degradation among others have threatened global peace, security and stability," Thapa said.

He added that the importance of meditation cannot be overstated. It influences various aspects of human life, society and the global community at large. "It transcends cultural, geographical, societal and religious boundaries, embodying truly humanistic values and reflecting the highest ideals of humanity,' he said.

Chargé d'affaires at the Permanent Mission of Sri Lanka Sugeeshwara Gunaratna noted that the UNGA resolution was co-sponsored by over 70 countries from all geographical regions and different cultural and religious backgrounds. 'This speaks volumes on the universal applicability and acceptance of the different techniques and practices which we call meditation.3

"It is our collective wish that in a world that seeks peace and harmony among the tragedy of conflicts, meditative practices could provide the essential ingredient in creating peaceful individuals, which is the fulcrum to building a sustainable and peaceful world," Gunaratna said.

The event also included a special meditation session led by Sri Sri Ravi Shankar. (PTI)

to reimpose PAR in Mizoram

Centre urged to review decision

AIZAWL, Dec 21: The ruling Zoram People's Movement (ZPM) in Mizoram on Saturday urged the Centre to review its decision to reimpose Protected Area Regime (PAR) as it would obstruct foreign tourists from visiting the northeastern state.

The Centre on Tuesday had reimposed the PAR in Mizoram, Manipur and Nagaland to regulate the movement of foreigners amid growing security concerns arising out of influx from neighbouring countries.

A statement issued by the ZPM said that "it took strong exception to the reimposition of the PAR in Mizoram, one of the most peaceful state in the country, which is moving towards development in the tourism sector.

It urged the Centre to review its decision citing that the reinstatement of the PAR will obstruct the state government's effort to attract tourists because foreigners will now have to obtain Protected Area Permit (PAP) from the Ministry of Home Affairs (MHA) to visit the state.

The ZPM also opposed the reimposition of PAR because it will restrict and hinder the movement of many ethnic Mizos living in foreign countries particularly Bangladesh and Myanmar into Mizoram, the statement said.

process of implementing the PAP. He had said that they are yet to demand PAP or RAP from foreigners visiting the state at the state's lone airport in Lengpui and other entry points of the state. He had also said that training

Allocate equal budget to NESIDS, NEC schemes: Mizoram CM urges Centre

AIZAWL, Dec 21: Mizoram Chief Minister Lalduhoma on Saturday urged the Centre to allocate equal budget to the North East Special Infrastructure Development Scheme (NESIDS) and North Eastern Council (NEC) scheme to accelerate development in the region, an official statement here said

Speaking at the North East Council's plenary session chaired by Union Home Minister Amit Shah in Agartala, Lalduhoma emphasised the need for appointment of a full-fledged NEC secretary to enhance administrative efficiency, it said.

He said equal budgetary allocation to NESIDS and NEC schemes reduce delays caused by multilevel approvals.

He emphasised the importance of regular reviews under the 10 per cent Gross Budgetary Support (GBS) and the newly implemented changes in fund release mechanisms to accelerate project implementation

During his address, Lalduhoma stressed investments and employment generation and underscored Mizoram's ambition to establish an investment zone with world-class infrastructure and a strong focus on 'ease of doing business'.

He pointed out that over 50 per cent of Mizoram's population is engaged in agriculture and allied sectors, but their contribution to the state's GDP remains minimal.

Gen K T Parnaik (Retd) on Friday exhorted police officers to strengthen community policing programmes to check the growing drug menace in the state.

CT Ravi ill-treatment claim an attempt by BJP to deviate public attention, says Shivakumar

BENGALURU, Dec 21: By claiming ill-treatment of party leader and MLC CT Ravi by police post his arrest, the BJP was attempting to deviate public attention from the original issue of him allegedly using derogatory language against a woman minister, Karnataka Deputy Chief Minister D K Shivakumar alleged on Saturday.

Highlighting that conscience was important, he hit out at the BJP leadership in the state for supporting Ravi, who was arrested for making a derogatory comment against state minister Laxmi Hebbalkar.

...ask them (BJP) if what he (Ravi) said was right or not. Let's discuss other things later. This shows the culture of their party and leader...what happened in the court is left to him (Ravi) and the police and the crime he committed. The main issue is his language and his culture," Shivakumar told reporters here in response to a question on the High Court ordering Ravi's release on Friday.

Alleging that Ravi has used derogatory language against several people in the past, the deputy CM said he is the leader from a national party, and "is it right for him to speak about women in such a manner.

Ravi allegedly used a derogatory word against Hebbalkar in the Legislative Council on Thursday during an altercation between them, when the House was adjourned for a while.

He was arrested on Thursday evening and taken into a police van from the premises of Suvarna Vidhana Soudha in Belagavi, where the legislature session was held.

Stating that conscience is important, Shivakumar said, "BJP supporting him (Ravi) just because he is their party leader is not right...one should be condemned if he is wrong and should be told that he is wrong. If anyone had used such words in my party, I would



(Leader of Opposition) is supporting him (Ravi). He is a party to it in this crime.

"This is their party (BJP) leadership. Let them say that this is how their party is. We will be happy. Let them keep their gems to themselves happily. Let them not send them out," he further said. Ravi on Friday accused the police of "violating" human rights, as he alleged that they took him on rounds the entire night to various places without providing proper food and rest

Responding to a question about police action against Ravi and alegations that he pressured the police, Shivakumar said, "...it is a police matter. I don't know...for everything that happens they hold me responsible...they don't get sleep without remembering me.'

Stating that conscience will give justice in this matter, he said, They (BJP) are trying to deviate from the main issue. To cover up his (Ravi) usage of a derogatory word, he is now blaming the po-

The High Court on Friday ordered immediate release of Ravi in its interim order, observing that police failed to follow the procedures in arresting him. However, the bench of Justice M G Uma asked Ravi to co-operate with the investigation and be available for questioning

Home Minister G Parameshwara on Saturday, responding to a question by reporters on HC ob-

serving that police failed to follow the procedures in arresting Ravi. said he wouldn't want to make any statement, as the matter is before the court. "As the matter is sub judice. It wouldn't be appropriate to speak.

Asked whether the arrest was done legally according to the government, he said, "The police argument will be that their action was right, but the matter is before the court and it will decide what is right and what is wrong.'

To a question as to why police took Ravi on rounds to four districts through the night on Thursday after his arrest, the Home Minister said, "I have sought for information. Once I get it I will share.

Noting that police had arrested 24 people in connection with an attempt to attack Ravi at the Suvarna Vidhana Soudha on Thursday, Parameshwara in response to another question said, "they were arrested to ensure that no untoward incident should happen and they were later released."

Asked whether someone else operating the Home Department superseding him, considering the way in which Ravi's arrest was done and the things that followed, Parameshwara said, "It cannot be done. Can it be done? Other than CM. no one else can do it. The CM is above the Home Minister and other ministers...I have a lot of freedom (in running the department)." (PTI)

PM Modi embarks on 2-day visit to Kuwait, likely to firm up roadmap for futuristic partnership

NEW DELHI, Dec 21: As he embarked on a two-day visit to Kuwait, Prime Minister Narendra Modi on Saturday said India and the Gulf nation have shared interest in peace, security and stability in West Asia.

Modi's visit to Kuwait, the first by an Indian prime minister in 43 years, comes two weeks after the collapse of Bashar al-Assad's regime in Syria and amid signs of a possible ceasefire deal between Israel and Hamas in Gaza.

The last Indian prime minister to visit Kuwait was Indira Gandhi in 1981.

In a departure statement, Modi said his talks with the top Kuwaiti leadership would be an opportunity to chalk out a roadmap for a futuristic partnership between India and Kuwait.

"We deeply value the historical connection with Kuwait that has been nurtured over generations. We are not just strong trade and energy partners but also have shared interest in peace, security, stability and prosperity in the West Asia region," he said. The prime minister is visiting Kuwait at the invitation of Kuwaiti Emir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah.

"I am confident that this visit will further strengthen and rein-



force the special ties and bonds of opening ceremony of the Gulf Cup friendship between the people of football tournament. "I express my gratitude to the

India and Kuwait," Modi said. The prime minister said he was looking forward to his meetings with the Emir, the Crown Prince and the prime minister of Kuwait. "It would be an opportunity to

ing the Indian diaspora in Kuwait who have immensely contributed to strengthening of bonds of friendship between the two nations," he added. Modi's engagements in Kuwait

NAGPUR, Dec 21: The shortage of manpower at every level of healthcare institutions under the Maharashtra Health Department and overburdening of infrastructure are the main concerns flagged by the CAG in its audit report.

The Comptroller and Auditor General noted that providing adequate and quality healthcare services to a large population requires a robust healthcare infrastructure and services.

This performance audit report for 2023-2024 was tabled in the legislative assembly on Saturday.

The shortage of doctors, nurses and paramedical staff was 22 per cent, 35 per cent and 29 per cent, respectively in primary and secondary healthcare under the state Health Department.

The shortage of doctors, nurses and paramedical staff was 23 per cent, 19 per cent and 16 per cent respectively in primary and secondary healthcare for women hospitals. The shortage is 42 per cent in the cadre of the specialist doctors.

The CAG stated that the overall shortage of doctors, nurses, and paramedics in the Health Department and Medical Education and Drugs Department was 27 per cent, 35 per cent, and 31 per cent respectively. The audit also noticed the regional disparity in the availability of manpower.

Health Department and Medical catering to the population in excess of the norms laid down in IPHS, the Education and Drugs Department were 23 per cent and 44 per cent, CAG stated. respectively. The CAG stated va-The audit noticed that 70 per cent

of the work for constructing new healthcare institutions and 90 per cent of the work for upgrading healthcare institutions as per the master plan (January 2013 and June 2014) was not completed as of September 2022.

It said a Super Speciality Hospital (Phase II), Amravati, constructed at the cost of ₹ 31.91 crore in June 2015 remained unutilised for more than three years. Further, 433 works included in the master plan could not be started due to non-availability of land. Out-Patient Department (OPD) services in hospitals were inadequate with 93 per cent of rural hospitals having only one registration counter as against two required as per IPHS in seven selected districts, the CAG said. Rajasthan accident: Experts blame incomplete construction, sudden cuts

JAIPUR, Dec 21: Incomplete construction, sudden cuts and a lack of traffic sense might have caused the Jaipur-Ajmer highway accident that killed 14 people, experts said on Saturday and called for a comprehensive statewide road safety action plan. They also attributed the absence of proper signages and road markings for the accident.

"The stretch of the Jaipur-Ajmer highway where the crash occurred is an accident-prone spot, with poor traffic management and ongoing construction creating hazardous conditions," said George Cheriyan, a prominent voice of Road Safety Network in India and a former member of the Rajasthan chief secretary's traffic management committee.

He said physical measures should have been in place to prevent big tankers from making uturns on the highway.

It is difficult to apply brakes when moving at high speeds, Cheriyan said.

An LPG tanker collided with a truck on Friday, sparking a mas-

sharpest increase in fatalities among them, with an almost six percentage point rise from 2022, according to data shared by state governments with the Centre.

According to Cheriyan, the continuing trend of such road accidents in Rajasthan called for a comprehensive statewide action on road safety for 2025 to 2030.

Bagru Udhyog Mitra co-convenor Navneet Jhalani, who passes the accident spot daily, said, "The foundation of Friday's accident was laid when the ring road was hastily inaugurated six years ago to bypass the implementation of the Model Code of Conduct for elections. A cloverleaf interchange had to be constructed on the busy high-

way but it is still pending.' He added that they submitted several several memoranda to the National Highways Authority of India regarding this. Road safety expert Dr Prerna

Arora Singh said, "There is no high mast lighting system at the intersection. Visibility becomes very low during winters. There is no radium, reflector or signal marker of any kind at the cut She also said the width of the cut at the intersection was too narrow. "If a big truck such as a container or gas tanker passes through, it blocks the road on both sides. This could possibly be the reason for the accident," Singh said. She also said there was a lack of road traffic sense among people that needed to be improved through interventions.

Election rule tweaked to restrict public inspection of electronic records

NEW DELHI, Dec 21: The government has tweaked an election rule to prevent public inspection of certain electronic documents such as CCTV camera and webcasting footage as well as video recordings of candidates to prevent their misuse.

Based on the recommendation of the Election Commission (EC), the Union law ministry on Friday amended Rule 93(2)(a) of the Conduct of Election Rules, 1961, to restrict the type of "papers" or documents open to public inspection. According to Rule 93, all "papers" related to elections shall be open to public inspection.

The amendment inserts "as specified in these rules" after papers". Law ministry and EC officials separately explained

that a court case was the "trigger" behind the amendment. While documents such as nomination forms, appointment of election agents, results and election account statements are mentioned in the Conduct of Election Rules, electronic documents such as CCTV camera footage, webcasting footage and video recording of candidates during the Model Code of



Conduct period are not covered. "CCTV coverage, webcasting of polling stations are not carried out under Conduct of Election Rules but are the result of steps taken by the EC to ensure a level playing field," a former EC official explained. An EC functionary said, "There have been instances where such electronic records have been sought, citing the rules. The

amendment ensures that only papers mentioned in the rules are available for public inspection and any other document which has no reference in the rules is not allowed for public inspection.

EC functionaries said the misuse of CCTV camera footage from inside polling booths could compromise voter secrecy. They also said the footage could be used to generate fake narrative using AI.

"All such material is available to candidates, including footage. After the amendment, too, it will be available to them. But other people can always approach the courts to get such electronic records," said another functionary.

Candidates already have access to all documents and papers. Nothing has been amended in the rules in this regard, the functionary added. Punjab and Harvana High Court, in the recent Mahmoud Pracha vs EC case, had directed sharing all documents related to the Haryana Assembly elections, including treating CCTV camera footage as permissible under Rule 93(2), with Pracha. Railway Ministry blames land acquisition From vision to reality: The journey of 2 bureaucrats hurdles for delays in Bengal projects to establish world's first pvt tribal university

KOTA (RAJASTHAN), Dec 21: In 2023, two former bureaucrats came together to open the world's first private tribal university. A year later, 600 students are studying at Jai Minesh Adivasi University's 30 acre campus in the Ranpur industrial area here.

"What was once unimaginable has become a reality," says R D Meena, co-founder of Jai Minesh Adivasi University, which is named after revered deity of Rajasthan's Meena community and dedicated to advancing research on tribal issues and culture.

Now, he hopes to make it a global hub for tribal studies, driving research and policy for the betterment of these communities.

Meena conceptualised the idea to open the university with retired IPS officer Laxman Meena.

Jai Minesh Adivasi University (JMAU) opened in May 2023 in Kota, a city renowned for grooming aspirants for IIT-NEET entrance exams

R D Meena, who is also the pres-



ident of the All India Shri Meena Social and Educational Committee, told PTI, "The Adivasi University, named after the community's lord, Jai Minesh, aims to be a global hub for tribal studies, providing affordable, quality education to students from all sections of society across the country and abroad."

In view of the tribal nature of the university, the state government not only allotted land for the institution at a concessional rate but also, in a

significant decision, authorised each of the 200 MLAs in the state assembly to donate ₹ 10 lakh to the university from their respective MLA funds, Meena further said.

A contribution of ₹ 25 lakh was also made by Lok Sabha Speaker and Kota-Bundi MP Om Birla, along with contributions from 2,500 community members.

The university offers 50 per cent reservation to children from the tribal community and enrolled 600

students in its first academic session.

The university primarily focuses on enhancing research on tribal issues and culture, as tribal communities represent 6 per cent of the global population across around 50 countries, Meena added.

Besides various academic degree and diploma courses in vocational programs, the university also provides free coaching to its students for civil service exams, he added.

"In the next 30-40 years, this university will be a global hub for tribal studies, driving research and policy for the betterment of these communities," R D Meena remarked

The Drawing and Painting department of the university has incorporated tribal art and cultural practices into its curriculum, as recommended under the New Education Policy, Dr Mukti Parashar, Dean of Drawing and Painting, Jai Minesh Adivasi University (JMAU), told PTI.

The labs at the university are

equipped with advanced technology and apparatus, and classes are regularly held to offer quality education, said Dr Devendra Acharya, Head of the Department of Physiotherapy, adding that the fee structure at JMAU is comparatively nominal.

With an objective to integrate tribal communities while preserving their identities, the journey for this university has just begun.

The destination appears promising, and Kota has evolved beyond being solely the city of coaching; it has transformed into a center for inclusive education and cultural preservation.

The institution embraces students from all backgrounds, transcending barriers of caste, class, or religion, establishing itself as an inclusive center for learning.

"My target is to crack the civil service exams after graduation, and I am availing myself of free coaching for the same at the university," said Priya Meena, an Arts student at the university. (PTI)

KOLKATA, Dec 21: The Ministry of Railways has reported significant delays in several railway infrastructure projects across West Bengal,

primarily due to challenges in land acquisition, an official statement said

Despite a substantial increase in funding, with allocations rising three times from ₹ 4,380 crore during 2009-14 to ₹ 13,941 crore in 2024-25, the pace of project execution remains hindered, the ministry statement said.

As of April 1, 2024, there are 43 railway projects in West Bengal, encompassing 4,479 km and costing ₹ 60,168 crore. These projects, which fall fully or partly within West Bengal under the Eastern, South Eastern, and North East Frontier Railways, involve new

lines and modernisation efforts. Of these, 1,655 km have been commissioned, with a capex outgo of ₹ 20,434 crore up to March 2024. The ministry stated that acquisition remains a significant bottleneck as out of the total 3,040 hectares required, only 640 hectares (21 per cent) have been acquired, leaving a balance of 2,400 hectares (79 per cent) yet to be secured.

It said the Railways acquires land for its projects through state governments

Railways pointed out some key projects experiencing delays due to land acquisition issues include: Nabadwipghat-Nabadwipdham new line (10 km): requires 106.86 hectares; only 0.17 hectares acquired. Chandaneshwar-Jaleswar new line (41 km): requires 158 hectares; no land acquired to date. Naihati-Ranaghat third line (36 km): requires 87.83 hectares; only 0.09 hectares acquired. Balurghat-Hilli new line (30 km): requires 156.38 hectares; 67.38 hectares acquired. Bypasses at Sainthia (5 km) and Sitarampur (7 km): require 22.28 hectares; but only 2.22 hectares could be acquired.

The completion of railway projects depends on various factors, including prompt land acquisition by state governments, forest clearances, cost-sharing deposits, shifting of utilities, statutory clearances, geological and topographical conditions, law and order situations, and climatic conditions affecting the number of working months available annually, the ministry said. RAFI@100: MOHAMMED RAFI IS MY MUSICAL FATHER, SAYS SONU NIGAM

MUMBAI, Dec 21: There can be no comparison between a father and a son. For Sonu Nigam, who considers Mohammed Rafi his "musical father", the very idea of comparing himself to the legendary singer is unthinkable.

After all, whatever he sings, he can never be quite like the master himself, said Nigam ahead of Rafi's 100th birth anniversary on December 24.

"Rafi sahab was the prime reference point. It was like 'Be like him, he can sing a qawwali, a bhajan, a sad song, a high-pitch song, a semi-classical'. So that's what a singer should be like. He was my inspiration," Nigam told PTI.

It began right in childhood itself.

Nigam's singer parents -Agam and Shobha - encouraged him to emulate the great Rafi who covered the spectrum of every genre and emotion through his effortlessly versatile voice.

"He has helped me be what I'm today and I still keep learning from him. He is my musical father," Nigam said. The 51-year-old, sometimes



Soccer's top players have had enough, as FIFA's new super-sized tournament sparks revolt

MANCHESTER, Dec 21: One of the most striking moments of soccer in 2024 was when Rodri hobbled onto a stage in Paris on crutches to receive the prestigious Ballon d'Or for best male player of the year.

The Manchester City and Spain midfielder had been one of the most outspoken critics against the increasingly congested soccer calendar, warning that the lack of downtime was detrimental to players' performance and health. Then, just a month before the Oct. 28 award ceremony, he tore his ACL during a seemingly routine run in a Premier League game against Arsenal.

Though such injuries have occurred throughout the history of the sport and aren't necessarily linked to overplaying, Rodri's season-ending injury became a visual representation of the physical toll of modern soccer at a time when the busy match schedule is facing legal challenges and the possibility of strike action.

Top footballers are now routinely playing more than 60 games per season for club and country, while the game is getting faster and more intense. Injuries are on the rise. Already pushed to their limits, some players say FIFA's newly expanded Club World Cup, to be held in the United States next year, is the last straw.

Players say they are "at breaking point, that they are at the limit, that it's actually too much," Alexander Bielefeld, from global players' union FIFPRO, told The As-



sociated Press.

The new Club World Cup is a supersized version of what used to be a short tournament with only seven teams. The new edition includes 32 teams from around the world and will be held every four years, starting next summer in the United States from June 14 to July 13. As its name suggests, it's envisioned to be club version of the World Cup for national

teams That means top players will have a monthlong tournament on top of their domestic league season three out of every four years. With more games also added to the Champions League in Europe this season as well as the next World Cup in 2026, the soccer calendar is filling up quickly.

"It's something that worries us because we are the guys who suffer," Rodri said in September, just days before he was injured. He said playwould be fair to expect a continuation of this upwards traers may have no choice but to refuse to play if the trend conjectory.

Tony Strudwick, medical director for West Bromwich Albion and former head of performance for Manchester United, said injuries are on the rise despite advancements in sports science and medicine.

"That to me looks like there's a mismatch between what the players can physically tolerate and what they've been exposed to," he told The AP. "During the last eight seasons, incidents of hamstring injuries, in particular, have increased.' Strudwick said the risk of

too many games was ultimately injury and burnout. But he said players are unlikely to raise the issue with their clubs or national teams. "Players are very reluctant

to say they don't want to play and they're very, very tired. It takes a relatively brave person to do that," he said.

Manchester City played 61 games in the 2022-23 campaign when it won a trophy treble of the Premier League, Champions League and FA Cup. This season that number could rise to 71 because of an expanded group stage and potential playoff in the Champions League and the Club World Cup. A heavy workload is also

an issue in women's soccer, FIFPRO said earlier this week, though it noted that while some top players have a packed schedule, others don't get to play enough.

If successful, the Club World Cup could rival the Premier League and Champions League as one of the most lucrative and watched tournaments in club soccer. (AP)

Jadeja urges top-order to fire in Boxing Day Test

MELBOURNE, Dec 21: Star India all-rounder Ravindra Jadeja on Saturday said lack of runs from the top-order builds pressure on the lower-order and called for an improved performance from the batting unit in the Boxing Day Test here.

Jadeja played a crucial role in the rain-hit third Test against Australia at Brisbane, scoring a gritty 77 in the first innings to help India secure a draw.

"Top-order runs are very important when you play outside India, especially in Australia and South Africa. When the top order doesn't score runs, the responsibility and pressure increase on the lower order," Jadeja said during an interaction at the MCG.

"Hopefully, the top-order and the middleorder do well in this Test. As a team, we need the top order to perform. If everyone contributes in the batting unit, the team will do well."

India's top-order struggled in Brisbane, barring opener KL Rahul, who scored a valiant 84. The rest of the top and middle order crumbled, but Jadeja, playing his first match of the tour, kept India afloat.

The match was eventually saved by the last-wicket stand between Jasprit Bumrah and Akash Deep, who produced a heroic partnership to avoid the follow-on.

While Washington Sundar was preferred in the opening Test in Perth, Ravichandran Ashwin featured in the second Test in Adelaide. Jadeja said missing the first two matches worked to his advantage as it allowed him to acclimatize to the conditions and prepare for the Gabba Test.

"I got a nice few days to understand and get used to the conditions. I was here so many days, I used to bowl and bat on the tracks here. I got more familiar with the conditions here," he said.

Ashwin retired with an illustrious record of 537 Test wickets at an average of 24 and 3,503 runs, including six centuries. He also claimed 156 wickets in ODIs and 72 in T20Is.

Describing Ashwin as his mentor, Jadeja said: "He played like my on-field mentor. We have been playing together for so many years as bowling partners. We kept passing messages to each other on the field regarding the match situation. I will miss all these things.

Jadeja and Ashwin shared a fruitful partnership in Tests, combining for 587 wickets across 58 matches.

Following Ashwin's retirement, Jadeja expressed hope that the team could find a suitable replacement "Hopefully, the Indian team gets a better

all-rounder and bowler. It's not like nobody can replace a player. Everyone goes, but you get the replacement," he said. "We have to move on. We will have to

move on. It is a good opportunity for young-sters to grab the opportunity." (*PTI*)

Annolpreet smashes fastest List A hundred by an Indian as Punjab beat Arunachal Pradesh

AHMEDABAD, Dec 21: Anmolpreet Singh smashed the quickest List A hundred by an Indian, a 35-ball effort, to guide Punjab to an easy nine-wicket win over Arunachal Pradesh in a Group C Vijay Hazare match here on Saturday.

Anmolpreet, who went unsold in the recent IPL auction, broke the record of former India all-rounder Yusuf Pathan, who had scored a hundred off 40 balls for Baroda against Maharashtra in 2009-10.

This knock is also the third fastest List A hundred behind Aussie Jake-Fraser McGurk, who smashed a 29-ball ton for South Australia against Tasmania in 2023-24, and South African AB de Villiers' 31ball hundred against the West Indies at Johannesburg in 2014-15.

The right-handed Anmolpreet made 115 off 45 balls (12x4, 9x6) as Punjab chased down a target of 165 in just 12.5 overs, reaching 167 for one. After the early fall of skipper Abhishek

Sharma (10), Anmolpreet and Prabhsimran Singh (35 not out, 25b) milked 153 runs for the unbroken second wicket alliance to guide Punjab home.

Earlier, Arunachal were bowled out for 164 with pacer Ashwani Kumar and legspinner Mayank Markande taking three wickets apiece.

Ashwin's wife pens heartfelt tribute after his sudden retirement



CHENNAI, Dec 21: Ravichandran Ashwin's wife Prithi Narayanan has penned a heartfelt tribute for her husband following his recent retirement from international cricket, saying "it is time to set the burden of being you down" and embrace life beyond the game. Ashwin made a surprise an-

nouncement of his retirement after the drawn third Test at Brisbane. The veteran off-spinner picked up just one wicket during the tour, including the 10-wicket loss at Adelaide

The 38-year-old retired with a stellar record of 537 Test wickets at an average of 24, in addition to scoring 3,503 runs, including six centuries. He also claimed 156 wickets in ODIs and 72 in T20Is.

Describing her tribute as a "Love letter from a fan girl", Prithi wrote on instagram: "Dear Ashwin, from not knowing how to put a kit bag together to following you to stadiums all over the world, rooting for you, watching you and learning from you, it has been an absolute pleasure. The world you introduced me to gave me the privilege to watch and enjoy a sport that I love from close quarters.

"It also showed me how much passion, hardwork and discipline is needed to keep your head above water. And sometimes even that is not enough. I remember us talking about why you, R Ashwin, had to do all of this and a lot more to even stay relevant in the scheme of things.

Ashwin, who debuted in 2011 against the West Indies, earned a reputation for his relentless pursuit of excellence. His near-equal tally of 269 wickets against right-handers and 268 against left-handers

highlights his versatility.

"How awards, the best of stats, the POMs, the accolades, the records didn't matter if you didn't sharpen your skill sets constantly and did not put in the work. Sometimes, nothing is enough," Prithi continued.

"As you end your wonderful international run, I only want to tell you that it's all good. It is all going to be good. It is time to set the burden of being you down. Live life on your terms, make space for those extra calories, make time for your family, make time to do absolutely nothing, share memes all day, create a new bowling variation, bug our kids out of their minds. Just do it all."

Prithi, who has been a constant companion on Ashwin's cricketing journey, reflected on his meticulous approach to his craft.

"When I saw Ashwins PC, I thought of small and big moments. Many many memories over the last 13-14 years. The big wins, the MOS awards, the quiet silence in our room after an intense game, the sound of the shower running for much longer than usual on some evenings post play, the scratch of pencil over paper as he scribbled thoughts down, the constant streaming of footage videos when he is making a game plan, the calm of meditative breathing before leaving for each game, certain songs playing on repeat while he unwinds..

"The times we weeped in joy after the CT final, after the MCG win, after the Sydney draw, The Gabba win, after making a comeback in T20s...the times we sat in silence and the times when we had our hearts broken," she wrote, (PTI)

Hockey in 2024: Consecutive Olympic medals, Sreejesh, HIL make headlines

NEW DELHI, Dec 21: Back-to-back Olympic medals after a hiatus of 50 years and the revival of the muchawaited HIL lit up the year for Indian hockey which also saw one of its biggest stars walk into sunset after a glorious career.

With their third-place finish in the Paris Olympics this summer, the Harmanpreet Singh-led men's team proved that the historic bronze in the Tokyo Games three years ago was not a flash in the pan.

The medal ensured the legendary PR Sreejesh, one of the team's biggest pillars for nearly two decades, got the send-off he deserved after he decided to retire from the sport. That he is now associated with the junior teams bodes well for Indian hockey as it seeks more success in the coming times.

Before Tokyo and Paris, the last time the Indian hockey team won successive Olympic medals was at 1968 Mexico City and 1972 Munich Games.

Under chief coach Craig Fulton, the Indians had to alter their playing style, concentrating more on defence and relying on counters to build fast-paced attacks, and the players embraced the approach before the big event came call-

The Indians played fearless hockey throughout the Games and the win against Great Britain in the quarterfinals, with 10 men, was a reflection of the players' mental toughness.

India played with a man less for nearly 43 minutes and eventually won the match in shoot-out thanks to resolute defending and PR Sreejesh's brilliance under the bar to progress to a second straight Olympic semifinals.

It was not just about defending, Fulton's team also showed their attacking prowess to stun mighty Australia 3-2 in their final pool game, ending a 52-year wait for a win over the formidable Kookaburras in the Olympics.

That victory held great significance as it came against a side which mauled them 5-0 in a Test series Down Under earlier this year.

India's hopes of playing an Olympic final were dashed by Germany in a close contest but, within 24 hours, they regrouped and beat Spain 2-1 to clinch another podium finish, showing sings of a



bright future. Many stars sparkled and some new

ones emerged in the year gone by but none can come close to what old warhorse Harmanpreet and Sreeiesh did

for the team. The duo complemented each other on the field and played a massive role in the team's success.

While Sreejesh was as solid as ever in front of the post in his final hurray. Harmanpreet was sturdy in the backline and ferocious with his dragflicks, finishing as the top scorer in Paris with 10 strikes from eight games.

Harmanapreet's exploits throughout the year, especially in Paris, won him his third FIH Male Hockey Player of the Year award.

Among women, young Deepika emerged as a bright spot in 2024 and she not only is a fine striker but also a potent dragflicker.

Nicknamed 'The Wall of Indian hockey', Sreejesh has worked on his craft every day to become one of the world's top goalkeepers. So when he announced his decision to retire after the Games just after reaching Paris, it came as a shock for the entire sports fraternity. In his final hurray also, he never put a foot wrong, making saves after saves to keep India in the hunt.

The much-anticipated revival of the Hockey India League after a gap of seven years was the icing on the cake for the national sport as the event has been the biggest feeder line for players in the past, producing stars like Harmanpreet, Manpreet Singh and many others.

The league also provides young Indian players the chance to rub shoulders with the best of world hockey.

This year the HIL has come in a new look with the introduction of a fourteam women's event alongside eightteam men's league. While the men's league will be held in Rourkela from December 28, the women will play in Ranchi from January 12.

Another big retirement of the year was that of the undisputed queen of Indian women's hockey, Rani Rampal, which brought the curtains down on a 14-year long illustrious career.

The lowest point came at the beginning of the year when the women's team failed to qualify for the Paris Games through the Olympic Qualifiers in Ranchi. It led to widespread changes in the team, with stalwart Harendra Singh taking over the coaching duties from Janneke Schopman.

But the year ended on a good note for both the men and women as they claimed the Asian Champions Trophy titles in Hulbuir, China and Rajgir, Bihar respectively, raising hopes of a bright future. (PTI)
