# Assam cabinet approves ₹ 2,000 cr for schemes to empower women, youth

MORIGAON, Jan 16: The Assam cabinet on Thursday approved ₹ 2,000 crore for the implementation of schemes aimed at empowering women and youth.

Addressing a press conference after chairing a cabinet meet here, Chief Minister Himanta Biswa Sarma said, "This is the first outstation cabinet sitting of this year. These sittings in different districts have helped in accelerated development. The next outstation cabinet meeting will be in Nagaon."

The council of ministers approved ₹ 2,000 crore for implementation of the Mukhya Mantri Mahila Udvamita Asoni (MMMUA), Chief Minister's Atmanirbhar Asoni and other schemes for 2024-25, he added.

"Guidelines for implementation of MMUA have also been approved and ceremonial distribution



of seed capital will begin from April," he said.

Sarma said though around 31 lakh women meet the criteria for availing MMMUA, the scheme can be extended to 27 lakh beneficiaries as per budgetary alloca-

"Due to this, some specific criteria have been decided upon to bring the eligibility list to 27 lakh. The scheme will be rolled out from Behali," he added.

Jan 16: The Assam government on Thursday announced a judicial enquiry and a police Special Investigation Team (SIT) probe into the Umrangso coal mine incident, in which nine workers were trapped with bodies of four victims recovered so far.

It also declared an ex-gratia of ₹ 10 lakh each to the families of the victims, even as officials said that suspected seepage of fresh water from underground streams has slowed down the dewatering

A coal mine in the Umrangso area of Dima Hasao district was flooded on January six when water had gushed in suddenly, trapping nine workers inside. Four bodies have been recovered since then in



Chief Minister Himanta Biswa Morigaon, said, "We discussed in Sarma, announcing decisions detail about the Umrangso tragedy taken at a Cabinet meeting at and officials deputed at the inci-

situation on ground."

He said as per the assessment of agencies like the Geological Survey of India, Coal India, OIL, NDRF, Army and Navy, engaged at the incident site, about 1,400 crore litres of water was present in

the mine. "About 400 crore litres has been pumped out so far and, if the dewatering continues at the current rate, it will take about 25 to 60 days for the process to be completed. We have told the agencies to continue with the process in the presence of the army till we reach the logical conclusion," the CM added. Sarma said the chances of survival of the remaining five miners are "slim" now and announced ₹ 10 lakh compensation to families

### Lok Sabha MP Dilip Saikia set to become new Assam BJP chief

GUWAHATI, Jan 16: Lok Sabha MP Dilip Saikia is set to be the next Assam BJP president as he became the only nominee for the post till Thursday, the last day for filing nominations, a party leader said.

The formal announcement for the state BJP chief will be made on Friday, he added.

Saikia is the second-time MP from the Darrang-Udalguri (previously Mangaldai) constituency.

"Saikia is the only nominee for the state president's post. He filed his nomination before our central leader Gajendra Singh Shekhawat, who is the returning officer for this election," state BJP spokesperson Dewan Dhruba Jyoti Maral told

The cut-off time for filing nominations was 7 pm on Thursday.

The MP submitted a list of 20 proposers and supporters along with his nomination, with outgoing state president Bhabesh Kalita, CM Himanta Biswa Sarma and deputy speaker in the state Assembly Numol Momin being among the signatories.

## Over 1.28 million pages of rare Assamese US removes sanctions on BARC, manuscripts, journals, books digitised

**GUWAHATI, Jan 16:** Over 1.28 million pages of rare manuscripts, journals, and books in Assamese have been digitised.

This marks a significant milestone in safeguarding and promoting Assamese literature, said Narayan Sharma, president of the Assam Jatiya Bidyalay (AJB) Educational and Socio-Economic Trust.

The digitisation work was done over 36 months, he said.

"This is a vital asset for researchers, students, and the global Assamese community. It ensures the timeless legacy of Assam is preserved with the aid of cutting-edge technology," Sharma

Among the literary works digitised are 26,000 'Xasipats', manuscripts on Vaishnavism. Buddhism, and Assamese traditions.

The project is a collaborative effort between the Nanda Talukdar Foundation (NTF) and the AJB Educational and Socio-Economic Trust, with support from Asam Sahitya Sabha, Dibrugarh University, and corporates such as Oil India Limited, NRL, and ONGC.

The digitised collection features nearly all editions of Orundoi, Assam's first magazine, alongside other iconic publications like Bahi, Abahan, and Ramdhenu. Additionally, the repository includes 33,970 books and 41,071 journal issues, all of (CONTD. ON PAGE-2)

# Sensex, Nifty extend gains for 3<sup>rd</sup> day on strong global cues, lower US inflation

mark indices Sensex and Nifty rallied for the third session on the trot on Thursday, helped by a rally in global markets after lower-than-expected consumer inflation in the US ignited hopes of more rate cuts by the Federal Reserve.

Intense buying in Reliance Industries, ICICI Bank and HDFC Bank also boosted sentiments, traders said. The 30-share BSE index climbed 318.74 points or 0.42 per cent to revisit 77,000 level at 77.042.82. During the day, it jumped 595.42 points or 0.77 per cent to 77,319.50

On the similar lines, the NSE Nifty rallied 98.60 points or 0.42 per cent to 23,311.80.

As many as 2,778 stocks advanced, while 1,188 declined and 101 remained unchanged on the BSE. Unabated foreign fund inflows, weakness in the rupee and elevated global crude prices continue to weigh on domestic equity markets, traders said.

"Benchmark indices continued to trade in the positive, albeit off highs, driven by positive investor sentiment following mild US inflation data, which raised hopes for a potential rate cut by the Federal Reserve. "Additionally, favourable developments in the Israel-Hamas ceasefire and a reduced trade deficit further boosted the market's upward movement. However, weak economic growth data from the UK

## Global shares advance after inflation data drives rally

TOKYO, Jan 16: Global shares mostly rose Thursday, following a rally on Wall Street driven by encouraging update on US inflation.

France's CAC 40 edged up 1.4% in early trading to 7,576.97, while Germany's DAX was down less than 0.1% at 7,576.97. Britain's FTSE 100 rose 0.7% to 8,355.34. The future for the S&P 500 was up 0.2% while that for the Dow Jones Industrial Average was nearly unchanged.

In Asian trading, Japan's benchmark Nikkei 225 added 0.3% to finish at 38.572.60.

Bank of Japan data showed wholesale prices in Japan rose 3.8% in December last year compared to a year earlier, adding to pressures on the central bank to raise interest rates, possibly at a monetary policy meeting next week. In China, the Hang Seng in Hong Kong gained 1.2% to 19,522.89, while the Shanghai Composite index rose nearly 0.3% to 3,236.03.

Australia's S&P/ASX 200 surged 1.4% to 8,327.00. South Korea's Kospi gained 1.2% to

# Infosys Q3 profit up 11.5 pc at ₹ 6,806 crore; company raises growth guidance

NEW DELHI, Jan 16: IT services major Infosys on Thursday reported 11.46 per cent increase in consolidated net profit at ₹ 6,806 crore for December quarter FY25 and raised its guidance on the back of growth in financial services and manufacturing.

The company had logged a profit of ₹ 6,106 crore in the corresponding period of the previous

Revenue from operations for the quarter under review came in at Rs 11,764 crore, 7.58 per cent higher than Rs 38,821 crore in Q3 FY24.

Financial services and manufacturing contributed 27.8 per cent and 15.5 per cent, respectively to the revenue, followed by retail and

In geographical terms, Infosys saw double-digit year-on-year growth in India and Europe. North America registered an annual

growth of nearly 5 per cent. "Financial services in the US continues to grow strongly in this quarter and over the past few quarters. We have seen a revival in European financial services during Q3. We are seeing an improvement in retail and consumer product industry in the US with discretionary

pressure easing," Infosys CEO and MD Salil Parekh said during the company's earnings call.

For the third consecutive quarter, Infosys raised the 2024-25 fiscal year revenue guidance. It now anticipates revenue growth of 4.5 to 5 per cent in FY25, up from 3.75-4.50 per cent it had given in the previous quarter.

Operating margin guidance remained unchanged at 20-22 per

"Our strong revenue growth sequentially in a seasonally weak quarter and broad-based year-onyear growth, along with robust operating parameters and margins, is a clear reflection of the success of our differentiated digital offerings, market positioning, and key strategic initiatives. We continue to strengthen our enterprise AI capabilities, particularly focusing on generative AI, which is witnessing increasing client traction," Parekh

The company added 5,591 employees during the quarter, bringtotal headcount to

Infosys CFO Jayesh Sanghrajka said the firm is on track to meet its hiring commitment and will hire

over 15,000 staff in the current fis-

"We are expecting 20,000 plus fresher hiring for FY26," he said. On whether a new US regime will affect the company, Sanghrajka said the company's depend-

ence on H1B visas has reduced. "Over the years, our dependence on H1B visas has reduced significantly. First and foremost, our onmix has reduced significantly--we used to be in the 30 per cent range...we are now at the 24 per cent range. Within that, our near shore has increased significantly

# Reliance Q3 net rises 7.4 pc on rebound in retail, higher telecom earnings

NEW DELHI, Jan 16: Reliance Industries Ltd on Thursday reported a 7.4 per cent rise in its December quarter net profit as retail business rebounded, telecom earnings surged on higher tariffs and mainstay oil and petrochemicals business delivered consistent perform-

Its consolidated net profit of ₹ 18,540 crore, or ₹ 13.70 per share, in October-December - the third quarter of April 2024 to March 2025 fiscal (FY25) - compared to ₹ 17,265 crore, or ₹ 12.76 a share, in the same period a year back, according to a company statement.

Profit was also up sequentially from ₹ 16,563 crore in the July-September quarter.

The profit before tax (EBITDA) rose 7.8 per cent to ₹48,003 crore. This was despite an almost 7 per cent rise in finance cost due to higher debt (₹ 3.5 lakh crore as of December 31, 2024, compared to ₹ 3.36 lakh crore in September and ₹ 3.11 lakh crore in December 2023). Its revenue was up 7.7 per cent yearon-year to ₹ 2.67 lakh crore.

Higher tariffs and more customers helped telecom arm profits jump, while more stores and higher footfalls helped retail businesses rebound. Good domestic demand and rising petchem margins helped oil-tochemicals businesses post decent numbers.

While Jio Infocomm's standalone profit jumped 24 per cent to ₹ 6,477 crore in Q3, Jio Platforms - the unit that houses all digital business - reported a 26 per cent rise to ₹ 6,861 crore.

All four key parameters - data minute usage, data consumed, average per-user earnings and number of subscribers - grew. The customer base rose to 482.1 million from 478.8 million in July-September 2024 and 470.9 million in October-December 2023, average revenue per user crossed the Rs 200 per month mark. ARPU in Q3 was ₹ 203.3 against ₹ 195.1 in the previous quarter and ₹ 181.7 a year back.

The residual impact of the tariff hike implemented in mid-2024 will flow through over the next few months, the firm said.

Retail arm Reliance Retail Ventures Ltd posted a 10 per cent year-on-year rise in profit to ₹ 3,458 crore as it opened 779 new stores to take the number to 19,102 and footfalls rose to 296 million on festive buying from 282 million a year back.

Oil-to-chemical business, which houses the company's twin refineries at Jamnagar in Gujarat and petrochemical plants, saw EBITDA rise 2.4 per cent to ₹ 14,402 crore. The refineries processed more crude and petchem margins improved.

In the fuel retail business, Jio-bp - its joint venture with BP of the UK - posted "highest ever quarterly sales across both petrol and diesel", the statement said.

Lower gas production from the KG-D6 block and a fall in the price of coal seam gas led to a 4.1 per cent fall in pre-tax profit of its oil and gas business to ₹ 5,565 crore in Q3.

"The average KGD6 production for the 3Q is 28.04 million standard cubic metres per day of gas and 21,000 barrels a day of oil," it said, adding that the current rate of production is around 27.9 mmscmd of

## Rupee drops 21 paise to 86.61 against US dollar

MUMBAI, Jan 16: The rupee depreciated 21 paise to close at 86.61 against the US dollar on Thursday, dragged down by a strong American currency overseas, elevated crude oil prices and foreign fund

However, positive domestic equity markets provided support at the lower level, forex traders said.

At the interbank foreign exchange, the rupee opened at 86.42 and touched the intraday high of 86.37 before ending the session at 86.61 against the greenback, 21 paise lower from the previous

The local unit settled with a gain of 13 paise at 86.40 against the dollar on Wednesday, a day after rebounding 17 paise from its lowest-ever level.

Anuj Choudhary, Research Analyst at Mirae Asset Sharekhan, said the rupee declined due to increased demand for dollars by im-

"Importers may continue to buy dollars, which may further pressurise the rupee. Traders may take cues from retail sales and weekly unemployment claims data from the US. USD-INR spot price is expected to trade in a range of ₹ 86.35 to ₹ 86.75," he said.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.05 per cent igher at 108.97.

The rupee's weakness was due to a recovery in the dollar index. which regained strength above 109 levels, coupled with continued volatility in crude prices, Jateen Trivedi, VP Research Analyst -Commodity and Currency, LKP Securities, said.

"Concerns over global economic conditions and muted FII flows added to the pressure on the rupee. The trading range for the rupee remains between 86.40 and 86.80 in the near term," he added.

Brent crude, the global oil benchmark, fell 0.12 per cent but stayed elevated at USD 81.93 per barrel in futures trade.

Analysts said concerns over geopolitical uncertainties are likely to add volatility in the dollar and crude until the US gets a new administration under President Donald Trump next week.

In the domestic equity market, the 30-share BSE Sensex climbed 318.74 points, or 0.42 per cent, to settle at 77,042.82 points, while the Nifty rose 98.60 points, or 0.42 per cent, to 23,311.80 points.

Foreign institutional investors (FIIs) offloaded equities worth Rs 4,341.95 crore on Thursday. (PTI) Data Protection Rules that do not mention any penal action for

# India needs targeted interventions to stabilise turmeric production: Report

HT Bureau GUWAHATI, Jan 16: A day after the launch of the National Turmeric Board, the Indian Council for Research on International Economic Relations (ICRIER) and Amway India Enterprises Pvt Ltd, unveiled a comprehensive joint report titled "Making India the Global Hub for Turmeric" on Thursday, addressing the pressing challenges faced by turmeric farmers and offering a strategic roadmap to enhance India's position in the

global turmeric market. An official statement said that the ICRIER-Amway Report highlights that while the global turmeric market, valued at USD 58.2 million in 2020, is expected to grow at a CAGR of 16.1 per cent by 2028, Indian turmeric farmers face hurdles such as fluctuating prices, limited market access, and inadequate post-

harvest infrastructure. "Despite India cultivating across



hectares with an expected production of 1,041,730 MT in 2023-24, there is a pressing need for targeted interventions to stabilise production and empower

farmers", the statement said. "According to the findings, third-party certified organic helps farmers to get a better price, but it is costly, and there is no subsidy. Hence, the report recommends subsidy for thirdparty organic, streamlining regulatory bodies and signing mutual recognition agreements for regulatory cooperation that will help to promote exports", it

The report also pointed out that India is able to supply only 10 percent of global demand of high-curcumin (over 5 per cent) turmeric with lower Maximum Residue Levels (MRLs). Hence, R&D is needed to develop, high-curcumin variety and such varieties should be marketed in global platforms, it said, adding that with six GI products, GI discussions in trade agreements are important. "India has more than 30 varieties of turmeric and there is scope for more GI products. Focus should be to secure GI in products above 5 per cent curcumin," the Report emphasised.

We must look to the future and think about prosperity and progress." The Tsungkamneo festival is a harvest festival celebrated by the Yimkhiung Naga tribe of Nagaland.

Noting that the Tsüngkamnyo festival is a time to celebrate community and the cultural heritage of our people, he said it is thus an apt time to reflect on the meaning of community.

Asserting that "we cannot forget our history and tradition", Sukhalu said, "It is not just about our festivals, traditional attire and customs. Our culture is rooted in the village ethos, which is marked by community, shared experience and generosity."

## Farmers' fast-unto-death

eteriorating health condition of the farmer leader Jagiit Singh Dallewal, who has been fast-unto-death hunger strike since November 26, 2024, has become a matter of serious concern, since he has been willing to end his hunger strike if Prime Minister Narendra Modi led government agrees for talks on farmers demand, but the Centre has shown no willingness yet. On the 51st day of Dallewal's hunger strike on January 15, 2025, Khanauri border turned tense with another 111 farmers joining him on fast-unto-death. As opposed to the Punjab side of the Khanauri border, there is a heavy deployment of security forces by the BJP-led Haryana government blocking their road to Delhi. Farmers have been on sit-in protest there since February 13, 2024, when they were stopped from marching to Delhi to press for their demands, the chief among them was a legal guarantee for Minimum Support Price (MSP). Modiled government has been asserting that they have been providing MSP at remunerative rates to farmers, but has not conceded the legal guarantee for the same, which has created a great suspicion among the farmers. The Centre has not been showing even any interest in beginning talks with the farmers on their demand.

It has a political ramification which is felt more by the Punjab unit of the BJP, a delegation of which had met Akal Takht Jathedar last week and expressed concern over Dellewal's deteriorating health and requested the supreme Sikh body Akal Takht's Jathedar Giani Raghbir Singh to intervene and give a direction to Dallewal to end his fast since Dallewal is also a Sikh. In the history of fast-unto-death hunger strikes in India, the second leg of the farmers movement has entered a sensitive phase breaking past records. Dallewal's fast-unto-death hunger strike is now one among the longest. Number of peoples, now 112 farmers, sitting on fast-unto-death at any place in independent India is perhaps the largest. Supreme Court of India has also shown its concern about the deteriorating health of Dallewal. On January 15, a bench comprised of justices Surva Kant and N Kotiswar Singh has given direction to the Government of Punjab to furnish a complete set of comparative medical reports of the farmer leader Jagjit Singh Dallewal for an independent evaluation for his deteriorating health condition by the director of the All India Institute of Medical Sciences (ÁIIMS), New Delhi. Supreme Court bench was sceptic about the report of the Chief Secretary of Punjab who said that Dallewal's platelet count and haemoglobin levels had improved, which prompted the bench to give the fresh direction.

Supreme Court has been hearing a contempt petition against Punjab's chief secretary and DGP over the ineffective handling of Dallewal's hospitalisation and the prolonged blockade at the border points which Haryana at Shambhu and Khanauri. Haryana has been keeping both the points blocked since February 13, 2024, so that the farmers can not march to Delhi for pressing on their demand from the PM Narendra Modi government. This second leg of the farmers agitation is led by Samyukta Kisan Morcha (non-political) and Kisan Mazdoor

1951) stands as the revered cultural luminary of Assam, heralding a cultural renaissance that played a pivotal role in delineating Assamese identity from the shadows of Bengali influence. In 1935, he etched his name in history by spearheading the Assamese film industry with the creation of the pioneering film "Joymoti." Agarwala's profound impact extended far beyond the realms of art and culture, as he intricately wove the fabric of Assamese literature through his compelling dramas, poignant poems, and captivating short stories. His journalistic prowess and musical compositions, collectively known as "Jyoti Sangeet," echoed not only in the hearts of Assam but resonated across the entire North-East region, leaving an indelible mark on generations.

An emblem of fervent patriotism and a revolutionary spirit, Jyoti Prasad Agarwala, despite being born into one of Assam's most affluent families, became a torchbearer for the freedom movement from his teenage years. His commitment deepened upon his return from Edinburgh University and Germany in 1930, where he delved into the realms of Economics and Film-making. Endowed with Mahatma Gandhi's blessings during the latter's stay at the ancestral home "Poki" in Tezpur, Agarwala founded the "Mrityu Bahini" (Death Squad) imbued with the tenets of non-violence, yet embracing the motto "Karengay ya Marengay" (Do or Die).

# Rupkonwar Jyotiprasad - Cultural pioneer of modern Assam

upkonwar Jyotiprasad Agarwala stands as a pivotal figure in the cultural landscape of Assam, whose profound contributions during the early 20th century not only revived the Assamese cultural identity but also laid the foundation for modern Assamese art, literature, music, and cinema. His relentless efforts to blend tradition with modernity led to a cultural renaissance in Assam, where the region's artistic expressions flourished even under the shadows of colonialism and socio-political subjugation. Agarwala's legacy as a poet, playwright, filmmaker, composer, and nationalist positions him as one of Assam's greatest cultural architects, whose influence remains deeply woven into the cultural fabric of the region.

Born in 1903 in the midst of British colonial rule, Agarwala's early exposure to both traditional Assamese culture and modern education shaped his worldview. The socio-political climate of Assam during this period was marked by colonial suppression, economic stagnation, and a cultural identity crisis. Assamese art forms, literature, and language were gradually eroding under the weight of colonial hegemony and the imposition of Bengali language and culture during the 19th century. His compositions served as anthems of cultural resurgence and continue to inspire generations in

Agarwala's literary legacy is equally profound. As a playwright, poet, and essayist, he used literature as a tool for social commentary and cultural reawakening. His plays, including Karengar Ligiri, Rupalim, Lavita and Sonit Konwari, are celebrated for their exploration of Assamese folklore, historical themes, and social issues. These plays were not mere theatrical expressions but powerful instruments for awakening public consciousness. Agarwala's literature often portraved strong female characters, historical narratives, and the importance of moral courage, which mirrored his vision for a culturally empowered society. His writings also reflected a synthesis of romanticism and realism, emphasizing both the beauty of Assamese traditions and the challenges posed by colonialism and modernity.

Theatre remained central to Agarwala's artistic philosophy. His theatrical innovations introduced modern stagecraft, dialogues drawn from the Assamese linguistic heritage, and narratives that blended folklore with contemporary realities. Through his plays. Agarwala sought to educate the masses about their own cultural richness while simultaneously critiquing social evils such as feudalism, gender oppression, and the erosion of indigenous identities. His theatre was not just art but activism, a platform for igniting collec-

tive introspection and transformation. Agarwala's contributions were not confined to the artistic domain alone; they were inherently political. As a cultural nationalist, he believed that the revival of Assamese identity was intrinsically linked to India's struggle for independence. He saw cultural preservation as an act of defiance against colonial attempts to erase indigenous identities. His works consistently reflected anti-colonial sentiments. emphasizing the importance of self-re-

## Kerala's caste conundrum By: M.R.Lalu

ndia's caste centric politics

frequently gives us devas-Lating jolts. It turns unpredictable as churn in the caste equations topple fortunes of parties and candidates alike. So are the conflicts about controversies on the narrative wars and the resentments of castes, groups and religions. In the present scenario, castes can topple governments and even reinstate them as well. Why do I call the politics caste centric? Most of the parties while strategizing the winnability of candidates first choose to underline the caste equations of the region. And the matter that I am going to discuss in detail here exposes the divergent views that the parties carry out without a sense of blemish. The recent narrative war began with Udayanithi Stalin the DMK scion in Tamil Nadu whipped up a storm. His call for the eradication of Sanatana Dharma, which he accusingly declared as an epidemic of malice, was the most devastating remarks that any politician could have uttered. His nonconformist verbal war on the world's oldest religion was a reintroduction of an ideology that his party continued to execute in a turbulent Dravidian political mobilization in his state which began with a convulsive and atheistic political movement by Ramaswamy Naickar popularly known as Periyar. The movement remained a detractor of Sanatana Dharma, especially of its alleged caste discrimination. Junior Stalin's call for its elimination continued to serve as fertilizer for the BJP's Hindu mobilization, which successfully captured the power of the wind possibly consolidating the majority sentiments especially while the Northern states went to polls. Throughout its campaign in the National Elections too, the BJP did not leave a leaflet of controversy the Deputy Chief Minister of Tamil Nadu triggered. That was understandable as politics is played out from unpredictable directions. Unsurprisingly, the second

in the line of a similar raging controversy was from the Kerala Chief Minister Pinarayi Vijavan. He represents the

Marxist (CPI-M), the party that throughout its electoral ascend and downfall consistently maintained its anti-sanatana stance. This time, he chose to highlight the social influence of Sree Narayana Guru, the most popular saintly social reformer of Kerala from the 20th Century. He said Sanatana Dharma commands the patronage of the powers that has resulted in the continuing oppression of Dalits, backward

classes and minorities in rural areas in North India and in Kerala, Vijayan continued that Sree Narayana Guru consistently fought against it and therefore, he did not belong to the Sanatana fold of spirituality. Now, who was Sree Narayana Guru and what is the significance of the Sivagiri Madhom that the Guru founded? For reasons ranging from Sree Naravana Guru's spiritual dimensions to his involvement in eradicating untouchability, Vijayan's attempt

to ridicule the notion of the social reformer's Sanatana line did not sit well with his political opponents, especially the Sree Narayana Guru, deeply disturbed by the casteism and untouchability in Kerala, began his revolutionary reform movement. A section of the marginalized society was prohibited from entering temples where the entry was only for the upper communities. Agitations to abolish temple discrimination later led to the Temple Entry Proclamation in 1936. It opened temples to all Hindus irrespective of their castes. Being a member of the oppressed Ezhava community. Naravana Guru's agitation took a different line. He consecrated a Siva idol by the Aruvippuram River. The reform movement he started was to abolish caste discrimination and the temple he consecrated was for all castes. As he faced resentment from the Brahmins and the upper castes, he announced that the idol he sanctified was of the Ezhava Siva. The philosophy he propounded "One Caste, One Religion, One God for mankind" became the slogan of the mass. It got easily popularized and the Sree

Narayana Dharma Paripalana

Yogam (SNDP) which was es-

tablished by his blessings had the sole purpose of uniting the backward communities. Calling it Sree Narayana Dharma, the saintly reformer wanted to clarify to his cohorts that the idea of propagation was not different from Sanatana Dharma, though he fought against certain practices of the creed.

The Ezhava community is classified as an Other Backward Caste comprising an estimated 24% of the state's population. Ezhavas are known to be the traditional vote bank of the Communist Parties and the event that Vijavan chose to put his controversial view was the inaugural function of the 92nd Sivagiri pilgrimage at Varkala on December 31, 2024. Vijayan sought to criticize Sanatana Dharma equating it with Varnashrama Dharma which according to him is regarded as the foundation of the modern day caste system. Narayana Guru remained a principal opponent of the malpractice of the caste system and it led a huge population of the marginalized communities to suffer mostly at the hands of the upper castes. Vijayan purposefully refused to highlight the Guru's stance on Sanatana Dharma. Guru remained an ardent follower of the Advaita philosophy and its proponent. Against the casteist oppression he chose spiritual renaissance.

Why did Vijayan have to stir up this new controversy while he knew the opposition, especially the BJP would jump into frame him as anti-Sanatan? Though electorally weak, the BJP has considerably intruded into the space of dominance of the Left parties especially among the Ezhavas. Previously, the Sivagiri pilgrimage was attended by Prime Minister Narendra Modi and Home Minister Amit Shah. The Madhom invites political leaders and spiritual personalities from across the spectrum and allows them to feel the spiritual realms of the Guru. A probable political shift that the Left parties sensed among the Ezhavas to the BJP gave it a threatening realization that the saffron party's gain in the last Lok Sabha election witnessed a significant share of votes drifting from the community. Being a

spiritual institution established by the Guru, Sivagiri Madhom is known for its equidistant political stance from all parties. Vellapally Natesan, the President of the SNDP Yogam remains a fishy character as he keeps changing his political line. His son Tushar Vellappalli's party Bharat Dharma Jana Sena (BDJS), though electorally insignificant, is a member of the NDA faction in Kerala. Eventually, the Sivagiri speech by the Chief Minister was later justified as an attempt to question the Brahminical element in Sanatana Dharma.

Sanatana Dharma is seen to

be an all encompassing philos-

ophy which substantiates life

giving and eternally sustainable practices that the world recognizes as the oldest. Sanatana Dharma and Hinduism are seen to be the same, but there are differing views that consider Hinduism as its ritualistic branch. Guru's social revival was to consolidate the marginalized population of Kerala that, in those days, remained scattered in Travancore, Cochin and Malabar, Swami Vivekananda, while touring the region, likened the dark days of untouchability in Kerala to a lunatic asylum. There had also been community leadership emerging from different castes. All wanted to refine and rebuild the power of its population. Ayyankali was one among those reformers who emerged from the extremely backward communiwhile Mannathu Padmanabhan worked for the Nairs, known to be an upper caste. The parties opposing Sanatana Dharma have been grievously hiding their double standard. The INDI Alliance headed by the Congress has been demanding a caste census in order to arrive at the stakeholding of each caste. And Naravana Guru remained a principal opponent of caste identification and marginalization. He wanted castes to be abolished. The question is, were Vijavan's assertions mere political stunts aiming to gain electoral goals or did he really mean to stand by the principles of Narayana Guru? (The author and freelance

# What Are the Structural Reasons Behind the Rupee's Fall?

The crash of the Indian rupee against the US dollar, an all-time low of 86.71, has surprised many. This is because until recently, the Reserve Bank of India (RBI) was hailed for dextrously managing financial stability, and maintaining a resilient financial system and robust macro-economic balance

But now, the sentiment is turning less sanguine. The rupee has depreciated over 3.2% since September 2024 and more is in the offing. And it entwines with the Indian stock markets (NSE) losing Rs 60 trillion or 12.6% market cap since the end of September 2024. The conviction on Indian markets being insular to the vagaries of global impulses has waned.

What's in store is rooted to both structural and cyclical factors chained to global and domestic impulses. The RBI tried to suppress it with an overtly interventionist currency intervention. But, as it unwinds in the face of renewed dollar rebound, the pace of depreciation could be higher than historical averages.

Our multi-dimensional framework, including models for the US dollar index and INR-USD indicate that the dollar can depreciate to 90-92 levels in the next six to 12 months; the bias is towards a higher and quicker depreciation.

From long-term perspective, the performance of the INR/USD is pro-cyclical, appreciating during cyclical up-turn (for example, 18% during 2002-2009) and depreciating during downturns. Indexed to 2008, the INR-USD has depreciated (90%) more than other currencies (38% dollar emerging markets index, and 21% AE dollar indices) because of the narrowing growth differential versus global.

A mercantilist approach Trends since 1993 show structural depreciation during the downcycle rising to 7% YoY (year over year) with one standard deviation ordaining a range of 13% and 1%. However, since October 2022, the trend depreciation has mellowed to 4% and an annualised average depreciation of 0.5%, contributed by the suppression of volatility resulting from aggressive interventions by the RBI following the

Ukraine-Russia war. Our currency inflexibility measure



shows that while at 0.38, the Chinese Yuan is increasingly getting flexible, INR close to ~1 is mimicking a peg [0 represents a fully flexible currency and 1 represents currency peg].

This mercantilist approach is contrary to RBI's de-jure position that the rupee is a managed float, with interventions utilised only for the purpose of managing large volatility. Since October 2024, RBI's foreign currency assets (FCA) declined by US \$ 47 billion, leading to a drain of Rs 4 trillion of domestic liquidity drain. This in turn led to a deficit liquidity situation notwithstanding the 50-basis point cash reserve ratio cuts and collateralised lending against government securities by RBL

But this position is becoming untenable as the rapid strengthening of dollar is accentuating the misalignment. An aggressive rundown of forex reserves may reduce RBI's ability to control markets, leading to speculative currency attacks.

'Growth' story On the domestic front, the discord between the perceived growth and actual situation is converging with the successive downscaling of growth projections by RBI and the Central Statistical Office from 7.2% to the latest 6.4%. The shift in narrative has manifested from the vocal concerns from Indian corporates over the shrinking middle class, and the inability to associate with the

official claims of robust growth.

post-pandemic rebound in urban demand and leveraged consumption camouflaged persistent household fragility. Receding productivity at the broader level is demonstrated in rising ruralisation, increased dependence of workers on agriculture, contracting real income per worker, declining value addition in the unorganised sector and eroding household savings. These glaring symptoms were overlooked in the official and consensus assessments. Thus, any downside surprises can expose the rupee to greater vulnerability.

The 10% resurge in the US dollar index since September 2024 aligns with the US economy emerging stronger than expected, forcing the US Fed to scale back two out the guided four rate cuts in 2025. With Trump 2.0, the impact of his expansionary impact of corporate tax cuts and tariff hikes could be elevated inflation and the US Feds remaining hawkish.

What has bolstered the US dollar valuation matrix is the widening growth divergences with eurozone that continues to face persistent economic challenges.

Further, China has been running down its dollar reserves while also adopting greater currency flexibility to counter slowdown and the prospective impact of Trump 2.0 mercantilism. This will have a bearing on the dollar emerging markets (EM) index. And the added sliver is the surging geo-political risks inducing increased global policy uncertainty.

An investment plan As these global and domestic impulses

India, including portfolio flows, FDI and external commercial borrowings, can see increased volatility. A modest 8.3% YoY return from the benchmark India equity indices, Nifty, and Sensex, is significantly lower than 26% from US S&P 500. And with a 3% INR/USD depreciation, the underperformance is starker. Pervasive demand weakness and margin pressure forebode further moderation even for the coming years. Consensus Nifty earningsper-share growth for FY25-FY27 is placed at 11% compound annual growth rate. These compared weaker than the projected earnings for US S&P 500. A relatively lower price/earnings to growth ratio for the US markets may continue to impact foreign institutional investor flows.

How RBI and the government respond to the impending rupee weakening will demonstrate the expanse of policy options. To us it appears limited as the landscape, including monetary policy, fiscal headroom, peak credit-deposit ratio of banks, rising retail defaults and languid private capex, is muddled with multiple constraints. The RBI's currency inflexibility may have been motivated by the desire to sustain a facade of macro-financial robustness, but it has constricted growth.

Thus, it will be imperative for the RBI to let go of currency inflexibility, and allow greater depreciation, thereby limiting liquidity tightness and ease the pressure on the economy. The attempts to limit the imbalances in the banking system, to contain reckless retail lending, can be hastened. As the real policy rate differential of India versus the US Fed rate is negative, the RBI's window to ease policy rate is narrow. This is specially so as the US Fed has rolled back two out of four cuts guided earlier for 2025; in fact, there are chances that the US rate cut cycle can just halt. In any case, given the structural underpinnings, monetary easing by the RBI will largely be futile from the growth standpoint.

# How Sri Lanka can untangle its geo-political knot

ri Lanka finds itself at the heart of a geopolitical tug-of-war between China and India, with far-reaching implications across the Indo-Pacific region. President Anura Kumara Dissanayake's visit to New Delhi in December underscored the delicate balance the island nation must maintain.

In a public assurance to Prime Minister Narendra Modi, Dissanayake unequivocally stated that Sri Lanka would not allow its territory to be used in any way detrimental to India's security. Yet, this commitment is under strain as Colombo wrestles with the pressures of economic dependence on China, particularly in light of the controversy surrounding Chinese research vessels docking at Sri Lankan ports.

These vessels, often classified as dual-use platforms with civilian and military functions, have raised significant security concerns in India and among Western powers. In the recent past, the docking of the Yuan Wang 5 and Shi Yan 6 vessels sparked apprehensions due to their advanced surveillance capabilities, which India perceives could be used to monitor its defence in-

India's apprehensions are not unfounded. Such ships reportedly possess advanced tracking capabilities for missiles and satellites and could significantly compromise India's strategic assets in the Indian Ocean.

Security analysts have noted that such vessels are often used to gather intelligence on naval activities and defence installations. To address growing Indian apprehensions, Sri Lanka implemented a year-long moratorium on foreign research vessels docking at its ports in 2024, a move partly influenced by India's insistence during earlier high-level meetings.

Sri Lanka's economic crisis has deepened its reliance on Chinese investments, with Beijing accounting for over 20% of its external debt in 2022. China's financial leverage is evident in its significant infrastructure investments, such as Sinopec's \$4.5 billion Hambantota refinery project. While providing muchneeded financial inflows, these investments have also restricted Colombo's ability to outright deny docking requests from Chi-

China's broader strategic goals

China's strategic interest in Sri Lanka extends beyond research vessels. Its "Look South" policy aligns with its broader ambitions in the Indo-Pacific, seeking to secure influence in key maritime zones. With its prime location along these routes, Sri Lanka is an essential asset in this strategy.

To advance these objectives, Beijing has invested heavily in Sri Lanka's infrastructure and energy sectors. These investments cement China's role as a dominant creditor and provide a platform for future strategic and economic activities in the region.

Moreover, China's potential leverage over Sri Lanka's International Monetary Fund negotiations emerged as a critical obstacle, forcing Colombo into a vulnerable position. This dynamic became glaringly apparent during the controversy surrounding the docking of the Yuan Wang 5 vessel.

Analysts noted that China's refusal to restructure Sri Lanka's debt significantly delayed the approval of the IMF bailout package. Given that the IMF requires creditor nations to agree on debt sustainability measures before disbursing funds, China's hesitancy to support restructuring was pivotal in prolonging Sri Lanka's economic crisis. Beijing's tactics reinforced accusations of "debt-trap diplomacy," as its inflexibility kept Sri Lanka tied to its financial dependence on China.

Regional dynamics and India's role

The broader geopolitical ramifications are significant, with Sri Lanka caught in the complex interplay of influence between India, China and the US. India's proactive engagement has included financial assistance and infrastructure investments, such as the US-supported West Container Terminal project in Colombo, designed to enhance regional economic integration and bolster Sri Lanka's growth. This partnership underscores India and the US's intent to counterbalance China's extensive economic and strategic footprint on the island.

As Sri Lanka navigates the tumultuous waters of international diplomacy, it stands at a crossroads where its decisions today will shape its sovereignty and stability for years to come. Dissanayake's administration faces a daunting task: finding a path forward that mitigates economic dependence on China while safeguarding its strategic autonomy in a region teeming with geopolitical rivalries.

The natural starting point for Sri Lanka lies in deepening its relationship with India. Colombo's northern neighbour has proven to be a steadfast ally during the island nation's most challenging moments, offering critical financial aid and technical

By fostering stronger bilateral ties, Sri Lanka could unlock new opportunities for collaboration. Joint maritime research, for instance, could serve as a diplomatic counterweight to China's presence in Sri Lankan waters, reassuring New Delhi of Colombo's commitment to regional security.

Multilateral engagement However, Sri Lanka's path forward cannot solely rest on India's shoulders. It must embrace the difficult but necessary task of diversifying its economic partnerships. China has dominated Sri Lanka's infrastructure development for years, leaving

the country heavily indebted and diplomatically vulnerable. Colombo should actively court investments from other regional powers, such as South Korea and the ASEAN countries, to break free of this dependency. Diversifying its sources of investment would reduce the outsized influence any single player may wield over its policies.

At the same time, Sri Lanka recognises the urgent need for clarity and consistency in its maritime policies. The government's plan to establish an SOP for foreign vessels is a step in the right direction.

Such a framework may bring much-needed transparency to decision-making, ensuring that all nations - friends or otherwise - are subject to the same rules. This approach would signal to the international community that Sri Lanka is committed to fairness and sovereignty while also addressing security concerns raised by its closest neighbours.

Sri Lanka can enhance its diplomacy by engaging actively with multilateral forums like the Quad and other Indo-Pacific initiatives. These platforms offer Colombo the opportunity to establish itself as a stabilising force in the region.

Positioned strategically along key maritime routes, Sri Lanka is well-placed to promote maritime security and boost regional trade. Such collaboration allows the nation to balance the competing influences of India and China, steering clear of perceptions of aligning too closely with either power.

The debt challenge

However, the most pressing issue for Sri Lanka is restructuring its overwhelming debt. With China as one of its largest creditors, Colombo faces the delicate task of negotiating debt relief while maintaining Beijing's goodwill. This will require deft diplomacy and a willingness to engage multilaterally, leveraging institutions like the IMF and World Bank to ensure that debt restructuring serves the broader goal of economic recovery rather than merely servicing existing obligations.

Sri Lanka stands at a critical juncture, navigating the complexities of economic dependency and strategic vulnerabilities. Dissanayake's assurances to India reflect a commitment to regional stability, but actions must follow words.

By adopting a balanced approach that prioritises transparency, economic diversification and multilateral engagement. Colombo can navigate its dilemmas without succumbing to the pressures of great-power rivalry. However, the road ahead will demand astute diplomacy and resolute policymaking to secure Sri Lanka's sovereignty and long-term stability. (Courtesy: Scroll.in)

# India and Russia at a crossroads

n Russia, 2024 was perceived as one of the most eventful years in the modern history of bilateral relations. Against considerable odds, the Indian prime minister, Narendra Modi, made a double visit to Russia. His first visit was in July as a part of the agreements within the 2000 Declaration on Strategic Partnership, followed by a second one in October to participate in the 16th BRICS summit in Kazan. While repeated visits are not rare—former Prime Minister Manmohan Singh visited Russia twice in 2009 and 2013, and Narendra Modi in 2015—this time, however, this gesture holds significance. It indicates India's commitment to secure traditional political ties and is thus considered to have more value than ever before.

From this perspective, India's message to the international community is reminiscent of 2009, when Indian leadership participated in the BRICS meeting and the Shanghai Cooperation Organisation (SCO) summit in Ekaterinburg, Russia, for the first time, shortly after the Indo-United States (US) civil nuclear agreement was signed in 2008. By reaffirming its commitment this year, India also placed the onus on Russian leadership, with 2025 slated to be the year of a reciprocal visit from Russia's President, Vladimir Putin. Although the scope of future proposals is still unknown, the early announcements about Putin's upcoming visit, in stark contrast to the

unexpected trip of Narendra Modi, may indicate that the Russian side is preparing well in advance for the

Global aspirations as a backbone of bilateral ties

In 2024, bilateral relations were shaped by India's global posturing on the international stage. In other words, the country's growing aspirations placed the global agenda above certain regional and bilateral issues. In July, during his first visit to Russia, Prime Minister Modi highlighted that India is pursuing important peacekeeping efforts aimed at resolving the Ukrainian conflict. This visit to Russia was also Modi's first after his re-election, breaking the tradition of prioritizing countries in India's immediate neighbourhood. The reasoning behind this decision seems to be quite obvious—relations with the Maldives had been tense, Bangladesh was grappling with an acute social and political crisis, and Sri Lanka

was entering a new electoral cycle. Additional reasoning comes from India's participation in multilateral meetings. The invitation to visit Italy for the G7 Summit in June was perceived as being of top importance, especially since it provided ground to amplify the voice of the Global South, as well as to hold talks with the Ukrainian president. In some regards, it was placed at a higher priority than participating in summits of important regional formats, for example, the SCO Summit in Astana and the second India-Central Asia

2024. Participation at the BRICS summit in Kazan in October is another great example. The decision to take part in the meeting of a nonbinding organisation with global ambitions counters some observations about the limited benefits that India could get from the format. Despite some disagreements among its members and abstention from India on the issues of de-dollarisation and the extension of memberships, BRICS is still considered the only

**Economic relations: Nuanced** but paramount

In the absence of political commitments tied to financial negotiations, 2024 also gave bilateral economic relations new value, but the prospects for growth are still un-

During the 25th session of the India-Russia Inter-Governmental Commission for Trade, Economic. Scientific and Cultural Cooperation (IRIGEC-TEC), the volume of bilateral trade was said to have reached US\$66 billion, indicating positive growth. Russia has reached the

fourth position among India's trade partners and is the second-largest exporter to India after China. However, challenges become ev-

ident when we examine these numbers more closely. Although in January-August 2024, trade broke records, the volume of Russian exports has approached its local maximum. During this period, it constituted US \$43.4 billion (mainly energy resource exports)—a modest increase of 5 percent compared to the previous period. As a result, the next stage of trade and economic cooperation will hinge on Russia's ability to diversify its export basket and expand India's export base. In the mid-term, Russia's key objective is to curb its inflation rate, eliminate the socio-economic disbalances caused by an overheated military-industrial complex, and ultimately facilitate a seamless transition from military to civilian production. For India, it will be necessary to resolve infrastructure and socio-economic problems to maintain its attractiveness to foreign investors and increase production and overall gross

domestic product (GDP) growth. Chronic disbalances remained a key problem in bilateral trade-India's imports from Russia were 12 times greater than its exports to the country between January and Au-

The two countries acknowledged the importance of promoting export in India through increased investments in export-oriented production. This measure is also highly nec-

sues. For instance, Russia's exporters could theoretically use ruble transactions to secure payments with Indian importers and conduct foreign currency transactions with Indian counterparts. However, in practice, such a system is limited by the huge negative trade balance. Nonetheless, 2024 showed some progress in that regard-from January to August, the combined exports of India to Russia constituted US\$4.2 billion, marking a 35 percent increase compared to 2023. Considering the current pace of incremental growth, the target of US\$100 billion trade turnover by 2030 that the countries have set seems to be more indicative than prescriptive.

Conclusion

This year demonstrated that, despite prevailing prejudices, India's commitment to its traditional ties with Russia remains resilient and not prone to sudden shifts. However, it also brought to light the challenges that need to be addressed in the coming years. Many of these, particularly in the military and political spheres, are speculative. In areas like trade and investment, despite record performances, both countries will require structural reforms. To further strengthen their ties, they must address these challenges swiftly and effectively in 2025. # India's Gorkha Brigade: A legacy at crossroads

he press and media are flooded with stories about Nepal Domiciled Gorkha soldiers and their imperiled future in the Indian Army under the Agnipath scheme. With the last NDG in India's Gorkha Brigade likely to retire around 2045-50, it is possible two Gorkha soldiers could confront each other in Doklam, or elsewhere along the LAC should NDGs start joining the PLA. Traditionally, they have joined the British Army since the early 19th century, later the Singapore Police and Brunei Army and still later, the French Foreign Legion and the Russian Army (around 15,000 according to Al Jazeera news). Soldiering is in their blood with the first choice always and every time, the British Army has pampered as well as exploited them. On 10 November 2024, Kathmandu Post carried a front-page picture of impeccably

smart Gorkhas at an attestation parade in the UK. Three brothers in a Nepali family could still be in British, Indian and Nepalese armies in that order of preference. But Britain does not recruit Indian Domiciled Gorkhas. NDGs ceased joining the Indian Army for 5 years rendering hopelessly bleak the future of the Gorkha Brigade and a strategic glue that binds India and Nepal.Last year, in November and December, Indian and Nepalese Army Chiefs who became honorary Generals in each other's army spent a week in the other's country and were made much of. Last week, 1/11 Gorkha Rifles commanded by Col JP Singh went for joint training with the Sri Sri Jung battalion of the Nepal Army at Saljhandi near the border town of Butawal. (With PLA Nepal Army does only platoon-level joint training restricted to Kath-

No weapons are carried by either contingent as the host country provides them. No two sovereign armies and their Chiefs have such unique rapport. Despite the shared history, geography and historic links between the two countries and their armies, recruitment of NDGs has been frozen since India took the unilateral decision in June 2022 to change the terms of engagement that Kathmandu says violated Treaty arrangements. Curiously both countries have remained silent at the political and military levels. India's seniormost officer, Chief of Defence Staff, Gen Anil Chauhan from 11 Gorkha Rifles has been approached by several Gorkha veterans to try to break the stalemate but he is loath to approach PM/RM/NSA saying that the government 'has taken a political decision'

It is his responsibility to raise the decision-making process to the next level as other Army Chiefs in the past have done in the national interest. During the economic blockade in 2015, Gen Dalbir Singh was able to persuade PM Narendra Modi and FM Sushma Swaraj that prolonging the blockade would adversely affect the livelihood of Indian Army Gorkha ex-servicemen and families of serving soldiers in Nepal which in turn would impact bilateral relations. The blockade was ended but bilateral ties were seriously disturbed. After King Gyanendra conducted the Palace coup in 2004, India decided to stop the supply of lethal armaments to the Nepal Army which was fighting the Maoists.

Then Army Chief, Gen JJ Singh, recommended against it. In a slanging match between MoD and EAM, Prime Minister Manmohan Singh upheld the embargo. On the other hand, Siachen, Army Chiefs had prevailed in convincing Singh not to budge over any withdrawal from or concessions on Siachen.

In 1986, during the Gorkhaland movement in North Bengal, as a senior Gorkha officer who had been deployed there, I was invited to a meeting by Principal Secretary to PM, Sarla Grewal along with Deputy Chief of Army Staff, Lt Gen Rawat for discussion on the violence

In the higher direction of war in 1971, PM Indira Gandhi consulted Field Marshal Sam Manekshaw at every stage for planning and conduct of battle. In 1975, then Army Chief, Gen Gopal Bewoor, 11 Gorkha Rifles convinced Gandhi of the negative impact of stopping the recruitment of NDGs. So this is not the first time that the absurd idea of ending NDG recruitment has come up. But this time government decided on NDGs that CDS accepted..Lt Gen Sanjeev Chauhan is the senior officer and President Gorkha Brigade which meets annually in February in a unique assembly of seven Gorkha regiments to discuss professional matters. On recruitment of NDGs, they too are stuck at the Army Chief/CDS level.

Two years ago, I wrote a letter on strategic loss accruing from altered rules of NDG recruitment to the Principal Secretary to the PM, PK Mishra. No acknowledgement nor reply was received. Service Chiefs in the past have been willing and able to advise political authority on military matters. The consultative process has stopped with this government.

On December 15, 2024, while inaugurating India's World magazine, Foreign Minister Jaishankar conspicuously omitted to mention national security or the military component of international relations as part of India's foreign policy vision. Answering a question last year on why no NDG recruitment he said foreign policy is determined by India's national interest and not that of any other country, implying Nepal. India's national interests in terms of defence and security are entwined with those of Nepal with whom New Delhi claims a special relationship which Kathmandu mildly reaffirms. It was Modi who said in Nepal's Parliament in 2014 that India has fought no war where Nepalese blood was not shed. India-Nepal relations are written in blood. (Courtesy: The Pioneer)

Israel has come under heavy international criticism, including from its closest ally, the United States, over the civilian toll in Gaza. It also blames Hamas for the civilian casualties, accusing it of using schools, hospitals and residential areas for military purposes.

Hamas, a militant group that does not accept Israel's existence, has come under overwhelming pressure from Israeli military operations, including the invasion of Gaza's largest cities and towns and the takeover of the border between Gaza and Egypt. Its top leaders, including Yahya Sinwar, who was believed to have helped mastermind the Oct. 7, 2023, attack, have been killed. (AP)

# 'With Gaza deal, IMEC Corridor can become reality'



WASHINGTON, Jan 16: With the ceasefire deal between Israel and Hamas in the Gaza Strip, the pathbreaking IMEC Corridor that stretches from India to Europe through the Middle East could now become a reality, US President Joe Biden has said.

The India-Middle East-Europe Corridor (IMEC) is seen as an alternative to China's One Belt, One Road

Signed by eight countries - India, US, Saudi Arabia, UAE, European Union, France, Germany and Italy – in New Delhi on September 9, 2023, it aims to bolster transportation and communication links between Europe and Asia through rail and shipping net-

"At the G20 in Delhi on September 23, I rallied key countries behind a vision of an economic corridor from India across the Middle East to Europe. That vision can now become a reality," Biden told reporters on Wednesday at the White House as he announced the agreement between Israel and Hamas on Gaza and

The IMEC Corridor project hit a roadblock with the Hamas attack on Israel in October 2023.

According to a recent Hudson Institute think-tank report, the IMEC provides another example of how New Delhi is using multilateral initiatives to pursue its expanding strategic and economic interests.

The IMEC initiative helps position India as a key player in reshaping global supply chains and trade

"By offering an alternative to China's Belt and Road Initiative, this project underscores New Delhi's proactive approach to regional economic integration and infrastructure development," the report said.

"India's involvement in the negotiations between Israel and the United Arab Emirates that ultimately resulted in the Abraham Accords marks another significant diplomatic shift toward greater flexibility and engagement," said the report. (PTI)

## Death toll rises to 87 as standoff between police, miners ends in South Africa

STILFONTEIN, Jan 16: The death toll in a months long standoff between police and miners trapped while working illegally underground at an abandoned gold mine in South Africa has risen to at least 87, police said Thursday as they wound down a rescue operation that has pulled more than 240 survivors out from deep un-

National police spokesperson Athlenda Mathe said that 78 bodies were retrieved from the mine in an official rescue operation that began Monday, while another nine had been recovered previously.

She did not give details on how those other bodies were retrieved. Community groups have said they launched their own rescue attempts when authorities said last year they would not help the miners because they were "criminals."

The miners are suspected to have died of starvation and dehydration. Authorities now believe that nearly 2.000 miners were underground working illegally at the Buffelsfontein Gold Mine southwest of Johannesburg since August last year. Many of them resurfaced on their own over the last few months, police said, and all the survivors have been arrested.

Police announced Wednesday that they were ending the rescue operation and believed no one else was underground.  $\bar{A}$  camera would be sent down on Thursday to make certain, Mathe said. The mine is one of the deepest in South Africa and the miners were working up to 2.5 kilometres underground.

# UK's Starmer arrives in Ukraine Lawyers for detained S Korean Prez say for security talks with Zelenskyy he will reject questioning by investigators

SEOUL, Jan 16: Lawyers representing South Korea's impeached detained by anti-corruption officials over his ill-fated declaration of martial law last month, maintaining that the investigation is illegal.

President Yoon Suk Yeol exercised his right to remain silent as he underwent more than 10 hours of questioning on Wednesday at the headquarters of the Corruption Investigation Office for High-Ranking Officials, following a massive law enforcement operation to detain him at his official residence in Seoul.

Investigators are expected to move to place him under arrest in the coming days.

The anti-corruption agency, which is leading a joint investigation with the police and the military over whether Yoon's martial law declaralion, has 48 hours either to request a court order for his formal arrest or to release him.

Yoon's lawyers have argued that the detention warrant issued by the Seoul Western District Court is invalid and have asked the Seoul Central District Court to consider his release. The clock for the arrest warrant is on hold while the court reviews his petition, which can take

Yoon didn't attend a hearing at the Central District Court on Thursday, which was part of the review, due to security concerns, according to Seok Dong-hyeon, one of the president's lawyers.

It was expected that the decision could come sometime during the evening. Hundreds of Yoon's supporters gathered in the streets near the court amid a heavy police presslogans calling for his release.

Yoon set off the country's most serious political crisis since its de-

#### mocratization in the late 1980s when he attempted to break through gridlock in legislation by declaring martial law and deploying troops around the National Assembly on Dec 3. The standoff lasted only hours before lawmakers managed to get through the blockade and voted to lift the measure.

His presidential powers were suspended when the opposition-dominated assembly voted to impeach him on Dec 14, accusing him of rebellion. His fate now rests with the Constitutional Court, which has begun deliberating on whether to formally remove Yoon from office or reject the charges and reinstate

Yoon and his allies have defied efforts to investigate his role in the chaos of Dec 3. He ignored requests to appear for questioning for weeks, remaining in his official residence to avoid detention as his lawyers turned away police, citing a law that protects locations potentially linked to military secrets from search without the consent of the person in charge — Yoon himself. They also said that the anti-corruption agency had no legal authority to investigate rebellion allegations.

Yoon also resisted one attempt to detain him as the presidential security service barricaded the residence. He was finally brought into custody after hundreds of anti-corruption investigators and police raided the presidential compound for some five hours in a second attempt.

In a video message recorded shortly before he was escorted to the headquarters of the anti-corruption agency, Yoon lamented that the "rule of law has completely collapsed in this country." He echoed the arguments of his lawyers that the anti-corruption agency does not have the authority to investigate his actions, but said he accepted detention to prevent violence. (AP)

## 'American accused of sexually assaulting Pennsylvania student being extradited to US'

PARIS, Jan 16: French Appeal Court prosecutors said an American man accused of sexually assaulting a Pennsylvania college student in 2013, and later sending her a Facebook message that read "So I raped you", was being extradited Thursday to the United

The Appeal Court prosecutors' office in Metz in northeastern France said Ian Cleary was handed over to US authorities at the Paris Charles de Gaulle Air-

Cleary (31) from Saratoga, California, was detained in April last year in Metz after a three-year search. He was held in custody pending extradition proceedings since his arrest.

In July last year, the Appeal Court in Metz ruled that he could

be extradited. Cleary had been the subject of an international search since authorities in Pennsylvania issued a 2021 felony warrant in the case, weeks after an Associated Press story detailed the reluctance of local prosecutors to pursue cam-

The arrest warrant accuses Cleary of stalking an 18-year-old Gettysburg College student at a party in 2013, sneaking into her dorm, and sexually assaulting her while she texted friends for help. He was a 20-year-old Gettysburg student at the time, but didn't

return to campus. The accuser, Shannon Keeler, had a rape exam done the same day. She gathered witnesses and evidence and spent years urging

officials to file charges. She went to the authorities again in 2021 after discovering Facebook messages that seemed to come from Cleary's account.

"So I raped you," the sender wrote in a string of messages. "I'll never do it to anyone ever

"I need to hear your voice." "I'll pray for you." According to the June 2021

warrant, police verified that the Facebook account used to send the messages belonged to Cleary. The AP doesn't typically identify sexual assault victims without their permission, which Keeler has granted. (AP)

Blue Origin envisions six to eight New Glenn flights this year, if everything goes well, with the next one coming up this spring.

"There's room for lots of winners" Bezos said from the rocket factory over the weekend, adding that this was the "very, very beginning of this new phase of the space age, where we're all going to work

the cost of access to space."

New Glenn is the latest in a series of big, new rockets to launch in recent years, including United Launch Alliance's Vulcan, Europe's upgraded Ariane 6 and NASA's Space Launch System or SLS, the space agency's successor to the Saturn V for sending astronauts to the moon.

The biggest rocket of all, at approximately 400 feet, is SpaceX's Starship. Elon Musk said the seventh test flight of the full rocket could occur later Thursday from Texas. He hopes to repeat what he pulled off in October, catching the returning booster at the launch pad with giant mechanical arms.

Starship is what NASA plans to use to land astronauts on the moon later this decade. The first two moon landings under the space agency's Artemis programme. which follows the Apollo missions of the 1960s and 1970s, will see crews descending from lunar orbit to the surface in Starships. (AP)

"We started a two-day pre-budget consultation with different departments on Thursday. We are also taking suggestions from experts. Earlier, a portal was launched in which we have received around 800 suggestions so far," Kishore said.

The minister said that they held meetings with agriculture, forest, urban development and some other departments and they gave valuable suggestions.

"Issues were also discussed regarding storing of surface water and groundwater recharge. We could use only 20 per cent of the surface water. Kishore further said that he would write to the Centre seeking Jhakhand's pending grants-in-aid. Grants-in-aid from the Centre for Jharkhand was estimated at around ₹ 16,000 crore this fiscal. Yuvraj, one of the finest left-handers to have played the game, lauded Rohit for resting himself from the Sydney Test due to a lean run. Gambhir's role has also come under the scanner following the Australia debacle but Yuvraj de-

# Willow that saved the follow-on: When Kohli asked Akash Deep 'Tumko bat chahiye?'

NEW DELHI, Jan 16: "Who wouldn't want it, Bhaiyya?" It was all that a shy Akash Deep could blurt out when Virat Kohli asked if he would like to own one of his bats that ultimately scripted a rare happy memory in an otherwise devastating

tour of Australia for Team India. The newest pace bowling workhorse in the Indian dressing room bowled nearly 88 overs (87.5 overs) for his five wickets across the two Tests that he played in the fivematch rubber.

But it was his follow-on and eventually match-saving 31 at the Gabba that garnered attention. India, however, lost the series 1-3 to surrender the Border-Gavaskar Trophy. 'Yes, that was Virat bhaiya's bat, the one with MRF logo, everyone
