India, US seal pact to enhance cooperation in cybercrime investigations

NEW DELHI, Jan 18: Days before it hands over power to President-elect Donald Trump, the Biden administration signed a pact with New Delhi that provides for boosting cooperation in combating cybercrime and related challenges such as terror financing and violent

The agreement on cybercrime investigations, signed in Washington on Friday, allows the agencies concerned of the two countries to step up the level of cooperation with respect to cyber threat intelligence and digital forensics, according to an Indian readout. It is the second such move in the

last few days by the outgoing Biden administration that reflected the overall upward trajectory of relations between the two nations. The US on Wednesday removed restrictions on three Indian nuclear entities -- Bhabha Atomic Research Centre (BARC), Indira Gandhi Atomic Research Centre (IGCAR) and the

Indian Rare Earths (IRE). The lifting of the restrictions is US such as terrorism and violent

The families of the five miners who remained trapped inside the mine were given cheques of ₹ 6 lakh, with the remaining amount to be handed to them later, an official statement said.

The coal mine in Kalamati area of Umrangso in Dima Hasao district was flooded on January six when water had gushed in suddenly, trapping nine workers inside. Four bodies have been recovered since then in the rescue operations. The

RG Kar verdict

Kolkata court pronounces accused Sanjay Roy guilty of rape-murder of on-duty medic

KOLKATA, Jan 18: A Kolkata court on Saturday found Sanjay Roy guilty of raping and murdering an on-duty doctor at the state-run RG Kar Medical College and Hospital, a heinous crime that ignited nationwide outrage and led to prolonged protests.

The Sealdah court, where Roy's trial was held, will announce his sentence on Monday, Additional District and Sessions Judge Anirban Das

said. The verdict was delivered nearly two months after the in-camera trial began in November 2024, and 162 days after the brutal crime on August 9, 2024.

Roy, arrested a day after the crime, was found guilty under Sections 64 (rape), 66 (punishment for causing death), and 103(1) (murder) of the Bharatiya Nyaya Sanhita (BNS).

Section 103(1) carries a possible punishment of death or life imprisonment. The judge stated that Roy was found guilty of sexually assaulting the doctor and strangling her to death, and that the CBI had proven all the charges

Das noted that Roy had entered the hospital around 4 am and attacked the

on-duty doctor while she was asleep in the seminar room of the hospital.

"You sexually assaulted the doctor. You throttled her and covered her face and she ultimately died owing to the attack," he said.

"On the basis of these allegations, charges were framed against you under Sections 64, 66 and 103(1) of Bharatiya Nyaya Sanhita (BNS). On

the basis of the statements of the witnesses and the documents produced in this matter, your guilt has been

proved and you are being pronounced guilty," the judge said. Das said Roy's statement will be heard at 12:30 pm on

Monday, and the sentence will be pronounced thereafter. At the time of the delivery of

the verdict, Roy claimed in court that he was framed. In his defense, Roy said, "I wear rudrakash necklace, and if I had committed the crime, it would have snapped." Following the verdict, Roy was escorted under strict police security to the Presidency Correctional Home, preventing waiting media persons from speaking to him. (CONTD. ON PAGE-2)

HAFLONG, Jan 18: A 10-year-old class 3 student lost her life, and several others were injured after a school bus overturned in the Dima Hasao district on Saturday, an official

The incident occurred between 8:00 and 8:30 AM near the 19 KM area under Umrangso Police Station in Dima Hasao

In an official statement, Debojit Borah, field officer of the District Disaster Management Authority (DDMA), said that the student, identified as Dalimar Ronghangpi, died on the spot due to the impact.

"Six students sustained severe injuries and were immediately transported to Hojai Ham Hospital for urgent medical attention. The injured students are Arklingson Hanse, 9 years old; Felyha Chingthongpi, 10 years old; Sarmukrang Terang, 8 years old; Divya Ronghangpi, 15 years old; Ruplin Engtipi, 17 years old and Malyn Teronpi, 18

years old," Borah added. He further stated that 16 students suffered minor injuries. Some received medical attention, while others were treated on-site. A thorough investigation is underway to determine the cause of the accident, and authorities are taking all necessary measures to prevent such incidents in the future.

Census indicates increase of avian guests at Pobitora

MORIGAON, Jan 18: A waterbird census was conducted at Assam's Pobitora Wildlife Sanctuary on Saturday, with initial estimates indicating an increase in the number of avian visitors, an official said.

Pranjal Baruah, the regional forest officer of the sanctuary, said the survey was carried

out by the forest department in collaboration with NGOs, experts and local people. "The sanctuary was divided into 10 zones and a total of 12 teams completed the bird count. Compared to the last count of around 8,000 birds from 56 species in 2023-2024, this year's count has identified around 10,000 birds," Baruah said. He also said rural land digitisation is "furthering rural empowerment by leveraging the power of technology and good governance".

"India was also impacted by this challenge. People in villages have property worth lakhs of crores (of rupees), but they do not have papers for it. There were disputes, properties were snatched, and even banks did not provide loans over it," he said.

The Prime Minister emphasised that no sensitive government could leave its villagers in such distress. "Previous governments should have taken steps to do something about it but nothing much was done," he said. Modi said Dalits, backward classes and tribals were the worst affected by this.

Elaborating on the SVAMITVA Yoiana, he said it involved mapping houses and lands in villages using drones and providing legal documents for residential properties to villagers. He added that the benefits of this scheme are now visible. "India has over six lakh villages, with drone surveys completed in nearly half of them," Modi said. He highlighted that after receiving legal documents, lakhs of people had taken loans from banks based on their properties and started small businesses in

their villages. "After getting legal property rights, lakhs of people have taken loans. They have used this money to start their businesses. Many of these are farmers, for whom this property card is a guarantee to financial security," he said.

Modi said that once property cards are issued in all villages, the scheme will unlock economic activities worth over Rs 100 lakh crore. He emphasized the substantial capital that will be added to the country's economy.

Noting that earlier, land disputes were common for farmers and obtaining land documents is challenging, often requiring multiple visits to offices and leading to corruption, the Prime Minister said that land records are being digitised to deal with these issues.

Highlighting that SVAMITVA and Bhu-Aadhaar are foundational systems for village development, he said that Bhu-Aadhaar provides a unique identity to land, with around 23 crore Bhu-Aadhaar numbers issued, making it easy to identify land plots.

"Over the past seven-eight years, approximately 98 per cent of land records have been digitised, and most land maps are now digitally available," Modi added. Later, in a post on X, the Prime Minister said rural land digitisation is "furthering rural empowerment by leveraging the power of technology and good governance". (PTI)

Only where UAN is not linked with Aadhaar, any correction would have to be submitted physically to the employer and after verification forwarded to EPFO for approval, he explained.

UAN registration is done by the employer for the employee at the time of joining. For many employees, mistakes were committed by employers in recording the father/spouse's name, marital status, nationality, and service details during the registration process or later.

In order to correct these errors, the employee had to make a request online with supporting doc-

The request would have to be verified by the employer and then forwarded to EPFO for approval before any change could be effected. This process was called the Joint Declaration.

Out of the 8 lakh requests that were forwarded to EPFO by employers in FY 24-25, it was seen that only 40 per cent were sent within 5 days, 47 per cent were sent after 10 days and the average time taken by the employer was 28 days.

The simplification would provide relief to employees in 45 per cent of cases through immediate correction through Aadhaar OTP verification and in the balance 50 per cent of cases through the employer itself.

If any member who can selfapprove has already filed his request which is pending with the employer, the member can delete the already filed request and selfapprove as per the simplified process. This will benefit nearly 3.9 lakh cases pending with employers as of date.

About the simplification of the process of claims for transfer of EPF account, the minister said EPF members with fully compliant e-KYC EPF accounts can file their Online Transfer Claims with Aadhaar OTP directly with EPFO without any need for intervention of employer.

If a number of claims filed (1.3 Crore) during FY 2024-25 is considered more than 94 per cent of claims (1.2 crore) will instantly reach EPFO.

The turnaround time of EPF transfer claim processing will be considerably reduced since it does not require approval by the employer.

If any member has already filed his transfer claim which is pending with the employer, the member can delete the already filed request and submit a claim

directly with EPFO. The simplification will also greatly reduce the member grievances considerably (presently 17% of the total grievances pertain to transfer-related issues) along with the corresponding rejections.

Large employers who have a large workload of approving such cases will have significant improvement in the ease of doing business.

EPFO are also being simplified for transfer claim processing within this month which will further smoothen this process.

At present, any online request for transfer of PF account in case of any change of job has to be verified by the employer before submitting to EPFO.

In this process, on average, 12 to 13 days are taken by employers before the claim reaches EPFO for verifying transfers.

During the last nine months, almost 20 lakh claims remained pending with employers for more than 15 days.

The minister also said that many initiatives are being taken to improve the delivery of services by the EPFO aiming to bring those at par with the banking sys-

NITI Aayog's Virmani revises FY'25 GDP growth projection

'Political uncertainties created by US elections much higher than anticipated

KOLKATA, Jan 18: NITI Aayog member and renowned economist Arvind Virmani on Saturday said he has revised his GDP growth projection for India on the lower side for FY'25 due to rising global uncertainties and risks, particularly from the United States

Virmani, who had earlier predicted GDP growth in the range of 6.5-7.5 per cent, adjusted the projection to 6.5-7 per cent now with a high probability of it being sub-7 per cent, amidst heightened risk aversion stemming from global political and economic challenges. "My focus from the beginning of the year was 7 per cent plus-minus 0.5 per cent, which means 6.5-'.5 per cent. But now I am revising it to 6.5-7 per cent. The political uncertainties created by the US elections are much higher than I had anticipated," Virmani said.

"The US election uncertainty has a domino effect, influencing Europe, China, and other regions, indirectly impacting India," he said on the sidelines of an interactive session with MCCI.

He highlighted the significant slowdown in China's economy, noting its "irrational" capacity-building approach despite reduced capacity utilisation. "China's overcapacity, coupled with its slowing economy, has exacerbated global uncertainty and risk aversion, and may further affect India's growth trajectory," he

Despite these challenges, Virmani remained opti-



mistic about India's long-term prospects.

"If India sustains 6 per cent growth for the next 25 years, it is well-placed to become an upper-middle-income or even a high-income country, coming close to China," he said.

Addressing the uneven distribution of investments across various states, Virmani said the NITI Aayog is working on benchmarks and indices to help states improve their investment climate, including Foreign Direct Investment (FDI) inflows. "Currently, only a few states attract the majority of investments. The Modi government recognises the crucial role of states and aims to provide actionable insights for others to catch up," he said. International institutions estimate the GDP growth of India at 6.4-6.5 per cent. (PTI)

Kolkata court pronounces accused

The parents of the deceased doctor expressed gratitude to the court for delivering justice, with her father stating, "The trust we had placed in you, you have honoured it completely." The mother of the medic, while acknowledging the verdict, voiced concerns that justice had not been fully served. "That Sanjay is guilty was proven by medical evidence. He stood silent during the trials, proving his role in torturing and killing my daughter. But, he was not alone. Others who are yet to be arrested should also be brought to book," she told PTI.

She added, "We will continue our fight for justice till our last breath." In its chargesheet, the CBI identified Roy, a civic volunteer with the city police, as the prime suspect in the brutal crime. Roy's elder sister, speaking from her home in Bhawanipore, said that the family would not challenge the court's decision.

"If he has committed any crime, he should get proper punishment. We don't plan to challenge the order," she said, adding that family members did not attend the trial. The junior doctors, who were at the forefront of the protests following the crime, have called for further investigation into the larger conspiracy allegations raised by the victim's parents. "There are a lot of unanswered questions. Allegations that the crime scene was tampered with and that influential people were involved must be fully investigated. This is just partial justice. The fight isn't over," said a junior medic.

The verdict also evoked mixed political reactions. Senior BJP leader Suvendu Adhikari welcomed the judgement, but called for further investigation into the conspiracy allegations by the victim's family. "We would have been happier if former RG Kar hospital principal Sandip Ghosh and former Kolkata police commissioner Vineet Goyal were also punished today. We must investigate whether anyone else was involved in the crime,"

Senior Trinamool Congress (TMC) MP Sougata Roy also welcomed the ruling, calling for the "harshest punishment" for Roy to set a strong precedent. The ghastly incident sparked nationwide protests, particularly from junior doctors in Kolkata, who demanded justice for the victim and stronger security measures in state-run hos-

Initially investigated by Kolkata Police, Roy was arrested on August 10, a day after the medic's body was found in the seminar room of the hospital. The Calcutta High Court later transferred the case to the CBI, which had sought death penalty for Roy.

The in-camera trial, which began on November 12, saw 50 witnesses testify. The trial concluded on January 9. Civil society groups in Kolkata and other cities held demonstrations and midnight rallies under the 'Reclaim the Night' campaign, calling for justice for the victim, who was affectionately christened 'Abhaya' and 'Tilottama' by some people. The crime also became a political flashpoint, with opposition parties, including the BJP and CPI(M) criticising the Mamata Banerjee-led government over the state's law and order situation. (PTI)

India and Russia at a crossroads

n Russia, 2024 was perceived as one of the most eventful years in the modern history of bilateral relations. Against considerable odds, the Indian prime minister, Narendra Modi, made a double visit to Russia. His first visit was in July as a part of the agreements within the 2000 Declaration on Strategic Partnership, followed by a second one in October to participate in the 16th BRICS summit in Kazan. While repeated visits are not rare—former Prime Minister Manmohan Singh visited Russia twice in 2009 and 2013, and Narendra Modi in 2015—this time, however, this gesture holds significance. It indicates India's commitment to secure traditional political ties and is thus considered to have more value than ever before.

From this perspective, India's message to the international community is reminiscent of 2009, when Indian leadership participated in the BRICS meeting and the Shanghai Cooperation Organisation (SCO) summit in Ekaterinburg, Russia, for the first time, shortly after the Indo-United States (US) civil nuclear agreement was signed in 2008. By reaffirming its commitment this year, India also placed the onus on Russian leadership, with 2025 slated to be the year of a reciprocal visit from Russia's President, Vladimir Putin. Although the scope of future proposals is still unknown, the early announcements about Putin's upcoming visit, in stark contrast to the unexpected trip of Narendra Modi, may indicate that the Russian side is preparing well in advance for the meeting

Global aspirations as a backbone of bilateral ties

In 2024, bilateral relations were shaped by India's global posturing on the international stage. In other words, the country's growing aspirations placed the global agenda above certain regional and bilateral issues. In July, during his first visit to Russia, Prime Minister Modi highlighted that India is pursuing important peacekeeping efforts aimed at resolving the Ukrainian conflict. This visit to Russia was also Modi's first after his re-election, breaking the tradition of prioritizing countries in India's immediate neighbourhood. The reasoning behind this decision seems to be quite obvious relations with the Maldives had been tense, Bangladesh was grappling with an acute social and political crisis, and Sri Lanka was entering a new elec-

Additional reasoning comes from India's participation in multilateral meetings. The invitation to visit Italy for the G7 Summit in June was perceived as being of top importance, especially since it provided ground to amplify the voice of the Global South, as well as to hold talks with the Ukrainian president. In some regards, it was placed at a higher priority than participating in summits of important regional formats, for example, the SCO Summit in Astana and the second India-Central Asia Summit, which was scheduled in 2024. Participation at the BRICS summit in Kazan in October is another great example. The decision to take part in the meeting of a non-binding organisation with global ambitions counters some observations about the limited benefits that India could get from the format. Despite some disagreements among its members and abstention from India on the issues of de-dollarisation and the extension of memberships, BRICS is still considered the only group actively pushing for a balanced approach, thanks to its focus on promoting global multipolarity.

In bilateral and multilateral relations with Russia, India has effectively highlighted the visibility of fruitful cooperation, yet it has been cautious about making any political commitments. For Russia, this policy may be deemed sufficient today, but shortly, it will require more tangible outcomes. **Economic relations: Nuanced but paramount**

In the absence of political commitments tied to financial negotiations 2024 also gave bilateral economic relations new value, but the prospects for growth are still unknown.

During the 25th session of the India-Russia Inter-Governmental Commission for Trade, Economic, Scientific and Cultural Cooperation (IRIGEC-TEC), the volume of bilateral trade was said to have reached US\$66 billion, indicating positive growth. Russia has reached the fourth position among India's trade partners and is the second-largest exporter to India after China.

However, challenges become evident when we examine these numbers more closely. Although in January-August 2024, trade broke records, the volume of Russian exports has approached its local maximum. During this period, it constituted US \$43.4 billion (mainly energy resource exports) a modest increase of 5 percent compared to the previous period. As a result the next stage of trade and economic cooperation will hinge on Russia's ability to diversify its export basket and expand India's export base. In the mid-term, Russia's key objective is to curb its inflation rate, eliminate the socio-economic disbalances caused by an overheated military-industrial complex, and ultimately facilitate a seamless transition from military to civilian production. For India, it will be necessary to resolve infrastructure and socio-economic problems to maintain its attractiveness to foreign investors and increase production and overall gross domestic product (GDP)

Chronic disbalances remained a key problem in bilateral trade—India's imports from Russia were 12 times greater than its exports to the country between January and August.

The two countries acknowledged the importance of promoting export in India through increased investments in export-oriented production.

This measure is also highly necessary to solve payment-related issues For instance, Russia's exporters could theoretically use ruble transactions to secure payments with Indian importers and conduct foreign currency transactions with Indian counterparts. However, in practice, such a system is limited by the huge negative trade balance. Nonetheless, 2024 showed some progress in that regard—from January to August, the combined exports of India to Russia constituted US\$4.2 billion, marking a 35 percent increase compared to 2023. Considering the current pace of incremental growth, the target of US\$100 billion trade turnover by 2030 that the countries have set seems to be more indicative than prescriptive.

Conclusion

This year demonstrated that, despite prevailing prejudices, India's commitment to its traditional ties with Russia remains resilient and not prone to sudden shifts. However, it also brought to light the challenges that need to be addressed in the coming years. Many of these, particularly in the military and political spheres, are speculative. In areas like trade and investment, despite record performances, both countries will require structural reforms. To further strengthen their ties, they must address these challenges swiftly and effectively in 2025. However, success will hinge on shifts in Russia's approach to the West, as well as the stability of India's positioning.

Israel-Hamas ceasefire deal is a great news but the follow up depends on Netanyahu

Hamas have agreed to a ceasefire deal; Israel, Oatar and the United States have said, after more than 460 days of a war that has devastated Gaza. Apparently, Israeli Prime Minister Netanyahu, under intense American pressure had to convince a lot of his coalition partners to seal the deal. Additionally, this deal comes as a win for Donald Trump, even before he starts his next stint as the 47th American President.

The Israeli Prime Minister's office was the last to confirm on early Friday morning (17 January 2025) that a deal has been agreed upon with Hamas. The agreement, which US officials expect to take effect Sunday (19 January), would see a pause in fighting in Gaza and lead to the phased release of hostages and Palestinian prisoners.

Qatar's Prime Minister Sheikh Mohammed bin Abdulrahman bin Jassim Al Thani had said on Wednesday that the ceasefire deal would come into effect on Sunday, but added that work on implementation steps with Israel and Hamas was continuing. Apparently, the American President-elect Donald Trump wanted the deal to be effective before his inauguration ceremony on Monday.

Trump had repeatedly indicated he would prefer to avoid inheriting the Israel-Hamas war as he prepared to take office on 20 January, and analysts say his impending return to the White House had injected renewed urgency into negotiations on a deal.

Reportedly, Trump and outgoing US President Joe Biden both took full credit following the announcement of the ceasefire deal Wednesday after the two American administrations worked together to mediate the truce.

The cooperation between the two camps was "almost unprecedented," a senior Biden administration official said after the deal was clinched, made possible by a rare intersection of interests between bitter rivals who both saw an opening following Trump's election

The deal includes a temporary ceasefire that will also, finally, allow displaced Palestinians to return to their homes – though after Israel's deliberate destruction campaign, which increased in ferocity, 86 Palestinians were killed in Israeli attacks after the announcement of the deal, and which has rendered many homes no longer habitable. But the Palestinians of the occupied territories wanted to return to their homeland as soon as possible and they welcomed the announcement with cheers and tears.

Reportedly, the peace deal consists of three phases. The first phase will last six weeks, and will involve a limited prisoner exchange, the partial withdrawal of Israeli troops from Gaza and a surge of aid into the enclave.



Israeli forces will reduce their presence in the Philadelphi Corridor, the border area between Egypt and Gaza, and then withdraw completely no later than the 50th day after the deal comes into effect.

Details of the second and third phases, though understood to be agreed to in principle, are to be negotiated further during the first phase. US President Joe Biden has said that the ceasefire will continue even if the negotiations on the second and third phases go beyond the

initial six weeks of the **DEGREE OF THOUGHT** first phase. Critically, Israel has By: Asad Mirza insisted that no written

guarantees be given to rule out a resumption of its attacks once the first phase is complete and its civilian captives returned.

However, according to an Egyptian source cited by the Associated Press, the three mediators involved in the talks – Egypt, Qatar and the United States - have given Hamas verbal guarantees that negotiations will continue and that all three would press for a deal that would see the second and third stages implemented before an initial six-week window has elapsed.

If it is determined that the conditions have been met for a second phase, Hamas will release all the remaining living captives, mostly male soldiers, in return for the freeing of more Palestinians held in the Israeli prison system. In addition, Israel would initiate its "complete withdrawal" from Gaza.

However, these conditions, which have yet to be voted upon by the Israeli cabinet, are at odds with the stated positions of many of the far-right wing members of Israeli Prime Minister Benjamin Netanyahu's cabinet, which he relies upon for support, as well as Netanyahu's own past positions, in which he has repeatedly used the presence of Hamas in Gaza to prolong the

The details of a third phase remain unclear. Should the conditions of the second stage be met, the third phase will see the bodies of the remaining captives handed over in return for a three- to five-year reconstruction plan

to be conducted under international supervi-

Additionally, there is currently no agreement over who will administer Gaza beyond the ceasefire. The

United States has pressed for a reformed version of the Palestinian Authority to do so.

US Secretary of State Antony Blinken on Tuesday (14 January) said the post-war reconstruction and governance envisions the Palestinian Authority inviting "international partners" to stand up an interim governing authority to run critical services and oversee the

Other partners, notably Arab states, would provide forces to ensure security in the short term, he said in a speech at the Atlantic Council, a Washingtonbased think tank. Israel has vet to suggest an alternative form of governance in Gaza.

There was staunch opposition to the deal from the far-right members of Netanyahu's government, such as Itamar Ben-Gvir and Bezalel Smotrich. They have been quite outspoken over the last week about their position on a deal, saying that it is bad for Israel's national

security and that they might not vote for it. They have gone so far as to say that they are willing to topple Netanyahu's government if they do not get their way.

Further, a small number of families of the captives in Gaza are saying "No" to a deal. Many members of the Tikva (Hope) Forum fringe group, including settlers in the occupied West Bank, hold right-wing ideologies. They oppose the release of Palestinian prisoners in Israel as part of the deal, arguing that a partial release of Israeli hostages from Gaza is unacceptable. Instead, they insist that defeating Hamas through strong military action should be the top priority, and is the best strategy to retrieve hostages.

The moot question is if the ceasefire will survive beyond that first phase. It entails even more negotiations meant to begin within weeks. In those talks, Israel, Hamas, and the US, Egyptian and Qatari mediators will have to tackle the tough issue of how Gaza will be governed, with Israel demanding the elimination of Hamas.

Hostage release also is a tricky issue, as not all hostages are held by Hamas, so getting other militant groups to hand them over could be an issue. In exchange for bodies handed over by Hamas, Israel will free all women and children it has detained from Gaza since the war began on 7 October,

Furthermore, Israel has said it will not agree to a complete withdrawal until Hamas' military and political capabilities are eliminated and it cannot rearm - ensuring Hamas no longer runs Gaza. Hamas says it will not hand over the last hostages until Israel removes all troops from everywhere in Gaza.

Trump had made a big issue of Middle East peace during his campaign and attacked Biden's failure to secure a ceasefire. Steve Witkoff, his surprise appointment as Middle East envoy, was dispatched to Qatar on 22 November less than three weeks after his election

Witkoff, a close friend of Trump who is also known to Qatari officials through his real estate business, had suddenly become the chief negotiator in an unlikely negotiating team led by Biden's top Middle East adviser Brett McGurk. În directing their envoys to co-ordinate, Biden and Trump both temporarily put aside their fierce personal and political rivalry - a small miracle in its own right.

However, in reality a lot hinges on what Netanyahu is able to deliver, in face of challenges from his coalition partners, if he is indeed able to deliver and the ceasefire lasts, then that too will not be a lesser miracle, given the ever-changing geopolitical dynamics of the middle eastern region. Global economy to weaken in 2025, says 56 percent of Chief economists

he global economy is set to face significant challenges in 2025, with 56% of chief economists surveyed expecting conditions to weaken, according to the latest Chief Economists Outlook from the World Economic Forum. Only 17% foresee an improvement, pointing to heightened uncertainty in key regions and the need for measured policy responses worldwide.

While the United States appears poised for a short-term boost – with 44% of chief economists predicting strong growth in 2025, up from 15% when they were asked in August last year – the outlook for the year ahead remains less optimistic for other major economies. Europe continues to rank as the weakest region for the third consecutive year, with nearly three-quarters (74%) expecting weak or very weak growth. Meanwhile, China's economic momentum is projected to slow amid subdued consumer demand and weaker productivity, further illustrating the uneven and uncertain nature of any global recovery.

"The latest Chief Economists Outlook released by World Economic Forum on January 16 reveals a global economy under considerable strain," said Aengus Collins, Head of Economic Growth and Transformation, World Economic Forum. "The growth outlook is at its weakest in decades and political developments both domestically and internationally highlight how contested economic policy has become. In this environment, fostering a spirit of collaboration will require more commitment and creativity

The new report underscores the significance of the recent US presidential election, with 61% of chief economists characterizing the impact for the global economy as a longterm shift rather than a short-term disruption. Major changes are expected in areas such as trade, migration, deregulation, fiscal policy and industrial policy. The chief economists' solid outlook for US growth in 2025 is in line with their expectation of near-term stimulus and of rising wages. However, they remain mindful of risks, with almost all expecting a rise in public debt levels (97%) and higher

In addition to subdued global growth prospects, the Chief Economists Outlook reveals intensifying pressures on the world's economic interconnectedness. A vast majority of respondents (94%) predict further fragmentation of goods trade over the next three years, while 59% expect services trade to follow a similar path. More than three-quarters also foresee higher barriers to labour mobility, while almost two-

thirds point to rising constraints on technology and data

The financial sector stands out as an exception, with less than half (48%) expecting an increase in fragmentation, likely reflecting the pivotal role of cross-border financial flows in modern economies. Nevertheless, domestic and international political developments, supply-chain realignments and security concerns loom large. These shifts are likely to push up costs for businesses and consumers alike over the next three years. Business responses to the increasing fragmentation of the global economy are expected to include restructuring supply chains (91%), regionalizing operations (90%) and focusing on core markets (79%).

Nearly half (48%) of chief economists anticipate an increase in global trade volumes in 2025, underscoring the resilience of global commerce. However, a large majority expect intensifying trade tensions, both between major powers and more widely. Protectionism is identified as the primary factor that will drive lasting changes to global trade patterns, with other prominent contributors including conflict, sanctions and national security concerns. Some 82% of respondents predict greater regionalization of trade over the next three years, alongside a continuing gradual shift from goods to services. (IPA Service)

Excessive social media use has detrimental effects on teenagers

The Australian government passed a law prohibiting teenagers under 16 from having social media (SM) accounts; nevertheless, they are permitted to view SM in a 'logged out state'. SM firms will face fines if they fail to comply with the law. The ban is expected to take effect by the end of the

However, a global debate has erupted about whether a ban on SM is the best way to address the detrimental effects of excessive use in teenagers. Yet, the government has come under criticism for passing the law too soon without considering the results of the trial, which is likely to be held next year to decide how the SM ban will be implemented in Australia. It is being monitored to see if such measures could be taken elsewhere

Social media is a useful tool for learning and connection, but if not used responsibly, it can have major health consequences. Sleep interruption is a severe issue. Browsing mobile platforms before bedtime can lead to poor sleep quality and quantity, particularly in teenagers. This results in daytime drowsiness. Sleep deprivation complicates emotional control and raises stress. Another disadvantage of SM for teenagers is their poor attention span.

A recent study, "Accelerating Dynamics of Collective Attention," published in Nature, shows that human attention spans have drastically decreased, going from 2.5 minutes twenty years ago to 45 seconds today. Rapid attention shifting between digital stimuli impairs focus on schoolwork and other non-digital tasks. Overuse of social media disrupts children's social lives and prevents them from learning essential social skills. The face-to-face interactions, such as reading facial expressions and body language, are crucial for empathy and social cue comprehension. Academic performance suffers as a result of the time spent on social media since it interferes with study and homework time. Aggression is another aspect of the detrimental effects of social media on teens' social lives. These days, video games and social media expose teenagers to violent and provocative content. The World Health Organisation states against exposing newborns under a year old to any electronic devices, including laptops or mobile phones, and against allowing children ages one to five to spend more than an hour a day in front of a screen.

According to studies, youngsters who use social media for more than three hours a day are twice as likely to suffer from mental health conditions like depression and anxiety because they are exposed to pictures of things they lack in their lives. Body dysmorphia is prevalent among young individuals and has grown in recent years. Those in their early teens are frequently resistant to constraints and could rebel against them. They may believe they are entitled to the same technological resources as their peers elsewhere. This resistance may cause confrontations between parents and children, resulting in interpersonal tension and mistrust. Bans, therefore, are ineffective. For example, prohibiting alcohol can often lead to increasing use. As a result, tech-savvy children may find ways to evade it, such as setting up secret accounts, utilising fake identities and VPNs, or accessing dangerous areas of the internet, thus increasing their exposure to hazardous content rather than decreasing it. Social media frequently turns into a tool for validation since humans are social creatures with an innate need for acceptance and belonging. Many people use the quantity of likes on their posts or photos as an instrument to assess someone's appearance, intelligence, and even personal value.

According to experts, compulsive notification checking can cause addictionlike symptoms in which people struggle to detach, affecting their mental wellbeing. Online conversations are frequently superficial, missing the emotional depth and nonverbal communication that characterise face-to-face interactions. This leads to an emotional separation. Furthermore, people prefer to present only the positive elements of their lives on social media, resulting in a false depiction of happiness and success that can make others feel even more alienated in their troubles. The way a tool is used determines its potency. The systemic and contemporary issues around social media use regulation must be addressed. A social media ban doesn't help young people learn or manage anything; it just delays their exposure to these platforms. The same algorithms will still be in place when they eventually begin utilising these plat-

forms, influencing users' views and behaviours and keeping both young and old users interested. In theory, algorithms present only contents that a user could find interesting. The content is actually tailored to promote spending more time on the platform.

Digital literacy and education are a better way to help children learn selfdiscipline when using their devices and to explain the advantages and disadvantages of social media. Establish a family media use plan, ban screens for at least an hour before bed, establish limits on content access, promote family communication and conversations, and refrain from using social media in the mornings, as this wastes teens' productive time and deters them from starting the day with energy. Every week, have a conversation with your teen about social media so they feel comfortable sharing their experiences with you without fear of criticism. Set boundaries for your own social media use and encourage the children to follow your lead by asking them about their experiences on social media, how they perceive what they see there, and how they would react to different scenarios they might come across online.

Teenagers in India may find that social media detoxification—the practice of distancing oneself from social media apps and preventing them from interfering with daily life—is a necessary lifestyle habit. Bringing life back on track with creativity, productivity, and a healthy dose of enthusiasm for the future is the ultimate goal. The children have an unquenchable desire to follow the latest trends and are impacted by social media influencers for the majority of their decisions. A social media detox can begin with specific hours of the day and then progress to days and weeks.

Parents and educators can initiate discussions regarding the psychological effects of social media, such as cyberbullying, misinformation, and online comparison, to educate children about the risks involved. Schools can take the lead in this area by integrating media literacy and mental health awareness into the curriculum. Madan Kamdev: The Khajuraho of Assam

adan Kamdev, a magnificent yet lesser-known archaeological Lisite in Assam, is often referred to as "The Khajuraho of Assam." This comparison draws from the site's intricate and sensuous sculptures that bear a striking resemblance to the famed temples of Khajuraho in Madhya Pradesh. Nestled amidst the verdant hills of Dewangiri. roughly 40 kilometers from Guwahati, Madan Kamdev's rich history, spiritual significance, and artistic achievements create an enigmatic allure that remains largely underappreciated on the global stage. However, to view Madan Kamdev as a mere reflection of Khajuraho would be to overlook its distinct narrative, cultural identity, and importance within the broader context of India's heritage.

The origins of Madan Kamdev trace back to the 9th and 10th centuries during the rule of the Pala dynasty, a period marked by a flourishing of art, religion, and architecture across the eastern regions of India. The Palas, who were known for their patronage of both Hinduism and Buddhism, established a tradition of temple-building that celebrated intricate design and storytelling. It is believed that the temples at Madan Kamdev were constructed primarily as an homage to Lord Shiva, evident in the numerous lingams and depictions of Shiva found among the ruins. The name "Madan Kamdev" itself invokes the spirit of Kamadeva, the Hindu god of love, adding layers of myth and meaning to the temple complex. According to legend, Kamadeva attempted to awaken Lord Shiva from deep meditation to restore love and passion to the world. Shiva, angered by the disturbance, opened his third eye and reduced Kamadeva to ashes. Some traditions hold that Madan Kamdev represents the spirit and essence of Kamadeva, making the site a symbol of love, passion, and divine

The architecture and sculptures at Madan Kamdev capture the quintessence of human emotion and divine connection. The carvings at the site are distinguished by their explicit representation of sensuality and love, themes that align with the classical Indian understanding of kama as an essential aspect of life and spirituality. The intricately carved stone figures depict scenes of divine beings, humans, celestial dancers, and mythical creatures, many of which are portrayed in romantic or erotic poses. These depictions, far from being merely ornamental, reflect a worldview that regarded love and sexuality as sacred, intertwined with devotion and the path to spiritual enlightenment. Such representations align with the tantric traditions that were prevalent in parts of medieval India, where physical intimacy and love were viewed as a means to attain a higher spir-

The artistic brilliance seen in the sculptures of Madan Kamdev speaks volumes about the mastery of Pala-era artisans. These craftsmen achieved a high degree of sophistication in their work, showcasing lifelike figures with detailed expressions and dynamic postures. The fluidity and grace in these carvings suggest advanced knowledge of human anatomy and a deep understanding of movement and balance. One can almost imagine the artisans meticulously shaping each figure, infusing stone with vitality and emotion. The figures of apsaras, gods, and goddesses appear caught in the midst of dance and embrace, while intricate floral and geometric patterns frame the scenes. This level of detail is indicative of an era that valued both the aesthetic and the symbolic, merging artistic beauty with deeper cultural and spiritual meanings.

The ruins of Madan Kamdev, spread over a large area on Dewangiri Hill, invite exploration and reflection. Despite their current state of partial destruction, the surviving structures and fragments convey a powerful sense of what once was. Scholars and archaeologists have long debated the reasons for the site's decline. Some suggest that natural calamities, particularly earthquakes common in Assam—may have played a role. Others believe that political conflicts, invasions, and the subsequent shift in dynastic power could have led to the temple's abandonment and eventual ruin. 

No group immediately claimed responsibility for the fatal shootings of the judges -- clerics Mohammad Mogheiseh and Ali Razini.

However, Razini's involvement in the 1988 executions had likely made him a target in the past, including a failed assassination attempt in 1999.

Their killings also come as Iran faces economic turmoil, the mauling of its Mideast allies by Israel, and the return of Donald Trump to the White House on Monday.

Both clerics served on Iran's Supreme Court, the state-run IRNA news agency reported.

A bodyguard for one of the judges was also wounded. The gunman later killed himself, IRNA

"According to initial investigations, the person in question did not have a case in the Supreme Court, nor was he a client of the branches of the court," the judiciary's Mizan news agency said.

"Currently, investigations have been launched to identify and arrest the perpetrators of this terrorist act." In January 1999, attackers on motorcycles hurled an explosive at Razini's vehicle, wounding him as he left work as the head of the ju-

Qatar says Israel-Hamas ceasefire to go into effect at 8:30 am on Sunday CAIRO, Jan 18: The ceasefire between Hamas and Israel will on first phase, Israeli troops are to

between Hamas and Israel will go into effect in less than 24 hours. Qatar's foreign ministry said on Saturday.

In a post on X, foreign minister Majid al-Ansari said the ceasefire will start at 8:30 am (6:30 GMT) on Sunday, and advised people to exercise caution and wait for directions from officials.

Early Saturday morning, Israel's Cabinet approved the deal for a ceasefire in Gaza that would release dozens of hostages and pause the 15-month war with Hamas, bringing the sides a step closer to ending their deadliest and most destructive fighting ever. Despite the ceasefire news, sirens sounded across central Israel on Saturday, with the army saying it intercepted projectiles launched from Yemen.

The Iran-backed Houthis have stepped up their missile attacks in recent weeks. The group says the attacks are part of its campaign aimed at pressuring Israel and the West over the war in Gaza.

There were also continued Israeli strikes into Gaza. The Palestinian health ministry said at least 23 people were killed the previous

Under the first phase of the ceasefire, 33 hostages are set to be released over the next six weeks, in exchange for hundreds of Palestinians imprisoned by Israel.

The remainder, including male soldiers, are to be released in a second phase that will be negotiated during the first.

Hamas has said it will not release the remaining captives without a lasting ceasefire and a full Israeli withdrawal.

According to the ceasefire plan, approved by the Cabinet and signed by Israel's national security advisor, the exchange will begin Sunday at 4 pm (14:00 GMT).

During each exchange, prisoners will be released by Israel after the hostages have arrived safely.

The plan says that during phase one, some 1,900 Palestinian prisoners will be released, in exchange for 33 Israeli hostages, both alive and dead.

Among the prisoners, 1,167 are residents of Gaza who were held by Israel but were not involved in the October 7, 2023, attack by

All women and children under 19 from Gaza held by Israel will be freed during this phase.

All Palestinian prisoners who were convicted of deadly attacks

will be exiled, either to Gaza or abroad, and barred from returning to Israel or the West Bank.

Some will be exiled for three years and others permanently, according to the plan.

However, key questions remain about the ceasefire, -- the second achieved during the war -- including the names of the 33 hostages who are to be released and who among them is still alive.

Hamas has agreed to free three female hostages on Day 1 of the deal, four on Day 7, and the remaining 26 over the following five weeks.

Palestinian detainees are to be released as well.

Israel's justice ministry has published a list of more than 700 people who are to be freed in the deal's first phase, saying the release will not begin before 4 pm local time on Sunday.

All people on the list are younger or female. Also during the pull back into a buffer zone about a kilometre wide inside Gaza, along its borders with Israel.

The move will allow displaced Palestinians to return to their homes, including in Gaza City and northern Gaza.

With most of Gaza's population driven into massive, squalid tent camps, Palestinians are desperate to get back to their homes, even though many were destroyed or heavily damaged by Israel's cam-

The largely-devastated territory is expected to see a surge in humanitarian aid.

Trucks carrying aid lined up on the Egyptian side of the Rafah border crossing into Gaza on Fri-

On Saturday, two Egyptian government ministers arrived in the northern Sinai Peninsula to oversee the preparations for the delivery of aid and to receive the evacuation of wounded patients, the health ministry said.

Hamas triggered the war with its October 7, 2023, cross-border attack into Israel that killed some 1,200 people and left some 250 others captive.

Nearly 100 hostages remain in Gaza.

Israel responded with a devastating offensive that has killed more than 46,000 Palestinians, according to local health officials, who do not distinguish between civilians and militants but say women and children make up more than half the dead. (AP)

Impeached South Korean Prez

SEOUL, Jan 18: South Korea's impeached president on Saturday argued for his release before a Seoul judge as the court reviewed whether to grant a law enforce-

ment request for his formal arrest. Yoon, who has been in detention since he was apprehended on Wednesday in a massive law enforcement operation at his residence, faces potential rebellion charges linked to his declaration of martial law on December 3, which set off the country's most serious political crisis since its democratisation in the late 1980s.

The Corruption Investigation Office for High-Ranking Officials, which is leading a joint investigation with police and the military, requested the Seoul Western District Court to grant a warrant for Yoon's formal arrest.

Yoon's lawyers said he spoke for about 40 minutes to the judge during the nearly five-hour closeddoor hearing. His legal team and anti-corruption agencies presented opposing arguments about whether he should be held in custody. The lawyers did not share his specific comments.

The judge is expected to make a decision by late Saturday or early Sunday. Yoon's motorcade was seen leaving the court Saturday evening for the detention centre, where Yoon will await the deci-

If Yoon is arrested, investigators can extend his detention to 20 days, during which they will transfer the case to public prosecutors for indictment. If the court rejects the investigators' request, Yoon will be released and return to his

Yoon was transported to the court from a detention centre in Uiwang, near Seoul, in a blue Justice Ministry van escorted by police and the presidential security service. Some protesters temporarily broke through the police lines and tapped on the windows of his van as the motorcade slowed while approaching the court. Youn did not speak to reporters before heading to the hearing.

It hadn't been clear until Saturday morning whether Yoon would choose to attend the hearing.

Defence lawyers met Yoon at the detention centre and he accepted his legal team's advice to appear personally before the judge, said Yoon Kab-keun, one of the president's lawyers.

The lawyer said the president was to argue that his decree was a legitimate exercise of his powers and that accusations of rebellion would not hold up before a criminal court or the Constitutional Court, which is reviewing whether to formally remove him from office or reinstate him.

Nine people, including Yoon's defence minister, police chief, and several top military commanders, have already been arrested and indicted for their roles in the enforcement of martial law.

The crisis began when Yoon, in an attempt to break through legislative gridlock, imposed military rule and sent troops to the National Assembly and election offices.

The standoff lasted only hours after lawmakers who managed to get through a blockade voted to lift the measure. The opposition-dominated assembly voted to impeach him on December 14.

Climate misinformation is rife on social media - and poised to get worse

CHICAGO, Jan 18: The decision by Meta, the parent company of Facebook and Instagram, to end its fact-checking programme and otherwise reduce content moderation raises the question of what content on those social media platforms will look like going forward.

One worrisome possibility is that the change could open the floodgates to more climate misinformation on Meta's apps, including misleading or out-of-context claims during disasters. In 2020, Meta rolled out its Cli-

mate Science Information Centre on Facebook to respond to climate misinformation. Currently, thirdparty fact-checkers working with Meta flag false and misleading posts. Meta then decides whether to attach a warning label to them and reduce how much the company's algorithms promote them.

Meta's policies have fact-checkers prioritising "viral false information," hoaxes and "provably false claims that are timely, trending and consequential." Meta explicitly states that this excludes opinion content that does not include false claims.

The company will end its agreements with US-based third-party fact-checking organisations in



slated to roll out to US users won't affect fact-checking content viewed by users outside the US. The tech industry faces greater regulations on combating misinformation in other regions, such as the European Union.

Fact-checking curbs climate misinformation

I study climate change communication. Fact-checks can help correct political misinformation, including on climate change. People's beliefs, ideology and prior knowledge affect how well factchecks work. Finding messages that align with the target audience's values, along with using trusted messengers - like climatefriendly conservative groups when speaking to political conservatives - can help. So, too, does appealing to shared social norms, like limiting harm to future generations.

Heat waves, flooding and fire conditions are becoming more common and catastrophic as the world warms. Extreme weather events often lead to a spike in social media attention to climate change. Social media posting peaks during a crisis but drops off quickly.

Low-quality fake images created using generative artificial in-

slop, is adding to confusion online during crises. For example, in the aftermath of back-to-back hurricanes Helene and Milton last fall, fake AI-generated images of a young girl, shivering and holding a puppy in a boat, went viral on the social media platform X. The spread of rumours and misinformation hindered the Federal Emergency Management Agency's disaster response. What distinguishes misinforma-

tion from disinformation is the intent of the person or group doing the sharing. Misinformation is false or misleading content shared without active intention to mislead. On the other hand, disinformation is misleading or false information shared with the intent to deceive.

Disinformation campaigns are already happening. In the wake of the 2023 Hawaii wildfires, researchers at Recorded Future, Microsoft, NewsGuard and the University of Maryland independently documented an organised propaganda campaign by Chinese operatives targeting US social media users.

To be sure, the spread of misleading information and rumours on social media is not a new prob-

telligence software, so-called AI lem. However, not all content moderation approaches have the same effect, and platforms are changing how they address misinformation. For example, X replaced its rumour controls that had helped debunk false claims during fast-moving disasters with usergenerated labels, Community

In the case of climate change, misinformation is "sticky". It is especially hard to dislodge falsehoods from people's minds once they encounter them repeatedly. Kaling Moyong elected Arunachal BJP president

ITANAGAR, Jan 18: Former MLA Kaling Moyong was on Saturday unanimously elected as the new president of the BJP Arunachal Pradesh unit

Kejriwal says Delhi Police prevented documentary screening, officials cite MCC

NEW DELHI, Jan 18: AAP supremo Arvind Kejriwal on Saturday alleged the Delhi Police prevented the screening of a documentary exposing the "secrets" and "conspiracies" behind the arrest of his party leaders.

A senior Delhi police office said no permission was sought for the screening event despite the Model Code of Conduct being in force in Delhi in view of the assembly polls on February 5.

But Kejriwal questioned why was permission needed for a private screening event. He told a press conference here the documentary --Unbreakable -- was to be shown to the media at the private event, and it was not any political programme.

"No votes were going to be sought at the event neither anything was to be said against any party,' Kejriwal said.

The AAP convener shared a picture of the venue of the screening at the Pyarelal Bhawan at ITO, showing a heavy police presence. He charged the police did not allow the screening at the behest of the BJP.

"The BJP is completely scared of the documentary because it uncovers the secrets and conspiracies behind the arrest of AAP leaders in the past two years. It exposes the illegal and unconstitutional activities of the

BJP," he alleged. At a separate press conference later in the day, senior AAP leader Saurabh Bhardwai screened the trailer of the documentary to the

He said the Aam Aadmi Party will not deter from showing the documentary and will ensure it

reached the public. "The AAP is now determined to ensure this film reaches the public. Whether I invite you to my home and show it to you in a room on a mobile phone or send it to you via WhatsApp, I will make sure you watch this film. One way or another, this film will reach every-

Prominent AAP leaders including Kejriwal, Manish Sisodia, Sanjay Singh and Satyendar Jain were arrested by central agencies in corruption cases during 2023-24. (PTI)

Delhi polls: AIMIM, BSP step up campaign with street plays, wall paintings, cricket matches

Assembly elections approach, political activity had intensified with smaller parties like AIMIM, BSP and others in the city engaging voters through grassroots campaigns including street plays, wall paintings, and cricket matches with chil-

Delhi will go to polls on February 5, with the ruling AAP, BJP, and Congress dominating the political

However, parties with significant

influence in other states, such as Asaduddin Owaisi's All India Mailis-e-Ittehadul Muslimeen (AIMIM), Mayawati's Bahujan Samaj Party (BSP), and Munish Kumar Raizada's Bharatiya Liberal Party (BLP), are working to expand their presence in the national capi-

The AIMIM has launched an intensive door-to-door campaign, particularly in Okhla, where its candidate Shafa-ur-Rehman and his wife are leading outreach efforts, along with student activists from Jamia Milia Islamia and former Citizenship Amendment Act (CAA) and National Register of Citizens



(NRC) protester.

"Family members, the student wing from Jamia, activists from the CAA-NRC protests, and party leaders are conducting a robust door-todoor campaign. Shafa-ur-Rehman, our candidate from Okhla, and his wife, along with party members, are effectively leading the outreach," AIMIM Delhi party president Shoaib Jamai told PTI.

Nukkad Sabhas (street meetings) are also being held regularly and the party has prioritised social media as part of its strategy, he said. "We have a dedicated social media team highlighting past state-

ments and actions of AAP MLA Amantullah Khan while also showcasing videos of areas lacking development to present a real picture to the voters," Jamai said.

BLP chief and candidate from New Delhi constituency, who was once a friend of Kejriwal, Munish Kumar Raizada, has focused on a grassroots-level campaign. His team has been actively visiting JJ clusters, all 16 Dhobi Ghats, Muslim colonies, and Valmiki Sadan. conducting door-to-door outreach.

Additionally, the party is using wall paintings, distributing pamphlets, billboards, and stickers, and stagram handles to reach a wider

"We are not relying on AI-generated content, movies, or songs like other parties. Our creative slogans and campaign songs are connecting with the people," Raizada said, emphasizing on the authenticity of their campaign.

Among the slogans, "Samaya nahi, Samadhan chuniye; Delhi mein Khuda chuniye" is one that has resonated strongly with locals, calling for change and action in the face of a stagnant political climate.

When not engaging with voters, Raizada and his team play cricket with children in the JJ clusters, which has earned him the affectionate title of "Doctor Uncle."

"It's not just about politics, it's about being with the people, listening to their issues, and helping in any way I can," he said, noting that he has used his medical expertise to assist locals in need of health sup-

Raizada's team conducts 8-9 Nukkad Nataks (street plays) weekly, addressing key issues like corruption, unemployment, and de-

"I will always be among the people. I won't just appear during election time like other politicians,' Raizada said, highlighting his commitment to represent the community genuinely.

The BSP, which plans to contest all 70 seats in the Delhi Assembly elections, has adopted a traditional approach to connect with the vot-

The party is focusing on door-todoor campaigning, supported by senior party leaders and conducting Nukkad meetings, Central Coordinator of the BSP Nitin Singh told

Along with posters and pamphlets, the party is utilizing media to reach out to people.

Singh said, "We are not engaging in the social media game like other parties. Instead, we are taking the traditional approach, connecting with people on a personal level and promoting our campaign in a raw, rassroots manner.'

He also alleged that RSS chief Mohan Bhagwat's

'true independence' remark was "against the country's

Constitution" Addressing 'Samvidhan Suraksha Sammelan' at Bapu Sabhagar here, Gandhi said, "Dalits, minorities and socially marginalised people comprise 90 per cent population of this country but they are not part of the system....This is the reason that we have been

He also claimed, "I have categorically told leaders in Parliament, in front of Prime Minister Narendra Modi Ji, that our party will get this passed at any cost."

Gandhi said a caste census across the country is "important to find out how much participation OBCs, Dalits and workers have in the bureaucracy and other

"The aim of the caste census is not just to know about the count of various castes but their participation in the country's wealth as well...We don't want a caste survey like the Bihar government did. The exercise which the Bihar government had done was just to befool people," the Congress leader alleged.

He also claimed that the 50 per cent cap on reservations for people belonging to SCs, STs and OBCs is "not enough".

"We will increase the cap for the benefit of the majority of the people. A few select organisations, including RSS and its people, industrial houses are running the country," he claimed

The country's Constitution is "not just a book" but "talks about atrocities and difficulties faced by Dalits", he said. Speaking on RSS chief Mohan Bhagwat's 'true in-

dependence' remark, Gandhi alleged, "His remark about India's true independence after the Ram temple consecration is against the Constitution. The BJP and the RSS are undermining the Constitution and neglecting marginalised communities.

He also said the political fight is on between "those who want to save the Constitution and ones who are

Simultaneous poll is 'unconstitutional', being brought with political motive: TN Minister Ponmudy

CHENNAI, Jan 18: The Centre's initiative of 'one nation, one election' was 'unconstitutional' and was being brought with a political motive, DMK senior and Tamil Nadu Forests Minister K Ponmudy said on Saturday.

Speaking at the DMK legal wing's third state conference that began here, he said "the move is unconstitutional and is being brought with a political motive."

Terming the move to enforce simultaneous poll as an attempt to dispense with the five-year term of assemblies and downsizing the states to union territories, senior advocate Kapil Sibal said states will not be in the picture at all if one nation, one election law was enforced.

"It will destroy the very federal structure of our country. The preamble of the Constitution says that India is a union of states. You have diminished the states,.. you are destroying the basic structure of the state, and trying for one nation, one poll, one language, political party, one religion," Sibal said during a discussion on the topic.

"The move amounts to destroying the essence of democratic functioning of our republic. Cronies support the idea without a national debate on it. I don't think the people of India and Tamil Nadu will tolerate it." Sibal said and claimed that it would also affect the education, health and other state specific

Replying to a question from T K S Elangovan, former MP, he said if this became a law, then the fiveyear term of 17 states will be truncated. But five-year term was the basic feature of the Constitution, he

Former CEC S Y Quraishi pointed 'with great anxiety' that what happened in Kashmir could happen anywhere. "With one stroke, Kashmir became a union territory. Can they not do it to Tamil Nadu tomorrow?" he asked.

Senior journalist N Ram said the Centre's attempt should be seen in a wider context of 'Hindutva authoritarianism' and what the BJP government has done and was doing to institutions and to citizens'

"It is an assault on the diversity and pluralism of India and India's civilisation because we are multi-

cultural, multi-ethnic and multieverything. It is an assault on federalism. It is to impoverish the diversity and pluralism of India that this plan is being worked out," Ram said during the panel discussion on the 'one nation, one election' initiative of the Centre.

The simultaneous elections proposes aligning the election cycles of the Lok Sabha and State Assemblies. This would allow voters to cast their ballots for both tiers of government on the same day in their constituencies, though voting could still occur in phases across

the country, the Centre had said. By synchronising these electoral timelines, the approach aims to address logistical challenges, reduce costs, and minimise disruptions caused by frequent elections, it had

Earlier, Ponmudy said he had faced several cases in the past including those filed with political motive during the erstwhile AIADMK regime under late Chief Minister J Jayalalithaa. "They filed a case against me for visiting a civil supplies godown and on then opposition leader and now Chief Minister M K Stalin and myself for visiting the Queen Mary's College," Ponmudy said at the conference. But these cases were successfully won by meticulous presentation and sound arguments by the DMK advocates in the courts. "The DMK's legal wing, especially senior advocate N R Elango, who has been handling my cases, should be appreciated for the good work," he said.

Party General Secretary and Water Resources Minister Duraimurugan who inaugurated the conference at the St George's Anglo Indian School, said he studied law and began practise in his younger days but took to full-time

"Like me Ponmudy and S Regupathy (state Law Minister) are advocates but they seldom go to courts. But, Ponmudy goes to the court to appear in his cases," Duraimurugan said in a lighter vein.

Lack of jobs, unsettled borders are issues India has to fix for Viksit Bharat: Army vice chief

SURAT, Jan 18: Lack of adequate employment opportunities, unsettled borders, and its position in the human development index are some of the weaknesses India needs to address to realise the vision of Viksit Bharat 2047, Vice Chief of the Army Staff Lt General N S Raja Subramani has said.

Speaking on the topic of "National Security and Bharat @ 2047 at Surat LitFest 2025 on Friday, Lt Gen Subramani said the India of 2047 should have integrated its response mechanism, resolved its internal problems in Jammu and Kashmir and the Northeast, as well as left-wing extremism (LWE) to ensure social and communal har-

"Our strengths are our geographical location, youth, stable economic growth, and service sectors — Pharma and IT — which are progressing. What are our weaknesses? First, environmental change; second, our manufacturing sector is not strong; third, we do not have that many employment opportunities. Our border, whether with China or Pakistan, is not yet developed. We need to improve the human development index," he said.

Lt Gen Subramani said, "It is our responsibility to work on the internal conflicts in the society, reduce tensions, and move forward towards development. Only then will internal security also improve.

He said that by 2047, India's response mechanism should be integrated, and internal problems would have to be solved.

Issues related to J&K, Manipur, Nepal, and the LWE would have to be resolved so that there is social and communal harmony and India becomes developed by 2047, he

Lt Gen Subramani said economic security is also vital, and India can never progress if national and economic security are not in unison.

He said external and internal security cannot be achieved without



economic security, and environmental, technological, human and energy security are all linked.

The Vice Chief of Army Staff said the economy is being used as a weapon today. Also, the world is being divided into various blocks and countries are going against globalisation and forming regional blocks.

India is also influenced by competition between the US and China, conflicts the world over, and hybrid, economic and cyber warfare — the war of narrative through social media — are affecting everyone.

'When we form a strategy, superpowers such as the US and China and Russia are important for us," he said.

As far as external security is concerned, India shares a long, unsettled border with China, which has given rise to tension between the two countries, he said

"You must have heard about our discussions with China in October-November 2024, due to which the tension between us after the 2020 Galwan war has reduced a bit, and China has left the region. Currently, the situation is nearly normal but also sensitive," Lt Gen Subramani said.

He said China will try to increase its influence on India's strategic space — neighbours like Bangladesh and Myanmar.

As far as external security is concerned, India's border areas need to be fully developed by

"Our relations with Pakistan and China are good, J&K and Northeast are integrated, we maintain our dominance over the Indian Ocean region, and we manage our security using tech-oriented solutions," he said.

As far as internal security is concerned, Lt Gen Subramania said the situation in J&K has become normal after Article 370 and recent elections with more than 60

"Now, we have an elected government there. Even when we have sporadic terrorist incidents, the Army, CAPF, police and state administration have controlled the situation. As far as the Northeast is concerned, you know about the violence in Manipur. Right now, the situation is under control. And we hope that it will take time, but we will control the situation as soon as possible," he said.

The CRPF and internal security forces have controlled LWE well, and we have seen maximum development in the red corridor, he

said. Lt Gen Subramani said that in 2047. India should be the kind of country people from all over the world would want to live in, and the economy should be more than

\$30 trillion. "We should have internal peace in every way and should be a leader in the sphere of environmental, energy, human and technological security," he said. (PTI)

KOLKATA, Jan 18: Senior BJP leader Suvendu Adhikari on Saturday welcomed the court's verdict declaring Sanjay Roy "guilty" of raping and murdering an on-duty doctor at the state-run RG Kar hospital, but called for further investigation into the larger conspiracy allegations raised by the victim's parents.

The Sealdah court, where Roy's trial was held, will announce the sentence on Monday, Anirban Das, the additional district and sessions'

"We welcome the judgment. But we would have been happier if the former principal of R G Kar hospital, Sandip Ghosh, and former Kolkata police commissioner Vineet Goyal were also punished today. The allegations of a bigger conspiracy leveled by the parents and junior doctors must be looked into. It must be seen whether anyone else was also involved in the crime or not," Adhikari told re-

Roy was found guilty under Sections 64 of the Bharatiya Nyaya Sanhita related to rape, and Sections 66 and 103(1) of the Act, dealing with punishments for death and murder. Section 103(1) provides for a possible punishment of death or life imprisonment.

The verdict came nearly two months after the in-camera trial began in November 2024 and 162 days after the brutal crime was committed on August 9, 2024.

The judge said Roy was convicted for sexually assaulting the doctor and strangling her to death, with the CBI successfully proving all the charges against him. Roy, who maintained his innocence throughout the trial, claimed he was framed. His statement will be recorded at 12:30 pm on Monday, followed by the sentencing. (PTI)

MAHAKUMBH NAGAR (UP), Jan 18: The International Society Krishna Consciousness (ISKCON), in partnership with the Adani Group, is providing meals to nearly one lakh people daily at the ongoing Maha Kumbh, a spiritual

organisation's official said. At a camp on Harshvardhan Marg here, ISKCON's one kitchen prepares food for 30,000 - 35,000 people in one session, and more than one lakh people are served food in three sessions a day, its Director (CSR) Madhukant Das told

ISKCON's food -- which includes dal, chole or rajma, vegetables and roti and rice, and halwa or boondi laddu in sweets-- is completely balanced. These meals are prepared on a clay stove over a fire of wood and cow dung cakes, which makes them taste amazing,

Das said meals are being distributed at 40 centres across Prayagraj, including bus stands, railway stations and several holding areas, where the crowd of devotees are halted on the main bathing days.

He also informed that the food is also being distributed to 15,000 employees engaged in cleaning at the fair and surrounding areas. ISKCON has set up three kitchens across Prayagraj, which are located at Khusrobagh near the Prayagraj junction, Netra Kumbh in Sector 6 and ISKCON temple premises in Sector 19 and food prasad is being prepared and distributed from here.

ISKCON comes to every Kumbh, so cow dung cakes are being made six months before the commencement of the fair. Das also said that 100 vehicles have been deployed for the distribution of food, which have been provided by the

"Over six months, the team traced Jha's network of family, friends, and associates. They conducted reconnaissance at his previous crime spots and interrogated individuals in fruit and vegetable mandis across Delhi-NCR, Haryana, Uttar Pradesh and Bihar, where Jha had once worked," said

the Additional CP. Analysing voluminous call data records, the team identified a suspicious mobile number that ultimately led them to Jha's location.

Acting on a lead, the team arrested Jha on January 17 as he attempted to flee to Bihar from Old Delĥi Railway Station, he said.

Police said that a history of gruesome crimes between 2006 and 2007, Jha's modus operandi left Delhi shaken.

Originally from Bihar, Jha resided near Azadpur Mandi in Delhi and befriended young men, often migrants, by helping them find jobs and offering them meals.

However, minor disagreements or perceived infractions would trigger his homicidal rage.

"Jha would tie his victims hands, claiming he would punish them, and then strangle them with a locally made nunchaku. He would dismember the bodies meticulously, ensuring minimal blood splatter. The remains were then packed in plastic bags and transported using his modified cycle-rickshaw before being dumped at pre-determined locations, often near Tihar Jail," Sain

He said that adding to the horror, Jha would leave handwritten notes of Delhi". (PTI)

with the dismembered bodies, taunting the police and challenging them to catch him.

Jha's first recorded murder dates back to 1998 when he killed Mangal alias Aurangzeb in Adarsh Nagar, Delhi, dismembering the body and scattering its parts.

Arrested in 1998, he was released in 2002. After his release, he resumed killing, police said.

In June 2003, Jha murdered his associate Shekhar in Haiderpur for being a drunkard and liar, disposing of the body in Alipur.

In November 2003, Umesh, a migrant from Bihar, was killed for alleged betrayal, and his body was dumped near Tihar Jail.In November 2005, Jha killed Guddu for his habits, including smoking marijuana and disposed of his body in Mangolpuri, police said.

In October 2006, Amit, accused of womanizing, met a similar fate, with his body left outside Tihar

In another case Upender was murdered in April 2007 for a love affair deemed inappropriate, his remains left near Tihar's Gate No 3.

In May 2007, Dilip, who ate non-vegetarian food, was killed and dumped near Tihar's Gate No.

Jha was convicted of three murders, earning two death sentences These were commuted to life

imprisonment without remission in

In October 2023, Jha was granted parole for 90 days but failed to surrender, choosing instead to go underground.

"His evasion prompted the Delhi Police to issue a reward for his capture. Despite his efforts to remain hidden, including staying in various parts of Bihar and Delhi and maintaining minimal contact with known associates, Jha was apprehended as he attempted to flee Delhi," said the officer.

Jha, who studied up to the eighth grade, migrated to Delhi in 1990 and worked in various low-income jobs. He was married twice and fathered five daughters.

Jha's seemingly kind demeanour masked a savage killer, who viewed minor infractions by his victims as justification for extreme punishment, police added. His case received a significant

"The probe into the ongoing construction of 52.40 kilometre Nelsnar-Kodoli-Mirtur-Gangaloor road in Bijapur district found serious irregularities in execution of the work. Due to alleged connivance of officials, there is prima facie evidence regarding wastage of government money, embezzlement, submission of faulty evaluation report and corruption in nexus with the contractor / construction agency," Deputy Chief Minister Arun Sao, who also holds the PWD portfolio, said in a statement.

Bharatiya Nyaya Sanhita (BNS) and Prevention of Corruption Act against then Executive Engineer (now retired) BL Dhruv, Sub-Divisional Officer RK Sinha, Sub Engineer GS Kodopi and other concerned officials for allegedly committing irregularities in the road construction work in a Naxal-affected area, Sao said. "The department has placed Sinha and

Kodopi under suspension with immediate effect. It has issued show cause notice to Dhruy seeking his reply within 15 days," the deputy CM said in the statement.

"The orders were issued on Friday. The probe team inspected Nelasnar-Kodoli-Mirtur-Gangaloor road work on January 8-9 and pointed towards various deficiencies, including potholes, peeled off surface layer at many places and inadequate thickness. Christian council urges heritage panel to apprise missionary schools before conferring heritage tag

Bengal Christian Council has urged the West Bengal government to inform the authorities of Christian Missionary educational institutions before giving heritage tag to any of their buildings in future.

The council in a statement on Friday said it will make a formal appeal to the appropriate authorities "to do away with such a cosmetic tag."

It also wondered if giving a heritage tag to buildings serves any practical purpose.

Council president Paritosh Canning said it had been noticed that many such organisations had been declared as 'heritage structures' by the state 'Heritage Commission' though the respective authorities of schools are never in-



formed about such a declaration.

"In hindsight, while such declarations may seem to add a touch of importance and glamour to such old buildings, in practical terms they serve no purpose. While regular maintenance and renovation costs are huge, receiving grants from the Heritage Commission remains a distant hope, to be precise," he added.

"Under these circumstances, we are contemplating making an appeal to the appropriate authority to do away with such a cosmetic tag to enable us to arrange on our own, to keen the buildings in good condition for years to come, with regular, relevant maintenance,

The request follows a sub-

mission made in December last year by La Martiniere School for Boys and La Martiniere School for Girls, both 188-year old institutions, to the state heritage commission to remove the structures from the list of Grade I Heritage Buildings on the ground that the minority institution has the "fundamental right to freely manage and regulate their property so that the "ability to make necessary repairs and renovations is not impeded."

Saif Ali Khan, in recovery after knife attack, has 'Jewel Thief', 'Kartavya' and 'Race 4' in pipeline

MUMBAI, Jan 18: Bollywood star Saif Ali Khan, currently recuperating at a Mumbai hospital after suffering injuries in a knife attack at home, had recently wrapped up filming for his next movie "Jewel Thief - The Red Sun Chapter" and has few other projects lined up. The 54-year-old actor suffered multiple stab wounds, including on his neck and near the spine, in a brutal attack at his house in Bandra in the early hours of Thursday. He was rushed to Lilavati Hospital, where he underwent emergency surgery.

Khan was most recently seen in Jr NTR's "Devara: Part 1", which was released in theatres across the country in September 2024. The Koratala Siva-directed movie, which featured Khan in the role of the antagonist, marked his debut in Telugu cinema. It also starred Jahnvi Kapoor. The actor is expected to return for the film's follow-up as well. Though the makers are yet to officially announce the second part. Khan's upcoming movie is "Jewel Thief - The Red Sun Chapter", a heist drama. The film, directed by Robbie Grewal, also stars Jaideep Ahlawat. "Pathaan" fame filmmaker Siddharth Anand is producing the upcoming feature with his wife, Mamta Anand, under their banner Marfix Pictures. It reunites Anand and Khan after 17 years. The duo previously collaborated on "Salaam Namaste" and "Ta Ra Rum Pum". According to a source, the actor had completed filming for the movie, which is set to release in March 2025. Besides "Jewel Thief", Khan will be seen in "Kartavya", an upcoming drama from filmmaker Pulkit of "Bhakshak" fame. "The film with Saif is ready, we are dealing with the release. The producers are the best to comment on the release date," the director told PTI. In October 2024, veteran film producer Ramesh Taurani had announced that Khan will be returning for the fourth chapter of the "Race" franchise.

Taurani, the founder of production house Tips Films, said "Race 4" will see Khan leading an ensemble cast. The film will go on floors in September, he added.

"Saif will be back in the 'Race' franchise, and we are excited to have him on board. He did a great job in the first two films. The film will boast an ensemble cast, and we are finalizing the script and cast. We haven't finalised the director either. We will announce the film officially before we go on floors, most likely next year," Taurani had told PTI in an earlier interview.

Known for its high-octane action, glamorous settings, and intricate plots, the franchise began with the 2008 movie "Race", featuring Khan and Akshaye Khanna as two brothers, Ranvir and Rajiv, embroiled in a complex web of betrayal and deceit. Khan returned for the movie's 2013 sequel, "Race 2", which starred John Abraham as the villain. Both films were commercially successful and received positive reviews from critics.

However, the franchise's third part "Race 3" featured an entirely new cast led by superstar Salman Khan. The film performed poorly at the box office. Khan was also in negotiations for various other projects with filmmakers like Priyadarshan, and "Animal" director Sandeep Reddy Vanga for his next movie "Spirit", which features Prabhas in the lead role. Diljit Dosanjh's 'Punjab '95' to release internationally on February 7

NEW DELHI, Jan 18: Punjabi star-singer Diljit Dosanjh has announced that his much-awaited film "Punjab 95", based on the life of human rights activist Jaswant Singh Khalra, will be released globally on February 7 without any cuts.

"Punjab 95", directed by Honey Trehan and produced by Ronnie Screwvala's banner RSVP Movies, will not be releasing in India for now. The movie was delayed after running into trouble with the Central Board of Film Certification (CFBC).


It also stars Arjun Rampal and Suvinder Vicky of "Kohraa" fame.

On Friday evening, Diljit shared a trailer of the movie, in which he portrays Khalra. The film sheds light on his relentless pursuit of justice during Punjab's tumultuous militancy period, highlighting his investigations into human rights violations and the disappearances of Sikhs.

"Panjab '95' releases in Cinemas Internationally only on 7th February. P.S. Full Movie, No Cuts #ChallengetheDarkness," he wrote.

In 2023, "Punjab 95" was scheduled to have its world premiere at the Toronto International Film Festival (TIFF) but was removed from the line-up without any official statement from the organisers.

Khalra investigated the mass cremation of thousands of unidentified bodies in Punjab between 1984 and 1994. In 1995, he mysteriously disappeared, and a decade later, in 2005, four police officers were arrested for his alleged abduction and murder. In 2007, the Punjab and Haryana High Court extended their initial seven-year sentence to life imprisonment. (PTI)



'Deva' most complex character l've ever played, says Shahid Kapoor

MUMBAI, Jan 18: Shahid Kapoor is no stranger to complex characters and yet he considers his portrayal of a cop in "Deva" the most challenging performance of his career. The action thriller revolves around a rebellious police officer (Kapoor) tasked with solving a highprofile case that unravels layers of deceit, betrayal, and a dangerous conspiracy. "After a while, I got an opportunity as an actor to do something that would make me happy. There's an overwhelming personality that Deva has which gives him that charisma and star quality, so it needed to be a combination of both those elements," he added.

Andrrews said the action sequences in "Deva" are designed in such a way that they don't feel like they have added for the sake of it.

"I always believe in myself, in my instinct, and I don't get bothered about what's happening in other (action) films. I wrote all the action sequences in 'Deva' myself. NEW DELHI, Jan 18: With great popularity comes more responsibility as an actor and person, says "Squid Game" star Wi Ha-joon, who is motivated by the global success of the Netflix series to deliver his best.

Ha-joon, already a popular name for K-drama lovers with his roles in hit shows such as "Something in the Rain", "Romance is a Bonus Book", "Little Women" and "The Worst of Evil", became a known face world over when the series became one of the most watched shows ever on the streamer after its premiere on 2021.

The 33-year-old actor plays Hwang Jun-ho, a detective whose search for his missing brother leads him to an island where he gets to know about a secret organisation that hosts deadly games involving poor and debt-ridden people for a prize money of 45.6 billion won.

Ha-joon's character learned at the end of the first season that the brother that he was searching for is actually at the front of the organisation. In the second part, he has been demoted and works as a traffic cop but reunites with Gihun in his mission.

South Korean creators have successfully explored the rich-poor through their stories, whether it is Bong Joon-ho's Oscar-winning film "Parasite", Netflix's period zombie series "Kingdom" or "Squid Game".

Ha-joon believes it has to do with the historical and social

background of Korea.

"Korea had to go through a lot of painful experiences like losing independence to Japan, Korean (civil) war, industrialisation and democratisation. And the social and economic injustices and unfairness that people had to go through, led to the pain in their daily lives and that became the background for the success of (such) Korean stories," he said.

If he were to win the prize money of 45.6 billion won that's offered in the series, Ha-joon said, he would simply donate it.

"Honestly, in Korea and around the globe, there are many heartwrenching stories I am hearing so I would love to help those in need with the money," he added.

Ha-joon also said he would be happy if he gets to "do an international collaboration".

Is a collaboration with Indian creators also a possibility? "Of course, I would love to visit India if there is an opportunity," he added.

"Squid Game 2" also features Lee Byung-Hun, Yim Si-Wan, Kang Ha-Neul, Park Gyu-Young, Park Sung-Hoon and Jo Yu-Ri.

Australian Open: Iga Swiatek is in total control during a 6-1, 6-0 rout of Emma Raducanu

MELBOURNE, Jan 18: palms more than a foot apart to turning. And so on. Tien, a qualifier ranked 121st, followed up his surprising win against No. 5 Daniil Medvedev in a five-setter that ended at 3 a.m. on Friday with a 7-6 (10), 6-3, 6-3 victory over Corentin Moutet of France. Michelsen, who is ranked 42nd, overwhelmed No. 19 seed Karen Khachanov of Russia 6-3, 7-6 (5), 6-2. It was the second time Michelsen knocked off a top-20 seed this week after beating No. 11 Stefanos Tsitsipas, the 2023 Australian Open runner-up, in

U.S. Open semifinalist in 2023, defeated No. 16 Lorenzo Musetti of Italy 6-3, 3-6, 6-4, 7-6 (5) and will take on Monfils on Monday.

Michelsen will try to send another high seed packing when he plays No. 8 Alex de Minaur, an Australian who beat No. 31 Francisco Cerúndolo 5-7, 7-6 (3), 6-3, 6-3. Tien faces 55thranked Lorenzo Sonego of Italy, a 6-7 (3), 7-6 (6), 6-1, 6-2 winner over Fabian Marozsan.

Against Raducanu, who won the 2021 U.S. Open as a teenage qualifier, Swiatek played at a level she called "perfect."

United and Scotland soccer great, dies at 84 MANCHESTER, Jan 18: Denis 1973-74 season.

Denis Law, the Manchester

Law, the Manchester United and Scotland great, has died. He was

The death of Law, the only Scottish player to win the Ballon d'Or, was announced by his family through United on Friday. In 2021 he was diagnosed with dementia.

"It is with a heavy heart that we tell you our father Denis Law has sadly passed away. He fought a tough battle but finally he is now at peace," the statement read.

'We would like to thank everyone who contributed to his wellbeing and care, past and much more recently. We know how much people supported and loved him and that love was always appreciated and made the difference.

Law is forever linked with Bobby Charlton and George Best, the three-pronged strike force that led United to English league titles in 1965 and '67 and the European Cup in 1968 — a first for an Eng-

"Everyone at Manchester United is mourning the loss of Denis Law, the King of the Stretford End,' United said in a statement. "With 237 goals in 404 appearances, he will always be celebrated as one of the club's greatest and most beloved players. The ultimate goalscorer, his flair, spirit and love for the game made him the hero of a

Law, Charlton and Best would be voted as European footballer of the year and win the Ballon d'Or in a five-season period from 1964-68. They are united in a statue at Old Trafford. Law is the only player with two statues at the stadium: He stands solo on the Stretford End concourse, naturally,

Law's 46 goals in the 1963-64 season remains a single-season record for United. His 237 goals for the club are bettered by only Charlton and Wayne Rooney, though his goals-per-game ratio is

However, a goal he scored against United is arguably his most famous. In one of the last games of his career, Law was playing for Manchester City — where he had two spells — at Old Trafford in United's next-to-last game of the

His late goal, with an audacious back-heel flick he insisted was "a fluke," meant United lost 1-0 and helped to ensure its relegation to the second division just six years after being European champion.

Law did not celebrate his goal and was substituted with head bowed as United fans invaded the pitch before the game restarted.

His 30 goals for Scotland are matched by only Kenny Dalglish, though was achieved in just 55 games compared to Dalglish's 102.

UEFA was one of many to react to Law's death. On X it wrote, "On behalf of European football we are deeply saddened to learn of the passing of Denis Law. One of Scottish football's true greats."

A player who would become fondly referred to as "The Lawman." Law left his northern Scotland hometown of Aberdeen as a skinny 15-year-old with poor eyesight. He became a feared penaltyarea predator and a pioneer in a modernizing world of European

By the age of 22, both United and City paid English-record transfer fees to sign Law, and he had played one season in Italy — an exotic change of culture at that time, though he disliked the defensive nature of Serie A.

He returned from Torino in 1962 to begin an 11-year stint at Old Trafford that helped re-establish United as an international power under manager Matt Busby.

Law joined a club that was still rebuilding from the airplane crash at Munich four years earlier. It took the lives of most of Busby's thendominant team returning from a European Cup game.

Law's prolific scoring helped United win the FA Cup in 1963 for its first trophy since the Munich disaster, and then two league titles in three seasons

Redemption for Busby's United was becoming European champion a decade after the tragedy.

Though Best and Charlton scored in the final, a 4-1 extra-time win over Benfica. Law missed the game at London's Wembley Stadium due to a knee injury that per-

NEW DELHI, Jan 18: Bolstered by the hope fuelled by the Paris Olympics, French badminton players are turning a new page, a revolution led by mixed doubles pair of Thom Gicquel and Delphine Delrue.

The French duo are on the rise again after achieving their career-best ranking of fifth at the start of 2023.

Since the Olympics, Thom and Delphine reached the quarterfinals at the Denmark Open, the semifinals at the Hylo Open, before finishing runners-up at the Japan Masters, steadily climbing to world number 12

from a mid-2024 dip to 23rd. The two made a strong start to the new season with a quarterfinal finish at the Malaysia Open Super 1000 and reached the semifinals at the ongoing India Open Super 750.

'The secret is to have the shield of fire in our head and the body if we want to reach the top level. And for that, you need to have goals to improve and also

goals for tournaments. And our big goal for this season is the World Championship in Paris,' Thom said.

"That's one of the best things. If you play well there, it can be fantastic. So that's the main goal."

Delphine added: "I think we have a goal to be back in the top 10 and to be in the top 8. So yeah, we also want to qualify for the World Tour Finals. So we have a lot of goals.

With Paris hosting the Olympics last year, there were high expectations from the home players. Even though it didn't turn out as the French players had hoped for, it brought significant change and hope for a better future.

While Thom and Delphine are the top-ranked shuttlers from the country, Alex Lanier and Toma Junior Popov are climbing up the world rankings in men's singles, currently ranked 17th and 18th, respectively. Alex had stunned reigning

world champion and Olympic silver medallist Kunlavut Vitidsarn in the opening round of the India Open. The Popov brothers – Toma and Christo — are also knocking on the top 20, with Christo ranked 22nd.

Bumrah picked for CT; Shami returns, Jaiswal gets maiden ODI call-up

Bumrah was on Saturday named in India's squad for the Champions Trophy with his availability depending on fitness, and talented opener Yashasvi Jaiswal expectedly received the nod from the selectors, who also brought back Mohammed Shami in the national fold.

Bumrah had suffered back spasms during the recent Sydney Test against Australia and did not bowl on the final day at SCG.

But the Ajit Agarkar-led selection panel went ahead and included the 31-year-old in the squads that will do duty in the home ODIs against England and in the marquee ICC event, starting February 19.

Top-order batter Shubman Gill has been appointed as the vice-captain of the squad that had did not have place for pacer Mohammed Siraj.

Rohit Sharma, who will lead the side against England in the CT, explained the rationale behind selecting Bumrah with an asterisk against his name

"Experience, it's only Siraj who's not there. But that's purely because we thought of it. We're not sure about Bumrah, whether he's going to play or not. We wanted to pick a squad where we have options of both, somebody to bowl with the new ball and somebody to bowl at the back end," said Rohit in the press meet to announce the

Rohit hoped that seasoned pacer Shami and left-arm pacer Arshdeep Singh will support Bumrah, or step in the eventuality of him missing the tournament.

"Obviously, with Bumrah missing, we're not sure. We wanted Arshdeep to come and play that role of bowling at the back end and Shami, obviously we saw what he did with the new ball (in the World Cup 2023 and during the recent domestic matches)."

Shami is returning to the ODI set up for the first time since the 2023 World Cup, and



the pacer has done well in the domestic matches (Ranji Trophy, SMAT and VHT),

even though he is yet to hit the peak rhythm. "Arshdeep hasn't played a lot of ODIs but he's been around the white-ball circuit for a long time. I don't feel so uncomfortable saying that he's not experienced.

"He has bowled some tough overs in white-ball cricket. I definitely think he can handle that pressure and Shami is a stalwart of white-ball cricket and what he did recently in the (ODI) World Cup was superb to watch," he added.

Rohit termed Siraj unfortunate to miss out on the selection and said his reduced effect with the old ball played a part in it.

"Siraj's effectiveness comes down a little bit if he's not going to take the new ball. We discussed it at length and we are only taking three seamers there (CT) because we wanted all the all-rounders with us.

"It's an unfortunate thing that he (Siraj) has to miss out but we had no option but to get the guys who can perform a certain role,"

The selection of Jaiswal was a no-brainer after his fine run Down Under albeit in Tests. and the variety he offers at the top as a left-

"Sometimes, I know it's very hard to ignore numbers but look at Jaiswal. We picked Jaiswal based on clearly what he's shown in the last 6-8 months. He's not played a single ODI but we still picked him because of the potential that he's got," he said.

All-rounder Harshit Rana, who made his Test debut in Australia, has been picked to play only the three-match ODI series against England.

Wrist-spinner Kuldeep, who was recuperating from a long-standing groin injury, has also been selected after sitting out of the Test series against Australia.

India have relied on a clutch of allrounders to make an impact in the blueriband event that they had won in 2013 under MS Dhoni.

Hardik Pandya will lead that list and the pace-bowling all-rounder will be back to ODIs for the first time after the 2023 World against Bangladesh with an ankle injury.

Others are experienced Ravindra Jadeja, Axar Patel, the two left-arm spinners, and off-spinner Washington Sundar.

Rishabh Pant has played a lone one-day match in the last two years, against Sri Lanka last year, after coming back from the accident, but the selectors have decided to give him the mantle of the first-choice wicketkeeper batter.

The left-handed variety that he offers down the line too might have played a part, with KL Rahul supporting him as the backup wicketkeeper batter.

However, as expected, Sanju Samson did not feature in any of the squads despite doing well against South Africa recently. He had made a hundred against the Proteas at Paarl late last year.

But Samson not attending Kerala's Vijay Hazare Trophy camp and the subsequent non-selection for the domestic tournament



participation in domestic cricket. Rohit also said that no player takes premier domestic red-ball

tournament "for granted" Mumbai will play Jammu and Kashmir at the MCA-BKC Ground when the Ranji Trophy resumes on January 23.

Asked about his availability for the game during a press conference at the Wankhede Stadium press box here, Rohit responded in

Days after the BCCI conducted a review meeting to assess the debacle Down Under, the Board has came out with 10 guidelines for India's centrally-contracted players, including making participation in domestic tournaments mandatory for selection in the national team.

The focus since then has been on the likes of Rohit and his longtime India teammate Virat Kohli.

The India skipper said, "Last 6-7 years, if you go back and look at our calendar, there hasn't been a time where we were sitting at home for 45 days and there is (domestic) cricket going on. You do get that time when you finish IPL and if there's nothing happening (in domestic cricket) right after that..." Rohit said.

"But if you see our domestic season, it starts in October, maybe September, and it gets over by February-March and that is the time India plays a lot of cricket as well. So, guys who are not playing certain formats and have time, and then there is domestic cricket happening, then they will play. "But (in) the last 6-7 years, I can at least tell about what has hap-

pened with me since I've started playing Test cricket regularly, which is from 2019, you hardly have any time in hand and then, when you play so much international cricket through the year, you need some time off as well as a cricketer just to refresh, get your mind right, just to be ready for the upcoming season."

The 37-year-old, who endured a horror run with the bat in the national team's tour of Australia recently, trained with the Mumbai squad at the Wankhede Stadium on Tuesday ahead of the second phase of the Ranji Trophy.

Rohit's last Ranji appearance was in November 2015 against Uttar Pradesh.

He added, "We have addressed it now and nobody takes it (domestic red-ball cricket) for granted or anything like that. It is just ben based on looking at how one has gone through the season, how much rest he needs," he said.

"Based on all of that, we decide what is going to happen with certain players. Now it's been made mandatory that if there is time, you have to play domestic cricket."

The past few weeks have been tumultuous for Rohit. He managed just 31 runs across three Tests during his time Down

Under and was forced to drop himself from the series-deciding fifth and final Test in Sydney due to his poor form. Rohit handed over the leadership duties to Jasprit Bumrah in that

LOS ANGELES, Jan 18: The devastation wrought by the deadly wildfires that ravaged sections of Los Angeles have left an indelible imprint on the region's

landscape and psyche. The runup to the city hosting the 2028 Summer Olympics and Paralympics, in addition to World Cup matches in 2026 and a Super Bowl in '27, will coincide with massive rebuilding of housing and infrastructure. That seems cruelly ironic after Los Angeles organizers sold the

Games as a no-build event. None of the Olympic venues have been damaged by the still-burning fires that tore through Pacific Palisades on the city's westside and Altadena, an unincorporated community above Pasadena in the foothills of the San Gabriel Moun-

The Palisades fire came close to Riviera Country Club, which will host Olympic golf and was inside the evacuation zone. UCLA, which will house athletes, was just outside the zone.

"While our focus remains on healing and rebuilding, there is no reason to believe that the fires will adversely impact or delay preparations for the 2028 Olympic and Paralympic Games, which are already well underway," Paul Kerkorian, executive director of the city's new Office of Major Events, said in a state-

The NFL, NBA and college basketball relocated or postponed games in the days after the fires began on Jan. 7.

"We are in full solidarity with the citizens of Los Angeles and full of admiration for the tireless work of the firefighters and the security forces," the International Olympic Committee said in a statement. "Currently the full focus must be on the fight against the fires and the protection of the people and prop-

Los Angeles was awarded the 2028 Olympics for a third time in 2017, with the IOC praising organizers' bid for using existing and temporary venues rather than constructing new stadiums and sports facilities specifically for the Games, as well as its commitment to sustainability and fiscal responsibility.

Yet the Games were still expected to cost roughly \$6.9 billion for investments like upgraded transportation, revamped facilities and improvements to the city's infrastructure with a goal of benefitting residents long after the Olympic flame is extinguished. Three major projects involve renovating the city's airport and expanding the Metro transportation sys-



tem and downtown convention center. No one counted on a large-scale disaster occurring in the nation's secondlargest city when those projects were approved.

'What's happened in a number of recent Olympics is something else comes along that entirely changes what the Games are all about," said Dr. Matthew Brown, a University of Utah political science professor who has written extensively about the Olympics.

We look forward to partnering with him and his administration to deliver a safe and successful Games our nation can be proud of," Wasserman said.

Los Angeles is not immune to disasters - real or imagined. Wildfires, earthquakes, mudslides, flooding, drought and rioting have left their marks on the nation's most populous county of nearly 10 million people. And on the screen, Hollywood has dreamed up mass destruction.

The ongoing wildfires have killed over 20 people, destroyed over 12,000 structures and fouled the sprawling region's air quality, which affects public

is put a big strain on availability of resources from the city of LA, surrounding cities and the state of California." Brown

"What happens then is those resources have to come from somewhere and that means other things are not going to have resources.'

Brown points out that while the Olympics are primarily funded through the local organizing committee, Games held in the U.S. depend heavily on state and local governments for police, fire, first responders and traffic control.

"Those are all local resources," he said. "They're not going to be controlled

by the local organizing committee.' It's unclear how the recovery could impact LA's notorious traffic congestion. Mayor Karen Bass has promised a "car free" Olympics, but no detailed transportation plans have been announced for the Games, which are expected to attract

thousands of people daily. The region's ability to recover will be tested as it prepares to host the World Cup, Super Bowl and the 17-day Olympics followed by the Paralympics in a span of three years. (AP)
