Nine miners still trapped, one arrested Dima Hasao coal mine 'illegal': CM • Navy divers to be engaged in rescue of miners

GUWAHATI, Jan 7: Chief Minister Himanta Biswa Sarma said on Tuesday that a person has been arrested after nine workers were trapped inside a coal mine in Dima Hasao district, which "appears to be illegal".

He also said a case was registered in connection with the incident that occurred on Monday in the Umrangso area.

Rescue operations have been continuing since Monday but no worker has been brought out of the quarry so far, a district official said.

"The police have registered an FIR under Umrangso PS Case No: 02/2025, citing Sections 3(5)/105 BNS, r/w Section 21(1) of the Mines and Minerals (Development and Regulation) Act, 1957, to investigate the incident. Prima facie, it appears to be an illegal mine. One Punish Nunisa has been arrested in connection with the case," the chief minister posted on 'X'.

Navy divers have been requisitioned to assist local authorities in rescuing the nine labourers trapped inside the coal mine as the water level inside the quarry has risen to nearly 100 feet, Sarma said.

The chief minister listed the names of the trapped labourers - Ganga Bahadur Shreth, Hussain Ali, Jakir Hussain, Sarpa Barman, Mustafa Seikh, Khushi Mohan Rai, Sanjit Sarkar, Lijan Magar, and Sarat Goyary.

"Distressing news from Umrangshu, where labourers are trapped in a coal mine. The exact number and status are yet unknown. The DC, SP and my colleague Kaushik Rai are rushing to the site. Praying to God for everyone's safety," Sarma had said in a post on X.

Eyewitness accounts and initial assessments suggest that the flooding occurred unexpectedly, leaving the workers unable to escape from the mine.

Rescue operations were launched immediately with teams consisting of local authorities, emergency responders and mining experts working to locate and rescue the trapped workers, the officials said. (PTI)

Delhi to vote on February 5, counting on February 8

NEW DELHI, Jan 7: Polling for all 70 assembly seats in Delhi will be held on February 5 and the votes counted on February 8, Chief Election Commissioner Rajiv Kumar announced on Tuesday.

Bypolls to two assembly constituencies -- Milkipur in Uttar Pradesh and Erode in Tamil Nadu -- will also be held according to the same schedule while that in two constituencies of Jammu and Kashmir -- Budgam and Nagrota -- will be held later due to the current snowy conditions.

The last date to file nominations is January 17 and the scrutiny of nominations will be done by January 18. Candidates will be able to withdraw their nominations till January 20.

"It is a single-phase election... We have deliberately kept polling on a Wednesday so more people come out to vote... like we did in Maharashtra. The entire election process will be completed by February 10," Kumar said at a press conference. Of the 70 seats in Delhi, 58 are general and 12 reserved.

According to the electoral roll, Delhi has 1.55 crore voters -- 83.49 lakh men, 71.74 lakh women, and 1,261 transgender persons.

There are 25.89 lakh young voters, 2.08 lakh firsttime voters, and 830 above the age of 100, Kumar said. More than 13,000 polling stations will be set up in Delhi, he said. In the 2020 polls, AAP won 62 seats and the BJP eight while the Congress drew a blank.

Centre asks states to increase surveillance for respiratory diseases

NEW DELHI, Jan 7: The Centre has advised states to step up surveillance for respiratory illnesses including ILI and SARI, and spread awareness about the prevention of transmission of the human metapneumovirus (HMPV) after five cases were detected in

Union health secretary Punya Salila Srivastava on Monday chaired a virtual meeting with states and union territories to take stock of respiratory illnesses and HMPV cases in the country and public health measures for their management, a health ministry statement said.

The meeting was attended by Health Research Department secretary Dr Rajiv Bahl, director general of Health Services Dr Atul Goel, experts from the National Centre for Disease Control (NCDC), Integrated Disease Surveillance Programme, (IDSP), Indian Council for Medical Research (ICMR), National Institute of Virology (NIV), and State Surveillance Units of IDSP, a health ministry statement said.

The meeting was held amid reports of a surge in HMPV cases in China and on a day when five cases of HMPV were confirmed in Karnataka, Tamil Nadu, and Gujarat. HMPV is a globally recognised respiratory virus. It is a viral pathogen that causes respiratory infections in people of all age

During the meeting, it was reiterated that the data from IDSP does not indicate any unusual rise in influenza-like illness (ILI) and severe acute respiratory illnesses (SARI) cases anywhere in the country, the statement said. This is also corroborated by the ICMR sentinel surveillance data, it said.

Union health secretary Srivastava emphasised that there is no cause for concern for the public as HMPV has been present globally since 2001, the statement said. She advised states to strengthen and re-

Microsoft to invest \$3 bn in AI, cloud expansion in India

BENGALURU, Jan 7: Microsoft will invest USD 3 billion (about ₹ 25,700 crore) to expand its cloud computing and artificial intelligence capabilities in India, its chief executive officer Satya Nadella said on Tuesday.

The tech giant will also train 10 million people in AI skills in India by 2030, Nadella said, addressing a conference attended by startup founders and executives from technology firms here.

Nadella is the latest in the list of tech tycoons to have visited India - the nation of 1.4 billion people that is emerging as an AI battlefront.

Chip maker Nvidia chief Jensen Huang, AMD's Lia Su, and Meta chief AI scientist Yann LeCun had in recent months visited India, home to millions of programmers and technology services providers like Tata Consultancy Services (TCS), Infosys, and Wipro. Nadella said the USD 3 billion investment in India would be the "single-largest expansion" done in the country. "The diffusion rate

6.8-magnitude quake in Tibet kills 95 people Tremors felt in neighbouring Nepal



BEIJING, Jan 7: A 6.8-magnitude earthquake struck near one of Tibet's holiest cities on Tuesday, killing at least 95 people and injuring 130 others with tremors also shaking buildings and forcing people to run to the streets in neighbouring Nepal.

According to regional disaster relief headquarters, the quake jolted Dingri County in Xigaze in Tibet Autonomous Region in China at 9:05 am Tuesday (Beijing Time). The US Geological Service, however, put the quake's magnitude at 7.1. At least 95 people have been confirmed dead and

130 others injured as of 3 p.m. Tuesday (local time), state-run Xinhua news agency reported. Chinese President Xi Jinping has ordered all-out

rescue efforts to carry out relief and rescue operations in the affected areas. Xi ordered utmost efforts to treat the injured and urged efforts to prevent secondary disasters, properly

resettle affected residents, and handle the aftermath Following the quake, China Earthquake Administration launched a level-II emergency service response and sent a work team to the site to assist with disaster

relief efforts. Xizang Autonomous Region also issued a level-II

emergency response to the quake. GDP growth likely to slip to 4-year low of 6.4 pc in FY25: Govt data

economic growth rate is estimated to slip to a four-year low of 6.4 per cent in 2024-25, mainly on account of poor showing by the manufacturing and services sector, according to government data released on Tuesday.

The gross domestic product (GDP) rate of 6.4 per cent will be the lowest since the Covid year (2020-21) when the country witnessed a negative growth of 5.8 per cent. It was 9.7 per cent in 2021-22; 7 per cent in 2022-23; and 8.2 per cent in the last fiscal ended March 2024.

The first advance estimates of National Income for 2024-25 released by the National Statistics Office (NSO) is lower than the 6.6 per cent projected by the Reserve Bank in December 2024. It is also a tad lower than the finance ministry's initial projection of 6.5-7 per cent.

The advance estimates will be used in preparation for the Union Budget to be presented by Finance Minister Nirmala Sitharaman in the Lok Sabha on February 1.

The economic growth slowed to a seven-quarter low of 5.4 per cent during the July-September period. It was 6.7 per cent in the first quarter (April-June).

The manufacturing sector output is expected to decelerate to 5.3 per cent from a high of 9.9 per cent recorded in the previous fiscal,

Wagh Bakri Tea to invest ₹100 cr for setting up new manufacturing unit in Gujarat

AHMEDABAD, Jan 7: Ahmedabad-headquartered Wagh Bakri Tea Group will set up a new plant in Gujarat with an investment of over ₹ 100 crore to increase its raw material storage capacity and instant tea output, CEO Sanjay Singal said on Tuesday.

Singal, who joined Wagh Bakri as its CEO in August last year, said that the new unit will expand its instant tea and raw material warehouse capacities.

The new warehouse will be equipped with Automatic Stock Retrieval System (ASRS), he said.

"We are setting up a new manufacturing unit to basically meet our expanded demand, especially in the instant tea category, because convenience is a new driver for our consumers, and for that we are setting up additional capacity," he said. The new unit will come up at Dakor in Gujarat with an investment of over ₹ 100 crore, and will be ready by the third quarter of 2025, he said.

With the new plant, the com-



pany will increase its capacity to produce instant tea by five times from the current 3,000-4,000 packets every day. "With the new instant tea line, this will grow up to

20,000 packets per day," he said. Further, its storage capacity will increase by 50 per cent to around 15-18 lakh chests, with each accommodating 14-20 kg, he said.

The company continues to launch new products every month and open new tea lounges in different cities. It also plans to increase its focus on e-commerce, quick commerce, digitisation, artificial intelligence in manufacturing and big data, etc., Singal said. "We started in 2023-24 with around 34 tea lounges, and added 20 this year. We plan to add a couple of stores every quarter. We are not here to look at the crazy expansion of tea lounges. This business is an integral part of our vision for the tea category, so we would like to expand where we can give good experience and make tea interesting, exciting for consumers," he said. Even when India's tea production dropped 8-12 per cent compared to last year, the company's volume growth has remained higher. "Our production has been higher than last year, with a double-digit growth compared to last year," he said, adding that fresh pricing will be based on next year's production.

"We assume that prices will rationalise, and we will see how we want to manage that. Having said that, the reason for price increases is that we will not compromise on the quality of a blend even for money," he said. He said that as per AC Nielsen, Wagh Bakri enjoys 9 per cent market share.

It is the largest selling premium tea brand, with roughly 60 million kg sales annually, out of which 12-15 per cent is exported, he said. "In volume-term, we are growing 4-5 times the growth of the category. Value growth will be around 10-12 per cent compared to last year," he

Xigaze also known as Shigaste is close to the border with India. Shigatse is considered one of the holiest cities of Tibet. It is the traditional seat of the Panchen Lama, a key figure of Tibetan Buddhism whose spiritual authority is second only to the Dalai Lama. The epicentre was located in Tsogo Township of Dingri County, which has a population of approximately 6,900 people within a 20-km radius. There are 27 villages within this area. Official data show Dingri County has a population of over 61,000 people.

The epicentre is located 90 km North-East of Lobutse in the Khumbu Himalayan range of North-East Nepal. The quake struck at a depth of 10 km, according to a report issued by the China Earthquake Networks Centre, state-run Xinhua reported.

In his message, President Xi said it is essential to strengthen earthquake monitoring and early warning, promptly allocate emergency rescue supplies, expedite the repair of damaged infrastructure, ensure that the basic needs of residents are met, and guarantee a safe and warm winter for all.

China refers to Tibet as Xizang, part of the Himalayan region.

The Tibetan plateau is known to be prone to heavy earthquakes as it sits right over the place where the tectonic Eurasian and Indian plates meet, often colliding with huge force. Shigaste also suffered significant damage in the massive 8.1-magnitude quake that devastated Nepal in 2015. Eighteen people were killed and 55 injured in the Shigaste region when a massive 8.1-magnitude quake hit Nepal and the wider Himalayan in 2015.

Meanwhile, in Nepal, the strong earthquake forced people to run out of their houses. It was felt in Kavrepalanchwok, Sindhupalanchok Dhading and Solukhumbu districts as well. Many people came out of their houses due to panic in Kathmandu. People witnessed buildings, trees and electric wires on the streets shaking for some time.

However, a Nepal Police spokesperson says that so far they have not received any information regarding any human causality. An official at Shankhuwasabha District Administrative Office said a two-storey building made of stone was damaged in Kimathanka Rural Municipality of the district due to the earthquake.

As the epicentre lies in Tibet, stronger tremors were felt by people living in Northern Nepal, Nepal Police spokesperson Bishwo Adhikari said. At least half a dozen tremors with magnitude ranging from 4 to 5 were also recorded within a time span of an hour around 7 am, according to the USGS report. The tremor was strong enough to terrorise people in Nepal, who recalled the 2015 great earthquake that killed 9,000 people. (PTI)

Dibrugarh DC promulgates order on animal slaughter

JORHAT, Jan 7: The Jorhat district administration has made it compulsory for livestock to be sold only after it is slaughtered in a government approved or private licensed slaughterhouse and bears the health mark/stamp by a veterinary doctor stating that the animal is fit for human consumption and 'Passed' stamp from the slaughter house.

The order was promulgated on Tuesday by Jorhat district commissioner Jay Shivani in exercise of sub section (1) and (2) of section 38 of the Prevention of Cruelty of Animals Act, 1960 (59 of 1960) and now called Prevention of Cruelty to Animals (Slaughter House) Rules,

The order specified that no person without the permission of the municipal board shall slaughter or cause to slaughter any animal for sale in the city except in a government approved slaughterhouse or a licenced private slaughter

Moreover, it is mandatory for the retail shop owner selling meat to get a trade license from the Jorhat Municipal Board and to retain the stamped portion of the meat until the whole carcass is sold, for inspection purposes.

Regarding the animals to be slaughtered, the order stated that no livestock in febrile condi-

The order further stated that it would be the duty of the manager/lessee of the slaughterhouse inter alia to arrange animals' antemortem and post mortem and keep a record of

It was stressed that every animal/carcass/internal organ/meat shall be subjected to veterinary inspection, which is called ante mortem (before slaughter) and post mortem (after slaughter) examination.

The animal fit for human consumption shall be passed or slaughtered and the meat fit for human consumption shall only be passed for

Regarding the ink to be used by the veterinary officer for the health mark stamp after finding the meat fit for human consumption should be of edible grade and non-poisonous, and all the instruments and marking articles shall be personal and when not in use, shall be kept in safe custody to be used only by the veterinary doctor/authorised veterinary doctor under lock and kev.

Retail shops should be glass fronted, should not be near a saloon or cement selling stores, should be clean and hygienic, the retail shop owner should have a valid trade license and should not slaughter any animal intended for human consumption near the shop.

Trouble brewing in UP coalition

Il is not well between BJP and coalition partners in Uttar Pradesh where Apna Dal and Nishad Party presidents expressed dissatisfaction on public platforms at the functioning of the Yogi Adityanath government. Significantly, Apna Dal (Sonelal Patel) leader and cabinet minister Ashish Patel publicly alleged threat to his life from STF (Special Task Force) of UP Police. While addressing the party workers, Ashish Patel minister for technical education said as a part of the larger conspiracy, allegations of corruption were levelled against him and the department. Ashish Patel said the allegation of not implementing the reservation policy while promotion of 100 teachers and other corruption charges were levelled deliberately to derail the social justice work being pursued by his party and the department. Pallavi Patel also met UP chief minister Yogi Adityanath to seek STF inquiry into the charges of corruption against Minister Patel. Union Minister Anupriya Patel and her husband and UP Minister Ashish Patel met BJP national president JP Nadda and sought his intervention into the alleged allegation and harassment being meted out to

Another coalition partner is also not happy with the prevailing situation in UP. Cabinet Minister Sanjay Nishad also came out publicly in support of Apna Dal leader and Minister Ashish Patel. He told media that there were certain elements in UP who were hell bent to create confusion. He also alleged that the state bureaucracy should be blamed for the alleged harassment of coalition partners. Earlier Sanjay Nishad had blamed BJP for not giving respect to coalition partners. Nearly 2316 years ago, the Indian philosopher, economist, jurist, and royal advisor professed diplomatic principles that still have relevance in modern diplo-

Chanakya who lived around 300 BCE was a key figure in the establishment of the glorious Mauryan Empire and is known for writing Arthashastra, an ancient Indian treatise on politics and economics.

Unfortunately, the South Block in New Delhi is manned by chosen blue-eyed civil officers who inherited the legacy of the British Rai instead of the marvel of Chanakya's diplomacy.

South Block in New Delhi houses the Prime Minister's Office, the Ministry of External Affairs (MEA), and the Ministry of Defense.

India had invested heavily in her continued hegemony among the neighbors, which has adopted a much trumped-up policy of 'Neighborhood First'.

Earlier Delhi pursued the 'Look East Policy' to yield positive results in the region and Bangladesh and several South Asian countries were partners in progress and economic development.

Not to be misunderstood for the 'Neighborhood First' policy, but the Hindutava (an ideology or movement seeking to establish Hinduism and Hindu culture as dominant in India) pursued by the governing Bharatiya Janata Party (BJP) has irked most South Asian

Presently India's relationships with neighbors are blowing hot and cold. Some countries have developed love and hate with India after arch-enemy China made a dent in the region with China's Belt and Road Initiative (BRI) mega projects, especially in Afghanistan, Pakistan, Sri Lanka, Maldives, and Bangladesh. Now those countries are on the fresh list of disapproval by the helms of affairs in Delhi's South Block.

Bangladesh on the diplomatic front is the opening batsman in a bid to bring to life the weakened SAARC (South Asian Association

Regional Cooperation). Bangladesh is expecting the SAARC foreign secretary-level meeting will be held soon, which has been halted for the last 10 years. The SAARC summit has also stalled for 10 years, because of the India-Pakistan conflicts.

"SAARC appears dead but it should not be buried," Touhid Hossain, a Bangladesh Adviser for the Ministry of Foreign Affairs remarked. The regional cooperation was extremely important for improving trade and economy and reducing poverty in the South Asian region, the ad-

Yunus told the New Age, "India is not responding seriously. Indians explain that they have problems with Pakistan." The bone of contention between Bangladesh and India is centered around Hasina, who is living in exile near Delhi.

Bangladesh has formally asked India to extradite deposed Bangladesh Prime Minister Sheikh Hasina, the MEA spokesperson refused to make any statement on Dhaka's request when Indian journalists asked for a comment.

Now it seems that Delhi will remain silent on the issue of extradition. Both countries signed a treaty in 2013 and amended it in 2016. The treaty was signed to deport northeast India's separatist leaders harbored in Bangladesh.

Similarly, two fugitive military officers indicted for the assassination of Sheikh Mujibur Rahman, the independence hero were hiding in India. Yunus told editor Kabir that if India does not officially respond to the extradition of Hasina, Dhaka will make a follow-up request after a month with Delhi

Dhaka has repeatedly requested Delhi to ensure that Hasina remains quiet and refrain from making fiery political speeches over the phone to her loyalists, which often emerges in social media.

Most of the central leaders of Hasina's Awami League have fled to India through clandestine routes. Many have taken refuge in Australia, Canada, Malaysia, Saudi Arabia,

destinations. Those who couldn't escape have been arrested. They were accused of the deaths of students and protesters. The political prisoners are languishing in prison without bail for the last four

Last week, Foreign Adviser Touhid Hossain and Chief of Army Staff General Waker-Uz-Zaman in separate media engagements have extended an olive branch to restore the bilateral relations with India.

General Waker, who is described by senior officers as a professional soldier in an interview with editor Matiur Rahman of Prothom Alo, the largest Bangla newspaper said that India is an important neighbor.

"We are dependent on India in many ways. And India is getting facilities from us too. A large number of their people are working in Bangladesh, formally and informally...So India has a lot of interest in Bangladesh's stability,' he observed.

"This is a give-and-take relationship....We have to maintain good relations based on equality. The people in no way should feel India is dominating over us, which goes against our interests," the COAS.

Waker is incidentally the husband of Sheikh Hasina's cousin and last June was made COAS. He was a hard nut in negotiating with Hasina to

Bangladesh and India have to be built on the basis of sovereignty, mutual interest, and dignity as the dimension and equation of Bangladesh's relation with India have changed after 5 August, noted Hossain.

On the other hand, Indian news NDTV, CNN-IBN media News18, Times Now, Republic TV and several other media outlets have been amplifying fake stories that General Waker has ceased power from Hasina. The Nobel laureate Prof Muhammad Yunus is a façade (stooge) and the Islamist party Jamaat-e-Islami is dominating the Interim Govern-

Prof Yunus in an interview with the New Age editor Nurul Kabir expressed his frustration over Indian media spreading concocted stories on Bangladesh and even described the Interim Government as an Islamist regime.

The Indian media along with the central leaders, as well as the state Chief Ministers of BJP have demonized Bangladesh for revenge attacks upon the 13 million Hindus and held Yunus responsible for the atrocities in the coun-

"When Indian Prime Minister Narendra Modi called me and alleged that the religious minority community was being persecuted here in Bangladesh, I told him that the narrative was an exaggerated one," Yunus said in an interview with the anti-establishment newspaper.

Hossain said that the role played by Indian media was not at all conducive to establishing normal relations between the two

Indian media, academicians, and political stalwarts are forgetting that the territory that is now Bangladesh was thrice partitioned. The British Raj partitioned in 1905 and 1947 to create Pakistan based on a Muslim-majority region in India. The third partition was in 1971, when it finally bifurcated from Pakistan after rejecting the Two-Nation theory, said political historian Mohiuddin Ahmad.

India must accept the political reality that Hasina has gone for now and must condemn the wanton deaths of more than a thousand students and protesters during the July-August so-called Monsoon Revolution, said Ahmad.

Historian Mohiuddin Ahmad concluded that unless Delhi recognizes the bloody student revolution that ousted the autocratic regime of Sheikh Hasina and gives hope on extradition, bilateral relations will continue to limp, which will severely affect regional cooperation (SAARC). The recent rise of the Human Metapneumovirus (HMPV) acases in China has brought attention to a virus that is not new but is now being widely discussed. HMPV, first identified in 2001, causes respiratory infections. Although it is not as severe or widespread as COVID-19, its increasing cases in China have raised concerns about its potential to spread to other countries, including India and beyond. People are questioning if HMPV might lead to a global crisis like COVID-19, potentially causing lockdowns and disruptions to daily life again.

HMPV primarily spreads through respiratory droplets, close contact with infected individuals, or by touching contaminated surfaces and then touching the face. Symptoms are usually mild, including fever, cough, nasal congestion, and shortness of breath. However, in vulnerable groups such as young children. the elderly, and those with weakened immune systems, the infection can become more severe, leading to complications like bronchitis or pneumonia.

In China, the number of HMPV cases has surged, particularly in northern regions. Hospitals have reported an influx of patients with respiratory symptoms, most of them children under the age of 14. This has caused concern among medical professionals, as the symptoms of HMPV can sometimes mimic other respiratory viruses, making diagnosis challenging. While the virus is not new, the current spike has brought it into the spotlight, prompting many to compare it to the early days of the COVID-19 pandemic.

Health officials in China have assured the public that HMPV is not as threatening as COVID-19. According to available data, HMPV infections represent only a small percentage of respiratory illnesses in comparison to influenza or COVID-19. Still, the sudden rise in cases has created anxiety, especially as the world is still recovering from the impact of the COVID-19 pandemic. People are worried about the possibility of another virus spreading globally, leading to disruptions in everyday life.

India has also reported isolated

India are keeping a close watch on the situation in China and monitoring for any signs of the virus spreading. The Indian government has issued guidelines to the public, advising them to practice good hygiene, avoid crowded places, and seek medical attention if they experience severe respiratory symptoms. These measures are similar to those taken during the COVID-19 pandemic, but experts emphasize that the risk of a global outbreak from HMPV is currently low.

Globally, countries are paying close attention to the developments in China. While HMPV is not new and has been a known cause of respiratory infections for over two decades, the renewed focus on it has highlighted the need for better awareness and preparedness. In many places, public health systems are still dealing with the aftereffects of COVID-19, which has made people more cautious about any potential threat from infectious diseases.

The fear of another pandemic has led some to wonder if we might face lockdowns again. Lockdowns were one of the most impactful measures during the COVID-19 pandemic, causing significant economic and social disruptions. However, health experts believe that HMPV is unlikely to require such drastic measures. Unlike COVID-19, which spread rapidly and caused severe illness in many, HMPV has a much lower transmission rate and generally causes milder symptoms. This makes it less likely to overwhelm healthcare systems or lead to widespread restrictions.

The focus now is on prevention and early detection. Good hygiene practices, such as washing hands frequently, wearing masks in crowded areas, and avoiding close contact with people showing symptoms, can help reduce the spread of HMPV. These measures are not new; they were widely promoted during the COVID-19 pandemic and remain effective for many respiratory viruses. Governments and healthcare organizations are also working on increasing public awareness about the virus, its symptoms, and ways to stay safe.

Currently, there is no specific treatment or vaccine for HMPV.

Mapping women's leadership in cities in India

n recent decades, India has witnessed the remarkable emergence of women as crucial drivers for participatory democracy. Women's participation as voters has impressively increased over the years in every election at national and state levels. Alongside women emerging as influential voters, their representation in local structures of governance, also called local self-government, is one of the highest across countries in the world. India is among the early adopters of gender quotas at the local government level, with very high participation by women in rural and urban areas. With the adoption of the Women's Reservation Bill in 2023 for national and state legislative assemblies, it is timely to assess the impact of gender quotas on India's urban self-governance institutions over the past three decades.

Women's leadership in urban governance

India's rapid economic growth has accelerated urbanisation with nearly half the population expected to reside in urban areas by 2035. With increasing urbanisation and worsening climate change, more women are expected to migrate to urban areas. Women and men use urban spaces differently and have different priorities when accessing urban services and infrastructure such as housing, transport, water and sanitation, health, and environmental resources, livelihoods, and economic opportunities. Research shows that most cities in the world fail to meet the basic needs of women, hindering their social and economic prospects, and thus widening gender gaps.

Indian cities, with challenges of inclusivity and equity, need to make concerted efforts to address the needs emanating from these demographic shifts. The increasing challenges in urban governance warrant more inclusive representation in administration to respond more effectively to evolving public needs. The 74th Constitutional Amendment Act, adopted in 1993, reserved one-third of electoral seats for women in Urban Local Bodies (ULBs) or municipalities. In the 30 years since then, 20 states have progressively raised women's representation to 50 percent in both rural and urban local bodies.

Mapping the impact Research has revealed that a sizeable number of women have served as mayors, which is the highest office in Urban Local Bodies (ULBs) in India. For instance, in Tamil Nadu, 11 out of 20 mayors in various municipalities elected in 2022 were women. An assessment of work done by women mayors shows that they have positively impacted aspects of urban governance, such as sanitation, water, cleanliness, healthcare, safety, and mobility. From the first female mayor of Madras in 1957, Tara Cherion, who is credited for slum management initiatives and introducing mid-day meals in corporation schools, to more recent instances, such



2018, and improved the water distribution network in Kanimanagalam, a region severely impacted by water scarcity and drought. Some of these women administrators belonged to politically influential families when they were elected, reinforcing the importance of social networks in gaining access to local political institutions. But in many other cases, women candidates with humble origins and limited prior exposure to politics, have been successful in winning electoral contests on their own.

Some of the state-based studies throw valuable insights into women's representation in local bodies and how many women manage to break stereotypes once elected to power. A study on ULBs in Rajasthan revealed that for women members of local bodies to shoulder administrative responsibilities effectively, having supportive families is important. Lack of experience and confidence is a persisting challenge faced by women leaders in ULBs, but many have demonstrated that they have the interest and capacity to learn on the job. A report on ULBs in Assam found that women experienced a tangible shift in their mindset, becoming more positive and self-reliant after winning seats. A study by the Jaipur Municipal Corporation revealed that women contributed to reducing gender prejudices both socially and in the municipality. Similarly, a report on the Kolkata Municipal Corporation showed that women councillors excelled in programme implementation and advancing community services and interests. Their performance often led to their re-election, even when their wards became open seats

Challenges to women in ULBs

Elected women representatives in ULBs face different barriers from those that confront their male counterparts. A major section of women who are elected to ULBs have no prior experience in politics and administration. As most party structures, especially at the local level, are still male-dominated, women's voices in decision-making structures remain limited. The persistently uneven distribution of unpaid care work between men and women due to prevailing gender norms impacts the work of women councillors and mayors who

ence is impacted by restrictive gender norms. Women councillors report facing social stigma and restrictions when they occupy positions of power. They are not considered to be assertive, knowledgeable, and able to lead well by large sections of society. The increasing influence of money and muscle power required to contest any election in India, combined with the aggression and misogyny faced by women candidates hinders their participation in politics. Reserved seat rotation every five years, aimed at inclusivity, limits women's ability to build on their experience. Elected men often pursue multiple terms, while women are dissuaded from contesting unreserved seats by parties or male household members.

Strengthening women's leadership

Studies have shown that, as representatives, women in ULBs lead to inclusive and positive outcomes by prioritising the needs of women and children and their communities. Women constituents find it easier to approach women councillors and demand resources like water and sanitation, pre-school education, and preventive health care.

A few key initiatives would go a long way in strengthening women's leadership in cities. First, a scaling up is required of capacity-building and training programmes for women addressing new challenges in urban governance like climate change resilience, environment and technology. There should be strict monitoring of the quality of these programmes. Second, establishing institutional mechanisms to ensure that women can discharge their functions without interference from male representatives, is much-needed. Awareness and sensitisation campaigns need to be conducted to help change conservative perceptions about women's participation in urban politics. Third, implementing institutional reforms that ensure political parties encourage more women to participate in local politics and provide access to skills and networks for innovative fundraising for women. As women's participation in local governance demonstrates its positive impact on policy outcomes, more concrete steps to strengthen women's

How long do menopause symptoms last?

The menopause transition usually lasts around 7 years, but symptoms may not be present all the time. However, how long menopause symptoms last can vary, and for some people they can last much longer.

According to the National Institute on Aging, the transition can take up to 14 years for some individuals.

Menopause is part of sexual maturation and is not a disease or condition, although people may experience many symptoms of menopause.

Doctors define menopause as occurring 1 year after a person's last period. Every individual experiences menopause differently, and the symptoms may vary in duration.

Duration Studies show that people typically experience hot flashes for an average of 4.5 years following their last period and 7.4 years in

total. However, they may last for more than 10 years. The extended duration of these symptoms results from the body rebalancing and reducing levels of estrogen and progesterone as the

ovaries slowly lose function. When does menopause start? Though menopause clinically occurs 1 year after the end of a person's last period, they may begin

experiencing symptoms earlier. Approximately 8 in 10 people have menopause symptoms before and after the end of their periods. Doctors refer to the year between the last period and menopause as peri-

menopause. Most people in the U.S. experience menopause between the ages of 45 and 55. However, this age range

The onset of menopause can also follow surgery that reduces ovarian function or hormones, such as a hysterectomy, where a surgeon removes the uterus, or surgery or other treatments for cancer. In these circumstances, symptoms may begin rapidly as an adverse effect of these procedures.

Symptoms

The symptoms of menopause usually start when estrogen levels begin to drop. Symptoms may include:

• Irregular menstruation: As estrogen levels drop, the menstrual cycle may change. A person may miss periods or experience more time between periods. Menstrual flow may also change

• Vaginal dryness: Decreases in estrogen levels can cause a reduction in vaginal lubrication. As lubrication decreases, the vaginal tissues also become thinner. This can lead to pain during intercourse and vaginal inflammation.

• Decreased fertility: As estrogen levels drop in perimenopause, preg- emotional changes that occur during *Today*)

nancy might become more difficult. When a person reaches menopause, their ovaries no longer release eggs, meaning that pregnancy is not pos-

• Weight gain: The metabolism tends to slow during menopause, which may cause sudden weight changes

• Hot flashes: Fluctuations in hormone levels might lead to hot flashes or an abrupt feeling of heat and flushing. These flashes may be mild, occurring primarily in the upper body, or they may radiate throughout the body

 Night sweats: Hot flashes during sleep cause night sweats, which may prompt such intense sweating that

they wake a person up.
• Sleep disturbances: Menopause often makes it hard to sleep. Many find that sleep disturbances occur more often around the time of menopause. The disturbances may be related to night sweats.

• Low mood: Some experience mood changes during menopause. These may be due to hormonal fluctuations, but life circumstances that tend to occur around menopause can also contribute.

• Attention problems: Many people find they have difficulty concentrating and focusing during menopause and might experience memory lapses.

• Thinning skin and hair: Extreme fluctuations in hormone levels might cause the skin to become thinner. Some people may experience hair

• Urinary frequency and incontinence: Around menopause, people may experience an increase in the frequency of passing urine due to weakening of the pelvic floor mus-

Treatment options

Menopause does not require medical treatment, as it is not a medical condition, but many seek relief from its uncomfortable symptoms.

Hormone replacement therapy Hormone replacement therapy (HRT) can help relieve menopauserelated hot flashes and other general symptoms. However, HRT does carry a small risk of breast and ovarian cancer.

Due to this, doctors often prescribe the lowest dose of estrogen possible to relieve symptoms.

Aside from relieving hot flashes, HRT can help prevent bone loss and

osteoporosis. Other treatments

Many other treatments are available that alleviate symptoms and prevent issues related to aging.

Other options include: • Medications to treat hot flashes: Low-dose antidepressants and some anti-seizure medications may help decrease hot flashes. Antidepressant medications may also assist with the

• Vaginal estrogen: Estrogen is available for direct application to the vagina in the form of a cream, tablet, or inserted ring. This can help relieve dryness and discomfort during

· Medications to prevent osteoporosis: Some doctors prescribe medications to prevent the loss of bone density that can occur during perimenopause and menopause.

When to contact a doctor

At the onset of perimenopause, a person may wish to schedule regular doctor visits for preventive health-

Around perimenopause, doctors may recommend certain health screenings that sometimes include a colonoscopy, mammogram, and blood tests.

An individual should not hesitate to seek a doctor's care and advice to deal with disruptive menopausal symptoms. If vaginal bleeding occurs after menopause, a person

should also seek medical attention. Outlook after menopause

The risk of some conditions increases after menopause, including: · Cardiovascular disease: As estrogen levels decline, the risk of heart

• Osteoporosis: Osteoporosis is a condition that causes bones to weaken, increasing the risk of fractures. For the first years after menopause, people lose bone density very rapidly. This increases the risk of osteoporosis and breaks.

 Certain cancers: The risk of breast and ovarian cancer rises after menopause. The reasons vary but may be due to hormonal changes related to menopause and its treatments or natural aging.

Most people continue to enjoy a healthy life throughout menopause, however. They can further ensure this by maintaining a balanced and nutritious diet, exercising, and regularly checking in with a doctor.

Menopause symptoms typically last for around 4 years after a person's last period. However, the frequency, severity, and duration of symptoms vary.

(UNCCD) in Riyadh, Saudi Arabia. A consensus was reached at the UNCCD COP15 in Abidjan, Côte d'Ivoire that the Gender Caucus was an effective platform to strengthen and accelerate gender conversation, policy, programme and agenda and hence the Convention's initiative to effectively implement the Gender Action Plan (GAP) at international and country level.

Convention to Combat Desertification

The Gender Caucus was established and convened at UNCCD COP14 in New Delhi in 2019, comprising of Parties, selected UN agencies and civil society organisation partners, to provide expert guidance on how to focus strategies on gender issues in drought, land degradation and desertification.

It was the adoption of the GAP at UNCCD COP13 in China's Ordos in 2017 that acknowledged a specific role for women in land restoration and sustainable land management, the importance of gender equality as a guiding principle in all policies and decisions associated to the fulfilment of the objectives of the Convention.

In 2022, a study commissioned by UNCCD and titled The differentiated impacts of desertification, land degradation and drought on women and men delved into why desertification is not gender-neutral.

"Women are major actors in the global efforts to reduce and reverse land degradation. They restore land, they protect land, they cherish, nourish and care for the land, while also caring for others," Ibrahim Thiaw, under-secretary-general and executive sec-

France marks 10 years since deadly Charlie Hebdo attacks

PARIS, Jan 7: A decade after gunmen stormed the offices of satirical newspaper Charlie Hebdo in a deadly assault that shook France to its core, the nation is pausing Tuesday to honour the victims and grapple with the evolving challenges of free expression and terrorism.

President Emmanuel Macron and Paris Mayor Anne Hidalgo are leading solemn tributes at the site of the attack, where 12 people, including some of France's most beloved cartoonists, were killed on January 7, 2015. Among those remembered was Ahmed Merabet, a police officer who was gunned down on the street while defending the newspaper.

The massacre, carried out by two brothers claiming allegiance to al-Qaida, marked the start of a grim new era for France, with a wave of extremist violence pushing the country to reassess its security priorities and commitment to free speech.

Speaking on the anniversary, Interior Minister Bruno Retailleau painted a stark picture of France's current security landscape.

"France has rearmed considerably, but the threat is still there," he warned in an interview with RTL, referencing both external dangers and a troubling rise in homegrown radicalisation.

"The nature of the threat has changed," Retailleau explained. "It is now primarily endogenous individuals radicalised through social media. Last year alone, our services foiled nine attacks, the highest number since

Retailleau cited recent attacks at public gatherings in Germany and New Orleans as grim reminders of why France must maintain a "very high level of caution.'

The attack on Charlie Hebdo, carried out in retaliation for the newspaper's irreverent caricatures of the Prophet Muhammad, ignited fierce global debates about the limits of free expression.

In the days that followed, millions marched in solidarity, brandishing pens and signs declaring, "I am Charlie" — a rallying cry for press freedom and defiance against extremism.

But 10 years on, the unity of that moment has splintered. French commentators say younger generations are increasingly critical of satire they see as divisive or insensitive, particularly toward marginalised communities. Charlie Hebdo itself remains unapologetic. Its 10th-anniversary edition features a cover cartoon of a reader perched on an AK-47, captioned "Indestructible." Chinese tech giants Tencent, CATL and others protest US listings as army-linked companies

Defence Department has added dozens of Chinese companies, including games and technology company Tencent, artificial intelligence firm SenseTime and the world's biggest battery maker CATL, to a list of companies it says have ties to China's military, prompting some to protest and say they will seek to have the decision reversed.

The US has in recent years sought to restrict sharing of advanced technology, including semiconductors and artificial intelligence, deeming it to be a threat to national security. The Defence Department updates its list of "Chinese Military Companies," or CMC list, annually. With the latest revision it includes 134 companies.

The National Defence Authorisation Act of 2024 bans the Department of Defence from dealing with the designated companies beginning in June 2026.

Tencent's Hong Kong-traded shares fell 7.3 per cent on Tuesday and the company said it would "initiate a reconsideration process to correct this mistake," seek talks if need be take legal measures to get it removed from the list. Tencent is the world's largest video gaming company and operates Chinese messaging platform WeChat.

"As the company is neither a Chinese military company nor a military-civil fusion contributor to the Chinese defence industrial base, it believes that its inclusion in the CMC List is a mistake," Tencent said in an announcement to the Hong Kong Stock Exchange. "Unlike other lists maintained by the US Government for sanctions or export control measures, inclusion in the CMC List relates only to US defence procurement, which does not affect the business of the Group," it said.

Battery maker CATL said in a statement posted on its website that the company "has never engaged in any military-related business or activities" and said the designation would not have adverse impact on its operations.

Like Tencent, CATL maintains that its inclusion to the list was a "mistake" and that it would proactively engage with the DoD to "address the false designation" and take legal action if necessary to protect company and stakeholder interest. CATL's stock fell 2.84 per

AI company SenseTime said in a statement that the decision to include it on the list had "no factual

"We firmly disagree with it," SenseTime's statement read, adding that the decision has "no material impact on our global operations."

"SenseTime remains firmly committed to working collaboratively with the relevant stakeholders to address this matter, and to safeguarding the interests of the company and our shareholders," the company said.

During a daily news briefing, Ministry of Foreign Affairs spokesperson Guo Jiakun urged the US to "immediately correct its wrong practices, and lift the illegal unilateral sanctions and long-arm jurisdiction on Chinese compa-

Indonesia, Japan agree to resume stalled talks on transfer of defence equipment



JAKARTA, Jan 7: Indonesia's government said it agreed with Japan on Tuesday to resume talks on the joint development of naval vessels that have stalled in recent

Visiting Japanese Defence Minister Gen. Nakatani discussed ways to deepen a defense partnership with his Indonesian counterpart, Sjafrie Sjamsoeddin, in a meeting Tuesday and agreed to continue negotiations on joint development of naval ships and other military equipment and on technology transfer, Defence Ministry spokesperson Brig. Gen. Frega Wenas said.

"In principle, both defence ministers welcomed cooperation on promoting military equipment," Wenas said. "Of course, it needs to be explored further where the joint development would occur and whether it would involve ships or other defence equip-

Japan is unable to export finished frigates or submarines under its current guidelines on transfer of defence equipment and technology, and it is believed that joint development is the most feasible way to make transfers.

Japanese media said Nakatani, who arrived in Jakarta on Sunday for an Indonesia-Japan defence ministerial meeting, would present a proposal for joint development of destroyers that stalled in recent years.

The Japanese government is envisioning frigates based on its Monogami class design, in which President Prabowo Subianto earlier showed interest when he was defence minister. The ships can be operated by a crew of about 90, half the number of conventional

However, negotiations stalled under former President Joko Widodo as the Indonesian government invested huge amounts in the relocation of its capital, Japan's Kyodo News agency re-

Tokyo has also proposed joint development of Monogami class frigates with Australia and Germany, and Canberra is expected to make a final decision on the partnership in the second half of this

Nakatani declined to comment to the media after his meeting with Sjamsoeddin. He said in a statement ahead of the talks that he hoped to deepen defence engagement with Southeast Asia's largest economy.

"Southeast Asian countries are in a strategically important region and occupy key points on our sea lanes," Nakatani said, "I would like to take this visit as an opportunity to further develop our cooperative relationship with Indonesia.

Japan's Defence Ministry said in a statement Tuesday that the two ministers agreed to establish consultations on mutual maritime security, including defence equipment and technology cooperation.

Defence is considered to be one of Subianto's priorities. He wants to strengthen the military by buying submarines, frigates and fighter jets and plans to increase defense cooperation with other countries.

Nakatani is to pay a courtesy call on Subianto before returning to Tokyo on Wednesday.

His visit is also expected to help lay the groundwork for a meeting between Subianto and Japanese Prime Minister Shigeru Ishiba later this week. (AP)

UAE agrees to rollover **USD** 2 billion payment in Jan: PM Sharif

ISLAMABAD, Jan 7: Prime Minister Shehbaz Sharif on Tuesday said the UAE has agreed to rollover the payment of USD 2 billion that Pakistan was due to pay this month.

Addressing the cabinet meeting, the prime minister mentioned that United Arab Emirates (UAE) President Mohamed bin Zayed conveyed this decision to him during a one-on-one meeting in Rahim Yar Khan over the weekend.

The UAE president was on a private visit to Rahim Yar Khan, a city in Punjab province, but also met Sharif on the occasion.

"He happily informed me that USD 2 billion owed by Pakistan in January was being extended by the UAE. He proposed it himself and immediately issued [directives as well]," Sharif said. Pakistan's foreign exchange reserves have gone up from USD 2.7 billion to USD 11.7 billion in the last two years and while external public debt stood at USD 100 billion two years ago, it currently stands in the same position, accord-

Though the prime minister didn't give the period of extension, the rollover of such a loan is often for one year. Both the UAE and Saudi Arabia regularly extend bilateral payments to help Pakistan tackle its balance of payment

The Prime Minister also told the cabinet that his meeting with the UAE President focused on strengthening bilateral relations and promoting investment, adding that the UAE leader expressed his commitment to investing in Pak-

Earlier in December, Saudi Arabia had extended USD 3 billion debt repayment period for Pakistan for another year after the cash-strapped nation could not pay the debt, the country's central bank had said when the term of the deposit

Over 22,000 bureaucrats in Pakistan

possess dual nationality: Report

ISLAMABAD, Jan 7: In a surprising development, a National Assembly (NA) panel was informed that over 22,000 bureaucrats in Pakistan possess dual nationality, raising concerns about national security. As the NA's standing committee on Interior met on Monday with Raja Khurram Nawaz in the chair, members sounded alarm over the practice and called for stringent measures to restrict the practice, especially for bureaucrats, judges and members of the parliamentarians, according to The Express Tribune newspaper.

The meeting was deliberating on the proposed legislation that would grant Pakistani passports to citizens of countries with which Islamabad has dual nationality agreements.

During the meeting, it was also revealed that 22,000 bureaucrats hold dual citizenship.

Committee member Abdul Qadir Patel expressed surprise that while members of the National Assembly and judges were prohibited from holding dual citizenship, bureaucrats were not. He proposed that the bill should include a provision to ensure that individuals with dual nationality should not be appointed as bureaucrats.

Patel also challenged the argument that politicians are not given dual citizenship due to the need to safeguard state secrets.

Agha Rafiullah of Pakistan Peoples Party (PPP) demanded detailed statistics on Pakistani citizens holding dual nationality, including how many have renounced their foreign citizenship and whether NADRA, the official registration body, possessed cials have said they do not have any evidence data on which countries these individuals were afthat the virus is spreading from person to perfiliated with.

The committee member also raised concerns about the relaxation of dual nationality rules, citing the example of the chairman of NAB (National Accountability Bureau), the top anti-corruption body, reported the paper.

Pakistan allows dual nationality with certain countries like the US, but it is forbidden for those in the armed forces, parliamentarians and judges of superior court. Concerns have been expressed often for bureaucrats with dual nationalities holding high positions. Still, no step has been taken as they are powerful people with the right connections. (PTI)

Taiwan holds military drills as concerns rise over possible defence budget cut

HSINCHU (TAIWAN), Jan 7: 542 Armored Brigade in Hsinchu Taiwan began three days of military drills on Tuesday as concerns rose over potential cuts to the defence budget due to legislative wrangling between the island's two major political parties.

The drills began in the north with tank maneuvering at a base in Hsinchu featuring outmoded CM-11 tanks, which are gradually being replaced by newly purchased Abrams M1A2T from the US.

The replacement marks a huge upgrade despite some complaints over the weight of the new tanks and their likely effectiveness at preventing a possible Chinese landing.

Troops arrived on armoured personnel carriers, while Apache and S-70 helicopters whirled overhead, providing reconnaissance and cov-

With the equipment Taiwan currently operates, the communication officer is on the ground to coordinate airborne attacks, said Army Captain Chuang Yuan-cheng of the county just south of the capital of Taipei. That allows them to guide the helicopters so that "ground fire and airborne fire are synchronised,'

On Wednesday, the army will show off its Patriot III anti-missile vstem aimed at countering one of China's most potent weapons against the island of 23 million.

And on Thursday, anti-submarine exercises will be held off of Taiwan's largest port of Kaohsiung. considered China's best conduit for resupplying its troops should it establish a beachhead in the heavily defended region.

The annual drills are held in the run-up to the Lunar New Year holiday to reassure the population of Taiwan's ability to meet China's threats and to boost recruitment. Taiwan has a backlog of orders from the US for about USD 20 billion in weapons systems, while it upgrades its M-16 fighters and de-

New Orleans attack came as FBI was facing political heat, bracing for transition

WASHINGTON, Jan 7: Joining law enforcement officials to update the public in the hours after a man killed 14 people and injured dozens of others in New Orleans, Louisiana's junior Republican senator, John Kennedy, implored the FBI to "catch these people" — and then added one more eyebrow-raising request of the federal government. "After we get to the bottom of this," he said, "they need to tell the American people the truth."

The comment appeared to allude at least in part to an FBI official's erroneous assertion hours earlier that the Bourbon Street rampage was "not a terrorist event," a misstep the FBI tried to clean up with a follow-up statement that said the bureau was indeed investigating the Islamic State group-inspired attack as "an act of terrorism."

But more broadly, the suggestion that federal officials might obscure the truth of the investigation, and Kennedy's warning that he would "raise fresh hell" if they did, reflected the uneasy position the FBI had already found itself in by the time of last week's attack: buffeted by suspicion and public criticism from lawmakers, especially allies of President-elect Donald Trump, and bracing for a leadership change expected to produce dramatic upheaval at the nation's premier federal law enforcement agency.

"When the rubber meets the road, what really matters is that even in spite of all of this noise — and that's all it is, is noise — the bureau goes about doing its job on a dayto-day basis," said Frank Montoya Jr., a retired FBI counterintelligence executive.

The attack by Shamsud-Din Jabbar that killed 14 took place in the waning days of the Biden administration and just over two weeks before FBI Director Christopher Wray plans to resign his position to make way for Trump's pick, Kash Patel.

It follows a turbulent stretch in which the bureau has faced an escalating threat of international and domestic terrorism and has also been at at the centre of politically explosive national security investigations involving both Trump and President Joe Biden that have put the FBI and Justice Department on the defensive and their decision-making

under scrutiny. The attack, the deadliest assault on US soil in years inspired by the Islamic State group, is certain to make counterterrorism and national security core topics of discussion at Patel's yet-to-be-scheduled confirmation hearing before the Senate Judiciary Committee

tional security prosecutor, Patel has appeared repeatedly on podcasts before he was selected as director, where he's spoken of his belief that the FBI needed a major overhaul. But he's been less specific about how as director he would protect the homeland.

One area he has discussed is significant reforms on how agents and analysts make use of Foreign Intelligence Surveillance Act eavesdropping powers in national security investigations. He has spoken also of a desire to break out the FBI's "intel shops" from the rest of its crime-fighting activities.

A person familiar with Patel's positions who has sat in on his meetings with senators and who spoke to The Associated Press on condition of anonymity to discuss private conversations said Patel wants to ensure "there's better intel-sharing across agencies" but is not calling for the elimination of spy powers.

The FBI has long characterised protecting the homeland from terrorist attack as its top priority, and Wray has been proactive in sounding the alarm about a rising threat inspired in part by the turmoil in the Middle East following the October 7, 2023, attacks by Hamas on Israel. (AP)

Jaahnavi Kandula fired from department SEATTLE/NEW YORK, Jan 7: In a significant development, a Seattle police officer who killed Indian student Jaahnavi Kandula in January 2023 when the patrol vehicle he was driving struck her, has

been fired from the police department, officials said. Kandula, 23, from Andhra Pradesh, was struck by a police vehicle driven by Officer Kevin Dave when she was crossing a street in Seattle on January 23, 2023. He was driving 74 mph (more than 119 km/h) on the way to a report of a drug overdose

Kandula was thrown 100 feet when she was struck by the speeding police patrol vehicle.

According to a report in The Seattle Times on Monday, Interim Seattle Police Chief Sue Rahr said that she had fired Dave from the Seattle Police Department.

The report, citing an email sent by Rahr to employees, said she fired Dave on Monday after the Seattle Office of Police Accountability found he had violated four department policies. "I believe the officer did not in-

tend to hurt anyone that night and that he was trying to get to a possible overdose victim as quickly as possible," Rahr said.

"However, I cannot accept the tragic consequences of his dangerous driving. His positive intent does not mitigate the poor decision that caused the loss of human life and brought discredit to the Seattle Police Department," according to the Seattle Times report.

It added that the policies Dave failed to follow "include using emergency lights for an emergency response and being responsible for safely operating a patrol vehicle", according to the copy of Rahr's

The development comes months after another Seattle police officer Daniel Auderer was fired following his insensitive comments and



laughter after Kandula's death. The Consulate General of India

in Seattle had been working consistently with authorities and law enforcement officials to ensure justice in the case, with Auderer's firing and now the action against Dave bringing a sense of closure and justice for Kandula's family.

The Consulate had been in regular touch with Kandula's family representatives and had said that it would continue to extend all possible support in ensuring justice for Jaahnavi and her family.

In a February 2024 post on X, the Indian Consulate in Seattle said that "On the recently released investigation report of the King County Prosecution Attorney on the unfortunate death of Jaahnavi Kandula, Consulate has been in regular touch with the designated family representatives and will continue to extend all possible support in ensuring justice for Kandula and her family.

"We have also raised the matter strongly with local authorities, including Seattle Police for appropriate redress. The case has now been referred to the Seattle City Attorney's office for review. We await completion of Seattle Police's administrative investigation and will continue to monitor progress on the case."

Rahr was appointed as interim chief in May 2024 and in July last vear, she had announced Auderer's firing. However, decision about Dave's action came in only now.

In bodycam footage released by the Seattle Police Department, Auderer was heard laughing after the deadly crash and had remarked "Uh, I think she went up on the hood, hit the windshield, and then when he hit the brakes, flew off the car...But she is dead."

After making these comments, Auderer "laughed hard for four seconds," the department's Disciplinary Action Report said. (PTI)

AGARTALA, Jan 7: The Tripura Human Rights Commission (THRC) has issued a notice to ILS Hospital in Agartala, seeking its response to allegations of negligence raised by former minister Gopal Chandra Das. The Commission took suo motu cognizance of the issue following reports in local newspa-

According to the reports, Gopal Chandra Das alleged negligence in the treatment of his wife, Saraswati Deb (Das), who was undergoing care for kidney-related ailments. A surgery had been performed on her at ILS Hospital on September 14, 2023, by nephrologist Dr Samaresh Paul and surgeon Dr Kanak Narayan Bhattacharjee. After a few dialysis sessions, she was discharged from the hospital.

The issue arose on December 23, 2023, non-functional. Gopal Chandra Das took his Hospital and Gopal Chandra Das, demanding wife back to ILS Hospital to address the their responses to the claims

issue. The hospital allegedly charged ₹ 5,510 for cleaning the cath line, but after admitting Saraswati Deb, they reportedly discharged her without performing the required procedure. Consequently, she had to return to GBP Hospital, where it was confirmed that the cath line had not been cleaned by ILS Hospital despite the payment.

The THRC noted that the allegations suggest a prima facie case of human rights violation. In its order, the Commission stated, "The allegations reported in the news appear to involve neglect on the part of ILS Hospital. Therefore, the Commission has directed the hospital authorities to provide a written explanation regarding the claims. Additionally, notice has been issued to Gopal Chandra Das to record his statement in connection with the allegations." The Commission has

Abuse me or call me Dawood, but help Delhi farmers: Chouhan to CM Atishi



NEW DELHI, Jan 7: Agriculture Minister Shivraj Singh Chouhan on Tuesday urged Delhi Chief Minister Atishi to implement central government farmer welfare schemes in the national capital, saying he was willing to weather personal attacks if it benefits Delhi's farming community.

"Abuse me or call me Dawood, it does not make any difference to me, but implement the farmer welfare schemes of the Government of India for the farmers of Delhi, give them the benefit of the schemes," Chouhan said in a meeting with a group of Delhi-based farmers

He requested the Delhi CM to submit proposals immediately and take central funds for implementation of the central schemes.

Chouhan's reference to Dawood Ibrahim, the notorious gangster, appeared to be a response to previous criticisms from Delhi's leader-

"I don't mind if you abuse me, but give the benefits of the schemes to the farmers... It is not in my nature to abuse anyone. With folded hands request you to implement the schemes," he said.

Several central government schemes meant for farmer welfare have faced implementation hurdles in Delhi, the minister said, adding that he had written to Delhi CM flagging this issue recently.

"I am saying with great pain that the farmers of Delhi are not getting the benefit of many schemes of the central government. Farmers are not getting the benefit of subsidy being provided by the Centre," he

The implementation of central government agricultural schemes in Delhi has been a point of contention between the Centre and the Delhi government. Several farmers at the meeting highlighted their exclusion from crucial programmes available in neighbouring states.

Captain Kanwarlal Dagar, former national president, Bharatiya Kisan Union, said, "The farmer of Delhi, once considered the king of India, has become the most backward in the country, despite three master plans implemented over the

Formula E race case: Telangana HC finds prima facie irregularities, refuses to quash FIR against KTR

HYDERABAD, Jan 7: In a setback to BRS Working President K T Rama Rao, the Telangana High Court on Tuesday refused to quash the FIR against him in connection with the Formula E race issue, removing the protection against the arrest given to him.

On December 31, 2024, the HC had reserved its orders on the petition filed by the former minister after hearing the arguments made by the state government as well as the defence in the case registered by the Anti- Corruption Bureau (ACB) which alleged that Rama Rao authorised payments to the tune of ₹ 55 crore, most of it in forex, to Formula E Organisation without necessary approvals.

High Court Judge Justice K Lakshman in his order said the allegations indicate that Rama Rao without any approval from the State Cabinet or the finance department directed the HMDA (Hy-Metropolitan Development Authority) to pay huge sums of money to a foreign

Will detoxify myself, go to Himalayas: CEC Rajiv Kumar on post-retirement plans

tion Commissioner (CEC) Rajiv Kumar on Tuesday revealed his intention to "detoxify" himself and spend several months in solitude in the Himalayas post his retirement next month.

Responding to a question while addressing a presser to announce the Delhi Assembly elections, he shared his post-retirement plans with an introspective touch.

"I will detoxify myself for the next four-five months, go to the deep Himalayas, be away from the glare of all of you. I need some 'ekant' (solitude) and 'swadhyay' (self-study)," Kumar, who is set to retire on February 18, said.

In October last year, Kumar was rescued from the remote Ralam village in Uttarkhand's Pithoragarh district following an emergency helicopter landing due to inclement weather and left stranded at over 12,000 feet.

Kumar, a 1984-batch IAS officer from the Bihar/Jharkhand cadre, also shared a personal aspi-



ration to give back to society by teaching underprivileged children. He recounted his humble beginnings, studying in a municipal school where classes were held

under a tree "I started learning ABCD in the 6th class. We carried a slate and sat under a tree to study. As a passion, I want to go back to those roots and teach such children," he

Before his appointment as CEC, Kumar held several key positions, including finance secretary and chairman of the Public Enterprises Selection Board. As finance secretary, he spearheaded significant reforms, such as bank mergers, recapitalization of public sector banks, and the crackdown on shell

SC refuses to hear Maneka Gandhi's plea against 45-day cap for filing election petition

NEW DELHI, Jan 7: The Supreme Court on Tuesday refused to entertain a plea of former union minister Maneka Gandhi against the 45-day limitation imposed for filing an election petition under the law saying court cannot legislate and open floodgates.

A bench of Justices Surva Kant and N Kotiswar Singh, however, issued notice on Gandhi's plea challenging Samajwadi Party's Ram Bhual Nishad's election from the Sultanpur Lok Sabha seat in 2024, and sought his reply in four weeks.

Section 81 of the Representation of the People Act prescribes the period of 45 days from the date of the election of a returned candidate within which an election petition can be filed.

BJP's Gandhi lost to Nishad by 43,174 votes in the 2024 Lok Sabha elections

"We don't want to open the floodgates. We are not inclined to entertain the petition as you want us in a way to legislate, which we cannot do. You want us to declare the 45-days limit is bad in law. You want us to fix 60 days or 90 days either way you want us to legislate which cannot be done," the bench

advocate Siddharth Luthra, appearing for Gandhi, withdrew the plea which sought a revisit of the 1973 Hukumdev Narain Yadav judgement directing election pleas to strictly adhere to the timelines and procedures under the Representation of the People Act.

Luthra said the law should be revisited in the context of a person who suppressed material facts of four criminal cases.

He submitted his client was not seeking the court to legislate, but only saying the 1973 verdict was bad in law and needed a revisit.

The bench said the petitioner couldn't make the submission that a particular judgement was bad in law in a writ petition and could only do it in a civil appeal, where the

verdict was relied upon.

"If we start interfering with the prescribed limit, then look at the consequences. It will defeat the very purpose of legislation," the bench told Luthra.

The top court had told Gandhi

prescribing 45-day time limit was a matter of policy and it had to see the legislative intent for fixing such a limit. "This was perhaps done so that there is no uncertainty on the election of the returned candidate,' the top court had said.

Gandhi challenged the August 14 2024 order of the Allahabad High Court dismissing her election petition against Nishad's election observing it was time-barred.

The high court's Lucknow bench held the petition was filed after the 45-day deadline and it couldn't be heard on merit.

She contended Nishad deprived the voters of their right to know his full criminal history and the delay in filing the petition should be con-

Gandhi argued 12 criminal cases were pending against Nishad but he disclosed only eight in his affidavit.

"The election petition being time-barred by Section 81 read with Section 86 of the Representation of People Act 1951 and Order VII Rule 11(d) of the Code of Civil Procedure is liable to be dismissed.' held the high court. (PTI)

Maharashtra govt makes FASTag mandatory at all toll plazas from April 1

MUMBAI, Jan 7: The Maharashtra cabinet on Tuesday decided to make toll collection through FASTag mandatory from April 1 and announced revisions in the Rules of Business to streamline administrative processes.

The cabinet chaired by Chief Minister Devendra Fadnavis approved the public works department's proposal that toll collection at toll plazas across the state will be done exclusively through FASTag from April 1.

It also approved amendments to the Public-Private Partnership Policv 2014 to facilitate this change. FASTag is India's electronic toll collection chip for national high-

The move is expected to bring efficiency and transparency to toll collection and reduce vehicle congestion at toll plazas. It will save time and fuel for commuters, a government statement said.

It also stated that vehicles without FASTag or those entering the dedicated lanes without proper tags will have to pay double the

At present, tolls are being collected at 13 road projects under the public works department and nine projects managed by the Maharashtra State Road Development Corporation. The decision will apply to these and all future toll projects in the state, the statement

In another decision, the cabinet approved the revised Maharashtra Government Rules of Business to make administrative functioning smoother and more efficient.

According to the government statement, the revisions include

After the governor's approval, the revised rules will be published in the official gazette. NEW DELHI, Jan 7: The Supreme Court on Tuesday agreed to examine on February 11 issues over the age bar for surrogate mothers and others under the laws. A bench comprising Justices B

V Nagarathna and Satish Chandra Sharma, which heard about 15 petitions challenging certain provisions of the Surrogacy Regulation Act and the Assisted Reproductive Technology (Regulation) Act, 2021, asked the Centre to file its written submissions in the case.

Additional solicitor general Aishwarya Bhati, representing the Centre, said she would file the written submissions and the government would abide by the apex ourt's directions.

The court underscored the need pass an interim order in the case. The 2021 surrogacy laws set age limits for intended parents and surrogate mothers. According to the law, the intended mother must be between 23 and 50 years of age, and the intended father must be be-

tween 26 and 55 years of age. Further, the surrogate mother must be married and between 25 and 35 years of age, having a biological child, and only act as a sur-

rogate once in her lifetime. The laws also provide condi-

tions to regulate surrogacy. The top court had outlined the importance of safeguarding the in-On deletions, Kumar clarified terests of surrogate mothers, obthat they are processed only serving the need for a robust system to prevent exploitation, especially given commercial surrogacy was prohibited in India.

Bhati said the laws currently permitted only altruistic surrogacy, in line with the objective of banning commercial surrogacy, and assured the court of the government's willingness to consider suggestions.

While altruistic surrogacy was commendable, the lack of adequate compensation mechanisms for surrogate mothers posed significant challenges, petitioners said.

One of the petitioners said the existing provisions only covered medical expenses and insurance and was inadequate.

Dr Arun Muthuvel, a Chennaibased infertility specialist, is the lead petitioner and has challenged the constitutional validity of the

His plea said the laws were "discriminatory, exclusionary, and arbitrary in nature" which denied agency and autonomy in the discourse on reproductive justice, providing a state-sanctioned notion of the ideal family and restricting reproductive rights.

Other petitions raised similar concerns, such as the exclusion of unmarried women from the ambit

Chief Secretary Chandra Bhushan Kumar himself handed over voter ID cards to the members of the Jarawa tribe, also one of the Particularly Vulnerable Tribal Groups, at their settlement in Jirkatang in South Andaman dis-

Historically, the Jarawas remained isolated from outside contact, preserving their unique cultural practices and traditions. They inhabit the western coasts of South and Middle Andaman Islands, a region rich in biodiversity that supports their traditional way of life.

The first significant friendly contact with the Jarawas occurred in April 1996, marking a turning point in their interaction with the outside world. This event was initiated when Enmei, a 21-year-old Jarawa tribesman, suffered a serious fracture in his left ankle.

"The administration provided him with medical treatment, and after his recovery, he was safely returned to his settlement. This incident was pivotal in fostering mutual trust and respect between the Jarawas and the administration," Sharma said. (PTI)

England urged to boycott Champions Trophy game against Afghanistan by UK politicians

LONDON, Jan 7: England should refuse to play the Champions Trophy cricket match against Afghanistan next month according to a letter signed by

more than 160 U.K. politicians. The politicians want the England and Wales Cricket Board to take a stand against the Taliban regime's assault on women's rights and boycott the men's oneinternational Afghanistan in Lahore, Pakistan, on Feb. 26.

Female participation in sport has effectively been outlawed since the Taliban's return to power in 2021, a move that puts the Afghanistan Cricket Board in contravention of International Cricket Council rules.

Because Afghanistan's men are still allowed to compete by the ICC, a strongly worded letter has emerged from the U.K. parliament pleading for the ECB to make its own moral objection. Penned by Labour MP Tonia Antoniazzi and signed by a crossparty group from the House of Commons and House of Lords including Nigel Farage and Jeremy Corbyn, it raises the "insidious dystopia" unfolding in Afghanistan.

The statement, addressed to ECB chief executive Richard Gould, concludes: "We strongly urge the England men's team players and officials to speak out against the horrific treatment of women and girls in Afghanistan under the Taliban.

"We must stand against sex apartheid and we implore the ECB to deliver a firm message of solidarity and hope to Afghan women and girls that their suffering has not been overlooked."

Gould issued a swift response, reaffirming ECB principles while suggesting it favoured a uniform approach from all member nations rather than acting alone. "The ECB strongly condemns the treatment of women and girls in Afghanistan under the Taliban regime," he said.

"The ICC constitution mandates that all member nations are committed to the growth and development of women's cricket. In line with this commitment, the ECB has maintained its position of not scheduling any bilateral cricket matches Afghanistan.

"A coordinated, ICC-wide approach would be significantly more impactful than unilateral actions by individual members.

"We understand the concerns raised by those who believe that a boycott of men's cricket could inadvertently support the Taliban's efforts to suppress freedoms and isolate Afghan society. It's crucial to recognise the importance of cricket as a source of hope and positivity for many Afghans, including those dis-

India to host top javelin competition with Neeraj and best in world

Olympic gold and silver medallist Neeraj Chopra will headline a star-studded global javelin competition which India will host most likely in September, the Athletics Federation of India (AFI) announced on Tuesday.

This event is in addition to a slew of competitions India has expressed its interest to host, including the marquee 2029 World Championships.

Outgoing AFI president Adille Sumariwalla confirmed that India has expressed interest to host the 2029 World Championships, as well as the 2027 World Relays. The AFI has already submitted its expression of interest to host the 2028 World Junior Championships when the international body chief Sebastian Coe visited the country in November last.

"There will be a top javelin competition in India in which the top-10 javelin throwers in the world will compete. This will be an invitation tournament to be held later this



12-year tenure as AFI chief ended on Tuesday, said on the first day of the AFI An-General Meeting (AGM).

"Neeraj Chopra will be there. He is part of the team that is organising the event, along with JSW, a foreign

year," Sumariwalla, whose firm and the AFI are together creating this competition. This is being done as there is so much interest in javelin with August 7 -- when Chopra won the Tokyo Olympics gold -- being observed as National Javelin

that the event is most likely to be held in September. Just before the start of the

Largest-ever Indian contingent to feature at India Open Super 750

NEW DELHI, Jan 7: Star China Masters, will lead India's shuttlers Lakshya Sen and PV Sindhu will headline host India's largest-ever contingent of 21 players at the Yonex-Sunrise India Open Super 750 badminton tournament, starting here from January 14.

With top stars like Olympic champions Viktor Axelsen, An Se Young, and world No. 1 Shi Yuqi leading the field, top-tier action is expected at the Indira Gandhi Stadium.

Axelsen, a 2023 finalist, had withdrawn from the last edition after falling sick while playing in the Malaysia Open.

A total of 21 Indian players, including three men's singles, four women's singles, two men's doubles, eight women's doubles, and four mixed doubles pairs, will compete in the USD 950,000 BWF World Tour event, which offers 11,000 ranking points for the champions.

With so many Indian players competing in a Super 750 event, it's a remarkable sign of the growth and rise of Indian badminton on the world stage," Sanjay Mishra, General Secretary, Badminton Association of India, said in a release.

"This is just the beginning— 2025 promises to be a year where more names will feature alongside the established names, while fresh faces will emerge and shine bringing glory and pride to India."

The tournament, which was elevated to Super 750 category in 2023, saw India field 14 entries in the past two editions, and India's highlights were Chirag Shetty and Satwiksairaj Rankireddy reaching the men's doubles final and HS Prannoy making the men's singles semifinals in 2024. Chirag and Satwik, semifinalists at the 2024

Djokovic says he still feels 'trauma' when he travels to Australia because of his deportation

MELBOURNE, Jan 7: Novak Djokovic said he still feels "a bit of trauma" when he travels to Australia, stemming from his deportation in 2022 because he was not vaccinated against COVID-19.

The last couple of times that I landed in Australia, to go through passport control and immigration, I had a bit of trauma from three years ago," Djokovic said in an interview with Melbourne's Herald Sun newspaper published Monday, ahead of the Australian Open. "And some traces still stay there when I'm passing passport control, just checking out if someone from immigration zone is approaching.'

Djokovic, who has won 10 of his 24 Grand Slam championships at Melbourne Park, continued: "The person checking my passport — are they going to take me, detain me again or let me go? I must admit I have that feeling."

Back in 2022, Djokovic sought, and initially obtained, an exemption that would allow him into the Australian Open and the country — even though there were strict rules requiring shots to protect against the coronavirus. But after his flight landed, he was detained at the airport, his visa was canceled and he was sent to an immigration hotel. A judge later reinstated the

visa and ordered Djokovic's release, ruling he wasn't given enough time to speak to his lawyers. Australia's immigration minister then took away the visa again, based on "public interest." Djokovic's appeal of that ruling was denied by a threejudge panel, and he was deported. He faced a possible three-year ban from the country as someone whose visa was revoked, but Australia had a change of government, its pandemic border rules changed and a new immigration minister granted Djokovic a visa in 2023 - when he went on to claim the

"I don't hold any resentment, to be honest," Djokovic told the Herald Sun about the saga. "I don't hold a grudge.

The Australian Open begins Sunday (Saturday EST), and Djokovic will be pursuing his



11th trophy in Melbourne to add to his men's record and an unprecedented 25th major singles title overall. A year ago, Djokovic lost in

the semifinals to eventual champion Jannik Sinner. "I just hope to, before I retire, get at least one more title there,"

said the 37-year-old Djokovic, whose only triumph at a tournament in 2024 was his singles gold medal for Serbia at the Paris Olympics in August.

Djokovic opened 2025 at the Brisbane International last week, losing in the quarterfinals to Reilly Opelka. (AP)

Rohit and Kohli's Test future depends on selectors: Gavaskar

Sharma's Test future is now in the hands of selectors, said former India captain Sunil Gavaskar while advocating an honest deepdive into the team's downward spiral in the last six months.

In an interview to PTI, Gavaskar spoke about India's recent debacles, including the home whitewash by New Zealand, the way forward and the responsibility on the Aiit Agarkar-led national selection committee to give a fair chance to those waiting in the

Asked about the raging debate surrounding the future of struggling stars Rohit and Kohli, Gavaskar said, "How long they continue is really up to the selectors.

"Now that India has failed to qualify for the WTC (World Test Championship) final, it would be pertinent to reflect on the reasons that (why it) happened," he added.

This is the first time since the WTC's inception that India could not make the finals following a 1-3 loss to Australia in the Border-Gavaskar series that concluded on Sun-

That defeat also meant that the coveted BGT was surrendered to Australia for the first time in a decade. The primary reason for the debacle was the batting unit's failure to fire with Rohit and Kohli proving to be Kohli scored 190 runs in nine innings in-

cluding an unbeaten century, while Rohit's tally was a dismal 31 from five completed

Gavaskar didn't mince words while point-



ing out the repeated failures of the team's batters, who failed to cross the 200 mark six out of nine times during the series.

"It is clear that in the last six months, the batting failed and that was the main reason that we lost matches that we should have won," the former captain stated.

"So, if changes are required for the new cycle of the WTC which starts in mid-June in England, then hopefully the selectors will take into account who would still be there for the final in 2027 and choose accordingly," Gavaskar put things perspective.

The 75-year-old former India captain did not take names but said there are some good performers coming up in the domestic circuit and the onus is now on the selectors to give them a fair chance.

"Unless they are given a chance how will we know if those doing well in Ranji Trophy will do well at the international level? Here's where good selections come in," he said.

Gavaskar also complimented the selection committee for unearthing a talent like Nitish Kumar Reddy, who was one of India's three centurions in the just-concluded tour, others

"Compliments to Ajit Agarkar and his team for seeing the potential in Nitish Kumar Reddy and picking him for the Test squad too," he said of the player, who also enjoys strong backing of head coach Gautam

On the bowling front, Gavaskar said India has enough talent that needs to be given the requisite opportunities to ensure that a generational star like Jasprit Bumrah is not overburdened. Once again, he refrained from taking names of the potential candidates, who would shape the bowling attack going

"India has got loads of promising pacers who are waiting for an opportunity. Yes, Bumrah should not be overburdened and if others step up then we can have an attack that can win matches in any conditions," he

The culture of putting stars at a pedestal has been an oft-stated problem in Indian cricket. But Gavaskar said it is not very difficult to stay grounded even with that if one is capable of taking an honest look at performances.

"We see our faces in the mirror every day and since we do that to us, we don't notice the changes that have come over the years. Only when we see photos or videos of earlier days do we notice the changes," he explained.

"It is then that we look to make the changes needed to look at our best. To do that, however, we need to take a long honest

Lloyd slams proposed 2-tier system, says terrible for nations who work hard to get Test status



GUYANA (WEST INDIES), Jan 7: Former West Indies captain Clive Lloyd has said it would be a bad idea to have a two-tier Test system to facilitate more series between the bigthree nations, saying it would be hugely detrimental for the West Indies and countries who have worked hard to get Test-match

The International Cricket Council, in collaboration with cricket boards of India, Australia and England, is exploring the possibility of a two-tier Test system to facilitate more series between these three nations.

The Age had reported that Jay Shah, the new ICC chairman, is set to meet Cricket Australia chair Mike Baird and his England counterpart Richard Thompson later this month to discuss the finer points.

"I think it will be terrible for all those countries who work so hard to get to Test match status and now they'll be playing among themselves in the lower section," Lloyd was quoted saying in the Trinidad & Tobago Guardian.

Expressing dismay over former ICC chairman Greg Barclay's suggestion that the West Indies be disbanded and play as individual countries, Lloyd said: 'We (West Indies) have a great history and now you're going to tell us because of a monetary sit- this system." (PTI)

uation, (we should be disbanded).

One of the most successful captains in history, Lloyd attributed the disparity in performance between the top-three and the rest to unequal disbursement of funds by the ICC.

"You could imagine they're talking about dismantling the West Indies, that is not the way to go. The way to go is to give them (West Indies and other teams) the same amount of money so they can improve their facilities, get better systems in place so that they can improve their cricket," the 80-year-old opined.

He also criticised the World Test Championship cycle, saying it is not "well organised".

The WTC cycle covers two years but not all 12 Test-playing nations compete in it, with Zimbabwe, Afghanistan and Ireland left out, while the remaining nine teams don't all play each other in the cycle.

"It's not well organised as such because if I am in a Test team, I want to play cricket so I can qualify for that system," said Lloyd.

"They (ICC and cricket boards) should sit down and have a system where it's not only T20 cricket. People still want to watch Test cricket and until we get that right, we will all be in

The Pakistan Cricket Board (PCB) on Tuesday said top players such as David Warner, Adil Rashid, Chris Woakes and Mustafizur Rahman will feature in the Platinum category during the players draft on January 11.

The other players in the Platinum category, which is the highest, include Australia's Matthew Short, Riley Meredith, and Steve Smith (subject to confirmation), along with England's Adil Rashid, Gus Atkinson, Jason Roy, Jonny Bairstow, Tom Curran, and Tom Kohler-Cadmore

New Zealand's Finn Allen, Kane Williamson (subject to confirmation), and Mark Chapman are also part of the platinum category. Sri Lanka's Charith Asalanka and West Indies' Shai Hope are also included in this category.

Apparently Smith Williamson have excused themselves from the PSL due to prior commitments. The PSL for the first time will clashe with the IPL and the PCB has been making efforts to secure the high-profile overseas players who were not picked in the IPL. (PTI)

great Ab de Villiers hopes the BCCI will allow Indian players to take part in the SA20 in the near future as it will only raise the profile of the young franchisebased league.

Dinesh Karthik is set to become the first Indian cricketer to compete in the SA20 but that was only made possible when he announced his international and domestic retirement last year.

The BCCI doesn't allow active players to take part in overseas leagues and as of now, the only way to play events outside India is by calling time on your career at home. Having said that, there is a growing trend of cricketers taking retirement in India to try their luck in the burgeoning overseas competitions.

"I would love to see more Indian players involved. We know Dinesh Karthik will be here this year which is fantastic and it's great for the tournament. "And hopefully the BCCI will allow

us to get more Indian players in the future to come and join the fun of the SA20," said de Villiers in a select media interaction ahead of third edition of SA20 beginning on January 9.

Having said that, he is fully aware that the BCCI is not going to make active Indian players available for overseas leagues anytime soon.

De Villiers reckons the only way to keep a league ahead of its rivals is by attracting the best overseas talent like the IPL has done over the years.

We know how to beat Aussies: Rabada CAPE TOWN, Jan 7: Fiery South

African pacer Kagiso Rabada, no stranger to beating Australia, believes the prospect of facing them in the World Test Championship final at Lord's in June has already sparked anticipation and motivation in his

Reigning champions Australia secured their spot in the WTC final with a sixwicket ictory over India in the fifth and final Test of the Border-Gavaskar Trophy in Sydney, clinching the series 3-1. South Africa were the first team to qual-

ify after defeating Pakistan by 10 wickets in the Boxing Day Test. "It's actually quite some distance away,

but a big occasion like the World Test Championship final gets you up for it," Rabada said on SuperSport after taking a six-wicket haul in his side's 10-wicket, second-Test demolition of Pakistan that com-

Up against defending champions Australia, the Proteas will start as underdogs but Rabada, who twice played a big part in winning series against Australia in 2016-17 and 2017-18, is confident of pulling off an

"South Africa versus Australia has always been an intense rivalry, because we play cricket quite similar. We play hard -and they're going to come hard at us, and we know that. But we also know how to beat them." he said.

About the significance of Test cricket, Rabada said: "One hundred per cent, Test cricket is still alive. It's our best format that we've been playing right now.

"When you look at South African cricket and all our legends, they've all been great Test cricketers. The world's best players are Test cricketers, and this series against Pakistan has been a wonderful advertisement for Test cricket, especially in South Africa."

The Proteas don't have any Test assignment in the build-up to the WTC Final at Lord's from June 11-16 and coach Shukri Conard has said they're looking at the possibility of a one-off match against either Ireland or Afghanistan.

"We're going to try and get a Test match, possibly in the UK, against Ireland or Afghanistan, whoever is free. And if unsuccessful, we'll obviously go out a couple of days earlier, and make sure we camp there really well, probably in Canterbury," said Conrad.

The coach was also all praise for his skipper Temba Bavuma for playing a key role in South Africa's resurgence.

"He's played unbelievably well this summer, and full marks to him," Conrad said. "I think any captain who wants to lead from the front, they want to lead through performance as well, and that's what Temba's done exceptionally well. (PTI)

Whitewash at home bigger failure than BGT loss; not fair to target Rohit, Virat: Yuvraj

DUBAI, Jan 7: World Cup-winning former all-rounder Yuvraj Singh has said that being whitewashed at home by New Zealand was a bigger low for Team India than the loss of Border-Gavaskar Trophy but refused to join the chorus of criticism against embattled veterans Rohit Sharma and Virat Kohli.

India have endured a difficult last few months in the five-day format, going down 0-3 to an under-strength New Zealand at home, which was a first in the team's Test history. This was followed by a 1-3 drubbing by Australia in the away edition of the Border Gavaskar series.

Both the debacles have been largely attributed to the team's batting frailties, especially those of Rohit and Kohli.

"According to me, losing (to) New Zealand is more hurting (sic). Because they are losing 3-0 at home. You know, that is not acceptable. This (losing BGT) is still acceptable because you have won two times in Australia. And this time you lost," Yuvraj told 'PTI Videos' in an inter-

"Australia has been a dominant side for the last so many years, that is my thought," the 43-year-old hero of India's 2011 World

Cup triumph said.

While Kohli managed at least a hundred during the series despite continuing to be dismissed whenever he was baited outside the off stump, Rohit was worse with a tally of just 31 runs and had to drop himself from the final Test.

But Yuvraj said it is unfair to lambast the duo given their past achievements. "We are talking about our greats, Virat Kohli and Rohit Sharma, we are saying

very bad things about them," he said. ...people forget what they have achieved in the past. They are one of the greatest cricketers of this time. Okay, they lost, they did not play good cricket. They are getting hurt more than us," he added.

Hopeful that India would bounce back strongly, Yuvraj said he has full faith in not just Rohit and Kohli but also new head coach Gautam Gambhir, who was his former teammate as well.

"I feel that Gautam Gambhir as a coach, Ajit Agarkar as a selector, Rohit Sharma, Virat Kohli, Jasprit Bumrah, they are the best minds in cricket right now," he as-

"And they have to decide what's the



way for Indian cricket in future," he said.

lauded Rohit for dropping himself The big-hitting former batter also from the Sydney Test, saying it was a selfless act.

"I think it is a big thing. I have never seen in the past that the captain's form is not going well and he himself has gone out. And this is Rohit Sharma's greatness that he has kept the team ahead of himself," Yuvraj said.

"I think he is a great captain. Whether win or lose, he will always be a great captain. And in his captaincy, we have played the (ODI) World Cup final. We won a T20 World Cup. We have achieved a lot," he pointed out.

He urged the critics to exercise restraint while dissecting the team's performance.

"I was a student of the game and now I am a student of the game. The amount of cricket I have played, they have played more cricket than me," said the man, who played 304 ODIs, 40 Tests and 58 T20 Internationals for India, amassing 11,000 runs across formats.

"I can give my opinion. And my opinion is that when players are not performing, it is easy to say bad about them. But it is very difficult to support them. Media's job is to say bad about them. My job is to support my friends and brothers. For me, they are my family. Simple," he signed off.(PTI)
