

B'desh HC commutes Paresh Baruah's life term



DHAKA, Jan 15: Bangladesh High Court has reduced the life sentence of ULFA leader Paresh Baruah to 14 years imprisonment in connection with an attempt to smuggle truckloads of weapons to the hideouts of the separatist group in Assam two decades ago.

Last month, the court had commuted Baruah's death sentence to life imprisonment.

Baruah, the United Liberation Front of Asom's military commander who is believed to be living in China, was sentenced to death after a trial in absentia in 2014. His name also figures in the 'most wanted' list of India's National Investigation Agency (NIA). "The two-judge bench commuted the life

imprisonment of Baruah and four Bangladeshis," an official of the attorney general's bureau said on Wednesday.

The High Court on Tuesday acquitted former Bangladesh Nationalist Party (BNP) state minister for home affairs Lutfuzzaman Babar and five others, who were sentenced to life imprisonment in the same case.

The court also commuted the prison sentences of five more convicts, including Baruah. The bench also declared abetted (ended) the appeals of other three accused as they died. Truckloads of weapons were seized in April 2004 that were being transported to ULFA hideouts in northeastern India through Chattogram, which was then spelled as 'Chittagong'.

The seized weapons included over 27,000 grenades, 150 rocket launchers, over 11 lakh ammunition, 1,100 sub machine guns and 11.41 million bullets.

One case was filed under the Special Powers Act 1974 for smuggling of firearms and the other under the Arms Act for illegal possession of arms

GUWAHATI, Jan 15: Dewatering continued in the coal quarry in Assam's Dima Hasao district, with the authorities failing to trace the five workers who are still trapped inside for 10 days.

Water was pumped out of the mine using machines brought by the ONGC and Coal India, and the water level has gone down considerably.

Dewatering is being carried out with the help of nine pumps while six others are on standby, the official said.

Nine workers had been trapped inside the mine on January 6 when the quarry was flooded. Four bodies were recovered since then.

The water level, which was initially at 100 ft, is coming down gradually and the current level is being ascertained, he said.

Divers will go inside the quarry only after the water level recedes to search for the trapped miners.

day. Navy divers who were requisitioned for rescue operations since the second day of the tragedy have been withdrawn and moved out of the incident site, an official said.

The rescue operations were being carried out jointly by the army, Assam Rifles, NDRF, SDRF and district administration since the first day.

"The hope of survival of the remaining trapped miners appears to be waning as they remain trapped for the ninth day but the rescue operations will continue," the official said.

An underwater Remote Operating Vehicle (ROV) is also being sent inside the quarry at regular intervals to capture images of the trapped miner, the official added.

The chief minister had earlier claimed that the mine was abandoned 12 years ago and was under the Assam Mineral Development Corporation till three years ago. (PTI)

GUWAHATI: A night of drinking among friends in Guwahati's Kahilipara locality turned fatal, leaving a 29-year-old man dead and four of his companions behind bars, as reported in a news bulletin. The victim, Akash Choudhury, a Rapido rider by night, was murdered after an altercation during a drinking session with his friends on Tuesday night. The incident occurred at around 8:45 PM at a local shop near the Kahilipara Power House. During the altercation, Akash was severely assaulted and allegedly thrown in front of an oncoming vehicle, worsening his injuries. Following the attack, one of the accused, Jiyarul Ali, rushed Akash to Hayat Hospital in an auto rickshaw. Despite their efforts to save him, Akash was declared dead at 9:15 PM. The four accused Banjit Rajbongshi (27), Jiyarul Ali (28), Debabrat Mallik (27), and Tarun Buragohain (25) were arrested by the police. According to Jiyarul, the group had been drinking together when Akash became heavily intoxicated. Jiyarul claimed that he asked Akash to come down

MCLEAN, Jan 15: Brett Holmgren got woken up early on New Year's Day by alerts that a driver had plowed into a crowd of revellers in New Orleans

The rampage, which killed 14 people, was the deadliest attack on US soil in years and was inspired by the Islamic State group. The National Counterterrorism Centre, which Holmgren leads, sprang into action to help the FBI run down information on the culprit from Texas and his plot.

It was a rare recent example of a mass attack motivated by religious extremism to hit the US homeland. But it didn't occur in a vacuum, coming at a time when a terror threat that has waxed and waned in the two decades since the Sept. 11, 2001, attacks is decidedly on the rise around the world

facing an elevated threat environment," Holmgren said in an interview with The Associated Press. "We faced that last year. We're going to face it again in 2025."

The NCTC emerged in the aftermath of 9/11 as a centralised US government hub to collect and analyze data and intelligence on the international terrorism threat, providing information to the White House and other agencies to shape policy decisions and protect against attacks.

A former counterterrorism analyst and assistant secretary of state, Holmgren was named its acting director last July and intends to step aside at the conclusion of the Biden administration. Meanwhile, the project is still in its initial stages, with discussions focused on securing the required land for the facility.

Exports contract 1 pc in December Trade deficit narrows to about USD 22 bn

NEW DELHI, Jan 15: India's trade deficit narrowed to USD 21.94 billion in December after last month's shocking surge to a lifetime high on the back of miscalculations in gold imports, government data showed on Wednesday.

Exports contracted for the second month in a row by about one per cent year-on-year to USD 38.01 billion due to global uncertainties, while imports rose by about 5 per cent to USD 59.95 billion

Key export sectors, including petroleum, gems and jewellery, and chemicals, have registered negative growth during the month under review.

Petroleum product shipments have declined by 28.62 per cent to USD 4.91 billion last month. During the first nine months of this fiscal also, these exports contracted by 20.84 per cent year-on-year to USD 49 billion.

However, textiles, electronics, engineering, rice and marine products recorded healthy growth in December 2024.

Cumulatively, during April-December this fiscal, exports recorded a growth of 1.6 per cent to USD 321.71 billion and imports by 5.15 per cent to USD 532.48 billion.

Trade deficit, the difference between imports and exports, during April-December widened to USD 210.77 billion from USD 189.74 billion during the same period previous fiscal.

Briefing the media on the latest data, Commerce Secretary Sunil Barthwal said that India's exports are doing better than other countries both in goods and services.

"This shows the resiliency of our exports. In all the three quarters of this fiscal also, we have done better. We are doing much better in non-petroleum exports," he told reporters here.

The ministry has recently held a meeting with commercial wings of Indian Missions in 20 countries to deliberate on issues impacting exports and ways to resolve them. These 20 countries account for

about 60 per cent of India's exports

When asked about the revision of gold and silver import data for November 2024, the secretary said a committee has been set up to create a robust mechanism for publishing consistent data.

in November 2024 were down by 5.06 per cent to USD 32.03 billion, while imports rose by 16 per cent to USD 63.86 billion. The trade deficit stood at USD 31.83 billion. "The data revision keeps on hap-

Raw cotton raw waste, used in the textiles industry, saw a surge in imports from USD 29.47 million in December 2023 to USD 142.89 million last month.

As per estimates, services export in December 2024 increased to USD 32.66 billion compared to USD 31.63 billion a year ago.

During April-December 2024-25, the exports rose by 11.61 per cent to USD 280.94 billion from USD 251.71 billion in the same period previous fiscal.

In December, India's shipment rose positively to the US, Saudi Arabia, France, Bangladesh and Sri Lanka.

During the month, the top five import sources were China, Switzerland, Thailand, Germany and the US.

Commenting on the data, Federation of Indian Export Organisations (FIEO) President Ashwani Kumar said the decline can be attributed to volatility in commodity and metal prices, along with ongoing international trade disruptions and currency fluctuations.

Geopolitical tensions in the Gulf region further exacerbated logistical challenges, affecting export flows to key markets like Europe, Africa, and the CIS (commonwealth of independent states), he said.

Kumar said there is an urgent need for enhanced support in the upcoming Budget. (PTI)

The excise case pertains to alleged corruption and money laundering in formulating and executing the Delhi government's excise policy for 2021-22, which was later scrapped.

Delhi Lieutenant Governor V K Saxena had recommended a CBI probe into the alleged irregularities. Subsequently, the ED registered a case under the PMLA. Taking cognisance of a CBI FIR lodged on August 17, 2022, the ED filed its money laundering case on August 22, 2022 to probe the alleged irregularities. (*PTI*)

"Mohan Bhagwat has the audacity to say to the nation what he thinks about the independence movement and the Constitution. In fact, what he said yesterday is treason... Because he is stating that the Constitution is invalid and everything, the fight against the British was invalid.

"Mohan Bhagwat's audacious comment that India didn't gain true independence in 1947 is an insult to our freedom fighters, every single Indian citizen and an attack on our Constitution," Gandhi later said in a post on X.

The former Congress chief said the party has worked with the Indian people and built the success of this country on the foundations of the Constitution and that is what the new Congress headquarters symbolises.

"It is important that we take ideas from this building and spread them in the rest of the country," he said. This building has emerged from the blood of our Congress people and not just Mahatma Gandhi, Jawaharlal Nehru, Patel ji, he noted.

Gandhi said, "We are fighting a civilisational war with these people, they are attacking every day the ideas that we believe in" and asserted that only the Congress can fight the BJP and the RSS.

Noting that everyone in this room is under severe assault defending the ideas of the Congress party, he said, "But these people are facing systematic attack on them". The former Congress chief said there is no other party in this country that can stop them. The only party that can stop them is the Congress and there is a reason for it and the reason is that we are an ideological party and our ideology did not emerge yesterday, he said. Zuckerberg's remark on India elections NEW DELHI, Jan 15: Meta India on Wednesday apologised for CEO Mark Zuckerberg's remarks that the incumbent government in India lost power in the 2024 elections due to its handling of the Covid-19 pandemic and termed it an "inadvertent error".

The apology came within days of Union Minister Ashwini Vaishnaw slamming remarks made by Zuckerberg as "misinformation", and asserting that Meta must uphold facts and credibility.

On Tuesday, BJP MP Nishikant Dubey, who heads the Parliament's Standing Committee on Communications and Information Technology, made it clear that the panel will summon Meta over Zuckerberg's comments. Meta India's Vice President Shivnath Thukral took to X on Wednesday to tender an apology on behalf of the company.

"Dear Honourable Minister @AshwiniVaishnaw, Mark's observation that many incumbent parties were not re-elected in 2024 elections holds true for several countries, BUT not India.'

"We would like to apologise for this inadvertent error. India remains an incredibly important country for @Meta and we look forward to being at the heart of its innovative future." he wrote.

Vaishnaw, earlier this week, had called out the remarks made by Zuckerberg on the Joe Rogan podcast. "Mr Zuckerberg's claim that most incumbent gov-

ernments, including India, in 2024 elections, lost post

@narendramodi Ji's leadership," said Vaishnaw, who is Minister for Information and Broadcasting as well as IT. The minister had expressed disappointment at Zuckerberg's remarks and had debunked the statement

by the Meta honcho as "misinformation". "From free food for 800 million, 2.2 billion free vaccines, and aid to nations worldwide during COVID, to leading India as the fastest-growing major economy, PM Modi's decisive 3rd-term victory is a testament to good governance and public trust. @Meta, it's disappointing to see misinformation from Mr Zuckerberg himself. Let's uphold facts and credibility," Vaishnaw had said. Meanwhile, Dubey on Wednesday said he treated the matter of Facebook founder Mark Zuckerberg's remarks on Indian elections as "closed" after an

official of the social networking platform tendered the apology. "A Meta India official has finally apologised for the mistake. This is a victory of the common citizens of India," Dubey said in a post on X.

He says the "most potent overseas threat facing the United States" right now is the group's Afghanistan-based affiliate, known as Islamic State-Khorasan, whose attacks include a March 2024 massacre at a Moscow theater and the August 2021 bombing that killed 13 U.S. service members and about 170 Afghans in the chaotic U.S. withdrawal from Afghanistan.

One ongoing spot of concern is Syria, where an insurgent group named Hayat Tahrir al-Sham, or HTS, led a lightning offensive last month that toppled the government of President Bashar Assad.

HTS is a Sunni Islamist group that formerly had ties with al-Qaida, although its leader has preached religious coexistence since taking over in Damascus. The group has not plotted against US interests in recent years and has been "the most effective counterterrorism partner on the ground," Holmgren said.

HTS has been designated by the State Department as a foreign terror organization, a label that carries severe sanctions. Asked whether that designation would remain, Holmgren said that was a policy decision, though he noted: "They want to be perceived as being on the right side of the international community at this time when it comes to (counterterrorism). But we will continue to evaluate not just their words but also the actions that they're undertaking.

Rupee extends gains, settles 13 paise higher at 86.40 against US dollar On Tuesday, the rupee rebounded from its low-MUMBAI, Jan 15: The rupee extended its re-

covery for the second straight session and settled with a gain of 13 paise at 86.40 (provisional) against the US dollar on Wednesday, tracking favourable cues from domestic equity markets and softening crude oil prices.

The American currency index also descended from a record peak, adding to the gaining momentum in the local unit, though it remained under pressure from continuous exit of foreign institutional investors, forex traders said.

At the interbank foreign exchange, the rupee opened at 86.50 and slipped to the intraday low of 86.55 against the greenback. It also touched A high of 86.28 before ending the session at 86.40 (provisional) against the dollar, registering a gain of 13 paise from its previous close.

est-ever level and settled with a gain of 17 paise at 86.53 against the dollar.

Anuj Choudhary, Research Analyst at Mirae Asset Sharekhan, said the rupee gained for the second consecutive session on weak US dollar and soft US 10-year treasury yields. A pullback in the domestic equities and overnight decline in crude oil prices also favoured the rupee. However. FII outflows capped sharp gains.

Analysts attributed the weakening dollar to lower-than-expected producer price index, as per the latest data released in the US.

Going ahead, Choudhary said the US inflation is expected to remain elevated and it may lead to a recovery in the US dollar, which is likely to put pressure on the rupee.

"Traders may take cues from CPI data from US and speeches from various Fed speakers today. USD-INR spot price is expected to trade in a range of Rs 86.25 to Rs 86.65," he added.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.22 per cent lower at 108.87. Brent crude, the global oil benchmark, rose 0.35 per cent to USD 80.20 per barrel in futures trade.

In the domestic equity market, the 30-share BSE Sensex climbed 224.45 points, or 0.29 per cent, to settle at 76,724.08 points, while the Nifty rose 37.15 points, or 0.16 per cent, to 23,213.20 points. Foreign institutional investors (FIIs) offloaded equities worth ₹ 8,132.26 crore on Tuesday. (PTI)

Solar-powered pumps for irrigation in rural areas in Tripura



AGARTALA, Jan 15: Tripura Renewable Energy Development Agency (TREDA) has set a target of setting up over 10,000 solar-powered pump sets to ensure assured irrigation in the rural farmland under PM Kusum scheme, an official said on Wednesday.

Of the total target, the TREDA has already set up 3,616 solar power pumps bringing 7,232 acres of farmland under assured irrigation benefiting 3,616 marginal farmers, the official said.

Work for establishing 5,051 pump sets has been in progress while steps have been taken to set up 2,264 solar-powered pump sets at the earliest. "The state government has taken steps so that the farmers who are liv-

ing in rural areas could double their production by using irrigation. Under PM Kusum scheme, farmers are given solar power pumps at a subsidised price," TREDA joint director Debabrata Sukladas told PTI.

According to him, if any farmer doesn't have a water source for irrigation, the TREDA will provide subsidies under the PM Kusum scheme. Sukladas said out of the target of setting up 10,895 solar-powered pumps, 3,616 pumps have already been installed which ensured irrigation in 7,232 acres of farmland owned by 3,616 marginal farmers.

"While work for setting up 5,015 solar-powered pumps was in progress, the remaining 2,264 pumps will be installed at the earliest. Once the scheme is implemented, around 21,790 acres of farmland will get irrigation facility," he said. Sukladas said the subsidy is available for the prospective farmers under the scheme.

"For one horsepower (HP) pump a prospective farmer will be required to pay only ₹ 10,000 out of the total cost of ₹ 1,39,000. In the case of 2 HP a farmer needs to provide only ₹ 15,000 out of the total cost of ₹



Revocation of border pass on India-Myanmar border demanded Mizo group urges Centre to reinstate FMR

AIZAWL, Jan 15: An Aizawl-based Chin-Kuki-Mizo-Zomi group has urged the Centre to reinstate the Free Movement Regime (FMR), which facilitates a visa-free movement across the India-Myanmar border.

The Zo Re-unification Organisation (ZORO), which represents ethnic Zo or Mizo tribes of India, Myanmar and Bangladesh, also demanded the revocation of the order mandating a border pass for people living within 10 km on either side to cross the international border.

Speaking to reporters, the organisation president R Sangkawia on Tuesday said that the Ministry of Home Affairs (MHA) has recently replaced the FMR with a new system to regulate movement across the India-Myanmar border.

The Ministry of Home Affairs (MHA) in February 2024 had decided to scrap the Free Movement Regime (FMR) between India and Myanmar to ensure the internal security of the country and to maintain the demographic structure of India's North Eastern states bordering Myanmar.

However, officials said that no official notification scrapping the FMR with Myanmar has been issued Myanmar border.

While Zokhawthar and Hnahlan cross points in east Mizoram's Champhai district will be implemented as pilot sites, 3 crossing points in Lawngtlai district will be set up under phase-I and another 13 points in all the six districts, which share border with Myanmar, will be set up under phase-II, the MHA said in the letter, according to Sangkawia.

According to the new guidelines, an individual will now require a "border pass" to travel to and from Myanmar, which will be issued by the Assam Rifles for only people living within 10 km on either side of the border for a stay-of up to 7 days, he said. An individual seeking the border pass must produce a document or certificate to prove that he or she

lives within a 10-km radius of the borders, he said. The identity proof document can be issued by

local police station officer-in-charge or village chief or village authority (administrator).

The MHA letter also said that movement of border residents from Myanmar and India would be allowed for "specific reasons such as visiting relatives, tourism, business, medical treatment and cultural exchange programmes," Sangkawia said. (PTI)



Doldrums in Bengal BJP

R iven with factionalism made worse by a rank and file lowering in morale, West Bengal unit of BJP is not a political outfit which has some reasons to fulfil its promise to emerge as the ruling dispensation of the state post 2026 Assembly elections. Nowhere matching its once grandiose description of the "Grand Old Party", the state Congress is just another political outfit which also ran. The commonality between the two boils down to the fact that they are unlikely to offer a semblance of political resistance to the TMC government in 2026 Assembly polls. The charisma of their leadership falls far short of the same of TMC supremo Mamata Banerjee even as they vainly promise to raise the upper limit of social welfare schemes like Lakshmir Bhander and Kanyasree once they emerge victorious in the coming polls without much hope of winning the elections. Enjoying the status of the principal Opposition party in the state Assembly, the BJP can trace its rise in the state from the late '90s when it was a poll partner of a fledgling Trinamool Congress. Promising self rule to the Gurkhas, the saffron camp had its most winnable constituency in Darjeeling parliamentary constituency

Apart from the hills, the BJP had Dum Dum and Krishnanagar Lok Sabha constituencies in its kitty during this time span. Apart from the support from Trinamool, "covert blessings" of CPI(M) strongman late Subhas Chakraborty ensured that Dum Dum became almost a pocket borough of BJP. A slump came thereafter in the electoral fortune of the saffron camp. Mukul Roy, the second in command in TMC after Mamata Banerjee switching his loyalty to BJP led to an upsurge in number of saffron camp representatives from West Bengal in 2019 Lok Sabha elections. Together with Roy's knowledge about the weak spots of TMC, the organisational network woven by state party chief, Dilip Ghosh saw BJP winning 18 Lok Sabha seats. Just as the BJP seemed almost poised to replace Trinamool in 2021 Assembly elections, the saffron camp bit the dust. Despite Prime Minister Narendra Modi and Union home minister Amit Shah making regular trips to campaign in West Bengal, the chinks in BJP's organisation became discernible.

The removal of Dilip Ghosh from the state chief's post opened a floodgate of intra-party feud. Sukanta Majumdar, an academic who replaced Ghosh could not rein in the feuding factions. Leader of the Opposition in the state Assembly, Subhendu Adhikari who had come over from Trinamool had engineered a spate of defections. But such is the state of West Bengal unit's organisational adhesion that many of the turn coats returned to TMC in ashes and sackcloth.Fissures turned into cracks as several BJP MLAs switched loyalty to the Trinamool Congress. Inner party squabble is eating into the state BJP as the differences between Adhikari "a projected leader" and Majumdar, a RSS protege show no indication of going away. Post 2021 Assembly elections, saffron camp organisation continued to go downhill as the party lost six seats in 2024 Lok Sabha polls.

Tusu Puja: The soulful celebration of agriculture, sacrifice, and womanhood in Eastern India

B asking in the warmth of the winter sun with a cup of coffee and the morning newspaper in hand, my thoughts drift to the recently concluded celebrations of Tusu Puja in the tea gardens of Assam, a sight often overlooked amidst the grandeur of other regional festivals. As winter casts its cool embrace over the land, the festival of Tusu, coinciding with the harvest season, adds its own unique vibrancy to the rich cultural mosaic of the northeastern and eastern states of India. It is a time of celebration, devotion, and a reaffirmation of the bonds that tie people together-rooted deeply in both agriculture and mythology. TusuPuja, though lesser known compared to other festivals like Magh Bihu or Makar Sankranti, holds an esteemed place in the hearts of the indigenous communities of Assam and Bengal.

Makar Sankranti marks a key moment in the Indian calendar, signaling the end of an inauspicious period from mid-December to mid-January, and heralding a time considered most auspicious for rituals, marriages, and other sacred occasions. Celebrated alongside festivals like Pongal in the South, Lohri in the North, and Magh Bihu in Assam, Makar Sankranti is a period of spiritual and cultural renewal. However, in the vast canvas of Indian festivals, there is one that is often overshadowed yet equally significant in its cultural context-the Tusu Puja, a festival of the indigenous tea garden communities of Assam and their counterparts in the Manbhum region of Bengal.

Tusu Puja, or Tusu Parab, is celebrated primarily by the Kudumi (Kurmi) people, an important agricultural community in Eastern India, spanning Odisha, Jharkhand, West Bengal, and Assam. The festival is a beautiful amalgamation of rural devotion, mythological storytelling, and communal festivities. Falling on Makar Sankranti, Tusu Puja is dedicated to Tusu Devi, the Goddess of Agriculture, revered as the embodiment of Shakti and fertility. The festival unfolds with a blend of rituals, songs, dances, and feasts, all deeply rooted in the agricultural cycles of the region, marking the harvest of the winter crop and a time for social cohe-

One of the most striking features of TusuPuja is the devotion shown by the young girls of the village. They create and worship small idols or murtis of Tusu Devi, made of clay or sola wood, which are often adorned with vibrant colours, tin-foil crowns, and decorative jewellery. Tusu Devi is visualized as a youthful, chaste girl, symbolizing both purity and fertility. In the remote tea gardens of Assam and in the districts of Purulia, Birbhum, Bankura, and Burdwan in Bengal, the festival is a communal affair that brings together people of all

ages and backgrounds, particularly the women who perform the central religious and cultural rituals.

The preparations for Tusu Puja begin in late December, as the cold winter sets in, coinciding with the harvest of the Amon rice crop. During these days, the women of the village engage in a ritualistic practice where they prepare the murtis of Tusu Devi, usually during the nights leading up to the festival. Each evening, unmarried girls gather at a house and sing traditional Tusu songs, known for their melodious tunes and evocative lyrics. These songs are more than mere entertainment—they are expressions of longing, devotion, and a deep connection to the land and its cycles. The process contin-

ues for 29 nights, culminating in a grand exchange of garlands and an offering of pulses and rice on the 30th day,

marking the peak of the celebrations. Tusu Puja is not merely a religious event but a vibrant celebration of femininity, womanhood, and social bonding. The young girls, during the festival, dress in traditional attire, sing devotional songs, and perform dances in front of the deity. These performances are not only acts of religious devotion but also serve as opportunities for social interaction. The competitive nature of the songs-where girls sing to outsmart each other and boys tease them-adds an element of youthful playfulness to the festival, making it a joyous occasion for all involved. The importance of Tusu Puja extends be-

yond its religious significance. It represents the collective aspirations and desires of young women for a loving husband, as they sing and dance with hopes of divine blessings. The girls, during the evening rituals, seek Tusu Devi's blessings to fulfill their wishes and ensure a prosperous future. The festival's social aspect is equally important; it provides an opportunity for young girls and boys to interact, forming bonds that may later lead to marriage, while older women act as guides and participants in the festivi-

A notable characteristic of Tusu Puja is its inclusivity, as it is a celebration of life and fertility shared by various indigenous communities like the Santhals, Mahatos, Lodhas, and others. The festive

atmosphere transcends **DEGREE OF THOUGHT** age, gender, and social status, creating an environment of unity and

communal joy. The festival also carries with it a significant folk-cultural heritage, with regional variations that reflect the unique stories and traditions of each community.

The stories surrounding Tusu Devi, and how she came to be worshipped, are as diverse as the regions in which the festival is celebrated. The most popular narrative tells of a young girl named Tushmuni (or Tusumoni) who was betrothed to a prince but tragically lost him to an early death. In her grief, she chose to end her life, a poignant act of self-sacrifice that would later be commemorated as Tusu Puja. Other versions of the story involve a king's love for

Tusu, whose untimely death causes him to lose his mental stability, or the tragic tale of Tusu's defiance against the advances of a Mughal king. Each story is steeped in themes of sacrifice, love, and purity, symbolizing the eternal struggle between love, duty, and loss.

The physical manifestation of Tusu in the form of murtis is also rich in symbolism. The idols are typically made with a combination of clay, sola wood, rice bran (known as "tush"), and other locally available materials. These murtis are painted in vibrant hues, adorned with decorative paper ornaments, and placed in specially prepared spaces in the home. The rituals of Tusu Puja are simple yet profoundly meaningful. Each morning, women perform a ceremonial bath in the nearby river or pond, and in the evening, they offer prayers, food, and song to Tusu Devi. A key ritual is the offering of prasad, which includes a mixture of peas, sweetmeats, and flattened rice. The sound of folk songs, known as "jagoronigeet" (awakening songs), fills the air as the community comes together to celebrate.

On the final day of the festival, the murtis are immersed in rivers or ponds in a ritual known as "bhasan," symbolizing the transient nature of life. The immersion ceremony is often accompanied by lively processions, singing, dancing, and the exchange of flowers and fruits. The act of immersing the idol into the river is a reminder of the impermanence of life and the cyclical nature of existence, where birth, life, and death are intertwined. After the immersion, the participants enjoy a feast, often consisting of rice, fish curry, and traditional sweet dishes, while also offering food to crows, a gesture of gratitude and reverence.

The immersion of the murtis and the subsequent feast symbolize the renewal of life and the promise of a prosperous future. As the Tusuni (the woman chosen to lead the rituals) immerses the idol and takes a holy dip in the river, she completes the spiritual cycle of the festival, which has brought the community closer together in worship, joy, and reflection.


TusuPuja, with its blend of religious reverence, cultural expression, and community solidarity, is more than just a festival; it is a vivid reflection of the agricultural life, the bond between people and the land, and the timeless themes of sacrifice and renewal. It may not attract as much attention as other festivals, but for the people of Assam, Bengal, and the indigenous communities of Eastern India, TusuPuja remains a cherished and deeply significant celebration, embodying the spirit of life and devotion in its most heartfelt and communal form. Taliban 2.0 **Technology and freedom - Are parents** India courts **By: Asad Mirza** India's humanitarian assistance to Afghanistan

ast week saw an unusual diplomatic development led by India, when India's topranking diplomatic officer, Foreign SecretaryVikram Misriheld a meeting with the Acting Foreign Minister of Afghanistan, Maulawi Amir Khan Muttaqi, in Dubai on Jan-

has been extensive and diverse since 2021. Responding to a request from Afghanistan, India has committed to further material support, particularly in the health sector and for the rehabilitation of refugees. Both sides also discussed strengthening their collaboration in sports. Additionally, they agreed on promoting the use of the Chabahar Port to enhance trade and provide humanitarian assistance to Afghanistan. In fact, the Chabahar Port may prove to be a port of promoting multilateral friendship with both Iran and Afghanistan, in addition to many central Asian republics. The distance from Chabahar to Kabul via Zahedan is only 1196kms by road or rail. Thus, the port could serve as an important linkage with Afghanistan in absence of Pakistan denying India the right of passage through its road or rail network repeatedly.Chabahar Port provides a direct route to Afghanistan through Zahedan without involving Pakistan. Resultantly, this also reduces Afghanistan's dependence on Pakistan for trade and helps build stronger economic ties with India, making trade smoother and more efficient. Strategically, a growing relationship with Taliban may also help India to counter the Chinese push in Afghanistan and other central Asian countries through its BRI project. Further, an increased mechanism of interaction may help India to influencethe Taliban to check anti-India elements operating from Afghanistan such as Lashkar-e-Taiba (LeT), Jaish-e-Mohammed (JeM) and Islamic State Khorasan Province (ISKP)

The meeting comes in the background of increasing Afghanistan-Pakistan tensions and many see this as India's move to edge out Pakistan from the Afghanistan equation. But the fact is that India has never given-up on either Afghanistan or Taliban. In fact, though not at the diplomatic level vet unofficially Indian establishment has kept a line of communication open with the Taliban since their emergence on the Afghanistan's political landscape in 1996 as Taliban 1.0.

Pragmatically, India has not ignored Taliban at all. In fact, at the Moscow Dialogue of 2017and the Intra-Afghan Peace Talks of 2020 in Doha. Indian representatives were present. further India's Ambassador to Qatar met Taliban representatives at their Doha office. In June 2022 Joint Secretary for Pakistan, Afghanistan, and Iran met key Taliban leaders paving the way for sending a technical team at the Indian embassy in Kabul. Subsequently, India allowed the Taliban to appoint a new Consul General in the Afghan Consulate in Mumbai.

The recent warming of ties between Kabul and New Delhi is not a sudden development but a result of quiet diplomacy since the Taliban came to power in Afghanistan and India began informal talks with the government.

While there might not be a formal recognition of the Taliban government by New Delhi, India has maintained a neutral and non-judgmental approach. Security sources say the Taliban government has appreciated this non-interference, creating an understanding of mutual acceptance.

Additionally, the alignment of India's security and strategic interests is equally important to counter Pakistan's influence. Security officials also emphasise that India has learnt from past experiences, such as the hijacking of a Indian Airlines plane in 1999, and now understands the importance of maintaining relationships with neighbouring states unless there are clear and credible reasons not to do so. In this context, New Delhi is focusing on securing its national security interests at a time when geopolitics in the region is in a flux.

Reportedly, the Foreign Secretary highlighted India's long-standing friendship with the Afghan people and the deep cultural and social ties shared by the two nations, at the meeting. He assured Afghanistan of India's commitment to addressing the immediate developmental needs of its people.

The discussions included a review of the ongoing Indian humanitarian assistance programmes in Afghanistan. The Afghan Minister expressed gratitude to India for its unwavering support and engagement with the Afghan people. Recognising the current developmental challenges, both sides agreed that India would explore additional development projects soon, complementing its ongoing humanitarian efforts.

In this regard it would be judicious for India if it courts Talibani leaders like Sher Mohammad Abbas Stanekzai, who was trained at Indian Military Academy, just like its old friend Hamid Karzai who also studied in India.

Another influence which India could leverage to its benefit to exert some sort of religious pressure on the Taliban leaders is the leading Indian seminary of Darul Uloom, Deoband. Many of the old guard Taliban leaders have been tutored at Deobandi madrassas in Pakistan and the border area of Afghanistan-Pakistan, run by several Deobandi alumnus. However, in the regard India should make sure that it asks the religious and not the political leaders of Darul Uloom to help in this regard, as such political leaders have no locus standi amongst the Talibani leaders.

A similar approach has been shown by Taliban leadership also, by appointing Ikramuddin Kamil as the acting consul at the Afghan Consulate in Mumbai, in November 2024, marking the first such appointment by the Taliban in India. Kamil like Karzai studied in India for seven years, completing his doctorate from South Asia University in New Delhi on a scholarship provided by theMEA.

So, if the Taliban leaders are ready to utilise people who have a connect with India, similarly India can gain a lot by utilising people who may have a connect with the Taliban leadership. This could be a win-win situation for both by-passing their common foe Pakistan, in the long run. ▲ ■ a childhood, that I had lived with more freedom than my kids do today. Certainly, we need to be apologetic about the restrictions that being parents we constantly hover over our children. Strictly confining their world between the walls of the house, most of the parents repeat this mistake. Always the illusive idea is parents are concerned about their children's safety. In my case, my parents blessed me with much freedom to move and play independently all along the complex dusty village patches and backyards. The moments I spent outside my living space were the moments of exploration and there was certainly the feeling of conquering the most stimulating and critical space of curiosity and with my friends, those were the heavenly days of childhood. Not only to my parents, but to most of the parents of those days, an interesting aspect was that they rarely had any idea about their children's whereabouts especially during holidays. They enjoyed abundant freedom like butterflies fluttering and dancing across lanes and landscapes of the beautiful village settings. When the merriment of the day was over, children snuggled into the warmth of their homes almost tired and disheveled. When they unusually delayed, they had to face moments of anger and outrage and eruption of disagreement. Altogether, my days as a child occupy the best part of my memory.

I think today we lost the genuine moments of fun and happiness. Obviously, children have multiple options of the sophisticated types such as smartphones, video games, internet and the Google University on their table. But don't they really miss the delight of being together with their friends enjoying the dusty patches of the village and its green and innocent ambiance and its rich fragrance of humanness elevated by the power of love and compassion and if they are in the city, at least a lovely gathering at the courtyards. Enjoying the enchanting aroma of the soil freshly soaked in the first rain of the season while little children play into the pitter-patter of its sprinkle, splashing their tiny feet in the tiny torrent of muddy water flowing to fill the burrows and the infinitesimal streams, life as a child was a magical blessing.

Never would you find a child being singled out or isolated. Everywhere, to the school and back and at the temple and the mangroves, we had a pleasant reason to come together, a fantastic team spirit of togetherness learned naturally. More than anything was the warmth of friendship that cultivated a sense of inclusiveness with sharing and caring. Learning basic lessons of acquiescence, all among the little crowd of boys and girls were euphoric and healthy even if they missed a meal or two.

Today things are different. Friendship has lost its essential charm and depth. Instead it has gained a sense of artificiality; children bury their vision and health being glued to the internet. The horizon of knowledge revealed to them on the



screen is luxuriant, but it also critically preserves a dark area of seclusion, misunderstanding and cynicism. This version of new friendship has actually brought damaging ripples of temperament into families. Children easily get anxious as they confront even slightly confusing situations. Though they have all sorts of tech available for entertainment, what are amiss are the friends. A child, with a lot of active friends and pleasant chitchat taking place outside their classrooms and family's quarantined atmosphere, will easily learn the art of collaboration. More efficiently he would find solutions to the problems that he would be hit at his age. I certainly would welcome a safety net that the parents draw around their children. But the danger it brings home is terrible. Children, in all usual conditions, would forget the need to open up their mind. A grave threat of being suppressed and questioned by their parents sustains while something like an apparent surrender to the tech-world by the children for every complex thing that they face would popup and parents would fail to strike a balance between their child's privacy and freedom and critically fail to become a good supporter. This is mostly due to their scanty contribution in the child's emotional upbringing. The child naturally creates a periphery for securing his seclusion and would persistently grow into an anxious person frequently concealing the real problem. So the child's tech privacy, to the extent of leading to his self-alienation, would be the most horrific development.

To my mind, what I pick from my childhood may not be the best possible solution for the problems today. But to avail certain levels of freedom to the child to be independent while motivating him to be a co-explorer, satiating his curiosity outside the firm and closeted environment of the home might be the best way we can handle his childhood. To me, in the 80s, a childhood without television and computer was heavenly. This feeling cannot be blamed. As technology progressed and gradually tore into our little minds, what they chose to emotionally stay away from were their parents. In most of the families, this could be emerging as a threatening situation. Do the parents find some leisure time with their kids to walk down the dark and dusty village lanes or at least to the park or to the beach? A weekly leisurely outing would help swipe the dust of discomfort that the child gathered about his parents or that could also be an event to unleash the tiny trash of disappointment he happened to nibble on secretively. If this is done routinely, there can be limited hours assigned for the child's personal entertainment on the screens and parents can have no reasons to worry about his tech wanderings. Small, yet prayers with the family members with a practice of silence for a while on a daily basis could alleviate the flow of annovance on silly matters.

Between the golden days of yore to the present tech oriented life, what comes with complete earnestness is a falsehood that we need to break with a genuine enthusiasm. The myth or falsehood is that the generation swelled by the eminence of the internet and social media has been indubitably overloaded by complex facts and figures and there are serious chances for its horrible derailment. We cannot completely disagree with that. But, to the parents and the conscience keepers of the society, one thing emerges with great relevance and gravity, that the children of today are excellently blessed with the best ways of communication. Giving them the most sophisticated gadgets and leaving them to pass their precious time alone in the complexity of online contents may seriously collapse their socializing behavior. How can this enigma be broken completely? Parents have to give their children a blend of practical experiences of socializing in the present tech-ridden environment wherein the child discovers the essence of humanity from real life situations rather than from the world he cantured on his smartphone screens. Paper vs Plastic: A comparative analysis

Plastic recycling involves sorting, cleaning and melting plastic waste to create new plastic products. Not all types of plastics are recyclable and the process can vary depending on the type of plastic. Questions tend to arise concerning the state and the developments of the technologies that are used in the production of these materials and trends in their usage. Due to such an invention, material science has been able to come up with biodegradable plastics which are as convenient as regular plastics, but environmentally friendly. Moreover, the emergence of biodegradable or partly biodegradable, fully compostable bioplastics based on renewable raw materials, similar to chemical application, corn starch, or sugarcane, opens the possibility of compromising between paper and plastic. The evidence shows that bioplastics are equally efficient as conventional plastics in terms of performance, thereby contributing less to carbon emissions and utilizing less fossil fuel. However, social doubts still persist over their termination and end-of-life.

Solutions for the impact on environment:

The development of biodegradable plastic will be a great boom to the environment as they can decompose naturally in the environment, reducing pollution and waste. The growing regulations of single-use bags has also seen a significant difference in the environmental impact plastics have. Furthermore the use of trees like bamboos and coconut leaves to make paper which are easily biodegradable will be a better alternative. Also using electronic ink which involves the technology that can be used to create paper-like displays that can be written on and erased but doesn't actually use paper. Conclusion

Therefore, the paper versus plastic debate can be viewed along environmental, economic, cultural and regulatory perspectives. Paper products have some benefits in biodegradability and renewability in their raw materials but some drawbacks with regard to resource use and disposal. On the other hand, the use of plastic offers convenience and longevity but has catastrophic effects on ecology.

To address such challenges it is about informing the consumer about proper decision-making where sustainable living and consumption are part of the decision-making process. In this way, by making consumers more aware, supporting technological innovations and adopting the right policies, stakeholders can help to build a more sustainable world. LOS ANGELES, Jan 15: Easing winds delivered a brief but muchneeded reprieve to firefighters Tuesday as they battled two massive blazes burning in the Los Angeles area, and the National Weather Service pushed back its unusually dire warning of critical fire weather until early the following day. Forecasters said the winds were below danger levels in the evening, but they were expected to strengthen overnight with potentially fire-fuelling gusts. Red flag warnings remained in effect from Central California to the Mexican border until late afternoon Wednesday.

Winds increased Tuesday but not to the near-hurricane-force levels that were predicted to happen earlier in the day. Still the danger was not over, officials said.

"Key message: We are not out of the woods yet," the National Weather Service in Los Angeles said in a post on social media. "The winds underperformed today, but one more enhancement could happen tonight-tomorrow."

This round of Santa Ana winds was not expected to be as mighty as last week, but they could carry fire-sparking embers for miles and stoke new outbreaks in a region where at least 25 people have already been killed.

Firefighters made more progress on the Palisades Fire, the largest and most stubborn blaze. CalFire **Operations Section Chief Christian** Litz said he took a helicopter ride around the perimeter and saw no active flames, though it was far from over.

Nearly 90,000 households lost electricity as utilities shut off power to prevent their lines from sparking new blazes.

Weary and anxious residents were told to be ready to flee at a moment's notice. They remained vigilant, keeping an eye on the skies and on each other: Police announced roughly 50 arrests, for looting, flying drones in fire zones, violating curfew and other crimes.

Of those, three people were arrested on suspicion of arson after being seen setting small fires that

The death toll is likely to rise, according to Los Angeles County Sheriff Robert Luna. Nearly 30 people were still missing, he said Tuesday. Some people reported as missing earlier have been found. Just under 90,000 people in the county remained under evacuation

orders, half the number from last week. Hollywood's awards season has been put on hiatus because of the crisis. The Oscar nominations have been delayed twice, and some organisations postponed their awards shows and announcements without

rescheduling. (AP)

Preventive power cuts introduced in Ukraine

KYIV, Jan 15: Russia launched a massive aerial attack against Ukraine on Wednesday, forcing the country to introduce preventive power cuts, the Ukrainian energy minister said.

WARSAW, Jan 15: Ukrainian President Volodymyr Zelenskyy was visiting Poland on Wednesday after the two countries reached an agreement on a longstanding source of tensions between them: the exhumation of Polish victims of World War II-era massacres by Ukrainian nationalists.

The office of Polish Prime Minister Donald Tusk said early Wednesday he would welcome Zelenskyy in the late morning, and that the two would hold a joint news conference shortly after noon local time.

The visit comes just days after Tusk announced progress on the issue of the exhumations, an issue that has strained relations for years.

"Finally a breakthrough. There is a decision on the first exhumations of Polish victims of the UPA," Tusk wrote on the social platform X on Friday, referring to the Ukrainian Insurgent Army.

"I thank the ministers of culture of Poland and Ukraine for their good cooperation. We are waiting for further decisions.'

A non-governmental group, the Freedom and Democracy Foundation, said Monday it will begin exhumation work on victims in Ukraine in April.

Although Poland has been one of Ukraine's most stalwart supporters since Russia's full-scale invasion nearly three years ago, the issue of the Polish victims lying in mass graves in Ukrainian soil eight decades after they were killed has left a festering bitterness among many Poles.

It also has put pressure on Tusk, who is seeking to show progress on an issue of continued importance to many people in Poland. It is particularly important as his party's candidate in a presidential

Japan, Philippines plan to convey to Trump need for US engagement in Asia

MANILA, Jan 15: Japan and the Philippines will convey to Presidentelect Donald Trump the urgent need for the US to remain committed to help uphold the rule of law in an Asian region where security concerns have become "increasingly severe," Japan's top diplomat said Wednesday.

The US, Japan and the Philippines have been building an alliance under outgoing President Joe Biden since last year to deal with China's increasingly aggressive actions in the disputed South China Sea and East China Sea. Trump's "America First" foreign policy thrust has triggered concerns about the scale and depth of US commitment to the region under his new term.

"We will approach the next US administration to convey that constructive commitment of the United States in this region is important also for the United States itself," Japanese Foreign Minister Takeshi Iwaya said in

a news conference with his Philippine counterpart, Enrique Manalo, in Manila

added

Iwaya said he was scheduled to attend Trump's January 20 inauguration as one of Washington's closest treaty allies in Asia along with the Philippines.

"Amid the increasingly severe strategic environment in the region, Japan places importance on our bilateral cooperation as well as on maintaining and strengthening trilateral cooperation between Japan, the Philippines and the United States," Iwaya said.

An alarming spike in confrontations between Chinese and Philippine coast guard and other forces in the busy sea passage has set off fears of a major escalation that could draw in the United States, which has repeatedly warned that it's obligated to help defend Philippine forces if they come under an armed attack in the South China Sea. NEW DELHI, Jan 15: The AAP on Wednesday said the home ministry granting sanction to prosecute Arvind Kejriwal was a "misuse" of power by the BJP and an attempt to defame the ruling party ahead of the Delhi Assembly polls. The Union Home Ministry has granted sanction to the Enforcement Directorate to prosecute the former Delhi chief minister in the excise policy-linked money laundering case, officials said.

The federal agency filed a chargesheet against the 56-year-old politician before a special Prevention of Money Laundering Act (PMLA) court here last year after arresting him in March.

The Aam Aadmi Party said the excise policy case registered in November 2022 was "unprecedented" as Kejriwal was arrested without any "sanction". (PTI)

BENGALURU/NEW DELHI, Jan 15: Two Indian space start-ups -- Pixxel and Digantara -- on Wednesday announced the launch of their satellites onboard a SpaceX rocket to closely monitor the earth and objects orbiting around it, marking a new era for the private firms in the space sector.

Pixxel became the first private company in India to have its own constellation of satellites using the cutting-edge hyper-spectral frequency that allows observation of the earth in over 150 bands, a technology that is useful in sectors as diverse as agriculture and defence.

Digantara Aerospace announced the launch of the world's first commercial satellite - Space Camera for Object Tracking (SCOT) - for surveillance of objects as small as 5 cm orbiting the earth to ensure safer space operations.

Surveillance of outer space or situational space awareness (SSA) is important to ensure the safety of spacecraft as orbits around the earth become crowded with artificial satellites as well as space debris.

Pixxel's three Fireflies, currently the world's highest-resolution commercialgrade hyperspectral satellites, are six times sharper than the 30-meter standard and are capable of capturing fine details previously invisible to conventional systems.

"For the first time a 5 meter hyperspectral is available. That is what makes it unique, not just in India, but globally," Pixxel co-founder and CEO Awais Ahmed told PTI.

Pixxel plans to launch three more Firefly



satellites over the next two months and follow it up with 18 more in future.

"This milestone by Pixxel, marks a significant step forward, as hyperspectral satellite imaging has a potential to play a transformative role for many use cases, especially the defence sector. The advanced hyperspectral

imaging capabilities of these satellites are poised to unlock new possibilities." Lt Gen A K Bhatt, Director General, Indian Space Association (ISpA), told PTI.

Lt Gen Bhatt said Digantara's SCOT satellite was a crucial stepping stone to ensure a more sustainable space environment and to tackle the growing issue of space debris and congestion, which pose a greater threat as the number of man-made objects in space increase in future

Digantara CEO Anirudh Sharma said SCOT aimed to enhance space safety, optimise traffic management and bolster national security initiatives.

From the sun-synchronous orbit, SCOT will track objects in Low Earth Orbit (LEO) with greater efficiency than existing sensors, which are constrained by weather conditions, geographic limitations and restricted fields of view.

"Unlike these traditional systems, SCOT offers persistent monitoring of Resident Space Objects, detecting and tracking objects as small as 5 cm," a company statement said.

As one of the world's first commercial Space Situational Awareness (SSA) satellites. SCOT is engineered to track Resident Space Objects (RSOs) with unmatched frequency and precision.

SCOT forms a key part of Digantara's mission to establish a hybrid network of surveillance systems, delivering persistent monitoring of the near-Earth environment to ensure improved safety and the long-term sustainability of space operations.

The cutting-edge resolution of Fireflies enable them to detect subtle changes in chemical compositions, vegetation health, water quality and even atmospheric conditions with unmatched accuracy, Pixxel cofounder and CTO Kshitij Khandelwal said at the headquarters of the start-up in Bengaluru.

While traditional earth observation satellites rely on broader spectral bands, the Firefly's narrowband sensors uncover hidden patterns and anomalies critical for applications, ranging from agriculture to climate action, he said.

Pixxel already has signed up more than 60 clients, including the US National Reconnaissance Organization, companies like Rio Tinto, British Petroleum, and the Union Ministry of Agriculture, who are receiving hyper-spectral data from its technology demonstration satellites. (PTI)

RAJKOT. Jan 15: Records tumbled like nine pins as the Indian women's cricket team, powered by skipper Smriti Mandhana's 70ball century, demolished Ireland by a whopping 304 runs to claim its biggest-ever ODI win and complete a 3-0 clean sweep here on Wednesday.

The result of the match was a mere formality once India set Ireland a massive target of 436, and Ireland could only garner 131 before getting bundled out in 31.4 overs

India put the first step forward towards a crushing victory through record-breaking Mandhana and her opening partner Pratika Rawal, reaching 435/5, highest total by an Indian team men's or women's — in ODIs.

India men's highest ODI total is 418/5 made against the West Indies in Indore in 2011.

Mandhana and Rawal added a whopping 233 runs for the first wicket in just 26.4 overs and there was no looking back.

Zheng loses to No 97 Siegemund, Osaka rallies to advance at the Australian Open

MELBOURNE, Jan 15: Distracted by a time penalty and unable to counteract No. 97-ranked Laura Siegemund's aggressive approach, Zheng Qinwen's loss in the second round Wednesday fell a long way short of last year's run to the Australian Open final.

Zheng lost the 2024 decider at Melbourne Park to Arvna Sabalenka and went on to win the Olympic gold medal in Paris and finish runner-up at the WTA Finals in a breakout season.

But her first tournament of the year ended in a 7-6 (3), 6-3 loss on John Cain Arena against 36-yearold Siegemund, who attacked from the first point and put Zheng off her game. Zheng needed a change of shoes early in the second set, got a time warning on her serve from the chair umpire - she said she couldn't clearly see the clock - and was worried about some minor issues which sidelined her before the Australian Open.

"I feel maybe today is not my day. There's a lot of details in the important points. I didn't do the right choice," Zheng said.

Of a weak serve that bounced before the net, Zheng said the time warning from the umpire "obviously that one really distracted me from the match." "This is my fourth year in the tour, and never happen that to me." Both of last vear's women's finalists were playing at the same time on nearby courts. Sabalenka, the two-time defending champion, extended her

run to 16 wins at Melbourne Park by winning the last five games to beat No. 54-ranked Jessica Bouzas Maneiro 6-3, 7-5, Naomi Osaka, another two-time Australian Open champion, reached the third round of a major for the first time since 2022 when she weathered an early barrage from U.S. Open semifinal-

ist Karolina Muchova before rallying to win 1-6, 6-1, 6-3. Osaka lost in the first round here

last year to Caroline Garcia in her comeback from maternity leave but avenged that with a first-round victory over Garcia this week.

Osaka will next meet Belinda Bencic, the Tokyo Olympic gold medalist who is playing in her first major since the birth of her daughter, Bella, last year.

MELBOURNE, Jan 15: Naomi Osaka's second-round match at the Australian Open could not possibly have started in a worse way. All of 21 minutes in, she sailed a forehand service return well long and, just like that, trailed 5-0.

Osaka strode to the sideline for the changeover, plopped herself down and draped a white towel over her head, blocking out all sights and leaving her with just her thoughts. She stayed like that throughout the break between games, even manoeuvering a water bottle under that towel to take a drink.

This was not a match against some unknown opponent, someone Osaka knew for sure she could beat. It was against 20thseeded Karolina Muchova, the runner-up at the 2023 French Open and a three-time semifinalist at other majors, including at Melbourne Park in 2021. Muchova also had defeated

Osaka in their two most recent matchups. None of that mattered on this afternoon, though: Osaka forgot about that disappointing
