Highly-trained 'clearance divers' skilled in deep diving on site: Navy

GUWAHATI, Jan 8: The rescue team deployed in the coal mine in Dima Hasao's Umrangso recovered the body of one of the nine trapped workers on Wednesday.

"The recovered body of the labourer was sent to Haflong for the post-mortem and after due procedure it will be handed over to the family," Harmeet Singh, Special DGP of Assam Police who has been looking after the rescue operation said.

Singh said that the de-watering of the tunnel has been done and the rescue team is exploring every option to extract water which are pouring from other channels.

HT Correspondent HAFLONG, Jan 8: The main streets of Haflong turned into a battleground of slogans on Wednesday as hundreds of BJP leaders and workers demand to remove the North Cachar Hills Autonomous Council (NCHAC) Chief Executive Member (CEM) Debolal Gorlosa.

The protesters accused Gorlosa of autocratic governance and chanted slogans like "BJP Zindabad," 'Narendra Modi Zindabad," and "Dr. Himanta Biswa Sarma Zindabad." The protestors also handed over a memorandum to the administration and party high command, calling for his immediate removal to safeguard the BJP's reputation in the region.

One protester strongly criticised Gorlosa's administration in Dima Hasao district and sought his imme-

diate removal from the post.

"He must be removed from his post for the good of

the party," the protester said. The rebellion within the BJP has reportedly been simmering for some time, with growing dissatisfaction over Gorlosa's leadership. Since the start of the New Year, dissident BJP leaders, activists, and supporters have intensified their protests.

The massive gathering reportedly involved thousands of BJP workers, effectively bringing Haflong town to a standstill.



# India can do 'frontier work' in Al, but investment a barrier: Nadella

NEW DELHI, Jan 8: India must get into frontier work in artificial intelligence and build foundational models, but investment is a real entry barrier and just one mathematical breakthrough can change entire dynamics, Microsoft Chairman and CEO Satya Nadella said here on Wednesday.

During his second day of Microsoft India AI Tour, Nadella said that India can do great work in the area of Indic languages and transforming its industries using artificial intelligence.

"There's no reason why India can't do frontier work, but you can even define frontier pretty unique. So for example, I don't think the last known big breakthrough in AI frontier has happened. I always say we are one mathematical breakthrough away from that entire edifice being thrown out and being going after something else," Nadella said.

He said academics in India, the research institutions, including Microsoft Research, are very fantastic math team and algorithms team.

"Let's not be bound, quite frankly, with what is considered frontier. So I would say India definitely should also do frontier work. Also use the frontier in order to. post training, to make it great for Indic languages, make it great for Indian industry, and so on," Nadella said. In response to a question by additional secretary in the IT ministry Abhishek Singh on whether India should build its own AI foundational model, Nadella said that India always has an option to do that but the real entry barrier in making foundational models is in-

He said the other way to look at the investment barrier is to lower the cost with the help of research, which is always open for India.

"I think that is the design space here is there for India to make some smart, strategic choice. And I'm not saying you shouldn't do like you know, but then you have to be mindful that it is a capital intensive business if you want to be on the frontier," Nadella

At present, India is using AI engines or the foundational models developed by OpenAI, Google etc.

At the event, Microsoft announced strategic part nerships with RailTel, Apollo Hospitals, Bajaj Finserv, Mahindra Group, and upGrad to help their teams and customers benefit from cloud and AI innovation. The company also signed an agreement with India AI to advance AI and emerging technologies in the country and establish AI Centre of Excellence and AI Productivity Labs to foster inclusive growth. "This critical care unit will be ready in one-and-half-years. We are going to develop a total of 28 such critical care units of around Rs 25 crore each across Assam. These centres will change the landscape of healthcare in Assam," he added.

Nadda's last programme was at the All India Institute of Medical Sciences (AIIMS)-Guwahati, located in Kamrup district. # Rupee plunges 13 paise to settle at new record low of 85.87 against US dollar

MUMBAI, Jan 8: The rupee extended its slide for the second straight session and declined 13 paise to hit a fresh record low of 85.87 (provisional) against the US dollar on Wednesday amid higher crude oil prices and stronger American currency.

Lacklustre sentiment in domestic equity markets and sustained outflow of foreign funds also played spoilsport even as investors stayed cautious over lower economic growth projection by the government, forex analysts said.

At the interbank foreign exchange, the rupee opened at 85.82 and touched the lowest-ever level of 85.89 against the greenback during intra-day. The unit settled at 85.87 (provisional) against the dollar, 13 paise lower than its previous close. On Tuesday, the rupee settled with a loss of 6 paise at 85.74 against the dollar.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.35 per cent higher at 108.76. The 10year US bond yields also remained elevated at 4.67 per cent amid expectations of delayed interest rate cuts by the Federal Reserve. Brent crude, the global oil benchmark, climbed 0.90 per cent to USD 77.74 per barrel in futures trade.

In the domestic equity market, the 30share BSE Sensex skid 50.62 points, or 0.06 per cent, to settle at 78,148.49 points, while the Nifty fell 18.95 points, or 0.08 per cent, to 23,688.95 points.

Foreign institutional investors (FIIs) offloaded ₹ 1,491.46 crore in the capital markets on a net basis on Tuesday, according to exchange data. The latest government data released on Tuesday showed India's economic growth rate is estimated to slip to a four-year low of 6.4 per cent in 2024-25 due to poor show by the manufacturing and services sectors. # Union Budget should reduce personal I-T for lower-income groups: EY India

NEW DELHI, Jan 8: The Budget is expected to focus on boosting private capex, tax simplification and reduction in personal income tax, particularly for the lower-income groups, to stimulate demand, EY India said.

The Union Budget for 2025-26 is scheduled to be presented in Parliament on February 1.

EY India, in its Budget expectation note, said with over ₹31 lakh crore stuck in income tax disputes as of 2023-24, there is an urgent need to clear Commissioner of Income Tax (Appeals) backlog and bolster alternate dispute resolution mechanisms like advance pricing agreements and safe harbours.

'While a full comprehensive review of the direct tax code may take time, we might see some initial steps towards its implementation in this Budget. I also hope for a reduction in personal income tax, particularly for the lower-income groups, to provide relief and stimulate demand," said Sameer Gupta, National Tax Leader, EY India.

EY said the expectations from Budget are focused on a set of strategic reforms that can propel the economy forward. With an emphasis on fiscal consolidation, tax system simplification, and invest-



ment-driven growth, the Budget is expected to lay a solid foundation for sustained economic develop-

EY anticipates significant reforms to simplify the tax system and improve taxpayer services, reduce litigation, and enhance tax compliance.

The government is already working on simplifying the Income Tax laws. It should follow a consultative approach and invite public comments on the draft proposals, EY said.

"Key areas of focus are likely to include enhancing public spend-

ing, reducing the fiscal deficit, incentivising private sector investment, and introducing targeted tax reforms that foster business innovation," EY said

In the last Budget, government had rationalised the capital gains structure in terms of holding period of assets and tax rates. The government may further address some of the unintended anomalies to make the rationalisation of capital gains more complete, EY said.

For instance, the holding period for capital assets, such as business undertakings in slump sales may be reduced from 36 months to 24

months and unlisted shares in IPO offer for sale (OFS) from 2 years to 1 year, aligning them with listed securities.

Gupta further said for businesses, particularly SMEs, reducing the complexity of tax compliance is critical.

To achieve sustainable growth in FY26, the government must prioritise reducing the fiscal deficit to 4.5 per cent of GDP in FY26 while reducing the debt-to-GDP ratio, which stands at 54.4 per cent, well above the fiscal responsibility and budget management (FRBM) target of 40 per cent. A medium-term real GDP

growth target of 6.5 per cent or higher will require boosting the aggregate investment rate (GFCF) measured at constant prices to 34 per cent. This can be achieved by increasing the government's capital expenditure, improving capital efficiency and encouraging states to enhance their investment spending. To stimulate private sector investment, a progressive reduction in interest rates should be considered. Additionally, targeted employment schemes should be fast-tracked to uplift urban demand and support economic momentum in FY26, EY said. (PTI)

The sit-in demonstration was organised by the All Bodo Students Union (ABSU) of Kokrajhar district committee, and supported by various social organisations including the Bodo Sahitya Sabha, Bodo Samaj, Harimu Afad, All Assam Tribal Sangha, All BTR Venture Senior Secondary School Employees' Association.

The protest demonstration started from 11 am and continued till 2 pm that highlighted their demand of the solutions to the issues and problems of the Bodo medium related educational environment.

A memorandum was submitted to the chief minister, Himanta Biswa Sarma through the district commissioner, Kokrajhar seeking immediate solutions to the issues and problems of the educational related and problems of the Bodo of Bodo in Key Examinations; recognition of Bodo as a subject in the Assam Judicial Service Exams and as Language I in the Central Teacher Eligibility Test (CTET).

The students union demanded infrastructure developments which include establishment of 35 new Bodo-medium model high schools and upgrading 101 high schools to higher secondary status, along with teacher recruitment.

The students' union demanded provincialisation of the educational institutions through the implementation of Clause 6.3 of the BTR Peace Accord for provincialisation of venture schools across the state.

The students' union also demanded recruitment of educational staff to have the better welfare and upliftment of the educational environment and said that appointment of academic officers, translators, lecturers, and teachers for Bodomedium institutions and related departments.

"Introduction of Bodo in Model Degree Colleges in Baksa, Dhudnoi, and Balipara, and distribution of Bodo-language educational materials in Anganwadi centers across the region," the union said.

The students union also sought a support for colleges outside BTR with initiating recruitment of assistant professors for Bodo departments in 10 colleges outside the Bodoland Territorial Region

The students union demanded teacher transfer of teachers of proficient in Bodo to Bodo-medium



"In a decisive move to address the long-pending educational demands of the Bodo community and highlight the Government of Assam's failure to prioritise these issues, the All Bodo Students Union (ABSU) carried out statewide sit-in demonstration today at every district headquarters in Assam in a peaceful protest", the students union leaders said.

# New job scopes by 2030

he Future of Jobs Report 2025, just released by the World Economic Forum, reveals that job disruption will equate to 22% of jobs by 2030, with 170 million new roles set to be created and 92 million displaced, resulting in a net increase of 78 million jobs. Technological advancements, demographic shifts, geo-economic tensions and economic pressures are the key drivers of these changes, reshaping industries and professions worldwide. Drawing on data from over 1,000 companies, the report finds that the skills gap continues to be the most significant barrier to business transformation today. Technology skills in AI, big data and cybersecurity are expected to see rapid growth in demand, but human skills, such as creative thinking, resilience, flexibility and agility, will remain critical. A combination of both skill types will be increasingly crucial in a fast-shifting job market. Frontline roles and essential sectors like care and education are set for the highest job growth by 2030, while advances in AI and renewable energy are reshaping the market - driving an increase in demand for many technology or specialist roles while driving a decline for others, such as graphic designers.

Frontline roles, including farm workers, delivery drivers and construction workers, are poised to see the largest job growth in absolute terms by 2030. Significant increases are also projected for care jobs, such as nursing professionals, and education roles, such as secondary school teachers, with demographic trends driving growth in demand across essential sectors. Meanwhile, advances in AI, robotics and energy systems – notably in renewable energy and environmental engineering – are expected to increase demand for specialist roles in these fields. Meanwhile, roles such as cashiers and administrative assistants remain among the fastest declining but are now joined by roles including graphic designers as generative AI rapidly reshapes the labour market. While technology skills in Al, big data and networks and cybersecurity are expected to see the fastest growth in demand, human skills such as analytical thinking, cognitive skills, resilience, leadership and collaboration will remain critical core skills.

A combination of both skillsets will increasingly be required by many growing jobs. According to the Report Al is reshaping business models, with half of employers globally planning to reorient their business to target new opportunities resulting from the technology. The most common workforce response to these changes is expected to be upskilling workers, with 77% of employers planning to do so. However, 41% plan to reduce their workforce as AI automates certain tasks. Almost half of employers expect to transition staff from roles exposed to Al disruption into other parts of their business, an opportunity to alleviate skills shortages while reducing the human cost of technological transformation. By prioritizing equitable and inclusive workforce transitions and strategies - and supporting workers through these transformations - stakeholders can build a resilient and adaptable global workforce that is prepared to thrive in the jobs of

# The politics of memorials

There is an urgent need for merit-based naming of public institutions. India must end the politicization of national assets, recognize achievers in diverse fields, and ensure recognition fosters inspira-

The passing of former Prime Minister Dr Manmohan Singh was marred by controversy over his Samadhi Sthal (final resting place), as his party unnecessarily stirred a dispute over a memorial. This incident reflects the party's consistent disregard for a leader whose immense contributions were sidelined in life and death. Dr Singh, a visionary economist and the architect of India's economic liberalization, transformed the nation's financial landscape as Finance Minister. His legacy deserves to be honored through initiatives like naming an economics research institute or library after him, inspiring students and researchers for generations.

The names of prominent experts, artists, scientists, and achievers who have significantly contributed to the nation's progress should only be associated with institutions relevant to their fields. However, in India, the opposite is often true. Actor Rishi Kapoor once openly criticized the absurdity of naming public resources, like roads, airports, and institutions, after political figures, advocating instead for recognizing achievers in art, science, and sports. Unfortunately, this wisdom has rarely been followed.

A glaring example of political overreach is the oldest national party's fixation with linking their family members' names to government schemes and infrastructure as if they owned the country and its public properties. Data reveals that over 449 schemes, along with 378 roads and streets, have been in the names of Indira and Rajiv. This excessive politicization reduces national resources to political propaganda tools, stifling recognition for deserving contributors in various fields. Some regional parties, like Shiv Sena in Maharashtra, also repeated this objectionable

Such practices contradict the spirit of democracy. Public assets belong to the nation, not to political dynasties. Naming a medical college after a pioneering surgeon or an airport after a legendary aviator would better reflect the contributions of individuals who shaped those fields. It's time to end the misuse of public infrastructure for political gain. Establishing an equitable system for naming national assets ensures merit-based recognition, fostering inspiration and fairness.

Public places like airports, hospitals, educational institutions, and roads are constructed using public funds, not personal resources. These are national assets belonging to the citizens of the country. As such, no political party or individual should be permitted to use their names for personal or political branding. Political leaders are merely temporary custodians of power, not the owners of public properties. They must govern responsibly and inclusively, not indulge in self-aggrandizement at the expense

of the nation's collective resources. The absence of a standardized mechanism to prevent and rectify such misuse allows this practice to continue unchecked. A fair and transparent framework should be established to govern the naming of public infrastructure, ensuring that the process is free from political bias. This mechanism could include criteria such as the individual's contributions to society, relevance to the field, and public consensus. For instance, an educational institution could be named after an esteemed educator, while a research center could honor a pioneering scientist. Such a system would preserve the sanctity of public spaces while encouraging a culture of meritocracy and fairness.

India is at a critical crossroads, and the need to depoliticize public resources is more crucial than ever. Instituting a merit-based system for naming public institutions would honor the right individuals and inspire the next generation. By shifting the focus from political favoritism to genuine recognition, the nation can take a significant step toward fostering a more equitable and democratic society. # GAZA: A world watching in silence as children pay the price

wo weeks ago, the world seemed to witness the faint glimmer of hope for peace in Gaza, as talks of a ceasefire edged closer to success. It was a brief moment of optimism, a fleeting possibility that even in the most bitter conflicts, humanity might find a way to end the suffering. Yet, as often happens in this fractured world, that prospect swiftly receded. The ceasefire talks once again foundered, leaving behind only the cold reality of an ongoing tragedy. But, as if by some cruel irony, the world did manage to reach a consensus on another matter at the outset of hostilities—one that demands no debate, no controversy, and, most tragically, no intervention. This grim consensus centers on

Gaza as a place where children, along with countless other innocent victims, can be killed, maimed, starved, and orphaned, all with little to no consequence. There is no global outcry strong enough to shift the moral compass; instead, the perpetrators whether governments or militias—invoke self-defense or righteous indignation to justify the unimaginable suffering. The numbers are staggering. According to UNICEF, by mid-December, at least 14,000 children had perished as part of the 45,000 total deaths in Gaza—deaths not including those who remain unaccounted for, buried beneath rubble or still missing. As tragic as it is, the true toll is far more horrific than statistics can reflect.

The impact on Gaza's youngest is devastating. Save the Children reported that 30% of the children killed by October 10 were under the age of five, with 6% of them not even having reached their first birthday. Among them, a tragic 169 children had been born after the conflict began, brought into a world where the hope of a future was already extinguished. The UN Office for the Coordination of Humanitarian Affairs (OCHA) estimated that by October 30, 35,000 children had lost one or both parents, and over a million children had been displaced from their homes, some with nothing left but hunger and fear. Yet beyond the measurable physical toll, there is the psychological devastation: a survey by War Child Alliance found that 96% of Gaza's children are mentally disoriented, living in a constant state of fear and anxiety, awaiting their inevitable death. The very notion that children should even have the capacity to fear death is a grotesque indictment of the human race.

What is perhaps most disturbing about the ongoing massacre of children in Gaza is not just the scale of the tragedy but the international indifference that it continues to engender. While the world knows what is happening, there is a conspicuous lack of outrage or action. News outlets, once overflowing with images of innocent lives lost, now relegate the conflict to mere footnotes or the ticker at the bottom of the screen. For most, it is business as usual, as the international order, which in theory should protect the most vulnerable, continues to function as a ruthless engine of war. The official narrative has become predictable: Israel claims to target terrorists. and the death toll among civilians is framed as "collateral damage" or minimized with claims of military necessity. Casualties among children are never highlighted directly, and the numbers are rarely treated as a tragedy in their own right. Instead, the rhetoric of "selfdefense" and "the fight against terrorism" provides cover for atrocities that would otherwise be deemed unacceptable in any other context.

The world, however, is not devoid of conscience. There are still a few voices that refuse to be silent, though they remain outliers in the broader global conversation. International organizations such as the United Nations, along with groups like UNICEF and Save the Children, continue to expose the enormity of the suffering, but their voices are drowned out by the prevailing geopolitical realities. The United States, a staunch ally of Israel, continues to block resolutions at the United Nations calling for ceasefires or international intervention, having vetoed 49 such resolutions in the past few decades, including four just last vear. This complicity is not merely a matter of diplomacy—it is a moral failing. Despite publicly acknowledging the toll on civilians, including children, the United States remains steadfast in its support for Israel, supplying it with the arms necessary to prolong the conflict. This is not just a failure of political will; it is a failure of humanity itself

The position of India in this global debate is equally troubling. As a democracy that prides itself on its moral standing, India has been hesitant to take a clear stand on the side of Palestinian children. While some within India express pro-Palestinian sentiments, the government's reluctance to act decisively is perplexing. India has abstained from several UN resolutions calling for a ceasefire, choosing instead to sidestep the issue with feigned neutrality. The political discourse around Palestine in India has also been tainted by domestic politics. When public figures, like Priyanka Gandhi, expressed solidarity with Palestine, they were met with accusations of "appeasement." There was no such outrage when Israeli actions were presented as a symbol of jobs and welfare for Indian workers, even as the cost was measured in the lives of innocent civilians in Gaza. At the heart of this global tragedy is the notion that Israel's actions in Gaza its occupation its military campaigns, its systemic violations of international law-are increasingly accepted by the global community, or at the very least, ignored. The ongoing war, which began with a brutal terrorist attack by Hamas against Israel, resulting in 1,200 deaths and the capture of hostages, has now taken on an inverse logic: the death toll among Palestinians, particularly children, has so far outstripped the Israeli casualties, yet the global focus continues to shift, not toward peace or accountability, but toward justifications and the unrelenting pursuit of vengeance. The

initial attack on Israel, which sparked widespread international condemnation, is now used to explain away the mounting Palestinian deaths—an attempt to place the blame on the victims themselves. And yet, amid all of this, the true tragedy of Gaza-the deaths of thousands of children, the anguish of a million displaced souls—remains the elephant in the room. It is as though the world cannot bear to face the human cost of its geopolitical choices. The language used to describe the carnage—"civilian deaths," "collateral damage," "acceptable losses"serves to desensitize us to the fact that these are not just statistics. They are children, born into a world of violence and despair, whose futures have been cruelly stolen from them. In the end, the tragedy of Gaza

is not simply a matter of politics or military strategy. It is a profound moral failure on the part of the global community. The lives of children, the most innocent and vulnerable members of society, must never be so easily sacrificed in the name of war, self-defense, or national interest. Yet this is precisely what has happened. The silence that surrounds Gaza's suffering is a silence we must all bear responsibility for. Until the world can collectively acknowledge this moral failure, the ghosts of the children who have died in this conflict will continue to haunt us, pleading for a world where innocence is no longer a casualty of geopolitics. uman metapneumovirus, part of the Pneumoviridae family, is a respiratory virus that causes illnesses ranging from mild colds to more severe lung infections such as pneumonia and bronchiolitis. Although less recognized than flu or respiratory syncytial virus, human metapneumovirus is an important cause of respiratory illnesses worldwide, especially during winter and spring. The virus poses a particularly great risk to vulnerable populations such as young children, the elderly, pregnant women, and people with weakened immune systems. The virus can cause great difficulties for them, so it is important to raise awareness and take preventive measures. Infants and young children are particularly vulnerable to severe respiratory conditions such as bronchiolitis and pneumonia.

Older adults, 65 years of age or older, as well as people with chronic health problems such as asthma or COPD, are more likely to have complications. During pregnancy, HMPV can cause respiratory problems, which can put the health of both mother and baby at risk. People who have weakened immune systems, whether due to a medical condition or treatment such as chemotherapy, are at higher risk of having severe

symptoms. A recent outbreak of hMPV in China has highlighted the potential seriousness of this virus, especially in vulnerable groups. Most infections occurred in children under 14 years of age, with many cases requiring hospitalization due to their severity. Symptoms range from persistent cough and fever to more serious conditions such as bronchiolitis and pneumonia. Its similarity to other respiratory illnesses complicates diagnosis and treatment.

To prevent its spread, health authorities in China have emphasized preventive measures such as hand washing, wearing masks, and timely testing. Symptoms of HMPV in adults often resemble the common cold or flu. These include persistent cough, frequent mucus production, nasal congestion or runny nose, fever, usually mild to moderate fatigue and general body aches, sore throat, and shortness of breath in severe cases. Children are more likely to have severe symptoms. Human metapneumovirus is highly contagious and spreads through a variety of means. The virus can spread when an infected person coughs, sneezes, or talks, causing respiratory droplets to spread into the air. The virus can also spread through physical contact with an infected person, especially if someone touches their face, eyes, or mouth. The virus can persist on surfaces,

and touching contaminated objects such as doorknobs or mobile devices increases the risk of infection. Small respiratory particles can remain suspended in the air, especially

in crowded or poorly ventilated spaces. Symptoms of human metapneumovirus resemble those of other respiratory infections, making accurate diagnosis dependent on specific laboratory tests. This molecular test detects the genetic material of the virus with high accuracy and is considered the gold standard for diagnosing human metapneumovirus. Rapid antigen tests give quick results but are less sensitive than PCR tests. Most people recover from human metapneumovirus in about 7 to 10 days without complications. However, certain groups are at higher risk of serious complications. Human metapneumovirus can cause viral pneumonia, with severe cases requiring hospitalization and intensive care. Infants and young children often experience inflammation and blockage of the airways, leading to difficulty breathing and wheezing. Human metapneumovirus can worsen existing respiratory conditions such as asthma or chronic obstructive pulmonary disease. These infections, such as bacterial pneumonia, can develop as complications due to a weakened immune system. Respiratory complications caused by human metapneumovirus during pregnancy may risk maternal and fetal health Human metapneumovirus has no specific

antiviral medication. The main goal of treatment is to manage symptoms and prevent complications. It is essential to recover and maintain strength. Medications such as acetaminophen or ibuprofen can control fever and body aches. In severe cases, supplemental oxygen or mechanical ventilation may be needed. Patients with complications such as pneumonia may need to be closely monitored in the hospital. To prevent HMPV, it is important to focus on preventive measures, as there is currently no vaccine available. To reduce the risk of infection, follow these measures. Wash your hands with soap and water for at least 20 seconds. Use an alcohol-based hand sanitizer when soap and water are not available. Stay away from individuals who show symptoms of respiratory illness. Avoid crowded areas during outbreaks. Be sure to regularly clean surfaces that are frequently touched, such as door handles, phones, and countertops. Wearing a mask during an outbreak or flu season can help reduce exposure to respiratory droplets. If you have any symptoms, it is important to stay home to prevent the spread of the virus. Being aware of human metapneumovirus and its potential impact is important for early detection and prevention.

As a result, millions of people died from radioactive radiation in the atmosphere until 32 years later, and many people suffered from various abnormal diseases. But even today, various countries are overzealous in developing nuclear bombs and bringing the destruction of the world closer. In addition, the increasing number of rockets, space missions, satellite launches, and aircraft movements in the upper atmosphere has depleted the ozone layer in the stratosphere, allowing the sun's ultraviolet rays to enter the Earth One foreshadowing a deadly future. Today, another serious environmental problem is rising global warming. Gases like carbon dioxide increase the temperature of the 



atmosphere. Therefore, it is necessary to take measures to prevent the destruction of trees and shrubs. A team of UN experts believes that if these temperatures are not reduced immediately, global temperatures will rise unprecedentedly within 35 years. It is true that no government or department can succeed in environmental development or conservation without public awareness and community involvement in environmental conservation. However, such measures will not go far unless every citizen of the country is aware of himself. We need to be vigilant today to avoid the extreme disasters caused by serious environmental pollution. It is imperative today that we control pollution at least to some extent through tree planting, population control, scientific disposal of waste from factories and industries. # India's forest cover increases but declines in biodiversity-rich areas

The Forest Survey of India has released its 18th India State of Forest Report, indicating a marginal increase in India's forest and tree cover. However, a concerning trend shows a decline in forest cover across several biodiversity-rich areas.

The report, released a year later than scheduled, highlights trends in forest cover change, degradation, agroforestry, carbon sink, mangroves, and forest fires. According to the report, India's total forest and tree cover is 8,27,357 square kilometres, accounting for 25.17% of the country's geographical area. This includes 7,15,343 sq km (21.76%) of forest cover and 1,12,014 sq km (3.41%) of tree cover.

The report claims an increase of 1,446 square km in forest and tree cover since 2021, comprising a forest cover increase of 156 sq km (0.2%) and a tree cover increase of 1,289 sq km (1.16%). It categorises forest data into recorded forest areas which largely consists of the reserved forests and protected forests and non-notified

While recorded forest areas show a minor increase of 7.28 sq km, 20 states and union territories report a decline in the category. States like Andhra Pradesh, Arunachal Pradesh, Assam, Chhattisgarh, Madhya Pradesh, Maharashtra, Tamil Nadu, Telangana, and the majority of North East states have registered negative growth in the recorded forest area. In contrast, non-notified forests have increased by 149 sq km.

A former Principal Chief Conservator of Forests and Head of Forest Force, Karnataka, BK Singh finds something amiss. He says, "In India, plantation is happening in 18,000 sq km annually. But the total forest and tree cover increase is merely 1,400 sq km in two years. It is a total mismatch." What is happening to the plantations? He asked. "Either the forests are being cut, and plantations are partly supplementing, or a major chunk of plantations are failing. It must be exam-

Singh says, "Though there are success stories in bits and pieces, the latest ISFR [India State of Forest Report] largely creates a disappointing picture."

Decline in eco-sensitive regions

The report paints a rosy picture, claiming an overall forest and tree cover increase. However, eco-sensitive zones like the Western Ghats, Himalayan states, and the Andaman & Nicobar Islands have witnessed a decline in forest cover. Over the past decade, the Western Ghats Eco-Sensitive Areas have lost 58.22 sq km of forest cover, while the latest assessment shows 327 sq km decrease in the northeastern region. Recorded forest areas in the Andaman & Nicobar Islands have also declined.

Debadityo Sinha, a Senior Resident Fellow and Lead of the Climate & Ecosystems team at Vidhi Centre for Legal Policy, says that report highlights that the prime natural forest and eco-sensitive zone are threatened, and the country is moving towards the planted forest. The report boasts of increased carbon sequestration due to

an increase in plantation, but it remains silent on carbon unlocked due to increased deforestation.

The report also provides a glimpse into deforestation trends in the last decade from 2011 to 2021, through its tree canopy density classification. Forests are categorised as Very Dense Forest (VDF, ≥70% canopy density), Moderately Dense Forest (MDF, 40%-70% canopy density), and Open Forest (OF, 10%-40% canopy density). Alarmingly, 46,707 sq km of VDF, MDF, and OF have degraded into non-forest areas, while 5,573 sq km have turned into scrub. Over the past decade, 40,709 sq km of forests have lost density, shifting from VDF and MDF to OF.

Calling it a massive change in the quality of existing forests, Sinha says there is a need for a proper study to understand how much carbon gets unlocked when natural forests are cut. Forest Survey of India should include this aspect in its biennial report when it shares the increased potential of carbon sink due to an increase in forest and tree cover.

Agroforestry increases, mangrove cover falls The latest forest survey dedicates a chapter on agroforestry, a land use system that integrates trees and shrubs on farmlands and rural landscapes. It claims that 21 states and UTs have shown an increasing trend in tree cover, which indicates that agroforestry is being promoted here. The report estimates the total tree cover under agroforestry in 2023 at 1,27,590 sq km, including trees with a Diameter at Breast Height (DBH) of 5 to 10 cm and bamboo. Agroforestry has grown by 20.02% over the past decade, from 2013 to 2023

The total growing stock (sum of all trees by number or volume) under agroforestry in the country is estimated at 1,291.68 M m3 in 2023, an increase of 286.94 M m3 (28.56 %) since 2013. Maharashtra, Karnataka, Odisha, and Rajasthan have the highest growing stock under agroforestry among states, while Jammu & Kashmir, Andaman & Nicobar, Dadra & Nagar Haveli and Daman & Diu lead among UTs.

Singh underlines an issue related to accuracy by saying that agroforestry is, by and large, tree cover and not forest cover. The tree cover is not included in the satellite imagery assessment. The researchers studied 42,972 sampled plots to estimate the tree cover and extrapolated the findings. So, accuracy is not as high as that of the satellite imagery interpretation, but agroforestry has been growing, and this is a good sign, he said, adding, 'So we are unable to hold on to our forest, but

we are able to grow agroforestry.' On the other hand, the report highlights a decrease in mangrove cover. India's total mangrove cover is 4,991 sq km, accounting for 0.15% of the country's geographical area. Very dense mangroves constitute 29.33%, moderately dense mangroves represent 30.07%, and open mangroves comprise 40.60%. Since 2021, mangrove cover has decreased by 7.43 sq km, with notable declines of 36.39 sq km in Gujarat and reductions of 4.65 sq km in the Andaman and Nicobar Islands. However, Andhra Pradesh and Maharashtra have seen increases of 13.01 sq km and 12.39 sq km, respectively.

Sinha underscores the importance of studying the reasons behind the decline in Gujarat and the Andaman & Nicobar Islands, as mangroves play a vital role in mitigating climate change and protecting coastal ecosystems. (Courtesy: Scroll.in)

# Biomedical waste is dangerous

Tealthcare activities protect and restore health and save lives. But what about the waste and by-products they generate? About 85% of the total waste generated by healthcare activities is normal, nonhazardous waste comparable to household waste. The remaining 15% is considered hazardous material that may be infectious, chemical, or radioactive. Measures to ensure safe and environmentally sound management of healthcare waste can prevent adverse health and environmental effects from such waste, including unintended release of chemical or biological hazards. Healthcare waste contains potentially harmful microorganisms that can infect hospital patients, healthcare workers, and the general public. Other potential hazards may include drug-resistant microorganisms that spread from healthcare facilities to the environment. Adverse health outcomes associated with healthcare waste and by-products also include injuries from sharp objects; exposure to pharmaceutical products, particularly antibiotics and cytotoxic drugs and substances such as mercury or dioxins, released into the surrounding environment during the handling or incineration of healthcare waste; chemical burns arising in the context of disinfection, sterilization or waste treatment activities; air pollution resulting from the release of particulate matter during medical waste incineration; thermal injuries associated with open burning and the operation of medical waste incinerators; radiation burns; and the spread of antimicrobial resistance through unsafe storage, treatment and disposal of pharmaceutical waste. Several reasons exist for inadequate healthcare waste services. These include limited legal frameworks (e.g., policies, regulation, guidelines), lack of awareness of the health hazards associated with

healthcare waste, inadequate training in proper waste management, absence of waste management and disposal systems, inadequate financial and human resources, and low priority. Many countries either do not have proper regulations or do not monitor and enforce them.

Worldwide, an estimated 16 billion injections are performed each year. Not all needles and syringes are disposed of safely, creating risks of injury and infection and opportunities for reuse. Injecting with contaminated needles and syringes has decreased significantly in low- and middle-income countries in recent years, partly due to efforts to reduce the reuse of injection equipment. Despite this progress, unsafe injections were still responsible for 33,800 new HIV infections, 1.7 million hepatitis B infections, and 315,000 hepatitis C infections. A person who experiences a needlestick injury from a needle used on an infected source patient has a 30%, 1.8%, and 0.3% risk of becoming infected with HBV, HCV, and HIV, respectively. Additional hazards arise during cleanup at waste disposal sites and during the handling and manual sorting of hazardous waste from healthcare facilities. These practices are common in many regions of the world, especially in low- and middle-income countries. Waste handlers face an immediate risk of needlestick injuries and exposure to toxic or infectious substances. The treatment and disposal of healthcare waste can also pose indirect health risks through the release of pathogens and toxic pollutants into the environment.

Disposal of untreated healthcare waste in landfills can lead to contamination of drinking, surface, and ground water if those landfills are not properly constructed. Minimizing healthcare waste should be a priamount of waste that needs to be handled and

treated. Waste minimization actions include green purchasing and selecting products where shipping is minimized and have less and ecological packaging, switching to reusable products when safe and feasible, ordering/receiving pharmaceuticals only based on documented need, and recycling common items including plastics, paper, and cardboard. Treatment of healthcare waste with chemical disinfectants can result in chemical substances being released into the environment if those substances are not handled, stored, and disposed of in an environmentally friendly manner.

Managing healthcare waste requires greater attention and diligence to avoid the adverse health outcomes associated with poor practice, including exposure to infectious agents and toxins. Key elements to improving healthcare waste management are to promote practices that reduce the amount of waste generated and ensure proper waste segregation; develop strategies and systems, along with strong monitoring and regulation, to progressively improve waste segregation, destruction, and disposal practices with the ultimate aim of meeting national and international standards: favour safe and environmentally friendly treatment of hazardous healthcare waste (e.g., autoclaving, microwaving, integrated steam treatment with internal mixing, and chemical treatment) over medical waste incineration, where possible; create a comprehensive system, responsibilities, resource allocation, and select safe and environmentally friendly management options to protect people from hazards when collecting, handling, storing, transporting, treating, or disposing of waste. Universal, long-term reform requires government commitment and support, although immediate action can be taken at the local level. (The ority. # That Arctic blast can feel brutally cold, but how much colder than 'normal' is it really?

n Arctic blast hitting the central and eastern US in early January 2025 is creating fiercely cold conditions in many places. Parts of North Dakota dipped to more than 20 degrees below zero, and people as far south as Texas woke up on Jan. 6 to temperatures in the teens. A snow and ice storm across the middle of the country added to the winter chill.

Forecasters warned that temperatures could be "10 to more than 30 degrees below normal" across much of the eastern two-thirds of the country during the first full week of the year. But what does "normal" actually mean?

While temperature forecasts are important to help people stay safe, the comparison to "normal" can be quite misleading. That's because what qualifies as normal in forecasts has been changing rapidly over the years as the planet warms.

**Defining normal** One of the most used standards for defining a science-based "normal" is a 30-year average of temperature and precipitation. Every 10 years, the National Center for Environmental Information updates these "normals," most recently in 2021. The current span considered "normal" is 1991-2020. Five years ago, it was

But temperatures have been rising over the past century, and the trend has accelerated since about 1980. This warming is fueled by the mining and burning of fossil fuels that increase carbon dioxide and methane in the atmosphere. These greenhouse gases trap heat close to the planet's surface, leading to increasing temperature.

Because global temperatures are warming, what's considered normal is warming, too. So, when a 2025 cold snap is reported as the difference between the actual temperature and "normal," it will appear to be colder and more extreme than if it were compared to an earlier 30-year average. Thirty years is a significant portion of a human life. For people under age 40 or so, the use of the most recent averaging span might fit with what they have experienced.

But it doesn't speak to how much the Earth has warmed. How cold snaps today compare to the past

To see how today's cold snaps – or today's warming – compare to a time before global warming began to accelerate, NASA scientists use 1951-1980 as a baseline.

The reason becomes evident when you compare maps For example, January 1994 was brutally cold east of the Rocky Mountains. If we compare those 1994 temperatures to today's 'normal" – the 1991-2020 period – the US looks a lot like maps of early January 2025's temperatures: Large parts of the Midwest and eastern US were more than 7 degrees Fahrenheit (4 degrees

Celsius) below "normal," and some areas were much colder. But if we compare January 1994 to the 1951-1980 baseline instead, that cold spot in the eastern U.S. isn't quite as large or extreme. Where the temperatures in some parts of the country in January 1994 approached 14.2 F (7.9 C) colder than normal when compared to the 1991-2020 average, they only approached 12.4 F (6.9 C) colder than the 1951-1980 average. As a measure of a changing climate, updating the average 30-year baseline every decade makes warming appear smaller than it is, and it makes cold snaps seem more extreme. (Courtesy: Down to Earth)

"All hell will break out. If those hostages aren't back, I don't want to hurt your negotiation, if they're not back by the time I get into office, all hell will break out in the Middle East," Trump told reporters at a news conference in Mar-a-Lago, Florida.

Trump will be sworn in on January 20 as the 47th President of the United States.

He was responding to a question on the status of negotiations with Hamas on the release of American hostages. His Special Envoy to the Middle East Steven Charles Witkoff, who has just returned from the region, told reporters that they are on the verge of it.

"I tell this, I don't want to hurt the negotiation. If the deal isn't done before I take office, which is now going to be two weeks, all hell will break out in the Middle East,' Trump said.

The first ceasefire - weeks after the October 7 attack – saw the release of dozens of hostages, but subsequent efforts to pause the fighting and secure the release of additional hostages have gone

# Thousands flee as wildfires burn out of control in, around Los Angeles



LOS ANGELES, Jan 8: California firefighters battled wind-whipped wildfires that tore across the Los Angeles area, destroying homes, clogging roadways as tens of thousands fled and straining resources as officials prepared for the situation to worsen early

The flames from a fire that broke out Tuesday evening near a nature preserve in the inland foothills northeast of LA spread so rapidly that staff at a senior living centre had to push dozens of residents in wheelchairs and hospital beds down the street to a parking lot. The residents waited there in their bedclothes as embers fell around them until ambulances, buses and even construction vans arrived to take them to safety.

Another blaze that started hours earlier ripped through the city's Pacific Palisades neighbourhood, a hillside area along the coast dotted with celebrity residences and memorialised by the Beach Boys in their 1960s hit "Surfin' USA."

In the frantic haste to get to safety, roadways became impassable when scores of people abandoned their vehicles and fled on foot, some toting suitcases.

The traffic jam on Palisades Drive prevented emergency vehicles from getting through and bulldozer was brought in to push the abandoned cars to the side and create a path. Video along the Pacific Coast Highway showed widespread destruction of homes and businesses along the famed roadway.

Pacific Palisades resident Kelsey Trainor said the only road in and out of her neighbourhood was blocked. Ash fell all around them while fires burned on both sides of the road.

"We looked across and the fire had jumped from one side of the road to the other side of the road," Trainor said. "People were getting out of the cars with their dogs and babies and bags, they were crying and screaming." A third wildfire started around 10.30 pm compted evacuations in Sylmar, a San Fernando Valley community that is the northernmost neighbourhood in Los Angeles. The causes of all three fires were under investigation.

Flames were being pushed by Santa Ana winds topping 60 mph (97 kph) in some places. The winds were expected to increase overnight, producing isolated gusts that could top 100 mph (160 kph) in mountains and foothills — including in areas that haven't seen substantial rain in months.

The situation prompted the Los Angeles Fire Department to take the rare step of putting out a plea for off-duty firefighters to help. It was too windy for fire-

fighting aircraft to fly, further hampering the fight. The erratic weather caused President Joe Biden to cancel plans to travel to inland Riverside County, where he was to announce the establishment of two new national monuments in the state.

He remained in Los Angeles, where smoke was vis-

The Federal Emergency Management Agency approved a grant to help reimburse California for the firefighting cost.

Officials didn't give an estimate of structures damaged or destroyed in the Pacific Palisades wildfire. but they said about 30,000 residents were under evacuation orders and more than 13,000 structures were under threat. Gov. Gavin Newsom visited the scene and said many homes had burned.

By evening the flames had spread into neighbouring Malibu and several people there were being treated for burn injuries and a firefighter had a serious head injury and was taken to a hospital, according to Los Angeles Fire Department Capt. Erik Scott.

Things were expected to worsen overnight. "By no stretch of the imagination are we out of the woods," Newsom warned residents, saying the worst of the winds were expected between 10 pm Tuesday and 5

am Wednesday. He declared a state of emergency. As of Tuesday evening, nearly 167,000 people were without power in Los Angeles county, according to the tracking website PowerOutage.us, due to the strong winds.

Recent dry winds, including the notorious Santa Anas, have contributed to warmer-than-average temperatures in Southern California, where there's been very little rain so far this season. Southern California hasn't seen more than 0.1 inches (0.25 centimetres) of rain since early May.

The Pacific Palisades fire started around 10.30 am and quickly consumed about 4.6 square miles (11.6 square kilometres) and sent up a dramatic plume of smoke visible across Los Angeles. The neighbourhood, which borders Malibu about 20 miles (32 kilometres) west of downtown LA, includes hillside streets of tightly packed homes along winding roads nestled against the Santa Monica Mountains and stretches down to beaches along the Pacific Ocean.

Long-time Palisades resident Will Adams said he immediately went to pick his two kids up from St. Matthews Parish School when he heard the fire was nearby. Meanwhile, he said embers flew into his wife's car as she tried to evacuate.

"She vacated her car and left it running," Adams said. She and many other residents walked down toward the ocean until it was safe.

Adams said he had never witnessed anything like this in the 56 years he's lived there. He watched as the sky turned brown and then black as homes started burning. He could hear loud popping and bangs "like small explosions," which he said he believes were the transformers exploding. "It is crazy, it's everywhere, in all the nooks and crannies of the Palisades. One home's safe, the other one's up in flames," Adams said. Actor James Woods posted footage of flam burning through bushes and past palm trees on a hill near his home. The towering orange flames billowed among the landscaped yards between the homes.

"Standing in my driveway, getting ready to evacuate," Woods said in the short video on X.

Some trees and vegetation on the grounds of the Getty Villa were burned by late Tuesday, but staff and the museum collection remain safe, Getty President Katherine Fleming said in a statement. The museum located on the eastern end of the Pacific Palisades is a separate campus of the world-famous Getty Museum that focuses on the art and culture of ancient Greece and Rome. The fire also burned Palisades Charter High School.

Film studios cancelled two movie premieres due to the fire and windy weather, and the Los Angeles Unified School District said it temporarily relocated students from three campuses in the Pacific Palisades

# 'It should be a woman. Long ago it should have been, but thank God' Pope Francis has named first woman to head major Vatican office, choosing Italian nun

Monday named the first woman to head a major Vatican office, appointing an Italian nun, Sister Simona Brambilla, to become prefect of the department responsible for all the Catholic Church's religious

The appointment marks a major step in Francis' aim to give women more leadership roles in governing the church. While women have been named to No. 2 spots in some Vatican offices, never before has a woman been named prefect of a dicastery or congregation of the Holy See Curia, the central governing organ of the Catholic Church.

The historic nature of Brambilla's appointment was confirmed by Vatican Media, which headlined its report "Sister Simona Brambilla is the first woman prefect in the

The office is one of the most important in the Vatican. Known officially as the Dicastery for the Institutes of Consecrated Life and Societies of Apostolic Life, it is responsible for every religious order, from the Jesuits and Franciscans to the Mercy nuns and smaller newer

The appointment means that a

women who do much of the church's work — the world's 600.000 Catholic nuns — as well as the 129,000 Catholic priests who belong to religious orders.

"It should be a woman. Long ago it should have been, but thank God," said Thomas Groome, a senior professor of theology and religious education at Boston College who has long called for the ordination of women priests. "It's a small step along the way but symbolically, it shows an openness and a new horizon or possibility."

Groome noted that nothing theologically would now prevent Francis from naming Brambilla a cardinal, since cardinals don't technically have to be ordained priests. Naming as a cardinal "would be

automatic for the head of a dicast-

ery if she was a man," he said. But in an indication of the novelty of the appointment and that perhaps Francis was not ready to go that far, the pope simultaneously named as a co-leader, or "pro-prefect," a cardinal: Ángel Fernández

The appointment, announced in the Vatican daily bulletin, lists Brambilla first as "prefect" and

Artime, a Salesian.



Fernández second as her co-leader. Theologically, it appears Francis believed the second appointment was necessary since the head of the office must be able to celebrate Mass and perform other sacramental functions that currently can only be done by men.

Natalia Imperatori-Lee, chair of the religion and philosophy department at Manhattan University, was initially excited by Brambilla's appointment, only to learn that Francis had named a male co-prefect.

"One day, I pray, the church will see women for the capable leaders they already are," she said. "It's ridiculous to think she needs help running a Vatican dicastery. Moreover, for as long as men have been

in charge of this division of Vatican governance, they have governed men's and women's religious communities.

Brambilla, 59, is a member of the Consolata Missionaries religious order and had served as the No. 2 in the religious orders department since 2023. She takes over from the retiring Cardinal Joao Braz de Aviz, 77.

Francis made Brambilla's appointment possible with his 2022 reform of the Holy See's founding constitution, which allowed laypeople, including women, to head a dicastery and become pre-

Brambilla, a nurse, worked as a missionary in Mozambique and led

from 2011-2023, when Francis made her secretary of the religious orders department.

One major challenge she will face is the plummeting number of nuns worldwide. It has fallen by around 10,000 a year for the past several years, from around 750,000 in 2010 to 600,000 last year, according to Vatican statistics.

Brambilla's appointment is the latest move by Francis to show by example how women can take leadership roles within the Catholic hierarchy, albeit without allowing them to be ordained as priests.

Catholic women have long complained of second-class status in an institution that reserves the priest-

hood for men. Francis has upheld the ban on fe-

male priests and tamped down hopes that women could be ordained as deacons.

But there has been a marked increase in the percentage of women working in the Vatican during his papacy, including in leadership positions, from 19.3 per cent in 2013 to 23.4 per cent today, according to statistics reported by Vatican News. In the Curia alone, the percentage of women is 26 per cent. (AP)

# MHA approves new State TYCM urges Manipur govt to restore grassroot democracy

IMPHAL, Jan 8: The Tribal Youth Council Manipur (TYCM) has urged the Government of Manipur to expedite the conduct of the Autonomous District Councils (ADCs) elections at the earliest to restore grass-root democracy and local self-government for the hill tribals of Manipur.

The elections for the Autonomous District Councils (ADCs), mandated under Sections 11 & 13 of the Manipur (Hill Areas) District Councils Act, 1971, were due in 2020 but have not been conducted, it said.

"Now, four years have lapsed without any progress, representing a significant denial of democratic rights and political suppression of grass-root local self-government in the hill tribal areas. This prolonged inaction appears to be an intentional effort to weaken and demolish the framework of Local Self-Government, thereby suppressing constitutional tribal rights," the tribal youth body

According to the TYCM, the non-existence of Autonomous District Councils (ADCs) for the past four years has led to a loss of development opportunities for the tribal population and the abandonment of numerous beneficial

The council also said these cannot be easily recovered/compensated for by fu-

Furthermore, the failure to conduct ADC elections constitutes a suppression of the tribal communities in hill areas and is a violation of the Indian Constitution, the Manipur (Hill Areas) District Council Act, 1971, and the law of the land.

The Hill Areas Committee (HAC) had resolved to recommend to the Government of Manipur to conduct the long-pending election to the ADCs as soon as possible. As the system of Caretaker Chairmanship has been canvide Order No. TA-501/1/2022 e-TA & H, Government of Manipur, in compliance with the Hon'ble Gauhati High Court order dated 15. 03. 2024 passed in WA. No. 353 of 2023, a temporary committee consisting of 20 members for each ADC was proposed to be formed until elections are conducted, it pointed out.

This includes 18 members selected from former ADC members, experts in local self-governance, and eminent persons, along with 2 government nominees, the council

The Manipur (Hill Areas) District Councils Act, 1971 does not provide for the formation of such interim committees, and the proposed measure is not only extralegal but also a direct affront to the democratic principles underlying High Court's order dated 15. 03. 2024 passed in WA. No. 353 of 2023, "clearly states that the appointment of Caretaker Chairmanship is unconstitutional". It added, "These temporary measures risk creating confusion and undermining the faith of tribal communities in local self-government".

The TYCM then strongly objected to this resolution, "which blatantly violates" the provisions of The Manipur (Hill Areas) District Councils Act, 1971. The proposed measures are illogical and unconstitutional, causing confusion among tribal communities, it also said. "These actions attempt to eradi-

cate and abolish the principles and spirit of the 1971 Act, which was established to ensure appropriate representation in local self-government. The decision of the HAC misleads the tribal populace and invites unnecessary complications," the tribal youth body men-The TYCM said it had already

submitted memorandums to the Chief Minister of Manipur, the Governor of Manipur and the Chairman of the Hill Areas Committee (HAC), urging them for immediate attention and action on these pressing issues.

The TYCM reiterated its demand for the timely conduct of ADC elections and the restoration the ADCs, said the TYCM. The youth body also said the Gauhati population of Manipur. (NNN)

# Manipur Cong leaders meet Tripura BJP Janjati Morcha slams CPIM's tribal wing

AGARTALA, Jan 8: The Janjati Morcha, the tribal wing of Tripura's ruling Bharatiya Janata Party (BJP), has strongly criticised the Gana Mukti Parishad (GMP), the tribal wing of the opposition CPI(M), for accusing the government of neglecting indigenous

The BJP leaders dismissed the allegations as baseless and labelled GMP's planned Raj Bhawan Abhiyan on January 9 as a futile

Addressing a press conference, Bidyut Debbarma, vice president of BJP Janjati Morcha and a member of the District Council, firmly defended the government's record. "The Raj Bhawan Abhiyan by GMP is unnecessary and irrelevant. Since the BJP took charge in Tripura in 2018, the state has witnessed unprecedented development for the Janajati community." Achievements such as the CM Rubber Mission, resolution of the 23-year-long Bru issue, renaming Agartala Airport as Maharaja Bir Bikram Airport, establishment of Eklavya Model Residential Schools, declaration of Aspirational Blocks, celebrating Maharaja Bir Bikram's birth anniversary on August 19, and setting up the Tribal Research Institute are clear examples of progress," Debbarma said. He further added that under the BJP's

leadership, the central government has introduced several welfare schemes benefiting tribal communities, and many Janajati individuals have been honoured with prestigious awards such as the Padma Shri

Debbarma criticised the CPI(M) and Congress for failing to address tribal issues during their tenure. "Previous governments ignored the Janajati community's welfare. BJP has not only worked for their development but has also respected their sentiments and heritage. Special packages have been sanctioned, and proposals have been submitted to grant more power to the Tripura Tribal Areas Autonomous District Council (TTAADC)," he said.

Dismissing the CPI(M)'s claims of inadequate development, joblessness, and lack of MNREGA work, Debbarma challenged the opposition to identify a single village without electricity under the current government. "If they can point out such issues, we will resolve them immediately. These false allegations are merely tactics to mislead the people," he asserted.

# Members echo party stand at parliamentary panel meeting on simultaneous polls



**NEW DELHI, Jan 8:** The parliamentary panel constituted to scrutinise the two bills on simultaneous elections held its first meeting on Wednesday, with BJP members lauding the concept, and opposition MPs questioning it.

Officials of the Ministry of Law and Justice made a presentation on the provisions of the proposed laws during the meeting, citing support to the idea of simultaneous Lok Sabha and Assembly polls by various bodies, including the Law Commission of India, sources said.

BJP members batted for the 'one nation, one election' proposal, saying it is in the interest of the country, they said.

A Congress member said the idea is against the basic fabric of the Constitution, while a Trinamool Congress MP said it negates people's democratic rights, they added.

Headed by BJP MP PP Chaudhary, the 39-member joint committee of Parliament comprises members from all major parties, from Congress, Sanjay Jha from JD(U), Shiv Sena's Shrikant Shinde, AAP's Sanjay Singh, and Kalyan Banerjee from Trinamool

Chaudhary is a former minister of state for law.

The Constitution (129th Amendment) Bill and the Union Territories Laws (Amendment) Bill were introduced in the Lok Sabha during the recent Winter Session and referred to the committee.

The government decided to increase the committee's strength from 31 to 39, as more political parties expressed their desire to be part of the exercise to examine the two draft legislations on simultaneous elections.

Former Union ministers Anurag Thakur, Parshottam Rupala and Manish Tewari, along with several other lawmakers, including Anil Baluni, Bansuri Swaraj and Sambit Patra, are also members of the

# UP govt will reclaim every inch of land taken under pretext of Waqf: Adityanath 'Hard to tell whether it is a Waqf Board or a board of land mafias'

LUCKNOW, Jan 8: Uttar Pradesh Chief Minister Yogi Adityanath on Wednesday said the state government will reclaim every inch of land that has been taken under the pre-

Speaking at the 'Maha Kumbh Mahasammelan' organised by a private news channel here, he claimed that the belief system of Sanatan Dharma represents the world's oldest culture, standing above comparison with any religion or sect.

"I inherit a legacy that spans thousands of years, with its cultural and spiritual events equally ancient. The tradition of Sanatan is higher than the sky and beyond comparison," Adityanath, according to an official statement, said.

Taking a strong stance on the Waqf Board, he said, "It is hard to tell whether it is a Waqf Board or a board of land mafias.

He said his government has amended the Waqf Act and is actively investigating all "occupied" land. "We will reclaim every inch of land that has been taken under the pretext of Waqf and it will be used to build housing, educational institutions and hospitals for the poor," he affirmed.

Highlighting the ancient heritage of Sanatan Dharma, Yogi asserted that the tradition of Kumbh far predates the Waqf institution.

"The stature of Sanatan Dharma is higher than the sky and its depth deeper than the ocean. It cannot be

Addressing the dispute over religious sites in Sambhal, the chief minister pointed out that the Puranas mention Sambhal as the birthplace of Kalki, the tenth incarnation of Lord Shri Hari Vishnu.

The regulations grant governors broader control over VC appointments and allows nonacademics to hold these posts.

They also propose to amend the norms for hiring faculty members in universities, allowing those with postgraduate degrees in Master of Engineering (ME) or Master of Technology (MTech), with at least 55 per cent marks, to directly get recruited to the assistant professor level without qualifying for the UGC National Eligibility Test (NET). The NGO challenged the validity and sought a stay on the operation of Section 7 of the Chief Election Commissioner and Other Election Commissioners Act, 2023, which excluded the CJI.

The apex court's March 2, 2023 verdict held leaving the appointment of the ECs and CEC in the hands of the executive would be detrimental to the health of the country's democracy and the holding of free and fair elec-

# BSF using both ultra-modern, conventional methods to guard border with B'desh: Official



PETRAPOLE (WB), Jan 8: Guarding the challenging international borders between India and Bangladesh, the Border Security Force (BSF) has adopted mechanisms that converge conventional methods and ultra-modern technologies to prevent smuggling and human trafficking.

A senior official said that the BSF's South Bengal Frontier, which guards 913 km length of the international border between the two neighbours, extensively uses electronic surveillance in cohesion with conventional methods like sentry posts and foot patrolling.

Noting that nearly half the 913 km long border guarded by the South Bengal Frontier is yet to be fenced, he said that several methods have been adopted by the force to stop smuggling and human trafficking along the difficult terrain and riverine sections.

'Pan, Tilt, and Zoom' (PTZ) cameras apart from fixed ones are in place in extensive numbers to keep an eye on every movement where fencing is yet to be completed, the senior BSF official said.

The cameras, equipped with night vision facilities, have sensors to detect and pinpoint any human movement along the borders. The information is passed on to the sentries from the control rooms, he told visiting reporters at Petrapole in West Bengal's North 24 Parganas district, around 110 from Kolkata.

Out of the 32 km-long border in one battalion command area of the BSF near the Petrapole land customs station, only 11 km are fenced while the rest area is guarded in a seamless convergence of conventional and ultra-modern technologies, he said.

"Manpower, technology and resources are used in a proper manner to prevent smuggling and human trafficking," he said.

quisition process is on for putting up smart fencing in the unfenced area and some land along the border has been handed over to the force for the purpose by the state administration according to BSF's requirement.

Conditions become more challenging during the monsoons as the Betna river flowing along the border and other water bodies in this area overflow owing to heavy rain, he said.

"The BSF jawans have themselves put up barbed wire along the border where smart fencing is yet to be put up," the official said.

These are, however, aided by top-end gadgets including trip layer flares which get activated when any intruder touches the wires, helping the force to easily locate movement in the area in the darkness of night.

"The smugglers and traffickers will continue to make efforts, but we are prepared to meet the challenges," the BSF official said.

The official said that gaps in sentry monitoring areas are also covered using electronic surveillance, including 360-degree rotating cameras and sensors which start blowing when anyone touches the camouflaging placed around these gadgets.

"Every movement is monitored along the border at the control rooms and directions are given from there to the concerned sentries for necessary steps," he said.

The official said that the BSF personnel are equipped with pump action guns (PAG), which are nonlethal weapons, on sentry duty in the area

At places where villages are located close to the border, netting is also used to cover the smart fences. which are 20 feet high at places, to prevent anyone from throwing some articles from across the border intended to be received by recipients waiting on the other side. (PTI)

NEW DELHI, Jan 8: Union Jal Shakti The state has achieved 76 per cent NEW DELHI, Jan 8: The Railways has spent Minister CR Patil on Tuesday conducted Greywater Management (GWM) cover- 76 percent of its budgetary outlay within the first nine months of the current fiscal, the ministry said in a press statement.

"According to a latest expenditure report of Indian Railways till January 5, 2025, heavy investment is made in capacity augmentation, a reality aiming to make rail travel a world class experience in India," it added.

According to the Railway Ministry, the total capex for railways in the Budget Estimate 2024-25 is ₹ 2,65,200 crore with Gross Budgetary Support of ₹ 2,52,200 crores. Out of it, ₹ 1,92,446 crores have already been spent.

"For rolling stock, the budgetary provision was for ₹ 50,903 crores. Out of it, ₹ 40,367 crores were spent by 5th January, which is 79 per cent of the budget, allotted for rolling stock," it said. "In safety-related works, out of budgetary allocation of ₹ 34,412 crore, the amount spent is ₹28,281, which is 82 percent of the allocated amount," the ministry added.

The press note stated that the government has prioritised transforming Railways into a world class entity, which ferries on an average "2.3 crore Indians" daily at an affordable cost.

BANIHAL/JAMMU, Jan 8: A new chapter was written in the Indian Railways' history with a successful rising grade speed trial in the challenging geography from Jammu and Kashmir's Katra to Banihal along the USBRL project, a top official said on Wednesday.

The remarks by the Northern Circle's Commissioner of Railway Safety (CRS) Dinesh Chand Deshwal offers a positive indication for an early start to direct rail services between Kashmir and rest of the country.

However, he said they would analyse the data collected after completion of the two-day statutory inspection later in the day before the Centre might take a decision to start the much-awaited service. Talking to reporters on reaching

Banihal after the successful highspeed trial run from Katra station, Deshwal said his team would return to Katra and all the collected data would be analysed before a decision was taken on the start of direct train services to Kashmir. "The trial run at 110 kilometres

per hour on the 180-degree rising grade in such a challenging geography from Katra to Banihal has written a new chapter in the history of the Railways. The trial run was smooth and filled us with a sense of fulfilment and the credit for it goes to our engineers who have done

such a great work," the CRS said. The trial train left Katra station at 10:30 am and reached Banihal station within one-and-a-half hours. The train left for Katra on its return journey at 2 pm and is expected to reach its destination by 3:30 pm.

This is the final speed trial run on the trek

Deshwal, who reached Katra on a two-day statutory inspection of the newly completed railway line, said the Centre would take the final decision on the start of services between Kashmir and the rest of the country. "I am not in a position to talk about it (start of services). The statutory inspection will be completed by this evening and all the gathered data analysed in accordance with guidelines of the Northern Railway," he said.

# If I rest, I'll get rusty: Mohanlal on career of over 40 years and turning director with 'Barroz'

**NEW DELHI, Jan 8:** Working non-stop is not a new thing, says Malayalam superstar Mohanlal, who once completed 36 films in a year and remains driven by his passion for storytelling.

In a career spanning more than 45 years, Mohanlal has starred in over 360 films across different industries. He started his stint in movies with the role of an antagonist in Fazil's "Manjil Virinja Pookkal" (1980) and then featured in critically acclaimed movies like "Manichitrathazhu", "Vanaprastham", "Kireedam",

"Bharatham", "Iruvar", and "Drishyam".
"My passion towards my profession is a
fuel for me. You should love your profes-

sion. So every day is a beautiful day for me. And I have had the chance of working with great actors and directors. I have evolved from their blessing. I am dedicated to my profession. I am a performer, and that creativity is a fuel for my journey," the actor told PTI.

"This is my 47th year in films... Normally, I'll finish one film and do the other film. But nowadays, sometimes I have to reschedule my assignments, but I can still do it. I have done 36 films in one year. So it's not a new thing for me... If I rest,

I'll get rusty," he added.

The 64-year-old actor recently made his directorial debut with "Barroz", a pan-India fantasy film in which he also plays the lead role.

also plays the lead role.

The decision to become a director was not a planned one, said Mohanlal, who thought he should give something back to his fans for their love and support throughout his career.

"There is no rule that you have to direct a film. This is something that just happened. When I heard the story, I thought this is something very different. I said, 'Okay, we'll produce it, but who will direct the film?'

"Then I thought that the past four decades I have had the honour of being part of the Indian cinema, telling stories that have touched people's lives in different ways. I have to give them back some kind of gift. This is from my heart. I'm giving something back to them," he said

Shot in 3D, "Barroz" is based on Jijo Punnoose's novel "Barroz: Guardian of D'Gama's Treasure". It was released in theatres last month.

Mohanlal takes on the titular role of Barroz, a loyal servant who has been guarding Vasco da Gama's treasure for the past 400 years. His only aim is to hand over the cellar keys to the heir of Da Gama and be free from his duties.

The idea behind the project was to create something that would not only spark the imagination of children but also allow adults to revisit their old innocence and sense of wonder as kids.

"If you ask me if I will direct another film after 'Barroz', then I don't have an answer right now," he added.

Asked if his experience of working with master directors like Fazil, Shaji M Karun, Mani Ratnam, or Jeethu Joseph came in handy while making "Barroz", the actor said the film was an entirely different project because it was shot in 3D.

"You cannot take their way of filmmaking in this film... Even the 3D comes with unique challenges that differ from normal traditional 2D filmmaking, like camera movement, shot division, and editing... We needed special cameras, we had to use special colours, costumes... Everything was different.

"I haven't taken any kind of inspiration from any directors even shot-wise. This is a creativity of my own," he added.

With films like Fahadh
Faasil-starrer "Aavesham",
"Manjummel Boys" by Chidambaram, and Blessy's "The
Goat Life", headlined by
Prithivraj Sukumaran, turning
out to be major money spinners, Mohanlal said it is a welcome change for the
Malayalam industry.

"Ours is a small industry, so we are catering only to Keralites. But now things have changed. Our film industry has grown, and we have a lot of pan-India actors in our films. We also have to compete with other film industries. Luckily, we have a lot of stories, and new directors have come, new thought processes have come," he said. (PTI)


When Lopez met the real-life Judy and Anthony, she thought this story "deserves to be told".

# AFI to aggressively monitor athletes for dope testing

CHANDIGARH, Jan 8: The Athletics Federation of India (AFI) on Wednesday brushed aside concerns that more doping cases could embarrass the country in future following closure of national camps, saying that it will continue to monitor the athletes and share relevant information with the NADA.

The AFI decided to end national camps after the Paris Olympics, except for the relay teams which will still be under the direct supervision of the national

For a long time, AFI has a policy of not picking non-campers for relay teams in view of the fact that they cannot tested frequently.

The athletes can now train at the National Centers of Excellence which are under Sports Authority of India (SAI) or they can choose private bodies like the JSW, Reliance and Tata. They can also train at centers attached with states or with Army, Navy or Air Force.

"We have formed a separate monitoring team which will monitor all the places where the athletes train. It will collect information of each athlete. This information will be shared to the NADA," outgoing AFI president Adille Sumariwalla said when asked if it will not

He also said that the General Body of the AFI has approved the report of the committee which was formed to look into the doping issue.

"We had constituted a committee under IPS officer Sagarpreet Hooda who is commissioner special cell of Delhi Police on doping issue. He has made some recommendations and the AGM has approved the recommendations. Now we will see which are implementable and how we do that."

Sumariwalla served three consecutive terms as AFI president since 2012. He was replaced by 2002 Asian Games shot put gold winner Bahadur Singh Sagoo on

But Sumariwalla said the AFI can only recommend the athletes to be admitted to the NCoEs.

"Any new thing will have positive and negative aspects. Of course, it will be difficult to implement initially but we believe it will be beneficial in the long run. The athletes can now train near their homes and families, can have food they like.

"Moreover, it is also about widening the pool of athletes. Earlier, we had less than 150 athletes in national camps under the AFI. Now just the NCoEs can accommodate a thousand athletes." (PTI)




