Rescue operations in Dima Hasao coal mine enter 7th day



GUWAHATI, Jan 12: Rescue operations at a flooded coal mine in Assam's Dima Hasao district continued for the seventh day on Sunday to locate trapped labourers

Dewatering of the mine is being carried out with the process ex-

pected to reach the final stage soon, the state Mines and Minerals minister Kaushik Rai said.

Altogether nine workers were trapped inside the coal mine in Umrangsu area, around 250 km from Guwahati, after a sudden

on January 6. Of them, the bodies of four labourers have been recov-

The first body was recovered on Wednesday while three others were fished out on Saturday.

NDRF team commander Roshan Kumar Singh said the water level inside the flooded mine is receding with the dewatering process going on. "Today is the seventh day of rescue operations and four bodies have been recovered so far. The dewatering exercise is on and the water level is receding," he said.

Rescue operations are being carried out by multiple agencies, including NDRF, SDRF, army and navy personnel, with drones deployed for mapping of the area.

71 people died due to drug abuse in Mizoram in 2024

AIZAWL, Jan 12: Seventy-one people, including 11 women, died due to drug abuse in Mizoram in 2024, according to the Excise and Narcotics Department.

The number of deaths was marginally lower than that reported in 2023. A total of 74 people had died due to drug abuse that year, it said. "Majority of them died due to heroin abuse," the department's spokesperson Peter Zohmingthanga said on Sunday. A total of 1,881 people, including 230

women, have died due to drug abuse in the state since 1984 when the first drug-related death was reported, government data showed. Mizoram, where alcohol is banned, has been grappling with drug smuggling from Myanmar. The tiny hilly state shares an 828-km-long border with Myanmar and Bangladesh. Spasmo-proxyvon and parvon spas were the main killer drugs in the state till 2015 when heroin took their place due to an increase in supply from Myanmar, officials said. The highest drug-related deaths were re-

ported in 2004 when 143 people died. Over the last 10 years, 564 people have been killed due to drug abuse in the state, the data showed. The Excise Department seized 46.5 kg of heroin, 138.8 kg of methamphetamine tablets and 586.6 kg of ganja, among others, in 2024. It filed cases against 7,309 people in drugs and alcoholrelated offences last year. (PTI)

BJP will demolish all slums if it comes to power in Delhi: Kejriwal

"They want your votes first and your land after the elections," Kejriwal said, referring to the BJP. There was no immediate response from the BJP.

The Aam Aadmi Party (AAP) chief further challenged Union Home Minister Amit Shah to withdraw all cases against people living in 'jhuggis' and resettle those displaced within 24 hours, vowing not to contest the elections if the BJP complies.

Shah withdraws all the cases against the slum dwellers or displaced people. If the BJP fails, I will contest and stand as a shield for the slum dwellers. Let's see who destroys them," Kejriwal claimed. He also criticised the BJP's 'Jahan Jhuggi Wahan Makaan' scheme, calling it an eyewash.

"In the past 10 years, they have constructed only 4,700 flats for slum dwellers. Delhi has 4 lakh 'jhuggis.' At this rate, it will take them 1,000 years to provide homes for all slum dwellers in the city," he said.

Kejriwal also alleged that the BJP has plans to take over the land currently occupied by slum dwellers without addressing their housing needs.

"They will demolish all the slums and acquire the land without any concern for the people living there," he added. Echoing similar sentiments, senior AAP leader Manish

Coal India looks to Argentina for lithium brine assets

Ltd (CIL) has set its sights on Argentina as a destination in its strategic diversification into critical minerals, with a focus on lithium brine assets, an official said on Sunday.

Recognising the economic significance and strategic value of minerals like lithium (Li), nickel (Ni), cobalt (Co), and others, the Maharatna company has initiated steps to explore opportunities in key resource-rich nations such as Argentina, Australia and Chile.

'The state-owned mining behemoth has invited expressions of interest (EoI) from experienced consultants to conduct technical due diligence on lithium brine assets in Argentina," a senior Coal India official told PTI.

The selected consultant will undertake due diligence, an initial review process to assess the financial, strategic, and geological viability of the identified assets, he

Lithium brine is a concentrated India's coal import



NEW DELHI, Jan 12: India's coal import rose by two per cent to 182.02 million tonnes (MT) in the April-November period of the current fiscal year.

The country's coal import was at 178.17 MT in the year-ago period, according to data compiled by business-tobusiness e-commerce mjunction services ltd.

However, the country's coal import dropped to 19.57 MT in the month of November, over 22.30 MT in the corresponding month of the previous fiscal.

"There was a drop in volumes, which was in line with market expectation. Ample availability in the domestic market reduced import demand from consuming sectors such as sponge iron and steel. Also, the comfortable stock position at power plants resulted in muted demand for imports," mjunction MD and CEO Vinaya Varma said.

This trend is likely to continue in the coming months, he said.

During April-November 2024, noncoking coal import was at 117.73 MT, lower than 118 MT imported during the same period last year. Coking coal import was at 36.93 MT during April-November period, down against 37.97 MT recorded in the year-ago period.

The government had earlier stressed on augmenting coal production and reducing the imports of dry-fuel.

As per the present import policy, coal can be freely imported by the consumers themselves considering their needs, based on their commercial prudence.

Coking Coal is being imported by Steel Authority of India Ltd (SAIL) and other steel manufacturing units mainly to bridge the gap between the requirement and indigenous availability and to improve the quality.

Coal-based power plants, cement plants, captive power plants, sponge iron plants, industrial consumers and coal traders are importing non-coking coal. Coke is imported mainly by pigiron manufacturers and iron and steel sector consumers using mini-blast fur-

NFRA to release 7 papers to help stakeholders ask key audit questions

NEW DELHI, Jan 12: To enhance the quality and the level of interactions between auditors and companies' audit committees, NFRA chief Ajay Bhushan Prasad Pandey has said the watchdog plans to come out with six to seven papers having sets of questions that will cover various aspects of statutory audits.

"The papers will also help the stakeholders in asking the right questions related to audits," he told PTI. Constituted in October 2018, the National Financial Reporting Authority (NFRA) has been making efforts to improve audit quality and has passed over 80 orders against various entities for auditing lapses.

"These papers will also act as a guidance for companies' audit committees, independent directors, and board of directors in understanding the nuances as well as critical aspects of auditing," the NFRA Chairperson said.

In the planned series, the first paper on 'Audit of Accounting Estimates and Judgments Part 1: Expected Credit Losses (ECL) under Ind AS 109' was issued on January 10. "NFRA plans to come out with six to seven papers containing sets of questions that will cover various aspects of statutory audits in order to enhance the quality and level of interactions between auditors and audit committees/ board directors of companies," Pandey said.

In many cases, the regulator has noticed that the audit committees did not engage with auditors and did not ask the right questions to the auditors.

Some of the auditors also did not present many of the issues to

the committees concerned. Such communication failures also led to many red flags of possible corporate failures going unnoticed.

Auditing standards require auditors to have two-way communication with the members of the TCWG (Those Charged With Governance)

"In NFRA's experience of enforcement, review and monitoring activities, it has been noticed that there are audit quality issues which could have been addressed at the right time provided the auditors had paid due emphasis to these areas and audit committees and concerned had asked the right questions," Pandey said.

According to him, the overall efforts are to further improve the quality of audits which is also a key for ensuring high corporate governance standards. (PTI)

TCS expects margin benefits as BSNL deal tapers, says CFO Samir Seksaria

NEW DELHI, Jan 12: Tapering off in the BSNL deal expected over the next few quarters will aid TCS to expand profit margin, a senior company official has said. The country's largest software exporter is also looking at creating a capacity of over 25,000 seats in Bengaluru over the long term on a land parcel acquired recently, Chief Financial Offi-

cer Samir Seksaria told PTI here. "The same program (BSNL) as it tapers down at a portfolio level. at an overall level, there would be a benefit which would come in (on margins)," Seksaria said replying a specific question on the impact of BSNL deal's tapering down on margins. He, however, declined to share a number on the positive impact on the operating profit front. For the December quarter, it re-

ported operating profit margin at 24.5 per cent for December quarter and made it clear that it aims to expand on it. Seksaria added that there would be a tapering down in the BSNL contract till the September quarter of FY26. It can be noted that the over ₹ 15,000-crore deal to help BSNL roll out a countrywide 4G network has had a significant contribution in the Tata group company's revenue growth over the last few quarters.

Seksaria said the company will make up for the tapering BSNL revenue from other sources across all markets it serves. Asked if it will enter the aspi-

rational profit margin band of 26-28 per cent, which has been elusive for some time, in FY26, Seksaria refrained from a specific comment but added that levers exist for expanding the number from current levels. The company was able to post a sequential margin expansion of 0.4 per cent and maintain it on a year-on-year basis despite the 1.70 per cent wage hikes earlier in the fiscal year.

The ongoing rupee depreciation against the dollar helps profitability, but the appreciation of the local currency against other world currencies has resulted in no margin gains, Seksaria said. He explained that its receivables are in multiple currencies and has an active hedging programme to limit any impact of currency volatilities on its fi-

nances. On the ₹ 1,625-crore land buy deal from a Tata group company announced last week, Seksaria said the company is planning to put the capacity to expand in Whitefield, a prime area of the IT capital. The company already has about 70,000 employees in various offices across Bengaluru. Seksaria said the company adopts a mix of

lease and build approach when it comes to setting up its units, and the effort in Bengaluru is part of the latter. It is building campuses or facilities across various pockets of the country, and the last of such centre to be inaugurated was in Coimbatore, the

UK borrowing costs hit their highest level since banking crisis; economist explains what's happening

LONDON, Jan 12: UK borrowing costs have risen rapidly to their highest level since the banking crisis of 2007-08, with implications for the government's tax and spending plans. Yields on gilts, as UK government bonds are called, have been rising – and these yields are effectively the level of interest that the government pays on its borrowing.

The yield on ten-year debt hit 4.82%, the highest since 2008. And the yield on 30-year gilts rose to 5.383% on January 8, which is the highest for 27 years.

Yields rise when the price of bonds fall, so an increase in yields is another way of saying that the price of bonds has fallen. But why has this happened?

It's because of supply and demand. In general, when supply increases, buyers normally face lower prices. So, higher government borrowing has increased the supply of government debt, which means that the price of bonds falls. Since yields are inversely related to price, yields rise – pushing up the cost that the government has to pay to borrow.

The supply of government debt has been rising, particularly since the budget on October 30. That was when chancellor Rachel Reeves set out a significant amount of borrowing as well as tax increases in order to invest in stimulating growth and balance the books over the course of the parliament.

Government borrowing will reach 4.5% of GDP in this fiscal year. This is known as the budget deficit. And that's going to increase the overall amount of government debt, which is now close to 100% of GDP.

But it's worth mentioning that the cost of borrowing has increased for other major economies too, since they face similar levels of public debt.



Both the US and France are expected to run budget deficits bigger than the UK's 4.5%. For the US, analysts expect the deficit to be around 7% of GDP. The French government's budget deficit is planned to be around 5% to 5.5% of GDP. As a result, the yield on ten-year US Treasuries has risen to 4.7%, which is just below the level for the UK. Bond investors are expecting more borrowing from the incoming Trump administration, which has pushed up borrowing costs from 3.6% in September before the presidential election.

France has struggled to pass its budget measures and has seen its borrowing cost rise to the level of Greece (3.2%), a country that was rescued during the euro crisis.

Bond investors also look at interest rates and inflation to determine how much they charge to lend to the country. For example, if inflation is expected to be high, then they would want a higher rate to lend in order to ensure they received their money back plus interest. In other words, if inflation is 3%, then they would lend at above 3% in order to make a real return.

UK inflation had slowed to its 2% target in May and June of last year, but it had risen to 2.6% in the latest figures released in December. This was perhaps not surprising, but bond investors are looking ahead to what might cause higher inflation and therefore interest rates to remain higher for longer in 2025. The UK is an open economy that imports en-

ergy, so it is subject to changes in global energy prices. As such, bond investors are concerned about another commodity price spike as tensions in the Middle East continue.

Also, the incoming Trump administration is expected to impose tariffs, extend tax cuts and increase government borrowing. The US could face higher inflation, which means that the Federal Reserve (the US central bank) may keep rates higher for longer.

Since the US affects global prices and sets global borrowing costs in numerous respects, bond markets are expecting that other central banks, including the Bank of England, may also slow their pace of rate cuts. It means that borrowing costs would be higher for longer, which are reflected in higher bond yields.

What does it mean for the UK budget? If more money is spent on repaying debt, then the chancellor has less to spend on public services as set out in her October budget. In 2023-24 more than 8% of government spending went on servicing its debt.

So if debt interest payments increase, Reeves may need to raise taxes further to balance the books in accordance with her fiscal rules which state that she won't borrow to pay for day-to-day spending. Higher taxes might dampen economic growth, which also makes the UK less attractive to international investors.

The government already spends more than £100 billion a year on debt interest payments. This is because about a quarter of UK gilts are linked to inflation, which means that interest payments increase if inflation rises. (AP)

CII suggests 10-point agenda on ease of biz reforms ahead of Budget

NEW DELHI, Jan 12: Ahead of the upcoming Budget, industry body CII on Sunday suggested a 10point agenda to drive ease of doing business reforms, aimed at reducing compliance burden, simplifying regulatory frameworks, and improving transparency.

Among the "urgent policy interventions", the industry body has recommended that all regulatory approvals -- central, state and local levels -- must mandatorily be provided only through the National Single Window System. It has also pitched for expediting the process of dispute resolution by improving the capacity of courts and placing greater reliance on alternative dispute resolution (ADR) mechanism. For streamlining environmental compliances, Confederation of Indian Industry (CII) said, a unified framework could be introduced, which consolidates all requirements into a single document.

Emphasising that easy access to land is important to facilitate new or expanding businesses, it said that states may be incentivised to develop an online integrated land authority with an objective to streamline land banks, digitise and integrate land records, provide information on disputed land and guide necessary reforms. To assist industry in land acquisition across nation, the India Industrial Land Bank (IILB), which provides information on land across majority of states, can be evolved into a national-level land bank, with dedicated central budget support, it said.

While India has over the last decade remained focused on improving ease of doing business (EoDB), there is a need to maintain the momentum, especially in certain specific areas, the CII stated.

CII Director General Chandrajit Banerjee said, "Simplifying regulatory frameworks, reducing compliance burdens, and enhancing transparency should continue to remain our focus agenda for next several years. Compliances for industry related to various areas such as land, labour, dispute resolution, paying taxes and environment offer a vast scope for reduction, vital for boosting competitiveness, driving economic growth and employment generation." To ensure timely processing of industry applications and delivery of services from the central ministries, an Act, imposing statutory obligation on all public authorities for time-bound delivery of services and redressal of grievances, could be passed, with provision of deemed approval beyond the prescribed timeline, CII suggested.

It stressed that the scope of the National Judicial Data Grid (NJDG), which has been set up to identify, manage and reduce pendency of cases across the courts, needs to be expanded to include the data of tribunals, which constitute substantial chunk of pendency of cases in the system.

Arguing that labour compliances continue to be extensive and arduous and await the implementation of the four labour codes, it called for the scope of the Shram Suvidha Portal, which facilitates integrated compliances in just a few select central Acts, to be expanded to function as a centralised portal for all central and state labour laws compliances.

Asserting that improving trade facilitation is important, it said there is a need to make the Authorized Economic Operator (AEO) programme, which allows numerous priority clearances to members, could be made more attractive and easier to join, it noted as part of the 10-point agenda.

Flagging the "high and rising pendency of tax disputes" as a major issue, CII said there is a need to minimise income tax litigation by unclogging the pendency at the level of Commissioner of Income Tax (Appeals) and improving the effectiveness of ADR mechanism such as Advance Pricing Agreement, Boards for Advance Rulings and Dispute Resolution Scheme, as part of the EoDB reforms. We do feel that there are some opportunities in our network where that product will work well," he said at a media briefing earlier this week.

The fleet size of Air India now

is 202 planes, including 67 wide body ones. Among them, 27 are B777s, and 40 are B787s.

Of the 67 wide body planes, all legacy B777s and some leased B777s have first class seats.

"To compete with the best airlines you need to have first class, it is an aspirational product, it defines how you run and build an airline... we are putting it on A350-1000 aircraft... some of them will have the product.

"It takes time to develop the product," Aggarwal said.

The large wide body aircraft --A350-1000s and B777Xs -- will have 325-400 seats. These planes are set to be inducted in the coming years and A350-1000 is anticipated in the next two years.

"It is important to have that product (first class) as it pulls the airline up... it will be mostly the mega cities; London, New York are good first class markets. Even if you have a private jet, you cannot fly to the US without one stop. If you have a first class product you can fly direct and reach

faster," he said. Air India also has three other wide body planes. Medium wide body aircraft -- A350-900 and B787-9 -- that have 300-325 seats - and small wide body plane --

B787-8 having 250-300 seats. The retrofit of wide body planes starting with Boeing 787s, will commence this year while the retrofit of 27 legacy Airbus 320 neos is expected to be completed by the middle of 2025.

Air India serves around 63 million passengers and most of them fly domestic or short-haul international. These flights are operated with narrow body aircraft. (PTI)

Thanks to the strong position of the BGB and locals, India has been forced to halt its activities, He said that under the 1974 agreement, Bangladesh handed over Berubari to India after parliamentary ratification.

In return, India was supposed to provide Bangladesh access to the Tin Bigha Corridor, but it failed to fulfil this commitment or ratify the agreement in its parliament, he added. "They used to open the corridor for an hour and then close it for another hour. Finally, in 2010, an agreement was reached to keep the corridor open 24 hours. However, this agreement also allowed India to construct a border fence on the zero line at Angarpota, violating the 150-yard rule," he said. "Now, while we oppose this construction, we face challenges as Bangladesh is a signatory to the 2010 agreement," he said, adding that the foreign ministry

BSF thwarts smuggling attempt; IG reviews border operations

der Security Force (BSF) stationed in Tripura has successfully foiled a significant smuggling bid and detained three Bangladeshi nationals in separate operations over the past 24 hours. On January 12, alert Mahila Pra-

haris (women personnel) of the BSF thwarted a large-scale smuggling attempt at the Border Out Post (BOP) Ashabari in Sepahijala district. The smugglers, armed with sharp-edged weapons, attempted to forcefully smuggle contraband across the border. In response, the BSF personnel fired two rounds from their service weapons under compelling circumstances, successfully preventing the smuggling operation. A substantial quantity of sugar and other contraband items was recovered during the operation. In a separate incident on January

11, BSF personnel from BOP Gaurnagar in Khowai district apprehended three Bangladeshi nationals who were attempting to cross into Bangladesh. The detainees, hailing from Brahmanbaria district in Bangladesh, disclosed the identities of Indian and Bangladeshi touts involved in facilitating illegal border crossings during questioning.

The BSF reported that by employing non-lethal strategies, troops also prevented several smuggling and infiltration attempts. The forces rescued 10 cattle and seized 1,000 kilograms of sugar, 16 kilograms of cannabis,

and large quantities of clothing, medicines, and other contraband valued at over ₹ 50 lakh.

Meanwhile, Inspector General (IG) Ashwani Kumar Sharma of Tripura Frontier BSF conducted a three-day operational review of the border areas under the Panisagar Sector. Denigrating women politicians

woman's honour was one of the issues triggering the battle of Kurukshetra while the Rajputs of Chittor fought to the last man defending the honour of their queen Padmini and other womenfolk. Standing up to defend a woman's honour is thus not unheard of in India. Though Constitution has given equal rights to women, political misogyny continues to flourish seeking to reduce Mamata Banerjee or Priyanka Gandhi Vadra to objects of ridicule. The practice of sexist rhetoric and objectification of women can be traced back to the earlier years of the republic with firebrand Socialist leader dubbing Indira Gandhi a "gungi gudiya" (dumb doll) or his later day ideological successor and former Bihar chief minister, Lalu Prasad Yadav infamously commenting roads with Hema Malini's cheeks. Invectives hurled to the then principal Opposition leader of West Bengal Mamata Banerjee by leading lights of CPI(M) leadership were beyond the norms of parliamentary convention and political behaviour. Over the years, sexist remarks towards woman politicians have been made with impunity. Of late, Delhi BJP leader, Ramesh Bidhuri's recent slur made against Congress MP, Priyanka Gandhi Vadra is aimed to demean individuals. Its other goal is perpetuating marginalisation of women in politics. Inaction against Bidhuri lends credence to this

Seeking to undermine the progress of women in public life, misogyny prevails in Indian politics. Not much protest is heard against it post the electoral triumphs of the BJP in different polling processes. Worse these sentences often find acceptance in the cultural milieu. It is normalised by a society conditioned to tolerate casual sexism. Political parties project themselves as champions of gender equality. They tout their commitment to women empowerment through various schemes and programmes. Schemes like Ladli Behna and Pyari Didi aim at women empowerment. But they ring hollow in the context of the views towards women and girls by the saffronites. It is time to end the disconnect between words and deeds. The question remains that how can a political party in India overlook comments of its members demeaning women in public forum after having launched schemes for their financial uplift. This is glaring. It also undermines the sincerity of these initiatives. The misogyny is more than a political issue. It is a social problem. There seems to be a cultural tolerance to sexism in our society.. Inappropriate remarks are dismissed as harmless banter or political theatrics. No action has been taken against Bidhuri yet. He ought to have been suspended from the party as a warning. A swift and decisive action against offenders, regardless of their stature and influence.

It is unlikely that any action would be taken against him. Courtesy has taken a backseat in modern day politics especially when members of the saffron camp take on their political opponents. It is Priyanka Gandhi in this case. And she is the target owing to the family she comes from. Misogyny has no place in a democracy that aspires to represent and empower all its citizens. Time has come to consign sexist rhetoric to the past and create a political culture that respects women.

Iran is the next target of Israel in the expanding West Asian conflict

Delebrating a trifecta: in the course of a little over a year, Israel has felled or significantly set back its three most troublesome enemies: Hamas, Hezbollah, and Syria's Bashar al-Assad. Another enemy, Iran, has been brought low by Israeli missile attacks, the assassination of Hamas leader Ismail Haniyeh in Tehran, and a Revolutionary Guard commander in Damascus. Its Iraqi Shia militia allies have reportedly promised, at least temporarily, to cease attacks

Israeli military sources claim that its strikes inside Iran (precipitated by an Iranian missile assault on Israel) dismantled much of its air defense systems. These security officials note that this was a key mission: to eliminate Iran's air defenses in preparation for a future all-out assault on its nuclear program. The sources estimate it will take a year or more for Iran to repair the current damage and restore its capabilities. During this period, it will be most vulnerable, and an attack would be most optimal from an Israeli point of view. That would be the time frame within which such an assault would be ex-

In its weakened state, both Israeli leaders and Trump security advisors are urging such an attack on Iran. Former Israeli defense minister, Yoav Gallant, travelled to Washington, DC, last month. He lobbied US officials, telling them this is "a window to act against Iran." He favored either an Israeli or preferably a joint US-Israeli operation against Iran's nuclear infra-

President Joe Biden does not favour such an attack. Thus it would be left to the incoming Trump administration, whose advisors are seriously considering this option. Though Trump has repeatedly expressed reluctance to commit US forces on behalf of foreign interventions, he is attuned to Israeli interests.

At the very least, he would instruct US intelligence agencies to share reports that could assist in targeting Iranian sites: he would also provide specialized munitions needed for such strikes as Biden has in Gaza and Lebanon.

Israel's new strategic approach has been showcased in Gaza. where it has committed genocide despite the world's horrified response. It has stood by and offered little resistance. Even arrest warrants by the International Criminal Court for Gallant and Netanyahu have not deterred them from slaughtering nearly 50,000 Palestinians. Turkey seeks to defeat Kurdish forces allied with the United States in northeastern Syria. It, too, has occupied a buffer zone inside northern Syria, as Israel has in the south.

The United States currently has 2,000 troops supporting its Kurdish allies. Will Donald Trump continue this operation? During his first term, he toyed with withdrawing our forces from Syria. But ultimately he was dissuaded by his generals, who persuaded him that Syria would fall into chaos and IŠIS would return if he did.

Given that Trump has nominated key military and intelligence figures who are far more in tune with his isolationist views on US foreign entanglements, he may leave the Kurds, our allies for the past fifteen years, to their own devices. Turkey will likely then launch a major offensive, which could decimate them. That would leave an opening for ISIS to resume terrorist activity in eastern Svria. In Trump's first term, he boasted he had defeated ISIS. He may enable their reemergence.

A massive strike against Iranian targets could ignite a regional war. Even with members of Iran's Axis of Resistance sidelined, there are others (Iraqi Shia and Houthi allies) who have the capability of inflicting damage on US and Israeli forces. It could be the first such widespread conflict since 1973.

Thus far, Iran has restrained its nuclear program. Its uranium enrichment has not surpassed 60 percent. It has not produced a missile delivery system. This process could take a year or more. It has chosen not to progress beyond these limits, since it doesn't want to give its enemies grounds for

This week, Axios reported that a US national security advisor presented a plan to President Biden to attack Iran's nuclear facilities should it take steps like those mentioned above. This makes the nuclear option a very dangerous one for Iran.

Though a US-Israel attack would cause serious damage to Iran's nuclear infrastructure, experts have judged it will not destroy its capabilities. Iran going nuclear would considerably alter the balance of power in the region. Instead of Israel being the lone nuclear power, Iran would join this select club. The former would no longer have unfettered power and influence. As with North Korea. Iran would possess a guarantee of survival should enemies launch an all-out attack whose goal is annihilation or regime change.

During the Cold War, the United States and Soviet Union maintained a policy of mutually assured destruction (MAD), which constrained each party from using their weapons. The Middle East is far less stable. Some, like Israel, are ruled by zealots engaged in genocide and harbouring visions of an apocalyptic war against Islam. The likelihood of nuclear war feels considerably higher than during the Cold War. Since October 7, 2023. Israel has transformed the region into a considerably more dangerous place. The new Trump administration may have neither the capability nor the will to prevent a conflict of catastrophic pro-

Trump's proposal to absorb Canada ignites sovereignty debate

cently posted maps on his Truth Social platform showing Canada as part of the United States. These provocative posts, shared on January 7, have ignited debates on sovereignty, diplomacy, and national identity. Trump's actions come amidst his repeated claims that Canadians would benefit from becoming part of the United States—a notion that Canadian officials swiftly and emphatically rejected. Trump's first post featured a striking image of a unified North America, with Canada seamlessly integrated into the United States. The map depicted the absence of national borders, with the term "United States" emblazoned across the combined territories. This was followed by another map where both regions were painted in the colours of the US flag, captioned "Oh Canada."

These posts appeared just hours after Canadian officials publicly dismissed Trump's assertion that annexing Canada would be advantageous for its citizens. The timing added fuel to an already contentious debate, amplifying reactions across both nations. In a press conference on the same day, Trump doubled down on his stance, suggesting that economic leverage could be used to realize his vision. He threatened to impose severe tariffs on Canadian goods if Ottawa resisted. "You get rid of that artificially-drawn line," Trump stated, "and you take a look at what that looks like. It would also be much better for national security." This rhetoric aligns with Trump's long-standing emphasis on using economic and security arguments to justify controversial positions. However, his comments about erasing the border have drawn sharp criticism, raising concerns about escalating tensions between two nations that share one of the world's longest undefended borders. Canadian leaders were quick to denounce Trump's remarks. Outgoing Prime Minister Justin Trudeau took to X (formerly Twitter) to assert Canada's sovereignty stating, "There isn't a snowball's chance in hell that Canada would become part of the United States.' Pierre Poilievre, leader of the opposition Conservative Party, echoed Trudeau's sentiment, declaring, "Canada will never be the 51st state." Both leaders emphasized the importance of Canadian identity and independence, rallying citizens against any no-

While denouncing Trump's proposal, Canadian politicians also stressed the importance of preserving strong bilateral ties with the US. Trudeau, whose tenure has seen fluctuating popularity, recently announced his resignation as prime minister and leader of the Liberal Party, adding another layer of complexity to Canada's political landscape.

The idea of annexing Canada is not new. In the 19th century, some American factions championed the "Manifest Destiny" doctrine, which aimed to expand US territory across the North American continent. However, these ambitions never gained substantial traction, and the relationship between the US and Canada evolved into one of the most stable and mutually beneficial partnerships in modern history. The two nations are deeply intertwined economically. Canada remains one of the US's

largest trading partners, with bilateral trade exceeding \$700 billion annually. Agreements like the United n a startling move that has sent shockwaves States-Mexico-Canada Agreement (USMCA) have through political circles in the United States and further cemented this interdependence. In Canada, outrage was palpable. Hashtags such as #HandsOffCanada and #TrumpBackOff trended on social media platforms, with many citizens expressing their frustration and reaffirming their national pride. For many Canadians, Trump's proposal not only disregards their sovereignty but also undermines decades of peaceful coexistence.

Trump's comments have introduced an element of unpredictability to US-Canada relations. While disputes between the two nations have historically been managed through diplomacy, Trump's aggressive rhetoric risks destabilizing this dynamic. His threats of tariffs could disrupt critical trade flows, harming industries on both sides of the border.

Furthermore, this proposal raises broader questions about the United States' commitment to respecting the sovereignty of its allies. Should such rhetoric translate into policy, it could alienate other nations, diminishing the US's standing in the global arena. Some analysts view Trump's controversial maps as a calculated political manoeuvre designed to energize his base and shift attention from domestic challenges. By presenting a provocative vision, Trump solidifies his image as a disruptor willing to challenge the status quo.

Others, however, see this as a reckless gambit with potentially serious diplomatic repercussions. The risks of alienating a close ally like Canada and ieopardizing decades of cooperation far outweigh the short-term political gains such rhetoric might yield. As Canada approaches its election season and the US transitions to Trump's leadership, the future of bilateral relations hangs in the balance. Canadian leaders have remained united in rejecting Trump's vision, using this controversy to rally citizens around their sovereignty and national identity. While the current uproar may fade, it serves as a stark reminder of the delicate balance between partnership and independence in international relations. Both nations must seize this opportunity to reaffirm their commitment to mutual respect and constructive dialogue. Trump's provocative maps and statements have thrust issues of sovereignty, diplomacy, and national identity into the spotlight. While his posts have sparked widespread condemnation, they also underscore the importance of maintaining strong, respectful relationships between neighbouring nations.

For now, Canada stands firm in defense of its autonomy, with its leaders and citizens united against any notion of annexation. Whether this controversy leaves a lasting imprint on US-Canada relations or fades into history as a fleeting political stunt remains to be seen. Magh Bihu: A symphony of Rituals, Feasts, and Cultural Vibrance

he Assamese term "Bihu" finds its roots in the Sanskrit word "visuvat," particularly associated with the mahavisuvasamkranti, symbolizing the vernal equinox at the junction of the Chaitra and Vaisakha months (mid-April). Bihu, a generic term, encompasses three significant Assamese festivals: BohagBihu, MaghBihu, and Kati Bihu. BohagBihu, celebrated at the junction of the Assamese months of Chot and Bohag, is also known as RangaliBihu due to its association with joyous singing and dancing during the springtime. MaghBihu, occurring in mid-January at the junction of the Assamese months of Puh and Magh, is alternatively called BhogaliBihu, highlighting its main feature of enjoyment through feasting. Kati Bihu, falling in mid-October at the junction of the Assamese months of Ahin and Kati, is also known as KangaliBihu or Beggar's Bihu. This name reflects its lack of connection with feasting or merry-making, as it occurs when the year's grains are exhausted, and the traditional winter crop is yet to mature. According to P. Goswami, BohagBihu aligns with the Vernal Equinox, Kati Bihu with the Autumnal Equinox, and MaghBihu with the Winter Solstice. The term Bihu can be traced back to the Sanskrit word "visuvan," signifying equinox. The multifaceted nature of Bihu captures the essence of Assamese culture through diverse celebrations marking the changing seasons.

MaghBihu is intricately linked to a folk fire ceremony, but the essence lies in the significance of Uruka, the Bihu eve. This prelude to the festive day holds immense importance as womenfolk diligently prepare for the celebrations ahead. Uruka extends beyond a mere day, involving the gathering of fuel, procuring fish from ponds or streams, and if feasible, obtaining some meat. The meticulous preparations for Uruka include the creation of an array of snacks such as Chira, Pitha, laru, and curd. In tribal communities, women take on the task of crafting rice-beer, typically left undistilled

The winter season adds an extra layer to this preparation, requiring four or five days for the beer to reach its matured state. Uruka, with its comprehensive preparations, sets the stage for the grand festivities of MaghBihu, reflecting the cultural richness and vibrant traditions associated with this Assamese cel-

Another noteworthy aspect of this Bihu celebration involves the construction of templelike structures in paddy or open fields, a task predominantly undertaken by young boys. These structures, known as "meji" or "Bhelaghar," are crafted using green bamboo, dried banana leaves, and hay or paddy stub-



to Sanskrit "Mesa-griha" (mesa = bhera/bhela = sheep), where some hairs of sheep or goat are traditionally burnt on the eve of DaulUtsava associated with Krishnaism. In upper Assam, the term "meji" is utilized, potentially originating from Sanskrit "Medha" or 'yajna." These linguistic connections suggest the preservation of ancient associations within the practice of burning Bhelaghar. An interesting observation in Assam reveals that people use firewood in the construction of meji. This tradition adds a unique and cultural touch to the Bihu festivities, connecting the present celebrations with ancient rituals and

The Uruka feasting during MaghBihu can take on the form of a familial gathering or a communal celebration. As the evening descends, the men of the village come together, assembling in the Bhelaghar arena. Here, they engage in Nam-Prasanga, a vibrant exchange accompanied by the rhythmic beats of nagara kettle drums and the melodic tones of bhortals or cymbals. The atmosphere is further enriched by the presence of village cowherds who spend the night in the Bhelaghar. They

the vegetables they've acquired, perhaps spirited away from the villagers' gardens. In this communal setting, the cowherds partake in the feasting, savoring the edibles offered to them. This amalgamation of music, warmth, and shared sustenance encapsulates the essence of MaghBihu's Uruka festivities, creating a memorable experience for all in-

As the feasting evening concludes, the crack of dawn heralds the next day's rituals. A family member meticulously ties thin strips of bamboo, jute, or hay around fruit-bearing trees. Simultaneously, a call goes out to the dogs, and they are offered rice. Meanwhile, womenfolk busy themselves cleaning the house and cooking pans. The men and children of the household then proceed to the mejis and bhelaghars, where offerings of delectables are presented to Agni, the God of Fire. Echoing cries of divine names fill the air as the structures are set ablaze. The vivid red flames provide warmth to those who endured the cold night, and the bamboo tubes burst open like celebratory gunfire.

Following the fiery spectacle, Brahmins,

ings) bestow blessings and mark foreheads with ash. The partially burnt sticks are scattered in the fields, and some pieces may be brought home to be placed near fruit-bearing trees. The belief underlying this ritual is that the ashes and the partially burnt bamboo enhance the fertility of fields and gardens. Drawing a parallel, Frazer notes that Europeans, engaging in similar fire rituals during Lent and midsummer, also held a belief in the potency of ashes and embers for fertility. This custom of tying bands of straw around tree trunks to promote fruitfulness, rooted in Indo-European traditions, resonates in these fire ceremonies, adding a layer of cultural depth to the festivities.

As the morning unfolds, following the burning of mejis and bhelaghars, people gather to partake in a serene session of hymn devotional Vaishnavite singing. Accompanied by the resonant beats of kettledrums and the melodic tones of large cymbals, a collective hymn-singing session takes place. This practice of nam-prosanga or hymn-singing, whether held in the namphar or within households, stands out as a notable feature during the month of Magh, considered auspicious for

religious endeavors. In this particular facet of the MaghBihu festival, the unmistakable influence of Vaishnavism becomes apparent. The harmonious blend of music and devotional singing creates a spiritual atmosphere, embodying the cultural and religious richness associated with this celebration.

On the Samkranti day, which follows Uruka, a dietary shift occurs with the exclusion of meat from meals. The lunch menu predominantly features chira, pitha, curd, and other vegetarian delights. A distinctive delicacy, tekeli-pitha, takes center stage, comprising salted rice powder steamed on the mouth of a small pitcher or kettle, reminiscent of the larger idli. Another delectable offering is sunga-pitha, created by placing moist rice powder in a green bamboo tube and roasting it over an open flame.

Traditionally seasoned with salt, some contemporary preferences lean towards a sweet variety. A variation called sungasaul emerges, featuring sticky bara rice steamed in a bamboo tube. Once prepared, the sticky roll is cut into pieces and enjoyed mixed with milk and Gur. Notably, in Sonitpur, a penchant for fried pithas adds a delightful twist to the culinary traditions associated with this festive period. These unique preparations not only satisfy the taste buds but also contribute to the distinctiveness of the MaghBihu celebration.

As the evening descends, the final meal of the day unfolds, featuring rice – potentially new if not consumed earlier in the Assamese month of Aghon. This is accompanied by a flavorful black gram curry and delectably fried yam, creating a satisfying and wholesome dinner. The following day at noon, a customary practice emerges - the indulgence in a dish known as "maghipanta." This dish comprises a small portion of leftover rice soaked in water, accompanied by remnants of dal. It is intriguing to note that the tradition of consuming soaked leftover rice might trace its roots to the tribal custom of imbibing rice beer, adding a cultural layer to this culinary

An intriguing facet of the MaghBihu celebration is the inclusion of various sports and traditional games across different locations. These engaging activities encompass a spectrum of events, ranging from wrestling, racing, and jumping to the unique competitions of buffalo fighting (mohjunj), egg fighting (kanijunj), chicken fighting (kukurajunj), and bulbuli (a type of small bird) fighting. Notably, the buffalo fighting in Ahotguri, located in the Marigaon district, has gained renown for its fervor and intensity. This dynamic blend of sports and competitions adds an element of excitement and community involvement to the festive atmosphere of MaghBihu, creating a lively and vibrant celebration. Bhogali Uruka: Night of Dheraghar: The heart of Magh Bihu food and folklore

Bhogali or Magh Bihu is a fesThe communalistic nature of the tivity that deeply resonates with the cultural ethos of Assam, culminating the harvest season. The feasting and narration night beyond being a social occasion is an expression about identity, agrarian gratitude, and community bonding for people of Assam. Steeped in folklore, traditional cuisine and collective joy, Bhogali Uruka is the cultural heartbeat of Assam, which unites food and stories to celebrate in har-

The festival finds its roots in the conclusion of the harvesting cycle, it embodies abundance, prosperity, and gratitude towards nature. Having toiled in the fields for months, farmers take solace and delight in this festival, as it marks the successful completion of their labor. This connection between agriculture and festivity is evident in the very nature of Uruka, where the feast is prepared from freshly harvested crops, thereby establishing a connection between land, sustenance, and community

Bhogali Uruka celebrates feasting as a symbol of abundance and collective gratitude. The preparations begin well in advance, as families and communities gather to cook elaborate meals. Traditional Assamese delicacies dominate the feast, including pitha (rice cakes), ladoo, sunga pitha (rice cakes steamed in bamboo), roasted meats, maasor tenga (sour fish curry), and pork cooked with lai xaak (mustard greens). The use of freshly harvested rice, besides additional local ingredients, gives the celebration a further



sense of authenticity because it pro-ship are symbolized through the fire.

feast adds cultural content to Bhogali Uruka. Great numbers gather under open skies and cook and share a meal in temporary makeshift huts, often referred to as Bhelaghars, made of bamboo, hay, and leaves. These tarpaulin structures, functional spaces for the feast, hold symbolic values such as simplicity, unity, and sustainable living. Cooking together builds a sense of collective responsibility as tasks are divided without distinction by caste, class, or age, representing Assamese culture as all-inclusive.

Though food forms the central axis of Bhogali Bihu's Uruka, folklore and oral traditions equally enrich the night. The celebration is characterised by sessions of storytelling around the Bhelaghar or by the fireside. Elders share folktales, myths, and historical anecdotes that ensure the passage of cultural wisdom to the next generation. Most of these stories are about local legends, moral teachings, and agricultural folklore. They entertain while educating.

Folk songs and folk dances add glory to the gaiety of the festival. The Bihu Geet that speaks of the love, agriculture, and natures are also heard in those days. Dhol (Drum) played rhythmically beats in clapping hands and nice dhol plays which add flavour to the ceremony. Bihu Naas has a different level as it represents an artistic action which is conducted among the culture to strengthen community ties. Most of the tracks reflect seasonal changes, agricultural prosperity, and local tales, thus perpetuating oral history through music and performance.

The Bhelaghar, or place of feasts and celebration, was considered to be sacred as well. When the first light of dawn broke after the all-night celebrations, the Bhelaghar and Meji, a bamboo- and hay-structure towering over it, was to be set on fire. The Meji was burnt down at the culmination of Bhogali Uruka, which meant the harvest cycle was coming to an end and a new agricultural year was to begin. Flames that rose into the sky were considered offerings to the gods to seek prosperity and protection for the community. People gather around the fire and offer pithas and other food items to the flames and pray for health, happiness, and a good harvest.

The ritualistic burning also symbolizes purification. Here, the victory of light over darkness, of knowledge over ignorance, and prosperity over hard-

This temparticular moment brings a sense of porary structure, made of bamboo, unity, renewal, and hope in the future as a community. The cultural significance of Uruka goes beyond the immediate sense of celebration. Rather, it is a poignant reminder of Assam's agrarian origin while inducing sustainability and an ecological balance. The festival thus represents a way of life where people live in harmony with nature and respect the land that supports them. This cultural wisdom, passed down through generations, underlines the relevance of environmental consciousness in modern times.

However, Uruka has its challenges in modern days. Urbanization and changing lifestyles have gradually decreased the communal elements of the festival, especially in urban areas where space and time constraints limit the scale of participation. Increasing commercialization of festivals with pre-packaged foods replacing traditional homemade dishes threatens the authenticity of the event.

All these aside, efforts to keep the spirit of Bhogali Uruka alive are going on relentlessly in the Assam valley. Cultural organizations and institutions often conduct community feasts and storytelling sessions and cultural performances that keep the traditions going. Schools teach the historical and cultural significance of the festival so that it does not fade away to mean anything less in younger generations' perception.

Uruka is more than just the feast; it is the epitome of the values it carries with it, such as thankfulness, unison, and cultural pride. It is a meeting point between generations, where food, folklore, and festivity blend together in a shared identity. The festival reminds people about community life where joy is shared, burdens eased collectively, and cultural roots are honored with rev-

As the flames of the Meji rise into the morning sky each year, they symbolize not just the conclusion of a harvest but the burning away of past hardships, the renewal of hope, and the reaffirmation of cultural bonds. Bhogali Uruka, with its blend of food and folklore, remains a living testament to Assam's rich cultural heritage, reminding its people of the values of togetherness, gratitude, and the enduring strength of traditions. Los Angeles wildfires death toll rises as crews fight heavy winds to save homes, landmarks

death toll from the wildfires ravaging the Los Angeles area rose to 16 as crews battled to cut off the spreading blazes before potentially strong winds return that could push the flames toward some of the city's most famous landmarks.

Five of the deaths were attributed to the Palisades Fire and 11 resulted from the Eaton Fire, the Los Angeles County coroner's office said in a statement Saturday

The previous number of confirmed fatalities before Saturday was 11, but officials said they expected that figure to rise as teams with cadaver dogs conduct systematic grid searches in levelled neighbourhoods. Authorities have established a centre where people can report the missing.

There were fears that winds could move the fires toward the J Paul Getty Museum and the University of California, Los Angeles, while new evacuation warnings left more homeowners on edge.

By Saturday evening, Cal Fire reported the Palisades, Eaton, Kenneth and Hurst fires had consumed about 62 square miles, an area larger than San Francisco. The Palisades and Eaton fires accounted for 59 square miles.

In a briefing posted online Saturday evening, Michael Traum of the California Office of Emergency Services said 150,000 people in Los Angeles County were under evacuation orders, with more than 700 people taking



refuge in nine shelters.

Crews from California and nine other states are part of the ongoing response that includes 1,354 fire engines, 84 aircraft and more than 14,000 personnel, including newly arrived firefighters from Mexico,

With Cal Fire reporting containment of the Palisades Fire at 11% and the Eaton Fire at 15% on Saturday night, the fight is set to con-

"Weather conditions are still critical and another round of strong winds is expected starting Monday," Traum said.

A fierce battle occurred Saturday in Mandeville Canyon, home to Arnold Schwarzenegger and other celebrities not far from the Pacific coast, where swooping helicopters dumped water as the blaze charged downhill. Firefighters on the ground used hoses in an attempt to beat back leaping flames as thick smoke blanketed

the chaparral-covered hillside. CalFire Operations Chief Christian Litz said Saturday that a main focus was the Palisades Fire burning in the canyon area, not far from the UCLA campus.

New evacuations were ordered Friday evening after a flare up on the eastern side of the Palisades

The National Weather Service warned that strong Santa Ana winds could soon return. Those winds have been largely blamed for turning the wildfires into infernos that levelled entire neighbourhoods around to city where there has been no significant rainfall in more than eight months.

The fire also threatened to jump over Interstate 405 and into densely populated areas in the Hollywood Hills and San Fernando Valley.

Firefighters for the first time made progress Friday afternoon on the Eaton Fire north of Pasadena, which has burned more than 7,000 structures, a term that includes homes, apartment buildings, businesses, outbuildings and vehicles. Most evacuation orders for the area were lifted, officials

No cause has been determined for the largest fires and early estimates indicate the wildfires could be the nation's costliest ever. A preliminary estimate by AccuWeather put the damage and economic losses so far between \$135 billion and \$150 billion.

Volunteers overflowed donation centres and some had to be turned away at locations including the Santa Anita Park horse racing track, where people who lost their homes sifted through stacks of donated shirts, blankets and other household goods.

Altadena resident Jose Luis Godinez said three homes occupied by more than a dozen of his family members were destroyed.

"Everything is gone," he said, speaking in Spanish. "All my family lived in those three houses and now we have nothing.'

Los Angeles County Sheriff Robert Luna warned residents against venturing back to destroyed homes to sift through rubble for keepsakes.

"We have people driving up and around trying to get in just to look.

Officials on Saturday warned the ash can contain lead, arsenic, asbestos and other harmful mate-

Residents will be allowed to return with protective gear after damage teams evaluate their properties, Thomas said.



Toll in Pakistan coal mine collapse rises to 11

Twelve workers were trapped when the coal mine collapsed in the Sanjdi area



KARACHI, Jan 12: The death toll in a coal mine collapse due to a methane gas accumulation and explosion has left 11 workers dead after rescuers recovered seven more dead bodies, an official said.

Twelve workers were trapped when the coal mine collapsed in the Sanjdi area, about 40 kilometres from Quetta in the Balochistan province, on Wednesday evening. In three days of rescue work, 11

bodies were recovered until Saturday night with rescue workers still searching for the last worker inside the collapsed structure, Abdullah Shawani, the head of the province's mining department, said.

"There are little chances of the last worker surviving for so long in the collapsed mine," Shawani said.

"The incident occurred due to a buildup of gas, which caused an explosion and the mine to cave in," Balochistan government spokesperson Shahid Rind said.

He said full-scale rescue operations were ongoing but the progress

was slow due to the presence of toxic gas and debris. An investigation is on to ascertain whether proper mining regulations were followed, he said. Pir Muhammad Kakar, one of the leaders of the mines workers association, said the incident resulted from non-implementation of mining regulations by the owner of coal mines and blamed officials at the mines department for the incident.

Kakar demanded strict action against these officials.

Coal mine collapses and death of workers happens frequently in the coal-rich western Balochistan known for hazardous working conditions and poor safety standards.

In March last year, at least 12 miners were killed in a gas explosion at a coalpit in Harnai.

In May 2018, 23 people were killed and 11 wounded after two neighbouring coal mines collapsed in Sanjdi while 43 workers also died in 2011 when gas explosions triggered a collapse in another Balochistan colliery. (PTI)

Germany says sanctions against Syrian war crimes suspects must stay but people need relief

RIYADH, Jan 12: Germany's foreign minister said Sunday that sanctions against Syrian officials responsible for war crimes must remain in place but called for a "smart approach" to provide relief to the Syrian population after last month's overthrow of President Bashar Assad, Annalena Baerbock spoke to reporters after arriving in Saudi Arabia for a conference on Syria's future attended by top European and Middle Eastern diplo-

Germany is one of several countries that imposed sanctions on the Assad government over its brutal crackdown on dissent. Those penalties could hinder Syria's recovery from nearly 14 years of civil war that killed an estimated 500,000 people and displaced half the prewar population of 23 million, "Sanctions against Assad's henchmen who committed serious crimes during the civil war must remain in place," Baer-

US govt not involved in planning, managing 'National Prayer

The statements, comments, positions, and opinions of participants or former officials at the IRF Summit or National Prayer Breakfast should not be interpreted as representing the opinions, positions, or policies of the US government, Dhaka Tribune quoted the US embassy spokesperson as saying on Saturday.

He made the remarks when media personnel drew the spokesperson's attention towards a report saying President-elect Donald Trump invited Bangladesh Nationalist Party (BNP) Acting Chairman Tarique Rahman and two senior leaders to attend the National Prayer Break-

"The United States is not hosting, organising, or funding the IRF Summit or National Prayer Breakfast," he said. "The IRF Summit is distinct from the International Religious Freedom Ministerial organised annually by the US and partner governments, which the German government most recently hosted in Berlin on October 10-11, 2024."

ZAGREB (CROATIA), Jan 12: Croatia's incumbent President Zoran Milanovic was the overwhelming favourite to win reelection as he faced a candidate from the ruling conservative party in a runoff presidential vote on Sunday

The left-leaning Milanovic comfortably won the first round of voting on Dec 29, leaving his main challenger, Dragan Primorac, a forensic scientist who had unsuccessfully run for presidency previously, and six other candidates far behind.

The runoff between the top two contenders was necessary because Milanovic fell short of securing 50% of the vote by just 5,000 votes, while Primorac trailed far behind with 19%. The election comes as the European Union and NATO member country of 3.8 million people struggles with biting inflation, corruption scandals and a labor shortage.

Milanovic, 58, is an outspoken critic of Western military support for Ukraine in its war against Russia. He is the most popular politician in Croatia, and is sometimes compared to US President-elect Donald Trump for his combative style of communication with political opponents.

Milanovic served as prime minister in the past with a mixed record. He has been a fierce critic of current Prime Minister Andrej Plenkovic and the pair have long sparred with each other. Milanovic regularly accuses Plenkovic and his conservative Croatian Democratic Union party of systemic corruption, calling the premier a "serious threat to Croatia's democracy". Plenkovic has sought to portray Sunday's vote as one about Croatia's future in the EU and NATO. He has labelled Milanovic "pro-Russian" and a threat to Croatia's interna-

tional standing. Primorac echoed this position as he cast his callot on Sunday. He said the presidential vote was "very important" and "about the future of Croatia, about the future of our homeland, our citizens, and, really, the direction that it would go from here". Political analyst Viseslay Raos said the increasingly outspoken Milanovic has no motive to "try to please someone or try to control himself". "If there was no cooperation with

the prime minister for the first five years (of his presidency), why would it be now?" he added. Though the presidency is largely

ceremonial in Croatia, an elected president holds political authority and acts as the supreme military commander. Despite limited powers, many be-

lieve the presidential position is key

for the political balance of power in a country mainly governed by the Croatian Democratic Union (HDZ) since gaining independence from Yugoslavia in 1991. During a TV debate ahead of the Sunday vote, Milanovic and Primorac exchanged barbs while exposing deep political differences. Primorac, 59, entered politics in the early 2000s, when he was science

and education minister in the HDZled government. He unsuccessfully ran for the presidency in 2009, and after that mainly focused on his academic career including lecturing at universities in the United States. China and in Croatia. Milanovic denied he is pro-Russ-

ian but last year blocked the dispatch of five Croatian officers to NATO's mission in Germany called Security Assistance and Training for Ukraine. He also pledged he would never approve sending Croatian soldiers as part of any NATO mission to Ukraine. Plenkovic and his government say there is no such proposal.

Milanovic accused Primorac of associating with "mass murderers," referring to Israeli Prime Minister Benjamin Netanyahu's associates and the war in Gaza. He also claimed that Plenkovic was Primorac's sponsor. and dubbed Primorac "the last communist" — a reference to his membership of the former ruling Communist Party of Yugoslavia in the late 1980s. MOSCOW, Jan 12: An emergency task force arrived in Russia's southern Krasnodar region on Sunday as an oil spill in the Kerch Strait from two storm-stricken tankers continues to spread a month after it was first detected, officials said.

The task force, which includes Emergency Situations Minister Alexander Kurenkov, was set up after Russian President Vladimir Putin on Friday called on authorities to ramp up the response to the spill, calling it "one of the most serious environmental challenges we have faced in recent years".

The Emergencies Ministry said Saturday that over 155,000 tons of contaminated sand and soil had been collected since oil spilled out of two tankers during a storm four weeks ago in the Kerch Strait, which separates the Russia-occupied Crimean Peninsula from the Krasnodar region.

Russian-installed officials in Ukraine's partially Russian-occupied Zaporizhzhia region said Saturday that the mazut — a heavy, low-quality



oil product — had reached the Berdyansk Spit, some 145 km north of the Kerch Strait. It contaminated an area 14 1/2-km long, Moscow-in-In response to Putin's call for acstalled Gov Yevgeny Balitsky wrote on Telegram.

Russian-appointed officials in Moscow-occupied Crimea announced a regional emergency last weekend after oil was detected on the shores of Sevastopol, the peninsula's largest city, about 250 km from the Kerch

tion, Ukraine's Foreign Ministry spokesman Heorhii Tykhyi accused Russia of "beginning to demonstrate its alleged concern' (only) after the scale of the disaster became too obvious to conceal its terrible conse-

"Russia's practice of first ignoring the problem, then admitting its inability to solve it, and ultimately leaving the entire Black Sea region alone with the consequences is yet another proof of its international irresponsibility,"

Tykhyi said Friday.

The Kerch Strait is an important global shipping route, providing passage from the inland Sea of Azov to the Black Sea. It has also been a key point of conflict between Russia and Ukraine after Moscow annexed the peninsula in 2014.

In 2016, Ukraine took Moscow to the Permanent Court of Arbitration. where it accused Russia of trying to seize control of the area illegally. In 2021, Russia closed the strait for several months.

Mykhailo Podolyak, an adviser to the head of Ukrainian President Volodymyr Zelenskyy's office, described the oil spill last month as a "large-scale environmental disaster" and called for additional sanctions on Russian tankers. (AP)

3 Naxalites killed in encounter

BIJAPUR, Jan 12: Three Naxalites were killed in an encounter with security personnel in Chhattisgarh's Bijapur district on Sunday, police said.

The gunfight broke out in the morning at a forest in the Indravati National Park area when a joint team of security personnel was out on an anti-Naxalite operation, Inspector General of Police, Bastar Range, Sundarraj P said.

Personnel belonging to the District Reserve Guard (DRG), Special Task Force (STF) and District Force were involved in the operation, he said.

After the intermittent exchange of fire stopped, bodies of three Naxalites clad in 'uniform' along with firearms, including the automatic ones, and explosives were recovered from the site, the official

Search operation was still underway in the area, he added.

With this, 12 Naxalites have been killed in separate encounters in the state so far this year.

During a three-day long anti-Naxal operation by security forces in Abujhmad on the border of Narayanpur-Dantewada-Bijapur districts that concluded on January 6, five Naxalites, including two women, were killed.

On January 9, three Naxalites were killed in an encounter with security forces in Sukma district. Earlier, on January 3, a Naxalite was killed in an encounter with security personnel in Gariaband district, which falls in Raipur division.

Last year, 219 Naxalites were neutralised by security forces in separate encounters in the state. On January 6 this year, Naxalites

blew up a vehicle with an IED in Bijapur district, killing eight police personnel and their civilian driver. (PTI)

Silver Notice 'more effective' than MLATs for info on offshore illicit wealth: CBI Director



NEW DELHI, Jan 12: Terming the recently introduced Interpol 'Silver Notice' a "more effective" tool than the Mutual Legal Assistance Treaties (MLATs) for gathering information on illicit assets parked offshore, CBI Director Praveen Sood has said it was Prime Minister Narendra Modi's idea, which has now

In an exclusive interaction with PTI, he said Prime Minister Modi had proposed in 2015 a system under the Interpol to trace money laundered offshore, and it has now taken shape as the Silver Notice.

The Notice, aimed at locating illicit assets laundered across borders, is the newest addition to the Interpol's suite of eight colour-coded Notices and Diffusions, which enable countries to share alerts and requests for information worldwide. Conventionally, the information on illicit assets is

gathered through MLATs which are treaties between two countries whereby they cooperate to provide and sion, investigation, and prosecution of crime.

Common complaints under MLAT include requests being transferred from one agency to another or one bank to another. Sometimes difficulties arise in obtaining a response because of a large number of re-

An hour before G20 Summit, PM asked Kant to evolve 'consensus' on Delhi declaration: Book

NEW DELHI, Jan 12: An hour before the start of the G20 Summit here on September 9, 2023, Prime Minister Narendra Modi asked Sherpa Amitabh Kant the status of the leaders' declaration and when told there were some issues, he asserted he just wanted to see the re-

sult - a "consensus" - very soon. Kant immediately went into a huddle with fellow Sherpas and managed to secure the final agreement. These behind-the-scene happenings find mention in Kant's new book "How India Scaled Mt G20: The Inside Story of the G20 Presi-

India had pulled off a big diplomatic win after the G20 summit adopted a consensus declaration overcoming major differences on the Russia-Ukraine war.

Modi made the announcement about a consensus on the 37-page declaration and its subsequent adoption at the start of the second session on the opening day of the two-day summit of the grouping of major developed and developing

Kant says the journey from the principles to the final draft of the NDLD (New Delhi G20 Leaders' Declaration) was, however, far from

"The text continued to face constant revisions and objections after 300 hours of negotiations over 250 bilateral meetings. The weight and seriousness of the negotiations were felt by all participants, but the pursuit of a mutually agreeable out-

come still seemed far from reach," he writes in the book, published by

"PM Modi was acutely aware of the stakes involved. He had asked me to send him urgent situation reports every two hours, a task that demanded immense multitasking and quick analysis. This constant communication kept PM Modi informed, but also spurred us into action, helping us map out the negotiations and take stock of our progress," he adds.

According to Kant, Russia insisted on the inclusion of the word sanction' and this led to extensive discussions with Alexander Pankin, Deputy Minister of Foreign Affairs of the Russian Federation, lasting for two-and-a-half hours, to persuade them to reconsider.

"The stakes were high, as refusal to compromise would have left Russia isolated with a 19-1 vote against it. We finally had to tell Russia that this was not feasible and would not be accepted by other countries. We made it abundantly clear to Russia that its insistence on this matter put significant pressure on India and made it impossible for us to move forward," he recalls.

Kant says that throughout the negotiations, the G7 countries were pressuring India to invite Ukrainian President, Volodymyr Zelenskyy but India's stance was to keep the guest list exclusive to the G20 lead-

"On Dr Jaishankar's advice, I had to inform the Russian negotiator

that if they didn't agree, the first speaker following PM Modi's speech would be Zelenskyy. This bold and assertive negotiation tactic ultimately worked, and Russia relented," he says.

But there was another hurdle, Kant says. The head of the Chinese team pointed out a bilateral challenge with the US, stemming from a greened portion of the G20 declaration that stated that the 2026 G20 Summit would be hosted in the US. The Chinese Sherpa explained

that the US would not grant them visas, not even for their governor in Hong Kong. They would not agree to the geopolitical paras until they received a written guarantee that they would be issued visas, the Kant then recalls that at about 8

Modi visited the Bharat Mandapam for an inspection before the start of the leaders' meeting. "I was to brief him on our progress so far. When he enquired about the Leaders' Declaration, I outlined the conflict between the US and China and informed him

that the NDLD was still not final-

in the morning of September 9,

"He paused for a moment, wondering as to why bilateral issues were being raised in a multilateral meeting, before replying that he did not want to get into the procedures or the process, but wanted to see the result - a consensus - very soon. He expected the Sherpa to navigate and secure the final agreement," the

The leaders' meeting commenced at 9 a.m. and Kant had to undertake parallel negotiations in a dedicated session from 9:30 to 11:30 a.m., in the room adjacent to the Leaders' Hall in the Bharat Mandapam.

"I, along with (US Sherpa Mike) Pyle and Li (Kexin, head of the Chinese team), hammered out the details of the letter. We opted to use the term 'ensure' instead of 'guarantee'. By noon, we had successfully resolved this bilateral matter, even though technically it was beyond the scope of India's role as G20 Chair.

"With China's consent, and both of America's conditions met, Russia, the US, China, the G7, and all countries were finally on board," Kant writes.

He says a consensus was thus reached on the very first day of the Leaders' Summit, unlike at the 2022 Bali Summit, where negotiations on the declaration text dragged on until the final hours. He called this "no small feat".

And so, after lunch on September

9, Modi made the official announcement of the declaration. Kant says his book tells the story of how a nation, once seen as a developing power, rose to lead the world stage—offering solutions, forging alliances, and building a lasting legacy that reflects the aspi-

rations of both developing and de-

veloped worlds. The book has a

Australian Open: Olympic champ Zheng Qinwen starts her bid for another final on a rainy Day 1

wen's tennis resume is quite different from what it was when she showed up at the Australian Open a full year ago. No matter everything she accomplished in 2024 — a runner-up finish at Melbourne Park; an Olympic gold medal for China — she felt jitters before entering Rod Laver Arena on Sunday. After overcoming some hiccups late in the opening set of her first-round match on a stormy Day 1 at the season's first major tennis tournament, Zheng came through with a 7-6 (3), 6-1 victory against Anca Todoni, a 20-

has won one Grand Slam match in her career. "Actually, I feel really nervous," said Zheng, who is seeded No. 5. "I started to feel nervous already since yesterday, 'cause I felt special emotion for the Australian Open. ... I really like
