2026 assembly polls: Assam Cong set for major shuffle

The major change in party organisation will be from booth to state level: Bhupen Borah

GUWAHATI, Jan 5: Assam gress president Bhupen Kumar Borah on Sunday said he will carry out a statewide reshuffle of all office-bearers of the party in February, with an eye on the assembly elections next year.

In an interview with PTI, he said around 90 per cent of the officebearers will be changed after assessing their capability, loyalty and performance in the last three-andhalf years.

"I'll carry out a statewide reshuffle in February to strengthen the party, keeping an eye on the next year's assembly elections,' Borah said.

The major reshuffle in party organisation will be from booth to state level, and the central leadership of the Congress has also given its consent to the proposed reorganisation, he added.



When I took charge as the PCC president in 2021, the party was demoralised after losing the state elections for the second time in a row. At that time, many MLAs and party leaders left us and joined the "Now, people are coming back

and joining the Congress. So, we have more capable and deserving people in the party. Those who have capability to work will get chance accordingly," Borah said.

Elaborating the proposed reshuffle process, the senior Congress leader stated that the party formed a Political Affairs Committee (PAC) in every district and it gave suggestions to change office-bearers at booth, block and district levels.

He said that the reshuffle exercise will begin from the booth level as per the recommendations of the district PACs and almost 90 per cent of the Assam Congress's of-

Chinese annexation of Indian territory occurred during Nehru's term: BJP

NEW DELHI, Jan 5: The BJP on Sunday flayed the Congress for alleging Chinese occupation of the Indian territory during Prime Minister Narendra Modi's term and said the grand old party cannot get away with "such lies" as all of it occurred during Jawaharlal Nehru's tenure.

The BJP's reaction came a day after the Congress alleged in a post

on X, "China kept occupying India's land. Narendra Modi kept giving clean chit." Reacting sharply, BJP IT department head Amit Malviya said the Congress has the "dishonesty" to speak of Chinese annexation of the Indian territory despite the fact that all of it occurred during Nehru's tenure as the prime minister.

"Imagine blaming Prime Minis-

ter Modi for Nehru's betrayal," he said in a post on X. "The Congress cannot get away with such lies, even if Rahul Gandhi thinks otherwise," he added. Malviya said the "reality" is that He'an County is the new name for Aksai Chin, which China occupied by 1962.

Govt should lower GST on cement at 18 pc, frame policy to boost demand: JK Lakshmi

PATNA. Jan 5: The government should reduce GST on cement to 18 per cent from 28 per cent and take some policy measures in the upcoming Budget to boost consumption of this key building material, a senior official of JK Lakshmi Cement said.

In an interview with PTI, Arun Shukla, President and Director of JK Lakshmi Cement, said there is a case to increase cement manufacturing capacity in India to meet the rising demand, which is expected to grow at an average annual rate of 7-8 per cent. "One of the longcherished dream, or the wish for us, has been reducing GST on cement," Shukla told PTI on the sidelines of 'Bihar Business Connect 2024' meet held here recently.

In India, cement is taxed at the highest rate of 28 per cent and this needs to be reduced to 18 per cent, he said while replying to a query on the Budget wishlist from the industry. "Cement is, I would say, one of the major component of driving growth in the economy," Shukla said, adding that cement is required to build world-class infrastructure that can support the growth of the Indian economy.

He also emphasised on the need to enhance the consumption of cement in India. "Cement is one of the major drivers of growth, so how we can really increase consumption of cement?" he said.

Shukla said the cement concrete roads have more longevity and in the long run and it is more cost-ef-

FDI in India surging as global investors see top destination: Piyush Goyal NEW DELHI, Jan 5: FDI inflows into the

country are surging, with investors from the Middle East, Japan, European Union, and the US recognising India's status as a top investment destination, driving rapid economic growth and generating millions of new jobs, Commerce and Industry Minister Piyush Goyal has said.

He said that global investors are showing keen interest in India as the country offers several advantages such as strong domestic market, skilled and talented workforce and rule of law. "I can clearly see FDI (foreign direct investment) in India once again growing rapidly and creating millions of jobs. Countries in the Middle East, EFTA region. Japan, and investors from the EU and the US are all realising that India continues to be the most preferred destination for FDI," Goyal told PTI.

He added that India's stable and predictable regulatory framework, coupled with a favourable business environment and progressive policies aimed at enhancing ease of doing business, is attracting an increasing number of investors from around the world.

'So my wish would be to really kind of drive this (cement consumption), through maybe some of the policies and specifications...," he said. JK Lakshmi Cement, part of the JK Organisation, is investing Rs 500 crore in Bihar to set up a manufacturing plant in Madhubani district. The Bharat Hari Singhania family-promoted JK Lakshmi Cement had signed a Memorandum of Understanding (MoU) with the state government in 2023 investors' meet itself for its proposed manufacturing unit. The company has already ac-

quired land and is in the process of obtaining other approvals to set up the plant. "We want to cater to local demand from this plant at Madhubani in Bihar," he said, adding that the plant is expected to be operational within a year.

Shukla complimented the Bihar government for fulfilling its promises, including fiscal incentives, saying "they are really walking the talk". About the company's experience in Bihar so far, Shukla said, "I think the experience has been encouraging, and the very reason I am here for the second time to attend this meeting was to express my gratitude, but to also encourage my other colleagues to set up.... 'The kind of support we have

got from all corners, all departments and the bureaucracy in Bihar was amazing. And this is one of perhaps the best experience which we had in setting up a new plant at new location," he said. J K Lakshmi Cement has 18 million tonnes of annual capacity.

"We have set a target to reach 30 million tonnes by 2030," he said. The 12 million additional capacity after studying all aspects. (PTI)

expansions across various geographies are on track, Shukla said. On consolidation in the cement sector, Shukla said, "I think this is a myth. I would say, if you really look at the statistics, top five players have been kind of holding on to about 55-57 per cent of the cement capacity, that situation is still there, it's not changing much."

Although cement demand in 2024 was low due to elections and cyclic nature, he said, "going forward, I think we clearly see a CAGR of 7-8 per cent. "And if you really look at the capacity addition, which is happening is about 5-6 per cent. So still, I think the demand and supply is in favour of adding cement capacity. So consolidation in that way also is not going to impact much," he said.

The prices go along with the demand and if the demand improves, prices will improve, he quipped.

JK Organisation has overseas manufacturing operations in Mexico, Indonesia, Romania, Belgium, Portugal, and the UAE. It owns companies such as JK Tyre, JK Paper, JK Fenner, and Umang Dairies besides JK Lakshmi Cement.

Shukla said the JK Organisation is exploring to invest in other sectors as well like tyre and paper manufacturing. "JK Organization is quite a diversified group. And the objective was to really explore other opportunities as well," Shukla said, adding that the group will decide on further investments

Tighter anti-spam norms in a month TRAI pilot soon to onboard past user consents onto digital system plan for fixed line, while work will continue on

NEW DELHI, Jan 5: TRAI will start, this month, a pilot to onboard paper-based and past permissions given by customers for receiving commercial communications onto its digital distributed ledger technology (DLT) platform, a process that in the long-run would include scrubbing and verifying their current validity and offering opt-outs to those keen on it, Chairman Anil Kumar Lahoti said, adding that tighter regulations on curbing spam as well as new consultation examining an authorisation framework for telemarketers can also be expected in coming weeks.

Telecom Regulatory Authority of India (TRAI) has also ruled out any rethink on its latest regulation that mandates service providers to offer separate special tariff vouchers (STV) for voice calls and SMS. Lahoti told PTI in an interview that while consumers can be encouraged to use data, they cannot be "compelled" to do so. TRAI's focus is to protect not only the interest of the industry, but also the interest of the consumer, who must have the option to pay only for services they need, he said.

The regulator is also all set to initiate a massive rehaul of its IT system, a move, it expects, would

2 pilots, 1 crew member killed as chopper crashes at Porbandar airport

GUJARAT, Jan 5: Two pilots and a crew member were killed on Sunday after an Indian Coast Guard helicopter on a routine sortie crashed at Porbandar airport runway in Gujarat and caught fire, officials said. The maritime security agency said the reasons for the incident are being investigated through a Board of Inquiry

"ICG ALH MK-III helicopter CG 859 met with a mishap at Porbandar Airport Runway at about 1215 hrs on 05 Jan 25. The ICG helicopter had 02 Pilots and 01 Air Crew Diver at the time of the incident and was on a routine training sortie," an ICG statement said.

Immediately after the incident, the crew was rescued and shifted to a government hospital at Porbandar, where they were declared as brought dead.

The deceased are Commandant (JG) Saurabh, Deputy Commandant SK Yadav and Navik Manoj Pradhan. They will be cremated as per service tradi-

tions and honour, the ICG stated.

Porbandar Superintendent of Police Bhagirathsinh Jadeja said the chopper crashed while landing near the Porbandar airport runway and caught fire.

"The chopper was returning and trying to land when the incident occurred near a runway. Three crew members were present on the chopper. They were rescued and rushed to Bhavsinh Civil Hospital in Porbandar with severe burn injuries, but none of them survived," the police officer told reporters earlier in the day.

The Porbandar airport contains separate enclaves for the Indian Navy and the ICG.

The latest incident comes four months after ICG's ALH MK-III helicopter crashed into the Arabian Sea off Porbandar on September 2, 2024, killing three crew members.

The bodies of its pilot and a diver were recovered soon after the incident, while the mortal remains of the third crew member after more than a month. (PTI)

he said, "No alliance will take place at the state level, but district units have been authorised to take a decision on the alliance with like-minded opposition parties." He pointed out that there are nearly 22,000 wards in 2,200 gaon panchayats and it is not possible to form an alliance for so many wards while sitting in Guwahati.

"So, Assam PCC has already instructed its district units that they can make an alliance with any anti-BJP party at district or block level. They are free to do so. We will be happy if any of our district units form alliances with any anti-BJP parties," Borah said.

The Congress state chief also mentioned the party's preparation for the assembly elections in Assam in 2026 and elaborated various programmes, including several 'yatras', planned during the year.

"The day panchayat elections are over, we will start a new journey from Sadiya to Dhubri, covering 45 assembly constituencies at one stretch. The second yatra will be from Sadiya to Mandia. All leadership will participate in these yatras," he added.

Borah said that the government is likely to announce the panchayat election schedule within January, following which every party leader and worker will be busy for it.

In the meantime, All India Congress Committee has declared 'Jai Sangbidhan, Jai Bhim and Jai Bapu' Yatra in every booth and mandal of the country, and the Assam unit will also implement such programmes, he added.

"These are our immediate plans. In between, I think there will be another round of elections in Rabha Hasong, Tiwa and Sonowal-Kachari autonomous councils. We will accordingly participate in these councils polls also, he said.

Asked about the Congress's strategy to fight the 2026 assembly elections in Assam, Borah said the aim of the party is to unite all the anti-BJP political parties, organisations and individuals to defeat the NDA.

"For this, definitely we will have to sacrifice some seats and we are ready to do so. In 2021 also, we contested 97 seats out of 126. This time as well, we will definitely sacrifice as per the situation," he added

The Congress chief stated that during the recent Congress Working Committee (CWC) meeting in Karnataka, it was decided to intimate the possible candidates 8-9 months before the assembly elections so that he or she can be involved in all party activities and prepare their constituencies in the run-up to the voting

"AICC will make an independent survey to see who will be the best candidate for the 2026 polls. In earlier elections, our prime criteria for selection of candidates was only winnability. This time, along with winnability, ideological commitment to the party or credibility of the candidate will also be assessed.

"We do not want a similar situation like Manipur, Maharashtra or Madhya Pradesh. We are very confident that the people of Assam want a change and kick the BJP government out of power. So, winnability and loyalty of a candidate will be the primary criteria in the selection of the candidate," he added.

Borah said that chief minister Himanta Biswa Sarma's assertion that 'Assam is shining' will bring the same result like what the 'India Shining' campaign of former PM Atal Behari Vajpayee did to the BJP government in 2004.

"The India Shining campaign brought Manmohan Singh government for 10 years. Likewise, Assam Shining as stated by our CM will bring the curtains down on the BJP government in Assam. The state is shining only for Sarma, his syndicate friends, non-Assamese contractors and non-Assamese capitalists," he added. (PTI)


CII proposes seven-point agenda to boost employment generation in budget

NEW DELHI, Jan 5: The upcoming annual budget for FY26 could announce further measures to boost employment generation, CII said on Sunday, emphasising that job creation at a mass scale is important to engage the young population productively, and drive inclusive growth in the world's most populous nation.

The industry body has suggested a seven-point agenda to harness India's demographic dividend, including an integrated national employment policy, support to labour-intensive sectors, and setting up an international mobility authority, among other targeted measures. With a median age of just 29 years, India is a young country, and is set to add 133 million people to its working-age population by 2050.

The government could consider launching an internship programme in government offices in rural areas for the college-educated youth, CII said. It argued that this initiative would create short-term employment opportunities in government offices while bridging the gap between education and professional skills

The programme would also help augment the available manpower



resources for the effective implementation of various rural programmes and government initiatives. CII has also proposed introducing a new provision under income tax rule in lieu of Section 80JJAA to encourage new employment. The new provision should

continue as Chapter VIA deduction from gross total income, which is available even if a taxpayer opts for concessional tax regime. It has proposed an integrated na-

tional employment policy which could subsume under its ambit the slew of employment generating schemes currently in works by various ministries/states.

In addition, the unified policy could also build on the single integrated employment portal -- National Career Service (NCS) -wherein all the data can flow into this from various ministries and state portals.

Highlighting that increasing women's participation in the workforce, which currently is low, can further boost the Indian economy, CII said, new initiatives including the construction of dormitories using CSR funds, the formalisation of sectors like care economy, and government-supestablishing ported creches in industrial clusters could be taken to increase female labour force participation. Moreover, rolling out labour codes while ensuring social security coverage to the gig and platform workers would further strengthen the employment landscape. Many parts of the world are facing workforce shortages due to ageing populations, and India should leverage this opportunity. The government could consider setting up an international mobility authority under the Ministry of External Affairs. This authority could facilitate G2G collaborations for helping Indian youth tap the overseas employment opportunities.

The authority could also work with the Ministry of Skill Development and Entrepreneurship to help develop skill development programmes aligned with global opportunities. In addition to technical skills, the programmes should also include cultural training, and foreign language skills.

Labour reforms and budget

The year 2024 saw the Union Government of India meticulously preparing the ground for proposed labour reforms, including the four controversial labour codes, and Employment Linked Incentive (ELI), though could not roll them out because of a range of issues, including hesitant attitude of India Inc and opposition from the joint platform of the 10 Central Trade Unions (CTUs). However, preparations reached an advanced stage, and the Union Government is almost ready to implement labour reforms in a big way in 2025. The Union Ministry of Labour and Employment has been consistently working for harmonization of rules under the four labour codes - the Code on Wages 2019, Industrial Relations Code 2020, Occupational Safety, Health and Working Conditions Code 2020, and Code on Social Security 2020, which have been resisted by the joint platform of 10 CTUs since 2020 even organizing all India strike actions, and are still demanding their withdrawal, alleging that they are anti-labour and pro-corporate, and their implementation would make workers suffer like economic slaves.Union Government on the other hand claims that implementation of these codes would bring much desired labour reforms which will benefit both the workers and employers.

PM Narendra Modi has committed himself for implementation of these codes which he said the biggest reform in independent India. During the year, 6 regional meetings were held between August and October, 2024 to facilitate State/UT Governments for framing the Rules within the ambit of Labour Codes, since labour is a state subject and rolling out implementation of the Codes legally require states own rules. Now, all 36 States/UTs are expected to complete harmonization and pre-publication of draft rules by 31st March 2025, the Union Ministry of Labour and Employment has said. Not only that, the Union Ministry of Labour & Employment has identified four reforms in Labour Laws to be carried out viz. Single Registration, Single Return, Firm-based common license with 5 years validity. Further the Ministry is also moving for change of role of Inspector to Inspector-cum-Facilitator. These steps, the Centre expects, would act as a catalyst for Ease of Doing Business (EODB) by reducing compliance burden. EPFO has released the updated Manual for Inspector cum Facilitator describing entire spectrum of duties and responsibilities of an Inspector cum Facilitator.


As for ELI Scheme announced in July 2024 in the Union Budget 2024-25 is concerned, it could not take off last year, again due to a range of issues, including the hesitations among the employing companies of the country in participating in the programme. Union Government had announced this programme as a major step towards incentivising job creation, promoting formalisation in job market, and improving employability. Three Schemes announced for large number of decent job creation under ELI and two other schemes as part of the five-package schemes had a total outlay of Rs 2 lakh crore and was expected to benefit around 4.1 crore young people over the next five years. Since, the Union Budget 2025-26 is expected to be tabled in the parliament of India on February 1, there is not much time left in implementation of the ELI Schemes announced in the Union Budget 2024-25. One year has already been lost. Nevertheless, Union Government is trying hard to roll out the scheme in the current financial year 2024-25 ending on March 31, 2025 itself.

he deployment of smart me-ters in Assam has sparked a highly polarized debate in society about the utility or nonutility of smart meters. With people on both sides voicing opinions, people today increasingly perceive smart meters as the building blocks for the modernization of energy use. They are based on the ability to offer correct billing, efficient energy management, and reduced power theft, all of which fall in line with the overall sustainability and enhanced electricity supply objectives of the state. However, the deployment of that technology has been faced with disbelief and anxiety, since fears of ballooning electricity bills, health effects, and data security drive the agenda in public debate. This study examines the complex component of public attitude and looks into the promise and problems in regard to the smart meters introduction in Assam. Supporters of Smart metering

assert that all the basic solutions to these old-time energy management problems are to be gained by using them. The problem and reasons behind consumer disputes, especially concerning the billings, can be traced majorly from analog meters due to the potential error that a human mind makes in it. Smart meters eliminate these problems as they offer accurate real-time information about the amount of electricity being used and bill accurately users for the amount of electricity they used. In Assam, which is facing a scenario of billing errors with consequent loss of public trust in the utility companies, the technological one is perceived to be the first step to re-earning public confidence. Furthermore, smart meters empower consumers to take better control of their energy use. With a detailing

of patterns of usage, the reason for households to adapt energy-saving practices will consequently result in aggregate cost decreases and also aid in saving the environment. As a state facing a volatile power supply with increasing energy needs, the potential of smarter demand-side management delivered by smart meters is attractive. All of these benefits, however,

are accompanied by the pervasive feeling of mistrust in smart meters. Of most concern to the public is



the rise in electricity tariff. Installation and operation of smart meters are highly costly, and there is public anxiety about liability falling on consumers' shoulders. Electricity rates already compare unfavorably with the national average in Assam, burdening household incomes barely above subsistence level. The threat of additional installation charges for meters, service charges, or even increased tariffs has been something that has fueled fear particularly within economically weaker communities. Critics argue that government and utility companies have a responsibility to ensure that technology does not worsen existing disparities in access to energy or exacerbate the burden of energy costs on consumers.

Utility companies' failure to communicate candidly has only amplified these fears. There is still much confusion for residents as to what effect the roll out of smart meters will have on their monthly costs. Lack of well-defined protocols and public consciousness raising actions have led to mistrust in that part of the population believes the scheme is driven by financial profitability rather than consumer well being. These fears need to be addressed through proactive engagement with the public, including transparent explanations of cost structures and assurances that tariffs will remain affordable. Health issues are, however sub-

stantially shaping public attitudes. Smart meters give minimal levels of electromagnetic radiation emitters to transmit data that though literature is seen being under the limit of a safe threshold, the people are not ready to welcome it. The skepticism to the new installation is nothing new to Assam rather an expression of anxiety happening around the globe on effects to

Taking note of issues of privacy, utilities should then take measures towards assuring their security, acting on stringent ethical imperatives in dealing with such consumer information.

The use of smart meters in Assam speaks of problems more generally with switching over to this new generation energy solutions. Despite the great potential of the technology for efficiency and sustainability, the adoption of the technology is shaped by managing the public relations challenges of negative and positive public sentiment. The modernization process should be taken into account with the needs of the population, a careful and open to all involved strat-Clear communication, egy. equitable policies, and strong safeguards must ensure that the smart meters do not end up benefitting only one section of society.

Rural development is generally conceived as a multi-sectoral activity which includes, besides agricultural development, rural industries, the establishment or improvement of social overhead facilities or infrastructure, such as schools, clinics, roads, communication, water supply, markets, welfare sources, improved

meant to give an opportunity for local initiative and participation in the developmental activities. India's vast majority of people live in rural villages. They are largely dependent on remote and unresponsive government (the Central and the State) historically



characterised as -centralised, bureaucratic, corrupt and nontransparent. In most parts of rural India there had been a continuous and deep rift between the people and the government. The people do not have proper access to the information regarding the developmental plans, schemes and actions of governments. Further, they have no effective means to influence the policies, programmes or resource allocations for their development.

The Constitution of India has given a place of pride to the attainment of the ideal of securing justice to all citizens. The Preamble speaks of the resolve to secure to all the citizens of India Justice which is defined or elaborated as social, economic and political. More significantly, the Preamble places justice higher than the other principle of liberty, equality and fraternity. The concept of Justice in the Preamble is indeed very wide. It is not confined to the narrow legal justice as administered by the Courts. Again the juxtaposition of words is important in as much as it gives precedence to social and economic over political justice. Article 38 especially embodies the preambular concept of justice ies, i.e., the Panchayats (Panchayati Raj Institutions: PRIs) and the Municipalities (Urban Local Bodies: ULBs). The local bodies are critical to the inclusive governance as they facilitate direct participation of people, particularly the marginalized, in governance. They also en-

> sure transparency and accountability of the public institutions and functionaries through processes such as, social audit. They can prepare context specific plans to address poverty, local infrastructure and socio-economic needs. The Eleventh Plan document recognizes PRIs as the "primary means of delivery of essential services that are critical to inclusive growth". Strengthening of the local bodies is, therefore, critical to improving governance across the

country and ensuring that the benefits of the huge funds routed through the Central/State Schemes reach the people in full measure. The rural and urban areas represent a political, social, economic and geographical continuum. However, in the present system, there is an artificial divide between rural and urban local governments, which has several shortcomings. First, the planning and management of socio-economic development including basic public services are artificially segmented. Second, in a rapidly urbanizing society, the boundaries between rural and urban territories keep shifting. The peri-urban areas around cities have dual characteristics of both the village and the town. Finally, as a democratic body representing the whole district does not exist and the District Collector continues to be the symbol of authority in the district, democratic decentralization is undermined. In all, the artificial separation of rural and urban local governments leads to fragmented planning and implementation, sub-optimal utilization of resources (manpower and financial) and vital gaps.

Medical myths: All about dementia

oday, an estimated 5.8 million people aged 65 years or older in the United States have dementia.

Due to the fact that the average lifespan of people in the U.S. has increased over recent decades, some experts project that by 2050, the number of older adults with dementia could reach 13.8 million.

Figures of this stature spark justifiable fear, and, as we have found in previous Medical Myths articles, fear tends to breed misconceptions.

In this article, we aim to dispel 11 of these myths

1. Dementia is inevitable with age

This statement is not true. Dementia is not a normal part of aging.

According to a report that the Alzheimer's Association published, Alzheimer's disease, which is the most common form of dementia, affects 3% of people aged 65-74 years in the U.S.

As a result of the risk increasing as we age, 17% of people aged 75–84 years and 32% of people aged 85 years and older have a dementia diagnosis

2. Dementia and Alzheimer's disease are the same thing

This is not quite correct. Alzheimer's is a type of dementia, accounting for 60-80% of all dementia cases. Other types of dementia include frontotemporal dementia (FTD), vascular dementia, mixed dementia, and Lewy body dementia.

The National Institute on Aging define dementia as "the loss of cognitive functioning thinking, remembering, and reasoning - and behavioral abilities to such an extent that it interferes with a person's daily life and activities."


Although dementias share certain characteristics, each type has a distinct underlying pathology.

Alzheimer's disease is associated with a buildup of so-called plaques and tangles in the brain. These structures interfere with brain cells, eventually killing them. In contrast, brain cell death in vascular dementia occurs due to a lack of oxygen, which can result from a stroke, for instance.

FTD, as another example, occurs when abnormal protein structures form in the frontal and temporal lobes of the brain, causing the brain cells in these regions to die.

3. A family member has dementia, so I will get it

A common myth is that dementia is purely genetic. In other words, if a person's family member has a dementia diagnosis, they are guaranteed to develop dementia later in life.



This is not true. Although there is a genetic component to some forms of dementia, the majority of cases

do not have a strong genetic link. As we learned above, rather than genetic factors, the most significant risk factor for demen-

tia is age. However, if a parent or grandparent developed Alzheimer's when they were younger than 65 years, the chance of it passing on genetically is higher.

mon, though. It occurs in about 5.5% of all Alzheimer's cases.

Alzheimer's disease, this means that most dementia cases are not hereditary. FTD, which is much less common, has a stronger genetic link, but if a parent or grandparent develops the condition, it does not mean that children or grandchildren are guaranteed to develop it.

Today, FTD affects an estimated 15-22 in every 100,000 people. Of these individuals, 10-15% have a strong family history of the condi-

4. Dementia only affects older adults

Age is a risk factor for dementia, but dementia can affect younger adults in rare cases. Some scientists estimate that, in people aged 30-64 years, 38-260 people in 100,000 — equivalent to 0.038-0.26% — develop early-onset demen-

In the 55–64 age bracket, this increases to close to 420 people in 100,000, or 0.4%.

5. Using aluminum pans causes Alzheimer's In the 1960s, scientists injected rabbits with high levels of aluminum. They found that the animals developed neurological lesions similar

to those that form in the brains of people with Alzheimer's

Additionally, some studies have identified aluminum within the plaques associated with Alzheimer's. However, aluminum also appears in the healthy brain, and researchers have not established a causal link between this element and the disease.

Following on from these studies, myths still circulate that drinking from aluminum cans or cooking with aluminum pots increases the risk of Alzheimer's.

However, since those early experiments, scientists have not found a clear association between Alzheimer's and using aluminum pots

Although researchers will, eventually, establish the precise relationship between aluminum and Alzheimer's, consuming aluminum through the diet is unlikely to play a major role.

As the Alzheimer's Society explain: "Aluminum in food and drink is in a form that is not easily absorbed into the body. Hence, the amount taken up is less than 1% of the amount present in food and drink. Most of the aluminum taken into the body is cleaned out by the kidneys.'

However, they also write that some research has found "a potential role for high dose aluminum in drinking water in progressing Alzheimer's disease for people who already have the disease.

6. Dementia signals the end of a meaningful life

Thankfully, this is not the case. Many people with a dementia diagnosis lead active, meaningful lives. Some people fear that if a doctor diagnoses them with dementia, they will no longer be able to go for a walk alone and will have to stop driving their vehicle immediately.

It is true that these adjustments may come in time as the condition progresses, but in mild cases of dementia, no changes may be necessary. As dementia worsens, changes to the way an individual leads their life are likely, but that does not mean that the person cannot lead a fulfilling life.

"Too many people are in the dark about dementia — many feel that a dementia diagnosis means someone is immediately incapable of living a normal life, while myths and misunderstandings continue to contribute to the stigma and isolation that many people will feel," explains Jeremy Hughes, former Chief Executive of the Alzheimer's Society.

7. Memory loss always signifies dementia Although memory loss can be an early symptom of dementia, it does not necessarily signify the start of this condition. Human memory can be unpredictable, and we all forget things occasionally. However, if memory loss is interfering with everyday life, it is best to speak with a doc-

Although memory issues tend to be an early sign of Alzheimer's disease, that is not the case for other forms of dementia. For instance, early signs and symptoms of FTD can include changes in mood and personality, language difficulties, and obsessive behavior.

8. Dementia is always preventable

This, unfortunately, is untrue. Importantly, though, certain factors can either reduce the risk of certain types of dementia developing or delay their onset.

For instance, the Lancet Commission's 2020 report on dementia prevention, intervention, and care lists 12 factors that increase the risk of dementia:

less education

hypertension

hearing impairment

smoking

obesity

depression physical inactivity

diabetes low levels of social contact

alcohol consumption traumatic brain injury

air pollution Some of these factors are more difficult to modify than others, but working on changing any of them might help reduce the risk of developing dementia. The authors of the report explain:

"Together, the 12 modifiable risk factors account for around 40% of worldwide dementias, which consequently could theoretically be prevented or delayed.'

However, as Dr. Nancy Sicotte, a neurologist at Cedars-Sinai hospital in Los Angeles, CA, explains, "Reducing your risk requires starting these lifestyle changes from the get-go, not waiting until you're 70."

9. Vitamins and supplements can prevent dementia

Linked to the section above, this is also false. To date, there is no strong evidence that any vitamin or mineral supplements can reduce the risk of dementia. In 2018, the Cochrane Library conducted a review with the aim of answering this question.

Their analysis included data from more than 83,000 participants across the 28 included studies. Although the authors report "some general limitations of the evidence," they conclude:

"We did not find evidence that any vitamin or mineral supplementation strategy for cognitively healthy adults in mid or late life has a meaningful effect on cognitive decline or dementia, although the evidence does not permit definitive conclusions.'

10. All people with dementia become aggressive

In some cases, people with dementia might find it increasingly hard to make sense of the world around them. This confusion can be frustrating, and some individuals might respond to the emotions in an angry manner. However, this is not the case for everyone.

In a study involving 215 people with dementia, 41% of the participants developed aggression during the 2-year study. When they looked at factors that increased the risk of developing aggression, the researchers identified two of the primary factors as physical pain and a low quality relationship between the person and their caregiver.

11. Dementia is never fatal

Unfortunately, dementia can be fatal. According to a 2020 study among adults aged 70-99 years, dementia may be a more common cause of death than experts have traditionally thought. The authors "found that approximately 13.6% of deaths were attributable to dementia over the period 2000-2009.'

Dementia worries people, especially as they age, and this is justifiable in many ways. However, it is important to counter misinformation that might enhance concerns and stigma

For now, researchers are working tirelessly to develop better ways to treat and prevent dementia. In the future, hopefully, science will reduce the impact of dementia and, therefore, the fear associated with the condition. (Courtesy: Medical News Today)

a decade) in Sao Paulo, Brazil found that falling temperatures may increase the number of deaths from stroke, particularly among people over 65 years. Another German study published in the same year in the European Journal of Epidemiology discerned that for every 2.9-degree Celsius drop in temperature over 24 hours, strokes increased 11 percent, and at higher rates for those already at risk. In the year 2016, a study published in the Journal of Stroke Quality Index (AQI) clubbed with winter smog also aggravates the condition.

Though anyone is susceptible to get a stroke, however, people with existing cardiac problem, high blood pressure problem, smokers, obese and elderly need to be watchful as with the weather getting cold, they are the ones more vulnerable to get a stroke. In fact, such patients have a higher risk of even dying from heart disease as well.

Stroke, which can be because of blockage causing paralysis or burst of blood vessel leading to bleeding, is seen more commonly during the winters. This is an important problem, as stroke is recorded to be the third leading cause of death and disability and WHO estimates suggest that one in four people may suffer stroke over a lifetime.

It is particularly worrisome that many young patients with uncontrolled blood pressure have developed bleeding in the brain during this vulnerable period. Probably the sudden increase in blood pressure in cold weather has played a role in these particular patients.

Various studies conducted in Japan, Korea, USA and China also suggests that there are more chances of stroke during the winter months. Several studies suggest that during extreme cold conditions, the risk of getting a stroke attack increases by 80% particularly when temperature dips below 15 degrees Celsius. Last year a

and Cerebrovascular Diseases examined nearly 1.72 Lakh ischemic hospitalizations in the United States and found that most of them occurred in cold average temperatures and when temperatures fluctuated significantly. Taking care of this issue is very important because this may lead to more chances of this deadly disease.

Why is winters a potential season for the rising incidences of stroke?

One of the prime reasons can be attributed that during the cold seasons the blood vessels constrict, which leads to the increase in blood pressure, which is a major risk factor for stoke. Also, there are various changes in the chemical balance in our body during the winters that increases the chances of clotting. Probably the reason number of stroke cases go up by 11 per cent during winters.

Other factors include prevalence of unhealthy habits like too much eating and drinking combined with decrease in physical activity. And in countries like India, study of around 56000 stroke deaths (over High pollution levels and depleting Air **Reducing the risk of stroke in winters**

In order to curb down the chances for stroke and other cardiovascular events, the most vulnerable groups need to take sensible precautions to ensure and minimize the after-effects of extreme cold weather. it is strongly recommended to regularly monitor your blood pressure during this changing weather, particularly those who are already hypertensive. And even with mild changes or rise in the blood pressure, one need to immediately consult the doctor who can prescribe an adjustment in the medications.

It is also advised to keep warm and avoid sudden exposure to severe cold temperatures as the risk of stroke remains for many days after the exposure. The elderly are advised to keep warm and if possible heat the home as well. It is advisable to keep oneself well hydrated and avoid sudden excessive exertion, excessive drinking or unhealthy eating. While non-communicable diseases (NCDs) impact people of all ages, locations and nationalities and these illnesses are more frequently linked to older age groups, research indicates 17 million premature NCD deaths take place before the age of 70, with a majority in low- and middle-income countries.

Although weight gain is often the price of eating and drinking with family and friends, new research shows the link between eating healthy and living a long life may be more complex than we thought. In other words, burning fat isn't the only guarantor of a long and healthy life.

In 440 BCE, the Greek physician Hippocrates proposed: "Let food be thy medicine and let thy medicine be food" that emphasises the importance of nutrition to maintain overall health. As science continues to reveal the intricate effects of diet on health. longevity and quality of life, this ancient wisdom is more relevant today than ever.

People tend to throw caution to the winds during the festive season but it's what we eat over a longer period of time and other associated factors that most impact how our bodies function.

Changing the quantity, type and timing of food intake, including fasting, has become one of the most effective, practical and safe ways to enhance health and increase lifespan and healthspan, the lifespan minus the amount of time spent in illness.

The goal of this dual focus is to increase the number of years people live with full functional capacity and vitality.

Healthspan vs. lifespan

While extending life is a noble objective, improving healthspan is becoming more and more important. If the extra years are tainted by ill health and diminished functionality, then a longer life has little value

To balance longevity and ensure healthspan, dietary interventions must target non-genetic aspects of human health such as immunological function, inflammation and nutrient balance.

Promoting general health requires eating a diet that is well-balanced and full of proteins, lipids, carbohydrates, vitamins and minerals. Individual dietary requirements, however, differ according to age, sex, heredity and metabolic risk status. Dietary advice can be customised to these factors to maximise the advantages of any nutritional intervention.

Effects of calorie restriction on longevity Reducing caloric intake from one's daily requirements without causing malnutrition is known as calo-

rie restriction. It has been demonstrated to increase lifespan in a variety of species, including humans.

According to available data, calorie restriction may be able to alter risk factors for serious chronic illnesses such type 2 diabetes, heart disease, cancer and neurological conditions. Adopting a calorie restricted diet can have major advantages for people, though the extent of these advantages will vary depending on the age that the diet is started.

Chronic systemic inflammation, which can result in cellular damage, immune system deterioration,

Beyond cutting calories

Even while traditional calorie restriction has demonstrated promise, many people find it difficult to keep it up over time. As a result, novel dietary strategies including protein restriction and intermittent fasting have become attractive substitutes. These methods promote healthy aging without requiring a large calorie cut, making them simpler to follow.

Because of its potential to enhance metabolic health and lower inflammation, intermittent fastingmodulating the timings of food consumption while maintaining the required amount of calories by alternating between eating and fasting-has grown in popularity.

Protein restriction, which involves limiting the consumption of specific amino acids, also has advantages for preventing disease and aging. These methods support the overall objective of sustaining or even increasing longevity while improving health

Well-rounded strategies for longevity

Although aging and longevity are mostly determined by heredity, it is possible to control non-genetic factors like nutrition and lifestyle to increase longevity and health span through undertaking some fundamental changes.

Adopting a balanced diet with food that is high in vitamins and minerals and optimal for proteins, fats and carbs can promote immunological and general health. Moderating calorie consumption - consuming only the daily required amount of calories — by maintaining a healthy weight and avoiding overeating is a suitable alternative to a calorie restrictive diet as not everyone may find the latter feasible.

Without drastically cutting calories, incorporating fasting intervals into diet regimens can improve metabolic health and lower inflammation. Certain anti-inflammatory foods including leafy greens, almonds, and fatty fish can help fight chronic inflammation linked to aging. Reducing protein consumption, especially from animal sources, can also promote healthy aging.

It can be beneficial to customise nutrition intake through creating a nutrition plan with medical experts that takes into consideration age, sex, genetics, and metabolic risk factors.

Holistic health behaviours like consistent exercise, stress reduction and enough sleep are necessary to support dietary efforts. A balanced diet and long-term adherence to dietary therapies are essential for longlasting results. It is also important to be consistent.

Although reducing calories and implementing new dietary techniques can have a big impact on aging and lifespan, these actions need to be a part of a more comprehensive, customised strategy. Lethal smog: How pollution surge fuels stroke cases

ir pollution has long been recognized as A a significant controller to the particular diseases. However, a significant contributor to respiratory growing evidence now highlights its alarming connection to stroke, one of the leading causes of death and disability worldwide. The recent surge in pollution levels across North India has underscored this link, with deteriorating air quality posing severe risks to public health, including an increased incidence of strokes.

How Pollution Contributes to Stroke

Stroke occurs when blood flow to the brain is interrupted due to a clot or bleeding, leading to brain cell damage. While lifestyle factors like poor diet and sedentary habits are well-established stroke risk factors, air pollution has emerged as a silent yet potent contributor.

Fine particulate matter, nitrogen dioxide, and other pollutants can infiltrate the bloodstream, causing inflammation and oxidative stress. These processes damage blood vessels, accelerate atherosclerosis (narrowing of arteries), and raise blood pressure, all of which heighten the risk of ischemic and haemorrhagic strokes. Studies suggest that even short-term exposure to high pollution levels can trigger strokes in vulnerable individuals, while prolonged exposure significantly increases the lifetime risk.

The Situation in North India

North India, particularly during the winter



months, experiences hazardous pollution levels due to a combination of factors such as stubble burning, vehicular emissions, and industrial discharge. Cities like New Delhi and its surrounding regions frequently record air quality indices (AQIs) in the "severe" category.

This toxic air is not only affecting the lungs but is also contributing to a marked rise in stroke cases. Neurology departments across hospitals in North India report a surge in strokerelated admissions during high pollution periods. Patients with pre-existing conditions, such as hypertension or diabetes, are particularly susceptible to pollution-induced strokes

Vulnerable Groups and Immediate Impact

also face increased risks of complications that could affect both maternal and foetal health, including the likelihood of strokes. In urban areas with poor air quality, people are often unknowingly inhaling pollutants that compromise their cardiovascular systems over time. Short-term spikes in pollution levels, such as during festive seasons or crop residue burning, can act as immediate triggers for strokes,

Children, the elderly, and individuals with

pre-existing cardiovascular conditions are most

vulnerable to the effects of pollution. Pregnant

women exposed to high pollution levels may

leading to emergency situations in hospitals. Mitigating the Risks

Tackling the pollution-stroke connection requires both individual and collective action. At a policy level, stricter regulations on emissions, better public transport systems, and promoting cleaner energy sources are critical. On an individual level, people can minimize exposure by wearing masks, using air purifiers, and avoiding outdoor activities during high-pollution days.

Healthcare professionals emphasize the importance of regular health check-ups, especially for those in high-risk groups, to monitor blood pressure, cholesterol, and other stroke risk factors. Raising public awareness about the link between air pollution and strokes is equally vital to encourage proactive measures. South Korean protesters brave cold to demand Yoon's ouster as detention deadline looms

SEOUL, Jan 5: Hundreds of South Koreans, bundled up against freezing temperatures and snow, rallied overnight into Sunday near the residence of impeached President Yoon Suk Yeol, calling for his ouster and arrest, as authorities prepared to renew their efforts to detain him over his short-lived martial law decree.

Dozens of anti-corruption agency investigators and police attempted to execute a detainment warrant against Yoon on Friday but retreated from his residence in Seoul after a tense standoff with the presidential security service that lasted more than five hours.

The one-week warrant for his detention is valid through Monday. There were no immediate indications that anti-corruption authorities were ready to send investigators back to the residence as of Sunday afternoon. Staff from the presidential security service were seen installing barbed wire near the gate and along the hills leading up to Yoon's residence over the weekend, possibly in preparation for another detention attempt.

A Seoul court last Tuesday issued a warrant to detain Yoon and a separate warrant to search his residence after the embattled president repeatedly defied authorities by refusing to appear for questioning and obstructing searches of his office. But enforcing them is complicated as long as Yoon remains in his official residence.

Investigators from the country's anti-corruption agency are weighing charges of rebellion after the conservative president, apparently frustrated that his policies were blocked by a legislature dominated by the liberal opposition, declared martial law on Dec. 3 and dispatched troops to surround the National Assembly.

The Assembly overturned the decla-



ration within hours in a unanimous vote and impeached Yoon on Dec. 14, accusing him of rebellion, while South Korean anti-corruption authorities and public prosecutors opened separate investigations into the events.

If the anti-corruption agency manages to detain Yoon, it will likely ask a court for permission to make a formal arrest. Otherwise, Yoon will be released after 48 hours.

The Corruption Investigation Office for High-Ranking Officials, which is leading a joint investigation with police and military investigators, says detaining Yoon would be "virtually impossible" as long as he is protected by the presidential security service. The agency has urged the country's acting leader, Deputy Prime Minister Choi Sang-mok, to instruct the service to comply with their execution of the detainment warrant, but Choi has yet to publicly comment on the issue.

The chiefs and deputy chiefs of the presidential security service defied summonses on Saturday from police,

who planned to question them over the suspected obstruction of official duty following Friday's events.

Yoon's legal team said it will file complaints against the anti-corruption agency's chief prosecutor, Oh Dongwoon, and approximately 150 investigators and police officers involved in Friday's detention attempt, which they claim was unlawful. The team said it will also file complaints with public prosecutors against the country's acting defense minister and police chief for ignoring the presidential security service's request to provide additional forces to block the detention attempt.

Yoon's lawyers had submitted an objection to the warrants against the president on Thursday, but the Seoul Western District Court dismissed the challenge on Sunday.

Park Chan-dae, floor leader of the main opposition Democratic Party, called for the anti-corruption agency to move quickly to detain Yoon, saying it was deeply disappointing to see the agency "hesitating and letting time slip

Hundreds of anti-Yoon protesters rallied for hours near the gates of the presidential residence from Saturday evening to Sunday, voicing frustration over the failed detention attempt and demanding stronger efforts to bring Yoon into custody. Separated by police barricades and buses, pro-Yoon protesters were gathering in nearby streets, denouncing his impeachment and vow-

ing to block any efforts to detain him. "With barely a day left before the execution deadline for Yoon Seok Yeol's detainment warrant, the presidential security service continues to hide a criminal and the Corruption Investigation Office for High-Ranking Officials cannot be more relaxed," Kim Eun-jeong, an activist, said on a stage during the anti-Yoon rally.

"Angry citizens have already spent two freezing nights demanding his immediate detainment. Are their voices not being heard?"

Yoon's lawyers have challenged the detention and search warrants against the president, saying they cannot be enforced at his residence due to a law that protects locations potentially linked to military secrets from search without the consent of the person in charge which would be Yoon. They also argue the anti-corruption office lacks the legal authority to investigate rebellion charges and that police officers don't have the legal authority to assist in detaining Yoon.

While the presidential security act mandates protection for Yoon, it does not authorize the presidential security service to block court-ordered detainments. The service's attempts to block the execution of the warrant may amount to an obstruction of official duty, according to Park Sung-bae, an attorney specializing in criminal law.

While the president mostly has immunity from prosecution while in office, the protection does not extend to allegations of rebellion or treason.

The agency said its outnumbered investigators had several scuffles with presidential security forces that threatened their safety and expressed "serious regret" that Yoon was not complying with the legal process.

After getting around a military unit guarding the residence's grounds, the agency's investigators and police were able to approach within 200 meters (yards) of Yoon's residential building but were stopped by a barricade comprising around 10 vehicles and approximately 200 members of the presidential security forces and troops. The agency said it wasn't able to visually confirm whether Yoon was inside the residence.

The Defense Ministry says the troops at Yoon's official residence are under the control of the presidential security service. Kim Seon-ho, the acting defense minister, conveyed his concern to the presidential security service, saying that deploying military personnel to block the execution of the detention warrant would be "inappropriate" and requesting that the troops aren't placed in a position where they might confront police, according to the ministry.

Yoon's defense minister, police chief and several top military commanders have already been arrested over their roles in the period of martial law.

Yoon's presidential powers have been suspended since the National Assembly voted to impeach him on Dec 14. Yoon's fate now lies with the Constitutional Court, which has begun deliberations on whether to uphold the impeachment and formally remove Yoon from office or reinstate him. (AP)

180 million people have been denied their voting rights, says B'desh CEC

DHAKA, Jan 5: Bangladesh's Chief Election Commissioner (CEC) AMM Nasir Uddin on Sunday said that almost 180 million people have been denied their voting rights and the Election Commission wants to end their deprivation, The Dhaka Tribune newspaper reported.

The CEC, while addressing the inaugural ceremony of a training programme for election officers ahead of a voter list updating exercise, said the Election Commission (EC) wants to remove the fact that the people have been deprived of the voting right for so long.

"We want to remove the pain of their deprivation. We are steadfast in our commitment," he said.

The countrywide door-to-door data collection for updating the list of possible voters will start on January 20

The CEC said they are here to hear the 180 million people who have been suffering from the deprivation of voting rights.

"We've taken the responsibility so that we can remove their deprivation," he said.

He said the commission's main goal is to arrange a fair and credible election.

"It's a marathon race beginning from today up to the delivery of the result," he said.

"Our goal, commitment and promises to the nation is to present a free, fair and credible election as the nation has been deprived of it for so long," the CEC said.

Meanwhile, the EC has decided to investigate irregularities and shortcomings in all previous elections, including the three preceding elections that have been controversial during the Awami League-rule in 2014, 2018 and 2024. The 2014, 2018 and 2024 national elections are widely regarded as some of the most controversial in the country's history.

The newly formed EC, which assumed office on November 21, has already initiated several reform measures while preparing for the 13th National Election. A few days ago, CEC Nasir Uddin said that ousted prime minister Sheikh Hasina's Awami League may participate in elections unless the government or the judiciary issues a ban against the party.

Chief Adviser Muhammad Yunus, 84, who was sworn-in to lead the interim government after the ouster of Hasina in August, during his Victory Day speech on December 16 indicated that elections might be held by early 2026.

"Broadly speaking, the election can be scheduled between the end of 2025 and the first half of 2026,' he said. Yunus said that the elections would be held after updating the voters' list. (PTI)

WASHINGTON, Jan 5: The outgoing Biden administration was one of the most pro-India administrations in decades and will be a tough act to follow, an eminent expert has said, observing that Trump 2.0 administration will be one that believes in great power politics, not strategic altruism.

'The outgoing Biden administration was one of the most pro-India administrations in decades and will be a tough act to follow for any presidential administration. Ties with India were cemented because of the belief that India's rise is in and of itself important to American national security interests," Aparna Pande, director, Initiative on the Future of India and South Asia at the prestigious Hudson Institute think-tank told PTI in an interview.

There was a deepening of relations on the security and defense realm, including ology, something India has high techno sought for decades, said Pande, author of several books, including From 'Chanakya to Modi: Evolution of India's Foreign Policy' "Irritants – like democratic backsliding and the issue tied to the 'murder for hire' incident – were not allowed to derail the partnership. The programme, titled "Pakistan Country Partnership Framework 2025-35", aims to improve social indicators in the most neglected but important areas, The Express Tribune newspaper reported, citing official documents.

It will focus on reducing child stunting, combating learning poverty, enhancing climate resilience, decarbonising the environment, expanding fiscal space, and boosting private investment to improve productivity.

These areas have broad support across the political spectrum and are expected to remain unaffected by government changes during the 2025-2035 period, which is anticipated to include at least three general elections.

This 'Country Partnership Framework' is scheduled to be approved by the World Bank board on January 14, following which the global lender's Vice President for South Asia Martin Raiser is also expected to visit Islamabad.

LONDON, Jan 5: Britain's Opposition Conservative Party is leading calls for Prime Minister Keir Starmer to scrap government plans for an official definition of Islamophobia over fears it would restrict free speech and action against wrongdoing.

WASHINGTON, Jan 5: Outgoing President Joe Biden has presented the US' highest civilian award to 19 people, including former secretary of state Hillary Clinton, football superstar Lionel Messi, controversial philanthropist George Soros and actor Denzel Washington, for their contributions to America and the world.

The Presidential Medal of Freedom is presented to individuals who have made exemplarv contributions to the prosperity, values, or security of the United States, world peace, or other significant societal, public or private endeavours.

Due to a scheduling conflict, Argentinian football star Messi could not be present in person at the White House to receive the award from the US president.

"For the final time as President, I have the honour of bestowing the Medal of Freedom on our nation's highest civilian honour on a group of extraordinary, truly extraordinary people who gave their sacred effort, their sacred effort, to shape the culture and the cause of America," Biden said at a glittering function in the East Room of the White House. Former president Bill Clinton, several of his Cabinet members including Defence Sec-

retary Loyd Austin along with several celebrities were present in the East Room of the White House during the awards ceremony Saturday afternoon.

"This group of people leave an incredible

mark on our country with insight and influence that can be felt around the globe in major cities and remote areas of life, finding us closer as people and showing us that what's possible as a nation, nothing beyond our capacity," Biden said.

"As cultural icons, ... humanitarians, rock stars, sports stars, you feed the hungry, you give hope to those who are hurting, and you craft the signs and sounds of our movements and our memories. It's amazing ... you inspire, and you bring healing and joy to so many lives that otherwise wouldn't be touched," the President said.

"You answer the call to serve and lead others to do the same thing. You defend the values of America even when they're under attack, which they have been," Biden said after which he presented the Presidential Medal of Freedom.

Fannie Lou Hamer, who transformed the struggle for racial justice in America, Ashton Carter, who served as the 25th Secretary of Defence, Robert Francis Kennedy remembered as an Attorney General who fiercely combatted racial segregation, and George W Romney, a businessman who served as the chairman and president of American Motors Corporation, were awarded posthumously. The medals were received by their family members.

Hillary Clinton was the only recipient to get a standing ovation.



"As a lawyer, she defended the rights of children. As First Lady, she fought for universal health care and declared women's rights are human rights," a military aide read the citation as she was presented the medal by the president.

"As Senator, she helped New York rebuild after September 11, 2001. As Secretary of State, she championed democracy worldwide. Her nomination for president broke barriers and inspired generations. Through it

all, her career has been dedicated to an eternal truth. America's ideals are sacred, and we must always defend and live by them," according to the citation.

Alex Soros accepted the award on behalf of his father George Soros, an investor, philanthropist, and founder of the Open Society Foundations.

"Born into a Jewish family in Hungary, George Soros escaped Nazi occupation to build a life of freedom for himself and countless others around the world," said the citation as read by the military aide. a "travesty,"

"Educated in England, he settled in America as he became an investor and philanthropist supporting key pillars of open societies, rights and justice, equity and equality, freedom now and in the future," it said.

"As an immigrant who found freedom and prosperity in America, I am deeply moved by this honour," George Soros said in a statement.

"I accept it on behalf of the many people around the world with whom the Open Society Foundations have made common cause over the past 40 years," he said.

The official said that residents of both countries living within 10 km on either side of the border now require a border pass to visit each other.



On December 24, the MHA issued a new protocol restricting and reducing the range of movement of people under the free movement regime (FMR) from the earlier 16 km to the present 10 km.

Although Union home minister Amit Shah had announced in February last year that the FMR would be scrapped, an official notification in this regard is yet to be issued, sources said.

According to the new guidelines, an individual crossing the border from India to Myanmar and from Myanmar to India will be given a "border pass" by the Assam Rifles, which guards the Indo-Myanmar border, for a stay of up to seven days.

Individuals will have to report at the designated border crossing points and fill out a form.

The Assam Rifles will conduct the document inspection followed by a security and health check by the state police and health department officials, respectively.

The Assam Rifles will upload all the forms on the Indo-Myanmar Border portal, record biometrics, and issue a border pass with a photograph of the applicant and a QR code.

The pass will have to be deposited on return at the same crossing point before completion of seven days.

The guideline stated that police will do physical checks to verify the visit of Myanmar nationals as per the details provided in the border pass and anyone violating the conditions will face legal action. (PTI)

KHNAM not ready to work with other political parties: Passah



SHILLONG, Jan 5: The Khun Hynniewtrep National Awakening Movement (KHNAM) has informed that it is not ready to work with other political parties because of its 'pro-Hynniewtrep agendas'.

After the party's central executive committee (CEC) meeting on Saturday, working president Thomas Passah said that the reason for the party's decision not to consider going for a pre-poll alliance ahead of the autonomous district council (ADC) elections is because its ideology and manifesto are very different.

'We have pro-Hynniewtrep agendas. I think it will differ a lot from the mission and agenda of the other political parties. Therefore, for sure, we will not be working with the NPP, BJP, UDP. Kohima bans 'shoot-at-sight' orders for stray dogs

<u>HT Correspondent</u> DIMAPUR, Jan 5: The Kohima district administration has banned "shoot-at-sight" orders for stray dogs. Kohima's additional deputy commissioner Rhosietho Nguori issued an order in this regard on Saturday stating that it has come to notice that certain organisations and associations within Kohima municipal wards and villages under Kohima district issued "shoot-at-sight" orders for stray dogs.

Nguori informed all concerned that such actions are in violation of provisions of the Prevention of Cruelty to Animals Act. 1960 (PCA Act), and the Bharatiya Nava Sanhita (BNS), which prohibits the killing of animals, including stray dogs.

Acts of this nature are deemed illegal under the law, the order said, strictly prohibiting any individual, organisation, or association from engaging in such activities.

The order said the presence of any stray dogs should be reported to the office of the municipal/town council authorities in the urban areas, or to the respective village authorities/area administrative officers concerned in rural areas. The authorities concerned, with the help of the chief veterinary office, will take care of such stray dogs as per laid down procedures of relevant laws.

The order further said strict action would be taken against those found violating this directive, under relevant provisions of the Act/law.

AGARTALA, Jan 5: Tripura Ganamukti Parisad (GMP), the tribal wing of the CPI(M), will submit a deputation to Governor Indrasena Reddy Nallu on various issues, such as low man-days in rural job scheme and alleged corruption in an autonomous council, on January 11, a senior leader said on Sunday

Addressing a press conference, GMP general secretary Radhacharan Debbarma said a programme has been chalked out in accordance with the decision taken in the conference of Adivasi Adhikari Rastriya Manch in Delhi on December 1.

"We want the BJP-led NDA government in Delhi to pass the Constitution (125th Amendment) Bill, 2019 at the earliest as it is pending for several years," he said. The Bill is intended to grant more financial and executive powers to the autonomous councils in the Sixth Schedule areas of the northeastern region. The amendment will impact one crore tribal people in Assam, Meghalaya, Tripura, and Mizoram, according to a tribal leader. Debbarma also accused Tipra Motha of turning the Tribal

Autonomous Areas Autonomous District Council (TTAADC) into a den of corruption.

"There have been no elected bodies of the village committees, like gram panchayats, since 2021. In the absence of elected bodies, leaders of Tipra Motha are siphoning off funds that are meant for development work. We want the BJP-led state

government to hold elections to the village committees as early as possible", he said. The TTAADC, constituted under the Sixth Schedule, has 587 village committees.

The former tribal council chief also lashed out at the BJP government over "shrinking man-days" under the MGNREGA, a guaranteed rural job scheme.

"The MGNREGA has generated an average of 42 man-days in the state with three months left to end the current financial year. Low man-days generation has reduced job opportunities for the rural poor," he said.

"We will organise an agitational programme on these issues on January 11 and submit a memorandum to the governor seeking his intervention", he said. (PTI)

ITANAGAR, Jan 5: More than 500 gm of heroin, 7 kg of cannabis and other narcotic substances have been seized alongside the arrest of 91 people by Naharlagun Police in Arunachal Pradesh in 2024, a police statement said.

The success was achieved under 'Operation Dawn' launched by Naharlagun Police, Naharlagun Superintendent of Police Mihin Gambo said in a statement on Saturday.

"Police seized 588.42 gm of heroin, 7,042.5 gm of cannabis, 48 gm of Lorazepam, and 233.81 gm of Morphine from various peddlers. A total of 41 NDPS cases were registered during the year and 91 peddlers arrested," the SP said.

"The efforts led to a noticeable improvement compared to the previous year, as more cases were detected, and stricter action was taken against drug peddlers. These actions also resulted in the confiscation of a significantly larger quantity of contraband substances, demonstrating the effective-



Singh -- the architect of India's economic reforms -- died on December 26 at the age of 92 following age-related complications.

In his letter, Bajwa said, "I am writing to propose a collective initiative of profound national significance -- one that transcends political boundaries to honour one of India's most distinguished states-

men, Dr Manmohan Singh.'

"Singh's contributions to our nation have been unparalleled. As the principal architect of India's economic liberalisation in 1991, he set the foundation for the country's transformative growth, resilience and global standing. His tenure as prime minister was marked by a steadfast focus on inclusive development, social justice and economic stability, directly impacting millions of lives across the nation," he added. Bajwa said he proposed the joint resolution due to Singh's contributions pro-

foundly shaping India's destiny. "As a proud son of Punjab, Dr Singh's dedication to public service and nationbuilding continues to inspire us all," he said in a post on X.

"I have also proposed forming an allparty delegation to meet Prime Minister Narendra Modi to advocate for this recognition. Honouring Dr Singh with the Bharat Ratna will not only celebrate his extraordinary contributions but also reaffirm our shared commitment to democracy, integrity, and excellence in public service," the Qadian MLA added in the post.

In his letter to the chief minister and the speaker, Bajwa said Singh's journey was a



testament to resilience, dedication and humility.

"As a proud son of Punjab, he upheld tributions to the state are equally commendable, addressing critical challenges in agriculture, rural development, and education, and catalysing growth in Punjab as

Govt launches 2 special categories visas for international students

NEW DELHI, Jan 5: India has launched two special category visa for international students intending to pursue higher education in academic institutions in the country.

MONDAY, JANUARY 6, 2025

The 'e-student visa' and 'e-studentx' visa have been introduced by the Ministry of Home Affairs and all applicants will have to use the 'Study in India' (SII) portal launched by the government, officials said.

The e-student visa facility can be availed by eligible foreign students registered on the SII portal while estudent-x visa is offered to the dependents of those holding e-student visas, they said.

The SII portal facilitates the admission process of international students who wish to pursue either long-term or short-term courses in India.

Students will need to apply for a visa separately on the portal https://indianvisaonline.gov.in/ but the authenticity of their application will be checked by SII ID.

Hence it is mandatory for students to apply to Indian higher educational institutions through SII website, the officials said.

Students may apply for the visa after receiving an admission offer letter from any of the SII partner institutes.

The e-student visa will be granted to such foreign nationals who obtain

JAMMU, Jan 5: Prime Minister Narendra Modi will inaugurate the newly created Jammu railway division through virtual mode on Monday, paving the way for efficient management of train services in the northernmost region of India. With the establishment of the new railway division in Jammu, a long-standing demand of people of the region has been fulfilled. This milestone event comes ahead of the muchawaited inauguration of train services to Kashmir from Katra, with the final trial run scheduled for Tuesday.

PM Modi to virtually

inaugurate Jammu railway division

"The prime minister will inaugurate the Jammu railway division through virtual mode from New Delhi tomorrow," an official said. In Jammu, the event will be attended and addressed by Lieutenant Governor Manoj Sinha, Chief Minister Omar Abdullah and Member of Parliament Jugal Kishore Sharma. Union Minister Dr Jitendra Singh is also expected to participate.

Headquartered in Jammu, the newly created division will involve the reorganization of the Firozpur Division. It will include the following sections under its jurisdiction, including Pathankot-Jammu-Udhampur-Srinagar-Baramulla (423 route km), Bhogpur-Sirwal-Pathankot (87.21 route km), Batala (excluding)-Pathankot (68.17 route km) and Pathankot-Joginder Nagar (narrow gauge section, 163.72 route km).

The total length of these sections will be 742.1 kilometres. Presently, the Indian Railways operates 17 zones with 68 divisions across the country. The Railway officials said the final jurisdiction will be determined based on the Detailed Project Report. The division will feature modern, hi-tech facilities, leveraging the full potential of Information Technology (IT), they said. With the creation of this division, the Indian Railways will now have 70 divisions under its 17 zones.

The newly established division will oversee operations on India's iconic rail projects, including the country's first cable-stayed rail bridge, the Anji Khad Bridge and the world's highest railway arch bridge over the Chenab River at Kauri. The Chenab Rail Bridge, located in Reasi district, stands 359 metres (1,178 feet) above the riverbed, making it 35 metres taller than the Eiffel Tower in Paris.

The Jammu division will also manage the Udhampur-Srinagar-Baramulla Railway Link (USBRL) project, which is now nearing completion.

The Anji Khad Bridge has a total length of 473.25 metres, including a 120-metre viaduct and a 94.25-metre central embankment.

Currently, the railway services in Jammu and Kashmir are managed by the Firozpur Division of Northern Railways.

Regarding the inauguration of train services to Kashmir from Delhi, the Commissioner of Railway Safety will conduct statutory inspections and final trials on January 7 and 8.

With the phased commissioning of train services, the Railways is expected to complete 255 km of the 272-kilometre USBRL project, leaving only a small stretch between Katra and Reasi to be finished by December. (PTI)

On the intervening night of December 2-3, 1984, methyl isocyanate (MIC) gas leaked from the Union Carbide pesticide factory in Madhya Pradesh capital Bhopal, killing at least 5,479 persons and leaving thousands with serious injuries and long-lasting health issues. Nearly 337 tons of Union

Carbide waste reached Pithampur from Bhopal on Thursday for disposal following an order of the Madhya Pradesh High Court.

The petition before the NGT seeks direction to the authorities in Dhar to submit on oath that residents in the area would not be harmed due to the disposal of the waste.

Furthermore, the petition seeks direction to the MP government to publish in Hindi and

report regarding the disposal of this waste to allay public concerns, PG Najpandey of the Nagrik Upbhokta Margdarshak Manch and activist Sunil Bhargav said. The social organisation filed the petition in the NGT on Friday, Najpandey told PTI.

There is apprehension among residents because thousands of people died due to the leak of toxic methyl isocyanate gas from Union Carbide factory in December 1984, he said. Therefore, we have moved the NGT to take cognisance of

their concerns," Najpandey said. "We don't want this toxic

waste in our area," is the refrain of locals at Tarpura, a village adjacent to Pithampur's waste incineration unit where the huge quantity of waste has been brought for disposal.

The plan to dispose of the waste linked to the 1984 Bhopal gas tragedy, among the worst industrial disasters in the world, has sparked off protests in the area.

The incineration of a huge quantity of toxic waste will be hazardous for humans as well as the environment, the villagers fear, even though the Madhya Pradesh government has sought to assure them that

there would be no harmful consequences. (PTI)

Cleric fears mass conversions; others flag seers' 'demand' to bar Muslims

Such people are found everywhere. If there are four brothers, their temperament will differ."

"I have been to Kumbh many times, as have many Muslims. Also, many community members are involved in the arrangements for the Maha Kumbh. So, demanding to keep them away cannot be a Sanatani 'sanskar'. Our culture is known for harmony and brotherhood, so the statement to ban Muslims from Maha Kumbh can at best be someone's personal view," the former Uttar Pradesh minister said. 


"It Ends With Us" co-stars Lively and Baldoni are entangled in a legal battle after she accused him of sexual harassment and running a smear campaign against her.

This year will be fantastic for Hindi cinema, says producer Dinesh Vijan

MUMBAI, Jan 5: Filmmaker Dinesh Vijan, whose production banner Maddock Films had a successful run at the box office in 2024 with "Stree 2", "Munjya" and "Teri Baaton Mein Aisa Uljha Jiya", on Sunday said Hindi cinema is a "quick learning industry" and the new year will be a fantastic one for the filmmakers up north. "Everything that's happening in society happens in films and vice versa. We are a very quick learning industry. Just Maddock Films doing well is not enough...

"This year, I'm excited with our line-up, with Yash Raj's line-up, with Dharma's line-up. I think there'll be some fantastic films coming," he added.

Recently, Telugu film producer Naga Vamsi in a roundtable conversation said that the Hindi film industry focuses on making films for Mumbai's posh areas like Bandra and Juhu, directing his comments at veteran producer Boney Kapoor who was also part of the interview.

During the roundtable, Vamsi also said that "Mumbai didn't sleep" after "Pushpa 2" earned over ₹ 80 crore at the box office in a single day.

SYDNEY, Jan 5: India head coach Gautam Gambhir said on Sunday that struggling stars Rohit Sharma and Virat Kohli "still have the hunger to excel" but urged all senior players, including the duo, to play domestic games and show their "commitment" towards redball cricket.

Known for his plain speak, the two-time World Cup hero also didn't give any assurances on whether Rohit or Kohli will be a part of the Test set-up moving forward.

Both the stars were woefully out of form during the just-concluded Test series against Australia that the visitors lost 1-3 to surrender the Border-Gavaskar Trophy as well as a spot in the World Test Championship final.

"It's not the right moment right now for me to talk about where we are going to be after five months. A lot of things change in sport. Forms change, people change, atchanges, everything titude changes in sport. And we all know that five months is a long time," Gambhir said at the post-series press conference.

"So let's see before the England series (in July) what's going to happen. But whatever will happen, will happen for the best interest of Indian cricket," asserted the former opener.

Rohit scored 31 runs in five innings before dropping himself from the playing eleven and Kohli managed 190 in nine knocks, including a second innings century after India had taken a lead of more than 300. A glaring failure for Kohli was his inability to avoid being dismissed on deliveries that were bowled outside the off stump. Asked if he would like the seniors to play at least one round, you don't give importance to do-



if not two, of Ranji Trophy starting January 23, Gambhir sent across a clear message.

"I would always like everyone to play domestic cricket. That is how much importance domestic cricket needs to be given. Not only one game, if they are available and they have the commitment to play red-ball cricket, everyone should play domestic cricket," Gambhir said. "As simple as it can get. If

mestic cricket, you will never get the desired players that you want

Man City turn corner with successive wins in Premier League as Arsenal and Chelsea drop points

LONDON, Jan 5: Erling Haaland and Manchester City might just be turning the corner after the team's worst run of results under Pep Guardiola Haaland scored twice in a 4-1

win over West Ham on Saturday as City secured back-to-back victories in the Premier League for the first time since late October, when a shocking and unthinkable six-week meltdown began. In that time, the defending

champions played nine league games and won just once, drop-ping them out of the Champions League qualification spots and raising questions about Guardiola's stomach for a rebuild.

Now, City can hope for better times ahead — especially after making up ground on secondplaced Arsenal and fourth-placed Chelsea after they both dropped points in draws at Brighton and Crystal Palace, respectively, on Saturday. Still, Guardiola wasn't getting

carried away.

"I'm very pleased for the re-sult," he said, "but you cannot ask me if the old City is back. If you saw the game, we are not." However, while the 2-0 win at

Leicester last weekend was unconvincing, there were better signs against West Ham - at

The energy here at the ground is spectacular and when cricket nations play such a match, you feel the energy. It's an awesome spectacle," Courier told PTI in an exclusive interaction.

Gavaskar upset after not being invited to present BGT with Border

SYDNEY, Jan 5: The legendary Sunil Gavaskar on Sunday expressed his displeasure after not being invited to present the trophy, named after him and Allan Border, to Australia following their win over India in the high-voltage fivematch rubber.

Australia reclaimed the Border-Gavaskar trophy after 10 years with a six-wicket win over India in the fifth and final Test.

Border presented the trophy to the home team but Gavaskar, despite being at the venue at the same time, was inexplicably ignored.

"I certainly would have loved to have been there for the presentation. After all it is the Border-Gavaskar Trophy and it is about Australia and India," Gavaskar was quoted as saying by Code Sports.

"I mean, I am here on the ground. To me it should not matter that Australia won when it comes to the presentation. They played better cricket so they won. That's fine.

"Just because I am an Indian. I would have been happy to present the trophy with my good friend Allan Border," he added.

Had the Indian team won the trophy, Gavaskar would have been invited to present it to the victorious side.

Cricket Australia (CA) later confirmed that Gavaskar was aware he would have presented the award to Indian captain Jasprit Bumrah if the tourists had won the Sydney Test and retained the trophy.

"We acknowledge it would have been preferable if both Allan Border and Sunil Gavaskar had been asked to go on stage," a CA spokesperson said in a statement.

Both India and Australia have been competing for the Border-Gavaskar Trophy since 1996-1997 and the rivalry has grown to become one of the biggest in Test cricket.

The five-match series that Australia won drew record crowds at multiple venues and broke an 87year-old attendance record at the Melbourne Cricket Ground last week. (PTI)

SYDNEY, Jan 5: A listless India was knocked out of the World Test Championship (WTC) final as Australia cruised to a six-wicket victory in the fifth Test here on Sunday to reclaim the Border-Gavaskar Trophy after 10 years, leaving the visitors with much to deliberate in a difficult transition phase made worse by over-the-hill batting stars.

Australia won the five-match series 3-1 and qualified for the WTC final against South Africa slated at the Lord's from June 11 to 15.

While Australia would be eyeing a second successive WTC mace, it would be the first time since the event's inception that India won't be in the finals. The team had finished runner-up in the previous two summit clashes.

On Sunday, the target of 162 could have been trickier for Australia had India's new Test captain Jasprit Bumrah been in a position to bowl despite painful back spasms. But once Virat Kohli led the team out, it was as clear as the Sydney skyline that defending the total would be next to impossible.

Bumrah deservedly walked away with the player of the series honour for his astonishing haul of 32 wickets in five matches. But it was hardly a consolation for the shambolic team performance that India managed, showing resilience only in brief phases.

"Little frustrating but sometimes you have to respect your body, you can't fight your body. Disappointing, probably missed out on the spiciest wicket of the series," Bumrah said of his inability to bowl in the second innings during the presentation ceremony.

All the right moves must be made to keep boxing in LA 2028 programme: Lovlina

GUWAHATI, Jan 5: With boxing's future as an Olympic sport hanging in the balance, India's star pugilist Lovlina Borgohain on Sunday asserted that "all the right moves must be made" to ensure its presence at the 2028 Los Angeles Games

Boxing was not on the initial programme for the Los Angeles Olympics and a decision on its inclusion is awaited.

Lovlina is now part of the Athletes Commission of the newly formed Asian unit of World Boxing.

"It's a huge privilege to be on this committee as India will now have a voice in decision making," said Lovlina, pointing out that boxing's technicalities, "especially scoring and judging" needed closer and impartial introspection.

"Till now, India was just an ordinary member with very little chance to raise a protest or point out a flaw in the system. That is going to change now since we will have seven positions in the Asian body.

"That's a big plus for athletes who want to perform their best and win an Olympic medal," said Lovlina, adding that "all the right moves must be made to keep boxing in the LA 2028 programme

Eyeing a third straight Olympic appearance in 2028 (if the sport is included in the roster) Tokyo Games bronze medallist Lovlina said she will take it one step at a time from here on.

Lovlina, who won a bronze at Tokyo Olympics in 2021 but returned emptyhanded from Paris 2024, said Los Angeles was very much in her plans.

"Tokyo was during COVID times.



Paris was a real learning curve. I did my best and have no regrets that I could not win a medal. For every athlete, there are lessons to be learnt and I want to be wiser leading into LA," Lovlina told SAI Media in an interaction on the sidelines of the ASMITA Women's Under-17 football final at the SAI campus here.

India's versatile lawn bowler, Nayanmoni Saikia on Sunday, accompanied Lovlina. Nayanmoni is a multiple gold medallist at the Commonwealth Games and the Arjuna Awardee is a popular face in Assam.

Both Lovlina and Nayanmoni took part in the Fit India Sundays on Cycle mission and stressed on the "no drugs" campaign undertaken by the Union Sports Ministry.

Lovlina was the darling of the media on Sunday. Assam's 'own daughter' will

be touching 31 when Los Angeles arrives but the middleweight (75 kg) boxer is confident that she will be "stronger and more experienced" if she can convert her Paris learnings into action.

"But I am not going to rush my preparations. LA is a long way off and proper weight and injury management will be part of my core plans. Right now, I am not looking beyond the upcoming National Games in Uttarakhand and to do well for Assam is uppermost in my mind," said Lovlina.

With at least three medals, including a gold in the 2023 world championship, Lovlina said 2025 would be a challenging year with the world championships on the cards.

"It will be a target to play the World Boxing Cup Final in India later in 2025," she added. (PTI)

There should be no excuse for not being able to play Ranji Trophy: Gavasakar tells senior players

SYDNEY, Jan 5: Legendary Sunil Gavaskar on Sunday urged Indian batters to play in the Ranji Trophy without offering any excuses to iron out technical deficiencies that led to their peril in two successive series against New Zealand and Australia.

Gavaskar said it was worrying to see the Indian batters churning out underwhelming efforts against New Zealand at home and in the just-concluded series against Australia Down Under.

India succumbed to the Kiwis 0-3 before surrendering to the Aussies 1-3.

"On January 23, there is the next round of the Ranji Trophy. Let's see how many players from this squad play. There should be no excuse for not being able to play," Gavaskar told Star Sports.

"If you do not play those matches, Gautam Gambhir will have to take a few tough decisions against those who are not available for the Ranji Trophy," he added.

"Gambhir should be saying: You do not have that commitment. We need commitment. You are not playing. Whatever you want to do, do it. But for Indian cricket, you cannot return to the Test squad."

Gavaskar said flaws have crept into Indian batsmen's approach because of not playing domestic cricket on available opportunities.

"What I saw were technical deficiencies. If you have been making the same mistakes, and I am not just talking about this series悠 am talking about the New Zealand series as well that did you do against New Zealand in India?"


Gavaskar said domestic cricket assumes importance in view of the upcoming 2025-2027 WTC cycle.

"And that's why, now, because the next cycle will start in June, we have not qualified for the World Test Championship. From now on, we should be ready for it. If we have to take tough decisions, then we will have to take them," he said.

With the next WTC cycle in focus, Gavaskar said India should now focus more on young cricketers such as Yashasvi Jaiswal and Nitish Kumar Reddy.

"They are hungry to earn a name for India and themselves. Such players are needed. You need such players who will protect their wicket like their life," he noted.

"That's why I'm interested that on January 23, in the Ranji



Trophy matches, who will play? I want to see that.

"Because at that time, there will be T20 matches against England. But those who are not playing T20, will they play Ranji Trophy matches or not?" he said. (PTI)
