Eminent Muslims write to PM on USTM chief's arrest

NEW DELHI, Feb 27: A civil society group comprising eminent Muslims on Thursday wrote to Prime Minister Narendra Modi, expressing deep concern over the arrest of the chancellor of private educational institution University of Science and Technology, Meghalaya (USTM) and urged him to ensure justice in the matter.

USTM chancellor Mahbabul Hoque was arrested from his Guwahati residence in the early hours of Saturday, police said. He was allegedly involved in a network that lured students with assurance of high marks through "fraud means", Assam Chief Minister Himanta Biswa Sarma had claimed.

"This arrest of a respected, nonpolitical citizen and his prolonged incarceration have been aimed at demoralising a section of progressive members of society. It prevents efforts by enlightened citizens to strive towards establishing modern secular institutions of higher learning and medical facilities," the letter signed by former chief election commissioner S Y Quraishi, former Delhi Lt Governor Najeeb Jung, former Aligarh Muslim University vice chancellor Zameer Uddin Shah, former MP Shahid Siddiqui and industrialist Saeed Sherwani said.



"This is pure vendetta and we are confident that you will give directions for redressal," the civil society group 'Citizens For

Fraternity' said In their letter to Modi, the group said Hoque was arrested in the early hours of Saturday "without an initial charge-sheet or arrest warrant and been lodged in a jail, which is about 300 km from Guwahati"

"The charge-sheet made available a day after his arrest accuses him of encouraging mass cheating in Class 12 exam. The timing of arrest, on a Saturday morning when judicial redress is difficult, clearly smacks of vendetta by the Government of Assam against USTM and its founder," the letter said. (PTI)

Assam hit by 5 magnitude earthquake; no casualty reported

GUWAHATI, Feb 27: An earthquake of 5 magnitude jolted the central part of Assam on Thursday morning, an official bulletin said.

There is no immediate report of any injury to anyone or damage to any property, officials said. A National Center for Seismol-

ogy report said the quake was recorded at 2:25 am in Morigaon district on the southern bank of Brahmaputra, at a depth of 16 km. The exact location of the epicen-

tre of the earthquake is around 52 km east from Guwahati in central

People in the neighbouring Kamrup Metropolitan, Nagaon, East Karbi Anglong, West Karbi Anglong, Hojai, Dima Hasao, Golaghat, Jorhat, Sivasagar, Cachar, Karimganj, Hailakandi, Dhubri, South Salmara-Mankachar and Goalpara districts also felt the jolt.

CHENNAI, Feb 27: Upping the ante against alleged Hindi imposition by the Centre, Tamil Nadu Chief Minister M K Stalin on Thursday said the state will not allow the forcing of the language on it and vowed to protect Tamil and its culture.

"Will oppose Hindi imposition. Hindi is the mask, Sanskrit is the hidden face," he said in a letter to party workers. The ruling DMK has been alleg-

ing Hindi imposition by the Centre through the 3-language formula as part of the National Education Policy (NEP), a charge denied by the union government. The issue has since become a bone of contention between the two, prompting Stalin to declare the state was even ready for "another language war," like the anti-Hindi agitation the DMK spearheaded in 1965.



In the letter, Stalin claimed many north Indian languages spoken in Bihar, Uttar Pradesh and Madhva Pradesh such as Mythili. Brajbhasha, Bundelkhandi and Awadhi "have been destroyed by the hegemonic Hindi."

"More than 25 north Indian native languages have been destroyed by the invasion of hegemonic Hindi-Sanskrit languages. The century-old Dravidian movement safe-

guarded Tamil and its culture because of the awareness it created and the various agitations," the ruling DMK chief said. Tamil Nadu is opposing NEP because the Centre is trying to impose Hindi and Sanskrit through

the education policy, he added.

Countering BJP's contention that the third language according to the NEP could be even a foreign one, Stalin claimed that according to the 3-language policy schedule, "only Sanskrit is being promoted in many states

SC upholds power of arrest of customs, GST authorities

NEW DELHI, Feb 27: The rest is to be exercised." Supreme Court on Thursday upheld the constitutional validity of the power of arrest under the amended laws of customs and the central goods and services tax (GST).

A bench of Chief Justice Sanjiv Khanna and Justices M M Sundresh and Bela M Trivedi said in appropriate cases, application for pre-arrest bail could be allowed and it was not essential for such pleas to be moved only after an FIR when facts were clear and a reasonable basis present to apprehend arrest.

About 280 pleas, including one of lead petitioner Radhika Agarwal in 2018, challenged the provisions of the Customs Act and the GST Act being "non compatible" with the CrPC and the Constitution.

Writing a 63-page judgement for himself and Justice Sundresh, the CJI held, "The challenge to the constitutional validity as also the right of the authorised officers under the Customs Act and the GST Act to arrest are rejected and dismissed with elucidation and clarification on the pre-conditions

Justice Bela Trivedi concurred with the CJI and wrote a 13-page verdict.

On the issue of power to grant anticipatory bail, the CJI said it arose when there was an apprehension of arrest.

"This power, vested in the courts under the code, affirms the right to life and liberty under Article 21 of the Constitution to protect persons from being arrested. In appropriate cases, application for anticipatory bail can be allowed, which may also be conditional," the verdict

As a result, the challenge to Sections 69 and 70 of the GST Act and Section 104 of the Customs Act were rejected by the court, which ruled in favour of the legislature's competence to enact the provisions that criminalised tax violations and

make arrests. The bench referred to certain judgments and said though customs officers were not police officers, they had the statutory authority to investigate and arrest offenders under the relevant laws. The bench was dealing with the validity (CONTD. ON PAGE-2)

India needs to ramp up bilateral relations for trade, investment: Sitharaman

NEW DELHI, Feb 27: Finance Minister Nirmala Sitharaman on Thursday said India needs to ramp up its bilateral relations for trade and investment, as the world is witnessing a churn, and bilateralism seems to be the new catalyst

Speaking at BS Manthan, the Finance Minister said these are very interesting yet challenging times and the government is making all efforts to make India move up the ladder and be an engine of global growth.

"Bilateralism is now taking the top of the agenda... It is for us to ramp up our bilateral relations with many countries, not just for trade, not just for investment, but also for strategic relations. So multilateralism, sort of, out, I'm still saying with a qualifying word 'sort of out', but bilateralism is very much your only catalytic tool that you can use," she said.

Observing that multilateral institutions are increasingly fading away, she said, every attempt to revive them and energize them is not having the desired result.

"So, where you have to address issues which affect more than your



rums left which can effectively deliver... multilateral institutions and their contributions probably are fading away, at least in the near future, till an attempt is made to revive them with that kind of energy... It's not going to happen in

the next few years," she said. Asserting that global trade is undergoing a complete reset, she said, "the terms and references with which all of us played trade, with some kind of an anchor in the

There is no Most Favoured Nation (MFN) concept, she said, adding, every country wants to be treated special, and every country wants to be sure that special treatment that they get is not

India is also in discussion with the 27-nation grouping -- the European Union, for a free trade pact. In the new global order, she said, India needs to ramp up its bilateral relations for trade, investment and boosting strategic relations.

With its technology and talent pool, the country can act as the engine of global growth in a new world order, she said.

"I think these are very interesting yet challenging times... India has to make a meaningful contribution to the global reset, as much as continuously make all the efforts to make India move up the ladder, both in terms of per capita income, and also in terms of a business destination, where talent can move, investors can move for the global good... we can be the engine of the global growth," she

Talking about reforms, Sitharaman said, it is something which the government will continue to do in various areas including debt management and maintaining fiscal prudence. (PTI)

of the amended provisions of the Customs Act and the GST Act post its 2011 judgement in the case of Om

Prakash v. Union of India. The 2011 verdict held that offences under the Customs Act and the Central Excise Act, 1944 were non-cognisable and, therefore, even if the officers, who had the power to arrest, could do so only after obtaining a warrant from the magistrate under CrPC.

The amendments were later brought in Section 104 of the Customs Act which specified certain offences as cognisable offences and empowered the officers to effect arrest in certain cases.

The amendments made to the Customs Act in 2012, 2013 and 2019 are substantive and were introduced to effectively modify the application of Om Prakash, which required a customs officer to obtain prior approval from a magistrate before making an arrest," the top court said.

The CJI said the amendments designated specified offences as cognisable and non-bailable, while imposing certain preconditions and stipulations for making arrest.

The petitioners' reliance on Om Prakash was no longer valid and must be rejected, the CJI added. The verdict, however, said it was important to examine the pre-conditions and safeguards established by the

legislature to protect the life and liberty of arrestees. 'If an officer of customs empowered in this behalf by general or special order of the principal commissioner

of customs or commissioner of customs has reason to believe that any person has committed an offence punishable under Section 132 or Section 133 or Section 135 or Section 135-A or Section 136, he may arrest such person and shall, as soon as may be, inform him of the grounds for such arrest," it said. A person arrested by a customs officer, held the court, had the right to meet an advocate of their choice during

the interrogation, but not throughout.

"We reject the challenge to the amendments as well as provisions of the Customs Act. Reliance placed by the petitioners on the decision of this court in Om Prakash is misconceived as the statutory provisions have undergone amendments to bring them in consonance with the law of the land. Moreover, the provisions themselves

provide enough safeguards against arbitrary and wrongful arrests," it said.

In the GST Act of 2017, the government provided the power of arrest in certain cases. On the challenge to the GST Act provisions over power to arrest and summon, the bench did not agree to the submissions that the Centre lacked "legislative competence".

It was argued that Article 246A of the Constitution while conferring legislative powers on Parliament and state legislatures to levy and collect GST, did not explicitly authorise the violations to be made criminal of-

The bench disagreed and said, "Article 246A of the Constitution is a special provision defining the source of power and the field of legislation for Parliament and the state legislature with respect to GST. The verdict added, "Parliament, under Article 246A of the Constitution, has the power to make laws regarding GST and, as a necessary corollary, enact provisions against tax evasion. Article 246A of the Constitution is a

comprehensive provision and the doctrine of pith and substance applies.' A penalty or prosecution mechanism for the levy and collection of GST, and for checking its evasion, was a permissible exercise of legislative power, it added.

The bench said the powers to summon, arrest and prosecute were ancillary and incidental to the power to

levy and collect goods and services tax. (PTI)

DHUBRI, Feb 27: In a major shake-up aimed at curbing corruption, the district commissioner Dhubri has transferred 28 Lat Mandals from various revenue circles of the district in a single day, sending shock-waves across the administrative corridors. The move came through an

official order issued by the office of the district commissioner. Dhubri under the Land Settlement Branch vide No DRS-32/2019/46, 26/02/2025. According to the order, the transferred officials belong to the Lat Mandals of revenue offices of Dhubri Circle, Gauripur Circle, Atani Circle, Golakganj Circle, Bilasipara Circle, and South

Salmara Circle. Allegations of rampant corruption, illegal land dealings, and irregularities have been hovering over many of these officials for a long time, prompting the administration to take this stern step. The sudden mass transfer is being seen as part of the "Zero Tolerance" policy adopted by the district commissioner to cleanse the revenue department of corrupt practices.

Several complaints from the public regarding bribery in land mutation cases, delay in landrelated services, and illegal land settlement had been piling up against the Lat Mandals, raising serious concerns over the integrity of the administration.

Although the administration has not officially commented on the reason behind the mass transfer, insiders claim that the step was taken after a series of confidential reports highlighted the nexus between revenue officials and land mafias operating in the district.

The transfer order has triggered panic among the remaining revenue staff, while the public has welcomed the move, hoping for transparency and accountability in land-related matters. With this unexpected development, all eyes are now on the Dhubri district administration, as people eagerly await further action against those found guilty of misusing their official positions.

Gati shakti cargo terminals are state-of-the-art logistics terminals being built with the participation of major industry partners for faster and more efficient handling of cargo. These terminals are



equipped with modern facilities which will improve the efficiency of freight logistics in the region and bring down the logistics costs, thereby enabling India to improve its position in the Logistics Performance Îndex (LPÎ).

One of these Gati Shakti cargo terminals is being developed at Baihata in Kamrup Rural District of Assam, constructed by BR Transcon Ltd. The terminal will feature three new goods lines, an Electronic in-motion weighbridge, durable goods circulating area with two goods platforms, high mast lighting for round the clock operations and special ramp for efficient handling of automobiles, among other facilities. It is expected that more than 25 freight rakes will be handled at this terminal every month.

Shrivastava instructed the concerned officials to ensure completion of this work within the next one month. Similarly, work on the Gati Shakti Cargo terminal at the Jogighopa Multi Modal logistics park is also in advanced stage, and is targeted to be completed by March 2025.

DHUBRI, Feb 27: A massive 38kilogram pumpkin grown in the char area of Dimatola has become the highlight of the Kisan Mela, organised by the Agricultural Tech-Management Agency (ATMA) in collaboration with the Dhubri district agriculture depart-

The pumpkin, cultivated on a 10bigha farm, has drawn significant attention from visitors and agricultural experts alike. The agro farm in Dimatola char, owned by Abu Lahel Bakey, spans 200 bighas of river-deposited land, where various vegetables like chilies, eggplants, potatoes, and pumpkins are grown alongside sesame, black gram, and mustard.

These fertile lands, however, are seasonal, appearing and disappearing with the shifting river. Despite their farming success, Bakey and other farmers in the region face major transportation challenges. 'We are far from the mainland, and the cost of transporting our produce is often higher than the value of the



vegetables themselves. We have to first travel by boat and then use vehicles, making the entire process extremely expensive," he explained. Due to these high costs, farmers are sometimes forced to discard their vegetables, leading to

financial losses. The farmers in these remote char areas sustain their livelihoods and maximize their agricultural potential despite being deprived by the MP's and MLA's in infrastructural development. Meanwhile, in the Birsing-Jarua

Development Block under Dhubri, farmers have reported a good return on vegetable production this season. The area has witnessed a strong yield of various crops, offering hope for better agricultural prospects in the region.

Use of USAID funds in India

The decision of US President Donald Trump to close the United States' Agency for International Development (USAID) led to a slugfest between the two main ruling class parties – the BJP and Congress. Announcing the closure, a list of recipients of USAID was published. Quoting from this list, Trump claimed that \$21 million was given for 'voter turnout' in India. Doubling down on this claim, Trump stated that this was intended to get 'somebody else elected'. He followed this up in yet another public interaction stating that this money went to his "friend Prime Minister Modi in India for voter turnout". These statements warrant serious consideration and should be thoroughly investigated. If proven true, they would indicate nothing less than direct interference by external forces in the internal democratic processes of our country. USAID is not an innocent agency that disburses foreign aid to deserving countries and communities without expecting anything in return. It operates as an extension of the US State Department, to carry forward its aggressive foreign policy objectives. Established by President John F. Kennedy during the Cold War to counter the growing influence of the Soviet Union, USAID has since played a key role in fomenting regime change, safeguarding US corporate interests, and crushing socialist movements.

The use of aid as a tool to enforce regime change or dismantle governments perceived as threats to US interests is not a new phenomenon – nor is it something that has bypassed India. Evidence has emerged regarding how the US 'aided' the Congress party in removing Kerala's first elected communist government. The fact that both the Congress and the BJP (or its earlier incarnation, the Jan Sangh) had no objections to such interference speaks volumes about their commitment – or lack thereof – to safeguarding India's sovereignty and democratic institutions. Against this backdrop, the US President's claim that \$21 million was paid to influence 'voter turnout' in India is a serious allegation that cannot be ignored or dismissed. Moreover, it must not be buried under the weight of 'whataboutery' by either the BJP

The Minister of External Affairs stated that the Trump administration's remarks are 'concerning' and that 'the government is looking into it.' Beyond this, however, he has remained completely silent on whether there is any truth to these claims. Certain media outlets have reported that the funds in question were not intended for India but for Bangladesh, suggesting that Trump may have confused 'Dhaka' with 'Delhi.' While this explanation might seem amusing, it is ultimately the government's responsibility to provide a clear and transparent account of USAID's involvement and activities in India. According to government reports, USAID has provided over \$17 billion (Rs 1.5 lakh crore) in funding to India since its establishment, supporting more than 555 projects across various sectors. Successive governments, regardless of which party was in power, have availed themselves of USAID funding. The full details of USAID funding, the nature of its projects, and its involvement in India's internal affairs must be brought to light. The government must come clean to safeguard the integrity and sovereignty of our country.

India is the second most preferred home for illegal migrants after the USA

ndia, the world's second most preferred destination of illegal migrants, has a lot to learn from the United States about how the latter has been handling the situation in recent years. Although US President Donald Trump is lately hogging the limelight for forcing illegal immigrants out of the country, such deportations are not unique to the Trump administration. His predecessor, Joe Biden, carried out 1.5 million deportations – almost the same number as carried out under Trump's first term – without much publicity. Former US president Barack Obama also followed the practice. The US has been the most preferred destination for unlawful migrants for years. It is believed to have the world's largest illegal immigrant population, numbering around 11.4 million. The majority of illegal migrants to the US come from neighbouring Mexico, followed by El Salvador and Guatemala.

The International Organisation for Migration and other global agencies conservatively put the number of undocumented migrants in India at around 10 million. India's weak deportation policy has encouraged over the years large illegal migration into the country from its neighbouring countries such as Bangladesh. Myanmar, Nepal, Pakistan and Afghanistan. Few will disagree that the world's most populous country needs a strong policy to deal with illegal immigrants for the safety and security of its own nationals. Economically, India is much weaker than neighbouring China, Saudi Arabia and the UAE which are known to follow a strong immigration policy. However, India's soft democratic system and easy judicial interventions often make forceful deportation of illegal immigrants difficult. The US, itself a country of immigrants, has shown the world its ruthless resolve to deal with illegal immi-

Contrary to the poor economic status of those migrating illegally into India, Indian unlawful migrants to the US and Canada are reasonably well-off. Most of them take the help of private agents to enter their chosen overseas destinations at a huge cost. A good

According to the Ministry of Home Affairs, India has a total land border length of approximately 15,106.7 kilometres, including those with countries such as Pakistan, China, Nepal, Bhutan, Myanmar, Bangladesh, and Afghanistan. India is still negotiating with Bangladesh to erect fencing along some portions of its borders. India has the longest international land border with Bangladesh covering 4,096.7 km. Jobless illegal immigrants are often easy prey for terrorists, drug peddlers, pimps, swindlers and other criminals. While the country must try to prevent the entry of illegal immigrants, the process of deportation should be carried out earnestly with wide international publicity. (IPA Service)

Chief Minister Stalin sounds Tamil bugle against Narendra Modi's 'Namaste India'

Vanakkam' or 'Namaste'? Tamil Nadu Chief Minister MK Stalin wouldn't mind a greeting in Russian, the language of his namesake, but greet him with a 'Ram-Ram' in 'khari-boli Hindi' and he might burst a blood vessel while soaking in the morning sun. The Tamil doesn't think Good Morning India' as 'English imposition' but Hindi imposition' is 100% the Tamil's 'Bogeyman.' In 1937, Madras Premier S Rajagopalachari sounded the bugle for 'Hindi' and the first 'anti-Hindi imposition' stir upset the Tamil Street. 'Hindi imposition' thereafter did not raise its hydra-head till 1965. Now, there is another move at 'Hindi imposition' and the DMK is back to blackening Hindi

Targets include bank-boards and notices at railway stations and bus-stands, wherever there is 'Devnagari', there is also the darky and sticky tar! Chief Minister MK Stalin has challenged Prime Minister Narendra Modi's three-language policy, which Stalin's DMK has vowed to fight till the cows come home, a wholly Hindi saying that goes back to the now debunked Aryan invasion.

The story goes that the Aryans went back to worshipping the cow while the Dravidians didn't mind chewing on jerky, dried beef and buffalo meat. Is it a cultural thing? No, more like denying the existence of the other.

And 'Hindi imposition' and hate for Hindi are two sides of the same coin; 3000 to 4000 years of history. The Dravidians were driven out of their well-laid out habitats and the hot-boiling hatred hasn't ebbed.

So, it isn't the three-language policy alone responsible. Like somebody put it, the tussle is an administrative deficiency, call it a trust deficit. Chief Minister MK Stalin and the DMK aren't ready to relent so long as suspicions remain that 'Hindi imposition' will keep rearing its head time and again, as often the 'Hindiwalas' want.

To be honest, trusting Prime Minister Narendra Modi is hazardous. Modi's staple is a 'lie a day', which is both cultural and political. Riding the Hindi tiger has its plusses. And Chief Minister MK Stalin, too, has political and cultural reasons to keep the gates shut on Hindi

The Prime Minister and the Chief Minister, both of them, are prisoners to their own political and cultural compulsions. The Modi government went one step further: It gave an ultimatum to the Stalin government, with the demand to fall in line or face the

of the New Education Policy (NEP) deal. This has added an edge to the deeply-rooted political and cultural battle. Chief Minister Stalin has called Modi's three-language formula 'Hindi imposition' and a violation of Tamil Nadu's linguistic auton-

Union Education Minister Dharmendra Pradhan says Tamil Nadu has to "align with India's Constitution" and commit to the three-language policy, which translates to "my way or the highway", and Tamil Nadu says "no Hindi imposition" and commitment only to the two-language formula, which translates to "over my dead body!"

The anti-Hindi movement in Tamil Nadu is rooted in the Dravidian movement and linguistic autonomy is part and parcel of the Dravidian resistance to 'Hindi imposition'. Chief Minister Stalin says Tamil Nadu was "ready for another language war," linking it to Lok Sabha delimitation exercise, fear-mongering that Tamil Nadu was facing the "threat" of losing 8 Lok Sabha seats after the delimitation exercise.

Stalin says Tamil Nadu shouldn't have succumbed to pressure and successfully implemented the family planning programme that left its population stranded. The Chief Minister has called an all-party meet to discuss the delimitation as well as the three-language policy of the Modi government. Stalin has called for Opposition unity, which is the Achilles heel of the opposition parties. Stalin has appealed for unity; for overcoming political differences and thwarting the Centre thwarting the Centre's "divisive agenda." BJP's Tamil Nadu president K Annamalai in turn charged Stalin with "trying to shift the narrative" by resorting to "imaginary

The all-party meeting called by Stalin is scheduled to be held on March 5 and it will discuss the three-language policy, as well, along with National Education Policy, central funds and NEET. Stalin said delimitation is the Damocles Sword hanging over the southern states.

Tamil Nadu is leading in all development indices but faces the "threat" of losing out on Lok Sabha seats as post-delimitation, states' representation will be subject to population and because Tamil Nadu succeeded in population control, "she" stands to lose as many as 8 Lok Sabha seats.

Chinese discourse on Trump tariff

n 1 February 2025, United States (US) President Donald Trump signed an executive order to impose additional tariffs on products from Canada, Mexico, and China. However, following talks with Canadian Prime Minister Justin Trudeau and Mexican President Claudia Sheinbaum Pardo on 3 February, Trump agreed to postpone the implementation of tariffs by a month. There were also discussions about a prospective call between the Chinese and American leaders on the same day, which apparently could not take place. On 4 February, President Trump announced that he is not "in a rush" and would speak to the Chinese leader at an "appropriate time". China responded by announcing a slew of retaliatory measures on the same day. First, it imposed additional tariffs of 10-15 percent on 80 imported goods originating from the US. Additionally, it included US companies like PVH Corp. and Illumina Inc. in the 'Unreliable Entity' list, implemented stringent export controls on key minerals like tungsten, tellurium, bismuth, molybdenum, and indium, initiated investigations into Google Inc. for a suspected violation of China's Anti-Monopoly Law, and officially sued the US at the World Trade Organization.

Forcing the US to accept China's rise 'Counter-sanction' has become a buzzword in Chinese policy circuits in the past few months. In December 2024, when the Biden administration sanctioned a large-scale chip export ban on China, the latter instantly retaliated with export controls of key raw materials such as gallium, germanium, antimony, and graphite on the US. It also took action against several US companies such as NVIDIA, Lockheed Martin Missiles, and Fire Control on various grounds. Chinese scholars are of the opinion that, through these strong measures, the Chinese government has formally set the tone for its prospective relations with Trump 2.0.

The Chinese state media, on the other hand, has been running a propaganda blitz, claiming major breakthroughs in various disruptive technologies including sixth-generation fighter jets, the Type 076 amphibious assault ship, the KJ-3000 early warning aircraft, the Hongqi-19 missile defence system, and a new laser-based radar technology that can detect submarines at a depth of 1,000 metres—showcasing China's scientific and technological prowess. The message emerging from Beijing is clear: "China has made great progress and surpassed the US in many areas. It now has considerable strength, including in equipment production and industrial chain... to force the US to accept China's rise. Afterall China is the only country with all industrial sectors, and the most complete industrial system in the world that can provide almost all the products of the Fourth Industrial Revolution to the world...no country or countries can decouple from China and that is the source of Chinese confidence," asserted Zhang Weiwei, a professor of International Relations at Fudan University.

Who bears the cost of the Trump tariffs: US consumers or Chinese enter-

Despite the tall assertions, concerns persist, the key being who will ultimately bear the cost of the current round of Trump tariffs: US consumers and end-users or Chinese enterprises. The Chinese side hopes that their merchants will pass the burden on to American consumers, triggering inflation and intensifying public grievances, thereby forcing Trump to retreat on the tariff

On the other hand, China is aware and increasingly concerned about the worsening trend of "involutionary" competition within the Chinese manufacturing industry. Competition is often considered to be positive as it can result in innovation and creativity. Low prices brought about by this involutionary competition among Chinese manufacturing enterprises has created competi-



tive advantages for its export companies, securing itself a dominant position in the international trade system. Nonetheless, in the new sets of development, with intensifying China-US trade friction and continued downward pressure on the Chinese economy, involutionary competition among Chinese companies is proving to be counterproductive.

The primary manifestation of the involutionary competition among Chinese companies is the endless price wars based on cost reduction through salary cuts, layoffs, and research and development cuts. Domestically, it is leading to a sharp decline in commodity prices, driving down corporate profits, and in turn, pruning the wages, employment,

and consumption power of the Chinese populace. Many Chinese speculators are of the opinion that the ongoing uncontrollable price competition in various industries, if not prevented, can devolve China from disruptive technological innovations to the age of "cutting corners, counterfeiting, and shoddy products".

Furthermore, excessive price competition in overseas markets is becoming increasingly unsustainable for Chinese companies where, despite surges in deliveries and revenue, Chinese companies (especially in the domains of automobile, solar panels) are facing widening losses as prices plummet to the bottom. Complementing this, China's export boom based on price-advantage is triggering trade disputes and

anti-dumping investigations in various countries including those that otherwise share comparatively closer ties with China, such as the European Union, Brazil, and South Africa.

For instance, the involution in China's automobile manufacturing industry is one of the fiercest, where a common strategy for automakers has been to boost sales by "trading price for volume". According to Chinese estimates, the scale of price reduction in the Chinese auto market from January to December 2024 reached 227 models, exceeding the figures of 2022 (95) and 2023 (148). Although the new energyvehicle sector is certainly the hardest hit, with new car prices dropping by an avpercent), additional relevant data highlights a 7.3 percent year-on-year decline in the profits of the Chinese automobile industry between January and November 2024. The same dataset delineated that profit margins were 4.4 percent lower than the average profit margin of 6.1 percent of downstream industrial enterprises. The profits of the automobile industry in November 2024 fell by 35 percent year-on-year, and the profit margin was only 3.3 percent.

Chinese media reports further claimed that, among 71 passenger car companies in the country, only three could remain profitable and only for three consecutive years. Even BYD Auto, the leading Chinese automaker, has seen its gross profit margin drop sharply despite a global heft in the sales of its new energy vehicles. Industry experts believe that, under the heavy pressure of price wars, the capabilities of technological innovation within Chinese new energy vehicles are bound to be impacted, with product homogeneity translating into an unwelcome trend.

Responding to the negative effects of involutionary competition in various industries and bringing the Chinese economy out of deflation continue to pose critical questions before the Chinese strategic community, which has been desperately urging Chinese enterprises "not to further reduce prices to bear the new US tariffs. That, in foreign trade, Chinese manufacturers need to maintain the bottom line of profitability and cannot further engage in vicious price competition...instead, they should compete for core competencies.

As succinctly put by Xuetao Song, Chief Macro Analyst at Tianfeng Securities, the limit of the tariff war between China and the US is actually a question of the limits of US consumer tolerance of inflation on the one hand and the profit margin of China's export manufacturing industry on the other. Russia's cancer vaccine: A milestone

ancer, one of the leading causes of death worldwide, continues to chal-✓ lenge medical science. Trump's MAGA + Modi's MIGA = A mega contradiction

n his visit to Washington last fortnight, Prime Minister Narendra Modi proclaimed a new equation in US-India relations: "MAGA + MIGA = MEGA Partnership"

By aligning India's development goals with Trump's signature slogan, Modi aimed to appeal to American conservatives while boasting about India's rise as a global power. However, beneath the rhetoric of economic cooperation and shared nationalist aspirations lies a fundamental contradiction one that exposes the fragility

of this supposed alliance. At its core, Trump's Make America Great Again or MAGA movement has been deeply intertwined with white supremacist ideologies and an exclusionary vision of America. While some Indian-American conservatives have aligned themselves with MAGA politics, often based on a shared Islamophobia and anti-left sentiment, they have failed to recognise the movement's broader racial and cultural prej-

The recent spate of anti-Indian rhetoric from MAGA figures and their supporters, from Silicon Valley to the White House, is a stark reminder that the movement does not see Hindutva supporters as equals, but rather as a convenient, expendable constituency.

Prime Minister Modi's attempt to merge MAGA with MIGA or Make India Great Again is rooted in the assumption that nationalist movements can find common ground. Both movements center around a romanticised past, economic selfsufficiency and a muscular and majoritarian approach to governance.

However, while Modi's brand of Hindu nationalism promotes India as a civilisational state with its own historical and cultural superiority, MAGA's racialised vision of America is fundamentally opposed to such ideas. White nationalist segments of MAGA do not see Indians, Hindutva supporters or otherwise, as partners in their project.

Instead, Indians are often cast as job stealers, cultural outsiders, or, at best, temporary allies in the fight against "woke" ideology.

Recent incidents highlight the widening gulf between Indian MAGA supporters and the movement's hardline base. Marko Elez, a staffer for Elon Musk's Department of Government Efficiency was found to have posted blatantly racist, anti-Indian messages, calling for a "eugenic immigration pol-



icy" and urging his social media followers to "normalize Indian

remarks outright, prominent MAGA figures, including Vice President JD Vance, who is married to a woman of Indian origin, came to Elez's defense, arguing that social media activity should not "ruin a kid's life".

This dismissive attitude toward anti-Indian racism within the movement has forced many Indian MAGA supporters to confront a harsh reality: their lovalty to MAGA does not grant them immunity from its deeply ingrained xenophobia.

The fall of biotech entrepreneur and former presidential candidate Vivek Ramaswamy serves as a cautionary tale. Once embraced by MAGA circles for his critiques of "woke" culture and his nationalist rhetoric, Ramaswamy quickly found himself ostracised after making remarks about American mediocrity and the cultural discipline

of immigrant families. The moment he suggested that American-born workers were losing out to foreign talent due to cultural laziness rather than a flawed immigration system, MAGA supporters, who had initially celebrated him as proof that the movement was not racist, turned on him.

Ramaswamy's ouster from Musk's DOGE underscores the rigid racial hierarchy within MAGA. While the movement is willing to accept non-white figures who reinforce its broader narratives, any deviation from its core ideology leads to immediate ostracisation. The message is clear: Indian-origin figures in the MAGA movement are tolerated only as long as they do not challenge the racialised status

One of the primary contradictions in the MAGA-Hindutva alliance is the question of immigration. Many Indian Americans in tech have supported Trump's policies, believing that his administration would favor highly skilled immigrants. However, MAGA's anti-immigrant base sees no distinction between undocumented migrants and legal visa holders, viewing both as threats to

American jobs and culture. The recent uproar over

Trump's handling of H-1B visa policies and his crackdown on birthright citizenship for children of visa holders signals a clear hostility toward Indian immigrants.

Trump's decision to deport several hundreds of undocumented Indian immigrants in shackles, on military planes, was met with outrage in India but barely a murmur from his loyalists in the Indian-American conservative community.

This silence is telling. While some pro-MAGA Indian Americans have begun to express concern about rising anti-Indian sentiment within the movement, others continue to delude themselves into thinking that they are integral to its future.

The reality is starkly different: MAGA does not prioritise Indian interests, and its base views Indian immigrants as expendable at best, and unwelcome at worst.

Despite these warning signs, many Indian nationalists continue to court MAGA support, believing that Trump's strongman persona aligns with Modi's leadership style. What they fail to acknowledge is that Hindu nationalists, in the eyes of white supremacists, are not natural allies but rather useful instruments.

The Indian diaspora in the US has long sought to position itself as a model minority - hardworking, successful, and aligned with conservative values. Yet, history has shown that model minority status is conditional and can be revoked at any time. The growing wave of anti-Indian racism within MAGA is proof that no amount of lovalty can override the fundamental racial biases at play.

Modi's proclamation of a MEGA partnership between MAGA and MIGA is, at best, a wishful slogan and, at worst, a delusion. The contradictions are too vast to ignore. MAGA thrives on exclusion and racial superiority, while Hindutva envisions a Hindu-dominated but globally respected India. These visions are not just different: they are fundamentally incompatible. Hamas calls for talks on next phase of ceasefire after hostage-prisoner exchange

KHAN YOUNIS, Feb 27: Hamas said Thursday it was ready to negotiate the next phase of the ceasefire in the Gaza Strip, after a swap in which it handed over the remains of four hostages in exchange for the release of more than 600 Palestinian prisoners held by Israel.

It was the final such exchange the two sides agreed to as part of a truce that's set to end this weekend. Negotiations over a second phase, in which Hamas would release dozens of remaining hostages in exchange for more prisoners and a lasting ceasefire, have not yet begun.

An Israeli group representing families of hostages held by Hamas said the remains of all four hostages returned early Thursday have been identified. The Hostages and Missing Families Forum identified them as Ohad Yahalomi, Itzhak Elgarat, Shlomo Mantzur and Tsachi Idan.

Mantzur, 85, was killed in the October 7, 2023, attack and his body was taken into Gaza. The other three were abducted alive and the circumstances surrounding their deaths were not known.

Hamas said in a statement that the "only way" for Israel to secure the release of the remaining hostages was through negotiations and adhering to the agreement. It warned that any attempt to pull back from the truce "will only lead



to more suffering" for the captives and their families.

Hamas confirmed that over 600 prisoners had been released overnight. Most were detainees returned to Gaza, where they had been rounded up after the October 7, 2023 attack that triggered the war and held without charge on security suspicions.

A joyful return for released prisoners

Some of the released prisoners fell to their knees in gratitude after disembarking from buses in the southern Gaza city of Khan Younis. In the West Bank town of Beitunia, dozens of prisoners were welcomed by crowds of relatives and well-wishers.

The released prisoners, some of whom had been serving life sentences over deadly attacks against Israelis, wore shirts issued by the Israeli prison service bearing a message in Arabic about pursuing

one's enemies. Some of the pris-

oners threw the shirts on the

ground or set them on fire.

Israel delayed the release of the prisoners on Saturday over Hamas' practice of parading hostages before crowds and cameras during their release. Israel, along with the Red Cross and UN officials, have called the cerehumiliating for the monies

Hamas released the four bodies to the Red Cross in Gaza overnight without a public cere-

The prisoners released Thursday included 445 men, 21 teenagers and one woman, according to lists shared by Palestinian Netanyahu has vowed to return all

officials that did not specify their ages. Only around 50 Palestinians were released into the occupied West Bank and east Jerusalem in this round, while dozens sentenced to life over deadly attacks against Israelis were exiled.

Last handover in ceasefire's

The latest handover was the final one planned under the ceasefire's first phase, during which Hamas returned 33 hostages, including eight bodies, in exchange for nearly 2,000 Palestinian prisoners. The family of Idan said Wednesday they had been told he is dead and his body was among those to be returned to Israel.

Idan was taken from Kibbutz Nahal Oz. His eldest daughter, Maayan, was killed as militants shot through the door of the family's safe room. Hamas militants broadcast themselves on Facebook holding the family hostage in their home as two younger children pleaded to be let go.

The ceasefire's six-week first phase expires this weekend. US President Donald Trump's Middle East envoy, Steve Witkoff, has said he wants the sides to move into negotiations on the second phase. Those talks were supposed to begin the first week of Febru-

Trump on Jan 20 ordered what he said would be a 90-day program-byprogram review of which foreign assistance programs deserved to continue, and cut off all foreign assistance funds almost overnight.

The funding freeze has stopped thousands of U.S.-funded programs abroad, and the administration and Musk's Department of Government jority of USAID staff off the job through forced leave and firings.

In the federal court filings Wednesday, nonprofits owed money on contracts with USAID describe both Trump political appointees and members of Musk's teams terminating USAID's contracts around the world at breakneck speed, without time for any meaningful review, they say.

A coalition representing major US and global businesses and nongovernmental organizations and former officials expressed shock at the move. The American people deserve a transparent accounting of what will be lost — on counterterror, global health, food security, and competition," the US Global Leadership Coalition said.

The State Department said Secretary of State Marco Rubio had reviewed the terminations.

In all, the Trump administration said it will eliminate 5,800 of 6,200 multiyear USAID contract awards, for a cut of USD 54 billion. Another 4,100 of 9,100 State Department grants were being eliminated, for a cut of USD 4.4 billion.

The State Department memo, which was first reported by the Washington Free Beacon, described the administration as spurred by a federal court order that gave officials until the end of the day Wednesday to lift the Trump administration's monthlong block on foreign aid funding.

"In response, State and USAID moved rapidly," targeting USAID and State Department foreign aid programs in vast numbers for contract terminations, the memo said.

Trump administration officials after repeated warnings from the federal judge in the case — also said Wednesday they were finally beginning to send out their first or any payments after more than a month with no known spending. Officials were processing a few million dollars of back payments, officials said, owed to US and international organizations and companies.

But US District Judge Amir H Ali's order to unfreeze billions of dollars by midnight Wednesday will remain on hold until the Supreme Court has a chance to weigh in more fully, according to the brief order signed by Chief Justice John Roberts.

Ali had ordered the federal government to comply with his decision temporarily blocking a freeze on foreign aid, ruling in a lawsuit filed by nonprofit groups and businesses. An appellate panel refused the administration's request to intervene before the high court weighed in.

The plaintiffs have until noon Friday to respond, Roberts said.

The administration has filed an emergency appeal to the Supreme Court in one other case so far, arguing that a lower court was wrong to reinstate the head of a federal watchdog

Taiwan condemns China for conducting shooting drills off its coast Russia to back its war against Ukraine, Seoul says

Thursday condemned China's military exercises after Beijing designated an area to conduct shooting drills off the self-governed island's southwest coast.

China considers the island a renegade province to be taken by force if necessary and in recent years has increased military activity around Taiwan's waters and airspace.

"China is the biggest troublemaker for regional peace and stability, and the sole and greatest threat to peace and stability in the Taiwan Strait and the Indo-Pacific region," Taiwan's Foreign Ministry said in its statement.

Taiwan's Defence Ministry said in a 24-hour period it detected 45 aircraft, 14 navy vessels and one ship from the Chinese military operating around Taiwan, of which 34 had crossed into its waters and air-

Pope beats back speculation of imminent death or conclave

ROME, Feb 27: Pope Francis continued his slow recovery from double pneumonia on Thursday, beating back speculation of an imminent death, resignation or conclave and signalling that he was still very much in charge albeit in a weakened state.

The Vatican said the 88-year-old pope once again slept well during the night at Rome's Gemelli hospital and was resting Thursday morning.

Doctors on Wednesday reported further slight improvements in his clinical condition. They said the kidney insufficiency that had been detected in recent days had receded, blood tests showed a slight improvement and a chest CT scan showed that his complex lung infection was taking the "normal evolution" as it is being treated.

The prognosis remained guarded, however. The pope, who had part of one lung removed as a voung man. is still receiving high flows of supplemental oxygen and respiratory physiotherapy to help his lungs expel fluid. But he hasn't had any more respiratory crises since Saturday, the Vatican said. Prayers for his heath continued to pour in from near and far, with the dean of the College of Cardinals presiding Wednesday night over what has now become a nightly appointment in St. Peter's Square, the 9 pm Rosary prayer.

"We are gathered in St. Peter's Square to pray confidently that God will allow Pope Francis to resume his apostolic service as soon as possible, in the fullness of his physical strength and with that pastoral dynamism that characterises him," said Cardinal Gio-

vanni Battista Re. As is now popularly known thanks to the Oscar-nominated film "Conclave," the 91-year-old Re would have a key role in any papal death or conclave, called to preside over the funeral and organise the secret balloting in the Sistine Chapel to elect a new pope. Francis recently extended Re's term, keeping him on in the important job rather than naming someone new. But on Wednesday night, Re was merely one of the Catholic Church's most senior cardinals, an important point of reference for the men who lead the church, praying for Francis' speedy recovery. (AP)

Brahim Aouissaoui, 25, was charged with terrorist murder and attempted terrorist murder. He admitted responsibility for the attack during the trial in Paris, even though he had said he couldn't remember anything since then. He explained that he wanted to avenge Muslims killed around the

On Oct 29, 2020, Aouissaoui killed worshippers Nadine Vincent, 60, and Simone Barreto, a 44-year-old French-Brazilian woman, and church worker Vincent Loques, 55. Police officers fired at him as he lunged at them, shouting "Allahu Akbar" (God is great) and wielding a knife. He was shot and seriously wounded.

The attack was the third in less than two months that French authorities attributed to Islamic extremists, and prompted the government to raise its security alert to the maximum level. It came while France was holding a trial over the 2015 attacks on satirical newspaper Charlie Hebdo,

Intuitive Machines' lander, named Athena, caught a lift with SpaceX from NASA's Kennedy Space Center. It's taking a fast track to the moon with a landing on March 6 — while hoping to avoid the fate of its predecessor, which tipped over at touch-

Never before have so many spacecraft angled for the moon's surface all at once. Last month, US and Japanese companies shared a rocket and separately launched landers toward Earth's sidekick. Texas-based Firefly Aerospace should get there first this weekend after a big head start.

The two US landers are carrying tens of millions of dollars' worth of experiments for NASA as it prepares to return astronauts to the moon. "It's an amazing time. There's so

much energy," NASA's science mission chief Nicky Fox told The Associated Press a few hours ahead of the This isn't Intuitive Machines' first

lunar rodeo. Last year, the Texas com-

pany made the first US touchdown on the moon in more than 50 years. But an instrument that gauges distance did not work and the lander came down too hard and broke a leg, tipping onto

"Certainly, we will be better this time than we were last time. But you never know what could happen," said Trent Martin, senior vice president of space systems.

It's an extraordinarily elite club. Only five countries have pulled off a lunar landing over the decades: Russia, the US, China, India and Japan. The moon is littered with wreckage from many past failures.

The 15-foot (4.7-meter) Athena will target a landing 100 miles (160 kilometers) from the lunar south pole. Just a quarter-mile (400 meters) away is a permanently shadowed crater the ultimate destination for the drone named Grace.

Named after the late computer programming pioneer Grace Hopper, the 3-foot (1-meter) drone will make three increasingly higher and longer using hydrazine fueled-thrusters for flight and cameras and lasers for nav-

If those excursions go well, it will hop into the nearby pitch-black crater, an estimated 65 feet (20 meters) deep. Science instruments from Hungary and Germany will take measurements at the bottom while hunting for frozen

It will be the first up-close peek inside one of the many shadowed craters dotting both the north and south poles. Scientists suspect these craters are packed with tons of ice. If so, this ice could be transformed by future explorers into water to drink, air to breathe and even rocket fuel.

NASA is paying \$62 million to Intuitive Machines to get its drill and other experiments to the moon. The company, in turn, sold space on the lander to others. It also opened up the

Falcon rocket to ride-sharing. Tagalongs included NASA's Lunar Trailblazer satellite, which will fly separately to the moon over the next several months before entering lunar orbit to map the distribution of water below. Also catching a ride was a private spacecraft that will chase after an asteroid for a flyby, a precursor to asteroid mining. (AP)

104 weapons surrendered in six Manipur districts

IMPHAL, Feb 27: Altogether 104 firearms and ammunition were voluntarily surrendered by the public in six districts in strife-torn Manipur, police said on Thursday.

These weapons were surrendered in Kangpokpi, İmphal East, Bishnupur, Thoubal, Imphal West and Kakching districts on Wednesday, a day before the seven-day period given by the authorities for giving up firearms ends, a senior officer said.

Manipur Governor Ajay Kumar Bhalla had on February 20 urged the people of the strife-torn state to voluntarily surrender looted and illegally held weapons within seven days, assuring no punitive action would be initiated against those giving up arms during this period.

Chief Secretary PK Singh had on February 23 said the seven-day time given for voluntarily surrendering weapons is enough if one wants to give up arms, and asserted that the forces would take action after the expiry of the period to recover such guns.(PTI)

Mamata sets 215 plus seat target for 2026 assembly polls, aims for fourth straight term

Minister Mamata Banerjee on Thursday set an ambitious goal of winning more than 215 of the total 294 seats in the state assembly in the 2026 polls, emphasising that the TMC would work to significantly reduce the BJP's tally and secure a fourth consecutive term in

Setting the tone for the electoral battle, Banerjee reiterated the need to surpass the 213 seats won by her party in 2021.

"I agree with Abhishek (TMC MP and her nephew Abhishek Banerjee) that we should aim for at least one more seat than our 2021 tally. Our goal should be to secure 215 seats or more while ensuring that BJP, CPIM, and Congress candidates struggle to retain their deposits," Banerjee asserted.

Addressing an organisational meeting of the Trinamool Congress before the chief minister, the MP said the party should work for winning at least one additional seat than the current strength.

Responding to Mamata Banerjee's statement, BJP MP Samik Bhattacharya claimed that she is afraid of losing the 2026 assembly polls and is saying such things to galvanize TMC workers

The BJP had secured 77 seats in the 2021

"We will win over 215 seats in the 2026 assembly polls and further diminish the BJP's numbers," Banerjee stated at the meet-

She also criticised the BJP's previous electoral claims.

"In 2021, they boasted '200 paar' but faced defeat. In 2024, they claimed '400 paar' in the Lok Sabha elections but failed to secure a majority. What Abhishek said is correct. We will secure a two-thirds majority, and BJP candidates should lose their deposits," Banerjee remarked. Telangana parties slam Union Minister



failed to acknowledge 'crisis'



NEW DELHI, Feb 27: Flagging the issue of household indebtedness, the Congress on Thursday said the root cause of such a "deepseated" malaise was the stagnation in real wages and claimed the government had failed to acknowledge

Congress general secretary incharge communications Jairam Ramesh cited the recently-released Indus Valley Annual Report 2025, an examination of India's economic landscape and start-up ecosystem by VC firm Blume Ventures, to attack the government.

The report offers a granular look into the Indian economy, he said and asserted that its most worrying implications were for India's household finances.

Ramesh said India's recovery from COVID-19 was based on consumption growth that was driven by loans.

Consumer loans in the post-Covid years were about 18 per cent of the Private Final Consumption Expenditure, he said.

In this time, personal loans replaced industry loans as the biggest segment of non-food borrowing, Ramesh said.

'This was a reflection of the slowing private investment levels. Much of this indebtedness was due to the rise in small ticket personal loans from non-banking financial companies -- they comprise 82 per cent of the new personal loans originated in 2024," he said citing the report.

Credit growth has now created a household indebtedness crisis instead of continuing to fuel consumption, Ramesh said.

Household debt to GDP has hit an all-time high of nearly 43 per cent, he claimed.

"As a flipside to the household indebtedness, households are saving less -- especially financially. Household share of savings dropped from 84 per cent in FY 2000 to 61 per cent in FY 2023, reflecting an increase in uninvested corporate profits," he said.

Without adequate savings to finance investments, combined with sluggish foreign direct investment, India is undergoing a massive slowdown in private investment, Ramesh said.

"The root cause of this deepseated malaise is the stagnation in real wages, both in the salaried sector and in the informal rural sector. Without increasing labour productivity and higher wages, any growth in consumption will have to be based on unsustainable credit

booms," the Congress leader said. Ten years after this crisis first surfaced, and five years after COVID-19 hit, the government continues to fail to acknowledge this crisis, Ramesh alleged. (PTI)



Echoing her stance, TMC national general secretary Abhishek Banerjee urged party workers to ensure a decisive victory.

"The battle for Bengal's future has begun. We must ensure the TMC's victory and make Mamata Baneriee the Chief Minister for a fourth consecutive term. Our aim is a twothirds majority in 2026," he said.

At the meeting held at Netaji Indoor Stadium here, he outlined the party's election strategy while stressing discipline and unity.

"The BJP has ED-CBI-Income Tax trio backing them, but they lack the courage to fight on the ground. We will dismantle their 'chakravyuh' (a military formation used to surround enemies, depicted in the Mahabharata). We have done it before and will do it again," Abhishek Banerjee said.



Congress MLAs boycott Rajasthan **Assembly proceedings**

Party holds mock session outside as impasse continues



JAIPUR, Feb 27: There was no end to the nearly week-long impasse in the Rajasthan Assembly, with Congress MLAs boycotting Thursday's proceedings and holding a mock session outside to protest against a state minister's remarks against former prime minister Indira Gandhi.

The deadlock over Social Justice and Empowerment Minister Avinash Gehlot's comments in the assembly last week escalated after the Congress' state president Govind Singh Dotasra's "undignified remarks" against Speaker Vasudev Devnani.

Holding placards, opposition MLAs marched towards the assembly and sat outside the premises. They raised slogans and demanded an apology from the minister for his remarks.

The Congress lawmakers also held a mock Question Hour outside the House, with Ghanshyam acting as the "chair" while the other members asked him questions on ruling BJP leaders' behav-

Inside the House, ruling party MLAs accused the Congress members of disrupting the proceedings and demanded that the deadlock be ended.

Former chief minister and senior Congress leader Ashok Gehlot told reporters outside the assembly that both sides should cooperate to end the impasse.

"This should end so that debate takes place in the assembly. The treasury and the opposition benches must cooperate and there should be no ego... This tension is unnecessary," he said.

Leader of Opposition Tikaram Jully said they were open for talks but the government did not want to run the House.

"The minister had made the remarks. We slept in the assembly for three days. Talks were held to end the deadlock. Three opposition leaders expressed regret. Despite this, the minister is not replying,'

"I have communicated to the chief minister and the parliamentary affairs minister that our doors are open for talks. Dotasra ji also said that he could visit the speaker's residence to clear things up. The government is afraid of the performance of its ministers... That is why it does not want to run the House," Jully said.

Rajasthan's Minister of State for Home Jawahar Singh Bedham told reporters that people elected the Congress MLAs but they ran away from the House.

"Undignified words were used by the Congress state president in the House and they were published prominently in newspapers. He is raising questions on that," he said.

The minister also said Ashok Gehlot was busy posting messages on social media but did not come to the assembly.

Bedham contended that the word "dadi" used by Avniash Gehlot to describe Indira Gandhi was not unparliamentary and noted that former prime minister Jawaharlal Nehru was referred to as "chacha".

"Dotasra ji should apologise for his remarks against the chair. He holds a dignified post as the party's state chief. He should come to the House. Who is stopping him? He should apologise and let the House run smoothly," he demanded.

During Zero Hour, BJP MLA Arjun Lal raised the impasse issue and said no disrespectful remarks were made.

The deadlock should be ended, he demanded.

Replying to him, Bedham said positive efforts were made by the government to break the deadlock.

Parliamentary Affairs Minister Jogaram Patel, along with others, held several rounds of talks with senior Congress legislators during which the Laxmangarh MLA (Dotasra) agreed to tender an apology for his conduct and the words used to refer to Devnani, Bedham

But when he spoke in the House, he did not say the things that he had agreed to during the meeting in the speaker's chamber, he added.

BJP MLA Srichand Kriplani said the Congress legislators would not have created a ruckus had Avinash Gehlot used the word 'grandmother" instead of "dadi".

On Tuesday, Devnani had said the words used by Dotasra against him were "insulting" to the chair.

Dotasra allegedly made the remarks against Devnani during the Congress' dharna in the House following the adjournment of pro-During Question Hour on Feb-

ruary 28, Avinash Gehlot had pointed to the opposition and said, 'In the 2023-24 budget, like always, you named the scheme (on working women's hostels) after your 'dadi (grandmother)' Indira Gandhi."

The remark triggered an uproar, leading to three adjournments and the suspension of six Congress MLAs.

Demanding an apology from the minister and the revocation of its members' suspension, the Congress MLAs began a sit-in in the assembly. Several rounds of talks between the two sides were held in the speaker's chamber but the issue could not be resolved as Devnani and Patel were not satisfied with the statement made by Dotasra. (PTI)


He also hailed Deshmukh's contribution in different fields, saying some people leave a lasting impact and become the reason for change

Delhi court acquits army officer in rape case

NEW DELHI, Feb 27: A Delhi court has acquitted an army officer accused of allegedly raping a woman on the pretext of marriage and said such a promise couldn't be held as "inducement for sex" over an indefinite period of

Additional sessions Judge Gajender Singh Nagar conducted the trial against the officer, who was also booked for the charge of unnatural offences and forcing the woman to undergo abortion twice.

In a verdict on January 25, the court said, "It has been held by the superior courts that inducement to have a physical relationship by promising marriage and the victim falling prey to inducement may be understandable in the context of the moment. A promise for marriage cannot be held out as an inducement for engaging in sex over a protracted and indefinite period of time.

The allegations, the court said, were "bald" and not proved beyond a reasonable doubt and the woman's testimony was untrustworthy, blemished and not of sterling

"Rather, the undersigned (judge) is of the considered opinion that the accused did not make physical relations, if any, with prosecutrix forcefully against her will and consent, rather she was a willing party to the said act," it held.

The order went on, "It is apparent that no offence of rape is committed with her (the complainant) and she always wanted to be with the accused, however, due to certain circumstances, their relationship could not fructify."

The court pointed out several inconsistencies in the woman's allegations, including doubts regarding the alleged incident of rape on February 13, 2014, at her rented

An order from the Army indicated to the court that the man was sanctioned leaves between February 14 and 15. "When the accused's leave was sanctioned from Feb-

ruary 14, then he must have taken some time to reach Delhi. In such circumstances, it is not possible that the accused was in Delhi on February 13 as claimed by the prosecutrix," it said. The court found it "strange" that the woman did not confide in her family her ordeal and instead accompanied the man to a hill station.

"It is very strange that despite being raped on February 13, the prosecutrix agreed to visit Manali alone with the accused and stayed with him in the same room where she was raped by the accused again and also got pregnant due to the same, but she did not inform her family about the same forthwith," the order said.

The allegations of pregnancy and abortion were not proved by any scientific or medical evidence, it added.

The statement about the woman's second pregnancy, after the accused refused to marry her in 2015, was also found to be inconsistent. (PTI)

Rashmi, who had been out on bail. was present in court when the verdict was delivered on February 19. She was taken into custody immediately and sent to Bengaluru central prison.

The case dates back to May 29. 2020, when a newborn was stolen from the BBMP (civic body) Hospital in Chamarajpet. The child's mother, who had just given birth, fell asleep after taking medication prescribed by a doctor.

When she woke up 45 minutes later, her baby was missing. A police

recovered the infant from a couple in North Karnataka, who had been misled into believing the baby was theirs through surrogacy. Shockingly, when officers arrived at their home, they found the couple joyfully celebrating the child's first birthday, unaware of the deception. The investigation was

Pune police use drones, dogs to look for Swargate bus rape accused

MUMBAI, Feb 27: Amid mounting pressure, police on Thursday deployed drones and dogs in Shirur taluka of Pune district to trace the accused in the Swargate bus rape case, officials said.

History-sheeter Dattatray Ramdas Gade (37) is accused of raping 26-year-old woman inside a Shiv Shahi bus of the Maharashtra State Road Transport Corporation (MSRTC) at Swargate bus station in Pune two days ago.

At least 13 teams of the Pune city police are trying to trace Gade, a resident of Gunat village, an official said.

In coordination with the Pune Rural police, a search operation is being conducted in the sugarcane fields at Gunat village as there was suspicion that Gade was hiding there, the official said.

Several senior police officials and more than 100 cops reached Gunat village in the afternoon, he said. Police are using drones for aerial imaging of the field so that Gade can be tracked down, he

A dog squad was also called for the search operation in the village,

Pune police have already announced a ₹ 1 lakh reward for any credible information that would lead to Gade's arrest, he said.

Pune Rural police are searching in the Shirur area and will do whatever is required for the operation, the official said.

In Pune City, police have questioned several persons, including Gade's friends, relatives and acquaintances, the official said. (PTI)

Kant said disruptions in global trade have created a significant opportunity for India. "There is a vacuum, and India can fill it. By doing so, we can accelerate economic growth,'

He said that India has made remarkable technological

progress in areas like fintech, citing UPI as an example. "We should replicate this success in clean-tech manufacturing, including solar energy, green hydrogen, batteries and electric vehicles. This is an opportunity for India to exceed 500 GW of renewable energy capacity by 2030. Technological disruptions are inevitable and we must be the first to lead. A technological leapfrog will transform India," he said.

Kant warned that if India fails to seize this opportunity, it will become dependent on imports. "If India does not seize this opportunity, we will become dependent on China for imports. Our spending on clean-tech imports will far exceed what we currently spend on oil," he said.

Asked whether insufficient funding from developed coun-

tries would impact the new climate goals of developing nations, Kant agreed. 'The developed world, responsible for financing climate action in developing countries, has failed to provide adequate funds. They did not fulfil their promise of USD 100 billion annually by 2020. Developing nations need USD 1.3

and sustainable development goals is USD 3 trillion," he Kant said that developing nations are not responsible for the climate crisis. (PTI)





BERLIN, Feb 27: Bundesliga contenders Bayern Munich and Bayer Leverkusen could be forgiven for thinking of their Champions League date before they fulfill challenging domestic obligations this weekend.

Bayern visits Stuttgart on Friday, while Leverkusen travels to Eintracht Frankfurt on Saturday.

Bayern then hosts Leverkusen for the first leg of their Champions League last-16 tie on Wednesday - a match that has taken on added importance for both teams with Bayern enjoying an eight-point lead over defending champion Leverkusen in the Bundesliga.

Leverkusen's players know that a Bayern collapse at this stage of the German league is unlikely and that their best chance of silverware lies in the German Cup — where they'll contest the semifinals and possibly in the Champions League, where a quarterfinal against Feyenoord or Inter Milan awaits if they can get past Bayern.

Leverkusen has already shown it's a match for the Bavarian powerhouse, dominating Vincent Kompany's team during their scoreless draw in the Bundesliga on Feb. 15, and knocking it out of the German Cup with a 1-0 win in the third round.

Sports Minister launches special capacity building course to develop more home-grown coaches

NEW DELHI, Feb 27: Sports Minister Mansukh Mandaviya on Thursday launched a special capacity building course in collaboration with Netaji Subhas National Institute of Sports, Patiala for current and former elite sports persons in an effort to help India produce more homegrown coaches and officials.

The course has been designed and developed for athletes who are currently employed and serving in various central government or autonomous departments, organisations under central government or Public Sector Undertakings (PSUs).

The eligibility criteria for this course are participation or medal winner in Olympics, World Championships, Asian Commonwealth

The medal winners of Youth Olympics, Junior World Championship, World University Games, senior National Championship and National Games can enroll for the course.



required is minimum graduation or equivalent degree from any recognized university in India.

The course consists of four certification levels -- foundation, pre-intermediate, intermediate and advanced certificate.

"We are suffering from a crisis of coaches, referees and trainers, so to bridge that I am starting a special capacity build-

week course. If they pass this course, some will become coaches, some will become referees, and they can be utilized in different sport-related work," Mandaviya said in a meeting with reporters.

learning options, allowing candidates to complete each level within two years while working. The course will be made available in two modes -- hybrid

diploma course. The course has been designed focussing on areas like modern coaching, sports science, yogasana and leadership, and will equip the candidates to integrate with the sports ecosystem and enhance their professional

skills. The minister also said his ministry is in the process of making an annual calendar for approximately 15 games.

LAHORE, Feb 27: Eyeing a semifinal racked up a 350-plus total in their tourspot, Australia's historic pedigree in nament opener before the Aussies rode cricket's biggest tournaments will count for nothing when they run into an Afghanistan side that is fast cementing its place in the game's top table, in the Champions Trophy here on Friday.

Basking in the afterglow of their memorable win over England at the Gaddafi Stadium on Wednesday, Afghanistan have a realistic chance of making their second successive semifinals of a global event, less than a year after their entry into the last four stage of the T20 World Cup in the Americas.

On the other hand, a win for Australia will secure their passage to the semifinals of the tournament while eliminating Afghanistan with a game to spare.

However, it is easier said than done. For one, for all their firepower in batting, Australia are without their three leading fast bowlers in Mitchell Starc, Pat Cummins and Josh Hazlewood.

The trio's absence was felt as England

on Josh Inglis's counterattacking hundred to emerge victorious by five wickets and 15 balls to spare.

Two-time winners Australia are seeking to regain the Champions Trophy title after a gap of 15 years. They had won back-to-back titles in 2006 and 2009 but have failed to reach the finals in the 2013 and 2017 editions, after which the event was discontinued.

In the absence of their big fast bowlers, Australia know that their strength lies in batting with the likes of Travis Head, Steve Smith, Marnus Labuschagne and Glenn Maxwell capable of inflicting plenty of damage on the opposition bowling attack.

While there is no doubt the absence of regulars has weakened the team, it has also provided an opportunity for the young turks to impress, cement their place in the side, and carry forward the rich Australian legacy in marquee events.



Australia are expected to produce a people like Ben Dwarshuis, Spencer strong performance with the bat but for Johnson, Nathan Ellis, and Adam

Zampa, who will shoulder the responsibility with the ball in challenging conditions, they are aware that they will have to put their best foot forward if they are to progress from the group stage. Dwarshuis and Johnson were profligate against England (the match against South Africa was washed out), and they will look to make amends on Thursday, and in Zampa, Australia have a spinner capable of exploiting the conditions in

RAWALPINDI, Feb 27: Pakistan's campaign in the Champions Trophy ended on a winless note after their match against Bangladesh was called off without a ball being bowled due to incessant rain here on Thursday.

Persistent downpour left the ground soaked, with covers in place and puddles forming around the field. With weather not improving, match officials called off the game nearly two hours after the scheduled start time. The gloomy weather prevented even the toss from taking

Rajput has lauded the role of ICC in the development of cricket in these regions.

"I think we have got every support from them, that's why cricket is big here, if you look at it, we are getting a lot of matches which have been played in Dubai as well.

"I think cricket has been improving so much here because of the ICC as well. ICC's headquarter is also in Dubai, so it's a natural advantage for you."
