Talk to China to halt Brahmaputra dam project in Tibet: BJP member Saikia



NEW DELHI, Feb 10: BJP member Dilip Saikia on Monday urged the government to hold bilateral talks with China to halt the construction of a massive dam on river Yarlung Zangbo in Tibet which could put Arunachal Pradesh and Assam in

Raising the issue during Zero Hour in the Lok Sabha, Saikia said that the dam, described as the largest in the world, would put downstream regions such as northeastern India and Bangladesh in danger.

He said the site of the dam is an

The dam will put in danger the people and communities in the downstream region, including Arunachal Pradesh and Assam.

Last year, China approved plans to build a dam over the Brahmaputra River called Yarlung Zangbo in Tibet close to the Indian border.

As per the plan, the massive dam will be built at a huge gorge in the Himalayan reaches where the Brahmaputra makes a huge U-turn to flow into Arunachal Pradesh and then to Bangladesh.

The project, estimated to cost around USD 137 billion, is located in the ecologically fragile Himalayan region along a tectonic plate boundary where earthquakes occur frequently. Saikia said the dam will be able to store huge amounts of water which can be used to cause floods or drought in

The expedition, led by NIMAS director Col. Ranveer Singh Jamwal, began at Gelling village in Arunachal Pradesh and concluded at Hatsingimari in Assam. The journey was undertaken with sponsorship from the ministry of defence.

The expedition took a total of 28 days, involving 25 days of intense rafting and three days for equipment maintenance. The team navigated through some of the most challenging stretches of the Brahmaputra, including dangerous Class 4 and 5 rapids in Arunachal Pradesh, such as Ningging, Palsi, Tooth Fairy, and Kodak.

In the Assam leg, the team dealt with massive currents, unpredictable river dynamics, and vast stretches of the river, which presented a unique challenge in maintaining their course.

The team consisted of nine rafters and 14 administrative and support staff and also included local rafters from

Arunachal Pradesh and Assam who joined the team to navigate the river's challenging sections. During the expedition, the team interacted with local



communities living along the river, including indigenous

tribes such as the Memba, Adi, Mishing, and Bodo. These exchanges provided valuable insights into the region's rich cultural heritage and its close connection to the Brahmaputra River, the release added

The success of this journey highlights the potential of adventure tourism in India, particularly in the northeastern region and also showcases the resilience and determination of the team, which overcame significant challenges to accomplish a feat never before attempted, the release added

HIV infections could jump over 6 times if US support dropped, not replaced: UNAIDS chief



LONDON, Feb 10: The head of the UN AIDS agency said on Monday the number of new HIV infections could jump more than six times by 2029 if American support of the biggest AIDS programme is dropped, warning that millions of people could die and more resistant strains of the

disease could emerge. In an interview with The Associated Press, UNAIDS executive director Winnie Byanyima said HIV infections have been falling in recent years, with just 1.3 million new cases recorded in 2023, a 60 per cent decline since the virus peaked in 1995.

But since President Donald Trump's announcement the US would freeze all foreign assistance for 90 days, Byanyima said officials estimate that by 2029, there could be 8.7 million people newly infected with HIV, 6.3 million AIDSrelated deaths and an additional 3.4 million children made

"We will see a surge in this disease," Byanyima said, speaking from Uganda. "This will cost lives if the American government doesn't change its mind and maintain its leadership," she said, adding that it was not her place to criticise any government's policy. Byanyima pleaded with the Trump administration not

to abruptly cut off funding, which she said has resulted in "panic, fear and confusion" in many of the African countries hardest hit by AIDS. In one Kenyan county, she said 550 HIV workers were

immediately laid off, while thousands of others in Ethiopia

were terminated, leaving health officials unable to track the epidemic She noted that the loss of US funding to HIV programmes in some countries was catastrophic, with external funding, mostly from the US, accounting for about 90 per cent of their programmes. Nearly USD 400 million goes to countries like Uganda, Mozambique and Tanzania, she said. "We can work with (the Americans) on how to decrease their contribution if they wish to decrease it," she

said. Byanyima described the American withdrawal from

global HIV efforts as the second biggest crisis the field has

ever faced — after the years-long delay it took for poor countries to get the lifesaving antiretrovirals long available in rich countries. Byanyima also said the loss of American support in efforts to combat HIV was coming at another critical time, with the arrival of what she called "a magical prevention tool" known as lenacapavir, a twice-yearly shot that was shown to offer complete protection against HIV in women, and which worked nearly as well as for men. Widespread use of that shot, in addition to other interventions to stop HIV, could help end the disease as a public health problem in the next five years, Byanyima said. She also noted that

lenacapavir, sold as Sunlenca, was developed by the Amer-

Lymphatic Filariasis by 2027: Nadda **NEW DELHI, Feb 10:** The government is committed to making India Lymphatic Filariasis-free by 2027, Union Health Minister J P Nadda said on Monday while seeking active community involvement to achieve the goal.

Nadda was speaking at the launch of the nationwide Mass Drug Administration (MDA) campaign for Lymphatic Filariasis (LF) elimination through a video conference with state health ministers and senior officers of 13 identified LF endemic states.

The campaign covers 111 endemic districts across 13 states with door-to-door administration of filaria prevention medications.

Noting that Lymphatic Filariasis incapacitates people and deteriorates their quality of life, Nadda called for the implementation of a fivepronged strategy to ensure the disease is eliminated much ahead of the Sustainable Development Goal of 2030.

"From February 10 onward, these medicines will be made available free of cost to a population of over 17.5 crore across endemic districts. It is imperative that residents in these areas consume the medicines, protecting themselves and their families from this debilitating disease," he said. Highlighting the importance of achieving high coverage, he underlined, "the endemic districts must ensure that over 90 per cent of the

eligible population consume anti-filaria medicines. Our collective commitment and determination will help transform lives and ensure a future free from Lymphatic Filariasis.'

He urged the states and UTs to monitor the campaign at a state level to ensure early diagnosis of affected people and also sought personal involvement of the political and administrative leadership at the identified state/district levels for the same.

The Union minister emphasised the importance of adopting a whole-of-government approach by engaging various ministries and departments to support campaign activities. He highlighted that this integrated approach, coupled with high-level advocacy across allied ministries,

Nadda also said that efforts are underway to integrate MMDP services fully in Ayushman Arogya Mandir (AAM) facilities for access to better self-care and added that approximately 50 per cent lymphodema cases receive Morbidity Management and Disability Preventaion (MMDP) kits annually. He stated that under NHM, there is provision for hydrocelectomy surgeries and PMJAY scheme also has option of hydrocelectomy for beneficiaries.

Close to 50 per cent hydrocele surgeries were conducted in endemic states in 2024, he added. He highlighted that through these efforts, Arogya Mandirs would help in reducing the burden of LF, allowing affected individuals to lead healthier lives and promoting the vision of a dis-

ease-free India. "India has and will continue to remain steadfast in its commitment to eliminate Lymphatic Filariasis. Our resolve is to achieve that target by 2027", he said while noting it is a last minute challenge. LF, commonly known as "Hathi Paon," is a parasitic disease transmitted by infected mosquitoes. It can lead to physical disabilities such as lymphoedema (swelling of the limbs) and hydrocele (scrotal swelling) and impose long-term burdens on affected individuals and families. (PTI)

"Our vision has always been to maintain the trust we have developed over the years. Growth is important, but it must be sustainable," Kaur said.

Amid rising competition and ongoing consolidation in the paint industry, Kaur said Berger Paints has well-defined strategies in place to navigate market dynamics.

Kaur emphasised that Berger Paints is not focused on chasing volume numbers or engaging in a race to be the largest player in the industry. "We don't have any such ego that we must be number one or

number two. Our priority is to stick to our planned targets and budgets. As long as we meet our own growth objectives, we are satisfied," she asserted.

The company had earlier announced plans to double its turnover to ₹20,000 crore by 2030. Kaur reaffirmed this target while maintaining a cautious approach toward inorganic growth.

Meanwhile, Berger Paints managing director & CEO Abhijit Roy, on the occasion of the inauguration of the company's new headquarters in New Town, said that there has been a recovery in the value loss of about 11 per cent faced over the last few quarters. "The price cut impact of 5 per cent last year has been mitigated. The slowdown impact loss of 3 per cent will be recovered with a consumer-centric budget," he said. He further stated that the company is expanding despite rising competition and will invest ₹ 2,000 crore in three new projects in Panagarh (West Bengal), Odisha, and Andhra Pradesh. Gold surges ₹ 2,430 to hit lifetime high of ₹ 88,500 per 10g amid Trump's tariff threats

NEW DELHI, Feb 10: Gold prices zoomed by ₹ 2,430 to hit a lifetime high of ₹88,500 per 10 grams in the national capital on Monday following firm global trends and a weak rupee, according to the All India Sarafa Association.

The precious metal breached the record USD 2,900 an ounce level in spot markets globally after US President Donald Trump announced imposition of fresh 25 per cent tariffs on all steel and aluminum imports to the US.

Heavy buying by jewellers and retailers also boosted the prices.

The precious metal of 99.9 per cent purity had settled at ₹86,070 per 10 grams last week.

Gold of 99.5 per cent purity surged by ₹ 2,430 to hit a record high of ₹88,100 per 10 grams in the local Silver prices increased ₹ 1,000 to ₹ 97,500 per kg.

Investors are dumping riskier assets like stocks as they prefer safe haven amid global economic uncertainties, traders said.

In futures trade on the MCX, gold contracts for April delivery rallied ₹ 940 to hit a new lifetime high of ₹85,828 per 10 grams.

"Gold witnessed strong gains, surging above Rs 85,800 in MCX and hitting USD 2,900 in spot markets as Trump's new round of tariffs on metal products

intensified trade war concerns. 'With no specific clarity on which countries are included or excluded, uncertainty in global trade has driven significant bullion buying," Jateen Trivedi, VP research analyst - Commodity and Currency, LKP Se-

curities, said. The subsequent contract for June delivery surged ₹ 1,015 or 1.18 per cent to hit a fresh peak of ₹ 86,636

Silver futures for March delivery climbed ₹ 632 to ₹ 95,965 per kg on the Multi Commodity Exchange



(MCX). Globally, Comex gold futures appreciated by USD 45.09 per ounce or 1.56 per cent to hit a record high of USD 2,932.69 per ounce. Meanwhile, spot gold in the global markets breached the psychological level of USD 2,900-mark.

"Gold climbed to a new record high on Monday as fund flow increased towards the safe haven asset in response to President Trump's latest declaration," Saumil Gandhi, senior analyst of Commodities at HDFC Securities, said.

Comex silver futures in the Asian market hours rose

nearly 1 per cent to USD 32.76 per ounce. According to a report by Dutch multinational ING Bank, gold has already hit a series of fresh record highs this year. Tariff concerns that risk higher inflation and slower economic growth are spurring demand for safe haven assets.

The precious metal prices will hit more record highs this year, with USD 3,000 per ounce now in sight, it

LS witnesses heated debate

BJP MP Anurag Thakur hailed the budget a "force multiplier". "Rahul Gandhi is calling the budget a 'bandaid budget'. I want to tell him that this is not a band-aid budget but a 'booster shot' budget. It is a force multiplier...," he said. The Hamirpur MP spoke about the measures taken by the government to enable start-ups in

the country and alleged that Congress is busy with "its own start-up".

"How many times it has been launched...," he said, taking a dig at Congress leaders. NCP MP Supriya Sule welcomed the tax rebate but maintained that "all is not well". "I urge this government that all is not good, the economy is slowing down, you have given a good tax rebate I welcome that but at the same time, I am not sure that it is going to deliver superior results as the government is expecting.

"I request the government to introspect... just winning elections does not mean all is well," Sule said.

TMC leader Kalyan Banerjee alleged that the budget was anti-people and destructive for the country's economy. He also opposed the proposal to increase the foreign direct investment (FDI) limit in the insurance sector. "The budget ignores the immediate challenges of growing unemployment, inflation and inequality," he said adding the income tax benefit will help only a limited number of people.

He also accused the Centre of neglecting West Bengal. "If you ignore us, the West Bengal people will give answers in 2026 (assembly elections)," he said. Aam Aadmi Party MP Gurmeet Singh Meet Hayer accused the Central Government of ignoring Punjab's farmers. The Sangrur MP said that the government has miserably failed in areas like per capita income, GDP and the depreciating value of the rupee against the dollar. He pointed out that India lags significantly in per capita income.

"In India, the income of only a handful of people has increased, while the general population's income growth has been negligible. The condition of the common man is aptly described by the saying 'amdani athani, kharcha rupaiya'," he said. Mocking the income tax slab, he remarked that the vast majority of the country's population is entirely excluded from its benefits.

Commenting on the depreciating rupee value, Hayer sarcastically noted that BJP leaders used to say 10 years ago that the "rupee is in the ICU" but now under their rule, the rupee's condition against the dollar is at its weakest. Igra Choudhary (SP) said that the budget is only a headline-grabbing document as it has neglected.

"It is not an inclusive Budget," she said adding no steps have been taken to reduce unemployment. She demanded an increase of MPLAD funds from ₹5 crore to ₹25 crore. Congress MP Amrinder Singh Raja Warring said that the budget would only help the rich and was election-centric. He demanded an increase in wages under MNREGA to ₹ 600 and a legal guarantee of 200 days of wage employment. (PTI)

According to a report of the one-man Nanavati Commission, formed to probe the violence, there were 587 FIRs registered in Delhi in relation to the 1984 riots that witnessed 2,733 people being killed. Of the total, the police shut about 240 cases as "untraced" and about 250 cases resulted in acquittals.

However, it was only in May 2023 that the central probe agency the CBI filed a chargesheet against Congress leader Jagdish Tytler for his alleged role in the killings of three people on November 1, 1984. The CBI alleged Tytler "incited, instigated and provoked the mob assembled at Pul Bangash Gurdwara Azad Market area in the national capital on November 1, 1984. The incident resulted in the burning down of the gurdwara and killing of Thakur Singh, Badal Singh and Guru Charan Singh. (PTI)

The training was organised by the field directorate, Manas Tiger Reserve and Wildlife Trust of India (WTI) and International Fund for Animal Welfare (IFAW) to minimise the knowledge gaps among the investigating officers and to update them on relevant sections of Bharatiya Nagarik Surakha Sanhita, 2023 (BNSS), Bharatiya Nyaya Sanhita, 2023 (BNS) and Bharatiya Sakshya Adhiniyam, 2023 (BSA) and the Wild Life (Protection) Act, 1972 as amended upto 2022.

The roots of this program date back to April 2011, when WTI first introduced a law enforcement training focused specifically at Manas Tiger Reserve, jointly with Assam Forest Department.

Over the years, the initiative has evolved into a comprehensive training series.

By December 2024, a total of 754 officers belonging to frontline forest staff participated in 30 batches of fresher, refresher and advanced training held in various parts of Manas Tiger Reserve that also included 10 days of special training in Kaziranga NP and Orang NP.

"The training is a part of our continuous process to enhance the skills of our Investigating Officers in order to build their capacity and knowledge on the procedural changes as per the latest amendments including the relevant sections of criminal laws and procedures. Delhi results and future of INDIA bloc

he victory of the BJP in the Delhi assembly elections defeating the ruling Aam Aadmi Party (AAP) convincingly is certainly a jolt to the opposition INDIA bloc, but it does not mean the end of AAP, or the final tolls for the INDIA bloc, as some commentators in the national media and the TV channels are projecting it to be. Those who have studied the mood of the Delhi electorate knew that in the 2025 elections, things would be much tougher for the AAP to retain power by defeating the BJP, as there was anti-incumbency after full two terms of Delhi's ruling party. The final clincher was the big income tax relief in the 2025-26 Union budget announced on February 1, four days before the polls, and the earlier announcement on the setting up of the eighth pay commission for the central government employees. The verdict favouring BJP was precipitated by the salaried middle classes of Delhi, who constitute majority of the 1.56 crore Delhi electorate. There were direct cash benefits to them. That certainly had an immediate impact on the polling day a few days later. But still, the voting figures show that the fight was not one-way; rather, it was a bitter battle. BJP got 45.56 per cent of the votes, while AAP secured 43.57 per cent, meaning a difference of only 2 per cent, though in seat terms, BJP got 48 and AAP only 22. Further, taking both the INDIA bloc parties AAP and Con-

gress votes together, the AAP-Congress combine got nearly 50 per cent of the votes and in terms of seats, 14 more seats would have come to the INDIA bloc kitty if there were an alliance. This means that INDIA bloc could have had a narrow victory by getting 36 out of the total of 70 seats, if there had been an alliance of the AAP and the Congress. Further, the AAP retained its base of Dalits, poor and Muslims, as the analysis of the constituency-wise voting patterns showed. The verdict was the result of a major middle class shift from AAP to BJP on the polling day, while the poor stood more or less by the AAP and the Congress.

So, the lesson is that both AAP and the Congress mishandled the alliance issue before the assembly polls. They should have worked out some understanding on seat-sharing before the assembly elections, taking into account the success of the BJP in the earlier assembly polls in Haryana and Maharashtra. Since this did not take place, the best thing for the AAP and the Congress now would be to assess the ground situation with objectivity and prepare for the next round to take on the BJP. AAP has conceded defeat and Arvind Kejriwal has promised to work as the responsible opposition. That is the perfect democratic approach in a vibrant parliamentary system. Now let us look at the emerging political situation. It is high time the INDIA bloc parties convene a meeting and decide on the new line of leadership. Rahul Gandhi remains the LoP and the Congress always remains the biggest constituent of the INDIA

Growing pressure on Dr. Yunus for early elections

hen Sheikh Hasina came to power, the new gener-ation (Gen Z) had not seen free, fair, and inclusive elections since 2008. Election observers described the parliament elections under her 15-year autocratic regime as fraud, and the poll results were cropped.

The international media had widely reported how elections in Bangladesh in 2014, 2018, and 2024 were held under the cover of darkness, keeping thousands of opposition leaders and members in

The rights organizations repeatedly made loud noise, but Hasina ignored their calls to hold free and fair elections. Instead, she was beating African drums that the country belongs to her father Sheikh Mujibur Rahman, who was ordained as the architect of Bangladesh's independence signalling she has the right the govern with an iron hand.

Amid cheering crowds, she often boasted that her father had made the country independent and was known as Bangabandhu (Friend of Bangladesh). Otherwise, she explained, the nation would have been subjugated by Pakistan's military establishment, making them second-class citi-

Nobel laureate Prof Muhammad Yunus took charge of an Interim Government backed by defiant student leaders and the military after they forced the Iron Lady (Hasina) to abdicate her power and flee to India, where she is living in exile.

The political parties except the Islamist party Jamaat-e-Islami have demanded an election at the soonest, indicating before the end of this year. Yunus charted a path to reforms to establish pluralism, democracy, and human rights, he announced in an address to the nation that several commissions suggested reforms to key state organs.

He conveyed to the political leaders that the elections would be held only after the reforms on Electoral System, Constitution, Public Administration, Judiciary, Financial Institutions, Media, Police Administration, and Anti-Corruption were made effective. The political parties and civil society



When military dictator General Muhammad Ershad was ousted by students backed by the military in 1990, the mainstream opposition parties signed an election pledge prepared by the student leaders. The opposition leaders promised to implement the reforms in key state organs

Sheikh Hasina, Khaleda Zia, and the Left Alliance jointly signed a tripartite political commitment that they will implement the reforms after winning the elections. Unfortunately, both the Begums went to power again and again but they deliberately avoided implementing the pro-people pledge.

After decades of bad governance, poor accountability and transparency, Yunus is determined to see a new Bangladesh, which adheres to the principles of international covenants to put the country at a respectable height on the world stage.

The reforms are supposed to guarantee democracy, pluralism, accountability, transparency, independence of the judiciary, independent election commission, freedom of expression, press freedom, and human rights. He has reiterated that the elections will be held once the reforms have taken off the ground zero.

Most political scientists and think tanks believe that the political parties would agree not to disagree. Later the politicians, when elected, the painstakingly homework for reforms would be binned. For more than five decades the political parties that ruled the nation

times reacted very violently.

The politicians publicly flouted the rule of law, punished the journalists for exposing their corrupignored tion, and accountability of elected representatives of public offices. They often coerced police and judiciary to ensure that their blue-eyed boys were kept out of prison for extortion from traders and protection money from industrialists, while their rivals were severely punished and blocked from politics.

The visible challenges in front of Yunus are acting as a stumbling block in the accountability of bureaucracy, judiciary and law and order situation. The police are unable to restore lawlessness and control price hikes in kitchen mar-

There is no guarantee clause to be signed by politicians, that the reforms should be taken into cognizance in "good faith" by the 'untamed' political parties. Yunus told in an interview with an editor of a Bangladesh newspaper that the leaders of the political parties when they held parleys with him were polite and humble.

However, when they spoke to the journalists, they gave a different statement which they did not put on the table of discussion with the Chief Adviser of the Interim Government. It is strange but it is a fact, he told the editor.

The recent spree of vandalism and demolition of the Bangabandhu Museum, the former residence of the first President of Bangladesh, Sheikh Mujibur Rahman on 5 February. Students went

berserk in several cities and towns dence in Dhaka in the looting and arson of Awami League senior leaders, who were deemed icons of accomplices to autocratic Hasina's misrule.

The Chief Adviser in a tone of warning that certain groups are pushing the nation into anarchy and lawlessness. The inventor of micro-credit Prof Yunus calls on all citizens "to immediately restore complete law and order and to ensure there will be no further attacks on properties" associated with the family of the ousted Sheikh Hasina and politicians of the fascist Awami League party or against any citizen on any pretext.

He, however, said the outrage has sparked from her (Hasina) refuge in New Delhi, and from there she continues to mobilize her militants to hamper Bangladesh's recovery from years of abuse under her 15-year rule.

If any attempt is made to destabilize the country through any kind of provocative activities, law enforcement agencies will immediately take strict action against anyone acting to create chaos and anarchy, which includes the destruction of property. The government will bring the responsible individuals and groups to justice, he stated.

While the vandalism and looting, the law enforcement agencies were playing as silent spectators when the mobs were rioting. Several civil society, rights, and citizens groups strongly condemned the vandalism, arson, and looting of family members of Hasina and Awami League leaders.

Celebrated feminist Bangladeshi writer Taslima Nasreen, who lives in exile in India, has called the demolition of Sheikh Mujib's residence an act of "Islamic terror-

The Jamaat-e-Islami Ameer Dr Shafiqur Rahman said "If the ongoing madness does not stop, Bangladesh will be heading towards civil war." While, the Bangladesh Nationalist Party (BNP) said in a statement that they will hold talks with Chief Adviser Prof Muhammad Yunus as soon as possible to express their concern over the country's "deteriorating" law and order situation, especially the demolition of Bangabandhu Sheikh Mujibur Rahman's resi-

They fear that these attacks and vandalism in the last two days could pose a serious threat to national stability and disrupt the upcoming national election, a BNP statement said. It is understood that on the issue of appalling law and order status, the political parties will press Yunus to hold elections in the coming winter.

Most political analysts argue that Yunus may not agree to their demand for an early election, unless the reforms get tacit approval from all political parties, except for the former ruling party Awami League. Most of the like-minded political parties, except the Islamist parties, are lisping the same jargon as the BNP's political agenda of early election.

Will an election roadmap neutralize the political crisis? Writer and researcher on political history Mohiuddin Ahmad does not believe that the situation will improve; rather, it may worsen.

Most political parties have extended their support to the Interim Government led by Prof Yunus. However, they argue that in the last six months, the government has failed in various areas, including controlling the price of daily essentials and improving the law and order situation

As a result, there are doubts about their ability to control any situation in the country. The last two days of vandalism have added to the crisis of confidence. Ahmad remarked that if the government announces an election roadmap, there will be a further crisis when local party leaders clash with rivals in electioneering.

The government and mainstream political parties should focus on the country's image and stability. Because if there is no stability, everything including democracy and elections will suffer, said political scientist Professor Mahbub Ullah to BBC Bangla Service. UK's counter-extremism remit to include Hindutva

ith the new Labour government in the UK led by Keir Starmer taking over, it was expected that the government will amaging extremist beliefs and the FCDO.

The UK-based Muslim organisations in the past had described Prevent as an undue intrusion in their undo some key policies of the earlier Conservative governments and have a relook at how the policies or programmes started by it, were given a fresh-up.

However, the last week of January witnessed confusion around the future direction of the UK government's counter-extremism strategy, as Home Office ministers were forced to reject the conclusions of a leaked internal review which called for a focus on "behaviours and activity of concern" rather than ideology.

An analysis of different parts of the report calling for the scope of counter-extremism work to be widened to cover a range of causes and activities including Hindutva (Hindu nationalism), Sikh extremism, extreme misogyny, and a fascination with violence, were published by Policy Exchange, a right-wing think tank. So far, the report has not been made public and only its analysis by Policy Exchange has gained traction.

Reportedly, Home Secretary Yvette Cooper did not agree with the recommendations of her own department's review and thus may order the focus of the policy to remain directed towards Islamist and far-right extrem-

UK introduced its Prevent policy in 2003 as part of an overall post 9/11 counter-terrorism approach called CONTEST, with the aim of preventing the radicalisation of individuals to

Successive British governments have long grappled with legal definitions of extremism, which human rights groups have warned, pose a serious threat to freedom of speech and freedom of belief.

However, one wonders at the alacrity with which the Labour Government and Cooper reacted to the alleged inclusion of Hindutya – as an ideology responsible for stoking violence in the UK. The reason is not hard to fathom, post-Brexit, UK has been striving hard to finalise a Free Trade Agreement (FTA) with India, so far 15 rounds of bilateral talks have been held to finalise the agreement. For the Labour Government, signing the FTA with India is the top most priority, and it would not like to cause any upset and annoy the right-wing government in India, putting the signing of the FTA at risk.

Further, the Home Office review warns that "narrow definitions (of extremism) ... predicated on violence, movements and associated harms that may warrant intervention."

The review nonetheless marks the first time that Hindutva has been discussed in detail in a major policy document. Examples of extremist beliefs which it cites include Hindutva. which the review notes played a "significant role" in inflaming tensions between Hindus and Muslims in Leicester in 2022, and "pro-Khalistan extremism", or calls for an independent Sikh state.

This is also the first time that a government document has linked Hindu nationalism to the Leicester riots, although a Daily Mail report in May 2023 quoted unnamed security sources as saying that the violence was stoked by activists linked to India's ruling Bharatiya Janata Party

According to the London-based institute Middle East Eye (MEE), Policv Exchange has been credited with shaping the direction towards counter-extremism taken by previous Conservative governments, and has been accused of promoting "hostility towards British Muslims", which it

Policy Exchange has warned that the review's "playing down of ideology in general, and Islamism in particular" risked becoming a "major victory" for critics of the Prevent programme. According to Policy Exchange's report, the review says that a full counter-extremism strategy will be published next year.

Further, Policy Exchange recommends that responsibility for counterextremism be shifted to the Home Office from the Ministry of Housing, Communities and Local Government. It also called for counter-extremism work to be delivered by a standalone team within the Prevent Directorate, which should be renamed the Prevent and Counter-Extremism Directorate.

It also calls for the creation of a Ministerial Counter-Extremism Board, attended by ministers, security officials and representatives from the MI5 and GCHQ intelligence agencies. Other members of the board, according to the Policy Exchange report, include the controversial Robin Simcox, head of the Commission for Countering Extremism.

The UK government's PREVENT programme has always remained contentious, based on its remit shared by several ministries including DCLG, Home Office and the FCDO.

vent as an undue intrusion in their working and treating the Muslim community as a pariah. While, on the other hand there was obviously no resource sharing or even lessons learned sharing between the different

A prudent decision earlier should have entrusted the work of building trust and relationship with the Muslim community, in the UK to the DCLG – a ministry which has deep rooted links with various communities in the UK, through a vast network of its counsellors and other professionals, who better understand the concerns and aspirations of different communities present in the UK, as they engage with them on a daily

But instead, the lion's share of the work was given to the Home Office, which with its darkened lenses could not view or understand the problems faced by the Muslim community and their efforts towards better assimilation with-in the British society, but as one related to violence and terrorthemed work only, linking everything with extremist Islamic ideologies being propagated from abroad.

Further, the FCDO in its own skewed way of working, focussed on bringing-in the saner elements from the Arab world, instead of India, to further its objective of portraving a positive image of the British Muslims supported through various government initiatives abroad, but failed to engage properly with those elements, which could have worked more effectively with the FCDO's and Home Office's overarching objectives, both within and outside the UK

In the current circumstances, it would be prudent if the FCDO could try to rope-in the secular Hindu leaders, based in India, to address the concerns of the Hindu community in the UK, instead of letting the flashpoints simmering below the surface. Additionally, it would be prudent to ropein the saner elements from India, as the genesis of Hindutya started in India and only India could help the British government and officials to tame this growing menace, pragmatically and prudently. Digestion: How the body breaks down food

The human digestive system refers to the organs that take in food and break them down. Digestion describes the complex process that enables the nutrients in food to enter the body and its cells.

Food contains all of the nutrients a person's body needs for health, but large, complex compounds bind them. During digestion, the body breaks these compounds down into smaller parts. This enables them to enter cells, providing energy and other benefits

This article explains how the body digests food from when it enters the mouth to when it exits the body. It also suggests some tips for healthy digestion and how to identify problems. What is digestion?

The human gastrointestinal tract, also called the alimentary canal, is around 30 feet (9 meters) long in

It consists of the following:

- the mouth, or oral cavity
- the esophagus · the stomach
- the small intestine
- the large intestine, or colon

In addition, the following organs support digestion, for example, by chewing or adding enzymes and other secretions that enable the body to absorb nutrients:

- the teeth
- the tongue • the salivary glands
- the liver
- the pancreas • the gallbladder

Together, these organs provide mechanical processing, the secretion of enzymes and bile to help break down compounds, and the excretion of

Some terms to describe these

functions include:

· ingestion, which includes chewing and swallowing

the secretion of substances that enable food and nutrients to move through the body effectively

 propulsion, where muscles move the contents of the canal forward

• digestion, the breakdown of food, for example, through chewing and secretions

• the absorption of nutrients, which mainly occurs in the small intestine

· defecation and urination, the removal of waste products through the rectum and the bladder, respectively

The mouth

Digestion begins even before the food enters the mouth. When a person smells or thinks of food or eating, the salivary glands begin producing

Once the food is inside of the mouth:

- · saliva moistens it.
- the teeth and tongue break it down mechanically.
- an enzyme in the saliva, salivary amylase, breaks it down into starch. Chewing and amylase digestion will convert the food into a small,

round blob, or bolus. This enables a

person to swallow it easily. The esophagus

After swallowing, the bolus enters the esophagus, where gravity and muscle contractions help move it down to the stomach through a process called peristalsis.

Peristalsis is the slow contraction of smooth muscles along and around the digestive system. As the bolus moves through the esophagus, these contractions push it toward the stomach.

What is esophageal achalasia, and how does it affect digestion?

The stomach The bolus enters the stomach

through a ring-like muscle called the lower esophageal sphincter. This

sphincter relaxes, allowing the bolus to enter the stomach.

In the stomach, the following processes occur:

The stomach stores the food temporarily

Cells in the stomach secrete gastric juices. These include hydrochloric acid, which maintains the pH of the stomach between 1.5-2.0.

The stomach has three muscular layers that churn and mix its contents. These processes turn the food into

a thick paste, known as chyme.

Hydrochloric acid is essential for: · destroying microorganisms, such

as bacteria • breaking down proteins and plant

• activating pepsin, an enzyme that

helps digest proteins The acid, however, can harm the stomach lining, so some cells produce mucus to protect the lining from dam-

The stomach does not absorb many nutrients from the chyme into the bloodstream, so the chyme enters the small intestine through the pyloric sphincter.

The small intestine

The small intestine is around 20 ft (6 m) long and absorbs around 90% of the nutrients from food into the bloodstream.

There are three sections:

• The duodenum: This receives chyme from the stomach and digestive enzymes from the liver and pan-

• The jejunum: Most of the chemical digestion and absorption occur here. • The ileum: This contains the ileocecal valve, a sphincter through

which food passes to the large intes-Once the food is fully broken down, the villi absorb the nutrients,

which enter the bloodstream Villi are tiny, finger-like projections that line the walls of the small intestine. Within the villi are tiny capillaries called lacteals. By increasing their surface area, the villi maximize their absorption of nutrients.

How do the intestines work? The large intestine

Any unabsorbed food and nutrients now pass to the large intestine, or colon. The material is now feces.

The large intestine is around 6 ft (2 m) long and consists of the: cecum, a pouch through which food

- enters from the small intestine
- ascending colon transverse colon
- descending colon
- sigmoid colon
- From the large intestine, the body absorbs water and electrolytes.

Food travels slowly through the colon to allow the body to absorb water, and trillions of gut bacteria break down any undigested food.

Next, peristalsis moves the feces toward the rectum.

The rectum

As the digested food moves into the rectum, nerves in the wall of the rectum known as stretch receptors detect when the chamber is full and stimulate the desire to defecate

Defecation involves two types of muscle movement.

The first happens automatically, and a person cannot control it. This is a relaxation of the smooth muscles in the internal anal sphincter.

The second, a person can control and is a conscious relaxation of the skeletal muscles in the external anal sphincter. If a person wishes to delay defection, they can avoid relaxing their muscles to move the feces back into the colon.

The longer feces stay in the colon, the more water the body will absorb. This can lead to dry, hard feces, constipation, and possibly impaction. For this reason, a person should defecate as soon as is convenient.

A person should seek medical advice if they are unable to defecate for about 3 days or if they have abdominal or rectal pain or bleeding.

How does digestion work, step-by-

First, the teeth, tongue, and saliva turn food into a bolus, which is small and liquid enough to pass through the esophagus.

Next, the bolus enters the stomach, where muscular action, acids, and enzymes turn it into a paste called chyme. The chyme enters the small

intestine. Here, about 90% of absorption occurs. Nutrients enter the bloodstream through capillaries in villi. From there, the nutrients travel to various body cells. Any remaining food passes into the large intestine, or

The body absorbs water as the food passes through to the rectum, ready for defecation.

How can I keep my digestion healthy?

Tips include:

• drinking plenty of water

• eating a varied diet with plenty of fresh vegetables and whole foods

• establishing regular bowel habits • seeking medical help for any unexplained changes in digestion or

SPHEREx: NASA's new eye on the Universe

new space SPHEREx, is an exciting project that will help scientists learn more about the universe. It is designed to study the sky in a unique way, gathering information that will help answer some of the biggest questions about space. SPHEREx stands for Spectro-Photometer for the History of the Universe, Epoch of Reionization, and Ices Explorer. 

US to impose 25 per cent tariffs on all steel and aluminum imports

dent Donald Trump said he will announce on Monday that the United States will impose 25 per cent tariffs on all steel and aluminum imports, including from Canada and Mexico, as well as other import duties later in the week.

"Any steel coming into the United States is going to have a 25 per cent tariff," he told reporters Sunday on Air Force One as he flew from Florida to New Orleans to attend the Super Bowl. When asked about aluminum, he responded, "aluminum, too" will be subject to the trade penalties.

Trump also reaffirmed that he would announce "reciprocal tariffs" — "probably Tuesday or Wednesday" — meaning that the US would impose import duties on products in cases where another country has levied duties on US

"If they are charging us 130 per cent and we're charging them nothing, it's not going to stay that way," he told reporters.

Trump's comments are the latest example of his willingness to threaten, and in some cases to im-



ing much earlier in his presidency than during his previous four years in the White House, when he pri-

oritised tax cuts and deregulation. Trump has alternately said he sees import taxes as tools to force concessions on issues such as immigration, but also as a source of revenue to help close the government's budget deficit.

Financial markets fell on Friday after Trump first said he would impose the reciprocal tariffs. Stock prices also dropped after a measure of consumer sentiment declined on Friday, largely because many respondents cited tariffs as a growing

The survey also found that Americans are expecting inflation to tick up in the coming months because of the duties.

Trump on Sunday did not offer any details about the steel and aluminum duties, or the reciprocal tariffs. Trump previously threatened 25 per cent import taxes on all goods from Canada and Mexico, though he paused them for 30 days barely a week ago. At the same time, he proceeded to add 10 per cent duties on imports from China.

Yet on Friday, he said he would also delay the tariffs on the millions of small packages — often from fast-fashion firms such as officials can figure out ways to impose them. The small packages have previously been exempt from

Trump's latest remarks stirred immediate worry from some global trading partners.

South Korea's acting president, Choi Sang-mok, called a meeting with the country's top foreign policy and trade officials on Monday to examine how Trump's proposed tariffs on steel and aluminum would affect its industries.

The office of Choi, who also serves as the country's finance minister, said officials discussed the potential impact and Seoul's possible responses, but specific details of the meeting were not disclosed. The stock prices of major South Korean steelmakers, including POSCO and Hyundai Steel, dropped as the market opened on

South Korea shipped about USD 4.8 billion worth of steel to the United States from January to November last year, which accounted for 14 per cent of its global exports of the products during the period. (AP)

Dawn News reported that Pakistan committed to strengthening institutional capacities with the IMF in October to fight corruption, support inclusive growth, and provide a level playing field for businesses and investments.

As a result, the ministry said a structural benchmark had been set to publish a report on the Governance and Corruption Diagnostic Assessment (GCDA) by July 2025, which will analyse critical governance and corruption vulnerabilities and identify priority structural reforms moving forward.

Sources said the mission would also engage with leading members of the superior judiciary besides the leadership of the financial, revenue, and election bodies to review their

The mission will examine the severity of corruption vulnerabilities across six core state functions, including fiscal governance, central bank governance and operations, financial sector oversight, market regulation, rule of law, and antimoney laundering and counter-fi-

The IMF team will engage with the Finance Division, the Federal Board of Revenue, the State Bank of Pakistan, the Auditor General of Pakistan, the Securities and Exchange Commission of Pakistan, the Election Commission of Pakistan, and the Ministry of Law and

It said the GCDA report will recommend actions for addressing corvulnerabilities strengthening integrity and governance, which will assist the government in bringing about reforms for promoting transparency, strengthening institutional capacities, and achieving inclusive and sustainable economic growth.

The finance ministry said the IMF had long provided advice and technical assistance that helped foster good governance, including promoting public sector transparency and accountability.

Traditionally the IMF's main focus had been encouraging countries to correct macroeconomic imbalances, reduce inflation, and undertake key trade, exchange, and other market reforms needed to improve efficiency and support sustained economic growth.

In 1997, the IMF adopted a policy on addressing economic governance, embodied in the Guidance Note on the Role of the IMF in Governance Issues.

To further strengthen the implementation of this policy, the IMF adopted in 2018 a new Framework for Enhanced Engagement on Governance (Governance Policy) to promote more systematic, effective, candid, and evenhanded engagement with member countries regarding governance vulnerabilities.

Under this policy framework, the IMF offers to undertake GCDA with member countries to analyse and recommend actions for addressing corruption vulnerabilities and strengthening integrity and governance in its member coun-

Following the analysis, GCDAs prioritise and sequence recommendations for systematically addressing the vulnerabilities. Since 2018, as many as 20 GCDA reports have been finalised and include Sri Lanka, Mauritania, Cameroon, Zambia, and Benin. Ten diagnostics are ongoing, and several are under consideration.

As part of its commitment to strengthening the capacity of relevant institutions to fight corruption to support inclusive growth and provide a level playing field for businesses and investments. Pakistan is also required to publish the complete UN Convention against Corruption Review Report immediately after the review process is completed.

The government has also committed, subject to the Supreme Court clearance, to consider enacting legislative amendments, if re-Accountability Bureau (NAB) Ordinance to strengthen the NAB's independence and effectiveness and empower the Provincial Anti-Corruption Establishments under the law to investigate money laundering related to corruption offences within their jurisdiction.

It will also allow them to request and receive financial intelligence from the Financial Monitoring Unit (FMU) as an investigating agency under the AML Act, and have sufficient resources and training to conparallel investigations. (PTI)

Pakistani lawyers stage protest against high-level meeting of constitutional body to pick eight SC judges

ISLAMABAD. Feb 10: Hundreds of lawyers on Monday staged protests in Pakistan's national capital against a high-level meeting of a constitutional body with the agenda to appoint at least eight judges of the Supreme Court.

The Judicial Commission of Pakistan (JCP) meeting was being held despite opposition by four apex court judges, the legal fraternity, resistance by opposition the Pakistan Tehreek-e-Insaf and controversy over the recent transfer of judges to the Islamabad High Court (IHC), which was opposed by five IHC judges.

The JCP, a top body empowered to approve judicial appointments, will finalise appointments for eight vacant Supreme Court judges.

Lawyers gathered at various locations in Islamabad, with the Lawyers' Action Committee staging a protest near D-Chowk. But police responded by closing several key entry points to the Red Zone, which houses key buildings, including the Supreme Court.

ing the 26th Amendment and demanding the cancellation of the JCP meeting

They also announced on Feb 3 to protest against the transfer of three high court judges to the IHC but it could not elicit a widespread response. The Karachi Bar Association had supported the strike call by staying away.

Last month, the Lahore High Court Bar Association (LHCBA) moved an application before the apex court through Advocate Muhammad Waqar Rana, seeking postponement of the JCP

The JCP earlier this month asked all high courts to send a list of five senior judges from each for consideration for the appointment of eight of them to the Supreme Court.

Initially, the IHC had forwarded the names of three judges Chief Justice Aamer Farooq, Justice Mohsin Akhtar Kayani and Justice Miangul Hassan Aurangzeb to the JCP because Justices Tariq Mehmood Jahangiri and Babar Sattar did not meet the minimum requirement of five years

Indian restaurants among targets accused of trying to kill Salman Rushdie of UK 'blitz' against illegal migrants

LONDON, Feb 10: Indian restaurants, nail bars, convenience stores, and car washes were among the targets of what the Home Office on Monday described as a "UK-wide blitz" on illegal working in the coun-

Home Secretary Yvette Cooper said her department's Immigration Enforcement teams had a recordbreaking January as they descended on 828 premises -- a 48 per cent rise compared to the previous January, with arrests surging to 609, and marking a 73 per cent increase from the previous year. The Home Office said that while its teams respond to illegal working intelligence in all sectors, a significant proportion of last month's activity took place at restaurants, takeaways and cafes as well as in the food, drink and tobacco industry.

A visit to one Indian restaurant in Humberside, northern England, alone led to seven arrests and four deten-

"The immigration rules must be respected and enforced. For far too long, employers have been able to take on and exploit illegal migrants and too many people have been able to arrive and work illegally with no enforcement action ever taken," said

"Not only does this create a dan-

gerous draw for people to risk their lives by crossing the Channel in a small boat, but it results in the abuse of vulnerable people, the immigration system, and our economy," she said. It comes as the Labour Party government's Border Security, Asylum

and Immigration Bill returns to Parliament for its second reading this week. The new legislation aims to "smash the criminal gangs" that Prime Minister Keir Starmer-led administration says undermines border security.

Further Home Office statistics claim that between July 5 last year and January 31 this year, illegal working crackdowns and arrests have soared by around 38 per cent compared to the same period 12 months prior. A total of 1,090 civil penalty notices have been issued during that phase, with employers facing a fine of up to GBP 60,000 per worker if found liable

"These figures demonstrate the commitment of my teams to crack down on those who think they can flout our immigration system," said Eddy Montgomery, Director of Enforcement, Compliance and Crime at the Home Office.

"I hope it sends a strong signal that there is no hiding place from the law, and we will continue to ramp up our activity to ensure those involved face the full consequences. We also know that many people who end up working illegally are often subjected to extremely poor conditions, so we will continue to do all we can to safeguard and protect the most vulnerable," he

How fast is your gut? The answer to this question is important to your health

OXFORD (UK), Feb 10: Many of us pay attention to the foods we're putting in our bodies -- asking ourselves whether they're nutritious and healthy for us.

But have you ever stopped to ask yourself how fast this food is moving through your gut? The answer to this question is actually really important, as the speed that food moves through your digestive tract affects your health and wellbeing in many ways. Once you've chewed up and swallowed your meal, this food begins its journey along the gastrointestinal tract - a long and winding pathway that begins at the mouth and ends at the anus.

Along the way, it reaches specialist organs that churn and digest (stomach), absorb nutrients (small intestine) and absorb water and salts (large intestine).

The movement of food through the digestive tract is known as gut motility. This process is partly controlled by the trillions of bacteria present in our gut. The gut microbiome is extremely important as these bacteria help develop our immune system and break down food. So, when we eat, we're not just

feeding ourselves – we're feeding

the micro-helpers present in the intestine. To thank us, the bacteria produce small molecules called metabolites that boost our immune system and keep our gut moving by stimulating the intestinal nerves so they contract and move the food onwards. Without these bacteria and their metabolites, our guts would be less able to move food through the gastrointestinal tract. This could cause a build up of ingested material, leading to constipation and discomfort.

There are many reasons that someone may experience fast transit time. For example, anxiety, inflammatory bowel disease (IBD) and irritable bowel syndrome (IBS) natural gut transit time – including can all cause decreased transit time and even diarrhoea.

In cases of fast transit, the resulting stool is loose with high water

ing you have slow gut motility), content. This indicates that the faecal matter has not spent enough time in the intestine, preventing sufficient absorption of water and nutrients. In cases of IBD for example, this can lead to dehydration

Testing your gut speed

Fortunately, there's a very simple at-home test you can do to check your gut motility. It's called "the sweetcorn test". And yes, it is what you're thinking. Don't eat any sweetcorn for 7-10 days (the "washout" phase). Then you are ready to begin the test. Note down the date and time, and eat some sweetcorn a corn on the cob or a handful of corn is sufficient. Because the outer shell of the corn is indigestible, it will pass through your gastrointestinal tract with the rest of the food you've eaten and will eventually be visible in your stool.

What you'll do is keep an eye on the next few stools you pass and note down the date and time that you observe the golden treasure. It should be noted that this at-home test is not definitive – but it does represent a measure of transit time that, on average, gives similar results to more sophisticated measures. (AP)

"Singh was scared of the proposed no-confidence motion. The government of Manipur was bound to collapse. The next step will be re-election or alternatively, President's Rule," he added.

Amidst rumblings within the state BJP seeking a change of leadership in the strife-torn state, Singh on Sunday tendered his resignation to Governor Ajay Kumar Bhalla at the Raj Bhavan.

The governor accepted Singh's resignation, along with that of his council of ministers, and requested that he continue in office until alternative arrangements are made.

The development came hours after Singh returned from Delhi after meeting Union Home Minis-

Singh had been defying the opposition's demand to step down as CM of the ethnic violence-hit state where trouble broke out 21 months ago in May 2023.

Last week, a new controversy erupted after the Supreme Court sought a sealed-cover forensic report on the authenticity of leaked audio clips alleging the role of Singh in the ethnic violence.

The tapes reportedly included conversations where Singh allegedly suggested that Meitei groups were allowed to loot arms and ammunition from the state government during the unrest, which has so far claimed 250 lives.

In his resignation letter, Singh said, "It has been an honour to serve the people of Manipur thus far. I am extremely grateful to the central government for time actions, interventions, developmental work and implementation of various projects for safeguarding the interests of every single Ma-

"My sincere request to the central government through your good office is to continue with the same. I take the opportunity to enumerate the most important ones of them ... To maintain the territorial integrity of Manipur which has a rich and diverse civilisational history over thousands of years," the letter

Singh also requested the Centre to continue the "crackdown on border infiltration and to formulate policy for the deportation of the illegal immigrants and the fight against drugs and narco-terror-

BJP sources on the other hand expressed hope that Singh's stepping down will help boost the efforts being helmed by the Centre to broker peace between the two main ethnic communities in the state. More than 250 people have been killed and thousands rendered homeless since ethnic violence broke out in the state in May

Registration of workers must in Sikkim: Official

GANGTOK, Feb 10: The Sikkim government on Monday asked employers to ensure registration of workers in both organised and unorganised sectors to "avoid legal consequences", a senior official said. "Only registered workers are permitted to work in Sikkim," Labour secretary Regul K told reporters. He also said there is a provision for penalty for those who fail to comply with the registration requirements.

Labour registration is an ongoing process and can be completed any time of the year at any designated office across the state, he said. "All workers must be registered to avoid legal consequences," Regul K said.

He said the labour department is carrying out an awareness campaign about the registration of workers in both organised and unorganised sectors under the Sikkim Labour (Regulation of Employment and Conditions of Service) Act, 2021. Regul K said the Sikkim government has tightened labour regulations, making it mandatory for all workers in hotels, shops and construction sites to obtain a labour card to maintain a database.

The official also said all stakeholders are being apprised about the significance of the Act, highlighting its key provisions and applicability. (PTI)

'Will accept any decision by BJP high command to resolve leadership issue'

'Whatever decision the high command takes, we will accept. The problem is over. The focus now is on how to restore peace," Khemchand told reporters.

Asked about the possibility of reconciliation between the two communities, Khemchand said, "Yes, I believe it will begin soon. According to the system of our party, whatever the high command decides, we must accept it, and all members will follow that decision." Khemchand has been vocal against the Biren Singh government for failing to restore peace and normalcy. He often remarked, "In the state's 2,000-year-old written history, there has never been a time when a valley resident could not step into the hills." Sources said BJP legislators are likely to hold more meetings in the next 48 hours, either in Imphal or elsewhere, to discuss the situation further. Meanwhile, security has been tightened across the state capital, especially in sensitive areas such as Sanjenthong, Singjamei, Moirangkhom, Keisampat, and Kangla Gate, to maintain order. (PTI)

Two held with Yaba worth ₹ 28 crore in Tripura

8 of 9 firearms looted from IRB

IMPHAL, **Feb 10:** Security forces have recovered eight of the nine firearms looted from an India Reserve Battalion (IRB) outpost in Manipur's Thoubal district, a police statement said on Monday.

The firearms, including three AKs and five SLRs, were recovered during a search operation in Ngamukhong foothills in the district and a hideout of banned outfit Kangleipak Communist Party was also busted in another subsequent operation, it said.

"The operations were launched after around 30 armed miscreants equipped with sophisticated weapons, breached one police (IRB) outpost at Kakmayai in Thoubal district (on Saturday night) and overpowered the police personnel deployed at the post," the police statement said. "The armed miscreants looted nine firearms, including six SLR and 3 AKs, from the outpost and escaped," it said.

Security personnel had managed to detain one of the miscreants, identified as Hijam Ningthem Singh (49) who was later identified as a member of KCP, the statement said.

During further course of investigation and relentless search operations at different locations, police on Sunday recovered three AKs and five SLRs out of the nine looted firearms from Ngamukhong foothill area, it said.

Stricter measures needed to counter baseless allegations against EC officers: Delhi poll body chief

Chief Electoral Officer R Alice Vaz, who was responsible for conducting the high-stakes elections in the national capital, has called for stricter measures to prevent people from levelling "baseless" allegations against EC officials.

In an interview with PTI, she emphasised that while existing provisions under electoral laws provide safeguards, evolving political scenarios may require tougher regulations to maintain trust in the electoral process.

"There is a need for stricter measures when it comes to allegations against officers involved in the election process. The Representation of the People Act and other legal provisions offer sufficient safeguards, but given the changing political landscape, it will be good if some more strict measures can also be put up," Vaz told PTI.

Her remarks come after the fiercely contested Delhi polls, in which the BJP delivered a decisive blow to the AAP, ending its decadelong rule. While the BJP secured 48 of the 70 seats, the AAP was reduced to 22 seats. As the CEO, Vaz played a crucial role in ensuring a free and fair election process in Delhi on behalf of the Election Commission.

This included overseeing poll preparations, implementing electoral guidelines, and addressing complaints from political parties and the public. She worked closely with district election officers (DEOs) and other officials to ensure transparency and strict adherence to the MCC.

"We have a well-defined complaint monitoring system. At the start of the process, we informed all political parties about the mechanisms available for lodging complaints. "Every issue raised -whether online, through applications, emails, or even physically submitted complaints -- was thoroughly scrutinised as per the ECI's guidelines," she said.

During the campaign, the AAP was particularly vocal in its criticism of the CEO's office with party supremo Arvind Kejriwal accusing election officials of manipulating

against alleged violations by the BJP candidates. Responding to these allegations, Vaz reaffirmed that the EC followed all protocols to ensure fairness

"We strictly followed all ECI guidelines, scrutinised every complaint properly, and took necessary action. Transparency was maintained throughout the process, and political parties were involved at every stage, from electoral roll verification to EVM checks and MCC enforcement," she explained.

One of the major challenges in this election was the heavy use of AI-generated content by political parties, which often targeted opponents through misinformation. Addressing this issue, Vaz said, "To counter misinformation and deepfakes, we strictly followed the EC's laid-out guidelines for social media monitoring. Any violation related to electoral rules was promptly processed and forwarded for ac-

To combat misinformation, the CEO's office launched an online portal called 'Myth vs Fact' to debunk false narratives surrounding electoral processes. "We actively updated this platform with clarifications to ensure voters received accurate information. Every day, we shared two to three myths along with verified facts to educate the public," she said.

She noted that during the peak election period, nearly 250 responses were issued, covering various topics from voter services and complaints to transparency measures. "Many complaints were also handled by the police, ensuring that electoral rules were enforced effec-

Explaining the role of the CEO, Vaz said the officer, on behalf of the ECI, is responsible for the overall election preparedness and its execution. The CEO coordinates with DEOs and assistant returning officers (AROs) to ensure smooth polling and transparency. "In consultation with the AROs, the CEO acts on behalf of the ECI and ensures all election-related processes are conducted fairly. Political parties and the general public are kept informed about every step of the process," she explained. (PTI)

NEW DELHI. Feb 10: Amid crit-told reporters outside Parliament. icism that the AAP-Congress bickering benefited the BJP in Delhi, Congress MP Manickam Tagore on Monday asserted that the INDIA bloc was formed for general elections 2024 and state-specific alliances were the way forward in the

He asserted that the INDIA bloc was formed particularly for general elections 2024. "Its main idea was to channelise the anti-Modi, anti-BJP anti-RSS forces at one level. that has been done. After that, coordination in Parliament has been happening at the floor level," he

"The speech of the leader of the opposition (Rahul Gandhi) had talked about an INDIA bloc vision as an alternative vision, it was not just a vision of the Congress. So we are positive towards it (INDIA bloc). But we know how one alliance partner's reaction can spoil it," he said.

"State elections are going to be different. State elections are going to be fought on state-level alliances. In Parliament, we are coordinating and our LoP calls it an INNDIA bloc vision," Tagore said.

Law and Industries Minister P Rajeeve also informed the Assembly that the state government will take all possible steps to prevent the mining, which would severely impact the marine ecology and the livelihoods of fisherfolk.

Budget politically driven with Delhi polls in mind: P Chidambaram

NEW DELHI, Feb 10: Congress leader P Chidambaram on Monday said the Union Budget 2025-26 was a 'politically-driven budget' with Delhi elections in mind as it ignored the poor and bottom half of the population.

Initiating discussion on Union Budget 2025-26 in Rajya Sabha, Chidambaram also accused Finance Minister Nirmala Sitharaman of claiming to improve fiscal deficit by cutting Centre's capital expenditure and grants-in-aid to states and terming it as bad economics.

"There ought to be a philosophy behind the Budget, but I cannot find one in this Budget. I shall not attempt to do so because after going through the Budget speech and Budget numbers, I believe there is no philosophy behind the Budget," he said.

Chidambaram further said, "It is obvious that the budget was politically driven, I shall not elaborate upon that but I congratulate the finance minister for achieving one of her objectives a couple

of days ago.' He was referring to BJP's win in the

The former finance minister also stated that the MGNREGA daily wage could have been increased "because the poorest are the ones who are going for MGNREGA work" and also the statutory minimum wage across the board under the Minimum Wages Act, could have been raised and that could have benefitted thousands and thousands of labour-

"She (Sitharaman) did nothing. But, she was focussed on the Income Tax and she was focussed on the Delhi elections,' Chidambaram asserted.

Referring to the Income Tax relief provided in the Budget, he said, "She remembered the middle class but what about the section of people she has forgotten?" Citing government data, Chidambaram said between 2012 and 2024. in the 12-year period, food inflation was 6.18 per cent, education inflation was 11 per cent, healthcare inflation was 14 per

from 25.2 per cent to 18.4 per cent," he said, adding as per household consumption survey in 2023, the average monthly per capita expenditure of a rural family is only ₹ 4,226 and in urban areas it is only ₹ 6,996.

"What is the position? The position is incomes are falling, wages are falling, government expenditures are not keeping pace with the promises, household net savings have fallen. Household debt has risen. This is the plight of the bottom 50 per cent of India. There is nothing in this Budget for the bottom 50 per cent," Chidambaram said.

By cutting capital expenditure by such a humongous amount she saved on the fiscal deficit ₹ 43,785 crore," he said, adding that cutting capital expenditure could have been understood had the sav-

ing of the fiscal deficit been equally big. "But after cutting ₹ 1,83,000-odd crore, she saved about ₹ 44,000 crore. Is it a good policy? I don't know, Is it good economics? I say no. It is not good economics," Chidambaram asserted. (PTI)

Maha Kumbh: Large number of devotees head to Kashi, Ayodhya after holy dip at Sangam



PRAYAGRAJ/VARANASI/AY-ODHYA, Feb 10: Undeterred by challenges, lakhs of devotees thronging the Maha Kumbh for a holy dip at the Sangam are now heading towards Kashi and Ayodhya, officials said.

According to government data, an average of 1.44 crore people are taking a holy bath at the Maha Kumbh every day.

Dr Sushma, who arrived in Prayagraj from Ranchi with her son on Monday, told PTI, "After taking a dip in the Sangam and visiting the fair, we will head to Kashi for Lord Shiva's darshan and later proceed to Ayodhya.'

Similarly, 74-year-old Ketari Devi from Ara, Bihar, said, "We saw on TV and mobile that this Maha Kumbh is happening after 144 years. After taking a holy dip, we will visit Kashi. Despite the huge crowd, we hope that we will get his darshan.'

Nishant Abhishek, who travelled from Mumbai, added, "We've heard that apart from Prayagraj, Kashi and Ayodhya are also witnessing heavy crowds. But this is a rare opportunity to visit all the three places during Maha Kumbh. We will also go to Ayodhya.'

ACP (Traffic) Shailendra Singh said that a significant number of devotees are heading towards Varanasi and Ayodhya after their visit to the Maha Kumbh. ADCP (Traffic) Kuldeep Singh said that compared to the 2019 Kumbh, the crowd this time is much larger even on regular days, leading to frequent traffic congestion.

Due to the heavy rush outside the Prayagraj railway station, the Northern Railway's Lucknow division has temporarily closed it for passenger movement from 1:30 pm on February 9 to midnight on February 14, an official statement said.

However, eight other railway stations in the Maha Kumbh area continue to operate regular and special

As per government figures, over 44 crore devotees have taken a dip at the Triveni Sangam till February 9. On February 10, by 10 am, over 63 lakh devotees had performed the

On key bathing days, the footfall has been record-breaking. On January 13 (Paush Purnima), it was 1.70 crore while on January 14 (Makar Sankranti) it was 3.50 crore, and 7.64 crore (highest so far) took dip in the Sangam on Mauni Amavasya.

With an average of 1.44 crore people taking a dip daily, authorities are managing an unprecedented surge of pilgrims in the holy city.

Over 1.02 crore people have taken holy dip in the Sangam till 4 pm, which included over 10 lakh Kalpwasis and 91.94 lakh pilgrims. The total number of devotees taking dip in the Sangam till date since the start of the Kumbh Mela has crossed 44 crore.

In Varanasi, a large number of devotees returning from the Maha Kumbh are arriving to visit the Kashi Vishwanath temple, leading to massive crowds across the city.

Due to the heavy rush, authorities have imposed restrictions on the movement of four-wheelers in several areas, and vehicles from outside the city are being halted at designated parking zones on the outskirts, officials said.

District and police officials are conducting regular patrols, while CCTV cameras and drones are being used to monitor sensitive and crowded areas, said DCP (Kashi Zone) Gaurav Banswal.

Multiple 'rain baseras' (temporary shelters) have been set up across the city for visiting pilgrims, he added.

As controversy grows over influencer's of 3 lakh children: Jal Shakti Minister Patil remarks, NHRC asks YouTube to remove episode

NEW DELHI, Feb 10: As controversy snowballed over influencer Ranveer Allahbadia allegedly offensive remarks made during an online reality show, a NHRC member on Monday shot a letter to YouTube saying it has "taken cognisance" of the issue and asked to take an "urgent action" and remove that episode from the popular platform.

Priyank Kanoongo, a member of the National Human Rights Commission (NHRC), in his letter said the rights panel has received a complaint from wherein it has been alleged that a YouTube show titled 'India's Got Latent', hosted by Samay Raina, contains highly objectionable, inappropriate and obscene remarks against the Indian

The letter has been written to YouTube's head of public policy in

"The complaint highlights concerns regarding the show's propa-

gation of negativity, discriminatory perspectives, religious and cultural intolerance, and disrespectful and obscene ideologies, particularly towards women and children. It is further alleged that, under the guise of freedom of speech, the show disseminates obscene and vulgar content along with misleading messages, thereby fostering a corrupt mindset in society," he wrote in

The content in question "prima face appears to be in violation" of various legal provisions under the Bhartiya Nyay Sanhita (BNS), the Protection of Children from Sexual Offences (POCO) Act, the Information Technology (IT) Act and other applicable laws, it reads.

Furthermore, it is alleged that the show "severely infringes" upon fundamental rights relating to religious freedom and the safety and dignity of women and children, as enshrined in the Constitution of India, the letter said A copy of the complaint has been annexed with the letter, it said.

"Additionally, the Commission

has come across certain links indicating that a recent episode of the aforementioned show features YouTubers making vulgar and explicit statements concerning children and women. These statements are not only deeply objectionable but also amount to a serious violation of woman and child rights. The availability of such content on widely accessible platforms, including YouTube, Instagram, and Facebook, poses a grave threat to the safety, dignity, and mental well-

About 10,249 acres of defence land under encroachment: Govt

NEW DELHI, Fab 10: Out of around 18 lakh acres of defence land across the country, about 10,249 acres are under encroachment, the government informed Parliament on Monday.

Minister of State for Defence Sanjay Seth said this in a written response to a query in the Rajya Sabha. The government was asked about the details of defence land "under encroachment" in the country, with location-wise data.

"Out of around 18 lakh acres of defence land across the country, about 10,249 acres is under encroachment," the minister said in his response. He also shared state-wise details of encroachment

In another query, the government was asked whether it is aware of the fact that a large number of parcels of land or bundles of land belonging to defence have been leased to private and other entities, which are either not leased further or under en-

Leases of defence land within cantonments have historically been granted to private individuals, institutions and government bodies for various purposes under the Cantonment Codes of 1899 and 1912, followed by the Cantonment Land Administration Rules of 1925 and 1937. Seth said.

"These leases were normally granted either in perpetuity or for a total lease period of 90 years. In order to extend the lease period of expiring or expired leases and regularise the occupation of these sites, besides recovering lease rent, the ministry issued an interim policy on March 10, 2017, which has been extended up to December 31, 2025. As regards encroachments on defence land, the same are dealt as per law under the provision of the Cantonments Act, 2006 and Public Premises (Eviction of Unauthorised Occupants) Act, 1971," the minister said in his response. (PTI)

Swachh Bharat Mission helped save lives



NEW DELHI, Feb 10: The government's Swachh Bharat Mission has helped save lives of three lakh children in the country according to a WHO report, Jal Shakti Minister C R Patil informed the Rajya Sabha on

He said under the government's Open Defecation Free (ODF) policy, around 12 crore toilets have been constructed across the country and 60 crore beneficiaries have benefitted from the scheme so far.

Replying to supplementaries during Question Hour in the Rajya Sabha, the minister said the scheme has helped ensure cleanliness and not wait till evening for defecating in the open.

"In the first five years, 10 crore toilets were constructed. In the second phase another two crore toilets were constructed and a total of 12 crore toilets have now been built. But the total number of beneficiaries under the scheme are 60 crore.

'This has also ensured women safety as women would now not have to wait all day long for going in the open for defecation. A WHO report has stated that due to the clean India campaign, the lives of around 3 lakh children have been saved," the minister said in the upper house.

He said the Clean India mission and ODF policy is a process in continuity and to take it forward, the Centre is working with state govern-

In his written reply to a starred question, the minister said 16,125 villages have declared themselves ODF-plus (Aspiring-1,497, Rising-558 and Model-14,070) up to February 6, 2025 in Himachal Pradesh.

"Sanitation is a state subject, the Department of Drinking Water and Sanitation provides financial and technical support to states. Phase II of Swachh Bharat Mission

(Grameen) is being implemented during the period from 2020-21 to 2025-26, with the focus on ODF sustainability and to cover all the villages with solid and liquid waste management i.e. converting the villages from ODF to ODF Plus (Model). The scheme is being implemented in rural areas of the country, including in Himachal Pradesh.

Observing that the task of constructing toilets is a continuous process and not a one-time activity, the minister said, "there are continuously new emerging households, migrant households etc. which will require toilets."

He said the construction of new Individual Household Latrines (IHHLs) continues to be the first charge on SBM(G) funds under Phase-II of SBM(G) and states are advised continuously to plan for left out toilets and address this gap on

The incident took place on February 6 at Navyug Vidyalaya, a grant-in-aid school run by a trust, in Jambusar town and the institute's management has asked school principal Hitendra Thakor not to report for duty for the time being, said Bharuch District Education Officer Swatiba Raol on Monday.

In the CCTV footage released by the school, principal Thakor, sitting inside his cabin, can be seen talking to a teacher, Rajendrasinh Parmar, who along with some other colleagues, was sitting

Suddenly, Thakor is seen getting up from his chair, rushing towards edly. Thakor then pulls Parmar down on the floor from the seat and slaps him multiple times on his face in the presence of others, who can be seen in the video trying to intervene.

Raol said the school management approached her on February 7 and submitted a complaint about the principal.

"After receiving the complaint, I have formed a committee to conduct an inquiry into the incident. The committee will record the principal's statement today (Monday). We will take action after getting the inquiry report. As of now, the school management has asked Thakor not to come to school,"

said the education officer. Raol did not shed light on what triggered the ugly incident, but Thakor separately told media persons that several parents had complained about Parmar's behaviour.

"Many parents had registered their complaints against Parmar. Thus, I had called him for a meeting on February 6. During that meeting, I tried to make him understand in a polite manner and also asked him why there has been no change in his behaviour so far,' claimed the principal. (PTI)

Just before he could finish the refrain of the song, a policeman stepped in and pulled the cables attached to the microphone and musical instruments.

Park police station said Sheeran was performing "without any permission so they had to

If something happens, I'd like for him to be there: Saif on Taimur going with him to hospital

NEW DELHI, Feb 10: Why did eight-year-old Taimur go with his father Saif Ali Khan to the hospital in the dead of night after the horrific knife attack at their home? Many thoughts were running through the actor's head and one of them was this if "God forbid" something were to happen to him, he would like his son to be

"He was absolutely composed. He was fine. He said, 'I'm coming with you.' I was getting a lot of comfort just from looking at him at that time. And I didn't want to go alone," Saif has said in an interview with Times of India, his first since the January 16 attack.

"My wife sent him knowing what he would do for me. Maybe it wasn't... at the moment, it was the right thing to do. I felt good about it. And I also thought, if God forbid, something happens, I'd

like for him to be there. And he wanted to be there also. It was a very filmy scene, recalled the actor, who was stabbed multiple times and was taken to hospital in an autorickshaw with a portion of the knife still lodged in his spine.

Man City vs Real Madrid: an accidental blockbuster in the Champions League playoffs

LONDON, Feb 10: Real Madrid against Manchester City in the Champions League is the accidental blockbuster of the new knockout playoffs round that starts Tuesday

The past two title winners surprisingly finished mid-table in the new 36-team standings format that ended in January. The topeight teams skipped the playoffs and went directly to the round of 16 in March. The penalty for City and Madrid is now to meet in the extra stage inserted into the format just to enter the round of 16 that they have come to expect as their rightful place.

Bayern Munich and Paris Saint-Germain also are wealthy and influential clubs now facing unexpected jeopardy in the twoleg playoffs on back-to-back midweeks in February

The bonus for UEFA and broadcasters is having global attractions in action for two extra games after an expanded opening league phase. If record 15-time champion Madrid is to retain its European title, it will take playing 17 games instead of 13 last season. Madrid eliminated Man City in the quarterfinals one year ago, and in two epic semifinal legs before lifting the trophy in 2022. Man City won their semifinals meeting decisively in 2023 on the

way to its first European Cup title. A different CityIt is a different Man City in personnel and per- early-season wobbles when against a team from outside sonality that Pep Guardiola will send out Tuesday in Manchester.

Star midfielder Rodri is out injured despite being included Friday in an updated squad, playmaker Kevin De Bruyne is less often fit, and the team's pursuit of a fourth straight Premier League title has been conceded with Liverpool the likely successor. New signings Omar Marmoush in attack and Nico Gonzalez in midfield have barely settled in — with Gonzalez getting injured early into his debut in the FA Cup and now a doubt for the Madrid game.

Madrid, however, is now rolling as La Liga leader since its Kylian Mbappé took longer than expected to settle in.

Indeed, the teams met just last week, with PSG winning 5-2 at Brest's 15,000-seat Stade Francis-Le Blé. That stadium in northwestern France does not meet UEFA's requirements so Brest has been playing its Champions League home games at Guingamp's Stade de Roudourou, 114 kilometers (70 miles) away.

PSG hasn't lost in any competition since Nov. 26 and starts as the big favorite to advance in a competition it has yet to win in 14 years under Qatari ownership.

Juventus and PSV meet Tuesday for the second time in Turin this season. Juventus, which has drawn more games that it has won this season, beat PSV 3-1 in September in the first of the 144 league-phase games.

Bayern aims to be homeward boundBayern reached the final when the Champions League title was last decided at its stadium in Munich — in 2012, when Chelsea won on penalties after a 1-1 draw.

The seven-time European champion has a long road back to a home-field final on May 31 after placing 12th in the league standings. Still, the blow of being in the playoffs was softened by being drawn against Celtic instead of Man City.

The runaway Scottish league leader, which won the 1967 European Cup seven years before Bayern's first title, hosts the first leg on Wednesday. (AP)

MEXICO CITY, Feb 10: The chance to win more trophies and play at the next edition of the FIFA Club World Cup convinced Spanish defender Sergio Ramos to sign a one-year deal with Monterrey of Liga MX in Mexico. Ramos, who will turn 39 in March, was introduced by the club on Sunday.

"I'm not tired of winning, but I did not come here to talk about my accomplishments," Ramos said at a press conference in Monterrey, northeastern Mexico. "I've never been here, I want to leave a legacy in Mexico, I'm not here to travel, I'm here to try to win new titles.'

Commonly known as Rayados, Monterrey is one of the most economically powerful

clubs in the country. It's one of three Mexican teams that will participate in the expanded Club World Cup which is set to be played in the U.S. next summer. The other two are León and Pachuca.

As well as the domestic league, Monterrey is also competing in the CONCACAF Champions Cup.

"This team (has) a huge growth margin, they are going to play local and international tournaments," Ramos said. "It's a good moment to make yourself noticed." He added "it was an easy decision to take."

Serial winnerRamos, part of Spain's World Cup-winning team in 2010, has not played an official match since May of last year when he was playing for Sevilla in the Spanish league. He's not worried about the

challenge ahead. "In soccer the age does not matter, performance matters," Ramos said. "To come here after a long career shows the hunger that I have to keep on winning." Ramos also won Euro 2012 with Spain and five Spanish league titles and four Champions League titles with Real Madrid, where he played for 16 seasons. (AP)

QINGDAO (CHINA), Feb 10: Without the services of an injured PV Sindhu, India will face an uphill task in pursuit of an elusive gold medal at the Badminton Asia Mixed Team Championships which get underway here on

India hope to improve on their bronze medal finish from the previous edition where Sindhu played a key role in Dubai two years ago. Her absence this year due to an injury will be a significant setback as the team embarks on its campaign in the prestigious biennial

Sindhu sustained a hamstring injury during a pre-tournament training camp in Guwahati on February 4, forcing her to withdraw from the tournament at the last minute. Her unavailability puts the onus on world No 29 Malvika Bansod to step up in women's singles.

Placed in Group D, India will open their campaign against Macau on Wednesday, followed by a clash with a strong Korean outfit on Thursday. A toptwo finish in the group will secure a spot in the quarterfinals, and while India is likely to progress to the last eight, advancing further will require exceptional performances from the squad.

While India have never won the gold at the Asia Mixed Team Championships, they did secure mixed team gold and silver at the Commonwealth Games in 2018 and 2022.

India have had notable success in recent team events, including their firstever Thomas Cup gold in 2022, the 2024 Badminton Asia Team Championships silver in Malaysia, and a historic men's silver at the Hangzhou Asian

The team features many key players

from those victories, including HS Prannoy, Lakshya Sen, Ashwini Ponnappa, Satwiksairaj Rankireddy, and Chirag Shetty, with all eyes on them to put up an inspired performance.

While Satwik and Chirag have been consistent with semifinal finishes at the Malaysia Open and India Open, Prannov has been troubled by niggles after returning to action following the Olympics, where he was affected by a pre-tournament chikungunya bout. Syed Modi champion Lakshya, on the other hand, has endured a few first-round exits this season and will need to regain his form quickly.

As expectations will be high for the men's singles and men's doubles, India also boasts strength in women's doubles, with Gayatri Gopichand and Treesa Jolly repeatedly showcasing their skills. The duo recently broke into the

world's top 10 on the back of their maiden super 300 title run at Lucknow and qualifying at the BWF World Tour event last year.

Adding to the experience is Ponnappa, who competed at the Paris Olympics alongside young Tanisha Crasto. The duo won the Guwahati Masters Super 100 last December and will look to put up a good show here.

The mixed doubles pair of Sathish Karunakaran and Aadya Variyath will also carry confidence into their first team event, coming off a gold medal at the National Games in Dehradun earlier this month.

In the last three editions of the tournament, China clinched the title in 2023 and 2019 while Japan emerged as champions in the inaugural edition in 2017. The event was not held in 2021 due to the COVID-19 pandemic. (PTI)

Pakistan are a dangerous side in home conditions, should make Champions Trophy semifinals: Shastri



Just another day in office, says Rohit but concedes it's not that simple

CUTTACK, Feb 10: It was just another day in office, said a nonchalant India skipper Rohit Sharma after his 32nd ODI century ended a prolonged lean patch but acknowledged that the process of getting back among runs "is quite difficult" even though it "sounds very sim-

Rohit blazed his way to a 90-ball 119 with 12 fours and seven sixes to set up India's four-wicket win over England in the second ODI here on Sunday, giving the hosts an unassailable 2-0 lead in the three-match

"...when people have played for a number of years and scored so many runs over the years...that means something," Rohit said in a video shared by BCCI.

"I've played this game for a long time now and I understand what is required of me. So, it's just about going out there and doing your things and this was, what I did today was, one of my things."

Rohit's 119 was his first century in ODIs since October 2023, a period during which the opening batter hit five fifties in 13 matches. Across formats, this was his first century since March 2024 when he hit 104 against England at Dharam-

"In my mind, it was just about doing things that I do, try and bat the way I do. I've been here long



enough... one or two knocks is not going to change my mind and the way I bat. But (it was) just another day in the office," the 37-year-old

Rohit, however, admitted that regaining form despite knowing the methods and ways, is not always

"When you have scored so many, vou have done something, right? You just need to get back to that that mindset of you know, how to get runs," he said.

"(It) sounds very simple, but it is quite difficult. But in my mind, it was just about enjoying and that is what we play the sport for, to enjoy the game more than anything else,' he explained.

Rohit's lean patch, particularly in Tests since October 2024 wherein he crossed fifty only once in eight games against Bangladesh, New

Zealand and Australia, led to calls for the India stalwart to contemplate

The usually affable Mumbaikar has been combative in his response to such suggestions. After Sunday's blitzkrieg too, he asserted that his only goal is to perform on the field and ignore the noise on the periph-

"We need to do our job, okay? Our job is to go out there and play the game. As long as you go there and you know that today when you go to bed, you know that you've given your best, that is what matters," he said.

"Every time I walk onto the pitch, walk on to play the game, I want to try and do well. Sometimes it happens, sometimes it may not happen. As long as I am clear what I want to do, that's all that matters. Nothing else matters," he added. (PTI)

If even Rohit Sharma can be under pressure, we should be easier on ourselves: Buttler



CUTTACK, Feb 10: If a player of Rohit Sharma's calibre could face pressure at times, the others should be a bit "easier" on themselves, said England skipper Jos Buttler as he hailed the Indian skipper's muchawaited century as a lesson in modern and dynamic ODI batting.

Facing intense scrutiny over his form and calls of retirement, the 37vear-old Rohit returned to form with his first century in the ODI format in 16 months to power India to a series-clinching win here on Sun-

"It's probably a nice reminder for all of us that if someone of Rohit's caliber can be under pressure, we should be a bit easier on ourselves," Buttler said after their four-wicket loss here.

"He's been a great player for such a long period of time and top players generally come up with the goods and he obviously did that

"Any time you're playing against great players and they're playing an innings like that, I'm sure players on both sides will be watching and learning. He played a brilliant innings and (displayed) how he can go up and down the gears and absorb pressure, put a lot of pressure back on (the opponent)," Buttler added in full admiration of Rohit's blistering 119 off 90 balls.

Rahul coming below Axar raises eyebrows, where does it leave Pant?

NEW DELHI, Feb 10: Towards the end of the second ODI between India and England in Cuttack, the broadcaster's camera briefly panned to Rishabh Pant sitting in the dugout, wearing the sleeveless green fluorescent bib which is mandatory for the reserves.

On the field, it was KL Rahul batting at No.6, an unusually low position for the man who has been preferred over Pant.

Ravi Shastri, who was on air, didn't hold back while talking about what he felt about a specialist top-order batter like Rahul coming in at No.6 instead of bowling all-rounder Axar Patel, who was promoted to No.5 during the first two games. Many in Indian cricket shared Shastri's

sentiments and are also wondering where does it leave an explosive game-changer like Pant if the management remains firm on the left-right combination formula to promote Axar above Rahul. If ends justify the means, then head coach Gautam Gambhir stood vindicated

after Axar scored 52 and 41 not out in the

first two games even though he came in at

"Gautam always looks at team's requirements and he finds KL suitable at No.6 as it helps him keep left-right combination intact. Now Axar has scored runs at No.5 and it does leave Pant in a tricky place.

"It will be tough to slot him in if this is the

batting combination they are looking at," a former India player, who has seen Gambhir's tactical moves from close quarters, told PTI on conditions of anonymity.

What has baffled many is how can Rahul, who has given his best at No. 5 and the opening slot in ODIs, be batting below a

bowling all-rounder. "KL has been outstanding at No.5 for India. He scored nearly 1300 runs (1259) and enjoys a strike-rate of near 100 (95.45) with an average close to 60. These are exceptional numbers and why do you want to reinvent the wheel?" a livid former national

selector questioned the experiment. But then the counter argument could be that Axar's elevation has yielded tje desired results. It's another matter that nobody yet knows whether Axar is a good enough candidate to be sent on days when India could be 20 for 3.

So why sent Rahul only in challenging conditions and not allow him to also get some easy runs like Axar?

Another former India player, who has worked with Gambhir said that come what may, the former opener will play eight batters irrespective of format.

"If you want batting till No. 8, you have got to play multi-skilled players and if Axar is playing then Pant can't play. And Axar will play in these conditions.

"Hence not just it is an unfortunate situation for Pant, who is not finding a slot in the side, it is also going to be tough for Rahul as his game isn't suited for four drop," he said. (PTI)
