GUWAHATI, Feb 20: Chief Minister Himanta Biswa Sarma on Thursday said that the preliminary investigation has found that Pakistani national Ali Tauqeer Sheikh, who is allegedly linked to Congress MP Gaurav Gogoi's British wife, has visited India 18 times to date.

During a discussion on Motion of Thanks on the governor's speech, Sarma also claimed that the initial information in the case is "very fatal" for the Congress and will have a "huge impact" on the politics of Assam.

"Within three days, the Assam Police SIT on the case found that Ali Tauqeer Sheikh visited India 18 times. Now, we will know who invited and hosted him during those visits," he added.

The CM also stated he knows informally that the preliminary investigation has revealed some startling facts, the impact of which will be huge on Assam politics.

"As per the initial information, the facts are very fatal for the Congress party. As a responsible person standing inside the assembly, I am saying this. I promise to the Assam Assembly that we will break the network of Ali Sheikh. Give us three months and we will inform everything in the August session," he added.

Sarma said the investigation findings will put some people in an indefensible position. "Sheikh apparently works in a

India's internal affairs," he added. The Assam chief minister and the BJP have been attacking Gogoi, the Deputy Leader of Congress in Lok Sabha, over his wife Elizabeth Colburn's alleged connection with Pakistan's spy agency ISI.

The Assam Police on Monday constituted a Special Investigation Team (SIT) to probe a case against the Pakistani national Ali Tauqeer Sheikh for his social media comments on Assam and India's internal affairs.

Sheikh, an advisor to the Pakistan Planning Commission and a former colleague of Colburn, was charged under various sections of the Bhartiya Nyay Sanhita (BNS) and the Unlawful Activities (Prevention) Act (UAPA).

After much hue and cry over Gogoi's wife's alleged ISI links, the Assam cabinet on Sunday decided not to register any case against the parliamentarian or his British spouse but instructed the DGP to file an FIR against the Pakistani national.

The state govt also announced that it will write to the Centre for probing Colburn's participation in Lok Sabha campaigns in the erstwhile Kaliabor constituency, which was won by the Congress MP twice, despite being a British citizen.

"The gang of miscreants was so ferocious that they even leaped at the security guards and beat them up," they added. Hussain claimed that the attack was pre-

planned and that he had informed the district administration and the police about the possibility of such an incident.

Making a statement in the Assembly, the Chief Minister Himanta Biswa Sarma said that the crowd had tried to prevent Hussain from entering the village when his PSO opened fire.

Despite the attack, the MP proceeded to the scheduled meeting venue, where the event was conducted in the presence of the district Superintendent of Police, he added.

The chief minister further assured that Hussain's security would be beefed up while he remains in the district, particularly in Samaguri and Rupohihat.

Director General of Police (DGP) Harmeet Singh told reporters that the situation was under control and that the SP concerned was investigating the incident.

"We will share further details as the investigation progresses," he said. The MP was unharmed, but two of his PSOs sustained minor injuries and are receiving necessary medical treatment, Singh added.

Shah asks NE insurgents to surrender



NEW DELHI, Feb 20: Union Home Minister Amit Shah on Thursday appealed to insurgents in the Northeast to lay down their arms and join the mainstream saying their participation in India's development journey is most welcome. Participating in the 'Unity Utsav - One Voice, One Nation' organised by the Assam Rifles here, Shah also said everyone knows that the Northeast wants peace and development and the region wants to work as an integral part of the country

"I appeal to all those insurgents who have not surrendered yet to lay down the arms and join the mainstream. Your participation in India's development journey is welcome," he said.

The home minister said there has been 70 per cent reduction in violence in the Northeast in the last five years, 70 per cent less casualties in security forces and 85 per cent less deaths among civilians.

He said over 10,000 insurgents have surrendered in the last five years, 12 peace accords were signed with different outfits and two border agreements were also signed among the states.

'The Northeast wants peace, Northeast wants development, Northeast wants to work as an integral part of India," he said.

The home minister said if the youth of the Northeast put forward two steps to be part of India's development process, the whole country will put forward four steps with open heart to welcome them. "Every part (CONTD. ON PAGE-2)

GUWAHATI, Feb 20: Prime Field at Khanapara to visit a re-Minister Narendra Modi will reach Assam on a two-day visit from February 24 to attend a world record making dance event and inaugurate a business summit. Chief Minister Himanta Biswa Sarma said here on Thursday.

The Prime Minister will arrive on Monday afternoon and attend the Jhumoi dance by artistes of the tea tribe community at the Sarusaiai Stadium.

Altogether 8,000 people will take part in the 'Jhumoir Binandini', an attempt to set a world record for the largest participants in a Jhumoir dance event.

NEW DELHI, Feb 20: Attacks on minorities in Bangladesh after the fall of the Sheikh Hasina government did not happen, the chief of that country's border guarding force claimed on Thursday as he termed reports in this regard as "exaggerated".

Border Guard Bangladesh (BGB) director general Maj Gen Mohammad Ashrafuzzaman Siddigui also said "many new issues" under the common heads were discussed during his high-level talks with BSF DG Daljit Singh Chawdhary here.

Siddiqui, while speaking to reporters during a joint press conference with Chawdhary, asserted that authorities of his country took steps for the protection of the minorities as he gave example of his force "personally" extending security cover to Durga Puja pandals within 8 km of their jurisdiction along the international border. This was the first high-level meeting of the two forces after the regime change in Bangladesh in August last year.

The BGB DG also said they raised "objections" and "flagged a number of cases" during the bi-annual talks DG-level with regard to the fencing being done by India along the 150 yards of the IB and has requested for a "joint inspection" before the work is done.

NEW DELHI, Feb 20: Debutant legislator Rekha Gupta was sworn in as Delhi chief minister along with six ministers on Thursday in a grand show of strength full of colour and spectacle to mark the BJP's return to power in the city after more than 26 years. The ceremony at the sprawling Ramlila Ground was attended by Prime Minister Narendra Modi, the top BJP brass and NDA leaders. Gupta is Delhi's fourth woman chief minister after her party's Sushma Swaraj, the Congress' Sheila Dikshit and AAP's Atishi. The 50-year-old MLA from Shalimar Bagh, who took charge of her office at the Delhi Secretariat in the afternoon, is also the only woman in the NDA team of chief ministers and the second in the country after TMC supremo Mamata Banerjee in West Bengal. The former student leader presides over an all-male cabinet that includes giant slayer Parvesh Verma, who defeated Arvind Keiriwal in the elections, Hindutva poster boy Kapil Mishra and the BJP's Sikh face Manjinder Singh Sirsa. WHO identifies encephalitis as increasing global threat, matter of urgent public health priority

NEW DELHI, Feb 20: The World Health Organization and Encephalitis International have launched a critical Technical Brief on encephalitis which identified the infectious and autoimmune disease as an increasing global threat, making it an urgent public health priority.

The Technical Brief outlines the worldwide burden of encephalitis, key actions required to improve prevention, data collection and surveillance, diagnostics and treatment, aftercare and awareness, and research innovation.

"Encephalitis is an increasing global threat. Without urgent attention and investment, we will see more needless deaths and disabilities from the condition," said Dr Ava Easton, the chief executive of

"WHO's recognition of encephalitis as a growing global threat marks a pivotal moment. We must act decisively to improve prevention, diagnosis, and care for those affected. Sensex, Nifty fall for 3rd day on selling in blue-chips, broader markets rebound

MUMBAI, Feb 20: Benchmark indices Sensex and Nifty declined for the third day on Thursday as fresh tariff threats, weak Asian markets and foreign fund outflows hurt investor sentiment.

The 30-share BSE Sensex dropped 203.22 points or 0.27 per cent to settle at 75,735.96. During the day, it tanked 476.17 points or 0.62 per cent to 75,463.01.

The NSE Nifty dipped 19.75 points or 0.09 per cent to 22,913.15.

Selling in frontline stocks HDFC Bank, ICICI Bank, ITC and Maruti dragged down the key indices. Broader markets, however, bucked the trend with midcap and smallcap indices gaining more than 1 per cent.

From the Sensex pack, HDFC Bank fell the most by 2.35 per cent. Maruti, Tech Mahindra, HCL Tech, ITC, ICICI Bank, Kotak Mahindra Bank and Bajaj Finance were among the major laggards.

The CM on Tuesday said he is not on a "witch hunt" drive over the controversy surrounding Colburn's alleged links with ISI and said that he is driven by only national security, which cannot be compromised.

Earlier, Sarma had softened his stand against Gogoi and said on Sunday that the opposition leader may be "trapped or blackmailed" in the larger "anti-India" conspiracy and expressed sympathy for him.

The BJP leader had last week targeted the Assam MP over the issue, demanding answers regarding the allegations of ISI links, "leading young individuals to the Pakistan embassy for brainwashing and radicalisation, and the refusal to take Indian citizenship for the past 12 years", referring to Colburn's nationality status. He had also alleged that the deputy leader of Congress in Lok Sabha had raised questions in Parliament on

sensitive defence matters after his marriage to the British citizen, a charge termed by the opposition leader as a "false accusation". The BJP had also accused Gogoi's wife of having links with Pakistan and the ISI, a charge rejected by the Congress leader as "laughable and entertaining".

Gogoi on Friday said that the BJP went to extreme steps to defame him and his family and asserted that he would be taking appropriate legal action, while he penned a letter in Assamese addressed to his wife and shared it as a post on Facebook on Saturday, assuring her that truth shall prevail. (PTI)

Mining tycoon Anil Agarwal launched the plan to overhaul the business in 2023 after failing to take Vedanta private in 2020.

The five entities being created from the split would include Vedanta Ltd, which would house the company's base metals.

According to Vedanta's demerger scheme, every Vedanta shareholder will receive 1 additional share in each of the 4 newly demerged companies on the completion of the demerger process.

The other companies that will be created out of the demerger are Vedanta Aluminium, one of the world's largest producers of aluminium; Vedanta Oil & Gas, India's largest private-sector crude oil producer; Vedanta Power, one of India's largest generators of power; Vedanta Iron and Steel - a company with a highly scalable ferrous portfolio; and Vedanta Limited which will include the world's second largest integrated zinc producer and third largest silver producer in Hindustan Zinc.

Vedanta Ltd will also act as an incubator for new

businesses, including Vedanta's technology verticals. Of the 391.03 crore shares of the company, 324.58 crore or 83 per cent, voted on the demerger scheme.

will create five independent companies of a global scale focussed on the mining, production and/or supply of aluminium, iron-ore, copper, oil & gas, and on generation and distribution of power.

It will enable greater focus of the Vedanta management on the relevant businesses thereby allowing further streamlining of operations and more efficient usage of assets and leveraging of opportunities.

Similarly, the demerger scheme has emphasised that over time, each of the independent companies can attract different sets of investors, strategic partners, lenders, and other stakeholders enabling deeper collaboration and expansion in these specific companies without committing the existing organisation in its entirety.

The demerger will enable investors to separately hold investments in businesses with different investment characteristics and market potential thereby allowing them to select investments which best suit their investment strategies and risk profiles.

As per Vedanta's demerger scheme, it will also enable focused and sharper capital market access (debt and equity), thereby unlocking the value of the demerged entities.

Nageswaran, an academic and former executive with Credit Suisse Group AG and Julius Baer Group, succeeded K V Subramanian.

His extension comes weeks after the Economic Survey 2024-25 projected a growth of 6.3-6.8 per cent for the next financial year amid Post-Graduate Diploma in Man-

Railway Electrification of Lumding –

Dibrugarh Section nearing completion

Upon completion, Dibrugarh will be directly connected to Guwahati through Overhead Equipment (OHE), enabling the Dibrugarh Rajdhani Express and other superfast trains to operate on electric traction.

The electrification of the Simaluguri – Tinsukia section is in its final phase, with commissioning targeted for March 25, 2025.

Notably, the Lumding - Dimapur - Furkating - Mariani sections have already been commissioned. Additionally, electric locomotive trials for the Mariani - Simaluguri - Dibrugarh section were successfully conducted on January 31, marking a significant milestone in the region's railway electrification efforts

The railway electrification project for the Lumding - Dibrugarh route via Tinsukia, along with the Simaluguri - Dibrugarh section and associated sidings under Northeast Frontier Railway is progressing at a rapid pace. Spanning the Lumding and Tinsukia divisions, the project commenced physical work in May 2022 and involves extensive infrastructure development. The project includes the installation of 488 RKM/650 TKM of Overhead Equipment (OHE), five traction substations, 29 switching stations, and five transmission lines spanning over 50 km.

Additionally, it comprises the construction of five OHE/PSI depots, five tower wagon sheds, and several civil structures, including 121 staff quarters, administrative buildings and station upgrades.

A significant infrastructure enhancement under this project is the reconstruction of the Road Over Bridge (ROB) at Mancotta, aimed at improving connectivity over the Dibrugarh & Dibrugarh Town station.



Hoping independence of EC

ith Union Government of India making the appointth Union Government of India making the appoint-ments of the Chief Election Commissioner of India, and an Election Commissioner under the new law of 2023, while the law itself is pending adjudication in the Supreme Court of India, people's hopes and fears about independence of Election Commission of India running high. The Chief Election Commissioner and other Election Commissioners (Appointment, Conditions of Service, and Term of Office) Act of 2023 was challenged in the Supreme Court of India on the ground that it goes against the spirit of the 2022 Constitution Bench verdict which emphasized that the appointment process should be insulated from executive interference so that its functioning will be truly independent. The Constitution Bench in its verdict had put in place a committee comprising Prime Minister, the Leader of Opposition in Lok Sabha, and Chief Justice of India to secure the appointment process democratic in true sense of the term. The law kept majority of the executive to control the very appointment process to have executive's wish implemented. Supreme Court of India did not deliver judgement in time, and under the same controversial law Modi government had appointed the new CEC and an EC on Monday night, February 17, after the meeting of three members - Prime Minister Narendra Modi. Union Minister of Home Amit Shah, and Leader of Opposition in the Lok Sabha Rahul Gandhi

A day after the appointment of new CEC Gyanesh Kumar and an EC Vivek Joshi, the petitioners who have challenged the law on the appointment of Election Commissioners requested the Supreme Court on February 18 to hear the matter on top priority on February 19 itself, fearing that the matter may not be heard at all since it was listed as no. 41 item. The request was declined, but Justice Surya Kant who was presiding over the bench, asked the petitioner's advocate Prashant Bhushan to make a mention on February 19. Later, The Supreme Court postponed the hearing to March 19, owing to non-availability of dates in between. Now, when the CEC Gyanesh Kumar and EC Vivek Joshi had already joined, people and political parties of the country are looking towards them with much hope and fear regarding independence of the Election Commission of India, irrespective of the final decision of the Supreme Court of India on the validity of the laws itself under which they have been appointed. Since the term of EC's under the new law is six year or 65 years of age, Gyanesh Kumar will be retiring in January 2029, just before Lok Sabha election of 2029. Thereafter, Vivek Joshi may become CEC, under whose control Lok Sabha election 2029 will be fought. Under the new law, only CEC has constitutional protection against removal, and ECs do not have any such protection. Their terms will depend on the wish of the CEC and the Government of India.

The level of hope and fear on Vivek Joshi is much higher that on Gyanesh Kumar since, Lok Sabha Election 2019 would most probably be held under his tenure. The 1989 batch Haryana cadre IAS officer, Vivek Joshi has been much loved by the Union Government is well known, especially after he was made chief secretary in November 2024 despite senior officers from the 1990 batch were waiting for their turn.

Assam's historic leap: New Accord cements indigenous rights and cultural safeguards

The recent agreement between the Assam government and the All Assam Students' Union (AASU) to implement 38 out of 52 recommendations of the Justice (Retd.) Biplab Sharma Committee marks a watershed moment in Assam's long-standing quest to safeguard its indigenous identity. This development, centered around Clause 6 of the Assam Accord, promises substantial constitutional, legislative, and administrative reforms aimed at protecting Assamese culture, language, and land rights Clause 6 of the Assam Ac-

cord, signed in 1985 following the Assam Movement (1979-1985), mandates special constitutional safeguards to protect, preserve, and promote the identity of the Assamese people. The movement itself was a result of prolonged agitation against the influx of undocumented immigrants, which Assamese nationalists believed posed an existential threat to the sociopolitical and cultural fabric of the state. However, despite the Accord's signing, the execution of its key provisions remained largely unfulfilled for decades. The recent dialogue between the Assam government and AASU signals a decisive shift toward actualizing these long-delayed promises.

Land Rights and Protection of Indigenous Ownership

One of the most pivotal aspects of the agreement is the safeguarding of land rights for Assam's indigenous communities. The government has decided to designate certain revenue circles modeled after tribal belt blocks, where only individuals who have resided for at least three generations or since 1951 will be eligible to purchase land. This step is a direct response to concerns over demographic shifts and land alienation, which have been at the heart of Assamese political discourse for decades.

Additionally, a comprehensive survey of char (riverine) areas will be conducted to identify illegal settlements. The chief minister clarified that while surveys will proceed, settlement policies will be formulated later through extensive consultations with AASU and other stakeholders. Such a survey is crucial, given that many of these areas have witnessed large-scale encroachments. The government has also announced the establishment of a dedicated tribunal to resolve land ownership disputes, ensuring a legal framework that prioritizes indigenous claims.

In an effort to balance economic growth with indigenous rights, the government will differentiate between prime agricultural land and non-agricultural land. Agricultural land will be protected from indiscriminate commercialization, with restrictions placed on conversion for industrial or commercial use without government approval. This move is expected to prevent large-scale acquisition by corporate entities, ensuring that Assam's agrarian economy remains intact.

Language **Policies:** Strengthening the Assamese Linguistic Identity

Language preservation is another major pillar of the government's implementation plan. Assamese will now be made a mandatory subject in all schools in the Brahmaputra Valley, ensuring that future generations remain connected to their linguistic heritage. In the Bodoland Territorial Region (BTR), both Assamese and Bodo will be compulsory subjects, reinforcing the linguistic diversity of the region while ensuring that indigenous identities are protected.


A landmark decision was also made to introduce Assam's history and geography as a compulsory subject up to Class 8. This measure aims to instill a strong sense of historical awareness among young students, re-

inforcing Assamese identity from an early age.

To further elevate Assamese as the language of governance. the state government has decided that, from April 14 (Bohag Bihu, the Assamese New Year), all official government notifications will be published in both English and Assamese. Additionally, a Directorate of State Languages will be established as an independent regulatory body to oversee the enforcement of language policies. Recognizing the need for lin-

guistic adaptation in the digital era, the government has proposed collaborating with institutions such as Gauhati University and Dibrugarh University to develop an AI-based translation tool. This tool will ensure efficient translation of government documents into Assamese, facilitating wider accessibility and

NATO, economic partnerships with European and Asian allies, and engagement in international organizations have cemented America's leadership in world affairs. However, under Trump's second term Presidency, these traditional alliances came under significant strain. His "America First" approach represented a dramatic departure from the multilateralism that had defined U.S. foreign policy for decades, favouring a more unilateral and transactional approach.

Trump's administration took a "Realist" stance, prioritizing national sovereignty, economic self-interest, and security over diplomatic cooperation. While "Realism", as a school of international relations, underscores the role of power and self-preservation in an anarchic global system, Trump's application of this principle went beyond pragmatic statecraft. His scepticism of NATO, confrontational trade policies, and direct engagement with authoritarian leaders reshaped America's global standing and tested the resilience of long-standing alliances. This shift raised fundamental questions about the future of the international order and whether the damage to these partnerships would be last-

Trump viewed alliances not as enduring commitments based on shared values but as transactional relationships in which the United States should only participate if they provided immediate national benefits. His administration's approach to international agreements underscored this perspective. In 2017, he withdrew the U.S. from the Paris Climate Agreement, arguing that it placed unfair economic burdens on American taxpayers while giving competitive advantages to countries like China. European allies, who had invested diplomatic capital in the deal, saw the move as a retreat from global leadership and a signal that the U.S. was no longer committed to cooperative solutions for pressing global issues.

The following year, Trump further alienated European allies by withdrawing from the Joint Comprehensive Plan of Action (JCPOA), commonly known as the Iran Nuclear Deal. The agreement had been a diplomatic achievement that involved the U.S., the European Union, and other key players in curbing Iran's nuclear ambitions. Despite European objections, Trump unilaterally pulled the U.S. out, citing concerns over Iranian compliance and the agreement's perceived shortcomings. This move deepened transatlantic tensions, forcing European nations to scramble to salvage the deal without U.S. support. The decision reinforced the notion that the U.S. was becoming an unreliable partner, willing to abandon agreements negotiated in good faith.



Nowhere was Trump's scepticism toward alliances more apparent than in his approach to NATO. Since its founding in 1949, NATO has been a pillar of U.S. and European security, ensuring a collective defense against external threats. However, Trump repeatedly criticized the alliance, arguing that the United States was disproportionately shouldering its costs while European members failed to meet their financial commitments. His administration focused heavily on the 2% GDP defense spending target that NATO members had agreed upon, using it as a metric to question the alliance's effectiveness.

While previous U.S. administrations had also encouraged greater burden-sharing, Trump's rhetoric was uniquely confrontational. Pete Hegseth, the US secretary of defence, left European defence ministers in shock during a meeting in Brussels on February 12, 2025, as he unequivocally stated that European security is no longer a primary focus of the United States. French President Emmanuel Macron, who began advocating for greater European defense autonomy. Macron even proposed the formation of a "true European army" to reduce reliance on the U.S. for security.

Trump's questioning of NATO's value aligned with the 'Realist' perspective that alliances should be conditional and serve immediate national interests. However, this stance also undermined trust in U.S. leadership and introduced uncertainty among allies. The long-term strategic consequences of Trump's NATO skepticism were significant. By casting doubt on America's commitment to transatlantic security, he emboldened ad-

versaries such as Russia, which has long sought to exploit divisions within NATO. The instability created by his rhetoric encouraged European nations to rethink their security strategies, though efforts to establish a more independent European defense force faced significant political and economic hurdles.

Trump's trade policies further strained U.S. relations with key allies. His belief in economic nationalism-viewing trade as a zero-sum game-led to tariffs, renegotiations, and disputes that disrupted longstanding agreements. His administration imposed tariffs on steel and aluminum imports from the European Union, Canada, and Japan, citing national security concerns. The decision triggered swift retaliatory measures, escalating tensions and undermining the trust that had defined transatlantic economic

was aimed at countering Beijing's economic rise, it had unintended consequences for U.S. allies. European nations and Asian partners, who had complex trade relationships with both the U.S. and China, found themselves caught in the middle of a growing economic conflict. Rather than building a unified front to challenge China's influence, Trump's approach created rifts within the Western alliance, weakening the effectiveness of a collective economic strategy.

One of Trump's most consequential trade decisions was withdrawing the U.S. from the Trans-Pacific Partnership (TPP), a trade agreement designed to counterbalance China's economic expansion in the Asia-Pacific region. Regional allies such as Japan and Australia had viewed the TPP as a critical component of economic and strategic cooperation. Without U.S. participation, the remaining member states moved forward with a modified deal, reducing American economic influence in the region and leaving a vacuum for China to fill.

Trump's foreign policy also reflected a deep skepticism toward international institutions. He frequently dismissed multilateral organizations as bureaucratic and ineffective, favouring direct negotiations and unilateral actions. A striking example of this came in 2020 when he withdrew the U.S. from the World Health Organization (WHO) during the height of the COVID-19 pandemic. Citing the organization's alleged bias toward China, Trump cut American funding like USAID and withdrew from global coordination efforts. His decision was widely criticized by allies, who saw it as an abdication of U.S. leadership at a critical moment. While Trump framed the move as a defense of national sovereignty, it reinforced the perception that the U.S. was disengaging from international cooperation, further isolating itself from global partners.

Another defining feature of Trump's foreign policy was his engagement with authoritarian leaders, prioritizing strategic and economic interests over democratic values. His administration pursued direct negotiations with President Putin or previously North Korean leader Kim Jong-un, marking an unprecedented level of dialogue between the two nations. While these summits reduced immediate tensions, they yielded no concrete agreements, raising concerns about their long-term effectiveness.

Trump's presidency significantly altered America's relationships with its allies, embracing a 'Realist' approach that prioritized national power, economic self-interest, and unilateral decision-making. While his policies-such as pressuring NATO allies to increase defense spending—aligned with some longstanding U.S. concerns, his confrontational approach weakened diplomatic trust and created greater global uncertainty. How the world treated India's diaspora at the time of its independence

ne of the many lasting consequences of the British colonial rule in the Indian subcontinent was the emergence of a large Indian diaspora across the British Empire. From the South Pacific to the North Atlantic, Indians spread everywhere. To countries such as Fiji, Mauritius and Trinidad, they went mostly as indentured labour. And to countries such as Canada and Australia, they went mainly in search of better opportunities.

A large number of these Indians did not come back, choosing instead to become citizens of their adopted homes. In some countries, they were treated with a degree of fairness, while in others, they faced openly discriminatory policies.

Just two months after India attained independence, Bishwanath Das, a member of the Constituent Assembly representing Orissa, prepared a series of questions about Indians' citizenship rights in Commonwealth countries. In particular, he wanted Jawaharlal Nehru to answer the following in a meeting of the Constituent Assembly on November 21:

"Will the Honourable Prime Minister be pleased to state:

the number of Indians living in other States and Colonies, including the British Commonwealth of Nations (number in such cases to be given separately);

• the States that have conferred Citizenship Rights on Indians;

• the disabilities that are still attached to Indians in each of the States constituting the British Commonwealth of Nations as also the British colonies; and

• the action taken, in each case, by the Government of India with the concerned States and Colonies to confer Citizenship rights on Indians since September 1946?"

The Constituent Assembly was given all this information by Nehru with the

help of the Ministry of External Affairs and Commonwealth Relations. Revisited today, it makes for interesting reading, showing the spread of the Indian diaspora.

'Few disabilities'

Australia, New Zealand and Canada may be sought-after destinations for Indians in the 21st century, but back in 1947, a time when these countries enjoyed Dominion status, they only had a small number of Indians.

In Australia, the Indian diaspora consisted of just 4,544 people, all of whom had citizenship and voting rights, although that did not protect them from official discrimination.

"There are a few disabilities in some of the States," Nehru's statement to the Constituent Assembly said. "E.g.. Certain sections of Widow's Pension Acts, Family Endowment Act and Rural Workers' Accommodation Act of New South Wales discriminate against British Indians as such. In Western Australia there are legal discriminations against British Indians along with other Asiatics and Africans with respect to Crown land, mining, certain occupations and employment."

The statement added that the Indian High Commissioner had been instructed to challenge these injustices and that Western Australia had given a favourable response.

A similar situation to Australia prevailed in Canada. It had an Indian-origin population of 1,500 and every one of them had citizenship rights. But at the provincial level, discrimination was not rare. In British Columbia, for instance, the diaspora had to fight for its right to municipal franchise.

A lot better than Canada and Australia was New Zealand. As the government statement in the Constituent Assembly pointed out, India's 1,200strong diaspora in New Zealand enjoyed "complete equality" of citizenship along with other subjects of the Crown.

Another country where Indians did not face discrimination from the government was the United Kingdom. But there was a question mark over their citizenship after India obtained independence. It was not clear at the time how many Indians living in the UK wanted Indian citizenship and how many wanted British citizenship. Complicating the matter further was the choice of Pakistani citizenship.


"Figures of the total Indian population are not available; but the total number of Indians who fall under well defined categories, like students, pedlars, seamen, professional and businessmen, retired persons, persons on the High Commissioner's staff, persons in domestic, catering and industrial services, is estimated to be between 5,000 and 6,000," the government statement read.

Exploitative system

Unlike in the UK or Canada, most Indians in the Caribbean were descendants of indentured labourers. A grossly exploitative system that replaced slavery, indentured servitude was abolished by the British government in 1917. But while it lasted, it was seen by the colonisers as a source of model immigrants.

In 1903, The Times of London published an article headlined "The Triumph of Trinidad", praising Indian workers while criticising workers of African origin. "The coolies come here under indenture to serve at a fair wage for five years," a correspondent wrote in the newspaper. "At the end of ten years they may, if they please, demand a free return passage home. I am told there is not more than one in five who avails himself of this privilege ... Unlike the negro, who careless of mankind, eats and drinks as long as he has cash and when it is expended turns to for a brief spell of work, the coolie is of a frugal mind."

In 1947, three countries in the Caribbean had sizeable Indian diasporas. Of these, Trinidad (1,70,396 members) and British Guiana (1,68,921) offered full citizenship rights and had no discriminatory laws against Indians.



But Jamaica (26,507) granted citizenship only to Indians who were born there or had lived there for more than 10 years.

Across the Caribbean, Hindus were not allowed to cremate their dead. Nehru's statement in the Constituent Assembly pointed out that literacy levels were low among the Indian community in the Caribbean and that few members of the diaspora held public posts.

Dishonourable mentions

The government statement also spoke of British colonies in Africa and Asia-Oceania, of which South Africa stood out in particular for its discriminatory policies against its 1,82,500strong Indian diaspora.

"Indians are subject to various disabilities in the matter of franchise, immigration and inter-provincial migration, acquisition and occupation of land, facilities for trade, education, marriage, travel, industries and professions, employment in public services, pensions, local Government, arms and ammunition, and various other matters," the statement said. "The Government of India have referred to the treatment of Indians in South Africa to

the United Nations General Assembly." There were other dishonourable mentions too in the government statement. Ceylon, it said, had discriminatory policies against Tamil estate workers. Kenya granted Indians full citizenship but did not let them buy or lease land in the highlands for agriculture, nor did it let them live in many residential areas of Nairobi and Mombasa.

Fiji, which was home to 1,30,000 Indians, gave them citizenship but did not let them buy land from native Fijians and made them pay a so-called residential tax. "Indian children lack adequate educational facilities compared to European and Fijian children," the government statement said. Indians also faced prejudice at the hands of Europeans in Fiji: "it is understood that Indian residents are not allowed admission in European-managed hotels and clubs or public playgrounds." The government said it had flagged the grievances of Indian sugarcane farmers, who were tenants of the Sugar Refining Company.

In Africa, at least three countries did not officially discriminate against Indians: Tanganyika (38,500-member diaspora), Uganda (25,972), and Zanzibar (16,000). These colonies did not have a system of elections, so Indians were nominated to their legislative councils.


Nehru's statement in the Constituent Assembly listed 11 territories where the government had no information about the diaspora's citizenship status, including Hong Kong (1,900 Indians), St. Lucia (2,189), Grenada (5,000), British Honduras (8,000), British Somaliland (520) and Aden (9,456).

Just three months into independence, there was not much more India could do besides using its high commissions to engage with the local authorities. The new India-US security compact

As states transition in economic heft, power, and influence, so do their relationships. Most starkly, this is visible in the changing nature of their ties with great powers. On the contrary, the recalibrations by great powers themselves have implicit success stories about growing powers, not just one of accommodation but increasingly, compulsion. While the United States (US) has remained a constant paradigm of growth, influence, and both soft and hard power for over threequarters of the last century, China and India have presented two very contrasting pictures of the kind of relationship rising states have with the preeminent power of the world. China's growth in the last three decades, in many ways, was facilitated by the US's role as the global security guarantor. Now, China and the US are fundamentally locked in a great power competition, with almost every aspect of the contest speeding towards a downward spiral. Three factors have intensified this trend. First, rapid shifts in American social and political choices and patterns domestically have altered how America thinks of its security and role in the world. Second, the US wants to retain its numero uno position even as China is hurtling from behind in the most critical of domains that underscore this great power competition. China's transformation of its naval power brings unprecedented pressure onto the Indo-Pacific countries and in the tacit spread of its economic tentacles throughout the world. compelling a reassessment of the metrics of the global power dynamic. Finally, a new tech race, which is beginning to unravel and will likely shape the course of great power competition in the next few decades, has enforced an order of multilateral accommodation of rising powers upon the US. Together, these have led to a new utilitarian view of security, power and influence in Washington. India is at the helm in that reassessment of Washington. When the Indian Prime Minister, Narendra Modi, visited the US to meet with his counterpart, President Donald Trump, on 13-14 February 2025, camaraderie, nostalgia, optics, and pragmatism seemed to roll into one. Keen observers of the India-US relationship were expecting Trump to give a new imprint to the bilateral relationship and not simply conform to the existing paradigms of continuity in bilateral ties. The barely 40-hour trip saw a new US-India COMPACT (Catalyzing Opportunities for Military Partnership, Accelerated Commerce & Technology) agreement, which aims to serve as the new broad framework for combining cooperation in defence, trade, energy security, technology and innovation, people-to-people ties, and multilateral cooperation. For the last two decades, the India-US defence ties based itself on the continued momentum provided by the 2005 Framework for the US-India Defence Relationship which promised "setting the US and India on a path to increasingly broad, complex, and strategic cooperation" and the subsequent 10-year framework signed in June 2015 which provided "avenues for high-level strategic discussions, continued exchanges between armed forces of both countries, and strengthening of defence capabilities." The latest extension of the framework is reflective of the expansive nature of defence ties between the US and India, especially in its increasing importance for cooperation in the transfer of sensitive technologies and strategic trust. 'Why does the government present the same words differently in each budget?'

While rejecting Keynesian economics and adopting neoliberal policies, major proponents of the international market claimed that when the market fails, the government should withdraw and leave the responsibility to private investors. Along with this claim, there was another assertion that the international market could never fail or disappoint. But is this a reality or merely a slogan? We witnessed its truth when the world went through the biggest economic crisis of the century in 2008 and has not fully recovered yet. Similarly, in 1997-98, the economies of the Asian Tigers (Singapore, Hong Kong, Taiwan, and Thailand), which had fully embraced the new economic policies, completely collapsed.

With the announcement of the budget, econoists have started analyzing its implications Many have stated in their analyses that the budget favors the wealthy, reduces public spending, and encourages foreign investment. However, there is nothing new in this. This trend has been consistently increasing in every budget. The narrative of "controlling inflation" in the name of economic innovation is repeatedly emphasized. But why does this keep happening? Why does the government continue to present the same words in different ways in each budget? Our Prime Minister and Finance Minister always provide a simple and straightforward answer that resonates with the citizens: this will make India a major global economy, attract large companies to invest here, and strengthen our economy. In this article, I will try to explore these three points, not just by superficially looking at the current budget figures. In the next article, we will discuss this with the relevant data. In 1943, an economist named Kalecki made a statement similar to Karl Marx's concept of the "reserve army of labor." He said that in the future, to control labor demand and suppress dissenters, a cyclical economy of unemployment would be maintained, leading to mass layoffs and a consistently high demand for labor in the job market. This would compel workers to accept lower wages. How could this economist foresee such a scenario 30 years ahead, and how could Marx predict events 200 years into the future? This demonstrates that the ideological framework used to formulate economic policies determines whose interests are prioritized. Therefore, it is not enough to merely say that a government is making economic policy; it is crucial to understand for whose benefit these policies are being made. Incidentally, Kalecki made this claim when major European countries were following Keynesian economics. At the core of Keynesian economics was the domestic market, focusing on increasing domestic demand and managing it to stimulate job creation and enhance purchasing power. However, this system largely controlled external influences, particularly foreign financial capital. The notion that external financial capital is essential for development was already dismissed by Russia when it became one of the world's largest economies within 10-12 years after the 1917 revolution. Keynesian economics helped revive the American economy and was followed by a period when nations emphasized internal consolidation. However, this was not favorable to foreign financial capital. Therefore, in 1944, the General Agreement on Tariffs and Trade (GATT), now known as the World Trade Organization (WTO), and the International Monetary Fund (IMF) were established. Their primary objective was to open national borders for international trade and operate economies under market control. They got their opportunity when the Middle East war in the early 1970s caused a sharp rise in oil prices, raising questions about Keynesian economics and



year for the US-India Major Defence Partnership in the 21st Century, as the one signed in 2015 nears its culmination. Importantly, the new framework weaves in India's Major Defence Partner (MDP) status to ensure that new technology access and supply guarantees in the area of defence and security can be part of a sustained process over the next decade.

A path that was set for the India-US defence cooperation in 2005 has required a new thrust every 10 years to accommodate new priorities. The latest iteration has placed the expansion of defence industrial cooperation, coproduction, and interoperability at the heart of bilateral defence ties. Among key plans to speed up supplies for India's defence requirements, India and the US have announced that they will pursue new procurements and co-production arrangements for 'Javelin' Anti-Tank Guided Missiles and 'Stryker' Infantry Combat Vehicles in India this year. Besides, the procurement of six additional P-8I Maritime Patrol aircraft is likely to boost India's Intelligence, Surveillance and Reconnaissance (ISR) capabilities in the expanse of the Indo-Pacific region.

The second Trump administration has clearly taken a long view of the security ties with India, wherein the focus of the planned steps is to further integrate bilateral security ties by making them deeply structural. A wider leveraging of India's MDP status through the Strategic Trade Authorisation-1 (STA-1) authorisation; initiating negotiations for a Reciprocal Defence Procurement (RDP) agreement to enhance bilateral procurement channels and establish well-oiled reciprocal supply lines for defence goods and services; and reviewing arms transfer regulations, including the International Traffic in Arms Regulations (ITAR), are all geared towards fostering deeper integration, interoperability, and co-production.

Given the lessons learnt over the past five years—both on and off the battlefield—it was rather incumbent upon Modi and Trump to outline a roadmap for the next decade. The importance of autonomous systems to the future of warfare and security is one such domain. India and the US announced the Autonomous Systems Industry Alliance (ASIA), a new initiative seeking to augment industry partnerships and production in the Indo-Pacific region. Partnerships between Indian and US companies for coproducing maritime systems and AI-enabled counter Unmanned Aerial System (UAS) could be useful for both countering and establishing Perhaps most importantly, India and the US have broken 'new ground' by announcing their intention to "support and sustain the overseas deployments of the US and Indian militaries in the Indo-Pacific"—a significant joint security commitment to the region. These deployments could reshape how India and the US approach regional security in the Indo-Pacific by enhancing cooperation in logistics, intelligence sharing, force mobility for joint humanitarian and disaster relief operations, and, most importantly, for countering common threats from the Gulf to the Far East.

There were several other announcements in the field of technology, innovation, energy security, space and people-to-people ties, which all feed into the new security compact between the two countries. However, three trends in the India-US bilateral as well as their multilateral cooperation framework stood out in the joint statement. The Indian Ocean will be a key domain in the Indo-US cooperation. The launch of the Indian Ocean Strategic Venture-a bilateral initiative to advance coordinated investments in economic connectivity and commerce-along with Meta's ambitious 50,000-kilometre undersea cable project, underscores a longterm commitment to connect and strengthen global digital infrastructure and regional security. Second. Modi's visit underscored that the commitment of both India and the US to the importance of the Quad framework in the Indo-Pacific remains resolute. And finally, a key convergence point in this new bilateral compact between India and the US is connectivity projects. The India-Middle East-Europe Economic Corridor (IMEC) aims to serve as the next transregional connectivity project which could reroute energy supply chains. However, its success remains contingent on the geopolitical externalities of the Middle East

Speaking at the Munich Security Conference, US Vice President J.D. Vance emphasised that America expects Europe to take on a greater security role, allowing Washington to focus on other critical regions. The implicit message was clear: Indo-Pacific security and the challenge posed by China remain top priorities for the US. Despite concerns that a second Trump administration might scale back America's global security commitments, its strategic competition with China is set to continue. A confident Trump administration views India as a crucial partner in advancing its strategic objectives while recalibrating America's role on the global stage. (Courtesy: ORF)



leading to trade deficits. Some international analysts believe that the U.S.-sponsored war in the Middle East aimed to expose the limitations of Keynesian economics and prepare the world for neoliberal policies—a mission they successfully accomplished.

Why was it necessary to completely reject Keynesian economics for neoliberal policies? The first reason is that Keynesianism promoted a closed or highly restricted economy, limiting external control. Second, it prioritized social welfare over private interests to some extent, which was against the interests of large private investors. If private investors spent more on the labor market, it would reduce their profits, which they did not want. Third, inclusive economic policies that consider all social strata reduce the chances of establishing economic monopolies.

These three reasons clarify how economic policies in the world, especially in semi-colonial countries, have shifted. Monetarism—where inflation control is prioritized while ignoring the employment market—became a global trend in the 1980s but became evident in India in the 1990s. Under this policy, domestic expenditure was curtailed under international pressure to control fiscal deficits, deliberately increasing unemployment and discrediting the old system. During this period, the Fiscal Responsibility and Budget Management (FRBM) Bill was passed, reducing domestic financial expenditure. This process continued with various sectors being opened to foreign investment.

Every government made promises of better employment but never delivered, keeping public attention focused on GDP growth. Meanwhile, the beneficiaries of these policies remained unclear. Later, economists like Layard, Nickell, and Jackman tried to normalize unemployment by introducing the "natural rate of unemployment" theory. However, one question remains: Why was inflation control prioritized while maintaining fiscal balance? Rising inflation indicates an unsuitable investment environment, making it less attractive to foreign investors. Therefore, the government focused on controlling inflation to promote "easy money" (foreign investment).

This new system set new standards of development, shifting focus from domestic demand and employment to increasing exports for higher profits. This benefited large corporations in two ways: they received a free hand in increasing production by investing in semi-colonial countries, and they could easily move to tax havens whenever major countries increased tax rates. These "footloose" companies could comfortably shift to regions willing to do anything for investment.

KHAN YOUNIS (GAZA STRIP), Feb 20: Hamas on Thursday released the bodies of four Israeli hostages, said to include a mother and her two children who have long been feared dead and had come to embody the nation's agony following the Oct 7. 2023. attack.

The remains were said to be of Shiri Bibas and her two children, Ariel and Kfir, as well as Oded Lifshitz, who was 83 when he was abducted. Kfir, who was 9 months old when he was taken, was the youngest captive. Hamas has said all four were killed along with their guards in Israeli airstrikes.

The militants displayed four black coffins on a stage in the Gaza Strip surrounded by banners, including a large one depicting Prime Minister Benjamin Netanyahu as a vampire. The fighters then carried the coffins over to Red Cross vehicles, where staffers in red vests covered them in white sheets before placing them inside.

The Red Cross convoy headed back to Israel, where authorities will carry out the formal identification of the remains using DNA, expected to take up to two days. Only then will the families be given the final notification. The Israeli military confirmed it had received the coffins.

Relatives in Israel have clung to hope, marking Kfir's first and second birthdays and his brother's fifth. The Bibas family said in a statement Wednesday that it would wait for "identification procedures" before acknowledging that their loved ones were dead.

Like the Bibas family, Oded Lifshitz was abducted from Kibbutz Nir Oz, along with his wife Yocheved, who was freed during a weeklong ceasefire in November 2023. Oded was a journalist who campaigned for the recognition of Palestinian rights and peace between Arabs and Jews.

Hamas-led militants abducted 251 hostages, including some 30 children, in the Oct 7 attack, in which they also killed some 1,200 people, mostly civilians.

More than half the hostages, and most of the women and children, have been released in ceasefire agreements or other deals. Israeli

forces have rescued eight and have recovered dozens of bodies of people killed in the initial attack or who died in captivity.

Hamas is set to free six living hostages on Saturday in exchange for hundreds of Palestinian prisoners, and says it will release four more bodies next week, completing the ceasefire's first phase. the remaining captives without a lasting ceasefire and a full Israeli withdrawal. Netanyahu, with the full backing of the Trump administration, says he is committed to destroying Hamas' military and governing capacities and returning all the hostages, goals widely seen as mutually exclusive.

Trump's proposal to remove some 2 million Palestinians from Gaza so the U.S. can own and rebuild it, which has been welcomed by Netanyahu but universally rejected by Palestinians and Arab countries, has thrown the ceasefire into further doubt. Italy PM Meloni visits pope in hospital, says he's in good spirits as tests show slight improvement

ROME, Feb 20: Italian Premier Giorgia Meloni visited Pope Francis for 20 minutes in the hospital on Wednesday and reported he was "alert and responsive" and full of good humour, despite his diagnosis of pneumonia and a complicated bronchial infection that has sidelined the 88-year-old pontiff for six days.

The Vatican said Francis' overall condition remained stationary but that blood tests showed a "slight improvement" in key inflammation indices. Francis also worked in the afternoon with his collaborators, the Vatican said in a late statement.

Meloni said she wanted to bring get-well wishes to the pope on behalf of the government and entire nation. "We joked around as always. He has not lost his proverbial sense of humour," she said in a statement issued by her office.

Meloni is the first confirmed outside visitor known to have called on the pope, beyond his secretaries and medical team, since his admission on Friday at Rome's Gemelli hospital, where popes have their own suite on the 10th floor

The Vatican has said Francis was up, eating and had gotten out of bed after a tranquil night, a day after tests confirmed he had pneumonia in both lungs on top of asthmatic bronchitis.

The Italian premier, who came to power in 2022 with a message touting her Christian credentials, has referred in glowing terms to

the influence on her of Popes John Paul II and Benedict XVI, both reference points for European conservatives like herself. While she and Francis don't see eye-to-eye on her crackdown on migrants, they have teamed up constructively on a campaign to reverse Italy's low birthrate.

Her visit came as prayers were pouring in for Francis' recovery. Francis also received another get-well wish from US Vice-President JD Vance, whom the pope recently targeted in criticising the Trump administration' s plans for mass deportations of migrants. "Let's all say a prayer for Pope Francis, who appears to have some serious health issues," Vance, a

Bronchitis can lead to pneumonia, which is a deeper and far more serious infection of the lungs' air sacs. Pneumonia can develop in part or all of one lung or in both lungs. It tends to be more serious when both lungs are affected because there isn't healthy tissue to compensate.

Treatment varies by severity but can include providing oxygen through a nasal tube or mask, intravenous fluids -- and treatment of the underlying cause of the infection. To date, Francis is breathing on his own and his heart function is said to be good. He has eaten breakfast every day, gotten out of bed, read the newspapers and done some work from his hospital room

The Vatican hasn't provided any information about how Francis is responding to any of the drugs he has been given other than to say he isn't running a fever. The Argentine pope, who has previously admitted to being a non-compliant patient, has a number of conditions that make him particularly at risk for complications: Aside from his age, he is not physically active and uses a wheelchair, limiting his ability to clear the fluids building up in his lungs.

Dr Meredith McCormack, director of pulmonary and critical care medicine at Johns Hopkins University, said doctors will be looking to see if Francis responds to the therapy, which can include physiotherapy to help clear the lungs. Severe cases of pneumonia are typically treated for about one to two weeks, but recovery in an older person could extend beyond that.

"Lack of worsening would be an encouraging sign," said McCormack, who is not involved in Francis' care. The Vatican has given no indication of how long the pope might remain hospitalised, only saying that the treatment of such a

Senate GOP budget bill back on track hours after Trump threw it into turmoil

WASHINGTON, Feb 20: Back on track, Senate Republicans pushed ahead on Wednesday with their USD 340 billion budget bill focused on funding the White House's mass deportations and border security agenda after Vice-President JD Vance gave a green light to proceed despite a morning dust-up caused by President Donald Trump.

The package was in jeopardy after Trump publicly bashed the approach from the Senate Budget Committee chairman, Sen Lindsey Graham of South Carolina. Trump said he favoured the "big beautiful bill" from House Republicans, a more politically fraught package that includes USD 4.5 trillion in tax cuts but slashes government programmes and services. Senators want to address those priorities later, in a second package.

"We are moving forward," said Sen John Barrasso of Wyoming, the GOP whip, after a lunch meeting with Vance at the Capitol.

The start-stop process is complicating what's already a heavy legislative lift for Republicans, who have a rare sweep of power with majority control of Congress, but face big hurdles enacting Trump's agenda as Democrats prepare to counter with steep objections at

every step. Ongoing GOP divisions over whether to do one package or two -- the House thinks they can only muscle one package to passage, while the Senate believes two will be easier -- has created a push-pull dynamic that Trump is leveraging as he goads the two chambers of Congress to compete with each other.

Trump, in his own private talks with the senators, including last weekend at Mar-a-Lago, has essentially told them just to "get the result". It all comes as Democrats, without the votes to stop Trump's plans, are warning Americans what's at stake.

"These bills that they have one purpose -- and that is they're trying to give a tax break to their billionaire buddies and have you, the average American person, pay for it," Senate Democratic leader Chuck Schumer of New York told AP.

Schumer convened a private call over the weekend with Democratic senators and agreed on a strategy to challenge Republicans for prioritising tax cuts that primarily flow to the wealthy at the expense of programme and service reductions in health care, scientific research, veterans services and elsewhere. ABU DHABI, Feb 20: US Secretary of State nature of the relationship, one marked by strong Marco Rubio met Wednesday with the leader of the United Arab Emirates, wrapping up an overseas trip that saw the highest-level outreach between the United States and Russia since Moscow launched its full-scale invasion of Ukraine in 2022.

Rubio's talk with Sheikh Mohammed bin Zayed Al Nahyan, also the ruler of Abu Dhabi, comes as the US also tries to continue a shaky ceasefire in the Gaza Strip between Israel and the militant Hamas group.

The UAE, which diplomatically recognised Israel in 2020 during President Donald Trump's first term, also has been key in mediating prisoner swaps between Russia and Ukraine. Ukraine's President Volodymyr Zelenskyy met with Sheikh Mohammed on Monday. Rubio offered his thanks in the meeting to the UAE "for the strength and enduring

economic ties, defense cooperation and mutual interests in regional stability," State Department spokesperson Tammy Bruce said in a statement. The meeting included discussions on artificial intelligence, the Gaza Strip, Syria, Lebanon and the Red Sea, which had been the site of attacks by

Yemen's Houthi rebels until the Gaza ceasefire, Bruce added. The UAE's readout focused on comments over

the Gaza Strip and the Palestinians during the meeting between Rubio, Sheikh Mohammed and Sheikh Abdullah bin Zayed Al Nahyan, the UAE's foreign minister, that lasted roughly 30 minutes.

The state-run WAM news agency reported Sheikh Mohammed had told Rubio "that the UAE strongly opposes any attempt to displace the Palestinian people from Gaza." (AP)

PANAMA CITY, Feb 20: Panama has informed India about the safe arrival of a group of Indians deported from the US and the Indian mission in the country is working closely with the host government to ensure their wellbeing after obtaining consular access to them.

The Embassy of India in Panama, Costa Rica & Nicaragua took to X on Thursday to share the information but did not provide data on the number of Indians arriving in Panama. The group of Indians is part of a larger group of 299 migrants sent to Panama by the US government.

These people arrived in the country on three flights last week after President Jose Raul Mulino agreed that Panama would become a "bridge" country for deportees.

The Trump administration has pledged to deport millions of people who crossed illegally into the US.

"Panamanian authorities have informed us that a group of Indians have reached Panama from the US," the Embassy of India in Panama, Nicaragua and Costa Rica posted on X.

"They are safe and secure at a Hotel with all essential facilities. The embassy team has obtained consular access We are working closely with the host Government to ensure their wellbeing," it said.

Three batches comprising a total of 332 Indians have already been sent back to India from the US amid an intensified crackdown by the Trump administration against illegal immigrants. (PTI)

South Korea's Yoon in court for hearing in his criminal trial

SEOUL, Feb 20: South Korean President Yoon Suk Yeol appeared in court on Thursday for a hearing where his lawyers contested his arrest on a criminal charge alleging he was orchestrating a rebellion when he briefly imposed martial law in December.

Security was heightened as the motorcade transporting Yoon arrived at the Seoul Central District Court and dozens of his supporters rallied nearby. The preliminary hearing will involve discussions of witnesses and other preparations for his criminal trial, and the court was also to review the request by Yoon's lawyers to cancel his arrest and release him from custody. Such challenges are rarely successful.

Yoon was indicted January 26 on the rebellion charge carrying a potential punishment of death or life in prison. In South Korea, presidents have immunity from most criminal prosecutions but not on charges of rebellion or treason.

The indictment alleges his imposition of martial law was an illegal attempt to shut down the National Assembly and arrest politicians and election authorities. (AP)

US Agriculture Department tries to rehire fired workers tied to bird flu response

OMAHA, Feb 20: The Agriculture Department is scrambling to rehire several workers who were involved in the US government's response to the ongoing bird flu outbreak that has devastated egg and poultry farms over the past three years.

The workers were among the thousands of federal employees eliminated on the recommendations of billionaire Elon Musk 's Department of Government Efficiency that is working to carry out Trump's promise to streamline and reshape the federal government. Republican Rep Don Bacon said the administration should be more

careful in how it carries out the cuts. "While President Trump is fulfilling his promise to shed light on

waste, fraud, and abuse in government, DOGE needs to measure twice and cut once. Downsizing decisions must be narrowly tailored to preserve critical missions," said Bacon, who represents

a swing district in Nebraska.

The bird flu outbreak has prompted the slaughter of roughly 160 million birds to help control the virus since the outbreak began in 2022. Most of the birds killed were egg-laying chickens, so that has driven egg prices up to a record high of USD 4.95 per dozen on average. The federal government has spent nearly USD 2 billion on the response, including nearly USD 1.2 billion in pay-

ments to farmers to compensate them for their lost birds.

A USDA spokesperson said the department "continues to prioritise the response to highly pathogenic avian influenza (HPAI)" and several key jobs like veterinarians, animal health technicians and other emergency response personnel involved in the effort were protected from the cuts. But some employees of the USDA's Animal and Plant Health Inspection Service were

"Although several APHIS positions supporting HPAI were notified of their terminations over the weekend, we are working to swiftly rectify the situation and rescind those letters," the department spokesperson said.

Politico and NBC News reported that the jobs that were eliminated were part of an office that helps oversee the national network of labs USDA relies on to confirm cases of bird flu and other animal diseases. It wasn't immediately clear how many workers the department might be trying to rehire and whether any of them worked at the main USDA lab in Ames,

Iowa. Trump administration officials said this week that the USDA might change its approach to the bird flu outbreak, so that maybe entire flocks wouldn't have to be slaughtered when the disease is found, but they have yet to offer many details of their plan. (AP)

UGC draft regulations will bring higher education under those promoting communal ideology: Kerala CM

THIRUVANANTHAPURAM, Feb 20: Kerala Chief Minister Pinarayi Vijayan on Thursday said the 'Draft UGC regulations 2025' was part of the efforts to place higher education "under the control of those promoting religious and communal ideologies" and therefore, "it cannot be allowed to pass".

After inaugurating a National Convention on these regulations here, chief minister said the guidelines were aimed at not only diminishing the role of state governments in higher education but also completely sidelining them.

He said that under the draft regulations, the states have no role in the appointment of vice chancellors (VCs) and assistant professors in state-established universities and termed them as "undemocratic and excessive"


Vijayan said that this was despite the fact the the state governments fund nearly 80 per cent of the expenses for running varsities and other higher educational institutions.

He further said that there was every possibility of the present po-



litical dispensation at the centre substituting people with academic excellence by those of political choice," as has happened in many iconic institutions, ranging from the Pune Film Institute to the ICHR"

"The approach of appointing Vice-Chancellors from outside academia, even from the private sector, needs to be seen as an attempt to commercialise higher education," he asserted.



"Even at the helm of research institutes we have those peddling falsehoods and superstitions as facts and scientific truths. Yet, the Draft Regulations do not seem to worry about these dangerous trends

that are creeping into our higher education sector, which will undoubtedly send us backwards," he said.

Referring to the concerns he has regarding the regulations, CM said that powers for appointing VCs have been given to Chancellors, who are the Governors appointed by the Centre.

"If the Chancellor can appoint anyone from a panel, undoubtedly the appointment will be at the behest of the political powers that have appointed the Governor, as in almost all state universities, Governors are Chancellors. Such politically motivated interventions can seriously impinge upon the standards of higher education in the country," he said.

Vijayan claimed that "gubernatorial excesses" were experienced by many opposition-ruled states including Punjab, Tamil Nadu, Telangana and Kerala, in the country.

The CM also highlighted his government's experience with Arif Mohammed Khan as a governor and how he had declined assent to various bills related to the administration of universities in the state,

"Over the years, we have seen the Union government repeatedly enact laws that encroach upon the states' powers and duties in several sectors, even on law and order, which is absolutely in the States List in the Constitution," Vijayan said.

The CM also raised the issue of the Centre allegedly eating into the states' financial resources as "share of Union allocation for their own schemes was coming down yearafter-year, with the state governments having to chip in more-and-more". LUCKNOW, Feb 20: Bahujan Samaj Party (BSP) supremo Mayawati on Thursday criticized Uttar Pradesh's budget for the financial year 2025-26 and said it lacked emphasis on public welfare such as inflation, poverty, unemployment and the basic needs of the common man.

In a series of posts on 'X', Mayawati said, "If the budget had been more about the wider public interest and public welfare, it would have been better. There is a clear lack of adequate government intention and policy towards eliminating inflation, poverty, unemployment and backwardness. How is true development possible?

The former Uttar Pradesh chief minister criticized the budget presented by Yogi Adityanath government as being more focused on appeasing the well-off middle class rather than addressing the needs of the broader population.

Mayawati said the core responsibility of any government should be to fulfil the objectives of "Sarvajan Hitaya" (welfare of all) and "Sarvajan Sukhaya" (happiness for all) by

tackling poverty and improving the living conditions of millions of families in the state.

It is a matter of concern that this is not happening," she added in her post.

The BSP chief criticized the state government's approach and said offering "other dreams" is not the solution to these fundamental issues.

NEW DELHI, Feb 20: Five, including the chief minister, out of seven newly sworn-in ministers in Delhi have declared criminal cases against themselves, while two are billionaires, according to poll rights body Association for Democratic Reforms.

The findings are based on the self-sworn affidavits submitted by the ministers ahead of the 2025 Delhi Assembly Elections.

According to the analysis by the ADR, five out of seven ministers (71 per cent) have declared criminal cases against themselves, while two ministers (29 per cent) are billionaires. The report highlighted that five ministers, including Chief Minister Rekha Gupta, have declared criminal cases against themselves.

Among them, one minister, Ashish Sood, faces serious criminal charges On the financial front, two min-

The average assets of the seven ministers analysed stand at ₹ 56.03 crores. All seven ministers have declared liabilities, with Parvesh Sahib Singh of the New Delhi constituency having the highest liabilities at ₹ 74.36 crores.

Six ministers (86 per cent) have declared educational qualifications of graduate level or above, while one minister has completed only the 12th standard.

In terms of age, five ministers (71 per cent) are between 41 and 50 years old, while the remaining two (29 per cent) are aged between 51 and 60 years. The cabinet includes isters, accounting for 29 per cent of only one woman minister which is the chief minister herself. (PTI)

HT Correspondent BHUBANESWAR, Feb 20: Siksha 'O' Anusandhan (SOA) deemed to be university has got a significant achievement by finding place among four institutions in India in the Times Higher Education (THE) World Reputation Rankings 2025. The list, which includes Indian

Institute of Science, Bengaluru, Indian Institute of Technology-Delhi and Indian Institute of Technology-Madras besides SOA, was published on Tuesday.

Only four institutions in India have been included in the list of which SOA is the lone private institution. All the four institutions were positioned in the 201-300 brackets in the ranking. They had ranked 300 institutions from 38 countries this year using a revamped methodology.

Harvard University has been ranked first in the list this year among the institutions worldwide for the 14th consecutive year followed by Massachusetts Institute of Technology (MIT) and University of Oxford (joint 2nd), Stanford University and University of Cambridge (joint 4th).

SOA was ranked 14th in the country among universities by the National Institutional Ranking Framework (NIRF) in 2024 while it was accredited by National Assessment and Accreditation Council (NAAC) with highest Grade A++.

It has been conferred with Category-I Graded Autonomy Status by the University Grants Commission (UGC) in 2022

The university has also been globally placed in the QS and THE world university rankings.

Odisha plans to construct 16 dams. 15 barrages on Mahanadi river: CM does not believe in Constitution: Dhami

BHUBANESWAR, Feb 20: Odisha Chief Minister Mohan Charan Majhi on Thursday informed the state assembly that 16 dam and 15 barrage projects have been planned for securing sustainable water development with equity for Mahanadi waters in the interest of the state.

In a written reply to a query by BJD legislator Ranendra Pratap Swain, the chief minister said, "Due to excess unplanned use of Mahanadi water in the upstream catchment of Mahanadi basin by Chhattisgarh, flow of water to the downstream of Odisha is gradually reducing as observed at Hirakud dam site located near the interstate border of Chhattisgarh and Odisha."

To this effect, the state has taken the shelter of the Mahanadi Water Dispute Tribunal and filed its claims through a number of pleadings and the matter is now sub-judice, he said.

Similarly, in another written statement to the House, Majhi informed that the government has also planned to build 41 in-stream storage structures on Mahanadi river.

Prasanna Acharya, BJD deputy leader in Assembly, had raised the issue during Question Hour. Acharya said that the Chhattisgarh government has constructed 8 or 9 barrages on the upper basin area of Mahanadi river, due to which, water flow in the river at the starting point in Odisha drastically reduced during summer. (PTI)

DEHRADUN, Feb 20: Uttarakhand Chief Minister Pushkar Singh Dhami on Thursday accused the Congress of spreading myths about the Uniform Civil Code as it does not believe in the Constitution and supports atrocities against women.

On Congress' opposition to the UCC's provision regarding compulsory registration of live-in relationships, he said it is meant for the safety of partners in such a relationship.

The Congress has been vehemently opposing the UCC especially because of its provisions regarding mandatory registration of live-in relationship as it looks upon the clause as an infringement on people's right to privacy.

Registration of live-in relationships will keep the authorities and parents of partners in such a relationship informed about them because many such alliances become abusive and sometimes even turn violent, Dhami told a press conference at the state assembly here.

Citing the brutal murder few years ago of Shraddha Walkar by her live-in partner Aftab who chopped her

into pieces, kept her body parts in a fridge and disposed them gradually, Dhami said mandatory registration of live-in relationships and availability of their records with authorities will guard against such eventualities.

"Congress is spreading these myths about the UCC because it does not believe in Ambedkar's Constitution and wants to give protection to perpetration of atrocities against women," he said.

Another myth being spread by the detractors of UCC is that if a man from outside Uttarakhand marries a girl from here he will get the rights of an original inhabitant of the state, Dhami said.

"These are all unfounded rumours being spread to mislead the people," he said.

The UCC was drafted after widespread consultations with a cross section of people. Every political party was invited to the dialogues including the Congress, Dhami said

He said the credit goes to the people of Uttarakhand for making it the first state in independent India to implement the UCC. (PTI)

Govt updates scheme to provide free coaching for PM CARES beneficiaries

NEW DELHI, Feb 20: The go ernment has introduced an updated scheme to provide high-quality coaching to children covered under the PM CARES scheme along with students from Scheduled Castes (SCs) and Other Backward Classes (OBCs).

Originally launched during the Sixth Five-Year Plan, the free coaching scheme has undergone multiple revisions over the years to enhance its effectiveness.

The latest update extends its benefits to PM CARES beneficiaries, removing caste and income-related restrictions for these students.

Under the scheme, students will receive coaching for a wide range of competitive examinations, according to the guidelines of the updated scheme.

These include Civil Services examinations conducted by the Union Service Commission Public (UPSC) and State Public Service Commissions, as well as officergrade recruitment tests for banks, insurance companies, and public sector undertakings (PSUs).

Justice Anup Jairam Bhambhani referred to the Supreme Court's verdicts in Pankaj Bansal, Prabir Purkayastha and Vihaan Kumar, which he said were founded on Article 22(1) of the Constitution of India. Therefore, the court said there remained "no doubt that the requirement of serving grounds of arrest in writing to an arrestee is compulsory and unquestionable regardless of whether an arrest has been made under the PMLA or the UAPA or under any other criminal statute"

"Moreover, the burden to prove compliance with the requirements of Article 22(1) of the Constitution always rests with the investigating agency," added the high court.

Article 22(1) prescribes that no person who is arrested should be detained in custody without being

informed, as soon as may be, of the grounds for such arrest nor shall he be denied the right to consult, and to be defended by, a legal practitioner of his choice"

While granting the relief to Singh, the court also quashed the arrests of "lieutenant colonel" Laimavum Anand Sharma, the head of the organisation's intelligence department, and organisation's member Ibomcha Meite, who were picked up by the National Investigation Agency from Manipur and brought to Delhi.

"The arrest of all three petitioners on March 13, 2024 is accordingly vitiated and is hereby set-aside. Consequently, the remand order dated March 14, 2024 and all subsequent remand orders passed by the special court are also quashed," held the court. The trio was directed to be re-

SC stays Lokpal order to entertain complaints against sitting HC judge, says its 'very disturbing'

(CDS).

NEW DELHI, Feb 20: The Supreme Court on Thursday stayed the Lokpal order entertaining complaints against a sitting high court judge, terming it "something very, very disturbing" and concerning the independence of the judiciary.

A special bench headed by Justice B R Gavai issued notice and sought responses from the Centre, the Lokpal registrar and the person who has filed complaints against the sitting high court judge.

Solicitor General Tushar Mehta, appearing for the Centre, said a high court judge would never fall within the ambit of the Lokpal and Lokayuktas Act, 2013.

The bench, also comprising Justices Surya Kant and Abhay S Oka, issued an injunction to prevent the complainant from disclosing the name of the judge and directed him to keep the complaint filed by him confidential. The apex court was dealing with a suo motu proceedings initiated over the January 27 order passed by the Lokpal.

"Issue notice to the Union of India, the registrar of Lokpal and the complainant. The registrar (judicial) is directed to mask the identity of the complainant and serve him through the registrar (judicial) of the high court where the complainant resides," it said.

"In the meantime, there shall be stay to the impugned order," the

to directions of the chief justice of India.

The bench noted that Sibal and another senior advocate had offered to assist the court "since the matter is of a great significance concerning the independence of judiciary".

"Once the finding that the Lokpal has a jurisdiction stands stayed, I think they are aware what are the ramifications of this order. If they don't understand this, then we are here," Justice Gavai observed.

The Lokpal passed the order on two complaints filed against a sitting additional judge of the high court. The complaints alleged that he influenced an additional district judge in the state and a judge of the same high court who had to deal with the suit filed against the complainant by a private company to favour that firm.

It was alleged that the private company was earlier a client of the named high court judge while he was practising as an advocate at the Bar. In its order, the Lokpal directed the complaints and relevant materials received in its registry in two matters be forwarded to the office of the CJI for his kind consideration.

"Awaiting the guidance of the Chief Justice of India, consideration of these complaints, for the time being, is deferred until four weeks from today, keeping in mind the statutory time frame to dispose of the complaint in terms of Section 20 (4) of the Act of 2013. "We make it amply clear that by this order we have decided a singular issue finally -- as to whether the judges of the high court established by an Act of Parliament come within the ambit of Section 14 of the Act of 2013, in the affirmative. No more and no less. In that, we have not looked into or examined the merits of the allegations at all," the Lokpal bench headed by Justice The bench said the matter would A M Khanwilkar said on January 27. (PTI)

Police station in Mumbai becomes home for Pakistani national awaiting deportation

MUMBAI, Feb 20: For the last four months, a police station in south Mumbai has become the temporary home of a 65-year-old Pakistani man who has served a sentence for illegal entry into India and is now awaiting deportation.

Nadir Munir Khan. a cloth merchant from Karachi, has been living in a room at Mata Ramabai Ambedkar (MRA) Marg police station since last October.

He can not leave the police station until the deportation, said senior inspector Santosh Dhanavate. Police have issued him a restriction order, forbidding him from stepping outside the premises.

Khan was arrested by officials of the MRA Marg police station on April 11, 2024, after he was found roaming in a suspicious manner near the Chhatrapati Shivaji Maharaj Terminus in the city.

He told police that he was a Pakistani national. But he had no visa and other necessary documents, so the police arrested him on the charge of illegal entry into India under the Foreigners Act and the Passport Act, the official told PTI on Thursday. In view of his nationality, the Intelligence Bureau and R&AW (Research and Analysis Wing) too questioned Khan besides

the police, the official said. He was then prosecuted for illegal stay in the country, and a local court sentenced him to six months in prison. He was released on October 11, 2024.

After completing the prison sentence, Khan was again sent to the MRA Marg police station, where he is now waiting for deportation.

"We have contacted Pakistani authorities. We are waiting for their response," the official said.

The police are looking after his daily needs, including food. According to Khan's statement to the police, he ended up in India via Nepal

In 2023, he travelled to Kathmandu on a business trip. Some local vendors who had ordered leather jackets cheated him by not making payment for the goods, he told police.

When he confronted them, he was allegedly assaulted and his passport and other documents were stolen. The Nepal authorities imposed a fine on him for overstaying, following which he crossed into India through Sonauli land port in Uttar Pradesh, from where he went

to New Delhi, Khan told police. After staying in New Delhi for some days, he came to Mumbai in

November 2023. "We have confirmed that he is a resident of Karachi. The Mumbai police's special branch has contacted the Ministry of External Affairs about Khan's deportation. We are now waiting for a response from Pakistani authorities," said inspector Dhanavate.

But until the process is complete, he is the police station's responsibility, the official said. (PTI)

'THE WHITE LOTUS' STAR JASON ISAACS ON HIS TRANSFORMATIVE INDIA TRIP: SAW MASSIVE WEALTH GAP

NEW DELHI, Feb 20: British star Jason Isaacs has vivid memories of filming his 2018 movie "Hotel Mumbai" in India where the massive wealth gap between the rich and the poor made him reflect on what material possessions mean. The actor, known for his performances in films such as "The Patriot", "Black Hawk Down", "The Death of Stalin", and the "Harry Potter" franchise, said the trip to India was quite transformative for him. "Hotel Mumbai" was based on the 2008 Mumbai terror attacks. "I think about transformation a lot because I'm older... And I think probably the first time I really thought a lot about it was when I worked in India. Well. they made a film called 'Hotel Mumbai'.

"We travelled around India a lot and we saw the highs and the lows and the massive wealth gap there. It does make you reflect on what material possessions mean... It's something that I think about all the time," Isaacs told PTI in a roundtable interview.

His new show "The White Lotus" focuses on a group of tourists and how their lives change during the course of an ultra luxury vacation and Isaacs said he had a similar experience in Thailand where the third season of the HBO show is set. "I made some friends but also got to see a country where people live very differently with massive disparity. We're actors, we're endlessly curious about who people are, how they are, and choices they make. And also for me, different cultures, different politics, different attitudes to life and death... So, it was a very three-dimensional experience.'

"The White Lotus", which currently streams on JioHotstar, is created by Mike White. Each season of the show revolves around the dynamics between rich guests and employees of a fictional resort chain, called White Lotus. The first season was set in Hawaii and the second season was shot in Sicily, Italy.

"Mike chose Thailand for a reason because people go there for a spiritual odyssey as well as for all the normally entertaining things. He wanted to make the series have more resonance and he achieved it in spades," the 61-year-old actor said.

Isaacs plays the role of Timothy Ratliff, a US-based financier, who visits the resort with his family -- wife Victoria (Parker Posey), sons Saxon (Patrick Schwarzenegger), Lochlan (Sam Nivola) and daughter Piper (Sarah Catherine Hook). While on vacation, Ratliff gets to know that his business is in serious trouble. "I had some big acting to do. I mean, there's some extreme emotions. There's a pressure cooker which is exploding... His entire life and future. And along with all the other sex, drugs, and tofu that Mike writes about, this series has questions of identity and what is the self," he said about the new season.

According to Isaacs, the USP of White's writing is that it can't be slotted into easy categories.

"There are no cliches here. What he does so brilliantly is that you meet the characters and you think you understand who they are. Sometimes you can even make comparisons with previous characters in the show, but he's far too sophisticated for that.

"So how does it compare? Timothy is Timothy, and there's no one like him specifically, and his particular dilemma has never been seen before," he added. In his long career, Isaacs has played some of the most compelling characters whether it is Lucius Malfoy from the "Harry Potter" movies, Colonel William Tavington in "The Patriot" or Georgy Zhukov in "The Death of Stalin".

Asked about his fascination for morally complex characters, the actor said they are the most interesting parts. (PTI)

"Even though they are lower in the standings, they're a team that fights hard and can surprise any opponent, so we can't afford to take them lightly," said Harmanpreet.

Ireland had finished last in the 2023-24 edition of the Pro League and are unlikely to significantly trouble India, but given wobbly start the hosts have had, they may cause some problems

DUBAI, Feb 20: A cramping Towhid Hridoy made a courageous maiden ODI hundred but led by five-wicket man Mohammed Shami India managed to keep Bangladesh to an underwhelming 228 in their Champions Trophy opener here on Thursday.

Hridoy (100, 118b, 6x4, 2x6) and an equally gutsy Jaker Ali (68, 114b, 4x4) added 154 for an doughty sixth-wicket stand to drag Bangladesh back from the depth of 35 for five after they elected to bat.

Shami also eased a lot of worries over the absence of injured pace ace Jasprit Bumrah with a five for 53 effort, and during the spell he also became the fastest Indian bowler to reach 200 ODI wickets. Hridoy's innings was an example of how to construct an innings yet maintain a healthy run-rate as he reached the milestone in just 114 balls. He and Ali also showed excellent composure under pressure.

However, both the Bangladesh batters benefited from the largesse of Indian fielders, as Ali was dropped on zero off the first ball he faced off left-arm spinner Axar Patel (2/43). It also robbed Axar of a hat-trick after he dismissed Mushfigur Rahim and Tanzid Hasan off successive deliveries.

Hridoy had the fortune when he was grassed by Hardik Pandya at mid-off off uldeep Yadav when he was on 23.

KL Rahul, who was sharp behind the stumps, floored a stumping chance to give the second reprieve for Hridoy. Indian fielders were also sloppy in the middle passage, allowing the Bangladesh batters to steadily



collect singles and twos to ease some pressure. But those moments of slip-ups should not take anything away from the way Indian bowlers, especially Shami, used the new ball on a rather slow but smooth pitch.

Shami, who had an average outing against England in T20I and ODI series recently at home, did not disappoint on the big stage and took the wicket of opener Soumya Sarkar in the first over itself. He did not take much time to grab his second wicket when he ousted Mehdy Hasan Miraz - caught brilliantly by Shubman Gill in the slips.

The Bengal pacer later returned to break the determined stand between Hridoy and Ali, dismissing the latter.

He later took two more wickets, and now the 34-year-old is India's highest wicket taker in ICC tournaments, going past former pacer Zaheer Khan (59).

Had doubts if I'd ever play for India again after injury: Shami

DUBAI, Feb 20: Veteran Indian pacer Mohammed Shami has revealed that following his ankle injury, there were moments when he feared his international career was over but his unwavering desire to play for the country again kept him going.

Shami suffered an ankle injury during the 2023 ODI World Cup final against Australia in November, which required surgery.

His recovery was further complicated by swelling in his left knee, as he was sidelined from international cricket for 14 months.

"From being in great form during the World Cup to suddenly finding myself on the operating table, from that form to being injured was really tough," Shami told the ICC

"For the first two months I often doubted whether I would be able to play again as an injury like this followed by a 14-month break can pull you down," he added.

The 34-year-old, however, made a successful international comeback, playing in two T20Is and as many ODI matches against England earlier this month.

With Jasprit Bumrah injured, Shami will lead the Indian pace attack in the Champions Trophy.

"My first question to the doctor was 'how many days until I can be back on the field'. He said my priority is to get you to walk, then jog and then run and thinking about playing competitive cricket is still a distant goal.

The transition from being an active athlete to relying on crutches was mentally challenging for Shami.

"I always wondered when I would be able to put my feet on the ground again, someone who is used to running on the field constantly was now in crutches.

The first two months were especially dif-



ficult, as self-doubt crept in.

"A lot of thoughts used to run through my mind. Will I be able to do it again? Will I be

able to walk without a limp? Shami said he was gripped by a sense of fear when he was asked to put his feet on the ground after three months and it felt like he was learning to walk again.

"After 60 days when they asked me to put my feet on the ground, you won't believe me, but I have ever (never) been more scared to put my foot on the ground," Shami said.

"It felt like I was starting over, like a toddler learning how to walk and I was worried about any complications.

Shami's unwavering desire to don the India jersey once again kept him motivated during the toughest phase of his recovery.

"Courage and passion to play for the country are the biggest motivators, and the desire to wear the India badge on my chest kept me going.

"You endure the pain and take it one step at a time without complaints or bitterness. The passion for representing my country has brought me this far. It was tough and there was pain, but with resilience and patience I made it through.

"My motivation has always been to serve my country for as long as possible because once you step away, you're just like anyone else," Shami said. (PTI)

Just forgive and move on, can't worry about everything: MS Dhoni

MUMBAI, Feb 20: "Even if it's tough to do...just forgive and move on." Mahendra Singh Dhoni became a life coach for once to share his secrets for a stress-free existence, describing himself as a careless person who would not give up on a good night's sleep by paying attention to what others think of him.

The 43-year-old former India wicketkeeper-batter, considered one of the game's greatest for captaining India to two World Cup titles in a storied international career, set a high benchmark for a leader with his calm and focused approach on the field.

He is now gearing up for what most believe is his final IPL season as a player with Chennai Super Kings and at an event here, he turned philosophical when asked to give advice to fans and followers. "I think, keep life simple. Be honest to

yourself, have gratitude towards people for whatever they have been doing for you. Don't always think, 'this is my birthright' and ask for more," the enigmatic big-hitter said here on Wednesday evening during the launch of his app 'DHONI' powered by Single.id where injured India keeper-batter Sanju Samson was also present.

"I know the whole app (DHONI) says 'thoda aur' (a little more), but the whole thing is to have that gratitude, to say thank you, to respect the elders (and) to give love to the younger ones," he added.

He then went on to stress on the need to have a forgiving attitude, which he feels is in short-supply right now.

"I always felt having a smile on your face solves half the problem. Even if you're not in a comfortable position, even if it's tough to do, have the power to for-



give. That is one thing that not many of us anyone, including former teammates or have," said the cricketer who has never re- critics, some of whom have even accused sponded to the personal attacks on him by him of hurting careers.

"We have become a very revengeful people. Isne mujhe aisa bola, main aisa bola (He said something to me, I said something back)...Just forgive, move on, be happy in life, because whatever we do... when we're growing up, we always wanted to be happy in life," he further stated.

Dhoni said being careless towards a few things helps in balancing the pressure of day-to-day life.

"We all feel the pressure. We always say the grass is greener on the other side. We always feel that his or her life is better, but what is important is how you manage that stress, how prepared you are," he said.

"I keep it very simple. Growing up, we were told 'you cannot be careless'. But I feel in today's environment, it is important to be a bit careless because you can't worry about each and everything that is happening around you. You cannot do things that are not in your control," he added

Dhoni said those who are obsessed with perception are not particularly constructive. He felt not every opinion merits a response or even consideration.

"If you get carried away with what others are saying, what others are feeling, then that important thing of what needs to be done, often you are not really giving utmost attention to that," he said.

"I am a bit careless in life. I don't give everything my 100 per cent attention because I feel this is important, (or) that's not important," he explained.

"Even if I am listening to something (and) I can't do anything about it so, what is the point of giving half an hour or whatever to it... and (also) having a good night's sleep," Dhoni concluded. (PTI)
