## Media must exercise utmost caution before publishing any statement, news or opinion: SC



NEW DELHI, Feb 19: The Supreme Court has said persons working in key positions in the media must exercise utmost caution and responsibility before publishing any statements, news, or opinions and observed the right to freedom of speech and expression was

A bench of Justices J B Pardiwala and R Mahadevan reiterated that the power of the media in shaping public opinion was significant and the press possessed the ability to inpublic sentiments and alter

The bench's observation came when it quashed a defamation case against English daily Times of India's editorial director and other journalists, who were accused of publishing alleged defamatory contents over the authenticity of certain paintings to be auctioned by Bid & Hammer - Fine Art Auctioneers. "We find it necessary to emphasise that right to freedom of speech and expression guaranteed under Article 19(1)(a) of the Constitution of India is paramount. At the same time, it is reiterated that those working in the media, particularly, individuals in key positions, authors, etc., must exercise utmost caution and responsibility before publishing any statements, news, or opinions," the bench said in its February 18 judgement.

#### Two more bodies found after 44 days

Dima Hasao coal mine tragedy: Toll touches six

GUWAHATI, Feb 19: Divers fished out decomposed bodies of two more miners trapped inside a coal mine in Assam's Dima Hasao district on Wednesday, 44 days after they went missing in the quarry, an official said.

With this recovery, six of the nine miners who had been trapped there on January 6 were found.

Dewatering operation in the mine at Umrangshu has been continuing for over one month. The two highly decomposed corpses were spotted by the divers who went in and brought them out.

The bodies are yet to be identified, the official said. Nine workers were trapped inside the mine on January 6 and the body of one was recovered two days later while those of three others were found on Janu-

An ex-gratia payment of ₹ 10 lakh each has been paid by the gov-



ernment to the next of kin of the four miners whose bodies were recovered earlier and Rs six lakh each to the family of those trapped inside.

The state government had announced that the family of all trapped inside the mine would be paid a total of ₹ 10 lakh each.

Chief Minister Himanta Biswa Sarma had said that if the dewatering continues at the current rate, it will take about 25 to 60 days for the process to be completed, and it will continue till (CONTD. ON PAGE-2)

#### 1.66 lakh illegal foreigners detected in Assam, 30,115 deported

GUWAHATI, Feb 19: Nearly 1.66 lakh immigrants have been identified as "illegal" according to Assam Accord norms and just over 30,100 of them have been deported from the state, the Assembly was informed on Wednesday.

In a written reply to a query by Congress MLA Abdur Rahim Ahmed, Implementation of Assam Accord Minister Atul Bora said a total of 1,65,531 immigrants staying illegally in Assam have been detected till December 31 last year, 2024. "Out of them, 32,870 came between 1966

and 1971, and 1,32,661 came after 1971," he added. The government has so far deported 30,115 illegal foreigners from Assam, the Minister said without sharing details of their country of origin.

The Assam Accord was signed in 1985 after a six-year-long violent anti-foreigner movement. The pact stated, among other clauses, that names of all foreigners coming to Assam on or after (CONTD. ON PAGE-2)

# Asam Sahitya Sabha adopts 'One Person, One Post' policy, 33% women's quota

JORHAT, Feb 19: The Asam Sahitya Sabha has

adopted a policy of 'One Person, One Post' and 33 per cent reservation for women in its new executive committee for the 2025-27 term.

Addressing newspersons at the Danbir Radha Kanta Handique Bhawan within the premises of the Sabha's central office here on Tuesday, newly elected Sabha president Dr Basanta Kumar Goswami stated that, as part of a series of reforms initiated by the premier literary organisation of the state, a policy of 'One Person, One Post' has been implemented for the 2025-27 executive committee.

He explained that the new policy aims to bring more transparency and inclusivity to the activities of the literary body. Elaborating on the decision, Dr. Goswami stated that under this policy, no individual would be allotted more than one post within the Sabha, and members of the same fam-

ily would not be able to hold multiple posts. Further, the Sabha president highlighted an-



other significant reform: the reservation of 33 per cent of seats for women in the new executive committee. He noted that these initiatives stem from resolutions adopted on February 5 during the five-day 77th biennial conference of the Sabha held at Pathsala in Bajali district. # Coal ministry plans to offer additional incentives in

#### underground mine auctions

KOLKATA, Feb 19: The Coal Ministry is planning additional incentives to boost underground (UG) commercial coal block auctions in India, a senior government official said on Wednesday.

The push for UG mining aligns with India's drive for sustainable coal production.

The proposed incentives are in an advanced stage of discussions and are expected to be announced soon, Coal Secretary Vikram Dev Dutt said at a roadshow for commercial coal mine auctions in the

Additional Secretary and nominated authority Rupinder Brar clarified that any new incentives and policy relaxations are expected to be applicable prospectively.

The coal ministry's policy evolution has involved multiple stakeholders, including industry players.

"We have consistently refined the auction framework based on industry feedback, ensuring an investor-friendly environment," Dutt said. The ministry was discussing demands for reclassification, as underground mining faces inherent challenges.

Of the 113 commercial mines successfully auctioned, 37 are underground, officials said.

The ministry is also working to secure environmental concessions with the Ministry of Environment, Forest, and Climate Change.

The ministry believes the next 2-3 years are crucial for commercial

mines to rapidly begin production. Currently, production from auctioned commercial mines is 20 million tonnes, but combined with captive production, it totals 157 million tonnes and is expected to reach 170 million tonnes by the end of the fiscal year, an official said. In 2025-26, this production is projected to rise to 210 million

Currently, 14 mines are operational and more will join soon.

The ministry plans to auction a similar number of blocks in the 12th tranche as it did in the 11th round, Dutt said. In the 11th round, 27 mines were under the hammer and received 72 bids for 17 mines. The technical evaluations are on and allotment is expected in a month. (PTI)

"While markets ended flat with a slightly negative bias due to selling in IT stocks, broader markets witnessed a lot of optimism as mid and smallcap stocks rallied after the recent sell-off.

"Despite the uncertainty over rising FII selling, falling rupee, and the ongoing tariff war, the recently beaten sectoral stocks from banking, automobile, telecom, metals attracted significant buying interest," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said. Foreign Institutional Investors (FIIs) turned buyers on Tuesday after unabated selling. They bought equities worth ₹ 4,786.56 crore, according to exchange data.

The BSE smallcap gauge jumped 2.41 per cent and midcap index climbed 1.30 per cent.

"Markets remained volatile and ended nearly unchanged, extending the prevailing consolidation phase. The ongoing indecisiveness in the index is keeping participants on edge," Ajit Mishra – SVP, Research, Religare Broking Ltd, said.

Global oil benchmark Brent crude climbed 0.65 per cent to USD 76.33 a barrel. After a day's breather, the Sensex ended 29.47 points or 0.04 per cent lower at 75,967.39 on Tuesday. The Nifty dipped 14.20 points or 0.06 per cent to settle at 22,945.30. (PTI)

# US reciprocal tariffs on India to have limited impact as economy domestically-driven: S&P

**NEW DELHI, Feb 19:** India will be less impacted by the proposed US reciprocal tariff as the country's economy is mainly driven by domestic demand, and has substantial services exports, which is not going to be targeted by the Trump Administration, S&P Global Ratings said on Wednesday.

US President Donald Trump has announced he will impose reciprocal tariffs on its trading partners, including India.

S&P Global Ratings, Economist Asia-Pacific, Vishrut Rana said the reciprocal tariff will hurt countries like Vietnam, South Korea, Taiwan more as they have high trade surplus with the US.

The Indian economy has two mitigating factors -greater reliance on domestic economy and larger services trade with the US, which is not likely to be tariffed. In Japan also, there are similar mitigating factors -- greater reliance on services trade, and domesticallydriven economy.

"... which means (US) trade measures might be less impactful there (India and Japan)," Rana said at the S&P Asia-Pacific Credit Focus webinar.

He also said that reciprocal tariffs may fuel inflationary expectations, thus leading to higher interest rates globally.

S&P Global Ratings, Director, Sovereigns (Asia-Pacific) YeeFarn Phua also said India's economy is largely still domestic-oriented and the nature of the exports to the US is more on the services side, which is less prone to tariffs.

"India's dependence on exports for growth is not that great. So, therefore, I think the impact (of US tariffs) will be more or less limited," he said, adding on the goods side the sectors which could be exposed to higher tariffs are jewellery, pharmaceutical, textiles and chamicals

Phua said the US may not impose higher tariffs on pharmaceuticals, which are basically generic drugs, from India as it would drive up healthcare costs in its own country.

However, textiles and to some extent chemicals are most at risk of higher tariffs. "If we were to reimagine that scenario for the first Trump administration to unfold again, I think overall, the impact on India should be quite minimal," Phua added.

e quite minimal," Phua added.

Earlier in 2018 under the Presidency of Donald

Trump, Washington had imposed an additional 25 per cent import duty on steel products and 10 per cent on certain aluminium products. In retaliation, India in June 2019, imposed additional customs duties on 28 American products.

More than five years after the initial tariffs were imposed, on July 3, 2023, the US removed tariffs on steel and aluminium imports from India.

With regard to economic growth in India, Phua said India will clock a 6.7-6.8 per cent GDP growth over the next two years. These growth rates, even though slower than before, continue to place India above sovereign peers at similar income levels, and "we do believe that this will continue to support fiscal revenue growth despite the income tax cuts."

He said fiscal 2025-26 budget will boost growth for the next few years, largely by domestic demand through tax cuts for households and GDP growth is now normalising to a more "sustainable level".

"The government remains very much focused on investment-led growth and also on agriculture sector reforms. However, we do think that economic expansion in India is startling to normalise towards a more sustainable level after real growth had averaged 8.3 per cent over the last three years post-pandemic,"

As per official projections, the Indian economy will grow at 6.4 per cent in the current fiscal (2024-25), lower than 8.2 per cent in 2023-24.

S&P Global Ratings has a 'BBB-' rating on India, which is the lowest investment grade. The outlook on the rating was positive, from stable, in May 2024. He further said India's fiscal metrics continue to be

quite positive and the tax revenue to GDP has grown over the last few years to around 12 per cent currently.

The central government deficit has been lower since

the pandemic years.

S&P believes that the government will meet its fiscal deficit target of 4.8 per cent and 4.4 per cent for the current and the next fiscal, respectively.

"These targets actually are quite consistent with our projections... We do believe that the government will meet the deficit targets, largely because there are continued large dividends coming from the central bank, as well as potential capex under-spending on the expenditure side," Phua said. shaping their beliefs and judgments. It has the capability to cause severe damage to the reputation of those concerned, with consequences that may be far-reaching and enduring, it added. "This highlights the critical need for accuracy and fairness in media reporting, especially when dealing with matters having the potential to impact the integrity of individuals or institutions. Keeping these aspects in mind, publication of the news articles must be done in public interest and with good faith," said the bench. The top court was hearing an appeal filed by the journalists against a Karnataka High Court order, which dismissed their petition challenging the initiation of the criminal proceedings against them.

The were facing charges of under Sections 499 (defamation) and 500 (punishment for defamation) of the IPC. The complainant (art auction house) alleged that the defamatory news item that was printed, published and circulated by all the accused persons had caused readers to view the complainant with suspicion and also fostered an unjustifiable and unfounded public opinion that its works offered for sale through public auctions could be fake.

The top court however observed procedural irregularities in the magistrate's summoning order and said the complainant failed to produce any witness to prima facie establish the alleged imputations had lowered its reputation. "No material has also been placed before us to suggest that the auction was unsuccessful or that any damage or loss was actually caused, due to the alleged news articles published in the newspapers," it said. The bench added, "Irrespective of the same, at this stage, remanding the matter for fresh examination of witnesses before issuance of summons would serve no useful purpose, given the remote likelihood of securing witnesses. It would only prolong the litigation yielding little to no benefit especially, since the auction has already concluded and more than a decade has passed." (PTI)

As a part of Natural Resources Management, NABARD has been supporting the implementation of various projects like Integrated Watershed Development with Climate Proofing Interventions (IWDCPIs), Integrated Tribal Devevelopment Programmes (ITDPs), UPNRM & Climate Change Projects, etc, across India.

The project would be implemented under convergence mode along with GiZ-India & Selco Foundation vith Kalong Kapili as the implementing agency.

The project was ceremonially launched and inaugurated at Kaliabor on Tuesday last, jointly by CGM-NABARD, Loken Das and the Kaliabor co -district commissioner, Liza Talukdar, in presence of DGM-NABARD, Sankar Das, GIZ representatives Nilanjan Ghose and Anuj Xess, programme manager of Selco Foundation Prashanth Bharadwaj, DDM-NABARD, Rajendar Perna, DFDO, Himangshu Talukdar, Kalong Kapili Director Jyotish Talukdar.

Speaking on the occasion, the CGM-NABARD, Loken Das suggested that that under the project, the identified 10 Model Fish Farms (MFFs) would be provided with DRE equipments viz Solar pump & solar

aerator (for production enhancement) and Solar Dryer & Solar Freezer (for processing activities). Each of these 10 MFFs would cater to nearby fish farmers for the purpose of demonstration of the DRE technology, training and capacity building. Accordingly, over 210 beneficiaries would be supported under the project.

DGM-NABAR Sankar Das also suggested that the pilot has been devised with various objectives like dissemination of effectiveness of DRE technologies in enhancing the stocking density and reducing the mass mortality during the culture period, reducing the overdependence on fossil fuels, mitigating the damage to environment and enhancing the income levels of fish

Besides, DM-NABARD Rajendar Perna informed the participants that the project has been formulated for implementation in Nagaon as there are more than 70,000 fish farmers in the district and the district tops the production of fish and fish seeds in the state. #### **Deciding fate of Ukraine**

ussian president, Vladimir Putin, has already achieved a very big objective of his diplomacy — isolating Europe from the United States. Now with the US President's latest statement from his clubhouse, Donald Trump seems to have dumped the traditional diplomatic tie up between Western Europe and America. India must take lesson — don't trust your allies. For fighting your war and for your existence, pursue relentlessly national military capabilities. Today, America might be paying India and Prime Minister Narendra Modi compliments - tomorrow they might just as well supply the most lethal weapons to Pakistan to teach a lesson. The world is now a sort of place, very much like a state of nature of Rousseau. In pursuit of its avowed aim of bringing the Ukraine war to an immediate end, America is going alone to the negotiating table with Russia, without taking the Europeans. This has given the Europeans the jolt they badly needed. After all, they had outsourced their defence to the Americans and now the chickens are coming home to roost. Donald Trump has now accused Ukraine of having started the war, and said that after three years it is still fighting the war instead of reaching some "deal" with the Russian president Putin. The American position must be under close examination of the Chinese president, Xi Jinping, and he must be feeling happy that he might also reach a deal with Trump isolating Taiwan.

If the war comes to end on the basis of present negotiating stance of the principal interlocutors (Russia and America), this will usher in a completely new world order. This will establish might is right rather than the former global regime which was based on rule of law and respect for sovereignty of nation states, whatever might be its limitations. While the fate of Ukraine is being decided at the negotiations hosted by Saudi Arabia, the country itself is absent and far away from any of the talks. Russia is seeking to bamboozle its viewpoint in the negotiations, if only for the vanity of the new US president. Donald Trump had promised to end the Ukraine war immediately on resuming office. The high representatives of the United States and Russia met in the Saudi Arabian capital Ritadh on Monday and set up committees for follow up negotiations. However, Russian ambassador to the UN. Vasili Nebenzya, has laid out conditions which are blatantly unac-

His first condition is that the European Union and United Kingdom should have nothing to do with the talks for ending war in Ukraine. The Russian envoy has stated that the EU and UK have an attitude of "primitive Russophobia" and therefore could not be part of any talks. Russia is inviting that Ukraine should be "demilitarised" and should not be part of NATO alliance. This was not acceptable to Ukraine or the European Union. But Trump has already said that Ukraine President should forget about his NATO membership. Any agreement accepting Russian conditions would not be acceptable to Ukraine or its present-day allies, namely, EU and UK. America has gone out of the way to force an agreement to end the war principally on its own calculations and diplomatic targets.

# British Prime Minister is staking lives at risk by committing troops to Ukraine

he geopolitics of Europe are moving. The least we should demand of our elected representatives in Parliament is a frank discussion of he geopolitics of Europe always held a veto over our foreign policy that is denied to British opinion — the Labour government gave the green light to Ukraine firing missiles at tar-

We have been denied one. When Russia launched its illegal invasion of Ukraine in February 2022, Labour MPs who signed a Stop the War Coalition statement condemning that invasion, but pointing to the role NATO expansion to Russia's borders had played in provoking it, were ordered to remove their names or lose the Labour whip.

Keir Starmer is the most intolerant Labour leader in the party's history: authoritarian crackdowns on any member or MP who dares to differ with him are no novelty. But given the incalculable stakes when it comes to brinkmanship with nucleararmed states, we should see refusal to countenance discussion on war and peace as especially dangerous.

In contrast to controversies of the past — from Suez to Iraq — there has been almost no debate in Parliament or Establishment media about the Ukraine war or the wisdom or otherwise of our government's approach to it.

Not only did Starmer silence by diktat, immediately, those MPs who pointed out (alongside die-hard US imperialists like Henry Kissinger) that NATO policy over the past decade had been widely predicted to provoke a violent

Russian reaction.

The ruling-class consensus suffocated the media: in the first week of the war, BBC Question Time presenter Fiona Bruce shut down an audience member who asked the panel whether NATO expansion might have provoked the invasion, and panel members were not permitted to answer. It should be possible to disagree on the causes of the Ukraine war without endorsing such censor-ship

By making disagreement treasonous, governments have been given carte blanche to escalate the war without having to persuade the public of their case.

When — because the Joe

Biden administration gave permission, since the White House always held a veto over our foreign policy that is denied to British opinion — the Labour government gave the green light to Ukraine firing missiles at targets inside Russian territory, it was not even announced in Parliament, nor raised until independent MP Jeremy Corbyn did so. Yet the risks of retaliation are obvious. Parliament failed to hold government to account by making ministers explain themselves.

This silence on alternative foreign policy has never applied in the United States. Its ruling class don't hesitate to assess and reassess their strategic approach. Washington never cared about Ukraine, as Britain's peace movement warned from the

The war lobby have not only prolonged the agony. Those who cried treachery at calls for dialogue should face the reality: if Boris Johnson had not scuppered the April 2022 peace deal on offer in Istanbul, Ukraine would be far better off now.

Hundreds of thousands of dead people would still be alive. And Russia had not at that stage made expansionist territorial claims on the scale it has done since, claims the US is now happy to accept as part of a great power carve-up.

Europe is left high and dry. Starmer's response is to see how far we can pursue US policy without the US: hence the proposal to deploy British troops to Ukraine, though the huge military build-up by Western powers on Russia's borders was a cause of the war, not a deterrent.

Even Starmer states openly that no such plan will work without backing from the United States, which has said it will not offer support to a European deployment in Ukraine nor come to its aid if it is attacked.

Starmer is putting Britain at risk of conflict with a nuclear power, and true to form, made his offer to foreign governments without the courtesy of a nod to Parliament. Lives should not be risked so carelessly, and British belligerence has done nothing but harm to date. (IPA Service)

# Reactions to influencer Ranveer Allahabadia's programme are bizzare

OCIAL media influencer Ranveer Allahabadia's question to a contestant on the online show 'India's Got Latent' has attracted not only public outrage, but systematic response from various State authorities. By mid-February, the Maharashtra Cyber Department had filed a First Information Report ('FIR') against Allahabadia, comedian Samay Raina, and other artists from the show for allegedly creating obscene content. Soon after, sitting chief ministers and a debate in a parliamentary standing committee pushed for constitutional restrictions on free speech, keeping in mind the malicious effects of such expression on Indian society.

A closer reading of the political reaction and the state machinery's behaviour towards Allahabadia's case reveals certain peculiar tendencies of societies where majoritarian forces are potent. Society's popular impulses creep into the institutions of the State and come to be presented as legal truth. This form of proscription of free speech generally arises when the social majority is incapable of accepting certain forms of practice that have historically haunted the institution of the State. The state and its institutions have, from time to time, criminalised certain acts that do not conform to a majoritarian logic. However, within the same realm of law, the State has failed to criminalise other acts of violence which bear significance in preserving majoritarian institutions.

In India, several laws govern obscenity when it appears on electronic or digital platforms. Section 294 of the Bharatiya Nyaya Sanhita criminalises the sale, display, or transmission of obscene material, including in electronic form, and Section 67 of the Information Technology Act mirrors the BNS's definition of obscenity, while prescribing a harsher punishment.

Obscenity jurisprudence has undergone a transition over the years - from the infamous five-judge bench decision of the Supreme Court in Ranjit D. Udeshi v. State of Maharashtra (1964), where it used the 'Hicklin test' to uphold a ban on D.H. Lawrence's novel 'Lady Chatterley's Lover', to its more recent verdict in Aveek Sarkar v. State of West Bengal (2014), where it adopted the 'community standards' test. Contrasted to the more conservative position in Udeshi, The Court ruled in Aveek Sarkar that works should not be judged in isolation but rather as a whole in order to prevent arbitrary conclusions. The crucial outcome of this was that not all potentially offensive material is

India's jurisprudential history on free speech is marked by two distinct streams. One stream conveys the impression that citizens are prone to violence and cannot be trusted with a great measure of freedom. Thus, for their own good, the State should protect citizens from the malignant influences of speech. Another stream acknowledges citizens as conscientious beings capable of living principled lives, such that rights reinforce the conditions to realise their full potential. Hence, it is not for the State to impose its visions of ideal citizens by curb-



ing what they can see, speak, or hear. In these matters, the Court has, over time, insisted upon a close degree of proximity between speech and disorder.

The Supreme Court is set to hear Allahabadia's plea to quash the multiple pending FIRs against him on Thursday, February 21, 2025. It is to be seen whether it will be able to stand by its own concretely established principles in Aveek Sarkar.

Lost amidst the noise around Allahabadia was a report published by India Hate Lab, a Washington-based organisation, which found a 74% increase in anti-minority hate speech in India in 2024. The report recorded 1000 incidents of hate speech, a third of which were recorded in the run up to India's general elections. Compared to this, 668 hate speech incidents

hate speech incidents had been recorded in 2023.

The report under

lined that 80% of the hate speech occurred in states ruled by the Bharatiya Janata Party and its allies, with Prime Minister Narendra Modi's campaign speech in Rajasthan's Banswara on April 21, 2024, marking an inflection point. Notably, the report also highlighted the ongoing demolition drive conducted by state machinery, particularly targeting Muslims and the row on the Hijab ban in educational institutions in Karnataka when the BJP was in power. While Allahabadia's unpleasant humour continues to foreshadow the country's television screens and public forums, a striking record of hate speech in a democratic country failed to solicit critical political engagement.

The Allahabadia incident underscores a perceived intent to suppress expressions that do not necessarily align with the majoritarian construction of an ideal society. On February 14, 2025, the Akhil Bharatiya Hindu Mahasabha, a far-right Hindu majoritarian group proposed a form of parallelly policing 'such elements' by essentially using a reciprocal threat of mutilating Allahabadia. All this signifies that legitimacy accorded through majoritarian endorsement is being institutionalised due to its performative nature and its steady integration into the insti-

tutions of the State.

The question that arises is this: how does one bridge the gap between acts of violence that enjoy legal immunity through public authorisation and individual claims that do not necessarily adhere to majoritarian principles?

Unsuspectingly, the recent judgement by the Chhattisgarh High Court which refused to convict a person accused of marital rape provides certain answers.

On February 13, 2025, the Court noted that Section 377 of the erstwhile Indian Penal Code ('IPC'), which provides punishment for 'unnatural offences', was repugnant to Exception 2 of Section 375 of the IPC, also termed the 'marital rape exception'. The exception permits non-consensual

sexual intercourse or acts by a man with his wife, the wife not being under eighteen years of age. In December 2017, the victim provided a

dying declaration stating that forceful intercourse by the husband had led to her illness, shortly before succumbing to her injury.

In 2022, the Delhi High Court had delivered a split verdict on the constitutionality of the Exception. Justice Rajiv Shakdher found the law unconstitutional, stating that the right to withdraw consent forms the core of women's right to life and liberty. However, Justice Hari Shankar relegated the issue to the legislature noting that "requires consideration of various aspects including social, cultural and legal." Justice Shankar's argument echoed the State's firm position on the Exception, which views it closely tied to sanctity of the institution of marriage. In the Delhi High Court, the government argued that law, if decriminalised, would be used by "unhappy wives" to harass husbands

The State's position, which is also the position of certain judges, underscores a regressive and patriarchal conception of agency within marriage. Equating 'consent for marriage' with 'consent for sexual intercourse' automatically undermines bodily autonomy, freedom, and the fundamental right to privacy. If courts continue to permit the revoking of bodily autonomy as a means to

preserve the sanctity of marriage, it would be a step towards constitutional chaos.

be a step towards constitutional chaos.

Similar to Allahabadia's case, the marital rape exception captures profoundly the contestation between agency and the caprice of collective will, with the Court as a final arbiter. The State's logic, which is backed by a majoritarian and populist value system that pushes to preserve marriage, due to its central position in Indian society, provokes fundamental concerns about the 'quality' of the society that these institutions reinforce and their adherence to the Constitution's transformative vision of a democratic polity.

The Constitution offers a site for self-determination, enabling individuals to realise their potential as free members of the polity. It recognises group rights and individual freedom, balancing their coexistence. While one set of rights seeks to uphold the sociocultural practices of a community, the other insists on individual autonomy and freedom of choice. The fundamental guiding principle is marked by equality among all individuals and liberty from all structures of domination and discrimination. Therefore, amidst the clash between individual autonomy and collective will, where the constitutional commitment to dismantle discriminatory practices endorsed by social institutions gets disrupted, the agency of the citizens should prevail.

Allahabadia's remarks, expressed in a corner of the internet, trembled both the virtual and physical world equally on issues ranging from morality to free speech and censorship. But the Chhattisgarh High Court's verdict could not solicit a single prime-time discussion or parliamentary debate on marital rape.

In 1984, Latvian political theorist Judith Shklar argued that the only defensible meaning of liberalism was a system that could secure the political condition necessary for every adult to exercise the freedom to make as many effective decisions about any aspect of their life without fear or favour as possible. Liberalism's significance is also grounded on the continuous presence of 'fear' that takes the shape of cruelty in our societies. Shklar presents cruelty as society's primary flaw. The hubris of this trait is carried by the social actors to the institutions of the State as well. The outcome is a system where the cruelty of the punishment that is inflicted on an individual or a group does not necessarily match the cruelty of the act con-

This is the problem of justice that societies run by majoritarian forces encounter. Both Allahabadia's case and the Chhattisgarh High Court's decision on marital rape exception show that the State and its institutions have actively endorsed a colonial attitude that assumes Indians are unable to respond to speech in a reasoned and rational manner. At the same time, when social institutions empowered by majoritarian lobbies and impulses perpetuate violence, the State revokes its protectionist stance. The State and its institutions essentially reinforce the appropriation of hierarchies as legal truths. (IPA Service)

# Trump's 'America First' doctrine: A catalyst for global turmoil

rom the moment Donald Frump took office in 2017, ■ his foreign and domestic policies have been marked by bold, sometimes controversial moves, but it is his stance on climate change and international relations that has shaped some of his most defining decisions. His first executive order, signaling the United States' withdrawal from the Paris Climate Agreement, encapsulated his administration's disregard for global environmental commitments. This decision came despite mounting evidence of climate disruptions in the U.S. since his campaign, with disastrous consequences unfolding across the country in the years that followed.

The year 2024 was marked as

the deadliest hurricane season in the continental U.S. since 2005, with Hurricanes Bervl and Milton accounting for at least 335 human deaths. The destruction caused by these storms left thousands without homes and power, compounding the dire consequences of the Trump administration's climate policies. Just as the nation faced the aftermath of these hurricanes, a new set of natural disasters threatened the country in 2025. Unprecedented snowfall in the central and eastern U.S. forced the relocation of Trump's second term inauguration indoors, while catastrophic wildfires ravaged Los Angeles. The combination of the Santa Ana winds and extreme dryness in California created the perfect conditions for a devastating fire that lasted for ten days, killing at least 25 people, destroying more than 15,000 structures, and displacing tens of thousands of residents, including Hollywood celebrities.

The fire, exacerbated by climate change-induced conditions, symbolized the broader struggles the U.S. was facing under a political system that appeared to be unwilling to confront the undeniable reality of a warming planet. Climate experts pointed to the interaction between La Nina and El Nino, contributing to the dramatic weather patterns that would make the southern part of the country drier than ever before. With winds reaching speeds of up to 120 kilometers per hour, efforts to control

the fires proved nearly impossible, further highlighting the devastating consequences of the administration's environmental stance.

Trump's pursuit of an "America First" agenda extended beyond climate policy and into global trade. He has imposed tariffs on goods from countries like Canada, Mexico, China, and Brazil, challenging global trade dynamics and potentially triggering a global trade war. This protectionist approach has sparked tension with other nations, particularly developing countries, who are now forced to reckon with shifting trade policies that could hamper their economic growth.

At home, Trump has launched efforts to shrink the federal workforce, offering two million federal workers the option to resign with pay through September 2025. This move is in line with his goal of cutting the size of government, although it also serves to further politicize the federal apparatus by pushing out those who do not align with his political ideology. Such actions signal a president testing the boundaries of executive power, seeking to exert unprecedented control over the functioning of the government.

Meanwhile, Trump's rhetoric on immigration has become increasingly aggressive. The deportation of illegal immigrants has accelerated under his administration, with even religious places, such as Sikh Gurudwaras in New York and New Jersey, being searched in an attempt to root out undocumented immigrants. The administration has also made plans to house some of these immigrants in Guantanamo Bay, effectively sidelining their access to legal rights and social services. These actions raise troubling questions about the erosion of civil liberties and the targeting of vulnerable populations based on political ideology.

In terms of geopolitics, Trump has proposed highly controversial measures aimed at bolstering U.S. dominance over strategic global resources. His desire to bring Canada into the U.S. fold as the 51st state is rooted in his belief that the U.S. would be more secure with a stronger foothold on its northern border. Additionally, Trump has set his sights on the Panama Canal and Greenland, hoping to secure these strategic



territories to counter China's growing influence in Latin America and the Arctic. The Panama Canal, a crucial international trade route, has become a point of contention in this global chess game, especially as China continues to make inroads in securing trade relationships with Latin American nations.

Equally significant is Trump's interest in Greenland, a territory that holds immense strategic and economic value. The U.S. has a long history with Greenland, stretching back to the Cold War when the U.S. military attempted to establish nuclear missile bases there. While these plans never fully materialized, the U.S. left behind nuclear waste and diesel fuel in Greenland's ice, and climate change is now bringing those contaminants to the surface. The Trump administration sees Greenland's rare earth and critical mineral deposits as key to countering China's dominance in the global minerals market. Additionally, the southern mountains of Greenland are rich in gold, further fueling Trump's interest in acquiring the territory. However, this move, if realized, could have devastating environmental consequences for both Greenland's fragile ecosystem and the broader global climate.

Equally concerning is the ongoing degradation of the Panama Canal, a vital global trade artery. Climate change, coupled with widespread deforestation in the Amazon, has significantly depleted the water levels in the Gatun Lake, which is responsible for raising ships to the necessary height to pass through the canal. As a result, the Panama Canal's efficiency has been drastically reduced, and fewer ships are able to navigate the route. Despite this, Trump's focus remains on controlling the canal, which could exacerbate the envi-

ronmental issues surrounding it. On the domestic front, the Trump administration's environmental policies have taken an increasingly regressive turn. The president has withdrawn from the Paris Climate Agreement for the second time, opting instead to pursue energy self-sufficiency through domestic drilling and oil exploration. The National Energy Emergency declared by Trump has allowed the suspension of environmental regulations, with plans to expand mining projects and lift restrictions on drilling in sensitive areas, including the Polar Bear Wildlife Sanctuary in Alaska. These decisions have sparked widespread concern about their potential to accelerate climate change, particularly through the disruption of wildlife habitats and the rapid melting of the Arctic ice.

The consequences of Trump's climate policies are not confined to the U.S. alone. The world is already witnessing the devastating effects of climate change, with the World Meteorological Organization reporting a 1.55-degree Celsius rise in global temperatures over the preindustrial period. # The threat of mega dams on Assam's ecology

he northeastern state of Assam, located in the biodiversity-rich Eastern Himalayas, is an ecologically fragile region that has been facing severe environmental challenges. One of the most significant threats to its ecology today is the construction of mega dams. While dams are often promoted as engines of development, providing hydroelectric power, irrigation, and flood control, the reality is more complex. In Assam, the environmental, social, and economic consequences of building large dams have sparked intense debate, with growing concern over the irreversible damage they may cause to the state's ecosystems and communities.

Assam's geographic position makes it particularly vulnerable to the impacts of mega dams. The Brahmaputra River, one of the world's largest and most dynamic river systems, flows through the state, supporting a rich diversity of life and providing livelihoods for millions of people. This river, along with its tributaries, forms the lifeblood of Assam's agricultural economy and natural ecosystems. However, the river is also notorious for its annual flooding, which can be both destructive and beneficial. The delicate balance of this natural system is threatened by the construction of large dams, which alter water flow, sediment transport, and the overall hydrology of the region.

The primary argument in favor of constructing mega dams in Assam and its neighboring states is their potential to generate vast amounts of hydroelectric power. With India's growing energy demands, the government has prioritized hydroelectric projects as part of its strategy for meeting the country's renewable energy goals. The Brahmaputra and its tributaries offer significant hydroelectric potential due to their fast-flowing nature, steep gradients, and consistent water supply from the Himalayan snowmelt and monsoons. Proponents of dams argue that they can provide a clean and renewable energy source, reducing India's dependence on fossil fuels and lowering greenhouse gas emissions.

However, the ecological costs of these dams are immense. The construction of large dams requires the submergence of vast areas of land, leading to the destruction of forests, wetlands, and wildlife habitats. The Brahmaputra River basin, where many of these dams are proposed, is home to a variety of endemic and endangered species, including the Indian rhinoceros, Bengal tiger, Gangetic dolphin, and various migratory bird species. The loss of habitat due to dam construction threatens the survival of these species, many of which are already under pressure from habitat fragmentation, poaching, and other human activities. Wetlands, which act as critical biodiversity hotspots and natural buffers

against floods, are particularly vulnerable to the impacts of dams. When wetlands are submerged or their water supply is altered, the delicate ecosystems they support can collapse, leading to the loss of plant and animal species.

The effects of mega dams on aquatic ecosystems are perhaps the most concerning. Dams disrupt the natural flow of rivers, which has far-reaching consequences for the species that depend on free-flowing water. Fish, in particular, are severely affected by the presence of dams, which block their migratory routes and alter the timing and quantity of water flow. The Brahmaputra River is home to a variety of fish species, many of which undertake long-distance migrations to spawn. These migrations are essential for maintaining healthy fish populations and sustaining the livelihoods of communities that rely on fishing. The construction of dams can prevent fish from reaching their spawning grounds, leading to a decline in fish populations and, ultimately, the collapse of fisheries. This has significant implications not only for biodiversity but also for the food security and economic well-being of local communities.

In addition to disrupting fish migration, dams can also alter the physical characteristics of rivers, such as water temperature, oxygen levels, and sediment transport. The Brahmaputra River carries a large amount of sediment from the Himalayas, which is essential for maintaining the fertility of the floodplains and deltas in Assam. This sediment is deposited during the monsoon season, enriching the soil and supporting agriculture. Dams trap sediment behind their walls, preventing it from reaching downstream areas. Over time, this can lead to a reduction in soil fertility, affecting agricultural productivity and leading to the degradation of ecosystems that depend on nutrient-rich sediments. The reduction in sediment transport also has geomorphological consequences, as the river's ability to shape the landscape is diminished. This can result in increased riverbank erosion downstream, altering the natural flow patterns of the river and causing the displacement of communities living along its banks.

The potential for increased flooding is another significant concern associated with mega dams in Assam. While dams are often touted as a solution to flooding, their actual effectiveness in this regard is debated. Large reservoirs behind dams can store water during periods of heavy rainfall, theoretically reducing the risk of downstream flooding. However, the unpredictability of the monsoon season, combined with the siltation of reservoirs, can limit the effectiveness of dams in controlling floods. In some cases, dam releases during extreme rainfall events can exacerbate flooding downstream, as the sudden release of water adds to already swollen



rivers. This has been a concern for many communities living in flood-prone areas of Assam, who fear that the construction of dams will make flooding more unpredictable and severe.

The social impacts of mega dams in Assam are as significant as the ecological ones. The construction of large dams often involves the displacement of thousands of people, many of whom belong to indigenous and marginalized communities. These communities have a deep connection to their land, which is not only a source of livelihood but also of cultural and spiritual significance. When dams are built, vast areas of land are submerged, forcing people to relocate. The process of displacement is often fraught with difficulties, as resettlement programs are rarely able to provide adequate compensation or alternative livelihoods. Displaced communities face the loss of their homes, agricultural land, and access to natural resources, leading to social and economic marginalization. Moreover, the disruption of traditional ways of life can have profound cultural impacts, as displaced communities are often unable to maintain their cultural practices and social structures in new environments.

The construction of dams also raises concerns about the violation of indigenous rights. Many of the areas targeted for dam construction are inhabited by indigenous communities who have lived in these regions for centuries. These communities have developed sustainable ways of managing natural resources, and their knowledge of the local environment is invaluable for biodiversity conservation.

However, the voices of these communities are often marginalized in the decision-making process surrounding dam construction. The lack of meaningful consultation and participation in these processes has led to widespread protests and resistance from indigenous groups, who see the construction

of dams as a violation of their rights to land,

resources, and self-determination. The economic benefits of mega dams are also called into question when considering the long-term costs of environmental degradation and social disruption. While hydroelectric power can provide a source of revenue and electricity, the economic costs of environmental damage, displacement, and the loss of biodiversity are often overlooked. For example, the decline in fisheries due to dams can have significant economic repercussions for communities that rely on fishing for their livelihoods. Similarly, the loss of agricultural productivity due to reduced sediment transport and altered water flow can affect food security and rural economies. The costs of managing increased riverbank erosion, flooding, and other environmental impacts can also place a burden on local governments and communities. In many cases, the economic benefits of dams are concentrated among a small group of stakeholders, while the environmental and social costs are borne by the most vulnerable communities

In recent years, the construction of mega dams in Assam has sparked widespread protests and opposition from civil society groups, environmentalists, and indigenous communities. One of the most controversial

projects is the Lower Subansiri Hydroelectric Project, which has been the subject of protests for over a decade. The dam, located on the Subansiri River, a major tributary of the Brahmaputra, has faced opposition due to concerns about its environmental and social impacts. Environmentalists have raised alarm over the potential for the dam to disrupt the river's ecology, affect fish migration, and increase the risk of downstream flooding. Indigenous groups, meanwhile, have protested against the lack of consultation and the potential displacement of communities.

The resistance to mega dams in Assam has also been fueled by concerns about the region's seismic vulnerability. The Eastern Himalayas, where many of these dams are being constructed, is a seismically active region, prone to earthquakes. The construction of large dams in this area increases the risk of dam failures in the event of an earthquake. A dam failure could have catastrophic consequences for communities living downstream, leading to loss of life, property, and environmental damage. The seismic risks associated with dam construction have been a key argument for those opposing these projects, as the potential for disaster outweighs the perceived enefits of hydroelectric power.

In light of these concerns, there is growing recognition that alternative approaches to water and energy management are needed in Assam. Rather than relying on large-scale infrastructure projects like mega dams, there is increasing interest in exploring decentralized and community-based solutions. Small-scale, run-of-the-river hydroelectric projects, for example, have been proposed as a more sustainable alternative to mega dams. These projects generate electricity without requiring large reservoirs or significant alterations to river flow, minimizing the environmental and social impacts. Community-managed water systems, which prioritize local knowledge and participation, have also been successful in managing water resources sustainably and equitably.

In essence, the construction of mega dams in Assam poses a significant threat to the state's ecology, biodiversity, and communities. While hydroelectric power offers the promise of renewable energy, the environmental and social costs of these projects are immense. Dams disrupt natural ecosystems, displace vulnerable communities, and increase the risk of environmental disasters. In a region as ecologically and culturally rich as Assam, the consequences of these projects could be devastating. As the debate over mega dams continues, it is essential to prioritize sustainable, community-based solutions that protect both the environment and the people who depend on it. # The Amazon: A forest shaped by human hands

or centuries, the Amazon rainforest has been regarded as a vast, untouched wilderness, a pristine ecosystem shaped primarily by natural forces. However, recent research has begun to challenge this perception, revealing that ancient human activities played a significant role in shaping the forest's composition and biodiversity. Archaeological evidence suggests that indigenous peoples have been managing and cultivating the Amazon for at least 4,500 years, transforming it into a vast, edible forest. This historical perspective sheds light on how early inhabitants practiced sophisticated forms of agriculture, develsustainable management techniques that continue to influence the rainforest today.

The indigenous peoples of the Amazon were not merely passive inhabitants of the forest but active stewards of the land. #### Is the spring season dying in India?

The daytime and nighttime temperatures are ranging much higher-thannormal in many regions across India, making it feel like a vanishing spring season, an early onset of the summer season and even heat waves are on the offing.

The higher-than-normal temperature rise is happening despite an ongoing La Nina phenomenon in the equatorial Pacific Ocean which generally causes colder winter and spring seasons in India as it does across many other regions.

The phenomenon is also occurring on the heels of the warmest January month on record in 2025 across the world with a temperature anomaly of 1.75°C above the pre industrial (1850-1900) average for the month.

Between February 9 and February 10 there was a sudden rise in day time temperatures by 2°C in northwest and central India, according to a press release by the India Meteorological Department (IMD).

Current day time temperatures are above normal by 3-4°C in many parts of northwest and central India and by 2°C in the northern parts of peninsular and eastern India, according to IMD. Maximum temperatures over southern India are already in the range of 30-35°C, with the highest of 36.6°C recorded in Kalaburagi in north interior Karnataka.

Additionally, night time temperatures in the same period increased by 2-4°C over most regions of Maharashtra and some regions of Gujarat, west Uttar Pradesh, Rajasthan, southwest Madhya Pradesh, west Telangana, Andhra Pradesh and Yanam.

This heralds a sudden shift to spring time climate over these regions of the country. The immediate reason for this rise in day time and night time temperatures is a warm air mass sitting over Eurasia and China, according to Raghu Murtugudde, professor of climate studies at the Indian Institute of Technology, Bombay and emeritus professor at the University of Maryland.

"The air mass is partially blowing in but the disorganised and weak winds in general are not able to provide any relief," Murtugudde told Down To Earth (DTE). The day time, night time and mean temperatures have been higher-than-normal all through the winter month of January as well.

"The average maximum (day time), average minimum (night time) and mean temperature for the country as a whole during January 2025 were 25.53°C, 12.51°C and 19.02°C respectively, against the normal of 24.61°C, 11.46°C and 18.04°C based on data of 1991-2020," as per IMD.

"Thus, the average maximum, average minimum and mean temperature were above normal with departure from normal of 0.92°C, 1.04°C and 0.98°C respectively for the country as a whole," IMD added.

The mean temperature anomaly over India for January was the second highest since 1901 after 1921 and the average min-

imum temperature was fifth highest since 1901, according to the monthly climate summary for January by IMD. Specifically, over east and north east India the average minimum temperature was second highest since 1901.

The monthly anomalies for minimum and mean temperatures in January 2024 were 0.97°C and 0.51°C, respectively, while the anomaly for maximum temperature was near normal, according to data from the IMD.

During January 2024, an El Nino phenomenon was present in the equatorial Pacific Ocean when generally warmer-than-normal temperatures are observed over India. In January 2025 the spike in temperatures has been observed while a La Nina phenomenon is underway when generally cooler-than-normal temperatures prevail over India.

This shows that the impact of global warming from the emissions of the greenhouse gases, mainly from the burning of fossil fuels, has overshadowed the influence of natural cycles of temperature variations such as the two phases (El Nino and La Nina) of the El Nino Southern Oscillation (ENSO) phenomenon.

The trend of higher-than-average monthly and daily minimum temperatures has been around for the past year or so. In 2024, 11 of the 12 months witnessed higher than normal night time temperatures.

Until around June 2024, the El Nino phenomenon was prevalent and the La Nina started off only in December, according to the National Oceanic and Atmospheric Administration (NOAA) of the United States.

The average minimum and mean temperature anomalies in March 2024 were not as high as in January and February 2024, showing decreasing gap between the average temperatures in these months.

According to a research paper published in October 2023 in the journal npj Climate and Atmospheric Science, there was a positive trend of increasing temperatures by 0.1°C-0.3°C per decade in north west, north east and north central India for the period of March to May from 1980-2020.

From January 2024 to January 2025, the difference in temperature anomaly for minimum temperature was 0.07°C while the difference in temperature anomaly for mean temperature for the month was a staggering 0.47°C

Some experts say that the current rising temperature trend doesn't have anything to do with the La Nina and that it may not even be prudent to call the ongoing phenomenon in the equatorial Pacific Ocean a La Nina, when cooler-than-normal temperatures prevail all over the region

vail all over the region.

"We are a bit careless in calling the pattern a La Nina especially since it's warm in parts of the eastern equatorial Pacific. The Arabian Sea is cool in the west and warm in the east but the Bay of Bengal is very warm all over. So, this has nothing to do with La Nina," Murtugudde told DTE. (Courtesy: Down to Earth)

But as her confirmation hearing begins Wednesday, advocates for workers' rights question whether Lori Chavez-DeRemer will be able to uphold that reputation in an administration that has fired thousands of federal employees.

Chavez-DeRemer, a former Republican member of Congress from Oregon and former mayor of a small city on the edge of liberalleaning Portland, is scheduled to appear before the Senate Committee on Health, Education, Labor & Pensions, the first stop in her confirmation process.

During her one term as a congresswoman, Chavez-DeRemer's voting record earned her strong union support. Some political observers surmised that Trump picked her as his labour secretary as a way to appeal to voters who are members of or affiliated with labour organizations. She is the daughter of a Teamster member.

Before she lost her House reelection bid in November, Chavez-DeRemer backed the PRO Act, legislation that would allow more workers to conduct union organizing campaigns and penalize companies that violate workers' rights. The bill, one of former President Joe Biden's priorities, passed the House in 2021 but didn't gain trac-

tion in the Senate. If confirmed as secretary, Chavez-DeRemer would be in charge of the Department of Labour's nearly 16,000 full-time employees and a proposed budget of \$13.9 billion in fiscal year 2025. She would set priorities that impact workers' wages, ability to unionize, and health and safety, as well as employers' rights to fire employ-

But it's unclear how much power Chavez-DeRemer will be able to



slash US government spending and the size of the federal workforce. During his first month in office, the president froze trillions of dollars in federal funding and offered buyouts to most federal workers.

His administration last week started laying off nearly all probationary employees who had not yet gained civil service protection. Billionaire Elon Musk, who leads Trump's Department of Government Efficiency, has called for getting rid of entire agencies.

'The Department of Labour is the agency where people in building are supposed to wake up every day thinking about how they can improve the lives of working people," said Adam Shah, director of national policy at Jobs with Justice, a nonprofit organization that promotes workers' rights. "It's quite possible that no matter what the secretary of labour stands for, the billionaire embedded in the Trump administration, who is so keen on destroying the institutions, will be interested in gutting the Department of Labour.

In January, Trump fired two of three Democratic commissioners serving on the Equal Employment Opportunity Commission, a federal agency that enforces civil rights in the workplace. He also fired the acting chair of the National Labour Relations Board, Gwynne Wilcox, the first Black woman to serve as an NLRB member, as well as General Counsel Jennifer Abruzzo. Wilcox sued the Trump administration, arguing that federal law protects her from being arbitrarily

#### Trump living in Russian 'disinformation space,' says Ukraine's Zelenskyy

KYIV, Feb 19: Ukraine President Volodymyr Zelenskyy said Wednesday that US President Donald Trump is living in a Russian "disinformation space" regarding his previous day's comments about the Ukrainian leader's approval rating.

Trump said at Mar-a-Lago that Zelenskyy's rating stood at 4 per cent. Zelenskyy replied in a news conference in the Ukrainian capital Kyiv that "we have seen this disinformation. We understand that it is coming from Russia.'

He said that Trump "lives in this disinformation space.3

Trump also suggested Ukraine ought to hold elections, which have been postponed due to the war and the consequent imposition of martial law, in accordance with the Ukrainian Constitution.

Public opinion polls and approval ratings haven't been reliable in Ukraine because of the fighting.

Zelenskyy made the comments shortly before he was expected to meet with Keith Kellogg, the US special envoy for Ukraine and Russia, who arrived in Kyiv on Wednesday. Kellogg will meet Zelenskyy and military commanders as the US shifts its policy away from years of efforts to isolate Russian President Vladimir Putin.

Trump suggested Tuesday that Kyiv was to blame for the war, which enters its fourth year next week, as talks between top American and Russian diplomats in Saudi Arapean supporters.

Trump's comments are likely to vex Ukrainian officials, who have urged the world to help them fight Russia's full-scale invasion that began February 24, 2022.

The battlefield has also brought grim news for Ukraine in recent months. A relentless onslaught in eastern areas by Russia's bigger army is grinding down Ukrainian forces, which are slowly but steadily being pushed backward at some points on the 1,000-kilometre front

Trump told reporters at his Florida residence Tuesday that Ukraine "should have never started" the war and "could have made a deal" to pre-

Kellogg said his visit was "a chance to have some good, substantial talks." Zelenskyy cancelled his planned Wednesday trip to Saudi Arabia in what some analysts saw as an attempt to deny legitimacy to the US-Russia talks about the future of his country.

American officials have signaled that Ukraine's hopes of joining NATO in order to ward off Russian aggression after reaching a possible peace agreement won't happen. Zelenskyy says any settlement will require US security commitments to keep Russia at bay.

"We understand the need for security guarantees," Kellogg said in comments carried by Ukrainian public broadcaster Suspilne Novyny on his arrival at Kyiv train station. (AP)

Trump's national security advisor Michael Waltz and special Mideast envoy Steven Witkoff joined Rubio at the table, along with Lavrov and Russian President Vladimir Putin's foreign affairs advisor Yuri Ushakov

No Ukrainian officials were present at the meeting, which came as



more numerous Russian troops in a grinding war that began nearly three years ago.

Ukrainian President Volodymyr Zelenskyy said his country would not accept any outcome from the talks since Kyiv didn't take part, and postponed his own trip to the kingdom scheduled for Wednesday. European allies have also expressed concerns that they are being

sidelined. Trump showed little patience for Ukraine's objections to being excluded from the talks.

"Today I heard, 'Oh, well, we weren't invited.' Well, you been there for three years. You should have ended it three years ago," Trump said during a news conference at his Florida residence. "You should have never started it. You could have made a deal.'

Russia, US agree to work toward ending

Ties between Russia and the US have fallen to their lowest level in decades in recent years -- a rift that has been widening ever since Russia illegally annexed Crimea from Ukraine in 2014 and only worsened after Moscow's full-scale invasion.

The US, along with European nations, imposed a raft of sanctions on Russia in an effort to damage its economy. And embassies in Washington and Moscow have been hit hard by expulsions of large numbers of diplomats, as well as other restrictions.

Rubio said on Tuesday that ending the war in Ukraine could "unlock the door" for "incredible opportunities" to partner with the Russians on issues of common in-

terest "that hopefully will be good for the world and also improve our relations in the long term"

His comments were further evidence of the remarkable US reversal on Russia after years in which Trump's predecessor, Joe Biden, led international efforts to isolate

Tuesday's meeting was meant to pave the way for a summit between Trump and Putin. After the talks. Ushakov and Waltz said no date has been set yet for that summit.

Speaking to reporters after the meeting, Lavrov mentioned the same three goals as Rubio and said that Washington and Moscow agreed to appoint representatives to carry out "regular consultations" on Ukraine. The meeting marked the most extensive contact between the two countries since Moscow's February 24, 2022, invasion.

The recent US diplomatic blitz on the war has sent Ukraine and key allies scrambling to ensure a seat at the table amid concerns that Washington and Moscow could press ahead with a deal that won't be favourable to them.

Kyiv's absence at Tuesday's talks rankled many Ukrainians, and France called an emergency meeting of European Union countries and the UK on Monday to discuss the war. Kyiv's participation in such talks was a bedrock of US policy

US State Department spokeswoman Tammy Bruce said the talks were aimed at determining how serious the Russians are about achieving peace and whether detailed negotiations can start.

Rubio said Tuesday that there would be "engagement and consultation with Ukraine, with our partners in Europe and others. But ultimately, the Russian side will be indispensable to this effort".

US Defense Secretary Pete Hegseth said last week that NATO membership for Ukraine was unrealistic and suggested Kyiv should abandon hopes of winning all its territory back from Russia -- two key items on Putin's wish list.

French President Emmanuel Macron on Tuesday said he spoke by phone to Trump and Zelenskyy following Monday's European meeting. The meeting at the Diriyah Palace in the Saudi capital of Riyadh also highlighted de facto leader Crown Prince Mohammed bin Salman's efforts to be a major diplomatic player.

Saudi state media described the talks as happening at the prince's direction. Like the neighbouring UAE, the prince has maintained close relations to Russia throughout its war on Ukraine, both through the OPEC+ oil cartel and diplomatically as well. (AP)

#### Migrant groups say racist attacks increase in German city after deadly Christmas market violence

Feb 19: When Haben Gebregergish first immigrated to the German city of Magdeburg seven years ago, the Eritrean immigrant was walking to the supermarket with her child when an intoxicated woman approached her on the

At the time, Gebregergish did not speak German well enough to comprehend what the woman was saying. But Gebregergish says that when the woman threw a beer bottle at her head, she immediately understood.

It was one of her first encounters with racism, but certainly not the last. In the aftermath of a deadly attack at a Christmas market in Magdeburg late last year, Gebregergish and other migrants who have settled in the city say they have experienced a sharp increase in racism and anti-immigration sentiments.

"We are the same as you." Gebregergish said earlier this month. "We are not different. Just like you, we have feelings. Sometimes we just like everyone else."

MAGDEBURG (GERMANY), was one of five high-profile attacks committed by immigrants in the past nine months that have made migration a key issue as the country heads toward an early election on Sunday. The suspect, a Saudi doctor, drove into the holiday market teeming with shoppers and left five women and a 9-year-old boy dead and 200 people injured.

The suspect arrived in Germany in 2006 and had received permanent residency, and authorities say the suspect does not fit the usual profile of perpetrators of extremist attacks. He is being held in custody as authorities investigate him.

Just one day after December 20 violence, there was a large rightwing demonstration in Magdeburg, and verbal and physical attacks on people with a migrant background have increased significantly in the city since then, according to the German-Syrian Cultural Association in Magdeburg.

"The migrant community and the advice centers report that attacks have increased by more than 70 per cent here in the city," said Saeeid Saeeid, who came to Gercity's Cooperation with the Advinst like everyone else." many from Syria seven years ago sory Council for Integration and and is a member of the association. Migration will be expanded. (AP)

"Racism already exists here and everywhere. But it has increased enormously since the attack."

Ketevan Asatiani-Hermann, newly elected chair of the board for the Advisory Council for Integration and Migration in Magdeburg, said victims of racist attacks in the city often do not feel support from politicians or police.

"The hatred has always been there, people just didn't dare to say it so clearly before," said Asatiani-Hermann, who came to Magdeburg in 2011 from Georgia.

Officers sometimes target or search the victims first before the perpetrator, she alleged, and they also worry reporting an attack could have a negative impact on their residence status.

The Magdeburg Police Department did not respond to multiple requests for comment. Mayor Simone Borris, in a state-

ment, said: "Cohesion and community are fundamental values of a city that are inviolable." The mayor also referred media to online services for migrants, and said the

#### Senate GOP pushes ahead with budget bill that funds Trump's mass deportations and border wall

Republicans pushed ahead late on Tuesday on a scaled-back budget bill, a USD 340 billion package to give the Trump administration money for mass deportations and other priorities, as Democrats prepare a counter-campaign against the onslaught of actions coming from the White House.

On a party-line vote, 50-47, Republicans launched the process, skipping ahead of the House Republicans who prefer President Donald Trump's approach for a 'big, beautiful bill" that includes USD 4.5 trillion in tax cuts that are tops on the party agenda. Senate Republicans plan to deal with tax cuts later, in a second package.

"It's time to act," said Senate Majority Leader John Thune on social media, announcing the plan ahead as the House is on recess week. "Let's get it done."

This is the first step in unlocking Trump's campaign promises -- tax cuts, energy production and border controls -- and dominating the agenda in Congress.

While Republicans have majority control of both the House and Washington power, they face big on those issues. (AP)

#### US top diplomat Rubio visits UAE after EU envoys approve more sanctions against Russia landmark talks with Russia over Ukraine war to mark third anniversary of its war on Ukraine

ABU DHABI, Feb 19: US Secretary of State Marco Rubio on Wednesday met with the leader of the United Arab Emirates, wrapping up an overseas trip that saw the highest-level outreach between the United States and Russia since Moscow launched its full-scale invasion of Ukraine in 2022. Rubio's talk with Sheikh Mohammed bin Zayed Al Nahyan, also the ruler of Abu Dhabi, comes as the US also tries to continue a shaky ceasefire in the Gaza Strip between Israel and the militant Hamas group.

The UAE, which diplomatically recognised Israel in 2020 during President Donald Trump's first term, also has been key in mediating prisoner swaps between Russia and Ukraine.

There was no immediate readout on what Rubio, Sheikh Mohammed and Sheikh Abdullah bin Zayed Al Nahyan, the UAE's foreign minister, discussed in their roughly 30-minute meeting. Ukraine's President Volodymyr Zelenskyy met with Sheikh Mohammed on Monday. Both the UAE and Saudi Arabia have been

discussed as possible sites for peace talks to end the war in Ukraine, which marks its third anniversary on Monday. Saudi Arabia also has been mentioned as the possible venue for a meeting between Trump and Russian President Vladimir Putin, providing a potential diplomatic boon to Saudi Crown Prince Mohammed bin Salman, the kingdom's de facto ruler. The leaders met Rubio at an Abu Dhabi con-

vention center that's hosting the biennial International Defense Exhibition and Conference this week, where both Ukraine and Russia have displayed weapons — even as Moscow faces Western sanctions over the war. (AP)

BRUSSELS, Feb 19: European Union envoys have approved a new raft of sanctions against Russia, with the measures set to enter into force next week on the third anniversary of its full-scale invasion of Ukraine, a top EU official and diplomats confirmed on Wednesday.

The move comes with the Europeans sidelined from US-led talks to end the war. The EU has slapped several rounds of

sanctions on Russia since President Vladimir Putin ordered his troops into Ukraine in February 24, 2022. More than 2,300 officials and entities - usually government agencies, banks and organizations - have been hit. The diplomats confirmed approval of the

sanctions — the 16th package of measures

including travel bans, asset freezes and trade restrictions — on condition that they not be named. The measures are still not entirely finalised until EU foreign ministers endorse them on Monday, allowing them to

enter force.

Among the latest sanctions are measures targeting Russia's so-called "shadow fleet " of ships that it exploits to skirt restrictions on transporting oil and gas, or to carry stolen Ukrainian grain. Some 70 vessels believed to be part of the shadow fleet will be added to more than 50 already listed. EU Commission President Ursula von

der Leyen, whose services drafted some of the measures for consideration, welcomed their prospective adoption by the 27-nation bloc's ambassadors. (AP)

# White House says Elon Musk not in charge at DOGE but advising president

WASHINGTON, Feb 19: The White House says billionaire Elon Musk is not technically part of the Department of Government Efficiency team that is sweeping through federal agencies but is rather a senior advisor to President Donald Trump.

Musk's exact role could be key in the legal fight over DOGE's access to government data as the Trump administration moves to lay off thousands of federal workers. Defining him as an advisor rather than the administrator in charge of day-to-day operations at DOGE could help the administration as it pushes back against a lawsuit arguing Musk has too much power for someone who isn't elected or Senate-confirmed.

The declaration was filed on Monday as the Trump administration fends off the lawsuit from several Democratic states that want to block Musk and the DOGE team from accessing government systems. The litigants say Musk is wielding "virtually unchecked power" in vio-



lation of the Constitution.

The Trump administration, on the other hand, says Musk is not a DOGE employee and has "no actual authority to make government decisions himself", Joshua Fisher, director of the White House Office of Administration, said in court papers. The documents do not name the administrator of DOGE, whose work Musk has championed in posts on

his social-media platform X and in a public appearance at the White House.

White House press secretary Karoline Leavitt declined on Tuesday to tell reporters at the White House who the DOGE administrator is, though minutes before she said in an interview with Fox News Channel that Musk has been tasked with overseeing the effort on behalf of the

Lavoffs, she told reporters, are up to individual agency heads. "Elon Musk, just like everybody else across the federal government, works at the direction of President Trump," Leavitt said. The DOGE team has roamed

from agency to agency, tapping into computer systems, digging into budgets and searching for waste, fraud and abuse, while lawsuits pile up claiming Trump and DOGE are violating the law. At least two are targeting Musk himself. Last week, Musk called for the

US to "delete entire agencies" from the federal government as part of the push to radically cut spending and restructure its priorities. US District Judge Tanya Chutkan seemed sceptical in a hearing on

#### Nagaland govt puts on hold transfer, posting of 1,650 school teachers

KOHIMA, Feb 19: The Nagaland government has put on hold the process of transfer and posting of 1,650 government school teachers across the state.

Principal director of school education. Thavaseelan K. in a notification issued on Monday, said, "In the interest of public service, the orders dated February 6 and February 10 are hereby kept on hold till further orders pending re-

Earlier this month, Nagaland's Department of School Education had issued the transfer and posting of the teachers.

On February 6, the department issued a notification regarding the re-deployment of 278 mathematics and science graduate teachers while on February 10 it notified the transfer and posting of 840 primary teachers, 341 graduate teachers and 191 graduate Hindi teachers and undergraduate Hindi teachers as part of the rationalisation of teachers in government schools across the state.

All these teachers were asked to join their new place of posting within seven days from the date of the announcement.

The department had asserted that no requests for retention or reconsideration of postings will be entertained under any circumstance while failure to comply with the new posting will result in withholding of their salaries.

Following the rationalisation notification, various student bodies expressed serious concern and opposed the process saying it is irrational and unjustified while it would have far-reaching implications for the entire state.

The student bodies, while asserting that they support teachers' rationalisation policy, alleged that, however, this time, the process had been done randomly without any groundwork, statistical reports and without consulting the district authorities.

They remarked that the hasty and arbitrary transfer of teachers has created uncertainty and chaos among students, parents and the teaching community, affecting not only the academic environment but also the future of students.

Advisor to school education and SCERT, Kekhrielhoulie Yhome, while speaking to PTI on Saturday, had said that despite the difficulties and opposition, the rationalisation process would continue as planned, with the department revisiting cases where specific concerns or exceptional issues arise. (PTI)

#### Five militants, one sympathiser arrested in Manipur

IMPHAL, Feb 19: Five militants belonging to three banned outfits have been arrested in Manipur in the last two days, police said on Wednesday.

One sympathiser of a proscribed organisation has also been nabbed.

#### 129 KHADC, 95 JHADC polling stations marked vulnerable

SHILLONG, Feb 19: A total of 129 polling stations have been identified as vulnerable and critical in areas under the Khasi Hills Autonomous District Council (KHADC) and 95 in the Jaintia Hills Autonomous District Council (JHADC) even as Commissioner & Secretary in-charge District Council Affairs (DCA) Cyril Diengdoh has assured adequate deployment of security forces is in place to ensure a free, fair and smooth ADC elections to be held on Febru-

Speaking to reporters on Wednesday, Diengdoh said, "All arrangements are in place. We have had multiple review meetings with the deputy commissioners, who are responsible to conduct the elections. The security plans are in place. The opposition party's assertion came after the SEC told a federal iudge in New York that its efforts to serve its complaint on Gautam Adani and Sagar Adani in the alleged bribery scheme are "ongoing". This included a request for assistance to the Indian authorities.

Congress general secretary incharge communications Jairam Ramesh said the SEC has just informed a New York district court that it has sought the assistance of the Modi government to serve complaints on the violations of US laws by Gautam Adani and some of his

"The PM has already declared the Modani issue to be a personal matter. Will he oblige the SEC?" Ramesh said on X

#### Karnataka Minister says guarantee scheme money not monthly salary; BJP hits back

BENGALURU, Feb 19: Karnataka Energy Minister K J George's remark that funds from the guarantee schemes are "not like a monthly salary," in response to complaints about delays in payments to beneficiaries has drawn sharp criticism from opposition BJP leaders on Wednesday.

There have been complaints about non-payment of funds to beneficiaries of Anna Bhagya (which provides cash in lieu of the additional 5 kg of rice to every member of a BPL household) and Gruha Lakshmi (which offers ₹ 2,000 per month to women heads of families) for the past couple of months in some cases.

Speaking to reporters in Chitradurga on Tuesday, George said, "Money is transferred every month to beneficiaries' bank accounts, but there may have been delays for some. Is there something the Minister should know about it? As soon as we are informed, steps will be taken to rectify it immediately. This is not like a monthly salary. The Chief Minister has assured that all pending payments will be cleared by May, as promised."

He added, "There may be a delay of 10 to 15 days due to various reasons." Reacting sharply, the Leader of the Opposition in the Legislative Assembly, R Ashoka, questioned the Minister's attitude toward vot-

"Is this your respect for voters? They are not begging for Gruha Lakshmi and Anna Bhagya funds. People did not ask you to introduce these guarantee schemes," he said.

Criticising the government for allegedly "belittling" voters after launching the schemes for electoral gains, Ashoka added, "If you can implement the guarantee schemes as promised, do so with respect. If not, step down. People were managing their lives before these schemes and will continue to do so without them.'

"Do not insult the self-respect of Kannadigas. The Congress party has already lost ground across the country. If the self-respect of Kannadigas is hurt, it is guaranteed that Congress will be wiped out in Karnataka too," he warned. (PTI)

#### No illegalities in land purchased about 40 years ago: Union Minister Kumaraswamy

BENGALURU, Feb 19: With revenue department officials conducting a survey of land belonging to him in Ramanagara district, Union Minister H D Kumaraswamy on Wednesday asserted that there are no illegalities in the land he purchased about forty years

The JD(S) leader, claiming that he was being targeted, also hit out at the ruling Congress government in the state and Chief Minister Siddaramaiah.

"I purchased the land 40 years ago. For forty years, surveys and investigations have been done a number of times. I have been open to it....there were no complainants for forty years. How have they emerged all of a sudden now?," Kumaraswamy asked.

Speaking to reporters here, he pointed out that in 1986-87 itself, Congress leader C M Lingappa and Ramachandra, a zilla panchayat member, had submitted a petition to the then Chief Minister, Prime Minister and Home Minister and others, alleging that the land was

"I have all the documents. This government and those claiming to protect the state resources (activists)

have gone against me. So far I have not got any notice from the High Court. On getting to know that officials were coming for a survey of the land owned by me without even serving a notice, I questioned the Principal Secretary and Deputy Commissioner, then they subsequently served notice. I allowed the survey. I even told them they can get the survey by any international agency," he said.

Asserting that there were no illegalities in the land he had purchased, the union minister, attacking the Congress, said he has documentary evidence about who has indulged in what kind of illegalities, and how the government lands have been illegally acquired by others. "But in today's system, the logical end cannot be reached," he added.

Revenue department officials on Monday conducted a survey of Kumaraswamy's farm land at Kethaganahalli in Bidadi hobli of Ramanagara district.

Social activists had alleged that 14 acres of government land had been encroached by Kumaraswamy. The High Court had directed the revenue department to submit a report. (PTI)

He also invited people from across the globe to explore the picturesque region popularly known as 'paradise on earth'.

Speaking at the inauguration of the SATTE exhibition at Yashobhumi here, Abdullah highlighted J&K's rich and diverse offerings beyond its famous tourist spots like Gulmarg and Pahalgam or religious pilgrimage to Mata Vaishno Devi and Amarnath shrines.

Jammu and Kashmir offers a lot more to satisfy anyone from holiday makers to adventure sports lovers and influencers to social media enthusiasts, he said at the South Asia's Travel and Tourism Exchange (SATTE).

The chief minister talked about improved connectivity between Kashmir and the rest of the country, including the direct rail link which is likely to start anytime

"The shadow of evil eye resulted in a difficult time for J&K over the past 30 to 35 years but the region is now emerging out of it and is once again one of India's prominent destinations for domestic tourism

"International tourism is also picking up in spite of the difficulties that we have with travel advisories issued by various embassies and consulates," Abdullah said, referring to the eruption of terrorism in early 1990.

Quoting famous Persian poet Amir Khusrau who once said "Gar firdaus, bar ruhe zamin ast, hamin asto, hamin asto, hamin ast (If there is paradise on this earth, it is here, it is here, it is here), Abdullah explained the cultural concept of 'nazar' (evil eye), suggesting that the region's beauty has often been overshadowed by challenges.

He reminisced about the significance of J&K in Indian culture, mentioning that no honeymoon was complete without a stay on the

He alleged that the Congress' wrong political approach helped the BJP win Haryana and Maharashtra. Referring to the INDIA formation, Vijayan said the alliance which had shattered the BJP's hopes of securing a two-thirds majority in the Lok Sabha elections has now been abandoned by the Congress.

#### Commits to make state USD 350-bn economy by 2030

JAIPUR, Feb 19: Recruitment for up to 2.75 lakh positions in the government and private sector. water supply projects, and the construction of nine greenfield expressways were the highlights of the Rajasthan Budget 2025-26 presented by state Finance Minister Diya Kumari in the assembly on Wednesday.

Supreme Court on Wednesday adjourned the pleas against the appointments of the chief election commissioner (CEC) and election commissioners (EC) under the

A bench of Justices Surya Kant and N Kotiswar Singh indicated that the matter would be listed after the Holi festival break due to paucity of time. However, no date was fixed for hearing the matter.

Advocate Prashant Bhushan, appearing for petitioner NGO Association for Democratic Reforms, said it was an important issue which required an urgent consideration.

He said the matter involved a short legal question -- whether the 2023 Constitution bench verdict should be followed for the appointment of the CEC and ECs through a panel involving the Prime Minister, Leader of Opposition and the Chief Justice of India or the 2023 law, which excludes the CJI from the panel.

At around 3 pm, Justice Surya Kant told Bhushan that he would be sitting in a special bench and the court had numerous matters listed before the Holi break.



be listed on any day in the coming week and assured the petitioners would not take more than an hour to advance submissions.

Advocate Varun Thakur, appearing for petitioner Java Thakur, also mentioned the matter for an urgent hearing saying it was "very important for the survival of democracy".

Justice Surya Kant said, for the court, all matters were equally important and no single matter was superior to others.

Bhushan referred to the 2023 verdict, saying it held that the election commissioners had to be selected for appointment by an independent panel comprising the prime minister, Leader of Opposition and Chief Justice of India.

On March 15, 2024, the top court refused to stay the appointments of the new ECs under the 2023 law which excluded the CJI from the selection panel and deferred the hearing on a batch of pleas against the appointments. The apex court told



#### India, Malaysia agree to form joint focus group to address nontraditional maritime security threats



NEW DELHI, Feb 19: India and Malaysia on Wednesday identified ways to deepen existing defence collaborations between the two nations, particularly in the fields of maritime security, multilateral engagements and defence industry, as they agreed to form a "joint focus group" to address non-traditional

maritime security threats. Both sides also identified steps to further enhance cooperation in emerging areas such as cybersecurity and Artificial Intelligence (AI), the Indian defence ministry said.

The 13th Malaysia-India Defence Cooperation Committee (MIDCOM) meeting took place in Kuala Lumpur on Wednesday.

The meeting was co-chaired by Defence Secretary Rajesh Kumar Singh and Lokman Hakim Bin Ali, Secretary General, Ministry of Defence, Malaysia,

"Both sides expressed happiness at the growing bilateral defence cooperation with regular engagements between the two armed forces in recent years," the defence ministry said in a statement.

The two sides held wide-ranging discussions on effective and practical initiatives to further expand bilateral defence engagements, and on regional and global issues.

"Both chairs identified steps to further enhance cooperation in emerging areas such as cybersecurity and AI. They identified ways to deepen the existing collaborations, particularly in defence industry, maritime security, and multilateral engagements," the statement said. They also agreed to form a "joint focus group to address non-traditional maritime security threats", it said.

#### Safeguarding privacy as a human right in digital world is necessary: NHRC chief

NEW DELHI, Feb 19: NHRC chairperson Justice (retd) V Ramasubramanian emphasised that safeguarding "privacy as a human right" in the digital world is necessary, even as he pointed out that there is a "significant decline" in value systems and one must bear its consequences.

The National Human Rights Commission chief's remarks came during an open house discussion on 'Ensuring privacy and human rights in the digital era: A focus on corporate digital responsibility' held at its premises, with some participants joining virtually, according to an NHRC statement on Wednesday.

Some of the important suggestions that emanated from the discussion include simplifying user agreements and policy frameworks to enhance consumer understanding and control over personal data; establishing "clear accountability" structures for data breaches, especially for research institutions and third-party data processors; and

strengthening user consent frameworks for greater transparency and informed decision-

Having "explicit penal provisions for non-compliance"; need cal data due to data storage in offfor bilateral agreements to address cross-border security and datasharing concerns; addressing the challenges arising from strict data localisation mandates: and having clear guidelines for obtaining verifiable parental consent for minors, were also suggested.

Addressing the participants, the NHRC chairperson "emphasised that safeguarding privacy as a human right in the digital world is necessary", the statement said.

The technological advancements should "align with fundamental human rights and privacy protection". The responsibility must begin with the individual user, it

However, following the intervention of the Centre and the state government, the KIIT authorities tendered an apology and requested the Nepalese students to return to the campus

Majhi, who is currently in Rajasthan, spoke over the phone with officials from Nepal, Sanjeeb Das Sharma and Navin Raj Adhikari, who held a meeting with Odisha Parliamentary Affairs Minister Mukesh Mahaling and Higher Education Minister Suryabanshi Suraj, along with Chief Secretary Manoj Ahuja at the State Guest House here during the day on the evolving situation.

#### Odisha CM urges Nepalese students to **UP woman kills husband with lover's help, cops** say tension over rape case had a role in murder protest petition in court." The tension

MAINPURI (UP), Feb 19: A woman and her lover were arrested for allegedly killing her husband here in Uttar Pradesh's Mainpuri. Apart from the affair their motive is also believed to be the husband's reluctance to pursue a case of the woman's alleged gang rape, police said on Wednesday.

Amna allegedly added sleeping pills to her husband Mohammed Sajid's food on Sunday, making him unconscious, while 25-year-old Sumit allegedly struck him with an iron wrench. The duo then took the husband's body to a field and set it on fire to destroy any evidence, they said.

Police, however, found a partially burnt body and began an investigation based on a complaint by the victim's father, Aashiq Ali. Superintendent of Police (SP) Ganesh Prasad Saha confirmed the arrests and said the incident came to light on Monday when Aashiq Ali filed a complaint at Bichwan police station.

The complainant alleged that his son. Mohammed Sajid had been murdered by Baisthwa Bhola Yadav and his son -- both residents of Partapur, Bhogaon. The complaint further claimed that Sajid's body was set on fire after his death. In 2022, Amna had accused Yadav and his sons of gang rape and filed an FIR against them. However, the police filed a final report in court in December 2022, deeming the allegations false.

Amna, dissatisfied with the outcome, filed a protest petition in the court through her husband later that month. The matter was still sub-judice, with the next hearing scheduled for February 20, 2025.

The SP added, "Amna was unhappy with her husband as she believed he was reluctant to pursue the

surrounding this issue is believed to have played a role in Sajid's killing, he said. Following Sajid's death, police

lodged an FIR and launched a probe. Analysis of call data of Sajid and Amna led police to arrest Sumit. Further investigation revealed that

Sumit, a resident of Bichwan, had been involved in a relationship with Amna. Police claimed Sumit confessed that he and Amna planned Sajid's murder together.

On the night of February 16, Amna allegedly laced her husband's food and tea with sleeping pills, rendering him unconscious. Once Sajid was incapacitated, Sumit struck him on the head with an iron wrench. The pair then transported the body to a nearby field and set it on fire to destroy any evidence, Sumit told police. (PTI)

#### Ensure child care, feeding rooms Court rejects discharge plea of Dawood gang member in public buildings: SC to states

in terror funding case MUMBAI, Feb 19: A court here has refused to discharge a member of the Dawood Ibrahim gang in an alleged terror funding case, holding that there was enough evidence to show his apparent involvement in the crime.

The Maharashtra Anti-Terrorism Squad (ATS) arrested Parvez Vaid in August 2022, acting on information that fugitive gangsters Dawood Ibrahim and his brother Anees were sending money acquired out of "proceeds of crime" to India for terrorist activities through their associates in

the country. Vaid was booked under the Unlawful Activities (Prevention) Act (UAPA) for allegedly being members of a terrorist organization, as well as under the Narcotic Drugs and Psychotropic Substances (NDPS) Act.

The Bombay High Court granted him bail last year, following which he filed a discharge application before the special court for UAPA cases. Judge B D Shelke, in the order passed on Tuesday, held that from the statements of witnesses and docu-

ments "it can be safely gathered that

there are sufficient grounds for pro-

ceeding against the accused". (PTI)

NEW DELHI, Feb 19: The Supreme Court on Wednesday outlined the importance of separate spaces for child care and feeding of infants in public buildings and asked states to ensure such facilities were provided. A bench of Justices B V Na-

garathna and Prasanna B Varale said setting up such facilities would ensure privacy of mothers and prove beneficial for infants. In existing public spaces, as far as practicable, the state govern-

ments may ensure such facilities were provided, added the court. "In so far as public buildings which are at the stage of planning and construction at public places, the state governments may ensure that sufficient space is reserved for the purposes referred to above,"

said the bench. The top court was hearing a plea seeking directions to construct feeding rooms, child care rooms or any other facilities for infants and mothers in public spaces.

The Centre's counsel said the secretary of the Ministry of



Women and Child Development on February 27, 2024, issued a communication on the issue to chief secretaries and administrators of all states and union territo-

Saying it was conscious that it issued no notice to states and UTs, the bench expressed satisfaction over the secretary's communication incorporating the prayers mentioned in the plea.

"On a perusal of the same, we

find that the advice for setting up

of the aforesaid facilities at public places is for the purpose of ensuring privacy and ease of discharging of duties of mothers who have young children and for the benefit of the infants," it added.

The bench said if the advice was

acted upon by the states, it would go a long way in facilitating privacy to young mothers and infants at the time of feeding.

"We find that the said advice which has been issued by the central government is in accordance

with the fundamental rights ensured under Articles 14 and 15 (3) of the Constitution," said the court.

The court directed the Centre to incorporate the advisory in the form of a reminder communication to the chief secretaries and administrators of the states and UTs along with a copy of its order.

The petitioner's counsel said states complying with the advisory issued by the Centre on February 27, 2024, would serve the purpose of filing the plea. The bench disposed of the plea

and asked the Centre to comply with its direction within two weeks. The plea sought a direction to the authorities to ensure the fundamental right of nursing mothers and infants were protected aside from dedicating exclusive spaces

for child care and feeding in public

buildings, etc. The top court on November 19, 2024 observed at the moment. there appeared to be no concrete law including rules or notifications, issued by the Centre. (PTI)


Kaushal is currently in the spotlight for portraying Chhatrapati Shivaji's son Sambhaji Maharaj in the Hindi movie

# Former Mumbai captain and selector Milind Rege dies at 76

MUMBAI, Feb 19: Former Mumbai captain and selector Milind Rege, a highly respected figure in domestic cricket, died after suffering a heart attack on Wednesday, just days after turning 76. Rege, who turned 76 last Sunday, was admitted in the intensive care unit of the Breach Candy Hospital here and passed away around 6am on Wednesday morning. He is survived by his

heart attack at the age of 26 but returned to the cricket field and even captained Mumbai in the Ranji Trophy. He played 52 First-Class matches between 1966-67 and 1977-78, taking 126 wickets with his right-arm off-break bowling. He also contributed with the bat, scoring 1,532 runs at an average of 23.56.

Antonelli says Lewis Hamilton

LONDON, Feb 19: As an 18year-old rookie taking over Lewis Hamilton's spot at Mercedes, Andrea Kimi Antonelli is having an introduction to Formula 1 unlike any other. Fortunately, he's had some advice

from the seven-time champion. "He said mainly to enjoy (it), not worrying about the external circumstances," Antonelli told reporters Tuesday. "Just working on yourself, enjoy the process, that was the main thing he said." Given Hamilton's legacy at Mercedes, where he won six titles, and his influence on F1, Antonelli prefers to be called "the next Mercedes driver" rather than the replacement for Hamilton, who's now at Ferrari.

Hamilton's own rookie season for McLaren in 2007 — one year after Antonelli was born went down in F1 history as he won four races and missed out on the title by one point to Kimi Raikkonen.

"Looking back at his 2007 season, which was incredible because he almost won the championship in his rookie year, what was quite impressive was the consistency," Antonelli said.

"What (Hamilton) did really well is starting off well and then keep developing without trying to do too much. That's why he did an amazing season and that's what I'm going to try to do."

Long considered one of the most promising talents in junior series, Antonelli raced in Formula 2 last year and got his first taste of F1 with a drive in Friday practice at his home Italian Grand Prix in August. Driving George Russell's car, he had a high-speed crash and apologized to team principal Toto Wolff. Antonelli said Mercedes gave him the support he needed.

"When you have the right people around you, they really help you not to get too bogged down by these things. I think the natural thing for a driver is you go on track and you try to push as hard as you can," he said.

"And the F1 (cars) nowadays are really complicated on this factor because the aerodynamic (effect) is so powerful that the fine line between being on the limit and going over is so little. And as soon as you go 105%, it happens like what happened in Monza.

Antonelli was able to drive an F1 car before he could legally drive on the road and only got his license last month. His examiner turned out to be a fan.

"I was quite nervous, I'm not going to lie, because I didn't want to fail," Antonelli said. "It was nice because after the test, we also had a nice conversation about everything because she's really passionate about the sport." (AP)

He was particularly emboldened by the rise of pace sensation Nahid Rana, who has added a new dimension to their bowling attack. The 22-year-old Rana holds

the record for the fastest ball (152kph) bowled by a Bangladesh cricketer, hits 150kph on occasion, and averages 145kph for most of his

Besides the presence of Rana and experienced pace colleague like Taskin Ahmed, the team also has few useful all-rounders and spinners, and some good batters.

"Obviously, all-rounders always balance the team and we have got some good allrounders. I hope they will perform tomorrow," Shanto said in the pre-match press conference here on Wednesday.

"If you look in this format, our

team is quite balanced and we believe we can beat any team in this tournament. All teams are capable of winning this trophy but I am someone who is not thinking about the opponents much. If we execute our plan properly we can beat any team in any day," Shanto said.

After years of struggle, Bangladesh are now in a position to boast a good pace-bowling attack, feels Shanto.

Yes, obviously. I think we always struggle with our seam attack, but last couple of years we have got some quality fast bowlers. Now we have got Nahid Rana, Taskin the way they are bowling. I think it helps

"As a captain, we love to see them bowling fast. So, I'm really happy that we have got a good fast bowling unit and under lights the ball might swing. So, if they bowl in the good areas, it will help our team.

Rana has done well in his nascent career, having taken 20 wickets in six Tests and four scalps in three ODIs.

# India look to rise above selection challenges, past turbulence against Bangladesh in their CT opener

DUBAI, Feb 19: A turbulent recent crick eting past has made a resonant effort mandatory for India in the Champions Trophy, and their opening match against a tricky Bangladesh here on Thursday will be the first point in assuaging a set of existential questions surrounding this team.

They are vexing even for a pre-tournament favourite like India. Can this Indian bowling unit tide over the absence of injured pace talisman Jasprit Bumrah? Can Virat Kohli and Rohit Sharma summon their glory days back? Can young names like Shubman Gill ace the pressure of a multi-nation competition to deliver consistently?

In that context, the ICC showpiece is a godsend because ODI is the comfort zone of those icons and young tyros in this Indian line-up, and they will be genuinely eyeing a strong outing here.

It's imperative that they do so -- from a team and individual perspective.

It would not be an exaggeration to say that Kohli, Rohit and even head coach Gautam Gambhir, although only six months into his tenure, are living on borrowed time because the shockwaves created by the setbacks against New Zealand and Australia have not subsided yet.

Some bright signs are there though. Skipper Rohit made a century a few days back against England and Kohli a fifty, while Gambhir masterminded the dominant 4-1 and 3-0 victories in T20Is and ODIs respectively. Gill was exceptional while emerging as the player of the series, cracking two fifties and a hundred in three ODIs against England.

But the challenge India face in the Champions Trophy is vastly different from a rather cosy home series

But herein too, India will have to ponder over who is the third spinner behind primary choices Ravindra Jadeja and Axar.

They have a tough selection to make between left-arm wrist spinner Kuldeep Yadav and Varun Chakravarthy.

If the recent form is the yardstick then 'mystery spinner' Chakravarthy should get the nod, but Kuldeep showed his readiness while outwitting some reputed batters in the nets here on Tuesday.

But India can take consolation from the fact that Bangladesh are going through turmoil of their own, weakened by the absence of stars like Shakib Al Hasan.

However, India will not like to leave anything to chance as Bangladesh has proved to be the proverbial banana peel for them in the past in global events.

## **Shubman Gill dethrones** Babar Azam to become No 1 batter in ICC ODI rankings

DUBAI, Feb 19: India vice-captain Shubman Gill on Wednesday dethroned Babar Azam of Pakistan from the No. 1 spot in the ICC ODI Rankings for batters on the back of his strong show against England in the recent home series. The ICC issued the latest rankings just ahead of the start of the eight-team Champions Trophy in Karachi with the match between Pakistan and New Zealand. "India right-hander Shubman Gill overtakes former Pakistan captain Babar Azam to become the top ranked ODI batter in the world," the ICC



Gill, who scored two fifties and a century in the recent three-match ODI series against England at home which India won 3-0, jumped one place to the No. 1 spot. He now has 796 rating points compared to

India skipper Rohit Sharma is placed at the third spot with 761 points followed by South Africa's Henrich Klaasen and New Zealand's Daryl Mitchell at fourth and fifth respectively. "It's a major shake-up at the top of the rankings just prior to the start of the Champions Trophy and leaves an interesting sub-plot to what will transpire over the coming weeks during the eight-team tournament in Pakistan and Dubai," the ICC said.

"This is the second time Gill has held the No.1 ranking in ODI cricket, with the India batter having also gone past Babar to claim top spot midway through the ICC Men's Cricket World Cup in

"Gill has been in excellent form of late, with his century against England in Ahmedabad during the third ODI of the recently concluded series enough to catapult the 25-year-old to the top of the rankings," the global governing body added. Sri Lanka's Maheesh Theekshana, meanwhile, has taken the first position in the ODI rankings for bowlers as he replaced Afghanistan captain Rashid

"While Sri Lanka won't be featuring at the Champions Trophy, Theekshana earned the top spot following his exploits against the Aussies that included an excellent four-wicket haul in the opening match of that series in Colombo," the ICC said. Sri Lanka had recently handed a 2-0 whitewash to Australia with Theekshana taking four wickets. The Sri Lankan spinner has 680 rating points, followed by Rashid at second, Namibia's Bernard Scholtz at third, India's Kuldeep Yadav at fourth and Pakistan's Shaheen Shah Afridi at fifth.

"Meanwhile, Afghan spin wizard Rashid drops to second and will be keen to regain the No.1 spot as he trails his Sri Lankan counterpart by just 11 rating points," the ICC said.

"While a trio of spinners in India's squad Kuldeep Yadav (up one place to fourth), South Africa's Keshav Maharaj (re-enters the rankings in sixth) and New Zealand's Mitchell Santner (up four rungs to seventh) are all inside the top 10 after making ground this week.'

Afghanistan veteran Mohammad Nabi remains the top ranked all-rounder in ODIs, followed by Sikandar Raza, Azmatullah Omarzai, Mehidy Hasan Miraz and Rashid. (PTI)
