Need new legal framework to regulate 'harmful' content: I&B Ministry

NEW DELHI, Feb 22: The Information and Broadcasting Ministry is examining the existing statutory provisions and the need for a new legal framework to regulate "harmful" content amid complaints of "obscenity and violence" being shown on digital platforms.

In its reply to a parliamentary panel, the ministry said there is a growing concern in the society that the constitutional right of "freedom of expression is being misused to showcase obscene and violent content on digital platforms"

It told the Standing Committee on Communications and Information Technology headed by BJP MP Nishikant Dubey that while certain provisions exist under the current laws, there is a growing demand for a stricter and effective legal framework to regulate

such harmful content.

It said, "This ministry has taken note of these developments and is in process of examining current statutory provisions and need for a new legal framework." The ministry said that many high courts and the Supreme Court, MPs and statutory bodies like the National Commission of Women have spoken on the issue, which has made headlines after the crass comments of social media influencer Ranveer Allahbadia drew wide condemnation.

Criminal cases have been registered against him, and his apology has done little to damp down the controversy. While the Supreme Court granted him protection from arrest, it also made very critical observations over his vulgar comments. (PTI)

Himanta claims pvt varsity promised students high score through 'fraud' USTM chancellor arrested, taken to Sribhumi

GUWAHATI, Feb 22: The chancellor of the University of Science and Technology, Meghalaya, (USTM) Mahbabul Hague was arrested from his Guwahati residence in the early hours of Saturday, police said.

He was allegedly involved in a network that lured students with assurance of high marks through "fraud means", Chief Minister Himanta Biswa Sarma claimed

Haque was arrested by a team of the Sribhumi district police. He was taken to Sribhumi immediately, a police officer said.

Commenting on Haque's arrest, Sarma said, "For some time now, I have been observing a large network which promises students that they will ensure high marks for them, and ahead of medical and engineering entrance and CBSE-conducted exams, the examination centre of these students are changed to

some specific schools."

"Over 200 students under the CBSE curriculum from Goalpara, Nagaon and Kamrup districts were taken to a centre in Pathakarndi in Sribhumi, hundreds of kilometres from their home, this time also. When the students did not get any opportunity to score easy marks, they created a ruckus and the issue came to the fore," the CM claimed.

Students appearing for board exams at a school in Patharkandi had raised allegations on Friday that their school authorities had assured them of external help in answering the question paper, but no such help was provided.

Sarma claimed that such fraud measures were not limited to CBSE-conducted exams alone, but happening in the medical entrance exam as well. "This person is a big fraud, his entire background

is fraud. He had been trying to mislead the people by bringing a few intellectuals under his influence," Sarma alleged, referring to Haque.

"We will ensure that education is not transformed into business in Assam. We will take steps to prevent it," he added. Haque was embroiled in a controversy last year over his OBC certificate, which he had obtained 'fraudulently" in Sribhumi district in the 1990s.

Sarma had said in August that a police case would be registered against the USTM chancellor for allegedly fraudulently obtaining the OBC certificate, which was cancelled subsequently.

The CM had also held USTM and Haque responsible for "flood jihad" against Guwahati, claiming that the water flowing down from the varsity campus. which is located on a hill adjacent to the city, leads to massive flooding. (PTI)

This narrative of 'minority-maiority' and politics of appeasement was created by the Congress. The BJP has always kept itself away from such politics," Saikia, who took over as the state party head

last month, said during an interaction with reporters here. Asked if the party will woo the religious minority voters in the

state, the two-time MP said, "We cannot isolate 33 per cent voters from ourselves. We have to assim-

ilate them in the development narrative. For Assam to be among the top five states, all parts and people have to be equal partners in it.' Saikia said the first target for the party for the 2026 Assembly polls

is achieving a simple majority on its own by crossing the halfway mark of 63 seats in the House of 126 members. "Together with our allies, our target is to win in 100 seats. As of today, we are in a winning position in 85, we need to add

15 more," he added. Saikia said work on formulating strategy for the state polls has al-

ready started, and preliminary talks with AGP, UPPL, and other smaller parties that are part of the alliance are on. "We are sure of a thumping victory in 2026 polls and we are (CONTD. ON PAGE-2)

Poor-quality water can affect crop yields and long-term soil fertility PM should pay heed to his NIT Rourkela develops model to assess friend Trump's remarks on groundwater quality for irrigation paper-ballot voting: Cong

NEW DELHI, Feb 22: Researchers at National Institute of Technology (NIT), Rourkela have developed a model based on Machine Learning to evaluate groundwater quality for irrigation purposes.

The findings of the research, conducted in Odisha's Sundargarh district, have been published in the prestigious Water Quality Research Journal.

According to officials, the developed model can be significantly used across the country to assess groundwater stress for irrigation purposes.

Agriculture being central to the local economy and surface water sources covering only 1.21 pc of the district, groundwater is essential to meet the irrigation needs of this area. Paddy, which occupies

76 pc of the net cultivable area, requires a large amount of water, making groundwater (GW) quality an essential factor for farmers, they said.

Groundwater extraction in Sundargarh district has been increasing due to growing agricultural demand, limited surface water availability, and population growth. This has resulted in reductions in both the quantity and quality of groundwater. Poor-quality water can affect crop yields and longterm soil fertility.

According to Anurag Sharma, Assistant Professor, Civil Engi-Department, NIT neering Rourkela, advanced data analysis techniques were used to examine key water quality parameters and their variations across different parts of the district.



The study examined groundwater samples collected from 360 wells across Sundargarh. These samples were tested for various chemical properties, including salts trends and understand how condi-

tions have changed from 2014 to 2021.

"The findings indicate that groundwater in the southern, south-western and eastern parts of Sundargarh district, including areas around Rangaimunda, Lephripara and Putudihi is considered to be fit for irrigation. These regions showed stable groundwater quality with acceptable levels of dissolved salts and minerals along with the permissible range of Sodium Adsorption Ratio (SAR), Kelly's Ratio (KR), Percentage Sodium (Na), Permeability Index (PI) and Exchangeable Sodium Percentage (ESP)," Sharma.

"However, the western and central parts of the district, particularly Krinjikela, Talsara and Kutra, and parts of Sundargarh town, have groundwater (CONTD. ON PAGE-2)

Delhi High Court reinstates fraud claims against Reliance

The resounding victory of the Central Government's legal team, led by the Attorney General of India A.R. Venkatramani reinforced by the active participation of the eminent jurist and the former Attorney General of India KK Venugopal, under the astute administrative guidance of Union Petroleum & Natural Gas Minister Hardeep Singh Puri, in the Delhi High Court verdict against Mukesh Ambani's Reliance Industries Ltd. (RIL), has decisively dismantled allegations of favouritism levelled against the Modi government.

This landmark ruling categorically refutes opposition claims that the government promotes select business houses, reaffirming its commitment to transparency, fairness, and the rule of law in corporate governance and policymaking. In a landmark judgment dated February 14, 2025, the Delhi High Court delivered a decisive verdict in the case of Union of India vs Reliance Industries Ltd. (RIL), addressing long-standing allegations of crony capitalism and favouritism towards major industrialists by the current government. This 79-page judgment not only exonerates the government from accusations of bias but also underscores the integrity of India's judicial system and the competence of its political and legal leadership. Background of the Case The dispute centres around the Production Sharing Contract (PSC) executed between the Union of India and Reliance Industries Ltd. in 2000, about the exploration and extraction of natural gas in the Krishna-Godavari basin.

The Ministry of Petroleum and Natural Gas alleged that RIL had engaged in "unjust enrichment" by extracting and selling gas that had purportedly migrated from fields operated by the state-owned Oil and Natural Gas Corporation (ONGC) to RIL's adjacent block. The government sought compensation, contending that RIL's actions resulted in significant financial losses to the state exchequer. Details of Judgement The Delhi High Court's single judge judgment in Union of India vs. Reliance Industries Ltd. examined the allegations of unjust enrichment, contractual breaches, and fraud against RIL, ultimately dismissing them due to a lack of concrete evidence.

The court upheld the findings of the international arbitration tribunal, reaffirming that RIL operated within the bounds of the Production Sharing Contract (PSC) and could not be held liable for natural gas migration beyond its control. However, the Division Bench of the Delhi High Court has quashed an arbitral award that had dismissed the Central government's claims against Reliance Industries Limited (RIL) and its foreign partners. The government had accused the conglomerate of "insidious fraud" and "unjust enrichment" amounting to over \$1.729 billion by allegedly extracting natural gas from deposits beyond its entitlement.

The Bench, comprising Justices Rekha Palli and Saurabh Banerjee, overturned the ruling of a single judge, who had, in May 2022, set aside the Petroleum Ministry's allegations. The court determined that the international arbitration award dated July 24, 2018, which had favoured the RIL-led consortium, was "contrary to public policy" in India. This decision marks a significant legal setback for RIL, as it reinstates the government's claims concerning unauthorised gas extraction.

The ruling also strengthens the government's position in regulatory disputes within the oil and gas sector. With the arbitral award nullified, the matter may now proceed further in Indian courts, potentially leading to fresh legal battles over financial liabilities and resource allocation in the country's hydrocarbon sector. Beyond the legal nuances, the judgment serves as a crucial precedent for future contracts, emphasising the importance of precision in drafting and adherence to arbitration mechanisms for dispute resolution. It underscores the independence of the judiciary in adjudicating disputes involving powerful corporate entities and government bodies, dispelling claims of crony capitalism.

The case also highlights the competence of the central government's legal representation, particularly the diligence of Attorney General AR Venkatramani and Union Petroleum & Natural Gas Minister Hardeep Singh Puri in defending the government's stance. It further reflects the abysmally woeful performance of the RIL legal team in defending the case. Furthermore, the ruling reassures investors about India's commitment to the rule of law, ensuring that legal processes remain transparent and evidencedriven. By challenging the political narrative of undue favouritism towards industrialists, the judgment reinforces the integrity of India's governance, corporate regulations, and media responsibility in shaping public discourse.

The Delhi High Court's latest judgment in Union of India vs Reliance Industries Ltd is a testament to the robustness of India's legal system and its capacity to adjudicate high-stakes disputes impartially. It dispels allegations of governmental bias towards prominent industrialists, affirming that decisions are grounded in evidence and legal merit. The ruling also underscores the importance of adhering to contractual obligations and the role of arbitration in resolving intricate commercial conflicts. As India continues to navigate its path towards economic growth, this judgment reinforces the principles of fairness, transparency, and the rule of law as cornerstones of its democratic ethos. BJP leadership is set to use Maha Kumbh festival for electoral gains in 2027 polls



A bench of NGT chairperson Justice Prakash Shrivastava, judicial member Sudhir Agarwal, and expert member A Senthi Vel were hearing the matter on the compliance of a December order, wherein it had directed the UP government and the Central Pollution Control Board (CPCB) to ensure that water quality in rivers Ganga and Yamuna was fit to drink and bathe in during the Kumbh. It pulled up the UP Pollution Control Board of not filing an action taken report in compliance with its December 23 order.

The CPCB report on water quality in the Ganga at Kumbh had said, "River water quality was not conforming with the primary water quality for bathing with respect to faecal coliform at all the monitored locations on various occasions. A huge number of people (are) taking a bath at Prayagraj during Maha Kumbh Mela in the river, including auspicious bathing days, which eventually leads to an increase in faecal concen-

This CPCB report exposed the utter contempt of the RSS and BJP leadership towards the religious beliefs and commitment of Hindus and simply treats them as a tool to win the elections and come to the power. The UPPCB even tried to get exonerated of the crime by saying that it had filed a compliance report. Nevertheless it ought to be mentioned that a day after being reprimanded by the National Green Tribunal (NGT) for delay in submitting action taken report on maintaining water quality in Prayagraj for the Mahakumbh, the UP Pollution Control Board (UPPCB) tendered unconditional apology on Tuesday along with the report.

Yogi countering the NGT version told the state assembly only yesterday that the UPPCB has been continuously monitoring the water quality at the Sangam and it is fit for both bathing and ritual drinking (aach-man). He held; "This time, 81 drains have been tapped, treating 261 MLD (million litres per day) of sewage. In January and February, faecal coliform levels at the Sangam nose were found to be within the acceptable range, below 2,500 MPN per 100 ml, according to the UP Pollution (Control) Board". He said the Maha Kumbh 2025 is being organised in a "grand" manner, while the 2013 edition suffered due to the "corruption, mismanagement", administrative negligence and chaos of the SP rule. For the 2025 event, 14 flyovers, nine permanent ghats, and seven riverfronts have been prepared. The length of temporary ghats has increased from just 4 km in 2013 to 12 km in 2025, he added.

The Kumbh Mela was being used by RSS and BJP as an opportunity for outreach, especially to build ties with sections of society which did not vote for the BJP. Undeniably this has been a very disturbing convergence of state and religion. The worst has been their blatant attempt to hide the actual number of devout Hindus who died in the stampede. It appears speaking lies and falsehood are the basic traits of the saffron ecosystem. Not only Modi or Mohan Bhagwat were accused of speaking lies. The stampede has also made bare the fact that Yogi is not far behind these leaders in speaking lies. "Meanwhile, while the very rich be-come much richer, 60% of Americans live paycheck to paycheck, 85 million are uninsured or under-insured, 25% of seniors are trying to survive on \$15,000 or less, 800,000 are homeless and we have the highest rate of childhood poverty of almost any major country on earth."

And the essence: "As modern-day kings, who believe they have the absolute right to rule, they will sacrifice, without hesitation, the well-being of working people to protect their privilege. ...Bottom line: The oligarchs, with their enormous resources, are waging a war on the working class of this country, and it is a war they are intent on winning."

That Sanders with his remarks bore down on protecting working people was consistent with his advocacy for democratic socialism. He also vigorously defended the U.S. Constitution.

"President Trump," he pointed out, "attempted to suspend all federal grants and loans - an outrageous and clearly unconstitutional act. As I hope every 6th grader in America knows, under the Constitution and our form of government the president can recommend legislation, he can support legislation, he can veto legislation, but he does not have the power to unilaterally terminate funding passed by Congress."

Elon Musk, according to Sanders, is "attempting to dismantle major agencies of the federal government which are designed to protect the needs of working families and the disadvantaged. These agencies were created by the U.S. Congress and it is Congress' responsibility to maintain them, reform them or end them. It is not Mr. Musk's responsibility.

What Mr. Musk is doing is patently illegal and unconstitutional – and must be stopped.'

Additionally, Musk "proposed that 'the worst 1% of appointed judges be fired every year,' and demanded the impeachment of judges that have blocked him from accessing sensitive Treasury Department files ... Mr. Musk, you don't impeach judges who rule against you. You may or may not know this, but under the U.S. Constitution, we have a separation of powers, brilliantly crafted by the founding fathers of this country in the 1770s."

Sanders laments that the oligarchy in charge disregards formative principles and constitutionally imposed checks and balances. The Declaration of Independence and the Constitution, products of the American Revolution, provided the principles and restraints. In this sense the Trump government is pursuing counterrevolution.

Not all socialists realize that the new autocrats are fighting a battle that began long ago and whose outcome is still contested. A victorious political revolution, we suggest, is no short-term happening, but actually represents a process, usually a prolonged one.

The values and ideals reflected in the Declaration of Independence had taken shape over the course of decades, even centuries, while the Constitution, as approved, was far from complete. The concept of a long, multi-faceted process of change is essential.

As feudalism waned, new horizons geographical, intellectual, and aspirational were in sight. Onerous demands of a land-based aristocracy, subservience to the Church in Rome, and obstacles to social and economic advancement weighed heavily. Kingly rule and feudal remnants were out of sync.

The rising bourgeoisie were restless. New knowledge, the dynamism of growing cities, entrepreneurial possibilities, new religious currents, and free expression of ideas had their appeal. The new class latched on to burgeoning technologies, possibilities for political participation, and new legal resources and financing modalities. Societal institutions were in flux.

The so-called American Revolution ran its course and brought change. A people's army won the war; the king and his ministers were out. The people's representatives governed. The Constitution outlined how government would work, who would

participate, what they would do, how they would be selected, and how to avoid autocratic rule.

Revolutionary change continued. Capitalism emerged. Factories spread, production and commerce expanded, and wealth accumulated. The unleashing of productive forces fostered exploitation of factory workers, plundering of overseas resources, and enslavement of workers in the cotton economy. Revolutionary socialism arrived, assertive in thought and action.

With his speech, Bernie Sanders was addressing still unsettled issues tending to disturb this long process of change and revolution. He discussed social and economic rights not yet guaranteed to working people, and due now. Equally, he expressed support for political freedoms and constitutional provisions, each the product of that early phase of revolution. U.S. socialists following Sanders' lead

would regard constitutional violations and war on the working class with equal seriousness. Helping them along would be greater appreciation of unfulfilled revolutionary purposes, also of the long duration of struggle. Unbalanced focus on class war may be distracting or interfere with perspective.

U.S. socialists owe much to their revolutionary ancestors, whose concepts of political rights and equality still inspire. Socialists defending working-class victims rely on notions of equality and guarantees of rights conveyed by the founding documents. They themselves, when facing political repression, look to constitutional protections

Sanders finished with an observation on tactics: "[T]his is what I do know: The worst fear that the ruling class in this country has is that Americans ... come together to demand a government that represents all of us, not just the wealthy few. Their oligarch's nightmare is that we will not allow ourselves to be divided up by race, religion, sexual orientation or country of origin and will, together, have the courage to take them on."

His plea for unity is a reminder that the idea of socialists attending to both constitutional crisis and working-class needs is incomplete. A future agenda item might center on what to do about wishful thinking. The remedy may lie in rigorous attention to the reality, as per the historical record, that goals and purposes may be undermined by opportunism and inappropriate compromise. (IPA Service)

Points to ponder over L'affaire Lok Sabha member Shashi Tharoor

The convulsions in the Congress over party MP Shashi Tharoor's fulsome praise of the Left Democratic Front (LDF) Government for the staggering growth in the start-up sector and its remarkable feat of emerging as the top state in the country in ease of business has exposed the double standards practised by the grand old party.

It all began with the Thiruvananthapuram MP lavishing praise on the Pinarayi Government for its success in establishing 2, 90,000 MSMEs since 2022. Tharoor's laudatory references came in an article he wrote for the New Indian Express. "God's Own Country was no more the Devil's Own Playground for business", Tharoor gushed borrowing Kerala's tagline for tourism promotion.

Not surprisingly, Tharoor's article drew trenchant criticism from many Congress leaders including Leader of the Opposition (LoP) V. D. Satheesan and former LoP Ramesh Chennithala. The burden of their song was that by praising the Pinarayi Government, Tharoor has given the political rival a huge propaganda advantage, with the local bodies elections in the State months away.

Tharoor, however, justified his stand by arguing that his article was based on the facts, figures and dates as well as the Global Start-up Ecosystem Report and Kerala's performance. The ranking is not released by the CPI(M), he pointed out. "We cannot bring politics in to everything, especially where public interest is concerned."

As for the LDF, both Chief Minister Pinarayi Vijayan and State Industries Minister P. Rajiv have welcomed Tharoor's article, and praised him for appreciating the achievements of the State Government. The Congress leaders should not convert their hate for the LDF into hate for the State, Pinarayi averred.

Of course, the criticism against Tharoor has been tamped down by the intervention of the party high Command. Rahul Gandhi told Tharoor to refrain from making statements which the LDF would use to its advantage. He also asked the Congress leaders in Kerala to



stop the open war of words.

The episode has, however, exposed the double standards practised by the Congress leaders in the State. In his complaint to the High Command Tharoor has claimed that he is being unfairly singled out for criticism.

He has a point. For instance, nobody came out with critical comments when LoP V D Satheesan praised State Education Minister V. Sivankutty for his efficient conduct of Kerala Youth Festival and a sports meet. The party leaders who are critical of Tharoor maintained a deafening silence on that occasion. Nor were there any demands for taking action again Satheesan. If this is not double standards, what is? That is the million dollar question.

Again, when Satheesan and Kerala Pradesh Congress Committee president K. Sudhakaran indulged in an open, noholds-barred verbal warfare against each other, there was no clamour for action against them. Rahul Gandhi himself had come out with appreciating comments on the LDF Government's performance in the past. Former chief minister A. K. Antony has also praised Industries Minister Elamaram Kareem in the erstwhile LDF Government for his cooperation and help in establishing defence projects in the State. This hap-

pened when Antony was the Union Defence Minister Last but not the least, no chorus of criticism erupted when former President of India Pranab Mukherjee addressed an RSS-organised function on the invitation of RSS chief Mohan Bhagwat.

If anything, Tharoor should be complimented for his praise of a Government led by the Congress's political rival. Criticism for the mere sake of criticism is not good. Leaders cutting across the political divide should not hesitate to appreciate the good work done by governments irrespective of their political affiliation. That is the way politics should be conducted in a democratic country. Healthy politics presupposes civility and decency towards political opponents. The politics of hate is a luxury the country cannot afford.

In an interesting development, the Democratic Youth Federation of India (DYFI), the CPI(M)'s youth wing, has invited Tharoor to speak at the start-up festival it is organising in March. A DYFI delegation led by its president A. A. Rahim called on Tharoor in New Delhi the other day to hand over the invitation. Although Tharoor appreciated the DYFI offer, he expressed his inability to attend the event because of prior commitments. (IPA Service)

WASHINGTON. Feb 22: President Donald Trump abruptly fired Air Force Gen CQ Brown Jr as chairman of the Joint Chiefs of Staff on Friday, sidelining a his-tory-making fighter pilot and respected officer as part of a campaign led by his defence secretary to rid the military of leaders who support diversity and equity in the ranks.

The ouster of Brown, only the second Black general to serve as chairman, is sure to send shock waves through the Pentagon. His 16 months in the job had been consumed with the war in Ukraine and the expanded conflict in the Middle East.

"I want to thank General Charles CQ' Brown for his over 40 years of service to our country, including as our current Chairman of the Joint Chiefs of Staff. He is a fine gentleman and an outstanding leader, and I wish a great future for him and his family," Trump posted on social media.

Brown's public support of Black Lives Matter after the police killing of George Floyd had made him fodder for the administration's wars against "wokeism" in the military. His ouster is the latest upheaval at the Pentagon, which plans to cut 5,400 civilian probationary workers starting next week and identify USD 50 billion in programs that could be cut next year to redirect those savings to fund Trump's priorities.

Trump has asserted his executive authority in a much stronger way in his second term, removing most officials from the Biden administration even though many of those positions are meant to carry over from one administration to the next.

US envoy praises Zelenskyy after

Ukraine and Russia said on Friday that he had held "extensive and positive discussions" with Ukraine's President Volodymyr Zelenskyy about the three-year war with Russia and praised the Ukrainian leader as an "embattled and courageous leader of a nation at war".

Retired US Lt. Gen. Keith Kellogg - who travelled to Kyiv on Wednesday and whose planned news conference with Zelenskyy on Thursday was changed at the last minute to a simple photo opportunity - struck a positive tone after what he said on the social platform X was "a long and intense day" of talks with Ukraine's senior leadership.

His comments marked a departure from recent rebukes of Zelenskyy by Trump and other senior US officials that appeared to indicate an abrupt deterioration of relations. Trump called Zelenskyy "a dictator without elections" and warned him that he'd "better move fast" to negotiate an end to the war or risk not having a nation to lead.

EU Defence Commissioner Andrius Kubilius said senior members of the bloc's executive branch are weighing how, "in a very urgent way, to send a very strong message to Ukrainians and to the world that we are standing together with Ukraine."

Feb 22: Hamas freed the first two of six Israeli hostages due to be released on Saturday even as heightened tension between the adversaries clouded the future of the fragile ceasefire deal.

The two hostages - Tal Shoham, 40, and Avera Mengistu, 38 — were put into Red Cross vehicles after being brought out onto a stage by masked and armed Hamas fighters in front of a crowd in the southern Gaza city of Rafah. Soon after, the Israeli military confirmed that the two had been brought into Israel.

A few hours later, Red Cross vehicles arrived in the central town of Nuseirat for the next handover.

The latest hostage release, to be followed by the freeing of hundreds of Palestinians imprisoned by Israel, is going ahead after tensions mounted over a grisly and heart-wrenching dispute triggered this week when Hamas initially handed over the wrong body for Shiri Bibas, an Israeli mother of two young boys abducted by militants.

The remains that Hamas transferred with her sons' bodies on Thursday were later determined to be those of an unidentified Palestinian woman. In response, Israeli Prime Minister Benjamin Netanyahu vowed revenge for "a cruel and malicious violation", while Hamas suggested it had been a mistake.

Hamas has said it won't release the remaining captives without a lasting ceasefire and a full Israeli withdrawal. Netanyahu, with the full backing of the Trump administration, says he's committed to destroying Hamas' military and overning capacities and returning all the hostages, goals widely seen as mutually exclusive.

Trump's Gaza plan adds to uncertainty

Trump's proposal to remove about 2 million Palestinians from Gaza so the US can own and rebuild it has thrown the ceasefire into further doubt. His idea has been welcomed by Netanyahu but universally rejected by Palestinians and Arab countries.

Trump said Friday that he was 'a little surprised" by rejections of the proposal by Egypt and Jordan and that he would not impose it.

"I'll tell you, the way to do it is my plan. I think that's the plan that really works. But I'm not forcing it. I'm just going to sit back and recommend it," Trump said in a Fox News interview.

Israel's military offensive killed more than 48,000 Palestinians, mostly women and children, according to Gaza's Health Ministry, which doesn't distinguish between civilians and combatants. Israel says it has killed more than 17,000 fighters, without providing evidence.

The offensive destroyed vast areas of Gaza, reducing entire neighborhoods to rubble. At its height, the war displaced 90 per cent of Gaza's population. Many have returned to their homes to find nothing left and no way of rebuilding. (AP)

New FBI director Kash Patel plans to relocate 1,500 employees

WASHINGTON, Feb 22: New FBI Director Kash Patel has told senior officials that he plans to relocate 1,000 employees at FBI headquarters to field offices around the country and move an additional 500 to a bureau facility in Huntsville, Alabama, according to a person with knowledge of the discussions.

The plans were communicated Friday, the same day Patel was sworn in at the White House. They reflect his long-stated determination to reduce the FBI's footprint in Washington and have more of a presence in offices in other cities

The person who discussed Patel's vision did so on condition of anonymity to describe plans that have not been made public.

At his swearing-in ceremony, Patel called the opportunity to lead the nation's premier federal law enforcement agency the "greatest honour" of his life.

Patel was confirmed by the Senate on Thursday by a 51-49 margin, with two Republican lawmakers. Susan Collins of Maine and Lisa Murkowski of Alaska, breaking party ranks and voting against him "I think he'll go down as the best ever at that position," President Donald Trump told reporters Friday ahead of the White House swearing-in, which was conducted by Attorney General Pam Bondi and attended by Republican supporters in Congress, including Sen. Ted Cruz of Texas and Rep. Jim Jordan of Ohio.

IMF mission after visiting Pakistan appreciates govt's commitment to assessment

ISLAMABAD, Feb 22: An International Monetary Fund (IMF) mission after visiting Pakistan to evaluate the country's governance appreciated the government's commitment to such assessments.

A technical mission of the IMF was in Pakistan earlier this month to scrutinise the judicial and regulatory system as part of the ongoing USD 7 billion Extended Fund Facility (EFF) to address governance and corruption vulnerabilities, Dawn News reported.

During the visit, a delegation led by Joel Turkewitz met with the Chief Justice of Pakistan, Yahya Afridi, to discuss judicial performance, governance, and reforms.

In a recent statement on its website, the IMF recalled that its scoping mission visited Islamabad from February 6 to 14 "to lay the groundwork for a Governance and Corruption Diagnostic Assessment (GCD) at the government's request."

"The IMF appreciates the Pakistan government's commitment to this exercise and looks forward to continuing our collaboration," it said. The IMF further announced that its scoping team for the GCD

assessment will "return to Pakistan later this year to continue gathering information and exploring opportunities to strengthen governance, integrity, and economic outcomes in preparation for the eventual assessment.

The IMF noted the mission's focus was to assess governance and corruption vulnerabilities across six core state functions.

"These include fiscal governance, central bank governance and operations, financial sector oversight, market regulation, rule of law, and anti-money laundering and countering the financing of terrorism (AML-CFT).'

During its visit, the team engaged with the Finance Division, the Federal Board of Revenue, the State Bank of Pakistan, the Auditor General of Pakistan, the Securities and Exchange Commission of Pakistan, the Ministry of Law and Justice, and the Supreme Court, the IMF said

"In addition, the IMF team met with a range of other stakeholders, including business associations, civil society organisations, and international development partners." (AP)

Trump administration reverses its previous decision and reinstates legal aid for migrant children

MIAMI, Feb 22: Days after telling legal groups who help migrant children who arrive in America alone - some so young they are in diapers or their feet dangle from their chairs in court — that they must stop their work, the federal govern-

ment Friday reversed itself. The Trump administration told the groups that they can resume providing legal services to tens of thousands of unaccompanied children. The Acacia Centre for Justice said that they received notice from the government of the reversal.

The notice came after the government on Tuesday suspended the program that provides legal representation to children who have arrived in the United States across the border with Mexico without parents or legal guardians. Several or-

ganisations that offer assistance to migrant children had criticised the measure and said at the time that the minors were at risk. The USD 200 million contract allows Acacia and its subcontrac-



tors to provide legal representation to about 26.000 children and legal education to another 1,00,000 more

The Friday notice from the United States Department of Interior obtained by The Associated Press does not explain the Trump administration decision to reinstate the program. It states that it "cancels" the order to halt legal services

to migrant children. "Acacia Centre for Justice may resume all activities," the short notice says.

Shaina Aber, executive director of Acacia said that they will continue to work with the government "to ensure that these critical services upholding the basic due process rights of vulnerable children are fully restored" and their partners can resume their work. tection.

She warned, however, that this is a "critical moment to ensure that no child is forced to navigate" the immigration system alone.

Acacia said that in less than 48 hours, members of the public sent more than 15,000 letters to the Congress demanding the resumption of the programme.

The programme is funded by a five-year contract, but the government can decide at the end of each year if it renews it or not. The deadline for this year's decision is in March.

Michael Lukens, the executive director of Amica Centre for Immigrant Rights, one of the subcontractors, said that despite the reversal he is still concerned.

"I'm very concerned because the attack on children is unprecedented and to even begin that is troubling," Lukens said. He said if the stopwork order had remained in place, it would have left kids across the country without due process or pro-

The Trafficking Victims Protection Act of 2008 created special protections for children who arrive alone in the US. The law said the government should facilitate legal representation for the children put into deportation proceedings, though it did not mandate every child have a lawyer.

Unaccompanied children under the age of 18 can request asylum, juvenile immigration status, or visas for victims of sexual exploitation.

Some of the organisations that provide legal representation said the decision to restore funds ensures the continuation of vital protections for vulnerable children.

"We urge the administration to stay this course by exercising the remaining year services under this existing contract," said Wendy Young, president of the Kids in Need of Defense, one of the organizations that assists migrant children. (AP)

Cong leader Udit Raj receives death threats, files complaint

NEW DELHI, Feb 22: Congress leader Udit Raj on Saturday filed a complaint alleging that the BSP workers have been threatening to kill him on the directions of their party supremo Mayawati.

Raj posted a picture of the complaint on X and said that he has been receiving death threats since February 18, after his remarks against Bahujan Samaj Party leader Mayawati.

On February 17, Raj launched a scathing attack on BSP chief Mayawati and said that she had "strangled the social movement" and now the time has come to strangle her.

He later clarified that he meant that people should recognise her patterns and leave her.

In the complaint, he claimed that the callers have been threatening to kill him if speaks against Bahujan Samaj Party leader Mayawati.

The conversations have been recorded and were submitted as evidence, he said.

"These callers not only extended direct threats but also posted/circulated and broadcasted the same on social media, after having recorded their act of extending threats and abusing me in filthy language, manifestly in order to provoke other persons also to execute such threats." the complaint read.

Raj alleged that there is a news clip in circulation on the YouTube Channel 'Bahujan Dastak', wherein the interviewer has been exhorting the public at large to slit his throat and announced a reward of ₹ 1 Lakh for such an act.

"I have been noticing unusual movements of various strangers near my house thus posing imminent an acute threat to my life and I apprehend that any untoward incident may take place if adequate security is not provided immediately," he said, requesting the Delhi Police Commissioner Saniav Arora to take immediate strict legal action and direct the concerned SHO to lodge an FIR immediately. (PTI)

MUMBAI, Feb 22: Congress leader Sachin Pilot on Saturday said the party cannot wait for the people to get tired of the BJP but must reach out to the people, and it has been working on it.

NEW DELHI, Feb 22: The Supreme Court is scheduled to hear on Monday a plea of Aam Aadmi Party (AAP) leader Durgesh Pathak for the dismissal of a petition challenging his election from Delhi's Rajinder Nagar Assembly seat in a 2022 bypoll.

A bench headed by Justice Surva Kant is scheduled to hear the plea, in which it has sought the response of one Rajan Tiwari, who has chalbypoll. The high court dismissed Pathak's application seeking rejection of the election petition filed against him, saying there was no justification to do so at that stage.

Tiwari, who has claimed to be a voter of Rajinder Nagar, challenged Pathak's election on the grounds of non-disclosure of criminal antecedents, holding an office of profit on the date of the scrutiny of his nomination, suppression of income-tax returns for financial year 2019-20 and disclosure of an incorrect valuation of shares in a company in the nomination form. He has alleged that apart from indulging in corrupt practices as envisaged under section 123 of the Representation of the People (RP) Act. Pathak had willfully and intentionally concealed facts, which would amount to undue influence under the Act. Tiwari has sought that the election be declared null and void on account of the AAP leader allegedly indulging in "corrupt practices" He has argued that the MLA omitted to disclose in his nomination papers the existence of an FIR against him for the alleged commission of offences under the Indian Penal Code and Information Technology Act, which is in violation of the RP Act. (PTI)

CAG cites loopholes in management of compensatory afforestation planning body's funds



DEHRADUN, Feb 22: The Comptroller and Auditor General of India (CAG) has cited many loopholes in the management of compensatory afforestation funds in the forest divisions of Uttarakhand, including their diversion to inadmissible activities and delaved submission of annual plan of operations to the Centre leading to cost escalations in various cases.

The CAG's latest audit report on Compensatory Afforestation Fund Management and Planning Authority (CAMPA) laid recently in Uttarakhand Assembly during its ongoing budget session said ₹ 13.86 crore was diverted at the divisional level to inadmissible activities like state scheme Harela. tiger safari work, renovation of existing buildings, expenses on personage visits, court cases, purchases of I-phones, laptops, fridges, coolers and stationery.

The state authority did not control the diversion or inadmissible expenditure from the State Compensatory Afforestation Fund, it said. The audit report on the functioning of CAMPA covers a period of 2019-2022

According to CAMPA rules, commensurate compensatory afforestation is mandatory in case of allocation of forest land for nonforest activities like infrastructural or industrial development.

It points out that in 52 cases 188.62 hectares of forest land was diverted to user agencies for nonforest purposes where in-principle approvals were granted but permission to start work was not granted by the competent author-

However, the user agencies started the road construction in the

forest areas without permission, it said, adding that the forest divisions did not take any cognisance of the unauthorised use of forest land and booked these as cases of forest offence.

According to CAMPA guidelines of 2009, after receipt of money, the state CAMPA shall accomplish the afforestation for which money is deposited in the Compensatory Afforestation Fund within a year or two growing seasons

However, scrutiny of records in divisions revealed that in 37 cases, compensatory afforestation work was executed after more than eight years of getting final clearance. This resulted in a cost escalation of ₹ 11.54 crore in raising compensatory afforestation, the report said

The implementation of compensatory afforestation activities suffered due to delayed submission of the annual plan of operations to the government of India for approval and defective planning, the audit report said.

There were instances of dysfunctional bottom-up planning and adoption of ad hoc or arbitrary approaches for the inclusion of irregular items in the Annual Plan of Operation (APO).

The release of funds was unrealistic and not commensurate with the approved APO. The state authority failed to ensure equitable and need-based funding of activities in all the implementing agencies.

There was inefficiency in funds release, not adopting of accounting procedure as per Compensatory Afforestation Fund rules, and not discharging of interest liability, the CAG report said.

The CAG has recommended that the state authority must exercise internal control and institute proper budgetary control checks for robust financial management so that misutilisation or diversion of CAMPA funds can be pre-

Man held for attempted smuggling of hybrid ganja worth₹1 cr KOCHI, Feb 22: The Customs department has arrested a man who attempted to smuggle ₹ 1 crore worth of hybrid ganja (hydroponic weed) through the Postal Appraising Section (PAD)

of Customs, officials said on Saturday. Acting on specific intelligence that hybrid ganja was being shipped from Thailand to an unidentified recipient in Kochi via post, Customs officers visited the Postal Appraising Section and seized the contraband on February 18, an official release from Customs added.

To track down the recipient and gather concrete evidence, a special team comprising officials from the Headquarters Pre-Unit, Customs ventive Preventive Commissionerate, Customs Postal Section, and India Post was formed. A dummy parcel was dispatched through the regular postal delivery process to lure the suspect.

Investigations revealed that the recipient had provided a fake address to receive the contraband. Consequently, Customs officers maintained surveillance at specific locations linked to the recipient.

On February 20, as a postman attempted to deliver the parcel to the given address, Customs officers moved in and arrested the suspect, a Kochi native.

A follow-up search of his res-idence led to the seizure of 30 grams of hydroponic weed, 50 grams of ganja, and incriminating evidence on his mobile phone, revealing details of distribution chains and a possible supply network targeting students and young individuals.

Following his voluntary statement, the accused was taken into custody and produced before a local court, which remanded him to judicial custody for 14 days, the release added.

Further investigations are underway, officials said. (PTI)

KOLKATA, Feb 22: The husbands of the two women whose bodies along with that of a girl were found in their Kolkata residence are likely to be arrested, a senior officer said.

The decision to apprehend the husbands, who were also siblings, was taken after postmortem reports suggested that the two women and the girl were murdered, dismissing speculations that the three died by suicide.

The three members of the family were found dead inside their Tangra residence, while three others were injured after their car crashed into a Metro Rail pillar in the city on early Wednesday. One of the injured persons told the police about the deaths in their familv. Two brothers - Pranay and Prasun Dey lived in that house in the eastern part of Kolkata with their wives Sudeshna and Romi, respectively. Pranay's son and Prasun's daughter were the other occupants of the house.

manual rules, ends caste-based work allotment SHIMLA, Feb 22: The Himachal

Pradesh government has amended all the caste-based provisions in the HP Prison Manual 2021 to ensure equality and elimination of castebased work allocation among prisoners, an official said on Saturday The state government has inserted a paragraph in the manual prohibiting caste-based discrimination in prisons and correctional institutions. The newly added provision, (para 5.66) ensures that

no discrimination, classification or segregation of prisoners will occur on the basis of caste, a government spokesperson said.

Whereas para 5.67 further mandates that there will be no discrimination of prisoners in allotment of any duty or work in prisons on the basis of their caste, he added.

Para 5.68 invokes the provision that prisoners will not be engaged in manual scavenging, sewer system maintenance and septic tank cleaning

the Jail Manual allowing the employment of paid sweepers in the absence of female prisoners for cleaning tasks. This clause, previously under paragraph 214, has now been completely deleted.

The spokesperson said that the jail records will no longer mention the caste, community or religious affiliations of inmates of prisons. The state government has introduced these reforms through the Himachal Pradesh Prison Manual Second Amendment, 2025, Furthermore, the amended Jail Manual also provides a clear definition of habitual offenders. A person will be classified as a habitual offender if the person has been convicted or sentenced to imprisonment on more than two occasions on account of any one or more offences committed on different occasions and not constituting parts of the same transaction within a continuous period of five years, provided the convictions have not been overturned on appeal

Not everything is fair, so keep option B ready: Taapsee Pannu's advice to new actors

MUMBAI, Feb 22: Hard work alone does not guarantee success in the film industry, says actor-producer Taapsee Pannu as she believes it is a common misconception that the world of movies is a fair place.

During the ABP Network's Ideas of India 2025 on Friday, the 37-year-old actor shared her thoughts on the harsh realities of the film industry. "The idealistic thing is that with hard work you will achieve everything

that isn't the case. Not everything is fair in the film industry. If you expect that things will be fair and square then that won't happen.

"It will be unfair. You will get to hear a lot of things, so keep your ego aside, otherwise, you will be disappointed, besides get used to hearing bad things. It's not about Bollywood. I'm not a victim of the industry," Pannu said. She advised aspiring talents to have a backup plan in case their efforts don't lead to success.

"I had option B. I had done engineering, had a job and I could do that. I wanted to do an MBA, so I had kept all the options ready," Pannu said. Pannu said that actors who are "outsiders" will often find that their suc-

Pannu said that actors who are "outsiders" will often find that their success depends not just on talent but largely on audience reception of their work. "Our stature depends on the audience. If the audience prefers watching hero-centric films in theatres and not ours, then how will we succeed? It's not that the industry kicks us out of the industry, they rather give us opportunities." The actor also opened up about her married life.

Pannu, who tied the knot with longtime partner badminton star Mathias Boe in 2023, said she didn't feel the need to issue a "press release" about her wedding. "I met him on the badminton court, I was in the audience, and he was playing, and it was a domestic league and that's where I met him. I've known the person I married for ten years, and now I have known him for 11 years.

"I've never tried to hide that from anyone. The thing is he is neither a cricketer nor a businessman, so maybe people were not interested in it. But whenever I was asked about him, I've always spoken about it. My marriage is going well." Pannu said she had a thoughtful approach towards her marriage and added that she tied the knot nine years after Boe proposed to her.

"I've seen many marriages that have fallen apart or not worked, and I was afraid. We are in a profession where there are so many ups and downs and I didn't want ups and downs in my personal life. So, after many trials and tests, I got married. My personal life is so stable that people think it's boring," she said. (PTI)

Court spares Aditya Pancholi of jail term in assault case, asks him to pay ₹1.5 lakh to victim

MUMBAI, Feb 22: A sessions court in Mumbai has upheld the conviction of actor Aditya Pancholi in a 2005 parking assault case but modified the one-year jail term handed by a magistrate and ordered his release on a bond of good behaviour.

The sessions court, however, directed the 59year-old actor to pay a compensation of Rs 1.5 lakh to assault case victim Pratik Pashine for availing the benefit of release under the Probation of Offenders Act.

The Metropolitan Magistrate (Andheri) had in November 2016 convicted the actor under IPC section 325 (voluntarily causing grievous hurt) and sentenced him to one-year simple imprisonment for assaulting Pashine over a parking dispute in 2005.

Pancholi appealed against his conviction and sentencing in the case.

Additional Sessions Judge D G Dhoble on Thursday partly allowed Pancholi's appeal against the magistrate's order and spared him of the jail term.

The sessions judge ruled that the trial court (magistrate) "has not committed any illegality, irregularity and perversity" in convicting and sentencing the accused to one-year jail term.

"The impugned judgment and order "L.convicting the appellant under Section 325 IPC is hereby upheld. But instead of awarding sentence of substantial punishment, I hold that the accused is entitled to be released on probation of good conduct under Section 4 of the Probation of Offenders Act," the sessions court ruled. (PTI)



It is heartbreaking, gruesome: Bhumi Pednekar on Justice Hema Committee report

Mumbai, Feb 22: As a woman, I feel scared, said actor Bhumi Pednekar, reacting to the Hema Committee report that exposed the harassment and sexual exploitation faced by women in the Malayalam film industry.

Speaking at the ABP Network's Ideas of India 2025, Pednekar said the findings of the report, which was released in August last year, perhaps the first instance for any film industry in India, were heartbreaking and gruesome.

"It is one part of the Indian fraternity where proper legal process was followed, there were heartbreaking gruesome details that came out. As a woman in India today, I'm scared. This is again not just about fraternity," Pednekar said.

"I'm scared when my younger cousin who lives with me in Mumbai goes to college and when she doesn't come home till 11 pm, I get nervous. There's deep conditioning of power. There's a problem when front page news is only about violence done to women. This is not one off thing, this is a regular occurrence," she added.

In the aftermath of an assault case on an actress involving actor Dileep in 2017, the Kerala government appointed a panel to study issues of sexual harassment and gender inequality.

The panel's 233-page report exposed the power dynamics within the Malayalam film industry, revealing the multiple layers of exploitation faced by women artists.

On a query about the casting couch in the Hindi film industry, the 35-year-old actor – who earlier worked as an assistant casting director at Yash Raj Films – said though she has not personally faced it, she acknowledged the widespread nature of such incidents within the industry.

"Before I became an actor, I was casting in an institution that was clean and organised. My casting director Abhimanyu Ray would never cast a girl without me being present in the room. Now that's the ecosystem in which I grew up.

"I was 17 when I started as a casting director in Yash Raj Films. I've no first-hand experience of it. But does that mean it doesn't happen? No, it does because we've had many women who have dared to come out and speak about it. I would never negate a girl's experience," she said.

The actor also addressed the glaring gender pay gap that persists in Bollywood and said it happens across all industries globally.

"The CEO of any major conglomerate, if she is a woman, will undoubtedly earn a lower salary. The pay gap is even more in the film industry," she said.

Pednekar recalled the time when she was paid way less than what her male counterpart earned for their project.

"I was offered 5 per cent of what my male counterpart got. I made this comparison because he and I had the same amount of hits. We were leading the film, and we also started at similar times, and yet he got 80 per cent more.

"I did that film because I didn't have a choice. I wanted to create an ecosystem where I can empower myself and others," she said. (PTI)

Babar Azam plays for himself; Pakistan not ready to face India: Danish Kaneria

NEW DELHI, Feb 22: Former Pakistan spinner Danish Kaneria has slammed Babar Azam for prioritising personal milestones over team success and expressed concerns about Pakistan's preparations ahead of their marquee Champions Trophy clash against India in Dubai on Sunday.

The former Pakistan captain, who recently lost his ODI No. 1 ranking to Shubman Gill, was blamed for his slow knock of 64 off 90 balls in the Champions Trophy opener against New Zealand. His inability to accelerate the run rate and dismissal in the crucial 34th over contributed to Pakistan's 60-run defeat, putting their title defence in jeopardy. Kaneria pointed out Pakistan's struggling batting lineup, accusing Azam of focusing more on his individual performance than the team's success.

"If we talk about Babar Azam, he is playing for himself. When he is under pressure, he focuses on keeping his stats and ICC

ranking intact," Kaneria told PTI Video. "I have scored a fifty, I have done it. But where is the intent of winning the match for your side?", Kaneria questioned. He credited Salman Agha (42 off 28 balls) and Khushdil Shah (69; 49b) for their impactful knocks, which helped Pakistan

avoid an even bigger defeat. "Salman Ali Agha and Khushdil Shah played great knocks, if those two boys hadn't scored quickly, then Pakistan would have lost by 100 runs, instead of losing by 60 runs.

"If you play, play for the country, the country comes first. Show a little intent...But unfortunately, Babar couldn't do that", he said. The 44-year-old further expressed concerns about Pakistan's readiness for the crucial clash against India.

"The scenario is crystal clear. I don't think there is much hype this time because Pakistan is not playing good cricket. India are playing excellent cricket," Kaneria said



He pointed to Pakistan's recent defeating England in at home. struggles, including a disappointing Tri-Nation Series campaign and a 1-1 draw against the West Indies in a home Test series. In contrast, he hailed India's strong injury and got a fifer against Bangladesh," he said. "On the resurgence following their Border-Gavaskar Trophy defeat in Australia, highlighting their dominant white-ball series win over England. "They had a debacle in Australia, many players were questioned. But the way they have started the year 2025,

Day before Pakistan clash, Kohli focuses on spin play

DUBAI, Feb 22: Indian superstar Virat Kohli meant business a day before the marquee clash against Pakistan in the Champions Trophy as he arrived at the ICC Academy two hours before scheduled practice time to iron out his issues against spin

Kohli, who was troubled by the ball outside off-stump from the pacers on the Test tour of Australia, has been found vulnerable against spin in the recent ODIs he has played.

The 36-year-old fell to leg-spinner Rishad Hossain in India's opening Champions Trophy game against Bangladesh on Thursday, his sixth dismissal in a row against spinners in ODIs.

He was caught at backward point while trying to cut Hossain. In the preceding series against England at home, leg spinner Adil Rashid had got the better of Kohli.

The former India captain will have to deal with the likes of Abrar Ahmed when India takes on Pak-

istan at the Dubai International Stadium on Sunday.

Irrespective of his form, Kohli's commitment to the game remains unquestionable, and his exemplary work ethic was on full display as he arrived for training well before his teammates, who also showed up an hour earlier than the scheduled time, and was the last to leave.

It was not a surprise that the majority of the net bowlers he faced were spinners, including a couple of leg-break bowlers, as many offspinners and a left-arm spinner. Pakistan have a part time left-arm spinner in Khushdil Shah, while

Salman Agha bowls off-spin. With due respect to the opposition, Indian batters would be fancying themselves against the Pakistan spin attack. The main challenge for them will come from the pace trio of Shaheen Afridi, Haris Rauf and Naseem Shah who all are under pressure after an underwhelming opening game against New Zealand.

While India are sitting comfortably after the win over Bangladesh, Pakistan find themselves in a mustwin situation.

The wicket is expected to be on the slower side, bringing a battery of Indian spinners into the game.

India have five spinners in the squad, including two specialists in Kuldeep Yadav and Varun Chakravarthy, while the allrounders who bowl spin are Ravindra Jadeja, Axar Patel and Washington Sundar. (PTI)

CT: India aim for semifinal, Pakistan eye survival in marquee clash

DUBAI, Feb 22: Hyped as a marquee showdown but mostly lopsided on the field, India and Pakistan lock horns in the ICC Champions Trophy here on Sunday with Rohit Sharma's men aiming to seal a semifinal spot and Mohammad Rizwan's team desperate to avoid early elimination from the tournament.

While India are on a high after claiming a measured six-wicket win over a sprightly Bangladesh, Pakistan are evidently tense after the 60-run loss in the tournamentopener against New Zealand.

The sub-continental rivals' last Champion Trophy clash was the 2017 final in which Pakistan walked away with the win and the trophy. Rizwan and Co. would look to draw inspiration from that triumph in London but would also need to scale up their performance in every department.

Though the buzz surrounding the match is nowhere close to being what it used to be at the peak of diplomatic tensions between the two countries, there is an air of quiet anticipation for the Group A clash at the Dubai International Cricket Stadium.

India will have a distinct advantage in every aspect. The side has settled in nicely while Pakistan have flown in a couple of days ago after the drubbing handed by the Black Caps in Karachi.

More often than not, an India-Pakistan clash is as much a battle of nerves as cricketing abilities and India would be in a much better space on both counts come Sunday afternoon

For starters, skipper Rohit, whose form was a major concern in the run-up to the tournament, seems to be getting back to his best if the lucid stroke-making against Bangladesh was anything to go by.

Kohli getting out to same type of bowling is a concern: Sunil Gavaskar

NEW DELHI, Feb 22: Virat Kohli's recurring dismissals due to an openfaced bat is a matter of concern as India aim to regain the Champions Trophy after 12 years, believes legendary Sunil Gavaskar.

The 36-year-old Kohli, who had a tough tour of Australia where he was repeatedly dismissed by fast bowlers in the off-side corridor, was dismissed for 22 in India's opening match of the Champions Trophy against Bangladesh on Thursday

This marks the sixth consecutive time Kohli has been dismissed by spin

in ODIs, as he had struggled against England's leg-spinner Adil Rashid too in the recent home series. "It is to a great extent due to the fact that the bat face opens up, the same thing happens when he's playing against the quicks in Australia," Gavaskar told India Today.

"The bat face is opening up, looking to play through the covers, opening the face of the bat, that gets him into trouble. So that is something that he's got to watch out for." Kohli was dismissed by wrist-spinner Rishad Hossain while trying to cut the ball, only to be caught by Soumya Sarkar at backward point.

"A couple of times before he got out, he reached for Rishad, the ball turned, the bat face opened, and luckily the bat face opened, and so there was no nick. So that is something that he'll have to tighten up on now,' Gavaskar said. "But yes, I guess if you're getting out to the same kind of bowling, then you know, there is a bit of concern," he added.

Kohli, who scored 765 runs in 11 matches during the 2023 ODI World Cup, has struggled to replicate that form this year, managing only 137 runs in six innings at an average of 22.83, with just one half-century.

In Tests since 2024, he has scored only 440 runs in 11 matches.

Duckett stands tall with career-best 165 as England post 351/8 vs Australia

LAHORE, Feb 22: Ben Duckett struck a magnificent career-best 165 to power England to 351 for 8 against Australia in their Champions Trophy Group B opening match here on Saturday.

The 30-year-old Duckett, who was benched during England's disastrous T20 World Cup campaign last year, grabbed his moment on the big stage, hitting 17 boundaries and three sixes during his 143ball knock to lead his side to their highest ever total in the Champions Trophy

England, after being sent in to bat, were in early trouble at 43/2 inside the powerplay, but Duckett stood tall, first stitching a 158-run stand with Joe Root (68) and later forging a crucial 61-run partnership with skipper Jos Buttler (23 off 21 balls). After his dismissal in the 48th over, Jofra Archer smashed two fours and one six in his 10-ball 21 not out to prop up the total past 350-mark. Duckett's innings was meticulously planned, blending patience with aggression. He started confidently, taking on Glenn Maxwell with a charge-down six in just the second over, setting the tone for England's recovery. Once settled, he rotated strike fluently with Root, allowing the innings to flow, before shifting gears in the latter half. Duckett brought up his century off

PCB enforces no-free-pass policy for ICC Champions Trophy

KARACHI, Feb 22: For the first time, the Pakistan Cricket Board (PCB) is not distributing free passes for enclosures, VIP areas, or hospitality boxes during the ongoing ICC Champions Trophy, a departure from past practices for international series in Pakistan.

Typically whenever an international series is held in Pakistan, the PCB reserves tickets to be given out as free passes to some stakeholders including the media, government departments, VIPs and sponsors.

However, this time except for a few tickets given to the Chairman for his personal guests and sponsors, the PCB has not been allocated any quota for complimentary passes, an official source close to the ticketing process for the Champions Trophy said. (PTI)

I eat only one meal a day, my weight was touching 90kgs during recovery phase: Shami

DUBAI, Feb 22: Giving an insight into how he keeps match-fit even at the age of 34, Indian bowling stalwart Mohammed Shami says he prefers to eat only one meal a day and avoids sweets.

Shami has been the standout bowler for India in the ongoing Champions Trophy with the pace spearhead grabbing five wickets against Bangladesh in the marquee event in Dubai, thus becoming the fastest Indian bowler to take 200 ODI wickets.

"After 2015, I only have one meal a day. I only have dinner; no breakfast, no lunch. It is very difficult to do such a thing but once you get used to it then it becomes very easy," said Shami during an interaction with cricketerturned-commentator Navjot Singh Sidhu on

Star Sports.

He had been sidelined from international cricket for 14 months due to an ankle injury sustained during the 2023 ODI World Cup final against Australia, which interrupted a remarkable run where he topped the tournament's wicket-taker's chart with 24 scalps.

The injury required surgery, and his recovery was further delayed by swelling on his left knee, keeping him out of international action for more than a year.

Shami said he gained quite a bit of weight during the recovery phase and had to shed nearly nine kgs to get back into shape.

"I have lost nine kgs (during rehabilitation). The most difficult thing is you have to challenge yourself. When you are in this condi-

tion ... when I was at the NCA, it was a very difficult phase,

"My weight was touching 90kgs. The best thing about me is that I do not crave for delicacies. I stay away from sweets. I stay away from a lot of things, things that generally one shouldn't eat. So, I stay away from them," said Shami, who will have to shoulder a lot of responsibility in India's clash against arch-rivals Pakistan in the Champions Trophy here on Sunday.

Shami, who has claimed 55 wickets across three ODI World Cups and became the eighth Indian to reach 200 wickets in one-day cricket, added that despite his strict regimen he does enjov his birvani once in a while.
