## Himanta hints at seeking Interpol help to probe ISI activities

GUWAHATI, March 4: Assam Chief Minister Himanta Biswa Sarma on Tuesday said his government may seek the help of agencies like the Interpol in investigating the alleged interference of Pakistani national Ali Tauqeer Sheikh, who allegedly has links with Congress MP Gaurav Gogoi's British wife, in India's internal affairs.

Sarma, however, said the probe is at an initial stage and he has already informed Union Home Minister Amit Shah about the developments in the case.

"The matter is very sensitive. I have informed the home minister about the issue. The SIT is doing its investigation, but we can do our probe until a certain level only. We may have to take the help of agencies like Interpol at a certain stage," he told reporters here.

The entire probe is at an initial stage now and the government will take it forward as far as possible in the coming days," he added.

The state police on February 17 constituted a Special Investigation Team (SIT) to probe a case against the Pakistani national for his social media comments on Assam and India's internal affairs.

Sheikh, an advisor of the Pakistan Planning Commission and a former colleague of Gogoi's British wife Elizabeth Colburn, was charged under various sections of the Bhartiya Nyay Sanhtia (BNS) and the Unlawful



Activities (Prevention) Act or UAPA. The CM, who also holds the Home portfolio, further

claimed that the SIT has obtained a lot of preliminary information related to the Pakistani national.

## President Trump temporarily suspends all military aid to Ukraine

NEW YORK/WASHINGTON, House between the US leader and March 4: US President Donald Trump has temporarily suspended, with immediate effect, the delivery of all American military aid to Ukraine, just days after an unprecedented showdown with Ukrainian President Volodymyr Zelensky in the Oval Office.

A report in The New York Times quoted a senior administration official as saying that Trump temporarilv suspended the delivery of all US military aid to Ukraine and that the order takes effect immediately, affecting "more than \$1 billion in arms and ammunition in the pipeline and on order".

The report said Trump's decision to halt military aid "resulted from a

his senior national security aides. The official said "the order would be in effect until" Trump determined that Ukraine had demonstrated a commitment to peace negotiations with Russia.

The order also pauses "hundreds of millions of dollars in aid through the Ukraine Security Assistance Initiative, which provides funds that Kyiv can use only to buy new military hardware directly from US defence companies.'

# 'Total police raj': Cong decries gunning down of 72 accused in Assam since 2021, seeks SC cognisance

GUWAHATI, March 4: The opposition Congress on Tuesday accused the BJP government in Assam of running a "police raj" after official data tabled in the assembly revealed that 72 accused persons were gunned down and 220 injured in police actions since Himanta Biswa Sarma became the chief minister in May 2021.

The Congress also stated that the Supreme Court should take suo motu cognisance of the data while issuing a verdict in an ongoing case on alleged fake encounters in the state.

Sarma, who also holds the home portfolio, tabled a set of official papers in the assembly on Monday, revealing that 256 police actions have been taken between May 10, 2021 and February 23 this year. Magisterial inquiries were conducted in 175 cases but not in 81 others.

The government, however, registered police cases in each incident under relevant laws and as per guidelines of the National Human Rights



Commission (NHRC).

Reacting to the data, Leader of Opposition Debabrata Saikia of the Congress said that the apex court, which is already hearing a case on 171 alleged fake encounters in Assam, should take cognisance of the latest data and go for further suo motu hearing before pronouncing the verdict.

"The SC should take cognisance of these latest facts and open the case instead of reserving the

verdict. This news should be taken into consid-

eration suo motu," Saikia told PTI. He alleged that the figures show that there is a "total police raj" in the state without any regard for the rule of law.

'We strongly condemn such a situation. We have been trying to raise the matter in the assembly so many times, but answers had always been evasive. Such killings of accused persons are happening because the ruling party is using the police for political gains," Saikia said.

The documents tabled in the House showed that 38 people were killed while they were in police remand. Additionally, 34 more lost their lives in police action while they were in custody but

before being sent to police remand. Similarly, 181 people received bullet injuries in these incidents while they were in police remand and 40 more were injured before being sent to police remand. (CONTD. ON PAGE-2)

#### 33 arms surrendered in Manipur

# World looking at India as trusted partner: Modi

NEW DELHI, March 4: Prime Minister Narendra Modi on Tuesday nudged the Indian industry for "big steps" to take advantage of global opportunities at a time when the world is looking at India as a trusted partner, saying the government will launch two missions to promote manufacturing and exports.

Addressing a post-budget webinar on Regulatory, Investment and Ease of Doing Business Reforms, Modi asked the industry to identify new products that can be manufactured in the country to meet global demand. "Our country is capable of doing this, all of you (industry) are capable, this is a great opportunity for us. I want our industry should not look at these expectations of the world as a mere spectator. We cannot remain spectators, you will have to look for your role in this, you will have to seek opportunities for your-

self," Modi told the industry players. The Prime Minister also stressed the need to develop new modes of



credit delivery to ensure access to timely and low-cost funds to over six crore micro, small and medium units across the country. He said five lakh first-time women and SC&ST entrepreneurs will be provided loans of up to Rs 2 crore.

"Today, India is a growth engine

for the global economy. India has proved its resilience even in difficult times... Today, every country wants to strengthen its economic partnership with India. Our manufacturing sector should take advantage of this partnership," Modi added.

The Prime Minister said the in-

dustry has gained new self-confidence due to the government's consistency and assurance for reforms. "I want to assure the stakeholders in manufacturing and export sectors that this will continue in the coming years. I urge you to move ahead with confidence and take big steps. For the country's manufacturing and export sectors new avenues have been opened," Modi said. The Prime Minister said MSMEs

need not only credit but also guidance, and suggested that industries should establish mentorship programmes to support them.

Asserting that stable policy and improved business environment are vital for any country to progress, he said the government has done away with over 40,000 compliances at the Centre and state level and is working on the Jan Vishwas 2.0 Bill.

It was not known exactly how many of these incidents were unilateral action by the police and how many were encounters, when both sides were engaged in gunfights. A year-wise breakup shows that the highest number of people were killed in 2021, the year when Sarma became the CM of Assam. That year, a total of 31 people lost their lives in 83 cases of police action, both in remand and before remand.

Also, 67 people were injured, including 54 in police remand and 13 before remand. In 2021, magisterial inquiry was conducted in 52 cases, while no such probe was ordered in 31 incidents. The next year, 18 accused were gunned down, including three before their police remand. A total of 79 others were injured in 95 incidents, out of which magisterial probes were conducted in 66. In 2023, the documents showed that 13 accused were gunned down, including nine before remand. Additionally, 35 people were injured in 44 incidents, out of which magisterial probes were ordered in 35 cases. In 2024, 10 people lost their lives, including three before police remand. A total of 35 people were injured in 28 cases, out of which magisterial probes were ordered in 21 incidents. In the current year till February 23, no death has been reported but five people have been injured during police remand in six different instances. Out of these, magisterial probes have been ordered in only one case.

Another set of documents showed that a total of 136 people were killed across Assam in police action since 2016, when the BJP came to power for the first time in the state. Earlier, the high number of shoot-outs whipped up a political furore with the opposition alleging that the Assam Police have turned "trigger happy" and were indulging in "open killings" under the Himanta Biswa Sarma-led regime.

The Supreme Court was on February 25 informed by the Assam government that the 2014 guidelines for investigating police encounters were duly followed in the state and unnecessary targeting of security forces was demoralising. Following the submission, a bench of Justices Surya Kant and N Kotiswar Singh reserved the verdict on a plea seeking an independent investigation over 171 alleged fake police encounters in Assam between May, 2021 and August, 2022, in which 56 people died, including four in custody, and 145 were injured.

The petitioner, Arif Md Yeasin Jwadder, had challenged a January 2023 order of the Gauhati High Court, which dismissed his PIL over the encounters by Assam Police. In October last year, the SC had termed the situation "very serious" and sought details, including on the probe conducted in these matters. (PTI)

Additionally, customised credit cards with a limit of ₹ 5 lakh will be provided to meet working capital needs. Underlining that the government has facilitated loan access and introduced a new type of loan, Modi said people are now receiving loans without guarantees, something they never imagined before. Over the past 10 years, schemes like MUDRA, which provide loans without guarantees, have also supported small industries, he noted.

He emphasised the need to develop new modes of credit delivery, ensuring that every MSME has access to lowcost and timely credit. He also announced that five lakh first-time entrepreneurs from women, SC, and ST communities will receive loans of ₹ 2 crore. He urged the industry to create a mentorship programme to help these individuals. Advanced systems like bulletproof jackets, drones, surveillance equipment and anti-drone technologies must be leveraged not only for security operations but also for disaster management and humanitarian relief," he said. Singh said the increasing frequency of natural calamities like cyclones, avalanches, earthquakes and cloud bursts underscored the critical need for advanced rescue tools. He mentioned that the use of technologies such as thermal imaging cameras, drone-based detection systems, and victim locating devices can significantly reduce casualties and damage. Referring to the recent avalanche at Mana in Uttarakhand, the defence minister lauded the use of advanced rescue equipment in saving lives and reducing the impact of the disaster. He said the impact of disasters can be minimised with the use of advanced technology.

'Today, India is a prospering nation, and disaster management must become an integral part of our preparedness." "It is not enough for security agencies and technology developers to take the lead; we must also educate the general public. Every citizen should know how to respond in times of crisis," he said. (PTI)

#### Over 60,000 kgs of seized betel

continue to remain unclaimed despite repeated efforts to trace their legitimate proprietors," the official said on Monday. The first case of October 13, 2024 involved the seizure of 405 sacks of betel nuts, weighing 26,905 kg. In another case of December 26, 2023, a staggering 33,515.26 kg of betel nuts were seized.

The official said sacks of the betel nuts have been lying on the premises of Lakhipur Police Station, but no individual or entity has come forward with valid proof of ownership. The authorities have issued multiple notifications, urging the rightful owners to establish their claim by submitting the necessary documentation, yet the stockpile remains untouched, he said. With such an enormous quantity remaining unclaimed, the matter has sparked speculation about its origins and whether these seized commodity is linked to illegal trade or not, the official said. A final call for any individual or business unit with rightful ownership of these confiscated goods to come forward and submit the required documents is being made. Failure to do so may lead to further legal action regarding the unclaimed property, he added. (PTI)

#### Senior citizen's ATM card stolen, ₹ 62,000 **looted in Nagaon**

NAGAON, March 4: In a shocking incident, a miscreant stole ATM card from a senior citizen from ATM booth, and ₹ 62,000 was looted from his account in Nagaon.

The stolen ATM card was used to withdraw ₹ 31,000 from the same ATM, and another ₹ 31,000 was withdrawn from a different ATM at Balaji Service Station. The total amount looted from Hazarika's account is ₹ 62,000.

# Experts delved into importance of endangered languages

The contractual NHM workers, who are paid very low salaries, said that their contributions during the pandemic have not been recognised or rewarded adequately.

## Trump throws a challenge

he US President Donald Trump has fired his missile on Europe, especially, France, UK and Germany by suspending arms aid to Ukraine after categorically making it clear that President Zelensky has to agree to the peace and security deal proposed by Trump on Friday in the White House meeting. The deal is still on the table and only this deal and not all those proposed by EU members at the Sunday meeting in London would be considered. The directive of Trump is not so much against Zelensky but more against the French President Emmanuel Macron and the British Prime Minister Keir Starmer who floated one month Ukraine truce plan in their meeting giving full backing to the Ukrainian president in his stand that Putin was not serious on peace and Trump was imposing Putin's plan on Ukraine. The EU countries agreed to increase their spending for Ukraine war. British Prime Minister already announced an immediate aid of US\$ one billion. This is meant to hit the EU nations below the belt so that after doing away with all brave postures of taking a position in variance with Trump, they agree to his terms finally and let his peace plan work. # **British Prime Minister's** dangerous delusions on Trump and Ukraine

n the one hand. Keir Starmer hosts European and Canadian leaders for a summit on militarisation in response to the abrupt US policy shift on Ukraine. On the other Israel's Benjamin Netanyahu blocks all humanitarian aid to Gaza, threatening to derail the second phase of the fragile ceasefire.

Donald Trump's position on Gaza, calling for the ethnic cleansing of its whole population, has not been endorsed in European capitals. But nor has it bothered them enough for heads of government to race to Washington to beg him to change his mind. Peace in Ukraine is, apparently, a far greater threat than war in the Middle East.

Starmer and Macron's Washington visits failed. The British PM was an embarrassment in Washington, told "that's enough" by the US president even as he fawned on him by weaselling out of a question on Trump's threats to Canada.

But the sycophancy secured nothing, as Trump and Vice-President JD Vance's public humiliation of Ukraine's Volodymyr Zelensky on Friday showed. Even now, Starmer, like NATO secretary-general Mark Rutte, calls on Zelensky to "patch things up" with Trump. They delude themselves: the shift in US policy is not

down to some personal falling out. Washington wants an off-ramp from confrontation with Russia to concentrate on its global "peer competitor," China; it recognises that the Pacific, not the Atlantic, is now the global centre of gravity economically, and has demoted Europe in its hierarchy of geopolitical interests accordingly; and it appreciates, apparently rather better than EU or British leaders, that

the war is being lost. Vance was not the first to point out that Ukraine faces severe manpower problems and endemic draft-dodging, leading it to deploy press gangs to seize men for the front line on the streets. The less propagandistic parts of the British media, such as the Financial Times, have reported on this for months. Starmer's inane pledges to supply Ukraine for "as long as it takes" ignore the fact that the longer the fighting goes on, the worse for Ukraine: one reason

Ukrainians show majority support

for talks in polls. Having howled down all talk of negotiations for three years, a White House U-turn means Starmer is now in favour of talks too. But he deludes himself again believing that Europe, if it ramps up military spending (and NATO countries already account for 75 per cent of world military spending), will convince Trump to offer the very "security guarantees" he has repeatedly ruled out to a hazardous Franco-British deployment

That this is about appeasing, not defying, Trump is clear since Starmer offers no quid pro quo for a US retreat from Europe. He does not suggest pulling back British warships helping US counterparts goad China in its coastal seas, or withdrawal from provocative Pacific commitments like the Aukus submarine pact.

in Ukraine.

If Britain "steps up" in Europe, it will be at the cost not only of our foreign aid budget but of social security and public services too. But it is more serious still to oppose British militarism because of its essential character. Britain is an imperialist country, involved in multiple acts of aggression against other countries from 1999 on, and has recently played a direct role in

Israel's war on Gaza. At the 2022 Trades Union Congress, an NEU delegate opposing increased arms spending pointed out that for all the lofty talk of defending Ukraine, British bombs would actually be used "to kill kids in Yemen.'

The British state does not have a benevolent side determined to uphold national independence in Ukraine, and a malevolent one helping crush any prospect of that in Palestine.

It is part of a belligerent US-led alliance whose wars have cost millions of lives. If Trump is now disrupting that alliance, we should take the opportunity to seek real independence and pursue a peaceful foreign policy. (IPA Service)

# **Assam's lifeline: The essence of Clause Six**

tural diversity and natural tural diversity and harman beauty, has long been a land of contrasts. Its history is marked by waves of migration, cultural assimilation, and struggles for identity. At the heart of Assam's quest to preserve its unique identity lies Clause Six of the Assam Accord, a provision that has become a symbol of hope and resilience for the Assamese people. This writeup explores the essence of Clause Six, its historical roots, significance, and the challenges surrounding its implementation.

The Assam Movement (1979-1985) was a defining moment in the state's history. It was a mass uprising led by the All Assam Students' Union (AASU) and the All Assam Gana Sangram Parishad (AAGSP) against the influx of illegal immigrants, primarily from Bangladesh. The movement was driven by the fear that unchecked migration was altering Assam's demographic fabric, threatening the cultural and linguistic identity of its indigenous population. After years of protests and negotiations, the Assam Accord was signed on August 15, 1985, between the Government of India, the Assam government, and the leaders of the Assam Movement. The Accord aimed to address the concerns of the indigenous population by detecting and deporting illegal immigrants and safeguarding their rights. Clause Six of the Accord emerged as a critical provision, promising constitutional, legislative, and ad-

the cultural, social, and linguistic identity of the Assamese people.

Clause Six states: "Constitutional, legislative, and administrative safeguards, as may be appropriate, shall be provided to protect, preserve, and promote the cultural, social, linguistic identity, and heritage of the Assamese people." This clause is not just a legal provision; it is a lifeline for the Assamese community, a promise to ensure that their identity remains intact in the face of demographic and cultural challenges. Assam's demographic composition is complex, with numerous indigenous communities, each with its own language, culture, and traditions. The Assamese language, while widely spoken, is not the mother tongue of all residents, making the preservation of linguistic identity a delicate issue. Clause Six seeks to address these complexities by providing a framework for safeguarding the rights of the indigenous population.

Despite its significance, Clause Six remained largely unimplemented for decades after the signing of the Assam Accord. The delay in its implementation became a source of frustration and disillusionment for the people of Assam. Various committees were formed over the years to define the "Assamese people" and recommend measures for safeguarding their rights, but none of their reports were acted upon. The issue gained renewed attention in 2019, following the passage of the Citizenship Amendment Act (CAA), which sparked widespread protests across Assam. The CAA, which grants citizenship to non-Muslim immigrants from Pakistan, Afghanistan, and Bangladesh, was seen as a direct threat to the Assamese identity, as it could lead to further demographic changes in the state. In response to the protests, the Government of India constituted a high-level committee in 2020 to recommend measures for the implementation of Clause Six. The committee, headed by Justice (Retd.) Biplab Kumar Sharma. submitted its report in February 2020, proposing a range of meas-

ures to protect the rights of the Assamese people. These

included reservations in legislative assemblies and local bodies, land rights, and cultural and linguistic safeguards. However, as of 2025, the recommendations of the committee have yet to be fully implemented, leaving the future of Clause Six in a state of uncertainty.

Clause Six is more than just a legal provision; it is a symbol of hope and resilience for the people of Assam. It represents their collective aspiration to preserve their identity in the face of external pressures and internal challenges. The clause acknowledges the historical injustices faced by the Assamese people and seeks to rectify them through constitutional and legislative measures. One of the key aspects of Clause Six is its focus on cultural and linguistic preservation. Assam is home to a rich tapestry of lan-

guages. including Assamese, Bodo, Mising, Karbi, and others. The clause aims to ensure that these languages are not overshadowed by dominant languages and that the cultural heritage of the state is protected for future generations. Another critical aspect of Clause Six is its emphasis on political representation. The clause seeks to ensure that the indigenous population has a fair share of political power, both at the state and local levels. This is particularly important in a state like Assam, where demographic changes have often led to con-

## Hopes for a truce between Kurdish militants and Turkiye brighten

t appears that one of the Middle East's most in-Ltractable conflicts might be nearing its end, and its ramifications will be felt far and wide, following the call for peace by PKK leader Abdullah Öcalan. For half a century, Kurdish militants have fought Türkiye for independence in the southeast of the country, which has claimed more than 40,000 lives and has rippled beyond Türkiye's borders into Iran, Iraq, and Syria.

On Thursday last (27 February), Abdullah Öcalan, the jailed leader of the Kurdistan Workers Party (PKK), called on its members to lay down arms and dissolve the group.

However, the call's success now hinges on sustained cooperation among the various parties involved, but political analysts are far from confident that the PKK militants, based in mountainous northern Iraq, will heed the appeal of Öcalan, who has been held in an island jail near Istanbul for a quarter of a

century. Turkish President, Recep Tayyip Erdoğan, called Öcalan's message the start of a new phase for peace efforts, although his government has publicly rebuffed suggestions that Öcalan's call could be followed by peace

Analysts say that for now, Erdoğan, 71, is focused especially on the domestic political dividends that peace could bring as he looks to extend his twodecade rule beyond 2028 when his term expires.

The announcement created ripples across the Middle East, and may affect an array of Kur-



dish militia groups with longheld but varied ties to the PKK. The group, which is classified as terrorist in Türkiye, the US, and the UK, called Öcalan's announcement part of "a new historic process" for the Middle

mittee also called for Ocalan to be freed from his island prison, to "personally direct" a meeting that would prompt them to lay down their weapons.

According to the New York Times, PKK launched an armed insurgency against the Turkish state in the early 1980s, originally seeking independence for the Kurds, who are believed to make up about 15% or more of Türkiye's population.

Initially the insurgency started from the mountains in eastern and southern Türkiye, PKK fighters attacked Turkish military bases and police stations, prompting harsh government responses. Later, the conflict spread to other parts of the country, with devastating PKK bombings in Turkish cities that killed many civilians

In 1999, Türkiye captured Öcalan and convicted him of leading an armed terrorist group. He received a death sentence that was later commuted to life in prison. Since his incarceration, Öcalan has shifted its ideology away from secession and The group's executive com- toward Kurdish rights inside

> Türkiye. The Kurds are an ethnic group of roughly 40 million people concentrated in Iran, Iraq, Syria, and Türkiye. Most Kurds are Sunni Muslims.

> The Kurds were promised a nation of their own by world powers after World War I, but that was never granted. There were Kurdish rebellions in various countries over the following generations, and Kurds have faced state suppression of their

language and culture. Since the 1991 Gulf War, the largely Kurdish northern region of Iraq has been semi-autonomous. Multiple efforts to freeze or end the Türkiye-PKK conflict have been made, starting with a ceasefire in 1993 and talks in 2009-11 and 2013-15. But all of them collapsed.

Hamad, a professor of Iranian and Asian Studies at Tanta University in Egypt and head of the Farabi Centre for Political and Development Studies, told Türkiye's Hawar News that Abdullah Öcalan's announcement is of utmost importance, as it reveals a political, ideological, and even a new national self-review that he conducted after a thorough analysis of the entire global and regional scene.

This also reveals that there

has been a genuine review in the

Turkish political mindset that manages the affairs of the Turkish state on one hand, and the conflict with the Kurds in general and Öcalan in particular on the other hand. Therefore, Dr Hamad said. Öcalan would not have issued this statement unless he had Turkish assurances, promises, and commitments to open the space and provide a sound democratic life for the Kurds to achieve what they could not achieve through arms.

Dr Hamad explained that the PKK leader Öcalan has read between the lines regarding what the future holds for the Kurdish issue on one hand, and perhaps some Western plans, especially American ones, which could strike at the strategic and vital interests of both the Kurds and the Turks together in the coming years, extending what happened in Syria, and this is very impor-

tant and extremely dangerous. Dr Hamad said that Öcalan has a realistic understanding of the regional and international scene. He said, "Abdullah Öcalan perhaps wanted to save the future of the Kurdish cause, unlike some other political organisations, and he read the

In this context, Dr Medhat scene well and he wanted to preserve the existence and essence of the Kurdish cause for the next hundred years.'

Meanwhile, Türkiye's Nationalist Movement Party (MHP), Erdogan's right-wing ally, has become a staunch supporter of the peace process and the farright Nationalist Movement Party (MHP) leader Devlet Bahçeli, who started the new process after his unexpected call suggesting that Öcalan announce an end to the insurgency in exchange for the possibility of his release in October 2024, has welcomed the recent call.

Yet, restoring peace might not be that easy, the Washington Institute's Turkish research programme director Soner Cagaptay told Reuters that the PKK leaders holed up in the Qandil mountains of northern Iraq remain deeply suspicious of Ankara's intentions.

"Elderly commanders might also object to disbanding the PKK entirely or immediately without achieving any of its original goals - an outcome that could suggest they have thrown their lives away for nothing," he

The details of Ocalan's announcement were "purposefully shrouded in mystery, in part because Ankara's two previous dialogues with the PKK failed

miserably", said Cagaptay. Indeed, if Öcalan's followers heed the new call, it would mark a turning point for Türkiye and have far-reaching implications for the Middle East, as Erdogan looks to capitalise on the upheaval in Syria and military gains against the PKK fighters based in northern Iraq. # IMF sees India's growth rate stagnant for the next five years

ndia's growth rate has decelerated to four years low in 2024-25, and the quarter four performance of the econ-Lomy would be key to achieve the projected 6.5 per cent of GDP growth rate. More serious concern lies ahead. Even International Monetary Fund (IMF) sees India's growth rate to remain stagnate at 6.5 per cent yearly until 2030. World Bank has said that to become a developed country by 2047, India will need an annual growth rate of 7.8 per cent. In the backdrop of such projections, India needs not only to work very hard but also a paradigm shift in its developmental policies.

The latest advance estimate of the National Statistics Office shows that country's GDP picked pace and grew by 6.2 per cent in October-December 2024 compared to only 5.6 per cent in July September 2024. For the full financial year 2024-25, the GDP growth rate, as per the second advance estimates was seen marginally higher at 6.5 per cent as against 6.4 per cent as per the first advance estimates released in January 2025. Nevertheless, the growth will still be four years low. However, the key for achieving even 6.5 per cent growth rate will depend on the performance during January-March 2025. To achieve 6.5 per cent of growth rate in the current financial year, India will need a growth rate of 7.6 per cent in the last quarter.

It should be noted that India has revised its GDP growth rate for the year 2023-24 upward to 9.2 per cent from the earlier estimate of only 8.2 per cent. It was thus the second highest growth rate of India in the last 12 years. In 2021-22 India's growth rate was 9.7 per cent which was from a very low base of a negative growth of (-)7.3 per cent.

The latest World Bank report released last week said

that India will need to expand at an average annual rate of 7.8 per cent in real terms to realise its goal of emerging as a developed country by 2047, but to happen this all growth engines, backed by a sustained reforms push, must perform more optimally. It says that departure from business as usual approach will now be required to emerge as a high-income country. It has projected a 6.7 per cent growth rate for India for the next two years through until 2026-

The recent consultation pager released by the IMF has though commended India's growth rate and said that the real GDP of the country is expected to grow at 6.5 per cent in 2024-25 and 2025-26, it has also included the downside

IMF says, "Risks to the economic outlook are tilted to the downside. Deepening geoeconomic fragmentation could affect external demand, while deepening regional conflicts could result in oil price volatility, weighing on India's fiscal position. Domestically, the recovery in private consumption and investment may be weaker than expected if real incomes do not recover sufficiently. Weather shocks could adversely impact agricultural output, lifting food prices and weighing on the recovery in rural con-

On the upside, deeper implementation of structural reforms could boost private investment and employment, raising potential growth, it says, adding India's financial sector health, strengthened corporate balance sheets, and strong foundation in digital public infrastructure underscore India's potential for sustained medium-term growth and continued social welfare gains.

Executive Directors have stressed that in the face of headwinds from geoeconomic fragmentation and slower domestic demand, continued appropriate policies remain essential to maintain macroeconomic stability. India's strong economic performance provides an opportunity to advance critical and challenging structural reforms to realize India's ambition of becoming an advanced economy

IMF's Macroeconomic Framework for India for 2020-21 to 2029-30, shows India's growth rate projections. The growth rate had been decelerating from 9.7 per cent in 2021-22. It decelerated to 7 per cent in 2022-23, and 8.2 per cent in 2023-24, which Government of India had revised it recently to 9.2 per cent. Then there is a sharp decline to projected growth rate of only 6.5 per cent for 2024-25. IMF's projection of India's growth remains the same until 2029-30.

IMF sees saving and investment as percentage of GDP to deteriorate over the year. The projected gross savings has been estimated at 32.7 per cent for the current financial year, which is likely to decline to 30.5 per cent. Gross investment would also decline from 33.6 per cent to 32.6 per cent during this period.

As for growth rate of merchandise export, the paper sees sharp rise from 0.4 per cent in 2024-25 to 4 per cent by 2029-30. However, it also sees sharp rise in merchandise

imports from 6.2 per cent to 7.2 per cent during this period. As for India's GDP is concerned, IMF has estimated it to be USD 3,843 billion in 2024-25. The paper has projected it to increase to USD 6,243 billon by 2029-30. It should be recalled that Modi government had claimed in 2018 that India would be \$5 trillion economy by 2025. It later claimed that the government would make India a \$10 trillion economy by 2030. However, India seems not on track to achieve this, it has miles to go. (IPA Service)

# A woman chief minister of BJP in Delhi is welcome, but what about Reservation Bill?

ekha Gupta's appointment as the Chief Minister of Delhi marks a significant political moment, not just for the Bharatiya Janata Party ('BJP'), which has returned to power in the national capital after 27 years, but also for the broader discourse on women's representation in Indian politics. The decision to elevate Gupta to the state's top executive position came after eleven days of deliberation within the party's high command, eventually making her the fourth woman Chief Minister in Delhi's history, only the second to currently serve in the chief minister's position nationwide. .

As she took the oath of office, in a grand ceremony at Delhi's Ramlila Maidan, accompanying Gupta were her six cabinet colleagues: Parvesh Sahib Singh Verma, Ashish Sood, Manjinder Singh Sirsa, Ravinder Indrai Singh, Kapil Mishra, and Pankaj Kumar Singh. Inconspicuously, they were all men. The optics of this moment vividly portrayed that while the appointment of a woman as Chief Minister was being celebrated as a step toward gender inclusivity, a closer look at the electoral landscape suggested otherwise.

The 2025 Delhi Assembly election, despite being fought largely on issues concerning women: ranging from safety to economic welfare, had strik-

ingly poor women's representation. Only 5 of Delhi's seventy seats were won by women - a mere 7.14 percent representation in the assembly. It gave us a sharp realist lens on the ineffectiveness of campaign narratives on women's empowerment and represen-

Among the five elected women in Delhi, four belong to the BJP: Rekha Gupta (Shalimar Bagh), Poonam Sharma (Wazirpur), Neelam Pahalwan (Najafgarh), and Shikha Roy (Greater Kailash). The sole woman legislator from the Aam Aadmi Party ('AAP') is Atishi, the former Chief Minister, who contested and won from the Kalkaji constituency.

Throughout the Delhi elections, all the major political parties aggressively tussled over wooing women voters. AAP, BJP, and the Congress all promised cash-transfer schemes targeted specifically at women.

AAP pledged ₹ 2,100 per month for women in Delhi, while both BJP and Congress went a step further, offering ₹ 2,500 per month if voted to power. This trend of competitive populism underscores the mistreatment of women within an electorate merely as a voting demographic, and not as stakeholders in electoral contests.

Despite rhetorical commitments to women's welfare, each of the parties were reluctant to field women as candidates. BJP, which contested 68 seats, allocated only 8 tickets to women, a



meagre 11.76 percent. AAP, contesting all 70 seats, nominated just 9 women (12.85 percent), while Congress also fielded just 9 women candidates. These figures clearly depict patriarchal arrangements within party structures, where women are continued to be considered political liabilities

The distribution of women candidates across constituencies is also revealing. In 21 of Delhi's seventy seats, which is thirty percent of the total, there was not a single woman candidate, neither party affiliated nor independent. Across twenty constituencies, only one woman contested and one won. This systemic exclusion from political competition raises serious concerns about the structural barriers that continue to limit women's access to legislative and executive roles. This consistent underrepresentation of women in candidate selection provides a broader reflection of the inherent patriarchy of political institutions in the country.

Nearing the close of his second term. Prime Minister Narendra Modi and his cabinet passed the Women's Reservation Bill, a landmark legislation aimed at reserving one-third of seats in the Parliament, state assemblies, and the Delhi Assembly for women. The bill presented the opportunity for a historic shift toward gender parity in Indian politics, with both the BJP and Congress initially competing to claim credit for initiating this long-overdue of the five elected women to the Delhi

mediate implementation remains absent. The electoral outcomes following its passage reveal the gap between legislative promises and political action.

The 2024 Lok Sabha elections, held after the bill's passage, saw only 74 women elected to the 18th Lok Sabha—just 13.6 percent of the total seats. This marked a decline from the 17th Lok Sabha, where women occupied 14.4 percent of seats. This number falls significantly short of the promised 33 percent quota, which will only come into effect after the next delimitation exercise, making its actual implementation uncertain in the near future. If major political parties were truly committed to women's representation, they would have proactively increased the number of women candidates in both national and state elections—including Delhi.

In the 17th Lok Sabha proceedings, two Members of Parliament (Asaduddin Owaisi and Imtiaz Jaleel from AIMIM) voted against the Women's Reservation Bill, due to the lack of OBC sub-categorisation in the bill. Owaisi argued that the bill, inevitably, would only set aside seats for Savarna women, while women from backward classes and Muslim communities would not benefit under any quota.

The Delhi Assembly elections perfectly exemplified this concern. None assembly belonged to a marginalised or minority community. There was no woman victor in any of the twelve seats reserved for Scheduled Caste candidates.

Thus, as the Delhi Assembly elections have demonstrated, major political parties continue to struggle with actively considering and presenting women as viable electoral candidates. When they are elected, there is no representation from marginalised commu-

Legally, the promise of a 33 percent reservation for women is now embedded within the constitutional framework, but the timing of its implementation remains uncertain, tied to the yet-to-be-determined delimitation process. The effectiveness of the law will ultimately depend on political will—whether parties genuinely commit to ensuring representation beyond tokenism. Unless systemic barriers such as internal party biases, financial constraints, and patriarchal gatekeeping are addressed, women's political participation will remain largely sym-

For gender parity in Indian politics to transition for law to life, it would be essential to improve women's qualitative representation in electoral politics - by candidate selection processes, actively promoting women in leadership roles, and ensuring that marginalized women are not excluded from the structures of power. # **Effective methods** for facial hair removal



ll women have light coloured body and facial hair, but some of it is thicker and grows faster than others. Generally, around 10% of women battle the problem of extensive, coarse and dark facial hair

Every woman wants to look beautiful, soft and smooth without any dark hair on face or other parts of body skin. The various products available in the market to get rid of thick facial hair can be expensive and irritate skin due to harsh chemicals.

There are many easy and safe methods to remove facial hairs though it



Mix a tablespoon of honey, lemon juice each with five tablespoons of potato juice. Meanwhile, grind the lentils (soaked overnight) to a smooth paste. Add all the ingredients and apply the mixture for about 20 minutes on the affected area. Wash it off once it is completely dry. This paste makes a thin crust that helps in hair removal. Plus, potatoes help in bleaching the hair, making them less

An effective and common facial hair removal method is threading. It is useful for shaping the eyebrows and also for removal of facial hair on areas like the upper lip and chin. There may be slight redness after threading, which reduces in a day. It is a popular method of hair removal. Tweezing is another method, where one hair is removed at a time. It is a suitable method for shaping the eyebrows, or to remove solitary hairs

from the chin area, or eyebrows. However, a word of caution – hair from a mole must not be removed without consulting a doctor.

Waxing can also be used for facial hair removal. Soft, strip waxing is useful. Roll on waxing kits are also available. It is said to be a breakthrough technology that may be used for facial hair. It is becoming popular

as it is easy to use and also more hygienic. The results are also said to be longer lasting. This relatively new method has a roll-on applicator, which is placed in a device that heats the product, but at a low temperature. It is then rolled on the area and removed with a strip. It is said to be useful in removal of short facial hair.

Hair removal by laser is becoming increasingly popular as a permanent method. Laser produces an intense beam of light, which is absorbed by the hair follicles. The laser disables the hair follicle's ability to produce hair. The heat produced by the laser light is controlled by the operator. A strong laser light leads to more heat. That is why cooling devices are used to prevent damage to the rest of the skin. The advantage of a laser is that the laser light can scan broader areas. Therefore, fewer sessions may be required. It should be done under supervision of a doctor. The temporary known side effects are redness, swelling and itching. The main risk in laser treatment is the possibility of skin burns, due to excessive heat of the laser light. Regrowth occurs in some cases, but is slower and scantier. It is very important to find a good laser clinic. So, before choosing the clinic, it is essential to find out its reputation, by making enquiries and talking to people who have been through the treatment. It is an expensive procedure and one should also discuss the approximate number of sessions that may be needed.

Laser can be used to remove hair from the entire face, or from particular areas, like upper lips, chin or cheeks. The time taken for the actual treatment is not much. ## A New Era or a Political Token? Rekha Gupta and the legacy of women CMs in Delhi

The appointment of first-time MLA Rekha Gupta as the Chief Minister of Delhi has not only been a surprising political move but has also reignited discussions on the role of women in Indian politics. With the Bharatiya Janata Party (BJP) presenting this decision as a testament to Prime Minister Narendra Modi's emphasis on 'Nari Shakti' (women's empowerment), the elevation of Rekha Gupta is being positioned as both a reward for female voters and a symbolic stride toward greater gender representation in governance. However, this decision also highlights the broader and more complex landscape of women in Indian politics—one where gender representation remains scarce and dynastic politics continues to dominate.

The Dismal Reality of Women's Representation

Despite comprising nearly 50% of the voting population, women remain significantly underrepresented in Indian politics, particularly in leadership positions. Rekha Gupta is only the second woman CM from the BJP since 2014, after Anandiben Patel in Gujarat, and currently the only woman heading a government among the 20 BJP/NDA-ruled states and Union Territories. This dismal record stands in contrast to India's early strides in women's political leadership, exemplified by Indira Gandhi's rise as Prime Minister in 1966—a milestone that predated similar advancements in utive victories, only to be unseated many Western democracies. Yet, in 2013 by the rise of Arvind Ke-

over the decades, the broader narrative of women in power has remained largely limited to elite, anglicized figures with privileged access to political corridors, rather than an inclusive representation across socioeconomic classes.

The Political Transformation of Women Leaders

While gender has played a significant role in shaping political narratives, it has often been intertwined with dynastic politics. A cursory look at the women MLAs and MPs in India reveals a disproportionately high number of dynastic politicians, suggesting that working-class women still struggle for equitable access to political power. Nevertheless, women leaders who have managed to break through the ranks have left an indelible mark on India's political landscape.

Sheila Dikshit's tenure as Delhi's longest-serving Chief Minister remains a testament to the transformative potential of women leaders. When Sonia Gandhi took over the Congress presidency in 1998, she was in store confidence within the party, which had suffered electoral setbacks under Sitaram Kesri. The Delhi Congress unit was in disarray, and choosing Sheila Dikshit as the CM candidate was a bold move. Her governance—centered on urban development, infrastructure expansion, and public welfare—reshaped Delhi into a modern metropolis. She successfully led Congress to three consecjriwal's Aam Aadmi Party (AAP). Similarly, Sushma Swaraj's brief tenure as Delhi's CM in 1998 was marked by the BJP's efforts to regain political ground, though she was unable to withstand the political wave driven by soaring onion prices and Sheila Dikshit's middle-class appeal. Later, Atishi's elevation within AAP signaled another attempt to capitalize on women's representation, but her political ascent was overshadowed by Kejriwal's dominance within the party. These instances illustrate a recurring pattern women leaders being positioned strategically but often lacking full

autonomy to shape political trajec-Rekha Gupta's Challenge: Symbolism or Substance? Rekha Gupta's rise to the posi-

tion of CM, despite her being a first-time MLA, raises pertinent questions about whether this move is purely symbolic or whether she can carve a substantive leadership legacy. Her apundoubtedly pointment strengthens the BJP's narrative on women's empowerment, but the real challenge lies in governance. She inherits a city grappling with severe pollution, an ailing Yamuna River, and growing infrastructural demands. Unlike Sheila Dikshit, who had the advantage of a strong political foundation and administrative experience, Rekha Gupta faces the daunting task of establishing credibility while contending with Delhi's deeply entrenched polit-

ical battles. Her trajectory could follow multiple paths. She might struggle, much like Sushma Swaraj and Atishi, whose leadership was either too short-lived or overshadowed by party hierarchies. Alternatively, she could emerge as a transformative figure akin to Sheila Dikshit, proving that her appointment was not just a political maneuver but a genuine effort to foster competent female leadership in Indian politics.

The Road Ahead: Breaking the Glass Ceiling

Despite India's historical precedence in electing women to powerful positions, systemic barriers remain firmly in place. Women in politics still battle structural inequalities, tokenism, and the challenge of breaking free from the shadows of male political heavyweights. The key to lasting change lies in moving beyond mere symbolic appointments and fostering an environment where competent female leaders have genuine agency and decisionmaking power.

For Rekha Gupta, the challenge is clear—will she be remembered as a mere political placeholder, or will she rise to leave a legacy akin to Sheila Dikshit? The answer will not be determined by her gender alone but by the policies she implements, the governance she delivers, and the trust she builds with Delhi's citizens. In a political landscape still dominated by men, her tenure will serve as a litmus test for whether India is truly ready to embrace more women in positions of power beyond just optics and electoral convenience. ## An important change in education is the increasing number of women teachers

ccording to the UDISE+ 2023-24 report, women now comprise 53.34 percent of Indian school teachers, reflecting their growing role in education. In higher education, only 43% of faculty are women, with their representation in leadership roles even lower. Gender equality in academia is still hindered by ingrained biases, professional barriers, and institutional constraints. Increasing the percentage of women in India's teaching workforce represents a paradigm shift in the quality of education, inclusiveness, and social equality. Gender biases in pedagogy are challenged, inclusive education is promoted, and female teachers increase the number of female students. To ensure wider student participation, female teachers encourage greater classroom participation and gender-sensitive teaching. According to a 2022 UN-ESCO report, inclusive participation is 20% higher in classrooms run by women. By addressing social barriers and safety concerns, the presence of female teachers enhances educational opportunities for girls. The increase in the number of female teachers ed to a significant increase in female enrollment in Bihar's Kanya Utthan Yojana. By normalizing conversations about gender roles, child marriage, and menstrual hygiene, female teachers promote equality. Under the Udaan scheme, adolescent girls are encouraged to seek guidance from female teachers. Female teachers are more likely to provide emotional support, improving student well-being.

Significant gender disparities in higher education faculty positions are due to the low representation of female faculty members. According to the All India Survey on Higher Education, despite a higher number of men holding teaching positions, women constitute only 43% of higher education faculty. Women faculty representation in IITs and NITs is still less than 20%, reflecting gender disparities in elite universities. Women's role in academic leadership is limited to the associate professor and profes-

sor level, where their percentage drops sharply. Less than 25% of full professors in public universities are women, which limits their ability to influence decisions. Less than 10% of vice-chancellors in India's top 50 universities are women. Due to socio-cultural barriers, women's participation is higher in southern states such as Kerala and Tamil Nadu, while it is lower in rural and north Indian universities. More than half of the professors in Kerala's public universities are women, while the percentage is less than 30% in Bihar and Rajasthan. Women are less likely to take up leadership roles due to unconscious biases in appointments and promotions. Academic women often lack the mentorship and strong professional networks necessary for research opportunities and career advancement. Many women take career breaks due to the dual responsibility of household chores, which impacts their advancement and research prospects.

Ensuring equal career advancement opportunities, establishing gender quotas, ensuring fairness of selection committees, and implementing clear promotion standards By mandating 40 percent female representation on academic appointment committees, Germany's DFG program encourages more women to enroll in higher education. Increasing women in academia's access to mentorship and networking opportunities: Establishing formal mentorship programs to connect female faculty members with senior academics, advising on funding opportunities, research, and leadership development. As evidence of the value of focused mentorship and support networks, the US "Women in Science and Engineering" program has been instrumental in increasing the number of women in leadership roles. Promoting work-life balance, providing on-campus child care services, increasing paid maternity leave, and implementing flexible tenure paths helps female faculty members continue their research careers by providing a one-year tenure extension after maternity. Providing special funding to improve the

administrative and academic visibility of women and running leadership development courses for them, India's "Women Scientists Scheme" helps women researchers return to academia after a career break by providing funding. Women make up only 43% of higher education faculty, limiting their influence outside the classroom. The percentage of women faculty in IITs and IIMs is less than 20%. UGC's Gender Advancement for Transforming

Institutions (GATI) program encourages women faculty to take up leadership positions. Establish equal pay guidelines, enforce labor laws more stringently, and regularize contract teachers. Strong enforcement of the Equal Remuneration Act 1976 is essential in private education. Improve campus safety protocols, transport options, and grievance procedures. The establishment of women's safety measures in educational institutions has been funded by the Nirbhaya Fund (2013). A gender-balanced teaching staff will reduce feminization in early education and normalize caregiving responsibilities. In early childhood education, Finland and Sweden aggressively encourage the recruitment of men. Establish anonymous grievance redressal procedures, ensure that internal complaints committees (ICCs) are functional, and implement stringent antiharassment policies in all universities. ICCs are mandatory in universities as per the UGC's 2023 directive; however, there are still gaps in implementation, especially in smaller and rural institutions. Strong mentoring programs, inclusive hiring practices, institutional change, and multi-pronged strategies are needed to reduce the gender gap in academia. Promoting family-friendly workplaces, guaranteeing transparent promotions, and strengthening anti-discrimination laws can help empower women in higher education. A paradigm shift toward gender-sensitive, merit-based policies will improve representation and strengthen India's economy. Needless to say, a hair removing cream should be patch-tested before use. This is done by applying it on the inner arm. If there is a reaction within 10 to 15 minutes, it should not be Home remedies do not remove hair,

but may lessen growth over a period of time. Make a thick paste of sugar, lemon juice and water and apply it in the direction of hair growth. Wash off when it dries. Apply it once or twice a week. Or, 3 teaspoons of powdered barley can be mixed with one teaspoon cold milk and 2 to 3 teaspoons lemon juice. Apply and leave on for 20 minutes and then rinse off with water. Do this two to three times a week. It is said to discourage hair

# EU ponders 800 billion euro plan to beef up defences to counter possible US disengagement

of the European Union's executive on Tuesday proposed an 800 billion-euro (USD 841 billion) plan to beef up the defences of EU nations, aiming to lessen the impact of potential US disengagement and provide Ukraine with military muscle to negotiate with Russia following the freeze of US aid to the embattled nation.

European Commission President Ursula von der Leyen said the massive "REARM Europe" package will be put to the 27 EU leaders. They are holding an emergency meeting in Brussels on Thursday following a week of increasing political uncertainty from Washington, where President Donald Trump questioned both his al-

liance to the continent and the

defence of Ukraine. "I do not need to describe the grave nature of the threats that we face," von der Leyen said. Her plan had already been in the works before Trump's decision early Tuesday to pause military aid to Ukraine. Key to the quandary of EU nations has been an unwillingness to spend much on defence over the past decades as they hid under the US nuclear umbrella and were hurt by a sluggish economy, which creates challenges for a quick ramp-up of such spending. KYIV, March 4: Ukrainians woke up on Tuesday to news that the Trump administration has paused military aid for their fight against Russia's invasion, days after a disastrous Oval Office row that has deepened a rift between Kyiv and the White House.

US President Donald Trump directed the US to pause all assistance to Ukraine as he seeks to pressure Ukrainian President Volodymyr Zelenskyy to engage in peace talks with Russia.

The decision appears to halt arms deliveries approved under the Biden administration, but it was not clear whether deliveries of ammunition for weapons systems already in Ukraine would be affected.

"I feel betrayed, but this feeling is not really deep for some reason. I was expecting something like that from Trump's side," said a Ukrainian soldier fighting in Russia's Kursk region, where Ukraine sion in August 2024 to improve its hand in negotiations.

The soldier spoke on condition of anonymity to speak freely about his thoughts as he was not authorised to speak to the press.

Other said the move has left even greater confusion about Donald Trump's intentions.

"The problem is that it's unclear what Trump wants and what the purpose of his actions is," said Oleksandr Merezhko, Ukrainian lawmaker and chair of the Foreign Affairs Committee.

"As of today, it appears that he is increasingly siding with Russia and trying to pressure Ukraine into accepting Russia's demands.'

"This looks terrible — forcing the weaker side to accept the terms of the stronger aggressor," he told The Associated Press.

Kyiv has feared the possibility of aid being stopped to Ukraine ever since Trump took office, and the US-Ukraine relationship has taken a downturn in recent weeks as Trump's team launched bilateral talks with Russia over the war in Ukraine and Trump's demeanour toward Zelenskyy has become in-

creasingly dismissive. Russia's state RIA Novosti news agency quoted Andrei Kartapolov, a retired general who chairs the defence committee in the lower house of Russian parliament, predicting that Ukraine would exhaust its current ammunition reserves within months. "We need to keep up the pressure and continue to target their bases and depots with long-range precision weapons to

destroy the stockpiles," he said. Trump said on Monday that he is still interested in signing a deal that would hand over a share of Ukraine's minerals to the United States, an agreement that Zelenskyy has also said he is ready to sign. "By abruptly halting military assistance to Ukraine, President Trump is hanging Ukrainians out to dry and giving Russia the green light to continue marching west," said Razom for Ukraine, a Ukrain-

ian advocacy group.
"Razom for Ukraine urges the White House to immediately reverse course, resume military aid and pressure Putin to end his horrific invasion." (AP)

Most of the money Von der Leyen is talking about, would come from loosening the fiscal constraints the EU puts on budgetary spending to "allow member states to significantly increase their defense expenditures without triggering" punishing rules aimed at keeping deficits from going too far into the red.

It would help member states to spend on defense without being forced to cut into social spending purely to keep within EU rules.

"So if member states would increase their defense spending by 1.5 per cent of GDP on average, this could create fiscal space of close to 650 billion euros (USD 683 billion) over a period of four years," von der Leyen said.

This would be topped up by a loans programme, controversially backed by the common EU budget, of 150 billion euros (USD 157 billion) to allow member states to invest in defence.

She said military equipment that needs to be improved includes air and missile defence, artillery systems, missiles and ammunition, drones and anti-drone systems and cyber preparedness.

Such a plan will force many EU member states to greatly increase their military spending, which is still below 2 per cent of gross domestic product. NATO Secretary-

General Mark Rutte has told the member states they need to move to more than 3 per cent as quickly as possible. The plan will now be the blueprint for Thursday's summit, although immediate decisions beyond strong commitments were

Von der Leyen hopes her plan will aid Ukraine

Von der Leyen said her plan would also help Ukraine as it struggles now, especially with any joint purchase of military materiel. "With this equipment, member states can massively step up their support to Ukraine," she said.

have proven again and again that there are no fundamental clashes of interest or geopolitical conflicts between China and Europe; rather, they are partners that contribute to each other's success," Lou said.

China wants to scale up its ties with the EU, which it regards as a lucrative market for Chinese products, particularly its AI-compatible e-vehicles and batteries.

The EU has clamped hefty tariffs on Chinese e-vehicles to protect the indigenous models.

China is also looking to cash in on the sharp turnaround in strategic alliances after the recent disastrous meeting between Zelenskyy and Trump, casting a shadow over the close US-EU ties.

The EU leaders rallied behind

meeting with Trump, following which he was asked to leave the White House.

The meeting videos were played up heavily by the state-run Chinese media outlets. "China-Europe relations are not targeted at, dependent on, nor subject to any third party,' Lou said in a veiled reference to the US-EU ties. The Trump-Zelenskyy fallout was a tricky moment for China as while pressuring Ukraine to settle for ending the war, the US President is also warming up to his Russian counterpart Vladimir Putin, a close ally of Chinese leader Xi Jinping.

There is lingering concern in Beijing over the emerging rapprochement between Trump and Putin over ending the Ukraine war.

Xi and Putin share a close alliance built over the years to ward off threats from the US and its allies. On March 1, Putin dispatched his top security official Sergei Shoigu to Beijing to brief Xi about Moscow's current talks with Washington to end the Ukraine war.

In his talk with Shoigu, Xi has underlined the need to carry on the core spirit governing China-Russia relations in the new era featuring good-neighbourliness, comprehensive strategic coordination, and mutually beneficial cooperation for win-win results. (PTI)

## US tariffs on Canada, Mexico take effect Investigators will question driver who allegedly as China takes aim at US farm exports

WASHINGTON, March 4: President Donald Trump's long-threatened tariffs against Canada and Mexico went into effect Tuesday, putting global markets on edge and setting up costly retaliations by the United States' North American allies.

Starting just past midnight, imports from Canada and Mexico are now to be taxed at 25 per cent, with Canadian energy products subject to 10 per cent im-

The 10 per cent tariff that Trump placed on Chinese imports in February was doubled to 20 per cent, and Beijing retaliated Tuesday with tariffs of up to 15 per cent on a wide array of US farm exports.

It also expanded the number of US companies subject to export controls and other restrictions by about

Canadian Prime Minister Justin Trudeau said his country would slap tariffs on more than USD 100 billion of American goods over the course of 21 days. Mexico didn't immediately detail any retaliatory

The US president's moves raised fears of higher inflation and the prospect of a devastating trade war even as he promised the American public that taxes on imports are the easiest path to national prosperity. He has shown a willingness to buck the warnings of mainstream economists and put his own public approval on the line, believing that tariffs can fix what ails the country.

"It's a very powerful weapon that politicians haven't used because they were either dishonest, stupid or paid off in some other form," Trump said Monday at the White House. "And now we're using them."

The Canada and Mexico tariffs were supposed to begin in February, but Trump agreed to a 30-day suspension to negotiate further with the two largest US trading partners.

The stated reason for the tariffs is to address drug trafficking and illegal immigration, and both countries say they've made progress on those issues. But Trump has also said the tariffs will only come down if the US trade imbalance closes, a process unlikely to be settled on a political timeline.

The tariffs may be short-lived if the US economy suffers. But Trump could also impose more tariffs on the European Union, India, computer chips, autos and pharmaceutical drugs.

The American president has injected a disorienting volatility into the world economy, leaving it off bal-



"It's chaotic, especially compared to the way we saw tariffs rolled out in the first (Trump) administration," said Michael House, co-chair of the international trade practice at the Perkins Coie law firm. "It's unpredictable. We don't know, in fact, what the president will do."

Democratic lawmakers were quick to criticize the tariffs, and even some Republican senators raised Sen. Susan Collins, R-Maine, said she's "very con-

cerned" about the tariffs going into effect because of her state's proximity to Canada. "Maine and Canada's economy are integrated,"

Collins said, explaining that much of the state's lobsters and blueberries are processed in Canada and then sent back to the US.

The world economy is now caught in the fog of what appears to be a trade war. Even after Trump announced Monday that the tariffs were going forward, Canadian officials were still

in touch with their US counterparts. 'The dialogue will continue, but we are ready to respond," Canadian Defence Minister Bill Blair said in Ottawa as he went into a special Cabinet meeting on US-Canada relations. "There are still discussions tak-

Shortly after Blair spoke, Trudeau said Canada would impose 25 per cent tariffs on USD 155 billion Canadian (USD 107 billion US) worth of American goods, starting with tariffs on USD 30 billion Canadian (USD 21 billion US) worth of goods immediately and on the remaining amount on American products in three weeks.

"Our tariffs will remain in place until the US trade action is withdrawn, and should US tariffs not cease, we are in active and ongoing discussions with provinces and territories to pursue several non-tariff measures," Trudeau said. (AP)

# rammed car into crowd in Germany, killing 2

March 4: Investigators on Tuesday will question a driver who allegedly rammed a car into a crowd in the southwestern German city of Mannheim, killing two people and injuring 11.

Andreas Stenger, head of the State Criminal Police Office, told German news agency dpa that police hope the interview with the perpetrator will lead to information about a motive for Monday's attack. Mourners left flowers in the city's centre to honour the victims.

The suspect is a 40-year-old German man from the nearby state of Rhineland-Palatinate who was detained and is in a hospital after being injured, State Interior Minister Thomas Strobl of Baden-Württemberg, which includes Mannheim, told dpa on Monday.

Strobl later told reporters in Mannheim that "as far as the specific motivation of the crime is concerned, we have no indication of an extremist or religious background at the moment. The motivation could rather be based in the person of the perpetrator himself". German police and prosecutors

said Monday at a joint news conference that the driver intentionally rammed his car into people and is being investigated for murder and attempted murder. Five of the 11 injured were seriously wounded.

Police and prosecutors said the driver shot himself in the mouth when he was arrested and had to undergo medical treatment at a hospital. While the driver did not seem to be ideologically motivated, prosecutors said that the man, whose identity was not revealed in line with German privacy rules, has several previous convictions.

He served a short prison sentence for assault more than 10



years ago, and was convicted for drunken driving. He had also been investigated for a hate speech offense on Facebook in 2018, for which he was fined, prosecutors said without giving further details.

Investigators are also looking into the possibility that the driver may suffer from psychological problems. Cars have been used as deadly weapons in several acts of violence in recent months in Germany. Police said earlier that "indications of a second perpetrator cannot be confirmed at this stage of the investigation". They said there was no more danger to the public.

Police spokesperson Stefan Wilhelm said a vehicle drove into people on Paradeplatz, a pedestrian street downtown, around noon, when workers come out for lunchbreaks. Local media reported a carnival market was taking place, meaning more visitors than usual in Mannheim, which has a population of 326,000. Mannheim University Hospital said they were treating three people, two adults and a child, dpa reported. The other wounded people were taken to different hospitals in the region. Images from the scene showed

presence. Officers gathered round a badly damaged black car.

Friedrich Merz, who likely will become Germany's next chancellor, wrote on X that "the incident as well as the terrible acts of the past few months — is an urgent reminder that we must do everything we can to prevent such acts".

Outgoing Chancellor Olaf cholz wrote on X that "we mourn with the families of the victims of a senseless act of violence"

Last month, a 2-year-old girl and her mother died two days after they were injured in a car-ramming attack on a union demonstration in Munich. A 24-year-old Afghan man who came to Germany as an asylum-seeker was arrested, and prosecutors said he appeared to ave an Islamic extremist motive.

Last year, six people were killed and more than 200 injured when a car slammed into a Christmas market in the eastern city of Magdeburg. The suspect, who was arrested, is a 50-year-old doctor originally from Saudi Arabia who had expressed anti-Muslim views and support for the far-right, antiimmigrant Alternative For Ger-

#### **Economy, AI likely to be among** top issues for China's legislature BEIJING, March 4: Harnessing the power of artificial intelligence and

shoring up the economy are among the issues expected to top the agenda when China's legislature meets Wednesday in Beijing. Almost 2,900 delegates have arrived in Beijing for the annual session

of the largely rubber-stamp parliament, the National People's Congress. Concomitantly, an advisory body of business leaders, athletes and academics, the Chinese People's Political Consultative Conference, convened Tuesday. The two bodies' concurrent meetings are known as the Two Sessions. The week-long parliamentary session, though largely ceremonial, helps to signal government priorities for the year.

Premier Li Qiang is expected to announce an economic growth target of around 5 per cent, in line with the past couple of years.

The meetings come as China's economy struggles with sluggish consumption, a lengthy property crisis, ballooning government debt and a possible renewed trade war with the United States. On Tuesday, Beijing announced additional tariffs of up to 15 per cent on imports on US farm products including chicken, pork, soy and beef. The move came in retaliation for an increase in flat US tariffs on Chinese products - from 10 per cent to 20 per cent – that came in effect at the same time.

"Undoubtedly, the adverse impacts brought by the external environment have deepened, and China's economy still faces some difficulties and challenges," said Lou Qinjian, spokesman for the National People's Congress in a news conference ahead of the session.

"Internationally, rising economic and political uncertainties make it harder to stabilise external demand. Domestically, demand is insufficient, and some enterprises are experiencing operational difficulties," he added. The government is expected to announce some measures to boost consumption such as increasing the deficit ratio from 3 per cent to 4 per cent,

though massive stimulus is unlikely. Harnessing the power of artificial intelligence may also feature in policy announcements. Lou described China's breakthrough DeepSeek AI model, unveiled earlier this year, as an example of the country's "innovative and inclusive approach to technology". (AP)

WASHINGTON, March 4: Uber will shift into a new gear in Austin, Texas, on Tuesday when its ride-hailing service will begin dispatching self-driving cars to pick up passengers.

The autonomous option is being provided through a partnership that brings together Uber and robotaxi pioneer Waymo, which already sells self-driving vehicle rides through its own app in Phoenix, San Francisco and Los Angeles. Waymo is now trying to expand

into more cities by teaming up with Uber — an alliance that was announced last September. The partnership begins in Austin and will, later this year, expand to

offer robotaxi rides in Atlanta. Waymo's robotaxis will be hitting the streets of Austin ahead of Tesla CEO Elon Musk's goal of launching a fleet of electric selfdriving cars later this year.

Uber's proven platform, we're ready to bring you the ride of the future, today," Uber crowed about the robotaxis coming to Austin.

Although there is no way passengers can guarantee that a ride ordered through Uber's app in Austin will be provided by one of Waymo's robotaxis, they can increase their chances of getting a self-driven car by going into their settings and turning on the autonomous vehicle preference.

When it sends a Waymo car to pick up a passenger, Über's app will send a notification that the ride will be provided by a self-driving car while also offering the option to switch to a human-controlled vehicle instead.

Originally started as a secret project within Google, Waymo has been making major inroads since its robotaxis first began charging for rides in Phoenix nearly five vears ago.

Waymo's robotaxis are now averaging 200,000 paid rides per week, up from about 10,000 weekly rides two years ago, according to a recent post by Alphabet CEO Sundar Pichai, who runs

the Mountain View, California, company that owns Google as well as Waymo.

After expanding into Austin and Atlanta this year as part of the Uber partnership, Waymo also plans to begin offering rides in Miami next year through its own app, mirroring how it already runs its service in Phoenix, San Francisco and Los Angeles.

Waymo, so far, has avoided a major traffic accident or other safety problems that might give regulators second thoughts about allowing its robotaxis to remain on the road.

Automaker General Motors tried to compete against Waymo in San Francisco with a robotaxi service operated by its Cruise subsidiary, but had its California license suspended in October 2023 after one of its self-driving cars dragged an injured pedestrian about 20 feet before coming to a

Uber also struck a deal last year to eventually deploy Cruise's robotaxis in cities that were never identified before General Motors pulled the plug on its fleet of selfdriving cars. (AP)

# Mizoram govt presents ₹15,198 cr budget

Lalduhoma on Tuesday presented a ₹ 15,198.76 crore budget for 2025-2026 and announced a 75 per cent increase in fund allocation for the flagship 'Bana Kaih' (Handholding) scheme, a financial assistance programme for farmers and small

He said the government will introduce a scheme from April to provide health insurance of up to ₹ 5 lakh cover per year to beneficiaries.

The chief minister, who also holds the finance portfolio, also presented supplementary demands for grants for the current fiscal (2024-25) amounting to ₹ 3,512.33 crore.

There was no proposal for levying new taxes

Presenting the annual budget and supplementary demands in the assembly, Lalduhoma said the government gives priority to the state's flagship programme "Bana Kaih" scheme and allocated ₹ 350 crore for the 2025-26 fiscal, a 75 per cent increase from ₹ 200 crore earmarked in the current fiscal.

The Bana Kaih scheme was launched in September last year and aimed at providing financial assistance and support primarily to entrepreneurs

and farmers ("progress partners") through targeted programmes designed to promote economic growth and self-sufficiency.

One of the key components of the scheme is handholding to progress partners(beneficiaries), under which the government provides financial support and offers loans up to ₹ 50 lakh to beneficiaries through partner banks.

Under this scheme, the state government introduced support prices for key crops - ginger, turmeric, Mizo chilli and broomsticks.

Lalduhoma said that his government would continue to purchase the four agricultural crops from the farmers in the next financial year.

He said that the government also prioritise the health sector and will introduce a universal scheme from April to provide health insurance of up to ₹ 5 lakh cover per year to beneficiar-

The CM said that ₹ 50 crore has been allocated for the implementation of the proposed scheme and other healthcare-related infrastructure.

In his second budget speech after the Zoram People's Movement (ZPM) came to power in December 2023, Lalduhoma said that Mizoram aims to capitalise on the opportunities arising

from the country's rapid ascent and grow alongside the nation towards the goal of 'viksit Bharat' and 'viksit Mizoram'.

"The total amount projected under revenue receipt and capital receipt for the financial year 2025-2026 is ₹ 15,198.76 crore, out of which ₹ 2,616.33 crore is expected from the state's own tax revenues and non-tax revenues and ₹ 10,331.28 crore from the Centre in the forms of share of taxes, revenue deficit grant, CSS and other grants," Lalduhoma said.

He said that the revenue expenditure for 2025-26 is estimated at ₹ 12,540.20, which is 82.51 per cent of the total budget and 4.88 per cent higher than the current fiscal estimate of ₹ 1,1957 crore.

The total fund earmarked for capital expenditure is ₹ 2,658.56 crore and it accounts for 17.49 per cent of the total estimated expenditure with an 8.29 per cent increase as compared to the current fiscal estimate of ₹ 2,455 core. he said.

While capital expenditure is meant mainly for the creation of assets and infrastructures for the public, enhancing productivity, employment generation and investment, the revenue expenditure penses, interest payments and power purchases, among others.

On the size of the state economy, Lalduhoma said that the GSDP is estimated to touch ₹ 36,088.82 core during the next financial year against ₹ 34,003.27 core in the 2024-25 fiscal.

He said that the government adopted a more realistic approach to calculate GSDP figures after recognising issues arising out of over-projected GSDP in the past.

With the new method of calculation, the GSDP for 2024-25 in Revise Estimate (RE) now stands at ₹ 34,0003.27 crore, reflecting a ₹ 14,034.25 crore decrease from ₹ 48,037.52 crore Budget Estimate (BE), he said.

"Although there is a significant decline in the projected GSDP figure, it does not mean that the economy is stalled and the state economy is projected to grow at 10.21 per cent in the next financial year," Lalduhoma also told a press conference after presenting the budget.

He said that the government would prioritise projects and infrastructure development plans funded by the Centre, which require a low share by the state. (PTI)

# EC's clarification on duplicate voter ID numbers a cover-up: TMC

namool Congress on Tuesday dismissed the Election Commission's clarifications on duplicate voter ID numbers as a "cover-up" and cited the poll panel's own guidelines to assert that two cards cannot have identical numbers.

The TMC on Monday called the duplication in EPIC (Electronic Electoral Photo Identity Card) numbers an "epic scam" and gave the poll panel a 24-hour deadline to "accept its mistake".

Party's Rajya Sabha MP Saket Gokhale on Tuesday shared on X excerpts from the 'Handbook For Electoral Registration Officers' to counter the poll panel's clarifications on the issue, which was first raised by TMC supremo and West Bengal Chief Minister Mamata Banerjee.

"Yesterday, the All India Trinamool Congress had given Election Commission of India 24 hours to admit and accept their blunder on the duplicate voter ID fraud issue. Clearly, the ECI, which has been exposed, wants to brazen it out," Gokhale said.

"The 'clarification' given by ECI (on Sunday) in response to CM Mamata Banerjee is actually a cover-up. They have admitted there's something wrong but are re-



fusing to accept it. The false 'clarification' given by the ECI contradicts its own rules and guidelines,"

He said the process of issuing the photo ID cards is laid down in the ECI's 'Handbook For Electoral Registration Officers'.

While the EC said photo ID cards with the same numbers were issued to multiple voters due to certain states using the same "alphanumeric series", Gokhale shared excerpts from the handbook and said it was impossible to do so as the Functional Unique Serial Numbers (FUSN) are different for every Assembly constituency.

"EPIC card numbers are an alphanumeric sequence of three letters and seven digits. The ECI handbook clearly states that the three letters, known as a Functional

Unique Serial Number (FUSN), are different for every Assembly con-

stituency," he said.

"Therefore, it is impossible for voters in two different assembly constituencies (even in the same state) to have the same first 3 letters on their EPIC. How is it then that the same EPIC numbers as voters in West Bengal have been allotted to random people in Haryana, Gujarat, and other states?" he said.

Countering the EC's clarification that even with two people having the same EPIC number, they can only vote in their respective constituency where they are enrolled, he said the voter is linked to his photo by the EPIC number.

"In photo electoral rolls, the elector is linked to his photo by the

voter in Bengal goes to cast their vote, their photo on the electoral roll will be different if the same EPIC number has been allotted to a person in another state.

"This will lead to the refusal of voting due to a photo mismatch. By allotting the same EPIC numbers in different states, voting can be denied to those who are likely to vote for non-BJP parties due to photo mismatch," he said.

He stressed that the EC rules mandate that the software used for issuing the photo ID cards keeps track of every used and unused number to ensure that the same EPIC number is not allotted to multiple people. Also, EPIC number links the details of voters with their photo and it is considered to be a 'permanent unique ID", he said.

"Therefore, it is impossible that any 'error' can lead to the same EPIC numbers being allotted to multiple people in different states. Also, since the EPIC number is linked to voter details, a duplicate EPIC number will lead to denial of voting," he said.

"This clearly reeks of a conspiracy to conduct voter suppression in favour of the BJP, where voters in non-BJP areas are being targeted by issuing their EPIC numbers to people in other states," he said. (PTI)

# Punjab: Many SKM leaders 'detained' ahead of planned Chandigarh sit-in

March 4: Several leaders of the Samyukta Kisan Morcha (SKM) were "detained" or put under "house arrest" after early Tuesday morning "raids" at their residences by the Punjab police ahead of their planned protest in Chandigarh on March 5.

Farmer leaders and opposition parties criticised the AAP government for the police action, which came a day after a meeting between Punjab Chief Minister Bhagwant Mann and SKM leaders ended abruptly with the CM walking out.

"The government cannot stifle the voice of farmers with such steps," Bharti Kisan Union (Lakhowal) general secretary Harinder Singh Lakhowal.

Apprehending police action, several farmer leaders have gone "underground", according to SKM

In Ludhiana, SKM leaders including Balbir Singh Rajewal, Harjit Singh Giaspura, Balwant Singh Khirnia, Avtar Singh Mahlo, Manmohan Singh Deol and Dilbag Singh were allegedly detained.

Ludhiana Deputy Commissioner Police Jaskaran Singh Teja said six farmer leaders were "detained".

Later, his supporters reached the police station and compelled the authorities to release him and drop him back at his residence.

He claimed that he had been placed under "house arrest", with at least three police personnel still deployed outside his house. (PTI)

### SP MLA Azmi's remarks on Aurangzeb rock legislature



MUMBAI, March 4: The issue of SP MLA Abu Asim Azmi's remarks eulogising Mughal emperor Aurangzeb rocked both houses of the Maharashtra legislature on Tuesday, with members of the ruling Mahayuti demanding his suspension and charging

him with treason. Both the houses were adiourned over the issue.

The development came on a day when the opposition Maha Vikas Aghadi planned to corner the government over the resignation of NCP minister Dhananjay

As proceedings of both the houses began, the Mahayuti members started raising slogans seeking action against Azmi, who is the Samajwadi Party's state president.

They claimed Azmi was a descendent of Aurangzeb, who tortured Maratha king Chhatrapati Sambhaji Maharaj and brutally killed him.

Deputy Chief Minister and Shiv Sena head Eknath Shinde led the attack on Azmi both in the legislative council and assembly.

In the council, the former CM said Azmi also made objectionable statements in the past against Maratha ruler Chhatrapati Shivaji Maharaj.

"Abu Azmi is purposely insulting Chhatrapati Shivaji Maharaj and (his son) Chhatrapati Sambhaji. Sambhaji's Maharaj's bravery and Aurangzeb's cruelty will give goosebumps to people," Shinde said in the council.

Aurangzeb tortured Sambhaji Maharaj in an inhuman way. Abu Azmi referred to Aurangzeb as an able administrator who built temples but he razed Kashi Vishveshwar temple, Shinde

The Mughal emperor not only killed Hindus but also people from other religions, the deputy CM said.

"Aurangzeb lost even after he won, but Sambhaji, through his bravery, won even even after his sacrifice. He (Aurangzeb) is a demon. Even a true Muslim will not forgive the progeny of traitors. It is wrong to eulogise Aurangzeb," Shinde said.

He also demanded that Azmi's membership of the legislative assembly be revoked.

No one will tolerate the act of eulogising Aurangzeb, the Shiv Sena leader said.

In the assembly, Shinde dubbed Azmi a "traitor" and said had no right to sit in the House. He asked SP MLA Raees

Shaikh to watch the recent Hindi film 'Chhaava', which has documented the bravery and sacrifice of Sambhaji Maharaj.

"See the torture Sambhaji Maharaj endured for 40 days. Aurangzeb asked him to change his religion," he said.

Praising Aurangzeb is an insult of the country's national heroes. Shinde said. Sambhaji Maharaj won 70

battles in nine years, he said, adding that Aurangzeb demolished temples and killed his own family. Industries Minister Uday

BJP national spokesperson Sudhanshu Trivedi also termed Azmi's remarks an "insult to the entire Indian society" and alleged that the opposition INDIA bloc constituents are engaged in a "cut-throat competition" with each other to prove themselves anti-Hindu for minority votes.

"This unwarranted and unwanted glorification of Aurangzeb, who was one of the most cruel and tyrannical rulers in history, is an insult to Indian society. This is an



old tendency of the Congress and 'INDI alliance'. Earlier their Rajya Sabha MP Imran Pratapgarhi had visited Aurangzeb's tomb and prayed," Trivedi told PTI Videos when asked for comment.

This makes it clear that they can "cross any limit and stoop down to any level" to carry forward their campaign to eradicate Sanatan Dharma, he charged. "This

"A minor girl raised her voice demanding the construction of a school building. It reached the

prime minister," he said. The National Conference leader said Prime Minister Modi acknowledged it in his 'Mann Ki Baat' program and promised that a school would be built.

"The prime minister promised that the school will be constructed. After hearing him, the entire administration rushed to the area with a promise to build a school there. Even after two years, that school is still a distant dream. It has not been constructed yet," he said. Taking a dig at the administra-

tion, he said, "If the administration can ignore a promise made by the prime minister himself, what hope does the common man have?" The National Conference

leader's remarks led to a heated exchange in the Jammu and Kashmir

Assembly, with the BJP members challenging him on what his own party had achieved in the past four months

He said every part of Jammu and Kashmir is far developed even though "we have never sought help from China, America, England or France to construct our roads."

The CM made the remarks the placate the opposition BJP and ruling National Conference members exchanging heated words over the development in Pakistan-occupied Kashmir (PoK).

"Whatever progress has been made in the areas across the border is because of the blessings of China," Abdullah said.

During question hour, NC MLA ind former minister Saifullah Mir in passing said that border infrastructure is better in PoK than on this side, even as he advocated for the construction of a tunnel to provide an all-weather connectivity to border areas of Keran and Jumagund in Kupwara district.

BJP's R S Pathania objected to his comparing the two sides.

NC MLA Nazir Gurezi and Peoples Conference legislator Saiad Gani Lone came in defence of Mir. who highlighted the challenges being faced by the locals, especially during the winter when snow cuts off roads for several months.

Speaker Abdul Rahim Rather ensured a smooth house proceeding, but BJP Pathania decried Mir's remarks.

Pathania told reporters outside the assembly, "He (Mir) praised a country with which we have no diplomatic relation. Our country did not send its cricket team there to play in the Champions Trophy and this is the country which is promoting separatism and terrorism in India. Mir's remark is of concern and condemnable and the

party's stand on it.'

During a discussion on Lt Governor's address while BJP member Sham Lal Sharma was speaking, Mir rose up from his seat and questioned Pathania for terming him a "traitor."

"My intention was not to draw a comparison between the two parts (of Kashmir). The National Conference is a party which has rendered the highest number of sacrifices for the country. Our workers, MLAs and ministers

were killed by terrorists," he said. Gurezi also stood up from his seat in defence of Mir and said "If someone had worn a coat, what is wrong when I say he is having a good coat," sending the house in a

commotion. Sensing the situation getting out of control, the chief minister requested the members to take up their seats, and said, "Gurezi is not wrong in his statement but he h not completed his talk."

Abdullah said, "All what has been done on the borders is for show off and that also was not done by them (Pakistan) on its own. Whatever progress was made in the border areas across the border was because of the blessings of China while there is no progress in the rest of the areas."

He said the development can be a matter of discussion but Mir who lives near the Line of Control, is not wrong in sharing what he sees.

"An effort like Vantara is truly commendable, a vibrant example of our centuries-old ethos of protecting those we share our planet with," he said, sharing pictures from his visit.


At Vantara, Modi said he saw an elephant which was the victim of an acid attack.

#### Bandh in parts of Beed after photos linked to sarpanch's murder go viral

CHHATRAPATI SAMBHA-JINAGAR, March 4: A 'bandh' was observed in parts of Maharashtra's Beed district on Tuesday after gory photographs related to the killing of sarpanch Santosh Deshmukh surfaced on

While Kej and Patoda in the district observed a total shutdown, some other parts witnessed partial bandhs, police

The development came on the day Maharashtra minister and NCP leader Dhananjay Munde resigned from the state cabinet, days after his close aide Walmik Karad was named as the mastermind in the sarpanch murder

"A bandh was observed in various parts of Beed. Patoda and Kej areas of the district saw a complete bandh. The police have deployed eight riot control units in sensitive areas of the district," a police official said.

"There is no additional force deployed in Massajog village (the native place of sarpanch Deshmukh). So far, nobody has been detained or arrested in connection with the bandh," he said.

Banners carrying the photographs of Dhananjay Munde were burnt in Kej with the protesters shouting slogans against the minister, the official said.

Deshmukh was abducted, tortured and murdered on December 9, last year, allegedly for attempting to stop an extortion bid targeting an energy company in the district.

The state Crime Investigation Department (CID) on February 27 filed a more than 1,200-page chargesheet at a court in Beed in Deshmukh's murder and two related cases.

As Deshmukh was tortured and killed, his assailants recorded 15 videos, clicked eight photos and even made two video calls. The videos and the photos are part of the chargesheet submitted by the CID before a court.

After these photographs surfaced on social media, various organisations gave a call for bandh to be observed on Tues-

Minister Munde's resignation followed a vociferous demand by the opposition for his removal from the cabinet. The demand intensified after gory photos and court chargesheet details related to the killing of Deshmukh surfaced, revealing the brutalities committed before

Three separate cases - murder of sarpanch, bid to extort money from Avaada company and asfirm - were registered at the Kej police station.

Seven persons have been arrested so far in the murder case and the police have invoked stringent Maharashtra Control of Organised Crime Act (MCOCA) against them. One of the accused is still at large. (PTI)

The protests erupted following campus violence on March 1, when two students, including Indranuj, were injured after a car in Basu's convoy allegedly grazed past them during a melee.

Basu himself sustained injuries when his car's windshield was damaged during the protest.

GOPESHWAR, March 4: Social activists have blamed the death of eight workers in an avalanche that hit a BRO camp at Mana in Uttarakhand's Chamoli district last week on "administrative negligence" and said the lives could have been saved had the authorities paid heed to a snowslide warning.

They also blame "reckless construction" works in avalanche-prone areas for the rise in snowslide inci-

The Chandigarh-based Defence Geoinformatics

Research Establishment (DGRE) issued an avalanche warning for a 24hour period at 5 pm on February 27 for places located above the height of 2,400 metres such as Uttarkashi, Chamoli.

Rudraprayag, Pithoragarh and Bageshwar districts of Uttarakhand.

The avalanche hit the Border Roads Organisation (BRO) camp in Chamoli between 5.30 am and 6 am on February 28, trapping 54 workers. While 46 of them were rescued alive, eight were found dead.

Atul Sati, a social worker and the convener of Joshimath Bachao Sangharsh Samiti said "administrative negligence" led to the death of the eight workers. "There was an avalanche warning and authorities should have acted on time," he said.

Following the incident, the Uttarakhand government issued an advisory for tourists staying in skiing destination Auli which has no history of avalanches, Sati said and alleged that it looks like an attempt to divert people's attention from the state's failure.

"When there was a warning and the authorities were aware that such a large number of workers were in Mana, why weren't they advised to move to safety?' asked another social activist.

The weather office in Dehradun issued a yellow alert for February 27, two days in advance, predicting isolated heavy rain and snowfall in locations situated at 3,500 metres and above. However, the State Emergency Operations Centre here alerted the district magistrates concerned on February 28 when the avalanche had already hit the camp.

Over the last four years, two dwelling units of BRO workers have been destroyed by avalanches in the Chamoli district alone. An avalanche in April 2021 de-

stroyed a settlement of workers in Niti Valley adioining the Indo-Tibet border, killing as many Experts feel that the

snowslides are a result of reckless construction being carried out in avalancheprone areas. Renowned MPS Bisht, an expert on

weather movements in the Kedar Valley, said the entire area is vulnerable to avalanches that keep coming from the Nar Parvat. Construction activities are being carried out reck-

Avalanches occur more during winters in the valleys of the upper Himalayan region where Badrinath and Mana are situated, but they can occur in any season in the snow-clad mountains.

Surveyors or mountaineers visiting these areas stay alert about such disasters. It is also true of the army and paramilitary forces. Winter defence posts are built at such places where the danger of avalanches is less, Kothiyal said. (PTI)

# ex-Sebi chief Buch, 5 others

MUMBAI, March 4: The Bombay High Court on Tuesday stayed for four weeks a special court's order directing FIR against former Sebi chairperson Madhabi Puri Buch and five other officials for alleged stock market fraud and regulatory violations, noting it was passed mechanically.

A single bench of Justice Shivkumar Dige said the special court order of March 1 also did not attribute any specific role to the accused in the matter.

"After hearing all the parties concerned and after going through the order of the special court, it appears that the order is passed mechanically without going into details and without attributing any specific role to the applicants (Buch and others)," Justice Dige

"Hence, the order is stayed till next date. Four weeks time is given to the complainant in the case (Sapan Shrivastava) to file his affidavit in reply to the petitions," the court said.

The HC's judgement came on petitions filed by Buch, three current whole-time Sebi directors Ashwani Bhatia, Ananth Narayan G and Kamlesh Chandra Varshney, Bombay Stock Exchange's Managing Director and Chief Executive Officer Sundararaman Ramamurthy and its former chairman and public interest director Pramod

Agarwal. The pleas sought quashing of the order passed by the special court directing the Anti-Corruption Bureau (ACB) to register an FIR against them pertaining to certain allegations of fraud committed in



1994 while listing a company on

the BSE. The pleas said the order was il-

legal and arbitrary. The special court had passed the order on the complaint filed by Sapan Shrivastava, a media reporter, seeking investigation into the alleged offences committed by the accused, involving large scale financial fraud, regulatory viola-

tions and corruption. Solicitor General of India, Tushar Mehta, appearing for the three Sebi officials, said there has been complete non-application of mind by the special court in passing

"Based on a vague and vexatious complaint, the special court has ordered an FIR. For something allegedly done in the year 1994, how can the current members of Sebi be held responsible," Mehta argued.

He claimed that complainant Shrivastava was an extortionist who was working under the garb of being a public spirited person.

Senior counsel Amit Desai, appearing for Ramamurthy and Agarwal, said to take such an action against senior members of the BSE was an "attack on the economy itself" especially on such frivolous allegations. (PTI)

## HC stays order directing FIR against Liquor shops near religious places in Uttarakhand to be shut down under new policy

DEHRADUN, March 4: The Uttarakhand government has approved a new excise policy for 2025-26 under which all liquor shops located near religious places in the state will be shut down.

Officials said licences granted earlier to liquor shops will be reviewed in the light of the new excise policy.

The state cabinet approved the new excise policy at a meeting chaired by Chief Minister Pushkar Singh Dhami on Monday.

It has been decided to cancel the liquor licences of shops near religious places and exercise more control on the sale of liquor, according paramount importance to public sensitivities, Secretary (home) Shailesh Bagauli said. The new policy makes the process for allotment of liquor shops more transparent and beneficial for local people by giving them self-employment opportunities in the sector, he said.

Lambert, in his speech, acknowledged VFX vendors DNEG and Wylie Co, who helped make the land of Arrakis, a fictional desert planet in which the film is set, a reality.

Malhotra, whose company has worked on the VFX of Oscar winners such as "Ex

Machina", "Blade Runner 2049", "First Man" and "Tenet" in the category, hopes Indian films open up in

a big way in the area. "Our artists and our capabilities are already ahead of what Indian filmmakers are using... We don't have enough big visual led effects projects here and that is where we are hoping to get to the next level."

Malhotra is hopeful there will soon be a time when Indian audiences and filmmakers "start to make visual effects a big part of their storytelling and vision".

"It's a matter of time... We will find that opportunity very soon.'

The Academy Award win for "Dune: Part Two" brought a feeling of validation because it comes from a "competitive group of the people who all have done incredible work", he said.

"To win these awards is pretty complicated. It's a feeling of relief and excitement because we have been validated yet again. There is a lot of joy and positive feeling among the teams across

Malhotra said he holds Villeneuve in high regard. They have earlier collaborated with

# Poorna Jagannathan on facing 'intense ageism' in Hindi cinema: They couldn't ever cast me

NEW DELHI, March 4: Actor Poorna Jagannathan, known for "The Night Of" and "Never Have I Ever", says she would have loved to work in more Hindi films post her debut with "Delhi Belly" but the intense ageism that she encountered left her feeling "underestimated".

The industry landscape has overhauled now due to the arrival of streaming services but when Jagannathan was in India, she said the filmmakers just couldn't place her in the right roles. "I felt like they couldn't ever cast me... When I landed in India, I was 40 years old, I had a child and they had no idea what to do with me or how to place me. The streaming culture has really affected who gets to tell stories now, but there was a very particular type of actress that would play different roles. And my Hindi is not great, so there was a language barrier," Jagannathan told PTI in an interview.

The only full-fledged movie she did in India was Abhinay Deo's 2011 film "Delhi Belly", a dark comedy which became popular for its edgy and adult humour.

The movie, which had a mix of English and Hindi, starred Imran Khan, Kunaal Roy Kapur and Vir Das as three struggling roommates who find themselves being hunted by a ruthless gangster. Despite the film's success, the actor said she found it difficult to get roles.

"I did 'Yeh Jawaani Hai Deewani' but I just felt underestimated. There was just no role for me. There was intense ageism in the industry when I was there. Things have really shifted. Priyanka, Deepika and all these people are really shifting what it means to be a woman in their forties, but not when I was there. I felt like I would've loved to have worked more, but it just didn't happen," Jagannathan said.

Jagannathan found critical acclaim in Hollywood with her role of Safar Khan, a Pakistani-American whose son (Riz Ahmed) is jailed in a murder case. The success of the show led to roles in "The Blacklist", "Better Call Saul", "Ramy", "Big Little Lies" and "Never Have I Ever". She was most recently seen in the George Clooney and Brad Pitt-starrer crime

comedy "Wolfs".

Her latest series is "Deli Boys", a comedy about two Pakistani-American brothers (Asif Ali and Saagar Shaikh) who unexpectedly inherit their father's illegal empire after his sudden death. "It's like 'Deli Boys' and 'Delhi Belly' have some crossover in terms of their humour and sensibility. It's both very absurd. It's very dark, it is very physical. And that is completely my sense of humour.

'When I read 'Deli Boys', I was like, 'Absolutely 1000%' and just by reading the first episode... Very few scripts are written for jokes nowadays. 'Deli Boys' just writes for comedy. It's a vehicle for the audiences to laugh their

a\*\*es off. So, I loved getting a script like this."

She plays the role of Lucky, who can "cook biryani and cocaine with equal talent".

'Imagine playing a gangster and a cocaine drug lord at 52. It's like a fantasy. I always say I have a teenage son and you have to out-gangster them every morning when you wake up. she added. And there is a fun story behind how she found the character in a Parsi woman she

met at a restaurant in Toronto "I was with my mother and this Parsi lady was there with her two grown sons. And just the way she spoke to us, the Parsis are so wonderful and so delicate, but when she wiped the food off hers, like a 28-year-old son, I was like, 'This is it. I have found her in a Parsi lady in Toron-

to'," Jagannathan said. "Deli Boys" blends crime, comedy, and family drama while also exploring themes of identity, the immigrant experience, and the allure of the American Dream from a South Asian perspective. Asked about the changes she has seen in the portrayal of South Asian immigrants in the west, Jagannathan said her career in Hollywood can be a case study.

"I can really do the trajectory of my career on the evolution of the writing and the characters. I'd play only very stereotypical characters in the beginning, only like a couple of lines as a nurse or a doctor, down to having the privilege of playing Lucky now," the actor said. (PTI)

## Defiant Usha says ad-hoc panel for boxing needed as BFI failed in 'fundamental' duties

NEW DELHI, March 4: Indian Olympic Association (IOA) chief P T Usha on Tuesday defended her decision to appoint an ad-hoc committee for boxing, saying the national federation failed to fulfil its "fundamental responsibilities" in the last one year and her action was necessary to "restore order and ensure proper governance".

Her statement came in response to IOA vice president Gagan Narang's letter on February 28 in which the former Olympic bronze-winner accused her of issuing "arbitrary" orders and undermining athletes' wel-

Usha's steadfast position is de-

spite the Delhi High Court's stay on the IOA's order. The court issued notice, seeking IOA's response to a petition filed by the Boxing Federation of India (BFI).

"...there is no truth in your (Narang) assertion that athletes are suffering due to this decision or any alleged arbitrary actions on my part. The decision to appoint an ad-hoc Committee was not arbitrary but a necessary step to restore order, ensure proper governance, and prioritize athlete development," Usha said in her reply to Narang, who is also a member of the IOA's Executive Council.

"The unfortunate reality is that



BFI has failed in fulfilling its fundamental responsibilities, including conducting national championships in the last year.

"With the 2026 Asian Games fast approaching, there has been

little to no effort to identify fresh talent, select promising boxers, and implement structured training programs to enhance India's medal prospects.'

Usha, who has been at logger-

heads with the Executive Council members over several issues, accused them of showing "disproportionate preoccupation" with issues of "personal preferences" rather than the overall good of Indian sports.

Narang wrote to her seeking a withdrawal of her "arbitrary" act of forming an ad-hoc committee to run the affairs of BFI. He had said that "due to such arbitrary order, our athletes are suffering and we are getting a bad name domestically and internationally". On February 24, the IOA constituted a five-member adhoc committee to oversee the affairs of boxing in the country on the ground that the sport's national federation failed to hold elections on time. The BFI termed the IOA's decision as "illegal" and filed a petition in the Delhi High Court to quash the order. Narang also claimed that Usha's decision to form the adhoc committee to run BFI was done "without consultation and/or approval of EC of IOA".

He had urged Usha to recall the order and call an emergency meeting of EC to discuss various pressing matters.

Hitting back at Narang, the IOA president said she has made several attempts over the past year to convene Executive Council meetings to discuss key issues. "Unfortunately, these efforts have been thwarted time and again by members -- including yourself -- who have consistently blocked meaningful discussions," she alleged.

"I struggle to recall any instance where the EC has actively engaged in discussions about improving athlete performance or implementing measures to enhance India's medal-winning po-"The persistent reluctance to address these critical matters raises serious concerns about the priorities of

some within the IOA," she said. The IOA has been a divided house ever since Usha appointed Raghuram Iyer as the CEO in January 2024. (PTI)

cialised skill, and Taeke will continue to work with us in future camps as well," Harendra said. Harendra also acknowledged the improvements in Deepika's performance.

"We've seen definite progress with Deepika, particularly during the recent Pro League matches. However, successful penalty-corner conversions rely on three key components -- the

injector, stopper, and dragflicker. "Unfortunately, we faced some challenges with the injection and stopping during some matches, which affected our conversion rate. But Deepika's tactical approach is improving with each game," he said. (PTI)

## Kohli's master-class steers India towards 4-wicket win over Aussies

**DUBAI, March 4:** Virat Kohli did not finish the chase for once but his measured 84-run knock steered India into their fifth Champions Trophy final with a clinical four-wicket win over an under-strength and profligate Australia in the first last-four clash here on Wednesday.

The Indian triumph ensures that the final of the eight-team competition will now be held here instead of Lahore, the original host of the marquee clash, as Rohit Sharma's men will not travel there owing to security concerns.

Player of the match Kohli (84, 98 balls, 5x4) was the fulcrum of Indian batting as they scaled down 265 in 48.1 overs after Steve Smith (73) and Alex Carey (61) led the Aussies to 264.

Now, India will await the winner of the second semifinal between South Africa and New Zealand at Lahore on Wednesday.

Kohli had wonderful support from Shreyas Iyer (45) with whom he realised 91 runs for the third wicket, and steadied the ship after the early departures of skipper Rohit Sharma (28) and Shubman Gill (9).

Australia were weakened by the absence of some of their premier stars, but India had not beaten them in the knockouts of an ICC tournament since the quarterfinal of the 2011 World

However, Kohli was determined to correct that anomaly. The pitch used for the semifinal was fresh but much smoother than the ones on which

the previous matches were played.

Kohli does not need a second invitation to exploit such conditions and a near-perfect control helped him keep pace with the asking rate.

Kohli's struggle point in an ODI innings is his inability to force the pace against spinners, but here the champion batter negated leg-spinner Adam Zampa, who had his number on a few occasions in the past, quite effectively.

The 36-year-old used the pull and drives, two of his most productive shots, to optimum effect. He placed him in the wide arc between sweeper cover and mid-wicket for easy, risk-free runs.

He lost the company of both Iyer, who played some delectable shots, and Axar Patel (27) in rather quick succession but Kohli went past his 50 in 53 balls.

Glenn Maxwell dropped him on 51 off leftarm spinner Cooper Connolly, a perceived early signal of an inevitable Kohli hundred.

But it did not arrive as an ugly hit off Zampa ended in the hands of Ben Dwarshuis near longon when India were 40 runs away from victory. KL Rahul (42 not out) and Hardik Pandya (28) played some smart and aggressive cricket as

India cantered home without much ado.

However, the Indian bowlers too deserve some credit as they kept the Aussies batting on a tight leash despite well-paced fifties from Smith and

Australian skipper Smith (73, 96b, 4x4, 1x6)

LAHORE, March 4: Loaded with world-class talent but haunted by the underachievers' tag at ICC events, New Zealand and South Africa will square off in an evenly-matched second semifinal of the Champions Trophy here on Wednesday.

South Africa and New Zealand have won the Champions Trophy once each in 1998 and 2000 respectively but the tournament was called the ICC Knockout Trophy at that time and didn't carry the significance which it has now. While South Africa would look to shed their big tournament "chokers" tag, the Kiwis will also be desperate to lay their hands on a title after having finished second best twice in the ODI World Cup (2015 and 2019) and once in the T20 World Cup (2021). Led by Mitchell Santner, New Zealand finished behind India in Group A, while South Africa topped Group B ahead of Australia. But there is little to separate the two sides. Both are evenlymatched in most departments but the Proteas look to be slightly ahead on

the bowling front because of variety. The two teams have enough firepower in their batting line-ups and have quality fielders but the contest is expected to be decided by the spinners.

Although the pitches here are a bit on the slower side but they haven't spun as much as the surfaces in Dubai and it will be interesting to see how the spinners of both the teams fare. The 44-run loss to India in their last group match notwithstanding, New Zealand will take confidence from their win over South Africa in the tri-series here last month.

Recently, New Zealand successfully chased 305 against South Africa here and then went on to win the tri-series, beating Pakistan in the final, and senior batter Tom Latham feels those experiences will hold them in good stead. "Yeah, the (South Africa) team that we played potentially will be slightly different, they had a lot of guys that that weren't in that side. They were still playing in their SAT20 back in South Africa so will be slightly different. "But I guess from our point of view, we'll lean back on those experiences of Lahore in playing against South Africa," Latham had said. "We'll do everything that we do leading up to a game. It's obviously going to be a reasonably quick turnaround, but it is what it is. And, we'll be looking forward to the challenge of a semifinal," he added referring to

New Zealand were in Dubai on Sunday to play against India and headed to Lahore the next morning. Latham has been New Zealand's best batter so far with 187 runs from three matches, but Kane Williamson's return to form with a classy 81 against India also augurs well for the Kiwis. On the bowling front, Matt Henry stood out and is currently the highest wickettaker with eight scalps and has good support from Will O'Rourke (six wickets). In skipper Mitchell Santner, Michael Bracewell, Rachin Ravindra, Glenn Phillips and Mark Chapman, New Zealand boast of a good spin attack. South Africa too are in red-hot form. The Proteas have fielded one of their most prolific squads in the tournament and have all their bases covered. With a century under his belt, Ryan Rickelton is in ominous form, while the likes of Temba Bavuma, Rassie van der Dussen and Aiden Markram have also contributed with the bat. South Africa's bowling also looks impressive with the likes of Wiaan Mulder, Kagiso Rabada, Lungi Ngidi, Marco Jansen, Keshav Maharaj and Tabraiz Shamsi in their ranks. While on-paper, South Africa look a formidable unit and have been the team to beat in recent ICC events, their overall form over the last one year or so doesn't inspire confidence as the Proteas have lost eight of their last 13 ODIs. #### It's not size, but mental strength that matters: Gavaskar backs Rohit Sharma



DUBAI, March 4: Backing India captain Rohit Sharma, who was subjected to fat-shaming, cricket legend Sunil Gavaskar on Tuesday said that slim guys are for modelling and in cricket, mental strength is what matters, not physical size.

Addressing the unnecessary criticisms directed at India skipper in the middle of Champions Trophy by a politician, Gavaskar reminded how Mumbai's big-hitting Sarfaraz Khan also faced body shaming, but it didn't affect his performance at

"I have always said, if you want only slim guys, then you should go to a modelling competition and pick all the models. It's not about that," Gavaskar told India Today.

"It's about how well you can play cricket. We talked about Sarfaraz Khan, he was vilified for a long time because he was on the heavier side. But if he scores 150 for India in a Test match and follows it up with another two or three fifty-plus scores, then what's the issue?

"I don't think size has anything to do with it. It's your mental strength ówhether you can last the distanceóthat's the most important thing. Bat well, bat for long, and score runs.'

Congress spokesperson Shama Mohamed called Rohit "fat for a sportsman" and described him as the most unimpressive Captain India has ever had.

However, she faced backlash on social media for her unwarranted comment and was forced to delete her post from the 'X'.

Congress also distanced itself from Shama's comment and requested her to delete the post. (PTI)

## Aaqib Javed to continue as Pakistan's head coach for tour of New Zealand

LAHORE, March 4: The Pakistan Cricket Board (PCB) has asked former pacer and national selector, Aaqib Javed, to continue as interim head coach for the whiteball tour of New Zealand.

A PCB official said due to time constraints between the Champions Trophy and New Zealand tour, Aaqib will continue as interim head

"The PCB meanwhile has started the process of finding a new head coach for the national team and due process would be followed," he said. The official said Pakistan should have a new head coach when they begin their new cycle of the World Test Championship (WTC) in August.

Last year, the PCB had appointed Jason Gillispie and Gary Kirsten as the red ball and white ball coaches respectively, but both resigned within six to eight months of their appointment citing issues with the Pakistan board.

Salman Ali Agha replaced Rizwan as captain of the T20 outfit with all-rounder Shadab Khan being recalled and named his vice-captain.

Rizwan has been retained as captain of the ODI squad after the team's disappointing show in the Champions Trophy. The selectors have avoided an overhaul in the one-day squad and retained majority of the players who flopped in the ongoing ICC

Babar is also retained in the ODI squad but batters Saud been axed.

The selectors have also sidelined fast bowlers Shaheen Shah Afridi and Haris Rauf from the one-day squad.

Pakistan play five T20s and three ODIs in New Zealand starting March 16. Pakistan will still be without

dashing opener Saim Ayub, who is yet to recover from an ankle injury while opener, Fakhar Zaman has also been ruled out of the tour with an injury he sustained in the first match of the CT.

His injury came after making a comeback to the Pakistan squad last month in the three-nation event while Saim got injured while fielding during the Test series in South Africa earlier this

## South Africa have bit more class and power compared to NZ: Ponting ahead of CT semifinal

LAHORE, March 4: South Africa have a "bit more class and power" in their lineup, which makes them favourites in the Champions Trophy semifinal against New Zealand, feels Ricky Ponting, though the Australian great added that if someone like Kane Williamson comes to the party he could get the job done for the Black Caps. New Zealand are coming into the knockouts on the back of a big defeat against India in Dubai, while South Africa are on a roll following their massive seven-wicket win against England in the group stage.

While momentum could play a big role in the contest, Ponting said with a deep batting lineup, just like India, South Africa enjoy an edge. "If I look at both the sides, I think there's that

little bit more class in the South African line-up. They bat deep. I think they might have a little bit too much power for New Zealand," Pointing opined on ICC Review on Tuesday. "I'm actually going with South Africa (to win

the contest) as much as I've praised New

Zealand," he added. The former Australian captain added that New Zealand top-order batter Williamson will have to play a leading role in the contest as every team relies on its big players to guide them in crunch games. 'Williamson, I think, needs to make runs for them in this game. Every team needs their big players standing up in big moments. Big games

mean big names. It doesn't get bigger than the

Champions Trophy semifinals. And,

Williamson is a big-game player, he will under-



stand the enormity of his role going into the game and I won't be surprised if he gets the job done," Ponting said.

Williamson, after hardly making any contribution against Pakistan (1) and Bangladesh (5), struck a 120-ball 81 against India in the final group game, which would have given him some confidence. However, Ponting feels the likes of opener Ryan Rickelton, skipper Temba Bavuma, Aiden Markram, David Miller and Heinrich Klaasen could make things difficult for the Kiwis. "He's (Klaasen) very important be-

cause he is such a dangerous player of spin bowling. He's such a great, clean hitter of spin. He is important to the middle order but South Africa bat deep like India. And, with a worldclass all-rounder like Marco Jansen and obviously Aiden Markram, (Temba) Bavuma, David Miller... their batting is really strong. That middle order. "I think Klaasen has been the No.1 T20 batter for long and if he brings that sort of stuff to the 50-over game... If he goes in around the 30-over mark and South Africa are 2-3 down, then he can be truly dangerous," he said. Ponting said a couple of intriguing match-ups

could dictate which side wins the contest. Rickelton has been outstanding for South Africa at the top of the order. He has got them off to some really good starts (in CT), made that big hundred a couple of games ago (against Afghanistan). And, Matt Henry has been great for New Zealand picking up a five-for... we

know he is a good swing bowler. "So, I think Henry and Rickelton will be a really intriguing one," opined Pointing. He said that Klaasen, who smashed a half-
