

Punjab Police team in Assam for transfer of seven aides of Amritpal Formalities for shifting from Dibrugarh jail completed



DIBRUGARH, March 17: A 25member team of Punjab Police has been stationed in Assam's Dibrugarh for the past two days to facilitate the transfer of radical preacher Amritpal Singh's seven aides who have been imprisoned along with the 'Waris de Punjab' leader here for nearly two years, officials said.

The date of the transfer, how-

ever, has not been officially disclosed but could be within the next two to three days, the officials added

Ten members of the outfit, including Amritpal who is an Independent MP, and one of his uncles, have been housed in the Dibrugarh Central Jail since 2023 after they were arrested under the National Security Act (NSA) from different

parts of Punjab following a crackdown on the outfit.

The Punjab Police team, led by Superintendent of Police Harinder Singh Gill, was engaged in completing the legal formalities in Dibrugarh, a town in eastern Assam, to proceed with the transfer, the officials said. The detainees set for transfer are

Daljit Singh Kalsi, Kulwant Singh Dhaliwal, Gurmeet Singh Bukkanwala, Harjit Singh, Bhagwant Singh alias Pradhan Mantri Bajeke, Basant Singh and Gurinderpal Singh.

Amritpal Singh, along with Papalpreet Singh and Varinder Singh Johal, will continue to be held under NSA here, with their detention scheduled to expire in June 2025.

The radical preacher had contested the 2024 Lok Sabha elections as an Independent candidate and won from (CONTD. ON PAGE-2)

Oppn misleading Muslims on Waqf Bill, no threat to board's properties: BJP

NEW DELHI, March 17: The BJP to bring about professionalism, on Monday accused the opposition parties of "misleading" Muslims on the proposed amendments to the Waqf Act and asserted that not "an inch" of waqf properties with clear titles will be taken away if the bill gets Parliament's nod.

The accusation came amid a host of Muslim organisations, led by the All India Muslim Personal Law Board, protesting the Waqf (Amendment) Bill here, with several MPs joining in support.

AIMIM chief Asaduddin Owaisi cautioned the NDA constituents like TDP, JD(U) and LJP (Ramvilas) that Muslims will never forgive them if they support this legislation.

Asked for comment, BJP MP Tejasvi Surya said, "The politics of vote bank in the country has always been based on fearmongering that has been the modus operandi of all of these so-called secular parties.'

"Let me assure everybody that the intent of the government in

good management and transparency in the management of Waqf properties," he told a press conference at the BJP headquarters here

The Bangalore South MP said the government has ensured that the powers of the Waqf Board are not abused to encroach on lands that did not belong to it.

"All those institutions which have clear titles, all those places of religious worship that have been in existence for years together, not a single one of them have fear from the new Waqf law," Surya said. Attempts are being made to mis-

lead Muslims, he charged, asserting, "Not an inch of such lands will be taken away.'

Slamming the opposition parties, he alleged that those who call themselves secular parties did nothing for the Muslims, except always making efforts to scare and mislead them.

"The government intends to make the Waqf Boards more and a case was registered with Dispur police station against some unknown culprits.

The body of another local, who had died on Sunday, has already been sent for post-mortem examination following similar suspicion

raised by people of the area. The official said that these two persons, Rajesh Telenga and Shankar Telenga, of Lattakoojan tea estate in Numaligarh area had died over the weekend.

The body of Rajesh, who had died on Saturday, was buried following rituals by his family and was exhumed during the day, the official said. Shankar's mortal remains were

sent for autopsy soon after his death on Sunday.

Within the context of FTA negotiations, Modi and Luxon agreed to discussions between respective authorities on both sides to explore early implementation of cooperation in the digital payments sector.

NEW DELHI, March 17: The Supreme Court on Monday said the trial of the Manipur ethnic violence cases, probed by the CBI, would be conducted in Guwahati, Assam, where they were transferred to earlier.

A three-judge bench headed by Chief Justice Sanjiv Khanna also extended till July 31, 2025, the tenure of a committee headed by Justice Gita Mittal, the former chief justice of the Jammu and Kashmir High Court.

The panel, also comprising former Bombay High Court judge Shalini P Joshi and Asha Menon, former Delhi High Court judge, was set up on August 7, 2023 by the top court to oversee relief and rehabilitation of the victims of ethnic violence in Manipur.

The tenure of the panel was previously extended by the top court by six months on August 5, last year. On Monday, the bench noted the submissions of a lawyer over the fate of the trials in the cases that were transferred to Guwahati for pre-trial proceedings by the

bench on August 25, 2023. "We clarify that the trial of transferred cases will be held before the courts at Guwahati," the CJI said. Keeping in mind the "overall environment in Manipur and the need

for ensuring a fair process of criminal justice administration", the top court transferred to Assam, 27 cases, having various offences, including the sexual assault case of the two women seen in a viral video being paraded naked. While passing a slew of direc-

tions, the top court had directed the Gauhati High Court chief justice to nominate one or more judicial officers to deal with the transferred cases. Of the 27 cases, 20 related to charges of molestation, rape, murder whereas three related to loot of weapons.

On the supply of the several reports submitted by the judges' panel to all the litigants, the bench was in the affirmative but asked the parties to exercise caution due to the "sensitivities involved".

NEW DELHI, March 17: Union Minister of State for Health Anupriya Patel on Monday said India's digital disease surveillance system offers a valuable model for other countries seeking to strengthen their public health infrastructure

The rise of emerging and re-emerging health threats in recent times underscores the critical necessity of strengthened preparedness, enhanced surveillance and well-coordinated international response mechanisms to safeguard global health security, Patel said after inaugurating the QUAD Workshop on Pandemic Preparedness for the Indo-Pacific Region here.

The purpose of the three-day workshop, jointly organised by the Ministry of Health and the Ministry of External Affairs, is to strengthen global health emergency frameworks, enhance pre-



paredness and resilience to health threats, ensure coordinated responses to evolving pandemics, implementation of One Health approach, and address human, animal and environmental

health through a multisectoral lens. Highlighting India's commitment to strengthening global pandemic preparedness and response efforts, Patel said. "India has contributed USD 10

million towards the establishment of Pandemic Fund which was specially conceptualised for fighting pandemics." "India has further pledged an addi-

tional USD 12 million to support its sustained functioning," she added. court.

Patel said India has led digital health initiatives, leveraging technology to improve health access and outcomes, and create sustainable and data-driven systems.

These efforts are central to building a health system capable of addressing both current as well as future health and climate challenges, she said.

Kaziranga National Park: SC refuses to hear plea against HC order

NEW DELHI, March 17: The Supreme Court on Monday refused to hear a plea against an order of the Gauhati High Court which adjourned sine die a case over the protection and preservation of Kaziranga National Park.

A bench of Justices B R Gavai and Augustine George Masih said the issues relating to the park, including the declaration of eco-sensitive zone, was pending before the apex

The bench told the petitioner's counsel to withdraw the plea challenging the high court order and file an application in the proceedings pending before the top court.

The counsel withdrew the plea with liberty to move an appropriate plea in the apex court. The petitioner's counsel said the plea filed before the high court raised several issues concerning the park, including the declaration of eco-sensitive zone.

"That issue is pending before this court," the bench observed.

In its order passed on December 6 last year, the high court adjourned the matter sine die (without a future date fixed) observing several issues relating to the national park were



pending before the apex court.

The PIL filed in the high court raised several issues concerning the protection of biodiversity and ecosystem of Kaziranga National Park including eco-fragile zone, protection of nine notified animal corridors and for action against alleged unauthorised industrial and other non-forest activity.

The petitioner alleged non-forest activity, including settlement of land within the forest area, had ramifications and referred to a report of the Comptroller and Auditor General of India stating a change in land pattern and other non-forest activities might wipe out the one-horned rhino to extinction. MUMBAI, March 17: Benchmark BSE Sensex rebounded by 341 points on Monday, snapping its five-day losing streak following buying in banking stocks and a sharp rally in global shares.

The 30-share BSE Sensex climbed 341.04 points or 0.46 per cent to settle at 74,169.95 as 19 of its constituents ended in the green and 11 in the red. In intra-day trade, the benchmark jumped 547.44 points or 0.74 per cent to 74,376.35.

The NSE Nifty rose by 111.55 points or 0.50 per cent to 22.508.75

From the Sensex pack, Bajaj Finserv, Mahindra & Mahindra, Axis Bank, Bajaj Finance, Adani Ports, ICICI Bank, Zomato and UltraTech Cement were among the biggest gainers



On Thursday, the rupee surged 17 paise to settle at 87.05 against the US dollar. Forex, stock markets were closed on Friday on the occasion of Holi festival.

"The rupee appreciated for the fourth day on a trot backed by better-than-expected economic data and recovery in the risk-assets. The weakness in the dollar index and lower treasury yields also supported the local

ties, said.

"We expect the rupee to trade with a slight positive bias on weakness in the US dollar and positive global markets. However, the ongoing trade tariff issue and outflows by foreign investors may cap sharp upside," Anuj Choudhary, Research Analyst at Mirae Asset Sharekhan, said. Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.11 per cent lower at 103.60. Brent crude, the global oil benchmark, rose 0.92 per cent to USD 71.23 per barrel in futures trade.

Choudhary further noted that traders may take cues from retail sales and Empire State Manufacturing Index data from the US. USDINR spot price is expected to trade in a range of 86.60 to 87. In the domestic equity market, the 30-share BSE Sensex surged 341.04 points, or 0.46 per cent, to settle at 74,169.95, while the Nifty advanced 111.55 points, or 0.5 per cent, to close at 22,508.75 points. MP demands two trains

Khoirabari, Dekargaon, Goreswar, Mazbat, Tangla and Udalguri that were done away with during the Covid pandemic. The BJP MP said the Narendra Modi government allocated ₹2,65,200 crore for the Indian Railways during 2025-26, breaking all records.

This allocation is six times higher than the ₹ 45,900 crore allocated during the United Progressive Alliance (UPA) regime, he said. In the last decade, a total of 31,180 kilometres of railway lines were laid while the Kavach security system was made operational along 4,876 kilometres of tracks, he said.

The MP said the Railways electrified 21,000 kilometres of tracks since Independence to 2014 but, during the last 10 years, more than 60,000 kilometres had been electrified and the Railways would soon achieve its 100 per cent target. bench directed the Manipur government to submit a detailed sealed-cover report on the number of properties that were fully or partially burnt, looted, or encroached upon during the ongoing ethnic violence in the state. It had emphasised the need for the state to address the grievances of the displaced persons and take steps to

restore their properties. The court also directed the Manipur government to provide specific details such as "buildings burnt or partially burnt, buildings looted, buildings trespassed or encroached upon"

The report was ordered to also provide information on the owners and current occupants of these properties, long with the details of any legal actions taken against trespassers.

The report was directed to indicate the steps taken by the state government to ensure trespassers were proceeded against as per the law. "You have to take a decision on how you want to deal with it or in terms of criminal action as well as to ask them (encroachers of the properties) to pay 'mesne profits' for the use of the occupation ...," the apex court had said.

Mesne profit is the compensation paid to a rightful owner of a property by a person who is in unlawful possession of it.

The top court also asked the state government to respond to the issue of release of funds for temporary and permanent housing as flagged by the judges' panel.

In August, 2023, the top court asked former Maharashtra police chief Dattatray Padsalgikar to monitor the probe into the criminal cases. Over 200 people were killed, several hundred injured and thousands displaced since ethnic violence first broke out in the state on May 3, 2023 when a "tribal solidarity march" was organised in the hill districts to protest against the majority Meitei community's demand for scheduled tribe status. We will continue to cooperate together against terrorist, separatist and radical elements," he said. Police seize PDS fraud and cross-border smuggling

HT Correspondent DHUBRI, March 17: In a major development, Garchuk Police in Guwahati have recently seized 240 sacks of alleged Public Distribution System (PDS) rice and intercepted a truck bearing registration number AS-17C-6071, which was suspected to be meant for smuggling in Bangladesh.

According to sources, the rice was in transit from a godown or rice mill owned by Aminur Islam in Dhubri and was allegedly being tried to be smuggled trespassing the international border to Bangladesh via Meghalaya, probably through a newly discovered route. The consignment was supposed to be unloaded at 13

Mile in Meghalaya crossing Assam border. In the past, when Public Distribution System (PDS) rice bags were being smuggled into Bangladesh via the river channel in Dhubri, the Border Security Force (BSF) frequently confiscated them

The traffickers may decide to take a different way, switching the jute sacks bearing a government-imposed branding.

The police suspect that this smuggling attempt is part of a larger organised racket involving diversion of subsidised food grains meant for the poor.

The truck driver, Rabiul Hoque, and handyman, Sirajul Hoque, were taken into custody in connection with the illegal transportation of the stolen goods.

Authorities have launched a detailed investigation to trace the masterminds behind the operation and identify any officials or traders involved in the illegal network.

The incident underscores the ongoing challenge of food grain theft and smuggling in the region. The authorities are also looking into whether gov-



ernment-subsidised PDS rice has been routinely di verted for such illegal activities

Further updates are awaited as the investigation pro gresses Meanwhile, a well-organised cattle smuggling net-

work operates between West Bengal and Bangladesh, using Dhubri as a crucial transit point.

The gang, originating from Coochbehar, Tufanganj, and Bakshirhat in West Bengal, discreetly transports two to three cows each night using Tata DI vehicles.

The cows are then smuggled across the border via Fakirganj, exploiting the river route to avoid detection by law enforcement agencies.

This clandestine operation continues despite periodic crackdowns, raising serious concerns about border security and illegal trade activities in the region.

The porous border and riverine terrain make enforcement challenging, despite efforts by law enforcement agencies.

Ambedkar Bhavan turns into wasteland

HT Correspondent DHUBRI, March 17: At the centre of Dhubri town, the Ambedkar Bhavan, which was built by the Directorate of Welfare of Scheduled Castes, Assam, at a cost of thirty lakh rupees, has been found to be abandoned and in ruins as a result of inadequate administration and upkeep. The government-funded building, meant to honour the legacy of Dr Bhimrao Ramji Ambedkar, remains abandoned, leading to growing public anger over the wastage of public funds.

Despite the allocation of an additional rupees nine lakh sixty eight thousand eight hundred by the Welfare of Scheduled Castes for the construction of a boundary wall and connecting road, the building has remained unused since its completion in 2015.

A letter (No. DDG-11/2010/97) from the office of the then deputy commissioner, Dhubri, dated September 2, 2015, addressed to the executive engineer of the Public Works Department (Building), Dhubri, to confirm the completion of the Ambedkar Bhavan and hand over the building to sub-divisional welfare officer, Dhubri.

However, since then, it has re-

mained unoccupied, surrounded by overgrown vegetation and suffering from neglect.

The lack of security and maintenance has led to significant damage and theft

Reports suggest that valuable items from the building have been stolen, while the generator installed on the premises has deteriorated due to prolonged exposure.

Additionally, the public has raised concerns over the absence of Dr. Ambedkar's statue in front of the building, further questioning the purpose of the project.

The situation has drawn widespread criticism from conscious sections of society, who are demanding accountability from the government and the district administration. This neglect comes despite repeated directives from the

chief minister to prevent the wastage of public funds. Citizens are now urging immediate action to restore and utilise the

B'desh opts for China-Pak axis

angladesh interim government is exploring all avenues to rejuvenate the country's ailing economy by expanding its trade and investment relationship with Pakistan and China. The objective is to reduce the dependence on India in major areas where the outsourcing is possible from these two friendly countries. Chief Adviser Dr. Mohammad Yunus is paying a visit to China on March 26-29 this year which according to the Chinese ambassador in Dhaka is going to be the most important visit by any Bangladesh leader in the last 50 years as the two countries are taking the relations to a new height. Apart from political discussions, the most important part will be the assistance being sought by Bangladesh chief adviser from China in expanding and building new manufacturing facilities in the country. Bangladesh wants Chinese companies to set up large number of factories in various core sectors of the economy. Dr. Yunus will have a separate meeting with the leading CEOs of the Chinese manufacturing companies. He will invite them to set up units in Bangladesh to turn the country into a major manufacturing hub of South Asia.

After the ouster of the Sheikh Hasina and her fleeing to India on August 5 and the installation of the interim government led by Dr. Yunus on August 8 last year, China has been active in cultivating the political parties apart from the members of the interim government. Already high level delegations of the BNP and the Jamait Islami have visited Beijing and had talks with the Chinese leaders. China is in touch with the new students party National Citizens Party (NCP). That way, the Chinese government has cultivated all the stakeholders in the present political arena of Bangladesh. This visit of Dr. Yunus is taking place in the wake of the completion of the political consultations of the Chinese leaders with the other political constituents. Historically, the trade relationship between Bangladesh and Pakistan has been lukewarm, preventing Pakistan from becoming a major sourcing hub. For instance, Bangladesh exported goods worth \$39.77 million to Pakistan in the July-December of the current fiscal year, according to the Export Promotion Bureau (EPB).

Though the Bangladesh political situation is in turmoil and there is no definite date about the timing of the next elections, experts in China are confident of having good ties with whatever formation comes to the government after elections. China is more advantageously placed vis a vis Pakistan in Bangladesh economy as Beijing has successfully launched a number of projects in the country. China watchers say that the future of the China-Bangladesh relationship is intertwined with Bangladesh's journey through political reform and economic recovery. Despite recent challenges, the long-standing friendship between the two nations provides a robust platform for collaboration. Bangladesh will be getting maximum benefits by collaborating with Beijing in the manufacturing sector. Interim govt sources say Bangladesh stands to benefit from enhanced trade ties with Pakistan as local traders are optimistic about getting more competitive prices and a broader range of raw material sources. Currently, trade dynamics favour Pakistan, with Bangladesh importing cotton, yarn, fabrics, and essential commodities from the country. However, these imports are still considerably lower than those from China and India -- Bangladesh's top two trading partners.

President Putin's sanctions-hit economy gets big relief with Beijing's help

t's a paradox of sorts. While Chinese goods flood the markets globally from watches to pens to electronic gadgets and EVs and luxury goods, China is facing a deluge of Russia made goods in its markets taking the local citizens by craze.

Reports from Chinese cities indicate that shopfronts are decked out in white, blue and red, with Chinese and Russian flags hanging side by side from the ceiling. Waist-high Russian dolls greet customers at the entrance. Inside, shelves are stocked with an array of Russian goods - from chocolates and cookies to honey and vodka, says an on-the-spot report from Hong Kong, a full Chinese

territory In China, pop-up stores specializing in Russian-made products have become an increasingly common sight. Their proliferation has left some residents puzzled, with many on Chinese social media questioning why these stores seem to have sprung up overnight.

Thousands of such stores have opened across the country in recent years, tapping into the Chinese public's affinity for Russia and deepening trade ties between Beijing and Moscow since Vladimir Putin's full-scale invasion of Ukraine began in 2022. China has become a critical eco-

nomic lifeline for US sanctions-hit Russia, with bilateral trade reaching record highs year after year. While cheap Russian oil, gas, and coal dominate China's imports, Russian food products – such as ice cream, sweet biscuits and milk powder - have also risen sharply in popularity, says a report from the us media network CNN.

Chinese businesses are capitalizing on the booming demand. More than 2,500 new companies involved in the trade of Russian goods have been registered since 2022, according to China's business records, with nearly half registered in the past year alone. Around 80% of the new firms that rushed to cash in on the craze remained in operation as of this month. business registration records show.

Most of these companies are based in Heilongjiang, the northeastern province bordering Russia, though in the past two years they've spread in other provinces.

More than aquatic and agricultural products, which make up the bulk of China's food imports from Russia, it is Russian-branded chocolates, biscuits and milk powder that have captured the attention of Chinese consumers, appealing directly to the "Made in Russia" brand promoted by Moscow.

As their popularity grows, the unofficial stores have also come under greater scrutiny from Chinese consumers and media, especially over the quality and authenticity of the goods sold there. Late last year, Chinese shoppers took to social media to complain that some products labelled as Russian for sale at the stores were in fact made in China and other countries, including Malaysia.

A report by state-affiliated Jiemian News found a significant portion of food products sold at Russian goods stores - such as bread, sausage and milk powder were produced in factories in northeastern China. On Douyin, China's version of

social media. Shoppers rushed to TikTok, Russian influencers based in China rushed to expose what they called "fake Russian goods." "I've never seen these candies in Russia. The packaging is all fake,' Russian Douyin user said. There's absolutely nothing like this in Russia," said another, hold-

The Russian embassy in China also weighed in, warning Chinese customers against "counterfeits" disguised as Russian goods. "These products often do not meet quality requirements and are different from similar products produced in Russia, but Russian words are used on the packaging to imitate the Russian origin," it said in a statement

Following the outcry, market regulators in Shanghai launched two rounds of inspections on 47 Russian goods stores in the city. Seven of them were accused of falsely advertising themselves as "state pavilions," misleading customers into believing they have official backing; others created "highly misleading impressions" about the origins of their products, the regulators said in a statement in January.

Some stores were ordered to close, while others were fined and required to label domestically produced goods more clearly. Other cities soon followed suit with similar inspections. Despite the controversy, the popularity of Russian goods is driving more stores to open in China, including official ones

The Russian Export Center said in February it plans to set up as many as 300 Russian goods stores with Chinese partners across the country before the end of the year. At this year's "Made in Russia Festival and Fair" in Shenyang, VeronikaNikishina, director general of the Russian Export Center, offered a tip for distinguishing authentic Russian products from counterfeits.

Genuine goods carry a dove shaped "Made in Russia" label on their packaging, with Russia clearly marked as the country of origin, she explained. "We sincerely hope that all Chinese consumers can purchase authentic, high-quality Russian-made products," Nikishina said. (IPA Service)

challenged fulcrum of Indian politics, is now teetering on the brink of irrelevance. Its survival is no longer a matter of mere electoral strategy but an existential necessity for Indian democracy. The upcoming AICC session in Ahmedabad presents an opportunity-perhaps the last-to confront the hard truths about the party's decline and initiate a transformative rebirth. The Congress must be willing to let its current avatar die, only to be reborn in a form that can effectively uphold the ideals of democracy, secularism, and justice that once defined

The party's downward spiral has been relentless since its last great electoral victory in 1984, when it secured 48.1% of the vote. Every subsequent election has seen a steady erosion of its influence, culminating in the disastrous performances of 2014 and 2019. The 99 seats secured in 2024 were seen by some as a sign of revival, but closer scrutiny reveals a grim reality. The Congress has been reduced to a marginal force in several of its traditional strongholds, performing dismally in states like Uttar Pradesh. Bihar, Gujarat, and West Bengal. In many regions, its victories were dependent on regional allies or on the failures of the BJP rather than on any inherent resurgence of the Congress itself.

This stagnation is not just a matter of electoral misfortune but of fundamental structural decay. The Congress, once a party with an indomitable grassroots network, now finds itself organizationally hollow. The disconnect between leadership and workers has widened into an unbridgeable chasm, making the party's rhetoric seem increasingly empty. The BJP's spectacular rise from two seats in 1984 to a dominant political force by 2014 was driven by its deep investment in grassroots organization, cadre-building, and ideological commitment. The Congress, in contrast, has neglected the first two and remains confused about the third.

The consequences of the Congress' decline extend far beyond its own fate. The absence of a strong national alternative to the BJP distorts the balance of India's parliamentary democracy. While regional parties have successfully challenged the ruling party in certain pockets, no single force has emerged as a cohesive coun-

challenge to the BJP's hegemony. Moreover, the Congress' inability to lead an opposition alliance with confidence has made it more of a liability than an asset to its partners. Without a strong Congress, the very idea of a multiparty democracy faces the risk of becoming a fragmented and ineffective system, where the ruling party eniovs unchecked power.

Internally, the Congress remains plagued by inertia and denial. The Gandhi family-while well-intentioned-has repeatedly failed to recognize and address the party's fundamental flaws. Surrounded by a protective coterie, they have distanced themselves from dynamic leadership voices that could have revitalized the party. The expectation that the BJP will eventually stumble, thus handing power back to the Congress, is delusional at best. The BJP, through its ideological clarity and organizational discipline, has shown no signs of faltering. The Congress, if it continues along its current path, may find itself politically extinct before the BJP even

exercises such as chintan shivirs or incremental reforms will not suffice. When a body is on a ventilator, bandaids do little to revive it. What is needed is a bold reimagination of the party from the ground up. The Congress must recognize that it is not yet completely dead, but neither is it truly alive. It exists in a state of political limbo, where its future depends on the willingness of its members to break free from outdated models and chart a new course.

The AICC session in Ahmedabad could be the moment when the Congress either seals its fate or begins its rebirth. But for the latter to happen, the session must go beyond predictable rhetoric and engage in rigorous, unflinching self-examination. A new generation of leaders must step forward, unburdened by past failures, and commit to rebuilding the party with fresh energy and ideas. Instead of relying on nostalgia for its past glories, the Congress must craft a vision for the future—one that resonates with the aspirations of modern India.

One of the gravest issues within the Congress is its unwillingness to acknowledge failure. Rather than holding individuals accountable, the party has mastered the art of blame-shifting. Even when reports are commissioned to analyze electoral debacles, they rarely translate into meaningful action. These exercises serve more as symbolic gestures than as catalysts for reform. The party's internal culture is one where dissent is stifled, and svcophancy is rewarded. This has led to an ecosystem in which genuine problemsolving is avoided, and superficial fixes are applied to deep-seated structural issues.

The fundamental question now is: will the Congress muster the courage to undergo this transformation, or will it once again succumb to the comforts of its familiar dysfunction? The choice is stark, and the stakes are enormous. If the Congress fails to act decisively now, it may not get another chance. The time for half-measures is over. What is needed is a revolution within, one that dismantles the old and makes way for the new. Medical Myths: IBS myths and facts

rritable bowel syndrome (IBS) is a chronic gastrointestinal disor-L der that affects around 11% of adults worldwide

Symptoms include:

• abdominal pain

excess gas

• bloating

• sudden, urgent need to use the bathroom

• changing bowel habits.

While relatively common, IBS is often misunderstood. To help us dispel some prevalent myths about this condition, we spoke with Dr. Ashkan Farhadi, a gastroenterologist at MemorialCare Orange Coast Medical Center in Fountain Valley, CA, and Dr. Mollie J. Jackson, a gastroenterologist at the University of Kansas Health System.

1. We know what causes IBS

Dr. Farhadi told Medical News Today that although research is uncovering more about IBS, we still do not know what causes it.

While certain foods such as dairy products or spicy foods may trigger symptoms, they do not cause the condition.

He noted, however, that post-infectious IBS can be caused by bacteria such as Campylobacter jejuni. 2. Stress causes IBS

In recent years, research has suggested that levels of mental stress influence gut bacteria composition and play a key role in IBS via the gut-

brain axis Dr. Farhadi says, however, that people with and without IBS generally face similar amounts of stress, meaning that it may be how people manage stress — rather than stress alone — that influences whether or not they may experience IBS symptoms.

"In my book on IBS, [I wrote about a study showing] that when a person is stressed, numbers of mast cells in their gut increase. So stress doesn't just increase the release of hormones and mediators in the gut; it also changes the anatomy of the gut in a way that makes it more sensitive to stress," he explained. "This means that even if you

come out of that stressful period, your gut is not the same gut you had before. IBS symptoms triggered by stress can thus linger even though the stress is gone. And this is very common in patients with IBS," he added.

Dr. Farhadi also mentioned a study he conducted that found that subjective perception of well-being is linked to fewer symptoms of IBS.

Previous research has also suggested that psychological, social, and genetic factors may all play a role in the development of IBS symptoms. 3. Doctors only diagnose IBS via

'fancy tests' "IBS can be diagnosed without fancy tests," Dr. Farhadi told us. "With the right clinical criteria, doctors can diagnose IBS with 97% accuracy in 5 years. No other test in the medical field has that kind of accu-

"We diagnose IBS based on the Rome IV criteria: Patients with IBS should report symptoms of abdominal pain at least once weekly - on average — in association with a change in stool frequency, a change in stool form, and/or relief or worsening of abdominal pain related to defecation," explained Dr. Jackson.

"There are subtypes of IBS, and you may have predominantly diarrhea, constipation, or a mixed pattern. Patients often also experience bloating, but his symptom is not needed in making the diagnosis," she added.

4. IBS is curable

There are different ways of treating IBS, including a mixture of prescription medication and lifestyle changes tailored to each person's individual situation.

"I can assure you in the overwhelming majority of cases, management is very cheap and simple: fiber, probiotics, reassurance, and exercise," said Dr. Farhadi.

When it comes to medication, according to Dr. Farhadi, it can be a "trial and error" experience. However, it can help relieve the symp-



"That's a meditative walk — you do meditation and walk together. It's a stress reliever to reboot your system. But it needs a lot of practice. After 1 year, you may get into that zone for 1 minute out of the 15 you're trying to do," he said.

8. Cutting out lactose helps A recent review found that, although many patients with IBS report milk intolerance, there is no conclusive link between IBS and lactose intolerance.

As around two-thirds of the world's population is lactose intolerant, it is reasonably likely for someone to be lactose intolerant and have IBS. This means that cutting out dairy products may help relieve gastrointestinal symptoms.

"Many patients with IBS associate their symptoms with eating and try to ease their symptoms by avoiding certain foods," said Dr. Jackson. "An elimination diet involves removing multiple foods out of your daily diet and then slowly reintroducing them to help identify trigger foods.'

"The most studied diet for IBS is the low FODMAP diet. FODMAP foods can lead to increased gas and distension and the triggering of meal-related symptoms in patients with IBS. Dairy is a high FODMAP food, and for some/many may be a dietary trigger, but this is not universally true," she explained.

'Food choices can be overwhelming and if available, a gastrointestinal dietician can help guide you in this process," she added

9. Natural treatments work for IBS

Natural remedies such as peppermint oil and cardamom have shown some promise in relieving symptoms of IBS and gastric ulcers. However, research into natural remedies is limited, so they may not be universally helpful.

"Black cardamom seeds and spearmint are muscle relaxants for the gut, and so they could reduce symptoms," said Dr. Farhadi.

"People can try these natural remedies and others as long as they are not really strong chemicals. Many herbal remedies have been around for thousands of years, and people are using them with no problem," he added.

Nevertheless, it is always recommended to check with a doctor before taking on any new line of treatment.

10. Fasting relieves IBS

"Imagine you have an engine, and the engine has a problem. Now you turn it off. Or course, you may not have any problems as long as it's off, but how long can you keep it off?" said Dr. Farhadi.

"So, if you reduce the number of times you eat from perhaps three to two times per day, you may reduce the number of symptoms you experience per day. It may help, but it isn't necessarily the way to go," he explained.

"Fasting, however, is good for other things — such as weight loss and memory," he added.

11. Fiber helps IBS

If a patient has chronic constipation, Dr. Farhadi said that fiber could help. However, if overdone, fiber can lead to bloating from excess gas in the gut.

To avoid this, Dr. Farhadi recommended consuming fiber via a pinch of water-soluble fiber psyllium — a prebiotic - on a spoon of Greek yogurt, which is a probiotic.

12. There is an IBS diet "There's no specific diet for IBS," said Dr. Farhadi.

"Diets are not only individualized; they are dynamic. One person may be able to drink coffee when on vacation yet experiences problems with it during finals. Moral education is fundamentally about teaching individuals the principles of right and wrong, and guiding them in making ethical decisions. It encompasses more than just adherence to societal norms; it involves fostering a deep-



seated sense of integrity, empathy, and responsibility. Unlike academic subjects that focus on intellectual knowledge, moral education delves into the ethical dimensions of human behavior and interactions. Its goal is to cultivate virtues such as honesty, kindness, fairness, and respect, which are essential for personal growth and harmonious coexistence.

The importance of moral education is particularly evident in the context of early childhood development. During these formative years, children are highly impressionable and absorb values and behaviors from their environment. Instilling moral values early in life helps shape their character and influences their actions and decisions as they grow. For example, teaching children about empathy and compassion can lead them to develop a strong sense of social responsibility and a desire to contribute

plays a crucial role in fostering social cohesion and harmony. In diverse societies, individuals come from various cultural, religious, and ethical backgrounds, which can sometimes lead to misunderstandings and conflicts. By promoting universal moral values such as respect, fairness, and empathy, moral education helps bridge these gaps and encourages mutual understanding and cooperation. It provides a common ground for individuals to interact and collaborate, regardless of their differences. This shared moral framework can contribute to a more inclusive and harmonious society where individuals work together for the common good.

The impact of moral education extends beyond individual and societal levels to the global community. In an interconnected world, ethical issues often transcend national borders, and global

The typical adult in the UK spends nearly two hours on social media per day. And for younger users, this can easily be up to five hours. The likes of Instagram or TikTok seem to draw us into their ever-changing feeds and it's difficult to tear ourselves away from these platforms. Now our latest study shows that even our body reflects a state of being glued to the screen when

we are on social media. We asked 54 young adults to browse their Instagram on their phone for 15 minutes as they would normally do in their daily life. However, in our study we had attached electrodes to their chest and fingers that allowed us to record their heart rate and "skin conductance", which is an indicator of sweating. Psychologists can use these physiological markers to infer subtle mental states and emotions. We also added a control condition where our participants read a news article on their phone, just before they logged onto Instagram.

What we found was that, relative to the news reading condition, scrolling away on Instagram led to a marked slowing of participants' heart rate while, at the same time, increasing their sweating response. From other research we know

that such a pattern of bodily responses shows that someone's attention is fully absorbed by a highly significant or emotional stimulus in their environment it's a state of simultaneous excitement and deep immersion into something very meaningful to us. Importantly, from the control

condition we knew that it was not just being on the phone or reading that caused this bodily response. So there seems to be something special about social media that can easily engross us.

The most intriguing effect in our study happened when we interrupted participants at the end of their Instagram stint and asked them to go back to reading another news article. Rather than snapping out of the excitement and returning to a calmer state,



participants' sweating response increased further, while heart rate also increased rather than slowed down further. Is it addiction?

What was going on? What helped us interpret these effects were participants' ratings of their emotions. We collected these before their social media bout and at the time we asked them to log off. Participants reported being

stressed and anxious when they had to disconnect from their feed. They even reported having social media cravings at that moment. So it looked like the physiological response that we observed when participants had to log off reflected another form of arousal but this time it was more negative

and stress-related Such bodily and psychological stress responses also occur when people with a substance addiction go through withdrawal during abstinence or after quitting "cold turkey". So were these signs that we observed "withdrawal" from Instagram?

The answer to this question is not straightforward. However, our study may give us some clues. After the experiment, we asked all participants to fill in a questionnaire assessing symptoms of 'social media addiction".

While this concept is controversial and currently not recognised as a mental health disorder. the questionnaire told us something about how social media use can negatively affect someone's daily life. This can even include their work or school results, or lead to conflict with their partners Notably, we did not see any heart rate and sweating differences between participants who scored high or low on these addiction measures. That means, that all our participants showed a pattern of excited immersion during use and stress-related arousal when use was interrupted.

We don't think that this finding means that we are all addicted to social media though. Instead, we believe that social media offers very powerful rewards. And some of its features may indeed have an addictive dimension, such as the personalised short-video streams that trap us in an endless loop of entertaining content.

Critically however, our previous study shows that it is primarily the social aspect of social media that drives most people to use it so intensively. This also means that - in contrast to drugs - social media taps into basic human needs: we all want to belong and to be liked.

So if we recognise the existence of "social media addiction", we might also need to recognise a "friendship addiction". We should therefore exert caution with the term addiction in the context of social media - the risk is that normal behaviour could become "pathologised" and lead to stigma.

And, as our previous research indicates, we may be just fine abstaining or cutting down from social media for a while without experiencing dramatic changes to our wellbeing (either positive or negative). The reason for this is that in contrast to drugs, we can satisfy our needs through other means - for instance, by talking to people. (Courtesy: Scroll.in)

US and Iran-backed Houthis both vow escalation after US airstrikes target rebels in Yemen

CAIRO, March 17: The United States and Iran-backed Houthi rebels in Yemen are both vowing escalation after the US launched airstrikes to deter the rebels from attacking military and commercial vessels on one of the world's busiest shipping corridors.

The Houthi-run Health Ministry said the US strikes killed at least 53 people, including five women and two children, and wounded almost 100 in the capital of Sanaa and other provinces, including Saada, the rebels' stronghold on the border with Saudi Arabia.

"We're not going to have these people controlling which ships can go through and which ones cannot. And so your question is, how long will this go on? It will go on until they no longer have the capability to do that," U.S. Secretary of State Marco Rubio told CBS on Sunday.

President Donald Trump on Saturday vowed to use "overwhelming lethal force" until the Houthis cease their attacks, and warned that Tehran would be held "fully accountable" for their actions.

The Houthis have repeatedly targeted shipping in the Red Sea, sinking two vessels, in what they call acts of solidarity with the Palestinians in Gaza, where Israel has been at war with Hamas, another Iranian ally. The attacks stopped when a Israel-Hamas

Ten of the drones were intercepted by U.S. Air Force fighter jets and one was intercepted by a Navy F/A-18 fighter jet. The missile fell into the water far from the ship, and nothing came close to hitting either the carrier or the warships in its strike group.

The spokesperson for U.N. Secretary-General Antonio Guterres in a statement called for "utmost restraint and a cessation of all military activities," while warning of the "grave risks" to the dire humanitarian situation in Yemen, the Arab world's poorest nation.

Rubio said that over the past 18 months the Houthis had attacked the US Navy "directly" 174 times and targeted commercial shipping 145 times using "guided precision anti-ship weaponry.'

The attacks sparked the most serious combat the U.S. Navy had

seen since World War II. On Sunday, the head of Iran's paramilitary Revolutionary Guard, Gen. Hossein Salami, denied his country was involved in the Houthis' attacks, saying it "plays no role in setting the national or operational policies" of the militant groups it is allied with across the region, according to state-run TV.

Iran's Foreign Minister Abbas Araghchi, writing on X, urged the US to halt its airstrikes and said Washington cannot dictate Iran's foreign policy.

The U.S. and others have long accused Iran of providing military aid to the rebels. The U.S. Navy has seized Iranian-made missile parts and other weaponry it said was bound for the Houthis.

The United States, Israel and Britain previously hit Houthi-held areas in Yemen, but the new operation was conducted solely by the US It was the first strike on the Houthis under the second Trump administration.

The USS Harry S. Truman carrier strike group, which includes the carrier, three Navy destroyers and one cruiser, is in the Red Sea and was part of the mission. The USS Georgia cruise missile submarine has also been operating in the region. (AP)

ISLAMABAD, March 17: The Pakistan government has convened an in-camera meeting of a highlevel parliamentary security panel on Tuesday where the top military leadership would brief lawmakers on the prevailing situation, amid a surge in the terror attacks in Balochistan Khyber and Pakhtunkhwa.

Prime Minister Shehbaz Sharif has asked National Assembly Speaker Ayaz Sadiq to convene the security meeting at Parliament House on Tuesday at 1:30 pm, it emerged on Monday.

The military leadership will provide a comprehensive briefing to the Parliamentary Committee on National Security on the prevailing security situation, according to a statement issued by the Prime Minister's Office (PMO). The development comes in the

wake of a series of deadly terror attacks in the two provinces, which share a border with neighbouring Afghanistan.

Citing a source in the National Assembly, Dawn newspaper reported that since no parliamentary committee on security was formed, therefore, members of the Standing Committees on Defence and Foreign Affairs from the National Assembly, federal cabinet members, chief ministers of the four provinces and leaders of all parliamentary parties or their representatives will attend the closed-door session. Prime Minister Sharif and Army Chief Gen Asim Munir will join the

and the Balochistan Liberation Army (BLA) have repeatedly attacked the security personnel and civilians. On Sunday, five people, including three security personnel, were killed and 30 others injured when a paramilitary convoy was attacked by BLA militants in Noshki district of Balochistan.

Last week, the BLA militants ambushed a train carrying 440 passengers in the same province and killed 21 passengers and four paramilitary soldiers. The army eliminated all 33 terrorists and rescued passengers.

On Sunday, three security personnel were killed in five separate terrorist attacks in Khyber Pakhtunkhwa province.

Balochistan and Khyber Pakhtunkhwa provinces accounted for over 96 per cent of terrorist attacks and deaths in Pakistan in 2024.

The militants also this month attacked Bannu Cantonment in Khyber Pakhtunkhwa where 16 terrorists were killed and five soldiers died. Also, renowned cleric Maulana Hamidul Haq Haqqani was killed with five other people in a suicide attack at his seminary in Nowshera district of KP.

Pakistan has repeatedly blamed Afghanistan for the surge in terrorist attacks, allegations that Kabul has denied. As if to put pressure on the Afghan government, Pakistan set March 31 as the deadline for Afghan Citizen Card (ACC) holders to leave the country or face deportation. In a related development, Pakistan turned down a request by the Afghan Taliban to grant an extension in the stay of Afghan refugees, reported The Express Tribune. Official sources told The Express Tribune on Sunday that the Pakistani decision was final and there would be no relaxation. Sources said relevant authorities and all four provinces have been given instructions to make appropriate arrangements for the return of Afghan refugees.

Över 800,000 Afghans living in Pakistan illegally have been repatriated to their country since Pakistan launched the campaign in November 2023. Pakistan, however, had spared those who were registered with the UNHCR or had the ACC. (PTI)

Putin, Trump will speak today about war in Ukraine Trump shares Modi's podcast with WASHINGTON, March 17: US Lex Fridman on his President Donald Trump will speak with Russian President

Vladimir Putin on Tuesday as efforts continue to end the war in Ukraine, a move that could represent a possible pivot point in the conflict and an opportunity for Trump to continue reorienting American foreign policy.

Trump disclosed the upcoming conversation to reporters while flying from Florida to Washington on Air Force One on Sunday evening, while the Kremlin confirmed Putin's participation on Monday morning

"We will see if we have something to announce maybe by Tuesday. I will be speaking to President Putin on Tuesday," Trump said. "A lot of work's been done over the weekend. We want to see if we can bring that war to an end."

Kremlin spokesman Dmitry Peskov on Monday morning confirmed the plans for the two leaders to speak on Tuesday, but refused to give details, saying that "we never get ahead of events" and 'the contents of conversations between two presidents are not subject to any prior discussion."

European allies are wary of Trump's affinity for Putin and his

hardline stance toward Ukrainian President Volodymyr Zelenskyy, who faced sharp criticism when he visited the Oval Office a little more than two weeks ago.

Although Russia failed in its initial goal to topple Ukraine with its invasion three years ago, it still controls large swaths of the coun-

During his conversation with reporters on Air Force One, Trump said he was pushing forward with his plans for tariffs on April 2 despite recent disruption in the stock market and nervousness about the economic impact.

"April 2 is a liberating day for our country," he said. "We're getting back some of the wealth that very, very foolish presidents gave away because they had no clue what they were doing.'

Trump has occasionally changed course on some tariff plans, such as with Mexico, but he said he had no intention of doing so when it comes to reciprocal tariffs. "They charge us and we charge

them," he said. "Then in addition to that, on autos, on steel, on aluminum, we're going to have some additional tariffs." (AP)

Chagos Islanders seek to take UK government to court over deal with Mauritius

LONDON, March 17: Two women born on the Chagos Islands are seeking to take the British government to court over a proposed deal to transfer sovereignty of the disputed Indian Ocean archipelago to Mauritius. Lawyers for the two women argued Monday that it was unlawful to exclude Chagossians from deciding the future of the tropical archipelago, home to a strategically important UK-US naval and bomber base.

The UK government announced in October that it intends to hand the Chagos Islands to Mauritius - though Britain would retain control of Diego Garcia, the largest island where the military base is located.

But negotiations have stalled, pending agreement from US President Donald Trump's government.

Britain evicted hundreds of people from the remote islands in the 1960s and 1970s so the US military could build the base on Diego Garcia. Many of the islanders were relocated to the UK and have faced legal challenges returning to their birthplace. Bernadette Dugasse and Bertrice Pompe. both British citizens, fear it will become even harder to go back to live where they were born once Mauritius takes control of the islands.

"Chagossians were removed from their place of birth, without their consultation, and have been treated badly for 60 years," said Pompe. "Since then we have been struggling to understand why we have been treated so poorly by the British government. I want to stay British and I also want the right to return to the Chagos Islands." (AP)

Radical Islamist party intensifies its action against Ahmadi community in Pakistan

LAHORE, March 17: A radical Islamist party in Pakistan has intensified its action against the minority Ahmadi community, forcibly stopping its members from offering special Friday prayers in several cities of Punjab and also torturing them, a community organisation said on Mon-

Last Friday, the Tehreek-e-Labbaik Pakistan (TLP) members surrounded the worship places of Ahmadis in Faisalabad, Sargodha, Layyah, Gujranwala, Sialkot, Bahawalpur and Okara districts of Punjab and threatened the Ahmadi worshippers to stop offering Friday prayers, Jamaat-e-Ahmadiyya Pakistan (JAP) said. (PTI)

Trump administration deports hundreds of immigrants even as a judge orders their removals be stopped

WASHINGTON, March 17: The Trump administration has transferred hundreds of immigrants to El Salvador even as a federal judge issued an order temporarily barring the deportations under an 18th century wartime declaration targeting Venezuelan gang members, officials said Sunday. Flights were in the air at the time of the ruling.

US District Judge James E. Boasberg issued an order Saturday temporarily blocking the deportations, but lawyers told him there were already two planes with immigrants in the air - one headed for El Salvador, the other for Honduras. Boasberg verbally ordered the planes be turned around, but they apparently were not and he did not include the directive in his written order.

White House press secretary Karoline Leavitt, in a statement Sunday, responded to speculation about whether the administration was flouting court orders: "The administration did not refuse to comply' with a court order. The order, which had no lawful basis, was issued after terrorist TdA aliens had already been reoved from U.S. territory."

The acronym refers to the Tren de Aragua gang, which Trump targeted in his unusual proclamation that was released Saturday. In a court filing Sunday, the Department of Justice, which has appealed Boasberg's decision, said it would not use the Trump proclamation he blocked for further depor-

tations if his decision is not overturned. Trump's allies were gleeful over the results

"Oopsie...Too late," Salvadoran President Nayib Bukele, who agreed to house about 300 immigrants for a year at a cost of \$6 million in his country's prisons, wrote on the social media site X above an article about Boasberg's ruling. That post was recirculated by White House communications director Steven Cheung.

Secretary of State Marco Rubio, who negotiated an earlier deal with Bukele to house immigrants, posted on the site: "We sent over 250 alien enemy members of Tren de Aragua which El Salvador has agreed to hold in their very good jails at a fair price that will also save our taxpayer dollars.

Steve Vladeck, a professor at the Georgetown University Law Center, said that Boasberg's verbal directive to turn around the planes was not technically part of his final order but that the Trump administration clearly violated the "spirit" of



This just incentivizes future courts to be hyper specific in their orders and not give the government any wiggle room," Vladeck said.

The immigrants were deported after Trump's declaration of the Alien Enemies Act of 1798, which has been used only three times in U.S. history.

The law, invoked during the War of 1812 and World Wars I and II, requires a president to declare the United States is at war, giving him extraordinary powers to

detain or remove foreigners who otherwise would have protections under immigration or criminal laws. It was last used to justify the detention of Japanese-American civilians during World War II.

Venezuela's government in a statement Sunday rejected the use of Trump's declaration of the law, characterizing it as evocative of "the darkest episodes in human history, from slavery to the horror of the Nazi concentration camps."

Tren de Aragua originated in an infamously lawless prison in the central state of Aragua and accompanied an exodus of millions of Venezuelans, the overwhelming majority of whom were seeking better living conditions after their nation's economy came undone during the past decade. Trump seized on the gang during his campaign to paint misleading pictures of communities that he contended were "taken over" by what were actually a handful of lawbreakers.

The Trump administration has not identified the immigrants deported, provided any evidence they are in fact members of Tren de Aragua or that they committed any crimes in the United States. It also sent two top members of the Salvadoran MS-13 gang to El Salvador who had been arrested in the United States.

Video released by El Salvador's government Sunday showed men exiting airplanes onto an airport tarmac lined by officers in riot gear. The men, who had their hands and ankles shackled, struggled to walk as officers pushed their heads down to have them bend down at the waist. The video also showed the men being transported to prison in a large convov of buses guarded by police and military vehicles and at least one helicopter. The men were shown kneeling on the ground as their heads were shaved before they changed into the prison's all-white uniform - knee-length shorts, T-shirt, socks and rubber clogs — and placed in cells.

The immigrants were taken to the notorious CECOT facility, the centerpiece of Bukele's push to pacify his once violencewracked country through tough police measures and limits on basic rights

The Trump administration said the president actually signed the proclamation contending Tren de Aragua was invading the United States on Friday night but didn't announce it until Saturday afternoon. Immigration lawyers said that, late Friday, they noticed Venezuelans who otherwise couldn't be deported under immigration law being moved to Texas for deportation flights. They began to file law-

suits to halt the transfers.

"Basically any Venezuelan citizen in the US may be removed on pretext of belonging to Tren de Aragua, with no chance at defense," Adam Isacson of the Washington Office for Latin America, a human rights group, warned on X.

The litigation that led to the hold on deportations was filed on behalf of five Venezuelans held in Texas who lawyers said were concerned they'd be falsely accused of being members of the gang. Once the act is invoked, they warned, Trump could simply declare anyone a Tren de Aragua member and remove them from the country.

Boasberg barred those Venezuelans' deportations Saturday morning when the suit was filed, but only broadened it to all people in federal custody who could be targeted by the act after his afternoon hearing. He noted that the law has never before been used outside of a congressionally declared war and that plaintiffs may successfully argue Trump exceeded his legal authority in invoking it. The bar on deportations stands for up to 14 days and the immigrants will remain in federal custody during that time. Boasberg has scheduled a hearing Friday to hear additional arguments in the case. (AP)

Security forces seize firearms in Manipur's Bishnupur

IMPHAL, March 17: Security forces seized firearms and ammunition during a search operation in Manipur's Bishnupur district, police said on Monday.

One 5.56 mm Insas rifle, two 9 mm carbine machine guns, one .303 modified sniper with magnifier scope, one SBBL gun, one pistol, four hand grenades, and cartridges were seized from the vicinity of Uyok forest on Sunday

Police also said that intelligence-based combing operations and cordon and search operations are being carried out in both hill and valley districts to recover all the looted and illegal weapons in the state.

Meanwhile, security forces ensured movement of 475 vehicles carrying essential items along NH-2 (Imphal to Dimapur) and strict security measures have been taken up in all vulnerable locations as well and security convoy is provided in sensitive stretches to ensure free and safe movement of the vehicles. (PTI)

Clashes between the Hmar and Zomi communities led to stone pelting Prohibitory orders imposed in Manipur's Churachandpur amidst rising tensions

IMPHAL/CHURACHAND-PUR, March 17: Manipur's Churachandpur administration on Monday imposed prohibitory orders across the district following clashes between the Hmar and Zomi communities, a day after a Hmar tribal leader was assaulted amidst demands from the community to identify the perpetrators, police said

According to the additional district magistrate, the prohibitory orders have been imposed under Section 163 of the BNSS 2023. "Whereas reports have been re-

ceived from the Superintendent of Police, Churachandpur, indicating a serious apprehension of a breach of law and order in the district, which is likely to disturb peace and tranquillity among different communities and may lead to damage to life and public property," the order stated. To prevent further escalation, unauthorised processions or unlawful assemblies of five or more people have been banned, along with the carrying of weapons, including sticks, rods and stones, it added



Throughout the day, protesters attempted to enforce a shutdown, urging shops to close immediately. Groups of men patrolled the streets with sticks, while clashes between the Hmar and Zomi communities led to stone pelting in multiple areas of the district headquarters. Central security forces intervened, firing gunshots in the air to

disperse mobs, officials said. According to officials, general secretary Richard Hmar of Hmar Inpui, one of the apex bodies of the

tribe, was attacked by a group of men inside the VK Montessori complex at Zenhang Lamka around 7.30pm on Sunday.

Strongly condemning the incident, Hmar Inpui issued a statedemanding that the ment perpetrators be handed over immediately and warned that failure to comply would result in it taking "its own course of action."

Tripura aims to install 50,000 solar plants in 2025: Minister 1-kilowatt plant can generate around 100 units of electricity per month

AGARTALA, March 17: The Tripura government has set an ambitious goal of installing 50,000 solar plants across the state during the current financial year, power minister Ratan Lal Nath announced on Sunday

Speaking at the inauguration of a registration camp for the Pradhan Mantri Surya Ghar Muft Bijli Yojana at Ranirgaon Vidyalaya in Jirania, Minister Nath highlighted that 12,800 solar plants have already been installed as part of the initiative.

He emphasised that the scheme, launched by Prime Minister Narendra Modi on February 13, 2024, aims to promote rooftop solar energy, enabling households to generate their own electricity and reduce their dependency on traditional power sources.



"Government subsidies are being provided to encourage the installation of solar plants," the minister said. "For a 3-kilowatt system, consumers will receive a subsidy of up to ₹85,800. A 1-kilowatt solar plant, which costs ₹ 65,000, will have a subsidv of ₹ 33,000, while a 2-kilowatt unit costing ₹ 1,30,000 will get a subsidy of ₹ 66,000.'

Highlighting the benefits of solar power, Nath stated that a 1-kilowatt plant can generate around 100 units of electricity per month. This not only helps in lowering household electricity expenses but also offers the opportunity to sell surplus power, generating additional income for consumers.

"These solar systems can be installed on rooftops, tin sheds, or open spaces, with a lifespan of around 25 years," he added.

To ensure widespread adoption, registration camps are being held across Tripura, urging residents to take advantage of the scheme. The event also saw the presence of tourism minister Sushanta Chowdhury as a special guest.

AIMPLB stages protest against Waqf Bill; 'One district, one mafia' era in UP replaced Owaisi cautions TDP, JD(U), LJP (Ramvilas) with One District, One Product: Adityanath



NEW DELHI, March 17: The All India Muslim Personal Law Board on Monday led a protest against the Waqf (Amendment) Bill which was joined by several MPs, with AIMIM chief Asaduddin Owaisi cautioning NDA constituents TDP, JD(U) and LJP (Ramvilas) that Muslims will never forgive them if they support the legislation.

A host of Muslim organisations joined hands under the aegis of the All India Muslim Personal Law Board (AIMPLB) to stage the demonstration at the Jantar Mantar here

Speaking at the protest site, Owaisi claimed the Narendra Modi government's intention to bring the Waqf Bill is to disturb peace in the country

"The prime minister's intention is that people keep fighting over Mandir-Masjid. Safeguarding Waqf properties is not the bill's objective," the AIMIM chief said.

"The bill attempts to take way Muslims' mosques, dargahs and cemeteries. We are cautioning (TDP chief) Chandrababu Naidu, (LJP-Ramvilas chief Chirag) Paswan Sahab and (JD-U's) Nitish Kumar -- remember that if you support this bill at this critical juncture, Muslims will not forgive you ever because it would be passed with your support," Owaisi said.

"Don't support this unconstitutional bill," he added.

The five-term MP from Hyderabad also pointed out that the bill allows for non-Muslims to be part of the Waaf council and boards. whereas in the management of endowments of other religions, only those belonging to that community are made members.

"The government is going to take an unconstitutional and anti-Muslim step," Owaisi said.

Speaking to reporters at the protest site, Congress leader and former minority affairs minister Salman Khurshid claimed that the bill is not valid constitutionally and people are not satisfied with it Shia cleric Kalbe Jawad alleged

that the bill's sole intention is to grab Waqf properties.

"Waqf grants Muslims the same rights that other religions enjoy over their institutions. If every faith has the right to administer its affairs, why are Muslims being singled out," Syed Sadatullah Husaini, president of Jamaat-e-Islami Hind and vice-president of AIM-PLB, asked.

Polical leaders from a host of opposition parties took part in the protest, raising questions over the government's intention behind moving the Waqf (Amendment) Bill by overlooking their concerns. "We are supporting the protest against the Waqf Bill. It is against

our Muslim brothers... The government is eying their lands. By rejecting all the suggestions of the opposition, the government has shown what its intention is. We are against this bill," Samajwadi Party leader Dharmendra Yadav said. Yadav's party colleague from Sambhal, Ziaur Rahman Barq, said

they have been opposing the bill since it was introduced in Parliament Accusing the government of creating a rift in the society, Tri-


namool Congress MP Shatrughan Sinha said, "This is divisive politics... No religion or community should be targeted like this. They are trying to sideline a community, which is not going to work. If they force this bill on the basis of brute majority, there will be protests." The government should call an all-party meeting on this issue, the actor-politician added.

Claiming that the opposition members' suggestions to the joint parliamentary committee were rejected, Congress leader Gaurav Gogoi said, "It shows the government does not want to resolve any issue, but just wants to create a divide in the society. We want the country to function as per the Constitution." The 'dharna' was to be held on March 13 but was postponed in view of holidays on account of Holi.

AIMPLB spokesperson S Q R Ilyas said that after careful consideration, the board came to the conclusion that the proposed legislation will pave the way for the "usurping" of Waqf properties, which would be a "direct attack" on Muslims.

The protest came amid the ongoing Budget Session during which the Waqf Bill could be introduced with the joint parliamentary committee having submitted its report on the proposed legislation.

The 31-member panel on the bill, after multiple sittings and hearings, suggested several amendments to the proposed legislation, even as the opposition members disagreed with the report and submitted dissent notes. (PTI)

"Every district had a mafia under the previous government. We replaced that with One District, One Product so that artisans and local products get global recognition and reate jobs," the chief minister said. Without naming former chief minister and Samajwadi Party chief Akhilesh Yadav, Adityanath said, "If the leader of a state wakes up at noon, gets ready by 2 pm and then goes on picnics with his friends, when will he work? The public suffered while his associates looted the state.

Adityanath also highlighted his government's focus on connectivity, stating that efforts are underway to reduce travel time from Saharanpur to Delhi to just 1 hour and 45 minutes.

Underlining the impact of the One District, One Product (ODOP) scheme, he noted that Saharanpur's renowned wood carving industry

Criticising previous governments for neglecting artisans, the chief minister said, "Earlier, these craftsmen existed but the old governments were too busy turning them into vote banks. They never cared about providing them with better designs, technology, packaging, or export facilities.

Adityanath also underscored his government's efforts in employment generation, pointing out that during Holi, the state announced 60,244 recruitments in the police force, including many for Saharanpur vouths. He noted that over 12,000 of these police jobs were secured by women.

"From 1947 to 2017, there were only 10,000 women in Uttar Pradesh Police. In just one recruitment drive, we added over 12,000 daughters to the force," he said. adding that his administration has provided over 7 lakh government jobs so far, with no allegations of nepotism or regional bias.

The chief minister further said, "This government is here to recognise and support your hard work. It is not meant for dynastic politics where a handful of people loot power for themselves.

Encouraging young entrepre-neurs, he said, "Remember, in business, one must have a sense of satisfaction, avoid unnecessary greed and have the passion to work hard. Having knowledge about the field we are entering and advancing based on that knowledge ensures that there will be no problems."

On the BJP-led governments at the Centre and in Uttar Pradesh, Adityanath said that when a double-engine government works, public welfare and national interest remain the top priorities. He described the recently concluded Maha Kumbh as a grand event that witnessed the arrival of over 66 crore devotees in Prayagraj.

He praised the hospitality shown by the people of Prayagraj and surrounding districts, saying, "Because of the Maha Kumbh, people from different sectors found opportunities -- some started tea stalls, some sold vegetables, some offered taxi services, some ferried passengers on boats, while others supplied goods, earning crores of rupees." ity. "There are several such NGOs in the state, which are registered on religious basis and are also getting funds from abroad. In Bastar dis-

president K Annamalai, the party's women's wing national chief Vanathi Srinivasan and senior state leader H Raja were among the party leaders who were detained here on Monday by the police ahead of their protest against the alleged irregularities in state-run liquor retailer TASMAC.

The saffron party had announced a picketing protest of the TASMAC headquarters here over the alleged ₹ 1,000 crore irregularities, as claimed by the Enforcement Directorate recently. The BJP found support from the most un-

expected corner, with its strident critic and DMK ally VCK welcoming the protest, from the prohibition point of view.

Annamalai lashed out at the ruling DMK and its party president and Chief Minister M K Stalin, alleging the "rupee symbol and budget drama" were an attempt to divert attention from the recent ED raids at the Tamil Nadu State Marketing Corporation (TAS-MAC), besides other entities.

Annamalai, clad in a black shirt, was detained near his house along with his supporters by the police.

In a social media post, the BJP state chief alleged senior party leaders including former state president and ex-Governor of Telangana, Tamilisai Soundararajan have been placed "under house arrest" by the police. Senior BJP leaders including H Raja, Pon Radhakrishnan, BJP Mahila Morcha chief

"The use of foreign funding in conversion cannot be denied. Though the government claims to have banned such funds, the institutions find their way by not providing audit reports," Chandrakar claimed. In his reply, Deputy CM Sharma said it is not correct to say that incidents of conversion are increasing due to lack of control of the local administration on NGOs. He said police conducts proper investigation and takes prompt legal action when complaints are received about people being lured to convert at such healing meetings.

Sharma said one case was lodged in 2020, seven in 2021, three in 2022, nil in 2023, a total of 12 in 2024 and four cases so far in 2025. (PTI)

Ex-Union minister Debendra Pradhan dies at 84, Prez, PM mourn

BHUBANESWAR, March 17: Veteran BJP leader Debendra Pradhan, who was a minister in the Atal Bihari Vajpayee government, died on Monday

He was 84 and survived by two sons, including Union Education Minister Dharmendra Pradhan.

Pradhan, the three-time Odisha BJP president, breathed his last at his son's official residence at Teen Murti Lane in New Delhi.

Condoling his death, President Droupadi Murmu said that having known him for many years, she got the opportunity to witness his dedication to public service and contribution to the development of Odisha and the nation.

"My heartfelt condolences to his son and Union Minister Shri Dharmendra Pradhan, other family members and admirers," she said in a post on X

Prime Minister Narendra Modi paid floral tributes to Pradhan's mortal remains, and hailed his efforts in strengthening the BJP in Odisha

"Dr Debendra Pradhan Ji made a mark as a hardworking and humble leader. He made numerous efforts to strengthen the BJP in Odisha. His contribution as MP and Minister is also noteworthy for the emphasis on poverty alleviation and social empowerment. Pained by his passing away. Went to pay my last respects and expressed condolences to his family. Om Shanti," Modi posted on X. Several Union ministers also visited the Teen Murti Lane residence to pay their respects.

Pradhan, a doctor by profession, started his journey in politics in Talcher and rose from the grassroots level. He first became the BJP's state president in 1988 and continued in the post for consecutive two terms till 1993. He returned to the post in 1995 and remained there till 1997. He won the 1998 Lok Sabha elections from the Deogarh seat and was re-elected again in 1999.

Chief Minister Mohan Charan Majhi said he was a popular public leader and an able parliamentarian.

"He had discharged his duties as the Union Minister for Transport and Agriculture from 1999 to 2001 with efficiency. As a public representative and MP, he had become the object of the common people's affection by doing many welfare works," Maihi said. (PTI)

Despite a budgetary allocation of Rs 14,164.42 crore for the fiscal 2025-26, several schemes remain underfunded, limiting their reach and impact.

The panel particularly emphasised the need to improve the effiof fund utilisation, ciency highlighting that large sums of money remain unspent due to procedural delays and administrative inefficiencies

It criticised the delayed submission of proposals and utilisation certificates by the state governments resulting in the accumula-

tion of unspent funds in the Single Nodal Agency (SNA) accounts.

As of February, the total unspent balance in SNA accounts stood at Rs 2,779.32 crore, down from Rs 5,055.93 crore the previous year.

The committee urged the ministry to work closely with the states to expedite the completion of necessary formalities, enabling quicker fund disbursement.

Additionally, the report highlighted a lack of transparency and coordination between the ministry and implementing agencies.

It expressed concern that the Ministry of Social Justice and Empowerment's heavy reliance on the state governments for execution has led to inconsistent implementation and delays in delivering benefits to the intended recipients.

The panel called for a more robust monitoring mechanism to track fund disbursement and ensure better accountability.

The committee further noted that while the budgetary allocation increased marginally over the years, the funds have not been proportionately utilised for critical welfare programmes. (PTI)

Engineer Rashid can't be allowed to use legislator status for reprieve: NIA to Delhi HC

NEW DELHI, March 17: The National Investigation Agency (NIA) on Monday said jailed Jammu and Kashmir MP Sheikh Abdul Rashid alias Engineer Rashid's couldn't be allowed to use his status to "get away from the rigours of imprisonment"

The NIA's response in the Delhi High Court came on Rashid's plea against a March 10 trial court order refusing him custody parole or interim bail to attend Lok Sabha proceedings till April 4.

The Baramulla MP, the probe agency said, faced serious charges under the anti-terror law Unlawful Activities (Prevention) Act (UAPA). The NIA argued Rashid could neither be granted an interim bail nor allowed custody parole for he had no enforceable right to attend Parliament session while in lawful custody. (PTI)

ISRO Kulasekarapattinam spaceport will see first SSLV launch in 2027



CHENNAI, March 17: The Kulasekarapattinam spaceport in Tamil Nadu's Thoothukudi district, the second launch complex for ISRO outside Andhra Pradesh, will see the maiden launch with the Small Satellite Launch Vehicle (SSLV) in 24 months, chairman of the space agency V Narayanan said on Monday

The Indian Space Research Organisation (ISRO) SSLV will primarily support polar launches of upto 500 kg, with Indian industry involved in its production.

"All facilities will be commissioned for launch in 24 months. The first launch will take place in two years. Don't think it will be literally small in size. It will be a 500 kg satellite," Narayanan told reporters after inaugurating a new research centre at the Indian Institute of Technology Madras - 'S Ramakrishnan Centre of Excellence for Research in Fluid and Thermal Science (ISRO-IITM).

Named after the former director of and a distinguished alumnus of IIT Madras, the Centre inaugurated in the presence of IIT-Madras director Prof V Kamakoti, will support 'Atmanirbhar Bharat' initiatives, promoting self-reliance in advanced space technologies and attract global talent and research funding.

"This will position India as a leader in thermal sciences research for space applications," the IIT Madras said.

Narayanan said the Centre would contribute immensely for the country's development. "Whether it is rocket launch vehicle, or satellite, thermal and fluid flow plays a very vital role, especially on how to handle the heat or thermal energy which is generated," Narayanan said.

During this year, ISRO has planned a series of launches including GSLV, a commercial satellite from the USA, and unmanned test mission with humanoid as part of the Gaganyaan mission, Narayanan told reporters.

The state-of-the-art research Centre, housed in the Department of Mechanical Engineering, will focus on critical advancements in spacecraft and launch vehicle thermal management — a key area for India's expanding space ambitions. The centre will serve as a nodal centre

for research in heat transfer, cooling sys-

tems and fluid dynamics. These are essen-ISRO's Vikram Sarabhai Space Centre tial for the next generation of spacecraft and satellite technologies. Scientists and engineers from ISRO will work alongside faculty and researchers from IIT Madras to address complex thermal challenges in space applications.

"This initiative is a game-changer for India's space program as thermal control is vital to satellite longevity, spacecraft safety, and mission success. The research at this Centre of Excellence (CoE) will directly impact upcoming lunar, Mars, and deep-space missions, ensuring India remains at the forefront of space technology," the institute said.

Also, the 'Arcot Ramachandran Seminar Hall' was inaugurated by Kamakoti, on the occasion.

Arcot Ramachandran (1923 - 2018), a world-renowned Professor of Heat Transfer, was the Director of IIT Madras between 1967 and 1973. He was instrumental in establishing the Heat Transfer and Thermal Power lab at IIT Madras.

Centre Coordinator Prof Arvind Pattamatta, Head, Department of Mechanical Engineering, IIT Madras Prof P Chandramouli, and Professor of Practice, Department of Mechanical Engineering, IIT Madras, P V Venkitakrishnan, too, were among those who participated. (PTI)

NEW DELHI, March 17: In a tournament that has fans flocking the grounds to see batters smash everything out of the park, bowlers have gradually established themselves as the cornerstone of success and the upcoming edition of IPL is going to be no different.

If one looks at the bowling units of various IPL outfits, defending champions Kolkata Knight Riders, five-time champions Mumbai Indians and last year's runners-up Sunrisers Hyderabad have the most balanced line-ups.

With all-rounders rendered less useful due to the Impact Player Rule, most teams now look at playing five specialist bowlers. Some even have luxury of playing the sixth bowler if need be while defending a total.

So, what makes KKR special in terms of bowling? In Harshit Rana, who has the uncanny ability of taking wickets with sheer pace and extra bounce, they have a potent Indian fast bowling option.

He would be supported by Varun Chakravarthy, who has been India's T20 trump card in recent years.

Add to that mix Anrich Nortje's blistering pace and Sunil Narine's guile, and 16 overs will be sorted for the side on most days.

The uncapped Vaibhav Arora was impressive last year and there is Andre Russell too who can always chip in with an over or two. In all of KKR's seven home games at the Eden Gardens, this attack cane be expected to be lethal.

In addition, Ramandeep Singh, and vice-captain Venkatesh Iyer can chip in with an over or two as per the team's requirements.

In case Nortie doesn't fire, there is the six-foot leftarmer Spencer Johnson. On tracks like the one in Chennai, Moeen Ali's off breaks could also be handy. By the look of things, KKR does have the best bowling attack on paper.

Ensure gender parity of athletes in events: Delhi HC to sports ministry

NEW DELHI, March 17: The Delhi High Court has directed the central sports ministry to ensure parity when it comes to participation of men and women athletes in the events of the national sports federations.

Justice Sachin Datta also directed the ministry to ensure that the pool of participating athletes was "broad enough" to include not only the athletes who had participated in international events, but it must also adequately accommodate those who participated in domestic or local or Khelo India sporting events.

The court order of March 12 came on a plea challenging a February 13, 2025 notification issued by the Badminton Association of India (BAI), restricting the participation of women para-athletes by providing them with only eight slots per event whereas men paraathletes received 16 slots.

"It is a matter of record that female athletes have brought significant sporting glory to the country and this court cannot countenance a situation where equilibrium is not maintained between the male and female contingents in sporting events," it added.

The judge said the allocation of lesser slots to women para-athletes did not commend itself to the court.

The principle of gender parity in sports was mandated under constitutional provisions as also in terms of the National Sports Development Code of India, 2011, it said.

The court added, "... it is directed that the Ministry of Youth Affairs and Sports must endeavour to ensure that parity is maintained in the participation of male and female athletes in sporting events organised by the National Sports Federations.

The court, as a result, disposed of a plea of one Rahul Kumar Verma challenging the BAI's circular, notifying the selection criteria for participation in the para-badminton events under the second Khelo India Para Games, 2025, to be held in Delhi between March 20 and March 22.

The plea said the notification amounted to discrimination against women athletes and was contrary to the National Sports Development Code of India, 2011.

The court also termed as "untenable" the submission of BAI's counsel who attributed the reduced slots of the women para-athletes to the reduced pool of performing international athletes in the sporting events concerned.

The second edition of the Khelo India Para Games (KIPG 2025) is set to kick off on Thursday and Navdeep, an Arjuna awardee, feels the tournament will help in developing the sporting ecosystem for para athletes "KIPG 2025 is a great platform

for senior athletes to compete against each other. We also motivate each other at all times. It further helps us in testing our training modules and practice our strengths and weaknesses before international competitions.

"We also get a chance to meet with budding athletes and get to exchange different ideas and

thoughts on the competitions," Navdeep told SAI Media.

Over 1200 para athletes will participate across six disciplines in the seven-day tournament at three venues ---Jawaharlal Nehru Stadium, Indira Gandhi Stadium and the Dr Karni Singh shooting range -- in New Delhi.
