

# Delay in submission of UCs affecting fund release: Patowary Oppn demands special package for 'chars' to address development gaps

GUWAHATI, March 7: Opposition parties of Assam on Friday demanded a special package for 'chars' (riverine vegetative islands), maintaining that residents of these areas lack adequate education, healthcare and other basic facilities.

The government, however, claimed that "development and welfare of char areas are being pursued through various schemes and there was no need for a special package."

Congress MLA Abdul Batin Khandakar had moved the resolution in the Assembly urging the government to grant special package to mitigate the development disparity of the char areas.

Claiming that the char areas, inhabited mostly by Bengal-Muslims, "lack adequate basic facilities," Khandakar said there was a need to "increase literacy rate in these parts and ensure more economic activities.'

He said high population growth rate is also an issue in the char areas, with "low literacy rate being a prime reason for it."

Another Congress legislator, Abdur Rasheed Mandal, said there is an "urgent need for a survey of the char areas and special budgetary allocation for undertaking development activities.'

Supporting him, AIUDF legislator Ashraful Hussain pointed out that the last socio-

Parliamentary Affairs Minister Chandra Mohan Patowary, replying on behalf of the Minority Affairs minister, said, "Funds for some Central schemes for minorities were being held up as submission of a large number of utilisation certificates (UCs) were pending since 2008.'

"We have been working overtime to get the UCs and many have been submitted over the last three years, leading to release of money by the Centre. Once more UCs are submitted, more funds will come," he added.

Patowary said there are varied reasons for non-submission of UCs, many of which are peculiar to the char areas which annually face flood and erosion problems, and the state has requested the Centre for special consideration

He elaborated on various work being undertaken for minority welfare, including in char areas, in education, health and other

The minister maintained that there was no need for any special package for char areas as the regular schemes and programmes were ensuring development in these parts.

JORHAT, March 7: Gaurav Gogoi, Member of Parliament (MP) for Jorhat and deputy leader of the opposition in the Lok Sabha, emphasised the need to enhance the higher education sector in Assam and across India.

His comments came in response to concerns over the significant number of students leaving Assam — and even going abroad — to pursue higher education.

According to Gogoi, one of the key reasons students go abroad for higher education is the lower cost of education.

'When the Russia-Ukraine war broke out, it was found that a large number of Indian students, including many from Assam, were studying medical science in Ukraine," he added, while responding to a query during an interactive youth programme titled Bartalap, held at the Jorhat Science Centre and Planetarium auditorium on Thursday evening. 
Allahbadia landed in Guwahati on Friday and headed directly to the Crime Branch office. To avoid con-

GUWAHATI, March 7: Women investors are making strategic and substantial investments, taking steps toward securing their financial future, said a survey.

The survey was done on investment patterns of 1 lakh women investors from January 1, 2024 to December 31, 2024 by PhonePe Wealth. This International Women's Day, PhonePe Wealth highlights the steady rise in women's participation in Mutual Funds on its platform, along with their growing commitment and contribution amounts.

## US wants macro, grand trade pact with India; not 'product-by-product': Lutnick

NEW DELHI, March 7: The US on Friday pitched for a macro, large and grand trade agreement with India, and not 'product-by-product' arrangement to boost bilateral ties between the two countries. US Commerce Secretary Howard Lutnick said India needs to open its agriculture market, emphasising that it can not be 'off the table' when the country is negotiating with its largest trading partner.

"Because India is so gigantic, and the US is so gigantic, the right way to do it (trade pact) is a macro, and that's why we think we can get it done. The US is interested in doing a macro, large-scale, broad-based trade agreement with India that takes everything into account and that I think it can be done

"...it's time to do something big, something grand, something that connects India and the US together, but does it on a broad scale, not product-by-product, but rather the whole thing. Let's bring India's tariff policy towards America down," he said at the India Today Conclave. In the agriculture sector, he said the Indian market for agriculture has to open up, and it can not just stay closed. "Now, how do you do that? And the scale by which you do that? Maybe you do quarters. Maybe do limits. You can be smarter when you have your most important trading partner on the other side of the table. You can't just say...it's off the table. That's just not an attractive way of doing business," Lutnick said. (PTI)

Furthermore, Gogoi observed that a significant number of bright teachers and research scholars from India are attracted to foreign educational institutions due to the lucrative salary packages, fellowships, stipends, and better academic environments and opportunities offered abroad.

"Educational institutions in foreign nations receive funding from both government and private sectors. The higher education sector in India should be given more focus on the government's priority list," he added.

In response to a query about the increasing use of Artificial Intelligence (AI) across industries, Gogoi acknowledged that AI is part of emerging new technologies globally and should not be opposed.

He mentioned that when computers and the internet were first introduced, there were similar fears about them causing unemployment. However, over time, people learned to use these technologies in daily life. To tackle unemployment, Gogoi stressed the need to boost labour-intensive industries such as handloom, textiles,

apparel, tourism, hospitality, shoes, and pharmaceuticals, by providing skill development training to youth. He also emphasised that steps to improve the state's 200-year-old tea industry should be high on the agenda, as

this industry employs a large number of people. Additionally, Gogoi reiterated the importance of improving air and road connectivity to Upper Assam areas. He stated that he has been urging the central government to introduce regular daily flights between Delhi and Jorhat. The MP also mentioned his past meetings and letters to Union Minister of Road Transport and Highways Nitin

Gadkari, urging immediate steps to improve the deplorable condition of the stretch of NH 715 (formerly NH 37) between Jorhat and Dibrugarh, and to expedite the completion of the four-lane project for this highway.

Ankur Jain led the police team in questioning Allahbadia, whose comments on the YouTube show sparked an uproar on the internet

"He reached the Crime Branch office around 12:30 PM, and the interrogation lasted for over four hours. He cooperated with the police and answered all our questions," Jain told reporters after the interrogation.

Allahbadia was scheduled to appear before the police on March 4, but he failed to attend. Earlier, the Guwahati Crime Branch also questioned another YouTuber, Ashish Chanchlani, who became embroiled in the same controversy due to his comments during an episode of the show. Jain also informed that police yet receive responses from other individuals involved in the investigation. Meanwhile, the Gauhati High Court on Friday granted anticipatory bail The high court had on February 18 granted interim bail to Chanchlani in the case. to Chanchlani.

"After going through the case diary, the high court granted anticipatory bail to the petitioner," his advocate Joyraj Borah told PTI.

Along with Borah, Chanchlani's counsels Hiranya Kumar Nath, Apoorv Srivastava and Avinash Lalwani argued that their client appeared before the investigating officer and cooperated in the case as per the previous directions of the HC.

"I think the entire political spectrum of the INDIA political parties are opposed to the content, intent and extent of the bill. The manner in which the bill was bulldozed through made a mockery of Parliament's joint committee process," he alleged.

'The Waqf (Amendment) bill is controversial and it is going to be opposed lock, stock and barrel," the Con-

gress' general secretary in-charge communications said. He asserted that the Congress will oppose the bill "tooth, nail and hammer" because it was the most unnec-

essary and the manner in which Parliament's joint committee functioned was "undemocratic" "Some witnesses were called selectively, some witnesses were not called. Most importantly perhaps for the first time in parliamentary history a joint committee had submitted a report on a bill without a clause-by-clause discussion on the bill," Ramesh said. Ramesh said he had been a member of the JPC on the data protection bill that was chaired by a BJP MP but inspite of that a clause-by-clause discussion was done.

"Both in Lok Sabha and Rajya Sabha at least five ministries will be taken up. We have given our list of ministries -- home, education, social justice, railways and health. That is going to be decided very shortly, our suggestions have already gone," Ramesh informed.

Then there will be a debate on the finance bill and there will be a debate on the appropriation bill, he said. The 31-member panel on the Waqf (Amendment) Bill, after multiple sittings and hearings, had suggested several amendments to the proposed legislation even as the opposition members disagreed with the report and submitted their dissent notes.

The panel's 655-page report was submitted to Lok Sabha Speaker Om Birla on January 30. The joint committee of Parliament had adopted the report that contained changes suggested by members from the ruling BJP by a majority vote of 15-11. The move prompted the opposition to dub the exercise an attempt to destroy Waqf boards.

The Bill was referred to the joint committee of Parliament on August 8, following its introduction in the Lok Sabha by Union Minority Affairs minister Kiren Rijiju.

Asked about the differences among INDIA bloc parties in assembly polls held after the Lok Sabha elections, Ramesh said it was not "unnatural" as the INDIA group was formed to fight the Lok Sabha election and not to fight thr state assembly elections. "When we formed the INDIA bloc we knew that we were fighting the Left in Kerala, we were fighting TMC in West Bengal... So, INDIA group was for the Lok Sabha election, it was not for fighting assembly elections. But we had state-level alliances. We had an alliance with DMK in Tamil Nadu, we have a long-standing alliance with the NCP (SP) of which Shiv Sena (UBT) has been a part since 2019, we have been in alliance with RJD for many years in Bihar, we have been in alliance with JMM in Jharkhand," he said.

"But the INDIA group was for the Lok Sabha polls so I am not surprised or disappointed that we fought each other in the state assembly polls that is the nature of the INDIA alliance," Ramesh asserted.

He said the INDIA bloc will be coordinating closely in the upcoming second half of the Budget session. The first half of the Budget Session was held from January 31 to February 13. The second half starts on Monday and will conclude on April 4. (PTI)

# **Adulterated Boondi with** poisonous colours flourish at Dhubri market

<u>HT Correspondent</u> **DHUBRI, March 7:** As the holy month of Ramadan continues, concerns have been raised over the sale of adulterated Boondi, a popular Indian snack made from fried chickpea flour in the markets of Dhubri district.

As per reports, unscrupulous traders in various markets across Dhubri district are using the Raja Rani brand non-edible, poisonous colors to enhance the appearance of the sweetened Boondi, posing a serious threat to public health

Boondi, widely consumed during Ramadan for its sweet and savory variants, is being sold in adulterated form in markets such as Fakirganj,

Airkata, Whab Bazar, Porab-Raduram Chariali, Salkata, Chirakuti, Medortari.

The use of non-edible artificial colors can lead to severe health issues, including food poisoning, organ damage, and long-term complications. Despite the growing concern among consumers, the Dhubri district food inspector has reportedly failed to take action against these illegal activities.

Market-goers and local residents have expressed frustration over the lack of inspections and enforcement measures to curb the sale of such adulterated food products. Health experts warn that consuming food items containing toxic industrial-grade colors can have severe conse-

Such chemicals are not meant for human consumption

and can lead to gastrointestinal disorders, kidney and liver damage, and even carcinogenic effects with prolonged exposure. Residents and consumer rights groups have urged the food safety department and local authorities to conduct urgent inspections and raids in the affected markets.

They demand strict penalties for traders involved in food adulteration and public awareness campaigns to educate people about the dangers of consuming chemically treated foods. With Ramadan being a time of devotion and fasting, the sale of contaminated food poses a significant threat to both religious observance and public health.

Authorities must take immediate steps to prevent further distribution of adulterated Boondi and ensure the safety of consumers across Dhubri

Kidney transplantation saves lives of two critically ill patients

# **Swagat Super Speciality successfully** facilitates organ donation

GUWAHATI, March 7: Swagat Super Speciality Hospital, Maligaon, successfully facilitated the retrieval and transplantation of two kidneys from a deceased donor, marking one of the first such collaborations between a private healthcare institution and public medical authorities in the region. The organs saved the lives of two critically ill patients awaiting transplants,

The donor Uttam Dey, tragically passed away, but his family's compassionate decision to donate his kidneys and liver turned grief into hope. While the liver was deemed unsuitable for transplantation, the kidneys were swiftly retrieved during a late-night surgery on February 28, 2025. The organs were transported via a police-escorted green corridor in the early hours of March 1 to Gauhati Medical College, where the transplant team of Urology Department was on standby and the two prepped recipients received the life-saving transplants. Both patients are now recovering, with the kidneys functioning optimally.

Led by Subhash Khanna, head of surgical disciplines, and Dr Ayushman Khanna, a multidisciplinary team of over 15 specialists executed the complex retrieval process. The effort included liver transplant experts Dr Amitabh Goswami, Dr Vikas Moond, Dr Ashutosh Kumar, Dr Gulab Singh Patel, Dr Ashwin R Krishnan and Dr Vibha Varma, and urology team was led by Dr Pushkal Bagchi and Dr Debanga Sarma



along with Dr Hiranya Deka and Dr Sandeepan Borthakur. The anesthesia team was headed by Dr Shabbir Khan. Several key persons of Swagat management were involved in the process and that included COO Jahidur Rahman and Transplant Coordinator Ms. Sirajun Nessa and Operation Manager Mr. Bikash Baruah who ensured seamless coor-

Khanna highlighted the historic nature of the procedure: "This is the first time a private hospital in Guwahati has retrieved organs from a deceased donor under the government's framework. It underscores the power of collaboration in advancing healthcare.'

The local Puranigudam as well as Samaguri police rushed to the spot and sent the mortal remains to Nagaon Civil Hospital for post-mortem. Local residents as well as other family members of the deceased youth have raised suspicions about the circumstances surrounding his death.

# **International Women's Day**

oing back to history, the idea to make it an international possibility, initiative came from Clara Zetkin, a communist activist and advocate for women's rights. In 1910, she raised it at an International Conference of Working Women in Copenhagen. Her suggestion was unanimously backed by the 100 women from 17 countries, who were present there at the conference. The first International Women's Day was celebrated in 1911, in Austria, Denmark, Germany and Switzerland. It was a phase when Russia was preparing for the first Socialist Democratic revolution to build up a new society. Kollontai, Elena, Stosama, Nadezda Krupskaya were among those Communist leaders who prepared the blue print of the women's movement and were discussing the practical aspects of it. Voting rights for women and many other issues were discussed. In fact the first salvo of the revolution came from the women workers only just before the February revolution. Clara Zetkin's original idea for an international celebration was not tied to a particular day. The date of March 8 was selected after Russian women demanded "bread and peace" during a war-time strike in 1917. Four days into the strike, the Tsar was forced to abdicate. According to the Julian calendar which was then in use in Russia, the women's strike had begun in February and in the Gregorian calendar used in much of the rest of the world, that date is March 8.

International Women's Day is a national holiday in many countries. In China, many women are given a half-day off work, as advised by the State Council. Thousands of events take place globally, including marches, talks, concerts, exhibitions and debates. In Italy, IWD is called Festadella Donna, and mimosa blossoms are a popular gift. Flower sales in Russia typically double around International Women's Day. In the US, March is Women's 'History Month'. In India, women were actively taking part in the freedom struggle and also for their own cause. National Federation of Indian Women was organised only after independence, 1954. The year 2025 is a turning point in the global pursuit of gender equality and women's empowerment, as it marks the 30th anniversary of the Beijing Declaration and Platform for Action. Adopted at the Fourth World Conference on Women in 1995 in Beijing, China, by 189 governments, the Beijing Declaration and Platform for Action remains the most progressive and widely endorsed blueprint for women's and girls' rights world-

The Day for Women in fact assimilates many other aspects of life since they are the ones always involved at the centre. The call, therefore, is to unite and join to celebrate International Women's Day under the theme: "For All Women and Girls: Rights, Equality, Empowerment". To promote gender equality, systemic barriers have to be addressed, patriarchy has to be dismantled, entrenched inequities have to be transformed, and voices of marginalized women and girls, including young people has to be listened before its final precipitation into an act, to ensure inclusivity and empowerment. It is also important to redefine power structures by ensuring access to education, employment, leadership, and decision-making spaces and to prioritize opportunities for young women and girls to lead and innovate.

Despite significant progress for women's rights since the adoption of the Beijing Platform for Action in 1995, the world is experiencing new and overlapping crises and the erosion of rights. This International Women's Day, it is imperative for women to march forward for their rights as the world cannot afford a step back.

To celebrate the Day, there are three colours suggested by IWD to wear and these are white, purple, and green. The colours have their own significance, like purple is for justice and dignity, green for hope and white represents purity. All these colours were also used by the Women's Social and Political Union (WSPU). It was a group in UK in 1903 to fight for women's vote. The International Women's Day website has chosen the theme "Inspire Inclusion". It says organisers and events aim to "break down barriers, challenge stereotypes, and create environments where all women are valued and respected."

## How can women be empowered in the era of 'sex objectification'?

oday, there is a growing trend of objectifying women in entertainment media. In Indian films, social media, music videos, and television, women are often depicted as mere sex objects. This phenomenon represents a significant harm to society, as it perpetuates harmful stereotypes. Many films and songs objectify the female form, following a predictable pattern. An entire generation has been influenced to believe that life is what is shown on screen. As a result, women are often objectified during "item dances" at village fairs, local theater, and various art forms, which are attended by men of all ages. Advertisements in newspapers, magazines, radio, television, the Internet, billboards, and flyers often portray women in a sexualized manner, with the aim of attracting female customers. In Indian society, there is a prevailing belief that women are naturally weak. Research on social media shows that girls are sexualized more often than boys, increasing the pressure on teenage girls to fit into typical sexual narratives. For example, there is a deodorant ad that depicts a woman as a 'sex object,' suggesting that she is attracted to a man simply because he uses that particular brand. This representation turns women into objects that do not have their own identity. Such portrayals in advertisements are not only degrading but also undermine

the true status and dignity of women. Cases of violence against women and girls are on the rise in India, reflecting a disturbing mindset that seeks revenge against them. This trend reinforces harmful patriarchal stereotypes that exist in society. The phenomenon of "self-objectification" makes women experience negative emotions such as shame and anxiety, which can cause them permanent psychological damage. Unfortunately, mass media in India has largely failed to address issues affecting women or empower them to advocate for their rights and achieve equality. Instead, women often find to ideal body images portrayed in the media, neglecting their own physical and mental well-being. The objectification of women in the media has a clearly harmful effect on society. To combat this, we need to increase social support and initiatives aimed at reducing the objectification of girls and women. It is important to establish and enforce laws that promote gender equality by eliminating discrimination against women. This includes promoting media awareness, encouraging parent and family involvement in media consumption. ensuring religious sensitivity, positive representation of girls in the media, teaching youth life skills, and advocating for egalitarian gender norms within comprehensive sex education. Only through these efforts can we truly discuss women's empowerment in an era marked by sexual objectification.

Room' incident surfaced on social media, where pornographic images of underage girls were shared through leaked conversations from a certain group. It is important to recognize that this incident is not just an isolated incident of young boys promoting rape culture; rather, it reflects a deeper issue within our societal outlook. Over the past few years, there has been a rise in reports of cyberbullying and harassment. In view of this situation, we urgently need strong legislation that criminalizes cyber violence against women and girls. Without a dedicated law, the existing IT Act and IPC only serve as temporary measures, proving inadequate to deal with the scale of these issues. The IPC was established much before the digital age, and the IT Act was primarily created to promote e-commerce rather than address the unregulated online environment. Hence, creating a law that specifically targets cyber abuse, harassment, and violence against women will significantly contribute to turning the conversation towards safety and equality.

# Beyond equality: The battle for public urinals

In our country, women's rights are often talked about. There is always a cry for women to have Lequal rights as men, but have we ever thought that let alone equality, even access to public toilets is a big struggle for women? Recently, it was surprising to know that an organization called Coro India has to run a 'right to Pee' campaign for women in Mumbai. Under this campaign, the establishment of free, clean and safe public urinals for women in the busiest areas of Mumbai is being advocated. From this, it is not difficult to understand that access to basic facilities for women in the country also remains

Urinals are easily available for men on roads, markets, bus stands and railway stations in small and big cities, but such facilities for women are either very few or are in very poor condition. In such a situation, women are forced to hold urine or go to unsafe and unhygienic places. The consequences of which they have to suffer in the form of urinary tract infection (UTI), kidney problems and other diseases.

Many times public toilets are in such an unsafe condition that women are afraid to go there. Defecating in public places in the open affects their dignity and self-respect.

Under Article 21 (Right to life and personal liberty) and 15 (Right to protection against gender discrimination) of the Constitution, it is the responsibility of the government to provide basic facilities to all citizens. Some time ago, the Rajasthan High Court has taken suo motu cognizance of the lack of toilets for women at workplaces and public places and the poor condition of the existing toilets and has sought a reply from the government. In its order, the court has said that women play the role of the backbone of a developing country. Women are facing many health problems due to the lack of toilets. The court said that women who go out of their homes look for toilets but they either do not find any toilet or it is not clean enough, due to which women hold back urine until they reach home. The High Court expressed concern that due to lack of toilets in the state, women drink less water and hold back urine, which can cause diseases.

The Chhattisgarh High Court has also taken suo motu cognizance of the lack of toilets in 150 government schools in Bilaspur district and the toilets not being usable in more than 200 schools and has sought a reply from the government. The High Court

noticed that due to the lack of toilets in schools, female teachers and girl students are affected as they have to go to the open field to urinate.

With the Rajasthan and Chhattisgarh High Court taking cognizance, it is clear that now this is not only a social problem but has also become a matter of legal rights, but the big question is when will this problem be solved? Will women have to raise their voice by running a campaign for the right to Pee everywhere on the lines of Mumbai?

The important campaign called 'right to Pee' launched by Coro India to solve the serious problem of women draws attention to this serious issue. This initiative is not limited to just ensuring the availability of special urinals for women, but it is a big step towards protecting the health, dignity and basic rights of women.

The facility of clean and safe urinals for women is not a privilege but a basic human right which they must get. This is not only an issue related to their health but also a question of equality, dignity and self-respect. The government, administration and society together will have to take serious initiatives on this subject so that women do not have to struggle to get such a basic right which is available to men with-

Hearing about this campaign of Coro India seems strange at first, but thinking about it makes one understand how serious this issue is and why it is important to discuss it? This campaign challenges the mindset of considering the lack of public urinals for women as a 'normal situation'. Actually, this is a long-neglected problem of women, which needs a debate at the national level. The solution to any problem comes only by talking. If we have a wide discussion on this, then this demand of women will be raised strongly. There will be pressure on the government and administration and this will pave the way to work towards making the life of women more safe and convenient.

It is important that more clean and safe urinals be built for women at public places. There should be CCTV cameras at outside women's toilets, proper lighting, sanitary napkin vending machines and regular cleaning. It is important that the government makes a clear policy on this subject and immediately takes steps like making women's urinals compulsory in new building plans. # The power of food creation -Empowerment or forfeit for women?

**\**ood is the quintessential fuel for the survival of all living beings. The act of creating food is deeply intertwined with human civilization, culture, and survival. The answer lies in a nuanced understanding of history, economics, gender roles and the evolving landscape of food production.

The ability to create food has empowered women in numerous ways. Traditionally, women have been the custodians of culinary knowledge, passing down recipes, techniques, and cultural significance from one generation to the next. This legacy fosters identity, belonging, and pride in one's her-

itage. Cooking also provides economic opportunities. In recent decades, women have leveraged their culinary skills to break into the professional food industry, becoming chefs, restaurateurs, and entrepreneurs. The rise of femaleled food businesses, home-based catering services, and social media-driven food influencers has demonstrated how cooking can be a tool for financial independence. Furthermore, food is a medium of creative expression. women continue to perform a disproportionate share of cooking and food-related tasks, even when they have careers outside the home. This expectation reinforces traditional gender roles and limits the time women can dedicate to personal growth, professional ambitions, and leisure activities.

In the professional front the culinary industry, the irony is stark. While home cooking is predominantly associated with women, the highest levels of professional cooking Michelin-starred restaurants, celebrity chef status and high-paying executive chef roles are often dominated by men. The rigid division of domestic work based on gender is clearly evident. Women in the industry face systemic biases, workplace harassment and fewer opportunities for advancement, highlighting a gender disparity that stems from longstanding societal norms in the culinary industry.

Cooking as solely a woman's responsibility should gradually change, it is changing at a slower pace. With increased gender awareness and advocacy for equality, men are taking on a more active role in home cooking, and shared domestic responsibilities are being encouraged. Cooking is being viewed as a life skill rather than a gendered expectation, fostering a more balanced approach in households. In the professional realm, more women are challenging stereotypes and excelling in culinary arts, food science and

agricultural industries. Women chefs, food entrepreneurs and activists are redefining food production, sustainability, and nutrition, advocating for inclusivity and fair opportunities. The rise of feminist food movements has also drawn attention to ethical food sourcing, labor rights, and equitable treatment of women in kitchens worldwide. While mostly women consider

cooking food for the loved ones as an act of care, compassion and duty, another perspective also looks at it as a gender socialized form of manipulation. Thus the power of creating food is both a boon and a forfeit for women, depending on how society frames and values their contributions. When viewed as a creative and economic opportunity, cooking can be a means of empowerment and financial independence. However, when imposed as an obligation tied to gender expectations, it becomes a restrictive burden that limits personal and professional growth. For true progress, society must continue to challenge traditional norms, recognize unpaid domestic labor and create more inclusive opportunities for women in the culinary world. Only then can food creation be celebrated as a choice rather than a duty, ensuring that women harness its power on their own terms. alit women make up a significant portion of India's population. For a long time, they have faced social exclusion and humiliation. Historical and cultural narratives in India often overlook the contributions of women from marginalized communities, instead focusing on male-centric perspectives or the perspectives of dominant castes. By remembering the untold stories of Dalit women heroes and their struggles throughout history, we can enrich these narratives and confront the institutional discrimination that Dalit women have faced for generations. Today's women leaders are resilient and diverse. They are at the forefront of the global climate movement, advocating for social protections, tackling crises, and working to end systemic racial discrimination. Around the world, women leaders are changing lives and inspiring a brighter future for all.

The story of Sabari in the Ramayana exemplifies themes of acceptance, selflessness, and unconditional love, inspiring numerous hymns and poems. The rise of bhakti inspired Mahar caste women such as Sant Nirmala and Soyarabai to challenge traditional Hindu beliefs. Nangeli bravely opposed the harsh "breast tax" that targeted lower caste women who covered their breasts. Kuyili, a Dalit woman who led the army of Rani Velu Nachiyar of Sivaganga in Tamil Nadu, fought against British forces around 1780. Jhalkaribai, another courageous Dalit warrior, was a prominent figure in the

First War of Independence of 1857, serving as a trusted aide to Rani Lakshmibai of Jhansi. Ujirao, Lucknow Among the social reformers, Savitribai Phule emerged as a pioneer in the field of Dalit education, founding a school with just nine girls in 1848, which by 1851 expanded to three schools with about 150 female students. She worked with her friend Fatima Sheikh to start a school in 1849 and in 1852 founded the Mahila Seva Mandal to promote women's rights, as well as the Balhatya Pratibandhak Griha, a safe place for widows and victims of assault to give birth.

Moovalur Ramamirtham Ammaiyar campaigned against the oppressive devadasi system, publishing a Tamil novel on the subject in 1936 and creating the fictional series Damayanti in 1945. Dakshayani Velayudhan made history as the first and only Dalit woman elected to the Constituent Assembly in 1946. In Maharashtra, writers such as Shantabai Kamble, Mallika Amar Sheikh, and Kumud Pawade highlighted Dalit feminism through their autobiographies. In Tamil Nadu, writers such as Bama and P. Sivakami addressed gender discrimination as a dual form of oppression. Marathi writers such as Urmila Pawar and Meenakshi Moon worked to bring Dalit women into the spotlight within the women's movement, using their research and personal stories to highlight the harsh realities they faced.

Labour laws need to be reformed to provide exit options to Dalit women trapped in a challenging system. It is important to combine social and cultural change with economic options. Significant investments in skilling and educating women are required, along with government efforts to create new jobs in the formal sector and reduce barriers to job creation. Ensuring more stable-wage jobs for women is important to combat their socio-economic exploitation. Sustained efforts are needed to promote gender equality and challenge the tendency to give preference to boys to overcome deep-rooted prejudices. Women must be empowered with decision-making power and proper representation in governance. Therefore, the Women's Reservation Bill must be passed expeditiously to increase

women's participation in Indian politics. Additionally, governmental or community organizations should be established to oversee programs aimed at social welfare. Dalit women need targeted policies and initiatives that specifically address their unique challenges. Comprehensive health policies, particularly those focused on maternal and child health, are important. Taking inspiration from Kerala's Kudumbashree model, access to credit can be improved by encouraging women to form self-help groups. Dalit women in India are currently facing a critical juncture, as they face three significant barriers: class, caste, and patriarchy. These three interconnected aspects of social structure are important for understanding gender dynamics and the oppression faced by Dalit women. # Terrorism perennial challenge to be dealt with commitment: Jaishankar in Ireland

'It's not that we have very specific prescriptions here'

LONDON, March 7: Conflicts are a dominating issue today and India has taken a view that differences must be settled through dialogue and diplomacy, External Affairs Minister S Jaishankar said in an address at University College Dublin in Ireland.

Jaishankar went on to cover a range of foreign policy issues and referenced the June 1985 Air India aircraft terrorist bombing to highlight a shared India-Ireland perspective on counterterrorism.

The external affairs minister (EAM) noted that the Irish village of Ahakista in West Cork commemorates the 329 victims of the Kanishka bombing disaster, which occurred off the coast of Ireland.

"A particular word about conflicts because it is today a very dominating issue where India is concerned; we have always taken the view that differences in this era cannot and should not be settled on the battlefield," Jaishankar said

He was addressing students, academics and members of the diaspora at the leading Irish research institution on the topic of 'India's view of the world' on Thursday.

"It is important to have dialogue and diplomacy, to find ways of sitting down and talking, however difficult it is. It's not that we have very specific prescriptions here," he

"Talking about conflict, perhaps a word on countering terrorism would also be appropriate, particularly as a foreign minister of a country which has long been at the receiving end of terrorist efforts.

"Ireland actually happens to have in the

village of Ahakista a commemorative plaque which commemorates the 329 victims of the Air India aircraft Kanishka bombing which happened off the coast of Ireland. It's always a reminder that this is a perennial challenge which needs to be dealt with a great deal of resolution and commitment overall." he added. The minister went on to highlight India's "decades of about 7 per cent plus minus growth ahead," which opens up the prospect of greater alliances with friendly nations such as Ireland, a member of the European Union (EU).

With reference to the ongoing India-EU trade negotiations, he said: "We have been gotiating quite long, almost 23 years now, for

a free trade agreement

"We just had a visit of the EU President with 21 commissioners to India, and we are perhaps a little bit more hopeful now that this exercise would be brought to an end, ideally by the conclusion of this year." The EAM highlighted the historic connections between India and Ireland and the strength of the bilateral relations, with nearly 13,000 Indian students enrolled at Irish universities.

"Economically today, we have a very robust level of trade. It's currently estimated at about 16 billion Euros... and what's interesting with Ireland is that actually our trade in

"Education, as is evident, has been a really promising area of exchanges. I came into Ireland with the belief that we had about 10,000 students here. I was told the numbers today are closer to 13,000... making really a very serious contribution to Ireland's national development," the minister said.

He also noted former president V V Giri's association with University College Dublin where he studied law in 1913-16.

"As the world transitions into a different phase, I think it's important for all of us to nurture our cultural attributes, to understand their full value, to factor it in as we develop our own identity. And I think there are learnings that we have from each other," he said.

From the university, the EAM went on to address an Indian community gathering organised by the Embassy of India in Dublin, where he hailed the success and impact of the Indian diaspora. The interaction on Thursday followed his meetings with Irish President Michael D Higgins and former Irish prime minister of Indian heritage Leo Varadkar among other government ministers.

"Started my visit to Ireland going to the iconic General Post Office Museum in Dublin. The 1916 Easter Rising has a special meaning for so many who fought for freedom from colonialism," Jaishankar said in a post on X.

He also toured other historic venues in the Irish capital, including Trinity College Dublin, and will make his way to Belfast in Northern Ireland on Friday after talks with

# Russia bombards Ukraine's energy grid after Zelenskyy says his team will hold talks with US



**KYIV, March 7:** Russia targeted Ukraine's energy infrastructure in a large-scale missile and drone bombardment during the night, officials said Friday, hours after Ukrainian President Volodymyr Zelenskyy said talks with the US on ending the 3-year war will take place next

Ukraine came under a "massive missile and drone" attack, Energy Minister Herman Halushchenko wrote on Facebook. At least 10 people, including a child, were injured, authorities said.

"Russia is trying to hurt ordinary Ukrainians by striking energy and gas production facilities, without abandoning its goal of leaving us without light and heat, and causing the greatest harm to ordinary citizens," Halushchenko wrote.

Russia has repeatedly targeted Ukraine's power grid during the war. The attacks have depleted electricity generation capacity and disrupted critical heating and water supplies. Ukrainian officials have accused Russia of "weaponising winter" in an effort to erode civilian morale.

Kremlin spokesman Dmitry Peskov said Friday that the energy supply is a legitimate target in the war because it is "linked with Ukraine's military industrial complex and weapons production".

Russian air defences downed 39 Ukrainian drones overnight, according to the Russian Defence Ministry.

Ukraine's largest private gas producer, DTEK, said the overnight bombardment was Russia's sixth attack in the past two and a half weeks on its facilities.

Russia fired 67 missiles from air, land and sea and launched 194 strike and decoy drones, Ukraine's air force said. Their primary target was Ukraine's natural gas extraction facilities, it said.

For the first time, Ukraine deployed French Mirage-2000 warplanes delivered a month ago to help repel the attack, according to the air force. Ukraine also has Western-supplied F-16 fighter jets to shoot down Russian missiles.

Ukrainian defences downed 34 missiles and 100 drones, the air force said, while up to 10 missiles didn't reach their targets and 86 drones were lost from radars, presumably jammed by electronic war-

Western-supplied air defence systems are crucial for Ukraine's fight but further US help is uncertain under US President Donald Trump, who says he is determined to end the war and has paused American military aid for Kyiv as a way of pressuring Zelenskyy to negotiate.

In his nightly address, Zelenskyy said Thursday he would travel to Saudi Arabia on Monday to meet the country's crown prince, and his team would stay on to hold talks with US officials

Zelenskyy welcomed a European Union plan to bolster the continent's defences. He expressed hope that some of the new spending could be used to strengthen Ukraine's own defence industry.

Popular Iranian singer who urged women to go without hijab lashed over alcohol conviction

DUBAI, March 7: Iranian officials have flogged a popular singer who posted a song online urging women to remove their mandatory headscarves over a conviction for possessing and consuming alcohol, his lawyer and authorities said.

Mehdi Yarahi was flogged on Wednesday, his lawyer Zahra Minuei wrote on the social platform X.

Iran's semiofficial Fars news agency, quoting an anonymous official, said the sentence was for him drinking and having alcoholic drinks, not his music.

The lashes were "fully carried out in Branch 4 of the Enforcement of Sentences Office at the Tehran Morality Security Prosecutor's Office, and Mr Mehdi Yarahi's case has been closed," Minuei said.

Yarahi wrote and performed the song "Roosarito," Farsi for "Your Headscarf." The music video urged women to remove their hijabs and featured uncovered women dancing. Yarahi's initial arrest in August was believed to be linked to the video, which is still available on-

Yarahi wrote on X apparently after the flogging: "He who is not willing to pay a price for freedom is

not worthy of it. On the streets of Iranian cities, it's becoming more common to see a woman passing by without a mandatory headscarf, or hijab, after the second anniversary of the death of Mahsa Amini and the mass protests it sparked in 2022.

Amini, 22, died on Sept 16, 2022, in a hospital after her arrest by the country's morality police over allegedly not wearing her hijab to the liking of the authorities.

The protests that followed Amini's death started first with the chant "Women, Life, Freedom." However, the protesters' cries soon grew into open calls of revolt against 85-yearold Supreme Leader Ayatollah Ali Khamenei.(AP)

# Orbán says Hungary will poll citizens on Ukraine's EU membership

BUDAPEST, March 7: Hungary will poll its citizens on Ukraine's potential future membership in the European Union, Prime Minister Viktor Orbán said on Friday, a day after he refused to endorse an EU statement on support for Kyiv that was backed by the bloc's 26 other leaders.

In statements to state radio, Orbán said EU plans to fill the gap left by apparent cuts to American support for Kyiv by the administration of President Donald Trump would damage the bloc's economy. He reiterated his position that EU membership for Ukraine would come down to whether Hungary approves it or not.

EU membership for Ukraine would mean that "Europe will be destroyed, including the Hungarian economy," he said. "This process must be stopped in time."

As a way of shoring up support for Orbán's stance, the government will issue a "national consultation," a form of political campaign conducted periodically by Orbán's right-wing populist government in the form of an informal questionnaire sent to every adult in the



Such surveys have been widely criticized by pollsters and opposition parties as propaganda tools that are manipulative in their phrasing and highly suggestive of

"Everyone will give their opinion" on Ukraine's potential EU membership, Orbán said. "The question is simple: yes or no."

The results of the survey will not be legally binding. He did not say when the survey would be conducted.

Orbán's government has said the

### surveys strengthen its bargaining position on the European level by demonstrating a national consensus on political issues. Orbán, a staunch supporter of

Trump and considered to be Russian President Vladimir Putin's closest EU partner, refused Thursday to endorse part of a statement supporting Ukraine at an emergency summit convened in Brus-

At the summit, EU leaders committed to working together to bolster the continent's defences and to free up hundreds of billions of euros for security after Trump's repeated warnings that he would cut them adrift to face the threat of Russia alone.

All 26 other EU leaders approved the bloc's stance that there can be no negotiations on Ukraine without Ukraine, and that the Europeans must be involved in any talks involving their security.

Orbán has repeatedly warned that his country could exercise a veto on allowing Ukraine into the EU, a decision which would require unanimity among all the bloc's leaders. (AP)

# Migrant boats capsize off Yemen, Djibouti, leaving at least 2 dead, 186 missing

CAIRO, March 7: Four boats carrying migrants from Africa capsized overnight in waters off Yemen and Djibouti, the UN migration agency said Friday. At least two people died, and 186 others were missing.

Two of the boats capsized off Yemen late Thursday, said Tamim Eleian, a spokesperson for the International Organisation for Migration. Two crewmembers were rescued, but 181 migrants and five Yemeni crewmembers remain missing, he told The Associated Press.

Two other boats capsized off the tiny African nation of Djibouti around the same time, he said. Two bodies of migrants were recovered, and all others on board were rescued.

Despite a nearly decade-long civil war, Yemen is a major route for migrants from East Africa and the Horn of Africa trying to reach Gulf countries for work, with hundreds of thousands attempting the route each year. To reach Yemen, migrants are taken by smugglers on often dangerous, overcrowded boats across the Red Sea or Gulf of Aden.

The numbers making it to Yemen reached 97,200 in 2023 — triple the

Last year, the number dropped to just under 61,000, probably because of greater patrolling of the waters, according to an IOM report this month. Over the past decade, at least 2,082 migrants have disappeared along the route, including 693 known to have drowned, according to the IOM. Some 380,000 migrants are currently in Yemen. (AP)

## Clashes in Syria's coastal region between govt forces, Assad loyalists kill more than 70

LATAKIA (SYRIA), March 7: Clashes between Syrian security forces and gunmen loyal to former President Bashar Assad in the country's coastal region have left more than 70 people dead and an area outside government control, a war monitor said Friday.

Government forces sent major reinforcements overnight to the cities of Latakia and Tartus as well as nearby towns and villages that are the heartland of the minority Alawite sect and a base of support for Assad, to try to get the situation under control, state media reported.

The clashes are the worst since Assad was removed from power in early December by insurgent groups led by the Islamist Havat Tahrir al-Sham. or HTS. Since Assad's fall, there have been some sectarian attacks against members of his minority Alawite sect. These incidents have occurred despite the fact that officially the new authorities have said they are against collective punishment or sectarian vengeance.

On Friday morning, large numbers of troops were deployed in Latakia and no civilians were seen in the street as a curfew that was imposed in the city and other coastal areas remains in force. Members of the security force said there were some clashes in one of the city's neighbourhoods but most of the city was calm and under government control. (AP)

## Unexploded WWII bomb in Paris halts Eurostar travel connecting Paris to London, Brussels

**PARIS, March 7:** The discovery of an unexploded World War II-era bomb near the tracks severed Paris' high-speed rail links with London and Brussels on Friday, dashing travellers' weekend getaway plans and causing cascading disruptions to scores of other trains to and from France's busiest railway station, the Gare du Nord in Paris.

Eurostar, operator of the sleek speedy trains that usually make rail travel between the UK and the continent a breeze, announced the cancellation of all its services to and from its hub in the French capital.

Bright red signs warning of service disruptions greeted rail users at the usually humming Gare du Nord station, their travel plans thrown into disarray during the morning rush hour.

The repercussions quickly rippled beyond France's borders. In Brussels, trains to Paris were cancelled until at least Friday afternoon.

"There's no solution, we're going to call the hotel

and stay one more day. And change our train ticket," said Michel Garrot, a retired Parisian who was visiting the Belgian capital with his wife. At London's St. Pancras station, travellers who'd been looking forward to Paris' charms found their plans dashed. "We're looking up flights, but our options are lim-

ited," said Lauren Romeo-Smith, part of a group on their way to a birthday weekend. Eurostar, which runs passenger trains through the

Channel Tunnel between Britain and the continent, said its "sincerely apologizes for the disruption and understands the inconvenience this may cause. "We appreciate everyone's patience and coopera-

tion during this time," it said. Passengers at St. Pancras were advised to take the

train to Lille in northwest France, or fly to Paris. Fridays are invariably busy at St. Pancras, Eurostar's London hub, as thousands of people leave and arrive for weekend breaks. (AP)

# SpaceX loses contact with spacecraft during latest Starship mega rocket test flight

TEXAS (US), March 7: Nearly two months after an explosion sent flaming debris raining down on the Turks and Caicos, SpaceX launched another mammoth Starship rocket on Thursday, but lost contact minutes into the test flight as the spacecraft came tumbling

The 403-foot (123-metre) rocket blasted off from Texas a little before sunset. SpaceX caught the first-stage booster back at the pad with giant mechanical arms, but engines on the spacecraft on top started shutting down as it streaked eastward for what was supposed to be a controlled entry over the Indian Ocean, half a world away. Contact was lost with the spacecraft as it went into an out-of-control spin.

The space-skimming flight was supposed to last an hour and couldn't release the mock satellites into space as planned. The spacecraft reached nearly 90 miles (150 kilometres) in altitude before trouble



struck. It was not immediately clear where it came down.

"Unfortunately this happened last time too, so we have some practice at this now," SpaceX flight commentator Dan Huot said from the launch site.

NASA has booked Starship to land its astronauts on the moon later this decade. SpaceX's Elon Musk is aiming for Mars with Starship, the world's biggest and most powerful rocket.

Like last time, Starship had four mock satellites to release once the craft reached space on this eighth test flight as a practice for future missions. They resembled SpaceX's Starlink internet satel-

taste of space. Starship's flaps, computers and fuel system were redesigned in preparation for the next big step:

returning the spacecraft to the launch site just like the booster.

During the last demo, SpaceX captured the booster at the launch pad, but the spacecraft blew up several minutes later over the Atlantic. No injuries or major damage were reported.

According to an investigation that remains ongoing, leaking fuel triggered a series of fires that shut down the spacecraft's engines. The on-board self-destruct system kicked in as planned.

SpaceX said it made several improvements to the spacecraft following the accident, and the Federal Aviation Administration recently cleared Starship once more for launch.

Starships soar out of the southernmost tip of Texas near the Mexican border. SpaceX is building another Starship complex at Cape Canaveral, Florida, home to the company's smaller Falcon rockets that ferry astronauts and satellites to orbit. (AP)

# New Zealand's top diplomat in London loses his job over remarks about Trump

WELLINGTON, March 7: New Zealand's most senior envoy to the United Kingdom has lost his job over remarks he made about US President Donald Trump at an event in London this week, New Zealand's foreign minister said Thursday.

Phil Goff, who is New Zealand's high commissioner to the UK. made the comments at an event held by the international affairs think tank Chatham House in London on Tuesday.

Goff asked a question from the audience of the guest speaker. Finland's Foreign Minister Elina Valtonen, in which he said he had been rereading a famous speech by former British wartime leader Winston Churchill from 1938, when Churchill was a lawmaker in the government of Prime Minister Neville Chamberlain. # Nagaland all-party delegation to meet Shah over FMR with Myanmar

KOHIMA, March 7: The Nagaland Assembly on Friday decided that an all-party delegation would meet Union Home Minister Amit Shah to apprise him about the "resentment of the Naga people" against the Centre's decision to scrap the Free Movement Regime (FMR) with neighbouring Myanmar.

The central government in January last year announced that the FMR, which allows people residing close to the India-Myanmar border to venture 16 kilometres into each other's territory without visa, would end

Chief minister Neiphiu Rio said in the assembly that the restriction would impact the age-old historical, social, cultural, tribal and economic ties of Nagas living on both sides of the India-Myanmar border.

Rio proposed that he would lead an allparty delegation to meet the Union home minister at the earliest opportunity to raise the issue before him and other members of the House accepted the suggestion.

The delegation would apprise the Centre about the concerns of the House expressed through resolutions passed on March 1, 2024, and the Cabinet decisions of February 8, 2024, and January 6, 2025.

The 1,643-km-long India-Myanmar bor-

der, which passes through Mizoram, Manipur, Nagaland and Arunachal Pradesh, currently has FMR. It was implemented in 2018 as part of India's Act East policy.

The CM informed the House that the Ministry of Home Affairs (MHA) on December 24 last year issued instructions allowing the cross-border movement of people who live within 10 km on each side of the India-Myanmar boundary.

It also directed the state government to deploy at least two police personnel and two health officials at each of the entry/exit points at the company operating bases (COBs) of the Assam Rifles for smooth implementation of the measure, he said.

According to the instruction, the movement of people has been limited to 43 designated crossing points and will be granted to only those who hold Border Passes issued by the Assam Rifles. Of these 43 designated points, nine are located in Nagaland.

The MHA has also requested the Nagaland authorities to check Myanmar nationals for their Border Passes and take appropriate action on overstay or any other unauthorised activity by them, Rio said.

"It will also impede the close familial ties that exist between the communities who live along the border where at times people will have to cross the India-Myanmar border for farming. Moreover, there is movement of people across the border to avail of healthcare and education facilities. Hence, on humanitarian considerations, these restrictions need to be re-looked upon," he

Maintaining that the state government has highlighted the issues to the Centre on numerous occasions, the CM said that the state Cabinet deliberated on the proposal of MHA for fencing the international border and decided to request the central government to continue with the FMR and enact appropriate regulations.

The CM said that the chief secretary wrote a letter to the Union Home Secretary in this regard on January 22. (PTI)

# Money laundering case

# *ED* attaches ₹ 65 cr properties linked to ex-GM of Sikkim bank

rectorate of Enforcement (ED) has provisionally attached movable and immovable properties worth ₹ 65.46 crore in connection with a money laundering case involving a former general manager-ranked officer of a Sikkim-based bank.

The ED said in a statement that the attached assets include four residential properties and land parcels located in Deorali, Syari, Ranipool and Penlong - all in Sikkim.

These properties were allegedly acquired using proceeds from fraudulent activities linked to siphoning of funds from the State Bank of Sikkim (SBS) by Dorjee Tshering Lepcha, its former general manager (operations).

Additionally, several bank accounts with a combined deposit of approximately ₹ 53.41 crore in the names of Lepcha and his family members have also been frozen, the statement said.

These actions are parts of an ongoing investigation into the misappropriation and laundering of funds from the bank under the Prevention of Money Laundering Act (PMLA), 2002.

Established in 1968, the SBS is an autonomous body under the Sikkim government and it is responsible to handle the treasury function of the state, according to the bank's website.

The statement added that that investigation followed an FIR regis-

ED's findings revealed that Lepcha allegedly orchestrated a largescale fraud by creating a fictitious bank account under the name "AE Roads and Bridges Department, Government of Sikkim.'

Funds were illegally credited to this account by manipulating documents maintained for transactions involving two public sector banks.

The statement said the misappropriated funds were then diverted to personal accounts belonging to Lepcha and his associates.

The ED last month conducted multiple searches at properties linked to Lepcha, and seized documents related to various property purchases. The investigation is ongoing, with authorities continuing to follow leads and gather evidence against Lepcha and others involved in this extensive fraud it

# BJP to back Nitish even after polls: Bihar Deputy CM Samrat Choudhary

PATNA, March 7: Bihar Deputy Chief Minister Samrat Choudhary has asserted that the BJP will back CM Nitish Kumar for another term in office, rubbishing speculations that the NDA could push for a new face after the assembly polls due later this year.

In a freewheeling conversation with PTI here, Choudhary also said the possible entry of Kumar's son Nishant in politics was their "personal" matter and an "internal" affair of the JD(U), even as he dismissed Tejashwi Yadav, the NDA's principal challenger in the state, as "mere appointee" of RJD president Lalu

"The BJP is comfortable with Nitish Kumar, who has led the NDA in Bihar since 1996. So Nitish was (the leader) yesterday, he is so today and will remain so tomorrow," said the former

A trenchant critique of Kumar until the JD(U) returned to the NDA last year, Choudhary made it clear that while in the opposition "we were supposed to question the government. But, once in a coalition, the BJP is with its alliance part-

He also claimed, "Nitish Kumar has himself

Atal Bihari Vajpayee, he became the chief minister. Even RJD president Lalu Prasad had become the CM with BJP's support. But he took a divergent path".

"On the other hand, with Nitish Kumar we have the situation that he is working under the leadership of Prime Minister Narendra Modi on the national level, while in Bihar he is our leader," Choudhary said.

Asked about speculations that 47-year-old Nishant, who has so far stayed away from public life, may enter politics in the near future, Choudhary replied, "It is a personal decision of Nitish ji and an internal matter of the JD(U). Whatever they decide, the BJP will be with them as an alliance partner.'

About another NDA partner Chirag Paswan, a union minister who heads the Lok Janshakti Party (Ram Vilas), he said the young MP from Haiipur was "a tall leader who lends strength to the coalition"

The BJP leader was also confident of the NDA winning "more than 200 seats" of the 243-strong assembly in the upcoming polls, thanks to the growth witnessed by the state under the "double engine government". The term "double engine" is used by BJP leaders to refer to the party being in power at the Centre as well as in a state.

The deputy CM was, however, dismissive of RJD leader Tejashwi Yadav, the NDA's principal challenger, whom he called "not a leader in his own right but merely an appointee of his father Lalu Prasad". "I have always said Tejashwi is just a baua

(kid). The day Lalu ji says he wants Tej Pratap or Misa Bharti to be his political heir, nobody will care about Tejashwi," claimed Choudhary.

"Moreover, the people of Bihar can never forget the 15 years of lawlessness under the RJD. Marauders used to barge into homes and gun down the occupants. During the wedding of a daughter of Lalu Prasad, a car showroom was shoplifted," alleged Choudhary.

Ridiculing Yadav's attempts to create a buzz with populist promises, the deputy chief minister pointed out, "The RJD was in power when prohibition was imposed but now they speak of giving relief to toddy tappers. Also, the very domicile policy he is now promising was scrapped when they were ruling Bihar." (PTI)

HYDERABAD, March 7: The Congress government in Telangana has said that it would organise an all-party meeting on the delimitation of parliamentary constituencies to ensure that the state does not suffer any injustice in the exercise.

Briefing reporters late on Thurs-

day after a Cabinet meeting chaired by Chief Minister A Revanth Reddy, Information and Public Relations Minister Ponguleti Srinivas Reddy claimed the NDA government at the Centre intends to hurt the south through delimitation of constituencies. The number of constituencies in south India should increase on a pro rata basis, the way they may increase in the north, he said. The Cabinet meeting also approved a draft bill to increase reservations for backward classes to 42 per cent, which would be passed in the Assembly. At present, 23 per cent is given for BCs.

The proposed all-party meeting would be led by Deputy Chief Minister Mallu Bhatti Vikramarka and senior Congress leader and former minister K Jana Reddy.

Srinivas Reddy, however, did not specify when the proposed all-party meeting would be convened.

The Telangana government's decision to conduct the all-party meeting came a day after Tamil Nadu Chief Minister M K Stalin held a similar all-party meeting on the issue of delimitation. (PTI)

# Omar Abdullah unveils fiscal reforms to strengthen J&K's economy

JAMMU, March 7: Jammu and Kashmir Chief Minister Omar Abdullah on Friday announced a series of economic and tax reforms aimed at bolstering revenue generation, infrastructure development and social security while underscoring the need for fiscal prudence.

Presenting the Budget in the Assembly, he highlighted the government's commitment to reduce fiscal deficit through strategic policy measures and central as-

"Because of our fiscal reforms and central support, the fiscal deficit will be reduced, bringing us closer to our Fiscal Responsibility and Budget Management (FRBM) target," Abdullah said.

He projected the region's economy to grow at 7.5 per cent in 2024-25, with an estimated Gross State Domestic Product (GSDP) growth of 9.5 per cent in 2025-

In a major announcement, Abdullah introduced new levies on non-transport vehicles purchased outside J-K but registered within the region through authorised dealerships. "These vehicles will now be subject to a 12 per cent road and token tax, along with a 3 per cent green cess on top of existing charges," he said.

"This measure aims to mitigate revenue losses and provide a level-plaving field for local automobile dealers," he

stated The chief minister also proposed revisions in fuel taxes to encourage the adoption of cleaner energy sources. The Budget reduces petrol rebates by Re 1 per litre and high-speed diesel rebates by Rs 2 per litre while increasing the tax rate on aviation turbine fuel to 5 per cent.

"We are taking steps to align fuel taxation with environmental goals while ensuring that J&K remains competitive compared to neighbouring states like

Punjab, Haryana and Himachal Pradesh," Abdullah said.

The chief minister acknowledged J-K's financial constraints, attributing them to high committed expenditures and limited revenue streams. He revealed that only 30 per cent of revenue receipts and 25 per cent of budgetary needs are covered by J-K's tax and non-tax revenues.

"Our historical challenges of high expenditure and low revenue generation have led to fiscal stress. However, through improved tax compliance, digital tracking and prudent fiscal management, we are ensuring revenue mobilisation,' Abdullah said.

The government has intensified efforts to improve tax realisation, especially through Goods and Services Tax (GST) compliance. He assured that GST tracking for capital works and risk-based eway bill verifications would

strengthened to curb tax evasion. "Red-flagged cases will be closely monitored using inputs from the Business Intelligence Unit (BIU) and GST Network (GSTN) to prevent revenue leakages," he said.

The government's focus on digital reforms has yielded positive results, with non-tax revenue reaching Rs 5,824 crore as of January 31, while tax revenue has climbed to Rs 11,650 crore — both figures exceeding last year's collections.

"We are improving billing, metering and digitisation to enhance revenue collection. Our reforms in metering and power billing have led to a reduction in under-recovery from Rs 6,552 crore in 2022-23 to Rs 5,244 crore in 2023-24, with a further target of Rs 4,200 crore in 2024-25," Abdullah said.

Despite these efforts, he acknowledged that J-K's debt burden has risen due to borrowing for power purchases. The pub-

lic debt has increased from 48 per cent of GSDP in FY 2015-16 to 52 per cent in 2023-24.

"To address this, we are reducing highcost debt and optimising liabilities for long-term fiscal stability," he said.

The chief minister reiterated the need to tackle J-K's infrastructure deficit, particularly in road connectivity, water supply, tourism and power. "Addressing these gaps requires signif-

icant financial resources and continued central support. Our discussions with the prime minister. Union home minister and finance minister have resulted in special financial assistance for J&K," he said. He announced that the budget for the

J-K Police, previously constituting 11 per cent of the state allocation, has been migrated to the Ministry of Home Affairs (MHA) Budget from 2024-25 onward. "J&K will also receive an extra Rs

5,000 crore in grants for 2024-25 and 2025-26, which will greatly strengthen our fiscal position," Abdullah said, expressing gratitude to the central government. "I sincerely thank the prime minister, Union home minister and Union finance minister for their unwavering support in strengthening J&K's fiscal health and realising its vision for growth and prosperity," he said.

The government is also focused on improving fiscal transparency by making all developmental expenditures publicly accessible through the Empowerment and Jan-Bhagidhari portal. Independent officers will verify projects to ensure timely completion and quality execution, he said."We are strengthening fiscal discipline by curbing reliance on overdrafts. Improved liquidity management has significantly reduced our dependence on ways and means advances," Abdullah said. (PTI)

play Holi till 2.30 pm on March 14 while Muslims would offer Jumma namaz after 2.30 pm here in the communally sensitive city of Uttar Pradesh, a senior police official on Friday said, adding seven companies of Provincial Armed Constabulary (PAC) have been deployed ahead of the festival.

The new directive comes a day after a circle officer (CO) kicked up a row by saying that Holi is a festival that occurs once a year whereas Jumma namaz takes place 52 times a year. He said anyone who feels uncomfortable with the colours of Holi should stay indoors on that day.

Sambhal Superintendent of Police (SP) Krishan Kumar on Friday told reporters that in view of Holi and the first Friday of Ramzan falling on the same day, seven companies of PAC have been deployed in the city. Complete peace prevails in the district and peace committee meetings are being organised at the mohalla level, he said.

Asked about the discussions that took place in the meeting of the peace committee, the SP said, "Talks were held with key people from both sides in the district-level peace committee meeting and it was decided that the Jumma namaz will be held after 2.30 pm and people of the Hindu community will play Holi till 2.30 pm and go to their

He said the Sambhal district police are keeping a strict vigil on social media and people should not believe any kind of ru-



Kumar said the police outposts are being inspected, an antenna has been installed at the Satyavrat police outpost and a district control room is being built on it because it is located at a height.

"If there is any rumour then inform the police so that it can be refuted in time. I would also appeal to everyone not to believe any kind of rumour," he said.

Sambhal District Magistrate (DM) Rajender Pensiya told reporters that the city has been divided into six zones and 29 sectors. Magistrates have been deployed in all sectors. Peace committee meetings have been held at the police station level and the district

# SC refuses status quo on **Dharavi redevelopment**

NEW DELHI, March 7: The Supreme Court on Friday refused to order a status quo on Dharavi redevelopment project in Mumbai.

A bench of Chief Justice Sanjiv Khanna and Justice Sanjay Kumar sought responses from the Maharashtra government and Adani Properties Pvt Ltd, which was awarded the tender for the project, on a petition challenging a December 20, 2024 verdict of the Bombay High Court.

The high court had cleared the decks for redevelopment of the slums in Dharavi and upheld the tender awarded to the Adani Group for the project, ruling there was no "arbitrariness, unreasonableness or perversity" in the de-

The high court in the process dismissed the plea of UAE-based Seclink Technologies Corporation challenging the state government's decision to award the mega redevelopment project to Adani Properties Pvt Ltd, which had made a Rs 5,069-crore offer.

Seclink Technologies Corporation emerged as the highest bidder for the project first in 2018 with its ₹ 7,200-crore offer, but the tender was later scrapped by the govern-

The Adani Group had emerged as the highest bidder for the 259hectare Dharavi redevelopment project in the heart of Mumbai and bagged it with its ₹ 5,069-crore

offer in the 2022 tender process. The corporation moved against

The bench noted Sundaram's submission on the proposed commitment and said, "The petitioner will file an affidavit to the said effect before this court.'

The bench, however, clarified no special equities would be claimed by either sides.

Senior advocate Mukul Rohatgi, appearing for Adani Properties Pvt Ltd, said the project work had already commenced.

"I have carried out constructions. I have deposited funds. About 2,000 people are employed," he said.

Mehta said some railway quarters were demolished aside from new constructions taking place.

While dismissing Seclink Technologies Corporation's plea, the high court had also rejected its contention that the tender was "tailor made" to suit a particular firm of the private conglomerate, noting three bidders had participated in the process.

The government had cancelled the 2018 tender and issued a fresh one in 2022 with additional condi-

The corporation first challenged the cancellation of the 2018 tender and subsequently the 2022 award of tender to the Adani Group.

The state government had claimed in the high court that the tender was awarded in a transparent manner without any undue favour to the highest bidder.

The government said the 2018 tender was cancelled and a fresh one was issued four years later owing to several factors like the COVID-19 pandemic and the Russia-Ukraine war which affected the financial and economic state of af-

The first tender for the mega redevelopment project was issued in November 2018.

In March 2019, the bids were opened and it was found that Seclink Technologies Corporation was the highest bidder.

# Pressing, touching minor's lips without sexual advances not POCSO offence: Delhi HC

NEW DELHI, March 7: The Delhi High Court has said in the absence of sexually motivated advances, touching and pressing minor girl's lips and sleeping next to her cannot attract prosecution for 'aggravated sexual assault' under POCSO Act.

Justice Swarana Kanta Sharma observed the acts might violate her dignity and outrage her modesty but without "overt or inferred sexual intent" would fall short of meeting the legal threshold required to sustain a charge under section 10 of Protection of Children from Sexual Offences Act (POCSO Act). The judge, however, ruled that there was a clear prima facie case under Section 354 of IPC for 'assault or criminal force to woman with intent to outrage her modesty'

The court passed the judgement on February 24 while deciding the plea of the uncle of a 12-yearold minor girl against framing of charges under Section 354 IPC and Section 10 of POCSO Act against him. The court sustained the charge under Section 354 but discharged him under section 10 of POCSO Act. "Essential ingredients of an offence under Section 354 of the IPC are squarely met. This provision criminalises the use of criminal force or

Referring to Supreme Court's rulings, the court said the apex court has repeatedly said modesty, in the context of Section 354 of IPC, must be interpreted in light of the dignity and bodily autonomy of a woman, or a minor girl.

"(However) the victim has not alleged any act of an overtly sexual nature, nor has she suggested in any of her recorded statements – whether before the magistrate, the police or CWC - that she was subjected to sexual assault or that there was even an attempt to commit such an offence... the absence of even the slightest indication of a sexually motivated advance in the statements of the victim negates the foundational requirement of 'sexual intent', which is an essential element of an offence under Section 10 of POCSO Act," it added.

The minor girl, the verdict said, was abandoned by her mother at a young age and lived at a child care institution. She was visiting her family at the time of the incident, it noted.

## US exits fund to compensate loss and damage in poor nations

NEW DELHI, March 7: The United States has withdrawn from a global agreement under which developed nations pledged to compensate developing countries for climate change impacts.

The African Group of Negotiators (AGN), a coalition of African nations participating in UN climate talks, expressed deep disappointment over the US withdrawal from the Board for the Fund for Responding to Loss and Damage.

"This decision, made by the nation with the largest historical responsibility for climate change, jeopardises vital support for vulnerable countries facing irreversible climate impacts," AGN Chair Ali Mohamed said.

In an official communication to Jean Christophe Donnellier, Developed Country Co-Chair of the Fund for Responding to Loss and Damage, Rebecca Lawlor, the Deputy Director at the US Office of Climate and Environment, wrote, "On behalf of the United States Department of the Treasury, I write to inform you that the United States is withdrawing from the Board for the Fund for Responding to Loss and Damage, effective immediately." "Both the United States Board Member and United States Alternate Board Member will be stepping down, not to be replaced by a US representative," the letter stated.

After years of advocacy by developing and least-developed countries suffering from climate change, nations agreed to establish the fund at the UN climate conference in Sharm El-Sheikh, Egypt, in 2022. going trial burning of the material in the industrial town. alleged the board is not making public the complete report of the ongoing trial incineration of Union Carbide's waste at the disposal

of "misleading" people on the on-

The outfit said it will soon approach the Madhya Pradesh High Court with a plea to stop the eightday-long trial of burning the waste brought from Union Carbide's defunct factory in Bhopal, the site of the 1984 industrial disaster, to Pithampur, located 250km from the state capital.

The pollution control board has consistently maintained that during the trial. all emission levels have remained within standard limits, while the state administration has allayed fears of any adverse impact on the health of local residents.

The second round of waste burning trial is currently going on at the disposal site. As part of a plan to dispose of 337 tonnes of waste from the Union Carbide factory in Bhopal, the material was transported to Pithampur on January 2. According to an order of the HC, the trial of disposal of this waste is to be done in three rounds while strictly following safety norms and a report is to be submitted before it on March 27. In each round of trial, 10 tonnes of waste is to be disposed of. The first round concluded on March 3 and the second phase is underway since March 6.

in Indore, Hemant Kumar Hirole, head of the Pithampur Bachao Samiti, said, "The State Pollution Control Board is not making pubplant of a private firm in Pithamlic the complete report of the ongoing trial of the Union Carbide waste burning at Pithampur's disposal plant. The board is misleading people. It has also not disclosed the status of the ashes and other residues left after burning the waste." He said his organisation will soon file a petition with "facts" in the HC and request it to halt the ongoing trial.

Hirole claimed that ever since the exercise started, local residents in Pithampur have complained of burning sensation in eyes, pain in the throat and dryness in mouth.

However, the board has insisted all emissions caused by the incineration are within standard limits.

Indore division commissioner Deepak Singh said during the trial disposal of the chemical waste, the health department examined the health parameters of people living in settlements around the incineration facility and all their test reports have been found to be

He said as part of the second round of trial, the process of putting waste in the incinerator began on Thursday (March 6) and it is estimated that 10 tonnes of waste will take about 55 hours to burn.

According to the pollution control board, in the first round of diswaste, the emission of particulate matter (PM), sulphur dioxide, nitrogen oxide, carbon monoxide, hydrogen chloride, hydrogen fluoride and total organic carbon from the Pithampur plant was found to be within standard limits.

On the intervening night of December 2 and 3, 1984, highly toxic methyl isocyanate gas (MIC) leaked from the Union Carbide's pesticide factory in Bhopal. At least 5,479 people were killed, while thousands others suffered physical disabilities in the world's worst industrial disaster.

According to the state government, the waste from the Union Carbide factory includes soil from the premises of the closed unit, reactor residues, sevin (pesticide) residues, naphthal residues and 'semi-processed" residues.

The board said according to scientific evidence, the effect of sevin and naphthal chemicals in this waste has now become "almost negligible". Methyl isocyanate gas is currently non-existent in this waste and it is also free of radioactive particles, it asserted. (PTI)

# Wanted to celebrate immigrants and refugees in 'My Melbourne': Kabir Khan

MUMBAI, March 7: Immigrants and refugees should not be seen with just one perspective, says filmmaker kabir Khan, who narrates an uplifting story of a young Afghan woman who reconstructs her life in Melbourne after fleeing the oppressive Taliban regime in "My Melbourne".

The anthology movie also features segments by Imtiaz Ali, Rima Das and Onir. Themed around the four pillars of diversity— sexuality, gender, disability, and race— the anthology film features four unique stories -- directed by Khan, Imtiaz Ali, Rima Das and Onir. They are inspired by true incidents.

Khan's segment, titled "Setara", brings to life the journey of a 15-year-old Afghan girl, who has come to Melbourne after fleeing the Taliban. She finds her sense of belonging through cricket amid family tensions and past trauma.

"It was an uplifting story because Setara's dream was fulfilled through cricket, and also to show a city with the heart to do this. It's an important story to tell the world that if you see immigrants and refugees with just one perspective, then

So, I said this is a very good story, through which we can talk about Melbourne, and her story," he said.

# Women's Day: White saris to technicolour portrayals: Hindi movie mothers evolve into fuller beings

NEW DELHI, March 7: Almost always in a white sari, long-suffering and beyond reproach, waiting for her son to come home so she can tell him to wash up while she sets out his meal. That's the mother figure imprinted in the collective memory of generations of Hindi cinema goers. That is fast changing. Images of the ideal 'ma' framed in sepia, all the way from Nirupa Roy to Rakhee, are giving way to the modern-day mother in her many shades who loves her children for sure but also maintains her individuality.

As another women's day comes around, time perhaps to look at the long distance travelled. More and more mothers in Hindi cinema, both mainstream and off it, now represent the concerns of everyday women, of those who have lives beyond their children. They have agency, often a job and points of view that go beyond typical "motherly concerns" of yore.

And that, many writers and directors have discovered can be a great backdrop against which to tell the story of the hero or the heroine. In the Saif Ali Khan-Rani Mukerji starrer "Hum Tum", both the mothers are single. One, who is separated from her husband and the other a widow. But both, Rati Agnihotri as mother to the hero and Kirron Kher as mother

to the heroine are spunky, smart and full of life. The 2004 film, in which the mothers are not mere stand-ins but vital to the lives of their children, was a huge hit.

In the 2000s, the mother figure started transforming slowly and Kher got too play many of these roles, some a little off-kilter, others hugely melodramatic and always empathetic of course. And so came films such as "Dostana", "Main Hoon Naa", "Veer Zaara" and "Devdas".

In 2014 came "Khoobsurat" where Kher played the mother of Sonam Kapoor and Ratna Pathak Shah the strict matriarch and mother of the hero Fawad Khan. Two years before that, Dimple Kapadia was

the fierce, full of laughs single mother to a wayward son in the Saif Ali Khan-Deepika Padukone starrer "Cocktail" The evolution of mothers is now visible in

the smallest of roles in narratives where they are sometimes the protagonist and other time a useful foil.

Actor Seema Pahwa has played many middle class mother roles in films such as "Bareilly Ki Barfi" and "Shubh Mangal Saavdhan".

In "Bareilly Ki Barfi", she is Sushila, a harrowed mother vetting grooms for her daughter. In "Shubh Mangal Saavdhan", she is a well read woman who uses a children's classic to deliver a sex talk to her soon-to-be-married daughter.

Among the more memorable in recent years has been Dolly Ahluwalia's turn as a widowed mother to Ayushman Khurrana in Shoojit Sircar's "Vicky Donor". The mother, a salon owner, has a great relationship with her mother-in-law, the two enjoying a tipple and more every evening after work.

In "Thappad", Dia Mirza plays a single mother who explains to her teenage daughter why she does not want to get married again.

In the same film, Ratna Pathak Shah delivers an engaging performance as a mother who makes her gentle husband realise that he overlooked her ambitions in their marriage.

Shah, in fact, has played many varieties of interesting and memorable mother roles in "Jaane tu Yaa Jaane Naa", "Khoobsurat" and

"Kapoor & Sons".

Over the years, the portrayal of mothers has become more diverse and also more nuanced, seen most particularly in parallel cinema. In 2024's "Girls Will Be Girls", director

Shuchi Talati explores the conflict between a young mother and her teenage daughter to mine a beautiful story. The film, which opened to rave reviews, features Kani Kusruti as the mother whose yearning and loneliness runs parallel to her daughter's coming-of-age dilem-

Also last year was Katrina Kaif playing a mother with a mysterious past in Sriram Raghavan's thriller "Merry Christmas". In fact, she is in a restaurant with her daughter when she attracts the attention of a stranger who she invites home.

With filmmakers exploring the funny and at times complicated facets of women within the framework of the relationship of their children, many such stories have started to emerge.

Geeta Agrawal Sharma last year had fun playing interesting mother roles in Varun Grover's directorial "All India Rank" and Kiran Rao's satirical rural comedy "Laapataa Ladies". In "All India Rank", she is Manju, who acts as the balancing act between a strict father and her son buckling under the pressure of cracking the IITs.

In "Laapataa Ladies", she is Yashoda, a conventional mother who realises what her life really is when her daughter-in-law gets swapped with another bride. There are moments when Sharma remembers her own fears as a young bride and the fact that she never cared to notice what she herself liked while cooking for the

# CHHETRI'S RETURN GIVES NATIONAL TEAM HOPE BUT REFLECTS BADLY ON INDIAN FOOTBALL

scribed as "a wise decision" by the sport's national federation, Sunil Chhetri's return from international retirement at 40 actually reflects badly on Indian football, for it lays bare the paucity of quality strikers in a country of over 1.4 billion.

No amount of praise is too high for the man who has served the national team with distinction for nearly two decades, eventually ending his glorious career as India's highest-ever goal scorer with 94 strikes to his name.

When he called time on his international career in May last year, Chhetri was the world's third leading scorer among active players, behind Portuguese superstar Cristiano Ronaldo and Argentine icon

But Chhetri's long list of achievements in the sport is one thing, and his coming out of retirement less than a year after he decided to leave the scene, is another, and Thursday's surprise announcement certainly carries a negative connotation.

According to the All India Football Federation (AIFF), he was coaxed out of retirement by national team head coach Manolo Márquez, who urged him to join his old teammates for the crucial final round of the AFC Asian Cup

2027 qualifiers. People in the top rung of the AIFF are convinced that the right move has been made by head coach, who is also doing duty as dian Super League.

Since his retirement, he had continued playing for Bengaluru FC in the ISL. He has so far scored 12 goals from 23 matches this season to become its highest Indian goal-scorer, and it is this performance graph that has driven Márquez to get in touch with Chhetri.

His form in the ISL, in which he has also made two assists besides finding the back of the net a dozen times, has also impressed AIFF president Kalyan Chaubey.

"Sunil's leadership qualities are unmatched. A player of his stature can motivate the entire team. His form too has been impeccable in the ISL, scoring 12 goals, and

India can greatly benefit with a striker like him," Chaubey said.

Like Chaubey, AIFF secretary general Anilkumar P too preferred to look at the positive side of the move, and so did the legendary IM Vijayan, who, however, also rued the absence of striker good enough to lead the team upfront.

"It's a wise decision on part of the head coach to include Sunil Chhetri based on the technical data we received from our experts," Anilkumar told PTI.

"In the ongoing Indian Super League, Chhetri is performing

"You look at Roger Milla, who came out of retirement (at 38) to help Cameroon qualify for the quarterfinals of 1990 World Cup. Age is not a factor, what matters is fitness, and Sunil remains extremely fit and he is also playing

very well," Vijayan told PTI. However, he acknowledged that

the lack of good strikers in India remains a problem. "We have been trying so hard to find good strikers, but unfortu-

nately, we have not succeeded so far. Most of the top strikers in the ISL are foreigners, so that is how Chhetri's retirement had made

The league will see top Indian shooters take on the best in the sport. Kalikesh said, "We are all very excited. With the ISSF now recognising the SLI and allotting a window for it in its official calendar it is now officially an international competition

"With India's already strong profile in the sport globally, this would help attract most top shooters to the league, besides the unique nature of the league itself.

"A lot of work is going on behind the scenes and this motivates us further to deliver one of the best ever shooting sport spectacles ever wit-

Last month, the NRAI had announced long-time former Hockev India chief executive Elena Norman as the consultant for the SLI and New Horizons Alliance Pvt. Ltd. as its commercial and marketing partner. Shooting has been the country's strongest sport at the Olympic Games since the turn of the century with Indians winning one gold, two silver and four bronze medals.

At Paris Olympics last year, Indian shooters won three medals in a single sport for the first time with Manu Bhaker becoming the first athlete from the country to bag two medals at a single Games post Inde-
