Karbi Anglong delegation submits memorandum to Gadkari seeking swift implementation of Article 244(A)

KHERONI, March 26: Several organisations in Karbi Anglong on Wednesday submitted a memorandum to Union Minister Nitin Gadkari, urging for a bill in Parliament to expedite the implementation of Article 244(A) of the Indian Constitution.

The delegation comprised representatives from the Karbi Anglong-Dima Hasao Autonomous State Demand Committee (KADHASD-COM), Karbi Students' Association (KSA), and Dimasa Students' Union (DSU).

In addition, Members of Parliament Amarsing Tisso, and members of Legislative Assembly (MLAs) Dr Numal Momin (Boka-Ronghang Dorsing (Howraghat), Bidya Sing Engleng (Diphu), Rupsing Teron (Baithalangso), and Nandita Gorlosa (Haflong), along with the Karbi Anglong Autonomous Council chief executive member (CEM) Dr Tuliram Ronghang and Dima Hasao Autonomous Council chief executive member Debolal Gorlosa, were also part of the delega-

Gadkari, known for his proactive approach to infrastructure dereceived memorandum amid his busy schedule addressing regional issues. While no official response has been issued yet, the delegation expressed hope that their plea would be taken up with the seriousness it deserves

Speaking on behalf of the delegation, a representative emphasized the need for swift action, stating, "The people of Karbi Anglong and Dima Hasao have waited decades for the fulfillment of this constitutional promise. We urge the Government of India to introduce a Bill in Parliament without delay to ensure justice and selfgovernance for our communities."

It is worth mentioning that the delegation's primary demand is the immediate creation of an autonomous state encompassing the Karbi Anglong and Dima Hasao regions within Assam, as promised under Article 244(A).

This constitutional provision allows for the establishment of an autonomous state with its own legislature or council of ministers—or both—granting greater autonomy over governance, law and order, and financial matters compared to the existing framework under the Sixth Schedule.

The submission of the memorandum follows a series of advocacy efforts by the groups, including a recent trip to Delhi where they sought meetings with top government officials. The demand for autonomy in Assam's hill districts has been a long-standing issue, tracing back to the 1950s. with renewed urgency in recent

### Trump cites India as example in executive order Taking relentless action against bank on overhauling American election system

The sweeping executive order, signed by Trump on Tuesday, states that "despite pioneering self-government, the US now "fails to enforce basic and necessary election protections used by both developed and

"India and Brazil, for example, are tying voter identification to a biometric database, while the United States largely relies on self-attestation for citizenship," according to the order.

"In tabulating votes, Germany and Canada require the use of paper ballots, counted in public by local officials, which substantially reduces the number of disputes as compared to the American patchwork of voting methods that can lead to basic chain-of-custody problems," it said.

"Further, while countries like Denmark and Sweden

in person and do not count late-arriving votes regardless of the date of postmark, many American elections now feature mass voting by mail, with many officials accepting ballots without postmarks or those received well after Election Day," it said.

In India, the Election Commission is exploring linking voter cards with Aadhaar, which includes a biometric database. On March 18, the EC said technical consultations between its experts and the Unique Identification Authority of India (UIDAI) for the exercise would "begin soon".

The poll authority said that while voting rights could only be granted to a citizen of India, according to Article 326 of the Constitution, Aadhaar establishes a person's identity and not citizenship or right to get enrolled as a voter.

### loan defaulters, fugitives: Sitharaman NEW DELHI, March 26: Finance Minister Nirmala

Sitharaman on Wednesday said relentless action is being taken against bank loan defaulters, including fugitives, and assured the Rajya Sabha that the government is not lying low in dealing with fraud cases.

The finance minister, while replying to a discussion on the Banking Laws (Amend) Bill 2024, NPAs have reduced drastically and the government has remained "absolutely committed" to taking stringent recovery action against wilful defaulters.

Opposition parties have been repeatedly raking up the issue of loan write-offs of large corporate borrowers and economic fugitives.

To this, Sitharaman said write-offs do not mean waivers. Borrowers of written-off loans remain liable to repay their dues and banks continue to pursue recovery actions in written-off accounts using various mechanisms.

She said that during the last five years, the Directorate of Enforcement has taken up around 912 cases related to bank fraud, including those pertaining to wilful default, and approximately ₹ 44,204 crore of

proceeds of crime have been attached/seized/frozen in these cases.

In eight cases, assets amounting to ₹ 22,276 crore have been restituted to banks/legitimate claimants/victims of money-laundering. Also, 144 accused persons have been arrested, and 239 prosecution complaints, including 66 supplementary prosecution complaints, have been filed before Special Courts.

Besides, 23 accused persons have been declared Proclaimed Offenders and 9 have been convicted

under PMLA, Sitharaman said. The minister said action has been taken against eco-

nomic offenders who fled the country. As on December 31, 2024, nine individuals have been declared as Fugitive Economic Offenders (FEOs), and assets worth ₹ 749.83 crore have been confiscated. "So action is going on relentlessly. We have not let it lie low," she said.

The minister further said the government's efforts have not been restricted to structural reforms alone. The government has deepened financial inclusion, took banking to the last (CONTD. ON PAGE-2)

### India likely to add 150 million room ACs by 2035 amid rising temperatures: Study

'This growth is outpacing India's power supply and could lead to serious electricity shortages

NEW DELHI, March 26: India is expected to add 130-150 million new room air conditioners (ACs) over the next decade which could increase the country's peak power demand by more than 180 gigawatts (GW) by 2035, straining the power system, according to a new study published on Wednes-

The study by the India Energy and Climate Center (IECC) at the University of California (UC) in Berkeley said the fastest-developing major economy can avoid severe power shortages and save consumers up to Rs 2.2 lakh crore (USD 26 billion) by doubling the energy efficiency of room ACs over the next 10 years.

India adds 10–15 million new ACs annually, with another 130-150 million expected over the next decade. Without policy intervention, ACs alone could drive 120 GW of peak power demand by 2030 and 180 GW by 2035, nearly 30 per cent of the projected totals,



the study said.

"This growth is outpacing India's power supply and could lead to serious electricity shortages as early as 2026," said Nikit Abhvankar, the study's lead author and UC Berkeley faculty.

"ACs are becoming one of the biggest drivers of peak demand, and without intervention, we risk blackouts or costly emergency fixes. But with smart policy, we can turn this into a win for consumers, manufacturers and the

grid," he said PTI reported on Monday that India is likely to experience a nine more heat waves.

In the summer of 2024, room air conditioner sales surged by 40 to 50 per cent year-on-year amid

record-breaking temperatures. According to an ongoing research at the Oxford India Centre for Sustainable Development at the University of Oxford, the largest cooling demand, in terms of the total population, will come from India, followed by China, Nigeria, Indonesia, Pakistan, Bangladesh, Brazil, the Philippines and the US in a world two degrees Celsius warmer than pre-industrial times. #### **Maternity scheme severely** underfunded: Sonia Gandhi

Party (CPP) chairperson Sonia Gandhi on Wednesday said the government's flagship programme to provide maternity benefits to pregnant women is "severely underfunded", resulting in a drastic fall in entitlements to beneficiaries.

NEW DELHI, March 26: Congress Parliamentary

Raising the issue through a Zero Hour mention in the Rajya Sabha, she said Pradhan Mantri Matru Vandana Yojana (PMMVY) has seen a drastic fall in the number of beneficiaries and asked the government why this was allowed to happen.

Gandhi said the National Food Security Act (NFSA), passed by Parliament in September 2013 under the leadership of the then prime minister Manmohan Singh in September 2013, has been the foundation for PM Garib Kalyan Yojana (PMGKY), which was launched during Covid-19 to provide foodgrains to poor families. PMGKY currently has 81 crore beneficiaries. Under NFSA, pregnant women were entitled to maternity benefit of ₹ 6,000 per child, paid in

two instalments. PMMVY was launched in 2017 to fulfil this entitlement. But under PMMVY, only ₹ 5,000 is given for the first child and the benefits are extended to the second child only if it is a girl.

"According to an informed analysis for 2022-23, about 68 per cent of pregnant women received at least one instalment of PMMVY for their first birth, but this number drastically dropped to 12 per cent (in) the following year. I would like to ask the Union government



why this was allowed to happen," she asked She also questioned the provision for PMMVY not being separately mentioned in the Union Budget documents. "The full implementation of the maternity benefits provision requires an annual budget of around ₹ 12,000 crore. Surprisingly, the Budget documents do not contain separate information on allocations for PMMVY," she said.

All that the Budget documents reveal is that there is a programme called Samarthya in the Ministry of Women and Child Development. It has five components, of which PMMVY is one.

"The allocation in 2025-26 for Samarthya is only ₹ 2,521 crore. This clearly shows that the PMMVY is severely underfunded, thereby violating the key provisions of the law passed by Parliament," she said. This is the second time (CONTD. ON PAGE-2)

CHANDIGARH, March 26: Punjab Finance Minister Harpal Singh Cheema on Wednesday presented a ₹ 2.36 lakh crore budget, which focusses on tackling drug menace in the state, and allocated a whopping ₹ 5,598 crore for the health sector.

No fresh taxes were imposed in the budget for financial year 2025-26. It was silent on giving monthly ₹ 1,000 to women which was one of the poll promises of the AAP before coming to power. He said the biggest threat to the progress and prosperity of Punjab is the drug problem.

"We are taking yet another landmark initiative to effectively fight the war against drugs. We have to fight this war not just with force and weapons, but also scientifically through data and analysis.

"We have decided to carry out the first-ever 'drug census' in Punjab next year (fiscal). This census will cover every household of Punjab and will collect data to understand the prevalence of drugs, usage of de-addiction centres, etc, besides collecting data on socio-economic status of the people of Punjab," Cheema said.

This data will be used to craft an effective and scientific strategy to eradicate the drug menace. He said Chief Minister Bhagwant Mann's visionary leadership has been the driving force behind Punjab's remarkable progress over the past three years.

Cheema proposed a total budget expenditure of ₹ 2,36,080 crore for FY 2025-26. The effective revenue deficit and fiscal deficit are expected to be 2.51 per cent and 3.84 per cent respectively.

Cheema said the Punjab government will establish a second line of defence at border by deploying and private hospitals across Punjab," he said. Moreover, a budgetary allocation of ₹ 5,598 crore

has been provided for the health sector, an increase of ten per cent over the previous year.

To incentivise crop diversification, a new scheme covering three districts -- Bathinda, Kapurthala and Gurdaspur -- is being introduced for Kharif maize crop. On stubble burning issue, he said it is a national concern and the Punjab government is com-

mitted to addressing it.

An allocation of ₹ 9,992 crore has been made for providing power subsidy to the agriculture sector. A state-of-the-art shrimp processing unit is proposed to support farming in waterlogged areas, Cheema said. Cheema said the cost of availing doorstep delivery of government services is being reduced from ₹ 120 to ₹ 50.

Presenting the fourth budget of the AAP government in Punjab, Cheema said, Chief Minister Mann's "unwavering commitment to the welfare of our people has guided us in delivering transformative change across multiple sectors, laying a strong foundation for a prosperous and empowered Punjab" During his speech, Cheema took a dig at rival parties who ruled Punjab in the past, and alleged they have destroyed and looted the state. ".. The only legacy these parties left in Punjab was that of "Udta Pun-

jab," said Cheema targeting them on the drug issue. An entire generation of youth is being eaten hollow from within due to drugs, he lamented adding that the AAP government's resolve is to build a "Rangla Punjab", a Punjab that is inclusive, progressive, and brimming with opportunity for all. The 30-share BSE Sensex declined by 728.69 points or 0.93 per cent to settle at 77,288.50 as 25 of its components closed in the red. During the day, it slumped 822.97 points or 1.05 per cent to 77,194.22.

#### Rupee rises 3 paise to close at 85.69 against US dollar

MUMBAI, March 26: The rupee pared its initial losses and settled for the day higher by 3 paise at 85.69 against the US dollar on Wednesday, supported by a resurgence of foreign fund inflows. Forex dealers said the rupee is facing renewed pressure on liquidity constraints, concerns over reciprocal tariff implementations and monthend demand for the US currency from importers.

All India Sarafa Association. On Tuesday, the yellow metal of 99.9 per cent purity had ended at ₹ 90,450 per 10 grams. Gold of 99.5 per cent purity rose by ₹ 235 to ₹ 90,235 per 10 grams against the previous close

of ₹ 90,000 per 10 grams. According to the traders, fresh buying by retailers after recent losses led to the recovery in gold prices. Firm global trends also influenced the sentiment. Similarly, silver prices recovered by ₹ 1,500 to ₹ 1,01,500 per kg. The metal had settled at ₹1,00,000 per kg on Tuesday.

Meanwhile, spot gold traded 0.16 per cent higher at USD 3,024.96 per ounce in the global markets. Also, Comex gold futures for April delivery in the Asian market hours quoted higher at USD 3,059.10 per ounce.

"Gold edged slightly higher on Wednesday, buoyed by safe-haven demand and strong inflow from gold-backed Exchange Traded Funds (ETFs). "The uncertainty surrounding US President Donald Trump's reciprocal tariff decision on April 2 appears to be a crucial factor supporting safe-haven metal gold," Saumil Gandhi, Senior Analyst of Commodities at HDFC Securities, said.

Jateen Trivedi, VP Research Analyst - Commodity and Currency at LKP Securities, said market participants are awaiting key macroeconomic data, including US GDP and Core Personal Consumption Expenditures (PCE) Price Index, scheduled for release later this week.

'The broader trend will also be influenced by developments in the Russia-Ukraine situation, which continues to drive safe-haven demand, Trivedi added. (PTI)

Efficient ACs also offer massive consumer benefits. Even with slightly higher upfront prices, they could deliver net savings of ₹ 66,000 to ₹ 2,25,000 crore (USD 8–26 billion) by 2035, paying for themselves within two to three years through lower electricity bills.

"A common concern with efficient ACs is that they might be more expensive," said Amol

Phadke, co-author and UC Berkeley faculty. "But our analysis of global markets, including India, shows that efficiency is not the main factor driving retail prices. With the right policy support, higher efficiency often goes hand in hand with lower costs, thanks to economies of scale, better supply chains and competitive markets," he added. Over 600 AC models -- 20 per cent of all offerings -- already exceed India's top efficiency threshold, the 5-star level, with many produced by domestic manufacturers. "This is a chance for Indian manufacturers to lead," said Jose Dominguez, co-author and IECC researcher. "With the right policy signal, they can scale under Make in India and PLI (Production Linked Incentive) schemes, positioning India as a global hub for sustainable and affordable cooling," he said.

The report also calls for updating AC test procedures to better reflect India's humid climate, where comfort depends not just on cooling but on moisture removal. (PTI)

#### Political unrest in B'desh and Army's role

s the Bangladesh Army going to take over control of their politically turbulent country, either from front or behind, to pre-Leipitate the holding of early elections? This question is being raised by the seasoned political observers in Dhaka, as the whole of last week was dominated by highly controversial posts on Facebook, Instagram, interviews in YouTube channels and both formal and unofficial interventions by the country's top army officials through statements and meetings. All this started soon after the stern remarks made by the U.S. Director of National Intelligence Tulsi Gabbard last Monday during her visit to India. Gabbard strongly criticized the Yunus government for its failure to protect the security of the Hindu minorities and the interim government's indulgence of the fundamentalist groups with international terrorist connections. Though the Yunus government officially contradicted the observations terming those exaggerated, the signal was there. Along with this, a Facebook post by a leading spokesman of the newly set up political party National Citizens Party (NCP), mainly by the August movement students, created a furore in political circles. This leader claimed that the army chief had a meeting with their delegation last week and a proposal was given that the national elections should be held early with the participation of all political parties, including the revamped Awami League.

The consensus was that the Army must ensure early national elections with transparency and the Army should have more powers to control the law and order situation in the country which the police administration of Yunus' government had failed to maintain. The army people were angry that the student agitators held demonstrations early in the week before the cantonment against the army and hurled abuses. Interestingly, the role of CIA is currently under intensive discussion in Bangladesh among the political parties and students activists.

As the latest political scenario unfolds in Bangladesh seven and half months after the installation of the Yunus government on August 8, 2024, three trends have emerged. First, the Army wants to hold early elections in Bangladesh and it does not want to exclude the Awami Party altogether. Second, the role of the new party NCP and its curious relationship with the BNP and the Army. Third is the attitude of the USA and China. The US policy makers also are following developments in Dhaka now, though Trump's own preoccupation right now is with Ukraine and Gaza. The U.S. may take some more time to decide whom to back in the general elections. As regards China, the Chinese ambassador in Dhaka has done extensive spadework among all the political stakeholders in Bangladeshi politics. The high-level delegations from BNP and Jamaat have already visited Beijing and had discussions with the senior Chinese leaders in the last few months. Moves are on to invite a delegation of the newly set up NCP to

# The QUAD conundrum: Militarisation or Equilibrium?

s Donald Trump prepares to descend upon New Delhi for the Quadrilat-eral Security Dialogue (QUAD) summit in 2025, a murmur of speculation ripples through geopolitical circles. Analysts posit that the mercurial US president, known for his disdain for multilateral cooperation beyond security realms, might steer this strategic quartet—comprising the United States, India, Japan, and Australia—toward militarisation. They cite his withdrawal from the Paris Climate Accord and other non-security initiatives as evidence of a singular focus on hard power, envisaging a QUAD transformed into a robust counterweight to China's ascendance. Yet, such assertions falter under scrutiny, clashing with the very raison d'être of the QUAD: a flexible framework designed to uphold a balance of power and strategic deterrence in the Indo-Pacific, not to ignite a militarised powder keg. As Trump's shadow looms over this year's summit, the feasibility of such a shift demands rigorous examination, set against the QUAD's evolutionary arc and the intricate realities of regional dynamics.

The QUAD's genesis traces back to the cataclysmic 2004 Indian Ocean tsunami, when the United States, India, Japan, and Australia coalesced into the 'Tsunami Core Group" to orchestrate rescue and relief ef-This embryonic collaboration blossomed into the Quadrilateral Security Dialogue in 2007, bolstered by joint military exercises like Malabar, which that year saw the navies of these four nations, alongside Singapore, flex their maritime muscle. China's vehement objections swiftly derailed this nascent alliance, prompting Australia's exit and India's cautious retreat under Beijing's diplomatic pressure. Though the QUAD languished, the Malabar exercise endured,

with Japan joining as a perma-

nent partner in 2015—a harbinger of renewed intent. The grouping's revival in 2017, under Trump's first administration, was no coincidence. It coincided with China's assertive pivot under Xi Jinping, who, since assuming power in 2012, has jettisoned Deng Xiaoping's low-profile dictum for a muscular foreign policy that has roiled the Indo-Pacific.

China's belligerence has been palpable across multiple fronts. For India, the Line of Actual Control (LAC) has been a perennial flashpoint, with incursions escalating since 2013—most notably in 2014, when the People's Liberation Army probed the Chumar sector of Ladakh just as Xi visited New Delhi. The China-Pakistan Economic Corridor (CPEC), threading through Pakistan-occupied

Jammu and Kashmir—territory India claims as its own—has further inflamed

tensions, as has Beijing's opposition to India's Nuclear Suppliers Group (NSG) bid and its shielding of Pakistan-backed terrorists at the UN Security Council. The 73-day Doklam standoff in 2017, near the India-Bhutan-China trijunction, marked a zenith of Sino-Indian friction, underscoring China's willingness to flex its military might. Beyond India, Japan grapples with territorial disputes over the Senkaku/Diaoyu Islands in the East China Sea, while Australia reels from economic coercion—trade reprisals that prompted Canberra to recalibrate its China policy. The United States, meanwhile, watches warily as China's militarisation of the South China Sea, via artificial islands, and its sprawling Belt and Road Initiative (BRI) threaten to erode American preeminence in the region.

This backdrop catalyzed the QUAD's 2017 resurgence, an informal alliance elevated from secretarial to ministerial dia-

logues by 2019 and crowned with its inaugural leaders' summit in 2021. Today, it convenes regularly, weaving a tapestry of cooperation that spans security— Maritime Domain Awareness. cybersecurity, critical technologies, and supply chain resilience—and non-security domains like humanitarian assistance and disaster relief (HADR), health, and climate change. Far from a Cold War relic like NATO, the QUAD eschews rigid structures or binding commitments, its fluidity a deliberate choice to foster strategic equilibrium rather than provoke outright confrontation. To militarise it, as some fear Trump might advocate, would invert this ethos, risking instability across an already volatile region.

> eral counts. First, it misaligns with his own transactional worldview. During his first term, Trump balked at alliances demanding sustained US commitments, decrying NATO as obsolete and pressing allies to shoulder greater burdens. A militarised QUAD, entailing significant financial and security obligations, would chafe against this instinct to minimise America's overseas entanglements. His focus on burden-sharing evident in trade spats with allies and his "America First" mantra—suggests he is unlikely to champion a formal military pact that binds the US to expansive regional defense roles. Moreover, the QUAD's current trajectory, blending security and non-security initiatives, aligns with Trump's penchant for pragmatic, results-driven diplomacy, as seen in the ministerial meeting held in the US mere hours after his second inauguration in January 2025—a testament to its con-

alienate key regional players, notably the ASEAN bloc. These Southeast Asian nations, economically tethered to China yet security-aligned with the US, thrive on strategic ambiguity. Hedging between great powers, they recoil from overtly anti-China frameworks that curb their diplomatic latitude. The QUAD's inclusive design—addressing HADR, health, and climate alongside security—has cultivated broader appeal, drawing ASEAN into its orbit without forcing a binary choice. A security-centric pivot would fracture this delicate balance, pushing ASEAN toward neutrality or even alignment with Beijing, thus diluting the QUAD's efficacy as a counterweight. China, perceiving a militarised QUAD as an existential threat, might retaliate with escalatory measures—fortifying its South China Sea outposts or intensifying economic pressure—heightening the risk of direct confrontation and unraveling the strategic deterrence the QUAD seeks to sustain. Critics who dismiss the QUAD as a toothless "talking shop" or an "Asian NATO" miss its nuanced potency. Unlike NATO, with its codified mutual defense pact and bureaucratic heft, the QUAD thrives on informality, its working groups tackling diverse sectors from technology to disaster response. Regular summits, ministerial dialogues, and operational initiatives—like joint maritime patrols and vaccine coordination during the COVID-19 pandemic—belie the notion of inertia. China's labeling of it as an "Asian NATO" is less a critique than a strategic gambit to delegitimise a grouping that threatens its regional hegemony. The QUAD's strength lies in its adaptability, a 21st-century construct attuned to fluid geopolitical currents rather than the

foundational intent: to preserve a favorable balance of power, not to ignite a new arms race. A shift toward overt weaponisation would amplify China's security dilemma, potentially triggering a destabilising spiral of tit-for-tat escalation—precisely the outcome the QUAD was revived to avert. Historical precedent supports this caution: Australia's 2007 withdrawal under Chinese pressure and India's reticence until 2017 reflect the quartet's sensitivity to regional equilibrium. Even under Trump's first term, the QUAD's revival prioritised dialogue over sabre-rattling, a trend reinforced by its 2021 elevation to leaders' summits and its focus on non-security cooperation, such as the Quad Fellowship for STEM students launched in 2022 In the shadow of Trump's impending visit, the QUAD stands

at a crossroads. His transactional lens might nudge it toward sharper security contours—perhaps bolstering maritime exercises or technology-sharing to counter China's naval ambitions-but a full-scale militarisation seems improbable. Such a move would contravene his aversion to long-term commitments. alienate ASEAN, and undermine the strategic deterrence that underpins the grouping's raison d'être. Instead, the QUAD is poised to persist as a multifaceted alliance, weaving security with softer domains to maintain equilibrium in an Indo-Pacific buffeted by China's rise. As New Delhi hosts this summit, the dialogue will likely reaffirm this balanced trajectory, proving that the QUAD's potency lies not in militarised bravado but in its capacity to adapt, deter, and endure. In a region teetering on the edge of rivalry and reconciliation, that may well be its most enduring legacy. (The writer can be

The initiative was unique and as such it was equally appreciated by the people at large as the State Government wanted to provide the residents the opportunity to further indulge in the habit of reading books and also penning a few that further glorifies the rich literary history of the state.

Accordingly, when the Assam State Budget of 2025-2026 was announced, the State Government amongst many other schemes, introduced the scheme of 'Astadash Mukutar Unnoyonee Mala' specially meant for strengthening the art of reading and writing amongst the dwellers. The scheme highlighted four important features,

a) financial support to 1000 writers offering ₹ 25,000 each who can contribute to creative, scientific and aca-

b) financial support of ₹ 5,00,000 to organize Grantha Mela for district and ₹ 2,50,000 for co-district headquarter, both of which has to be approved by Assam Prakashan Parishad large often faces the problem of finance in terms of publishing a book. With the increase in the publishing cost of books, the writers often find it difficult to take the risk of publishing as the returns might not be worth the investment. As such, the decision of providing a grant of ₹ 25,000 by the Assam Government might help the writers immensely at least in terms of managing the finance of publishing a book. Although the eligibility criterias and the modus operandi of the scheme is still not out, however taking into account the desire of the honourable Chief Minister of Assam to enhance the age-old habit of reading and writing, it can be presumed that the scheme shall be very helpful for the young writers in question. Furthermore, credit has to be also

given to the Assam Government for understanding the fact that readership shall only increase if the people at large are given the opportunity to buy more and more books. As such the decision to provide grant for organising Grantha Mela in District and Co-district headquarter shall mean the people from each and every nook and corner of the state shall have the opportunity to read, access and buy books. If this happens in reality, then people of the state won't have to travel every time to Panbazar or visit the annual book fair organized in Guwahati to buy books of their choice. Although in the present time, effort has been undertaken to organize book fairs in different parts of the state, this scheme shall further increase the number of book fairs that can be organised.

> cluded Assam Book Fair breaking records with ₹ 7 crores sale, and book fair of Assam Sahitya Sabha Adhibekhan selling books worth ₹ 5 crore, highlight the fact that people have shown their interest in buying books if provided with the right opportunity and the right stock. Therefore if more numbers book fairs are organised in the coming years taking into relevance the newest scheme of the government, then the numbers can be even more promising. Moreover, the other two aspects of the scheme, viz, the idea of gifting books at Government functions and granting a sum of ₹ 1000 to government employees for purchasing will further strengthen the ratio of books being published and books being bought. Moreover if this scheme can be executed and continued by the Government of Assam in the way it is thought of, then the state can lead by example and might see itself in the list of countries like Norway, Ireland, Germany, the Czech Republic, Denmark, UK and other that are known for providing grants and several funding opportunities for writers. # Unlocking global potential: Promoting indigenous agricultural varieties of Assam in export markets

ssam, the lush green land of the Brahmaputra, is home to a diverse range of indigenous agricultural products that hold immense potential in global markets. From aromatic rice varieties like Joha and Bora to world-famous Assam Tea, vibrant turmeric, juicy citrus fruits, and exotic herbs, the state's agricultural wealth is deeply intertwined with its cultural heritage. However, despite their uniqueness and superior quality, many of these indigenous varieties remain underutilized in international trade. Promoting these agricultural treasures in export markets can not only boost Assam's economy but also secure the future of its farmers, preserve biodiversity, and elevate India's global agricultural footprint.

The global food industry is increasingly shifting towards organic, sustainable, and traditional food products, with consumers demanding healthier and more authentic choices. Assam's indigenous agricultural produce aligns perfectly with this trend. The world is recognizing the value of traditional food systems, and Assam's naturally grown crops, cultivated for centuries using ecofriendly methods, offer a unique selling proposition. The demand for non-GMO, chemical-free, and climate-resilient crops is rising, making it the ideal time for Assam to step forward and claim its rightful place in the international market.

Among Assam's most significant agricultural products, the state's rice varieties stand out as a prime export opportunity. Joha rice, with its distinct aroma and taste, has the potential to compete with international aromatic rice varieties such as Basmati and Jasmine rice. Similarly, Bora rice, a glutinous variety, is perfect for making traditional sweets and rice-based snacks, which are highly popular in Southeast Asia and Japan. If these rice varieties receive the right branding and international market linkage, they can fetch premium prices, benefiting farmers and boosting the agricultural sector.

Assam Tea is already a global brand,

However, the focus has mainly been on the mass production of CTC (Crush, Tear, Curl) tea, while specialty teas like Orthodox Assam Tea, White Tea, and Hand-Rolled varieties remain underrepresented in premium markets. The emerging preference for artisanal and organic teas in Europe and North America presents an opportunity for Assam's tea planters to reposition their products as luxury beverages. Moreover, the demand for traditional herbal infusions, such as those made from locally grown herbs like Thekera (Garcinia), Brahmi, and Tulsi, can open new avenues for Assam's tea industry.

Turmeric from Assam, particularly the Lakadong variety grown in nearby Meghalaya, has gained attention for its high curcumin content. Similarly, the local Assamese turmeric varieties, known for their deep color and rich aroma, can be marketed as premium spices in health-conscious markets. The increasing demand for curcumin-based supplements, herbal medicines, and natural food colorants in the West provides an untapped market for these indigenous spices. Assam's Black Pepper, Bhut Jolokia (Ghost Pepper), and exotic citrus fruits like Kaji Nemu (Assam Lemon) also hold great promise in international spice and fresh produce mar-

Another significant segment that can be explored is Assam's indigenous pulses and oilseeds. The naturally grown black gram (Matimah), pigeon pea (Arhar dal), and sesame seeds from the region have unique nutritional properties that can attract global health-conscious consumers. The trend of plant-based protein consumption is growing, and these indigenous legumes can be positioned as superfoods in international markets. Additionally, Assam's mustard oil, known for its purity and pungent flavor, can find a niche among the Indian diaspora and gourmet food

One of the key aspects of successfully promoting Assam's indigenous agricultural varieties in export markets is ensuring proper certification and branding. Organic certification, Geographical Indication (GI) tagging,



will enhance the credibility of these products. Currently, many small farmers struggle to obtain such certifications due to high costs and bureaucratic hurdles. Government initiatives and private partnerships must focus on streamlining these processes so that more farmers can access export markets.

Infrastructure also plays a crucial role in the export potential of agricultural products. Efficient cold storage facilities, food processing units, and logistics networks must be developed to ensure that perishable items such as citrus fruits, medicinal herbs, and organic vegetables reach global markets in optimal condition. Establishing export hubs, dedicated agricultural clusters, and farmer cooperatives will help in aggregating production and reducing transportation costs, making Assamese products more competitive on the

# Air pollution worsened in almost all Bengal cities in 2024: Global report

pike in air pollution has become a rule rather than an exception in West Bengal, with all cities barring Kolkata witnessing deteriorating air quality in 2024 compared to 2023, a new report showed.

Kolkata recorded a marginal decrease in air pollution but is still the second most polluted metro city in the country after Delhi and among the top two per cent of the world's cities with the worst air qualities, according to the report.

The study was carried out by IQAir, a Swiss air quality monitoring technology company. It was based on particulate matter (PM) 2.5 data collected from more than 40,000 air quality monitoring stations across 8,954 locations in 138 countries, territories and regions.

PM2.5 is one of the most potent, fine air pollutants that can penetrate the deep crevices of lungs and trigger a bevy of respiratory diseases, including the fatal ones.

The state's twin industrial cities Durgapur and Asansol, located about 170 kilometres northwest of Kolkata, ranked 24th and 25th globally in terms of air pollution, the report showed. Both recorded poorer air quality in 2024 compared to 2023, the report stated.

While Durgapur is listed under both the Union government's flagship National Clean Air Programme (NCAP) and Smart City programmes, Asansol is an NCAP city.

Huge investment still pollution surged

Four of the seven cities studied in West Bengal — Durgapur, Asansol, Barrackpore and Howrah recorded PM2.5 values 10 times more than the World Health Organisation guideline of 5 microgrammes per cubic metre of air, the report showed. This is despite around Rs 120 crore invested to counter air pollution in these cities.

Durgapur led with 72.3 microgrammes and Asansol remained just behind with 72.2 microgrammes. Both the cities recorded substantial jumps from their respective pollution levels of 2023: Durgapur from 49.5 to 72.3 — a 46 per cent rise — and Asansol from 62.4 to 72.2 — around

16 per cent. Barrackpore, a city in North 24 Parganas district where the air pollution was measured for the first time under the global project, recorded 58.4 microgrammes. Howrah's annual average of PM 2.5 was 57.1 micrograms — a 10 per cent increase over 2023. The national limit is 40

microgrammes. The highest PM2.5 value of 128.9 microgrammes in West Bengal during 2024 was recorded in December 2024 in Durgapur.

Siliguri and Haldia, despite having annual pollution levels below 40 microgrammes each, however, recorded higher values compared to 2023.

The state pollution control board accepted that the air quality trends in these cities were concerning. "We are trying our best but while the north

westerly pollution load coming from Jharkhand side is mainly responsible for poor air quality in Durgapur and Asansol, Barrackpore, I feel, gets impacted by the pollution generated by the brickfields in the adjoining areas," said Kalyan Rudra, chairperson of the state pollution control board. The unplanned nature of industries and minimum green cover in Howrah pushes up its pollution levels, it added.

Kolkata, whose PM2.5 levels exceeded the WHO guideline by nearly nine times, spent ₹ 792 crore under NCAP in the last five years, out of the total released fund of ₹ 960 crore.

"We could control Kolkata's pollution to an extent using a range of actions, particularly sprinkling of water and reducing roadside emission by providing gas connection to several roadside eateries and cloth presser units," claimed Rudra. "However, it will be difficult to reduce the city's pollution beyond a point, as World Bank experts have pointed out, unless pollution within the regional airshed can be countered," added Rudra.

Kolkata has long been holding the tag of the second most polluted metro city in India, despite having few industries and less vehicles than many others in the country.

"It is a fact that climatic and meteorological factors play a key role in worsening Kolkata's air pollution status, as the city is in the tip of the Indo- Gangetic plains and gets affected by the pollution generated in the zone, like Delhi; but the inadequate policy implementation also contributes to the problem," explained Anumita Roychoudhury, an air pollution expert from environmental think tank Centre for Science and Environment.

"Like the rest of the country, Kolkata has also been focusing on dust control; which is important but to substantially reduce pollution level, it needs to act as well to counter pollution from transport, waste burning and likewise; a multi sectoral approach," added the expert.

"As observed through in-depth chemical characterisation, solid waste and biomass burning are the dominant sources over Kolkata. Such emissions are enhancing ammonia in air, which in turn helps form a huge amount of particulate matter. We need to target ammonia emission that is producing ultrafine particulate matter through a secondary process," explained Abhijit Chatterjee, a scientist associated with the central government research organisation Bose Institute. ## Early arrival of summer in India and increase in heatwaves

eat wave events in India are increasing rapidly due to climate change. According to the India Meteorological Department, a heat wave is defined as a heat wave when the temperature in the plains exceeds 40 degrees Celsius and this condition persists for a long time. India experienced 554 heat wave days in 2024, while the number was 230 in 2023. This increase is affecting agriculture, water availability, and public health, necessitating urgent mitigation measures.

February, which is usually a winter month, is now experiencing extreme heat. Odisha, Telangana, and Maharashtra recorded temperatures above 40°C in February 2025, pointing to climate change. Example: Mumbai recorded a temperature of 38.7°C in February 2025, the hottest February day in five years. This disrupted daily life and led to a rise in heat-related illnesses. Global warming is leading to more frequent and intense heatwaves in urban and rural areas, putting a huge strain on the population. Night temperatures are also increasing unexpectedly. 31 states and union territories recorded night temperatures 1°C above normal, while 22 states saw an increase of 3°C-5°C. Delhi recorded its hottest February night in 74 years in 2024, shortening the recovery time for vulnerable sections. Marine heatwaves increase inland temperatures and affect monsoon patterns. In 2023, marine heatwaves in the Bay of Bengal delayed the monsoon in eastern India and increased pre-monsoon heat. Concrete structures, less greenery, and the presence of pollutants make urban areas hotter. In April 2023, temperatures in urban areas of Ahmedabad were 3-4°C higher than the surrounding rural It is necessary to incorporate heat-

wave mitigation in the national adaptation plan while ensuring coordination among states. Ahmedabad's Heat Action Plan (2013) helps prevent 1190 deaths every year. Urban planning should increase the use of green buildings, passive cooling, and heat-resistant materials. Telangana's Cool Roof Policy (2021) promotes heat-reflecting roofs, which reduce indoor temperatures. Tree plantation, rooftop gardening, and conservation of water bodies can reduce temperatures. Delhi's Urban Forest Initiative reduced local temperatures by 2-3°C in several hotspots. Local weather monitoring, heatwave forecasting, and urban heat island mapping should be expanded. Heat insurance. adjusted working hours, and cooling shelters need to be ensured for vulnerable workers. Rajasthan's Heat Insurance Pilot (2023) provided financial compensation to daily wage workers on extreme heat days.

Extreme heat can lead to longer summer holidays in schools, making it difficult to complete the syllabus.

Many schools do not have adequate cooling facilities, which affects the health of students. Heat waves during exam time can affect student performance. Extreme heat reduces the productivity of workers, especially in construction, farming, and other outdoor jobs. Increased electricity consumption can lead to energy crises, which increase power cuts. Heatwaves lead to health problems, which puts pressure on hospitals and increases healthcare costs. Water levels in lakes, ponds, and rivers fall rapidly, worsening the drinking water problem. Groundwater levels decline, affecting irrigation and drinking water supply. Incidents of forest fires increase, which causes loss of biodiversity. Heat affects the ecosystem of many plants and ani-

Develop and use crops that are more heat tolerant and require less water. Encourage farmers to adopt micro-irrigation technology (drip irrigation). Promote green roofs, reservoirs, and open green areas. Install shade trees and water spray systems in public spaces. Adopt temperature adaptation technologies in smart cities. Promote heat-resistant building materials and energyefficient design. Strengthen global and regional efforts to control sea temperature. Regenerate mangrove

Also, expanding schemes like Mahatma Gandhi NREGA and implementing cooling-focused urban policies will help ensure public health, livelihoods, and future sustainability. # Wildfires ravage southern South Korea, killing 24 people and forcing 27,000 to evacuate

wildfires that were among South Korea's worst ever were ravaging the country's southern regions, killing 24 people, destroying more than 200 structures and forcing 27,000 people to evacuate, officials said Wednesday.

The death toll included a pilot who died after a helicopter crashed during efforts to contain wildfires in the southeastern town of Uiseong, one of the areas hardesthit. The aircraft had no other crew members.

The National Fire Agency said at least 26 other people sustained varying degrees of injuries.

An ancient Buddhist temple, houses, factories and vehicles were among the structures destroyed in the wildfires that have burned 43,330 acres, the government's emergency response centre said.

In a televised address, South Korea's acting President Han Duck-soo said the wildfires that began last Friday were causing worse damage than many other past wildfires.

"Damages are snowballing,"

#### IMF approves loan for Pak to address climate change

ISLAMABAD, March 26: The IMF approved a loan of USD 1.3 billion for Pakistan to address climate change while also reaching a staff-level agreement on the first review of the already agreed USD 7 billion loan.

The new agreement spans over 28 months under the Climate Resilience and Sustainability Facility which aims to help nations address climate challenges while committing to reforms.

Additionally, freeing USD 1 billion for the country under the USD 7 billion bailout programme would bring the total disbursements to USD 2 billion.

"The IMF team has reached a staff-level agreement (SLA) with the Pakistani authorities on the first review of the 37-month extended arrangement under the Extended Fund Facility (EFF), and on a new 28-month arrangement under the IMF's (Resilience and Sustainability Trust) with total access over the 28 months of around USD 1.3 billion," Nathan Porter, mission chief to Pakistan, said on Tuesday.

"Upon approval (by the IMF board), Pakistan will have access to about USD 1 billion under the EFF, bringing total disbursements under the programme to about USD 2 billion," he added. Pakistan Prime Minister Shehbaz Sharif praised his team for the "positive development." "This was achieved through teamwork, no doubt," he said.

Sharif further said that politicians from the opposition had questioned if the government would be able to convince the IMF without a mini-budget. "With God's grace, the mini-budget did not come," he said. He acknowledged that the people faced difficulties as the government persevered to fulfill the conditions set by the IMF.

"Particularly, the common people who faced difficulties, if their sacrifices weren't there, the stafflevel [agreement] would not have been possible as they face the burwe'll have wildfire damages that we've never experienced, so we have to concentrate all our capabilities to put out the wildfires in the rest of this week."

Han said crews were struggling to extinguish the wildfires because strong winds swept the areas overnight. Han said about 4,650 firefighters, soldiers and other personnel were working Wednesday to extinguish the wildfires with the help of about 130 helicopters.

He said that "a small amount" of 5-10 millimetres of rain was expected Thursday.

Observers say the ongoing wildfires are the third biggest in South Korea in terms of land burned.

Officials in several southeastern cities and towns had ordered residents to evacuate Tuesday as firefighters struggled to contain multiple blazes fuelled by dry

The largest fires were in Andong, the neighbouring counties of Uiseong and Sancheong, and the city of Ulsan, according to South



Earlier on Tuesday, officials had said firefighters had extinguished most of the flames from the largest wildfires in those areas, but wind and dry conditions allowed the blazes to spread again.

But efforts to fight the fires were partially suspended overnight as the winds strengthened.

The blaze in Uiseong destroyed nearly half of more than 30 structures at Gounsa, a temple which was said to be originally built in the 7th century. Among the destroyed structures were two statedesignated "treasures" pavilion-shaped structure built on a stream built in 1668 and a Joseon Dynasty structure built in 1904 to

mark the longevity of a king. The temple's another state-desthe 8th century, was evacuated to a safe place, according to government and Buddhist officials.

The Justice Ministry said it protectively removed 500 inmates from a detention centre in Cheongsong, another southern town, but no damages were reported to the

The Korea Forest Service said it had raised its wildfire warning to the highest "serious" level nationwide Tuesday, requiring local governments to assign more workers to emergency response, tighten entry restrictions for forests and parks, and recommend that military units withhold live-fire exercises. The 18 dead include four firefighters and government workers who were killed in Sancheong on Saturday after being trapped by fastmoving flames driven by strong winds, according to officials.

The UK government also sanctioned Vinyagamurthy Muralidaran, the deputy leader of the LTTE, who later turned a rebel of the group and became a deputy minister in the national parlia-

In a statement on Wednesday,

## Palestinians protest against Hamas in Zelenskyy says Ukraine ready to observe ceasefire against energy targets



KYIV, March 26: Ukraine is ready to proceed with a ceasefire prohibiting attacks on energy infrastructure, President Volodymyr Zelenskyy said, in line with a deal that was brokered by the United States during three days of negotiations with Ukrainian and Russian officials in the Saudi capital.

Speaking in a video address late Tuesday, Zelenskyy said Ukraine had agreed with US negotiators "that a ceasefire for energy infrastructure can start today." But, he warned, any strikes on Ukraine's energy facilities by Moscow would draw "strong retaliation."

The comments underscored the tenuous agreements that came out of the three days of separate US-Ukrainian and US-Russian talks in Riyadh. Washington said it had agreed with the warring parties to implement a pause on attacks on energy infrastructure as well as taking steps to ensure safe navigation for ships in the Black Sea.

Those talks were part of a broader effort by President Donald Trump's administration toward a limited, 30-day ceasefire that Moscow and Kyiv agreed to in principle last week, but has thus far failed to materialize as both sides continue to launch drone and rocket attacks against the other.

While Zelenskyy on Tuesday thanked the US for its efforts to strike an agreement, questions remained over some key details, and a comprehensive peace deal to end the

three-year war still looked distant. Russia links the Black Sea deal to sanctions relief

On Tuesday, the White House said in separate statements that the sides had "agreed to ensure safe navigation, eliminate the use of force, and prevent the use of commercial vessels for military purposes in the Black Sea."

Details of the prospective deal were not released, but it appeared to mark another attempt to ensure safe Black Sea shipping after a 2022 agreement that was brokered by the UN and Turkiye but halted by Russia the next year.

After the White House issued its statement Tuesday, the Kremlin warned that a potential Black Sea deal could only be implemented after sanctions against the Russian Agricultural Bank and other financial organisations involved in food and fertilizer trade are lifted and their access to the SWIFT system of international payments is en-

Zelenskyy on Tuesday evening reacted to those demands, casting them as an example of Moscow "manipulating, twisting agreements, and lying" about the terms of the agreement.

"There are absolutely clear statements that have been published by the White House, everyone can see what is stated there," Zelenskyy said. "And there is something that the Kremlin is lying about again: that supposedly

the (ceasefire) in the Black Sea depends on the issue of sanctions. In an apparent reference to Moscow's demands, the White

House said Tuesday the US "will help restore Russia's access to the world market for agricultural and fertilizer exports, lower maritime insurance costs, and enhance access to ports and payment systems for such transactions. When asked about when Washington might help Moscow achieve

ambitions, Kremlin spokesman Dmitry Peskov said Wednesday that contacts between Russia and the US "continue quite intensively," and that authorities are "satisfied with how pragmatic, constructive and productive our dialogue is."

Peskov said the 2022 Black Sea Grain initiative could be revived if Russia's demands regarding agricultural and fertilizer exports are met. He said that those are the same demands that Russia initially put forward in the grain deal and that weren't being fulfilled.

Moscow claims compliance with pause on energy strikes

Peskov said that Putin's order to pause strikes on Ukraine's energy infrastructure for 30 days, given on March 18 per an agreement with Trump, still stands, and that Russian forces are complying with it. He accused Kyiv of continuing to target Russia's energy infrastructure but added that "we still believe that this moratorium (on strikes) should be observed."

Ukrainian officials have reported multiple strikes against their energy sites since March 18. In a post on X on Tuesday, Zelenskyy's communications adviser Dmytro Lytvyn said Moscow was "lying" about observing a ceasefire on energy infrastructure.

"They've been hitting our energy sites with bombs, attack drones, and FPV drones. We're not going into all the details, but there have already been 8 confirmed hits on energy facilities," Lytvyn



Global South, where many nations are burdened by unsustainable debt servicing. These step repayments are effectively cannibalising vital health budgets, leaving millions without access to essential health services," the minister said.

"We must reverse this trend and accelerate progress towards Uni-



versal Health Coverage (UHC). We must invest in accessible, affordable and comprehensive prihealth care for all," Motsoaledi told the meeting, the theme for which is 'Accelerate Health Equity, Solidarity and Uni-

versal Coverage" The minister called on the G20 members to acknowledge that spending on health is not a cost but an investment. "We must advocate

Boycotts remaining days of assembly session

AGARTALA, March 26: The opposition CPI(M) in Tripura on Wednesday announced that its MLAs would boycott the remaining days of the budget session of the assembly, accusing Speaker Biswa Bandhu Sen of being partisan. The seven-day budget session which commenced on March 21 entered its third day on Wednes-

The Left party's legislators' announcement came after Sen rejected a privilege motion moved by Leader of the Opposition Jitendra Chaudhury of the CPI(M), while accepting another by Parliamentary Affairs Minister Ratan Lal Nath on technical grounds.

Soon after the Question Hour, the Speaker said he received two motions for alleged breach of privilege by Nath and Chaudhury.

"Under the Rule of Assembly proceedings, the Speaker can allow only one privilege motion in a day. Since I have received the privilege motion submitted by the parliamentary affairs minister first, I will allow it. I am rejecting the privilege motion submitted by Chaudhury," he said.

Angered by the Speaker's decision, CPI(M) MLAs started raising slogans against him.

The issue has its genesis in Nath's alleged racist remarks against Chaudhury, a tribal leader, in the House on Monday.

The leader of the opposition moved the privilege motion claiming that Nath had made a "derogatory, abusive and racial" comment against "myself, my family and my community"

In his privilege motion against the CPI(M)'s mouthpiece in the state, Nath alleged that the newspaper published a "deliberately motivated" report on his remark.

The parliamentary affairs minister read his motion against the editor of the CPI(M) mouthpiece.

"My words have been deliber-



ately given a communal angle, spreading a hateful provocation in a highly planned manner," he said. Angry CPI(M) MLAs rushed to

the well and staged protests accusing the Speaker of being partial. They later staged a walkout. Later, the leader of the opposition told reporters in his chamber that the CPÎ(M), the main opposi-

tion in the 60-member Assembly,

The budget comprises ₹ 11,028 crore of revenue expenditure and ₹ 5,168 crore of capital outlay.

The devolution of taxes from the Centre was estimated at ₹ 5,519 crore, a leading source of receipts, along with ₹ 2,600 crore that the central government will provide to Sikkim as grants and aids in 2025-26, said Tamang, who also holds the finance portfo-

## Over 1.92 lakh metric tons of illegally mined coal detected



SHILLONG, March 26: Over 1.92 lakh metric tons of illegally mined coal have been detected in four coal-rich districts of Meghalaya as per aerial survey conducted by a leading drone survey and inspection company

This was revealed by Justice (retd) BP Katakey, who is heading the high court constituted one man committee, after chairing a meeting on Tuesday.

Addressing media persons, Katakey said, "The report of the aerial survey conducted by Garuda has been submitted and according to the report, in four districts - East Jaintia Hills, South West Khasi Hills, West Khasi Hills and South Garo Hills, they found little over 1.92 lakh metric tons of coal other than the inventoried coal.'

"I have asked them to furnish certain clarification which I am expecting today or by tomorrow. So therefore, according to them other than inventoried coal there are more coal available

within 1 km radius. Therefore, in today's discussion I have requested the deputy commissioners and superintendents of police of the concerned districts as well as concerned departments to be more vigilant about the availability of coal other than this 1.92 lakh metric tons of coal," he said.

Katakey added, "Based on this survev report, I will submit my report to the Meghalaya High Court what would be my impression on this report because I have to give my impression on this report, which I cannot share with you right now unless I submit the report and unless the High Court makes it public. So, facts remain that the survey report conducted by Garuda, found an additional 1.92 lakh metric tons of coal in four districts in the state of Meghalaya.

When asked, Katakey said, "Any coal found other than CIL designated depot is illegal. After the ban was imposed by the NGT, which has been confirmed by the Supreme Court, which has said that there cannot be rat hole mining, it means illegal mining unless the mining is allowed under the provision of MMDR Act."

Further, he informed, "I have been told in today's proceedings that whole prospective licenses have already been issued and another four have also been granted total eight and out of eight in respect of three environmental clearances have been granted and five are vet to get the environmental clearance and out of those three environmental clearance projects, one has started their operation.

Why should I ask the government to clarify because I am here because of the high court and as per high court order. These surveys have been conducted because of the directions issued by me from time to time and based on these reports I will scrutinize those reports, and I will have my own interpretation of this report and inform the high court, and the high court will definitely take appropriate action thereafter,"Katakey added.

"But I am reiterating that any coal found other than the coal available in the CIL designated depots are illegally mined coal and action has to be taken under the MMDR Act means FIRs have to be registered, coal has to be seized, the entire coal has to be put into auction subject to the permission to be granted by the respective courts of law and the entire deposits will go to the state's exchequer, not a single of it will go to the coal miners," he further

# Pig farmers in Arunachal urged to shift from traditional to commercial farming

## NU researchers, local community collaborate to conserve Indigenous fish species

Approach is uncommon in scientific studies in the region **HT Correspondent** 

DIMAPUR, March 26: Researchers at Nagaland University have collaborated with the local community to study and conserve indigenous fish species in Dikhu river in Nagaland.

The river, one of the most important tributaries of the Brahmaputra, flows through Nagaland and is home to many freshwater species crucial for local biodiversity and the economy. According to a release from the univer-

sity on Tuesday, this research integrates traditional ecological knowledge from local villagers to better understand fish diversity, fish species assessment, indigefishing techniques, community-based fishing practices.

It said the approach is uncommon in scientific studies in the region.

The study underscored an urgent need for focused conservation efforts in the river systems of Nagaland. The release said these systems support a unique and rich biodiversity but are threatened by increasing human encroachment and unsus-

tainable practices. It showed that the Dikhu river is not

#### **Opposition accuse govt of writing** off loans of wilful defaulters, burdening banks with NPAs

NEW DELHI, March 26: Opposition members in Rajya Sabha on Wednesday accused the government of writing off crores of rupees owed by wilful defaulters who have fled the country while crushing banks under the burden of non-performing assets.

Participating in the discussion on the Banking Laws (Amendment) Bill, 2024 in the Upper House, Shaktisinh Gohil (Congress) said the government has written off ₹ 87,000 crore owed by 50 wilful defaulters till 2024 citing official data.

"People, including Mehul Chokshi and Rishi Agarwal are in the list of those wilful defaulters. The government has written off loans to those people who looted this country and fled abroad. But when poor, small traders and farmers default on loans the government auctions their assets," he said.

Expressing similar views, Saket Gokhale (TMC) said by the government's own admission, consumption is down in the economy and people are not taking loans to buy any new products or to consume something new but they are taking loans to service their existing loans. "The other side of this problem is that Indian banks are being crushed under the burden of non-performing assets (NPAs). In just the last five years Indian banks have a staggering ₹ 10 lakh crore in NPAs," he said. This is not created by ordinary people, Gokhale said, adding "this is created by a bunch of ten-fifteen people who defrauded the system and left the country".

Taking a dig at the government's approach to solve the 'NPA crisis', he said,"Banks have now been told to write off NPAs...these NPAs are taken off the balance sheets of banks, it does not mean they are repaid. It just means that they are taken off to make the balance sheet look healthy...but this money is still not being recov-

# Protests over Waqf Bill rock Bihar, AIMPLB stages 'maha dharna' in Patna

**PATNA, March 26:** Protests against the Waqf Bill rocked Bihar on Wednesday, from the legislature to the streets, as political parties within the state and outside stood in solidarity with the All India India Muslim Personal Law Board (AIMPLB), which organised a 'maha dharna' here.

The AIMPLB demonstrations were held barely a kilometre away from the Vidhan Sabha premises, to demand rollback of the Bill brought by the Narendra Modi government at the Centre, and to request "secular" leaders like chief minister Nitish Kumar to reconsider "support" to the contentious legislation.

Leader of Opposition Tejashwi Yadav turned up shortly after ruckus created on the issue by his colleagues in the RJD and allies like the CPI(ML) had forced adiournment of the assembly within minutes of commencement of pro-

Yadav was accompanied by his father Lalu Prasad, the RJD president who chose not to speak owing to bad health.

The young RJD leader assured the gathering that he had the same "blood flowing in the veins" as of the former Bihar CM, who had famously stopped the Ayodhya Rath Yatra in its tracks by getting BJP patriarch L K Advani arrested.

Earlier, BJP MLA Hari Bhushan Thakur Bachaul had claimed that the Bill attacked the Waqf Boards' "extra constitutional" character, and advised the RJD to worry about the fate of Yadav with the assertion that its ally Congress has "refused" to accept him as chief ministerial candidate for the assembly polls, due later this year. Salian, former manager of Bollywood actor Sushant Singh Rajput, died on June 8, 2020, after falling off the 14th floor of a residential building in Mumbai's Malad area, six days before Rajput allegedly committed suicide in his apartment in Bandra.

Her father Satish Salian on Tuesday submitted a complaint to the Joint Commissioner of Police in Mumbai, demanding registration of a case against Aaditya Thackeray and others in connection with his daughter's death.

Raising the issue in the legislative council, Gawli, who is the legislator of the ruling Shiv Sena led by deputy chief minister Eknath Shinde, said, "The government must make its position clear regarding the allegations levelled against Aaditya Thackeray by the lawyer representing Disha Salian's family. NEW DELHI, March 26: Oppo- Chancellor of the institute, apsition members on Wednesday urged the Centre to ensure the autonomy of the proposed 'Tribhuvan Sahkari University' in Gujarat's Anand, even though they alleged the BJP government believes in centralisation of power rather than autonomy.

Minister of Cooperation Amit Shah moved the 'Tribhuvan Sahkari University' Bill in Lok Sabha for its consideration. The bill proposes to grant a university status to the Institute of Rural Management in Anand, Gujarat as 'Tribhuvan Sahkari University' and declare it an institution of national importance.

The 'bill was introduced in Lok Sabha on Monday

Participating in the discussion after it was moved by the home minister for consideration on Wednesday, TMC MP Saugata Roy alleged the BJP government does not believe in autonomy, but in centralisation of powers.

NEW DELHI, March 26: Leader of Opposition Rahul Gandhi on Wednesday claimed that he was not being given a chance to speak in the House which was being run in a "non-democratic style", and said Lok Sabha Speaker Om Birla had made "unsubstantiated" remarks about him.

Gandhi's remarks came after Birla asked him to follow the rules of procedure that members are expected to observe to uphold the dignity of the House. It was not immediately clear what was the reason for the Speaker to make the observation. The former Congress president said the Speaker made remarks about him and then adjourned the House without giving him an opportunity to speak. "The Speaker just got up and left. He did not allow me to speak a word. He was speaking about me, and I don't know what he said about me, all unsubstantiated. I said, 'let me speak as you have spoken about me', but he did not say a word and just left. He adjourned the House when there was no need of it," the former Congress president said.

About 70 Congress Lok Sabha MPs, including deputy leader of Lok Sabha Gaurav Gogoi, party general secretary KC Venugopal and party's whip in the Lok Sabha Manickam Tagore, met the Lok Sabha speaker and raised the "denial" of opportunity to Gandhi to speak in the House.

Speaking with reporters in Parliament House complex, Gandhi said there is a convention that the Leader of Opposition is allowed to speak, but whenever he gets up to speak he is not allowed to speak.

"So, in what manner is this House being run? We are not being allowed to (GSDP), in compliance with the speak. I have not done anything, I was sitting quietly, I did not speak any-Fiscal Responsibility and Budget thing. # Terror funding case: Delhi HC allows jailed J&K MP to attend Parliament in custody

Delhi High Court has allowed Jammu and Kashmir MP Abdul Rashid Sheikh, alias Engineer Rashid, arrested in a terror funding case, to attend the ongoing Parliament session "in-custody" and rejected NIA's apprehension that he was a flight risk.

A bench of Justices Chandra Dhari Singh and Anup Jairam Bhambhani directed the director general (prisons) that Rashid would be escorted by plain clothed policemen from prison to Parliament on days of the Lok Sabha session between March 26 and April 4.

The Baramulla MP, the bench said, would be handed over to the custody of the Parliament security or marshals, who would allow him to attend the proceedings and he could avail other facilities and amenities there.

"While out to attend the Parliament session, the appellant (Rashid) shall not be entitled to use any cellular or landline phone or other communication device; nor shall he be entitled to have access to the internet by any mode," the bench's March 25 order said.

Rashid, who was represented by senior advocate N Hariharan and advocate Vikhvat Oberoi, was directed not to interact with anyone out of jail, except within the Parliament precincts. He should not engage with or address the media in any manner, the court said, including his pending criminal case. The bench asked Rashid to bear



the expenses for the to-and-fro

travel and other arrangements. Rashid, who is facing trial under the Unlawful Activities (Prevention) Act (UAPA) in a 2017 terror funding case, had challenged a March 10 trial court order refusing him custody parole or interim bail to attend Lok Sabha proceedings till April 4.

In the high court, he gave up his plea for interim bail or custody parole and sought to attend the Parliament sessions "in-custody".

The NIA opposed the plea saying by allowing him to attend Parliament, would enable him a platform to air his opinions which he could misuse.

The high court, however, said the control of parliamentary proceedings was within the remit of the Lok Sabha speaker and it had no doubt that the proceedings would be conducted with requisite discipline. "This court is confident that subject to the conditions that the court proposes to impose by this order, the state machinery would be able to ensure the integrity of the appellant's custody, so that he remains available to face

trial," the bench said The bench said NIA's apprehension that once Rashid was within the precincts of Parliament, and inside the house, he would cease to be "in-custody" of the court, was "without basis"

"The appellant would only temporarily be handed over to the Parliament security detail and that too for the limited purpose of performing his duties as a MP of his constituency. Furthermore, the NIA?s submission that the appellant, who is an elected MP, would be a flightrisk within the precincts of Parliament, is to be heard only to be rejected," it said.

The court urged the secretary general of the Lok Sabha to ensure compliance of the conditions according to parliamentary rules, to ensure that Rashid's judicial custody was not compromised.

The bench said though there was no doubt Rashid was accused in a serious case of UAPA and had been in judicial custody since his arrest on August 9, 2019, as an MP he owed "to the people of his constituency the duty and responsibility to represent them in Parliament".

The Baramulla MP, who defeated Omar Abdullah in the 2024 Lok Sabha polls, is facing trial in a terror funding case with allegations that he funded separatists and terror groups in Jammu and Kashmir. He has been lodged in Delhi's Tihar Jail since 2019 after the NIA arrested him in the 2017 terrorfunding case. He was granted interim bail for one month in September last year to campaign in the Jammu and Kashmir Assembly The NIA's FIR alleged Rashid's

name cropped up during the interrogation of businessman and coaccused Zahoor Watali. After being chargesheeted in October 2019, a special NIA court framed charges against Rashid and others in March 2022 under Sections 120B (criminal conspiracy), 121 (waging war against the government), and 124A (sedition) of the Indian Penal Code and for offences relating to terrorist acts and terror

"The current natural gas consumption in India is 190 Million Standard Cubic Meters per Day (MMSCMD). We expect a significant rise in city gas distribution by

"As per the growth estimates, natural gas consumption will rise to 297 MMSCMD under a scenario based on the existing global and domestic situations and policies. If the situation is conducive, the demand can grow to 365 MM-SCMD by 2030," he said.

Jain was in Gandhinagar to attend the 2nd PNGRB national conclave on natural gas and petroleum products infrastructure.

Jain said PNGRB has allotted a license to lay the CGD network through a bidding process. We are committed to setting up 17,000 CNG stations and 12 crore domestic pipeline connections across the country by 2030, he added.

PNGRB is a statutory body mandated to regulate the refining, processing, storage, transportation, distribution, marketing and sale of petroleum, petroleum products and



natural gas. "One of the challenges (to natural gas consumption) is that the prices are not under our control. Another challenge is the exclusion of gas from the GST regime," he said.

Jain demanded that states consider slashing of tax because natural gas is a clean fuel. He said CNG is a new fuel for India. There are associated challenges related to laying infrastructure.

'As far as the natural gas pipeline is concerned, 10,000 km pipelines have been authorised to be laid at ₹ 3-5 crore per km, which will attract an investment of ₹ 40,000-50,000 crore in 3-5 vears," Jain said.

He said another commitment of ₹ 30,000 crore is for distributing city gas at ₹ 400 crore per district.

We expect to see an increase in CNG target with CNG adoption being undertaken rapidly. In domestic PNG, it depends on con-

He said the CGD network bidding involves three objectives - the number of proposed CNG stations, houses to be connected to domestic pipelines, and kilometres of network to be laid in cities or districts.

"We granted seven years to the winner of bids to achieve these three objectives. They gave us a commitment to setting up 17,000 CNG stations and 12 crore domestic pipeline connections. These targets were set up during the last bidding round in 2023, which they have to complete by 2030," Jain said. As per a report shared by PNGRB on "India's Natural Gas Demand Projection for 2030-2040," the CGD sector is expected to be the primary growth driver for natural gas consumption with a projected 2.5 to 3.5 times growth by 2030. It is expected to play a crucial role in shaping future NG (Natural Gas) consumption trends across various demand projection scenarios. (PTI)

#### Boy, 16, stabbed to death in Delhi's Wazirabad; 3 minors nabbed

NEW DELHI, March 26: A 16-year-old boy was abducted and killed for a Rs 10 lakh ransom in the Wazirabad area of north Delhi, a police officer said on Wednesday.

Three juveniles have been apprehended in connection with the murder, he said.

The class 9 student was taken to a deserted area near Bhalaswa Lake, where he was stabbed multiple times, he said.

'The family members of the boy had received a call regarding a ransom of ₹ 10 lakh. Later, they discovered his body," said the officer. On Monday, a complaint was filed at the local police station about a boy missing since Sunday. The boy studied in Mukherjee Nagar.

'During investigation, it was found that the missing/kidnapped boy was last seen with three boys, two of them aged 16 and 17, on a motorcycle on Jharoda Pushta road," the officer said. The sighting was confirmed through CCTV footage from the area. Police apprehended all three boys, who, during interrogation, revealed they had kidnapped the boy for a ransom of 10 lakh. They said that on Sunday, they took him with them on a motorcycle to hang out.

They took him to a forested area near Bhalaswa Lake, where they stabbed him and fled, leaving him dead. The next day, they called the boy's father, a driver by profession, using the boy's SIM and demanded a ransom of ₹ 10 lakh. "The body of the victim was discovered by a police team at the instance of the apprehended juveniles," the officer said. Police sources said that the accused also tried to cut the boy's body into parts. The mother of the deceased told reporters that the boys who allegedly killed her son lived nearby.

"My son left on Sunday around 7.30 pm after receiving a call, saying he will come back in 10 minutes. Later, we got a call with a demand for ₹ 10 lakh," she said. The father of the boy added, "Two boys came to our house to pick my son. After that, his mother kept calling him but it went unanswered. Around 9 pm on Sunday, his phone went off. I started a search for him and then went to the police station to register a complaint."

He said around midnight he got a call with the demand for a ransom, to be paid within three days, or else his son would be killed. "He was killed so brutally. His throat was slit and he was stabbed multiple times. I want them to go through the same pain that my son did," he said.

A relative of the boy blamed the Delhi Police for the slow action and law and order situation in the capital. "They waited so long to investigate the matter. If this continues, no kid would be safe in this neighbourhood. What are the police doing?" (PTI)

#### 'Insensitive, inhuman': SC stays Allahabad Cash, gold found in abandoned Sarpanch murder: Bid to foil **HC** controversial observations on rape

NEW DELHI, March 26: The Supreme Court on Wednesday took a strong exception to the Allahabad High Court's recent views that mere grabbing of a woman's breasts and pulling drawstrings of her "pyjama" wasn't rape, and stayed the observations, outlining total "insensitivity" and "inhuman approach".

Calling it a "very serious matter", a bench of Justices B R Gavai and Augustine George Masih said, "In normal circumstances, we are slow in granting stay at this stage. But since the observations in paragraphs 21, 24 and 26 are totally unknown to canons of law and depict total insensitive and inhuman approach, we are inclined to stay the said observations.'

The top court had taken a suo motu cognisance of the matter after the contentious observations of the high court were brought to the notice of Chief Justice of India Sanjiv Khanna by "We the Women of India" collective. The staying of the high court's controversial observations made in a March 17 verdict would mean that they cannot be used in any judicial proceedings for seeking relief by the present set of accused or others. The high court's verdict had come on a plea by two persons challenging a trial court's order summoning them for the alleged offence of attempt to rape a minor.

The verdict had held that the attempt to rape offence was not made out against the accused. The high court had held they were liable to be summoned for the lesser offence of assault or use of criminal force to woman with intent to disrobe her.

Referring to the high court's observations. solicitor general Tushar Mehta said, "This is one judgement I take a very serious exception." Attorney general R Venkataramani also appeared in the matter.

"It is a very serious matter," Justice Gavai said, "exhibiting total insensitiveness on the part of the judge." The bench added, "We are sorry to use such harsh words against the judge.'

Mehta said the chief justice of the high court was the master of the roster there and it was advisable that some steps were taken.

"We have perused the order (of the high court). We are at pains to say that some of the observations made in the impugned order and particularly in paragraphs 21, 24 and 26 depicts a total lack of sensitivity on the part of the author of the judgement," the bench said.

The apex court said it was not as if that the verdict was dictated at the spur of the moment in the court itself.

The high court had reserved its verdict in the matter in November last year and after almost four months, the judgement was pronounced, it added. The bench said it was clear that the judge had authored the verdict after application of mind. The top court issued notices to the Centre,

Uttar Pradesh government and the parties before the high court in the matter seeking their responses in the suo motu proceeding. The registrar (judicial) of the apex court

was directed by the bench to communicate its order to the registrar of the Allahabad High Court following which it would be "immediately" placed before the chief justice there.

The high court's chief justice was urged to examine the matter and take such steps as he deemed proper. The bench said the matter would be heard after two weeks.

During the hearing, one of the advocates appearing in the matter said they moved a plea against the high court order. The bench said the plea would be heard along with the suo motu proceedings. Another advocate said they would file an application on behalf of the victim's mother.

The March 17 ruling had also said that such an offence fell under the ambit of assault or use of criminal force against any woman with the intent to disrobe or compel her to be

Justice Ram Manohar Narayan Mishra's verdict came on a petition filed by two persons challenging the order of a special judge in Kasganj through which they were summoned under Section 376 (rape) of the IPC among other sections.

It came on record that an application was moved before the court of special judge, POCSO Act, alleging that on November 10, 2021, she (informant) was returning from the home of her sister-in-law along with her 14year-old daughter. It was alleged that accused Pawan, Akash and Ashok, who were from her village, met her on the way and offered a lift to her daughter. The accused allegedly stopped their motor-

bike on the way to her village and started grabbing her breasts. Akash dragged her and tried to take her beneath the culvert and pulled the drawstring of her lowers. (PTI)

# SUV belong to ex-constable of MP transport dept: ED

NEW DELHI, March 26: The Enforcement Directorate Wednesday said cash and gold worth about Rs 52 crore seized from an abandoned SUV in Madhya Pradesh last year "belonged" to former state transport department constable Saurabh Sharma, who is being investigated on corruption charges. The ED's declaration has ended months of speculation over the ownership of the cash and gold stash.

The ED, I-T Department and the Madhya Pradesh Lokayukta Police are the three agencies probing Sharma and the cache recovered from the vehicle on December 20 last year from an area in Bhopal.

The case began with the Lokayukta raiding Sharma first and recovered assets worth more than ₹ 3 crore, including ₹ 2.85 crore in cash, from his premises in Bhopal.

"In this case, Income-Tax Department had seized cash and gold from an Innova car belonging to Chetan Singh Gaur. ED investigation has revealed that the said cash and gold seized from Innova car belonged to Saurabh Sharma only," the federal probe agency claimed in a statement. The statement did not elaborate further. The vehicle was registered in

the name of Gaur and he is stated to be linked to Sharma.

The tax department seized 52 kg of gold bars worth ₹ 40 crore and more than Rs 11 crore in cash from the vehicle.

Sharma or his legal representatives could not be contacted immediately for a response on the charges made against him by the ED.

The issue has snowballed into a political controversy in the central state with the opposition Congress and the ruling BJP trading charges on rampant corruption in the transport department during their respective regimes. The ED also said it has attached assets worth ₹ 92.07 crore.

A provisional order for attachment was issued on Tuesday under the Prevention of Money Laundering Act (PMLA), it said.

The assets represent the "proceeds of crime" derived and obtained by Saurabh Sharma in his name or in the name of his relatives, associates apart from firms, companies, society, etc. "owned or controlled" by them, the agency said.

The linked associates or entities include Sharad Jaiswal, Chetan Singh Gaur, Aviral Building Constructions Pvt Ltd, Aviral Enterprises Pvt Ltd and UR Infrastructures Pvt Ltd, it said.

The ED said probe found that Saurabh Sharma "had purchased various movable and immovable properties in the name of his family members. friends, associates and also in the name of companies, firms, society by arranging unsecured loans from various unknown persons by laundering of ill-gotten money obtained and derived by him by commission of criminal activity relating to scheduled offences"

Sharma, Gaur and linked person Jaiswal were arrested in the case by the ED and they are currently lodged in jail under judicial custody. The ED case of money laundering stems from the Lokayukta Police FIR.

As per the Lokayukta Police, Sharma got appointed as a constable in the state transport department on compassionate grounds in 2015 and took voluntary retirement in 2023. His father, a government doctor, died in 2015, as per the special police establishment of the MP government.

The Lokayukta also alleged that Sharma earned money through corrupt means including setting up a school and hotel in the name of his mother, wife, sister-in-law and close associates Gaud and Jaiswal. (PTI)

# extortion attempt motive

CHHATRAPATI SAMBHAJINAGAR, March 26: The motive behind the killing of sarpanch Santosh Deshmukh was his opposition to extortion attempts targeting an energy firm linked to a windmill project, the prosecution on Wednesday submitted to a court in Maharashtra's Beed district. The court is likely to frame charges in the case against eight persons, including Walmik Karad, a close aide of former Maharashtra minister Dhananjay Munde, in April.

On Wednesday, special public prosecutor Ujjwal Nikam, submitted the facts of the case, including relevant documents, to the court.

"The prosecution informed the court of the gruesome manner in which Deshmukh was first kidnapped, tortured physically and then ultimately killed," Nikam told PTI. The court was also told that the motive behind the offence was Deshmukh's intervention and opposition to the extortion attempts made by the accused persons from the company, the prosecutor added.

The court has posted the matter for further hearing on April 10. Nikam said the court is likely to frame charges in the case next month after which the trial will commence.

The accused in the sarpanch murder case were produced in a court via video-conference on Wednesday. Deshmukh, the sarpanch of Massajog village in Beed district, was abducted and tortured to death on December 9 last year allegedly for attempting to stop an extortion bid targeting an energy company.

Eight persons, including Karad, have been arrested so far and booked under the stringent Maharashtra Control of Organised Crime Act (MCOCA). The other arrested accused were identified as Sudarshan Ghule, Vishnu Chate, Jairam Chate, Mahesh Kedar, Sudhir Sangale, Prateek Ghule and Siddharth Sonawane. One Krishna Andhale is wanted in the case.

Before the hearing, Nikam met the family members of the deceased sarpanch and the Crime Investigation Department (CID) officials.

"We also told the court that we have evidence for every fact presented. This case is based on circumstantial, paper and scientific evidence...We filed an application in the court requesting that the identity of the witnesses be kept secret," Nikam said. The court was told that accused Sudarshan Ghule was working as per instructions of prime accused Walmik Karad, he said.

The prosecution also submitted in the court the audio recordings in which the personnel of Avaada Energy Private Ltd company were threatened, he

# Stopping funds of states disagreeing to implement PM Shri school scheme not justified: Par panel

releasing funds to states which have not agreed to implement the PM SHRI schools scheme is not factual and justified, a parliamentary panel has noted.

The observations by the committee come amid an ongoing war of words between the Centre and the Tamil Nadu government over stoppage of funds worth over ₹ 2100 crore after the state refused to implement new National Education Policy (NEP) objecting to the three-language formula.

The Parliamentary Standing Committee on Education, Women, Children, Youth and Sports, headed by Congress' Digivjay Singh, recommended that the Ministry of Education should re-evaluate Sarva Shiksha Abhiyan (SSA) funding allocations and ensure that none of the states are placed in disadvantageous positions for not accepting NEP 2020 or PM SHRI scheme.

"The Committee has taken seri-

ous note of the non-release of SSA funds to certain states which have not signed MoUs for implementation of PM SHRI scheme. The total funds pending under this scheme to the states are considerable, with over ₹ 1,000 crore to West Bengal, ₹ 859.63 crore to Kerala and ₹ 2.152 crore to Tamil Nadu. "The committee also notes that 33 out of 36 states and Union territories have signed the MoU for PM SHRI and are implementing the scheme and developing NEP exemplar schools, so as, to create an equivalence in assessment and curriculum at the national level," said the report tabled in Rajya

Sabha on Wednesday. The committee recommended the department to resolve the issue amicably with the state governments concerned and release the pending funds on priority basis.

"The department has also informed the committee that PM SHRI is the model school scheme



SSA is the program to achieve the NEP goals. This appears to be the reasoning behind the decision to halt SSA grants to states not signing the PM SHRI MoU.

'However, the Committee takes the view that this reasoning is not factual or justified. The SSA predates PM SHRI and is intended to

help states to achieve the targets of the Right to Education Act. The RTE is a law duly passed by Parliament and confers education as a fundamental right onto every child. The SSA, as a scheme that enforces the fundamental rightbased RTE, cannot be bypassed by the NEP, which was an executive policy statement," the report said.

"However, underfunding and delays in transfer of SSA funds have constrained further advancements in their school infrastructure, teacher training, and student support. "During FY 2024-25, state like Tamil Nadu was allocated ₹3,586 crore under SSA, with the Union government's share expected to contribute ₹ 2,152 crore, but this amount has not been released despite repeated requests by the state governments. The withholding of funds is severely impacting teachand transportation for students in remote areas.

"The committee further observes that withholding the funds under SSA to states for not entering into MoU for separate schemes like PM SHRI is not justifiable," it added. The panel has recommended immediate release of pending SSA funds to states like Kerala, Tamil Nadu and West Bengal to prevent disruption in salaries, teachers training programs, and school infrastructure maintenance.

"Department should re-evaluate SSA funding allocations and ensure that none of the states are placed in disadvantageous positions for not accepting NEP 2020 or PM SHRI scheme. The committee also recommends the department to ensure an objective, need-based model to ensure equitable fund distribution across states," the report said. (PTI)



Kamra shared a screenshot from YouTube on X, which showed "Naya Bharat", his new video, has been blocked due


to copyright restrictions and therefore is not visible to viewers. Due to copy right claims, the video will not be able to generate revenue as well. "Hello @TSeries, stop being a

# Argentina beat Brazil 4-1 after securing its place at the 2026 World Cup

RHENOS **AIRES** GENTINA), March 26: Defendchampion celebrated throughout Tuesday as the team secured its place at the 2026 World Cup hours before an historic 4-1 win over archrival

Bolivia's failure to beat Uruguay meant Argentina had enough cushion in South American qualifying to secure one of the continent's six direct spots for the 48-team World Cup set to be co-hosted next year by the U.S., Canada and Mexico.

After Bolivia's 0-0 draw with Uruguay at El Alto, about 85,000 raucous Argentina fans kicked off the festivities at the Monumental de Nunez Stadium despite the absence of Lionel Messi. They were chanting into the night in Buenos Aires, now more confident their team can defend the World Cup title. For Brazil, its worst deficit in South American World Cup qualifying history compounded pressure on coach Dorival Júnior.

Brazil is in fourth place in South American qualifying with 21 points, 10 behind Argentina but only two behind second-place Ecuador, which was held to a 0-0 draw by Chile. Third-place Uruguay and fifth-place Paraguay also have 21 points, and Colombia is one point behind them in sixth. Seventh-place Venezuela has 15 points after a 1-0 win over 9thplace Peru.

Brazil was missing three regular starters — goalkeeper Alisson, de-



fender Gabriel Magalhães and midfielder Bruno Guimarães and wasn't really competitive from start to finish.

It's the first time Argentina has won both matches against Brazil in a World Cup qualifying tournament. The home victory was also Argentina's first against the Brazilians since qualifying for the 2006 World Cup.

Argentina has led South American qualifying from the start, with few hiccups and major away wins at Brazil and Uruguay. But coach Lionel Scaloni has not fielded 37year-old Messi in several games, which still raises doubts on

whether the star will play at the World Cup next year. Messi has an injury to his adductor and was not included in Argentina's squad for the two latest matches.

Striker Julián Álvarez said Argentina's big win "is historic because of the rival, the context, what was said, the great match we played and because we are qualified to the World Cup."

"Very humbly we did our work," he said.

Argentina scored its two first

goals in only 12 minutes of play, both thanks to accurate passing and some clumsy Brazilian defending.

Alvarez netted the first in the 4th minute after Marquinhos, Murillo and Guilherme Arana failed to reach the ball. The Argentina striker shot between the legs of goalkeeper Bento from close range.

Argentina scored again eight minutes later with Enzo Fernández, once again from close range after a low cross by Gonzalo Molina. Brazil got one back via Matheus Cunha in the 26th after a mistake by Cristian Romero, who lost the ball to the Brazilian by the edge of the box. Enzo Fernandez found Alexis Mac Allister bursting into the penalty box unmarked 11 minutes later to make it 3-1 to Argentina. During the break, Brazil sought to get some grip by boosting its presence in the midfield with Joao Gomes and the substitution of Murillo and striker Rodrygo. But it was to no avail, with Giuliano Simeone scoring for Argentina in the 71st after four Brazilian defenders failed to block a low cross in front of their goal.

"Everything we planned, from the first minute of play, did not happen," Brazil's coach told a news conference. "Argentina was much better in every way. I apologize to Brazil fans, we expected something very different from what we showed. It was a very difficult night for us." (AP)

## First batch of Indian shooters leave for Buenos Aires World Cup



NEW DELHI, March 26: The first batch of 22 Indian shooters accompanied by 13 support staff left for Buenos Aires on Wednesday to participate in the year's first ISSF World Cup, which will begin from April 3 in the Argentina capital. It will be a combined World Cup in which competitions will be held in all the three disciplines of rifle, pistol and shotgun shootings.

A total of 35 Indian shooters will participate across 15 medal events including 12 individual and

The remaining members of the squad will depart on March 29 as their competitions begin in the latter stages of the tournament.

# FIFA details Club World Cup prize money with \$125M target for the winner in \$1BN fund

ner of FIFA's first 32-team Club World Cup in the United States could earn \$125 million as details of a \$1 billion prize money fund were finally published Wednesday.

FIFA said it allocated \$525 million in guaranteed fees for teams taking part in the June 14-July 13 tournament, ranging from \$38.19 million to the topranked European team – likely Real Madrid – to \$3.58 million for the Oceania representative Auckland City.

A further \$475 million is earned by results in the 63 games, with \$2 million paid for winning group stage games, \$7.5 million for playing in the round of 16 and \$40 million to the team that wins the final at MetLife Stadium near New York.

The golden trophy has been sitting in the Oval Office at the White House this month after FIFA President Gianni Infantino delivered it to President Donald Trump, who was invited to pres-

ent it to the winning captain. The prize fund was delayed until a global broadcast deal was

**GENEVA**, March 26: The winbelatedly agreed in December with streaming service DAZN. which then got a major investment from a state-backed sports agency in Saudi Arabia. Fans can watched games for free on DAZN's website.

Each of the 12 European teams in the Club World Cup lineup will be paid at least \$12.81 million as an entry fee for the first expanded edition of the four-yearly tournament. Payments will be decided by "a ranking based on sporting and commercial criteria," FIFA said without providing details.

Manchester City, Bayern Munich, Paris Saint-Germain and Chelsea also qualified by either winning a Champions League title from 2021 to 2024, or having consistent results in the competition over those four seasons.

Countries were capped at two entries, unless they had three Champions League winners. Salzburg of Austria qualified as the final European team, despite



never advancing beyond the round of 16, because higherranked clubs like Liverpool and Barcelona were blocked by the country cap.

The six South American teams each will get a \$15.21 million entry fee.

Teams from Africa, Asia and the CONCACAF region of North America — including Lionel Messi's Inter Miami, despite not winning the MLS Cup title last season — each will get \$9.55 million for playing.

Leon of Mexico is currently contesting its removal from the competition by FIFA because it is in shared ownership with Pachuca which also qualified.

FIFA aims to share \$250 million among clubs worldwide who did not qualify for the tournament. It is unclear how many clubs will be paid, or how much they will get.

The maximum prize of \$125 million ranks below the English Premier League and UEFA's Champions League in soccer's prize money table. Man City got 176 million pounds (\$227 million) in prize money from the Premier League

for winning the title last season. In the 2022-23 Champions League prize list, the most recent published by UEFA, title-winning Man City got almost 135 million euros (\$146 million). The competition's total prize fund has now risen by almost 25% for each season through

UEFA will pay out close to 2.5 billion euros (\$2.7 billion) among the 36 teams in the new expanded format that guaranteed eights games played instead of six. The \$1 billion Club World Cup prize pot is, however, more than double the \$440 million FIFA shared among the 32 soccer federations whose teams played at the 2022 World Cup in

Sponsors who signed with FIFA for the club event in the two highest commercial tiers also have deals for the men's 2026 World Cup in the U.S. which will be co-hosted by Canada and Mexico. (AP)

HYDERABAD, March 26: Having lost their opening clash, Rishabh Pant's Lucknow Super Giants will be wary of Sunrisers Hyderabad's ultra-aggressive approach with the bat when the two teams face off in the Indian Premier League here on Thursday.

Last year's runner-up SRH picked up from where they had left off in the opening clash to nearly break the record of the highest total in the IPL, handing the Rajasthan Royals a crushing defeat by 44 runs.

The huge win also propelled SRH to the top of the points table for having the best net run rate and given their all-round firepower, the Pat Cummins-led side would want to maintain their dominance in the competition.

SRH went hammer and tongs against RR with their new recruit Ishan Kishan smacking a century and the other big guns firing as usual to make 286/6 in their last outing here at the Rajiv Gandhi International Cricket Stadium in Uppal.

Such batting approach could be terrifying for the opponents and SRH's remarkable consistency makes them the most feared batting unit in the IPL circuit.

The addition of Kishan to the mix of SRH's premier weapons in Abhishek Sharma, Travis Head and Heinrich Klaasen is another masterstroke. To top it off, Nitish Kumar Reddy too struck his runs at more than 200 against Rajasthan Royals.

Kishan appeared to be a man on a mission as he struck his maiden century in the IPL after being let go by Mumbai Indians, smashing six sixes and 11 fours in his 47hall 106 not out.

In such circumstances, LSG will be required to have clear bowling plans as the smallest of error is proving costly in the IPL, which has already witnessed a new record being made — 119 sixes have been struck in the first five matches.

On their part, LSG, who lost to Delhi Capitals by one wicket in a thrilling finish showed a similar approach with the bat but they were guilty of losing their way in the middle overs, which proved to be costly.

LSG lost six wickets and added only 76 runs in their last eight overs against Delhi Capitals and despite early wickets, they could not withstand the onslaught by the lower-order as Ashutosh Sharma's 66 not out handed his side a win.

LSG's new skipper Pant had a forgettable game of sorts in his first outing with the team, falling for a six-ball duck during their batting slide and he also missed a regulation stumping when DC needed six off the final over with one wicket in hand.

Nicholas Pooran was magnificent in his strokeplay but the tone was set by Mitchell

Marsh — playing in this IPL only as a specialist batter — with his stunning attack on the DC bowlers.

While LSG would feel they did not do too many things wrong in the clash against DC, they would know a better show with the ball will be paramount against SRH who have been severe on all opponents.

Apart from their senior spinner Ravi Bishnoi, LSG will also have high hopes from the unheralded duo of Manimaran Siddharth and Digvesh Rathi, who both bowled with control to snaffle a couple of wickets each against DC.

With Shardul Thakur outrunning DC's Mitchell Starc to find swing with the new ball which resulted in a couple of wickets, it was inexplicable why LSG did not turn to the senior all-rounder who bowled only two overs upfront when the opposition was running away with the games.

On these counts, LSG would be expected to come up with better plans.

# BFI postpones elections, say impossible to complete process within original time-lines



NEW DELHI, March 26: Boxing Federation of India (BFI) on Wednesday postponed its election scheduled for March 28, saying it's "impossible to complete the process within originally planned timelines" after the Delhi and Himachal Pradesh High Courts directed the body to reinstate the names omitted from the electoral col-

"This is to inform you that the Annual General Meeting (AGM) of the Boxing Federation of India (BFI), which was scheduled to be held on 28.03.2025, stands postponed," BFI said in a notification to its member units.

The BFI added that the decision to postpone the AGM, during which election of the office bearers were to be held, was necessitated following the March 21 order by Returning Officer (Justice Retd) RK Gauba.

"The Ld. Returning Officer has observed that in light of the court orders and the resulting mandated additions to the electoral college list, it is practically impossible to continue and complete the election process within the originally planned timelines as per the Model Election Code," the notification stated.

The electoral college was finalised on March 13 while the window of nominations was

from March 14 to 16. In his order, Gauba noted that the two court orders "necessitates certain steps to be taken by BFI under the R&Rs and the

Model Election Code.'

"Having regard to the fact that the Model Election Code prescribes the time-lines for the election process, it is rendered practically impossible, with above mandated additions to the Electoral College List, for the electoral process to be continued and completed under the extant Schedule.

Both the Delhi and Himachal Pradesh High courts had stayed the March 7 order issued by BFI President Ajay Singh that rendered all those who are not elected members of their state associations ineligible to be members of the electoral college.

While the Delhi HC had asked the BFI to proceed with the elections, the Himachal HC had directed the federation to extend the date of nominations to enable the candidature of former Sports Minister Anurag Thakur, who was declared ineligible after the March 7 order.

BFI had challenged the Himachal High Court's ruling but the appeal was rejected on Tues-

The elections, which have already faced multiple delays and controversies, were originally supposed to take place before February 2.

The BFI flung into action only after the Indian Olympic Association (IOA) appointed an ad-hoc committee, a move the national federation challenged in the Delhi High Court, which subsequently put a stay on the ad-hoc panel. (PTI)
