House passes Bills to allow Guv to take charge of autonomous councils if polls delayed

GUWAHATI, March 6: The Assam Assembly on exist which render holding of elections impractical" Thursday passed amendment Bills related to seven autonomous councils, authorising the governor to take the general council and the executive council, he may over the functioning of these bodies if holding of elections is found to be "impractical" even at the end of the mandated extended term of the elected committees.

Tribal Affairs minister Ranoj Pegu, who introduced the Bills, said that there is a provision of extending the term of the elected councils running these bodies for a maximum of one year. "The problem will arise if elections cannot be held even after the end of the extended period. And hence, these amendment Bills have been brought," he said.

The amendment Bills pertained to Mising Autonomous Council, Bodo Kachari Welfare Autonomous Council, Thengal Kachari Autonomous Council, Deori Autonomous Council, Sonowal Kachari Autonomous Council, Rabha Hasong Autonomous Council and Tiwa Autonomous Council. The amendment states that if the governor is "satisfied that circumstances so which the governor can (CONTD. ON PAGE-2)

assume to himself any or all of the powers and functions of these councils and appoint any person or interim council or authority to exercise the powers and functions

The normal term of the elected councils is five years. Taking part in a discussion on the Bills, Leader of the Opposition in the assembly, Debabrata Saikia of the Congress maintained that the arrangement for the interim period can also be done by bringing an ordinance and there was no need for making

amendments to the original Acts. Another Congress MLA, Abdur Rasheed Mandal, said the amendment will "weaken the councils" and give power to the gover-

## Sensex rallies 610 points to end above 74K on buying in RIL, firm global trends

MUMBAI, March 6: Benchmark Sensex rallied nearly 610 points to reclaim the 74,000 mark while Nifty closed above 22,500 on Thursday following heavy buying in Reliance on easing crude oil prices and firm global trends after US President Donald Trump softened stand on tariffs.

Recovering from early losses, the 30-share BSE Sensex jumped 609.86 points or 0.83 per cent to settle at 74,340.09, marking its second straight day of gains. During the day, it surged 660.57 points or 0.89 per cent to hit a high of 74,390.80.

The broader Nifty of NSE advanced 207.40 points or 0.93 per cent to close at 22,544.70. In the session, the 50-share barometer jumped 219.15 points or 0.98 per cent to hit an intraday high of 22,556.45. From the Sensex pack, Asian Paints, NTPC, Reliance Industries, Tata Steel, Bajaj Finserv, Hindustan Unilever, Sun Pharmaceuticals, Adani Ports & SEZ, Axis Bank, Tata Consultancy Services, Titan and Bajaj Finance were the major gainers.

Tech Mahindra, Kotak Mahindra Bank, Zomato, Tata Motors, and IndusInd Bank were the laggards.

'The Indian indices exhibited resilience, owing to positive global cues following Trump's softened



tariff stance on automakers from Canada & Mexico amidst the weakening dollar index," Vinod Nair, Head of Research, Geojit Financial Services said

A correction in crude oil prices, influenced by a slowdown in demand and further economic stimulus from China, ignited optimism in the energy and metals sectors, Nair added.

Broader markets also closed higher with the BSE smallcap gauge climbing 1.63 per cent and midcap index advancing 0.65 per cent.

Among the BSE sectoral indices, Energy, metal, Oil & Gas, Commodities, Utilities, Services, Power, healthcare, FMCG and In-

dustrials were the gainers. Telecommunication and Realty were the laggards.

As many as 3,007 stocks advanced while 989 declined and 107 remained unchanged on the BSE. The market capitalisation of BSE-listed firms climbed by ₹ 4,53,808.84 crore to 3,97,57,850.59 crore (USD 4.57 trillion). "The benchmark indices continued their positive momen-

tum. Among sectors, the Oil & Gas and Metal indices rallied over 2 per cent, whereas intraday profit booking was observed in IT and Realty stocks," Shrikant Chouhan, Head Equity Research at Kotak Securities, said.

"Markets extended their re-

bound, gaining nearly a percent on the weekly expiry day, driven by strong cues. After a gap-up opening, Nifty dipped in the early session but witnessed a notable recovery in heavyweight stocks across sectors, pushing the index higher and closing near the day's high at 22,528.15 level," Ajit Mishra - SVP, Research at Religare Broking Ltd, said.

Mishra further said the recent cool-off in crude oil and the dollar, along with the potential negotiations on US tariffs, has improved global sentiment and fuelled this rebound. In Asian markets, Tokyo, Shanghai, Hong Kong and Seoul ended higher.

European markets in the midsession deals were trading on a mixed note. Wall Street ended in the positive zone on Wednesday. Global oil benchmark Brent

crude rose by 0.52 per cent to USD 69.66 a barrel. Meanwhile, Foreign Institu-

tional Investors (FIIs) offloaded equities worth ₹ 2,895.04 crore on Wednesday, according to exchange data. On Wednesday, the BSE Sensex surged by 740.30 points to close at 73,730.23. Cutting short its record 10-day falling streak, the broader Nifty of NSE rebounded 254.65 points to settle at 22,337.30. (PTI)

### Borjan to get Sainik School

it was initially proposed at Khanduli in West Karbi Anglong but faced opposition from the people, adding, "A second proposal to set it up in Langkaijan was also rejected because of its proximity to the Marat Longri Wildlife Sanctuary. Finally, Borjan was chosen as the project site.'

"This is not just a Rs 1 or 2 crore project but a ₹ 4,000 crore project. It will provide jobs to 1,000 local youths. Candidates from other constituencies will not interfere-100% of the job opportunities will be given to local candidates of Borjan. The adjoining villages will benefit from road connectivity, and all households will receive free electricity. Additionally, the KAAC will earn revenue from this project," the CEM said.

He further mentioned that the Sainik School is a ₹ 375 crore project that will also create employment opportunities. Addressing concerns that students from outside Karbi Anglong might fill the seats, he clarified, "As per the agreement, 80% of the students will be from Karbi Anglong. The Sainik School will offer various facilities that students can benefit from." The CEM also announced a proposal to establish a biogas plant in Karbi Anglong. This proposal emerged after the Advantage Assam 2.0 summit held in Guwahati recently.

He stated that Chief Minister Himanta Biswa Sarma had identified Karbi Anglong as a potential location for a biogas plant to be set up by Reliance

Speaking on the proposed biogas plant, the CEM explained that it would run on grass, which could be cultivated by villagers.

"This project will generate employment for many local youths, both skilled and unskilled. Around 40,000 people from our district migrate to other states for work. Andhra Pradesh signed an MoU with Reliance for a similar project, which became a major revenue source for the state. We are not rushing into this. An interaction with all stakeholders, including student and youth organisations, intellectuals, and political leaders, will be held on March 8 in Diphu. If everything goes well and people agree, we plan to sign an agreement to lease land at ₹ 10,000 per bigha per year. If we provide 30 bighas, our revenue from the project could reach ₹ 50 crores annually," he said. Comparing the project with Andhra Pradesh, where seven lakh local youths were employed, the CEM assured that 100% of jobs in Karbi Anglong would be given to local youths.

He also highlighted the financial prospects for local farmers, stating that if grass for the biogas plant is cultivated, the income per bigha could reach ₹ 50,000 annually. For 20 hectares of land, the estimated annual income could be around ₹12 lakhs.

"The company will provide seeds free of cost and offer technical support for grass cultivation," he added. Ronghang also criticised opposition leaders for opposing the KAAC's efforts to implement various central and

state-sponsored welfare schemes. Additionally, he assured the people of Borjan that the KAAC would implement the demands outlined in their memorandum, which included improvements in road connectivity, access to safe drinking water, better medical facilities, school infrastructure, and playgrounds.

done so and continues the facility in Goalpara district of Assam. "All Indians languishing at the centre should be immediately released and the foreigners should be deported. The detention centre should be demolished. Many decisions are taken ex-parte there and the Supreme Court has also questioned this," he added. Independent MLA Akhil Gogoi drew the attention of the House that not only Hindus and Muslims were declared as 'D' voters, but people from the Nepali, Koch-Rajbongshi, Hajong, Garo and Rabha communities were also put under the category.

This entire problem would have been sorted out if the National Register of Citizens (NRC) were completed. The NRC found who was Indian and who was not. But it is just lying. If the NRC is wrong, please rectify it. The final NRC was released on August 31, 2019 by excluding 19,06,657 people. However, it has not been notified by the Registrar General of India yet, leaving the document without any official validity. "I request the government to table the NRC in the Assembly. Then we can recommend it to the Centre and settle this foreigner issue permanently," he added.

Stating that the detention centre is against human rights, Gogoi also claimed that very few foreigners have been deported after Chief Minister Himanta Biswa Sarma came to power compared to his predecessor Sarbananda Sonowal, while it was the highest during Congress CM Tarun Gogoi's tenure.

The biggest hurdle in deporting the foreigners is the absence of an extradition treaty with Bangladesh. So, I feel an Assembly resolution should be adopted requesting the Centre to sign a treaty with the neighbouring nation," he added.

Citing examples, Congress legislator Nurul Huda said thousands of Indian citizens have been suffering in the detention centre for years.

"People are dying inside the centre, but their bodies are not sent to Bangladesh. These are handed over to the relatives in Assam for the last rites. If they were Bangladeshis, why don't you send them to that country?" he questioned the government.

In a written reply on Monday, the CM said there are 1,18,134 'D' voters at present in Assam as informed by the Election Department.

He also said that there are 258 inmates at the transit camp as on February 24. Supporting the existence of the detention centre, BJP MLA Dipayan Chakraborty urged the government to release all the Hindu 'D' voters from the facility. AIUDF MLA Ashraful Hussain said 'D' voters are deprived of all basic facilities and identity documents like Aadhaar Card, PAN Card and Voter ID Card. "It is a political problem and cannot be solved by the legal system. A political solution has to be found for a permanent solution. This entire system was created to economically weaken a community," he added. Slamming the Foreigners Tribunals (FTs), Hussain said that if 'D' voter cases are registered against 126 MLAs of the Assam Assembly, 50 per cent of them will not clear the FT judgement. (PTI)

At the interbank foreign exchange, the rupee opened stronger at 86.96 and touched the high of 86.88 against the greenback during the day. The unit later turned volatile and hit the day's low of 87.16 before ending the session at 87.12 against the dollar, 6 paise lower from its previous closing level.

On Wednesday, the rupee settled 13 paise higher at 87.06 against the US dollar, registering the third straight day of gain. In the preced-

aren Analyst Asset Sharekhan, said the rupee lost initial gains and fell against the US dollar on selling pressure by FIIs, while the American currency fell to a four-month low as the US decided to delay implementing higher tariffs on imports from Canada and Mexico.

Looking ahead, the USDINR exchange rate is anticipated to fluctuate within a range of 86.40 to 87.70 in the short term, he added.

### Is China getting ready to challenge Trump?

ow is China, the second largest economic and military power of the world after the United States is planning to confront the second term US President Donald Trump's resurgence disrupting the so long established global order to impose his total domination on international politics? Every political analyst is looking at the current deliberations of the National People's Congress of China which began its week long session in Beijing on March 5. The timing of the session was decided earlier but the taking over of the U.S. presidency once again by the maverick leader on January 20 this year and his series of actions including the announcement of additional tariff on Chinese exports to the US just one day before the beginning of the Chinese Congress session has given a new dimension to the thinking of the policy makers of the Chinese Communist Party who have been closely monitoring the actions of the U.S. president regarding the earlier Israel-Hamas ceasefire deal and now the moves regarding ending the war in Ukraine. So far, China has been out of big focus of Trump as the U.S. President is deeply engaged in his moves regarding Ukraine involving President Vladimir Putin and Ukrainian President Volodymyr Zelensky but China knows that after consolidating his position in the event of the ending of Ukraine war, Trump will put all his guns to aim at China. Trump's advisers are saying that President Trump is hoping to conclude a deal with the Chinese president Xi Jinping on the basis of economic collaboration and investment sidelining other geo political issues for the present. Those will be taken up in the second phase since dealing China will be a tough task and the process will take time.

So far China has reacted to the tariff hike by making the point that Trump cannot threat China to submission, China is also imposing reciprocal tariff hikes and if Trump wants to have a trade war, China is equally ready for a war. This assertion emanates from the confidence of the Chinese leadership in the growth of the Chinese economy and its market and investment potential which has to be taken into account by the shrewd businessman Donald Trump who is a hardcore transactionist believing in what sort of package brings benefits to the American economy. The Chinese economy, despite its occasional hiccups like in the last two post covid years, is gearing up to fill the gaps and becoming vibrant in 2025 and 2026

Chinese Prime Minister Li announced the growth target of 5 per cent in 2025 in the annual government work report, which also outlined plans to stabilise economic growth by boosting domestic demand and creating 12 million new urban jobs. In the last two years, there was dissatisfaction in Chinese youth regarding the quality of jobs in urban areas. The sentiments got reflected in the social media pages of the high tech youth also. The Chinese report has taken note of that quality issue this time and appropriate jobs are being created in urban areas. Some western economists have been doubting about the possibility of recording five per cent growth in 2025 in view of the current trade war.

# Trump is out to destroy the world for the sake of American profits

The world has barely emerged from the shadow of the COVID-19 pandemic, a crisis that ravaged economies, disrupted supply chains, and sent financial markets into turmoil. Just as nations are striving to rebuild, another storm is brewing-one that threatens to be more insidious and longer-lasting than the pandemic itself. The economic virus known as the Trumpian tariff has begun its disruptive march, casting a pall over global trade and economic stability. The tremors are already evident; markets are reacting with unease, businesses are recalibrating their strategies, and governments are bracing for impact. The world is witnessing a chaotic and unpredictable shift in economic diplomacy, engineered by a leader who treats international trade like a high-stakes game of power and dominance.

Donald Trump's approach to tariffs is not merely a policy shift but an assault on the established world order. Trade wars are nothing new, but the way Trump has wielded tariffs as a weapon of retribution is unprecedented. Countries that have long been economic allies of the United States find themselves in the crosshairs. ### **Can govt complete delimitation process** before Lok Sabha election 2029?

Politics in South India, especially in Tamil Nadu, has become hotter on the issue of de-limitation of constituencies in India, after the first Census to be completed after 2026. Census

A assembly election and the resolve of the RSS cadres and leaders not to undertake electioneering in West Bengal unless the party president J P Nadda apologises for his Lok Sabha election eve remarks against the RSS, has finally forced the state BJP leaders to have a two-day long meeting with the state RSS leaders.

The importance of the two-day meeting could be gauged from the simple fact that almost all the state BJP leaders were present to sort out their differences with the RSS and provided an undertaking that they would abide by the directives of the Sangh. Even the turncoat leaders did not muster courage to oppose the stand of the RSS. The electoral exigencies could be made out from the fact that all the 27 frontal organisations of RSS were present at the meeting.

The meeting held in Uluberia of Howrah, is significant for the reason that it would send a positive message to the rural voters. Yet another reason that made the BJP to hold the joint coordination meeting has been the fact that the suburban areas of Kolkata have significant supporters and followers of the party in the lower middle class and intermediate migrant castes. These areas have sufficient number of RSS karyakartas (cadres).

Insiders maintain that state BJP leaders were the targets of the RSS functionaries, who charged the former with neglecting the task of the party building and simply being concerned with their personal gains and benefits. The leaders of these frontal organisations sought to know from the BJP leaders what was their contribution in strengthening the party at the base level and what they have done to reach out to the poor Hindus and voters of the state.

They were also asked to clarify what they had done to win over the trust of the Bengali people, and whether they had made any inroads into the Bengali aristocrat section. This is the class which plays the crucial role in building positive political narrative and thus expand support base among all sections of Bengali society. It



was pointed out that though this section was not happy with the functioning of Chief Minister Mamata Banerjee and her government, it has not yet distanced itself from her. While the Mamata government has not performed to the satisfaction of the common people, and especially to liking of the upper strata of the Bengali society, the BJP leadership had as yet failed to exploit the performance gap and win over the people. Mamata Banerjee had virtually

finished off the Congress in the state. Almost all the TMC cadres and leaders are old Congress workers. They were averse to the state Congress leaders joining hands with the CPI(M), which was why they had followed Mamata in her endeavour to float TMC. However, now in a changed situation, with Rahul Gandhi unwilling to go along with CPI(M), has been motivating some of these old workers to come back to Congress. It is worth mentioning that Congress won one Lok Sabha seat and got around 7 percent of the popular vote in Bengal. In 2021 assembly election, the Congress

had secured only 2.38 per cent. The RSS leaders also pointed out that BJP has lost around 4 per cent of its vote in 2024, which it had got in 2019.

The RSS insiders maintain that dynamics of intense differences between the RSS and the BJP has forced the national leadership to intervene. Initially, the turncoats led by the leader of opposition in

the assembly, Suvendu Adhikari, had fed the central leadership with the impression that everything was fine and they were in command of the situation. They had even assured them that the saffron ecosystem would succeed in defeating Mamata Banerjee's TMC. But the 10-day visit of RSS chief Mohan Bhagwat had exposed them.

At his meeting with the RSS cadres of south and central Bengal, Bhagwat had come to comprehend from the briefings by the Sangh cadres, that BJP would not even be able to keep the seats it had won in2021 elections. This time its seats may even decline to 30 from the present 77. This scenario has been indeed a matter of serious concern for the RSS, more than the BJP. In the defeat of BJP, the RSS will lose its support base and that would also symbolise shifting of its cadres to the TMC. RSS is omnipresent. During the

ten-year rule of the BJP government, it has penetrated deep in to the police, military, judiciary, bureaucracy and academic sectors of the country. All the frontal organisations have accomplishing their missions diligently. Though Modi has been harping on political slogan of Hindutva, the strategy of RSS to engage the people at psychological level has been most

dangerous for the secular and democratic forces. The RSS has been achieving its mission through cinema and literature. This has aroused the communal passion amongst the Hindus to an unbelievable level.

RSS leaders want to capture power in Bengal as it enables the Sangh to bring Bengal's culture and social tenets under its control and thus dictate its course. Bengali society is still relatively liberal and open. Unless it is regimented, the RSS cannot aspire to rule over the entire east as well as north India. To depend on the turncoats is its compulsion. RSS leadership has been actively interfering in the political activities and ensuring the victory of BIP in various elections at the national and state levels, even though the RSS continues to project itself purely as a cultural organization.

The painstaking initiative that RSS undertook during the Haryana, Maharashtra and Delhi elections has strengthened peoples' perception of it being an active political tool. Nevertheless, RSS hangs on to the image of the Sangh being an 'apolitical' and 'cultural' organization, with nothing to do with the BJP's election efforts or its decision-making process. Its participation in the electoral process would also be projected as a mechanism to protect and strengthen the cultural and social ethics of the Hindu society, than working to ensure the victory of BJP. It is this compulsion of winning the assembly elections of Bihar and Bengal that has forced the RSS to adopt a more obliging stance. (IPA Service)

process in yet to be started, though it was to be started in early 2025, a process which takes about 18 months to be completed. Registrar General and Census Commissioner's tenure was extended until August 2026, which was an indication that the Centre had planned the Census process to be completed by that time. Centre plans to complete the delimitation process by 2028 and the Lok Sabha General Election 2029 to be held as per new delimitation order. However, a new twist has come after the allparty meeting in Tamil Nadu on March 5, 2025, when Chief Minister M K Stalin demanded postponement of delimitation for the next 30 years.

Only a week before Union Minister of Home Amit Shah had assured in an event on February 26 in Tamil Nadu, "Today a meeting will be held to ensure the South does not suffer on account of delimitation. The public in Tamil Nadu is disturbed. This is why the Tamil Nadu CM (Stalin) and his son (Udhayanidhi) are trying to distract the public. Mr Stalin, the Modi government has made it clear in Lok Sabha that after delimitation, on pro rata basis, not a single seat will be reduced in any southern state. And I want to reassure the public of South India that Modiji has kept your interest in mind to make sure that not even one seat is reduced pro rata. And whatever increase is there, southern states will get a fair share, there is no reason to doubt this.

Only a day earlier, CM Stalin has described the delimitation process as a "sword hanging over the head of South India." He had warned that Tamil Nadu could lose up to eight of its 39 Lok Sabha constituencies due to the delimitations exercise, poten-tially reducing its seats to 31. He had called for all party meeting on the issues on March 5, 2025. The outcome of the meeting held a week after Amit Shah's assurance suggests that there were no takers of his assurance. Barring the BJP and its ally TMC, all the political parties of the state participated in the meeting. The meeting passed a resolution demanding that the freeze on the number of seats in Lok Sabha based on the 1971 Census should be extended for another 30 years. A joint committee of MPs from all parties in South India has also been proposed to draft a joint response to the issue.

CM Stalin said that Tamil Nadu and Southern states should not be punished for effectively implementing population control measures, adding, "Delimitation exercise solely based on population figures will be a gross injustice to Tamil Nadu and other Southern States. We are not against Delimitation exercise, but we want justice to be rendered to us.<sup>2</sup>

South Indian states have serious apprehension about the real intensions of PM Narendra Modi led BJP government suspecting them of trying to establish political hegemony of the BJP through increase of Lok Sabha seats from the Hindi belt states, chiefly Uttar Pradesh, Bihar, Madhya Pradesh and Rajasthan.

The basis of delimitation is yet to be worked out, but there are speculations on the basis of certain indication, such as the increase of seats in the new parliament building in New Delhi. The New Parliament building ahs 888 seats. Currently, we have altogether 543 MPs, which works out to be one MP representing about 10 lakh people. The delimitation was based on the 1971 population.

Population of the country has been something around 142 crore in 2025. The increase of seats in Parliament building is indicative of the government intention to increase the number of MPs. If we decide one MP for 20 lakh population there would be 707 seats. If we decide for one MP in 15 lakh population, total seats would be 942. As per the 2024 Lok Sabha election figures, each Lok Sabha Con-stituency had 17.84 lakh voters on projected population of 25.8 lakh.

During a parliamentary debate in September 2023, on Women's Reservation Bill, the implementation of which was also linked to delimitation on the first Census after 2026, the issues of parliamentary seats was discussed, in which MPs for Southern states have raised the issue and expressed their concern of losing their representation in the parliament of India.

If one MP per 20 lakh population is adopted Tamil Nadu's seats would remain the same at 39, while seats in Uttar Pradesh including Uttarakhand would increase from current 85 to 126 and Bihar including Jharkhand would increase for 54 to 85.

On projected population of 142 crore, Lok Sabha Constituencies are to rise to 848. In that case the number of seats in Uttar Pradesh would increase from 80 to 143, Bihar from 40 to 79, Rajasthan from 25 to 50 and Madhya Pradesh from 29 to 52.On the other hand, in the southern states - in Tamil Nadu it would increase from 39 to 49, Andhra and Telangana from 42 to 45, Karnataka from 28 to 41. As for Kerala is concerned its seat will remain at 20.

Southern states say that in that case the party who will win in Hindi belt states would be able to form government at the centre, which would bring them under the dominant political party in the Hindi belt states – UP, Bihar, Madhya Pradesh, and Rajasthan. BJP is interested to establish its permanent government in India on the basis of new delimitation order before the Lok Sabha election 2029.

In this situation, one can expect more twists in the delimitation row, in the coming months when the issue of reservation of seats for SCs, STs, and Women will bring some more trouble and rows. The million dollar question remains - Could India be able to complete delimitation process before Lok Sabha election 2029? (IPA Service)

# 'Trump Gaza proposal was pre-meditated with Israel'

n an article in the Palestine Chronicle: "Arab Consensus Challenges Trump's Ethnic Cleansing 'Proposal' for Gaza", Dr. Mohannad Mustafa from the Haifa University's School of Political Sciences exposes the raison d'être behind Trump's original proposal' for the ethnic cleansing of Gaza, and what now appears his intent to back away.

Mohannad Mustafa avers that Trump's plan was not a mere afterthought. It was pre-meditated. Trump had wanted "to implement (the plan) since the beginning of the assault. The Israel far-right had embraced the idea with great zest after it was clandestinely agreed upon between the US and Israel. In the thick of war, Israel's Ministry of Intelligence had developed a meticulous plan for the extinction of Palestinians from Gaza and sending them to several countries - not just in the region, but even in lands far from Palestine.

Dr. Mustafa describes the plan as one that was, in fact, one of the unofficial objectives of the war". In the event of a victory, which would have left Gaza battered-beyond-reconstruction, Israel's Ministry of Intelligence had prepared a detailed plan for the deportation set-up in Gaza. This gives further credence to the suspicion that this was Trump's plan and that he had no intention to be a peacemaker. In his mind, he willed to be just another land grabber much like his colonialist collaborators. But he wore the garb of a 'solution finder'

His threat that all "hell would break loose" if the fighting did not end on the day he assumed Presidency, was meant to be a threat to Hamas fighters, and the people of Gaza. Mohannad Mustafa reports that the Institute for Jewish Peoplehood Policies found that 53% of Israeli Jews supported the proposal and its implementation, while 30% supported it but thought it not viable. Clearly, there was a build-up to the plan to ethnically cleanse Gaza. Very few Israeli's expressed qualms about this malevolent plan. The Peace Movement,

though convinced of its mischievous intent, was simply too feeble to make a difference The plan had acquired broad consensus among policy makers to the extent

that the Israeli Security Cabinet officially adopted Trump's plan during its first meeting after Netanyahu's return from the UŠA. Israel had jumped the gun when it thought that it was rid of the Gaza imbroglio once and for all. But foolishly! Dr. Mustafa writes that Netanyahu publicly conceded that Israel had worked with the US administration in shaping the plan and influenced Trump's position on it. The plan lies down in the dumps as deadwood, and has no chance, whatsoever, of turning up.

When Trump eventually pulled back from the plan in a policy, he had to rationalize his conclusion. His reversal included a lame statement saying that "he would not impose it but only recommend it". That was not only patronizing, but a downright perversion of the facts. The droves of displaced Gazans who returned to their battered homes in Northern Gaza clearly showed that, despite the mauling they received during the war, the death-count, and destruction of basic infrastructure, they were not going anywhere. Gaza was theirs and they were there to stay. They declared in no uncertain terms that "Gaza is not for sale" referring to Trump's dodgy proposal to turn Gaza into a "Riviera of the Middle East".

The Arab League was decisive. They would find a relevant resolution that fitted in with the realities of the region. Jordan nor Egypt declared they would not accept Palestinians if they were forcibly displaced. And they had good reason. The Egyptian regime knows full well the Palestinians in Gaza will not stop resisting until all of Palestine is liberated. If Hamas attacks Israel from the Egyptian Sinai, Israel would respond with military force. The Egyptian regime would have faced two choices: One, not responding and immediately, thus losing the little acceptance it still

has among Egyptians. Two, responding and going to war with Israel would mean the end of the proxy regime. Simply put, allowing the population of Gaza into Egypt would mark the end of the Egyptian surrogate regime.

Many have claimed that Egypt is also rejecting Trump's plan to avoid being viewed as complicit in ethnic cleansing. In truth, Egypt has already been complicit for the past 16 months, standing by as Gazans were massacred without taking action to protect them. Their current position only reinforces this complicity. The deaths and injuries of hundreds of thousands were not enough to prompt a stand. The real red line was marked when Israel's actions posed a threat to Egypt's sovereignty and the survival of its regime.

Jordan, as a neighboring country, has a complex relationship with Palestine and Gaza. Jordan is concerned about potential security threats from Gaza, given the ongoing conflict with Israel. Jordan also has qualms about the potential impact of Gazan refugees in terms of the country's stability and domestic politics. Jordan is already hosting a large number of refugees from Syria and other countries, which puts a significant strain on its resources. Jordan's economy is facing significant challenges, including high unemployment and debt, which might make it difficult to absorb more refugees. To add to the complexities, Jordan has a peace treaty with Israel, and accepting Gazan refugees might be seen as complicating that relationship. Jordan's decision to accept Palestinian refugees would also be influenced by regional dynamics, including its relationships with other Arab states and the international community. Given that Gazans confront a severe humanitarian crisis, including a blockade, poverty, and lack of access to basic services, Jordan would inherit the responsibility to be the provider of humanitarian assistance to Gazans.

While Trump and Israel, as well the Real Estate syndicates elsewhere in the world, notably in the USA, had their lips

smacking at the thought of a sea-front villa on free land, Trump had to backtrack swiftly seeing the repercussions and consequences were potentially disastrous. Trump still had to save face. He got the world to make-believe that his chic mode to the reconstruction of Gaza, which the US would own, was workable. No. It simply was not. The 'Riviera' construct was going to be ethnic cleansing with a fancy name and just another war crime. Trump shifted from his political idiom to virtual silence on the initiative, and shut down all banter within his US administration. In fake pride, he adamantly declared that his plan "was excellent". He conceded he would "not impose it but only recommend it".

Clearly, Hamas had won the war on another front. And, their only weapon was sheer defiance and resilience. It reminds this writer of what Mahatma Gandhi once said about the struggle for India's independence: "First, they ignore you, then they laugh at you, then they fight you, then you win." Gaza could claim 'Zafer' (Arabic for victory) The Arab League in atypical tone rejected U.S. President Donald Trump's Gaza relocation plan, terming it unacceptable. Arab League secretary-general Ahmed Aboul Gheit said today their focus is on Gaza and tomorrow it will shift to the West Bank. Gheit said the Arab world has opposed this idea for 100 years and they are not about to cede now.

Now, with a ceasefire in place, Trump and Netanyahu are seeking to upset the applecart with a string of pretexts. Even those are going nowhere. They have are shedding crocodile tears about the condition of Israeli hostages. Trump did not want the exchange in drips and drabs; rather he wanted a quick and total transfer of hostages. Washington does not understand the Palestinian spirit of "Summud" (steadfastness). The cultural divisions and worldview are like cheese and chalk.

Every Israeli hostage has, upon release, extolled the quality medical care,

adequate diets for the sick, and medical attention. Israeli hostages were unequivocal in their praise for the religious and humane values of Hamas hostage takers. One of them declared that "if there were another war involving Gaza and Israel, he would probably join Hams as a muiahidin for Hamas

In stark contrast, Palestinian prisoners have been subjected to cruelties while in Israeli detention. Jenin and other cities have been brutally attacked. Even there, the Palestinian remains bold and resistanceprone. Of course, they fear for their children and youth. So the Israeli Occupying forces (IOF) are now using two fronts - both tacitly - and outside the radar of international attention. But they have been called out.

AA, Turkey reports that there have been over 350 violations of the January 15 ceasefire agreement by Israel. Ismail al-Thawabteh, chief of government ability to receive family visits, obtain media, has said: "The Israeli occupation

has violated the ceasefire agreement more than 350 times since it was signed, clearly demonstrating its continued breach of commitments and its defiance of the international community." Since the ceasefire was signed on Jan. 15, the Israeli army has killed and injured dozens of Palestinians through airstrikes, including those carried out by fighter jets and drones, as well as direct shootings or drone strikes. Further violations include Israeli incursions into border areas east of the Gaza Strip.

Hamas reported multiple Israeli breaches of the ceasefire, such as delaying the return of displaced individuals to northern Gaza, targeting Palestinians with airstrikes and gunfire, obstructing the entry of shelter supplies, and delaying the arrival of medical necessities. Since the start of the ceasefire agreement, Israel has killed 92 Palestinians and injured 822 others in direct attacks.

United Nations Secretary-General António Guterres affirms: "Any refusal to accept the two-State solution by any party must be firmly rejected." The denial of the right to Statehood would indefinitely prolong the conflict, and a one-State solution — huge Palestinian populations inside that State without any real sense of freedom, rights and dignity would be inconceivable. Rivad Al-Maliki, Minister for Foreign Affairs and Expatriates of the State of Palestine, said that Israeli leaders "do not see our people as an empirical and political reality to coexist with, but as a demographic threat to get rid of through death, displacement or subjugation"

There are only two paths ahead, he stressed - one that starts with Palestinian freedom and leads to shared peace and security in the region, or one that continues denying this freedom and dooms the region to endless conflict. "Israel should no longer entertain the illusion that there is somehow a third path whereby it can choose continued occupation and colonialism and apartheid and somehow still achieve regional peace and security," he emphasized. The recent emergence of the National Citizens Party, a studentled political formation, raises a compelling question: Can a party born out of a student movement, lacking an established political pedigree, truly become a dominant force in the country's politics?

To answer this, we must examine the critical elements that drive political success in Bangladesh. The factors pose significant challenges to the National Citizens Party's ambitions, making its rise to power an uphill battle. ndia's urgent search for 114 multi-role fighter aircraft and Laspiration for the fifth-generation development programme just got more complicated. United States (US) President Donald Trump has sprung a surprise offer of the F-35 Joint Strike Fighter (JSF), while the Russians have offered to partner with India on their S-57 E Felon production with Hindustan Aeronautics Limited (HAL) by this year itself. These offers have caught the mainstream and social media's attention, fuelling widespread debate and speculation. With the US actively leveraging the imposition of trade tariffs while boosting military sales to India, the offer comes

From a strategic perspective, how the first-time purchase of US fighters will impact the longstanding Indo-Russian relations will need to be seriously considered. The deal will certainly impact India's own fifth-generation Advanced Medium Combat Aircraft development, its future Combat Air Teaming System programme, and the future AD systems, as it is all-important they integrate operationally with all of IAF's mainstream combat platforms and sensors of 'non-US' origin. India's further development of the Tejas fighter that remains hostage to US-supplied engines and has already been interminably delayed highlights a big red flag. The US offer wi need to be closely assessed against the long, steady, and relatively more reliable strategic relationships with Russia and France to ensure the preservation of India's strategic autonomy. The final choice must take into consideration that the Rafale and the Su-57 are 'well-balanced platforms' with 'solid upgrade programs', 'free of US content' and would be more cost-effective to operate in the long run. The necessity to arrest the IAF's reducing combat strength since over two decades, continues in its downward spiral especially with the urgently needed purchase of the 114 multi role fighter aircraft (MFRA), is also stagnating amidst indecision, apathy, a 'broken' procurement system[3]. and a systemic failure to grasp the long-term consequences. The nation's MFRA requirement is entirely separate from the indigenous fifth-generation fighter aircraft production aspirations, and the distinction is imperative to prevent the further exacerbation of an already complex imbroglio. An expedited MFRA purchase is a critical requirement to prevent air power's contribution to the nation's conventional deterrence from weakening any further, as it will directly impact our national security in the air. land and sea domains. The Indian military can ill afford to ignore air power, considering that our two main adversaries have strong air forces. The fifth-generation fighter requirement, on the other hand, is a natural process of continuous improvements in platform, systems and weapons capabilities, which, if not ensured, will swiftly lead to the redundancy of IAF's air power. Considering the inevitable proliferation of fifth and sixth gen fighters in the inventory of India's adversaries, the choice must be military-driven to bolster the nation's conventional deterrence. balanced with its future growth, geopolitical trajectory, and strategic autonomy. A wasted momentum?

The National Citizens Party emerged from the Anti-Discrimination Student Movement and the National Citizens Committee, both of which played crucial roles in last year's protests that led to the overthrow of Sheikh Hasina's government. Yet, the party's formal launch came months after the height of the movement, raising concerns that it squandered its political momentum.

Revolutions are driven by emotion, and as famed political scientist Samuel P Huntington noted in Political Order in Changing Societies, "Revolutionary movements are most successful when they consolidate power before the fervor of the masses dissipates.

Had the National Citizens Party been formed immediately after the July-August uprising, it could have capitalised on the raw energy of the people, channeling it into a structured political movement. Instead, the delay has allowed competing political forces to reclaim lost ground, diminishing the party's initial advantage.

Additionally, in the months following the protests, public focus has shifted toward deteriorating law and order, economic instability, governance concerns, and global crises, further diluting the impact of the movement that gave rise to the National Citizens Party. This delay has resulted in a loss of urgency, making it harder for the party to maintain relevance.

#### Where is the charisma?

Politics in Bangladesh is deeply personal. The country's most successful political movements have been spearheaded by leaders who commanded near-religious devotion. Sheikh Mujibur Rahman, Ziaur Rahman, Hussain Muhammad Ershad these were not just politicians; they were symbols of their movements.

The National Citizens Party, by contrast, lacks a comparable figure. Its leadership structure is collegiate, with Nahid Islam as the convener and other members filling key positions. While this structure reflects an attempt at collective leadership, history suggests that movements without a singular, unifying leader rarely succeed.

Without a leader who can electrify the masses, the National Citizens Party risks becoming another faceless organisation lost in Bangladesh's chaotic political arena.

Additionally, the party's reliance on an intellectual and academic base, while beneficial in policy-making, does not necessarily translate to mass appeal. Successful

political figures often possess a combination of personal charm, rhetorical skills, and an ability to connect with diverse demographics.

The National Citizens Party's current leadership must find a way to embody this inspiration if they hope to transition from student activists to national leaders.

#### New voters equation

One factor that could work in favour of the newly formed political party in Bangladesh is the emergence of nearly four crore new voters over the past 16 years, a period marked by multiple voterless elections under the Awami League.

These young voters, disillusioned by the lack of democratic processes, might have been expected to form a potential base for an alternative political force. However, the reality is far more complex.

These new voters are scattered across the country, making it extremely difficult for any single party - especially one without established grassroots networks – to mobilise them effectively.

While they may collectively yearn for change, their geographical dispersion means they do not form a concentrated voting bloc capable of making a significant electoral impact.

Without a centralised structure to harness their collective power, their votes will likely remain fragmented, reducing their overall influence in the political process. The new party may gain pockets of support among the youth, but without a mechanism to convert that support into a strategic advantage, it will struggle to

#### make a meaningful difference. The missing infrastructure

Bangladesh's major parties – the BNP, the Awami League, and Jamaat-e-Islami have extensive grassroots networks that stretch into the remotest villages. These networks are crucial for mobilising voters, influencing local politics, and ensuring electoral success. The National Citizens Party, despite its urban student base, lacks such an infrastructure.

History teaches us that no political party can sustain itself without a strong grassroots network. The Aam Aadmi Party in India, for example, found early success in Delhi but struggled to expand nationally due to its weak rural presence.

The National Citizens Party must recognise that mobilising students and urban activists is not enough. Without an extensive network of local organisers, it will struggle to convert enthusiasm into electoral victories. Building strong alliances with trade unions, farmers' associations, and local organisations could provide the National Citizens Party with a much-needed foundation beyond the university campuses.

Can it break the dynastic grip?

One of the biggest hurdles facing the National Citizens Party is Bangladesh's entrenched culture of dynastic politics. The Awami League is synonymous with the Sheikh Mujib family, while the BNP remains centered around the Zia family. In a political culture where legitimacy is often equated with family lineage, new parties struggle to gain traction.

Even outside Bangladesh, dynastic politics remains a formidable force. In India, the Nehru-Gandhi family has dominated the Congress Party for decades. In Pakistan, the Bhuttos and Sharifs continue to wield power. The challenge for the National Citizens Party is convincing voters that political legitimacy does not require a famous last name.

While the fall of Sheikh Hasina's government created a momentary crisis, it has not yet been sufficient to upend the dominance of established dynasties.

'Second republic' – a political gambit? The National Citizens Party's call for a "second republic" signals its intent to radically reshape Bangladesh's political landscape. This vision includes drafting a new democratic constitution, eliminating corruption and nepotism, and strengthening national security.

While these goals are ambitious, radical political transformations are difficult to implement without significant institutional backing. As noted by historian Theda Skocpol. "Revolutions succeed not because of ideals alone, but because they control the machinery of the state." Without control over major institutions - military, judiciary, bureaucracy – the National Citizens Party's vision risks being more rhetorical than actionable.

Despite its challenges, the National Citizens Party is not necessarily doomed to irrelevance. Political history is full of movements that overcame initial skepticism. If the party can overcome all challenges, it might carve out a viable political space. Otherwise, it risks becoming another forgotten chapter in Bangladesh's political narrative. As Nelson Mandela once said, "It always seems impossible until it is done." with added complexities. Two questions immediately come to the fore: Does the platform satisfy the operational requirements of the Indian Air Force (IAF) with its depleting fighter squadron bench strength? Does the deal make strategic sense for India's geopolitical dynamics?

An analysis of a fighter aircraft is much than the surge of somewhat simplistic number-crunching comparisons being aired. The F-35 has been a trouble-ridden pro-

gramme that has faced serious reliability, availability, and maintenance issues as it struggles to meet testing guidelines and mission readiness goals. Its stealth features are difficult to maintain and have not been fully tested, and its logistics train is so long that it is difficult to deploy. are some key issues as per the US 'Fiscal Year 2024 Annual Operational Test and Evaluation report published at the end of January 2025. Cost overruns are another chal-

lenge as the original estimate was US\$200 billion to develop and purchase approximately 3,000 F-35s, which today, have doubled to US\$412 billion for a fleet of 2,456 platforms. The JSF has been called a 'trillion dollar trainwreck' that has 'hollowed out the US Air Force'. The project has also come into the crosshairs of Elon Musk, who leads the unofficial US Department of Government Efficiency for fiscal cuts in governmental spending.

The exorbitant F-35 will severely limit the number of squadrons that can be purchased, and numbers matter for retaining India's conventional deterrence. It will also have enormous hidden costs for setting up dedicated maintenance and repair infrastructure, facilities, and equipment, as the IAF has had to do with the US C-17, C-130, and Apache fleets. Then comes the cost of weapons with their environment-controlled storage and testing facilities and operational mission support systems. Given the limited number of squadrons that the IAF can afford, it means that it would have effec-

not be able to integrate into IAF's net-centric operations as the datalink and networking protocols of its mainstay fleet of SU 30, airborne warning and command systems, airborne early warning control aircrafts, indigenous radars, and Active Denial Systems (ADS). This also means that the platform cannot be a part of any composite multi-platform packages necessary for penetrating, attacking, and surviving adversarial air defence systems in the IAF's offensive counter-air missions and



strategic deep strike missions. It will not form part of future integrated air operations of the IAF and joint operations, where aerial and surface sensors and shooters of the Army and Navy are also combat-networked, a vital future joint warfighting imperative. Its single engine will not only affect its combat survivability, but the prohibitive high cost of the aircraft will be a serious safety concern for peace-time training in bird-intensive environments.

The long history of close relationship and military assistance to Pakistan—an important strategic lever of the US and its militarywill be an added dynamic in the combat employment of the F-35 against the Pakistan Air Force's mainstay F-16 fleet. Equally, operating on a daily basis with the IAF's Russian origin fighters, EW equipment, and AD weapon systems will be an issue with the US. There are also bound to be peacetime restrictions of operating the platform close to India's northern borders with Chinese electronic and signal intelligence collection sensors, further impacting IAF's

On the specific issue of tariffs, the minister noted that Commerce and Industry Minister Piyush Goyal is currently in Washington to discuss a bilateral trade pact, following discussions between Prime Minister Narendra Modi and President Trump at the White House last month.

"We had a very open conversa-tion about it (tariffs) and the result of that conversation was that we agreed on the need for a bilateral trade agreement," he said.

During the exchange with Chatham House Director Bronwen Maddox, he covered a broad spectrum of issues, including his "cautious optimism" over the India-UK Free Trade Agreement (FTA) negotiations after his ministerial discussions over the past few days.

"It's a very complicated process. So, given the complexity, it's natural that it would take time... from my discussions with Prime Minister (Keir) Starmer, Foreign Secretary David Lammy and [Business] Secretary Jonathan Reynolds, I got a consistent message that the British side is also interested in moving forward. I had a few points to convey on behalf of my concerned colleagues as well. So, 'm cautiously optimistic and hope that it doesn't take that long," he said.

On China, Jaishankar noted some positive movement since October 2024, including the opening of the Mount Kailash pilgrimage route in Tibet.

"We have a very, very unique relationship with China as the only two billion plus populated countries in the world... we want a relationship where our interests are respected, sensitivities are recognised and works for both of us," he said.

Responding to an audience question on "solving" issues in Kashmir, the EAM stated: "On Kashmir, actually we have done, I think, a good job solving most of it. Removing Article 370 was step number one, restoring growth and economic activity and social justice in Kashmir was step number two, and holding elections with a very high turnout was step number three.

FRANKFURT, March 6: The impact of a potential trade war with the United States and massive increases in European defence spending and government borrowing loom over a policy meeting Thursday at the European Central Bank, which is expected to cut interest rates by a quarter percentage point.

Analysts are widely expecting a cut in the European Central Bank's (ECB) benchmark deposit rate to 2.50 per cent, a step to lower borrowing costs for consumers and businesses in an economy that's struggling to get out of first gear.

The bank's monetary policy statement and post-meeting news conference by President Christine Lagarde will be scrutinised for hints about how far the bank will cut rates amid concerns about weak growth. The bank has already reduced the benchmark rate by 1.25 percentage points since June.

Meanwhile new concerns that would massively reshuffle the economic picture are likely to intrude: the potential impact of new tariffs on European imports from US President Trump, which could slow growth, and plans for massive

the White House said Wednesday that US officials have engaged in "ongoing talks and discussions" with Hamas officials, stepping away from a long-held US policy of not directly engaging with the militant group.

Confirmation of the talks in the Qatari capital of Doha came as the Israel-Hamas ceasefire remains in the balance. It's the first known direct engagement between the United States and Hamas since the State Department designated the group a foreign terrorist organiza-

White House press secretary Karoline Leavitt declined to provide detail on the substance of talks, but said President Donald Trump has authorized his envoys to "talk to anyone."

Egyptian and Qatari intermediaries have served as mediators with Hamas for the US and Israel since the group launched its Oct 7, 2023 attack on Israel that sparked the war.

"Look, dialogue and talking to people around the world to do what's in the best interest of the American people is something that the president . believes is a good-faith effort to do what's right for the American people," she said.

Leavitt added that Israel has been consulted about the direct engagement with Hamas officials, and noted that there are "American lives

Israeli Prime Minister Benjamin Netanyahu's office offered a terse acknowledgement of the U.S.-Hamas talks. "Israel has expressed to the United States its position regarding direct talks with Hamas," the prime minister's office said.

Those two forces could push the ECB in opposite directions: a hit to growth would call for lower rates, while more persistent inflation would argue for keeping rates higher in coming months.

Growth estimates for Germany, the eurozone's largest economy, shot up overnight and long-term interest rates rose following an agreement by the two parties that will form the country's next government to loosen constitutional limits on borrowing and exempt defense spending.

COLOMBO, March 6: Deshabandu Tennakoon, theoretically still the island nation's police chief, is being treated as a fugitive and his team members are on a trail to arrest him, police spokesman Buddhika Manathunga said here on Thursday. A warrant has been issued for arresting Tennakoon, under suspension since July 2024 and is on the run, and the Criminal Investigations Department (CID) has been tasked with locating him. The Magistrate's court in the southern town of Matara had last week ordered Tennakoon be arrested over a shooting incident in the southern resort town of Weligama, about 150 kilometres southeast of Colombo, on December 30, 2023.

Sri Lanka's police chief

Tennakoon, as the inspector general, had sent police officers from the Colombo Crime Division (CCD) to the resort hotel in Weligama for a raid in connection with illegal drugs.

However, the Weligama police, unaware of the undercover operation, opened fire at the CCD vehicle killing an officer.

Manathunga told reporters that the court ruled that the undercover operation was illegal and eight police officers, including Tennakoon, must be arrested. Tennakoon, who was suspended by the highest court, is absconding and raids have been carried out since last week at locations where Tennakoon was likely to be. The court has issued a travel ban on him. We seek public support to arrest him. We treat him as a suspect, Manathunga said. (PTI)

on Thursday brushed off President Donald Trump's latest threat and reiterated that it will only free the remaining Israeli hostages in exchange for a lasting ceasefire in the Gaza Strip.

Hamas accused Trump and Israeli Prime Minister Benjamin Netanyahu of trying to back out of the ceasefire agreement they reached in January. The agreement calls for negotiations over a second phase in which the hostages would be released in exchange for more Palestinian prisoners, a permanent ceasefire and an Israeli withdrawal from Gaza.

Hamas spokesman Abdel-Latif al-Qanoua said the "best path to free the remaining Israeli hostages" is through negotiations on that phase. which were supposed to begin in early February. Only limited preparatory talks have been held so far. On Wednesday, Trump issued what he said was a "last warning" to Hamas after meeting with eight former hostages. Hamas has rejected the proposal and says it is sticking with the agreement signed in January.

Israel has cut off the delivery of food, fuel, medicine and other supplies to Gaza's roughly 2 million Palestinians in an attempt to pressure Hamas into accepting the new arrangement. It has threatened "additional consequences" if Hamas does not resume the release of hostages. (AP)

ZEALAND), March 6: New Zealand's most senior envoy to the United Kingdom has lost his job over remarks he made about US President Donald Trump at an event in London this week, New Zealand's foreign minister said Thursday.

Phil Goff, who is New Zealand's High Commissioner to the UK, made the comments at an event held by the international affairs think tank Chatham House in London on Tuesday.

Goff asked a question from the audience of the guest speaker, Finland's Foreign Minister Elina Valtonen, in which he said he had been re-reading a famous speech by former British wartime leader Winston Churchill from 1938, when Churchill was a lawmaker in the government of Prime Minister Neville Chamberlain.

Churchill's speech rebuked Britain's signing of the Munich Agreement with Adolf Hitler, allowing Germany to annex part of Czechoslovakia. Goff quoted Churchill as saying to Chamberlain, You had the choice between

HONG KONG, March 6: Hong Kong's top court on Thursday overturned the convictions of three former organisers of an annual vigil in remembrance of the 1989 Tiananmen Square crackdown over their refusal to provide information to police, marking a rare victory for the city's pro-democracy activists.

Chow Hang-tung, Tang Ngokkwan and Tsui Hon-kwong - core members of the Hong Kong Alliance in Support of Patriotic Democratic Movements of China were convicted in 2023 during Beijing's crackdown on the city's pro-democracy movement. They received a sentence of 4 1/2 months and have already served their terms.

The alliance was long known for organizing candlelight vigils in the city on the anniversary of the Chinese military's crushing of the 1989 pro-democracy protests in Beijing. But it voted to disband in 2021 under the shadow of a sweeping national security law imposed by China

Critics said the shutdown and the case showed that the city's

Western-style civil liberties were shrinking despite promises they would be kept intact when the former British colony returned to Chinese rule in 1997

Before the group dissolved, police had sought details about its operations and finances in connection with alleged links to pro-democracy groups overseas, accusing it of being a foreign agent. But the

group refused to cooperate, insisting it was not. On Thursday, judges at the Hong Kong Court of Final Appeal unanimously ruled in the trio's favour. Chief Justice Andrew Cheung announced the decision in court

The prosecution needed to prove that the alliance was a foreign agent, the judges wrote, adding that the lower courts "fell into error" in holding that it was sufficient merely that the police commissioner said he had reasonable grounds to believe the alliance was a foreign agent. In a lower court trial, the appel-

lants also took issue with crucial details that were redacted, including the names of groups that were

alleged to have links with the alliance.

The judges ruled that by redacting the only potential evidential basis for establishing that the alliance was a foreign agent, the prosecution disabled itself from proving its case.

"Non-disclosure of the redacted facts in any event deprived the appellants of a fair trial," they wrote.

After the ruling, Tang told reporters outside the court that he hoped the top court's ruling proved that the alliance was not a foreign agent and that in the future they could prove that the 1989 movement was not a counter-revolutionary riot.

"Justice lives in people's hearts. Regardless of the outcome, everyone knows the truth in their hearts," he said.

During an earlier hearing at the top court in January, Chow, who represented herself, said her case highlighted what a police state is.

"A police state is created by the complicity of the court in endorsing such abuses. This kind of complicity must stop now," she said. (AP)

Arunachal Assembly introduces four **Bills for better** governance

ITANAGAR, March 6: The Arunachal Pradesh Assembly on Thursday introduced four Bills aimed at improving governance and administrative efficiency in the state.

Deputy chief minister Chowna Mein, who also holds the tax and excise portfolio, introduced the Arunachal Pradesh Goods and Services Tax (Amendment) Bill, 2025 to amend the state's Goods and Services Tax Act of 2017

Mein, who also serves as the planning and investment minister, introduced the Arunachal Pradesh Arun Parivar Authority Bill, 2025.

The Bill seeks to establish a legal framework for good governance and ensure efficient, transparent and targeted delivery of public welfare benefits and services to residents.

Land management minister Balo Raja introduced the Arunachal Pradesh Public Premises (Eviction of Unauthorized Occupants) Bill, which seeks to amend the existing Arunachal Pradesh Public Premises (Eviction of Unauthorized Occupants) Act, 2003.

Additionally, water resources minister Biyuram Wahge introduced the Arunachal Pradesh Flood Plain Zoning Bill, 2025, which aims to regulate floodplain zoning of rivers in the state and address related concerns. During the day, the Assembly paid tribute to former minister Medi Ram Dodum, who died on September 1 last year after a prolonged illness.

Leading the obituary reference on the inaugural day of the Budget session, Speaker Tesam Pongte expressed sorrow over Dodum's nouncement allowing the free movement of all people on all roads in Manipur from March 8. In line with this, we are proceeding with our peace march to convey a message of harmony, not to provoke anyone.

Acknowledging opposition from three Kuki organisations, Manihar urged them to support the march instead

"Three Kuki organisations have objected to our proposed march. We appeal to them to join us in this effort for peace. The march is also a way to see if the Centre stands by its commitment to allowing free movement," he said.

# RSS leader touches raw nerve with Marathi comments Haryana: Budget session from

'If you love and respect your own language, you do the same to other languages'

MUMBAI, March 6: Senior Rashtriya Swayamsevak Sangh (RSS) leader Suresh Bhaiyyaji Joshi's remarks that a "person coming to Mumbai may not necessarily learn Marathi" sparked a huge controversy in Maharashtra and invited strong condemnation from the Opposition on Thursday.

Even as Joshi sought to put a lid on the raging row by saying his remarks, made at an event in Mumbai's Ghatkopar on Wednesday, were misconstrued, and that Marathi is the language of Mumbai and Maharashtra, the opposition Shiv Sena (UBT) demanded that he be booked for treason.

Chief Minister Devendra Fadnavis quickly stepped in to douse the fire and declared in the assembly that Marathi is the language of Mumbai and Maharashtra, and anyone who lives in the state should learn and speak it.

The RSS functionary's controversial remarks came at a time when the BJP-led Centre and the DMK-headed government in Tamil Nadu are locked in a bitter war of words over the three-language formula under the National Education Policy (NEP).


Fadnavis's statement came after Shiv Sena (UBT) MLA Bhaskar Jadhav said the BJP-led Mahayuti government should clarify its stand on Joshi's comments.

The CM said, "I haven't heard what Bhaiyyaji said, but the language of Mumbai and Maharashtra is Marathi. Everyone should learn Marathi and should speak the language." Fadnavis affirmed his government respects other languages as well. "If you love and respect your own language, you do the same to other languages. I am sure Bhaiyyaji will agree with me," Fadnavis said.

Leaders of the opposition Maha Vikas Aghadi (MVA) staged a protest in Mumbai against Joshi's remarks, and shouted slogans asserting Marathi is the language of the metropolis.

Shiv Sena (UBT) chief Uddhav Thackeray, a bitter critic of the BJP, demanded that the RSS leader be booked for treason over his remarks on Marathi.

Speaking in the legislative council, Revenue Minister Chandrashekhar Bawankule of the BJP said the Maharashtra government's policy on Marathi is clear -



- those living in the state should know and learn the language. The government policy is clear that whoever lives in Maharashtra should know Marathi and learn it. There is no compromise on the Marathi language, Bawankule said. A day after his remarks triggered a controversy, Joshi said Marathi is my native language and I take pride in it. Marathi is Maharashtra language and Mumbai's language. There are no two opinions about it. People speaking many languages live in harmony in

Mumbai." It is expected that those coming from outside and speaking other languages should also understand Marathi, Joshi said.

"Mumbai doesn't have a single language. Each part of Mumbai has a different language. Ghatkopar area's language is Gujarati. So if you are residing in Mumbai, it is not necessary that you have to learn Marathi," Joshi had said at the event on Wednesday. In a clarification on Thursday, the RSS leader said his remarks were misconstrued.

# today likely to be stormy

CHANDIGARH, March 6: The three-week long budget session of Haryana assembly will begin here on Friday and the budget will be presented on March 17.

The session is likely to be stormy as the opposition Congress said it will raise a host of issues, including unemployment, paper leak, rising debt, law and order and farmers' plight.

In the meeting of the Business Advisory Committee of the Assembly, which was presided over by Speaker Harvinder Kalvan and in which Chief Minister Nayab Singh Saini and some opposition leaders also remained present, recommended the duration of the House sittings.

Speaking to reporters here on Thursday evening after a meeting of the BAC and an all-party meeting which was convened by the Speaker ahead of the session, Saini said the session will begin with the Governor's Address. Saini said the budget session will begin on March 7 and continue till March 28. The budget estimates for 2025-26 will be presented on March 17 by Saini, who also holds the Finance portfolio.

Earlier, according to the tentative schedule of the budget session, it was to be held from March 7 to 25 with budget presentation on March 13. Replying to a question, Saini said some important bills will also be brought during the budget session

In the all-party meeting, all the parties were unanimous about the state government's move to have a new building of Haryana Vidhan Sabha built here.

According to a statement, at present, there is space available for only 90 MLAs to sit in the present House of Harvana Legislative Assembly. In such a situation, it is not possible to conduct the proceedings of the House in view of the increase in the number of assembly constituencies in the state due to the delimitation to be held in the near future, it was felt.

Speaking to reporters here after the BAC meeting, Congress leader and former Haryana chief minister Bhupinder Singh Hooda said his party will raise various issues during the session including "paper leak, unemployment, law and order corruption, illegal mining, rising debt, farmers issue". On Thursday evening, Haryana Congress chief Udai Bhan held a meeting of party MLAs ahead of the assembly session beginning Friday. Speaking to reporters later, empowerment. (PTI)

'Without fail': SC fast-tracks decisions

Udai Bhan said the Saini government has failed on various fronts.

Bhan claimed that the government made tall promises at the time of October assembly elections including giving Rs 2,100 to women under 'Lado Lakshmi Yojana' and procure paddy at Rs 3,100 per quintal, but nothing has been done yet. Indian National Lok Dal has said the party will prominently raise various issues related to public interest during the budget session.

Meanwhile, with the Assembly session beginning Friday, the Congress party is yet to name the Congress Legislative Party (CLP) leader.

After BJP rode to power for a third consecutive term in Haryana in last year's Assembly polls, the Congress MLAs have attended three sittings of the Assembly without a Leader of Opposition.

Ruling BJP also took potshots at this, with Minister Anil Vij saying, "there is internal conflict in the Congress. Many Congress MLAs want Bhupinder Hooda to be Leader of Opposition, but Congress high command does not want him. This is the reason the matter is stuck"

Meanwhile, during the budget session, the government is going to bring a fresh version of the bill on the regulation of travel agents.

CM Saini had recently said the travel agents involved in sending the state youth abroad through illegal routes are being identified and strict action will be taken against them.

Saini had also said the government has made full planning to implement the 'Lado Lakshmi Yojana'

Ahead of the October 2024 Haryana polls, the BJP had promised Rs 2,100 to women as monthly financial assistance for the women under this scheme if the party returned to power.

The Budget Session is coming up and we will be making the proision of its budget, Saini had said.

Meanwhile, ahead of the presentation of the budget, Saini, in recent weeks, held pre-budget consultations with diverse groups to gather valuable suggestions. He also sought suggestions from ruling and opposition MLAs.

Saini had on Tuesday said that the state budget for 2025-26 will be growth-oriented, with a special focus on sectors such as agriculture, education, health, sports, infrastructure, and

NDMC issues 30-day notice to property tax defaulters

NEW DELHI, March 6: The New Delhi Municipal Council (NDMC) has issued showcause notices to 380 property tax defaulters, warning of strict action, including attachment and account freezing, if their dues remain unpaid. With the financial year 2024-25 nearing close, the NDMC has intensified its tax recovery efforts, identifying 3,200 taxpayers who have defaulted for three consecutive years, the civic body said in a statement.

The defaulters have been warned of coercive measures if payments are not made within the stipulated time

'Under NDMC regulations, a 30-day show-cause notice is issued to 380 defaulters, followed by additional reminders. If there is no response or payment, the Council may take action, including property attachment, sealing, or account freezing," said the statement issued on Thursday.

The NDMC, which oversees approximately 15,600 properties, aims to collect Rs 1,150 crore in property tax this year. As of mid-February, Rs 807 crore had been collected. The NDMC also announced that the tax collection centre at its headquarters in Palika Kendra and three counters in Gole Market, RK Puram and Sansad Marg will remain open on

properties in Connaught Place and sealed some shops and restaurants over the last three days for the non-payment of property taxes.

Meanwhile, the New Delhi Traders Association (NDTA) expressed concerns over what it calls were excessive tax demands and business closures. It has urged the civic body to streamline tax collection and ensure ease of doing business.

One NDTA member pointed out alleged disparities in tax structures. "Businesses in MCD areas pay almost 20 times less tax than those under NDMC's jurisdiction. We demand 'one city, one tax' for a level playing field," he said. With both the New Delhi MP Bansuri Swaraj and local MLA Parvesh Sahib Singh from the BJP, traders are hopeful their concerns will be addressed.

"Now, we have BJP representatives at all levels. A 'single engine' government is in the NDMC, and we expect our issues to be resolved soon," an NDTA office-bearer said. The traders body has approached both the MP and the MLA and they have assured that a new law is under process to remove ambiguities in the tax system, the NDTA officebearer added. "The prime minister has consistently emphasised accuses BJP of manipulating electoral rolls KOLKATA, March 6: A delegation of the ruling Trinamool Congress met the chief electoral officer (CEO) of West Bengal on Thursday, demanding that 'unique ID' be introduced on voter cards to prevent

the induction of fake voters in the electoral rolls. Earlier in the day, TMC leaders held a meeting with district functionaries to review findings of a door-todoor scrutiny of electoral rolls, alleging that the BJP has been manipulating the voters' list ahead of next year's assembly elections, with the meeting focusing on addressing detected irregularities and finalising the party's strategy to counter the issue.

The TMC delegation that called on the CEO was led by the party's state president Subrata Bakshi and included state ministers Firhad Hakim, Arup Biswas, Chandrima Bhattacharya, and Rajya Sabha MP Ritabrata Baneriee.

After submitting the memorandum, Firhad Hakim said, "The BJP is trying to turn the elections in West Bengal into a farce. It is unacceptable for the same EPIC (Electors Photo Identity Card) number to exist across different states. Just as Aadhaar and passports have unique identification numbers, voter cards too must have a unique ID."

Hakim added that this marks the beginning of a new movement under Mamata Banerjee's leadership for voter card reform, similar to her 1993 demand for photo identification in elections.

He accused the BJP of manipulating voter lists to gain power in Delhi and Maharashtra by adding fake

and 2025, Hakim claimed that the number of voters increased abnormally in a short span, similar to the voter surge in West Bengal from the 2024 Lok Sabha elections to date.

"The growth in voters in Delhi over five years was almost identical to the rise in West Bengal in just seven months. This is unnatural," he remarked.

Hakim also emphasised the need for physical verification of voter names added online and urged the Election Commission to ensure that electors from other states do not cast their votes in West Bengal.

Last week, West Bengal Chief Minister and TMC supremo Mamata Banerjee accused the BJP of inserting "outsider" voters into the electoral rolls with alleged backing from the Election Commission. She claimed that the BJP had used similar tactics in Haryana, Maharashtra, and Delhi in previous elections

Following that, TMC state president Subrata Bakshi issued directives to district-level leaders to conduct a thorough verification of voter lists.

The verification process was completed within 10 days, and district presidents and chairpersons reported their findings during Thursday's meeting.

A special committee, formed by Mamata Banerjee to oversee the matter, includes senior leaders such as Abhishek Banerjee, Derek O'Brien, Sudip Bandyopadhyay, and others. At a rally in Durgapur on Wednesday, TMC MP

### Importance of criminal law shouldn't be undermined: CJI

NEW DELHI, March 6: Chief Justice of India Sanjiv Khanna on Thursday said the importance of criminal laws in society should not be undermined and hoped young lawyers would join criminal litigation as a first choice.

CJI Khanna was speaking at the launch of "Ratanlal & Dhirajlal's Law of Crimes: A comprehensive commentary on Bhartiya Nyaya Sanhita 2023" edited by former Chief Justice of India U U Lalit.

The event was organised in the Delhi High Court's auditorium in the presence of the former CJI, Minister of State (independent charge) Law and Justice Arjun Ram Meghwal, attorney general R Venkataramani and other judges of the Supreme Court and the high court.

CJI Khanna said when it comes to dealing with arrests and detentions, criminal law directly impacts individual liberty, social harmony and the fundamental balance between state power and personal liberty.

"When I look at law students, new entrants, many of them do not want to take up criminal practice. The fact of the matter is, most of the litigation in district courts is criminal litigation. We should not therefore ignore the importance of criminal law and I hope and trust that many youngsters including lawyers will gradually join criminal law as the first choice and rather than a second or compulsion," he said.

CJI Khanna said the legal system has embraced an evidence based approach in criminal law and criminal jurisprudence in future would not rely upon untested assertions about behaviour and social dynamics. "It will increasingly rely upon data. Data exists, data speaks. Analytical tools exist. What we need to do it let evidence drive the criminal law forward," he shared.

Meanwhile, Vaibhav Singh, Station House Officer of Naini police station in Prayagraj, confirmed to PTI that Pintu Mahara does have a criminal record.

"Pintu Mahara has a history sheet at the Naini police station and was released from jail two years ago in connection with a case," the SHO said.

Police sources said Mahara's family has been involved in illegal activities, including ransom, extortion, and illegal liquor production for years. Many members of the family have a criminal history, they said.

The UP government on Wednesday claimed that Mahara earned Rs 30 crore over the 45 days of the Maha Kumbh.

"Pintu's life took a dramatic turn with one bold decision. Anticipating a massive influx of devotees, he expanded his fleet from 60 to 130 boats ahead of the Maha Kumbh," the government had said in a statement.

The statement followed Chief Minister Yogi Adityanath's remarks in the state assembly, where he responded to opposition criticism of the Maha Kumbh. (PTI)

NEW DELHI, March 6: The Supreme Court on Thursday asked all high courts to direct civil courts in their jurisdiction to decide the execution petitions within six months, failing which presiding officers would be held liable. A bench of Justices J B Pardiwala and Pankaj Mithal further ordered the high courts to summon the data from the district judiciary over the pendency of such execution petitions.

The execution petitions, the bench said, filed for execution of decrees in civil disputes were pending for three-four years. "If the execution petitions remain pending for three-four years, it defeats the very purpose of decree," Justice Pardiwala said. The verdict came in a 1980 civil dispute from Tamil Nadu.

"We direct all the high courts across the country to call for the necessary information from their respective district judiciary as regards pendency of the execution petitions," the bench said.

The court directed that after collecting the data, the high courts should issue an administrative order or a circular to the respective district judiciary asking the execution petitions to be decided and disposed of within six months without fail. "Otherwise the presiding officer concerned would be answerable to the high court on its administrative side," it added.

The verdict said once the relevant data was collected by the high courts, it should be forwarded to the registry of the top court with individual reports.

The registry was directed to convey the order to all high courts and the matter was posted after seven months for compliance. The top court noted in its verdict in 2021 and subsequently in 2022 it directed the execution proceedings to be completed within six months from the date of filing but the directions were yet to be followed. It pointed out a "long and inordinate" delay on the part of the executing courts in the country in deciding such petitions.

The civil dispute before the bench concerned a sale agreement of June 30, 1980 entered by Tamil Nadu

resident Ayyavoo Udayar over a piece of land. After the dispute arose over title of the land, Udayar filed a civil suit for specific performance against the defendants in 1986 with respect to an agreement to sell.

In 2004, the decree-holder filed a petition to direct the defendants to execute the sale deed and deliver the possession of the property. It was, however, dismissed.

This was challenged by way of a revision petition, which was allowed in 2006 but the sale deed was again not executed. In 2008, an order of delivery of possession was passed but not executed.

The top court held that the high court "committed an egregious error" in passing the order.

"We must now ensure that the appellants are able to reap the fruits of the decree. We are also of the view that the rejection by the high court of the amendments to the execution petition filed by the appellants, was erroneous and deserves to be set aside.

The executing court should now proceed to ensure that vacant and peaceful possession of the suit property was handed over to the appellants in their capacity as decree holders and if necessary, with the aid of police, within two months "without fail". (PTI)

### Registration for Ayushman Bharat to start after March 8: Delhi health minister

NEW DELHI, March 6: Delhi Health Minister Pankaj Singh announced on Thursday that the registration process for the Ayushman Bharat scheme will begin after March 8, marking a significant step toward expanding healthcare access in the national capital

Speaking at a press conference, Singh said that the Delhi government would soon sign a Memorandum of Understanding (MoU) with the Centre to implement the scheme. He also assured that fundamental changes in the city's healthcare system would be visible within 100 days.

The minister emphasised the strict monitoring of hospital bed allotments and EWS quotas, with two nodal officers appointed to ensure transparency. He assured that no government hospital in Delhi would face a shortage of medicines.

Focusing on economically weaker sections (EWS), he said that all hospitals must provide treatment in accordance with government-mandated standards. He also instructed the health department to discourage excessive local purchasing of medicines and to promote affordable healthcare schemes like the Pradhan Mantri Jan Arogya Yojana (PMJAY). Officials were asked to submit a report on medicines procured from local companies in previous years.

Additionally, Singh directed that each government hospital have a dedicated medical director or superintendent, ensuring that no official holds additional responsibilities for multiple hospitals. Emphasising safety, he ordered a comprehensive audit of all government hospitals and ongoing healthcare projects in Delhi.



Criticising the previous AAP-led government, Singh claimed that nearly 2,500 Mohalla Clinics existed only on paper, with rent expenses being misused. "An order has been passed to shut down such clinics to curb corruption," he said.

Singh also highlighted that around 20 per cent of childbirths in Delhi occur outside hospitals, a statistic the government aims to improve by promoting institutional deliveries.

The minister further said that mobile dental vans would soon be deployed to the outskirts of the city to provide medical services to underserved populations. In the initial phase, 10 mobile units will be deployed, with plans to expand the initiative across the city.

Meanwhile, Singh directed the Directorate General of Health Services (DGHS) to ensure that nursing homes and private health centres meet all safety and operational standards before obtaining registration

"Anyone found guilty of wrongdoing will not be spared," the minister warned, adding, "We will make government hospitals better than private

Additionally, to improve transparency and efficiency, he announced that future meetings with hospital directors would be conducted via video conferencing, with necessary technical support from the IT department.

The meeting was attended by medical directors and superintendents of all government hospitals, along with senior officials from the Public Works Department (PWD), Food Safety, and the Health and Family Welfare departments. (PTI)

# Felt like a massive responsibility: Actor Taaruk Raina on playing lead role in 'The Waking of a Nation'

## Our industry has potential to make all kinds of films, not just tentpoles: Reema Kagti



NEW DELHI, March 6: "Superboys of Malegaon" director Reema Kagti believes both the industry and the audiences have the potential to celebrate different kind of movies, not just tentpole cinema with big stars.

Kagti's film, which documents the real-life story of Malegaon-based filmmaker Nasir Shaikh, released in theatres last week.

The filmmaker, known for her critically-acclaimed movies such as "Honeymoon Travel Pvt Ltd", "Talaash" and streaming show "Dahaad", hopes that people go out in theatres to watch the so-called "underrated" films and not wait for them to release on OTT.

"There is an anxiety to films that don't have big actors or stars or bankable people but what I see on social media all the time is people saying, 'Why don't we give new actors and writers a chance?'

"And frankly, a lot of people have put good work out there, which doesn't get seen in theatres. And then it comes out on OTT and everybody starts calling it an underrated gem. But actually you have underrated it as an audience because you can't be calling the next person out for not going in when you yourself haven't seen it," Kagti told PTI in an interview.

The director, who also runs production house Tiger Baby with filmmaker-friend Zoya Akhtar, admitted that the industry did not do well last year but believes that it is just part of the cycle.

"There is a lot of talent, dreams and producers. So I don't think one bad year in that sense should

be looked at as the end... I believe that our industry has the potential to make a range of films because that's the mark of a thriving industry. And our audience also has the potential for different kinds of films, not just big tentpoles," she said.

"Superboys of Malegaon", written by lyricist-writer Varun Grover, dramatises Shaikh's career, which began with him making spoofs of films like "Sholay" and "Superman" for the audience in his home town. Kagti, who was also born in a small town in Assam, could see many parallels between her and Shaikh's journey as movie buffs who loved Salim-Javed (Salim Khan-Javed Akhtar)'s cinema, Bruce Lee, Charlie Chaplin and Buster Keaton.

"We both are film buffs... In Nasir's story and experiences, there's deep love for films and the magic of cinema. The other similarity between Nasir and me that I think is that we were both products of piracy," she added

While Kagti travelled all the way to Mumbai to pursue her movie dreams, Shaikh gave birth to a thriving 'do-it-yourself' kind of filmmaking that's still popular in Malegaon. Kagti wanted to capture the many

inspiring elements of Shaikh's journey in "Superboys of Malegaon".

'We came from a very admiring point of view. We were not there to judge his filmmaking. We were there to kind of celebrate how in a real small town in India, this film buff just got up and made films just for the love of making a film and inadvertently gave rise to an entire video film industry

"Nasir initially made his films only to release in his parlour, but because it became so popular, they sort of started following what happens in Bombay when a film does really well -- other theatres start asking for it. That gave Nasir confidence to make more films and a whole lot of other people in Malegaon are still making films. But now it's moved to YouTube.

There is already a critically-acclaimed documentary "Supermen of Malegaon" by Faiza Ahmed Khan on Shaikh's life. Kagti, Zoya and Farhan Akhtar, who has also backed the film with Excel Entertainment, said they are fans of the documentary and have paid a tribute to it in their movie but their attempt was to go beyond and create a feature film. "We wanted to get into the making of Nasir as a director, his friends, the community that made films for themselves. And to kind of explore themes like 'why is art important? Who decides what is art?' The importance of people being represented and things like that.

"Which is why Varun said he would like to go to Malegaon and start on a fresh page. Though we had all seen the documentary, he went and started from scratch again in terms of all the research and met people in Nasir's life. And luckily for us, Nasir is a huge archivist of his own life. So there was a lot of material that Varun had.

The film also gave Kagti a chance to explore themes like friendship, dreams and how the concerns that Nasir and his group were dealing with reflected the larger world. "We realised that the way Nasir made his films, it was a smaller version of what goes on in a bigger filmmaking hub like maybe Mumbai or any other place. The film also has layers of friendship, an underdog story which can inspire anybody to have a dream. It has a universal message and speaks to a wider audience than just filmmakers." (PTI)

### Have consistent selection policy, grievance redressal system for athletes: Ministry tells NSFs

NEW DELHI, March 6: In a bid to ensure accountability and consistency, the sports ministry has made it mandatory for national federations to standardise their selection policies, notify athletes of trials at least 15 days in advance and institute a grievance redressal system to bring down litigation caused by feelings of injustice. The instructions on selection matters come after sports minister Mansukh Mandaviya made it clear to the national federations that he wants them to avoid legal showdowns with athletes as has been seen in wrestling, shooting and some winter sports events in recent

times.

possession, has been sent to the Îndian Olympic Association, the Sports Authority of India (SAI) and the National Sports Federations (NSFs).

The new directives make it mandatory for NSFs to upload selection policies on their respective websites and amend them only if there is a three-month window before a competition. It has also been made compulsory to videograph selection trials.

Video recordings of the selection trials shall be forwarded to SAI along with the duly signed minutes of selection committee, while sending proposals for financial assistance," it stated in the

The circular, which is in PTI's five-page document which also ing the Ministry and "giving the cide within seven days of a commakes it mandatory for NSFs to inform the ministry before every trial. The ministry has asked NSFs to publicise the selection criteria for showpieces such as the Olympics, Paralympics, Asian

Games, Para Asian Games and Commonwealth Games at least two years in advance. This has been a long-standing demand in a sport like shooting where renowned pistol coach Jaspal Rana saying that policies

which are not standardised negatively impact athletes. Inclusion of athletes, coaches, support staff and officials in the long list of these mega-events cannot be done without intimatrationale and basis for names proposed"

"Details of long list will be submitted to Ministry/SAI at least 30 days before the last date for making entries in the long list."

For other international events where it being a part of the national camp would be a pre-requisite for athletes, the ministry has directed that the NSFs notify them of the requirements at least three months before the commencement of training

In case an athlete still feels hard-done by the system, the NSFs have been directed to create a Grievance Redressal Committee or Appeal Committee to de-

plaint. "...(the committee) shall invariably include Sportspersons of Outstanding Merit who must have retired from active sports for

at least four years," it has directed. "No member of Selection Committee shall be part of the

Grievance redressal Committee. Such proceedings will be summary in nature follow-

ing principles of natural justice. If the NSF has formed a Dispute Resolution Commission (DRC), then second appeal shall be made before the DRC.'

The power to constitute the selection panel was earlier vested with the federation but the latest directive hands it over solely to

the NSF president.

"Composition of the selection committee shall be decided by the President of the NSF," it states. While steering clear of making

it mandatory that could lead to accusations of government interference, the ministry has given a long list of what should be an

ideal selection committee. According to the directive, the panel should "ideally" be headed High Performance Director/Chief Coach/Foreign Coach/former international player (preferably Major Dhyan Chand Khel Ratna Awardee/Arjuna

Awardee). "Selection Committee may include, among others, coach(es), SOM, ex-international

player(s), member(s) of Executive Committee (not more than two on rotation basis) nominated by the President of NSF." The earlier guidelines made observers from the ministry and SAI a party to the selection process by requiring them to sign the minutes. The new directives state that such officials would report their findings to SAI and ministry and not be a part of the proceedings.

"If the Ministry/SĂI is not satisfied with the selection of athletes recommended by the NSF on the grounds of fairness and transparency, the Ministry reserves the right to approve the participation at no cost to the Government," it adds. (PTI)

#### Australian tennis great Fred Cricket in the UAE: How Emirates' dream Stolle has died at age 86 stalled even as Afghanistan soar MELBOURNE, March 6: I felt comfortable," Stolle told

Fred Stolle, a winner of two Grand Slam singles titles and 17 major doubles trophies, has died, Tennis Australia said Thursday. He was 86.

Stolle was an "iconic figure" in tennis as a player and later as a commentator for Australia's Nine Network and U.S. broadcasters. Tennis Australia CEO Craig Tiley said. Tiley did not provide a cause of death.

The 1.91-meter (6-foot-3) Stolle was part of Australia's successful era in the 1960s as tennis progressed from an amateur to professional sport.

Nicknamed "Fiery Fred" or "Fiery" for short, he lost the first five Grand Slam singles finals he reached — four of them to fellow Australian Roy Emerson. He also fell in consecutive Wimbledon finals in 1963, 1964 and 1965. He broke through on his least favorite surface, on clay at the 1965 French Championships, beating Tony Roche in the final.

the Tennis Channel. "The French was not the one I was supposed to win, but it was exciting for me." Stolle beat three seeds to reach the final. Afterward, he held the No. 1 ranking and turned pro. He won 10 men's doubles titles at Grand Slams from 1962-69, four each with Bob Hewitt and Emerson and two with Ken Rosewall. He's one of the few to win all four doubles majors.

Stolle also won seven mixed doubles majors, his partners including Margaret Court, Lesley Turner Bowrey and Ann Haydon Jones.

He won the Davis Cup in 1964, 1965 and 1966. His most notable win was in 1964 in Cleveland where, with Australia 2-1 down, he beat American Dennis Ralston 7-5, 6-3,

Khurram said the lack of sufficient tournaments also affected the temperament of upcoming players.

"The boys lack this temperament, technique because they don't play many longer-version



from the first moment. There needs to be some planning and a vision which I think currently

is missing," he added. Gopal Jasapara, a veteran coach who runs the G-Force Cricket Academy here, agreed with Khurram.

'We are more into quantity than quality and it can give the false picture of growth sometimes. Quality is there, but the youngsters are viewing sports as a way to get a job. Basically, the mindset has changed.

"There are some 60 or 70 cricket grounds in the UAE, you know, privately owned. They just want to keep their ground busy. They organise a lot of tournaments in the evenings for young boys, and they take into the game without so much skills," said Jasapara.

## India have real clarity on how they want to operate in Dubai: Williamson

### 300 women boxers to compete in national championship

NEW DELHI, March 6: As many as 300 pugilists will compete for glory at the 8th Elite Women's National Boxing Championship in Greater Noida from March 21-27.

Organised in association with the UP Boxing Association, the tournament returns to the venue that hosted its last edition in 2023.

Held under the World Boxing and Boxing Federation of India (BFI) competition guidelines, the championship is open to boxers born between January 1, 1984, and December 31, 2005.



Each state unit can field a maximum of 10 boxers, with entries by numbers closing on March 10 and final name confirmation due by March 15. The action offiially begins on March 20 with the arrivals, draw, and tech-

nical meeting. The opening rounds will take place from March 21 to 24, followed by the quarter-finals on March 25 and the semi-finals on March 26, leading up to the finals on March 27.

The tournament will follow a three-round format, with each bout consisting of three-minute rounds with a one-minute rest period. The tenpoint must-scoring system will be in place, and all matches will adhere to World Boxing Technical & Competition Rules.

Boxers will also be required to undergo a daily weigh-in throughout the competition.

Beyond the 300 competing boxers, the championship will also bring together over 100 coaches and support staff, along with 60 technical officials, ensuring a top-tier spectacle.

Defending champions Railway Sports Promotion Board (RSPB) will be looking to retain their title after a dominant performance in the previous edition, where they clinched five gold medals, one silver, and two bronzes

RSPB nudged Haryana by eight points, the latter finishing second with seven medals, including three golds, three silvers, and a bronze. (PTI)
