India looks at ways to navigate Trump's reciprocal tariff KA has 15 illegal rat-hole mines: Minister Govt seized over 25,630 tonnes of illegal coal in last 3 years,

NEW DELHI, March 5: With US President Donald Trump's threat of reciprocal tariff stoking fears of a global trade war, India is looking at finding an amicable solution to the challenge under the broader framework of a trade deal with Washington.

In his latest salvo, the US president, while addressing a joint session of the Congress on Tuesday, mentioned India alongside the European Union, China and Canada for charging higher tariffs on American products.

In line with his "America First" policy, Trump announced during the speech reciprocal tariffs from April 2 on numerous trading partners and nations that impose higher levies on imports from the United States.

He said other countries have used tariffs against the US for decades and now, it is "our turn" to start using

"On average, the European Union, China, Brazil, India, Mexico and Canada -- have you heard of them? And countless other nations charge us tremendously higher tariffs than we charge them," Trump said.

He added: "It is very unfair. India charges us auto tariffs higher than 100 per cent. China's average tariff on our products is twice what we charge them. And South Korea's average tariff is four times higher." India is confident of finding a solution, people familiar with the

matter said while referring to the commitment expressed by Prime Minister Narendra Modi and Trump during their February 13 talks in Washington DC.

At the meeting, the two sides agreed to negotiate a mega trade deal by the end of this year and set an ambitious target of USD 500 billion in annual trade by 2030 to narrow the trade deficit. "Recognising that this level of ambition would require new, fair-trade terms, the leaders announced plans to negotiate the first tranche of a mutually beneficial, multi-sector Bilateral Trade Agreement (BTA) by fall of 2025," a joint statement on the Modi-Trump talks said.

To advance this innovative, wide-ranging BTA, the US and India will take an integrated approach to strengthen and deepen the bilateral trade across the goods and services sector, and work towards increasing market access, reducing tariff and non-tariff barriers, and deepening supply-chain integration, it said.

Both sides made firm commitment to boost the overall trade and India hopes that a mutually-beneficial outcome will emerge on the issue of tariffs, the people cited above said as New Delhi looks at navigating the trade landscape with the Trump administration. House told • Over 263 illegal rat hole coal mines detected in state

GUWAHATI, March 5: The Assam government on Wednesday said that at least 263 illegal rat-hole coal mines have been detected in the central part of the state under the jurisdiction of two autonomous

The government also informed the assembly that it has seized over 25,630 tonnes of illegal coal in the last three years.

In a written reply to a query from Independent MLA Akhil Gogoi, Mines and Minerals minister Kaushik Rai said that 248 rathole mines have been found in North Cachar Hills Autonomous Council (NCHAC), comprising Dima Hasao district.

In Karbi Anglong Autonomous Council, comprising East Karbi Anglong and West Karbi Anglong districts, 15 such rat-hole mines tracted through this dangerous not share details of rat-hole mining

in those areas. At least nine labourers were trapped inside the illegal 3-Kilo Coal Quarry in Umrangso area on January 6 after a sudden gush of water flooded the site. Partially decomposed bodies of all miners were retrieved after several days from the rat-hole mine.

Rai, in a reply to a separate query from AIUDF MLA Ashraful Hussain, said that the government has seized 25,631.98 tonnes of illegally mined and transported coal from different parts of the state in the last three years.

"The process of auctioning the coal through a legal system is underway... We have taken steps to prevent illegal coal mining in the state. A monitoring committee was also formed under the leadership of the DGP to check such illegal activities," he added. (PTI)

Assembly turns spotlight on 'D' voters, Oppn seeks closure of detention centre

GUWAHATI, March 5: Highlighting the plight of the 'D' (Doubtful) voters, the opposition on Wednesday demanded closure of Assam's sole detention centre, now called a transit camp, and tabling of the NRC report in the Assembly

During a discussion on the contentious issue, AIUDF MLA Aminul Islam claimed that lakhs of people were declared 'D' voters without officials visiting their homes and proper verification.

"There are thousands of cases when only one person in a family is declared 'D' voter but his sibcitizens. This has ruined so many families and shattered the dreams of thousands of youths," he added.

Islam demanded formation of an all-party team by the Speaker to study the conditions of the 'D' voters and living in the detention centre. "Even the Foreigners Tribunals have declared verdicts despite respondents submitting enough proof. These courts are very biased and justice is not done there," Islam said.

CPI(M) member Manoranjan Talukdar said the BJP had promised to close down the detention centre before coming to power, but it has not (CONTD. ON PAGE-2)

He was speaking at the Joint Regional Official Language Conference and Award Distribution Ceremony for the East and Northeast regions, organised by the Department of Official Language, Ministry of Home Affairs, at Sonapur, on the outskirts of

The Union Minister of State for Home Affairs highlighted the significance of the conference as a platform for encouraging the use of Hindi across government departments, offices and banks, an official statement said.

He said that government schemes and initiatives must be effectively communicated to all citizens, ensuring equal access and benefits, and underscored the importance of fostering a strong connection between the government and the public through the use of familiar languages, reinforcing Hindi's as both an official language and a "unifying force in India's diverse linguistic landscape". The minister maintained that language is

not just a means of communication but the reflection of a nation's cultural identity. He elaborated on various initiatives taken

by the government to promote Hindi and other Indian languages, including the launch of the 'Kanthasth' translation tool in 2018 and the emphasis on mother tongues in the National Education Policy of 2020. Rai also stressed the need to integrate

"A trial will be taking place. Not

Bangladesh has issued two arrest warrants for her.

Yunus said they had sent "formal letters" but received "no official response" from New Delhi.

Last year, India confirmed receiving the 'note verbale' or diplomatic communication from the Bangladesh High Commission in New Delhi but refrained from com-

loan of ₹ 4.7 lakh crore. In 2024, 38 per cent of the total loans taken by women are from gold loans, he

In February 2025, RBI data showed that gold loans increased by a whopping 71.3 per cent in a year, the Congress chief said.

"Narendra Modi ji, you had talked about 'stealing of mangalsutras'. That has now come true. In your rule, women have been forced to mortgage their gold ornaments. First you made women's 'stri-dhan' disappear by implementing demonetization, now due to inflation and falling household savings, they are forced to mortgage their most valuable thing -- their jewelery," Kharge

During the Lok Sabha polls campaign last year, Modi had alleged that the Congress will take away 'mangalsutras' and redistribute the wealth of the people.

Kharge alleged that the Modi government has worsened the condition of the economy so much that middle class families who buy two-wheelers are now unable to repay their loans.

In view of rising loan defaults, twowheeler financiers are cutting down on lending for the first time since 2019, he

He said 75 per cent of people buy twowheelers on loan so that they can repay it slowly, but the financial crunch is so severe that as compared to last year, loans worth about ₹2 lakh crore are still outstanding till September 2024, which has increased by ₹

40,000 crore in a year. Two-wheeler sales have declined by 6 per cent in February 2025, Kharge added. "Recession, financial crunch and reduction in spending capacity - this is the essence of the economy you run," Kharge said, hitting out at the prime minister. (PTI)

NEW DELHI, March 5: India's services sector activity witnessed a sharp uptick in February boosted by improving domestic and international demand, which resulted in a quicker expansion in output and a substantial increase in employment, a monthly survey said on Wednesday. The seasonally adjusted HSBC India Services PMI Business Activity Index rose from January's 26-month low of 56.5 to 59.0 in February, indicating a sharp rate of expansion. In the Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion, while a score below 50

denotes contraction. "India's services business activity index rose to 59.0 in February 2025, up considerably from January's 26-month low of 56.5. Global demand, which grew at its fastest pace in six months according to the new export business index, played a major role in driving output growth for India's services sector,' said Pranjul Bhandari, Chief India

Economist at HSBC. According to the survey, productivity gains, favourable underlying demand and greater intake of new business. Moreover, gains in international orders supported this uptick in growth, with service providers reporting better demand from clients in Africa, Asia, Europe, the Americas and the Middle

East, the survey said. In order to accommodate for rising new business and alleviate capacity pressures, Indian services firms continued to pursue recruitment drives. Employment expanded sharply, and at one of the fastest rates seen since data collec-

tion began in December 2005. "Job creation and charge inflation remained strong during February. Looking ahead, business sentiment remains broadly positive, but did slightly slip last month to its lowest level since August

2024," Bhandari said. Advertising, better customer relations, efficiency gains and



healthy demand conditions all underpinned upbeat projections for output in the year ahead. Around one-quarter of survey members forecast growth in the year ahead, while fewer than 2 per cent were pessimistic. Meanwhile, the HSBC Îndia Composite Output Index rose from 57.7 to 58.8, indicating

a substantial rate of expansion. Composite PMI indices are weighted averages of comparable manufacturing and services PMI indices. Weights reflect the relative size of the manufacturing and service sectors, according to official GDP data. At the composite level, payroll numbers expanded at a marked pace that was little changed from January's survey record, while cost pressures across the private sector were at their least intense since last October, the

The HSBC India Services PMI is compiled by S&P Global from responses to questionnaires sent to a panel of around 400 service sector companies.

On the domestic macroeconomic front, the Indian economy grew by 6.2 per cent in the December quarter, recovering sequentially from seven-quarter lows, but the expansion came in lower than last year. For the full 2024-25 fiscal (April 2024 to March 2025). the government now pegs GDP growth at 6.5 per cent, marginally higher than its initial estimate of 6.4 per cent but below the revised growth rate of 9.2 per cent for 2023-24. The growth in the current fiscal and less than 7 per cent expected in the next will keep India as the fastest-expanding major economy. (PTI)

Borjan to get Sainik School

it was initially proposed at Khanduli in West Karbi Anglong but faced opposition from the people, adding, "A second proposal to set it up in Langkaijan was also rejected because of its proximity to the Marat Longri Wildlife Sanctuary. Finally, Borjan was chosen as the project site."

"This is not just a ₹ 1 or 2 crore project but a ₹ 4,000 crore project. It will provide jobs to 1,000 local youths. Candidates from other constituencies will not interfere—100% of the job opportunities will be given to local candidates of Borjan. The adjoining villages will benefit from road connectivity, and all households will receive free electricity. Additionally, the KAAC will earn revenue from this project," the CEM said.

He further mentioned that the Sainik School is a ₹ 375 crore project that will also create employment opportunities. Addressing concerns that students from outside Karbi Anglong might fill the seats, he clarified, "As per the agreement, 80% of the students will be from Karbi Anglong. The Sainik School will offer various facilities that students can benefit from." The CEM also announced a proposal to establish a biogas plant in Karbi Anglong. This proposal emerged after the Advantage Assam 2.0 summit held in Guwahati recently.

He stated that Chief Minister Himanta Biswa Sarma had identified Karbi Anglong as a potential location for a biogas plant to be set up by Reliance. Speaking on the proposed biogas plant, the CEM explained that it would run on grass, which could be cultivated by villagers.

This project will generate employment for many local youths, both skilled and unskilled. Around 40,000 people from our district migrate to other states for work. Andhra Pradesh signed an MoU with Reliance for a similar project, which became a major revenue source for the state. We are not rushing into this. An interaction with all stakeholders, including student and youth organisations, intellectuals, and political leaders, will be held on March 8 in Diphu. If everything goes well and people agree, we plan to sign an agreement to lease land at ₹ 10,000 per bigha per year. If we provide 30 bighas, our revenue from the project could reach ₹ 50 crores annually," he said. Comparing the project with Andhra Pradesh, where seven lakh local youths were employed, the CEM assured that 00% of jobs in Karbi Anglong would be given to local youths.

He also highlighted the financial prospects for local farmers, stating that if grass for the biogas plant is cultivated, the income per bigha could reach ₹ 50,000 annually. For 20 hectares of land, the estimated annual income could be around ₹ 12 lakhs. "The company will provide seeds free of cost and offer technical support for grass cultivation," he added. Ronghang also criticised opposition leaders for opposing the KAAC's efforts to implement various central and state-sponsored welfare schemes.

Additionally, he assured the people of Borjan that the KAAC would implement the demands outlined in their memorandum, which included improvements in road connectivity, access to safe drinking water, better medical facilities, school infrastructure, and playgrounds.

If the NRC is wrong, please rectify it. The final NRC was released on August 31, 2019 by excluding 19,06,657 people. However, it has not been notified by the Registrar General of India yet, leaving the document without any official validity. "I request the government to table the NRC in the Assembly. If they were Bangladeshis, why don't you send them to that country?" he questioned the government. In a written reply on Monday, the CM said there are 1,18,134 'D' voters at present in Assam as informed by the Election Department.

He also said that there are 258 inmates at the transit camp as on February 24. Supporting the existence of the detention centre, BJP MLA Dipayan Chakraborty urged the government to release all the Hindu 'D' voters from the facility. AIUDF MLA Ashraful Hussain said 'D' voters are deprived of all basic facilities and identity documents like Aadhaar Card, PAN Card and Voter ID Card. "It is a political problem and cannot be solved by the legal system. A political solution has to be found for a permanent solution. This entire system was created to economically weaken a community," he added. Slamming the Foreigners Tribunals (FTs), Hussain said that if 'D' voter cases are registered against 126 MLAs of the Assam Assembly, 50 per cent of them will not clear

the FT judgement. Parliamentary Affairs Minister Chandra Mohan Patowary said that no one has been kept at the transit camp without the orders of the FTs. "We keep the detainees after they are declared foreigners. We keep them till deportation takes place. Also, the 'D' voter concept was introduced not by the government or police. It was done by the Election Commission and they issued the guidelines for terming someone as a 'D' voter," he added.

The concept of 'D' voters was introduced in Assam in 1997 by the EC. It prepared a list including those who

could not provide evidence in favour of their Indian nationality. D voters do not exist anywhere else in India. The issue of D-voters is one of the most contentious topics in Assam's political and social sphere. Several elections have been fought and won over this single issue of illegal Bangladeshi immigrants, who are initially marked as D-voters if their names are found in the electoral rolls. Deletion or regularisation of a D-voter is done as per orders of the Foreigners Tribunals and the subsequent judgements by higher courts. (PTI)

Work strike by contractual health workers in Gossaigaon dispensaries, and sub-health cen-

HT Correspondent GOSSAIGAON, March 5: In solidarity with the state-wide work strike called by NHM (National Health Mission) employees, contractual health workers of Gossaigaon Block Primary Health Centre and Gossaigaon RNB Civil Hospital in Kokrajhar continued their protest for the second consecutive day on Wednesday. The work strike, called from March 4 to March 6, witnessed participation from nearly 200 healthcare workers, including doctors, pharmacists, and employees from various levels

Under NHM Assam, around 24,000 employees, including officers and staff, have been serving in the state's healthcare sector in various positions since 2006. Among them, approximately 20,000 employees, including medical officers, dental officers, CHOs, pharmacists, GNM/staff nurses, laboratory technicians, physiotherapists, radiographers, and NLMs, have been working in medical colleges, district hospitals, model hospitals, primary health centers, state ters for nearly two decades on a fixed pay basis, despite providing essential healthcare services.

Even though NHM technical staff and officers perform duties equivalent to those of their permanent counterparts, they receive significantly lower salaries. Many of these contractual employees face job insecurity as they approach the upper age limit for employment without being regularized. While the state's public health services rely heavily on NHM workers, the Assam government has yet to take concrete steps to address their longpending burning issues. In contrast, several other states like Delhi, Haryana, Odisha, Manipur, Bihar, and Jharkhand have regularized NHM workers or provided equal pay and benefits.

On January 20, NHM workers submitted a memorandum to the chief minister through the commissioners of all districts, but no response has been received so far. Expressing their dissatisfaction, pharmacist Mofidul Islam stated

that apart from emergency medical services, they had withdrawn from all other duties during the strike.

Islam further raised demands such as the recruitment of NHM workers into permanent positions in the health department through special appointment procedures, priority for NHM workers in new medical colleges and hospitals, implementation of a pay scale system until job regularization, wage security, payment of pending salaries as per the 7th Pay Commission (2016), full execution of the 2021 Notification (No. HLA.409/2020/Pt/55), and provision of gratuity, pension, death benefits, leave policies, health insurance, and bank loan facilities. Additionally, he demanded equal pay for equal work as per the Supreme Court verdict (Verdict no. 213 of 2013).

During the protest, NHM contractual workers held placards reading slogans like "Our demands are justified, they must be fulfilled," "Don't betray COVID warriors," and "Regularize NHM contractual employees."

Fat shaming remark uncalled for

at-shaming is the new normal in Congress party political circles these days. Congress spokespersons use it with critical remarks regarding the cricketing performances of top Indian cricketing icons. Electoral roll manipulation in state elections is prima facie true

ward by Trinamool Congress (TMC) from Bengal is just another in a series of evidences of electoral roll manipulation that invariably favours BJP and its allies, as it has recently been witnessed in the recent Maharashtra and Delhi Vidhan Sabha election. Opposition political parties have not only alleged Election Commissions complicity in voter lists fraud, but also demanded to fix the responsibility. Since, evidences emerged so far suggests that electoral roll manipulation in state elections is prima facie true, it must be investigated, action to be taken, and take steps to prevent such manipulation in the future.

Chief Minister of West Bengal Mamata Banerjee has his party leaders that in every assembly constituency, there are 20-30 thousand voters who are "not residents of the state" and are likely to tilt the balance in favour of the BJP. She has cited examples of voters with the same Electors Photo Identity Card (EPIC) number in West Bengal and in other states, and said that the move to induct such "outsiders" into West Bengal's voter list was intended to influence the Assembly election of

On March 3, TMC had warned that if Election Commission does not accept its 'mistakes' within 24 hours the party would release another set of documents which will cause 'more embarrassment' to the poll body. The party had released example of multiple voters' cards having same number. TMC has demanded that EC clean up the electoral rolls in the next 100 days. The party has also demanded an investigation to find out "who in the BJP is the mastermind" behind electoral roll manipulation.

Election Commission on March 2 had admitted that some Electoral Photo Identity Cards in different states have identical numbers due to a "decentralized and manual mechanism" being followed prior

he evidence brought for- to shifting of electoral rolls database to the ERONET (Electoral Roll Management). Nevertheless, TMC has rejected the EC's explanation and has insisted on cleaning

the electoral roll from 'outsiders'. The issue was first raised by West Bengal CM Mamata Banerjee on February 27. She had alleged that BJP won Maharashtra and Delhi Elections by "enrolling fake voter" from Haryana and Gujarat. Mamata Banerjee had also accused the Bharatiya Janata Party (BJP) of enrolling "fake voters" from other states in the electoral rolls with the "help" of the Election Commission. TMC has cited proof of people from Haryana enrolled in West Bengal, and hence, Mamata's allega-

On March 3, Congress accused the EC of being complicit in largescale voter list manipulation, alleging that duplicate voter ID numbers have been used to favour ruling BJP. The allegations were made by the party's Empowered Action Group of Leaders and Experts (EAGLE), calling the issue a grave threat to India's democratic

Congress leader Rahul Gandhi has been alleging electoral list manipulation after recent Maharashtra election. He has now said on a post on X, "The cover is now blown. It is clear that the ruling BJP wins or attempts to win elections by manipulating voter lists in connivance with the Election Commission.'

On February 7, Rahul Gandhi had claimed that there were more registered voters in Maharashtra than the total adult population of the state and more voters were added in five months between the 2024 Lok Sabha and Assembly polls in November 2024, than in the increase shows a discrepancy the past five years. He had claimed this in a joint press conference where NCP (Sharad

Pawar) leader

Supriva Sule and

Shiv Sena (UBT)

leader Sanjay Raut was also present. He claimed several "irregularities" took place in the recently concluded assembly elections.

"Between the 2019 Assembly elections and the 2024 Lok Sabha election, 32 lakh voters were added to Maharashtra's electoral rolls over five years. However, between the 2024 Lok Sabha elections and the 2024 Assembly elections, 39 lakh new voters were added in just five months," Rahul

Gandhi had pointed out. Similar voter list manipulation was alleged even during the Delhi election. The electoral roll data now publicly available also suggests voter list manipulation in very large scale. After getting voters name deleted and new voters enrolled, the net increase in electors in Delhi was 895881 between January 2024 and 2025. It should be noted that total electors were decreased by 68,236 during 2020 and 2024. Young electors attaining 18 years age in 2020 were 2.08 lakhs, in 2024 were 2.5 lakh and in 2025 were 2.08 lakh. It means sudden increase in total number of voters were due to outsiders, and since its patter is not supported by other patters of increase in votes, such as first time voters.

One can even see the surprising election results. In most of the constituencies' addition of new voters mostly favoured BJP to win. There was only one constituency Hari Nagar where electors decreased by 261, and BJP won by a margin of 6632 vote. In all other constituencies net new voters increased by thousands.

It may be surprising to note that net new voter addition in Mustafabad was 21117 and BJP won by a margin of 17578; Karawal Nagar net addition was 22770 BJP's winning margin was 23355; Malviya Nagar net addition 5471, BJP's winning margin 2131; Uttam Nagar net addition 21159 BJP's winning margin 29740; Matiala net addition 30327 BJP's winning margin 28723; Bijwasan net addition 12649, BJP's winning margin 11276; Palam net addition 9880 BJP's winning margin 8952; Laxmi Nagar net addition 8166 BJP's winning margin 11542; Nangloi Jat net addition 26173 BJP's winning margin 26251; Motinagar net addition 8695 BJP's winning margin 11657; Madipur net addition 9915 BJP's winning margin 10899; Badli net addition 22900 BJP's winning margin 15163; and Bawana net addition 36727 BJP's winning margin 31475.

There are other surprising data too, which needs closer analysis. For example, increase on new net voter are higher in the constituencies where there have been larger AAP support base. The new voters addition thus has a pattern which depended on the support bases of BJP and AAP. The new voters addition were according to constituency wise requirements.

To understand it more clearly, one can take the example of the Central Delhi where AAP has very high traditional support base. Out of seven constituencies, AAP had won six - Burari, Sadar Bazar, Chandni Chowk, Matia Mahal, Ballimaran, and Karol Bagh. AAP lost only Timarpur to BJP by 1168 votes. Barring Burari, where net new additions were 43220, in all other constituencies net new addition ranged between 4432 and 7048. Burari showed abnormal addition and in rest addition seemed to be normal

AAP had raised the issue of deletion of name of their voters from the lists and enrolment of outsiders in large number in maiority of constituencies. There emerges a pattern that shows BJP the major beneficiary of the abnormal electoral roll deletion and addition of name exercise.

Electoral roll manipulation is only the tip of the iceberg of the election process manipulation. There are many other issues, such as EVM manipulation through numerous ways, voter turnout manipulation, and creating hurdles before peace loving voters by deliberately created tensions and violence, and so on. Entire electoral process and management needs a fresh look to have a free and fair poll in the country. EC have been alleged by the Opposition of favouring BJP by not even acting against their leaders as promptly and properly as against the opposition. Independent investigation is needed to know the layers of truth for the sake of Democracy in India. (IPA Service)

Bangladesh: Political turmoil, geopolitical shifts, and the future of democracy

s the seasons transition from spring to autumn, Bangladesh finds itself at a critical crossroads, navigating political upheaval, shifting global alliances, and rising tensions that threaten to reshape its democratic fabric. The country's turbulent political landscape, already fraught with instability, has been further shaken by the student-led uprising that culminated in the fall of Sheikh Hasina's government in August. Amidst this turmoil, Bangladesh's army chief, General Waker-Uz-Zaman, has issued a stern warning, urging political factions and student movements to halt their violent confrontations

and uphold national stability. A nation in chaos: The student uprising and its aftermath

The spark that ignited this recent wave of political unrest was an unprecedented midnight demonstration on February 23 by students of Dhaka University. Their demand was clear: the resignation of Bangladesh's home affairs advisor, Jahangir Alam Chowdhury, a retired lieutenant general, whom they blamed for the government's inability to curb rampant crime, extortion, and attacks on women and liberal activists. The failure of authorities to address these concerns led to a rapid escalation in tensions, culminating in violent clashes and a law-and-order crisis.

A desperate Chowdhury called an emergency press conference at 2:30 AM, promising swift action to restore security. However, in a grim turn of events, journalists attending the conference were attacked, further undermining the credibility of the government. The situation deteriorated to such an extent that the military had to step in, with General Waker-Uz-Zaman delivering a forceful address warning political actors, students, and Islamist factions against further destabilizing the nation.

The military's message: Stability over chaos

In his unequivocal remarks, General Zaman emphasized three key points. First, he admonished political groups, including student movements, the Bangladesh Nationalist Party (BNP), and Jamaate-Islami, for their violent rivalries, cautioning that their actions endangered Bangladesh's sover-

Second, he condemned efforts to free radical Islamist elements, particularly those involved in the 2009 Bangladesh Rifles (BDR) mutiny, in which dozens of army officers were massacred. "The mutineers who were punished deserve

it," he declared, drawing a firm line against any attempts to rewrite history in favor of those who had challenged military authority.

Third, and most crucially, General Zaman asserted that elections must be held by December 2024, quashing speculation that the interim government led by Nobel Laureate Mohammed Yunus might delay the process under the guise of implementing systemic reforms. The military's direct intervention signals an implicit rejection of prolonged governance by unelected officials and a clear preference for returning to an elected administra-

Geopolitical realignments and the shadow of global powers

Bangladesh's domestic turbulence has not unfolded in isolation. The nation finds itself caught in the shifting currents of global power struggles, with major international actors seeking to influence its trajectory

The ousting of Sheikh Hasina's government has been viewed by many as a "colour revolution," allegedly fueled by American deepstate funding funneled through USAID under the Biden administration. However, with the transition of power in Washington, the geopolitical tide appears to be turning once more.

Recent reports suggest that former US President Donald Trump, in his meeting with Indian Prime Minister Narendra Modi, indicated that he would leave the Bangladesh situation to India's discretion. This statement has been interpreted as a green light for Delhi to take a more assertive role in stabilizing its eastern neighbour. General Zaman's speech, in which he referred to Mohammed Yunus by name rather than his official title of Chief Advisor, further hints at a possible shift in Bangladesh's military loyalties.

Interestingly, this development aligns with historical precedents. Two previous Bangladeshi military rulers, General Hussein Mohammed Ershad and General Moeen U Ahmed, initially adopted anti-India postures before ultimately recognizing the geopolitical necessity of maintaining amicable ties with their larger neighbour.

In contrast, it was the democratically elected government of Begum Khaleda Zia that most severely strained Bangladesh-India relations, offering sanctuary to separatist rebels from India's northeast and obstructing regional connectivity initiatives.

The electoral battlefield: Can stability be restored?

As Bangladesh inches closer to

the promised elections, the key question remains: will the political landscape be inclusive and representative? The re-entry of the Awami League into the electoral process could serve as a stabilizing factor, potentially mitigating the risk of political violence.

Historically, both the Awami League and BNP have commanded substantial voter bases, each polling between 30-48% and 25-40% respectively. Islamist parties, including Jamaat-e-Islami, have typically garnered a smaller but still significant share of 5-8%.

However, concerns loom large over the integrity of the upcoming elections. The proliferation of illegal arms among political cadres raises fears that the electoral process could descend into blood-

The emergence of a new political entity, the National Citizen's Party, formed with alleged backing from Yunus, further complicates the political calculus. While initially enjoying substantial support, the student-led movement behind this party appears to be losing public favor due to its association with lawlessness and the erosion of institutional stability.

The road ahead: A new great game unfolds

Bangladesh's immediate future is fraught with uncertainties. The military has signaled its intent to restore order, but its commitment to a genuinely free and fair election remains under scrutiny. Political actors from all sides have begun courting India, recognizing its crucial role in shaping the postcrisis order. Meanwhile, ordinary Bangladeshis, weary of instability and economic hardship, yearn for a return to normalcy.

The broader geopolitical implications of Bangladesh's crisis cannot be overlooked. If the elections proceed transparently, the country could emerge from this turmoil with a renewed sense of democratic legitimacy. However, if the process is marred by violence, manipulation, or exclusion, Bangladesh risks further entrenching its political divisions, setting

the stage for prolonged instability. The coming months will be decisive in determining whether Bangladesh can navigate these treacherous waters and uphold its democratic foundations, or if it will become yet another battleground in the larger contest of global power politics. Only time will tell how the 'Great Game' will unfold in Dhaka, and whether the forces of democracy will ultimately prevail. (The writer can be reached

of Nobel laureate Prof Muhammad Yunus's interim government has prompted Chief of Army Staff, General Waker-Uz-Zaman, to call for an elected government. His statement on 24 February made it clear to the government, political parties, and student leaders responsible for waging the July-August Monsoon Revolution last year which ousted Sheikh Hasina's autocratic rule, that 18 months is enough time to hold a general election.

Prof Yunus has announced that the election could be held in December this year. However, his Press Secretary, Shafiq ul Alam, said it could be held either in December or January 2026. The election date to parliament will be announced at the decision of the Election Commission, which is not an independent body.

Earlier, Yunus has repeatedly said that the elections will be held only after reforms of crucial state institutions take place to ensure democracy, accountability, and transparency of the government and the officials.

The General repeated twice that the election should be free, fair and inclusive. The questions that come to mind are: What does he mean by inclusivity? Did he mean that no political parties should be left out from contesting the parliamentary elections?

On the other hand, the students have been agitating that Sheikh Hasina led Awami League should be banned and Yunus should not invite the Jatiya Party to any official dialogue. The East Pakistan Awami Muslim League is the oldest party and was born only a few years after the birth of Pakistan.

The founders of the party, who defected from the Muslim League in a bid to accommodate others, dropped "Muslim" and formed the Awami League in 1955.

Whereas, Jatiya Party, a king's party emerged after General Husain Muhammad Ershad in a bloodless coup in 1981 formed his party to consolidate his power. In 1990, he was overthrown after months of violent street protests by the

His party indeed was a "loyal opposition" during the 15 years rule of Hasina. The honeymoon period of the

Jatiya Party abruptly ended when the Awami League regime collapsed and Hasina

Bangladesh election schedule

fled to India last August. The back-scratching has prompted the leaders of the student revolution to say no to the Jatiya Party - a loud and clear message that they should not be in politics in future. The two military juntas took power and formed king's parties one was the Bangladesh Nationalist Party (BNP), which ruled the country for the fourth consecutive term. The second was the Jatiya Party. General Ershad's party ruled for nine years until his regime collapsed in 1990.

BNP was formed when military dictator General Zia ur Rahman, a liberation war decorated officer, took power in the vacuum when independence hero Sheikh Mujib ur Rahman was assassinated in August 1975 by a dozen young military officers without a political vision to steer the country through a crisis.

General Rahman took over the helms of affairs of the country, after a soldier's mutiny in less than three months of the previous military putsch. Despite having a political vision, for unknown reasons, he rehabilitated those politicians who opposed the independence of Bangladesh in crucial positions.

He also rehabilitated scores of Bangla-speaking military officers who fought alongside the Pakistan Army against the Mukti Bahini guerillas and Indian troops during the bloody war in 1971 and dodged the surrender ceremony of Pakistan armed forces. Also, most of the Bangla-speaking military officers were recruited in senior positions in the police services.

In a speech, last week, commemorating the fallen officers of the Bangladesh Rifles (BDR) revolt 17 years ago, General Waqar-uz-Zaman has said, "We are thinking that we will finish the work quickly and take the army back to the cantonment.'

"We have to be patient. Work with professionalism. Until an elected government comes, we have to do this with patience," he furthermore stated. Many have remarked that the COAS has expressed discomfort against the Yunus government when the situation of law and order reached an alarming level.

The crime situation in Bangladesh is such that there are thefts, robberies and dacoities committed in broad daylight causing widespread panic among the citizenry. The Home Affairs Advisor,

Lt. General Jahangir Alam Chowdhury, called a press conference at his house at 3 am and blamed the Awami League for the law and order situation. He said, "Awami League is funneling ill-gotten money to desperate criminals." Political and administrative

ircles believe that the ments of the army chief regarding the alarming rise of crime amid the demand for the resignation of the home adviser, and his accountability have given the allegation of failure of the government.

Meanwhile, Indian Nobel laureate Prof Amartya Sen, who was born in Bangladesh and studied in a school in Dhaka in an interview with the Indian official news agency Press Trust of India (PTI) a few days ago praised the Bangladeshi Army for its restraint in not attempting to establish military rule, as has happened in many other coun-

Dr Sen said "Yunus is an old friend. I know he is highly capable and, in many ways, a remarkable human being. He has made strong statements about Bangladesh's secularism and democratic commitment."

In many third-world countries, the military has always been ambitious to take over power and overthrow a legitimate government; Bangladesh Army seems to behave very rationally.

Bangladesh military officers are refused deployment in United Nations Peacekeeping and also provided visit visas to the United States, Canada, Great Britain, Australia and European countries for track record on human rights abuse. That is one of the reasons that General Zaman has advised his troops deployed for the anticrime operation so-called "Devil Hunt" to avoid excessive force and shoot to kill sus-

On the other hand, the mainstream political parties Bangladesh BNP and Islamist party Jamaat-e-Islami have been demanding an early election, a month after Yunus took charge of the government in August last year.

Dr Yunus, however, urged the political leaders to hold their patience until the crucial reforms of the election commission, judiciary, civil administration, constitution, media, anti-corruption, police administration and others are implemented.

The Chief Adviser of the Interim Government aims for the reforms in a bid to develop a state system based on public ownership, accountability, and welfare. The political parties negotiating with the government have in the back of their mind the fact that the Yunus administration does not have the reforms in the absence of a

They are saying in closeddoor party meetings that the political parties would be empowered to implement the reforms. Without the reforms, most observers and political think tanks believe that the political parties will take the country back to square one when they refuse to have the reforms in place.

Reforms will bring about more accountability and transparency of elected public representatives, which the politicians will not agree to in any case. In addition, the independence of the judiciary, and civil and police administration will jeopardize their authority over their constitution.

This is not the first time that the political and administrative reforms have been taken seriously. In 1990, days after the downfall of the military dictator, the student leaders were able to convince the mainstream opposition parties, the Awami League, BNP and Left coalition leaders to sign a pledge that they would bring about reforms of the government institutions.

Unfortunately, both the Awami League and BNP ruled the country several times. They deliberately ignored the reforms, leading to politicization of police, civil services, judiciary, election commission and other governmental institutions to manipulate in favor of the politicians and their henchmen.

Therefore, political historian Mohiuddin Ahmed predicts that hundreds of pages of reform documents would be thrown out of the windows of the iconic massive parliament building designed by Louis Kahn, a celebrated visionary architect. ree bean is a fast-growing leguminous tree that increases the soil's fertility through nitrogen fixation. It can help maintain ecological balance by enriching and improving soil health.

It is associated with various beneficial bacterial populations that help in releasing nutrients to the soil, thus improving the health and properties of the soil.

The leaves and other parts of the tree are easily decom- n u a l posed enhancing the organic matter content of soils.

Due to a large aboveground biomass, it can also play a vital role in the sequestering of atmospheric greenhouse gases especially carbon dioxide which help in the mitigation of regional climate

In both the hill district of Assam (Karbi Anglong and Dima Hasao) where jhum cultivation is commonly practiced, tree bean can be used as a tool for the reclamation of degraded jhum land and checking of soil erosion.

The tree can be intercropped with horticultural and agricultural crops there-

fore, tree bean based agroforestry systems have a dynamic role to play in supporting rural livelihoods

Recently, the elusive anglerfish, a ghostly predator of the ocean's twilight zone, was spotted closer to the surface than ever before. A fish known for thriving in the lightless depths had ventured into our world. And that, to me, is more terrifying than its monstrous grin.

Seagrass conservation key to global biodiversity and climate targets, studies show

recent review published on February 28, 2025 in Nature Reviews Earth & Environment by Carlos M Duarte, King Abdullah University of Science and Technology, Thuwal, Kingdom of Saudi Arabia and team shows that seagrass is declining worldwide due to human activities.

According to this review, seagrass has been declining at a rate of 1-2 per cent per year for the past century and nearly 5 per cent of species are now endangered.

They say that safeguarding 30 per cent of seagrass by 2030 could protect over 750 fish species, store millions of tons of carbon and sustain coastal communities.

We are losing biodiversity fast. A 2024 study by Balaji Vedharajan, published in the Journal of Indian Society of Remote Sensing, mapped seagrass along Tamil Nadu's Manora coast using advanced acoustic technology and ground-truthing techniques.

The findings were alarming, while 46 per cent of the surveyed area had seagrass and seaweed cover, 54 per cent was just open seafloor.

This means there's a huge opportunity for restoration, but more importantly, we need to stop the destruction in the first place.

Despite laws to protect coastal ecosystems, enforcefrom cities, industries, and agriculture continues to degrade these meadows, while coastal development and tourism put additional pressure on fragile

However, there is hope. Some countries have successfully restored seagrass by improving water quality, establishing marine protected areas, and launching conservation proj-

Currently, 23.9 per cent of known seagrass areas are in marine protected zones, and nearly 2,000 restoration projects have been initiated worldwide, ac-

cording to Duarte's

For example, in Virginia in the United States, a large-scale project has successfully reapproximately hectares of Zostera marina, leading to the recovery of associated invertebrate populations.

In India, notable restoration initiatives have been un-

dertaken. Between 2011 and 2020, researchers restored 14 acres of degraded seagrass areas in the Gulf of Mannar and Palk Bay, achieving a success rate of 85-90 per cent.

Additionally, the Organization for Marine Conservation, Awareness and Research has been actively involved in community-based seagrass restoration projects in Palk Bay, employing eco-friendly methods such as bamboo frames and coconut rope to transplant seagrass sprigs.

Studies like the one in Manora provide crucial data for conservation planning. But work is needed on ground.

Seagrass protection must become a national priority.

It should be integrated into broader marine conservation policies with strict enforcement. Scientists, conservationists, policymakers and local communities must work together to safeguard these ecosystems for the future. (Courtesy: Down To

The flight of the florican: An ornithologist's lifelong quest to save a terrestrial bird

...With a flash of white and a sharp carrying rattle", the bird "fluttered off the ground before dropping back to the spot he took off from". It "did that endearing jump twice more, before hurrying away into the fast descending dusk". That's how ornithologist

published in 1987 described the dramatic courting display of the male lesser florican. Two years later, the population of this species of bustard had fallen to 750, down from the 4,374 birds that Sankaran

and his mentor, veteran scien-

tist Asad Rahmani, had esti-

mated only five years before,

Ravi Sankaran, in an article

Today, the lesser florican is on the brink of extinction – the latest survey by the Wildlife Institute of India in 2017-'18 estimated that as few as 340 birds remain. During the 20th century, the lesser florican popularly known in Madhya Pradesh as the kharmor (the "peacock of the grass" in Hindi) – was abundant and conspicuous in dry grasslands all over India, from Uttar

Pradesh to Tamil Nadu. The story of the lesser florican's decline is equally the story of the untiring efforts by ornithologists Sankaran to study and conserve the endangered bird

species. Sankaran's "first love was floricans", Rahmani wrote in an obituary after the ornithologist died in 2009. After Sankaran saw the lesser florican in Sailana and the Bengal Florican in Dudhwa for the first time, he was "hooked" to the two species for the rest of his life, wrote Rahmani.

Sankaran's papers at the Archives, National Centre for Biological Sciences, contain his research notes and corre-

spondence on the lesser florican over several years and show how he was central to efforts to conserve it.

Fourteen years Sankaran's death, the imminent extinction of the lesser florican poses a troubling question for conservationists: how did the species come to such a pass despite a good scientific understanding of its ecology

Since the early 20th century, the lesser florican's courtship display has attracted the attention of several naturalists and scientists. During breeding season, the male bird arches its back, ruffles its conspicuously white neck feathers, then leaps up vertically a metre or two above the ground, followed by a controlled descent with par-

Little is known about the bird's winter movements, which appear to be largely irregular, British ornithologist Frank Finn noted in Indian Sporting Birds as far back as 1915. What is clear, however, is that the lesser florican requires large, continuous tracts of grasslands and grasslandlike habitat, such as fallows, fields and open scrub savannah, to survive. This is likely

tially open wings. Sankaran calculated that the bird could repeat this display up to 200 times an hour during peak breeding season from June to August. After a successful courtship, the female lesser florican nests in dense grassland, raising its chicks

foxes, dogs and humans. Many naturalists have remarked on the uncanny ability of the lesser florican to arrive with the monsoon rains in western and north-western India, where it stays till nesting is over.

its Achilles Heel today. In 1978, ornithologist RS Dharmakumarsinhji wrote that



the lesser florican was "seen frequently" in the Wankaner Hills of Gujarat, along with other game birds such as rain quail and partridges, between 1928 and 1938. Now, the species is recorded in only a few sites such as Velavadar in Gujarat and Shonkhaliya in Rajasthan.

The extensive hunting of the lesser florican has been one of the major causes of endangerment since the 19th century. British authors wrote of the lesser florican as a preferred game species, since it was easy to target during its leaping display. Finn included it as one of the key sporting birds of India, along with the Common Crane and the Bengal Florican, in his 1915 paper in the Journal of the Bombay Natural History Society. Sankaran's correspondence with bird-lovers in Central India also indicates that hunting the lesser florican was

a popular sport till the 1940s. Large-scale hunting appears to have continued after independence. Dharmakumarsinhji mentions the frequent hunting of the male lesser florican in Gujarat's Kathiawar district even in the 1960s. But it was the rapid loss of

grassland and fallows all over

India that possibly pushed the

species into endangerment. By the time Sankaran began his research on the lesser florican in 1985, the species was already restricted to a handful of sites in Eastern Gujarat, Eastern Rajasthan and Western Madhya Pradesh.

Changes in the landscape were evident in the sites Sankaran visited frequently. Based on surveys in the late 1990s, he estimated that 50% of privately owned grasslands that he had visited in 1989 had been lost between 1989 to 1999. Sankaran also identified over-grazing by livestock that had converted large stretches of grasslands to unproductive land by the late 1980s.

His observations give vital clues into how a rare species may be pushed to low numbers when natural and human factors come together. In 1999, Sankaran wrote that the lesser florican was particularly susceptible to drought. Rainfall determined the regrowth of grass every monsoon as well as insect prey. An extended drought from 1985 to 1987, Sankaran wrote, pushed down the bird's populations drastically and never recovered.

As Sankaran observed, this was due to the natural patchiness in rainfall in this part of

India. Even in years of good monsoon, some patches of grasslands may not receive sufficient rain, which is essential for the successful breeding of the lesser florican. Today, with climate change and increasingly erratic weather, the odds are stacked against the lesser florican more than ever before.

Science and conservation From 1995, Sankaran's prolific correspondence, research reports and papers reveal a deep concern with conservation issues and a keenness to save the lesser florican in the wild. Sankaran and fellow researchers feared for the bird's future as early as 1992, writing in the Journal of the Bombay Natural History Society that they believed, "in all probability, the population has fallen well below levels from which it can recover; that the species is drifting steadily towards ex-

tinction" Sankaran seems to have had strong faith in science as the basis for effective conservation, particularly in bringing about coexistence. For instance, in a 1990 research paper co-authored with Rahmani, Sankaran attempted to link grassland management and ownership with the likelihood of successful breeding of the lesser florican. This was a time when scientists were just beginning to use their research for the conservation of species

and habitats. Sankaran tried to understand how the birds were able to thrive in the matrix of natural grasslands, used grasslands, fallows and agricultural fields. In a research paper Sankaran presented at a workshop in Baroda in 1994, he advocated for the expansion of grasslands under strict protection coupled with the regulation of freerange grazing in private bheeds village commons. Sankaran, and the co-authors,

suggested "there should be no

the first rains of the southwest monsoon and the harvest of grass in November", after which the hay could be harvested for stall-feeding. They were convinced that such a strategy would benefit both local residents and the lesser florican: the grasslands would be more productive after a breather from grazing and the bird would be able to breed successfully as well.

Sankaran was perhaps the first ornithologist to engage seriously with the people in the landscape, including farmers, forest officers and administrators. He organised workshops with varied stakeholders to devise conservation plans that would be locally acceptable. He tried to persuade farmers to reduce pesticide use in jowar. groundnut and soyabean fields where the lesser florican was found to be breeding.

In the early 1990s, he had also started nurturing a network of local nature-lovers to keep tabs on the arrival dates of male birds and breeding numbers in specific sites. He called this the Florican Watch network. This was perhaps one of the earliest instances of citizen science in India.

At a workshop in Bhopal in 1996, Sankaran spoke about a payment scheme by the Madhya Pradesh Forest Department for local villagers in Sailana and Sardarpur wildlife sanctuaries in return for reporting on the lesser florican and protecting them, which continued for several years.

Some of this work was taken forward by the Bombay Natural History Society after Sankaran's death.

Since Sankaran died, the lesser florican is on the brink of extinction. In the village of Shonkhaliya in Rajasthan, which lesser floricans still visit during the monsoon, the habitat is not ideal. There, the bird

grazing in grasslands between has taken to mounting its courtship displays and breeding in cultivated fields. But pesticides are still used in the fields and vilayati kikar, an invasive tree species, has grown over some of the adjoining grasslands, shrinking the lesser florican's habitat.

Bird photographers, biologists and birdwatchers continue to flock to the village to witness the lesser florican's spectacular breeding display. But fewer and fewer birds arrive with the rains each year.

The intriguing leaping display of the male lesser florican had made it an easy target for hunters, just as it has attracted the attention of naturalists since the 1800s. Did the bird's unique courting display also push scientists like Sankaran into focusing on the breeding grounds at the cost of understanding and challenging the larger socio-ecological issues

in Indian grasslands? From the 1960s, subsistence agriculture transitioned into modern and chemical-intensive farming. Development and agricultural expansion has also sidelined itinerant herders who could possibly coexist with the lesser florican. Grasslands have fragmented due to neglect by the government, which views these as "wasteland".

The large-scale agrarian and landscape transformation sounded the death-knell for the lesser florican, as it has for pastoralists and marginal farmers. Sankaran, in his 1987 article, had hoped that preserving grasslands would give a new lease of life "to one of India's most spectacular birds – the lesser florican – and also all the other creatures that inhabit a grassland". A quiet end likely awaits the lesser florican, but it is also a tragic failure of science and conservation in countering the larger forces of population decline. (Courtesy:

PESHAWAR, March 5: Intelligence reports "unequivocally confirm the physical involvement of Afghan nationals" in the terror attack in northwest Pakistan in which five soldiers, 13 civilians and 16 terrorists, including four suicide bombers, were killed, the army said Wednesday.

Till late Tuesday night, there were reports of death of 12 civilians, including four children, as two explosive-laden vehicles rammed into the boundary wall of the main cantonment in Bannu in Khyber Pakhtunkhwa province while the army personnel killed at least six terrorists.

Following the suicide attack on the Bannu Cantonment, about 200 kilometres south-west of Peshawar, Pakistan army said it reserves the right to take necessary measures in response to the threats emanating from across the border.

Islamabad "expects the interim Afghan government to uphold its responsibilities and deny its soil for terrorist activities against Pakistan," the Inter-Services Public Relations (ISPR), the media wing of the army, said in a statement.

The ISPR statement noted that intelligence reports "unequivocally confirmed the physical involvement of Afghan nationals in this heinous act, with evidence also pointing to the fact that the attack was orchestrated and directed

The term 'khwarij' refers to a group in early Islamic history which was involved in violence and the Pakistan army uses it for the banned Tehreek-e-Taliban Pakistan (TTP).

Hafiz Gul Bahadur-affiliated little known Jaish Al Fursan, in a statement, had claimed the attack in Bannu. The group is one of the several factions of TTP.

As the terrorists rammed the explosives-laden vehicles into the perimeter wall of the Bannu Cantonment, several terrorists attempted to enter the high-security zone, the troops engaged the intruders with precision, killing all by khwarij ring leaders operating 16 terrorists, including four suicide bombers, the ISPR said.

In the intense exchange of fire, five brave soldiers, who put up a heroic resistance, were killed in the line of duty, the ISPR added.

Meanwhile, 13 civilians lost their lives while 32 were injured as a result of a mosque and a residential building suffering "severe destruction" due to the impact of the the suicide blasts.

President Asif Ali Zardari, Prime Minister Shehbaz Sharif and province's Governor Faisal Karim Kundi and Chief Minister Ali Amin Gandapur condemned the attack and an inquiry into the incident has been ordered.

Islamabad has consistently voiced concerns that the banned tacks in Pakistan, asking the Afghan interim government to rein in the group; Kabul has de-In July 2024, a terrorist attack nied the allegations.

Last month, the ISPR said an Afghan national "involved in terrorism inside Pakistan" was killed during an operation in the province's North Waziristan dis-

On November 20 last year, 12 troops were killed in a suicide attack on a security check post in the Mali Khel area of the district.

On October 14, security forces foiled a gun and bomb attack on Iqbal Shaheed Police Lines and killed five militants who wearing lice officials died during the oper-

targeting Bannu Cantonment had seen death of eight personnel from the security forces while a retaliatory operation killed 10 terrorists.

The ISPR statement had attributed that attack to the Hafiz Gul Bahadur group, "which operates from Afghanistan and has used Afghan soil to orchestrate acts of terrorism inside Pakistan in the past as well."

Pakistan has witnessed an uptick in terror activities recently, especially Khyber Pakhtunkhwa and Balochistan provinces after the banned TTP ended its ceasefire with the government in November 2022.

February saw a marginal increase in terrorist attacks but a sharp surge in civilian casualties, according to a report published by an Islamabad-based think tank, Pakistan Institute for Conflict and Security Studies (PICSS).

According to PICSS, the country witnessed 79 terrorist attacks last month, resulting in the deaths of 55 civilians and 47 security personnel, while 45 civilians and 81 security personnel were injured.

Security forces, meanwhile, intensified counter-terrorism operations, eliminating 156 terrorists, injuring 20, and arresting 66, the

Indian-origin nurse attacked by patient in Florida, could lose eyesight

HOUSTON, March 5: A 67-year-old Indian-origin nurse was repeatedly punched in the face by a patient at a Florida hospital in a possible hate crime that could lead to her losing her eyesight, local media has reported. Nurse Leela Lal, also known as Leelamma Lal, was assaulted and "every bone of her face broken" by Stephen Eric Scantlebury, a 33-year-old patient she was tending to in the psychiatric ward at the Palms West Hospital in West Palm Beach, Florida on February 18, police said.

In a local court, a police officer testified that a video clip showed Scantlebury saying, 'Indians are bad' and 'I just beat the (expletive) out of an Indian doctor'," news channel WPTV.com said.

Scantlebury faces a charge of attempted second-degree murder in the attack and also faces a hate crime enhancement, which could result in harsher penalties if he is convicted, the media said.

WPTV.com reported after the incident that HCA Florida HealthCare, which runs the Palm West Hospital, said the attack occurred "within a matter of seconds" and was "witnessed by multiple people" and added that Lal was taken by helicopter to St Mary's

Trump criticises high tariffs charged by India



NEW YORK/WASHINGTON, March 5: US President Donald Trump criticised the high tariffs charged by India and other countries, terming them as "very unfair" and announced reciprocal tariffs from April 2 on nations that impose levies on American goods.

Trump made these remarks in an address to the Joint Session of the Congress on Tuesday. It was the first address of his second term in the White House. On January 20, Trump was sworn in as the 47th President of

"If you don't make your product in America, however, under the Trump administration, you will pay a tariff and in some cases, a rather large one,' Trump said.

"Other countries have used tariffs against us for decades and now it's our turn to start using them against those other countries. On average, the European Union, China, Brazil, India, Mexico and Canada — have you heard of them? And countless other nations charge us tremendously higher tariffs than we charge them,

"It's very unfair. India charges us auto tariffs higher than 100 per cent." In February, President Trump said

that his administration would "soon" impose reciprocal tariffs on countries such as India and China, reiterating what he had said during Prime Minister Narendra Modi's visit to the US capital last month.

Trump has made it clear to Prime Minister Modi that India will not be spared from Washington's reciprocal tariffs and emphasised that "nobody can argue with me" on tariff structure.

"China's average tariff on our products is twice what we charge them. And South Korea's average tariff is four times higher. Think of that. Four times higher. And we give so much help militarily and in so many other ways to South Korea. But that's what happens. This is happening by friend and foe," Trump said.

"We've been ripped off for decades by nearly every country on earth, and we will not let that happen any

longer," Trump said. Asserting that this system is "not

fair to the United States" and never was. Trump said that reciprocal tariffs will kick in from April 2

"Whatever they tariff us, other countries, we will tariff them. That's reciprocal, back and forth," Trump said amid applause from Republican lawmakers.

"Whatever they tax us, we will tax them. If they do non-monetary tariffs to keep us out of their market, then we will do non-monetary barriers to keep them out of our market. There's a lot of that too. They don't even allow us in their market. We will take in trillions and trillions of dollars and create jobs like we have never seen before,"

Trump said. He added that "I did it with China, and I did it with others and the Biden administration couldn't do anything about it because it was so much money they couldn't do anything about it.

He added that the US has very large deficits with both Mexico and Canada.

"But even more importantly, they have allowed fentanyl to come into our country at levels never seen before, killing hundreds of thousands of our citizens and many very young, beautiful people, destroying families. Nobody's ever seen anything like it. They are in effect receiving subsidies of hundreds of billions of dollars. We pay subsidies to Canada and to Mexico of hundreds of billions of dollars. And the United States will not be doing that any longer. We are not going to do it any longer."

Trump is implementing a 25 per cent additional tariff on imports from Canada and Mexico and a 10 per cent additional tariff on imports from China. In a retaliatory action, Canada said that effective March 4, 2025, it is imposing 25 per cent tariffs on USD 30 billion in goods imported from the United States.

Mexico said it will announce reciprocal action on Sunday.

China also announced it will impose additional tariffs of up to 15 per cent on imports of key US farm prod-

Slovak president swears in new minister in reshuffle to stabilise government

(SLUVANIA), March 5: Slovakia's President Peter Pellegrini swore in a new minister of tourism and sports on Wednesday in a reshuffle aimed to stabilise the

government. The appointment of Rudolf Huliak came two weeks after the three parties in the governing coalition agreed on a move to increase the power of the Smer (Direction) party of populist Prime Minister Robert

Under the agreement, the coalition's two junior partners — the Hlas (Voice) party and the ultranationalist and pro-Russian Slovak National Party — gave up control of one ministry each to Smer.

With the addition of the ministries overseeing investments, regional de-

velopment and information, and tourism and sports, Smer now controls nine ministries, Hlas six and the Slovak National Party two

The deal was a result of a recent crisis in the coalition that risked its parliamentary majority. The coalition had 79 seats in the

150-seat parliament known as the National Council before four Hlas lawmakers and three others, including Huliak, in the Slovak National Party parted with their parliamentary factions.

The lawmakers did not join the opposition but have demanded posts in the government, parliament and state institutions in exchange for their loyalty. That has made it difficult for the government to advance

Veterans speaking out on Trump administration's plans to cut VA's budget

NORFOLK (US), March 5: Stephen Watson served in the Marines for 22 years and receives care through the Department of Veterans Affairs for a traumatic brain injury. He supports President Donald Trump and adviser Elon Musk's cost-cutting program — even if it affects the VA. "We're no better because we're veterans." said Watson, 68, of Jesup, Georgia. "We all need to take a step back and realize that everybody's gonna have to take a little bit on the chin to get these budget matters under control." Gregg Bafundo served during the first Gulf War and has nerve damage to his feet from carrying loads of weight as a Marine mortarman. He says he may need to turn to the VA for care after being fired as a wilderness ranger and firefighter through the layoffs at the US Forest Service. "They're going to put guys like me and my fellow Marines that rely on the VA in the ground," said Bafundo 53 who lives in Tonasket Washington

The Trump administration's move to end hundreds of VA contracts — halted after public outcry — and ongoing layoffs are affecting the nation's veterans, a critical

and politically influential constituency

More than 9 million veterans get physical and mental health care from the VA, which is now being examined by Musk's Department of Government Efficiency.

The VA manages a USD 350 billion-plus budget and oversees nearly 200 medical centres and hospitals, many in Republican-led states and districts. Veterans have shown up at town hall-style meetings to voice their anger, and groups like the Veterans of Foreign Wars are mobilizing against cuts. Veterans were much likelier to support Trump, a Republican, than Vice President Kamala Harris, a Democrat, in November's presidential election, according to AP VoteCast, a survey of the American electorate conducted in all 50 states. Nearly 6 in 10 voters who are veterans backed Trump, while about 4 in 10 voted for Harris.

China hikes defence budget to USD 249 billion amid hectic military modernisation

BEIJING, March 5: China on Wednesday announced a 7.2 per cent increase of its national defence budget totalling to USD 249 billion this year amid its hectic efforts to modernise armed forces, including fast paced development of warships and new generation

The planned defence expenditure for the country is 1.784665 trillion yuan (about USD 249 billion) this year, according to a draft budget report submitted to China's Parliament by Premier Li Qiang, state-run Xinhua news agency reported

Last year, China increased its defence budget by 7.2 per cent to about USD 232 billion (1.67 trillion yuan).

China has the world's second-largest military budget after the US whose latest defence spending amounted to over USD 890 billion as proposed by President Donald Trump. The Chinese defence spending is amounted

to three times that of India's ₹ 681, 210 crore (USD 78.8 billion). China's defence budget figures are viewed by critics with scepticism in the light of massive military modernisation, including build-

ing aircraft carriers, rapid construction of

advanced naval ships and modern stealth air-

craft being carried out at a feverish pitch by the Chinese military. Announcing the annual budget which includes the defence spending at the opening of the annual session of China's parliament, the National People's Congress (NPC) Chinese Premier Li Qiang said last year, China made major new progress in national defence and military development.

Li emphasised on the Chinese President Xi Jinping's core leadership of the ruling Communist Party as well as the People's Liberation Army (PLA) and the military follow the party

Xi is also the Chairman of the Central Military Commission (CMC) which is the overall high command of the military.

We will stay committed to the Party's absolute leadership over the people's armed forces, thoroughly implement the system of ultimate responsibility resting with the chairman of the Central Military Commission, continue improving the political conduct of the military," he said.

The Chinese military functioned under the leadership of the Communist Party unlike the armed forces of other countries which functioned under the government.

"We will step up military training and combat readiness, speed up the development of new combat capabilities, and establish a framework of modern military theories with Chinese characteristics, so as to firmly safeguard China's sovereignty, security, and development interests," Li said in his work report submitted to the NPC.

On Tuesday, Lou Qinjian, spokesperson for the NPC, defended China's increasing defence expenditure, saying that "peace needs to be safeguarded with strength"

Since 2016, China's annual defence spending has maintained single-digit growth for nine years in a row, he said, adding that China's defence expenditure as a share of GDP has been kept under 1.5 per cent for many years. (PTI)

AI pioneers who channeled 'hedonistic' machines win computer science's top prize WASHINGTON, March 5:

Teaching machines in the way that animal trainers mold the behaviour of dogs or horses has been an important method for developing artificial intelligence and one that was recognised Wednesday with the top computer science award. Two pioneers in the field of re-

inforcement learning, Andrew Barto and Richard Sutton, are the winners of this year's A M Turing Award, the tech world's equivalent of the Nobel Prize Research that Barto, 76, and

Sutton, 67, began in the late 1970s paved the way for some of the past decade's AI breakthroughs. At the heart of their work was channeling so-called "hedonistic" machines that could continuously adapt their behaviour in response to positive signals.

Reinforcement learning is what led a Google computer programme to beat the world's best human players of the ancient Chinese board game Go in 2016 and 2017. It's also been a key technique in improving popular AI tools like ChatGPT, optimising financial trading and helping a robotic hand solve a Rubik's Cube.

"We were kind of in the wilderness," Barto said in an interview with The Associated Press. "Which is why it's so gratifying to receive this award, to see this becoming more recognised as something relevant and interesting. In the early days, it was not."

In particular, they borrowed

from ideas in psychology and neuroscience about the way that pleasure-seeking neurons respond to rewards or punishment. In one landmark paper published in the early 1980s, Barto and Sutton set their new approach on a specific task in a simulated world: balance a pole on a moving cart to keep it from falling. The two computer scientists later co-authored a widely used textbook on reinforcement learning

"The tools they developed remain a central pillar of the AI boom and have rendered major advances, attracted legions of young researchers, and driven billions of dollars in investments," said Google's chief scientist Jeff Dean

in a written statement. In a joint interview with the AP, Barto and Sutton didn't always agree on how to evaluate the risks of AI agents that are constantly seeking to improve themselves. They also distinguished their work from the branch of generative AI technology that is currently in fashbehind chatbots made by OpenAI, Google and other tech giants that mimic human writing and other

"The big choice is, do you try to

learn from people's data, or do you

try to learn from an (AI) agent's own life and its own experience?" Sutton said. Sutton has dismissed what he describes as overblown concerns about AI's threat to humanity,

while Barto disagreed and said "You have to be cognizant of potential unexpected consequences. Barto, retired for 14 years, de-

scribes himself as a Luddite, while Sutton is embracing a future he expects to have beings of greater intelligence than current humans an idea sometimes known as posthumanism.

"People are machines. They're amazing, wonderful machines, but they are also not the "end product" and could work better, Sutton said, "It's intrinsically a part of the AI enterprise," Sutton said. "We're trying to understand ourselves and, of course, to make things that can work even better. Maybe to become such things." (AP)

Committee on Manipur Integrity (CO-COMI) has strongly condemned the "provocative and inflammatory" statement issued by the Committee on Tribal Unity (COTU), a Kuki-Zo based organisation, on March 3, 2025, wherein they "openly challenge the authority of the Union Home Minister and the Government of India.'

"This brazen declaration is not only unconstitutional but a direct threat to national unity, law and order, and the sovereignty of the Indian state", said a COCOMI statement on Tuesday.

"The COTU's so-called 'Unbreakable declaration of the Kuki-Zo community' is nothing short of a secessionist manifesto that incites unrest, endorses illegal blockade tactics, and openly defies the democratic and constitutional framework of the country", the COCOMI further said. "This rhetoric of defiance and extremism, issued on a public platform, warrants immediate legal and administrative intervention".

By declaring their struggle for a 'Separate Administration' as 'non-negotiable' and threatening to 'carve their own path, no matter the cost,' COTU has openly challenged the constitutional framework of India, the COCOMI said and added that this "defiance" undermines the authority of the Union Home Minister and disrespects the due process of law.

The statement that "no free movement shall be permitted in Kuki-Zo land" is an unlawful act that directly contravenes the fundamental rights guaranteed by the In-

tained, while noting that no entity or community has the legal right to impose restrictions on citizens' movement within Indian territory.

The COTU's warning that "no Kuki-Zo volunteer shall be arrested" and that "any such action will be met with consequences" is an outright challenge to the rule of law, the COCOMI also said and stressed that the demand for impunity for individuals engaging in disruptive activities must be met with strict legal repercus-

The COCOMI then said that the "explicit" statement that the COTU will "unleash total resistance if the government enforces peace without addressing their demands" is a clear act of rebellion.

"Such statements by so-called civilian groups called COTU encourage violence and create an atmosphere of intimidation and civil unrest, and the declaration that their demand for a Union Territory with Legislature is 'final' and 'not negotiable' contradicts the democratic principles of dialogue and resolution", it said.

"This inflexible stance is a deliberate attempt to destabilize peace efforts in Manipur", the committee further said and alleged that the COTU's call for 'No peace before separation' exposes their role in perpetuating violence.

"By making peace conditional upon separation, the COTU has blatantly revealed itself as the primary instigator of violence in Manipur.

Their statement justifies continued un-

rest and conflict solely to push their vested political agenda, the COCOMI further said and alleged that this proves beyond doubt that the turmoil in Manipur since May 3, 2023, has been premeditated and orches-

One of the significant achievements during the month was the successful construction of a Road under Bridge (RUB) at km 57/7-8 between Panisagar and Pencharthal station on the Baraigram – Agartala section. Commissioned on February, this new RUB has

permanently eliminated unautho-

rized track crossings at the location, substantially enhancing safety for both train operations and the local population.

In addition, NFR completed the replacement of old girders at Major Bridge No 103 located at

and Kampur station. Following the successful replacement of all four girders existing speed restriction of 75 kmph will now be withdrawn, enabling trains to operate at higher speeds while ensuring safer passage across the bridge.

AGARTALA, March 5: A Traffic Inspector in Tripura has been arrested for allegedly misappropriating ₹ 74 lakh from the Bishalgarh Traffic Police Unit in Sepahijala district, officials said on Wednesday.

Additional superintendent of police, Sepahijala District, Rajib Sutradhar, stated that during routine reconciliation of traffic fines, discrepancies amounting to ₹ 74 lakh were identified.

"While verifying the records, we found that the amount collected as fines was not deposited in the government treasury by the Bishalgarh Traffic Unit. Inspector Amarjit Debbarma, who was responsible for handling the funds, initially claimed that he had submitted the amount. NEW DELHI, March 5: Drawing attention to the financial difficulties faced by railway porters, Congress leader Rahul Gandhi on Wednesday said they risked their lives to help people during the stampede at the New Delhi Railway Station last month and yet their voice was not being heard.

The former Congress president, who posted on his YouTube channel a video of his recent interaction with porters at the New Delhi Railway Station, asserted that he would fight for their rights.

Gandhi also urged people to share suggestions on the 'Awaaz Bharat Ki' portal to improve crowd management and strengthen security. "We will listen to the voice of India!" he said on X.

The increasing number of stampedes at railway stations and other public places is a matter of great concern, Gandhi said, noting that many innocent people lose their lives or get injured in such inci

"We need to think together about how to prevent such tragedies," he said. In his post accompanying the video of his interaction with porters, Gandhi said, "A few days ago, I reached New Delhi Railway Station and met the porter brothers there again. During the interaction, they told me how everyone together made every possible effort to save people's lives on the day of the stampede.'

"Whether it was trying to remove people from the crowd, ensuring that the injured reached the ambulance and administration, or taking out the bodies of the dead using their physical abilities, handcarts or spending money from their own pockets, they helped the passengers in every way," the Leader of Opposition in the Lok Sabha said. Gandhi thanked them for saving many lives and helping in the relief work during the stampede at the station on February 15.

At least 18 people were killed in the incident at the New Delhi Railway Station, which was witnessing a surge of passengers waiting to board trains for Prayagraj.

The Congress leader said, "I am very impressed to see the compassion of these brothers who come to

earn daily wages" "They are still living in financial difficulties - but are full of passion and goodwill. They need help, about which they conveyed their demands. I will definitely make every possible effort to help them," Gandhi said.

In a post in Hindi on X, the Congress leader quoted a porter as saying, "Some days we don't even have money to eat. We either send money home or eat food."

"Our porter brothers are forced to live in such difficulties," he said in his post on X.

"During the stampede at New Delhi Railway Station, these people risked their lives to help people, but their voice is not being heard. I will put their demands before the government and fight with all my might for their rights!" Gandhi said

Taking part in a debate on the motion of thanks to LG's address at a time when NC president Farooq Abdullah reached the visitors' gallery to watch the proceedings, Para sought restoration of the two holidays and highlighted the importance of the July 13, 1931 when 22 men fell to the bullets of Dogra Maharaja's soldiers outside Srinagar central jail and the contribution of

Crying injustice, Azmi said the action against him was taken despite him retracting his remark.

Uttar Pradesh Chief Minister Yogi Adityanath asked the Samajwadi Party to take a stand on Azmi's remarks, demanding that it must expel him for glorifying the Mughal ruler.

Maharashtra minister Chandrakant Patil moved the motion of suspension of Azmi from the House for the remainder of the session's term.

Members of the treasury benches said Aurangzeb's praise amounted to an insult of Maratha king Chhatrapati Shivaii Maharai and his son Chhatrapati Sambhaji Maharai. The motion was passed by a voice

vote. "Azmi's comments praising Aurangzeb and criticizing Sambhaji Maharaj do not suit the stature of a member of the assembly and is an insult of the democratic institution of the legislative assembly," Patil said.

Azmi, president of the Samajwadi Party's state unit, had said that during Aurangzeb's reign, India's border reached Afghanistan and Burma

"Our GDP accounted for 24 per cent (of the world GDP) and India was called a golden sparrow (during his regime)," claimed the MLA from Mankhurd Shivaji Nagar constituency in Mumbai.

Asked about the fight between Aurangzeb and Chhatrapati Sambhaji Maharaj, Azmi had termed it a political battle.

His comments rocked both houses of the state legislature on Tuesday, with members of the ruling side demanding his suspension and that he be booked for treason.

Azmi said his remarks were twisted. "Whatever I have said about Aurangzeb is something that has been stated by historians and writers. I have not made any derogatory remarks against Shivaji Maharaj, Sambhaji Maharaj or any national icons. Still, if anyone is hurt by my remarks, then I take back my statements and comments," he said on Tuesday.

In a video statement released by his office on Wednesday, Azmi asserted he had not said anything wrong, but retracted the remark, which he made outside the assembly, to ensure the House functions. 'Despite this I was suspended,' he said.

Deputy Chief Minister and Shiv Sena head Eknath Shinde on Tuesday

led the attack on Azmi both in the legislative council and assembly.

"Azmi is purposely insulting Shivaji Maharaj and Sambhaji Maharaj. Sambhaji Maharaj's bravery and Aurangzeb's cruelty will give goosebumps to people," Shinde had said. The Mughal emperor not only killed Hindus but also people from other religions, he had said.

Shinde dubbed Azmi a "traitor" and said he had no right to sit in the House.

The recent Hindi film, 'Chhaava', has documented the bravery and sacrifice of Sambhaji Maharaj, he said. "See the torture Sambhaji Maharaj

Govt clears Kedarnath, Hemkund Sahib Ji ropeway projects worth ₹ 6,811 cr



NEW DELHI, March 5: The government on Wednesday approved two ropeway projects in Uttarakhand --Sonprayag to Kedarnath and Govindghat to Hemkund Sahib Ji -- at a total cost of ₹ 6,811 crore to help significantly reduce the travel time to the pilgrimage sites and boost tourism.

The construction of these two ambitious projects is likely to be completed in 4-6 years. The two ropeways will be constructed under the National Ropeways Development Programme - Parvatmala Pariyojana.

The decisions of the Cabinet Committee on Economic Affairs (CCEA), chaired by Prime Minister Narendra Modi, were announced by Information and Broadcasting Minister Ashwini Vaishnaw.

The Sonprayag to Kedarnath ropeway is planned to be developed in public-private partnership and will be based on the most advanced Tri-cable

Detachable Gondola (3S) technology having the capacity to carry 1,800 passengers per hour per direction (PPHPD), which could ferry 18,000 passengers per day.

Vaishnaw informed that the 12.4-km ropeway project from Govindghat to Hemkund Sahib Ji too will be developed on DBFOT mode at a total capital cost of ₹ 2,730.13 crore.

Currently, the journey to the Hemkund Sahib Ji is a challenging 21km uphill trek from Govindghat and is covered on foot or by ponies or palanquins. The proposed ropeway is planned to provide convenience to pilgrims visiting the Hemkund Sahib Ji and the tourists visiting the Valley of Flowers. and will ensure all-weather last-mile connectivity between Govindghat and Hemkund Sahib Ji.

The journey to the Kedarnath temple is a challenging 16-km uphill trek from Gaurikund and is currently covered on foot or by ponies, palanquins and helicopter. The proposed ropeway is planned to provide convenience to pilgrims visiting the temple and ensure all-weather connectivity between Sonprayag and Kedarnath. (PTI)

IIT Madras develops framework to protect critical infrastructure against ballistic missiles

NEW DELHI, March 5: Researchers at the Indian Institute of Technology (IIT), Madras, have developed a framework that can boost protection of critical infrastructure in the country against the threat of ballistic missiles, according to officials. The framework will help designers develop innovative solutions for improving the ballistic resistance of reinforced concrete (RC) panels, they said.

The findings of the research were published in reputed peer-reviewed journal "Reliability Engineering & System Safety". Using computational simulations, the researchers studied the impact of missiles on RC, which is the main

material used to construct vital structures ranging from military bunkers, nuclear buildings and bridges to run-

According Alagappan nalagu, assistant professor, Department of Civil Engineering. Madras, concrete structures face highly localised such as penetration, perfoscabbing, ration, spalling and crushing under projectile impact load.

"Due to the strategic importance of these structures, it is necessary to protect them against projectile and debris impact, which can result in localised damage or even the collapse of the entire structure," he said. Ballistics is a field of engineering that deals with the launching, flight behaviour, and impact effects of projectiles such as bullets, bombs, and rockets. This science is used not only for designing bunkers, but also for designing the walls of nuclear power buildings, bridges, and other protective structures.

The researchers conducted the study during Finite Element' (FE) simulation, a computational technique used to simulate and analyse physical phenomena in engineer-

nite Element Method (FEM), a numerical approach for solving complex problems involving partial differential equations. These problems often arise in fields like structural mechanics, among others. The researchers focused on the development of the novel performance-based design framework based on Depth of Penetration' (DOP) and Crater Damage Area in

INDORE, March 5: The Madhya Pradesh High Court has directed the state government to strictly adhere to one of its circulars and give priority in government jobs to persons with higher disability.

The high court gave this direction recently while disposing of the petitions of five persons suffering from higher disability. These petitions said the state government was "completely ignoring" its own circular in the appointment of divyangs or differently-abled persons. In the circular issued on July 3, 2018 by the General Administration

Department of the state government, it was said, "It has often been seen that divyangs whose percentage of disability is less, are being given reservation in government service. Divyangs whose percentage of disability is more, are not being given appointments in government service. This action is contrary to the intention of the provision mentioned in the Divyang Jan Adhikar Niyam 2017. Therefore, priority should be given to those divyangs who have more disability. In light of this circular, Justice Subodh Abhyankar of the Indore

bench of the high court on February 24 cancelled the recruitment of a total of five candidates on Class IV posts under the divyang quota by the Skill Development Department of the state government, Kannod Municipal Council of Dewas district and Jaora Municipal Council of Ratlam district. Navratna status gives us freedom to fund HC: Will state book 5 cops indicted in magistrate report on encounter of Badlapur case accused

MUMBAI, March 5: The Bombay High Court on Wednesday asked the Maharashtra government if it dicted by a magistrate's report on the encounter of the Badlapur school sexual assault accused.

The court posed this question even as the state government reiterated that it had already set up a commission headed by the retired Chief Justice of the Allahabad High Court and a probe is being carried out by the state CID into the alleged police shootout.

The accused in the case was allegedly shot dead in a police encounter in September last year while being taken from the Taloia prison to Kalvan in Thane district. The escorting police team claimed that they shot at the accused in self-defence after he snatched the gun of one of them and opened fire. Since it was a custodial death, as per law, a magistrate conducted an inquiry and submitted his report to the HC. The magistrate said there was substance in the allegations made by the parents of the deceased accused that this was a fake encounter, and raised suspicion on the policemen's self-defence claim. As per the inquiry report, five policemen were responsible for the death of the accused.

On Wednesday, a division bench of Justices Revati Mohite Dere and Neela Gokhale said it only wanted to know what the state government proposes to do now that the magistrate has submitted his report.

Once that the report has come, our question is whether it is incumbent on the State to register a FIR or not. Today the question is whether the State proposes to lodge an FIR or not? Say yes or no, the court said. The state government has to tell us whether FIR ought to be registered or not, it added.

Senior counsel Amit Desai, appearing for the government, said the state is already carrying out an independent investigation, besides the inquiry commission, and hence believes that it is acting in accordance with the law.



The observations made by the magistrate cannot be a basis for registering an FIR (first information report), Desai said. The state is carrying out its independent investigation and based on that it will come to a conclusion on whether a chargesheet needs to be filed or closure report based on whether or not a cognizable offence is made out, he added.

Desai said at this stage, when an investigation is already underway, it is not permissible for the court to ask about registering an FIR based on the magistrate's inquiry report. The court will continue hearing the matter on March 10. The bench had last week appointed senior advocate Maniula Rao as amicus curiae (friend of the court) to assist it after the deceased accused's parents said they no longer wished to pursue the case. The court had asked Rao to assist the court on several issues including whether an FIR ought to be registered by the state based on the report submitted by the magistrate. The deceased accused was arrested in August 2024 for allegedly sexually assaulting two minor girls inside the toilet of a school in Badlapur. He was an attendant at the school.



Intimate cinema is almost extinct in this sensationseeking age: Mahesh Bhatt

MUMBAI, March 5: Veteran filmmaker Mahesh Bhatt on Tuesday said intimate stories are rare to find in Hindi cinema, especially at a time when the industry is largely focused on sensation-driven content.

At the trailer launch event of filmmaker Vikram Bhatt's new film "Tumko Meri Kasam", the cinema icon praised the director for his decision to explore a deeply personal story about a real person rather than relying on the familiar horror format.

"It is a mystery in itself that, in this industry, redefining and reinventing yourself again and again is not an easy thing to do. To be here for 35 years and to move from the idiom which the market has acknowledged you for which is horror and to come into an intimate space where the heart beats, the soul cries, and to pull out the story from the life of a

living person is a challenge," Mahesh Bhatt told reporters.

"In these times, where intimate cinema is almost extinct... I don't think there are many people who make films like this. So I think in this age and time, had the courage, the audacity to back a story of a man who himself has been audacious," he added.

Starring an ensemble cast of Anupam Kher, Adah Sharma, Ishwak Singh, and Esha Deol, "Tumko Meri Kasam" is loosely based on the life of Dr. Ajay Murdia, the founder of Indira IVF, a chain of fertility clinics.

Vikram Bhatt, known for horror movies such as the "Raaz" franchise, "1920", "Haunted – 3D", and "Shaapit", has directed the film from a script he wrote.

Nayanthara is the latest South cinema personality, after Kamal Haasan, Ajith, and Jayam Ravi, to relinquish a title given to them.



Set during the colonial rule, the historical thriller series delves into the conspiracy and events leading up to Jallianwala Bagh Massacre and Hunter Commission's investigation into the tracedy

In "Waking of a Nation", co-written by Madhvani, Shantanu Srivastava, and Shatrujeet Nath, they are honouring the memories of those who lost their lives, he said.

"We've not shown the massacre, we just show the soldiers coming in. I didn't want to show it, and that was the most sensitive part about the way we approached it. Other filmmakers have shown the massacre. I felt it would be better, as we don't know if there were 400 or 2,000 people, so it would be more dignified not to show it.

"We dedicated this to the people who have lost their lives during the massacre, and we wanted to treat that with the utmost respect and sensitivity," Madhyani, best known for "Aarya" and

"Neerja", told PTI in an interview.

The filmmaker said he has also tried to stay away from the caricaturish portrayal of the British in Hindi cinema

trayal of the British in Hindi cinema.
"Though they've done a villainous thing, they were thinking that they were doing their duty. They are shown

as villains but not in a melodramatic way. The idea was to try and be fair, which is the wrong word to use when I'm talking about the white skin. But to try and be fair to the idea of duty and why people do what they do in the name of duty, there are so many things that you can do."

In crafting "Waking of a Nation", Madhvani said he drew inspiration from acclaimed films that handle historical narratives with nuance, including "The Battle of Algiers", Oliver Stone's "JFK", and Kathryn Bigelow's "Detroit" to evoke a similar sense of authenticity.

"These were the movies that we used as a reference point, but only more for a treatment and more for a documentary way of shooting because that's the way you can represent truth and honesty," the Emmy Award-winning director said.

Madhvani has narrated the story of the massacre through the eyes of four friends: a lawyer, Kantilal Sahni , a journalist named Ali Allahbaksh , an ordinary man, Hari Singh ; and his wife, Poonam .

The show also stars British actors Paul McEwan and Alex Reece, among

Madhvani said the show can be a thriller, a courtroom drama and it also has "conspiracy and crime".

"I'm not a political person. I'm looking at it from the British Raj perspective because I'm troubled by the idea that we are speaking in English and

today we are dressed in Indian attire," Madhvani, who hails from Barsi, a small town near Maharashtra's Solapur region, said.

"I'm troubled by the idea of cultural colonisation that has happened to us, so that's the lens from which I'm looking at it. Eventually, the reason it will reach out to people is because the soul of the story is four friends and their connection," he added.

Madhvani credits his casting director, Abhimanyu Ray, for zeroing in on Raina, Dutta, Singh, and Mehta for the show.

"It's their talent that brought them here. It's because of the auditions and the re-auditions that we decided that they will be able to take the emotional burden of the roles that they are playing. I don't judge it on earlier work. I judge it on what they are capable of in the auditions that they do," he said.

Produced by Ram Madhvani and his wife Madhvani, "Waking of a Nation" is set to premiere on March 7 on Sony LIV.

As the launch date draws near, the director is both excited and nervous.

"When you are taking on something which is this big in India, there are so many pressures about wanting to do justice to them, first of all to the audience, and my entire team, so I am still scared. There is a line in 'Neerja', 'Fear gave her courage'. I don't think there is any harm in being scared as long as you are honest about your fears." (PTI)



"I mean, that's a lot of points," James said afterward, rubbing his beard in wonder. "Obviously, the first thing that comes to mind is where I'm from. Picking up the game when I was a little kid and having a love for the sport, and hoping that someday I'd be able to play at the highest level. I've been able to do that and really enjoy my career. So it's definitely an honor. It's pretty cool to see that."

James already is the top scorer in NBA history in both the regular season and the playoffs. Maintaining a spectacular level of play midway through his record-tying 22nd season, he is pulling away from the other greats of the game: Lakers

With their victory over the Pelicans, the Lakers improved to 11-2

lar-season games, trailing only Robert Parish (1,611) and Abdul-Jabbar (1,560). If he stays healthy and elects to return for a record 23rd season, he will likely surpass Parish next winter.

James has also played in 287 postseason games, the most in NBA history. He became the league's career playoff scoring leader on May 25, 2017, when he surpassed Michael Jordan's total of 5,987 during the Cleveland Cavaliers' Eastern Conference finals game at Boston.

James then became the top scorer in regular-season history on Feb. 7, 2023, when he topped Abdul-Jabbar's record of 38,387 points during the Lakers' game against Oklahoma City.

James' prolific scoring is due in large part to his metronomic consistency. With his performance against the Pelicans, he has scored at least 10 points in 1,278 consecutive games since Jan. 6, 2007 by far the longest such streak in NBA history.

James' player of the month award for February was his 41st, extending his own league record. He is also the oldest player to win the award, surpassing a 37-yearold Karl Malone in November

decade watching the winning score Time to give my racket and bandana a rest: TT stalwart Sharath announces retirement

CHENNAI, March 5: Indian table tennis legend A Sharath Kamal will hang up his racket and the iconic bandana later this month, having staved at the top of his game for more than 22 years and resisting the temptation of lasting another Olympic

cycle at the ripe old age of 42. In his own words, life has come full circle for one of India's finest athletes who will say goodbye to professional table tennis in front of his friends and family in Chennai, where the WTT (World Table Tennis) Star Contender and his swansong will be staged from March 25 to 30.

Sharath's contribution to the game goes beyond the staggering numbers, including seven gold medals at the Commonwealth Games, two path-breaking bronze medals at the Asian Games and five appearances at the Summer Olympics.

Paris last year was easily the highlight for him as an Olympian, having received the honour of carrying India's flag at the opening ceremony.

The results did not go his way in the French capital but considering his fitness and ranking (he remains India's highest ranked player at no. 42), Sharath decided to carry on for another season and take it

Another Commonwealth Games and Asian Games are on the horizon but Sharath has had enough.

"Not saying I am letting it go completely, but this is certainly the end for us on the big tables, in front of the big crowds. Time to give my bandana and racket some rest," he said.

"Grateful beyond words for all the iov. for all the love, for all the pain, for all the lessons, and for all the people this sport has given me."

For the better of the past two decades, Sharath inspired the younger generation to take up the sport before Manika Batra emerged to share that responsibility.

Sharath not only lifted the profile of the sport, he announced the arrival of Indian table tennis on the global stage and made his presence felt against the all-conquering Chinese and other Asian giants including Japan and South Korea.

His booming forehand made his opponents nervous and over time, he continued to evolve and developed an equally lethal backhand. Kamlesh Mehta, an Arjuna awardee

and another fine player to have come out of India, listed out the reason for Sharath's longevity in the game.



"The game has changed so much in the last 20 years. When he started, he was not doing the backhand banana flick. He had to learn that banana flick and strengthen his backhand.

"He was able to make those changes, learn new things and put it in his game. That's the reason he could sustain himself for so long," Mehta told PTI.

As any elite athlete, Sharath had his

share of ups and downs. The hip and hamstring injury he suffered during the 2015 World Championships was a major setback in his career.

"Many people had written him off after that injury but he came back stronger," Some of Indian table tennis' best re-

sults coincided with the twilight of Sharath's career. With Sharath now having the support

of a formidable bench strength, India were able to stun Japan for a bronze medal at the 2018 Asian Games. Fellow Chennai resident G Sathiyan was the architect of that famous win. Another unthinkable happened when

he and Manika teamed up to land a historic mixed doubles bronze in Jakarta. Even Sharath did not see it coming on the highly competitive continental stage. There was no stopping him as he en-

tered his 40s, bullish about his returns at what was going to be his final appearance at the Commonwealth Games.

Ahead of the 2022 edition in Birmingham, he had to work doubly hard to maintain his fitness as his battered and bruised body was not responding to the zeal of a teenager. With an unprecedented three gold medals, he surpassed his own

Even the players ask me how I am able to add a new stroke every time I play them. I don't have a proper answer to that, I can only say it is not easy.

"What I have been able to do at 40 is unbelievable in a very positive way. How am I able to still play like this?" Sharath had wondered after the bull run in Birmingham 2022.

Three years later, he remains a potent force on the pro circuit and would like to say goodbye to competitive table tennis on a high later this month.

Sharath also has a wise head on his shoulders as he planned his retirement well in advance. He is the first Indian to be elected into the International Table Tennis Federation (ITTF) athletes' com-

He is also part of the athletes' body in the Indian Olympic Association (IOA) and in future, he is aiming for a seat on the athletes' commission of the Interna-

tional Olympic Committee. Apart from that, he sees himself as an administrator at the Table Tennis Federation of India, ensuring his presence around the sport. However, the massive void he leaves on court may never be

Smith bids adieu to ODIs after Australia's CT exit

skipper Steve Smith on Wednesday announced his retirement from ODI cricket following his team's four-wicket loss to India in the Champions Trophy semifinal here but the star batter will continue to play Tests and T20 Internationals.

The 35-year-old, who was leading the world champion side in the absence of an injured Pat Cummins, informed his teammates after the match that he would be stepping away from the 50over format with immediate effect.

Reflecting on his decision, Smith said it was the right time to step aside as Australia builds itself for the 2027 ODI World Cup.

"It has been a great ride, and I have loved every minute of it," Smith said. "There have been so many amazing times and wonderful memories. Winning two World Cups was a great highlight along with the many fantastic team-mates who shared the jour-

ney," he added in a media release

shared by Cricket Australia. A key member of Australia's victori-



ous 2015 and 2023 ICC World Cupwinning teams, Smith was named Australia's men's ODI Player of the Year in 2015 and 2021 and earned a place in the ICC men's ODI Team of the Year in 2015. He took over the ODI captaincy in 2015 and, fittingly, led the side one last time in his final match.

"Now is a great opportunity for people to start preparing for the 2027 World Cup so it feels like the right time to make way," he said.

The veteran of 170 ODIs said Test

Ravindra, Williamson centuries power NZ to 362/6 against SA in CT 2nd semifinal

LAHORE, March 5: Centuries from Rachin Ravindra and Kane Williamson powered New Zealand to a big total of 362 for 6 -- the highest in Champions Trophy history -- against South Africa in the second semifinal at the Gaddafi Stadium here on Wednesday.

The duo shared 164 runs for the second wicket to provide the perfect platform for the later batters to blast away in the final overs. New Zealand added 112 runs in the final 10

overs after reaching 250 in 40 overs. Daryl Mitchel (49 off 37 balls), Glenn Phillips (49 not out off 27) and Michael Bracewell (16 off 12) provided the fire power

in the final overs as South African bowlers

wilted on a good batting track. The semifinal will mark the end of the Champions Trophy in Pakistan as the final will now be played in Dubai on March 9 between India and the winners of Wednesday's match.

Opting to bat, New Zealand's left-handed opener Ravindra blasted 108 of 101 balls with 13 fours and one six while stalwart Williamson struck 102 off 94 balls with 10 fours and two sixes.

New Zealand built on a strong opening stand of 48 between Ravindra and Will Young, who scored 21 off 23 balls before he was dismissed by Lungi Ngidi in the eighth over.

After conceding just 32 in his first six overs, Ngidi went for runs in his final overs though he finished with three wickets.

Ravindra scored his second century of this Champions Trophy after his 112 against Bangladesh and fifth hundred in an ICC tournament. He had scored three centuries in the World Cup in India in 2023.



Williamson batted calmly after early jitters to get to his 15th hundred and his fourth against South Africa. He has now scored hundreds in his last three ODIs against the Pro-

Connolly's shot selection irks Ian Healy

SYDNEY, March 5: Former Australian wicketkeeping great Ian Healy has questioned the tactical acumen of Cooper Connolly, saying he was "angry" with the way the opener handled India's pace spearhead Mohammed Shami in the Champions Trophy semifinal in Dubai.

Connolly, a late addition to the Australian squad and a surprise pick to open the batting against Rohit Sharma's side ahead of Jake Fraser-McGurk in the last-four clash on Tuesday, was dismissed for a nine-ball duck by Shami. India defeated Steve Smith's side by four wickets with Virat Kohli's brilliance shining through on a slow wicket to make the

"I got so angry. (Opening partner) Travis Head was gesturing about how slow the wicket was to his partner (in Connolly)," said Healy on SEN Radio. Australia were expecting Connolly to rise to the occasion, but the batter, playing only his fourth ODI, edged it behind the stumps.

"Cooper Connolly just kept swinging. In those conditions, you have to work the ball around into gaps and not swing (for the fences). He faced nine balls for nought. A duck and he played and missed at the first eight and then nicked the ninth," said Healy. Australia were dismissed for 264 in 49.3 overs with India chasing down the target with 11 deliveries to spare.

'Mohammad Shami was the bowler and I was just getting so angry. It was such poor thinking and when you're batting in tough conditions, you have got to work hard. He was swiping away, square on the off-side and just not watching the ball at all." Healy added that the opener wasn't even watching the ball and kept missing the line. Though Smith and Alex Carey scored half-centuries, the momentum in Australia's batting was missing after the setback of losing Connolly early. "There were three and a half hours of hard work (to be had there) and it was just reckless thinking rather than getting the ball on the bat and using your footwork.

"Connolly's footwork was absent, his shot selection was poor and his technique of the shot was poor because he wasn't watching the ball. His head was watching the gap (in the field) where he thought the ball was going to go and he kept missing it all the time," added Healy. (PTI)

You cannot build pressure on Kohli and that's frustrating: Ashton Agar

NEW DELHI, March 5: Batting stalwart Virat Kohli can be a bowler's nightmare when on song and his repertoire of strokes make it nearly impossible to "build pressure on him", said Australian spinner Ashton Agar following another masterclass from the Indian ace in the Champions Trophy semifinal.

Kohli added to his match-winning unbeaten century against Pakistan in the group stage by slamming a fluent 84 against Australia in Dubai to guide India into the final of the marquee tourna-

"It is not the damage that he can do to the fence, it's just the fact that you cannot build pressure on him. So it's really hard to get him out in a sense. You never really feel like you're on top of him unless the ball is really spinning. And you don't get a lot of pitches in one-day cricket like that," left-arm spinner Agar, who has taken 79 wickets across formats for Australia, said on ESPNcricinfo's Match Day.

Kohli's ability to find the gaps and squeezing ones and twos with



ease too drew praise from the Australian cricketer, who said that for a bowler it's really "frustrating".

"That's the frustrating part about bowling to him. He has this fantastic ability to hit your best ball, the top of middle stump, slightly spinning away, he holds the bat's face slightly longer than other batters do, opens it in the last second, and hits it in the cover point gap. He's probably the best in the world at doing that and

he's very difficult to build pressure

Agar added that Kohli was the fulcrum around which the Indian team built the innings to overcome Australia.

"India batted around Virat beautifully. The guys who came in kept pushing the rate and allowed Virat to do his thing, hit the odd boundary and just keep ticking over. I saw a stat that Virat has scored the most singles since the year 2000, which is phenomenal. It was a bit of a masterclass from him and all the batters contributed nicely." Kohli's effort included 56 singles and four twos, indicating his exemplary fitness level. Former India cricketer Sanjay Manjrekar added, the fact that Kohli is able to find the gaps despite five fielders inside the circle is a testa-

ment to his mastery over batting. "Now you have five fielders inside the circle, so it's not easy as it used to be -- like during our times -when you had four fielders. Very rarely has he hit the ball straight to the fielder and hasn't got a run," said Manjrekar. (PTI)

Rejuvenated Virat Kohli ready to conquer new peaks

DUBAI, March 5: Seldom does a Virat Kohli knock in a winning chase leaves one wanting for more. But his 84 that guided India to a semifinal victory over Australia in the Champions Trophy here had that touch of incompleteness to it. A familiar Kohli hundred on Tuesday would have been his 25th three-figure mark while hunting down a target. But the master would not be too displeased about the knock he eventually managed as he ticked many boxes. Here are the two most important of them.

Box No.1: He tamed spinners, an Achilles Heel that haunted him for long, and more recently exploited by England's Adil Rashid and Bangladesh's Rishad Hossain.

Box No.2: The fifty was full of determination to defeat an opponent who had given India and him several heartbreaks in the past. Through it, he, perhaps, was conveying his readiness to battle on for some more time, conquer some more peaks.

But that has not come without its share of hard work. Kohli had to spend an extra two hours at nets to polish his skills ahead of the match against Pakistan after he was dismissed by Hossain against Bangladesh.

Subsequently, he negated Pakistan's Abrar Ahmed, but Adam Zampa is in a different league as a white ball legspinner. The slow Dubai pitch that slows down even more during the second half would have given more zing to Zampa's craft.

Since their first meeting in 2017, Zampa had dismissed Kohli five times in white ball formats, and counterattack has been Kohli's preferred way to nullify the Aussie leg-

Before the Champions Trophy match, Kohli had made 264 runs off 245 balls against him at a strike-rate of 107. But the nature of the pitch here demanded a different approach from Kohli as he ticked off Zampa, taking 23 off 24 balls. He also made 12 runs off nine balls against Tan-

It was not spectacular but effective in a tricky chase of 265, even though he eventually fell to Zampa. But much after the team's job was done.

India head coach Gautam Gambhir appreciated the way Kohli planned his chase. (PTI)
