



## India, China competition should never turn into conflict, says PM Modi



**NEW DELHI, March 16:** De-lizations. "Even in the modern spite past tensions with China, Prime Minister Narendra Modi has favoured dialogue over discord and said differences between India and China were natural but stronger cooperation was in the interests of the two neighbours and

for global stability. In a podcast with Lex Fridman, Modi said India and China were working to restore the conditions along the borders as they were before the clashes along the Line of Actual Control in 2020, the first since 1975 that resulted in deaths of security personnel on both sides. "However, after my recent meeting with President Xi, we have seen a return to normalcy at the border. We are now working to restore conditions to how they were before 2020," Modi said referring to his meeting with Chinese President Xi Jinping in October last year.

"Slowly but surely, trust, enthusiasm, and energy should return. But of course, it will take some time, as there has been a five-year gap," the prime minister said. Modi said cooperation between India and China isn't just beneficial for the two nations, but also essential for global stability and prosperity.

"Since the 21st century is Asia's century, we want India and China to compete in a healthy and natural way. Competition is not a bad thing, but it should

learned from each other," he said. "Together, they have always contributed to the global good in some way. Old records suggest that at one point India and China alone accounted for more than 50 per cent of the world's GDP. That's how massive India's contribution was. And I believe our ties have been extremely strong, with deep cultural connections,

During his over three-hour interaction, the prime minister said there was no real history of conflict between India and China if one looked back over centuries.

"It has always been about learning from each other and understanding one another. At one time, Buddhism had a profound influence in China, and that philosophy originated in India," Modi said. "In the future too our relationship should remain just as strong and continue to grow. Differences are natural. When two neighbouring countries exist, occasional disagreements are bound to happen," he said. Even within a family, not everything is always perfect, he said, adding "but our effort is to ensure that these differences don't turn

into disputes". "That is why we actively work towards dialogue. ## Bodo Accord brought peace to BTR: Shah

Minister Amit Shah on Sunday said that the Congress had made fun of the Bodo Accord but it brought peace and development to the

The youth of Bodoland Territorial Region (BTR) now "carry the tricolour instead of guns", and this has been made possible by the signing of the accord in January 2020, Shah said at the open session of the 57th annual conference of the All Bodo Students' Union (ABSU) at Dotma in Assam's Kokra-

"Peace, development and enthusiasm pre-vailing in BTR have been possible because of ABSU, a signatory of the accord. Had ABSU not taken the initiative, there would have been no accord or peace in the region," he said.

"The Congress may have laughed at us, saying there will be no peace in BTR and this agreement will be a joke but 82 per cent of the clauses of the Bodo Accord have been implemented. In the next two years, there will be 100 per cent implementation under the leadership of Prime Minister Narendra Modi, bringing long-lasting peace in the region," he said.

"According to the terms of the accord, we brought the entire BTR region out of the purview of the Armed Forces Special Powers Act (AFSPA) in 2022," Shah said.

The NDFB, also a signatory to the peace accord, has given up arms to return to the mainstream and both the central and state governments have taken several initiatives



"In the last three years, 4,881 NDFB cadres have surrendered their firearms and ₹ 287 crore has been spent on their rehabilitation, with 90 per cent given by the Narendra Modi government at the Centre," the Union home minister said.

He said the surrendered cadres were also being trained in various skills with the help

of non-governmental organisations. Shah also appreciated Chief Minister Himanta Biswa Sarma's initiative to induct 400 of these youth into the state commando force.

"When the Bodo Accord was signed, there was happiness not only in BTR and Assam but in the entire country," he said.

#### Shah takes stock of implementation of new criminal laws in NE states

GUWAHATI, March 16: Union Home Minister Amit Shah on Sunday took stock of the implementation of three new criminal laws -- BNS, BNSS and BSA -across the northeast (NE) in a review meeting with the chief ministers and DGPs of the states in the region.

As the President's rule is imposed in Manipur, its Governor Ajay Kumar Bhalla took part in the meeting.

"Hon'ble Union Home Minister Shri @AmitShah is currently chairing a conference of Chief Ministers from the North Eastern States in Guwahati on the implementation of the new criminal laws," the Office of Assam CM said in a post on X.

The meeting is being attended by seven CMs of the northeast region, while DGPs of five states are present, except those of Mizoram, Arunachal Pradesh and Ma-

Chief secretaries of several northeastern states are also present in the meeting. Each of the eight states is making pre-

sentations to update the union home minister on the implementation of Bharatiya Nagarik Suraksha Sanhita (BNSS), Bharatiya Nyaya Sanhita (BNS) and Bharatiya Sakshya Adhiniyam (BSA).

"The meeting has begun sometime back. It started with the opening remarks by Union Home Secretary Govind Mohan after the arrival of Shah," an official told

The conference is about reviewing the implementation and the present status of various new provisions related to police, prisons, courts, prosecution and forensics in the Northeastern states, another senior

After his speech, Shah released a book 'New Criminal Laws: Standard Operating Procedures and Rules', prepared by the Assam CID and published by the Assam government, he added.

#### Two arrested with drugs worth ₹24 cr

GUWAHATI, March 16: Two persons were arrested on Sunday with yaba tablets worth around ₹ 24 crore in Assam's Sribhumi district, located along the inter-state border with Mizoram, police said.

On the basis of a tip-off, a truck coming from Mizoram's Champhai district was intercepted at Puwamara bypass, Superintendent of Police Partha Protim Das said.

"On thorough search of the vehicle, police recovered 80,000 yaba tablets from a secret chamber in the truck," he told PTI.

Das said the arrested persons hail from the Cachar district in Barak valley of the state. "We have initiated legal action to find out the forward and backward links in the drug cartel," he said. Another senior officer said the total value of the seized (CONTD. ON PAGE-2)

#### Prohibitory orders imposed in Karbi Anglong amid threats

**DIPHU, March 16:** District Administration of Karbi Anglong has issued Prohibitory Order under Section 163 of Bharatiya Nagarik Suraksha Sanhita (BNSS) to prevent disturbances to public peace and tranquility in the district.

The order comes in response to reports of potential threats from certain organisations and anti-social elements engaging in activities that could disrupt communal harmony and public order.

As per the order from Karbi Anglong district magistrate Nirola Phanchopi on Sunday, any form of obstruction, picketing, or rally, including Mashal processions, in front of offices, public places, or locations of public importance is strictly prohibited.

"The gathering or assembly of five or more persons without prior permission has also been restricted. Additionally, carrying firearms, explosives, or any substances that may pose a threat to public safety is not allowed. The use and throwing of firecrackers

in public places such as roads, bus stations, and railway stations have also been banned to prevent disturbances," the order read further.

It further said that holding public meetings, rallies, processions, or dharnas without the approval of the district magistrate is not permitted. The order also restricts the delivery of inflammatory speeches, including communal, anti-state, or anti-national statements, as well as the display of banners, posters, or wall writings that could incite unrest. "The use of loudspeakers or microphones without prior authorisation is also prohibited," it added.

Given the urgency of the situation, the order has been passed ex-parte and has come into immediate effect. Any violation will result in prosecution as per the provisions of BNSS. However, an exception has been granted to police, paramilitary, and military personnel regarding restrictions on gatherings. The District Administration has urged all citizens to comply with the order and cooperate in maintaining peace and harmony in Karbi An-

#### Cong hits out at govt over air quality report putting India as 5<sup>th</sup> most polluted country

NEW DELHI, March 16: The Congress on Sunday attacked the government after a world air quality report ranked India as the world's fifth most polluted country, and demanded that all "anti-people" environmental law amendments over the past 10 years be rolled back.

In a statement, Congress general secretary (Communications) Jairam Ramesh said the Swiss air quality technology company IQAIR has just released its 2024 World Air Quality Report which finds that India is the world's fifth most polluted country.

The Rajya Sabha MP said in his statement that according to the report, India's population-weighted average concentration of fine particulate matter is 50.6 μg/m3 which is 10 times the WHO's annual guideline level of 5 µg/m3.

He claimed that according to the report, 74 of the world's 100 most polluted cities are in India, and national capital New



Delhi is the second-most polluted city in the world after Brynihat in Meghalaya.

"Among the lesser-known tragedies of the non-biological PM's reign is the rapidly deteriorating air quality nationally and the inattentiveness and policy chaos that has characterised the government's response to it," he said in his statement. Ramesh cited several studies in the past about air pollution-linked fatalities in the country. In early July 2024, he said, a study pub-

lished in the prestigious Lancet journal showed that 7.2 percent of all deaths in India are associated with air pollution which comes about 34,000 deaths each year in just 10 cities. The former environment minister said that around the same time, a study by the Centre for Science and Environment revealed that the government's interventions in pollution control are poorly designed, with the National Clean Air Program (NCAP) largely focused on mitigating road dust rather than industrial, vehicular, and biomass emissions -- the source of PM 2.5 -- that are the leading causes of mortality.

To make matters worse, in the last five years, the Central Pollution Control Board (CPCB) has left more than 75 percent of the Environment Protection Charge (EPC) and Environmental Compensation (EC) funds unspent, he claimed, adding that in total ₹ 665.75 crores have been left unutilised. 'India will co-chair the EWG on counter-terrorism for the first time'

## India to host regional counter-terror conclave this week

NEW DELHI, March 16: India will host a two-day conclave of 10nation ASEAN grouping and some of its dialogue partners beginning Wednesday that will focus on firming up a comprehensive strategy to combat the threat of terrorism and extremism.

The conclave of the experts working group (EWG) on counterterrorism under the framework of ASEAN Defence Ministers' Meeting-Plus (ADMM-Plus) mechanism is also expected to deliberate on the evolving regional security scenario, officials said.

The ADMM-Plus is a platform comprising 10-nation ASEAN (Association of Southeast Asian Nations) and its eight dialogue

partners -- India, China, Australia, Japan, New Zealand, the Republic of Korea, Russia and the US.

The EWG conclave to be held in Delhi will be co-chaired by India and Malaysia.

The defence ministry said delegations from 10 ASEAN members and the bloc's eight dialogue partners along with Timor Leste and ASEAN Secretariat will be participating in the meeting. "India will co-chair the EWG on counter-terrorism for the first time," it said. Defence Secretary Rajesh Kumar Singh will deliver the keynote address at the opening ceremony of the conclave on Wednesday.

It will be the first meeting for activities planned for EWG on counter-terrorism for the ongoing cycle from 2024-2027.

"Discussions will focus on evolving a robust and comprehensive strategy designed to tackle the evolving threat of terrorism and extremism," the ministry said. "The meeting aims to share the onground experience of the defence forces of ASEAN and its dialogue partners. It will lay the foundation for the activities/exercises/seminars/workshop planned for the cycle 2024-2027," it added in a statement. The ADMM-Plus has been focusing on seven areas of practical cooperation such as countering terrorism, maritime security, peacekeeping operations, humanitarian mine action and cyber secu-



rity. EWGs have been established to facilitate cooperation in these areas. The EWGs are each cochaired by one ASEAN member state and one dialogue partner fol-

lowing a three-year cycle. The task of the co-chairs is to lay down the objectives, policy guidelines and directions for the EWG for the three-year cycle. (PTI)

India, New Zealand announce resumption of FTA talks after gap of 10 yrs

NEW DELHI, March 16: After a gap of about ten years, India and New Zealand on Sunday announced resumption of negotiations for a proposed free trade agreement (FTA) to boost economic ties.

India and New Zealand began negotiating the Comprehensive Economic Cooperation Agreement (CECA) in April 2010 to boost trade in goods, services, and investment. However, after ten rounds of discussions, the talks stalled in February 2015.

"The two nations are pleased to announce the launch of negotiations for a comprehensive and mutually beneficial India-New Zealand Free Trade Agreement (FTA) negotiations," the commerce ministry said.

The announcement was made after the meeting of Commerce and Industry Minister Piyush Goyal and Todd McClay, New Zealand's Minister for Trade and Investment

Prime Minister of New Zealand Christopher Luxon is here on a

four-day visit from March 16.
"The India-New Zealand FTA negotiations aim to achieve balanced outcomes that enhance supply chain integration and improve

market access," it said.

"With bilateral trade continuing to grow steadily, surpassing USD 1 billion during April-January 2025, the FTA negotiations aim to unlock new avenues for businesses and consumers, fostering mutual growth and prosperity of our na-

tions," Goyal said in a post on X.

## DVC's ₹1,500 cr push to modernise power supply

KOLKATA, March 16:
Damodar Valley Corporation
(DVC) has launched a ₹ 1,500
crore project to modernise power
supply in its command area to ensure round-the-clock quality power
and to reduce aggregate technical
and commercial (AT&C) losses, an
official said on Sunday. DVC's entire distribution network primarily
serves industries, with negligible
supply to retail consumers.

The project focuses on shifting from conventional power distribution to a state-of-the-art, technology-driven system to establish a robust primary and secondary distribution network across DVC's command area spanning 24.235 square kilometres in West Bengal and Jharkhand. "The project capex is nearly ₹ 1,500 crore and will be completed in 18 months. The system integrates advanced features such as a distribution management system, outage management system, customer relation management, metering data management system, GIS mapping for real-time communication, ring main units (RMU), and fiber opticbased metering communication systems," DVC member (Finance) Arup Sarkar told PTI. The new distribution system incorporates cuttingedge technologies, including unmanned container-based substations (E-houses) equipped with GISbased 33 KV panels, modular battery chargers, and substation automation systems (SAS), he said.

In the first phase, DVC will deploy 12 E-houses, 8 conventional indoor-based 33/11 KV substations, and 4 GIS-based prefab substations. The first E-house was commissioned on January 3, 2025, in Dhanbad, with additional Ehouses in BIADA, Deoli, Giridih, Hazaribagh, and Sindri slated for commissioning by March 2025, Sarkar said. The entire distribution network, including consumer feeders, will be managed through two advanced control centres located in Kalyaneshwari, West Bengal, and Koderama, Jharkhand, DVC said. These centres will ensure hot redundancy and feature a 24X7 customer cell. The new system will enable automatic consumer connection and disconnection based on billing and collection, allowing customers to manage their services seamlessly through a mobile app, eliminating the need for physical interaction, the official said. New Zealand's average import tariff is only 2.3 pet cent, with over half of its tariff lines already duty-free, meaning Indian goods already have substantial access to its market

In contrast, India's average tariff stands at 17.8 per cent, meaning it would have to make significant reductions, making a traditional FTA less attractive for India. "As talks resume, both countries will need to find common ground on these issues to move forward successfully," GTRI Founder Ajay Srivastava said. He said earlier New Zealand was demanding greater access to India's dairy market, which India resisted to protect its domestic dairy industry that supports millions of farmers.

Currently, India's dairy imports from New Zealand are minimal (around USD 0.57 million), and while India may consider limited imports of value-added dairy products, it remains firm against allowing raw dairy imports, he said.

India was also reluctant to lower tariffs on New Zealand's dairy, meat, and wine exports, while New Zealand pushed for mo

favourable trade terms.

"Pressure from the US to open India's dairy and agriculture sectors may also influence negotiations," Srivastava said, adding that another key issue was India's demand for easier movement of its skilled professionals and better access for its IT and services sector.

India wanted New Zealand to grant work opportunities similar to those given to Australia and China, but New Zealand did not agree, according to GTRI. It said earlier the FTA talks got complicated as both countries were part of the negotiations around the Regional Comprehensive Economic Partnership (RCEP), which India eventually withdrew from in 2019 due to certain concerns about market access and protecting local industries.

The bilateral trade between the two countries stood at USD 873.4 million (exports USD 538.33 million and imports USD 335 million) in 2023-24 as against USD 1.02 billion in 2022-23.

India's key goods exports to New Zealand include clothing, fabrics, and home textiles; medicines and medical supplies; refined petrol; agricultural equipment and machinery such as tractors and irrigation tools; auto; iron and steel; paper products; electronics; shrimps; diamonds; and basmati rice. The main imports are agricultural goods, minerals, apples, kiwifruit, meat products such as lamb, mutton, milk albumin, lactose syrup, coking coal, logs and sawn timber, wool, and scrap metals.

In FY24, India's services exports to New Zealand stood at USD 214.1 million, while New Zealand's services exports to India totalled USD 456.5 million. India's key services exports include IT and software services, provided by companies such as Infosys and HCL, along with telecommunications services to support New Zealand's digital infrastructure.

India also exports healthcare services, including medical tourism, pharmaceutical research, and telemedicine. Financial services are another important area, with Indian banks and fintech companies offering digital payment solutions. New Zealand's services exports to India are led by education services, with thousands of Indian students pursuing higher education in New Zealand.

Tourism services are also significant, as Indian tourists are drawn to New Zealand's natural landscapes and adventure activities.

New Zealand provides fintech services, offering digital solutions to India's financial sector, and specialised aviation training programmes for pilots and cabin crew. Additionally, New Zealand

# SAIL to scale up Rourkela Steel Plant capacity to 9 MT by 2030 at ₹ 30,000 cr investment

NEW DELHI, March 16: Stateowned SAIL has plans to more than double the capacity of its Rourkela Steel Plant (RSP) to around 9 million tonne per annum at an investment of ₹ 30,000 crore, a move which will boost supplies to sectors like defence, oil & gas, automobiles among others.

Post expansion, which will come up over an area of 1,200 acre, RSP will alone contribute around 25 per cent to SAIL's overall 35 million tonne per annum (MTPA) production capacity target by 2030, Alok Verma, Director In-Charge, RSP told PTI in an interview. Located at Rourkela in Odisha, around 320 km from state capital Bhubaneswar, RSP holds the distinction of being the first public sector steel plant in India. It was set up in 1950s with German collaboration with an initial capacity of 1 MT.

The plant became operational on February 3, 1959, when the then President of India Rajendra Prasad lit up the first blast furnace Parvati.

At present, the total steelmaking capacity of Steel Authority of India Ltd (SAIL) stands at 20.30 MTPA of which RSP's contribution is 4.4 MTPA.

Speaking further, the official said RSP's capacity will be enhanced by 5 MTPA to 9.4 MTPA by 2030. "With the expansion, we aim to garner a sizeable share of the sectors which we cater to," Verma said adding RSP produces plates, hot rolled (HR) coils, spiral welded and electric resistance welded pipes, cold rolled non-oriented (CRNO) which find applications in areas like ship building, rail wagons, LPG cylinder, automobiles, oil and gas, motors, generators, and transformers.

The plant also has a dedicated mill to manufacture naval grade, armour grade and quenched and tempered plates for various naval and defense applications.

and detense applications.

Sharing the details, Verma said approximately 1,200 acre on the south eastern side of the plant will be required for taking up this mega

green field expansion project to be implemented with an investment of around ₹ 30,000 crore.

As part of expansion the major facilities are planned. It includes raw material handling plant, coke oven stamp charge battery, sinter plant, thin slab caster-direct rolling, cold rolling mill, silicon mill and logistics, he said.

Besides, a new blast furnace and steel melting shop will be set up.

As a prerequisite for this expansion, a railway line connecting Dumertra station to RSP is under construction for smooth movement of raw materials and finished goods to strengthen logistics. It will avoid load on Bondamunda Yard.

The second rail connection work is being executed by South Eastern Railways on cost deposit scheme for which the requisite amount has been deposited to Indian Railways by RSP.

SAIL, under Ministry of Steel, is among the top three steel manufacturers in India. (PTI)

# Indian corporate houses remain positive for hiring persons with disabilities

KOLKATA, March 16: Indian companies are ramping up hiring of persons with disabilities (PwDs), seeing it as both a "social imperative" and a "strategic business advantage" amid growing diversity, equity and inclusion (DEI) commitments, stakeholders said.

Onboarding such people in Indian corporate houses has seen a steady rise, with a 30-40 per cent increase in job postings for inclusive roles over the past three years, they said.

Indian companies, ranging from the steel and mining sectors to the insurance segment are focusing on workplace accessibility to onboard PwDs in their job rolls.

Future Generali India Insurance Company MD and CEO Anup Rau said the insurer has achieved the milestone of one per cent of its workforce comprising of PwDs.

"The commitment to ensuring at least one per cent PwDs of our workforce is rooted in our belief that inclusion is not just a box to tick or a policy to implement it's a responsibility to create a meaningful change," Rau told PTI.

In the last one year, the insurer's PwD workforce has increased from 16 to 41 employees across 16 regional branches, and nearly 22 per cent of the PwD hires are women, he said. "In FY'23 it was stated that only seven of the Nifty 50 companies had over one per cent PwD employees, with four out of them being in the public sector space. This stark reality underscores the urgent need for corporate leadership in champi-

oning inclusion," Rau said. Vedanta Chief Human Resource Officer Madhu Srivastava said the group has taken a slew of steps to enhance workplace accessibility such as ramps and dedicated walkways for easy mobility, braille-enabled elevators to support visually impaired employees and text-tospeech software for better digital accessibility, and ensure a seamless experience for individuals with disabilities.

"Currently, we employ over 50

individuals from the PwD community in front-end roles and continue to expand our efforts in this space. Additionally, we have onboarded interns with disabilities to provide them with hands-on exposure to the dynamic environment of a global natural resources conglomerate like ours," Srivastava told PTI. While the group's core operations in mining and smelting present certain challenges in integrating PwDs into technical roles, it remains "committed to identifying opportunities that pro-

integrating PwDs into technical roles, it remains "committed to identifying opportunities that provide them with meaningful exposure and upskilling," the Vedanta official said. "Embracing workplace diversity, including hiring persons with disabilities, is not just a social imperative it is a strategic business advantage," she said.

Tata Steel spokesperson said the

company employs 100+ PwD employees across functions.

In an emailed response, the spokesperson said, "Over the past

spokesperson said, "Over the past 2-3 years, the number of PwD employees at Tata Steel has steadily increased. We have made significant strides in our hiring practices and have actively sought to create a more inclusive environment."

The steelmaker's official also said including people with disabilities in the workforce strengthens

businesses by fostering diverse perspectives and boosting creativity and impossing

ity and innovation.

With environmental, social and governance-focused hiring and government incentives like tax benefits for PWD employment, the share of such employees in the formal workforce is expected to double by 2030, human resources investment platform First Meridian Global Services and Innovsource CEO Manmeet Singh said.

Large corporations and startups alike are "prioritising diversity, especially in sectors like IT, retail, and BFSI, where remote and hybrid work models enable greater participation," Singh told PTI.

"Despite reports that India has over 7 crore persons with disabilities (PWDs), and their employability rate remains at just 0.4 per cent, hiring of PWDs in India has seen a steady rise, with a 30-40 per cent increase in job postings for inclusive roles over the past three years," he said. Stronger regulatory mandates along with diversity, equity, and inclusion commitments by corporate houses, are driving PWD hiring, he said. Atlantabased Global technology & digital talent solutions provider NLB Services CEO Sachin Alug said integrating persons with disability, although a focus area, is gaining momentum slowly in India Inc.

"Today, culture plays a major role in determining the brand identity of a company and how it is perceived by partners, customers, employees and the entire business ecosystem. In order to build a diversity-oriented culture, businesses are striving to employ a diverse workforce," Alug told PTI. (PTI)

# Lenders transfer ₹ 1,104cr McLeod Russel debt at discount with 5-yr repayment tenure

KOLKATA, March 16: A consortium of lenders to bulk tea producer McLeod Russel India Limited (MRIL) has transferred its debt exposure to the National Asset Reconstruction Company Limited (NARCL) for ₹ 700 crore, representing a 36 per cent haircut, sources said on Sunday.

The debt of ₹ 1,104.69 crore has been sold under a 15:85 cash-to-security receipts (SR) structure, with 15 per cent of the consideration to be paid upfront and the remaining 85 per cent through SRs over the next five years, they said.

The Swiss challenge auction for the debt transfer of the base value of ₹ 700 crore received no counterbids against NARCL's offer due to extremely poor sentiments about the tea sector, a merchant banker official involved in the transaction said.

The ₹ 700 crore debt deal is seen as significantly lower than a previously attempted one-time settlement (OTS) of ₹ 1,030 crore backed by Carbon Resources, which lapsed due to a lack of consensus among lenders. McLeod officials stated that the development is a positive step that will allow the company to negotiate with only three debtors NARCL, JC Flowers ARC, and IndusInd Bank rather than a dozen banks.

"We are not out of the woods, but this will help the company get time to turn around and avoid a distress sale of assets," a company official said, declining to be quoted due to the sensitivity of the matter.

As of June 30, 2024, McLeod Russel had total outstanding dues of ₹ 1,461.06 crore, including debt assigned to another private asset reconstruction company and Indusind Bank which are not part of this transaction.

NARCL is expected to work closely with the existing management to restructure the company. However, no immediate comments were available.

Based on financial due diligence, the lenders anticipated an additional net recovery of approximately ₹ 270 crore upon full redemption of the SRs.

McLeod had informed the bourses that NARCL had taken over the loans of ICICI Bank-led consortium which had State Bank of India, HDFC Bank Limited, Axis Bank Limited, Punjab National Bank, UCO Bank, Indian Bank, and RBL Bank.

ICICI Bank officials declined to speak on the details. The company's loans were classified as non-performing assets (NPAs) in October 2019 due to financial stress arising from a prolonged downturn in tea prices, rising costs, and unrecovered loans extended to group entities, notably McNally Bharat Engineering Co Ltd, which is undergoing insolvency proceedings. McLeod Russel, promoted by the Khaitan family, operates 31 tea estates in Assam and two in West Bengal, with a saleable production of 39.19 million kg in FY24 and a workforce exceeding 50,000 mysleves.

# India should seek reciprocity from EU on medical devices under FTA: GTRI

NEW DELHI, March 16: India should seek reciprocal concessions from the European Union (EU) under the proposed free trade agreement (FTA) in the medical devices sector to promote its exports, economic think tank GTRI

said on Sunday. India charges zero to 10 per cent tariffs on most medical devices and a duty cut by India on medical devices without addressing EUs regulatory challenges will result in low exports but large scale imports from EU. "To achieve a fair trade deal, India must demand reciprocity. India should cut tariff on medical devices only if the EU reduces its non-tariff barriers," the Global Trade Research Initiative (GTRI) said. The ongoing India-EU FTA negotiations on medical devices are asymmetrical.

While the EU demands zero tariffs on medical devices from India, it maintains high regulatory barriers that hinder Indian exports difficult in the EU markets, it added.

GTRI Founder Ajay Srivastava said the EU customs duty rates are zero, but market entry costs are substantial because of the stringent regulatory framework.

"Exporting to EU has become

more difficult as it replaced the Medical Device Directives (EU-MDD) with the more stringent Medical Device Rules (EU-MDR)," he said.

Citing an example, he said the new certification and regulatory expenses amount to 60,000-300,000 euro annually for market access of 100,000-3.75 million euro. "Certification approval time

months to 2-3 years now. Shortage of notified bodies and auditors in the EU is leading to high certification costs," Srivastava said.

On account of this, Indian exporters are withdrawing from the EU market or limiting product offerings as high entry and certification costs make market participation financially unsustainable, he noted.

Moreover, he said the lack of Indian participation in the Medical Device Single Audit Program (MDSAP) limits the acceptance of Indian devices in key regulated markets. MDSAP allows medical device manufacturers to be audited only once for compliance with regulatory requirements in multiple markets, including Australia, Brazil, Canada, Japan, and the United States. It was the late prime minister Atal Behari Vajpayee who included the Bodo language in the Eighth Schedule of the Constitution, Shah said.

Sixty villages of Sonitpur and Biswanath districts have also been included in BTR to ensure their development and progress, he added. ABSU is taking forward the education and empowerment of youth and it is due to their efforts that students till class 12 are appearing in examinations in the Bodo medium. Products from Kokrajhar and other districts of BTR under the 'One District, One Product' initiative are now being displayed at hotels in New Delhi and this has been possible due to peace in the region, he said.

More than 12 products from BTR have already got GI tag and this has led to the growth of an industrial environment, Shah said. Shah said he was honoured to address the ABSU convention and thanked all ABSU members for inviting him to it.

"I also pay my obeisance to the 5,000 martyrs who had laid their lives for the cause of the Bodoland, paying the way for peace in BTR," he said. "Investments of over Rs 5 lakh crore are lined up for Assam following the recent business summit in the state. I urge the youth to move ahead by educating themselves and establishing permanent peace... the future is ready for you," he said.

The government is going to ensure infrastructure development in BTR which will help the youth compete with those in the rest of the country, Shah added. The Union home minister recalled that a few years ago, he was invited to the Bathou Puja of the Bodos and was gifted some books on the religion.

## Cong hits out at govt over air On 29th July 2024, he said, upon being asked a question about the Lancet study, the Ministry of Environment,

Forests, and Climate Change made the "shocking" claim in Rajya Sabha that there was "no conclusive data" to directly correlate air pollution and deaths. He further claimed that in August 2024, a study by the Mumbai-based International Institute of Population Sciences used government data from the National Family and Health Survey (NFHS V) to unravel the worst kept secret in India: that air pollution is costing thousands of Indians their lives and health.

"In districts where air pollution exceeds National Ambient Air Quality Standards (NAAQS), there is a 13 percent increase in premature mortality for adults and around 100 percent increase in mortality for children," he also claimed.

"This Government's Modus Operandi is to deny that there is a real air pollution-linked mortality problem, underfund programmes targeted at mitigating pollution, fail to utilise the resources that it allocates, and misuse the funds that do get spent," Ramesh said. The Congress leader spelt out some steps the government must take moving forward.

"The first step must be to acknowledge the public health crisis linked to air pollution across wide swathes of India. Consequently, given this crisis, we must revisit and totally revamp both the Air Pollution (Control and Prevention) Act of 1981 and the National Ambient Air Quality Standards (NAAQS) put into effect in November 2009. As per the NAAQS, the permissible concentration of fine particulate matter is 60  $\mu$ g/m3 for a 24-hour period, and 40  $\mu$ g/m3 annually - versus the guidelines of less than 15  $\mu$ g/m3 for a 24-hour period and 5  $\mu$ g/m3 annually set by the WHO," he said.

Ramesh suggested the government must drastically increase the funds made available under the NCAP. The current budget, inclusive of NCAP funding and the 15th Finance Commission's grants, is about ₹ 10,500 crores, spread across 131 cities, he said. "Our cities need at least 10-20 times more funding - NCAP must be made a ₹ 25,000 crore programme. "The NCAP must adopt measurement of PM 2.5 levels as the yardstick for performance. NCAP must reorient its focus to key sources of emissions - burning of solid fuels, vehicular emissions, and industrial emissions." he said.

The former environment minister also suggested that the NCAP must adopt a regional/airshed approach for air quality control, municipal and state authorities must have the governance architecture and resources required to collaborate across jurisdictions.

The NCAP must be given legal backing, an enforcement mechanism, and serious data monitoring capacity for every Indian city, beyond the current focus only on "non-attainment" cities, he said.

Ramesh also said that Air pollution norms for coal power plants must be enforced immediately and all power plants must install a Fluoride Gas Desulfurizer (FGD) by the end of 2025. "The National Green Tribunal's independence must be restored, and the anti-people environmental law amendments of the last 10 years must be rolled back," he said. (PTI)

#### IMF's recommendations

There is a pressing need to create quality jobs for India's growing population, and advancing difficult factor and product market reforms, complemented by continuing efforts to streamline regulations and address skill mismatches could reinvigorate private investment and increase formal employment, says International Monetary Fund (IMF). In the recent Staff report for Article IV Consultation, it has pointed out the aberrations that has cropped in the labour market. It says much of the increase in the labour force participation rate (LFPR) has been driven by own-account and unpaid family workers. An observed increase in agricultural employment since COVID-19 period diverges from traditional development paths, whereby workers tend to relocate from agriculture to industry and service, and India's own historical experience. There is high degree of informality in the job market. On structural reforms, IMF not only recommends a holistic horizontal reforms, which it says needed to stimulate private investment, raise potential growth, and create quality iobs, but also notes India's ambition of becoming an advanced economy by 2047 that requires a significant and sustained rise in potential growth. In this backdrop, one of its recommendations was that India's near-term priorities should include implementation of the labour codes.

Steadfast implementation of the new labour codes, which require cooperation between Centre and states, is needed to enhance labour market flexibility and ease constraints keeping firms inefficiently small, while providing adequate social protection for workers. Advancing labour market reforms, including relaxing hiring and firing regulations, could generate an additional 44 million jobs by 2029/30, the report says. During the consultation Indian officials highlighted ongoing work with states to notify the new labour codes in the period ahead. More flexible and targeted social safety nets facilitated by the use of technology can help support structural transformation and facilitate migration of workers from rural to urban areas, for example, through greater inter-state portability of benefits such as the "One Nation, One Ration Card". Recent policy initiatives to enhance female labour force participation are welcome. Building on existing reforms to improve workplace safety, support female entrepreneurship, and improve access to childcare, priorities should include removing obstacles to female employment, ensuring that women can participate safely in the labour force, and further expanding support for childcare facilities. These reforms would help reduce inequality by creating more and

Improving the quality of education, fostering skill development, and ensuring adequate health and nutrition are critical for building dynamic labour force in future, the report says. Raising human capital accumulation is essential for unlocking potential growth and fully harnessing India's demographic dividend. Rapid advancements in AI are likely to transform the labour market, underscoring the need to continue improving the quality of education, health and nutrition, and skill development. While India's education spending as a share of GDP is on par with peers, spending quality needs to improve through enhanced teacher training, further leveraging of technology to monitor teacher and student attendance and performance, continued promotion of early childhood development, and regular classroom observations to provide feedback and support to teachers.

# US aid suspension triggers economic crisis in Mena and South Asia

ident Donald Trump issued an executive order suspending all USAID and State Departmentfunded projects, totalling \$60 billion, for 90 days. This decision was framed as a reassessment of foreign aid effectiveness and its alignment with the administration's strategic priorities. The abrupt termination of nearly 10,000 foreign aid grants and contracts has sent economic and humanitarian shockwaves through countries in the Middle East, North Africa (MENA), and South Asia, raising concerns over regional stability, economic sustainability, and geopolitical re-

The US has historically been a major financial backer of many MENA nations, offering aid to bolster fragile economies, reinforce security frameworks, and support humanitarian projects. In 2023 alone, Jordan and Egypt were among the top beneficiaries, receiving \$1.6 billion and \$1.5 billion, respectively. With this aid now suspended, these nations are scram-

bling to secure alternative economic

partnerships.

Jordan, one of the region's most politically stable nations, relies heavily on US assistance to sustain its economy and support its 1.3 million Syrian refugees. American aid has been crucial in funding healthcare, education, and employment initiatives. The aid suspension places these programs at risk, forcing Amman to seek emergency funding from Gulf

nations and international lenders. Egypt, a long-time recipient of substantial US military and economic assistance, faces economic

uncertainty due to the aid cuts. American funds have been instrumental in maintaining Egypt's defence capabilities and financing infrastructure projects. With US support in limbo, Cairo is turning to China and the Gulf states to bridge the financial gap. However, Gulf nations, already contending with their own economic challenges, may not provide indefinite assistance, leaving Egypt in a precarious position.

Lebanon has been hit hard by the aid cuts, with UNICEF forced to scale back crucial programs amid an escalating food crisis. Over half of children under two years old in eastern Lebanon are now facing severe food insecurity. In Sudan, where conflicts have displaced millions, at least two million people have lost access to life-saving assistance due to the abrupt funding halt.

South Asian nations, already grappling with economic hardships and humanitarian challenges, are struggling to maintain essential services following the aid suspension. Countries such as Bangladesh, Pakistan, and Nepal, which have relied on US funding for healthcare, education, and economic development, are among the hardest hit.

In 2023, Bangladesh received \$490 million in US aid, much of which was allocated to healthcare and refugee support, particularly for the Rohingya population in Cox's Bazar. The suspension has forced the International Centre for Diarrhoeal Disease Research. Bangladesh to lay off over 1,000 employees, while over 300 non-profits reliant on USAID funding have ceased operations, leaving thousands unemployed. #### Anti-US German mood helps Chancellor Designate Frederick Merz to consolidate

rmany, the strongest economy of Europe Tand the nation facing big onslaught from the United States President Donald Trump in his second term, is finally getting back its mojo to carve out a strong independent position distancing from its longtime ally the U.S. Despite the spectacular victory of the far right pro-Trump AFD in the recent national elections, the political mood in Berlin is aligned against far right and Trump helping the chancellor designate Frederick Merz of the CDU/CSU to consolidate his position as the head of a strong nation caring for its sovereignty and national interests.

The agreement reached by Merz with the Green Party on Friday March14 for his ambitious programme to hike the defence spending and infrastructure in the context of the threat from the U.S. president that the transatlantic ally will cut off its assistance to its European ally as per the MAGA programme of Trumpisa majorstep... Already Merz has reached with understanding with the Social Democratic Party (SPD) on the formation of the coalition government and the details of the budget. Now the agreement with the Greens will help the new coalition head to pass the budget with a big majority in the new Bundestag which will be meet-

This welcome development for the German politics has been possible due to Europe's running battle with the U.S. president Donald Trump in which lor designate Merz was also personally attacked by the MAGA leaders in USA. Now Merz seems to have decided to opt for a make Germany strong policy by proposing to present a enhanced budget which will help the economy to be stronger and meet the challenges of the present ailments faced by the industries. Merz said after the agreement with Greens "Germany is making its large contribution to the defence of freedom and peace in Eu-

rope. Germany is back" In the February 23 national elections, out of the total of 630 seats in Bundestag, the centre-right CDU/CSU got 208 seats as against the far right AFD's 151 which doubled its voting percentage to 20.7 per cent this time as against the earlier elections. The SPD got 121 seats, the greens 85, the left wing De Linke 64 and the others only one. The CDU/CSU led by Frederick Merz has already reached an understanding with SPD for government formation. This gives them a clear majority of a total of 329 seats as against the required majority of 316 seats in Bundestag. But still the understanding with the Greens will make the total 414. The far right FD with 151 seats and the Left with 64 seats are expected to oppose the new coalition govern-

ment from their own perspective. In Europe, the major countries are having coalition governments. The budgetary policies emerge as big issues between the parties inside the coalition. This is true for other countries like France,



the agreement of the new German coalition on the coming budget with the support of nearly two-third is a personal victory of the Chancellor designate Merz and his political skill in negotiations.

Greens were earlier opposed to the contents of the new budget proposals but after prolonged negotiations, their leaders finally agreed when Merz explained how this package was the answer of Germany to the Trump's rantings against the U.S.'s European allies. He explained to the Greens that the hike in defence spending was needed to be independent of the U.S. at the present stage of Trump's unilateral actions globally.

Both De Linke and BSW will be working to improve their respective support base as the new coalition starts functioning. A mood of optimism is back in Germany. 

There still will not be a shred of evidence pre-

sented by Pak Army, or the Pakistani media, which has been comatose since March 11. If it was the Indian media, 'Bolan' in Balochistan would have been prominently displayed on the 'Atlas', overrun and trampled out of existence and belief, all the evidence destroyed, but at least the media wouldn't be sitting, waiting to be spoon-fed with half-truths and non-truths.

Finally, one shred of evidence of Pakistan under untold stress and a lot of consternation: Pakistan Defence Minister KhawajaAsif has started the blame-game in earnest, "assailing" jailed former Prime Minister Imran Khan's PTI of "politicising" the hijacking of the Jaffar Express and "misinter preting" the situation on Social Media.

But KhawajaAsif did hint that things weren't hunky-dory in Pakistan. "Passengers were sepa-rated based on the provinces they belonged to and people hailing from Pakistani Punjab were identified and targeted." He didn't answer the question, "Why?" What makes the rest of Pakistan hate Pakistan's Punjab and Pakistani Punjabis?

### Is toothpaste killing all the good bacteria in our mouth?

The goal of brushing one's teeth is to have fresh breath and prevent cavities. But the effect of toothpaste on the complex ecosystem of bacteria in our mouths – the oral microbiome – is often overlooked.

Recent research has highlighted just how crucial the oral microbiome is for our overall health. A well-balanced microbiome helps regulate harmful bacteria, aids digestion and protects the gums. But does toothpaste support this balance, or could it be disrupting it? And could the toothpaste of the future be designed to work with the oral microbiome rather than against it?

The mouth is one of the most densely populated microbial habitats in the body, home to more than 700 species of bacteria. These bacteria inhabit not only the surfaces of the teeth and gums in biofilm – a sticky, structured community that can be both beneficial and harmful – but also thrive in our saliva, contributing to the dynamic oral microbiome.

A healthy microbiome includes bacteria that help regulate pH levels (a measure of how acidic or alkaline a substance is), break down food and even produce natural antimicrobial compounds. But when the balance is disrupted - often due to diet, poor oral hygiene or certain medical conditions - harmful bacteria can take over. This imbalance, known as dysbiosis, is linked to tooth decay and gum disease.

What does toothpaste actually do? The main function of toothpaste isn't to kill bacteria outright but to disrupt the biofilm that allows harmful bacteria to thrive. Brushing mechanically removes this

biofilm from teeth and gums, while abrasives in toothpaste help break it up further.

Many toothpastes also contain fluoride, which strengthens tooth enamel and helps prevent cavities. Interestingly, fluoride itself doesn't kill bacteria, but it makes it harder for acid-producing bacteria like Streptococcus mutans, a key player in tooth decay, to cause damage

Some toothpastes include antibacterial agents, such as triclosan (now banned in some countries due to safety concerns) or newer alternatives like stannous fluoride and zinc compounds. These ingredients target harmful bacteria, but there's still debate about whether they also disrupt beneficial microbes in the process.

Despite toothpaste being a daily staple, research into its effects on the oral microbiome is still evolving. Some studies suggest that certain antibacterial agents reduce both harmful and beneficial bacteria, potentially changing the microbiome in ways we don't vet fully understand. Others indicate that the microbiome recovers quite quickly after brushing, making any disruption temporary.

Scientists are now exploring whether future toothpaste formulations could take a more targeted approach, reducing harmful bacteria while preserving beneficial species. Some emerging research looks at probiotics and prebiotics - ingredients that could actively support a healthier oral microbiome rather than simply disrupting it.

Keeping the oral microbiome in balance isn't just about avoiding cavities. There's growing evidence linking gum disease to heart disease, diabetes and harms during pregnancy. Inflammation triggered by harmful oral bacteria can spread beyond the mouth, potentially contributing to long-term health problems.

Brushing with fluoride toothpaste twice a day and cleaning between the teeth helps reduce the bacterial load in the mouth, lowering the risk of both oral and systemic diseases.

Microbiome-friendly toothpaste

As our understanding of the oral microbiome grows, toothpaste may evolve to become more selective in its action. Instead of broad-spectrum antibacterial agents, future formulations might include ingredients that support beneficial bacteria while keeping harmful species in check.

Some promising candidates include arginine, a naturally occurring amino acid that promotes the growth of beneficial bacteria, and plant-derived antimicrobials that disrupt harmful biofilms without killing good bacteria. However, research in this area is still in its early stages, and more evidence is needed to determine the long-term effects of these ingredients.

Toothpaste plays a key role in oral health by breaking up bacterial biofilm, reducing the risk of tooth decay and gum disease. While some ingredients may affect the oral microbiome, research suggests that brushing and flossing remain the most effective ways to maintain a healthy mouth.

Future toothpaste innovations may shift towards microbiome-friendly formulations but, for now, the best advice remains the same: brush twice a day with fluoride toothpaste, spit out the excess and clean between your teeth daily. (Courtesy: Scroll.in)

#### Many gluten-free foods are high in calories and sugar, low on fiber and protein, and they cost more — new research

nited States consumers often pay more for gluten-free products, yet these items typically provide less protein and more sugar and calories compared with gluten-containing alternatives. That is the key finding of my new study, published in the journal Plant Foods for Human Nutrition.

This study compared gluten-free products with their glutencontaining counterparts and the findings suggested that many perceived benefits of gluten-free products — such as weight control and diabetes management — are exaggerated.

Currently, many gluten-free products lack dietary fiber, protein and essential nutrients. Manufacturers often add supplements to compensate, but the incorporation of dietary fibers during processing can hinder protein digestion.

In addition, gluten-free products generally contain higher sugar levels compared with other products containing gluten. Long-term adherence to a gluten-free diet has been associated with increased body mass index, or BMI and nutritional deficiencies. Gluten-free products — defined in the U.S. as those that contain less than or equal to 20 parts per million of gluten - largely lack wheat, rye, barley and sometimes oats, all rich sources of arabinoxylan, a crucial nonstarch polysaccharide. Arabinoxylan provides several health benefits, including promoting beneficial gut bacteria, enhancing digestion, regulating

blood sugar levels and supporting a balanced gut microbiota. Our study also pointed out that it is difficult to find a glutenfree product that excels in all nutritional areas, such as high protein and fiber content with low carbohydrates and sugar. On the other hand, gluten-free seeded bread contains significantly more fiber — 38.24 grams per 100 grams — than its

gluten-containing counterparts. This is likely due to efforts by manufacturers to address fiber deficiencies by using ingredients such as pseudo-cereals, such as amaranth and quinoa hydrocolloids — meaning water-soluble macromolecules used in gluten-free baked goods made with quinoa flour. These improvements, however, vary by manufacturer and re-

gion. For example, gluten-free products in Spain tend to have lower fiber content than their gluten-containing counterparts.

The term "gluten-free diet" has become a buzzword, much like "organic," and is now a part of everyday life for many people, often without a full understanding of its actual benefits. While a gluten-free diet is a medical necessity for people who are sensitive to gluten, a condition called celiac disease, or for those with wheat allergies, others adopt a gluten-free diet due to perceived health benefits or because it's a trend.

In 2024, the global gluten-free product market was valued at US\$7.28 billion and projected to reach \$13.81 billion by 2032. The U.S. market share is estimated to be \$5.9 billion — a little less than half of the global figure.

Approximately 25 per cent of the U.S. population consumes gluten-free products. This figure is far higher than the the roughly 6 per cent of people with non-celiac wheat sensitivity, 1 per cent of people with celiac disease and even lower percentages of people with wheat allergies.

This suggests that many people adopt gluten-free diets for reasons other than medical necessity, which may not offer health or financial benefits.

Symptoms of celiac disease and gluten intolerance include stomach pain and bloating.

What's next

Investment in research and development is essential to create more nutritionally balanced gluten-free products using locally available ingredients. This will require human feeding trials with different formulations of gluten-free products to ensure that these products meet nutritional needs without adverse ef-

Collaborations between governments could help secure subsidies, which would reduce production costs and make these products more affordable. Although the initial costs of research and maintaining a gluten-free production line are high, using local ingredients and financial incentives can make these products more cost-competitive compared with their gluten-containing counterparts.

## Conceiving amid Smog: Impact of pollution on IVF success

s pollution levels surge across North India, the detrimental effects of poor air quality extend far beyond respiratory illnesses. Increasing evidence reveals a concerning link between pollution and reproductive health, particularly in the success rates of in vitro fertilization (IVF) treatments. For couples struggling with infertility, pollution represents an often-overlooked factor that could significantly impact their journey toward parenthood.

#### **Connection Between Pollution** and Fertility

Air pollution, laden with fine particulate matter, heavy metals, and other toxins, is known to affect overall health. Its influence on reproductive health is now a focus of scientific research.

Pollutants like nitrogen dioxide, and sulphur dioxide can disrupt hormonal balance, oxidative stress levels, and inflammation in the body, factors that play a crucial role in fertility.

For men, exposure to polluted air has been associated with lower sperm count, reduced motility, and an increase in abnormal sperm morphology. For women, pollution can impair ovarian reserve, disrupt menstrual cycles, and adversely affect egg quality. These challenges compound the difficulty for couples undergoing IVF, where both egg and sperm quality are critical for successful out-

**Impact on IVF Success Rates** Studies have highlighted that individuals exposed to higher levels of air pollution are at a greater risk of poor IVF outcomes. Pollutants can negatively influence embryo quality, implantation success, and pregnancy rates.

One study reported that women exposed to elevated levels of fine particulate matter during ovarian stimulation had fewer mature eggs retrieved during the IVF process.

Additionally, pollution-induced oxidative stress can lead to increased DNA damage in reproductive cells. This not only reduces the likelihood of conception but may also elevate the risk of miscarriage and complications during

#### pregnancy. Pollution Crisis and Reproductive Health

North India is facing alarming pollution levels, with the region frequently enveloped in hazardous smog during the winter months. Cities like Delhi, Gurugram, and Lucknow report air quality indices (AQI) that often exceed safe limits by several folds.

This environmental crisis am-

plifies health risks, including those related to fertility. For couples seeking IVF treat-

ment, the toxic air quality may pose an added hurdle. Prolonged exposure to polluted air could affect both partners, diminishing the effectiveness of fertility treatments and adding to the emotional and financial strain of the process.

Protective Measures for Reproductive Health

While systemic solutions are essential to combat pollution, individuals can reduce its impact by using air purifiers, limiting outdoor exposure on high-pollution days, maintaining an antioxidantrich diet to counter oxidative stress, and consulting fertility specialists to address potential risks

during IVF. As the air quality crisis continues to escalate, its implications for reproductive health and IVF outcomes cannot be ignored. Addressing this issue requires both immediate individual precautions and long-term policy interventions. For hopeful parents navigating the challenges of infertility, understanding and mitigating the impact of pollution could be a vital step in achieving their dream of parenthood. nightclub fire killed 51 people early Sunday in North Macedonia's eastern town of Kocani, and injured more than 100, interior minister Panche Toshkovski told a press conference.

The blaze broke out around 2:35 a.m. during a concert by a local pop group at the Pulse nighclub, according to Toshkovski. He said pyrotechnics caused the roof to catch fire. Videos showed chaos inside the club, with young people running through the smoke as the musicians urged people to escape as quickly as possible.

Officials said the injured have been taken to hospitals around the country, including the capital, Skopje, many with severe burns. The effort was being assisted by multiple volunteer organisations. Health Minister Arben Taravari

said 118 people have been hospitalised, adding that he had received offers of assistance from neighbouring countries.

#### Five security personnel killed in terror attack in Balochistan

KARACHI, March 16: At least five security personnel were killed and more than a dozen injured in a terrorist attack in Pakistan's restive Balochistan province on Sunday.

A suicide attacker rammed an explosive-laden vehicle into a convoy of paramilitary Frontier Corp (FC) on the national highway in the Noshki area of the province.

No group has claimed any responsibility for the attack yet. Confirming the attack, the police

chief of the local Noshki police station Zafarullah Sumalani said that the initial investigations suggested that it was a suicide attack. "The death toll may rise," he said.

Sumalani also said that evidence from the site of the attack suggested that a suicide attacker rammed an explosive-laden vehicle into the FC convoy.

Meanwhile, security forces have cordoned off the blast site, and investigations are underway to determine the cause and those responsible for the attack.

Balochistan Chief Minister Sarfraz Bugti condemned the attack and expressed sorrow over the loss of life. "Those who play with the peace of Balochistan would be brought to a tragic end," Bugti said in an official release. Balochistan government spokesperson Shahid Rind also condemned the attack

"targeting innocents." Earlier last week, in the same province, the Balochistan Liberation Army (BLA) militants ambushed the Jaffar Express, carrying 440 passengers, near the mountainous terrain of Gudalar and Piru Kunri on March 11. The militants killed 21 passengers and four paramilitary soldiers before the Army eliminated all 33 terrorists on March 12. (PTI)

### US prepares to deport about 300 alleged gang members to El Salvador

WASHINGTON, March 16: President Donald Trump's administration will pay El Salvador USD 6 million to imprison for one year about 300 alleged members of the Venezuelan Tren de Aragua gang, in one of the first instances of the Central American country taking migrants from the United States.

The agreement follows discussions between El Salvador's President, Nayib Bukele, and Secretary of State Marco Rubio about housing migrants in El Salvador's notorious prison. Bukele's government has arrested more than 84,000 people, sometimes without due process, since 2022 as part of his crackdown on gang violence in the small country. It came as the American Civil Liberties Union and Democracy Forward preemptively sued Trump late Friday in federal court in Washington, DC, saying five Venezuelan men being held at an immigration detention centre in Raymondville, Texas, were at "imminent risk of removal" under the Alien Enemies Act.

The agreement may have been put on hold, however. US District Judge James E. Boasberg on Saturday blocked anyone from being deunder proclamation for two weeks and scheduled a Friday hearing to consider arguments. ACLU attorney Lee Gelernt said two flights Saturday may have carried people deported under Trump's proclamation, one to El Salvador and one possibly to Honduras. (AP)

### Iran denies aiding Yemen's Houthi rebels after US strikes, threat from Trump

**CAIRO, March 16:** Iran on Sunday once again denied aiding Yemen's Houthi rebels after the United States launched a wave of airstrikes against them and President Donald Trump warned that Tehran would be held "fully accountable" for their actions.

The Houthi-run Health Ministry said the strikes killed at least 31 people, including women and children, and wounded over 100.

The rebels said one strike hit two homes in northern Saada province, killing four children and a woman. The rebel-run Al-Masirah TV showed images of what it said were the bodies. The Houthis have repeatedly targeted international shipping in the Red Sea and launched missiles and drones at Israel in what the rebels said were acts of solidarity with the Palestinians in the Gaza Strip, where Israel has been at war with Hamas, another Iranian ally.

The attacks stopped when a fragile Israel-Hamas ceasefire took hold in Gaza in January, but the Houthis had threatened to renew them after Israel cut off the flow of humanitarian aid to Gaza this month.

The US and others have long accused Iran of providing military aid to the Houthis and the US Navy has seized Iranian-made missile parts and other weaponry it said were bound for the militant group, which controls Yemen's capital, Sanaa, and the coun-

President Donald Trump said he ordered a series of airstrikes on the Houthiheld areas in Yemen on Saturday, promising to use "overwhelming lethal force" until Iranian-backed Houthi rebels cease their attacks on shipping along a vital maritime corridor. The Houthis said at least 18 civilians were killed. "Our brave Warfighters are right now carrying out aerial attacks on the terrorists' bases, leaders, and missile defences to protect American shipping, air, and naval assets, and to restore Navigational Freedom," Trump said in a social media post. "No terrorist force will stop American commercial and naval vessels from freely sailing the Waterways of the World."

He also warned Iran to stop supporting the rebel group, promising to hold the country "fully accountable" for the actions of its proxy. It comes two weeks after the US leader sent a letter to Iranian leaders offering a path to restarting bilateral talks between the countries on Iran's advancing nuclear programme.

Trump has said he will not allow it to become operational.

The Houthis reported explosions in their territory Saturday evening, in the capital of Sanaa and the northern province of Saada, the rebels' stronghold on the border with Saudi Arabia, with more airstrikes reported in those areas early Sunday.

Images online showed plumes of black smoke over the area of the Sanaa airport complex, which includes a sprawling military facility. The Houthis also reported airstrikes early Sunday on the provinces of Hodeida, Bayda, and Marib.

At least 18 people were killed, including 13 in Sanaa and five in Saada, according to the Houthi-run health ministry. At



least 24 others were wounded, including nine in Sanaa and 15 in Saada, it said.

A US official said this was the beginning of air strikes on Houthi targets that are expected to continue. The official spoke on the condition of anonymity because they were not authorised to talk to

Nasruddin Amer, deputy head of the Houthi media office, said the airstrikes won't deter them and they would retaliate against the US. "Sanaa will remain Gaza's shield and support and will not abandon it no matter the challenges," he added on social media.

Another spokesman, Mohamed Abdulsalam, on X, called Trump's claims that the Houthis threaten international shipping routes "false and misleading".

The airstrikes come a few days after the Houthis said they would resume attacks on Israeli vessels sailing off Yemen in response to Israel's latest blockade on Gaza. They described the warning as affecting the Red Sea, the Gulf of Aden, the Bab el-Mandeb Strait and the Arabian Sea. There have been no Houthi attacks reported since then.

Earlier this month, Israel halted all aid coming into Gaza and warned of "additional consequences" for Hamas if their fragile ceasefire in the war isn't extended as negotiations continue over starting a second phase.

The Houthis had targeted over 100 merchant vessels with missiles and drones, sinking two vessels and killing four sailors, during their campaign targeting military and civilian ships between the start of the war between Israel and Hamas in late 2023 and January of this year, when this ceasefire in Gaza took effect. The attacks raised the Houthis' profile as they faced economic and other problems at home amid Yemen's decadelong stalemated war that's torn apart the Arab world's poorest nation.

The Houthi media office said the US strikes hit a residential neighbourhood in Sanaa's northern district of Shouab. Residents said at least four airstrikes rocked the Eastern Geraf neighbourhood there. terrifying women and children. The Eastern Geraf is home to Houthi-

held military facilities and a headquarters for the rebels' political bureau, located in a densely populated area. The Houthis reported fresh strikes on the southwestern Dhamar province late Saturday. They said the strikes hit the outskirts of the provincial capital, also named Dhamar, and the district of Abs. The United States, Israel and Britain have previously hit Houthiheld areas in Yemen. (AP)

#### Hamas says it will only release American-Israeli hostage if ceasefire deal implemented

CAIRO, March 16: Hamas said on Saturday it will only release an American-Israeli and the bodies of four other hostages if Israel implements their ceasefire agreement, calling it an "exceptional deal" aimed at getting the truce back on track.

Israeli airstrikes meanwhile killed nine people in the Gaza Strip who the military identified as militants, allegations denied by a UK-based aid group that said eight of its workers were killed.

A senior Hamas official said long-delayed talks over the ceasefire's second phase would need to begin the day of the release and last no longer than 50 days.

Israel also would need to stop barring the entry of humanitarian aid and withdraw from a strategic corridor along Gaza's border with Egypt. Israel has said it won't pull out from the corridor, citing the need to combat weapons smuggling.

Hamas would also demand the release of more Palestinian prisoners in exchange for hostages, said the official, who spoke on condition of anonymity to discuss the closed-door talks.

Edan Alexander, 21, who grew up in New Jersey, was abducted from his military base during Hamas' October 7, 2023, attack that ignited the war. He is the last living US citizen held in Gaza. Hamas still has 59 hostages, 35 believed to be dead.

Speaking at a protest camp set up last week outside Israeli military headquarters in Tel Aviv. relatives of hostages said Netanyahu was "violating the agreement he signed and abandoning the hostages in Gaza". "You want to sacrifice our children for the pleasures of power," said Itzik Horn, father of hostage Eitan and freed hostage Iair. Prime Minister Benjamin Netanyahu late Saturday told negotiators to prepare for the continuation of talks regarding the release of hostages, his office said.

Indonesia's cocoa farmers work with businesses

Two Israeli airstrikes in the northern town of Beit Lahiya near the border killed at least nine people, according to Gaza's Health

The Palestinian Journalists' Protection Center, a local watchdog, said the dead included three Palestinian journalists who were documenting aid distribution. Local health official Fares Awad identified one as Mahmoud Islim, who was operating a drone. The Israeli military said it struck two people operating a drone that it said posed a threat to soldiers in the area. It said it launched another strike at a group of people who came to collect the drone equipment, identifying all those targeted as militants.

The army later released the names of six people it said were militants killed in the strikes, including one accused of taking part in the October 7 attack and another who it said had been released as part of the ceasefire. The military said two others, including Islim, were militants posing as journalists.

The UK-based Al Khair Foundation said that eight of its workers were killed in the strikes. It denied the Israeli military's allegations that those killed were militants or had connections to Hamas

Hamas in a statement called the attack a 'serious escalation" showing Israel's attempts to "sabotage any opportunity" to implement the ceasefire agreement.

Also Saturday, Israel's military said it removed a platoon of soldiers from Gaza who were seen in a video on social media opening fire during a celebration of the Jewish holiday of Purim. The video shows soldiers shooting, apparently randomly, while another performs the customary reading of the Book of Esther. The military said the soldiers "will face disciplinary measures".

Israel has cast doubt on Hamas' offer The United States said it presented on Wednesday a proposal to extend the ceasefire a few weeks as the sides negotiate a permanent truce. It said Hamas was claiming flexibility in public while privately making 'entirely impractical" demands.

Talks continued in Egypt, which along with Qatar has served as mediators with Hamas in the indirect talks with Israel.

Israel and Hamas were to begin negotiations on the ceasefire's second phase in early February, but only preparatory talks have been held. In Phase Two, Hamas would release all remaining hostages in exchange for a lasting truce.

The first phase saw the release of 25 Israeli hostages and the bodies of eight others in exchange for nearly 2,000 Palestinian

#### Russia, Ukraine trade overnight aerial attacks after Putin sets out conditions for ceasefire

KYIV, March 16: Russia and Ukraine traded heavy aerial blows overnight, with both sides on Saturday reporting more than 100 enemy drones over their respective territories.

The attacks comes less than 24 hours after Russian President Vladimir Putin met with US envoy Steve Witkoff to discuss details of the American proposal for a 30day ceasefire in the war with

Putin told a press conference on Thursday that he supported a truce in principle but set out a host of details that need to be clarified before it is agreed. Kyiv has already endorsed the truce proposal, although Ukrainian officials have publicly raised doubts as to whether Moscow will commit to such a Speaking to reporters in Kyiv on

Saturday, after virtual talks between Western allies hosted by UK Prime Minister Keir Starmer, Zelenskyy voiced Ukraine's support for the 30-day full ceasefire proposal to discuss a longer-term peace plan, but said Russia would attempt to derail talks with conditions and "buts".

Starmer has told allies to "keep the pressure" on Putin to back a ceasefire in Ukraine, hailing Ukraine as the "party of peace". Starmer said Putin will "sooner or

later" have to "come to the table". In a statement earlier on Saturday, Zelenskyy had accused Moscow of building up forces along the border. "The build up of Russian forces

indicates that Moscow intends to keep ignoring diplomacy. It is clear that Russia is prolonging the war," he said. However, Zelenskyy stressed

## to fight bitter impact of climate change TANJUNG REJO (INDONE-

SIA), March 16: The loud whirr of a chainsaw sounds through the forest as a small group of farmers gathers around a tree filled with red seed pods. With one slow stroke, a severed knobby branch hits the ground.

"Now it will help the tree grow new fruit," farmer Tari Santoso says with a smile.

Thousands of cocoa farmers across Indonesia like Santoso are working with businesses and other organisations to protect their crops from the bitter impacts of climate change and under-investment that have pushed cocoa prices to record levels.

Cocoa trees are high maintenance: Grown only near the equator, they require a precise combination of steady temperatures, humidity and sunlight. It takes five years for a tree to start producing the seeds that are processed into cocoa used to make chocolate and other delectable foods. Climate change raises the risks for farmers: Hotter weather hurts yields and longer rainy seasons trigger the spread of fungus and deadly pests. Increasingly unpredictable weather patterns have made it harder for farmers to deal with those challenges.

So farmers are switching to other crops, further reducing cocoa supplies and pushing prices higher: In 2024, prices nearly tripled, reaching about USD 12,000 per



leading some chocolate makers to try growing cocoa in laboratories.

Indonesia is the third-largest producer of cocoa in the world, behind Cote D'Ivoire and Ghana, according to the United Nations Food and Agriculture Organisation, farmers are joining with businesses and nongovernmental organisations to develop better growing practices and improve

Sitting in the shade of his forest farm in south Sumatra, 3 miles (5 kilometers) from a national park where Sumatran tigers and rhinos roam, farmer Santoso is working with Indonesian chocolate maker Krakakoa.

After he began working with the company in 2016, Santoso starting using practices that helped his cocoa trees flourish, regularly pruning and grafting new branches onto older trees to promote growth

and prevent the spread of disease. He is using organic fertiliser and has adopted agro-forestry techniques, integrating other crops and trees such as bananas, dragon fruit, coffee and pepper, into his farm to foster a healthier ecosystem and invest in other income sources.

"It wasn't very successful before we met Krakakoa," Santoso said. "But then, we received training ... things are much better.'

Krakakoa has trained more than 1,000 cocoa farmers in Indonesia according to its founder and CEO, Sabrina Mustopo. The company also provides financial support. Santoso and other farmers in Sumatra said the partnership

provides low-interest loans to farmers, with interest paid back into the cooperative rather than to banks outside of the community.

Cocoa farmers who need bigger loans from government-owned banks also benefit from partnering with businesses, as the guaranteed buyer agreements can provide collateral needed to get loans approved, said Armin Hari, a communications manager at the Cocoa Sustainability Partnership, a forum for public-private collaboration for cocoa development in Indonesia.

Dozens of other businesses, the government and nongovernmental organisations and cooperatives are also working with cocoa farmers to better cope with climate change, benefiting thousands, Hari said. He pointed to a collaboration between Indonesia's National Research and Innovation Agency and the local division of international chocolate maker Mars, which have released a new variant of cocoa that pro-

duces more pods per tree. Challenges still remain, said Rajendra Aryal, the FAO's country director for Indonesia. Fewer people see cocoa farming as a lucrative business and instead are planting other crops such as palm oil. And many small-scale farmers

still cannot get loans, he said. But Aryal said he hopes that continued collaboration between helped them to form a cooperative farmers and others will help. (AP)

#### **Drugs worth ₹ 88 crore seized** Amit Shah says no mercy for drug cartels

"No mercy for drug cartels. Accelerating the Modi govt's march to build a drug-free Bharat, a massive consignment of methamphetamine tablets worth ₹ 88 crore is seized, and 4 members of the international drug cartel are arrested in Imphal and Guwahati zones," he wrote on X.

Acting on a tip-off, the officers of NCB Imphal zone carried out an operation on March 13. ## Tripura BJP to contest TTAADC village committee polls in alliance with TMP, IPFT

AGARTALA, March 16: Tripura BJP president Rajib Bhattacharjee on Sunday said that the ruling party will contest the elections to the village committees of TTAADC along with its allies, the Tipra Motha Party (TMP) and the Indigenous People's Front of Tripura (IPFT).

The BJP and TMP had fought the state assembly elections in 2023 separately but a year later, the Tipra Motha Party joined the BJP-led coalition govern-

"We believe in coalition politics... we will fight the elections to the village committees under the Tripura Tribal Areas Autonomous District Council (TTADC) collectively after consultation with our two allies, TMP and IPFT," Bhattacharjee told reporters here.

The TTAADC, constituted under the Sixth Schedule, has 587 village committees (akin to panchayats) for which elections were supposed to take place in February 2021. The schedule of the polls is yet to be announced.

Bhattacharjee said the BJP, in association with Janajati Morcha, the tribal wing of the ruling party, has initiated highlighting the good work of the BJP-led coalition government for the welfare of the indigenous peo-

"Today, we organised a state-level programme – 'Empower-ing Janajati, Empowering Tripura' -- here to highlight the good work done by the BJP-led government in the last seven years. Such programmes will be held in district and block levels as well," he said.

Bhattacharjee said the BJPled government has been spending more development funds in the tribal-dominated blocks than in non-tribal blocks to speed up development activities such as road construction, drinking water supply, housing and livelihood.

"The 23-year-old Bru issue has been solved permanently by rehabilitating the internally displaced families in the state during the BJP rule. Besides, as many as 18 Eklavya Model Residential Schools have been sanctioned for providing proper education to tribal students," he

In response to a petition filed by the Tipra Motha Party for holding village committee elections at the earliest, the Tripura High Court had last year directed the State Election Commission (SEC) to conduct the polls by December 2024.

Although the five-year tenure of the village committees expired in February 2021, the elections could not be held due to the COVID-19 pandemic. The State Election Commission later initiated delimitation of the village committees, further

# Jyoti Basu rejecting PM post not factor: Karat

decline of the CPI(M) was caused by the erosion of support in West Bengal and Tripura, veteran leader Prakash Karat has said and added a roadmap to rebuild the party's strength would be discussed during

its upcoming all-India congress. Karat -- who served as the CPI(M) general secretary between 2005 and 2015 -- further said he did not consider veteran leader Jyoti Basu declining the prime minister's post in 1996 as a reason behind the party's decline.

"It is a fact that the party's independent strength and influence have not grown ... And that's primarily been due to the erosion in our base of support in West Bengal and Tripura, two of the strong states that we have," Karat said in an interview with PTI.

"So, the focus of our forthcoming party congress is how we strengthen the party," the CPI(M) interim coordinator added.

The CPI(M) had 43 MPs in the 14th Lok Sabha from 2004 to 2009. Its tally declined to 16 in 2009, nine in 2014 and three in 2019. The party won four seats in the Lok Sabha in the 2024 elections. In state assemblies, the CPI(M)-led Left Front was defeated by the TMC in West Bengal in 2011 after being in power for 34 years. It was defeated by the BJP in Tripura -- which the CPI(M)-led coalition had governed since 1993 -- in 2018.

Speaking about preparations for the party congress, Karat said political and organisational reviews during the past three years had been done. Shortcomings and weaknesses in political, ideological and organisational work would



be identified during the meet.

"Keeping in mind that ... Our political task or goal still remains how to isolate and defeat the BJP or the Modi government, for that you need wider unity. We recognise that. How to maintain this wider unity, a broader platform, that we will have to strive for," he

"At the same time, we don't see this as separate. Strengthening of the CPI(M) will also help strengthen the overall opposition unity or strengthening of the Left. And we feel that the Left's alternative politics or policies need to be projected as a rallying point for the fight against the various policies of the Modi government," he added.

He also disagreed with the suggestion that the party's decision not to accept the prime minister's post offered to then-West Bengal chief minister Basu in 1996 as a reason for its gradual decline.

"We should not forget that our main strength in Parliament at that

support from the Congress. After both Basu and former prime minister VP Singh declined, HD Deve Gowda took over as prime minister in the United Front government. He was succeeded by IK Gujral, whose government collapsed in 1998.

Karat, who took over the party's running last year, said the passing of general secretary Sitaram Yechury came as a setback just as preparations for the all-India congress had started picking up pace.

However, the party's organisational structure made it possible to carry the preparations forward, he added. "Our Politburo and Central Committee work on a collective basis, we were able to overcome this loss immediately" Karat told

The 24th All-India Party Congress of the CPI(M) will be held in Tamil Nadu's Madurai on April 2-6. Karat said a new leadership would emerge as the Central Committee had instituted an age limit

"Those who pass 75 years of age will not be eligible to be elected to the Central Committee. And the Central Committee elects the Politburo (members) and the general secretary," he added

According to the party's draft political resolution, to be discussed at the Madurai meet, the CPI(M) would continue to cooperate with the INDIA bloc and other regional parties against the BJP and also work on strengthening Left unity while focusing on increasing its mass base and influence.

The document also stressed on the urgent need to expand the independent strength of the CPI(M). (PTI)

## Those who called Maha Kumbh 'Mrityu Kumbh' unable to control disturbance during Holi: Adityanath

GORAKHPUR (UP), March 16: Hitting out at his West Bengal counterpart Mamata Banerjee over her remarks criticising Maha Kumbh arrangements, Uttar Pradesh Chief Minister Yogi Adityanath said Sunday those who had said the "Maha Kumbh of Prayagraj was a 'Mrityu Kumbh' were unable to control disturbance during Holi".

Addressing the oath-taking ceremony of newlyelected office bearers of the Gorakhpur Journalists Press Club in Gorakhpur, he said that "for the first time, people came to the Maha Kumbh from Tamil

"People (devotees) also came from Kerala. The population of Uttar Pradesh is 25 crores, and the Holi concluded peacefully. But, in West Bengal, a number of disturbances took place during Holi," he said.

On the day of Holi, a 20-year-old youth was killed in a scuffle during celebrations in West Bengal's North 24 Parganas district.


Akash Choudhury, alias Amar, was accosted by three to four youths while celebrating Holi with his friends near his residence in Titagarh. As an argument broke out, he was repeatedly stabbed in his neck and other parts of his body by the assailants, the officer added. Adityanath took a dig at Banerjee over such incidents in her state.

"People who were unable to control the disturbance 'upadrav') during Holi, had said that the Maha Kumbh of Prayagraj was a 'Mrityu Kumbh'. But, we said that this is not 'Mrityu' (death), it is 'Mrityunjay' (victory over death) It is a Maha Kumbh.

He said that everyday of the Maha Kumbh witnessed 50,000 to 1 lakh people from West Bengal taking part in the 45-day event.

Days after the January 29 stampeded at the Sangam Nose, where the official toll was 30, West Bengal Chief Minister Mamata Baneriee had said the Maha Kumbh has turned into a "Mrityu Kumbh" due to such incidents of stampede, claiming the actual toll was suppressed by authorities.

They have hidden hundreds of bodies to bring down the toll. The Maha Kumbh has turned into a 'Mrityu Kumbh' under the BJP rule," Banerjee said during an address in the West Bengali assembly on February 18. Back in Gorakhpur, Adityanath also said his government sent ministers to some states to invite

#### Removal of Aurangzeb's grave won't serve any purpose: Athawale

MUMBAI, March 16: Union minister Ramdas Athawale has voiced his opposition to the demand for demolition of Mughal emperor Aurangzeb's grave in Maharashtra's Chhatrapati Sambhajinagar district, saying its removal will not serve any purpose.

Talking to reporters here on Saturday night, the Republican Party of India (A) leader also said the matter should not be politicised. Some right wing outfits have called for the removal of Aurangzeb's

grave located at Khuldabad in Chhatrapati Sambhajinagar. Organisations like Bajrang Dal and Vishwa Hindu Parishad (VHP) plan to submit a memorandum to the state government on Monday, urging legal action to remove the grave and have warned of 'karseva' and

statewide protests if the demand is not met. BJP's Satara MP Udayanraje Bhosale, a descendant of Maratha king Chhatrapati Shivaji Maharaj, had sought the removal of Aurangzeb's

tomb in Chhatrapati Sambhajinagar. Aurangzeb is remembered in Maharashtra for his battles with the Marathas, who resisted his expansionist ambitions. Shivaji Maharaj's son, Sambhaji, was captured, tortured, and executed on his orders.

Athawale said it is true that Aurangzeb was cruel and killed (Shivaji Maharaj's son) Chhatrapati Sambhaji Maharaj. But, he failed to conquer the (Maratha) kingdom and ultimately died in Maharashtra.

"His tomb has existed for many years, and there is no need to reopen this issue. The tomb stands as a reminder of his misdeeds, and its removal will serve no purpose," said the leader, whose party is an ally of the ruling

Asked about some BJP leaders raising the issue, Athawale said he does not believe that this matter should be politicised.

"Neither the BJP nor any other party is involved in this controversy. It is inappropriate to describe Aurangzeb as an astute administrator or compare the BJP regime to his rule," the Minister of State for Social Justice and Empowerment said.

Athawale said that since Aurangzeb was buried there (in Khuldabad), his tomb should remain undisturbed.

Notably, Shiv Sena (UBT) MP Sanjay Raut on Friday called the BJP rule in Maharashtra worse than that of Aurangzeb and claimed farmers were dying in the state because of the saffron party.

Earlier this month, Samajwadi Party MLA Abu Asmi Azmi was sus-

pended from the state assembly till the end of its budget session on March 26 following his remarks eulogising Aurangzeb. The Chhatrapati Sambhajinagar administration in an order on Saturday

barred Hindutva leader Milind Ekbote from entering the district from March 16 to April 5 amid calls from some outfits to remove Aurangzeb's

The order said Ekbote's organisation Dharmaveer Sambhaji Maharaj Pratisthan pays homage to the warrior-king annually in Pune and intelligence inputs were received about him and his supporters possibly coming to Khuldabad to remove Aurangzeb's tomb. (PTI)

Talking to reporters on the occasion. Kanhaiya Kumar, who is also national in charge of NSUI, the students wing, launched a veiled attack on the ruling BJP-led NDA in Bihar. "This government is unable to give jobs. Every competitive exam is marred by question paper leaks or ends in litigation in court because of other irregularities. Those who got employed recently, like government teachers, are being deprived of pension benefits that their seniors enjoy," said the Begusarai-born leader.



## Wanted for deadly terror attacks in J&K, top LeT commander killed by gunmen in Pakistan

**NEW DELHI, March 16:** A top Lashkar-e-Taiba (LeT) com-mander, wanted by Indian security agencies for several deadly terror attacks in Jammu and Kashmir, was eliminated by gunmen in an attack in Pakistan, officials said on Sunday.

Zia-ur-Rehman alias Nadeem alias Abu Qatal alias Qatal Sindhi was gunned down in the Jhelum area of Punjab on Saturday evening. His security guard was also killed, the officials said, quoting information received from the neighbouring country.

Considered the most trusted handler of LeT founder and 26/11 Mumbai terror attack mastermind Hafiz Saeed, they said 43-year-old Rehman was the main handler of the terror outfit involved in the planning of various attacks in the Poonch-Rajouri region of Jammu and Kashmir.

The officials said Rehman had infiltrated the Jammu region in early 2000 and exfiltrated in 2005. He had a wide network of Over Ground Workers in Poonch and

#### Whitewashing of Sambhal mosque underway

SAMBHAL (UP), March 16: The whitewashing of the outer wall of the Shahi Jama Masjid in Uttar Pradesh's Sambhal began on Sunday morning, an advocate of the mosque side said. The Allahabad High Court on March 12 directed the Archaeological Survey of India (ASI) to undertake and complete the whitewashing at the mosque within one week.

Following the high court order, an ASI team carried out measurements and assessments on March 13. "The whitewashing of the outer wall of the Shahi Jama Masjid in Sambhal began on Sunday," Shakeel Warsi, an advocate representing the mosque side in the Sambhal district court told PTI.

Shahi Jama Masjid's president Zafar Ali said, "The whitewashing work started at around 9 am. The whitewashing of the outer wall is

The officials said Rehman is also the mastermind of the Reasi Bus Attack which was orchestrated on the day of the oath-taking ceremony of Prime Minister Narendra Modi-led government on June 9, 2024.

In this attack, terrorists killed nine pilgrims and injured 41 by firing on a bus carrying pilgrims to Shiv Khori temple

He was also involved in the Bhatta-Durian terror incident on April 20, 2023, in which five Army personnel were killed. He is also accused in the Kandi attack on officers and personnel of the 9 Para Special Forces on May 5, 2023. The attack claimed the lives of five personnel, officials said.

They said Rehman, along with Saifullah Sajid Jutt, another Pakistan-based terrorist, was the main handler of terrorists of the outfit operating in the Poonch-Rajouri belt of Jammu and Kashmir.

Born on February 4, 1982, in the Sanghar district of Sindh province of Pakistan, Rehman was in charge of LeT's Khuiratta dets (small group of terrorists ready to infiltrate) located in Kotli district of Pakistan-occupied Kashmir (PoK).

He was the main link between the LeT cadres and its operators in PoK and Sindh Province of Pakistan, the officials said, adding he was the most trusted handler of Saeed.

On several occasions, the LeT founder tasked Rehman with ensuring control over the dets in PoK, the officials said. Rehman's associates -- Rivaz Ahmed alias Abu Qasim and Hanzla Adnan -were killed in separate incidents in Pakistan in September and December 2023.

Over a dozen terrorist commanders of different outfits, including Jaish-e-Mohammad and Hizbul Mujahideen, have been eliminated by unidentified gunmen in Pakistan and PoK over the last three

#### Grenade-like object hurled at YouTuber's house in Jalandhar, Pak don claims responsibility

CHANDIGARH, March 16: A Pakistani gangster has claimed responsibility after a "grenadelike object" was hurled at the residence of Jalandhar-based YouTuber Rozer Sandhu on Sun-

Two videos have emerged since the incident, one in which a Pakistani gangster, Shahzad Bhatti, claiming that he carried out the attack against the YouTuber for allegedly using derogatory language against the Muslim community.

Police on Sunday said unidentified persons hurled a "grenade-like object" at Sandhu's residence at Maqsudan in Punjab's Jalandhar district. However, it did not explode, and the house was

On receiving the information, senior police officers rushed to the spot. A bomb disposal squad took the object to custody.

Jalandhar Rural Superintendent of Police Jasroop Kaur Bhatt said, "We found a round metallic object, but couldn't immediately verify if it was a grenade. It has the appearance of a grenade. Fur-

residence, Senior Superintendent of Police (Rural) Gurmeet Singh said, "We spoke to Sandhu and also found a suspicious metallic object. A bomb disposal team is examining it," he said, adding that they will examine the CCTV footage.

Singh said agencies abroad are trying to derail the ongoing campaign against drugs in Punjab and nobody will be allowed to get away with their nefarious designs.

Asked whether the influencer has made any objectionable comment, Singh said nothing of that sort has come to light.

Meanwhile, a purported 18-second video has emerged, showing a man sitting in a car, giving directions to throw a grenade-like object at the second floor of a building. He is seen asking another man in the car to take out the pin.

In yet another video, Pakistani gangster Shahzad Bhatti has claimed that the "grenade" was hurled in Jalandhar as the YouTuber was abusing Islam.

"If he survives, we will do it again. He is not alone, there are five people who did it. They thought we forgot. I thank my brothers Zeeshan

Akhtar and Happy Passia (a US-based terrorist) who helped me," Bhatti said in the video.

"If you want no bloodshed to take place or peace to be disturbed, you arrest them. I give you pictures and names, you arrest them. If you don't arrest them, I will wreak such havoc that their seven generations will remember.

I am showing the video (of hurling the grenade) at the end. I do not need fame. I have made the video so that if anyone abuses again, I shall do worse. If he (Sandhu) survives, I shall do (something) bigger than this," Bhatti said.

"You arrest them if you don't want bloodshed. He, his brother and there are three-four more people. I have their names and pictures," the gangster

The development comes a day after a motorcycle-borne person hurled an explosive device at a temple in Amritsar. In the blast that followed, a portion of the temple's wall was damaged and window panes shattered.

There have been many incidents of explosions targeting police posts in Amritsar and Gurdaspur

### **Immigration Bill:** Seven-year jail term for using forged passport

**NEW DELHI, March 16:** Anyone found using a forged passport or visa for entering, staying or exiting India will be punished with a jail term of up to seven years and a fine to the extent of ₹ 10 lakh if the new immigration bill is approved by Parliament. The legislation, piloted by the Union Home Ministry, also provides for mandatory reporting of information about foreigners by hotels, universities, other educational institutions, hospitals and nursing homes to enable tracking of overstaying foreigners.

All international airlines and ships will also be required to submit at a port or place in India the passenger and crew manifest, the advance information of passengers and crew on board of such aircraft, vessel or other mode of transport.

"Whoever knowingly uses or supplies a forged or fraudulently obtained passport or other travel document or visa for entering into India or staying in or exiting from India, shall be punishable with an imprisonment for a term which shall not be less than two years, but may extend to seven years and shall also be liable to fine which shall not be less than one lakh rupees, but may extend to ten lakh rupees," according to the bill introduced in Lok Sabha on March 11. It also says that any foreigner who enters into any area in India without a valid passport or other travel document, including visa required for such entry in contravention of provisions of the law or of any rule or order given in pursuance thereof, shall be punishable with an imprisonment for a term which may extend to five years with a fine which may extend to five lakh rupees or with both.

The legislation empowers the Centre to exert control over places that are "frequented by any foreigner" and require the owner to close the premises, permit its use under specified conditions, or refuse admission to all or a "specified class" of foreigners.

The Immigration and Foreigners Bill, 2025 is a comprehensive legislation to regulate all matters relating to foreigners and immigration. Matters relating to foreigners and immigration are presently adminis(Entry into India) Act, 1920, the Registration of Foreigners Act, 1939, the Foreigners Act, 1946 and the Immigration (Carriers' Liability) Act, 2000. All these laws are now proposed to be repealed.

While the Immigration and Foreigners Bill, 2025 consists of several existing provisions in the four Acts proposed to be repealed after simplification and harmonisation, it also has certain new provisions to meet the present-day requirements.

This legislation is in line with the government's policy of simplification of laws, ease of doing business and minimising compliance burden.

It seeks to balance the requirements of national security and related issues of immigration of foreigners with the need to promote economic growth and tourism in the country. However, it is not connected with any matters related with grant of citizenship.

"The Bill will help in tackling the problem of illegal migration into India and facilitate tracking of movement of overstaying foreigners within India.It will also help in reducing the compliance burden,' an officer said. While Indian visas of all categories to foreigners can be granted in physical or sticker form by Indian missions or posts located abroad, the Bureau of Immigration (BoI) grants electronic visas under seven categories to people from 167 countries. Besides, visa-on-arrival is granted by immigration authorities at six designated airports to nationals of three countries -- Japan, South Korea and the UAE (only for such UAE nationals who had earlier obtained e-visa or regular or paper visa for India). The stay and movement of foreigners in India and their exit are regulated by the BoI and state governments and Union Territory administrations.

According to existing laws, all foreigners on long-term (more than 180 days) student, medical, research, employment, missionary and project visas are required to register with the Foreigners Regional Registration Officer (FRRO) or the Foreigners Registration Officer (FRO) concerned, having jurisdiction over the place where the foreigner intends to stay, within 14

De Wilde pointed out that regulation remains the biggest challenge for any evolving industry, including the tobacco sector.

He noted that scientific and technological advancements are redefining the industry, but longterm impact can only be achieved through progressive policies that support modernisation, industry transformation, and investment-driven growth. He argued that such an approach would also elevate India's role in the global tobacco ecosystem.

He underscored how science-led decision-making has transformed various industries worldwide, from renewable energy to digital finance, enabling economic expansion and stronger global positioning. Drawing parallels to these industries, he urged India to adopt a similar approach for tobacco control by embracing scientifically validated alternatives.

Reflecting on PMI's own transformation, De Wilde explained that the company began rethinking its role in the tobacco industry two decades ago, recognising that combustion is the primary cause of

harm in smoking. To address this, PMI invested \$14 billion in scientific research and product innovation, hiring over 500 top scientists to develop less harmful alterna-

Ten years ago, PMI launched these alternatives in collaboration with governments, leading to significant reductions in cigarette consumption in multiple countries. Citing international examples, De Wilde pointed to Japan, where the introduction of alterna-

tives has halved the combustible cigarette market. In Rome, one in three smokers has transitioned to alternatives, while Sweden has achieved the lowest smoking rate in Europe—just 5%—with young adult smoking rates nearing zero.

He highlighted that Sweden also reports the lowest lung cancer incidence among men in the EU, demonstrating the public health benefits of regulatory mod-Turning to India, De Wilde commended the coun-

try's success in regulatory clarity across industries such as technology, finance, and infrastructure. He suggested that India's progressive policy frameworks, which have accelerated economic transformation, could be extended to scientifically backed

tobacco control measures.

'Progressive policies can drive less harmful solutions to tobacco use in India? By adopting a structured regulatory approach, he argued, India could set a global benchmark for policy

> development and trade. PMI, he said, is eager to work with Indian policymakers to align scientific innovations with regulatory priorities. While many countries have implemented structured policies for new tobacco product categories, India has an opportunity to lead the way in responsible industry evolution.

De Wilde emphasised the potential for government-industry collaboration to drive positive change, benefiting both public health and economic growth. Proposing a redefined tobacco control strategy for India, De Wilde advocated for a blend of science-driven policies and sustainable regulations that ensure

access to harm-reduction alternatives. With millions of lives at stake, he emphasized that such an approach could significantly strengthen pub-

Beyond policy modernisation, De Wilde reiterated PMI's commitment to sustainability, particularly in agriculture and farmer empowerment

NATAKA), March 16: Mangaluru Police seized over 37 kg of MDMA valued at ₹ 75 crore, the biggest-ever drug haul in the state, a police official said on Sunday.

Two South African nationals were arrested in Bengaluru in connection with this case, the official

Addressing a press conference, Mangaluru Police Commissioner Anupam Agarwal stated that the operation stemmed from an earlier arrest six months ago. In September, police apprehended one Haider Ali in Pumpwell, Mangaluru, and confiscated 15 grams of MDMA from him.

Subsequent investigations led authorities to a Nigerian national named Peter, who was arrested in Bengaluru with MDMA worth ₹ 6 crore. Further probes pointed to an international drug network with links to traffickers using air routes between Delhi and Bengaluru, he Mangaluru Central Crime Branch (CCB) police arrested two South African nationals -- Bamba Fant (31) and Abigail Adonis (30) -upon their arrival in Bengaluru on March 14. The suspects were taken into custody in Neeladri Nagar, Electronic City in Bengaluru, the senior police officer said

Authorities discovered MDMA concealed in their trolley bags, alongside four mobile phones, passports, and ₹ 18,000 in cash. Police sources indicate that the arrested individuals were allegedly supplying drugs to Nigerian peddlers operating in Bengaluru and other regions

Additionally, they are suspected of using forged passports and visas for travel. The investigation is ongoing to trace the larger network behind the illicit drug trade, officials said.

Karnataka Chief Minister Sid-

Mangalore City Police in which the largest quantity of drugs was detected in the history of the state in which two accused have been arrested, was commendable.

"By seizing 37 kg of MDMA worth over 75 crores, our police have averted a major danger that was about to face the lives of thousands of young people," he said in a post on 'X' in Kannada.

"Since the first day we came to power, we have been committed to building a drug-free society and have waged a war against drug sales and consumption," he said.

#### Seven policemen injured in spate of mob attacks in Bihar

BHAGALPUR/MADHUBANI/NAWADA, March 16: Seven policemen were injured in three incidents of mob attacks in Bihar, officials said on Sunday. These attacks happened in Bhagalpur, Madhubani and Nawada districts on Saturday, and were similar in nature -- police visiting an area on receiving information about a fight, and getting assaulted

Two more such incidents happened in the state in the last five days. While an assistant sub-inspector (ASI) died on Saturday after he was assaulted in Munger district, another policeman of the same rank died in Araria district on Wednesday. In Bhagalpur's Kahalgaon sub-division, five policemen were injured after being attacked by a mob in the Antichak police station area, officials said. Among those injured were a sub-inspector, three constables and a chowkidar, they said.

"The incident took place when a police team went to investigate a brawl between two boys, which had escalated. One of the boys hurled stones at the team. Following that, locals also started hurling stones. A police vehicle was damaged," Station House Officer of Antichak Ashutosh Kumar said. "Additional forces were immediately sent to the area and the situation was brought under control," he said.

The injured policemen were taken to the nearest government hospital for treatment, he said. "The prime accused, however, managed to flee. Local magistrate Sanjeev Choudhary was also present there when the incident happened. Based on the statement given by Choudhary, a case was registered against 24 people," Kumar said. Five people have been arrested so far, he added.

In Madhubani district, a police team was attacked when it went to the Parsahi area on receiving information about a fight between two groups of people, officials said. "Initially, a group of people indulged in a scuffle with the policemen. Amid the melee, a policeman was hit by a blunt object on his head. He was immediately rushed to the nearest hospital. He is out of danger at present. Some more policemen sustained minor injuries," a police officer said. A case was registered against 30 people, they said. Another policeman was injured in a similar attack when he along with some of his colleagues went to Shekodaura in Nawada's Kawakol police station area on getting information about an incident of stone pelting between two groups of people.

"A case has been registered and a search is underway for the accused," the district police said in a statement. Hours before these three incidents, ASI Santosh Kumar Singh succumbed to the injuries that he received after being attacked by a mob in Nandlalpur village in the Mufassil police station area of Munger district. (PTI)



# AR RAHMAN DISCHARGED AFTER HOSPITALISATION DUE TO DEHYDRATION

CHENNAI, March 16: Music composer AR Rahman was admitted to a corporate hospital here on Sunday fol-

hospital here on Sunday following dehydration and was discharged some hours later after doctors gave him a clean bill of health.

The 58-year-old musician was hospitalised on early Sunday morning and was now back home, according to his manager Senthil Velan.

AR Reihana, the music director's sister, earlier refuted reports that Rahman was hospitalised after he complained of chest pain.

"Nothing happened. He had dehydration and gastric problems," Reihana told PTI Videos. The two-time Oscar and Grammy winner, known for films such as "Roja", "Dil Se..", "Enthiran", and "Slumdog Millionaire", initially also complained of neck pain, his

"He (Rahman) has just come back home. He is perfectly fine. He was hospitalised early this morning... The doctors conducted some tests and everything was normal," Velan told PTI.

Rahman's close aide Vijay Iyer said the composer, who is fasting on account of the holy month of Ramzan, had returned from a trip to the UK and was jet-lagged.

"All that added up and caused him some level of dis-

comfort for which he was advised an immediate, thorough check-up and rest. He is back home and doing fine now. Thanks for your wishes," Iyer said in a statement.

Rahman's wife Saira Rahman, who announced separation with the musician after 29 years of marriage in November, also sent her best wishes.

"AR is in my prayers, and I wish him the best of health. In this tough time, I stand by him, as I also recover from my surgery, and wish him a speedy recovery," Saira Rahman said in a statement.

In an audio statement, she asked the media not to refer to her as Rahman's ex-wife as they were separate but "not divorced". "We are still husband and wife. It's just that we are separated because I wasn't keeping well for the last two years and I didn't want to stress him. I request the media to not call me his 'ex-wife'. I ask everyone, including his family, to not give any stress to him and take care of him," Saira Rahman further said.

Earlier, Rahman's son AR Ameen shared a picture of the medical bulletin issued by Apollo Hospitals, Greams Road on his Instagram Stories.

In the bulletin, the hospital authorities said Rahman visited the facility "today morning with dehydration symptoms and got discharged after routine Concerned fans also shared get well soon messages on social media.

"Get well soon... Thalaivaraeyy..." wrote an admirer on X. "Oh no! Wishing @arrahman speedy recovery. He'll be fine and live beyond 100 years," said another.



# Almost no difference in acting between films and OTT series: Sheeba Chadha



GUWAHATI, March 16: Actor Sheeba

Chadha, known for her roles in movies such as "Badhaai Do" and "Dum Laga Ke Haisha" as well as series like "Mirzapur" and "Bandish Bandits", says there is hardly any difference between working in a feature film and web shows.

According to the actor, the only difference could be that a performer is allowed more time to get into the depth of their character.

"I really don't find much difference. The crews are so osmotic that people working in one medium are also working for the other. One is long format and the other has finiteness in features. Actors like us get more compounded, fleshed-out characters in OTT with more space and time to explore, which is not possible in a film

"That difference is there. In the sheer experience of working, I don't find it much different. In the performance, I don't find any difference... But sometimes a really well-nuanced and well-written character in a film too will give you that (satisfaction). You can have a long drawn out, fleshed-out series in a character but it might not give you the same satisfaction," Chadha told PTI in an interview.

The acclaimed actor started her career with 1998's "Dil Se.." and played pivotal roles in "Hum Dil De Chuke Sanam", "Phir Bhi Dil Hai Hindustani", "Murder", "Parzania", "Delhi-6", "Raees", "Gully Boy", and "Doctor G", among others. Chadha, 52, said she didn't have any 'ideal or dream character' on her list.

Asked how she chooses her characters, she said: "There is no science to it. I don't go about it in a very detailed way. Of course, the character has to be interesting enough with a definitive space in the story. After that, it's just the maths of dates, money and other things. It's quite simple."

Chadha, also a well-known theatre actor, said she is not getting enough time to do plays due to her busy work schedule.

"Yes, I am doing less theatre. I don't think I should be calling myself a theatre practitioner right now, because I am not practising theatre right now," she added.

The actor said she earlier used to think that being away from the stage would be impossible for her.

"But I have found out that it has not been so. Organically, cinema and OTT have been at the centre of my life now, but it's (theatre) not going to go anywhere. Right now it's just not allowing me the time and investment needed for theatre. "You can't just start a rehearsal (for a play) and say one of my film projects has come and I am not going to do it. You cannot do that. I am not finding that kind of space right now to truly invest, but in times to come it will happen, I know it. I will be doing it for sure." Chadha also said she hasn't been able to watch many movies in the recent years due to her work engagements

"Especially Malayalam cinema that I really want to start watching. I have been hearing

wonderful stuff about it," she said, adding that every kind of cinema has its place in society.

Bollywood has its place because its reach is of another kind and everybody consumes Hindi cinema all over the country, added the actor. "Now, we have access to regional cinema. When we started, we used to watch a lot of world cinema, but not so much regional. Of course, (Satyajit) Ray and (Ritwik) Ghatak used to be classics. Now, we have a lot of Telugu, Tamil, and Malayalam (films). So, any kind of cinema is good. The more we can make, the better."

Chadha, who has portrayed some of the most layered characters in cinema, said it is immaterial if a film telling a story of a woman is directed by a man or a woman.

"It depends on how deeply you are immersed in the story that you want to tell. Then I think beyond a point gender may not matter so much," she added.

Asked if Indian cinema, especially Bollywood, has been true in projecting women, the actor said she wasn't sure if it was easy to answer this question.

"At all points of time, people will be represented and shown as in the society, maybe not on centre stage. One will have films where one sees a lot of representation in a more nuanced and explorative way, and we are seeing that over time. Has it been done to its best? Probably not. That scope is limitless for any kind of exploration because it (cinema) is evolving." (PTI)

opening race, Melbourne's first wet race since 2010, from pole position. "I know what I'm capable of, I know what I can do, but obviously it's just round one, so we need to go and do it again next weekend and then continue from there. A long season ahead, we've just got to keep our head down and keep pushing."

## Olympic presidential candidate Prince Feisal sees real-world politics playing a bigger role

presidential election on Thursday takes place in a political climate that seems a world away from the last contested Olympic leadership vote in 2013.

There is a very different flavor between the two elections,' said Prince Feisal of Jordan, among three of the seven candidates on this ballot who was an IOC member and voted 11 1/2

Then, in September 2013, Russia was the next Olympic host with the Sochi Winter Games opening less than four months later. Russia was then a more trusted IOC partner, before it tainted those games with a statebacked doping scheme and broke United Nations-backed

> A big issue for Bach's successor is protecting the next Summer Games, opening in July 2028 in Los Angeles, when the United States is shaping up as an unpredictable partner for its long-term allies in the multilateral world order the IOC sees itself belonging to. Diplomatic challenges are normal in Jordan, led by Prince Feisal's elder brother King Abdullah II, who met with President Donald Trump at the White House last month.

BARCELONA, March 16: After a slow start to his Real Madrid career, Kylian Mbappe has already surpassed one of the club greats. Mbappe scored twice in Madrid's 2-1 comeback win over Villarreal on Saturday to take his tally to 31 goals in all competitions this season — one more than Brazil striker Ronaldo managed in his first campaign at the club. It also helped Madrid open up a three-point lead atop the panish league over Barcelona which has played two games less.

Long gone are the scoring troubles Mbappé endured in his first months at Madrid.

Having surpassed Ronaldo's tally from 2002-03, the former Paris Saint-Germain player is now closing in on the 33 goals that Cristiano Ronaldo scored in his first season with Madrid in 2009-10. "They are legends who marked eras with the club,' Mbappé said about the two Ronaldos. "If I score more goals than Ronaldo and Cristiano it doesn't mean that I am better, just that my first season is better. Scoring goals is important, but it is even more so if we win La Liga, the Champions

CHRISTCHURCH, March 16: A new era for Pakistan white ball cricket got off to a rough start Sunday with a nine wicket loss to New Zealand in the first of

five Twenty20 internationals. First time captain Salman Ali Agha led a new look team into the match which followed Pakistan's poor performance at home in the 50-overs Champions Trophy and began its buildup to the 2026 T20 World Cup. The Pakistan batting crumbled against the New

Zealand pace attack and the tourists were all out for 91 in 18.4 overs, its fifth-lowest total in T20 interna-New Zealand easily ran down that total, reaching

92-1 from 10.1 overs with Tim Seifert making 44 from 29 balls and Finn Allen 29 from 17. Tim Robinson was 18 not out and took two runs from the first ball of the 11th over to complete the win.

"It was obviously difficult and we weren't up to the mark," Ali Agha said. "They bowled really well. They were bowling in the right areas and there was swing and seam for them as well.

"But out batting wasn't up to the mark. We have won day before the next game and we will try to gather ourselves and be better in the next game."

Pakistan was in trouble from the start with the new opening pair of Mohammad Haris and Hasan Nawaz, stepping in for the veterans Mohammad Rizwan and Babar Azam, both dismissed without scoring in the first eight balls of the match.

A fully fit Kyle Jamieson took 3-8 and Jacob Duffy 4-14 as Pakistan stumbled to 14-4 at the end of the six over powerplay. Jamieson and Duffy produced pace, bounce and swing on a brownish pitch at Hagley Oval and the Pakistan batters had no early response.

"It was really nice to be back on home soil," said Jamieson who bowled 18 dot balls. "We had some pretty favorable conditions which I'm sure me and



(Duffy) would take most places around the country. "It was nice to have those and just try to cash in as much as we could."

Salman and Khushdil Shah gave the Pakistan innings some impetus when they took 14 runs from the 10th over bowled by Ish Sodhi and 15 from the 11th bowled by Michael Bracewell to lift Pakistan from 28-4 after nine overs to 57-5 after 11. The Pakistan batters looked more at home against the spinners

But Duffy returned to dismiss Khushdil for 32 and the rest followed quickly with only three batters reach-

ing three figures. Seifert put New Zealand on course to a comfortable win, taking 12 runs from the third over and 14 runs off the fifth as New Zealand reached 43-1 in the power play. Allen, unusually subdued, scored only nine runs in the first six overs.

New Zealand was 90-1 after 10 overs, needing only 2 runs to win, when the umpires unaccountably called for drinks. The second match is at Dunedin, New

#### **BCCI's Medical Team head Nitin** Patel puts in his papers

NEW DELHI, March 16: The BCCI's recently inaugurated Centre of Excellence (COE, earlier NCA) is expected to witness a few changes in composition of its staff in coming few months after Sports Science and Medical team head Nitin Patel recently tendered his resignation after a successful stint of nearly three years.

While Patel was unreachable for a comment, a senior BCCI official confirmed the development to PTI that one of the senior-most staffers of NCA is indeed "moving on". "Yes, Nitin has resigned as head of Sports Science and Medical Team. Nitin had a very good stint with BCCI and especially during this tenure, where he was instrumental in set-up of Sports Science and Medical team at NCA," a senior BCCI source told PTI on condition of anonymity. "One good thing that happened in the past couple of years is that whenever any injured player did his rehab, he only came back when after being more than hundred percent. Nitin's family lives abroad and managing COE's sports science and medical division is 365 -days-a-year assignment," the source added.

Some of the notable injury management assignments which Patel dealt, include India's pace spearhead Jasprit Bumrah, senior speedster Mohammed Shami, senior batter KL Rahul, lead spinner Kuldeep Yaday to name a few. The source said that a few Level 3 coaches and instructors along with some of the S&C coaches (Strength and Conditioning) coaches could make a move in some months time.

NCA head VVS Laxman's tenure is set to get completed by the end of this year and it is unlikely that he would seek an extension although the legend might be requested to carry on till the 2027 World Cup. Before Patel, one of the NCA coaches Sairaj Bahutule also quit and

joined Rajasthan Royals support staff. Sitanshu Kotak has joined the senior men's team staff permanently. Another reputed NCA coach Hrishikesh Kanitkar, who looks after India U-19 and occasionally India A teams is still on COE roster but it will be interesting to see if he hangs around once the U-19 World Cup in Zimbabwe and Namibia is finished early next year.
