Naga tribal chief urges Centre to scrap decision to fence Indo-Myanmar border

LONGWA (NAGALAND), April 6: A tribal chief in Nagaland's Mon district on Sunday urged the Centre to scrap the decision to fence the Indo-Myanmar border and to reduce the area of the Free Movement Regime (FMR).

Forty-nine-year-old chief of Angh ('king'), TonyeiPhawang claimed that people on both sides of border in Mon district belong to the Konyak Naga tribes and they are inter-dependent as they have family members on both sides of the border.

"We do not want fencing of the Indo-Myanmar border,"Phawang, the 10th generation chief of Angh told PTI at Longwa village in Mon district. He claimed that there are 35 villages under him of

which 30 are located on the other side of the international border and five are on this side "My own house which was originally constructed

He said if the Centre reduces the area under FMR and fences the Indo-Myanmar border then Konyak Nagas would suffer a lot.

Centre not seeking control of Waqf Boards: Nadda

26 YEARS OF DEDICATED JOURNALISM

NEW DELHI, April 6: The Centre does not want to control Waqf Boards but ensure that they operate within the bounds of law so that their assets are used in promotion of education, healthcare and employment for the Muslim community, BJP president JP Nadda said on Sunday.

Addressing an event organised at the BJP headquarters here to mark the party's 46th foundation day, Nadda said governments in Turkey and many other Muslim countries have taken the Waqf properties under their control.

'We are only asking those operating (the Waqf Boards) to do it as per rules. You will have to do it as per rules," he said.

"We do not seek to control the Waqf Board. Our goal is to ensure that those managing it operate within the bounds of law and adhere to established rules. The properties and funds of the Waqf Board should be dedicated to promoting education, providing healthcare and employment opportunities for the Muslim community," the BJP chief said.

Before the address, Nadda hoisted the BJP flag at the party headquarters.

Several party leaders, including MPs and Delhi chief minister Rekha Gupta, were present.

Revisiting the BJP's political journey that began with the Bharatiya Jana Sangh in 1951, Nadda said today it has become the world's biggest political party and is in power in several states because it never deviated from its ideological foundation for votes, unlike the Congress which suffered a decline due to its "ideological dilution"

He also attributed the BJP's success to party stalwarts such as Syama Prasad Mookerjee, Pandit Deendayal Upadhyay, Atal Bihar Vajpayee and L K Advani.

Today, we have 240 members in Lok Sabha, 98 members in Rajya Sabha and more than 1,600 MLAs across the country. We have



just concluded our membership drive and the number of BJP members has crossed 13.5 crore. We have more than 10 lakh active party workers in the country," Nadda said.

He said BJP is the only political party that has witnessed a "scientific growth"

"Expanding the organisation and winning elections is an art and a science," he said, adding, "Though our opponents take jibes at us in Parliament, they also say we are the world's biggest party. Even our opponents recognise our strength."

Nadda said the BJP has always kept the nation first and made efforts to promote India's traditions, culture and history, and pointed out that a "magnificent" Ram temple was constructed in Ayodhya during

the party's rule. He said in the Shah Bano case, the Congress under the then prime minister Rajiv Gandhi had succumbed to appeasement politics by "bowing" to pressure from certain sections of the Muslim community.

"Despite the Supreme Court calling for the emancipation of Muslim women, no one had the courage to take a decisive action,' he said, adding that BJP under the leadership of Prime Minister Narendra Modi abolished triple talag and liberated Muslim women. EU countries cautious on Brazil's push for new climate body

NEW DELHI, April 6: Brazil's idea to create a new multilateral body under the UN climate regime to fast-track implementation of COP decisions has triggered cautious responses from key developed countries, with Germany, the Netherlands and Sweden backing reform discussions but warning against weakening the core UN-FCCC process.

Brazil, which will host this year's UN climate conference or COP30 in Belem, has informally proposed setting up a "Climate Change Council" under the UN Framework Convention on Climate Change (UNFCCC) to improve how the world responds to climate change.

The idea is to speed up decisionmaking, coordinate efforts and improve implementation as many feel the current UN climate process is too slow and complicated.

While the Paris Agreement has helped lower projected warming since the start of the Industrial Revolution to around 2.1-2.8 degrees Celsius, the world is still off track for its 1.5 degrees Celsius goal. In fact, 2024 was the first year with global temperatures above 1.5 degrees Celsius for a full calendar vear.

With climate impacts worsening and global action not keeping up, experts say real progress may now require a complete rethink of the Paris Agreement and how climate diplomacy works.

Part of a five-member delegation from EU countries that visited India last week, Germany's Deputy Special Envoy for International Climate Action Gerhard Schlaudraff told journalists that the idea was discussed at the Petersberg Climate Dialogue in Berlin in

March. He welcomed Brazil's move to start the conversation but warned against undermining the UNFCCC or the Paris Agreement

RAMESWARAM (TAMIL NADU), April 6: Prime Minister Narendra Modi on Sundayinaugurated the Pamban sea bridge, providing rail link between Rameswaram island and the mainland and flagged off the new Rameswaram-Tambaram (Chennai) train service here.

The PM also flagged off a Coast Guard ship which passed under the

Chief Minister M K Stalin skipped the big ticket event and upped the ante on the delimitation issue and said he had already conveyed to the prime minister his inability to take part in the bridge inaugural since he had prior official commitment.

The CM was in the hill town Udhagamandalam to attend official engagements on Sunday.

The bridge is all set to improve connectivity to this spiritual destination flocked by devotees throughout the year from across the country. Built at a cost of over ₹550 crore, this is India's first vertical sea-lift bridge.

Spanning 2.08 kilometers, the bridge comprises 99 spans and a 72.5-meter-long vertical lift span

that can be raised up to 17 meters, allowing the smooth passage of large ships while ensuring seamless train operations.

The bridge features stainless

steel reinforcement, high-grade paint, and fully welded joints, enhancing durability while reducing maintenance requirements.

Its foundation is supported by 333 piles and 101 piers/pile caps, designed for dual rail tracks and future expansion. The use of polysiloxane paint protects it from corrosion, ensuring longevity in the harsh marine environment. This bridge is a remarkable blend of tradition and technology.

In the train, school children proudly waved the tricolour and the Southern Railway has announced that select mail and express and passenger trains will now originate and terminate at Rameswaram as the new bridge has been commissioned.

Indian metal firms eye domestic growth, remain resilient to US tariffs

While the United States has announced certain tariffs on metals. companies like Vedanta, JSW Steel, Hindustan Zinc, and NALCO are also betting on India's strong demand, the global race for critical minerals, and strategic geographic diversification to drive growth, analysts said.

Domestic steel demand is forecast to grow by 10 per cent annually over the next few years. Similarly, aluminium demand is expected to grow at a CAGR of 7.2 per cent till 2030.

aims to increase its share of valueadded products to over 90 per cent, from the current 60 per cent, to capitalize on India's growing construction and electric vehicle markets.

Similarly, Vedanta's subsidiary, Hindustan Zinc Ltd. Women hold 39.2% of bank accounts in India, 42.2% in rural areas: Mospi

NEW DELHI, April 6: Women own 39.2 per cent of bank accounts in the country and the proportion is even higher at 42.2 per cent in rural areas, according to a government report.

The Statistics and Programme Implementation Ministry (MoSPI) released the 26th edition of its publication titled Women and Men in India 2024: Selected Indicators and Data on Sunday.

The publication offers a comprehensive overview of the gender landscape in India, presenting selected indicators and data across key areas like population, education, health, economic participation, and decision-making, all sourced from various Ministries/ Departments/Organizations.

A MOSPI statement said that the report highlights that women own 39.2 per cent of all bank accounts and contribute to 39.7 per cent of total deposits

Their participation is the highest in rural areas, where they make up 42.2 per cent of account holders.

It stated that there is a rise in DEMAT accounts over the years, indicating growing participation in the stock market. From March 31, 2021, to November 30, 2024, the total number of DEMAT accounts increased from 33.26 million to 143.02 million, marking more than

Male account holders have consistently outnumbered female account holders, but female participation has also shown a growing trend.

The number of male accounts rose from 26.59 million in 2021 to 115.31 million in 2024, while female accounts increased from 6.67 million to 27.71 million during the same

Rising percentage of female-headed proprietary establishments across manufacturing, trade, and other services sectors over the years 2021-22, 2022-23 and 2023-24 has been observed, it stated.

The total number of electors increased from 173.2 million in 1952 to 978 million in 2024, with a notable rise in female voter registration. Female voter turnout varied over the years.

reaching 67.2 per cent in 2019 but slightly declining to 65.8 per cent in 2024. The gender gap in voting has narrowed,

with female turnout surpassing male turnout Over the years, there has been an increase

in the number of startups recognized by DPIIT with at least one-woman director, reflecting a positive trend in female entrepreneurship. The total number of such startups rose from 1,943 in 2017 to 17,405 in 2024.

The primary and higher Secondary levels (students) have consistently high GPI (Gender Parity Index), indicating strong female enrolment. Upper primary and elementary levels saw fluctuations but remained close to parity.

DIMAPUR, April 6: The Rising People's Party (RPP) on Sunday urged the Nagaland food and civil supplies department to publicise the list of beneficiaries for distribution of rice under the tide-over category within 10 days in the interest of transparency and accountability. In a release, the party said the matter is serious as the issue pertains to the distribution of 3,17,563.04 MT of tide-over rice issued by the Union ministry of consumer affairs to the state between 2018 and (October) 2024.

Quoting RTI documents, it said it was surprising that the department claimed not to have the names of beneficiaries under the tide-over category. It said as per the ministry of consumer affairs, food and public distribution, letter no. F.NO.15-33/2015-NFSA dated

December 7, 2015, the states were directed to "digitize beneficiary database and upload in the state portal before the implementation of the NFSA, 2013"

Further, the RPP said, as per the ministry's letter no. F. No. 15-62/2022-NFSA dated 27/01/2023, "The state government shall place the list of the identified eligible households in the public domain and display it prominently." According to the party, in another strange claim, the department said "the distribution of rice is done by the stockiest themselves". "Be as it may, the stockiest/handling agents/ carriage contractors should be having the names of the beneficiaries," it said.

The party, therefore, urged commissioner and secretary of the department to upload these names in public domain, such as department website, state

US tariffs and future

n April 2, US President Donald Trump announced what amounts to a dramatic escalation of the trade war initiated during his first term. Addressing a crowd of auto union workers at a Rose Garden event at the White House, the president revealed the details of his plan to reset the United States' relationship with its trading partners, framing his tariffs as a "declaration of economic independence." The historical record, of course, begs to differ, though economic history does not seem to be Trump's forte. At one point during his address, the president opined that the United States was "proportionally the richest" between 1789 and 1913, when trade barriers were in place, and that the Great Depression of the 1930s would have not occurred as it had if the ultraprotectionist 1930 Smoot Hawley Tariff Act had stayed in place longer. Economic historians generally agree that the disastrous set of tariffs on over 20,000 imported goods worsened the Depression. And according to ad hoc estimates done by Evercore ISI, a prominent advisory firm for investment banks, the weighted average tariff rate of the "Liberation Day" measures were just under 30 percent, compared to the 20 percent of Smoot Hawley.

After his historical digression, the president produced a chart of countries with corresponding tariff rates and went through them one by one. Initial reports from the Wall Street Journal and Bloomberg indicated that there would be a 10 percent blanket tariff on all imports. This turned out to be only part of the picture. The dollar slid sharply, and stock market futures and economic commentators were jolted by the revelation that most major trading partners would be subject to "reciprocal discounted tariffs" based on effective tariff rates that are claimed to account for nontariff barriers like value-added taxes and currency manipulation. Vietnam's tariff rate for the United States, for instance, is said to be 90 percent, based on which the United States would impose a reciprocal "discounted" (by 50 percent) rate of 45 percent. Other offenders include the European Union (20 percent), Japan (24 percent), and China (34

According to the text of the corresponding executive order, these reciprocal tariffs will be added to existing ones, yielding a rate of 54 percent for China. The United States' largest trading partners — those that were set to suffer the greatest economic hit, Canada and Mexico - are exempt from this reciprocal rate. Goods compliant with the United States-Mexico-Canada Agreement signed during Trump's first term, are not, it seems, subject to the 10 percent additional blanket tariff. The same will hold for goods that have already come under sectoral tariffs, such as autos and steel. The 25 percent tariffs on "foreign made" autos will come into effect at midnight on Thursday. These carve outs, though relieving, will be cold comfort for many across the border, since both Mexico and Canada are already facing the prospect of recessions induced by Trump's policies. While there are methods to quantify nontariff barriers, the numbers displayed by Trump are by all ap-

Assam Panchayat elections 2025: A crucial test for grassroots democracy

s Assam gears up for the Pan-chayat elections scheduled in two phases on May 2 and May 7, 2025, the state is set to witness an intense political atmosphere in the coming weeks. Though not as glamorous as Assembly or Parliamentary elections, these three-tier rural elections play a pivotal role in decentralizing power and bringing governance closer to the people. Over the years, Panchayat elections have evolved from being low-key affairs to politically charged events characterized by aggressive campaigning and high voter participation. This transformation underscores the increasing political consciousness among rural voters and their growing stake in governance and development.

The significance of the Panchayati Raj Institutions (PRIs) lies in their potential to empower the rural populace, giving them direct involvement in decision-making processes. However, for these institutions to function effectively, it is imperative that they remain free from corruption, partisanship, and inefficiency. The challenge before the electorate is not just to vote wisely but also to actively monitor the performance of their elected representatives to ensure accountability.

The Election Framework and Schedule The Assam State Election Commission (ASEC) officially announced the Panchayat Election 2025 schedule on April 3, 2025. The elections will take place in two phases—May 2 and May 7—with counting scheduled for May 11. These elections will be held across 27 districts, excluding Sixth Schedule districts, which operate outside the Panchayati Raj framework. With the model code of conduct coming into immediate effect, political parties have intensified their campaigns, striving to secure victories in crucial constituen-

According to the election timeline, the issue of the Notice of Election by district commissioners began on April 3, allowing candidates to file their nominations until April 11. Scrutiny of nomination papers was conducted on April 12, followed by a deadline for withdrawal of candidature on April 17. The final list of contesting candidates was published the same day.

The first phase of polling will be conducted in Upper Assam and Barak Valley districts, including Tinsukia, Dibrugarh, Charaideo, Sivasagar, Majuli, Jorhat, Golaghat, Dhemaji, Lakhimpur, Sonitpur, Biswanath, Cachar, Hailakandi, and Sribhumi. Any repoll, if required, will take place on May 4. The second phase will be held in Lower and Middle Assam districts, including Dhubri, South Salmara-Mankachar, Goalpara, Bongaigaon, Bar-

peta, Bajali, Nalbari, Kamrup, Kamrup (Metro), Hojai, Nagaon, Morigaon, and Darrang, with a repoll date set for May 9.

Polling hours are fixed from 7:30 AM to 4:30 PM for both phases, and the elections will be conducted using paper ballots due to the unavailability of enough Electronic Voting Machines (EVMs).

Political Dynamics and the Role of the Opposition

Despite the importance of these elections, the Opposition has remained relatively passive in its approach. While the ruling BJP-led coalition has exhibited an aggressive electoral strategy, the Congress-led Opposition has yet to announce a clear alliance or strategy. Given its weak

standing following multi-DEGREE OF THOUGHT ple electoral setbacks, the Opposition's lack of preparedness could signifiimpact the

electoral outcome. Internal conflicts within opposition parties have further diluted their ability to present a united front against the ruling coalition.

For political parties, Panchayat elections serve as a crucial test of their grassroots support and influence. The BJP-led government, having implemented various rural development programs, is looking to consolidate its hold in rural Assam. Meanwhile, the Opposition's inability to mobilize effectively may further erode its standing, reducing its ability to challenge the ruling alliance in future electoral con-

Voter Base and Electoral Infrastructure The total number of registered voters for the 2025 Panchayat elections stands at 1,80,36,682, reflecting a 13.27% increase from the 2018 elections, which had 1,56,41,456 voters. This voter base consists of 9,071,264 male voters, 8,965,010 female voters, and 408 others. To facilitate the electoral process, 25,007 polling stations have been established across the participating districts.

The election will determine representatives for 21,920 Gaon Panchayat (GP) members, 2,192 Anchalik Panchayat members, and 397 Zilla Parishad members. Notably, the GP elections will be apolitical, meaning candidates will not be allowed to use party symbols, instead relying on free symbols designated by the ASEC. However, candidates contesting for Anchalik Panchayats and Zilla Parishads are permitted to use political

party symbols. Significantly, 50% of all seats across Panchayat levels are reserved for women, reinforcing ef-

forts to ensure gender inclusivity in rural governance. Additional reservations exist for Scheduled Castes (SC) and Scheduled Tribes (ST) candidates, further promoting

equitable representation. Financial and Regulatory Aspects

To curb excessive expenditure and maintain fairness in the electoral process, the ASEC has set expenditure limits for candidates: ₹ 10 lakh for Zilla Parishad members, ₹ 2.5 lakh for Anchalik Panchayat members, and ₹ 25,000 for GP members. A toll-free complaint number will be available in each district to report violations of the model code of conduct.

Additionally, 88 election observers will oversee the election process to ensure compliance with electoral norms. The affidavits submitted by candidates contesting for Anchalik Panchayat and Zilla Parishad positions will be made publicly accessible on the ASEC's website, enhancing transparency.

Unlike previous elections, no direct election will be held for the post of Gaon Panchayat president. Instead, the elected GP members will internally select a president from among themselves. Each GP consists of ten members, reinforcing a decentralized approach to leadership selec-

Challenges and the Way Forward While the Panchayati Raj system was envisioned as a vehicle for grassroots empowerment and rural development, its effectiveness depends on the integrity and efficiency of its elected representatives. Corruption, political partisanship, and inefficiency remain key challenges. Without proper oversight, there is a risk that instead of decentralizing power and governance, the system may merely decentralize corruption and inefficiency.

It is imperative that voters not only exercise their franchise judiciously but also hold their representatives accountable post-election. The rural electorate has the power to influence the pace and direction of development by electing competent representatives and ensuring transparency in governance.

Moreover, the growing influence of social media in shaping public opinion presents both opportunities and challenges. While it can serve as a tool for political awareness and mobilization, it can also contribute to misinformation and communal polarization. Hence, responsible electoral participation, informed decision-making, and a commitment to democratic values are essential for strengthening the Panchay-

ati Raj system. The 2025 Assam Panchayat elections represent a crucial juncture for grassroots democracy in the state. With a growing voter base, increased political engagement, and reserved representation for marginalized groups, these elections have the potential to shape rural governance in significant ways. However, for the system to truly serve its intended purpose, both the electorate and the elected must prioritize accountability, transparency, and development over personal and political gains.

As Assam moves towards these elections, the responsibility lies with voters to make informed choices and with political leaders to uphold the spirit of democracy. mall cell lung cancer (SCLC) is a fast-growing cancer that develops in cells within the lung. A range of medical tests and procedures are available to help doctors diagnose SCLC and create an appropriate treatment plan.

Lung cancer is a complex disease comprising various subtypes. A person who receives a diagnosis of SCLC may want to get a second opinion to confirm the diagnosis and offer reassurance about their proposed treatment plan.

A second opinion can also help a person gain access to clinical trials that may not be available elsewhere.

This article explains the ways doctors diagnose SCLC.

Imaging tests

According to the American Cancer Society, doctors may order one or more of the following imaging tests to diagnose or stage lung cancers.

Cancer staging is an important part of the diagnostic process for SCLC. It helps determine whether and to what extent the cancer has spread.

Chest X-ray

A chest X-ray is one of the first tests doctors order to check for abnormalities in the lungs. Areas that appear abnormal will prompt doctors to order further tests.

CT scan

A CT scan uses X-rays to take a series of cross-sectional images of the body. It then combines these images to produce a more detailed image.

A CT scan can help doctors detect lung tumors and determine their location, size, and shape. A CT scan can also help doctors detect enlarged lymph nodes and tumors in other parts of the body, either of which may indicate that the cancer has spread.

A CT scan is more effective at finding lung tumors than a routine chest X-

MRI scan

MRI uses strong magnets and radio waves to produce detailed images of the body's soft tissues. Doctors often use MRIs to look for signs that a cancer has spread to other organs or tissues in the body

PET/CT scan

A PET/CT scan involves injecting a slightly radioactive sugar into the blood

radioactivity in the body

Because cancer cells tend to take up more sugar than normal cells, areas of high radioactivity on a CT scan may indicate the presence of cancer cells.

Doctors typically use PET/CT scans for cancer staging.

Needle biopsy Doctors may use a needle biopsy to collect tissue or cells from a suspicious lung mass. After collecting these samples, they analyze them under a micro-

scope to look for cancer cells. There are three main types of needle biopsy for SCLC. These are outlined

Fine needle aspiration (FNA) biopsy

FNA biopsy involves inserting a very thin, hollow needle into the mass to withdraw cells or small fragments of

This type of needle biopsy can help doctors detect cancer in very small masses or in the lymph nodes surrounding the lungs.

Core biopsy

A core biopsy involves using a larger needle to remove one or more small cores of tissue from a suspicious mass. Surgeons may perform this type of biopsy during lung surgery.

Thoracentesis

Pleural effusion is the medical term for excess fluid in the pleural space, which is the fluid-filled space around the lungs. There are many potential causes of pleural effusion.

Thoracentesis is a procedure that doctors may use to determine whether pleural effusion is due to lung cancer spreading to the lining of the lungs or another condition.

This procedure involves inserting a hollow needle between the ribs to help drain excess fluid from the pleural

Endoscopy

An endoscopy is a procedure that allows doctors to see inside the body using a scope. The scope is a thin, flexible tube with a light and camera at one

Scopes also contain tiny instruments that allow doctors to take samples from any abnormal-looking tissues. Doctors can then analyze the samples under a microscope to check for cancer cells.

There are many types of endoscopies, including: Bronchoscopy: Bronchoscopy involves using a type of scope called a bronchoscope to look inside the lungs. A doctor inserts the bronchoscope through the mouth or nostril, down the windpipe, and into the airways of the

lungs Thoracoscopy: Thoracoscopy allows doctors to investigate the pleural space, which is the space between the lungs and the chest wall. The procedure involves inserting a type of scope called a thoracoscope through a small cut beneath the shoulder blade and between

Mediastinoscopy: Mediastinoscopy is a procedure that allows doctors to investigate the mediastinum, which is the area between the two lungs. It involves inserting a device called a mediastinoscope behind the breastbone and in front of the windpipe. Small instruments inside the mediastinoscope allow doctors to take tissue samples from the lymph nodes along the windpipe and major bronchial tube areas.

Laboratory tests Disease specialists called pathologists analyze biopsy samples to determine whether a person has lung cancer and to establish the type.

Laboratory tests can also determine whether the cancer originated in the lungs or spread from elsewhere in the body. This is important, as treatments differ depending on where the cancer

originated Molecular testing is a type of laboratory test that involves checking for specific gene changes in cancer cells. Identifying these changes can help doctors determine whether a cancer may be responsive to targeted drug therapies.

Once the pathologist has analyzed the samples, they write the results in a pathology report. This report is typically available within 1 week.

Staging SCLC

- As the American Lung Association explains, lung cancer staging helps doctors determine the following:

Lung cancer staging can also help doctors establish the most appropriate treatment options for a person's lung cancer. Staging may also offer insights on a person's outlook.

Staging systems

According to the American Cancer Society, doctors use the American Joint Committee on Cancer (AJCC) TNM staging system to describe the growth and spread of SCLC. The TNM acronym stands for:

• T (tumor): the size of the tumor and whether it has grown into nearby struc-

tures or organs N (nodes): whether the cancer has

spread to nearby lymph nodes • M (metastases): whether the cancer has spread, or "metastasized," to dis-

tant organs or tissues For treatment purposes, doctors typically use a staging system that groups SCLC into one of the following two

• Limited stage: The cancer is confined to one side of the chest. The affected area is small enough that the person can receive radiation therapy in that one area. Around 33% of SCLCs are limited stage at the time of diagno-

• Extensive stage: The cancer has spread extensively throughout the lung or has spread outside of the lung where it originated. This may include the opposite lung or other organs and tissues in the body. Around 66% of SCLCs are extensive stage at the time of diagno-

Second opinions

People who have received a diagnosis of SCLC may benefit from seeking a second opinion about their diagnosis. A second opinion can help:

• confirm the diagnosis and provide reassurance about the proposed treatment plan

• provide insights into other potential treatment options that may be more effective or have fewer side effects

· open opportunities for participation in clinical trials that may not be available at other medical institutions

For individuals who want to seek a second opinion, the Lung Cancer Foundation of America advises finding a healthcare professional who specializes in lung cancer, such as a:

- · thoracic oncologist
- · medical oncologist radiation oncologist
- The organization also advises bringing all relevant medical records to the initial consultation so that the doctor is better able to understand the specifics of the case and offer an informed opinion. Medical records to bring include:

• pathology reports

imaging scans

• genomic testing results, sometimes called biomarker results

Frequently asked questions

How quickly does SCLC progress? Doctors sometimes use "doubling time" to describe how quickly a cancer is growing. Doubling time describes the amount of time it takes for a single cell to divide or the amount of time it takes for a tumor to double in size. Lower doubling times indicate a fastergrowing cancer.

SCLC is an aggressive disease with a short doubling time and a high risk of early spread. SCLC symptoms typically develop suddenly and often persist for 8 to 12 weeks before a person visits a doctor. Despite this relatively short time frame, most SCLC cases are extensive stage at the time of diagno-

What are the survival rates for SCLC?

The 5-year relative survival rate denotes the percentage of people who are alive 5 years after their initial diagnosis compared with people who do not have that diagnosis

According to the American Cancer Society, the 5-year relative survival rates for SCLC are:

- Localized: 30%
- Regional: 18%
- Distant: 3%

Summary

SCLC is an aggressive form of lung cancer that tends to grow and spread rapidly. For people with SCLC, receiving an accurate diagnosis is the first step toward receiving appropriate treatment. Doctors may use a range of diagnostic tests and procedures to diagnose and stage SCLC.

The first step is usually a chest Xray. If this shows abnormalities within the lungs, doctors may order additional tests, such as other types of imaging scans, needle biopsies, or endoscopy. Laboratory tests of biopsy samples can confirm the diagnosis of SCLC.

bout 10% of Americans say they have chronic insomnia, and millions of others report poor sleep quality. Ongoing research has found that bad sleep could lead to numerous health problems, including heart disease.

Dr Julio Fernandez-Mendoza is a professor of psychiatry and behavioral health, neuroscience and public health sciences at Penn State College of Medicine. He discusses the need for sleep, why teenagers require more sleep than adults, and how you can get a good night's sleep without medications.

The Conversation has collaborated with SciLine to bring you highlights from the discussion that have been edited for brevity and clarity.

How much sleep is enough for adults and for adolescents?

Julio Fernandez-Mendoza: Adults who report getting about seven to eight hours of sleep per night generally have the best health, in terms of both physical and mental health, and longevity.

But that recommendation changes with age. Adults over age 65 may need just six to seven hours of sleep per night. So older people, if otherwise healthy, should not feel anxious if they're getting just six hours. Young people need the most – at least nine hours - and some younger children may need more.

How can insufficient sleep harm our health?

Fernandez-Mendoza: Our team was the first to show that those complaining about insomnia – difficulty falling or staying asleep - were more likely to have high blood pressure and be at risk for heart disease.

In both teens and adults, we found that insomnia and shortened sleep may and go above and beyond simple sleep hygiene habits. If they don't work, see a provider who can help you. Do you have advice specifically for

adolescents? Fernandez-Mendoza: Adolescence is a unique developmental period. It's not just the obvious physical, emotional and behavioral changes that occur during adolescence and puberty – there are changes in a teenager's brain that can

alter their sleep patterns. When an adolescent goes through puberty, their internal clock changes so that their sleep schedule shifts to later hours. While it's true that adolescents are more engaged at night because of their social relationships, there's also biology behind why they want to stay up late - their internal clocks have

shifted. It's not just choice. School start times for most adolescents are at odds with that biological shift. So they don't get enough sleep, which affects their performance in school. Research suggests that schools with later start times are more closely aligned with the science on child development and don't put adolescents at risk by making them wake up earlier than their bodies are biologically in-

Parents can help their teens get better sleep. Set a time for kids to stop doing homework and put away electronics. Instead, they can watch TV with the family or read - something relaxing and enjoyable that will help them wind

down before bed. You can also gradually move back their wake-up time. Start on weekends, waking them up 30 minutes earlier every day, including school days, until the child reaches the desired wake-up time. Don't try to reshift them suddenly - for example, waking up a teenager at 5 a.m. like it's the military – because that doesn't work. They won't get used to it, since it's at odds with their internal clock. So, do it little by little. If that doesn't work, see a clinical provider.

What kind of treatments can a sleep clinician provide?

Fernandez-Mendoza: People should get help if they feel they sleep poorly, if they're fatigued during the day, or if they snore or grind their teeth. All these issues deserve attention.

Some people may think a sleep provider just prescribes expensive medcation, but that's not true. There are behavioral, non-drug-based treatments that work. Cognitive behavioral therapy is the first-line treatment recommended for insomnia. Light therapy may also help, which is the use of a bright light therapy lamp at a given time during the day or evening, depending on the person's sleep problem. (Courtesy: Scroll.in)

DBS works miracle for young-onset patient of Parkinson's Disease

arkinson's disease is a progressive disorder of the nervous system that affects the body movement. It has a gradual progression and usually starts with no symptoms or barely noticeable ones in either hand. Usually tremor in hands may be enough to justify the prevalence of Parkinson's but it can also be accompanied by stiffness or

slowing down or reactive movements. During the early stages, the face may show little or no expression, or arms may not swing when you walk, speech may become soft or slurred and the symptoms gets worse as the disease progresses. In such situations it is important to consult an experienced Neurosurgeon immediately.

How to identify the symptoms? Depending upon the person the signs and symptoms may vary. Early signs may be mild and may go unnoticed. Symptoms often begin on one side of the body and usually remain worse on that side, even after symptoms begin to affect both sides.

Parkinson's signs and symptoms may include a tremor or shaking of a limb, slowed body movement, muscle stiffness restricting the range of motion, impaired posture and balance, loss of involuntary movements, speech or writing

issues. What causes PD? In Parkinson's disease, certain nerve cells (neurons) in the brain gradually break down or die. Many of the symptoms are due to a loss of neurons that produce a chemical messenger in your brain called dopamine. When dopamine levels decrease, it causes ab-

normal brain activity, leading to signs of Parkinson's disease. The cause of Parkinson's disease is unknown, but several factors appear to play a role, including genetics, and environmental triggers like exposure to certain toxins.

How to diagnose? It is best to get it tested from an experienced Neurosurgeon based on the medical history, physical examination and review of the sign and symp-Imaging tests — such as MRI, ultrasound of the

brain, SPECT and PET scans — may also be used to help rule out other disorders. Imaging tests aren't particularly helpful for diagnosing Parkinson's disease. Sometimes it takes time to diagnose Parkinson's disease. Doctors may recommend regular follow-up appointments with Neurosurgeons trained in movement disorders to evaluate your condition and symptoms over time and diagnose Parkinson's disease


How to treat it?

In deep brain stimulation (DBS), surgeons implant electrodes into a specific part of your brain. The electrodes are connected to a generator implanted in your chest near your collarbone that sends electrical pulses to your brain and may reduce your Parkinson's disease symptoms.

Deep brain stimulation is most often offered to people with advanced Parkinson's disease who have unstable medication responses. DBS can stabilize medication fluctuations, reduce or halt involuntary movements (dyskinesias), reduce tremor, reduce rigidity, and improve slowing of movement. DBS is effective in controlling erratic and fluctuating responses to medication for controlling dyskinesias that don't improve with medication adjustments.

However, DBS isn't helpful for problems that don't respond to medication therapy apart from tremor. A tremor may be controlled by DBS even if the tremor isn't very responsive to medication.

Why DBS is preferred over medications? Medications are provided for temporary effect to subside the symptoms of PD. When a person is able



to enjoy the effect of the medicine, it is known as on-phase and when it subside its known as offphase. Over a period of time the effect of the medicines on the body tends to stop and hence the frequency of medicine intake increases. If a patient is prescribed to take the medicine thrice a day, then due to the loss of effect, they might need it more than 8 times a day. This affects their quality of life as they tend to get on and off that many times.

What DBS does is that it provides a constant effect to the patient for 24 hours. It avoids dyskinesia that is it prevents the halting of involuntary movements. Moreover DBS doesn't allow tremor fluctuations as in case of medicines. Medicines tend to end the effect unpredictably, and patients planning for their work or to go out for shopping may be at a risk of attack as the effect may subside any time which can impact their quality of life. Yemen Houthi rebels say US strikes kill 2 1 killed in Russian

Trump's bombing video suggests higher overall death toll

DUBAI, April 6: Suspected US airstrikes killed at least two people overnight in a stronghold of Yemen's Houthi rebels, the group said Sunday, while a bombing video posted by US President Donald Trump suggested casualties in the overall campaign may be higher than the rebels acknowledge.

The strikes in Saada killed two people and wounded nine others, with footage aired by the Houthis' al-Masirah satellite news channel showing a strike collapsing what appeared to be a two-story building. The Iranian-backed Houthis aired no footage from inside the building, which they described as a solar power shop.

The intense campaign of airstrikes in Yemen under Trump targeting the rebels over their attacks on shipping in Mideast waters stemming from the Israel-Hamas war has killed at least 69 people, according to casualty figures released by the Houthis.

However, the Houthis have not acknowledged any casualties from their security and military leadership — something challenged after an online video posted by Trump.

Early Saturday, Trump posted what appeared to be black-and-white video from a drone of a group of over 70 people gathered in a circle. An explosion detonates during the 25-second video, with a massive crater left in its wake

"These Houthis gathered for instructions on an attack," Trump claimed, without offering a location for the attack or any other details about the strike. "Oops, there will be no attack by these Houthis! They will never sink our ships again!"

The US military's Central Command, which oversees America's Mideast military operations, has not published the video, nor offered any specific details about the strikes it has conducted since March 15. The White



strikes so far targeting the Houthis.

The rebel-controlled SABA news agency in Yemen, citing an anonymous source, described the bombing as targeting "a social Eid visit in Hodeida governorate." Muslims across the world just celebrated Eid al-Fitr, the festival at the end of the holy Muslim fasting month of Ramadan. SABA had published images of other commanders meeting fighters during the holiday, though not any high-level Houthi officials.

"Those present at that gathering had no connection to the operations carried out by the (Houthis), which are implementing the decision to ban navigation on ships linked to the American and Israeli enemy," the SABA report said, adding that the attack killed and wounded "dozens."

However, the Houthis previously have not acknowledged any strike on Hodeida during

The SABA report also did not describe those killed as civilians, suggesting they did have ties to the rebels' security or military forces. Hodeida has been a site of Houthi attacks into the Red Sea.

Moammar al-Eryani, the information minister for Yemen's exiled government opposing the Houthis, claimed the strike killed some 70 Houthi fighters and leaders, as well as "experts" from Iran's paramilitary Revolutionary Guard.

He offered no evidence for the claim, though Iran has backed the Houthis in the war. Neither the Iranian government nor the Guard has not acknowledged the attack.

Mohammed al-Basha, a Yemen expert of the Basha Report risk advisory firm, cited social media condolence notices suggesting a colonel overseeing police stations for the Houthis in Hodeida had been killed in the strike Trump highlighted, alongside his two

"The strikes have expanded significantly, hitting multiple governorates simultaneously, alongside telecommunications infrastructure, command nodes, properties tied to senior Houthi leadership and previously untouched tunnel networks in mountainous areas," al-Basha told The Associated Press.

"We've also seen direct targeting of Houthi force gatherings, indicating a more aggressive and evolving shift in the targeting strategy," al-Basha said.

An AP review has found the new American operation against the Houthis under Trump appears more extensive than those under former US President Joe Biden, as Washington moves from solely targeting launch sites to firing at ranking personnel and dropping bombs on cities.

The new campaign of airstrikes started after the rebels threatened to begin targeting "Israeli" ships again over Israel blocking aid entering the Gaza Strip. The rebels have loosely defined what constitutes an Israeli ship, meaning many vessels could be tar-

The Houthis targeted more than 100 merchant vessels with missiles and drones, sinking two of them and killing four sailors from November 2023 until January of this year. They also launched attacks targeting American warships without success.

The attacks greatly raised the profile of the Houthis, who faced economic problems and launched a crackdown targeting dissent and aid workers in Yemen amid a decadelong stalemated war that has torn apart the Arab world's poorest nation.

The campaign shows no signs of stopping as the Trump administration repeatedly has linked its airstrikes on the Houthis to an effort to pressure Iran over its rapidly advanc-

from Pershing Square to City Hall. Demonstrators voiced anger over the administration's moves to fire thousands of federal workers,

close Social Security Administration field offices, effectively shutter entire agencies, deport immigrants, scale back protections for transgender people and cut funding for health programs.

Musk, a Trump adviser who runs Tesla, SpaceX and the social media platform X, has played a key role in the downsizing as the head of the newly created Department of Government Efficiency. He says he is saving taxpayers billions of dollars.

Asked about the protests, the White House said in a statement that "President Trump's position is clear: he will always protect Social Security, Medicare, and Medicaid for eligible beneficiaries. Meanwhile, the Democrats' stance is giving Social Security, Medicaid, and Medicare benefits to illegal programs and crush American sen-

Kelley Robinson, president of the Human Rights Campaign advocacy group, criticized the administration's treatment of the LBGTQ+ community at the rally at the National Mall in Washington, D.C., where Democratic members of Congress also took the

Khyber Pakhtunkhwa begins mapping Afghan nationals amid nationwide repatriation drive

PESHAWAR, April 6: The Khyber Pakhtunkhwa provincial government has started the mapping of Afghan citizens in line with the Pakistan government's policy to repatriate them to Afghanistan, officials said.

Thousands of Afghans have lived in the provincial capital Peshawar since 1978, when the Russian invasion of neighbouring Afghanistan led to a massive influx of refugees into Pakistan.

The Khyber Pakhtunkhwa government has deputed police to map and collect data on the whereabouts of Afghans, as the district administration here identified 160,000 people holding Afghan Citizens Cards

(ACC) who are set to be repatriated. Police say mapping of Afghans and other foreign nationals residing in Peshawar is underway and will help determine their exact numbers in specific areas.

for mapping in Peshawar, comprising officials from police, district administration, and departments. Of these over 200 are police officials.

Holding centres in Peshawar and Khyber districts are also being manned by police contingents.

However, a police official, wishing not to be named, said they have not yet received orders about Afghans living illegally in Peshawar. Afghans wanting voluntary repatriation will be repatriated, the police official said.

On Saturday, the Torkham border point in Khyber district saw the largest deportation of Afghans since April 1, when the government launched a nationwide operation to repatriate illegal foreigners.

Over 750 refugees, including men, women and children, were sent to Afghanistan after they were



and Islamabad. Officials at the transit centre in Khyber Pakhtunkhwa's Landi Kotal said the Afghan nationals were handed over to the Khyber police at the Karkhano Market checkpost in Peshawar.

The refugees were first taken to the NADRA (National Database and Registration Authority) desk and then shifted to the Torkham border to complete the deportation process. Officials at the transit centre noted a rise in the number of returning Afghans since the March 31 deadline for voluntary repatriation expired, as Punjab police intensified their crackdown on undocumented Afghan nationals in the province.

The assistant commissioner of Landi Kotal directed all Afghans residing in the tehsil to vacate their homes and return to Afghanistan, as per the federal government's order to expel all illegal foreigners.

Meanwhile, the Kohat administration has asked Afghan nationals, including illegal refugees and Afghan Citizen Card holders, to return to their country voluntarily.

According to official data, in rounded up in the Punjab province Kohat's eight camps, 100,000

Afghan refugees live, of which 16,000 got Afghan Citizen Cards from the United Nations High Commissioner for Refugees in

Kohat Additional Deputy Commissioner (ADC) (G) Hamid Iqbal, Superintendent of police (SP) (City) Farooq Zaman and other officials met with Afghan elders from three Ghamkol Sharif refugee camps on Saturday. They emphasised that Pakistan had hosted refugees for 40 years but it was time for them to return on their own in line with the government's decision. The ADC said authorities won't use force to send refugees to Afghanistan and would facilitate their return.

"Afghan refugees should understand Pakistan's economic and security compulsions under which they can't be hosted any further, so they should opt for voluntary repatriation," he said

Meanwhile, customs officials said that over the past three days, 519 vehicles transported export goods to Afghanistan, while an additional 85 vehicles carrying Afghan Transit Trade consignments were also dispatched. (PTI)

Unacceptable: UK on detention of 2 Labour MPs in Israel

LONDON, April 6: The British government has described as "unacceptable" the detention of two Labour Party members of parliament in Israel after being denied entry for a proposed visit to the West Bank as part of a parliamentary delegation.

Abtisam Mohamed, MP for Sheffield Central in northern England, and Yuan Yang, MP for Earley and Woodley in south-east England, said in a joint statement posted on social media on Sunday that they were "asounded" at the unprecedented step.

Israel's immigration authority said the entry had been denied because the UK government MPs intended to "spread hate speech" against Israel and were travelling to "document the security forces" amid the ongoing conflict with Hamas.



"It is unacceptable, counterproductive, and deeply concerning that two British MPs on a parliamentary delegation to Israel have been detained and refused entry by the Israeli authorities," said UK Foreign Secretary David Lammy

"I have made clear to my counterparts in the Israeli government that this is no way to treat British parliamentarians, and we have been in contact with both MPs tonight to offer our support. The UK government's

focus remains to secure a return to the ceasefire and negotiations to stop the bloodshed, free the hostages, and end the conflict in Gaza," he said. The MPs said their trip was organised with UK charities that had "over a decade of experience in taking parliamentary delegations".

Yemen-born Mohamed and British Chinese Yang have both made several interventions in the Israel-Hamas conflict in the House of Commons since being elected for the first time last year.

"We are two, out of scores of MPs, who have spoken out in the parliament in recent months on the Israel-Palestine conflict and the importance of complying with international humanitarian law," their joint statement

"Parliamentarians should feel free to speak truthfully in the House of Commons, without fear of being targeted," they said. Mohamed was born in Yemen. She is the first Arab woman to be

elected as a British MP. Yang is the first Chinese-born British citizen to be elected to the UK

Elon Musk says he hopes for zero tariffs with Europe someday

WASHINGTON, April 6: Billionaire Elon Musk told Italy League leader Matteo Salvini on Saturday that he hoped in the future the US and Europe could create "a very close, stronger partnership" and reach a "zero-tariff zone.

Musk spoke to Salvini in a video conference during the League's congress in Florence. Salvini is the leader of the farright, anti-migrant League party and vice premier of the Italian conservative government led by Premier Giorgia Meloni.

He said that, ideally, there will be a "zero-tariff zone in the future with a free trade zone between Europe and North America." Musk, an adviser to President Donald Trump who owns Tesla, SpaceX and the social media platform X, has played a key role in government downsizing as the head of the newly created Department of Government Efficiency.

Prime Minister Keir Starmer and French President Emmanuel Macron agreed Saturday that a trade war was in no one's interest as they discussed the fallout from the sweeping tariffs announced earlier this week by President Donald Trump.

Starmer and Macron discussed the global economic and security impact of the tariffs, particularly in Southeast Asia, Starmer's office said in a statement released after a phone call between the two leaders. "They agreed that a trade war was in nobody's interests, but nothing should be off the table and that it was important to keep business updated on developments," the statement said.

The leaders also discussed efforts to build a coalition of countries willing to support Ukraine in its war against Russia and provide peacekeeping forces in the event a ceasefire is reached. "Following discussions between mili-

tary planners in Ukraine this week, they discussed the good progress that has been made on the Coalition of the Willing," the statement said. The baseline 10% levy announced by Trump this week kicked in at 12:01 am Saturday ET (0401 GMT), triggering customs agents' collections at ports of entry across the U.S.

Countries targeted by Trump for higher tariffs are due to go in effect on Wednesday. Those include assessments as high as 50% for Lesotho, 49% for Cambodia and 47% for Madagascar.

others with sincerity and taking trust as the basis. We do not provoke trouble, but we are not afraid of trouble. Pressure and threats are not the right way to deal with China. China has and will continue to take firm measures to safeguard its sovereignty, security and development interests." the statement said.

On Saturday Trump was at his golf course in Jupiter, Florida. It's his first time visiting the club since his second term started. Spotted in his motorcade, in his signature red MAGA hat and white polo shirt. Trump was reading a tabloid article about China's response to U.S. tariffs.

"They, and many other nations, have treated us unsustainably badly," Trump said on Truth Social. "We have been the dumb and helpless "whipping post," but not any longer.

Italian Economy Minister Giancarlo Giorgetti warned that imposing retaliatory tariffs on the United States would be dam-

aging for both Italy and Europe. Speaking at a business forum in Cernobbio, near Milan, Giorgetti said Saturday that Italy is working for a "de-escalation" with the U.S. following Trump's announcement of a general tariff

of 20% on European Union countries. "We should avoid launching a policy of counter-tariffs that could be damaging for everyone and especially for us," Giorgetti said. "Our message is that we need to avoid pushing the panic button. ... We are following a pragmatic and rational approach." (AP)

Generational shift ongoing process in Cong: Pilot ahead of AICC session

NEW DELHI, April 6: Ahead of the AICC session in Ahmedabad, Congress general secretary Sachin Pilot on Sunday said a generational shift was underway in the party with young leaders living up to the tasks entrusted to them, and asserted that accountability as well as strengthening of ideology would be the watchwords going forward.

In an interview with PTI, Pilot said the All India Congress Committee (AICC) session taking place in Gujarat is significant as it comes at a time when the focus is on strengthening the party in that state and restoring its past glory there.

The former Union minister also asserted that while the party may have lost some state polls after the Lok Sabha elections, it has not lost the conviction or the vigour to fight on.

Asked if the time has come for a generational shift within the party, Pilot said any shift is never overnight but a gradual one.

'The party has committed itself to strengthening the backwards, young people, women, Scheduled Castes, Scheduled Tribes, and minorities. These are the sections that form the largest chunks of our population and adequate representation of those sections is crucial," he said

"At the party forum, we adopted the Udaipur declaration and are adhering to that. In all party appointments we are keeping that declaration in

"The (generational) shift is happening automatically, there are many people who are now taking people appointed in AICC, young people are now taking on leadership roles and are living up to the

task," Pilot told PTI over phone from Jaipur. Noting that the party had declared at its Belagavi conclave in December that 2025 will be the year of organisational empowerment, Pilot said the focus was on organisational reforms, filling up of vacant posts and making sure the party sticks to the Udaipur declaration by giving young people more political power.

"Mr Rahul Gandhi, Mr Mallikarjun Kharge and Priyanka (Gandhi Vadra) ji are taking active interest in the functioning of the party, departments and frontal organisations like the IYC, NSUI, Sewa Dal, Mahila Congress and so on.

"We have committed ourselves to making 2025 as the year of rejuvenating and enthusing the party cadre. We are going to see more ideological strengthening of the party, giving effective people more responsibilities and ensuring that those who are not up to the task make way for people that are working hard and performing," Pilot said.

Whether accountability would be the watchword going forward for the party, Pilot shot back, saying "it has to be"

Giving responsibility is one thing but every person, when he or she is given a job, has to be accountable, he stressed.

'There will be a constant review of who's performing and not performing. For example, in Rajasthan we have taken a decision that any office



bearer of the party who does not attend three party meetings consecutively without proper reason, that person has to let go and give space to someone else," the Congress general secretary said.

Pilot said in the meetings at the Indira Gandhi Bhawan here, it has been decided that District Congress Committee chiefs will be given a much larger role and they will have more involvement in elections, financial management and selection process of candidates for elections.

All those aspects have been there before also but will be much more enhanced in the future, he

On Congress persons switching sides around the Lok Sabha polls and after that, Pilot said organisations are bigger than individuals and people come and go according to their likes and dislikes and political compulsions.

But the Congress is one of the oldest political

serve the people whether in power or in the opposition remains intact, he said

"How to sharpen it, how to strengthen it, how to get more young people join the Congress fold is obviously a constant effort from the top leadership...The BJP has used central agencies to subjugate, defame, threaten, lure and character assassinate leaders from the opposition, especially from the Congress," he said.

"Gujarat has always been a Congress bastion. However, in the last two decades or so we haven't been able to win elections but our vote share has been very strong there and it is bipolar politics in Gujarat. Mr Gandhi has made several visits to the state recently also. I think he and Mr Kharge have taken it upon themselves that we have to revive, strengthen and restore the Congress' past glory in Gujarat," Pilot said.

Prez Murmu embarks on state visit to Portugal, Slovakia amid shifting global trade dynamics

NEW DELHI, April 6: President Droupadi Murmu set off on a state visit to Portugal and the Slovak Republic on Sunday, marking the first such visit in nearly three decades.

Her tour comes at a time of significant global economic change, with trade tariffs recently imposed by the United States reshaping international commerce and India's growing engagement with Europe.

In February, European Commission President Ursula von der Leyen and the College of Commissioners visited India. New Delhi has expressed hope of finalising the India-EU free trade agreement this year.

In a tweet on X, Ministry of External Affairs spokesperson Randhir Jaiswal said, "President Droupadi Murmu emplanes on state visits to Portugal and the Slovak Republic. These are the first state visits to either country by the President of India in more than 25 years. The visits will further expand India's multi-faceted engagement with two important EU partners.'

Murmu's two-day "landmark" visit to Portugal, which coincides with the 50th anniversary of diplomatic relations between New Delhi and Lisbon, comes 27 years after an Indian president last visited the nation.

President Murmu will engage in meetings with top leadership including Portugal's President Marcelo Rebelo de Sousa, Prime Minister LuÃs Montenegro and Assembly Speaker Dr José Pedro Aguiar-Branco.

Mayor of Lisbon Carlos Manuel Félix Moedas will host a special event for President Murmu. She will also attend a banquet hosted by Presi-

"Trade between India and Portugal is valued

at USD 1.5 billion and has been growing steadily with a 50 per cent increase over the last five years," said Tanmaya Lal, Secretary (West) at the Ministry of External Affairs, on Friday while

briefing the press about the visit. "We are seeing expansion in cooperation across renewable energy, IT, pharmaceuticals, education, tourism, and defence," he had said.

He also said that Portugal has always played a very important role in deepening the India-EU partnership. Asked about the possibility of the discussions on India-EU free trade agreement, Lal had said, "Yes, the areas of mutual interest will be discussed."

"In 2000, during the Portuguese Presidency, the first India-EU Summit was hosted by them. Also in 2021, the first-ever Leaders' Summit between India and the EU, where all the leaders from all individual EU partner countries attended this summit. So the India-Portugal relationship has a very strong element of India-EU partnership," Lal had said.

During her visit to Portugal, President Murmu will interact with a cross-section of Indian community members including researchers working in various Portuguese institutions.

The Indian community in Portugal numbers approximately 1,25,000, including over 35,000 Indian nationals and 90,000 persons of Indian origin. The community, spread across Lisbon, Algarve, and Porto, has become an integral part

of Portugal's social and economic landscape. President Murmu will also offer floral tributes at the statue of Mahatma Gandhi at the 'Alameda Mahatma Gandhi' (Avenue). She will also attend a community reception before moving to her second leg of the visit to the Slovak Republic on April 9 and 10.

"There are deep connections, especially with Sanskrit studies in Slovakia. Mahatma Gandhi's works have been translated into Slovak, and Slovakia offered valuable support during the evacuation of Indian students from Ukraine in 2022," Lal noted. During her visit to Slovakia, President Murmu will hold delegation-level talks and meet Slovak President Peter Pellegrini, Prime Minister Robert Fico, and the Speaker of the National Council Richard Rasi.

Her engagements include a visit to the stateof-the-art Tata Motors Jaguar Land Rover (JLR) facility in Nitra, a testament to the strong industrial ties between Slovakia and India. Inaugurated in 2018, the JLR plant has a capacity to produce 1,50,000 vehicles annually, with an investment of Euro 1.4 billion. As part of her diplomatic tour, President

Murmu will participate in a traditional bread and salt ceremony, an ancient Slovak custom symbolizing life and health. She will also meet Indian community members in Slovakia. There are around 6,000 Indians living and working in the Central European nation. (PTI)

PM should allay fears of TN over delimitation exercise: Stalin

UDHAGAMANDALAM (TAMIL NADU), April 6: Prime Minister Narendra Modi should allay the fears of people of Tamil Nadu surrounding the proposed delimitation exercise, Chief Minister M K Stalin said here on Sunday

Modi should also ensure that a resolution is passed in the Parliament to make sure the rights of Tamil Nadu are not curbed, he said at an official event here.

Stalin, after inaugurating a slew of projects and announcing new schemes to the popular tourist spot here, said he has sought an appointment with the Prime Minister to present the memorandum on the concerns surrounding the proposed delimitation.

"We have sought an appointment to present the memorandum on the delimitation... Since I am taking part in this government function I have conveyed to the PM about my inability to take part in his meeting and deputed our Ministers Thangam Thennarasu and Raja Kannappan. Through this meeting and through you, I hereby seek the Prime Minister to allay the fears of delimitation," Stalin said while addressing the gath-

He was referring to Modi's visit to Tamil Nadu's Rameswaram on Sunday where the PM inaugurated the new Pamban bridge.

'You (Modi) should also ensure that a resolution in this regard is passed in the Parliament. This (delimitation) not only leads to a reduction of Parliamentary seats, it is our right to ask and at the same time, it is also a cause of worry about our future," she said.

"Including Puducherry there would be 40 Parliamentary seats. But the ruling BJP government is trying to shrink our voices through delimitation."

Stalin said a Joint Action Committee meeting on fair delimitation was conducted on March 22 in Chennai and saw the participation of Chief Ministers, Deputy Chief Minister and prominent leaders representing various political ideologies across India.

In his brief address to the gathering, Stalin emphasized that Prime Minister Modi must provide a clear guarantee that Tamil Nadu, along with other states that have effectively managed population growth, will not be penalized in the upcoming delimitation process.

Their (Tamil Nadu's) share of parliamentary seats in percentage terms will remain untouched. He should make this promise publicly, allay the fears in the minds of the people of Tamil Nadu and follow it up with a constitutional amendment in Parliament. This is the only way to ensure a fair delimitation," Stalin said.

He recalled that Tamil Nadu was the sole state to oppose the delimitation exercise, alleging that the Centre had conspired to reduce the state's parliamentary representation. "If (Delimitation in the present form) has been established it will cause a huge loss for the state in the Parliament," he warned.

The CM noted that his party's MPs have raised concerns in Parliament over the delimitation issue, the alleged imposition of Hindi, and the allocation of funds to Tamil Nadu.

Earlier, Stalin inaugurated and inspected a new 700bed healthcare facility at the Government Medical College Hospital in the district, which was built with an investment of Rs 143.69 crore.

He acknowledged that constructing a hospital in a hilly region like Udhagamandalam was challenging, but credited the efforts of Minister E V Velu (Minister for Public Works) for making the project a reality

Taking a dig at the previous AIADMK government, Stalin said a proposal to establish a medical hospital was mooted by the then Chief Minister (Edapadi K Palaniswami), but it was only implemented during the current regime.

During his visit to the hill station, Stalin also announced a slew of projects to Udhagamandalam, which includes a multi-level car parking facility, 'Hopon, Hop-off' tourist bus facility among others. (PTI)

Judge conducting trial in 2008 Malegaon blast case transferred, victims say it will delay justice

MUMBAI, April 6: Special NIA court judge AK Lahoti, conducting trial in the 2008 Malegaon blast case, has been posted to Nashik in the annual general transfer of district judges, days before the court was likely to reserve the matter for judgment. The transfer order for Lahoti and other judges issued by the registrar general of the Bombay High Court will come into effect when

the courts re-open after summer vacation on June 9.

Victims, however, said Lahoti's transfer would further delay justice, and they are planning to approach the Bombay High Court, requesting an extension for the special judge. Lahoti is the fifth judge to be transferred in the 17-year-old case. The order has mentioned that the judicial officers who are under the order of transfer are "directed (a) to finish by judgments all cases in which hearing has already been concluded and (b) should endeavour to dispose of all part-heard cases before handing over charge'

In the last hearing on Saturday, judge Lahoti directed the prosecution and defence to wrap up the remaining arguments by April 15 and was expected to reserve the matter for judgment the following day, a defence lawver said. Advocate Shahid Nadeem, representing the victims, said, "We are considering filing an application in the high court. We had earlier submitted a letter to the chief justice requesting an extension of his (judge's) tenure until the judgment is passed.'

He said the justice has already been delayed, and the presiding judge's transfer will cause more delays. "In the interest of justice, we will decide after con-



sulting with senior advocates," he added.

India is home to about 16 per cent of the world's women, but it accounts for about a quarter of all cervical cancer cases and nearly a third of global cervical cancer deaths.

Indian women face 1.6 per cent lifetime cumulative risk of developing cervical cancer and 1 per cent cumulative death risk from cervical cancer, officials had stated According to some recent esti-

mates, almost 80,000 women develop cervical cancer and 35,000 die due to this cancer in India every year. (PTI)

Mumbai Indians will hope the batters will get their act together to shoulder responsibility when they take on an inspired Royal Challengers Bengaluru in an Indian Premier League match here on Monday. With three defeats in four games marking yet another poor start for the five-time winners, Mumbai Indians are grappling with batting woes. Only two MI batters have hit half-centuries so far in four matches, with Suryakumar Yadav and Ryan Rickelton recording one each. Among all the 10 IPL teams, this is the least number of contributions in terms of fifties per batter.

Scoring fifties has always been tough in T20 cricket, but IPL teams have increasingly moved towards being top-heavy with their best batters getting most overs to face and looking to bat through.

At the centre of MI's struggles with the bat are former skipper Rohit Sharma, who missed the last game against Lucknow Super Giants due to a blow to his knee at the nets after a poor start to the IPL, and middle-order batter Tilak Varma, whose starts haven't converted into big scores. It remains to be seen if Rohit is fit for the clash against RCB but MI will certainly need a quick fix to their batting woes and would need Suryakumar to continue doing the heavy lifting.

With 177 runs to his kitty, the India T20I captain has been MI' best vital cog in this RCB line up. The

NEW DELHI, April 6: The Indian boxing contingent ended their campaign at the World Boxing Cup with an impressive haul of six medals, including a gold won by Hitesh, at Foz Do Iguacu in Brazil.

It's India's first-ever outing in an elite-level international meet organised by World Boxing.

Hitesh became the first Indian boxer to clinch a gold medal in the World Boxing Cup. His opponent Odel Kamara of England was injured and couldn't take to the ring in the 70kg final on Saturday. Abhinash Jamwal, the other Indian boxer to reach the final in the 65kg category, gave his best against local favourite Yuri Reis but could not do enough to get a favourable verdict and bagged a silver medal.

Four Indians -- Jadumani Singh Mandengbam (50kg), Manish Rathore (55kg), Sachin (60kg) and Vishal (90kg) --

SUZUKA (JAPAN), April 6: ing. And there was only one in-Max Verstappen won Sunday's Japanese Grand Prix to break a "mini-slump" of two wins from 16 races but needed a drive that his Red Bull team engineer called "perfection" to get it

It was Verstappen's fourth straight victory on the Suzuka circuit in central Japan and breaks the momentum of the McLarens of Lando Norris and Oscar Piastri, who won the season's first two races in Australia and China.

"We still have work to do," Verstappen said. "But it does show if we nail everything we can be up there." He did just that.

The four-time defending Formula 1 champion, Verstappen started from pole position after setting a course-record time in qualifying, which he called "insane." Norris placed second and Piastri was third. The track was dry despite rain earlier in the day to produce an incident-free
