

Punjab Police takes custody Gaurav bats for backing loyal Congmen to win polls of Papalpreet Singh

HT Correspondent DIBRUGARH, April 9: The Punjab

Police on Wednesday took custody of Waris Punjab De member Papalpreet Singh from Dibrugarh Central Jail following the completion of his detention under the National Security Act (NSA).

A team from the Punjab Police had sought permission for his custody and transit remand from the Court of the District and Sessions Judge, Dibrugarh. After receiving approval, the police team took custody of Singh from the iail.

Before his transfer, Singh underwent a medical check-up at the Assam Medical College and Hospital (AMCH).

A senior police official stated that Singh would spend the night in the lock-up at Dibrugarh Police Station and would be flown to Punjab on Thursday under heavy security.

"In Punjab, he will be tried for the Ajnala police station attack case along with other Waris Punjab De members," the official added.

Singh was brought to Dibrugarh Jail

from Punjab on April 11, 2023. It may be mentioned that eight Waris Punjab De members lodged in Dibrugarh Jail were already shifted to Punjab last month following the expiry of their

NSA detention period. Those shifted include Kulwant Singh Dhaliwal, Harjeet Singh, Gurinderpal Singh Aujla, Gurmeet Singh Bukkanwala, Bhagwant Singh, Daljeet Singh Kalsi, Basant Singh, and Varinder Singh Johal. They are now facing trial in Punjab for their alleged involvement in the 2023 Ajnala police station attack

Significantly, with Singh's transfer, only Waris Punjab De chief Amritpal Singh remains in the high-security Dibrugarh Jail. His NSA detention period is set to expire on April 22. If not extended by the Punjab government, he is also likely to be shifted to Punjab.

It may be recalled that Amritpal Singh won the Khadoor Sahib Lok Sabha seat in the 2024 general elections while still under detention in Dibrugarh

India, China moving in 'positive direction': EAM Jaishankar

NEW DELHI, April 9: India and China are moving towards a "positive direction" in their ties and work needs to be done to normalise the relationship, External Affairs Minister S Jaishankar said on Wednesday.

"I think we are moving in a positive direction," he said.

India-China relations plunged to their lowest point since the 1962 war following the Galwan Valley clashes.

Following a series of diplomatic and military talks, the two sides withdrew their troops from several friction along the Line of Actual Control (LAC) in eastern Ladakh

In October last, the two sides firmed up a disengagement pact for Depsang and Demchok, the last two friction points in eastern Ladakh.

"It's obviously better than the last time I was here. I think the disengagement, particularly the Depsang-Demchok was important," he said at the News 18 Rising Bharat Summit.

Davs after the agreement was finalised, Prime Minister Narendra Modi and Chinese President Xi Jinping held talks in Kazan and took a number of decisions to improve the ties.

Jaishankar suggested that issues on the border remained to some extent because of the force build up over a period of years.

"But there were many other things which also happened during this period some of it was a collateral of the situation: some of it was actually a carryover from the Covid era. For example, our direct flights stopped during Covid, they were not resumed," he said.

"The Kailash Mansarovar Yatra stopped during Covid. It did not again resume. I think there is work to be done. We are at it," he said.

"We are sort of trying to see whether lot of this post-Covid and parallel to the border tension, the combination of these issues -- how much we can progress on this," Jaishankar added.

The external affairs minister said both sides are looking into these issues.

"We are looking at it because at the end of the day we have always maintained that the situation, which we saw between 2020 and 2024, was not in the interest of either country," he said. "It was not in the interest of our re-

lationship. And I think there is a recognition of that now," he added.

Last month, India and China explored ways to rebuild ties and agreed to initiate efforts to promote people-topeople exchanges, including arrangements for resumption of direct flights and resume Kailash Manasarovar Yatra this year.

In December NSA Ajit Doval travelled to Beijing and held talks with Foreign Minister Wang under the framework of Special Representatives (SR) dialogue on the boundary ques-

In January, foreign secretary Vikram Misri visited Beijing and held talks with his Chinese counterpart Sun Weidong. (PTI)

Forest officials seize smuggled logs near Assam-Meghalaya border

HT Correspondent KHERONI, April 9: Forest officials from the Southern Range, Kheroni, in West Karbi Anglong district conducted a raid on Tuesday night and seized a truck carrying illegally felled logs in Umkhermi village, near the Assam-Meghalaya border.

The operation followed a tip-off about the illegal transportation of timber.

A Meghalaya-registered truck (ML 04 6133), bound for Meghalaya, was seized and brought to the Southern Range office in Kheroni. However, the timber smugglers managed to flee the spot, and no arrests were made.

Deputy Ranger Sushil Sarkar, who led the raid, said the perpetrators-often from Meghalaya-



destroying forests in Assam to smuggle logs into the neighbouring state.

"We received information about illegal activities in Umkhermi and immediately alerted the staff at the Mukoilum sub-beat office. They have long been engaged in acted promptly and succeeded in

NEW YORK, April 9: Mumbai terror attack accused Tahawwur Rana is expected to be extradited to India from the US "shortly", sources have said

According to government sources in India, a multi-agency team from India has gone to the US and all paperwork and legalities are being completed with US authorities.

Sources said "very high possibility" that Rana "could be extradited shortly."

It is also learnt that Rana is not coming to India on Wednesday and the extradition process is in the works.

The hugely significant development comes just days after Rana's last-resort attempt to evade extradition to India failed after the US Supreme Court justices denied his application, moving him closer to being handed over to Indian authorities to face justice in the dastardly attacks.

Rana, 64, currently lodged in the Metropolitan Detention Center in Los Angeles, had submitted an 'Emergency Application For Stay Pending Litigation of Petition For Writ of Habeas Corpus' on February 27, 2025 with Associate Justice of the Supreme Court of the United States and Circuit Justice for the Ninth Circuit Elena Kagan.

Rana had then renewed his 'Emergency Application for Stay Pending Litigation of Petition for Writ of Habeas Corpus previously addressed to Justice Kagan', and requested that the renewed application be directed to US Chief Justice John Roberts.

An order on the Supreme Court website noted that Rana's renewed application had been "distributed for Conference" on April 4 and the 'application" has been "referred to the Court." A notice on the Supreme Court website Mon-

day said that "Application denied by the Court." New York-based Indian-American attorney Ravi Batra had told PTI that Rana had made his

application to the Supreme Court to prevent extradition, which Justice Kagan denied on March 6th. The application was then submitted before Roberts, "who has shared it with the Court to conference so as to harness the entire Court's view.

The Supreme Court justices are Associate Justice Clarence Thomas, Associate Justice Samuel A Alito, Jr, Associate Justice Sonia Sotomayor, Associate Justice Elena Kagan, Associate Justice Neil M Gorsuch, Associate Justice Brett M. Kayanaugh, Associate Justice Amy Coney Barrett, and Associate Justice Ketanji Brown Jackson.

In his emergency application, Rana had sought a stay of his extradition and surrender to India pending litigation (including exhaustion of all appeals) on the merits of his February 13.

In that petition, Rana argued that his extradition to India violates US law and the UN Convention Against Torture "because there are substantial grounds for (CONTD. ON PAGE 2)

LONDON, April 9: India offers a compelling growth opportunity for foreign banks, Finance Minister Nirmala Sitharaman told investors in the UK.

Sitharaman's remarks came as she chaired an India-UK Investor Roundtable in London, attracting around 60 UK investors representing various pension funds, insurance companies, banks and other financial institutions.

According to the Ministry of Finance, the high-level roundtable on Tuesday evening outlined the priorities of the government for enabling sustained economic growth and investment opportunities, with the policy support that is shaping "New India'

It highlighted the efforts being made by the ministry to pursue process and governance reforms to



reduce compliance burden and ease banks and the government of India regulation for facilitating an enis actively encouraging foreign inabling environment for business vestment in the banking sector," Sitharaman told the gathering. and investments With an expanding middle class

"India offers a compelling growth opportunity for foreign and strong and stable policy envi-

ronment, the Union Finance Minister said that India is set to become the sixth-largest Insurance market by 2032 with the expected growth at 7.1 per cent CAGR from 2024-2028 — one of the fastest growing insurance markets among G20 countries, the Ministry of Finance readout said.

Home, auto loans to get cheaper as RBI cuts interest rate for 2^{nd} time in a row

MUMBAI, April 9: Home, auto and other loans are likely to cost less as the Reserve Bank of India (RBI) cut interest rates on Wednesday for a second consecutive time and signalled more easing to come as it sought to bolster the economy that is facing further pressure from damaging US tariffs.

The Monetary Policy Committee (MPC), consisting of three central bank members and an equal number of external members, voted unanimously to cut the repurchase or repo rate by 25 basis points to 6 per cent. It had reduced rates by an equal measure in February -- the first cut since May 2020.

The repo rate is the rate at which the RBI lends money to banks to meet their short-term funding needs. With a 25 bps cut in the repo rate, all external benchmark lending rates (EBLR) linked to it will come down. And if the banks fully pass on this to the borrowers, equated monthly instalments (EMIs) on home, auto and personal loans will decline by 25 bps. The move lowers borrowing costs to the lowest level since November 2022, amid easing inflation and a fall in oil prices.

RBI changed its policy stance to "accommodative" from "neutral", indicating the possibility of more rate cuts in future, Governor Sanjay Malhotra said while announcing the MPC decisions.

The rate cut came on a day when the full 26 per cent additional tariffs on Indian goods exported to the US came into effect. The US tariffs exacerbate uncertainties, with some economists predicting a 20-40 basis point drag on Indian GDP growth in the current fiscal year that started on April 1.

RBI also lowered its estimate for economic growth to 6.5 per cent for 2025-26 fiscal year from



6.7 per cent earlier. The inflation projection was also lowered to 4 per cent from 4.2 per cent, keeping it within the target range of 2-6 per cent

The Indian economy grew by 6.5 per cent in the fiscal year ended March 31 (2024-25), its weakest pace since the pandemic.

"The recent trade tariff-related measures have exacerbated uncertainties clouding the economic outlook across regions, posing new headwinds for global growth and inflation," he said. "Amidst this turbulence, the US dollar has weakened appreciably; bond yields have softened significantly; equity markets are correcting; and crude oil prices have fallen to their lowest in over three years."

Under these circumstances, central banks are navigating cautiously, with signs of policy divergence across jurisdictions, reflecting their own domestic priorities. State Bank of India (SBI) chairman CS Setty said the revision of stance to accommodative will cushion the secondary impact of tariffs on the domestic econ-

DK Srivastava, Chief Policy Advisor, EY India, said the central bank recognises that global uncertainties will have an adverse impact on India's growth prospects.

"However, a periodic injection of monetary stimulus supported by maintenance of adequate liquidity conditions and healthy domestic economic conditions, including robust agricultural prospects, will help India maintain a reasonably

Governor said, has made steady progress towards the goals of price stability and sustained growth. Growth is improving after a weak performance in the first half of the financial year 2024-25, although it remains lower than expected.

On the inflation front, while the sharper-than-expected decline in food inflation has given comfort, 'we remain vigilant to the possible risks from global uncertainties and weather disturbances", Malhotra said. Explaining the meaning of

change in policy stance, he said, "The change in stance means MPC intends only the status quo or rate cut.'

Since taking office in December, Malhotra has pivoted to a more growth-friendly approach than his predecessor Shaktikanta Das, who was more focused on containing price rise (inflation). The new governor cut rates in his debut policy meeting in February, and has injected more than USD 80 billion into the banking system in the last two months.

Lower interest rates provide relief to businesses and consumers alike, potentially spurring credit demand, investments, and job creation. Commenting on the MPC decision, Upasna Bhardwaj, Chief Economist, Kotak Mahindra Bank, said, "The increasing global turmoil and its spillovers to the Indian growth slowdown will necessitate the MPC for deeper rate

cuts. "We see scope for additional 75-100 basis point rate cuts in the year ahead, depending on the scale of global slowdown." Radhika Rao, Executive Director and Senior Economist at DBS Bank, said recent liquidity management measures have under-

scored the preference to maintain a surplus balance, thereby keeping the banking system well-oiled and aiding policy transmission.

"Overall, policy guidance remained dovish, while keeping an eye on global uncertainties and the consequent need to maintain stability in domestic financial markets. We expect a further 50 bp of cuts this year," Rao said.

On the impact of global trade and policy uncertainties on growth and inflation, the RBI governor said uncertainty in itself dampens growth by affecting investment and spending decisions of businesses and households.

The dent on global growth due to trade frictions will impede domestic growth, Malhotra said, adding higher tariffs shall have a negative impact on net exports.

There are, however, several known unknowns - the impact of relative tariffs, the elasticities of our export and import demand; and the policy measures adopted by the government including the proposed Foreign Trade Agreement with the USA, to name a few. These make the quantification of the adverse impact difficult," he said.

The risks to inflation are two sided. On the upside, uncertainties may lead to possible currency pressures and imported inflation. On the downside, slowdown in global growth could entail further softening in commodity and crude oil prices, putting downward pressure on inflation. "Overall, while global trade and

policy uncertainties shall impede growth, its impact on domestic inflation, while requiring us to be vigilant, is not expected to be of high concern," he said. (PTI)

India emerging as a stable growth hub amid global uncertainty: NSE Chief Ashishkumar Chauhan \$19.6 billion—the highest globally,

HT Bureau GUWAHATI, April 9: Ashishkumar Chauhan, Managing Director and CEO of the National Stock Exchange of India (NSE), shared an optimistic outlook on India's financial markets amid global challenges at the India Global Forum, Mumbai NXT25, through an official statement on Wednesday.

Chauhan highlighted the resilience of Indian markets, despite a \$1.5 trillion drop from their peak, emphasizing the country's robust long-term growth trajectory. "In 2014, India's market capitalization was under \$1 trillion. Today, it is approaching \$5 trillion, reflecting significant wealth creation," he noted, underscoring the substantial progress India has made in capital market growth.

Responding to concerns over foreign investor exits, Chauhan attributed the trend to global interest rate hikes and a broader 'risk-off' sentiment that has impacted emerging markets. However, he reassured stakeholders that India remains relatively insulated from global tariff

RBI not to tighten gold loan

norms but rationalise it: Guv

MUMBAI, April 9: Reserve Bank Governor Sanjay Malhotra on Wednesday said the proposed guidelines on gold loan are not going to tighten such lending but rationalise it. "The (draft) guidelines will be issued soon. To our mind, there is no tightening. It is a rationalisation only. It's broadly on the conduct side, primarily, whatever were the guidelines for NBFCs, those have been extended now to the banking sector also," he said during a media interaction here. The RBI will publish draft guidelines for the consultation and then based on feedback it will be finalised

Earlier in the day, the governor, while unveiling first bi-monthly monetary policy for the current financial year, said loans against the collateral of gold jewellery and ornaments, commonly known as gold loans, are extended by regulated entities for both consumption and income-generation purposes.

In order to harmonise guidelines across various types of regulated entities, to the extent possible, keeping in view their differential riskbearing capabilities, we shall issue comprehensive regulations on prudential norms and conduct-related aspects for such loans, he said. (PTI)

KBI signals more rate cuts amid economic uncertainty: HDFC Economist

GUWAHATI, April 9: In a recent commentary on the Reserve Bank of India's (RBI) latest monetary policy decision, Sakshi Gupta, Principal Economist at HDFC Bank, highlighted the central bank's shift toward a more accommodative stance in an official statement here on Wednesday.

The RBI's decision to implement a 25 basis points (bps) rate cut, coupled with a change in its policy stance to accommodative, sends a clear signal that more rate cuts may be on the horizon

Gupta anticipates two additional rate cuts in 2025, with the next one likely to come in the June policy

meeting. The continued improvement in liquidity conditions is expected to play a crucial role, as the average liquidity is forecasted to remain above neutral in the current quarter. This, she believes, will further drive the transmission of rate cuts into money market rates and deposit rates. "As liquidity conditions continue to improve, expected to average above neutral in the current quarter, transmission of rate cuts to money market rates and for deposit rates is also likely to increase," she said. However, the RBI's decision also takes into account the growing global economic risks, particularly due to tariff tensions. As a result, the central bank has revised its GDP growth forecast down by 20 basis points to 6.5%. Gupta cautioned that if global tensions continue to escalate, there could be additional downward pressure on growth projections. "Recognising the increasing global headwinds due to tariff tensions, the RBI revised down its GDP growth forecast by 20bps to 6.5%. If global tensions continue to escalate, we see a further downside risk to these projections," she added. Looking ahead to FY26, HDFC Bank expects GDP growth to be around 6.3%, assuming some retraction in current tariff announcements and successful bilateral negotiations. Gupta's analysis indicates that while the RBI's actions are aimed at supporting domestic economic growth, external challenges remain a significant factor in shaping future policy decisions.

Rana, a Canadian national of Pakistani origin, is known to be associated with Pakistani-American terrorist David Coleman Headley, one of the main conspirators of the 26/11 attacks.

During a joint press conference with Prime Minister Narendra Modi in the White House in February, President Donald Trump announced that his administration has approved the extradition of "very evil" Rana "to face justice in India"

A total of 166 people, including six Americans, were killed in the 2008 Mumbai terror attacks in which 10 Pakistani terrorists laid a more than 60-hour siege, attacking and killing people at iconic and vital locations in Mumbai. (PTI)

<u>HT Bureau</u> GUWAHATI, April 9: The Northeast Frontier Railway (NFR) has achieved an important milestone in the construction of new Road Over Bridge (ROB) at Panbazar, with the successful launching of a 60-meter Bow String Girder. This critical operation was executed flawlessly during a wellcoordinated 3-hour traffic block on the night April 8.

The new ROB, once completed, will replace the earlier structure built in 1965, which has already been dismantled. The old ROB had long posed structural and operational challenges. With limited vertical and horizontal clearances, the old bridge enforced a permanent speed restriction of 15 km/h and created a "dead wire zone" affecting electric locomotive operations. Also, recurrent water-logging dur-

ing heavy rains further disrupted train movements and passenger services in the vicinity. Designed to overcome these limitations, the new 60-meter span bridge will ensure enhanced clearances, eliminating speed restrictions and facilitating seamless movement of electric locomotives. Elevated track levels will mitigate waterlogging issues, ensuring smooth operations even during the monsoon season.

Beyond its technical upgrades, the project plays a strategic role in remodelling Guwahati station yard, paving the way for additional platforms and improved passenger amenities. The new three-lane wide carriageway-upgraded from the previous two-lane configuration-will ease road congestion and enhance urban traffic flow. Despite spatial constraints near

the Fire Brigade station impacting material storage and logistics, the project has advanced steadily till date. Key achievements include completion of foundational structures, fabrication and positioning of the bow string girders and innovative sub-soil strengthening through Geo-cell technology to ensure long-term durability and stability

Regular inspections by authorised agencies have upheld stringent quality and safety standards throughout the construction process. NFR General Manager Shri Chetan Kumar Shrivastava personally reviewed the project's progress and directed officials to ensure timely completion. With the successful girder launch, the ROB project now enters its final phase, set to significantly boost both rail and road connectivity in Guwahati.

The breakthrough came when they tracked Gowala to a hideout in Jalpaiguri, where they coordinated with West Bengal Police to execute the successful raid. Mukesh Gowala, widely known as a "chiloni thief" for his swift and stealthy operations, now faces charges related to multiple robberies.

His capture marks a significant win for the Dhubri Police in their continued efforts to combat crossborder criminal activities. Authorities are expected to gather further

information from Gowala, which may help in resolving additional cases involving similar criminal acts.

The successful operation has been hailed as a major victory for inter-state cooperation between the police forces of Assam and West Bengal, reaffirming their commitment to maintaining law and order across state borders.



Baby has his task cut out

year old CPI(M) politburo member Mariam Alexander Baby has taken over as the sixth general secretary of the Communist Party of India (Marxist) following his nomination at the 24th congress of the Party which concluded at Madurai on April 6. Baby is a veteran leader of the CPI(M) from Kerala with wide exposure both in the state and also in national politics. He was the education minister in the Kerala LDF government as also member in Rajya Sabha for two terms. Like his earlier two predecessors, Baby also joined the CPI(M) through students movement. It seems that the CPI(M) leadership chose M A Baby over the prominent peasant leader and present politburo member Dr. Ashok Dhawale taking into account two factors. First, Baby's familiarity with the national politics and political leaders due to his Rajya Sabha tenure and secondly, Baby can two terms even within the present 75 year limit for CC members. The new CPI(M) general secretary will be 74 in 2028 by the time the 25th party congress of the CPI(M) is held. So he has no problem for second term as per the present age ceiling. Baby is suave, media savvy and has good friends in the cultural world. His friendly manners and transparent approach were noted by us. He was unorthodox, a good listener and a communist with a liberal mind.

The big question is: will Baby be able to steer the CPI(M) at this critical period and impart dynamism among the party cadres. Can Baby arouse the same confidence among the INDIA Bloc partners as the former CPI(M) general secretary Sitaram Yechury could? As a part of the new strategy of the CPI(M) and the Left, he should talk with the other Left parties and work on mobilising the cultural workers and the groups from every region of the country under a national banner to fight against Hindutva on a priority basis. This will be far more impactful than the limited focus given in the political resolution on paying "special attention to organise anti-communal work through social and cultural activities among the working class and in the working class residential areas by the party and the trade unions".

The existing cultural organizations like IPTA of the CPI, CPI(M)'s own groups and the CPI(ML)-Liberation supported various groups in Bengal, Bihar and Jharkhand can be put under one broad banner to steer the course of the movement. Apart from this broad political task, the new general secretary will have to deal with the state assembly elections in Kerala in 2026. The win is of high importance to the CPI(M) because only Kerala remains as the only state presently ruled by the party as the leader of the Left Democratic Front. As regards West Bengal which is also going to polls along with Kerala, the issue is whether the state CPI(M) can break the jinx of present zero in the assembly to one or two seats. For the new CPI(M) general secretary challenges are too many. It is to be seen how he meets that in his present term

Rahul Gandhi is focusing on Bihar youth Mahavira: Spiritual hero of nonviolence and peace in a big way before Assembly polls

Dressurising the alliance partner to accrue more political and electoral benefit has certainly not been an alien concept. It has been in vogue for pretty long time. Obviously to look at the frequent visit of Rahul Gandhi to Bihar from the perspective of pressuring RJD to concede more seats to Congress during the October assembly election would be a flawed analysis. A weak political party is always vulnerable and it cannot be supposed to dictate the terms. Congress is not an exception.

Rahul's three visits to Bihar during the last three months ought to be seen and analysed in entirely new perspective. No doubt a strong Congress will create some kind of pressure on the big brother RJD for some more seats. But it cannot be expected to dictate RJD chief Lalu Yadav or Tejashvi. The fact also cannot be ignored that Congress has no sufficient number of winnable candidates. It even cannot claim to have that amount of strength which would ensure victory of its all candidates. The remark that Rahul made during his Monday visit to Bihar is quite significant; "Our aim is to draw the attention of the world to the plight of Bihar's youth, who find government jobs getting scarce day by day and privatisation bringing no benefits. Let us bring the government in the state under pressure and change it". It is intriguing to make out what prompted him to say "our aim is to draw the attention of world". Why the world should bother the plight and miseries of Bihar's vouths? What is the relation between the two? Youths of other states are also facing the problems of joblessness. But what is so special about Bihar that it should be brought to the attention of world?

In fact the answer to the vexed issue has come from him: "wanted to show the world the plight of youths of Bihar who have to migrate to other states in search of jobs." At a time when all the states have been achieving huge economic growth, Bihar has been languishing. The youths of Bihar has indeed been the most productive force and have been contributing to the socio-economic growth of other states, they were unable to help their own state. Bihar is incapable to help them in earning their livelihood in their own state. Why there is utter lack of job in Bihar?

As in other places, in Patna too, while addressing the Samvidhan Bachao Sammelan he lambasted the feudal and rich people for the exploitation of the poor. OBC, EBC, Dalits, Muslims and poor of the general castes. He pressed for caste census, and slammed RSS-BJP for opposing a castebased census and asserted Congress would ensure social justice by shaping policies

tacked RSS chief Mohan Bhagwat, saying, "Mohan Bhagwat says there is no need for a caste census. I want to tell him -- a castebased census is like an x-ray of society. It reveals the real picture of the population and helps frame inclusive policies." Ever since Rahul embarked on his Bharat

Bachao yatra, he had come to realise that the giving leverage to rich and feudal elements would prove to be disastrous for the Congress. It has to return to its old base of poor and dalit. The rich and upper caste people rallying behind RSS and BJP and pursuing the politics of Hindutva has made him conscious of the fact that these people could not be relied. They nurture of the feeling that BJP can protect their class interest. Obviously in the greater interest of the party and make it gain back its old credibility. Rahul chose the political line of setting a counter narrative to the politics of violence and hatred of saffron ecosystem. For this Congress has to be reformed. This issue was also raised by Rahul at the sammelan. He emphasised on internal reforms within the Bihar Congress. It implied a shift in leadership representation. He said "Earlier, two-thirds of our district presidents in Bihar were from upper castes. Under Mallikarjun Kharge's leadership, that has changed. Today, two-thirds come from OBC, EBC, Dalit, and Mahadalit communities. We've aligned leadership roles with population realities"

Urging party workers to connect with marginalized communities, Gandhi emphasized the need to build a people-centric political movement: "Bihar has always led transformative movements. This time too, Bihar will lead from the front". He tried to lay down an ideological critique: "This Constitution is not just a document from 1947 -- it reflects the values of our ancient

civilization. The ideology of Savarkar has no place in it: he never had the courage to face the truth." He underlined "fear and silence dominate national discourse. It's difficult to speak the truth these days. People know it, but many leaders are afraid to say it aloud". His observation that plight of Bihari youth should be brought to world ought to be seen in this perspective.

Rahul is not only the leader who has been frequently visiting Bihar. Narendra Modi who did not find time to visit Manipur even for once during the last two years, has been making frequent forays to Bihar. Shockingly the mainstream media which has been agog at Rahul's visit never sought to know why Modi has been regularly visiting Bihar. Of course like in other northern Indian states, Bihar has some regional parties, but it is Congress which is in direct contest with BJP. Any political development that takes

level. The youth of Bihar from pre-Independence days have been playing crucial role in transforming the politics. The latest being the Bihar Movement of Jay Prakash Narayan. It has completely transformed the Indian politics and the rise of BJP owes to this movement. While RSS and BJP's strategy has been to weaken and push back the Congress and win the Dalits and poor to their Hindu fold, the Congress is striving to make the youths join its rank. In latest political scenario the BJP appears to be a step ahead of Congress both in terms of long-term strategy and on-theground tactics. The Congress intends to reverse the model and it can only be done through new social coalition as the old social justice coalition has proved to be ineffective and having lost its direction. Under the old system all the groups are divided and have no pointed direction

If BJP aspires to bring together OBCs and the Dalit to check the rise of Yadavs, the Congress is working on the formula to bring all including the Muslims and poor General caste people on single platform. No other state except Bihar could be best laboratory for accomplishing this mission. It is also to be noted that while mainstream media has been trying to create confusion in the opposition camp by saying that Congress was pushing the RJD to corner. Rahul has made it explicitly clear that they would go to polls together under Mahagathbandhan banner. He said Mahagathbandhan will work for uplift of Dalits, EBCs, women of Bihar. Rahul addressing 'Samvidhan Suraksha Sammelan' (Save the Constitution symposium) in Patna, said: am confident that the people of Bihar would show a new direction to India again this time as they have always done.

His observation that people from weaker sections of society were being treated as second-class citizens ought to be taken seriously. In the past he had talked of exploitation and disparity, but probably this is for the first time he said that they were treated as second class citizens. Rahul had a made a significant departure from the old pattern of politics, when the parties would prefer to build caste equations and depend on caste leaders, was also evident from his thrust on youths. This is evident from his observation: "Young friends of Bihar, I will be coming to Begusarai on April 7 to join you in the 'Roko Palayan, Do Naukri' campaign, walking shoulder to shoulder with you. The goal is to show the world the spirit of Bihar's youth, their struggles, and their hardships. Come wearing a White T-Shirt, ask questions, raise your voice -- to put pressure on the government for your rights, to hold them accountable. others to live in himself. They were healthy. No disease could touch him. He gave many sources of health. One of them was the formula – Kavotsarga. Kayotsarga means purification of the body, maintenance of the body, purity and restraint towards the body. Kayotsarga is also the starting point of sadhana and it is also the final point. This is the first understanding of health and the final conclusion. It is the shield for emergency situations involving the body. It is the use of stress-immersion and is free from all sorrows.

Mahavira'ssadhana period lasted twelve and a half years. In it he repeatedly used kayotsarga. The wearer of protective armor or bulletproof jacket does not have the fear of being shot, similarly after going into deep Kayotsarga, the effect of adverse conditions of major diseases and deadly and lifethreatening attacks is attenuated. Like Mahavira, one who practices Kayotsarga becomes healthy-hearted, becomes light and can lead a happy life by being absorbed in expansive meditation. The person, who wants to get rid of

various kinds of diseases, wants to become healthy and has to take medicine in the form of Kayotsarga. Mahavira had the science of medicine whose constituent elements are not mentioned in medical science, he gave such an unfading system of health, which is as easy as it is difficult. Kayotsarga is a type of penance. In which physical restlessness and anger etc. have to be immersed. The focus has to be on the breath. Is the mind fickle or the restlessness of the mind is the mind. On the basis of this concept, it seems difficult to stop the restlessness of the mind.

In the practice of Kayotsarga, words like relaxation, shavasana or relaxation for the body are used. Israeli strike on Gaza apartment building kills at least 15: officials say

DEIR AL-BALAH (GAZA STRIP), April 9: Israeli aircraft struck a residential block in warravaged northern Gaza on Wednesday, killing at least 15 people, health officials said, as the renewed fighting in the devastated Palestinian enclave showed no signs of letting up.

Gaza's Health Ministry said more than half of the dead were women and children. It said at least 40 people were wounded in the strike, which hit a four-storey building in the Shijaiyah neighborhood of Gaza City. Rescue teams were searching for victims under the rubble.

The Israeli military said it struck a senior Hamas militant who it said was behind attacks emanating from Shijaiyah. It did not name him or provide further details. Israel blames the deaths of civilians on the militant group, because it embeds itself in dense urban areas As it ratchets up pressure on Hamas to agree to free hostages, Israel has issued sweeping evacuation orders in parts of Gaza, including for Shijaiyah. It has imposed a blockade on food, fuel and humanitarian aid that has left civilians facing acute shortages as supplies dwindle. It has pledged to seize large parts of the Palestinian territory and establish a new security corridor through it.

Earlier this week, Hamas fired its strongest volley of rockets since the ceasefire collapsed, lobbing 10 projectiles toward southern Israel.

Israel resumed its war against Hamas in Gaza last month after an eight-week ceasefire collapsed. The ceasefire brought a muchneeded reprieve from the fighting to war-weary Palestinians in Gaza and sent an infusion of humanitarian aid to the territory. It also led

Nightclub roof collapse in Dominican capital leaves at least 79 dead and 160 injured



SANTO DOMINGO (DO-MINICAN REPUBLIC), April **9:** The roof of an iconic nightclub in the Dominican capital collapsed early Tuesday during a merengue concert attended by politicians, athletes and others, leaving at least 79 people dead and 160 injured, authorities said.

Crews were searching for potential survivors in the rubble at the one-story Jet Set nightclub in Santo Domingo, said Juan Manuel Méndez, director of the Center of Emergency Operations.

"We continue clearing debris and searching for people," he said on Tuesday night. "We're going to search tirelessly for people.'

Nearly 12 hours after the top of the nightclub collapsed onto patrons, rescue crews were still pulling out survivors from under the debris. Firefighters removed blocks of broken concrete and used sawed pieces of wood as planks to lift heavy debris as the noise of drills breaking

Pérez's manager, Enrique Paulino, whose shirt was spattered with blood, told reporters at the scene that the concert began shortly before midnight, with the roof collapsing almost an hour later, killing the group's saxophonist.

"It happened so quickly. I managed to throw myself into a corner," he said, adding that he initially thought it was an earthquake.

It wasn't immediately clear what caused the roof to collapse or when the Jet Set building was last inspected

The club issued a statement saying it was cooperating with authorities and noted that the owner. Antonio Espaillat, was out of the country and returned late Tuesday.

"There are no words to express the pain this event has caused. What happened has been devastating for everyone," he said.

A spokeswoman for the Ministry of Public Works referred questions to the mayor's office. A spokesperson for the mayor's office did not



to the release of 25 living Israeli hostages held in Gaza and the return of the remains of eight others, in exchange for hundreds of Palestinian prisoners.

Mediators have since attempted to bring the sides to a bridging agreement that would again pause the war, free hostages and open the door for talks on the war's

end, something Israeli Prime Min-ister Benjamin Netanyahu says he will not agree to until Hamas is defeated. Hamas wants the war to end before it frees the remaining 59 hostages it holds, 24 of whom are believed to be alive.

The war, which was sparked by Hamas on October 7, 2023, attacks on southern Israel, has seen the deadliest fighting between Israelis and Palestinians in their history. It has ignited a humanitarian crisis in already impoverished Gaza, and has sent shockwaves across the region and beyond.

20 elderly people killed in fire at nursing home in China



BEIJING, April 9: Twenty elderly people were killed in a fire at a nursing home in north China's Hebei province, local officials said on Wednesday.

A total of 39 elderly residents were residing in the building when the blaze broke out around 9 pm on Tuesday (local time) in Longhua County, Chengde City, state-run Xinhua news agency reported.

The fire was extinguished by around 11 pm. A total of 20 people have been confirmed dead so far while 19 were sent to a hospital for examination.

Police have detained the person in charge of the nursing home. The cause of the fire is still under investigation, the report said.

Hong Kong-based South China Morning Post quoted Jimu News that the 300-bed Guoen Senior Home had 260 elderly residents at the time of the blaze, based on public records.

Among them were 98 people with total disability and 84 described as semi-disabled. According to the records, the remaining 78 residents were capable of self-care.

According to the licensing record, its business scope was "providing accommodation, food, and daycare for the elderly and disabled". In October, more than 50 officials were punished after they were found to be responsible for a January 2024 fire that killed 39 people and injured nine at a building complex in Xinyu city in the southeast province of Jiangxi.

Investigations showed that the fire was caused by the illegal construction of a cold storage facility in the basement of the building complex, resulting in casualties and a direct economic loss of more than 43.52 million yuan (USD 5.9 million), the Post report said. (PTI)

Suspected US strikes in Yemen kill at least 8 people, Houthi rebels say

DUBAI, April 9: Suspected US airstrikes pounded the area around Yemen's Red Sea port city of Hodeida on Tuesday night, killing at least eight people, the Iran-backed Houthi rebels said.

The strikes hit around Hodeida's al-Hawak district, the rebels said, and wounded 16 people. The area is home to the city's airport, which the rebels have used in the past to target shipping in the Red Sea.

Since its start, the intense campaign of US airstrikes targeting the rebels over their attacks on shipping in Mideast waters -- related to the Israel-Hamas war -- has killed at least 81 people, according to casualty figures released by the Houthis.

Footage aired by the rebels' al-Masirah satellite news channel showed chaotic scenes of people carrying wounded to waiting ambulances and rescuers searching by the light of their mobile phones. The target appeared in the footage to be a home in a residential neighbourhood, likely part of a wider decapitation campaign launched by the Trump administration to kill rebel leaders

Other strikes targeted Yemen's mountainous Amran governorate, north of the rebel-held capital of Sanaa. There, the Houthis described American strikes hitting telecommunication equipment. Previous US strikes also targeted telecommunications gear in Amran near Jebel

In his first public speech after US President Donald Trump's steep global hike of tariffs, especially targeting China with 104 per cent on Chinese exports to America, Xi called for building a community with a shared future with neighbouring countries and striving to open new ground for China's neighbourhood work, state media reported.

Xi made the remarks at the high-level central conference on work related to neighbouring countries. The two-day conference on Tuesday and Wednesday was attended by top officials from the ruling Communist Party. In his speech, Xi systematically summarised the achievements and experience of China's neighbourhood work in the new era, scientifically analysed the current situation, and outlined the goals, tasks, ideas and measures for the next phase, state-run Xinhua news agency reported. Social worker imprisoned nearly 4 years for mediation attempts at Hong Kong protests



HONG KONG, April 9: A Hong Kong social worker was sentenced to three years and nine months in prison Wednesday on a

charge of riot for her role in the 2019 antigovernment movement, in a case that signals the authorities' stern approach to protest-related acts.

Jackie Chen was among a group of social workers who often carried a loudspeaker seeking to mediate between police and protesters during the often-violent social unrest. While she had been acquitted in her first trial in September 2020, prosecutors successfully appealed the verdict. She was convicted following a retrial.

In March, judge May Chung rejected Chen's claim of being a mediator in her verdict. She said Chen had continuously shouted unfounded accusations against the police during a protest in August 2019 and had used her social worker role, claiming to be "safeguarding justice," to back the protesters

Handing down the sentence on Wednesday, Chung noted Chen did not resort to violence at the scene, but her sentencing would have to consider what the whole

crowd was doing at the site. She pointed to the serious circumstances of the riot.

The judge initially set the sentence at 5 years but reduced it after considering factors like the pressure facing Chen over the long legal proceedings and her contribution as a social worker.

In Chen's mitigation letter posted by local media, she said 2019 was a crucial turning point in her life, with many social workers wanting to provide emotional support during the protests. She said even though she knew the government had planned to appeal against her acquittal in the first trial, she never thought of leaving the city because she wanted to continue her service for the people who are in need.

She said she felt especially guilty toward her 75-year-old mother, whose health has deteriorated in recent years. She hoped the judge could allow her to reunite with her family earlier.

"Although many people say I am a good social worker, I am truly an unfilial daugh-

ter." she wrote.

When she entered the courtroom, her supporters in the public gallery waved at her. She smiled and nodded back.

The social worker's conviction drew attention because of her mild role in the 2019 protests. The movement, sparked by a nowwithdrawn extradition bill, was the biggest challenge to the Hong Kong government since the former British colony returned to Chinese rule in 1997.

Chen could also lose her social worker license. Last year, the government amended the law to allow the removal of a social worker's name from the register if he or she has been convicted of an offense that is punishable with imprisonment and may bring the profession into disrepute.

In the same hearing, three other defendants received jail terms of two years and five months each for rioting. They had been initially acquitted but the government successfully appealed. They then chose to plead guilty. (AP)

Kharge warns partymen at AICC session

AHMEDABAD, April 9: In a stern warning to non-performing leaders, Congress president Mallikarjun Kharge on Wednesday said those who do not help in party work should take rest and those who don't fulfil their responsibilities should retire.

In his inaugural address at the AICC session on the banks of the Sabarmati river here, Kharge also alleged "fraud" in elections and said the Maharashtra polls were won like this as he made a strong pitch for return to ballot paper. He attacked the Election Commission for not stopping the "irregularities" and instead taunting the parties raising questions

He also hit out at the ruling BJP government accusing it of inciting communalism by raising 500 yearsold issues and seeking to divide people and promote hatred among them, instead of preparing for future chal-

Such dangerous thinking should never be supported, Kharge said.

Talking tough, he said, "I also want to say that those who do not help in party work, need to rest, those who do not fulfil their responsibilities must retire," amid applause from Congress leaders and workers.

'There is fraud happening in elections. With the advancement of electronic technology, developed countries of the world have abandoned EVMs and moved towards ballot paper. But our Election Commission is not ready to take cognizance of this. We saw in the Maharashtra elections that fake voter lists are being prepared," he alleged. Kharge also stressed that role of district Congress committee presidents in the organisation will be greatly enhanced and they will henceforth have a say in the selection of party candidates.

"The role of district presidents is going to be important in the formation of the organisation. Therefore, their appointment has to be done strictly and impartially as per the AICC guidelines," he said.

The district president has to make the booth committee, mandal committee, block committee and district committee by adding the best people within one year of his or her appointment, Kharge said, adding that there should be no bias in this.

"In future, we are going to involve district presidents in the candidate selection process for polls," the Con-

gress president said. Taking on the ruling dispensation, the Congress chief said from the banks of Sabarmati, the Congress is going to take the message of deter-

mination, struggle and dedication to walk on the path of justice. Kharge said we are once again fighting for India's independence, claiming that in this second battle for independence the enemies are injustice, inequality, discrimination,



poverty and communalism. The only difference is that back then foreigners used to promote injustice, poverty and inequality, now our own government is doing it, he said

"Then foreigners used to take advantage of communalism, today our own government is taking advantage of it," he charged.

"But we will win this battle too!" Kharge added Attacking the government, he said

Verbal spat, WhatsApp war among MPs bring to fore TMC's internal rift

KOLKATA/NEW DELHI, April 9: A video of a verbal spat, and screenshots of heated exchanges between TMC MPs Kalyan Banerjee and Kirti Azad in the party's official WhatsApp group, shared by BJP's Amit Malviya, went viral on Tuesday, bringing to fore deep fissures within the Bengal's ruling party.

BJP's IT cell head Malviya stoked the row by posting screenshots and videos of the exchanges on X, claiming the spat was evidence of the TMC's internal implosion.

PTI, however, could not independently verify the authenticity of the screenshots and the videos.

The controversy began on April 4 when a TMC delegation visited the Election Commission to submit a memorandum regarding duplicate voter identity cards, according to Malviya and sources within the Mamata Banerjee-led party.

TMC MP Mahua Moitra reportedly confronted Kalyan Banerjee -the party's chief whip in Lok Sabha for allegedly excluding her from the list of signatories on the memorandum that the delegation was submitting to the EC.

An altercation broke out between the two MPs on the premises of the EC office, with Kalyan Banerjee later claiming that Moitra had asked the security personnel present there to arrest him, accusing him of misconduct. As the incident came to the fore, another senior TMC MP. Saugata Roy, said Moitra was crying after the altercation.

"What he has done has maligned the party. He should be immediately removed as the chief whip. Kalyan Banerjee is known for his intemperate and uncivilised behaviour," Roy said.

Under attack, Banerjee addressed a press conference on the issue.

"I have been in politics for the last 40 years. This woman MP was asking the security outside the EC office to arrest me. Who are they to send me to jail? She hurled abuses at me. I fight in Parliament. I'm not obsessed with one industrial house," he said. Without naming Moitra directly, he added, "Just because the woman MP speaks fluent English doesn't mean she can insult anybody.

Moitra, when contacted by PTI, declined to comment on the episode. Roy said that although he was not present during the spat at the EC office, he saw Moitra crying and complaining to other MPs at Vijay Chowk. "She told other MPs he behaved in an uncivilised manner. He has a history -- from calling Jyotiraditya Scindia a 'lady killer' to throwing a bottle during a JPC meeting. I have remained silent so far, but this can't go on," he said.

Have faith, nothing will happen in Bengal by which one can divide and rule. You send out a message that all have to stay together. Jio aur jiney do (live and let live). You don't need to feel rattled.

The Waqf (Amendment) Bill was passed by the Lok Sabha on April 3, and by the Rajya Sabha in the early hours of the next day after marathon debates in both Houses of Parliament. President Droupadi Murmu gave her assent to the Bill on April 5.

Banerjee, also the Trinamool Congress supremo, appealed to the people not to pay

a political movement.

"There are people who would instigate you politically, provoke you to assemble and launch a movement. I will appeal to all of you not to do that. Please remember when Didi is here, she will protect you and your properties. Do not distrust. Let us trust each and everyone. If we are together, we can win everything. India engaged with US to seal trade pact: Jaishankar 'Impact of Trump's tariffs not yet known'

NEW DELHI, April 9: The impact of US President Donald Trump's reciprocal tariffs is not yet known and New Delhi's strategy to deal with the situation is to firm up a bilateral trade pact with Washington by fall of this year, External Affairs Minister S Jaishankar said on Wednesday.

In first detailed response to the US policy on tariff, Jaishankar said India is perhaps the only country to reach an understanding with Washington to seal a trade deal after Trump assumed the presidency for the second time.

The external affairs minister's comments came hours after Trump's sweeping tariffs against around five countries including India came into force triggering massive trade disruptions and fears of a global economic recession.

India is among the countries that have adopted a cautious approach in reacting to potentially seismic action, saying it is engaged with the Trump administration on the bilateral

trade agreement (BTA). "I don't think it's possible to speak about what would be the impact, because we don't know. What is our strategy? I think that's pretty clear," Jaishankar said at News 18 Rising Bharat Summit. "We decided that we will engage the Trump administration early on this set of issues and we were very open with them, very constructive with them as they were with us, and what we agreed to do was to try to negotiate a bilateral trade agreement by fall of this year," he said.

Following talks between Prime Minister Narendra Modi and Trump in Washington DC in February, the two sides announced to negotiate the first tranche of the BTA by the fall of 2025.

"I think we are the only country after President Trump has assumed presidency the second time, which has actually reached such an under-standing in principle," Jaishankar said.



He said every country in the world today is fashioning its own strategy to deal with the United States and that India's goal is to strike a trade pact with the Trump administration.

"In our case, our strategy has a goal. And the goal is to see whether it's possible to actually deal with this situation by concluding a bilateral trade agreement. And I should add that in an in-

teresting way, this has long been our objective," he said.

Jaishankar said the "present situation" may have created the circumstances for such a serious conversation on the trade deal.

"But if you look at President Trump's first term, we were actually negotiating a trade deal which could not fructify, and if one looks even at Biden's administration, we discussed trade possibilities and we ended up with the IPEF initiative," he said.

In line with Washington's long-term vision for the Indo-Pacific, then US President Joe Biden launched the ambitious Indo-Pacific Economic Framework for Prosperity (IPEF) in May 2022.

It was an initiative aimed at deeper cooperation among like-minded countries in areas like clean energy, supply-chain resilience and digital trade.

"They (the Biden administration) were very

averse to doing a bilateral agreement. From the Indian perspective, actually working out something bilaterally with the United States is not at all a sort of a negative or a sort of an unwanted situation," Jaishankar said. "On the contrary, it is something which has long been our objective." he added.

Talking about India's engagement with European nations in the middle of the Russia-Ukraine war and the US tariffs, Jaishankar said, it has been New Delhi's endeavour to have negotiations with Europe on a free trade deal.

"I am pretty confident that just as we are seeing a very intense engagement with the US, and by the way, with the UK as well, I expect the pace to pick up with Europe," he said.

"We have an aspirational goal. We'd like to close out the FTA this year," he said.

India is also negotiating a trade deal with the UK. (PTI)

PM Modi's meeting with Yunus **Raised concerns of radicalisation** in Bangladesh: Jaishankar

NEW DELHI, April 9: India conveyed its concerns over attacks on minorities and radicalisation in Bangladesh at the meeting between Prime Minister Narendra Modi and head of the neighbouring country's interim government Muhammad Yunus last week, External Affairs Minister S Jaishankar said on Wednesday.

Jaishankar underscored India's push for holding fresh polls in Bangladesh, saying elections are essential to democracies, and asserted that "no country wishes Bangladesh well more than us".

Modi and Yunus met for the first time in Bangkok since the ouster of the Sheikh Hasina government in August last year in the face of a massive anti-government protest.

"I think the main messages from our side which came out at the meeting -- one that our relationship with Bangladesh for historical reasons is a very unique relationship. It's very fundamentally a peopleto-people connect," Jaishankar said at the News 18 Rising Bharat Summit

"No country wishes Bangladesh well more than us: that's almost in our DNA. As a well-wisher, as a friend, I think we hope they go the right way and do the right things," he said

Jaishankar said the Indian side was very open in sharing its con-



cerns over the current situation in Bangladesh.

"We have concerns about radicalising tendencies. We have concerns about the attacks on minorities. I think we were very open about sharing those concerns," he said responding to a question on what PM Modi conveyed to Yunus.

"As a country which has a democratic tradition, democracies require elections. That's how mandates are given and mandates are renewed. So, we hope that they go down that path," Jaishankar said, underlining India's push for

India-Bangladesh relations nosedived dramatically after the interim government headed by Muhammad failed to contain attacks on minorities, especially Hindus, in that country.

Last week, the Indian side was upset over the Bangladeshi version of the meeting between Modi and Yunus Yunus' press secretary Shafiqul

Alam, in a Facebook post on Saturday, said the chief adviser raised with Modi Bangladesh's request for the extradition of Hasina and

the "response was not negative".

People familiar with the matter described the version as "mischievous and politically motivated", especially the aspects relating to attacks on minorities and Dhaka's request for extraditing former premier Sheikh Hasina, people familiar with the matter said on Saturday. The characterisation of the Indian prime minister's remarks regarding the relationship with Yunus and the previous Bangladesh government were "inaccurate", they said. New Delhi has so far not re-

sponded to the request made by Bangladesh's interim government last year for the extradition of Hasina. Hasina has been living in New Delhi since she fled Dhaka in August last year.

In the meeting in Bangkok on Friday, Modi conveyed to Yunus India's deep concerns about the safety of Bangladesh's Hindus and other minorities.

"The prime minister urged that rhetoric that vitiates the environment is best avoided," an Indian readout of the meeting said. PM Modi underlined India's

concerns related to the safety and security of minorities in Bangladesh, including Hindus, and expressed his expectation that the government of Bangladesh would ensure their security. (PTI)

Submit proposal for using electric vehicles in govt bodies: SC to Centre

NEW DELHI, April 9: The Supreme Court on Wednesday directed the Centre to submit a proposal by April 30 on the adoption of electric vehicles (EVs) in government departments to reduce pollution. A bench of Justices Abhay S Oka and Ujjal Bhuyan asked additional solicitor general Aishwarya Bhati to place on record the proposal by April end.

During the hearing, Bhati said while 60 lakh vehicles over the permissible age were plying in Delhi, in the NCR the number stood at 25 lakh

"ASG has flagged issues that large number of overage vehicles plying in Delhi and NCR region. We will issue directions on this when we consider the issue of vehicular pollution (sic)," the bench

The top court further directed the Centre to complete the study within three months on the use of remotesensing technology to keep a check on vehicular pollution.

SC raps Centre over delay in cashless scheme for accident victims, summons transport secy

NEW DELHI, April 9: The Supreme Court on Wednesday rapped the Centre over the delay in formulating a cashless medical treatment scheme for motor accident victims and summoned the secretary of the Ministry of Road Transport for an explanation.

A bench of Justices Abhay S Oka and Ujjal Bhuyan took objection that despite its January 8 order, the Centre did not comply with it.

'The time granted has expired on March 15, 2025. This is a serious breach and violation of not only orders of this court but a violation of implementing a very beneficial legislation. We direct the secretary, ministry of road transport and highways to appear on video-conferencing and explain why the directions of this court were not complied with,' the bench said. Only when top government offi-

cers are summoned here they take the orders of the court seriously, it added Additional solicitor general Vikramjeet Banerjee, appearing for

the Centre, said there were "bottle necks' The bench, however, re-

marked,"This is your own legislation, people are loosing lives, because there is no facility for cashless treatment. This is for the benefit of common people. We are putting you to notice, we'll take action under contempt. Ask your secretary to come and explain." The official was directed by the

top court to appear on April 28 for the explanation.

The bench also directed the sec-

retary of transport department to issue instructions in writing to all district magistrates to upload the claims of hidden hit-and-run cases on the General Insurance Council (GIC) portal.

On January 8, the top court directed the Centre to formulate the scheme for the cashless medical treatment of motor accident victims in the "golden hour" period mandated under the law It had referred to Section 162(2)

of the Motor Vehicles Act, 1988, and ordered the government to provide by March 14 the scheme which could save numerous lives with prompt medical care to acci-

dent victims The golden hour, defined under Section 2 (12-A) of the Act, refers to a one-hour window following a traumatic injury under which a timely medical intervention will

most likely prevent death. The court had underscored the importance of providing immediate medical care during the critical period and said delays caused by financial concerns or procedural hurdles often cost lives.

It had underlined the statutory obligation on the Centre to frame a scheme under Section 162 for cashless treatment and said the provi-

Kerala inks ₹ 817.80 cr loan MoU with Centre for Adani group-operated Vizhinjam Port

THIRUVANANTHAPURAM, April 9: The union government, a bank consortium and Adani Ports Pvt Ltd, which manages the Vizhinjam deep-sea port, on Wednesday inked a tripartite Memorandum of Understanding (MoU) for providing Viability Gap Funding (VGF) of ₹ 817.80 crore to the project. Besides that, the Centre and the Kerala government signed an MoU according to which the state will share 20 per cent of the revenue it gets from the port with the union government.

The deep-water port has been developed by Adani Ports and Special Economic Zone Ltd (APSEZ), India's largest port developer and part of the Adani Group, under a public-private partnership model at an estimated cost of ₹ 8,867 crore. Speaking on the occasion, state Minister for Ports, V N Vasavan said that the Kerala government has decided to accept the VGF as a loan from the Union government.

He said that the state agreed to accept it as a loan after several pleas to the Centre to provide it as a grant did not yield a result.

"Till now, the Union government had provided VGF as a grant, like it had given to the Tuticorin Port. Our Chief Minister had personally written to the Prime Minister requesting him to provide the amount as a grant. But we have not received any positive reply and in order to avoid further delays, we have decided to take it as a loan," Vasavan said.

V N Vasavan said the Vizhinjam International Seaport Ltd (VISL) is the biggest development dream of the state and the government did not want any delay in completion of the project.

sion sought to uphold and protect the right to life guaranteed by Article 21 of the Constitution. The law therefore provides the

It was noted despite the provision being in force since April 1, 2022, the government was yet to implement the scheme, prompting the court's intervention.

The Centre had submitted a draft concept note outlining a proposed scheme, which included a maximum treatment cost of ₹ 1.5 lakh and coverage for only seven days.

However, these limitations were criticised by counsel representing the petitioner, who argued they fell short of addressing the need for comprehensive care.

The GIC was tasked with administering hit-and-run compensation claims and developing a portal to streamline the process, it said.

The portal would enable the upload of required documents, inform states of deficiencies, and reduce delays in processing claims.

The order had said 921 claims under the hit-and-run compensation scheme remained pending as of July 31, 2024, due to document deficiencies, and asked the GIC to coordinate with claimants and address the issue.

The GIC was further instructed to expedite the development of the portal and report compliance by March 14, 2025. (PTI)

2 transport infrastructure projects get CCEA nod

NEW DELHI, April 9: The Cabinet Committee on Economic Affairs (CCEA) on Wednesday approved two infrastructure projects related to the transport sector that are aimed at removing congestion and enhancing integrated transport development, Union minister Ashwini Vaishnaw said.

It approved the construction of the 19.2-km, six-lane, access-controlled Zirakpur bypass worth ₹1.878.31 crore in Puniab and Haryana on the "hybrid annuity mode"

The primary purpose of the project is to ease up congestion in Zirakpur, Panchkula and surrounding areas by diverting traffic from Patiala, Delhi and Mohali Aerocity, and providing direct connectivity to Himachal Pradesh.

The proposal aims at reducing the travel time and ensuring hasslefree traffic movement in the con gested urban section of national highways 7, 5 and 152, an official statement said. The CCEA also gave its nod for the doubling of the Tirupati-Pakala-Katpadi single railway-line section of 104 km in Andhra Pradesh and Tamil Nadu with a total cost of ₹ 1,332 crore, Vaishnaw said.



NEW DELHI, April 9: The Cabinet Committee on Security (CCS) chaired by Prime Minister Narendra Modi on Wednesday cleared a proposal to procure 26 naval variants of Rafale fighter jets from France at a cost of around ₹ 64,000 crore for deployment on board aircraft carrier INS Vikrant, sources in the defence establishment said.

The delivery of the jets will begin around five years after the signing of the contract under an inter-governries of deliberations and evaluation tests of the platform.

Under the deal, the Indian Navy will also get associated ancillary equipment including weapon systems and spares from Dassault Aviation, the manufacturer of Rafale (Marine) jets.

The Indian Air Force bought 36 Rafale fighter aircraft in fly-away condition.

There is a thinking in the IAF that it should go for at least two more squadrons of Rafale jets.

The defence and strategic ties between India and France have been on an upswing in the last few years. In July 2023, India and France announced a raft of ground-breaking defence cooperation projects including the joint development of jet and helicopter engines.

The two strategic partners also had expressed commitment to cooperate in the co-development and coproduction of advanced defence technologies, including for the benefit of third countries.

The defence ministry also approved a proposal nearly two years back to procure three Scorpene submarines to further crank up India's naval prowess.

Meet to chalk out legal measures to wriggle out of NEET all set to be chaired by CM Stalin

CHENNAI, April 9: A meeting of the legislature party leaders to be chaired by Chief Minister M K Stalin to deliberate legal measures in order to secure exemption for Tamil Nadu from conducting National Eligibility cum Entrance Test for medical admissions is all set to be held Wednesday.

The main opposition AIADMK had already dubbed the meeting a 'drama,' that could serve no purpose as people are outraged over the ruling party's alleged failure to get it scrapped.

AIADMK chief Edappadi K Palaniswami has made it clear that his party will not attend the meeting. The meeting comes against the background of President Droupadi Murmu withholding assent to the Tamil Nadu anti-NEET bill and this was informed by CM Stalin on April 4.

BJP Tamil Nadu chief K Annamalai too described the meeting a drama to deceive the people and said his party would not take part in it.

"It is the Supreme Court's judgment that led to the nation-wide implementation of NEET," the BJP leader said adding if the DMK does not want NEET, it must have approached the Supreme Court.

Annamalai wondered why the DMK, which is in power for the past four years in the state has

been "enacting dramas" such as Assembly resolution and all-party meeting over NEET and has not gone to court to get an exemption from the national test.

Only after NEET's introduction, those from ordinary families and students from government schools have got the opportunity to pursue medical education. The DMK has been opposing NEET only to facilitate income for the private medical colleges run by the party people, Annamalai alleged. "Not just NEET, it may be any test, our students will ace any

exam...hence, please stop your dramas and allow Tamil Nadu students to study peacefully," Annamalai said on 'X.' (PTI)

"Attention is invited to reconsider the issue pertaining to issue of remote sensing. UoI (union of India) has sought time of 10-12 months to complete the study. This issue is of vital importance for curbing vehicular pollution. We direct Union of India to complete the study within three months from today," the bench said.

Bhati said after the FASTag system coming into existence, cars zoomed past toll plazas and couldn't be used anymore to conduct the study. So, we will need some more time, she said.

The proposal for using remote sensing devices for on-road emission monitoring had first come in 2019 from Environment Pollution (Prevention and Control) Authority, which assists the apex court on environment issues.

The top court has been monitoring the air pollution crisis in Delhi in an ongoing Public Interest Litigation — M C Mehta v. Union of India, since 1984. (PTI)

The minister said the first phase of the project is already completed and the commissioning will be done based on the dates available with the Prime Minister.

"The Kerala government is already in talks with the PMO and they have said that the PM's date will be awarded sooner," Vasavan said. He said the VISL has already become the number one port in the country and is also now considered one of the best in the entire world.

So far, more than 250 cargo vessels have docked at the VISL, handling over 6 lakh TEUs (Twenty-foot Equivalent Units), the minister said.

He further said that the works for completing the rail and road connectivity to the port are being done on a war-footing and will be completed by 2028. A cabinet meeting chaired by Kerala Chief Minister Pinarayi Vijavan on last Thursday, had decided to accept the central government's share of ₹ 817.80 crore as VGF for the port project.

According to a statement from the Chief Minister's Office, issued post the Cabinet meeting, the central government has set a condition that the state must repay the amount under the Net Present Value (NPV) model. Earlier, the Kerala government had requested the Centre to release the VGF share without conditions.

However, the Union government rejected this request, stating that the Vizhinjam project could not be compared to the Outer Harbour Container project at Tuticorin Port. Vijayan had then written to Finance Minister Virmala Sitharaman in October last year, urging her to release the funds without the repayment condition.

He had argued that the condition imposed by the Department of Economic Affairs' Empowered Committee would result in a financial burden of ₹ 10.000 to ₹ 12,000 crore for the state. The CM had also contended that a similar repayment condition was not applied to the Outer Harbour project at Tuticorin Port, which follows a similar financial structure to the Vizhinjam Seaport. The port received the commercial commissioning certificate on December 4 last year following the successful completion of its trial run. (PTI)

Ancient Nalanda was also centre for cultural diplomacy: Abhay K



NEW DELHI, April 9: The ancient university of Nalanda was an "institution without borders" and a great magnet that attracted scholars from across the world, but it was also veritably a "centre for cultural diplomacy", says diplomat and author Abhay K.

In his new book, "Nalanda: How It Changed the World", he charts the rise, fall and re-rise of the famed seat of learning in a new avatar besides its seminal contribu-

tions to the world at large for several hundreds of years uninterruptedly.

Currently serving as the deputy director general of the Indian Council for Cultural Relations (ICCR) under the Ministry of External Affairs, the diplomat hails from the ancient town of Rajgir in Bihar's Nalanda district.

During a video interview to PTI on the sidelines of an interaction held at the India International Centre here on Tuesday evening, he also said, "I think there is a need for more excavations at the site."

The ruins of Nalanda University or the Nalanda Mahavihara is a UNESCO World Heritage Site, a coveted tag it earned in 2016.

According to the UNESCO website, the Nalanda Mahavihara site comprises the archaeological remains of a monastic and scholastic institution dating from the third century BCE to the 13th century CE.

"It was a place where people from all across the world came, gathered, received knowledge and then took that knowledge back and spread it in their own countries. So, what could be a greater centre for cul-

tural diplomacy than Nalanda itself," Abhay K told PTL

"But we also have an example of King of Swarnadeepa asking King Deva Pala of the Pala dynasty through his ambassador Bala Barman to dedicate five villages for the upkeep of a monastery, which housed monks from Swarnadeepa," the diplomat said.

And there are several other examples such as a scholar coming from Tibet and studying at Nalanda, taking back knowledge and shaping a Tibetan script and grammar, and then the examples of Santa Rakshitha, Padma Sambhava, all of these going from Nalanda to Tibet and spreading knowledge there, he added.

Noted author and historian William Dalrymple also took part in the interaction on the topic "Nalanda: How It Changed the World" with Abhay K's new book being the pivot for the public discourse.

Spread over an area of 23 hectares, an ancient site of Nalanda is located about 98 km from Bihar's capital Patna. The property is owned, protected, maintained and managed by the Archaeological Survey of India (ASI), an autonomous institution under the

Ministry of Culture.

"It includes stupas, shrines, viharas (residential and educational buildings) and important artworks in stucco, stone and metal. Nalanda stands out as the most ancient university of the Indian subcontinent. It engaged in organised transmission of knowledge over an uninterrupted period of 800 years," reads its description on the UN-ESCO website.

The diplomat said Nalanda was the "first global institution or an institution without borders", as it had students from various countries, teachers from several countries, its teachings and philosophies that influenced the cultures and civilisations of the rest of the world.

"So, the idea of a university itself was born at Nalanda.. You have several contributions of Nalanda, in a way it acted as a cultural melting pot of the world," he added. He cited Chinese traveller Xuanzang's visit to Nalanda in ancient era to "copy sutras from the great sutra library of Nalanda", so Nalanda was "a great magnet" and it attracted people from all across the world. Asked what motivated him to write this

book, Abhay K said, "We need to know more about Nagarjuna or Dharmakirti or Arvabhatta and others. We have forgotten our own great masters. This book is an intervention in that direction."

The book is about "contributions of Nalanda" and how "Nalanda changed the way". At the same time, through its eight chapters, "it takes you to the very origin of Nalanda, how did the university, monastery university originate, why did it become so famous and who studied there"

The nearly 200-page book also covers the "great continuity of Nalanda even after its decline in the 13th century or even at least the idea of Nalanda, which has not only survived, but thrived rather, as we see in institutions named after Nalanda, all across the world today, from Brazil to Australia, Canada to Malaysia, so Nalanda named institutions are found everywhere", he added.

The diplomat mentioned the attempts in recent years to revive Nalanda's great glory and the inauguration of the campus of the new Nalanda University by Prime Minister Narendra Modi last vear. (PTI)

IIT Madras, Ziroh Labs to set up AI **Research** centre

NEW DELHI, April 9: Indian Institute of Technology (IIT) Madras has partnered with Ziroh Labs, a California-based innovation-driven deep tech startup, to establish a Centre of AI Research (COAIR) to solve India's compute accessibility challenges, officials said on Wednesday.

The COAIR will focus on developing practical, efficient AI solutions focusing on CPU and edge device inferencing. In a significant step towards making AI models solve accessibility problems, Ziroh Labs unveiled the first version of "Kompact" AI at IIT Madras, they said.

Kompact AI is an AI platform that enables foundational models to be built and served using CPUs without requiring Graphics Processing Units (GPUs), which are expensive and hard to obtain. (PTI)

Statue of SRK-Kajol from 'DDLJ' to be installed at UK's Leicester Square

NEW DELHI, April 9: A bronze statue of Bollywood superstars Shah Rukh Khan and Kajol striking a pose from their 1995 superhit "Dilwale Dulhania Le Jayenge" will be erected at the Leicester Square in London, in a first for an Indian movie.

It will join the 'Scenes in the Square' movie trail in Leicester Square, the Heart of London Business Alliance announced on Wednesday.

The statue from the film, commonly called "DDLJ", will be unveiled in spring this year, months ahead of its 30th release anniversary on October 20, 2025. "DDLJ" marked the directorial debut of Aditya Chopra and was produced by his filmmaker-father Yash Chopra under the Yash Raj Films banner.

The film, which was prominently shot in the UK, follows the love story of two young non-resident Indians Raj and Simran who fall in love during a vacation through Europe with their friends. It's around Leicester Square in the film where Raj and Simran first cross paths, albeit unbeknown to one another. According to a press release, the new statue will be positioned along the eastern terrace, outside the Odeon cinema, honouring the scene from the film. Other London locations featured in "DDLJ" include Horseguards Avenue, Hyde Park, Tower Bridge and King's Cross Station.

Mark Williams, deputy chief executive at the Heart of London Business Alliance, said it's fantastic to have the opportunity to add "titans of international cinema" Shah Rukh Khan and Kajol to their trail.

EKTA KAPOOR CONFIRMS REMAKE OF 'KYUNKI SAAS BHI KABHI BAHU THI' IN THE WORKS

MUMBAI, April 9: Producer Ekta Kapoor has confirmed she is set to remake her groundbreaking 2000 daily soap "Kyunki Saas Bhi Kabhi Bahu Thi", teasing that show's lead star Smriti Irani, now a politician, may return.

The show, which ran for about eight years between 2000 and 2008, was co-produced by Shobha Kapoor and Ekta Kapoor under their banner Balaji Telefilms. It ran for a total of 1,833 episodes.

"Kyunki Saas Bhi Kabhi Bahu Thi", which defined the dynamics of Indian family dramas in the early 2000s, revolves around Irani's Tulsi, who was the ideal daughter-in-law of the wealthy Virani family. Kapoor, who tasted massive success with the Star Plus series, said she hopes to hit the 2000-episode milestone with the remake.

"I'm re-making the biggest show I ever made. It gave me an identity, and then I had to fight a lot to make other things. But it became what I was known for. But because of my problems as a production house with another big corporate, the programme ended (with) 160 episodes less before it completed its big 2000 (episode milestone).

"The love we have received for this programme has brought everyone who is attached to it back to complete just those episodes to reach that 2000 (number). The show deserves that," she said on day two of India Global Forum here on Tuesday evening.

What can fans expect from the remake version of "Kyunki Saas Bhi Kabhi Bahu

Thi"? "We're bringing politics into entertainment or a politician," the producer said in an apparent reference to Irani, a former cabinet minister in the ruling BJP government.

Kapoor said the popular show had "an authentic nature", which was in stark contrast from the content being produced today.

"If we slip from our authenticity, we might not cater to anyone. So, let's do what we believe in, give it those episodes of nostalgia, not real action, but a nostalgic form of storytelling that people remember from their younger days, and come back just for that, and not make it a part of the number game, not make it struggle to be a form of content that is being made today," she added.

The producer, who has also backed films such as *"The Dirty Picture"*, *"Once Upon a Time in Mumbaai"*, *"Shootout at Lokhandwala"*, and *"The Sabarmati Report"*, said the dull performance of Hindi films at the box office is a "cyclical" phenomenon.

"When there were no movies in the theatre, old movies got a chance to (re)release, and music had worked because they were played so often in the last few years. People were like, 'Wow, what an amazing movie'," she said.

"Now, when the buyers have become fewer, people are again going to come into the market, make stories they believe in. Stars will charge lesser, eventually those movies will do well, the buyers will increase..." she added. (PTI)

Rice opened the scoring by bending one free kick around the Madrid wall in the 58th minute and sent another into the top corner in the 70th as Arsenal won the first leg of the quarterfinals 3-0 at the Emirates Stadium.

With Madrid great Roberto Carlos looking on in the stands, Rice put on a display of power and bend reminiscent of the many free kicks scored by the

Brazilian defender in his day in the 75th to put Arsenal on — or by his teammates David Beckham, Zinedine Zidane and Figo for that matter. since 2009.

Unlike those names, Rice has not been known for his free kick prowess — until now. In fact, he had never scored from a direct free kick before in his career.

NEW DELHI, April 9: Champion cricketer Virat Kohli said curbing the ego and playing as per the demands of a match situation form the core principle of his batting One of the most successful

batters of the modern era, Kohli recently flew past another milestone while becoming the first Indian player to score 13000 runs in T20s.

"It's (batting) never about ego. It was never about trying to overshadow anyone. It's always been about understanding the game situation — and that's something I've always taken pride in. I want to play according to what the situation demands,

Kohli told JioHotstar. "If I was in rhythm, in the flow of the game, I naturally took the initiative. If someone else was better placed to take the lead, they would do it," he

Kohli is the highest run-getter in the IPL with 8168 runs from 256 matches with eight hundreds, the most by any batter.

from the 2011 edition onwards.

"In my first three years with Royal Challengers Bengaluru, I didn't get many opportunities to bat in the top order. I was usually sent lower down. So, I wasn't really able to crack the IPL in a big way.

"But from 2010 onwards, I started performing more consistently, and by 2011, I was regularly batting at number three. That's when my IPL journey really began to take shape," he added

Kohli admitted that spending 18 years in the league helped him polish his skills in the shortest version of cricket.

Iver wants fearless, free-flowing attitude from his batters Maxwell fined, handed

MULLANPUR, April 9: Punjab Kings skipper Shreyas Iyer on Tuesday said he wants his batters to play with an aggressive, fearless, and free-flowing mindset, something young opener Priyansh Arya showcased during his sensational maiden IPL century against Chennai Super Kings.

Arya rode on his luck and power-hitting to slam 103 off 42 balls -- the fifth fastest century in IPL history as PBKS posted 219/6 despite half their side returning to the dugout in the first eight overs.

"Absolutely. This is going to be the template, irrespective of the ground. We have variety in the batting line-up. Great hitters, great timers, scintillating to watch Priyansh bat from the out-

"When I had a chat with him in the last game, he was a bit timid in his decision-making against Jofra (Archer). Tonight, he was backing his instincts," Iyer said at the post-match pres-

"It was free-flowing and that is the mindset I want in everyone. Today, he kept on going, he was fearless and it was basically one of the top knocks I have seen in the IPL so far."

Yuzvendra Chahal bowled just one over giving away nine runs and Iyer said it was a tactical move to hold back the experienced leg-spinner.

"That was a tactical call, because (Shivam) Dube had already played a few deliveries, and also Conway. With Yuzi coming in, we know how destructive he (Dube) can be. But Yuzi is a smart bowler. My instincts felt that pacers bowling slower balls into the wicket (would work), and we basically wanted pace against Dube

"We delayed a bit but eventually, it worked out.

CSK skipper Ruturaj Gaikwad lamented his side's missed chances in the field, admitting that dropped catches have cost them dearly in

"I think the last four games, the only point of difference, it has been critical, the catches we have been dropping, the same batsman is scoring 15,20, 30 runs," he said after CSK lost by 18 runs against Punjab Kings.

Gaikwad was full of praise for young PBKS opener Arva.

"Priyansh played well. High risk batting and it came off well. We were getting wickets at regular intervals but they kept the momentum going. 10-15 runs lesser would have helped us. NEW DELHI, April 9: World Boxing has formed an interim committee to oversee the affairs of the Boxing Federation of India (BFI) to ensure administrative continuity and management of domestic and international competi-

World Boxing President Boris van der Vorst has written to BFI chairman Ajay Singh, conveying the appointment of a six-member committee.

The committee will be headed by Singh for "a period not extending 90 days."

The six-member committee includes BFI Vice President Narender Kumar Nirwan, Executive Director Arun Malik and Olympian L Sarita Devi.

One of the remaining two members of the committee

Both Kalita and Digvijay have challenged the decision in court.

The infighting among the federation had led several state units to boycott the women's nationals last month, where Singh announced several national championships. "This Interim Committee is being formed to provide administrative continuity and safeguard the rights and interests of Indian boxers until elections are held and a new democratic executive committee is elected," the letter from van der Vorst read.

The interim committee has been tasked with multiple responsibilities including day-to-day management of the BFI to ensure administrative continuity; organise domestic competitions including national championship in "a fair, transparent, and inclusive manner and taking all steps necessary to ensure participation."

The committee will select Indian teams for international events on the basis of selection policy in a timely manner and coordinate with SAI, IOA and other national stakeholders for protecting the interest of Indian boxing and its athletes.

It is learnt that several members of the BFI, including two Vice Presidents, had approached van der Vorst raising concerns over Indian boxing, prompting the World Body to take action.

"Overseeing financial matters, including the operation and management of BFI's bank accounts, to ensure transparency and discipline; representing BFI in all ongoing and future legal proceedings, with the authority to act in the best interests of the Federation" were also listed as the responsibilities. (PTI)

DK is trying to create a new player in me: RCB's Jitesh credits mentor Karthik for revival

Sharma attributed his ongoing renaissance as a T20 batter to the efforts put in by Royal Challengers Bengaluru mentor Dinesh Karthik who believes that the wicketkeeper can develop into a true '360' degree player.

Jitesh had a lukewarm IPL 2024 for Punjab Kings, scoring just 187 runs from 14 matches at a measly average of 17 and at a reduced strike-rate of 131.

But at RCB, the 31-year-old has already made handy 85 runs from four matches, and his strike-rate has touched 185, a sign of him regaining confidence.

"It's been a great journey till now because in the off-season, I really worked hard with him. I think whichever shot that I am playing right now is the replica of what he used to play. He is trying to create a new player in me," said Jitesh on the eve of the match against Delhi Capitals.

Jitesh said Karthik, a former wicketkeeper batter for RCB, has a lot of trust in his abilities with the

"He believes in me that I can play all around the circle — 360 angles.

BENGALURU, April 9: Jitesh I am really enjoying myself in a new role. While I am playing those shots, I am very happy because I have never tried those shots and I have all the backing. The process is still on," he added.

The first thing Karthik drove into Jitesh's mind was that a lean season happens to every cricketer, and there is nothing to be disappointed about it.

"I think last year's performance was my mental thing. I was not mentally in the game at that moment. I was thinking about the future. But when I met Dinesh bhai, he told me that it's a human error. It's not rocket science," he said.

Perhaps, Jitesh was a worried man after losing his place in the Indian T20I side after the home series against Afghanistan in January 2024. The Maharashtra man said Karthik identified some shortcomings in his batting, and began to work on it.

"He saw how I try to dominate. I don't have the craze to take out runs, but I have the craze to win the match. I like that a lot. So, I think he found out that there are some shots that I am lacking and started

working on that," he said. (PTI)

NEW DELHI, April 9: It was a day before the Indian Premier League mega auction when renowned Delhi coach Sanjay Bhardwaj was having brunch with a gentleman named Pawan Arya.

Bhardwaj, whose noted disciples include current India head coach Gautam Gambhir, Amit Mishra, Nitish Rana to name a few, made a prophecy to Arya, a government school teacher about his son Priyansh.

"I told Pawanji, aap ka beta at least ₹ 2.70 crore par bikega kal. Baki Ishwar ki marzi (Your son will fetch minimum ₹ 2.70 crore and rest is up to the Almighty. Priyansh was sold for 3.8 crore," Bhardwaj, also known as "Guru ji", told PTI after his ward waltzed to 39-ball-century against CSK on Tuesday night.

Bhardwaj was happy that the auction price didn't get into his head. The 24-yearold southpaw had joined Bhardwaj's Lal Bahadur Shastri Academy at the age of 10. "When he hit six sixes for South Delhi Supetstars in Delhi Premier League last year, he was able to maintain composure. Even after there was bidding war at IPL auctions, he quietly practised. He hasn't changed since his father brought him to me as a 10-year-old. He is 24 now but remains

same. "His parents, both government school teachers have inculcated good values in

him." Just before IPL, Priyansh trained at an academy near Ratapani Wildlife Sanctuary which is close to Bhopal.

"I have a residential academy in Bhopal near the jungles. Priyansh trained over there

before IPL and worked on his game, range hitting before he joined Punjab Kings camp," said the coach.

Ask any Delhi player, it is not always

easy to get the breakthrough and Bhardwaj remembers how he had to actually ensure that a hefty club tournament entry fee of ₹ 50,000 was paid so that his ward gets a shot at Delhi U19 trials.

"The tournament is organized by a former India player. Priyansh was 16 back then. 50,000 entry fee for a club like ours is a lot of money. But glad I paid it and Priyansh scored 93 and Gursharan Singh, then in charge of U19, put him in Cooch Behar squad and he scored nearly 400 runs."

"He was selected for India U19 and played a tri-series game against Proteas colts.

Priyansh's forte is T20 and he can muscle any bowler without a lot of footwork.

Bhardwaj's aim is to ultimately see his ward in India whites.

"Abhi uss pe bahot kaam baaki hai (He is a work in progress). We will work at my academy in Bhopal after IPL so that he can become a Delhi regular in Ranji Trophy,' Bhardwaj said.

But what made him smile was a gesture from his student on Tuesday.

"I normally never request for passes but there was someone I couldn't turn down and I sent him a request for a couple of tickets. He texted me photo of the envelope and my acquaintances could watch the match," he said.

Having got a good look at Privansh during the pre-season camp, Punjab Kings support staff did not take long to be convinced of his special talent.

"He played about eight balls in a practice game before the IPL. That was enough for us to say that he has to play the first game," assistant coach Brad Haddin told the host broadcaster soon after Priyansh's sizzling innings. (PTI)
