**NEW DELHI, April 7:** The domestic cooking gas LPG price on Monday was hiked by a steep ₹50 per cylinder across India and CNG by ₹ 1 per kg, while the government raised taxes on petrol and diesel to shore up its revenues.

# SC closes case as Centre assures to implement panel suggestions

NEW DELHI, April 7: The Supreme Court on Monday closed a matter over the functioning of the National Testing Agency (NTA) in holding last year's NEET-UG after the Centre assured of implementing exam reforms suggested by its expert panel.

A bench comprising Justices P S Narasimha and Joymalya Bagchi took note of the Centre's compliance reports on the issue and the submissions of its solicitor general Tushar Mehta as it disposed of the plea. Mehta said the Centre had accepted all the suggestions of the seven-member panel, except one--NTA conducting online NEET exams--for the time being.

"Over 26 lakh students take up NEET across India and the government will have to ascertain availability of internet and computers... this will take some time," he said, "but the report (of the expert panel) has been accepted".



Nothing survived in the case and it can be disposed of, Mehta added. The bench noted the submissions and the developments, say-

ing no further order was required. The top court on August 2, last year, refused to annul the contentious NEET-UG of 2024, saying there was no sufficient material on record to indicate a systemic leak or malpractice compromising the

integrity of the examination. It had expanded the remit of the seven-member expert panel, headed by former Indian Space Research Organisation (ISRO) chief K Radhakrishnan, to review NTA's functioning and recommend exam reforms to make the NEET-UG (National Eligibility cum Entrance Test Undergraduate), transparent and free from malpractices. On January 2, Mehta said the Centre-appointed committee filed its report and assured that the government would implement all of

On October 21 last year, the top court extended the time granted to the Centre-appointed expert panel to file its report on exam reforms.

# Govt stepping up efforts to help exporters

#### Group to monitor possible import surge

NEW DELHI, April 7: The government has set up an inter-ministerial group to monitor a possible surge in imports from countries like China, Vietnam and Thailand, fearing a surge in inbound shipments following the imposition of high reciprocal tariffs by the US on these countries, sources said.

The product categories that may see an upsurge in diversion of imports from the US to India include consumer goods, electronics, chemicals

The clear signals for these rises in imports are likely to manifest from June to July, they said, adding the "import monitoring group" will include officials from the departments of commerce, revenue and the Department for Promotion of Industry and Internal Trade (DPIIT).

The concerned line ministries and industry associations have also been asked to provide inputs on the surge in imports and its impact on the domestic

"The idea is to observe these imports and see if any measures need to be taken. It will look at all the data points closely, including shipments coming from air and sea routes. While intense watch is required, volatility in imports is normal," the sources added.

As sweeping tariffs have been imposed on India's competitors including China, Thailand, Vietnam and Malaysia, their goods become expensive in the US market and this would lead to diversion of goods into countries like India after some months.

While the US has imposed an additional 26 per cent import duty on



India, its competitor Vietnam is facing 46 per cent tariff, China 34 per cent, and Indonesia 32 per cent, and Thai-

One of the sources said that the government is also stepping up efforts to

The commerce ministry is fasttracking formulation of its export promotion mission to support exporters in areas such as providing credit at affordable rates; and negotiations of proposed free trade agreements with the European Union, Oman, New Zealand and the UK.

Additionally, concerned officials have been directed to hold a series of bilateral meetings with the identified 20 countries such as Australia, Brazil.

In 2023-24, the US was the largest trading partner of India with USD 119.71 billion bilateral trade in goods (USD 77.51 billion worth of exports, USD 42.19 billion of imports and USD 35.31 billion trade surplus). China was the second largest trading partner with USD 118.39 billion twoway commerce (USD 16.65 billion exports and USD 101.73 billion imports and USD 85 billion trade deficit).

The US accounts for about 18 per cent of India's total goods exports and 6.22 per cent in imports and 10.73 per cent in bilateral trade. On the other hand China's share is just about 4 per cent in exports and a staggering 15 per

import-dependent to meet its needs - has risen by 63 per cent to USD 629 per tonne in February 2025 from USD 385 in July 2023, he said. This necessitates LPG to be priced at ₹ 1,028.50 per 14.2-kg cylinder in Delhi. "But the public sector oil marketing companies have been so far modulating the prices," he said, adding that the oil PSUs suffered under-recoveries or loss of ₹41,338 crore in the fiscal year ended March 31 (2024-25) on account of selling LPG below cost.

In view of the mounting losses, the prices have been moderately increased. "At current prices, the cost of cooking per day using LPG for Ujjawala households is around ₹ 6.10 and that for general users is ₹ 14.58, which is reasonable," Puri noted. The rates, he said, will be reviewed every month and any softening will be passed on to consumers.

The ₹ 50 per cylinder hike will only cover the future cost and for the past cost, the oil ministry will seek budgetary support from the finance ministry. The additional accruals from the excise

duty hike can be used to compensate the oil companies for their losses, he said. "It is our commitment to make good their losses." As much as 16,000 crore litres of petrol and diesel is consumed annually in the country and the ₹ 2 a litre excise hike could yield up to ₹

32,000 crore to the government. While the mop up from excise duty hike on petrol and diesel will be solely at the disposal of the central government, as SAED is out of the divisible pool with the states, the LPG price hike of ₹ 50 per cylinder is likely to mop up ₹ 5,000-7,000 crore.

#### **Sensex sinks 2,227** pts as trade war fears engulf global markets

MUMBAI, April 7: Stock markets crumbled on Monday with benchmark Sensex sinking by 2,226.79 points – its steepest singleday decline in 10 months - as a global market carnage following US President Donald Trump's tariff hikes and retaliation from China fanned fears of economic slowdown.The 30-share BSE Sensex crashed 2,226.79 points or 2.95 per cent to settle at 73,137.90, recording its third day of decline. During the day, the index slumped 3,939.68 points or 5.22 per cent to 71,425.01. The NSE Nifty tumbled 742.85 points or 3.24 per cent to settle at 22,161.60. Intra-day, the benchmark dropped 1,160.8 points or 5.06 per cent to 21,743.65.

All Sensex shares, except for Hindustan Unilever, ended with losses. Tata Steel fell the most by 7.33 per cent followed by Larsen & Toubro which cracked 5.78 per cent. Tata Motors, Kotak Mahindra Bank, Mahindra & Mahindra, Infosys, Axis Bank, ICICI Bank, HCL Technologies and HDFC Bank were the other big laggards.

Hindustan Unilever ended marginally higher.

"The market tumbled as the carnage over high US tariffs and the retaliation by other countries may kickstart a trade war. Sectors like IT and metals have underperformed relative to the broader market due to the risk of high inflation with slower growth that may result in a potential recession in the US." Vinod Nair. Head of Research. Geojit Investments Limited, said.

As many as 3,515 stocks declined while 570 advanced and 140 remained unchanged on the BSE. Notably, 775 stocks hit their 52week lows while 59 firms were at 52-week peaks on the BSE.

"After US markets plunged on Friday, it was writing on the wall for other global equity indices which fell like a pack of cards amid fears that Trump's policies on reciprocal tariffs may lead to recession and higher inflation in the US going ahead.

"Already, commodity prices of crude oil and several metals are seeing a downward slide, which is an indication of a slackening demand if the current trend persists," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.

In Asian markets, Hong Kong's Hang Seng index tanked more than 13 per cent, Tokyo's Nikkei 225 plunged nearly 8 per cent, Shanghai SSE Composite index dropped over 7 per cent and South Korea's Kospi sank over 5 per cent. European markets too came under heavy selling pressure and were trading with up to 6 per cent decline.

US markets ended sharply lower on Friday. The S&P 500 dropped 5.97 per cent, Nasdaq composite slumped 5.82 per cent and the Dow

#### Rupee drops 38 paise to settle at 85.82 against US dollar

MUMBAI, April 7: The rupee declined 38 paise -- steepest in more than five weeks -- to settle at 85.82 (provisional) against the US dollar on Monday amid the wide-spread global turbulence over escalated tariff war and fear of a global economic slowdown.

A steep decline in crude prices and a weaker American currency failed to arrest the fall in domestic currency due to the withdrawal rush by foreign as well as domestic equity investors, forex traders said. They said the currency exchange markets globally faced extreme volatility as investors tried to escape risks, following the US administration's sweeping reciprocal tariffs on multiple countries and China's retaliatory move on the American imports. On the domestic macroeconomic front, market participants were watchful as the Reserve Bank of India's (RBI's) monetary policy committee began its three-day deliberations on key interest rates. The decision of the six-member rate-setting panel will be announced on Wednesday.

At the interbank foreign exchange, the rupee opened at 85.79 and moved in a wide range between the high of 85.57 and the low of 85.90 against the greenback during the day. The unit ended the session at 85.82 (provisional) against the dollar, registering a loss of

38 paise from its previous closing level. Earlier, the domestic unit had witnessed such a steep fall on February 25 when it depreciated 47 paise. On Friday, the rupee settled 14 paise lower at 85.44 against the US dollar, a day after gaining 22 paise on Thursday, following the implementation of the US' reciprocal tariff on about 60 countries. Anui Choudhary, Research Analyst

at Mirae Asset Sharekhan, said the rupee declined on risk-off sentiments in global markets and a strong US dollar. He said the rupee is expected to trade with a negative bias due to weak global markets and ongoing uncertainty around trade tariffs.

"Selling pressure by FIIs may also weigh on the domestic currency. However, weak crude oil prices may support the rupee at lower levels. USD-INR spot price is expected to trade in a range of ₹ 85.50 to ₹ 86.20," Choudhary

#### A path to global recession?

President Donald Trump's declaration of April 2, 2025, as "Liberation Day" marked a seismic shift in U.S. trade policy, with the imposition of sweeping reciprocal tariffs that have sent shockwaves through the global economy. The new measures include a universal 10% tariff on all imports, with punitive rates as high as 54% for China, 46% for Vietnam, and 20% for the European Union, alongside a separate 25% levy on foreign-made automobiles. Framed as a corrective to decades of "unfair" trade practices, the policy has been celebrated by the administration as a rebirth of American industry. Yet beneath the rhetoric lies a complex web of economic consequences, retaliatory threats, and a potential reordering of global trade dynamics that could leave the U.S. and its allies grappling with long-term instability. For American manufacturers, the tariffs present a double-edged sword. On one hand, industries like steel, automotive, and textiles - long battered by foreign competition - may see short-term gains as higher import costs push consumers toward domestically produced goods. The Alliance for American Manufacturing, for instance, praised the move as a lifeline for workers who have "seen unfair trade cut the ground from beneath their feet for decades". However, the reality is more nuanced. Many U.S. manufacturers rely on global supply chains, importing components like auto parts from Mexico or semiconductors from Asia. The 25% tariff on foreign auto parts, for example, could raise production costs for American automakers by \$2,000 to \$15,000 per vehicle, forcing them to either absorb losses or pass expenses onto consumers. Small businesses, from craft breweries to electronics assemblers, face similar strains. The National Association of Manufacturers warned that thin margins could collapse under the weight of new tariffs, jeopardizing investments and jobs.

Consumers, meanwhile, are poised to bear the brunt of this policy. Despite White House claims that tariffs act as a "tax cut," economists overwhelmingly agree that import taxes inflate prices for everyday goods. Fruits and vegetables from Mexico, clothing from Vietnam, and electronics from China - all staples of American households - will become more expensive. The Yale Budget Lab estimates that the average American family could pay an additional \$2,700 to \$3,400 annually. Retailers, already grappling with inflation, warn of unavoidable price hikes, particularly for items like apparel and toys, which lack a domestic manufacturing base. Even sectors temporarily spared, like pharmaceuticals, face uncertainty as the administration considers future investigations that could extend tariffs to critical medicines. The global reaction has been swift and severe, signalling the onset of a protracted trade war. The long-term implications for global trade are profound. Trump's tariffs represent not just a tactical escalation but a philosophical rejection of the post-WWII liberal order.

Factually speaking, Trump's tariffs are less a solution to globalization's discontents than a high-stakes gamble - one that prioritizes political symbolism over economic stability. While the administration touts "liberation" from foreign competition, the costs - higher prices, lost exports, and a destabilized trading system - will be borne by the very workers and consumers it claims to protect. The world is now bracing for a new era of economic nationalism, where the rules of trade are written not through cooperation but through conflict, and the collateral damage could reshape economies for decades to come.

#### Protests in the US show how a people's mass movement can be rebuilt

emonstrations across the United States over the weekend against Donald Trump and his policies give the lie to claims that all is lost in the struggle for people's rights and social justice against the conservative right and its far-right allies.

Of course, there are always the defeatists - notably the "centreleft" intellectuals — who insist that the working classes on both sides of the Atlantic are too stupid, lazy, selfish and racist to resist injustice. In the words of Private Frazer: "We're all doomed!" Fascism is inevitable.

Meanwhile, millions of protesters of all colours, creeds and political affiliations, from the centre-right to the real left, from Los Angeles to Washington DC, marched in defence of jobs. women's rights, the US constitution, the young, the elderly, the sick, black communities, the world's poor and the Palestinians

against the Trumpian onslaught. They face a deeply reactionary Republican administration backed by a sizeable section of ruthless monopoly capital and a powerful state apparatus. The US working class, the labour and progressive movements and the people will need all the unity they can muster to block the advance of the resurgent right and its proto-fascist el-

But as the worldwide pushback grows against Donald Trump's global trade war, cracks will open up within the ruling Republicans, the monopoly capitalist class and even within and between the agencies of the state. Provided the insurgents put not their trust in Democratic Party politicians on the big-business payroll, they can generate their own vision, strategies and leadership to turn back the MAGA maniacs.

In Britain, too, the "centre left" must not be allowed to divert or demoralise the emerging opposition to Keir Starmer's treacherous regime and its pro-City, pro-NATO policies. In many local communities, people are beginning to mobilise to defend their public services, their social facilities and their rights.

Never have such policies as a wealth tax, public-sector housebuilding and public ownership of energy and public transport been so popular. The Alternative Economic Strategy is making a welcome comeback.

Protesters march every week against the British government's sickening silence about — and complicity in — the Israeli genocide. Britain's armed forces can blast the Houthis and defend Israel against incoming rockets, can bomb and invade Serbia, Iraq, Afghanistan, Libya and Yemen yet not a finger can be lifted to protect defenceless Palestinians in Gaza and the West Bank.

Public cynicism about the West's real motives for pouring yet more weapons into the Ukraine war cauldron instead of genuinely seeking the end to a conflict that did not begin with Russia's brutal incursion three vears ago. In Britain, we can build a people's mass movement around these burning issues and, in the process, expose the anti-workingclass politics of Reform UK, whose four top officers made their millions in banking, property development or the City.

Again, though, we need unity to be built on solid foundations. These cannot include demands for Britain to align itself with the EU in a trade war against the US and even China. Nor should there be illusions that deep-seated problems which festered during decades of EU membership can somehow be more readily resolved by rejoining the big-business club or its capital and labour

NATO rearmament must be opposed. The US-led cold war anti-socialist alliance has now outlived the Warsaw Pact by more than 30 years. Clasping these two serpents to its bosom would spell suicide for any people's movement that stands for public services, social justice, peace and solidarity. (IPA Service)

# BJP's resurgence in Indian politics

haratiya Janata Party (BJP) was established with a vision to bring in 'Cultural Nationalism," in 1980. The BJP is a national party and is the most prominent member of Sangh Pariwar family. The history and spirit of BJP can be traced back to the Bharatiya Jan Sangh (BJS). BJS, the predecessor party of BJP, was founded in 1952 which won 3 seats in the first Lok Sabha (LS) election in India and continued as a political party for 24 years. Subsequently the BJS merged into the Janata Party in 1977 and formed a coalition government. BJP was formed after the fallout of Janta Party coalition government in

The man behind creating such a large party with once single objective was none other than the great visionary, scholar and leader Dr Syama Prasad Mookerji, drawing inspiration from Pandit Deendayal Upadhyaya. Pandit was an insightful leader and guided the erstwhile BJS party from 1953 to 1968.

Taking its genes from RSS and the erstwhile BJS, BJP is dedicated to the country's unity, integrity, its inherent uniqueness, social strength, individual character and cultural exclusivity that have been the characteristic of India.

With the principle of "Justice for all and appeasement of none" the Sangh(RSS), founded by Dr K B Hedgewar (Doctorji) in 1925 and strengthened after 1940 by M S Golwalkar (Guruji). It believes the Hindu identity and culture as the foundation of the county. To the Sangh, all Indians, irrespective of their religion, region, caste, and creed are equal.

In 1967 the BJS gained a substantial foothold in the Hindispeaking regions of northern India. Ten years later the party, led by Atal Bihari Vajpayee, joined three other political parties to form the Janata Party and took over the reins of government. Plagued by factionalism and internal disputes, however, the government collapsed in July 1979. The BJP was formally established in 1980, following a split by dissidents within the Janata coalition, whose leaders wanted to prohibit elected BJS officials from participating in the RSS. The BJS subsequently reorganized itself as the BJP under the leadership of Vajpayee, Lal Krishan Advani, and Murali Manohar Joshi.

On 4th April, 1980 the National Executive of the Janata Party adopted a resolution prohibiting members of RSS to continue in the Janata Party. This resolution was sequel to the fears entertained by Chandrashekhar's Group and a few Socialists who had not left the Janata Party when the split caused by Ch. Charan Singh took place and others that the erstwhile Jana Sangh would capture the party on account its mass base and large army of dedicated workers. This development was anticipated by leaders and workers of the Jana Sangh and RSS background in Janata Party. So they had asked Jana Sangh workers from all over the country to assemble at Delhi before the meeting of the National Executive of Janata Party and to be prepared for all eventualities. The resolution adopted then was not acceptable to erstwhile Jana Sangh constituent and to several other leaders and persons in Janata Party who had no RSS background. The Jana Sangh constituent had sincerely worked towards the strengthening and smooth working of the Janata Party. Even though it constituted the largest single constituent of the Janata Party and had a larger popular base in the country it did not ask for proportionate share either in Janata Government or in Janata Party and was content with whatever was given to it.

The Jana Sangh constituent wanted Janata Party to succeed and emerge as an alternative to Congress which had ruled the country for three decades prior to 1977. In this background, there was a feeling of regret and unhappiness as well as of good riddance and relief in the Jana Sangh workers. The condition imposed for membership of the Janata Party was unacceptable. No such condition was stipulated when the Janata Party was formed and this matter had been settled before the merger of the constituents to form Janata Party. This being raised at this stage was not for any genuine reason arising out of the manner in which Janata Party or Janata Government was functioning during 1977 to 1979, but for ulterior reason to control the party. RSS had not interfered in any manner either in the functioning of party or government. Two

days after, the adoption of this resolution the Jana Sangh workers held a Conference on April 6, 1980 at the Kotla ground in Delhi and decided to part company with Janata Party. The general mood was of unhappiness and of being forced to leave a party which had been formed under the inspiration of Jayaprakash Narayan with high hopes. There was, however, no alternative. BJP was, thus, launched on 6th April, 1980.

Besides these there was a

galaxy of other leaders who worked with dedication selflessness and competence. These included Nanaii Deshmukh. Dr.Murli Manohar Joshi, S.S. Bhandari. K.R. Malkani, V.K.Malhotra, Kushabhau Thakre, Jana Krishnamurthi, Kidarnath Sahani, J.P. Mathur, Sundar Lal Patwa, Bhairon Singh Shekhawat and Shanta Kumar. Many eminent persons who had no RSS background such as Jethmalani, Shanti Bhushan and Sikander Bakht also joined the party. The leadership available to the party was a great asset. The party had also inherited a disciplined, dedicated and hard working cadre of workers from Jana Sangh. The band of workers available to the BJP was willing to face any challenge. Thus, the BJP started with able

leadership and dedicated and disciplined cadre on its journey to become an alternative to Congress and to work for making India a developed and prosperous country not only in the material sense but also culturally and spiritually in keeping with its tradition and culture. Atal Bihari Vajpayee assumed the Presidentship of JP and L.K. Advani became the General Secretary. It was decided to convene a Plenary Session of the party in December, 1980. The period between April-December, 1980 was utilised for intense activity throughout the country to build the party. During this period, about 25 lakh members of BJP were enrolled. The plenary session of BJP was held at 'Samata Nagar' at Bombay on 28-30 December, 1980.

Advani describes this convention as follows: "The Bombay Convention of the BJP has been universally acclaimed as a landmark in recent political history. It has evoked sharp comments from admirers and critics of the party alike. Veteran statesman M.C. Chagla, has described the party as 'a glimmer of hope' in an otherwise very depressing situation. In a symposium titled 'The Challenge of 1981' published by Times of India's Sun-Chagla wrote that "there is just a glimmer of hope which is beginning to show itself and that is the extraordinary strength which this new party, the BJP, has shown.... And if this party goes on from strength to strength and receives the support of people from all over the country we might at last have a democratic alternative to Indira's Government.

The BJP led NDA Government after it assumed charge in 1998 embarked on policy changes and reforms in various sectors to put economy on rails and to promote growth with equity. The main issues confronting the economy were:

(i) The need to tackle the high gross fiscal deficit of the Centre and State Governments together; (ii) Low savings and investment:

(iii) High interest rates and reduced growth;

(iv) Adverse pressures on inflation, financial markets and ex-

ternal sector. (v) Mounting interest payments leaving a declining share of Government expenditure available for essential functions such as defence, law and order, social services and public investment in infrastructure:

(vi) Redefinition and narrowing of Government responsibilities to focus on primarily social sector;

(vii) Systematic efforts to reduce subsidies by targeting these to the poorest segments of soci-

(viii) Disinvestments of commercial undertakings such as power utilities, transport undertakings and others; (ix) A concerted programme to

deploy user charges for eco-

nomic services rendered by Government; (x) Systematic induction of information technology tools and modern management practices to enhance efficiency of gover-

nance and resource generation; (xi) Institutional reforms necessary to nurture modern-economic growth. This requires changes in legal and administrative structures, reform of legal system modernisation of laws, regulations and rules which gov-

ern and influence economic transactions:

(xii) Launching of effective public programmes for irrigation, agriculture and allied activities, agricultural research, rural credit:

(xiii) Ensuring larger investment in agriculture and rural development-promoting private investment in this sector;

(xiv) Bringing about reform of

policies for agriculture trade, pricing and marketing to bring about rapid development of agriculture:

(xv) Removal of controls on agricultural exports and import controls:

(xvi) Giving priority to development of infrastructure including power, roads, ports, telecommunications and civil aviations:

(xvii) Providing dedicated, high quality long-term private investment in higher education, kill generation; (xviii) Reform of financial

sector by making structural changes aimed at removal of rigidities of the banking system and tackling the problem of weak banks and non-performing assets; (xix) Reforms in India's exter-

nal economic policies relating to foreign trade, investment, external debt and currency convert-After identifying the major is-

sues and priorities, the Government embarked on policy initiatives to tackle these in a systematic man

ner. In 2003-04, some major initiatives were further an-

nounced like: • Antyodaya Anna Yojana expanded from April 1, 2003 to cover an additional 50 lakh families raising the total coverage to more than a quarter of all Below Poverty Line (BPL) families in 2003-04.

· A community-based Universal Health Insurance Scheme launched in July 2003.

· A special pension policy, Varishtha Pension Bima Yojana, guaranteeing an annual return of per cent in the form of a monthly pension scheme launched in July 2003.

• National Programme for Education of Girls at Elementary Level (NPEGEL) launched in 2003-04 for providing additional components for education of girls at elementary level.

· Pradhan Mantri Swasthva Suraksha Yojana (PMSSY) designed with an objective, to provide AIIMS like institutions in six backward states of Bihar, Chhattisgarh, Madhya Pradesh, day Review (January 18, 1981), Orissa, Rajasthan and Uttaran-

 Unorganised sector workers social security scheme launched in January 2004 on a pilot basis in 50 districts in the country.

The question of reviving the Jana Sangh was considered at this meeting. But this idea was not accepted. Vajpayee firmly said: "No. We should not turn back. We will make use of our experience in the Janata Party. We shall move ahead on the strength of our original thinking and principles.'

According to the Constitution of BJP the objective of the party

is as follows: The party is pledged to buildup India as a strong and prosperous nation, which is modern, progressive and enlightened in outlook and which proudly draws inspiration from India's ancient culture and values and thus is able to emerge as a great world power playing an effective role in the comity of the nations for the establishment of world peace and a just international order. The party aims at establishing a democratic state which guarantees to all citizens irrespective of caste, creed or sex, political, social and economic justice, equality of opportunity and liberty of faith and expression. The party shall bear true faith and allegiance to the Constitution of India as by law established and to the principle of socialism, secularism and democracy and would uphold the sovereignty, unity and integrity of India.

**Five Commitments:** BJP adopted five principles viz. 'Our Five Commitments'.

They were: 1. Nationalism and National Integration: The first principle adopted

was 'Nationalism and National Integration'. In the era of Nation States, the welfare of the people depends largely on nation's efforts.

Defence of national interests should become the primary concern of every Indian. India is one nation and Indians are one people; constituting and mutually accommodating plurity of religious faiths, ideologies, languages, interest etc. People of allies were able to form a majordifferent faiths and different ideologies should be able to coexist in peace and harmony with one another. Those who have external or extra-territorial loyalties or are engaged in anti-social activities have to be kept out.

2. Democracy Second commitment is to Democracy, a fundamental plank of the JP Movement. The subversion of the democratic institutions had been going on for a long time. To defend democratic institutions and norms and to fight ceaselessly against emerging fascist trend and to defend democracy and fundamental rights was an important commitment. In this regard decentralisation of administration assumes importance. It is not enough to have representative democracy at the level of Parliament and State legislatures operating through bureaucracy but also to have institutions of participatory democracy at district, Intermediate and Panchayat levels with adequate powers and financial resources guaranteed by the Constitution in order to involve people in the efforts for national reconstruction and to make them feel responsible for shaping their own destinies.

3. Positive Secularism

third commitment adopted is 'positive Secularism', that is 'Sarva Dharma Sama Bhavana' based on moral values. The Congress concept of secularism identified it simply with protection of

interests of religious minorities with a view to nursing communal vote banks. It became a respectable garb for appease-

ment of narrow communal and sectional interests. No doubt, protection of minority interests s an important aspect of secularism. But in its totality, secularism is a much wider and more positive concept. It constitutes the bedrock of democracy. A state that discriminates between one citizen and another on grounds of their faith, which does not treat them equally, cannot claim to be truly democratic because one of the cardinal principles on which democracy is based is equality of all citizens. Commitment to secularism is as fundamental as commitment to democracy. Secularism is also a guarantee of nationalism and national integration. It is this broad concept of secularism that BJP subscribes to. A truly secular state can be established only if a sense of 'Indianness' gets instilled in every citizen, irrespective of his religion, caste, region or language.

4. Gandhian Socialism

The Fourth commitment is 'Gandhian Socialism'. The BJP adopts Gandhain approach to socio-economic issues leading to the establishment of an egalitarian society free from exploitation. Gandhian approach to economy aims at decentralisation of power and regulating the production and patterns of consumption to ensure distributive justice, which represents the basic feature of integral humanist approach. Integral Humanism demands a technology with a human face. A technology which provides employment and bread to the hungry millions and economic system, which is free from exploitation. This is a must for improvement of quality of life. Bread, Freedom and Employment are also the Gandhian first principles. In the Gandhian framework, there is always a scope for large, medium and small and there need not be restriction on any technology so long as it does not debase human beings or becomes an instrument of exploitation or neo-colonialism.

5. Value-based Politics: Fifth commitment adopted by BJP is 'Value-based Politics'. Integral Humanism believes in a value-based society. Political activity without any commitment to a set of norms and values becomes merely a self-seeking game. Social and political life should be guided by a set of norms and values, the abridgement of which should bring forth social sanctions and punishment. BJP will strive to build up such a 'value-based politics' and, thus, cleanse the public life and restore moral values. Irrespective of caste creed, language, region, an average Indian cherishes deep respect for values like tolerance, contentment's, simple living, hardwork and brotherhood.

BJP emerged as the largest single party in the LS election, 1996 and was invited by India's president to form a government. However, its tenure in office was short-lived, as it could not muster the majority required to rule in the 545-member lower house. In 1998 the BJP and its ity government with PM Vaipayee. In May of that year, nuclear weapons tests ordered by Vajpayee drew widespread international condemnation. After 13 months in office, coalition partner All India Dravidian Progressive Federation (All India Anna Dravida Munnetra Kazagham) withdrew its support, and Vajpayee was prompted to seek a vote of confidence in the LS, which he lost by the margin of a single vote.

BJP then contested the 1999 parliamentary elections as the organizer of the NDA, a coalition of more than 20 national and regional parties. The alliance secured a governing majority, with the BJP winning 182 of the coalition's 294 seats. Vajpayee, as leader and was again elected the PM. Although he sought to resolve the country's long-standing conflict with Pakistan over the Kashmir region and made India a world leader in information technology, the coalition lost its majority in the 2004 parliamentary elections to the Congress Party's United Progressive Alliance (UPA) coalition, and Vajpayee resigned from office.

Return to power BJP's fortunes began to rise, largely because of the growing discontent with Congress Party rule. Narendra Modi, the longtime Chief Minister of Gujarat, was chosen to lead the BJP electoral campaign, thus making him the party's candidate for PM. The party won 282 seats outright, and its NDA partners added 54 more. Modi was then named head of the party, and began forming a government that included not only senior BJP officials but also several leaders from parties allied with the coalition. Modi was sworn in as

the PM on May 26, 2014. BJP rule included a mixture of policies relating to the economy and to promoting Hindutva. On November 8, 2016, ₹ 500 and ₹ 1,000 banknotes were demonetized with just a few hours' notice with the intent of stopping 'black money'. More than 99% of the banknotes were returned and replaced, indicating even black money had been successfully exchanged and returned to circulation. But the policy did broaden the income tax base through increased bank activity and stimulated the use of cashless transactions. In 2017 the Goods and Services Tax (GST) was introduced, reforming the collection of consumption taxes nationwide

Meanwhile, the BJP appealed to notions of Hindutva through measures such as banning the sale of cows for slaughter, a move later overturned by the Supreme Court. The party likewise legislated name changes for certain jurisdictions. As both unemployment and the cost of living continued to rise and Modi's grandiose promises on economic growth remained unfulfilled, the BJP began suffering local election losses. In 2018 the party lost all 5 state elections held in November and December, including those in its strongholds of Madhya Pradesh, Rajasthan, and Chhattisgarh. On the national level, however, the party was able to pull off a landslide victory in 2019 and even expanded its representation in the LS. This was in part due to the support it gained after the government's handling of a security crisis in Jammu and Kashmir(J&K) in February 2019.

The party's second term in power was marked by swift and heavy-handed actions. In August 2019 the BJP-led government stripped J&K of its autonomy and brought it under the direct control of the union government. Communications and movement in the territory were severely restricted during the transition. In March 2020 the spread of the global COVID-19 pandemic prompted the government to implement a strict national lockdown until June. As restrictions were eased, the BJP made efforts to counter the economic impact of the pandemic. Those efforts included Modi's use of executive action to reduce obstacles to selling produce and to encourage private investment.

The BJP aimed to secure 370 seats in the 2024 LS elections even though it needed just over 272 seats to win. In a surprising turn of events, it faced stiff competition from the opposing INDIA alliance and failed to secure a majority on its own even though its alliance, the NDA, won enough seats to form the government at the center.

# Aurangzeb's tomb: A reflection of imperial decline and historical controversies

Three days after violent clashes erupted in Nagpur, authorities partially lifted the curfew in affected areas on March 20, 2025. At the heart of the unrest is the tomb of the Mughal emperor Aurangzeb, a historical site now embroiled in contemporary political and ideological disputes. The Vishva Hindu Parishad (VHP) and other Hindutva organizations have called for its removal, reigniting discussions on the legacy of one of India's most controversial rulers. While Aurangzeb died over 300 years ago, on February 20, 1707, his unassuming grave, once largely forgotten, has become a focal point of modern conflict. However, beyond the presentday turmoil, the emperor's burial site and his final years offer profound lessons on the rise and fall of empires, the fragility of power, and the ironies of his-

The Final Years of Aurangzeb: An Empire in Decline

Aurangzeb reigned for nearly five decades, the longest rule of any Mughal emperor. Under his dominion, the empire reached its territorial zenith but also sowed the seeds of its eventual downfall. By the late 17th century, his reign was marked by an agrarian crisis, growing discontent among the nobility, and relentless military conflicts, particularly against the Marathas in the Deccan. As the empire's administrative efficiency crumbled, regional forces such as the Marathas gained strength, posing a formidable challenge to Mughal authority.

It was during one of these prolonged military campaigns in the Deccan that Aurangzeb met his end. Nearing the age of 90, the emperor succumbed to illness, leaving behind an empire that was fracturing under its own weight. Unlike his predecessors, who were buried in grandiose mausoleums reflecting the splendor of their reigns, Aurangzeb had explicitly instructed a simple burial, adhering to Islamic austerity. His grave lies within the dargah complex of Sheikh Zainuddin, a 14th-century Chishti Sufi saint in Khuldabad, Maharashtra.

Austere in Death: Aurangzeb's Unadorned Grave

Aurangzeb's tomb starkly contrasts with those of his forebears. While Humayun, Akbar, Jahangir, and Shah Jahan rest in grand edifices visited by tourists worldwide, Aurangzeb's burial site is modest and unembellished. Saqi Musta'd Khan's Maasir-i-Alamgiri, later translated by historian Sir Jadunath Sarkar, provides a detailed account of his burial: "According to His Majesty's last will, he was buried in the courtyard of the tomb of Shaikh Zainuddin [at Rauza, near Daulatabad] in a sepulcher built by the emperor in his own lifetime. The red stone platform over his grave, not exceeding three yards in length, two and a half yards in breadth, and a few fingers in height, has a cavity in the middle. It has been filled with earth, in which fragrant herbs have been planted.

Over time, his grave received a minimal enhancement. American historian Catherine Asher, in Architecture of Mughal India, notes that Aurangzeb's open-air tomb was originally marked by



a simple stone cenotaph. In the early 20th century, British Viceroy Lord George Curzon had a white marble screen erected around the grave, not as an endorsement of Aurangzeb's policies, but in acknowledgment of his status as one of India's longest-reigning monarchs

The Significance of Khuldabad: A Chosen Resting Place

Aurangzeb's decision to be buried in Khuldabad, formerly known as Rauza, carries historical and religious significance. The site is home to the shrines of many revered Sufi saints, and Aurangzeb, despite his rigid Sunni orthodoxy, expressed reverence for Sufism. This paradox is emblematic of the complexities in his character; while he enforced strict Islamic laws, he chose to be buried in a place associated with Sufi mysticism, which often diverged from orthodox interpretations of Islam.

The tomb complex also houses the graves of his son Azam Shah, who briefly ascended the Mughal throne, and the first two Nizams of Hyderabad—Asaf Jah I and his son Nasir Jung. This further cements Khuldabad's importance as a resting place for key figures in India's early modern history.

The Contradictions in Aurangzeb's

Aurangzeb's legacy remains deeply polarizing. Historian William Dalrymple describes him as a "depressingly puritanical figure," enforcing bans on music, art, and public celebrations that were hallmarks of the Mughal court. Yet, his actions defy simple categorizations. Despite his austere religious policies, his choice of burial site reveals a continued esteem for Sufi saints, whose beliefs often ran counter to strict orthodorum.

His tomb is notably similar to that of his elder sister, Jahan Ara, who is buried in a simple grave within the Nizamuddin Auliya dargah in Delhi. Ironically, Jahan Ara had been a staunch supporter of Prince Dara Shikoh, Aurangzeb's rival in the succession battle. Dara Shikoh, known for his syncretic religious views, was executed on Aurangzeb's orders, yet the contrast between their religious inclinations is blurred by the striking similarities in their final resting places.

Tomb Architecture as a Reflection of Mughal Fortunes

The grand tombs of earlier Mughal

emperors symbolized imperial stability and prosperity. In contrast, Aurangzeb's modest grave serves as a reminder of the Mughal Empire's decline. Historian Michael Brand, in his research paper Orthodoxy, Innovation, and Revival: Considerations of the Past Imperial Mughal Tomb Architecture, observes that "while Babur and Aurangzeb willed their own simple burials, Humayun, Akbar, and Jahangir were all entombed in structures built by their sons and successors. It can be asked whether Mughal tombs were really erected to commemorate dead emperors or as victory monuments for the survivors of internecine warfare."

Aurangzeb's grave signifies that, unlike his predecessors, he lacked powerful successors capable of cementing his legacy through grand architecture. The Mughal Empire, from Babur to Aurangzeb, had in a sense come full circle—an empire that began with Babur's modest burial in Kabul ended with Aurangzeb's simple tomb in Khuldabad.

A Dying Emperor's Reflections
Aurangzeb himself was acutely aware
of his failures. In his last days, he
penned a letter to his son, Prince Azam,
filled with regret and existential reflection. Historian Jadunath Sarkar, in A
Short History of Aurangzib, quotes the
letter: "I know not who I am and what I
have been doing. I have not at all done
any (true) government of the realm or
cherishing of the peasantry. Life, so
valuable, has gone away for nothing."
These words, spoken by a ruler once
feared across the subcontinent, reflect
the weight of his unfulfilled aspirations.

Lessons from Aurangzeb's Grave Aurangzeb's tomb, unassuming yet historically profound, encapsulates the contradictions of his reign—religious rigidity versus personal reverence for Sufi saints, imperial ambition versus administrative failure, and power versus ultimate humility in death. Whether viewed as a tyrant or a ruler who upheld his convictions, his resting place stands as a testament to the impermanence of power. In the modern era, where historical grievances fuel contemporary conflicts, Aurangzeb's life and legacy serve as a crucial reminder that history is seldom black and white—it is a landscape shaped by paradoxes, ambitions, and, ultimately, the passage of time. # China's frequent military drills spark concerns in Taiwan of real attack with little time to respond

high-intensity drills conducted by the Chinese military around Taiwan by air, land, sea, and missile forces are raising concerns in the island about whether its military would have sufficient time to respond to a potential Chinese attack.

These drills by the People's Liberation Army (PLA) are gradually narrowing the beleaguered island's strategic space through a "salamislicing" approach, according to a

Apprehensions are mounting that these high-profile drills may escalate into an attack with Taiwan having no time to respond. China claims the island as part of its mainland, asserting that it will take over it through peaceful means or

Early this month, China held two-day large-scale military drills around Taiwan, which the PLA said tested its integrated joint operation capabilities and focused on blockade enforcement of the estranged island.

It was the sixth large-scale exercise conducted by the PLA since August 2022.

Besides concerns over a real attack, there is a growing concern over whether the Taiwanese military would be able to respond quickly enough as the PLA continues its strategy of gradually eroding buffer zones, the Hong Kong-based South China Post quoted military officials from Taipei as saying.

One former Taiwanese Air Force commander warned that if the Chinese warplanes could reach Taipei within three minutes of crossing

#### Nine terrorists killed in security operation in Pakistan's KP

PESHAWAR, April 7: Nine terrorists have been killed during an intelligence-based operation in Khyber Pakhtunkhwa province of Pakistan, the media wing of the military said

The terrorists belonging to the banned Tehreek-e-Taliban Pakistan (TTP) group were killed during Sunday night's operation by security personnel in the Takwara area of Dera Ismail Khan district, an ISPR statement said.

The statement said Pakistani troops effectively engaged the terrorists' location and killed nine terrorists, including high-value target Shireen, after an intense exchange of fire. The statement said Shireen, a group leader, was wanted for his "involvement in numerous terrorist activities" and "in target killing of

Shireen was also responsible for the death of Captain Hasnain Akhtar on March 20, the statement added The forces also recovered weapons and ammunition from their

possession, it said The statement said a "sanitisation operation" was being conducted to eliminate the presence of any other

terrorists in the area. Pakistan has witnessed an uptick in terror activities over the past year, particularly in Khyber Pakhtunkhwa and Balochistan, after the militant

group ended its ceasefire with the

government in November 2022. On Sunday, security forces killed eight terrorists and injured another four as they thwarted an infiltration attempt on the Pakistan-Afghanistan

Violence by Militant and security operations intensified in Pakistan in March, with the number of terror attacks surpassing 100 for the first time since November 2014, data released by the Pakistan Institute for Conflict and Security Studies (Picss)



the median line in the Taiwan Strait, which separates China and Taiwan, it would be too quick for the island's air force to respond.

"The scale and complexity of these drills suggest that the PLA is building an operational familiarity with an attack scenario," Arthur Chi, a military analyst at Taiwan's Institute for National Defence and Security Research, a government think tank said.

"Through these exercises, the PLA is also testing how Taiwan military responds using it as a reference for future combat planning,"

Analysts agreed that Beijing's incremental encroachment tactics commonly referred to as "salami slicing" – were blurring the line between routine drills and acts of aggression, the report said.

"Salami slicing" is the most frequently aired concern along the Line of Actual Control (LAC) dividing India and China where the Chinese military is accused of

gradual encroachment of disputed

territories.

In Taiwan, each exercise expanded the PLA's operational footprint, eroding long-standing norms such as the median line and testing the island's responses, the analysts

Chi said the PLA's gradual encroachment into Taiwan's air and sea defence spaces was even more concerning.

Taiwan's defence ministry earlier confirmed that some PLA warplanes and ships came close to the island's contiguous zone, which extends 44.4km from the coast.

"Each step appears minor in isolation but contributes to a broader erosion of Taiwan's strategic space," Chi said.

Taiwan officials have been asserting that China is finalising plans to attack the island in 2027 but strategic analysts aver that Russia's attack on Ukraine and US President Donald Trump's open as-

trol over Panama Canal may embolden Beijing to advance its military plans.

These drills have raised concern in Taipei that such an exercise could seamlessly transition into an attack, with Taiwanese Defence Minister Wellington Koo Li-hsiung warning the military to be aware of such a possibility and be prepared to rapidly escalate its alert levels.

"Through joint intelligence, surveillance and reconnaissance operwell

intelligence-sharing with allies, we have determined that the time required for the PLA to transition from exercises to actual combat may not be as long as previously assumed," Koo said last month.

"Without vigilance, the military could fail to mobilise in time should an emergency arise," he

#### Japanese emperor visits Iwo Jima to honour dead in one of WWII's fiercest battles

IWO-TO (JAPAN), April 7: Japan's Emperor Naruhito visited Iwo Jima on Monday and paid tribute to thousands of Japanese and Americans who died in one of World War II's bloodiest battles.

Naruhito and his wife, Empress Masako, prayed at three memorial sites — one for the Japanese soldiers, another for the islanders and a third for both Japanese and American war dead. The couple offered a bouquet of white flowers and poured water over a cenotaph from a ladle to console those who died under the heat while suffering from hunger and thirst. They were due to meet with representatives of bereaved families and descendants of former island res-

The visit by the royal couple, both

born after the war, is the first to Iwo

Naruhito, in his 65th birthday remarks in February, noted the 80th anniversary of the end of WWII and stressed the importance of remembering the wartime history and telling younger generations about the tragedy. Japan fought the war and invaded large areas of Asia in the name of his grandfather, Emperor Hirohito.

The battle of Iwo Jima lasted from Feb. 19 to March 26, 1945, as the United States tried to take control of a key strategic point to advance to mainland Japan. Despite expectations by the US they would overwhelm the Japanese within days, Japanese soldiers used underground tunnels and resisted for five weeks,

spired many novels and movies.

Nearly all of the more than 21,000 Japanese and nearly 7,000 US troops were killed. More than half of the remains of the Japanese are still unaccounted for. All 1,100 residents of Iwo Jima except for 103 men drafted as military employees were forcibly evacuated to mainland Japan. Of the 103, 82 were killed in the fighting.

The emperor's Iwo Jima visit comes 10 days after Japanese Prime Minister Shigeru Ishiba and Defence Minister Gen Nakatani joined US Secretary of Defence Pete Hegseth in a memorial service marking the end of the battle. Former residents and their descen-

footprint in the Gaza Strip since relaunching its war against Hamas last month. It now controls more than 50% of the territory and is squeezing Palestinians into shrinking wedges of land.

The largest contiguous area the army controls is around the Gaza border, where the military has razed Palestinian homes, farmland and infrastructure to the point of uninhabitability, according to Israeli soldiers and rights groups. This military buffer zone has doubled in size in recent

Israel has depicted its tightening grip as a temporary necessity to pressure Hamas into releasing the remaining hostages taken during the Oct. 7, 2023, attack that started the war. But the land Israel holds, which includes a corridor that divides the territory's north from south, could be used for wielding long-term control, human rights groups and Gaza experts say.

Prime Minister Benjamin Netanyahu said last week that even after Hamas is defeated, Israel will keep security control in Gaza and push Palestinians to leave.

The demolition close to the Israeli border and the systematic expansion of the buffer zone has been going on since the war began 18 months ago, five Israeli soldiers told The Associated Press.

"They destroyed everything they could, they shot everything that looks functioning ... (the Palestinians) will have nothing to come back, they will not come back, never," a soldier deployed with a tank squad guarding the demolition teams said. He and four other soldiers spoke to the AP on condition of anonymity for fear of reprisals.

A report documenting the accounts of soldiers who were in the buffer zone was released Monday by Breaking The Silence, an anti-occupation veterans group. A handful of soldiers -- including some who also spoke to AP -- described watching the army turn the zone into a vast waste-

"Through widespread, deliberate destruction, the military laid the groundwork for future Israeli control of the area," said the group.

Asked about the soldiers' accounts, the Israeli army said it is acting to protect its country and especially to improve security in southern communities devastated by the Oct. 7 attack, in which some 1,200 people were killed and 251 taken hostage. The army said it does not seek to harm civilians in Gaza, and that it abides by international law.

Carving Gaza into sections In the early days of the war, Israeli troops forced Palestinians from communities near the border and destroyed the land to create a buffer zone more than a kilometer (0.62 miles) deep, according to Breaking The Silence.

Its troops also seized a swath of land across Gaza known as the Netzarim Corridor that isolated the north, including Gaza City, from the rest of the narrow, coastal strip, home to more than 2 million people

When Israel resumed the war last month, it doubled the size of the buffer zone, pushing it as far as 3 kilometers (1.8 miles) into Gaza in some places, according to a map issued by the military.

The buffer zone and the Netzarim Corridor make up at least 50% of the strip, said Yaakov Garb, a professor of environmental studies at Ben Gurion University, who has been examining Israeli-Palestinian land use patterns for decades. Last week, Netanyahu said Israel intends to create another corridor that slices across southern Gaza, cutting off the city of Rafah from the rest of the territory. Israel's control of Gaza is even greater taking into account areas where it recently ordered civilians to evacuate ahead of planned attacks.

Neighbourhoods turned into rubble

Hundreds of thousands of Palestinians used to live in the land that now makes up Israel's buffer zone, an area that was key to Gaza's agricultural output.

TEL AVIV, April 7: Israel has dramatically expanded its to rubble, as well as nearly a dozen new Israeli army out-

posts since the ceasefire ended. When the ceasefire was announced in January, Nidal Alzaanin went back to his home in Beit Hanoun in northern Gaza. His property stood on the edge of the buffer zone

and lay in ruins. All that remains is a photo of him and his wife on their wedding day, a drawing of his son's face on a porcelain plate and the carcass of a 150-year-old sycamore tree planted by his great-grandfather. His greenhouse was reduced to twisted scraps of metal.

The 55-year-old farmer pitched a tent in the rubble, hoping to rebuild his life. But when Israel resumed its campaign and seized his land, he was again uprooted.

"It took 20 years to build a house and within five minutes they destroyed all my dreams and my children's dreams," he said from Gaza City, where he now shelters.

Israel's bombardment and ground offensives throughout the war have left vast swaths of Gaza's cities and towns destroyed. But the razing of property inside the buffer zone has been more methodical and extensive, soldiers said.

The five soldiers who spoke to the AP said Israeli troops were ordered to destroy farmland, irrigation pipes, crops and trees as well as thousands of buildings, including residential and public structures, so that militants had nowhere to hide.

Several soldiers said their units demolished more buildings than they could count, including large industrial complexes. A soda factory was leveled, leaving shards of glass and solar panels strewn on the ground.

Soldier alleges buffer zone was a kill' zone

The soldiers said the buffer zone had no marked boundaries, but that Palestinians who entered were shot at.

The soldier with the tank squad said an armoured bulldozer flattened land creating a "kill zone" and that anyone who came within 500 meters of the tanks would be shot, including women and children.

Visibly shaken, he said many of the soldiers acted out of vengeance for the Oct. 7 attack.

"I came there because they kill us and now we're going to kill them. And I found out that we're not only killing them. We're killing them, we're killing their wives, their children, their cats, their dogs, and we destroyed their houses," he said.

The army said its attacks are based on intelligence and that it avoids "as much as possible, harm to non-combat-

Long-term hold?

It is unclear how long Israel intends to hold the buffer zone and other territory inside Gaza.

In announcing the new corridor across southern Gaza, Netanyahu said Israel aims to pressure Hamas to release the remaining 59 hostages, of whom 35 are believed dead. He also said the war can only end when Hamas is destroyed and its leaders leave Gaza, at which point Israel would take control of security in the territory.

Then, Netanyahu said, Israel would implement US President Donald Trump's call to move Palestinians from Gaza, what Israel calls "voluntary emigration."

Some Israel analysts say the purpose of the buffer zone isn't to occupy Gaza, but to secure it until Hamas is dismantled. "This is something that any sane country will do with regard to its borders when the state borders a hostile entity," said Kobi Michael, a senior researcher at two Israeli think tanks, the Institute for National Security Studies and the Misgav Institute.

But rights groups say forcibly displacing people is a potential war crime and a crime against humanity. Within Gaza's buffer zones, specifically, it amounts to "ethnic cleansing," because it was clear people would never be allowed to return, said Nadia Hardman, a researcher at Human Rights Watch.

Israel called the accusations baseless and said it evacuates civilians from combat areas to protect them. (AP)

# World's largest deforestation project fells forests for bioethanol fuel, sugar, rice in Indonesia

JAKARTA, April 7: Indonesia plans to clear forests about the size of Belgium to produce sugarcane-derived bioethanol, rice and other food crops, potentially displacing Indigenous groups who rely on the land to survive.

Local communities say they're already experiencing harm from the government-backed project, which environmental watchdogs say is the largest current planned deforestation operation in the world. A vast tropical archipelago stretch-

ing across the equator, Indonesia is home to the world's third-largest rainforest, home to many endangered species of wildlife and plants, including orangutans, elephants and giant forest flowers. Some live nowhere else. Indonesia has been building food es-

tates, massive plantations designed to improve the country's food security for decades, with varying level of success. The concept was revived

by former President Joko Widodo during his 2014- 2024 administration. The current president, Prabowo Subianto, has expanded such projects

to include crops to produce bioethanol,

sugar cane or corn, in pursuit of Indonesia's ambition to improve its energy mix and develop more renewable

"I am confident that within four to five years at the latest, we will achieve food self-sufficiency," Prabowo said in October 2024. "We must be self-sufficient in energy and we have the capacity to achieve this.'

Biofuels, such as bioethanol, play an important role in decarbonising transport by providing a low-carbon solution for sectors that heavily rely on fossil fuels such as trucking, shipping and aviation, according to the International Energy Agency. But the agency also cautions expansion of biofuel should have minimal impact on landuse, food and other environmental factors in order to be developed

sustainably. That's of particular concern in Indonesia, where more than 74 million hectares (285,715 square miles) of Indonesian rainforest — an area twice the size of Germany — have been logged, burned or degraded for development of palm oil, paper and rubber plantations, nickel mining and other commodities since 1950, according to Global Forest Watch.

Indonesia has vast potential for bioethanol production due to its extensive agricultural land but currently lacks sustainable feedstocks, like sugarcane and cassava. A previous attempt to introduce bioethanol-blended fuel in 2007 was discontinued a few years

later due to a lack of feedstock supply. Since then, the government has accelerated work on its food and energy estate mega-project, which spans 4.3 million hectares (about 10.6 million acres) on the islands of Papua and Kalimantan. Experts say the combined size of the numerous project sites makes the mega-project the largest current defor-

estation project in the world. The largest site, called the Merauke Integrated Food and Energy Estate, will cover more than 3 million hectares (7.4 million acres) in the far-eastern region of Papua, according to the international environmental organisation

Mighty Earth. Överlapping with the Trans-Fly



ecoregion, it's home to critically endangered and endemic mammals, birds and turtles and to several Indigenous groups who rely on traditional ways of

"Imagine every piece of vegetation in that area being completely cleared ... having all the trees and the wildlife erased from the landscape and replaced with a monoculture," said Glenn Horowitz, CEO of Mighty Earth. "It's creating a zone of death in one of the

most vibrant spots on Earth."

An unpublished government feasibility assessment obtained and reviewed by The Associated Press estimates that carbon dioxide emissions from clearing land for the project will total 315 million tonnes of C02 equivalent. An independent assessment by the Indonesia-based think tank Center of Economic and Law Studies esti-

mated double that. Deforestation contributes to erosion, damages biodiverse areas, threatens wildlife and humans who rely on the forest and intensifies disasters from ex-

treme weather. Djojohadikusumo, Hashim Subianto's brother and envoy for energy and the environment, said the government will reforest 6.5 million hectares (16 million acres) of degraded

#### AIZAWL, April 7: Financial frauds were the most common cybercrime in Mizoram, accounting for 56.38 per cent of 321 cases registered between January 2020 and March 11 this year, as per official

A total of 181 cases of financial crimes, primarily online banking fraud and cheating by impersonation, were registered during the period, records from the state cybercrime police station said.

Other offences include identity theft (32 cases), child pornography (16), social media harassment (nine), copyright infringement (seven), false rumours (five), and hacking (one).

The highest number of financial crimes was reported in 2022 during which 107 cases were registered, the records said.

More than ₹ 1.42 crore was recovered in financial fraud cases between 2021 and March 11, 2025.

The state registered the highest number of cybercrimes in 2022, recording 158 cases, followed by 72 cases in 2023, the records

The number of cybercrime cases decreased to 41 in 2024, and of these, 17 were related to financial crimes and 15 to sexual harass-

In the current year till March 11. thirteen cybercrime cases were registered, of which six were related to sexual harassment and four to financial fraud.

The records stated that 113 people, including eight juveniles, were arrested in cybercrime cases and 40 of them were convicted, since

# ASEAN-India Artists' Camp concludes LNKR condemns brutal attack on civilians

IMPHAL, April 7: The Liangmai Naga Katimai Ruangdi, Manipur (LNKR) strongly condemned the "heinous incident" that occurred on April 5, 2025, at around 11:45 am. The attack was allegedly carried out by individuals identified as Thangnaimang Veiphei, chief of L. Phaijang Kuki village, Thangkhulen Veiphei, chief of Munlai Kuki village, and Houmang Veiphei, chief of Haraothel Kuki village, the Liangmai student body said.

Despite the curfew imposed by the district magistrate of Kangpokpi, these individuals led a sudden and brutal assault on the peaceful residents of Konsakhul/Konsaram Naga village, said the LNKR. At the time, the villagers were lawfully engaged in leveling their plots and constructing homes. This violent and unlawful action constitutes a gross violation of human rights and a blatant disregard for the rule of law, it added. The LNKR then demanded immediate action from the concerned authorities to bring the perpetrators to justice and ensure the safety and security of the Konsakhul Naga community. Such acts of aggression should not go unpunished in a democratic society, it also said. The LNKR then said, "In a deeply distressing and unforgettable turn of events, Aimson Abonmai, chief of Konsakhul Naga village, and Adam Dirinamai, chairman of Konsakhul Naga village, along with three other individuals— Ch. Paramchandin, Ab. Widinbou, and Th. Aloipu—were assaulted".

# Manipur MLA to challenge Waqf Amendment Act in Supreme Court

The LNKR also said such "heinous acts of assault, abduction, arson, and theft in Konsakhul Naga village are not isolated but have been increasing at an alarming rate. The student body added that the continued silence and restraint shown by the Naga community must not be mistaken for weakness. "It is disturbing that certain groups—particularly Kuki settlers, whose presence in Konsakhul traces back to the goodwill and hospitality of the Nagas-now act in ways that disregard the rights of the indigenous landowners and threaten communal harmony". The party said the Ahmedabad Session will be themed "Nyaypath: Sankalp, Samarpan and Sangharsh", with more that 1,700 elected and co-opted AICC members attending the main conclave on April

"Every section is suffering today. They are feeling cheated and are looking at the Congress with hope because democracy is being mur-



dered. Thus, as a responsible political party, it is our duty to come forward and lead them towards light from today's darkness," Khera said at a press conference.

"While people are looking at the Congress, we are looking at Gujarat because this state, the land of Mahatma Gandhi and Sardar Patel, had always shown us the way in difficult times. That is why our leadership has chosen Gujarat to hold the CWC and AICC session. We are sure Gujarat will show us the way forward," said Khera.

He said despite slogans like "Congress-mukt Bharat" and attempts to eliminate it from the political map, the party remains standing as "it is the voice of the citizens, not just a political party". Amit Chavda, Congress Legislative Party (CLP) leader in the Gujarat Assembly, said many important issues concerning the people of the state and country will be discussed in the AICC session.

"Issues such as malnutrition, high cost of education, contract system in employment, people affected by demolitions, inflation and corruption will be discussed in the AICC session, which will begin at 9:30 am on Wednesday," Chavda

As per a party release, the CWC meeting will see participation of 262 leaders, including Sonia Gandhi and Rahul Gandhi and party president Mallikarjun Kharge. Incidentally, a CWC meeting was held at the same venue in 2019 ahead of the Lok Sabha elections.

"The CWC meeting will begin

#### We are learning from mistakes in Bihar, empowerment of downtrodden now top priority: Rahul

PATNA, April 7: Congress leader Rahul Gandhi on Monday asserted that his party was "learning from its mistakes in Bihar" where the party had been lax in bringing about all-round development through empowerment of the downtrodden.

The Leader of the Opposition in the Lok Sabha was addressing a symposium in the state capital, months ahead of the crucial assembly polls in which the Congress, in alliance with RJD and the Left, will take on the formidable ruling NDA.

While addressing the "Samvidhan Suraksha Sammelan" (Save the Constitution Symposium), Gandhi claimed that Prime Minister Narendra Modi had built a "system" in which the country is being run by five per cent of the population and 10-15 people are controlling the entire corporate world.

"I must be the first person in the Congress to admit that we did not work, in Bihar, with the zeal we should have. But we shall move forward learning from our mistakes. Our party, and the coalition of which we are a part, shall strive for uplift of SCs, STs, OBCs, extremely backward classes and minorities," said the Congress leader, whose party's decline in the state began with the Mandal wave of the 1990s

He said, "We recently did something which may not have been great but was still of significance. We reconstituted District Congress Committees. Earlier, twothirds of these were headed by upper castes. Now two-thirds of these are headed by the deprived castes. This has been in line with clear instructions from (national president Mallikarjun) Kharge ji and me for the organization"

Claiming that Bihar has been the land of great political changes, starting from the Independence struggle, Gandhi alleged that at present, the NDA's politics is serving the interests of billionaires. "We are sure that Bihar will once again serve as a catalyst for change," he said. The Congress leader, who was on his third tour of the state in four months, had earlier visited Begusarai, about 150 km away, to take part in "palayan roko, naukri do (stop migration, give jobs) pada-yatra", an initiative of the party's student and youth wings to highlight Bihar's endemic problem of joblessness and mi-

which is also the home state of the party's youth wing national in charge Kanhaiya Kumar. The former Congress president, however, was joined there by thousands of young supporters, many of them wearing white Tshirts like the leader has been doing since the "Bharat Jodo Yatra" a couple of years ago. Union minister Giriraj Singh, who represents Begusarai in the Lok Sabha, appeared miffed at the Leader of the Opposition's presence in the town. "Rahul Gandhi should worry about his own palayan (departure) from public mind," the BJP leader told reporters in Patna.

At the Samvidhan Suraksha Sammelan in the state capital, Gandhi gave a nearly 40-minute-long speech, calling the Constitution "not a merely 70 years old book, but an ideology that is thousands of years old, since the times of the Buddha, continuing through the era of Kabir and Guru Nanak, and ultimately inspiring Babasaheb Ambedkar". The Congress leader mocked PM Modi for "bowing down before the Constitution after the elections, realising that his bluster of 400 plus seats for the BJP had backfired and people would not allow him to tinker with the Samvidhaan

He alleged that BJP, and its parent body RSS, drew inspiration from Vinayak Damodar Savarkar "who could not stand the truth", in stark contrast with Mahatma Gandhi and Jawaharlal Nehru, the first Prime Minister, "both of whom loved truth with the same intensity as the Buddha did".

The former Congress president asserted that a nationwide caste census was needed "just like an X-ray is required to assess the injury to any part of the body", but the BJP-RSS were opposed to that.

"But they will have to get a caste census done. They will also have to pull down the fake barrier of the 50 per cent cap on quotas for the deprived castes. I have told the PM inside Parliament that if his government dithers, we will do the needful," said Gandhi

The Congress leader peppered his speech with many anecdotes, recalling interactions with qualified medical and engineering graduates and a skilled shoe-maker, all of whom, he said, were finding it difficult to realise their full potential "because of the system". (PTI)

#### NC, Congress, CPI(M) MLAs hold protest outside J&K Assembly against Waqf Act

JAMMU, April 7: The members of the coalition government in the Jammu and Kashmir Assembly on Monday held protests outside the House over the Waqf (Amendment) Act after the Speaker adjourned the House following a ruckus over the demand to discuss the new law.

The MLAs of the National Conference (NC), Congress, CPI(M) and some Independents staged a dharna at the entry gate of the Assembly and protested against the BJP-led government at the Centre.

"BJP resorted to manhandling in the House. They raised religious slogans. We reminded them that this is not a wrestling ring. We are here to raise constitutional issues," NC member Altaf Kaloo told reporters.

He said they had brought an adjournment motion in the House, which the Speaker did not accept. "In the Tamil Nadu Assembly, a resolution was passed even though Muslims constitute only 6 per cent of the population. Why can't there be discussions in this Muslim-majority region?" he said.

The Speaker rejected the demand to debate the issue, stating that issues pending in the court cannot be discussed in the House. Participating in the protest, CPI(M) member M Y Tarigami called on everyone to unite against the BJP and its divisive politics.

"I urge the people of Jammu to support us. BJP may try to give it a communal colour, but we must stand united," he said.

Congress' Irfan Hafeez Lone carried a banner against the Act, saying it is not acceptable to the people and held a protest at the staircase of the House.

Earlier, Lone held a banner — Waqf Amendment Bill is not acceptable to us -

and called BJP "anti-Mahatma Gandhi" and "supporters of Nathuram Godse" inside the House. This drew a sharp reaction from some BJP members, who rushed near the well of the House.

NEW DELHI, April 7: The BJP on Monday criticised several public interest litigations challenging the Waqf (Amendment) Act as "vote bank interest litigations". BJP national spokesperson Shehzad Poonawalla claimed that the pleas filed in the Supreme Court by several organisations are "merely an excuse to incite their vote bank and create riotlike situation in the country".

He told reporters that the only people whose interests will be harmed by the new law is the land mafia which has grabbed Waqf properties. "It seems to be less PIL and more vote bank interest liti-

The organisations behind the legal challenge to the Act, including the Congress, AIMIM, and some Muslim outfits, were also behind the allegation that the Citizenship (Amendment) Act will



snatch the citizenship of Muslims, Poonawalla alleged.

He said that the new law will ensure social justice and the application of Constitution in managing Waqf properties. Many Muslim bodies and even Chris-

tian organisations have welcomed the amendments to the Waqf Act, he noted, asserting that it is not a "Hindu-Muslim"

The BJP spokesperson said the Con-

gress had used Parliament to overturn a Supreme Court judgment, which had provided alimony to divorced Muslim women in the Shah Bano case in 1985. When Parliament has now passed a law for ensuring justice to the backward and women among Muslims, the Congress is again opposed to it, he added.

Earlier in the day, a bench comprising Chief Justice of India Sanjiv Khanna and Justices Sanjay Kumar and K V Viswanathan agreed to consider, listing for an urgent hearing, the plea of Jamiat Ulama-i-Hind, AIMIM leader Asaduddin Owaisi and others, including Congress MP Mohammad Jawed and AAP MLA Amanatullah Khan on the issue.

The All India Muslim Personal Law Board has also moved the top court against the constitutional validity of the Waqf (Amendment) Act, 2025. (PTI)

# Will fight till my last breath: Mamata vows to protect sacked Bengal teachers, restore their dignity

KOLKATA, April 7: West Bengal Chief Minister Mamata Banerjee on Monday pledged to protect the rights of "eligible candidates" who lost their jobs after the Supreme Court verdict, and asserted that she would continue fighting for them as long as she is alive and even if it meant going to jail. Speaking at a meeting with those who lost their jobs after the apex court verdict, Banerjee urged the affected teachers and staff to return to their respective schools and "voluntarilv" resume duties.

"Even if I have to go to jail, I will keep fighting to ensure no deserving candidate is deprived of job - this is my promise, as long as I am alive," she said in an emotionally charged message at the Netaji Indoor Stadium here. Speaking at a packed gathering of affected

teaching and non-teaching staffers, Baneriee said, "No one has received any termination letter yet. So continue with your work. You are free to offer voluntary service in the meantime.'

The Supreme Court on April 3 upheld a 2024 Calcutta High Court judgment annulling the recruitment of 25,753 teachers and non-teaching staffers appointed through the 2016 School Service Commission (SSC) recruitment drive, terming the entire selection process "vitiated and

Banerjee said the state administration would first seek "clarification" from the apex court, and if needed, file a review petition "to ensure the interests of eligible candidates are safeguarded".

"If the clarification is not in our favour, we will make alternative arrangements within two months. No eligible candidate will be jobless. The government has not sent any termination letters. You can continue to teach voluntarily," she

"Who will manage the schools now? Who will handle all the other tasks? If someone is not in a position to provide jobs, they shouldn't have the authority to take them away either," the CM said. Banerjee, however, said the state government

respects the top court ruling. "We are not here to disobey the Supreme Court. We will act strictly within the legal framework. But I must say, the administration wasn't given enough time to rectify the mistakes," she

She also announced the formation of a legal team comprising Abhishek Manu Singhvi, Kapil Sibal, Rakesh Dwivedi, Kalyan Banerjee and Prashant Bhushan, who would represent the state

"We will explore all legal avenues, including seeking clarification and modification of the judgment. We are ready with plans A, B, C, D, and E," the chief minister asserted and appealed

to the aggrieved teachers to trust her government. "Continue teaching and educating without worry. If you suffer for two months now, you won't have to suffer for the next 20 years," she

Banerjee said the West Bengal government has plans ready to prevent any break in service for those who are eligible. "I will stand by those who lost their jobs in an unjust manner. I don't care what others think. I will do everything to restore your dignity."

In a clear message to the opposition, Banerjee alleged that a "dirty game" was being played to destroy the state's education system.

"A dirty game is being played by some people. One should figure out the real faces behind the masks. Many are trying to mislead people with false information," she said.

Without naming the party, Banerjee lashed out at senior advocate and CPI(M) leader Bikash Ranjan Bhattacharya for initiating the legal proceedings that culminated in the Supreme Court

**NEW DELHI, April 7:** The BJP on Monday demanded gress-ruled state. that Congress leaders Rahul Gandhi and Privanka Gandhi Vadra seek Karnataka Home Minister G Parameshwara's resignation over his comment that incidents like molestation do happen at times in a big city like Bengaluru.

BJP national spokesperson Shehzad Poonawalla alleged that Parameshwara is a "serial offender", claiming that he had made similar remarks trivialising crimes against women during sexual assaults against them in the Karnataka capital in 2017.

The BJP leader told reporters that the Karnataka Congress leader has exhibited a brazen display of "most shocking, misogynist, patriarchal, sexist and obnoxious mindset" by trivialising an incident that has shocked the country, especially women of the state.

Parameshwara was responding to the incident where a woman was molested in a secluded place in Suddaguntepalya. "Police are working continuously round-theclock ignoring rain and cold. That is why there is peace in Bengaluru. In a big city like Bengaluru, here and there incidents like this do take place," the minister said.

Poonawalla noted that the city police has been unable to apprehend the criminals and accused the minister of standing with the culprits. He claimed that the crimes against women have seen a 50 per cent rise in the Con-

He said Parameshwara might have dismissed the insult heaped on Draupadi, the famous character from the epic Mahabharata, as a minor incident even though it ended up triggering the legendary war between Pandavas and Kauravas. Poonawalla asked if Priyanka Gandhi Vadra's "ladki hun lad sakti hun" campaign, which she had spear-

headed in the BJP-ruled Uttar Pradesh in the run-up to the 2022 assembly poll, is a mere "empty tokenism and slogan". He said, "Rahul Gandhi and Privanka Gandhi Vadra should break silence and seek resignation from G Parameshwara.' The BJP spokesperson cited several cases of crimes

against women, including the gang-rape of an Israeli tourist, to target the Congress government and added that several Congress leaders in the past have made similarly provocative statements related to women.

Poonawalla said several women functionaries of the Congress were sacked in the past for raising questions on the treatment of women by party leaders. "Insulting women is the identity of the Congress," he

alleged and cited Congress leader Adhir Ranjan Chowdhury's controversial "Rashtrapatni" barb for President

Chowdhury later apologised for his remark. (PTI)

fused the motion, moved by NC's Nazir Gurezi and Tanvir Sadiq, seeking adjournment of the question hour to discuss the Waqf law.

A notice for the motion was given to the speaker

# Badlapur accused death: HC says prima facie offence disclosed

MUMBAI, April 7: The Bombay High Court on Monday ordered an FIR against five policemen for the custodial death of Badlapur sexual assault case accused Akshay Shinde, who was allegedly shot in a police van, and setting up of an SIT, noting that a prima facie offence is disclosed.

A division bench rapped the Maharashtra government for its "reluctance" to lodge an FIR, stating that such action undermines the state's legitimacy and the common man's faith in the criminal justice

When a prima facie offence is disclosed, it is mandatory to lodge a case, the bench of Justices Revati Mohite Dere and Neela Gokhale noted.

The bench said it was satisfied that the encounter required a thorough investigation as it is undisputed that the deceased succumbed to bullet injuries inflicted by a police officer when he was in police

"We are of the opinion that a cognisable offence is disclosed, and as such, the police are dutybound to proceed in adherence with the law. Reasonableness and credibility of the information are not conditions precedent for registering an FIR," the bench said.

As a Constitutional court, the HC cannot remain "mute spectators" even though the parents of the deceased had said they do not want to pursue the case, the bench said.



The parents of Shinde had claimed that their son was killed in a fake encounter.

"When a prima facie offence is disclosed, it is mandatory for a case to be lodged. When a cognisable offence is disclosed, the police are duty-bound to proceed in adherence with the law. Reasonableness and credibility of the information is not a condition precedent for registration of an FIR," the bench said.

Shinde, accused of sexually assaulting two minor girls at a school in Badlapur in Thane district, was allegedly killed in a police shoot on September 23, 2024, when he was being taken to Kalyan from the Taloja prison for questioning in an-

The escorting police team had claimed they had shot at the accused in self-defence after he snatched the gun of one of them and opened fire.

A magistrate inquiry report, however, dismissed their argument and indicted five police personnel.

Slamming the government for its "reluctance" to lodge an FIR, the bench said such action undermines the state's legitimacy and the common man's faith in the criminal justice system.

The bench added that a Constitutional court cannot ignore the state's failure to fulfil its obligations and remain mute spectators.

The bench directed the joint commissioner of Mumbai Police's crime branch Lakhmi Gautam to

The court said it was confident that the SIT would unearth facts and conduct a fair and impartial investigation from all angles, uninfluenced by anyone.

After the order was pronounced, senior counsel Amit Desai, appearing for the government, sought a stay but the court refused.

The only condition for recording an FIR is that there must be information and that information must disclose a cognisable offence, both present in this case," the HC

The bench said a refusal to investigate a crime undermines the rule of law, erodes public faith in justice, and allows perpetrators to go unpunished.

"The state's reluctance to even register an FIR has left the deceased's parents helpless, forcing them to forgo closure over their son's untimely death. Such negligence weakens public trust in institutions and compromises the state's legitimacy. As a constitutional court, we cannot allow this and be mute spectators," it said.

The bench said police authorities are duty bound to adhere to the principles of law and SC judgements and ensure that the case, which prima facie discloses the commission of a cognisable offence, is taken to its logical end.

"Such action was warranted in the interest of justice and to uphold

public confidence in the justice delivery system. The same is necessitated, keeping in mind the adage 'Justice must not only be done, but seen to be done'," the HC said.

"We are unable to understand the reluctance of the State CID or the police authorities to register an FIR more particularly when the petitioner's (Akshay Shinde's father Anna Shinde) complaint and now the inquiry report prima facie discloses the commission of a cognisable offence," the HC said.

The bench said the criminal justice system will acquire credibility only when the citizens at large are convinced that justice is based on the foundation of truth.

"Crimes affect the entire society and thus the legitimate interest of the society in the investigation cannot be brushed aside.

"It is important to strengthen the faith and confidence of people in the law enforcing agency and this institution lest the faith of the people in the administration of justice stands shaken," the court said.

Denial of a fair probe or delay is as much injustice to the victim and the society as to the accused, it added.

Considering the facts in the magistrate's report, the court cannot allow the issue to be swept under the carpet, especially when the moot question about adhering to Constitutional norms and due legal process is at stake, the bench

#### Callousness in filing DCPCR vacancies can't be appreciated: Delhi HC

NEW DELHI, April 7: The Delhi High Court on Monday pointed out "callousness" on the part of the Delhi government in filling vacancies in the Delhi child rights commission and directed the selection process for such posts to be completed in a time-bound

Observing the Delhi Commission for Protection of Child Rights (DCPCR) was not functional since July 2023, a bench of Chief Justice D K Upadhyaya and Justice Tushar Rao Gedela said children rights had taken a backseat in the national capital.

The DCPCR was directed to fill vacancies within six weeks. The bench also expressed concern on the menace of substance abuse among children and directed the authorities to complete the selection of members for District Child Protection Units (DCPUs) within eight weeks.

"There is no gainsaying that the DCPCR performs certain important statutory functions to ensure protection of child rights. However, on account of vacancies, such functions are not being performed, as a result of which it is the rights of the children which take a back seat. Such a situation, resulted on account of callousness on part of the government, cannot be appreciated," the bench said.

After the Delhi government counsel sought time to conclude the process for vacancies in DCPCR, the court said the officials were already in contempt of its order, mandating conclusion of the process by the Department of Women and Child Development within three months.

The court said constituting DCPCR was the duty of the officials, entrusted to them by the legislature.

"Three months' time was given in October (last year). Six months (have lapsed). Not a single day is possible in terms of the earlier order. You are already in contempt," it said.

The bench questioned the counsel for not being able to complete a "simple" selection process since July 2023.

"These measures have been annulled by you. They have been made otiose. Have the officers ever visited New Delhi Railway station or Old Delhi Railway Station or ISBT or other such places? These measures are for the welfare of those children. Is the government not aware of the menace of substance abuse amongst children?" it further asked.

The Delhi government counsel informed the bench that following an advertisement issued in December last year, a screening committee was constituted for DCPCR vacancies on January 31, and a list of eligible candidates should soon be placed before the

For the district units, the counsel said, scrutiny was completed and interviews would be scheduled by April end.

"We thus direct that the selection process for the members of district child units shall be completed within eight weeks from today," the court ordered

Saying DCPCR was not functional in Delhi since July 2023, and especially that the time granted on October 25, 2024 to fill the vacancies ceased long ago, the bench gave a six-week timeline to fill

The Delhi government was further directed to file an affidavit to show compliance of the court order.

The court a week ago expressed concerns over vacancies in the Child Welfare Committees (CWCs) and Juvenile Justice Boards On Monday, it was informed that all posts had been filled.

"Not only did the Central government approve but the notification has also been issued by the government of the national capital territory of Delhi," additional solicitor general Chetan Sharma said. While 12 members were notified for JJBs, apart from three names in the reserve, eight chairpersons and 27 members were fi-

#### Decide compensation afresh under insurance policy: SC to NCDRC

NEW DELHI, April 7: The Supreme Court on Monday directed the National Consumer Disputes Redressal Commission (NCDRC) to consider afresh the quantum of compensation payable under an insurance policy to a company for its losses in 2005

A bench of Justices Sanjay Kumar and Augustine George Masih was hearing an appeal of the insurance firm against the NCDRC's August 2022 order.

The NCDRC held the insurance firm was liable to compensate an Agra-based company, which suffered losses due to the collapse of a factory shed, under its policy.

The apex court said the company had taken a comprehensive insurance policy from the insurance firm against fire and special perils, and the policy was operative from June 30, 2005 to June 29, 2006.

It came on record that heavy rainfall on August 1, 2005, led to the collapse of the factory shed and caused the damage to the plant, machinery, stocks and buildings.

The bench said the company raised an insurance claim for ₹ 91 lakh following which the insurance firm appointed a surveyor who assessed the losses at ₹ 8.89



arguing the loss suffered was not due to the insured peril of "inundation" and would, therefore, fall outside the policy's purview.

Aggrieved by the repudiation, the company approached the NCDRC, saying it engaged an independent surveyor who confirmed the damage was caused by inundation and assessed the loss at ₹ 46.97

The company argued in the NCDRC that its premises were renovated in 2003, and the insured shed/factory buildings were in a sound condition, obviating the possibility of a collapse due to weakening of walls or seepage.

to pay ₹ 46.97 lakh to the company.

In the top court, the insurance firm said it was not contesting its liability to pay compensation under the policy but the NCDRC did not properly deal with the issue of the quantum of compensation.

"Having noted that the surveyor appointed by the appellant (insurance firm) had assessed the damage at a much lesser figure, i.e., ₹ 8,89,176, the NCDRC could not have assumed that the appellant had mutely accepted the enhanced estimation of ₹46,97,085, as per the unilateral assessment made by the surveyor appointed by the respondent (company)," the bench

The apex court said the NCDRC did not independently apply its mind on deciding the quantum of the claim and "blindly acted" upon the alleged failure of the insurance firm to deny the assessment in surveyor's report produced by the company.

'This impression, as pointed out earlier, was unfounded and erroneous," the bench said. The top court remitted the matter to the NCDRC for a fresh consideration on the quantum of the compensation under the insurance policy for the losses suffered by the respondent. It asked the NCDRC to give priority to the matter and decide it ex-

#### Railways land-for-jobs 'scam': SC refuses to hear ED's plea against bail to Lalu aide

**NEW DELHI, April 7:** The Supreme Court on Monday refused to examine a plea of the ED against the bail granted to RJD chief Lalu Prasad Yadav's close aide and businessman Amit Katyal in a money laundering case linked to the alleged land-for-jobs scam in the Indian Railways. A bench of Justices M M Sundresh and Rajesh Bindal said it was not inclined to interfere with the Delhi High

other accused?" the bench said. Additional solicitor general S V Raju said the order of the high court was bad

in law and needed to be set aside. The high court on September 17 last year granted bail to Katyal while deprecating the "pick and choose" policy adopted by the Enforcement Directorate (ED). The high court noted despite no other accused being arrested in the case and given Katyal had joined the probe, he was unceremoniously held from the Indira Gandhi International Airport be-

fore he took off for Ranchi. The bail order said the agency did not explain the necessity of his arrest and while it reflected a "pick and choose policy", but also entitled Katyal to bail on the ground that his role was "much less" than the other accused.

Katyal, who was arrested by the ED on November 10, 2023 under various provisions of the Prevention of Money Laundering Act (PMLA), was granted bail by the high court on furnishing a personal bond of ₹ 10 lakh and two sureties of the like amount.

While he sought bail on parity, arguing the ED couldn't adopt a pick and choose policy, indicating discrimination, the ED argued Katyal actively assisted Yadav and his family members while handling the proceeds generated through alleged corrupt practices of the RJD supremo who was then the railway minister.

The high court said no other accused were arrested in the ED case, though they were the alleged to be the main perpetrators or beneficiaries of the offence under the PMLA, and chargesheeted.

Katyal, the court said, was not a flight risk as he joined the investigation and never evaded summons. The ED claimed that Katyal was the director of a company named A K Infos-

ystems Private Limited, which acquired and from candidates on behalf of Yadav. Some other members of the RJD supremo's family are also accused in the case. On May 22, a trial court dismissed Katyal's bail application, saying there were no sufficient grounds to grant him the relief, after which he approached the

high court. The case is related to Group D appointments made in the West Central Zone of the Indian Railways based in Jabalpur, Madhya Pradesh, during Yadav's tenure as the rail minister between 2004 and 2009 in return for land parcels gifted or transferred by the recruits in the name of the RJD supremo's family or associates, officials said. On the other hand, 42-year-old Mohammad Haseem said the compounded effects of heat and humidity reduce work and increase costs. "There's low income because people don't step out. We also end up spending money on buying water and lemon juice.'

The IMD's yellow alert also signals moderate health concerns, particularly for vulnerable groups such as the elderly, infants, and those with chronic conditions.

Thirty-four-year-old Jaspreet Singh, who has been running a food cart in the Red Fort area for 11 years, said, "We are habituated to this heat now, but we witness people fainting now and then due to the

Narendra Shah, a 70-year-old rickshaw puller, is among the vulnerable populations most affected during heatwaves.

"This time, the weather has become worse very early. I'm the sole breadwinner in the family, and earnings get affected during this time. However, I must mention that there is ample availability of free water across the city," Shah told PTI.

Medical professionals have also warned that the impact of such heat exposure is often underestimated.

Dr Vivek Nangia, a senior pulmonologist, said, "First, the stage is heat cramps, second is heat exhaustion wherein people could develop dizziness, nausea, vomiting, and stage three is heat stroke, where people land up in hospitals and ICUs. It's like a medical emergency. The overall impact is dehydration, loss of salt and minerals from the body.'

pre-existing heart, lung or kidney diseases, and, in severe cases, it may lead to confusion, organ failure or even death. Measures that can be taken to avoid heat

He added that extreme heat can worsen

include staying indoors during peak hours, wearing light-coloured clothing, keeping the head covered and consuming ample fluids.

The Sustainable Futures report also highlighted that many Heat Action Plans (HAPs) rely heavily on directives issued during emergencies by disaster management and health authorities. The long-term institutionalisation of HAPs is weak across cities. Measures such as creating shaded rest areas, rooftop solar panels for cooling and increasing urban green cover are not consistently implemented in the most ex-

posed communities. Delhi has expanded access to free drinking water in many public areas, but workers say other infrastructure, like shaded zones or cooling shelters, remains scarce. (PTI)

MUMBAI, April 7: Following the massive success of "Gadar 2", which reignited his popularity among fans, Hindi cinema star Sunny Deol says he is ready to embark on a new phase in his 42-year career with a few upcoming projects in the streaming

Deol, the action star of 1990s films "Ghatak", "Arjun", and "Damini", returned to the movies with a bang in 2023 with the sequel to his 2001 blockbuster "Gadar: Ek Prem Katha".

The 67-year-old actor, who is awaiting the release of his film "Jaat", said his OTT debut will allow people to watch his work on more than one medium.

"I'm doing a couple of projects for OTT, and they are not meant for the silver screen because the audience of that is

niche. So, it's best to go there (OTT). People keep watching your films on different plat-

"It is an interesting thing (medium) for actors and directors because it offers all kinds of variety, and you don't have to restrict yourself to something," Deol told PTI in

an interview here.

The actor said he wants to explore "newer kinds of roles".

"I'm already doing something (like that), I'm looking into it. But it all depends if a writer and director offer you something (different). If you try and look for it, then it becomes difficult," he added.

Deol credited OTT platforms for making his films relevant for the new generation of cinema goers.

"Those who didn't see our films in cinema (halls) but it

became relevant on digital platforms, and today's generation got to see it. I thank God and everybody for lov-

ing us so much."

Billed as a high-octane drama with larger-than-life action sequences, "Jaat" is different from his previous movies, he said.

The film, set to be released on April 10, is directed by south filmmaker Gopichand Malineni, known for "Don Seenu", "Bodyguard", "Balupu", and "Veera Simha Reddy".

"I enjoyed working on 'Jaat' because it was a refreshing thing to do. Whenever we do South films, they are mostly remakes. For me it's a new film. For the first time, I'm working with a South director, and it has been a great experience. We all learn so much from each

other," he said. For Deol, he always looks at the story before signing a

film, not action sequences.

"It's the story and the characters that drive the character to do what he does, and all of this makes the action look good. Most of the subjects that I've done or the characters I've portrayed are defending or fighting for something or are stuck in some situation wherein he (hero) stands up and fights. In real life, too, I believe you've to fight it out to be where you want to be," he

Besides "Jaat" and his upcoming OTT projects, Deol has a host of films lined up including, "Border 2", a sequel to his iconic 1997 film.

"I have emotions attached with every film because every film is a baby. You want to do your best every time. When you do part two ('Border 2'), you can justify things, and people get happy and satisfied, but there's always pressure as well. However, we will ensure that we don't overthink things," he added.

He is also collaborating with renowned filmmaker and his longtime friend Rajkumar Santoshi on period drama "Lahore 1947", and is reported to play a pivotal role in Nitesh Tiwari's twopart "Ramayana".

"Jaat" also features Randeep Hooda, Vineet Kumar Singh, Saiyami Kher and Regina Cassandra.

# Kunal Kamra asks BookMyShow to not delist him, share contact of audiences from his shows

**NEW DELHI, April 7:** Stand-up comedian Kunal Kamra on Monday wrote an open letter to BookMyShow requesting the online ticketing platform to either not delist him or to hand over the contact information of audience members he has earned through his solo shows over the years.

The letter, which he shared on his X page, comes days after Shiv Sena claimed BookMyShow had taken Kamra off the sale and artists list from its platform amid ongoing controversy around his 'traitor' jibe against Maharashtra Deputy Chief Minister Eknath Shinde.

"Dear BookMyShow, I understand that you need to maintain a cordial relationship with the state, and I know that Mumbai is a major hub for live entertainment. Without the state's cooperation, iconic shows like Coldplay and Guns N' Roses wouldn't be possible

"I request one of the following: Do not delist me, or provide me with the data (contact information) I've generated through your platform from my audience," Kamra said in his two-page letter.

On April 5, the Mumbai-born comedian -- who is now a perma-

nent resident of Tamil Nadu -- had asked BookMyShow whether the reports of him being delisted from the platform

"Hello @bookmyshow can you please confirm if I have your platform to list my shows if not it's fine. I understandů

(sic)" he wrote on X.

On Monday, the comedian also addressed his audiences calling for a boycott of the platform over the news of Kamra being delisted as an artist.

He said he was "not a fan of boycotts or down rating

a private business".

"BookMyShow is well within their right to do what's best for their business (sic). However, the issue at hand isn't about whether you can or will delist me-it's about your exclusive right on listing our shows. By not allowing artists to list their shows through their own websites, you've effectively prevented me from accessing the audience I've performed for from 2017 to 2025," he further stated in the letter

According to Kamra, BookMyShow takes a 10 per cent cut of revenue for listing shows. (PTI)

The actor, also known for web series "Tabbar" and TV show "Kaleerein", met with a casting director at Chhabra's office in Aram Nagar, a bustling area in suburban Mumbai renowned for its casting agencies and production houses. "The guy said 'It is a Vikramaditya Motwane show, do you want to skip this? Have you read the full script?' I said no. He insisted I give auditions, and I did. I was finalised and met Vikram sir. The only thing I asked him was, 'If you will capture every beat of my silence,' and he said, 'I will',"


Cheema is also set to star in

# LIFTING OF SALIVA BAN IN IPL BRINGS BOWLERS BACK INTO THE GAME: PBKS' LOCKIE FERGUSON

NEW DELHI, April 7: Punjab Kings pacer Lockie Ferguson has given a big thumbs up to the lifting of saliva ban in the IPL, saying it will bring the bowlers "back into the game" by helping them procure reverse swing, a crucial factor in death

As per the amended rules in the post-Covid era, bowlers can now use saliva to shine the ball which can help it reverse even in benign conditions.

The New Zealander has so far taken three wickets in the IPL with a best of 2/37 against Rajasthan Royals in Mullanpur.

"From a fast bowler's point of view, bowling at the death, any assistance we can get to get the ball moving legally and make permanent.

an impact with it is always greatly appreciated," Ferguson told PTI Videos.

'We have high-scoring games here, which is great... but I suppose if you can shut out overs at the death with the use of reverse swing, then that's helpful," he

The BCCI had lifted the ban on use of saliva on the ball in the IPL last month after a majority of the captains agreed to its proposal

The International Cricket Council (ICC) had banned the age-old practice of applying saliva to shine the ball as a precautionary measure during the COVID-19 pandemic. In 2022, the world body made the ban

The IPL too included the ICC ban in its playing conditions in the aftermath of the pandemic but its guidelines are outside the purview of the sport's governing body.

The IPL 2025 has witnessed several close matches, and fewer runaway totals, partly due to the slight re-balancing of the scale between the bat and the

"We have such dry wickets here in the IPL and sort of dry conditions... I think, it (use of saliva) brings the bowlers back into the game a little bit more, which is great. We want to see a contest between bat and ball. I think everyone wants that," he

Ferguson, who has not yet

NINGBO (CHINA), April 7: India's top shuttlers, including Lakshya Sen, HS Prannoy and two-time Olympic medallist PV Sindhu, will try to overcome their string of below-par performances this season when the openinground matches in the Badminton Asia Championships commence here on Tuesday.

Besides the two top-ranked Indian men's singles players in the world, Prannoy (17th) and Sen (18th), Kiran George (34th) and Priyanshu Rajawat (35th) will aim to put up a good show, while in women's singles, Sindhu, whose world ranking has dropped to 17th, will hope to recover her form in the continental event. The other Indians in the fray, the young Malvika Bansod (23rd), Anupama Upadhyaya (43rd) and Aakarshi Kashyap (48th), will be keen to make an impact in an extremely tough field. Sen, a bronze medallist at the 2021 World Championships, will open his campaign against Chinese Taipei's Lee Chia-Hao, a finalist at the All England Championships early this month, in the USD 500,000 tournament.

Prannoy, who hasn't been at his best since suffering a bout of Chikengunya, will face China's Guang Zu Lu in his first match. Priyanshu Rajawat has been drawn against Thailand's Kan-







taphon Wangcharoen, while Kiran George will face a qualifier.

In the women's singles, twotime Olympic medallist Sindhu will begin her campaign against world No. 34 Ester Nurumi Tri Wardoyo of Indonesia, while her compatriots face stiffer challenges.

Anupama will take on Thailand's former world champion Ratchanok Intanon, seeded eighth, while Malvika has been drawn against China's Fang Jie Gao. Aakarshi Kashyap faces second seed Yue Han of China.

**PARIS, April 7:** When Aston competition since 1983. Villa coach Unai Emery returns to Parc des Princes for the first leg of the Champions League quarterfinals against Paris Saint-Germain on Wednesday, it may stir up some difficult memories for him.

In contrast, Villa's on-loan forward Marcus Rashford will doubtless recall one of his happiest soccer experiences.

For Villa defender Lucas Digne and attacking midfielder Marco Asensio, the trip could be a case of mixed feelings.

A few months later, PSG spent 422 million euros (then \$456 million) during the offseason to buy Neymar from Barcelona and Mbappé in a stunning double swoop. But even they could not save Emery. He left at the end of the following season after two difficult years during which PSG went out twice in the last 16 of the Champions League, but he also made his mark as a coach willing to stand up to player power. "It was a difficult time," Emery said. "For the team to adapt to me and for me to adapt to the team.

Villa seems to have adapted very well to his methods. The Birmingham-based club is on a seven-game winning run heading into its first quarterfinal in the Emery, who has won the Eu-

ropa League a record four times as a coach, guided unheralded Villarreal to the Champions League semifinals in 2022.

It was a big fee for an unproven 20-year-old defender, but the quick and skillful Digne was impressive at times with his performances at left back.

However, he was unable to hold down a regular place and, after being loaned to Roma, he joined Barcelona in 2016.

His transition to the Premier League, first to Everton and then Villa four years ago, saw him become a consistent and respected Premier League defender.

The 31-year-old Digne recently reached 50 caps for France. Emery sensed an opportunity during the winter transfer window and got Asensio on loan from PSG until the end of the season. (AP)

Asked whether spin or pace is the bigger strength of the KKR bowling unit, Gibson offered a nuanced response.

"Bowling is the strength. We have no strengths. If we take wickets with a new ball, then we can be very dangerous in the middle-overs, of course, with Varun and Sunil (Narine)," he said. "And if we don't take wickets with a new ball, then we've still got those guys that we can utilise in the middleovers. We played Moeen Ali who bowled very well for us in Rajasthan and he didn't even get to bowl any overs in the last game. We've got some more

overs into Russell." Gibson acknowledged that while Russell could be expensive at times, his knack for picking up crucial wickets makes him a valuable asset.

"He might go for runs but he always takes a wicket for us. He's a partnership-breaker and we use him in that way as an impact sort of bowler. If you like to come on and take a wicket, then we can get him off and get one of our better

bowlers back on," he explained. Sunil Narine has been struggling for big runs at the pole position but Gibson played down any concern. (PTI)

NYON (SWITZERLAND), club finals goes into the overall April 7: Ticket prices at the men's Champions League final are unchanged from last year for most fans of the two competing teams with big increases only for high-end seats, UEFA said

Each finalist will get 18,000 tickets for the May 31 game at Bayern Munich's stadium with a special lowest-price rate of 70 euros (\$77). That's the same price as the lowest cost tickets at the 2024 final played at Wembley Stadium in London.

Substantial price hikes have been added to the two highestrated categories of seats. Topprice tickets go from 713 euros (\$781) last year to 950 euros (\$1,040) this time, and "category 2" tickets rise from 500 euros (\$548) last year to 650 euros (\$712), UEFA said.

# Pant says Nehra's advice helped him rebuild after life-threatening car crash

KOLKATA, April 7: The flamboyant Rishabh Pant on Monday acknowledged the influence and guidance of Ashish Nehra after he survived his horrific car accident, saying the former India seamer's advice to "stay happy" stood the keeper-batter in good stead during a difficult phase.

Pant met with the accident on the Delhi-Dehradun highway on the night of December 30, 2022. His car caught fire but he made a lucky escape even though his injuries were quite severe and needed multiple surgeries.

"I think one advice which really helped me was from Ashish Neĥra," Pant recalled in a freewheeling chat during CII Eastern Region's interactive session -'India@100: Leadership Insight from the Sports Economy' here.

"He is a senior from my club also. He just came to me, saw me, and he told me, 'I had lots of injuries. Just one thing if you can do is keep yourself happy. Do things that makes you feel happy. And keep following that'.

"I think that advice really stood with me and helped me to go through my injury," the 27-yearold Pant added.

After a year of intense recovery and rehab, he returned to professional cricket during the Indian Premier League last year and made his international return in the T20 World Cup in the Ameri-

For someone who preferred doing everything by himself, losing control over his own body was the most difficult thing to digest.

"I've been playing cricket day in and day out since I was a kid. And just seeing me so immobile in my life -- that was the hardest

"So even a small thing, brushing my own teeth, was harder for my life. I just couldn't do it for the first one month at least.'

It was at that moment Pant realised that he needed to surrender to the process.

"I have to accept that I can't move on from this in one day or two. That is where I calmed myself down and just realised that there is no point being negative and criticising yourself every day.

"For me, it might be eating food. For someone else, it might be talking to someone. So you have to find your own way.'

The accident changed his perspective on life. "Once your perspective to life

changes, the perspective to sports definitely changes. Because how you see life, eventually it will follow," he said.

Pant realised how people often take most things in life for granted.

"Simple things like waking up every day, brushing your own teeth, walking towards your washroom... small, small things but it plays a huge part. And as day to day life, we take it for granted. I think that is my learning from it.' For a professional cricketer,

success is often measured in runs, wickets and records but Pant's brush with the near-fatal accident reshaped his definition of it. "You want to be successful

each and every day. But a lot of time in sport it might not happen," "But that doesn't mean you are

going to beat around the bush and put you down always. You have to have a mindset where you push yourself. 'Yes, I can be better'."

After leaving Delhi Capitals, Pant was acquired by Lucknow of ₹ 27 crore in the mega auction last year, after which he was made the captain of his new franchise.

Pant, who is going through a lean patch in the ongoing IPL, has a simple philosophy to deal with tough times: back the process, trust instincts.

"We should be following a certain process and that is part of my day-to-day life," he said.
"When you keep it very simple,

like if you are watching a wicket, how it's going to play, what this batsman is going to do, what we can execute in a better way. "Like Mahi bhai (MS Dhoni)
