

## US top trading partner of India for 4th straight year in FY25

Trade gap with china widens to USD 99.2 bn

NEW DELHI, April 16: The US remained India's largest trading partner for the fourth consecutive year in 2024-25 with bilateral trade valued at USD 131.84 billion, while the country's trade deficit with China widened to USD 99.2 billion during the same period, government data showed.

In the last fiscal, India's exports to China contracted 14.5 per cent to USD 14.25 billion as against USD 16.66 billion in 2023-24. The imports, however, rose by 11.52 per cent in 2024-25 to USD 113.45 billion against USD 101.73 billion in 2023-24.

The trade deficit with China has widened by about 17 per cent to USD 99.2 billion in the last fiscal from USD 85.07 billion in 2023-24. China continued to be the second largest trading partner of India with USD 127.7 billion two-way commerce in 2024-25 as compared to USD 118.4 billion in 2023-24.

According to the commerce ministry data, China was India's top trading partner from 2013-14 till 2017-18 and also in 2020-21. Before China, the UAE was the country's largest trading partner. The US has been the largest partner since 2021-22.



Sarafa Association, the precious metal of 99.9 per cent purity had finished at ₹ 96,450 per 10 grams on Tuesday. Gold prices logged the highest single-day gain since April 11 when the spot rates skyrocketed by ₹ 6,250 per 10 grams -- the record steepest single day rise so far -- in the local markets.

So far this year, the yellow metal prices have risen by ₹ 18.710 or 23.56 per cent. Gold of 99.5 per cent purity also appreciated by ₹ 1,650 to hit a fresh peak of ₹ 97,650 per 10 grams against the previous close of ₹ 96,000 per 10 grams. Silver prices also climbed by ₹ 1,900 to ₹ 99,400 per kg. The white metal had closed at ₹ 97,500 per kg on Tuesday.

On the Multi Commodity Exchange, gold futures for June delivery surged by ₹ 1,984 or 2.12 per cent to touch a record high of ₹ 95,435 per 10 grams.

"Gold showed a solid rally once again...as MCX gold hit landmark levels of ₹ 95,000, while Comex gold surpassed USD 3,300, reflecting strong safe-haven demand," Jateen Trivedi, VP Research Analyst of Commodity and Currency, LKP Securities, said.

The rally was driven by geopolitical uncertainty and the absence of any constructive progress in tariff negotiations between the US



and China. Until there is a concrete update indicating de-escalation, gold is likely to remain elevated, Trivedi added. On the global front, spot gold

rose to touch a record high of USD 3,318 per ounce. Later, it pared some gains to trade at USD 3,299.99 per ounce. "Gold surged to a record high, driven by growing trade war concerns after the US government tightened export rules to China," Kaynat Chainwala, AVP-Commodity Research, Kotak Securities, said. President Donald Trump has announced an investigation into whether tariffs are needed on critical minerals, further fuelling market anxiety. On Wednesday, the US administration further raised tariffs on most goods from China to 245 per cent.

According to Abans Financial Services' Chief Executive Officer Chintan Mehta, gold prices hit record highs as the US dollar index slipped below the 100-mark, nearing three-year lows.

He said the upswing in gold is fuelled by rising expectations of a potential interest rate cut, with markets closely watching US Federal Reserve Chair Jerome Powell's speech to come later in the day. Experts said the Powell's commentary would provide more clues on the interest rate path, which will play a key role in influencing the US dollar price dynamics.

"As the Federal Reserve navigates the twin challenges of supporting economic growth while managing tariff-driven inflation, the current macro environment continues to offer strong support for gold. "Adding to the bullish momentum, major banks remain positive on gold's outlook, citing continued inflows into goldbacked ETFs and sustained central bank buying," Mehta said.

Spot silver in the Asian market hours rose nearly 2 per cent to USD 32.86 per ounce. Saumil Gandhi, Senior Analyst of Commodities at HDFC Securities, said the market participants are now looking for macroeconomic data, including US retail sales and industrial production for further insights on the US Federal Reserve's interest rate cycle. up for public good. But the facts suggest otherwise," Saikia said. "This is a case registered in 2013 during Congress rule. Their protests now seem like an attempt to obstruct and intimidate investigative agencies." Hitting out at the Congress for protesting the ED's actions, CM Sarma said, "Ordinary Congress workers are the real losers. They sit in crumbling offices while their leaders enjoy ₹2,000 crore. If anything, Congress workers should ask Sonia and Rahul Gandhi to return the money to the people."

"I feel pity for them," Sarma added. "Rahul Gandhi always says he fights corruption. Well, now both mother and son must prove their innocence in court. They are out on bail, they have been chargesheeted — the time has come for them to answer." Both Sarma and Saikia dismissed Congress's claim of political vendetta. "The BJP has never misused any investigative agency. The case is being pursued as per court orders," Saikia said, adding, "India will never support the loot committed by the Gandhi family." Mizoram delegation to

districts - Aizawl, Kolasib and Mamit - share a 164.6-km border with Assam's Cachar, Karimganj and Hailakandi districts. The decades-old border dispute mainly stemmed from two conflicting colonial-era demarcations - one from 1875 under the Bengal Eastern Frontier Regulation (BEFR) and another from 1933. Mizoram claims that 509 square miles of the Inner Line Reserved Forest (ILRF) delineated in 1875 under the BEFR as its legitimate area or boundary. In contrast, Assam asserts the border defined by a 1933 map prepared by the Survey of India in 1933 as its constitutional boundary. As a result, both states lay claim to overlapping areas, with no ground demarcation conducted till date, officials said. Since August 2021, both states have held four rounds of ministerial-level talks to resolve the decades-old border dispute. (PTI)

#### GMCH to become one

Inspecting the development of Guwahati's second medical college — Pragjyotishpur Medical College and Hospital — the chief minister said the hospital, which currently offers limited OPD services, is expected to be fully operational by August 15 this year. "With 600 beds and an intake capacity of 100 MBBS students, the new college will also offer postgraduate courses including obstetrics and orthopaedics. It will have 100 paying cabins to cater to the needs of a diverse patient base," Sarma noted.

He further revealed that plans are already underway for the construction of another 500-bed facility within the Pragjyotishpur Medical College campus in the future, further enhancing Guwahati's healthcare landscape. Chief Minister Sarma was accompanied by top officials including Siddharth Singh, Commissioner and Secretary, Medical Education and Research, and Chandan Sharma, Commissioner and Special Secretary, Public

Works Department, during the review visit. The developments signal the Assam government's focused push toward expanding quality healthcare and medical education infrastructure in the state, the official statement said.

2012. It has withstood scrutiny by both the Delhi High Court and the Supreme Court, which have allowed the case to proceed," Ete stated.

According to the official BJP statement, the ED began its investigation in 2021 and filed a chargesheet under the Prevention of Money Laundering Act (PMLA) on April 15, 2025. The case alleges a criminal conspiracy to misappropriate properties worth over ₹2,000 crore belonging to Associated Journals Ltd. (AJL), which were originally meant for media operations and public interest. Ete explained that these assets were transferred to Young Indian Pvt. Ltd., a company incorporated in 2010 by Sonia and Rahul Gandhi, who together hold a 76% stake. The transfer, according to the chargesheet, was made for a nominal sum of ₹50 lakh.

He further added that AJL had received loans from the Indian National Congress, which were later waived off without repayment after Young Indian took control of AJL. "This case is not politically motivated, as alleged by Congress. It is a judicially sanctioned inquiry into serious financial fraud and misuse of public assets," Ete reiterated. Dismissing the Congress' protests as "diversionary tactics aimed at evading accountability," Ete emphasised the BJP's trust in India's judicial and investigative institutions. "We have full faith in the independence and professionalism of our judiciary and law enforcement agencies," he said. The BJP Arunachal Pradesh, in the statement, reaffirmed its "unwavering commitment to transparency, accountability, and justice," and expressed full support for the rule of law and the constitutional framework.

### SC proposes to stay

of the provision-wise objections to the Act and expressed reservations on several aspects of the legislation, including the inclusion of non-Muslims in the central waqf council and state waqf boards. It also objected to empowering district collectors to adjudicate disputes related to waqf properties and the provisions allowing de-notification of properties declared as waqf by competent courts.

"Ordinarily, courts do not interfere at the admission stage when a law is passed. But this case may warrant an exception. If a property declared as waqf by user is denotified, it can have grave ramifications," the CJI said. The hearing saw sharp exchanges between the bench and the solicitor general when the judges questioned the logic behind permitting non-Muslims in waqf governance, while a similar reciprocity did not apply to Hindu religious endowments. "Are you suggesting that Muslims could now be part of Hindu endowment boards as well? Please state it openly," it told Mehta.

The law officer said not more than two non-Muslim members, apart from ex officio ones, would be included in the waqf council, and offered to state it in an affidavit. The bench, however, said under the new Act, only eight of the 22 members of the Central Waqf Council would be Muslims.

"If eight are Muslims, two may be judges' who might not be Muslims. That leaves a majority of non-Muslims. How is this consistent with the religious character of the institution?" the bench asked.

Γhe tensions briefly escalated when the law officer appeared to question the neutrality of the all-Hindu judicial bench. "When we sit here, we shed our personal identities. For us, all parties are equal before the law. That comparison is entirely misplaced," the bench said. "Why not allow non-Hindus in the advisory boards of Hindu temples, then?" it asked. The bench, which did not issue a formal notice as of now, said it would not consider staying the law at the present stage.

The apex court questioned Mehta on how "waqf by user" could be disallowed as many would not have requisite documents to get such waqfs registered. "Waqf by user" refers to a practice where a property is recognised as a religious or charitable endowment (waqf) based on its long-term, uninterrupted use for such purposes, even if there isn't a formal, written declaration of waqf by the owner.

The amended provision states, "Provided that the existing waqf by user properties registered on or before the commencement of the Waqf (Amendment) Act, 2025 as waqf by user will remain as waqf properties except that the property, wholly or in part, is in dispute or is a government property".

The bench during the hearing asked, "How will you register such waqfs by user? What documents will they have? It will lead to undoing something. Yes, there is some misuse. But there are genuine ones also. I have gone through privy council judgments also. Waqf by user is recognised. If you undo it then it will be a problem. Legislature cannot declare a judgment, order or decree as void. You can only take the basis."

Mehta submitted there was a large section of Muslims who did not want to be governed by the Waqf Act. The bench then asked Mehta, "Are you saying that from now on you will allow Muslims to be part of the Hindu endowment boards? Say it openly."

When a public trust was declared to be a waqf 100 or 200 years ago, it couldn't suddenly be taken over by the waqf board and declared otherwise, it added. "You cannot rewrite the past," the bench said. Mehta said a joint parliamentary committee had 38 sittings and examined 98.2 lakh memorandums before

Parliament's both houses passed the law. The CJI wanted the parties to address the court on whether a high court could hear the matter and asked for the crux of their prayers. (PTI)

Additionally, Sarma will hold a comprehensive meeting with all KAAC department heads to assess ongoing projects and formulate forward-looking development strategies. The Chief Minister's visit, coupled with the vibrant cultural congregation, marks a significant step toward fostering unity, development, and cultural pride among the Karbi people.

India is expected to grow by 6.5 per cent in 2025 on the back of continued robust public spending and ongoing monetary easing, even as the world economy is on a recessionary trajectory, driven by escalating trade tensions and persistent uncertainty, a UN report said.

The UN Trade and Development (UNCTAD) in its new report, Trade and Development Foresights 2025 - Under pressure: Uncertainty reshapes global economic prospects', said that global growth is projected to slow to 2.3 per cent in 2025, placing the world economy on a recessionary path.

The report released on Wednesday cites mounting threats, including trade policy shocks, financial



volatility and a surge in uncertainty that risk derailing the global out-

## Trump's 90-day pause?

onald Trump's 90-day tariff reprieve spells 90 days of geopolitical turbulence, US bullying and the threat of war. All three have been constant features of the period of US "unipolar" power, especially since the beginning of what even US presidents have termed the "forever wars." But Trump's aggression is global. That is not changed by the 90-day pause on tariffs (above a 10 per cent base line) on everyone except China, on whose products tariffs are now being hiked well above 100 per cent. Yes, it identifies China as his main target. Yes, it is an affronted response to the one big country which has met his threats with defiance. But the escalation against China and suspension — not removal — of threatened tariffs elsewhere are part of the same strategy. Trump is trying to browbeat the world into siding with the United States against China in a conflict the US, not China, has decided on. Successive US governments have slapped sanctions (which, not being UN-authorised, have no international legal standing) on Chinese products. But the universal tariff threat ratchets up the pressure. Align with our demands, the US says, or we have already identified the level of economic pain we are going to inflict on you. Those demands are intended to force all markets open to whatever the US wants. Economist Michael Roberts points to the catch-all list of supposedly unfair practices the US objects to, including "currency manipulation, 'opaque' licensing, 'discriminatory' product standards, 'burdensome' customs procedures, data localisation and so-called 'lawfare' of taxes and regulation.'

This is the extraterritorial imposition of US power writ large. Other countries may not decide their own policies on procurement, the quality or safety of goods, tariffs (!), protecting their citizens' data from US acquisition, or how to tax and regulate US companies operating on their territory. It is outrageous. The US has interfered in other countries' external affairs for decades. It has always been ready to inflict economic suffering to achieve political subordination — as the economic war on Venezuela and the crippling six-decade illegal blockade of Cuba show. But now, despairing of its ability to compete with its "peer competitor" China without brute force, it threatens these policies on everyone at once. Trump has already backed up economic with military threats. His bid for control of the Panama Canal, effectively forcing a Hong Kong-based company there to sell infrastructure to a US-based one, was accompanied by such threats.

Whether Trump's strategy can work is unclear. China is the biggest trading partner of a majority of countries: falling in with Trump carries heavy economic penalties as well. Many US manufacturing firms themselves depend on supply chains including China, and, as analyst Malcom Kyeyune observes, the US has shown none of the joined-up thinking China does in providing assistance to industries affected by foreign trade disruption. What is clear is that it will be painful and carries the threat of war—quite possibly world war, if the US deploys its military to cut Chinese supply lines or seize its assets.

Hezbollah should wake up to the new reality of military and economic weakness

The new President in his inaugural speech, clearly said that he wanted the state to have the monopoly of force. He wanted the state to be the one with the weapons. It should be remembered that Hezbollah was the only Lebanese armed group that refused to surrender its weapons following a 1975-

1990 civil war, arguing that its arms were necessary to fight against occupying Israeli troops in south Lebanon. The interna-

the UN Security Council, has demanded multiple times that Hezbollah should disarm. Instead, Hezbollah has continually ignored these demands. They ignored UN Resolution 1701, which called for a zone free of armed personnel besides the army of Lebanon. They ignored UN Resolution 1559 and the Lebanese Taif Agreement, which ended the Lebanese Civil War and called for the disbanding and disarmament of all Lebanese and non-Lebanese militias. Hezbollah in the

But now the time has changed, with the group weakened militarily and economically, critics see this as a unique opportunity to disarm it. More than a year of fighting with Israel has left the Iran-backed Shia group, once renowned as the world's strongest non-state actor, reeling. The group's near-total dominance of the Lebanese state for the past two decades has been weakened by the losses it has suffered in the past year of

past has clearly shown it has no inten-

Most of Hezbollah's senior leadership was killed in the fighting, along with

thousands of its fighters, and many of its weapon caches were destroyed. Hezbollah has also lost control of key assets such as the Beirut airport and smuggling routes along the Syrian bor-



der, both historically key for its cash flow. They no longer have a territorial

link between Lebanon, Syria, Iraq, and Iran, which was crucial for getting arms supplies

from Iran. This also hinders their logistics about obtaining weapons, which were stored in Syrian underground tunnels. Moreover, the main backer of Hezbollah, the Iranians, are themselves under immense pressure from the United States right now, and they are not in a position to provide any major assistance to Hezbollah.

As a condition of the ceasefire with Israel, which was agreed in November last year. Hezbollah has withdrawn its weaponry from its historical heartland south of the Litani River, about 18 miles from the Israeli border. The Lebanese army has been active in enforcing the terms of the ceasefire deal. It has been dismantling military assets belonging to the group in south Lebanon and conducting raids in the southern suburbs of Beirut, something unthinkable just six months earlier.

Hezbollah is assessing the ground realities, that's why the group is in "wait and see mode", as it recovers from the war and adjusts to a new political reality in Lebanon and the wider region. Many analysts believe that at present, Hezbol-

lah is internally split into two factions. One faction acknowledges the group's defeat by Israel and is willing to turn their weapons over and integrate into Lebanon as a political party. On the

other hand, another faction believes Hezbollah's sole legitimacy lies in fighting Israel, and that if they stop doing so, they have no right to exist as a movement. But this group, which has been running a state within a state for decades, must realise that it can no longer unilaterally drag Lebanon into foreign conflicts and blackmail the Lebanese state through its large arsenal. But any effort to disarm Hezbollah forcefully can prompt a new conflict in Lebanon.

To avoid this kind of

situation, the Lebanese top leadership must convince Hezbollah to give up arms and solely be a political force. Any negotiations about Hezbollah's disarmament are likely to be difficult and long. The central objective should be convincing Hezbollah that disarmament need not amount to the party's complete demise. One of the options that can be put forward for Hezbollah's consideration is that its arsenal, believed to still include long-range missiles, be put under the control of the state, while its fighters, estimated to be several thousand, could be integrated into the Lebanese army. Alternatively, a new defence strategy can also be negotiated under which Hezbollah fighters would join a paramilitary force within the Lebanese Army.

Hezbollah will remain an important player in Lebanese politics, but not a hegemon. The old order marked by Iranian influence and Shia ascendancy has crumbled. Lebanon now stands at a crossroads: the chance to reclaim sovereignty and pluralistic politics or the risk of another descent into fragmentation and chaos. Lebanon can sink further into chaos or use Hezbollah's defeat as a catalyst for change. Hezbollah's disarmament can also open doors for long-overdue political and economic reforms in Lebanon (IPA Service)

# Spain's ruling govt partner Leftwing Sumar facing serious credibility crisis

pain's left-wing Sumar held its second national conference on March 29–30, with its future already in doubt. In two recent polls, the junior partner in the country's coalition government had lost over half its support since the 2023 general election (down from 12.3 percent to around 6). Even more worryingly, Público calculates that this would mean Sumar keeping only one-third of its seats — making it hard to see how one of Europe's few broad-left governments could secure reelection.

The speed of Sumar's unravelling is staggering, with Deputy Prime Minister Yolanda Díaz's project to reorganize the radical left imploding after its initial solid election result in 2023. This collapse can partially be explained by internal contradictions. Sumar's capacity to operate as a broad-left unity platform, intended to bring together scattered forces, was undermined from the start by factional warfare between Díaz and Podemos, the previously hegemonic force on the Spanish left.

Much of the political capital Díaz accumulated as a pro-worker labour minister has been squandered over the last two years on a high-stakes standoff with Podemos's current leadership. In particular, her decision not to offer either Podemos' Ione Belarra or Irene Montero a ministerial role in the coalition government's second term gave their party the excuse it had been seeking to break with Sumar, just months after running under its banner in the 2023 election

After this demoralizing split and a series of heavy losses in regional and European elections, Sumar suffered a body blow last October when a sexual misconduct scandal erupted around its key strategist Íñigo Errejón. His resignation and acknowledgement of abusive behaviour toward female activists saw Sumar struggle to answer questions about what and when it had known about the allegations. As a subsequent allegation of rape emerged (which Errejón denies), the Spanish right went on the attack, decrying the Left's hypocritical moralizing around feminism. Podemos saw an opportunity to further undermine Díaz's standing.

Yet the Errejón case was also the first time since the general election that a news story involving Sumar had really captured national attention. As the junior partner in a ruling coalition now without a parliamentary majority, it has struggled to maintain relevance across over eighteen months of institutional deadlock. This is in sharp contrast to the radical left's experience in Prime Minister Pedro Sánchez's first coalition government from 2020 to 2023. Operating under the previous Unidas Podemos electoral alliance, it had forced targeted but substantial concessions from Sánchez's center-left Partido Socialista (PSOE) - ranging from measures tackling the cost-of-living crisis and a strengthening of labour laws to a raft of feminist legislation.

But now faced with a far worse balance of forces in parliament, the four new Sumar ministers Díaz brought into the cabinet have remained marginal figures, whose limited briefs have not provided them with the means to intervene in the political agenda over the last eighteen months. This is particularly devastating since Diaz's leadership profile is premised on delivering in office

— and her reputation for securing progressive policy gains. No longer able to point to its institutional influence, and lacking extra-parliamentary structures of its own or even a strong media presence, Sumar has faded into the background.

This, in turn, points to the narrow basis around which Díaz had sought to reorganize the Spanish left from mid-2022 onward. Drawing on the coalition government's experience managing the nandemic as well as her legislative achievements strengthening workers' rights, Sumar looked to broaden the Left's electoral appeal by presenting itself as a credible party of government - one capable of delivering concrete policy advances. In this respect, its profile chimed with the technocratic spirit of the early 2020s. This was a moment when Bidenomics and the European Union's COVID-19 rescue fund appeared to open up the possibility of a new progressive state interventionism and when — very briefly — far-right populism was on the retreat.

As Sumar was rolled out across a series of public events in late 2022 and early 2023, Díaz struck a note of pragmatic reformism. Pointing to the coalition's successful cap on energy prices and her reform cracking down on bogus self-employment in the gig economy, she insisted that through institutional negotiation and social partnership a new social contract for the twenty-first century could be achieved that would go beyond neoliberalism. Missing, however, was any role for grassroots organizing or a clear anti-elite discourse—with Díaz's more managerial profile and her platform's softer messaging striking a distinct note to Podemos's combative left populism.

Podemos founder Pablo Iglesias had in fact also failed to effectively combine his ministerial role with an oppositional discourse during his eighteen months in the cabinet, engaging in highly charged controversies around lawfare and media bias that alienated voters at the height of the pandemic. By contrast, Díaz became the highest-rated political leader in Spain after successfully overseeing the Spanish state's COVID-19 furlough scheme and pushing through repeated increases in the minimum wage. Quickly becoming a household name on the back of these measures, she was able to appeal to a substantive part of PSOE's vote despite being a member of the Spanish Communist Party and a Unidas Podemos minister. As Iglesias resigned and named Díaz deputy prime minister in 2021, many on the Spanish left believed her candidacy could see the parliamentary left expand its profile and weight in cabinet.

Reorganizing the Left to exploit this window of opportunity was core to Sumar's tactical hypothesis. Yet ultimately Díaz and her inner circle were not able to build on this initial promise, failing to expand out from her popularity as a pandemic-era minister to construct a sustainable electoral brand or organization. Like Podemos before it, Sumar was built as a lean, top-down platform, but one which unlike its predecessor did not have its origins in a movement wave beyond the institutions but rather was built from office. This has further reinforced the sense that it is defined more by its promise of "effective" progressive governance than by any clear social or political identity.

Initially, Sumar struck a labourist line, playing up Díaz's links to trade unionism, before pivoting to a pop-infused green discourse during the 2023 snap election and then slowly moving back to-

ward a certain social and labourist message in recent months, after Errejón's exit. But these discursive shifts occurred without it ever articulating a broader political project that went beyond its participation in government.

Even in the 2023 general election campaign, the first time Sumar's machine was put into action, the platform struggled to cut through, with its policy-focused campaign lacking a clear narrative and coming across as overly technical to many voters. Though Díaz had made her name delivering bread-and-butter labour and welfare reforms, her green-aligned campaign advisers changed tack and instead focused Sumar's campaign on innovative policies linked to free time, equality of opportunity, and mental health. In part, this was a means to distinguish Sumar from Sánchez's pitch for social democratic stability, but proposals such as its Thomas Piketty-inspired universal inheritance scheme (under which every eighteen-yearold in Spain would receive €20,000 to "kick-start a life project") failed to engage the Left's base with the young academics and professional consultants staffing the campaign unable to sell their

Díaz's strong performance in the final stretch of the campaign, particularly in the leaders' debate, was enough to repeat the result obtained by the Unidas Podemos alliance in 2019 but not to win over PSOE voters in the earlier-predicted numbers. Indeed, amid a global reactionary wave, Sánchez bucked the wider trend of incumbents being punished over the cost-of-living crisis, not least because of the Spanish government's more robust protection of working people's living standards — which pressure from the Left had been key in securing.

Relief at avoiding a hard-right Partido Popular—Vox government was soon tempered, however, by the weakness of the second coalition's numbers in parliament — with the administration now depending on the support of the center-right Catalan-nationalist Junts to have a majority to pass legislation. Over the last eighteen months, this pro-independence party has used its effective veto to stall most of the government's agenda, including blocking the coalition from passing any government budget since the election. At the same time, the limits of the first coalition's reform agenda have also become apparent, particularly in terms of its toothless housing law — with Spain's largest cities facing rent hikes of 10–14 percent in 2024.

Ultimately, without the Left's previous institutional momentum and Díaz's ability to win highprofile policy concessions in the cabinet, Sumar has not been able to maintain a distinct political profile from PSOE over the last eighteen months. Junts has refused to support Díaz's star policy proposal for a reduction in the working week from 40 to 37.5 hours while it has also voted down measures such as the renewal of the windfall tax on electricity companies' profits and a vital reform that would have allowed for rent controls on short-term leases.

Political analyst Mario Rios doubts whether such measures alone could ever have sustained Sumar given the political direction of travel in post-pandemic Europe. "In the current political landscape, governance is necessary, but it is not the main tool for attracting voters and winning elections," he explains in relation to Sumar's po-

sitioning. "Today's politics is based on the confrontation of models, values, and worldviews," he continues. "In contrast, Sumar is based on the idea that voters simply want solutions to the problems they face. Focusing solely on policies like the minimum wage or the reduction of the working week without framing them as part of a broader vision can only lead to electoral defeat."

Yet Sumar's failure to flesh out its project and its lack of results in the cabinet cannot alone explain the collapse in Diaz's popularity among the Left's own electorate. Over the last eighteen months, she has gone from being the preferred choice for prime minister of two-thirds of Sumar's 2023 voters to that of just 23 percent. There are now also considerably more Sumar voters from the last election who would prefer Pedro Sánchez to lead the government than her. Though her broader approval ratings are still much stronger than those of Iglesias when he stood down, only 40.9 percent of voters now give her a pass mark or higher, compared to 54.9 percent two years

In this respect, her declining numbers with her own base and the platform's disastrous European election results last year must also be seen in terms of Sumar's descent into a spiral of internal crises and scandals. The platform seemed to have hit rock bottom the night of the European elections last June as Díaz resigned as its leader after it had only won 4.6 percent of the vote and three seats. She later clarified she would stay on as deputy prime minister and remain the Left's figurehead in the government, but she would no longer lead the construction of a left-unity project At that point, however, her authority was already shot. The Communist-led Izquierda Unida, which had been Sumar's most vocal backer only a year earlier, was now denouncing its "hyper leadershin" structure and lack of internal democracy after it had been left without a seat in the European Parliament for the first time since its creation in 1986. "The time when Sumar set the agenda and other forces followed is over," Izquierda Unida coordinator Antonio Maíllo insisted. Then Errejón's resignation deprived the platform of its only other figure with national name recognition and opened up a firestorm of recriminations on

More broadly, however, the speed with which Sumar imploded has to be seen in terms of two factors relating to its internal development. First, it was constructed in opposition to Podemos. Second, reorganizing the Spanish left around such a personality-centered platform left it dependent on Díaz's continued popularity, with Sumar, like Podemos before it, skipping the hard work of onthe-ground organizing during its initial surge, when it still had momentum

when it still had momentum.

In reality, this is a familiar story on the Spanish left. A series of internally diverse left-wing projects have experienced initial electoral surges over the last decade — from Podemos at a national level and municipalist platforms like Ahora Madrid and Zaragoza en Común to Díaz's previous En Marea vehicle in Galicia. But operating in an organizational void, most have very quickly come undone under external pressures and internal tensions. Any sustainable future project for Spain's left will need to transcend this "electoral war machine" model. It seems unlikely that Díaz will be leading it. (IPA Service)



# The challenge is increasing temperature and changing atmospheric patterns



n important factor controlling the Earth's climate is the amount of sea ice floating in the polar regions. However, due to changing atmospheric patterns and rising temperatures, this has declined to a record low of 15-76 million square kilometres. Global temperatures are rising, ocean currents are becoming turbulent, and extreme weather events are becoming worse as a result of this decline. Extreme weather events around the world are being affected by changes in the Earth's climate. The frequency and intensity of devastating wildfires, yearslong droughts, heavy rainfall, severe flooding, record-breaking heat waves on land and at sea, and widespread flooding during storms are all increasing. Since the Industrial Revolution, human activities, particularly the burning of fossil fuels, have caused a rapid increase in the atmospheric concentration of greenhouse gases. Methane, carbon dioxide, and other gases act like a blanket, trapping heat and warming the Earth as their concentrations increase. As a result, the air and oceans on Earth become warmer. Ice on land melts, weather patterns change, and the water cycle is affected by this temperature rise, making extreme weather conditions worse. Climate change affects our society in many ways.

Droughts can affect human health and food production. Floods can damage infrastructure and ecosystems and spread disease. In addition to changing food availability and limiting worker productivity, human health problems caused by droughts, floods and other weather events also increase mortality. The physical infrastructure of our transportation and communication systems includes roads, bridges, ports, electric grids, broadband internet and other components. It is often designed to last



in most communities was built without considering climate change. Current infrastructure may not be able to handle severe weather conditions such as wind, snow, flooding, heavy rain or temperature fluctuations. The impacts of these events can take many different forms. For example, higher temperatures cause indoor cooling needs, which can put pressure on the energy grid. Flooding caused by unexpectedly excessive rainfall that exceeds stormwater drainage capacity can close major routes, businesses and highways.

Coastal infrastructure, such as water supplies, roads, bridges and more, are at risk due to sea level rise. Since much of the population lives in coastal areas, millions of people will be affected by the risks. In addition, sea level rise can lead to coastal erosion and flooding due to high tides. Research suggests that some communities will reach or be at sea level by the year 2100. Now it will be up to for many years. Therefore, the infrastructure them to decide what to do. During a process

called managed retreat, communities will likely move away from the shoreline and make changes to their infrastructure. Ocean heat transport is primarily responsible for the global decline in sea ice. When warm ocean currents enter the polar regions, sea ice melts faster at the base. Warmer water is brought into the Arctic by the Atlantic Meridional Overturning Circulation (AMOC), which reduces the stability of the ice. These climate patterns affect oceanic and atmospheric conditions as well as the rate of ice formation and melting. The 2015-2016 El Niño event increased ocean temperatures and reduced Antarctica's sea ice to record lows. Large volcanic eruptions release aerosols, which have the potential to temporarily cool the atmosphere, but they can also be a contributing factor to warming oceans in the long term.

The 2022 Hunga Tonga eruption released water vapor into the stratosphere, potentially

More powerful storms cause fragile sea ice to break up, making it more likely to melt and be affected by ocean currents. Storms in the Barents and Bering Seas will cause ice to break up in 2024, resulting in record lows of Arctic sea ice cover. Methane and carbon dioxide trap heat in the atmosphere, raising global temperatures and accelerating polar ice melt. Arctic sea ice has been declining at a rate of 12–2% per decade since 1981, due to the dramatic increase in carbon dioxide levels caused by the Industrial Revolution.

Ocean acidification and atmospheric temperature rise are caused by pollutants released from the burning of coal, oil, and gas. Arctic amplification is the process whereby the Arctic warms up to four times faster than the global average due to heat-absorbing emissions from industrial activities. When forests are destroyed, less carbon is absorbed and when cities grow, more heat is retained, which affects atmospheric circulation. Sea ice degradation and global warming are indirectly caused by deforestation in the Amazon, which reduces carbon absorption. Drilling and increasing marine activities in the Arctic region disrupt the sea ice ecosystem and generate pollution and heat, which contribute to local temperature rise. The rapid migratory activity in the Arctic region following the discovery of natural resources in the region has further reinforced this mechanism, resulting in greater loss of polar ice.

As sea ice on Earth decreases, oceans absorb more heat, which reduces albedo, or reflectivity, and warms even more. Climate change is accelerated by the Arctic's declining albedo effect, causing polar regions to warm twice as fast as the rest of the world. Freshwater released from melting ice reduces salinity and slows deep-ocean circulation, which has an impact on climate regulation. A weakening Atlantic Meridional Overturning Circulation (AMOC) is likely to alter weather patterns in the Indian Ocean region, Europe, and North America. Indirectly, melting sea ice speeds up the melting of land-based ice sheets, raising sea levels worldwide. When all the ice melts, the Greenland ice sheet will raise sea levels by about 23 feet. Temperature changes are increasing storms, droughts, and heat waves, affecting atmospheric circulation. The jet stream is affected by melting Arctic ice, leading to longer heat waves across North America and Europe. Melting sea ice disrupts food chains, endangering fisheries and marine life that depend on cold-water habitats. Entire ecosystems are affected, as krill populations in Antarctica decline and polar bears and seals lose their hunting grounds. Climate action must be decisive to prevent

dangerous declines in global sea ice. Ice loss can be reduced by strengthening global climate pledges such as the Polar Code, promoting the clean energy transition, and funding geoengineering initiatives. Adaptive policies and improved polar monitoring will increase climate resilience. A sustainable future depends on everyone's determination to reduce emissions and protect the planet's fragile cryosphere. Many communities lack preparation to deal with the threats of climate change. Scientists are researching how communities are affected by climate change now and in the future, and can suggest best practices. Investing in resilient infrastructure that can withstand future climate risks is important for communities. All members of our society, including teachers, risk communicators, emergency managers, and city planners, should receive environmental education about this. Through environmental education, anyone can learn how to prepare for climate change.

## Thar desert is greening, thanks to higher rainfall, excessive groundwater pumping

The Thar Desert in India saw a striking 38 per cent rise in greening annually over the last two decades, driven by a significant increase in monsoon rainfall and agricultural expansion, a new study showed. It has shed light on how the landscape of the Great Indian Desert has changed, impacted by both climate change and anthropogenic pressures.

Groundwater resources have also contributed significantly to vegetation growth, the report Greening of the Thar Desert driven by climate change and human interventions highlighted. At the annual scale, groundwater accounted for 55 per cent contribution and precipitation for 45 per cent, it indicated. In fact, Thar was the only desert in the world with the highest concurrent increase in population, precipitation and vegetation during the last few decades, scientists from IIT Gandhinagar and Bay Area Environmental Research Institute, NASA Research Park in the US established.

Thar region, which hosts the world's highest population density for a desert, spans 200,000 square kilometres across northwestern India (Rajasthan, Gujarat, Punjab and Haryana) and southeastern Pakistan. The scientists analysed all the 14 major deserts across the globe during 2000-2020 and found that the region experienced the highest population growth

#### Abnormal increase in rainfall

Defying the trend of expansion of arid areas, the desert experienced a 64 per cent rise in precipitation between 2001 and 2023 - increasing at a rate of 4.4 millimetres year after 2000, the report showed. The annual rainfall increased across the Thar region, particularly in the northwest and primarily during the summer monsoon.

The analysis was based on data from Climate Hazards Group InfraRed Precipitation with Station (CHIRPS), which combines insitu and satellite-based precipitation observations. Among the 14 major deserts, only four (Thar, Arabian, Negev and Eastern Gobi) showed a significant increase in precipitation and one (Namib) experienced a

substantial decline in precipitation during 2001–2023, the study found. The remaining nine major deserts did not experience a significant change in mean annual precipitation. The researchers termed the increased precipitation as "opposing effects of climate change". These changes contributed significantly in vegetation growth in the deserts - all four major deserts with a significant increase in precipitation also experienced a significant increase in vegetation during

2001–2023, according to the study. **Greening of desert** 

Thar's extensive greening was driven by large-scale monsoon changes coupled with groundwater pumping for irrigation purposes, government interventions in building irrigation infrastructure and power supply.

"For instance, climate change can limit water availability, while human interventions associated with irrigation and groundwater pumping can sustain crops in water-limiting environments," the authors wrote.

During the summer monsoon season, precipitation accounted for 66 per cent of the greening, while groundwater contributed 34 per cent. However, in the non-monsoon season, groundwater was the major driver of vegetation growth (67 per cent). Annually, the contributions were more balanced, with groundwater accounting for 55 per cent and precipitation for 45 per cent. The team of researchers — Vimal Mishra, Hiren Solanki and Ramakrishna Nemani — examined the spatial changes in annual vegetation greening calculated from the moderate resolution imaging spectroradiometer (MODIS) and precipitation from the CHIRPS dataset during 2001–2023.

Comparing the seasonal cycle of mean monthly greening for the 2001-2010 and 2011–2020 periods, the team found that the region experienced a substantial increase in vegetation greenness during the summer monsoon (June-September) and non-monsoon (October-May) seasons.

Large-scale agri expansion drives groundwater depletion

The region experienced a significant agricultural expansion, with crop area increas-

ing by a major 74 per cent and irrigated area by 24 per cent during 1980–2015. Similarly, there was a significant expansion in the gross (95 per cent) and net (58 per cent) irrigated areas during the same period.

The summer monsoon season overlaps with the Kharif season, the major cropgrowing period for the region. "While Kharif season crops meet a large fraction of the total water requirement from the summer monsoon rainfall, crop growth during the Rabi season largely depends on irrigation from surface water and groundwater resources," the authors wrote.

The scientists used in-situ observations of well levels from the Central Ground Water Board (CGWB) and satellite observations from Gravity Recovery and Climate Experiment (GRACE) for the 2002–2021 period to examine the potential impacts of groundwater pumping on its storage variability in the Thar region. As agriculture activities expanded, the intensive use of groundwater has caused groundwater depletion in the Thar, reflecting an imbalance between water extraction and recharge rates.

Most groundwater wells showed a decline in water levels, especially in the northcentral region, where vegetation greening had increased significantly during the monsoon and winter seasons.

#### Rapid urbanisation

Several regions within Thar showed a 50 per cent to even 800 per cent rise in urban areas during 1985–2020, the report showed.

The Thar region's population growth during 2000-2020, was followed by the Arabian Desert, while most other deserts did not experience a considerable increase in population, the study showed. "This population growth in the Thar region is evident from the expansion of urban areas and cropland, likely driven by cultivation potential and relatively lower land prices. Water availability also played a crucial role in urban settlement and agricultural expansion.

For instance, the Indira Gandhi Canal surface water sourced from north India and enhanced water availability in the northwest parts of the Thar Deser," it said. (Courtesy: Down to Earth)

Issues like hunger, malnutrition, agrarian distress, and farmer suicides threaten social stability. To address these challenges, enhancing food production at the household level is crucial. This requires innovative, farmerfriendly, and cost-effective technologies. One such promising solution is the System of Rice Intensification (SRI).

System of Rice Intensification (SRI): A Game Changer SRI is a low-cost, eco-friendly, and pro-poor innovation for rice cultivation that can also be applied to other crops like wheat, maize, sugarcane, and vegetables. The system is based on five simple yet transformative principles:

1. Transplanting young, single seedlings – Using 10–12day-old seedlings instead of the conventional 30+ days.

2. Wide, square spacing – Plants are arranged in 25x25 cm grids, preventing overcrowding. 3. Alternate wetting and drying (AWD) – Fields are irri-

gated intermittently rather than kept continuously flooded. 4. Regular weeding with cono-weeders – Weeds are incorporated into the soil to enhance fertility.

## **US, China seek to draw other countries** into their respective orbits: Singapore PM

pore Prime Minister Lawrence Wong on Wednesday said the US and China claim they do not wish to force countries to choose sides but seek to draw other countries into their respective orbits, local media reported

"America and China are now locked in a fierce contest for global supremacy. Neither country wants an open conflict, but there is a deep mistrust and suspicion on both sides," Wong said, in an apparent reference to the tariff war between the two countries.

"Both powers claim they do not wish to force countries to choose sides, but, in reality, each seeks to draw the other closer into their respective orbits. This rivalry is already reshaping the world and will continue to define the geo-political landscape for years to come," Wong said.

"We are in the midst of a messy transition globally. To what? Nobody can tell." Wong told an audience of about 900 at the annual S. Rajaratnam Lecture.

#### **Berlin doctor** charged with killings of 15 patients under palliative care



BERLIN, April 16: A doctor in Berlin has been charged with murder over the deaths of 15 patients under palliative care, prosecutors said on Wednesday. He is also accused of trying to cover up the evidence by starting fires in their homes.

The doctor was part of a nursing service's end-of-life care team and was initially suspected in the deaths of just four patients. That number has crept higher since last summer, and investigators now say they've found evidence linking him to the deaths of 15 people between September 22, 2021, and July 24 last year.

The victims' ages ranged from 25 to 94. Most died in their own

He allegedly administered an anesthetic and a muscle relaxer to the patients without their knowledge or consent. The drug cocktail then allegedly paralysed the respiratory muscles. Respiratory arrest and death followed within minutes, prosecutors said

The doctor — a 40-year-old man whose name hasn't been released, in line with German privacy rules — has been in custody since August 6. Prosecutors said Wednesday that he has not yet responded to the case against him.

The charges were filed to the Berlin state court, which will now have to decide whether to bring the case to trial and if so, when.

Murder charges carry a maximum sentence of life in prison. Prosecutors said they aim to ask the court to establish that the suspect bears particularly severe guilt, meaning that he wouldn't be eligible for release after 15 years as is usually the case in Germany. They also want him to be banned from his profession for life. (AP)

ISLAMABAD. 16: April Terming China as Pakistan's "most sincere friend", Prime Minister Shehbaz Sharif on Wednesday said that the recent agreement with the IMF would not have been possible without Beijing's support.

He was addressing a ceremony here for agriculture graduates selected for training in China. Under the programme, 1,000 Pakistani agriculture graduates will receive training in China in modern farming techniques, digital crop management and climate-resilient

The first group of 300 graduates is set to depart soon for a threemonth programme, followed by two additional batches in phased training over the next year.

Prime Minister Sharif acknowledged China's continued economic partnership, particularly noting the one-year extension of a USD 2 billion loan repayment last month, which provided much-needed relief for Pakistan's foreign exchange reserves.

The support by China, Saudi Arabia and the UAE helped to get a USD 7 billion bailout package from the International Monetary Fund (IMF) in September 2024 to avert a balance of payments crisis and the prime minister highlighted the role of China during the cere-

gling economy," he said, adding that the recent loan extended by the IMF was not possible "without support of China".

Recalling his last visit to China, Sharif said that he was much inspired by the research work in various fields of the agriculture sector during his visit to Chinese univer-

## Trump admin sues Maine over participation of transgender athletes in girls sports

WASHINGTON, April 16: The Trump administration said Wednesday it is suing Maine's education department for not complying with the government's push to ban transgender athletes in girls sports, escalating a dispute over whether the state is abiding by a federal law that bars discrimination in education based

The lawsuit follows weeks of feuding between the Republican administration and Democratic Gov Janet Mills that has led to threats to cut off crucial federal funding and a clash at the White House when she told the president: "We'll see you in court."

"We are going to continue to fight for women," Attorney General Pam Bondi said at a news conference alongside former University of Kentucky swimmer Riley Gaines, who has emerged as a public face of the opposition to transgender athletes.

Trump's departments of Education and Health and Human Services have said the Maine agency is violating the federal Title IX antidiscrimination law by

allowing transgenders to participate on girls teams. The lawsuit reflects a stark philosophical turnabout from the position on gender identity issues taken dur-

ing Democratic administrations.

Under President Joe Biden, the government tried to extend civil rights policies to protect transgender people. In 2016, the Justice Department, then led by Attorney General Loretta Lynch, sued North Carolina over a law that required transgender people to use public restrooms and showers that corresponded the gender on their birth certificate.

Maine officials have refused to agree with a settlement that would have banned transgender students from sports, arguing that the law does not prevent schools from letting transgender athletes participate.

Trump signed an executive order in February, "Keeping Men Out of Women's Sports," that gave federal agencies wide latitude to ensure entities that receive federal funding abide by Title IX in alignment

with his administration's interpretation of "sex" as the gender someone was assigned at birth.

Trump was joined at the signing of that order by Gaines and other female athletes who were in support of a ban. Gaines tied with a transgender athlete for fifth place in a 2022 NCAA championship and has testified before lawmakers across the country on the issue. She and others frame the issue as women's

During a February meeting with governors, Trump threatened to pull federal funding from Maine if the state did not comply with his executive order. Mills responded: "We'll see you in court."

Maine sued the administration this month after the Department of Agriculture said it was pausing some money for the state's educational programmes because of what the administration contended was Maine's failure to comply with the Title IX law.

A federal judge on Friday ordered the administration to unfreeze funds intended for a Maine child nutrition programme.

Sarah Foster, Maine's assistant attorney general, said last week in a letter to the Education Department that nothing in the law "prohibits schools from allowing transgender girls and women to participate on girls' and women's sports teams.

Ouestions over the rights of transgender people have become a major political issue in the past five years. Twenty-six US states have laws or policies barring transgender girls from girls school sports. GOPcontrolled states have also been banning gender-affirming health care for transgender minors and restricting bathroom use in schools and sometimes other public buildings.

In his 2024 race, Trump campaigned against the participation of transgender athletes in sports. As president, he has signed executive orders to do that and to use a rigid definition of the sexes, rather than gender, for federal government purposes. (AP)

JERUSALEM, April 16: Israel's defence minister said Wednesday that troops will remain in so-called security zones in the Gaza Strip, Lebanon and Syria indefinitely, remarks that could further complicate talks with Hamas over a ceasefire and hostage release.

Israeli strikes across Gaza meanwhile killed another 22 people, according to local health officials, including a girl who was not yet a year old. The girl's mother, who was wounded in the strike, embraced her daughter, still wearing a bloodied blue and white dress, before she was taken for burial.

Israeli forces have taken over more than half of Gaza in a renewed campaign to pressure Hamas to release hostages after Israel ended their ceasefire last month. Israel has also refused to withdraw from some areas in Lebanon following a ceasefire with the Hezbollah militant group last year, and it seized a buffer zone in southern Syria after rebels overthrew President Bashar Assad in December.

"Unlike in the past, the (Israeli military) is not evacuating areas that have been cleared and seized," Defence Minister Israel Katz said in a statement. The military "will remain in the security zones as a buffer between the enemy and (Israeli) communities in any temporary or permanent situation in Gaza — as in Lebanon and Syria."

The Palestinians and both neighbouring countries view the presence of Israeli troops as military occupation in violation of international law. Hamas has said it will not release dozens of remaining hostages without a complete Israeli withdrawal from Gaza and a lasting ceasefire.

# 'pandemic treaty' to try to avoid COVID-19 mistakes

LONDON, April 16: Five years after COVID-19 triggered national lockdowns, economic uncertainty and killed millions, the World Health Organisation's member countries agreed on a draft "pandemic treaty" that sets guidelines for how the international community might confront the next global health crisis.

After the world's largely disastrous response to the coronavirus. countries tasked the WHO with overseeing a pandemic treaty in 2021; negotiations concluded early Wednesday on an agreement expected to be adopted next month at the UN health agency's annual meeting in Geneva.

WHO Director-General Tedros Adhanom Ghebreyesus heralded it as a historic moment, saying countries have proven that "in our divided world, nations can still work together to find common ground and a shared response".

Following US President Donald Trump's decision to withdraw the country from the WHO in January. American officials were barred from participating in the talks and

Rachael Crockett, of the advocacy group Drugs for Neglected Diseases Initiative, described the

draft pandemic treaty as "a product of compromise" She said it contained strong pro-

visions, but only if countries chose to implement them. "This could change what we saw in COVID, when some populations didn't get access to what they needed."

The draft treaty notably includes a provision to guarantee that countries that share critical virus samples receive any resulting tests, medicines and vaccines, with the WHO to hold up to 20 per cent of such products to ensure poorer countries get supplies.

Negotiations on this provision are expected to continue after the treaty is likely accepted by member countries in May.

Crockett acknowledged that as is often the case with international law, there are few consequences for countries that don't comply: "There's not much that can be done if countries choose not to ratify or abide by it."

Yuanqiong Hu, of aid organization Doctors Without Borders, said that if disputes arise between countries, the treaty includes a mechanism for them to use diplomatic channels, followed by arbitration.

Countries are already legally bound by the International Health Regulations to do things like quickly report dangerous new outbreaks. But those have been flouted repeatedly, including by African countries during Ebola and other outbreaks, China in the early stages of COVID-19 and arguably the US amid its ongoing bird flu epidemic. ## Forcible restriction on visiting sacred Thangjing violation of freedom of religion: Manipur MP

IMPHAL, April 16: BJP's Rajya Sabha MP Leishemba Sanajaoba on Wednesday said restrictions imposed by some groups on visiting Thangjing, a sacred site for Meiteis, is a violation of freedom of religion guaranteed Constitution.

He said it would be hard for Meiteis to tolerate such restrictions for long as Thangjing has religious and cultural significance for the community.

Speaking to reporters on the sidelines of an event, the MP, who is also a member of the former royal family of Manipur said, "Peace process between the two sides has already been initiated by the Centre. At such a time when there is an understanding to restore peace, such fresh developments (restriction on visiting Thangjing) are unfortunate.

"The Centre can and should take relevant steps. If armed miscreants and some obstinate organisations are allowed to do whatever they want, it would be difficult to achieve peace and it would disturb normalcy," he said.

He said that the recent objection to visiting the sacred Thangjing is a challenge to the freedom of religion guaranteed by the Constitution. "Since time immemorial, Meiteis have been ascending to Thangjing for pilgrimage. It has religious and cultural significance for the community. No civilised group would object to others visiting their sacred place," he said.

"While Meiteis are bearing such humiliation, this cannot be tolerated for long," he added.

Meitei elders are also against the pilgrimage now and they want the community members to carry on with the journey later when the situation improves.

They said that the route to the sacred site at the top of Thangjing hills passes through thick forests and isolated areas and going through such areas in the prevailing situation can be dangerous for Meiteis. Meitei community members take the annual pilgrimage in the month of April in accordance with the traditional Manipuri calendar system.

Thangjing Hill is considered a sacred site by the Meitei community, who traditionally visit it throughout the Manipur month of 'Sajibu' which generally falls in April. However, full moon day and days following it are considered the most auspicious ones. On April 13, the full moon day,

many Meitei pilgrims from various parts of the Imphal Valley offered prayers in Bishnupur and camped overnight in Moirang and surrounding areas, preparing for the pilgrimage in the days ahead.

Hundreds of Kuki-Zo community members, however, gathered at the Thangjing Hill and staged demonstrations on April 13, officials said.

The Kukis said that attempts to cross the buffer zone shall be considered a direct challenge to the Kuki-Zo community and if any untoward incident occurs during such attempts, those who undertake them would be responsible for it.

Coming off a three-month long injury layoff, Bumrah is yet to find the accuracy which makes him a tough customer to deal

After a rather tidy outing against Royal Challengers Bengaluru, Bumrah struggled to nail his yorkers and was taken apart by Delhi Capitals' Karun Nair as he leaked 44 runs in that game.

The 31-year-old will face stern test against a Sunrisers' fearsome line-up comprising Travis Head, Abhishek Sharma, Ishan Kishan and Heinrich Klaasen.

But the five-time champions will also want former captain Rohit Sharma to get back to his run-making ways at the earliest as his current tally is an underwhelming 56 runs from five matches at an average of 11.20. ## South California's Pomona city to host cricket during \_A 2028 Olympics

DUBAI, April 16: The South Californian city of Pomona will host the cricket competition during the 2028 Los Angeles Olympics, the ICC has announced.

Cricket, which is returning to the Olympics after 128 years, will feature six teams each in the men's and women's competitions and will be held at the Fairgrounds in Pomona. The city is located 48km from Los Angeles, which is the main venue of the Games.

Fairgrounds or Fairplex, as it is more popularly known, is a facility that is used for conventions, and commercial, educational and sports (primarily motorsports) events through the year. There is no designated cricket ground at

the venue. "We welcome the announcement of the venue for cricket at Los Angeles 2028 as it is a significant step towards the preparation for our sport's return to the Olympics," ICC chairman Jav

night. "Although cricket is a hugely popular sport, it will be a fantastic opportunity to expand traditional boundaries when it features in the Olympics in the fastpaced, exciting T20 format that

should appeal to new audiences." Cricket, which made its only appearance in the Olympics at the Paris Games in 1900, was included in the Los Angeles Olympics programme after the International Olympic Committee's 141st Session at Mumbai in October 2023.

Cricket joined five new sports at LA28, including baseball/softball, flag football, lacrosse (sixes) and squash. The T20 format, recognised as the vehicle for the growth of the game by the ICC, has also featured in other multisport events in recent years.

The Asian Games in 2010, 2014 and 2023 featured both men's and women's T20 competitions while the Birmingham 2022 Commonwealth Games staged a women's competition. (PTI)

The captain, who played at Adelaide, Brisbane and Melbourne during the Border-Gavaskar Trophy, failed in five consecutive innings before deciding to sit out to accommodate Shubman Gill, who missed the Boxing Day Test at MCG.

We somehow wanted Gill to play, he's such a good player. He missed out in the previous Test match. I'm like... okay, if I'm not

hitting the ball well, it is right now. Things can change five days later, ten days later," Rohit told former Australian skipper Michael Clarke during Beyond23 Cricket podcast.

"I spoke to the coach and the selector, and they kind of agreed, not agreed, .... there was an argument around it," he disclosed.

Known for his team-first leadership approach, the Indian skipper's logic was simple.

"You try and put the team first, you just look at what the team wants, and make the decision accordingly. Sometimes it will work, sometimes it may not. That's how it goes. Every decision you try and make, you aren't guaranteed success," said Rohit.



The great batter also gave a logical reasoning as to how he arrived at the decision to drop himself. "I didn't have a great game (in Adelaide). Then I went back to the room, and I was like, I should

have opened man. I would rather fail doing what I do and where I do it. That's my place, that's my position. I would rather go there and bat, whether I get success or not, it's a different story. But I'm team," he said. In fact, he thought, he should give himself another game in

Brisbane. "And I said, no. It's only one game. Let's not overthink, let's give it another game. It's 1-1. We can try and change things around in Brisbane. And then, it was a draw. When we got back to Melbourne, we changed our mind. I went back to open the innings." Rohit admitted that he had to drop himself as there were multiple players, who were out of form at the same time, including star batter Virat Kohli. Barring his hundred in the opener in Perth, Kohli struggled though the series. (PTI)
