

Modi tells forces to respond harder to Pak actions: Sources

Indira 'mishandled' situation post-B'desh creation: Himanta

GUWAHATI, May 11: Chief Minister Himanta Biswa Sarma on Sunday criticised former Prime Minister Indira Gandhi for her "mishandling" of the situation following the creation of Bangladesh after India's historic 1971 win against Pakistan.

In a post on X, Sarma alleged that due to failure of the political leadership of that period, creation of Bangladesh was a "historic opportunity lost".

The CM's long post comes in the wake of Congress leaders' criticism of Prime Minister Narendra Modi after US President Donald Trump on Saturday claimed that India and Pakistan have agreed to a "full and immediate" ceasefire after US mediation.

India and Pakistan on Saturday reached an understanding to stop all firings and military actions on land, air and sea, with immediate effect.

Sarma titled his post as 'The Myth of Bangladesh's Creation: A Strategic Triumph, A Diplomatic

"India's 1971 military victory was decisive and historic. It broke Pakistan in two and gave birth to Bangladesh. But while our soldiers delivered a stunning battlefield success, India's political leadership failed to secure lasting strategic gains," he said.

The creation of Bangladesh is often hailed as a diplomatic triumph, but history tells a different story, he claimed.

"India's military triumph in 1971 was not matched by strategic foresight. What could have been a new regional order was reduced to a one-sided act of generosity. Had Mrs. Indira Gandhi been alive today, the nation would have questioned her for mishandling the decisive victory won by our armed "The creation of Bangladesh was not a bargain — it was a (CONTD. Panchayat polls: BJP ahead in counting of votes

A clear picture to emerge today: Poll panel

GUWAHATI, May 11: The BJP is leading in the Assam panchayat polls' counting, which is underway across the state since Sunday morning amid tight security, officials said.

Panchayat elections took place in two phases on May 2 and May 7 in 27 districts for the first time after the delimitation of constituencies. The counting of votes for both phases is being held simultaneously since 8 am.

According to Assam State Election Commission (ASEC) data, the BJP has won six members of Anchalik Panchayat constituencies in Majuli district.

"We have not got any other trends or results yet from the districts. Counting of panchayat votes is a very complex job with three



The total seats include 21,920 Gram Panchayat (GP) members with 10,883 seats reserved for women. Voting also happened for 2,192 Anchalik Panchayat (AP) members with 1,124 reserved for women and 397 Zilla Parishad (ZP) members with 199 seats re-

Sources said the BJP is leading

in 355 AP seats and its ally AGP in 42 seats, while the Congress is ahead in 21 AP constituencies.

In the case of ZP, the saffron party is marching ahead in 35 and AGP in two. Congress is not leading in any ZP seat yet.

The GP members were not allowed to contest on party tickets

have won uncontested - 34 ZP members, 311 AP members and 2,567 GP ward members.

"The counting of ballot papers began in all the 39 centres across the state. The counting agents of candidates reached early in the morning for the exercise," a senior official said.

In view of stray violence and disruptions during voting, the administration has arranged adequate security measures in all the counting centres to avoid any such situations, he said.

"There are thousands of seats in the election. We will try to complete the counting as soon as possible. However, we believe that it is likely to stretch till tomorrow." the official said.





DHEMAJI, May 11: "Will our house still be standing when we return some day? What about the land?"

Lakhisekhi Bara's ears ring with these questions from her husband every day. Questions to which she has no answer.

Bara (52) moved to Assam's Dhemaji from a neighbouring district with her daughter-in-law when the 2023 floods rendered them homeless while the men of the family migrated to Chennai to work as construction labour-

The two women are among several to have been left behind in the district by the men in their families who moved to other states due to climate-induced income loss

"We used to work the farm- Chennai two years ago. We



land but agriculture has become unpredictable while daily wage work is not regularly available. It was not possible to run the household with this income. As a result, my husband and our son moved to

moved to Dhemaji because other women from our extended family live here and we can be there for each other in times of need," she tells PTI.

"Whenever my husband calls, he wonders if our land will be safe to resume agriculture some day. What if it is completely washed away? That is our only asset," she

Among the country's 250 most backward districts, Dhemaji is severely flood-prone. Official estimates suggest more than 23 lakh people in 28 districts of Assam in India's northeast have been affected by floods.

The unpredictable Brahmaputra river -- originating in the Tibetan Plateau and flowing through Arunachal Pradesh and Assam before emptying into the Bay of Bengal -shapes the state's flood land-



Govt to hold pre-emption right over oil, gas in emergency: Draft rules

rights over all oil and natural gas produced in the country in any event of national emergency, according to draft rules being framed under a revamped oilfields legislation.

A pre-emption right (or preemptive right) is the legal right of a party - often a government or existing shareholder - to purchase or claim a product, asset, or resource before it is offered to others.

The inclusion of such rights over crude oil - extracted from underground or beneath the seabed and refined into fuels like petrol and diesel - as well as natural gas, which is used for power generation, fertilizer production, CNG for vehicles, and piped cooking gas, is intended to help the government prioritize national interests and ensure public welfare during emer-

The producer of oil and natural gas will be paid a "fair market price prevailing at the time of preemption", the draft rules said. Ministry of Petroleum and Nat-

DCM Shriram's arm Fenesta buys 53% stake in DŇV Global for ₹44 crore

NEW DELHI, May 11: DCM Shriram group firm Fenesta, which is into uPVC and aluminium windows and doors, has acquired 53 per cent equity stake in DNV Global for ₹44 crore to expand its business.

The deal is expected to be completed in next 2 months.

The acquisition of DNV Global will help Fenesta in backward integration and opportunity to create new line of business (hardware).

"This strategic investment marks a significant step in Fenesta's vision to enhance customer experience, deepen vertical integration, enhance product reliability, achieve accelerated growth in scale and unlock operational synergies across its supply chain," DCM Shriram said in a statement on Sunday

The total acquisition cost is ₹ 44 crore, which includes ₹31 crore by subscribing to fresh equity share capital of DNV Global and ₹ 13 crore by purchase of equity shares from the existing promoters/share-



ural Gas has invited comments on draft rules after Parliament earlier this year passed the Oilfields (Regulation and Development) Amendment Bill which replaced outdated provisions from the 1948 Act, to boost domestic production, attract investment, and support the country's energy transition goals.

"In the case of a national emergency in respect of petroleum products or mineral oil, Government of India shall, at all times, right of preemption of the mineral oils, refined petroleum or petroleum or mineral oil products produced from the crude oil or natural gas extracted from the leased area, or of the crude oil or natural gas where the lessee is permitted to sell, export or dispose of without it being refined within India," the

This right will be exercised by providing a "fair market price prevailing at the time of pre-emption to the lessee by Government of

leum or mineral oil products or the crude oil or natural gas taken in pre-emption.

The rules however did not define what would constitute a national emergency. Industry sources said war or war-like situations like the one that the country faced in the military standoff with Pakistan - or natural disasters could constitute a national emergency.

"Government of India shall be the sole judge as to what constitutes a national emergency in respect of mineral oils, and its decision in this respect shall be final," the rules said.

The draft rules also provide for oil and gas operators being exempt from their obligations under the Act in force majeure conditions.

Force majeure includes an act of God, war, insurrection, riot, civil commotion, tide, storm, tidal wave, flood, lightning, explosion, fire, earthquake, pandemic and any other happening which the lessee could not reasonably prevent or

JSL serious on ₹ 40,000-cr investment in Maharashtra: MD Abhyuday Jindal

about Maharashtra" and is engaged in discussions with the state government to acquire a land parcel for its proposed ₹ 40,000-crore stainless steel manufacturing facility, its MD Abhyuday Jindal said.

At present, Jindal Stainless has a capacity of 3 million tonnes per annum at its two plants in Hisar (Haryana) and Jajpur (Odisha). The company is in the process of ramping up capacity to 4.2 MT by FY27.

In an interview to PTI, Jindal said, "We are very serious about the investment. Currently, we are in discussions with the state government for acquisition of land." He made the remarks in reply to a question seeking an update on the agreement signed with the Maharashtra government in March this year.

On the capex for FY26, Jindal said it has been fixed at ₹ 2,700 crore, which includes ₹ 1,000 crore spillover of FY25. In FY25, the company's capex guidance was ₹ 5,500 crore but it translated into ₹ 4,500 crore. So the remaining has been added to

On the India-UK FTA, he said it may not have a direct impact but can indirectly impact growth of the company through its customers.

Jindal further said as of now, JSL is not looking for new markets and will continue to focus on the US and Europe for exports.

He said during the March quarter, the export demand began to rise once more, which was fulfilled by ramping up capacity utilisation. This is projected to continue improving in the short and mid-term, especially in quality-conscious markets like the US and the EU, as "the old customers have started to return".

As per company information, JSL's investment proposal has also been approved in a meeting of the state cabinet subcommittee. The project, with an estimated investment of ₹ 40,000 crore, is scheduled to be developed over the next 10 years, which is expected to create more than 15,000 jobs.

The proposed stainless steel facility will have a total melting capacity of 4 million tonnes per annum and will be constructed in phases, with the first phase expected to be operational in the next four years.

JSL will also produce specialised grades for critical applications in emerging sectors such as hydrogen, nuclear energy, defence, mobility, infrastructure, and process industries.

The government of Maharashtra will support the proposed investment by expediting the necessary permissions, registrations, approvals, clearances, and fiscal incentives from the relevant state departments, according to information provided by the company.

Jindal Stainless Ltd (JSL) is India's largest stainless-steel manufacturer and posted an annual turnover of ₹ 40,182 crore in FY25. It is ramping up facilities to reach 4.2 million tonnes of annual melt capacity by FY27. The company has 16 stainless steel manufacturing and processing facilities in India and abroad, including in Spain and Indonesia, and a worldwide network in 12 countries, as of March 2025. (PTI)

Former ICAR member demands CBI probe into Padma Shri awardee Ayyappan's death

NEW DELHI, May 11: A former member of the Indian Council of Agricultural Research (ICAR) on Sunday demanded a court-monitored CBI investigation into the "untimely and mysterious" death of former ICAR Director General and Padma Shri awardee Sub-

banna Ayyappan. Venugopal Badaravada, previously on ICAR's Governing Body, said: "The conditions surrounding his untimely death are deeply troubling. His scooter was found abandoned, and the cause of his death remains unclear. These circumstances demand a court-monitored CBI investigation".

In separate letters to Prime Minister Narendra Modi and Home Minister Amit Shah, Badarayada alleged that the tragic event reveals "deep-rooted corruption, irregular appointments, and abuse of power within ICAR, ASRB (Agricultural Scientists Recruitment Board), and affiliated institutions"

"Ayyappan ji's death might be a consequence of institutional vendetta or administrative collapse, as the scientific and farming communities are now alleging," he added. Ayyappan (70) was found dead in the Cauvery River near Srirangapatna, Karnataka, on Saturday. His two-wheeler was discovered on the riverbank, with local police suspecting he may have jumped into the river. His body was recovered three days after he went missing under suspi-

cious circumstances. Badaravada also criticised ICAR for "unlawfully" removing him from the governing body on May 5 through "a one-sided office

order without conducting a serious inquiry"

"This unlawful removal reflects a dangerous trend within ICAR, silencing whistleblowers while shielding entrenched corruption," he claimed.

Ayyappan, who resided in Vishweshwara Nagar Industrial Area of Mysuru, was reported missing on May 7 when his family filed a complaint with the Vidyaranyapuram Police Station. Police noted that he often meditated at the Saibaba ashram, located on the Cauvery River banks in Srirangapatna. The deceased scientist was the first non-crop specialist to head ICAR and was credited with playing a significant role in India's 'Blue Revolution'

Godrej Properties to launch projects worth ₹40K cr in FY26: Chairman

NEW DELHI, May 11: Godrej Properties plans to launch housing projects worth ₹40,000 crore, as the company aims to increase market share and retain its position as the top listed real estate firm in terms of sales bookings.

In an interview with PTI, Godrej Properties Executive Chairperson Pirojsha Godrej noted that the housing demand continues to be strong despite global economic uncertainties, and cited the company's performance in the last fiscal, where it achieved record sales bookings of ₹ 29,444 crore, the highest among listed entities.

"So, overall, I am very happy with the company's performance in FY25, and I think, key is now to maintain this momentum in the current financial year," Pirojsha told PTI.

He said the company would continue to invest in land acquisition and development works to expand its business and increase market share. "We raised ₹ 6,000 crore in October last year through QIP (Qualified Institutional Placement). That ₹ 6,000 crore plus ₹ 7,500 crore operating cash flow creates a pretty good war chest to ensure further investments and maintain this kind of strong growth rate," Pirojsha

Talking about the targets for the 2025-26 fiscal, he said, "We have guided for ₹32,500 crore worth of sales booking value for this fiscal, which is 20 per cent higher than our guidance

of last year and 10 per cent higher than the actuals we delivered. Hopefully, if market support again, we can outperform the guidance".

We have a good lineup of projects. We have guided for launches of 40,000 crore worth of projects. There is good visibility across the region," he added. In the last fiscal, Pirojsha said, the company

had given guidance of launching ₹ 30,000 crore worth of projects, but it ended up launching properties valuing ₹ 36,600 crore. According to an investor's presentation, Godrej Properties launched 34 projects, either a

new one or a new phase in existing projects, last fiscal with 292 lakh square feet of area and an estimated sales bookings value of ₹ 36,600 crore. Pirojsha said the company would launch a project in Worli, Mumbai, in the first half of this fiscal and also hoped to launch its big-ticket project at Ashok Vihar in Delhi by March 2026.

These new launches and sales from ongoing projects would help the company to meet the targeted sales bookings of ₹32,500 crore for this fiscal.

During the 2024-25 fiscal, Godrej Properties sales bookings rose 31 per cent to a record ₹ 29,444 crore from ₹22,527 crore in the preced-

Pirojsha noted that these sales bookings were distributed across various regions and said it is a good sign that the company is not "overly reliant on any one region and one or two projects". Pirojsha said the company's collections of funds from customers rose sharply to a record ₹ 17,047 crore last fiscal from ₹ 11,436 crore in the preceding year.

Strong collections helped in generating healthy operating cash flow for the company, he pointed out. Pirojsha also mentioned that the company's market share increased to 4.3 per cent last fiscal.

In the presentation, the company cited PropEquity data, estimating the total market size of tier-I residential markets at ₹ 6.9 lakh crore in the last fiscal.

Based on PropEquity data, Godrej Properties' share was 4.3 per cent as it clocked sales bookings of ₹ 29,444 crore during 2024-25.

On financial performance, Godrej Properties recently reported that its consolidated net profit rose 93 per cent to ₹ 1,399.89 crore during 2024-25 from ₹ 725.27 crore in the preceding fiscal. Its total income grew to ₹ 6,967.05 crore last fiscal compared to ₹ 4,334.22 crore in the 2023-24 fiscal.

The board also approved a proposal to raise up to ₹ 2,000 crore by issuing non-convertible debentures, bonds, and/ or other debt securities on a private placement basis, in one or more tranches. (PTI)

Women who are left

man. Most of the men still left in the village were either senior citizens or children. Roopa Baruah (32) lives in a 'chang ghar' -- a temporary home built on bamboo stilts -- with her two children, aged four and six, while their pucca house built under the Pradhan Mantri Awas Yojna lies abandoned.

Her husband works in a Bengaluru rubber factory and hasn't been back for two years.

"The pucca house is located in a far-flung spot in the village. If it gets submerged, I cannot rush out on my own with the children. So I live in a 'chang ghar' here with other women nearby. Sometimes, if my children are ill, it is easier to get help here," she tells PTI. "My husband sends money. He asks if we will be able to live together in our house some day. The children miss their father but what can we do when there are no income sources here? If we also migrate, it will be expensive and our house here may be gone forever," she says.

The majority of Dhemaji's residents live in 'chang ghars', with their livestock kept below. During floods, however, the animals have to be accommodated inside to save them from being washed away.

When living at home becomes perilous, they move away from the embankment and return after the waters recede. A working-age man, Bokul moved back to Dhemaji four months ago after losing an arm in a factory accident in Kerala. He now lives with the women of the family.

'Most of the men have left the village to make a living in other states. It is mostly the elderly or those with disabilities, like me, who live here since we cannot go out to earn. I help my wife and my brother's wife, who lives here with her three-year-old son. Nobody wants to migrate but there is no choice," the 26-year-old says.

Rebuilding homes, collecting firewood, fishing, stitching and weaving for pittances, besides helping children and livestock adjust to a new place as floods render them homeless every year are among the changing roles women in the district perform due to the migration of men that has increased their vulnerability and workload. Indian Institute of Technology (IIT), Guwahati, researchers studying the climate-induced migration from the district believe Dhemaji serves as a compelling case due to its extreme vulnerability to environmental changes, partic-

ularly flooding. The study is being funded by the Indian Institute for Human Settlements and Population Council. According to IIT, Guwahati, professor Anamika Baruah, who is leading the study, recurrent floods lead to displacement, erosion, prolonged waterlogging and the destruction of livelihood -- especially agriculture, the district's economic backbone. "Climate change further intensifies these challenges, increasing the frequency and the severity of floods, resulting in both seasonal and permanent displacement. Beyond the environmental impact, the socio-economic consequences in Dhemaji are substantial," she says.

Debarchana Biswas, a postdoctoral scholar at IIT, Guwahati, says most workers from Assam, particularly districts such as Dhemaji, are not happy migrating to other parts of the country despite recognising its economic benefits. "For many, migration is seen as a positive step toward improving their financial situation but, deep down, leaving behind their families, homes and familiar surroundings is emotionally challenging. Migration, while providing better wages, comes with the emotional and logistical burden of maintaining two households,' she says, citing the study. "This dual responsibility is financially and emotionally draining. Moreover, during emergencies, their inability to quickly return home exacerbates their sense of helplessness," she says.

The 2021 Climate Vulnerability Index ranked Assam as India's most climate-vulnerable state. The expansive Brahmaputra and Barak river basins, Assam's fast-dwindling green cover and northeast India's overall geoecological fragility are a few reasons behind the vulnerability. Improved plans and programmes are being implemented for disaster risk reduction in hazard-prone areas compared to previous years, says environmental scientist Partha Jyoti Das. He says, "High-vulnerability groups like women, the elderly and marginalised communities should get more attention in disaster risk reduction policies. Although we have many policies and programmes on paper to address such concerns, the vulnerable people somehow do not get the desired benefit of such interventions to the expected extent -- indicating execution deficit and lack of monitoring of government projects and welfare schemes." Das, who heads the Water, Climate and Hazard division at Aranyak -- a research organisation -- notes outwards migration of youngsters from rural areas is usually considered a useful strategy to cope with the negative impact of climate-induced hazards. The remittances they send back is also crucial for survival and sustenance of their families in a hazard-prone environment.

"However, labour out-migration also has some negative impacts. We have seen wives and girls bearing more burden of family responsibilities such as looking after parents, in-laws and children. The women must also take care of family vocations such as farming, livestock rearing and other such means of income generation," he adds. Luit Goswami, executive director at Rural Volunteers Centre -- a non-profit working in the region -says Dhemaji is extremely vulnerable to climate change due to its proximity to the confluence of the Brahmaputra and many of its tributaries. "However, like most developing regions, climate change issues have received ss importance here and efforts are more focused on recovery than creation of adaptive capacity," he says.

"The forced displacement due to climate extremes leads to distress migration, which has largely been accepted as an adaptation strategy by the families and the communities affected," he adds.

The responsibilities of women seem to be soaring they ensure the rights of children such as survival (food and nutrition, health care), development (education) and protection (early marriage, child labour, child-trafficking, drug abuse), he says. "All these lead to physical and mental health deterioration." (PTI)

Referring to the perennial immigration issue, the Assam CM pointed out that no agreement was reached for mandated return of illegal Bangladeshi migrants. "As a result, Assam, Bengal, and the Northeast face unchecked demographic change, sparking social unrest and political instability," he added. Sarma also claimed that India

did not secure access to the strategic Chittagong Port and even after five decades, the Northeast remains landlocked. He also alleged that insurgents found a refuge in Bangladesh and for several decades, the neighbouring country served as a base for anti-India militant groups and exploited the vacuum India failed to close in 1971. "Conclusion: A Victory Undone by Silence," Sarma said. (PTI)

chayats, and 88 Gaon Panchayats. In terms of candidature, 69 candidates are contesting for the Zilla Parishad seats, 417 candidates for Anchalik Panchayat seats, and a massive 3,999 candidates are vying for positions across the Gaon Panchayats—highlighting the competitive nature of the polls.

As of the time this report was filed, the counting was proceeding without any reported irregularities. With the final results expected by May 12 evening, all eyes remain on the outcome that will define the leadership and governance framework across Dhubri's rural landscape for the upcoming term.

Our Margherita correspondent adds: BJP-supported candidates have secured a clean sweep in all 13 gaon panchayats and four ZPC seats under the 83rd Margherita Assembly constituency.

The counting of votes, which began this morning, concluded with a decisive victory for the BJP alliance across all the contested panchayats.

In the Borgolai Gaon Panchayat, former president Mira Subba, vice-president Jhuma Sen, and ward members Swapna Chetry Bhujel, Ranjit Chetry, Bhanu Tanti, Lakshmi Jaishi, Khusbu Kar, and

Gauhati High Court directs swift repatriation of Nigerian national after 1457 days of illegal detention

HT Correspondent KHERONI, May 11: In a landmark decision, the Gauhati High Court has directed the immediate repatriation of Kamardeen Oaladeji Oladimeji, a Nigerian national who has been held at the Matia Transit Camp in Goalpara, Assam, for 1,457 days beyond his prison sentence. The ruling, issued on May 9, 2025, under case number WP(C)/2207/2025, underscores the illegality of his prolonged detention and instructs authorities to act promptly or face the possibility of his unconditional

According to the official court order, Oladimeji was initially detained on November 12, 2020, for entering India without valid travel documents. He was later convicted on August 18, 2021, by

the Judicial Magistrate First Class (II) in Karimganj (now Sribhumi), under the Foreigners Act, 1946, and the Passport (Entry into India) Rules, 1950. He was sentenced to six months' imprisonment and fined ₹2,000 for each offense. Despite completing his sentence by May 13, 2021, he continued to be held at the transit camp—an act now deemed unlawful by the court.

The bench, comprising Justices Kalvan Rai Surana and Malasri Nandi, heard arguments from Oladimeji's legal counsel, D.K. Agarwala, along with Tawhid Laskar and A. Borbhuyan. The legal team emphasized that the Nigerian Embassy could issue an Emergency Travel Certificate (ETC) upon conducting an online

court directed the Ministry of Home Affairs and the Ministry of External Affairs to coordinate with the Nigerian Embassy to facilitate the issuance of necessary travel documents within seven days. In the event of any delays, the

court ordered the Superintendent of the Matia Transit Camp to arrange a video conference between Oladimeji and Nigerian Embassy officials to expedite the process. Once the ETC is issued, the Assam Home & Political (B) Department has been instructed to make necessary arrangements for Oladimeji's travel from Matia to Lokpriya Gopinath Bordoloi International (LGBI) Airport in Guwahati. The onward journey to Nigeria-via New Delhi or another international airport—is to be coordinated accordingly. The court clarified that the cost of travel would be borne by Oladimeii himself.

The High Court expressed grave concern over the unjustifiable delay in the repatriation process and warned that failure to comply within the stipulated timeframe would lead to Oladimeii's unconditional release. It emphasized that further detention beyond the courtmandated period would be the sole responsibility of the concerned authorities.

The matter has been listed for further hearing on May 30, 2025.

This ruling highlights the judiciary's commitment to upholding legal standards in detention cases involving foreign nationals and draws attention to procedural lapses in India's immigration and

He explained how biochar can enhance soil health and support crop growth.

Dr Milon Jyoti Konwar, Scientist at the Directorate of Research, AAU, Jorhat, highlighted the detrimental impact of Parthenium on crop yields, livestock, and grazing land. He stressed the urgency of adopting effec-

tive control measures for this invasive species. A live demonstration on the preparation of compost using Parthenium was conducted by Prakshipta Boruah, Subject Matter Specialist (Agronomy), and Monuj Pegu, Farm Man-

ager, KVK Karbi Anglong. The compost was prepared using dry cow dung, chopped banana pseudostems and leaves, paddy straw, and Parthenium plants (excluding flowers). The resulting compost is expected to be ready for application after approximately 60 days.

In an effort to encourage local participation and sustainable practices, vermi-beds were also distributed to Self Help Groups in the vil-

The event witnessed the active engagement of 20 farmers who gained practical knowledge and hands-on experience in transforming Parthenium into useful compost.

The initiative is part of a broader effort to promote environmental sustainability, manage invasive species, and empower farmers with low-cost, eco-friendly solutions for soil health improvement.

Declaration of assets

The gesture of Supreme Court judges declaring their assets is at best symbolic. The declaration itself does not and cannot constitute a meaningful solution to judicial corruption, especially when the mechanisms for oversight remain weak, opaque, and riddled with structural loopholes. The immediate provocation for this move—the discovery of burnt currency at the residence of Delhi High Court judge Yashwant Varma—has added urgency to the narrative, but urgency is not the same as effectiveness. If anything, this incident highlights the gaping holes in the system and the inadequacy of the current means of accountability. It took a fire to bring out this specific problem, but fire can in no way be a solution to expose corruption! The declaration of assets, as a standalone act, suffers from several intrinsic limitations. It deals only with visible, documented, and legal forms of wealth—assets that are officially held and can be presented on paper. However, the primary currency of corruption is black money, which by its very nature exists outside official records and declarations. Those who engage in corrupt practices rarely channel the proceeds into traceable bank accounts or real estate holdings that can be openly declared. Instead, such funds are typically laundered, concealed, or converted into benami assets. Therefore, the act of publicly listing one's white money holdings does little to address the real, subterranean networks of illicit wealth accumulation. It may help cultivate a veneer of transparency, but it doesn't shine any light into the darkest corners where corruption truly thrives.

Moreover, the efficacy of asset declaration is fundamentally tied to the presence of robust external oversight. In the Indian judicial framework, judges are not subject to independent anticorruption bodies like the Lokpal or the Lokayukta. This glaring omission significantly dilutes the impact of asset declarations. Without an empowered, autonomous agency to scrutinize the veracity of these declarations or to investigate anomalies, the process becomes largely performative. Judges remain their own watchdogs, operating within an insular system of in-house supervision that has long been criticized for its lack of transparency, its aversion to accountability, and its tendency to shield errant members. It is precisely this self-regulatory model that has allowed instances of misconduct to be quietly buried without public scrutiny or legal consequence.

The Indian judiciary has often justified its internal mechanisms by invoking the doctrine of judicial independence, an important principle to protect judges from political or executive interference. But judicial independence should not be conflated with judicial impunity. Transparency and accountability can and must coexist with independence; they are not mutually exclusive. The Varma case and its aftermath may serve as a test of this balance, but past precedent does not inspire much confidence. The root problem is the lack of structural mechanisms to ensure external and impartial oversight. In countries with more robust anti-corruption frameworks, judges are not immune to investigation or prosecution by external bodies. Their asset declarations are subject to audit, and any discrepancies can trigger formal inquiries. In India, however, the absence of such mechanisms means that even if a judge accumulates disproportionate assets, there is no clear, institutional pathway to investigate or prosecute the matter unless it erupts into a scandal too large to suppress.

Buddha's path to truth and inner awakening

It begins with right view and right intention, cultivating a clear understanding of reality and a compassionate purpose in life. Right speech, right action, and right livelihood guide one's conduct in society, fostering harmony and non-harm. Right effort, right mindfulness, and right concentration focus on mental cultivation, encouraging selfawareness and meditative insight. Together, these elements form a holistic path inner awakening

What sets Buddha's path apart from many other reli-

gious or philosophical traditions is its emphasis on per-

sonal experience over dogma. The Buddha encouraged inquiry and self-exploration. He famously told his followers not to accept his words blindly but to test them through their own experience, like a goldsmith testing the purity of gold. This raand experiential approach empowered individuals to take responsibility for their own transformation. Enlightenment was not bestowed by any divine entity but attained through inner awakening. The Buddha's teachings thus emphasized the potential of every human being to awaken, regardless of caste, gender, or social status.

International Nurses Day 2025: Caring for nurses is caring for the future

ach year on May 12th, the world pauses to pay homage to a profession that, more than ✓any other, embodies the principles of compassion, resilience, and healing. International Nurses Day (IND), celebrated on the birth anniversary of Florence Nightingale—the trailblazing reformer and founder of modern nursing-is not merely a tribute to nurses' indispensable service. It is also a moment of reckoning. A time to reflect on the persistent gaps in healthcare systems, the undervaluation of caregiving labour, and the urgency of reimagining nurses as not just healers, but pillars of economic and social resilience. In 2025, this recognition takes on even greater meaning under the International Council of Nurses (ICN) theme: "Our Nurses. Our Future. Caring for nurses strengthens economies.'

This powerful theme encapsulates a profound truth—nurses are not auxiliary assets to national development; they are essential catalysts. By spotlighting the intrinsic link between the well-being of nurses and the economic health of nations, this year's observance compels a paradigm shift. In a world increasingly shaped by global health threats, demographic transitions, and the mounting burden of chronic diseases, the strength of economies will depend not only on factories, data, or infrastructure, but on the stamina, skills, and support given to nurses.

Florence Nightingale, whose legacy inspired this annual celebration, revolutionised healthcare in the 19th century through data-driven nursing reforms during the Crimean War. Today, her symbolic lamp continues to burn—especially during the annual "Lamp Lighting" ceremonies worldwide—signifying the enduring light nurses bring to the darkest moments of human vulnerability. But in 2025, the flame must illuminate more than tradition. It must cast light on an urgent global agenda: to protect, empower, and invest in nurses as a moral imperative and a strategic necessity.

The statistics underscore this urgency. According to the World Health Organization (WHO), there exists a global shortfall of 5.9 million nurses. Nurses constitute nearly 59% of the global health workforce and in many low- and middle-income countries, they provide up to 80% of primary healthcare. Yet they remain undervalued, overburdened, and underpaid. The COVID-19 pandemic brought them into the international spotlight as frontline warriors, but once the applause faded, many found themselves again in unsafe working conditions with insufficient mental, emotional, and financial support.

This context makes the 2025 theme particularly resonant. It is not simply a celebration of the profession, but a clarion call for action. By drawing attention to the economic impact of nursing, the ICN challenges policymakers to recalibrate their understanding of development. Healthier populations mean greater workforce productivity, fewer days lost to illness, lower public health expenditures, and a stronger economic base. In fact, estimates from the International Labour Organization (ILO) suggest that every dollar invested in health—particu-ficiency. However, to ensure they are not left belarly in nursing—generates up to four dollars in economic returns. It's a fiscal argument as much as a humanitarian one.

Moreover, nursing is a profoundly gendered profession Over 90% of nurses worldwide are women To invest in nurses, therefore, is to invest in gender equality. This links directly to Sustainable Development Goals (SDGs), especially SDG 3 (Good Health and Well-being), SDG 5 (Gender Equality), and SDG 8 (Decent Work and Economic Growth). However, despite their numerical dominance, women in nursing remain underrepresented in leadership roles and policy-making bodies. Addressing this imbalance is not just about fairness—it's about making healthcare more responsive, inclusive, and effective.

India, home to nearly 3.3 million registered nurses and midwives, presents a telling case. Despite this large workforce, the nurse-to-population ratio remains around 1.7 per 1,000—well below the WHO recommended 3 per 1,000. The shortage is acute in rural and tribal areas where health infrastructure is already fragile. Each year, thousands of nurses graduate from Indian institutions, yet systemic issues such as poor remuneration, contractual employment, job insecurity, and unsafe workplace environments hinder retention. Worse, the allure of better-paying jobs abroad has created a persistent "nursing brain drain," particularly to countries like the UK, Canada, and Gulf states. While remittances provide economic benefits, the cost is the weakening of India's own health system.

The Indian government, through the Indian Nursing Council (INC), has taken steps toward reform: updating curricula, increasing digitalisation in licensure, and expanding nursing education. However, much more remains to be done. The pandemic further highlighted the vulnerabilities of Indian nurses—many of whom worked long hours in COVID-19 wards without adequate protective equipment or psychological support. While public appreciation spiked momentarily, lasting structural support was largely absent. International Nurses Day 2025 thus serves as a call to translate respect into policy—to prioritise fair wages, safe workplaces, and meaningful career pathways.

Internationally, the ICN and WHO have put forward frameworks such as the "Global Strategic Directions for Nursing and Midwifery 2021-2025," urging countries to build a workforce that is educated, employed, empowered, and equitably distributed. These recommendations are not aspirational—they are foundational to achieving Universal Health Coverage (UHC) and ensuring global health equity. Without a robust nursing workforce, no nation can claim preparedness for future health crises or progress toward inclusive de-

It is also worth noting the evolving landscape of healthcare itself. Digital health technologies, artificial intelligence (AI), and telemedicine are transforming patient care models. Nurses are at the forefront of this digital revolution—not as passive hind, nations must invest in digital literacy, ethical training, and curriculum reform. The future of healthcare will be technologically enabled but human-centred—and nurses are vital to bridging

The themes of International Nurses Day have consistently evolved to reflect pressing realities. In 2020, amidst the pandemic, the theme was "Nurses: A Voice to Lead - Nursing the World to Health.' The 2021 theme advanced the conversation to envision "A Vision for Future Healthcare." By 2022. it demanded action: "Invest in Nursing and Respect Rights to Secure Global Health." The 2023 and 2024 themes—"Our Nurses. Our Future." and "The Economic Power of Care"-began linking nurse welfare with systemic outcomes. The 2025 theme is thus not an isolated slogan, but part of a growing global consciousness that caring for nurses is not an auxiliary task—it is central to societal progress.

At a policy level, this means integrating nurses into decision-making bodies, creating national frameworks for workforce planning, and enabling public-private partnerships that fund nursing education and employment. At the community level, it requires combating the stigma and violence nurses often face, particularly during crises. At the institutional level, it means reforming how nursing is perceived—not as subordinate to doctors, but as a critical, autonomous pillar of health systems.

It is also essential that other sectors beyond health-finance, labour, gender, and educationrecognise their stake in this agenda. Economic planning must account for the value nurses bring. Gender policies must address workplace equity in nursing. Labour ministries must ensure fair contracts and benefits. And education systems must provide adequate infrastructure and scholarships for nursing aspirants, especially in underserved

International Nurses Day 2025, therefore, is not merely an observance—it is a movement. It asserts that the fate of nations is intertwined with the fate of nurses. In every rural clinic, urban hospital, refugee camp, or school infirmary, nurses are shaping outcomes not just in health, but in human dignity. Their well-being is a mirror reflecting our collective priorities.

The world has long entrusted nurses with the task of healing its wounds. It is time the world healed theirs. Investing in nurses is not an act of charityit is an act of foresight. It is a commitment to a more just, healthy, and economically resilient world. This year's theme—"Our Nurses. Our Future. Caring for nurses strengthens economies"-must be internalised as both a philosophy and a strategy. Only then can we build a future where every nation stands on the strength of those who care.

The British Heart Foundation notes that palpitations can stem from a wide range of underlying heart

conditions, such as: • cardiomyopathy, wherein the heart becomes enlarged

· congenital heart disease Palpitations can also result from arrhythmia, which refers to any change to a person's regular heart-

Causes of arrhythmia include: • atrial flutter, which is a fast and irregular heartbeat

• ventricular tachycardia, which occurs when the lower chambers of the heart pump too fast, reducing the amount of oxygen in the blood

• atrial fibrillation, which is when there is a short circuit in the heart that causes the atria, or upper chambers in the heart, to pump rapidly

 supraventricular tachycardia, which is when the heart suddenly beats a lot faster than normal

It may also be a warning sign of heart failure or a heart attack, both of which can result from a range of structural and other issues.

• what the triggers are

· whether they last for seconds, minutes, or hours

Being able to answer some of the following questions may also help with diagnosis:

• Is the heart rate too fast or slow during a palpitation episode, and is the rhythm regular or irregular? • Is there lightheadedness, dizzi-

ness, shortness of breath, or chest • Do the palpitations tend to occur during a particular activity? Is there

a pattern? Do the palpitations start and stop suddenly or fade in and out?

Treatment options Not everyone with heart palpitations will need treatment. If they do, it will depend on the type of palpitations, the person's symptoms, and the cause and amount of palpitations they are experiencing. Options include:

• Emotional causes: A person may find it beneficial to learn how to deal with a panic attack and use breathing techniques to help remain calm.

• Medication: If a person starts to have palpitations while taking certain medications, a doctor may recommend an alternative. • Lifestyle: The heart palpitations

should resolve without treatment, and people may find it beneficial to avoid the triggers. • Hormonal: Heart palpitations

that occur due to hormonal changes are usually temporary. The doctor may prescribe antiarrhythmic drugs, such as beta-blockers or non-dihydropyridine calcium channel blocker therapy. Beta-block-

ers slow the heart rate and reduce

blood pressure. If a person has arrhythmia, a healthcare professional may recommend the following medical proce-

Catheter ablation surgery: During catheter ablation surgery, a cardiologist will thread an ablation device into the heart through a catheter that passes through a deep vein in the groin, neck, or chest. The device causes scars to form over faulty electrical tracts in the heart. This can help correct the way electrical impulses travel through the heart.

• Electrical cardioversion: This procedure involves sending an electrical shock into the chest wall to try to stabilize a person's heart rhythm and rate. A doctor may choose this therapy to "reset" the electrical rhythm of the heart.

 Implantable pacemaker or defibrillator placement: A pacemaker is a permanent cardiac device that monitors and treats electrical conditions of the heart.

Home remedies

Some people experience regular palpitations, which may be bothersome. To reduce these, a person can try the following:

• Find a comfortable position and

· Perform deep breathing tech-

niques.

• Try to avoid panic, as this can worsen symptoms • Take magnesium supplementa-

tion, although a person should discuss this with a doctor first. Stay hydrated.

People may also try the Valsalva maneuver breathing method. A 2015 study found that the Valsalva maneuver is a simple and noninvasive method for stopping an abnormal heart rhythm. However, the researchers also noted that more research is necessary.

Complications

Many cases of heart palpitations are harmless. However, if they are a sign of an underlying heart condition, there can be serious complica-

Some heart conditions, such as atrial flutter, can lead to stroke. Heart palpitations can also be a symptom of heart failure and may precede cardiac arrest.

Some people may faint due to a sudden drop in blood pressure. Always get palpitations checked out and discuss management with a healthcare professional.

Prevention

Often, lifestyle strategies can help reduce or stop nonserious palpitations. For example, people should try to reduce or avoid the following:

• any medications that may trigger

• getting enough sleep

From 2000 to 2010, less than 100 measles cases were reported each year in the U.S. Since 2010, there have been isolated outbreaks. mainly in unvaccinated communities, with approximately 200 to 300 cases a year. The latest major outbreak in the U.S. was in 2019, with 1,274 cases, primarily in the New York City metropolitan area and

parts of New Jersey. Cases fell in 2020 to 2023 during the COVID-19 pandemic, returning to prepandemic levels in 2024. Currently, most U.S. cases are coming from an epidemic in Texas, with 702 confirmed cases as of May 6. Of these, 91 people were hospitalized

and three people, two of them children, died. Measles cases are still being reported. Texas is one of 12 measles outbreaks documented in the U.S. in 2025 to date.

The World Health Organization has declared both North and South America to be at high risk for measles. Canada reported a total of 1.177 cases as of April 19, with 951 of them linked to an outbreak that began in New Brunswick in October 2024 and spread to seven provinces. In 2023, there were 12 measles cases in all of Canada. Mexico reported 421 confirmed measles

cases as of April 18, and another 384 cases are under investigation. There are also small measles outbreaks in South America, with Belize reporting its first two cases since 1991. Brazil reported five cases, and in Argentina there are 21 confirmed cases of measles, mainly in the capital city of Buenos Aires.

In Europe, measles cases rose tenfold, hitting 35,212 in 2024, according to the European Centre for Disease Prevention and

How did the US eliminate measles?

Measles is one of the most contagious infections ever identified. One person with measles can spread the infection to 12 to 18 others. That number, which epidemiologists call R0, is 1 to 4 for the flu and 2 to 5 for

In 1912, measles became a nationally reportable disease tracked by all the health departments in the U.S. At that time, there were about 3 million to 4 million cases and 6,000 deaths each year in the country. Medical care improved and the death rate decreased, but cases spiked to epidemic levels every two to

It was not until 1963, when the first measles vaccine became widely available, that cases dropped dramatically. The current measles vaccine, which is called the MMR vaccine because it also includes vaccines against mumps and rubella, was released in 1971. In 1977, the U.S. government launched the National Childhood Immunization Initiative to ensure that school children received vaccination against polio, diphtheria, pertus-

sis, tetanus, mumps, rubella and measles.

now COVID-19 are endemic in the U.S. A higher-than-normal number of cases in an area is termed an outbreak. For measles, an outbreak is defined as more than three cases in a county or local area. When cases from an outbreak spread outside the local area, that is an epidemic, and if an epidemic spreads into many countries across the world,

it becomes a pandemic. The measles outbreak in Texas started in January 2025 as an outbreak in six counties and quickly reached epidemic levels, hitting a total of 29 counties and a count of

702 cases as of May 6. A 2022 study used a computer algorithm to model the trajectory of measles cases in the U.S. given the drop in vaccination rates during the pandemic. If children who missed vaccines due to the pandemic do not receive catch-up vaccinations, and vaccine hesitancy continues at current rates, the study found, then 21% of U.S. children – about 15 million - will be vulnerable to measles over the following five years. That is well below the number needed to prevent

measles outbreaks. A study using a similar approach published in April 2025 found that measles is likely to become endemic again in the U.S. and predicted that the country could experience 850,000 cases over the next 25 years if vaccination rates remain the same. If vaccine rates decrease further, the study found, case numbers could increase to 11 million over the

next 25 years. What would it take to reverse the rise in measles?

Reversing this trend will require steadily increasing community vaccination rates. The April 2025 study found that boosting community vaccination rates by 5% would tamp down the increase in cases to between 3,000 and 19,000 over the next 25 years

May 11: US President Donald Trump on Sunday praised the "strong and unwaveringly powerful" leadership of India and Pakistan for reaching a "ceasefire" and offered to work with them for a "solution" on the Kashmir issue.

India has always maintained that the Kashmir issue is a bilateral matter and there is no space for any third party. India asserts that the Union Territory of Jammu & Kashmir and the Union Territory of Ladakh are and always will be integral and inalienable parts of it.

"I will work with you both to see if, after a "thousand years," a solution can be arrived at concerning Kashmir. God Bless the leadership of India and Pakistan on a job well done!!!" Trump said in a post on Truth Social.

His comments came hours after India and Pakistan on Saturday reached an understanding to stop all firings and military actions on land, air and sea, with immediate effect.

"I am very proud of the strong and unwaveringly powerful leadership of India and Pakistan for having the strength, wisdom, and fortitude to fully know and understand that it was time to stop the current aggression that could have lead (led) to the death and destruction of so many, and so much,"

UK hails India-Pak ceasefire, calls for sustained de-escalation

LONDON, May 11: The UK on Saturday welcomed the ceasefire agreed between India and Pakistan, calling on both nations to sustain their steps towards de-escalation.

Prime Minister Keir Starmer said the UK had been "engaged" with both countries for some days in pursuit of a ceasefire.

"I'm pleased to see today that there's a ceasefire. The task now is to make sure that that is enduring and is lasting," he told the BBC from Kyiv, where he is meeting European leaders for peace talks over the Russia-Ukraine conflict.

'Today's ceasefire between India and Pakistan is hugely welcome. I urge both parties to sustain this. De-escalation is in everybody's interest," said Foreign Secretary David Lammy. He took to social media soon after Indian Foreign Secretary Vikram Misri told reporters in New Delhi that the Director General of Military Operations (DGMO) of Pakistan had called his Indian counterpart on Saturday afternoon to agree to "stop all firing and military action on land, in the air and sea, with effect from 1700 hours IST".

The announcement followed a night of intense military activity in the region, with Lammy expressing "serious concern" and calling on India and Pakistan to move toward a "dialogue that leads to a swift and sustainable ceasefire".

Earlier, in a joint statement with fellow G7 Foreign Ministers of Canada, France, Germany, Italy, Japan, and the United States and the High Representative of the European Union, the UK had strongly condemned the "egregious terrorist attack" in Pahalgam on April 22 and urged maximum restraint from both India and Pakistan.

"Further military escalation poses a serious threat to regional stability. We are deeply concerned for the safety of civilians on both sides. We call for immediate de-escalation and encourage both countries to engage in direct dialogue towards a peaceful outcome.

"We continue to monitor events closely and express our support for a swift and lasting diplomatic resolution," read the statement, issued hours before the ceasefire announcement.

Diaspora groups in Britain reacted with guarded relief, with Friends of India Society International (FISI) UK highlighting India's "firm and uncompromising" stand against terrorism and INSIGHT UK stressing on a "humanity against terrorism" message.

"There are no winners in war. A lot of innocent people suffer unnecessarily and therefore, I welcome this step and hope that good sense will prevail where both sides agree never again," said Rami Ranger, House of Lords peer and Chairman of the British Sikh Association. "History has a habit of repeating itself if we don't learn from it. So, I hope this time, the Pakistani leaders will learn from the history. This could be the time when we draw a line and end this hostility

forever," Lord Ranger said.

Chietigj Bajpaee, Senior Research Fellow at the London-based think tank Chatham House, struck a note of caution because the ceasefire does not resolve the "underlying grievances" in the India-Pakistan bilateral relationship. (AP)

Soon after Trump's announcement, Foreign Secretary Vikram Misri said that the directors general of military operations (DGMOs) of India and Pakistan have agreed to stop all firings and military action on land, air and sea with effect from 5 pm (IST) on Saturday.

Tensions between India and Pakistan soared after the Indian Armed Forces hit terror launchpads in Pakistan and Pakistan-occupied Kashmir (PoK) last week in response to the Pahalgam terror attack.



US Secretary of State Marco Rubio on Saturday said that over the past 48 hours, Vice President J D Vance and he engaged with senior Indian and Pakistani officials, "including Prime Ministers Narendra Modi and Shehbaz Sharif, External Affairs Minister Subrahmanyam Jaishankar, Chief

of Army Staff Asim Munir, and National Security Advisors Ajit Doval and Asim Malik." "I am pleased to announce the Governments of India and Pakistan have agreed to an immediate

ceasefire and to start talks on a

broad set of issues at a neutral

Vance had also expressed gratitude to the leaders of India and Pakistan for their "hard work and willingness to engage in this ceasefire."

"Great work from the President's team, especially Secretary Rubio. And my gratitude to the leaders of India and Pakistan for their hard work and willingness to engage in this ceasefire," Vance said in a post on X.

Last month, Trump had said that there have always been tensions between India and Pakistan, and the two countries will figure it out between themselves "one way or the other." administration and lawmakers lauded Trump's efforts for de-escalation.

"I am incredibly proud to serve alongside Vice President Vance and Secretary Rubio. This historic administration is working every day to achieve peace. The golden age is coming and it starts with peace throughout the world," Commerce Secretary Howard Lutnick said on X.

Former national security advisor Mike Waltz, whom Trump plans to nominate as US ambassador to the United Nations, said, "progress towards stability in a historically volatile region. It won't be easy, there will be violations and much work to be done, but another step in President Trump's commitment to peace."

The House Committee on Foreign Affairs in the US has said President Trump is the "President of Peace."

Far-right political activist Laura Loomer said Trump "deserves the Nobel Peace Prize" for his efforts on India and Pakistan.

"He is truly such a transformative historical figure and the most consequential President of our lifetime. Once again, he has proven his commitment to Peace. Thank you, President Trump," Loomer said in a post on X. (PTI)

Israeli strikes on Gaza kill 11 people, mostly women and children



DEIR AL-BALAH (Gaza Strip), May 11: Israeli strikes overnight and into Sunday killed 11 people in the Gaza Strip, mostly women and children, according to local health officials.

Two of the strikes hit tents in the southern city of Khan Younis, each killing two children and their parents. Other strikes killed a child and a man riding a bicycle, according to Nasser Hospital, which received the bodies. In northern Gaza, an Israeli strike killed a 16-year-old boy, according to the In-

donesian Hospital.

The Israeli military says it only targets militants and tries to avoid harming civilians. It blames Hamas for civilian deaths in the 19-month-old war because the militants are embedded in densely populated areas. There was no immediate Israeli comment on the latest strikes.

Israel has sealed Gaza off from all imports, including food, medicine and emergency shelter, for over 10 weeks in what it says is a pressure tactic aimed at forcing Hamas to release hostages. Israel resumed its offensive in March, shattering a ceasefire that had facilitated the release of more than 30 hostages.

Aid groups say food supplies are running low and hunger is widespread.

U.S. President Donald Trump, whose administration has voiced full support for Israel's actions, is set to visit Saudi Arabia, Qatar and the United Arab Emirates this week in a regional tour that will not include Israel.

The war began when Hamas-led militants attacked southern Israel on Oct. 7, 2023, killing some 1,200 people, mostly civilians, and taking 251 hostage. Fifty-nine hostages are still inside Gaza, around a third of them believed to be alive after most of the rest were

released in ceasefire agreements or other deals.

Israel's offensive has killed over 52,800 Palestinians, mostly women and children, according to Gaza's Health Ministry, which does not say how many of the dead were combatants or civilians. The offensive has destroyed vast areas of the territory and displaced some 90% of its population of around 2 million.

Israel recovers remains of soldier killed in Lebanon in 1982

In a separate development, Israel said it retrieved the remains of a soldier killed in a 1982 battle in southern Lebanon after he had been classified as missing for more than four decades.

The recovery of Sgt. 1st Class Tzvi Feldman's remains brought more closure to a case that has plagued Israel for years. The Israeli military said his remains were recovered from deep inside Syria, without providing further details.

Feldman went missing, along with five other Israeli soldiers, in a battle with Syrian forces in the Lebanese town of Sultan Yaaqoub. Several years later, two of the missing soldiers were returned alive to Israel in prisoner exchanges with Syria. The remains of another soldier were returned in 2019, after Russia said it had helped locate them in Syria, while the fate of the other two remained unknown.

For many long years, I have authorized numerous covert operations to locate the missing from Sultan Yaaqoub, and I promised the Feldman family that I would never stop working to bring their son home, Israeli Prime Minister Benjamin Netanyahu said Sunday.

Cases of soldiers missing for decades have a powerful emotional and political resonance in Israel, where military service is compulsory for most Jewish men. (AP)

Chinese Foreign Minister Wang speaks to NSA Doval, calls for lasting ceasefire with Pak

BEIJING, May 11: Chinese Foreign Minister Wang Yi spoke to India's National Security Advisory (NSA) Ajit Doval and expressed hope that New Delhi and Islamabad would address their differences through dialogue and achieve a lasting ceasefire.

During their conversation, Doval told Wang that war was not India's choice but India needed to take counter-terrorism action after the Pahalgam attack, state-run Xinhua news agency reported in separate dispatches.

Wang also condemned the April 22 terror attack in Jammu and Kashmir's Pahalgam, which had cross-border linkages and triggered the worst fighting between India and Pakistan in years

Wang also spoke to Pakistan's Deputy Prime Minister Mohammad Ishaq Dar, Xinhua's reports said.

Hostilities soared between India and Pakistan after the Indian military hit terror infrastructure in Pakistan and Pakistan-occupied Kashmir (PoK) on May 7 in response to the Pahalgam attack, which claimed 26 lives.

The two nuclear-armed neighbours on May 10 reached an understanding to stop all firings

and military actions on land, air and sea with immediate effect after four days of intense cross-border drone and missile strikes.

In his talks with Doval, Wang expressed hope that India and Pakistan would remain calm and restrained, properly handle differences through dialogue and consultation, and avoid escalating the situation, according to Xinhua's reports.

Wang said China supports and expects India and Pakistan to achieve a comprehensive and lasting ceasefire through consultation, which is in the fundamental interest of the two countries and meets the common aspiration of the international community.

He said China condemns the terrorist attack in Pahalgam and opposes all forms of terrorism. Noting that the world is undergoing both transformation and upheaval, Wang said peace and stability in Asia are hard-won and deserve to be cherished. India and Pakistan are neighbours that cannot be moved away and they are both neighbours of China, he said.

Doval told Wang that the Pahalgam attack resulted in serious casualties for the Indian side and that India needed to take counter-terrorism

War is not the choice of the Indian side and is not in the interest of either side, Doval underlined, adding that both India and Pakistan will be committed to the ceasefire and look forward to restoring regional peace and stability as soon as possible, the reports said.

In his conversation with Dar, the reports stated, Wang said that as a neighbour of both Pakistan and India, China is concerned about the conflict between the two.

He said China believes that Pakistan will make decisions in line with its fundamental and long-term interests.

Dar told Wang that Pakistan is willing to achieve a ceasefire with India but will respond to any acts that violate its sovereignty and territorial integrity.

Noting that Pakistan stands on the frontline

of the international fight against terrorism, Wang said China supports its continued firm counterterrorism efforts, the Xinhua reports said.

Before India and Pakistan agreed to the

ceasefire, China on Saturday strongly urged the two countries to exercise calm and restraint, and return to the track of peaceful settlement. (PTI)

US, China begin 2nd day of tariff talks

GENEVA, May 11: The US and China on Sunday resumed crucial tariff talks that have put the global economy on edge, but appeared to have diverging views of where the negotiations presently stand.

US President Donald Trump wrote on social media that "great progress" was being made and even suggested a "total reset" was a possibility as the sides took their seats for the second and final scheduled day of discussions in Geneva.

Beijing has yet to comment directly, but its official news agency took a tough approach, saying China will "firmly reject any proposal that compromises core principles or undermines the broader

cause of global equity".

Still, Trump wrote Sunday on social media that "great progress" was being made.

He gave no further details, and officials at the White House also offered little information during and after the opening day of dis-

cussions. Two officials speaking to The Associated Press on condition of anonymity because of the sensitivity of the matter confirmed that the talks had resumed on Sunday

morning.

The discussions could help stabilise world markets roiled by the US-China standoff that has ships in port with goods from China unwilling to unload until they get final word on tariffs. The discussions have been shrouded in secrecy, and neither side made comments to reporters as they left Saturday.

In its editorial, Xinhua said, "Talks should never be a pretext for continued coercion or extortion, and China will firmly reject any proposal that compromises core principles or undermines the broader cause of global equity."

Several convoys of black vehicles have been seen coming and going from the residence of the Swiss ambassador to the UN delegation in Geneva, which hosted the

talks aimed at de-escalating trade tensions between the world's two biggest economies.

Trump last month raised US tariffs on China to a combined 145%, and China retaliated by hitting American imports with a 125% levy. Tariffs that high essentially amount to the countries' boycotting each other's products, disrupting trade that last year topped USD 660 billion.

Even before talks got underway, Trump suggested Friday that the US could lower its tariffs on China, saying in a Truth Social post that "80% Tariff seems right! Up to Scott!" — referring to lead negotiator and Treasury Secretary Scott Bessent.

The talks mark the first time the sides have met face-to-face to discuss the issues. And though prospects for a breakthrough are slight, even a small drop in tariffs, particularly if taken simultaneously, would help restore some confidence. (AP)

Bangladesh's interim government bans deposed PM Sheikh Hasina's Awami League

DHAKA/NEW DELHI, May 11: Bangladesh's interim government led by Muhammad Yunus on Saturday evening banned deposed prime minister Sheikh Hasina's Awami League under an anti-terrorism law.

The announcement to ban Hasina's Awami League came after the student-led newly-floated National Citizen Party (NCP) activists rallied since Thursday and carried out blockades across Dhaka demanding the ban. "The official gazette notification will be issued in this regard on the next working day," Yunus's office said, describing it as a "statement of the Council of Advisers" or the Cabinet.

The statement said the Council decided that the ban would remain effective until the completion of the "trial of the Awami League and its leaders in Bangladesh's International Crimes Tribunal in the interest of protecting the country's security and sovereignty".

It said the decision was also taken for the security of the leaders and activists of the July 2024 uprising that eventually led to the ousting of the Awami League regime alongside the complainants and witnesses of the trial in the International Crimes Tribunal (ICT).

The meeting chaired by Yunus simultaneously

The meeting chaired by Yunus simultaneously amended the ICT law allowing the tribunal to try any

political party, its front organisations and affiliated bodies.

Hasina's 16-year-long Awami League regime was toppled on August 5 last year in a student-led violent mass uprising prompting the 77-year-old former prime minister to flee to India.

Three days after her ouster, Yunus took charge as

the chief adviser of the interim government.

Hasina and many of her party leaders have been facing 100s of cases, including that of mass murder and corruption, since then. Most of her party leaders and ministers in her government are either arrested or fled abroad.

(SAD), which led the last year's movement that ousted Hasina, crystalised as the National Citizen Party (NCP) earlier this year.

The announcement to ban Awami League came as Bangladesh on Saturday witnessed an escalating tension as NCP supporters marched towards Yunus's official residence to mount pressure for the ban. (AP)

Israel's blockade means Gaza's hospitals cannot provide food to recovering patients

KHAN YOUNIS (Gaza Strip),

May 11: It cost a fortune, she said, but Asmaa Fayez managed to buy a few zucchinis in a Gaza market. She cooked them with rice and brought it to her 4-year-old son, who has been in the hospital for the past week. The soup was his only meal of the day, and he asked for more

"It's all finished, darling," Fayez replied softly. Still, it was an improvement from the canned beans and tuna she brings on other days, she said.

Hospital patients are among the most vulnerable as Palestinians across Gaza struggle to feed themselves, with Israel's blockade on food and other supplies entering the territory now in its third month.

With hospitals unable to provide

food, families must bring whatever they can find for loved ones. "Most, if not all, wounded patients have lost weight, especially in the past two months," Dr. Khaled Alserr, a general surgeon at

Nasser Hospital in the southern

city of Khan Younis, told The As-

sociated Press. Nutritional supple-

ments for intensive care unit patients are lacking, he said. "Our hands are tied when it

comes to making the best choice

for patients. Choices are limited,"

he said.

Hunger worsens as supplies dwindle

Malnutrition is on the rise across Gaza, aid groups say. Thousands of children have been found with acute malnutrition in the past

month, but adults as well are not

getting proper nutrients, according

to the U.N. It estimates that 16,000

pregnant women and new mothers

this year face acute malnutrition.
Since Israel's blockade began on
March 2, food sources have been
drying up. Aid groups have
stopped food distribution. Bakeries
have closed. Charity kitchens
handing out bowls of pasta or
lentils remain the last lifeline for
most of the population, but they

are rapidly closing for lack of supplies, the U.N. says.

Markets are empty of almost everything but canned goods and small amounts of vegetables, and prices have been rising. Local pro-



duction of vegetables has plummeted because Israeli forces have damaged 80% of Gaza's farmlands, the U.N. says, and much of the rest is inaccessible inside newly declared military zones.

Fayez's son, Ali al-Dbary, was admitted to Nasser Hospital because of a blocked intestine, suffering from severe cramps and unable to use the bathroom. Fayez believes it's because he has been eating little but canned goods. She splurged on the zucchini, which now costs around USD 10 a kilo-

gram (2.2 pounds). Before the war it was less than a dollar.

Doctors said the hospital doesn't have a functioning scanner to diagnose her son and decide whether he needs surgery.

Israel says it imposed the blockade and resumed its military campaign in March to pressure Hamas to release its remaining hostages and disarm.

Hamas ignited the war with its Oct. 7, 2023, attack on Israel, in which militants killed some 1,200 people, mostly civilians, and took

251 hostage, most of whom have been released in ceasefire agreements or other deals. Israel's offensive has killed over 52,000 Palestinians, mostly women and children, according to Gaza's Health Ministry, which does not say how many of the dead were civilians or combatants.

Concern over Israeli plans to control aid

Israeli officials have asserted that enough food entered Gaza during a two-month ceasefire earlier this year. Rights groups have disputed that and called the blockade a "starvation tactic" and a potential war crime.

Now Israeli plans to control aid distribution in Gaza, using private contractors to distribute supplies. The U.N. and aid groups have rejected the idea, saying it could restrict who is eligible to give and receive aid and could force large numbers of Palestinians to move — which would violate international law.

Those under care at hospitals, and their families who scrounge to feed them, would face further chal-

lenges under Israel's proposal. Moving to reach aid could be out of the question.

Another patient at Nasser Hospital, 19-year-old Asmaa Faraj, had shrapnel in her chest from an airstrike that hit close to her tent and a nearby charity kitchen in camps for displaced people outside Khan Younis.

When the AP visited, the only food she had was a small bag of dates, a date cookie and some water bottles. Her sister brought her some pickles.

"People used to bring fruits as a

gift when they visited sick people in hospitals," said the sister, Salwa Faraj. "Today, we have bottles of water."

She said her sister needs protein, fruits and vegetables but none are available.

Mohammed al-Bursh managed to find a few cans of tuna and beans to bring for his 30-year-old son, Sobhi, who was wounded in an airstrike three months ago. Sobhi's left foot was amputated, and he has two shattered vertebrae in his neck. (AP)

MLA stresses strengthening govt school enrolment in Lower Subansiri

NAMSAI, May 11: In a concerted move to revamp the educational landscape of Lower Subansiri district, MLA of Ziro-Hapoli, Er Hage Appa, chaired a high-level meeting on Saturday, May 10, 2025, at the District Secretariat Building, Ziro.

The meeting, aimed at addressing the pressing issue of low enrolment rates in government schools, brought together key stakeholders from the education sector, including school management committees (SMCs), education officials, and civil society representatives.

According to an official statement issued following the meeting, the MLA expressed deep concern over the declining enrolment figures and the deteriorating state of government-run educational institutions in the district.

He underscored the urgent need for systemic reforms to improve student intake and the overall quality of education.

While acknowledging the challenges, Er Appa also lauded the efforts of the School Management Committee of N G Government Secondary School, Tajang Village, which has reportedly made notable progress in boosting student enrol-

He called on the committee to share its successful model with other schools in the district, suggesting that replicable strategies at the grassroots level could significantly impact enrolment figures.

The MLA emphasised the importance of empowering local SMCs, advocating for their creation in areas with minimal administrative

He highlighted that direct engagement between SMCs, parents, teachers, and students is crucial for effective monitoring and accountability in government schools.

Further, he assured attendees that there would be no political interference from his side in the transfer and posting of teachers, entrusting the responsibility of rationalizing staff distribution to the Education Department and SMCs.

Deputy Commissioner of Lower Subansiri, Vivek H P (IAS), also addressed the gathering and urged introspection among stakeholders.

He questioned why private school teachers remain highly motivated despite often earning lower salaries than their government counterparts.

Stressing the role of leadership in schools, he said, "Every student deserves a clean and conducive environment for learning, and it is the responsibility of headmasters and principals to ensure the upkeep of their institutions.'

Calling schools the "building blocks of our civilized society," the DC encouraged teachers and administrators to remain committed even to challenging students.

He proposed a multi-pronged and multi-dimensional approach to improve the district's 18 proposed government schools, emphasising better infrastructure, increased en-

rolment, and enhanced academic standards. District Academic Education Officer (DAEO), Shri Rubu Buker, provided a detailed account of the enrolment initiative undertaken at N G Government Secondary School, Tajang.

He revealed that a 12-member task force was constituted, with each member assigned to bring in at least five students.

The effort, he said, was bolstered by collaboration with the Tajang Welfare Council, which has been instrumental in offering free books, transportation, and coaching for students who require additional academic support.

Adding to the discourse, Tage Opo, Block Resource Centre Coordinator (BRCC), highlighted a significant structural reform underway

He said that the number of government schools had been reduced from 76 to 25 during the 2024-25 academic session, with plans to further consolidate to 18 schools in the 2025-26 session.

The strategy, he explained, is intended to facilitate effective monitoring, teacher rationalisation, and quality education delivery.

"Consolidation will allow us to focus our resources and improve learning outcomes," said Opo.

He also stressed the necessity of providing qualified teachers and improved infrastructure to regain the trust of students and parents in pub-

From the civil society front, Pura Nado, President of the Apatani Students Union, voiced the need for stricter oversight not just on students, but on teachers as well.

"Earlier, students were disciplined in schools. Now, the time has come to discipline irregular teachers," he stated.

Drawing a comparison between private and government schools, Nado noted that private institutions are more adept at marketing their facilities and results through social media and suggested that government schools adopt similar promo-

He also proposed the organisation of inter-school co-curricular activities such as literary meets and sports tournaments to foster a spirit of healthy competition among stu-

In a significant resolution proposed by MLA Hage Appa and agreed upon unanimously by those present, the meeting concluded with decision to entrust SMCs, Zilla Parishad Members (ZPMs), and apex village bodies with the responsibility of improving both enrolment and educational standards in their respective areas.

The meeting also saw participation from several prominent community representatives, including Tage Rita, Secretary of the Apatani Women Association Ziro (AWAZ). and Hage Komo, Secretary of Tanii Supun Dukun (TSD), among others, who shared their perspectives and committed to supporting the district's education mission.

In recognition of their bravery, the people of Bomjir reportedly gifted symbolic items to the Gobuk warriors—'Sisuk Rebung' (horn) to Jantang Kombo, 'Ngiding' (spear) to Pikor Siboh, and 'Benjak Rebung' (buffalo horn) to Kipom

These heirlooms are still preserved by their descendants today.

The inauguration of the Mipang Migang Mikmo memorial not only honours the sacrifices made over a century ago but also aims to instill a sense of pride and historical consciousness among future generations, bridging Arunachal Pradesh's vibrant tribal history with India's broader narrative of resistance and independence.

BrahMos a message of our armed forces' strength, says Rajnath

LUCKNOW, May 11: BrahMos is not just a weapon but a "message of strength" of India's armed forces, Defence Minister Rajnath Singh said on Sunday at the inauguration of the largest integration and testing facility of the supersonic cruise missile system.

"India is now one of the most powerful nations in the world. We are constantly increasing our strength, and I believe that the facility centre that is being inaugurated today will help in further strengthening India's power," he said while virtually addressing the event from Delhi

"BrahMos is one of the world's fastest, supersonic cruise missiles. BrahMos is not just a weapon, but it is a message in itself. A message of the strength of our armed forces. A message of our deterrence towards the enemy. A message of our commitment to safeguarding our borders," Singh said.

The country's largest BrahMos integration and testing facility centre in Lucknow will strengthen India's efforts towards self-reliance in the defence sector, the Defence Minister said, addressing the inaugural ceremony at the Uttar Pradesh Defence Industrial Corridor in his Lok Sabha constituency.

"A good thing is that in this defence corridor, we are seeing very important participation of both public and private sectors," he

On the private sector, he noted that PTC Industries Limited is starting Titanium and super-alloy material plants. "Apart from this, the foundation of seven additional critical projects is also being laid. This will certainly accelerate the pace of India's self-reliance in the defence sector," the defence minister said. Major investments have been made in aircraft manufacturing, UAVs, drones, ammunition, composite and critical materials. small arms, textiles and parachutes, he said.

"When our government moved

forward with the vision of a defence corridor in Uttar Pradesh... one of our objectives was that we should once again develop Uttar Pradesh as the production centre of the country.

"The UP Defence corridor passes through Lucknow, Kanpur, Jhansi, Chitrakoot, Agra and Aligarh, and all these nodes will emerge as new centres of development in the coming times," Singh said. He expressed happiness that the project was completed in just 40 months.

"Looking at the circumstances around us today, it becomes very important that we continue to fulfil our goals in such a timely manner,' Singh said and congratulated the DRDO, engineers and people and institutes associated with this proj-

Singh said the inauguration of the BrahMos facility assumes importance as it took place on Naional Technology Day.

Completed in three-and-a-half years, the BrahMos production unit in Lucknow is spread over 80 hectares of land provided free of cost by the Uttar Pradesh government, the state government had said in the statement.

The UP Defence Industrial Corridor, announced by Prime Minister Narendra Modi in 2018, has six nodes --- Lucknow, Kanpur, Aligarh, Agra, Jhansi, and Chitrakoot where major investments are being made to boost defence man-

Ask Pakistanis about strength of BrahMos missile: Adityanath

LUCKNOW, May 11: Uttar Pradesh Chief Minister Yogi Adityanath on Sunday said a glimpse of the valour of the Brah-Mos missile was seen during Operation Sindoor and if that was not enough, one should ask Pakistanis about it. He also said the time has come to deal a crushing blow to terrorism and to achieve it, the entire country has to unite under Prime Minister Narendra Modi's leader-

Speaking at the inauguration ceremony of the BrahMos Aerospace Integration and Testing Facility here, Adityanath said, "What is the BrahMos missile? You have seen a glimpse of the valour of the BrahMos missile during Operation Sindoor. And if the glimpse was not visible, then ask Pakistanis about the strength of the missile."

Adityanath said Prime Minister Narendra Modi has declared that any incident of terror will be considered as a war. "Until we completely crush terrorism, there will be no solution to this problem. The time has come to crush it and for this, entire India, in one voice, has to unite under Modi's leadership." he added. The Bharatiya Janata Party (BJP) leader said terrorism is a "dog's tail" that can never be straightened. "Terrorism will not follow the language of love. We have to give a reply to it in its own language. And in this direction, India has given a message to the world through Operation Sindoor," he said. Adityanath congratulated Modi. Defence Minister Rajnath Singh and the armed forces' personnel for the success of Operation Sindoor. "It is necessary for any self-reliant country to achieve its goals on its own, instead of depending on other countries for its defence supplies. Israel is an example of this. It has achieved the goal of self-reliance in the field of security. It has forced its neighbouring enemy countries to face tough times," he said. The chief minister said the Defence Manufacturing Corridor and the Brah-Mos missile are part of the target set for the country by Modi in 2014. He said in 2018, the prime minister had announced two defence corridors in the Union Budget. "After the government was formed again at the Centre in 2019, Rajnath Singh, as the defence minister, organised the Defence Expo in Lucknow for the first time in 2020. He had also announced then that a production unit of BrahMos missiles will be set up in Lucknow,' Adityanath said. districts as precautionary measure CHANDIGARH, May 11: Punjab reimposed blackout measures in several districts as a precautionary measure after withdrawing it earlier on Saturday. Blackout measures have been imposed in many districts including Hoshiarpur, Ferozepur, Fazilka, Pathankot, Patiala, Moga, Kapurthala, and Muktsar districts. The development came after Pakistan violated the bilat-

eral understanding reached this afternoon to immediately stop all firings and military actions on land, air and sea. The district authorities in Punjab earlier withdrew blackout measures and restrictive orders after India and Pakistan agreed to an immediate ceasefire following four days of intense crossborder drone and missile strikes that brought the two countries teetering on the edge of full scale war. Amritsar Deputy Commissioner Sakshi Sahwney said, "Since there are reports of ceasefire violation, we will remain on alert today.

"We will observe a blackout if and when needed. I advise all kindly be prepared for enforcement of blackout if the need arises and be at home. Please do not indulge in bursting of firecrackers. We have done this drill several times, so please do not panic. This is by way of abundant caution."

The Hoshiarpur district administration said that blackout was imposed at 8:50 pm and an air raid siren was sounded. "Lights off as a measure of abundant precaution. Please cooperate," said a message shared by the district authorities.

In Ferozepur, the district authorities clamped the blackout at 8:40 pm, urging citizens to switch off lights. "Do not need to panic," said a message shared by the administration. The blackout continued till 10:30 pm. An official in Fazilka said the blackout was enforced at 9:30 pm, while it has been clamped in Rupnagar from 9:30 pm to 5:30 am.

The Ludhiana district administration said, "In view of the change in circumstances, all members of the public are requested to stay indoors and must go for voluntary blackout wherever is possible." There is no major cause of concern but voluntary blackout must be ensured as a matter of abun-



dant precaution, said the Ludhiana deputy commissioner. The Sangrur district administration also announced a blackout from 9:10 pm to 11 pm.

In a late night media briefing on Saturday, Foreign Secretary Vikram Misri called upon Pakistan to take appropriate steps to address these violations and deal with the situation with "seriousness and responsibility".

The armed forces have been given instructions to deal strongly with any instances of repetition of the violations of the border along the International Border as well as the Line of Control (LoC) in Jammu and Kashmir, he said.

"For the last few hours, there have been repeated violations of the understanding arrived at earlier this evening between the Directors General of Military Operations of India and Pakistan," he said. "This is a breach of the understanding arrived at earlier today," Misri said.

The directors general of military operations (DGMO) of India and Pakistan agreed to stop all firings and military action on land, air and sea with effect from 5 pm on Saturday, Foreign Secretary Vikram Misri announced in Delhi.

The ceasefire came hours after the militaries of India and Pakistan attacked each other's facilities, dangerously escalating the standoff. Following the announcement of ceasefire, markets and shops, which earlier remained closed at places including Pathankot and Kapurthala, reopened.

Earlier in the day, debris of unidentified projectiles was found in Beas in Amritsar, Jalandhar, Pathankot and Dubli village in Tarn Taran districts.

In Gurdaspur's village Rajubela Chhichhran, residents said a crater -- around 35 feet wide and 15 feet deep -- was formed following a loud blast in the early hours of Saturday.

A police official said no one was hurt in the incident. However, there was damage to electrical wires in the incident. After learning about the crater in the field, many curious villagers, including youngsters, reached the site and

started clicking pictures on their mobile phones. In Phagwara, an unidentified object fell in a field between Khalyan and Sahni villages in the Phagwara district early Saturday, officials said. Locals said an explosion-like sound was heard around 2.40 am from the fields at the Khalyan village towards Sahni. The impact of the unidentified object created a crater about 7-8 feet deep and 12-14 feet wide in the field, the officials said.

Authorities asked people not to touch any part of any unidentified projectile lying on the ground and to inform the local police about it.

Pathankot went gone into an alert mode after explosionlike sounds were heard in the border district early morning, with the local authorities ordering closure of markets in the region as a precautionary measure.

After a night of bristling tension, people woke up to explosion-like sounds in Pathankot and Jalandhar districts, while air sirens rang out in Hoshiarpur, Amritsar and Ferozepur amid a sharp upturn in the military conflict between India and Pakistan. Punjab shares a 553-km-long border with



court on Saturday.

Meghalaya to launch statewide survey on drug abuse



SHILLONG, May 11: Meghalaya Minister in-charge Social Welfare Paul Lyngdoh recently announced that the state government will soon launch a statewide survey on drug abuse to identify areas based on their vulnerability factor.

Addressing media persons, Lyngdoh said the survey, which will be a major initiative, will be conducted in collaboration with the United Nation Organization on Drugs and Crimes (UNODC).

This will help us update information and also identify areas based on their vulnerability fac-

To tackle the problem of drug

trafficking in the state, the minister also informed that the government is in the process of procuring two vehicles, which will be tasked with narcotics scanning, one of which is already on its way. "We expect with the constant intervention of the DGP, this should materialise soon," he said.

He added, "In regards to the Sniffer dogs, I am happy to share with you that they are currently being trained. It will take another six months before completing the

training of the sniffer dogs." On the joint VDP training and coordination initiative, Lyngdoh said that few dorbar shnongs have already come forward and applied for being recognized as VDPs.

"In Shillong until DREAM came into being, there were only 11 VDPs and now we expect this number to go up at least double the current number as we have been having regular interaction and consultative meetings with the dorbar

He further informed, "In the Cantonment area, which has always been seen as something which is off the radar beyond the reach of the state government, I am happy to share with you that the CEO of the Cantonment Board is now partnering with the dorbar shnong of areas within the cantonment board. In Jhalupara for instance, a major point where there is also a large concentration of migrant population, CCTVs will be

TYCM urges revision of budgetary allocation



IMPHAL, May 11: The Tribal Youth Council Manipur (TYCM) has urged the Executive Committee of the 5th State Level Shirui Lily Festival 2025 and the concerned authorities to revise the approved budget allocation and incorporate provisions for the promotion of local entrepreneurs, farmers, indigenous products, and disability-inclusive events.

This is to ensure the meaningful participation of persons with disabilities and to facilitate the immediate construction of essential additional infrastructure at Shirui Lily peak", it also stated.

The 1st Executive Committee meeting of the 5th State Level Shirui Lily Festival 2025, held last month under the chairmanship of Prashant Kumar Singh, Chief Secretary, Government of Manipur, approved a budget allocation of ₹ 6.30 crore for various Shirui Lily Festival-related activities.

While the State Government organizes the Shirui Lily Festival annually with substantial investment, the TYCM said it "believes that this festival is not merely for entertainment purposes—it should also serve as a catalyst for socio-economic development and promoting local entrepreneurship and ecotourism, especially for the residents of the hill areas". The TYCM also said it is a valuable platform for promoting local entrepreneurs, youth initiatives, and indigenous farmers.

Upon thoroughly reviewing the approved budget, the TYCM said it observed with concern that no provisions have been made to promote local entrepreneurship or to ensure inclusion of persons with disabilities.

Additionally, the current state of infrastructure from Shirui village to Shirui peak is inadequate and requires urgent attention, the TYCM also said. The trail from the village to the peak is approximately 1.5 km. At present, there is only one rest house, a water tank, and two public toilets at the peak. However, there are no public toilets or rest houses along the route, and the existing stair guard/pathway is in a dilapidated condition, the TYCM

Furthermore, according to the TYCM, the current infrastructural facilities along the route from

Shirui village to Shirui peak are grossly inadequate to accommodate the increasing number of visitors and participants.

Upon a thorough examination of the approved budget allocation for the 5th State Level Shirui Lily Festival 2025, the Tribal Youth Council Manipur (TYCM) has identified certain event items that appear to be over budgeted or unjustified, and therefore require revision and reduction.

The TYCM then said that the Shirui Lily Festival is a government-organized and governmentfinanced event, and not managed or funded by any private firm or NGO. The State Government has a fully functional Transport Department with its own fleet of buses. Therefore, the allocation of ₹ 5.25 lakhs for public transportation between Imphal and Ukhrul is unnecessary, the YCM also said. Such logistical arrangements should be the responsibility of the Transport Department without requiring additional expenditure.

Furthermore, the Government of Manipur has its own Police Department and Traffic Police personnel, who are regular salaried public servants. Their mandated duties include maintaining law and order and managing traffic during public events. Hence, the allocation of an additional ₹ 16 lakhs for security and traffic management is also deemed unnecessary, the TYCM stated.

The State Government has approved budget allocations for certain items that are unnecessary, instead of prioritizing genuine and essential components for the Shirui Lily Festival 2025, it added.

Langdang village, being a crucial gateway to Shirui peak and other tourist spots, plays a vital role in the festival's success. The TYCM urged the State Government and the festival organizers to revisit the planning process and include Langdang village in the budgetary allocations. This would not only benefit the local community but also enhance the overall

Specifically, the TYCM recommended considering Phangrei (zero point) for festival-related development and providing support for roadside shops, temporary amenities, and other facilities within Langdang village's jurisdic-

festival experience.

The TYCM then appealed to the authorities to mend differences and work towards a more inclusive celebration that reflects the spirit of unity and cooperation. By doing so, we can ensure the 5th State Level Shirui Lily Festival is a grand success, benefiting all stakeholders involved. (NNN)

Meghalaya to adopt Miyawaki Forest method SHILLONG, May 11: Meghalaya is taking a big step forward in protecting the environment

by using the Miyawaki Forest method – a fast and effective way of growing dense, native forests. This method was developed in Japan by botanist Akira Miyawaki and is now being used across the state as part of a major afforestation project led by the Soil and Water Conservation Department, Government of Meghalava Chief Minister Conrad K.

Sangma has played a key role in pushing for environmental conservation. He has raised serious concerns about deforestation across the state and has been working to restore green cover through various programs. To support this effort, the state has initiated

different interventions including Green Meghalaya and has partnered with different organizations to promote conservation and afforestation programmes. The state government is also providing financial incentives through the Payment for Ecosystem Services (PES) for conservation of forest cover.

On Thursday, the Chief Minister visited a Miyawaki Forest site at Mawsharoh, Ummir in East Khasi Hills, where the method is being used to grow a forest on a 1.5-hectare area. Currently, similar projects are being implemented on a total of 25,000 hectares throughout Meghalaya.

Officials from the Soil and Water Conservation Department shared how the Miyawaki method is helping to restore the ecosystem. The method involves planting native trees close together in layers, which leads to rapid



growth of dense, self-sustaining forests. These state as one of our main afforestation drives, forests grow faster than traditional plantations and require less maintenance over time.

The project is being carried out with strong support from local communities, who are actively involved in the planting and care of these forests. The first Miyawaki forest plantation in Meghalaya began three years ago in

Garo Hills as a pilot project. "The project will be expanded across the

These mini-forests help absorb carbon dioxide, fight climate change, improve air quality, reduce noise pollution, and provide shelter for wildlife. This move marks a major step forward in expanding rail connectivity to the southern and western regions of Sikkim, it added.

The proposed route aims to bridge a vital infrastructure gap, linking remote towns like Dentam, located near the India-Nepal border at Chiwabhanjyang, with the national railway network. The new line, estimated to have

an approximate length of 75 km during the initial feasibility survey, is envisioned as a strategic extension of the under-construction Sivok-Rangpo railway line, which is expected to be operational by

Melli, a key entry point to southern and western Sikkim, is likely to serve as a junction for the proposed



less integration of the region into the national transportation system.

The final location survey will provide detailed technical and feasibility insights necessary to guide the final alignment, engineering design and cost estimation for the

project. This new connectivity project is expected to act as a catalyst for

economic growth in the region, especially in Gyalshing and surrounding areas, by enhancing access, promoting tourism, boosting trade and creating employment opportunities, the statement issued on Saturday said.

The work tenders related to the execution of the survey are expected to be floated shortly, it said.

OTPC, Assam Power Development Corp jointly developing 250 MW battery energy system

solar power through a battery energy system for using it during the peak hours or at night when solar energy generation goes


off," the official said. According to him, since the concept is new to energy players, the setting up of a 250 MW battery energy system will be implemented in a phased manner.

"The battery energy system is just like a warehouse where the power generated from


solar sources will be stored in the facility, and later it will be supplied during peak hours or at night," he explained. He said the proposed facility is the first such initiative in the northeast-

At the Thursday's game, the Punjab side was 122 for 1 in 10.1 overs when lights went out which at first was attributed to floodlight failure. The teams and the assembled fans were eventually evacuated from the stadium for their security.

Videos of Zinta asking spectators to vacate the stadium in an orderly manner also started doing rounds of the social media.

The actor, who said she was finally back home after "a crazy last few days", on Sunday thanked fans for being "absolute rock stars".

'To all the people that were in the Dharamshala stadium - Thankyou Thankyou Thankyou for not panicking & for any stampedes... I'm sorry I was a bit curt & said no to pictures with everyone but the need of the hour was the safety of everyone and it was my duty & responsibility to make sure everyone stayed safe. Thank you for making it possible," she wrote in a post

The Himachal Pradesh Cricket Association Stadium, which can house approximately 23,000 spectators, was packed to about 80 per cent of its capacity at the time of evacuation on

MELBOURNE, May 11: Bob Cowper, who scored test cricket's first triple century on Australian soil, has died at the age of 84 due to an undisclosed illness, Cricket Australia said Sunday. Cowper played 27 test matches for Australia between 1964 and 1968, with a record of 2,061 runs at an average of 46.84, including five centuries, while also taking 36 wickets with his part-time off-spin. left-hander

renowned for both his strokeplay and steadiness, particularly during his most famous innings a 12-hour, 589-ball 307 against England at the Melbourne Cricket Ground in February 1966. The innings was the only test triple century made in Australia in the 20th century, and just the 10th ever scored at that time. It came after he was recalled on his home ground, having been 12th man in the previous test in Adelaide. Cowper was a force on home soil and his batting average of 75.78 runs in Australia remains the second-highest of all time behind only Donald Bradman. He retired in 1968 and became a stockbroker. COLOMBO, May 11: India displayed absolute dominance to crush Sri Lanka by 97 runs and earn a well-deserved title triumph in the Women's Tri-Nation ODI series after vice-captain Smriti Mandhana's sublime century and the bowlers' collective effort in the title clash here on Sunday.

After Mandhana rose to the occasion to power India to a commanding 342 for seven, the bowlers completed the task by bundling out Sri Lanka for 245, with Sneh Rana (4/38) and Amanjot Kaur (3/54) doing the bulk of the damage.

Skipper Chamari Athapaththu (51 off 66 balls) and Nilakshika Silva (48 off 58) were the chief

contributors for the hosts. Earlier, battling cramps in humid conditions, elegant left-hander Mandhana, who had returned to form with a fifty in India's last match against South Africa, struck a majestic 116 off 101 balls to lay the foundation for India's imposing total after skipper Harmanpreet Kaur opted to bat. Her knock was laced with 15 fours and two sixes, including four successive boundaries off Athapaththu to bring up her 11th ODI hundred in style.

Deepika, Salunkhe win bronze as India finish with 7 medals at Archery World Cup Stage 2

SHANGHAI, May 11: India's most decorated archer, Deepika Kumari, salvaged her pride with a hard-earned bronze medal after a semifinal heartbreak, while Parth Salunkhe also finished on the podium for the first time as India wrapped up their campaign at the Archery World Cup Stage 2 with seven medals, here

A day after compound archers put up a dominating show with five medals, Deepika and Salunkhe added two more from the recurve section to end India's campaign on a high.

Exactly a year after the 21-year-old reigning Olympic champion Lim Sihyeon had knocked Deepika out at the same stage of the Yecheon World Cup, the Indian was undone again by the Korean in the semifinal, losing 1-7 in a largely one-sided women's recurve individual contest.

The 30-year-old four-time Olympian, though, bounced back strongly to defeat another Korean, Kang Chae Young, 7-3 in the bronze medal playoff and return with a consolation podium finish. Deepika's win took India's overall medal tally to six at the event, with five coming from the compound section on Saturday that included a remarkable triple-medal haul by comeback archer Madhura Dhamangankar.

In the bronze medal playoff, Deepika showed greater composure and tactical clarity than her defeat to Lim in the semis

The opening set ended in a 27-all tie, but Deepika edged ahead with a solid 28 in the second to take a 3-1 lead. Kang, a former world champion who had beaten Deepika in the Berlin World Cup quarterfinals back in 2017, fought back in the third, scoring a flawless 30 to Deepika's 27 to make it three-all.

The Indian responded with her best shooting under pressure, firing three perfect arrows for 30 in the fourth set to again take a 5-3 lead. Needing just a draw in the final set to secure

victory, Deepika delivered once more, shooting 29 to Kang's 28, to bag the bronze. Earlier, Deepika began nervously in the semifinal, losing the first set 26-27 despite hitting 28, but Lim held steady to force a split and deny Deepika any rhythm. The world No. 1 then shifted into top gear, drilling in a perfect 30 in the third set while Deepika managed 28. With momentum fully on her side, Lim wrapped up the match in the fourth with a 29, as Deepika managed a 28. It was a repeat of their 2023 clash, though Deepika had managed to take two set points back then.

In the men's section, 21-year-old Salunkhe, who qualified lowly at 60th place, impressed with his resilience after a 1-7 loss to top seed and Korean legend Kim Woojin in the semifinals. After taking just one point off multiple Olympic medallist and reigning champion Woojin in his semifinal loss, Salunkhe bounced back impressively to beat higher-seeded French archer Baptiste Addis 6-4 in a tense five-settter to earn his maiden World Cup medal.

not board the flight from the national capital on
