GUWAHATI, May 30: Alert for very heavy rainfall and gusty wind was issued for several districts of Assam on Friday as incessant downpour lashed most parts of the state, including largest city Guwahati which was also hit by massive waterlogging in almost all locali-

Himanta reviews flood preparedness



HT Bureau GUWAHATI, May 30: Chief

Minister Himanta Biswa Sarma on Friday held a review meeting via with the State's ministers, MPs, MLAs and DCs to take stock of the state's readiness in responding to the impending flood season.

The said review meeting was held via video conferencing at Lok Sewa Bhawan.

In the meeting, addressing the Deputy Commissioners (DCs), Sarma recalled that Assam had witnessed three waves of floods from the first week of June last year, adding, "In anticipation of similar challenges this year, the state government has proactively initiated a series of preparatory measures, including the advance release of budgetary allocations to districts likely to be impacted".

The chief minister further highlighted the recent creation of codistricts and stated that additional human resources have been deployed to strengthen the administrative machinery in affected areas.

He also directed DCs to ensure that immediate relief is extended to all flood-affected individuals in the event of embankment breaches. Further, he underscored the importance of timely communication from villagers regarding potential breaches, and instructed relevant departments to respond swiftly by deploying geo-bags and other necessary materials to fortify vulnera-

ble embankments. Sarma further urged DCs to hold meetings with the Water Resources Department to coordinate the distribution of relief materials. Additionally, he stressed the dual importance of not only delivering aid but also ensuring the structural integrity of embankments through vigilant upkeep and reinforcement.

"Every embankment breach would be subject to a thorough inquiry to ascertain the causes and prevent recurrence in the future,' he added. He emphasised the need for ad-

vance provisioning of clean drinking water, essential food supplies, cattle fodder and other relief essentials so that assistance may be renimmediately flood-impacted communities.

"During this critical period, all DCs need to maintain close coordination with the chief secretary and the principal secretary of the Revenue Department," the chief minister directed.

Sarma further deliberated on the implementation of a new welfare scheme - 'Eti Koli Duti Paat'. launched as part of the bicentenary celebration of Assam's tea industry. It may be noted that under this initiative, a one-time financial assistance of Rs 5.000 would be extended to all permanent and temporary workers, as well as employees of registered tea estates across the state.

Based on data provided by tea garden authorities, the scheme is set to benefit 3,82,660 permanent workers, (CONTD. ON PAGE-2)

Polls to 2 Assam RS seats on June 19



NEW DELHI, May 30: Elections for eight Rajya Sabha seats -- two in Assam and six in Tamil Nadu -- will be held on June 19, the poll panel announced.

The two Raiva Sabha seats in Assam and the six in Tamil Nadu will fall vacant in June and July, respectively The BJP-led NDA which has

84 seats in the 126-member Assam Assembly will look to retain both the Rajya Sabha seats being vacated by Birendra Prasad Baishya of the Asom Gana Parishad and Mission Ranjan Das of the BJP.

In Tamil Nadu, the ruling DMK-led alliance appears set to win four of the six seats falling vacant, while the AIADMK and its alliance partner PMK will seek to retain the two seats they

currently hold.

The terms of six members from Tamil Nadu -- Anbumani Ramadoss (PMK), N Chandrasegharan (AIADMK), Mohamed Abdulla (DMK), M Shanmugam (DMK), P Wilson (DMK) and Vaiko (MDMK) -will end on July 24.

The elections are unlikely to make any difference in the political equations in the Rajya Sabha.

The notification for the Rajya Sabha elections will be issued on June 2, the Election Commission said and the counting of votes will take place on the same day.

The last date for filing nomination papers is scheduled for June 9. The results could be declared the same day if the number (CONTD. ON PAGE-2)

In almost all countries in the world, the number of extreme heat days has at least doubled compared with a world without climate change.

Caribbean islands were among the hardest hit by additional extreme heat days.

WASHINGTON, May 30: Scientists say Puerto Rico, a territory of the United States, endured 161 days of extreme heat. Without climate change, only 48 would have oc-

"It makes it feel impossible to be outside," said Charlotte Gossett Navarro, chief director for Puerto Rico at Hispanic Federation, a nonprofit focused on social and environmental issues in Latino communities. who lives in the San Juan area and was not involved in the report.

"Even something as simple as trying to have a day outdoors with family, we weren't able to do it because the heat was too high,' she said, reporting feeling dizzy and sick

When the power goes out, which happens frequently in Puerto Rico in part because of decades of neglected grid maintenance and damage from Hurricane Maria in 2017, Navarro said it is difficult to sleep. "If you are someone relatively healthy, that is uncomfortable, it's hard to sleep ... but if you are someone who has a health condition, now your life is at risk," Gossett Navarro

Heat waves are silent killers, said Friederike Otto, associate professor of cli-



mate science at Imperial College London, one of the report's authors. "People don't fall dead on the street in a heat wave ... people either die in hospitals or in poorly insulated homes and therefore are just not seen,"

Low-income communities and vulnerable populations, such as older adults and people with medical conditions, suffer the most from extreme heat.

The high temperatures recorded in the extreme heat events that occurred in Central Asia in March, South Sudan in February and in the Mediterranean last July would have not been possible without climate change, according to the report.

At least 21 people died in Morocco after temperatures hit 48 degrees Celsius last July. People are noticing temperatures are getting hotter but don't always know it is


being driven by climate change, said Roop Singh, head of urban and attribution at the Red Cross Red Crescent Climate Centre, in a World Weather Attribution statement.

"We need to quickly scale our responses to heat through better early warning systems, heat action plans, and long-term planning for heat in urban areas to meet the rising challenge," Singh said.

City-led initiatives to tackle extreme heat are becoming popular in parts of South Asia, North America, Europe and Australia to coordinate resources across governments and other agencies. One example is a treeplanting initiative launched in Marseille,

France, to create more shaded areas. The report says strategies to prepare for heat waves include monitoring and reporting systems for extreme temperatures, providing emergency health services, cooling shelters, updated building codes, enforcing heat safety rules at work, and designing

cities to be more heat-resilient. But without phasing out fossil fuels, heat waves will continue becoming more severe and frequent and protective measures against the heat will lose their effectiveness, the scientists said. (AP)



waterlogging in almost all localities of the city. Areas such as Panjabari, Six Mile, Rukminigaon, Hatigaon, Anil Nagar, Tarun Nagar, Chandmari, were under water, with the level reaching up to waist level in many places. People were seen using inflatable rafts to commute in parts of the city as students, officer-goers and others waded through the waters to reach their destinations.

Several educational institutions closed early, though students remained stranded on roads for hours due to

GUWAHATI, May 30: The Gauhati High Court has issued notice to the Assam government directing it to provide details on the whereabouts of two brothers, declared foreigners by a tribunal, and on the 'arbitrary arrest of declared foreigners who are apprehending illegal push back'.

A Division bench of Justice Kalyan Rai Surana and Justice Malasri Nandi on Thursday directed the state government to give details about the wherebrother Akbar Ali who were detained by the officials of the Nagarbera police station in Kamrup district on May 25. The court has posted the next date of

hearing on June 4. The court was hearing a writ petition filed by the duo's nephew Torap Ali who claimed that his family apprehends both his uncles 'may be in danger of being illegally pushed into

The petitioner claimed that the authorities have refused to give details of the whereabouts of the two brothers since May 25 when they were called to the police station.

My husband is Indian; we know justice will prevail: Wife of Assam man deported to Bangladesh

MORIGAON (ASSAM), May 30: For Rita Khanam. faith in God remains her final refuge as she waits anxiously for news of her husband, whom she last saw in a video ear-

The footage, reportedly shot in the 'no man's land' along the Indo-Bangladesh border in Assam's South Salmara Mankachar district, has left her distraught and searching

Speaking to PTI over the phone from her home at Khandapukhuri in Morigaon district, Khanam said her family is in touch with the authorities and has submitted documents to prove her husband Khairul Islam's Indian nationality.

She remains hopeful that "justice will prevail." Islam was among nine persons arrested by Morigaon police on May 24 in a crackdown on illegal immigrants declared by the Foreigners' Tribunal (FT), but who had been

evading deportation. Along with his three siblings, Islam was declared a foreigner by the FT in 2016, a decision he challenged in the Gauhati High Court.

The High Court upheld the FT's ruling, leading to his detention in 2018.

He was set free in 2020 following a Supreme Court general order to release all detainees who had spent more than two years in jail.

"My husband is a former school teacher and a law-abiding citizen. On May 23, personnel from Mikirbheta police station came to our house and took him away, saying they had a few questions and he could return home after that,' Khanam said.

Khanam said she had a gut feeling that the situation was more serious, as police came at a late hour.

"And the next thing we know, he was taken to Morigaon SP's office and from there, to the detention camp at Matia (in Goalpara district). And then, the video emerged where we found that he had been deported to Bangladesh," she

Islam is believed to be among 14 illegal Bangladeshi nationals who were sent back to their country by the BSF through the South Salmara Mankachar border on Tuesday.



Though a BSF officer, who refused to be identified, had confirmed deporting the persons, an official statement by the force said a "large group of Bangladeshis" had attempted to infiltrate, which was successfully thwarted by the border guards.

Khanam claimed that her husband's appeal against the FT decision is pending before the Supreme Court, though local police maintained that they had the necessary clearance for his deportation.

"In the case of Khairul Islam, we had the necessary clearance to deport him. But for his two brothers and a sister, who were also declared foreigners by the FT, we are awaiting legal formalities. Hence, we have not detained them," a local police officer told PTI.

Khanam is confident of her husband's Indian nationality, and their family members are already in touch with the authorities to present necessary documents.

"Our relatives are pursuing the matter. We know that he is an Indian and I have full faith in 'Ishwar and Allah' that he will return," she said, as she waited at their residence with her two teenaged children for Islam. (PTI)

Cracks in Trump-Musk ties

racks have begun to emerge in the Trump-Musk relationship as the latter has shown his disappointment with President Donald Trump on the recent domestic policy endorsed by the Congress. He said in a TV interview that he was "disappointed" that it would increase the federal deficit. The GOP has been constantly criticizing the previous Biden administration for increasing the budget deficit and had been going hammer and tongs with spending cuts. Now the Trump administration seems to have fallen into the same trap of deficit balloon for an entirely set of different reasons. Musk's public break comes as the Republicans' bill heads to the Senate, where several senators have also criticized the legislation for increasing the deficit. The legislative package encompasses many of Trump's priorities, and the president has urged Congress to send the bill to his desk for a signature "as soon as possible."

Secondly, it enhances coverage under the two schemes by boosting the cost by over \$1,000 which coming on top of inflation and grocery prices could end up being unacceptable to the middle-class populations. This is how its playing out: Biden pandered to the middle-class expanding Obamacare offering them discounted Medicare and Medicaid and making up the losses by taxing the rich, but trump has gone in reverse gear cutting down on expenditure on Medicare and Medicaid on specious grounds that many were falsely doctored their taxes. Biden depended on the middle class votes for his party to retain power. But Trump needs donations from the rich to sustain his election campaigns as the cases foisted against him during the Biden era, not that Biden was responsible for it, but his own doings put a big hole in his pocket also drained out the finances of the GOP which subsidized is court cases expenditure.

Taking 8 million out of the health care net has angered many. Besides the pricing of drugs, one does know, if it goes south now. While Musk was highly enthused about Trump about reducing expenditure and reduce the deficit in the budget, it's not working that way. Not only is the work he was doing in DOGE being undone by Trump with his domestic policies that was not putting in place a watertight scheme that brings in more revenue and compensates for Trumps tax cuts.

Israeli genocide in Gaza is a reminder of atrocities perpetrated by Nazis on Jews

aqeen Hammad, a 12-year-old Palestinian girl, was shredded into pieces by an Israeli missile attack on her residence. Yaqeen has been aptly called the Anne Frank of Gaza. Like Anne, who kept a diary in an attic in a Holocaust-ravaged, Nazi-occupied neighbourhood, Yaqeen documented the horrors around her. Her diaries – digital this time – became a record of the brutalities faced by her people.

Ironically, the present-day Israeli Zionists, who invoke the Holocaust to justify their moral rationale for the State of Israel and recount their suffering, are now adopting similar oppressive attitudes. Yaqeen moved from one refugee camp to another, shot videos, and posted them on Instagram, bringing global attention to the gruesome realities in Gaza. More than a media activist, she was also involved in humanitarian aid, helping thousands of hapless Palestinians in war-ravaged Gaza.

The phrase "live-streamed genocide" has gained currency – coined by Amnesty International – thanks to brave social media activists like Yaqeen. The targeting of children in Gaza is not accidental; it is the outcome of a sinister ideology that labels even innocent children as collaborators of Hamas. This notion is deeply ingrained in the hysteria whipped up by Zionist politicians. Moshe Feiglin, a close associate of the Netanyahu government, even stated emphatically: "Every baby in Gaza is an enemy." The depravity of such statements is unprecedented. Some extremists have gone so far as to support wiping out all such children as a military objective.

The latest Israeli plan reportedly involves deploying reinforced army units to capture and "clean out" Gaza's 365 square kilometres – 70 per cent of which has already been turned into "no-go zones" for Palestinians. Most of Gaza's population could be pushed to Rafah, the southernmost city, which has itself been virtually razed. Cities like Khan Younis and Deir al-Balah are now synonymous with daily destruction.

Perhaps the most disturbing element of the Israeli plan is the forced relocation of Palestinians into Israelicontrolled zones, ironically termed "humanitarian zones." There, ration packets are distributed by private security contractors tied to Israeli-vetted aid organisations. Aid has been politicised and militarized – used as a tool for coercion. This design enables a protracted occupation, with Palestinians confined to increasingly smaller areas and Israel controlling all access to necessities. Reportedly, Donald Trump even involved himself personally in setting up an aid organisation outside UN oversight to carry

out this militarised aid programme.

Netanyahu's cabinet has codenamed the military mission
"Gideon's Chariots." Whether it is truly intended to pressure Hamas into releasing hostages or simply a cover for collective punishment is clear from the scale of destruction.

However, the intensity of the military operation has forced some changes in western leadership's tone. In a joint statement, the UK, France and Canada condemned the humanitarian crisis, calling it "intolerable." They questioned the inadequacy of the food aid plan and said: "We condemn the abhorrent language recently used by Israeli government officials. Permanent forced displacement is a breach of international humanitarian law." While initially supporting Israel's right to self-defense after Hamas' October 7 attack, they now strongly oppose the expansion of military operations in Gaza. European Commission President Ursula von der Leyen stated: "Humanitarian aid must never be politicised," emphasizing that the only viable resolution is a two-State solution.

Yet, in the absence of US pressure – especially with Donald Trump's silence – it is uncertain whether Netanyahu will heed this advice.

Francesca Albanese, the UN's Special Rapporteur on human rights in the occupied Palestinian territories, was forthright: "Most member states remain inactive at best or are actively aiding and abetting Israel's criminal conduct." She referred particularly to western and some Gulf nations. She also warned that Israel risks becoming a pariah state, given its relentless assault not only on Palestinians but also on the United Nations. It is clear that this tragedy stems from the complicity - wilful or not – of nations that backed the 1948 UN plan creating Israel. The Zionist ideology of ethnic cleansing was evident from the outset. Jewish historian Ilan Pappé, whose family suffered during the Holocaust, detailed these intentions in his book The Ethnic Cleansing of Palestine, beginning with the 1948 Nakba. This design is now unfolding – with Donald Trump's grandiose plan to turn Gaza into a tourist riviera adding insult to injury.

We must understand why Israel is pursuing this hysterical campaign in Gaza post–October 7. Regardless of Hamas' military capacity, their actions challenged the myth of Israel's security invincibility. This campaign could not have proceeded without active western complicity – especially from the US. Without a civilized State-to-State relationship between Israelis and Palestinians, military might can never secure lasting peace. (IPA Service)

Will artificial floods in Guwahati be controlled?

t took just one day of rain for Guwahati to descend into Inundated roads, stranded schoolchildren, office workers marooned in knee-deep water, and tragically, lives lost-including a child. What followed was all too familiar: outrage, despair, and yet another round of public discourse condemning governmental failure and urban mismanagement. The city's recurring tryst with artificial floods is not merely a consequence of nature's fury, but a deep-rooted civic and structural failure. Guwahati, the bustling gateway to Northeast India, perched beside the mighty Brahmaputra, is paradoxically drowning in mismanagement, poor planning, and short-sighted urban-

Artificial flooding in Guwahati is not a new phenomenon. Its history dates back at least four decades. In the Kumarpara locality, older residents recall a time when boats floated along roads submerged by floodwaters, and families sought shelter elsewhere until the waters receded. Even then, locals blamed human activities—unregulated construction, encroachment, and lack of government foresight. Today the

ment foresight. Today, the Bharalu River, once an arterial waterway of the city, is now a stagnant, garbage-choked drain reflecting the city's worsening ecological decay. Despite modern technology and supposed development, the nature and severity of these floods have

only intensified. The Bharalu River, originating from the foothills of Meghalaya's Khasi Hills and called the Bahini in its upper reaches, weaves through the heart of Guwahati before draining into the Brahmaputra. Once a vital channel for stormwater drainage, it now serves as a polluted corridor, choked by solid waste and constricted by encroachments. Construction over wetlands and natural reservoirs like Deepor Beel, Borsola Beel, Saruchala Beel, and Silsako Lake has exacerbated the crisis. Buildings have sprung up on blocked drains, while reservoirs have been buried or constricted. drastically reducing the city's capacity to manage even moderate



Guwahati's topography compounds the problem. Hemmed in by hills, water descends rapidly into the city basin during rains. The hills, once natural buffers, are now losing their forest cover due to deforestation and haphazard development, reducing their ability to absorb rainfall. The result is a fast-flowing deluge of water with

nowhere to go—flooding roads, homes, and markets within an hour of sustained precipitation.

The government's response has

been a mixed bag. The "Mission Flood Free Guwahati" initiative, launched by the Assam government, was meant to address the chronic urban flooding through infrastructural upgrades and better stormwater management. Measures included desilting of drains and installing auto-priming pumps at vulnerable locations. Yet the ground reality remains grim. Reports indicate that the Guwahati Municipal Corporation (GMC) has been sluggish and inconsistent in implementing these projects. Restoration works, including the eviction of illegal encroachments around water bodies such as the Silsako Beel. have faced delays, legal hurdles, and political controversy.

d political controversy. The challenges go beyond infrastructure. The city suffers from a lack of integrated urban planning. Urban expansion has rarely factored in flood risk assessments. Roads are built without proper drainage channels, while large-scale housing projects continue to sprout on marshy land, further compromising the city's natural flood-resilience. Garbage disposal remains a chronic problem, with citizens often dumping household waste directly into drains and

waste directly into drains and rivers. This leads to massive blockages, rendering existing sewer systems ineffective. The lack of a citywide waste management system has left the Bharalu-Bahini tributary functioning as an open drain, choked with waste and unable to efficiently carry runoff to the Brahmaputra.

Even the convergence of the Bharalu and Brahmaputra rivers

Even the convergence of the Bharalu and Brahmaputra rivers poses structural limitations. The Brahmaputra has an average depth of 45 metres near Guwahati, while the Bharalu is only about 3 metres deep. This vertical drop in elevation causes a sharp decrease in water velocity, preventing smooth drainage. Some experts have suggested altering the flow direction or creating a gradient transition to improve the Bharalu's discharge capacity into the Brahmaputra.

Drawing inspiration from global

examples could offer innovative solutions. The case of San Antonio, Texas, is particularly instructive.

After devastating floods in 1921, the American city constructed a network of interconnected canals along the San Antonio River. These not only prevented future floods but evolved into the world-famous "River Walk"—a vibrant tourist attraction lined with pedestrian paths, gondola rides, and riverside cafes. A similar approach could transform Guwahati. Constructing canals that connect the Bharalu-Bahini rivers to the Brahmaputra and linking other reservoirs such as Deepor Beel, Khanajan, and Bondajan can create a dual-purpose network: a modern drainage system and a scenic urban waterway. Roads currently prone to flooding could be retrofitted into drainage canals, with overhead flyovers ensuring transportation continuity. A well-

also boosting tourism revenue.

Venice, Italy, another canalbased city, has long fascinated tourists with its waterborne charm.

While Guwahati may not emulate Venice in architectural grandeur, it can certainly adopt its hydrological wisdom. Picturesque artificial canals could redefine the city's relationship with water—from a source of destruction to a medium of beauty and utility. These canals, if maintained and marketed well, could become iconic attractions, helping recoup the initial infra-

Beyond canals, Guwahati must also adopt techniques like rainwater harvesting to increase the waterholding capacity of nearby hills and prevent instant runoff. Protecting the forest cover and implementing stringent construction norms in hilly areas is equally critical. In tandem, the drainage infrastructure beneath major roads needs to be overhauled. Many parts of the city lack underground sewer systems, while those that exist are insufficient or blocked. Constructing wider, deeper underground drains akin to those in larger metropolises could significantly improve stormwater flow.

Equally important is cross-border collaboration. Guwahati's flooding cannot be resolved in isolation. Deforestation and unregulated development in Meghalaya directly affect the city's flood levels through unchecked runoff. Coordinated flood management, afforestation drives, and integrated catchment area planning between Assam and Meghalaya are essential to curb upstream water flow and mitigate downstream impact.

While the blame game between the government and the public often dominates post-flood narratives, a shift in mindset is urgently needed. Citizens must be made aware of the impact of their actions—be it dumping garbage in drains or illegal hilltop construction. At the same time, the government must lead by example through transparency, urgency, and innovation in tackling urban floods.

The future of Guwahati need not be a story of repeated submergence. While the city may have grown without a plan, science and technology today offer the tools to build resilience. What is required is not just infrastructure, but vision. Vision to reimagine the city's water management system, draw inspiration from global success stories, and implement context-specific solutions rooted in sustainability. Guwahati's water woes are not insurmountable. But without decisive action, bold planning, and community cooperation, the monsoon will continue to be a season of fear, not

China-Pakistan Alliance: A Strategic Challenge for India

hina's strategic relationship with Pakistan is a multifaceted and deeply calculated partnership that extends far beyond merely countering India's influence in South Asia. According to former Indian Foreign Secretary Vijay Gokhale, China's engagement with Pakistan is driven by a combination of military, economic, and political objectives that form part of a longterm geopolitical strategy. In a recent interview with CNBC-TV18, Gokhale elaborated on the motivations behind this enduring alliance, highlighting China's need to balance India, secure maritime access to the Arabian Sea, limit U.S. influence in the region, and address internal security concerns related to ethnic fundamentalism. This partnership, which has its roots in the early 1960s, has evolved significantly, particularly with the launch of the China-Pakistan Economic Corridor (CPEC) in 2015, and carries profound implications for India and the broader regional dynamics.

China's view of Pakistan as a strategic asset dates back decades, with the relationship being carefully nurtured for a variety of reasons. Gokhale outlined four primary motivations driving China's commitment to Pakistan. First and foremost, Pakistan serves as a counterbalance to India in the Chinese strategic calculus. As India's regional and global influence grows, China perceives Pakistan as a critical partner in offsetting India's dominance in South Asia. This is particularly important given India's economic rise and its increasing alignment with Western powers, which China views with suspicion. By strengthening Pakistan, China seeks to create a regional counterweight that can challenge India's aspirations and keep it preoccupied with security concerns along its western border. The second key factor is Pakistan's geo-

graphical significance. Located at the crossroads of South Asia, Central Asia, and the Middle East, Pakistan offers China access to the Arabian Sea through the port of Gwadar. This is a critical component of China's strategy to address its so-called "Malacca Dilemma"—the vulnerability of its energy and trade routes through the narrow Malacca Strait, which could be disrupted by rival powers in times of conflict. Gwadar provides an alternative route for Chinese trade and energy supplies, bypassing the Malacca Strait and reducing dependence on maritime chokepoints controlled by other nations. Moreover, as Gokhale noted, with China's third aircraft carrier group undergoing testing and likely to be deployed in the Indian Ocean once operational, Gwadar's role as a friendly port for repairs and resupply will become increasingly vital. While China already has a military base in Djibouti, Gwadar's proximity to the Persian Gulf and its strategic location make it an ideal hub for China's naval ambitions in the Indian Ocean region

The third motivation is China's desire to prevent Pakistan from falling into the U.S. sphere of influence. During the Cold War and even in the post-9/11 era, Pakistan maintained close ties with the United States, including hosting American military assets. For China, the presence of U.S. military bases in Pakistan would pose a direct threat to its national security, particularly given Pakistan's proximity to China's western borders. By cultivating a strong alliance with Pakistan, China ensures that Islamabad remains outside the U.S. camp, thereby safeguarding its own strategic interests in the region.

Finally, China sees Pakistan as a partner in addressing internal security challenges, particularly in its restive Xinjiang province. The region, home to China's Uyghur Muslim population, has faced issues of ethnic unrest and religious extremism. Pakistan's influence in the Islamic world and its ability to manage cross-border militant groups are seen as valuable tools for China in controlling the spread of fundamentalism into its territory. By maintaining close ties with Pakistan, China hopes to leverage its neighbour's influence to stabilize its own borderlands.

The launch of the CPEC in 2015 marked a significant deepening of the China-Pakistan relationship. This ambitious infrastructure and economic initiative, part of China's broader Belt and Road Initiative, has seen billions of dollars invested in Pakistan's energy, transport, and port infrastructure. The development of Gwadar port, in particular, has been a cornerstone of this project, providing China with a strategic foothold in the Arabian Sea.

Arabian Sea.

However, the partnership has not been without challenges. Chinese personnel working on CPEC projects have faced security threats, including attacks by militant groups, and Pakistan's economic instability has raised concerns about its ability to repay Chinese loans. Despite these hurdles, Gokhale emphasized that China views its investments in Pakistan as a long-term strategic commitment rather than a purely financial venture. For Beijing, the benefits in terms of national security and geopolitical influence outweigh the immediate economic risks

The implications of this partnership for India are significant. China's growing presence in Pakistan, particularly through CPEC and the development of Gwadar, has heightened India's security concerns. The possibility of Gwadar serving as a Chinese naval



hub in the Indian Ocean poses a direct challenge to India's maritime interests. Furthermore, the strengthening of Pakistan's military and economic capabilities through Chinese support complicates India's regional strategy, particularly in the context of the longstanding India-Pakistan rivalry. The China-Pakistan axis also places additional pressure on India to bolster its own strategic partnerships, both regionally and globally, to counterbalance this alignment.

Gokhale also shed light on the current state of India-China relations, which have been strained since the 2020 border clashes along the Line of Actual Control (LAC). While disengagement of troops at various friction points has been achieved, the broader process of de-escalation remains incomplete. Beyond the border, other aspects of the relationship, such as trade, investment, and people-to-people ties, continue to face challenges. India has imposed restrictions on Chinese investments and apps, citing security concerns, while China has reportedly created informal trade barriers. For instance, Gokhale pointed to delays in the export of critical equipment, such as tunnel-boring machines for metro systems and components for manufacturing next-generation Apple phones in India. Joint ventures in sectors like lithium-ion technology have also encountered obstacles, reflecting the broader tensions in the relationship.

The collapse of the previous diplomatic framework that governed India-China relations has left the two countries in a state of "armed coexistence," according to Gokhale. This situation is inherently unstable, as it lacks a clear mechanism for managing disputes and preventing escalation. To address this, Gokhale advocated for the development of a new diplomatic framework that would

provide predictability and stability to the relationship. Such a framework would need to ensure that neither side resorts to the use or threat of force, allowing both nations to focus their resources on economic development. For India, leveraging China's economy for its own growth remains a goal, but this depends on China's willingness to invest in India in good faith.

Looking ahead, India faces the challenge of navigating this complex geopolitical land-scape while safeguarding its national interests. A predictable and stable relationship with China is essential, but achieving this will require careful diplomacy and strategic foresight. India must also continue to strengthen its own economic and military capabilities to assert its position in the region. At the same time, fostering partnerships with like-minded countries, such as the United States, Japan, and Australia through frameworks like the Quad, can help India counterbalance China's growing influence.

China's long game with Pakistan is a testament to its strategic patience and focus on securing its geopolitical objectives. For India, this partnership underscores the need for a proactive and multifaceted approach to regional security and diplomacy. By addressing the challenges posed by the China-Pakistan axis and building a robust framework for engaging with China, India can position itself to thrive in an increasingly competitive geopolitical environment. As Gokhale noted, there is wisdom on both sides, and the steps being considered to stabilize India-China relations offer hope for a more predictable future. However, the path forward will require resilience, adaptability, and a clear-eyed understanding of the stakes involved in this high-stakes geopolitical

Indian-American Faizan Zaki overcomes shocking, self-inflicted flub to win Scripps National Spelling Bee

dian-American Faizan Zaki's enthusiasm for spelling nearly got the better of him. Ultimately, his joyful approach made him the Scripps National Spelling Bee champion.

The favourite entering the bee after his runner-up finish last year - during which he never misspelled a word in a conventional spelling round, only to lose a lightninground tiebreaker that he didn't practice for - the shaggy-haired Faizan wore the burden of expectations lightly, sauntering to the microphone in a black hoodie and spelling his words with casual

Including Faizan, whose parents emigrated from southern India, 30 of the past 36 champions have been Indian American, a run that began with Nupur Lala's victory in 1999, which was later featured in the documentary "Spellbound." Lala was among the dozens of past champions who attended this year and signed autographs for spellers, families and bee fans to honour the

Throughout Thursday night's finals, the 13-year-old from Allen, Texas, looked like a champion in waiting. Then he nearly threw it away. But even a shocking moment of overconfidence couldn't prevent him from seizing the title of best speller in the English language. With the bee down to three spellers, Sarvadnya Kadam and Sarv Dharavane missed their words back-to-back, putting Faizan two words away from vic-

At least 88 people dead after floods submerge market town in Nigeria

ABUJA (NIGERIA), May 30: At least 88 people have been confirmed dead after floods submerged Mokwa, a market town in Nigeria's Niger State, on Thursday, an official said

Husseini Isah, head of the operations office in Minna, capital of Niger State, said that many more are still at risk, with rescue efforts underway on Friday. Earlier reports said at least 20 died.

'The number keeps rising," Isah told The Associated Press. "But at the last count, 88 bodies have been

The floods were triggered by torrential rains that lasted several hours. According to local reports quoting residents and local government officials, a dam collapse in a nearby town worsened the situa-

Mokwa is a major meeting point for traders from the south and food growers in the north of the country.

In a similar occurrence last September, torrential rains and a dam collapse in Nigeria's northeastern Maiduguri caused severe flooding, leaving at least 30 people dead and displacing millions, worsening the humanitarian crisis caused by the Boko Haram insurgency.

Nigeria often faces seasonal floods, particularly impacting communities along the banks of the Niger and Benue Rivers. (AP)

Hong Kong pro-democracy, gay rights activist Jimmy Sham released

HONG KONG, May 30: Hong Kong's prominent pro-democracy and LGBTQ+ activist Jimmy Sham was released from prison on Friday after serving over four years in the city's biggest national security case under a Beijing-imposed law.

Sham's activism made headlines during 2019 anti-government protests, when he was the convenor of a now-disbanded prodemocracy group that organised some of the biggest peaceful marches that year, including one that drew an estimated two million

people. Sham was among 47 activists arrested in 2021 for their roles in an unofficial primary election. He was sentenced with 44 other activists last year after judges ruled that their plans to effect change through the primary would have undermined the government's authority and create a constitutional crisis. Only two of the original defendants were acquitted.

Even behind bars, Sham continued to fight for recognition of his same-sex marriage registered overseas at the city's top court, which later ruled the government should provide a framework for recognising same-sex partnerships. It was a landmark decision for the city's

LGBTQ+ community. "I feel happy. No matter whether there's a change in (my) freedom, I am definitely freer compared to yesterday," Sham told reporters Friday after he was reunited with his family. (AP)

pens," Brooks said, and the other two spellers returned to the stage. Later, standing next to the trophy with confetti at his feet, Faizan said: "I'm definitely going to be having nightmares about that

Even pronouncer Jacques Bailly tried to slow Faizan down before his winning word, "eclaircissement," but Faizan didn't ask a single question before spelling it correctly, and he pumped his fists and collapsed to the stage after

saying the final letter. The bee celebrated its 100th anniversary this year, and Faizan may be the first champion who's remembered more for a word he got wrong than one he got right.

"I think he cared too much about his aura," said Bruhat Soma, Faizan's buddy who beat him in the "spell-off" tiebreaker last year.

Faizan had a more nuanced explanation: After not preparing for the spell-off last year, he overcorrected, emphasizing speed during his study sessions.

Although Bruhat was fast last year when he needed to be, he followed the familiar playbook for champion spellers: asking thorough questions, spelling slowly and metronomically, showing little

hallmarks of well-coached spellers, and Faizan had three coaches: Scott Remer, Sam Evans and Sohum Sukhantankar.

None of them could turn Faizan

"He's crazy. He's having a good time, and he's doing what he loves, which is spelling," Evans said. Said Zaki Anwar, Faizan's father: "He's the GOAT. I actually believe that. He's really good, man. He's been doing it for so long, and he knows the dictionary in and out."

A thrilling centennial After last year's bee had little drama before an abrupt move to the spell-off, Scripps tweaked the competition rules, giving judges more leeway to let the competition play out before going to the tiebreaker. The nine finalists delivered. During one stretch, six spellers got 28 consecutive words right, and there were three perfect rounds during the finals. The last time there was a single perfect round was the infamous 2019 bee, which ended in an eight-way tie.

Sarv, an 11-year-old fifth-grader from Dunwoody, Georgia, who ultimately finished third, would have been the youngest champion since Nihar Janga in 2016. He has three years of eligibility remaining.

The most poised and mature of the final three, Sarvadnya - who's from Visalia, California - ends his career as the runner-up. He's 14 and in the eighth grade, which means he has aged out of the competition. It's not a bad way to go

came just the fifth runner-up in a century to come back and win, and the first since Sean Conley in

With the winner's haul of USD 52,500 added to his second-place prize of USD 25,000, Faizan increased his bee earnings to USD 77,500. His big splurge with his winnings last year was a USD 1,500 Rubik's cube with 21 squares on each side. This time, he said he'd donate a large portion of his winnings to charity.

The bee began in 1925 when the Louisville Courier-Journal invited other newspapers to host spelling bees and send their champions to Washington. For the past 14 years, Scripps has hosted the competition at a convention center just outside the nation's capital, but the bee returns downtown next year to Constitution Hall, a nearly century-old concert venue near the White

A passionate champion

Faizan has been spelling for more than half his life. He competed in the 2019 bee as a 7-yearold, getting in through a wild-card program that has since been discontinued. He qualified again in 2023 and made the semifinals before last year's second-place finish.

"One thing that differentiates him is he really has a passion for this. In his free time, when he's not studying for the bee, he's literally looking up archaic, obsolete words that have no chance of being asked," Bruhat said. (AP)

HONG KONG, May 30: Dozens

other countries, from Pakistan and Indonesia to Belarus and Cuba, signed the Convention on the Establishment of the International Organization for Mediation in Hong Kong to become founding members of the global organisation, following Chinese Foreign Minister Wang Yi.

The support of developing countries signaled Beijing's rising influence in the global south amid heightened geopolitical tensions, partly exacerbated by US President Donald Trump's trade tariffs.

At a ceremony, Wang said China has long advocated for handling differences with a spirit of mutual understanding and consensusbuilding through dialogue, while aiming to provide "Chinese wisdom" for resolving conflicts between nations.

"The establishment of the International Organisation for Mediation helps to move beyond the zero-sum mindset of you lose and I win," he said.

The body, headquartered in Hong Kong, aims to help promote the amicable resolution of international disputes and build more har-

monious global relations, he said. Beijing has touted the organization as the world's first intergovernmental legal organization for resolving disputes through mediation, saying it will be an important mechanism in safeguarding the principles of the Charter of the United Nations. It also positioned Hong Kong as an international legal and dispute resolution serv-

Wang said the city's rule of law is highly developed, with the advantages of both common law and mainland Chinese law systems, asserting that it possesses uniquely favorable conditions for international mediation.

Hong Kong leader John Lee said the organization could begin its work as early as the end of this

The ceremony was attended by representatives from some 50 other countries and about 20 organizations, including the United Na-

Yueming Yan, a law professor at the Chinese University of Hong Kong, said the new organisation is a complementary mechanism to existing institutions such as the International Court of Justice and the Permanent Court of Arbitration in the Hague. "While the ICJ and PCA focus on adjudication and arbitration, IOMed introduces a structured, institutionalised form of alternative dispute resolution – namely, mediation — on a global scale," she said.

Although many details about the new body are yet to be clarified, it could open the door for greater synergy between formal litigation or arbitration and more flexible methods like mediation, she said.

Shahla Ali, a law professor at the University of Hong Kong, said the International Organisation for Mediation would have the capacity to mediate disputes between states, between a state and a national of another state, or in international commercial disputes.

"Conventions can provide opportunities to experiment with new approaches," she said, noting rising interest in mediation globally as a means to resolve investor-state

WASHINGTON, May 30: the search landscape, as alterna-Google will return to federal court Friday to fend off the US Justice Department's attempt to topple its internet empire at the same time it's navigating a pivotal shift to artificial intelligence that could undercut its power. The legal and technological threats facing Google are among the key issues that will be dissected during the closing arguments of a legal proceeding that will determine the changes imposed upon the company in the wake of its dominant search engine being declared as an illegal monopoly by US District Judge Amit Mehta last year.

Brandishing evidence presented during a recent three-week stretch of hearings, Justice Department lawyers will attempt to persuade Mehta to order a radical shake-up that includes a ban on Google paying to lock its search engine in as the default on smart devices and an order requiring the company to sell its Chrome browser.

Google lawyers are expected to assert only minor concessions are needed, especially as the upheaval triggered by advances in artificial intelligence already are reshaping

tive, conversational search options are rolling out from AI startups that are hoping to use the Department of Justice's four-and-halfyear-old case to gain the upper hand in the next technological frontier.

"Over weeks of testimony, we heard from a series of well-funded companies eager to gain access to Google's technology so they don't have to innovate themselves," Lee-Anne Mulholland, Google's vice president of regulatory affairs, wrote in a blog post earlier this month. "What we didn't hear was how DOJ's extreme proposals would benefit consumers.

After the day-long closing arguments, Mehta will spend much of the summer mulling a decision that he plans to issue before Labour Day. Google has already vowed to appeal the ruling that branded its search engine as a monopoly, a step it can't take until the judge orders a remedy.

While both sides of this showdown agree that AI is an inflection point for the industry's future, they have disparate views on how the shift will affect Google.



The Justice Department contends that AI technology by itself won't rein in Google's power, arguing additional legal restraints must be slapped on a search engine that's the main reason its parent company, Alphabet Inc., is valued at USD 2 trillion.

Google has already been deploying AI to transform its search engine into an answer engine, an effort that has so far helped maintain its perch as the internet's main gateway despite inroads being made by alternatives from the likes of OpenAI and Perplexity.

browser that Google CEO Sundar Pichai helped build nearly 20 years ago would be among the most effective countermeasures against Google continuing to amass massive volumes of browser traffic and personal data that could be leveraged to retain its dominance in the AI era. Executives from both OpenAi and Perplexity testified last month that they would be eager bidders for the Chrome browser if Mehta orders its sale.

The debate over Google's fate also has pulled in opinions from Apple, mobile app developers,

legal scholars and startups.

Apple, which collects more than USD 20 billion annually to make Google the default search engine on the iPhone and its other devices, filed briefs arguing against the Justice Department's proposed 10year ban on such lucrative lock-in agreements. Apple told the judge that prohibiting the contracts would deprive the company of money that it funnels into its own research, and that the ban might even make Google even more powerful because the company would be able to hold onto its money while consumers would end up choosing its search engine anyway. The Cupertino, California, company also told the judge a ban wouldn't compel it to build its own search engine to compete

against Google. In other filings, a group of legal scholars said the Justice Department's proposed divestiture of Chrome would be an improper penalty that would inject unwarranted government interference in a company's business. Meanwhile, former Federal Trade Commission officials James Cooper and Andrew Stivers warned that another

proposal that would require Google to share its data with rival search engines "does not account for the expectations users have developed over time regarding the privacy, security, and stewardship" of their personal information.

The App Association, a group that represents mostly small software developers, also advised Mehta not to adopt the Justice Department's proposed changes because of the ripple effects they would have across the tech industry. Hobbling Google in the way the Justice Department envisions would make it more difficult for startups to realize their goal of being acquired, the App Association wrote. "Developers will be overcome by uncertainty" if Google is torn apart, the group ar-



NEW DELHI, May 30: Pakistan should hand over UN designated terrorists Hafiz Saeed and Masood Azhar to India if it is serious about talks between the two countries, Defence Minister Rajnath Singh said on Friday.

In an interaction with the naval warriors onboard aircraft carrier INS Vikrant off Goa, Singh said if Pakistan resorts to anything "evil or unethical" against India, it will face the firepower and ire of the Indian Navy this time.

If Pakistan tries to cast an evil eye, the opening of New Delhi's response will be at the hands of the Indian Navy, he said in a clear message to Islamabad.

Pakistan needs to understand that the time is up for the "dangerous game" of terrorism it has been playing since Independence and India will use every method to root out the menace, Singh said.

Anti-India activities are being carried out openly from Pakistani soil and India is "completely free" to carry out every kind of operation against terrorists on both sides

of the border and the sea, he said. The defence minister, highlighting the Indian Navy's role during Operation Sindoor, said it succeeded in keeping the Pakistani military tied down

When the Indian Air Force destroyed terror bases on Pakistani soil, the Indian Navy's aggressive deployment in Arabian Sea confined Pakistani Navy to its own

shores, he said. Singh used his brief speech to the naval personnel to send a stern warning to Pakistan as he asserted that Operation Sindoor is not just a military action but India's frontal

assault against terrorism. "We will use every method

"It should start by handing over terrorists like Hafiz Saeed and Masood Azhar to India. Both of them are not only on the list of 'Most Wanted Terrorists' in India but are also on the UN's list of designated terrorists," he said.

Azhar, the head of Pakistanbased Jaish-e-Mohammad terror group, is wanted in India for the 2008 Mumbai terror attacks, 2016 Pathankot airbase attacks and the

2019 Pulwama strike. Saeed, the founder of Lashkare-Taiba (LeT) terror group is known to be the mastermind of the Mumbai terror attack and wanted in several other terror cases in

"Today the whole world is acknowledging India's right to protect its citizens against terrorism. Today no power in the world can stop India from doing this work,"

On Pakistan's repeated offer of talks, Singh clarified: "If there are talks, it will only be on terrorism

and Pakistan-Occupied-Kashmir. If Pakistan is serious about talks, it should hand over terrorists like Hafiz Saeed and Masood Azhar to India so that justice is served."

Commending the Indian Navy's "silent service" during Operation Sindoor, Singh said the mighty Carrier Battle Group ensured that the Pakistani Navy did not venture out, or else it would have faced the

On Operation Sindoor, he said, "Our strike was so powerful that Pakistan began pleading with the entire world to stop India.

In just a short span of time, we demolished Pakistan's terrorist bases and its intentions, he said adding the speed, depth and clarity with which our armed forces acted were remarkable.

Operation Sindoor not only sent a clear message to terrorists but also to their patrons who nurture them, Singh said.

In the end, on our own terms, we halted our military actions, he said. India carried out precision strikes on nine terror infrastructures early on May 7 in response to the Pahalgam terror attack.

The Pakistani attempts were strongly responded to by the Indian side by inflicting heavy damages to a number of key Pakistani military installations including air bases, air defence systems, command and control centres and radar

Foreign Secretary Vikram Misri on May 10 announced that India and Pakistan reached an understanding to stop all firings and military actions on land, air and sea, with immediate effect. (PTI)

Congress' Jai Hind Yatra more like Jai Pakistan Yatra: BJP

NEW DELHI, May 30: The BJP on Friday lashed out at the Congress for its leaders' questions and jibes at the government over the conflict with Pakistan and alleged the opposition party's ongoing 'Jai Hind Yatra' looks more like "Jai Pakistan Yatra".

BJP national spokesperson Sambit Patra told reporters that senior Congress leaders, including Rahul Gandhi and Telangana Chief Minister Revanth Reddy, have often asked about the number of aircraft India lost in Operation Sindoor. He accused Jairam Ramesh of equating MPs travelling abroad as members of all-party delegations with terrorists.

Gandhi never asked about the details of terror sites and air bases destroyed in Pakistan but his party has enquired about the losses of Indian jets more frequently than the neighbouring country, he said.

The BJP MP from Puri said these leaders are "babbar" (warrior) of Pakistan and "gabbar" (the iconic villain of Bollywood blockbuster Sholay) of India, and added they would meet the same fate as the fictional bandit in the movie did in the hands of protagonists Jai and Veeru.

"Gabbar's defeat is certain due to India's 'jai' (glory) and 'veerta' (valour).'

He noted that even Congress MPs are part of the seven all-party delegations currently on a visit to world capitals to put across India's resolve against terror following the Pahalgam massacre and retaliatory strikes against Pakistan.

These Congress MPs are doing a good job, strongly projecting India's stand but Ramesh in one breath is comparing them to terror-

The Congress chief spokesperson had said on Thursday that the terrorists behind the Pahalgam attack are roaming and so are these

Patra rejected media reports that the ruling BJP planned to distribute vermilion (sindoor) among women to mark the Narendra Modi government's anniversary. He accused the opposition party of spreading this propaganda to belittle Operation Sindoor.

He cited controversial statements of a number of Congress leaders, including some questioning the military conflict with Pakistan and the suspension of the Indus Waters Treaty after the Pahalgam attack to accuse the opposition party of deliberately attempting to lower the country's morale. The BJP leader said the opposition party might have claimed it is with the government on the issue, but it has been lowering the morale of the armed forces from the very beginning.

"The Congress should suspend its Jai Hind Yatra, which is more like Jai Pakistan Yatra, and instead consult with Pakistan and hold a joint press conference," Patra said, claiming that Gandhi is being quoted frequently in Pakistan.

With the Congress increasingly turning caustic at its MP Shashi Tharoor, who is leading the multiparty delegation to the US and four other countries, for his stout defence of the government's actions, Patra said the party is divided into two factions.

One supports Pakistan, he alleged, while another includes those who want to raise their voice for India but cannot due to leaders like

Gandhi. He noted that another Congress leader Salman Khurshid. who is a member of one of the delegations, had spoken about the changes brought by the revocation of Article 370. Somebody should relay the former Union minister's remarks to Gandhi, the BJP leader

During the Congress-led UPA rule, terrorists were invited to the Prime Minister's Office at the behest of the then Congress president Sonia Gandhi, he claimed and referred to reports that she had cried over the killing of some young terrorists in the Batla House en-

Patra also referred to Pakistani Prime Minister Shehbaz Sharif's comments that India's Brahmos missiles hit his country's military facilities ahead of the planned attack on Indian targets to emphasise the damage inflicted on the neighbouring country.

"Gandhi should listen to his friend Sharif," he said.

Patra quoted the opinion of USbased military expert John Spencer, which has been reported widely in the Indian media, that India won the tech war in the conflict while Pakistan lost as China's

He said Spencer was not alone as many experts have spoken about India's decisive victory but some opposition parties, especially the Congress, have been trying to lower the country's morale.

Criticising West Bengal Chief Minister Mamata Baneriee for her choice of words in slamming Prime Minister Narendra Modi. who at a rally in the state had hit out at her government, he said Modi is everyone's "sewak". (PTI)

Fixation on size of economy alone not helping; investment not picking up: Cong US economy," Bery said.

NEW DELHI, May 30: The Congress on Thursday took a swipe at the government over the state of the economy, saying fixation on its size gets headlines but consumption is tepid and investment momentum is just not picking up.

Congress general secretary, in-charge of communications, Jairam Ramesh said first the NITI Aayog CEO makes a claim on the size of the Indian economy which apparently surpassed Japan's "just as he was speaking". Then a member of the NITI Aayog con-

tradicts its CEO and presents a more realistic picture," he said.

"Now the Vice Chairman of the NITI Aayog takes a completely different line saying that his colleagues were using the wrong standard for comparison and that actually

India's economy is already half the size of that of the USA," Ramesh said.

"This fixation on the size of the economy alone is not helping. It gets headlines but meanwhile consumption is tepid and investment momentum is just not picking up," the Congress leader said. His remarks came after NITI Aayog Vice Chairman Suman Bery said that the size of the Indian economy in the purchasing power parity (PPP) term is already USD 15 trillion, which is more than half the size of the US economy.

The purchasing power parity (PPP) is the amount of currency units required to purchase a basket of goods and services that can be purchased with one unit of the reference economy's currency.

"There has been a lot in the newspapers

about our being the fourth largest economy. Those are all measured at market prices, but the real way of measuring productivity is purchasing power parity.

"And while we are USD 4 trillion GDP at market prices, at PPP term, we are USD 15 trillion economy," Bery said while addressing the Annual Business Summit 2025 of the Confederation of Indian Industry (CII).

He said that economists tend to measure labour productivity at purchasing power parity as PPP measures the real size of the economy of a country against the size of the US "And so while we (the size of Indian

economy in PPP term) are at USD 15 trillion, the United States is at USD 29 trillion. So we are roughly half the world size of the

NITI Aayog member Arvind Virmani on Monday said India is set to become the fourth largest economy in the world by overtaking Japan by the end of 2025.

The International Monetary Fund (IMF), in its World Economic Outlook report released in April, had said that India is expected to be the fourth largest economy in the world with a GDP of USD 4.19 trillion in 2025, ahead of Japan.

"India is in the process of becoming the fourth largest economy, and I am personally confident that will happen by the end of 2025 because we need (data) of all 12 months GDP to say that, you know, to assert that. So to say till then, it remains a forecast," Virmani had said. (PTI)

Hindu Kush Himalaya could lose 75 pc of ice by century's end under current climate policies: Study

NEW DELHI, May 30: The Hindu Kush Himalaya, where glaciers feed rivers supporting two billion people, could lose up to 75 per cent of its ice by the end of the century if global temperatures rise by 2 degrees Celsius, according to a new study.

If countries can limit warming to 1.5 degrees Celsius above pre-industrial levels, the study published in the journal Science said 40-45 per cent of glacier ice in the Himalayas and the Caucasus would be preserved.

In comparison, the study found that only about one-

nities, such as the European Alps, the Rockies of the western US and Canada, and Iceland, would be especially hard hit, it said.

These regions could lose nearly all their ice at 2 degrees Celsius, with only 10-15 per cent of their 2020 levels remaining. Scandinavia could face an even grimmer future, with no glacier ice left at all at this level of warming. The study highlighted that limiting warming to 1.5 degrees Celsius, a target set by the 2015 Paris Agreement, would help preserve some glacier ice in all regions.

It predicted that 54 per cent of present-day glacier ice would remain globally and 20-30 per cent in the four most sensitive regions, if this goal is met.

These findings come as global attention turns to the melting of glaciers and its impact, with world leaders gathering in Dushanbe, Tajikistan, for the first UN conference on glaciers starting Friday.

Over 50 countries are attending, including 30 at the ninisterial level or higher. Speaking in Dushanbe, Asian Development Bank

Vice-President Yingming Yang said, "Melting glaciers



threaten lives on an unprecedented scale, including the livelihoods of more than 2 billion people in Asia. Switching to clean energy to cut the release of planetwarming emissions remains the most effective way of slowing glacial melt.'

"At the same time, it is essential to mobilize financing to help the most vulnerable adapt to a future of more floods, droughts, and rising sea levels across Asia and the Pacific," he added.

To get these results, a team of 21 scientists from 10 countries used eight glacier models to calculate the potential ice loss of the more than 200,000 glaciers worldwide, under a wide range of global temperature scenarios. For each scenario, they assumed that temperatures would remain constant for thousands of

In all scenarios, the glaciers lose mass rapidly over decades and then continue to melt at a slower pace for centuries, even without further warming

This means they will feel the impact of today's heat for a long time before settling into a new balance as they retreat to higher altitudes.

"Our study makes it painfully clear that every fraction of a degree matters," says co-lead author Dr Harry Zekollari from the Vrije Universiteit Brussel. "The choices we make today will resonate for centuries, determining how much of our glaciers can be preserved." (PTI)



Asian Athletics: Golden brace for record-breaking Gulveer; High-jumper Pooja also on top



GUMI (SOUTH KOREA), May 30 Long-distance runner Gulveer Singh shattered a decade-old meet record, while teenaged high-jumper Pooja Singh produced a personal best performance as the duo added a couple of more gold medals to India's kitty on the penultimate day of the 26th Asian Athletics Championships here on Friday.

Gulveer etched his name among the greats of Indian long-distance running by winning a tightly-contested men's 5000m final to add to his 10,000m gold won on the opening day of the competition.

The national-record-holding runner clocked 13:24.77sec to edge past Thailand's Kieran Tuntivate, who finished close behind 13:24.97sec, while Japan's Nagiya Mori took bronze in 13:25.06sec.

The previous championship record belonged to Oatar's Mohamed Al-Garni, who had clocked 13:34.47sec in the 2015 edition.

Later, 18-year-old Pooja jumped to a personal best of 1.89m in her penultimate attempt to finish ahead of Uzbekistan's Safina Sadullaeva (1.86m). The Haryana teen, whose father is a construction worker, has been doing well at the continental level, having earlier collected a gold at the Asian Under-23 Championships in 2023.

The win completed a remarkable

double for Gulveer, who had earlier bagged gold in the 10,000m competition on the opening day with a timing of 28:38.63sec.

With this performance, Gulveer oined an elite group of Indian athletes to have won gold in the men's 5000m event of the continental meet -- the other three being Gopal Saini 1981), Bahadur Prasad (G Lakshmanan (2017).

The 26-year-old from Atrauli in Uttar Pradesh had also won a bronze in the 2023 edition.

However, there was mild disappointment in the women's 3000m steeplechase, where defending champion Parul Chaudhary had to settle for silver. She clocked 9:12.46sec and was

bested by Kazakhstan's Norah Jeruto Tanui (9:10.46sec). The bronze also went to a Kazakh, Daisy Jepkemei (9:27.51sec).

Gulveer's triumph gave India their sixth gold medal of the championships, pushing the country's overall tally to six gold, seven silver, and three bronze medals so far.

Earlier, India's 4x100m men's relay team was disqualified during the preliminary round after a faulty baton exchange but Sachin Yadav and Yashvir Singh made the men's javelin throw finals alongside reigning Olympic champion Arshad

STAVANGER (NORWAY), May **30:** Reigning world champion D Gukesh emerged the winner in a thrilling Armageddon tie-break against American Grandmaster Fabiano Caruana but Arjun Erigaisi succumbed to Magnus Carlsen's intuitive skills on a mixed day for the Indians in the 'Open' category of Norway Chess here.

World No. 3 Caruana enjoyed a pawn advantage for most part of the Round 4 game against his Indian opponent, who turned 19 on Thursday, but the American could not convert it into a significant advantage in over four hours of engrossing chess

thanks to Gukesh's superb defensive skills. The Armageddon tie-break was ap-

plied to break the stalemate. Both Gukesh and Erigaisi are now tied fourth in the six-payer field with 4.5 points apiece, while Carlsen is the sole leader with 8

points, followed by Caruana on 7 and American GM Hikaru Nakamura on 5.5.

With Gukesh, playing with white pieces and having a huge threeminute advantage in Armageddon white gets 10 minutes and black seven – after coming out of a tricky situation during the Classical slugfest less than 15 minutes earlier, the Indian overpowered Caruana on the clock to take 1.5 points from the
