

Gaurav issue: Police quiz Ripun Bora for six hours Investigators tried to puzzle him with different questions, says Cong leader

GUWAHATI, May 29: Senior Congress leader and former Rajya Sabha MP Ripun Bora was on Thursday questioned by Assam Police in connection with a case related to party colleague Gaurav Gogoi's alleged links with Pakistan, officials said.

A police officer told PTI that the Bora reached the CM's Special Vigilance Cell (SVC) office at around 11 am and the questioning continued for about six hours.

He, however, declined to share any further details saying the case is under investigation. Coming out of the SVC office, Bora told

reporters that the investigators tried to puzzle him with different questions, but he fully cooperated with them.

'They asked me about my statements in the press conference and if I had made those remarks. I replied accordingly. They said they might call me again if there is any need, and I will come then," he added.

Bora also said that he suggested the investigators to call two more persons for questioning -- Assam chief minister Himanta Biswa Sarma and BJP MLA Diganta Kalita.

"Both Sarma and Kalita spoke as if they knew everything about Gogoi's visit. CM

Cong calling MPs in all-party delegations 'terrorists': BJP on Jairam Ramesh's remarks

NEW DELHI, May 29: The BJP on Thursday accused the Congress of equating the parliamentarians, who are out on a foreign mission to expose Pakistan, with terrorists and demanded "strict action" on this issue.

This came after senior Congress leader Jairam Ramesh, while attacking the government with his claim that a special session of Parliament was being considered for June 25-26 to mark the 50th anniversary of the Emergency to divert attention from the real and more urgent issues, reportedly remarked "our MPs are roaming and terrorists are also roaming"

Latching on to the Congress leader's remarks, BJP national spokesperson Shehzad Poonawalla said, "Jairam Ramesh says the elected MPs in the all-party delegations who

are exposing Pakistan abroad are actually like terrorists." "When Pakistan is being cornered by diplomatic strike, the Congress once again comes out to speak for Pakistan and and calls out parliamentarians terrorists," he charged and asked the Congress if DMK MP Kanimozhi, NCP (SP) MP Supriva Sule and Sama-

GUWAHATI, May 29: A bomb threat was received by Gauhati High Court on Thursday, which turned out to be a hoax, police said.

An officer of Guwahati Police told PTI that a mail landed at Gauhati High Court's official email id in the morning threatening to carry out a blast in the building.

"We carried out a thorough search of the premises and found nothing. It was a hoax," he added. An official of the high court said there has been no hampering in the functioning of the court and different judges heard cases in a routine manner. On April 22, a similar bomb hoax mail landed at Gauhati HC's official email id. The threat had come from an unknown organisation, named 'Madras Tigers'. (PTI)

Firearms and ammunition were also recovered from the encounter spot, the official said.

Acting on specific information of a possible armed attack by poachers on the frontline staff stationed at Balidubi camp in the Agoratoli range of the park, a joint operation was launched by the police and the forest department on Wednesday night.

All forest camps near the area were put on high alert and additional security personnel deployed in the area, the official said. At around 10.30 pm, the joint team detected suspicious movement near the Dhanbari area and issued a warning to the poachers who in turn fired at the security personnel.

The security personnel retaliated and the exchange of fire continued for nearly half an hour before the poachers fled the spot

During the search operation following the encounter, an unidentified and injured individual was found and immediately taken to Swahid Kamala Miri Civil Hospital in Bokakhat, where he was declared dead on arrival by the medical officer.

The security personnel recovered an AK-56 rifle and 11 rounds of live ammunition, a .303 rifle with three rounds of live ammunition, a bag containing an axe, food items, and a torch were recovered from the spot.

'The number of CAMs was less in 2024 compared to the previous year' **ISRO** carried out 122 Collision Avoidance Manoeuvres in 14 years

BENGALURU, May 29: ISRO has said it has carried out 122 Collision Avoidance Manoeuvres (CAM) for its Earth Orbiting Satellites in the last 14 years.

In its Space Situational Assessment Report, the Indian Space Research Organisation said it regularly carries out analyses to predict close approaches by other space objects to Indian space assets.

In case of any critical close approach, CAMs are carried out for the operational spacecraft to mitigate the collision risk, it said.

The space agency said that more than 53,000 alerts issued by the Combined Space Operations Center (CSpOC) of the US Space Command for ISRO's earth orbiting satellites were analysed using more accurate orbital data from



flight dynamics Data shows that since 2010 to 2024, 122 CAMs were conducted and the maximum 23 were carried out between 2022 and 2023. Between 2023 and 2024, 10 CAMs were conducted.

to meet collision avoidance requirements by adjusting orbit maintenance manoeuvres on several occasions and avoiding exclusive CAMs," ISRO explained.

ISRO also said that a total of 136 Indian spacecraft, including those from private operators or academic institutions, were launched in Earth-orbit till December 31, 2024. The number of operational satellites owned by the Government of India is 22 in Lower Earth Orbit (LEO) and 31 in Geo-synchronous Earth Orbit (GEO) by the end of 2024.

In addition, two Indian deep space missions, namely, Chandravaan-2 Orbiter (CH2O) and Aditya-L1 at Sun-Earth Lagrange's point were also active. "The propulsion module of the Chandrayaan-3 (CONTD. ON PAGE-2)

India shares terrorism concerns with Saudi Arabia's security experts

RIYADH, May 29: An all-party Indian delegation on Thursday visited the Naif Arab University for Security Sciences and think tank Gulf Research Centre here to share strong concerns about cross-border terrorism emanating from Pakistan.

The delegation, led by BJP MP Baijayant Panda, is visiting Saudi Arabia from May 27 to 29 to convey India's firm stance against terrorism and its continued efforts to combat this global menace in all its forms and manifestations.

At the Naif Arab University for Security Sciences, the Indian MPs "shared strong concerns with crossborder terrorism and the position of zero tolerance against terrorism," said a post on X by the Indian Embassy here.

Panda shared a post on X that the Indian team had a "meaningful exchange with university President Dr Abdulmajeed bin Abdullah Al-Bunyan, discussing India's firm zero-tolerance approach to cross-border terrorism and shared opportunities in security education and research."

A member of the delegation, Satnam Singh Sandhu, described the institution as a "brilliant platform to exchange the best practices to stop terrorism and benefit mutually" in a post on X.

India to remain fastest-growing economy, RBI's balance sheet increases to ₹ 76.25 lakh crore

MUMBAI, May 29: The balance sheet of the RBI increased to ₹ 76.25 lakh crore, aided by nearly 33 per cent gains in foreign exchange transactions, as of March 2025, leading to a bumper ₹ 2.7 lakh crore dividend to the central government, said the central bank's annual report released on Thursday.

The keenly watched report said the Indian economy is poised to remain the fastest-growing major economy in 2025-26 by leveraging its sound macroeconomic fundamentals, robust financial sector and commitment towards sustainable growth.

The economy exhibited resilience during 2024-25, supported by strong macroeconomic fundamentals and proactive policy measures, amid protracted geopolitical tensions and geoeconomic fragmentation, said the RBI's Annual Report for the Year 2024-25.

"The strength of the financial sector, reflected in improved asset quality and well-capitalised banks, further supported economic activity. Amidst multiple global headwinds, the Indian financial markets demonstrated resilience and orderly movements," it said.

It also flagged global financial market volatility, geopolitical tensions, trade fragmentation, supplychain disruptions and climate-induced uncertainties as factors posing downside risks to the growth outlook and also upside risks to the inflation outlook.

However, factors like easing of supply-chain pressures, softening global commodity prices and higher agricultural production on above-normal south west monsoon augur well for inflation outlook, the Reserve Bank said.

Shifts in tariff policies may result in sporadic episodes of volatility in financial markets, it said, adding that exports may encounter

The withdrawal of ₹ 2000 banknotes from circulation, initiated in May 2023, continued during the year and 98.2 per cent of ₹ 3.56 lakh crore in circulation at the time of announcement have returned to the banking system up to March 31, 2025.

The value and volume of coins in circulation increased by 9.6 per cent and 3.6 per cent, respectively, during 2024-25.

Also, the value of e-rupee in circulation increased by 334 per cent during 2024-25. The supply of notes increased by 24.69 per cent from 2,43,000 lakh pieces during the year 2023-24 to 3,03,000 lakh pieces during 2024-25.

Currency in circulation includes banknotes, central bank digital currency (CBDC) and coins. Presently, banknotes in circulation comprise denominations of ₹ 2. ₹ 5, ₹10, ₹20, ₹50, ₹100, ₹200, ₹ 500 and ₹ 2000.

The Reserve Bank is no longer printing banknotes of denominations of \gtrless 2, \gtrless 5 and \gtrless 2000. Coins in circulation comprise

denominations of 50 paise and $\gtrless 1$, ₹ 2, ₹ 5, ₹ 10 and ₹ 20.

On counterfeit notes, the report said that during 2024-25, out of the total Fake Indian Currency Notes (FICNs) detected in the banking sector, 4.7 per cent were detected at the Reserve Bank.

The counterfeit notes detected in the denominations of ₹ 10, ₹ 20, ₹ 50, ₹100 and ₹ 2000 declined during 2024-25, while those in \gtrless 200 and ₹ 500 denominations increased by 13.9 and 37.3 per cent, respectively, as compared with the previous vear. (PTI)

India's job market to grow 2.8 pc in H1 FY26 amid cost-conscious hiring: Report

MUMBAI, May 29: India's job market is expected to grow 2.8 per cent in the first half of 2025-26 amid economic complexity and cost-conscious hiring, a report said on Thursday. This marks a measured decline from 7.1 per cent in October-March FY25, signalling a deliberate pivot toward demand-sensitive and costconscious hiring, according to TeamLease Services's 'Employment Outlook Report'.

The TeamLease Services' report forecasts a 2.8 per cent Net Employment Change (NEC), down from 71 per cent in H2 FY25, as 47 per cent of employers interviewed indicated plans for workforce expansion, 28

per cent opting for stability, while 25 per cent expect to reduce. The 'Employment Outlook Report' is based on extensive primary and secondary research, drawing insights from over 1,263 employers across 23 industries and 20 cities across the country.

It further revealed that there is a growing trend of flexi-staffing, with 69 per cent of employers embracing flexible workforce models to manage cyclical demand and seasonal peaks. By allowing organisations to scale quickly without the burden of long-term costs, flexi-staffing is proving crucial, especially during the leaner H1 period, said the report. (PTI)

Indian economy size USD 15 tn in PPP term, more than half of US economy: NITI VC Bery

NEW DELHI, May 29: NITI Aayog Vice-Chairman Suman Bery on Thursday said that the size of the Indian economy in the purchasing power parity (PPP) term is already USD 15 trillion, which is more than half the size of the US economy.

The purchasing power parity (PPP) is the amount of currency units required to purchase a basket of goods and services that can be

"There has been a lot in the newspapers about our being the fourth largest economy. Those are all measured at market prices, but the real way of measuring productivity is purchasing power parity.

"And while we are USD 4 trillion GDP at market prices, at PPP term, we are USD 15 trillion economy,"Bery said while addressing the Annual Business Summit 2025 of the Confederation of Indian Industry (CII). He said that economists tend to measure labour productivity at purchasing power parity as PPP measures the real size of the economy of countries against the size

of the US economy. "And so while we (the size of India economy in PPP term) are at at USD 15 trillion, the United States is at USD 29 trillion.

"So we are roughly half the world size of the US economy," he said. Bery said India needs to diversify its sources of supply, so the country would not have to depend on a particular supplier.

He also suggested that India should leverage global knowledge and innovate locally, while reform-



ing markets and building skills.

The NITI Aayog vice chairman also emphasised that the states should utilise opportunities of Free Trade Agreements (FTAs) which were signed by the Union government. He said competitiveness should not only be restricted to manufacturing but should extend to services as well.

Bery said India's labour productivity is the lowest among the G20 nations and a sustained rise in productivity of labour is crucial for India to leverage its demographic dividend. India's track record has not been bad in terms of growth productivity, but it needs to get

better. "Our problem is our low level of labour productivity, not only with respect to the US but also with respect to some of our peers, such as China and other peers in ASEAN, he said. Noting that rising labour productivity leads to faster growth in real incomes, Bery said the fact that that has not been happening as fast as people's aspirations, is what is leading to the skewing for government jobs.

Bery pointed out that India has maintained an average growth rate of 6.5 per cent for the 30 years since 1991 reforms to the COVID period in 2021, suggesting that the roots of resilience in India are as much in our institutions as they are in our policies. Deep institutional sources of resilience are in place, but we mustn't be complacent, because we need to up our game for all kinds of reasons, he said.

According to Bery, industrialisation is another challenge facing the country and policy lessons could be drawn from countries such as China, Japan and South Korea even though each country must work out its own path and productivity trajectory. (PTI)

HT Bureau GUWAHATI, May 29: The Northeast Frontier Railway (NFR) has achieved a key infrastructure milestone by successfully removing a permanent speed restriction in the Simaluguri-Moranhat section under the Tinsukia division.

According to an official statement issued by NFR, this development follows the completion of a major track realignment project aimed at enhancing operational efficiency and increasing train speeds. The engineering work involved replacing an existing 3-degree curve, which was 290 meters long and had required trains to reduce speed between Km 22/8 and Km 23/1.

This curve has now been redesigned into a 2-degree curve, extended to 420 meters, allowing trains to run at the sectional speed limit of 110 kmph.

The realignment significantly improves both line capacity and running efficiency. The project required a major slew of

5,772 mm, demanding high levels of precision and technical expertise. Following the alignment, machine packing was conducted to stabilize the

track, ensure alignment accuracy, and maintain structural safety.

NFR stated that it continues to undertake proactive measures to improve track conditions across its network

These include the elimination of Permanent Speed Restrictions (PSRs), comprehensive track renewal, and regular maintenance activities. As part of these ongoing efforts, NFR has successfully removed 15 PSRs so far, reflecting its commitment to enhancing train punctuality and overall passenger service.

The removal of the speed restriction in the Tinsukia division is part of NFR's broader strategy to ensure safer, faster, and more reliable rail travel throughout the region

Who pays for trade war?

y the time Washington and Beijing released their latest joint statement on May 12 - ostensibly pressing pause on a spi-D ralling tariff war - much of the world exhaled in cautious relief. But beneath the performative diplomacy and sterile communiqués, a quieter suffering has gone largely unheard. For the world's most vulnerable economies, the damage is neither paused nor negotiable. It is metastasizing. At the centre of the storm lies the United States' renewed enthusiasm for tariffs - an economic instrument once discarded by the apostles of neoliberal globalization, now being redeployed with almost missionary zeal. The United Nations Conference on Trade and Development (UNCTAD) has sounded the alarm: America's recent wave of tariff hikes, far from being a targeted effort to recalibrate great-power competition, threatens to rupture the already fragile prospects of the least developed countries (LDCs) and small island states. Rebecca Greenspan, the head of UNCTAD, has put it bluntly: the poorest nations on earth those who have played little to no role in ballooning the U.S. trade deficit - should be exempt. Her case is unimpeachable. The 44 least developed countries contribute less than 2% to America's trade imbalance. Their exports are, in most cases, inconsequential in value and unthreatening in scope. Take Madagascar, whose prized export is vanilla. Punitive tariffs on such economies amount not to economic policy, but economic vandalism.

But the ideology of economic nationalism, like its military counterpart, rarely pauses to interrogate the collateral damage. The numbers speak with a clarity that policymakers prefer to ignore. According to UNCTAD, vulnerable economies currently account for just 0.3% of the U.S. trade deficit. Yet in the next round of planned tariff escalations - set to take effect by July 2025 - some of these very nations are slated to face rates exceeding 25%. Seven of them are LDCs. Many are in Asia and the Pacific, regions already groaning under the triple burden of climate crisis, debt overload, and post-pandemic recovery. Even the arithmetic of injustice is startling. In April alone, the average U.S. tariff on LDCs in Asia and Oceania doubled, with projections suggesting it may triple by July. Tariffs on Latin American and Caribbean nations have surged more than 40-fold. The worst hit? Agriculture and textiles - the sectors that not only anchor these economies but also employ the largest swath of their working populations.

One might ask, what rationale underpins this? Officially, Washington claims it is "protecting domestic industries." But in practice, it resembles an exquisitely precise sniper attack on economies too weak to retaliate. These are not the high-tech sectors threatening Silicon Valley's dominance. They are the labour-intensive, lowmargin industries that are the difference between subsistence and survival for millions. Nowhere is the contradiction more grotesque than in America's expectations from the very nations it punishes. As Washington tightens its own trade borders, it insists that others dismantle theirs. The asymmetry is breathtaking. This hypocrisy is neither accidental nor new. As Joseph Stiglitz - one of the few economists in the West willing to pierce the veil - once observed, "Those who build walls will eventually be surrounded by them." That moment may be closer than many in Washington dare admit.

Pak PM's outreach to Iran fails to produce desired results

ne good thing coming out of India's "4-Day War", aka 'Operation Sindoor', is the thaw in relations between Pakistan and Iran, two Islamic countries which share a border and often end up trading fire across the same border. Iran is a country worth cultivating or left to its own devices. Pakistan, on the other hand, can be left to its own devices only at India's peril.

India and Pakistan can be neighbours but Indian 'netas' should stop parroting that Indians and Pakistanis share the same dna. It's an insult even if politicians from both sides of the Wagah share traits. Prime Minister Shehbaz Sharif carried with him several sheafs of olive leaves, including one for Iran. It's been a year since Iran and Pakistan conducted cross-border airstrikes and Shehbaz Sharif wanted to bury the hatchet deep in Iran soil. Watching Shehbaz Sharif appease Iranians was Field Marshal Asim Munir, newly promoted and hailed as Pakistan's saviour in the "4-Day War". Shehbaz Sharif's mistake is carting Munir to wherever he travels to in the world. The only world leader who sees promise in Field Marshal Asim Munir is United States President Donald Trump whose enduring interest is 'cryptocurrency'' and he thinks Pakistan is a promising country for 'trade in crypto.'

Bangladesh as a pawn in Pakistan's anti-India game

Dakistan's strategy of using Bangladesh as a conduit to destabilize India represents a complex and sensitive dimension of South Asian geopolitics. This approach aims to undermine India's internal security, economic stability, and regional influence through indirect means, leveraging Bangladesh's geographical proximity and socio-political dynamics. The roots of this strategy lie in the historical animosity between India and Pakistan, compounded by Pakistan's inability to achieve its objectives through direct confrontation. By exploiting Bangladesh as a strategic buffer, Pakistan seeks to create instability in India's northeastern states, foster communal tensions, and weaken its economic and political fabric. This article explores the historical context, mechanisms, consequences, and India's responses to this strategy, analyzing its implications for regional stability. The India-Pakistan rivalry has been a

defining feature of South Asian politics since the partition of 1947. The division of the subcontinent along religious lines cre-

ated deep-seated mistrust, with disputes like Kashmir becoming flashpoints of conflict. Pakistan's repeated failures in direct military engagements with India, notably in the wars of 1947, 1965, and 1971, prompted a shift toward asymmetric warfare. The 1971 Bangladesh Liberation War was a pivotal moment in this context. India's support for Bangladesh's independence from Pakistan, culminating in the creation of a sovereign Bangladesh, dealt a severe blow to Pakistan's national pride and territorial integrity. The loss of East Pakistan (now Bangladesh) intensified Pakistan's hostility toward India, setting the stage for a long-term strategy of destabilization through proxy means.

Pakistan's Inter-Services Intelligence (ISI) has been the primary architect of this strategy, employing Bangladesh as a staging ground to orchestrate activities against India. The porous India-Bangladesh border, spanning over 4,000 kilometers, offers a strategic advantage due to its geographical complexity, including dense forests, rivers, and hilly terrain. This border has been exploited for activities such as illegal infiltration, arms smuggling, and the movement of terrorist operatives. Pakistan's objective is to create instability in India's northeastern states, including Assam, Tripura, and Meghalaya, which share borders with Bangladesh. These states are ethnically diverse and have historically grappled with insurgencies, making them vulnerable to external manipulation.

One of the key tactics in Pakistan's strategy is the support of terrorist and insurgent groups operating in Bangladesh and India's northeast. Reports from Indian intelligence agencies have repeatedly pointed to ISI's links with militant outfits in Bangladesh,

such as Jamaat-ul-Mujahideen Bangladesh (JMB), which have been involved in anti-India activities. These groups are allegedly provided with funding, training, and logistical support to carry out operations across the border. In India's northeast, insurgent groups like the United Liberation Front of Asom (ULFA-Independent) have reportedly received assistance from Pakistan through bases in Bangladesh. During the 1990s and early 2000s, ULFA leaders were known to operate from safe havens in Bangladesh, allegedly with ISI backing. This support enabled these groups to conduct attacks, disrupt governance, and create a climate of fear in the region. The India-Bangladesh border's perme-

ability has facilitated the movement of individuals, including trained operatives, into India. This has led to demographic shifts in states like Assam and West Bengal, fueling social and political tensions. The issue of illegal immigration has been a contentious one in

Bangladeshi migrants has sparked debates over identity, resources, and citizenship. The 1980s saw the rise of the Assam Movement, driven by fears of demographic change, which culminated in the Assam Accord of 1985. Pakistan has allegedly exploited these tensions by encouraging infiltration to exacerbate ethnic and communal divisions, thereby weakening India's internal cohesion. The presence of undocumented migrants has also strained India's security apparatus, as distinguishing between economic migrants and potential operatives remains a challenge. The ISI has been accused of fostering

radical ideologies among certain religious groups in Bangladesh to create an anti-India sentiment. This involves funding madrasas and organizations that propagate extremist views, which can then be channeled into subversive activities against India. In states like Assam and West Bengal, where religious diversity is pronounced, such efforts risk igniting communal violence. For instance, propaganda targeting India's Muslim population, portraying India as antagonistic to their interests, has been used to sow discord. The 2012 riots in Assam between Bodo tribes and Bengali-speaking Muslims, while rooted in local issues, were allegedly amplified by external actors seeking to exploit communal fault lines.

The smuggling of counterfeit Indian currency through the India-Bangladesh border has been a persistent issue. These counterfeit notes, often traced back to printing operations in Pakistan, are funneled into India to destabilize its economy. By flooding the market with fake currency, Pakistan aims to undermine public confidence in India's financial system, increase inflation, and strain law enforcement resources. Additionally, the smuggling of arms and narcotics through Bangladesh further

compounds India's security challenges, as these activities fund insurgent and criminal networks operating within its borders.

India has adopted a multi-pronged approach to counter Pakistan's strategy. On the security front, it has strengthened border management along the India-Bangladesh frontier. The construction of a border fence, though incomplete in some areas, has been a significant step toward curbing illegal crossings. The deployment of advanced surveillance technologies, such as drones and thermal imaging cameras, has enhanced monitoring capabilities. The Border Security Force (BSF) has been bolstered with additional personnel and resources to patrol the border effectively. Joint operations with Bangladeshi authorities have also been initiated to dismantle terrorist networks and curb smuggling.

India has deepened its engagement with Bangladesh to neutralize Pakistan's influence diplomatically. Since the mid-2000s, India-Bangladesh relations have seen significant improvement, particularly under the leadership of Bangladeshi Prime Minister Sheikh Hasina. Bilateral agreements on trade, connectivity, and security cooperation have strengthened ties. India has provided economic assistance, including lines of credit for infrastructure projects, foster goodwill and reduce to Bangladesh's reliance on external actors. The extradition of ULFA leaders from Bangladesh to India in the late 2000s was a testament to the growing cooperation between the two nations. By aligning Bangladesh's interests with its own, India has sought to limit the space for Pakistan's maneuverability.

In the northeastern states, India has pursued a combination of development and dialogue to address the root causes of insurgency. Investments in infrastructure, education, and healthcare have aimed to integrate the region more closely with the Indian mainstream, reducing the appeal of separatist ideologies. Peace talks with groups like ULFA and Bodo factions have led to accords that have significantly reduced violence. The Bodo Peace Accord of 2020, for instance, brought a degree of stability to Assam's Bodoland region. These efforts have weakened the ability of external actors like Pakistan to exploit local grievances

On the international stage, India has worked to isolate Pakistan diplomatically by highlighting its role in sponsoring terrorism. At forums like the United Nations, India has presented evidence of Pakistan's involvement in cross-border terrorism, seeking to garner global support. The Financial Action Task Force (FATF) has placed Pakistan on its grey list for failing to curb terror financing, imposing economic penalties that limit its ability to fund subversive activities. India's growing global influence has also enabled it to rally support from major powers like the United States and European nations, further pressuring Pakistan to rein in its intelligence agencies.

Bangladesh's internal political dynamics, including periodic instability and the influence of religious hardliners, provide fertile ground for Pakistan's activities. The rise of opposition groups in Bangladesh, some of which have historically been sympathetic to Pakistan, could complicate India's efforts. Moreover, the India-Bangladesh border's terrain and the socioeconomic disparities between the two countries make it difficult to completely seal off illicit activities. The persistence of poverty and unemployment in Bangladesh also creates vulnerabilities that external actors can exploit.

The broader implications of Pakistan's strategy extend beyond India-Bangladesh relations. It undermines the prospects for regional cooperation in South Asia, where organizations like the South Asian Association for Regional Cooperation (SAARC) have struggled to function effectively due to India-Pakistan tensions. The perpetuation of instability in India's northeast hinders economic development and connectivity projects, such as the India-Myanmar-Thailand trilateral highway. which aim to integrate the region with Southeast Asia. Furthermore, the use of Bangladesh as a proxy risks drawing it into the India-Pakistan rivalry, potentially destabilizing its own political and social fabric.

To address these challenges comprehensively, India must continue to strengthen its partnership with Bangladesh. Expanding economic cooperation, particularly through initiatives like the Bangladesh-Bhutan-India-Nepal (BBIN) framework. can create shared stakes in regional stability. Enhancing intelligence-sharing and joint counter-terrorism operations will be crucial to dismantling networks supported by Pakistan. At the same time, India must sustain its focus on developing its northeastern states, addressing grievances that could be exploited by external actors. Public diplomacy efforts to counter extremist propaganda and foster communal harmony will also be essential.

Pakistan's use of Bangladesh as a tool to destabilize India is a multifaceted strategy rooted in historical grievances and geopolitical ambitions. While India has made significant strides in countering this threat through security, diplomacy, and development, the challenge remains formidable. The interplay of regional dynamics, internal vulnerabilities, and global geopolitics necessitates a sustained and coordinated response. By deepening ties with Bangladesh, addressing domestic fault lines, and leveraging international support, India can mitigate the impact of Pakistan's strategy. Ultimately, fostering peace and prosperity in South Asia requires collective action among regional actors to transcend the zero-sum logic of conflict and build a framework for mutual cooperation.

✓ Value-Added Exports : The policy promotes the export of products with higher processing and branding, including non-forest produce, herbs, handicrafts, and more. ✓ Research & Development :

and providing handholding for increasing exports. ✓Other Export Promotion Initiatives under DEH : The Directorate General of Foreign Trade (DGFT) is enancing e-commerce exports through its Districts as Export Hubs initiative, collaborating with various e-commerce companies. These platforms are identifying districts across India for capacity-building and outreach activities in partnership with DGFT Regional Authorities. The initiative focuses on educating MSMEs about e-commerce exports, enabling them to sell globally, and includes training on imaging and digital cataloging of products.As part of this effort, DGFT has signed MoUs with Amazon India, Shiprocket, and DHL to support local exporters, promote e-commerce exports, and conduct capacity-building sessions, training on packaging, branding and marketing, and workshops for MSMEs in 20, 16, and 76 districts respectively. In order to create more awareness around exports in all the country's regions, DGFT Regional Authorities have been organizing "Outreach Events" under 'Districts As Exports Hubs' to promote the products/services with export potential as identified under the Initiative. These events are designed to emphasize ecommerce exports and to provide dedicated support to exporters in the districts to onboard the manufacturers or sellers or exporters into e-commerceplatforms. As a result of these collaborations 10 outreach events were organized in Districts export outreach events in Faridabad, Moradabad, Ludhiana, Jodhpur, Bangalore, Ahmedabad, Hyderabad, Mumbai, Jamshedpur and Varanasi over a period from March-June 2024. These events, organized with leading e-commerce platforms, provided valuable hand-holding, capacity building, and training sessions for participating businesses, offering key insights and support to help them succeed in global markets. Various ecosystem players like ECGC, EPCH, FIEO, MSME, India Post and various Banks like HDFC, ICICI, SBI and Exim Bank have also collaborated and contributed in successful completion of these outreach events. The events have provided insights about the concerns of the exporters and built awareness about the issues faced in ecommerce adoption, for instance, payment issues, trust and buyer verification, etc. DGFT has also partnered with Exim Bank to boost exports under the ODOP-DEH initiative (One District, One Product and Districts as Export Hubs). This collaboration stems from an Exim Bank study that identified 59 middle exports districts with export potential. Under the collaboration, DGFT selected 6 districts (Anantapur, Raipur, Solan, Tirupur, Kanpur, Kolhapur) from a list of 20 proposed by Exim Bank. These districts will receive support through Exim Bank's GRID program(Grassroots Initiatives for Development). The program aims to address sector-specific challenges and identify suitable beneficiaries for support. Exim Bank aims to prepare a detailed proposal outlining challenges and solutions for collaborative implementation. Returning to our state Assam, we can say that there exist incredible export opportunities in the state of Assam, especially given its geographical location and being the largest state in the northeastern part of India. As the recent trends point towards India's increasing economic engagement with its immediate neighbours as well as other countries to its east, building Assam's export capabilities gains even more importance. Assam is also uniquely located to serve as trade hub for other North Eastern States. Thus, enhancing the trade competitiveness of the state would translate to greater gains for the whole North Eastern part of India. ✓ Provide cold storage infrastructure and reefer containers for transportation : Since ICD Amingaon facilitates trade for the entire NER, reefer container services may be made available on the route from ICD to Kolkata port as well as on routes connecting the ICD to other North Eastern states. Access to reefer services in these routes will facilitate exports of agriculture products from the entire region.

✓ Harmonise standards across all Land Customs Stations between India and Bangladesh : Different LCSs have their own list of negative items which are not allowed in crossborder trade. For instance, Hilsa fish is not allowed to be imported through ICP Sutarkandi, but imports are allowed through Manu LCS. Removal of such inconsistencies are required to ensure uniform standards and practices at all border points for ease of trading across borders.

✓Deepen and ensure maintenance of Inland Waterway Transportation (IWT) network :

A seamless IWT network would provide access to Assam and NER, in general to the Mongla port in Bangladesh and Kolkata ports through which goods can be exported to far off destinations. Currently, out of the 15 national waterways present in the State, only two are in use. Other routes need to be explored to strengthen integration in the region. Besides, rivers along the IBP route are mid-stream and require regular dredging. To ensure regular dredging of rivers along the IBP route for Inland Water Connectivity, India and Bangladesh need to formulate an agreement, specifying cost sharing and other clauses.

Incentivize Participation of Women in Trade : The female labour force participation rate of Assam as estimated in the Periodic Labour Force Survey, January - March 2021 was18.8%, a drop from 20.2% in the previous quarter. Engaging in both trade and trade facilitation activities can provide a stimulus to employment of women in the State. Thus, identification and training of potential women traders is required. Government of Assam through its various agencies, may also like to conduct workshops towards educating women about the various advantages and processes pertaining to exports so as to make them better equipped. Further, since women run enterprises may face challenges in getting trade financing, the State Government may like to explore suitable financial structures to incentivize commercial banks to come up with products that prioritize financing to women led export enterprises. The strategies as outlined at above focus on boosting exports of goods and services, strengthening trade facilitation, enhancing connectivity, and ensuring better utilization of present trade infrastructure. These can help the State in harnessing its true economic potential and in transforming Assam into a vibrant hub for trade and commerce. The Government of Assam has various initiatives to promote exports, including recognizing export excellence, supporting cluster-based exports, and promoting valueadded exports. They also offer financial assistance for participation in trade fairs, both within and outside India. Furthermore, they are developing an Export Promotion Industrial Park (EPIP) to facilitate export business. Export Promotion & Facilitation Strategies :

✓ Recognition of Excellence : The government provides awards and certificates for outstanding export performance, especially in key sectors.

✓ Cluster Development :

They focus on establishing export-oriented clusters to improve standardization and meet export demands.

The government encourages research to develop new exportable products and strengthen branding efforts.

✓ Financial Assistance for Trade Fairs : Within India: Reimbursement of stall rent (up to 75%), railway travel fare, and daily food and lodging expenses for two participants. Outside India: Reimbursement of stall rent (100% on a sharing basis), air travel fare, and daily food and lodging expenses for one participant.

✓Infrastructure Development :

Export Promotion Industrial Park (EPIP)

The government has established an EPIP in Amingaon, Guwahati, to facilitate export-related activities.

It builds on the policy impetus of the Atma Nirbhar Bharat Mission, vision of Make in India for the world and the clarion call of Vocal for Local given by the hon'ble Prime Minister by involving States and Districts as meaningful stakeholders and active participants in order to synergise export promotion efforts in India. He envisioned that each district in the country holds economic potential comparable to that of a smallcountry. As a result, the DEH initiative was launched in August 2019 to foster balanced regional development across all districts of the country. With the advent of Foreign Trade Policy (FTP) 2023, DGFT has legitimized this cause through the inclusion of 'Districts As Export Hubs initiatives' under the Chapter 3 of FTP 2023. It aims to channelize the potential and diverse identity of each District of the country to make them Export Hubs. Towards this goal, the products or services (including GI products, agricultural clusters and toy clusters) with export potential in all the districts of the country have been identified and institutional mechanism in the form of State Export Promotion Committees (SEPC) at State/UT level and District Export Promotion Committees (DEPCs) at the district level has been created in all districts of the country to provide support for export promotion and address the bottlenecks for export growth in the Districts. District Export Action Plans are being prepared for identified products and services, to benefit both producers and manufacturers- addressing challenges to export, identifying infrastructural bottlenecks, supply chain gaps, improving market accessibility

Bangladesh's 1971 Apology Demand Geopolitics, justice, and the Assam dilemma

n a dramatic and historically poignant diplomatic overture, Bangladesh has once again raised its long-standing demand for an official apology from Pakistan for the atrocities committed by the Pakistani military during the 1971 Liberation War. The demand, presented during a foreign secretary-level meeting in Dhaka on 17 April 2025, marks a renewed assertion of national memory and historical justice amidst a significant political transition in the South Asian country. The discussions — the first Foreign Office Consultation between the two countries in 15 years also included Dhaka's claims for USD 4.32 billion in compensation as part of the undivided Pakistan's assets, along with a share of foreign aid intended for the victims of the 1970 Bhola cyclone. The current developments, however, transcend mere diplomacy; they intertwine with the internal political turbulence in Bangladesh, evolving Indo-Bangla dynamics, and the persistent ghost of illegal migration that continues to trouble India's northeastern frontier.

The renewed push came from Bangladesh's interim government, headed by Nobel laureate tionals

Professor Muhammad Yunus, Bangladeshi citizenship and rewho assumed charge on 8 August 2024 following the dramatic ousting of long-serving Prime Minister Sheikh Hasina. Hasina, who had remained in power for 16 years, was forced to resign after a mass studentled uprising rocked the country in July-August 2024. Fleeing the political storm, she sought temporary refuge in India, triggering a cascade of legal and diplomatic complications. A staunch proponent of justice for the victims of the 1971 genocide, Hasina had consistently demanded an unconditional apology from Pakistan — a stance now echoed by the very

interim regime that replaced her, despite its prior opposition to her leadership. At the recent bilateral meet-

ing, Bangladesh's foreign secretary MdJashimUddin presented a series of historical and humanitarian claims to his Pakistani counterpart AmnaBaloch. Chief among them was the demand for a formal apology for what Dhaka estimates to be the killing of three million people and the rape of over 200,000 Bengali women by the Pakistani army during the Muktijuddha. Bangladesh also revived its de-

mand for the repatriation of nearly three lakh Pakistani nawho refused mained stranded in Bangladesh for decades. The financial compensation claim of USD 4.32 billion, along with a demand for Bangladesh's share in the pre-1971 foreign aid fund of USD 200 million, underscores the country's insistence on material as well as moral restitution. This resurgence of memory

politics occurs amidst a politically fragile environment in Bangladesh. Professor Yunus ---a globally celebrated microfinance pioneer and recent inductee into TIME magazine's list of the 100 most influential people — has faced immense challenges in governing the country. His administration inherited a battered economy. dysfunctional state institutions, and a populace fractured along ideological and ethnic lines. Despite these daunting realities, Yunus has expressed his vision for an egalitarian and inclusive Bangladesh, one in which citizens are treated fairly regardless of faith or ethnicity.

Yet, his diplomatic overtures, especially toward Pakistan and China, have not gone unnoticed by India. The Indian establishment remained conspicuously silent when Yunus extended an invitation to Pakistani dignitaries, including Foreign Minister Muhammad Ishaq Dar, who 27–28 April — the first such visit by a Pakistani foreign minister since 2012. More alarming for New Delhi, however, was the reported proposal by Yunus to grant China access to develop an airfield in northern Bangladesh, perilously close to India's strategically sensitive Siliguri Corridor. Often dubbed the "Chicken's Neck," this narrow strip connects the Indian mainland with its northeastern states and is considered a geostrategic choke point. Even Assam Chief Minister HimantaBiswaSarma publicly condemned Yunus for what was perceived as a move jeopardising regional security.

India's concerns have also been amplified by growing reports of minority persecution in Bangladesh during the political transition — including temple vandalism, targeted killings of Hindus, and the marginalisation of secular voices. The cultural ramifications of these developments became apparent when the iconic MangalShobhajatra, a UNESCO-recognised New Year procession, had its name changed to BarshabaranAnandaShobhajatra due to Islamist sensitivities. In Chittagong, the cultural procession was cancelled altogether, citing security threats — an unsettling signal of

Bangladesh.

For India, and particularly the state of Assam, the political flux in Dhaka is more than a distant concern — it is a matter of domestic anxiety. The scars of the 1971 war are etched deep in Assam's collective memory. The influx of Bengali-speaking refugees from East Pakistan during and after the conflict strained local resources, altered demographic balances, and laid the foundation for a protracted and violent anti-immigrant movement in the 1980s. Despite the historic Assam Accord of 1985, which set 25 March 1971 as the cutoff date for legal entry, illegal migration remained an unresolved challenge. While the accord legally sanctified pre-1971 migrants, it left Assam to bear the disproportionate burden of resettlement without any national redistribution mechanism. The rest of India did not step forward to share the humanitarian load, leaving the Assamese people to grapple with the socio-economic and cultural fallout alone.

The demand for updating the National Register of Citizens (NRC) on a nationwide scale a proposal that has gained momentum in the wake of the recent Pahalgam terror attack draws its historical urgency

is scheduled to visit Dhaka on the shrinking secular space in from precisely this regional experience. For Assam, the NRC is not just a bureaucratic exercise but a long-overdue attempt at demographic rectification. However, political opportunism, administrative lethargy, and a lack of cohesive national policy have stalled any meaningful resolution. Despite repeated electoral promises, governments in both New Delhi and Dispur have failed to curb the continuous inflow from across the porous Indo-Bangla border.

Professor Yunus's attempts to reset Bangladesh's diplomatic priorities while simultaneously reconciling with Islamabad without adequately addressing historical injustices - strike a discordant note. The bonhomie between Yunus and Pakistan Prime Minister Shehbaz Sharif, reinforced through their meetings in New York and Cairo. may signal a strategic realignment. But it also raises legitimate concerns in India about Dhaka's potential drift toward an Islamic bloc orientation. In this context, Yunus's appeal to New Delhi for the repatriation of Hasina - now facing multiple arrest warrants on charges including genocide and enforced disappearances - remains diplomatically sensitive. direct interference, Prime Minister NarendraModi made it clear during his recent meeting with Yunus at the BIMSTEC summit in Bangkok that India expects the protection of minorities and a return to democratic stability in Bangladesh.

The future trajectory of Indo-Bangla relations will largely depend on the outcome of the next general elections in Bangladesh, which Yunus is expected to facilitate. While he currently enjoys international acclaim, his ability to deliver a credible, free, and fair electoral process will determine not only his domestic legitimacy but also the stability of South Asia's geopolitical equilibrium.

For the people of Assam, and indeed for the Indian state as a whole, the hope remains that Dhaka's reawakening to the truths of 1971 will not only lead to justice with Islamabad but also lay the foundation for a comprehensive and humane resolution to the issue of illegal migration. As history continues to cast a long shadow over the subcontinent, it is accountability. inclusivity, and regional cooperation - not denial, appeasement, or authoritarian populism - that must guide the way forward. India's diplomacy helps Mauritius regain Chagos Archipelago after 60 years

The end of Britain's 60-year-old occupation of the Chagos Archipelago marks a historic moment that erases one of the darkest remnants of colonial rule, which continued to shadow several parts of the world even decades after independence. On 22 May 2025, British Prime Minister Keir Starmer and Mauritian Prime Minister Navin Ramgoolam signed a landmark agreement in a digital ceremony, officially transferring the Chagos Archipelago including strategic and militarily significant islands such as Diego Garcia back to Mauritius. Behind this historic deal stood another silent yet pivotal force India. Particularly, the role of Prime Minister Narendra Modi was crucial and decisive in this diplomatic development, although he always remained behind the scenes.

The story of the Chagos Archipelago is not just about geography or strategy, but also about justice, sovereignty, and self-respect. In 1965, just as Mauritius was on the verge of gaining independence from Britain, the British separated the Chagos Archipelago from Mauritius and retained it under their ently, thousands of local res trol. Subseq idents were forcibly evicted from their homes, and the island of Diego Garcia was developed into a massive military base for the United States a base that remains an essential part of America's global strategic framework to this day. Since then, Mauritius had been fighting for the return of this land a battle that has finally reached its conclusion. Under the terms of the agreement, Britain has returned sovereignty over the archipelago to Mauritius, although Diego Garcia will continue to be used jointly by Britain and the U.S. under a 99-year lease. In return, Mauritius will receive approximately £101 million annually. This arrangement also maintains the strategic military balance considered essential by the U.S. and its allies in the Indian Ocean. Yet, the most significant aspect of this development is that a deep wound of colonialism has finally begun to heal.

This agreement did not happen overnight. It was the result of years of negotiations, debates on international platforms, and quiet diplomacy. India's role in this context is especially noteworthy. Since 2019, when the International Court of Justice issued an advisory opinion declaring Britain's occupation illegal, India has consistently supported Mauritius' claim. Whether in the United Nations General Assembly or in regional groupings of Indian Ocean countries, India has made it clear that the Chagos Archipelago is an integral part of Mauritius and that its return was only a matter of time.

PM Modi viewed this issue not merely as helping a friendly nation but as a moral initiative to strengthen the voice of the "Global South" and confront the legacy of colonial history. That is why India's role in this entire affair remained significant but was never used for publicity or political gain. India did not release any grand official statements, nor did it present this as a diplomatic victory. But Mauritius wholeheartedly acknowledged the support, explicitly thanking PM Modi.

Mauritian PM Navin Ramg nam stated lifted after the hearing concluded, clearing the way for the final signing.As for Diego Garcia, it remains an extremely important outpost for the U.S. military, particularly in terms of monitoring Afghanistan, Iran, and China. Therefore, the agreement was not merely historical or emotional; it had multiple layers of strategic and security concerns. Striking a balance here was crucial and India played a significant role in achieving that. This agreement also offers a glimpse into a "New World Order." Today, as Western powers begin to dismantle their old colonial footprints, countries like India are stepping forward not only to forge partnerships but also to define their role based on justice and moral values. This is not just about geography it signals a transformation in global consciousness. This entire episode has once again proven that although justice may be delayed, it is achievable provided there is strong will, consistent diplomatic effort, and international cooperation. The return of Chagos is not just a victory for Mauritius but also a ray of hope for millions whose lands, identities, and rights were taken away through colonial conspiracies.

For India, this is both an opportunity and a responsibility. An opportunity because its in fluence in the Indian Ocean has become more stable and widely accepted. A responsibility because as India aspires to become the voice of the Global South, it must continue to stand on the side of justice and morality whether the issue concerns a small African nation or an island state in South Asia. The return of the Chagos Archipelago is no ordinary event. It is a turning point in history where the door on colonialism has been closed, and a new chapter of global justice has begun. In this victory, India's role has been that of a quiet but firm foundation and it demonstrates that true diplomacy doesn't always make noise, but it does change history. Russia's balancing act: Navigating the Indo-Pak rift post-Pahalgam

he Russia-India partner-ship is a unique one. With converging geopolitical interests and an absence of bilateral disputes, the two countries have forged a longstanding relationship with minimal friction. Therefore, the Kremlin's response was unsurprising when Pakistan-funded terrorists launched attacks in Pahalgam, claiming the lives of 26 civilians. Russian President Vladimir Putin offered his condolences to the victims of the attack and reiterated Moscow's readiness to step up cooperation with India in the fight against terrorism. Similar sentiments were echoed in subsequent Russian statements. However, the incident also signals a slight shift in Moscow's approach to

Pakistan divergences also stems fence system and BrahMos from Moscow's efforts to strengthen its relationship with Islamabad. Since the dissolution of the Soviet Union. Russia's foreign policy has become more flexible, opening up new avenues for engagement with Pakistan. Although high-level exchanges were sporadic during the 1990s and 2000s, the past decade has witnessed a steady expansion of Russia's security dialogue with Pakistan. Political consultations on counter-terrorism and joint antiterrorism drills have assumed increasing importance. Moscow has also prioritised its partnership with Islamabad in the context of developments in Afghanistan, operating on the assumption that Pakistan wields considerable influence over Afghan affairs. On 22 April 2025, Moscow hosted a meeting of the Russia-Pakistan working group on counter-terrorism and other security challenges, where both sides acknowledged "the proximity of key approaches in the fight against terrorism." This was followed by a visit from Russian Deputy Foreign Minister Andrey Rudenko to Islamabad, where he co-chaired inter-ministerial consultations that reviewed the "positive dynamics" of bilateral cooperation across various domains. That said. Russia-Pakistan ties continue to face several structural limitations, ranging from Pakistan's financial and political instability to payment issues and logistical hurdles. Despite regular political and diplomatic engagement between the two sides and the stated intention to upgrade their economic relationship, several ambitious projects-such as the Karachi-Lahore gas pipeline, dubbed the Pakistan Stream Gas Pipelinehave not moved forward. The bilateral trade remains modest, barely exceeding US\$ 1 billion, and is primarily composed of Russian agricultural exports. The growing Pakistan-Russia cooperation and their convergence on security issues should not be misconstrued as New Delhi losing prominence in Moscow's strategic calculus. Since the Russia-Ukraine war began, India has gained greater salience in Russia's foreign policv, with New Delhi emerging as Russia's second-largest trading partner, and bilateral trade reaching a record US\$ 66 billion in 2024. The two countries have also made notable strides in enhancing international transit and logistics, collaborating on key trade corridors such as the International North-South Transport Corridor and the Eastern Maritime Corridor. Even with their bilateral military-technical partnership on a progressive decline—given India's diversification of military acquisitions-New Delhi continues to express interest in procuring additional weapons and platforms from Russia. Given that the S-400 air de-

missiles played a key role in shaping India's posture during the latest crisis, India and Russia are likely to intensify efforts to co-produce new equipment.

In Russia's calculus, its bilateral cooperation with India and Pakistan is not directed against a third country. Since the 2019 Pulwama attack, Russian experts have argued that Moscow seeks to avoid being coerced into taking sides in the Indo-Pakistani conflict. Rather, it aims to de-escalate tensions and foster trust through bilateral and multilateral mechanisms such as the Shanghai Cooperation Organisation (SCO). Russia's balancing act between India and Pakistan has become more complicated since 2017, when both New Delhi and Islamabad joined the SCO. Despite its modest track record in addressing security threats across Eurasia. Moscow continues to invest considerable effort in promoting the SCO as a flagship regional organisation. Given that both India and Pakistan are members of the SCO's Regional Anti-Terrorist Structure (RATS), regularly participating in SCO Peace Mission exercises, Moscow is compelled to maintain a delicate balance between the two whenever new tensions arise. The recent conflict between New Delhi and Islamabad has underscored the fragility of the SCO's expanded membership. Although the organisation is not mandated to intervene in bilateral disputes. strained relations between India and Pakistan will inevitably spill over into its agenda. The post-Pahalgam dynamics make it clear that no consensus on regional security can be reached under the SCO umbrella unless Pakistan begins to address the issue of cross-border terrorism effectively. Until then, multilateral forums will remain mired in discord, placing Russia, a principal proponent of the SCO, n a tough spot. However idealistic Moscow's vision of Eurasia as a zone of stability and cooperation may appear, it remains a consistent feature of its regional policy. Both New Delhi and Islamabad hold distinct significance in Russia's approach to the broader region. India's prominence stems not only from its historical ties with Russia and the scale of its market, but also from Moscow's longstanding advocacy for trilateral cooperation between Russia, India, and China (RIC) on regional affairs. Pakistan, on the other hand, is viewed as a key player in efforts to forge a regional consensus on Afghanistan, an objective Russian diplomacy pursues through various multilateral initiatives, including the 'Moscow Format'. Russia's farreaching ambitions for Eurasia suggest that it will remain inclined to maintain a neutral stance in future confrontations between India and Pakistan. (Courtesy: ORF)

According to him, the return of Chagos is not just the return of territory, but the restoration of dignity and India's role in this was invaluable. India's Ministry of External Affairs called the agreement a "historic resolution" and said it would serve as a milestone for stability, cooperation, and peace in the Indian Ocean region.

There was, however, a minor but sensitive hurdle along the way. A Chagos native, Beatrice Pomp, filed a petition in a British court expressing concern that if the islands were handed over to Mauritius, she might not be allowed to return. The court temporarily halted the agreement, but the injunction was

the Indo-Pak calculus, suggesting a marked neutrality in Russia's diplomatic stance between New Delhi and Islamabad. This shift appears to be influenced by the growing Russia-West contestation as well as regional geopolitical realignments. which have elevated Pakistan's importance in Russia's strategic outlook

It may be tempting to view Russia's neutrality in the latest flashpoint between New Delhi and Islamabad as a new development. Following this logic, one might even draw a parallel with India's nuanced stance-"on the side of peace"-regarding the war in Ukraine. However, Moscow's careful and balanced navigation of India-Pakistan tensions is not new. In 2019, Russia struck a similar balance following the terrorist attacks in Pulwama. Much like after the Pahalgam attack, Russia was deliberately cautious in its choice of words. The content of Russian press statements following the Putin-Modi phone calls on 28 February 2019 and 5 May 2025 was notably similar, with both parties condemning terrorist attacks and reaffirming their commitment to combating ter-

rorism together. On both occasions, Russian Foreign Minister Sergey Lavrov offered to mediate the conflict.

However, in the latter case, any prospective talks with his Pakistani counterpart. Ishaq Dar, hinged on the condition that both sides were "willing" to accept such mediation. Missing in both cases was explicit support for India's actions and an acknowledgement of New Delhi's right to self-defence. Since 2019, Russia has also refrained from criticising Pakistan for its links to cross-border terrorism. A careful reading of Moscow's statements might even suggest that India is up against unidentified global terrorist groups in Kashmir with no discernible regional base or connection to Pakistani soil. Elon Musk leaving Trump administration after leading effort to slash federal govt

WASHINGTON, May 29: Elon Musk is leaving his government role as a top advisor to US President Donald Trump after spearheading efforts to reduce and overhaul the federal bureaucracy. His departure, announced on Wednesday evening, marks the end of a turbulent chapter that included thousands of layoffs, the evisceration of government agencies and reams of litigation.

Despite the upheaval, the billionaire entrepreneur struggled in the unfamiliar environment of Washington, and he accomplished far less than he hoped.

He dramatically reduced his target for cutting spending — from USD 2 trillion to USD 1 trillion to USD 150 billion — and increasingly expressed frustration about resistance to his goals.

Sometimes he clashed with other top members of Trump's administration, who chafed at the newcomer's efforts to reshape their departments, and he faced fierce political blowback for his efforts.

Musk's role working for Trump was always intended to be temporary, and he recently signalled that he would be shifting his attention back to running his businesses, such as the electric automaker Tesla and the rocket company SpaceX.

But administration officials were often vague about when Musk would step back from his position spearheading the Department of Government Efficiency, known as DOGE, and he abruptly

Israel authorises more settlements in the occupied West Bank

JERUSALEM, May 29: Israel said Thursday it would establish 22 Jewish settlements in the occupied West Bank, including the legalisation of outposts already built without government authorisation. Israeli strikes on the Gaza Strip meanwhile killed 12 people overnight, health officials said.

Israel captured the West Bank, along with Gaza and east Jerusalem, in the 1967 Mideast war, and the Palestinians want all three territories for their future state. Most of the international community views settlements as illegal and an obstacle to resolving the decades-old conflict.

Defence Minister Israel Katz said the settlement decision "strengthens our hold on Judea and Samaria," using the biblical term for the West Bank, "anchors our historical right in the Land of Israel, and constitutes a crushing re-

Musk described it as a "massive spending bill" that increases the federal deficit and "undermines the work" of his Department of Government Efficiency. "I think a bill can be big or it could be beautiful. But I don't know if it could be both," Musk said.

Speaking in the Oval Office on Wednesday, Trump defended his agenda by talking about the delicate politics involved with negotiating the legislation.

"I'm not happy about certain aspects of it, but I'm thrilled by other aspects of it," he said. Trump also suggested that more

changes could be made. "We're going to see what happens. It's got a way to go," he said.

Republicans recently pushed the measure through the House and are debating it in the Senate. Musk's concerns were shared by

some Republican lawmakers. "I sympathise with Elon being discouraged," Wisconsin Senator Ron Johnson said.

Speaking at a Milwaukee Press Club event on Wednesday, Johnson added that he was "pretty conthere was enough fident" opposition "to slow this process down until the president, our leadership, gets serious" about reduc-He said there ing spending. was no amount of pressure Trump could put on him to change his position.

Speaker Mike Johnson asked senators to make as few changes to the legislation as possible, saying that House Republicans reached a "very delicate balance" that could be upended with major changes.

The narrowly-divided House will have to vote again on final passage once the Senate alters the bill. On Wednesday, Johnson thanked Musk for his work and promised to pursue more spending cuts in the future, saying "the House is eager and ready to act on DOGE's findings"

US will begin revoking visas of Chinese students: Marco Rubio

WASHINGTON, May 29: Secretary of State Marco Rubio said on Wednesday the US will begin revoking the visas of some Chinese students, "including those with connections to the Chinese Communist Party or studying in critical fields"

Rubio said in his announcement posted on X that the government will "aggressively" revoke visas for students from China, which is the second-largest country of origin for international students in the United States, behind only India. In the 2023-2024 school year, more than

270,000 international students were from China, making up roughly a quarter of all foreign students in the United States.

On Tuesday, Rubio halted the scheduling of new visa interviews for international students as the department prepares guidelines for increased vetting of their activity on social media. The announcements from the State Depart-

ment added to the uncertainty for America's international students, who have faced intensifying scrutiny from President Donald Trump's administration.

University of Wisconsin-Oshkosh student Vladyslav Plyaka was planning to visit Poland to see his mother and renew his visa, but he doesn't know when that will be possible now

"I want to make sure the foreign students are people that can love our country," Trump told reporters in the Oval Office.

Earlier this year, the US Immigration and Customs Enforcement arrested and tried to deport students who had been involved in campus protests against the Israel-Hamas war.

The Trump administration abruptly terminated the legal status of thousands of international students before reversing itself and then expanding the grounds on which students can

Tagging Tharoor's remarks on surgical strikes, Raj had said on Wednesday, "My dear Shashi Tharoor, Alas! The West Bank is home to 3 million Palestinians, who live under Israeli military rule, with the Western-backed Palestinian Authority administering population centers. The settlers have Israeli citizenship.

Ísrael has accelerated settlement construction in recent years long before Hamas' October 7. 2023, attack ignited the war in Gaza — confining Palestinians to smaller and smaller areas of the West Bank and making the prospect of establishing a viable, independent state even more remote. During his first term, Presi-Donald Trump's dent administration broke with decades of US foreign policy by supporting Israel's claims to territory seized by force and taking steps to legitimise the settlements. Former President Joe Biden, like most of his predecessors, opposed the settlements but applied little pressure to Israel to curb their growth. The top United Nations court

ruled last year that Israel's presence in the occupied Palestinian territories is unlawful and called on it to end, and for settlement construction to stop immediately. Israel denounced the non-binding opinion by a 15-judge panel of the International Court of Justice, saying the territories are part of the historic homeland of the Jewish people

Calls for settlements in warravaged Gaza

Israel withdrew its settlements from the Gaza Strip in 2005, but leading figures in the current government have called for them to be re-established and for much of the Palestinian population of the territory to be resettled elsewhere through what they describe as voluntary emigration. (AP)

UK flags new Indian market for Scottish salmon trade after FTA

LONDON, May 29: The UK government has flagged the unlocking of the Indian market for Scottish salmon following the Free Trade Agreement (FTA) with India, finalised earlier this month and expected to be formally signed off in the coming weeks.

Downing Street has this week been highlighting benefits of the India-UK FTA and other trade pacts struck in its wake with the US and European Union (EU) in an effort to showcase the sectors and regions across the United Kingdom set to benefit.

"These trade deals deliver long term security for people in Scotland. They will create opportunities for more seamless trade and attract inward investment to grow the economy, making a difference to people's lives," Prime Minister Keir Starmer said in a statement

"These changes will be felt everywhere, whether it's lower food prices at the checkout, more choice for consumers and higher living standards that will improve livelihoods across Scotland," he said.

Downing Street noted that the FTA had "unlocked a new salmon market through our deal with India, with tariffs dropping from 33 per cent to 0 per cent". "Securing frictionless access to key markets such

as the EU, along with expanding opportunities in India, is crucial to protect our producers from unnecessary barriers like tariffs and red tape," said Tavish Scott, chief executive of Salmon Scotland, the key representative of the sector.

"Ministers rightly recognise salmon as the jewel in the crown of our world-class produce and its vital role in the economy of coastal communities and across the UK." he said.

However, in Scotland, the spotlight remains on the whisky industry which is set to see tariffs for exports to India slashed significantly over the next decade following what the UK has dubbed as a "landmark deal" - agreed on May 6 and expected to add an extra GBP 25.5 billion annually in the long run to the current two-way trade of GBP 41 billion.

Under the pact, Scottish distillers will immediately see tariffs halved from 150 per cent to 75 per cent and eventually to just 40 per cent over the next decade.

UK Business and Trade Secretary Jonathan Revnolds said: "The three landmark deals secured this month with the US, India, and the EU have shown this government is serious about striking the deals that our businesses want and need.

"For Scottish businesses, these deals will mean stability and jobs protected as they seize new opportunities to sell to some of our biggest trading partners." "From our world-renowned whisky distilleries to our cutting-edge green energy sector, Scotland has so much to offer international markets..." (PTI)

ROME, May 29: An all-party delegation led by BJP MP Ravi Shankar has met senior Italian officials to reaffirm India's "zero-tolerance" stance on terrorism and New Delhi's resolve to combat all forms of terror.



Diseases (VPD) Surveillance. According to an official statement, the meeting was convened with the primary objective of strengthening the RI microplanning mechanism to ensure that every child, especially in the remotest parts of the district, retimely and complete ceives immunisation.

to promote scientific and sustainable farming Krishi Raths flagged off from Khartooth and Jemeithang to spread agricultural awareness

NAMSAI, May 29: In a concerted effort to empower farmers and promote scientific and sustainable agricultural practices, the Viksit Krishi Sankalp Abhiyan (VKSA) was formally launched in Tawang district on Thursday.

The campaign was inaugurated by Tawang Deputy Commissioner Kanki Darang at Khartooth village, marking the beginning of an intensive district-wide outreach programme under the national initiative of the Union Ministry of Agriculture and Farmers Welfare.

ALIPURDUAR (WB), May 29: Prime Minister Narendra Modi on Thursday said 'Operation Sindoor' was far from over and warned that India would continue to exact a heavy price on those who sponsor terrorism, asserting that Pakistan has already been hit "three times inside its home.'

Addressing his first rally in West Bengal since the launch of 'Operation Sindoor' earlier this month, the PM invoked the region's deep cultural and emotional connection with 'sindoor', referring to the traditional ritual of 'Sindoor Khela' observed by Bengali women during Durga Puja, to reinforce India's hardened stance against terrorism.

"Now that I am standing on the sacred land of 'Sindoor Khela', it is only right that we speak about a new resolve against terrorism 'Operation Sindoor'," Modi said to loud cheers.

He added, "On April 22, the brutal terrorist attack in Pahalgam shook the nation. The pain and anger felt across West Bengal were deeply understood. I could feel your outrage. The terrorists dared to wipe off 'sindoor' from the foreheads of our sisters. But our brave soldiers made them realise the power of that sindoor'.

"From this land of Bengal, I, on behalf of 140 crore Indians, declare


"Terrorism and mass murder are the biggest expertise of the Pakistani army, because whenever there is an open war, they face defeat," he added.

NEW DELHI, May 29: People of Pakistan-Occupied Kashmir (PoK) are part of India's "own family" and the day is not far when they will return to the Indian mainstream by listening to their inner voice. Defence Minister Rajnath Singh said on Thursday.

Laying out India's policy approach towards Pakistan, Singh said New Delhi has "redesigned and redefined" its strategy and response to terrorism and that possible dialogue with Islamabad will be only on terrorism and PoK.

In an address at the CII Business Summit, he said 'Make-in-India' in the defence sector has been an essential component in the country's national security and it played a key role in India's effective action against terrorism during Operation Sindoor.

In the remarks, Singh appeared to be largely attempting to reach out to people of PoK saying India considers them to be part of its "own" family and exuded confidence that they will return voluntarily.

"I believe that the people of Pakistan Occupied Kashmir (PoK) are our own, part of our family," he said.

"We are committed to the resolution of 'Ek Bharat Shreshtha Bharat' (One India, Best India) and we have full faith that those of our brothers who are geograph-

ically and politically separated from us today, will also return to the mainstream of India someday or the other with self-respect, listening to their voice of soul," he said

People of PoK part of Indian family, day not

Most of the people there feel a deep connection with India, there are only a few who have been misled, he said

The defence minister said the unification of the PoK with India depends on "the cultural, social and economic prosperity of this country"

He said most of the people in PoK feel a "deep connection" with India and only a few of them have been 'misled"

"The situation of our brothers and sisters living in PoK is similar to that of Shakti Singh, the younger brother of brave warrior Maharana Pratap.'

"Even after separation, the confidence and faith of the elder brother towards his younger brother remains intact," Singh said.

"India always talks about connecting hearts, and we believe that by walking on the path of love, unity and truth, the day is not far when our own part, PoK, will return and say, I am India, I have returned," he said.

In a clear message to Pakistan, Singh also said the business of terrorism is not cost effective and it will come with a heavy price as Islamabad has realised now. His comments came three days after Prime Minister Narendra Modi said it is for the vouth of Pakistan to step forward and "free Pakistan from the disease of terrorism"

The defence minister described 'Make-in-India' as crucial for national security and prosperity, stating that the use of indigenous systems during Operation Sindoor has proved that India has the power to penetrate any armour of the enemy.

"We destroyed the terrorist hideouts and then the military bases. We could have done a lot more, but we presented a great example of coordination of power and restraint," he said. In his remarks, Singh also highlighted India's domestic defence capabilities.

India's defence export was less than Rs 1000 crore 10 years ago but it has now reached a record figure of ₹ 23,500 crore, he said. (*PTI*)

Congress accuses BJP of trying to take political advantage of Operation Sindoor

NEW DELHI, May 29: The Congress on Thursday accused the BJP of trying to take political advantage of Operation Sindoor with its reported plans to distribute vermilion among women across the country and said that the drive was a "shield" to hide the Modi government's "political and diplomatic failure"

Congress spokesperson Ragini Navak referred to reports that have claimed the Modi government is preparing to take the success of Operation Sindoor to every household under which 'sindoor' will be given to women as a gift from June 9, when the Modi government completes one year of its third term.

"It is a matter of great shame that the Modi government wants to use the vermilion as a shield to hide its political and diplomatic failure. How low will the Modi toon to take credit for the val ery of the armed forces?" she asked at a press conference Madhya Pradesh Deputy CM Jagdish Devda has also said at the party's headquarters at 24, Akbar Road here. The BJP has officially not shared any details of its plans for

its anniversary celebrations to mark one year of 'Modi government 3.0'. There was no immediate comment from the ruling party on the Congress' claims.

"When Narendra Modi was not satisfied with putting up big posters of Operation Sindoor in every district and every corner of the country with his photo on it and by dressing up in army uniform... Now, the BJP has announced that it will go door-to-door and distribute 'sindoor'." Navak claimed.

If the BJP wants to go door-to-door and distribute vermilion, then it should first answer for whom and for what will this 'government vermilion' given by strangers be useful, the Congress spokesperson asked. "Don't the selfproclaimed 'contractors of Hinduism' know that the sindoor (vermilion) in the parting of a Hindu Sanatani married woman's hair is applied by her husband or she gets it from her in-laws or from a Shakti Peeth/temple as a blessing for good fortune?" Nayak asked.

"How can the BJP-RSS people distribute vermilion among women when terrorists who ruined the married life of the women (in the Pahalgam terror attack) have not been killed yet?" she asked. Nayak claimed the box in which the vermilion will be kept will also have Prime Minister Narendra Modi's photo printed on it.

"BJP MLA Ranveer Singh Pathania says, 'The Air Force is useless because they were sleeping when Pakistan was attacking'. All this is happening, but Narendra Modi is silent. that the whole country, the entire army bows at the feet of Narendra Modi," she claimed. (PTI)

Pune teen student, held for Op Sindoor post and later granted bail, appears for exam: HC told

MUMBAI, May 29: The Pune teen student, arrested for her social media post criticizing the Indian government over Operation Sindoor and later released on bail, has appeared for her semester examination under requisite security, her lawyer told the Bombay High Court on Thursday.

The high court had on Tuesday slammed the Maharashtra government for its "absolutely shocking" and "radical" reaction to the engineering student's post and for arresting her.

The court ordered immediate release of the 19-vear-old, originally from Jammu and Kashmir. from Pune's Yerwada Central Jail, noting the police were "bent upon ruining her life" and turning her into a "hardcore criminal".

The court had also suspended the rustication order issued by the student's college Sinhgad Academy of Engineering, and permitted her to appear for ongoing second year semester examinations. KOHIMA, May 29: Five major Naga tribes of Nagaland on Thursday held protest rallies in various districts, demanding a review of the state's job reservation policy.

GANGTOK, May 29: Prime Minister Narendra Modi on Thursday said the Pahalgam terror strike last month was an attack on the soul and unity of India, and subsequent Operation Sindoor was a "decisive response" to terrorists.

He asserted that the country was united in its fight against terrorism, adding that India gave a befitting reply and destroyed terror infrastructure and several airbases in Pakistan.

Describing the Pahalgam attack as a "deliberate attempt" to create a rift in India on religious lines, Modi said, "We sent out a clear message that India is united despite the terror strike which erased sindoor of some of our sisters.'

At least 26 people, mostly tourists, died in the April 22 terror attack in Pahalgam. The execution-like killing by terrorists after reportedly asking about the victims' faith left the entire country grieving and outraged.

Addressing the 50th anniversary of Sikkim's statehood function at Paljor Stadium here, Modi said the Himalayan state is the "pride of the nation" and its people believe in democracy.

The prime minister regretted that he could not at-

tend the function at the statehood celebrations due to inclement weather, but assured that he would visit the state in future.

Pahalgam terror strike was attack on India's

"Operation Sindoor against terrorists in the wake of the Pahalgam attack was a befitting reply to those who unleashed terror in India. What terrorists did in Pahalgam was an attack on humanity, and we are now united in the fight against terrorism," the PM said virtually from Bagdogra in West Bengal.

The PM inaugurated a slew of infrastructure projects and laid the foundation stones of several others. The projects inaugurated by Modi included a 500bed District Hospital in Namchi, 'Swarna Jayanti Maitreya Manjari' (at White Hall, Ridge Park), a passenger ropeway at Pelling to Sangacholing Monastery, a 'gaushala' at Mamring and a statue of former prime minister Atal Bihari Vajpayee in Gangtok district.

He also laid the foundation stones for a district hospital at Pakyong, a visitor experience centre at Nathula, and the conversion of Singshore Bridge into a glass skywalk.

He also unveiled the Bhaleydunga Skywalk project, a working women's hostel at Gangtok (Tadong), Swarna Jayanti Convention Centre at Namli, and Swarna Jayanti Sports and Cultural Centre near Gangtok.

Tripura braces for extreme rainfall; Govt issues advisory, emergency depts on alert

AGARTALA, May 29: The Tripura government on Wednesday has issued a high-alert advisory in anticipation of extremely heavy rainfall across the state from May 28 to 31, as predicted by the India Meteorological Department (IMD). District authorities and emergency services have been directed to remain on standby, with evacuation and relief measures to be initiated as necessary.

In an official order signed by Deputy Secretary C.K. Malsom, the government cited a Special Weather Bulletin from the IMD's Agartala Meteorological Centre, warning of "heavy to very heavy rainfall, with isolated instances of extremely heavy showers accompanied by squally and gusty winds" during this period.

The adverse weather conditions are attributed to a low-pressure area that has developed over the northwest Bay of Bengal, off the Odisha coast.

"All District Magistrates have been instructed to closely monitor the situation and ensure readiness of all disaster response units, including the NDRF, SDRF, Tripura State Rifles (TSR), Fire and Emergency Services, and trained volunteers," the order stated. Authorities have also been asked to identify vulnerable locations, maintain surveillance on rivers, embankments, and catchment areas, and to initiate timely evacuations from low-lying regions to designated shelters.

"Rescue equipment such as boats, life jackets, and other flood-relief tools must be kept in readiness. If the situation demands, immediate deployment of response teams is essential," the advisory added.

Damage assessments are to be conducted without delay, with all districts required to report their findings and the actions taken to the State Emergency Operation Centre (SEOC) by 2:00 PM daily.

Ajay Devgn, Kajol support eight-hour shift for mothers in the film industry

MUMBAI, May 29: In an industry known for its unpredictable schedules and long hours, Bollywood actor couple Kajol and Ajay Devgn on Thursday backed for an eight-hour shift, particularly for working mothers, during movie shoots.

At the trailer launch of "Maa". Devgn and Kajol were asked to comment on the demand for an eighthour shift for working mothers.

"I love the fact that we can work less," Kajol told reporters here.

Devgn said "honest" filmmakers in the industry are open to the idea of an eight-hour shift.

"It's not that it's not going well (the demand for eight hour shift); people understand it. Most of the honest filmmakers will not have a problem with this (demand). Apart from working mothers, many others have usually started working for eight to nine hours. So, it is person-to-person, and most of the industry understands this," the actor-producer said.

Actor Deepika Padukone's alleged exit from Sandeep Reddy Vanga's "Spirit" after the two did not agree over an eight-hour working shift among other conditions has sparked a discussion around shooting hours

in the industry.

Padukone and Vanga never officially announced that they were collaborating but Vanga recently accused an unknown actor for playing "dirty pr games" and revealing key plot details in media. He later announced Triptii Dimrri as the heroine of the movie.

"Maa" features Kajol in the titular role and is directed by Vishal Furia, who is known for his work on "Lapachhapi", "Criminal Justice" and "Chhorii"

Devgn, who is producing "Maa", said he was instantly attracted to the idea of making a mythological horror movie, and thought of roping in his actor wife Kajol for it.

"When Saiwyn (Quadras, writer) narrated to me the thought of this film ('Maa'), I realised a lot of films in the horror genre are being made, like horror-comedies, but no one has attempted mythological horror.

"Hollywood often makes characters despite not having a mythological reference, but we don't use it. It was a great idea, and we decided to do it. The character of the mother was so strong, so who else could we think of apart from her (Kajol)," the

superstar said. Kajol said she is happy to feature in a horror movie. "For the first time, a mytho-

logical horror is attempted, and I'm happy to be part of it. I'm excited," the actor said, adding, "I've never been approached for a horror film. This time, the casting was in-house."

When asked about similarities between "Maa" and "Chhorii", Furia said the only common thread between them is that they both narrate the ordeal of a mother trying to protect their daughter.

"The only similarity is that both stories are about mothers. But in this film, we are talking about Kali Maa, which is a bigger entity; this world is much bigger. It is a cinematic experience, and you can't watch it at

home. The vision is of sir (Devgn), and the script is Saiwyn sir (Quadras)," the director said.

Devgn, who has been a part of horror movies like "Bhoot" and "Shaitaan", said he fails to understand why the horror genre was not popular in the past. "I don't know why the horror genre was not attempted with a bigger star cast before. It was not done for many years. I've always felt that it is a strong genre," he said.

Slated to be released in cinema halls on June 27, "Maa" also stars Indraneil Sengupta, Kherin Sharma and Ronit Roy.

Norway Chess: Gukesh beats Nakamura to get campaign back on track

STAVANGER (NORWAY), Ma 29: World champion D Gukesh brought his campaign back on track on his 19th birthday, defeating world No.2 Hikaru Nakamura of the USA in the third round to open his account even as Arjun Erigaisi suffered his first defeat in the Norway Chess Tournament here on Thursday.

Gukesh, who suffered back-toback defeats to world No.1 Norwegian Magnus Carlsen and compatriot Arjun Erigaisi in the first two rounds, put Nakamura -- one of the best Rapid and Blitz players -under time pressure to win the game in 42 moves and collect three points.

Playing with white pieces, Gukesh, who was constantly under time pressure in the last two games, was the one who got Nakamura staring at the clock in round three of the six-player double round-robin tournament.

"I feel quite good (about the win). I think my time management was much better today than before. He (Nakamura) had some drawing chances, but I guess, overall, it was good," said Gukesh as he moved to fifth spot on the points table ahead of Chinese No.1 Wei Yi.

Nakamura realised soon after the start of the game that something had gone wrong early on in a Giuoco Piano opening. He decided to reverse the situation by switching to a kingside attack that could exploit Gukesh's vulnerability after a difficult start.

NEW DELHI, May 29: The India U-23 men's national team was on Thursday drawn in Group H of the AFC U23 Asian Cup Qualifiers and will play against hosts Qatar, Bahrain, and Brunei Darussalam. The draw was conducted at the AFC House in Kuala Lumpur. Qatar, the highest-seeded team among the four, will host Group H, with the matches slated to be played between September 1 to 9. A total of 44 teams were divided into 11 groups of four each. The group winners and the four best runners-up, alongside hosts Saudi Arabia, will complete the cast of 16 teams for the seventh edition of the AFC U23 Asian Cup, which will take place in January 2026.

The seedings for the draw were based on a points system derived from the teams' final rankings across the previous three editions of the tournament. India were placed in Pot 3. India had earlier appointed Naushad Moosa as the head coach of their U-23 national team.

Moosa takes charge from June 1, when the Blue Colts assemble in Kolkata for a training camp, before flying off to Tajikistan to play two exposure matches against Tajikistan (June 18) and Kyrgyz Republic (June 21).

The India U-23s will utilise all the FIFA international windows to set camp and play exposure friendlies to prepare for the AFC U23 Asian Cup qualifiers, the All India Football Federation (AIFF) said.

Carlos Alcaraz overcame a one-set blip to defeat Fabian Marozsan 6-1, 4-6, 6-1, 6-2, and Iga Swiatek had far less trouble dispatching 2021 U.S. Open champion Emma Raducanu 6-1, 6-2 to extend her French Open winning streak to 23 matches. Top-ranked Arvna Sabalenka won 6-3, 6-1 against Jil Teichmann.

Other women's winners included 2024 runner-up Jasmine Paolini, Olympic gold medalist Zheng Qinwen and 18-year-old Canadian qualifier Victoria Mboko. Olympic silver medalist and Wimbledon unseeded American Bernarda Pera 6-2, 4-6, 7-6 (10-3). No. 10 Holger Rune of Denmark beat unseeded American Emilio Nava 6-3, 7-6 (5), 6-3 and No. 12-seeded American Tommy Paul rallied from two sets down to beat Marton Fucsovics. Other men advancing included No. 8 Lorenzo Musetti and No. 25 Alexei Popyrin. But No. 20 Stefanos Tsitsipas, the 2021 French Open runner-up, lost to unseeded Matteo Gigante.

The second round concludes with 24-time major champion Novak Djokovic taking on France's Corentin Moutet in Court Suzanne-Lenglen in a match that could feature a raucous atmosphere. Yes, definitely: Jadeja on captaincy dreams



NEW DELHI, May 29: He may not be among the names considered for the job but veteran allrounder Ravindra Jadeja says he would love to be India's Test skipper at some point, having understood the role under different captains throughout his long career. Young batter Shubman Gill was recently appointed as India's Test captain for the tour to England with wicketkeeper-batter Rishabh Pant designated to do the duty of his deputy.

"Yes, definitely! Over the years, I have played under different captains. I know the mindset of every single captain whom I have played under and I also understand what players need and their mindset," the 36-year-old Jadeja told his former India teammate Ravichandran Ashwin in a YouTube chat when asked whether Test captaincy was among his ambitions.

Jadeja, who played his first Test back in 2012, detailed some of the leadership lessons he picked up from the iconic Mahendra Singh Dhoni, under whom he made his debut in all three formats for India, besides playing together for Chennai Super Kings in the IPL.

"Every captain has a different mindset on how he wants to run the team. I have played under MS Dhoni in every format and his thinking is very simple. If he feels that a batter can hit shots in a particular region, he keeps the fielder there to make the batter uncomfortable," said Jadeja.

It may be recalled that Ashwin had also supported Jadeja for India's Test captaincy once Rohit Sharma called it quits from the red-ball format.

"Why do we forget about Ravindra Jadeja? If you are willing to go for a new person as captain. I would say why not make him an understudy of an experid guy for ty handing him the job on a full-time chance to get out of there, at that basis?" Ashwin had wondered on his YouTube channel in support of the 80-Test veteran.

Breaking down the leadership requirements in different formats, Jadeja admitted that leading in T20s can take much more out of a captain than doing that job in Test cricket.

"In Test cricket, you have to change two or three fielders as per the need of the bowler and you don't need to change the field as per batsmen.

"Captaincy in Test cricket is way more different. It's simple, but calculative. It's not complicated like IPL or T20s, where every ball is an event," said Jadeja. The premier all-rounder said he never thought of having

such a long Test career. "Honestly, when I started to play for India, I never thought I would play so many Tests. I always thought white-ball cricket was my forte and I wanted to establish there," he said.

"I was also fascinated by those coloured jerseys, numbers and names written on the back, the crowd and playing under lights, it was interesting for a young cricketer. All these were not in Test cricket then," said Jadeja.

"I also thought that Test cricket is such a long format and only those sincere players like Sachin paaji and Rahul paaji could play that format," he chuckled.

The spin-bowling all-rounder admitted that Dhoni has played an influential role in his cricketing career. They first met in 2005 during the Challenger Trophy.

"I was a kid then, so it was like he was MS Dhoni and when I saw him on the flight, he had long hair. Our manager said that we have to go with Dhoni from the airport to the team hotel.

"I was hesitant and thought, how can I go with him?" he recalled

"Luckily, his phone got dropped on the floor and he had to wait. I thought this was the

Hardik has got the love of the fans back after being booed on his return to the team last year and an IPL trophy will cement his place in the list of the fabled greats of the franchise.

But in their pursuit of glory, both leaders must find a way to address the issues at hand.

Titans have more to be worried about as they have lost momentum going into the play-offs. Having conceded 465 runs in their last two defeats, they need to up their game with the ball.

Mohammed Siraj, the de facto leader of the pace battery, will need to provide breakthroughs in the powerplay.

The struggles of left-arm pacer Arshad Khan with the new ball has added pressure on the likes of Prasidh Krishna who has been the Titans' trump card this season with 23 wickets.

In addition to the shortcomings in the pace department, the ineffectiveness of spin allrounder Rashid Khan has aggravated their bowling woes.

On the batting front, the top three, including Sai Sudharsan, Gill and Jos Buttler contributed massively to their play-off journey. Considering that, the absence of Buttler.



who left for national duty after the league stage, is bound to be felt. Kusal Mendis has been roped in as But-

tler's place but it remains to be seen if he can inspire the same level of confidence.

The middle-order comprising Shahrukh Khan and Sherfane Rutherford is not the most reliable, making Titans vulnerable against Mumbai Indians who would have that at the back of their mind.

Bairstow could open alongside Rohit Sharma at the top of the order. The Englishman would surely be expect-

ing to start the game, having agreed to join

Suryakumar Yadav has been doing the heavy lifting in the batting department with a record 640 runs in a season. In case he fails, Mumbai Indians will have a real task at hand.

Batting first, the pace at which Mumbai batters score has also been questioned and that is another area Hardik will have to focus on.

However, their strong bowling attack always poses a bigger threat to the opposition.

"Batting, we'll figure out what is the right template on right tracks and if we bat first, what is the pace we want to bat. (There are a) couple of things which we need to identify, but I don't think there is panic," Hardik had said after the loss to Punjab Kings in their final league game.

Test players hope to understand English conditions in India A's 1st 'Unofficial Test' against Lions

CANTERBURY (ENGLAND), May 29: A clutch of frontline Test players, including opener Yashasvi Jaiswal and allrounder Nitish Kumar Reddy, will be eager to acclimatise to English conditions during India A's first four-day unofficial Test against the England Lions, beginning here on Friday. Apart from Jaiswal and Nitish, the India A side has Abhimanyu Easwaran, Dhruv Jurel, Karun Nair, pacers Akash Deep and Shardul

Thakur who will want to have a feel of the pronounced swing on offer here, ahead of the Test series against England, starting from June 20. It's imperative too because these players, except Karun, are on their maiden tour to England.

It starts with Easwaran. India will require an opener to partner Jaiswal at the pole position after the retirement of Rohit Sharma and a batter at No. 4 slot which was left vacant by Virat Kohli. In the context of an opener, the performance of Easwaran, who has extensive experience in the position through his 101-match-old First-Class career, will come under scrutiny. The Bengal man had come close to breaking into the first eleven on a couple of occasions in the past, but failed to get an eventual look in. Now there is an open space to explore after Rohit's departure and Easwaran will certainly want to produce a stellar effort to lock his place either as an opener or No. 3 in the five-match Test series. The right-hander, who has a compact technique, can be used as No. 3 as well if the selectors want to make KL Rahul the opener. In that case, newly-appointed skipper Shubman Gill can be slotted in at No. 4

Karun's outings too will be in focus after forcing his way back to the India team after eight years on the back of a stellar run in the domestic circuit since the 2023-24 season.

The experienced batter is a favourite to find a place in the middle-order, and he also has considerable experience of English conditions while playing County cricket for Northamptonshire. Nitish Reddy was very impressive in the 2024-25 Test series against Australia, having made 298 runs from five Tests at an average of 37 including a gutsy hundred. But the inclusion of Thakur, himself a capable lower-order batter, in the Test squad as well as in the 'A' team is an indication that the Indian management is in the hunt for some more firepower in bowling.

Therefore, Reddy will be keen to stay ahead of the competition with a fruitful outing both with bat and ball.

Dhruv Jurel, who is also a part of the Test outfit, and Sarfaraz Khan, who missed out on Test selection, will like to keep themselves ready if a call comes their way at some stage of the five-match series.

World Cup Tune-up: India Women to host Australia Women for three ODIs in September

NEW DELHI, May 29: India Women will play their counterparts from Australia in a three-match ODI series at home in September as part of the preparations for the ICC World Cup which the country is hosting later this year, the BCCI said on Thursday. The board also said the men's 'A' teams from Australia and South Africa will be touring the country from September-November during which they will play multi-day and limited overs cricket matches.

"The Australian Women's team will tour India for a threematch One Day International series, serving as crucial preparation ahead of the ICC Women's Cricket World Cup 2025," the BCCI said in a statement.

The three matches of the women's series will be played at the M. A. Chidambaram Stadium in Chennai. The games are scheduled on September 14, 17 and 20.

The 50-over Women's World Cup is scheduled to be held across multiple venues in India from September 29 to October 26. Around the same time, the Australian men's A team will also be touring India for a series featuring two four-day matches and three One-day games.

The tour will begin with a four-day match in Lucknow from September 16-19 with the second game also being scheduled at the same venue from September 23-26 The three one-day matches will be held from in Kanpur on September 30, October 3 and 5. The contests against the Aussies will be followed by matches against the visiting South Africans in October-November. (PTI)

Performance of uncapped players instrumental to our success: Ricky Ponting



MULLANPUR, May 29: Ricky Ponting, who is getting major credits for Punjab Kings' massive turnaround in the IPL after years of disappointment, feels their radical auction strategy and the performance of uncapped players allowed him to execute his coaching philosophy of playing "differently" this season.

Punjab Kings are in their first play-offs since 2014 but considering his world-conquering achievements, the Australian legend is not satisfied with finishing at the top of the league stage.

He has won the IPL title as player and head coach of Mumbai Indians but could not get his hands on the trophy while coaching the Delhi Capitals for seven season.

Before he signed up for the job at Punjab Kings, he made it clear to the owners that he wanted complete control over the running of the team

The free hand given to him has produced instant results, starting from his auction strategy to retain only the uncapped duo of Prabhsimran Singh and Shashank Singh. In an interview to PTI ahead of the IPL playoffs, Ponting covered all areas that got the franchise much-needed success. Excerpts from the interaction. Q. This has been a massive turnaround for this team after years of under-performance. What would you put that down to?

A. When you say this team, it's really this franchise, it's not this team, this team is brand new. Once I got the job, I wanted to make sure that things were different around this team, around this franchise and, we went with a slightly different passage into the auction with just retaining the two younger uncapped players and we copped a bit of criticism for that at the time.

People thought we got that strategy wrong, but I was very clear on the vision that I had where I wanted this franchise to go and we picked the appropriate players to give me the best chance of attaining the vision that I set out with. So far it's been a good season...The fact that I think (in the) last game against Mumbai Indians, we had six uncapped players on our side, all of which are playing exceptionally good cricketers.

This whole season so far hasn't been about qualification. We've talked a bit about giving ourselves the best chance to finish 1-2, and we know now that we've actually finished in first position on the table after the league stage. I've got a good feeling. This group's been terrific and not just the 25 players, we've all been in this together.

Q. Did you have a point to prove after not being able to win a trophy at Delhi Capitals for seven years though you did win one at Mumbai Indians? A. I'm not sure if I had a point to prove. With the good squads that I had in DC, it was pretty evident to

see where we made it with good players in that squad. We had three years in a row where we made the playoffs. One of those was into a final that Mumbai beat us in.

I made it pretty clear that when I accepted the head coach's job (with Punjab Kings) that I wanted to have pretty much full autonomy over the way that we go about the coaching staff and the way that we go about putting the strategy together with the auction, our scouts did a terrific job. We got the players that we wanted, whether they'd

be younger players or more experienced overseas players. And that's been shown so far that, with (Glenn) Maxwell and Lockie Ferguson getting ruled out early in the tournament, we've hardly skipped a beat.

Our Indian core has been terrific for us. And, our captain (Shreyas Iyer), as a leader he has been magnificent. So a lot of it revolves around that, the dynamic that he and I have together.

Q. You spoke highly about your uncapped players (Priyansh Arya, Prabhsimran, Nehal Wadhera, Shashank, Harpreet Brar, Vijavkumar Vyshak). Can any of them go on to play for India in the near future?

A. There is four of them who can. You look at Priyansh Arya. He has been a revelation for us at the top of the order. I must have watched, I don't know how many hours of video I watched on him going into the auction, but he was the one that I wanted to make sure that we got.

Prabh is probably the obvious one when you talk about playing for India. Still only 24 years of age. I read somewhere the other day that he's now got the most runs for an uncapped player in IPL history.

Wadhera is someone that I think could play for India as well in the middle order. And Shashank, you've only got to look at the cold, hard numbers with him. His strike rate and boundary percentage at the end of innings is as good as anyone going around.

So again, this year, he struck at 185 or something like that (in the league stage). All four of those guys could play. As I said, Brar's been outstanding for us, Vyshak is also on the radar (for the national selectors). Q. Following your chats with the owners and the management, were there any lessons learned from the failures of the past?

A. I did speak to the management. My big mantra this year was to be different, to make this place feel different, look different from the outside, you know be really daring with the way that we play our cricket, be really dynamic and not sit back and wait for opportunities to arise to go and create opportunity and create momentum in games for ourselves.

I'm not a big media reader. I don't look at social media a lot. But what I've been hearing and the vibe I've been getting is that what we've been able to create around this team has been pretty cool. (PTI)
