Vain and preposterous: New Delhi on Beijing renaming places in Arunachal

NE state an integral part of India, says MEA

NEW DELHI, May 14: India on Wednesday outrightly rejected as "vain and preposterous" China renaming some places in Arunachal Pradesh and said such attempts will not alter the "undeniable" reality that the state "was, is, and will" always remain an integral part of India.

New Delhi's reaction came in response to Beijing announcing Chinese names for some places in Arunachal Pradesh, which the neighbouring country claims as the southern part of Tibet.

"We have noticed that China has persisted with its vain and preposterous attempts to name places in the Indian state of Arunachal Pradesh," External Affairs Ministry Spokesperson Randhir Jaiswal said.

"Consistent with our principled position, we reject such attempts categorically," he said.

Jaiswal was responding to a media query on the issue.

"Creative naming will not alter the undeniable reality that

will always remain an integral and inalienable part of India," he said. In April last year too, India had

reacted sharply when Beijing re-

leased a list of standardised names of 30 places in Arunachal Pradesh. The Chinese Civil Affairs Ministry released the first list of the standardised names of six places in Zangnan in 2017, while the second list of 15 places was issued in 2021 followed by another list with

names for 11 places in 2023. China's release of the new list of names of places in Arunachal Pradesh comes amid efforts by the two countries to normalise ties hit by the eastern Ladakh border standoff.

After a gap of nearly five years, India and China last month decided to resume the Kailash Mansarovar Yatra, a move that was seen as an attempt to repair the relationship.

The Kailash Mansarovar Yatra was suspended initially in 2020 because of the COVID-19 pandemic and subsequently because of the



military standoff between the two sides along the Line of Actual Control (LAC) in eastern Ladakh.

The militaries of India and

China completed disengagement of troops at the two remaining friction points of Demchok and Depsang under a pact sealed on October 21 last year.

Narendra Modi and Chinese President Xi Jinping held talks in the Russian city of Kazan and agreed to revive various bilateral dialogue mechanisms.

Following the Modi-Xi talks, the two sides held a series of meetings in the last few months which were aimed at normalising the bilateral

India appears to have had 'clear edge' in targeting Pak's military facilities: NYT report

pears to have had a "clear edge" in targeting Pakistan's military facilities and airfields during the recent four-day confrontation, the New York Times reported, citing satellite images.

High-resolution satellite imagery, from before and after the strikes, shows "clear damage" to Pakistan's facilities by Indian attacks, according to the report.

"The four-day military clash between India and Pakistan was the most expansive fighting in half a century between the two nucleararmed countries. As both sides used drones and missiles to test each other's air defences and hit military facilities, they claimed to inflict severe damage," the report

It added that satellite imagery indicates that while the attacks were widespread, the damage was far more contained than claimed "and appeared mostly inflicted by India on Pakistani facilities."

In the new age of high-tech warfare, the report said that strikes by appeared to be precisely targeted.

'Where India appears to have had a clear edge is in its targeting of Pakistan's military facilities and airfields, as the latter stretch of fighting shifted from symbolic strikes and shows of force to attacks on each other's defence capabilities," the report said.

At Bholari air base, located less than 100 miles from the Pakistani port city of Karachi, India's defence officials said they had struck an aircraft hangar with a precision attack. "The visuals showed clear damage to what looks like a hangar," the NYT report said.

Further, the Nur Khan air base, within a roughly 15-mile range of both the Pakistani Army's headquarters and the office of the country's prime minister and a short distance from the unit that oversees and protects Pakistan's nuclear arsenal, was "perhaps the most sensitive military target that India struck." Panchayat polls results: BJP wins all major seats

GUWAHATI, May 14: The ruling BJP and its ally AGP bagged all the major Zilla Parishads and Anchalik Panchayats across Assam, according to the rural poll results declared by the state election commission on Wednesday.

The Assam State Election Commission (ASEC) in a statement declared the final results, four days after the counting of panchayat election votes started on Sunday morning at 8 am across 39 counting centres.

Panchayat elections took place in two phases on May 2 and 7 in Assam's 27 districts for the first time after the delimitation of the constituencies

According to ASEC data, the BJP has won 1,261 members of Anchalik Panchayat (AP) constituencies, while its ally Asom Gana Parishad (AGP) has bagged 184 seats so far. Opposition Congress has won 481 seats, while 64 seats have been bagged by AIUDF, 17 by Raijor Dal, four by Trinamool (CONTD. ON PAGE-2)

NE may attract fresh investment Himanta leads 'Tiranga Yatra' in Assam of ₹ 2.5-3 lakh cr, says Scindia

NEW DELHI, May 14: Fresh investment in northeastern states may go up in the range of ₹ 2.5-3 lakh crore across sectors, Union minister Jyotiraditya Scindia said on Wednesday ahead of the business summit.

Union minister for the Development of North Eastern region (DoNER) Scindia said his ministry has received investment commitment of ₹ 1.12 lakh crore from nine roadshows organised by his ministry and does not include any old investment that has already been announced earlier.

The minister was speaking during the curtain raiser of the two-day Rising Northeast Investors' Summit 2025, scheduled to be inaugurated by Prime Minister Narendra Modi on May 23.

Scindia said the DoNER ministry will ramp up investment numbers till the summit ends on May 24.

"You got to add to this kitty, the six industrial houses that we have met and what they are going to invest. Plus, you got to add to this kitty all what the PSUs are going to invest. The rough order book should be be-

12 militants arrested from 3 **Manipur districts**

IMPHAL, May 14: Security forces have arrested 12 militants belonging to proscribed outfits and two arms dealers from Manipur, police said on Wednesday. All the arrests were made on Tuesday, they said.

Four cadres of the banned People's Liberation Army, two members of Kangleipak Communist Party and one of Kanglei Yawol Kanna Lup were apprehended near Yongkhul village in Tengnoupal district, a police officer said.

Besides, two members of the outlawed KCP (PWG) were arrested from Lilong Nungei and Wangbal in Thoubal, and two cadres of PREPAK from Koirengei Kabui Khul Gate in Imphal East.

Another active cadre of the proscribed United National Liberation Front (Pambei group), who is also an arms dealer, was held from

Pakistan hands over BSF jawan to India after 21 days



AMRITSAR, May 14: India and the Ferozepur sector on April 23 Pakistan on Wednesday handed each other's border-guarding personnel captured by the Border Security Force (BSF) and the Pakistan Rangers respectively at the International Borders (IB) between the two countries, officials

BSF jawan Purnam Kumar Shaw was handed over to India, 21 days after he was apprehended by the Rangers from along the International Border in Punjab.

Shaw was apprehended by the Pakistan Rangers a day after the Pahalgam terrorist attack in which 26 people were killed.

The officials said a Pakistan Ranger apprehended by the BSF from the Rajasthan border on May 3 was also handed back to the neighbouring country.

Constable Shaw was handed over to the BSF by the Pakistan Rangers at 10.30 am at the joint check post (JCP) Attari in Amritsar district opposite Pakistan's Wagah, a BSF spokesperson said.

A picture of the jawan released by the force showed a bearded Shaw with ruffled hair and wearing a dark green round-neck T-shirt.

"Today at 1030 hours Constable Purnam Kumar Shaw has been taken back from Pakistan by the BSF at the Attari-Wagah border,"

the spokesperson said. Shaw had "inadvertently" crossed over to the Pakistan territory while on operational duty in around 11.50 am and detained by the Pak Rangers, he said.

The officials told PTI that the jawan will undergo a full body check-up and medical test followed by a counselling and 'debriefing' session where he will be asked "relevant questions" by the BSF officials about his 21-day detention by the Rangers.

The jawan, belonging to the 24th BSF battalion, will not be drafted in active duty and will also be part of an official inquiry instituted by the Punjab frontier of the BSF to look into the sequence of his apprehension by the Rangers and find lapses, if any, they said.

The spokesperson said the handover of the jawan at the border "was conducted peacefully and in accordance with established proto-

"With the consistent efforts of the BSF through regular flag meetings with the Pakistan Rangers and through other communication channels, the repatriation of BSF constable has become possible," he

The jawan was part of the 'Kisan Guard' that was deployed for the protection of Indian farmers, who till their land ahead of the fence. The trooper apparently "miscalculated" the alignment of the IB and stepped to rest under a nearby tree from where he was apprehended by the Rangers, the officials had said. (CONTD. ON PAGE-2)

"The terrorist infrastructure sites that India destroyed were responsible not only for the deaths of Indians but of many other innocents around the world," he said.

"There is now a new normal. The sooner Pakistan gets used to it, the better," he added. Jaiswal also responded to claims by Pakistan's foreign minister Ishaq Dar in an interview to CNN in which he claimed that the Pakistani military

beat Indian armed forces.

Operation Sindoor, Pakistan has seen its terrorism centres in Bahawalpur, Muridke, Muzaffarabad and other places destroyed," the MEA spokesperson said. "Thereafter, its military capabil-

recruitment advertisement for teachers. Addressing a press conference at the Rangsina Sarpo Auditorium Hall, Lorulangso, Diphu, on Wednesday, the candidates demanded employment opportunities.

Council (KAAC) to immediately release a

The SSTET was conducted by the Assam Department of Education on April 30, 2023, for the three Sixth Schedule districts -Karbi Anglong, Dima Hasao, and Bodoland Territorial Region (BTR). The results were declared on June 15, 2023.

In Karbi Anglong, 1,023 candidates qualified at the Lower Primary level and 801 at the Upper Primary level. In West Karbi Anglong, 600 candidates cleared the Lower Primary level and 419 the Upper Primary. Altogether, 2,843 candidates from the two districts successfully passed the SSTET



2023. Following the results, both Dima Hasao and BTR districts promptly issued recruitment advertisements, conducted interviews, and appointed qualified candidates. However, more

than a year later, KAAC has yet to publish any recruitment advertisement.

William Hanse, one of the SSTET-qualified candidates, said, "We have approached

the concerned department and higher authorities multiple times, but the only response we receive is that the process is ongoing. No concrete steps have been taken so far.'

Highlighting the dire condition in many rural schools across Karbi Anglong—where some schools operate with only a single teacher and others suffer from a mismatch between student numbers and available teaching staff—Hanse added, "If KAAC issues recruitment advertisements and fills the vacant posts, the educational environment in the twin districts will improve significantly. Many young, qualified, and talented individuals are ready to contribute to strengthening the education system."

The SSTET-qualified candidates have made an earnest appeal to KAAC chief executive member Tuliram Ronghang; chief minister Dr. Himanta Biswa Sarma; education minister Ranoj Pegu; minister and Guardian minister of Karbi Anglong, Nandita Gorlosa; KAAC education executive member Richard Tokbi; and other concerned authorities to take immediate action.

Markets end higher as inflation cools to 6-yr low in Apr; metal shares shine

benchmark indices Sensex and Nifty ended higher in a volatile trade on Wednesday due to selective buying support amid easing inflation and positive global cues.

Besides, heavy rush on metal and industrial counters and unabated foreign capital inflows supported the positive trend in the equity markets, traders said.

The 30-share BSE benchmark Sensex climbed 182.34 points or 0.22 per cent to settle at 81,330.56. The gauge hit a high of 81,691.87 and a low of 80,910.03.

As many as 2,857 stocks advanced while 1,121 declined and 147 remained unchanged on the BSE. The NSE Nifty rose 88.55 points or 0.36 per cent to 24,666,90.

"Markets were choppy in intraday trade but managed to end in the green on selective buying support as investors don't want to rush into equities after Monday's strong optimism. While foreign fund flows in the domestic market will be critical going ahead, investors are worried that the US-China settling tariff disputes could revive foreign investors' interest in Chinese markets again," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.

Tata Steel emerged as the biggest winner in the Sensex pack, rising 3.88 per cent, followed by Eternal, Tech Mahindra, Maruti, Mahindra & Mahindra, Infosys, IndusInd Bank, HCL Tech, Tata Consultancy Services and Bharti Airtel were the major gainers.

Telecom operator Bharti Airtel climbed nearly 1 per cent after it posted about a five-fold jump in consolidated net profit to ₹ 11,022 crore in the March 2025 quarter,



mainly due to the tariff hike impact and one-time gain on tax benefits.

However, Asian Paints, Tata Motors, Kotak Mahindra Bank, NTPC and Power Grid were

among the laggards. Tata Motors dipped over 1 per cent after the firm reported a 51 per cent decline in consolidated net profit to ₹ 8,556 crore for the March quarter, hit by lower volumes and operating leverage.

"The session began on a positive note, supported by encouraging factors, such as easing retail inflation and stable global cues. However, the absence of sustained buying interest and a mixed performance among heavyweight stocks limited further gains as the day progressed," Ajit Mishra -SVP, Research, Religare Broking Ltd, said.

The BSE smallcap gauge jumped 1.63 per cent and the midcap index climbed 1.19 per cent. Among sectoral indices, metal

Shree Cement Q4 PAT declines 16pc to ₹556 cr

KOLKATA, May 14: Shree Cement on Wednesday reported a 16 per cent year-on-year decline in consolidated net profit at ₹ 556 crore for the March quarter of FY25, compared to ₹ 662 crore in the corresponding period last year.

Revenue from operations was higher at ₹ 5,240 crore in Q4 FY25, up from ₹ 5073 crore in the quarter, while the EBITDA remained steady at ₹ 1,381 crore, the company said in a statement. Total cement and clinker sales volume during the quarter reached 9.84 million tonnes, the company's highest-ever quarterly dispatch. Premium product sales contributed 15.6 per cent of total trade volume, up from 11.9 per cent in Q4 FY24. "Our focus on premiumisation and cost optimisation has helped us navigate a challenging cost environment. We remain optimistic about cement demand recovery in FY26 and will continue to pursue strategic growth across products and markets," said managing director Neeraj Akhoury. During FY25, Shree Cement commissioned two grinding units — one at Etah, Uttar Pradesh (3.0 MTPA), and another at Baloda Bazar, Chhattisgarh (3.4 MTPA) -- taking total cement capacity to 62.8 MTPA. The company has set a target of crossing 80 MTPA capacity by FY28, with projects in Rajasthan, Karnataka, and Jharkhand underway. The company also expanded clinker capacity at its Nawalgarh unit from 3.8 to 4.5 MTPA in the quarter. (PTI)

WPI-based inflation was 2.05 per cent in March. It was 1.19 per cent in April last year.

WPI inflation lower than 0.85 per cent was last recorded in March, 2024, when it was 0.26 per cent.

As per the WPI (Wholesale price index) data, deflation in food, and fuel and power WPI, along with disinflation in manufactured products drove the moderation. Food articles saw a deflation of 0.86 per cent in April, against an inflation of 1.57 per cent in March. Deflation in vegetables was 18.26 per cent during

as against 26.65 per cent in March. Inflation in fruits softened to 8.38 per cent, from 20.78 per cent in the previous month. Potato and pulses saw a deflation of 24.30 per cent and 5.57 per cent, respectively.

"Favourable base effects to keep WPI inflation low in coming months," Barclays said in a research note. Deflation in fuel and power was 2.18 per cent in April, compared to a 0.20 per cent inflation in March.

"Sharp sequential decline in prices of mineral oils such as kerosene (which was also reflected in consumer prices) and ATF and motor fuels, drove this fall." Barclays said.

NEW DELHI, May 14: Investors have continued to exude a high level of confidence in India's economy, the Prime Minister's policy and the country's talent, Union Minister Ashwini Vaishnaw said on Tuesday.

The minister was responding to a question on investor sentiment post-India-Pakistan military standoff on the sidelines of the inauguration of a new design centre by the Japanese semiconductor company Renesas.

"There is a very high level of confidence about our country's economy, about our Prime Minister's policies, about the excellent talent that we have in our country, and the way, the measured, the calibrated way by which our economy is growing," Vaishnaw said in response to question the mood of investors after heightened tension between India and Pakistan following their four-day military con-

"Everybody wants to come to India at a much faster pace," Vaishnaw said.

The minister said that Renesas has started a new semiconductor design centre in Noida which will



mark the beginning of design for the world's smallest chip in the country. "The key point about this centre is, for the first time in our country, three nanometer chips, which are the most advanced, will be designed here in India end-toend," Vaishnaw said.

Renesas, India Country Manager and VP, MID Engineering, Analog & Connectivity Group Malini Narayanamoorthi said that it is a proud moment for the company to start designing 3-nanometer chips at its Noida facility.

"We are proud to announce that, for the first time, 3-nanometer chips an industry first will be designed right here at the new Renesas Design Centre in Noida," she said. Vaishnaw said that as part of the chip design effort, the government will provide a microcontroller-based hardware kit, which can be used to develop many semiconductor-based products.

"That will be given to the 270 academic institutions, in which we have set up the EDA tools so that the students can learn, while they are learning the software part of it, they can also try their hands at hardware and develop new products." Vaishnaw said.

Renesas CEO Hidetoshi Shibata, who joined the event virtu-

ally, announced that the company has grown 10 times in India to date and plans to grow the total workforce in the country to 1,000 by the end of 2025. He said that Renesas expects 10 per cent of the company's total revenue to come from India in the next few years.

"Initial target was to achieve 10 per cent business by 2030, but it may take longer because of (US) tariff discussion," Shibata said.

Vaishnaw asked Renesas to grow the India facility by 10 times. Renesas during the inaugural

event signed a memorandum of understanding (MoU) with the Centre for Development of Advanced Computing (C-DAC) and exchanged two memoranda of understanding (MoUs) under the MeitY Chips to Startup (C2S) programme. The MoUs focus on supporting local startups by enabling them to drive technological advancement and promote local manufacturing in alignment with the Make in India initiative.

Federation of Barua Buddhist Welfare Association demands buddhist control over Bodh Gaya Temple Management

MARGHERITA, May 14: The Federation of Barua Buddhist Welfare Association of Assam (FBBWAA) has strongly condemned the recent incident at the sacred Mahabodhi Mahavihara in Bodh Gaya, Bihar, where a Buddhist monk, Bhikkhu Vinacharya, was allegedly assaulted by fringe elements during Buddha Jayanti celebrations. The monk has since gone missing, sparking outrage and concern among Buddhist communities across the country.

Addressing the media, Subash Barua, Chairman of the FBBWAA, and Secretary General Shibu Talukdar criticized the Bihar Government and state police for their failure to locate the missing monk and ensure the safety of Buddhist pilgrims at one of their holiest sites.

The leaders reiterated their long-standing opposition to the Bodh Gaya Temple Management Committee (BTMC) Act of 1949, under which non-Buddhist individuals are permitted to control the management of the Mahabodhi Temple. They argued that the act is "illegal and unconstitutional" and demanded full control of the temple be returned to the Buddhist commu-

"Bodh Gaya is one of the most revered pilgrimage sites for Buddhists worldwide. Unfortunately, some vested non-Buddhist interests, with the support of fringe elements, have taken control of the sanctity of the site and are now trying to obstruct the Mahabodhi Mahavihara Mukti Andolan (MMMA)," said Shibu

He further claimed that Bhikkhu Vinacharya, a monk associated with the MMMA, was assaulted during the protests and has been missing since the inci-



dent. "The silence of the authorities raises serious questions about the commitment of the Bihar Government to protect the sanctity of Buddhist sites," Talukdar added

The FBBWAA has issued an appeal to President Droupadi Murmu, Prime Minister Narendra Modi, Union Home Minister Amit Shah, Bihar Chief Minister Nitish Kumar, and the Bihar Director General of Police to immediately investigate the matter, locate the missing monk, and take strict action against those responsible for the violence.

"If our demands are not met, we will be compelled to raise this issue at the international level, including at the United Nations headquarters in New York, warned Talukdar.

The incident has reignited a decades-old demand for the liberation of the Mahabodhi Temple from non-Buddhist control, with Buddhist organizations across India rallying in support of the MMMA's cause.

Modern technology for ensuring safety of Lumding – Badarpur hill section

GUWAHATI, May 14: In a major step towards enhancing railway safety and infrastructure resilience, Northeast Frontier Railway (NFR) has deployed state-of-the-art technology to address challenges related to landslides, drainage issues and embankment stability along the Lumding-Badarpur Hill Section in Assam of Lumding division under NFR.

This section, spanning hilly terrain across Dima Hasao and Cachar districts, is a vital link connecting the states of Tripura, Mizoram, Manipur and the Barak Valley of Assam with the rest of India. The difficult topography and extreme monsoon conditions make this route especially vulnerable to natural hazards, often disrupting rail traffic and posing significant safety risks.

To mitigate these challenges, NFR has initiated a comprehensive aerial and geophysical

survey over an 80-kilometer stretch of the hill section, from KM-45 to KM-125. This initiative utilizes advanced drone-based LiDAR (Light Detection and Ranging), high-resolution aerial imaging and electromagnetic surveys. The survey captured 2 cm resolution LiDAR orthophotos, thermal imagery and Digital Elevation Models (DEMs), providing detailed insights into terrain morphology slope stability and surface deformation. Complementing the aerial survey, Ground Pene-Radar (GPR). Transient Electromagnetic Survey, Electrical Resistiv-

ity Tomography (ERT) and Seismic Refraction Testing (SRT) have been deployed across vulnerable slopes and track borders. These geophysical methods have helped detect underground faults, soil saturation zones and subsurface water accumulation, enabling early identification of potential

Wife murdered by husband in Nagaon Rupahihat

NAGAON, May 14: In a shocking incident, a man allegedly murdered his wife by slitting her throat at Jorthani village, near Rupahihat, in Nagaon district today. According to sources, the accused, identified as Khairul Islam, tied his wife's hands and feet, gagged her mouth with a stone, and then brutally slit her throat. The victim, Sabina Yasmin, was a mother of four children.

After committing the gruesome act, the accused fled the scene, but was later apprehended by locals in the Gonabari area. The community members immediately handed him over to the Runahihat police.

It has been reported that the couple had been facing ongoing marital discord for some time, with locals having intervened multiple times in an attempt to resolve their disputes. The violent incident has created tension in the area, and both Rupahihat police and Kaliabor SDPO have initiated an investigation into the matter. The victim's family has demanded the capital punishment for Khairul Islam, sources added.

Ban on Awami League

he banning of the Awami League activities by the interim government of Bangladesh led by Dr. Muhammad Yunus last week has got wider implications for the pro-active political parties in the country in view of the coming national elections expected by early next year. Equally, the decision assumes significance for India which is now left with no friendly political party operating in its neighbouring country. The wide ramifications of this action by the Yunus government have not got attention in Indian media due to its total involvement with India-Pakistan conflict last week. Awami League is the political party founded by the legendary Sheikh Mujibur Rahman and this Party led the struggle of liberation for the formation of Bangladesh in 1971. Since the AL ruled Bangladesh most of the years till 2024 excepting the years under the army rule and two tenures of the BNP led by Khaleda Zia, presently the chairperson of the main opposition party BNP. Sheikh Hasina ruled for fifteen years consecutively since 2009 but had to abandon her position as Prime Minister of the Awami League government on August 5, 2024 and left for India. She is still staying in India and occasionally addressing her AL supporters in Bangladesh through video.

Recently, Dhaka witnessed massive 72 hour rally by the new party of students National Citizens Party (NCP) demanding to the government the immediate banning of all activities of Awami League. NCP is the only party which has taken up the banning of Awami League as its core programme. Earlier there were talks that Awami League will be allowed to function in a truncated form excluding the leaders and workers against whom there are charges of murder and torture. BNP was earlier in favour of allowing AL to participate in the elections under some guidelines, but now with the government's official ban, the BNP also announced its support saying it is the national demand. As a result, in the coming elections, the competition will be between the two main parties BNP led by Khaleda Zia, former Prime Minister and the NCP led by the students who engineered the fall of Sheikh Hasina government in August last year through their anti quota movement. The other parties, there so many, are smaller in size, they will try to ally with one group or the other. Jamaat-e-Islami has gained strength in the recent months due to big financial assistance from the Islamic countries abroad but the acceptability of this party among the citizens is very low. The main electoral fight will be limited to BNP and the NCP.

What is the future of Awami League? Awami League has a band of dedicated activists still in the country though many of them cannot work openly. The AL will certainly challenge the ban in the court. But the government has inserted some specific provisions in the order which will make it difficult for AL in their legal battle if they want to fight. The AL leader Sheikh Hasina has not

been active in the recent weeks.

NDA sweeps Assam Panchayat polls, Congress faces rout

n a resounding electoral triumph that has reshaped the political landscape of Assam, the National Democratic Alliance (NDA), led by the Bharatiya Janata Party (BJP) and its ally Asom Gana Parishad (AGP), has swept the 2025 Assam panchayat elections, delivering a crushing blow to the opposition, particularly the Indian National Congress. The results, declared on May 11, 2025, following two phases of voting on May 2 and May 7, underscore the NDA's growing dominance in the state's grassroots politics and signal a significant shift in voter sentiment ahead of the 2026 Assembly elections. The BJP-AGP combine secured an overwhelming 1,409 out of 2,192 Anchalik Panchayat seats, while the Congress managed a mere 122 seats, with other parties and independent candidates collectively claiming 41 seats. This landslide victory, coupled with the NDA's strong performance in Zila Parishad seats, where it won 307 out of 397, cements the alliance's grip on

The panchayat elections, often seen as a barometer for upcoming state-level contests, were conducted across 27 of Assam's 34 districts, excluding seven under autonomous councils. With a voter turnout of anproximately 74.71%, more than 1.8 crore eligible voters participated in the democratic exercise, casting their ballots across 25,007 polling stations. The elections encompassed 21,920 Gram Panchayat seats, 2,192 Anchalik Panchayat seats, and 397 Zila Parishad seats, with the use of ballot papers adding to the complexity of the counting process, which began at 8 a.m. on May 11 and extended late into the evening. The NDA's dominance was evident early on, as it had already secured 325 seats uncontested before polling began-37 Zila Parishad seats (35 BJP, 2 AGP) and

Assam's rural and semi-urban polit-

ical structures

BJP, 29 AGP). This uncontested haul, described by Chief Minister Himanta Biswa Sarma as an "unprecedented mandate," set the tone for the alliance's sweeping victory.

The BJP-AGP combine's success was particularly pronounced in key districts such as Dhemaji, Sivasagar, Biswanath, and Sonitpur, where the alliance registered neartotal dominance. In Sivasagar, for instance, the BJP won 11 out of 12 Zila Parishad seats and 23 out of 27 Anchalik Panchayat seats, with the AGP securing the remaining Zila Parishad seat and three Anchalik seats. The Congress, by contrast, was relegated to a single Anchalik Panchayat seat in the district. Simi-

seats and 59 Anchalik Panchayat seats, leaving the Congress with just three Anchalik seats. In Dhemaji, the BJP secured 52 out of 65 Anchalik Panchayat seats, while the Congress managed only five. These results highlight the NDA's ability to penetrate rural strongholds traditionally contested by opposition parties, signaling a shift in voter preference toward the alliance's development-oriented agenda.

CM Sarma, a key architect of the NDA's success, attributed the victory to the public's trust in Prime Minister Narendra Modi's welfare schemes and the state government's focus on grassroots development. Addressing the media, Sarma expressed confidence that the panchayat results foreshadow a strong performance in the 2026 Assembly elections, predicting that the NDA could win around 95 of the 126 Assembly seats. "Towns and cities have been our strongholds traditionally. Now, we have performed very well in villages," Sarma remarked, emphasizing the alliance's expanding rural footprint. He credited the BJP's organizational strength and the tireless efforts of party workers, or "karyakartas," for translating policy achievements into electoral gains. State BJP president Dilip Saikia echoed this sentiment, describing the outcome as a "historic victory" driven by overwhelming public support for the NDA's gov-

ernance model. The Congress, once a dominant force in Assam's politics, faced a near-total rout in these elections, particularly in Upper Assam districts like Jorhat and Sivasagar. which fall under the Jorhat parliamentary constituency represented by Congress MP Gaurav Gogoi. In both districts, the Congress failed to secure a single Zila Parishad or Anchalik Panchayat seat, a stark con-

trast to its performance in the 2024 Lok Sabha elections, where Gogoi had won with a significant margin. This

discrepancy suggests a disconnect between the Congress's parliamentary appeal and its weakening grassroots presence. Assam Pradesh Congress Committee chief Bhupen Borah, visibly shaken by the results, accused the BJP of undermining grassroots democracy by delaying panchayat elections and misusing state resources. Borah alleged that the BJP government failed to deliver on key promises, such as providing 100 days of employment under MGNREGA, and claimed that only 6,200 job card holders received the mandated work during the BJP's tenure. He also raised concerns about monetary irregularities in candidate selection, citing complaints from five districts and proposing an inquiry committee to investigate.

Despite these accusations, the Congress's electoral performance paints a grim picture of its declining influence. The party's 122 Anchalik Panchayat seats and 62 Zila Parishad seats reflect a significant erosion of its rural base, particularly in areas where it had previously enjoyed support from minority communities. Sarma, in a pointed remark, suggested that the Congress's limited success was due to "minority votes driven by fear of the BJP," framing the opposition as increasingly reliant on a narrow voter base. This narrative aligns with posts on X, where some users described the Congress as a "Muslim party" in Assam, though such claims lack nuance and oversimplify the complex dynamics of voter behavior in the The NDA's success was not lim-

ited to the BJP and AGP. In certain constituencies, smaller allies like the United Peoples' Party Liberal (UPPL) and regional parties like the Rabha Hasong Joutha Sangram Samiti (RHJSS) bolstered the alliance's performance, particularly in tribal areas. The RHAC elections in April 2025, where the NDA won 33 out of 36 seats, served as a precursor to the panchayat polls, demonstrating the alliance's ability to mobilize support among indigenous communities. Political analysts view these victories as a testament to the BJP's strategic outreach, which has combined welfare schemes with a strong organizational network to consolidate its

hold over diverse voter groups. The opposition, particularly the Congress, faces an uphill battle to regain relevance in Assam. Bhupen Borah's criticisms of the BJP's governance, including unfulfilled promises under schemes like the Pradhan Mantri Awas Yojana and the Orunodoi initiative, failed to resonate with voters, who appear to have prioritized the NDA's visible development projects and assertive leadership. The Congress's manifesto promises, such as a monthly grant of Rs 3,500 for poor women under the "Lakshmi" scheme, did little to sway the electorate, which seemed more convinced by the NDA's track record. Smaller parties like the All India United Democratic Front (AIUDF) and Raijor Dal also struggled to make a dent, with the AIUDF securing just one Anchalik Panchayat seat uncontested and Raijor Dal winning a handful of seats in specific constituencies.

The panchayat elections' significance extends beyond immediate political gains, as they are widely regarded as a "semifinal" for the 2026 Assembly polls. The NDA's ability to secure uncontested victories in 325 seats before polling even began reflects a combination of strategic candidate selection, opposition disarray, and public goodwill. The BJP's focus on "doorstep governance," as articulated by newly elected Zila Parishad members like Ganesh Basowar and Pranodipta Rajkhowa, resonated with voters seeking accessible and responsive leadership. Basowar, who won by a margin of 11,556 votes, promised regular ward visits, while Rajkhowa emphasized addressing public concerns directly in communities rather than from distant offices.

As the dust settles on the pan-

chayat polls, the NDA's sweeping victory has set the stage for a highstakes Assembly election. For the BJP and AGP, the results affirm their political strategy and organizational prowess, while for the Congress, they signal an urgent need for introspection and reinvention. The opposition's allegations of electoral malpractice and resource misuse, while serious, have been overshadowed by the NDA's electoral juggernaut, which shows no signs of slowing down. With Chief Minister Sarma at the helm, the NDA is poised to leverage this momentum to further entrench its dominance in Assam, leaving the Congress and other opposition parties scrambling to find a foothold in an increasingly saffron-colored political landscape. The 2025 panchayat elections have not only reshaped Assam's rural governance but also set a clear trajectory for the state's political future.

Global weapons industry is witnessing an unprecedented growth

or an import-dependent country on critical arms supplies, it may be risky to get involved in a long-drawn war. Ukraine, currently the world's biggest arms importer, learnt the hard truth after Donald Trump became the US president. Recently, Ukraine had to part with its substantial mineral (rare earth) deposits to secure US arms supplies to fight Russia. Last year, Ukraine displaced India as the world's largest arms importer. The US accounted for around 45 percent of Ukraine's total arms imports. while Germany and Poland provided 12 percent and 11 percent respectively. Without the US help, Ukraine would have possibly surrendered before Russia within months of the Russian attack.

Thanks to the growing military impasse in Europe, Asia, and Asia-Pacific regions, the demand for arms and ammunition has substantially grown in recent years. According to the Stockholm International Peace Research Institute (SIPRI), the world is witnessing an unprecedented rise in military expenditure. The global military expenditure reached \$2.718 trillion last year, an increase of 9.4 percent in real terms from 2023. It is the steepest year-on-year rise since the end of the cold war. Military spending increased in many parts of the world. It witnessed rapid growth in both Europe and West Asia. The top five military spenders are the US, China, Russia, Germany and India. Together, they accounted for 60 percent of the global total, with combined spending of \$1.635 trillion.

Military spending in Europe (including Russia) rose by 17 percent to \$693 billion last year. It was the principal contributor to the global increase in military spending in 2024. With the war in Ukraine continuing in its third year, military expenditure kept rising across the continent, pushing European military spending to a record level. Russia's military expenditure reached an estimated \$149 billion in 2024, 38 percent higher than the previous year. It represented 7.1 percent of Russia's GDP and 19 percent of all Russian government spending. At 34 percent of GDP, Ukraine had the largest military burden of any country in 2024.

Several countries in Central and Western Europe saw an unprecedented rise in their military spending in 2024. Germany's military expenditure rose by 28 percent to reach \$88.5 billion, making it the biggest spender in Central and Western Europe and the fourth largest in the world. Poland's military spending grew by 31 percent to \$38.0 billion in 2024, representing 4.2 percent of Poland's GDP. For the first time since its reunification, Germany became the biggest military spender in Western Europe. Thanks to President Trump's dislike for supporting NATO's huge military spending, the policies adopted by Germany and many other European countries suggest that Europe has entered a new era of high and increasing military spending.

The US military spending itself rose by



5.7 percent to reach \$997 billion, which was 66 percent of total NATO spending and 37 percent of world military spending in 2024. A significant portion of the US budget for 2024 was dedicated to modernizing military capabilities and the US nuclear arsenal in order to maintain a strategic advantage over Russia and China. European NATO members spent \$454 billion in total, representing 30 percent of total military spending across the alliance. Going by the global arms exports data, the top 10 arms manufacturing countries are: the US, Russia, France, China, Germany, Italy, UK, Spain, Israel, and South

The military expenditure in the West Asian region jacked up by 15 percent to an estimated \$243 billion in 2024. Israel's military expenditure surged by 65 percent to \$46.5 billion last year, the steepest annual increase since 1967, as it continued to wage war in Gaza and escalated conflict with Hezbollah in southern Lebanon. Its military burden rose to 8.8 percent of GDP, the second highest in the world. Lebanon's military spending rose by 58 percent in 2024 to \$635

Surprisingly, Iran's military spending dropped by 10 percent in real terms to \$7.9 billion in 2024 despite its involvement in regional conflicts and its support for regional proxies. The impact of sanctions on Iran may have limited its capacity to increase military spending. Iran has developed a significant drone industry, notable for its multiple types of drones, including Kamikaze and multi-role UAVs. Iran is known for producing affordable and readily available drones, such as the Shahed-136 and Shahed-

China, the world's second largest military spender, raised its military expenditure by seven percent to an estimated \$314 billion. China accounted for 50 percent of all military spending in Asia and Oceania, continuously investing in modernization of its military and expansion of its cyberswarfare capabilities and nuclear arsenal. Japan's military expenditure rose by 21 percent to \$55.3 billion in 2024, the largest annual increase since 1952. Its military burden reached 1.4 percent of GDP, the highest since 1958. India's military expenditure, the fifth largest globally, grew modestly to \$86.1 billion.

Amid rising tensions with India over the

April 22 Pahalgam terror attack, cashstrapped Pakistan endorsed an 18 percent hike in defence spending in its 2025-26 budget. India's defence budget for the current financial year too showed a record 9.53 percent rise as the country looks to modernise its armed forces and indigenous defence production against heightened geopolitical tensions. India's armed forces will receive Rs.6.81 trillion (USD78.3 billion), although only 26.4 percent of this budget will be spent on new acquisitions. Almost 23.6 percent will go towards pensions, which have been a major burden on India's defence spending since 2008. Almost 75 percent of the procurement sub-budget, or ₹ 1.12 trillion, will be set aside solely for domestic spending.

Ironically, the two rival South Asian nations, Pakistan and India, are heavily dependent on arms imports. India's historic import dependence on arms should be a matter of genuine concern for the country surrounded by hostile neighbours such as Pakistan, China and Bangladesh. Russia, itself fighting a prolonged war with Ukraine, remains the largest arms supplier to India although its share has decreased. India is increasingly diversifying its arms imports. However, the country needs to be self-sufficient in producing critical arms to be truly militarily powerful. No country can sustain a long-drawn war with imported arms. Currently, two of India's close defence allies and suppliers, Russia and Israel, themselves are involved in prolonged wars.

As in the case of India, Pakistan too is substantially import dependent for critical arms. It relies heavily on next door China for such arms supplies. China accounted for 81 percent of Pakistan's arms imports between 2020 and 2024. China's dominance in this area has increased over the past decade. Now, Pakistan, which is less than one-fourth the size of India, is the fifth-largest arms importer globally, accounting for 4.6 percent of global arms imports. Last year, the world's top five arms importers were Ukraine, India, Qatar, Saudi Arabia, and Pakistan. Almost entirely dependent on China for sophisticated weapons, Pakistan can't involve itself in a long-drawn war unless it continuously gets substantial artillery support from China. (IPA Service)

Operation Sindoor and the BrahMos leap

n a moment resonant with symbolism and strategy, Raksha Mantri Rainath Singh virtually inaugurated the BrahMos Integration and Testing Facility Centre in Lucknow, Uttar Pradesh on May 11, 2025. The event, which coincided with National Technology Day, was not merely a celebration of India's burgeoning defence manufacturing capabilities but also a powerful reaffirmation of its national resolve in the aftermath of Operation Sindoor—a military retaliation that has come to define New India's approach to terrorism.

Speaking with gravitas, Rajnath Singh described Operation Sindoor as more than a retaliatory strike. It was, in his words, a "symbol of India's political, social, and strategic willpower." This sentiment echoed through the Defence Minister's speech as he lauded the Indian Armed Forces for their precision and restraint in carrying out the operation, ensuring that only terrorist infrastructure was targeted deep within Pakistan and Pakistan-occupied Kashmir (PoK). Twenty-one terror camps across nine locations were reportedly struck in a calibrated response to the brutal Pahalgam massacre, where innocent civilians fell victim to Pakistani-sponsored terrorism

India refrained from immediate disclosure of the specific weaponry used in the early morning offensive on May 7. However, Wing Commander Vyomika Singh, an IAF helicopter pilot, offered critical insight during the official briefing, emphasizing that nicheweapons technology meticulously selected warheads were employed to avoid collateral damage. This strategic precision exemplifies the evolving doctrine of the Indian military: to neutralize threats with minimal civilian harm, leveraging advanced technology and refined tactics.

The foundation for such surgical precision lies in India's growing arsenal of modern weapon systems. Among the key tools likely used in Operation Sindoor is the HAMMER (Highly Agile and Manoeuvrable Munition Extended Range), an air-toground weapon tailored for the Rafale fighter jets. Developed by the French defence giant Safran, the HAMMER boasts a range of up to 70 km and can be launched from low altitudes, functioning autonomously and resiliently in jammed electronic environments. India has steadily acquired this system, reinforcing its aerial strike capa-

Complementing this is the SCALP-EG missile, known as Storm Shadow in the UK, which is a stealth-enabled. long-range air-launched cruise missile. With a range of 450 km and a triad of navigation systems—INS, GPS, and terrain referencing—the

SCALP can penetrate heavily fortified targets, including bunkers and ammunition depots. Its ability to operate in all weather and at night adds to its lethality, making it ideal for deepstrike missions like those in Operation

India's twin assertion of strength

In the air-to-air combat sphere, the Meteor missile stands out as a gamechanger. Designed by MBDA, the Meteor is a Beyond Visual Range Airto-Air Missile (BVRAAM) that thrives in contested electromagnetic environments. Its solid-fuel ramjet provides consistent thrust, resulting in the largest "No Escape Zone" of any missile in its class. The Meteor equips Indian fighter aircraft with unmatched supremacy in aerial engagements.

Perhaps the most iconic of India's arsenal, however, remains the BRAH-MOS supersonic cruise missile. Developed jointly by India's DRDO and Russia's NPO Mashinostroyeniya, BrahMos operates at speeds nearing Mach 3 and features the 'Fire and Forget' mechanism, drastically reducing engagement time and exposure to enemy countermeasures. Capable of flying at altitudes as low as 10 metres. and carrying warheads between 200-300 kg, BrahMos strikes fear into adversaries due to its versatility and speed. Its range has been extended significantly in recent years, adding strategic depth to India's strike capabilities.

In recent times, India has also expanded its deployment of loitering munitions-drones capable of surveilling targets before engaging them with surgical precision. These systems embody the convergence of surveillance and strike capabilities, enhancing the Armed Forces' ability to conduct autonomous operations with minimal risk to personnel.

It is within this context of technological advancement and strategic resolve that Rajnath Singh's statements about Operation Sindoor take on their full significance. Noting that Pakistani forces attempted to retaliate by targeting civilian zones including temples, gurudwaras, and churches, the Defence Minister underscored the contrast between the conduct of the two nations. While Pakistan's response was indiscriminate, India's was targeted and surgical, underlining a moral high ground even in conflict.

Singh's remarks also made it clear that the operation was not limited to border skirmishes. He revealed that Indian forces struck military targets even in Rawalpindi, home to the Pakistani military headquarters. This disclosure reflects a bold new threshold in India's counter-terror strategy-a willingness to act decisively wherever threats emanate, irrespective of geog-

The backdrop to this assertive military posture is India's parallel push towards self-reliance in defence manufacturing. The BrahMos Integration and Testing Facility Centre inaugurated in Lucknow exemplifies this vision. Sprawling across 200 acres, the facility will handle integration of booster subassemblies, avionics, propellants, and ramjet engines. With an investment of ₹ 300 crore, it is poised to create significant direct and indirect employment, bolstering the Uttar Pradesh Defence Industrial Corridor (UPDIC).

This new centre is not only an industrial asset but also a symbol of India's commitment to 'Aatmanirbharta' in defence. The inauguration saw five newly recruited trainees felicitated, among 36 selected to operate the facility, showcasing the emphasis on skill development and local empowerment. The centre also includes a programme design and administrative block, laying the foundation for indigenous R&D.

Quoting the former President Dr. APJ Abdul Kalam, Singh reaffirmed that strength alone commands respect in the international arena. He praised the Uttar Pradesh government for fostering a robust defence ecosystem, cit-180 Memorandums of Understanding (MoUs) worth ₹ 34,000 crore under UPDIC, of which ₹ 4,000 crore have already been realized. Projects in UAVs, drones, aircraft manufacturing, textiles, and superalloy materials are underway, marking UP as a pivotal node in India's defence future.

UP Chief Minister Yogi Adityanath, present at the inauguration, echoed the Defence Minister's sentiments, praising Operation Sindoor as a stern message to the world: India no longer tolerates terrorism. He emphasized that only a resolute stance can yield lasting solutions to terrorism, affirming that Lucknow is on the path to becoming a global hub for defence manufacturing.

As global military spending soars, with the Stockholm International Peace Research Institute reporting a \$2,718 billion defence market in 2024, India sees an opportunity. Singh projected the BrahMos facility as a step towards carving out a significant role in this international market. With the slogan "Make-in-India, Make-forthe-World" gaining momentum, India's aim is not just self-sufficiency but leadership in defence exports.

Thus, Operation Sindoor and the BrahMos facility together signal a dual assertion: a declaration of India's operational capability to strike against terror and a commitment to indigenize its defence backbone. These developments are not isolated; they are integral to a coherent national strategy of deterrence, development, and diplomacy. From terror to climate: Act before crisis hits

ndia because of its varied geography, location, geological and climatic Londitions coupled with its 'reactive approach' in dealing with things is prone to natural and other disasters. Time and again the national disaster response has not been at all commensurate with the desired level of preparedness as well as, technology and swift action. Our administrative system takes action and rises from slumber only when disasters happen. Every year time and again seasonal disasters occur and several lives are lost as also huge loss of property and lifesustaining resources.

The governance for disaster management during the last few years has improved after the creation of the National Management Authority (NDMA) but it falls short of the level of international standards. Take for example the recent Pahalgaon terrorist attack on 22nd April 2025 in which 26 innocent Hindu lives were brutally killed by Pakistan-sponsored terrorists by first asking about their religion. It was an attack on the soul of India but the administration there miserably failed to plan to prevent such attacks on tourist spots in Kashmir, even as in major tourist spots elsewhere in the country security arrangements are made to oversee law and order and all who matter in running security apparatus in Jammu and Kashmir know full well that Kashmir is always on the radar of Pakistan sponsored terrorists. It was a well-known fact that last year more than 2.35 crore tourists visited Kashmir and the government opened all tourist places without making any arrangements for the security of

witnessed now and then. There was no coordination between the state and central intelligence agencies though intelligence inputs were indicating terrorist strike. In an era of modern technological innovation, there should not be collateral human loss of our armed forces during search operations to tackle the terrorists. We have a very professional Army no doubt but we need to learn a lesson or two from the Israeli Army and their leadership even though they too have a divided coalition polity. The state and central agencies failed to apprehend the local support to terrorists and Islamists not only in Kashmir but all over as the ecosystem that supports anti-national forces is yet to be given a fatal blow as they gleefully carry out their operations.

There have been talks of hunting down the perpetrators and their supporters for the last 35 years but with minimal lasting success as Pakistan keeps blackmailing about the use of their clandestinely achieved nuclear power status. This is so far about the threat to our national security. A solid standard operating procedure along with accountability and well-defined coordinated responsibility must be enforced.

The government also committed harakiri by opting for an early election as terrorist sympathisers also won and boosted their morale. Let us discuss the other disasters looming large in the coming months. The coming summer is showing its fangs. Only a well-planned strategy can help prevent life and property losses. But what Delhi-NCR saw on 2nd May 2025 a severe thunderstorm, gusty winds, hails and rains that choked the roads with fallen trees and water logging killing 6 people in Delhi proves that no lesson has been learnt. The roadside trees fell as a pack of cards because for the last many years, the environmentalists have been arguing against the concretisation of soil around trees and pavements which dries up moisture, and trees become weak as their roots cannot spread and do not get water.

The weather pattern and westerly winds coupled with rising temperatures due to climate change are making flying challenging as has been noticed for many days in the last 15 days. A concerted pinpointed strategy is the need of the hour. India's summer and monsoon seasons in 2025 are poised to aggravate challenges due to climate change, population pressures, poor planning, and systemic inefficiencies.

The issues needing attention are heatwaves, water scarcity, flooding, agricultural disruptions, and health risks as their intensity and frequency are increasing every year. While some measures are in place, India's response remains inadequate, and at best policies are reactive, inadequate investment, and bureaucratic inertia with a lack of accountability.

The second important issue which need to be addressed is how to deal with Heat Island effects and Heat strokes. It is music to hear to notice that the Delhi Chief Minister had the other day proposed a 3 3-hour break from 12 PM to 3 PM for the labourers working on roads and construction works. Last year during 2024 the country experienced a severe heatwave, resulting in more than 700 reported heatstroke deaths across 17 states, according to the "Heat Watch 2024" report. It also identified around 40,000 cases of heatstroke. What this report misses is the actual data which is several times more as the reporting mechanism does not cover all such

There are instances of heat island effects in cities mainly due to factors like reduced vegetation, impervious surfaces concrete pavement, and building materials that store and release heat. In this regard, the Metropolitan cities need to emulate the urban landscape management of Agartala city by the Tripura government where roads and pavements all over have been aesthetically redesigned with vegetation. The civic authorities must plan for at least 20 heat waves this season for each city and proper water management and availabilty in both urban and rural areas.

The heat-related mortality may increase in slums and rural hinterlands. A new building code be prepared by the civic bodies under the supervision of IDMA which should have provisions on how to deal with heat island effects and how greenery should be used to tackle

To deal with seasonal diseases like gastroenteritis and other viral diseases must have a plan of action. Yet another issue is managing the water resources in urban areas.

As more than 60 per cent of our districts in the country are water stressed. Cities like Bengaluru and Chennai may face "Day Zero" scenarios, where water supplies run dry, as seen in Cape Town in 2018. There is a complete absence of water use planning at the household level. We must prepare for rainwater harvesting and water harvesting at the landscape level in both urban and rural areas, especially in forestlands.

Tamil Nadu's success in reviving water bodies should be replicated all over India so all other successful stories. The National Disaster Management Authority must be reformed and be given the role of policy planning and monitoring of disaster preparedness for the entire country and only qualified experts should be posted in it rather than making it a post-retirement sinecure for lobbyists. s many as 11 million people in the United tates were forced to relocate within the country due to disasters in 2024 — a quarter of the global figure, according to the latest report by the Internal Displacement Monitoring Centre (IDMC). This was the highest for a single country in the year, the report noted.

The number of people displaced due to wildfires in the country was also the highest globally, according to the Global Report on Internal Displacements 2025. This was in keeping with the trend for the

A majority of the 266,000 movements due to wildfires took place in California, the authors wrote in the report. "The largest event was the Park fire in Butte and Tehama counties in late July, triggering more than 66,000.

Wildfires are particularly debilitating for the displaced people because it delays their return home. The authors cite the example of Hawaii, where the Maui fires of August 2023 have caused 3,000 people to continue to live in internal displacement by the end of 2024,

they observed. **Internal** displacements due to disasters & conflict

Disaster-related internal displacements were at an all-time high across the world, with 45.8 million forced out of their homes in 2024. This was the largest figure since IDMC began monitoring the category of internal displacement in 2008. The global figure was also more than doube the annual average of the last ure for the region was higher

decade, the analysis showed. Almost all the disaster displacements (99.5 per cent) were in the aftermath of weather-related events made severe by climate change, the authors highlighted. Further, some 29 countries and territories, including the US,

recorded their highest disaster displacement in 2024. IDMC acknowledged that many of these internal displacements were pre-emptive evacuation that saved lives in places such as the US, the Philippines and Bangladesh. However, the authors flagged that without adequate support, these people may remain displaced longer than they need

and territories reporting disaster displacements last year, 53 reported pre-emptive evacuations, but incomplete data means the true number is likely higher.'

Moreover, some 20.1 million people were displaced internally due to conflict. The analysis also highlighted the interplay between disasters and conflict in the lives of displaced individuals. "More than three-quarters of people internally displaced by conflict and violence as of the end of 2024 were living in countries with high or very high vulnerability to climate change," they wrote, adding that the number of countries that reported displacements due to both the reasons have tripled since

Global internal displacements in 2024

Sub-Saharan Africa witnessed the highest number of internal displacement in 2024, with 19.3 million people forced to leave home due to conflict, violence and disasters. Of this, 7.8 million were displaced due to disasters. Further, all 23 countries that recorded conflict displacements also registered movements triggered by disasters, the analysis showed.

East Asia and Pacific followed with 16.2 million internal displacements, of which 14.8 million were due to disasters. This marked the disaster-related highest movement among regions. The number of disaster displacements was the region's

highest since 2016. This was followed by the Americas, where 14.5 million people were displaced internally in 2024 — 13.1 million for disasters. The overall figthan the previous five years

put together. South Asia recorded 9.2 million internal displacements, almost all of which was due to disasters. "After drier conditions associated with El Niño in 2023, the number of disaster displacements in South Asia nearly tripled in 2024 to reach 9.2 million. The figure was the second highest for the region in more than a decade," the researchers wrote.

Middle East & North Africa recorded 5.7 million internal displacements. Some 599,000 of this was due to disasters.

Europe and Central Asia saw the least number of internal displacements in the year to be. "Of the 163 countries at 846,000, of which 358,000 were disaster-related. Almost 60 per cent of the region's displacement was due to the conflict between Russia and Ukraine. However, 10 countries in Europe and Central Asia reported their highest disaster displacement numbers

What it means to be disabled during a 45°C Summer

t's just the beginning of summer in Delhi, and the Ltemperature is already crossing 40°C. The ceiling fans in many low-income homes barely cut through the thick, hot air. Water coolers sputter, electric bills soar, and public spaces – once offering a semblance of relief – become unbearable outright inaccessible.

According to the June 2022 report by the Disability Inclusive Climate Action Research Programme (DICARP), only 39 out of 192 countries explicitly reference persons with disabilities in their national climate policies. This policy invisibility reflects what I've witnessed firsthand

Delhi-where disabled individuals are often left to navigate life-threatening heatwaves without support. The International Labour Organization (ILO) also warns that climate change will severely worsen health conditions for vulnerable populations, particularly those with pre-existing conditions or who work in informal sectors with no cooling access. These insights underline what we already feel: climate vulnerability is not just about temperature—it's about whose lives are consistently left out of planning and protection.

But while the heat affects everyone, it doesn't affect everyone equally.

Over the past few months, under my project "Green Disability," I interviewed more than 20 disabled, neurodivergent, and chronically ill individuals across Delhi/NCR, I have decided to keep their identities undisclosed – mostly from working-class backthey are coping with the worsening heatwaves. These interviews were anonymous to protect the privacy of the individuals, but their voices and lived truths are undeniable.

Delhi's Heat Action Plan, while a positive step in recognizing climate risk, lacks any mention of persons with disabilities. It lists cooling centers, early warning systems, and public awareness campaigns but without integrating accessibility standards. There are no detailed provisions for inclusive shelters, assistive cooling devices, or multilingual alerts in accessible formats. This omission makes clear that even well-intentioned policies can deepen marginalization when inclusion is an afterthought rather than a foundation.

The findings? Brutal. Exhausting. And invisible to the mainstream climate conversa-

The City That Doesn't Care If You Can't Move Fast

Delhi's streets are a nightmare during a heatwave. Melting asphalt, honking traffic, dust rising from dry gutters. For wheelchair users and people with mobility impairments, simply stepping out becomes a

"The pavement is too broken to use," one respondent told me. "And the buses are too crowded and too hot. But it is what it is. In order to survive, I have to work somehow.'

For those with chronic illnesses who rely on electricitypowered medical equipment, power cuts during peak heat hours are dangerous.

Delhi may pride itself on becoming a "smart city," but the smartness seems reserved for the few who can afford private ACs, fast cars, and walled so-

Public Infrastructure: Designed for the "Able" and the Wealthy

The lack of shade, tactile paving, or sensory-friendly spaces means most public infrastructure simply wasn't built with disabled people in mind. In 40°C+ heat, this exclusion isn't just inconvenient – it's op-

The heat amplifies every barrier. "I use a walker," said another participant, "and the metal burns my hands in the sun. The bus stop nearby has no shelter. I have to wait in the

open, sweating, dehydrated." Even hospitals, already stretched thin, become sites of further exclusion. Long queues in sweltering corridors. Broken elevators. No sign language interpreters. And for caregivers the mental and physical toll doubles.

Delhi's heat doesn't just test infrastructure – it exposes neg-

The Hidden Cost: Emotional and Mental Health

What surprised me most was how many people described not just physical exhaustion but deep emotional fatigue.

An autistic young woman spoke of the sensory overwhelm – the buzzing heat, noise, pollution – that leads to frequent meltdowns. "It feels like the city is screaming," she said.

Others mentioned worsening anxiety, mood swings, and isolation. When staying indoors becomes a necessity, and stepping out becomes a hazard, loneliness sets in.

Many disabled individuals live alone or with limited family support. Their community networks - already frayed by social stigma – become even harder to maintain during ex-

"I miss meeting my friends," one participant told me. "But my body just can't take the heat

Water, Jobs, and What It Costs to Stay Cool

For some, the summer heat directly affects their income. A visually impaired man who sells small goods at traffic lights told me he's lost over half his daily income – people don't roll down windows anymore in the heat. His own energy dips before noon.

Others reported skipping medical appointments, reducing daily meals, or going without drinking water for long hours because toilets aren't accessible or nearby. For menstruating or chronically ill women with disabilities, the choice between hydration and dignity is a daily negotiation.

Cooling becomes a luxury not just in terms of money, but in effort. What does it cost to fill a bucket of water when your building has no lift and you can't walk unassisted? What does it mean to "stay hydrated" when you need assistance just to reach the kitchen?

The Unasked Questions, and a City That Must Listen

The most powerful thread through all the stories was this: no one asks. No one asks disabled people how they're coping. No one asks if they need help. No one asks what the city can do better.

But they should.

Because it's not just about heat. It's about who gets to be seen as worth protecting during a crisis. Who gets counted when policies are made, and who is left to figure it out alone.

As one respondent said: "We're not even in the conversation. Not with the city, not with the climate activists, not with the media."

What Needs to Change -**Right Now**

If there's one thing the recent heatwave has made clear, it's this: accessibility and climate adaptation must go hand in

Here's what the city can do immediately: Ensure that every cooling

center and public space is wheelchair accessible, and that information is shared in formats accessible to people with visual and hearing disabilities. Create heatwave early warn-

ing systems with multiple modalities: audio, text, visuals, and community volunteers. Equip community health workers and caregivers with

training to assist disabled individuals during climate crises. Provide subsidies or support for assistive cooling technologies - such as cooling vests,

solar-powered fans, or battery backups for medical devices. Center disabled people in climate planning. Nothing about

Through my initiative, Green Disability, I'm trying to push this conversation forward – not as a token "add-on" but as an urgent iustice issue. We're holding workshops, building digital accessibility resources, and bringing lived experiences into the heart of climate dialogue.

ndia is confronting the harsh reality of water scarcity. The annual decline in per capita water availability from 1486 m3 in 2021 to 1367 m3 by 2031 sets an alarming trajectory, falling below the current global average of approximately 5500 m3 and signalling a severe water scarcity challenge for the nation.

The growing population exacerbates the demand for water, affecting food, sanitation, and development needs. Worsening water pollution, climate change-induced droughts, and inadequate water resource management further strain water supply, particularly

groundwater resources India's reliance on monsoons for agriculture intensifies the pressure on water resources, with droughts increasing in frequency and projecting a worsening trend until 2049.

The agricultural sector, which employs 70 percent of the population, is the primary water consumer but faces low water-use efficiency. Inefficient irrigation systems and overexploitation of groundwater aggravate the water stress.

India's irrigation sector, consuming 80 percent of total water, relies heavily on unsustainable groundwater extraction, driven by perverse subsidies and suboptimal water pricing.

Groundwater depletion at a rate of 0.3 metres annually poses a severe threat to the country's water security. Recognising the urgency, the Ministry of Jal Shakti was established in 2019, implementing programs to enhance irrigation efficiency and promote optimal water resource utilisation.

However, with declining real prices, the existing water pricing system has led to inter-state conflicts — emphasising the need for a holistic approach to water pricing, considering the comprehensive values and ecosystem service losses associated with water diversion

Ecosystem Services and Water Val-Water allocation challenges arise from spatiotemporal differences in availabil-

ity, requiring efficient management to al-

ing needs. Hence, a robust and inclusive water valuation technique is needed to enhance water governance processes. Valuing water serves as an objective

tool for decision-making, providing a quantified basis for ranking and prioritising projects in water-related infrastructure. Equitable and inclusive valuation aids the allocation of scarce resources, balancing efficiency, equity, and sustainability considerations for social optimality in consumption and production. Water plays a pivotal role in providing ecosystem services, benefiting both people and the environment in var-

locate scarce resources among compet-

Ecosystems like rivers, wetlands, and marine ecosystems offer goods such as clean water and fish, along with services like water purification and flood mitigation. Environmental flows, which allocate water to sustain ecosystems, are crucial for the well-being of these environments and the communities dependent on them.

Despite water's importance in sustain-

ing diverse ecosystems, there is a lack of detailed quantitative knowledge regarding the impacts of environmental changes on ecosystem structure and

Examples include changes in biodiversity, water quality parameters, hydrological flow data, and the economic valuation of ecosystem services. Such data helps understand and manage the trade-offs between human activities and ecosystem health. However, recognising water's contribution to ecosystem services remains an emerging research area.

The importance of integrating environmental sciences and economics for collaborative research efforts cannot be understated, and the need for a balance between equity and efficiency in water pricing must be emphasised.

Efficiency aims to optimise water allocation for maximum net benefit, while equity ensures fairness among economically diverse groups. Differential pricing (higher for industrial use than domestic), market-based pricing, and

output pricing (charging based on crop production) are possible strategies to achieve equity and efficiency in water allocation, recognising the challenges in objectively measuring fairness.

Pricing Water in India

India faces a severe water crisis driven by significant demand-supply gaps, inefficient water resource management, and climate change. Predictions indicate critical water shortages by 2050, highlighting the urgency for practical solutions. There is a disparity in irrigation water pricing across states, leading to low revenue collection. This is mainly attributed to low water taxes, infrequent charge revisions, and flaws in the revenue collection mechanism.

However, the regulatory body's effectiveness is contingent on the establishment of a robust pricing mechanism.

A uniform and rigid water pricing system across India is highly required to accurately value and sustainably utilise the depleting resource. Currently, water pricing in India varies significantly across states, with many states setting nil

to low water taxes and rarely revising charges.

This results in flawed revenue collection mechanisms and low revenue generation in the irrigation sector. Again, over utilisation of groundwater resources due to a focus on supply-side measures exacerbates the crisis, necessitating the immediate implementation of a stringent water tariff system nationwide. The multifaceted water tariff design approach must balance revenue generation, efficiency, demand management, economic development, and public welfare.

The tariff-setting process should be transparent, ensuring equity, sustainability, and resource conservation. Forwardlooking rates should consider environmental costs, align with government policies, and adapt to varying

water supply characteristics. The overarching goal is to address India's water crisis through an integrated approach involving effective regulation, pricing mechanisms, and sustainable resource management. (Courtesy: ORF)

Convinced India, Pak to let's have peace: President Trump

NEW YORK, May 14: US President Donald Trump has repeated his claim that Washington "got involved" with India and Pakistan, saying he "didn't like what was happening" and that he did a "good job" as he "convinced" the two countries "to let's have peace and let's go and make trade deals." Trump was speaking to Fox News aboard Air Force One after he wrapped up his Saudi Arabia visit on Tuesday. This is the fifth time since Saturday that Trump has claimed that the US brokered the "ceasefire" between New Delhi and Islamabad.

India and Pakistan reached an understanding on Saturday to end the conflict after four days of intense cross-border drone and missile strikes. Indian government sources in New Delhi have been maintaining that the Director Generals of Military Operations (DGMOs) of India and Pakistan reached an understanding to stop all firings and military actions on land, air and sea, with immediate effect. They said no third party was involved.

"Well, I've been busy, but I've enjoyed it, because we're getting things accomplished. You can have times when you're working very hard and not getting things done. That happens too, but we're getting a lot done," Trump said in an interview to Fox News' Sean Hannity.

Trump was responding to a question that it has been "an amazing week so far", with the President getting a trade deal with China, playing a big role in India and Pakistan and slashing prescription drug prices.

"I don't think there's ever been a little period like this with the potential nuclear war. And two countries (India and Pakistan), they have very good leaders, people I know very well. And, yeah, it was, it was a very important process. We got involved with India and Pakistan," Trump said. When asked to give an insight into what happened behind the scenes, Trump said, "Well, I didn't like what was happening. And you know, they're two very strongly nuclear countries, with very, very powerful amounts of nuclear, too, serious stuff.

"And if that ever started, boy, that's the beginning of something that could be really bad. Even a minimal minimum, you could have millions of people killed and with one shot, two shots. And I just thought it was something we could get involved in," he said.

"And I did a good job. (Secretary of State) Marco

(Rubio) did a good job, and (Vice President) J D (Vance) did a good job. We sort of were a team. And we, I think, convinced them to let's have peace and let's go and make trade deals. If we can make trade deals, we like that much better than nuclear weapons. And that was a great thing.'

Hours earlier, addressing a high-level audience at the Saudi-US investment forum in Riyadh, that he doesn't like war and wants to be a peacemaker and unifier.

With Saudi Crown Prince Mohammed bin Salman in the audience, along with senior members of the Saudi and American governments, Trump said, "Just days ago, my administration successfully brokered a historic ceasefire to stop the escalating violence between India and Pak-

"And I used trade to a large extent to do it. And I said, 'Fellows, come on. Let's make a deal. Let's do some trading'," Trump, who was in Saudi on the first leg of his fourday Gulf region trip, said to applause from the audience. Sitting in the audience were billionaire Elon Musk,

Rubio and other senior members of the Trump administration as well as the Saudi leadership. "Let's not trade nuclear missiles. Let's trade the things

that you make so beautifully. And they both have very powerful leaders, very strong leaders, good leaders, smart leaders. And it all stopped. Hopefully, it'll remain that way, but it all stopped," Trump said. India carried out precision strikes under 'Operation Sin-

door' on terror infrastructure early on May 7 in response to the April 22 Pahalgam terror attack that killed 26 people. Following the Indian action, Pakistan attempted to attack Indian military bases on May 8, 9 and 10.

The two countries reached an understanding on Satur-

On Saturday, Trump announced that India and Pakistan had agreed to a "full and immediate ceasefire" after a "long night of talks mediated by the United States." Later, in a post on Truth Social, Trump offered to work

with India and Pakistan for a "solution" on Kashmir, while crediting Washington for helping the two nations arrive at the "historic and heroic decision" of stopping the conflict.

India has always maintained that the Kashmir issue is a bilateral matter with Pakistan and there is no space for any

Israeli airstrikes in Gaza kill 60 people, including 22 children, Health Ministry says

STRIP), May 14: At least 22 children were killed in Gaza early Wednesday in a punishing series of Israeli airstrikes across Gaza, according to local hospitals and health

The strikes killed at least 60 people in total, Gaza's Health Ministry reported, including 10 people in the southern city of Khan Younis. The strikes came a day after Hamas released an Israeli-American hostage in a deal brokered by the United States, and as President Donald Trump was visiting Saudi Arabia.

On Tuesday, Israeli Prime Minister Benjamin Netanyahu said there was "no way" Israel would halt its war in Gaza, dimming hopes for a ceasefire.

"The whole operation against India was designed under the supervision of former prime minister and PML-N chief Nawaz Sharif," Pakistan's Punjab province Information Minister Azma Bukhari claimed.

She said Nawaz is not a leader of "a, b, c, d type", rather his work speaks for him-"It was Nawaz Sharif who made Pak-

istan a nuclear power and now designed the whole operation against India," the minister claimed. India carried out precision strikes under

'Operation Sindoor' on terror infrastruc-Kashmir early on May 7 in response to the April 22 Pahalgam terror attack. Following the Indian action, Pakistan attempted to attack Indian military bases on May 8. 9 and 10.

Nawaz had been advocating for a diplomatic solution to the rising tensions with India. "Pakistan is a peace-loving country and prefers peace, but also knows how to defend itself," Nawaz said in a post on X on Saturday.

IMF disburses USD 1.023 bn tranche to Pak; to hold virtual discussions about budget

KARACHI/ISLAMABAD, May 14: The International Monetary Fund has disbursed a second tranche of USD 1.023 billion under the Extended Fund Facility programme for Pakistan, the central bank said on Wednesday.

The disbursement of the second tranche comes on a day when the International Monetary Fund (IMF) is holding virtual discussions on Pakistan's upcoming budget as the visit of its mission to Islamabad was delaved due to security concerns in the region. The federal government is planning to unveil the budget for fiscal 2025-26 on June 2.

The IMF talks will continue until May 16.

The Central bank said the second tranche amount would be reflected in its foreign exchange reserves for the week ending May 16.

The amount was approved last week by the IMF board under the ongoing Extended Fund Facility (EFF) and allowed an additional arrangement for the USD 1.4 billion Resilience and Sustainability Facility (RSF).

The decision to release the funds came after the IMF expressed satisfaction on the first review of Pakistan's economic reform programme supported by the EFF Arrangement, the bank said.

The IMF noted that Pakistan's policy efforts under the EFF had already delivered "significant progress" in stabilising the economy and rebuilding confidence, amidst a challenging global environment.

"Fiscal performance has been strong, with a primary surplus of two per cent of gross domestic product achieved in the first half of FY25, keeping Pakistan on track to meet the end-FY25 target of 2.1 per cent of

Pakistan's gross reserves stood at USD 10.3 billion at end-April, up



from USD 9.4 billion in August 2024, and are projected to reach USD 13.9 billion by end-June 2025 and continue to be rebuilt over the medium term, it was pointed out.

Meanwhile, the IMF talks that started virtually Wednesday will continue until May 16.

The global lender has appointed a new mission chief to Pakistan and the mission is now expected to travel to Islamabad over the weekend, subject to the security situation, government sources told The Express Tribune on Tuesday.

The IMF mission delayed its scheduled arrival here on Tuesday due to uncertainty caused by the India-Pakistan conflict that had affected air travel across the region.

"Virtual discussions are expected to be held from today. For the second and final leg of the talks, the IMF team is expected to arrive in Islamabad on Saturday and stay until May 23," the source said.

The IMF has set multiple fiscal conditions, whose successful completion has so far helped smooth continuation of the programme despite initial setbacks.

Pakistan has met the IMF targets for a primary budget surplus by the federal government, as well as net revenue collection and cash surplus targets by the four provinces.

Against a primary surplus target of ₹ 2.7 trillion, the federal government reported a surplus of Rs 3.5 trillion, or 2.8 per cent of GDP.

The size of the federal budget still remains tentative due to redoing of defence needs and the government plans to announce less than ₹ 18 trillion budget. The overall budget deficit target after incorporating large provincial cash surpluses is projected at 5.1 per cent of the GDP or ₹ 6.7

Funerals held in Myanmar for pupils, teachers killed in airstrike on school

BANGKOK, May 14: Funerals have been held in Myanmar for almost two dozen students and teachers alleged to have been killed in an airstrike on a local school by a ruling military jet fighter.

Local resistance groups and independent media said Tuesday that 20 pupils and 2 teachers died in the attack on Ohe Htein Twin village, in Sagaing region's township of Tabayin, also known as Depayin. Their reports said that as many as 100 people were wounded.

The dead students were from grades 2 to 11, with the youngest seven years old, according to the shadow National Unity Government, which serves as an umbrella organization for opponents of military rule

A member of a local resistance group fighting against army rule told The Associated Press that another student, who was severely injured in Monday's bombing, died Tuesday afternoon while undergoing

medical treatment. The resistance fighter, who requested that neither he nor his group be named for fear of arrest by the military, said the incident occurred while more than 100 students were studying in a school in the village, which has about 500 houses. He denied that any resistance

fighters were stationed in the village that was attacked. Sagaing has been a stronghold of armed resistance to army rule in Myanmar, and the military in recent years has stepped up airstrikes in their fight against resistance forces, which include the armed People's Defense Forces. The resistance has no effective defense against air attacks, which many reports say hit non-military targets. Myanmar has been in turmoil since the army's 2021 takeover ousted the elected government of Aung San Suu Kyi, which led to nationwide peaceful protests that escalated into a durable armed resistance denying the army control of much of the country.

A report Tuesday in the state-run Global New Light of Myanmar newspaper denied the army had carried out the airstrike, saying malicious media outlets were intentionally spreading fake information. The military's tight control over the media and the relative remoteness of many such incidents makes independent confirmation of what occurred difficult.

The bodies of 18 of the victims, most of them under the age of 10 were buried Monday in two village cemeteries after hastily arranged funerals just a few hours after the bombing incident, the unidentified resistance

About 100 wounded people, both students and teachers, were being treated in regional hospitals as the village's clinic lacked adequate facilities. At least two victims have had to have limbs amputated, he

"I am honoured to be named Canada's Minister of Foreign Affairs. I look forward to working with Prime Minister Mark Carney and our team

to build a safer, fairer world and deliver for Canadians," Anand, an MP from Oakville East, posted on X soon after taking oath. Sidhu, 41, also took to X after swearing-in and said, it is an "honour of a lifetime" to be appointed as Canada's International Trade Minister.

"I'm grateful to Prime Minister @MarkJCarney for the confidence he's placed in me to diversify trade, support Canadian businesses in reaching new global markets, and help create good-paying jobs across Canada," he said. "I'm proud to stand alongside my colleagues as we work together to build the fastest-growing economy in the G7," he added in the post on X.

Sidhu's appointment as the Minister for International Trade comes at a time when Canada is battling the Trump administration's aggression towards Canada on tariffs. Anand, who was a front-runner in the race to be the next prime minister to replace

Trudeau, had in January declared that she is backing out from the race and also that she would not be seeking reelection. However, she had reversed the decision on March 1 saving "Canada is facing a crucial moment in our nation's history." Born and raised in rural Nova Scotia, Anand moved to Ontario in 1985.

The Prime Minister of Canada's website mentions that Anand was first elected as a Member of Parliament for Oakville in 2019 and previously served as President of the Treasury Board, as Minister of National Defence, and as Minister of Public Services and Procurement.

31 Maoists killed in 21-day action at Karregutta hills: CRPF DG

May 14: Central and state security forces have eliminated at least 31 Naxals in a 21-day-long comprehensive operation carried out in dense forests around Karregutta hills on the Chhattisgarh-Telangana border, security officials said Wednesday, asserting it is the "beginning of the end" of the Maoist

Addressing a press conference, CRPF Director General GP Singh and Chhattisgarh Director General of Police (DGP) Arun Dev Gautam said during the 21-day operation that started on April 21, the forces have recovered bodies of 31 Maoists, of which 28 have been identified.

"The eliminated Naxals identified so far carried a reward of Rs 1.72 crore on their heads. The forces have also seized a massive haul of weapons and destroyed four technical units of Naxals that used to manufacture weapons and IEDs." Vivekanand, Additional DG (Anti-Naxal operations) of Chhattisgarh Police, said.

The officials said that after analysing facts and information during the operation, it can be safely believed that many senior

Mayawati condemns derogatory remarks on Col Qureshi

LUCKNOW, May 14: BSP chief Mayawati on Wednesday condemned the purported objectionable remarks made by Madhya Pradesh minister Vijay Shah against Army officer Colonel Sofiya Qureshi, terming them "deeply saddening and shameful.'

The former Uttar Pradesh chief minister demanded strict action to prevent communal disharmony and uphold the dignity of India's armed forces.

In a strongly worded post on X, Mayawati said, "First the Foreign Secretary and then a woman officer of the Army have been subjected to disgusting, indecent and inappropriate remarks. This is actually an attempt to destroy the positive atmosphere of enthusiasm and pride prevailing across the country over the success of 'Operation Sindoor' carried out by the Indian Army against Pakistan. This is extremely painful and shameful." Col Qureshi was a prominent face during media briefings on Operation Sindoor,

In a follow-up post, the BSP supremo said, "In this context, the indecent comment made by a senior Madhya Pradesh minister regarding a Muslim woman Army spokesperson should be taken very seriously. The BJP and the central government must take strict action against him so that the malicious intentions of the enemy fail and the country's communal harmony and unity are not disturbed.'

Uttar Pradesh Congress president Ajay Rai also lashed out at the minister, saying Shah had not only insulted a brave daughter of India but also attacked the strength of womanhood and national unity.

"By insulting a brave woman officer of the Indian Army, Colonel Sofia Qureshi, Madhya Pradesh Minister Vijay Shah has hurt the honour of woman power, the armed forces, and our unity," Rai said on X on Tuesday. He added, "His comments reflect a petty and disgusting mindset. How can a person holding a position of responsibility make such immoral and hateful remarks? The police have registered 17 FIRs related to the operation in which the help of the National Investigation Agency is also being sought, officials said.

CRPF DG Singh said security forces are undertaking "relentless and ruthless" operations to ensure that Naxalism is eliminated by March 31, 2026. Singh said the anti-Naxal oper-

ation, which started in 2014, has been intensified and made more focused since 2019, with central paramilitary forces working "shoulder to shoulder" with state police with a commitment to stamp

Highlighting the effects of the operations on the ground, he said that in 2014, the number of the most Naxal-affected districts was 35, which has reduced to six in 2025 so far, while the number of Naxal-affected districts has come down from 126 to 18 during the period.

"The number of violent incidents in 2014 was 1,080, which has come down to 374 in 2024. The number of security personnel killed in Naxal violence in 2014 was 287, which has dipped to 19 in 2024. The number of Naxals eliminated during the period has reached 2089," he said.

As many as 928 Naxals have surrendered before security forces in 2024, while another 718 Maoists have surrendered so far this year, he said.

Security forces have been trying to drive out Naxals from their hideouts and "fill the vacuum". In such areas, 320 new security camps have been established so far, besides 68 night landing helipads. "We are committed to eliminating Naxalism by March 31, 2026, through relentless and ruth-

Justice B R Gavai sworn in as next CJ

NEW DELHI, May 14: Justice Bhushan Ramkrishna Gavai, who has been part of several benches that delivered landmark rulings including the one upholding the Centre's decision to abrogate provisions of Article 370 bestowing special status to Jammu and Kashmir, was on Wednesday sworn in as the 52nd Chief Justice of

The 64-year-old was administered oath by President Droupadi Murmu at a brief ceremony at the Ganatantra Mandap in the Rashtrapati Bhavan

He succeeds Justice Sanjiv Khanna, who demitted office on Tuesday on attaining the age of 65.

CJI Gavai, who was elevated as a judge of the Supreme Court on May 24, 2019, will have a tenure of over six months and would demit office on November 23.

He took the oath of affirmation in Hindi.

Soon after he took oath, CJI Gavai sought blessings of his mother Kamal Tai Gavai by touching her feet. He was greeted by Vice President Jagdeep Dhankhar, Prime Minister Narendra Modi, Union ministers and former judges.

PM Modi later posted pictures of the swearing in on his social media

"Wishing him the very best for his tenure," the prime minister wrote on X

Union ministers Rajnath Singh, Amit Shah, J P Nadda and Arjun Ram Meghwal attended the swearing in ceremony along with former president Ram Nath Kovind.

Born on November 24, 1960, in Amravati, Justice Gavai was elevated as an additional judge of the Bombay High Court on November 14, 2003. He became a permanent judge of the high court on November 12, 2005

Justice Gavai has been a part of several Constitution benches in the apex court which delivered pathbreaking verdicts.

He was part of a five-judge Constitution bench which in December 2023 unanimously upheld the Centre's decision to abrogate provisions of Article 370 bestowing special status to the erstwhile state of Jammu and Kashmir.

Another five-judge Constitution bench, of which Justice Gavai was a part, annulled the electoral bonds

He was part of a five-judge Constitution bench which, by a 4:1 majority verdict, gave its stamp of approval to the Centre's 2016 decision to demonetise Rs 1,000 and Rs 500 denomination currency notes.

Justice Gavai was also part of a seven-judge Constitution bench, which by a 6:1 majority held that states are constitutionally empowered to make sub-classifications within the Scheduled Castes, which form a socially heterogeneous class, for granting reservation for the uplift of castes that are socially and educationally more backward among them.

A seven-judge Constitution bench also having Justice Gavai ruled that the arbitration clause in an unstamped or insufficiently stamped agreement between parties was enforceable as such a defect was curable and did not render the contract invalid.

In an important verdict, a bench headed by Justice Gavai laid down pan-India guidelines and said no property should be demolished without a prior showcause notice and the affected must be given 15 days to respond.

He is also heading the bench which is hearing matters related to forests, wildlife and protection of

He had joined the bar on March 16, 1985, and was the standing counsel for the Municipal Corporation of Nagpur, Amravati Municipal Corporation and Amravati

Pakistan and India are equal powers'. Who is saying this? Prime Minister Modi's 'good

all stopped," Trump said.

A day earlier, Trump had claimed that his administration stopped a "nuclear conflict" between India and Pakistan, telling the south Asian neighbours that America would do a "lot of trade" with them if they ended hostilities.

India and Pakistan reached an understanding on May 10 to end the conflict after four days of intense cross-border drone and missile strikes.

Indian government sources in New Delhi have maintained the directors general of military operations (DGMOs) of India and Pakistan reached an understanding to stop all firings and military actions on land, air and sea and that no third party was involved.



Tripura to roll out new tech for power line repairs without supply disruption: Minister

AGARTALA, May 14: Tripura

Power Minister Ratan Lal Nath on Wednesday announced that the state is planning to introduce advanced technology that will allow repair of electricity lines without disrupting power supply.

Speaking after a review meeting with officials of Tripura State Electricity Corporation Limited (TSECL), Nath said the initiative is part of the government's monsoon preparedness efforts.

The meeting was attended by officers up to the rank of Senior Manager

"Usually, we begin preparations before Durga Puja to avoid power cuts during the festive days. But floods often affect these plans. Despite this, our officials have worked relentlessly. Now, with the monsoon setting in, we held a review to assess how many damaged poles have been replaced, wires cleaned, and new ones installed. We have also instructed officials to issue daily warnings and carry out timely inspections to avoid any power disruption," Nath said.

He added, "We are working to



adopt a technology that will allow us to repair electric lines without having to cut power, which will be a big step forward.'

The minister also highlighted significant improvements in the power sector, crediting the hard work of helpers and electricians who are working round the clock. However, he raised concerns over two pressing issues.

"Only 70 percent of consumers in Agartala have cleared their electricity bills," he revealed.

More alarmingly, he said there

has been a rise in vandalism targeting electrical infrastructure.

"Some miscreants have been deliberately damaging transformers at night. They are opening cut-outs and causing short circuits. On one day alone, 21 such incidents were reported. While we didn't take it seriously earlier, the situation has escalated. An FIR has been lodged, and I have spoken with police officials to arrest those responsible. It's time for the community to come forward and help identify the culprits," Nath added.



One-man studio: 'Mission: Impossible 8' stars remember their favourite Tom Cruise moments

NEW DELHI, May 14: His first "Mission: Impossible" film was in 1996. Almost three decades and seven films later, Tom Cruise is now 62. And his co-stars in "Mission: Impossible - The Final Reckoning" doff their hats to the producer and high-octane action star who has made every MI film all his own and also mega hits.

For Hayley Atwell, Cruise is a one-man studio. Greg Tarzan Davis says the man is filmmaking school in himself, Simon Pegg remembers when they went feeding sharks, Esai Morales recalls the energy that he brings to every frame and Angela Bassett just loves to see him run.

After all, Cruise has not only headlined the series as Ethan Hunt, the American spy out to kill the baddies and save the world, but also redefined what it means to be an action star. He has been battered, broken many bones and still insisted on doing his own stunts.

Atwell, who essays the role of his ally Grace, said he is never just an actor on set. He is many things

'I think it is his ability, how to be spatially aware and how he can be focused very intensely in the scene. But yet you also know that he can see through the lens what is picking up on the camera," Atwell told PTI in a virtual interview.

"He knows where the focus puller is. He knows what the lighting is doing. If some-

one sneezes at the back of the set, he'll bless them and ask them if they are okay. He has the ability to be an actor, a producer, a writer, a director, a lighting designer, a focus puller and a cameraman all at the same time," she said.

Cruise, who debuted as Hunt in Brian de Palma's "Mission: Impossible", has almost written himself into legend in his subsequent turns as the spy, giving audiences a cinematic experience in all MI movies

He has taken the art of performing stunts to an unknown level jumping from one building to another in "Mission: Impossible III", scaling the Burj Khalifa in 2011's "Ghost Protocol", hanging off a flying plane in "Rogue Nation" or riding a motorcycle off a cliff in the previous entry "Dead Reckoning"

In "Final Reckoning", speculated to be his swansong, Cruise has pulled off some more daring stunts, including one where he hangs from the wing of a plane.

"He was up there piloting the plane himself obviously, and he was performing on the wing. And he's the only one really who can be aware of what the camera's going to pick up and where the light's going to be and how much he needs to kind of position himself so that the camera can see his performance," Atwell said.

"So that feels very Tom Cruise to me.

Pegg, who has been a regular in the franchise as tech genius Benji Dunn since

"Mission: Impossible III", recalled the time the cast was shooting in South Africa. "We were doing a drive up this big long road and the helicopter would follow up the road filming us and then we'd get to the top and we'd all jump in the helicopter and Tom would fly us back down... And then

we'd do the shot again," he said. The actor said they tried the shot six times and Cruise flew them down every

"We got the shot and we had a little bit of time left in the day and Tom said, 'Hey, do you want to go diving with sharks?'

'And we said sure. And so we all got in the helicopter with Tom. We went out to the coast and the next thing we knew it was me, Pom, Tarzan, Hailey and Tom all in a cage, feeding these giant eight foot copperhead sharks. That is a typical Tom

Bassett first worked with Cruise on the sixth movie "Fallout" in 2018, playing CIA deputy director Erika Sloane. She returns for "Final Reckoning" but this time as US

In both movies, Bassett said she would always look forward to Cruise's running sequences that have also become a signature of the franchise.

"On set I remember seeing the movie or seeing all his movies and commenting, 'Boy, that guy can run.' I know they're all the big crazy stunts that he does but I really just love to see him sprint nonstop," she said.

Her off-stage memory of Cruise is watching him dance.

'We know he's a pretty good dancer, a good dance partner. So his birthday occurred while we were working and we were able to get him to give us a few steps here and there.

Morales, who plays the villain Gabriel in "Final Reckoning", said he is simply in awe of the Hollywood superstar as well as director Christopher McQuarrie, who has helmed all the four instalments since "Rogue Nation"

"There's nothing they won't tackle. There's nothing they won't consider at least, to bring joy and thrills to their audi-

Ethan Hunt is now older and weatherbeaten, and just as compelling. According to Morales, the MI franchise sees Hunt evolve.

"You see him from this cheeky young agent. If you go back and see he is literally cheeky. He is like a kid in the beginning of this... Into this weathered person. Every line in your face is a story.'

He also remembered the time Cruise

screened a behind-the-scenes promo for the cast.

"It's nice to have a dinner party. And

then he said, 'I've got a surprise for you.' And we watched this massive screen and at the end of this, you see this little boy emerge from him.

"He would go like, 'isn't that great?' And it's so infectious and you really see that these folks live for their audiences. They live to entertain and hopefully enlighten, but mostly entertain.'

Davis, who also starred in Cruise's 2022 blockbuster "Top Gun: Maverick", said the superstar always puts his best foot forward.

"He demands a certain type of excellence and hard work. And it was cool to be able to see it through both projects... He embraces the fandom and what the audi-

Pahalgam fallout: Pakistan doubtful for Asia Cup hockey in Rajgir

tional federation is awaiting a government advisory but Pakistan's participation in this year's Hero Asia Cup hockey tournament in India is in serious doubt because of the prevalent tension between the two countries after the Pahalgam terror attack.

The Asia Cup will be staged in Rajgir, Bihar from August 27 to September 7. Hosts India, Pakistan, Japan, Korea, China, Malaysia, Oman and Chinese Taipei are scheduled to participate in the 12th edition of the continental showpiece, a qualifying tournament for next year's World Cup to be held in Netherlands and Belgium. "It is too early to say anything but we will follow the government's directive on this issue, which has been the case in the past," HI secretary general Bholanath Singh told PTI.

"We can't predict anything right now especially after the recent barbaric Pahalgam attack and Operation Sindoor that India conducted following that. "There is still close to three months for the tournament but we will abide by what our government suggests us. There are no two ways about it.'

In the aftermath of the Pahalgam terror attack, which claimed 26 lives and injured many, the government ordered all Pakistani nationals to leave the country and revoked their visas.

A fortnight after the gruesome India responded launched 'Operation Sindoor' and carried out missile strikes on terrorist hubs in Pakistan and Pakistan Occupied Jammu and Kashmir. This led to further escalation as Pakistan launched drone and missile attacks, which were neutralised by India's robust air defence system. India responded by hitting military installations and air defence systems located in promiand Rawalpindi among others. The two countries agreed to a ceasefire on May 10 after Pakistan's Director General of Military Operations reached out to his Indian counterpart. Prime Minister Narendra Modi, in his address to the nation, made it clear that any engagement with Pakistan will hinge on clear evidence of action against terrorism by that country.

"If the government advisory does not give an all clear than Pakistan won't travel to India. It all depends on the government position at that time," a federation source told PTI. In case Pakistan doesn't get the nod to travel to India, the decision to make the tournament a seven-team affair or bring in a new team to fill the vacant slot, will be entirely in the hands of the Asian Hockey Federation.

"It's very hard to predict right now whether a new team will be added in such a scenario or it will be a seven team tournament. The Asian Hockey Federation will take a call on this," the official said on condition of anonymity.

The last time a Pakistan hockey team did not compete in a multination event in India was the 2016 Junior World Cup, which took place a few months after a terror attack at the Pathankot air base. Malaysia had replaced the Pak-

istani team in that event. The current scenario has also put a question mark on Pakistan's participation in the upcoming Junior World Cup to be held in Chennai and Madurai from November

28 to December 10. The Asia Cup assumes high significance as it is a World Cup qualifier, with the winner earning a direct spot for next year's megaevent that will be held in the Belcity of Wavre and Netherland's Amstelveen from August 14 to 30. (PTI)

How Carlo Ancelotti's move from Real Madrid to Brazil got awkward

MADRID, May 14: Carlo Ancelotti is swapping Real Madrid for Brazil in one of the biggest moves in world soccer. The problem is, neither he, nor Madrid, want to talk about it.

As coaching switches go, they don't come any bigger than this. But when news broke Monday that Ancelotti was leaving the sport's the most successful and iconic club team to take charge of its most successful and iconic national team, there was an awkward silence.

Madrid chose to ignore the announcement by the Brazilian soccer federation and was still to publicly acknowledge it 24 hours later.

There was silence, too, from Ancelotti, who didn't even provide a quote for his new employer when it published its official statement.

That left an uncomfortable vacuum until Ancelotti finally confirmed his departure during a scheduled news conference on Tuesday, which he only took

part in because he was supposed to preview Madrid's upcoming match against Mallorca.

"If I didn't have this news conference today it would have been a fantastic day. But in this news conference I have to explain things that I don't want to explain," the Italian coach said.

Becoming coach of record five-time world champion Brazil should be among the proudest moments of Ancelotti's career. He is the first foreign coach to take charge of the team of Pele, Ronaldo and Neymar; and the most iconic yellow jersey in soccer.

But even for Ancelotti — who is famed for his cool demeanour on the sideline, cigar smoking and the odd raised eyebrow his reaction has been under-

The 65-year-old Ancelotti who has won a record five Champions League titles as a coach — does not begin his new job until May 26 with a view to leading Brazil to next year's

"Real Madrid will release the statement when they want. There's no problem whatsoever. They'll do it at the appropriate time for Real Madrid and there's nothing further to add," Ancelotti said. The appointment of Ancelotti, who is arguably the greatest active coach in soccer, is a major coup for Brazil as it aims to return to the summit of the sport next year. Manchester City manager Pep Guardiola has previously been linked with the job, but signed a contract extension with his club this season.

Test cricket would have been a 'far blander place' without Kohli: Vaughar

LONDON, May 14: "Gutted, shocked and sad" at Virat Kohli's sudden retirement from the longest format, former England skipper Michael Vaughan said no individual has done more for Test cricket than the star Indian batter.

Kohli announced his retirement from Test cricket on Monday, drawing the curtain on a stellar red-ball career. He represented India in 123 Tests, scoring 9,230 runs at an average of 46.85, including 30 centuries.

'There are not too many Test retirements where I am left genuinely disappointed that I won't watch a cricketer play again. But I'm gutted we won't see Virat Kohli in England this summer or in whites any more," Vaughan wrote in his column for the Telegraph.

"I'm shocked that he's retiring now, and I'm also quite sad about it. In my time involved in the game, stretching back more than 30 years, I don't believe there is any individual who has done more for the Test format than Virat."

Kohli led India to 40 wins in 68 Tests -- the most by any Indian skipper to date -- and Vaughan said it was the 36-year-old Indian who

It was complete madness, we were crammed into vans: Healy recalls IPL halt

captain Alyssa Healy has shared a gripping account of the night of "complete madness" when the IPL match between Punjab Kings and Delhi Capitals was called off midway in Dharamsala due to air raid sirens in neighbouring cities.

The match was halted when Punjab were cruising at 122 for 1 in 10.1 overs with floodlight failure cited as the initial reason. Healy, who is married to Australia and Delhi Capitals pacer Mitchell Starc, was in the stands along with family members of other players.

Assuming it was a minor issue, Healy and the others with her stayed calm at first before things went out of

"Couple of the light towers went out and we were just there waiting. I heard a rumour a couple of seats down that we might have to evacuate the stadium cause the lights gone down," Healy said on the 'WillowTalk' podcast.

"And we are large group of family and extra support staff. And next minute the guy that kind of wrangles the group of us and gets us on the bus comes up and his face was white.

"And he was like, we need to go right now. And we were saying, 'oh, it's okay'. Like we're probably best off letting everyone else get out of the stadium and like stay here. We're probably safer at the moment. Cause there'll be people going down the stairs everywhere," she added.

Things escalated quickly and they were shuffled into what Healy described as "a holding pen," where the PBKS and DC players were already present.

"Then the next guy came out, his face was white, grabbed one of the children and said 'we need to leave right now'," the wicketkeeper batter said.

Such was the urgency that Healy recalled Faf du Plessis being in the room without his shoes. "The boys (players) are there. Faf didn't even have

shoes on. They're all just waiting there looking stressed. I asked to Mitch, 'what's going on?' And he said, 'the town 60 kilometres away had just been smacked by some of the missiles'."

"And so there was a complete blackout in the area, which meant that's why the lights were off because



the Dharmasala stadium was like a beacon at that point in time.'

It was then that the gravity of the situation dawned. India had launched missile attacks on terror infrastructure in Pakistan and Pakistan Occupied Jammu and Kashmir a fortnight after the April 22 Pahalgam terror attack in which 26 people were killed.

On the day of the match, a blackout was enforced in several districts including Pathankot, Amritsar, Jalandhar, Hoshiarpur, Mohali in Punjab and Union Territory Chandigarh amid air raid alarms and reports of explosion-like sounds in Jammu.

"So all of a sudden we're crammed into vans and off we go back to the hotel. There was madness. We're sitting on the bus with some of the Punjab players. I think Shreyas was on my bus. It was just like get in a van as soon as you can get out of there," Healy added.

The teams were brought to Delhi through a lengthy road and train journey which involved traversing Hoshiarpur and Jalandhar.

The IPL was suspended for a week but is set to resume on May 17 with most of the foreign players expected to fly back for their respective franchises. (PTI)


