NEW DELHI, May 23: Prime Minister Narendra Modi on Friday said the Northeastern region is witnessing unprecedented progress and the government is determined to accelerate its growth story.

Addressing the 'Rising North East Investors Summit' here, he also said that diversity of the Northeast is its biggest strength and that the region is emerging as the frontrunner of growth.

"The Northeast is witnessing unprecedented progress. We are determined to accelerate its growth story," he said while inaugurating the two-day event which is being attended by chief ministers of the region, union ministers, bureaucrats, diplomats among others.

Top industry leaders Mukesh Ambani, Gautam Adani, Anil Agarwal among others attended the inaugural session.

Modi said for his government, EAST means - "Empower, Act, Strengthen and Transform".

'There was a time when Northeast was only called frontier, now it is the frontrunner of growth," he said.

He said the Northeast was earlier synonymous with bombs. guns and blockades which took away many opportunities from youths there.

"Over 10,000 youths in the Northeast have given up violence in last decade," he said

Operation Sindoor: Stop 'undermining' armed forces' valour, BJP tells Rahul

NEW DELHI, May 23: The BJP on Friday launched a scathing attack at Leader of Opposition in the Lok Sabha Rahul Gandhi and asked him to stop "undermining" the Indian Armed Forces' valour and "jeopardising" the country's security by making "irresponsible remarks" about the ongoing Operation Sindoor.

Calling Gandhi "Nishan-e-Pakistan", BJP national spokesperson Gaurav Bhatia alleged the Congress leader's remarks on the India-Pakistan conflict were being used by Islamabad to "defame" India. "Rahul Gandhi, you decide which side you are on. You have to decide whether you are India's leader of opposition or Pakistan's Nishan-e-Pakistan," Bhatia said at a press conference.

The BJP's charge came a day after Gandhi accused Prime Minister Narendra Modi of having



"compromised" India's "prestige" and asked him why he sacrificed the nation's interests by agreeing to halt military hostilities against Pak-

"Rahul Gandhi, stop undermining the valour and commitment of our brave armed forces, stop asking questions which shouldn't be asked. They jeopardise national security," Bhatia urged the Congress

He said Gandhi's remarks could not be dismissed as "juvenile behaviour". "It has been the core character of Rahul Gandhi to intentionally ask such questions, taking forward the agenda of nations which are inimical to our country,' he alleged. (PTI)

5 Assam hospitals certified for surrogacy clinics

Minister Ashok Singhal on Friday handed over certificates for establishing surrogacy clinics to five hospitals in the state, asserting that it is a step towards bringing the process of surrogacy under government regulation.

Singhal said the Assam government is dedicated to creating a transparent and accountable system that guarantees access to advanced reproductive services for couples in need.

The certificates for establishing Assisted Reproductive Technology (ART) clinics, ART banks and surrogacy clinics were provided to Apollo Fertility, Down Town Hospital, GMCH Fertility and IVF Centre, and The Institute of Human Reproduction - all in Guwahati – and Swasti Hospital in

Op Sindoor exposed Pakistan sponsoring terrorism in India: Amit Shah

NEW DELHI, May 23: The Operation Sindoor undertaken by the Indian armed forces in retaliation for the Pahalgam terror attack has 'completely exposed" the fact that terrorism in India is sponsored by Pakistan, Union Home minister Amit Shah said on Friday.

Shah also said that the operation showed the "firm" political will of Prime Minister Narendra Modi, the "precise" intelligence inputs from agencies, and the "lethal" capabilities of the armed forces.

India hit as deep as '100-km' inside Pakistan after they dared to target a few Indian civilian and military setups following Operation Sindoor (on May 7), when nine terrorist camps were deci-

mated, he said. Shah made the remarks while delivering the annual Rustamji

Memorial Lecture organised by the Border Security Force (BSF) alongside its 22nd investiture cer-

Raised in 1965, the BSF guards the over 6,000-km-long Indian borders with Pakistan and Bangladesh. K F Rustamji was the founding chief of the BSF.

"The terrorists undertook an extreme attack in Pahalgam as they selectively chose innocents, asked their religion and killed them brutally in front of their families, including women and children,' Shah said, adding that this "sin" was committed by Pakistan-sponsored terrorists.

"India's response under Operation Sindoor was different," he

(PoK) were "destroyed" within a few minutes, out of which two were the headquarters of terror outfits, Shah said

"We did not attack their military installations or air bases. We only hit the terrorist bases in Pakistan. Those who committed a criminal act on our land -- the Jaish-e-Mohammed, Hizbul Mujahideen and Lashkar-e-Toiba -- their bases, houses, training camps and launchnads used against India were destroyed." Shah said.

The home minister added, "We thought it was enough that we hit the terrorists but Pakistan proved that it was sponsoring terrorism, as they took the Indian strikes as an attack on themselves and targeted civilian locations and military bases in India." But the Indian air defence (CONTD. ON PAGE-2)

Bangladesh's interim govt chief Yunus mulls resignation: Report

DHAKA, May 23: Bangladesh's interim government chief Muhammad Yunus is mulling resignation as he is finding it difficult to work in view of political parties failing to reach a common ground to bring a change in the country, according to a media report.

Student-led National Citizen Party chief Nhid Islam was quoted by BBC Bangla Service that Yunus is apprehensive over the evolving political situation in the country and whether he will be able to carry on with his

"He (Yunus) said he is thinking about it (resignation). He feels that the situation is such that he cannot work," Islam said on Thursday night after he met with the 84year-old leader. Islam said he went to meet chief adviser Yunus after hearing throughout the day about the speculation of his resignation.

"Sir (Yunus) said, 'If I can't work... I was brought here after a mass uprising to bring change and reform to the country. But in the current situation, with mounting pressure from movements and the way I'm being cornered, this isn't how I can work," Islam told the BBC

Another media report referring to unnamed sources close to Yunus said he actually threatened to resign if political parties do not give him their backing and expressed his desire to quit at a cabinet or advisory council meeting earlier on Thursday.

It said the other advisers, effectively ministers, however, persuaded him not to do so.

Islam told the BBC that he urged Yunus "to stay strong for the sake of the country's security, and future and to meet the expectations of the mass uprising' (and) I hope everyone will cooperate with him"

Islam, one of the key coordinators of the Students Against Discrimination (SAD), who previously served as one three representatives of the platform in the interim government's advisory council or cabinet, quit his office to lead the NCP that emerged in February this year

Goyal meets US commerce secy for 2nd time in a week to discuss proposed trade pact

Meeting assumes significance as both the countries are looking at finalising an interim trade pact

NEW DELHI, May 23: Commerce and Industry Minister Piyush Goyal on Friday met US Commerce Secretary Howard Lutnick in Washington, their second meeting within a week, to discuss the proposed bilateral trade agreement currently under negotiation between the two countries.

On May 20 also, Goyal held a meeting with Lutnick to expedite the talks on the first phase of the trade pact.

"Held a constructive meeting with Secretary @HowardLutnick for a mutually beneficial trade agreement. Committed to enhancing opportunities for our businesses and people," Goyal said in a post on

The meeting assumes significance as both the countries are looking at finalising an interim trade pact by July 9, the day America's 90-day suspension of reciprocal tariffs on Indian goods comes to an end.

The US on April 2, imposed an additional 26 per cent reciprocal tariff on Indian goods but suspended it for 90 days. However, the 10 per cent baseline tariff imposed by America remains in place.

Airtel Payments Bank reports 81% surge in FY25 net profit HT Bureau

GUWAHATI, May 23: Airtel Payments Bank has reported a strong financial performance for the fiscal year ended March 31, 2025, with net profit rising 81.4% year-on-year to ₹63 crore. The bank's annual revenue climbed to ₹2,709 crore, marking a 47.5% increase over the previous year. The bank also posted an EBITDA of ₹299 crore for FY25, up 64% year-on-year, and saw customer balances grow 30.6% to ₹3,659 crore. Gross Merchandise Value (GMV) reached ₹3,808 billion for the year, underscoring the bank's growing transaction base.

In the fourth quarter alone, Airtel Payments Bank earned ₹726 crore in revenue, up 34.7% from the same period last year. Quarterly profit more than doubled to ₹26 crore, registering a 138% year-on-year increase. Over the last four years, the bank has maintained a compound annual growth rate (CAGR) of 44% in revenues

Managing Director and CEO Anubrata Biswas attributed the performance to customer trust and the bank's diversified operations. At present, the Trump administration requires approval from the US Congress to bring tariffs below the MFN (most favoured nation)

India may look at certain commitments from the US on the duty concessions for its labour-intensive sector in the first tranche of the proposed bilateral trade agreement (BTA). Both countries have fixed a deadline to conclude the first phase of the pact by fall (September-October) of this year to more than double bilateral trade to USD 500 billion by 2030 from the current

USD 191 billion. To boost bilateral trade, India is seeking duty concessions for labour-intensive sectors like textiles, gems and jewellery, leather

GUWAHATI, May 23: In a significant step towards strengthening reproductive healthcare in Assam, the Institute of Human Reproduction (IHR), Guwahati, has been officially certified as a Level 2 ART (Assisted Reproductive Technology) Clinic, ART Bank, and Surrogacy Clinic.

The recognition was conferred during a state-level certificate distribution ceremony held at Janata Bhawan, Dispur, as part of an initiative led by Chief Minister Himanta Biswa Sarma and Health Minister Ashok Anand Singhal

According to an official statement, IHR is among the first batch of institutions in Assam to receive these certifications, which are granted under the Assisted Reproductive Technology (Regulation) Act, 2021

Rupee snaps 3-day losing streak, gains 70 paise to settle at 85.25 /USD

MUMBAI, May 23: The rupee snapped its three-day losing streak and settled for the day higher by 70 paise at 85.25 (provisional) against the US dollar on Friday, on a sharp fall in the dollar index and surge in domestic equities, amid rise in risk appetite for riskier assets. Forex traders said, the rupee which had lost 53 paise in the last three trading sessions, settled with significant gains on Friday largely supported by the weakness of the American currency in the overseas market.

However, a slight recovery in crude oil prices and foreign fund outflows capped the appreciation bias in the local unit to some extent.

At the interbank foreign exchange market, the rupee witnessed heavy volatility. It opened at 85.95 then touched an intra-day high of 85.11 and a low of 86.10 against the US dollar.

The domestic unit settled for the day at 85.25 (provisional), higher by 70 per cent over its previous close. On Thursday, the rupee depreciated 36 paise to

close at 85.95 against the US dollar. "We expect the rupee to trade with a positive bias improved global risk sentiments. However, selling pressure from foreign investors may cap sharp upside movement," said Anuj Choudhary - Research Analyst at Mirae Asset Sharekhan Choudhary further noted that traders may take cues

on underlying weakness in the US dollar index and

from existing home sales data from the US. "USD-INR spot price is expected to trade in a range of 85 to 85.70," he said.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading lower by 0.60 per cent at 99.36, on rise in risk appetite in global markets and strength in riskier currencies. Easing of US treasury yields also pressurised the greenback.

Brent crude, the global oil benchmark, fell 0.22 per cent to USD 64.30 per barrel in futures trade.

In the domestic equity market, the 30-share BSE Sensex advanced 769.09 points, or 0.95 per cent, to close at 81,721.08, while the Nifty rose 243.45 points, or 0.99 per cent, to 24,853.15. (PTI)

displayed "marvellous strength" as Pakistan could not touch any of India's installations, Shah said. "After this, we hit their air bases and gave a strong response by introducing them to our fire power and exposing their hollow air defence," he said. "We did not hit (Pakistan's) civilian installations. Operation Sindoor and the incidents that followed completely exposed the fact that Pakistan is sponsoring terrorism in India because it was the Pakistan Army that replied after we hit their terror bases," Shah said.

The home minister said Operation Sindoor "exposed" this fact as top Pakistan Army officers were seen offering namaz and shouldering the coffins of the terrorists who were killed.

The operation was successful as it used the correct firepower and achieved its aims besides "showing the reality" to Pakistan, Shah said. The home minister also said that global experts and the world were "praising" the bravery and firepower of the Indian armed forces.

The operation also brought to the fore the fact that the 'Aatmanirbharta' (self-reliance) achieved by India in defence production was successful, he said. Lauding the BSF for carrying out its duties during the operation, Shah said the force "proved its mettle" by not allowing the Pakistani forces to move even an inch.

The home minister also paid condolences to the two BSF troopers who were killed during the operation llong the International Border in Jammu. Shah recalled that India has been facing Pakistan-sponsored terrorism for many decades but a "befitting reply was not given" until the Modi government came to power (in 2014).

"We were defensive... Our police force and BSF did their best to protect the people but a befitting reply was not given. After 2014, when Prime minister Modi took charge, the biggest attack took place in Uri (2016) where our jawans were burnt alive. "We conducted a surgical strike (across the border) and hit the terrorists by entering their hideouts for the first time. We thought that terrorism will stop but it did not, and the Pulwama attack happened (in 2019)," Shah said. The Modi government gave a "stronger" response than Uri as it demolished terror bases across the front, Shah said. Lauding the BSF, Shah said, "The bravery shown by the BSF in the 1971 war that was imposed upon us, and the contributions made by the force (in the creation of Bangladesh) cannot be forgotten by India and neither should Bangladesh ever forget it."

The BSF played a "significant" role in the creation of Bangladesh and set an "exemplary" standard of bravery by standing shoulder-to-shoulder with the armed forces in fighting against injustice, Shah recalled.

The home minister said the 2.75 lakh personnel-strong BSF was working in some of the most difficult conditions marred by geographical challenges along the two borders (with Pakistan and Bangladesh). "I want tell you that the Modi government is standing behind you like a rock and the Ministry of Home

Affairs will soon implement some technology solutions and models to strengthen border security in areas where it is not possible to erect fences," Shah said. The home minister also awarded gallantry and other service medals to BSF personnel during the event, which

its meeting held on May 15, 2025. The revised framework stipulates that the risk provisioning under the Contingent Risk Buffer (CRB) be maintained within a range of 7.50 to 4.50 per cent of the RBI's balance sheet.

During accounting years 2018-19 to 2021-22, owing to the prevailing macroeconomic conditions and the onslaught of the Covid-19 pandemic, the Board had decided to maintain the Contingent Risk Buffer (CRB) at 5.50 per cent of the Reserve Bank's Balance Sheet size to support growth and overall economic activity. The CRB was increased to 6 per cent for FY2022-23 and to 6.50 per cent for FY 2023-24. Based on the revised ECF, and taking into consideration the macroeconomic assessment, the Central Board decided to further increase the CRB to 7.50 per cent, the RBI said. "The Board thereafter approved the transfer of ₹2,68,590.07 crore as surplus to the Central Government for the accounting year 2024-25," it said.

The government has estimated ₹ 2.56 lakh crore as dividend/surplus for FY26 from the Reserve Bank of India, nationalised banks and financial institutions. The government aims to bring down the fiscal deficit during 2025-26 to 4.4 per cent of the GDP from 4.8 per cent estimated for the preceding fiscal.

Commenting on the RBI's decision, Aditi Navar, Chief Economist with Icra, surplus transfer is about ₹ 0.4-0.5 lakh crore (equivalent to 11-14 bps of GDP), higher than the amount that was likely assumed in the FY26 Union Budget, implying an equivalent upside to non-tax revenues, which would provide some buffer to make up for a miss in taxes or disinvestment receipts, or higher-than-budgeted expenditure in the fiscal.

Shrinkhal Chaliha detained en-route to Duliajan

SIVASAGAR, May 23: Shrinkhal Chaliha, Administrative Secretary of Bir Lahit Sena, a vocal critic of non-Assamese traders in Assam, was taken into temporary police custody on Thursday while on his way to Duliajan. Chaliha's vehicle was intercepted by a combined team of Dibrugarh, Sivasagar, and Moran police at Sepon along NH-37, following which he was swiftly taken to Dibrugarh.

Confirming the development, Sivasagar SP Subhrajyoti Bora told this correspondent that Chaliha had not been arrested but was being held temporarily as a preventive measure. He is expected to be released by the evening.

The action is believed to be in response to heightened tensions in Duliajan following the BN Singh Petrol Pump incident. The incident had sparked widespread protests after former AASU General Secretary Sankarjyoti Baruah was arrested based on an FIR filed by Tanu Shahi and Navnet Shahi on May 17. In retaliation, several youth and student organizations had called for a Duliajan Bundh

Activists have raised concerns over perceived police bias, pointing out that despite multiple FIRs filed against the petrol pump owner's family, no arrests have been made on their end, while protest leaders and indigenous activists have faced police action.

Meanwhile, Raijor Dal President and Sivasagar MLA Akhil Gogoi strongly condemned the police's move against Shrinkhal Chaliha. Speaking to the media, Gogoi urged Chief Minister Dr. Himanta Biswa Sarma to immediately and unconditionally release Chaliha

Gogoi further alleged that under the BJP regime, the indigenous Assamese population has been systematically "assaulted and by non-Assamese insulted" traders. He criticized the administration for what he termed as selective enforcement of law, which he claimed favors outsiders at the expense of local voices.

As tensions simmer in Duliajan and across upper Assam, all eyes are now on how the state government navigates the growing unrest among indigenous rights groups and youth organizations.

NH-315 in Margherita left in ruins: AJYCP warns of escalated agitation

MARGHERITA, May 23: The

persistent deterioration of National Highway 315 (NH-315) in the Margherita Co-District has become a dire concern for residents and commuters, with large stretches of the road lying in a dilapidated condition for months. Despite repeated calls for action, including a recent protest by the Asom Jatiyotabadi Yuba Chatra Parishad (AJYCP), no substantial repair work has been initiated. sparking frustration and warnings of intensified agitation.

The issue is particularly acute within the 83rd Margherita Assembly Constituency, where vital segments of NH-315 passing and Tirap Colliery have become damaged. Kanchan Borah, Vice President of AJYCP Tinsukia District Committee, highlighted the plight of thousands who use this highway daily-including students, patients, workers, and pregnant women-who now face lifethreatening risks due to the road's condition

The AJYCP staged a protest on May 15, marching from Ledo College Road to Ledo Bazaar, demanding immediate restoration of the highway. The protest, led by AJYCP Tinsukia District President Prabin Tamuly and Vice President Kanchan Borah, was a direct appeal to the government and Margherita MLA Bhaskar Sharma. Protesters decried the in-

action of the Assam Government, NHIDCL, and Margherita Co-District Administration, warning of larger agitations if their demands are ignored.

Borah noted that the road's deterioration-marked by deep potholes and large craters—has rendered sections of the highway nearly impassable. The situation worsens during rains, when waterlogging makes the hazards indistinguishable. significantly increasing the risk of accidents. Several mishaps involving twowheelers and smaller vehicles have already been reported, with no official assurance of remedial measures forthcoming.

"Even a single spell of rain of waterlogged, crater-ridden traps," said Borah. "Despite its strategic connectivity and high daily traffic volume, the highway continues to be neglected by those

While the BJP government promotes a narrative of development, locals argue that the inaction over NH-315's condition belies this claim. The AJYCP has now vowed to launch a grand agitation in Margherita unless authorities including the NHIDCL, local administration, and MLA Bhaskar Sharma—take urgent steps to restore the highway.

As public patience wears thin, all eyes are now on the administration and state leadership to respond before the situation spirals further into public unrest.

Drug peddler apprehended in Biswanath during joint police operation

23: In a major breakthrough in the ongoing crackdown on drug trafficking, a joint police team from Biswanath and Sootea successfully apprehended a key member of a drug peddling network during a late-night raid on Thursday.

Acting on information provided by two previously arrested peddlers, Jamir Ali and Ikramul Hussain, the team conducted an operation at Kekukali village, Khanamukh, under the Chariduar Police Station. With support from the Khanamukh outpost, police apprehended Nurjamal, identified as the mastermind of the drug distribution network.

During the raid, police recovered: 8 containers with 10.69 grams of illegal drugs, an Alto car (Reg. No. AS12A G0659), ₹ 1,07,400 in cash and a mobile phone.

The accused was brought to the Sootea Police Station for further interrogation, confirmed Trilochan Das, Officer-in-Charge of Sootea PS. Investigations are ongoing to uncover the full extent of the network and possible accomplices.

It is noteworthy that minoritydominated areas have been increasingly identified as hotspots for drug trafficking in the region. Local residents and concerned citizens have urged law enforcement agencies to dismantle the entire supply chain and intensify surveillance to curb the growing menace.

Leadership turmoil in Nagaon District Drug Dealers' Association

NAGAON, May 23: Tensions have escalated within the Nagaon District Drug Dealers' Association following the controversial ousting of its General Secretary, Simanta Saikia, during an emergency executive meeting held last Thursday at a roadside restaurant near the Borghat bypass.

The meeting, chaired by association president Jiban Bonik, reportedly ended with Saikia being relieved of his duties—an action that has since triggered widespread backlash from local civic and youth organisations.

Simanta Saikia has condemned the decision, calling it

"illegal" and accusing certain factions within the association of orchestrating a "deep conspiracy" to discredit him. He maintained that the internal disagreement stemmed from the recent launch of a free ambulance service by the association, an initiative he claims was manipulated for political motives.

In response to Saikia's removal, several prominent regional organisations—including the Asom Jatiyatabadi Yuba Chatra Parishad (AJYCP), All Students' (AASU), and Krishak Mukti Sangram Samiti (KMSS)—have issued a joint ultimatum demanding his immediate reinstatement within 24 hours.

These organisations have strongly criticized president Jiban Bonik, alleging interference by "outsiders" aiming to "undermine the interests of indigenous business communities." They warned that if Saikia is not reinstated, they will launch mass protests across the district and ensure that "no external forces are allowed to dominate Assam's local business ecosystem.'

As the deadline looms, observers are closely watching the association's next move amid mounting public pressure and the threat of large-scale agitation.

DC orders immediate measures to prevent urban flooding in Jorhat

JORHAT, May 23: With the arrival of the monsoon season and the increasing threat of urban flooding, District Commissioner Jay Shivani, in his capacity as the Chairman of the District Disaster Management Authority (DDMA), has issued a stringent order to undertake critical flood mitigation measures in Jorhat district. The took place at the home of Kamal Das around 4 directive mandates the cleaning and de-silting of all drains within the Municipal and Development Authority areas to prevent artificial flooding—a recurrent problem exacerbated by clogged drainage systems.

The order specifically highlights a recurring issue: silt removed from drains is often dumped alongside them, which ends up re-entering the drainage systems during rainfall, rendering the entire desilting process ineffective. Furthermore, this practice has led to unhygienic conditions, causing inconvenience to pedestrians and contributing to the deterioration of public health and cleanliness.

In a decisive move, the DC's order, which comes into immediate effect, states that all concerned municipal boards, departments, agencies, and contractors must ensure that silt and debris are cleared within 10 hours of extraction. Failure to comply will be treated as a public service obstruction, and legal action may be taken under Sections 41(C), 51(b), 55(1)(2), and 58(1)(2) of the Disaster Management Act, 2005. This urgent intervention follows years of disruption where sharp showers have flooded residential areas and critical office campuses, including the DC and SP offices, paralyzing daily life for hours.

The administration hopes this proactive measure will significantly reduce waterlogging and improve resilience against monsoon-related challenges in Jorhat.

Lizard was rescued from a residential area in Tingrai-Digboi, located in the Tinsukia district of eastern Assam, on Friday. The unusual sighting PM, prompting a swift response from local environmentalist Debojit Moran. Upon being alerted, Moran arrived at the residence, carefully captured the monitor lizard, and ensured its safe transport. The reptile was later released into the Lakhipathar Reserve Forest, a nearby protected area, restoring it to its natural habitat

We have rescued a rare Bengal monitor lizard from the residence of Kamal Das. I reached the spot, caught the lizard, and kept it in a box. It was later released in Lakhipathar Reserve Forest," said Moran, who is known for his work in local wildlife conservation. Bengal Monitor Lizards, part of the Varanus genus, are among approximately 80 recognized species of monitor lizards globally. They are primarily native to Africa, Asia, and Oceania, although one species has also established itself as an invasive species in South

While the IUCN Red List categorizes most monitor lizard species as of "Least Concern", their global populations are declining due to threats like habitat loss and poaching.

Ukraine war peace talks

S President Donald Trump has virtually called off his peacemaking efforts with Ukraine and Russia to break their ongoing conflict after his two-hour talk on Monday with so-called buddy Russian President Vladimir Putin ended in a no entry zone. Now the Vatican has entered the scene to host the peace talks between the Russian and Ukrainian leaders. One does not know if President Trump asked the Chicago born Pope Leo XIV for help to bail him out and host the talks so that both leaders would listen to him. But VP JD Vance indeed met the new pope from Chicago Leo XIV and explained the global situation including Ukraine. Trump spoke with both Russian President Vladimir Putin and Ukrainian President Volodymyr Zelenskyy and other leaders in separate calls Monday, in an attempt to stop the "bloodbath" of the war in Ukraine. But the president's peace initiative ended inconclusive leaving him frustrated. Russia and Ukraine would now hold direct talks on a ceasefire "immediately," Trump said afterward in a post on his social network Truth Social. However, it was unclear what form those talks would take or when they would happen. The Vatican, Trump said, has expressed interest in hosting the negotiations. "The conditions for that will be negotiated between the two parties, as it can only be, because they know details of a negotiation that nobody else would be aware of," he said. Trump's call with Putin lasted more than two hours and "was very informative and very open." Putin told Russian state media.

Meanwhile, Putin's spokesperson Dmitry Peskov said before the call that Russia "highly values" and is "grateful to the American side." In a briefing with journalists, he said that if the U.S. can "help to achieve our goals through peaceful means, then this is indeed preferable." Peskov was also asked about the chance of Trump and Putin meeting in person, a possibility the American president floated on Friday. "It will largely depend on what they themselves decide," Peskov said. The meeting "needs to be worked out" by the two leaders in terms of dates and other details, he said. Ahead of the much anticipated Trump-Putin call, leaders from Britain, France, Germany and Italy said they spoke Sunday with Trump. The British government said in a statement that it was urging "Putin to take peace talks seriously." Those leaders "also discussed the use of sanctions if Russia failed to engage seriously in a ceasefire and peace talks," the statement said — something Trump has previously threatened.

There have been several rounds of peace talks to end the Russian invasion of Ukraine since it began in February 2022. Russia's president Vladimir Putin seeks recognition of all occupied land as Russian, for Russia to be given all of the regions it claims but does not fully control, guarantees that Ukraine will never join NATO, and the lifting of sanctions against Russia. Ukraine's president Volodymyr Zelenskyy seeks a full withdrawal of Russian troops, the return of prisoners and kidnapped Ukrainian children, prosecution of Russian leaders for war crimes, and security guarantees to prevent further Russian aggression.

Tariffs, Chips, and the AI Wars

America's strategic recode in the tech Cold War

n an era where artificial intelligence is swiftly becoming the cornerstone of global economic and military supremacy, the United States and China are locked in a sprawling technological conflict defined as much by semiconductors as by sanctions. In a dramatic policy shift, the U.S. Department of Commerce (DOC) under the current Trump administration has formally revoked the Biden-era 'Artificial Intelligence Diffusion Rule," a sweeping regulation that was due to take effect on May 15. This decision marks more than a procedural reversal-it is a fundamental reorientation of America's strategy in the intensifying tech war with China, with profound implications for global supply chains, geopolitical alliances, and the fu-

The now-defunct rule was intro-

duced by the Biden administration in January with the explicit purpose of regulating the international flow of advanced AI chips, a critical component in developing stateof-the-art AI systems. Framed as a delicate balancing act, the rule sought to curtail the export of sensitive U.S.-made AI technologies to adversarial nations like China and Russia while maintaining collaborative openness with allies such as Japan and South Korea. A third category—comprising countries like Israel and Mexico—was to be tightly monitored with a cap on GPU imports to prevent transshipment to restricted nations. Nvidia, one of the world's leading chipmakers, sharply criticised the rule, calling it "unprecedented and misguided," warning it would derail global innovation and cooperation. This approach built upon previous export control frameworks from October 2022 and 2023, presenting a multi-tiered licensing regime that hoped to marry national security imperatives with industrial pragmatism.

However, the Trump administration has opted for a cleaner, more confrontational doctrine. The DOC's announcement not only

nullified Biden's rule but also signalled a future regulatory strategy that pivots away from blanket restrictions toward bilateral negotiations. Jeffrey Kessler, the new Secretary of Commerce for Industry and Security, described the rescinded rule as "ill-conceived and counterproductive," affirming instead a "bold, inclusive strategy" that emphasises direct partnerships with trusted nations while resolutely blocking technological access to adversaries. The immediate issuance of enforcement guidance illustrates this shift: reaffirming the



ban on Huawei's Ascend AI chips, warning against training AI models in China using U.S. technology, and urging the strengthening of chip supply chains against diver-

While the tools and language have changed, the strategic objective remains constant: to sustain American dominance in the AI domain while denying China the technological wherewithal to overtake the U.S. economically or militarily. This retooled strategy prioritises agility and enforceability over the bureaucratic scaffolding of universal frameworks. It is a tactical recalibration rather than a retreat, moving from systemic

regulation to surgical interdic-

But this policy realignment does not exist in a vacuum. It intersects profoundly with the economic front of the U.S.-China rivalry specifically, tariffs. The economic war, ignited under the first Trump administration and sustained by Biden, has seen waves of tariffs on Chinese goods, met with retaliatory duties on American products. The tech sector has been hit especially hard, with rising costs on servers, semiconductors, and key components vital for AI infrastructure. The renewed Trump administration has intensified this front, using tariffs as a coercive mechanism to bend trade and tech negotiations to American advantage.

Recent moves underscore this escalation. Nvidia, for instance, now requires a special license to ship its H20 GPUs to China—a less capable version of its flagship H100 and H200 chips, customised to comply with U.S. export controls. This dual pressure—restrictboth the intellectual architecture of AI and the physical hardware required to power itcreates an ever-tightening vise on the global tech industry. Companies are being forced to manoeuvre within a labyrinth where technological ambition and compliance

Beijing has already launched massive investments in domestic semiconductor innovation, AI foundational models, and supercomputing capacity. By forcing China to decouple from U.S. technologies, Washington may be hastening the emergence of an independent, state-backed Chinese AI infrastructure that rivals the

This broader context is essential. The shift in U.S. AI export policy is not merely a bureaucratic maneuver but a flashpoint in a larger strategic theatre. It represents a move from codified order to dynamic contestation, with national security considerations overtaking multilateral regulation. Where Biden sought to enforce a preemptive, rule-based order, Trump prefers a reactive, transactional model. Both aim to maintain American hegemony in AI-but through radically different meth-

In the end, this is not just a battle over semiconductors or software algorithms. It is a defining struggle over who will write the rules for the technological future. For now, that future looks increasingly divided, defined less by cooperation and more by confrontation. With AI poised to revolutionise everything from warfighting to wealth generation, the world is witnessing not just a new industrial revolution but a new kind of cold warfought with chips instead of missiles, and code instead of cannons. The revocation of the AI Diffusion Rule is not a detour from that war. It is a redrawing of the battlefield.

Domestic violence in Assam: Legal protections and challenges

omestic violence remains a deeply entrenched social issue in Assam, reflecting broader patterns of gender inequality and socio-economic vulnerabilities that plague not only the northeastern state but India as a whole. Despite the presence of comprehensive legal protections, the grim reality on the ground reveals persistent gaps in implementation, awareness. and social attitudes that continue to undermine the safety and dignity of countless women. The problem is not merely legal or institutional but deeply cultural, and the state's struggle to curb domestic violence exposes critical challenges in governance, societal mindset, and resource allocation.

Assam consistently ranks among the states with the highest reported crimes against women, according to data from the National Crime Records Bureau (NCRB). This alarming trend underscores the urgency of addressing domestic violence in a holistic manner. The Protection of Women from Domestic Violence Act (PWDVA), enacted by the Indian Parliament in 2005, stands as the most significant legislative instrument aimed at safeguarding women from domestic abuse. This Act broadens the definition of domestic violence beyond physical assault to include emotional, verbal, sexual, and economic abuse, thereby recognizing the multifaceted nature of violence women endure within their homes. It provides victims with remedies such as protection orders, monetary relief, custody of children, and the right to reside in the shared household. However, despite the robust legal framework, the lived experiences of women in Assam reveal a persistent disconnect between the law and its enforcement.

One of the foremost challenges lies in the pervasive lack of awareness among women about their rights under the PWDVA, especially in rural and remote areas of Assam where literacy rates are comparatively low and patriarchal norms dominate social relations. Many women accept domestic violence as a normalized aspect of marital life, influenced by longstanding cultural and societal beliefs that prioritize family honor and male authority over individual rights. This internalization of violence as an inevitable fate discourages victims from seeking help or reporting abuse to authorities, often resulting in continued cycles of suffering behind closed doors.

Further complicating the issue is the inadequate infrastructure to support survivors of domestic violence. Assam has taken steps such as establishing One Stop Crisis Centres (OSCs) in various districts and operating a women's helpline (181), but these services remain significantly under-resourced. Staff shortages, insufficient funding, and lack of specialized training for counselors, social workers, and legal aid providers hamper the effectiveness of these support systems. Many women report difficulties in accessing timely and sensitive assistance, often facing bureaucratic delays or

insensitivity when they do come forward. Additionally, shelter homes meant to provide temporary refuge frequently operate with limited capacity and resources, and some lack standardized protocols for care, which deters women from seeking refuge

The justice delivery system itself presents a daunting hurdle. Police investigations in domestic violence cases often remain incomplete or delayed, with a high pendency rate reported in Assam. This slow process discourages survivors from pursuing legal remedies, especially when combined with the fear of social stigma and retaliation from abusers. Moreover, the judicial system frequently lacks gender-sensitized mechanisms that ensure the dignity and safety of survivors during court proceedings. In many instances, victims face secondary victimization through insensitive questioning and procedural hurdles, which further silences them. The absence of adequate legal aid compounds the problem, leaving many women ill-equipped to navigate complex legal processes on their own.

Economic dependence is another critical factor that perpetuates domestic violence in Assam. Many women remain financially reliant on their husbands or in-laws, lacking independent income or assets that would enable them to leave abusive environments. The fear of economic insecurity for themselves and their children acts as a powerful deterrent against reporting abuse or seeking separation. This vulnerability is intensified by limited access to education and employment opportunities for women, especially in rural and marginalized communities where traditional gender roles restrict

women's mobility and autonomy. The challenges of tackling domestic violence in Assam are not limited to legal and institutional shortcomings. Social stigma surrounding divorce, separation, or even the admission of domestic abuse prevents many women from speaking out. Victims often face ostracism within their communities, with family and neighbors discouraging them from exposing "family matters" to outsiders. This culture of silence enables perpetrators to act with impunity and denies women the solidarity and support they need to break free from violent circumstances.

Civil society organizations have stepped in to fill some of the gaps left by state mechanisms. Numerous grassroots groups and feminist collectives work tirelessly to raise awareness about women's rights, provide counseling and legal assistance, and advocate for stronger policy implementation. These organizations have played a critical role in training local leaders, law enforcement officers, and healthcare workers to better understand and respond to domestic violence. They have also campaigned for the formation of women's safety committees at the village level, believing that community engagement is key to transforming entrenched norms. Collaborative efforts involving multiple stakeholders—government, NGOs, healthcare providers, and legal experts—are essential to

build a responsive and victim-centric system The Assam State Commission for Women, established in 1993, is mandated to protect and promote women's rights in the state. It investigates complaints of domestic violence and advises the government on policy measures. Yet, its impact is constrained by limited resources, lack of widespread visibility, and bureaucratic challenges that hamper swift action. Strengthening such statutory bodies, empowering them with adequate funding, authority, and independence, is crucial for a systemic response to domestic violence.

Addressing domestic violence in Assam demands not only better enforcement of laws but also deep societal change. Educational campaigns focusing on gender equality and respectful relationships must be integrated into school curricula and community programs. Men and boys need to be engaged as allies in challenging toxic masculinity and norms that condone violence. Media can play a constructive role by responsibly reporting on domestic violence and amplifying survivor voices without sensationalism. Policy responses should also prioritize economic empowerment of women, ensuring access to education, vocational training, and employment opportunities that can reduce dependency on abusive partners. Safe housing schemes and financial aid for survivors can facilitate their transition towards independence. Further, healthcare systems must be equipped to identify and support victims through trained personnel and integrated referral services

In recent years, Assam's government has made some efforts to address domestic violence, including launching helplines and public awareness campaigns. However, the real test lies in consistent, transparent, and accountable implementation. Strengthening coordination between police, judiciary, healthcare, and social services is essential to create an integrated support network. Regular training for frontline workers on gender sensitivity and legal provisions will improve the quality of response. Monitoring and evaluation mechanisms must be established to assess the effectiveness of programs and policies, with feedback from survivors and community members guiding improve-

Ultimately, the fight against domestic violence in Assam cannot be won by law enforcement or social programs alone. It requires dismantling the structural inequalities and patriarchal mindsets that sustain violence behind closed doors. The state must prioritize women's safety as fundamental to social development and human rights. Only by fostering a culture of respect, equality, and justice can Assam hope to reduce the scourge of domestic violence and enable women to live with dignity and security. The legal protections are in place, but it is the collective will of society, supported by vigilant governance and proactive civil engagement, that will bring transfor-

Waqf Amendment Act, 2025: A review By: Mohammad Hafeez Khan

The concept of 'Waqf' is rooted in Islamic laws and traditions. It refers to an endowment made by a Muslim for charitable or religious purposes, such as building mosques, schools, hospitals, or other public institutions. Another defining feature of a Waqf is that it's inalienable- which means it cannot be sold, gifted, inherited or encumbered. Therefore, once a property is divested from the waqif, i.e., the creator of a wagf, it vests in God and as per Islamic belief since God is ever lasting, so is the 'waqf property'

Recently, the Waqf (Amendment) Act, 2025 was passed by the Lok Sabha and Rajya Sabha. The Act amends the Waqf Act, 1995, allowing the government to regulate Waqf properties and settle related disputes.

The Act aims to improve Waqf Board efficiency, update Waqf definitions, streamline registration, and boost use of technology in record management. Waqf refers to an endowment made by a Muslim for charitable and religious purposes, such as building mosques, schools, hospitals, or other public institutions. It is inalienable, i.e., it cannot be sold, inherited, gifted or encumbered. **Main Provisions of the Act:**

· Separation of Trusts from Waqf: Muslim-created trusts under any law will no longer be considered Waqf, ensuring individ-

uals retain full control over their trusts. Eligibility for Waqf Dedication : Only practicing Muslims (for atleast 5 years) can dedicate their property to Waqf. Properties already registered with Waqf Boards will remain will remain so unless disputed or identified as government land.

· Women's Rights in Family Waqf: Women must receive their inheritance before Waqf dedication, with special provisions for widows, divorced women, and orphans. Ending Arbitrary Property Claims: Sec-

tion 40 of the original Waqf Act (1995) has been removed, preventing Waqf Boards from arbitrarily declaring properties as Waqf. Section 40 of the Waqf Act (1995) gives the Waqf Board the authority to decide whether a property is a Waqf property or not.

• Waqf Tribunals : The Waqf Tribunals consist of 3 members, i.e., a district judge, a state government officer (joint secretary level), and an expert in Muslim Law and jurisprudence.

■ Aggrieved parties can appeal directly to the concerned High Court within 90 days of receiving the Waqf tribunal's order.

· Government Land & Waqf disputes : An officer above the rank of Collector will investigate government properties claimed as Wanf to prevent any unwarranted claims.

Reduced Annual Contributions: Wanf in-

stitutions' mandatory contributions to Waqf Boards reduced from 7% to 5% allowing more funds to be allocated for charitable purposes. Annual Audit Reforms: Waqf institutions earning over Rs 1 lakh must undergo audits

For example, it has sparked controversies like ownership claims over islands in Bet Dwarka, where courts face legal challenges in determining ownership.

• Poor Management : The Waqf Act, 1995 has failed to prevent mismanagement and land encroachments. For example, in Karnataka (between 1975 and 2020), 40 Waqf properties were notified, including farmlands, public spaces, government lands, graveyards, lakes and temples.

• Lack of Judicial Oversight : Under the Waqf Act, 1995, Waqf Tribunal decisions cannot be appealed, which limits judicial review and reduces transparency.

• Misuse of Powers : Section 40 of the Waqf Act, 1995 has been used to declare private properties as Waqf, leading to legal battles. For example, in Kerala, around 600 Christian families protested after the Waqf Board claimed their ancestral lands leading to legal disputes.

The Waqf (Amendment) Bill, 2025 aims to streamline the management of Waqf properties, with provisions to safeguard heritage sites and promote social welfare.

Non-Muslim properties declared as Waqf-The Waqf (Amendment) Bill 2025 aims to streamline Waqf property management while safeguarding heritage sites and individual property rights. Various states have seen disputes over Waqf property claims, leading to legal battles and community concerns. As of data from September 2024, across 25 States/ UTs Waqf Boards, a total of 5973 government properties have been declared as Waqf properties. Some examples of the same:

Tamil Nadu:

A farmer in Thiruchenthurai village was unable to sell his land due to the Waqf Board's claim over the entire village. This unexpected requirement prevented him from selling his land to repay a loan for his daughter's wedding.

Govindpur Village, Bihar: In August 2024, The Bihar Sunni Waqf Board's claim over an entire village in August 2024 affected seven families, leading to a case in the Patna High Court. The case is

In September 2024, around 600 Christian

families in Ernakulam district are contesting

the Wagf Board's claim over their ancestral

land. They have appealed to the Joint Parliamentary Committee. Karnataka:

In 2024, Farmers protested after the Waqf Board designated 15,000 acres in Vijayapura as Waqf land. Disputes also arose in Ballari, Chitradurga, Yadgir, and Dharwad. The government, however, assured that no evictions

would take place.

Uttar Pradesh: Complaints have been raised against alleged corruption and mismanagement by the State Wanf Board.

Further, the Joint Committee on the Waaf (Amendment) Bill (JCWAB) had also received some communications regarding unlawful claim of properties by Waqf Boards, some of which are as under:

Karnataka (1975 & 2020): 40 Waqf properties were notified, includ-

ing farmlands, public spaces, government lands, graveyards, lakes, and temples.

The Punjab Waqf Board has claimed land belonging to the Education Department in Patiala. Additionally, MoHUA (Ministry of Housing and Urban Affairs) informed the JPC during their presentation in September 2024, that 108 properties under control of Land and Development Office, 130 properties under control of Delhi Development Authority and 123 properties in the public domain were declared as Waqf properties and brought into litigation.

The Bill also seeks to improve the economic and social status of Muslim women. particularly widows and divorced women, by promoting self-help groups (SHGs) and financial independence programs.

Iran, US hold fifth round of nuclear negotiations in Rome with enrichment key issue

ROME, May 23: Iran and the United States began a fifth round of negotiations over Tehran's rapidly advancing nuclear programme Friday in Rome, with enrichment emerging as the key issue.

US officials up to President Donald Trump insist Iran cannot continue to enrich uranium at all in any deal that could see sanctions lifted on Tehran's struggling economy. Iran's Foreign Minister Abbas Araghchi early Friday insisted online that no enrichment would mean "we do NOT have a

"Figuring out the path to a deal is not rocket science," Araghchi wrote on the social platform X. "Time to decide." The US is again represented in the talks by Mideast envoy

Steve Witkoff and Michael Anton, the State Department's policy planning director. Oman's Foreign Minister Badr al-Busaidi is mediating the negotiations as the sultanate on the Arabian Peninsula has been a trusted interlocutor by both Tehran and Washington in the talks.

Multiple convoys arrived at the Omani Embassy in Rome's Camilluccia neighborhood just after 1 pm. The embassy previously served as the site of another round of talks. Iranian media just before 2 pm announced the talks had begun, without elaborating.

Enrichment remains key in negotiations

The talks seek to limit Iran's nuclear programme in exchange for the lifting of some of the crushing economic sanctions the US has imposed on the Islamic Republic, closing in on half a century of enmity.

Trump has repeatedly threatened to unleash airstrikes targeting Iran's programme if a deal isn't reached. Iranian officials increasingly warn they could pursue a nuclear weapon with their stockpile of uranium enriched to near weapons-grade levels.

"Iran almost certainly is not producing nuclear weapons, but Iran has undertaken activities in recent years that better position it to produce them, if it chooses to do so," a new report from the US Defence Intelligence Agency said. "These actions reduce the time required to produce sufficient weapons-grade uranium for a first nuclear device to



probably less than one week."

However, it likely still would take Iran months to make a

working bomb, experts say. Enrichment remains the key point of contention. Witkoff at one point suggested Iran could enrich uranium at 3.67%, then later began saying all Iranian enrichment must stop.

That position on the American side has hardened over time. Asked about the negotiations, State Department spokesperson Tammy Bruce said "we believe that we are going to succeed" in the talks and on Washington's push for

"The Iranians are at that table, so they also understand what our position is, and they continue to go," Bruce said Thursday.

One idea floated so far that might allow Iran to stop enrichment in the Islamic Republic but maintain a supply of uranium could be a consortium in the Mideast backed by regional countries and the US.

There also are multiple countries and the International Atomic Energy Agency offering low-enriched uranium that can be used for peaceful purposes by countries.

However, Iran's Foreign Ministry has maintained enrichment must continue within the country's borders and a similar fuel-swap proposal failed to gain traction in negotiations

Meanwhile, Israel has threatened to strike Iran's nuclear facilities on their own if it feels threatened, further complicating tensions in the Mideast already spiked by the Israel-

Hamas war in the Gaza Strip.

Araghchi warned Thursday that Iran would take "special measures" to defend its nuclear facilities if Israel continues to threaten them, while also warning the US it would view it as being complicit in any Israeli attack. Authorities allowed a group of Iranian students to form a human chain Thursday at its underground enrichment site at Fordo, an area with incredibly tight security built into a mountain to defend against possible airstrikes.

Talks come as US pressure on Iran increases

Yet despite the tough talk from Iran, the Islamic Republic needs a deal. Its internal politics are inflamed over the mandatory hijab, or headscarf, with women still ignoring the law on the streets of Tehran. Rumours also persist over the government potentially increasing the cost of subsidised gasoline in the country, which has sparked nationwide

Iran's rial currency plunged to over 1 million to a US dollar in April. The currency has improved with the talks, however, something Tehran hopes will continue as a further collapse in the rial could spark further economic unrest.

Meanwhile, its self-described "Axis of Resistance" sits in tatters after Iran's regional allies in the region have faced repeated attacks by Israel during its war against Hamas in the Gaza Strip. The collapse of Syrian President Bashar Assad's government during a rebel advance in December also stripped Iran of a key ally.

The Trump administration also has continued to levy new sanctions on Iran, including this week, which saw the US specifically target any sale of sodium perchlorate to the Islamic Republic. Iran reportedly received that chemical in shipments from China at its Shahid Rajaei port near Bandar Abbas. A major, unexplained explosion there killed dozens and wounded over 1,000 others in April during one round

Pakistan met all conditions: IMF on financial assistance to Islamabad

WASHINGTON, May 23: The International Monetary Fund (IMF) has said its executive board granted USD one billion in assistance to Pakistan this month after finding out that the country met all conditions and targets for it.

The IMF carried out a review of its extended fund facility (EFF) granted to Pakistan in September last year and based on it, the board approved the amount on May 9, said Julie Kozack, a director at global body's communications department.

The IMF executive board approved the fresh assistance to Pakistan notwithstanding New Delhi's apprehensions that the funds could be used for cross-border terrorism.

India's Defence Minister Rajnath Singh on May 16 pressed the IMF to reconsider the financial assistance, saying Islamabad could use a large part of it to fund the terrorist infrastructure.

At a media briefing Kozack, answering a question, said the IMF executive board approved Pakistan's EFF programme in September last year and the first review at that time was planned for the first quarter of

The fresh assistance was granted following completion of the review, she said.

At the same time, Kozack said any deviation from the established programme conditions would impact future reviews under the Pakistan

What I want to emphasise here is that it is part of a standard procedure under programs that our executive board conducts periodic reviews of lending programmes to assess their

"And they particularly look at whether the programme is on track, whether the conditions under the programme have been met, and whether any policy changes are needed to bring the programme back on track."

"And in the case of Pakistan, our Board found that Pakistan had indeed met all of the targets. It had made progress on some of the reforms, and for that reason, the board went ahead and approved the programme," the IMF official said.

On the use of funds, Kozack said the IMF financing is provided to members for the purpose of resolv-

ing balance of payments problems. Generally explaining the case of Pakistan, she said all of the disbursements received under the EFF are allocated to the reserves of the central

"So, those disbursements are at the central bank, and under the programme, those resources are not part of budget financing. They are not transferred to the government to support the budget," she said.

Kozack said the EFF programme provides additional safeguards through "our conditionality".

"And these include, for example, targets on the accumulation of international reserves. It includes a zero target, meaning no lending from the central bank to the government," she

"And the programme also includes substantial structural conditionality around improving fiscal

North Korea denies warship was severely damaged as full investigation underway on its failed launch

SEOUL, May 23: North Korea is seeking to arrest those responsible for the failed launch of its second naval destroyer, as it denied the warship suffered major damage — a claim quickly met with outside skepticism.

A statement from North Korea on its handling of the botched launch came after leader Kim Jong Un expressed fury over an incident that he said was caused by criminal negligence. The the main military committee said Friday that those responsible would be held responsible for an "unpardonable criminal act."

Satellite imagery on the site showed vessel lying on its side and draped in blue covers, with parts of it submerged. North Korea says it'll take about 10 days to repair its damage, but outside observers question that timeframe because damage to the ship appeared much worse than what North Korea claims.

Here is what you need to know about the failed ship

How much damage was there to the ship

North Korea's state news agency, KCNA, said Friday that the severity of the damage to the 5,000-ton-class destroyer was "not serious" as it cancelled an earlier assessment that the bottom of the hull had been left with

It said the hull on the starboard side was scratched and some seawater had flowed into the stern section. But it said it'll take a total of 10 days to pump up the seawater, set the ship upright and fix the scratches.

It's almost impossible to verify the assessment l cause of the extremely secretive nature of North Korea. It has a history of manipulating or covering up militaryrelated setbacks, policy fiascoes and other mishaps, though it has periodically acknowledged some in recent years. Lee Illwoo, an expert with the Korea Defense Network in South Korea, said the North Korean warship likely suffered much worse damage, including the flooding of its engine room located in the stern section, and holes in the starboard. He said North Korea could simply set the ship upright, paint it and claim the ship has been launched, but that repairs could take more than a year as the replacement of an engine requires cutting

Why the ship's launch failed

According to the North Korean account, the destroyer was damaged when a transport cradle on the ship's stern detached early during a launch ceremony at the northeastern port of Chongjin on Wednesday.

Moon Keun-sik, a navy expert who teaches at Seoul's Hanyang University, said North Korean workers are probably not familiar with launching a 5,000ton-class warship, which is nearly three times heavier than its existing main navy ships.

Observers say North Korea tried to launch the destroyer sideways, a method it has never used for warships, although it has previously employed it with big cargo and passenger ships.

Compared with those non-military vessels, Lee sad it would be more difficult to maintain balance with the destroyer because it's equipped with heavy weapons systems. He suspected North Korean scientists and workers likely did not factor that in.

How Kim has reacted

The damaged ship is assessed as the same class as North Korea's first destroyer, launched with great fanfare last month with a floating dry dock at a western shipyard. It is North Korea's biggest and most advanced warship to date, and Kim called its construction "a breakthrough" in modernizing North Korea's naval forces to cope with what he calls US-led security

Subsequently, a failure to launch the second destroyer was an embarrassment for Kim. But by disclosing it to both internally and externally, Kim could be trying to show his resolve in modernizing naval forces and boost discipline at home. He ordered officials to thoroughly investigate the case and repair the warship before a high-level ruling Workers' Party meeting in

North Korea said Friday the country's Central Miliry Commission summoned Hong Kil Ho, manager of the Chongjin shipyard, as it begun its investigation of

"No matter how good the state of the warship is, the fact that the accident is an unpardonable criminal act remains unchanged, and those responsible for it can never evade their responsibility for the crime," the commission said, according to state media.

Kim Dong-yub, a professor at the University of North Korean Studies in Seoul, said North Korea appears to be using the failed launch as a chance to strengthen the ruling party's control over science and technological sectors. Lee Choon Geun, an honorary research fellow at South Korea's Science and Technology Policy Institute, said that North Korea's handling of the damaged warship could have long-term consequences for its defense science sector, especially if military scientists face harsh punishment.

"If scientists are held severely accountable, I would say the future of North Korea's defense science doesn't look very bright, as it would be a sign that political responsibility is being prioritized over technical accountability," Lee wrote on Facebook. (AP)

UK agrees to hand the Chagos Islands to Mauritius in a deal it says protects a key US base

LONDON, May 23: Britain signed an agreement Thursday to hand sovereignty over the contested Chagos Islands to Mauritius, a move the government says ensures the future of a U.S.-U.K. military base that is vital to British security.

The Indian Ocean archipelago is home to a strategically important naval and bomber base on the largest of the islands, Diego Garcia.

Under the agreement, the U.K. will pay Mauritius an average of 101 million pounds (USD 136 million) a year to lease back the base for at least

Prime Minister Keir Starmer said that base, operated by U.S. forces, is crucial for British counterterrorism and intelligence and is "right at the foundation of our safety and security at home."

"By agreeing to this deal now on our terms, we're securing strong protections, including from malign influence, that will allow the base to operate well into the next century, helping to keep us safe for generations to come," Starmer told reporters at a U.K. military headquarters in Northwood, near London.

KINSHASA (CONGO) May 23: Congo's senate has voted overwhelmingly to lift former President Joseph Kabila of his parliamentary immunity, paving the way for his prosecution over his alleged support of a rebel insurgency in the country's east."The Senate authorizes the prosecution and lifting of Joseph Kabila's immunity," Senate speaker Jean-Michel Sama Lukonde said Thursday after the vote.

Kabila has not commented on his immunity being lifted. Justice Minister Constant Mutamba said the former president is accused of "treason, war crimes, crimes against humanity and participation in an insurrectional movement" in the country's east.

Earlier this month the attorney general of Congo's army asked the Senate to revoke the lifetime immunity from prosecution that Kabila enjoyed because of his honorific title as senator for life.

The decades-long conflict in eastern Congo escalated in January when the Rwanda-backed M23 rebels advanced and seized the strategic city of Goma, followed by the town of Bukavu, which they took in February. (AP)

Trump administration revokes Harvard's eligibility to enrol foreign students, impacting students from India, elsewhere

NEW YORK, May 23: The Trump administration has revoked Harvard University's eligibility to enrol foreign students, raising concerns over the legal status of thousands of students, including nearly 800 from India, currently enrolled at the varsity.

In an unprecedented development, the Trump administration on Thursday ordered the Department of Homeland Security to terminate Harvard University's Student and Exchange Visitor Programme (SEVP) certification.

"This means Harvard can no longer enrol foreign students and existing foreign students must transfer or lose their legal status," the federal agency said.

Homeland Security Secretary Kristi Noem said in a letter dated May 22 to Harvard University that "I am writing to inform you that effective immediately, Harvard University's Student and Exchange Visitor Programme certification is revoked."

The development also threatens to impact the students from India, who are studying at Harvard University. Currently, Harvard hosts a total of about 10,158 students and scholars from around the world across its schools.

According to statistics on the website of Harvard International Office, there are 788 students and scholars from India at all schools under Harvard University for the 2024-25 academic year.

The Harvard Global Support Services said on its website that each year, anywhere from 500-800 Indian students and scholars study

at Harvard.

Ajay Bhutoria, former advisor to President Joe Biden on the Asian American, Native Hawaiian, and Pacific Islander (AANHPI) Commission told PTI in a statement that as an Indian-American committed to fostering opportunity for the community and a strong advocate for immigration policies under the Biden administration, he is "deeply outraged" by the Trump administration's decision. He said Indian students contribute over

USD 9 billion annually to the US economy and strengthen the cultural and economic ties between the two nations, often going on to lead innovation in tech, medicine, and be-"This policy directly threatens over 500

Indian students at Harvard, forcing them to transfer or leave the US before the next academic year begins. These students, who represent the brightest minds from cities like Mumbai, Delhi and Bengaluru, have invested their dreams, finances and futures in a Harvard education—only to have their aspirations shattered by a politically motivated attack," Bhutoria said.

He added that the additional demand by the Department of Homeland Security for protest footage and disciplinary records is a "blatant attempt" to intimidate and silence students, particularly those engaged in ac-

"This is not the America we stand for—an America that should be a beacon of opportu-



nity, not a place of fear for young scholars," Bhutoria said. He added that the termination of Harvard's SEVP certification sends a "chilling message" to Indian students and the broader South Asian diaspora that "your contributions are not valued."

"By targeting Harvard, the Trump administration risks driving talent to countries like Canada and the UK, weakening US-India relations at a time when collaboration is more critical than ever," he said.

Bhutoria called on the administration to reverse this decision immediately and urged the Biden-era allies in Congress to "fight for our students' rights. To the Indian government and our community: let us unite in advocacy, amplify these students' voices, and ensure that education remains a bridge, not a barrier, between our nations.

Noem said in the letter that the revocation of Harvard's Student and Exchange Visitor Programme certification means that Harvard is prohibited from having persons on F or J non-immigrant visa status for the 2025-26 academic school year.

"This decertification also means that existing aliens on F or J non-immigrant status must transfer to another university in order to maintain the non-immigrant status," she

The F-1 Visa (Academic Student) allows individuals to enter the United States as a full-time student at an accredited college, university, academic high school or other academic institution. J visas are nonimmigrant visas for individuals approved to participate in exchange visitor programmes in the

Harvard said that the University is aware of the US Department of Homeland Security order to terminate Harvard's Student and Exchange Visitor Programme (SEVP) certification for the 2025-26 academic year.

"Harvard is committed to maintaining our

ability to host our international students and scholars, who hail from more than 140 countries and enrich the University and this nation," it said. The announcement comes just days before

thousands of foreign students are set to graduate at Harvard. The new academic session will begin in the fall.

Noem said in the letter that if "Harvard would like the opportunity of regaining" its SEVP certification before the upcoming academic school year, it "must provide all of the information requested" within 72 hours.

Harvard is required to provide any and all records, whether official or informal, in its possession, including electronic records and audio or video footage regarding illegal activity, dangerous or violent activity, threats to other students or University personnel, deprivation of rights of other classmates or University personnel, whether on or off campus by a nonimmigrant student enrolled in Harvard University in the last five years.

The university is also required to provide any and all disciplinary records of all nonimmigrant students enrolled in Harvard University in the last five years and any and all audio or video footage in the possession of Harvard University of any protest activity involving a nonimmigrant student on a Harvard University campus in the last five years.

DHS further said that Harvard's leadership has created an "unsafe campus environment by permitting anti-American, pro-terrorist agitators to harass and physically assault individuals, including many Jewish students, and otherwise obstruct its once-venerable learning environment.

"Many of these agitators are foreign students. Harvard's leadership further facilitated and engaged in coordinated activity with the Chinese Communist Party, including hosting and training members of a CCP paramilitary group complicit in the Uyghur



Memo to Labour Minister demanding retired casual/ contingency workers family members engagement

HT Bureau NAMSAI, May 23: The Bharatiya Mazdoor Sangh (BMS), Arunachal Pradesh unit, on Thursday submitted a memorandum to the Minister of Labour & Employment, raising a significant demand on behalf of casual and contingency workers across various government departments. The organization urged the state government to mandate the compulsory engagement of family members of those casual or contingency workers who have retired without receiving any retirement benefits.

In the memorandum, the BMS expressed concern over the difficulties and hardships faced by individuals who had served under casual or contingency employment schemes and have since retired. The union pointed out that these retired workers are not entitled to the retirement benefits typically extended to regular employees, which places them in an even more vulnerable financial position post-retirement. According to the BMS, many such workers, after years of service, are now living in worse financial conditions than they did during their employment due to the absence of any pension or post-retirement security.

The BMS emphasized that these workers, despite contributing significantly to their respective departments and the functioning of have not received any form of retirement the state government over many years, are left without a safety net once their services are terminated upon reaching retirement bring much-needed relief to the families of



age. The organization highlighted that the issue is widespread and has become a source of deep concern among departmental workers and their families.

In response to this ongoing problem, the Bharatiya Mazdoor Sangh, on behalf of the affected workers, has requested the government to adopt a cabinet resolution that would ensure the automatic and compulsory appointment of family members—such as sons or daughters—of the retired casual or contingency workers to vacant casual or contingency (MTS) positions. This measure, the BMS argued, should be applied par-

benefit or pension under existing schemes. The BMS stated that such a policy would the retired workers and would help maintain continuity of livelihood for those who have devoted their lives to public service under less secure employment categories.

Speaking to the media, BMS President Ringu Chapo revealed that the organization had also submitted a two-point charter of demands along with the memorandum. One of the demands calls for the enhancement of the current retirement benefit of ₹ 3,00,000 (Three Lakhs), which was recently announced by the state government, to a more substantial amount of ₹ 10,00,000 (Ten Lakhs).

While the BMS welcomed the received government order (No. SE/APEC-I/E-V/WC-52/2015-16/5559-62) dated 31/03/2016, which formally fixed the superworkers at 60 years, it maintained that the currently sanctioned retirement benefit of ₹ 3 lakh is grossly inadequate. The union emphasized that, considering the long years of hard service rendered by these workersoften under challenging conditions—the sum of ₹ 3 lakh is not enough to provide any meaningful financial support post-retire-



NEW DELHI, May 23: Congress president Mallikarjun Kharge on Friday urged party spokespersons to take the message of social justice to the people fearlessly and treat it as an ideological commitment and not an election issue.

In a message to the spokespersons at their workshop on social justice, he said it is their responsibility to take the issue to the grassroots and create awareness on it among the masses.

Calling the party spokespersons as the voice of our thoughts, he said today, when the country is becoming aware of the caste census, it is our responsibility to take this topic to the public with facts, with sensitivity, and without fear.

This is not only a fight for social justice but also a fight to protect the soul of the Constitution. I appeal to you not to consider this campaign as just an election issue, it is our ideological commitment. Today's dialogue is a proof of our unity in this direction," Kharge said in his video message.

"My best wishes to all of you for this historic effort. Let us together build an India where the identity, dignity and rights of every citizen are equally respected," he stressed.

"This workshop is not just a program, it is a continuation of our thoughts and struggle. Today, when the country is talking about caste iustice, it is the responsibility of the



Congress party to give direction to this discussion, take it from slogan to policy, and make 'Jitna Aabadi Utna Haq' not just a slogan but a national resolution," the Congress chief also said.

He said the issue of caste census is not new and the Congress has constantly raised it, in our manifestos, in Parliament, on the streets, and on every platform where social

justice should be talked about. He said he himself had written a letter to the Prime Minister in April 2023 reiterating the demand that caste census should be started immediately. In that letter, he said he had clearly said that "until we have the correct data, no government can claim that it is providing justice to

"Today we have to ask, what is the participation of OBC, Dalit and Adivasi communities in the power structures of the country? Are they represented in proportion to their population in the media, bureaucracy, judiciary, corporate sector and higher education institutions?

If not, what is the reason for this?

And what is the solution? "The solution is to bring out the truth, make the data public, and then rebuild policies. This is why we consider caste census not just a statistical exercise but a moral obligation of Indian democracy," he

Kharge also said the party also has to clearly demand that Article 15 (5) of the Constitution be implemented immediately, so that OBC,

Dalit and Adivasi students get reservation in private educational institutions

Today, when a large part of education is concentrated in the private sector, denying these communities that access is a form of exploitation, he noted, adding that the Congress believes that no society can be equal without equal opportunity in education.

"We must also ensure that the 50 per cent reservation limit is now reconsidered in the light of new data. When social realities have changed and data is presenting a new picture, our policies must also change accordingly. The current limit of reservation should be seen with a balance of both data and justice, so that OBC, Dalit and tribal communities can get their real rights," he also asserted.

He said the caste survey conducted in Telangana presented a model in which society, experts and the government all participated.

'We want the central government to also adopt a similar publicoriented and transparent model. We are ready to cooperate in this process," Kharge noted.

The central government has already announced that it will conduct the caste enumeration as party of the next census exercise, coming ahead of the Bihar assembly elections slated later this year, where

Rahul takes swipe at Jaishankar, says India's foreign policy has collapsed



NEW DELHI, May 23: Congress leader Rahul Gandhi on Friday claimed that India's foreign policy has "collapsed" and asked External Affairs Minister S Jaishankar to explain why has India been hyphenated with Pakistan and who asked US President Donald Trump to "mediate" between the two South Asian

Gandhi tagged a post by the Congress which carried a video clip of Jaishankar answering questions on the Pahalgam terror attack and the subsequent tensions between India and Pakistan, during an interview with Dutch broadcaster NOS

"Will JJ explain: Why has India been hyphenated with Pakistan? Why didn't a single country back us in condemning Pakistan? Who asked Trump to "mediate" between India & Pakistan?" Gandhi said.

"India's foreign policy has collapsed," the Leader of Opposition in the Lok Sabha claimed.

Gandhi on Thursday had accused Prime Minister Narendra Modi of having compromised with India's prestige and asked him why he sacrificed the nation's interests by agreeing to halting of military hostilities against Pakistan.

"Modi ji, stop giving hollow speeches. Just tell: Why did you believe Pakistan's statement on terrorism? Why did you sacrifice India's interests by bowing to Trump? Why does your blood boil only in front of cameras? You have compromised with the prestige of India!," he had said in a post on X.

Congress leaders have been hitting out at the Exter-

The reference is from the epic poem 'Prithviraj Raso' in which Jaichand, a Rajput ruler, is said to be allied with Muhammad Ghori against another Rajput ruler Prithviraj Chauhan.

AICC secretary in the office of the Congress president Gaurav Pandhi said, "Every single day that Jaichand Jaishankar continues as the Minister of External Affairs, he remains not just a liability but a serious threat to India's national interests. He should be removed from office without delay, and an independent inquiry must be instituted to investigate his failures.

The Congress has been questioning the government for halting Operation Sindoor at a time when the armed forces were going strong and taking decisive action against terror camps in Pakistan.

The war of words between Congress and BJP over their leaders' statements on the Indo-Pak conflict has intensified this week, with the ruling party calling Rahul Gandhi "modern age Mir Jafar" and the opposition party describing Jaishankar as "new age Jaichand".

The two parties traded barbs over their remarks on Operation Sindoor and also posted memes on social media, each suggesting that the other has betrayed the

The Congress and Rahul Gandhi have attacked Jaishankar, alleging he had forewarned Pakistan about Operation Sindoor.

The US President has been repeatedly claiming that he helped settle the tensions between India and Pak-

India carried out precision strikes under Operation Sindoor on terror infrastructure early on May 7 in response to the April 22 Pahalgam terror attack that killed

Following the Indian action, Pakistan attempted to attack Indian military bases on May 8, 9 and 10. The Indian forces launched a fierce counter-attack on sev-

eral Pakistani military installations.

India and Pakistan reached an understanding on May 10 to end the military confrontation after four days of intense cross-border drone and missile strikes.

On May 10, Trump had announced that India and Pakistan agreed to a full and immediate ceasefire after a long night of talks "mediated" by Washington. (PTI)

India's 'Akashteer' system shines in Ops Sindoor, Have donated money to National Herald, says Karnataka DCM Shivakumar **DRDO** chief foresees international demand

NAGPUR, May 23: India's top defence scientist is confident that the success of the indigenously-developed 'Akashteer' air defence system during Operation Sindoor will draw interest from other countries.

'Akashteer', the fully automated air defence control and reporting system, emerged as the invisible force of new war capabilities during Operation Sindoor, launched against nine terror sites in Pakistan and Pakistan-occupied Kashmir.

"Definitely, our air defence system has performed exceedingly well, and I am sure there will be interest from other countries," Defence Research and Development Organisation (DRDO) chief Samir V Kamat told PTI on Thursday evening.

The DRDO chairman spoke about India's march for 'Atmanirbhar' (self-reliance) in the defence sector, saying that while substantial advancements have been made, more work is necessary to become completely self-reliant.

Internal audit flags ₹ 709 crore irregularities in Jal Shakti ministry schemes

NEW DELHI, May 23: An internal audit review of the Jal Shakti ministry for 2023-24 has flagged financial irregularities amounting to over ₹ 709 crore across key water and sanitation schemes.

The report highlighted blocked funds. unauthorised spending, idle machinery, and violations in procurement procedures. According to the Annual Internal Audit Review, ₹ 525.96 crore worth of govern-

ment funds remain blocked. These include unspent balances under the Atal Bhujal Yojana in Maharashtra and Haryana, as well as issues like excess expenditure, irregular expenditure in states

such as Kerala and Bihar. The audit also revealed ₹ 23.56 crore in irregular expenditure, largely due to overspending beyond approved limits for administrative and IEC (Information, Education, Communication) activities

under SBM-G. In multiple instances, funds were diverted for ineligible expenses, and several purchases were made without following overnment e-marketplace (GeM) or tender procedures, leading to further unauthorised purchases worth ₹ 10.82 crore.

The audit report said the non-recovery of government dues from central

government department/state government/government bodies and private parties stood at ₹ 19.05 crore.

In total, the internal audit wing of the ministry reported financial irregularities worth ₹ 70,925.02 lakh (₹ 709.25 crore) across its departments, including non-recovery of dues, irregular expenditures, and unutilized funds.

Idle and damaged machinery valued at Rs 1.32 crore was also discovered lying unused across several field offices.

At the end of the financial year, 3,752 audit paras remained outstanding, up from 3,417 the previous year - even after special camps were held in June and July 2023 to settle pending cases.

In auditing, "audit paras" or "audit paragraphs" refer to specific findings or observations identified by auditors during an audit process. These are detailed statements that highlight irregularities, noncompliance, or areas needing improvement within an organization's operations or financial records.

The Internal Audit Wing also cited staff shortages and lack of specialised training as key challenges, recommending targeted capacity building in risk-based audit methods to ensure more effective oversight in

121 Bangladeshi nationals residing illegally in Delhi to be deported

NEW DELHI, May 22: The Delhi Police has detained 121 Bangladeshi nationals for allegedly residing unlawfully in India with their deportation process being ini tiated through the Foreigners Regional Registration Office (FRRO), an official said on Friday.

The illegal immigrants were rounded up in a week, the official further stated, adding that five Indians were interrogated in the case.

"A case has also been registered at the Narela Industrial Area police station to probe a suspected syndicate allegedly involved in facilitating the illegal entry and stay of foreign nationals in the country," Deputy Commissioner of Police (outer north) Nidhin Valsan said.

Five Indians have been interrogated in connection with the case, one of whom has been served a notice under Section 35(3) of the Bharatiya Nagarik Suraksha Sanhita (BNSS), he added.

A police team carried out an extensive verification drive over the last week, during which documents of 831 suspected Bangladeshi nationals were scrutinised. "As many as 121 individuals were found residing in the country without valid documentation," the DCP said.

A case has been registered under relevant sections of the Bharatiya Nyaya Sanhita (BNS), along with Sections 14 (penalty for contravention of provisions of the Act, etc.) and 14C (penalty for abetment) of the Foreigners Act, 1946, to investigate the syndicate responsible for facilitating illegal entry and residence of immigrants, the officer

A Special Investigation Team (SIT) is probing the matter.

Preliminary investigations revealed that the five Indians involved were renting properties to the undocumented immigrants, the police said. The officer further informed that authorities are also probing the alleged fabrication of government documents, including Aadhaar cards, voter IDs, and electric meter connections, reportedly used by these immigrants to establish local identity.

"Notices have been issued to the concerned departments. Legal action will be taken against all individuals, including government officials, if found complicit in the facilitation of these forged documents," the DCP said, adding that further investigation is underway. (PTI)

May 23: "Jack of all trades" is how Kannur native and a resident of Qatar, Safrina Latheef, the first woman from Kerala to scale the Everest peak, likes to describe herself. Latheef was a banker and a baker before she turned to mountaineering, a long-term desire of

Describing the momentous feat as one of the "toughest" things she has done in her life till now, Latheef said that not just physical fitness, but mental strength was also very important to make the climb.

'The dead bodies shake you up. You could be the next body on the line -- that thought crosses your mind. You have to fight all that to reach the summit," she said in a voice note shared with PTI from

She reached the Everest base camp on April 19, began the climb on April 28, started the final push for the 8000-foot summit on May 12 and reached the top on May 18.

"It is a mental struggle, as we see a lot of unexpected things like avalanches, rock falls and dead bodies of climbers who tried to scale the summit with the same aspirations and dreams as us.

However, reaching the peak is worth all that gruelling effort because of the view from there, said Safrina Latheef, who is in her late

"You are on top of the world, the clouds. There is nothing above you that is the feeling you get. It is difficult to describe it. You have to experience it.' But, her decision to take off her

goggles to experience the view with her naked eyes proved a bit costly as she got blinded by the snow and had to make the descent with poor vision and was subsequently, briefly hospitalised for it,

Earlier in the day, speaking to a news channel from Nepal, Latheef said that she did not realise the heights she was climbing while scaling the summit, but on the way down "I came to realise the enormity of it".

"I am excited with the experience and happy that I got back alive," she added.



Giving details of the effort she put in to achieve the feat, she said that it was during the COVID-19 pandemic that she and her husband realised the importance of health and physical fitness.

"We became health conscious, joined a gym and began running. It was a long-term desire of mine to do adventure trekking. So, after we became healthier, when we had time, we climbed Mt Kilimanjaro (5,895 meters) in Tanzania with some friends," she said in the voice

Since then, her only thought was to climb the highest peak on Earth Mount Everest which stands at 8,849 meters

"For that, we have been training for the last four years. We found a trainer and asked him to train us specifically to climb Everet. We planned to scale Everest last year, but, unfortunately, my husband suffered a training injury.

"This year again he suffered a training injury, but I said I cannot wait any longer and decided to climb it alone. However, my wish

husband," she stated in the voice As part of the training to climb

Everest, the couple climbed Mt Aconcagua in Argentina which is close to 7,000 meters, but it was a rocky mountain. "In order to understand how it

was to climb a snow mountain like Everest, we climbed Mt Elbrus (5,642 meters) in Russia. We also went to the Everest base camp in Nepal to understand the trekking culture," she said. She said she was lucky to have a

climb without him and she went for On what was important to survive the arduous climb to the summit of Everest, she said it was physical and mental fitness and ap-

propriate clothing.

"Proper clothing is important to combat the weather conditions at that altitude. Physical fitness is also very important in order to make the gruelling climb to the top. But most important is mental fitness as without it, one might give up halfway," she said.

Latheef said that each day of her trek, she questioned why she was spending so much money to torture herself physically like this.

"It is very hard to keep our aim in mind because of the amount of physical torture. So, we have to be mentally strong if we have to reach the top," she said. Now that she has returned alive

from Everest, she has no immediate plans to climb any other high "But, I want to complete the seven summits sometime," she

said, referring to the highest moun-

tains on each of the seven traditional continents. Latheef, who has been residing in Qatar for the last 25 years, said, We need to find our own happiness and we cannot depend on oth-

ers for that". (PTI)

Tripura capable of meeting fish demand without Bangladesh imports: Minister

AGARTALA, May 23: Tripura Fisheries Minister Sudhangshu Das on Friday asserted that the state will not suffer from any fish shortage despite the absence of imports from Bangladesh, thanks to robust domestic production and sup-

plies from other Indian states. "Due to recent restrictions imposed by the central government on the import of certain items, fish imports from Bangladesh have halted. However, there is no cause for concern," Das told reporters after a departmental review meeting. "Our current fish production is sufficient to meet 100% of the state's demand. Moreover, we are sourcing additional fish from West Bengal and Andhra Pradesh, which ensures there is

The minister was speaking after chairing a review session of the Animal Resource Development (ARD) Department to evaluate the implementation of the 2025-26 financial year's budget. The meeting was attended by ARD Director Neeraj Kumar Chanchal and senior officials from both state and district levels.

Das said the meeting aimed to strategize optimal use of the newly allocated budget while reflecting on the achievements and shortcomings of the previous financial year. "We have reviewed last year's performance and discussed how to bridge existing gaps. Our focus remains on achieving self-sufficiency not only in fish but also in milk eggs, and meat production, while ensuring veterinary care and welfare," he added.

He also informed that action has already been taken on the resolutions from the previous review meeting. "District-level meetings are underway, and we have successfully utilized around 99% of last year's budget. There are no unspent funds remaining," the minister said.

Govt forms special NIA court in Manipur for trial of cases related to ethnic violence

Jurisdiction of the special court shall extend throughout Manipur



NEW DELHI, May 23: A sessions court in Manipur's Churachandpur has been designated as a special NIA court for the trial of cases related to ethnic violence being investigated by the National Investigation Agency (NIA).

In a notification on Thursday, the Ministry of Home Affairs (MHA) said the court of district and sessions judge, Churachandpur district, has been designated as a special court under Section 11 of the National Investigation Agency Act, 2008 (34 of 2008). "In exercise of the powers conferred by Section 11 of the National Investigation Agency Act, 2008 (34 of 2008), the Central government, in consultation with the chief justice of the High Court of Manipur hereby designates the court of district and sessions judge, Churachandpur district, as the special court for the purpose of Sub-section (I) of Section 11 of the said Act, for the trial of the scheduled offences investigated by the National Investigation Agency," the

The jurisdiction of the special court shall extend throughout Ma-

notification said.

The NIA has taken over three key cases related to ethnic violence that began on May 3, 2023. These cases include the abduction and killing of six women and children in Jiribam, as well as other violent

The NIA registered these cases in November 2024 after the MHA decided to hand them over to the agency for probe due to the severity of the crimes and the escalating violence in Manipur.

Manipur witnessed violence for several months since May 3, 2023. It started after Kuki-Zo tribals living in the hill districts protested over a high court recommendation for granting Scheduled Tribe (ST) status to Meiteis. At least 260 people were killed and thousands rendered homeless in the ethnic violence between Imphal valleybased Meiteis and adjoining hillsbased Kuki-Zo groups. Manipur is currently under the

President's Rule, which was imposed on February 13 after the then chief minister N Biren Singh resigned on February 9.

The state assembly, which has tenure till 2027, has been put under suspended animation.

After the imposition of the President's Rule, Governor Ajay Kumar Bhalla took a number of steps to restore peace and bring back normalcy. There were also efforts from the central government to open the state's roads for normal traffic. However, it did not fructify due to various reasons. (PTI)

Tripura allots land for Data Centre to power digital revolution in NE: CM

AGARTALA, May 23: In a landmark move to position Tripura as a technological leader in the Northeast, Tripura Chief Minister Manik Saha on Friday announced the allocation of land in Agartala for the establishment of data centers, including a state-of-the-art facility poised to serve as a digital hub for the entire eastern and northeastern region of India.

The announcement came during his address at the Rising Northeast Investors Summit 2025 in New Delhi, at a special session titled "IT for Ashtalakshmi: Beyond the Bits and Bytes, Into AI and 5G."

Saha emphasized that the Tripura government is committed to building robust digital infrastructure to support the convergence of Artificial Intelligence (AI) and 5G technologies—paving the way for transformative governance and innovation in the region.

"The eight northeastern states, fondly referred to as 'Ashtalakshmi', embody nature's abundance and untapped potential. Much like the goddess they are named after-symbolizing prosperity, knowledge, and strength—this region stands at the cusp of a digital renaissance," the Chief Minister said.

He highlighted that Tripura now boasts comprehensive 5G connectivity across all towns and 583 villages, making it one of the best-connected states in the region. These advancements are supported by the state's forward-looking policies, including the Information Technology Policy 2022 and the Data Center Policy 2021.

Saha underscored the synergistic relationship between AI and 5G, noting that while 5G enables ultrafast, low-latency communication, AI introduces intelligent automation and data-driven decision-mak-

"It's not just about speed—it's about unlocking innovation across sectors. Whether through edge computing or real-time analytics, the AI-5G fusion will redefine possibilities in healthcare, agriculture, education, and beyond," he added.

Reaffirming the state's proactive approach, the Chief Minister noted that Tripura recently hosted a high-level workshop titled "AI for Good Governance" in collaboration with the Ministry of Electronics and Information Technology and the National e-Governance

The workshop showcased how AI is being harnessed to streamline public services. A notable success story is Tripura's move towards paperless administration, which has reduced file processing time from nine days to just three—yielding annual savings of over Rs 50

"These reforms are more than just digital upgrades. They are about creating a governance model built on transparency, accountability, and efficiency," Saha said. Looking ahead, he announced that the state will soon launch department-specific AI pilot projects and a single-window digital platform to enhance citizen serv-

AGARTALA, May 23: Former Tripura Chief Minister Biplab Kumar Deb on Friday strongly criticised the CPI(M) for opposing the recent killing of 27 Maoists—including their general secretary Nambala Kesavarao-in an encounter with security forces in Chhattisgarh.

In a video message, Deb, the BJP MP from the West Tripura constituency, said the CPI(M) Politburo's condemnation of the Maoist killings revealed the party's "real character"

"This only proves that they are against our country, against our territory and anti-social. Even during Operation Sindoor they also organised programs in West Bengal supporting China and Pakistan. BJP vehemently opposes their stance," Deb

He said the Maoists had annihilated thousands

of people, including political leaders and security forces, but when they were killed in an encounter with the security forces, the Marxists were condemning the killing.

"I hate them unequivocally. They are working as a white colour political party and supporting the Maoists," he said.

Tripura unlikely to be affected due to closure of Top officials effigies traffic in Assam's Badarpur on NH-6: Official



AGARTALA, May 23: The maintenance of a key bridge in south Assam's Badarpur is unlikely to affect movement of vehicles to Tripura, an official said on Friday.

The NHIDCL has suspended vehicular movement for two months due to major maintenance and rehabilitation of the bridge, locally known as Gammon Bridge, at Badarpur, the official said.

"Tripura is unlikely to be affected by the major bridge repairing work over the Barak river in Assam's Badarpur even as National Highways & Infrastructure Development Corporation Ltd (NHIDCL) announced the suspension of vehicular movement on the Assam-Agartala national highway," Tripura Transport Secretary C K Jamatia told PTI over phone from New Delhi.

"As per the latest report, vehicles are returning to the state as scheduled. An alternative route, Silchar-Kalain-Guwahati, is open for vehicular movement," he said.

He added that traffic movement on the na-

tional highway has not completely stopped yet, as per the latest report received by the state administration.

The Managing Director and Highway Administration of NHIDCL, Krishan Kumar, in an official order on Tuesday (May 20), announced the suspension of vehicular movement at Badarpur for undertaking major bridge repair works over the Barak river.

Under section 31 and section 33 of the Control of National Highways (Land & Traffic) Act, 2002, the Highway Administration has ordered temporary closure for undertaking repair and rehabilitation of a major bridge, locally known as Gammon Bridge, over Barak river on the National Highway 6 in Assam's Cachar district for vehicular for a period of 60 days (From May 21 to July 20, 2025), Kumar said in the order.





MUMBAI, May 23: A film should offer a novel experience to audiences, regardless of genre, says actor Tusshar Kapoor, who is awaiting the release of his horror comedy "Kapkapiii"

The genre of horror comedy has become increasingly popular in recent years, with films such as "Stree 2", "Bhool Bhulaivaa 3", and "Munjya" enjoying massive box office success

in 2024. Asked whether the genre guaranteed success at the ticket window, Kapoor said it depends on the story

"Each film has its own destiny. If it's good, then it will work. There's no guarantee that a horror comedy film will work. The film should be good. It should have something new. The script and presentation should be good. We hope people like our film. But, without any biases, this is quite a 'paisa vasool' film," the actor told PTI in an interview here.

Ganemat also secured victory by a one-shot margin, finishing with 53 ahead of Maheshwari Chauhan's 52 in the women's

Angad Vir Singh Bajwa and Parinaaz Dhaliwal finished third in the men's and women's categories, respectively.

Earlier, in the final two qualification, Bhavtegh Singh Gill shot 22 and 24 to add to his 73 from Thursday, qualifying in first

Mairaj totalled 118, while Smit Singh with 117, Angad with 116, and Anantjeet with 115 completed the top six qualifiers.

In the women's category, Ganemat topped the qualification round with 114 shots, followed closely by Maheshwari with 113.

Parinaaz also shot 113, while Oshmi Shrivas, Darshana Rathore, and Mansi Raghuwanshi rounded out the top six with scores of 108, 107 (SO-3), and 107 (SO-2), respectively.

A separate selection trial was not conducted for junior athletes and as a result, Oshmi and Mansi were also placed first and second in the junior category with the same scores. Agrima Kanwar was placed third with a score of 104.

In the men's junior category, Yuvaan finished on top with a score of 110, while Yashwardhan Singh Rajawat and Anjaneya Singh Mandawa finished second and third with scores of 108 and 106, respectively.

The selection committee will consider the scores from the ISSF Junior World Cup in Suhl. Germany, for junior athletes participating in that event, as selection trials 2 coincides with it. Scores of such shooters will not be marked as "zero," the National Rifle Association of India (NRAI) said. (PTI)

Ancelotti had already been announced as the next Brazil coach but the Spanish club had yet to make any announcement about his departure. Ancelotti had another year left on his contract.

"Real Madrid and Carlo Ancelotti have reached an agreement to bring an end to his time as Real Madrid coach," the club said in a statement. "Our club wishes to express its gratitude and appreciation for a man who is a true leg-end of both Real Madrid and world football.'

Madrid will pay tribute to Ancelotti on Saturday during the team's final match of the league season against Real Sociedad in the Spanish league at the Santiago Bernabeu Stadium. Also bidding farewell on Saturday will be veteran midfielder Luka Modric.

"Carlo Ancelotti will forever be part of the great madridista famlly," Madrid club president Florentino Pérez said. "We feel incredibly honored to have had the chance to enjoy a coach who has helped us achieve so much success, but who has also embodied our club's values in such exemplary fashion.

Barcelona seek 3-peat of Arsenal in Lisbon final

LISBON, May 23: Barcelona is aiming to complete a three-peat of Women's Champions League titles and win its fourth European crown in five years when it faces Arsenal in Lisbon on Saturday.

Barcelona is out to reaffirm its status as the dominant force in European women's soccer after it finally beat Lyon and successfully defended its title in last year's final. Its possession-hungry and high-scoring attack is led from the midfield by Ballon d'Or winners Aitana Bonmatí and Alexia Putellas and several other members of Spain's World Cup-winning team that beat England in the 2023

Barcelona will be play its sixth Champions League final in seven seasons and a record-equaling fifth in a row at Lisbon's 50,000capacity Estádio José Alvalade. The Catalan club has the chance to become the only team other than Lyon to lift the European Cup in three consecutive years.

Standing in its way is an Arsenal team that has excelled as a spoiler this campaign and hopes it can pull off another upset and win its second European title.

"They're a fantastic team and they've obviously got the recent history to prove it," Arsenal defender Leah Williamson said about Barcelona in the buildup to

'We respect them a lot, but it's a final, so everybody turns up and everybody gives their best." Firstyear Barcelona coach Pere Romeu has a side that can hit from all angles with multiple scoring op-

It leads all the major team statistics in attack: most goals scored with 44 — to Arsenals' 25 — the highest possession, best pass accuracy and most shot attempts.

Barcelona forward Claudia Pina leads the competition in scoring with 10 goals, ahead of Arsenal pair Mariona Caldentey, who joined from the Spanish club last summer, and Alessia Russo with seven each. Bonmatí and teammate Patri Guijarro lead the competition with five assists each.

Barcelona added to its winning squad in the offseason by signing Poland striker Ewa Pajor, who went on to lead the Spanish league with 23 goals. Pajor, 28, is seeking her first European title after losing four finals with former club Wolfsburg, including the 2023 final to Barcelona after leading 2-0. "The final is played in the details and we can prepare the details before the game," Pajor said. "What I have also learned because I've played in four finals - you have to be there in the first minute until the end.'

Barcelona has rolled to a sixth consecutive Liga F title and has reached another Copa de la Reina final, but at the same time it has proven beatable.

Barcelona's home unbeaten run in Liga F came to an end after a record 64 games this season, and it lost to Real Madrid for the first time in 19 clasicos since its top rival founded a women's team. It also started the Champions League with a rare group stage loss to Manchester City. (AP)

From borrowing money to beach glory: Prasanna Bendre's hard work finally pays off

DIU, May 23: His sporting aspirations were once powered by borrowed money and crowdfunding campaigns. But now, Prasanna Bendre has emerged as a breakout star with a hat-trick of medals at the Khelo India Beach Games.

At the inaugural edition of the games, Bendre has won two gold and a bronze in pencak silat, a traditional martial art form with roots in the Indonesian and Malaysian civilizations and which was part of the 2018 Asian Games.

Prior to this moment of glory, his father knocked on doors, sent messages, and even turned to reluctant relatives to seek support for his son's passion for a sport most in India have not heard of.

"I don't remember the schedule of my events anymore," a smiling Bendre told PTI after his final medal -- a bronze in the ganda (doubles) event with partner Sudhanshu to cap a successful week

"It's been non-stop matches since Monday. But I'm not tired. I'm just grateful." The 23-year-old's journey began

on a difficult note.

Hailing from Daman, a coastal town in the union territory of Dadra and Nagar Haveli & Daman and Diu (DNHDD), Bendre's choice of the sport didn't make things easy for him and his family. It wasn't cricket or badminton.

There were no sponsorships, no fanfare. Only questions. "People used to ask, 'Isse kya ho jayega?' (What will you even

achieve with this?)," he recalled. "But once I started winning medals, their attitude changed. All the negatives turned into positives. Meri mehnat rang layi hai (my

hardwork has paid off)." To support his sporting dreams, Bendre's family went to extraordi-

His father spearheaded crowdfunding campaigns, knocking on doors and sending messages to raise money for his international travel. They even borrowed from reluctant relatives, managing whatever little they could.

'To compete internat had to do crowdfunding. We belong to the Maharashtrian community, and even they stepped in to help," he said. "Some relatives were reluctant at first. But now, they are so proud -- my phone hasn't stopped ringing with congratu-



latory messages," he said.

Bendre struck gold in tanding (45kg combat), followed it up with another in tunggal (solo demonstration), and ended with a bronze in ganda (doubles), keeping hosts DNHDD ahead of giants such as Maharashtra and Harvana in the pecking order midway into the

"It's a proud moment. To win three medals and be the top performer from a small UT is something I'll always cherish," he said.

"I hope it is there in the Asian Games next year and I get to win a

"I hope pencak silat becomes part of the Olympics in the next 10 years. My dream is to represent India and win a medal there."

His love for martial arts began in 2016 with taekwondo. But a mismatch in weight -- he weighed only 40kg while the lowest category there was 54kg -- made things difficult for him. "No matter how hard I tried, I was always at a disadvantage. In pencak silat, I found a fair chance in the under-40kg category. That's when I made the switch in 2019.'

His breakthrough came in 2022, when he won silver at the Asian Championship in Srinagar, followed by a bronze in Dubai the next year. Earlier this year, he reached the

quarterfinals of the World Championship in Abu Dhabi, narrowly missing a medal, all achieved through crowdfunding.

Despite his packed Bendre is also pursuing an MA in Psychology from Madhav University in Rajasthan.

"I want to grow in both academics and sports. I also want to become a coach someday and help others like me." he said. (PTI)

F1 hopes extra pit stops bring more excitement in the glamorous but dull Monaco Grand Prix

MONACO, May 23: The Monaco Grand Prix may be "the jewel in Formula 1's crown" but the race itself is rarely must-see TV. Sometimes, it's downright dull.

F1 and its governing body, the FIA, hope a rule change for Sunday's race will change that. Drivers will be forced to change tires at least twice in the hope that more pit stop strategy could shake up an event where Saturday qualifying — and the resulting grid position — is often more important than race day.

"I guess it can go both ways. champion Max Verstappen said Thursday. "It can be quite straightforward, or it can go completely crazy because of safety cars coming into play or not making the right calls. I think it will spice it up probably a bit more.

The change is designed to stop a repeat of last year, when a first-lap crash brought out the red flag, allowing everyone to make their one mandatory tire change.

With overtaking all but impossible on the twisty Monaco streets, the rest of the race was a procession. Home driver Charles Leclerc took the win for Ferrari and all of the top 10 finished in grid order.

How Sunday's race shakes out could depend on whether teams get creative with their strategies.

"Normally, with one stop, once you have a good pit stop and everything is fine, then you drive to the end and just stay focused and not hit the barrier," Verstappen said. "But something different, people gambling, guessing when the right time is to box.'

McLaren's Monaco pedigreeMonaco was once McLaren territory. It could be again. It's the most successful team with

15 wins in Monaco, but none since

Lewis Hamilton took the victory in

Gill front-runner as India decides on new Test captain for England tour

MUMBAI, May 23: India's cricket selectors will set the ball rolling for the team's long transition journey in the longest format when they pick a new Test captain and finalise the squad for what is expected to be a challenging five-match series in England, here on Sat-

The 25-year-old Shubman Gill is a clear favourite to land the high-profile job as Indian embarks on a new World Test Championship cycle following the retirement of stalwarts Virat Kohli and Rohit Sharma in a span of one week.

By simple logic, Jasprit Bumrah was the vice-captain on the previous tour of Australia and he should be elevated to the leadership role but question marks over his long-term fitness and workload management are likely to go against him on the discussion table.

Rishabh Pant has had a forgettable IPL but he remains a vital part of India's transition phase in the Test format. The selectors are likely to make him vice-captain.

Barring the leadership conundrum, no major shake-up is expected.

Though Rohit and Kohli's exit leaves a massive void, the likes of K L Rahul can provide much-needed experience in the batting department.

Rahul and Yashasvi Jaiswal are expected to open in the first Test beginning in Leeds on June 20 but hot on their heels will be Sai Sudharsan, who is likely to be picked as a reserve opener.

It remains to be seen if one among Karun Nair, Sarfaraz Khan or Shreyas Iyer make it as an additional specialist batter.

Following the retirement of another stalwart, R Ashwin, Ravindra Jadeja will be lead spinner in the squad and it would be interesting to see if the selectors go with two or three



spinners in English conditions.

COLOMBO, May 23: Veteran Sri Lankan all-rounder Angelo Mathews on Friday announced that the first Test against Bangladesh next month will be his last fiveday game as he makes way for younger talent in the traditional format with a "grateful heart and unforgettable memories."

The 37-year-old will, however, continue to play white-ball cricket for his country. His final Test appearance will be in Galle from June 17 to 21

"With a grateful heart and unforgettable memories. It is time for me to say goodbye to the most cherished format of the game, International Test Cricket!...The first Test match against Bangladesh in June will be my last red-ball appearance for my country," he posted on 'X'.
"Whilst I bid adieu to the Test format, as

discussed with selectors I will remain available for selection for the white ball format, if and when my country needs me.
"I believe this Test team is a talented

side with many future and present greats playing the game. Now seems like the best time to make way for a younger player to take the mantle to shine for our nation," he added.

Since making debut in 2009, Mathews has turned up in 118 Tests, scoring 8167 runs -- the third-highest tally in Sri Lanka's history, behind Kumar Sangakkara (12,400) and Mahela Jayawardene (11.814).

He has a fairly good average of 44.62 and has so far smashed 16 hundreds and 45 centuries with a 200 not out being the best of his lengthy career. He also has 34 wickets

Mathews, who was Sri Lanka's all-format captain from 2013 to 2017, said he has considered playing the format the highest hon-



It'll be tough without Rohit and Virat but also an opportunity for others, says Gambhir

NEW DELHI, May 23: India head coach Gautam Gambhir has admitted that dealing with the absence of Virat Kohli and Rohit Sharma will be a significant challenge for the team but their Test retirement has also opened the door for others to step up and take responsibility.

Kohli and Rohit bid farewell to Test cricket within a week of each other earlier this month. The announcements came ahead of the marquee five-match series in England next month, the squad for which will be announced on Saturday in Mum-

"I think, when you start the game and when you want to finish, it's a very individual decision. No one has the right. Be it the coach, the selector, be it anyone in this country has any right to tell someone when to retire and when not to retire. So it comes from within," Gautam Gambhir told CNN-News18.

With their exit, India will not only need a new Test captain but will also be without two of their most seasoned players, a leadership and experience void, Gambhir admits, won't be easy to fill.



"And yes, we've got to be without two senior players to really experience players. And sometimes I believe that it's the opportunity for some other people to put their hand up and say, 'Okay, I am ready

He drew a parallel with India's Champions Trophy triumph, which came despite the absence of pace spearhead Jasprit Bumrah.

"So yes, it will be tough, but then there'll be people putting their hand up for sure because this question was asked to me before. Champions Trophy as well. 'When Jasprit Bumrah wasn't there

and I said exactly the same thing, someone missing out might give another person an opportunity to do something special for the country, hopefully, there'll be other guys waiting for that opportunity," he said

While Kohli and Rohit have bid adieu to the Test and T20 format, they will still be available for India in the 50-over

Asked if the two can make the team for the 2027 ODI World Cup, Gambhir said "Look, it's still a long way away. We still have a T20 World Cup before that, and that is again a huge tournament that is going to happen in India, which is in February-March," he pointed out.

"So the entire focus at the moment, after England, will be on the T20 World Cup, and November-December 2027 is still two-and-a-half years away. And I've always said one thing – if you keep performing, age is just a number," he added. (PTI)
