No steps initiated to resolve nine demands

Sit-in by employees' union of ONGC completes 7 days

GUWAHATI, May 27: The indefinite sit-in by the employees' union of ONGC's Assam Asset completed a week on Tuesday with no immediate solution in sight to solve a slew of demands, including restarting a recruitment process, overtime allowance and regularisation of a section of temporary staff.

The ONGC Purbanchal Employees' Association (OPEA) initially protested by wearing black badges for a few days and then started a sit-in from May 21 at Assam Asset's head office in Nazira of Sivasagar district.

It, however, has not affected the company's operation as of now, the employees' union said.

"Our main focus is to restart the recruitment process. Nowadays, all work is being outsourced to private parties. Our local youths are being deprived of job opportunities due to this decision of the management," OPEA General Secretary Sanjeeb Boruah told PTI.

He alleged that despite having thousands of vacancies, the management has stopped the recruitment process since 2023, severely impacting operations and denying vital employment opportunities to the youths of Assam.

"It is known that in the year



2022, the Executive Committee of the PSU had sanctioned nearly 300 regular posts (unionised category) for ONGC Assam Asset, ONGC Jorhat and ONGC Silchar. But this process was halted due to unknown reasons," Boruah claimed.

As a Maharatna company operating in the state, ONGC has a "greater responsibility towards local employment generation, which is being undermined by this continued inaction", he added.

"After we announced our agitation programmes last month, a team from ONGC headquarters visited Assam and held talks with us on April 29. However, a solution to the impasse could not be found,"

Bornah said.

When contacted, a senior official of ONGC Assam Asset declined to comment on the development, saying that "it is an internal matter between the union and the management".

Boruah said if the company does not accept their demands, the employees' union will go to the next step of a 'hunger strike', followed by a 'tool-down strike'.

"The union has already served a notice for the hunger strike. We just hope that the management will listen to our legitimate demands before that," he added.

As part of the demands, OPEA has raised issues like the sudden ues and (CONTD. ON PAGE-2)

"This sudden and unjustified action has dealt a devastating blow, not only jeopardising the livelihoods of over 1,000 dedicated employees, but also casting a long shadow over the well-being of 1,000 families, including their children and spouses.

"This decision, made without foresight or compassion, will forever mark a painful chapter in the legacy of the Assam Asset — a blemished page in its history, etched with distress, betrayal, and hardship," the union claimed in the

OPEA also demanded the regularisation of tenure-based field operators (TBFO) and paramedical staff, who have served ONGC for over two decades with unwavering commitment, the union said.

"Despite repeated representations, deliberation, and commitment from ONGC Management, their regularisation remains pending. Their continued exclusion from permanent employment reflects poorly on our collective val-

Dibrugarh district. According to the Duliajan Police, the incident involved a confrontation with depot staff, leading to charges under sections of the Bharatiya Nyaya Sanhita (BNS) 2023, including assault and public disturbance.

Baruah was remanded to judicial custody on May 19 and held at Dibrugarh Central Jail until his re-

The case gained attention due to Baruah's past role as AASU general secretary, a position he resigned from in September 2024 amid unrelated sexual harassment allegations, which he denied. AASU has since distanced itself from (CONTD. ON PAGE-2)

Above-normal June rainfall to keep heat in check: IMD

NEW DELHI, May 27: India is likely to receive above-normal rainfall in June, which is expected to keep maximum temperatures in check in most parts of the country, the India Meteorological Department (IMD) said on Tuesday.

At a press conference, M Ravichandran, Secretary in the Ministry of Earth Sciences, said rainfall across the country during June is likely to be more than 108 per cent of the long-period average of 166.9 mm.

"During June, most of the country is expected to receive normal to above-normal rainfall. However, some southern parts of peninsular India and parts of northwest and northeast India may receive belownormal rain," he said.

IMD Director General Mrutyunjay Mohapatra said that due to this expected good rainfall, most parts



of the country may experience normal to below-normal maximum temperatures, except for many areas in Northwest and Northeast

Above-normal minimum temperatures are likely over most parts of the country, except some parts

of central India and the adjoining south Peninsula owing to the

cloudiness, he said.

From June to September, he said, the country is likely to receive 106 per cent of the long-period average rainfall of 87 cm.

Rainfall between 96 per cent and

104 per cent of the 50-year average of 87 cm is considered 'normal', the IMD said.

Northwest India is likely to receive normal rainfall, while the Northeast may see below-normal rain. Central India and the southern peninsular region are expected to receive above-normal rainfall, he

The monsoon core zone is likely to receive above-normal rainfall (more than 106 per cent of the long-period average) this season. This zone includes parts of Madhya Pradesh, Chhattisgarh, Maharashtra, Odisha and nearby areas, which depend heavily on monsoon rain for agriculture.

Above-normal rainfall is expected in most parts of the country, except for Ladakh, adjoining areas of Himachal Pradesh, northeastern states and (CONTD. ON PAGE-2)

The 55-year-old climber leading stood atop the 8,849-meter summit at around 4 am under stable weather conditions, according to Mingma Sherpa, chairman of Seven Summit Treks, the expedition organiser.

The 30-share BSE Sensex dropped 624.82 points or 0.76 per cent to settle at 81,551.63 in a volatile session. During the day, the barometer tanked 1,054.75 points or 1.28 per cent to 81,121.70. As many as 25 Sensex shares declined while five advanced.

The 50-issue NSE Nifty declined 174.95 points or 0.70 per cent to 24,826.20. The barometer saw sharp swings in both directions in the first half but sustained profit-taking in heavyweight stocks dragged the index down.

Key indices Sensex and Nifty had advanced around 1.5 per cent in the past two sessions.

Analysts said investors turned cautious ahead of the release of industrial and manufacturing production data for April on Wednesday and the first quarter GDP numbers, scheduled to be announced later this week.

undermines the principle of dignity of labour," the union claimed. "These frontline workers deserve recognition and security, not indefinite contractual uncertainty," it said.

The notice also pointed out that the alleged unavailability of essential PPE items such as safety shoes, coveralls and hand gloves has been a "persistent concern, particularly affecting the safety of the field employees". "Despite repeated concerns raised by the union, the management has consistently failed to ensure the timely provision of these basic protective items, thereby compromising the personal safety of our frontline workers,' the union alleged. This ongoing issue continues to remain "unresolved, reflecting a serious lapse in compliance and accountability" within the entity", it claimed.

Some other important issues the union has raised are "inordinate delay in the agreed upgradation process of class IV fire personnel, field duty expenditure (FDE) to employees of central workshop (CWS), rising trend of privatisation and outsourcing and discontinuation of certain medical facilities". (PTI)

India saw 934.8 mm of rainfall in 2024, 108 per cent of the average. In 2023, it recorded 820 mm, 94.4 per cent of the average. In 2022, it saw 925 mm; 870 mm in 2021; and 958 mm in 2020, according to the IMD data.

Visit of Parliamentary teams

The Modi government has launched a significant international diplomacy effort to seek support from the global community in the fight against Pak-sponsored terrorism. Seven all-party delegations have been sent to major international capitals this week New Delhi launched 'Operation Sindoor' following a terrorist attack by militants linked to Pakistan in Pahalgam on April 22. It saw the death of 26 civilians. This marked the worst assault on civilians since the 26/11 Mumbai attacks. New Delhi is working on diplomatic efforts regarding the Pahalgam attack and New Delhi's retaliation. However, the international response has been mixed. The U.S., Japan, the UAE, and the UN have called for restraint and dialogue, while Israel supports New Delhi. China has condemned the strikes and urged both sides to stay calm. The all-party delegations of MPs are a good strategy to inform and seek support from the global community. Notable MPs chosen include Shashi Tharoor and Anand Sharma (Congress). Baiiavant Panda and Ravi Shankar Prasad (BJP), Sanjay Kumar Jha (JDU), Shrikant Eknath Shinde (Shiv Sena), Kanimozhi (DMK), and Supriya Sule (NCP) among others.

The delegation members will engage with various stakeholders. including political leaders and intellectuals. They are articulate and well-prepared to perform their roles. They will engage with many people, including political leaders and intellectuals. The delegations, which is already on its job, are scheduled to visit 33 countries. There are 31 political leaders from the ruling National Democratic Alliance (NDA) and 20 from other parties in the delegations. They will be assisted by former diplomats. Their mission embraces the message of the "One Message, One Nation, One Bharat" campaign. The goal is to present a unified stance against Pakistan-sponsored terrorism. This united effort, where the BJP, Opposition and Muslim communities speak in one voice about zero tolerance of terrorism, not only strengthens New Deli's commitment but also reassures the global community of India's resolve. This is not the first time the government has taken the Opposition on board on foreign policy issues. Former Prime Ministers P.V. Narasimha Rao (Congress), A.B. Despite the government and the Opposition not being on the same page on many issues, when the government invited the Opposition to join

The Modi government aims to reduce criticism of its 'Operation Sindoor' by involving Opposition Members of Parliament (MPs) in international diplomatic efforts. The primary goal is to present a united front against terrorism. This move of the BJP is a welcome step for democracy as it will strengthen India's position in a multipolar world. Incorporating diverse opinions is a positive step for India's diplomatic efforts. Overall, sending all-party delegations to address this crucial issue is commendable.

Northeast rising: Modi's vision turns frontier into economic powerhouse

he Rising North East Investors Summit 2025, inaugurated by Prime Minister Narendra Modi on May 23, 2025, at Bharat Mandapam in New Delhi, marks a pivotal moment in the economic reawakening of India's Northeastern Region (NER). This two-day summit, concluding on May 24, serves as a clarion call to global and domestic investors, spotlighting the Northeast as a land brimming with untapped potential. Long overshadowed by its geographic isolation and a historical lens that prioritized security over development, the NER is now poised to emerge as a cornerstone of India's vision for a Viksit Bharat by 2047. With investment proposals totaling an unprecedented Rs 4.22 lakh crore, as announced by Union Minister for Communications and Development of North Eastern Region Jyotiraditya M. Scindia, the summit underscores a transformative shift in perception—from a peripheral frontier to a dynamic front-runner in India's growth nar-

The Northeast, comprising eight states— Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, and Tripura—has historically been marginalized due to its challenging terrain and a myopic policy approach that viewed the region primarily through a security prism. This isolation, compounded by decades of underinvestment, left the NER trailing behind India's more developed regions. However, the past two decades have witnessed a gradual shift, with infrastructure projects, policy reforms, and a renewed focus on economic integration beginning to reshape the region. Despite these strides, the journey to parity remains long, necessitating events like the Rising North East Investors Summit to catalyze sustainable and inclusive growth.

Prime Minister Modi, in his inaugural address, described the Northeast as "the most diverse region of our diverse nation," encapsulating its unparalleled richness in nature, wildlife, landscapes, ethnic cultures, history, and heritage. This diversity, he emphasized, is the region's greatest asset, positioning it as a hub for tourism, bio-economy, bamboo industry, tea, petroleum, sports, and skill development. The summit, attended by dignitaries including Union Minister Jyotiraditya M. Scindia, Assam Chief Minister Himanta Biswa Sarma, Arunachal Pradesh Chief Minister Pema Khandu, Meghalaya Chief Minister Conrad Sangma, Mizoram Chief Minister Lalduhoma, Nagaland Chief Minister Neiphiu Rio, Sikkim Chief Minister Prem Singh Tamang, and Tripura Chief Minlective commitment to transforming the NER

into a beacon of opportunity. The summit's significance lies not only in its scale but also in its strategic intent. It builds on a series of pre-summit activities, including roadshows, state roundtables, an Ambassador's Meet, and Bilateral Chambers Meet, orchestrated by the central government with robust support from NER state governments. These efforts culminated in a platform that brought together policymakers, industry leaders, and investors to explore key sectors: tourism and hospitality, agro-food processing, textiles, handloom, handicrafts, healthcare, education, skill development, information technology, infrastructure, logistics, energy, entertainment, and sports. The event featured ministerial sessions, Business-to-Government dialogues, Business-to-Business meetings, startup showcases, and

exhibitions highlighting policy initiatives, creating a vibrant ecosystem for investment discussions.

A cornerstone of the summit's narrative was the shift from India's erstwhile "Look East" policy to the more proactive "Act East" framework, which Prime Minister Modi articulated as a vision defined by the acronym EAST: Empower, Act, Strengthen, and Transform. This policy shift has placed the Northeast at the heart of India's economic and geopolitical strategy, particularly as a gateway to Southeast Asia. The region's strategic location, bordering ASEAN nations, positions it as a critical trade bridge. Modi highlighted the potential for trade with ASEAN, currently valued at \$125 billion and projected to surpass \$200 billion in the coming years, with the Northeast playing a pivotal role. Projects like the India-Myanmar-Thailand Trilateral Highway and the Kaladan Multimodal Transit Project, which will connect Kolkata Port to Myanmar's Sittwe Port via Mizoram, are set to enhance regional connectivity, reduce trade distances, and boost industrial growth.

Infrastructure development emerged as a central theme, with Modi underscoring its role in fostering investor confidence and driving economic activity. The past decade has seen an "Infrastructure Revolution" in the NER, with investments of thousands of crores transforming connectivity. Notable projects include the Sela Tunnel in Arunachal Pradesh, the Bhupen Hazarika Bridge in Assam, 11,000 kilometers of highways, new railway lines, doubled airport capacity, waterways on the Brahmaputra and Barak rivers, and a 1,600-kilometer Northeast Gas Grid ensuring reliable energy for industries. The expansion of digital infrastructure, including 13,000 kilometers of optical fiber and 4G/5G coverage, has further positioned the Northeast as a digital gateway. These advancements, coupled with the development of Guwahati, Imphal, and Agartala as Multi-Modal Logistics Hubs and Land Custom Stations in Meghalaya and Mizoram, are unlocking new avenues for trade with Indo-Pacific nations.

Tourism, a sector with "mindboggling potential" as described by Modi, is a key focus for the NER. The region's biodiversity, cultural heritage, and natural landscapes make it an ideal destination for eco-tourism, cultural tourism, and wellness tourism under India's "Heal in India" initiative. The doubling of tourist numbers in recent years has spurred the growth of homestays, created jobs for young

guides, and expanded the tour and travel ecosystem. However, realizing this potential requires a futuristic vi-

sion backed by robust planning and groundlevel execution. The state governments must balance development with the preservation of the region's natural environment, which Modi described as its "very soul." Sustainable tourism, intertwined with environmental conservation, is non-negotiable to maintain the Northeast's unique appeal.

The bio-economy and bamboo industry, alongside tea and petroleum, represent timetested and emerging sectors with significant investment potential. The Northeast's climate and soil are ideal for organic farming, with products like tea, pineapples, oranges, lemons, turmeric, and ginger gaining international acclaim. The region's organic farming scope has doubled over the past decade, aligning with the global demand for organic food. Modi's vision of an Indian food brand on every global dining table hinges on the Northeast's agricultural prowess. Initiatives like the Oil Palm Mission, leveraging the region's suitability for palm oil cultivation, promise strong income for farmers and reduced import dependency. Additionally, the government is facilitating food processing units through mega food parks, cold storage networks, and testing labs, further enhancing the agro-food processing sector.

Energy and semiconductors are emerging as strategic sectors for the Northeast. Investments in hydropower and solar power, coupled with the region's first semiconductor plant, signal a high-tech future. Modi announced that the first "Made in India" chip from an NER-based facility will soon be introduced, marking a milestone in India's quest for technological self-reliance. These developments, alongside opportunities in solar modules, cells, and storage solutions, position the Northeast as a hub for innovation and manufacturing. The summit's investment proposals, totaling ₹ 4.22 lakh crore, reflect strong confidence in the NER's economic potential. While Indian conglomerates like Reliance and Adani Group have led the charge—Adani alone committed ₹ 50,000 crore for projects in Assam, including aerocities, hotels, cement plants, and the Jogighopa Multimodal Logistics Park—the focus remains on attracting foreign investors. To achieve this, state governments must present a compelling and realistic investment climate, addressing challenges like bureaucratic hurdles and land acquisition complexities. The presence of global investors and foreign missions at the summit underscores the NER's growing appeal, but matching rhetoric with actionable outcomes is critical.

Peace and stability are foundational to the region's development. Modi highlighted the government's zero-tolerance policy against terrorism and insurgency, noting that over 10,000 youth have embraced peace through agreements over the past decade. This shift has unlocked entrepreneurial opportunities, supported by schemes like MUDRA, which has disbursed thousands of crores to NER youth. Education and skill development are also priorities, with ₹21,000 crore invested in the education sector, including new schools, AIIMS, medical colleges, IIITs, and a sports university. The Khelo India program, with eight Centers of Excellence and over 250 Khelo India Centers, is nurturing sports talent, while digital innovation is empowering young entrepreneurs to launch startups.

The Rising North East Investors Summit 2025 is more than an event; it is, as Modi described, "a movement and a call to action." It embodies the Ashtalakshmi vision, symbolizing the Northeast's multifaceted potential to drive India's progress. The region's transformation from a neglected frontier to a land of opportunity hinges on sustained collaboration between the central and state governments, industry leaders, and global investors. By leveraging its diversity, strategic location, and robust infrastructure, the Northeast is poised to become a powerhouse of trade, tourism, and technology. As Modi concluded, the region's progress will propel India to new heights, making the Northeast not just a participant but a leader in the journey toward a Viksit Bharat. Syria's new relationship with USA marks a watershed in West Asia politics

The American President Donald Trump in a significant shift in US foreign policy, recently announced the easing of long-standing sanctions on Syria, marking a pivotal moment for the war-torn nation and the broader Middle. East. This decision came during the President's middle east tour and discussions with Crown Prince Mohammed bin Salman.

The meeting between Syria's interim President Ahmad Al-Sharaa, formerly known as Abu Mohammed Al-Golani and President Rump, apparently at the behest of the Saudi Crown Prince Mohammad bin Salman (MbS), was followed by a sudden announcement of ending economic sanctions against Syria. It reflects a pragmatic approach to fostering stability and economic recovery in the region.

Though unexpected, yet the fact is that these sanctions were imposed by the US itself in 1979, when it designated Syria as a "state sponsor of terrorism", citing its support for groups like Hezbollah and its military presence in Lebanon.

The next round of sanction was imposed in 2004 under the Syria Accountability and Lebanese Sovereignty Restoration Act, targeting Syria's alleged pursuit of weapons of mass destruction and its interference in neighbouring Iraq.

The most stringent measures came in 2011, in response to the Assad regime's brutal crackdown on peaceful protesters, leading to the Caesar Syria Civilian Protection Act of 2019, which aimed to hold the regime accountable for war crimes.

However, the easing of sanctions may offer a way forward to Syria and its new leader to rebuild the country and reintegrate into the international community.

Bashar Al-Assad's regime's collapse in December 2024 ushered in a new era for Syria. While concerns have been expressed about his past affiliations, Al-Sharaa has made concerted efforts to distance himself from his militant past and present himself as a statesman com-

mitted to rebuilding Syria. His first diplomatic outreach was to Saudi Arabia, including a visit to Makkah with his wife. The visit signalled a desire to align Syria with its Arab neighbours - as opposed to Iran and embrace a more moderate form of Islam and governance.

The world's attention on Syria today is because of its strategic location – as it has been for millennia. The emerging political trends in the Levant and the wider Middle East for years to come, will be based on the outcome of the competition to control Syrian governance.

In fact, domestic, regional, and global actors are competing for power and influence in Syria because of the country's

unique position and status. Syria, by heritage is a rather rare complete and consequential Arab country, due to its human and natural resources, strategic geography, and political, cultural, and ethnic ties in the Middle East and the world. Syria today, even in its dilapidated state after half a century of autocratic abuse and 13 years of war, hosts hundreds of diplomats, businesspeople, civic activists, and carpetbaggers. But this is not new.

This has been the Syria's global contribution for the last 5,000 years, ever since Damascus and Aleppo emerged as productive, vibrant, and strategic urban centres in the third millennium BC. Historically, the land and people of Syria have consistently generated knowledge, value systems, food, wealth, culture, technology, and identities that have made their land a strategic and coveted global crossroads.

As Faisal J Abbas opines very aptly in his article in the Arab News, that in fact, the American decision to ease sanctions should not be viewed as an endorsement of past actions but a recognition of the changing dynamics, and a bet on a future that the US, Saudi Arabia, and other middle eastern states can help support in rebuilding their country and as a result extend their sphere of influence. And the main factor behind this benevolence is to keep Syria away from its old allies i.e. Russia and Iran.

The western sanctions were primarily aimed at the Assad regime's oppressive policies and its destabilising role in the region. With the regime's fall, maintaining these sanctions would have only hindered the Syrian people's aspirations for

peace and prosperity. Moreover, Al-Sharaa has shown commitment to forming an inclusive government, respecting minority rights, and focusing on reconstruction efforts aligns with the hope of broader goal of giving a chance to the regional stability.

Syria's economy has been devastated by years of conflict and sanctions, with over 90 percent of the population living in poverty. The lifting of sanctions would open the doors for international investment, aid, and the rebuilding of critical infrastructure.

It also allows Syria to shift from being a hub for illicit activities, such as drug trafficking, to becoming a centre for trade and tourism, reminiscent of its prewar status. For the Syrian people, the lifting of sanctions brings hope for a future free from conflict and economic de-

Faisal further opines that Syria has always been and remains special because it is the most complete Arab country that enjoys all the assets of genuine statehood and nationhood. These include fertile land and water resources; mineral and

agricultural wealth; an industrial base; human wealth in skilled citizens, proficient managers, and entrepreneurial businesspeople; a pluralistic citizenry across vibrant and creative urban centres, alongside deeply anchored villages, and rural settlements; a strong national and cultural identity; and, access by land and sea to the wealth and trade routes of three continents.

It is also a consequential country because of its intrinsic wealth and its strategic geography. Ancient and modern empires - from Greece, Rome, Persia, Byzantium, and India to Britain and France, not to mention Russia and the United States – have fought to control Svria in order to secure access to its resources and important cross-continental routes that traverse it.

More than any other Arab land, including modern Egypt and energy-rich Gulf states, Syria is also consequential because it emits across the region waves of emotion and identity that reflect what ordinary Arabs seek in order to fulfil both their human and civic aspirations. At various moments in the past century, these sentiments emanated from the realms of pluralism, constitutionalism. Islamism, anti-colonialism, and Ara-

Syria is also important for people around the world to grasp because its experience reminds us in a single stroke of the entire modern Arab region's strengths, weaknesses, failures, identi-

ties, and aspirations. Al-Sharaa's overtures to Arab nations and his efforts to distance Syria from former allies like Iran and Russia suggest a potential realignment that could serve US strategic interests.

However, the one definite fact is that the easing of sanctions on Syria represents a pragmatic approach to a complex situation. It acknowledges the transformative changes in Syria's political landscape and offers a pathway for the country to rebuild and reintegrate into the international community.

For the Syrian people, it brings hope for a future free from conflict and economic despair. For the region and the world, it presents an opportunity to foster stability and counteract extremist in-In a way, Syria's struggle for dignified,

stable statehood today is the delayed culmination of the historic but quashed decade of mass Arab uprising for democracy, pluralism, and equal rights for all. As in 1920, Syria today also tests

whether external powers can allow its citizens to define themselves, and set an example for the rest of the region. If there is any Arab citizenry that can achieve this, it is the Syrians, because they have been practicing for this moment for 5,000 years. (IPA Service)

Pakistan's ethnic faultlines and the rise of secessionist sentiments

The Islamic Republic of Pakistan, forged in the crucible of Partition on religious lines in 1947, is now reeling under the weight of internal contradictions that threaten its very unity. Even as it seeks to ignite tensions across the border with India—most recently by sponsoring cross-border terrorism that culminated in the deadly Pahalgam terror attack—it faces a far more dangerous challenge from within: the burgeoning calls for independence emanating from its own disenchanted provinces. The Sindhi, Baloch, Pashtun, and the people of Gilgit-Baltistan are no longer content with the illusion of federal harmony. Instead, they are demanding autonomy, dignity, and, increasingly, secession from what they see as a Punjabi-dominated, militarised

Balochistan: A Legacy of Be-

trayal and Resistance Balochistan, Pakistan's largest yet most neglected province, has long simmered with discontent. Rich in natural resources—gas, coal, and precious minerals—yet povertystricken and underdeveloped, the region remains a stark symbol of Pakistan's extractive federalism. Historically, the princely state of Kalat, which comprised most of modern-day Balochistan, was recognised as independent following a Standstill Agreement with Pakistan in August 1947. However, in 1948, under coercion and against the will of its ruler, the Khan of Kalat, and its people, Balochistan was annexed into Pakistan.

Since then, the province has witnessed five major insurgencies: in 1948, 1958, 1962, 1973–77, and the ongoing rebellion since the early 2000s. These movements have stemmed from grievances over political marginalisation, cultural erasure, and the exploitation of Balochistan's natural wealth without due recompense to its people. The Baloch Liberation Army (BLA), now the torchbearer of the independence movement, recently declared independence and sought recognition of a sovereign "Democratic Republic of Balochistan" from the United Nations. Their struggle, however, is met with brutal repression. Pakistan's infamous "Kill and Dump" policyoperational since 2009—has led to the abduction, torture, and assassination of thousands of Baloch activists.

Sindh: The Forgotten Cradle of Indus Civilisation

Sindh, home to the ancient Indus Valley Civilization, has long resented what it perceives as cultural and political colonisation by Pakistan's cen-

tral regime. The Jeay Sindh Freedom Movement (JSFM) has reinvigorated its long-standing demand for an independent "Sindhu Desh." The grievances are manifold: systematic erasure of Sindhi language and culture, land encroachments by the military, and a state-led campaign to the region are beginning to speak out impose Urdu as a hegemonic national identity. The Sindhi nationalists accuse the Pakistani state of promoting a monocultural Islamic identity at the expense of their syncretic, Sufi-based traditions. Enforced disappearances, illegal detentions, and assassinations of activists have become tragically commonplace. The voice for Sindhi independence is no longer a fringe cry; it echoes in the streets of Karachi, Hvderabad, and interior Sindh—louder and bolder than ever before.

Pashtunistan: A Homeland Denied The Pashtuns, the second-largest ethnic group in Pakistan, have historically straddled the Durand Line, the arbitrary border drawn by the British in 1893 to separate British India from Afghanistan. Neither the Afghan nor the Pakistani Pashtuns have ever recognised the legitimacy of this line. In modern Pakistan, Pashtuns largely inhabit Khyber Pakhtunkhwa and parts of northern Balochistan. Despite their numbers, the community has long suffered marginalisation, especially in the wake of Pakistan's post-9/11 alliance with the West.

The Pashtun Tahafuz Movement (PTM), a civil rights campaign, has emerged as the principal platform for Pashtun grievances. It speaks against enforced disappearances, extrajudicial killings, and the militarisation of civilian spaces in the name of counterterrorism. While PTM originally called for human rights and justice, its discourse is gradually evolving into one of national self-determination. The dream of Pashtunistan, an independent homeland for Pashtuns, is no longer confined to history books; it is alive in the chants of protesters and in the blood of those martyred for daring to dissent.

Gilgit-Baltistan: The Silenced Frontier Nestled amidst the mighty Karakorams and the Himalayas, Gilgit-Baltistan is not only one of the most picturesque regions in South Asia but also one of the most strategically vital. Bordered by Afghanistan's Wakhan Corridor, China's Xinjiang, Indian-administered Ladakh, and Pakistan's own Khyber Pakhtunkhwa, the region is crucial for the China-Pakistan Economic Corridor (CPEC). Yet, its people have remained politically disenfranchised and economically neglected. Locals complain of rampant land grabs by the Pakistani Army and a lack of basic infrastructure, healthcare, and education. With no constitutional status and no representation in Pakistan's Parliament, Gilgit-Baltistan exists in a legal and political limbo. Now, youth movements and civil society voices from more forcefully, demanding autonomy or outright independence from Islamabad's yoke.

The Military State and the Mirage of Unity

Pakistan's central problem lies in its over-reliance on the military as the custodian of its national identity. Since its creation, the country has oscillated between military rule and weak civilian governments, with the military establishment functioning as the de facto ruler. Instead of fostering a pluralistic democracy, successive regimes have pursued the chimera of Islamic unity, often by silencing eth-

nic diversity and dissent. What is more alarming is that the state seems to have learnt nothing from the secession of East Pakistan in 1971, which led to the birth of Bangladesh, That conflict, too, was rooted in the denial of political rights. cultural identity, and economic justice. History, it seems, is poised to repeat itself—this time in the west.

A State on the Brink Today, as the world watches the Islamic Republic of Pakistan escalate hostilities with India in an effort to deflect attention from its internal woes, its house is increasingly engulfed in flames. From the rugged mountains of Balochistan to the deserts of Sindh, from the valleys of Pashtunistan to the icy peaks of Gilgit-Baltistan, voices of rebellion are rising—each one echoing the

same sentiment: freedom. Economic collapse, religious extremism, ethnic marginalisation, and authoritarian governance have pushed the country into a vortex of instability. In attempting to homogenise its population under the banner of Islam and military discipline, Pakistan has alienated its own citizens. The writing on the wall is clear: unless Pakistan moves swiftly towards a more inclusive, federal, and democratic model, it risks fracturing under the very weight of its suppressed diversities. A new chapter in South Asian geopolitics is being written—not by cartographers, but by the oppressed who have dared to rise. As Pakistan clings to its imperial delusions, its ethnic peripheries may well become the epicentres of new nations. The question now is not if the federation will fracture, but when. How many eggs does a woman have?

female's egg quality and quantity determine their likelihood of conceiving. Unlike other cells in the body, egg cells cannot regenerate.

A person's life stage and the presence of various health conditions also affect the number and quality of their eggs.

This article explores how many eggs a female has and their role at different stages of their life. We also discuss tests to measure egg count, fertility options, conditions that may impact eggs, and more.

How many eggs are females born with? According to the American College of Obstetricians and Gynaecologists (ACOG), a female fetus typically has around 6–7 million eggs at 20 weeks of gestation, dropping to 1– 2 million at birth. The number of immature egg cells — oocytes — decreases by around 11,000 each month before puberty.

Why does menstruation not start at

While females have millions of eggs in their ovaries, they do not mature until puberty. Puberty begins when the hypothalamus, an area of the brain that plays a role in hormone production, produces the gonadotropin-releasing hormone (GnRH).

Menstruation typically begins when a female is 12–13 years old. However, some may start as early as 8 years old.

A female typically has around 300,000-500,000 eggs when puberty begins and rapidly loses more eggs each month. Aside from their monthly cycles, many factors affect how many eggs a person loses every cycle.

How are eggs released?

The GnRH regulates the onset of puberty, sexual development, egg development, and ovulation by signaling the release of folliclestimulating hormone (FSH) and luteinizing hormone (LH).

The FSH activates several immature eggs in fluid-filled sacs called follicles to mature during each menstrual cycle. Known as the follicular phase, this process begins on the first day of a person's period.

The ovulation phase begins when the LH stimulates the ovaries to release an egg. However, the ovaries are programmed to allow only one egg to fully mature and be released each cycle. The body reabsorbs the rest.

The chance of fertilization is dependent on the release of a mature egg from the ovary in a particular menstrual cycle.

How many eggs does a female have in

A female is most fertile in their mid-20s, with a 25-30% chance of becoming pregnant each month.

ACOG states that a female's fertility gradually and significantly drops around age 32. They will have around 120,000 eggs, with a 20% chance of conceiving per cycle.

ACOG further states that a female will experience a rapid decline by age 37, when egg count drops to around 25,000.

According to the Centers for Disease Control and Prevention (CDC), around 1 in 5 couples where the female partner is 30–39 years old experience problems conceiving their first child. However, both males and females may experience infertility

How fertile is a female at 40?

By 40, a female's chance of conceiving drops to 5%. Older females generally have a lower success rate with fertility treatments such as in-vitro fertilization (IVF).

However, more people are successfully conceiving in their 40s. The number of births in women between 40-44 years old rose almost continuously from 1985 to 2019. There was a slight decline in birth rates in 2020 across all

Using eggs donated by younger females increases the chance of success with IVF for

Menopause By the time a female reaches menopause, they may have fewer than 1,000 eggs. As a person ages, immature eggs become increasingly resistant to the FSH. As the number of viable eggs decreases, the ovaries also begin to produce significantly less estrogen and progesterone. This leads to menopause, when a person's menstrual cycle ends and they no

The average age a person reaches menopause in the United States is 52 years. This varies depending on how many eggs a person has at birth and other factors, such as medical conditions and treatment.

Egg quality Aside from decreasing in number, eggs also drop in quality as a person ages. A few hours before ovulation, the oocyte divides, resulting in an egg that contains 23 chromosomes. Older age is highly associated with oocyte abnormal-

These older eggs are more likely to contain abnormal chromosomes. This is why the risk of having a child with Down Syndrome and other abnormalities is higher as a person ages.

This tendency to have extra or missing chromosomes is also responsible for the increased miscarriage and low birth rates among older adult females.

Tests to measure egg count There are tests that a person can take to estimate their egg count.

Antral follicle count The antral follicle test involves a medical practitioner using ultrasound to count visible follicles. This gives them an idea of a person's total egg count and how many eggs a person can potentially freeze during one cycle.

Anti-Mullerian hormone (AMH) test The anti-Mullerian hormone (AMH) is a protein hormone produced by special follicular cells. The AMH level in the blood can help healthcare professionals estimate the number of follicles in a person's ovaries, which gives

them an idea of their total egg count. Since AMH levels are stable throughout the menstrual cycle, a doctor can perform this test at any time.

Fertility options There are several options a person may con-

sider to improve their chances of pregnancy. Egg donation Older people or those who have premature ovarian failure (POF) that causes early

menopause may consider egg donation. This involves using eggs donated by another female, typically someone in their 20s or early

In an egg donation cycle, a donor takes medications to stimulate the production of multiple eggs. At the same time, the recipient undergoes hormone therapy to prepare the uterus for

After the donor's eggs are fertilized in a laboratory, a doctor places one or more embryos into the recipient's uterus

Egg freezing or fertility preservation

Individuals who want to delay childbearing may consider preserving their healthy eggs in a process known as egg freezing. A doctor can extract the eggs while the person is younger and use when they want to become pregnant.

The process involves taking medications to stimulate the ovaries to produce multiple eggs. These eggs are retrieved and kept in a laboratory at sub-zero temperatures.

When a person is ready to conceive, a doctor thaws the eggs and injects surviving eggs with a partner or a donor's sperm for fertilization. Assisted reproductive technologies

People with unexplained infertility, or when traditional options have failed, may try more advanced therapies. These can include IVF and superovulation with timed intrauterine insem-

In superovulation and IUI, a female takes

medications to stimulate the growth of multiple eggs in the ovaries. When the eggs are ready to ovulate, a donor or partner's washed sperm is injected directly into the uterus. Sometimes an additional medication is given to stimulate ovulation so that timing is more

In contrast, IVF involves removing a person's egg that a doctor fertilizes with a donor or partner's sperm in a laboratory. Once successful in fertilization, the doctor transfers the embryo to the uterus.

LBGTQI+ and egg supply

Most information about egg supply and fertility options is for cisgender and heterosexual females. However, fertility issues can affect anyone born with ovaries.

A person transitioning to male can freeze their eggs, embryos, or ovarian tissue before hormone therapy or gender-affirmation surgery. People assigned female at birth (AFAB) and taking the male hormone testosterone may experience amenorrhea, the absence of menstruation due to the hormone suppressing ovu-

The effect of taking testosterone on egg supply is unclear. But a recent small study found that functional ovarian reserve was preserved in transgender men receiving testosterone therapy over a prolonged period.

A case study from 2020 documented a person taking testosterone who was able to retrieve eggs for freezing. They stopped testosterone treatment for only 24 days around the time of egg stimulation. This compares to cases where hormone treatment ceased for up to 6 months before egg retrieval.

Another case study from 2019 reported a 20year-old transgender male becoming pregnant 2 months after stopping testosterone therapy. More research is needed to offer accurate fertility guidance to trans people.

A person wishing to discuss their fertility options before or after transitioning should speak with a medical professional.

Conditions that may impact eggs Age is the major factor that affects a female's egg quality. However, some conditions may also contribute, including:

 endometriosis • ovulation disorders, such as polycystic ovary syndrome (PCOS) and POF

obesity • immune disorders

cancer treatments

inadequate nutrition

A 2017 study found that oxidative stress damages oocytes and impairs their fertilization capacity. Smoking, drinking, drug use, and inadequate diet can increase free radicals in the body, damaging the egg. When to contact a doctor

According to the CDC, medical professionals recommend that females younger than 35 vears with no health or fertility issues and regular periods try to conceive for at least 1 year before consulting a doctor. However, females 35 years or older should contact a doctor after 6 months and even sooner for those over 40

People who have other health issues or circumstances such as irregular periods or have received chemotherapy should also consider discussing their fertility options sooner.

A person's biological clock affects their fertility. Age not only decreases egg quantity but can also affect their quality.

People concerned about their egg supply due to factors such as aging, different priorities, gender-affirming surgery or hormone therapy, or preparation for cancer treatment have several fertility options to consider.

A person should discuss these options with a healthcare professional to determine which options are most suitable. (Courtesy: Medical

Biodiversity funds not reaching indigenous people, women who protect nature: Report

oney meant to protect forests, oceans and wildlife is not reaching the people who live closest to nature, a new study has found.

The International Institute for Environment and Development (IIED), a United Kingdom-based policy research organisation, along with partners in five countries, conducted a detailed analysis of biodiversity funding from the Global Environment Facility

GEF is one of the largest international funds for nature and climate action. It is playing a key role in delivering on the \$200 billion annual biodiversity finance goal under Target 19 of Kunming-Montreal Global Biodiver-

sity Framework (KMGBF). Their study analysed data from GEF-funded projects and interviews from community groups in Kenya, the Philippines, Malawi, Vanuatu and Antigua. The findings showed that most indigenous people and local communities (IPLC) received little to no direct support from these funds, despite being the primary custodians of biodiversity.

Local voices left out

Although 24 per cent of GEF-6 funding and 30 per cent of GEF-7 funding was targeted at local actors, in most cases, these groups were listed as indirect beneficiaries and not direct recipients of funding, according to the

In Malawi, only one local organisation received direct funding and that too just 0.3 per cent of the project's total budget.

"Our research shows not enough money is getting to those who are best placed to protect nature," said Nicola Sorsby, researcher at IIED.

Most of the earth's biodiversity is managed by Indigenous Peoples and local communities. which is why it's critically important to ensure they get the support they need to protect and restore nature. - Nicola Sorsby, researcher, IIED

In Bangladesh, researchers could not find local recipients because the projects hadn't started. No IPLC women's organisations were found to be receiving direct support in any of the five countries studied. One indigenous group in the Philippines said: "We have tried to get funding from GEF since 2009, but we got no clear information on how to apply or take part." Meanwhile, other groups in the country were selected by intermediaries.

The findings echo concerns raised at COP16 in Colombia, where governments failed to agree on clear strategies for mobilising funds to meet the KMGBF Target 19, which aims to raise \$200 billion per year by 2030 from all sources.

A factsheet by Delhi-based think tank Centre for Science and Environment (CSE) on the money trail for biodiversity pointed out that funding flows remained unclear and hard to track. with gaps between pledges and actual delivery from developed countries

Too many middlemen

The research shows that a major reason for the funding gap is GEF's reliance on large international agencies, development banks, and national government offices to distribute the money.

The intermediaries known as 'implementing agencies' and 'operational focal points' often make decisions without involving the communities the funds are meant to support.

In Antigua, one community used SGP grant to restore a village reservoir and develop a tourism park. In Vanuatu, several communities praised the simpler process and more direct support.

However, the study also found that the small funding amount and delays in approval still posed problems, especially for groups in remote areas.

Women missing from the pic-

IIED's research also found that gender equality is largely missing from GEF's main funding streams. While there are gender indicators in project documents, they are rarely used properly and there's no requirement to track how much money reaches women's organisations directly.

As a result, indigenous and



This system creates confusion. delays and often locks out small communities groups. IIED's interviews found that many indigenous organisations did not even understand how to access GEF funding or were told no projects were available even when the groups were actively receiving

The findings also highlighted that communities were often brought into projects after they had been designed and approved. giving them no real say in what is done or how funds are used. In Malawi, one group was asked to join a project only after another partner had dropped out.

Small Grants Programme shows what works

The study pointed to one big without relying on intermedispot — the GEF Small Grants Program (SGP). This programme provides a small amount of money, usually upto \$50,000, directly to local groups.

The analysis showed that SGP has been more successful in reaching indigenous and local actors, offering them more flexibility and ownership of their local women who play a crucial role in managing natural resources are left out of decision making and funding.

With the next round of GEF funding talks (GEF-9) scheduled for later this year, and Target 19 progress is under close global scrutiny, researchers say its time for real change. The CSE factsheet also emphasised that financial solutions currently on the table remain small-scale and fragmented.

IIED recommended expanding the successful SGP approach across all GEF funding; publishing clear data on who is receiving funds and how much; and simplifying the funding process so that local groups can apply directly aries.

They also advocated for longterm, flexible funding to help local organisations build capacity and lead projects. Committing to principles for local-led, genderresponsive biodiversity action is the need of the hour, the experts highlighted. (Courtesy: Down to

Distinction between state of Pak & terrorism has withered away: Ravi Shankar Prasad

and terrorism has now withered away, BJP MP Ravi Shankar Prasad said on Tuesday, underlining that terrorism as an instrument of state policy is a part of the military state in the neighbouring country. Prasad, who is leading an all-party parliamentary delegation to France, conveyed India's zero-tolerance stance against terrorism emanating from Pakistan in a briefing with local French media.

During a press conference hosted at the Indian Ambassador to France's residence, the team presented photographic evidence of Pakistani military officials attending the funerals of terrorists and flagged how 52 UN-designated terrorist organisations found a safe harbour by Pakistan

"The distinction between the state of Pakistan and terrorism has now withered away," Prasad told reporters.

"Terrorism as an instrument of state policy is a part of the military state of Pakistan. There is no democracy there and the most hilarious aspect was that the general whose forces were defeated at the hands of India, decisively, got promoted to Field Marshal. This is their state of denial, always," he said.

The performance of military gear in the conflict was also raised by the local media in Paris, to which the delegation pointed to the multiple briefings by the Ministry of Defence



'Not even a single aircraft from India crossed into Pakistani territory," he said. "On operational details, Pakistan keeps on lying but today our military establishment has explained everything, with digital proof," the BJP leader said.

On India-France bilateral ties, he added: "We have a strategic partnership dating back to 1998. Prime Minister (Narendra) Modi also has a personal friendship equation for the French President (Macron)... There is a whole big horizon as to how these two nations undertake their partnership, including for deago India became the fourth biggest economy in the world. That is what India's economic might is.'

Fellow MP Daggubati Purandeswari highlighted the resounding success of Operation Sindoor in the wake of the Pahalgam terrorist attack last month.

"Ultimately it is the goal that matters. Our focus was completely on how do we neutralise the terrorist camps, which our soldiers and our weapons have actually done their job. And, we have not lost even one soldier. All of them are back home

Former Union minister M J Akbar asserted India's clear and thought-through "no first use" doctrine on nuclear weapons.

"Pakistan is a military state, it is no longer a civilian state. Singapore minister says city-state stands with India against terrorism

SINGAPORE, May 27: Singapore strongly condemns all acts of terrorism and stands with India against the menace, a senior minister of the city-state told an all-party Indian parliamentary

delegation on Tuesday. The all-party delegation conveyed that if there is a terrorist attack on India, New Delhi will give a fitting reply. "India will not tolerate any nuclear

blackmail. India will strike precisely and decisively at the terrorist hideouts developing under the cover of nuclear blackmail. India will not differentiate between the government sponsoring terrorism and the masterminds of terrorism," it said.

The delegation members requested Singapore's support in the fight against terrorism, particularly at multilateral fora like the UN and the Financial Action Task Force (FATF), the global money

laundering and terrorist financing watchdog, the Indian mission said in the statement.

As close friends and partners, India and Singapore will continue to work closely on regional and global issues, including terrorism, it said

Jha highlighted that the delegation brings representatives of different political parties together to convey India's united resolve against terrorism.

The delegation members conveyed that the terrorist attack in Pahalgam was an attempt to disturb the trajectory of peace, development, and normalcy in the Union Territory of Jammu

and Kashmir, the statement said

The Government of India deemed it essential that the perpetrators and planners of the April 22 terror attack be brought to justice. In response to this heinous act of terror, India launched Operation Sindoor, targeting the terrorist infrastructure. India's response was measured, non-escalatory, proportionate, and responsible, it said. (PTI)

ANYA demands more digital exam centres for CUET aspirants in Arunachal



NAMSAI, May 27: The All Nyishi Youth Association (ANYA) has once again strongly reiterated its demand for the establishment of four additional digital examination centres for CUET aspirants in Arunachal Pradesh. The state currently has only four centres, and the organization has urged the Arunachal Pradesh government to take proactive steps in preparing necessary infrastructure well in advance to facilitate the process.

Addressing the media, ANYA President Jamru Ruja said that the association has already met the state's Education Minister, P.D. Sona, and submitted a detailed memorandum regarding the matter. Ruja stressed that while the issue is serious, it is indeed feasible, provided the central government takes into account the unique geographical challenges of Arunachal Pradesh and the fact that the state shares international borders with

three countries. Highlighting the hardships faced by students, Ruja said that hundreds of students from remote and far-flung districts of Arunachal are forced to travel to the state capital Itanagar, and due to the shortage of examination centres, many are assigned centres located in various parts of

Assam. As a result, students appearing for the CUET (Common University Entrance Test) 2025 are facing several logistical and financial challenges.

According to Ruja, the lack of sufficient computer-based exam centres in Arunachal Pradesh has become a pressing concern. This inadequacy has compelled candidates to journey to distant exam locations outside the state, especially in Assam, leading to significant hardship not just for the students, but for their families as well. He cited recent incidents where students faced problems at centres in Dibrugarh and even in Guwahati, reflecting the ongoing difficulties in managing the examination logistics.

Ruja further added that numerous students have reportedly missed their exams due to issues such as poor transportation, financial constraints, insufficient information, and the inaccessibility of exam centres. He expressed concern over the evident digital infrastructure gap in the state, questioning how such basic facilities remain inadequate even in the year 2025.

He emphasized the importance of the state government being prepared. "We are hopeful that the Union Government may approve or recommend approval for new digital centres. But for that to happen, the

State Government must be ready with identified locations and infrastructure details, so that when a query arises from the Centre, they can respond promptly." Ruja stated. ANYA concluded its statement with a firm demand for budget allocation in the upcoming Budget Estimate or Revised Estimate for the financial year 2025-26 to set up government-run digital/computer examination centres in each district of Arunachal Pradesh. The organization believes that such a move would not only address the current concerns of the students but also promote the longterm development of digital education infrastructure across the state. Meanwhile, reacting to the demand.

Education and RWD Minister P.D. Sona acknowledged that the representatives of ANYA had approached him recently. He confirmed that a meeting was held to discuss the matter. "At present, there are four digital centres in the state, namely at NIT, NERIST, RGU, and Model Village iON Digital Zone, all of which are situated near the state capital. These are clearly not sufficient to meet the needs of students from remote districts," the Minister said.

He further informed that the demand for four additional centres in other parts of the state has been officially received and taken seriously. "Since the authority to approve such centres lies with the Central Government, I have already written a letter to the Union Education Minister drawing attention to the matter," said Sona.

The Minister expressed optimism that the central government would consider the proposal favorably, keeping in mind the importance of educational equity and accessibility for all students across Arunachal Pradesh. He added that the state government is ready to respond promptly once a query or follow-up is received from the central authorities.

GANDHINAGAR, May 27: Prime Minister Narendra Modi on Tuesday said terrorism was not a proxy war but a deliberate war strategy adopted by Pakistan, and India will respond to it accordingly.

Refusing to make any distinction between non-state and state actors in Pakistan, Modi said the neighbouring country is engaging in war by continuing to support terrorism. "Vasudhaiva Kutumbakam' (the world is one family) is our 'sanskar' (value imbibed through tradition), we want happiness for our neighbours too, but if you challenge our strength, then India is also a land of heroes," Modi said, speaking at an urban development programme of the Gujarat government here.

"We can not call this a proxy war, as those who were killed after May 6 (during Operation Sindoor) were given state honors in Pakistan. Pakistani flags were draped over their coffins, and their military saluted them. This proves that these terrorist activities are not just a proxy war, this is a deliberate war strategy on their part," the prime minister said.

"If they are engaging in war, then the response will be accordingly," he said.

response will be accordingly," he said.

Modi was on his first visit to Gujarat after Operation Sindoor undertaken by the Indian armed forces to strike terrorism bases in Pakistan in response to the terrorist attack in Pahalgam. During his visit to Vadodara, Dahod, Bhuj, Ahmedabad and Gandhinagar, he experienced "fervour of patriotism with the roar of success of Operation Sindoor", he said, adding that this feeling could be seen across the country.

A single thorn can cause constant pain

even if a body is strong otherwise, the prime minister said, adding India made up its mind to "remove the thorn of terrorism", and did it with utmost conviction.

"We should have killed the Mujahideens who entered Kashmir in 1947" and then the present situation would not have arisen, he said, referring to the incursions in Kashmir immediately after Independence. "During Partition, Maa Bharati (Mother India) was divided into two, and that very night, the first terror attack on Kashmir was launched by Mujahideens," Modi said, adding that with the help of these terrorists Pakistan captured a "part of Mother India".

"Sardar Patel was of opinion then that the Indian army should not have stopped until Pakistan-Occupied Kashmir (PoK) was reclaimed." (PTI)

KOHIMA, May 27: Nagaland has sought enhanced legal infrastructure support from the Centre. In this regard, Principal Secretary for Law & Justice, Government of Nagaland, Y Kikheto Sema met with Union Minister for Law & Justice, Arjun Ram Meghwal, at his office in Shastri Bhavan, New Delhi recently. The meeting was held in continuation of the commitments made by the Union Minister during his visits to Nagaland on October 22, 2024, and April 12, 2025, an official statement said today.

During the discussion, Kikheto Sema urged the Union Minister to enhance the quota of Notary Publics in the state from the existing 200 to 400 under Rule 8(4A) of the Notaries Rules, 1956, the statement also said. He highlighted that while the original quota of 200 was allotted during statehood in 1963, when Nagaland had just 3 districts and a population of 3.7 lakhs, the state now comprises of 20 districts with an estimated population of 22.58 lakhs, creating a sub-

stantial demand for notarial services. In response, Union Minister Meghwal, along with Additional Secretary (Legal Affairs), Ashutosh Mishra, assured that the proposal would be duly considered and the necessary amendment to the Rules could be expected within two months, the statement added.

Sema also drew attention to the long-pending High Court building project in Nagaland, noting that the state may be the only one yet to receive central funding for such a project. Despite financial constraints, the state government has already invested ₹ 242 crore, but an additional ₹ 299 crore is needed to complete the construction, the statement also said. The Union Minister informed that the matter has been taken up with the Ministry of Finance and expressed hope for its consideration in the current financial year.

Furthermore, Sema requested central funding support for the construction of new district courts at Niuland, Tseminyu, and Shamator, where land acquisition has recently been approved by the State Government. He also sought early release of funds for the ongoing construction of district courts at Mon and Noklak, and for various other district-level projects.

IT'S A SERIOUS MATTER, TO BE HANDLED BY **COURT: AKSHAY KUMAR** ON PARESH RAWAL'S 'HERA PHERI 3' EXIT



MUMBAI, May 27: Bollywood star Akshay Kumar on Tuesday (May 27, 2025) said that the on-going controversy over the exit of his costar Paresh Rawal from "Hera Pheri 3" is a "serious matter", which is being "handled by the court".

About two weeks ago, Rawal's sudden departure from the project sent shockwaves in the film industry and among the fans of the franchise who have been waiting for the third part for close to 20 years.

Kumar, who also serves as a producer on "Hera Pheri 3", has sued Rawal, for ₹25 crore in damages.

At the trailer launch of the superstar's upcoming film, "Housefull 5", he was asked how fans are disappointed with the exit of Rawal from "Hera Pheri 3", and have called the acclaimed actor, "foolish", to which Kumar said it is "not right" to address his "good friend" Rawal as "foolish"

"Using this kind of word for one of my costar like a foolish word or something. I would not appreciate it, and that's not right. I worked with him since the last 30-35 years, we are very good friends. He's a great actor and I really admire him. Whatever it is (referring to controversy), I don't think this

going to talk about it because whatever has to happen, it's a very serious matter. It is a matter which is going to be handled by the court and things like that. So, I don't think I'm going to speak about it here," he told reporters.

Last week, Rawal broke his silence over the controversy and said his lawyer has responded to the legal suit.

Boney Kapoor's firm submits layout of International Film City project to YEIDA

wood film producer Boney Kapoor's company Bayview Projects LLP on Tuesday submitted the layout of the International Film City to the Yamuna Expressway Industrial Development Authority (YEIDA), an official statement issued here said.

YEIDA will now review the plan, and after necessary approvals, formal construction work will begin. The International Film City is planned to be developed over 1,000 acres along the Yamuna Expressway at Sector-21 in Greater Noida.

The first phase will kick off on 230 acres of land with an estimated investment of Rs 1,510 crore, the statement said. OSD (Officer on special duty) to Yamuna Authority (YEIDA) Shailendra Bhatia said Kapoor, who has taken the responsibility of building the film city, submitted the complete layout of

the project on behalf of his company. Now, the authority will review and examine the entire layout, after which they will give the necessary approval to start work, he said.

CEO, YEIDA, Arun Veer Singh made it clear that the construction will fully follow the agreement, and no changes will be accepted without approval.

Separate NOCs (no-objection certificates) will be required for approvals like parking, landscaping, and gardening.

He said that Bayview Projects LLP, selected as the highest bidder by offering 18 per cent of gross revenue share, was issued the Letter of Award last year.

On June 27, 2024, YEIDA and the concessionaire representative Kapoor signed the concession agreement. The site's right of way was transferred to the concessionaire on February 27, 2025.


The master plan of the film city was approved on January 30, 2025. The project will be completed in

three phases over the next eight years. In the first phase, construction will take place on 230 acres, and in future, expansion will happen on the remaining 770 acres in phases 2 and 3, the statement said.

In the first 155 acres, main structures like film studios, sound stages, post-production units, and a film institute will be built. Besides, on 75 acres, a commercial centre with retail, offices, and entertainment complexes will be developed, but this will start only after the film-related buildings are completed, it said.

GM of Bayview Projects LLP Rajiv Arora, according to the statement, said the construction will begin immediately after all approvals. "We will build a film city that will fulfil Chief Minister Yogi Adityanath's dreams," Arora said.

will be laid by the chief minister. According to the statement, the proposed international film city is a historic step to make Uttar Pradesh a national and international film production hub. This project will create about 500,000 direct and indirect jobs and will take Uttar Pradesh's economy to new heights. The upcoming film city will also include a grand convention centre with 10,000 seats, where big film ceremonies and events will take place, a museum based on Indian cinema, a special film festival area, which will have a guest house, and an auditorium and separate accommodation facilities for artists. It will also have small studio units with different Indian architectural styles, which could be rented for shooting or staying, apart from having large sound stages and an underwater shooting studio. Plenty of sports, from soccer and baseball to the NFL, are replacing, or at least helping, officials with some form of high-tech replays or other technology. Tennis, too, is following that trend, except at

Roland-Garros, where competition continues through June 8.

Even the longest-running and most tradition-bound of the majors, Wimbledon, is — gasp! abandoning line judges and moving to an automatic system this year. The WTA and ATP added machine-generated rulings this season for tour events on red clay, the surface at the French Open. But Grand Slam hosts can do what they want, and the French tennis federation is keeping the human ele-

Djokovic, the 24-time major

At the end of the opening day, India stood at second place with one gold and one bronze, behind China (5 gold, 2 silver) and above Japan (3 silver, 2 bronze).

Gulveer was elated to pocket gold at the continental championships, though the warm weather at the time of his 25-lap race denied him a better timing.

"Irrespective of the time, the main goal was to finish first. I am happy to have successfully implemented my race strategy," Gulveer said here.

"The gold medal will certainly enhance my world ranking and brighten chances to win a ticket to Tokyo World Athletics Champi-



onships in September.'

Alcaraz beat Sinner in the final there. Monday's result gave Alcaraz 28 wins in his past 30 matches on red clay, including going 7 for 7 a year ago at Roland-Garros. One of the losses came against Novak Djokovic in the gold-medal match at last year's Paris Olympics, held at the same site as the French Open.

Swiatek has slipped to No. 5 in the rankings, her first time out of the top two spots in about three years. She hasn't reached a final at any tournament since collecting her third consecutive championship — and fourth in five years — in Paris in 2024.

champion Gukesh's challenge in thriller

STAVANGER (NORWAY), said Carlsen. The Norwegian tried May 27: World No.1 Magnus Carlsen inflicted a huge blow to reigning World Champion D Gukesh's chances in the opening round of Norway Chess here, showing his endgame expertise to log three full points. In what had been touted as the match of the tournament with the five-time world champion playing against an opponent half his age, Gukesh kept the Norwegian defending champion under pressure for most part of the over four-hour-long game of classical chess before the Indian made a losing mistake and lost in 55 moves.

Following the win, Carlsen earned three points and is in joint lead with American Grandmaster and world No.2 Hikaru Nakamura, who beat American GM Fabiano Caruana. The second Indian in the fray, Arjun Erigaisi defeated China's No.1 Wei Yi in an exciting Armageddon game after the classical game had ended in a draw.

Erigaisi earned 1.5 points from the win, while Wei secured one. The tournament's scoring system gives three points to the winner in the Classical format.

If the Classical game is drawn, the players gain one point each and then play for another half-point in Armageddon. Two-time World Rapid champion Koneru Humpy score a decisive win against R.

Vaishali in an all-Indian match-up. Playing with characteristic calm and precision, Humpy capitalised on her opponent's mistake in the endgame. The Carlsen-Gukesh match went down to the wire, with the Norwegian, playing with the white pieces, pressuring his opponent to make a mistake in the endgame to accurately finished the game in his favour. Carlsen, who hasn't played an individual Classical event in the whole year since winning the Norway Chess 2024 title, was off to a less-promising start, with the Norwegian admitting his decision to play the Jobava London did not work out as planned. "I just realised I don't know anything,"

to unnerve Gukesh with the rarelyapplied opening but realised after only a few moves that he was not going anywhere.

In fact, Gukesh, playing with black pieces, had neutralised his opponent's white advantage by the 11th move, when he had the Norwegian thinking for more than 15 minutes. But Carlsen, the five-time world champion who has since moved to shorter formats, such as Rapid and Blitz and, more recently, Freestyle chess, showed he has not lost his touch with the Classical format, winning the contest after 55 engrossing moves.

"I tried to surprise him (with the opening). I responded the way you often do, especially in the first round, in the absolute wussiest way possible," said the 34-year-old Carlsen. Gukesh later offered a pawn sacrifice, while Carlsen instead steered toward the kind of endgame on which he's built his dominance in the chess world.

"It's still fairly equal, but there's this small imbalance as his pawn structure is a little bit ruined," said Carlsen after the match.

He felt that Gukesh "did really, really well for a long time (in the game)," and then, when a pawn race developed, the price of a move had suddenly grown exponentially. Asked if it meant a lot for him to beat the reigning world champion, Carlsen downplayed the moment, saying, "Not necessarily, but every win in this tournament is hard to come by, so I'm happy with that." Earlier, Erigaisi impressed in the first round beating his Chinese opponent Wei Yi in Armageddon after the two had agreed to a draw.

Even as the spotlight was firmly on the match between India's teenage world champion D Gukesh and world No.1 Magnus Carlsen, Erigaisi, ranked No.4 in the world, was the first to take the opening points by beating China's No.1 player Wei in Armageddon after the two had agreed to a draw after 54 moves. New Brazil coach Ancelotti turns down Neymar and predicts a 'better' Vinicius Júnior

RIO DE JANEIRO, May 27: Carlo Ancelotti's first day as Brazil coach included saying "No" to Neymar and a promise to find more improvement from his former Real Madrid striker Vinícius Júnior.

Ancelotti was introduced on Monday at a packed press conference in a Rio de Janeiro hotel, and just to ensure he was under no illusions as to his primary task, he was welcomed by Brazil's last two World Cup-winning coaches, 1994's Carlos Alberto Parreira and 2002's Luiz Felipe Scolari.

Scolari gave Ancelotti a national team jacket and told the first foreigner in a century to coach Brazil full-time, "Just be you, the person you always were, and you will win with Brazil. We all wish you well with Brazil, we will always support you."

The Italian, contracted to the end of the 2026 World Cup in the United States, Canada and Mex-



ico, announced his first squad for World Cup qualifiers next week against Ecuador and Paraguay.



"I watched that century and I just couldn't believe how well he struck the ball and how easy he was hitting the sixes and how relaxed he was," Waugh said in a media interaction alongside Anil Kumble, Matthew Hayden and Robin Uthappa on 'Australian Summer of Cricket 2025-26' organised by JioStar, Cricket Australia and the Australian

"As a 14-year-old, he had no concept of pressure...just play with complete freedom. so that was great to watch. I guess for him the challenge will be to keep it under control," he added.

Waugh believes that Suryavanshi, who already has an IPL contract worth over Rs one crore, will be a multi-millionaire "before he is 16 years of age" and would be faced with



the pressures and expectations.

"Can he play the same way with the same enthusiasm, the same freedom as he has done this year? That'll be his challenge," he

"He's got a lot of skill, he's mentally tough and he's got a great backstory, so you want to see someone like that be successful. It's a great story for cricket and for me watching from a long way away," Waugh

said referring to the well-documented accounts of his parents' sacrifices to ensure his

Every teenaged batting sensation invariably draws comparison with the iconic Sachin Tendulkar, who padded up for a Test as a 16-year-old. Waugh said neither Suryavanshi nor anyone else merits that comparison because a talent like Tendulkar does not come along frequently.

92 as an 18-year-old still inspires awe Down

"I don't think you can compare anyone to Sachin Tendulkar. I mean, a 16-year-old (18year-old) coming out to Australia and scoring a century in Perth on the hardest, (the) most unique pitch in world cricket where most players really struggle to play on a pitch," he said.

"...for him to score a century as a teenager in Perth was a freakish performance. It's very rare you get a Sachin Tendulkar come along. But I would never have expected a 14-year-old to score a 100 in the IPL, that was unthinkable.

"Even right now it's unthinkable. I look back to myself as a 14-year-old and I couldn't contemplate being in that situation and being successful," Waugh added.

One of the most successful Test captains ever, Waugh said Indian teams aren't as "intimidated" while touring Australia now and

also enjoy massive support from fans. "I don't think teams are intimidated like they used to be from away tours. They're so well-travelled and well-experienced and have played a lot of conditions, a lot of experience.

"I don't think playing away from home is the same intimidation factor as it used to be 10 (or) 20 years ago and the fact that India have won two Test series recently in Australia, and also they have probably more crowd support in Australia than Australia has got," he added. (PTI)
