

India overtakes Japan as 4th largest economy Scores of 'doubtful citizens'

We are now a USD 4 trillion economy, says NITI Aayog CEO

NEW DELHI, May 25: India has become the fourth largest economy in the world, overtaking Japan, NITI Aayog CEO BVR Subrahmanyam has said.

Subrahmanyam said the overall geopolitical and economic environment is favourable to India. "We are the fourth largest economy as I speak. We are a USD 4 trillion economy as I speak," he said.

Citing IMF data, Subrahmanyam said India today is larger than Japan. Till 2024, India was the fifth-largest economy in the world. "It is only the US, China and

Germany which are larger than India, and if we stick to what is being planned and what is being thought through, in 2.5-3 years, we will be the third largest economy," Subrahmanyam said.

The International Monetary Fund (IMF), in its World Economic Outlook (WEO) report released in April had said that India is expected to be the fourth largest economy in the world with a GDP of USD 4.19 trillion in 2025, ahead

of Japan. India's nominal GDP for

2025 (FY26) is expected to be

USD 4.187 billion marginally

more than the likely GDP of Japan which is estimated at USD 4.187 billion, the IMF had said. According to IMF data, India's

per capita income has doubled

from USD 1,438 in 2013-14 to USD 2,880 in 2025.

The IMF in its WEO report also said the Indian economy is projected to grow at 6.2 per cent in 2025-26, slower than earlier estimated rate of 6.5 per cent, due to escalated trade tensions and global

PM asks NDA govts in states to adopt best governance practices for 'Viksit Bharat'



NEW DELHI, May 25: Prime Minister Narendra Modi asserted on Sunday that caste enumeration is a step towards bringing into the mainstream of development those left behind, as he emphasised that his government does not believe in resolutions -- one hailing the valour caste politics but in the empowerment of the marginalised.

Addressing a conclave of NDA chief ministers and deputy chief ministers, Modi said the success of Operation Sindoor was an endorsement of the country's push towards self-reliance in the defence sector, an apparent reference to the important role played by indigenous defence technology in the recent India-Pakistan conflict, sources

Presentations on seven best governance practices, including the Uniform Civil Code in Uttarakhand, in as many states were made by different CMs and deputy CMs. Modi suggested forming a committee to study them and how they can be integrated elsewhere.

A synergised effort from the NDA-ruled states can speed up the realisation of 'Viksit Bharat', he added.

Sources said the prime minister also asked leaders to avoid the tendency to speak out of turn, seen as an expression of disapproval in the backdrop of political rows triggered by insensitive and contentious remarks made by the members of the ruling alliance at several places fol-

lowing Operation Sindoor. Briefing reporters, BJP president J P Nadda said 20 chief ministers and 18 deputy chief ministers attended the conclave in which two of armed forces and Modi's brave leadership in the context of the recent military action and another praising the decision of caste enumeration in the next census- were

Nadda said the prime minister in his remarks praised the bravery of the armed forces. Modi also emphasised the goal to turn India into a developed country at a fast pace and to make it "powerful, capable and self-reliant", the BJP president noted. A census of castes, Nadda said, was always part of the ruling alliance's imagination, noting that the Bihar government headed by JD(U) leader and chief minister Ni-

tish Kumar was the first to do it. The resolution has made it clear that the NDA does not believe in caste politics but acknowledges the need for a caste census to bring into the mainstream of development the deprived, exploited, Dalits and others left behind. It is the need of the society, he added. Andhra Pradesh Chief Minister and TDP president N Chandrababu Naidu did not attend the meeting due to a prior commitment in his (CONTD. ON PAGE-2)

Bangladesh's two 'chicken necks' more vulnerable than Siliguri corridor: Himanta

GUWAHATI, May 25: Chief Minister Himanta Biswa Sarma on Sunday said that those who 'habitually threaten' India on the 'chicken neck corridor', should note that Bangladesh has two such narrow strips of land which are "far more vulnera-

India's chicken's neck, known as the Siliguri corridor, is a narrow strip of land, measuring around 22 km-35 km in width, that connects the northeast region with the rest of India.

Sarma in a post on X said, "To those who habitually threaten India on the 'Chicken Neck Corridor', should note these facts as well: Bangladesh has two of its own 'chicken necks'. Both are far more vulnerable. First is the 80 km North Bangladesh Corridor- from Dakhin Dinajpur to South West Garo Hills. Any disruption here, can completely isolate the entire Rangpur division from rest of Bangladesh.

"Second is the 28 km Chittagong Corridor, from South Tripura till the Bay of Bengal. This corridor, smaller than India's chicken neck, is the only link between Bangladesh's economic capital and political capital," he also posted on X.

For the neighbouring country, disruption in one of these 'chicken necks' will cut off the link between its economic and political capitals, and disruption in the other will isolate the entire Rangpur division from the rest of the country, Sarma

"I am only presenting geographical facts that some may tend to forget. Just like India's Siliguri Corridor, our neigh bouring country is also embedded with two narrow corridors

Drugs worth ₹11.5 crore seized in Assam, 4 arrested

GUWAHATI, May 25: Narcotic substances worth ₹ 11.5 crore have been seized from two districts of Assam and four drug peddlers were arrested, Chief Minister Himanta Biswa Sarma said.

In a post on X, Sarma said on Saturday night that the Assam Police dealt a major blow to the drug trade through two operations in Karbi Anglong and Cachar districts.

"@karbianglongpol intercepted a vehicle at Khatkhati checkpost and seized: 4.899 kg Morphine worth ₹ 5 Crore; 1 peddler arrested," he said.

In the second operation in Cachar, the district police and Special Task Force (STF) seized over 1.2 kg of heroin worth more than ₹ 6 crore, Sarma said.

"@cacharpolice & @STF intercepted a vehicle at Sonabarighat and seized: 1.239 kg Heroin worth ₹ 6.5 Crore; 3 persons arrested," the chief minister added. (PTI)

India, Maldives to review implementation of economic, maritime security partnership today

NEW DELHI, May 25: External Affairs Minister S Jaishankar and his Maldivian counterpart Abdulla Khaleel will on Monday take stock of the implementation of the India-Maldives comprehensive economic and maritime security partnership

Khaleel, accompanied by a high-level delegation, is paying a three-day visit to India beginning Sunday evening. It is his third trip to India this year.

The India-Maldives vision document on comprehensive economic and maritime security partnership was adopted by Prime Minister Narendra Modi and Maldivian Pres-

ident Mohamed Muizzu in October last year. Foreign Minister Khaleel's visit is in continuation of "intensified high-level political exchanges" between India and Maldives, the Ministry of External Affairs (MEA) said an-

nouncing his trip. It said Khaleel will lead Maldives at the



second High Level Core Group (HLCG) meeting to oversee progress in the implementation of the India-Maldives vision document on comprehensive economic and maritime security partnership.

Foreign Minister Khaleel will also hold bilateral discussions with external affairs minister S Jaishankar, it said

"Maldives is India's key maritime neighbour and an important partner in India's 'Neighbourhood First' policy and vision MAHASAGAR that is Mutual and Holistic Advancement for Security and Growth Across Regions," the MEA said in a statement. "The visit is aimed at strengthening the comprehensive economic and maritime security partnership between the two countries," it added.

The ties between India and the Maldives came under severe strain after Muizzu, known for his pro-China leanings, took charge of the top office in November 2023. Within hours of his oath, he had demanded the withdrawal of Indian military personnel from his country. Subsequently, the Indian military personnel were replaced by civilians.

There was a thaw in the relations as Muizzu vowed to boost the bilateral ties with India during his visit to Delhi in October. (PTI)

'Excess sugar consumption leads to childhood obesity'

CBSE Sugar Boards to help students, parents make informed choices on sugar intake: Experts

NEW DELHI, May 25: With the students and parents to recognise Central Board of Secondary Education (CBSE) directing schools to set up dedicated 'Sugar Boards' to underline the importance of limiting sugar consumption, experts feel the move will encourage both students and parents to make informed choices on sugar intake.

The initiative targets a growing public health concern: the silent but significant rise in childhood obesity, Type-2 diabetes, and metabolic disorders.

As part of the move, which has stirred up enthusiasm among health experts, educators and nutritionists, schools across India have been directed to prominently display sugar awareness boards on their campuses to encourage both the "hidden" sugars in their daily

Dr R Goswami, professor of endocrinology at AIIMS Delhi, called the move a good initiative.

"Carbohydrates, especially those with excess of free sugar such as cold drinks and maida-rich food, are relatively cheaper sources of energy and calories when compared to protein-rich

"So, one gets more quantity of carbohydrate-rich food as compared to protein-rich food in the same amount of money spent,'

"As a result, when a person starts consuming more of such carbohydrate-rich food, coupled with



lack of exercise, obesity develops. However, there is no data that show taking sweets in moderation when the Body Mass Index (BMI)

is maintained leads to diabetes. So one can take sweets, but in moderation. "Excess sugar consumption leads to childhood obesity, which

can lead to Type 2 diabetes at a later stage. Children should also avoid refined carbohydrates such as maida, which increases calorie intake and can later lead to obesity. Taking sugar in limitation is very important as it directly affects the BMI." With over 250 million school-aged children in India, the potential impact of this initiative can be significant.

According to data, Indian children consume far above the World Health Organization's (WHO) recommended limit of 5 per cent of daily calories from added sugars -

India's renewable energy capacity grows 3-fold to 232GW in last decade

logged threefold growth in its renewable power capacity in the last decade, with the installed green energy capacity reaching 232GW, including large hydro power plants, currently compared to 75.52GW capacity in March 2014, official sources said.

India has emerged as a global front runner in renewable energy space as the traiff of the grid-connected solar power plants has gone down by 80 per cent to ₹ 10.95 per unit (for 170MW at Neemuch), sources said.

In March 2014, India's installed solar energy capacity was 2.82 GW, which has crossed 108GW now, recording multifold growth. Wind energy capacity has more than doubled to 51GW presently from 21GW in 2014.

Sources mentioned that during the UPA regime, India was almost absent in the solar manufacturing scene, with a meagre 2GW of solar module production in 2014.

In 2024, India has transformed into a global leader, with solar module manufacturing skyrocket-

HC Dismisses RVUNLAppeal on Compensation Cess

JAIPUR, May 25: The Rajasthan High Court has dismissed an appeal by the Rajasthan Rajya Vidyut Utpadan Nigam Limited (RVUNL) in connection with a dispute with Adani Entreprises Limited on the issue of compensation cess.

A bench of Justices Avneesh Jhingan and Bhuwan Goyal held that RVUNL is liable to reimburse the amount paid by Adani-owned joint venture company AEL under Clean Energy Cess for coal min-

Coal blocks were allotted by the Centre to RRVUNL which invited tenders to enter into a joint venture arrangement for the development and operation of coal blocks, transportation and delivery of coal to the thermal power stations of the

Adani Enterprises Limited (AEL) being the successful bidder formed a joint venture company and executed a Coal Mining and Development Agreement (CMDA) for 30 years with RVUNL.

In 2010, the central government levied Clean Energy Cess (CEC) on the goods mentioned in the Tenth Schedule of the Finance Act,2010 in which coal was also one of the levied products.

The RVUNL, in accordance with the CMDA, was paying the CEC, but in 2017, the Goods & Services Tax Acts (GST) were implemented.

The Goods & Services Tax (Compensation to States) Act, 2017 was also enacted to compensate states for the loss of revenue arising from the implementation of the GST.

The CEC imposed by the Finance Act, 2010, was repealed by the Taxation Amendment Act of 2017. Thereafter, a dispute arose between the two companies on the issue of reimbursement of cess paid under the 2017 Act known as the 'compensation cess'

The matter was referred for arbitration. While upholding the contention of the Adani company that RRVUNL is liable to reimburse compensation cess to them on the entire coal mined, the claim was allowed by the arbitrator.

The objections filed by the RVUNL under Section 34 of the Arbitration and Conciliation Act were rejected by the commercial court which held that the view taken by the arbitrator was a plausible one. Following this, the RVUNL approached the high

While dismissing RVUNL's appeal, the high court bench held, The argument that reimbursable shall include only those taxes for which the Nigam has a statutory liability to pay has lacuna. (PTI)

Geopolitical tensions to slow FY25 semiconductor design GCCs hiring: Report


NEW DELHI, May 25: India's semiconductor design Global Ca-pability Centers (GCCs) witnessed a 15 per cent decline in job openings in 2024-25, mainly due to ongoing geopolitical uncertainties and global supply chain disruptions, according to a report.

The report by talent solutions provider Careernet revealed open positions peaked in May 2024 with 3,760 jobs before gradually tapering off to 3,040 by January 2025 and closing the year at 3,181 in March 2025.

This reflects a measured slowdown of nearly 15 per cent yearon-year decline in active roles across India's top 50 semiconduc-

tor design GCCs. Despite this moderation, the overall demand for niche skills in VLSI (Very Large Scale Integration), embedded systems, and RF/analogue design remained resilient, with mid-sized GCCs demonstrating greater hiring agility, it added.

Semiconductor design is a niche area with inherently less headcount compared to other tech functions. so fluctuations in hiring sentiment - especially from two or three major industry players - can significantly influence the overall semiconductor design job market.



"The semiconductor design GCCs in India have experienced a relatively sluggish trend in new job openings over the past few quarters. This cautious hiring environment is largely driven by ongoing geopolitical uncertainties, global supply chain disruptions, and volatility in valuations within key technology areas, such as artificial intelligence and advanced computing," Careernet CBO Neelabh Shukla told PTI.

The report is based on an analysis of job openings in India's top 50 semiconductor design GCCs in

2023-24 and 2024-25. Meanwhile, the report revealed that the intellectual property (IP)

design sub-sector focusing on developing specialised chip components and reusable design blocks continued to demonstrate strong demand, with a significant number of open positions.

"Despite these short-term fluctuations, we remain optimistic about the medium to long-term outlook. Increased global focus on semiconductor supply chain resilience, combined with strategic Indian government initiatives to boost domestic semiconductor manufacturing and design capabilities in India, is expected to catalyse a more robust growth trajectory for semiconductor design jobs in the coming years," Shukla added. (PTI)

PNB targets ₹16k-cr recovery, aims to keep slippages below 1% in FY26: MD

NEW DELHI, May 25: Punjab National Bank (PNB) is targeting a significant recovery of ₹ 16,000 crore and aims to keep slippages below 1 per cent in the current fiscal year to sustain profitability, the top official of the country's second biggest state-owned lender said.

The total recovery of the bank stood at ₹ 4,733 crore for the fourth quarter and ₹ 14,336 crore for FY25 while overall slippages ratio was 0.73 per cent during the last financial year.

"Going forward, maximization of recovery and preventing fresh slippages are going to be priority areas. We are targeting a higher total recovery of ₹ 16,000 crore as against of recovery of about ₹ 14,000 crore in FY'25...we are expecting that the quarterly our slippages will be in the range of around ₹ 1,500 crore to ₹ 1,700 crore," PNB MD and CEO Ashok Chandra told PTI in an interview. The bank is going to focus on recovery through the technical write off accounts, he said, adding, "I am expecting that ₹ 6,000 crore of recovery will happen in the technical right off book. So, we have set up a target of R₹ 1,500 crore of minimum recovery every quarter." The technical write off book of the bank stands around ₹91,000 crore with the provision coverage ratio of more than 96 per cent and recoveries from such accounts are

Chunky assets are no longer there but there are a lot of NPA accounts in the range of ₹ 25 crore to ₹ 50 crore where recoveries are expected, he added

added to the bottomline directly.

The bank also plans to expand its RAM (retail, agriculture and MSMEs) sector lending to 58 per cent of its loan book in the current financial year with the help of various initiatives taken, including loan outreach.

The bank closed FY25 with loan outstanding under RAM segment

at ₹ 6,02,682 crore, 56 per cent of

the loan book. "We are planning to increase RAM from 56 per cent to 58 per cent in this financial year because that will give me the cushion against loss which is happening due to reduction in the interest rate in the corporate and the RLLR (repo-linked lending rate) loan book," he said.

The volume increase in the RAM segment will help compensate for a loss due to further rate cuts, he said.

For the financial year ended March 2025, PNB has emerged as the top bank in terms of profit growth among 12 public sector banks (PSBs) with a 102 per cent rise. The bank's net profit doubled to ₹ 16,630 crore compared to ₹ 8,245 crore in the previous fiscal.

The bank has reported a 14 per cent rise in total business at ₹ 26.83 lakh crore in FY25, one of the highest in the banking system. (PTI)

HFCL expects 25-30 pc revenue growth in current fiscal Company MD

NEW DELHI, May 25: Domestic telecom gear HFCL expects 25-30 per cent growth in revenue during the current fiscal on account of increase in order book and pick-up in demand, a top official of the company said. During the earnings call, HFCL's managing director

Mahendra Nahata said that the company's order book as of March 31, 2025, has increased to ₹ 9,967 crore from ₹ 7,685 crore as on March 31, 2024

"With strong order book, demand pick-up and full capacity utilization, the company expects growth of 25-30 per cent in revenue of the current financial year on an overall basis with major growth starting from the second quarter," Nahata said.

He said that HFCL has become the first Indian company to develop and commercially launch 5G Fixed Wireless Access customer premises equipment -- a modem for providing wireless 5G connectivity for home broadband services.

"In its very first year of launch, we have successfully despatched over 4 lakh units of this equipment, demonstrating strong market acceptance. With growing demand from telecom operators and ISPs, we ex-

pect to have continuous demand for such products. I am happy to inform you that in the last week we have received another order of ₹ 174 crores for this product," Nahata said.

During the March 31, 2025 quarter, HFCL recorded about 39 per cent decline in revenue to ₹ 800.72 crore mainly on account of poor demand for optical fibre.

Nahata said that after experiencing subdued demand for optical fibre cable over the past 6-7 quarters leading to lower capacity utilization, the company's optical fibre manufacturing has now begun operating at full capacity starting June 2026 quarter as against 45 per cent capacity utilisation during FY25.

"Our Optical Fiber Cable manufacturing capacity utilization was also 40 per cent during last financial year. This will also start operating at full capacity by July 2025. With market conditions showing clear signs of recovery and new growth drivers such as 5G rollouts, data centre expansion, BharatNet Phase III execution, and rising export demand, our revenue from optic fibre cable during FY'26 is expected to improve significantly," Nahata said. Jute industry pins hope on June 3 ECJ meet amid supply crunch, soaring prices

KOLKATA, May 25: The Centre's Expert Committee on Jute (ECJ) will meet in Kolkata on June 3 to review the raw jute and mesta supply situation, even as the industry struggles with high prices, delayed crop arrivals, and low availability

The committee, under the Ministry of Textiles, will assess the 2024-25 supply-demand scenario and discuss the outlook for the 2025-26 crop of the golden fibre. Officials from the Jute division, National Jute Board, Agriculture Ministry and other stakeholders will attend the meeting.

Though official estimates suggest sufficient availability with 73 lakh bales of production, 5 lakh bales of imports, and 23 lakh bales of carryover stock, actual supplies remain tight due to hoarding, jute mill officials said. Consumption stands at around 70 to 72 lakh bales. "A delayed monsoon in key jute-growing areas like Murshidabad, Nadia, and Goalpara has

Possibility of 4-day work week?

In recent times, there are talks in public domain and media in general that India will have a 4-day work week as and when the new ▲ labour codes, particularly Code on Wages 2019, come into operation in the very near future. The Ministry of Labour & Employment in India is exploring the feasibility of a 4-day workweek, with the possibility of longer daily shifts to maintain the 48-hour weekly limit. The contention here is that the Code on Wages 2019 allows for this flexibility, but employees must consent to the reduced work week and longer days, according to a statement from Apurva Chandra, Labour and Employment Ministry Secretary. This means that employees could potentially work 12-hour days, four days a week, to meet the 48-hour weekly requirement. The Labour Secretary, however, clarified that having a reduced number of working days does not mean a cut in paid holidays. Therefore, when the new rules will provide flexibility of four working days, it would imply three paid holidays. However, legal provisions as postulated in existing and proposed labour laws do not entertain the possibility of a 4-day work week. Daily work-hour is something that is stipulated in the Code on Wages 2019 and that is an 8 work-hour. Still a perception is being created in public domain that this 8 work-hour would become 12-hour and technically speaking 4-day week becomes feasible given the fact that weekly work hour is restricted to 48 hours.

But this does not stand legal scrutiny. Even though the union labour secretary was quoted widely in the media, Code on Wages 2019 read with the draft Code on Wages (Central) Rules 2020 provisions as available on Ministry's website, do not entail a 12-hour working day. The 12-hour spread-over includes rest hour and overtime. No worker is allowed to work more than five hours without a break of at least half an hour as per the Factories Act 1948. That means that the permissible maximum 12 hour spread over will definitely include at least half an hour rest period. The contention of 4day week emerges on the premise that daily working hours would be 12 hours and total working period in 4 days would be, in that case, 48 hours. The Factories Act stipulates 48 hours of working in a week. If 48 work-hour can be reached in 4 days, the remaining three days can be given as paid holiday. However, setting a daily 12-hour work day is not legally feasible under the Code on Wages and draft Rules framed thereunder. Daily working hours are stipulated at 8-hours only. Spread-over can extend to 12-hours.

In fact, the daily work-hour and weekly work-hour in the Code on Wages remain as they are in existing laws like Minimum Wages Act, 1948 and the Factories Act. The only change is regarding the spread-over limit. The existing spread over is maximum 10 and ½ hours which is now extended to 12 hours under the new Code. It seems that is what is creating confusion and giving rise to the misperception of a 4-day work week.

It is not my responsibility to soften the hearts of those who routinely disregard my fundamental needs. My perspectives may come mostly as complaints or grievances but how can I overlook these menaces and speak with a sugar-coated mouth? I am not in the position to soften the hearts of those who deprive me of my

I do not intend to offend anyone personally, but allow me to illustrate a few situations that any one of us could realistically experience. And if articulating such scenarios is seen as inappropriate or subversive, one must question the very meaning of Indian citizenship and the much-celebrated constitutional rights that accompany it. While I frequently criticize the government, I am equally capable of acknowledging and applauding its commendable efforts—I am not blind to progress when I see it. Take, for instance, the scenario of reporting an inactive police officer someone who either delays his duty or avoids it entirely. One day, you might find yourself on the receiving end of an unexpected and troubling act of retaliation, either by the officer in question or his associates—details of which I dare not elaborate on, for my own safety. We live in a country where, disturbingly, many feel hesitant or even afraid to approach the police for assistance, owing to their detached, often hostile demeanor. Consider the ordeal of seeking assistance from an administrative officer a Sub Divisional Collector, District Magistrate, or even an IAS officer—for a personal or private matter that is fully lawful under Indian regulations. You may spend weeks, even months, completing repetitive bureaucratic procedures, only to find your application lost amid chaotic and

Try obtaining essential academic or professional information from a state or central university—an institution that should ideally champion transparency and access to knowledge.

In such moments, filing an RTI seems impractical or even intimidating. How is a student expected to draw inspiration from an educator who, rather than nurturing trust, acts with arrogance and indifference? Govt. Bank employees working with the most neglecting and uninterested attitude which causes you to lose your patience and had to shift to a private bank who provides you way service and help. Banks receives money from us which also helps in the governance and the emplyees must not prioritize their famed lunch breaks and minimize their bossy attitudes. Step into a government hospital, and you may witness appalling behaviour from healthcare workers-mocking, dismissive responses to questions about a loved one's health, often with no effort to provide proper guidance. And that's if you manage to overlook the grim, unhygienic surroundings that in themselves pose severe health risks. These are just a few helpless problems which are occurring in our Democracy's departments, and I am among the lakhs who face such issues, which makes me slowly lose trust and hope in the government.

Eventually, I am starting to understand why Indians are leaving this land for other countries that value human beings more than their salaries and side incomes. Even though the heads of a Govt. may announce their determinations and goals in service us wholeheartedly dedicatedly, the lower ranks and staffs are the ones who are staining the images of their superiors. They act more powerful with the worst behaviour one can ask for when citizens seek help or the designated service the staffs are supposed to provide without any questions if all the required mammoth of complex documents are produced. We can negotiate easily with Gods but not with most government workers. If you do not have the "connections" then be aware of the hurdles you are about to face. Go with the least expectations, with some money for support, and if nothing works leading to agitations or disputes. be prepared for vulgar remarks, stern eye-looks, or threatens sometimes accompanied by physical harms.

Political crisis in Bangladesh intensifies with Army backing BNP for December election

The political crisis in Bangladesh has reached its flashpoint in the last 48 hours with two opposing groups getting ready for a major confrontation on the issue of holding elections in the country. One side is led by the newly floated party of the students - National Citizens Party (NCP) backed by the chief adviser Dr. Muhammad Yunus and the other group is the main opposition party Bangladesh Nationalist Party (BNP) supported by the Army Chief Waker Uz Zaman. The Jamaat el Islami is a divided house but most of them have distanced from their one time ally BNP and now supporting Dr. Yunus.

On Thursday, May 22, in the wake of the BNP demand that the chief adviser has to drop a few of his key advisers allied to the NCP, Dr. Yunus felt isolated as he was already under fire for the lapses in administration during a meeting early this week with the Army Chief. Reports said that he decided to submit his resignation as the chief adviser and indicated that to his close NCP advisers. They immediately intervened and persuaded him not to take any precipitate step at this crucial time of the country's politics.

Nahid Islam, NCP general secretary and a close aid of Dr. Yunus said after talking to him on Thursday evening that

the chief adviser was weighing resignation. He said he went to Jamuna, the state guest house as they had been hearing about Yunus's possible resignation since morning. According to him, the chief adviser expressed concerns about whether he would be able to continue working under the current circumstances under which he was being pressurized from opposing directions.

Dr. Yunus said he felt "held hostage" by the countless demonstrations, "I cannot work like this if you, all the political parties, cannot reach a common ground," the NCP chief quoted Yunus as saying. The NCP general secretary urged the Chief Adviser to continue in his present position and guide the country to tide over the present political turmoil to which Dr. Yunus reportedly agreed.

Lately, political tensions have been rising, fuelled by protests from various parties and increasingly toxic rhetoric on social media and at political gatherings. The BNP has long been pressing for the election by December. Also, on Thursday, BNP demanded a smaller advisory council, with immediate removal of Mahfuj, Asif and National Security Adviser Khalilur Rahman.

According to Dhaka media reports, leaders of the NCP demonstrated on Wednesday, saying they would not take part in any polls under the current Election Commission. Accusing the EC of bias and terming it a "party office" of the BNP, they demanded its reconstitution. They also demanded the resignation of Finance Adviser Salehuddin Ahmed, Law Adviser Asif Nazrul, and Planning Adviser Wahiduddin Mahmud. They, along with Jamaat-e-Islami, want the election only after reforms are carried out and trial of the banned Awami League leaders.

The tensions between the BNP and the NCP have been escalating since the founding of the NCP by the student leaders in February this year. Dr. Yunus is under the influence of the NCP and he was forced to take the decision on the banning of Awami League and denying the Party participation in the coming elections. This decision was not acceptable to both the BNP and the Army Chief. BNP favours the view that the Awami League in a truncated form can be allowed to take part in elections, since any election with the earlier ruling party being kept out, will create doubts about the legitimacy of the polls to the foreign

BNP now finds that on such a major issue, the party's views were sidelined and the NCP's young leaders precipitated the decision through their pressure on the Chief Adviser.BNP leaders also believe that the NCP will delay the holding of elections as they are demanding that the

current election commission can not be trusted by them for holding fair polls. This means that they are not ready for any road map for holding elections even early next year.

Right now, BNP is in a comfortable position with the return of the BNP chairperson Khaleda Zia following medical treatment in London. Though the BNP supremo is not allowed to do running for campaign in favour of BNP, she is meeting leaders and giving instructions. Khaleda Zia has influence among the army officers. That is helping the BNP compared to the contender NCP.. BNP leaders are organizing meetings and making preparations for booth committees at the lower level

The NCP, on the other hand, is setting up its core committees for the stakeholders like the workers, peasants, women, young educationists, lawyers apart from the core base of students. The NCP thinks BNP as the establishment party like Awami League. The NCP leadership is determined to challenge the BNP on policy issues and corner the party which is hoping to emerge as the winner in the coming elections. The battles lines are already drawn up. Come June and July, the streets of Dhaka and the districts might witness massive demonstrations by both the parties focusing on their respective

Outrage grows over Trump's wild allegation against South African President

utrage has continued to mount after United States President Donald Trump falsely accused South African President Cyril Ramaphosa of the systematic killing of white farmers. President Trump dimmed the lights of the Oval Office to play a video of left-wing politician Julius Malema chanting an old anti-apartheid

Trump then proceeded to display news articles and photos to highlight his accusation that white farmers have faced "death, death, horrible death" at the hands ofRamaphosa's government.

One of the photos was later revealed to be a screenshot from a video taken in the Democratic Republic of Congo in February 2025, showing Red Cross workers respondmass jailbreak in the Congolese city of Goma.

Trump had already cut all US assistance to South Africa and welcomed several dozen white South African farmers to the US as refugees as he pressed the case that a "genocide" is underway in the country.

Since returning to office, Trump has launched a series of accusations against the ANC-led government, claiming it is seizing land from white farmers, enforcing anti-white policies and pursuing an anti-US foreign policy. The executive order breaking off support for South Africa made it clear that one reason for the attack was "accusing Israel, not Hamas, of genocide" in the International Court of Justice. Experts in South Africa say there is no evidence of white people being targeted for their race, although farmers of all races are victims of violent home invasions in a country with a high crime rate. llergies are common, particularly in children. Some allergies tend to disappear as a person ages, but many are life-

In the United States, allergies are the sixth leading reason for chronic illness, with more than 50 million people experiencing various allergies each year.

Symptoms of allergies may interfere with a person's daily tasks and reduce their quality of life.

In this article, we examine whether people can get rid of allergies. We also look at prevention strategies and possible ways to manage allergies

Can you get rid of allergies forever?

There is currently no cure for allergies. However, researchers continue to investigate potential therapies.

People can treat their allergy symptoms with medications and take steps to reduce their exposure to the allergen causing the reac-

Immunotherapy

Immunotherapy is not a cure for allergies but a disease-modifying treatment. It may help reduce a person's sensitivity or allergic response to allergens.

A doctor may recommend immunotherapy if:

- · Medications are not controlling allergy symptoms
- A person is unable to avoid allergens
- · Allergy medicines are interacting with a person's other medica-
- A patient does not like taking medications

Some people no longer have significant allergic reactions to allergens following years of immunotherapy. Others may require ongoing immunotherapy to manage their symptoms.

Immunotherapy is available as allergy shots (SCIT- subcutaneous immunotherapy) or sublingual immunotherapy (SLIT). Oral immunotherapy (OIT) is also available for peanut allergies.

Allergy shots Allergy shots involve having exyears. Over this time a person becomes less sensitive to the allergen and reacts to it less severely. Allergy shots help control

- symptoms of allergies to:
- Pollen Dust mites
- Pet dander Molds
- Bees
- Other stinging insects SLIT

SLIT involves small doses of an allergen that a person takes in tablet or drop form under the tongue to improve tolerance to an allergen and reduce symptoms. It is commercially available for allergies to dust mites, grass pollen,

and ragweed.

Peanut allergen powder (Palforzia) is currently the only OIT with approval from the Food and Drug Administration (FDA). Palforzia may reduce severe allergic reactions, including anaphylaxis, occurring with accidental exposure to peanuts in children ages 4-17.

Do allergies go away? Some people may outgrow allergies, especially allergies developed during early childhood. Whether someone's allergy will disappear as they get older depends on what they are allergic to and the severity

of the allergy. Several studies suggest some

food allergies may go away. Around 85% of children out-

Common OTC oral decongestants include oxymetazoline nasal (Vicks Sinex) and phenylephrine (Sudafed PE). Pseudoephedrine (Sudafed) may be available behind the pharmacy counter or by pre-

Mast cell stabilizers

Mast cell stabilizers, such as cromolyn sodium (NasalCrom), prevent the release of chemicals that cause inflammation, including histamine and leukotrienes. This prevents allergy symptoms

from occurring, such as sneezing,

runny nose, and itchy eyes. Oral corticosteroids

A doctor may prescribe an oral corticosteroid, such as prednisone, for severe allergy symptoms. Oral corticosteroids reduce inflammation and prevent severe allergic reactions.

A doctor will monitor a person taking oral corticosteroids because the medication may cause severe side effects.

Topical corticosteroids

Topical corticosteroids, such as hydrocortisone, reduce skin inflammation and irritation. They are available OTC and with a prescription as creams, gels, and lotions. **Epinephrine**

Anaphylaxis is a severe, lifethreatening allergic reaction. During anaphylaxis, a person may experience constriction of the airways and swelling of the throat. Blood vessels may also expand, which can cause a severe drop in blood pressure.

Doctors prescribe an injectionbased medication called epinephrine to prevent anaphylaxis from becoming life-threatening in people with potentially severe aller-Epinephrine is more

Epinephrine improves breathing and contracts blood vessels to continue supplying the heart and brain with blood.

Prevention

The most important step a person can take to prevent an allergic reaction is to avoid the allergen that triggers their allergy.

Avoiding allergens is not always practical or possible — for example, if a person is allergic to their pet's dander or is a gardener with a pollen allergy.

In these cases, a doctor can help prepare an allergy management plan to reduce allergen contact and manage symptoms with medicines.

If someone is unclear on the cause of an allergy, they may find it helpful to keep a diary. Keeping track of their whereabouts, actions, and diet can help a person identify what triggers or worsens their

symptoms. When to contact a doctor

A person should consult their doctor or an allergist if they experience persistent allergy symptoms that do not ease with OTC treatments or that interfere with carrying out their daily tasks.

According to the Indian Council of Medical Research (ICMR), cancers among the youth, particularly breast, colorectal, blood, and thyroid cancershave seen a significant spike, especially in urban areas like Delhi, Bengaluru, and Mumbai. This shift in demographics is a wake-up call for early detection, timely interven-

This can be achieved by using less salt in cooking, avoiding sprinkling extra salt on food, and steering clear of pickles, ketchup, fast food, and processed items-many of which are loaded with hidden sodium.

Russia hits Ukraine with largest drone-and-missile attack of war so far, killing at least 12

KYIV, May 25: A massive Russian drone-and-missile attack targeted the Ukrainian capital, Kyiv, and other regions in the country for a second consecutive night, killing at least 12 people and injuring dozens, officials said early

The scale of the onslaught was stunning — Russia hit Ükraine with 367 drones and missiles, making this the largest single attack of the more than three-yearslong war, according to Yuriy Ihnat, a spokesperson for Ukraine's Air

In all, Russia used 69 missiles of various types and 298 drones, including Iranian-designed Shahed drones, he told The Associated

It was "the most massive strike in terms of the number of air attack weapons on the territory of Ukraine since the beginning of the full-scale invasion in 2022," Ihnat

There was no immediate comment from Moscow.

For Kyiv, the day was particularly sombre as the city observes Kyiv Day, a national holiday that falls on the last Sunday of May commemorating its founding in the 5th century.

"I was trying to persuade my daughter to come to us," Fedorenko said, adding she told her daughter, "After all, you live on the eighth floor in Kyiv, and here it's the ground floor.

"She said, 'No, mum, I'm not coming.' And thank God she didn't come, because the rocket hit (the house) on the side where the children's rooms were," Fedorenko said.

Ivan Fedorenko, 80, said he regrets letting their two dogs into the house after the air raid siren went off. "They burned to death," he said. "I want to bury them, but I'm

Indonesian president, Chinese premier meet to discuss expanding trade during US trade war

JAKARTA (INDONESIA), May 25: Chinese Premier Li Qiang met with Indonesia's President Prabowo Subianto on Sunday to discuss ways to expand trade and investment during the US global trade war and as ec'monomic globalization faces headwinds

Li arrived in Indonesia's capital, Jakarta, on Saturday afternoon for a three-day visit to Southeast Asia's largest economy. It was the first stop of his first overseas visit this year.

Indonesia and China are member states of the Group of 20 major developing countries and emerging economies and of BRICS.

Li brought 60 prominent Chinese businesspeople for his address to the Indonesia-China Business Reception on Saturday evening. He emphasised in his remarks that China's economy has achieved rapid growth this year despite increasing external chal-

"The current international situation is a stalemate," Li said at the event, which was also attended by Subianto, "Unilateralism and protectionism are on the rise, bullying behaviour is increasing.

Li noted this year marks the 70th anniversary of the conception of the Non-Aligned Movement by Asian and African countries in Indonesia's Bandung city when the world was at a historical crossroads.

The Bandung spirit of solidarity, friendship and cooperation has played a pivotal role in the unity and cooperation of the Global South countries, Li said.

"More than seven decades later, the world is once again at an important crossroads," Li said.

He called on all countries to seek common ground while resolving differences through dialogue and peaceful coexistence.

Subianto expressed gratitude to the Chinese government and its companies "that have participated in our economy, created jobs, transferred technology and built trust among all businesses, especially in our homeland." He also invited Chinese businesspeople to invest more in Indonesia. Two-way trade exceeded USD 147.8 billion last year, growing by 6.1 per cent.

Li said for nine consecutive years, China has been Indonesia's largest trading partner, and its Belt and Road cooperation program has seen substantive progress, including nickel smelting plants and Whoosh, the commercial service of Southeast Asia's first high-speed railway which has been operating since October 2023, carrying nearly 10 million pas-

terials to China's fast-growing electric car makers.

On Sunday, Subianto hosted Li in a ceremony at Merdeka Palace in Jakarta before the two leaders held a bilateral meeting behind closed

"The current international situation is facing a huge upheaval, and peaceful development is facing many uncertain and unstable factors," Li said in his opening remarks.

China wants to strengthen its traditional friendship and Belt and Road Initiative partnership with Indonesia. especially in five key pillars: politics, economy, maritime affairs, security and cultural and people-to-people exchanges." Li said.

Li's visit to Jakarta in September 2023 came with USD 21.7 billion in new Chinese investment, following a previous USD 44.89 billion investment commitment made when former President Joko Widodo met Chinese President Xi Jinping in July the same year.

The two leaders oversaw the signing of a dozen agreements including cooperation to encourage bilateral transactions in local currencies, trade, investment, tourism, health and agricultural exports.

Subianto emphasized the close historical relationship between Indonesia and China and said the two countries are at an important moment in the history of bilateral relations.

"I reiterate our commitment to strengthening our comprehensive strategic partnership with the people and the government of China,' Subianto said. "We see this will bring goodness not only to the two countries, but also to the entire Asian re-

Indonesia's Minister of Investment and Downstream, Rosan Roeslani, who is also the head of the Investment Coordinating Board, said that Li's visit brought prospects for concrete cooperation, including the implementation of USD 10 billion in investment that was previously agreed upon by the two countries.

"The investment has started and covers a number of strategic sectors, Roeslani told reporters, adding that the visit will also open opportunities for several new collaborations in the fields of transportation, industrial cluster development, mineral downstreaming and the chemical sector.

Li is scheduled to meet with Indonesian parliament members Sunday. On Monday, he will head to Malaysia, where he and Prime Minister Anwar Ibrahim are scheduled to address the ASEAN-GCC-China Economic Summit, attended by leaders from Southeast Asian countries

The election is the first to allow broad voter participation since last year's presidential contest, which President Nicolás Maduro claimed to have won despite credible evidence to the contrary. It is taking place two days after the government detained dozens of people, including a prominent opposition leader, and linked them to an alleged plot to hinder the vote.

"I think it's absolutely despicable," opposition operative Humberto Villalobos said Saturday, referring to the election participation of some opposition members. "We're facing the most brutal repression in recent years in the country. (The vote) is a comedy, a parody.'

Villalobos was elections division chief for opposition leader Maria Corina Machado when he and five other government opponents sought refuge in March 2024 at a diplomatic compound in Venezuela's capital to avoid arrest. He spent more than a year there, and on Saturday, along with four of the others, spoke publicly for the first time since they left the compound and arrived in the United States earlier this month.

US Secretary of State Marco Rubio, who met with the group Friday, has described their departure from the compound as an international rescue operation. That assertion has been challenged by Venezuelan Interior Minister Diosdado Cabello, who has said it was the result of a negotiation with the government.

The ruling party-loyal National Electoral Council is overseeing Sunday's election for state legislators, 285 members of the unicameral National Assembly and all 24 governors, including the newly created governorship purportedly established to administer Essequibo, a region long



LAHORE, May 25: At least 20 people were killed and over 150 injured in Pakistan's Punjab as powerful windstorms and heavy rains battered the province on Satur-

The storm was so powerful that it paralysed road and air traffic, damaged infrastructure and caused widespread power outages.

According to the Punjab government, most deaths in the province of over 13 crore occurred due to the collapse of dilapidated houses or getting trapped under fallen billboards.

"At least 20 people, including children, were killed and over 150 injured in various parts of Punjab in incidents related to powerful windstorms and heavy rains," the provincial government said on Sunday.

The gusty winds and hail also hit the capital, Islamabad, and Khyber Pakhtunkhwa province, causing extensive damage to crops and power lines. However, no casualty was reported there.

Storms accompanied by heavy rainfall led to water accumulation in several low-lying areas and trees falling

A private airline flight FL-842 from Karachi to Lahore also narrowly escaped a disaster when it was caught in severe turbulence while landing at Lahore airvideos of passengers aboard the plane reciting Quran

DHAKA/NEW DELHI, May 25: Bangladesh's International Crimes Tribunal on Sunday framed charges against a former police commissioner and seven other officers for their alleged atrocities during last year's antigovernment protests. The protests had led to the ouster of then prime minister Sheikh Hasina's regime.

The tribunal for the first time took cognizance of a case filed over mass killings and atrocities committed during the July 2024 uprising.

A three-member bench of the tribunal, headed by Justice M Golam Mortuza, accepted the charges submitted by the prosecution against Dhaka's ex-police commissioner Habibur Rahman Habib and seven other policemen and set June 3 as the date for starting hearing in the case.

"There are grounds to take into cognizance the formal allegations," Prothom Alo newspaper quoted the bench as saying. According to the charges, the then Dhaka Metropolitan Police Commissioner Habib, now at large, allegedly ordered subordinates to open fire on protesting crowds at the Chankharpul area in old Dhaka.

Apart from Habib three other accused are on the run while four are in jail. The four were present as the tribunal accepted the charge.

Hasina, who is now in India, and several of her cabinet and party colleagues are accused of identical crimes. The tribunal's move came as government employees for a second consecutive day staged protests inside the Bangladesh Secretariat on Sunday against the proposed Government Service (Amendment) Ordinance, 2025. The protestors have been demanding its withdrawal, calling it a black law that made it easy for authorities to take punitive actions and terminate the government employees.

Chief Adviser Muhammad Yunus's interim Cabinet approved the law last

sent. National Board of Revenue (NBR) officials also abstained from work for the second consecutive day demanding scrap of a separate new

The protest began after the NBR Reform Unity Council rejected the finance ministry's decision to amend the Revenue Policy and Revenue Management Ordinance which seeks to dissolve the NBR and form two existing divisions, separating tax policymaking from administration.

Yunus's government in the past two days faced several challenges.

There have been reports of discord between the military and the interim government over the possible timeline for holding the parliamentary elections and other policy issues related to Bangladesh's security affairs, particularly involving a proposed humanitarian corridor of aid channel to Myanmar's rebel-held Rakhine state.

Zaman along with the Navy and Air Force chiefs met Yunus last week and reportedly reiterated their call for election by December this year to allow an elected government to take charge. They also conveyed their reservation about the corridor issue.

The next day, Zaman held a senior officers meeting at Dhaka Cantonment and said he was unaware of the government's several strategic decisions despite the military's active role. The military also decided to be tough against rampant incidents of "mob justice". Troops were called out of their barracks with magistracy power to maintain law and order.

Yunus on Saturday held an unscheduled closed-door meeting of the advisory council which later said in a statement that they discussed in detail the "three primary responsibilities entrusted to the interim government elections, reforms, and justice". (PTI)

Informal talks between Indian, Pakistani officials in third-party countries may help de-escalate tensions: UK experts

LONDON, May 25: Leading UK strategic experts believe an attempt to coordinate informal talks between Indian and Pakistani officials in third-party countries may offer a possible prospect to restore stability following the recent military escalation in the re-

The International Institute for Strategic Studies (IISS), a London-based think-tank, last week held a session entitled 'The India-Pakistan military conflict and prospects for regional stability and security' to weigh up the political and security considerations of the conflict in the region.

It came ahead of an all-party delegation led by BJP leader Ravi Shankar Prasad bound for Europe, arriving in the French capital of Paris on Sunday to present India's counterterrorism stance and Operation Sindoor in the wake of the Pahalgam terror attack on April 22 that claimed 26 lives.

"India and Pakistan have emerged from their 100-hour military conflict with strongly differing and disputed narratives," said Rahul Roy-Chaudhury, IISS Senior Fellow and Head of the South and Central Asian Pro-

"India has refused to talk or trade with Pakistan until all terror attacks against India



end," he said. When, or if, that happens, India has stated that it will focus only on terrorism and Pakistan-occupied Kashmir (PoK) in any future talks with Pakistan, he noted

international intervention towards this end,

he said

"In this context, the regeneration of private and informal 'track 1.5' dialogues between Indian and Pakistani senior officials and influential experts held in third-party countries

provide the best immediate prospect of a return to regional stability," he added.

India has made it clear that it will only have a dialogue with Pakistan on the return of Pakistan-occupied Kashmir and the issue of terrorism.

India has always maintained that the Kashmir issue is a bilateral matter and there is no space for any third party.

With reference to the all-party delegation, set to arrive in the UK next week following talks in other capitals of Europe, Roy-Chaudhury believes the focus will be on showcasing an all-India consensus and sensitising the international community over India's counter-terrorism doctrine.

"I think the focus of these delegations will be really on sensitising the international community on how to counter terrorism emanating from Pakistan," he said.

Desmond Bowen, IISS Associate Fellow for South and Central Asia, pointed to the wider global interest in this regional conflict.

"The world is interested in this because the world is interested in the possibility, and indeed the avoidance of a nuclear war... in that context, the risk has clearly shot up, deterrence failed on both sides and the chance of misreading across the India-Pakistan divide is a lot higher now than it's been for many years," said Bowen.

Antoine Levesques, IISS Senior Fellow for South and Central Asia, focussed on the military technology aspects of the conflict earlier this month.

"India has made a very big narrative of the Make in India implications of what it sees as its successful use of military equipment during that campaign, and this will have an impact on India's ability to market itself as a

defence supplier," he said. Viraj Solanki, IISS Research Fellow for South and Central Asia, highlighted the implications of the "disputed and differing" narratives between the US, India and Pakistan

on the May 10 ceasefire. India and Pakistan reached an understanding on May 10 to end the conflict after four days of intense cross-border drone and mis-

"Three differing narratives raise many questions on the sustainability of the ceasefire over the medium to long term. And I think this is fundamentally because there is no joint statement between India and Pakistan on the ceasefire, as there was for the 2021 ceasefire which held for four years,' said Solanki. (PTI)



Operation Sindoor not just military mission, but reflection of changing India: PM Modi

NEW DELHI, May 25: Prime Minister Narendra Modi on Sunday said that Operation Sindoor was not just a military mission, but "the face of a changing India" that reflects the country's resolve, courage, and growing strength on the global stage.

Addressing his monthly radio programme Mann Ki Baat, the Prime Minister termed Operation Sindoor as a turning point in the global fight against terror and a symbol of India's growing strength and clarity of purpose.

Leaders of the ruling National Democratic Alliance, who had gathered here for a meeting, listened to the Prime Minister's Mann ki Baat address together.

Operation Sindoor was launched on the intervening night of May 6-7 to avenge the April 22 Pahalgam terrorist attack

In retaliation, the Indian armed forces struck terror sites, including the headquarters of Lashkar-e-Taiba, Jaish-e-Muhammad, and Hizbul Mujahideen.

The Prime Minister said Operation Sindoor has infused the entire nation with a sense of patriotism with people declaring to prefer Made in India goods over imported ones.

"Today the entire country is united against terrorism, filled with anger and



determination," Modi said.

"This itself is the real strength of India. I urge all of you too. Come, let us take a pledge on this occasion, wherever possible in our lives, we will accord priority to products made in the country," he said.

'This is not just a matter of economic self-reliance — it is a feeling of participation in nation building. One step of ours can become a huge contribution to the progress of India," he said.

The Prime Minister said the precision with which Indian forces attacked the terrorist infrastructure across the border was "extraordinary."

Modi emphasised that the operation was not a one-off military action, but a reflection of a changing and resolute

"Operation Sindoor is the picture of our resolve, courage, and the face of a changing India." he said.

The operation's success was followed by a series of gestures in tribute to the armed forces, ranging from patriotic poems on social media to paintings by children and massive Tiranga Yatras.

"In many cities, youth volunteered for civil defence, wrote poems, sang songs of resolve, and children made paintings carrying powerful messages," Modi said. He talked about a recent visit to Bikaner where he was gifted paintings

made by children. "In cities like Katihar and Kushinagar, families named their newborns 'Sindoor'

in honour of the operation," he said. The Prime Minister credited India's home-grown defence capabilities for the mission's success, following the spirit of 'Atma Nirbhar Bharat'.

'This was the ultimate bravery of our soldiers, backed by the power of weapons, equipment, and technology made in India," he said.

Modi noted a renewed energy across the country towards the 'Vocal for Local' campaign post-Operation Sindoor, saying the mission had not just inspired patriotism but also strengthened the spirit of self-reliance.

'This victory carries the sweat of our engineers, technicians, and every citizen who contributed," he said. (PTI)

Heavy rains, strong winds continue to lash Kerala, causing widespread destruction



THIRUVANANTHAPURAM, May 25: A Huge number of trees got uprooted, houses were damaged, rivers are in spate, and shutters of some dams were raised in Kerala on Sunday with heavy rains overnight and strong winds continuing to lash across the state.

Almost all districts of the state received widespread rains throughout the night and in the morning, causing intense waterlog-

ging in low-lying areas and traffic snarls. In landslide-battered Chooralmala in Wayanad, incessant heavy rains caused concerns among local people the previous

Water flow in the Punnapuzha River, crisscrossing through the Chooralmala-Mundakkai region, heavily increased due to continuing downpour, they said.

'We are yet to recover from the shock of last year's landslide. We have not slept properly at night, as we were scared of seeing heavy rains. We feared something worse," an elderly local man told a TV channel.

In Pathanamthitta district, a family had a narrow escape as huge trees uprooted and fell upon their tile-roof house near Ezhamkulam, as strong winds accompanied by a downpour lashed the area on the previous evening.

"My daughter had a narrow escape as she just came out of the house when the trees fell upon the house," a family member said, pointing towards the broken roof of his old tiny house.

Five shutters of the Malankara dam in Idukki district were raised on Sunday morning to release the excess water, according to an official statement.

Those who live on the banks of the Thodupuzha and Moovattupuzha rivers should exercise caution in view of the raising of dam shutters, it said.

Uprooting of trees was reported in northern Kozhikode and Kasaragod districts, where strong winds caused damage in many places.

Tragedy was averted in the heart of Kollam city as a huge flex board, erected on the side of a road, fell, local people said.

A house and vehicles were damaged as uprooted trees fell upon them in Kunnathunad and Munambam Harbour, respectively, in Ernakulam district.

Meanwhile, the Indian Meteorological Department (IMD) on Sunday predicted thunderstorms with moderate rainfall (5-15mm/ hour) with surface wind speed likely to be 50 Kmph (in Gusts) at a few places in Ernakulam, Thrissur, Malappuram and Kozhikkode.

Moderate rainfall (5-15mm/ hour) with surface wind speed likely to be 40 Kmph (in Gusts) at a few places in Alappuzha, Pathanamthitta, Kottayam, Palakkad, Kozhikode, Wayanad, Kannur and Kasaragode, it said.

The Indian National Centre for Ocean Information Services (INCOIS) warned of high tidal waves from 3.1 metres to 4.2 metres and rough seas in the coastal area of the state till Monday night.

The IMD on Saturday announced the early onset of monsoons in the state. It said that the state is witnessing the early

arrival of monsoon after a gap of 16 years. According to the IMD, the monsoon arrived eight days earlier than usual, and the last time this happened was on May 23,

Prior to that, an early onset of the monsoon was seen on May 19, 1990, after

Liberian ship sinks off Kerala coast, 24 crew rescued

KOCHI/NEW DELHI, May 25: A Liberian vessel carrying 640 containers, including 13 with hazardous cargo, sank off the Kochi coast on Sunday, sparking fears of a possible oil spill. All 24 crew members were rescued after the ship developed a critical tilt on Saturday, according to officials.

So far, no oil spill has been reported, the Ministry of Defence said on Sunday as full pollution response preparedness was activated by the Indian Coast Guard which was monitoring the situation along with the Indian Navy.

"Liberian container vessel MSC ELSA 3 (IMO NO. 9123221) sank off the Kochi coast at around 0750 hrs today on May 25, 2025, due to

"The vessel went down with 640 containers, including 13 with hazardous cargo and 12 containing calcium carbide. It was also loaded with 84.44 MT of diesel and 367.1 MT of furnace oil," the ministry said in a statement.

Of the 24 crew members, 21 had been rescued by the Indian Coast Guard on Saturday, and the remaining three were later rescued by INS Sujata, which joined the rescue operation launched by the

Given the sensitive marine ecosystem along Kerala's coast, the ICG has activated "full pollution response preparedness" and ICG aircraft equipped with advanced oil spill detection systems are conducting aerial surveillance. officials said.

"ICG ship Saksham, carrying pollution response equipment, remains deployed at the site. So far, no oil spill has been reported," the defence ministry said.

The Kerala State Disaster Management Authority (KSDMA) has cautioned the general public against touching any cargo containers or oil spills that may wash ashore.

The coast guard has confirmed that the vessel was carrying Marine Gas Oil (MGO) and Very Low Sulphur Fuel Oil (VLSFO).

Deploying its ships and aircraft, the Indian Coast Guard had launched a rescue operation on Saturday following a distress call from the Liberian container vessel that developed a critical 26-degree list nearly 38 nautical miles southwest of Kochi.

The emergency began on May 24, when MSC ELSA 3, en route from Vizhinjam to Kochi, developed a 26-degree "starboard list" approximately 38 nautical miles southwest of Kochi, the officials

The vessel lost stability, prompting a distress call. ICG's Maritime Rescue Sub-Centre (MRSC) in Kochi immediately launched a coordinated response,

they said "An ICG Dornier aircraft was deployed for aerial surveillance, spotting two life rafts with survivors. ICG patrol ships and merchant vessels MV Han Yi and MSC Silver 2 were also diverted to assist, in line with global search and rescue protocols," the defence

ministry said. By late evening of Saturday, 21 of the 24 crew, including nationals from Russia, Ukraine, Georgia, and the Philippines, had been rescued. Three senior crew members remained onboard to assist with salvage arrangements, it said. (PTI)

BJP slams CM Siddaramaiah for skipping NITI Aayog meeting, says Karnataka deserves better

BENGALURU, May 25: Slamming Chief Minister Siddaramaiah for not attending the 10th meeting of the NITI Aayog Governing Council in New Delhi, chaired by Prime Minister Narendra Modi, the BJP on Sunday said Karnataka deserves better.

State BJP President B Y Vijayendra termed the CM's absence a deliberate withdrawal from opportunities that could shape Karnataka's future.

He accused Siddaramaiah of desperately clinging to a slipping chair and focusing more on appeasing the Congress high command.

Sources close to the Chief Minister cited a "prior engagement" in the state as the reason for Siddaramaiah skipping the meeting in New Delhi on Saturday and said he had sent his speech to be read out at the council. They clarified that the Chief Minister did not "boycott" the meeting. "The Congress government in Karnataka, unable to hide its complete lack of development work, keeps harping about what the Centre owes, as if blam-

ing Delhi will somehow cover up its failures. But governance is not a blame game or a chorus of complaints; it is a shared responsibility built on cooperation and commitment to the people," Vijayendra posted on 'X'. Noting that when Narendra Modi invites every Chief Minister for the 10th NITI Aayog Governing Council to shape the shared vision of Viksit Bharat by 2047, CM Siddaramaiah chooses to skip, he said, "This isn't just one leader missing one meeting—it's a deliberate withdrawal from opportunities that could shape Karnataka's future." "A Chief Minister desperate to cling to a slip-

"Chief Ministers of Congress-ruled states like Telangana, Himachal Pradesh, and DMK-ruled Tamil Nadu's Chief Minister M.K. Stalin attended the meeting, but, unfortunately, our CM Siddaramaiah did not. He should tell the people why he did not attend or whether he boycotted it," he said.

"This Chief Minister and government, along with its ministers and MLAs, can stage protests in Delhi against the central government, but cannot attend such an important meeting. It seems doing politics is more important to this CM than the development of the state," the state BJP chief added.

"This is an injustice to the state. Since becoming Chief Minister, Siddaramaiah has chosen a path of confrontation with the central government, which will do no good for Karnataka," he said.

Pointing out that the CM Siddaramaiah and Deputy CM D K Shivakumar have time to hold the government's two-year celebration in Hosapete, attend the IPL match at Chinnaswamy Stadium, and go to Delhi to knock on the high command's door when their chair is in trouble, BJP leader and Leader of Opposition in Assembly R Ashoka said they don't have time or interest to attend the NITI Aayog meeting, which was attended by the PM and CMs of all states.

He also noted that the CM and Deputy CM did not attend the World Economic Forum meeting held in Davos. "Why do people like you need politics and public life? For the Congress party, politics is just about having fun and enjoying power; it has no interest or commitment to public welfare or development,"

Andhra CM seeks Defence Minister's support to transform state into aerospace, defence industries hub

AMARAVATI/NEW DELHI, the fifth hub. May 25: Andhra Pradesh Chief Minister N Chandrababu Naidu sought Defence Minister Rajnath Singh's support to transform the state into an aerospace, defence industries hub. Naidu, during his recent meeting with Rajnath Singh, gave a wish list of half a dozen projects, requesting him to mobilise defence public sector undertakings (DPSU) investments and set up an air force station.

Similar to Uttar Pradesh and Tamil Nadu defence corridors, the Chief Minister also requested Singh to notify five hubs with the potential to develop into aerospace and defence industries.

"Request formal recognition for the hubs by the Central government to promote investments," a press release issued on Sunday, quotes the CM as saying.

The five hubs proposed by him include Jaggaiahpet – Donakonda Hub (6,000 acres), Lepakshi -Madaksira Hub (10,000 acres), Visakhapatnam – Anakapalli Hub (3,000 acres), Kurnool – Orvakal Hub (4,000 acres) and Tirupati as

According to Naidu, Jaggaiahpet - Donakonda hub is suited for missile and ammunition production, Lepakshi – Madakasira Hub for civil and military aircraft and manufacturing, electronics Visakhapatnam – Anakapalli Hub for naval equipment production and weapons testing.

Likewise, he noted that Kurnool Orvakal Hub is well suited for military drones, robotics and advanced defence component manufacturing, while Tirupati Hub is apt for research and development (R&D) in advance defence innovations. Naidu also requested the establishment of a DRDO Industry-Academia Centre of Excellence at IIT Tirupati.

Similarly, he sought the Defence Ministry's intervention to develop a common storage policy for ammunition. As the current defence manufacturing regulations require large land banks, at least 1,000 acres per project, the TDP supremo called for a structured common storage area framework for enabling efficient land usage. (PTI)

Tripura's rare Bostami turtles facing extinction, govt launches study

AGARTALA, May 25: The softshell Bostami turtles, an endangered species found in a lake surrounding the Tripureswari Temple in Tripura's Gomati district, are facing extinction, officials said.

The International Union for Conservation of Nature (IUCN) had classified the specimen as extinct in the wild, they said.

The 15th-century temple, constructed by King Dhanyamanikya in Udaipur, around 55 km from Agartala, is considered to be one of the holiest Hindu shrines in the country, and it is among the 51 'Shakti Peeths'

It is also known as 'Kurma Pitha' as the temple premises resemble 'Kurma' or turtle.

The state government has sanctioned funds for a year-long study on Bostami turtles to be conducted by the Turtle Survival Alliance Foundation.

Gomati District Magistrate Tarit Kanti Chakma said the study is a priority for both the forest department and the district administra-

District Forest Officer (DFO) H Vignesh said a meeting in this connection was held recently between the DM and forest officials.

"A comprehensive study will be undertaken by the Turtle Survival Alliance Foundation, an Uttar Pradesh-based organisation, to determine the current population and its problems. Hatching generally occurs with the onset of monsoon. Accurate population data is lacking due to the absence of scientific studies," Vignesh told PTI.

These turtles are considered a living relic of biodiversity and have symbolic significance in reli-

Spread over 6.4 acres, the Kalyan Sagar Lake had been a natural habitat of the turtles. However, around two decades ago, the temple committee cemented the banks of the lake, which led to the death of several turtles, officials of the state fisheries department said.

According to experts, the construction of the embankments increased the mortality of the turtles, disrupting their natural habitat and places for laying eggs.

"As an amphibian, it is extremely essential for the turtle to have sandy exposure, which is not available in the lake after the construction of walls around the waterbody," said Mrinal Kanti Dutta, a former professor of Central Fisheries College in Lembucherra.

Jyoti Prakash Roy Chowdhury, an environmentalist and former member of the state's Wildlife Board, said the turtles faced problems basking on the banks, as the embankments were cemented.

"One side of the embankment

near the lake acquired so that the turtles could comfortably lay eggs," Roy Chowdhury told PTI.

Sources in the fisheries department said shifting of the animals from the pond is impossible due to the religious beliefs of the locals.

A population of these turtles was identified in the 'kachapukuri' (pond) on Nilachal hill, next to the Kamakhya temple in Guwahati, Roy Chowdhury said.

These turtles were traditionally believed to be nearly extinct and only available in a pond of the shrine of Hazrat Bayezid Bostami in Chittagong, where there are around 150 of them.

"It has been found that at least one wild population still exists in the Jia Bhoroli River, a tributary of the Brahmaputra in Assam," Roy Chowdhury said. He also said that there may be some genetic problems, as breeding is taking place within a small community in lakes or ponds. "Therefore, exchange of population and breeding among the new communities is needed to avoid any ge-

Nagaland seeks policy reforms in PMMSY guidelines

DIMAPUR, May 25: The Nagaland government has sought policy reforms in Pradhan Mantri Matsya Sampada Yojana (PMMSY) guidelines, saying the current funding of ₹ 8.40 lakh per hectare under PMMSY is outdated and insufficient compared to the latest Nagaland public works department schedule of rates pegged at ₹ 25 lakh per hectare.

Attending the fisheries secretaries conference 2025 and national workshop on harnessing technology and innovation in aquaculture in New Delhi on Friday, Nagaland commissioner and secretary for law & justice, fisheries & aquatic resources Y Kikheto Sema raised key concerns and recommendations to be addressed in the upcoming guidelines of the PMMSY, an official statement said on Satuday. Speaking on issues specific to the north eastern region and Nagaland.

he called for urgent revision of cost norms. Highlighting the region's vulnerability to natural disasters like landslides and floods, Sema advocated reintroduction of provisions for the renovation and reclamation of old ponds and water bodies, which were part of earlier schemes but are missing under the current PMMSY framework.

He urged the Union government to adopt an integrated cluster approach for agricultural and allied sectors to improve productivity, marketability, and promote agro-aqua-eco-tourism in rural areas. He also stressed the need to include administrative and contingency costs for effective monitoring, a feature common in other central flagship programmes but currently lacking in PMMSY.

A major point of contention raised was the funding pattern under the scheme. With the existing 60:40 ratio (central:state), many small and marginal fish farmers in the region are unable to contribute their share. Sema proposed a more viable model of 90:10 or 80:20, as applied in

other schemes for the Northeast and hilly states. Calling attention to infrastructure, he requested setting up of a modern fish market in Dimapur, equipped with hygienic and state-of-the-art fa-

cilities, citing the current markets' unorganised and unhygienic conditions. Sema appealed to the Centre to direct banks and financial institutions to actively support farmers, entrepreneurs, and cooperatives under PMMSY, noting hesitation from banks to finance fishery-based ini-Responding to the submissions, Union secretary for fisheries Abhilash

IMPHAL, May 25: The Manipuri Students' Federation (MSF) organized a 'human chain' protest along National Highway 150 (Tiddim Road) on Saturday under the banner "ManipurMuthatpaYaroi" (Do Not Obliterate Manipur).

The protest, aimed at demonstrating unity and resistance against perceived threats to Manipur's identity, saw participation from students of various educational institutions, local residents, and youths. The 'human chain' stretched approximately 3.5 kilometers, from ChangangeiUcheckon near Bir Tikendrajit International Airport to Kwakeithel, along NH-150 (Tiddim Road) in Imphal West district.

Organizers described the protest as a peaceful assertion of the people's commitment to safeguarding Manipur's cultural and political identity.

Speaking to media at the protest site, AMUCO general secretary PratabLeishangthem referred to a recent incident of the reported directive by security forces to a Manipur State Transport (MST) bus to remove the word "Manipur" from its signage while ferrying a media team to Ukhrul for the inauguration of the 5th Shirui Lily Festival on May 20 at Guwaltabi.

'We should not solely blame the central forces involved in the Guwaltabi incident. The real accountability lies with the higher authorities namely the Governor, the Chief Secretary, the Security Advisor, and the Director General of Police. Their resignations are essential to de-escalate the growing tension, and the Central government must recognize the gravity of the matter,"Pratab asserted.

MSF president Hijam Roshan alleged that the cen-



tral government was attempting to implement divisive policies aimed at sowing discord among Manipur's communities. "The students of Manipur will take various initiatives to protect our state. The May 20 incident, where central forces allegedly ordered the removal of 'Manipur' from an MST bus signage, is an

example of this divisive policy aimed at obliterating Manipur," he said.

In response to the incident, the Coordinating Committee on Manipur Integrity (COCOMI), an apex civil society body, had called a 48-hour general strike that paralyzed normal life in Imphal East, Imphal West, Thoubal, and Kakching districts. The COCOMI demanded an official apology from the Governor and the resignation of the Security Advisor, the Chief Secretary, and the Director General of Police, holding them responsible for the controversy.

Pratab further noted that various civil and local bodies have since organized multiple forms of protest, including torch rallies and 'human chains'. He called on the central government to abandon divisive strategies that risk creating communal enmity. (NNN)

When Manoj Kumar stepped in to save 'Lag Ja Gale' from rejection

NEW DELHI, May 25: "Lag Ja Gale", that plaintive ode to love sung by Lata Mangeshkar in the 1964 classic "Woh Kaun Thi", almost didn't see the light of day. Quite simply, director Raj Khosla didn't like the track and it took composer Madan Mohan to first convince the film's star Manoj Kumar who then persuaded the filmmaker that

the song was finally included. Once he heard the song again, Khosla picked up his shoe to hit himself, according to "Raj Khosla: The Authorized Biography", released on May 20 ahead of the filmmaker's 100th birth anniversary on May 31.

"I got a call from Madan Mohan one day. 'Raj Khosla has lost his mind,' Madan said. 'Ek gaana sunaya. Usko pasand nahi aaya. You come and handle this please," the book quotes Kumar as saying.

However, Kumar, who hadn't heard the song yet, was reluctant to intervene, reasoning that it was ultimately "Khosla's film", and opted to speak with producer N N Sippy about the

matter. "There were only a few days left for the shoot and the song was yet to be finalized. What was to be done? Sippy concurred with the music director. He, too, wanted Manoj Kumar to approach Raj Khosla and sort this out," recounts the book by author Amborish Roy-

choudhury in association with Khosla's daughters Anita Khosla and Uma Khosla Kapur. Kumar agreed to intervene when the composer played the song for him.

Kumar, on whom the song was eventually picturised alongside actor Sadhana Shivdasani, described the piece of music as a "brilliant composition" and was amazed that Khosla who joined the film industry with the dream of becoming a playback singer and someone with keen appreciation of good music didn't like the song, the book reads.

The soul-stirring melody, as noted in the book and explained by music composer Sanjeev Kohli, Mohan's son, was a particularly challenging piece to exe-



cute, even for the legendary Mangeshkar due to the intricate 'murkis' and nuanced variations incorporated by both Mohan and Lata herself, which demanded exceptional vocal finesse.

Gukesh is confident of meeting expectations

STAVANGER (NORWAY), May 25: Star Indian chess player D Gukesh is embracing the "new level" of competition where he is confident of handling the challenges and "meeting the expectations". Gukesh became the youngest chess world champion when he defeated Ding Liren of China last year in Singapore at just 18 years of age.

Set to compete in the elite Norway Chess tournament beginning on Monday, the Chennai youngster said the only thing he needed to gain more success was to keep random thoughts at bay and just concentrate on the game.

"It is a new level (for me). But when I see it as a challenge to prove to myself that I can handle this, even though the expectations are high, I can meet them if I keep working hard and doing my best, said the Indian Grandmaster.

He said that playing five hours of classical chess can make one's mind wander, but the key to winning those tiring games is to not lose focus. "In a classical game, you end up playing five hours and those are the times you cannot fully be thinking about the game. I think there are random thoughts that come to our mind but the important thing is to stay in the game and come back to those thoughts

"This is the purpose of the note that you're making. And you can't afford to allow weak moments," said Gukesh, who along with Arjun Erigaisi will compete against the likes of world No.1 Magnus Carlsen and No.2 Hikaru Nakamura in the USD USD 1,62,681 tournament, once termed as "the Wimbledon of Chess" by the legendary Garry Kasparov.

The 12-day tournament, which concludes on June 6, will see Gukesh compete against Carlsen in his own backyard, which will be the highlight of the event given that the Indian is the world champion and the Norwegian is the world No. 1.

This will be the first time since being crowned world champion that the 18-year-old will face off against Carlsen in the classical for-

AHMEDABAD, May 25: Gujarat Titans' hopes of a top-two finish in the IPL suffered a massive dent when they went down by 83 runs to Chennai Super Kings, who were powered by fifty-makers Devon Conway and Dewald Brevis, here Sunday.

The Titans have 18 points after a full set of 14 league matches and are still on top of the table despite the Net Run Rate taking a nose dive after this big defeat.

To maintain their position inside the top two, GT now require Royal Challengers Bengaluru (17 points) to go down to Lucknow Super Giants in their final league match. It's important because either Mumbai Indians (16) or Punjab Kings (17 points) will overtake GT with a win from their face-off.

Cutting back to the match, once asked to chase a stiff 231, the Titans floundered badly losing inform skipper Shubman Gill, Jos Buttler and Sherfane Rutherford in the Power Play passage itself with just 35 runs on the board.

The Gujarat side was bowled out for 147 in 18.3 overs.

Pacer Anshul Kamboj did the early damage, claiming the wickets of Gill and Rutherford.

Sai Sudharsan (41, 28b), the latest entrant into the India Test squad, and his Tamil Nadu teammate M Shahrukh Khan (19) added 55 runs for the fourth wicket to infuse some interest into the chase.

But left-arm spinner Ravindra Jadeja returned for his second spell to dismiss both Sudharsan and Shahrukh in the space of four balls in the 11th over, and the match effectively ended at that point. CSK finished their IPL 2025 engagements at the bottom of the pile with eight points from 14 matches, the five-time champions' worst ever finish in the 10team league.

It will be a challenge for Gill to lead India in England, says Pujara



NEW DELHI, May 25: Test veteran Cheteshwar Pujara on Sunday said it will be a challenge for a youngster like Shubman Gill to captain India in tough conditions in England but a big opportunity and confidence booster for him if he achieves success as a leader in the marquee series.

Gill was named new Test captain on Saturday, succeeding Rohit Sharma. The move officially began a new era in the Indian red-ball setup after the shock retirements of Rohit and Virat Kohli.

Rohit and Kohli announced their Test retirements within a span of one week this month.

"When you go abroad as a captain, whether you are young or matured, it will be challenging. To start off in England, it won't be easy for Shubman but it's a great opportunity for a young player. If he leads well in England it will boost his confidence.

"The reason he has been given the responsibility ahead of Jasprit Bumrah is because we are hearing that Bumrah will not be able to play all five Test matches," Pujara said on Sunday during an online interaction organised by Sony Sports network, the official broadcaster of India's tour of England.

"So if Shubman has been given the responsibility, the team management and selectors are thinking that he could lead the team for a

The 37-year-old Pujara, who is yet to announce Test retirement after last playing for India in June 2023, advised Gill to keep captaincy and his batting separate.

"There is also a lot of responsibility on him as a batter but I'm sure the kind of talent he has he will be successful in England. It will definitely motivate him to perform well. I don't know whether being a captain it will bring the best out of him but as a batter he has always tried to perform well for the team.

"When you are playing as a batter at the highest level you never think about whether you are a captain or a player, you always want to do well for the team."

"You need to keep it separate, when you are batting in the middle, you need to think as batter rather than thinking about captaincy," Puiara said.

Pujara, who has scored 7195 runs from 103 Tests after making India debut in 2010, feels the captaincy responsibility won't affect Gill's batting approach, which is aggressive.

'I don't think his batting approach will change, he has to bat the way he bats. He is an aggressive player, he likes to play his shots and he has to continue playing his shots but at the same time he needs to understand the English conditions and figure out who is the right bowler to take on," he

Pujara also justified the reason behind naming Rishabh Pant as vice-captain for the England tour despite the wicketkeeper-batter's poor form of late.

"Bumrah is out of contention for captain or vice-captain's role and that's the reason Pant has been

LUCKNOW, May 25: Royal Challengers Bengaluru have got a massive boost ahead of the Indian Premier League playoffs with Australia fast bowler Josh Hazlewood rejoining the side two days before their final league match here on Tuesday.

Hazlewood had returned home during the one-week break due to the suspension of the IPL in the wake of India-Pakistan military conflict and was also dealing with a shoulder niggle from which the right-arm pacer has recovered.

'It's obviously great to be back. A couple of weeks at home, (I) made the most of the last (as I) went up to Brisbane and bowled quite a few overs,' Hazlewood said in a video posted by RCB on Sunday.

"Everything has been good Hopefully to get the ball rolling again and, yeah, look forward to tomorrow and start the practice," he added.

The 34-year-old was training in Brisbane as a part of Australia's preparations for the World Test Championship final against South Africa next month and was being monitored by Cricket Australia's medical team.

The RCB camp was closely Hazlewood's progress. He has been RCB's best bowler in this IPL with 18 wickets in 10 matches and is fourth-highest currently wicket-taker in the competi-

Already qualified for the play-offs, RĈB face Lucknow Super Giants in their last IPL league match here on Tuesday.

RCB will depend on other results for a top-two finish after losing their last match against Sunrisers Hyderabad by 42 runs.

In fact, a win by a narrow margin for PBKS over Mumbai Indians on Monday would keep RCB ahead but in case of a defeat to LSG, the Rajat Patidar-led side would have to go through the Eliminator again. (PTI)

Winning or losing not in our hands, everyone gave their best: DC **B** batter Sameer Rizvi



JAIPUR, May 25: Delhi Capitals batter Sameer Rizvi, who struck a high quality half-century against Punjab Kings, feels that everyone in his side gave their best performance in the IPL even though they couldn't

make it to the playoffs. The 21-year-old Rizvi struck 58 not out off 25 balls, which included five sixes and three fours, for his maiden half-century as DC chased down the target of 207 with three balls to spare and by six wickets on Saturday. "Winning or losing isn't in our hands. What is in our hands is playing good cricket. Everyone gave their best throughout the tournament. We couldn't make it to the playoffs, but overall, the team put in a strong effort," Rizvi said in the post-match press conference.

DC will end at fifth place with seven wins, six losses and one no result. They had begun the season brightly with four wins on the trot only to fizzle out in the later stages.

Asked about his maiden IPL fifty, Rizvi said, "I felt very relaxed. The things I used to think about -- what I need to do, how I need to play -- I was finally able to execute them in this match.

"I feel really good about how I played, because this is exactly what I aspire to do." Rizvi said he took some time to settle down before playing his shots.

"When I came in to bat, the required rate was high. My approach was to take three or four balls to settle in and then start attacking. Karun

Nair, on the other hand, smashed four boundaries in an over, which eased the pressure on me and allowed me to take my time."

Nair, who on Saturday made a return to the Indian Test team after eight long years, made 44 off 27 balls. "We have to maintain a winning mindset in the IPL. Last year, even 260 was chaseable, so on a flat wicket, 200 or 220 is definitely chaseable. You have to stay positive when you're chasing. I was confident because it was a good wicket and I backed myself to play my shots," Rizvi added.

Punjab Kings have already made it to the IPL play-offs but their spin bowling coach Sunil Joshi felt his side needs consistency in the middle overs. "Overall, we were a bit inconsistent in the middle overs. That is something which we need to go back to the drawing room (board) and address that we have been bowling really well in the middle overs, with high dot-ball percentage," he said. "That is something which we have done well. And, again, (Harpreet) Brar has come back very well." Srikanth's inspired Malaysia run ends with defeat in final

KUALA LUMPUR, May 25: His long title drought did not end but shuttler Kidambi Srikanth capped a remarkable campaign with a runner-up finish at the Malaysia Masters Super here on Sunday, going down in straight games to China's world No. 4 Li Shi Feng in the men's singles final.

The 32-year-old, who charted a long road back from injuries and missed opportunities, made his first BWF World Tour final in six years, starting from the qualifiers and riding a resurgent wave all the way to the title clash of the BWF 500 tournament.

The former world No. 1 was erratic and struggled to break through the second-seeded Li's solid defence and was unable to convert openings, eventually losing in 11-21 9-21 in 36 minutes.

"It has been pretty good week. It's my third tournament, played decently well in the first two as well but couldn't really win those matches. But pretty happy with the way how it went so far. Not exactly the way I wanted to be today but still I think he played really well," Srikanth said.

"I'm just very happy to be back playing again. I just want to keep myself happy. There was a point in my career where I was pretty used to being standing there and then it's been a while. So to be back again on the podium really feels special."

Despite the loss, it was an inspirational show from Srikanth, who, after slipping to world No. 82 earlier this month, showed grit and class to remind the world of his

Srikanth was error-prone in the

early exchanges, gifting away points that allowed Li Shi Feng to pull ahead 6-3. A straight smash to the Indian's backhand took Li to 8-5, and al-

> though Srikanth replied with a 402kph thunderbolt, a netted smash gave the Chinese a fivepoint cushion going into the midgame interval. Unforced errors continued to

> hurt Srikanth. Two loose shots went long, and Li responded with a precise crosscourt winner to make it 14-8.

> Srikanth showed glimpses of brilliance with a net kill and a swift forehand cross to trail 10-16, but couldn't string together momentum. A 22-shot rally at 10-17 ended with Srikanth pushing the shuttle long, and Li closed out the opening game in just 16 minutes with con-

secutive down-the-line smashes. In the second game, Srikanth played better but his inconsistency persisted. Despite engaging in tight

rallies, he often went wide or long,

while Li dictated the tempo, hitting anything that his opponent lifted in A powerful crosscourt smash

helped Li go into the interval leading 11-5, leaving the Indian a mountain to climb. Srikanth did craft a beautiful re-

verse drop after a grueling 46-shot rally at 5-12, and produced an elegant crosscourt winner at 8-18. But such moments were few.

Li stepped on the gas, scoring on both flanks to reach 18-7. A sharp net interception brought the Chinese within two points, and backto-back smashes sealed his victory and the title. (PTI)

Was eagerly awaiting the call, says Karun Nair after India comeback

JAIPUR, MAY 25: Senior batter Karun Nair feels "proud and fortunate" at his return to the Indian Test team after a long gap of eight years and says he was "awaiting this call" having done well in the last 12-16 months in domestic circuit.

The 33-year-old Nair was on Saturday named in the 18-member Indian squad for the five-match Test tour of England beginning June 20 after scoring big runs in the 2004-05 season. He last played for India in

"Really happy and proud. Have been batting well in the last 12-16 months. It's about keeping my processes the same and do the same things that have worked for me," Nair said after his side Delhi Capitals beat Punjab Kings by six wickets in an IPL match here Saturday night. Nair was dropped from the national team in 2017 soon after becoming India's second triple centurion in Tests

"Grateful to get back, happy and proud and fortunate. Found out like all of you found out (about his selection). Was eagerly awaiting the call, got a lot of messages from close ones," the right-handed batter said.

His performances were instrumental in Vidarbha winning the Ranji Trophy in the 2024-25 season. In the Ranji Trophy, he plundered 863 runs in nine matches with four centuries, while in the Vijay Hazare Trophy, he amassed 779 runs in just eight innings, including five centuries, performances that paved the way for his return to the Indian

Speaking about Saturday's victory which helped Delhi Capitals finish the season on a high note after failing to qualify for the play-offs, Nair said the result showed that they were a good team. "Feels amazing, we truly deserve this. Haven't been at our best. But tonight shows we're a good team that had bad games," he said. While young Sameer Rizvi won the Man-of-the-Match award for his maiden IPL fifty, Nair chipped in with an invaluable 44-run knock off 27 balls to keep DC in the game in the middle overs. "I've been hitting the ball really well, came into the tournament with a lot of runs. Confidence was high. I was playing too many shots too early, coaches told me to take my time and then go big," Nair said. (PTI)

Srikanth's Malaysia run shows he belongs at the top tired or not.

NEW DELHI, May 25: There's a strange serenity in watching Kidambi Srikanth play when he's in the zone. For much of the last few vears, that version of Srikanth felt like a thing of the past. In Malaysia, it made a compelling return.

The former world number one might not have won the title but his march to the final of the Malaysia Masters -- a BWF World Tour event -- his first such final in six years is not just personal redemption but a reminder to what persistence and discipline can deliver.

'Srikanth is a player who should be in the top," said coach RMV Gurusaidutt. "As soon as possible, he should be in this circuit. That will be our primary target as a team. Be back in the top 20 and play in the big

Srikanth's racquet skills were never in doubt. His 2017 runófour Superseries titles in a yearówas historic. He added a World Championship silver in 2021 and led India to their maiden Thomas Cup triumph in 2022, winning all six matches. But consistency deserted him. His style had become predictable ó explosive at the start, but often rushed and unsustainable over longer rallies as he failed to close out matches from winning positions.

His struggles saw him slip in rankings -- he went as low as world number 82 early this month.

"When we started in late 2023, I felt he was at a very bad fitness level. It's quite surprising. And I just told him, point blank that, you focus

on getting better with your fitness," recalls coach Parupalli Kashyap. In recent years, chronic in-

juriesóshoulder, knee, adductor, Achillesóhampered his training. At one point, he could only manage shadow practice and underarm strokes. "The shoulder issue has been there for a very long time. It is very on and off," Guru said, adding that there were also knee and achilles concerns due to load man-

Still, Srikanth didn't shut down. "He has not sat down for 3-4 or 5 weeks this year. He was able to play and train, though he wasn't getting entries into the bigger events."

But the real change came in his mindset. Over the past four months, Srikanth showed up every day ó "Morning sessions, evening gym,

cardio ó he was there. That's the improvement we wanted,î Guru said. "And imagine ó in the third week

of back-to-back tournaments, he delivers this kind of performance. That speaks of the fitness and the discipline. What stood out in Malaysia was the subtle transformation in his playing style. The outright attackheavy game has evolved into an allround, balanced approach.

"This tournament, he was actually playing an all-round game. It was not just attackóit was about constructive rallies and holding on. That kind of game creates pressure on the opponent,î said the 2014 Commonwealth Games bronze medallist. (PTI)
