## Misri pins Trump claim on ceasefire decision

NEW DELHI, May 19: Foreign Secretary Vikram Misri told a parliamentary committee on Monday that the conflict between India and Pakistan was always in the conventional domain, and there was no nuclear signalling by the neighbouring country, sources said.

The sources said Misri reiterated the government's stand that the decision to stop military actions was taken at a bilateral level, as some opposition members questioned US President Donald Trump's repeated assertions about his administration's role in stopping the conflict.

Some MPs, the sources said, asked if Pakistan used Chinese platforms in the conflict. Misri said it did not matter as India hammered Pakistani air bases. When an

opposition member asked about Trump's several social media posts eyeing "centre-stage" after India and Pakistan decided to stop hostilities, the foreign secretary quipped that the US president did

not take his permission to do so. The committee members also unanimously condemned the trolling of Misri following the

## **Current tensions between India and Pak soared** because of Pahalgam terror attack: Indian envoy

MOSCOW, May 19: The tensions between India and Pakistan soared because of the Pahalgam terror attack, where tourists were shot at point-blank range after their religious affiliation was established, Indian envoy to Russia Vinay Kumar has said, asserting that India had to react to this.

In an interview with the 'Izvestia' daily published on Monday, Kumar also said that India will support an increase in imports of Russian oil to its market.

"First of all, the current tension arose due to the terrorist attack in Pahalgam, where tourists were shot at point-blank range after their religious affiliation was established. Therefore, India had to react to this," Kumar said while responding to a question. "And the ceasefire was the result of India's reaction to the escalation started by Pakistan. It was reached on a bilateral basis when the head of the General Staff of Operations of the Pakistani army called his Indian counterpart," he said.

India carried out precision strikes under 'Operation Sindoor' on terror infrastructure in Pakistan and Pakistan-occupied Kashmir early



on May 7 in response to the April 22 Pahalgam terror attack that killed 26 people.

Following the Indian action, Pakistan attempted to attack Indian military bases on May 8, 9 and 10. The Indian forces launched a fierce counter-attack on several Pakistani military installations. India and Pakistan reached an understanding on May 10 to end the conflict after four days of intense crossborder drone and missile strikes.

US President Donald Trump, in a post on social media, claimed that the US brokered the ceasefire between the two countries.

A section of Russian social media had expressed surprise that New Delhi ignored Moscow and preferred Washington's mediation. Kumar said it was Islamabad's initiative. "But India has consistently maintained a policy that Kashmir is a bilateral issue, with no third-party mediation envisaged. That position remains in place," he asserted.

He recalled that several world leaders, including Russian President Vladimir Putin and Foreign Minister Sergei Lavrov, spoke to their Indian counterparts after the Pahalgam attack.

Responding to a question about the future of Indo-Russian defence cooperation, Kumar expressed confidence that it will further develop. "This has been the case for decades. And lately our relationship has even deepened. We not only buy and sell military equipment, but also engage in the joint development and production of defence products," he said. "Indian-made equipment, including Brah-

Mos, has repeatedly proved its effectiveness, including in the period from May 7 to May 10. Therefore, I believe (CONTD. ON PAGE-2)



DIBRUGARH, May 19: Former AASU general secretary Sankar Jyoti Baruah was arrested on Monday for allegedly assaulting petrol pump workers in Assam's Dibrugarh district, police said.

Last year, Baruah had resigned as the general secretary of the All Assam Students' Union (AASU), amid controversy surrounding his personal life and allegations of sexual harassment of a law student. ### 71 'anti-nationals' arrested in Assam

GUWAHATI, May 19: A research team of Indian Institute of Technology Guwahati has developed a highly responsive fluorescent sensor that can detect cyanide in water and human cells using only a UV light source, an official statement said on Monday

The developed sensor changes colour and emits bright fluorescence in the presence of cyanide, contributing to both environmental safety and forensic investigations, the IIT Guwahati statement said. Cyanide is a highly toxic compound widely used in industrial processes, such as manufacturing of synthetic fibres, metal cleaning, plastics, electroplating and gold mining.

Improper disposal of cyanide often leads to its release into the environment, contaminating soil and water sources, and consumption of this contaminated water can disrupt oxygen supply in human body. Even a small amount can cause severe health effects or death. Therefore, there is a need to develop sensors that can detect even trace amounts of cyanide in various

materials, the statement said. Fluorescent chemosensors are chemicals that light up under light when they in-

teract with specific chemicals. These sensors are popular due to their ease of use, low cost, high sensitivity and potential for use in biological systems.

While many existing sensors work by dimming their light (known as a "turn-off" response) when detecting substances, a "turn-on" response — where the signal brightens instead — is often more effective because it avoids false negatives and improves detection clarity

The IIT Guwahati research team, led by Prof G Krishnamoorthy of Department of Chemistry, has developed a "turn-on" chemosensor based on a compound called 2-(4'-diethylamino-2'-hydroxyphenyl)-

1H-imidazo-[4,5-b]pyridine, which gives a weak blue fluorescence under UV light, the statement said.

In the presence of cyanide, this fluorescence turns on and shifts to a brighter cyan colour due to a chemical change in the molecule.

This reaction is highly specific to cyanide, especially in a carefully selected solvent system that includes water.

The research team conducted a combination of lab experiments and advanced computational calculations, called DFT calculations, to confirm the sensing mechanism of the developed technology.

"What sets this sensor apart is its versatility. The sensor works not only in lab solutions but also in river and tap water samples, with an accuracy of 75-93 per cent. It can be embedded into paper strips for portable testing and is effective in live cell imaging. In fact, the sensor was used to detect cyanide inside biological cells,

showing promise for applications in environmental and forensic investigations,' Prof Krishnamoorthy said. The researchers also demonstrated that

this molecular sensor can function like a basic logic gate, (CONTD. ON PAGE-2)

The Department of State is "taking steps today to impose visa restrictions on owners, executives, and senior officials of travel agencies based and operating in India for knowingly facilitating illegal immigration to the United States", it said.

The statement added that the US will "continue to take steps to impose visa restrictions against owners, executives, and senior officials of travel agencies to cut off alien smuggling networks".

"Our immigration policy aims not only



to inform foreign nationals about the dan gers of illegal immigration to the United States but also to hold accountable individuals who violate our laws, including facilitators of illegal immigration," the State Department said, adding that enforcing US immigration laws and policies is critical to upholding the rule of law and protecting Americans.

It said this visa restriction policy is global and even applies to individuals who otherwise qualify for the Visa Waiver Programme. (PTI)

GUWAHATI, May 19: Three more people have been apprehended in Assam for allegedly being involved in "anti-national" activities, following the Pahalgam terror attack, taking the total number of such arrests to 71 so far, Chief Minister Himanta Biswa Sarma said on Monday.

In a post on X, Sarma said one person each was arrested from Kokrajhar, Goalpara and South Salmara-Mankachar districts. "71 Anti-Nationals are now behind bars! @assampolice is strictly monitoring the digital space," he added.

Earlier, opposition AIUDF MLA Aminul Islam was arrested on sedition charges for allegedly "defending" Pakistan and its complicity in the Pahalgam terror attack.

After getting bail in the case, Islam was detained under the National Security Act (NSA). Sarma had, on May 2, threatened to take stringent action against those who raised the 'Pakistan zindabad' slogan in the aftermath of the Jammu and Kashmir terror attack last month. (PTI)

HT Correspondent JORHAT, May 19: A total of 24 victims of human trafficking under the jurisdiction of Mariani Police Station in the Titabar sub-division of Jorhat district were rescued in two batches from Arunachal Pradesh and reunited with their families by the Jorhat district police in the past few days, an official said.

The victims, all from tea garden areas, were reportedly lured in April with promises of work in Tezpur, but were instead taken to Arunachal Pradesh after being drugged.

They were rescued from Rupa in the West Kameng district of Arunachal Pradesh on May 15 and 17, respectively, and brought to the Deberapar Police Outpost.

NEW DELHI, May 19: Government is considering amendments to the laws governing the nuclear power domain, including the sectoral regulator, to allow participation of private sector as India eyes to produce 100 GW atomic energy by 2047.

Government sources said amendments were being considered to the Atomic Energy Act to allow private sector participation and the Civil Liability for Nuclear Damage Act to limit the liability on suppliers of equipment to build atomic energy plants.

The government is also considering regulatory reforms and is evaluating the model of Indian National Space Promotion and Authorization Center (INSPACe) which acts as the promoter and regulator for the space sector that

was opened up for private participation in 2020

Finance Minister Nirmala Sitharaman announced opening up of the nuclear power sector which has been restricted to public sector companies. The Nuclear Power Corporation of India Limited operates atomic power plants across the country that contribute 8.7 GWe to the country's energy mix. Sitharaman also announced the

Nuclear Energy Mission for research and development of Small Modular Reactors (SMR) with an outlay of Rs 20,000 crore and to operationalise five indigenously

developed SMRs by 2033. The Department of Atomic Energy officials has recently said that the Nuclear Energy Mission aims to leverage private sector participation, streamline regulatory

frameworks, and scale up nuclear power production to meet India's increasing energy demands.

Foreign nuclear power firms had evinced interest in setting up atomic power plants in India after it secured a waiver from the Nuclear Suppliers Group to engage in global nuclear trade. The NSG waiver came after the landmark India-US civil nuclear deal of 2008.

However, the Civil Liability for Nuclear Damage Act of 2010 proved to be an impediment for private sector participation. The private sector termed certain provisions of the law were unacceptable and contradicted the international Convention for Supplementary Compensation for Nuclear Damage (CSC). The government (CONTD. ## People facing 'double attack' of 'skyrocketing inflation', rising taxes, says Congress

NEW DELHI, May 19: The Congress on Monday alleged people were facing the "double attack" of "skyrocketing inflation" and rising taxes, and asked the Narendra Modi-led government to answer how the common people would survive its impact.

Congress general secretary incharge communications Jairam Ramesh shared on X a media report that claimed the burden of taxation on people had been rising.

"Under the self-proclaimed double-engine government, the people of India are facing a double attack of skyrocketing inflation and rising taxes. Inflation and tax burden have increased continuously in the last 10 years," Ramesh said in a post in Hindi on X.

He claimed expenditure on medical and education had risen 12-15 per cent every year.

"School fees, books, uniforms -- everything has become expensive. Banks are charging fees even for small services. There is a tax on car, net banking, even FASTag and GST on essential items like milk, curd and flour!" he said.

Ramesh said incomes had not increased but taxes and expenditure had broken the backs of the people.

"The Modi government should answer how will the common people survive this tax loot and rampant inflation?" Ramesh asked.

The Congress has been attacking the government over its handling of the economy, claiming the issues of rising prices, decreasing private investment, and stagnating wages were hitting the common people hard. (PTI)

an independent group of scientists and communicators based in the US, said the number of such days had doubled in 90 per cent of countries and territories. As part of the study, researchers analysed daily temperatures from 2020 to 2024 in 247 countries and territories, and 940 cities, to determine the rise in "pregnancy heat-risk days" -- extremely hot days associated with higher risks of preterm birth and maternal health complications. India experienced an average of

days each year during this period,

Climate change accounted for nearly a third of the average annual number of pregnancy heat-risk days in India during 2020-2024, adding six out of a total of 19 days, the researchers said in the study. Sikkim reported the highest number of pregnancy heat-risk days attributed to climate change, with 32. Goa and Kerala recorded 24 and 18 additional days, respectively. Among the cities analysed, Panaji experienced the highest av-

The largest increases were observed in regions with limited access to health care, including the Caribbean, central and South America, the Pacific Islands, southeast Asia and sub-Saharan Africa. Research links high temperatures during pregnancy to increased risks of complications such as hypertension, gestational diabetes, hospitalisation, severe maternal morbidity, stillbirth and pre-term birth, which can lead to lifelong health impacts for children.

## Stock markets close lower for 2<sup>nd</sup> day; IT stocks fall after US rating downgrade

BSE Sensex dropped by 271 points on Monday, marking the second straight day of losses due to selling in IT and banking stocks and a weak trend in global markets after rating downgrade of the US by Moody's Ratings.

The 30-share BSE barometer declined 271.17 points or 0.33 per cent to settle at \$2,059.42. During the day, it dropped 366.02 points or 0.44 per cent to a low of 81,964.57

The NSE Nifty dipped 74.35 points or 0.30 per cent to 24,945.45

Among Sensex firms, Eternal, Infosys, Tata Consultancy Services, Tech Mahindra, Reliance Industries. Asian Paints, HCL Tech and Adani Ports were the laggards. Power Grid, Bajaj Finance, NTPC, State Bank of India and IndusInd Bank were among the gainers. Among sectors, realty, pharma, and auto shares advanced while IT declined by over a percent.

### **Delhi Metro** ticketing goes live on Uber app

NEW DELHI, May 19: Ride-hailing platform Uber on Monday announced the rollout of metro ticketing on the Uber app, powered by the Open Network for Digital Commerce (ONDC), starting with Delhi Metro. Three more cities across India are slated to go live in 2025, Uber said, adding it will soon launch B2B Logistics via the ONDC network, a solution that will allow businesses to request on-demand logistics from Uber's delivery network, without needing their own fleet.

"Uber today announced the rollout of metro ticketing on the Uber app, powered by the Open Network for Digital Commerce (ONDC), with Delhi Metro going live as the first launch city. This marks Uber's first integration with India's pioneering digital public infrastructure and a major step forward in making public transport more connected," the company said in a release. This move follows an Memorandum of Understanding (MoU) signed in 2024 during Uber CEO Dara Khosrowshahi's visit to India, where Uber committed to collaborating with ONDC to advance the reach and impact of India's digital public goods.

## Rupee climbs 15 paise to settle at 85.42 against US dollar

MUMBAI, May 19: The rupee appreciated 15 paise to settle at 85.42 against the US dollar on Monday, on weak US dollar index and a decline in crude oil prices. Forex traders said global investors were also cautious as global rating agency Moody's downgraded US investment grade rating, leading to a fall in dollar index.

At the interbank foreign exchange, the domestic unit opened at 85.43 and moved between the intra-day high of 85.35 and the low of 85.61 against the greenback. The unit ended the session at 85.42, registering a gain of 15 paise over its previous closing level.

On Friday, the rupee pared its gains and settled 3 paise lower at 85.57 against the dollar.

"We expect the rupee to trade with a positive bias amid persistent weakness in US dollar index and a weak tone in global crude oil prices," Anuj Choudhary Research Analyst at Mirae Asset Sharekhan said, adding weak domestic equities capped a sharp upside.

"USD-INR spot price is expected to trade in a range of 85.10 to 85.65," he noted.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading lower by 0.86 per cent at 100.22.

The US dollar weakened as Moody's downgraded US credit rating to AA1 from AAA. Economic data from the US released on Friday too disappointed the markets, Choudhary said.

Brent crude, the global oil benchmark, fell 0.78 per

cent to USD 64.90 per barrel in futures trade.

Traders further noted that with Brent hovering around USD 65 per barrel, India, one of the world's largest oil importers, faces the dual challenge of a widening trade deficit and increased dollar demand -- factors that could further strain the rupee.

Dilip Parmar, Senior Research Analyst, HDFC Securities, said the rupee gained ground as the greenback softened against a spectrum of leading global currencies

"In the short run, the USD-INR spot rate is expected to find a support level at 85.25 and encounter resistance around 85.87," he added.

In the domestic equity market, the 30-share BSE Sensex declined 271.17 points, or 0.33 per cent, to close at 82,059.42, while the Nifty fell 75.35 points or 0.30 per cent to settle at 24,944.45.

Foreign institutional investors (FIIs) purchased equities worth ₹ 8,831.05 crore on a net basis on Friday, according to exchange data.

Meanwhile, India's forex reserves jumped by USD 4.553 billion to USD 690.617 billion during the week ended May 9 on the back of a steep increase in gold assets, the RBI said on Friday.

In the preceding week, the overall reserves had dropped by USD 2.065 billion to USD 686.064 billion. The forex reserves had touched an all-time high of USD 704.885 billion at end-September 2024. (PTI)

NEW DELHI, May 19: Realty firm AU Real Estate has acquired 446 flats in bulk through e-auction for ₹ 1,468 crore in a housing project at Noida being developed by state-owned NBCC Ltd and the company will sell these apartments in open market.

As per the direction of the Supreme Court, Amrapali Stalled Projects Investments Reconstruction Establishment (ASPIRE) was formed to complete the stuck projects of the erstwhile Amrapali Group through NBCC (India). The state-owned firm was asked to complete 38,000 flats and hand them over to homebuvers.

## Landmark life sentence delivered in Margherita for 2018 murder case



HT Correspondent MARGHERITA, May 19: In a historic first for the Margherita Sub-Divisional Magistrate Court, Monteswar Dohotia

#### was sentenced to life imprisonment on Monday for the brutal murder of his uncle, Bimal Dohotia, bringing closure to a seven-year-long legal battle.

The case, registered as Session Case No. 17(M)/2020 under Bordumsa Police Station Case No. 42/2018, stems from the 2018 killing of Bimal Dohotia in 1 No. Mohong Shantipur, under the juris-diction of Bordumsa Police Station in Margherita district.

Monteswar Dohotia, son of Phuleswar Dohotia, stood trial for the murder. His co-accused, Pabitra Doho-tia, son of Kulai Dohotia, remains absconding since the incident.

Presiding over the trial, Additional Sessions Judge (FTC-1) Anil Kumar Basfor convicted Monteswar under Sections 302/34 of the Indian Penal Code and awarded him a life sentence. This verdict marks the first-ever life imprisonment handed down by this court, setting a significant legal precedent in the region.

The ruling has brought much-needed relief to the bereaved family of Bimal Dohotia, who endured years of emotional and legal turmoil in their quest for justice

The local community has widely welcomed the judgment, viewing it as a strong deterrent against violent crimes and a reflection of the judiciary's firm commitment to justice.

## ₹1,000 cr invested in NE waterways in 2 yrs, equal amount in pipeline: Sonowal These efforts aim to boost cargo and passenger movement

GUWAHATI, May 19: More than ₹ 1,000 crore has been invested in the waterways in the Northeast in the last two years, while another ₹ 1,000 crore will be pumped in to boost the sector, Union minister Sarbananda Sonowal said on Monday

He said efforts were underway to boost cargo and passenger movement, improve last-mile connectivity and promote economic growth in the region.

The Union Minister of Ports, Shipping and Waterways was speaking after reviewing ongoing projects in Assam and other northeastern states with senior officials of the ministry, Inland Waterways Authority of India (IWAI), Public Works Department (PWD), Indian Port Rail and Ropeway Corporation Limited (IPRCL) and Cochin Shipyard Limited (CSL).

"In the last two years, more than ₹ 1,000 crore has been invested, with ₹ 300 crore worth of projects already completed... We are on track to complete the remaining ₹ 700 crore projects by the end of 2025," Sonowal said

Projects worth an additional ₹ 1,000 crore are on the anvil, targeted for completion by 2026, he said.

"These efforts aim to boost cargo and passenger movement, improve last-mile connectivity, promote economic growth in the Northeast, and align with the broader vision of 'Atmanirbhar Bharat' through sustainable and inclusive transport solutions," he added.

Sonowal said the Union government is actively developing key infrastructure projects along NW2 (Brahmaputra) and NW16 (Barak), including the construc-



tion of passenger vessels of various capacities, terminal facilities and capacityouilding initiatives.

He also reviewed progress on the proposed Inland Water Transport (IWT) project at Doyang Lake, and assessed the potential of Noune and Shilloi Lakes in Nagaland for water sports and tourism

Feasibility studies for IWT development on the Tiawng and Chhimtuipui rivers in Mizoram, as well as on Umiam Lake and the Ummgot River (NW106) in Meghalaya were also reviewed.

Speaking at the review meet, Sonowal said, "Since 2014, the Modi government has revived the once-neglected mode of water transport, especially through the Brahmaputra and Barak rivers. Schemes such as Jalvahak are encouraging businesses to adopt this economical, efficient, and eco-friendly mode, reducing pressure on road and rail, and positioning Assam as a key driver in India's journey towards a self-reliant economy by 2047.'

Reviewing multiple projects ranging from new infrastructure development for capacity enhancement on national waterways to scaling up skill development initiatives for youth of the region in the maritime sector, the Union minister emphasised the urgency and the need for optimum utilisation of funds.

To further enhance cruise tourism and cargo handling capacity across Brahmaputra and Barak rivers, over ₹ 1,500 crore has been earmarked for key projects scheduled to be completed by 2027-28. These include the construction of modern jetties equipped with onshore facilities at Silghat, Bishwanath Ghat, Neamati Ghat, and Guijan. Additionally, a new building for the

regional office of the Mercantile Marine Department will be constructed at Fancy Bazar in Guwahati.

Sonowal also noted progress on the proposed water metro services in Guwahati and Dibrugarh, among others, with a ₹ 315-crore investment and two electric catamarans being built by Cochin Shipyard Ltd.

A ₹ 100-crore cruise terminal in Guwahati and a Regional Centre of Excellence (RCoE) in Dibrugarh worth ₹ 120 crore are also in the pipeline.

On Barak River, Sonowal reaffirmed that survey and dredging equipment, and floating terminals at Karimganj and Badarpur projects reflect the government's commitment to making Northeast a hub of India's maritime future.

To ensure consistent navigability along the Brahmaputra, the Dredging Corporation of India (DCI) has been entrusted with maintaining a minimum assured draft of 2.5 metres from the India-Bangladesh border to Pandu under NW2 till 2026-27. For this effort, an additional ₹ 191 crore has been sanctioned. These measures are a part of the government's broader initiative to integrate Northeast into the country's maritime growth trajectory, Sonowal added. (PTI)

The 2012 incident had sparked widespread outrage and led to a prolonged trial that lasted 13 years.

The victim was subjected to severe physical torture and eventually set ablaze by a group of people in Jalha village in Charaideo on suspicion of practising witchcraft, police said. (PTI)

## Fissures deepen in APHLC as key grassroots leaders resign from Lumbajong Unit

Grassroots leaders resign citing factionalism and internal divisions

DIPHU, May 19: The All Party Hill Leaders Conference (APHLC) suffered yet another setback as several grassroots leaders from its Lumbajong Member of Autonomous Constituency Committee announced their resignation from the party.

The development was made public during a press conference held at Hotel Hempi, Diphu, on Monday, where the leaders voiced their frustrations over growing factionalism and internal disputes within the party ranks.

Kelvin Tokbi, who served as the Finance Secretary of the APHLC Youth Wing Central Committee, was among the leaders who addressed the media.

Speaking candidly about the disarray within the party, Tokbi said, "We are in a state of confusion. At present, there are three groups operating under the APHLC banner - the Rajen group, the Shersing group, and the J.I. Kathar group. It has become unclear to us whom we should follow or work with.

Tokbi highlighted a series of recent developments that have caused disillusionment among committed members. He noted that both the Rajen and J I Kathar factions have been inde-



pendently conducting meetings and public engagements, while instructions from one faction often directly contradict those from another.

Referring to a recent meeting at the residence of Rajen Timung, Tokbi revealed that attendees were specifically told not to participate in any meetings organized by the Shersing faction.

This kind of directive only proves that the APHLC is not aiming for electoral victory, but is instead on a path of self-destruction," he remarked.

He further alleged the presence of individuals within the party who are operating as BJP agents and accused the party leadership of pursuing divisive policies.

"Through this platform, we are announcing our decision to step away from the APHLC. We have worked tirelessly for the party since the beginning, with unwavering commitment, but the present circumstances have compelled us to take a break," Tokbi declared.

Echoing similar sentiments, Jonasing Ronghang, President of Ward No. 4 and the Police Reserve polling station, voiced his disappointment with the state of affairs within the party

"We have lost faith in the APHLC leadership due to the factionalism that has taken root," Ronghang said.

He elaborated that within the Lumbajong constituency alone, there are three competing groups, and that attending one group's meeting would result in backlash or exclusion from another.

"This is the reality of APHLC now. If we attend Shersing's meeting, Rajen refuses to work with us. If we go to a J.I. Kathar meeting, Rajen again stops us. In such an environment, it is impossible to function as a dedicated party worker," he explained, adding that these are the reasons behind his departure from the party.

The press conference also saw the presence of Rolison Phangcho, Assistant Secretary of the APHLC Lumbaong Central Committee, and Langkai Bey, Secretary of the Mijung Longki Teron polling station. Both leaders confirmed their resignation from the APHLC, marking a significant blow to the party's grassroots organizational strength in the Lumbajong area.

## Pope Leo XIV has his tasks cut out

The world's attention has been on the Vatican City in Rome for the past few days. The Catholics have made history with the election of Robert Francis Prevost, a 69-year-old American cardinal of Spanish descent. He has taken over as the 267th occupant of the throne of St. Peter. This momentous event, the first time an American has ascended to the papacy in the 2000-year history of the Catholic Church, is a significant milestone. The Pope is the leader of the Roman Catholic Church. He guides about 1.4 billion Catholics worldwide and is the head of Vatican City. Due to his position, the Pope is regarded as one of the world's most powerful people. He has extensive diplomatic, cultural, and spiritual influence. He is considered the successor of St. Peter, the first apostle. He is believed to have the highest teaching authority in faith and morals. What do the global Catholics want from a new pope? Pope Leo will lead a divided Catholic Church of 1.4 billion members, almost the size of India or China. These, such as divorce and remarriage, LGBTQ Catholics, the role of women, and climate change, are significant and will require careful consideration and action. The new Pope will exercise supreme power in faith, morals, church discipline, and government. He is expected to continue the reforms started by his predecessor, focus on poverty and marginalized people, and build a "bridge" between different groups within the Church. Many watched with interest when Pope Leo appeared on the Vatican balcony. In his first speech, Pontiff spoke to the crowd in Spanish, mentioning "his beloved Diocese of Chiclavo in Peru." This shows that his identity as both an American and a Peruvian will influence his papacy. Many Peruvians remember him as a priest who stood with the country's poorest people. Within the Vatican, he was informally known as the "Latin American Yankee," a nickname that captures his dual identity and capacity to bridge a hemisphere. The crowd cheered when he said, "Peace be with you."

The new Pope has to take several key steps. The new Pontiff has given hints about his priorities as head of the Catholic Church ---peace, climate change and technology. But abuse scandals and the role of women will remain important. Like his predecessor, Pope Leo wants to support the poor and marginalized. He would like to continue to open the Vatican and listen to voices outside the church hierarchy. Pope Leo needs to continue these reforms and address the economic issues to maintain the Church's stability and integrity. Church.

# Big setback for President Trump as Moody's downgrades US economy

t's the turn of the United States government to face a sovereign rating being downgraded by the Moody's from its top AAA rating – Moody's keeps downgrading the ratings of many developing countries including India. Moody's Ratings cut the United States' sovereign credit rating down a notch to Aa1 from the Aaa, the highest possible. however As1 would mean the economy is stable but not strong.

Moody's cited the burgeoning debt burden of the US government in financing the federal government's budget deficit and rising cost of rolling over existing debt amid high interest rates. A sign that it has inherited the burden from the previous Biden government and nothing in 100 days to bring down the debt or the cost of servicing the debt.

"This one-notch downgrade on our 21notch rating scale reflects the increase over more than a decade in government debt and interest payment ratios to levels that are significantly higher than similarly rated sovereigns," the ratings agency said in a statement.

The decision to lower the United States credit profile could be expected, at the margin, to lift

the yield that investors de-mand in order to buy U.S. Treasury debt to reflect more risk, and could dampen sentiment toward owning U.S. assets, including stocks. Having said that, all the major credit rating agencies continue to give the United

States their second-highest available rat-The yield on the benchmark 10-year Treasury note climbed 3 basis points in after-hours trading, trading at 4.48%. The iShares 20+ Year Treasury Bond ETF fell about 1% in extended trading, while the SPDR S&P 500 ETF Trust fell 0.4%.

Moody's had been a holdout in keeping U.S. sovereign debt at the highest credit rating possible and brought the 116-yearold agency into line with its rivals. Standard & Poor's downgraded the U.S. to AA+ from AAA in August 2011, and Fitch Ratings also cut the U.S. rating to AA+ from AAA, in August 2023. "Successive U.S. administrations and

Congress have failed to agree on meas-

ures to reverse the trend of large annual fiscal deficits and growing interest costs,' Moody's analysts said in a statement. "We do not believe that material multi-year reductions in mandatory spending and deficits will result from current fiscal proposals under consideration.

The U.S. is running a massive budget deficit as interest costs for Treasury debt continue to rise due to a combination of higher rates and more principal debt to finance. The fiscal deficit in the year that began October 1 is already running at \$1.05 trillion, 13% higher than a year ago. Revenue from tariffs helped shave some of the imbalance last month.

The Moody's downgrade came as the GOP-led House Budget Committee on Friday rejected a sweeping tax cut package as part of President Donald Trump's agenda, including extending tax cuts enacted in 2017. Moody's officially rated U.S. bonds in 1993 for the first time but had assigned a "country ceiling rating" of AAA on the U.S. since 1949.

The House Budget Committee - voted down the massive party-line package, with a critical band of Republicans pushing for deeper spending cuts . The GOPled H BC voted to reject a sweeping package for President Donald Trump's agenda on Friday, dealing an embarrassing setback to Speaker Mike Johnson, R-La., and Republican leaders.

The vote in the Budget Committee was 16-21, with a band of conservative hardliners who are pushing for steeper spending cuts joining all Democrats in voting against the multi trillion-dollar legislation, leaving its fate uncertain.

The Republicans who voted "NO" were Reps. Chip Roy of Texas, Ralph Norman of South Carolina, Andrew Clyde of Georgia and Josh Brecheen of Oklahoma. Rep. Lloyd Smucker of Pennsylvania changed his vote from "yes" to "no." he said, as a procedural move to allow Re-



publicans to call the bill up again.

During the hearing, Roy fired a warning shot at Republican leaders, saying he opposes the bill as written because it will increase the deficit. "I have to now admonish my colleagues on this side of the aisle. This bill falls profoundly short. It does not do what we say it does with respect to deficits," Roy said. "That's the truth. Deficits will go up in the first half of the 10-year budget window and we all know it's true. And we shouldn't do that. We shouldn't say that we're doing something we're not doing.

"This bill has back-loaded savings and has front-loaded spending," Roy added. "I am a no on this bill unless serious reforms are made today, tomorrow, Sunday. Something needs to change or you're not going to get my support." Afterthe vote tally was read, the HBC chair Jodey Arrington adjourned the hearing

Negotiations with the GOP holdouts will continue in the coming days. The House Budget Committee announced it would reconvene to take up the bill again on Sunday at 10 PM. "You never know until you ask the question where people stand, which is the reason I called for a vote. You can't accomplish anything in life without having deadlines and decisions," Arrington told reporters afterward. "Today was a deadline and a decision, and it's one of the decision points to get us to the successful passage of the reconcilia-

But Smucker told reporters he hopes the legislation can pass committee by Monday, which would keep the House on track to approve the measure by the end of next week. "So, we're working through some remaining issues here. There are just a few outstanding issues. I think everyone will get to yes," Smucker said. In a post on X, the Freedom Caucus said its member will work through the weekend to reach a deal to pas the package.

Prior to Friday's committee meeting, Republican leaders conceded that changes would be needed for the bill to pass through the House, where the party holds a slim majority. In addition to the spending and deficit concerns from the right, a group of blue-state Republicans have called for a higher cap on the state and local tax deduction, or SALT. The house strength is now 220 to 215. With GOP hardliners crossing the aisles it's going to be a tough task for speaker Johnson to get the budget passed.

Across the aisle, Rep. Brendan Boyle, D-Pa., previewed the Republican divisions at the outset of the hearing, vowing that all Democrats would oppose it. "You will hear over the course of this hearing a vigorous debate. And frankly there is a strong divide between Republicans and some other Republicans. There is also a divide between both sets of Republicans and this side of the dais," said Boyle, the top Democrat on the budget panel. "I can speak at least as to why every Democratic member will be voting no on the bill for billionaires.

## Symbolism behind India's military operation codenames

n the grand tapestry of India's post-independence history, military operation codenames stand out Las emblematic expressions of national will, strategy, and emotional resilience. These names, though often overlooked in public discourse, are more than bureaucratic tags for logistical undertakings. They are resonant phrases, steeped in symbolism, designed not only to define tactical intent but also to stir national sentiment and forge collective memory. In India's complex security landscape, where every confrontation echoes with historical, political, and emotional undertones, the art of naming operations has emerged as a powerful tool of strategic communication. From the days of India's nascent statehood to the evolving realities of modern asymmetric warfare, each codename chosen for military, paramilitary, or police actions has conveyed layered meanings. Whether drawn from mythology, nature, Sanskrit lexicon, or culturally loaded metaphors, these names are linguistic reflections of India's values, resolve. and strategic posture. They embody the lived experiences of soldiers and civilians alike, tying battlefield realities to public consciousness and often to the very soul of the nation. Consider the symbolic weight of recent operations such as 'Operation Sindoor', Launched in response to the brutal Pahalgam terrorist attack of April 22, 2025, this operation epitomises the emotional and political depth imbued in such naming practices. While the acronym SINDOOR is said to stand for "Strategic Initiative for Neutralising Destructive Opponents with Overwhelming Retaliation." its true power lies in its emotional symbolism. 'Sindoor', the vermillion applied by married Hindu women, is associated with love, honour, and marital sanctity. The operation, as per media reports, was named by Prime Minister Narendra Modi to pay tribute to the widows of those slain in the Pahalgam attack. In doing so, it transformed a military action into an act of justice, vengeance, and national solidarity. This is not a standalone case. India's military codenaming tradition has long reflected such dual purpose: tactical clarity and emotional narrative. During the First Indo-Pak War of 1947-48, Pakistan launched 'Operation Gulmarg', an infiltration of tribal fighters into Kashmir. India responded with 'Operation Rescue', airlifting troops to save Srinagar. The very name signified a mission not of conquest, but of salvation and defence, subtly framing India's role as a guardian rather than an aggressor. In 1948, 'Operation Polo' was launched for the integration of Hyderabad into the Indian Union. The name, seemingly benign, perhaps deliberately understated the military nature of the mission to avoid alarming the public and international observers. Likewise, 'Operation Vijay' was the chosen title for both the liberation of Goa in 1961 and the Kargil War in 1999. The term 'Vijay' means victory in Sanskrit and Hindi, and its repetition across decades reinforced a sense of continuity, purpose, and inevitable triumph. The 1971 Indo-Pak war, which led to the creation of Bangladesh, saw Indian forces conducting 'Operation Cactus Lily'. The name, combining the rugged resilience of a cactus with the delicate symbolism of a lily, possibly reflected the duality of military strength and humanitarian concern. Similarly, the Indian Air Force launched 'Operation Safed Sagar' during the Kargil War, literally translating to 'White Sea', an evocative metaphor for the snowcovered heights of the conflict zone.

Siachen Glacier. The name refers to Kalidasa's ancient poem "Meghdoot" (Cloud Messenger), combining poetic imagery with strategic depth. Fighting on the world's highest battlefield demanded more than logistics; it required a national mythos to justify the extraordinary commitment. 'Operation Trident' (1971), another example, borrows from Lord Shiva's weapon, the trishul, conveying power, precision, and divinity during a decisive naval assault on Karachi Harbour.

Operations often carry an implicit message to the domestic audience and international community. In 1987, the Indian Peace Keeping Force's (IPKF) en-

n the history of independent India, few incidents have brought the nation's attention so forcefully to the crossroads of military might, political discord, and social deates as the recent Operation Sindoor, Launched in retaliation against a deadly terrorist attack on innocent tourists at Pahalgam in Jammu and Kashmir, the operation was a decisive military action aimed at terror camps operating from across the Line of Control. Yet what should have been a moment of collective resolve and national solidarity quickly spiralled into a maelstrom of political controversies, identity-driven narratives, and partisan discord. This comprehensive article attempts to explore not only the military strategy and outcomes of Operation Sindoor, but also the socio-political debates it triggered. Figures like senior Congress MP Shashi Tharoor, Indian Army's Colonel Sofiya Qureshi, Indian Air Force's Wing Commander Vyomika Singh, and political commentators from across the spectrum became focal points of a drama that laid bare India's fragile political consensus on matters of national security. ured military responses. In the aftermath, the Indian armed forces sent out their offie political spectrum but drew veiled criticism from within his own party. Congress communications in-charge Jairam Ramesh remarked cryptically, "There's a difference between being in the Congress and being of the Congress." This highlighted internal divisions within the party, particularly on matters of security, where ideological clarity has increasingly eluded opposition ranks. Fueling the controversies was the circulation of a manipulated video on social media, purporting to show External Affairs Minister S. Jaishankar suggesting that Pakistan was forewarned of the operation. The video was later exposed as a deepfake by independent factcheckers, but not before Congress leader Rahul Gandhi amplified it on his social media platforms, raising operational security concerns. This incident revealed the double-edged nature of digital technology in contemporary political warfare. where misinformation can rapidly escalate tensions in already fraught situations. Amidst these political storms, the Indian public overwhelmingly sided with the armed forces and their spokespersons. Social media and public platpolitical forms hailed Colonel Qureshi and Wing Commander Singh as emblems of modern India - inclusive, courageous, and professional. Their dignified silence in the face of communal and casteist innuendoes won them even greater admiration, reaffirming public faith in the integrity and secular character of India's military. The episode also rekindled urgent debates over the politicisation of military operations. Analysts warned that using military actions for partisan gains leaders weakens operational integrity and erodes public trust in institutions. Furthermore, the communalisation and caste-based targeting of individual officers set a dangerous precedent. India's military has historically prided itself on transcending such divisions, and experts argued that safeguarding this

Operation Sindoor served as a timely reminder that national security crises demand political unity and maturity. India's strength lies in its unity, and episodes like Operation Sindoor underscore the necessity of protecting the secular, inclusive character of its institutions. In times of external threat, the nation must rise above divisions, reaffirming its collective commitment to sovereignty, integrity, and democratic values. As the dust settles on this operation, it leaves behind crucial lessons — about the need for political restraint, the dangers of misinformation, and the imperative of preserving the armed forces' apolitical character. Some operations have drawn directly from Indian mythology and classical language. 'Operation Meghdoot', launched in 1984, enabled India to secure the

gagement in Sri Lanka was named 'Operation Pawan' (wind), suggesting speed, subtlety, and omnipresence. A year later, 'Operation Cactus' rescued the Maldivian government from a coup, again using a metaphor of toughness and resilience. More recently, 'Operation Bandar' - India's retaliatory airstrike in Balakot after the Pulwama attack - invoked the monkey god Hanuman, evoking courage, stealth, and righteous fury.

Beyond war, these codenames also serve humanitarian missions. 'Operation Maitri' (Friendship) during the 2015 Nepal earthquake, 'Operation Ganga' (named after India's sacred river) for evacuations during the Ukraine crisis in 2022, and 'Operation Dost' (Friend) in response to Turkey-Syria's 2023 earthquake, all signal compassion and solidarity. Likewise, 'Operation Kaveri' during the 2023 Sudan crisis invoked the nurturing essence of the Kaveri river, underlining India's role as a protective force for its citizens and friends abroad.

Counter-insurgency operations in Kashmir and other insurgency-prone areas have also been distinctly named. 'Operation Rakshak' (Protector), initiated in the early 1990s, positioned security forces as guardians. More assertively, 'Operation All Out' conveyed a no-holds-barred approach to militancy in Kashmir. These names serve both to inform and to warn — a calculated display of intent.

The psychological dimension of codenames is not to be underestimated. A well-chosen name boosts troop morale, garners public support, and helps define the historical narrative. As military historian Shiv Kunal Verma aptly put it, "Every operation is a story in itself, and the name is its headline — short. striking, and deliberately chosen." It encapsulates the ethos, goals, and sometimes, the geopolitical message the operation seeks to send.

Moreover, naming conventions reflect India's evolving military doctrine — from defensive postures to proactive interventions. The shift is evident in the move from operations with subtle names like 'Polo' and 'Rescue' to assertive ones like 'Bandar' and 'Sindoor'. This transformation parallels India's larger geopolitical evolution - from a cautious postcolonial state to an assertive regional power ready to project its will across borders.

As the world navigates an age of information warfare and media spectacle, naming operations has become part of the narrative strategy. In an era where missiles are live-streamed, and strikes are tweeted in real time, the name becomes the first and often most enduring symbol of the action. It is a lexical missile, carrying with it meaning, emotion, and intent.

India's operation codenames are not incidental but intentional. They are chosen not just for military relevance but for emotional, cultural, and political impact. Each name is a linguistic monument to a moment in history — carrying echoes of strategy, sacrifice, sovereignty, and spirit. In recognising the stories behind these names, we honour the uniformed lives that carry them into action and the values they are sworn to defend. cial spokespersons for press briefings — Colonel Sofiya Qureshi of the Indian Army and Wing Commander Vyomika Singh of the Indian Air Force. Their calm, composed, and authoritative briefings quickly drew admiration from citizens and veterans alike. Defence experts and historians responded with sharp rebukes, reaffirming that India's armed forces have long remained above caste, religion, and regional considerations — a rare institution in modern India that unites through merit, discipline, and patriotic duty

Adding another layer of complexity was senior Congress leader Shashi Tharoor's unexpected intervention. While sevopposition eral maintained guarded neutrality or evaded direct comments, Tharoor openly praised Operation Sindoor as a strategically sound and morally justified action. Citing Article 51 of the UN Charter, Tharoor defended India's right to proactive selfdefence. His position was no-

## Health security vs. Profit motive

edicines are one of the greatest gifts of science, saving countless lives and empowering humanity to fight severe diseases. However, when these very medicines become poisonous weapons in the blind race for profit, they cease to be science and instead turn into mere commerce, a trade where a handful of companies earn billions at the cost of risking people's lives.

Recently, a significant intervention occurred in India when the Central Drugs Standard Control Organization (CDSCO) ordered a ban on thirty-five "Fixed-Dose Combination" (FDC) medicines. This decision is not only a bold move but also sets an important precedent for protecting public health. Many of these banned medicines had been widely used for years to treat common ailments such as fever, pain, allergies, and colds. This raises pertinent questions: Was there no scientific evaluation before these drugs were allowed in the market? If there was an evaluation, why are these drugs now considered dangerous? And if there wasn't any evaluation, how were these medicines available for so long?

The answers to these questions reveal the complex realities of drug regulation in India, the efficacy of regulatory agencies, the influence of pharmaceutical companies, and the inherent weaknesses in policymaking.

Fixed-Dose Combination (FDC) drugs are formulations where two or more active pharmaceutical ingredients are combined in a single pill or syrup. Sometimes, FDCs offer therapeutic convenience, particularly for diseases like diabetes, tuberculosis, or HIV/AIDS, where multiple medications are needed simultaneously. However, often pharmaceutical companies exploit FDCs to boost profits. They combine various ingredients without scientific evidence or medical ne-

Many of these FDCs provide no added therapeutic advantage and, worse, sometimes increase the risk of side effects and complications. For example, drugs that mix a painkiller with an antibiotic or a

steroid without medical justification are administered to patients, leading not only to deteriorating health but also contributing to the growing problem of Antimicrobial Resistance (AMR) - now a

global health crisis. The history of FDC drug production and sale in India is riddled with complexities. The drug regulation system is divided between the center and the states. New drugs require approval from the central body (CDSCO), while manufacturing and distribution permissions are granted by state drug controllers.

Pharmaceutical companies often exploit this confused setup by obtaining state approvals without securing central clearance, allowing them to sell their products for years without rigorous scientific vetting. This dual system creates a situation where drugs remain legally available in the market even if they are scientifically unsafe.

Dr. Jyoti Singh believes that individuals who have consumed these banned drugs have suffered lasting impacts on their immune systems. Regular medicines are no longer effective for them, signaling a grave danger for the future. She also asserts that banning these drugs, in reality, serves little tangi-

ble benefit. In her view, nowadays, even "bans" have become a kind of business strategy, a clever ploy through which governments and pharmaceutical companies can earn even more profit.

However, it also highlights a critical flaw: as long as there is a long gap between scientific evaluation and regulatory action, unsafe drugs will continue reaching the masses.

Thus, if a medicine is banned only after fifteen to twenty years of use, a crucial question arises: who will compensate for the harm caused in that duration? Will pharmaceutical companies be held accountable? Will the government step forward through public interest litigations to ensure compensation for affected patients?

There is an urgent need for a transparent system regarding the production, pricing, promotion, and distribution of medicines. Today, pharmaceutical companies heavily influence doctors through medical representatives to push their products. Patients trust their doctors and consume the prescribed medicines without knowing whether they were truly necessary.

If doctors themselves are unaware of a drug's effectiveness, the patient becomes a target of blind experimentation. This is why even ineffective or harmful drugs continue to be sold openly

The commercialization of healthcare services today worsens this crisis further. In the mad race for profits, not just pharmaceutical companies but pharmacies, hospitals, and even doctors are increasingly drawn into a web of commercial interests. In a country like India, where a large population remains poor and illiterate, the sole aim of medical services should be public welfare, not profit-making.

However, when drug availability in public hospitals declines, forcing people into the expensive private sector, pharmaceutical companies find immense opportu-often at the cost of people's health. Another alarming aspect of this whole situation is the lack of public awareness. Even today, a significant number of people consume medicines without consulting doctors. They purchase Over-The-Counter (OTC) drugs from medical stores where sometimes even the shopkeepers recommend medicines without sufficient knowledge. This practice not only encourages the misuse of medicines but also leads to severe side effects.

To curb this trend, not only stricter laws are needed, but largescale public awareness campaigns must also be launched. People

must be educated about the dangers of self-medication and the need for proper medical consultation.

On the other hand, pharmaceutical companies argue that before banning any drug, a thorough scientific evaluation should be conducted. Sometimes regulatory bodies, they claim, draw conclusions based on superficial testing, creating uncertainty and confusion in the pharmaceutical industry. This hampers innovation and research as well.

Thus, there is a real need for a regulatory process that is transparent, evidence-based, and fair. Any decision regarding banning a drug should not stem from political pressure or public emotion but should be grounded in solid scientific evidence.

It is also true that India is the largest producer of generic medicines in the world, and Indianmade drugs are considered affordable and accessible globally. However, if issues of quality and safety are ignored in this quest for supremacy, the very image of India as the "Pharmacy of the World" could be jeopardized.

Therefore, India must strengthen its regulatory framework further, not only ensuring rigorous pre-approval evaluations but also maintaining continuous post-market surveillance.

Considering all these factors, it becomes evident that banning dangerous drugs is not merely a matter of issuing government orders. It must be a collective effort encompassing health policy, ethical considerations, scientific scrutiny, and public interest. Until pharmaceutical companies are held accountable, the role of doctors becomes transparent, and the government assumes its responsibilities with seriousness, no regulation can be truly effective, they will remain confined to paper alone. "His sensibilities are that he's got to get on the phone with President Putin, and that is going to clear up some of the logjam and get us to the place that we need to get to," said Trump's envoy, Steve Witkoff. "I think it's going to be a very successful call

## **Biden diagnosed with** aggressive prostate cancer



WASHINGTON, May 19: Former President Joe Biden has been diagnosed with prostate cancer, his office said Sunday

The finding came after the 82-yearold reported urinary symptoms, which led doctors to discover a nodule on his prostate. He was diagnosed with prostate cancer on Friday, with the cancer cells having spread to the

"While this represents a more aggressive form of the disease, the cancer appears to be hormone-sensitive. which allows for effective management," his office said. "The President and his family are reviewing treatment options with his physicians." In a post on X on Monday morning, Biden posted a photo of himself and his wife, Jill Biden, and wrote:

"Cancer touches us all. Like so many of you, Jill and I have learned that we are strongest in the broken places. Thank you for lifting us up with love and support.'

Prostate cancers are graded for aggressiveness using what's known as a Gleason score. The scores range from 6 to 10, with 8, 9 and 10 prostate cancers behaving more aggressively. Biden's office said his score was 9, suggesting his cancer is among the most aggressive.

When prostate cancer spreads to other parts of the body, it often spreads to the bones. Metastasized cancer is much harder to treat than localised cancer because it can be hard for drugs to reach all the tumours and completely root out the disease.

However, when prostate cancers need hormones to grow, as in Biden's case, they can be susceptible to treatment that deprives the tumours of hormones

Outcomes have improved in recent decades and patients can expect to live with metastatic prostate cancer for four or five years, said Dr. Matthew Smith of Massachusetts General Brigham Cancer Center. "It's very treatable, but not curable," Smith said. "Most men in this situation would be treated with drugs and would not be advised to have either surgery or radiation therapy. Many political leaders sent Biden their wishes for his recovery.

President Donald Trump, a longtime political opponent, posted on so-

cial media that he was saddened by the news and "we wish Joe a fast and successful recovery."

Biden's vice president, Kamala Harris, said on social media that she was keeping him in her family's "hearts and prayers during this time." "Joe is a fighter — and I know he will face this challenge with the same strength, resilience, and optimism that have always defined his life and leadership," Harris wrote.

Former President Barack Obama said his thoughts and prayers were with Biden, his former vice president, lauding his toughness. "Nobody has done more to find breakthrough treatments for cancer in all its forms than Joe, and I am certain he will fight this challenge with his trademark resolve and grace," Obama wrote on social media

The health of Biden was a dominant concern among voters during his time as president. After a calamitous debate performance in June while seeking reelection, Biden abandoned his bid for a second term. Harris became the nominee and lost to Trump, a Republican who returned to the White House after a four-year hiatus. But in recent days, Biden rejected concerns about his age despite reporting in the new book "Original Sin" by Jake Tapper and Alex Thompson that aides had shielded the public from the extent of his decline while serving as president

In February 2023, Biden had a skin lesion removed from his chest that was a basal cell carcinoma, a common form of skin cancer. And in November 2021, he had a polyp removed from his colon that was a benign, but potentially pre-cancerous lesion

In 2022, Biden made a "cancer moonshot" one of his administration's priorities with the goal of halving the cancer death rate over the next 25 years. The initiative was a continuation of his work as vice president to address a disease that had killed his older son. Beau, who died from brain cancer in 2015.

His father, when announcing the goal to halve the cancer death rate, said this could be an "American moment to prove to ourselves and, quite frankly, the world that we can do really big things." (AP)

The blast occurred near Jabbar Market in Killa Abdullah district of Balochistan on Sunday, causing extensive damage to the building and triggering widespread panic. Several shops collapsed, and fires erupted in multiple establishments following the explosion, The Express Tribune newspaper reported

Killa Abdullah Deputy Commissioner Riaz Khan said four people were killed and 20 others injured in the explosion.

He said that the market was located adjacent to the rear wall of the Frontier Corps (FC) Fort. Following the explosion, a brief exchange of gunfire occurred between unidentified assailants and FC personnel.

Law enforcement officials sealed off the area and launched a



comprehensive search and clearance operation.

No group immediately claimed responsibility for the attack. The injured included a security guard of tribal elder Haji Faizullah Khan Ghabizai and several

## Right-wing populists hopeful after first round of Polish presidential election Trump's big bill advances in rare weekend vote as conservative holdouts secure changes

WARSAW (POLAND), May 19: There's a long way to go yet in Poland's presidential election — but Sunday's first round was a good day for candidates on the political right and far right and it flashed a big red warning signal for the moderate government of Prime Minister Donald Tusk.

Tusk's candidate, liberal Warsaw Mayor Rafal Trzaskowski, and a conservative opponent backed by the national conservative Law and Justice party, Karol Nawrocki, emerged ahead in a pack of 13 candidates.

They were extremely close - Trzaskowski with 31.36 per cent of the votes and Nawrocki with 29.54 per cent, according to final results released Monday morning. Poles now head to a nail-biting second round on June 1, with much resting on the outcome of the runoff.

The race is not only for the presidency, an office with the power to influence foreign policy and veto laws. It will also seal the fate of Tusk's efforts to repair the country's relationship with European allies after after years of rule by Law and Justice, which was often in conflict with Brussels. Tusk has been trying to reverse changes to the judicial branch that were considered undemocratic by the EU, but his efforts have been largely blocked by outgoing conservative President Andrzej Duda.

Many centrist and progressive voters are also disappointed that Tusk has not delivered on other promises, like liberalizing the restrictive abortion law. He has also been criticised for the heavy handed way he took over control of public media from Law and Justice, and the continued politicisation of taxpayer funded public media.

Trzaskowski and Nawrocki wasted no time at all as they head toward the finish line. They got out on the streets early

Five Republicans voted no, one on procedural grounds, the other four voicing concerns about the bill's impact on federal budget deficits. On Sunday evening, the four voicing concerns about the bill's impact on the deficit voted present, and the measure passed by a vote of 17-16.

Johnson is looking to put the bill on the House floor before the end of the week.

"This is the vehicle through which we will deliver on the mandate that the American people gave us in the last election," he said on 'Fox News Sunday.'

The Republicans who criticized the measure noted that the bill's new spending and the tax cuts are front-loaded in the bill, while the measures to offset the cost are back-loaded. For example, they are looking to speed up the new work requirements that Republicans want to enact for able-bodied participants in Medicaid. Those requirements would not kick in until 2029 under the current bill.

"We are writing checks we cannot cash, and our children are going to pay the price," said Rep. Chip Roy, R-Texas, a member of the committee. "Something needs to change, or you're not going to get my support."

Johnson said the start date for the work requirements was designed to give states time to "retool their systems" and to "make sure that all the new laws and all the new safeguards that we're placing can actually be enforced.'

Roy was joined in voting no by Reps. Ralph Norman of South Carolina, Josh Brecheen of Oklahoma and Rep. Andrew Clyde of Georgia. Rep. Lloyd Smucker of Pennsylvania switched his vote to no in a procedural step so it could be reconsidered later, saying after the hearing he was confident Republicans would "get this done." Johnson said talks to deal with their concerns were continuing Sunday. (AP)

New pro-European president in Romania puts it back on Western course, but fault lines remain

BUCHAREST (ROMANIA), May 19: An upset presidential election victory in Romania on Sunday by a pro-European Union centrist over a hard-right nationalist eased fears among many in the Balkan nation that their political future was being swept up in the tide of right-wing populism spreading across Europe

Final results from the presidential race showed Nicusor Dan winning 53.6 per cent of the vote, ahead of the hard-right candidate George Simion, who during the campaign portrayed his movement as championing conservative values like patriotism, sovereignty and the family, and who styled himself as the Romanian analogue to US President Donald Trump

Sunday's victory for the pro-EU candidate marked a significant comeback in a tense election that many viewed as a geopolitical choice for the former Eastern Bloc country between East or West.

But as Dan, a 55-year-old mathematician, pro-Western reformist and mayor of Bucharest, takes over Romania's presidency, fault lines remain in the country where endemic corruption, inequality and an erosion of trust in traditional institutions and parties have fuelled a broad rejection of the political establishment.

A tense election

Dan's decisive win on Sunday was a major turnaround from the first round of elections on May 4, where Simion — a nationalist who has advocated for uniting Romania with neighbouring Moldova and is banned from entering Ukraine - had nearly double Dan's share of votes to become the clear front-runner for the second round.

Simion's surge to prominence came after Romania's first attempt to hold the presidential election late last year in which far-right outsider Calin Georgescu topped first-round polls. The country's political landscape was upended after a top court voided the ballot, alleging electoral violations and Russian interference. Capitalising on the furor over the annulment of that election, Simion allied with Georgescu, who was banned in March from running in the election redo, and promised to appoint him prime minister if Simion secured the presidency.

While Simion was considered the favourite for the second round, a high voter more than in any Romanian election of the past quarter-century — is thought to have benefited Dan.

Adding to the high turnout were approximately 1.6 million votes from members of Romania's large diaspora, which is primarily concentrated in Western Europe. Estimates



suggest that between 4 and 5 million Romanians live abroad — nearly a quarter of the country's population. Most emigrated after Romania joined the EU in 2007, seeking relief from high unemployment and low wages. Fault lines remain

After Dan is sworn in as president in the coming days, he will face the challenge of nominating a prime minister who can garner the support necessary to form a government

- a tall order in a country where anger with establishment politicians led to the emergence of figures like Georgescu and Simion. Yet Dan himself, who rose to prominence

as a civic activist fighting against illegal real estate projects and ran independently on a pro-EU ticket to support Ukraine and reaffirm Western ties, is among the critics of Romania's entrenched political elite, and has argued for fiscal reforms and a crackdown on

corruption. Speaking to ecstatic supporters in the early hours of Monday following his victory, he struck a reformist tone, saying Romania was beginning "a new chapter, and it needs every one of you."

"It needs experts to get involved in various public policies, it needs people in civil society, it needs new people in politics," he said. Cristian Andrei, a Bucharest-based political consultant, says Dan will face a string of immediate challenges, including putting together a new government in what is now a 'totally new political landscape."

"He will have to push and show reforms while meeting resistance in the state apparatus and being opposed by the new populist parties that now won 5 million votes," Andrei said. "He will be under pressure to deliver change to an exasperated Romania while trying to unify a divided country.' Romania in the EU and NATO

As a member of the EU and one of the easternmost members of the NATO military alliance, Romania plays a pivotal role in Western security infrastructure - especially since Russia's full-scale invasion of neighbouring Ukraine in February 2022.

After that invasion, NATO bolstered its presence on Europe's eastern flank by sending additional multinational battlegroups to Romania, Hungary, Bulgaria and Slovakia, and Bucharest has played an increasingly prominent role in the alliance, donating a Patriot missile system to Ukraine and opening an international training hub for F-16 jet pilots from allied countries.

Many observers saw Sunday's vote as crucial to maintaining Romania's place within the network of Western alliances - especially amid fears that the Trump administration is reconsidering its security commitments to the United States' European partners. Siegfried Muresan, a Romanian member of the European Parliament, told The Associated Press on Monday that the election result was a relief for many in Brussels, the EU's de-facto capital, and that Romania is now expected to play an active role in the bloc particularly in security and defence.

"There was an erosion of Romania's credibility in the last year," Muresan said. "That is partly restored now through the clear victory of the pro-European candidate."

Muresan added that Romanians will expect Dan to deliver on promised reforms, but that his clear victory marks a setback for hard-right nationalism.

"People really rallied behind Europe ... and understood the risks which extremists pose," he said. "So much lies now with the new president, who is a unifier, who has campaigned on the basis of facts." (AP)

The event witnessed active participation from residents of Reliance Colony, Itabhatta, and Satsang Nagar – I, II, and III.

The awareness programme, part of a sustained campaign launched by the urban development authorities, aims to educate local residents about the importance of responsible waste segregation and management in accordance with the newly enacted bye-laws.

The event began with a welcome address by Er Jumtum Potom, Assistant Engineer (Urban Development), who explained the objectives of the programme and stressed the importance of civic engagement in achieving the broader goal of a cleaner, healthier township.

Following the welcome remarks, Er Mosum Sema, Execu-Engineer (Urban Development) and Member Secretary of DUDA, Namsai, took the stage to deliver a detailed address on the core principles of effective waste management.

She emphasized the critical role of waste segregation at the household level and urged residents to

cling. She explained that wet waste, such as food scraps and vegetable peels, can be converted into compost or used as livestock feed, while dry waste, which includes plastic, metal, and paper items, should be handed over to the designated DUDA sanitation vehicles



separate their waste into two distinct categories—wet and dry.

Er Sema also informed the gathering that continuous awareness and cleanliness drives have already been conducted in various colonies within the township and that visible improvements in sanitation levels have been observed. However, she noted with concern that improper disposal pracfor appropriate handling and recytices, such as dumping waste into

drains, continue to hamper efforts to maintain cleanliness and hy-

She urged residents to cooperate by disposing of waste responsibly and refraining from actions that clog the drainage systems and contaminate the local environment

One of the key points highlighted during the programme was

the introduction of a nominal user fee for the door-to-door waste collection service. While no charges have been collected from households so far, Er Sema informed that, in accordance with the Arunachal Pradesh Solid Waste (Management & Handling) Bye-Laws, 2023, the collection of a small fee has now become neces-

sary to ensure the long-term sus-

tainability of waste management services in the township.

The programme also featured an address by C R Khampa, Deputy Commissioner of Namsai and Chairman of DUDA, who reiterated the importance of community involvement in managing the town's sanitation systems. He reminded the participants

that waste generation is a daily re-

ality in every household and that proper segregation and disposal of waste must become a routine

practice for every family. Echoing the proverb "Cleanliness is next to Godliness," he encouraged residents to instil a culture of cleanliness in their homes and neighbourhoods.

He further informed that the recently constructed Material Recovery Facility (MRF) in the township will soon be handed over to local women's Self Help Groups (SHGs) for operation and maintenance, empowering local women and promoting decentralized waste processing.

The Deputy Commissioner also announced the appointment of "nuisance detectors"-a mechanism by which fines would be levied on individuals or households found violating the solid waste management bye-laws.

The event was attended by a large number of local residents, stakeholders from the participating colonies, and officers and staff members from the Urban Development Department.

The authorities expressed satisfaction with the level of community interest and reiterated their commitment to building a cleaner and more sustainable urban environment through consistent awareness and enforcement initia-

The next round of the awareness campaign is scheduled to be held on May 21, 2025, and will target other residential clusters within the township.

### FTI, Arunachal Pradesh students alleged Locals urge timely completion of Papunallah-Chimpubeing deprived from basic amenities **Ganga Market Road Project amid monsoon concerns**

DIBRUGARH, May 19: The students of the Film and Television Institute (FTI), Arunachal Pradesh, have alleged severe administrative neglect, stating that they are being deprived of the most basic amenities necessary for academic and personal well-being.

In an official statement issued by the first batch of students, they announced an indefinite academic halt beginning May 15, 2025, citing a prolonged lack of response and unfulfilled promises from the institute's administration.

The promised construction of critical academic facilities such as the Classroom Theatre (CRT) and post-production blocks remains incomplete. Students reported frequent illness due to unsafe drinking

water, persistent internet disruptions that hinder their coursework, and the need to attend classes in unsafe or unfinished facilities.

The students also expressed concern over the lack of institutional identity

They pointed out that the institute still does not have a formal name, official logo, functional website, or even basic dentification cards for students.

They further highlighted that there is no full-time Director on campus and that most administrative functions are either delayed or dysfunctional due to understaffing and poor management.

In the press release, the students stressed that the current academic halt is not symbolic but a direct response to unac-

ceptable learning conditions. They stated that the environment is physically unsafe, emo-

tionally draining, and academically unsustainable. They demanded the immediate completion of essential infrastructure, provision of clean drinking water, uninterrupted

electricity, operational academic facilities, and a clear system of accountability from the administration.

NAMSAI, May 19: The residents of Jullang Panchayat area, along with regular commuters of the Papunallah-Chimpu-Ganga Market road corridor, have issued an earnest appeal to the executing agency and the Public Works Department (PWD) to expedite and complete the long-delayed road construction project.

The appeal was made in light of the deteriorating condition of certain stretches of the road, which is causing daily hardships, especially with the onset of the monsoon season.

According to an official statement issued by local representatives, while the overall road construction is nearing completion, there remain a few critical segments along the approximately 11kilometre stretch—from the Papunallah tri-junction to Ganga Market via Chimpu-where the condition of the road remains poor.

The delays are reportedly due to the sluggish progress of culvert construction in key areas, creating bottlenecks and subjecting commuters to "untold suffer-



frastructure to prevent waterlogging and further damage during heavy rainfall. "We urge the PWD and executing

School has already seen the major components of the culvert work completed, and casting work is expected to begin

FTI, located at Jote, around 22 kilometres from the Papum Pare district headquarters, is the only film and television institute in the entire northeastern region of India.

Despite this distinction, the students claimed that the ground realities at the campus have been disappointing and far removed from the standards expected of a national-level institution.

According to the students, their decision to suspend academic activities indefinitely has come after months of raising concerns regarding essential academic infrastructure and basic amenities, which have gone unaddressed.

In their statement, the students recalled a prior academic halt in March 2025, following which a meeting was held and written assurances were given by the administration.

However, they alleged that even after those assurances, no visible improvement has been made. They stated that the institute continues to lack clean drinking water, consistent electricity supply, power backup, campus security, properly functioning classrooms, and access to reliable internet serv-

Until these basic needs are met, the students declared they would not resume academic activities.

The statement also emphasized the importance of dignity in education.

Despite being the third national film institute in India, the students noted the absence of fundamental institutional features such as a logo, identity cards, or a full-time campus di-

They urged concerned stakeholders to take notice and support their call for an academic environment that upholds the rights and dignity of its students.

The release concluded with a powerful assertion that while the institute may exist as a national institution on paper, its current condition reflects neglect in practice.

Presently, the institute has a total of 45 students from various parts of the country, all of whom, according to the release, are unified in their demand for change.

When approached for a comment, Bishnu Halder, the Chief Academic Coordinator of FTI, Arunachal Pradesh, declined to speak on the matter, stating that he is not the appropriate person to address the issue.

"Though a majority of the work appears to be done, there are still a few locations where road conditions are severely hampered by incomplete culvert work," said one of the concerned residents.

"With the rainy season already beginning, road users are facing increased difficulty navigating the route. The patchwork and temporary repairs carried out by the contractor are inadequate, and we fear further degradation unless urgent action is taken."

The residents emphasized the importance of completing the project with a focus on durability and road quality, stressing the need for robust drainage in-

agency to work on a war footing and complete the project before the monsoon intensifies," the locals said, "attention must also be given to proper roadside drainage to ensure smooth water runoff.

Responding to the concerns, a representative of the executing agency acknowledged the delays and attributed them to unavoidable challenges such as land issues and the shifting of utility services.

"More than 90% of the work on the Papunallah-Chimpu-Ganga Market road has already been completed. The remaining portions are under active progress," said the contractor.

The official elaborated that there are three specific locations where progress has been slow.

"One such site near HIM International

May 19: At least 12 persons, including a YouTuber, have been nabbed on the charges of spying for Pakistan in the past two weeks from Punjab, Haryana and Uttar Pradesh with investigations pointing out that they were allegedly part of a Pakistan-linked espionage network operating in north India, police said

While six of them have been held from Punjab, four were nabbed from neighbouring Haryana

Among those arrested, two women, including the YouTuber from Haryana, were allegedly in touch with Pakistani officer Ehsanur-Rahim alias Danish posted at the Pakistan High Commission in New Delhi. On May 13, India expelled the Pakistani official for allegedly indulging in espionage.

Police investigations so far revealed that the accused were allegedly passing on sensitive information to Pakistani Intelligence Operatives (PIOs), officials said, adding that a probe into their financial transactions and forensic analysis of their electronic devices were also underway.

In addition to the arrests made from Punjab and Haryana, an alleged agent of Pakistan's intelligence agency Inter-Services Intelligence (ISI) was arrested from Uttar Pradesh's Rampur on Sunday by the state's Special Task Force. The official further said a fire accident case was registered in connection with the incident.


Further investigation would proceed as per its findings, he added. A blaze triggered by a suspected short circuit in a building near the iconic Charminar here on Sunday killed 17 people, including eight children, belonging to an extended family of a jeweller.

The fire broke out at a building in Gulzar Houz here, police said.

"All 17 who were shifted to hospitals were dead," a senior police official told PTI. A narrow staircase was the only escape route for the inmates of the building, but they could not rush out, a Fire Department official said.

The building housed jewellery shops on the ground floor, and people were residing in a flat above, police said, adding that smoke spread and people suffocated.

There were a total of 21 people in the building when the incident occurred, and out of them, 17 who were shifted to different hospitals in an unconscious condition by the fire department they could not survive, while four of them on the upper floors were rescued. (PTI)

BHUBANESWAR, May 19: Odisha Law minister Prithiviraj Harichandan on Monday said the government has already started the process of identifying Bangladeshis staying illegally in different districts of the state.

The government has issued direction to all district collectors, coastal security agencies and formed a Special Task Force to coordinate the process of identifying the undocumented Bangladeshi immigrants in the state.

"We have already started the process of identifying illegal migrants staying in both urban and rural areas. No foreign national residing without valid legal status will be allowed to stay in Odisha. Different engineering departments of the state government have been asked not to engage any Bangladeshi or foreign national without valid documents. The government has taken a strong stance in this regard," Harichandan told reporters here. In April, Odisha's Panchayati Raj minister Rabi Narayan Naik and Food Supplies minister KC Patra had said that the state would identify all foreign nationals staying in the state illegally.

Naik had said that illegal settlers are being identified from gram panchayat level, Patra said that the government has decided to deny ration cards availed by such persons in a fraudulent manner.

Meanwhile, the Commissionerate of Police, Bhubaneswar-Cuttack on Sunday held a meeting of officers-in-charge of all police stations and discussed the issue of illegal Bangladeshi migrants staying in the twin cities.

Bhubaneswar DCP Jagmohan Meena instructed all police stations to gather detailed data on undocumented foreigners, particularly Bangladeshi nationals, and take appropriate legal action. He also asked the police to investigate how these (illegal settlers) people entered Bhubaneswar, their activities, and whether they possess valid documents. Police sources said that the Special Task Force (STF) of Crime Branch in this regard had arrested 10 illegal Bangladeshi immigrants, including six men, three women and a juvenile from Bhubaneswar railway station here in March. (PTI)

### 'Entire nation in shame': SC orders SIT probe against MP minister over remarks on Col Qureshi

NEW DELHI, May 19: The Supreme Court on Monday pulled up Madhya Pradesh minister Vijay Shah for his remarks on Colonel Sofiya Qureshi and constituted a three-member special investigation team to probe the FIR lodged against him.

A bench of Justices Surya Kant and N Kotiswar Singh told the minister that it had seen his videos where he made the remarks and his apology and wondered if "they were crocodile tears or an attempt to wriggle out of the legal proceedings".

"The entire nation was in shame due to the comments... We saw your videos , you were on the verge of using very filthy language but somehow better sense prevailed or you did not find suitable words. You should be shameful. Entire country is proud of our Army and you made this statement," Justice Surva Kant said. The bench further grilled the minister, "What kind of apology was this? You should have simply admitted your mistake and apologised but you say if you have said this and that...then I apologise. This is not the way to seek apology. The kind of crass comments you made, you should be shameful.'

Shah was represented by senior advocates Maninder Singh and Vibha Dutt Makhija. The top court asked the Madhya Pradesh director general of police to constitute a three-member special investigation team (SIT) headed by an IG rank officer by Tuesday 10 am also comprising a woman officer to probe the FIR registered following an order of the Madhya Pradesh High Court. #### Waterlogged roads stall Bengaluru traffic; PM abused Congress, now taking its help for diplomatic delegations: Ramesh

NEW DELHI, May 19: The Congress on Monday dismissed as an "absolute lie" Union minister Kiren Rijiju's reported assertion that the government did not ask for names for the all-party diplomatic delegations going abroad, and said it was "cheap politics" to not get the names it selected cleared with the opposition party.

Taking a swipe at Prime Minister Narendra Modi, Congress genin-charge eral secretary communications Jairam Ramesh said the same prime minister who had abused the Congress publicly in countries such as Australia, the US, South Korea and China, was taking the help of the opposition party in these delegations.

"Why didn't the prime minister pick up the phone and speak to Congress president Mallikarjun Kharge and Leader of Opposition in the Lok Sabha Rahul Gandhi? Why didn't he have the courtesy to do that? The fact is that our narrative has been punctured and continues to get punctured because of the politics of polarisation in the country," Ramesh told PTI.

Later, in a post on X, Ramesh said, "After 11 years of abusing and defaming the Opposition -- especially the Congress -- the prime minister is now forced to send allparty delegations overseas. The

truth is that the BJP's poisonous politics at home has cost us hugely abroad. Our sanctimonious diplomacy has fallen flat and India is back to being hyphenated with Pakistan." "That is the real 'new normal'," he added.

The "self-styled Vishwaguru's balloon", which was full of hot air. has been well and truly punctured, Ramesh said.

"It is a reflection of his own inadequacies -- now completely exposed -- that the prime minister is now turning towards bipartisanship. But this is only momentary, hypocritical, and opportunistic,' he said

On Saturday, the Congress said it was asked by the government to submit the names of four leaders for the all-party delegations to be sent abroad to explain India's stance on Pakistan-backed terrorism. It nominated Anand Sharma, Gaurav Gogoi, Syed Naseer Hussain, and Amrinder Singh Raja Warring. Of the four, only Sharma has been included in the seven delegations that will be visiting various countries.

Four Congress leaders -- Shashi Tharoor, Manish Tewari, Amar Singh and Salman Khurshid -- who were not part of the list sent by the Congress have been included in the delegations.

Asked about Union Parliamentary Affairs Minister Rijiju's reported remarks that the government never asked the Congress for names, Ramesh said to PTI, "That is a lie -- LIE -- absolute lie. He had a conversation in the morning of May 16 with the Congress president and Mr Rahul

Gandhi and in pursuance of that conversation the latter wrote to Mr Rijiju suggesting four names."

"At no point of time, the Modi government did the Congress the courtesy of saying that, 'look these are the four names we have selected, what do you have to say about them'," he added.

Ramesh also accused the BJP and the prime minister of having played "cheap politics" on the issue "His (Modi's) image has taken a

beating, he is desperate in changing the narrative once again. Our demand is that a prime ministerchaired all-party meeting be held and a special session (of Parliament) be called to reiterate the resolution of February 1994 and give it fresh meaning, as well as take the nation into confidence," the Congress leader said.

He claimed that while India made gains through Operation Sindoor, diplomatically it had been hurt as the narrative changed. (PTI)

BENGALURU, May 19: Heavy overnight rains severely affected parts of the city on Monday, leading to water-logged roads, inundated residential areas and traffic pile-up, as the city braces for more spells in the coming days.

Bengaluru received 103 mm of rain in the last 24 hours, according to an IMD bulletin.

The social media was flooded with videos of waterlogged roads from various parts of the IT capital, highlighting how the city collapses when there is rain.

According to Home Minister G Parameshwara, for the last three days, Bengaluru has witnessed heavy rains. "During pre-monsoon, we usually see flooding and inundation. BBMP (Bruhat Bengaluru Mahanagara Palike ) has been on the job of clearing waterlogging and uprooted trees and branches from roads. Authorities are on the job," he said.

A picture captured by Bengaluru Corporate Club's official 'X' handle shows a chock-a-block Silk Board -- one of the infamous bottlenecks that slow down traffic in the city -- at 7.20 am, the supposedly non-peak hour, on Monday.

PTI Videos reported that the traffic jam at Silk Board stretched for nearly 10 km. This pre-monsoon season, according to hobby

weather watchers of the city, Bengaluru has been witnessing 15 to 20 cm of rainfall for the last couple of days. Most of them have advocated for work from home, as city roads make commuting almost impossible as well as dangerous, especially with the flooding of underpasses at several places.

One of the worst rain-affected areas in Bengaluru so far was Sai Layout in Horamavu, which falls in the Mahadevapura zone. Earlier, pre-monsoon rain submerged the avout with 4-5ft of water, leaving streets flooded to knee level.

According to some news reports, the residents have blamed clogged drains and claimed that

despite repeated complaints to the authorities, they were not cleaned. Water entered homes in NC Colony on Tannery Road as well. Although no injuries have been reported, a tree that was uprooted in the heavy rains in Jayanagar fell on a parked car and a jeep, damaging them. East End Road towards Mount Carmel School Road was also temporarily closed as a tree fell on the stretch.

Waterlogged roads in different parts of the city had made commuting a nightmare for people.

Despite constant traffic alerts by the traffic police about slow-moving traffic in several places, people pushing their stuck cars in knee-

deep water could be spotted at places like Panathur S Cross, upper ramp of Domlur flyover and Koramangala, which are prone to waterlogging. Traffic was also slow near Manyata Tech Park.

Meanwhile, the yellow alert issued on May 18 to some regions in Karnataka, including Bengaluru, remains valid for Monday and Tuesday as well, said India Meteorological Department's Bengaluru centre Director N Puviarasu. Speaking to PTI, he said the department is studying the current pattern of the air circulation and will later issue a weather update. "As per the current pattern of the cyclonic circulation, Karnataka, especially the coastal parts will get heavy rainfall. Bengaluru is also expected to receive heavy rainfall for the next two days," he said. A Yellow alert could possibly result in temporary disruption of electricity in some areas, minor traffic snarls and possible uprooting of weak trees and branches, warned IMD.

On Sunday, IMD had issued a vellow alert for heavy rainfall across 23 districts in Karnataka, including Bengaluru, till Thursday.

The alert warned of moderate to heavy thundershowers, lightning, and gusty winds reaching speeds of 50 - 60 km/h. (PTI)



## Tripura trade organisation welcomes port curbs on imports from Bangladesh

AGARTALA, May 19: An organisation of businessmen and traders in Tripura on Monday welcomed the Centre's decision to impose port restrictions on imports of certain goods from Bangladesh and said the national interest comes first above anything else

Bangladeshi exporters, who send goods in substantial quantities through land ports, will be the losers in view of the Central government's move, Tripura Chamber of Trade and Business (TCTB) general secretary Rajat Paul said

The central government had on Saturday imposed port restrictions on the import of a few Bangladeshi goods, such as readymade garments and processed food items, in response to similar curbs placed by Dhaka on certain Indian products last month. However, the Directorate General



of Foreign Trade (DGFT), in its notification, said the port restrictions will not apply to Bangladeshi goods transiting through India but destined for Nepal and Bhutan.

We welcome the DGFT restriction on imports of certain goods from Bangladesh because the country's interest comes first above anything else. Bangladeshi exporters, who send substantial goods through land ports, will be the maximum losers, following the move", Paul said

He said around 28 cement manufacturing factories are functioning in Bangladesh's Comilla and Brahmanbaria, and supplying huge quantities of the construction material to the northeastern states.

Besides, Bangladesh traders have started supplying corrugated sheets to the northeastern states, he said, adding, they will not be able to do the same after the curbs imposed by DGFT.

Tripura imported goods worth  $\mathbf{R}$ 636.72 crore from Bangladesh during the 2022-23 financial year and ₹ 703.67 crore in the 2023-24 fiscal.

The northeastern state's exports stood at only ₹ 121.37 crore in 2022-23 and ₹ 12.31 FY'24.

Tripura shares an 856-km-long border with Bangladesh and has five functional land ports. (PTI)

"Tripura has seen massive development over the last decade under the leadership of Prime Minister Narendra Modi," said the Union Minister. "PM Modi has pledged to transform

India into a developed nation by 2047, and the Northeast is playing a crucial role in this journey.<sup>3</sup>

He informed that of the 11 Integrated Aqua Parks sanctioned across the country, four are in the Northeast, highlighting the region's growing significance in India's fisheries sector. Rajiv Ranjan Singh underscored the

#### Focus on sovereign state, not on dependent one: NSCN-IM Sikkim Cricket Ground gets floodlight system 'We must not wait for others or depend on others to develop our country'

IMPHAL, May 19: Senior NSCN-IM leader Rh Raising urged the Nagas to focus on "sovereign state, not on dependent state". He also said that the Naga nation comes from the Naga foundation. The NSCN-IM leader added that the history of the Nagas, the political concept of the Nagas, the identity of the Nagas, the culture of the Nagas and the sovereign state of the Nagas come from the Naga foundation. "It can never come from other foundations. And that if our foundation is betrayed or murdered, we perish", he stated.

Rh Raising is Special Emissary of the Collective Leadership, National Socialist Council of Nagalim-IM. He was speaking on the occasion of the Naga Plebiscite Day observed in Ukhrul on May 16, commemorating the 1951 event. The programme was organised by the All Naga Students' Association, Manipur (ANSAM), and participated by the United Naga Council (UNC), the Naga Wo0men Union (NWU), the NPMHR and other Naga organisations and leaders.

In his speech, Rh Raising said, "We are looking for our future: While the Nagas were living free and independent, their free existence was interrupted by the British invasion and occupation of a part of Naga country for a period of time. Nevertheless, on the eve of the British departure from British India, the Naga people declared their independence on August 14, 1947". The NSCN-IM leader also said, "The world is well informed of this"

In 1950, the Constituent Assembly of India invited the Nagas to join the Union of India, which was rejected by the Naga National Council (NNC) under the leadership of A. Z.Phizo and his colleagues, the NSCN-IM leader said. "That big no saved the future of the Nagas, the history of the Nagas, the land of the Nagas, the identity of the Nagas, the culture of the Nagas and politics of the Nagas". A plebiscite conducted on May 16, 1951 reaffirmed that decision, he added. It was informed to the United Nations and many countries through their embassies in Delhi, he further added. "History shall ever speak of it", he said.

Contrary to the democratic method, the Government of India tried to subdue the Nagas through military might but to no avail", Rh. Raising alleged. It rather created a horrible human rights situation in Nagalim, which drew the attention of the world, the NSCN-IM leader claimed.

Under its ugly colonial policy, the Government of India imposed the so-called 16th point agreement in 1963 in the stolen name of Naga people's convention, he also said. However, the Naga people had rejected the agreement.

In its incessant attempts to murder the Naga political issue, the government of India dictated the infamous Shillong Accord in 1975. Nevertheless, Raising said, it was also rejected outright and condemned by the Naga National Assembly under the leadership of Isak Chishi Swu and Th Muivah. "That historic decision saved the future of the Nagas once again. The Nagas see no future in those accords of treason. They are for a principled based solution", he added

Rh Raising then said the Naga nation comes from the Naga foundation. The history of the Nagas, the political concept of the Nagas, the identity of the Nagas, the culture of the Nagas and the sovereign state of the Nagas come from the Naga foundation, he stated. It can never come

from other foundations. "And that if our foundation is betrayed or murdered, we perish", he stated.

The NSCN-IM leader then said Nagas of the past generations focused on the Naga foundation/principle. "They stood firm in the matter of principle. Nagalim for Christ is our foundation and vision as well. Like our fathers, let us also

focus on our foundation and stay the course in all weathers", he also stated.

The NSCN-IM leader then said there are a section of people from some quarters who talk of problems, but they never talk of solutions. "They talk of solution, but they never talk of foundation/root of solution. They talk of peace and unity, but they never talk of foundation of peace and unity. They talk of development, but they never talk of politics, the root of development. They should know that development is the flower, politics is the root", the NSCN-IM leader added.

Rh Raising then said, "We are poor and weak in many respects because we don't have a recognized sovereign state as of now". Sovereign state is the power house of developments. Riches don't come from begging bowl, it comes from sovereign power, he stated. Development does not come from charity, it comes from the spirit of self-reliance of a sovereign people, he further said. Man through the power of a sovereign state has become master of the air, master of the ocean and master of the land, he added. "He has turned desert into river and green pasture through the power of a sovereign state. Wars, natural calamities and diseases are combatted

through the instrument of a sovereign state. Hungers and thirst are eradicated through it. Rugged mountains and swarm lands are developed into beautiful cities through it. Scholars, scientists, writers, statesmen, administrators, army generals and preachers are the products of quality colleges and universities of a sovereign state. We must not wait for others or depend on others to develop our country. We are the prime factor. We are the master of our destiny. We ust need a strong decision for a sovereign state", Rh. Raising further added.

The NSCN-IM leader then said that after forty years of confrontations punctuated with negotiations, the Government of India and the National Socialist Council of Nagalim (NSCN-IM) signed the

NAGA

Framework Agreement on August 3, 2015. This Framework Agreement stopped fighting, killing, horrible army atrocities and violations of human rights in Nagalim, he claimed. It has turned armed confrontation into political negotiation, guerrilla warfare into mass warfare and enemies into friends, he further claimed. 'It is a bridge between the two people. The Framework

Agreement is in the pages of history. It will ever speak of sovereign rights of the Nagas. Declaration of Naga independence on August 14, 1947 is made a recognized political entity by this Framework Agreement stating that 'Nagas have the unique history of independence.' The historic plebiscite conducted on May 16, 1951 was a political step to be recognized by the aggressor-state for legitimacy", Rh. Raising stated. Now, the Framework Agreement has made it a recognized political entity, he stated.

According to Rh. Raising, the Naga national entity was forcibly colonized by India. "The Framework Agreement has made it a recognized entity. It has also recognized the land of the Nagas stating that 'Nagas are the owner of their land - anything on the surface of land and beneath of it belongs to the Nagas.' On the issue of integration, it says, 'integration of all Naga areas is the legitimate right of the Nagas"', he added.

Rh. Raising then said that it has also been mutually agreed 'coexistence of the two entities sharing sovereign power' based on the doctrine of shared sovereignty and interdependent relationship. He said there will be mutual consultation and cooperation sharing sovereign power as defined in the compe-

tencies. This Framework Agreement will certainly protect the sovereign right of the Nagas and security interest of India. Nagas will view India as partner and vice versa. It will bring the two people closer for a greater and higher cause, he stated.

Raiding then said, "Ours is a people's movement for national independence, where all sections of people are involved. And that NSCN is the national revolutionary front of the Naga people who confront and negotiate with the aggressor-states". He said civil societies are another front who shouts in the street and through memorandums and mass media for the cause. He also said elected leaders speak in their respective platforms for the cause. Rh. Raising said the Church is another front, who prays for the cause. "The historic Framework Agreement is the foundation of solution. We hope and trust that Indian leaders will keep their word However, if the government of India betrays the historic Framework Agreement, the matter does not end there. The problem cannot be left unsolved. It must be solved sooner or later. National independence movement of a people from bondages to freedom is the course of history no power can stop", the NSCN-IM leader added.

Also speaking on the occasion, ANSAM president Th. Angteshang Maring said, "Today we are commemorating the historic Naga Plebiscite Day, whereby Nagas chose to remain as a free people and Independent Nation". Amongst others, the August 14, 1947 independence declaration, rejection of the Panglong Agreement of 1947, and the May 16, 1951 Plebiscite for Nagalim independence represents Nagas' unique history and national principle on sovereignty, he started. "This historic day marked that Nagalim was never a part of India or Myanmar (erstwhile Burma) as the case may be, either by consent or by conquest and is one of the key foundations for Naga freedom", the ANSAM leader also said.

Amongst others, according to the ANSAM chief, two important agreements were signed between GoI and NSCN, whereby "Nagas' unique history" and sovereignty were officially recognized that has reinforced the significance of celebrating May 16, 1951 plebiscite Day. One of them is the Amsterdam Joint Communique of July 11, 2002 which recognizes Nagas' unique history and situations. The other one is the Framework Agreement of August 3, 2015 signed on the foundation of sovereignty. "The Framework Agreement recognizes the sovereignty of Nagas as agreed to enter a new relationship of the two entities based on "Shared Sovereignty", the ANSAM leader added. (NNN)

## If the choice is between Pakistan and hell, I would prefer hell: Javed Akhtar

**NEW DELHI**, May 19: Noted lyricist and screenwriter Javed Akhtar, who is often targeted for his views on patriotism and religion, says that if there comes a time he has to choose between Pakistan and hell, he would prefer to go to hell. Akhtar, 80, was speaking at Shiv Sena (UBT) leader Sanjay Raut's book launch

on Saturday night in Mumbai.

At the event, the lyricist -- who identifies himself as an atheist -- said extremists from both India and Pakistan shower abuses on him on a daily basis.


"Some day, I'll show you my Twitter (now X) and WhatsApp. I am abused by both sides. I'm not thankless so I'll say there are also people who appreciate what I say, encourage me. But it's true that extremists from both here and there abuse me. This is right. If one of them stops abusing me, it'll be a matter of concern for me.

"One side says 'You are a kaafir (non-believer) and will go to hell. The other side says, 'Jihadi, go to Pakistan'. If the choice is between Pakistan and hell, I would prefer to go to hell," Akhtar said amid a round of applause from the audience.

The award-winning writer further said it's important to have citizens not subscribing to the ideology of any political party.

"That way they can say what they feel is right and what is wrong. There should be no party loyalty. All parties are ours and yet no party is ours. I'm also one of those citizens. If you speak from one side, you'll make the other side unhappy. But if you speak out from different points of view, you make many more people unhappy," he added. Akhtar, who came to Mumbai at the age of 19, credited the city and Maharashtra for all his achievements.

In his last 30 years of living in Mumbai, the veteran poet said he was given police protection four times on threat perception, out of which three times because of



"mullahs".

Last month, Akhtar said in an interview with PTI there is hardly "any warmth today" in India-Pakistan cultural ties, the veteran screenwriter-poet noted while saying that this is not the time to even think about whether Pakistani artists should be allowed to work in India. His comments came after "Abir Gulaal", a film featuring Pakistani star Fawad Khan, was not allowed to release in theatres in India in the aftermath of the Pahalgam attack. (PTI)

**NEW DELHI, May 19:** Independent films and directors bring fame to India but they don't get enough support once they return home from festival rounds, says actor Nawazuddin Siddiqui, who believes that movies by Anurag Kashyap, Payal Kapadia, and Neeraj Ghaywan have done more to crack the international market than the big Bollywood projects.

According to Siddiqui, indie filmmakers depict characters from the streets and corners of India and reach audiences beyond just the diaspora.

"A lot can happen if such (independent) films are supported. We dismiss them as festival films. They get limited release and the makers of such films don't get any support. But these are the films that bring fame to our country," the actor told PTI in an interview here.

His comments come days ahead of the Cannes Film Festival premiere of Ghaywan's "Homebound" in the Un Certain Regard section on May 21.

Siddiqui, who has travelled to Cannes with eight of his films including Kashyap's much-acclaimed "Gangs of Wasseypur", "The Lunchbox" by Ritesh Batra, and Aseem Ahluwalia's "Miss Lovely", worked with Ghaywan in the second season of web series "Sacred Games".

"Bollywood films are not seen by western audiences typically, these are the films that are watched whether it is Payal Kapadia or Neeraj Ghaywan's movies... These films create an identity for our country because the more local, the more global," he added.

The 51-year-old actor is equally at home with critically-acclaimed films like "Peepli Live", "Monsoon Shootout", and "Manto", as well as commercial hits such as "Badlapur", "Kahaani", and "Bajrangi Bhaijaan".

"In our films, we don't see characters from our society. The characters that you see in our films don't exist in our streets and corners. If you make movies about India, then they earn a name outside because they are real films. The big films, the so-called commercial films, I am sorry, they still have not been able to crack that market but these small filmmakers have already done that." Citing the example of his 2013 film "The Lunchbox", also starring Irrfan and Nimrat Kaur, Siddiqui said many in the western world know about the movie.

"These filmmakers (indie), they may be small because of their budget but they are big filmmakers because of their mind. And these independent filmmakers bring glory to India and

"So, when I met Tom and McQ (nickname for McQuarrie) for the screen test for this, there was, of course, the acting and the dialogue scene that I had to learn... We were interpreting it in different ways, trying lots of different things and improvising with the text," the 43-year-old actor said.

It was followed by a fight sequence to test her ability and fitness level, she added.

"It was sort of discovering where my natural skill set was and what interested me. We learned pretty quickly that I loved working with props and knives, a sleight of hand.



She became a thief based on understanding how I like to move my body with props," Atwell said.

It all felt like a "bespoke collaborative process", she said, describing the experience of working with Cruise, who has headlined the franchise since its inception with 1996's "Mission: Impossible", and Mc-Quarrie, who helmed the last four "MI" films.

"They'd said, 'We're not looking for an actor to fit into a character or to fit into the story. We're looking for an actor that we want to work with. And then we'll create the story and the character with them in mind and around them.'

"This film is an accumulation of all the missions that have gone together in terms of its ambition and what it sets out to achieve emotionally with all the characters," Atwell said.

According to Atwell, what draws her to a project is not just the story or genre, it's all the people she would work with.

LONDON, May 19: England's Test captain Ben Stokes has quit drinking alcohol during his ongoing hamstring injury rehabilitation in an effort to be battle-ready for the upcoming Ashes series against traditional rivals Australia.

The flamboyant cricketer said he gave up drinking at the start of the year in the hope abstinence would hasten his recovery from the iniurv

The 33-year-old Stokes had surgery on his left hamstring in December after suffering a tear during the third Test against New Zealand, which ruled him out of action for a prolonged period.

"After my first major injury, I remember the shock of it and after the initial adrenaline had stopped I was thinking, 'How has this happened?" Stokes told the Untapped podcast.

"(I thought) 'We did have a bit of a drink four or five nights ago, could that have played a part?' It wouldn't have helped.

"Then I was like 'OK, I need to start changing what I do'.'

Stokes tore his hamstring in the Hundred last year and then injured it again during the Test tour of New Zealand.

"I don't think I'll ever be completely sober, but I've not had a drink since January 2. I said to myself: 'Not until I finish my injury rehab and get back on the field'.

Stokes recently unveiled his partnership with zero alcohol spirits company CleanCo, for which he has signed on as an "investor and brand partner".

NEW DELHI, May 19: The BCCI on Monday termed as "speculative and imaginary" the report which claimed that it has decided to pull out of men's Asia Cup and women's Emerging Teams Asia Cup.

A media report, quoting sources, said that BCCI won't let Indian teams compete in the two Asian

Cricket Council (ACC) events at a time when the cricket body is being headed by a Pakistani and just days back the two neighbouring nations were involved in a military conflict. Pakistan's interior minister Mohsin Naqvi, who is also PCB Chairman, holds the position of President in the ACC.

Defending champions India are the hosts for the Men's Asia Cup, to be played in the T20 format, in September while Sri Lanka have been allotted the Women's Emerging Teams Asia Cup.

"Since this morning, it has come to our notice about some news items about BCCI's decision not to participate in the Asia Cup and Women's Emerging Teams Asia Cup, both ACC events. Such news is devoid of any truth as till now, the BCCI has not even discussed



or taken any such steps regarding the ensuing ACC events, leave alone writing anything to the ACC," BCCI secretary Devajit Saikia to PTL

Saikia added that BCCI is focussed on ensuring the smooth conduct of the Indian Premier League (IPL) and the upcoming five-match Test series against England beginning next month.

"At this stage, our prime focus is on the ongoing IPL and the subsequent England series, both men and women. The Asia Cup matter or any other ACC event issue has not come up for discussion at any level, hence any news or report on that is purely speculative and imaginary. (PTI)

Gill is a thinking cricketer, but too Scheffler's fiery celebration at PGA Championship early to judge his Test captaincy shows desire that burns in world's No. 1 player

CHARLOTTE (USA), May 19: Everything Scottie Scheffler did Sunday was expected..When the pressure was on, he hit the fairways he needed to hit. He landed the approach shots he needed to land. And, of course, he made clutch putts he needed to make. It's what everyone has come to depend on from the world's No. 1 player, a fine-tuned, almost mechanical approach to the game

right up until the celebration.

That's when Scheffler, in a rare display of pure emotion, took off his hat and slammed it into the green on the 18th hole after winning the PGA Championship by five shots over Bryson DeChambeau, Harry English and Davis Riley at Quail Hollow. He followed with a hard slap of hands with his caddie and a quick hug, reminiscent of a defensive lineman celebrating a quarterback sack or a basketball player enjoying a high-flying dunk.

A short while later Scheffler was asked to hoist the 27-pound Wanamaker Trophy and he thrust it so hard in the air that the top started to fly off. So much for Scottie Scheffler being a robot.

The raw emotion he displayed Sunday reflects the burning competitiveness that resides within his built-for-golf 6-foot-3, 200pound frame. When asked afterward if he views him-

self as having a competitive fire, Scheffler laughed and said, "Yeah." The calm, even-keeled demeanor on the

Scheffler didn't swing the club all that well for the first 2 1/2 days in Charlotte.

Scheffler ate a sandwich as he made the turn at 2-over-par for the day, then proceeded to drill his drive down the middle of the fairway on the par-5 10th hole. He followed it with a approach shot to within 40 feet of the cup. He two-putted from there for birdie and never trailed again.

Scheffler really didn't need to do much after that point.

From there, it wasn't a matter of Scheffler running away with the tournament as much as it was others running away from him. Rahm failed to make birdie putts on Nos. 14 and 15 and made a mess of the three closing holes known as the Green Mile to take himself out of contention. Scheffler methodically proceeded to secu

## Mental barrier broken, free to push his limits: Gagan Narang on Neeraj breaching 90m mark

NEW DELHI, May 19: The 90-metre "mental barrier" broken, superstar Neeraj Chopra will now strive to push the limits further to attempt tasks that were previously considered out of reach, reckons Olympic medallist shooter Gagan Narang.

Chopra entered the elusive club when he threw the spear at a distance of 90.23 metres at the Doha Diamond League on Friday.

"The monkey is off his back and he is now free to push his limits," Narang told PTI Videos.

"At one limit, that glass ceiling, that mental barrier which probably played on his mind for some time is now broken," Narang said, as the double Olympic medallist Chopra prepares for major events like the upcoming World Championships, in which he will look to defend the title he won two years ago. Chopra, however, finished second to Germany's Julian Weber, who threw 91.06 metres, in Doha.

Narang hailed the achievement as "absolutely phenomenal" and "monumental" for Indian athletics, emphasising its broader significance.

"It's not just about the distance, right? It's about redefining what's possible for Indian sport, especially on the global stage.

This is the first competition of the season for him. And there are many more competitions lined up. So, while it's important to break that



barrier, I think getting the right score is important at the right time.

He stressed "that confidence is very, very important" for Chopra to build on this milestone. Narang, who served as India's Chef de Mission at Paris 2024, drew a parallel with his own experience in shooting, where chasing the perfect 600/600 score was both a mental and physical challenge. "You know, I was shooting 597, 598, 599. But that 600 — the world record mark – was not coming. I took it personally. And one and a half months later, I broke that record.

That mindset — to go beyond what's seen as the limit — is what we're witnessing with Neeraj now." Even as Chopra continues to set benchmarks in Indian athletics, the widening gulf between the 27-year-old and his compatri-

ots is becoming a matter of concern. Narang, however, dismissed such concerns. "I don't see a problem at all. There is an outlier in every sport. At some point, someone has to break the glass ceiling — Neeraj has done that." He likened the trajectory to his own

shooting career, where early world-beating performances took time to be emulated. "He's inspired a whole generation. Now others will start chasing that standard. Some may even surpass it in time."

The 2012 London Olympics bronze medallist further expressed his optimism about the proposed shooting league, scheduled to launch in November 2025.

"We've been thinking about a league for a long time. Indian shooters travel to Germany to compete in Bundesliga - now it's time for something of our own," he said.

According to him, the format - which is expected to include junior, youth, and senior players in each team — will be a major boost for Indian shooting.

"It'll allow juniors to learn directly from seniors, and bring international exposure to the grassroots. That knowledge exchange is invaluable." It remains to be seen if the league can directly impact India's Olympic medal count, but Narang is hopeful. (PTI)
