

Defence secretary meets Modi to apprise him about combat readiness

States asked to conduct drills to prepare for any attack

NEW DELHI, May 5: The Union Home Ministry has asked several states to conduct mock drills on May 7 amid rising tensions with Pakistan following the Pahalgam terror attack, government sources said on Monday.

The measures to be taken during the drill include operationalisation of air raid warning sirens and training of civilians on civil defence aspects to protect themselves in the event of a "hostile attack", they said. The other measures are provisions of crash blackout measures, early camouflaging of vital plants and installations and updation of evacuation plans and their rehearsal.

Prime Minister Narendra Modi has been holding a series of highlevel meetings, including with top defence functionaries, as India weighs its options for countermeasures against the April 22 terror at-



tack which left 26 civilians, mostly tourists, dead.

NEW DELHI, May 5: The Supreme Court on Monday perused a forensic report on authenticity of leaked audio clips alleging role of former Manipur chief minister N Biren Singh in the ethnic violence and asked the state government to file a fresh report pertaining to the probe.

A bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar opened the sealed cover report of the Central Forensic Science Laboratory (CFSL) submitted by Solicitor General Tushar Mehta and asked the law officer to seek instruction from the state officers with regard to investigation in the matter.

"The FSL report has been filed. We need a month to probe it," the law officer said, adding the matter can be taken up by the Manipur High Court now as "peace is prevailing now and the probe can go on".

"Let us keep the petitioners aside and if something wrong has been done then let us look into it rather than protecting anyone," the CJI said.

After perusing the report, the CJI asked the law officer that he will have to speak to the officers about it. 'The solicitor general to take fresh instructions on

filing a fresh report after re-examination. Let it be relisted in the week commencing July 21, 2025," the bench ordered. When lawyer Prashant Bhushan, appearing for petitioner Kuki Organisation for Human



Rights Trust (KOHUR), said the probe pertains to the former chief minister and it should be fair, the CJI said, "Now we have the President Rule there ... it should not be a problem". He then adjourned the hearing on the plea of KOHUR.

Earlier, the state government had informed the bench that a forensic report on the authenticity of leaked audio clips alleging the role of Singh in the ethnic violence was ready and will be filed.

Singh resigned as the chief minister of Manipur on February 9, amid rumblings within the state BJP and growing demands for a change of leadership. Earlier, the top court sought (CONTD. ON PAGE-2)

Campaign ends for final phase Panchayat polls

GUWAHATI, May 5: Campaigning for the second and final phase of panchayat elections in Assam ended on Monday, as ruling and opposition parties wooed rural voters with the promise of all-round development.

Polling will be held in 13 districts of central and lower Assam in 12,130 polling stations on May 7. Chief Minister Himanta Biswa Sarma led the cam-

paign for the BJP and its allies, addressing back-toback rallies during campaigning.

Sarma dwelt on various schemes taken up by his government since he assumed power four years back, with focus on initiatives for women, youth and the marginalised sections. He maintained that schemes for free education and the state government's tough stance against social ills like child marriage and drug abuse have been yielding positive results.

Sarma also slammed the previous Congress governments in his campaign speeches, accusing the grand old party of trying to appease the voters with 'lungi, dhoti, suta (yarn), blanket and mosquito nets" without actually empowering them. Union minister Sarbananda Sonowal and state BJP president Dilip Saikia, among other leaders, also campaigned for the ruling alliance. (CONTD. ON PAGE-2)

GUWAHATI, May 5: Chief Minister Himanta Biswa Sarma on Monday claimed that talking about peace with India is "treated as a crime" in Pakistan, whereas in India, dialogue is "tolerated, debated and even promoted on mainstream platforms".

"To those in India who continue to preach 'Aman ki Asha' without grasping the ground reality -- understand this: In Pakistan, talking about peace with India is treated as a crime. In India, talking about peace with Pakistan is tolerated, debated even promoted on mainstream platforms," Sarma posted on X.

"Romanticising Pakistan while enjoying Indian freedom is not idealism -- it is ignorance at best, hypocrisy at worst and a betrayal of your own motherland," he added. The chief minister listed how Pakistan handles pro-India voices through surveillance and profiling, censorship and takedowns, legal intimidation, arrests and torture, forced disappearances and social boycott and threats.

Regarding surveillance and profiling, Sarma alleged that every post, tweet, or article with pro-India sentiment is tracked by Pakistan's intelligence agencies, especially the ISI, with students, activists, and journalists routinely placed on watchlists. He alleged that Pakistan resorts to censorship and takedowns with the Pakistan Telecommunication Authority (PTA) actively blocking or removing content deemed favourable to India.

"Even hashtags promoting peace or dialogue are erased without explanation," he claimed. Regarding legal intimidation, Sarma alleged that under Pakistan's draconian cybercrime law PECA, people are arrested for expressing anything seen as "pro-India"

Vague charges like "anti-state" and "glorifying the enemy" are used to silence voices of reason, he added.

Citizens have been picked up by intelligence agencies, tortured, and jailed without trial -- often for something as harmless as a poem, a peace appeal, or a balanced article, Sarma alleged.

Regarding forced disappearances, the chief minister alleged that dozens -- especially Baloch, Pashtun, and Sindhi activists -- have "vanished without a trace for expressing support for India or challenging Pakistan's military narrative". Families wait for years, with no answers and no justice, he added. (CONTD. ON PAGE-2)

Russia fully backs India's fight against Japan's House of Representatives-led team winds up 3-day visit to Assam terrorism, Putin tells PM Modi in phone call

GUWAHATI, May 5: A high-level delegation of Japan, led by its Speaker of House of Representatives NukugaFukushiro concluded a three-day visit to Assam on Monday, during which they held discussions with the chief minister and visited several places.

State cabinet minister Nandita Garlosa, along with top officials, bid farewell to the delegation at the Lokpriya Gopinath Bordoloi International Airport here.

"The esteemed Japanese delegation, led by Hon'ble Speaker of the House of Representatives, H.E. Nukaga Fukushiro, concluded their three-day visit to Assam. Hon'ble Minister of Sports and Youth Welfare, Smt. @GorlosaNandita, along with senior officials, bid them farewell at Lokpriya Gopinath Bordoloi International Airport," the Chief Minister's Office said in a post on X.

The over 50-member delegation had reached Guwahati on Saturday evening.

Soon after arrival, Fukushiro and his team had met chief minister Himanta Biswa Sarma and discussed various issues of mutual interest, and later attended a dinner hosted in their honour by the governor and the Speaker of the Assam assembly.

The delegation had on Sunday visited an upcoming Japan-assisted skill training centre and the Indian Institute of Technology (IIT), Guwahati, both at Amingaon, and Tata's proposed semiconductor plant at Jagiroad. This was the fourth high-level delegation visit to the state since Sarma had toured Japan in February, the chief minister said on Sunday.

The Japanese ambassador to India came twice, an industry delegation attended the Advantage Assam business summit, and a team of intellectuals (CONTD. ON PAGE-2)

NEW DELHI. May 5: Russian President Vladimir Putin on Monday conveyed to Prime Minister Narendra Modi in a phone call that Russia fully backs India's fight against terrorism and that the perpetrators of the Pahalgam terror attack must be brought to justice.

A Russian embassy readout said Putin described the terror attack as "barbaric" and that both the leaders emphasised the need for an "uncompromising fight" against terrorism in all its manifestations. It also said that President Putin accepted the prime minister's invitation for the annual India-Russia summit to be held in India this year.

During the conversation with Modi, Putin "strongly condemned the terror attack in Pahalgam" and conveyed condolences at the loss of innocent lives, External Affairs Ministry spokesperson



Randhir Jaiswal said in a social media post

The Russian president was among the first world leaders to condemn the April 22 terror attack that killed 26 civilians.

Putin conveyed "deepest condolences on the loss of innocent lives and expressed "full support" to India in the fight against terrorism. Jaiswal said.

"He emphasised that the perpetrators of

the heinous attack and their supporters must be brought to justice," the MEA spokesperson added.

Both leaders reiterated their commitment to deepen the special and privileged strategic partnership between India and Russia

Modi conveyed his greetings to Putin for the 80th anniversary of the Victory Day and invited him for the annual India-Russia summit to be held in India later this year, Jaiswal said.

The Russian readout said the president once again "expressed his sincere condolences over the death of Indian citizens as a result of the barbaric terrorist attack on April 22 in Pahalgam".

During the conversation, the strategic nature of Russia-India relations as a special privileged partnership was emphasised, it said. (CONTD. ON PAGE-2)

Three arrested for killing wild elephants in MNP

GUWAHATI, May 5: Three persons have been arrested for their alleged involvement in the killing of three wild elephants in Assam's Manas National Park, officials said on Monday.

The three accused were arrested from Chirang district and the police seized two single-barrel muzzle-loading guns, cartridges, walkie-talkie sets and poaching gear from their possession.

Following their arrest, the accused led the police to the recovery of two tusks.

The arrested persons have been identified as JabidBorgoyary, Mahesh Islary and Jaran Basumatary. The carcasses of three wild elephants, allegedly killed by the poachers, were found near the India-Bhutan border in Palengshi

BJP's Sambit Patra meets ex-Manipur ANRF to launch 'small business deep-tech **CM Biren Singh, party MLAs in Imphal**

IMPHAL, May 5: BJP's North East in-charge Sambit Patra on Monday held closed-door meetings with former Manipur chief minister N Biren Singh in Imphal. Patra met Singh at the latter's residence in Luwangshangbam in Imphal East district.

"Some BJP MLAs were also present during the closed-door meeting with Singh, which lasted for more than an hour," party sources said.

Patra then met Speaker Thokchom Satyabrata Singh at his residence in Bamon Leikai. The BJP leader also interacted with a few party MLAs at a city hotel.

Two BJP MLAs, who were part of the discussions with Patra at the hotel, said the talks mainly revolved around the law and order situation in Manipur.

"We discussed ways to restore peace in the hills and the valley. We also talked about the role of security forces. He (Patra) listened to us patiently and assured that our



concerns will be notified to the authorities, party MLA Kh Ibomcha told reporters.

BJP MLA Sapam Kunjakeshor added: The discussions were mostly focused on law and order, and restoration of peace and normalcy. There was, however, no discussion on the recent letter by 21 MLAs to PM Modi and Home Minister Amit Shah about formation of government in Manipur. Another party legislator, Th Shvamkumar, who met Patra, said

once peace is restored in the state, a popular government can be automatically formed .

As there is an ongoing conflict, the Centre seems more focused on bringing back peace first... All the BJP MLAs are part of one family. We had discussions on government formation in Manipur. Presidents' Rule cannot be imposed for long. The assembly has to be dissolved if it exceeds six months, the legislator from Andro constituency said. (CONTD. ON PAGE-2)

NEW DELHI, May 5: In a significant step aimed at boosting innovation, India is set to launch a 'small business deep-tech innovation'programme to empower startups and MSMEs to scale breakthrough technologies for realworld applications.

The newly-launched Anusandhan National Research Foundation (ANRF) will help the initiative, Union Science and Technology minister Jitendra Singh said on Monday after a review meeting.

Singh called for bold new directions in science-driven growth, including AI-led innovations, deep-tech start-ups and greater infrastructure sharing.

The meeting witnessed the minister focus on the evolving role of the ANRF as well as ongoing national missions such as the geospatial initiative. Abhay Karandikar, the science and technology depart-



naraman and other senior officials attended the meeting.

Kalyanaraman presented an ambitious vision for the ANRF, promcatalvtic ising mechanisms, deep integration with

infrastructure, the minister reviewed ANRF's plan to create a 'cloud of research and innovation infrastructure', a digital platform that would offer deep-tech startups and academic institutions access to underused scientific equipment and facilities across the country. This move is expected to democratise research capabilities, especially for smaller players who often lack access to high-end lab tools, Singh said

The minister directed the ANRF to engage with vice-chancellors of universities to raise awareness about its mission and opportunities for collaboration.

Singh also asked the ANRF to explore the possibility of helping medical colleges establish their own medical research parks -- a move that could boost clinical in-Recognising the need to better novation and local biotech entrepreneurship. (PTI)

Sensex rises nearly 295 pts to close at 2025-high on foreign fund inflows, drop in crude prices

MUMBAI, May 5: Benchmark BSE Sensex climbed nearly 295 points to close at an over fourmonth high on Monday following sustained foreign fund inflows and a sharp correction in global crude oil prices.

Rising for the second in a row, the 30-share BSE barometer gained 294.85 points or 0.37 per cent to settle at \$0,796.84, marking its highest close in 2025 so far. During the day, it jumped 547.04 points or 0.67 per cent to 81,049.03.

The NSE Nifty rose 114.45 points or 0.47 per cent to 24,461.15, its highest closing level in 2025

Among Sensex firms, Adani Ports jumped 6.29 per cent amid reports that Gautam Adani's representatives met with US administration officials to seek the dismissal of criminal charges in a bribery probe. All other listed Adani group stocks, including Adani Enterprises, Adani Ports, Adani Power and Adani Green Energy, ended with sharp gains.

Bajaj Finserv, Mahindra & Mahindra, Eternal, Power Grid, ITC, Tata Motors, Asian Paints and Hindustan Unilever were also among Sensex gainers.

Experts urge stronger response as asthma remains widely undiagnosed

HT Bureau GUWAHATI, May 5: On the occasion of World Asthma Day, health experts have raised concerns over the widespread underdiagnosis of asthma in India, urging for a more robust national response to the chronic respiratory condition.

According to an official statement, nearly 70% of individuals experiencing severe asthma symptoms remain undiagnosed, while fewer than 2.5% of patients use inhaled corticosteroids daily-the recommended course of treatment.

This year's World Asthma Day, themed "Make Inhaled Treatment Accessible for All" by the Global Initiative for Asthma (GINA), comes at a time when asthma and other chronic respiratory diseases have become leading contributors to Non-Communicable Disease (NCD) related deaths in the country.

NCDs are responsible for over half of all fatalities across India, making effective asthma management a growing public health priority.

Dr Smitakshi Medhi, Consultant Pulmonologist in Guwahati, highlighted the critical need for timely diagnosis, proper inhaler technique, and consistent adherence to treatment in order to manage asthma effectively.

"The primary goals of asthma management are to control symptoms, reduce dependence on rescue medication, prevent hospitalisations, and preserve lung function-ultimately improving quality of life," she said, "Unfortunately, these areas are often hindered by poor device technique, limited access to care, and a lack of long-term support.

Initiatives such as Cipla's "Breathefree" program, which reportedly reached over one crore people in the 2024-25 financial year alone, are helping to bridge these gaps

"Breathefree" includes on-ground screening camps, digital educational tools, and instructional videos that aim to improve understanding and use of inhalation therapy

In a high-level meeting with the top defence brass, Prime Minister Modi on April 29 gave the armed forces "complete operational freedom" to decide on the mode, targets and timing of the response to the Pahalgam terror attack. Modi also emphasised the national resolve to deal a "crushing blow to terrorism". Amid the escalating tensions between the two sides, the Pakistan military has been resorting to unprovoked firings" using small arms from their posts across the LoC in the last few days.

The Pakistan Army resorted to unprovoked firings on Sunday night as well. "During the night of May 4 and 5, Pakistan Army posts resorted to unprovoked small arms fire across the LoC in areas opposite Kupwara, Baramulla, Poonch, Rajauri, Mendhar, Naushera, Sunderbani, and Akhnoor in Jammu and Kashmir," said a Indian military source. India on April 23 announced a raft of punitive measures against Pakistan including suspension of the Indus Waters Treaty, shutting down of the only operation land border crossing at Attari and downgrading of diplomatic ties in view of cross-border links to the attack.

In response, Pakistan shut its airspace to Indian airliners and suspended all trade with India, including through third countries. Pakistan rejected India's suspension of the Indus Waters Treaty and said any move to stop the flow of water will be seen as an "act of war". (PTI)

SC seeks fresh report

a sealed-cover forensic report from the CFSL on the authenticity of the leaked audio clips alleging Singh's role in the ethnic violence that began in May 2023. KOHUR had sought a court-monitored SIT probe into Singh's alleged role. Bhushan termed the contents of the audio leaks a "very serious matter" and said Singh was purportedly heard saying that Meitei groups were allowed to loot arms and ammunition of the state government. "I have annexed transcripts of tape recordings," he added.

The solicitor general said the petitioner had "ideological inclinations" and there was a report by a committee of three high court judges which stated that there were efforts to keep the "pot boiling". "A truth lab confirmed that 93 percent it is the voice of the chief minister," Bhushan said, adding "truth labs are far more reliable than the FSL reports." The law officer, however, questioned the veracity of the truth lab report.

On November 8 last year, a bench headed by former CJI D Y Chandrachud directed KOHUR to produce material to indicate the authenticity of some of the leaked audio clips. Bhushan had said he would also file a copy of the tape in a CD format. Mehta, however, said the plea could be filed in the high court under Article 226 of the Constitution. More than 260 people have been killed and thousands displaced since the ethnic violence broke out between the Imphal valley-based Meitei and neighbouring hills-based Kuki communities in May 2023. The clashes began after a 'Tribal Solidarity March' was organised in the hill districts to protest against an order of the Manipur High Court on the Meitei community's demand for Scheduled Tribe status.

Bhushan alleged that the recorded conversation prima facie showed the complicity and involvement of the state machinery in the violence against the Kuki Zo community. He said the clips had "disturbing conversations" and Singh could be heard instigating the violence and protecting the attackers.

KOHUR's plea alleged that Singh was instrumental in "inciting, organising and thereafter centrally orchestrating the large-scale murder, destruction and other forms of violence against the Kuki-dominated areas in Manipur". "Petitioner is praying for a court-monitored investigation by special investigation team into the leaked audio tape clips as there is clear and strong prima facie evidence showing involvement of the highest functionary, i.e., chief minister of a state. The investigation would need to unearth the conspiracy which appears to involve the highest functionary of state," it said. (PTI)

Sarma alleged that Pakistan also resorts to social boycott and threats and those who speak about peace or acknowledge India's achievements are ostracised, branded traitors, and often threatened by extremist elements. World Bank ED Parameswaran Iver to represent India at IMF board

NEW DELHI, May 5: Parameswaran Iyer, Executive Director at the World Bank, has been temporarily entrusted with the responsibility of being India's nominee director on the board of International Monetary Fund (IMF) ahead of a crucial May 9 meeting, sources said.

Iver's nomination was necessitated to fill a vacancy created with the termination of services of K V Subramanian as the executive director at the IMF, six months ahead of his three-year tenure.

The government's decision assumes significance as the IMF Executive Board will meet on May 9, to take a call on a new USD 1.3 billion loan under a climate resilience loan programme, along with the first review of the ongoing USD 7 billion bailout package for Pakistan.

NEW DELHI, May 5: Moody's Ratings on Monday said sustained escalation of tensions between India and Pakistan will not have any major economic disruption in the country, but will be a setback for Islamabad as its forex reserves could come under pressure and weigh on growth.

In its commentary titled 'Escalating Pakistan-India tensions would weigh on Pakistan's growth', Moody's said it does not expect major disruptions to India's economic activity because it has minimal economic relations with Pakistan (less than 0.5 per cent of India's total exports in 2024).

On April 22, 26 people were killed after terrorists opened fire on tourists in Pahalgam, Jammu & Kashmir. India has identified five terrorists, including three Pakistani nationals, behind the massacre in Pahalgam and has pledged to take action against the perpetrators of the heinous act

"Sustained escalation in tensions with India would likely weigh on Pakistan's growth and hamper the government's ongoing fiscal consolidation, setting back Pakistan's progress in achieving macroeconomic stability," Moody's said.

Pakistan's macroeconomic conditions have been improving, with growth gradually rising, inflation declining, and foreign-exchange reserves increasing amid continued progress in the IMF programme.

"A persistent increase in tensions could also impair Pakistan's access to external financing and pressure its foreign-exchange reserves, which remain well below what is required to meet its external debt payment needs for the next few years," Moody's said. The Executive Board of the International Monetary Fund (IMF) is scheduled to meet Pakistani officials on May 9 to evaluate a fresh USD 1.3 billion funding arrangement for Pakistan under its climate resilience loan programme. It will also assess an ongoing USD 7 billion bailout package.

Moody's rates India at 'Baa3', which is the lowest investment-grade rating. Citing "cross-border linkages" to the April 22 attack, India has promised severe punishment to those involved in the strike.

Following the deadly terror attack, India and Pakistan's diplomatic relations have deteriorated. India suspended the Indus Waters Treaty of 1960, which could severely reduce Pakistan's water supply, shut down the only operational land border crossing at Attari and downgraded diplomatic ties.

In response, Pakistan suspended the 1972 Simla peace treaty with India, halted bilateral trade and closed its airspace to Indian airlines.

The number of Zila Parishad (ZP) constituencies stands at 181, Anchalik Parishads (AP) at 87 and Gaon Panchayat (GP) constituencies at 10,530. As many as 1,289 candidates have won uncontested - 21 ZP members, 151 AP members and 1,117 GP ward members, the officials said. Polling in the first phase was conducted in 14 districts of Tinsukia, Dibrugarh, Charaideo, Sivasagar, Majuli, Jorhat, Golaghat, Dhemaji, Lakhimpur, Sonitpur, Biswanath, Cachar, Hailakandi and Sribhumi. The rural body polls are not held in seven districts of the state, which are under the Sixth Schedule of the Constitution and have autonomous council polls. (PTI)

The media in the country, quoting Foreign Affairs Ministry officials, have published sketchy information on the so-called humanitarian corridor. The Interim Government has yet to spell out details of the plan, which has raised suspicion which is now mixed with conspiracy theories.

The United Nations wants to dispatch food, medical supplies and other essentials to Rakhine, where silent famine persists.

The United Nation Development Program (UNDP) in an assessment report released in November 2024, painted a grave situation in the Rakhine state. It said the people caught in the civil war are experiencing a near famine and proposed that immediate food. medical aid, agriculture inputs, construction materials and other essentials need urgent attention from the international aid agencies.

UNDP report stated that Rakhine is on the verge of an unprecedented disaster due to a combination of interlinked issues. Restrictions on goods entering Rakhine, both internationally and domestically, have led to a severe lack of income, hyperinflation, and significantly reduced domestic food production. Essential services and a social safety net are almost non-existent, leaving an already vulnerable population at risk of collapse in the coming months.

The report shows that Rakhine's economy has become almost dysfunctional. Critical sectors such as trade, agriculture, and construction have halted. Export-oriented, agrobased livelihoods are disappearing as markets become inaccessible due to blockades by the junta

UN warns that Rakhine faces the imminent threat of acute famine. The worst victims of a lack of food are millions of internally displaced persons (IDPs), including Rohingyas.

In the last couple of months, a fresh influx of Rohingya Muslims in Bangladesh has added to the already 1.2 million languishing in overcrowded camps in Cox's Bazar, in Southeast Bangladesh.

However, there is no specific assessment of the number of IDPs in Rakhine, as they spread over the forests, hills and banks on the riverfront. The IDPs do not live in permanent shelters. They live in makeshift camps. The worst victims of internal displacement are children, women and elderly persons. They are suffering from severe malnutrition, communicable diseases and the absence of healthcare.

UN wants to address an unfolding humanitarian crisis in Rakhine and said it is only Bangladesh, its immediate neighbor separated by a kilometer-wide Naf River can

The United States Army Pacific (US-ARPAC) stationed in Hawaii is supposed to provide logistics and security for the IDPs in Rakhine state.

It is reported that the US military will be deployed for the logistics at the corridor at Silkhali, a small river port. The site has been secured by the Bangladesh Army, a no go for the civilians. The army would only facilitate logistics for the UN operation, said a senior government official, who is privy to the corridor.

UNDP report says that internal rice production is declining due to a lack of supplies of seeds, fertilizers, severe weather, and a rise in the number of IDPs that could no longer engage in agricultural production after the civil war erupted and repeatedly relocating to safer places has further exacerbated the miseries.

The UN estimates that with the near-total halt of trade, over 2 million people are at risk of starvation.

When UN Secretary-General Antonio Guterres visited the camps and had Iftar (food for breaking the fast in Ramadan) with the refugees, he told the Bangladesh authorities that a "humanitarian corridor" needed to be opened to reach the hungry people.

Before leaving Dhaka after a visit to Cox's Bazar Rohingya camps, in mid-March, Guterres said he had discussed with Bangladesh authorities the possibilities of a humanitarian corridor would connect inside Myanmar as a means of creating conditions for Rohingya repatriation to Rakhine with the rebel Arakan Army which has captured except for few places resisted by the Myanmar military troops.

He said it would, however, require the "authorization and the cooperation of the parties to the conflict" in Rakhine, where the Ayanmar junta is fighting the rebels, which has further caused frustration, pain and agony for the IDPs. On the other hand, Tarique Rahman, the supremo of Bangladesh Nationalist Party (BNP), said from his London office, cautioned the Interim Government that such a decision can only be taken by the parliament.

Presently, there is no parliament, and the upcoming election is scheduled for the first half of 2026, after the Ramadan and Eid holidays. Therefore, the hungry people in Rakhine will have to wait for at least a year until an election is held in Bangladesh and a parliament begins to function.

Meanwhile, top US officials visiting Bangladesh a fortnight ago held secret meetings in Bangladesh with hybrid representatives of the United League of Arakan (ULA), a political wing of AA and Chin National

The CNA and ULA are members of the United Nationalities Federal Council (UNFC), a coalition of opposition groups that aims to establish a federal system in Myanmar or achieve levels of autonomy and peace among the country's various ethnic minorities.

Nobel laureate Aung San Suu Kyi, under house arrest and accused of sedition, is incommunicado. The former senior leaders of her party who could evade arrest and have gone underground safely are earnestly working with the ethnic rebels under the banner of UNFC.

Bangladesh Foreign Adviser Touhid Hossain told journalists that the Interim Government agreed in principle with the UN proposal on the corridor, but certain conditions must be met for its implementation.

A day later, BNP Secretary General Mirza Fakhrul Islam Alamgir slammed the interim government for making such a move without consulting the political parties.

"An interim government has no authority to make such a policy decision," reads the statement by President Mohammad Shah Alam and General Secretary Ruhin Hossain Prince of the Communist Party of Bangladesh (CPB).

The CPB questioned that the West's sudden interest in the Rohingya issue was "part of a broader imperialist conspiracy"

The Islamist party Jamaat-e-Islami's Ameer (chief), Shafiqur Rahman said the humanitarian corridor requests that the government make the issue transparent to the nation because it might involve many security issues.

Radical Islamic platform Hefazat-e-Islam Bangladesh's fiery leader, Secretary General Mamunul Haque, opposing the move, said, "Imperialist powers are trying to implement their agenda by using Bangladesh. As a patriotic force, Hefazat-e-Islam does not support this in any way."

In response to the concerns of the political party leaders regarding the humanitarian corridor being premature, said Shafiqul Alam, press secretary to the Chief Advisor Prof Muhammad Yunus.

To pacify the political parties, the government quickly said nothing had been finalized regarding the corridor. But said that the government would be willing to provide logistic support should there be UN-led humanitarian support to the state of Rakhine, said Khalilur Rahman, the National Security Adviser in charge of Rohingya issues, told French news agency AFP. Luis Arce, elected in 2020, candidate for the Movement to Socialism Party (MAS) and former economics minister under President Evo Morales, will head the list. Longtime MAS leader Morales is a presidential candidate, too. The new "Evo, the People" (Evo Pueblo) party held a three-day gathering in Chapare state, Morales's home base, in late March; attendance topped 70,000.

The divisions in Bolivia, along with various social and political instabilities, have put the country's socialist beginnings in a state of vulnerability. Most Bolivians face the prospect of returning to lives of misery, and U.S. intervention is waiting in the wings.

Morales's presidency achieved much. A new constitution established the pluri-national state and gave political rights to indigenous peoples. By nationalizing oil and gas production, the government gained funding for expanded education, healthcare, and support for mothers, children, and the elderly. GDP tripled, poverty fell, wealth inequalities diminished, and international currency reserves accumulated. Morales became a symbol and spokesperson for environmental sustainability.

Then came troubles. They've worsened amid political divisions and destabilization episodes. The selling price for exported natural gas fell, and the country's deposits turned out to be more limited than first thought. (However, discovery of a huge natural gas field was announced in July 2024.) Funding for social programs and for imports of gasoline, diesel fuel, and food went downhill.

Government agencies borrowed from the central bank to maintain programs and access to supplies. The bank drew upon the nation's currency reserves, which have almost disappeared. Dollars, in demand to pay for everyday items, are scarce. Inflation, shortages, and discontent continue.

Old political divisions have also taken on new life. Having accused U.S. Ambassador Philip Goldberg of conspiring with the opposition, Morales expelled him in 2008, along with the U.S. Drug Enforcement Administration. He expelled USAID in 2013.

Big landowners, oil and gas producers, and their proxies in Bolivia's four eastern states, particularly in Santa Cruz, mounted a rebellion with separatist and racist overtones in 2008. It failed, but not before causing significant social damage and splits.

Separately, sections of the Bolivian Workers Confederation opposed certain government initiatives. Indigenous groups fought against a new government highway passing through a large preserve.

Morales also faced major controversy over the legitimacy of his third presidential term and the fourth one that would have followed his electoral victory in October 2019. But a coup led by right-wing conspirators, including the Santa Cruz rebels of 2008, took down his government in November 2019. Morales escaped to Mexico, while U.S. support enabled the coup against him to succeed.

The coup government named Jeanine Áñez as president and arranged for elections. From exile in Argentina, Morales nominated former economics minister Arce as the MAS presidential candidate in

government nominees to reaffirm his political...authority." Morales led a march in 2021 that defended Arce against far-right attacks, but the unity didn't last.

By 2023, Morales was actively seeking re-election, even though a Constitutional Court ruled against another Morales term. He also faced charges of sexual abuse of a minor. Morales abandoned the MAS party completely in 2024 after Arce-supporting Grover Garcia replaced him as party president.

By late 2024, the split between the two former MAS colleagues was profound. In September, Morales marched with supporters from Caracollo in Oruro Department to La Paz, led protests and vigils against Arce's policies, encouraged highway blockades, and carried out a five-day hunger strike.

Ethnic division may be playing a role, with Arce supposedly speaking for Bolivia's mestizo population and Morales, Bolivia's first indigenous president, representing indigenous peoples.

Destabilization has returned in full force. In June 2024. Gen. Juan José Zúñiga sought to arrest Morales for his presidential ambitions. He later led troops and armoured vehicles in attacking government office buildings in La Paz, in the process demanding freedom for the jailed 2019 coup leaders. In doing so, according to one report, he revealed his right-wing political orientation and longing for U.S. intervention. Stirring the pot of mutual accusations, the now-imprisoned Gen. Zúñiga recently told an interviewer that, in attacking the government, he and his associates had been following President Arce's instructions to carry out a "self-coup" that would promote discontent in military ranks and ultimately an armed uprising. Zúñiga accused Arce of manipulating the list of potential voters ahead of the upcoming elections. The overflow of complaints on social media about

shortages of basic supplies is also destabilizing. The apparent object is to create panic and generate demand for black-market dollars.

Observer Pablo Meriguet notes refusal by the strongest center-right opposition candidates to unite in a single campaign, specifically veteran politicians Samuel Doria, Manfred Reyes, and Jorge Quiroga. He sees this as improving the electoral prospects of either Arce or Morales. The young senate president and former MAS politician Andrónico Rodrigues, also running for president, has confusedly made overtures to right-wing business leaders.

U.S. government officials have long categorized the ascendency of the MAS government in Bolivia with dangers they perceive from Cuba, Venezuela, and Nicaragua. How do celebrities influence society?

elebrities wield an extraordinary amount of influence over society, shaping cultural norms, consumer behavior, political discourse, and even individual aspirations. Celebrities like Gwyneth Paltrow, through platforms like Goop, have popularized wellness trends such as clean eating and alternative therapies, often shaping consumer habits despite debates over their scientific validity. The economic impact is staggering-celebrity endorsements drive billions of dollars in sales annually, as brands leverage their star power to capture market share. Celebrities shape societal values and behaviors by serving as role models, particularly for younger audiences. Fans often look to them for cues on how to live, love, and express themselves. This can have profound effects, both positive and negative. On one hand, celebrities who embody resilience, kindness, or ambition can inspire others to pursue their goals. For example, athletes like Serena Williams have motivated countless individuals to break barriers and strive for excellence, particularly in underrepresented communities. On the other hand, the glorified lifestyles of some celebritiesmarked by wealth, glamour, and excess-can foster unrealistic expectations. The curated images on social media, often filtered and staged, can lead to feelings of inadequacy among fans, contributing to issues like body dysmorphia or low self-esteem. Studies have shown that heavy exposure to celebrity culture correlates with increased anxiety and dissatisfaction, especially among adolescents who internalize these idealized standards. Celebrities also play a significant role in shaping public discourse, particularly on social and political issues. Their platforms give them a megaphone to advocate for causes, and many use this power to raise awareness and drive change. For instance, Leonardo DiCaprio has long championed environmental conservation. using his fame to spotlight climate change and fund conservation efforts. Similarly, stars like Oprah Winfrey and Rihanna have addressed issues like racial justice, gender equality, and education, influencing public opinion and inspiring activism. During the Black Lives Matter movement, celebrities amplified messages of justice, encouraging their followers to engage in protests or donate to relevant causes. These efforts can galvanize millions, as fans often trust and emulate the values of their idols. However, celebrity activism is not without criticism. Some argue that it can oversimplify complex issues or center the celebrity rather than the cause itself. When stars speak on topics they are not wellversed in, they risk spreading misinformation or diluting the message, which can undermine genuine advocacy.

Taylor Swift endorsed a candidate in the 2018 midterm elections, voter registration spiked, particularly among young people. Similarly, during the 2020 presidential election, celebrities like Cardi B and John Legend used their platforms to encourage civic participation. This influence stems from their ability to reach demographics that traditional political messaging often misses, such as younger or less engaged voters. However, this power can also polarize, as fans may reject celebrities who take stances they disagree with, leading to backlash or "cancel culture." The political weight of celebrity voices underscores their role as cultural influencers, capable of shifting the needle on public opinion.

Yet, the influence of celebrities is not always intentional. Their actions, even when private, can spark societal trends or controversies. Paparazzi culture and tabloid media thrive on exposing celebrity scandals, which often shape public conversations about morality, relationships, and personal responsibility. For instance, high-profile divorces or legal troubles, like those of Brad Pitt or Kanye West, dominate headlines, prompting discussions about marriage, mental health, or the pressures of fame. These moments can humanize celebrities, but they also feed a voyeuristic culture that scrutinizes their every move. The public's fascination with celebrity missteps can distract from more pressing societal issues, yet it also reflects how deeply their lives resonate with audiences.

The psychological impact of celebrity influence cannot be overstated. Fans often form parasocial relationships with celebrities, feeling one-sided bond that mimics friendship or intimacy. This dynamic makes their influence more potent, as fans are more likely to trust and emulate someone they feel connected to. For example, when a celebrity like Demi Lovato speaks openly about mental health struggles, it can destigmatize seeking help and encourage fans to prioritize their well-being. Conversely, when celebrities engage in problematic behavior—such as promoting harmful diets or making insensitive remarks-it can normalize those actions among impressionable audiences. The responsibility of this influence is a topic of debate. Should celebrities be held accountable for the impact of their words and actions, or is it the

Mother Tongue as Medium of Instruction

anguage is not just a tool for communication; it is the soul of thought, the vessel of culture, and the bridge between generations. When a child takes their first steps into the world of learning, they do so through the language they know best-their mother tongue. It is through this language that they learn to express emotions, understand relationships, and make sense of the world. And yet, for millions of children, formal education begins not in this familiar linguistic environment but in a completely alien one, where the language of instruction differs from the language of their home. This disconnect often becomes the silent barrier that undermines the very purpose of education. It is in this context that the case for mother tongue as the medium of instruction emerges not just as a cultural imperative, but as a practical, psychological, and pedagogical necessity.

In the Indian context, where linguistic diversity is as vast as its geography, the debate around the medium of instruction takes on special significance. India is home to hundreds of languages and dialects. Yet, in many urban and even semiurban areas, English continues to be the dominant language of instruction, while in several others, state languages are imposed on children whose mother tongue may be a tribal or minority language. This results in a fundamental conflict between the language of thought and the language of instruction. Children who enter school with a language unfamiliar to them often find themselves bewildered, unable to follow lessons or engage meaningfully in classroom discussions. This early alienation can have long-lasting effects, leading to a lack of confidence, poor academic performance, and, in many cases, early dropout from school

The cognitive and psychological benefits of mother tongue-based education are well-established. Studies from around the world have consistently shown that children learn best when they are taught in their mother tongue during the early years of education. This is because the brain processes concepts more efficiently when they are introduced in a language already known to the learner. In contrast, when a new concept is introduced in an unfamiliar language, the child first struggles to decode the language and then attempts to understand the concept, creating a double burden. This not only slows down the learning process but also increases the chances of misinterpretation and rote learning. On the other hand, when the child understands the language of instruction, the mind is free to focus on learning the concept itself.

Moreover, the use of the mother tongue in education nurtures emotional and social development. A child who can interact in class, ask questions, and share ideas in their own language is more likely to feel

included, respected, and confident. This sense of inclusion fosters a positive attitude towards school and learning. It also strengthens the child's sense of identity and pride in their cultural heritage. In contrast, when children are forced to suppress their native language in favour of another, they may internalize a sense of inferiority regarding their own culture, leading to issues of self-worth and disconnection from their roots. The argument for mother tongue instruction is not a rejection of global or national languages. Rather, it is a call for a more grounded and inclusive approach to education. Multilingualism is a strength, and India is perhaps the best example of how multiple languages can coexist within a single nation. English and Hindi have their own importance and utility, especially in higher education and in accessing global opportunities. But their place in the education system should not come at the cost of neglecting the mother tongue during the foundational years of learning. Language acquisition is not a zero-sum game. A strong foundation in the first language actually facilitates the learning of second and third languages later in life. The goal should be to create an additive model of language education, where the mother tongue is the base upon which other languages are gradually and effec-

The New Education Policy (NEP) 2020 of India has made a significant step in this direction by recommending the use of the mother tongue or regional language as the medium of instruction until at least Grade 5, and preferably up to Grade 8. This recommendation is based on pedagogical research and aims to make education more accessible, inclusive, and effective. However, for this policy to succeed, it must be backed by concrete implementation strategies. This includes developing high-quality teaching and learning materials in various regional languages, training teachers to teach effectively in mother tongues, and sensitizing parents and communities about the long-term benefits of mother tongue education.

tively introduced.

One of the common challenges faced in implementing mother tongue-based instruction is the perception among parents that English-medium education is superior and necessary for their children's future success. This perception is not without reason. In many cases, English-medium schools do offer better resources, infrastructure, and opportunities. English is seen as the language of aspiration, upward mobility, and global access. As a result, parents, especially those from marginalized communities, often prefer to send their children to English-medium schools, even if the child struggles to cope. However, it is essential to separate the language of instruction from the quality of education. A good school should be defined by its ability to teach effectively, not merely by the language it uses.

Governments and educational planners

need to address this perception gap by improving the overall quality of mother tongue schools. This includes investing in infrastructure, curriculum development, teacher training, and community outreach. Public awareness campaigns can play a critical role in changing mindsets and highlighting the advantages of early education in the mother tongue. Examples from countries like Finland, Ethiopia, and Papua New Guinea, where mother tonguebased multilingual education has been successfully implemented, can serve as valuable models.

Another important aspect is the availability of textbooks and digital resources in diverse languages. In an age where digital learning is becoming more prominent, the lack of content in regional and tribal languages puts a large section of students at a disadvantage. Government agencies, publishers, and ed-tech companies must work together to ensure that high-quality educational content is available in all mother tongues. This will not only improve learning outcomes but also help preserve and promote linguistic diversity.

Teachers are the backbone of any education system, and their role becomes even more crucial in the context of mother tongue instruction. Many teachers themselves may not have received training in their own language or may be products of English or state-language education systems. Capacity-building programmes must be initiated to train teachers in effective pedagogical methods that are aligned with mother tongue instruction. Furthermore, teachers should be encouraged to use culturally relevant examples, stories, and references in the classroom, making education more relatable and meaningful to the students. Ultimately, the success of mother tongue-based education depends on a collective effort from policymakers, educators, parents, and communities. It requires a shift in mindset—from viewing language as a barrier to recognizing it as a bridge. Education should be about empowering children to think critically, express creatively, and learn joyfully. For that to happen, we must speak to them in the language they understand best-not just linguistically, but emotionally and culturally.

In conclusion, the mother tongue is the first language of the heart and the mind. It is the foundation upon which all other learning is built. Denying children the opportunity to learn in their mother tongue is denying them the right to an education that is truly meaningful and effective. As we envision a future that is inclusive, equitable, and rooted in local contexts, the use of mother tongue as the medium of instruction must not remain a policy on paper but must become a reality in classrooms across the country. The intestines sit in the abdomen and absorb nutrients and some water. Below, learn about the small and large intestines in more depth:

Small intestine

Food broken down by the stomach moves into the small intestine, which absorbs nutrients and sends them into the bloodstream.

Three major classes of nutrients pass through the small intestine:

mune system. As an older study, from 2011, suggests, the small intestine's role in keeping bacteria under control is crucial and requires further investigation.

How long is the small intestine? The small intestine is roughly 20–25 feet in length, making it the longer section. It has

in length, making it the longer section. It has a very high surface area, which is amplified roughly 60-120 times The small intesting is not flat on smooth

The small intestine is not flat or smooth. Instead, the following characteristics help maximize its surface area and capacity for absorption:

• mucosal folds — intricate folds on the intestine's surface

• villi — tiny, finger-like projections that line the inner wall of the intestine

• microvilli — even smaller, hair-like projections on the villi

Large intestine

The large intestine absorbs water, salt, and other waste material from the digestive product and solidifies the waste into stool, which passes into the rectum.

The large intestine has several several parts, including:

• The cecum: This section receives the digestive product from the small intestine and moves it to the colon.

• The appendix: This is a finger-shaped pocket that joins with the cecum.

• The colon: This is the longest part of the large intestine. It absorbs water and salt and

Conditions that affect the intestines Various health issues can affect the intestines. For example, a person may develop: Constipation

Constipation involves the GI tract struggling to pass stool. It may result from a low fiber or fluid intake, hormonal imbalances, or a lack of mobility. Constipation can also be a side effect of medication.

It is more common in older people than younger people. Eating more fiber, drinking plenty of fluids, and getting regular exercise may help ease constipation. A person might also try over-the-counter fiber supplements and laxatives.

Viral gastroenteritis

Viral gastroenteritis is also called the stomach flu. It results from an infection and can cause cramps, watery diarrhea, nausea, vomiting, and a fever. The symptoms may last from a few days to 10 days.

The stomach flu accounts for 19–21 million cases of diarrheal illness annually in the United States.

The key is to maintain hydration and replace electrolytes. To address specific symptoms, such as diarrhea, over-the-counter medications, such as loperamide (Imodium), can help.

Irritable bowel syndrome

This condition, usually called IBS, is characterized by abdominal pain, bloating, and changes in bowel habits. It affects around 25– 45 million people in the U.S.

The exact cause is unknown, but the authors of one review observe that specific bacteria tend to be associated with it.

The right treatment depends on the person's symptoms, but the results of a 2019 review suggest that a holistic approach, including personalized probiotic therapy and diet modifications, may be best.

Celiac disease

Over time, in a person with celiac disease, the gluten in wheat damages the small intestine so that it no longer absorbs nutrients as efficiently. Symptoms vary, from diarrhea and abdominal pain to irritability and depression. Adopting a gluten-free diet is a key element of treatment.

Crohn's disease

Crohn's disease causes chronic inflammation in the GI tract. It most commonly affects the end of the small intestine and the juncture with the large intestine.

Because the symptoms of this inflammation also stem from many other health issues, a doctor may refer the person to a specialist, called a gastroenterologist, for further testing and a diagnosis.

The frequency and severity of symptoms can vary from person to person. Treatment involves taking medication, including biologic

Colorectal cancer

Depending on where the abnormal cells first form, the doctor may refer to colorectal cancer as bowel, colon, or rectal cancer. Taken as a whole, colorectal cancer is the third most common cancer diagnosed in adults in the U.S.

A variety of tests can detect colorectal cancer, including a colonoscopy, a CT scan, and a biopsy. Most early forms of the cancer cause no symptoms, so screening and early intervention are crucial.

Symptoms of colorectal cancer include:

- diarrhea or constipation
- blood in stool, making it look black
- bleeding from the rectum

• a feeling of fullness, pain, or bloating in the abdomen

- fatigue
- unexplained weight loss

The most common treatment is surgery, though the advisability of this depends on the tumor's size and location and on the stage of the cancer.

Prevention

Not all intestine-related health problems are preventable, but there are several ways to look after the gut, including:

• eating a healthful diet that is rich in protein, fiber, and complex carbohydrates

- staying hydrated
- managing stress levels
- quitting smoking and avoiding secondhand smoke

When to see a doctor

If stomach or gut pain lasts for more than a few days and does not ease with home care, contact a doctor.

Also, a person should receive medical attention if they have:

• a flare-up of symptoms of a known health issue

• a loss of appetite combined with tiredness and fatigue

- blood in stool
- intense, severe pain that lasts hours **Takeaway**

Pak threatens nuclear response if India attacks or disrupts water flow

MOSCOW, May 5: Pakistan will respond with "full spectrum of force", including nuclear, if it is attacked or its vital water flow disrupted. Pakistan's ambassador here has warned amid tensions between New Delhi and Islamabad after the Pahalgam terror attack.

Muhammad Khalid Jamali made the comments during an interview with Russia's state-run TASS news agency on Sunday.

Warning that Pakistan was prepared to respond to any aggression, the ambassador said, "We in Pakistan will use the full spectrum of force, both conventional and nuclear.'

Ties between India and Pakistan plummeted following the April 22 Pahalgam terror attack in Jammu and Kashmir that killed 26 people, mostly tourists.

Jajamali reiterated Islamabad's position regarding the Indus Water Treaty, a key agreement between India and Pakistan, which New Delhi suspended last week as a part of its diplomatic response to the terror attack

"Any attempt to usurp the water of the lower riparian, or to stop it, or to divert it would be an act of war against Pakistan and would be responded to with full force, including nuclear," he said.

Following the Pahalgam attack. India, among other punitive actions, announced the suspension of the 1960 Indus Accord, which governs water sharing between the two countries.

Earlier on April 24, Prime Minister Narendra Modi vowed to punish the terrorists involved in the terror attack and their backers.

In a high-level meeting with the top defence brass on April 29, Modi asserted that the armed forces have "complete operational freedom" to decide on the mode, targets and timing of India's response to the terror attack, according to government sources. (PTI)

Israel plans to capture all of Gaza under new plan, officials say TEL AVIV, May 5: Israel approved plans on Monday to capture the entire Gaza Strip and remain in the territory for an unspecified amount of time, two Israeli officials said, in a move that if implemented would vastly expand

Israel's operations in the Palestinian territory and likely bring fierce international opposition. Israeli Cabinet ministers approved the plan in an early morning vote, hours after the Israeli military chief said the army was calling up tens of thousands of reserve soldiers.

The new plan, which the officials said was meant to help Israel achieve its war aims of defeating Hamas and freeing hostages held in Gaza, also would push hundreds of thousands of Palestinians to southern Gaza, what would likely exacerbate an already dire humanitarian crisis.

Since a ceasefire between Israel and Hamas collapsed in mid-March, Israel has unleashed fierce strikes on the territory that have killed hundreds. It has captured swathes of territory and now controls roughly 50% of Gaza. Before the truce ended, Israel halted all humanitarian aid into Gaza, including food, fuel and water, setting off what is believed to the be the worst humanitarian crisis in nearly 19 months of war. The ban on aid has prompted widespread hunger and shortages have set off looting.

Israel is trying to ratchet up pressure on Hamas

The Israeli officials said the plan included the "capturing of the strip and the holding of territories." The plan would also seek to prevent the militant Hamas group from distributing humanitarian aid, which Israel says strengthens the group's rule in Gaza. It also accuses Hamas of keeping the aid for itself to bolsters its capabilities. The plan also included powerful strikes against Hamas targets, the officials said.

The officials said Israel was in touch with several countries about President Donald Trump's plan to take over Gaza and relocate its population, under what Israel has termed "voluntary emigration" yet which has sparked condemnations from Israel's allies in Europe and the Arab world.

One of the officials said the plan would be implemented gradually. Both officials spoke on condition of anonymity because they were discussing military plans.

For weeks, Israel has been trying to ratchet up pressure on Hamas and prompt it to show more flexibility in ceasefire negotiations. But international mediators trying to bring the sides toward a new deal have struggled to do so. Israel's measures do not appear to have moved Hamas away from its negotiating positions.

The previous ceasefire was meant to lead the sides to negotiate an end to the war, but that goal has been a repeated sticking point in talks between Israel and Hamas. Israel says it won't agree to end the war until Hamas is defeated. Hamas meanwhile has demanded an agreement that winds down the war.

Israel wants to prevent Hamas from handling aid The Israeli officials did not disclose details on how the plan seeks to prevent Hamas from involvement in aid distribution. One said the ministers had approved "the option of aid distribution," without elaborating.

According to an internal memo circulated among aid groups and seen by The Associated Press, Israel told the United Nations that it will use private security companies to control aid distribution in Gaza. The U.N., in a statement Sunday, said it would not participate in the plan as presented to it, saying it violates its core principles.

The memo, sent to aid organizations on Sunday, detailed notes from a meeting between the Israeli defense body in charge of coordinating aid to Gaza, COGAT and the UN.

Under COGAT's plan, all aid will enter Gaza through the Kerem Shalom crossing, letting approximately 60 trucks enter daily and distributing 20 kilograms of aid parcels directly to people on the day of entry, although their contents were unclear as was how many people will have access to the aid.

The memo said the aid will be distributed at logistics hubs, which will be run by private security companies. The memo said that facial recognition will be used to identify Palestinians at the hubs and SMS alerts will notify people in the area that they can collect aid.

The UN said the plan would leave large parts of the population, including the most vulnerable, without supplies. It said the plan "appears designed to reinforce control over life-sustaining items as a pressure tactic - as part of a military strategy." (AP)

Romania's hard-right candidate to face pro-EU reformist in presidential runoff Pakistan conducts 'training

ISLAMABAD, May 5: Pakistan on Monday conducted a successful training launch of the 'Fatah series' surface-to-surface missile with a range of 120 kilometres amid heightened tensions with India following the Pahalgam terror attack.

The Inter-Services Public Relations (ISPR), the media wing of the army, said in a statement that a "Fatah Series" was tested as a part of the ongoing exercise "INDUS".

"The launch was aimed at ensuring the operational readiness of troops and validating key technical parameters, including the missile's advanced navigation system and enhanced accuracy," the statement said.

The training launch comes amid tensions between India and Pakistan after terrorists killed 26 people, mostly tourists, in Jammu and Kashmir's Pahalgam on April 22.

Following the terror attack, India took a raft of punitive measures, including the suspension of the 1960 Indus Accord, which governs water

The runoff will be held on May 18 between the two staunchly anti-establishment candidates but ideological opposites, who have made their political careers railing against Romania's old political

Dan, a 55-year-old mathematician and former anti-corruption activist who founded the Save Romania Union party (USR) in 2016, ran on a pro-EU ticket, told the media early Monday that "a difficult second round lies ahead, against an isolationist candidate." "This was a democratic process that Romania needed ... this won't be a debate between individuals, it will be a debate between a pro-Western direction for Romania and an anti-Western one," he said. "I call on all Romanians to be part of this battle, and

I am optimistic that we will win.'

In third place was the governing coalition's joint candidate, Crin Antonescu, with 20.07%, and behind him Victor Ponta, a former prime minister from 2012-2015, with 13% of the vote, while Elena Lasconi, who came second in last year's first round ballot, only obtained about 2.6%.

Final turnout stood at 9.57 million people — or 53.2% of eligible voters, according to data from the electoral authorities. Last year's election was annulled after the farright outsider Calin Georgescu topped the first round, following allegations of electoral violations and Russian interference, which Moscow has denied. The election redo took place months after an annulled vote plunged the country into its worst political crisis in decades.

Simion, who came fourth in last year's race and later backed Georgescu, said in a pre-recorded speech aired after polls closed Sunday that, "I am here to restore constitutional order. ""I want democracy, I want normalcy, and I have a single objective: to give back to the Romanian people what was taken from them and to place at the center of decision-making the ordinary, honest, dignified people," he said.

After her poor showing in Sunday's vote, Lasconi announced her resignation on Monday as leader of the USR party, saying, "I fought with all my strength against a rotten, corrupt system that has kept us captive for 35 years." "Our efforts must be directed toward supporting a pro-European path and accelerating the transformation of a system that has proven dysfunctional and not in the citizens' interest," she said. The presidential role carries a five-year term and significant decision-making powers in national security and foreign policy.

Cristian Andrei, a Bucharest-based political consultant, said Sunday's outcome will likely trigger a "crisis" within the mainstream parties, and the runoff will pit pro-Western ideas against "more conservative, patriotic messaging."

"We'll have two anti-establishment candidates, one that is anti-establishment with a more conservative view of how Romania should advance, and a pro-Western anti-establishment," he told The Associated Press. "This is the most important thing to say: that it will be like a total anti-establishment movement on both sides of the road."

In a speech conceding defeat, the governing coalition's candidate, Antonescu, distanced himself and did not endorse either candidate in the runoff, saying, "I was not part of the coalition." "I presented a program, some ideas, and some people voted for me. I urge them to decide for themselves which of the remaining candidates best aligns with the ideas I put forward," he said. "I encourage everyone who voted for me today to show up and vote." (AP)

80 years after liberation from Nazis, Dutch commemorate victims of war

AMSTERDAM, May 5: Trains came to a halt, cars pulled to the side of the road and no planes arrived or departed in the Netherlands for two minutes on Sunday, as the country went silent to remember victims of war. Thousands of people gathered in Amsterdam to watch as Dutch King Willem-Alexander laid a wreath at a war memorial, 80 years and a day since the country was liberated from Nazi occupation in 1945.

The first speaker at the annual event was 14-yearold Marijn van der Wilk who read a poem he had written about resistance during the war. "They were brothers, sisters, neighbors. Just people, like you or me. In a time when doing good could be life-threatening. And yet they did it," he said during the nationally televised event.

Prime Minister Dick Schoof discussed the grief his family felt over the death of his grandfather, who was executed by Nazi soldiers for his work in the resistance.

"On this day, in the two minutes of silence, that echo sounds extra loud. When we think of all the people who were murdered for who they were. Who died of hunger or exhaustion. Or who fought for peace and freedom. Our peace and freedom," Schoof said.

The national day of commemoration, at which flags fly at half staff from buildings throughout the country, honors military personnel and civilians killed in conflicts around the world since the outbreak of World War II. It is followed Monday by celebrations to mark the country's liberation from Nazi German occupation at the end of the war.

Not every place in the country observed the remembrance. Some predominantly Christian areas honored the dead on Saturday, as to not disrupt the



Sunday sabbath.

In The Hague, a few hundred people gathered for an alternative commemoration. A group of civil servants organized May 4 inclusive, an event to remember all victims of conflict, frustrated with the Dutch government's response to the conflict in Gaza. According to the association's website, the official event is too restrictive. "We commemorate both the victims of the past and the victims of today, regardless of where, by whom or when the war, genocide, persecution or oppression took place. We do not want to exclude anyone, all victims are given

a place." A few pro-Palestinian slogans could be seen in the crowd in Amsterdam.

Later Sunday evening, two veterans will light a Liberation Fire to kickstart a day of celebrations marking the 80th anniversary of the end of German occupation of the Netherlands. Mervyn Kersh, a 100-year-old veteran from Britain, and Nick Janicki, 101, from Canada will light the flame in Wageningen, the central city where German officers signed the official surrender in 1945, organizers said. US, Philippine forces cancel ship-sinking drill after World War II-era target prematurely sinks

MANILA, May 5: A World War II-era Philippine navy ship to be used as a target in a combat exercise by American and the Philippine forces accidentally sank Monday hours before the mock assault, prompting the drill to be cancelled, US and Philippine military officials said.

The BRP Miguel Malvar, which was decommissioned by the Philippine navy in 2021, took on water while being towed in rough waters facing the disputed South China Sea and sank about 30 nautical miles (55 kilometers) off the western Philippine province of Zambales. Nobody was onboard when the ship listed then sank, the Philippine military said.

American and Philippine forces would proceed with other live-fire maneuvers off Zambales on Monday despite the premature sinking of the Malvar. The ship was built as a patrol vessel for the US Navy in the 1940s and was transferred to Vietnam's navy before the Philippine military acquired it, Philippine navy Capt John Percie Alcos said.

"It's an 80-year-old dilapidated ship and it wasn't able to withstand the rough seas," Philippine Lt. Col John Paul Salgado told The Associated Press.

The ship-sinking exercise was planned in an offshore area facing the hotly disputed Scarborough Shoal, which has been closely guarded by the Chinese coast guard, navy and suspected militia ships.

The Philippines also claims the fishing atoll, which lies about 220 kilometers west of Zambales. Chinese and the Philippine forces have had increasingly hostile confrontations in the waters and airspace of Scarborough in recent years.

The cancelled ship-sinking drill would have been the third to be staged by the treaty allies in recent years. It was supposed to be one of the highlights of largescale annual military exercises by the United States and the Philippines from April 21 to May 9 with about 14,000 U.S. and Filipino forces participants.

Called Balikatan, Tagalog for shoulder-to-shoulder, the combat drills have increasingly focused on the defense of Philippine sovereignty in the face of China's growing aggression in the South China Sea, which Being claims virtually in its entirety.

Mock battle scenes which have been staged so far, including the retaking of an island from hostile forces, have reflected assurances by the Trump administration, including by Defense Secretary Pete Hegseth, that the US would abide by its treaty commitment to defend the Philippines in case Filipino forces come under an armed attack, including in the South China Sea.

On Sunday, US, Australian and Philippine forces practiced retaking an island from hostile forces in the coastal town of Balabac in western Palawan province, which faces the South China Sea.

Japanese forces and British marines joined as observers of the combat exercise, which "showcased the growing interoperability and cohesion among partner nations in maintaining regional security," Salgado said.

"What we have seen since Trump returned to the White House is a remarkable level of continuity in the US-Philippines alliance not only in joint military drills, but also on American statements that the alliance is ironclad,' said Derek Grossman, a senior defense analyst at **RAND** Corporation.

"The Trump administration is trying to keep the pressure on China through its support to the Philippines," Grossman said, but added that it's unclear "just how sustainable this commitment will be given that the Trump administration seems less hawkish on China than its predecessors."

China has vehemently opposed such exercises involving U.S. forces in or near the South China Sea or Taiwan, the island democracy, which Beijing claims as a province and has threatened to annex by force if neces-

U.S. and Philippine military officials, however, have insisted that the combat exercises were not designed with China in mind but serve as a deterrence to acts of aggression in the region. (AP)

Geothermal energy will power eco-friendly solutions, including fruit, nut, and meat drying, space heating among others

Northeast's first geothermal production well drilled in Arunachal



ITANAGAR, May 5: The Centre for Earth Sciences and Himalayan Studies (CESHS) has successfully drilled Northeast India's first geothermal production well at Dirang in Arunachal Pradesh's West Kameng district, an official said on Monday.

The successful drilling marks a major milestone in the region's quest for sustainable energy and represents a first-of-itskind initiative in the Northeast, CESHS geosciences division head Rupankar Rajkhowa said.

He said the achievement follows two years of intensive geochemical and structural surveys of hot springs across western Arunachal Pradesh

Once operational, geothermal energy will power eco-friendly solutions, including fruit, nut, and meat drying, space heating, and controlled-atmosphere storage systems -- vital technologies for improv-

ing agricultural and living conditions in the high-altitude terrain of the state, he said

The project is the result of international scientific collaboration between CESHS, the Norwegian Geotechnical Institute (NGI), Oslo, the Icelandic geothermal firm Geotropy ehf, and the drilling team from Guwahati Boring Service (GBS).

Through advanced geochemical analy-

sis, the Dirang region has been identified as a medium-to-high enthalpy geothermal zone, with reservoir temperatures estimated at 115 degrees Celsius, making it highly suitable for direct-use geothermal applications.

Structural and geological mapping in the Dirang area revealed quartzite overlying schist at tectonic contacts near the Main Central Thrust (MCT), consistent with extensional normal faults found elsewhere in the higher and lesser Himalayas. These insights have enabled precision drilling to access the geothermal reservoir with minimal environmental impact.

This breakthrough project is supported by the Government of Arunachal Pradesh and the Ministry of Earth Sciences, Rakhowa added.

With the first production well completed, CESHS plans to scale operations with deeper drilling in Dirang, potentially making it India's first geothermal-powered city for space heating, he added.

"This pioneering development paves the way for a new era of clean energy in the Himalayas," CESHS director Tana Tage said.

"It demonstrates the potential of geothermal resources in transforming regional livelihoods while ensuring environmental sustainability," he added.

The geothermal-powered drying and storage facilities are expected to become operational soon, setting a national precedent for sustainable energy use in mountainous and remote regions.

The CESHS is an autonomous organisation under the Department of Science and Technology of the Government of Arunachal Pradesh. (PTI)

The revised rates will take retrospective effect from January 1, 2025. This enhancement will benefit a

wide range of stakeholders including: All India Services (AIS) officers serving or posted under the State Government, Central Government employees on deputation to the Government of Arunachal Pradesh, State Government employees and Pensioners and family pensioners.

The total financial implication of this decision is estimated at ₹ 73.22 crore for a 14-month period, with a monthly outlay of ₹ 5.23

For the four-month arrear period from January to April 2025, the DA component is estimated at ₹ 20.80 crore (₹ 5.20 crore per month) and the DR component at ₹ 0.12crore (₹ 0.03 crore per month), amounting to a total of ₹ 20.92 crore. The arrears will be paid in cash, offering timely financial relief to employees and pensioners. Starting May 2025, the revised DA and DR rates will be incorporated into the monthly salary and pension disbursements.

East Siang Police apprehends drug peddler in Ruksin



HT Bureau ITANAGAR, May 5: In a significant breakthrough under the ongoing Operation Dawn 2.0, the East Siang Police apprehended a drug peddler and seized approximately 7.63 grams of suspected heroin near Ruksin Petrol Pump on Monday.

Acting on credible intelligence, the Anti-Drug Squad (ADS) of East Siang launched a swift operation that led to the arrest of Shri Usman Ali (Ahmed), a resident of the Sawmill area in Pasighat, who was caught redhanded. NEW DELHI, May 5: The Congress on Monday reiterated its demand for the government to announce a timeline and roadmap for the caste survey, remove the 50 per cent cap on reservation and implement Article 15(5) of the Constitution for reservation in private educational institutions.

The chiefs of the opposition party's SC and OBC departments and the Adivasi Congress made the assertions at a press conference at the Congress' 24, Akbar Road, office. AICC OBC Department chairman Anil Jaihind said when Manmohan Singh was prime minister and Arjun Singh education minister, the 93rd Amendment of the Constitution was passed and Article 15(5) added to it.

"It provided reservation in educational institutions for Dalits, Adivasis and OBCs. At that time, this reservation was implemented in government institutions but people of private institutions took it to the court, where the case continued. In January 2014, it was decided that the government could provide reservation to Dalits, tribals and socially and educationally backward classes in private educational insti-

tutions," he said. "Then, general elections were held and a new government came into existence. For the past 11 years, there is a provision in the Constitution that reservation can be given to Dalits, tribals and backward classes in private institutions but a law needs to be made for this," Jaihind said. "It is unfortunate that, till date, the Modi government has not made such a law due to which the de-

prived and the exploited sections of society are not getting the benefit of education," he said.

Calling the 50 per cent cap on reservation "the biggest obstacle to social justice", AICC SC Department head Rajesh Lilothia said the Congress wanted it to be abolished. "Just like Rahul Gandhi and the Congress forced the government to

conduct a caste census, we will also get this 50 per cent limit on reservation removed," Lilothia said.

The Centre granted 10 per cent reservation to the general caste in the name of EWS (Economically Weaker Sections), which was also approved by the Supreme Court, he said and added this made it clear that the 50 per cent limit could also be crossed.

"If the BJP can do this for the eneral caste, then why can't it do for the deprived and the exploited? The Modi government has announced the caste census but our demand is that its complete timeline should be disclosed. Along with this, the entire format of the caste census should be discussed," ilothia said.

Rahul Gandhi has asserted that till voice of the deprived, exploited and the oppressed is not raised in a strong manner, they cannot get social justice, Lilothia said. "Today, the BJP and Narendra Modi had to bow down before Rahul Gandhi."

Adivasi Congress chairman Vikrant Bhuria said the caste survey would be the "biggest decision" in history

"When Rahul Gandhi raised the issue of caste census, BJP leaders raised questions. This shows that the BJP and Narendra Modi have never been in favour of a caste census. Earlier, Narendra Modi used to say talking about caste was a sin and part of Urban Naxal thinking and that there were only four castes in the country. But now, Narendra Modi has taken a U-turn because he has realised this is a very big revolution," Bhuria siad.

"We want to know what is the roadmap of the BJP government for caste census, what is its timeline and what will be its details?" he asked.

"The demand from the BJP government and Narendra Modi is that we do not want headlines on caste census, we want a timeline and deadline for caste census," he said. Bhuria claimed that the government took the step out of fear.

"We want you to put forward the seriousness of the caste census." he said. The government last week announced that caste enumeration would be included in the forthcoming general census in a "transparent" manner. (PTI)

Waqf Amendment Act aimed at resolving issues; Cong opposing it to perpetuate vote bank: Yadav Army taking measures to

NEW DELHI, May 5: The rights of Muslim groups and individuals to create, manage and regulate Waqf will remain intact, Union Minister Bhupendra Yadav said on Monday, and alleged that the Congress is spreading rumours about the Waqf Amendment Act, 2025.

Addressing a press conference at Delhi BJP office, the Union minister said that Prime Minister Narendra Modi has come up with various reforms in the fields of social justice, economic growth, transparency and gender equality.

"The Waqf Amendment Act, 2025 recently passed by Parliament is an important milestone of this progressive journey," he asserted.

The Congress is spreading rumours that the rights of Muslims will end due to the Act, he alleged, adding that it was not for the first time that the Act was amended.

Some issues like transparency and management in Waqf affairs remained unaddressed in the last amendment in 2013, which have been taken care of now by the Waqf Amendment Act, 2025, he said. "The rights of the Muslim groups and individuals to create, manage and regulate Waqf will remain intact even after the latest amendment," Yadav said.

The latest amendments to the Waqf Act were discussed and consulted in detail when the government referred the subject to the Joint Parliamentary Committee to incorporate all views, he said. The Congress leaders are trying to spread rumours about the Waqf Amendment Act, 2025 but they should be asked if the Waqf Act was so sacrosanct then why their party's governments amended it eight times since 1956, Yadav said.

Later, addressing a gathering of Muslim intellectuals at the Amebdkar International Centre, the senior BJP leader said that the Congress should be asked why they did not computerise the records of Waqf properties as recommended by the Rehman Committee in 2008, and why no judicial system was evolved to settle disputes.

"They should also be asked why they did not talk about rights of the Pasmanda people and Muslim women and the sin committed by the party to prevent the work for a progressive Muslim society to perpetuate it as a vote bank," Yadav said.

After the Waqf Amendment Act 2013, the Waqf properties doubled in number within a decade, he said.

This 100 per cent increase was beyond anyone's comprehension and gave rise to the talks of correct management of Waqf properties, he said. "The Union home minister has said that Mut-

walli (caretaker) of Waqf will only be a Muslim and they will manage it," he said, rejecting the rumours allegedly spread by the Congress.

The plea sought a direction for the National Board of Examinations in Medical Sciences (NBEMS) to conduct the examination, scheduled on June 15, in a single duct NEET-PG 2025 in a single shift to "maintain just, fair, reasonable and equitable grounds of competition for all the candidates as a difference of even 0.1 marks in NEET-PG examination can alter the rank of a candidate by hundreds and thousands".

The plea said NEET-PG 2025 covers a wide range of medical specialisations.

MURSHIDABAD, May 5: West Bengal Chief Minister Mamata Banerjee on Monday rubbished as "baseless and fabricated" the allegations that surplus sacred neem wood from Puri's Jagannath temple was used in crafting the idols of the newly built temple in Digha, even as tensions simmered between both the state over reports of attacks on Bengali-speaking migrant workers.

Banerjee also condemned what she called a "disturbing pattern" of harassment of Bengali-speaking people in Odisha and said she had directed the state DGP to take up the matter with his counterpart in the neighbouring state.

"Why would we use stolen neem wood? We have our sources of neem wood. These allegations are completely baseless and unacceptable," Banerjee said in Murshidabad.

"Why are they so angry just because we have built a Jagannath temple in Digha? Is it a crime to worship Lord Jagannath in West Bengal?" she asked, adding that the backlash was politically motivated.

Her remarks came a day after the Shree Jagannath Temple Administration (SJTA) in Puri questioned a senior servitor over the alleged use of surplus sacred wood meant for the 12th-century Puri shrine in crafting idols for the Digha temple.

temple authorities and drawing criticism from some quarters in Odisha.

Meanwhile, Banerjee expressed grave concern over reports that Bengali-speaking migrant workers from West Bengal were being targeted in Odisha.

"Just like migrant workers from Odisha work peacefully in Bengal, people from Bengal also work in Odisha. I have received disturbing reports that even those merely speaking Bengali are being attacked there. This is deeply condemnable," she said.

"Our DGP will speak with his Odisha counterpart regarding this. We will not tolerate attacks on our people," she asserted.

The Digha temple project, backed by the West Bengal government, has been pitched as a major tourism and religious hub on the Bay of Bengal coast and is seen by many as a cultural counter-narrative to Puri's famed temple, one of the holiest shrines in the Hindu religion.

While the SJTA has not directly accused the West Bengal government of wrongdoing, it has expressed concern over reports that sacred wood left over from the construction of new chariots or temple works in Puri may have been diverted without proper authorisation.

It is alleged that some Puri servitors used leftover 'neem' wood from the 2015 'Nabakalebara' (new form) ritual to make the idols for the shrine in Digha.

'Nabakalebara' is a ritual held every 12 or 19 years, during which the wooden bodies of idols - Lord Balabhadra. Devi Subhadra and Lord Jagannath — are changed at the Puri temple. (PTI)

A bench of Justices B R Gavai and K V Viswanathan agreed to hear the plea filed by seven medical practitioners who have also sought a direction to increase the number of test centres across the country for conducting National Eligibility-cum-Entrance Test-Post Graduate (NEET-PG) 2025 in a single shift.

"Issue notice, returnable one week," the bench said. The notices were issued to the NBEMS, the National Medical Council and the Centre, seeking their responses to the plea.

The NBEMS is entrusted with the responsibility of conducting postgraduate and postdoctoral examinations in approved specialities leading to the award of Diplomate of National Board (DNB) and Doctorate of National Board (DrNB) and Fellow of National Board (FNB).

The petitioners have challenged an April 16 notification issued by the NBEMS which notified that NEET-PG 2025 examination would be conducted on June 15 in two-shifts.

Advocates Sukriti Bhatnagar and Abhisht Hela appeared for the petitioners.

"Holding the examination in two shifts has the potential for unfairness due to varying difficulty levels between shifts, the challenges of a transparent and accurate normalisation process and the increased stress and anxiety for candidates," the plea said.

It said the petitioners were seeking directions to con-

It said holding such an extensive examination in two shifts directly violated the rights of the candidates under Article 14 of the Constitution as maintaining just, fair, reasonable and equitable grounds of competition was almost impossible because of a lack of transparency in the moderation and normalization process.

"It also violates Article 21 of the candidates, as the process violates the basic right to fair examination," the plea claimed.

It said NEET-PG 2024 was also conducted in a twoshift format and the results were challenged before the top court due to problems arising out of the format and the subsequent normalization system.

"There is a likelihood that one batch of candidates may face a more difficult question paper than the other batch as happened in the case of NEET-PG 2024, where it was alleged that the question paper in the second shift was easier," the plea said.

It said holding the examination in two shifts introduces variability in difficulty levels and subject-wise question distribution.

The plea said it also creates bigger problems such as moderation, scaling and rationalisation of questions and normalization of marks for candidates of both shifts as the same would benefit aspirants of either of the two shifts

"This results in violation of the right to equality and makes the whole process vitiated and non-transparent, leaving an itch in the hearts and minds of meritorious candidates," it said. (PTI)

Bench-led by next CJI BR Gavai to hear pleas Japan backs India's fight against terrorism challenging Waqf (Amendment) Act from May 15: SC

NEW DELHI, May 5: The Supreme Court on Monday said the pleas challenging the Waqf (Amendment) Act's constitutional validity will now be taken up by a bench headed by Chief Justice of India-designate Justice B R Gavai on May 15 as the incumbent CJI will be demitting office on May 13.

As soon as a bench comprising Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and K V Viswanathan assembled for the hearing, the CJI said, "There are certain aspects which you (Centre) dealt with, but that require clarification. I do not want to reserve any judgment or order at this interim stage. This matter will have to be heard on a reasonably early date and this will not be before me." CJI Khanna will be succeeded by Justice Gavai a day after his superannuation on May 13.

"We have not very deeply gone into the counter affidavit (of the Centre). Yes, you have raised certain

points in regards to registration (of Waqf properties) and have given some disputed figures, that will require some consideration," the CJI said. "We would have loved to pursue your lordship (the CJI) as every contention has an answer. But, we cannot embarrass you because there is no time," Solicitor General Tushar Mehta, appearing for the Centre, said while indicating the retirement of the CJI. "It is painful to remind your lordship (about the retirement)," the law officer added.

"No no I am looking forward to it," the CJI responded. The CJI categorically said the Centre's affidavit was exhaustive and it has dealt with most of the issues regarding the concerns expressed on the earlier date.

The CJI said some figures referred to by the Centre and disputed by the other side may have to be dealt with and the case will have to be heard on any reasonably early date. CJI Khanna, however, said it would not

be possible before the bench presided over by him in view of time constraints and posted the pleas for further hearing on May 15 before a bench headed by Justice Gavai, the CJI designate. Earlier on April 17, the Centre as-

sured the top court that it would neither denotify waqf properties, including "waqf by user", nor make any appointments to the central waqf council and boards till May 5. The assurance of the Centre came

when the bench was informed that the waqf law was passed by Parliament with "due deliberations" and it should not be stayed without hearing the government.

The Centre also strongly opposed the apex court's proposal to pass an interim order against the denotification of waqf properties, including 'waqf by user', aside from staying a provision allowing the inclusion of non-Muslims in the central waaf councils and boards. (PTI)

Waqfs to support the welfare and maintenance of women External affairs MoS highlights key provisions of Waqf(Amendment) Act 2025

<u>HT Bureau</u> GUWAHATI, May 5: Minister of State for External Affairs & Textiles, Pabitra Margherita, on Monday highlighted the key provisions and significance of the recently passed Waqf (Amendment) Act, 2025 on Monday.

Describing the Act as a "transformative change" under leadership of Prime Minister Narendra Modi, Margherita emphasised that the legislation has been aimed at correcting historical imbalances and ensuring that waqf properties are managed with greater transparency, equitable representation, inclusivity, and accountability to serve the community's welfare truly.

Highlighting the democratic and consultative approach behind the Act's passage, Margherita noted that it followed 38 meetings of a 31-member Joint Parliamentary Committee (JPC) over 5 months, review of 7,772 petitions, consultations with 284 delegations, analysis of nearly 1 crore online suggestions, and over 25 hours of Parliamentary debate.

"One of the core features of the



reform is inclusivity, with mandaas from backward class Mustory representation of marginalized lims- in every State and UT Waqf Muslim groups-ensuring repre-Board. In a historic step, at least sentation from the Bohra and two Muslim women will now serve on every Waqf Board and in Aghakhani communities, as well

the Central Waaf Council, ensuring gender representation and long-overdue recognition," Margherita said.

Speaking on gender rights, the Minister of State highlighted that family Waqfs would now be required to ensure that daughters, widows, and divorced women receive their rightful legal share before such Waqfs are created. The Amendment further strengthened this by allowing Waqfs to support the welfare and maintenance of these women, making community welfare a living reality. Focusing on the economic po-

tential of waqf properties, the Minister expressed concern that despite Waqf assets being worth crores, their reported annual income in 2025 was a mere ₹ 126 crore against the ₹ 12,000 crore potential revenue. The Amendment sought to bridge this gap by enforcing accountability, introducing professional oversight, and implementing structural reforms to unlock waqf's true economic value.

"In a step toward ensuring authenticity, the Act now allows only

individuals who have practiced Islam for at least five years to declare a waqf. The concept of 'Waqf by user', where prolonged usage could convert land into Waqf, has been abolished for future cases," the Minister said.

The Act also ushered in an era of digital governance. All Waqf records would now be centralized on a national digital portal, allowing public access to data on registration, mutation, audit, leases, and litigation. Integration with land records and geotagging would enhance transparency and help eliminate encroachments and misuse, the Minister added.

HT Correspondent AGARTALA, May 5: A shocking incident has come to light from Katlamara Primary Health Center under Simna Assembly Constituency in West District, where a newborn baby was allegedly sold by her parents to a couple from the Khowai district of Tripura.

The incident has sparked widespread outrage among locals.

Sources said that the incident occurred on April 30, when Lakshmi Rani Das, wife of Prasenjit Das, gave birth to a girl child at Katlamara PHC.

Allegations soon surfaced that the infant had been sold directly from the hospital premises.

However, in her defense, Lakshmi Rani Das denied "selling" the child, claiming instead that she had "given" her away due to poverty and desperation.

"I didn't sell out my daughter

but I have given her to another family. I don't know their names. I believed them and that's why I have given them. I can't feed her. My husband is suffering from TB and we don't have money to raise her," she told reporters today.

Lakshmi, already a mother to two sons and a daughter, cited dire financial constraints and her husband's health condition as the reasons behind her decision.

Following a swift investigation, authorities managed to trace the baby to the Khowai area.

She was successfully rescued and has since been shifted to a shelter home, officials confirmed

Kohima DC directs strict implementation of COTPA

DIMAPUR, May 5: Kohima deputy commissioner B Henok Buchem, who is also the chairman of district level coordination committee, National Tobacco Control Programme, Kohima, on Monday directed all village councils, municipal and town wards, government departments, educational institutions, commercial establishments, and the public to ensure strict adherence to key provisions of the Cigarettes and Other Tobacco Products Act, 2003 (COTPA 2003) in the district.

In a circular, Buchem pointed out that smoking is strictly prohibited in all public places, including government offices, healthcare facilities, educational institutions, public transport, restaurants, and entertainment venues. It directed that clear 'No Smoking' signage must be prominently displayed in all such areas. The DC said all forms of direct and indirect advertisements, promotion, and sponsorship of cigarettes and other tobacco products are strictly prohibited. This includes point-of-sale displays, hoardings, promotional events, and any other means of encouraging tobacco use, he added. The circular further said the sale of cigarettes and other tobacco products to persons below the age of 18 is strictly prohibited. It said retailers are required to verify the age of purchasers.

It also reminded that the sale of cigarettes and other tobacco products is banned within a radius of 100 meters from the outer boundary of any educational institution, including schools, colleges, and universities. The circular asked all authorities concerned to ensure strict implementation of the provisions of the COTPA Act 2003 within their respective jurisdictions.

In the statement posted on Instagram, the singer said he will cooperate with the police authorities of Karnataka in the matter and always "cherish the love" he has received from the people of the state irrespective of the verdict.

"I leave it up to the sensible people of Karnataka to decide who is at fault here. I will accept your verdict gracefully. I fully respect and trust the law agencies and Police of Karnataka and will comply with whatever is expected from me," Nigam wrote.

Trump imposing 100% tariff on imported films may encourage Hollywood to move out of US: Shekhar Kapur

NEW DELHI, May 5: Filmmaker Shekhar Kapur on Monday criticised American President Donald Trump for threatening a 100 percent tariff on films imported to the US, saying the move could backfire and instead push Hollywood filmmakers to leave the country.

In a post Sunday night on his Truth Social platform, Trump said he has authorised the Department of Commerce and the Office of the US Trade Representative to slap a 100 per cent tariff "on any and all Movies coming into our Country that are produced in Foreign Lands".

As a patriot, Nigam said, he loathes anyone trying to create hate in the name of "language, caste or religion", especially after the terror attack in Jammu and Kashmir's Pahalgam which claimed the lives of 26 people, including two from Karnataka.

"I had to school them, and I did, and thousands of students and teachers cheered me for it. The matter got over and I sang Kannada for more than an hour. It's all there on social media," he added.

On Saturday, Nigam shared a video on Instagram in which he defended himself after an FIR was filed against him for allegedly offending the sentiments of Kannadigas during the concert. (PTI)

Rabada eligible to play after completing 'treatment program'

NEW DELHI, May 5: The provisional ban on South African pacer Kagiso Rabada for using a prohibited recreational drug has been lifted after he completed a "substance abuse treatment program" during the suspension, making him available for his IPL franchise Gujarat Titans.

According to a statement from the South African Institute for Drug-Free Sport (SAIDS), Rabada, who has already linked up with the Gujarat Tians after serving his suspension, can now take the field. GT will take on Mumbai Indians in Mumbai on Tuesday.

The 30-year-old was tested during the SA20 league in January and the lifting of suspension also makes him available for the World Test Championship final against Australia next month.

"Mr. Rabada tested positive for a Substance of Abuse and was subsequently notified of the allegation of his doping offence on 1 April 2025. A provisional suspension was imposed and Mr. Rabada returned immediately to South Africa from India," the release stated. "As per the South African Anti-Doping Rules specifically pertaining to Substances of Abuse, the player was offered an opportunity to complete a substance abuse treatment program. "After Mr. Rabada satisfactorily completed two sessions of his treatment program, his provisional suspension ended. The player has effectively served a one-month period of ineligibility and may now resume participation in sport," it added. Cocaine, heroin, MDMA and cannabis fall in the category of 'Substances of Abuse' for which Rabada was sanctioned.

The abuse of such drugs can lead to a maximum of four-year ban but if a sportsperson can prove that the use occurred out-of-competition and is not related to performance enhancement, the suspension could be reduced to three months. (PTI)

BERLIN, May 5: The "curse" has been lifted.

Harry Kane can finally celebrate his first career title after Bayern Munich became Bundesliga champion with a little help from Freiburg on Sunday.

Freiburg drew with secondplaced Bayer Leverkusen 2-2 to leave Bayern an unassailable eight points clear of the 2024 champion with two rounds of the German league remaining.

The 31-year-old Kane had never won a title in a career of runner-up finishes and defeats in finals with Bayern, Tottenham and England, leading some to speak of a "curse" against a player considered one of the world's best forwards.

Kane's arrival as Bayern's record signing in 2023 was followed by the club's first trophyless season since 2012.

Kane was ready to celebrate Saturday when Bayern looked set to win 3-2 in Leipzig. But Yussuf Poulsen equalized with the last kick of the game for Leipzig to draw 3-3 and postpone Bayern's party.

"Next week, Harry!" teammate Thomas Müller wrote on Instagram.

He didn't have to wait that long. Leverkusen played without conviction in Freiburg, knowing that second place was already secured and that it only had a mathematical chance of defending its title with Bayern having a far superior goal difference.

Maximilian Eggestein fired the home team ahead before the break and an own-goal from Piero Hincapie after it put Freiburg firmly in control.

Leverkusen had to wait till the 82nd minute for Florian Wirtz to

pull one back with his team's first shot on target. Jonathan Tah equalized with the next in stoppage time, but it made no difference for the new league champion.

"We are the champions!" Kane sang with teammates in a Munich restaurant, where he and Joshua Kimmich were doused in beer or champagne as they sang Bob Marley's "Three Little Birds.

It's Bayern's record-extending 34th German championship including the first for the club in 1932. Every other title came after the Bundesliga's formation in 1963. Bayern will be presented with the trophy after its home against Borussia game Mönchengladbach next weekend, when Müller will be given what's sure to be an emotional send-off after 25 years at the club. "He's going as a legend,' Germany coach Julian Nagelsmann said of Müller's 13 Bun-

Oscar Piastri wins at Miami for 3rd straight F1 victory, 4th win of season for c'ship leader

GARDENS MIAMI (FLORIDA), May 5: The first time Oscar Piastri arrived at the Miami Grand Prix as a Formula 1 driver he was in the slowest car in the field and only narrowly avoided finishing last. Fast-forward two years and Pi-

astri and McLaren Racing have come full circle. Piastri maintained his advan-

tage in the F1 championship fight by winning at Miami on Sunday for his fourth win through six races this season. Piastri has won three consecutive F1 races for McLaren Racing, where he and teammate Lando Norris are trying to dethrone four-time defending champion Max Verstappen of Red Bull. McLaren has won Miami

Piastri is the first McLaren driver to win three consecutive F1 races in 28 years; Mika Hakkinen did it with a win in the 1997 season finale and then victories in the first two races of 1998.

He widened his lead over Norris in the driver standings to 16 points, while Verstappen trails Piastri by 32 points.

Norris' win at Miami last season snapped Verstappen's two-year winning streak at the course surrounding Hard Rock Stadium. Norris also won the sprint race on Saturday — Piastri dominated but a late safety car cost him the victory — but Verstappen won the pole in qualifying.

Verstappen, who announced the birth of his first child Friday morning, has been determined to disprove the myth that fatherhood would make him a more conservative driver. It was evident as he darted away at the start and then aggressively held off Norris' challenge for the lead.

The Red Bull and McLaren were side-by-side and Norris was trying to edge ahead of the Dutchman, but he ran off track and lost four spots. Norris said Verstappen forced him off track and there was nothing he could do but try to



avoid running into a wall — but F1 took no action against Verstappen. "What can I say? If I don't go for it, people complain. If I go for it, people complain," Norris said. You can't win. But it really just how it is with Max — it's crash or their pass.' Verstappen was unapologetic

after fading to fourth and insisted he raced within the rules.

"I mean, I had nothing to lose, so I also wanted to have a bit of fun out there," Verstappen said, adding McLaren's strong start to the season is "not frustrating at all." "We are here to win and today we were miles off that, so it doesn't really matter," Verstappen

said. Norris recovered from the early incident and picked his way back toward the front, but not before Piastri took control away from Verstappen on the 14th of 57 laps. McLaren has decided it will allow Piastri and Norris to race each other cleanly without team orders, and Norris was cleared to challenge his Australian teammate for the victory.

In the waning laps, Norris was able to close the gap but could never catch Piastri and settled for second in a 1-2 finish for McLaren. The two held a nearly 40-second advantage over George Russell of Mercedes, who finished third.

Alex Albon of Williams was fifth, Kimi Antonelli of Mercedes was sixth and Charles Leclerc was seventh after Ferrari ordered Lewis Hamilton to give his teammate the position in the closing laps. Hamilton was eighth.

Carlos Sainz Jr. was ninth for Williams and Yuki Tsunoda was 10th for Red Bull.

Jack Doohan ran into another car on the opening lap and then crashed on the second lap - a showing that won't quiet chatter the rookie is on the verge of being replaced at Alpine by Franco Colapinto.

With the best Net Run Rate among all teams, third-placed MI need two wins from remaining three matches to ensure a direct spot in the final four. The five-time winners will play two of these games at home, where they have won four out of five matches.

GT, who are ranked fourth, have four matches left of which two will be at their home-ground in Ahmedabad where they too have won four out of five times. The Shubman Gill-led side essentially needs two more wins to sail into the playoffs.

The top order troika of B Sai Sudharsan (504 runs), Jos Buttler (470) and skipper Gill (465) have dominated the tournament like no other, setting up many a wins for the Titans.

But the outcome of Tuesday's contest could be determined by how they perform against arguably the best bowling attack in the competition with Trent Boult (16 wickets), Hardik Pandya (13), Jasprit Bumrah (11) and Deepak Chahar (9) ensuring tough times for opposition batters.

Ever since MI began their winning streak, which has swelled to an impressive six matches on the trot, they have not conceded a total in excess of 200 either at home or away even once.

It is enough to ring alarm bells in the Titans' camp, whose winning formula has largely been based on piling up heavy totals batting first.

DUBAI, May 5: India retained their top position in the ODIs and T20Is to extend their dominance in the white-ball formats but slipped a place to fourth spot in the Test format, in which Australia reigned supreme, in the latest ICC annual men's ranking update issued on Monday.

The latest rankings rate all matches played since May 2024 at 100 per cent and those of the previous two years at 50 per cent.

In the ODI rankings, 2023 World Cup finalists India have strengthened their grip at the top on the back of a victorious ICC Champions Trophy campaign, improving their rating points from 122 to 124.

Coming in second place are the runners-up at the Champions Trophy, New Zealand, overtaking their Trans-Tasman rivals Australia, who now occupy the third spot.

Sri Lanka, who enjoyed an excellent run at home in recent months, including ODI series wins against India and Australia, are in fourth place after gaining five rating points, leapfrogging Pakistan (fifth with a gain of one point) and South Africa (sixth with loss of four points) in the process.

Afghanistan also climbed up the ladder - moving to seventh following a four-point improvement - at the expense of former world champions England, who fell to eighth after dropping four points.

West Indies, meanwhile, rose to the ninth spot after gaining five points to surpass Bangladesh, who dropped to 10th with a four-point decline

In T20Is, the current world champions India are placed at the top, although their lead over the second-placed Australia has reduced from 10 to nine points.






