

Import duty cut on crude edible oils will protect local processors Industry bodies and also protecting the sector from

NEW DELHI, May 31: Edible oil industry bodies SEA and IVPA have hailed the government's decision to cut basic custom duty on crude oils to 10 per cent, saying the move will discourage imports of finished products and safeguard the interests of domestic refiners.

On Friday, the government reduced the basic custom duty on crude palm oil, crude soyabean oil and crude sunflower oil to 10 per cent from earlier 20 per cent.

The effective import duty (including basic custom duty and other charges) on these three products will now be 16.5 per cent, as against 27.5 per cent earlier.

With a sharp rise in imports of refined palmolien in the past six months, both industry bodies have been urging the government to increase the duty difference between crude edible oils and refined edible oils. Welcoming the decision, Solvent Extractors Association of India (SEA) President Sanjeev Asthana said, "the government's decision to increase the duty differential from 8.25 per cent to 19.25 per cent is a bold and timely move. It will discourage imports of refined palmolien and shift demand back to crude palm oil, thereby re-

The local resident had reportedly died in his house and the family had to arrange for a bamboo shaft to take the body out to a dry place for it to be taken to the cremation ground. Several localities of the city remained submerged for the second day with different rescue agencies taking people to safer places as residents abandoned their waterlogged houses with no water or power supply.

The ASDMA bulletin said floods have been reported in six districts, with five revenue circles of Kamrup Metropolitan, Kamrup and Cachar reeling under 'urban floods'

Floods have also been reported in Dhemaji, Lakhimpur and Golaghat, impacting eight revenue circles in these three districts

A total of 10,150 people have been affected by 'urban floods', with two camps and one relief distribution centre being opened

Nearly 2,000 people have been affected by floods in the other three districts, though no camps or relief distribution centres are operational in the flood-hit urban areas till now. One ring 'bandh' (a type of dyke) has been breached under the North Lakhimpur revenue circle. NDRF and SDRF personnel have been evacuating people in different affected parts, the bulletin added. Almost all the major rivers across the state were on a 'risng' water level trend, as per ASDMA information.

The Brahmaputra was flowing near the danger level in Dibrugarh, Ranganadi in Lakhimpur, Dhansiri in Numaligarh, Jia Bharali in Sonitpur, Kopili in Kampur and Beki in Barpeta. As per the latest RMC data, Dhubri, Kokrajhar and Bongaigaon have 'red alert' issued, while the districts of South Salmara Mankachar, Goalpara, Chirang, Baksa, Barpeta, Bajali, Dima Hasao and Cachar are on 'orange alert'.

'Red alert' implies 'warning/take action', and the districts with such a warning may witness heavy to very heavy rainfall at a few places, with extremely heavy rainfall at isolated places, and squally winds with speed reaching 40-50 kmph gusting to 60 kmph.

An 'orange alert' asks people to be 'alert/be prepared to take action' for thunderstorm and lightning accompanied with gusty wind reaching wind speed 30 to 40 kmph with heavy to very heavy rain very likely at isolated

Chief Minister Himanta Biswa Sarma had said on Friday that the state was facing an 'abnormal situation' due to incessant downpours caused by massive cloud cover over several parts of the Northeast. Heavy rainfall has also been recorded in Arunachal Pradesh and Meghalaya, aggravating the situation in Assam, especially in Guwahati, which has been hit by massive waterlogging, he said.

A special casual leave was announced for government employees of Kamrup and Kamrup Metropolitan districts on Saturday, who have to commute some distance to reach their offices. Educational institutions have also been closed in the two districts on Saturday. Flight services at Guwahati airport were affected on Friday due to heavy rain and gusty winds, the officials said. (PTI)

Sixty-three families were also evacuated to safer places due to landslides and floods, it said. Landslides have also blocked national and intra-state highways at 69 locations, the bulletin said. Officials also said that many travellers intending to travel to the southern part of the state were stranded in Serchhip town after landslides damaged a national highway. A report from Lawngtlai town said two persons were rescued from the debris of buildings that collapsed due to landslides triggered by heavy rain on Friday. An official said the two survivors were rescued on Saturday morning and the search for the other missing persons is underway.

No fatality has been reported so far and the number of missing persons is yet to be ascertained, he said. Rescue operation and debris clearance are being carried out by personnel of National Disaster Response Force (NDRF), State Disaster Response Force (SDRF), security forces along with volunteers of Young Lai Association (YLA), the largest civil society organisation in Lawngtlai district, he said.

The incident occurred at around 10:30 am on Friday in the border area of Bazar Veng and Chandmary localities in Lawngtlai when the landslides struck a four-storey building and five other houses, including two under construction, according to the official. One floor of the four-storey building was used as a hotel and around 20 people from Myanmar were believed to be staying in the hotel at the time of the incident.

to disrupt India's metal exports Experts NEW DELHI, May 31: US President Donald Trump's announcement to double tariffs on imported steel and aluminium will impact Indian exporters, particularly those engaged in value-added and finished steel products and auto-components, experts say.

Expressing concern over the Trump-administration's move, they said the Indian government should take up the matter bilaterally with the US authorities.

On May 30, Trump announced that he would double the existing 25 per cent tariffs on steel and aluminium imports from June 4.

This hike comes under Section 232 of the US Trade Expansion Act of 1962, a law that allows the president to impose tariffs or other trade restrictions, if imports are deemed a threat to national security. Trump originally invoked this provision in 2018 to set the 25 per cent tariff on steel and 10 per cent on aluminium. He raised tariffs on aluminium to 25 per cent in Febru-

"These exports are now exposed to sharply higher US tariffs, threatening the profitability of Indian producers and exporters," GTRI founder Ajay Srivastava said. India has already issued a formal

notice at the World Trade Organization (WTO) signalling its intention to impose retaliatory tariffs on US goods in response to the earlier steel tariffs. "With Trump now doubling the

tariffs, it remains to be seen whether India will carry out the retaliation by increasing tariffs on certain US exports within a month." he said.

The Federation of Indian Export Organisations (FIEO) President S C Ralhan said the proposed increase in import duty will have a significant bearing on India's steel exports, especially in semi-fin-

stainless steel pipes, structural steel components, and automotive steel parts.

"These products are part of India's growing engineering exports, and higher duties could erode our price competitiveness in the American market," he said.

The US is among the top destinations for Indian steel manufacturers, who have been gradually increasing market share through high-quality production and competitive pricing.

"Such sharp increases in tariffs send discouraging signals to global trade and manufacturing supply chains. We urge the government to take up the issue at the bilateral level to ensure that Indian exporters are not unfairly disadvantaged... as 25 per cent additional duty will be a huge burden, which is difficult to be absorbed by the exporter/importer," Ralhan

The FIEO chief also emphasized on the need for Indian exporters to diversify their markets and invest in higher-grade value-added products to mitigate the impact of such protectionist measures. (PTI)

Over 10,000 people affected; landslides claim 5 lives Heavy rain continues to create havoc in parts of Assam for 2nd day

GUWAHATI, May 31: Five persons were killed in landslides in Assam in the last 24 hours as incessant rain led to floods in six districts, affecting over 10,000 people, an official bulletin said on Saturday

Three districts in the western part of the state remained on 'red alert' and eight more were on 'orange alert', as per Regional Meteorological Centre (RMC) data, while rainwaters from upstream areas in Arunachal Pradesh and Meghalaya aggravated the flood situation in the state.

The Assam State Disaster Management Authority (ASDMA) said all five deaths have been reported from the Kamrup Metropolitan district.

Urban Affairs minister Jayanta Malla Baruah had on Friday said that three members of a family, a mother-daughter duo and a niece. were killed in a landslide in Bonda area on the outskirts of Guwahati.

One more arrested in Assam for being 'Pakistan sympathiser', total at 79

GUWAHATI, May 31: One more person, accused of being a Pakistan sympathiser, has been apprehended in Assam, taking the total number of such arrests to 79 in the state since the Pahalgam terror attack last month, Chief Minister Himanta Biswa Sarma said.

The arrested person has been identified as Farijul Haque from Mangaldai in Darrang district.

"Crackdown on pro-Pakistani sympathisers. Total arrests made: 79," the chief minister posted on 'X' on Friday. Sarma had earlier said the state-wide crack-

down on traitors would continue, and nobody would be spared

Former school teacher 'deported to Bangladesh' returns home in Assam

MORIGAON, May 31: A former school teacher, who was detained by Assam Police on the charges of being a foreigner and allegedly deported to Bangladesh, returned to his home in Morigaon district on Saturday, an officer said.

Khairul Islam and eight others were picked up from different parts of the district on May 24 but family members claimed they were not told about their whereabouts.

Islam's family had claimed that they saw him in a video purportedly showing him being taken to Bangladesh. They claimed he was "shot at" at the India-Bangladesh border in South Salmara Mankachar district.

Islam's family members claimed that the police brought him home

on Saturday morning. An officer of the Assam Border Police said that his medical checkup was conducted and he was

found to be physically fit. The officer, however, refused to divulge details on where he was detained.

The other eight persons who were picked up along with Islam have been shifted to a detention centre at Matia in Goalpara district, police said.

Their family members claimed that their appeals were pending before either the Supreme Court or the Gauhati High Court.

Islam's wife Rita Khanam had said on Friday that her husband is a former school teacher and a law-

abiding citizen. She claimed that policemen had come to their residence at night, and took him away, saying they have some questions to ask and he can return home after that but since then the family was not given any information about his whereabouts till the video surfaced.

Move to deport illegal foreigners: SC moved



NEW DELHI, May 31: A plea has been filed in the Supreme Court alleging that the Assam government has reportedly launched a sweeping and indiscriminate drive" to detain and deport persons suspected to be foreigners without nationality verification or exhaus-

tion of legal remedies. The plea referred to a February 4 order of the apex court which, while dealing with a separate petition, directed Assam to initiate the process of deportation of 63 declared foreign nationals, whose nationality was known, within two weeks.

"Pursuant to the said order (of February 4)... the state of Assam has reportedly launched a sweeping and indiscriminate drive to detain and deport individuals suspected to be foreigners, even in the absence of foreigners tribunal declarations, nationality verification, or exhaustion of legal remedies," said the plea filed by the All BTC Minority Students Union. The petition, filed through advocate Adeel Ahmed, referred to news reports including one about a retired school teacher who was allegedly "pushed back" into

Bangladesh. "These instances reflect a growing pattern of deportations con-

ducted by the Assam Police and administrative machinery through informal 'push back' mechanisms, without any judicial oversight or adherence to the safeguards envisaged by the Constitution of India or this court." it said.

The plea alleged that this policy of "push back", being executed in border districts like Dhubri, South Salmara and Goalpara was not only legally indefensible but also threatens to render stateless numerous Indian citizens, especially those from poor and marginalised communities who were either declared foreigners ex-parte or have no access to legal aid to challenge their status.

It said such actions were directly contrary to the fundamental rights guaranteed under the Constitution.

"The 'push back' policy, as implemented, violates Articles 14 and 21 of the Constitution by deporting individuals without due process, thereby denying them the opportunity to contest their deportation and infringing upon their right to life and personal liberty," the plea claimed

3 sentenced to 20 years of rigorous imprisonment for drug trafficking in Assam

DIPHU, May 31: A court in Assam's Karbi Anglong district sentenced three persons to 20 years of rigorous imprisonment for trafficking drugs three years ago.

The District and Sessions Court here also imposed a fine of ₹ two lakh on them.

The three were arrested in August 2022 at Dilai under the Bokajan subdivision of the district after drugs worth ₹ 10 crore were seized from their possession.

District and Sessions Judge D K Deka sentenced them to 20 years of rigorous imprisonment. The traffickers - Raiesh Lakhendri. Kumar Gajimer and Tanganbo Marianmai- were booked under the Narcotic Drugs and Psychotropic Substances (NDPS) Act.

The three were arrested when they were coming in a vehicle from the neighbouring Nagaland.

DIPHU, May 31: Incessant rainfall for over 36 hours in Karbi Anglong and West Karbi Anglong districts has disrupted normal life. Diphu, the headquarters of the Karbi Anglong Autonomous Council (KAAC), faced power outages for over 12 hours. Roads were deserted, construction activities came to a halt, and business transactions dropped significantly.

In West Karbi Anglong, the water level of the Kapili River is steadily rising. The situation has worsened due to water released from the Khandong Dam of the Umrangso Hydropower Project and the Karbi Langpi Hydro Electric Project on May 30.

Floodwaters from the Kapili have entered agricultural fields in Kheroni Das Basti, triggering panic among residents. Soil erosion and strong winds uprooted several trees along roads and in villages. A massive tree fell on the Lanka-Kheroni-Umrangso arterial road at around 11 p.m. on May 30, bringing traffic to a halt. Local res-

AIZAWL, May 31: Four persons, including three Myanmar refugees were killed and one injured when their houses collapsed due to landslides triggered by heavy rain in Mizoram on Saturday, taking the toll in the current monsoon to five, officials said.

Three persons aged between 34 and 71 years from a Myanmar family have died and another was injured when a massive landslide struck and buried their rented house at Vaphai village in east Mizoram's Champhai district near the Myanmar border on early Saturday, they said.

The family has been taking shelter in the village since 2021 following the military coup in the neighbouring country, they said. The injured person was taken to a nearby hospital at Farkawn.

In a separate incident, a 53-year-old man was killed when his house collapsed due to landslide in Serchhip district about 114 km from state capital Aizawl on Saturday.

Officials said that the victim succumbed to his injuries in Serchhip district hospital.

On Friday, a 37-year-old man was killed and another injured when a wall collapsed on a labourer camp at Aizawl's huampui area.

Mizoram has been experiencing heavy rain since Friday, triggering landslides and rockfalls at several places.

An IMD report said Lawngtlai district received 205 mm of rainfall on Saturday followed by Khawzawl district 184 mm. Hnahthial district 130 and Aizawl received 91 mm of rainfall. At least 56 houses were damaged in 147 landslides across the state on Saturday, according to a bulletin by state emergency operation centre. (CONTD. ON PAGE-2)

Crisis on repeat: The IMF, Pakistan, and failed reform

Dakistan's relationship with the International Monetary Fund (IMF) reflects a deeper pattern of structural dependence. The US\$ 7 billion Extended Fund Facility (EFF) approved in 2024 is not merely a financial lifeline but an attempt to manage entrenched dysfunction. The IMF, acting as a lender of last resort, demands reforms in exchange for support: fiscal discipline, subsidy cuts, and transparency. Yet in politically resistant environments like Pakistan, these reforms often remain superficial. This marks Pakistan's 24th IMF bailout since independence-the most for any country-highlighting a recurring cycle of crisis and external assistance. While the Fund aims to restore stability, it increasingly finds itself propping up states that are fiscally mismanaged, strategically insecure, and institutionally fragile.

This dynamic is not unique to Pakistan. From Lebanon to Sudan, several fragile economies are accumulating unsustainable debt burdens, not only due to exogenous shocks or administrative inefficiencies, but because of deliberate political decisions-ranging from military adventurism to strategic ambiguity. Nevertheless, IMF conditionalities revolve around technical indicators such as fiscal consolidation, subsidy reform, and governance diagnostics, with limited consideration of the political economy of conflict and control.

In such contexts, the effect of bailouts is often counterintuitive as they end up underwriting the very dysfunctions they are meant to address. The IMF's approach rests on the premise that financial instability can be corrected through marketoriented reforms and institutional strengthening. Yet, these measures have limited traction in fragile states where political power is fragmented and often resides outside civilian control.

The Limits to Technical Conditionality

As part of its Extended Fund Facility, the IMF required the Pakistani government to release a Governance and Corruption Diagnostic Assessment (GCDA) by mid-2025. However, by March 2025, a cabinet committee remained undecided on whether the report should be released in full or redacted format—an early signal of resistance within the state apparatus. In reality, governance in many fragile states is characterised by dual structures of power, where informal networks, military actors, and entrenched elites influence or override official policy. IMF programmes often fail to account for this fragmentation.

This disconnect also raises concerns about accountability. By operating within a narrowly defined economic framework, the IMF avoids addressing how power is exercised and contested. As a result, programmes may stabilise foreign exchange reserves or improve fiscal balances in the short term, but they rarely produce lasting institutional reform. In such cases, technical neutrality masks a deeper failure to grapple with the sources of systemic dysfunction.

Additionally, in conflict-prone environments, fiscal crises are not just a consequence of weak institutions-they are often strategically engineered outcomes. Prolonged military spending, proxy conflicts, diplomatic isolation, and deteriorating investor sentiment contribute to macroeconomic stress. These are political decisions with economic costs. Yet, the IMF rarely differentiates between debt generated by poor governance and that driven by deliberate strategic behaviour.

This has been a recurring pattern in Pakistan. The country's balance-of-payments crises are frequently linked to geopolitical choices, be it increased defence spending, cross-border tensions, or restricted access to foreign investment due to its greylisting by the Financial Action Task Force (FATF) from 2018 to 2022. Nonetheless, IMF frameworks treat such crises as technocratic problems, amenable to fiscal solutions. In certain years, Pakistan's defence expenditure has exceeded the total value of IMF assistance. In 2024, Pakistan received US\$ 1 billion as part of a US\$ 7 billion EFF from the IMF, spread over 37 months. Yet, in the same year, it spent a staggering US\$ 10.2 billion on defence-more than ten times the bailout tranche, raising serious questions about whether international financial support inadvertently sustains militarised priorities rather than economic reform.

These dynamics have clear regional implications, particularly for India. The IMF's financial assistance stabilises Pakistan's macroeconomic position without addressing its military posture or support for proxy terrorist networks. This inadvertently creates fiscal space for security-sector spending, with implications for cross-border peace. Indian taxpayers, through their IMF quota contributions, find themselves underwriting stability in a country that has, at various points, sponsored actors responsible for cross-border attacks and ceasefire violations.

Towards a Geopolitically Intelligent IMF

The objective should not be to politicise IMF lending but to enhance its strategic relevance in today's complex geopolitical environment. Conflict-prone states increasingly demonstrate characteristics that go beyond mere fiscal mismanagement. Many are structurally resistant to reform, shaped by informal hierarchies, elite capture, and entrenched military dominance. If the IMF is to remain futureready and effective, its lending framework must account for these underlying realities

Manipur's unhealed wounds

Can Unity Prevail Amid Ethnic Strife and Political Turmoil?

wo years after the cataclysmic ethnic violence of May 3, 2023, which claimed over 260 lives and displaced more than 70,000 people, Manipur remains a state teetering on the edge of chaos. The communal strife between the Meitei majority in the Imphal Valley and the Kuki-Zo tribal communities in the surrounding hills has left deep scars, with law and order still in disarray. The recent push by a faction of Bharatiya Janata Party (BJP) legislators to form a new government, claiming the support of 44 Members of the Legislative Assembly (MLAs), offers little reassurance. Far from addressing the root causes of Manipur's unrest, this move underscores the persistent disconnect between the Union government's policies and the complex socio-political realities of the state. Compounding the crisis, a civil disobedience movement led by the Coordinating Committee on Manipur Integrity (COCOMI) has erupted, protesting an alleged order by central security forces to remove the word "Manipur' from a state transport bus's destination board. This incident, though seemingly minor, has ignited widespread outrage, symbolizing a broader assault on Manipuri identity and pride. As the state grapples with these challenges, the imposition of President's Rule, the resignation of former Chief Minister N. Biren Singh, and the appointment of a new governor have done little to restore normalcy, raising critical questions about the path forward for this beleaguered border state.

The ethnic violence that erupted in May 2023 was triggered by a Manipur High Court order recommending Scheduled Tribe status for the Meitei community, a decision that stoked fears among the Kuki-Zo tribes of losing their reservation benefits. What began as a tribal solidarity rally in Churachandpur spiraled into a brutal conflict, leaving over 260 dead, 1,500 injured, and 70,000 displaced. The violence exposed deep-seated ethnic divisions, with the Meiteis, who constitute 53% of Manipur's population, pitted against the Kuki-Zo communities in the hills. The state's social fabric was further strained by historical tensions, such as the 1993 riots between Hindu Meiteis and Meitei Pangals (Muslims), which killed around 100-140 people. The 2023 clashes, however, were unprecedented in their scale and ferocity, rendering large swathes of Manipur ungovernable.

The Union government's response has been marked by delay and indecision. Former Chief Minister N. Biren Singh, a polarizing figure accused of exacerbating divisions, remained in office until February 2025, despite his inability to anticipate or contain the violence. His administration was criticized for partisan governance, with allegations that it fanned the flames of ethnic discord rather than fostering reconciliation. Singh's resignation on February 9, 2025, followed by the imposition of President's Rule on February 13, was intended to stabilize the state. However, the suspension of the state assembly, which has a tenure until 2027, has created a political vacuum, leaving Manipur under the administration of Governor Ajay Kumar Bhalla, a former Union Home Secretary who assumed office on January 3, 2025. Bhalla's tenure has been anything but smooth. Tasked with restoring normalcy,



he has faced significant challenges, including a civil disobedience campaign spearheaded by COCOMI, a prominent Meitei organization. The campaign, launched on May 24, 2025, was triggered by an incident on May 20, when central security personnel, reportedly from the 4th Mahar Regiment, allegedly ordered the removal of the words "Manipur State Transport" from a government bus carrying journalists to the Shirui Lily Festival in Ukhrul. COCOMI condemned the act as an affront to Manipur's identity, demanding a public apology from Bhalla and the resignation of Chief Secretary P.K. Singh, Security Advisor Kuldiep Singh, and Director General of Police Rajiv Singh. The group's 48hour statewide bandh, starting May 21, disrupted life in the Imphal Valley, with protests, torch rallies, and sit-ins underscoring the depth of public anger. CO-COMI rejected the government's two-member bureaucratic inquiry into the incident, calling for an independent probe led by a retired High Court judge.

The protests took a dramatic turn on May 26, when Bhalla, returning from New Delhi, was airlifted by an Indian Army helicopter from Imphal International Airport to Kangla Fort, a mere 6 kilometers away, to avoid a human chain of protesters along Tiddim Road. Demonstrators, carrying placards demanding an apology, accused the governor and the President's Rule administration of being disconnected from Manipur's realities. The Congress party, led by figures like Jairam Ramesh and former Chief Minister Okram Ibobi Singh, seized on the incident to criticize the central government. Ramesh, in a post on X on May 27, 2025, argued that President's Rule had "made no difference whatsoever," pointing to Bhalla's helicopter ride as evidence of governance failure. Ibobi, speaking at an event marking Jawaharlal Nehru's death anniversary, called the bus incident "embarrassing" and demanded that the "competent authority" responsible for the order apologize,

described the removal of the state's name as "anti-Manipur," challenging its historical and cultural identity. The organization's call for mass protests, including gheraoing Raj Bhavan and boycotting central government offices, highlights a growing sense of alienation. Women protesters in Bishnupur and Thoubal districts even pasted "Manipur/Kangleipak" on security vehicles, a defiant act of reclaiming identity. COCOMI's broader demands include not only an apology but also a rejection of what it calls the "surrender of governance to narco-terror threats" under President's Rule.

The push to form a new government adds another layer of complexity. On May 28, 2025, ten MLAs, including eight from the BJP, one from the National People's Party (NPP), and one Independent, met Governor Bhalla to press for a "popular government." BJP legislator Thokchom Radheshyam Singh claimed the support of 44 MLAs, excluding the ten Kuki-Zo MLAs and five Congress MLAs. However, ethnic divisions and internal BJP rivalries cast doubt on the feasibility of this move. The choice of a new chief minister remains contentious, with Singh's legacy as a divisive figure looming large. The Indian Express reported on May 29, 2025, that the lack of unanimity among MLAs could undermine government formation, while the ethnic fault lines between Meiteis and Kuki-Zo communities make consensus elusive.

Congress leaders have been vocal in their criticism. Keisham Meghachandra Singh, president of the Manipur Pradesh Congress Committee, alleged that both the 'double-engine" BJP government and President's Rule had failed Manipur. In a post on X, he demanded Bhalla's recall and Home Minister Amit Shah's resignation, accusing them of neglecting the state. Meghachandra questioned who authorized the removal of "Manipur" from the bus, warning that erasing the state's name within its borders could spell its end.

The Union government's broader ap proach has been criticized for its ad-hocism. The decision to resume traffic on the national highway despite ongoing ethnic clashes was reversed after two months, with the Ministry of Home Affairs admitting that peace could not be restored quickly. The first tripartite meeting between Meitei and Kuki-Zo representatives in April 2025, described by COCOMI as a "symbolic gesture," failed to yield progress. The Justice Gita Mittal committee, tasked with overseeing relief and rehabilitation since August 2023, had its tenure extended to July 31, 2025, but its impact remains limited. Meanwhile, the state's economy and social cohesion continue to fray, with shutdowns like the "Sintha Leppa" on May 3, 2025, marking the violence's second anniversary, paralyzing the Imphal Valley and hill districts.

Manipur's crisis demands a nuanced, long-term strategy, not short-term political maneuvers. The ethnic divide, exacerbated by historical grievances and recent violence, requires dialogue that addresses the insecurities of both Meiteis and Kuki-Zo communities. The bus incident, though a flashpoint, reflects a deeper failure to respect Manipuri identity and pride. Governor Bhalla's efforts to engage with stakeholders are a start, but replacing him with a potentially fractious elected government risks further instability. The Union government must prioritize rebuilding trust through transparent investigations, such as an independent probe into the bus incident, and invest in infrastructure, education, and economic recovery to heal a fractured society.

As Manipur navigates this turbulent period, the path to peace lies in acknowledging its complex ethnic mosaic and historical sensitivities. The protests over the bus incident underscore a collective yearning for dignity and recognition. Strengthening the governor's initiatives, fostering inter-community dialogue, and addressing systemic issues like unemployment and displacement are critical

Firstly, civil–military fiscal transparency must be integrated into programme design. This requires detailed reporting on defence spending, off-budget security expenditures, and military control over state-owned enterprises. Without such disclosures, assessing whether proposed reforms are credible or merely performative becomes nearly impossible. Transparency in these domains is essential to understanding the actual fiscal structure of fragile states and ensuring that IMF funds are not inadvertently sustaining entrenched power networks.

Secondly, the IMF should distinguish conflict-induced debt from other forms of macroeconomic distress. When a country's economic instability is rooted in prolonged military escalation or provocative foreign policy behaviour, additional scrutiny must precede financial disbursement. The intent is not punitive, but precautionary: to avoid reinforcing actions that undermine peace and regional stability. By flagging such debt separately, the IMF can better align its lending practices with broader international peacebuilding efforts.

Thirdly, regional impact assessments should precondition large financial packages to be distributed to countries in active or latent conflict zones. These assessments must include data on ceasefire violations, sanctions exposure, and FATF compliance, helping the Fund anticipate the spillover risks of its decisions. Independent audits should be mandated in high-risk areas, particularly defence and internal security, to ensure accountability and mitigate misuse. Such mechanisms will help protect the integrity of IMF assistance in politically volatile contexts.

Finally, it must be acknowledged that while the IMF was never intended to function as a conflict-resolution body, its lending decisions today carry undeniable geopolitical consequences. As fragile states increasingly blur the lines between economic fragility and strategic risk, the IMF can no longer afford to rely solely on technical neutrality. Financial support that ignores how power is exercised will fail to deliver genuine reform. Cracks appear in ties between Donald Trump and his buddy Elon Musk

▼ racks have begun to emerge in the Trump-Musk relationship as the latter has shown his disappointment with President Donald Trump on the recent domestic policy endorsed by the Congress. He said in a TV interview that he was "disappointed" that it would increase the federal deficit.

"I was, like, disappointed to see the massive spending bill, frankly, which in-

creases the budget deficit, not just decrease it, and undermines the work that the DOGE team is doing," Musk told CBS' "Sunday Morning" in an interview. The GOP has been constantly criticizing the previous Biden administration for

increasing the budget deficit and had been going hammer and tongs with spending cuts. Now the Trump administration seems to have fallen into the same trap of deficit balloon for an entirely set of different reasons.

Musk's public break comes as the Republicans' bill heads to the Senate, where several senators have also criticized the legislation for increasing the deficit. The legislative package encompasses many of Trump's priorities, and the president has urged Congress to send the bill to his desk for a signature "as soon as possible."

He has called it the Big Beautiful Bill, and for the urban middle class its anything but beautiful, as Trump has sought to cut down the expenditure on Medicare and Medicaid, considered a socialistic

measure, to compensate for the tax cuts he is offering the rich bold and beautiful. In the first instance the bill eliminated 8 million people from their eligibility avail of the benefits of the bill.

Secondly it enhances coverage under the two schemes by boosting the cost by over \$1,000 which coming on top of inflation and grocery prices could end up being unacceptable to the middle-class populations.

This is how its playing out: Biden pandered to the middle-class expanding Obamacare offering them discounted Medicare and Medicaid and making up the losses by taxing the rich, but trump has gone in reverse gear cutting down on expenditure on Medicare and Medicaid on specious grounds that many were falsely doctored into the scheme and by saving thus subsidise the rich by lowering their taxes.

Biden depended on the middle class votes for his party to retain power. But Trump needs donations from the rich to

sustain his election campaigns as the cases foisted against him during the Biden era, not that Biden was responsible for it, but his own doings put a big hole in his pocket also drained out the finances of the GOP which subsidized is court cases expenditure.

Now that Biden is out, Trump could also see his policies boomeranging on him in the November 2026 mid-term elections to the house. The urban middle class is deeply disappointed with Trump, whom they voted for against Biden, has not delivered on the promise of keeping prices down. In fact, prices have gone up to the contrary.

mogul's remarks in the interview also come as he has suggested he would be backing away from his administration role to return his attention to the private sector. Musk said in a post on X last week that he had to be "super focused" on his companies and was "back to spending

24/7 at work and sleeping in conference/server/factory rooms."

Medicaid, Medicare, and Obamacare are distinct but related healthcare programs. Medicaid and CHIP (Children's Health Insurance Program) provide health coverage for low-income individuals and families, while Medicare primarily serves people age 65 and older and some individuals with disabilities. The Affordable Care Act (ACA), often referred to as Obamacare, expanded health insurance access through the Health Insurance Marketplace and Medicaid expansion.

While Musk was highly enthused about Trump about reducing expenditure and reduce the deficit in the budget, it's not

working that way. Not only is the work he was doing in DOGE being undone by Trump with his domestic policies that was not putting in place a watertight scheme that brings in more revenue and compensates for Trumps tax cuts.

DOGE cuts down heavily on government jobs considered redundant and saves expenditure, but Trump's budget effects huge tax cuts on the bold and beautiful rich people and does not bring in the revenue needed, the cuts in government jobs, health care are not being compensates in an equal measure by increased revenues which is leading to the deficit – back to square one of Biden.

Musk, a Trump ally and top White House figure, has also distanced himself from the president on his tariff policies. Musk, whose automaker Tesla has parts made in North America, China and Europe, has called for a "zero-tariff situation" between Europe and the U.S., and positioned himself as an advocate of "free trade and lower tariffs." 



ness the miraculous ice Shiva Linga, believed to be a divine manifestation of Lord Shiva. While religious beliefs uphold this structure as a sacred phenomenon, the science behind its formation offers an equally intriguing explanation.

The periodic appearance and disappearance of the ice Shiva Linga have long fascinated both spiritual seekers and researchers. This article delves into the environmental and scientific processes responsible for this extraordinary occurrence.

A Sacred Destination in the Himalayas Situated in Jammu and Kashmir, around 141 kilometers from Srinagar, the Amarnath Cave is surrounded by snow-capped peaks.

For most of the year, harsh weather conditions render the area nearly inaccessible. However, between June and August, as summer melts the surrounding snow, the cave opens to pilgrims undertaking the annual Amarnath Yatra

The cave, standing at approximately 40 meters (130 feet) in height, maintains an environment conducive to ice formation. As the pilgrimage season progresses, the ice Shiva Linga reaches its maximum size around the time of Shravana Purnima (full moon in July-August), before gradually melting away with the rising temperatures.

The Scientific Explanation Behind the Ice Shiva Linga

The natural formation of the Shiva Linga is primarily attributed to the freezing of moisture within the cave. Water seeps in through natural fissures in the surrounding rocks and glaciers. Due to the cave's low temperatures, this moisture condenses and gradually freezes, forming an ice structure over time.

This process is similar to how stalactites and stalagmites develop in limestone caves, except that instead of minerals, frozen water accumulates to create the Shiva Linga.

Another critical scientific factor influencing the formation is sublimation and condensation. Sublimation occurs when ice transitions directly into vapor without becoming liquid—a process common at high altitudes where atmospheric pressure is low.

At night, as temperatures inside the cave drop further, water vapor condenses and refreezes onto the existing ice, causing the Shiva Linga to grow. Conversely, during the daytime, slightly warmer temperatures lead to minor sublimation, contributing to its gradual shrinkage. This continuous cycle of condensation and freezing explains the Shiva Linga's characteristic waxing and waning.

The Role of Temperature and Humidity The cave's internal climate plays a crucial

role in determining the ice formation. Because it remains significantly colder than the external environment, seepage from surrounding glaciers consistently provides water, sustaining the process.

Humidity levels also influence the size of the Shiva Linga. When humidity is high, as it often is during the monsoon season, increased moisture in the air leads to greater condensation and ice accumulation. This explains why the Shiva Linga reaches its largest size in July and August, when humidity is at its peak.

Connection to the Lunar Cycle

A long-standing belief among devotees is that the ice Shiva Linga expands and contracts in sync with the moon's phases. While this phenomenon holds spiritual significance, some scientists propose that temperature fluctuations and humidity variations-potentially influenced by lunar gravity-could contribute to these changes

The full moon is known to bring subtle shifts in atmospheric pressure and humidity, which might impact the condensation and freezing process inside the cave. However, this correlation remains an area of speculation rather than definitive scientific proof.

The Annual Cycle of Formation and Melting

Each year, as summer temperatures rise, the ice Shiva Linga gradually melts, eventually disappearing by late August or early September. As winter approaches, the cycle resets. Water seeping into the cave freezes again during the colder months, laving the foundation for the next year's formation.

Interestingly, variations occur from year to year. Some seasons see the Shiva Linga forming earlier or later, or appearing larger or smaller than usual. These changes depend on environmental factors like snowfall levels, glacier activity, and overall climatic conditions.

and science. For millions of Hindus, it is a sacred symbol of divine presence, reinforcing their spiritual beliefs. From a scientific standpoint, it is a remarkable example of how environmental conditions align to create a unique natural structure.

These perspectives are not necessarily conflicting. Rather, understanding the scientific processes enhances appreciation for the wonder of nature, without diminishing the spiritual significance that devotees attach to the phenomenon.

Environmental Challenges and Preservation Efforts

The increasing number of pilgrims and tourists visiting Amarnath has raised concerns about its ecological impact. Pollution, waste accumulation, and rising temperatures pose potential threats to the ice Shiva Linga's natural formation.

To address these challenges, environmentalists and local authorities are implementing measures to regulate visitor numbers and promote eco-friendly pilgrimage practices. Key initiatives include:

Limiting visitor access: Authorities have introduced caps on the number of pilgrims allowed inside the cave at a given time.

Reducing pollution: Encouraging biodegradable offerings and minimizing waste disposal in and around the cave.

Climate monitoring: Studying the effects of climate change on the ice formation process and proposing conservation strategies accordingly.

A Phenomenon Worth Preserving

The ice Shiva Linga of Amarnath remains an extraordinary marvel-one that continues to inspire awe among devotees and scientists alike. While religious beliefs celebrate it as a divine manifestation, science attributes its formation to a complex interplay of temperature, humidity, and condensation processes.

Regardless of one's perspective, the Shiva Linga's existence reminds us of nature's intricate workings and the importance of preserving such sacred sites for future generations. Understanding its scientific basis does not detract from its spiritual significance: rather, it deepens our admiration for this natural wonder, which seamlessly blends faith, geography, and meteorology.

As pilgrimage traditions continue and scientific research advances, the Amarnath Cave will remain a place of reverence, wonder, and discovery-a testament to both devotion and the beauty of the natural world. Death toll reaches 151 in north-central Nigeria town submerged in floods, thousands displaced

ABUJA (NIGERIA), May 31: At least 151 people have now been confirmed dead after heavy rainfall unleashed flooding in a market town in north-central Nigeria, the local emergency services told The Associated Press on Saturday.

More than 3,000 people were displaced in the flooding in the town of Mokwa in Niger state, more than 300 kilometres west of Abuja, the capital of Africa's most populous nation, Niger state emergency agency spokesman Ibrahim Audu Husseini said.

At least 500 households across three communities were affected in the predawn rain Friday, leaving roofs barely visible and residents waist-deep in water, Husseini added. (AP)

34 terrorists arrested. major attack foiled in Pakistan's Punjab

LAHORE, May 31: At least 34 terrorists were arrested when a major terror attack was foiled by law enforcement agencies in Punjab province of Pakistan, a statent said on Saturday

VIENNA, May 31: Iran has further increased its stockpile of uranium enriched to near weapons-grade levels, a confidential report by the UN nuclear watchdog said on Saturday and called on Tehran to urgently change course and comply with the agency's probe. The report comes at a sensitive time as

Tehran and Washington have been holding several rounds of talks over a possible nuclear deal that US President Donald Trump is trying to reach.

The report by the Vienna-based International Atomic Energy Agency — which was seen by The Associated Press — says that as of May 17, Iran has amassed 408.6 kilogrammes of uranium enriched up to 60 per cent. That's an increase of 133.8 kilogrammes since the IAEA's last report in February.

That material is a short, technical step away from weapons-grade levels of 90 per cent. A report in February put the stockpile at 274.8 kilogrammes.

The IAEA chief Rafael Mariano Grossi has stressed repeatedly that "Iran is the only nonnuclear weapon state enriching to this level". On Saturday, Grossi said he "reiterates his

urgent call upon Iran to cooperate fully and effectively" with the IAEA.

On Thursday, senior Iranian officials dismissed speculation about an imminent nuclear deal with the United States, emphasising that any agreement must fully



lift sanctions and allow the country's nuclear program to continue.

The comments came a day after Trump said he has told Israeli Prime Minister Benjamin Netanyahu to hold off on striking Iran to give the US administration more time to push for a new nuclear deal with Tehran.

Trump said on Friday that he still thinks a deal could be completed in the "not too distant future"

"They don't want to be blown up. They would rather make a deal," Trump said of Iran. He added, "That would be a great thing that we could have a deal without bombs being dropped all over the Middle East."

Trump said he's warned Israeli Prime Minister Benjamin Netanyahu from carrying out preemptive strikes on Iran's nuclear program, while the talks are playing out. (AP)

Most of the arrested militants belong to the banned Tehreek-e-Taliban Pakistan (TTP) group, with three of them categorised as the "most dangerous terrorists", a Counter-Terrorism Department (CTD) statement said.

The statement said it conducted 415 intelligence-based operations in different districts of the province during this week and arrested 34 terrorists

It said the terrorists planned to target law enforcers and important buildings in the province and were arrested from various locations in Lahore, Rawalpindi, Gujranwala, Jhelum, Bahawalpur, Sahiwal, Narowal, Jhelum, Pakpattan, Bahawalnagar, Bukhara, Kasur and Nankana Sahib. (PTI)

Appeals court keeps block on Trump administration's downsizing of federal workforce

SAN FRANCISCO, May 31: An appeals court on Friday refused to freeze a California judge's order halting the Trump administration from downsizing the federal workforce, which means that DOGE-led cuts remain on pause for now.

The Republican administration had sought an emergency stay of an injunction issued by US Judge Susan Illston of San Francisco in a lawsuit brought by labour unions and cities, including San Francisco and Chicago.

The judge's order questioned whether Trump's administration was acting lawfully in trying to pare the federal workforce. Trump has repeatedly said voters gave him

a mandate to remake the federal government,

and he tapped billionaire Elon Musk to lead the charge through the Department of Government Efficiency (DOGE).

Tens of thousands of federal workers have been fired, have left their jobs via deferred resignation programmes or have been placed on leave. There is no official figure for the job cuts, but at least 75,000 federal employees took deferred resignation, and thousands of probationary workers have already been let

Illston's order directs numerous federal agencies to halt acting on the president's workforce executive order signed in February and a subsequent memo issued by DOGE and the Office of Personnel Management. (AP)

Country that made smoking sexy is breaking up with cigarettes

'Tobacco must disappear where there are children'

PARIS, May 31: Brigitte Bardot lounged barefoot on a Saint-Tropez beach, drawing languorous puffs from her cigarette. Another actor, Jean-Paul Belmondo, swaggered down the Champs-Elysees with smoke curling from his defiant lips, capturing a generation's restless rebellion.

In France, cigarettes were never just cigarettes - they were cinematic statements, flirtations and rebellions wrapped in rolling paper.

Yet beginning July 1, if Bardot and Belmondo's iconic film scenes were repeated in real life, they would be subject to up to 135 euros (USD 153) in fines.

After glamorising tobacco for decades, France is preparing for its most sweeping smoking ban yet.

The new restrictions, announced by health minister Catherine Vautrin, will outlaw smoking in virtually all outdoor public areas where children may gather, including beaches, parks, gardens, playgrounds, sports venues, school entrances and bus stops.

"Tobacco must disappear where there are children," Vautrin told French media. The freedom to smoke "stops where children's right to breathe clean air starts".

If Vautrin's law reflects public health priorities, it also signals a deeper cultural shift. Smoking has defined identity, fashion and cinema here for so long that the new measure feels like a quiet French revolution in a country whose relationship with tobacco is famously complex.

According to France's League Against Cancer, over 90 per cent of French films from 2015 to 2019 featured smoking scenes — more than double the rate in Hollywood productions. Each French movie averaged nearly three minutes of on-screen smoking, effectively the same exposure as six 30-second television ads.

Cinema has been particularly influential. Belmondo's rebellious smoker in Jean-Luc Godard's "Breathless" became shorthand for youthful defiance worldwide. Bardot's cigarette smoke wafted through "And God Created Woman", symbolising unbridled sensuality.

Yet this glamorisation has consequences. According to France's public health authorities, around 75,000 people die from tobacco-related illnesses each

Although smoking rates have dipped recently — fewer than 25 per cent of French adults now smoke daily, a historic low — the habit remains stubbornly embedded, especially among young people and the urban chic.

France's relationship with tobacco has long been fraught with contradiction. Air France did not ban smoking on all its flights until 2000, years after major US carriers began phasing it out in the late 1980s and early '90s.

The delay reflected a country slower to sever its cultural romance with cigarettes,

even at 35,000 feet. Strolling through the stylish streets of Le Marais, the trendiest neighbourhood in Paris, reactions to the smoking ban ranged from pragmatic acceptance to nostalgic defiance.

"It's about time. I don't want my kids growing up thinking smoke is romantic,' said Clémence Laurent, a 34-year-old fashion buyer, sipping espresso at a crowded café terrace. "Sure, Bardot made cigarettes seem glamorous. But Bardot didn't worry about today's warnings on lung cancer.'

At a nearby boutique, vintage dealer Luc Baudry, 53, saw the ban as an attack on something essentially French. "Smoking has always been part of our culture. Take away cigarettes and what do we have left? Kale smoothies?" he scoffed.

Across from him, 72-year-old Jeanne Lévy chuckled throatily, her voice deeply etched — she said — by decades of Gauloises. "I smoked my first cigarette watching Jeanne Moreau," she confessed, eyes twinkling behind vintage sunglasses. 'It was her voice - smoky, sexy, livedin. Who didn't want that voice?

Indeed, Jeanne Moreau's gravelly, nicotine-scraped voice transformed tobacco into poetry itself, immortalised in classics such as François Truffaut's "Jules et Jim". Smoking acquired an existential glam-

our that made quitting unimaginable for generations of French smokers. (AP)

ITANAGAR, May 31: At least nine people have been killed in flash floods and landslides in Arunachal Pradesh after heavy rainfall in the past few days, officials said on Saturday.

Seven members of two families lost their lives after their vehicle was swept off the road by a landslide late Friday night along the Bana-Seppa stretch of National Highway 13 in East Kameng district, police said.

The vehicle was en route to Seppa from Bana in Bichom district when a sudden landslide triggered by heavy rainfall pushed it into a deep gorge, said East Kameng Superintendent of Police (SP) Kamdam Sikom.

'All the victims were residents of Kitchang village in Bana," he said.

Rescue efforts began immediately but were severely hampered by torrential rain, fresh landslides, and extremely poor visibility through the night. Despite these challenges, police and rescue teams continued their efforts.

"On Saturday, the operation resumed with vital support from local villagers. After several hours of a painstaking search, the wreckage was located approximately 150 metres below the highway," Sikom said, adding that all seven occupants were found dead inside.

The deceased have been identified as 35-year-old Shankar alias

reported at Jyoti Nagar, Dirang, Padma, and Durga Mandir in the district.

District Disaster Management Officer (DDMO) Mindu Yangzom said Border Roads Organisation (BRO) teams and machinery have been deployed near Jamiri, though continuous rain has hampered restoration efforts.

A major landslide in Petaling colony in Bomdila, the district

headquarters, on Friday washed away portions of roads and culverts and an abandoned house.

Though no casualties were reported, landslides caused disruptions in power supply.

Road connectivity between Nafra-Nakhu-Nachibom villages in West Kameng and Bichom district was cut off due to landslides at several points, leaving many commuters stranded.

The DDMO in West Kameng district has issued an advisory, urging people to avoid landslide-prone areas, streams, and unstable zones. Citizens have been warned

against venturing into water bodies for fishing or hunting and advised to evacuate immediately in case of flash floods or landslides.

CM lays digital foundation for ₹750-cr education infrastructure projects

NAMSAI, May 31: In a major step towards transforming the education sector in Arunachal Pradesh, Chief Minister Pema Khandu on Saturday digitally laid the foundation stones for a range of infrastructure development projects valued at ₹750 crore.

The projects, to be implemented by the Rural Works Department (RWD) during the financial year 2025-26, fall under the ambit of the state's Education Department.

According to an official statement, the initiative is a key component of the state government's Shikshit Arunachal 2029 Mission, which aims to address infrastructure gaps and improve the overall quality of education across government schools.

A significant portion of the funding will be used to upgrade 39 government higher secondary schools under the SASCI scheme at a cost of ₹300 crore.

An additional ₹322 crore has been earmarked for the construction of 156 hostels and teachers' quarters in various districts, also under the SASCI scheme.

Further, the plan includes the development of 14 large-capacity hostels, each accommodating 120 students, under the DAJGUA scheme at a cost of ₹71.40 crore.

Sixty bachelor barracks for school staff in rural areas will be built with a budget of ₹9 crore.



One more tests positive for COVID-19 in Arunachal, tally rises to 3

ITANAGAR, May 31: A 51-year-old man has tested positive for COVID-19 in Arunachal Pradesh, taking the total number of infections in the current wave to three in the state, a senior health official said on Saturday.

The man had undergone a rapid antigen test at Ramakrishna Mission Hospital (RKMH) here on May 28 and was found positive for the coronavirus infection, he said.

Arunachal Pradesh had earlier reported two cases of the new COVID-19 variant on May 27, State Surveillance Officer Dr Lobsang Jampa said.

These cases were detected through RT-PCR tests at the Virus Research and Diagnostic Laboratory (VRDL) of Tomo Riba Institute of Health and Medical Sciences (TRIHMS), he said.

A 34-year-old woman, who is in her 21st week of pregnancy, tested positive after she had developed COVID-like symptoms of fever and mild cough.

The woman had arrived in Itanagar from Bengaluru on May 13. The woman's 53-year-old mother also tested positive for the infection but remained asymptomatic.

The pregnant woman is currently admitted to a hospital, while her mother has been placed under isolation, the official said. Jampa urged the public not to panic, assuring that the new strain appears to be less severe than earlier variants. "The health department is closely monitoring the situation and taking all necessary precautions to prevent the spread of the virus. We are also tracing all possible contacts the two women may have had," he added.

He noted that a comprehensive public health advisory will be issued soon after consultation with the National Centre for Disease Control (NCDC) in Delhi.

So far, the state health department has tested four samples, of which three have been found positive, the official added. (PTI)

Bullets will be answered with cannon balls: Modi warns Pak

'This means the BJP government is empowering our sisters and daughters at every level and in every field

BHOPAL, May 31: Prime Minister Narendra Modi on Saturday said proxy wars by terrorists will not work and bullets will be answered with cannon balls, adding that 'sindoor' has become a symbol of valour following India's response to the Pahalgam terror attack.

He also described Operation Sindoor as the biggest and most successful anti-terror operation in the country's history.

Speaking at the 'Lokmata Devi Ahilyabai Mahila Sashaktikaran Maha Sammelan' here on the occasion of the legendary queen's 300th birth anniversary, Modi said, "Through a decisive response, Bharat gave a message that proxy war by terrorists will not work. Bharat, a land of culture and values, sees sindoor as a symbol of women's power. Today, that same sindoor has become a symbol of our valour and resistance to terrorism." "If you fire bullets, then rest assured that they will be answered with cannon balls," Modi said.

"India is a country of culture and traditions, and sindoor is a symbol of women power in our tradition. Hanuman ji, who is immersed in Ram Bhakti, also sports sindoor. We offer sindoor in Shakti Puja. This sindoor has become a symbol of bravery," he said.

Earlier this month, Indian armed

forces carried out missile strikes on nine terror targets in Pakistan and Pakistan-Occupied Kashmir under Operation Sindoor. The operation was conducted two weeks after the massacre of 26 civilians in Kashmir's Pahalgam.

Sindoor or the vermillion mark symbolises the marital status of Hindu women, and its use as the operation's name resonated powerfully in light of the April 22 Pahalgam massacre.

"In Pahalgam, terrorists not only shed the blood of Indians, but also attacked our culture. They tried to divide our society and the biggest thing is that they challenged the women power of India," Modi said. "This challenge has sounded the death knell for terrorists and their handlers. Operation Sindoor is the biggest and most successful operation in the history of India against terrorists. While the Pakistan army could not even imagine, our army destroyed the terrorist hideouts," he added.

Rani Ahilyabai Holkar was born on May 31, 1725, at Chondi village in Maharashtra's Ahilyanagar. She ruled the Malwa region of central India from 1767 to 1795, as the queen of the Holkar dynasty in the Maratha Empire. 'When we talk of girls' mar-

riageable age, some people in the country see secularism in danger. They think it is against our religion. But Devi Ahilyabai thought about the marriageable age of girls in those times," he said.

"She got married at an early age. She knew the way to girl's progress. In Malwa Sena, she created a special battalion of women. These people of the western world do not know. They curse us in the name of the rights of women and try to portray us in a bad light. Women were in our army even 250-300 years ago. At village level, she created safety groups for women," Modi noted.

"When the country was in shackles of slavery 250-300 years ago, it was not easy to do something so impactful that future generations would remember it. But Devi Ahilyabai did it. She never separated devotion to God from service to the people," he said. (PTI)

Constitution should be credited for keeping country united during crises: CJI



The Constitution has ensured that whenever the country has faced a crisis, it has remained united and strong, Chief Justice of India (CJI) B R Gavai said on Saturday.

The CJI was addressing a function after the inauguration of advocate chambers and multi-level parking at the Allahabad High Court here.

"When the Constitution was being made and its final draft was presented before the Constituent Assembly, at that time some people used to say that the Constitution is too federal while some used to say that it is too unitary.

"Babasaheb Bhimrao Ambedkar had replied that the Constitution is neither wholly federal nor wholly unitary. But one thing I can tell you is that we have given a Constitution which will keep India united and strong both in times of peace and war," CJI Gavai said.

He said India has been on the path of development after independence due to the Constitution.

"Today we see what is the condition of our neighbouring countries. And India is making a journey towards development after independence. Whenever there has been a crisis in the country, it has remained united and strong. The credit for this should be given to the Constitution," he said. In the 75-year journey of the

Constitution coming into effect, the legislature, the executive and the judiciary have contributed a lot in bringing social and economic equality, he said.

"It is our fundamental duty to reach out to the last citizen of this country who needs justice. Be it

PRAYAGRAJ (UP), May 31: the legislature, the executive or the judiciary, everyone has to reach out to that citizen," the CJI told the gathering

Referring to the land reforms, he said some laws were brought under which land was taken from the landlord and given to the landless persons.

"These laws were challenged from time to time. Before 1973, the Supreme Court's view was that if there is a conflict between the Directive Principles and the Fundamental Rights, then the Fundamental Rights will prevail."

Gavai said, "In 1973, a decision of 13 judges came that the Parliament has the right to amend the Constitution and for this, it can amend the Fundamental Rights, but it does not have the right to change the basic structure of the Constitution.'

The Chief Justice of India said that this bench had also said that both the Fundamental Rights and the Directives Principles are the soul of the Constitution.

Both of these are the two wheels of the golden chariot of the Constitution, if you stop one of these wheels, the entire chariot will stop. He said, "I have always been saying that the bar and the bench are two sides of the same coin. Unless the bar and the bench work together, the chariot of justice cannot move forward.

"Today the Allahabad High Court has given a good role model for the whole country in which the judges vacated 12 bungalows for the bar (for the construction of the complex) and took care of the convenience of their lawyer brothers." (PTI)

ANDHRA PRADESH, May 31: Andhra Pradesh Chief Minister N Chandrababu Naidu on Saturday said that the TDP-led NDA government works for the poor, executes all programmes, so that they are not put into any trouble.

Addressing a village meeting at Cheyyeru in this district, the chief minister noted that over 64 lakh people in the state receive pensions akin to employees on the first day of every month.

"This government works for the poor. We are doing all the programmes to avoid any trouble for the poor," said Naidu, adding that the NDA government is a unique one in history to disbursing pensions. The state government has so far spent ₹ 34,000 crore on welfare pensions, he added.

He said that the southern state gives welfare pensions more in terms of value and volume than richer states such as Maharashtra and Telangana. Referring to the Deepam-2 scheme, which offers three free cooking gas cylinders to eligible beneficiaries, the CM noted that he will deposit money into the bank accounts of the ben-

Likewise, Naidu called on SC and ST communities to avail solar power scheme (PM Surva Ghar) to generate power on their rooftops and stand a chance of avoiding electricity bills completely, along with the possibility of selling excess power to the grid.

Under this scheme, the TDP supremo highlighted that SC and ST communities will get 100 per cent subsidy, BCs ₹ 98,000 subsidy for 3 kw solar power system and Other Castes (OCs) ₹ 78,000 subsidy. Naidu tasked MLAs and officials to achieve the target of installing 10,000 solar power systems per constituency.

Further, the CM noted that 'Mega DSC' (District Selection Committee) notification has been issued for the recruitment of over 16,000 teachers. Issuing a warning to marijuana and drug users and peddlers, the CM vowed that he would not spare them, underscoring that he set up a separate wing (Eagle) to nab them using drones.

Naidu reiterated his promise to implement 'Talliki Vandanam' (₹ 15,000 per annum for every school going child in a given family) before schools reopen for the 2025-26 academic year in June.

Similarly, he also reiterated the importance of population management, calling on people to have more children to avoid problems such as aging and facing a situation where there would be lower number of workers and higher number of pensioners. When it comes to population, Naidu said South India is at a disadvantage when compared to North India.

The CM also promised to implement 'Annadata Sukhibhava' (₹ 20,000 financial aid to farmers per annum) in three installments soon. Similarly, he also assured to start implementing free bus travel for women from August 15. The CM observed that he is implementing his welfare promises one after the

other as there are several problems. Referring to Konaseema district, Naidu advised the local farmers to incorporate inter-cropping of cocoa or fodder grass in their 90,000 acres of coconut orchards to increase their income. (PTI)

Overflowing water from the Borpani River has already submerged croplands in over 27 villages under the Kampur and Kachua revenue circles, as per district reports.


In response, the district administration has declared a red alert and urged residents living along the riverbanks to remain vigilant.

NEW DELHI, May 31: Actor Manushi Chhillar says working women are often discussed with disrespect and contempt, especially when it comes to entertainment industry but it is different for men. Chhillar got crowned Miss World in 2017 and later went on to make her acting debut with Akshay Kumar-starrer "Samrat Prithviraj" (2022), shared a post on her X handle on Saturday.

The 28-year-old actor said she grew up in an empowered and educated environment where everyone was treated equally.

But she was also "exposed to the mentality" which viewed successful men as "hardworking and talented" individuals, contrary to women, who were perceived as "opportunists, gold diggers or manipulators".

"A misogynistic mindset finds it easier to attribute a woman's success to a man's patronage than her own merit. I've always really ignored silly comments which have no consequence in the real world, but I constantly see working women, specially in the entertainment industry being discussed with such disrespect and contempt," her post began, "I grew up in an empowered, educated environment where irrespective of gender, we all had equal value to add. But I have also been exposed

to this mentality of "men are hardworking and talented if successful, whereas women and opportunists, gold diggers or manipulators," she added.

viewing, particularly for the parental guidance group.

In a gazette notification, the Ministry of Information and Broadcasting amended the rules notified in December 1991 laying down principles for sanctioning films for public exhibition. The rules allow the Central Board of Film Certification (CBFC) to allow certification of films for unrestricted public exhibition with an endorsement in accordance with the nature and type of content with the markers -" 'U/A7+', 'U/A 12+' and 'U/A 16+'.

"Content suitable for a child aged

seven years and above and under the age of seven years with parental guidance shall be classified as "U/A 7+" rating; (ii) content suitable for a child aged thirteen years and above and under the age of thirteen years with parental guidance shall be classified as "U/A 13+" rating; and (iii) content suitable for a child aged sixteen years and above and under the age of sixteen years with parental guidance shall be classified as "U/A 16+" rating," the notification read.

Last year, the CBFC had introduced an updated film certification system aligned with social values and promoting age-appropriate viewing. The rules were substantially overhauled to improve, update and modernise the entire process of certification of films for public viewing. The three age-based categories were suggested for U/A certification against the previous age group of 12 years.

Rules for certifying films are formulated under the Cinematograph Act, 1952. Earlier, there were just two categories: U - for unrestricted public exhibition - and A - restricted to adult audiences, but nudity was not allowed. (PTI)

Raj Khosla@100: The master of suspense and melodrama in Hindi cinema

NEW DELHI, May 31: His first stint in cinema came as a stunt double for a heroine, Waheeda Rehman made her Hindi debut in his film, he wanted to be singer instead went on to become the master of the crime-suspense genre with gems such as "CID" and "Woh Kaun Thi?".

Raj Khosla, the director with unlikely beginnings, would have been 100 on Saturday. He had a limited oeuvre of just over 25 films in 34 years but most stand out in the crowded gallery of Indian movies for their watchability, their star power and perhaps most of all for the many songs heard and remixed even today.

With his centenary -- which will be celebrated in Mumbai with a one-day retrospective of his restored films -cinephiles reopen a chapter of Indian cinema history that may not have got the prominence it deserved. Beginning his movie making career with "Milap" in 1955 and ending with "Naqaab" in 1989, both fairly forgettable, Khosla directed a host of major hits in between. He gave Sadhana three of her best films in "Woh Kaun Thi?", "Mera Saava" and "Anita", worked with Dev Anand in memorable classics, including "Kala Paani" and "Solva Saal", and was mentored by Guru Dutt.

With his second film "CID", a stylish crime drama, Khosla sealed his place as a hit director still remembered. The 1956 film, which also starred Dev Anand and Shakila and introduced Waheeda Rehman, was offered to him by Guru Dutt.

Khosla, the director who carefully balanced art and commerce in his movies, has also given Hindi cinema some of its most memorable songs --"Lag Jaa Gale", "Mera Saaya", "Jhumka Gira Re", "Kahin Pe Nigaahen Kahin Pe Nishaana", "Yeh Hai Bombay Meri Jaan", "Nazar Lagi Raja Torey Bangley Per" and "Hai Apna Dil To Awara" and so many more.

In fact, "Jhumka Gira Re" from "Mera Saaya" has been repurposed in Karan Johar's 2023 film "Rocky Aur Rani Ki Prem Kahani".

Born on May 31, 1925, in Rahon in undivided Punjab, Khosla's parents moved to Mumbai when he was just three. Khosla attended Anjuman-I-Islam school. He completed his college from Elphinstone College, where he became interested in theatre.

Khosla trained in Hindustani classical music from a young age and hoped to make a career in music after graduation but life had other plans. He was a fan of legendary singer



Kundan Lal Saigal and they sometimes did their 'riyaaz' together.

"At my ancestral house in Matunga, just down the road, Mr K L Saigal used to stay, and every day in the morning, dad used to go to his place and do riyaaz. He would listen to him sing as well. He used to practice with him also. This was an everyday ritual," Khosla's daughter Sunita Bhalla told PTI.

"Later, KL Saigal sahab told dad, "Why don't you go and sing on the radio or in movies'. So, he got twothree opportunities to sing in films and

s he sang as well. This was before he made his debut as a director with 'Milap'," she recalled.

According to "Raj Khosla: The Authorized Biography" by Amborish Roychoudhury, Khosla worked briefly at a bank after college but quit the job after just three months.

His first stint in cinema came as a stunt double for a heroine. He had to ride a horse. Khosla was paid Rs 75 for this adventure.

He would eventually make his acting debut with a film called "Raen Basera"

where he also got to sing for one of the songs. But the movie did not do well and Khosla continued to search for playback opportunities. He got his second song for "Bhool Bhulaiyan", the book says.

The singing career was shortlived. It was his friendship with Dev Anand, a rising star at the time and the actor of many of Khosla's hits later, which changed the course of his life.

Dev Anand offered Khosla a chance to work as an assistant director with Guru Dutt on "Baazi" and promised that he would get a chance to sing as well. And life took a turn.

The book has Khosla telling Nasreen Munni Kabir in an interview, "I met Guru Dutt and he asked me, 'Have you any experience in assisting?' I said, 'Yes, I have.' Tommy-rot, I knew nothing about film-making. The second thing he asked, 'Do you know Hindi?' I replied, 'Of course I know Hindi.' Guru Dutt said, 'Okay, start from tomorrow'." "I couldn't actually write in Hindi. I'm from Punjab, Gurdaspur, so I knew Urdu. In those days, in the Punjab learning Urdu was very common; even now you will find that many Punjabis who are over forty know how to write Urdu, not Hindi," he is quoted as saying.

The first thing Khosla did after the meeting was to buy a book on the Hindi alphabets and learn the letters from scratch, the biography goes on to say.

Khosla assisted Guru Dutt on "Jaal" (1952) and "Aar Paar" (1954). In fact, his directorial debut "Milap" starred his friend Dev Anand and Geeta Bali, who was married to Guru Dutt.

The very next year came "CID", which propelled him to the big league. After that came back to back hits in "Kala Pani", "Solva Saal", both in 1958, and "Bombai Ka Babu", all with Dev Anand.

In 1964, he directed "Woh Kaun Thi?", a ghostly tale starring Sadhana, Manoj Kumar and Prem Chopra. The movie set the standard for Bollywood suspense and established Khosla's flair for moody psychological dramas. Sadhana's dual performance as the twin sisters and Madan Mohan's haunting music, including the still-popular track "Lag Jaa Gale" sung by Lata Mangeshkar.

In 1966's "Mera Saaya" was another gem from Khosla in the thriller space that once again featured Sadhana in a dual role. The film cemented his reputation as a filmmaker who could blend suspense with emotion. (PTI)

Alcaraz cruise into fourth round of the French Open

PARIS, May 31: Defending champion Carlos Alcaraz reached the fourth round of the French Open after laboring past Damir Dzumhur 6-1, 6-3, 4-6, 6-4 in the night session

The second-seeded Spaniard had never before played Dzumhur, a 33-year-old Bosnian who had never been past the third round at any major tournament.

"I suffered quite a lot today," Alcaraz said.

"The first two sets was under control, then he started to play more deeply and more aggressively. It was really difficult for me." Dzumhur hurt his left knee in a fall in the second round, and had treatment on Friday on his right leg during the changeover at 3-2 down in the third set. He then laid down on the ground while the trainer worked on both legs for several minutes

The crowd on Court Philippe-Chatrier did a Mexican wave and shouted "Olé" while it waited.

Then Dzumhur received cheers when he made an improbable smash despite being off balance. again when he won the third set, and once more when he broke Alcaraz in the opening game of the fourth set.

An improbable turnaround seemed to be happening as Alcaraz made clumsy unforced errors, hitting routine-looking winners long or forcing shots on his usually accurate forehand. At one point in the fourth set, Alcaraz even stared down at the clay in frustration after sending a booming forehand way out. But the four-time Grand Slam singles champion broke back in the sixth and the eighth games to serve for the match.

Still, the resilient Dzumhur, whose face was red with effort and glistening with sweat, broke back to drag the suspense out a little longer.

"That's why it's difficult to win Grand Slams because you have to maintain your focus over three or four hours," Alcaraz said. "I didn't enjoy it too much."

Alcaraz finally clinched victory on his second match point and faces No. 13 Ben Shelton in the fourth round. (AP)

PARIS, May 31: Defending champion Iga Swiatek joined No. 1ranked Aryna Sabalenka in the fourth round of the French Open and neither player has dropped a set.Sabalenka, a three-time Grand Slam winner who has only once reached the semifinals at Roland-Garros, beat Olga Danilovic 6-2, 6-3 on Court Philippe-Chatrier, where the hot weather contrasted with previous days

"The ball flies much faster," Sabalenka said. "The bounces are much higher." Swiatek, who has won four of her five major titles at Roland-Garros, defeated Jaqueline Cristian 6-2, 7-5 on Court Suzanne-Lenglen to extend her French Open winning streak to 23 matches. A second set lasting 1 hour, 16 minutes, tested the Pole, who yelled in relief after winning on her second match point. Swiatek had 20 winners and 21 unforced errors.

"She used her chances and just went for it," said Swiatek, who enjoyed temperatures which reached 29 degrees (84 F). "For sure I don't mind. On clay it gives the balls the extra bounce." Sabalenka and Swiatek have been in contrasting form. Sabalenka has reached six

singles finals this year, the most for a woman entering Roland-Garros since Serena Williams in 2013. But Swiatek is looking to reach her first final anywhere since winning her third straight French Open title, and fourth overall, a year ago. No woman has won four straight French Opens in the Open era. Asked who was under the most

pressure to win this year - her or Swiatek — Sabalenka said, jokingly: "Let's just leave it on Iga since she won it, what, three times in a row?

Defending men's champion Carlos Alcaraz labored to a 6-1, 6-3, 4-6, 6-4 win against Damir Dzumhur, meaning the four-time major winner has dropped two sets so far. No. 4-seeded Jasmine Paolini, last year's runner-up, beat Ukrainian Yuliia Starodubtseva 6-4, 6-1, and No. 12 Elena Rybakina won against 2017 champion Jelena Ostapenko. Olympic champion Zheng Qinwen beat 18-year-old qualifier Victoria Mboko 6-3, 6-4, while No. 16 Amanda Anisimova and Liudmila Samsonova also advanced. In men's

Inter Kashi set to move CAS

again after AIFF upholds

NEW DELHI, May 31: I-League club Inter Kashi is set to knock on the doors of the Court of Arbitration for Sport (CAS) for a second time after the All India Football Federation upheld the appeal of Namdhari FC, Real Kashmir and Churchill Brothers against the Varanasi-based club over re-registration of Mario Barco.

The AIFF appeals committee's latest judgement means four points would be deducted from Inter Kashi while two would get added to Churchill's tally and Namdhari would get three.

Thus Churchill would rise to an "unassailable" 42 points and would be champions irrespective of Kashi's appeal at CAS.

Inter Kashi would drop to 37 points while sixth-placed Namdhari would jump to 35 points.

Inter Kashi said they would appeal against the judgement at CAS -- the highest court to adjudicate sports disputes internationally -where an appeal by club is pending.

"Inter Kashi will now appeal the decision at the Court of Arbitration for Sport. While it is unfortunate that Inter Kashi has to approach CAS yet again for a truly free and fair hearing of the matter, it seems to be the new reality of Indian football," Inter Kashi said in statement and posted it on X.

"The club fully believes that a free and fair hearing at CAS will bring all relevant facts to the forefront. There will be no further comment on this matter at this time," the club added in the statement. In its order passed on Saturday, the AIFF appeals committee rejected the league committee's earlier decision, saying that the ruling cannot be used for making an ineligible player (Mario Barco) into a valid player for Inter Kashi. In the provisional standings, Churchill had 40 points from 22 matches, one point more than Kashi, while Real Kashmir were third with 37 points.

The I-League officially concluded on March 31, and after weeks of uncertainty, the AIFF ap-

peals committee declared Churchill Brothers as champions on April 19. But Inter Kashi appealed against the ruling at CAS, which had asked the AIFF to not declare Churchill Brothers as I-League champions or organise medal ceremony. The CAS had staved the AIFF's decision while hearing the appeal from Inter Kashi

A ruling from the Deputy President of the CAS Appeals Arbitration Division Sport had stated: "The All India Football Federation is ordered not to declare the winner of the I-League 2024/2025 or organise a medal ceremony for the I-League 2024-25 until the present arbitration has been concluded."

The AIFF meanwhile announced a set of amendments to its regulations on the status and transfer of players, which will come into effect from June 1

The AIFF said it focuses on enhancing player welfare, supporting women's football and youth football more effectively, and improving regulatory transparency.

'A standout feature of the updated regulations is the increased attention to the rights and well-being of female players," the sports body said.

The AIFF said it has "introduced provisions addressing menstrual health, allowing female players to take leave from training during the onset of their menstrual cycle.

"Expanded clauses now also cover pregnancy, adoption, and family leave for both players and coaches, aiming to create a more inclusive environment for women in the sport.

"The amendments also introduce structural reforms in player transfers and youth development. New limitations on the number and duration of player loan deals have been set to ensure fairness.

"To safeguard young talent, the AIFF has revised its regulations concerning the registration of minors at academies, emphasising child protection in accordance with FIFA standards." (PTI)

"The introduction of mandatory testing will be part of a new policy on Sex, Age and Weight' to ensure the safety of all participants and deliver a competitive level playing field for men and women," World Boxing wrote in a statement. The fighters' national federations will be responsible for administering the tests and providing the results to World Box- her inclusion.

World Boxing announced that all athletes over 18 years old in its competitions must undergo a polymerase chain reaction (PCR) genetic test to determine their sex at birth. The PCR test detects chromosomal material through a mouth swab, saliva or blood.

If an athlete intending to compete in the women's categories is determined to have male chromosomal material, "initial screenings will be referred to independent clinical specialists for genetic screening, hormonal profiles, anatomical examination or other valuation of endocrine profiles by medical specialists,' World Boxing wrote. The policy also includes an appeals process.

He followed with 10 goals in his next five Ligue 1 games, took a break for one game, then scored five in his next four.

It was a similar tale in the Champions League. Dembélé was sent off in November when PSG lost at Bayern Munich 1-0. He returned a different player, scoring as PSG came from two goals down to beat Manchester City 4-2, then grabbing a hat trick against Stuttgart, then two more goals at Stade Brest. (AP)

AHMEDABAD, May 31: A rampant Mumbai Indians will present a stern test of character for a rattled Punjab Kings in a virtual semifinal when the two teams face off in Qualifier 2 of the Indian Premier League here on Sunday.

An eight-wicket hammering at the hands of Royal Challengers Bengaluru in a onesided Qualifier 1 may have eroded some amount of confidence in Shreyas Iyer's Punjab Kings, who are now in a do-or-die situation as they dream of winning a maiden IPL trophy

On the other hand, Mumbai Indians took another stride towards a potential sixth title with a comprehensive victory, which knocked out title favourites Gujarat Titans in the Eliminator.

History tells Mumbai Indians know their way around these lanes of IPL knockouts better than either of the other two teams left in the competition and that certainly tilt the scales in favour of Hardik Pandya's side.

But coach Mahela Jayawardene's challenge would be to keep his troops organised which the former Sri Lankan captain has been able to do exceedingly well after taking over a side that finished at the bottom in the previous season.

For the Iver-Ricky Ponting pair, the task would be to ensure their players put behind the crushing defeat in their last game and channel their energies to fight the fires that have erupted particularly in the bowling line-up, where Arshdeep Singh is carrying extra pressure.

The absence of Marco Jansen and unavailability of IPL's highest-ever wickettaker in Yuzvendra Chahal was evident when PBKS scrambled to find options to apply pressure on a spicy wicket in Mullanpur against RCB.

Winning culture built over the years does help in big games: Mahela

MULLANPUR, May 31: The winning culture that Mumbai Indians have built over the years with their core group of players does help them perform in high-pressure situations, said head coach Mahela Jayawardene after their tight win over Gujarat Titans in the IPL Eliminator here.

Having won five titles, the storied franchise is one step away from reaching another IPL final.

With Sai Sudharsan looking unstoppable in the middle, Titans were on course to chase down 229 in the knock-out game on Friday but individual brilliance from the likes of Jasprit Bumrah enabled Mumbai Indians to get over the line.

Like they usually do, Mumbai Indians were slow starters this season before lifting their game in the second half of the tournament.

Jaywardene gave his thoughts on what makes them tick on the big stage.

"Well, when you have a winning culture, it is easier to try and have that same thing going through. Even when you get a new group, we still have a very experienced co-group within our ranks.

"So, the conversations that we have, planning and everything is about, how can we get better, how can we push through," he said referring to the core including Rohit Sharma, Suryakumar Yaday, Hardik Pandya and Bumrah, who have been part of the team's triumphant campaigns over the years.

The seniors know all about winning and they try to inculcate the same spirit in the youngsters who join the squad. "That winning mentality itself comes through from those senior players and having that experience, guys who have won trophies does help and my job is to try and cultivate that for the new guys who are coming into the spot.

"After the big auction, we had quite a few new faces, but I think telling them about the history of Mumbai and how we go, how we operate and have that attitude that we will never die from a situation, we will always fight through. So, I think that is shown today," said the Sri Lankan great. While Bumrah got them back in the

match by castling Washington Sundar with a yorker, Rohit rode his luck early to make 81 off 50 balls after being dropped twice in the powerplay.

On the lead pacer, who returned from a long injury lay-off in the middle of the season, Mahela said: Tthere are definitely no concerns when he comes back because the reputation itself carries through and he was quite confident. "He had bowled few sessions, he was nailing those yorkers and all that. He is a massive asset for us, the experience that he carries through to the team and the situation that he has been bowling for us as well.

"It is great to have him around the group, the experience that he brings, talking to Ashwini (left-arm pacer) in that last over (of the match).

Mahela said Rohit's hand at the top of the order was equally important.

"Rohit was brilliant. He let Johnny take control initially and then when he knew it was his time and the bowler then he picked and he got into a brilliant tempo.

"The pressure that he put on the two spinners, especially Sai and Rashid in that situation was absolutely brilliant and that is what Rohit does. Big games he does have a different gear that he plays. That is what experience does and he cannot replace that."

He also said rookie pacer Ashwani

Kumar is a fine talent and needs to be groomed properly by the franchise.

The heavy dew in the second half of the game aided Sudharsan and Washington who were collecting boundaries at will in the run chase. Mahela said they forced to change their plans considering the unexpected dew. "I didn't anticipate dew because I was here practising and knew yesterday's game as well (Qualifier 1), there wasn't much dew.

"I looked at the wicket, we had a chat, we felt that against this opposition that batting first is the right call. So, we played tactically, brilliantly, the way we batted, the tempo was great and we put runs on the board and took that early wicket of Shubman as well, which was a massive one.

"But halfway stage, I saw the dew coming in...So, we had to make a call, there was a, like planning wise, we were thinking, long boundaries, the way we gripped, the leg spinner might be an option for us, but we then took that out and then bowl Ashwini.



How Bobat, Flower, Karthik changed RCB's auction dynamics to lead team to IPL final

BENGALURU, May 31: Insight, per-haps, was not the watchword in Royal Challengers Bengaluru's auction process, for long. In the past, they assembled a slew of stars and then tried to build the team around them.

It was so glaring in the mid 2010s 'Galactico' era of Virat Kohli, Chris Gayle and AB de Villiers when RCB was a three-man team.

But the appointment of Mo Bobat and Andy Flower and Dinesh Karthik into the coaching staff changed the template, and it reflected in RCB's approach in the auction room in 2024.

In Rishabh Pant, KL Rahul and Shreyas Iyer some of the biggest names in contemporary Indian cricket were available to buy, and going by the past precedent, RCB would have broken their vault to acquire at least two of them.

Instead, they focussed on value buys such as Josh Hazlewood, Bhuvneshwar Kumar, Krunal Pandya, Phil Salt, Suyash Sharma, Romario Shepherd and Tim David.

Each of them have played important roles in RCB's wins this season to prove their worth — home and away.

It was clear that RCB wanted certain players to suit certain roles within the team, rather than purchasing players merely on their reputation.

"I think we got predominantly what we wanted in terms of playing personnel. But more importantly, with the actual shape



of the team and the vision of that team that Andv and I spent so much time thinking about and talking about, we pretty much nailed that. And you get to see that come to life on the field," said Bobat, the RCB's director, in a release.

The acquisition of Salt offers the most palpable validation of those words.

The RCB was ready to let go Will Jacks, who had blitzed a 41-ball hundred against Gujarat Titans last year, for Salt, whom the coaching staff thought can produce big overs consistently upfront.

He plays the high-risk game, and has taken apart the biggest names in opposition ranks like Mitchell Starc (Delhi Capitals) and Pat Cummins (Sunrisers Hyderabad) to destroy their morale.

However, Salt has also produced those little cameos that made a big difference in the eventual outcome of the match. The Royal Challengers needed a quick start while chasing an imposing 228 against Lucknow Super Giants, and a win was imperative for them to ensure a toptwo finish

The English opener made 30 off 19 balls, helping Kohli milk 61 runs in just 5.4 overs and RCB did not let that early momentum slip away.

Karthik, the mentor who had a critical role in finalising the RCB auction pattern, explained the rationale behind selecting players like Salt.

"I thought we did beautifully in picking a very balanced squad, knowing what sort of players we want and which player would fit in which role. As we were picking the team, we used to put players in certain roles and see how they fit. (PTI)
