## Assam to use 1950 law to deport illegal immigrants

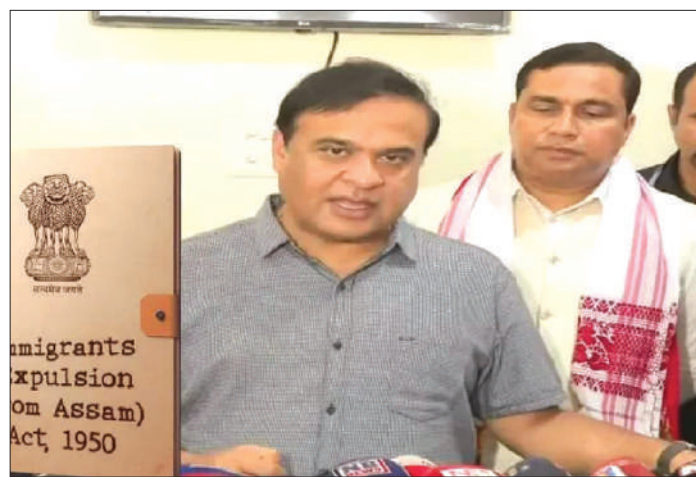
*Fresh move marks departure from long-standing process involving foreigners' tribunals*

GUWAHATI, June 7: In a move that may spark legal and political uproar, Chief Minister Himanta Biswa Sarma on Saturday said that the Assam government does not need to approach court every time to deport illegal foreigners, as it can use an old law passed in 1950.

The chief minister said that the Assam government has decided to invoke a little-known law from 1950—the Immigrants (Expulsion from Assam) Order—to fast-track the deportation of undocumented immigrants, bypassing the usual judicial process.

"The identification and removal of 'foreigners' would now proceed at a faster pace after slowing down due to complications surrounding the National Register of Citizens (NRC). This time, if someone is identified as a foreigner, we will not have to approach the foreigners' tribunal to initiate a push-back," Sarma said while talking to



reporters in Nalbari.

Referring to a previous Supreme Court hearing on Section 6A of the Citizenship Act, he added that the court had clarified the Assam government is not obligated to seek judicial approval for every deportation.

He also pointed to the Immigrants Expulsion Order, enacted in 1950, which he claimed grants district commissioners (DCs) the authority to issue deportation orders without judicial intervention.

"Our lawyers had not informed us about this provision earlier. We

recently became aware of it, and we are now taking it seriously," he said. The chief minister confirmed that deportations have already begun under the renewed approach, though individuals with pending cases in court have not yet been affected.

The move marks a departure from the long-standing process involving foreigners' tribunals—quasi-judicial bodies responsible for determining the status of suspected undocumented immigrants. Until now, individuals declared as "foreigners" by the tribunals had the right to challenge the verdict in the High Court and the Supreme Court.

However, the policy shift has triggered concern among minority communities and political groups. The All India United Democratic Front (AIUDF), a minority-based opposition party, recently petitioned Assam Governor Lakshman Prasad Acharya, alleging widespread (CONTD. ON PAGE-2)

## Indore couple was accompanied by three men on day they went missing, claims guide



SHILLONG, June 7: A tourist guide on Saturday claimed that the honeymoon couple from Indore, Raja Raghuvarshi and his wife Sonam, was accompanied by three men on the day they went missing from Meghalaya's Sohra area.

An official confirmed that the guide had provided this information to the police.

While the couple went missing on May 23, Raja's body was found in a gorge on June 2 while a search for his wife was underway.

Speaking to PTI, Albert Pde, a guide at Mawlakhiat, said he had seen the couple accompanied by three male tourists as they were climbing over 3,000 steps from Nongriat to Mawlakhiat around 10 am on May 23. He said he recognised the couple as he had offered his services to them on the previous day to climb down to Nongriat but they had politely refused and hired another guide. "The four men were walking ahead while the woman was behind. The four men were conversing in Hindi but I could not understand what they were speaking as I know only Khasi (CONTD. ON PAGE-2)

## Assam flood situation improves marginally, rivers showing receding trend

GUWAHATI, June 7: The flood situation in Assam improved marginally as major rivers, including the Brahmaputra, were showing a receding trend though a population of over four lakh people were still affected by the deluge in 18 districts of the state, officials said on Saturday.

Rainfall has been less in most districts and scattered in some, leading to a recession in the water level of the major rivers. The Brahmaputra is flowing above the danger level in Dhubri, Kopili in Dharamtul, River Barak at Katakhal in Halakandi and Kushiara in Sribhumi.

There was no report of any casualty during the day though a person was reported missing in Kamrup (Metro) district. A landslide took place in the



Rupnagar area of Guwahati early on Saturday and a person has been reported missing. The current first wave of floods along with landslides due to heavy rainfall has so far claimed 21 lives.

The floods have affected 1,296 villages

under 54 revenue circles of 18 districts and 16,558.59 hectares of cropland are still under water while 2,96,765 animals are facing the impact of the current wave.

More than 40,313 displaced people are taking shelter in 328 relief camps, while 1,19,001 affected people were provided relief at distribution centres set up in the affected districts.

Chief Minister Himanta Biswa Sarma on Friday visited the Barak Valley for the second time in a week and assured timely rehabilitation grants to the people and that damaged infrastructure, like roads, will be repaired before Durga Puja festivities.

## 2 more persons arrested in crackdown on 'anti-nationals' in Assam

GUWAHATI, June 7: Two more persons have been arrested in Assam in an ongoing crackdown on "anti-national and communal elements", Chief Minister Himanta Biswa Sarma said on Saturday.

With these, the number of arrests in such cases in the wake of the Pahalgam terror attack has reached 90. "Update on crackdown against Anti-national and communal elements - 7 Jun - 90 arrests till now," Sarma said in a post on X.

One person has been apprehended by Goalpara police for making "offensive social media post on Lord Ram", and another by Kamrup police for "inciting communal discord" through social media.

The state police have been taking action against people for "anti-India" and "pro-Pakistan" activities, including posts on social media, since the April 22 Pahalgam terror attack, in which 26 people were killed.

Among those arrested on the anti-national charge was opposition AIUDF MLA Aminul Islam.

He was initially arrested on sedition charges for allegedly "defending" Pakistan and its complicity in the Pahalgam attack.

After he secured bail in that case, he was held under the stringent National Security Act.

Sarma had earlier said that the state-wide crackdown on traitors would continue. (PTI)

## Namrata Bora accident case Conrad assures 'fair' probe to Himanta

GUWAHATI, June 7: Chief Minister Himanta Biswa Sarma on Saturday requested his Meghalaya counterpart Conrad Sangma to conduct a "fair and impartial inquiry" by a senior police officer into the death of a 25-year-old woman in a road accident in the hill state earlier this week.

He said that the bereaved family of the Golaghat native has raised concerns regarding the accident and urged Sangma to ensure that all facts surrounding it are brought to light.

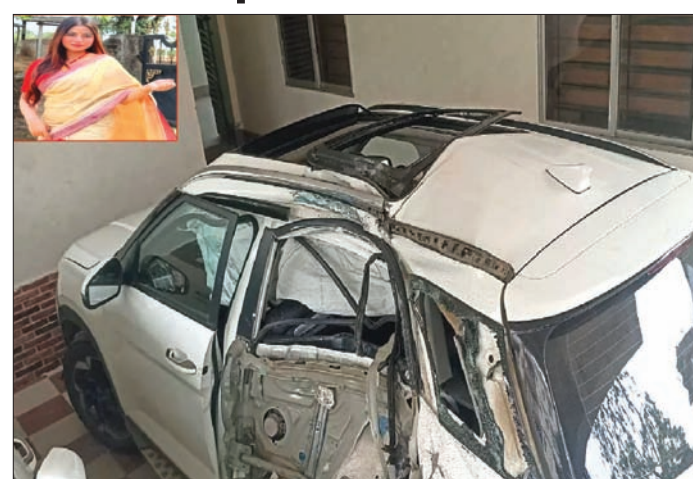
The victim, Namrata Bora, who worked in Guwahati, had purportedly gone on a drive towards Shillong with her friends in the early hours on Wednesday, but they decided to return midway.

Their car met with an accident in Shangbanga area of Ri Bhoi district when it was hit by another vehicle while trying to overtake a stationary truck.

Namrata succumbed to her injuries at Nongpoh Civil Hospital, where she was taken, while the other four passengers escaped with minor injuries.

"I request Hon'ble Chief Minister of Meghalaya, Shri @Sangma-Conrad, to kindly look into a tragic incident that occurred near Nongpoh police station in the early hours of Wednesday, June 4," Sarma said in a post on X.

"A vehicle bearing Assam registration number AS 01 EV 9578 met



with an accident, resulting in the unfortunate death of a young woman, Namrata Bora, while four other co-passengers sustained only minor injuries," he said, adding that a case has been registered at Nongpoh police station.

"However, in view of the concerns raised by the bereaved family and well-wishers, I request that a fair and impartial enquiry be conducted by a senior police officer to ensure that all facts surrounding the incident are brought to light," the chief minister added.

Meghalaya chief minister Conrad Sangma on Saturday said instructions have been given for a fair and impartial inquiry into the incident.

Replying to Himanta's post on

X, the Meghalaya CM also said on X, "@himantabiswa I have given instructions to ensure the same."

Speaking to reporters on the sidelines of a programme in Nalbari later, Sarma said that he had also spoken to Sangma in the morning with request for handing over the inquiry to a senior officer and his Meghalaya counterpart has responded positively.

He said Assam Police have also started their own "preliminary inquiry" and will hand over the findings to Meghalaya Police, if they uncover anything.

"If there is anything behind the accident, we will get to its roots. Since it happened in Nongpoh, Assam Police cannot conduct the probe. (CONTD. ON PAGE-2)

NEW DELHI, June 7: The BJP on Saturday accused Congress leader Rahul Gandhi of attacking democratic institutions to undermine people's trust in the electoral process, claiming he was doing so to pre-empt his party's defeat in the upcoming elections as he cannot garner public support.

This came after Gandhi launched a fresh attack on the ruling BJP, alleging that the 2024 Maharashtra Assembly election was a "blueprint for rigging democracy". He also claimed the "match-fixing" of Maharashtra will come to Bihar next, and anywhere the BJP is losing.

Hitting back, BJP national spokesperson Pradeep Bhandari accused the Congress leader of resorting to attacking democratic institutions under a well-planned conspiracy, as he knows that his party is set to suffer defeat in the upcoming Bihar Assembly polls.

Gandhi is trying to undermine the trust of people in the electoral process because he is unable to gain public support in favour of his party, Bhandari charged, calling the Congress leader "anti-democracy".

"Rahul Gandhi knows he's losing Bihar and, like always, he's resorted to a well-planned conspiracy: attacking democratic institutions to pre-empt his defeat," the BJP spokesperson wrote on X, reacting to the Congress leader's charge. "Unable to win the trust of the people, he is now trying to undermine the trust of the people in the electoral process itself," he alleged, adding, "Rahul Gandhi is anti-democracy."

Slamming Gandhi over his accusations, BJP IT department head Amit Malviya accused the Congress leader of deliberately making repeated attempts to sow seeds of doubt and dissension in the minds of the voters about the poll process.

"It is not that Rahul Gandhi doesn't understand how the electoral process works. He does very well. But his goal is not clarity; it is chaos. His repeated attempts to sow seeds of doubt and dissension in the minds of voters about our institutional processes are deliberate," Malviya wrote on X.



The BJP leader pointed out that when Congress wins an election, be it in Telangana or Karnataka, the same system is hailed as "fair and just".

"But when they lose -- from Haryana to Maharashtra -- the whining and conspiracy theories begin, without fail," he said, adding, "This is straight out of George Soros' playbook -- systematically erode people's faith in their own institutions, so they can be cracked open from within for political gains".

"India's democracy is strong. Its institutions are resilient. And the Indian voter is wise. No amount of manipulation will change that," Malviya asserted.

Gandhi on Saturday alleged that the Maharashtra assembly elections in 2024 were a "blueprint for rigging democracy".

Posting on X, his article titled 'Match-fixing in Maharashtra', published in the Indian Express, the Congress leader accused the ruling BJP of stealing the assembly elections held in the state last year.

"How to steal an election? Maharashtra assembly elections in 2024 were a blueprint for rigging democracy. My article shows how this happened, step by step," Gandhi wrote on X. "It's not hard to see why the BJP was so desperate in Maharashtra. But rigging is like match-fixing - (CONTD. ON PAGE-2)

## 4 held for duping people by promising them jobs in Tata's semiconductor unit: Police

MORIGAON, June 7: Four persons, including a college lecturer, were arrested in Assam's Morigaon district on Saturday for allegedly duping people by promising them jobs in the Tata group's upcoming semiconductor unit in lieu of money, police said.

The semiconductor unit is being set up at Jagiroad in Morigaon district. The accused had collected lakhs of rupees from aspirants with the promise of providing jobs in the unit, a police officer said.

"The scam involved creating fake WhatsApp groups and promising lucrative jobs to unemployed

youths in Nagaon and Morigaon districts," the police officer said.

Led by alleged mastermind Tarikul Ahmed, who posed as an engineer at the semiconductor unit, they offered fake job opportunities to hundreds of youths, the officer said.

"They collected lakhs of rupees from the victims, promising them jobs in the project. The scammers even created fake appointment letters, interview letters and other documents to deceive the victims," the police officer said. ## The delegation will visit the Assam State Zoo and Botanical Gardens Delegation from Bhutan's Gelephu arrive on 6-day visit to Assam, M'laya

GUWAHATI, June 7: A nine-member delegation from Bhutan's Gelephu Mindfulness City (GMC) arrived on Saturday at the Lokapriya Gopinath Bordoloi International Airport here on a six-day visit to Assam and Meghalaya, an official said.

The delegation was scheduled to visit Indian Institute of Technology Guwahati (IITG) and the Hayagriva Mahavira Mandir at Hajo in Kamrup district on Saturday.

The delegation will visit the Assam State Zoo and Botanical Gardens, the Umananda or the Peacock Island, the Guwahati Tea Auction centre and the Royal Bhutan Consul General's Office here on Sunday.

The nine-member team will leave for Meghalaya on Monday. On June 10, the delegation will call on Chief Minister Himanta Biswa Sarma and also meet the state's chief secretary, director general of Police and chief commissioner of the Central GST, Central Excise and Customs, North East Region.

On June 11, the team will visit Kamakhya Temple, Pandu Port and the Royal Global University and will

leave for Bhutan the next day.

Gelephu Mindfulness City (GMC) is a Special Administrative Region in Bhutan, bordering Assam. It is an innovative urban development project that integrates economic growth with mindfulness, holistic living, and sustainability. The chief minister had visited Bhutan in December last year to primarily understand the Gelephu Mindful City which is being developed by the Bhutan government as a buoyant city.

The city, once developed, near Assam's geography will change the entire economy of the region and the Bhutan King is keen that Assam also takes advantage of the city by inviting investments from billionaires who will visit Gelephu, Sarma had said earlier.

The billionaires can come and reside in the luxurious hotels in Gelephu and invest in various projects in Kokrajhar, Chirang and Bongaigaon.

Sarma said that the state government's job is not to create a twin city on the Assam side but to complement the Bhutan city. (PTI)





## Infosys gets huge relief on GST as DGGI closes ₹ 32,400 cr pre-show cause notice

**NEW DELHI, June 7:** In a major relief for Infosys, the Director General of GST Intelligence has closed pre-show cause notice proceedings against the company for financial years 2018-19 to 2021-22 involving a staggering ₹ 32,403 crore in GST dues.

The latest move effectively ends nearly a year-long GST saga for Infosys's second-largest IT services firm.

Mid-last year, the goods and services tax (GST) authorities had slapped ₹ 32,403 crore notice on Infosys for services availed by the company from its overseas branches for five years starting 2017.

The GST demand, in fact, exceeds Infosys's annual profits (net profit for full FY25 stood at ₹ 26,713 crore), and its closure now is bound to come as a significant relief for the tech major.

The Bengaluru-headquartered company, in a BSE filing, said with the receipt of the latest communication from DGGI "this matter stands closed".

"In continuation to our earlier communications on July 31, 2024, August 1, 2024 and August 3, 2024 on GST, this is to inform that the company has today received a communication from the Director General of GST Intelligence (DGGI) closing the pre-show cause notice proceedings for the financial years 2018-19 to 2021-22," the company said in the filing late Friday evening.

Infosys -- which competes with



the likes of TCS, Wipro and others for global IT contracts -- said it had received and responded to a pre-show cause notice issued by DGGI for the period July 2017 to March 2022 on the issue of non-payment of IGST under Reverse Charge Mechanism.

"The GST amount as per the pre-show cause notice for this period was ₹ 32,403 crore. The company had on August 3, 2024 received a communication from DGGI closing the pre-show cause notice proceedings for the financial year 2017-2018. With the receipt of today's communication from DGGI, this matter stands closed," Infosys said.

In July last year, Infosys had informed that Karnataka State GST authorities issued a pre-show cause notice for payment of GST of ₹ 32,403 crores for the period July 2017 to March 2022 towards the expenses incurred by overseas

branch offices of Infosys Ltd, and added that the company has responded to the pre-show cause notice.

"The company has also received a pre-show cause notice from Director General of GST Intelligence on the same matter and the company is in the process of responding to the same," the filing of July 2024 had said.

All along, Infosys maintained that GST is not applicable on these expenses. "Additionally, as per a recent circular issued by the Central Board of Indirect Taxes and Customs on the recommendations of the GST Council, services provided by the overseas branches to Indian entity are not subject to GST," Infosys had argued back in July 2024.

The tech firm had asserted GST payments are eligible for credit or refund against export of IT services. "Infosys has paid all its GST

dues and is fully in compliance with the central and state regulations on this matter," the company had contended.

The document sent to Infosys by GST authorities at that point had reportedly said, "In lieu of receipt of supplies from overseas branch offices, the company has paid consideration to the branch offices in the form of overseas branch expense. Hence, M/s Infosys Ltd, Bengaluru is liable to pay IGST under reverse charge mechanism on supplies received from branches located outside India to the tune of ₹ 32,403.46 crores for the period 2017-18 (July 2017 onwards) to 2021-22."

The Directorate General of GST Intelligence in Bengaluru had been of the opinion that Infosys did not pay the Integrated-GST (IGST) on the import of services as a recipient of services.

For the just-ended March quarter, Infosys reported an 11.7 per cent decline in consolidated net profit to ₹ 7,033 crore mainly on account of compensation to employees, and acquisitions during the reported period.

The company has guided for a revenue growth of 0-3 per cent in constant currency terms in the current fiscal year, citing uncertainty in the environment. For the full FY25, profits saw a marginal increase of 1.8 per cent to ₹ 26,713 crore; revenues climbed 6.06 per cent to reach ₹ 1,62,990 crore -- exceeding its guidance of 4.5-5 per cent for the full FY25. ## AMNS India supplied 25,000 MT steel for Chenab Bridge project: Co statement

**NEW DELHI, June 7:** AMNS India has said it supplied 70 per cent steel for Chenab Bridge and 100 per cent steel for Anji Khad Bridge projects, which were inaugurated by Prime Minister Narendra Modi on Friday.

AMNS India supplied 25,000 metric tonnes of high-strength structural steel, accounting for 70 per cent of the total steel used in the Chenab Bridge, the company said in a statement.

This included specialised steel grades for different components, high-strength steel for the arch and tailored grades for the pillars, it said.

For the Anji Khad Bridge, AMNS India said it has supplied about 7,000 metric tonnes of customised fabricated steel structures, meeting 100 per cent of the

bridge's steel requirement. The steel for both projects was produced at its Hazira facility in Gujarat.

Ranjan Dhar, Director and Vice President, Sales & Marketing, ArcelorMittal Nippon Steel India (AMNS India), said, "The Chenab and Anji Khad Bridge is not just an engineering marvel but a symbol of India's advancing self-reliance and industrial strength. ## Extreme poverty in India down to 5.3 pc in 2022-23: World Bank

**NEW DELHI, June 7:** India's extreme poverty rate declined sharply to 5.3 per cent over a decade from 27.1 per cent in 2011-12 even as the World Bank revised upwards its threshold poverty line to USD 3 per day.

Given India's inflation rate between 2017 and 2021, a revised extreme poverty line of USD 3 would constitute a 15 per cent higher threshold than USD 2.15 expressed in 2021 prices and result in a 5.3 per cent poverty rate in 2022-23, the World Bank said in a report. As against 34 crore people below poverty line (USD 3 per day) in 2011-12, the numbers have come down to 7.5 crore in 2022-23 in absolute numbers.

The World Bank has announced a major revision to global poverty estimates, raising the International Poverty Line (IPL) from USD 2.15/day (2017 PPP) to USD 3/day (2021 PPP), according to a factsheet issued by the Press Information Bureau (PIB) on the report.

"While the change led to a global increase in the count of extreme poverty by 125 million, India emerged as a statistical outlier in a positive direction. Using more refined data and updated survey methods, India not only withstood the raised threshold but also demonstrated a massive reduction in poverty," PIB said in its factsheet details issued on Saturday.

The new poverty line would have increased the count of global extreme poverty by 226 million people. But thanks to India's data revision, the net global increase was only 125 million, as India's revised data reduced the count by 125 million on its own, it said.

In India, the World Bank report said, 54,695,832

people lived on less than USD 3 per day in 2024. Thus, the poverty rate at USD 3 per day (2021 PPP -- percentage population) is 5.44 per cent in 2024.

The extreme poverty rate decreased from 16.2 to 2.3 per cent between 2011-12 and 2022-23, while the poverty rate at the lower middle income country (LMIC) line declined by 33.7 percentage points, it said.

Free and subsidised food transfers supported poverty reduction, and the rural-urban poverty gap narrowed. The five most populous states account for 54 per cent of the extremely poor, it said.

With regard to economy, the report said, real GDP of India was around 5 per cent below the pre-pandemic trend level as of FY25.

Growth should gradually converge back to potential over 2027-28 assuming the current global uncertainties are resolved in an orderly fashion, it said.

"The outlook, however, is subject to significant downside risks, as policy shifts may continue to unfold globally. Elevated trade tensions would dampen demand for India's exports and further delay the recovery in investment," it said.

The current account deficit is expected to average around 1.2 per cent of GDP over FY26-28 and remain adequately financed by capital inflows, it said, adding that foreign exchange reserves are projected to remain stable around 16 per cent of GDP.

India has lifted 171 million people from extreme poverty in the decade between 2011-12 and 2022-23, the World Bank said. (PTI)

"By the time I reached Mawlakhiat, their scooter was not there," the guide claimed. He has also given his statement to the police. The newlywed's rented scooter was found at Soharim, several kilometres from the parking lot at Mawlakhiat with the keys latched to it.

Meanwhile, even as Sonam is yet to be traced, his brother Govind, who is camping in Shillong, accused the state government of not doing enough and searching for her "like she is dead". "We strongly believe Sonam is alive. They are searching for her like she is dead," Govind said, urging authorities to take help from the CBI or any other agencies. Chief Minister Conrad K Sangma has assured that the government was leaving "no stone unturned" to find the missing woman.

However, the terrain, extremely heavy rainfall and foggy weather conditions that reduce visibility to only a few feet were affecting the search operation.

"We are trying our best... our boys are doing what they can without rest using gadgets and trained dogs. The search will continue," East Khasi Hills district superintendent of police Vivek Syiem said.

Raja's decomposed body was found in a gorge near Weisawdong falls on June 2.

A gold ring and a neck chain were found missing from his body, further leading to suspicion that he was murdered. A day later, a bloodstained machete was discovered nearby and two days later, a raincoat that was similar to the one used by the couple was found in Mawkma village, half-way between Soharim and the gorge where Raja's body was found.

Another CCTV footage from one of the homestays showed that Sonam was wearing a similar raincoat. At the Mawlakhiat parking lot, there are no CCTVs and no registers to record the vehicles being parked.

"The village itself has very poor infrastructure and inconsistent power supply," an elder at the village said. Asked if the couple and the three other men left Mawlakhiat together, he said he could not remember any specific individual since there are many visitors in a day.

The locals have decided to start recording the vehicle numbers and visitors' phone numbers. A special investigation team headed by an SP and assisted by four DSPs is probing the matter. The search for Sonam is continuing with the participation of NDRF, SDRF, mountaineers, sniffer dogs and drones. (PTI)

## 76 army personnel airlifted from landslide-hit Chaten in north Sikkim



**GANGTOK, June 7:** At least 76 army personnel were on Saturday airlifted from Chaten in north Sikkim where road connectivity has been snapped due to multiple landslides triggered by heavy rain, officials said.

This marks the "completion of

coordinated evacuation efforts", which included the rescue of all stranded tourists earlier, they said.

"Altogether 76 army personnel were airlifted by three MI-17 helicopters. The air evacuation operation from Chaten has concluded today with the helicopters trans-

porting army personnel from Chaten to Pakyong Greenfield Airport," an official said.

The state government continues to closely monitor the overall situation and remains committed to providing all necessary support in the disaster-hit region and assis-

tance to those affected by natural calamities, another official said.

Heavy rain had triggered multiple landslides in north Sikkim recently, disrupting road connectivity in the region. As a result, more than 1,600 tourists had been stranded in Lachen, Lachung and Chungthang towns for days before they were rescued by the state government.

The Indian army, National Disaster Response Force (NDRF), State Disaster Response Force (SDRF), Border Roads Organisation (BRO), and the Mangang district administration had carried out rescue and search operations for days and evacuated all stranded tourists and local people, the officials said.

Several helicopters were pressed into service to evacuate more than 140 tourists by air, they said.

Three army personnel were killed, four injured and six others went missing after a landslide hit a military camp at Chaten on the evening of June 1. Efforts are underway to locate the missing soldiers. (PTI)

## Written examination for BTC grade-III posts to be held on June 15

**KOKRAJHAR, June 7:** The Central Selection Board (CSB), an autonomous body under the Government of Bodoland Territorial Council (BTC), has announced that the written examination for Grade-III posts in various departments of BTC will be conducted on June 15.

The examination has created some confusion among candidates, particularly regarding the eligibility for appearing in multiple departmental exams. Hundreds of candidates who applied for multiple departments expressed concerns, as the official CSB notification did not clearly state whether appearing for more than one department was permitted.

On Saturday, the CSB issued a clarification. In a press conference held at the Bodoland Guest House in Kokrajhar, CSB Chairman Dr. Dipak Kumar Basumatary clarified that candidates who have applied for multiple departments will be allowed to appear for the examination on June 15. However, if they qualify in the written test, their testimonials will be verified, and they will be considered for appointment in only one department.

Basumatary further informed that Bodoland University will conduct the examination for all departments simultaneously on June 15. Admit cards are being issued online according to the options selected by candidates during the application process.

He added that a total of 416 posts are to be filled across various departments, for which 47,068 candidates have applied. The examination will be held in 75 centres across BTC districts.

Meanwhile, Dipen Boro, President of the All Bodo Students' Union (ABSU), raised concerns about discrepancies in the issuance of admit cards. He said he had a telephonic discussion with CSB Chairman Basumatary regarding the matter, and the latter assured that clarifications would be provided through the press conference held on Saturday.

## Noted physician passes away

**NAGAON, June 7:** Renowned physician Dr Biswarup Gohain Baruah, a resident of Panigaon, Polytechnic Road, Bishnu Rabha By-lane in Nagaon town, passed away last night while undergoing treatment at a private hospital in Guwahati. He was a respected figure in the medical fraternity and known for his dedication to patient care.

According to sources, Baruah suddenly fell ill on the morning of June 4 and was initially admitted to a private hospital in Nagaon. Later the same day, he was referred to a private hospital in Guwahati for advanced treatment, where he ultimately breathed his last.

## Grave allegations surface against headmaster of Majiahadi English ME School

**KHERONI, June 7:** Serious allegations have emerged against Gobin Johori, Headmaster of Majiahadi English ME School in West Karbi Anglong district (UDISE Code: 18331007304), accusing him of monopolistic practices and widespread irregularities in the school's operations. The controversy, extensively reported across multiple media outlets on June 6, has sparked public outrage, with residents demanding a thorough investigation and immediate intervention by the Karbi Anglong Autonomous Council (KAAC).

Sukulal Daudunglangtha, the founding and former President of the School Management Committee (SMC), has accused Johori of unilaterally restructuring the SMC without prior consultation or approval. Daudunglangtha claims he did not authorize any resolutions during his tenure, yet Johori allegedly went ahead and appointed all teaching and non-teaching staff on his own. According to the Unified District Information System for Education (UDISE), the school employs seven teaching staff and one non-teaching



staff member for the 2024-25 academic session. The legitimacy of these appointments is now under serious scrutiny.

Further compounding the issue are glaring discrepancies in student enrollment and attendance figures. While Johori claims an enrollment of 15-20 students, both Daudunglangtha and the Sarkari

Gaon Burha (SGB) of Majiahadi village report actual physical attendance ranging from zero to three students. This stark inconsistency has raised concerns over potential mismanagement and misuse of funds intended for the school's functioning.

The school's infrastructure also raises questions. Despite Johori's assertion that the school has three bighas of land, it continues to operate out of a temporary structure. This has led to suspicions of forged or misrepresented land documents possibly being used to obtain UDISE registration and avail KAAC facilities.

Local residents have also alleged financial mismanagement and irregular staff appointments, deepening the community's mistrust in the school's administration. As tensions escalate, the public is calling for a transparent and thorough investigation by relevant authorities, particularly the KAAC, to ensure accountability and restore faith in the school's governance.

Stakeholders now await swift and decisive action to address the growing crisis at Majiahadi English ME School.

## Chinese credibility deficit

China's defence exports have historically faced a credibility deficit, rooted in persistent performance and reliability issues. Repeated cases, such as Thailand and Algeria replacing crucial components in Chinese weapon systems with Western alternatives, underscore systemic shortcomings and enduring doubts. This perception has been reinforced in the previous years by instances such as the operational failure of ground combat platforms in African states as well as technical deficiencies in airborne early warning and control systems and frigate exports to Pakistan.

However, the most notable shock emerged during the Operation Sindoor clashes between India and Pakistan, where Chinese systems reportedly failed across domains. The episode ended up casting doubts on China's capacity to sustain competitive defence exports and questioned the maturity and resilience of its broader military-industrial complex.

## Dependence exposed in combat

Since the early 2000s, China has become Pakistan's principal defence partner, significantly reshaping the region's military balance. By the time of Operation Sindoor, according to Stockholm International Peace Research Institute, 81% of Pakistan's defence inventory came from China. This was more than an arms trade, it reflected deep strategic dependence.

Pakistan's order of battle was dominated by Chinese systems: J-10C and JF-17 fighter aircraft, JY-27A long-range air surveillance radars, and multiple surface-to-air missile systems. The Fatah rockets were modelled on China's A300 rocket system. Chinese SH-15 self-propelled artillery was utilised on the Line of Actual Control. Beijing's drones, such as the CH-4 and Wing Loong series, were crucial assets, backed by an extensive radar grid.

This set-up wasn't just tactical, it also reflected structural shifts. Historically, Pakistan relied on its air force for air defence, with ground-based systems playing a secondary role. China helped build the Comprehensive Layered Integrated Air Defence (CLAD) and expand the Air Defence Ground Environment System (ADGES) into central components of Pakistan's posture. The JY-27A radar at Mianwali operated in the very-high frequency (VHF) band and tracked stealth aircraft up to 500 km. China's YLC series radars, deployed across key installations, formed the core of Pakistan's ADGES network. Pakistan's CLAD was built almost entirely with Chinese hardware: HQ-9Ps and HQ-16s for high- and medium-altitude coverage, HQ-17s, FM-90s, and FN-6s for short-range protection.

During Operation Sindoor, Chinese support even extended into space and signals. Beijing provided satellite reconnaissance, real-time targeting data, and secure ultra sets for satellite-based communications. Some of this intelligence, routed through the Pakistan Army, has reportedly reached even terrorists.

However, when the real tests came, Chinese weapon systems failed across domains. Drones were jammed, radars neutralised, and missile batteries underperformed. The much-touted ADGES and CLAD crumbled in real combat. Pakistan's deep military reliance on China-produced integration, not superiority, and for Islamabad, the cost of dependence became visible as the strategic alignment delivered hardware, not success.

## China's security apprehensions

Although Chinese internet commentators blamed Pakistan's poor training and limited personnel competence for the underperformance of Chinese weapons during Operation Sindoor, the outcome revealed deeper flaws in China's defence manufacturing. The operation exposed serious gaps in the capability and combat reliability of Chinese-made systems.

China's state-dominated military-industrial complex has, since long, produced weapons that outwardly match Western or American systems in appearance and advertised specifications. Yet, most of these systems have never been battle-tested. Without real combat data, their actual performance remains speculative. Moreover, corruption in China's defence sector is a well-known issue, raising doubts about the quality and integrity of production. The risk of compromised and underperforming systems remains high.

Still, this hasn't stopped Beijing from inducting these weapons into its People's Liberation Army (PLA) or exporting them to friendly regimes or those with funds. Most of the surface-to-air missile systems and radars used in the May clashes form a central part of China's own air-defence network. The JY-27A radar is deployed opposite Taiwan and India. Over 500 J-10 fighters are in PLA service. The PL-15 is its standard beyond-visual-range missile.

While Pakistan received export variants, concerns about reliability extend to China's own versions. For instance, Beijing suspects that Moscow supplied a downgraded S-400 system to avoid the risk of reverse engineering, while India received a fully capable version. As a result, China finds itself in a bind—its domestic systems are often untested and prone to flaws, while its imported ones are restricted in capability. Compounding the problem, the West's arms embargo since the 1989 Tiananmen crackdown continues to block China's access to the advanced weaponry.

There are signs of innovation—civil-military fusion has helped Chinese manufacturers integrate advanced civilian technologies into weapons design. Yet, these gains are overshadowed by long-standing credibility apprehensions. As a result, a core question persists: Is the PLA truly prepared to fight and win the wars that the Chinese Communist Party intends to fight in the future?

## Lessons for India

Operation Sindoor has revealed four key takeaways. First, China and Pakistan now form a de facto military partnership, integrating capabilities across space, intelligence, surveillance, and reconnaissance, cyber, electronic warfare, and communications. Though China avoids overt support, it tacitly bolsters Pakistan's hand. Second, Chinese weapons, despite advanced outward appearances, performed poorly in battle. Beijing is now eager to study battlefield data to improve its systems. Third, India's indigenous weapons are maturing, boosting both combat capability and export potential. Lastly, India must intensify local weapons development while selectively pursuing foreign collaboration. ## Elon Musk's vicious attack against Trump's economic policies has stunned maga supporters

NEW YORK: The differences between US President Donald Trump and his first buddy tech billionaire Elon Musk, who sunk \$288 million of his personal fortunes to get the mercurial Trump re-elected, has now exploded in the public domain with a spat. The bitter attack by the Tesla CEO against the U.S. President's economic policies indicates that there are differences in approach between the two friends of fundamental nature.

The words "disgusting abomination" used by Musk endangers the relationship between the President and the tech billionaire, founder of TESLA EVs, xAI, SpaceX, Neural Link (Brain Mapping) and owner of social platform X, are so strong that the unpredictable Trump could sway which way he wanted in the relationship as he is also used to using in-temperate language in his social media platform Truth Social, with millions of followers. Could both gut each other with their verbal spat, in which Trump has remarkably kept his cool and not reacted violently.

An utterly frustrated Musk, who made his fortunes building a company coming to USA on a H1B visa, has a different take on every one of Trumps policies starting from immigrants, tariffs and government spending. He continued with these for the first 130 days of Trump regime. Now after getting out of administration, he is airing his personal views in a no holds manner.

Musk walked into White House as the chief administrator of DOGE – Dept of Govt Efficiency – to slash redundant government jobs and save government expenditure. When ideological differences emerged and his co administrator wanted DOGE outside of the government, the 2024 presidential aspirant and admirer of Trump Vivek Ramaswamy was eased out to campaign for governorship of the Ohio state, where he lives.

Once inside a building next to the White House, Musk never got a room in the West Wing, the most powerful advisory group in the United States in the presidential house, he began his job in earnest. At the end of his 130 days mission, he spent \$135 billion to effect a saving of \$175 billion in government spending, a fraction of the \$2 trillion reduced later to \$1 trillion he promised.

When Trump virtually offered him the last straw to pull out of DOGE, Musk was flabbergasted that the man who had been campaigning all along in 2024 to shut down his predecessor Biden from government spend for inflating budget deficit, did exactly the same of what Biden did bringing the entire situation back to square one.

Fears are being expressed in Washington DC that Trump's Big Beautiful Bill, vastly different from Biden's Build, Back, Better initiative on climate technologies of a \$1.7 trillion, might end up with an expenditure ballooning deficit to \$5 trillion in the next 10 years, leaving a gaping hole in the government's budget.

Trump's attempts to cut taxes for the rich, for those earning over \$4 million a year saving them \$400,000 a year and cutting expenditure on Medicaid, Medicare, Obama care and the redefining of the Affordable Care act leaving out 8.6 million of urban middle class from the health care net, raising the costs of medicare by \$1,000 per urban household, enhancing the prices of drugs needed by the middle classes, seems to mitigate all the gains achieved by DOGE in Cutting on wasteful government expenditure.

In a vituperative outburst on his X media platform, Musk bellowed calling the Big Beautiful bill as a "massive, outrageous, pork-filled Congressional spending bill". He went on to say it was an

abomination bill.

The bill scraped through the Congress at 215-214 by a solitary vote. It's now hanging in balance in the senate where the republicans outnumber democrats by 53 to 47 and vice president, JD Vance, with the presiding officer of the senate, holding the tie breaking vote.

With three republicans opposing it in the senate, Trump could see the BBB through the senate 50 to 47 and if it's a nail biting finish JD Vance can always come to the rescue with his tie breaking vote. But the bill could be gutted from its present form to make it acceptable to the section of republicans opposing the bill.

History seems to repeat itself. Joe Biden's Build Back Better initiative with a budget of \$1.7 trillion was gutted by his own democrats representing the fossil fuels lobby as it sought to promote climate change technologies against fossil fuels. The fossil fuel lobby, which influences several senators and congressmen spent about \$93 billion in FY 2023-24 to lobby against climate change advocacy groups.

Biden's Build Back Better initiative went through the drain down to about \$1 trillion and yet managed to be allocated \$750 billion for climate change technologies that included promoting EVs, subsidies on car sales and the batteries that went into it. But Trump's BBB, very similar in moniker to Biden's BBB, is likely to be gutted in its present form in the sen-

ate with Musk influencing senators. Musk said of the congressmen who voted for the bill: "Shame on those who voted for it: you know you did wrong. You know it."

White House press secretary Karoline Leavitt reacted to a question on Elon Musk calling Donald Trump's tax bill as "a disgusting abomination. The billionaire's aggressive intervention comes at a critical time for Trump's "big, beautiful bill", which narrowly passed the House of Representatives last month and needs to be approved by the Senate if it is to become law.

Trump has imposed a deadline of July 4 to pass the legislation, which could define his second term and set the course for the US economy. He has heaped pressure on Republican senators who are alarmed about the package, which would slash taxes, reduce social spending and increase the federal debt.

Hours before Musk's comments on X, Trump attacked Republican Senator Rand Paul, a staunch fiscal conservative who has taken issue with the bill's provisions to raise the limit on how much the federal government can borrow by \$5tn.

"Rand Paul has very little understanding of the BBB, especially the tremendous GROWTH that is coming," Trump said on his Truth Social media platform on Tuesday morning. "The BBB is a big WINNER!!!"

Other fiscally conservative senators — including Wisconsin's Ron Johnson, Mike

Lee of Utah and Rick Scott of Florida — have called for deeper spending cuts in the bill.

Another group of Republican senators — including Susan Collins of Maine, Alaska's Lisa Murkowski and Josh Hawley of Missouri — have criticized the bill's proposed cuts to Medicaid, a government healthcare scheme for lower-income and disabled Americans. They will now face the flak from their constituents back home.

Trump's party controls the Senate by a 53-47 margin, meaning the Republicans can only afford to lose the support of three senators if the spending bill is to pass the upper chamber. Asked about Musk's comments, White House press secretary Karoline Leavitt said: "Look, the president already knows where Elon Musk stood on this bill. It doesn't change the president's opinion. This is one big, beautiful bill, and he's sticking to it." But Musk's intervention is likely to embolden the president's Republican critics. Paul agreed with Musk on X, saying, "We can and must do better." Lee replied: "The Senate must make this bill better."

Musk's broadside came five days after his high-profile send-off at the Oval Office and his dispute with the White House escalated, which he has criticized over tariff policy and blamed for not fully backing his efforts to cut \$1tn from the US budget. Musk, who outsources many of the spare parts from China for TESLA and also sells TESLA cars by the huge numbers in that country, was one of those badly hit by the Tariffs heaped on China.

Musk saw his quarter line profits plummet to 71%. The stakeholders and board of directors were very much upset and asked Musk to either return to TESLA and do his job as the CEO or resign and find an alternate to run the company. Everything in Musk's venture is dear to his heart from TESLA to Space X to Neural Link on Brain Mapping to his social media platform X which he acquired from Twitter for \$44 billion. He said he would return to his flagship company running all the entities and sleep in his office if necessary to bring back the company to profit making days once again.

The administration on Tuesday sought to mollify disgruntled supporters of Musk's cost-cutting task force, the so-called Department of Government Efficiency, by presenting Congress with a small slither of cuts the initiative identified — including contracts related to diversity programmes and more than \$1bn in funding for NPR and PBS — to be enshrined in law. ## When national unity must rise above partisan politics

India's resolute response to the Pahalgam terror attack, under the mantle of Operation Sindoor, has drawn a clear red line against those who dare to endanger its sovereignty. In a move that has drawn both national and international approval, the Government of India launched a precision military strike to avenge the blood of fallen civilians. But beyond the battleground, a different kind of war is being fought—one that demands unity of purpose rather than division of opinion.

To consolidate global support against terrorism and articulate India's stance with clarity, the government dispatched high-level bipartisan delegations to influential world capitals. These were not mere symbolic gestures but strategic diplomatic missions aimed at underlining a singular national message: India will not tolerate terrorism, nor will it permit its soil to be undermined through violence.

One such delegation is being led by Congress MP Dr. Shashi Tharoor in the United States. Known for his articulate diplomacy and deep understanding of international affairs, Tharoor's presence has added gravitas to the delegation. He has spoken with clarity and conviction, offering a balanced, factual, and principled account of India's position on cross-border terror and its recent military response.

When questioned about fellow Congress leader Rahul Gandhi's controversial statement—alleging that Prime Minister Narendra Modi "surrendered" after receiving a call from then US President Donald Trump—Tharoor swiftly countered the claim. "India didn't need persuading to stop. No one needed to tell us to stop be-



cause we were telling them that the moment Pakistan stops, we are prepared to stop," Tharoor said, reinforcing the fact that India's decision was sovereign and strategic, not the result of foreign pressure.

His remarks, while diplomatically worded, subtly corrected the narrative that sought to undermine the Indian government's decision-making during a crucial security operation. Tharoor further elaborated that if any communication came from the United States, it was likely directed at Pakistan, urging them to halt hostilities since India had already indicated its willingness to cease operations should the other side stop. "That's a wonderful gesture on their part," he noted, signalling gratitude without compromising national pride.

His response also underlined a critical strate-

gic position: "We have no real difficulty speaking the same language as the Pakistanis, as long as they use the language of terrorism. We will use the language of force, and that doesn't require a third party," Tharoor added. It was a categorical assertion that India's counter-terrorism posture is firm, independent, and unambiguous.

Joining Tharoor in this bipartisan diplomatic mission is another Congress leader, Milind Deora, who lauded Tharoor's conduct, saying, "He always puts country before party." Deora's words are significant, especially when viewed in contrast to the controversy sparked by Gandhi's comment, which seemed to prioritise political point-scoring over statesmanlike responsibility.

Another all-party delegation, this one in Jakarta and led by senior Congress leader and former External Affairs Minister Salman Khur-

shid, echoed similar sentiments. Responding to the "surrender" allegation, Khurshid clarified, "The call came from the DGMO of Pakistan. We stopped when they said 'Let's stop,' and we didn't send any further attacks on them." His remarks offer insight into the operational protocol between military officials and reinforce that India was neither coerced nor cajoled into halting its operations.

Khurshid also voiced disappointment at the politicisation of India's security policy. "Is it so difficult to be patriotic?" he asked, lamenting that political opportunism was eroding the very consensus that India's global diplomatic efforts were trying to build. "We are not supporting each other's parties—we are supporting one simple idea called India," he added, poignantly reminding all that patriotism must not become the casualty of politics.

This divergence within the Congress party itself—between those engaged in international diplomacy and those stirring domestic discontent—poses a moral and strategic dilemma. How can a party reconcile its global diplomacy with internal dissent that undermines the very cause it seeks to advance abroad?

More dangerously, Rahul Gandhi's remarks have been gleefully seized upon by Pakistan's propaganda machinery. His "Narender surrender" jibe has found its way into digital campaigns designed to mock India's resilience and amplify false narratives. This is no longer merely a domestic debate; it has international ramifications.

The consequences of such careless political rhetoric extend beyond partisan squabbling. They erode the hard-earned credibility India has built through military professionalism, diplomatic outreach, and democratic stability. The revocation of

Article 370, once a subject of fierce debate, has since ushered in higher voter participation, reduced militancy, and restored political normalcy in Jammu and Kashmir. As Khurshid noted, "There is an elected government in Kashmir today," and to trivialise this progress for short-term political gains is deeply unfortunate.

India has a proud history of bipartisan unity on foreign policy and national security—from the 1971 Bangladesh Liberation War to the 1999 Kargil conflict. These were moments when political leaders, irrespective of their ideological leanings, stood shoulder to shoulder. That tradition must not be abandoned now, particularly when Indian delegations are carrying the country's message abroad.

The essence of India's foreign policy rests on its strategic autonomy and unwavering resolve against terrorism. That must not be muddled by off-the-cuff political remarks. When Indian civilians and soldiers are targeted, and India responds, there should be no space for domestic divisions. Politics can wait; national unity cannot.

As the world watches, India's strength lies in its resolve—and in its unity. Leaders like Dr. Shashi Tharoor and Salman Khurshid exemplify this statesmanlike approach. Their words abroad carry the dignity of a nation that refuses to be bullied and refuses to compromise on truth. Their voices must not be drowned by the din of domestic discord.

In moments like these, the nation looks to its leaders not merely for answers, but for assurance—that they speak with one voice when it matters most.

Now she lives in Morigaon. ## ‘Bhaimon Da’ - A journey through cinema

The recently released Assamese film ‘Bhaimon Da’ stands as a heartfelt tribute to the legendary filmmaker Munin Barua, a pivotal figure in the golden era of Assamese cinema. Known affectionately and respectfully as ‘Bhaimon Da’ within the industry, Munin Barua's life and work are beautifully portrayed in this film, which captures not only his personal journey but also the broader struggles and triumphs of Assamese cinema during a challenging period. Well-known actor Nilim Dutta vividly portrays the character of Biju Phukan, while Samudragupta Dutta's performance as Shiva Prasad Thakur is touching. Partha Hazarika

beautifully portrays the complex character of Zubeen Garg. The roles of Jatin Bora and Ravi Sharma are portrayed with ease by promising actors Kaushik Bhattacharya and Joy Saikia, respectively. Capturing the physical expressions, gestures, dialogue delivery, and tone of characters beloved by Assamese audiences is no easy task, yet these new actors have largely succeeded. With its emotional depth, artistic quality, and cultural significance, ‘Bhaimon Da’ stands as a shining example of Assamese cinema's enduring legacy. The efforts of the producer, director, cast, and crew deserve heartfelt appreciation and congratulations for bringing this important story to the screen.

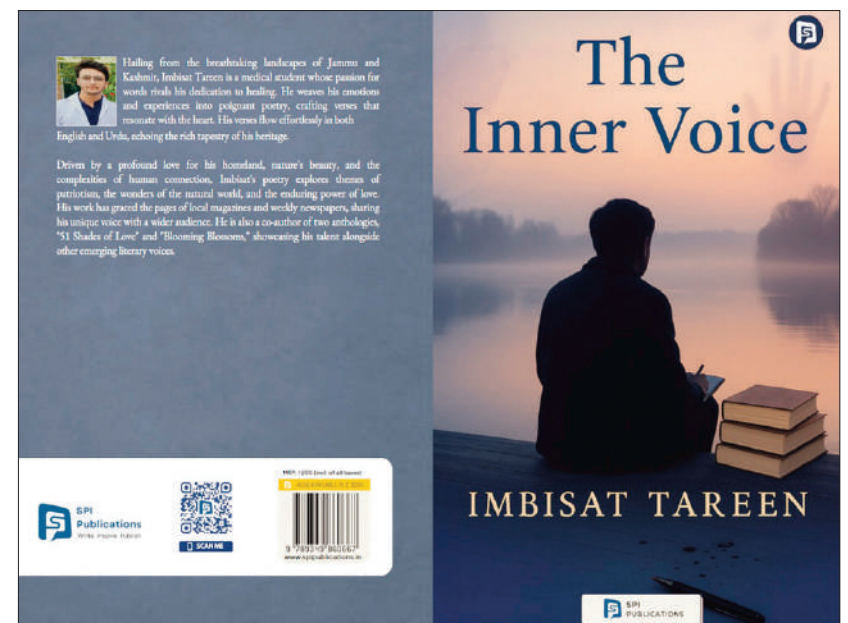

Flood situation in Arunachal improves

ITANAGAR, June 7: The flood situation in Arunachal Pradesh improved on Saturday with water levels of most rivers receding, even as 33,000 people in 24 districts remained affected, officials said.

Twelve people lost their lives and one person went missing in rain-related incidents, including landslides, after the monsoon set in, they said.

In its daily report, the State Emergency Operation Centre (SEOC) said 33,200 people in 215 villages remained affected due to floods and landslides in the state.

The water levels of most major rivers and their tributaries were showing a receding trend over the last 24 hours, it said.

Altogether, 515 houses were damaged across the state, and 432 livestock deaths were reported, it added.

As many as 112 roads and 17 bridges were damaged in the state. The floods also affected 51 water supply projects, 17

power transmission lines and eight hydro projects, the SEOC said.

Changlang is the worst-affected district, with six villages inundated and 2,231 people rendered homeless.

Flash floods washed away the Makantong bridge on the Trans Arunachal Highway, disrupting connectivity between Miao and Bordumsa. The authorities have decided to start ferry services for the locals there.

The Noa-Dehing river has damaged farmland in the Dharmapur block in the Namphei circle.

The water supply projects in Changlang town, Namtok extra assistant commissioner headquarters, Yatdam circle, Phinbiro-I and II villages and Rang Hill village were damaged by landslides, leading to a drinking water crisis.

Additionally, floods and landslides damaged around 17 hectares of farmland and 20 hectares of horticulture plantations

in the district.

Three hanging bridges at Phaparbari, Two Hut and Lama Camp were also damaged by flood in district. A Bailey bridge at 60 Mile between Miao and Vijaynagar was also damaged.

In the Upper Siang district, the Sirnyuk hydropower project in Jengging was damaged due to severe rainfall.

In the Itanagar Capital Region, landslides damaged pipelines of the Poma water supply project, causing a drinking water crisis. The restoration process would take about several days, officials said, adding that water tankers were being arranged.

Three relief camps have been set up in the state, and 239 people are taking shelter there, they said.

Relief and rescue efforts were underway with support from the NDRF, State Disaster Response Force (SDRF), police and local volunteers. (PTI)



Rijiju's intervention sought over Arunachal weightlifter's exclusion from Commonwealth team



ITANAGAR, June 7: A social welfare and cultural organisation in Arunachal Pradesh has called for the immediate intervention of Union Minister Kiren Rijiju, over the exclusion of the state's weightlifter, Sambo Lapung, from the Indian team for the upcoming Commonwealth weightlifting championship.

Lapung, a three-time national gold medalist from Lapung village in East Kameng district, has been dropped from the final team despite a stellar record in the 96 kg category, the organisation claimed.

The East Kameng Social Welfare and Cultural Organization (EKSOWCO), submitted a representation to the minister on Saturday, describing the Arunachal weightlifter's exclusion from the Indian team as a "serious lapse in fairness and transparency" by the Indian Weightlifting Federation (IWF).

Union Minority Affairs and Parliamentary Affairs Minister, Kiren Rijiju, who represents the Arunachal West parliamentary constituency in the Lok Sabha, has been urged to take steps to address what the organisation perceives as a "gross injustice" to Sambo Lapung.

Lapung clinched gold at the senior National Weightlifting Championships held in Chandigarh (2022), Itanagar (2023), and Himachal Pradesh (2024).

EKSOWCO has questioned the

selection criteria used by the IWF and alleged lack of consistency and meritocracy.

The organisation claimed that Lapung's exclusion not only diminishes his outstanding achievements but also delivers a blow to regional sentiments across Arunachal Pradesh and the northeast.

"This decision reflects a disturbing trend of stereotyping and discrimination against athletes from the northeast by mainland institutions," the representation said.

EKSOWCO also claimed that such incidents risk alienating the youth of the region, for whom sports represent a powerful vehicle for national integration and self-realisation.

"Lapung's inclusion would inspire countless young talents and reinforce the message that merit and hard work are duly rewarded," said EKSOWCO Chairperson Raya Flago.

"Ignoring such a decorated athlete from your constituency sends a disheartening message, not just to him but to the entire region," he added, urging the Union minister to take up the matter personally with the IWF.

The organisation has also demanded that the IWF adopt a transparent, performance-based selection policy, placing greater weight on national championships rather than selectively favouring other events. (PTI)

Chief Secretary and team inspect DBT, interact with officers

The release further stated, "It provided an inclusive overview of the Centre's core research domains, outreach programmes, research achievements, and its role in fostering a bioresource-based economy in Arunachal Pradesh."

The dignitaries toured laboratories, R&D



facilities, and the orchidarium, interacting with scientists and officers to gain firsthand insight into ongoing research in orchids, microbial resources, bioinformatics, medicinal and aromatic plants, foam-forming biomaterials, millets, rice, translational research, and value-added agri-waste innovations.

Special emphasis was placed on the strategic initiative to develop Arunachal Pradesh as the "Orchid Capital of India." With over

650 recorded orchid species, the state is a biodiversity treasure trove. The dignitaries expressed strong interest in expanding orchid-focused research and commercialization activities.

Discussions highlighted the need to establish dedicated business research and development verticals for orchids — including mass propagation, high-value floriculture, development of orchid-based herbal formu-

lations, nutraceuticals, and eco-tourism-linked value chains. The CoE's efforts to integrate biotechnology, entrepreneurship, and local community participation were appreciated as a transformative step toward positioning Arunachal Pradesh on the global orchid map.

# India will never countenance 'perpetrators of evil' being put on par with victims: Jaishankar

*'For the first time, Rafale fuselages will be produced outside France'*

**NEW DELHI, June 7:** India expects partners to understand its policy of "zero tolerance" against terrorism, and it will never countenance "perpetrators of evil" being put on par with its victims. External Affairs Minister S Jaishankar said on Saturday during extensive talks with his British counterpart David Lammy.

Jaishankar's remarks, which seemed to be an attempt to send an unambiguous message to the global community, came against the backdrop of unease in New Delhi over several countries hyphenating India and Pakistan following their four-day clashes last month.

Lammy arrived in New Delhi this morning on a two-day visit to review various aspects of the strategic partnership between the two countries.

A British readout said bolstering economic and migration ties and delivering further growth opportunities for British businesses are set to be at the top of the UK foreign secretary's visit to India.

Before holding talks with Jaishankar, the British foreign secretary met Prime Minister Narendra Modi.

In his televised opening remarks at the meeting with Lammy, Jaishankar thanked the UK for its strong condemnation of the "barbaric" Pahalagam terror attack and London's solidarity and support to New Delhi's fight against terrorism. "We practice a policy of zero tolerance against terrorism and expect our partners to understand it, and we will never countenance perpetrators of evil being put on par with its victims," he said.



It is understood that the Indian side explained its challenge of dealing with cross-border terrorism emanating from Pakistan.

The UK was among the countries which were in touch with both India and Pakistan in an attempt to de-escalate tensions during their military conflict from May 7-10.

Lammy paid a two-day visit to Islamabad from May 16, during which he welcomed the May 10 understanding between India and Pakistan to stop the military actions.

Jaishankar also described the recently finalised India-UK free trade deal and the double contribution convention as "truly a milestone".

"The recent conclusion of the India-UK FTA and the double contribution convention is truly a milestone which will not only propel our two-way trade and investment but will also have a positive effect on other strategic aspects of our bilateral ties," Jaishankar said. The UK readout said, Foreign

Secretary Lammy will also welcome progress in "our migration partnership, including ongoing work on safeguarding citizens and securing borders in both countries."

It said addressing migration remains a top priority for the government, and Lammy is focused on working internationally with global partners to secure the UK's borders at home.

"India was one of my first visits as foreign secretary, and since then has been a key partner in the delivery of our 'Plan for Change'. Our relationship has gone from strength to strength -- securing our future technologies, adding over 25 billion pounds in trade every year between our countries and deepening the strong links between our cultures and people," Lammy said.

He said the signing of the free trade agreement with India is just the start of the ambitions for the two countries.

"We're building a modern partnership with India for a new global era. We want to go even further to

foster an even closer relationship and cooperate when it comes to delivering growth, fostering innovative technology, tackling the climate crisis and delivering our migration priorities, and providing greater security for our people," he was quoted in the readout.

The British foreign secretary is also scheduled to meet leading figures in Indian business to discuss how both sides can unlock greater investment by Indian business in the UK.

In 2023-24, India was the UK's second-largest source of investments in terms of the number of projects for the fifth consecutive year.

In his remarks, Jaishankar listed various initiatives which were rolled out recently to bolster the ties.

"Since your last visit to India, there have been significant initiatives which both of us have taken, and those initiatives have progressed well," he said.

Jaishankar singled out the Technology Security Initiative (TSI) and said it will enable deeper collaboration in strategic technology sectors of AI, semiconductors, telecom, quantum, health-tech, biotech, critical minerals and advanced materials.

"We have also launched the strategic exports and technology cooperation dialogue, the first meeting of which was held, I believe, this week."

"This will enhance, among others, the TSI's effectiveness in promoting trade in critical and emerging technologies, including the resolution of relevant licensing or regulatory issues," he said. (PTI)

# Rahul alleges Bihar polls like Maha to be fixed, Nadda says electoral losses making him desperate

**NEW DELHI, June 7:** Rahul Gandhi claimed on Saturday that the 2024 Maharashtra Assembly elections were a "blueprint for rigging democracy", drawing rebuke from BJP president J P Nadda, who accused the Congress leader of "cooking up bizarre conspiracies" in his desperation after losing a series of elections.

The Leader of the Opposition in the Lok Sabha alleged in an article in the Indian Express that this poll "match-fixing" would next happen in the Bihar elections and "anywhere the BJP is losing".

In a post on X, he said, "My article shows how this happened, step by step: Step 1: Rig the panel for appointing the Election Commission. Step 2: Add fake voters to the roll. Step 3: Inflate voter turnout. Step 4: Target the bogus voting exactly where the BJP needs to win. Step 5: Hide the evidence." Hitting back, Nadda said Gandhi's article is a blueprint for manufacturing fake narratives, owing to his sadness and desperation of losing election after election.

He said, "Here's how he does it, step by step. Step 1: The Congress Party gets defeated in election after election due to its antics. Step 2: Instead of introspecting, he cooks up bizarre conspiracies and cries rigging. Step 3: Ignores all facts and data. Step 4: Defames institutions with zero proof."

He added, "Step 5: Hopes for headlines over facts. Despite being exposed time and again, he shamelessly keeps peddling lies. And, he is doing this because a defeat in Bihar is certain."

Democracy doesn't need drama. It needs truth, Nadda asserted.

Gandhi said fixed elections are a "poison" for any democracy, and the side that cheats may win the



game, but it damages institutions and destroys public faith.

In his article, Gandhi alleged that voter turnout figures were inflated. "Election Commission data show that the number of registered voters in Maharashtra in the 2019 Vidhan Sabha elections was 8.98 crore, which rose five years later to 9.29 crore for the May 2024 Lok Sabha elections. "But a mere five months later, by the November 2024 Vidhan Sabha elections, the number had leapt to 9.70 crore. A crawl of 31 lakh in five years, then a leap of 41 lakh in just five months," Gandhi said.

So incredible was this leap that the registered voter total of 9.70 crore was even greater than the 9.54 crore adults in Maharashtra, according to the government's own estimates, he said in his article.

Pointing to inflation in voter turnout on polling day, Gandhi pointed out that "the polling turnout at 5 pm was 58.22 per cent. Even after voting closed, however, turnout kept increasing more and more. The final turnout was reported only the next morning to be 66.05 percent."

"The unprecedented 7.83 per-

centage point increase is equivalent to 76 lakh voters - much higher than previous Vidhan Sabha elections in Maharashtra". He also pointed to the addition of new voters in only 12,000 booths across 85 constituencies in the state, where the BJP eventually won.

In his rejoinder, Nadda shared an article on the portal 'OpIndia' which countered Gandhi's charges.

The BJP also accused Gandhi of attacking democratic institutions to undermine people's trust in the electoral process, claiming he was doing so to pre-empt his party's defeat in the upcoming elections, as he cannot garner public support.

BJP national spokesperson Pradeep Bhandari said the Congress leader was resorting to attacking democratic institutions under a well-planned conspiracy, as he knows that his party is set to suffer defeat in the upcoming Bihar assembly polls.

Gandhi is trying to undermine the trust of people in the electoral process because he is unable to gain public support in favour of his party, Bhandari charged, calling the Congress leader "anti-democracy". (PTI)

## Helicopter on way to Kedarnath crashlands on highway, all safe

**RUDRAPRAYAG, June 7:** A helicopter on its way to Kedarnath made an emergency landing on the highway in Rudraprayag district on Saturday after developing a technical snag during take-off, officials said.

However, all pilgrims on board and the pilot are safe, the officials said. The helicopter had taken off from Badasu base for Kedarnath when it made the emergency landing shortly after take-off on the main road just below the highway near Sirsi following a technical snag during take-off, they said.

Videos on social media showed the Kestrel Aviation helicopter standing in the middle of the highway, dangerously close to populated buildings with a parked car damaged by its tail rotor.

Six people on board the helicopter including the pilot had a narrow escape.

The pilot sustained minor injuries and was rushed to a hospital.

People on the ground got scared as they saw the helicopter getting imbalanced in the air and crash-landing on the road, eyewitnesses said. Kedarnath heli service nodal officer Rahul Chaubey said the incident had not affected the heli shuttle service to the Himalayan temple. (PTI)

## 86.5 lakh deaths in 2022, 15 pc dip over Covid-hit 2021: CRS data

**NEW DELHI, June 7:** Nearly 86.5 lakh deaths were reported in the country during 2022, a significant decline of more than 15 per cent from Covid-affected 2021 which had recorded over 1.02 crore deaths, according to a new data from the Civil Registration System (CRS).

The dip of 15.74 lakh from 2021 brought mortality figures broadly back in line with pre-pandemic patterns last seen in 2020, the data for 2022 brought out by the office of the Registrar General of India through CRS report showed.

According to the CRS data, 2021 registered a sharp spike with 1.02 crore deaths across the country as compared to 81.1 lakh in 2020, 76.4 lakh in 2019, and 69.5 lakh in 2018, underscoring the impact of Covid -19. "In the case of registered deaths, the number has decreased from 102.2 lakh in 2021 to 86.5 lakh in 2022, i.e. a decrease of 15.4 per cent. Some of the major states namely, Gujarat, Maharashtra, Madhya Pradesh, Andhra Pradesh, Tamil Nadu, Uttar Pradesh, Karnataka, West Bengal, Bihar and Haryana have contributed significantly to the decreased number of registered deaths," the report said.

Around 5.26 lakh deaths were reported due to Covid -19 till July 26, 2022, according to a reply given by the government in the Lok Sabha on July 29, 2022.

The World Health Organisation had reported over 47 lakh Covid -19 linked deaths in India which was strongly disputed by the government. The Centre had said the WHO estimates suffered from "a number of inconsistencies and erroneous assumptions". "India had registered a strong objection to the process, methodology and outcome of this unscientific modelling approach especially when India had provided authentic data published through Civil Registration System by Registrar General of India to WHO," the government reply had said.

The CRS report also showed that over 2.54 crore births were registered in 2022. "The number of registered births has increased from 242.0 lakh in 2021 to 254.4 lakh in 2022, an increase of about 5.1 per cent," the report said. There has been an increase in 2022 in registered births in almost all states and UTs, except Bihar, Haryana, Himachal Pradesh, Sikkim, West Bengal, Ladakh, and Lakshadweep as compared to 2021. (PTI)

## CM, DCM have 'blood on their hands', should quit: Shobha Karandlaje

**BENGALURU, June 7:** BJP leader and Union Minister of State Shobha Karandlaje on Saturday alleged that Chief Minister Siddaramaiah and his deputy D K Shivakumar have "blood on their hands", as she held them directly responsible and demanded their resignation in connection with the June 4 stampede that killed 11 people.

Demanding a probe by a sitting High Court judge for the truth to come out, she slammed the state government for suspending Bengaluru police commissioner B Dayananda and four other senior police officials over the incident.

The Bengaluru North MP also questioned the Congress high command and party leader Rahul Gandhi's silence on the incident, and urged them to seek the CM and Deputy CM's resignation if they have "guts".

"Is Karnataka Congress bankrupt of leaders other than Siddaramaiah and Shivakumar? Let the two face inquiry, make others CM and Deputy CM. Where are Congress general secretaries K C Venugopal and Randeep Singh Surjewala, who often come to the state for everything, hiding?" she asked. She further alleged that they are silent on the issue as the Karnataka Congress government is an ATM for the party's Delhi high command.

The stampede occurred on June 4 evening in front of the Chinnaswamy stadium here, where a large number of people thronged to participate in the RCB team's IPL victory celebrations. Eleven people died and 56 were injured in the incident.

"Siddaramaiah and Shivakumar have blood on their hands. The parents who have lost their children are cursing. They (CM and DCM) are trying to wash the blood on their hands and wipe it on police officers. A person known as a tough cop, a

good and honest officer, who came from a normal family and became Bengaluru's commissioner has been suspended," Karandlaje said.

Speaking to reporters here, she said this is a dark spot on this government and the CM's image.

"In the history of Bengaluru or any metropolitan city, we have not heard about officials being transferred for mistakes, but here because of the mistake of the CM and his deputy, the Commissioner has been suspended. You (CM, DCM) have committed the fault and you are blaming them (officials) for it. You are wiping the blood on your hands on them," she added. Questioning Siddaramaiah and Shivakumar, the MP from Bengaluru North asked are they partners with RCB in any ways?

If laurals were brought to the country or the state by an official national or state team, then holding celebrations is understandable, but they were never felicitated this way, she noted and said, "When a private franchise RCB won the match, you wanted to celebrate. The grand stairs of Vidhana Soudha were reserved for swearing-in or government ceremonies all these years. You used it for a private team."

If anyone in the government is planning to have a partnership with RCB or planning for franchise ownership, she sought to know, and further asked, "with these intentions, attempts were made to take publicity from RCB's win."

Pointing out that the family of ministers and the CM had gathered there at the event at Vidhana Soudha, while the public was suffering, Shobha asked how the permission was given. Didn't the intelligence or police have information about the gathering of lakhs of people? (PTI)

## PM Modi lays down 5 priorities for building disaster-resilient infra

**NEW DELHI, June 7:** Prime Minister Narendra Modi on Saturday outlined five key global priorities for him to build disaster-resilient infrastructure, including a skilled workforce, a global digital repository to document best practices and innovative financing.

In a video address to the International Conference on Disaster Resilient Infrastructure 2025, Modi said strengthening early-warning systems and coordination is another crucial aspect.

He noted that India has established a tsunami-warning system benefitting 29 countries and that it recognises the Small Island Developing States (SIDA) as large-ocean countries and the need for special attention to their vulnerabilities.

With the event being hosted in Europe for the first time, Modi thanked French President Emmanuel Macron and extended his best wishes to him for the upcoming United Nations Oceans Conference.

In his remarks, he prime minister noted that the conference's theme is "Shaping a Resilient Future for Coastal Regions" and underscored the vulnerability of coastal regions and islands to natural disasters and climate change.

He cited recent disasters, including Cyclone Remal in India and Bangladesh, Hurricane Beryl in the Caribbean, Typhoon Yagi in Southeast Asia, Hurricane Helene in the United States, Typhoon Usagi in the Philippines and Cyclone Chido in parts of Africa. (PTI)

## Make a vow to reduce salt, processed food & 10 pc less oil for healthy India: J P Nadda

**BENGALURU, June 7:** On this World Food Safety Day, every Indian must make a vow to reduce salt intake, processed food as well as 10 per cent of oil consumption, said Jagat Prakash Nadda, Union Minister for Health and Family Welfare on Saturday.

According to him, it is our collective responsibility to spread awareness about eating the right food.

Nadda was addressing an event organised to celebrate World Food Safety Day by the Union Ministry of Health and Family Welfare at National Institute of Mental Health and Neuro Sciences (NIMHANS) in Bengaluru. World Food Safety Day is celebrated on June 7 of every year.

"We should take the clarion call given by our Prime Minister Narendra Modi and see to it that at least in our own homes, we are able to reduce 10 per cent of oil consumption and salt consumption. This is the most necessary part. We also have to see to it that processed foods are reduced to the maximum," said Nadda.

He also said to remain healthy and to eat right, India must revisit its traditional food practices.

"Our traditional food includes

many types of preparations with millets. We have to revive this tradition," he added.

Nadda said change is possible only if it is a continuous process.

"By talking about food safety habits only on World Food Safety Day is not going to work. It will only work if we make it a part of our life and if we make it a habit," he added.

Nadda also said health consciousness and the Eat Right Movement are imperative as obesity is spreading fast in India.

"India's diabetes study by ICMR says that from 2008 to 2020, the obesity in urban India has increased by 39.6 per cent and in rural areas, it has increased by 23.1 per cent. It is also projected that by 2050, 1/3 of the population will be obese," said Nadda, adding that time to act is now.

During the event, Nadda also released a booklet called 'Eat Right India'.

Sanjay Kumar, Secretary of Department of School Education and Literacy, who addressed the gathering via video conferencing, explained how the science of eating right has become a part of National Council for Education, Research and Training's curriculum. (PTI)

## Technology must complement, not replace, human mind in judicial decision-making: CJI B R Gavai

**NEW DELHI, June 7:** Technology must complement, not replace, the human mind in judicial decision-making, Chief Justice of India B R Gavai has said while emphasising that the value of discretion, empathy and judicial interpretation is irreplaceable. In his keynote address on "Role of Technology in the Indian Legal System" at the School of Oriental and African Studies (SOAS) of the University of London, the CJI said while the judiciary welcomes innovations like automated cause lists, digital kiosks and virtual assistants, it must ensure that human oversight, ethical guidelines and robust training are integral to their implementation.

"The value of discretion, empathy and judicial interpretation is irreplaceable," Justice Gavai said and pointed out that the Indian judiciary is well-positioned to develop homegrown ethical frameworks tailored to the country's constitutional and societal realities.

"We possess the technological expertise, the judicial foresight and the democratic mandate to build systems that reflect our values of equality, dignity and justice," he

said. "In fact, in the very first week after assuming office as the chief justice of India, I initiated a discussion with the Centre for Research and Planning of the Supreme Court to prepare a comprehensive note on the ethical use of artificial intelligence and emerging technologies in the judiciary."

"Technology must complement, not replace, the human mind in judicial decision-making," the CJI said, adding, "The emphasis must always be on using technology to enhance trust and transparency -- never to replace the human conscience at the heart of justice."

He said though the judiciary has started to embrace technology, with the emergence of artificial-intelligence (AI) tools in judicial processes -- from case management to legal research, document translation and even predictive analytics -- there must be caution.

"Around the world, debates are ongoing about the ethical use of AI in legal systems. Concerns include algorithmic bias, misinformation, data manipulation and breaches of confidentiality. For instance, sensitive information, such as the identity of a victim of crime, must never be disclosed due to AI error



or the absence of clear protocols. Additionally, a few recent cases have shown that AI tools can generate fabricated citations or biased suggestions if not properly regulated and monitored," the CJI underscored. He added that technology, if anchored in constitutionalism and empathy, can transform access to justice from an abstract ideal into a lived and shared reality.

"As we continue our journey toward modernising the Indian legal system, our approach must remain deeply rooted in constitutional values. The integration of technology must be people-centric, inclusive

and guided by ethical clarity. Our ultimate goal should be to make justice accessible to every citizen, regardless of language, geography, income or digital literacy," he said.

Concluding his address, Justice Gavai said, "I firmly believe that access to justice is not solely the responsibility of the judiciary. It is a shared national commitment. Law schools, civil society, legal-aid institutions and governments must work in unison to develop and promote technological models that are accessible, transparent and inclusive."

Meanwhile, at a joint event of

the Singapore International Arbitration Centre (SIAC) and Trilegal organised on the occasion of London International Disputes Week, CJI Gavai said in recent decades, the justice-delivery mechanism, once confined within the boundaries of courtrooms, has witnessed a significant shift towards modes of alternative dispute resolution, with arbitration emerging as a prominent pillar of that transformation. The CJI was speaking on the topic of "Navigating the evolving landscape: The impact of the 7th edition of the SIAC Rules on India-Related Arbitrations".

"At the cusp of this evolution lies the recognition that justice, particularly in complex commercial disputes, need not be adversarial or bureaucratic. Rather, it must be confidential, expert-driven and above all, tailored to the needs of those who seek it. Arbitration, in this context, is a substantive recalibration of how we understand and deliver justice," he said.

Justice Gavai pointed out that over the last 10-15 years, India has made a multi-pronged effort towards its aspiration of building a favourable and sought-after place for arbitration. (PTI)



## WTC final will be a new challenge for Australia in foreign conditions: Lyon

**LONDON, June 7:** Nathan Lyon says it will be a different challenge for Australia to take on South Africa in the World Test Championship final despite having the experience of winning ICC trophies across formats since the side will compete in foreign conditions with Duke balls.

Australia come into this WTC final on June 11 at the Lord's not only as defending champions but their squad also comprises of players who won the 2015 ODI World Cup, 2021 T20 World Cup and 2023 ODI World Cup.

"Having the experience of the guys who have won three (50-over) World Cups and T20 World Cups and obviously the World Test Championship final a couple of years ago, that experience and that pressure in those higher games, it's going to be, it's on our side, isn't it, but it doesn't mean anything when you come to the game," Lyon was quoted as saying by the ICC.

"South Africa have got some world class batters and obviously they've got some unbelievable bowlers there as well so it's going to be a good challenge and obviously it's a one-off Test match.

The English conditions offer good swing to bowlers while in Australia pacers enjoy bounce. The Australians use, in home conditions, the Kookaburra balls, which offer good grip to spinners after loss of seam.

"It's going to be different challenge and with foreign conditions and the Dukes ball. It's going to be two best bowling attacks going at each other which is another exciting thing so it's going to be a good challenge for all batters," he said.

Lyon said he has followed the progress of the South African batters in recent days.

"I'm a cricket nuffie, so I've watched a fair amount of cricket and even tuned into their (South Africa's tour) game at the moment against Zimbabwe," Lyon said.

"They've got some class players as I said with the likes of Aiden Markram, Rickelton at the top of the order there, they're class players, there's no point in hiding behind that fact either." (PTI)

## Diksha adds another solid round in Spain to move into tied third place

**TENERIFE (SPAIN), June 7:** India's Diksha Dagar followed up her opening round with another strong effort, carding a three-under 69 on the second day to tie tied third at the Tenerife Women's Open on the Ladies European Tour here.

The 24-year-old has carded rounds of 70 and 69 to sit at five-under after two rounds. She is four shots behind sole leader Lauren Walsh (67-68), who is nine-under at Abama Golf.

Avani Prashanth played three-over par 75 on the second day to fall down the standings to tied 43. Tvesa Malik (73-75), Hitaashree Bakshi (72-76) and Sneha Singh (77-79) failed to make the cut, which was set at three-over par.

Starting her day on the first tee, Diksha picked up a shot on the fifth hole before dropping one on the fifth but immediately got it back on the sixth and grabbed one more on the ninth.

## GUKESSH BLUNDERS AGAINST CARUANA

# Magnus Carlsen wins Norway Chess title for seventh time



**STAVANGER (NORWAY), June 7:** World champion D Gukesh committed a costly blunder against American Grandmaster Fabiano Caruana in the final round to finish third, as five-time world champion Magnus Carlsen clinched a record-extending seventh Norway Chess title here.

Gukesh, after being in a disadvantageous position against 2018 Norway Chess champion Fabiano Caruana, tried to stage a late comeback but ran out of time and committed a blunder, instantly realising his chances had slipped away. Gukesh offered a handshake, grimaced, closed his eyes, and buried his face in both hands in frustration.

It was a golden opportunity for the young Indian world champion to win his maiden Norway Chess title in only his second appearance, after a roller-coaster tournament that saw him start on a poor note before turning things around with impressive Classical wins over Magnus Carlsen, compatriot Arjun Erigaisi, and China's Wei Yi.

Defending champion Carlsen, who was the overnight leader with 15 points after round 9, ended the tournament with 16 points after fashioning the great escape against GM Erigaisi and steering the game to a draw in the 10th round on Friday. Gukesh finished third -- the same as in the 2023 edition -- with 14.5 points, while Caruana was second with 15.5 points. Erigaisi finished fifth with 13 points.

Erigaisi won the Armageddon tie-break against Carlsen following the miraculous draw by the Norwegian, but it did not matter in the end as the five-time world champion had already secured a point with the stalemate to win the title.

While Gukesh quietly walked out of the arena after losing to Caruana, Carlsen said he had to "literally fight for his life" to stay in the match against Arjun Erigaisi.

A defeat for the Norwegian would have been catastrophic, as the Gukesh-Caruana game was still in progress, and a Classical win for either would have dashed

his hopes of a seventh Norway Chess title and the accompanying prize purse of approximately USD 69,500.

In fact, had Gukesh managed to draw his game against the American Grandmaster, he would have secured the title--provided Carlsen had lost his Classical encounter against Erigaisi.

Under the Norway Chess format, a Classical win earns three points, while a draw gives each player one point. A drawn game is followed by an Armageddon tie-break to decide the winner, who is awarded an additional half point.

"I don't know what to say, like I kind of provoked him (Erigaisi) into concrete action and then I obviously missed something pretty big. But I thought I was doing well when he completely out-calculated me and I just had to yeah fight for my life," said Carlsen.

"It's just trying to find practical chances that keep the game alive, and it seemed that he (Erigaisi) got a bit nervous at some point... gave

me very good chances." Carlsen admitted that part of his attention was on the Gukesh-Caruana game, given the significant impact it could have had on his title-winning chances.

"I was just not good enough to find the win but looking at the other game (between Gukesh and Caruana), I kind of figured out at some point that I probably wouldn't need to win and that helped me," said Carlsen. "Yeah, of course it's (the win) a huge relief after a day like this in the tournament. Obviously, you know, my struggles have been well documented here but at least I fought till the end so I'm happy with that. It's been a roller-coaster ride and we're talking about classical chess." Carlsen said he would not be playing a lot of classical chess in times to come.

"Not a lot (of classical chess) for sure. I'm not going to say that this tournament was my last for sure but I enjoy other forms of chess a lot more."

On whether the title felt like a statement amid talks of the next generation rising, Carlsen said: "Had I actually won the tournament convincingly, we might have been having these talks. But honestly, there were at least three people who could have won this tournament easily, and I kind of stumbled into it. I don't think that's much of a statement. 'It's good to see that I feel like, at least in parts of the game, I am a lot better than the kids who are trying to take over. It's rare to see so many twists and turns... the quality wasn't perfect, but there was a lot of good chess as well.'"

In the women's section, overnight leader and two-time world blitz champion, Ukraine's Anna Muzychuk won the title with 16.5 points despite an Armageddon tie-break loss to India's R. Vaishali in the final round. Muzychuk's draw in the classical game against the Indian earned both players a point each, while Vaishali secured another half a point by beating the Ukrainian in the Armageddon sudden death to finish on 11 points. ## India's archery hopes crash in Antalya debacle; Simranjeet shines in rare spark



**ANTALYA (TURKEY), June 7:** Indian archery endured a forgettable outing at Stage 3 of the World Cup here on Saturday, returning empty-handed in a performance that raised serious questions over team selection, preparation and mental fortitude, especially with the Asian Games just a year away.

The high of Shanghai last month, where India stood second on the medal tally with two gold, one silver and four bronze medals, now seems like a distant past. The third leg in Antalya saw both recurve and compound archers flop spectacularly, with not a single podium finish, even in their traditionally strong compound category.

A day after India's compound archers crashed out in both individual and team events, the recurve results were equally dismal, with seasoned names like four-time Olympians Deepika Kumari and Tarundeep Rai also failing to reach the medal rounds.

The only fight came from Simranjeet Kaur, who shocked everyone by stretching Korean Olympic gold medalist An San to a shoot-off in the quarterfinals on Saturday. Simranjeet, who barely made the cut at 54th with the third-lowest qualification score, was on the verge of a historic win, leading 5-3 and needing just a point to seal it against Korean star An San.

But, as has often been the case with Indian archers, nerves took over in the decider. A poor fifth set saw her shoot a 5 and an 8, al-

lowing An San to force a shoot-off. The Korean nailed an 11 under the new scoring system, while Simranjeet faltered with an 8, losing 5-6 (29-28, 24-29, 27-24, 27-27, 23-29) (8-11).

Her second set, where she landed an arrow in the blue ring (6), also proved costly.

An San, meanwhile, defeated Indian star Deepika three times in a row. The South Korean had earlier ousted the Indian star in the second round with a 6-0 rout (29-30, 27-28, 28-30) dashing her hope for a successive medal. Deepika had bagged a bronze in Shanghai last month. Deepika, the former world number 1, continues to falter against elite opponents and has failed to learn from repeated mistakes, particularly against the dominant Koreans.

Ankita Bhakat, who was India's best archer in qualification at 32nd, exited in the opening round, losing 2-6 (27-26, 26-28, 29-30, 28-29) to Dunya Yenhilayay -- another lead squandered after going up 2-0. Former youth world champion and Shanghai bronze medalist Parth Salunkhe suffered a shock first-round exit to Lu Shuai of China 2-6 (28-29, 25-28, 28-25, 27-30), while Rai, at 41, showed little justification for his selection as he went down 2-6 to Germany's Mathias Kramer (28-30, 29-28, 27-31, 29-32). Another seasoned campaigner Atanu Das, after leading 4-2, surrendered meekly to world no. 1 Brady Ellison 4-6 (28-27, 30-31, 31-30, 30-31, 27-30) from being 4-2 up. (PTI)

## WFI hands temporary suspension to 30 overage wrestlers, bars them from junior competitions

**NEW DELHI, June 7:** Cracking down the whip on overage wrestlers competing at junior level, the Wrestling Federation of India (WFI) has handed temporary suspension to 30 of them in the past month after investigating more than 400 such cases.

The WFI acted on complaints, largely from coaches and wrestlers from the Delhi 'Akharas' that many wrestlers from Haryana have procured fake certificates to show they were born in the national capital and are eligible to compete at junior level.

Much to the exasperation of WFI, two overage wrestlers even won medals at the recent Khelo India Games in Bihar.

"We do not want to spoil careers of wrestlers, so we have just barred them from the junior level competitions, like U18 and Cadets. They should compete at the senior level, if they are over 18 they must represent their original state," a senior WFI official

told PTI.

"Now they need to come to WFI, apologise for their actions and cheating. We will consider their cases. This has been going on for some time. One by one we suspended around 30 such offenders in the last 30-40 days."

The WFI official explained that most of these wrestlers, misguided by their coaches in Haryana, paid bribes to procure fake birth certificates from the Narela and Rohini zones in Delhi.

"Out of 436 cases, around 300 were from the Narela zone, while the rest were from the Rohini zone like Sultanpuri and Mangolpuri. Most of them were getting certificates from Begumpura."

"All of them wanted to represent Delhi since getting selected in Haryana teams is not easy. We approached MCD and the Delhi Cantonment Board after receiving complaints and upon investigation it was proved they were fake certificates," the official said.



ates," the official said.

"Actually the coaches are to be blamed. They want their wards to win medals at competitions to become famous. That greed drives them to have overage wrestlers competing at junior level," he added.

Then WFI had also complained to the Games Technical Commit-

tee of the Khelo India to get a female wrestler thrown out of competition for submitting a fake birth certificate.

"This female wrestler had submitted a certificate issued by Delhi Cantonment Board. When we approached the Board, they confirmed to us that no such certificate has been issued by them."

Explaining the modus operandi, the WFI official said that the wrestlers play hefty sum to cyber cafe owners to create fake bar codes on the certificate.

Anyone who scans the certificate will get details as they were filled by the cafe owners, making the certificate appear original.

Also, the WFI has decided not to consider birth certificates, issued only recently.

Meanwhile, the WFI has suspended Sanjay Lather, a Haryana coach, after receiving a sexual harassment complaint against him during the Khelo India Games.

"We had received a complaint that this coach, who was appointed by the state government, had entered the room of a female wrestler after the competition ended."

"The Internal Complaints Committee duly investigated the matter and decided to terminate him from all wrestling activities for life," the official said. (PTI)

## India must give Gill a crack at Test captaincy for a long period of time: Ponting

**NEW DELHI, June 7:** India have taken the right decision by handing the reins of the Test team to Shubman Gill and now the youngster must given a long rope to prove his credentials, says Ricky Ponting, who is also confident that India can handle the ongoing transition phase better than other countries.

India will be without stalwarts Virat Kohli, Rohit Sharma, Ravichandran Ashwin, who all retired recently, and pacer Mohammed Shami when they begin their five-Test tour of England on June 20.

While Kohli and Rohit retired from Tests last month, Ashwin had hung up his boots during the Australia tour last year and Shami was ruled out on fitness grounds for the tour of the Old Blighty.

"I actually think it's the right

move. I know there's a lot of other people out there, pundits out there saying they can't understand why it wasn't Bumrah and why they have gone to Shubman, but I think it's pretty simple," Ponting told The ICC Review.

"Bumrah's injuries are holding him back a bit in the last couple of years and you don't want that with a captain. You can't have a captain coming in and missing games here and there, so I think it's the right decision."

"Now that they've made it, it's one they've got to stick with and give him (Gill) a good crack at it for a long period of time," he said. Ponting said it would be tough to replace players with experience but said India should be able to handle the transitional phase better than any other Test-playing side. "It's



always very hard to replace players like that, (given) that have been around for so long that have played that much Test cricket. But if any country can do it and do it quickly, India can, because of the amount of

young talent that they have," Ponting said.

"I've seen it first hand for 10 years now around the IPL and we've seen the emergence of (Yashasvi) Jaiswal and these sort

of guys that have come into international cricket with India and (have) done really well pretty much straight away."

"The skill side of it's one thing to replace and India will replace the skill side of it easily enough, but the experience is the big thing that's going to be missing for them." He continued, "Now even with a young captain with Shubman Gill, they'll still have some experience around with KL Rahul and Bumrah and these sort of guys. But if you look at a rebuilding sort of phase, India can cope with it better than most other teams."

Ponting, who coached Punjab Kings to the Indian Premier League final this year, said left-arm pacer Arshdeep Singh should be named in the playing XI for the first Test at Headingley. (PTI)

## Sharma misses cut, Ahlawat retires in KLM Open

**AMSTERDAM, June 7:** Indian golfer Shubhankar Sharma failed to make the cut after carding a one-over 72 on the second day of the KLM Open here. Sharma shot 78 in the first round.

Play was suspended for the day due to darkness at The International.

Though the projected cut is set at four-over, Sharma at eight-over is certain to miss the cut. He had two birdies and one bogey in his second round.

Meanwhile, Veer Ahlawat retired after a difficult first day of 78. During the second round, the weather conditions were tough as play had to be stopped for two hours in the afternoon before it could be resumed. The strong winds went to over 35

mph.

Joakim Lagergren set himself apart from the rest of the field on the second day as he played a round of three under par for the day despite the harsh conditions.

Lagergren was helped by the fact that he started earlier in the day, taking the lead by two strokes with a round of 68 and has a total score of eight under. The round included seven birdies and four bogeys.

The harsh weather made it challenging for all players as day one leader Ricardo Gouveia had to fight his way to a round of one-over 72. He is now in second place with a score of six-under par.

Gouveia made four birdies and five bogeys. (PTI)
