# Honeymoon horror: Wife behind husband's muder; 5 held sonam gives in at Ghazipur in UP • Conrad congratulates Meghalaya police for cracking the case to identify illegal foreigners'

SHILLONG/ LUCKNOW, June 9: Indore tourist Raja Raghuvanshi was allegedly killed by men, hired by his wife, during their honeymoon in Meghalaya, DGP I Nongrang said on Monday.

Speaking to PTI, she said the wife, Sonam, surrendered before the Nandganj Police Station in Uttar Pradesh's Ghazipur, while three other assailants were arrested in overnight raids.

Of the three arrested men, two are from Madhya Pradesh's Indore and one from Lalitpur in Uttar Pradesh, she said

East Khasi Hills SP Vivek Syiem said one more was arrested from Madhya Pradesh's Sadar district on Monday.

Raghuvanshi and his wife went missing while vacationing in Sohra area in Meghalaya's East Khasi Hills district on May 23. His body

while a search for his wife was underway.

"One person was picked up from UP, and another two accused were apprehended from Indore by the SIT," the DGP said.

"Sonam surrendered at the Nandganj police station in UP, and was subsequently arrested," she Nongrang said the arrested men

had revealed that the wife had hired them to kill Raghuvanshi. The East Khasi Hills SP said,

'The first person arrested was Akash Rajput, 19 years old, from Lalitpur, Uttar Pradesh. The second was Vishal Singh Chauhan, 22 years old, from Indore, Madhya Pradesh. The third was Raj Singh Khushwaha, 21 years old, also from Indore.

"Sonam Raghuvanshi is currently in police custody. This after-

**GUWAHATI, June 9:** The flood situation in Assam remained critical with around 2.6 lakh people in six districts still suffering from the deluge on Monday, even as the water levels continued to recede in many parts of the state, officials said.

A senior official of the Assam State Disaster Management Authority (ASDMA) told PTI that the floodwaters continued to recede in almost all inundated areas, with most parts of the state not witnessing any rain in the last 24

"If it does not rain today, we hope that the situation will improve considerably in most parts of the state," he added.

A report, issued by the ASDMA on Sunday night, said that three more people lost their lives in Kamrup district, and around 2.6 lakh people are suffering from the deluge across six districts.

"I am thankful to Congress and other opposition leaders, especially Shashi Tharoor, who have strongly defended India's position on foreign soil. Not only him, but leaders like Asaduddin Owaisi and Supriya Sule also represented India on foreign

soil and defended the nation. "They all stood for India. But Leader of the Opposition in Lok Sabha Rahul Gandhi did not. He has betrayed the nation. He has betrayed the armed

forces," Sarma alleged. He criticised Gandhi for allegedly questioning India's losses in the armed conflict with Pakistan during Operation Sindoor.

#### Six active COVID-19 cases in Assam

GUWAHATI, June 9: Assam's active Covid case count declined to six in the current wave as two more persons recovered from the disease in the last 24 hours, according to the Union Health Ministry data released on Monday.

According to the data, there are six active cases in Assam, while two have recovered since Sunday. Since January this year, Assam has seen seven people recovering from the COVID-19 virus, it added.

There are 6,133 active COVID-19 cases in India, and six more deaths have been reported, the ministry said. Official sources have maintained that most cases are mild and managed under home care. (PTI)

# India's heatwaves worsening, but no one knows how many dying

NEW DELHI, June 9: On a scorching May afternoon last year, a ragpicker in Delhi's Ghazipur area collapsed from heat exhaustion.

"The family rushed him to the hospital," says Majida Begum, a sanitation worker who witnessed it. "But he was declared dead on arrival. They had no proof that he died due to heat, so they were not given any compensation.'

His death was never officially counted, just one of the countless lives lost in India's intensifying heatwaves that go unrecorded and uncompensated.

An investigation by PTI reveals that disjointed, outdated reporting systems are obscuring the true toll, weakening both public awareness and policy action. Accurate data on heat-related deaths helps identify who is most at risk.

Without it, the government cannot plan effectively, create targeted policies or take timely action to save lives. But behind the missing numbers are real people, many



poor and undocumented, whose deaths routinely slip through the cracks of India's incoherent report-

Currently, at least three separate datasets attempt to monitor heatstroke or heat-related deaths. The two most commonly cited in the media are maintained by the National Centre for Disease Control

(NCDC) under the health ministry and the National Crime Records Bureau (NCRB) under the home ministry. The India Meteorological Department (IMD) also reports figures on deaths caused by "heatwaves" in its annual reports, drawing data primarily from media

However, these three sources re-

For instance, data obtained through an RTI query from the health ministry shows 3,812 heatrelated deaths were recorded between 2015 and 2022 under the Integrated Disease Surveillance Programme (IDSP), managed by

the NCDC. In contrast, NCRB figures, cited multiple times in Parliament by Union Earth Sciences minister Jitendra Singh, put the number of deaths due to "heat/sunstroke" during the same period at 8,171.

Meanwhile, the IMD's annual reports record 3,436 deaths due to 'heatwave" between 2015 and 2022. While the NCDC and the IMD have already released the figures for 2023 and 2024, the NCRB is yet to publish the data for these years.

Since 2015, the health ministry has been collecting data on heat illness and deaths from April to July. In 2019, this was extended to March through July, covering 23 states. (CONTD. ON PAGE-2)

MOSCOW, June 9: The tension between India and China has eased "significantly" and the stalled work of the RIC troika could be restarted, Russian Foreign Minister Sergei Lavrov said on Monday.

Speaking at the "Forum of the Future-2050" here, he said the resumption of joint work in RIC format could be the first step towards pan-Eurasian processes, including the formation of a multi-polar architecture.

"I really hope that we will be able to restore the work of the Russia-India-China trio. We have not met at the level of foreign ministers for the last couple of years, but we are discussing this issue with my Chinese colleague and with the Indian head of the External Affairs department.

"I really hope that now that the tension has eased, in my opinion, has eased significantly on the border between India and China, and the situation is stabilising, there is a dialogue between New Delhi and Beijing, we will be able to resume the work of this Russia-India-China trio," Lavrov was reported as saying by Russia's state-run TASS news agency.

Lavrov said that Russia and China can and should play a leading and proactive role in the pan-continental process, including in the formation of a multi-polar architecture, and added that the restoration of the RIC format could act as the first step towards this.

"This will also be a very important step forward in the movement of continental processes," Lavrov added. The two-day forum inspired by Russian philosopher Alexander Dugin, often dubbed as President Vladimir Putin's 'guru', has attracted young participants. Tesla and SpaceX CEO Elon Musk's father Erol Musk is also attending the forum.

Last week, a Pakistani delegation met Lavrov in Moscow and handed over a letter from Prime Minister Shehbaz Sharif for Russian President Vladimir Putin.

Lavrov said that a direct dialogue between Pakistan and India is needed to build mutual trust between the two countries, TASS news agency reported, citing the Russian Foreign Ministry. On Friday, top diplomats from India and China dis-

cussed bilateral relations to implement the consensus reached by the leaders of the two countries last year, the Chinese Foreign Ministry said.

The meeting between Indian Ambassador to China Pradeep Kumar Rawat and China's Vice Foreign Minister Sun Weidong on Thursday is the first diplomatic engagement between the two countries post the Operation Sindoor that India launched in response to the April 22 Pahalgam terror attack that left 26 people

Tensions between India and Pakistan, Beijing's allweather ally, escalated after the Pahalgam terror attack, with India carrying out precision strikes on terror infrastructure in Pakistan and Pakistan-occupied Kashmir in the early hours of May 7. The four days of on-ground hostilities from both sides ended with an understanding of stopping the military actions following talks between the directors general of military operations of both sides on May 10. (PTI)

# Dalmia Bharat, Birla Corp incentive demand worth ₹430cr at risk after Bengal govt's policy churn

KOLKATA, June 9: Two major companies, Dalmia Bharat Ltd and Birla Corporation, said that about ₹ 430 crore in promised state incentives may now be at risk after the West Bengal government scrapped several industrial subsidy schemes in 2025.

An official of Dalmia Cement (Bharat) Ltd (DCBL), a wholly owned subsidiary of Dalmia Bharat, stated that it was supposed to receive ₹ 236.32 crore along with 8 per cent interest under the now-revoked 'WB State Support for Industries Scheme 2013'.

Dalmia Bharat operates a cement plant with a capacity of four million tonnes in Paschim Midnapore district.

Birla Corporation Ltd, another affected firm, disclosed that it was to receive ₹55.66 crore in Industrial Promotion Assistance (IPA), already sanctioned by the West Bengal State Industrial Development Corporation (WBSIDC). Additionally, the company has an



outstanding claim of ₹ 138.58 crore. Both companies fear that these incentive dues may be jeopardised due to the implementation

of the Revocation Act. "This legislation is likely to adversely affect the order of the Hon'ble Calcutta High Court," a Dalmia Bharat official said, adding that the company is evaluating all

legal options to protect its rights. Officials of both companies said they are reviewing the legal validity and retrospective nature of the Act and are considering all avenues, including court challenges.

The West Bengal government had said in March that it had revoked eight incentive schemes for heavy industries', launched during formulate a modern scheme to encourage the setting up of industrial

An industry chamber official, declining to be quoted, said these are just two cases and more are expected to join the list.

During a previous discussion on the Revocation of West Bengal Incentive Schemes and Obligations in the Nature of Grants and Incentives Bill, Chief Minister Mamata Banerjee had said the situation had changed significantly over the last 20-25 years and that some of the incentives introduced by the erstwhile Left Front government had become "irrelevant" and were

being withdrawn. "Now, various works are being done on AI technology. Many new ideas and approaches have been added to the industry. Therefore, a new policy is being brought with the opinions of all concerned." Banerjee had said. A committee was also set up in this regard. (PTI)

Meghalaya chief minister Conrad K Sangma congratulated the state police for cracking the case that had shocked the nation. "Within 7 days, a major breakthrough has been achieved by the #meghalayapolice in the Raja murder case... 3 assailants who are from Madhya Pradesh have been arrested, female has surrendered and operation still on to catch 1 more assailant... well done," he posted on X earlier in the day

PTI had on Saturday reported that a tourist guide in Mawlakhiat, Albert Pde, had seen Raghuvanshi and his wife with three men on the day they went missing. Albert said that he had seen the couple, accompanied by three men, as they were climbing over 3,000 steps from Nongriat to Mawlakhiat around 10 am on May 23.

Albert said he recognised the couple as he had offered his services to them on the previous day to see the famed living roots bridge in Nongriat, but they had politely refused and hired another guide. He also said that all three men accompanying the couple were speaking in Hindi, indicating that they were not locals.

The families of the husband and the wife had sought a CBI investigation. Raghuvanshi's body was found in a gorge near Weisawdong Falls. A gold ring and a neck chain were found missing from his body, further leading to suspicion that he was murdered. A day later, a bloodstained machete was found nearby, and two days later, a raincoat that was similar to the one used by the couple was found in Mawkma village, halfway between Sohrarim and the gorge where Raghuvanshi's body was found. Madhya Pradesh chief minister Mohan Yadav on Saturday said he has requested Union home minister Amit Shah to order a CBI probe into the case.

On Friday, Sonam's family urged the Centre to hand over the case to the CBI, expressing dissatisfaction with the probe of the Meghalaya Police. "My daughter has been abducted and is still in the clutches of her captors. Meghalaya Police are not investigating the matter properly. They have been negligent right from the beginning. I have been seeking the deployment of the Army since the day they went missing. If it was done in time, they would have been found safely," Sonam's father, Devi Singh Raghuvanshi, told PTI. After their marriage on May 11, the couple left for Meghalaya on May 20 for their honeymoon.

They arrived at Mawlakhiat village on May 22 on a rented scooter. On May 24, their scooter was found abandoned at a cafe along the road from Shillong to Sohra, following which the search for them began. A special investigation team (SIT) headed by an SP and assisted by four DSPs was probing the matter. (PTI)

#### Assam govt to intensify drive

It implies that the government does not have to go to a tribunal for identifying foreigners and if the DC has prima facie evidence, the illegal resident can be 'evicted' or 'removed', Sarma said. He added that people coming in to escape religious persecution are exempted under the Act. Sarma said another recent Supreme Court ruling that updating NRC and identification of foreigners are not inter-linked has made it clear that the government's 'hands and legs are not tied' with the NRC process and it can go ahead with finding out the illegal residents. He said the process of securing NRC data, as directed by the apex court, was being done and it will be

completed within 8-12 months, after which 'acceptance/ rejection slips' to the people can be given. He, however, added that the state government does not consider the final draft of the NRC as the "final one' as ineligible people have got their names included in it through "various means". "Even people declared as foreigners by Foreigners' Tribunals have their names in NRC," he claimed, adding that his government had approached the apex court with the plea for re-verification of 20 per cent of names in border districts and 10 per cent in other districts. He alleged that activists like Harsh Mander had conspired to include foreigners in the NRC and said, "If I would have been the CM then, I would have jailed the likes of him."

"We have documented all evidence showing how about 2,600 Facebook accounts of Islamabad, Riyadh, Saudi Arabia, post on Palestine or Assam only... They don't welcome Rahul Gandhi but do so for one Assam leader," he added. The chief minister said that while the state government has been facing the Supreme Court's criticism for not expelling identified foreigners, it has been doing so for last two-three months now.

He admitted that a few of these expelled or pushed back people had court cases pending and they were brought back using formal and informal diplomatic channels. Sarma said over 303 illegal Bangladeshis have been pushed back in the past couple of months and the drive will be intensified, adding that 35 people are ready to be pushed back once flood waters recede. "There is no way that Pakistani, Bangladeshi fundamentalist elements will be allowed to enter Assam. To save Assam, we have to be more active," the CM asserted. "I am an Assamese first, and then the chief minister... We have cleared the path for deportation and the process will continue," he added. Sarma said a huge number of illegal Bangladeshis picked from other states have been pushed back by BSF with the Assam government as the facilitator, though he did not mention any figure.

"It is necessary to push back these people so that the message goes that they should not try to come here illegally," he added. Responding to AIUDF MLA Rafikul Islam's caution that foreigner detection should be handled carefully because "citizenship is a most valued asset for any individual," Sarma doubled down on his criticism of the Congress. "Rafikul Islam has said citizenship is the most valuable asset, but it may not be so for Congress as they have people in whose family out of four members, three are foreigners," he said. Sarma had been claiming that not only has Congress MP Gaurav Gogoi's wife retained her British citizenship, but their two minor children are also not Indian nationals.

CPI(M) legislator Manoranjan Talukdar and Islam also expressed apprehension that power to DCs to declare foreigners should not be used arbitrarily or on communal lines. Opposition Congress and AIUDF expressed their dissatisfaction with the chief minister's reply and demonstrated in the Well of the House, with the Congress also briefly walking out of the House. The House was adjourned for 30 minutes as AIUDF MLAs were seated

The book on his life will be presented to 10-12 lakh people in Assam, he added. The chief minister said several proposals have been received during the first meeting of the core committee formed for the centenary celebrations, and steps will be taken to implement these as far as possible. "Bhupen Hazarika was a person of the masses, and the government alone cannot celebrate his life. I urge the MLAs to take this celebration to all levels of society to make it a real success," he added. Sarma also underlined various measures by his government to present before the country and world the rich heritage and history of the state, including celebrations of the 400th birth anniversary of legendary Ahom general Lachit Barphukan, UNESCO world heritage site status to Charaideo Moidam and classical language status to Assamese. No eviction of tribals has been carried out by our government," he claimed. #### India's heatwaves worsening

The NCRB has recorded heatstroke deaths since 1995, listing them as "accidental deaths from forces of nature" since around 2010. PTI spoke to government officials and healthcare-policy experts to understand the large discrepancies between these datasets. A senior Delhi Police official explained that the NCRB data largely reflects the number of unattended individuals found dead by police at public spaces, homes and elsewhere.

Such bodies are taken to hospitals where doctors conduct autopsies to determine the cause of death. According to the NCRB, 730 people died from "heat/sunstroke" in 2022, 374 in 2021 and 530 in 2020. By contrast, the NCDC data shows just 33 heat-related deaths in 2022, none in 2021 and four in 2020, as many states failed to report their figures. These states included Delhi, Uttar Pradesh, Rajasthan, Punjab, Haryana, Madhya Pradesh, Chhattisgarh, Bihar, Jharkhand, Karnataka, Kerala, Andhra Pradesh, Telangana, West Bengal and Tamil Nadu. A health ministry official, speaking on the condition of anonymity, said the data from the NCRB and the NCDC

are "not directly comparable" because they originate from different sources. "The NCDC reports deaths of patients who come to hospital OPDs or are admitted. But if a person dies and is brought for autopsy, that data goes to the forensic medicine department, which may not always share the information with the NCDC," the official said. He acknowledged the existence of multiple datasets on heat deaths in India and noted that "none of those alone gives the full picture". "While knowing the actual number of heat deaths is important for policy making, confirming such deaths is difficult even with health ministry guidelines, he added. (PTI)

JORHAT, June 9: In a compelling observance of World Environment Day 2025, the CSIR-North East Institute of Science and Technology (CSIR-NEIST), Jorhat, hosted a day-long programme that underscored the urgency of sustainable development and collective climate action.

## **Communal tensions grip Dhubri town** following alleged cow meat recovery

DHUBRI, June 9: Communal tension gripped Dhubri town after alleged cow meat and body parts was recovered from multiple locations, including the premises of a Hanuman Mandir in Baluchar, Ward No. 3. The incident, first reported on Sun-



day, sparked widespread unrest, leading to the closure of shops and market establishments across the town.

On Monday, the situation deteriorated further, with riot-like scenes reported in several areas such as Chatiantola and Baluchar. Police were compelled to use tear gas at certain spots to disperse agitated crowds. The recovery of suspected cow meat and body parts triggered anger among local residents, further intensifying the volatile atmosphere.

In response to the unrest, Dhubri District Commissioner Dibakar Nath, IAS, invoked Section 163(1) of the Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023, and issued prohibitory orders with immediate effect. The order cited potential threats to peace and public tranquillity and sought to prevent any escalation of vio-

Under the order, all shops and commeron standby as a precautionary measure.

cial establishments within Dhubri town limits have been directed to remain closed until further notice. The assembly of five or more persons in public places for demonstrations, rallies, or meetings has also been prohibited. Only essential serv--such as medical facilities, educational institutions, police, SDRF,

> forces—have been exempted. District Commissioner Nath. warned that any violation of the prohibitory order would attract penal action under Section 188 of the Bharatiya Nyaya Sanhita and other relevant laws. The order was passed ex-parte in view of the urgency and remains in effect until further notice.


# Manas National Park witnesses significant growth in tourism revenue

#### BTR's sustainable tourism initiatives highlighted

GUWAHATI, June 9: Manas Na-

tional Park, located within the Bodoland Territorial Region (BTR), has recorded a steady and notable increase in tourism revenue over the past three financial years, as per report of the Forest Department. The Tourism Department, in collaboration with the Forest Department and local stakeholders, continues to focus on maintaining this momentum.

For the financial year 2024–25 (up to May 2025), the total revenue collected from tourism activities in the park stands at ₹ 1,73,31,100. A total of 60,921 Indian visitors and 3,426 foreign visitors entered the park during this period. This marks a substantial growth in comparison to the previous year, 2023-24, which recorded over ₹ 1 crore 40 lakh 64 thousand in revenue with 50,515 Indian and 1,816 foreign tourists. In 2022-23, the revenue stood at ₹ 1,35,98,275 from 55,257 Indian and 924 foreign tourists.



The figures demonstrate an encouraging upward trend, particularly in foreign tourist arrivals, which have more than tripled over the last three years. The peace that has prevailed in the re-

gion in recent years, under the leadership of BTC CEM Pramod Boro, has created a stable environment for tourism to flourish. Manas National Park today reflects not only the area's natural beauty but also the growing sense of stability and progress in the This growth further coincides with

ongoing efforts by the Tourism Department of BTR to promote ecotourism and improve the visitor experience through better infrastructure, accessibility, and local engagement. Increased awareness, combined with conservation-based initiatives, appears to have contributed to the park's growing popularity

As a UNESCO World Heritage Site and a key biodiversity hotspot, Manas National Park plays an important role in conservation and nature-based tourism in Assam. The consistent rise in both footfall and revenue underlines the park's significance in the broader tourism landscape of the region. These developments align with the larger goals of the BTR administration to strengthen sustainable tourism while preserving the ecological balance of the park and supporting the livelihoods of local communities.

# India's diplomatic outreach

everal days have passed since the temporary truce in the limited four-day war between India and Pakistan taking effect on May 10 this year. Prime Minister Narendra Modi has been talking of his three-point doctrine since then, the most important of which is no dialogue with Pakistan unless the ruling regime of Islamabad shuns terrorism. Pakistan Prime Minister on the other hand is claiming as usual that his government had no role in the Pahalgam massacre of April 22, Pakistan strongly believes in fight against terrorism. Pakistan is ready for bilateral talks to discuss all the pending issues including terror. In this backdrop, fierce campaign has been launched by both India and Pakistan to influence the views of the foreign countries including the permanent and non-permanent members of the United Nations. Seven parliamentary delegations from India are on a visit to 33 nations in their diplomatic outreach. Two delegations have already returned. Congress Lok Sabha member Shashi Tharoor is still staying in the US at the head of the delegation to apprise both the U.S. government officials and the UN members the Indian viewpoint why Pakistan is the fountainhead of terrorist actions on Indian soil and why it is not possible to have any bilateral dialogue with Pakistan. Pakistan Prime Minister Shehbaz Sharif has himself visited four countries so far as a part of his government's global outreach. Simultaneously a high powered delegation led by former Pakistan Foreign Minister Bilawal Bhutto Zardari is in USA talking to the Washington administration and the UN mem-

Herein lies India's dilemma of positive global diplomatic outreach. So far, the feedback from the Parliamentary delegations talks abroad and the Indian embassies own efforts for outreach is this - all foreign leaders and the diplomats in the course of discussions are mentioning two things. First they are all with India in its fight against terror. They all favour India's fight against terrorists based in Pakistan. But they do not like any war between the two nuclear powers on this issue. They want bilateral talks if India does not agree for a mediator. Even Russian foreign minister has mentioned this, though Russia's statement was strongest in support of India's actions. This in the perception battle or more specifically in information war, Pakistan is getting some advantage as of now vis a vis India. Left to the external affairs ministry officials, they could have done much better job than the visiting Parliamentary delegations but their hands are tied.

Now let us look at some upcoming events which show how challenging will be India's task in the coming two months in the arena of global diplomacy. First, India has not been invited to the G-7 summit at Alberta in Canada scheduled from June 15 to June 17. In the last five years, our Prime Minister made every effort to make himself visible among the World's top leaders. Last year at the G-7 summit in Italy, Italian Prime Minister Giorgia Meloni praised the Indian PM belonging to their own far right clan.

# Elon Musk's Bold Move: The America Party

tial figures in the world U.S. President Donald Trump and billionaire entrepreneur Elon Musk has taken a dramatic turn, sparking a political storm that could reshape the landscape of American governance. What began as a seemingly strong alliance during the 2024 U.S. presidential election has now deteriorated into a public feud, with Elon Musk announcing his intention to form a new political party aimed at representing the interests of America's middle class. This bold move by Musk, a visionary known for revolutionizing industries like electric vehicles and space exploration, has sent shockwaves through the political and business worlds, raising questions about the future of American politics and the potential impact of this rift on both domestic and global

The alliance between Donald Trump and Elon Musk was once a powerful one. During the 2024 presidential election. Musk emerged as one of Trump's most significant financial backers, pouring approximately \$300 million into his campaign through various political action committees, most notably the America PAC, which Musk founded to support Trump and other Republican candidates. This substantial financial support was widely credited with helping Trump secure a victory in the election, marking his return to the White House for a second term. Musk's contributions were not just financial; his public endorsements and use of his massive social media platform, X, amplified Trump's message, reaching millions of voters and shaping public opinion in key battleground states.

The relationship between two of the most influentially appeared that the partnership between Trump and Musk would usher in a new era of government reform. The collaboration was hailed by some as a bold experiment, combining Trump's political influence with Musk's business acumen and technological vision.

However, the honeymoon period was short-lived. By May 2025, just 130 days after his appointment, Musk stepped down from his role at DOGE, citing frustrations with the pace of reform and the direction of Trump's policies. The breaking point came when Musk publicly opposed Trump's "One Big Beautiful Bill Act," a massive domestic policy bill that bundled several of Trump's key initiatives. The bill included significant tax cuts, such as removing taxes on Social Security income, tips, and overtime pay, which Trump touted as relief for the middle class. However, the Congressional Budget Office estimated that while the bill would deliver \$3.7 trillion in tax cuts, it would also increase the national debt by \$2.4 trillion over a decade and necessitate a \$4 trillion increase in the debt ceiling. Musk, a self-proclaimed fiscal conservative, slammed the bill as "exaggerated" and "pork-filled," calling it a "grotesque insult" to fiscal

responsibility. Musk's criticism did not sit well with Trump. The former president took to his social media platform, Truth Social, to lash out at Musk, accusing him of being upset over the abrupt cancellation of electric vehicle (EV) mandates, a policy shift that could cost Tesla billions in potential revenue. Trump went further, threatening to terminate federal contracts and subsidies with Musk's companies, including Tesla and SpaceX, which rely heavily on government partnerships for projects like space exploration and satellite launches. In response, Musk fired back on X, claiming that Trump would not have won the election without his financial and public support, and that Democrats would have retained control of both the House and Senate without his intervention.

The world is watching as this saga unfolds. Will Musk's America Party gain traction and challenge the dominance of the two-party system? Will Trump's threats against Musk's businesses materialize, and if so, how will Musk respond? And how will this feud affect the millions of Americans who feel caught in the middle, hoping for leadership that addresses their needs and aspirations? # Ukraine's drone gambit: Striking Russia's heartland amid stalled peace talks

n the eve of the second round of peace talks between Ukraine and Russia in Istanbul on June 2, 2025, Ukraine executed an audacious drone attack, codenamed "Operation Spiderweb," targeting Russian airfields deep within the country's heartland. This meticulously planned assault, involving 117 drones smuggled into Russia and launched from trucks, struck at least five air bases, including those in the Irkutsk region of Siberia and the Murmansk region in Russia's Far North. The operation, which Ukrainian President Volodymyr Zelenskyy described as a year-and-a-half in the making, aimed to disrupt Russia's strategic bomber fleet, with Ukraine's Security Service (SBU) claiming damage to 41 aircraft— 34% of Russia's strategic cruise missile carriers—at an estimated cost of \$7 billion to the Kremlin. The timing, scale, and depth of the attack have raised critical questions about its implications for ongoing peace negotiations, Russia's investigative priorities, and the political ramifications for President Vladimir Putin. As the war enters its fourth year, this bold Ukrainian maneuver underscores the escalating asymmetry of the conflict and the challenges of achieving a diplomatic resolution.

The Istanbul talks, mediated by Turkish Foreign Minister Hakan Fidan, were the second attempt since May 2025 to broker a ceasefire between Ukraine and Russia, following the first direct negotiations since the early months of Russia's full-scale invasion in February 2022. However, the discussions, which lasted barely an hour, vielded little progress beyond an agreement to exchange 1,000 prisoners of war and the remains of 12,000 fallen soldiers. The Ukrainian delegation, led by Defence Minister Rustem Umerov, and the Russian delegation, headed by Vladimir Medinsky, a former Cultural Minister, lacked the authority to make binding decisions, serving instead to narrow differences for eventual presentation to Zelenskyy and Putin. The absence of a ceasefire agreement reflects deep-seated disagreements, with Ukraine insisting on a 30-day unconditional ceasefire as a prerequisite for talks, backed by European allies, while Russia demands a roadmap addressing its maximalist goals, including Ukrainian neutrality, protection of Russian-speaking populations, and retention of occupied territories, including Crimea and four annexed oblasts. The drone attack, occurring just hours before the talks, was perceived by some as a deliberate signal from Kyiv to demonstrate its military resilience and influence the negotiations, though it may have hardened Russia's stance.

assault, which targeted airfields thousands of miles from the front lines, marked a significant escalation in its long-range strike capabilities. Unlike previous attacks, which focused on closer targets like oil refineries or border regions, this operation struck deep into Siberia's Irkutsk region and other distant areas, exposing vulnerabilities in Russia's air defenses. The method of deployment drones concealed in wooden mobile homes attached to long-haul trucks and remotely launched—was unprecedented, highlighting Ukraine's innovation in drone warfare. The SBU described the targets as "completely legitimate," emphasizing that the affected aircraft were used to launch cruise missiles against Ukrainian cities. Videos verified by The New York Times showed strikes at Olenya Air Base in Murmansk and Belaya Air Base in Irkutsk, with at least five aircraft, including four strategic bombers, damaged. Russian military bloggers and hawkish commentators, while downplaying the extent of the damage, expressed outrage at the failure to protect critical assets, with some likening the attack to Russia's "Pearl Harbor." Russia's Defense Ministry confirmed fires at several airfields but claimed minimal impact, asserting that additional attacks on three other bases were thwarted and several arrests

Russia's investigation into the drone strikes is likely to focus on two critical angles, as noted by Nandan Unnikrishnan, a Distinguished Fellow at the Observer Research Foundation. First, Moscow will assess whether the attack targeted nuclear-related facilities, such as strategic bombers or storage sites, which could escalate the conflict given Russia's restraint in deploying nuclear weapons absent NATO's direct involvement. The targeting of airfields hosting nuclear-capable assets would be a serious concern. prompting scrutiny of Ukraine's intentions and capabilities. Second, Russia will investigate the role of external support, particularly the United States, as drones require sophisticated navigation systems, potentially reliant on U.S. satellite infrastructure. This raises questions about whether the attack was a unilateral Ukrainian operation to gain leverage in negotiations or a NATO-backed effort to provoke a broader escalation. The Kremlin's suspicion of Western involvement is heightened by previous Ukrainian strikes, such as the attempted drone attack on Moscow during Russia's Victory Day parade on May 9, 2025, attended by over 20 foreign leaders. The depth and coordination of the June attack suggest a level of technological and logistical sophistication that Russia will scrutinize both military and political challenges, though its impact on his domestic standing appears limited. Militarily, the loss of strategic bombers, even if exaggerated by Ukrainian claims, could constrain Russia's ability to sustain large-scale cruise missile strikes on Ukraine while maintaining nuclear deterrence patrols against NATO and Japan, as noted by Justin Bronk of the Royal United Services Institute. The attack's penetration of Russia's vast territory undermines the narrative of invulnerability, potentially prompting a reevaluation of air defense priorities. However, politically, Putin's grip on power remains unshaken. Unnikrishnan argues that public support for Putin is "way too solid" for the attack to significantly alter his position, despite criticism from hardline bloggers calling for retribution. Putin's response, articulated through spokesman Dmitry Peskov, framed the war as "existential" for Russia's national interests, suggesting that the attack strengthens Moscow's resolve to pursue its objectives. Putin's subsequent warning to U.S. President Donald Trump about retaliatory measures underscores his intent to maintain a hardline stance, even as he engages in peace talks to appease international pressure.

The drone attack complicates an already fragile peace process. Ukraine's strategy, as articulated by Zelenskyy, aims to demonstrate that continuing the war carries significant risks for Moscow, potentially forcing Russia to negotiate in good faith. The operation's symbolic impact—proving Ukraine's ability to strike deep into Russia—bolsters morale in Kyiv and signals to Western allies that Ukraine remains a formidable partner despite battlefield setbacks. However, the timing, just before the Istanbul talks, may have undermined diplomatic progress. Russia's delegation, led by Medinsky, presented maximalist demands, including territorial concessions and Ukrainian demilitarization, which Kyiv rejected as capitulation. The Kremlin's insistence on addressing "root causes," such as Ukraine's NATO aspirations, contrasts with Kyiv's call for an immediate ceasefire to regroup and replenish resources. The U.S., under President Trump, has exerted pressure on both sides to reach a deal, with Trump expressing frustration at the lack of progress and threatening sanctions on Russia. Yet, his simultaneous criticism of Zelenskyy for provocative rhetoric suggests a shift from the Biden administration's unequivocal support for Ukraine, complicating Kyiv's position.

The broader context of escalating tit-fortat attacks further dims prospects for peace. Russia's response to the drone strikes included a massive aerial assault on Ukraine,

The scale and audacity of Ukraine's drone

For President Putin, the drone attack poses launching over 470 drones and missiles in a single day, described by Ukrainian officials as the war's largest air attack. This barrage killed at least 12 people, including three children in Zhytomyr, and targeted a training unit in Dnipropetrovsk, wounding dozens. Zelenskyy condemned the "silence of America" and called for tighter sanctions to deprive Russia of resources, while European leaders, including Germany's Friedrich Merz and the UK's Keir Starmer, urged stronger measures against Moscow. The intensification of Russian ground offensives in Donetsk and the presence of North Korean troops in Kursk further highlight Russia's strategic advantage, reducing its incentive for a prolonged ceasefire. Ukraine's Kursk incursion in August 2024, aimed at gaining leverage for territorial exchanges, disrupted earlier talks in Doha, and the recent drone attack may similarly derail momentum in Istanbul.

> The implications for peace talks hinge on whether Ukraine's demonstration of strength can shift Russia's calculus. Analysts like Mick Ryan of the Lowy Institute argue that while the attack showcases Ukraine's evolving drone capabilities, it is unlikely to alter Putin's determination to achieve his war aims. Russia's slow but steady advances on the ground, coupled with Ukraine's exhaustion and dwindling resources, give Moscow a perceived upper hand. The negotiations, still at a preliminary stage with second-level officials, face the challenge of reconciling irreconcilable positions. Ukraine's push for a 30-day ceasefire, supported by European allies, aims to create space for diplomacy, but Russia's insistence on a comprehensive resolution tied to its geopolitical demands suggests a prolonged stalemate. The drone attack, while a tactical success for Ukraine, risks reinforcing Russia's narrative of Western-backed aggression, potentially escalating retaliatory strikes and further entrenching the conflict.

> Ukraine's drone assault on Russian airfields represents a bold escalation, exposing Moscow's vulnerabilities and strengthening Kyiv's negotiating position symbolically. However, it has deepened the divide in peace talks, with Russia's investigation likely focusing on NATO's role and the protection of nuclear assets. For Putin, the attack is a military setback but not a political threat, given his domestic support. As both sides exchange devastating blows, the path to a ceasefire remains elusive, with U.S.-led mediation struggling to bridge fundamental disagreements. The war's trajectory, shaped by Ukraine's innovative warfare and Russia's relentless aggression, underscores the complexity of achieving a just and lasting peace. # How does the respiratory system work?

The respiratory system allows air to reach the lungs, from which oxygen enters the blood and circulates to all body cells. This system also removes waste gases from the body and helps prevent disease due to particulate matter.

The respiratory system helps prevent the intake of harmful particles— such as dust, fumes, and mist — through coughing, sneezing, or swallow-

The respiratory system is made up of the nose, sinuses, lungs, diaphragm and other organs and structures.

This article examines the various parts of the respiratory system, some respiratory conditions, and how a person breathes. It also looks at lung function and the processes of inhalation and ex-

Parts of the respiratory system

The respiratory system is divided into an upper and lower respiratory tract. The upper tract com-

• the diaphragm The sections below will look at each part of the respiratory system in more detail

Nose and nasal cavity

Forming the main external opening of the respiratory system, the nose protects the anterior portion of the nasal cavity. The nose is also unique, as it is the only part of the system that is externally visible.

The nasal cavity is the uppermost part of the respiratory system, divided into two by the nasal septum. It is the best entrance for outside air, as hairs and mucus line the inside wall and operate

Within this hollow space, the air is warmed,



moisturized, and filtered before reaching the lungs. The nose prevents dust, mold, and other contaminants from reaching the lungs.

The paranasal (meaning around the nose) sinuses are four paired, hollow spaces above and below the eyes.

Connected to the nose by small openings, they regulate the temperature and humidity of inhaled air. These cavities also give tone to the voice. Sinuses develop after birth and reach their final size around the age of 20.

The pharvnx, or throat, is a versatile muscular tube, shaped like a funnel, that delivers air from the mouth and nose to the trachea, or windpipe. It also connects the nasal and oral cavities with the larynx and esophagus.

The pharynx is key to the respiratory and digestive systems. It allows inhaled air to pass from the nasal cavity to the larvnx, trachea, and lungs.

A section of the pharynx called the nasopharynx hosts the epiglottis. This keeps the passage to the esophagus covered, preventing air from entering the digestive system.

The larynx has a dual function in the respiratory

system: as an air canal to the lungs (while stopping food and drink from blocking the airway) and as the "voice box" (which contains vocal cords for

The larynx is a 2-inch tube made up of nine cartilage pieces. It connects the pharynx with the trachea and is held together by ligaments, membranes, and fibrous tissue.

#### Lungs

The lungs are the primary organs of the respiratory system, as they perform a vital role in breathing: gas exchange.

The air that a person breathes in through the nose and mouth contains oxygen and other gases. Oxygen enters the lungs, then the bloodstream, allowing the body to function normally. However, the lungs also take the carbon dioxide from the blood and release it into the air when a person breathes out.

The grape-like sacs called alveoli in each lung allow the exchange of oxygen and carbon dioxide to take place.

Trachea

The trachea runs down the neck and upper chest. It is a wide, hollow tube that connects the larvnx to the bronchi, or airways, of the lungs.

Its most vital function is to enable airflow to and

#### Diaphragm

The diaphragm is a dome-shaped sheet of muscle located below the lungs. It separates the chest from the abdomen.

The diaphragm operates as the major muscle of respiration and aids breathing. The parasympathetic nervous system regulates the contraction and relaxation of the diaphragm and intercostal muscles.

How does the respiratory system work?

There are two phases of breathing: in and out. As a person inhales, the diaphragm contracts and moves downward. The space left in the chest allows the lungs to expand. Muscles in the ribs also help enlarge the chest cavity, pulling the rib cage upward and outward.

Once the lungs expand, air moves in through the nose and mouth. The air travels down the trachea and into the lungs, allowing a person to

The exchange of oxygen and carbon dioxide occurs before exhalation. When a person exhales, the diaphragm relaxes, the lungs recoil, and the air moves out of the lungs

#### Respiratory system diseases

Due to the complex nature of the respiratory system, many health conditions can affect it. The following sections will look at some respiratory conditions in more detail.

#### Asthma

Asthma is a chronic, long-term inflammatory condition that affects the airways. Symptoms are variable and recurring, including coughing, chest tightness, and shortness of breath.

#### Chronic obstructive pulmonary disease

Chronic obstructive pulmonary disease (COPD) is a condition that progresses with time and makes it hard to breathe.

People who smoke heavily may experience inflammation of the airways, which makes it difficult for the lungs to inhale and exhale enough air. Symptoms of COPD include breathlessness, a persistent cough, and frequent chest infections

A symptom of bronchitis is an inflammation of the lung airways. When the airways are inflamed, they produce too much mucus, which causes coughing, wheezing, and fatigue. The two main types of bronchitis are acute and chronic. Chronic bronchitis is a form of COPD.

A doctor may treat bronchitis with antibiotics and recommend that a person drinks plenty of fluids to dilute the thick mucus in the airways.

#### **Sinusitis**

Sinusitis can cause inflammation of the air cavities within the nose and lead to facial pain, headache, and a blocked or runny nose. It usually develops due to an infection and is treatable with nasal sprays, fluids, pain relievers, and deconges-

#### Pneumonia

Bacteria, viruses, and fungi can all cause pneumonia. Symptoms include a high temperature, a cough, difficulty breathing, and chest pain.

A doctor will usually treat pneumonia with antibiotics. They may also recommend hospitalization for serious cases.

#### Lung cancer

Lung cancer begins in the lungs but may spread to the lymph nodes or other areas of the body. There are two types of lung cancer: small cell and non-small cell lung cancer. They require different treatments, which will depend on how far the condition has progressed.

Lung cancer is dangerous because many people do not have any symptoms until the condition is in an advanced stage.

#### Summary

On average, people breathe 10-20 times per minute. This means that having an efficient respiratory system is essential to quality of life.

If the lungs do not exchange oxygen and carbon dioxide efficiently, it can lead to health issues such as shortness of breath and fatigue.

The theme of this year's World Food Safety Day—'Food Safety: Science in Action'—highlights the vital role of scientific knowledge in ensuring safe food for all. Against this backdrop, this commentary explores how Artificial Intelligence (AI) can become a powerful tool to strengthen food safety systems globally and address the implementation challenges associated with such apparatus. Conventional food safety systems are struggling to keep up with sophisticated, globalised food systems and the emerging risks they present. While surveillance gaps continue to widen, AI-enabled technology is driving new methodologies in detecting, tracing, and preventing contam-

#### AI in Food Safety

Comprehending the role of AI in enhancing food safety requires an examination of how food moves from farms to our tables. The food supply chain consists of interconnected stages-production, processing, distribution, consumption, and disposal—with each stage dependent on the smooth functioning of the others. Multiple stakeholders participate in this chain, including farmers, seed producers, merchants, transporters, wholesalers, retailers, financial institutions, and insurance providers.

As food moves systematically through the supply chain, it generates vast amounts of data at each stage. Forces detain Greta Thunberg, other activists

JERUSALEM, June 9: Israeli forces seized a Gaza-bound aid boat and detained Greta Thunberg and other activists who were on board early Monday, enforcing a longstanding blockade of the Palestinian territory that has been tightened during the war with Hamas.

The activists had set out to protest Israel's ongoing military campaign in the Gaza Strip, which is among the deadliest and most destructive since World War II, and its restrictions on the entry of humanitarian aid, both of which have put the territory of some 2 million Palestinians at risk of famine.

The Freedom Flotilla Coalition, which had organized the voyage, said the activists were "kidnapped by Israeli forces" while trying to deliver desperately needed aid to the territory.

The ship was unlawfully boarded, its unarmed civilian crew abducted, and its life-saving cargo — including baby formula, food and medical supplies — confiscated," it said in a statement. It said the ship was seized in international waters some 200 kilometres from

Along the way, it had stopped on Thursday to rescue four migrants who had jumped overboard to avoid being detained by the Libyan coast

"I urge all my friends, family and comrades to put pressure on the Swedish government to release me and the others as soon as possible," Thunberg

## Italians head to polls in referendum on citizenship, labour, but vote risks sinking on low turnout

ROME, June 9: Italians headed to the polls Monday on the second and final day of referendums that would make it easier for children born in Italy to foreigners to obtain citizenship, and on providing more job protections.

But partial data showed a low turnout, well below the required 50 per cent plus one threshold, risking to

Campaigners for the change in the citizenship law say it will help second-generation Italians born in the country to non-European Union parents better integrate into a culture they already see as theirs.

Partial data from Italy's Interior Ministry published at 2100 GMT on Sunday showed that national turnout stood at 22.7 per cent, just over half of the 41 per cent registered at the same time of the day in the latest comparable referendum held in 2011. The polling stations close later Monday at 1300 GMT.

The new rules, if passed, could affect about 2.5 million foreign nationals who still struggle to be recognised as citizens.

The measures were proposed by Italy's main union and left-wing opposition parties. Premier Giorgia Meloni showed up at the polls on Sunday evening but didn't cast a ballot — an action widely criticised by the left as antidemocratic, since it won't contribute to reaching the necessary threshold to make the vote

"While some members of her ruling coalition have openly called for abstention, Meloni has opted for a more subtle approach," said analyst Wolfango Piccoli of the Teneo consultancy based in London. "It's yet another example of her trademark fence-sitting.

Supporters say this reform would bring Italy's citizenship law in line with many other European countries, promoting greater social integration for long-term residents.

It would also allow faster access to civil and political rights, such as the right to vote, eligibility for public employment and freedom of movement within the EU.

"The real drama is that neither people who will vote 'yes' nor those who intend to vote 'no' or abstain have an idea of what (an) ordeal children born from foreigners have to face in this country to obtain a residence permit," said Selam Tesfaye, an activist and campaigner with the Milan-based human rights group Il Cantiere.

Activists and opposition parties also denounced the lack of public debate on the measures, accusing the governing centre-right coalition of trying to dampen interest in sensitive issues that directly impact immigrants and workers.

In May, Italy's AGCOM communications authority lodged a complaint against RAI state television and other broadcasters over a lack of adequate and bal-

Opinion polls published in mid-May showed that only 46 per cent of Italians were aware of the issues driving the referendums. Turnout projections were even weaker for a vote scheduled for the first weekend of Italy's school holidays, at around 35 per cent of around 50 million electors, well below the required

"Many believe that the referendum institution should be reviewed in light of the high levels of abstention (that) emerged in recent elections and the turnout threshold should be lowered," said Lorenzo Pregliasco, political analyst and pollster at YouTrend.

Some analysts note, however, that the center-left opposition could claim a victory even if the referendum fails on condition that the turnout surpasses the 12.3 million voters who backed the winning centre-right coalition in the 2022 general election. (AP)

TOKYO, June 9: An explosion at a storage site for unexploded ordnances at a US military base on Japan's southern island of Okinawa injured four Japanese soldiers, though the injuries are not life threatening, officials said on Monday.

The four soldiers sustained finger injuries while working at a facility that belongs to Okinawa prefecture and temporarily stores unexploded ordnance, mostly from wartime and found on the island, local officials said. One of the harshest battles of World War II was fought on Okinawa.

**BEIJING, June 9:** China's exports to the United States fell 35 per cent in May from a year earlier, new customs data show, adding to pressure on the world's second largest economy as a new round of trade talks with Washington was due to start later Monday in London.

China's total exports rose 4.8 per cent last month, slowing from an 8.1 per cent year-on-year increase in April. Imports declined 3.4 per cent year-on-year, leaving a trade surplus of USD 103.2 billion.

to the United States in May, compared with USD 44 billion a year earlier. Its imports from the US fell to USD 10.8 billion, the report said.

Still, exports to Southeast Asia and the European Union remained robust, growing 14.8 per cent and 12 per cent, year-on-year.

Exports to Thailand, Vietnam and Indonesia were sharply higher, and exports to Germany jumped more than 12 per cent. "The acceleration of exports to

other economies has helped China's exports to remain relatively buoyant in the face of the trade war," Lynne Song of ING Economics said in a commentary.

Many businesses had rushed orders earlier in the year to try to beat higher tariffs. Once new import duties took effect, shipments slowed. Exports will likely rebound somewhat in June thanks to a 90-day suspension of most of the tariffs China and the US imposed on each other in their escalating trade war, Zichun Huang of Capital Economics said in a report.

"But with tariffs likely to remain elevated and Chinese manufacturers facing broader constraints on their ability to sustain rapid gains in global market share, we think export growth will slow further by yearend," Huang said.

MARAAT AL-NUMAN (SYRIA), June 9: A contractor digging into the earth where the rubble of a destroyed house had been cleared away in northern Syria stumbled across a surprise: the remains of an underground Byzantine tomb complex be-

lieved to be more than 1,500 years old. The discovery emerged last month in the town of Maarat al-Numan in Idlib province, which is strategically located on the route between the cities of Aleppo and Damascus.

# MLA Rotom Tebin appeals to CS for intervention over illegal bombing and encroachment in Dollungmukh

HT Bureau NAMSAI, June 9: In a significant development underscoring the escalating tensions and deep-seated concerns of residents in the Dollungmukh Sub-Division, 25 Raga (ST) Assembly Constituency MLA Rotom Tebin, along with a delegation of local panchayat leaders, senior citizens, and concerned community representatives, submitted a memorandum to Shri Manish Gupta, Chief Secretary of Arunachal Pradesh, during his two-day official visit to Dollung-

The Chief Secretary's visit was primarily to assess the final stages of work on the Lower Subansiri Hydroelectric Project (LSHP), a 2000 MW mega-infrastructure initiative nearing its commissioning phase. However, the visit also served as a critical opportunity for local stakeholders to raise pressing grievances that have been causing widespread anxiety and discontent among

During a serious and focused interaction, MLA Tebin led the delegation in presenting a comprehensive memorandum that drew attention to two particularly grave issues — ongoing illegal bombing exercises by the Indian Air Force (IAF) at the Dolum firing range, and persistent border encroachment activities allegedly being carried out by the Forest Department of neighboring

The memorandum, submitted on behalf of the people of Dollungmukh, ex-

use of the Dolum firing range by the IAF despite the expiration of the lease agreement on January 31, 2025. The lease had been conditionally extended earlier, but locals allege that further activities are now being carried out without proper authorization, violating both the spirit and the letter of existing understandings.

Terming the ongoing air force bombing activities as "illegal and hazardous," MLA Tebin emphasized that such exercises pose a direct threat to the lives and property of villagers. The proximity of inhabited areas to the bombing range, particularly with three out of six villages in the subdivision falling partially within the affected zone, has heightened fears of accidental casualties and longterm environmental damage.

"This is not merely a matter of military exercises — it is a humanitarian concern," stated MLA Tebin during the meeting. "Our people are living under constant fear. Every time the bombs fall, families are gripped by anxiety. If any tragedy occurs, who will shoulder the responsibility — the Indian Air Force, or the Government of Arunachal

The memorandum also pointed out a critical jurisdictional issue. It expressed strong dissatisfaction over the IAF's continued coordination with Assam authorities in matters concerning the Dolum firing range, despite the signing of a historic Memorandum of Understanding (MoU) on April 20, 2023, between the Governments of Assam and Arunachal Pradesh, in the presence of Union Home Minister Amit Shah. The MoU clearly demarcated administrative boundaries, affirming that all six villages under the Dollungmukh Sub-Divi-

territorial jurisdiction. "It is not only a matter of legality but of respect for federal arrangements," the memorandum noted, urging that any decisions regarding the area be taken jointly by the Arunachal Pradesh government, Government of India, and the

Such acts have been described as provocations that undermine peace and cooperative federalism.

The delegation submitted three key demands to the Chief Secretary including immediate and unconditional cessation of all illegal bombing operations by the Indian Air Force at the Dolum firing range, until legal and safety procedures are fully re-examined and followed, transparent and accountable dialogue with the IAF regarding any future lease extensions, ensuring that public safety and community concerns are addressed beforehand and formal communication with the Government of Assam, urging it to instruct its forest department to cations and terms laid out in the 2023

In response, Chief Secretary Manish Gupta acknowledged the seriousness of the issues raised and assured the delegation that the government would examine the memorandum with the utmost urgency and sincerity. The people now look to the state leadership for tangible actions that will restore a sense of security, legal clarity, and governance in this strategically important frontier region.

NAMSAI, June 9: The 3rd District Task Force on Immunization (DTFI) Meeting for 2025-26, coupled with an Orientation Workshop on the Stop Diarrhoea Campaign, a reorientation session on Rogi Kalyan Samiti (RKS)/Jan Arogya Samiti (JAS), and an extensive review of various National Health Mission (NHM) and vertical programme activities, was successfully conducted on Monday at the District Secretariat in Namsai.

The meeting was chaired by CR Khampa, Deputy Commissioner of Namsai, who emphasized the importance of integrated and sustained efforts across departments to strengthen the district's public health system. In his address, the DC reiterated the need for accountability, datadriven action, and community-level health outreach to improve health outcomes.

A key agenda of the meeting was the comprehensive review of major health indicators, which included Antenatal Care (ANC) registration rates, institutional delivery rates, distribution of Iron and Folic Acid (IFA) supplements to pregnant women and children, Bacillus Calmette-Guérin (BCG) vaccination coverage, and daily Outpatient Department (OPD) reporting across health facilities in the district. Officials discussed the current gaps, achievements, and the necessary interventions required to achieve the district's annual health targets.

As part of the ongoing Stop Diarrhoea Campaign, an orientation session was conducted focusing on capacity building and preventive strategies. The campaign aims to reduce morbidity and mortality caused by diarrhoeal diseases, particularly among children under five. The orientation paid special attention to the setup of Zinc-ORS Corners in all health institutions, which are expected to play a crucial role in managing and controlling diarrhoea cases during peak seasons. Additionally, the meeting stressed the importance of Information, Education, and Communication (IEC) activities to raise public awareness regarding hygiene,

sanitation, and the timely use of ORS and Zinc. Participants were also briefed on the functioning, roles, and responsibilities of Rogi

Kalyan Samiti (RKS) and Jan Arogya Samiti (JAS), with an emphasis on ensuring participatory governance and decentralization in healthcare service delivery. The reorientation aimed to re-energize the functioning of these samitis in aligning with the core goals of responsive and accountable health management at the facility level. The session also featured a detailed review of the status of Non-Communicable Disease (NCD) programmes and the Ayushman Bharat Health Account (ABHA) registrations and service delivery status. District programme officers presented data on screening, diagnosis, referral, and follow-up mechanisms related to prevalent NCDs such as hypertension, diabetes, and common cancers. The ABHA component was reviewed to ensure that digital health records and services are efficiently integrated and accessible to the citizens.

Towards the conclusion of the meeting, officials were urged to gear up preparedness levels across all health facilities in light of the possible resurgence of COVID-19 or any other public health emergency. Emphasis was laid on adequate stockpiling of medicines, protective equipment, and other emergency resources, as well as reactivating district-level COVID-19 response teams as a precautionary measure.

The meeting witnessed the active participation of District Medical Officer (DMO), District Reproductive and Child Health Officer (DRCHO), District Programme Officer (IDSP/NCD), Medical Superintendent (MS), Medical Officers-in-Charge (MO/ICs), Child Development Project Officer (CDPO), Health and Wellness Officers (HWOs), and a representative from the United Nations Development Programme (UNDP).

The convergence of multiple programmes in a single platform underscored the district administration's commitment to holistic health system strengthening and inter-departmental coordination. The collaborative and consultative nature of the session is expected to translate into more responsive and inclusive health service delivery for the people of Namsai.

## Fisheries Secretary conducts extensive visit to Sangdupota Circle, interacts with fish farmers

NAMSAI, June 9: In a proactive move to understand the grassroots realities of fish farming in Arunachal Pradesh, Secretary of Fisheries, Tayi Kaye, undertook a detailed inspection visit to the Sangdupota circle on Sunday. This marks his first official field visit to the region after assuming charge of the Fisheries Department and highlights his commitment to promoting sustainable aquaculture and addressing the challenges faced

# Four dead after falling off local trains near Mumbai Railway mulls automatic doors

MUMBAI, June 9: Four commuters died and nine were injured after falling off two overcrowded local trains in Maharashtra's Thane district during the morning rush hour on Monday, officials said.

The incident occurred near Mumbra railway station when the trains were passing each other on a steep turn.

Chief Public Relations Officer of the Central Railway, Swapnil Dhanraj Nila, said the victims were travelling on the footboard of the two trains, one travelling towards Kasara and another travelling towards Chhatrapati Shivaji Maharaj Terminus Mumbai

The commuters were hanging from the doors of the crowded trains and their backpacks brushed against each other as the trains passed in opposite directions, police

The guard of a train going towards Kasara alerted the railway authorities about the incident. Those who fell off the trains were rushed to nearby hospitals, where four were declared dead on arrival, police said.

The Railway Board has decided that all new suburban trains in Mumbai will have automatic door closing facility and the existing ones will also be retrofitted to have the mechanism, an official said.

Around 75 lakh commuters travel daily by suburban trains in Mumbai, the official said. Chief Minister Devendra Fadnavis said the railway administration was probing the cause of the accident. Deputy CM Eknath Shinde said steps were being taken to help

the victims and their families. The incident highlights the need to pay serious attention to overcrowding and passenger safety in the suburban railway system, Deputy CM Ajit Pawar said.



The deceased were identified as Ketan Saroj, Rahul Gupta, Mayur Shah and Thane Government Railway Police (GRP) constable Vicky Mukhyad.

Nila said an injured person informed that commuters fell from local trains travelling in opposite directions after some of those standing on the footboards collided with

Responding to concerns over inadequate facilities for Mumbai commuters despite their significant contribution to the Railways' revenue, Shinde said, "A high-powered Railways committee will investigate the matter. The truth will come out, and if

anyone is found guilty, strict action will be

Congress leader Rahul Gandhi expressed his condolences to the families of the deceased and wished the injured a speedy re-

"Indian Railways is the backbone of the lives of crores of people, but today it has become a symbol of insecurity, congestion and chaos," Gandhi posted on X.

"11 years of Modi government = no accountability, no change, only propaganda. The government has stopped talking about 2025 and is now selling dreams of 2047. Who will see what the country is facing today?" he added.

NCP (SP) president Sharad Pawar said the Central Railway should implement measures like installing automatic doors in suburban trains in view of overcrowding.

"The Central Railway should increase local trains on important routes. Necessary measures should be implemented immediately for the safety of passengers," he posted on X. "It is well known that the increased

crowding in local trains is the main reason. After such accidents, it is not right to blame the passengers for their deaths," Pawar said. Shiv Sena (UBT) MP Priyanka Chaturvedi said, "The Railways should just shut up about what they are planning to do because none of them have been delivered as far as Mumbai local trains are con-

"These are not deaths by overcrowding but murders executed by an apathetic Reel Minister and the government of Maharashtra," Chaturvedi posted on X.

Mumbai Congress president Varsha Gaikwad said Railway Minister Ashwini Vaishnaw should own responsibility for the tragedy and resign.

MNS president Raj Thackeray said the railways infrastructure in Mumbai has colapsed due to the "hordes" of migrants.

# Tribal family ostracised for not serving liquor in last rites feast in Odisha

BARIPADA (ODISHA), June 9: A tribal couple and its three children have allegedly been ostracised by the villagers for not serving 'handia' (traditional rice beer) in the last rites feast held after the death of a 67-year-old man of the family in Odisha's Mayurbhanj district, police said on Monday

It is a practice in various tribal societies to serve 'handia' to people attending the feast organised as part of the last rites.

It is alleged that the villagers are not allowing the family members to take water from village ponds or tubewells or purchase groceries from shops.

Following a complaint lodged by the deceased man's son, a police team went to their village and asked the villagers to sort out the matter within two days or face legal action.

Ram Soren of Kesapada village under Sarat Police Station limit died on March 27 and the members of the Santhal community observed the rituals according to boycott order.

tradition. Soren's son Sangram organised a community feast a month later as per tradition on April 27.

However, he did not serve 'handia' in the feast to the villagers following which he, his wife Lachha and their children have allegedly been socially boycotted.

In a complaint lodged at Sarat Police Station, Sangram and his wife charged the villagers with denying them access to resources like water from ponds or tubewells, and even to village grocery shops.

"This is not all, the villagers also do not speak to us including my children. We are not even given work by the villagers making our life miserable," Sangram's wife Lachha Soren told reporters. The couple has three children - a 13-

year-old daughter and two sons aged 8 She claimed that a person spoke to them and has been told to pay a penalty of Rs 2,000 for violating the community's social

Asked about the reason behind not going by the tradition of serving liquor at the feast, Sangram said, "My father was a habitual alcoholic for which he died early. We have seen tribal families getting ruined due to alcoholism. Therefore, I de-

community said, "We have the tradition of offering Handia to the departed soul during funeral rituals. But there is no religious norm to serve it to people in the community feast. It all depends on the economic condition of the deceased person's family. They may serve Handia if they desire, but they cannot be forced."

# Goa minister apologises as **GMCH** doctors stage protest

**PANAJI, June 9:** Amid protests by senior doctors of the Goa Medical College and Hospital (GMCH), Goa Health Minister Vishwaiit Rane on Monday apologised for his behaviour towards a doctor whose suspension he ordered in public view and said medical services should not be disrupted.

Doctors of the Goa Medical College and Hospital (GMCH) are holding a protest against the minister, while the opposition Congress has demanded his ouster over the incident that occurred at the GMCH on Saturday.

Rane is facing severe backlash from organisations, including the Indian Medical Association (IMA) and Goa Association of Resident Doctors (GARD), which has threatened a strike.

He had lashed out at GMCH's chief medical officer (CMO), Dr Rudresh Kuttikar, for allegedly misbehaving with patients during his surprise visit to the premier facility on Saturday and ordered his sus-

Chief Minister Pramod Sawant on Sunday tried to control the damage by overruling the controversial decision. Several medical unions, including the IMA Goa, condemned his behaviour, with GARD on Sunday setting a 48-hour deadline for the minister to apologise for his conduct.

In a social media post, Rane wrote, "My heartfelt apology to Dr Kuttikar for the harsh words I spoke during my visit to GMCH."

"In the heat of the moment, my emotions overtook my expression, and I deeply regret the manner in which I addressed the situation," the minister said.

He stated that it was never his intention to undermine or disrespect the dignity of any medical professional. "Doctors hold a sacred and noble position in our society. They work tirelessly to heal, to comfort, and to save lives," he said.

The minister said while he may have erred in his communication. his intent was always to ensure that no patient is denied timely care and that the public health system remains responsive and compassionate. "However, I am equally concerned about the disruption in services at Goa Medical College, which is now impacting thousands of innocent patients," the minister

"The public is bearing the brunt of this situation, and I urge all our doctors to reflect on the larger responsibility we share for the welfare of our people," the minister said. Speaking to reporters earlier in the day, Rane had apologised for his behaviour and clarified that he never moved a file to suspend a

"I did not move the file. The issue has become a national one now," he said, adding that the matter has been churned into a different kind of scenario.

Several doctors, including members of the IMA's Goa unit, heads of departments of the GMCH, consultants, students and medical interns, staged a protest against Rane in front of the hospital in Bambolim. The protesting doctors demanded a public apology from the minister and called to end the VIP culture at the GMCH.

Doctors also demanded that news cameras and media should not be allowed inside sensitive places such as the casualty ward.

A delegation of doctors also met GMCH's dean, Dr Shivanand Bandekar. AAP leader Ramrao Wagh, who was at the protest site, said doctors are demanding a public apology from Rane.

"I have heard that he (Rane) has apologised, but doctors are not happy with that kind of apology," he said. The Congress has voiced support for the protesting doctors, demanding Rane's ouster.

Goa Pradesh Congress Committee President Amit Patkar, in a post on X, said the party has unwavering solidarity with the state's doctors.

"When those who save lives are forced to hang up their stethoscopes and take to the streets, it's not just a strike - it's a cry for dignity, justice, and safety," he said.

He said the real disease plaguing Goa is the BJP's intoxicated arrogance. "Vishwajit Rane's abuse of power has crossed all limits," he said. Patkar demanded action from Chief Minister Pramod Sawant, saving, "Sack him now or face a mass revolt." (PTI)

# World's largest container ship MSC IRINA docks at Vizhinjam port

THIRUVANANTHAPURAM, June 9: The MSC IRINA, currently the world's largest container ship by capacity, arrived at the Vizhinjam International Seaport here on Monday morning, port officials said.

The vessel, with a length of 399.9 metres and a width of 61.3 metres-- approximately four times longer than a standard FIFA-designated football pitch -- is expected to remain berthed until Tuesday.

The vessel arrived at Vizhinjam at 8 am on Monday, receiving a traditional water salute on arrival.

The arrival of the MSC IRINA marks a major step forward for the new deepwater port, which was formally inaugurated by Prime Minister Narendra Modi on May 2. With a carrying capacity of 24,346 TEUs (twenty-foot equivalent units), the massive

# Arrested Arambai Tenggol leader ex-head constable, terminated from service in March: Manipur Police



IMPHAL, June 9: Manipur Police on Monday said Ashem Kanan Singh, arrested by the CBI a day before, was a former head constable in the state police and was terminated from service in March due to involvement in criminal activities.

The CBI arrested Singh, a member of Meitei outfit Arambai Tenggol (AT), on Sunday for his alleged involvement in various criminal activities related to the 2023 Manipur violence, officials said.

In a post on X, police said, "Ashem Kanan Singh (46) was arrested by CBI in Imphal. He was a Head Constable in Manipur Police till he was terminated from service on 3rd March 2025 for his involvement in various criminal activities, including cross-border smuggling

of arms..

"He was arrested for his criminal activities which include several acts of grave nature and involvement in unlawful activities and criminal cases registered against him," police said, adding, "following his arrest, protests erupted from the evening of June 7 in the valley areas of the state with Manipur Police and security forces bringing the situation under con-

trol "

Earlier, NIA arrested three insurgents in a case related to a deadly attack on security forces that had killed two police commandos and injured several others in Moreh, Tengnoupal district, on January 17, 2024.

"One Thangminlen Mate, a member of Kuki Inpi Tengnoupal (KIT) insurgent outfit, was arrested on May 19, 2025, in Assam's Silchar. Two other accused, part of the team which executed the deadly attack, namely Kamginthang Gangte, a member of the Kuki National Army (KNA), and Hentinthang Kipgen @ Thangneo Kipgen, associated with the Village Volunteers group in Churachandpur district, were arrested by the NIA on June 6 from Manipur," police said.

Following the arrests, protests and rallies were held, and a shutdown was imposed by some civil society organisations in Tengnoupal and Moreh and Tengnoupal districts on June 6 and 7.

In its appeal, police urged the public not to support such protests in connection with the arrests of people involved in unlawful and criminal activities. (PTI)

# Youth leader's house, family members attacked by BJP for criticising Tripura CM, alleges Congress

**AGARTALA, June 9:** The Congress on Monday alleged that BJP workers have ransacked the house of its youth wing leader Sahajan Islam and beat up his family members in West Tripura district for allegedly criticising Chief Minister Manik Saha on social media.

The BJP accused the youth Congress leader of making derogatory remarks against the CM in a Facebook post and lodged an FIR against him. "Over 100 BJP and Yuva Morcha supporters armed with weapons entered the house of Sahajan at Shantipara on Sunday around 11 pm and ransacked the property. His parents were beaten up and his wife was phys-

tered the house of Sahajan at Shantipara on Sunday around 11 pm and ransacked the property. His parents were beaten up and his wife was physically assaulted," Tripura Pradesh Congress Committee (TPCC) president Asish Kumar Saha told the reporters.

Congress leader Sudip Roy Barman rushed to the spot but faced strong

protests by the Yuva Morcha supporters, another party leader said.

As the tension gripped the locality, where the chief minister's ancestral house is situated, a strong contingent of police personnel rushed to the spot and brought the situation under control.

Sahajan, a popular Youth Congress leader, in a Facebook live, lashed out at the chief minister after a vehicle carrying cattle was detained by a mob in front of the West Agartala Police Station, and a few untoward incidents occurred during Eid Al-Adha on Saturday.

"A man, who had been extracting teeth in his entire career in exchange of money, has been made the chief minister. The police have been working in favour of a particular community," the Youth Congress leader claimed, referring to the CM's medical profession.

"The attack on the political leader's house and his family members shows that mafia raj is prevailing in the state. We are under an autocratic rule. His outburst on the chief minister was a reaction to what had happened across the state during Eid on Saturday. Instead of handling the issue politically, the BJP chose the path of violence," Roy Barman told the reporters

The Congress demanded the arrest of those involved in the attack on Sahajan's residence and his family members.

The BJP on Monday strongly reacted to the Facebook post, claiming that it "defamed the chief minister" and lodged an FIR against the Congress leader.

"The Congress leader has insulted our chief minister. The way he attacked the chief minister is highly objectionable. We lodged an FIR against him and demand his arrest," Ashim Bhattacharjee, the BJP sadar (Urban) district president, said. (PTI)

IMPHAL, June 9: Protesters took out torchlight processions overnight, burnt a government building and clashed with security forces, defying prohibitory orders as Manipur continued to witness demonstrations over the arrests of a Meitei organisation leader and four others and its product of the product of t

ers, police said on Monday.

Clashes broke out between protesters and security personnel in Kwakeithel and Singjamei in Imphal West district, prompting the police to fire several rounds of tear gas shells and rubber bullets to disperse the agitators, an officer said.

The Sub-Divisional Collector (SDC) Office at Yairipok Tulihal in Imphal East district was set on fire, causing partial damage to the building, and official records were destroyed, he said.

The police have initiated an investigation to identify the culprits behind the arson, the officer said,

adding that security in the area has been heightened to prevent untoward incidents. The demonstrators created mounds of soil on roads in Sekmai and Koirengei areas in Imphal West district to prevent the movement of security forces.

They burnt tyres in the middle of the roads and clashed with security forces in Wangkhei, Yairipok and Khurai in Imphal East district, and several rounds of tear gas shells were fired to disperse them, another officer said. Burnt tyres with smoke billowing were seen on the roads in several localities across Imphal this morning.

"The situation continues to remain tense with protesters blocking several roads with bamboo sticks. Though several roadblocks, particularly on the Tiddim road that leads to the Imphal airport, have been cleared by security forces," a police officer said.



Women's groups joined the protests and held torchlight processions in Khurai, demanding the immediate formation of a government in the state, which is now under the President's rule.

Protests erupted across Manipur since Saturday over the arrests of Meitei outfit Arambai Tenggol leader Kanan Singh and four others. The Central Bureau of Investigation (CBI) said it has arrested a member of Arambai Tenggol at Imphal Airport on Sunday for his alleged involvement in various criminal activities related to Manipur violence in 2023, while the police did not disclose details of the four others

Prohibitory orders have been

clamped in Imphal West, Imphal East, Thoubal, Bishnupur and Kakching districts, while internet and mobile data services, including VSAT and VPN facilities, have been suspended in these valley areas since Saturday night after violent protests erupted across the state. Manipur Governor Ajay Kumar Bhalla on Sunday held a security review meeting with senior officials in the wake of the demonstrations across the state.

More than 260 people have been killed and thousands rendered homeless in the ethnic violence between Meiteis and Kuki-Zo groups since May 2023.

The Centre had on February 13 imposed the President's rule in the northeastern state after Chief Minister N Biren Singh resigned.

The state assembly, which has a tenure till 2027, has been put under suspended animation. (PTI)

# Sikkim landslide: Body of army man recovered, search underway for 5 others

**GANGTOK, June 9:** The body of an army man, one of the six people who went missing after a landslide hit a military camp at Chaten in north Sikkim earlier this month, was recovered on Monday in Mangan district, police said.

The deceased was identified as Sainuddhin PK, a senior officer said. The search operation is underway to trace other missing persons, Mangan Superintendent of Police (SP) Sonam Detchu Bhutia said.

"The rescue teams have recovered the body of army man Sainudheen PK, who was among the six missing personnel after the June 1 landslide at a military camp in Chaten," the SP said.

Apart from the missing persons, three army personnel had lost their lives, and four others were injured in the landslide. North Sikkim has been hit by multiple landslides triggered by heavy rain, disrupting road and telecommunication connectivity.

Around 2,000 tourists had also been stranded in north Sikkim's Lachen, Lachung and Chungthang towns due to inclement weather conditions for days before being evacuated by road and air in rescue operations earlier this week. (PTI)

The team, led by AIIMS Director Prof. (Dr.) M. Srinivas, will soon submit a detailed report to Tripura Chief Minister Dr. Manik Saha. Based on their findings, AIIMS will extend support through training initiatives aimed at improving the skills of doctors, nurses, and lab technicians in the state.

Speaking at a press conference on Monday, Dr. Srinivas said that while Tripura already has a robust healthcare system, the state government is seeking further assistance from AIIMS to upgrade and expand its services. "The state government has asked AIIMS for guidance on strengthening healthcare delivery. We will advise on improving medical infrastructure and services at

Agartala Government Medical College (AGMC) and GB Pant Hospital," he said.

The delegation, which arrived in the state on June 7, met with Chief Minister Dr. Manik Saha and held in-depth discussions on key aspects of healthcare development—including infrastructure, health education, service delivery, and super-specialty facilities. They also visited AGMC, GBP Hospital, IGM Hospital, and Tripura Medical College to review operations across various departments.

Dr. Srinivas noted that their visit included direct interactions with medical professionals, healthcare staff, and patients. "We will compile all our observations into a comprehensive report to be submitted in Delhi. Based on this, a detailed action plan will be prepared. We are committed to arranging training through AIIMS to enhance healthcare delivery in Tripura," he added.

Delegation member Dr. Ramesh Agarwal praised the state's performance on key health indicators.

"We had meaningful discussions with the Health Secretary and senior officials. Notably, Tripura's infant mortality rate is significantly lower than the national average, which reflects the strength of its healthcare system," he said.

He also highlighted the advantage of having a doctor as the state's Chief Minister in driving forward health sector reforms

Assuring continued support, Dr. Agarwal emphasized that AIIMS will actively assist in the future development of Tripura's healthcare system.

The 37-year-old actor said he thought the fandom of "Harry Potter" would disappear over time, but it didn't.



# Kim Novak to receive Golden Lion lifetime achievement award at Venice Film Fest

**NEW DELHI, June 9:** Hollywood golden era star Kim Novak, known for her roles in Alfred Hitchcock's "Vertigo" and films like "Picnic" and "Man with the Golden Arm", has been awarded the Golden Lion for Lifetime Achievement at the 82nd Venice International Film Festival, to be held from August 27 to September 6.

Novak, who is 92, is counted among the last of the great glamorous movie stars of the golden era, who was the No. 1 box office star in the world in '58, '59' and '60. Her best known role internationally is in Hitchcock's 1958 hit "Vertigo", which saw her in a double role opposite James Stewart.

Novak's other movies that are counted among classics are "Picnic" (1955,) "The Man with the Golden Arm" (1955), "Pal Joey" (1957,) and "Bell, Book and Candle" (1958).

The decision to honour Novak was made by the Board of Directors of La Biennale, upon recommendation of the Artistic Director of the Festival, Alberto Barbera, according to a press release on the festival's official website.

In a statement Novak said sha is "deaply deaply to passive the prestigious of the prestigiou

In a statement Novak said she is "deeply, deeply touched" to receive the prestigious Golden Lion Award from the "enormously respected" film festival.

"To be recognized for my body of work at this time in my life is a dream come true.

I will treasure every moment I spend in Venice. It will fill my heart with joy," she said.

Barbera called Novak one of the most beloved icons of an entire era of Hollywood

films.

"She never refrained from criticizing the studio system, choosing her roles, who she let into her private life and even her name... Independent and nonconformist, she created her own production company and went on strike to renegotiate a salary that was much lower than that of her male co-stars," Barbera said. (PTI)

# 'Ocean' is David Attenborough's greatest, most personal account yet: team behind Nat Geo documentary

**NEW DELHI, June 9:** Veteran British broadcaster David Attenborough is the world's most trusted storyteller, bringing not only passion and truth but also a rare personal connection to everything he touches -- something that is evident in his latest documentary, "Ocean with David Attenborough", say the filmmakers behind the project.

The National Geographic film, described by the team as Attenborough's most personal yet, explores the story of the ocean through the lens of a man whose life has paralleled the rise of marine science.

For directors Keith Scholey, Colin Butfield, and Toby Nowlan, and executive producer Enric Sala, one thing is clear -- the documentary wouldn't exist without the 99-year-old legend.

"Without David, there's no film. There's no two ways about it. This is a challenging subject which has to happen. David has always told people the truth and he has universal trust.

"To have a person of his stature to be able to tell this story, it is so important to get it funded in the first place, and then get it on cinema screens, and then to the world," Scholey told PTI in an interview.

The documentary special, which explores diverse and vital marine ecosystems, highlighting their connection to preventing climate disaster and the threats posed by harmful fishing practices, will premiere on National Geographic and stream on JioHotstar at 7 pm on Sunday on World Oceans Day.

As a broadcaster, Scholey said Attenborough possesses the quality of creating a passionate narration, and delivering it in an effective way that reaches the audience.

"Thank heavens we've got him, because otherwise, we couldn't make films like this, we just could not reach so many people, so he is a great gift," said Scholey, who has been collaborating and working with the British legend consistently for the past 40 years.

Butfield, who besides co-directing the documentary also wrote the book "Ocean: Earth's Last Wilderness" with Attenborough, believes the British broadcaster's life closely mirrors the ocean's journey of exploration and discovery.

"He's (Attenborough) had such a long life, he's seen so much of the natural world... When he was a boy,



we knew very little, and then as he started to dive and film and travel, we gradually uncovered more and more.

"Also the large-scale destruction of the ocean started to happen in his lifetime, and it's happening off the coast of the country he, Keith and I live in (the UK) as well as many other parts of the world. And then the recovery has happened during his lifetime in certain places. So he's got that phenomenal span of it," he added.

Nowlan, who has worked on BBC's "A Perfect Planet", and Emmy-win-

ning series "Planet Earth II" and "Our Planet", all with Attenborough, added that he brings not only authority but also unwavering enthusiasm to his work. "Even at 99 years old, when he narrates something, when he lends himself to something, he says it with such presence and passion. It's as if someone's just seen it for the first time. When David says something, it's never about the David Attenborough show. It's all about the subject, and this subject is the ocean. It's his greatest message yet, the most impor-

tant story he's ever told," he said.

And for Sala, a marine biologist and National Geographic explorer-inresidence, Attenborough is the "opposite of fake news".

"David was extremely passionate about this project and this idea that after 100 years, he's come to this big conclusion that there's nowhere more important on Earth than the ocean. And so that lent himself to being very personally involved in everything in the film. It's very unique and might be the most personal account from David on screen," he added.

According to the makers, "Ocean with David Attenborough" features never-before-seen footage of bottom trawling, the act of dragging weighted fishing nets along the Ocean floor, exposing its severe impact on the

ocean.

While Attenborough highlights these urgent threats in the documentary, he also shares inspiring global stories, showing that if the world acts now, marine life can recover faster

"It's good for us, nature, climate, and it felt like it's the right optimistic story coming at the right moment," he

Sala believes ocean recovery is possible because many protected areas worldwide have already shown miraculous signs of healing and replenishing themselves.

"Many countries have done it. India is one of the countries that agreed to protect at least 30 per cent of the ocean by 2030, (it) still has a long way to go, but the commitment is there. So, we believe it's possible because it's already happening in many places around the world," he said (PTI)

**NEW DELHI, June 9:** Tokyo Olympics silver medallist Mary Tucker feels the Shooting League of India will provide huge opportunity to develop the sport both within India and across the world.

The 23-year-old, who won silver in the mixed 10m air rifle team event during Tokyo2020, has earlier competed for the University of Kentucky and West Virginia University in the NCAA competitions, and also represented Saltendorf in Germany's Bundesliga.

Tucker said she enjoys competing in team format tournaments. "I really like leagues. I have experience with the NCAA and with the Bundesliga, and I really like being on a team and having that atmosphere of being able to have spectators rooting for an entire team. "I really like the format of having top athletes and junior athletes competing together. I feel like that's a huge opportunity to develop shooting sports both within India and all around the world," Tucker was quoted

as saying in a media release. The ISSF has allocated the window between November 20 and December 2 for the first season of the SLI, and the tournament will feature mixed team events in pistol (10m, 25m), rifle (10m, 50m 3 positions), and shotgun (Trap & Skeet).

"India is at a really high level in the sport, so it's really a good opportunity for the Indian athletes to compete with people from outside, but also it's a great opportunity for interna-tional athletes because we get to compete with the really high-level Indian shooters. (PTI)

# India gear up for Hong Kong test in Asian Cup Qualifiers

KOWLOON (HONG KONG), June 9: Seeking its first win in the tournament, the Indian football team will face another acid test when it takes on Hong Kong in a crucial AFC Asian Cup 2027 round three qualifier match here on Tuesday. As per reports in the local media, all 50,000 tickets for the match have been sold out, setting a new attendance record for Hong Kong football.

Manolo Marquez's men will have their task cut out as they face a Hong Kong side that has been revitalised under the guidance of manager Ashley Westwood, who knows a lot about Indian football and will certainly look to use his knowledge to the home side's ad-

Placed in Pot 1 for the qualifiers, India, ranked 127th, got off to a slow start with a draw against Bangladesh in March.

Meanwhile, Pot 2 side Hong Kong, ranked 153, also managed only a point in Singapore, meaning there is still nothing to separate the four sides in Group C after the first matchday.

For Hong Kong, the day will be a historic. The game is not only a crucial qualifier in their search for only a second AFC Asian Cup berth in 59 years, but also the inaugural football match at the 50,000 seater Kai Tak Stadium, part of the Kai Tak Sports Park, the largest

sports complex in Hong Kong. Featuring a retractable roof and constructed at a cost of HKD 30 billion at the site of the city's former airport, the stadium even features a flexible pitch system for



It will be India and Hong Kong's 25th meeting since their first in 1951. India lead the head-to-head with nine wins, Hong Kong have eight, while seven have been draws. However, the Blue Tigers have won only once on Hong Kong soil, a 2-1 friendly victory in 1957.

The previous meeting in 2022 is still fresh in the memories of many a 4-0 drubbing in a rain-lashed Asian Cup qualifier in Kolkata.

Defender Sandesh Jhingan, however, reiterated that it's "all about

# Saudi Arabia's WC hopes hinge on a near-impossible task against Australia

that has scored six goals through nine qualifying games needs to beat Australia by a five-goal margin to earn a direct spot at the 2026 World

Head coach Herve Renard knows it's an extremely unlikely outcome for his Saudi team, but he's urging his players to go all in Tuesday in the last game of the third round of Asian qualifying for next year's global tournament.

"The door is closed but we have to try to qualify even if it is through the window," Renard said after his team's 2-0 win over Bahrain last week kept Saudi.

"Everything must go very well for us if we are to qualify; we have to score goals."

Anything less than a five-goal deficit means Australia — in second spot in Group C — qualifies for a seventh World Cup. The last time the Socceroos lost by such a margin was in successive 6-0 defeats against Brazil and France in 2013. The Australians have scored 14 goals and conceded six through nine qualifiers.

After successive World Cup qualifications through the playoffs, Australia is close to securing a direct route but coach Tony Popovic is taking nothing for granted. "We need to do a job in Saudi,"

sition, but we need to finish it off." Popovic has only been in the job since September, stepping in after Graham Arnold resigned after collecting just one point in the group's first two qualification games.

"It's been a really intense period since I've come in but everyone's embraced what we're aiming to do," he said. "And we're very close now to achieving our goal."

Asia has been allocated eight places at the 48-team World Cup in the United States, Canada and Mexico. The top two teams in each of the three groups in this round advance directly. The third- and fourth-place teams in each group go into another round vying for two more places.

Japan was the first to qualify and will top Group C regardless of the outcome between Australia and third-place Saudi Arabia. Iran and Uzbekistan have qualified from Group A. and South Korea and Jordan have qualified from Group B.

If Saudi Arabia fails to win by five, it will join United Arab Emirates, Qatar, Indonesia and Iraq in the next stage of qualifying in October. Oman, meanwhile, is fourth in Group B, a point ahead of the Palestinian team in fifth place, with the two teams meeting in Amman on Tuesday. (AP)

# Sinner's run at French Open ends in heartbreak

PARIS, June 9: After a flawless fortnight in Paris, Jannik Sinner was on the brink of capturing his first French Open title after a dominant run on the clay courts of Roland-Garros.

Facing defending champion Carlos Alcaraz, the top-ranked Italian was firmly in control.

Sinner's deep groundstrokes, excellent service, heavy top spin, and subtle variations had worn down Alcaraz, who found himself 5-3 down and trailing 0-40 in the fourth set, and facing three match points. At that moment, it felt like the best of all possible worlds for the

23-year-old Sinner. But then the momentum swung. Alcaraz fought back, saved the first

match point when Sinner sent a forehand long. On the second, Sinner missed a return. The third ended with Alcaraz winning a short baseline exchange. Sinner had just let his chance slip away. From there, Alcaraz pro-

duced one of the greatest comeback in Roland-Garros history to win the longest final ever played on the Parisian dirt — 5 hours and 29 minutes — 4-6, 6-7 (4), 6-4, 7-6 (3), 7-6 (10-2). It's an amazing trophy, so I won't sleep tonight very well, but it's okay," Sinner said during the trophy ceremony.

There is hardly anything between the two best players in tennis at the moment, who have now combined to win the last six Grand Slam titles and appear poised to



build one of the sport's most compelling rivalries in the years ahead.

Sunday's duel delivered a match of rare intensity, filled with punishing baseline rallies, exquisite drop shots, and brilliant passing shots thrilling a packed Court Philippe-Chatrier. Reflecting on the match in his post-final press conference, Sinner tried to draw positives from a

devastating loss. "Obviously, this one hurts," he said. "There's not so much to say right now. But again, I'm happy with how we're trying to improve every day and put myself in these kinds of positions. It was a very high-level match, that's for sure. I'm happy to be part of it. But yeah, the final result hurts.'

It was a particularly tough ending for Sinner, who had not dropped a set on his way to the final, including a dominant semifinal win over three-time French Open champion Novak Djokovic. Before facing Alcaraz, Sinner had never lost a Grand Slam final, winning his first three. A victory would have made him just the fifth

man in the Open Era to win three

consecutive major titles.

"I'm pretty sure you are going to be a champion, not once but many, many times," Alcaraz told him during the trophy ceremony. "It is a privilege to share the court with you in every tournament, making history with you." Sinner, who will remain world No. 1, said he'll lean on his family and loved ones to recover from the loss. "Now it's my time to take something from the close people I have," he said. "As I've always said, before my career started, I never would've imagined finding myself in this position. It wasn't even a dream because it felt so far away — I wasn't even thinking about it." (AP)

# Germany reassesses World Cup prospects after being taught lessons by France and Portugal

last place in a mini-tournament it expected to win have dealt Germany a cold dose of reality ahead of

the 2026 World Cup. The Nations League final four in Germany was supposed to show Julian Nagelsmann's team can count itself among Europe's best, but a 2-1 loss to Portugal in Munich followed by a 2-0 defeat to France in Stuttgart instead revealed a gulf in class. It showed that tournamentwinner Portugal, beaten finalist Spain – the European champion – and a talent-packed France team are among the favorites with defending champion Argentina to win soccer's biggest prize next year.

Nagelsmann was keen to highlight the positives, noting that Germany dominated and created a host of chances in the first half against France on Sunday – but counterpart Didier Deschamps had already said what little importance he gave the third-place decider, and it was clear which side was more motivated in

Kylian Mbappé scored before the break and set up Michael Olise for the second goal as Les Bleus shook off their apathy in the second half and might have scored more.

"If you look at the first half, honestly, they were not bothered about winning. But they still won," Germany captain Joshua Kimmich said. Germany's forwards were simply not as clinical as France's.

It was a similar tale against Portugal, which rallied to beat Germany on Wednesday.

Portugal coach Roberto Martínez changed the game when he introduced substitutes Vitinha, Francisco Conceição and Nelson Semedo in the second half, and Germany needed goalkeeper Marc-André ter Stegen at his best to stop the visitors

scoring any more. Coach Nagelsmann pointed to the injury-enforced absences from his team - Jamal Musiala, Angelo Stiller, Kai Havertz, Antonio Rüdiger, Nico Schlotterbeck, Tim Klein-



dienst, Jonathan Burkardt and Yann Aurel Bisseck.

But France was also without key players like Ousmane Dembélé and Eduardo Camavinga while Deschamps had to do without three of his preferred four-man backline -William Saliba, Dayot Upamecano and Jules Koundé.

Even with a full-strength squad, it's debatable whether Germany can match its rivals' strength in depth when it comes to player develop-

ment and the quality of youngsters coming through. Nine players in Spain coach Luis de la Fuente's Nations League

squad are young enough to play at the Under-21 European Championship starting Wednesday in Slovakia. Star player Lamine Yamal is just 17 while Real Madrid's new

signing Dean Huijsen looked like he'd been playing for Spain for vears. The final was just his fourth appearance.

It's quite clear, when it comes to the depth of the squad, that we have to abandon the illusion of getting it sorted out in a year," Nagelsmann said. "We have a few positions in German soccer that are given too little attention.

Nagelsmann pointed to Spain's use of wide players in attack – like Yamal or Nico Williams – and said Germany's dearth of wing backs had been a problem for years. Kimmich has been deployed at right back when his favored position is in midfield. "Right now we're looking at what's important to see where we are in the world, what we need for the future, and to learn the right lessons from that," Nagelsmann said. "It would be nice if we could get one or two of the players up to speed by next year, but of course that's a limited window of opportunity." (AP)

NORTHAMPTON, June 9: India A lost three wickets but its lead surged to 289 against England Lions on the fourth and final day of the second unofficial Test, here on Monday.

India lost Dhruv Jurel (28), Nitish Kumar Reddy (42) and Shardul Thakur (34) in the opening session before taking the lunch break at 268 for seven at the County Ground.

Thakur fell at the stroke of lunch, cleaned up by George Hill (3/39) while Tanush Kotian (7) was at the other end.

Resuming at 163/4, Jurel hit a couple of fours off Chris Woakes in mid-wicket region to start the proceedings but he could not convert it into a big score.

Jurel perished for a 51-ball 28 with three fours. He was caught behind off an outswinger from Eddie Jack as the ball shaped

He put on 46 runs for the fifth wicket with Reddy, who missed the personal milestone of a halfcentury. Reddy had his middle stump flattened when a nip-backer from Hill found its way between his bat and pads, ending the allrounder's innings for 42 off 78 balls with four fours and a six.

Thakur (34, 47 balls, 3x4s, 2x6s) struck a four down the ground before launching consec-

# Australia's champion pedigree faces South Africa's gritty ambition in cricket's WTC final LONDON, June 9: When it comes to

Only Australia has won all four men's global trophies. It is hard to beat in finals, having won 10 of 13 across the 50-over World Cup, 20-over World Cup, Champions Trophy, and World Test Championship. And let's not get started on the women's team, which is even more dominant.

The men go for world title No. 11 from Wednesday in the WTC final against South Africa at neutral Lord's.

That ruthless focus Australia brings on the biggest stages is in marked contrast to South Africa, a perennial underachiever. The Proteas have won just one of cricket's major international titles, the Champions Trophy's inaugural predecessor in 1998, when most of the current Proteas were toddlers.

An experienced squad — average age 29 1/2 — compensates with a bond that can't be underestimated, a determination to have each other's backs.

That showed often in the 2023-25 WTC cycle as the Proteas, who used 30 players more than any other team — found a run-scorer or wicket-taker at just the right time. They won their last seven tests and were first to qualify for the final.

"We haven't been super dominant in our performances," South Africa captain Temba Bavuma said when the team qualified in De-

"We definitely haven't been clinical or ruthless when the opportunity or the situation is called upon. But I think what we've done is that we've found ways to make sure that the result is on our side.

Australia already had a veteran team when it won the 2023 final by crushing India by 209 runs at the Oval. Ten of that 11 are back. Only David Warner is missing, retired from the test format.

Medium-pace bowler Josh Hazlewood was injured and didn't play, but he's ex- Green scored three hundreds for Gloucester-



pected to replace one of the 2023 stars, Scott Boland, Hazlewood overcame a shoulder injury to spearhead Royal Challengers Bengaluru to a first Indian Premier League title

last week with 22 wickets in 12 innings. Warner's permanent replacement at opener still hasn't been settled. Sam Konstas made an audacious debut at age 19 in December against India, but Travis Head was preferred in Sri Lanka in February. They seem to be the main candidates.

Marnus Labuschagne has opened only once since 2016, and his form has dropped to the point of concern. He averaged just 28.33 in the WTC cycle and attempts last month to spark form at Glamorgan in the second tier of the English County Championship fell flat.

But he's not ready to bowl. It may not matter. Australia has four of its top 10 all-time leading wicket-takers in Nathan Lyon (553, third), Mitchell Starc (382, fourth), captain Pat Cummins (294, eighth), and Hazlewood (279, 10th).

Steve Smith is locked in at No. 4 in the batting order. He turned 36 last week and hasn't played in the top flight since March, just like Konstas, opener Usman Khawaja, Lyon, Boland, and wicketkeeper Alex Carey. But they're entrusted with the knowhow to switch on when it counts.

Smith has four hundreds in his last five tests, and passed 10,000 career runs, almost as many as the South Africans. At Lord's he

Rabada, with 327 wickets, is three away from tying Allan Donald for fourth place on South Africa's all-time list. Rabada will have the company of left-armer Marco Jansen, who took 29 wickets in six matches in the cycle.

The third seamer will be either Lungi Ngidi, who was one of eight South Africans at the IPL, or Dane Paterson, who has been nipping the ball around for Middlesex in county division two.

South Africa has confirmed Aiden Markram and Ryan Rickelton as the openers and captain Bavuma at No. 4. They played in the IPL, too.

Middle-order batter David Bedingham, South Africa's leading scorer in the cycle, proved in a warmup game against Zimbabwe that he's recovered from a broken toe sustained in April.

The finalists didn't meet in this cycle. Their last series was in January 2023, when Australia won 2-0 at home and dom-

South Africa didn't play England either. It topped the standings with eight wins from 12 tests despite forfeiting a series in New Zealand to focus on its domestic Twenty20

Australia also didn't play last-place Bangladesh. With 13 wins in 19 tests, Australia clinched its spot in the final by beating India in January. It lost only twice away from home.

Lord's, the home of cricket, holds no demons for both teams.

South Africa has lost only once there in seven post-apartheid tests. The last appearance resulted in an innings victory inside three days in 2022.

The ODIs will be held at Ranchi (November 30), Raipur (December 3) and Visakhapatnam (December 6). The five T20Is will be held at Cuttack (December 9), New Chandigarh (December 11), Dharamsala (December 14), Lucknow (December 17) and Ahmedabad (December 19).

Meanwhile Tamil Nadu Cricket Association (TNCA) has expressed its inability to host the women's ODI series against Australia starting September 14, which was supposed to serve as a pre-cursor to the 50-over World Cup starting September 30.

The first two matches of the series will now be played in Mullanpur (New Chandigarh) and the third match in

# Harry Brook celebrates England's second series win in 11 days with T20 victory over West Indies

BRISTOL (ENGLAND), June 9: England cricket captain Harry Brook praised the unity of his "group of mates" Sunday after sealing his second series win in just 11 days.

England won the second Twenty20 cricket international against West Indies by four wickets with nine balls remaining to take an insurmountable 2-0 lead in the three-match series. England scored 199-6 in 18.3 overs after West Indies lost the toss and posted 196.

Brook has won five in a row against the West Indies since taking over from Jos Buttler, including a 3-0 sweep in the ODI matches.

England didn't have it easy at Bristol, with the asking rate climbing past 11 per over at one stage as it chased down West Indies' target.

But the team stuck together to get over the line, with five of the top six batters making handy contributions before Jacob Bethell (26) and Tom Banton (30 not out) hammered 56 off just 21 deliveries between them to puncture the West Indian resistance. Buttler again top scored for England with 47 off 36 deliveries. He hit 96 when England beat West Indies by 21 runs in the series opener on Friday. It was the kind of game England was tending to lose in the difficult final days under Buttler,

whose captaincy ended with eight straight defeats across both white ball formats.

After dominating the West Indies in three oneday internationals, England was expected to receive a tougher contest from the visitors, who are higher-rated in T20s than ODIs. West Indies smashed 47 runs off the last two

overs of its innings, including 31 runs in the 19th over against spinner Adil Rashid, with his six deliveries going for 6-6-6-1-6-6. Jason Holder (29 not out) hit the first three sixes and Romario Shepherd added the last two. Skipper Shai Hope was top scorer for West In-

dies with a 38-ball 49, including four sixes. He shared an 89-run partnership for the second wicket with Johnson Charles after opener Evin Lewis was trapped lbw to Luke Wood (2-25 in four overs) on the first ball of the match. Charles hit three sixes and three fours in his 39-ball 47 before he was bowled by Wood.

West Indies had No. 2-ranked T20 bowler Akeal Hosein (1-33) back with them on Sunday. Hosein missed the first T20 as he was unable to travel to England in time because of recent changes to Britain's visa entry requirements for Trinidad and Tobago citizens. (AP)

"England's conditions test every skill - swing, seam, and temperament. If India's players adapt quickly and stay united, they can surprise England, just as we've seen in the past with new teams rising to the occasion," he said.

India are starting a new era under the leadership of Gill and Vaughan, who led England to many memorable Test wins, said appointing the 25-yearold as their Test captain was a "bold move" and it could be a defining tour for them.

"Well, it's official — Shubman Gill is the new face of Indian Test cricket, stepping up as captain for the England series. It's a bold move, trusting a young leader with a new-look team after the retirements of giants like Rohit and Kohli," Vaughan said.

"Gill has got plenty to prove, especially away from home, but he has shown (that) he has got the temperament for big moments. With Rishabh Pant as his deputy and a squad hungry to make their mark, this England tour could be the start of something special for India's next generation. Don't be surprised if these youngsters rise to the occasion," he added. (PTI)
