# Honeymoon murder: Sonam and aides presented before M'laya court

#### Sonam, aides get 8-day police custody • Brother sure she killed Raja

INDORE/SHILLONG, June 11: His sister had "100 per cent" killed her husband, Sonam Raghuvanshi's brother Govind said on Wednesday as the young woman and four men accused in the sensational "honeymoon murder" of 29-year-old Raja Raghuvanshi were sent to eight-day police custody in Shillong.

Convinced of his sister's guilt, Govind Raghuvanshi also said his family had snapped ties with her and vowed to fight a legal battle to get justice for Raja Raghuvan-

Wednesday marks one month to the day Sonam and Raja Raghuvanshi got married. The Indore couple went to Meghalaya for their honeymoon and went missing soon after.

Raja's blood stained body was found 10 days later in a deep gorge and Sonam was presumed missing till June 9, when she was nabbed from a dhaba hundreds of miles away in Uttar Pradesh.

A court in Shillong sent Sonam and her four aides to eight-day police custody. "Police sought a 10-day remand. The court



Khasi Hills district SP Vivek Syiem told PTI. The 24-year-old woman was arrested from Ghazipur, while her aides were apprehended from Indore for their alleged role in conspiring and killing Raja.

The special investigation team sought po-

wife and her boyfriend allegedly plotted to kill him in the jungles of the north-eastern state, they said.

"Sonam convinced Raja that they need to make offerings at the Kamakhya Devi Temple before consummating the marriage," a police officer who is a part of the investigation told PTI. Sonam and Raja got married in Indore on May 11 and arrived in Meghalaya via Guwahati on May 20. Both went missing on May 23 in Sohra in East Khasi Hills district, hours after checking out of a homestay at Nongriat village.

Raja's body was found in a gorge near Weisawdong Falls on June 2. A search continued for Sonam, who emerged in Uttar Pradesh's Ghazipur, around 1,200 km away, in the early hours of June 9 and surrendered as police arrested her boyfriend Raj Kushwaha and the three contract killers hired by them to murder Raja.

"Sonam coerced her husband to take her to the deep jungles of Nongriat with the belief that the hitmen she hired would have a better chance of killing (CONTD. ON PAGE-2)

# Arunachal, Assam Guvs discuss border, immigration, flood issues

GUWAHATI, June 11: In a meeting held at the Raj Bhavan in Guwahati on Wednesday, the Governor of Arunachal Pradesh, Lt General K T Parnaik (Retd), PVSM, UYSM, YSM, called on the Governor of Assam, Lakshman Prasad Acharya, to deliberate on key regional matters and foster enhanced cooperation between the two neighbouring states.

The interaction was held in a cordial and constructive atmosphere and focused on a wide array of issues concerning peace, progress, and the prosperity of the Northeast region.

According to an official statement, the Governor of Arunachal Pradesh commended the positive strides taken by the Chief Ministers of Assam and Arunachal Pradesh in addressing and resolving long-standing inter-state border disputes.

He noted that the ongoing discussions between the two governments have created a renewed sense of goodwill and trust among the people living along the border, who have historically maintained strong cultural and social ties.

Drawing from his previous ex-

perience as a Corps Commander in Tezpur, Governor Parnaik expressed concern over the persistent challenges posed by illegal immigration in the region.

Her bail plea was heard by Judicial Magistrate (First Class) Sunil Kumar through her lawyer Kumar Mukesh.

The police opposed the bail plea and argued the case's investigation was underway. Mukesh said the court after hearing the arguments of both the parties rejected her bail plea. On June 9, the court extended Malhotra's judicial custody and fixed her case's hearing on June 23. The 33-year-old YouTuber appeared before the court through video-conferencing.

Hisar Police arrested Malhotra on suspicion of espionage on May 16 and she was subsequently remanded to five days of police custody by the court.

## India-Pak conflict was about combating terrorism: External Affairs Minister Jaishankar

BRUSSELS, June 11: External Affairs Minister S Jaishankar has said the recent confrontation between India and Pakistan was not just a mere conflict between two neighbours, but it was about combating terrorism, which will eventually come back to haunt the West. Jaishankar, in an interview with the Eu-

ropean news website 'Euractiv' Wednesday, also pitched for an EU-India free trade, underlining that India - a nation of 1.4 billion – offers skilled labour and a more trustworthy economic partnership "Let me remind you of something -

there was a man named Osama bin Laden. Why did he, of all people, feel safe living for years in a Pakistani military town, right next to their equivalent of West Point?" Jaishankar, who is travelling to Europe a month after India launched Operation Sindoor in response to the Pahalgam attack, told Euractiv. He was replying to a question on the re-


#### Study of young exoplanets reveals new insights into their formation NEW DELHI, June 11: Astro-

physicists have gained new insights into how planets outside the solar system, or 'exoplanets', form by studying two "young" giant planets, "still hot from their formation", a new study says.

In one of the planets, known to orbit a sun-like star 'YSES-1', researchers detected clouds containing sand-like particles -- or silicate clouds -- the strongest one seen on an exoplanet vet, they said.

"When we looked at the smaller, farther-out companion (planet), known as YSES 1-c, we found the tell-tale signature of silicate clouds in the mid-infrared (using the James Webb Space Telescope)," co-author Evert Nasedkin, a postdoctoral fellow in Trinity College Dublin's school of physics, Ire-

The author added this is the



ture observed in an exoplanet yet" and related to its youth

"We believe this is linked to the relative youth of the planets: younger planets are slightly larger in radius, and this extended atmosphere may allow the cloud to ab-

sorb more of the light emitted by the planet," Nasedkin said. In the study published in the journal Nature, the authors wrote,

'With two exoplanets around a solar-type star, the YSES-1 system is an ideal laboratory for studying this early phase of exoplanet evolution.

The findings help understand how the 'YSES-1' solar system formed, offering further insight into the origins of our solar system, the researchers said.

"Directly imaged exoplanets -planets outside our own Solar System -- are the only exoplanets that we can truly take photos of," Nasedkin said. "These exoplanets are typically still young enough that they are still hot from their formation, and it is this warmth, seen in the thermal infrared, that we as astronomers observe," the author said. Studying the other planet 'YSES-1b', the team found that the entire planetary system is young, at 16.7 million (CONTD. ON PAGE-2)

AGARTALA, June 11: Tripura Agriculture and Farmers Welfare Minister Ratan Lal Nath on Wednesday launched a scathing attack on the Congress, accusing it of fostering a regime riddled with corruption, while hailing the BJP-led government under Prime Minister Narendra Modi for ushering in an era of holistic development.

# 'Challenging times for global trade; India will certainly cross USD 825 bn exports this fiscal'


is facing severe geo-political challenges, but India has consistently emerged as a winner in such times, and the country's exports of goods and services will certainly cross USD 825 billion in 2025-26, Commerce and Industry Minister Piyush

Despite global economic uncertainties due to the Russia-Ukraine conflict, Israel-Hamas war and the Red Sea crisis, the country's overall exports touched an all-time high of USD 825 billion against USD 778 billion in 2023-24. As per estimates of certain multi-lateral bodies, there would be a contraction in global trade, Goyal said.

"The world is going through severe geo-political challenges...So these are challenging times, but India has always emerged (as) a winner in challenging times and we did a record USD 825 billion exports in 2024-25. This year, we hope to do much better," he told PTI.

When asked if last fiscal's figures will be crossed, he said: "We will certainly be able to cross that". Apex exporters' body FIEO has projected that the country's overall

Federation of Indian Export Organisations (FIEO) President S C Ralhan has said the healthy growth may come on account of international buyers seeking to diversify their sourcing in the wake of global economic uncertainties.

In 2025-26, merchandise exports are expected to grow 12 per cent to USD 525-535 billion from USD 437 billion in 2024-25, while services exports are likely to rise by about 20 per cent year-on-year to USD 465-475 billion from USD 387 billion in the last fiscal, according to FIEO.

The major sectors that are expected to show a significant jump in the shipments this fiscal include electronics, engineering, chemicals, textile and clothing, pharma and even the agriculture sector. Free trade agreements with countries such as the UAE, Australia and European Free Trade Association (EFTA) will also help boost exports in the coming months.

The India-EFTA trade agreement is expected to come into force from October 1 this year.

Goyal also said that FTAs signed during the Congress era were not good and have impacted

They signed FTAs with countries like ASEAN, which are India's competitors; besides, they were not balanced, he said, adding that India opened more markets for those countries and "we did not get" good deals in return.

On finished goods, he said, India removed the duties but import taxes on raw materials created inverted duty issues and that hurt "us a lot", he said.

He added that now the Modi government is doing FTAs with developed countries/regions like Australia, the UK, EFTA, the EU, the UAE, Oman, Peru, and Chile.

"Here we collaborate, there is no competition...so we are doing FTAs with well thought out strategies," Goyal said.

India-EFTA signed the Trade and Economic Partnership Agreement (TEPA) on March 10, 2024. Under the pact, India has received an investment commitment of USD 100 billion in 15 years from the grouping while allowing several products such as Swiss watches, chocolates, and cut and polished diamonds at lower or zero

# Stock markets close higher on firm global trends, foreign fund inflows

MUMBAI, June 11: Benchmark Sensex closed higher by 123 points while Nifty rose for a sixth consecutive day on Wednesday following a rally in global markets amid optimism over US-China trade talks and foreign fund inflows.

In a volatile session, the 30-share BSE Sensex rose by 123.42 points or 0.15 per cent to settle at 82,515.14. During the day, it climbed 391.79 points or 0.47 per cent to 82,783.50, driven by gains in IT and energy shares. In its sixth straight day of gains, the 50-share NSE Nifty ended 37.15 points or 0.15 per cent up at 25,141.40. The index moved between a low of 25,081.30 and a high of 25,222.40 during the day. In the six sessions to Wednesday, Nifty gained 598 points or 2.42 per cent.

After a flat start, the Nifty gradually moved higher in the first half and tested the resistance at 25,200, but failed to sustain the momentum at close, Ajit Mishra SVP, Research, Religare Broking Ltd said.

From the Sensex pack, HCL Tech, Infosys, Tech Mahindra, Reliance Industries, Bajaj Finserv, ICICI Bank, Tata Motors and Eternal were the lead gainers.

Power Grid, Adani Ports, IndusInd Bank, Nestle, HDFC Bank and Hindustan Unilever were among the laggards. "Profit-booking continues in the broader markets, driven by elevated domestic valuations. However, large-cap resilience is supporting the indices, with institutional investors favouring companies with stable earnings outlooks.

"Auto and IT sectors remain in focus - auto stocks are gaining on improved monthly sales, while IT shares are benefiting from optimism around a potential US-China trade resolution," Vinod Nair, Head of Research, Geojit Investments Ltd, said.

The BSE smallcap gauge went up by 0.06 per cent while midcap index dipped 0.12 per cent.

"Benchmarks ended with marginal gains on Wednesday extending their consolidation phase. Positive developments in US-China trade talks and a steady global equity environment helped buoy sentiment, though gains were tempered by profit-booking in certain sectors," Satish Chandra Aluri, Analyst, Lemonn Markets Desk, said.

Among sectoral indices, oil & gas surged the most by 1.83 per cent, followed by energy (1.33 per cent), BSE Focused IT (1.30 per cent), IT (1.25 per cent), teck (1.01 per cent), healthcare (0.74 per cent) and auto (0.19 per cent). Financial Services, FMCG, industrials, power, utilities, services, capital goods and bankex were among the laggards.

As many as 2,227 stocks advanced while 1,821 declined and 132 remained unchanged on the BSE. In Asian markets, South Korea's Kospi, Japan's Nikkei 225 index, Shanghai's SSE Composite index and Hong Kong's Hang Seng settled in the positive territory. European equity markets were trading higher. (PTI)

RENALYX - RxT 21 machine is world's first fully indigenous, AI and cloud-enabled smart hemodialysis machine with real-time remote monitoring and clinical connectivity facility, the company said. Currently, the company manufactures RxT 17 through contract manufacturing and with the launch of RxT 21, it will set up its own facilities at Bengaluru and Mysuru in Karnataka and at Mumbai in Maharashtra, Renalyx Health Systems Founder and Director Shvam Vasudeva Rao told PTI.

This is expected to raise the manpower of the company to over 500 people in 1-2 years from the current 100, he added.

"RxT 21 makes Renalyx the sixth company globally and first in India to produce an advanced dialysis machine with EU CE certification, a mandatory conformity marking for products sold within the European Economic Area (EEA). We are aiming for an annual capacity of 5,000 machines in the company-owned manufacturing units," he

The Indian CDSCO (Central Drugs Standard Control Organisation) approval of the machine is in its final stages and is expected by July this year, while the US FDA approval process is underway and anticipated by March 2026, he said. When asked how the company is planning to raise ₹ 800 crore for setting up the manufacturing units, Rao said, the company will get it through a mix of foreign direct investment (FDIs), equity and debt.

'The company plans to raise funds through the sale of equity, backed by strong interest from prominent Indian and international investors. In addition, it will raise debt, and the promoters will also invest capital. We are also planning to go public within the next three years," he added.

Renalyx Health Systems is a technology innovation company which is focused on delivering inclusive solutions for comprehensive renal care

With initial deployments of the machine planned in Maharashtra and Karnataka, the company will go for rapid pan-India distribution of RxT 21 with its partners as well as exports to other countries.

Rao said the company has penetrated international markets, and has secured orders from South Africa, the USA, and Europe. (PTI)

#### Honeymoon murder: Sonam and aides

him somewhere on the route, considering it is secluded. But, since there were too many tourists trekking to Nongriat on May 22 and May 23, they couldn't kill him there," the officer said. "They finally killed him near Weisawdong Falls, and dumped his body into the deep gorge," he said. Syiem, who is overseeing the investigation, told PTI that the contract killers arrived in Guwahati on May 21, a day after the couple reached the north-east. The killers procured a machete from outside their hotel in Guwahati, and then travelled by road to Shillong, he said. "We have gathered CCTV evidence, making this investigation a very tight-knit one," he said. Sonam was in touch with her boyfriend Raj throughout the day of the murder, while Raj coordinated with the

"Sonam was present when Raja was killed," the officer said, adding that after the crime, she fled. Sonam, her boyfriend Raj and the three suspected contract killers were produced before a court in Shillong on Wednesday. Sonam's brother Govind said that based on the evidence so far, he knows "100 per cent" that it was his sister who executed the crime, and she should be hanged if found guilty.

Govind also said that his family has snapped ties with her after her alleged involvement in the killing of her husband came to light. An emotional Govind reached Raja Raghuvanshi's house in Indore to console the latter's family members. Sharing the family's grief, he hugged Raja's mother Uma and broke down. Coming out in support of the victim's family, he vowed to fight a legal battle to get justice for them. He later addressed media persons. When asked if Sonam should be given capital punishment if charges against her were proven, he said, 'Absolutely. If Sonam is found guilty, she should be hanged straight away. I will appoint a lawyer myself to represent Raja Raghuvanshi's family in the court." "I am with the truth. Raja Raghuvanshi's family has lost a son. I have apologised to his family. Our family has broken ties with Sonam," he said.

"I do not know whether my sister Sonam has confessed her crime in the Raja Raghuvanshi murder case or not, but from the evidence that is coming out, I know 100 per cent that she is the one who executed this crime," he said. He, however, dismissed reports of the alleged love affair between Sonam and Raj Kushwaha, another prime accused in the case. "Raj always called Sonam didi (sister). Sonam tied a rakhi to me and Raj while together in my house. Raj was just our employee. He was working in our office for two-three years. He used to manage the office and handle clients," he said. Govind claimed that the three other accused in the case - Vishal Chauhan, Akash Rajput and Anand Kurmi - have an old relationship with Raj Kushwaha. Sonam made the first phone call to Govind before she surrendered before the police in Uttar Pradesh's Ghazipur. "During the phone call, she was crying miserably and was very nervous. I informed the police myself and got her to surrender," he said. (PTI)

# Ethanol production capacity jumps over 4-fold to 1,810 cr litres in 11 yrs of Modi govt: Official tutions, whichever is lower, is being

AHMEDABAD, June 11: India's ethanol production capacity has jumped more than four times in the last 11 years of the Modi government to 1,810 crore litres annually with the help of favourable policy initiatives, according to a senior of-

With an enhanced installed production capacity, the blending of ethanol with petrol has surged to nearly 19 per cent from 1.53 per cent in 2013, leading to huge saving in foreign exchange -- more than ₹ 1.10 lakh crore -- as well as benefits to sugarcane and foodgrain farmers.

A senior official from the Department of Food and Public Distribution in the central government said till 2013, ethanol distillation capacity in the country was only 421 crore

However, the official highlighted that the ethanol production capacity in the country has reached 1,810 crore litres, thanks to policy changes by the government, including interest subsidy to set up manufacturing facilities. Till 2013, the official said the supply of ethanol to OMCs (oil marketing companies) was only 38 crore litres with blending levels of 1.53 per cent in 2013-14 ethanol supply year (ESY) that runs from

(November to October). "Production of fuel grade ethanol



and its supply to OMCs has increased by more than 18 times from ESY 2013-14 to ESY 2023-24," the official said at an event in Ahmedabad. Many ethanol plants have been set up in Gujarat with the help of

Centre's interest subsidy policy. In ESY 2023-24, about 707 crore litres of ethanol have been blended by OMCs, thereby achieving blend-

ing of 14.60 per cent. Till May 25 in current 2024-25 ESY, about 548 crore litres of ethanol have been blended by achieving blending of 18.74 per cent, the official said.

During the last 11 years, the total revenue generated by sugar mills/distilleries, including grainbased distilleries stood around ₹ 2 lakh crore, of which ₹ 1.22 lakh crore is revenue generated by only sugarcane-based distilleries.

The Centre has notified various ethanol interest subvention schemes from 2018-2022 (in 2021 ethanol production from grain was also included under these schemes) to encourage sugar mills and distilleries to enhance their ethanol production

Under these subvention schemes, the government is facilitating project proponents to avail loans from banks/financial institutions for which interest subvention at 6 per cent or 50 per cent of the interest charged by the banks/financial insti-

#### Biswanath Farm machinery moves towards litchi production

11: The North Eastern Farm Machinery Training and Testing Institute (NEMTI), Biswanath, under the Government of India, has taken a proactive step toward enhancing litchi production in the region. In collaboration with Tezpur Litchi Bagan, the institute planted 100 high-quality litchi seedlings across 2.5 acres of land on Wednesday.

#### Britain to revamp its defence

The United Kingdom's Strategic Defence Review (SDR), published on June 2 this year offers an ambitious vision for the British Armed Forces. It reiterates a focus on a 'NATO First' policy, amid what Prime Minister Sir Keir Starmer calls in the document a 'new era for defence and security'. The latest war preparedness, to fight any future war in Europe or elsewhere has been proposed in the Strategic Defence Review (SDR), 2025. The SDR proposes to build as many as a dozen new nuclear-powered attack submarines, get the British Army ready to fight a war in Europe and become "a battle-ready, armour-clad nation," Prime Minister Keir Starmer vowed on Monday. Starmer said Britain "cannot ignore the threat that Russia poses" as he pledged to undertake the most sweeping changes to Britain's defences since the collapse of the Soviet Union more than three decades ago. The government announced its plans for the military in response to a strategic defence review commissioned by Starmer and led by George Robertson, a former UK defence secretary and NATO secretary general. It was the first such review since 2021, and it landed in a world shaken and transformed by Russia's invasion of Ukraine — and by the re-election of Donald Trump last year. Starmer's centre-left Labour Party government has said it will accept all 62 recommendations made in the review, aiming to help the UK confront growing threats on land, air,

Starmer used the launch of the review to commit to building "up to" 12 new conventionally armed, nuclear-powered submarines to replace Britain's seven-strong Astute class from the end of the next decade onwards. However, the review says the Royal Navy "must continue to move towards a more powerful but cheaper and simpler fleet". It envisages the navy playing a new role in securing the UK's critical undersea infrastructure and maritime traffic. Its transformation should include use of unmanned technology across the board, including a "hybrid" aircraft carrier air-wing with both crewed aircraft and drones. The army must deliver "tenfold increase in lethality" at the same time as reequipping and modernising after much of its kit, including Challenger 2 tanks and ammunition, have been given to Ukraine. A new "digital war fighter group" - using AI and drones - should be established by July 2026. While the UK is "already under daily attack" in cyberspace, the review warns that cyber-threats will become harder to mitigate as AI and other technology evolves.

The formation of a new "cyber and electromagnetic command" to oversee cyber-operations was announced last week by the British Ministry of Defence (MoD). That new command must be filled by civilians and reserves, given that greater expertise exists in the civilian sector, according to the review. While the review says the UK has access to world-class intelligence capabilities, they are "underpowered and fragmented" within defence intelligence, part of the MoD, and there should be a new unit to protect the military from hostile spy services. Essentially, the SDR is designed to send a message to both Moscow, and to President Trump in Washington that Europe is heeding his demand for NATO members to spend more on their own defence.

# Madhavdeva's role in the **Neo-Vaishnavism movement**

ment, which emerged in Assam during the 15th and 16th centuries, played a transformative role in reshaping the socioreligious landscape of the region. At the heart of this cultural and spiritual resurgence were two towfigures—Srimanta Sankardev, the founder of the movement, and his most illustrious disciple, Madhavdeva. While Sankardev laid the foundation of the Neo-Vaishnavite faith, it was Madhavdeva who upheld and expanded this tradition with remarkable devotion, poetic brilliance, and organizational acumen. His unwavering commitment, theological contributions, and literary excellence helped solidify the movement's position as a major force in the spiritual and cultural life of

Madhavdeva was born in 1489 in the Lakhimpur district of Assam, in a society rife with religious orthodoxy, caste divisions, and ritualistic practices. Initially, he was a follower of the Shakta tradition, a faith that focused on the worship of the goddess and involved elaborate rituals and sacrifices. However, his life underwent a profound transformation when he came into contact with Srimanta Sankardev. Their meeting at the Belguri Satra is often regarded as a spiritual turning point, not only in Madhavdeva's life but also in the broader journey of the Neo-Vaishnavism movement. Initially resistant to Sankardev's ideas, Madhavdeva was deeply moved by Sankardev's teachings, particularly his emphasis on Eka Sharana Nama Dharmathe path of devotion to one God. They are sung in satras and namghars (community prayer halls) as a means of invoking divine presence and fostering a sense of spiritual community. His borgeets, along with those composed by Sankardev, form the musical backbone of the movement and are revered for their emotional intensity and theological clarity.

In addition to his literary and musical contributions, Madhavdeva played a critical role in institutionalizing

Neo-Vaishnavite movement. He was instrumental in establishing satras, which served not only as centers of religious instruction and practice but also as hubs of cultural education and social reform. These satras became instrumental in spreading the Neo-Vaishnavite faith across Assam and beyond. Under Madhavdeva's leadership, the satras flourished as egalitarian institutions that welcomed people from diverse social backgrounds, challenging the rigid caste hierarchies that had long dominated Indian society. Through these institutions, Madhavdeva emphasized the values of humility, community service, and devotion, thereby making religion a unifying

havdeva's leadership was his ability to maintain unity within the Neo-Vaishnavite community. movement. Madhavdeva's contribution was not limited to religious teachings; he was deeply involved in shaping the cultural identity of Assam. Through his writings, music, and

the establishment of socio-religious institutions, he laid the foundation for a shared Assamese culture that transcended

ethnic and linguistic differences. His use of the Assamese language as the medium for religious expression helped standardize and enrich it, laying the groundwork for a distinct literary tradition. In this sense, Madhavdeva was both a spiritual guide and a cultural architect whose influence is felt to

Despite his immense contributions, Madhavdeva never sought personal glory or recognition. He always considered himself a servant of God and a disciple of Sankardev. His humility and dedication earned him the reverence of his followers, who saw in him the embodiment of the very ideals he preached. His legacy is enshrined not just in texts and temples but in the daily lives of countless devotees who continue to follow the path he illuminated.

Madhavdeva passed away in 1596, but his influence has endured for over four centuries. The satras he helped establish continue to function as centers of religious and cultural activity, and the literary and musical traditions he nurtured remain vibrant. His teachings have shaped the moral and spiritual compass of generations and continue to inspire people to lead lives of devotion, compassion, and integrity.

In contemporary Assam, Madhavdeva is remembered not only as a religious reformer but also as a symbol of unity, tolerance, and cultural pride. His life and work serve as a powerful reminder of the transformative potential of faith when combined with compassion, inclusivity, and a commitment to social justice. As the world grapples with increasing divisions and spiritual uncertainties, Madhavdeva's message of universal brotherhood, devotion to a single deity, and rejection of ritualistic orthodoxy remains as relevant as ever.

In conclusion, Madhavdeva's role in the Neo-Vaishnavism movement was foundational and farreaching. As the foremost disciple of Srimanta Sankardev, he not only preserved his guru's vision but also expanded and institutionalized it, ensuring its transmission across generations. His literary brilliance, musical genius, organizational skill, and moral authority made him central figure in Assam's religious and cultural history. Through his tireless efforts, Neo-Vaishnavism emerged as a powerful force for spiritual awakening, social reform, and cultural renaissance—a legacy that continues to illuminate the path of countless seekers to this day. # Madhavdev: The light of Assamese devotion

adhavdev, a towering figure in Assamese history, left an indelible mark on the region's literature, culture ■and religious life. Born in 1489 at Letekupukhuri, near Narayanpur in Lakhimpur district, Madhavdev is celebrated as the principal disciple and true successor of the great saint and reformer, Srimanta Sankardev. His multifaceted contributions to the spiritual, literary and social fabric of Assam continue to inspire generations. As a key proponent of the Neo-Vaishnavite movement, Madhavdev played a pivotal role in spreading the message of devotion, unity and cultural revival, shaping the identity of the Assamese people in profound ways. His life's work, encompassing devotional literature, music, drama and religious propagation, remains a cornerstone of Assam's heritage.

In the early years of his life, Madhavdev was a follower of the Shakta tradition, worshipping the goddess Shakti. However, his transformative journey began when he met Sankardev, whose teachings of Ekasarana Naam Dharma, a monotheistic form of Vaishnavism, deeply influenced him. This encounter marked a turning point, leading Madhaydey to dedicate his life to the path of devotion and the propagation of his guru's ideals. The bond between Sankardev and Mad-

the Thousand Verses, contains 1,000 stanzas, of which approximately 400 are his original compositions, while the rest are translations and adaptations from various Puranas and scriptures. Written in a simple yet melodious style, the "Naam Ghosa" extols the glory of Lord Krishna, emphasizes devotion to the guru and advocates humility and surrender to God. Its language is accessible, allowing ordinary people to connect with its spiritual essence. The "Naam Ghosa" has become an invaluable treasure in Assamese culture, widely revered and recited in religious gatherings, serving as a bridge between

complex theological concepts and the common devotee. Another significant work by Madhavdev is the "Bhakti Ratnavali", a text that explores the essence and dimensions of devotion. Drawing from various scriptures, this work highlights the importance of Bhakti (devotion) as a means to attain spiritual liberation. Madhaydey's ability to distill profound philosophical ideas into accessible writings made him a beloved figure among the masses. His literary repertoire also includes 157 Borgeets, devotional songs that are a cornerstone of Assamese music and culture. These songs, steeped in the "Batsalva Ras" (the sentiment of parental love), vividly portray the childhood exploits of Lord Krishna and the tender affection of his mother, Yashoda. The Borgeets are characterized by their lyrical beauty, simplicity and deep emotional resonance, captivating listeners and evoking a sense of devotion and love. Through these songs, Madhavdev brought the divine qualities of Krishna closer to the people, enriching Assamese culture

with a unique musical tradition that continues to thrive. Madhavdev's contributions to the dramatic arts further highlight his versatility and creativity. He authored "Arjun Bhanjan", a full-fledged play based on episodes from the tenth canto of the "Bhagavata Purana", showcasing his skill in weaving narrative and devotion into theatrical form. Additionally, he composed shorter dramatic works known as "Jhumuras", such as "Chordhara", "Pimpara Guchowa", "Bhojan Behar", and "Bhumi Letowa". These compositions laid the groundwork for Assamese drama, blending entertainment with moral and spiritual teachings. At the behest of Sankardev,

Madhavdev also translated the 'Adi Kanda" of Valmiki's "Ramayana"into Assamese, further enriching the region's literary landscape. His final work, "Naam Malika", is a collection of verses that glorify divine names, drawing from various Puranas and scriptures. This text reflects his signature style which is simple, profound, and steeped in devotion making it a fitting capstone to his literary career.

Madhavdev's contributions to the religious sphere were equally transformative. Following Sankardev's passing in 1568. Madhaydey took up the mantle of leadership, tirelessly working to spread the tenets of Ekasarana Naam Dharma. He established key institutions like the Barpeta Satra and Sundaridiya Satra, which became centers of religious, cultural, and social activities. These satras (monastic institutions) played a crucial role in fostering devotion, education, and community welfare, serving as hubs for spiritual discourse and cultural expression. The social reforms initiated by Madhavdev also deserve recognition. By promoting self-sufficiency and community welfare through the satras, he addressed the practical needs of society while nurturing spiritual growth. His emphasis on equality, devotion, and humility challenged rigid social hierarchies and superstitions prevalent at the time, aligning with Sankardev's vision of a harmonious and inclusive society. Madhavdev's teachings encouraged individuals to lead ethical lives, grounded in devotion to God and service to humanity. His approach bridged the gap between the spiritual and the mundane, making religion a lived experience rather than a dis-

# **Challenges to Democracy in India**

**Measures to Have Access to Democracy:** Democracy in India faces more serious challenges and needs to have more concern. Civil society needs to take serious steps with the government to better the prevailing condition. Poverty, lack of education and social exclusion in general reduce access to democ-

**Equal Quality Education for All:** Democracy is obviously based on the idea of equality and the significance and the necessity of education for efficient functioning of democracy. This was appreciated by the framers of the Indian Constitution. There is no equal qualitative education for all in India. Whatever the efforts are there to improve the quality and quantity of education to realize the constitutional mandate that free and compulsory education to all the children up to the fourteen years of age. The National Policy on Education 1986, a National Literacy Mission 1988 under Sarva Shiksha Abhiyan and Right to Education Act, 2009 are not sufficient and efficient. In addition to that Saakshar Bharat 2009 aims at developing functional literacy and numeracy in the age group of fifteen and above to enable them to put their signature and to consider them under literacy group. In reality, it is not making them learn beyond basic literacy and acquire equivalence to formal educational system. Finally, though the literacy rate has risen to 74.04 per cent according to 2011 Census and the Right to Education is provided as a fundamental right, the situation is not much better than earlier. If the children have access to good and qualitative education throughout the country uniformly, the problem of education will be solved to a large extent. It is possible only with the nationalization of education in India. In India right from the voters to the people's representatives, most of them lack basic education and are less educated. Less educated and ignorant representatives of the people are governing the educated and the intellectual class. So naturally there's misgovernance in

most part of our country. Simultaneous Elections, popularly known as One Nation One Election, mean holding elections for all the State Legislative Assemblies, House of the People, and local bodies (Municipalities and Panchayats) simultaneously throughout the country.

Elections to the Legislative Assemblies of States and House of the People were held simultaneously in India from 1951-52 to 1967. This cycle broke, and currently, elections are held every year and sometimes even within a year at different times, which results in massive government expenditures, diversion of security forces and electoral officers engaged in elections from their primary duties for prolonged periods, disruption in developmental work due to the application of the Model Code of Conduct, etc.

Thus, the Law Commission of India observed in its 170th Report on Reforms of the Electoral Laws that the government should consider the situation where the Lok Sabha and all the Legislative Assemblies elections are held at once, i.e. One Nation One Elec-

Under the One Nation One Election, elections will be held only once every five years for both the Lok Sabha and all the Legislative Assemblies throughout the country.

The first step in making One Nation One Election work is to conduct simultaneous elections for the State Legislative Assemblies and the House of the People. For this, there is no requirement for the ratification by the states of constitutional amendments.

The second step will be to synchronise elections of the Panchayats and Municipalities with the State Legislative Assemblies and the House of the People in such a way that Panchayats and Municipalities elections are held within 100 days of holding elections to the House of the People and the State Legislative Assemblies. For this to happen, not less than one-half of the States have to do rat-

India has a thriving civil society and media that can rival those in so-called full democracies. Citizens are right to point a finger towards the imperfect functioning of the organs of State. These act as countervailing pressures. In particular, one should mention the Association for Democratic Reforms (ADR), and PRS Legislative Research. Such exercises improve transparency and accountability and their focus has been on the functioning of Parliament. There is relatively less scrutiny of executive and judiciary since they are not elected.

While the criticisms are in order, two points need to be mentioned. First, India, like many other countries, is an indirect and representative democracy. If one undermines faith in the institutions of governance, that undermines democracy, rather than strengthening it. Second, other than pointing a finger outwards, there is also the question of pointing inwards, at the extent to which individuals and enterprises help build democracy within their own ambits. After all, the Preamble to the Constitution begins with the words, "We the People".

Indeed, we the People have built democracy in India for thousands of years. Per se, that democracy is good and an end in itself. The pursuit of that democracy, and its perfection, is one pursuit of progress. The imperfections can be described as "bad". But for most Indians, democracy is non-negotiable. # Guwahati's battle with India's urban flood crisis

The recurring specter of urban flooding has become an all-too-familiar ordeal for India's major cities-Mumbai, Delhi, Kolkata, Hyderabad, and Guwahati-where torrential rains transform bustling streets into impassable waterways. This escalating crisis, evident in recent years, stems from a confluence of factors: outdated and inefficient drainage systems, rampant urbanization, and the intensifying impacts of climate change. Historically, urban planners designed drainage networks to channel stormwater from rooftops, streets, and roads into natural water bodies, aiming to prevent inundation. However, these systems, often engineered for rainfall expected once every two years, are increasingly overwhelmed by modern storms of unprecedented magnitude. Compounding this, the concretization of urban landscapes, clogged drains, and the integration of sewage into stormwater systems have strained infrastructure beyond its limits. In cities like Guwahati, where topographic challenges exacerbate flooding, the consequences are particularly severe. As climate change amplifies the intensity of rainstorms, India's urban centers face a pressing need for innovative, scientific solutions to mitigate flooding and adapt to a rapidly changing environment.

Urban drainage systems were originally designed with careful consideration of land use and rainfall patterns. The volume of stormwater runoff depends heavily on how land is utilized—open, permeable surfaces like parks absorb water, while paved areas generate significantly more runoff. Traditionally, Indian cities boasted substantial green spaces capable of absorbing considerable runoff, but rapid urbanization has transformed these landscapes. Over decades, cities have, either by design or through illegal encroachments, paved over vast areas, reducing natural absorption capacity. This concretization, coupled with population growth and changing land use, has increased stormwater volumes far beyond what aging drainage systems were built to handle. In Guwahati, for instance, the loss of wetlands and hillsides to urban sprawl has drastically reduced natural drainage, exacerbating flooding in low-lying areas like Anil Nagar and Zoo Road. The city's drainage network, designed decades ago, struggles to cope with the increased runoff from these impermeable surfaces, leading to frequent inundation during the monsoon season.

The capacity of a drainage system is determined not only by expected rainfall but also by the size of its catchment area—the land from which runoff flows into drains. Larger catchment areas produce greater volumes of stormwater, necessitating wider, deeper drains to prevent overflow. As water moves through a network of smaller drains into larger ones, the flow rate and volume increase, requiring progressively larger cross-sections. In cities with complex topography, such as Guwahati, where hills and low-lying areas coexist, gravity alone is often insufficient to evacuate stormwater, particularly in underpasses or floodprone zones like Dispur. Here, pumps are essential to move water, but their deployment requires scientific precision. Guwahati's drainage challenges are compounded by its location on the Brahmaputra River's floodplains, where heavy monsoon rains and river overflow combine to overwhelm infrastructure. A 2023 report by the Assam State



Disaster Management Authority noted that 60% of Guwahati's drains are either undersized or clogged, reducing their capacity by up to 40%.

Clogging is a pervasive issue across Indian cities. Drains accumulate silt and solid waste, including plastics and debris, which diminish their carrying capacity. In Delhi, stormwater drains often double as conduits for sewage due to poorly managed sewerage systems and the exclusion of some areas from municipal networks. This dual burden clogs drains further, as organic waste and sediment settle, impeding water flow. In Guwahati, the Bharalu River, a primary drainage channel, is choked with sewage and garbage, rendering it a stagnant health hazard rather than an effective conduit. Desilting, a critical maintenance task, is often neglected or inadequately performed. Many drains, particularly in older urban areas, are permanently covered, making cleaning nearly impossible without significant retrofitting. The 2015 Manual on Stormwater Drainage Systems, developed for the Ministry of Housing and Urban Affairs, recommended regular desilting and access points for maintenance, yet implementation remains inconsistent. In Guwahati, a 2024 civic audit revealed that only 30% of drains were desilted before the monsoon, leaving the city vulnerable to flooding.

Climate change has dramatically intensified these challenges. Over the past two decades, India has experienced rainstorms of greater magnitude and intensity, driven by shifting weather patterns. The 2015 manual advised cities to design drainage systems for a one-in-five-year return period to account for climate variability, but recent storms have exceeded even these projections. Mumbai's 2005 deluge, which dumped 944 mm of rain in 24 hours, and Chennai's 2015 floods, with 345 mm in a single day, highlight the inadequacy of existing infrastructure. In Guwahati, a single day in June 2024 saw 214 mm of rain, paralyzing the city and flooding key areas like GS Road. These extreme events overwhelm drains designed for lower rainfall thresholds, rendering them ineffective. The Intergovernmental Panel on Climate Change (IPCC) projects that South Asia will face a 20% increase in extreme precipitation events by 2050, necessitating urgent upgrades to urban drainage

Scientific tools offer a path forward. A simulation framework on a Geographic Information System (GIS) platform, piloted for the Government of Delhi, models runoff movement and adapts drainage systems to changes in population, land use, and rainfall patterns. This framework identifies flood-prone areas and optimizes drain design, offering a blueprint for cities like Guwahati, where haphazard urban planning has exacerbated flooding. For instance, Guwahati's rapid expansion into hilly areas has increased runoff into low-lying zones, yet the city lacks a comprehensive drainage master plan. A 2025 study by IIT Guwahati proposed a GIS-based model to integrate real-time rainfall data with topographic analysis, potentially reducing flood impacts by 25%. Such tools, however, require consistent investment and political will, both of which have been lacking.

Mitigating urban flooding demands a multifaceted approach. Enhancing groundwater recharge through permeable pavements and green spaces can reduce runoff volumes. Rejuvenating water bodies, such as Guwahati's Deepor Beel, a Ramsar wetland encroached by urban development, is critical. Cities like Singapore have implemented rooftop gardens to retain rainwater, a strategy Indian cities could adopt. Underground storage systems, such as tanks or detention basins, can temporarily hold excess water, easing pressure on drains. In Japan, massive stormwater tunnels divert runoff to rivers, though their high cost—often billions of dollars—poses challenges for India. Guwahati's 2024 budget allocated ₹200 crore for drainage upgrades, including new culverts and pumps, but experts argue this is insufficient for a city of 1.2 million facing annual floods. Community-led initiatives, stricter regulations on encroachments, and advanced planning are essential to transform India's urban centers into resilient, flood-resistant metropolises.

The impacts of urban flooding are profound, disrupting daily life, economies, and ecosystems. In cities like Mumbai and Delhi, inundated streets halt transportation, stranding commuters and delaying essential services. Guwahati's 2024 floods, for instance, paralyzed key commercial hubs like GS Road, with businesses reporting losses in the crores. Property damage, particularly in low-income areas, exacerbates economic inequality, as residents struggle to recover. Health risks are equally dire: stagnant floodwater breeds mosquitoes, increasing cases of dengue and malaria, while sewage contamination raises the threat of cholera and typhoid. A 2023 study by the Indian Council of Medical Research noted a 15% spike in waterborne diseases in Guwahati post-monsoon. Ecologically, floods carry pollutants into rivers and wetlands, harming biodiversity. Deepor Beel, once a thriving habitat for migratory birds, now suffers from siltation and pollution, diminishing its ecological and flood-mitigating roles.

Guwahati's flooding crisis is a microcosm of India's urban challenges. The city's location in the Brahmaputra valley, coupled with an average annual rainfall of 1,688 mm, makes it inherently flood-prone. Urban sprawl has encroached on critical wetlands like Deepor Beel, now reduced to a fraction of its original size, and Silsako Beel, similarly degraded. Hillside deforestation in neighboring Meghalaya channels silt-laden runoff into Guwahati's drains, further clogging them. The Bharalu River, meant to serve as a primary drainage channel, has become a de facto sewer, with a 2024 report by the Central Pollution Control Board classifying it as one of India's most polluted water bodies. The Guwahati Metropolitan Development Authority (GMDA) has acknowledged that the city's drainage system fails when the Brahalu cannot handle excess rainwater, a recurring issue during heavy rains. In May 2025, when 112.5 mm of rain fell in a short period, areas like Rukminigaon, Hatigaon, and Wireless were submerged, prompting the Assam State Disaster Management Authority (ASDMA) to deploy rescue teams with rubber boats. Posts on , such as one from @GuwahatiCivic on May 20, 2025, voiced public frustration: "Another monsoon, another flood. Why are our drains always clogged?"

The root of Guwahati's drainage problem lies in its outdated infrastructure and poor urban planning. Many drains, built in the 1970s, were designed for a smaller population and lower rainfall intensity. The city's population, now over 1.2 million, has outgrown this infrastructure, while unplanned construction in hilly areas increases runoff into low-lying zones. A 2021 article in The Times of India warned that Guwahati's flooding could force residents to abandon the city if unaddressed Guwahati Floods Will Worsen. The GMDA's "Mission Flood Free Guwahati" initiative, launched in 2020, aims to upgrade drains and manage stormwater, but progress is slow. A 2024 civic audit revealed that only 30% of drains were desilted before the monsoon, despite annual flooding. Pumps installed in areas like Anil Nagar often fail due to power outages or insufficient capacity, leaving residents stranded.

Climate change has turned manageable rains into catastrophic deluges. The IPCC's 2021 report projected that South Asia's monsoon rains will become 20% more intense by 2050, a trend already evident in India. Bengaluru's 2024 floods, triggered by 130 mm of rain in 12 hours, and Hyderabad's 2020 deluge, with 192 mm in a day, reflect this new reality Urban Flooding in India. Guwahati's June 2024 flooding, caused by 214 mm of rain, overwhelmed its drainage network, highlighting the gap between infrastructure and current needs. The 2015 Manual on Stormwater Drainage Systems recommended a one-in-five-year return period for drain design, but even this is inadequate for today's storms. Cities must adopt higher thresholds, such as one-in-ten years, to accommodate extreme weather, though this requires signif-

Scientific solutions are critical to addressing urban flooding. The GIS-based simulation framework piloted in Delhi offers a model for Guwahati, mapping runoff patterns and identifying floodprone areas. A 2025 study by IIT Guwahati proposed a similar framework, integrating real-time rainfall data with topographic analysis to optimize drain placement and size, potentially reducing flood impacts by 25% Urban Flood Mitigation Planning for Guwahati. Such tools can guide urban planning, ensuring new developments account for drainage needs. However, implementation faces hurdles: Guwahati's 2024 drainage budget of ₹200 crore is dwarfed by the estimated ₹1,500 crore needed for comprehensive upgrades. Political will, often undermined by short-term priorities, remains a barrier.

Sustainable, nature-based solutions can complement infrastructure upgrades. Enhancing groundwater recharge through permeable pavements and green spaces reduces runoff volumes. Restoring wetlands like Deepor Beel, a Ramsar site, could absorb significant floodwater, but encroachments must be cleared. A 2023 X post by @AssamWildlife urged action to save Deepor Beel, noting its role in flood mitigation. Rejuvenating water bodies like Silsako Beel and stopping hillside construction are equally critical. Cities like Chennai have piloted lake restoration to mitigate floods, a strategy Guwahati could emulate. Rooftop gardens, as seen in Singapore, retain rainwater at the source, while underground storage tanks can detain excess water. Large-scale solutions, such as Tokyo's stormwater tunnels, are effective but prohibitively expensive for India. Basic street-level drainage improvements, such as wider culverts and regular desilting, remain founda-

Community engagement is vital to long-term success. Public awareness campaigns can discourage waste dumping in drains, a chronic issue in Guwahati, where the Bharalu River is littered with plastics. Mumbai's citizen-led drain-cleaning initiatives offer a model for community involvement. The National Disaster Management Authority's 2010 guidelines advocate integrated urban planning, emphasizing coordination between municipal bodies, but implementation lags Mission Flood Free Guwahati. Stricter regulations on wetland encroachments and illegal constructions are essential, requiring robust enforcement. A 2025 X post by @GuwahatiResident highlighted the need for accountability: "Why do builders get away with blocking drains? We pay the price every mon-

India's urban flooding crisis demands a paradigm shift. With 50% of the population projected to live in cities by 2050, the stakes are immense. Guwahati's struggles-clogged drains, lost wetlands, and extreme rains—mirror those of Mumbai, Delhi, Kolkata, and Hyderabad. While complete flood prevention is unattainable, a combination of scientific planning, sustainable infrastructure, and community action can mitigate impacts. GIS-based modeling, wetland restoration, and green solutions offer hope, but they require sustained investment and governance reform. As India's cities face a deluge of challenges, the path to resilience lies in reimagining urban planning for a climate-altered future, ensuring that metropolises like Guwahati thrive despite the storms. # Heatwave days to double in Delhi, Chennai & these 6 Indian cities by 2030

umbai, Chennai, Delhi, Surat, Thane, Hyder-Patna \_\_abad. Bhubaneswar are projected to witness a two-fold increase in heatwave days by 2030, according to a study released June 10, 2025 by development consulting firm IPE Global and GIS technology provider Esri India.

Unveiled at the International Global-South Climate Risk Symposium in New Delhi, the report titled Weathering the Storm: Managing Monsoons in a Warming Climate offers a district-level assessments of the correlation between extreme heat and erratic rainfall in India. The findings underscored the escalating threat of climate change and call for urgent, localised interventions to strengthen resilience across urban and rural landscapes.

Incessant and erratic rainfall will become more frequent in 8 out of 10 districts in India, the report noted.

"Our analysis suggests that around 72 per cent of the tier-I & tier-II cities are going to witness an increased occurrences of heat stress and extreme rainfall events, accompanied with storm surges, lightening and hailstorms," said Abinash Mohanty, head of Climate Change and Sustainability Practice at IPE Global and lead author of the study. "Meteorological phenomenon like El Nino & La Nina are going to gain stronger momentum, resulting in abrupt surge in climate extremes like flood, cyclones, storm surges

and extreme heat. Coastal districts, in particular, are expected to endure prolonged summer-like conditions even during the peak monsoon months of June through September. Around 69 per cent of coastal districts will be affected by heat stress by 2030, a figure that could rise to 79 per cent by 2040.

Drawing on dynamic climate modelling and spatial analytics,

the study documented a stark rise in extreme heat over the last three decades. Between 1993 and 2024, India recorded a 15 times increase in heatwave days during both the March-May and June-September periods. The last decade alone saw a 19-fold surge, with far-reaching implications for human health, agriculture, energy demand and water

Microclimate shifts, land-use change

The study highlighted that in a business-as-usual scenario, 63 per cent of hotspot districts will undergo land-use and land-cover changes by 2030. These transformations — from forest to farmland, wetland to settlement — are exacerbating local heat and rainfall extremes by disrupting natural cooling systems and water

Some states that already face extreme heat will bear an additional burden of extreme rainfall. These include Gujarat, Rajasthan, Tamil Nadu, Odisha, Uttarakhand, Himachal Pradesh, Maharashtra, Uttar Pradesh, Meghalaya and Manipur, with more than 80 percent of the districts projected to be impacted by this by 2030, the authors of the report found.

Local factors such as deforestation, unplanned urbanisation, loss of wetlands and mangroves intensify the broader climate crisis. "Embracing hyper-granular risk assessments and establish climate-risk observatories should become a national imperative to safeguard Indian agriculture, industry, and large-scale infrastructural projects from the vagaries of climate change," said Mo-

"The growing intensity and frequency of extreme heat and rainfall events across India are no longer rare occurrences — they are signals of a shifting climate reality impacting lives, livelihoods, and infrastructure," said Agendra Kumar, Managing Director, Esri India. Addressing spatially informed approach, the expert added. "GIS technology offers the ability to visualise and respond to these risks in realtime — whether in city planning, agriculture or disaster response.

The report recommended the establishment of a Climate Risk Observatory — a centralised platform using Earth Observation data and climate models to provide real-time and predictive information.

Such a system, the authors argued, would enable real-time forecasting, improve public communication and help policymakers prioritise investment in climate-resilient infrastructure.

The authors also called for the creation of heat-risk champions within District Disaster Management Committees to coordinate response efforts and enhance grassroots resilience.

Financing risks

In addition to scientific and governance reforms, the study advocates for risk financing mechanisms to cushion the economic blow of climate-induced

"Climate and development pathways are intricately linked. Nearly all countries of the Global South face the dual challenge of improving living conditions for large segments of their population while simultaneously adapting to the consequences of climate change," said Ashwajit Singh, Founder and Managing Director of IPE Global.

India has to bring innovations from margins to the mainstream, he suggested. "Only then, can India truly emerge as the climate solutions capital to the world".

# Plastic in the urban veins: Towards circular and climate-resilient cities

s the monsoon approaches, Indian cities once again face the familiar threat of Clogged drains, flooded streets, and overflowing landfills—symptoms of a deeper, more chronic crisis. Plastic waste, largely uncollected and poorly managed, chokes stormwater systems and magnifies the impact of extreme weather. According to the Ministry of Housing and Urban Affairs, waste generated in Tier 1 cities accounts for 72.5 percent of the total waste generated per day. India generates 4.1 million tonnes of plastic waste annually, out of which, more than 40 percent remains uncollected. What is collected is often mixed with organic and hazardous waste, making recycling difficult. In cities like Bengaluru and Mumbai, where daily waste exceeds 9,000 tonnes, plastic pollution is no longer just an environmental nuisance—it is a structural failure of planning, design, and governance. The 2023 Bengaluru floods, worsened by plastic-choked drains, exposed how unmanaged waste can undermine urban resilience. As World Environment Day 2025 calls attention to combatting plastic pollution, it is time to confront it not as a sanitation issue, but as a barrier to building climate-re-

Despite increasing policy attention to plastic waste management, India's urban response remains fragmented and largely reactive. The Plastic Waste Management Rules (amended in 2021) have mandated Extended Producer Responsibility (EPR), but implementation has faltered due to capacity constraints at the municipal level and a lack of traceability in the informal sector. State-level bans on single-use plastics have proven difficult to enforce, especially in markets and among small vendors. Municipalities remain underfunded and overburdened, with solid waste management constituting a minor portion of urban development budgets. Much like India's early approach to managing heatwaves—limited to issuing alerts without upgrading infrastructure—plastic waste management continues to be treated as an auxiliary function rather than a core pillar of climate-resilient planning. The result is a deeply linear economy in cities: one that takes, uses, and dumps, with few systems in place for reuse, recovery, or regeneration.

A systems transformation toward circular cities is essential. However, this transition must acknowledge the uneven terrain on which Indian cities operate. Nearly 80 percent of the recycling economy is informal. Lakhs of waste pickers, often women and Dalits, manually collect and sort plastic waste with little protection, income security, or institutional support. Municipalities rarely integrate these workers into formal service delivery, and in most cities, there

is no database of who they are or where they work. This exclusion undermines recovery rates and reinforces social inequities. For example, Delhi's attempts to automate collection have displaced thousands of informal workers without alternative livelihoods. In contrast, cities like Pune have shown that cooperatives such as SWaCH can bridge the gap, offering social protection while enhancing service efficiency. A just transition toward circularity must therefore be people-centred—recognising the informal sector as a climate ally, not a regulatory burden.

India's urban development schemes—Smart Cities Mission, AMRUT, and Swachh Bharat Abhiyan—have begun building infrastructure for waste collection, transportation, and processing. But these investments remain unevenly distributed, with wealthier Tier-I cities capturing the bulk of funding while smaller towns and peri-urban settlements lag. Moreover, these schemes lack a unified circular economy vision. Climate action plans under the C-CAP initiative rarely include material flow assessments or set recovery targets for high-leakage materials like multilayered plastics. Waste-to-Energy plants, often backed under public-private partnerships, remain controversial due to the low calorific value of Indian waste and the emission of toxins when burning plastic. Chennai, for instance, faces local resistance against its WTE plant over air quality and land-use concerns. Without upstream reforms—segregation at source, design for recyclability, and waste audits-technologydriven solutions will continue to underperform.

Reform must begin at the point of design and procurement. Indian cities continue to rely on linear supply chains for packaging and materials, with procurement guidelines rarely considering circularity. There are few incentives for bulk consumers—hotels, markets, e-commerce warehouses—to shift away from single-use plastics. Bengaluru's "Refill Hubs" pilot in government stores, where citizens refill cleaning products and staples, represents a promising shift, but such experiments need institutional scale and financing. The absence of mandates for public procurement of recycled content or subsidies for reusable packaging keeps the circular business models niche. Local governments, constrained by fiscal deficits, are unable to underwrite the transition costs for circular in-

Technology could be a powerful enabler, but is underutilised. Startups in Indian cities are piloting AI-based segregation, traceability platforms for EPR, and decentralised plastic-to-fuel units. However, many face regulatory bottlenecks, data inaccessibility, or weak municipal uptake. Unlike the relatively coordinated rollout of digital public goods in healthcare or finance, urban waste tech lacks systemic support. Cities do not maintain digitised, real-time dashboards

of plastic flows or segregation performance. In contrast to cities like Amsterdam or Seoul that track materials through every node of the urban metabolism, Indian cities rely on manual reporting and sporadic audits. The National Urban Digital Mission offers an opportunity to institutionalise data-driven waste governancethrough smart bins, geo-tagged collection routes, and open dashboards for public account-

Communities—especially women-led households, resident welfare associations, and youth groups—can anchor behavioural transitions. Yet, public awareness campaigns remain sporadic and top-down. Behaviour change communications are often limited to poster drives or punitive fines, without fostering long-term collective ownership. Cities like Indore and Surat, which have climbed the cleanliness rankings. did so by coupling civic participation with decentralised infrastructure. Similarly, urban circularity efforts must be hyperlocal—linking community Material Recovery Facilities with micro-enterprises, and deploying reward-based models to incentivise low-waste behaviours. Plastic-free bazaars, zero-waste housing societies, and school-led audit programmes must move from pilot to policy.

The consequences of inaction are not distant-they are already unfolding. Plastics contribute directly to India's emissions burden. Uncollected plastics clog storm drains, fuel landfill fires, and leach toxins into urban water systems. The public health fallout-ranging from microplastic ingestion to respiratory diseases—is already visible in high-density informal settlements where waste collection is weakest. In a warming world, plastic pollution acts as a threat amplifier—intensifying the frequency and scale of urban climate disasters. Cities that continue to manage waste in isolation from climate and health goals will remain locked in a reactive cycle—cleaning up after disasters rather than building resilience before

they strike. India has positioned itself globally as a champion of sustainable lifestyles through its LiFE campaign and has led calls at the G20 and United Nations Environment Assembly (UNEA) for collective action on plastic pollution. Yet, if this global vision is to be credible, it must be backed by transformative change in India's cities. Combatting plastic pollution is no longer an issue of local cleanliness; it is a strategic imperative for national climate resilience. economic efficiency, and social equity. World Environment Day 2025 offers a moment not just for reflection but for redesign. The plastic crisis is an urban crisis, and solving it demands a new generation of Indian cities that are circular by principle, inclusive by design, and resilient by default. (Courtesy: ORF)

# Russian attacks kill 3, wound 64 as drones hit Kharkiv, other parts of Ukraine

We stand strong. We help one another. And we will endure, says Terekhov

KYIV, June 11: Russian forces launched a new drone assault across Ukraine overnight on Wednesday, killing three people and wounding 64 others, Ukrainian officials said.

One of the hardest-hit areas was the city of Kharkiv in northeastern Ukraine, where 17 attack drones struck two residential districts, Mayor Ihor Terekhov said. Emergency crews, municipal workers and volunteers worked through the night to extinguish fires, rescue residents from burning homes, and restore gas, electricity and water services.

"Those are ordinary sites of peaceful life — those that should never be targeted," Terekhov wrote on Telegram

Three people were confirmed killed, according to Kharkiv regional head Oleh Syniehubov. In a statement, Ukrainian President Volodymyr Zelenskyy said that 64 people had been wounded and reiterated his calls for greater international pressure on Moscow.

"Every new day now brings new vile Russian attacks, and almost every strike is telling," he said. "We must not be afraid or postpone

#### Jaishankar meets EU Parl Prez, discusses ways to strengthen ties

BRUSSELS, June 11: External Affairs Minister S Jaishankar Wednesday met European Parliament President Roberta Metsola here and discussed ways to further strengthen the EU-India strategic partnership

Jaishankar, who is travelling to Europe to boost bilateral ties and reaffirm India's policy of zero-tolerance against terrorism, also met leaders of the European Parliament and welcomed their support for "stronger" India-EU relations.

"A warm conversation with @EP\_President Roberta Metsola in Brussels this morning. Discussed further strengthening of India-EU parliamentary ties, building upon our shared values of democracy and pluralism," he said

in a post on X. 'Value her positive sentiments on advancing our partnership in trade, technology and security," the minister added. Metsola said she was delighted to welcome Jaishankar to the European Parliament.

"As negotiations on a free trade agreement advance, we look forward to transform commitments into actions and to strengthen the strategic partnership between Europe and India," she added. Jaishankar, who is travelling to Europe a month after India launched Operation Sindoor in response to the Pahalgam attack said he had a "pleasure interacting" with European Parliament members Angelika Niebler, Urmas Paet, Pilar del Castillo, Vladimir Prebilic, and Winkler Gyula on Tuesday.

"Welcomed their support for stronger India-EU ties. Also appreciate their understanding of India's right to defend itself against terrorism," he said, adding that they "exchanged perspectives on global developments and regional issues."

Jaishankar has also met European Commission President Ursula von der Leyen and praised her "strong condemnation" of the Pahalgam attack and solidarity in combating terrorism.

The April 22 Pahalgam terror attack claimed 26 lives, following which India carried out precision strikes on terror infrastructure in Pakistan and Pakistan-occupied Kashmir on May 7. (PTI)

WARSAW, June 11: Prime Minister Donald Tusk defended his centrist, pro-European government before parliament on Wednesday, seeking to reassert control and rally his fractured coalition after suffering a bitter political defeat. Tusk requested a vote of confidence in the wake of the June 1 loss of Warsaw Mayor Rafal Trzaskowski — his close ally — to nationalist historian Karol Nawrocki. Backed by US President Donald Trump, Nawrocki is set to replace outgoing President Andrzej Duda, another conservative who repeatedly blocked Tusk's reform efforts.

"I am asking for a vote of confidence with full conviction that we have a mandate to govern, to take full responsibility for what is happening in Poland," Tusk said. Most of the power in Poland's parliamentary system rests with an elected parliament and a government chosen by the parliament. However, the president can veto legislation and represents the country abroad.

"Anyone who is ready to move forward with me, with the government, and above all with our voters, regardless of these momentary emotions, and build a better Poland, should vote today for a vote of confidence in our government," Tusk said.

The vote, scheduled for Wednesday afternoon, is widely expected to go in Tusk's favour. His four-party coalition holds a narrow but stable majority in the 460-seat Sejm, Poland's lower house.

A loss would trigger the formation of a caretaker government and may open the door for an early parliamentary election. That could potentially returning power to the conservative Law and Justice party, in coalition with the far-right Confederation party, whose candidate placed third in the presidential race.

Tusk had long counted on a Trzaskowski victory to break the institutional deadlock created by Duda's vetoes. Instead, he now faces an incoming president aligned with the nationalist opposition and openly hostile to his government's legislative priorities.

"We cannot close our eyes to reality," he said. "A president who was reluctant to accept the changes we proposed for Poland and our voters is being replaced by a president who is at least equally reluctant to those changes and proposals." But he also argued that Trzaskowski's narrow defeat indicates that there is continued strong support for those who share his views.

The election result has rattled the already uneasy governing coalition, which spans from centre-left to centre-right and has struggled to deliver on key campaign pledges, including liberalizing Poland's abortion law and legalizing same-sex civil unions. Tusk acknowledged the growing strains in Wednesday's ad-

# S Korea halts propaganda broadcasts along border with rival North in move to ease tensions

SEOUL, June 11: South Korea's military shut down loudspeakers broadcasting anti-North Korea propaganda along the inter-Korean border on Wednesday, marking the new liberal government's first concrete step toward easing tensions between the war-divided rivals.

The South resumed the daily loudspeaker broadcasts in June last year following a yearslong pause in retaliation for North Korea flying trash-laden balloons toward the South in a psychological warfare campaign

South Korea's Defence Ministry said the move, ordered by President Lee Jae-myung, was part of efforts "to restore trust in inter-Korean relations and promote peace on the Korean Peninsula"

Kang Yu-jung, Lee's spokesperson, described the decision as a "proactive step" to reduce military tensions and ease the burden for South Koreans residing in border areas, who have also been affected by North Korea's retaliatory loudpeaker broadcasts.

North Korea, which is extremely sensitive to any outside criticism of its authoritarian leadership and its third-generation ruler, Kim Jong Un, didn't immediately comment on the step by Seoul.

South Korea reactivated its front-line loudspeakers to blast propaganda messages and K-pop songs toward the North last year in response to thousands of trash balloons that Pyongyang flew toward South Korea to drop substances including wastepaper, cloth scraps, cigarette butts and even manure.

From May to November last year, North Korea flew about 7,000 balloons toward South Korea in 32 separate occasions, according to the South's military. The North said that its balloon campaign came after South Korean activists sent over balloons filled with anti-North Korean leaflets, as well as USB sticks filled with popular South Korean songs and dramas. Trash carried by at least one North Korean balloon fell on the South Korean presidential compound in July, raising concerns about the vulnerability of key South Korean facilities. Officials said that the balloon contained no dangerous material and no one was

The South's broadcast playlist was clearly designed to strike a nerve in Pyongyang, where Kim's government has been intensifying a campaign to eliminate the influ-



and language among the population in a bid to strengthen his family's dynastic rule.

The Cold War-style psychological warfare campaigns added to tensions fuelled by North Korea's growing nuclear ambitions and South Korean efforts to expand joint military exercises with the United States and strengthen threeway security cooperation with

**Efforts to improve relations** Lee, an outspoken liberal who took office last week after winning an early election to replace ousted conservative Yoon Suk Yeol, has vowed to improve relations with Pyongyang, which reacted furiously to Yoon's hard-line policies

and shunned dialogue. During his election campaign, Lee promised to halt the loudspeaker broadcasts, arguing that they created unnecessary tensions and discomfort for South Korean residents in border towns. In recent months, those residents had complained about North Korea's retaliatory broadcasts, which included howling animals, pounding gongs

and other irritating sounds. In a briefing on Monday, South Korea's Unification Ministry, which handles inter-Korean affairs, also called for South Korean civilian activists to stop flying anti-North Korean propaganda leaflets across the border. Such activities "could heighten tensions on the Korean Peninsula and threaten the lives and safety of residents in border areas," said Koo Byoungsam, the ministry's spokesperson.

In his inaugural address last week, Lee vowed to reopen communication channels with North Korea. But prospects for an early resumption of dialogue between the rival Koreas remain dim. North Korea has consistently rejected offers from South Korea and the

nuclear talks between Washington and Pyongyang collapsed over sanctions-related disagreements.

The North's nuclear threats

North Korea's priority in foreign policy is now firmly with Russia, which has received thousands of North Korean troops and large amounts of military equipment in recent months for its war with Ukraine. South Korean and US officials have expressed concern that Kim in return could seek Russian technology transfers that could enhance the threat posed by his nuclear weapons and missile programme.

Yoon, who was removed from office in April over his short-lived imposition of martial law in December, had focused on strengthening military partnerships with Washington and Tokyo and on securing stronger US assurances of a swift and decisive nuclear response to defend the South against North Korean nuclear attack.

# Rights group says global brands at risk of links to forced labour in China's minerals industry

among dozens of companies at risk of using forced labour through their Chinese supply chains because they use critical minerals or buy minerals-based products sourced from the farwestern Xinjiang region of China, an international rights group said Wednesday.

The report by the Netherlands-based Global Rights Compliance says companies including Avon, Walmart, Nescafe, Coca-Cola and paint supplier Sherwin-Williams may be linked to titanium sourced from Xinjiang, where rights groups allege the Chinese government runs coercive labour practices targeting predominantly Muslim Uyghurs and other Turkic minorities.

The report found 77 Chinese suppliers in the titanium, lithium, beryllium and magnesium industries operating in Xinjiang. It said the suppliers are at risk of participating in the Chinese government's "labour transfer programmes," in which Uyghurs are forced to work in factories as part of a long-standing campaign of assimilation and mass detention.

Commercial paints, thermos cups and components for the aerospace, auto and defence infrom Xinjiang, the report said. It said that companies must review their supply chains. "Mineral mining and processing in (Xin-

dustries are among products sold internationally that can trace their supply chains to minerals

jiang) rely in part on the state's forced labour



programmes for Uyghurs and other Turkic people in the region," the report said.

The report came as China and the United States, the world's two largest economies, said that they have agreed on a framework to get their trade negotiations back on track after a series of disputes that threatened to derail them.

The two sides on Tuesday wrapped up two days of talks in London that appeared to focus on finding a way to resolve disputes over mineral and technology exports that had shaken a fragile truce on trade reached in Geneva last month. The Chinese government has rejected the UN claims and defended its actions in Xinjiang as fighting terror and ensuring stability.

In 2021, then US President Joe Biden signed a law to block imports from the Xinjiang region unless businesses can prove the items were made without forced labour. The law initially targeted solar products, tomatoes, cotton and apparel, but the US government recently added new sectors for enforcement, including aluminum and seafood.

LONDON, June 11: Senior US and Chinese negotiators have agreed on a framework to get their trade negotiations back on track after a series of disputes that threatened to derail them, both sides have said.

The announcement came at the end of two days of talks in the British capital that wrapped up late Tuesday.

The meetings appeared to focus on finding a way to resolve disputes over mineral and technology exports that had shaken a fragile truce on trade reached in Geneva last month. It's not clear whether any progress was made on the more fundamental differences over China's sizeable trade surplus with the United States.

"First we had to get sort of the negativity out and now we can go forward," US Commerce Secretary Howard Lutnick told reporters after the meetings. Asian stock markets rose Wednesday after the agreement was announced. The talks followed a phone call between President Donald Trump and Chinese leader Xi Jinping last week to try to calm the waters.

Li Chenggang, a vice minister of commerce and China's international trade representative, said the two sides had agreed in principle on a framework for implementing the consensus reached on the phone call and at the talks on Geneva, the official Xinhua News Agency said.

Further details, including any plans for a potential next round of talks, were not immediately available.

Li and Wang Wentao, China's commerce minister, were part of the delegation led by Vice Premier He Lifeng. They met with Lutnick, Treasury Secretary Scott Bessent and Trade Representative Jamieson Greer at Lancaster House, a 200-year-old mansion near Buckingham Palace.

# Trump says will 'liberate' Los Angeles in speech to mark 250th anniversary of Army

FORT BRAGG (US), June 11: President Donald Trump called protesters in Los Angeles "animals" and "a foreign enemy" in a speech at Fort Bragg on Tuesday as he defended deploying the military on demonstrators opposed to his immigration enforcement raids and as he vowed to "liberate" the

West Coast city. Trump, in his most aggressive language yet regarding the protests, used a speech ostensibly supposed to be used to recognise the 250th anniversary of the US Army to denounce the protesters while repeating his false statements about the 2020 election being rigged and attacking the previous commander in chief, former

President Joe Biden. The Republican president, who sees the military as a critical tool for domestic goals, has used the recent protests in Los Angeles as an opportunity to deploy the National Guard and US Marines over the objections of California's Democratic governor.

Protesters blocked a major freeway and set cars on fire over the weekend in Los Angeles, but the demonstrations in the city of 4 million people have largely been centred in several blocks of downtown.

"We will not allow an American city to be invaded and conquered by a foreign enemy. That's what they are," Trump said Tuesday.

Trump's heated rhetoric came as he has left open the possibility of invoking the Insurrection Act, one of the most extreme emergency powers available to the president. It authorises him to deploy military forces inside the US to suppress rebellion or domestic violence or to enforce the law in certain situations. Trump received plenty of cheers from the crowd, which laughed at the president's jokes and delighted in his dancing to his campaign anthem of "YMCA." However, some members of the audience were uneasy with certain

aspects of his remarks. Robin Boothe, who voted for Trump and works on the base as an audiology assistant, said the speech was "classic Trump." However, she also found it to be too partisan, especially his comments on Los Angeles.

"I thought that was better left for a news conference than what we were celebrating today," the 50year-old said.

The president called Los Angeles "a trash heap" with "entire neighbourhoods under control" of criminals and said the federal government would "use every asset at our disposal to quell the violence and restore law and order."

"We will liberate Los Angeles and make it free, clean and safe again," Trump said. Trump authorised the deployment of 4,000 National Guard soldiers to the city against the wishes of California Gov. Gavin Newsom. About 700 Marines were deployed to the Los Angeles area but had not yet been sent to respond to the protests.

Newsom asked a federal court Tuesday to block Trump from



using the military in his city. California leaders accused Trump of fanning protesters' anger and stoking the unrest.

In an address Tuesday evening, Newsom warned: "California may be first, but it clearly will not end here. Other states are next. Democracy is next. Democracy is under assault before our eyes.'

Trump also announced his administration was restoring the names of seven military bases that

were given the monikers of Confederate leaders until being changed by the Biden administration. Fort Pickett, Fort Robert E. Lee and Fort A.P. Hill in Virginia, Fort Hood in Texas, Fort Gordon in Georgia, Fort Rucker in Alabama and Fort Polk in Louisiana will have their names changed back, Trump said.

Defence Secretary Pete Hegseth has already brought back the names of Fort Bragg and Fort Benning in Georgia.

"Can you believe they changed that name in the last administration for a little bit?" Trump said. "We'll forget all about that.'

As they did when they changed back Fort Bragg and Fort Benning, Defence officials announced Tuesday that they had identified service members with the same last names in order to make the change and not have the bases officially carry Confederate-related names.

Before he spoke, Trump watched the US Army demonstrate a missile strike, a helicopter assault and a building raid, a preview of the kind of show of American military might he's expected to display in the nation's capital for a massive military parade this weekend. Trump has promoted the Army's anniversary as a reason to hold the parade on Saturday, which is also his 79th birthday. Tanks and other vehicles will roll down city streets in a reminder of how the Republican president is reshaping the armed forces after returning to the White House this year.

"I think it's going to be great," Trump told reporters at the White House earlier Tuesday. "We're going to celebrate our country for a change." As a backdrop to the parade, "No Kings Day" protests are planned across the country on Saturday to push back against what critics see as the administration's draconian policies. Trump said earlier Tuesday that there would be more immigration raids and that any additional protests would be met with even greater force, including those who show up at the

If they do, Trump said, "they will be met with very big force." "I haven't even heard about a

protest but you know, this is people that hate our country. But they will be met with very heavy force." Newsom weighed in Tuesday on

the parade, accusing Trump of forcing the military "to put on a vulgar display to celebrate his birthday, just as other failed dictators have done in the past." (AP)

#### Arunachal sends fourth batch of trainees to Premier Drone Academy in Hyderabad

# Joint civil-military mock drill on disaster preparedness conducted successfully in Tawang

NAMSAI, June 11: A large-scale joint civil-military mock drill on disaster preparedness was successfully conducted on Wednesday at Mhentsang Rong (Bomdir Nallah) in Tawang, aimed at enhancing inter-agency coordination and strengthening response mechanisms in the event of natural disasters such as landslides, earthquakes, flash floods, and fires.

The mock drill commenced at 11:30 AM and was personally supervised by Brigadier Bhupal Singh, SM, Commander of the Tawang Brigade. The meticulously planned exercise saw active participation from multiple agencies including the Indian Army, 38th Battalion of Sashastra Seema Bal (SSB), 55th Battalion of Indo-Tibetan Border Police (ITBP), 12th Battalion of the National Disaster Response Force (NDRF), Tawang Fire Brigade, Tawang Police, KDS District Hospital medical team, and Veterinary Officers from the Department of Animal Husbandry & Veterinary, Tawang.

Preparations for the drill began a

day earlier, on June 10, with a thorough inspection of static equipment and a joint briefing session chaired by Brigadier Singh and District Dis-Management Officer (DDMO) Genden Tsomu at the Brigade Headquarters. Detailed response protocols were discussed to ensure seamless coordination during the exercise. The mock drill was carried out across five different locations, simulating multiple disaster scenarios to evaluate the efficiency. agility, and coordination of rescue operations under high-pressure conditions. These included realistic enactments of landslides, fire outbreaks, flash floods, and earth-

quakes During the debriefing session, Brigadier Singh lauded the performance and cooperation of all participating teams. He emphasized that while drills are valuable, actual disaster situations demand rapid and

well-coordinated responses, citing past experiences with flash floods in the region. "A moment's delay can cost lives," he said, urging personnel to maintain a constant state of

Brigadier Singh further proposed the identification of responsible individuals in every locality to disseminate early warnings during emergencies. Highlighting the critical nature of the first two hours following a disaster, he advised communities in vulnerable areasparticularly those located near steep slopes or densely populated zones-to develop localized disaster management plans with clearly marked evacuation routes.

He also stressed the need for regular mock drills, particularly during the monsoon season, to reinforce preparedness. He recommended that communities be equipped with basic first-aid knowledge and ensure pre-stocking of essential supplies such as food, water, and medicine in disaster-prone zones.

This joint exercise reflects the unwavering commitment of both civil and military agencies to protect lives and minimize disaster impact through proactive planning and coordination.

# More than a hundred villagers participated in the construction of the bridge

NAMSAI, June 11: A one-day online training programme on e-Compliance and e-File Management Skills was conducted recently for officers and officials of the Arunachal Pradesh State Human Rights Commission (AP-SHRC) by officials of the National Human Rights Commission (NHRC). The training aimed to equip participants with essential tools and knowledge to efficiently manage human rights violation cases using digital platforms.

The objective was to enhance the competencies of officials in the diarization process, complaint handling, and systematic documentation of human rights-related cases. Special focus was placed on utilizing digital systems for case registration, action taken reports, tracking file movements, document management, dashoperations, reporting procedures, and the use of the Central Registry System to ensure a seamless and accountable workflow.

NHRC resource persons shared valuable insights, expertise, and practical experiences in diarization of complaints and digital case management techniques.

**HT Correspondent** DIBRUGARH, June 11: In a heartening example of resilience and community spirit, villagers from the remote Chatong village in Arunachal Pradesh have constructed a wooden bridge entirely from their own resources, addressing a longstanding communication bottleneck that had plagued the region for years. Located in the hilly terrain of Longding

district, Chatong is home to the Wancho tribe—a community known for its strong traditions and collective strength. With no financial aid or infrastructural support from the government, the residents of Chatong decided to take matters into their own hands. Coming together as a unified force, the villagers contributed money from their own pockets and built a wooden bridge that now connects them more effectively with the rest of the district.

More than a hundred villagers participated in the construction of the bridge, working shoulder to shoulder. Women from the village also played a vital role by preparing and serving tea and meals to support the men working tirelessly on the



"We have contributed from our own pockets to build the bridge because the government has failed to do so. This bridge will finally ease the communication problem which has long been ignored," said a villager who was part of the initia-

The construction, driven by necessity and frustration over years of official inaction, was completed in just three days. The

bridge is now a critical link for villagers in Chatong, Ozakho, Langmai, and Chajam—all part of eastern Arunachal's Longding district—who had been suffering from a lack of proper connectivity.

Despite the state's recent developmental strides, regions like Longding continue to highlight the uneven spread of infrastructure. In particular, the affected villages had long struggled due to the absence of a reliable bridge, making travel and access to basic services a daunting challenge. Although two roads technically connect these villages, one of the routes—a PMGSY road through Chibam block—has remained completely non-motorable, making it useless for daily travel or transport of goods.

As a result, villagers were forced to take a much longer alternative route, traveling nearly 40 kilometers through neighboring Tirap district just to reach their own district headquarters, Longding. This detour not only increased travel time but also exacerbated the daily hardships faced by the community

Years of disappointment and unmet promises from successive governments and relevant departments had led to growing frustration. That frustration eventually turned into determination, as villagers turned to community labour and local materials to create a functional bridge that could serve their needs

"It took around three days to complete the construction of the bridge, which is now expected to significantly ease the dayto-day struggles of the villagers," said

Jacob Wangsu, President of the Chatong Students' Union.

"When the government didn't step in, our people took it upon themselves to build what was necessary," he added, underscoring the people's sense of ownership

and agency in solving their own problems. The four villages collectively comprise around 500 households and fall under the Kanubari Legislative Assembly Constituency, currently represented by Minister Gabriel D. Wangsu. Despite being under a sitting minister's jurisdiction, the plight of these villagers had gone unnoticed and unaddressed for years, further fueling their decision to act independently.

This remarkable example of grassroots initiative stands as a testament to the strength and unity of rural communities. While it highlights the tenacity of the people, it also casts a spotlight on the continuing infrastructural and administrative gaps that still exist in many parts of Arunachal Pradesh. The bridge, though modest in appearance, carries with it the weight of collective effort, hope, and the unspoken question-when will the government finally catch up?

# Mahayuti to contest local body elections together: Fadnavis

June 11: The BJP-led Mahayuti alliance will contest the upcoming local body elections in the state together except for friendly fights where tie-ups do not materialise. Maharashtra Chief Minister Devendra Fadnavis said on Wednes-

Elections to several municipal corporations and other local bodies, including the Brihanmumbai Municipal Corporation, have been pending for the last three years.

The state BJP president, working president, and the election committee of the party are authorised to take decisions related to the local bodies elections, Fadnavis told reporters in Akola after launching irrigation and power generation projects.

"We have decided to contest the polls as an alliance. There will be friendly fights wherever a tie-up does not work out," he added.

The Ajit Pawar-led Nationalist Congress Party and Eknath Shinde-led Shiv Sena are the two other members of the alliance.

When asked about Prahar Janshakti Party leader Bachhu Kadu's hunger strike, Fadnavis said district guardian minister Chandrashekar Bawankule will speak to him. Kadu is on hunger strike for

# 12 dead, over 2 dozen injured in separate road accidents across Rajasthan JAIPUR, June 12: At least 12

people were killed and over two dozen were injured in three separate road accidents in Jaipur, Jaisalmer and Jalore districts of Rajasthan, police said on Wednes-

In Jaipur, five people, including a newly-wed bride, were killed while eight others suffered injuries after a multi-utility vehicle (MUV) carrying a wedding party collided head-on with a truck early Wednesday morning, officials said.

The accident occurred near Bhatkabas village on the Dausa-Manoharpur highway under Raisar police limits. The victims were travelling from Shahdol in Madhya Pradesh to Udaipurwati in Jhunjhunu district when the accident

"The impact was so severe that the vehicle was completely mangled. Several passengers were trapped and could only be extricated after intense rescue efforts," a police official said.

The deceased include Bharati (18), the bride; Jeetu (33) Subhash (28), Ravi Kumar (17) and another person whose identity is yet to be ascertained.

The groom, Vikram Meena (25), is among those seriously injured and is undergoing treatment at a

private hospital, police said. In Jaisalmer, three people including the groom and a ninemonth-old child were killed and four others were injured when an unidentified vehicle collided with

"Shiv Sena party chief (Thackeray) has authorised local leaders and asked them to review where polls can be fought in an alliance. At places where it is not possible, we can contest independently or not. A decision will be taken by the party chief. A decision on (whether to contest the) Mumbai (polls as an alliance or independently) will also be taken," Raut said.

The stage is set for the muchawaited elections to civic bodies, with the state government issuing a notification to finalise ward boundaries. The move follows a Supreme Court directive last month asking the SEC to proceed with the elections while hearing petitions related to the OBC quota and ward delimitation. Civic body polls in the state have been pending for two years. (PTI)

#### ED searches on Cong MP, MLAs 'conspiracy to divide party in Karnataka: Kharge

KALABURAGI (KARNATAKA), June 11: Congress President Mallikarjun Kharge on Wednesday termed the Enforcement Directorate (ED) searches against a party MP and three MLAs in the state, as a "conspiracy" to divide the party in Karnataka.

Without taking the name of the ruling BJP at the Centre, he claimed that the grand old party was being targeted, aimed at creating difference within the party, to reap benefits out of it, but they wouldn't be successful in their attempts as all Congress legislators are united. "I don't know the details. I just saw it on TV. Naturally, if the ED has done it, they have been angry with the Congress party since the beginning. If they are targeting the Congress MLAs, there seems to be a conspiracy to divide our party," Kharge said.

Speaking to reporters here, he said if they harass them by bringing up something now that is said to have happened during the election, it is not right.

"The matter should have been looked into during the election, but after one year, one-and-half year, if they are taking it up now, it seems to be an attempt to divide the party legislators here. Let's see how the ED takes the case. I will get information from the CM over the phone and see what needs to be done," he

The ED on Wednesday conducted searches against

Congress Ballari MP E Tukaram and three MLAs of the party as part of a money laundering investigation into the alleged Valmiki scam-linked money laundering case, official sources said.

They said five premises in Ballari and three in Bengaluru city are being searched under the provisions of the Prevention of Money Laundering Act (PMLA). These include houses belonging to Tukaram and MLAs Nara Bharath Reddy (Bellary city), J N Ganesh (Kampli) and N T Srinivas (Kudligi). To a question about an allegation by the ED that the corporation's money was misused, Kharge said, "They may say so. It is a matter left to ED. I will not interfere. Such inquiries happen. During elections, crores of rupees are seized. Where is it? To whom does it belong? So far, things haven't come out. Money was seized from all parties then. Where is that money?"

Noting that everyone knows who spends how much during elections, while indicating to the BJP, he said, "They especially target one party (Congress) because, if they trouble this party naturally, there will be differences within and they feel that it will benefit them. But it is impossible. Despite all their harassment, all our MLAs are united and this is nothing new in Karnataka...I don't want to comment more until the inquiry is completed," he added. (PTI)

# Rahul writes to PM, flags delay in scholarships for students from marginalised communities

**NEW DELHI, June 11:** Leader of Opposition in the Lok Sabha Rahul Gandhi has written to Prime Minister Narendra Modi flagging the "deplorable" conditions in residential hostels for Dalit, ST, EBC. OBC and minority students and the delay in post-matric scholarships for those from marginalised com-

In his letter to Modi, Gandhi urged the PM to resolve these two critical issues which he said hinder education opportunities for the 90 per cent of students who are from marginalised communities.

"Firstly, the conditions in residential hostels for students from Dalit, ST, EBC, OBC and minority communities are deplorable. During a recent visit to Ambedkar Hostel in Darbhanga, Bihar, students complained about single rooms which 6-7 students were forced to share, unhygienic toilets, unsafe drinking water, lack of mess facilities, and no access to libraries or the internet," the Congress leader said.

"Secondly, post-matric scholarships for students from marginalised communities are plagued by delays and failures," Gandhi said and cited the example of Bihar where he claimed the scholarship portal was non-functional for three years and no student received a scholarship in 2021-22.

"Even thereafter, the number of Dalit students receiving scholarships fell by nearly half, from 1.36 lakh in FY23 to 0.69 lakh in FY24. Students further complain that the scholarship amounts are insultingly low," Gandhi said in his letter to Modi dated June 10.

"While I have cited examples from Bihar, these failures are widespread across the country. I urge the government to immediately take two actions to remedy these failures," he said.

Gandhi called for an audit of every hostel for students from Dalit, Scheduled Tribes (ST), Economically Backward Class (EBC), Other Backward Classes (OBC) and minority communities to ensure good infrastructure, sanitation, food and academic facilities; and allocate adequate funds to address deficiencies.

He also appealed for disbursement of post-matric scholarships on time, increasing scholarship



amounts, and improving execution by working closely with state governments.

"I am sure you agree that India cannot progress unless youth from marginalised progress. I look forward to your positive response," Gandhi said in his letter to Modi

The issues were also raised at a joint press conference by Congress' SC department chief Rajendra Pal Gautam, Adivasi Congress chief Vikrant Bhuria and AICC NSUI in-charge Kanhaiya Kumar at the Congress' Indira Bhawan headquarters.

Kumar said Gandhi is continuously meeting students, employees and teachers from Dalit, backward, tribal, extremely backward and minority classes.

"Whenever we meet students from these classes, the first thing they say is that we do not get our scholarship on time. Scholarship drop out is very high in the country, because the government has made the entire scholarship process a punishment," Kumar

"Rahul Gandhi has written a letter to Prime Minister Modi on the scholarship of students, other problems and hostel conditions. However, what action the government takes on this will be known only in the coming time," he said.

Kumar said student suicide is a ig issue in the country with two students committing suicide every

"The government is continuously reducing the education budget. Apart from this, the money of SC/ST sub-plan is also being di-

said.

The result is that children are struggling for basic rights like education and this is a big injustice against the deprived class, Kumar

In his remarks at the presser, Gautam said, "Recently, Leader of Opposition Rahul Gandhi visited Dr. Ambedkar Hostel in Darbhanga. Students from various hostels came and met him there. What Rahul Gandhi saw was very sad and heartbreaking. There he saw that 6-7 students live together in one room, toilets are in a very dirty condition, there is no arrangement for drinking water, there is no facility of books in the library, there is no internet facility, and there is no facility of good food." Gautam

Children of SC/ST, EBC and minority class are forced to study in very bad conditions, he claimed.

'Even their scholarship is not given, because sometimes the server of the government portal is down, sometimes it does not work at all," he said.

Gautam also flagged the issue of suicides in hostels, saying biggest reason for this is the poor financial condition of many children, in which parents take loans at high interest rates for the child's educa-

"Children think that they will study diligently, if they get scholarship, they will repay the loan taken for studies, but when the scholarship does not come, the loan keeps increasing, then the children come under pressure and take steps like committing suicide. It is sad that the government is not serious in this matter," he said. (PTI)

# Hope prayers for peace, progress Shukteerth embodies 5,000-year-old legacy, will be answered: Farooq Abdullah no other faith can claim that: Adityanath

MUZAFFARNAGAR (UP), June 11: Shukteerth is not just a spiritual site but a living testimony to India's 5,000-year-old cultural and religious heritage, which is singular in the world, Uttar Pradesh Chief Minister Yogi Adityanath on Wednesday said.

Addressing a gathering of saints on the 65th death anniversary of Swami Gyan Bhikshuk Das Ji Maharaj, Adityanath said, "When the country was struggling under foreign invasions during the medieval period and its culture and religion were under attack, Satguru Ravidas Ji emerged as a divine light.

Ravidas led by example, offering the nation spiritual guidance that still resonates today, he said.

"He raised awareness against social evils and blind practices, inspired faith in action over ritual, and kindled spiritual consciousness," Adityanath said, and quoted the saint's famous saving, 'Mann changa to katoti mein Ganga' - If the mind is pure, divinity resides even in the smallest vessel.

The gathering also remembered Satguru Samandas Ji Maharaj. Adityanath said saints have always had a role in building a cohesive society.

"It is this path that prevents (reported exodus) incidents like those in Kairana and Kandhla, provides us security, guidance, and the courage to face adversity," he said.

He paid his tributes to Shukteerth as the place that has "stood for over 5,000 years."

"If there is any tradition in the world with such a long documented history, let it come forward. Only you (referring to the saints) can lay claim to such an eternal heritage," he said.

Shukteerth, or Shukratal, in Muzaffarnagar draws pilgrims from across India. It is the site where Sukadeva Goswami is believed

to have recited the Srimad-Bhagavatam to King Parikshit, Abhimanyu's son, nearly 5,000 years ago. Nestled along the banks of the Ganga River, the destination lies approximately 28 kilometres from Muzaffarnagar.

Ravidas, Adityanath noted, said he would be happy only when every person gets equal rights and food without discrimination.

That ambition, he said, was fulfilled by Prime Minister Narendra Modi through the Pradhan Mantri Garib Kalyan Anna Yojana, under which 81 crore people received free food grains, even during the pandemic. "This is the true spirit of the saints' teachings,"

The CM said that before 2014, roads to Sant Ravidas' birthplace Sear Govardhan were single-lane. It is now connected via a four-lane road. A grand ashram, a magnificent statue, and an 'Anna Kshetra' have been built in the area. Land has been acquired for a park and statue in tribute to the saint, he said.

The BJP leader also said that a ghat and a parking lot will be developed around the Samandas Ashram, roads there will be widened and the area beautified. He also criticised past governments for "failing" to honour BR Ambedkar adequately. (PTI)

istry shows. According to the latest data from the Indian SARS-CoV-2 Genomics Consortium (INSACOG), 206 cases have been linked to XFG variant, with the highest count of 89 infections coming from Maharashtra, followed by West Bengal reporting 49.

Dr Bhargava said the XFG variant of SARS-CoV-2 (which causes COVID-19) carries mutations which may improve its ability of binding to human cells and bypassing immune defences.

"Early reports suggest that the variant has high immune escape potential, but there is no current evidence to indicate (an) increased severity (of disease)," he said. Other states reporting infections

due to the XFG variant are Kerala (15), Tamil Nadu (16), Gujarat (11), Madhya Pradesh (6), Andhra Pradesh (6), Odisha (4), Puducherry (3), Delhi (2), Raiasthan (2), and Punjab, Telangana and Haryana (one each).

However, similar to how the virus adapts, so has India's diagnostic infrastructure since the first wave of the pandemic, and the RT-

India has seen 74 deaths in the current surge in COVID-19 cases, which started January this year. Kerala continues to be the most affected with over 2.200 cases, followed by Gujarat (1223) and Delhi (757). Official sources have said that most cases are mild and can be managed under home care, even as all states have been instructed to ensure availability of oxygen, isolation beds, ventilators, and essential medicines, amidst rising cases of COVID-19. INSACOG data also shows that 21 of the newly emerging cases are linked to the LF.7 variant -- Maharashtra and Gujarat reporting the highest with six cases each -- and two to the NB.1.8.1 variant -- one each in Maharashtra and Tamil Nadu. # Naga delegation begins historic repatriation process of ancestral remains from Oxford Museum

**DIMAPUR, June 11:** Naga elders and leaders from various 'Naga tribe hohos', accompanied by members of the Forum for Naga Reconciliation (FNR) and Recover, Restore, and Decolonise (RRaD), met with the administration of the Pitt-Rivers Museum (PRM) at the University of Oxford to initiate the repatriation process of Naga ancestral human remains that had been displayed in the museum until 2020 on June 9, according to a press release by the FNR.

The Naga delegation was welcomed into the museum by Director. Professor Dr Laura van Broekhoven and members of her staff from PRM, the press note also said. "It has been a long journey to get to this moment", said Prof van Broekhoven, as she welcomed the delegation.

"I am very pleased we are now at this moment of the process, that we were able to welcome all of you to Oxford", she stated.

Prof van Broekhoven added that ...over a century ago, the first Naga ancestral human remains were donated by (John Henry) Hutton to the Pitt Rivers Museum. Many others followed later. These ancestral remains have been in our care since then. We know that this week will be one that we will both feel grief and sadness when looking back on that past, and also we will feel hope as we work towards reconciliation and healing in the future. I hope we



can support and hold each other throughout this process", the press release also said.

In response to the welcome, Reverend Dr Ellen Konyak Jamir, coordinator of RRaD and member of FNR, stated that the Naga delegation had arrived with hearts heavy with history, the press release stated. She explained that their presence represents a sacred journey that began five years ago to repatriate the physical remains of Naga ancestors who were taken away and have resided within the walls of PRM for generations.

Acknowledging the complex and painful colonial past that led to their presence here, Dr Konyak-Jamir remarked, "We recognise and express our sincere appreciation for the PRM's commitment to change, and

ethical stewardship. She praised their courage in confronting complicated histories and their dedication to the process of repa-

"We come with hope in the process, may this journey appease our

ancestors and our communities," Dr Konyak-Jamir said, as she requested Dr Visier Sanyü, an elder from FNR, to share the Indigenous chant before the process began, the FNR press re-

lease added Dr Sanyü's chant, titled "Our Ancestor", alluded to the parting of the Naga ancestor from the creator.

The verse concluded with the hope that the ancestor would be reunited with the creator and aid in healing the wounds of the past.

The keynote address was delivered by Thejao Vihienuo, president of the Angami Public Organisation, who reminded the audience of the history of the Nagas living between the Brahmaputra and Chindwin rivers. Vihienuo emphasised that the Nagas were never conquered until the British invaded their land in the nineteenth century and divided their ancestral

"We have embarked on this historic journey, not only for the repatriation of our ancestors but also as a journey towards the process of decolonisa-

He acknowledged that the ancestral remains displayed in the museum had conveyed the history of the Naga people in silence, the press release also

"We are proud of these ancestors and are here to pay our respectful homage to them," he said.

"Nagas are aware we cannot undo the past. But...we are confident that this process of repatriation will go a long way in healing the wounds of all the people involved," he concluded, the FNR press statement further said.

The Naga delegation then went to the room where the ancestral remains had been placed for them. This was the first time such a dele-

gation had been granted access to the remains since they were removed from the display room. Chanting an incantation to the Blue Sky Father and Mother Earth, Nepuni Piku from FNR, invoked the name of

cestral remains to pay homage and He asked for their goodwill and requested that the ancestors bless those who had come to take them back home, the press note also said.

#### **Brooms, not bars: Manipur Police's** unique approach for protest management

IMPHAL, June 11: In a novel twist to conventional policing, Manipur Police has traded handcuffs for brooms and shovels, initiating a "community service" programme for dozens of youths detained in various districts of the valley during violent protests since June 7. This unique approach follows the unrest which was witnessed on the streets after the arrest of prominent Arambai Tenggol leader Asem Kanan Singh and four associates during a joint operation of Manipur Police and the CBI as he was wanted in several cases.

During the protests, people demanded unconditional release of Singh and others, leading to a 10-day bandh called by Arambai Tenggol, which was eventually called off on Tuesday. Instead of facing formal charges that could mar their futures, over three dozen young people found themselves on the streets, not as rioters, but as cleaners.

Leveraging the innovative provisions of the recently introduced Bharativa Nagrik Suraksha Sanhita (BNSS), Manipur Police handed them the tools of civic duty – brooms and shovels – to clear the very roadblocks, burnt tyres, and concrete debris they or others had created during the protests.

This unconventional move, police officials said, was a deliberate choice to safeguard the careers of these "misguided youths." By invoking Section 4(f) of the BNSS

which advises community service for firsttime offenders involved in minor misconduct, authorities are offering a path to rehabilitation rather than punitive measures. Widely shared photos and videos show these young people in custody sweeping the



# Zoya Akhtar-Ayesha Sood on 'In Transit': We wanted trans people to tell their own stories

NEW DELHI, June 11: The idea for "In Transit", a four-part docu series about the lives of trans and non-binary individuals, was born out of the many stories filmmakers Zoya Akhtar and Reema Kagti came across while auditioning for a trans character in the second season of their critically-acclaimed series "Made in Heaven".

Directed by Ayesha Sood and produced by Akhtar and Kagti through their Tiger Baby banner, "In Transit" is set to premiere on Prime Video on June

"Made in Heaven" has been praised for giving centrestage to LGBTQ individuals, first with a gay lead in Arjun Mathur's wedding planner Karan and then by introducing a trans character with Meher, who was played by Trinetra Haldar Gummaraju, in season two.

Zoya said they "got crazy feedback from the LGBT community" through the show as the community felt represented in an authentic way.

"When we wrote a trans character, we realised we knew very little... So, we started interviewing people and the people that spoke to us were very honest and they shared a lot, including their dreams. Mehar was a specific kind of character, so that story came out of these interviews.

"We realised that this is something that we need to expand on in a

different format. They need to tell the audience their own story and we pitched that to Amazon Prime who went for it in one call so we are lucky,"

Akhtar told PTI in a virtual interview.

The filmmaker said they decided to rope in Sood to direct the series as they wanted someone who could shepherd the project in an authentic way, without adding any shock value to it.

Sood, a filmmaker, photographer and editor who runs the media company Jamun Collective, said when Akhtar and Kagti approached her with the idea, she was a little flummoxed as trans experience is a huge canvas.

"I was like, 'How do you tell the story of trans people?' Like women in India, the canvas is huge... There are so many diverse experiences of being a woman in India, likewise, being trans in India is our baseline setting and it is vast, unique and complex. How do we bring that out in the stories?

"So, we talk about things that are universally moving to all of us, like identity, our place in the world, our relationships with families and finding love. These are universal things that move everybody," Sood told PTI.

The team had a long period of research, and eventually found a way as well as a structure to tell these stories. "The Indian idea of being

trans is vast. So we wanted to get a

broad range of stories and people from different contexts and we wanted to be uniquely rooted in India. These are real people from different walks of life who are expressing their trans-ness," Sood said.

"It was also a matter of who could tell their stories to us. It's not easy for everyone to be on camera... These are tough lives, so it was also about who could actually tell us these stories," she added.

"In Transit" is the second project from the documentary slate that Akhtar and Kagti are planning to produce through their banner, following "Angry Young Men", a cinematic exploration of iconic screenwriter duo Javed

Akhtar and Salim Khan's filmography. A third, "Turtle Walker" by Taira Malaney, will chronicle the extraordinary journey of conservationist Satish Bhaskar. Akhtar, known for films such as "Luck By Chance", "Dil Dhadakne Do" and "Gully Boy", said she loves documentaries as the format allows a filmmaker to explore different stories. There is also a lot of interest for documentaries in India now, she added.

"There's a lot more exposure and I think people are interested in stories. Certain stories are good as short films, certain things lend themselves to eight hours of narrative. Certain things are good as features, and certain stories

need to be told in their most authentic, true self," Akhtar said.

Sood credited the OTT platforms for nurturing the format.

"We now have a growing audience for documentaries. The platforms are entirely to be praised for this. They have brought documentaries into your living room and everybody is watching them. Along with it, the craft has also elevated."

In "In Transit", Sood brings in a lot of pop culture references to describe the trans experience.

The documentary explores the lives of nine individuals, including a classical musician from Bangalore, a school educator from Tripura and a corporate professional in Mumbai.

The director said these pop culture references show why representation matters, whether it is a film or a television serial like "Hum Paanch".

"That's what people consume and spend their time being inspired, watching and discussing. It wasn't like I needed to get a Bollywood reference out here. It's the world that the charac-

ters live in.

"And those are the things that struck them when they were growing up, like the first time they saw themselves on screen, or the first time they felt something about a character or love or any such thing," she said. (PTI)

# **AUSTRALIA QUALIFY FOR 2026 WORLD CUP WITH 2-1 WIN OVER SAUDI ARABIA**

nor Metcalfe scored his first goal for Australia and Mitchell Duke iced the 2-1 victory in Saudi Arabia that ensured the Socceroos qualified for a sixth straight World Cup.

Needing just to avoid a five-goal defeat to secure direct entry to the 2026 tournament, the Socceroos rallied with Metcalfe equalizing just before halftime with a left-foot strike and Duke putting them ahead with a 48thminute header. Abdulrahman Al Oboud had opened for the Saudis after 19 minutes.

Goalkeeper Mat Ryan made five saves, including a late penalty, in his 100th international for Australia. The Socceroos had to qualify through playoffs in 2018 and 2022 and so earning the direct entry took some pressure off. "We've done the first part qualifying automatically," Socceroos coach Tony Popovic said. "Now the next part is to be bigger



Popovic was part of the Socceroos squad that qualified for 2006, ending a long World Cup drought for Australia, and then reached the second round. Now he has guided another generation of players to the marquee global

"We've built a good foundation now (but) we want to get better, kick on and try and do something special in the World Cup," he said. Earlier, Japan and South Korea ended successful campaigns on a high with emphatic home victories over Indonesia and Kuwait, respectively.

In Osaka, Daichi Kamada scored after 15 minutes to set Japan, preparing for an eighth consecutive World Cup, on its way to a 6-0 victory.

Takefusa Kubo added a second five minutes later and Kamada extended the lead just before the break. Soon after the restart, Ryoya Morishita and Shuto Hosoya made it six.

The Palestinian team was eliminated from contention after conceding a goal seven minutes into stoppage time in a 1-1 draw with Oman, giving the Oman team the last spot in the next round of continental qualifying.

Six qualifiers so far from AsiaAustralia joins already-qualified Japan, Iran, South Korea, Uzbekistan and Jordan i n reaching the expanded 48-team tournament in the United States, Canada and Mexico. Asia's two other automatic places will be settled between the six third- and fourth-place teams. That round takes place in October. The teams will be Oman, Qatar, Iraq, Saudi Arabia, the United Arab Emirates

Earlier, South Korea, which has qualified for an 11th straight World Cup, sealed the top spot in Group B after beating Kuwait 4-

# Man City signs Reijnders from AC Milan to complete \$150M spending spree



Manchester City concluded a \$150 million spending spree ahead of the Club World Cup by announcing the signing of Netherlands midfielder Tijjani Reijnders from AC Milan on Wednesday.

The 26-year-old Reijnders moved for an initial fee of 55 million euros (\$63 million) and is the second midfielder — after France playmaker Rayan Cherki — to join City in the special June 1-10 transfer window created to allow sides in the 32-team Club World Cup to reshape their squads.

City paid Lyon \$41 million for Cherki and also signed Algeria left back Rayan Aït-Nouri from Wolverhampton for \$42 million.

After deciding not to push to sign Florian Wirtz — the Germany playmaker is close to joining Liverpool, according to reports in the British media — City has spent around the same amount on three players.

Add this latest splurge to an outlay of more than \$200 million in the winter transfer window and City has already spent at least \$350 million on players in 2025 to provide manager Pep Guardiola with a squad capable of reclaiming the Premier League title

from Liverpool. Breakthrough seasonReijnders has just been named as the best midfielder in Serie A after a breakthrough campaign in which

MANCHESTER, June 11: he scored 15 goals and added five assists across all competitions for Milan, which endured a dismal season and failed to qualify for Europe. He joined Milan from AZ Alkmaar in 2023 for a fee of around 20 million euros (then \$22.4 million) and recently signed a contract extension through to June 2030. That's the length of his contract at City, too.

City is releasing De Bruyne to end his 10-year stint at the club and now has Reijnders and Cherki to link up with Rodri in an enticing midfield set-up.

June 11: Boos rang out as England left the field after a 3-1 loss to Senegal in a friendly Tuesday which marked the first defeat of Thomas Tuchel's tenure as coach.

Senegal recovered from conceding Harry Kane's early goal to become the first team from Africa to record a victory over England.

"We're not going to panic. But for sure we know we need to do better," England captain Kane told broadcaster ITV and suggested England had lost "that aggressive nature that we've had."

In World Cup qualifying Tuesday, the Netherlands beat Malta 8-0 and Austria beat San Marino 4-0.

England's landmark lossKane was the only player retained in Tuchel's starting lineup from last week's 1-0 win over Andorra. which had caused Tuchel to criticize his team's attitude. The changes brought little improve-



Kane's record-extending 73rd England goal gave his team the lead in the seventh minute, when he bundled in after a goalkeeping error by Edouard Mendy.

# Dressing room seems like a funeral, but we can still qualify: Marquez after Hong Kong defeat

HONG KONG, June 11: "The dressing room is like a funeral (site)," said Indian football head coach Manolo Marquez as he struggled to explain the 0-1 loss to Hong Kong here even though he remained optimistic about the team's chances of qualifying for the 2027 AFC Asian Cup.

India conceded in the fifth minute of stoppage time on Tuesday, slumping to a second straight goalless outing in Asian Cup qualifiers, jeopardising their chances of qualifying for the Asian Cup.

..we are not very happy. We are sad. The dressing room is like a funeral, practically," Marquez said when a question on the future of the team came up, insisting that it was not the time to dwell on that

...But I still think that India has possibilities to qualify," he declared nonetheless in the post-

match press conference. Ranked 26 places above their opponents in the FIFA charts, the Indians were undone by poor finishing and lack of composure in key moments. India should have taken the lead in the 35th minute when Ashique Kuruniyan misjudged the delivery and fluffed a golden chance from close range.

"The game is easy to speak. Two teams fighting and that's all. Without too many chances. I think both teams defended both with order and one action. This is football," he said, trying hard to find the right words to explain the performance.

India now have just one point from two matches in Group C. With only the group winners advancing to the 2027 AFC Asian Cup in Saudi Arabia, the task ahead would be arduous.

"I cannot say nothing negative about the players. I think that the effort was there, the attitude was there, the plan of the game was there. In some moments, I feel that we can play better with the ball and be more brave," he said.

"But this is about the situation that the team is not winning and the players are a little nervous. In some actions that the pass is clear, we are a little nervous," he admitted. Since taking over from Igor Stimac last year, Marquez has overseen eight matches with only one win -- a 3-0 friendly victory over Maldives. (PTI)

#### top 10s easier at LIV Golf OAKMONT (USA), June 11: say that I would most likely have Two-time major champion Jon

Rahm comes into the U.S. Open off another top 10 at LIV Golf, which is nothing new. The Spaniard has never come in lower in the 20 events he has finished since joining the Saudi-backed league at the start of last vear. Is that a big deal?

"I would happily trade a bunch of

them for more wins, that's for sure,' said Rahm, who has two LIV victories but has yet to win this year. "But I keep putting myself in good position." One of the criticism of LIV is the 54-man fields over 54 holes, especially with a half-dozen or more considered past their prime and several unproven young players. Rahm delivered some context on his streak. "Listen, I'm a realist in this case," he said. "I've been playing really good golf, yes, but I'd be lying if I said that it wasn't easier to have top 10s with a smaller field. That's just the truth, right? Had I been playing full-field events, would I have top 10 every single week? No. But I've been playing good enough to been inside the top 30 every single time and maybe even top 25."

He considered that impressive, and he figures most of those would be top 10s. Rahm tied for eighth last week in Virginia without ever having a serious chance of winning over the final few holes. He said against a full field, he doubts that would have been a top 10.

"I think winning is equally as hard, but you can take advantage of a smaller field to finish higher," he said. "As much as I want to give it credit personally for having that many top 10s, I wouldn't always give it as the full amount just knowing that it's a smaller field.'

"We're looking to negotiate end of this year, and I'm very excited. They see the value in me. # 12 THE HILLS TIMES The Great Indian Football Mess: Bhutia, others demand overhaul of 'rotten' system

KOLKATA, June 11: Outraged by India's plummeting fortunes on the football field, talismanic former captain Bhaichung Bhutia has accused the national federation of destroying the sport while some other stakeholders have lambasted the current system as "rotten" and riddled with "fragile egos".

Bhutia's scathing attack on the All India Football Federation (AIFF) and its President Kalyan Chaubey came a day after the team collapsed to a stunning 0-1 loss to a lower-ranked Hong Kong in the third round of the AFC Asian Cup quali-

"It's very painful to see... we are definitely struggling now to even qualify for the Asia Cup, which we've been qualifying for regularly," Bhutia told PTI.

"Countries like Uzbekistan, Indonesia (likely qualifiers based in current form) and Jordan have qualified for the World Cup, and we are still struggling for the Asia Cup. Very unfortunate," he lamented.

The loss on Tuesday left India's hopes of qualifying for the 2027 Asian Cup hanging by a thread -- a stark contrast to their recent back-to-back appearances at the continental showpiece.

Visibly anguished, the former India captain called for Chaubey's resignation and demanded a structural overhaul of Indian football, describing the on-field disasters and off-field chaos as symptoms of

Current India head coach Manolo Marquez, who is also the coach of Indian Super League side FC Goa, took over from Croatian legend Igor Stimac in July last year. Stimac was sacked after a string of disappointing results, including a loss to Afghanistan in a World Cup qualifier in Guwahati.

Marquez hasn't been able to arrest the slide either and the team has logged just one win in its last eight matches. It is being widely speculated that he does not wish to continue in the position.

India had trained for nearly three weeks in Kolkata ahead of the crucial match on Tuesday, only to be outclassed by a team ranked 26 notches below them (India: 127, Hong Kong: 153).

The latest defeat is expected to push the country down to 133 in the FIFA rank-

Bhutia, who was defeated by Chaubey in the AIFF presidential election in September 2022, did not mince words while calling out the current leadership, alleging mismanagement, corruption, and bypassing of key footballing committees in major decisions, including the appointment of Marquez.

"Kalyan Chaubey has destroyed Indian football. Chaubey has to resign and leave. He has completely destroyed it. Three General Secretaries in two-and-a-half years -- the entire structure, the system

will have to be changed," he said.

"Controversy after controversy, corruption charge... even after months now we don't know who the I-League winner is," he added, referring to the ongoing legal tussle between Inter Kashi and Churchill Brothers for the championship.

He accused Chaubey of bypassing the Technical Committee to appoint Marquez and criticised the decision to let the Spaniard simultaneously coach both FC Goa and the national team.

Bhutia also criticised the decision to bring talismanic striker Sunil Chhetri out of international retirement, saying it was a poor call driven more by desperation

"It was nice of him to come out of retirement, but it was a completely bad decision. Manolo should not have requested, and now we hear the Federation pushed for it. But what's changed?" he asked.

"There is nothing happening at the grassroots. It's all negative news off the field, and that reflects on the national team's performance.'

Bhutia also ridiculed AIFF's decision to offer a USD 50,000 match bonus instead of a qualification-linked reward for the Hong Kong game.

"You're paying ₹ 42 lakh for one game. Why not link it to qualification? It just shows how clueless the management is." Former India international Goutam

Sarkar echoed Bhutia's sentiments, expressing frustration at the team's stagnation and the federation's failings. "We have not progressed even an inch.

If Sunil Chhetri continues to be your indispensable player, can it be more unfortunate?" he wondered.

"Of course, the Federation is completely responsible. They have been a complete failure.'

Legendary defender and coach Subrata Bhattacharva slammed the obsession with foreign coaches and called for more faith in Indian talent.

"It's no guarantee that a foreign coach will give you success. Domestic coaches like PK Baneriee and Amal Dutta brought

"Foreigners in ISL won't help Indian players develop. Only Indian coaches

know our boys and can develop them." On Chhetri's return, Bhattacharya, who also happens to be his father-in-law, said, "It's his personal decision, but if it was done to serve someone's personal interest,

Two of Indian football's key club stakeholders -- Bengaluru FC owner Parth Jindal and FC Goa CEO Ravi Puskur -- also launched a scathing attack on the AIFF and the broader footballing ecosystem, calling for deep introspection and structural reform in the wake of the humiliat-

ing defeat. FC Goa's Puskur called the system

"rotten in ways we refuse to admit."

"Everything moves on influence, favours, and fragile egos. We don't have the maturity to manage the ecosystem we claim to be building. We turn on each other faster than we face uncomfortable

truths," Puskur wrote on X. Puskur, however, felt that blame for the national team's persistent failures cannot be placed solely on the federation, the

coach, or the players. "We lost the match versus Hong Kong yesterday and there's outrage -- players, coach, federation, clubs are all facing the ire. But the truth is: blame isn't isolated. It belongs to all of us. And yes, that includes me," he added.

"Clubs -- mine included -- have inflated player salaries irresponsibly. We are outbidding each other for perception, knowing fully well it's unsustainable. Then we act shocked when these players fall flat on the international stage. WE built that illusion."

Bengaluru FC owner Parth Jindal also lashed out at the AIFF on social media, calling for urgent course correction.

"This is completely unacceptable @IndianFootball - just not good enough under any circumstances - deep introspection needed by the AIFF - this is not what all of us lovers and backers of Indian football have spent our hard-earned money and effort to witness - get a manager and a system that works -- it's high time," he said. (PTI)

# **Indian football continues to slide as team** suffers defeat to lower-ranked Hong Kong

KOWLOON (HONG KONG), June head coach Manolo Marquez was forced 11: There was no stopping Indian football's decline as the senior men's team, lacking in spunk, finishing skill and the will to fight, suffered a calamitous 0-1 defeat to lower-ranked Hong Kong in a crucial 2027 AFC Asian Cup Qualifier match here on Tuesday.

Hosts Hong Kong emerged victorious after an injury-time goal by Stefan Pereira.

The referee awarded Hong Kong the penalty after India custodian Vishal Kaith came out of the goalline and tried to punch the ball to safety, only to end up hitting Michael Udebuluzor and injuring the player.

Pereira (90+4) stepped up to take the spot kick and shot the ball to the right of Kaith, who was also shown a yellow card for his injury-time foul.

The latest reverse jeopardised India's prospects of reaching the next Asian Cup in Saudi Arabia, and the team is also set to drop to 133 on the FIFA rankings with Hong Kong gaining points and climbing

up in the pecking order. It is a continuation of a series of disappointing results that the team has endured in recent years during which activities off the field grabbed more headlines than onfield performances, including the unceremonious exit of previous head coach Igor Stimac after an ugly dispute with his employers All India Football Federation

to convince Sunil Chhetri to come out of retirement a year after he called it quits in international football.

However, even his comeback has not been able to lift the team out of the abyss it has found itself in recent times. The future of Manolo, who succeeded Stimac while also holding on to his job as ISL side FC Goa's coach, is also uncertain with the national team.

As his wards went about fluffing the two-three clear chances that came their way, Manolo was seen expressing his frustration on the touchline.

Earlier in the day, Manolo kept out veteran striker Chhetri from the starting XI.

A sea of red packed the stands at the newly built Kai Tak Stadium but despite the strong home support, India did pretty well to create a few chances in the first half, even though Hong Kong enjoyed more possession. But, as has been the trend with them in recent times, the lack of finishing has again let the Blue Tigers down in the first 45 minutes.

Among the opportunities that came their way before the half time break, the Indians came closest in the 35th minute but Ashique Kuruniyan shot the ball wide from a close range after Liston Colaco ran down the left to provide him a nice

Meanwhile, after having received medical attention after getting injured, Colaco unleashed a powerful long-range shot but oht into the

Hong Kong also grew in confidence as the game approached the half time. The home team could have taken the lead from a free-kick had it not been for a timely clearance by Asish Rai from goalmouth after custodian Vishal Kaith was

Both India and Hong Kong have had their moments but neither side could convert in a tightly contested first half of this crucial 2027 AFC Asian Cup Qualifier.

Kuruniyan, who has otherwise performed his job admirably on the flanks, looked to have got another chance to break the deadlock some minutes into the second half, but could not.

Soon after, coach Marquez brought on India's all-time highest goal-scorer Chhetri alongside Naorem Singh in place of Kuruniyan and Brandon Fernandes.

India created chances in the second half too, including in the 81st minute when Lallianzuala Chhangte found Chhetri with a brilliant cutback inside the Hong Kong box, but the veteran striker was not able to connect it well.

The result is a setback for India who came into the game after a goal-less draw against Bangladesh in their first Asian Cup qualifying match, at home in March. India have one point from two games and are last in the group, and only one team from the pool of four will qualify for the final. India will now need to win their remaining four matches, but given their inability to score it looks improbable (PTI)

On first 4-game losing streak since 2007, US looks unprepared with World Cup a year away



NASHVILLE (USA), June 11: The only bright side for the U.S. soccer team is the World Cup starts in a year, not this

The Americans conceded four goals in the first half, failed to get a shot on target and were embarrassed in a 4-0 blowout loss to Switzerland in a friendly on Tuesday night.

"It's really easy to look at one game, one half, and be like, oh, this is all going to pieces, they can't come back from this," defender Walker Zimmerman said. "But you look even the build-up to the 2022 (World Cup), we take down Morocco 3-0 and they make it into the semifinal. Things change — that was six months apart. It's not the end of the

Heading into their CONCACAF Gold Cup opener against Trinidad and Tobago on Sunday, the Americans are on a fourgame losing streak for the first time since 2007 and have dropped four consecutive home games for just the third time overall

and first time since 1988

U.S. coach Mauricio Pochettino blamed himself for picking a starting lineup that included four players with two or fewer international appearances. He wanted them to gain international experience but the Americans gave up four goals by the 40th minute for the first time since Nov. 9, 1980, at Mexico and the first time ever at home, accord-

ing to Opta. "It was my decision and the decision didn't work," he said. "It's painful because you don't want to improve losing

A dismayed fan base, angered by firstround elimination at last year's Copa America and two losses in the CONCA-CAF Nations League final four in March, is questioning the commitment of the team's player pool.

The U.S. was missing star Christian Pulisic (wanted time off); Yunus Musah (personal reason not disclosed): Weston McKennie, Tim Weah, Gio Reyna
